FDI rises to \$5.55bn since 2015, KDIPA report reveals

KUWAIT CITY, Oct 28, (KUNA): His Highness the Amir Sheikh Meshal Al-Ahmad Al-Jaber Al-Sabah received His Highness the Crown Prince Sheikh Sabah Khaled Al-Hamad Al-Sabah at Bayan Palace Monday morning.

The Amir received His Highness the Prime Minister Sheikh Ahmad Abdullah Al-Ahmad Al-Sabah Monday morning at Bayan Palace as well. Later, His Highness the Amir met with Minister of Commerce and Industry, Minister of Finance, and Acting Minister of State for Economic Affairs and Investment Khalifa Al-Askar, along with Kuwait Direct Investment Promotion Authority (KDIPA) Director General Sheikh Dr. Meshaal Jaber Al-Ahmad Al-Sabah and Deputy Chairman Wafa Al-Qatami, as they presented KDIPA's report for the 2023/2024 fiscal year.

Additionally, His Highness received President of Kuwait Audit Bureau Essam Al-Roumi, who submitted the bureau's annual report for the 2023/2024 fiscal year.

His Highness the Crown Prince Sheikh Sabah Khaled Al Hamad Al-Sabah also received Minister Al-Askar, Director General Sheikh Dr. Meshaal Jaber, Deputy Chairman Wafa Al-Qatami, and President Al-Roumi at Bayan Palace, as they presented their respective reports for the fiscal year.

Kuwait attracted foreign direct investments (FDI) of up to KD 206.9 million (USD 675 million) from the period starting in April 2023 to March 2024, according to a report released by the country's direct investment authority.

The fresh investments have upped the cumulative figure since the inception of Kuwait Direct Investment Authority (KDIPA)

KUWAIT CITY, Oct 28: The Embassy of the Republic of Korea to the State of Kuwait hosted the 7th Smart City Forum on Monday, October 28 at the Crowne Plaza Hotel to explore new technologies, innovative urban solutions and the evolving partnership between Korea and Kuwait in advancing smart urban transformation.

High-ranking officials, industry leaders, and experts from both nations gathered to discuss the future of smart city development and strengthen bilateral cooperation which is seen as vital for the ongoing collaboration between Korea and Kuwait, which began in 2017 as a follow-up to the signing of a Memorandum of Understanding (MOU) on smart city development in 2016.

Since then, the two countries have made significant strides, particularly through the South Saad Al-Abdullah Smart City project. The Korea Land & Housing Corporation (LH) has been instrumental in shaping the project's master plan and overseeing its management, reinforcing Korea's role as a strategic partner in Kuwait's Vision 2035 initiative.

Ministry of Health achieves 90 percent digital transition

KUWAIT CITY, Oct 28: The Minister of Health Dr. Ahmad Al-Awadhi has announced the digital transformation of all administrative correspondence in all health sectors, from division heads to the minister's office. This marks the first digital transformation the Ministry of Health has undertaken since its founding. In the coming two weeks, another step will be taken in that direction. In a press statement issued to announce the opening of the 2nd Ku-

wait Public Health Conference, titled "Public Health Challenges and Proposed Solutions", the minister revealed that 70,000 employees, including technicians, administrators, nurses, and other healthcare professionals, have completed training on the new electronic system.

He affirmed the effectiveness of the electronic systems in hospitals and administrative sectors, highlighting the restoration of these systems in most primary health care centers.



KUWAIT CITY, Oct 28, (KUNA): The 51st General Assembly of the Federation of Arab News Agencies (FANA) commenced on Monday in Kuwait hosted by KUNA with representatives from member agencies in attendance to discuss a range of topics outlined on the agenda.

Private lessons prohibited

MoE sets up student care centers for tuition classes

KUWAIT CITY, Oct 28: The student care centers in various educational districts have started the registration of grades five to 12 students who wish to attend tutorial classes in the afternoon, stressing that teachers must adhere to the Education Ministry's regulation on prohibiting private tutorials.

These centers are part of the ministry's strategy to advance the educational process and help students overcome difficulties in certain subjects in order to improve their academic performance. They provide services in the educational districts to cater to the largest number of students.

The tutorial classes cover basic subjects like Mathematics, Science, Arabic and English: in addition to other subjects according to each student's needs with the aim of improving their academic performance in preparation for the end-of-first-semester exams.

The ministry assigned qualified teachers to these centers. They are selected according to their experience and efficiency in teaching certain subjects. It is expected that these centers will witness a huge turnout of students and parents who wish to improve their children's educational capabilities to be ready for the end of the first semester and final exams.

It called on all students to benefit from these centers that provide additional educational support and develop the students' abilities for them to excel and succeed in their academic journey.

The registration fee for each subject is KD 25 for the intermediate and secondary stages. If a student registers in more than one subject or if two siblings register in the same center, the fee for each subject is reduced to KD 20.

The total tutorial period will be 20 hours - two hours per subject per week or three hours per day -- from 5:00 pm to 8:00 pm Sunday to Wednesday.

Car auction tender to open Dec 1

KUWAIT CITY, Oct 28: The Central Agency for Public Tenders (CAPT) set Dec 1, 2024 as the date for announcing the tender for the car auction in Amghara. Sources revealed the agency will be in charge of the procedures for launching the tender in accordance with Article 17 of Public Tenders Law No. 149/2016, which stipulates contracting through public tender (competitive negotiation or solicitation of bids).

Sources said the contract covers the maintenance of roads, main and secondary squares, asphalt or dirt squares, sidewalks, temporary roads, service sections, parking lots, and rainwater and sanitary sewer networks.

Meanwhile, sources disclosed that the Ministry of Public Works will soon launch the study and design phases for the establishment of a sewage water treatment plant in a low-cost housing project and the complementary works with an implementation period of 18 months; indicating the announcement will most likely happen in March 2025.

Sources added this project is in the ministry's contract plan for the current fiscal year, indicating the aim is to treat sewage water from the housing project and use the treated water for the irrigation of ornamental plants, protection of the environment and reduction of pollution.

Sources said the project includes studying options and alternatives for treating sewage water in emergency situations, designing tanks for treated water, irrigation canals, electrical conversion station, administrative buildings to serve the station and connecting roads.

MoCI to protect consumers

KUWAIT CITY, Oct 28 : The Ministry of Commerce and Industry has announced that the Commercial Control Department will conduct an inspection tour of the perfume exhibition.

This initiative aims to ensure compliance with laws and regulations prohibiting the marketing and promotion of goods and services outside designated areas, such as shops and display outlets (booths). This enforcement is in accordance with Resolution No. 198 of 2024.

The primary goal of these inspections is to protect consumers from potential harassment arising from promotional activities conducted outside the legal framework. The Ministry emphasizes that this decision is intended to ensure that sales and promotional operations are executed professionally, without causing inconvenience or undue pressure on consumers during their visits to booths and stores.

By enforcing these regulations, the Ministry aims to foster a fair and safe commercial environment that prioritizes consumer rights and upholds market integrity. This proactive approach is part of the Ministry's broader commitment to maintaining ethical business practices and enhancing the overall shopping experience for consumers.

KUWAIT CITY, Oct 28: Acting Director of Kuwait University, Dr. Osama Al-Saeed, has emphasized the university's commitment to hosting seminars and events that benefit university members and visitors, promoting cooperation between academia and security sectors.

Strategic restraint in intricate ties between Iran & the West

"IN THE intricate dynamics between the Iranian regime, the United States, and Israel, there lies a complex tapestry of strategic restraint, implicit tolerance, and carefully calibrated threats," columnist Talal Abdul Karim Arab wrote for Al-Jarida daily. "Reflecting on this issue in my July 4, 2019 article

"Reflecting on this issue in my July 4, 2019 article for Al-Qabas, titled "America will not kill the golden egg-laying hen," I examined why the United States, despite provocative rhetoric, often shies away from decisive action against Iran.

"Former President Trump's rhetoric, for instance,

promised a hardline stance on Iran, particularly against actions threatening international stability or targeting US assets. Yet, even as Iran and its proxies attacked American bases, assets, and commercial interests, Trump's response remained surprisingly measured.

"Despite provocations that many assumed would trigger retaliation, Trump refrained, citing his concern over potential casualties among Iranian forces.

"This cautious stance has striking parallels to Obama's handling of Syrian President Bashar al-Assad, a major ally of Iran. When Assad crossed Obama's "red line" by using chemical weapons, the deployment of US fleets along Syria's coast initially raised expectations of a robust response.

"However, Obama's decision to step back not only avoided direct conflict but also allowed Iran to solidify its presence in Syria, emboldening Iranian influence throughout the region.

"Both Obama's and Trump's approaches point to a long-standing tolerance from Western powers, including the US and Europe, toward Iran -- a tolerance that extends despite the regime's documented human rights abuses, sectarian policies, and inflammatory rhetoric toward Arab neighbors.

"This forbearance suggests that Iran's actions may, in fact, align with underlying Western interests, and perhaps even serve Israel's strategic agenda.

"In a Al-Jarida article dated March 15, 2023, I noted, "Those who believe that America and its allies want to overthrow the Iranian regime are mistaken." After all, eliminating Iran would mean destroying a "golden egg-laying hen," a phrase reflecting Iran's pivotal role in justifying US strategic presence and arms sales in the Gulf.

"The West's implicit agreement with Iran appears to be straightforward: as long as Iran halts nuclear ambitions, its regional activities may continue with minimal interference.

"For Gulf nations, this tacit agreement means perpetual insecurity, with Iran cast as an ever-present threat pushing them toward costly arms deals with Western suppliers.

"This strategy keeps Gulf states vigilant and heavily

dependent on Western military support, especially as Iran continues to deploy missiles and drones toward sensitive targets, even religious sites such as Makkah.

The complexity of this arrangement underscores that, unless the Iranian regime diverges drastically from its current agenda or crosses the nuclear threshold, its status quo will likely persist. Any true change, it appears, would need to stem from within Iran, driven by the will of the Iranian people themselves."

Kuwait has emerged as an important digital hub for new media, including online journalism and social media platforms.

KUWAIT CITY, Oct 28: Under the auspices of the Kuwait Camel and Folk Heritage Association, and with the participation of the Food and Agriculture Organization of the United Nations (FAO) and the Middle East Camel Network (Camnet), the Kuwait Institute for Scientific Research (KISR) is hosting the "Camels and Food Security" conference.

The event, themed "Strengthening Efforts to Eliminate the General Health and Economic Burdens of Camels", will take place on October 29-30 at the Millennium Hotel, coinciding with the International Year of the Camel.

A scientific researcher at the Environmental Research and Life Sciences Center and Head of the conference organizing committee Abdulaziz Al-Atiqi explained that the conference aims to highlight the status of camels as a national resource.

It will highlight the importance of both public and private initiatives in enhancing the sustainability and conservation of this unique animal, as well as its

PAM launches domestic worker rights campaign

KUWAIT CITY, Oct 28: The Public Authority for Manpower (PAM) has launched an awareness campaign on its social media accounts about the rights and duties of domestic workers and the mechanism for transferring from one employer to another, reports Al-Anba daily.

A source explained to the daily that if a domestic worker transfers to another employer during the guarantee period stipulated in the relevant law and regulations -- six months from the date of arrival in Kuwait -- without the knowledge of PAM; the worker's guarantee is forfeited unless a new contract is made between the new employer, labor recruitment office, worker and authority, which is represented by the Department for Organizing and Recruiting Domestic Workers. The source added that if the domestic worker refuses to continue working during the six-month guarantee period, the worker must be handed over to this department to protect the first employer's right to recover the recruitment costs.

In another development, Secretary General of the Supreme Council for Family Affairs Iman Al-Anzi revealed in a statement to the daily that the council received 228 reports on domestic violence in the last three months; including about 140 reports on violence against children; indicating most of these cases are due to a dispute between spouses regarding visitation and neglecting a minor.

The conference will not only focus on improving the livestock sector in Kuwait and the region as a whole but will also bring together experts, researchers, and policymakers to raise awareness about the value of camels as an important animal resource. Participants will share knowledge and expertise on combating animal diseases, using modern technologies in molecular biology and genetics, and improving methods for counting, numbering, and tracking animals.

Al-Atiqi stressed that the conference is taking place at a critical time, as the world is facing challenges related to food security, climate change, and the need for sustainable agricultural and animal practices.

He said the strategies to be discussed include improving agricultural methods to boost local fodder production, adopting resource-efficient animal husbandry techniques, strengthening regional cooperation to ensure food and animal security, and developing information systems for accurate statistics.

Al-Atiqi explained that the first day of the conference will focus on public health and infectious diseases in camels, including emerging diseases and the impacts of climate change. The first day's sessions will also review the work of the Middle East Camel Network and the Reference Center for Camel Diseases.

The second day's sessions will be held under the theme "Enhancing the Contribution of Camels to the Future of Food Security in the Region". Discussions will include topics such as the nutrition and sustainable management of camels, boosting the production and consumption of camel milk along with its health and economic benefits, camel genetics and breeding, improving breeds and their production capabilities, and developing policies that support food security at both national and regional levels.

This conference will serve as a platform for experts and interested parties to exchange knowledge and experiences, and work collaboratively to create a clearer vision for an implementation plan aimed at developing the camel sector.

Bids for main power station project open

KUWAIT CITY, Oct 28: The Public Authority for Housing Welfare (PAHW) has launched a tender for the establishment of the main power station in South Saad Al-Abdullah Residential City, reports Al-Anba daily.

The new project, coded 'SSAB 4Z', includes the supply and installation of a 400/132/11 kV station to generate power to cover the electricity needs of a densely populated area and improve electricity services.

Sources confirmed this is part of the country's plan to develop the electrical infrastructure and cover the needs of new residential cities.

Sources said the deadline for the submission of bids is on Nov 28, 2024; indicating that the participating local and international companies should have experience in implementing similar projects over the past decade.

Sources disclosed that interested companies can submit their inquiries until Nov 7, 2024; thereby, giving contractors the opportunity to inquire and ensure that all requirements are met. Another basic condition is that the capital of the companies should not be less than KD5 million, which reflects the size of the project and its economic importance, sources added.

Sources said it is expected that the new project will contribute to ongoing efforts to support the electricity network in the region in line with the country's commitment to improve the infrastructure and basic services for the public.

Moreover, the two sides touched on the Syrian crisis and the international efforts to find a political solution that ends the suffering of the Syrian people.



Kuwait's solar market set for expansion

KUWAIT CITY, Oct 28: According to MEED Magazine, Kuwait is set to launch the tender for the third phase of the Dabdaba and Shagaya renewable energy project, which will have a capacity of 1,100 megawatts, by the end of this year, reports Al-Qabas daily.

According to informed sources, the solar energy market in Kuwait is expected to experience significant growth in the coming years. Given the current increase in electricity consumption, the country will require at least seven new power stations in the next seven to eight years, with one station coming into service each year.

The sources revealed that Kuwait needs to add 1,000 megawatts annually to prevent potential energy supply shortages. He initiated this massive operation because His Highness wisely recognizes that Kuwait's true strength lies in a state of functional institutions where everyone understands their roles and responsibilities without infringing on those of others.

Based on this understanding, it is important to investigate the regrettable situation the nation currently faces due to several decisions, particularly those made by the Ministry of Finance and Ministry of Commerce and Industry. Among these, the B.O.T. law stands out as one that needs to be thoroughly reassessed.

It is irrational for Kuwait to violate international laws, particularly those pertaining to the specified timeframes in this legislation.

Despite the right of preemption, is it reasonable to expect an investor to abandon their life's work and put their project up for tender, only to be excluded from the process? Or to force them to build and operate a facility, only to abandon it after 10 or 15 years?

Facilitating business and promoting flexibility are essential first steps in boosting the national economy. Subsequently, the Ministry of Commerce and Industry, the Ministry of Finance, the Ministry of Interior, and others must establish laws that benefit the nation and prevent a return to the chaos of previous times.

His Highness the Amir delivered a firm message to the ministers - "The situation is serious, and I will hold the negligent accountable. The people seek real achievements, and we want unlimited giving. I will closely monitor your performance."

This directive was issued after a careful examination of the state of affairs brought about by improper practices that have persisted for roughly 30 years.

back in January of 2015 up until March of this year to KD 1.7 billion (USD 5.55 billion), the report said.

New aircraft factory will boost new skills: Modi

Leaders of India, Spain launch India's 1st private military aircraft plant

VADODARA, India, Oct 28, (AP): Indian Prime Minister Narendra Modi and his Spanish counterpart Pedro Sanchez inaugurated India's first private military aircraft plant on Monday, boosting New Delhi's ambitions of growing local manufacturing in its defense and aerospace industries.

Sanchez was welcomed to the country with a roadshow in Gujarat state's Vadodara city where hundreds of people cheered and waved banners.

The two leaders then launched the Tata Aircraft Complex, the manufacturing hub which will produce the Airbus C-295 transport military aircraft in collaboration with Airbus Spain and to be deployed by the Indian air force.

Sanchez said the project was a triumph of Modi's vision "to turn India into an industrial powerhouse and a magnet for investment and business-tobusiness collaboration."

"This partnership between Airbus and Tata will contribute to the progress of the Indian aerospace industry and will open new doors for the arrival of other European companies," he added.

"This new aircraft factory will boost new skills and new industries in India," Modi said, adding that the country was now supplying parts to the world's leading aircraft companies.

The chairman of Tata conglomerate, Natarajan Chandrasekaran, hailed it as a historic day for the country's defense sector and credited the late Ratan Tata, the industrialist and former chairman who died earlier this month, for conceiving the idea more than a decade ago.

Under a \$2.5 billion deal signed in 2021, Airbus will deliver the first 16 of the aircraft from its final assembly line in Seville, Spain - six of them have been delivered to the Indian air force so far. Tata Advanced Systems Ltd will produce

40 of the aircraft in the Vadodara plant, which is expected to roll out the first C-295 aircraft made in India in 2026. The aircraft can transport up to 71 troops or 50 paratroopers and will be able to access remote locations. It can also be used for medical evacuations and aid in disaster response and maritime patrol duties.

Since coming to power in 2014, Modi has vowed to turn India into a global manufacturing hub, including in infrastructure, pharmaceuticals and defense. As part of an effort to modernize and reform military equipment, the government has sought to grow the private defense manufacturing sector, a space previously occupied solely by the government-run organizations, and has eased foreign direct investment regulations to try and encourage companies to establish themselves in India.

The visit marks the first by a Spanish leader to India in 18 years. Modi and Sanchez have previously met on the sidelines of global summits in 2018 and 2021. During the two-day visit, Sanchez will hold talks with Modi to review ties between the countries and also speak with Indian Foreign Minister Subrahmanyam Jaishankar.

On Tuesday, Sanchez will travel to Mumbai, India's financial capital and home to Bollywood, where he is expected to interact with trade and industry leaders, and also visit film studios in an effort to grow collaboration between the Indian and Spanish entertainment industry.

Their bilateral trade stood at nearly \$10 billion as of 2023. According to the Indian foreign ministry, more than 200 Spanish companies actively operate in India and around 80 Indian companies in Spain. The two leaders are expected to sign agreements that will further boost ties and cooperation in various areas such as trade, information technology, renewable energy and defense, according to an Indian government statement.

Harris calls on US 'to turn page on hatred, division', Trump NY event features insults

PHILADELPHIA, Oct 28, (AP): Kamala Harris said Sunday that "no one can sit on the sidelines" in this year's presidential election, capping a day of campaigning across the largest city in the crucial battleground state of Pennsylvania.

"We are focused on the future and we are focused on the needs of the American people," Harris said, "as opposed to Donald Trump, who spends full time looking in the mirror focused on himself."

Speaking at a city recreation center, the Democratic vice president singled out young voters, praising them for being "rightly impatient for change," and told the audience that "there is too much at stake" in the campaign.

Mark Ruffalo and Don Cheadle, two actors who starred in Marvel's "Avengers" movies, were at the rally. Harris reminded the crowd that Pennsylvania's deadline for early voting is Tuesday, telling them to "get it done tomorrow if you can."

Energizing voters in Philadelphia, a traditional Democratic stronghold, is crucial for Harris' chances of beating Republican nominee Donald Trump. If turnout falls short here, she'll struggle to overcome Trump's advantages in Pennsylvania's rural areas. "Philadelphia is a very important part of our path to victory," Harris told reporters. "It's the reason I have been spending time here. But I'm feeling very optimistic about the enthusiasm."

The Democratic coalition relies on voters of color, and Harris' itinerary on Sunday reflected that focus. She began the day with the Black congregation at the Church of Christian Compassion, where she said the United States is "determined to turn the page on hatred and division."

Meanwhile, Trump hosted a rally featuring crude and racist insults at New York's Madison Square Garden Sunday, turning what his campaign had dubbed as the event where he would deliver his closing message into an illustration of what turns off his critics.

With just over a week before Election Day, speakers labeled Puerto Rico a "floating island of garbage," called Harris "the devil," and said the woman vying to become the first woman and Black woman president had begun her career as a prostitute.

"I don't know if you guys know this, but there's literally a floating island of garbage in the middle of the ocean right now. I think it's called Puerto Rico," said Tony Hinchcliffe, a stand-up comic whose set also included lewd and racist comments about Latinos and Black people, all key constituencies in the election just nine days away.

40 soldiers killed in army base attack: Chad prez

DAKAR, Senegal, Oct 28, (AP): Unidentified assailants killed at least 40 soldiers during an overnight attack on a military base in the country's west, Chad's presidency said Monday. President Mahamat Deby Itno visited the base in Barkaram, an island in Chad's Lake region, early morning and announced the launch of a military operation to track the assailants.

Chad has long battled with an insurgency in the country's west, near the border with Nigeria. It was not immediately known who was behind the latest attack, but previous attacks in the region have been blamed by the government on the Boko Haram militant group. In March, an attack the government blamed on Boko Haram killed seven soldiers, reviving fears of violence in the Lake Chad area. A

Philippine ex-leader Duterte says he kept 'death squad' as mayor to kill criminals

MANILA, Philippines, Oct 28, (AP): Former Philippine President Rodrigo Duterte told a Senate inquiry Monday that he had maintained a "death squad" of criminals to kill other criminals when he was mayor of a southern Philippine city.

Duterte, however, denied authorizing police to gun down thousands of suspects in a bloody crackdown on illegal drugs he had ordered as president and which is the subject of an investigation by the International Criminal Court as a possible crime against humanity. Duterte, 79, attended the televised inquiry in his first public appearance since his term ended in 2022. The Senate is looking into the drug killings under Duterte, which were unprecedented in their scale in recent Philippine history.

Duterte acknowledged without elaborating that he once maintained a death squad of seven "gangsters" to deal with criminals when he was the longtime Davao city mayor, before he became president.

"I can make the confession now if you want," Duterte said. "I had a death squad of seven, but they were not policemen, they were also gangsters."

"I'll ask a gangster to kill somebody," Duterte said. "If you will not kill (that person), I will kill you now."

Sen. Aquilino Pimentel III, who was overseeing the inquiry, and Sen. Risa Hontiveros, pressed Duterte to provide more details but the former president responded in unclear terms and said he would explain further in the next hearing. Often cursing during the hearing, Duterte said he would take full responsibility for the killings that happened while he was president from 2016 to 2022. But he said he never ordered his national police chiefs, who also attended the inquiry, to undertake extrajudicial killings.

"Did I ever tell you to kill any criminal?" Duterte asked his former police chiefs. They included Ronald Dela Rosa, the current senator who first enforced Duterte's campaign against illegal drugs as his national police chief.

"No, Mr. president," dela Rosa responded.

Former Sen. Leila de Lima, one of the most vocal critics of Duterte who once investigated the drug killings in Davao, said there was adequate evidence and witnesses of the extrajudicial killings but they were scared of testifying against Duterte. De Lima was arrested early on in Duterte's presidency on drug charges she said were fabricated to stop her from proceeding with her Senate investigation. She was cleared of the charges and released from more than six years of detention last year.

"This man, the former mayor of Davao city and the former president of the Republic of the Philippines, for so long has evaded justice and accountability," said de Lima, sitting near the former president.

"We have not made him to account after all these years," she said, and added that witnesses could now surface and help prosecute Duterte and his associates. Duterte sounded defiant through the bearing

N.Korea sent troops to help Russia: NATO

BRUSSELS, Oct 28, (AP): NATO on Monday confirmed that North Korean troops have been sent to Russia to aid in its almost three-year war against Ukraine and that some have already been deployed in Russia's Kursk border region, where Russia has been struggling to push back a Ukrainian incursion.

"Today, I can confirm that North Korean troops have been sent to Russia, and that North Korean military units have been deployed to the Kursk region," NATO Secretary-General Mark Rutte told reporters. Rutte said that the move represents "a significant escalation" in North Korea's involvement in the conflict and marks "a dangerous expansion of Russia's war."

His remarks came after a high-level South Korean delegation including top intelligence and military officials as well as senior diplomats briefed the alliance's 32 national ambassadors at NATO headquarters in Brussels.

KFH holds webcast for Q3 '24 financial results

Performance remarkable

KUWAIT CITY, Oct 28: Kuwait Finance House (KFH) held the Analysts Conference for Q3 2024 with the participation of KFH Group Senior Deputy CEO – Finance, Dr. Shadi Zahran, KFH Group Chief Strategy Officer, Fahad Al-Mukhaizeem, KFH **Group Acting CFO and General Manager Financial Control and Regulatory Report**ing, Jamal Al-Humairi.

KFH Group Senior Deputy CEO - Finance, Dr. Shadi Zahran commenced the conference by highlighting the Bank's financial performance up till the end of Q3-2024. KFH's earnings per share up to the end of Q3-2024 reached 29.62 fils, representing an increase of 4.8% compared to the same period last year. ROAE increased from 11.72% to 12.11%. ROAA stood at 1.85%. Net financing income up to the end of the third quarter of 2024 reached KD 835.1 million; an increase of 17.0% compared to the same period last year. And net operating income up to the end of Q3-2024 increased to reach KD 754.0 million; an increase of 1.9% compared to the same period last year.

He added: "KFH has achieved record financial results by the end of the third quarter of 2024, with growth in most of the key financial indicators. This success is attributed to the strong performance and disciplined implementation of KFH's strategy, along with a cautious approach to risk management. The bank has also focused on diversifying the financing portfolio, improving the quality of assets, along with capital optimization enhancing the capital base, and to ensure KFH's ongoing financial strength and solid creditworthiness.'

line inflation rate driven by reductions in housing and transportation costs. By the end of September 2024, the Kuwaiti Crude Oil Price stood at USD 74.3 per barrel, reflecting a decrease of over 24% compared to the same period last year. Nevertheless, the current developments suggest potential for economic recovery and stabilization in the coming year where GDP growth is expected to reach 3.8% in 2025.

The Central Bank of Kuwait (CBK) has announced a reduction in the discount rate of 25 basis points, lowering it from 4.25% to 4.00%, effective September 19, 2024. This decision comes as a result of careful observation of both domestic and international economic conditions and marks the conclusion of the monetary tightening cycle that began in March 2022 by many global central banks.

He added: "In terms of credit ratings, Kuwait maintains a robust profile with an A+ rating and a stable outlook from Standard & Poor's, an A1 rating from Moody's, and an AA- rating from Fitch, all with stable outlooks.'

Al-Mukhaizeem said: "Kuwait has an opportunity to implement key economic reforms that can lead to a more diverse and resilient economy. Possible actions include enhancing the business environment, simplifying regulations, improving transparency, and diversifying revenue sources. This will have a positive impact which will attract foreign investment and stimulate private sector growth paving the way to a more dynamic economy that thrives beyond oil dependency.'

He further noted that within the banking sector, KFH also continues to strengthen its position, with a long-term credit rating of A from Fitch and A2 from Moody's, both with stable outlooks. Al-Humairi explained that the higher profits are mainly from the increase in net operating income and lower provisions. Partly offset by higher net monetary loss that resulted from the application of IAS-29 "Financial reporting in Hyperinflationary Economies" on the financial statements of Kuwait Turkish Participation Bank (KTPB) and increase in operating expenses.

He added: "Financing income has increased by KD 558.3mn or 35.5% compared to same period last year mainly due to increase in yield. Net financing income at KD 835.1mn increased by KD 121.2mn or 17% compared to same period last year mainly due to an increase in financing income by KD 558.3mn offset by increase in finance cost and distribution to depositors by KD 437.1mn."

Looking at the operating income profile, Al-Humairi said that the contribution of net financing income to operating income increased from 64%in 9M-23 to 70% in 9M-24 due to an increase in net financing income and decline in investment income.

Increase in fees and commissions by KD 26.3mn is mainly related to increase in transaction fee income mainly from our subsidiary in Turkey.

Al-Humairi noted that Group NFM for 9M-24 at 2.97% is higher by 28bps compared to 9M-23. Average yield improved by 225bps while average COF also increased by 197bps. This was the result of both rate hikes and repricing of assets and liabilities during the period.

He added: "Looking at provisions and impairments, group total impairment charge decreased of

He said: "The Group has achieved Net Profit After Tax attributable to Shareholders for the first nine months ended 30th September 2024 of KD KD (17.3)mn compared to 9M-23.

Al-Humairi confirmed that KFH cautious approach towards provisioning have contributed to financing provision balance exceeding ECL required as per CBK IFRS 9 by KD 514mn as of 30 September 2024.

As for the Net Monetary Loss, application of IAS-29 on the financial statements of KTPB resulted in recognition of net monetary loss of KD 117.8mn in the current period an increase of KD 38.6mn compared to 9M 2023 due to inflation and significant maturity of CPI linked sukuk during last quarter of 2023.

Financial position:

Total Assets at KD 36.3bn decreased by KD (1.8)bn or (4.6)% in 9M-24.

Net financing receivables at KD 19.1bn decreased by (1.5)% mainly due to sale of KFH Bahrain and foreign currency volatility during the period. Excluding this impact, group net financing receivable increased in 9M 2024 by 5.6%. Investments in debt securities at KD 6.4bn.Deposits for 9M-24 at KD 19.9bn.

The contribution from CASA deposits to total group customer deposits as at the end of 9M-24 is 42.8% and on an overall basis the Group continues to benefit from a large pool of low-cost deposits. Contribution of customer deposits to total fund-

ing is 69.6% compared to 71.7% in 2023.

The main reason for this growth is attributed to the increase in the Consumer sector revenues, which constitute 73% of total revenues. Meanwhile, Business sector revenues accounted



for 27% of the company's total revenue during the first nine months of 2024. Overall, the growth in stc's revenue is a result of our efforts to improve the company's business model, developing digital services, and providing integrated technical solutions to companies in various fields."

Aldharrab added: "These outcomes resulted in a growth of EBITDA by 1.2% to reach KD 63.7 mn in the first nine months of 2024 compared to KD 63.0 mn during the same period in 2023 supported by the increase in stc's revenue. As a result, the Company's net profit increased by 1.4% to reach KD 24.7 mn (EPS 25 Fils) in the first nine months of 2024 compared with KD 24.4 mn (EPS 24 Fils) in the same period last year. The increase in net profit is mainly attributed to the cost optimization program and enhancing the company's operational efficiency at both stc and its subsidiaries. stc's customer base stands at approx. 2.3 mn customers at the end of September 2024".

Continuing claims rise to highest level since 2021

US applications for jobless benefits fall Burgan Bank attends 2024 WBG and

AI, digital currencies among key topics

WASHINGTON, Oct 28, (AP): The number of Americans filing for unemployment benefits fell last week, but the total number of those collecting benefits rose to its highest level in almost three years.

The Labor Department reported Thursday that applications for jobless claims fell by by 15,000 to 227,000 for the week of Oct. 19. That's less than the 241.000 analysts forecast.

Weekly applications for jobless benefits are considered a proxy for U.S. layoffs.

Continuing claims, the total number of Americans collecting jobless ben-efits, rose by 28,000 to 1.9 million for the week of Oct. 12. That's the most since November 13, 2021.

The rising level of continuing claims suggests that some who are receiving benefits are finding it harder to land new jobs. That could mean that demand for workers is waning, even as the economy remains strong

Still, the four-week average of continuing claims is only as high as it was this summer, and not terribly concern-

ing yet, analysts say.

In response to weakening employment data and receding consumer prices, the Federal Reserve last month cut its benchmark interest rate by a half of a percentage point as the central bank shifted its focus from taming inflation toward supporting the job market. The Fed is trying to pull off a rare "soft landing," whereby it brings down in-

flation without tipping the economy into a recession.

It was the Fed's first rate cut in four years after a series of increases starting in 2022 that pushed the federal funds rate to a two-decade high of 5.3%.

Inflation has retreated steadily, approaching the Fed's 2% target and leading Chair Jerome Powell to declare recently that it was largely under control.

Earlier this month, the government reported that U.S. inflation reached its lowest point since February 2021.

During the first four months of 2024, applications for jobless benefits averaged just 213,000 a week before rising in May. They hit 250,000 in late July, supporting the notion that high interest rates were finally cooling a red-hot U.S. job market.

In August, the Labor Department reported that the U.S. economy added 818,000 fewer jobs from April 2023 through March this year than were originally reported. The revised total was also considered evidence that the job market has been slowing steadily, compelling the Fed to start cutting interest rates

Proof that immigrants fuel US economy is found in billions they send back home

Donald Trump has vowed to deport millions of immigrants if he is elected to a second term, claiming that, among other things, foreign-born workers take jobs from others. His running mate JD Vance has echoed those anti-immigrant views.

Researchers, however, generally agree that massive deportations would hurt the U.S. economy, perhaps even triggering a recession.

Social scientists and analysts tend to concur that immigration - both documented and undocumented - spurs economic growth. But it is almost impossible to calculate directly how much immigrants contribute to the economy. That's because we don't know the earnings of every immigrant worker in the United States.

We do, however, have a good idea of how much they send back to their home countries - more than US\$81 billion in 2022, according to the World Bank. And we can use this figure to indirectly calculate the total economic value of immigrant labor in the U.S.

I conducted a study with researchers at the Center for Latin American and Latino Studies and the Immigration Lab at American University to quantify how much immigrants contribute to the U.S. economy based on their remittances, or money sent back home.

Several studies indicate that remittances constitute 17.5% of immigrants' income.

Given that, we estimate that the im-migrants who remitted in 2022 had take-home wages of over \$466 billion. Assuming their take-home wages are around 21% of the economic value of what they produce for the businesses they work for like workers in similar entry-level jobs in restaurants and construction - then immigrants added a total of \$2.2 trillion to the U.S. economy yearly.

That is about 8% of the gross domestic product of the United States and close to the entire GDP of Canada in 2022 - the world's ninth-largest economy

Beyond its sheer value, this figure

tells us something important about immigrant labor: The main beneficiaries of immigrant labor are the U.S. economy and society.

The \$81 billion that immigrants sent home in 2022 is a tiny fraction of their total economic value of \$2.2 trillion. The vast majority of immigrant wages and productivity - 96% - stayed in the United States.

Remittances from the U.S. represent a substantial income source for the people who receive them. But they do not represent a siphoning of U.S. dollars, as Trump has implied when he called remittances "welfare" for people in other countries and suggested taxing them to pay for the construction of a border wall.

The economic contributions of U.S. immigrants are likely to be even more substantial than what we calculate.

For one thing, the World Bank's estimate of immigrant remittances is probably an undercount, since many immigrants send money abroad with people traveling to their home countries.

In prior research, my colleagues and I have also found that some groups of immigrants are less likely to remit than others. (AP)



'Conclave' emerges as the surprise hit of the weekend

'Venom' falls short of projections as superhero films fade

NEW YORK, Oct 28, (AP): "Venom: The Last Dance" showed less bite than expected at the box office, collecting \$51 million in its opening weekend, according to studio estimates Sunday, significantly down from the alien symbiote franchise's previous entries

Projections for the third "Venom" film from Sony Pictures had been closer to \$65 million. More concerning, though, was the drop off from the first two "Venom" films. The 2018 original debuted with \$80.2 million, while the 2021 follow-up, "Venom: Let There Be Carnage," opened with \$90 million even as theaters were still in recovery mode during the pandemic.

"The Last Dance," starring Tom Hardy as a journalist who shares his body with an alien entity also voiced by Hardy, could still turn a profit for Sony. Its production budget, not accounting for promotion and marketing, was about \$120 million - significantly less than most comic-book films. But "The Last Dance" is also performing better overseas. Internationally, "Venom: The Last Dance" collected \$124 million over the weekend, including \$46 million over five days of release in China.

That's good enough for one of the best international weekends of the year for a Hollywood release. The low weekend for "Venom: The Last Dance" also likely insures that superhero films will see their lowest-grossing year in a dozen years, not counting the pandemic year of 2020, according to David A. Gross, a film consultant who publishes a newsletter for Franchise Entertainment. Following on the heels of the "Joker: Folie à Deux" flop, Gross

estimates that 2024 superhero films will gross about \$2.25 billion worldwide. The only upcoming entry is Marvel's "Kraven the Hunter," due out Dec. 13. Even with the \$1.3 billion of "Deadpool & Wolverine," the genre hasn't, overall, been dominating

the way it once did. In 2018, for example, superhero films ac-counted for more than \$7 billion in global ticket sales.

Last week's top film, the Paramount Pictures horror sequel "Smile 2," dropped to second place with \$9.4 million. That

brings its two-week total to \$83.7 million worldwide. The weekend's biggest success story might have been "Con-clave," the papal thriller starring Ralph Fiennes and directed by Edward Berger ("All Quiet on the Western Front"). The Focus Features release, a major Oscar contender, launched with \$6.5 million in 1,753 theaters. That put "Conclave" into third place, making it the rare adult-

oriented drama to make a mark theatrically. Some 77% of ticket buyers were over the age of 35, Focus said. With a strong open-ing and stellar reviews, "Conclave" could continue to gather momentum both with moviegoers and Oscar voters.

The comments on Puerto Rico were immediately criticized by Harris' campaign, but were also called out by Angel Cintron, the head of the GOP on the island, and Republican U.S. Rep. Maria Elvira Salazar, who represents parts of Miami and has participated in recent Trump events. (AP)



Depardieu skips court due to 'health issues'

PARIS, Oct 28, (AP): French actor Gérard Depardieu, who is facing trial for the alleged sexual assaults of two women on a film set in 2021, won't appear before a criminal court in Paris on Monday due to health reasons, his lawyer said.

Depardieu, who previously has denied any wrongdoing, is accused of using "violence, coercion, sur-prise or threat" in the alleged assault, which prosecutors said took place on the set of "Les Volets verts" ("The Green Shutters.")


Lawyer Jérémie Assous said doctors say the actor's health doesn't allow him to appear for the opening of the trial on Monday.

Depardieu "is deeply affected and unfortunately his doctors don't allow him to appear at the hearing," Assous told France Info radio.

Assous said he will ask the court for the postponement of the trial because his cli-

ent "wishes to come, wants to express himself. Prosecutors say that in both

cases, victims reported that the 75-year-old actor trapped them between his legs and groped their buttocks, genitals, chest and breasts over their clothes. The trial was scheduled as

Chalamet 'crashes' his own look-alike contest

NEW YORK, Oct 28, (AP): Actor Timothée Chalamet made a surprise appearance at his own look-alike contest in Lower Manhattan on Sunday, an event that drew hundreds of onlookers, a dispersal order from police and at least one arrest.

Flanked by bodyguards, Chalamet briefly posed for photos with his high-cheeked, curly haired doppelgängers, some of whom had dressed as the actor's characters in "Wonka" and the "Dune" movies.

But just as the wannabe-Chalamats began strutting along a red carpet in Washington Square Park, police ordered the large group to disperse, slapping organizers with a \$500 fine for an "unpermitted costume contest."

At least one contestant was taken away in handcuffs, though police did not immediately say why. A spokesperson for the NYPD said charges were pending.

The organizers had posted flyers for the contest - which promised a \$50 prize to the winner - around New York in recent days, spurring social media speculation and thousands of RSVPs to an online invite.

Eventually, a winner was chosen: Miles Mitchell, a 21-year-old Staten Island resident, who dressed in a purple Willy Wonka outfit and tossed candy to the crowd from a brief case.

'Conclave' mirrors real-life Vatican power struggles

Papal drama thrills Rome

ROME, Oct 28, (AP): With Pope Francis a few weeks away from his 88th birthday, the plotting for his successor is well underway at the Vatican.

How timely, then, that just across town in Rome, "Conclave" a thriller filled with back-stabbing, manipulative cardinals, quick to toss morality out of the window as they promote their candidate, is a top draw at the Rome Film Festival.

This might be a little too close to home - literally and figuratively - for Pope Francis.

Austrian-Swiss Director Edward Berger, who directed "All Quiet on the Western Front" (2022), adapted the film from the 2016 novel "Conclave" by Robert Harris. Berger puts an extraordinary Ralph Fiennes in the role of Cardinal Thomas Lawrence, dean of the College of Cardinals responsible for organizing the conclave.

Powerful

The conclave is the centuries-old tradition in which, on the death of a pope, cardinals gather in the Sistine Chapel at the Vatican to participate in rounds of voting until they elect a new pontiff. Conclave comes from the Latin "cum clave," meaning "with a key," to indicate the Cardinals are locked in until they have chosen the new leader for the world's 1.3 billion Catholics.

The whole process is conducted under the spectacular frescoed ceiling painted by Michelangelo, and his masterpiece "The Last Judgment" depicting the fate of men heading to heaven or hell covers the wall behind the altar. During the entire process, the prelates are cut off from communicating with the outside world and must live in seclusion inside the Vatican.

Conclaves have a reputation as a no-holds-barred competition as cardinals make backroom deals to elect their favorites in secret ballots.

At the end of each round of voting, the ballots are thrown in a specially constructed stove in the Sistine Chapel, with a chemical added that will color the smoke. The tens of thousands of people gathered in St. Peter's Square awaiting the result will know whether or not a new pope has been selected by the smoke that appears from the chimney. Black means the cardinals have not yet selected a pope, white means a new pope has been chosen.

In "Conclave" Stanley Tucci plays Aldo Bellini, a progressive American cardinal fighting it out against the powerful conservative Cardinal Goffredo Tedesco played by Sergio Castellitto and Canadian Cardinal Joseph Tremblay played by John Lithgow. Nigerian Cardinal Joshua Adeyemi, played by Lucian Msamati, could be the first Black pope, but his homophobic views clash with the progressives.

While women remain excluded from the conclave and the highest circles of power at the Vatican, they provide assistance carrying out humble roles serving the cardinals during the conclave period. Isabella Rossellini plays a nun who surprises in her role of quiet observer who does not miss a trick.

While a thriller, the film often comes close to the real workings and current debates at the Vatican. As the stars of the film strolled down the red carpet, some wondered how the film would be viewed over at the Vatican.

"It's intriguing. Are they sitting there at the Vatican watching the news coverage of 'Conclave'?" actor Fiennes said. "I am sure there are a few people in the Vatican who would be curious to see what the film is saying.'

Despite his age and serious health issues, including a bad knee which has forced him to use a wheelchair, Pope Francis does not appear to be slowing down. In August he took his longest and most challenging trip ever, traveling by air to four countries in the Asia-Pacific. This month he has presided over the synod, a three-week meeting of more than 360 bishops and lay people to discuss the future of the church.

But Francis is not immortal. Discussions on who could be his successor have already begun, but it remains to be seen if the next real conclave will be as thrilling as the film.

After the incident, it was arranged for Depardieu to apologize. But in a TV interview aired Saturday, the woman said the actor was furious and blamed her for causing trouble. Prosecutors said witnesses confirmed that what Depardieu had said did not constitute an apology.

In the interview with French online news site Mediapart, the production designer - who spoke on camera but only gave her first name - said the alleged assault had taken a toll on her personal and professional life for at least 1 1/2 years. The woman, according to prosecutors, said it had taken her a while to file a complaint but she decided to do so after hearing on television that there had never been an incident during the shoot.

A director's assistant told investigators Depardieu had touched her buttocks on several occasions. She had expressed her disapproval and in return, Depardieu, she said, had been insulting toward her. She was also given a six-day leave by a psychiatrist.

Assous, Depardieu's lawyer, told the AP in an email Saturday that "the witnesses and evidence (Depardieu) will produce will demonstrate that he is the target of false accusations.

Despite the allegations against Depardieu, many have come out in his support, including French President Emmanuel Macron.

Late last year, 56 French performers, writers and producers published an essay defending the film star, saying that when "Gérard Depardieu is targeted this way, it is the art (of cinema) that is being attacked."

Their call came just weeks after national broadcaster France 2 put out a documentary outlining accusations of sexual misconduct by 16 women against Depardieu, and showed the actor making obscene remarks and gestures during a 2018 trip to North Korea.

In the footage, Depardieu can be seen making groaning sounds and sexual comments in front of women, including a girl about 10 years old who is horse riding. He can also be seen posing for a photo, saying he was "touching the bottom" of a North Korean interpreter by his side.

He was charged in 2021 with rape and sexual assault after authorities revived a 2018 investigation that was initially dropped, following allegations from actor Charlotte Arnould.

In an open letter published in the conservative-leaning newspaper Le Figaro, Depardieu said last year: "I have never, ever abused a woman.'

The actor was long seen as a national icon in France. He has been a global ambassador for French film and enjoyed international fame with several roles in Hollywood.

Earlier this year, actor Judith Godrèche called on France's film industry to "face the truth" on sexual violence and physical abuse during the Cesar Awards ceremony, France's version of the Oscars.

Godrèche had previously alleged two prominent filmmakers sexually abused her when she was a teen, sending new shockwaves through the industry.

More recently, the ongoing trial of 50 men accused of raping a woman who had been previously drugged and rendered unconscious by her husband shook the country.

Afghanistan targets 6.2m children in anti-polio drive

Pakistan launches new vaccination drive amid rising polio cases

ISLAMABAD, Oct 28, (Agencies): Pakistan began a nationwide vaccination campaign Monday to protect 45 million children from polio after a surge in new cases that has hampered years of efforts to stop the disease in one of the two countries where it has never been eradicated.

Pakistan regularly launches such campaigns, but violence targeting the health workers and police assigned to escort them is common. Militants falsely claim the vaccination campaigns are a Western conspiracy to sterilize children.

The campaign is the third this year and will continue until Sunday "in response to the alarming increase in polio cases," said Ayesha Raza Farooq, the prime minister's adviser for the polio eradication program. "We are re-energized in our efforts to combat polio," she said in a statement. During the door-to-door campaign,

children younger than 5 will be vaccinated and given drops of Vitamin A supplements to enhance their immunity

Prime Minister Shehbaz Sharif recently met with front-line health workers, urging them to ensure no child was left unvaccinated by going door-

Anwarul Haq, who is the coordinator of the National Emergency Operations Centre for Polio Eradication, also urged parents to fully cooperate with polio workers. "Polio has no cure, but it can be prevented with this readily available vaccine," he said.

Pakistan has recorded 41 cases across 71 districts so far this year, Farooq said. Most were reported from southwestern Balochistan and southern Sindh province, following by Khyber Pakhtunkhwa province and eastern Punjab province.

The surge in cases in new locations is worrying authorities since previous cases were from the restive northwest bordering Afghanistan, where the Taliban government in September suddenly stopped a door-to-door vaccination campaign

Authorities in Pakistan say the Afghan Taliban's recent decision to stop

door-to-door anti-polio campaign will have repercussions beyond the Afghan border, as people from both sides frequently travel to each other's country. The World Health Organization has confirmed 18 polio cases in Afghanistan this year.

Pakistan and Afghanistan are the only two countries in the world where the spread of polio has never been stopped. It is one of the world's most infectious diseases, so it continues to spread anywhere people are not fully vaccinated. In severe cases, polio can cause permanent paralysis and death.

Meanwhile, the Afghan caretaker government's Ministry of Public Health on Monday announced a threeday vaccination campaign aimed at protecting 6.2 million children under the age of 5 from poliovirus.

Running from Monday to Wednesday, the campaign will provide anti-polio drops to children in 16 out of Afghanistan's 34 provinces, said Sharafat Zaman Amarkhil, spokesperson for the ministry.

In his message, Amarkhail urged tribal elders, religious scholars, and parents to cooperate with polio workers to implement the campaign appropriately.

"There are no confirmed positive polio cases registered in Afghanistan in 2024. The ministry is trying to eradicate this wild virus by launching vaccine campaigns," Amarkhail said.

In another development, the vaccination rate for Australian children declined for the third consecutive year in 2023, new data revealed on Monday.

According to the governmentfunded immunization coverage report for 2023, published by the National Centre for Immunisation Research and Surveillance (NCIRS), the vaccination coverage rate declined among children at all three standard age assessment milestones in 2023.

Tiny pollutants in air could be a silent killer: research

Our study shows that high levels of ultrafine particles in the atmosphere over long periods of time are significantly associated with increased non-accidental deaths, particularly from cardiovascular and respiratory diseases.

Ultrafine particles are aerosols less than 0.1 micrometers, or 100 nanometers, in diameter - about one-thousandth the width of a human hair. Due to their tiny size, they can be easily inhaled into the distal branches of lungs, quickly absorbed into the bloodstream and even pass through organ barriers

Effects

We also found that certain underserved populations, including Hispanics, non-Hispanic Black people, children under 5. older adults and non-New York City residents, are more susceptible to the adverse effects of ultrafine particles. The disparities our study uncovered underscore the necessity for public health agencies to focus on and protect highrisk populations. We quantified the long-term health impacts of exposure to these pollutants by combining mortality data from vital records in New York state and using a model that tracks how particles move and change through the air. Air pollution is now ranked the second-leading risk factor for death, accounting for about 8.1 million deaths globally and about 600,000 deaths in the United States in 2021.

Most air pollution standards and regulations have been focused on larger particulate matter, such as PM2.5 - which includes organic compounds and metal particulates - and PM10, a category that includes dust, pollen and mold.

In comparison, ultrafine particles are typically much greater in number and have a much larger surface area-to-volume ratio, allowing them to carry substantial amounts of hazardous metals and organic compounds. Furthermore, because of their smaller size, ultrafine particles can follow the air flow and get deep into the lungs when inhaled. These unique characteristics make ultrafine particles particularly dangerous, leading to a range of adverse health problems.

Despite this understanding, ultrafine particles remain largely unregulated, while larger particulates are regulated under the National Ambient Air Quality Standards.

Due to their unique characteristics, ultrafine particles require additional, tailored attention.

Britain set to ban disposable vapes

LONDON, Oct 28, (Agencies): The British government is set to ban the sale and supply of single-use vapes in England from next summer, it was announced on Thursday

The Labour party government has proposed the legislation in a bid to curb a rise in vaping among young people, protect the environment, and "end the nation's throwaway culture."

If the bill receives parliamentary assent, the ban would be introduced from June 1, 2025, the Department for Environment, Food and Rural Affairs has confirmed.

Vape use in England has more than quadrupled from 2012 to 2023, and 9.1 percent of the British public now buys and uses these products, according to the government.

The non-profit organization Material Focus has estimated that five million single-use vapes were either discarded as litter or thrown away in general waste every week in the UK last year, the equivalent of eight vapes being discarded per second.

Banning disposable vapes will not only protect the environment, but importantly reduce the appeal of vapes to children, and keep them out of the hands of vulnerable young people," said Andrew Gwynne, minister for public health and prevention.

Despite the legal age of 18 for purchasing and using vaping products, figures published in August by Action on Smoking and Health (ASH) indicated that around 20 percent of young people aged 11 to 17 have vaped in 2023 and 2024.

The latest statistics from the National Health Service (NHS) also show that a quarter of 11-to-15-year-olds have tried vaping, and nearly one in 10 do it fre-

Daylight saving time ends at 2 a.m. local time next Sunday, Nov. 3, which means you should set your clock back an hour before you go to bed. Standard time will last until March 9 when we will again "spring forward" with the return of daylight saving time.

That spring time change can be tougher on your body. Darker mornings and lighter evenings can knock your internal body clock out of whack, making it harder to fall asleep on time for weeks or longer. Studies have even found an uptick in heart attacks and strokes right after the March time change.

"Fall back" should be easier. But it still may take a while to adjust your sleep habits, not to mention the downsides of leaving work in the dark or trying exercise while there's still enough

Some health groups, including the American Medical Association and American Academy of Sleep Medicine, have said it's time to do away with time switches and that sticking with standard time aligns better with the sun - and human biology.

Most countries do not observe daylight saving time. For those that do mostly in Europe and North America - the date that clocks are changed varies.

Two states - Arizona and Hawaii don't change and stay on standard time. Here's what to know about the twice

yearly ritual. The brain has a master clock that is set by exposure to sunlight and darkness. This circadian rhythm is a roughly 24-hour cycle that determines when we become sleepy and when we're more

evening, levels of a hormone called melatonin begin to surge, triggering drowsiness. Too much light in the evening - that extra hour from daylight saving time - delays that surge and the cycle gets out of sync.

And that circadian clock affects more than sleep, also influencing things like heart rate, blood pressure, stress hormones and metabolism.

Even an hour change on the clock can throw off sleep schedules - because even though the clocks change, work and school start times stay the same.

That's a problem because so many people are already sleep deprived. About 1 in 3 US adults sleep less than the recommended seven-plus hours nightly, and more than half of US teens don't get the recommended eight-plus hours on weeknights.

India names three uncapped players

DELHI, India, Oct 28, (AP): Rohit Sharma will lead an 18-man squad as India looks to defend the Border-Gavaskar Trophy across five tests against Australia starting November 22.

India will look to bounce back from its first home test series loss in 12 years against New Zealand in order to confirm qualification for the 2025 World Test Championship final.

It needs to win four of its remaining six tests this WTC cycle and will be aiming for a third straight test win in Australia following 2-1 victories in 2018-19 and 2020-21.

Three uncapped players have been named to a squad missing pacer Mohammed Shami. Opening batter Abhimanyu Easwaran is included, along with all-rounder Nitish Reddy and pacer Harshit Rana.

The remainder of the squad is along expected lines - young batters Yashasvi Jaiswal and Shubman Gill to lead the charge, along with Virat Kohli, who has averaged 54.08 in 13 tests in Australia. Lokesh Rahul has been included, despite inconsistent form, along with Sarfaraz Khan, who scored 150 against New Zealand in Bengaluru.

Rishabh Pant and Dhruv Jurel are the two keeper-batters. Pant was the architect of India's last series' win in Australia, playing a match-winning knock at the Gabba. Brisbane will host the third test.

Three spinners were also named with Ravichandran Ashwin and Ravindra Jadeja, both possibly

facing their last Australian tour, joined by Washington Sundar, who picked 11 wickets in the second test against New Zealand.

For the first time since 1991-92, Australia will host India in a fivetest series and it will become the norm for the Border-Gavaskar Trophy in the future. Melbourne and Sydney will host the Boxing Day and New Year's tests as per Australian tradition.

India has also named its T20 squad that will travel to South Africa for a four-match series starting November 8. Suryakumar Yadav leads the T20 side once again, with all-rounder Shivam Dube, batter Riyan Parag and pacer Mayank Yadav missing due to injuries.

Durban, Gquberha, Centurion and Johannesburg will host the four games, with the series ending on November 15.

Norris tightens championship fight

Sainz wins Mexico City Grand Prix

MEXICO CITY, Oct 28, (AP): Carlos Sainz Jr. got the win he desperately wanted in the final days of his Ferrari career. The Formula 1 title race, meanwhile, grew a lot more contentious. Sainz won the Mexico City Grand Prix on Sunday and Lando Norris closed the gap on Max Verstappen after another furious battle that cost the reigning three-time series champion three penalties and shaved 10 points off Verstappen's lead in the standings.

Sainz not only won but finished on the podium for the first time in Mexico City. It was the fourth win of his career, and second of the season for the driver who is being replaced by Lewis Hamilton next year at Ferrari. The Spaniard had never before won two races in a season. "Honestly, I really wanted this one," said Sainz, who sounded emotional on his radio on the cool-down lap. "I really needed it for myself, I wanted to get it done. I've been saying for a while I wanted to get one more win before leaving Ferrari, and to do it here in front of this mega crowd, it is incredible."

Verstappen started second and took the lead from pole-sitter Sainz on the start, but the first lap quickly drew a caution when contact between Yuki Tsunoda and Alex Albon caused Tsundona to crash and Albon to retire with damage to his car.

The restart was spicy with the Ferraris racing Verstappen and Norris for position. And for a second consecutive week, the title contenders clashed.

Norris was penalized last week. This time it cost Verstappen two penalties totaling 20 seconds. After the race, the FIA

also penalized Verstappen two points to give him six for the 12-month period.

"I knew what to expect. I don't want to expect such a thing, because I respect Max a lot as a driver, but I was waiting to expect something like this," Norris said of Verstappen's driving. "Not very clean driving in my opinion, but I avoided it."

Norris was penalized a week ago at the United States Grand Prix for forcing Verstappen off track - a punishment that gave the final spot on the podium to the three-time reigning world champion. It also allowed Verstappen to widen his lead in the driver standings to 57 points before the race Sunday.

The tables were turned at Autódromo Hermanos Rodríguez when Verstappen was given a 10-second penalty for banging wheels with Norris and forcing Norris off the track. "Ten? That's aggressive," Verstappen said.

He then was slapped with a second 10-second penalty for gaining position when he left the track for a combined

20-second penalty to be served on his first pit stop. "That's fine then. That's silly, man," Verstappen radioed.

He pitted from third on Lap 27 and his mechanics could not begin his service until the 20-second penalty was served. He dropped to 15th when he rejoined the race. Although Verstappen recovered to finish sixth, Norris spoiled what looked to be a Ferrari sweep when he snatched second place from Charles Leclerc with eight laps remaining.

China qualifies for U17 Asian Cup finals: China qualified for the AFC U17 Asian Cup finals as one of the five best second-placed teams in the qualification stage, the team confirmed late Sunday night after a 2-2 draw with South Korea in the final game of Group C.

South Korea topped the group, with China finishing second due to an inferior goal difference.

"We made it, China have reached the U17 Asian Cup finals as one of the best five second-placed teams," the Chinese team announced on its social media account.

Real faces investigation over racist insults to Barca's Yamal

MADRID, Oct 28, (Xinhua): Real Madrid face a likely sanction after FC Barcelona's Spain international winger Lamine Yamal was the victim of racist insults during his side's 4-0 thrashing of Real Madrid in Madrid's Santiago Bernabeu Stadium on Saturday night.

Videos on social media show the 17-year-old, whose mother is from Equatorial Guinea and whose father is from Morocco, receive various racist insults from a sector of Real Madrid fans as he celebrated scoring Barcelona's third goal in a 4-0 win in the 77th minute.

La Liga issued a statement stating they would "immediately report the racist insults and gestures received by Barcelona players to the Hate Crimes Section of the National Police Information Brigade, as well as informing the Co-ordinating Prosecutor of the Hate Crimes and Discrimination unit of the State Attorney General's office." The organization also "vehemently" condemned "the incidents at the Santiago Bernabeu and remains firm in its commitment to eradicate any kind of racist behavior and hatred inside and outside stadiums." Spain's Superior Sports Committee (CSD) also issued a statement, saying the behavior was "unacceptable," and "far removed from the values of coexistence and respect inherent in sport, and whose eradication requires the work of everyone and, in particular, the collaboration of the clubs." The CSD added that "the events that occurred during the course of this match will be analyzed by the State Commission against Violence, Racism, Xenophobia and Intolerance in Sport." This could result in Real Madrid receiving a fine and a possible closure of the section of the ground where the insults came from.

Real Madrid has been vocal in their condemnation of racism after their Brazilian winger Vinicius Jr has been the target of abuse on several occasions, and the club also posted a communique which "strongly condemns any kind of behavior involving racism, xenophobia or violence in football and sport, and deeply regrets the insults that a few fans uttered last night in one of the corners of the stadium." The club said it was investigating to "locate and identify the perpetrators of these deplorable and despicable insults so that the appropriate disciplinary and judicial measures can be taken." Vinicius has been the main focus of the battle against racism in Spanish grounds, but the player has so far failed to make any comments about the insults aimed at Yamal.

Man United fires Ten Hag after woeful start to season

MANCHESTER, England, Oct 28, (AP): Manchester United finally ran out of patience and fired manager Erik ten Hag on Monday after a troubled start to the season which has left the 20-time English champions languishing in the

Premier League amid a period of major upheaval at the storied club. Ten Hag, who was hired in 2022, won two domestic cups in his 2 1/2 years in charge but paid the price for leading United to just three wins in nine league games in the opening months of this campaign.

There have been four defeats in there, too, including heavy beatings by fierce rival Liverpool and Tottenham. A 2-1 loss at West Ham on Sunday was Ten Hag's last game in charge, with the Dutchman departing with United in 14th place in the 20-team standings. "Erik ten Hag has left his role as Manchester United men's first-team man-

ager," United said.

"We are grateful," the club added, "to Erik for everything he has done dur-ing his time with us and wish him well for the future."

United said Ruud van Nistelrooy, one of Ten Hag's assistants and a former striker at the club, would be taking over as interim head coach while a permanent head coach is recruited.

The team's next game is at home to Leicester in the English League Cup on Wednesday.

Ten Hag joined from Dutch giant Ajax and was tasked with the responsibility of bringing the good times back to a club that has been in decline since former manager Alex Ferguson retired in 2013.

Despite winning the League Cup in 2023 and the FA Cup this year, United

was showing no sign of improving on its worst league campaign in 34 years, having finished in eighth place last season.

Already 12 points behind first-place Manchester City in the Premier League, United - which never had a distinguishable style of play under Ten Hag - appears to have little hope of challenging for the title and is in danger of missing out on qualification for the lucrative Champions League once again.

Ten Hag only held onto his job following an unexpected victory over fierce rival Man City in the FA Cup final in May and an extensive end-of-year review by United. He was then handed a one-year extension to his contract to 2026.

However, the club's new soccer leadership - fronted by new minority owner Jim Ratcliffe - was clearly unimpressed with the pace of change under Ten

Hag. Ratcliffe, the British billionaire, has taken over control of United's soccer operations, with a new CEO, sporting director and technical director all installed in recent months. They now have to appoint a sixth permanent manager since Ferguson's departure, following David Moyes, Louis van Gaal, Jose Mourinho, Ole Gunnar Solskjaer and Ten Hag.

"I don't think anybody will be truly shocked after what happened yesterday," former United defender Gary Neville said of the latest loss to West Ham.

"The fact they are in 14th is just unacceptable. You can't be 14th after nine games with the level of spending that has occurred, without being under significant pressure.'

MADRID, Oct 28, (Agencies): Atletico Madrid can't find a way to end its slump.

Diego Simeone's team followed up its home loss against Lille in the Champions League with a 1-0 defeat at Real Betis in the Spanish league.

An own-goal by defender José María Giménez less than five minutes into the match sealed Atletico's second consecutive loss.

It has only one win in its last six matches in all competitions - a 3-1 victory over Leganes in the Spanish league last weekend. Before that, it had league draws at home against Real Madrid and at Real Sociedad, and it lost 4-1 at Benfica in the Champions League.
