THE scene of King Mohammed VI arriving to greet the French President conveyed several important messages for both the local and interna-

tional audience. The most important message among them was to dispel rumors regarding the King's health.

These rumors, which were circulated by certain media outlets outside Morocco, were intended to undermine Rabat's significant influence in the Arab world particularly in Africa.

The second of these messages targeted Europe in response to attempts, especially from

France, to exert pressure on Morocco, following a

period of heightened tensions in relations between the two countries throughout the past two years.

However, Morocco's firm stance compelled France to abandon its attempts to exert pressure, as evidenced by French President Emmanuel Macron's state visit.


This visit symbolized a reconciliation between Rabat and Paris, effectively turning the page on the differences that some countries sought to exacerbate in an effort to undermine Morocco's role in Africa.

Kuwait upholds cash payment rights

KD10 cash limit on domestic labor offices, car sales, temporary trade fairs and pharmacies

KUWAIT CITY, Oct 29: The Ministry of Commerce and Industry has confirmed that cash payment method is applicable in almost all commercial activities, except those for which a ministerial decision was issued prohibiting cash payment, such as domestic labor offices, car sales, temporary trade fairs and pharmacies if the transaction amount

The ministry reiterated that all other activities normally accept cash payment; stressing no point of sale has the

right to reject cash payment, as cash remains an essential part of the payment process in commercial activities. It affirmed that store owners can provide additional electronic payment methods as an option for consumers, in addition to cash payment, to ensure everyone's comfort and facilitate commercial transactions.

In another development, the Commercial Control Department at the ministry inspected the Perfume Exhibition to make sure that traders comply with the laws and regulations prohibiting the marketing and promotion of goods and services outside the boundaries of shops and booths.

This inspection is aimed at protecting consumers from any illegal promotion to ensure that sales and promotions are completed in a professional manner without inconveniencing or pressuring consumers who visit the booths and stores. This is in addition to protecting the rights of consumers and ensuring strict compliance with laws to guarantee a fair and safe commercial environment.

Protect women & children in war zones: Sheikha Jawaher

KUWAIT CITY, Oct 29, (KUNA): It is imperative to ratchet up efforts aiming to mitigate the ill effects of war and armed conflicts on women and children, in line with UN Resolution 1325, a Kuwaiti diplomat said on Tuesday.

War and armed conflicts often witness "grave violations" of human rights committed against women and children, both of whom are most vulnerable to the devastating effects triggered by the unrest, Kuwaiti Assistant Foreign Minister for Human Rights Affairs Sheikha Jawaher Al-Sabah told the UN International Conference on Women, Peace and Security in the Philippines' capital of Manila.

The Kuwaiti senior diplomat went on to highlight her country's commitment to UN Resolution 1325, which calls for the integration of women into conflict resolution and peacebuilding efforts, citing the formation of a national ad hoc committee tasked with working alongside global bodies to protect and enhance the rights of women, she said.

Kuwait has lately seen a spate of notable achievements made by women across various fields, chief among them the judiciary, diplomacy and security, she underlined, hailing these accomplishments as part of a national ambition to establish gender parity.

The FANA General Assembly was

The assembly was informed about the report related to preparing a specialized session by the FANA General Assembly regarding developing media people's skills on sustainable development, in implementation of the council of Arab media minis-

development to be held in 2025. State news agencies from the wider Arab region agreed on Monday that talks in Kuwait were paramount given the "status quo" around the world, highlighting such gather-

ings as instrumental in ratcheting up media

cooperation.

The 51st General Assembly of the Federation of Arab News Agencies (FANA) represents an effort to ensure that news agencies around the region are on the "same page" when it comes to relaying information with "accuracy and reliability" to the public, they said.

The talks come at a time of meteoric technological advancements in the media sector, said Qatar News Agency chief Ahmad Al-Rumaihi, citing the emerging Artificial Intelligence (AI) industry as chief among those changes, behooving news agencies to employ such methods in their day-to-day operations.

Significance

On the significance of the gathering, Oman News Agency chief Ibrahim Al-Azri said the region is going through a number of "unprecedented" political events, which call for more cooperation on pressing matters such as the "Palestinian cause," he underlined, while his Jordanian counterpart Fairooz Mubaideen highlighted the talks as a testament to the camaraderie within the

On the agenda for the talks that kicked off in Kuwait earlier on Monday, the Jordanian official said it runs the gamut from the AI industry to the role of Arab media in swaying public opinion, while Tunis-Afrique Presse news agency chief Najeh Missaoui cited the talks as a platform for knowledge exchange.

Arab news agencies have an imperative role in broadcasting trustworthy and factual information, mainly in light of current global events, Kuwait's Minister of Information and Culture and Minister of State for Youth Affairs Abdurrahman Al-Mutairi said on Monday.

Meeting with the Federation of Arab News Agencies' (FANA) head and members partaking in the 51st General Assembly currently hosted by Kuwait News Agency (KUNA), Al-Mutairi extolled the Federation's role in backing communication, and sharing news and information among Arab countries.

Right contractor, lots of patience key to erecting your dream home

Family, spouse opinion holds sway

KUWAIT CITY, Oct 29: Building a home is a dream for many citizens. Although the construction process may seem complicated, understanding the basic steps and structural elements and lots of patience can greatly contribute to the project's success and help avoid common mistakes.

To achieve a successful and stable construction, experts in the field stressed the importance of selecting the right engineering office to create precise internal and external designs and plans for the house. They also highlighted the need to consider the opinions of family members, including spouses and children.

The experts advised families to choose high-quality materials for all construction needs, including electrical and plumb-

ing installations, and to make the best use of available space. They warned against contractor fraud, which may involve the use of low-quality materials or manipulation of costs for materials and labor to achieve illegal profits. The experts explained that building a "dream house" re-

quires careful attention to details and thoughtful planning. These precise steps can help citizens in Kuwait achieve their goal of creating a comfortable and safe home. starting with the location of the land and its level in relation to

the surrounding streets. Factors such as whether the land is flat

or sloped, the dimensions and measurements of the plot, and its shape, whether rectangular or square, are crucial The house's facade poses a construction challenge, as it needs to consider its orientation (north, south, east, or west) to understand how wind and sunlight will affect the home. It is also important to take into account neighboring buildings

and nearby public amenities, such as mosques, schools, and **Financial**

Understanding costs, assessing financial capacity, and staying within the budget allocated for construction and finishing, as well as avoiding excessive debt are major challenges for those looking to build their dream home. It is important to consult family members, gather all opinions and preferences, and document all needs and notes.

In this regard, the Vice President of the International Society for Value Engineering in the Gulf States Dr. Eng. Bader Al-Dhaidi shared several tips for those wishing to build a

He advised the need to study the needs of the families, including those of children and spouses, and clearly define the

desired functions of each element in the building before starting the planning phase. Dr. Al-Dhaidi stressed that understanding family needs is important, as they are the primary beneficiaries of a home.

He highlighted a study presented at a conference as per which 88 percent of individuals who built their homes were dissatisfied because their requirements and needs were not taken into consideration beforehand. In contrast, only 12 percent reported satisfaction, which was mainly among those who learned from previous experiences and consulted a specialized

Dr. Al-Dhaidi urged individuals to be aware of their financial capacity and the budget allocated for construction and finishing, insisting that citizens should not overextend themselves, as this can lead to debt.

He indicated that some people end up building at costs beyond their means, which can result in construction projects getting halted for years due to their inability to cover financial

No entry in schools after official work hours: MoE

KUWAIT CITY, Oct 29: The Ministry of Education issued a

circular to schools and kindergartens about the new mechanism on regulating the entry of individuals to schools.

The circular emphasized the need to guarantee the safety of educational facilities and the school community by following the system in place. It stressed that no one is allowed to enter the school during or

after official working hours unless their data (name and identification number) are recorded in a special register. The reason for the visit must be specified as well, while a written permit must be obtained if the visit is outside official working hours.

This is part of the ministry's efforts to ensure compliance with the directives on the security and safety of educational facilities and their employees.

All concerned parties in schools and kindergartens have been instructed to adhere to the circular, whose stipulations were adopted in order to protect the school community and ensure a safe environment for everyone.

Gang of building material thieves from sites busted

KUWAIT CITY, Oct 29: In Criminal Security Department has arrested a gang of Asian workers engaged in theft and resale of construction materials from sites in Al-Mutla'a City and neighboring areas.

Acting on information submitted by a Kuwaiti citizen the plainclothes men began their investigations and arrested the suspects, who during interrogations confessed to systematically stealing and reselling construction materials at significantly reduced prices.

The large quantities of stolen goods were then seized from a warehouse in the Jleeb Al-Shuyoukh area.

4 years jail for lawyer: The Court of Appeals has upheld the verdict of a lower court and sentenced an unidentified lawyer to 48 months imprisonment with hard labor.

The administrative Decision No. 503/2024, which outlines the transfer of these 20 administrators to various departments, including the Financial Affairs Department, Food Laboratories, Information Systems Center, and the Imported Food Department, will take effect at the beginning of November next year.

27 traffic accidents per day in 2023

"This fund later evolved into the Kuwait Investment Authority (KIA), which currently manages assets exceeding \$978 billion, according to unofficial estimates.

"The KIA has played a critical role in maintaining the stability of the Kuwaiti economy, particularly during crises like the Iraqi invasion, enabling the state to sustain social welfare despite its heavy dependence on oil.

"Over the years, other countries have launched sovereign funds, although Kuwait retains a prominent position as one of the largest in the world.

"For instance, Abu Dhabi manages around \$1.7 trillion through its various sovereign funds, including ADIA, Mubadala, and ADQ, which have bolstered its global standing.

"Norway offers a successful model in sovereign fund management, having established its fund based on oil revenues in the 1990s

"Today, it boasts the largest sovereign fund globally, with assets exceeding \$1.6 trillion. Norway's fund has facilitated investment diversification away from oil, characterized by high transparency and effective governance, ensuring optimal resource utilization and providing a framework for balancing immediate benefits from resources with long-term financial sustainability. "In contrast, Saudi Arabia utilizes its

Public Investment Fund (PIF) to drive its Vision 2030 initiative, aiming to reduce oil dependency and diversify its economy by investing in strategic sectors such as technology, tourism, and renewable energy. "Unlike other sovereign funds, the

PIF focuses on domestic development and acts as a significant catalyst for economic transformation within the King-

"For the United States, which relies heavily on the private sector, natural resource revenues contribute only a small fraction to GDP.

"Therefore, establishing a sovereign fund would necessitate increased government intervention, such as raising taxes or borrowing, potentially exacerbating the fiscal deficit. Instead, the US could allocate its resources more effectively towards innovation and infrastructure, aligning with its economic structure and fostering sustainable

"While sovereign wealth funds have proven effective for countries reliant on natural resources, the notion of creating such a fund in the US may not be prag-

"The American economy is built on a competitive model where government intervention in investing surpluses could impede growth. "Ultimately, what works for Kuwait,

Norway, Abu Dhabi, and Saudi Arabia may not be the most suitable choice for the world's largest economy.'

Jleeb conditions spark urgent call for action

KUWAIT CITY. Oct 29: In a recent session, Kuwait's Municipal Council approved key initiatives aimed at supporting food storage infrastructure and enhancing public facilities.

Among the approved projects are strategic storage areas of 1,000 square meters in Adan and Mubarak Al-Kabeer for food warehouses, along with plans to reallocate sites for the Constitutional and Capital Markets Courts in Granada.

The Council also endorsed several proposals, including the establishment of a specialized training institute for Sadu handicrafts at the Sadu House and the addition of multi-storey parking at Amiri Hospital. A proposal to extend the service road parallel to Street No. 85 in Al-Shamiya was also approved.

Responding to member inquiries, the Council provided updates on service projects in Al-Jahra and discussed concerns over telecommunications towers. It also addressed citizens' complaints about secondary power stations in Al-Adiliya.

The Council referred several key proposals to its executive body for further review, including a proposal to allocate space for a zoo, create an entrance for Al-

Mutlaa City, and relocate a street in Abu Halifa.

It also discussed allowing charities to establish headquarters in investment buildings.

The Council's Deputy Chairman, Khaled Al-Mutairi, called for immediate action on the deteriorating conditions in Jleeb Al-Shuyoukh, emphasizing that the area's proximity to Kuwait Airport and Jaber Stadium makes its current state an issue of national importance.

Citing security concerns, infrastructure strain, and theft of public utilities, Al-Mutairi urged the Council to expedite improve-

In his speech at the celebration of Austria's National Day recently, Frank stressed that "we are committed to making the council more effective and accountable, including our candidacy for a non-permanent seat in the 2026

Assistant Minister of Foreign Affairs for Europe Mohammad Yaqoub Hayati attended the event.

Frank also confirmed the political consultations between the two countries' ministries a few months ago. "I am confident that strengthening diplomatic relations between our countries, which have lasted about 60 years, will continue to be beneficial for Kuwait and Austria. A new dimension of horror has been unleashed in the Middle East a little over a year ago, as the violence being practiced on both sides

-- Palestinians and Israelis -- and the civilian population throughout the region is heartbreaking. It is clear that Austria stands by international law. Protecting innocent civilians in Gaza and Lebanon, as well as the hostages, is irreversible. We need to de-escalate on all fronts. We must do everything in our power to end the humanitarian catastrophe that is happening now. This requires an immediate ceasefire in Gaza, Lebanon and all possible fronts to allow humanitarian aid and finally release the hostages, including the Austrians," he added.

He also emphasized that "we must make room for diplomacy again. A negotiated two-state solution is the only way to achieve lasting peace, so the

Israelis and Palestinians can live side by side in peace.'

He pointed out that the war of agression launched by Russia against Ukraine has made it clear that the enemies of an open society with its corresponding values and a rules-based international order continue to pose a serious threat to people's way of life in Europe as well and not far from Austria's eastern border. Unfortunately, many other regions are also facing the scourge of war, civil war, terrorism and all the disastrous consequences, he as-

serted. He stressed that Austria is not just an observer of the events taking place in this region: as part of UNIFIL, there are 170 Austrian soldiers on duty along the Blue Line, alongside Blue Helmets from many other countries. Regarding regional developments, Lavrov said the talks categorically rejected the random bombing of civil neighborhoods in Gaza, the killing of civilians and other violations of international humanitarian law.

He affirmed the need of taking urgent measures to reach a ceasefire and open humanitarian corridors to

avoid further killing.

He demanded hastily creating proper conditions to resume comprehensive talks with Palestinians and Israelis as soon as reaching a

Lavrov expressed Russia's categorical rejection of displacing Palestinians to Egypt's Sinai Peninsula. He said this idea runs counter to

the interest of Egypt and Palestinians, and to peace endeavors in the

On Syria, Lavrov said the talks affirmed the need of reaching a comprehensive settlement based on the relevant Security Council resolutions regarding maintaining Syria's sovereignty and territorial integrity.

Kuwait humanitarian contributions embody its national principles of extending a helping hand and supporting people affected by disasters everywhere, he said.

He urged world countries to stop exporting weapons to the Israeli occupying entity and to press it to end its criminal war on Palestine and Lebanon.

He called for achieving a permanent truce for protecting civilians and putting an end to the ongoing systematic violations and crimes against the Palestinian and Lebanese peoples.

Elsewhere, an Israeli strike on a five-story building where displaced Palestinians were sheltering in the northern Gaza Strip killed at least 60 people early Tuesday, more than half of them women and children, Gaza's Health Ministry said.

In a separate development, Lebanon's militant group Hezbollah said it has chosen Sheikh Naim Kassem to succeed longtime leader Hassan Nasrallah, who was killed in an Israeli airstrike last month. Hezbollah vowed to continue with Nasrallah's policies "until victory is achieved."

Israel also faced backlash after passing legislation that could severely restrict the ability of the U.N. agency for Palestinian refugees to operate in the Palestinian territories. The agency, known as UNRWA, is the largest aid provider in Gaza. Israel has long accused it of militant ties, allegations it denies.

A spokesperson for the U.N. children's agency said the decision "means that a new way has been found to kill children."

Hezbollah said in a statement that its decision-making Shura Council elected Kassem, who had been Nasrallah's deputy leader for over three decades, as the new secretary-general.

Kassem, 71, a founding member of the militant group established following Israel's 1982 invasion of Lebanon, had been serving as acting leader. He has given several televised speeches vowing that Hezbollah will fight on despite a string of setbacks.

Hezbollah began firing rockets into Israel, drawing retaliation, after Hamas' surprise attack out of Gaza on Oct. 7, 2023, triggered the war there. Iran, which backs both groups, has also directly traded fire with Israel, in April and then again this month.

The tensions with Hezbollah boiled over in September, as Israel unleashed a wave of heavy airstrikes and killed Nasrallah and most of his senior commanders. Israel launched a ground invasion into Lebanon at the start of October.

Hezbollah fired dozens of rockets into northern Israel on Tuesday, killing at least one person in the northern city of Maalot-Tarshiha, authori-

Even as attention has shifted to Lebanon and Iran in recent weeks, Israel has continued to wage a large operation in northern Gaza and to carry out airstrikes across the territory.

Dr. Marwan al-Hams, director of the field hospitals' department at the Gaza Health Ministry, announced the toll from Tuesday's strike in the northern town of Beit Lahiya at a news conference. He said another 17 people are missing.

'Sign of deepening relations'

N.Korea sends top diplomat to Russia as its troops train to fight in Ukraine

SEOUL, South Korea, Oct 29, (AP): North Korea said Tuesday its top diplomat is visiting Russia, in another sign of their deepening relations as rival South Korea and Western nations say the North has sent thousands of troops to support Russia's war in Ukraine.

North Korea's official Korean Central News Agency said a delegation led by Foreign Minister Choe Son Hui departed for Russia on Monday, but didn't specify the purpose of the visit. In a closed-door hearing at South Korea's parliament, the South's spy agency said Choe may be involved in highlevel discussions on sending additional troops to Russia and negotiating what the North would get in return, according to Lee Seong-kweun, a lawmaker who attended the meeting.

The announcement of Choe's visit came hours after the Pentagon said North Korea has sent about 10,000 troops to Russia, who are expected to arrive in battlefields in Ukraine within "the next several weeks."

South Korean and Western leaders have expressed concern that North Korean involvement could help prolong Russia's aggression in Ukraine,

and that Russia may offer technology in return that could advance the threat posed by North Korea's nuclear weapons and missile program.

Pentagon spokesperson Sabrina Singh told reporters Monday that some of the North Korean soldiers have already moved closer to Ukraine and were believed to be heading for the Kursk border region, where Russia has been struggling to push back a Ukrainian

South Korea's National Intelligence Service told lawmakers it's examining the possibility that some groups of North Korea's military personnel in Russia, including generals or other high-ranking officials, may have already moved to frontline areas. The spy agency also said the two sides appear to be struggling to resolve communication issues although the Russian military is training North Korean troops on Russian military terminology, Lee said.

The agency said space-based reconnaissance is an area where North Korea is likely receiving Russian help. It said North Korea may be acquiring advanced components from Russia as

it prepares to launch another military reconnaissance satellite following a failed attempt in May, said Park Sunwon, another lawmaker who attended the hearing.

North Korea first placed a spy satellite in orbit last November. Its leader Kim Jong Un has described those assets as crucial for monitoring South Korean and U.S. military activities and

enhancing the threat of his nuclearcapable missiles.

South Korean President Yoon Suk Yeol in telephone calls with European Union Commission President Ursula von der Leyen and NATO Secretary-General Mark Rutte on Monday shared South Korean intelligence assessments that North Korean troops could be deployed to battlefronts "more quickly than anticipated." He called for closer coordination with European governments aimed at "monitoring and blocking "illegal exchanges between Pyongyang and Moscow, Yoon's office said in a statement.

After initially denying the claims about North Korean troop deployments, Pyongyang and Moscow have adopted a vaguer stance, asserting that their military cooperation conforms with international law without directly admitting the presence of North Korean forces in Russia.

North Korea has also been accused of providing millions of artillery shells and other military equipment to Russia to fuel its war in Ukraine. The United States and its partners have described Russia's procurement of North Korean personnel and supplies as a violation of U.N. Security Council resolutions, and raised suspicions that Moscow is helping Pyongyang to evade sanctions and unlawfully finance its weapons program.

Russia, along with China, has blocked U.S.-led efforts at the Security Council to tighten sanctions on North Korea over its recent missile testing activities, which intensified after Russia's invasion of Ukraine in 2022. Russia also vetoed a U.N. resolution to extend the mandate of a panel of monitors in March in a move that effectively abolished oversight by U.N. experts of Security Council sanctions against North Korea. It prompted Western accusations that Moscow was acting to shield its arms purchases from Pyong-

yang.
"The illegal military collusion between Russia and North Korea poses a significant security threat to the international community and a serious matter that could potentially harm our security. We must thoroughly examine all possibilities and prepare countermeasures," Yoon said in a Cabinet meeting in Seoul on Tuesday.

Arab American voters make their choice – Harris, Trump or neither – in election's final days

DEARBORN, Mich., Oct 29, (AP): Bowls of labneh and platters of za'atar bread covered the tables in a Lebanese restaurant near Detroit, yet no one seemed to have much of an appetite.

On one side were Kamala Harris 'top emissaries to the Arab American community. On the other were local leaders who were explaining - once again - why many in the community couldn't vote for the vice president because of the war in Gaza.

"I love this country, but I'll tell you, we have never been so disappointed in this country as we are now," said Nabih H. Ayad, chairman of the Arab American Civil Rights League. "We wanted to give the Democratic Party the opportunity to do something, and they haven't.

"The one line we can't cross," Ayad said, "is geno-

Nasrina Bargzie and Brenda Abdelal, who were hired by Harris' campaign to spearhead Arab and Muslim outreach, listened intently but said little in

If Harris loses Michigan and the presidential election next week, it's conversations like this one that could explain why. The Detroit area has the country's largest concentration of Arab Americans, and Democrats fear that Harris will pay a steep political price for US support for Israel, which rejects allegations that its military operations in Gaza constitute a genocide.

Community members who normally back Democrats said they face an impossible decision. Either they punish Harris for what they view as complicity in the deaths of at least 43,000 Palestinians, according to Gaza's Health Ministry, or they endure Donald Trump 's return to the White House, which they fear would

revive discrimination toward their community.

A reminder of the situation's complexity came in Ann Arbor on Monday night, when Harris held a campaign rally. Assad Turfe, one of the few Arab American elected officials in Michigan to endorse the vice president, said his community needs someone "who sees us, who understands us and who will give voice to our pain," adding that "without a doubt that Kamala Harris is that leader.'

But as Harris began her remarks, pro-Palestinian protesters interrupted by chanting, "Israel bombs, Kamala pays, how many kids have you killed today?" Harris responded, "hey guys, I hear you" and "we all want this war to end as soon as possible.'

It's unclear how many skeptics Harris will be able to win over, especially since she has not proposed any concrete changes on US policy toward Israel or the war in Gaza. Four years ago, Joe Biden won by a 3-to-1 margin in Dearborn, where nearly half of the 110,000 residents are of Arab descent. Now Democrats are concerned some of these voters will go to Trump or thirdparty candidates like Jill Stein.

They're split. There are those who will vote for Harris, recognizing that they could get a seat at the table," said US Rep Ro Khanna, D-Calif., who convened the recent meeting at the Lebanese restaurant in his efforts to help the Harris campaign. "But there's a chunk that will vote for Stein or stay at home. Then there's a minority who will vote for Trump.'

Trump has secured a number of endorsements from Muslims in the area, including from two Democratic mayors who represent Muslim-majority cities outside Detroit. He brought several Muslims on stage at a rally in metro Detroit on Saturday.

He argues he will put "a stop to the endless wars" and notes the Abraham Accords that Israel signed with several Arab nations during his presidency. He has also mocked Harris' embrace of former Rep Liz Cheney, a conservative Republican whose father, former Vice President Dick Cheney, was a key force behind the US invasion of Iraq. Harris is campaigning with Liz Cheney to try to pull away moderate Republicans turned off by Trump in Michigan and elsewhere.

But many top Arab American leaders - even those

who have not endorsed Harris - are still deeply negative toward Trump and say his endorsements don't reflect a majority of the community. They also remember his call for a "total and complete shutdown" on Muslims entering the country and his travel restrictions on visitors from Muslim-majority countries. And some point out that Trump has suggested that he would give Israel even more leeway to attack its rivals

Turfe, a Lebanese American and the deputy executive of Wayne County, is among the few Arab American leaders in Michigan to have endorsed Harris. He says it's to ensure the community doesn't return to a Trump presidency that "opened up old wounds for the generation that lived through those post 9/11 years."

Turfe said he was jolted awake by immigration agents in 2005 when they came to detain his wife, who had come to the country when she was 2 years old and

was unaware that she didn't have legal citizenship. "They came for her and they ripped my family apart," he said.

Then in 2006, Turfe's two grandmothers were killed in Lebanon as Israel fought with Hezbollah in a war backed by President George W. Bush.

Orbán boosts Georgia's ruling party over election despite outcry vote was rigged

TBILISI, Georgia, Oct 29, (AP): Hungarian Prime Minister Viktor Orbán gave a boost Tuesday to Georgia's ruling party, saying its victory in a parliamentary election in the South Caucasus nation was free and democratic despite a massive opposition protest that denounced the vote as rigged and illegitimate.

Orbán, Russian President Vladimir Putin's closest partner in the European Union, is the first foreign leader to visit Georgia following Saturday's vote that the country's electoral commission said was won by the ruling Georgian Dream party.

Georgia's president and opposition said the election was "stolen" with the help of Russia, claiming there was widespread ballot fraud and violence, with the EU and the U.S. calling for a full investigation.

But Orbán gave a different assessment after meeting with his counterpart, Prime Minister Irakli Kobakhidze, and congratulating him on the victory by his Georgian Dream party. "I look at the debate that has erupted around the election, I

read the evaluations of international organizations, and I see that no one dares to question that this election was a free and democratic choice," Orbán said. People rallied outside parliament Monday night, demand-

ing a new election under international supervision and an investigation into the alleged vote rigging. The protest underlined tensions in the country which lies between Russia

and Turkey and where the Georgian Dream party has become increasingly authoritarian and tilted toward Moscow.

Orbán was booed after arriving at his hotel in Tbilisi on Monday evening. Protesters called him a "political prostitute" and "puppet" in Russian and Hungarian, using exple-

tives to tell him to leave the country.

Kobakhidze said Orbán's visit had "particular significance" as it takes place during Hungary's presidency of the Council of the European Union although the bloc said he doesn't have any mandate for the visit.

Georgian Dream told voters it is committed to joining the EU despite the fact Brussels suspended Georgia's membership process after the party adopted a Russian-style "foreign influence law" in June that critics say curbs press freedom.

Pursuit of EU membership and NATO is written into Georgia's constitution and many in the country of 3.7 million viewed Saturday's vote as a pivotal referendum on the opportunity to join the bloc.

Georgian Dream, established by Bidzina Ivanishvili, a shadowy billionaire who made his fortune in Russia, has adopted laws similar to those used by the Kremlin to crack down on freedom of speech and LGBTQ+ rights.

Orbán said it was clear "the opposition and the ruling party are committed to European integration," rejecting opposition claims that Georgian Dream opposes it.





Russian drones, missiles and bombs smashed into Kyiv and Kharkiv, Ukraine's biggest cities, in nighttime attacks, killing four people and wounding 15 in a continuing aerial onslaught, authorities said Tuesday.

Russia has bombarded civilian areas of Ukraine almost daily since its full-scale invasion of its neighbor almost three years ago, causing thousands of casualties. The Russian army is also pushing hard against front-line defenses in the eastern Donetsk region of Ukraine.

In another worrying development for Kyiv officials, Western countries say North Korea has sent some 10,000 soldiers to help Russia's military campaign.

Ukrainian President Volodymyr Zelenskyy was expected to speak about that new threat at a meeting Tuesday in Reykjavik with the leaders of Denmark, Iceland, Finland, Norway and Sweden.

A Russian aerial attack struck Kharkiv, in Ukraine's northeast, at around 3 a.m., hitting a house and killing four people, regional Gov. Oleh Syniehubov said. Nearly 20 houses were damaged in the attack, he said.

Several hours earlier, Russia dropped a glide bomb on the landmark Derzhprom building in Kharkiv city center, injuring seven people, Mayor Ihor Terekhov said.

Derzhprom, also known as the Palace of Industry, is included in UNESCO's World Heritage List as an example of modernist architec-

US warns of visa restrictions for people who undermine Ghana's democracy

ACCRA, Ghana, Oct 29, (AP): The U.S. State Department has warned that it would restrict U.S. visas for people who undermine Ghana's democracy, ahead of the West African country's general election in December.

Ghana has held peaceful, free, fair and transparent elections for nearly two decades. The presidential and parliamentary elections will be held concurrently on Dec. 7. It will be the ninth consecutive general election since the country's return to multiparty democracy in 1992.

But allegations of voter roll irregularities this year have created concerns about a possible democratic backslide.

U.S. Secretary of State Antony Blinken was quoted as saying in a statement that the visa policy announced Monday would be directed only at people "who undermine democracy" and not at the government

or people of Ghana. Last month, Ghana's biggest oppo-

sition party, the National Democratic Congress, or NDC, held nationwide protests demanding an audit of the voter roll, alleging it detected thousands of unauthorized transfers and erasures of voter names.

Current President Akufo-Addo is stepping down this year after his second and final four-year term. Former President John Dramani Mahama of the NDC, who lost in the 2016 and 2020 elections, will face off with Vice President Mahamudu Bawumia of the New Patriotic Party in this year's election.

Last year, the U.S. State Department announced a similar policy of visa restrictions ahead of the Nigerian general election, restricting entry to people "believed to be responsible for, or complicit in, undermining democracy in Nigeria."

More than 150 hurt in India fireworks explosion

NEW DELHI, Oct 29, (AP): A huge explosion of fireworks injured more than 150 people at a religious festival in a temple in southern India, a report said Tuesday.

The explosion occurred Monday night when a fireworks storage facility near Veerarkavu temple caught fire, the Press Trust of India reported, citing the police. It happened in Kasargod, which is nearly 580 kilometers (360 miles) northwest of Thiruvananthapuram, the Kerala state capital,

The injured were treated at various hospitals in Kasargod, Kannur, and Mangaluru districts. Eight of them had serious injuries.

There is a huge demand in India for firecrackers, which are used in religious festivals and weddings. Fatal accidents occur nearly every year as people work in makeshift factories without proper safety measures. An explosion at a fireworks fac-

tory in southern India July last year killed eight people. In 2018, a massive fire at a firecracker factory in New Delhi killed 17 workers. A year earlier, a blast killed 23 people while they were making firecrackers in a village in Madhya Pradesh state in central India.

Market makers' trading in Kuwait surges to KD 2 billion in 9 months

KUWAIT CITY, Oct 29: Market makers' trading in operational stocks covered by their services surged nearly 100 percent in the first nine months of this year, ending on September 30, reaching almost two billion dinars, up from approximately one billion dinars during the same period in 2023, reports Al-Rai daily.

Transactions conducted by investment companies licensed as market makers accounted for about 20 percent of total trading in this timeframe, a significant increase from around 14 percent in 2023. This percentage represents the highest market-making activity in the region, underscoring the service's efficiency in meeting key market demands.

The activity of market makers on the shares of 47 banks and companies -- about 32 percent of those listed on the stock exchange -- has shown significant momentum since the beginning of the year. Trading volumes increased by approximately 35.8 percent, totaling 10.1 billion dinars compared to 7.5 billion dinars by September 30, 2023.

While market-making results vary between active and illiquid stocks, many investment companies specializing in this field have successfully adapted to these challenges. The stock exchange provides a flexible regulatory environment that supports marketmaking activities, backed by a framework approved by the Capital Markets

Ål-Bahar emphasized that NBK Group is actively pursuing the growth of its wealth management business in the Kingdom through NBK Wealth. The bank is also focused on expanding its offerings to clients by introducing a range of funds and other wealth management services.

Furthermore, she highlighted that NBK is actively engaged in this year's edition of the FII taking place in Riyadh, represented by a significant delegation. Throughout the conference, the delegation held numerous meetings and successfully concluded several financing agreements with prominent Saudi companies across various sectors, underscoring the bank's strong commitment to supporting Saudi Vision 2030.

Besides the Saudi market, NBK is also focused on the Egyptian market, which is one of the Group's key growth areas.

Geopolitical Risks

On the topic of geopolitical risks and their implications for the economies of the GCC region, Al-Bahar remarked that these challenges are not unfamiliar to the area. She underscored that, despite the increasing tensions, the macroeconomic impacts have predominantly remained confined to the countries directly engaged in the conflict.

Al-Bahar highlighted that the circumstances for GCC countries are unique, as they consistently demonstrate resilience in navigating crises, particularly through government support provided to various economic sectors during challenging times.

She referenced the support provided by the Government of Kuwait during the COVID-19 crisis, which involved postponing and easing restrictions for banks and SMEs. She also highlighted the enactment of legislation to guarantee bank deposits during the global financial crisis of 2008.

On banks prioritizing social impact and sustainability principles

NBK Wealth engages in insightful panel discussion at Future Investment Initiative

The panel featured a diverse array of experts, including Andrew Bester, Member of the Management Board and Head of Wholesale Banking at ING Group, and Dr. Sidi Ould Tah from the Arab Bank for Economic Development of Africa (BADEA). These distinguished leaders contributed a wealth of knowledge and diverse perspectives, enriching the dialogue on the essential role banks play in fostering social impact.

A Commitment to Social Impact

A central theme of the discussion was whether banks should prioritize social impact amid ongoing economic pressures and market volatility. Al-Hamad underscored that social impact must be integral to a bank's daily operations, fundamentally shaping its culture and decision-making processes. He emphasized the necessity of defining social impact in relation to specific geographies and local needs, essential for driving sustainable change and empowering communities. This sentiment was echoed by Bester and Dr. Ould Tah, who agreed that banks must recognize their societal roles beyond profit-making.

The conversation delved into the finance industry's commitments to social responsibility and sustainability, raising questions about the potential for lasting change versus a return to traditional profit-driven models. The panel engaged in a series of compelling questions that prompted an in-depth examination of banks' responsibilities in today's financial landscape.

Participants explored the opportunities presented by a \$4.5 trillion circular economy, particularly for banks seeking impactful investments. They discussed how banks can effectively communicate to investors that socially responsible investing can yield positive financial returns, particularly in sectors such as renewable energy, waste management, and sustainable agriculture. Al-Hamad noted that such investments not only align with long-term growth but also cultivate a healthier population, thereby boosting demand for banking services.

NBK's Triple Bottom Line Approach

Al-Hamad highlighted that NBK leads the charge in this movement, exemplifying a strong commitment to social impact investing through its Triple Bottom Line approach, which balances people, planet, and profits. In 2023, NBK launched its inaugural three-year Environmental, Social, and Governance (ESG) strategy, setting ambitious targets, including a goal of accumulating \$10 billion in sustainable assets by 2030 to facilitate a transition to a low-carbon economy.

The panel also addressed the call from the United Nations Environment Programme Finance Initiative (UNEP FI) for banks to embed circularity into their strategies. In April 2024, NBK joined the Partnership for Carbon Accounting Financials (PCAF) to quantify and disclose its financed emissions, enhancing its understanding of environmental impacts and supporting more impactful initiatives.

Leveraging Technology for Impact

The discussion also emphasized the role of technology in bridging the information gap that often hinders social impact initiatives. Al-Hamad remarked, "Leveraging technology is essential to enhance our understanding of social impacts, enabling stakeholders to make informed decisions." As investors increasingly seek data-driven insights, banks must harness technology to facilitate access to crucial information.

Panelists highlighted the potential for International Sustainability Standards Board (ISSB) standards to transform impact disclosures, anticipating advancements in technology that would make disclosures regarding social and environmental impacts and social and environmental impacts and social and environmental impacts.

more frequent and automated. Enhanced tracking across supply chains can improve transparency, while data analytics and artificial intelligence can bolster reporting and accountability.

Innovation in a Competitive Landscape

The panel addressed the pressing need for banks to innovate in a competitive landscape, particularly in response to the agility and customer-centric focus of fintech companies. Al-Hamad emphasized that to drive meaningful societal impact, banks must embrace innovation. Traditional banks are increasingly investing in technology and digital initiatives, leveraging advanced data analytics to gain insights into customer preferences and tailor their offerings.

Al-Hamad highlighted NBK's commitment to continuous learning and development, empowering teams to adopt innovative practices. He cited the launch of Weyay Bank in 2021, the first end-to-end digital bank in Kuwait, which emphasizes financial literacy and caters to the underserved youth demographic.

Government Initiatives and Sustainable Finance

The panel also examined the role of government initiatives in fostering sustainable finance and their impact on market dynamics. While such initiatives aim to encourage investments in renewable energy and sustainable technologies, it is crucial that they do not simply redirect capital to meet regulatory criteria without achieving meaningful change.

Al-Hamad acknowledged that aligning with international regulatory requirements has become vital for transforming business models. He noted that stricter regulations are compelling banks to adopt ambitious strategies for mitigating environmental and social impacts. Al-Hamad reaffirmed NBK's commitment to ensuring the integrity of its sustainability initiatives, emphasizing that its ESG strategy is woven into the bank's operations with oversight from its board of directors. In 2024, NBK became the first bank in Kuwait to issue a \$500 million Green Bond, underscoring its dedication to facilitating genuine sustainable outcomes.

As the discussion concluded, panelists emphasized the urgent need for banks to redefine their core purpose to reflect a commitment to positive societal impact. Reflecting on the insights shared, the panelists underscored the collective responsibility of the banking sector to transcend traditional profit motives. The call to action for financial leaders was clear: redefine your bank's core purpose and embrace the opportunity to be a true force for positive change.

Burgan Bank announces its financial results for first nine months of 2024

Reporting KD 165 million in revenue and KD 33 million in net profit

KUWAIT CITY, Oct 29: Burgan Bank Group ("Burgan" or "the Bank") announced its financial results for the ninemonth period ended September 30, 2024 (9M'24).

The Group reported KD 165 million in revenues for 9M'24, improving by 5% y-o-y, compared to KD 157 million during the same period in 2023. The increase in revenues wasmainly driven by higher Net-Interest Income of KD 112 million, up 23% y-o-y, while Non-Interest income remained solid at KD 53 million.

The Group's Net Interest margin also increased to 2.2% for the current period as compared to 1.9% in 9M'23,

improving by 30bps y-o-y.

Driven by higher revenues, the Group reported a solid net income of KD 33 million, compared to KD 30 million for the same period in 2023, marking a strong growth of 10% y-o-y.

The Group delivered strong asset growth of 11% y-o-y in 9M'24, reaching KD 7.8 billion by the end of the period. The Group's loan book grew by 6% y-o-y, reaching KD 4.4 billion; primarily driven by its Kuwait operations. Burgan's deposit base also expanded by 14% y-o-y and stood at KD 5.0 billion by the end of 9M'24.

The Group reported significant improvement in its asset quality metrics with Non-performing Loan (NPL) ratio of 1.9% in 9M'24 compared to 2.5% reported last quarter (6M²24) – translating into on a sequential (q-o-q) improvement of ~60bps. Further, the Group's Provision Coverage Ratio was also strong at 218% at the end of 9M'24.

The Group continues to maintain solid and healthy capital levels, with Common Equity Tier 1 ratio (CET1) of 12.9%, Tier I capital ratio of 15.2% and Capital Adequacy Ratio (CAR) of 19.0%, well above the regulatory requirements and demonstrating sufficient capital buffers to support future growth.

Commenting on Burgan's financial results, the Bank's Chairman, Sheikh Abdullah Nasser Al-Sabah, said:"During this year, we witnessed consistent innovation-driven growth and development across core areas of Burgan Bank's operations, as we continue to push ahead with our evolution-focused strategy. Our financial core remains strong and our foundations solid, as we carefully balance risk with reward in pursuit of development. These past nine months have seen us make considerable long-term investments across our entire business, including fortifying our digital infrastructure and enhancing our digitally smart solutions; further evolving our customer experience online and off; expanding our tailored offerings to all segments of customers; and investing in the growth, development and well-being of our human capital.'

The Chairman further added: "Guided by our core vision to become the most progressive and modern bank in Kuwait, we remain committed to offering bestin-class financial services and tailored solutions that create sustainable, longterm value for our customers, employees and shareholders, while adhering to the global standards of Environmental. Psoriasis affects over 76,000 people in Kuwait: experts

KUWAIT CITY, Oct 29: The Ministry of Health, represented by Al-Amiri Hospital, observed World Psoriasis Day to raise community awareness about this skin disease, support those affected, and enhance the understanding of the condition among healthcare professionals, including doctors, nurses, psychologists, and social workers. During the celebration, Hospital Director Dr. Arej Al-Kandari informed reporters that psoriasis is prevalent in Kuwait at rates consistent with global statistics. He emphasized the ministry's commitment to providing the latest treatments available worldwide.

Dr. Al-Kandari explained that the primary aim of celebrating this day, which occurs annually on October 29, is to inform all segments of society about the nature of psoriasis and the latest developments in its treat-

This includes correcting miscon-

ceptions, recognizing the importance of the target group, assisting them, and offering support to alleviate their suffering. He highlighted the collaboration among various departments in treating psoriasis, noting its association with several other diseases, such as joint and digestive system disorders.

He also mentioned the hospital's efforts to establish a special clinic that connects dermatology services at the Abdul Karim Al-Saeed Center with other departments.

Consultant Dermatologist and Skin Pathologist Dr. Mohammed Al-Otaibi, who heads the Dermatology Department at Al-Amiri Hospital, explained that psoriasis can manifest in various forms, including spots where the skin membrane bleeds but not from the entire sur-

He noted that any part of the body can be affected by psoriasis; however, it tends to appear more frequently on areas such as the elbows, knees, lower back, scalp, and nails. The incidence rate varies by climate, with

New option for those struggling with hearing loss

Apple AirPods Pro's new hearing aid feature to address ignored problems

NEW YORK, Oct 29, (AP): Some Apple AirPods wireless headphones can be used as hearing aids with a new software update available Monday. It's a high-profile move that experts applaud, even if they only reach a small portion of the millions of Americans with hearing loss.

An estimated 30 million people - 1 in 8 Americans over the age of 12 - have hearing loss in both ears. Millions would benefit from hearing aids but most have never tried them, according to the National Institute on Deafness and Other Communication Disorders. Countless others have tried them, but don't use them because of cost, poor quality, poor fit, how they look or for other reasons.

Over the past few years, there's been a push to change that. Two years ago, federal rules changed to allow hearing aids to be sold over-the-counter, a move that many hoped would bring better and cheaper options to patients. And last month, the U.S. Food and Drug Administration approved soft-ware from Apple that would turn Air-

It's unclear yet whether the rule changed has helped, experts say. But turning AirPods into hearing aids is the kind of creative move advocates had hoped for. Here's what to know about hearing loss, hearing aids, and Apple's

About 15% of Americans report some difficulty hearing. Most people with hearing loss are over 60, but hearing problems don't only affect older people. One study found men and people living in rural areas are more likely to have hearing loss.

And it has been linked to many health effects beyond the ear. It contributes to isolation, depression and cognitive decline, experts say. It raises dementia risk and rewires the brain. It's also been linked to an increased risk of falls - a major health concern among older adults.

"Everything we do, all our relationships, whether it's personal or in our work life, involve hearing conversation," said Barbara Kelley, executive

director of Hearing Loss Association of America. "We're finding now that the sooner that people can pay attention to their hearing health, the better." Before the 2022 rule change by the

US Food and Drug Administration, everyone had to see a doctor and get a prescription for a hearing aid to get one. Now, they're available without one.

"As more of them are sold, then hopefully the price will go down," said Elizabeth Stangl, an audiologist at the University of Iowa. "But we haven't seen a big rush to get them."

Even buying over-the-counter, a decent hearing aid can easily run you \$400 to \$500, said Stangl, who researches how well people adjust to using hearing aids. And some of the less expensive options are really just "cheap amplifiers," lacking the personalized level settings and noise canceling features that really make hearing aids helpful.

The hearing aid feature is available with AirPods Pro 2 models, and requires an iPhone or iPad to set it up. It starts with built-in tests that will help users determine if they have hearing loss, set up the feature if they do, and set personalized amplification levels.

The headphones sell for \$249 on Apple's website, and sometimes less

from other retailers. While there are many other earbudtype devices that can function the same way, experts agreed that the AirPods addition is a good one, simply because of the way it could help normalize hearing aids.


"It's just mainstream," Kelley said. The ubiquity of AirPods could make people worried about the look of a hearing aid more open to using them.

There may be some drawbacks, though. Fit and comfort during long use might be an issue. And while other hearing aids are built to last through a whole day or more, Stangl said the battery life of the AirPods won't allow for that. She also noted that wearing earbuds can send a message to others that the person doesn't want to be disturbed or spoken to.

"But we're hoping that more people will try it and realize, 'Yeah, these do she said.

Stangl suggests people do plenty of research before buying. She said Facebook and Reddit forums can be especially helpful in vetting devices. The websites Hearing Tracker and Soundly also have reliable reviews and resources for selecting a hearing aid, she said.

The Hearing Loss Association of America and American Academy of Audiology have guides to buying a hearing aid at their websites. If you are stuck, consult an audiologist.

Latest mission to make China a major space power

China set to launch next crew to space station

JIUQUAN, China, Oct 29, (AP): China said all systems are ready to launch the next crew to its orbiting space station early Wednesday, the latest mission to make the country a major space power.

The two men and one woman will replace the astronauts who've lived on the Tiangong space station for the last six months. The new mission commander, Cai Xuzhe, went to space in the Shenzhou-14 mission in 2022, while the other two, Song Lingdong and Wang Haoze, are first-time space travelers both born in the 1990s.

Song was an air force pilot and Wang an engineer with the China Aerospace Science and Technology Corporation who will be the crew's payload specialist. Wang will be the third Chinese woman aboard a crewed mission.

The three appeared at a brief news conference Tuesday behind protective glass, declaring their intention to carry out their scientific projects on the space station and

"bring pride to the fatherland." The Shenzhou-19 spaceship carrying the trio is due to launch from the Jiuquan Satellite Launch Center in northwest China atop a Long March-2F rocket, the backbone of China's crewed space missions. Launch time is set for 4:27 a.m., according to the space agency's spokesperson Lin Xiqiang. China built its own space station after being excluded from the International Space Station, largely due to the United States' concerns over the program's complete control by the People's Liberation Army, the Chinese

Communist Party's military arm.

De Zorzi and Stubbs hit first test centuries as SA dominates Day 1 vs B'desh

CHATTOGRAM, Bangladesh, Oct 29, (AP): Opener Tony de Zorzi and Tristan Stubbs hit maiden centuries to help South Africa dominate Bangladesh on

Day 1 of the final cricket test on Tuesday.

The Proteas reached 307-2 before bad light forced an early stumps with Zorzi batting on 141. David Bedingham was on 18.

Stubbs scored 106 from 198 balls with the help of six fours and three sixes before being out. Left-arm spinner Taijul Islam took both of the wickets for 110 after bowling 30 overs.

Zorzi was instrumental in putting South Africa on the front foot after stand-in captain Aiden Markram won the toss and opted to bat first. Zorzie and Markram put on 69 runs for the opening stand, scoring at a run rate of nearly four until left-arm spinner Taijul intervened.

Ťaijul broke through with the wicket of Markram, who chipped a tossed-up delivery straight to mid-on after scoring 33 off 52 with two 4s.

Zorzi edged a delivery of pacer Hasan Mahmud

behind when on 6 but debutant Mahidul Islam failed to hold on to the catch.

Zorzi made Bangladesh pay heavily for the missed

Taijul. who took eight wickets in the first test that Bangladesh lost by seven wickets, was largely ineffective as Zorzi attacked him as a strategy to put pressure on the hosts' bowling lineup.

Stubbs was also similarly comfortable in his stay in the crease and used his feet properly against the

Zorzi raised his maiden test century from 146 balls, employing a sweep shot to precision for a boundary against offspinner Mehidy Hasan through deep square-leg

Stubbs hit Mehidy for three sixes in quick succession before he cut a delivery of occasional bowler Mominul Haque to sweeper cover for a single to complete his first test century from 194 balls. Soon after, Taijul dismissed Stubbs with a low delivery, ending 201-run partnership between him and Zorzi.

Bangladesh's bowlers however failed to conquer Zorzi, who struck 10 fours and thee sixes in 211 balls and kept attacking relentlessly to help South Africa go past 300.

England wicketkeeper Jamie Smith will miss the team's test tour of the New Zealand over November and December because he will be on paternity leave for the birth of his first child.

Jordan Cox will take the gloves for the tour and looks set to win his first test cap during the threematch series.

Batting allrounder Jacob Bethell, 21, was called up to a test squad for the first time, having made his international debut in the summer in T20 and ODI matches against Australia.

The 16-man squad will be captained by Ben Stokes and play tests in Christchurch, Wellington and Hamilton.

The first test in Christchurch starts Nov. 28.

Here's how Erik ten Hag got it wrong at Man U

Bad signings, no identity and big losses

LONDON, Oct 29, (AP): Erik ten Hag's 2 1/2-year tenure at Manchester United will divide opinion.

He ended United's longest trophy drought in nearly 40 years, claiming two domestic cups - and beating fierce rival Manchester City in one of the finals.

Yet, there were too many humiliating moments and matches for a team of United's stature to accept, making his departure on Monday pretty much inevitable.

Here's a look at what went wrong for the Dutchman at Old Trafford:

SPENDING

Ten Hag oversaw the spending of around 615 million pounds (\$800 million) on players since his arrival at Old Trafford in the summer of 2022. In the Premier League, only Chelsea has spent more in that time. Yet, few of the signings were a success and there was a short-sightedness involved, given the majority were either Dutch players - and therefore wellknown to Ten Hag - or had previously played in the Netherlands. Just this summer, United spent around \$240 million on five new signings - two being Netherlands internationals in Joshua Zirkzee and Matthijs de Ligt and another, Noussair Mazraoui, who played under Ten Hag at Ajax. Undoubtedly the biggest flop has been Brazil winger Antony, who followed Ten Hag by joining for \$95 million from Ajax but barely plays.

STYLE

Arguably the biggest criticism of Ten Hag has been his inability to instill a distinguishable philosophy or style of play at Old Trafford. Under the Dutchman, United has been a "moments" team - a far cry from the cohesive and attractive side he built at Ajax. Managers like Ange Postecoglou (Tottenham), Unai Emery (Aston Villa) and Arne Slot (Liverpool) have quickly established a clear identity at their respective teams despite

being in charge for less time than Ten Hag. Across town, Manchester City - under Pep Guardiola - has been playing some of the best soccer ever seen in the English game. Meanwhile, Ten Hag has appeared to stumble through matches, without United showing a clear pattern of play and the team relying on big individual moments to score goals. Tactically, Ten Hag has been found out many times, too. Just last week, he surprised fans by deploying Mazraoui - a fullback - as a No. 10 in a Europa League game, when United drew 1-1 at 10-men Fenerbahce.

STATISTICS

Ten Hag will leave United with a couple of trophies but far too many big defeats and bad statistics. United is currently on its worst ever

start to a Premier League season -14th place and 11 points after nine games - and that comes hot on the heels of its worst finish - eighth in the Premier League era (since 1992). The 7-0 loss at Liverpool last season was the heaviest defeat at its fiercest rival, its worst competitive defeat in more than 90 years, and surely the low point in his tenure that has also featured a 6-3 loss at Man City, 4-0 losses at Brentford and Crystal Palace, and a last-place finish in a Champions League group containing Galatasaray and FC Copenhagen.

SITUATION

There will be some sympathy for Ten Hag, who might have been destined to fail because he was a good coach simply at United at the wrong time. His en-

tire tenure has been dogged with upheaval and behind-the-scenes change, whether it was the first two years when United was up for sale - and its American owners were heavily criticized for how they run the club - or the last few months when United was adjusting to its fresh soccer leadership fronted by new minority owner Jim Ratcliffe. However, Ten Hag has always had plenty of money to spend, whoever he was reporting to, and should clearly have been doing better with the standard of players at his disposal. United needs a big personality to get the club out of its current malaise and competing with the likes of City, Liverpool and Arsenal - and Ten Hag never seemed to be the man

Sounders open first round with win

CINCINNATI, Oct 29, (AP): Luciano Acosta picked up an assist on Yamin Asad's first career postseason goal and Roman Celentano made it stand up as FC Cincinnati beat New York City FC 1-0 in the opener of a best-of-three first-round series for the MLS Cup.

Asad ended a scoreless match in the 51st minute when he took a pass from Acosta and sent a header into the net to give Eastern Conference No. 3 seed Cincinnati the lead in the match and the series - which shifts to Citi Field in New York on

It was the first postseason goal for Asad in his third career playoff appearance. Acosta notched his third assist in his 10th postseason match.

Celantano totaled two saves in goal for Cincinnati on the way to his third career clean sheet. He had two shutouts in four playoff starts last season. Celantano has allowed just six goals in seven career playoff starts.

Matt Freese saved five shots in his first postseason start for sixth-seed NYCFC. Freese's only other postseason appearance came in 2021 while playing for the Philadelphia Union when he filled in for starter Andre Blake - out with COVID-19 - in a 2-1 loss to his current club.

Both keepers had one save in a scoreless first half between two clubs that had never met in the postseason.

NYCFC will be without defender Tayvon Gray, who was hit with a red eard for a foul on Acosta in the ninth minute of second-half stoppage time. Cincinnati beat NYCFC 1-0 at

home in March on a goal by Acosta and lost 3-2 on the road early this month. Acosta tied for the league lead with 19 assists during the regular season and added a team-high 14 goals. His 33 goal contributions in a single season set a club record.

Cincinnati and Inter Miami both finished with 11 road victories this season to tie for the league record in a single campaign.

Alex Roldan scored the decisive goal in a 5-4 shootout after Seattle goalkeeper Stefan Frei and Houston's Steve Clark dueled to a scoreless draw in regulation, and the Sounders rallied to beat the Dynamo in a bestof-three first-round opener for the MLS Cup.

Frei was not tested the whole rainy night and finished without a save in his shutout effort. But he guessed right in the fourth round of the shootout - forcing Erik Sviatchenko to miss wide left. Roldan sent a rightfooted shot to the top right corner, delivering the winner for the Western

Conference's No. 4 seed.

Frei led the league in clean sheets this season with 13 after topping the league with 14 last year. He has allowed just 32 goals in 33 postseason starts with 14 shutouts - all with the Sounders.

Steve Clark turned away three shots in his 18th career postseason start - the last six with the No. 5 seed Dvnamo.

The Sounders, who joined the league in 2009, have never lost a home match to the Dynamo.

Houston was forced to play a man down from the 66th minute on after midfielder Coco Carrasquilla was sent off for getting two yellow cards over a span of five minutes.

Sounders' leading goal scorer Jor-

dan Morris left with an injury in the 52nd minute. He was replaced by Raúl Ruidíaz, who scored the first shootout goal for Seattle. Albert Rusnák, Jackson Ragen and Cristian Roldan had the others. The Dynamo's successful PKs

came from Ezequiel Ponce, Griffin Dorsey, Sebastian Kowalczyk and Daniel Steres.

Seattle has made the playoffs in 15 of its 16 seasons, winning conference championships four times and the MLS Cup twice - 2016 and 2019. The club got off to the worst start in its history this season before going 12-2-3 in the second half.

Houston, which set club records with 54 points and eight road victories this season, will host the Sounders on Sunday.

The Dynamo are making their 10th postseason appearance and first in back-to-back seasons since 2013. The two clubs played to a 2-2 draw in Houston during the regular season. Seattle beat the Dynamo 1-0 at home.

Few upsets likely on second day of Copa del Rey matches in Spain

MADRID, Oct 29, (Xinhua): Six more teams from La Liga, including Atletico Madrid, kick off their campaign in this season's Copa del Rey on Wednesday.

With the format of the competition meaning none of the teams playing in the Spanish Supercup (Athletic Bilbao, Mallorca, Real Madrid or FC Barcelona) go into the hat for the first two rounds, Atletico are arguably the biggest club in the first round as they look to improve on last season's semifinal which saw them beaten 4-0 on aggregate by Cup holders Athletic.

Diego Simeone's side face Catalan outfit Unio Esportiva Vic, who play in the regional Lliga Elit, which is the sixth tier of the Spanish game and who shouldn't be a threat to a side that contains players such as Alexander Sorloth and Conor Gallagher.

Simeone is likely to carry out big squad rotation to the team that lost 1-0 to Real Betis on Sunday, but one rule in the Copa del Rey is that sides must have seven players from their first team squad on the pitch throughout the match, otherwise risk expulsion from the competition.

Sevilla travel to the outskirts of

Madrid to play Las Rozas, who play in Group 7 of Spain's fifth-tier Tercera Division and are clear favorites to continue their improvement under Francisco Garcia Pimienta.

Osasuna have to travel to the far southwest of Spain to face sixth-tier Chiclana, who reached the first round of the cup last season, before losing 5-0 at home to Villarreal and a similar result is likely on Wednesday.

Leganes claimed an important win in La Liga on Sunday and the topflight minnows are away to Lucena. The fifth-tier club from near Cordoba in the south of Spain, may be one of the few 'minnows' with a chance of an upset as they top their group in Tercera, while Leganes are more focused on surviving in La Liga than the Copa del Rey.

Celta Vigo are also in the south of Spain to face sixth-tier side San Pedro, and should have few problems, while Valencia go to the south of Madrid to play Parla Escuela.

This semi-professional shouldn't be a problem for Valencia, but the side currently bottom of La Liga will want a convincing win ahead of their La Liga match at home to Real Madrid next weekend.



mouk at 7:00 pm. This season, nine clubs are competing, including defending champion Kuwait Club, Al-Qadsiya, Kazma, Al-Arabi, Al-Qurain, and Yarmouk. Thamer Al-Shanfa, Secretary General of the Basketball Federation, anfollow a two-division merger format, with the top four teams progressing to the "golden square" to vie for the title. Teams finishing in fifth to ninth place will compete in a separate group to determine rankings.

Al-Shanfa confirmed that the Federation's competition committees and referees are fully prepared, expecting this season to showcase high-level play due to strong technical preparations by the clubs. He highlighted the Federation's collaboration with clubs to ensure successful local championships that strengthen players and benefit the national teams. Additionally, the Federation has scheduled the Super Cup match between Kuwait and Al-Qadsia for November 27.

The league began in the 1961-1962 season with six clubs. Al-Qadsiya has won the title 23 times, followed by Kuwait Club with 15 titles, Kazma with 9, Al-Arabi with 8, Al-Jahra with 5, and Al-Sahel with one. The league's 2000-2001 season was canceled, with no champion declared.

26th Arabian Gulf Cup draw scheduled for November 9 in Kuwait

KUWAIT CITY, Oct 29: The Supreme Organizing Committee for the 26th Arabian Gulf Cup Football Championship has scheduled the tournament draw for November 9. Kuwait will host the competition from December 21 to January 3.

The draw ceremony is expected to feature Sheikh Hamad bin Khalifa, President of the Arabian Gulf Cup Football Federation, along with federation officials, delegations from the eight participating teams, and prominent Gulf football stars.

PHOENIX, Oct 29, (AP): Devin Booker scored 33 points, Kevin Durant added 30 and the Phoenix Suns rallied to beat the Los Angeles Lakers 109-105.

The Lakers took an 83-76 advantage into the fourth, but couldn't hold on, suffering their first loss of the season after winning three in a row. Durant made back-to-back jumpers to give the Suns a 105-101 lead with 2:17 left.

Rodri and Bonmatí win Ballond'Or as Real Madrid snubs ceremony

PARIS, Oct 29, (AP): Spanish midfielders Rodri and Aitana Bonmatí won the men's and women's Ballon d'Or awards as the world's best soccer players. At the same time, Real Madrid snubbed the star-studded ceremony in Paris in apparent protest.

The 28-year-old Rodri won the prestigious award for the first time after helping Manchester City win the Premier League and being a key player in Spain's European Championship

He succeeded eight-time winner Lionel Messi of Argentina and beat Real Madrid's Vinícius Júnior into second place, which greatly displeased the Spanish club. Madrid and its players stayed away from the ceremony and then vented their feelings on social

Rodri showed emotion when former winner George Weah read his name, putting his hands over his face.
"Incredible night for me," said

Rodri, who is out for the season after injuring his ACL last month and arrived on crutches to the ceremony. "One of my key things is I always try to improve every game.

Known as a hard-working and unselfish player despite his abilities, Rodri was quick to deflect praise from

"I just want to say thank you again to the people who recognize my value in the game," he said. "When I was a kid I never thought of winning the Ballon d'Or, but in the last years I've been playing at the highest level."

The 26-year-old Bonmatí retained her award after helping Barcelona win the Spanish League, the Spanish Cup, and the Champions League. Bonmatí joined Barca teammate Alexia Putellas in winning two titles since the women's trophy was first awarded in 2018. She beat her teammates Caroline Graham Hansen of Norway and Salma Paralluelo of Spain as Barcelona completed a 1-2-3.

"It's a pleasure to be here again," said Bonmatí, who received the award from Oscar winner Natalie Portman. "Thanks to my teammates and the clubs who make me a better football player every year."

Even though attacking midfielder Jude Bellingham was third Dani Carvajal finished fourth in the voting, and coach Carlo Ancelotti won the coach of the year award, no one from Madrid attended the gala in central

Ancelotti posted a message on X instead as did Vinícius, who was considered by many to be the favorite for the award, even though Rodri also had an outstanding season.

"I'll do it 10 if needed," Vinicius wrote in Portuguese. "They are not

Madrid midfielder Eduardo Camavinga made it clear what he thought of the vote, calling it "football politics."

"My brother you are the best player in the world and no award can say otherwise," the France international wrote on X along with a photo of him and Vinicius celebrating together. "Love you, my bro."

Former Madrid star Karim Benzema, who won the Ballon d'Or in 2022, posted a supportive message in French on Instagram, along with the words "Trop Fort" ("Too Strong").

Neither Messi nor Cristiano Ronaldo - winners of the prestigious individual award a combined 13 times - were in the running for this year's prize - the first time that's happened since 2003.

FIFA to host talks on player welfare with unions, clubs

ZURICH, Oct 29, (AP): FIFA is ready to host talks led by Arsène Wenger on improving player welfare that could weigh limiting the number of games they play in a congested calendar and mandating offseason breaks.

FIFA said Monday a Wenger-led task force "will convene in the coming weeks" and include delegates from global players' union FIFPRO, clubs and domestic leagues, plus national federations. Those groups previously had seats on a committee of stakeholders that FIFA shut down in 2021.

The new panel's scope will include "operational, medical, regulatory and legal perspectives," FIFA said, without specifying a timetable or path to making decisions.

The consultation will start with FIFA under increasing legal pressure to listen more to stakeholders,

including a formal complaint to the European Commission in Brussels this month by union and league of-

That filing cited European competition law in how FIFA has expanded or added new men's competitions that increase the workload for elite players that has pushed some to talk of going on strike.

"The task force is due to make recommendations informed by the latest scientific research into the topic of players' physical and men-tal well-being," FIFA said in a state-

FIFA already partners with the World Health Organization including to promote good practice on managing head injuries.
