A.I. CAMERAS SET TO TRACK REAL-TIME ROAD OFFENSES Kuwait deports 497 in 4 days

Child front-seat fine jumps to KD 50

KUWAIT CITY, Nov 17: Some 385 people were arrested and 497 were deported in the last four days due to residency violations, the Ministry of Interior announced on Sunday.

In a press statement, the ministry said that security forces carried out operations throughout the country between November 11 and 14, apprehending and arresting the aforementioned numbers.

The ministry affirmed that it would continue its security campaign against those violating residency laws including individuals bringing in workers and laborers

Meanwhile, the Ministry of Interior has announced the deployment of advanced artificial intelligence (AI) cameras to enhance road safety and enforce traffic regulations across Kuwait, reports Al-Seyassah daily.

Colonel Abdullah Bu Hassan, Assistant Director of the Traffic Awareness Department, revealed in an interview with Al-Akhbar Channel that approximately 252 AI-powered cameras are being installed on public roads throughout the country. These state-of-the-art devices are specifically designed to detect and record violations related to seat belt usage and mobile phone use while driving

"The installation process has already begun, and the cameras will become operational as soon as they are in place," Bu Hassan stated. He emphasized that this technology represents a significant step forward in traffic law enforcement.

Three decrees issued to revoke citizenship of 8

KUWAIT CITY, Nov 17: The Official Gazette Kuwait Alyawm has published three decrees (192, 193, and 194 of 2024) in its latest issue on Sunday, announcing the withdrawal of Kuwaiti citizenship from eight individuals, along with their dependents. The decisions were made in accordance with Decree Law No. 15 of 1959 governing Kuwaiti citizenship, reports Al-Seyassah daily. Saleh Al-Fadala, Head of the Central Agency for Affairs of Il-

legal Residents, stated that the agency is currently working to address the legal status of those affected by the citizenship revoca-

In a video message during a Diwaniya visit, Al-Fadala explained that once the names of those affected are officially listed, state agencies are instructed to halt transactions involving these individuals until they provide the required information on prescribed forms which are especially prepared for this purpose.

Al-Fadala emphasized that each case is reviewed individually and decisions are based on the information obtained from the rel-

While legal determinations are pending, basic humanitarian services, such as medical treatment, remain available to those concerned individuals whose nationalities have been revoked. He also disclosed ongoing discussions with the Ministry of So-

cial Affairs to examine the legal circumstances of individuals with

In his remarks, Al-Fadala expressed gratitude to His Highness the Amir Sheikh Mishal Al-Ahmad Al-Sabah and acting Prime Minister Sheikh Fahad Al-Yousef for their guidance and support, acknowledging the tangible outcomes of their efforts.

Attendance goes smart with MEW's phone app

in the Ministry of Electricity, Water, and Renewable Energy, the team responsible for the fingerprint attendance system, in collaboration with the Information Systems Center, launched the smart fingerprint application for smartphones on November 11. This marks a major development in the comprehensive fingerprint project, which began implementation in August 2021.

This application is part of a plan to update and modernize the fingerprint attendance system and related devices, which will be applied to all 35,500 employees in all sectors of the ministry.

Programming, testing, and developing the application took two full months. It underwent practical experiments with a selected segment of users to ensure its efficiency before the official launch. It was designed to keep pace with the latest technical standards and meet the needs of employees in sensitive locations.

The technical team of the fingerprint attendance system is currently present at the Doha West Station to activate the application on the ground. The team is working to familiarize workers with the application, and to program the system to ensure smooth operation and distinctive experience that facilitates daily tasks.

KUWAIT CITY, Nov 17, (KUNA): The Kuwaiti naval force would be running a live-ammunition exercise on Monday and Tuesday from 07:00 am to 06:00 pm local time, said the army on Sunday.

Hezb spokesman killed in airstrike

BEIRUT, Nov 17, (AP): A rare Israeli airstrike on central Beirut killed Hezbollah's chief spokesman on Sunday, an official with the militant group said. Earlier, Israeli strikes killed at least 12 people in the Gaza Strip, officials said, where Israel has been at war with the Palestinian Hamas for over a year.

The latest in a series of targeted killings of senior Hezbollah officials came as Lebanese officials were considering a United Statesled cease-fire proposal.

Tunisia-Kuwait explore ways to upgrade ties

TUNIS, Nov 17, (KUNA): The fourth Tunisian-Kuwaiti high committee meeting, on November 18-22, will be exploring venues for cooperation and collaboration, which in

turn furthers ties between the two Arab countries. Tunisian and Kuwaiti relations date back to the early

1960s when both countries signed a deal to establish diplomat ties in 1963. Kuwaiti investments in various fields in Tunisia be-

gan in 1976, a development displaying deep-rooted ties. Kuwait Investment Au-

thority (KIA) gained the trust of the Tunisian market through ventures in telecommunication, pharmaceuticals, the car industry, and the financial and tourist sectors.

During the 162nd meeting for the Arab League ministerial council, held in Cairo last September, Tunisian Foreign Minister Mohammad Ñafti met with Kuwait counterpart Abdullah Al-Yahya both stressed the importance of the upcoming meeting, which hopefully reflect both leaderships and peoples' desire for more cooperation.

During the third committee meeting, which was held in Kuwait back in 2015, eight agreements and MoUs were signed between Kuwait and Tunisia, leading to more enhanced ties.

In this regard, former Tunisian Foreign Minister Ahmad Wanis commended the exemplary relations, saying that at the moment, ties were witnessing several dynamic activities supervised by the leaderships of both countries.

The upcoming fourth high committee meeting would be another milestone, which would add to the astonishing ties between both countries.

On his part, former diplomat Abdullah Al-Obaidi pointed out that there were several agreements signed between two countries in various fields and hopefully the upcoming fourth committee meeting would looking into ways to enhance them as well as signing other agreements

He mentioned that the Kuwait Fund for Arab Economic Development (KFAED) had contributed to development in Tunisia.

He revealed that the amount of Kuwaiti public investments in Tunisia where at around USD 200 million in addition to private investments that covered several sectors.

Kuwait and Tunisia have signed thus far 50 agreements since diplomatic ties began some 53 years ago and the upcoming meeting will explore ways to take relations to the next level.



Sustainability and building Earth

In previous articles, we briefly discussed the definition of sustainable development, its three main areas, and the mistake of focusing on just one aspect of sustainability, such as financial sustainability. Instead, we

emphasized the need to activate and achieve all aspects of sustainability. We suggest, quite simply, adding the word "sustainability" to any concept or issue an institution is concerned with and then working

towards achiev-

ing and activating it. For example, by attaching "sustainability" to "organization," we strive for "organizational sustainability." Similarly, with "operational sustainability," "improvement sustainability," and "institutional sustainability" – all of which need to be realized.

We previously mentioned the 17 Sustainable Development Goals (SDGs) and the role of countries or institutions in engaging with them positively. But what does positive engagement mean? How do we begin to interact with these goals? Do we have to accept the SDGs exactly as they are written? To answer these questions, we'll discuss two key points:

1. How do we positively engage with these goals from our understanding of the importance of sustainability within our culture and Islamic teach-

2. What reservations might we have about the wording of certain goals or their interpretation from a human and logical perspective?

If we examine the primary domains of sustainability - economy, environment, society, and governance - we will find that these were emphasized and systematically activated in our civilization and historical trajectory. This indicates that these global ideas and institutional directives will naturally find their place in our reality if we approach them correctly. Their importance or usefulness won't require much explanation but will need activation in people's lives and an emphasis on revitalizing and re-focusing on them.

Our civilization and culture have defined and built an integrated methodology for how individuals and institutions deal with these sustainability domains in their modern sense. This methodology serves as a guiding framework, regulating and directing human actions, rooted in the understanding that humans are stewards of the earth. Our task is to develop it, not destroy it. We must live in harmony with natural laws and not according to harmful desires that lead to the destruction of our environment, economy, or society. As Allah has commanded: we are meant to build and cultivate the earth, not exploit or ruin it "He produced you from the earth and settled you in it" (Surat Hud, 61).

This civilized methodology aims to foster a mindset in individuals and institutions that drives them toward leaving a lasting impact, maintaining continuity, and making a difference in the environment, economy, and human life. From this perspective, we can understand the consistent condemnation of corruption in the earth and the strong disapproval of those who spread it. We also see the encouragement for development, growth, and sustainability, even in the most difficult and uncertain circumstances. The Prophet Muhammad (Peace Be Upon Him) famously said: "If the Hour (the Day of Judgment) is established and one of you has a sapling in his hand, if he is able to plant it before the Hour is established, then let him plant it."

This prophetic teaching emphasizes the importance of positive action and sustainability, even in moments of crisis, highlighting the value Islam places on continuous efforts to improve and sustain life on Earth.

KUWAIT CITY, Nov 17: Minister of Awqaf and Islamic Affairs Mohammad Al-Wasmi supervised the sorting of Hajj pilgrimage applications to choose 8,000 pilgrims who met the conditions.

In a press statement following the press conference in the ministry on Sunday with representatives of Kuwait Hajj Caravans Union in attendance; Al-Wasmi revealed that the sorting process for those who registered on the platform to perform Hajj for the year 1446 (Islamic calendar) was carried out in a smooth and transparent manner. He affirmed there were no errors in the sorting process. "We are here to overcome obstacles. Every year, we work hard to develop the registration mechanism to ensure ease of sorting," he added.

Asked about increasing Kuwait's pilgrims quota, he said "the number of Hajj applicants on the electronic platform reached 34,700 citizens and 8,000 pilgrims were selected. In cooperation with our brothers in Saudi Arabia, we are hoping to increase the number; which is possible, but not yet confirmed." He said the Kuwaiti caravans are known for their excellence in service provision, given their long experience in the field.

Meanwhile, Director of the Hajj and Umrah Department Sattam Al-Muzain said the ministry submitted a request to the Saudi Ministry of Hajj to increase Kuwait's

Regarding the Hajj of Bedouns, he disclosed the ministry is waiting for official approvals. He clarified the quota for this category has yet to be determined and it will be known once the approvals are obtained.

He stated that 7,700 slots were allocated for the Sunni and Jaafari sects, and 300 for the religious and medical teams accompanying the caravans.

He explained the sorting mechanism was based on three age groups, as it was done by prioritizing the oldest age in each group. He said the first group consisted of those 60 years old and above, the second group consisted of those aged 35 to 59 years old, and the third group consisted of those 34 years old and below.

He added those who were accepted will receive messages and notifications through the Sahel application, urging them to register for the caravans within five days to ensure their names are not deleted from

He confirmed there is a link with the Ministry of Interior to verify the pilgrims' data and compliance with the requirements of Saudi Arabia, indicating that all those who were accepted have not performed Hajj before.

"After amending the Hajj regulations, the fees for Hajj are now down to a total of KD1,650; compared to the price range of KD3,500 to KD4,000 prior to the amendment," he concluded.

Lowest bidder wins pact to build purification plant



KUWAIT CITY, Nov 17: After preparing the valuation budget for the submitted bids and in response to the Ministry of Public Works' request, the Central Agency for Public Tenders (CAPT) decided in its meeting last Wednesday to award the contract for the construction, operation, and maintenance of a purification plant in South Mutlaa City to the company with the lowest bid. The project, with a total cost of KD 149.6 million, will be implemented within five days.

According to sources, the project involves the construction of a purification plant and a pumping station with a capacity of up to 400,000 m³/day to treat wastewater from South Mutlaa City. It also includes the establishment of an electrical conversion station with a capacity of 16 MW, as well as administrative buildings, laboratories, and infrastructure services for the sewage treatment plant. The project will also address the treatment of sludge to generate electrical energy.

In addition, the project includes a control and distribution system for treated water (DMC), treated water lines for irrigation in South Mutlaa Housing City, and a connection to the Abdali farms irrigation network.

The sources highlighted that the Ministry of Public Works is committed to collaborating with all relevant government agencies, in line with the directives of the Minister of Public Works Dr. Noura Al-Mishaan. This includes supporting housing projects and their infrastructure needs, such as sewage treatment and purification stations, as these are critical components of the city's overall

Spread of AI will widen the gap between rich and poor nations

"WHETHER we like it or not, artificial intelligence has become a dominant feature in the direction and vision of governments and countries worldwide,' columnist Dr. Issa Mohammad Al-Omairi wrote for Al-Anba daily.

"This is due to its advantages and benefits for human society, as it represents the coming technological revolution that will transform the world, shifting it from east to west and opening new frontiers.

"However, amidst this global race and competition in the field, we must recognize that every positive development carries with it negative aspects. "Nothing



fect. While the positive side of Dr. Issa Al-Omairi artificial intel-

ligence is almost universally acknowledged, it is the negative side that is the

focus of this article.
"What I believe is that the issues surrounding modern technological advancements should not be viewed through a single lens or based solely on emotional perspectives.

"These matters require an objective, effective approach because they are multifaceted, with many details hidden within. The negative aspects lie in these details.

"For developed industrial nations and countries with low populations that rely on skilled labor, artificial intelligence can be seen as a blessing -- a practical solution to meet their needs for rare, low-wage labor. But what about the developing countries that rely on cheap labor as a key source of national income and a pillar of their future economic and industrial development ambitions?

"In light of this question, the world is currently facing a dilemma. It is important to clarify where the problem of artificial intelligence lies for these countries, and how the entire world can benefit from it.

"The new international system, dominated by technology giants and artificial intelligence, will create a scenario where a few winners -- who control everything -- will hold unprecedented wealth, concentrated in the hands of a small number of companies in China, the United States, Japan, and a few Southeast Asian countries that form the new industrial nations, along with a limited number of

European Union countries.

"This, in our view, presents a future danger for artificial intelligence's impact on countries that lack it. These countries will become poorer, and face widespread social unrest and political and economic collapse, stemming from the widespread unemployment of workers.

"A significant inequality gap will emerge between nations if artificial intelligence spreads rapidly. As a result, the historical economic advantage that -- will diminish as artificial intelligence takes over industries.

"It is likely that factories powered by artificial intelligence will move from their current locations to areas closer to massive consumer markets.

"Consequently, the gap between those who have wealth at a global level and those who do not will significantly widen, with no clear indicators or measures available to bridge or close this gap.'

Also:

"In late 2022, the Executive Regulations of the Companies Law in Kuwait were amended to include a provision requiring joint-stock companies to deduct 1 percent of their annual profits for the Kuwait Foundation for the Advancement of Sciences (KFAS)," columnist Dr. Sarah Khaled Al-Sultan wrote for

Al-Jarida daily. "While the amendment aimed to profinancial vide support for the Foundation. it has sparked a legal debate about the nature of this deduction and its classification as



a tax. Below is Dr. Sarah Al-Sultan an exploration

of this issue, examining its implications before and after the amendment,"

"Established in 1976, KFAS operates as a private institution supporting research, scholarships, and innovation. Historically, Kuwaiti shareholding companies voluntarily contributed a percentage of their profits -- initially 5 percent, later reduced to 1 percent -- to the Foundation.

"For companies that signed KFAS's founding agreement, their obligation was contractual. However, for non-signatory companies, these payments were voluntary, reflecting their belief in the Foundation's mission.

"The recent amendment introduced a mandatory requirement for joint-stock companies to allocate 1 percent of their annual net profits to KFAS.

"The executive regulations enforce this obligation and require companies to transfer the deducted amount to the Foundation. This shift from voluntary contributions to compulsory payments raises the question: Is this deduction a tax?

"Compulsion -- The amendment creates a legal obligation, mirroring the compulsory nature of taxes.

"Non-recoverability: The deducted amounts are final and cannot be reclaimed. "Lack of direct compensation -- Companies receive no direct benefit from

their payments, aligning with the nature

of taxes, which are paid without direct services in return. "Linked to the ability to pay -- The deduction is proportional to annual profits reflecting a company's financial capacity.

"Given these characteristics, the deduction closely resembles a tax, despite not being collected by the Tax Adminis-

tration or entering the state treasury. "Compliance with Article 134 -- Kuwait's Constitution mandates that taxes must be imposed by law, raising questions about the legality of using executive regulations for this purpose

"Budgetary Principles -- Article 141 prohibits allocating public revenues for specific expenses without legislative approval, further complicating the deduction's legal standing.

"The classification as a tax necessitates its inclusion in treaties to avoid double taxation. Kuwait's adoption of the OECD's Base Erosion and Profit Shifting framework may require integrating this deduction into broader global minimum tax agreements.

"Acknowledging the deduction as a tax influences discussions on corporate tax reform, particularly regarding the cumulative tax burden on companies.

"The legal amendment mandating the 1 percent deduction for KFAS has transformed a voluntary contribution into a de facto tax.

"While it aims to fund scientific advancement, its legal classification raises constitutional and international implications. This development highlights the need for a comprehensive review of corporate taxation in Kuwait to ensure clarity, compliance, and fairness.'

"The truth is that I have noticed a lot of surprise, and even frustration, from those I know, especially those without subscriptions to paid channels. Their inner voice keeps asking repeatedly,

"The Council of Ministers should have taken this matter seriously and ensured that it was addressed, not just for this tournament but for any future ones as well. Our national team, including players, administrators, and fans, should never feel that their efforts to raise Kuwait's name in international sports competitions

are being overlooked or undervalued."

"THE suspension of flights to Kuwait, announced by British Airways, is set to take effect in March. This follows similar decisions announced by Dutch and German airlines to halt their services to the country. The move is understood to have technical and organizational reasons behind it", columnist Eng. Adel Al-Jarallah

Al-Kharafi wrote for Al-Seyassah daily. "The Directorate General of Civil Aviation (DGCA) must thoroughly investigate the reasons behind these flight suspensions to ensure that history doesn't repeat itself. It is important to make sure that Kuwait's new airport does not end up underutilized, and does not justify its high costs, after a long wait and high expectations for it to become a regional hub for air transport.

"The successive suspensions of flights are undoubtedly disappointing and raise concerns about the future of Kuwaiti air transport. Have we lost our appeal to tourists, investors, and airlines to the extent that major carriers are now halting flights to Kuwait?

"In a recent statement published in the media, a Kuwaiti expert outlined several technical factors behind the flight suspensions. These are issues that must be addressed promptly by DGCA to ensure that our new airport remains attractive to global air carriers.

"If the expert's assertion is correct that the flight suspensions are in the interest of Kuwait's national carrier, it may not necessarily align with the interests of Kuwait itself.

"In my view, the issue goes beyond just aviation. The attractiveness of air travel is part of a larger picture, which includes the appeal of foreign invest-ment, skilled labor, and tourism. These factors are interconnected, and we must ask whether the components that drive them are in place.

"Kuwait's new airport, with its potential to occupy a prominent regional position, is not solely defined by its facilities and services, although these are undeniably important. More importantly, it depends on our ability, resources, and strategic plans to improve our current situation. Allah is the guarantor of success."

Call to support victims of 'domestic violence'

KUWAIT CITY, Nov 17: The Supreme Council for Family Affairs is working towards the activation of all its committees, in addition to preparing a comprehensive work plan for shelters and protection centers; including campaigns on the Protection from Violence Law and the Child Law with the aim of raising public awareness on the laws that protect the family and society, reports Al-Anba daily quoting sources.

Sources confirmed the council is coordinating with the Social Development Office to create psychological and social programs as per the approved standards for dealing with violence cases. Sources said this is in compliance with the leadership's directives on the importance of concerted efforts between the two parties to ensure the provision of effective and comprehensive support for those affected by domestic violence.

Sources revealed the council is working hard to activate the role of psychological and social specialists and develop the skills of professionals in these fields by organizing training courses to raise the efficiency of employees assigned in protection centers, as well as following up the work of joint committees whose members are from parties or entities concerned with violence cases and to automate procedures in order to ensure the effective flow of work.

Mechanisms

Regarding the work mechanisms in the protection centers and ways to deal with abused women, sources explained that the council has protection centers for abused women in Ahmadi and Khaitan. They said these centers are manned by the most capable employees who provide full care and support to those affected by domestic violence. They added these centers rely on a team of qualified national professionals in the psychological, social and legal fields to guarantee the provision of the best services, and to handle cases in a professional manner in line with the commitment of the council to provide a safe and nurturing environment for abused women.

Sources also confirmed the establishment of similar centers in all governorates, stressing that the council is keen on providing integrated protection, in cooperation with all other concerned authorities, to achieve the desired goals related to family and childhood.

On the council's work plan and activities, sources disclosed that it conducts training programs for employees assigned in the centers on a regular basis to hone their skills and update them on the new methodologies; in addition to organizing workshops on the empowerment of women, a special initiative to qualify abused women functionally and academically, and a comprehensive program for the celebration of World Children's Day.

Oman celebrates 54th National Day

MUSCAT, Nov 17, (ONA): The Sultanate of Oman will celebrate the 54th glorious National Day on Monday, marking milestone accomplishments in different areas.

The citizens of Oman and various state institutions have rendered an indispensable contribution to the continuous achievements in the path of the comprehensive development during the renewed renaissance of His Majesty Sultan Haitham bin Tarik, who has outlined a wise and sound vision that leads to progress and prosperity in all fields.

His Majesty's directives to all state institutions to continue improving the missions entrusted to them and to develop appropriate conditions to upgrade performance at all levels have contributed positively over the past five years to achieving success in various targets of Oman Vision 2040.

The government of His Majesty the Sultan has managed to improve the state's economic and financial performance and reduce debt and increase the gross domestic product; as the state's public revenue at the end of August 2024 amounted to RO 8.106 billion, up by RO 183 million compared to RO 7.923 billion registered over the same period in 2023.

The state's general budget until August 2024 achieved a surplus of about RO 447 million, while the public debt portfolio declined by the end of June 2024 to RO 14.4 billion, compared to RO 20.8 billion in

Pension

The Sultanate of Oman also launched this year (2024) the social protection system by unifying and merging pension funds, and

unifying and merging pension funds, and restructuring the schemes.

Oman succeeded in reducing the ratio of public debt to GDP from 62.3 percent in 2021 to 35 percent in mid-2024 and achieving a budget surplus for consecutive years, recording 2.7 percent and 2.2 percent in 2022 and 2023, respectively.

This has led to a remarkable improve-

This has led to a remarkable improvement in the credit rating of the Sultanate of Oman by credit rating agencies, as Standard & Poor's raised its second credit rating for the Sultanate of Oman to "BBB-" from "BB+" with a stable outlook. Further, Moody's revised its outlook for the Sultanate of Oman from a stable to a positive, confirming the credit rating at "Ba1".

These ratings affirm that the Sultanate of Oman is a safe investment environment, as it returned to this rating category after a decline of nearly 7 years (since 2017) due to the repercussions of the crises resulting from the slump in global oil prices and the Covid-19 pandemic.

Moreover, the Sultanate of Oman has also advanced in many international indicators, as it rose 39 ranks in the 2024 Index of Economic Freedom issued by the Heritage Foundation to obtain the 56th place globally after being ranked 95th globally in 2023. In the Entrepreneurship Index, it came in the 11th place globally, advancing 27 places from its ranking in 2022/2023. It also came in the 50th place globally in the

also came in the Suth place globally in the Environmental Performance Index after being ranked 149th in the 2022 ranking.

In the education sector, Sultan Qaboos University (SQU) achieved a remarkable progress in the 2025 World University Pankings to obtain the 362nd place ad-Rankings to obtain the 362nd place, advancing 92 places from its previous classification.

The Sultanate of Oman also advanced 10 ranks in the Global Innovation Index issued by the World Intellectual Property Organization (WIPO), to obtain the 69th place globally out of 132 countries included in the index; as Oman achieved the highest performance in: (human capital, research,

and infrastructure). Oman also advanced 9 ranks in innovation outputs and came among the top 20 countries globally in 5 sub-indicators, including: second place globally in the percentage of government spending per student, in addition to the 16th place globally in the availability of information and communication technologies, and the 19th place globally in doing business, as it jumped 93 ranks in the growth rate of labour productivity compared to its ranking in the 2022 index.

FDI

Meanwhile, the volume of foreign direct investments (FDI) in the Sultanate of Oman until the end of the fourth quarter of 2023 amounted to RO 25.05 billion, an increase of 21.6 percent compared to the same period in 2022, which amounted to RO 20.59 billion.

Regarding the government investments, Oman Investment Authority (OIA) is exerting sincere efforts to make the Sultanate of Oman an attractive investment destination and achieve sustainable economic development. The Authority's assets increased to RO 19.2 billion compared to about RO 17.9 billion at the end of 2022. It contributed to achieving profits exceeding RO 1.7 billion, and supporting the state's general budget with an amount of RO 800 million, and repaid RO 300 million of loans from its subsidiaries before their due date in 2023.

The OIA invests in 13 global funds, such as the Platinum Investment Fund and the Global Infrastructure Fund, in addition to direct investments in global companies, such as the American "Our Next Energy" Company and the Australian "Hysata".

One of the most important strategic projects that were inaugurated at the beginning of this year (2024) is the DuqmRefinery and Petrochemical Industries Project in the Special Economic Zone at Duqm (SEZAD).

The refinery is the largest joint investment project between the Sultanate of Oman and the State of Kuwait, integrated between the Omani OQ Group and Kuwait Petroleum International Company, with a capital exceeding RO 3.5 billion.

The Sultanate of Oman has witnessed the implementation of many projects in the field of renewable energy, most notably Manah Solar Power Project with a production capacity of 1,000 megawatts located in A'Dakhiliyah Governorate, IbriSolar Power Project with a production capacity of 500 megawatts located in A'Dhahirah Governorate, Barka Solar Power Project with a production capacity of 500 megawatts located in South Al Batinah Governorate, the Amin Solar Power Plant Project with a production capacity of 100 megawatts located in Dhofar Governorate, Sohar Solar Power Project with a production capacity of 100 megawatts in North Al Batinah Governorate and Dhofar Wind Farm with a production capacity of 50 megawatts located in Dhofar Governorate.

The Sultanate of Oman is pressing ahead with boosting public and private sectors partnership, as the private sector is the key driver of the economic development and GDP growth in various sectors. The private sector also contributes remarkably to the economic diversification efforts, as it is a peer to the public sector in social development through the contribution of its institutions to education, health and social investment

economy. The private sector has embarked on enhancing efforts to elevate the national economy through exploring the opportunities offered by incentive initiatives, such as the National Program for Private Sector Development and Foreign Trade "Nazdaher" and financial incentive and sustainability initiatives, along with enhancing partnership with the government sector.

The private sector is also the incubator environment for national capital investment, as it relies primarily on individual initiatives, whether in the form of personal companies or jointstock companies, in addition to hosting innovative ideas and transforming them into projects that benefit society through entrepreneurs and small and medium enterprises(SMEs). The sector is also the main component for attracting foreign investment, whether by providing effective partnerships in qualitative projects or by providing the requirements for these projects through local content of products and

The total volume of added investment in all industrial cities affiliated to the Public Establishment for Industrial Estates (Madayn) during the first half of 2024 exceeded RO 177 million, bringing the total volume of investment in all these cities, including Knowledge Oasis Muscat (KOM) and Al Mazunah Free Zone, to more than RO 7.6 billion.

Meanwhile, the number of localized investment contracts reached 2,310. As many as 55,242 employees work in investment projects in all industrial cities, of whom Omanis constitute 38 percent, while the total area of existing and new industrial cities reached 163,176,459 square

The volume of cumulative investment in Sohar Free Zone, Salalah Free Zone and Khazaen Economic City amounted to RO 1.33 billion, covering several sectors, most notably the pharmaceuticals, food, petrochemicals, plastics, logistics, renewable energy sectors and others.

As far as the ports sector is concerned, the ports of Sohar, Salalah and Duqm, which enjoy a globally integrated infrastructure, continue to boost their operational efficiencies to become major berthing stations on various global shipping lines. During the first half of 2024, these ports maintained their operational volumes, handling about 1.8 million containers with a general cargo volume of up to 13 million tons. This figure reflects the ports' effective contribution to supporting the national economy and enabling Omani exports to reach international markets with a high competitive ca-

The dry dock in the Special Economic Zone in Duqm (SEZAD), which is classified as the second largest dry dock for ship repair and maintenance in the Middle East and North Africa (MENA Region), was able to implement 106 projects from about 70 countries around the world during the first half of 2024, thanks to its strategic location close to global shipping lines.

Tourism

In the tourism sector, the Sultanate of Oman has achieved remarkable results in recent years, as the number of tourists increased by 36.7 percent to nearly 4 million tourists in 2023 compared to 2022. The number of visitors coming to the Sultanate of Oman by the end of the first half of 2024 amounted to about 2 million, an increase of 3.2 percent. Meanwhile, the number of hotel establishments stands at 895, including 34,378 hotel rooms.

The Sultanate of Oman continues its focus on the comprehensive and balanced development of all governorates through the construction of sustainable cities within the priorities of Oman Vision 2040. This approach is done by channeling investments towards constructing smart cities and developing governorates while applying the principle of administrative and economic decentralization.

Sultan Haitham City project represents the first smart and sustainable project as an integrated city with an area of 14,800,000 square meters. It includes about 20,000 housing units distributed over 19 integrated neighborhoods with various facilities and

The progress made by the Sultanate of Oman in many global indicators reflects the determination of the country, as a government and people, to achieve its future aspirations to be among the advanced countries.

Among these indicators is the progress made by Oman in the media index for the second year in a row, ranking 40th globally after advancing 6 ranks in the Global Soft Power Index issued by the British Brand Finance Agency for 2024, compared to the 46th place in 2023.

It also advanced in other sub-indices, such as advancing 10 ranks in the Sustainable Future Index and 5 ranks in the Positive Impact Index.

The Sultanate of Oman also achieved qualitative progress in the Global Environmental Performance Index for 2024, advancing 99 places from the previous ranking (where it was ranked 149th globally), to occupy the 50th place globally in 2024 ranking, which was announced by the Yale Center for Environmental Policy and Law at Yale University in the United States.

The Royal vision of His Majesty seeks to uplift the human thought by furnishing the appropriate environment for establishing qualitative cultural and intellectual institutions. Laying the foundation stone of Oman Cultural Complex at the Airport Heights in Muscat Governorate represents a vivid example of this approach. Oman Cultural Complex seeks to promote cultural, literary, theatrical and research activities through the enhancement of relevant programmes. The move aims to expand the scope of engagement in highlighting Oman's cultural heritage and exploring the country's accomplishments. The complex includes three main buildings, namely the National Theatre, the National Library and the National Records and Archives Authority (NRAA).

Promote

On the domestic front, His Majesty Sultan Haitham bin Tarik continues his Royal meet-the-people tours to engage with citizens all over the Sultanate of Oman and listen to their visions and proposals about measures to promote the development of their respective governorates and upgrade economic and service projects.

In continuation of this Royal ap proach, His Majesty the Sultan held a meeting at the Royal Camp in Saih Al Mahasin in the Wilayat of Khasab, Musandam Governorate, with sheikhs and dignitaries of Musandam, some members of the Council of Oman and members of the Municipal Council and the businessmen community in the Governorate.

Meanwhile, the Council of Oman, represented by the State Council and the Shura Council, is a key partner in this important phase. In exercising its national roles and responsibilities, the Council of Oman relies on the Basic Law of the State and the Law of the Council of Oman, which have defined the paths of work according to clear powers.

During the first convening of the eighth term, the State Council discussed a number of topics, including draft laws referred by the government, in addition to the draft state general budget for the fiscal year 2024. It also held 5 public sessions.

A joint session was also held with the Shura Council to discuss the disputed articles in a number of draft laws, in implementation of the provisions of Article (49) of the Council of Oman's Law.

On its turn, the Shura Council held, during the same period, 12 regular sessions and dealt with 4 ministerial statements, approved 20 draft laws and agreements referred by the government, and 4 urgent statements.

The municipal councils in various governorates of the Sultanate of Oman work on the basis of decentralization. The government has paid attention to activating the role of these councils and developing their legislation, in translation of the far-sighted vision of His Majesty the Sultan towards enabling them to carry out their developmental and societal roles in accordance with their prerogatives. This approach comes within the priorities of Oman Vision 2040 regarding the development of sustainable governorates and

The Sultanate of Oman also attaches a great importance to the education sector as it is a tool for development and progress.

In this context, the Council of Ministers approved, during a meeting held last September under the chair of His Majesty the Sultan, the allocation of RO 40 million to be added to the current 5-year plan to help accelerate the construction of new schools, in light of a steady rise in number of students in some governorates.

The number of students in public and private schools during the current academic year has exceeded one million male and female students. This year (2024) witnessed the opening of 16 new schools in a number of governorates. Construction of 15 school buildings has also begun and tenders have been floated for 20 new schools.

The teachers represent the cornerstone of the development and progress of Oman's renewed renaissance. In this context, the Honourable Lady, Spouse of His Majesty the Sultan has stressed that teachers play a vital role in the educational system.

As for the health sector in the Sultanate of Oman, it is witnessing a remarkable development that meets the aspirations of the government and Oman Vision 2040. This progress is reflected on the health infrastructure and the improvement in the quality of services provided to citizens and resi-

Healthcare

Among the projects that the health strategy focuses on is providing secondary and tertiary healthcare through constructing, replacing, upgrading and expanding hospitals in most governorates. Currently, 9 hospitals are being built with more than 1,660 beds, and 5 other referral hospitals are being expanded. To keep pace with the requirements of primary healthcare to provide basic health services, 15 primary healthcare institutions are currently being constructed, replaced and expanded, in addition to establishing 9 kidney dialysis units.

Meanwhile, the University Medical City, which was established last February, contributes to backing the government's efforts to upgrade the health sector in the Sultanate of Oman, and providing health services to citizens and residents according to national and international standards. The city includes Sultan Qaboos University Hospital, Oman National Center for Hematology and Marrow Transplantation and Sultan Qaboos Comprehensive Cancer Care and Research Center.

The Medical City Hospital for Military and Security Services - Muscat which was inaugurated by His Majesty addition to the efforts of the Sultanate of Oman to provide medical services and healthcare.

The government of the Sultanate of Oman attaches a great importance to the youth due to their vital role in the march of building Oman's renewed renaissance. This was underscored by HH Sayyid Theyazin bin Haitham Al Said, Minister of Culture, Sports and Youth, when he addressed the Omani youth on their annual day. The Sultanate of Oman has always emphasized upholding the principles of transparency and integrity and applying the approach of accountability in all sectors by boosting the oversight system to achieve national goals. In this context, His Majesty has underscored the importance of simplifying procedures and governing performance, integrity and accountability to ensure full alignment and harmony

with the requirements of his vision. The Sultanate of Oman also continues to extend bridges of cooperation, consolidate the principle of friendship, and strengthen relations with countries

His Majesty Sultan Haitham bin Tarik's visits to a number of Arab and foreign countries embody this approach that lays emphasis on cooperation and close diplomatic relations with these countries.

Culture, Arts and Letters (NCCAL), announced on Sunday that the team uncovered a courtyard or workshop area likely used for crafting shell ornaments dating back to the Ubaid culture. The site has also yielded numerous pottery items over 7.000 years old.

Dr. Hassan Ashkanani, Professor of Archaeology and Anthropology at Kuwait University, highlighted the discovery of a small clay human head as one of the season's most impressive finds. Dating back to 7700-7500 years ago, the figurine features an oblong skull, slanted eyes, and a flat nose, characteristics typical of Ubaid culture statues.

Professor Piotr Bielinski, co-director of the Kuwaiti-Polish mission, emphasized the significance of these artifacts in raising questions about their purpose and symbolic value in ancient society.

The excavation has also provided evidence of local pottery production, with the discovery of unfired clay pottery. This finding, along with scientific analyses supervised by Professor Anna Smogorzewska, suggests that Bahra 1 may be the oldest known site for pottery production in the Gulf region.

The Bahra 1 site, dating back over 5700 years, is recognized as the oldest and largest known settlement from the Ubaid period in the Arabian Peninsula. The ongoing excavations, a collaboration between Kuwait's National Council for Culture and the Polish Center for Mediterranean Archaeology at the University of Warsaw, continue to shed light on the rich prehistoric heritage of the region.

Organization (WHO) recommended that free sugars should be less than 10 percent of the total daily energy of an individual, and preferably less than five percent to obtain additional health ben-

She explained that free sugars are those added to foods or drinks by manufacturers, chefs or consumers; in addition to the natural sugars found in honey, syrup, juices and drinks -- the excessive consumption of which leads to an increase in calories with low nutritional value, which negatively affects public health, especially among children.

She said studies indicate that sugar consumption in many countries in the Middle East ranges from nine to 15 percent of total energy; which increases the risk of obesity, heart disease, high blood pressure, type 2 diabetes and tooth decay -- one of the most common health problems among children.

Consequently, initiative was stifled unless driven by ideological, tribal, or sectarian motives, which were often imposed on institutions due to unpatriotic calculations. Rather than serving the public good, decisions were frequently based on selfish interests or political maneuvering, operating on the principle of "scratch my back, and I will scratch yours.'

Sadly, the drawers of the National Assembly and the Secretariat of the Council of Ministers are filled with approximately 400 important pieces of legislation that could serve the nation's interests and elevate Kuwait to new heights. This is just one example of the retrogressive nature of both government and parliamentary work.

Much of this legislation was driven by self-interest, either through issues like naturalization, the negative consequences of which we are witnessing today, or through increased spending aimed at furthering dubious goals.

At the same time, a slogan emerged insisting on not "touching the pockets of the people." While this sentiment was based on the right principle, it was motivated by the wrong reasons. The aim was not to protect the welfare of low-income citizens or those with modest salaries, but rather to increase the wealth of the already rich. The future of a nation with approximately 62 percent of its pop-

ulation being young people, many of whom have high aspirations to serve their country, cannot be shaped by legislative measures that seek to isolate the country and stifle its growth, to the point of turning it into something akin to Kandahar or Tora Bora. Unfortunately, there are those who continue to obstruct progress, particularly those who foster favoritism and nepo-

tism in all public sectors. As a result, many small and medium enterprise owners, especially young entrepreneurs, are left with no choice but to migrate to neighboring countries in search of better opportunities. However, the situation has changed. The major obstacle

that once stood in the way, namely, the National Assembly, has been temporarily suspended. Yet, this does not mean that the Council of Ministers can afford to sleep on silk. There is legislation that needs to be revised and amended

to better serve Kuwait and its people. In addition, officials must put in greater effort to inspire young people to work hard and contribute meaningfully to the nation's progress. His Highness the Amir Sheikh Meshal Al-Ahmad's reception of the young volunteer is a clear indication that

Kuwait and its citizens are always under His Highness the

Amir's watchful eye. Our Amir, being the leader of the nation, is the epitome of leadership, and his role as the head of the "rescue mission" sets a powerful example for all officials to follow.

VP still sending persistent appeals to donors

Harris, Democratic Party's funding operation raise \$1bln-plus in defeat

ATLANTA, Nov 17, (AP): Kamala Harris and the Democratic Party's prodigious fundraising operation raised more than \$1 billion in her loss to Donald Trump, but the vice president is still pushing donors for more money after the election.

Democrats are sending persistent appeals to Harris supporters without expressly asking them to cover any potential debts, enticing would-be donors instead with other matters: the Republican president-elect's picks for his upcoming administration and a handful of pending congressional contests where ballots are still being tallied.

"The Harris campaign certainly spent more than they raised and is now busy trying to fundraise," said Adrian Hemond, a Democratic strategist from Michigan. He said he was been asked by the campaign after its loss to Trump to help with fundraising.

The party is flooding Harris' lucrative email donor list with near-daily appeals aimed at small-dollar donors - those whose contributions are measured in the hundreds of dollars or less. But Hemond said the postelection effort also includes individual calls to larger donors

One person familiar with the effort and the Democratic National Committee's finances said the Harris campaign's expected shortfall is a relatively small sum compared to the breadth of the campaign, which reported having \$119 million cash on hand in mid-October before the Nov. 5 election. That person was not authorized to publicly discuss the campaign's finances and spoke on condition of anonymity.

But the scramble now underscores the expense involved in a losing effort and the immediate challenges facing Democrats as they try to maintain a baseline political operation to counter the Trump administration and prepare for the 2026 midterm elections. It also calls into question how Democrats used their resources, including hosting events with musicians and other celebrities as well as running ads in a variety of nontraditional spaces such as Las Vegas' domed Sphere.

Patrick Stauffer, chief financial officer for the Harris campaign, said in a statement that "there were no outstanding debts or bills overdue" on Election Day and there "will be no debt" listed

for either the campaign or the DNC on their next financial disclosures, which are due to the Federal Election Commission in December.

The person familiar with the campaign and DNC's finances said it was impossible to know just where Harris' balance sheet stands currently. The campaign still is getting invoices from vendors for events and other services from near the end of the race. The campaign also has outstanding receipts; for

example, from media organizations that must pay for their employees' spots on Air Force Two as it traveled for the vice president's campaign activities.

Within hours of Trump picking Florida Republican Matt Gaetz for attorney general on Wednesday, Harris' supporters got an appeal for more money for "the Harris Fight Fund," citing the emerging Trump team and its

Gaetz, who resigned his House seat after the announcement, "will weaponize the Justice Department to protect themselves," the email said. It said Democrats "must stop them from executing Trump's plans for revenge and retribution" and noted that "even his Republican allies are shocked by this" Cabinet choice.

Another appeal followed Friday in Harris' name.

"The light of America's promise will burn bright as long as we keep fighting," the email said, adding that "there are still a number of critical races across the country that are either too close to call or with the margin of

recounts or certain legal challenges." The emails do not mention Harris' campaign or its finances.

The "Harris Fight Fund" is a postelection label for the "Harris Victory Fund," which is the joint fundraising operation of Harris' campaign, the DNC and state Democratic parties. Despite the language in the recent appeals, most rankand-file donors' contributions would be routed to the national party, unless a donor took the time to contact DNC directly and have the money go directly to Harris or a state party.

The fine print at the bottom of the solicitation explains that the first \$41,300 from a person and first \$15,000 from a political action committee would be allocated to the DNC. The next \$3,300 from a person or \$5,000 from a PAC would go to the Harris for President "Recount Account." Anything beyond that threshold, up to maximum contribution limits that can reach into the hundreds of thousands of dollars, would be spread across state parties.

Officials at the DNC, which is set to undergo a leadership change early next year, indicated the party has no plans to cover any shortfall for Harris but could not explicitly rule out the party shifting any money to the campaign.

US House elections produce a stalemate

WASHINGTON, Nov 17, (AP): After one of the most chaotic and least productive sessions in modern history, voters made a surprising choice in elections for the US House -- they overwhelmingly

stuck with the status quo. House Republicans will hold onto a thin majority, and while the chamber's exact partisan divide is still to be determined as votes are tallied in a handful of states, the results of 435 House races nationwide have produced hardly any change

to the makeup of the chamber. In fact, it's more like a stalemate: Republicans and Democrats have each flipped seven seats, while just eight incumbents nationwide have lost their races.

The results show just how entrenched the political dynamics have become in a legislative chamber that is meant to closely reflect the will of the people. Neither Donald Trump's sweep of swing states nor a record of two years marked by infighting among GOP House members seemed to weigh much on House election results. Instead, the contest for control of the chamber boiled down to just a couple dozen politically divided districts and fewer truly close races even as House candidates nationwide spent a combined \$1.5 billion, according to Open Secrets, which

tracks political spending.

House Democratic Leader Ha-

keem Jeffries called it "bitterly disappointing" to see his party's bid to retake the House fall short by just a few seats. But he also made sure to note, "Notwithstanding the adverse political environment that happened with a Trump wave sweeping every single battleground state in America, Democrats will actually have increased the number of seats in the new Congress.

Still, that hasn't stopped Republican leaders from taking a victory lap and talking of a mandate to ir plement a conservative agenda.

"On Election Day, Americans sent a clear message to reject the consequences of Democratic control," said Rep. Richard Hudson, the chair of the GOP's House campaign committee, adding, "That's why voters delivered House Republicans a majority and sent Donald Trump to the White House in a landslide."

Trump is on track to win the popular vote for the first time, but it will likely be a narrow victory once all ballots are counted, reflecting how politically deadlocked the country has become. In the House, the margins will also be close, particularly after Trump chose several House Republicans for roles in his administration.

"Every single vote will count," said House Speaker Mike Johnson. "Because if someone gets ill, or has a car accident or a late flight on their plane, then it affects the votes on the floor.'

Johnson's party held onto the majority largely thanks to two seats the party flipped in Pennsylvania, as well as three more that were redistricted by the GOP-controlled North Carolina General Assembly to favor their party.

Democrats, meanwhile, did best in New York - Jeffries' home state where they flipped three seats. They also picked up two redistricted seats, in Louisiana and Alabama, that were ordered by courts to ensure fair representation for Black voters.

But as the congressional map becomes clear after the latest redistricting cycle following the 2020 census, some democracy advocates are concerned about the small number of House districts that are in play.

While Republicans for years won more congressional seats than expected through gerrymandered districts, Democrats have battled back by shaping districts to their advantage and essentially evened out the

playing field.
"The consequences are that the people's House barely reflects the will of the people. Voters have very little possibility to shift the balance of power in the House even when their moods change," said David Peters, who has written about gerrymandering and is a senior fellow at FairVote, an organization that advocates for voting reforms.

Greek ex-PM criticizes govt policies

Samaras expelled from New Democracy

ATHENS, GREECE, Nov 17, (AP): Former Greek prime minister and lawmaker Antonis Samaras was expelled from the ruling New Democracy party over his persistent criticism of government policies.

Samaras, 73, a hard-line nationalist, has criticized Prime Minister Kyriakos Mitsotakis' approach to negotiations with Turkey, which he has likened to appeasement. He also strongly disapproved of government policy that he considered too "centrist" or "woke".

The government appeared particularly irked by a Samaras interview to be published in Sunday newspaper To Vima in which he called for the ouster of Foreign Minister George Gerapetritis over his conduct of negotiations with Turkey.

"Mr. Samaras ... did not just express opinions. He expressed his complete disagreement with all governing policies. Moreover, he adopted extreme lies (about the foreign minister) in an unbecoming and provocative manner,' said government spokesman Pavlos Marinakis in announcing Samaras' expulsion Saturday afternoon.

Samaras responded in a lengthy statement, saying, "Arrogance and loss

of nerve explain Mitsotakis' move. Cut off from the party base, he is leading a party that scarcely resembles New Democracy.'

It is not the first time that Samaras

has clashed with a Mitsotakis. In 1992 then-Prime Minister Constantine Mitsotakis, father of the current premier, dismissed Samaras as foreign minister over policy differences regarding the name dispute with what was then the Former Yugoslav Republic of Macedonia, the present North Macedonia.

In 1993, Samaras and a few likeminded lawmakers left New Democracy, bringing down the Mitsotakis government and ushering in more than 10 years of socialist rule. Samaras founded his own short-lived party, Political Spring.

Samaras succeeded former Prime Minister Costas Karamanlis as head of the conservatives in 2009, but left the post after an electoral defeat in 2015. "This time, history will not re-

peat itself. The government majority continues its course, without Mr. Samaras," said the governent spokesman. 'No one has the right to mess with the country's stability in these troubled times," said Marinakis.

The ruling conservatives have a slight majority in Parliament, with 155 lawmakers out of 300. But Samaras has a number of supporters among that group, as does the now retired Kara-

Reactions to Donald Trump's victory mixed on NATO's eastern flank

WARSAW, Poland, Nov 17, (AP): Conservative lawmakers in the Polish parliament exulted at Donald Trump's victory, standing and applauding while they chanted his name.

The prospect of a second Trump term has excited people on the populist right across Central Europe who share his anti-immigrant views and contempt for international organizations.

But many others in a region near the war in Ukraine are afraid. They worry Trump could abandon Ukraine and force Kyiv into a deal that ends up emboldening Russia further, or unwind the U.S. military presence in Europe.

The change in Washington means Europe will have to invest more in its security and defense rather than relying on the American protective shield as it has done for decades, argues Michał Baranowski, managing director of Warsaw-based GMF East, part of the German Marshall Fund think tank.

"We Europeans - Poles and French and Brits and preferably Germany as well - need to step up," Baranowski said. "Only by stepping up do we have a chance to keep the worst case scenarios from happening, both a bad deal in Ukraine and perhaps a lowering of US engagement in Europe.

Poland, the Baltic states and other nations across Central and Eastern Europe were under Moscow's control during the Cold War. When that era ended in 1989, it freed them to turn to the West. They never want to return to being satellites of Moscow.

NATO members now, they worry that Trump in his second term could end a decades-long commitment to securing the peace in Europe. Just this week, a missile defense base in northern Poland was inaugurated - the fruit of years of planning by Republican and Democratic administrations. Polish officials expressed hopes that it was a sign that a bipartisan U.S. commitment to the region would endure.

"The whole world will see clearly that this is not Russia's sphere of interest anymore," Polish President Andrzej Duda declared. Trump has a long history of denigrat-

ing NATO, and former administration

officials say he repeatedly threatened to withdraw the U.S. from the alliance.

His allies have described that as bluster or tough negotiating tactics that have pushed other European allies to take more responsibility, and argue that Trump didn't abandon NATO.

The change in Washington has in just a few days changed the dynamic of Poland's presidential campaign before an election next spring. Foreign Minister Radek Sikorski, a former defense minister with ties in Washington, entered the running to be the candidate for centrist Prime Minister Donald Tusk's party, challenging the longtime favorite, Warsaw Mayor Rafał Trzaskowski.

Sikorski argues that his experience makes him the better choice for the times. His opponents argue that the anti-Trump views of his wife, the American writer Anne Applebaum, could create complications with Trump's upcoming administration.

The region is now holding its collective breath to see what a second Trump presidency will bring. Officials in Poland and the Baltic states have been stressing their high defense spending - relative to their overall economic output - in their congratulatory messages to Trump.

Kersti Kaljulaid, who was Estonia's

president during Trump's first term, told the Estonian public broadcaster ERR that Estonians, Poles and others in Eastern Europe found ways to reach Trump before, "and I think that this skill is something that we still have today.

All are now watching to see if Trump will make a deal with Russia to end the war in Ukraine, as he has promised. It is a cause of existential importance, because any deal is expected to shape security in the region in profound ways in the years and decades to come.

The biggest fear would be a deal that gives Russia significant Ukrainian territory, rewarding President Vladimir Putin's violation of international law and allowing Moscow to rebuild its military strength.

Poland's Tusk has stressed that no deal should be made over the heads of Ukraine and countries in the region that will be affected.

"There is no doubt that the new political landscape is a serious challenge

for everyone," Tusk said last week. Tusk congratulated Trump last week and is striking a conciliatory tone af-

ter having been critical in the past of a position seen by most Poles as overly friendly to Putin.

Russia launches one of fiercest missiles, drone attacks at Ukraine infrastructure

KYIV, Ukraine, Nov 17, (AP): Russia on Sunday launched a massive drone and missile attack on Ukraine, described by officials as the largest over the past months, targeting energy infrastructure and killing civilians.

The attack came as fears are mounting about Moscow's intentions to devastate Ukraine's power generation capacity ahead of the cold winter.

President Volodymyr Zelenskyy said that Russia had launched a total of 120 missiles and 90 drones in a largescale attack across Ukraine. Various types of drones were deployed, he said, including Iranian-made Shaheds as well as cruise, ballistic and aircraftlaunched ballistic missiles.

Ukrainian defenses shot down 140 air targets, Zelenskyy said in a statement on the Telegram messaging app. "The enemy's target was our energy

infrastructure throughout Ukraine. Unfortunately, there is damage to objects from hits and falling debris. In Mykolaiv, as a result of a drone attack, two people were killed and six others were injured, including two children," Zelenskyy said.

Two others were killed in the Odesa region, where the attack damaged energy infrastructure and disrupted power and water supplies, said local Gov. Oleh Kiper.

The combined drone and missile attack was the most powerful in three months, according to the head of Kyiv's City Military Administration Serhii Popko.

Russian strikes have hammered

Ukraine's power infrastructure since Moscow's all-out invasion of its neighbor in February 2022, prompting repeated emergency power shutdowns and nationwide rolling blackouts. Ukrainian officials have routinely urged Western allies to bolster the country's air defenses to counter assaults and allow for repairs.

Explosions were heard across Ukraine on Sunday, including in capital Kyiv, the key southern port of Odesa, as well as the country's west and central regions, according to local reports.

The operational command of Poland's armed forces wrote on X that Polish and allied aircraft, including fighter jets, have been mobilized in Polish airspace because of the "massive" Russian attack on neighboring Ukraine. The steps were aimed to provide safety in Poland's border areas, it said.

'Sixth major storm to hit country in less than a month'

Latest typhoon lashes Philippines, displacing massive numbers of people

MANILA, Philippines, Nov 17, (AP): A powerful typhoon wrecked houses, caused towering tidal surges and forced hundreds of thousands of people to flee to emergency shelters as it cut across the northern Philippines on Sunday in the sixth major storm to hit the

country in less than a month.

Typhoon Man-yi slammed into the eastern island province of Catanduanes on Saturday night with sustained winds of up to 195 kilometers (125 miles) per hour and gusts of up to 240 kph (149 mph). The country's weather agency warned of a "potentially catastrophic and life-threatening situation" in provinces along its path.

There were no immediate reports of casualties from the typhoon, which was forecast to blow northwestward on Sunday across northern Luzon, the archipelago's most populous region. The capital region of metropolitan Manila would likely be spared from a direct hit but was placed, along with outlying regions, under storm alerts and warned of dangerous coastal storm surges.

"The rain was minimal, but the wind was

very strong and had this eerie howling sound," Roberto Monterola, a disaster-mitigation officer in Catanduanes, told The Associated Press by telephone. "Along a main boulevard here, the tidal surges went up to more than 7 meters (23 feet) near the seaside houses. It looked re-

The entire province of Catanduanes had no power after the typhoon knocked down trees and electricity posts, and disaster-response teams were checking how many more houses were damaged in addition to those impacted by previous storms, he said.

'We need tin roofs and other construction materials, aside from food. Villagers tell us here that they still haven't gotten up from the past storm and were pinned down again by this typhoon," Monterola said. Nearly half of the island province's 80,000 people were sheltering in evacuation centers.

Catanduanes officials were so concerned as the typhoon approached that they threatened vulnerable villagers with arrest if they did not follow orders to evacuate to safer grounds. More than 750,000 people took refuge in emergency shelters, including churches and a shopping mall, due to Man-yi and two previous storms mostly in the northern Philippines, Assistant Secretary Cesar Idio of the Official of Civil Defense and other provincial officials

The rare number of back-to-back storms and typhoons that lashed Luzon in just three weeks left more than 160 people dead, affected 9 million people and caused such extensive damage to residential communities, infrastructure and farmlands that the Philippines may have to import more rice, a staple food for most Filipinos. In an emergency meeting as Man-yi approached, President Ferdinand Marcos Jr. asked his Cabinet and provincial officials to brace for "the worstcase scenario.

At least 26 domestic airports and two international airports were briefly shut and interisland ferry and cargo services were suspended due to rough seas, stranding thousands of passengers and commuters, according to the Civil Aviation Authority of the Philippine and the coast guard.

Xi cautions US to 'make the wise choice' to keep relations stable

LIMA, Peru, Nov 17, (AP): China's leader Xi Jinping met for the last time with US President Joe Biden on Saturday but was already looking ahead to President-elect Donald Trump and his "America first" policies, saying Beijing "is ready to work with a new US administration.'

During their talks on the sidelines of the annual Asia-Pacific Economic Cooperation summit in Peru, Xi cautioned that a stable China-U.S. relationship was critical not only to the two nations but to the "future and destiny of human-

"Make the wise choice," he cautioned. "Keep exploring the right way for two major countries to get along well with each other.'

Without mentioning Trump's name, Xi appeared to signal his concern that the incoming president's protectionist rhetoric on the campaign trail could send the U.S.-China relationship into another valley.

"China is ready to work with a new US administration to maintain communication, expand cooperation and manage differences so as to strive for a steady transition of the China-U.S. relationship for the benefit of the two peoples,' Xi said through an inter-

Xi, who is firmly entrenched atop China's political hierarchy, spoke forcefully in his brief remarks before reporters. Biden, who is winding down more than 50 years of public service, talked in broader brushstrokes about where the relationship between the two countries has gone.

He reflected not just on the past four years but on the decades the two have known each other.

"We haven't always agreed, but our conversations have always been candid and always been frank. We've never kidded one another," Biden said. "These conversations prevent miscalculations, and they ensure the competition between our two countries will not veer into conflict.'

Biden urged Xi to dissuade North Korea from further deepening its support for Russia's war on Ukraine. The leaders, with top aides surrounding them, gathered around a long rectangle of tables in an expansive conference room at a Lima hotel.

They had much to discuss, including China's indirect support for Russia, human rights issues, technology and Taiwan, the self-ruled democracy that Beijing claims as its own. On artificial intelligence, the two agreed on the need to maintain human control over the decision to use nuclear weapons and more broadly improve safety and international cooperation of the rapidly expanding technology

Venezuela releases dozens of prisoners after anti-government protests

TOCUYITO, Venezuela, Nov 17, (AP): Venezuela's government on Saturday released some of the thousands of people who were detained during and after deadly protests that followed the July presidential election. The disputed results have earned officials, including President Nicolás Maduro, international scorn.

The individuals left prison a day after the attorney general, who is loyal to the ruling party, announced the review of 225 cases linked to the aftermath of the election, which Maduro and opposition candidate Edmundo González both claim to have won. Tearful reunions took place outside prisons in various cities.

The Venezuelan-based nongovernmental organizations Penal Forum and Venezuelan Prison Observatory announced the prison releases on X. The former confirmed the release of at least 70 people, while the latter said the government freed the individuals under certain conditions, which it did not explain further.

Maduro's government has come under heavy criticism for the election's lack of transparency and the repression unleashed in its aftermath, including the arrests of political leaders, lawyers, poll workers, election volunteers and protesters, both minors and adults.

The protests erupted after Venezuela's electoral authorities declared Maduro had won the July 28 contest and alleged they could not publish precinct-level results because their website had been hacked.

Senegalese vote in parliamentary election

DAKAR, Senegal, Nov 17, (AP): Polls opened in Senegal on Sunday for a parliamentary election that is set to determine if the country's newly elected president can carry out ambitious reforms.

More than 7 million registered voters in the West African country are choosing 165 lawmakers in the national assembly, where the party of President Bassirou Diomaye Faye currently does not hold a majority.

Faye, who was elected in March on an anti-establishment platform, says that has blocked him from executing the reforms he pledged during his campaign, including fighting corruption, reviewing fishing permits for foreign companies and securing a bigger share from the country's natural resources for the population.

In September, he dissolved the opposition-led parliament, paving the way for a snap legislative election. His party is facing the Takku Wallu opposition platform led by former President Macky Sall, alongside 39 other registered parties and coalitions.

Polls will close at 6 pm (1800

GMT). The first provisional results are expected to be known by Monday morning, but the final count will only

be published later during the week.

Faye's political party, PASTEF, needs at least 83 seats in order to gain a majority in the assembly. Analysts say it has a high chance of securing that, given its popularity and Faye's margin of victory in the March presidential election.

Faye, 44, was elected with 54% in the first round, becoming Africa's youngest elected leader, less than two weeks after he was released from prison. His rise has reflected widespread frustration among Senegal's youth with the country's direction - a common sentiment across Africa, which has the world's youngest population and a number of leaders accused of clinging to power for decades.

Over 60% of Senegalese are under 25 and 90% work in informal jobs. Senegal has been hit by skyrocketing inflation in recent years, making it difficult for them to get by.

The country is also a major source of irregular migration to Europe, with thousands leaving every year on rickety, artisanal fishing boats in search of economic opportunities.

13 killed, more kidnapped by extremist rebels in Congo

At least 13 people were killed and others kidnapped in eastern Congo by extremist rebels linked to the Islamic State group, local authorities said Saturday.

Rebels with the Allied Democratic Forces, which has ties to IS, killed civilians in Mabisio village in North Kivu province, said the area's administrator, Col. Alain Kiwewa, on state television.

Women were among those killed in the attack late Friday evening, and houses were burned and looted, he said.

Eastern Congo has struggled with armed violence for decades as more than 120 groups fight for power, land and valuable mineral resources, while others try to defend their communities. Some armed groups have been accused

of mass killings. In recent years, ADF attacks have intensified and spread towards Goma, eastern Congo's main city, as well as neighboring

Ituri province. Rights groups and the United Nations have accused the ADF of

killing hundreds of people and abducting even more, including a significant number of children. In August, the ADF killed at least

12 people in several villages in North Kivu.

GCC exports fall to KD 11.9 mln

Kuwait's non-oil exports dip to KD 21.1 mln in Oct

KUWAIT CITY, Nov 17: The Ministry of Commerce and Industry has reported a decline in Kuwait's total local exports (excluding oil) in October, amounting to 21.1 million dinars, down from 24.4 million dinars in September, reports Al-Seyassah daily.

Saleh Al-Azmi, Undersecretary of the International Organizations Affairs and Foreign Trade Sector, provided details to the Kuwait News Agency (KUNA), highlighting the total certificates of origin issued for Kuwaiti

For the Gulf Cooperation Council (GCC) countries, 1,823 certificates were issued last October, valued at KD 11.9 million, compared to 1,781 certificates worth KD 14.6 million in September.

Exports to Arab countries saw a decrease in both the number of certificates and value, with 322 certificates worth KD 8.3 million issued in October, compared to 370 certificates valued at KD 8.06 million in September.

In Europe, 7 certificates were issued to five countries, down from 9 certificates for six countries the previous

The African exports showed a significant drop, with only two certificates worth KD 29,737 issued, compared to four certificates worth KD 54,299 in September.

Exports to the Americas also saw a decline, with 11 certificates issued in October valued at KD 116,363. compared to 6 certificates worth KD 163.862 the month before

Exports to Asian countries and Australia increased slightly, with 5 certificates issued to three countries worth KD 88,404, compared to three certificates for three countries valued at KD 48,366 in September.

Oil price target set at \$91

Kuwait's budget deficit projected at \$18 billion

THE oil price in Kuwait's budget for next year must reach \$91.00 per barrel. This figure

is based on our upcoming fiscal budyear get, starting April 1, with a projected deficit KD 6 billion (approximately \$18 billion). The

total budget is set at KD 25 billion, which is KD 2 billion lower than the current year's budget.

It is worth noting that the government has announced an equilibrium price to balance the budget for the first time. This budget is based on a crude oil price estimate of \$70 per barrel. However, it is unlikely that oil prices will remain at this level, as they are expected to remain within the range of \$75 to \$80 per barrel.

Achieving a balanced budget while reducing expenses will be a significant accomplishment, but it definitely is worth trying. The government's goal is to cut costs, which will be a challenging yet necessary task.

At the same time, the government plans to create over 24,000 new job opportunities in the next 12 months, which will be a true challenge for our new Prime Minister and his administration.

While some figures have been announced and published, the most important number in the budget has not yet been disclosed, or may have been overlooked - Kuwait's crude oil production for the next year or the present level of crude oil production. However, we can

estimate that it is around 2.8 million barrels per day, which could generate KD 22 billion in revenue. This would result in a lower deficit of approximately KD 2.5 billion, or potentially a balanced budget with no deficit, assuming an oil price of \$80 per barrel and production at 2.8 million barrels per day. If oil prices reach the projected \$91 per barrel, it would be a blessing.

Currently, Kuwait is expected to incur a KD 6 billion deficit in the current fiscal year, with more than 55 days remaining to close the books before the fiscal year ends on March 31.

This brings us to the challenge of tackling the KD 6 billion shortage. The options on the table include borrowing from international banks, tapping into our sovereign wealth funds, or thinking outside the box such as ing some of the oil com panies. The latter could serve as an effective solution, as it would provide immediate cash to the government and also strengthen the private sector. It could promote economic growth by offering job opportunities for our national graduates and encouraging private sector develop-

While this is a promising solution, it will require huge efforts from both the government and the private sector to make it

The goal is to achieve a positive budget with reduced expenses and a lower deficit compared to previous years. The question remains whether we can maintain this level of expenditure and fulfill our obligations.

We wish the new government and its leadership success in reducing the budget deficit without resorting to borrowing. It is

time for a new era.

Bidding opens Nov 17 for KPC cafeteria tender

KPC postpones tender dates for communication network project

KUWAIT CITY, Nov 17: Kuwait Petroleum Corporation (KPC) has announced the postponement of the preliminary meeting and closing of the tender for the supply, operation and maintenance of communication network and support devices for its main building and the Petroleum Training Center.

The corporation said that the preliminary meeting will be held on Nov 21, instead of Nov 12; while the closing date was rescheduled from Dec 10 to Dec 17.

It also announced the launching of a tender for the operation and management of the cafeteria of the oil complex to provide food services. In its announcement in the official gazette -- Kuwait Al-Youm, KPC said the bidding for this tender will be on Nov 17 and the closing date will be Dec 24; adding that this tender is for companies specialized in the field and it is not divisible.

KPC explained it is not permissible for one person or a group to register the classification with more than one name or to submit more than one bid in a tender, except for alternative bids, as per the tender conditions.

According to the corporation, an individual who owns shares in separate companies and each company is independent in terms of legal personality, finances, engineers, employees and general administrative system is allowed to register himself and each of the companies.

Moreover, Kuwait Oil Tankers Company (KOTC) announced the extension of the deadline for submitting bids for the tender for renting computers, printers and accessories, and providing maintenance and technical support services to the company; so the new deadline is Dec 17 instead

Kuwait Central Bank holds discount rate steady at 4.0% despite Fed cuts

US Fed cuts rates to 4.50%-4.75%, inflation declines

KUWAIT CITY, Nov 17: According to the weekly report from Al-Shall Center, the US Federal Reserve reduced the benchmark interest rate by a quarter of a percentage point on November 7, bringing it to a range between 4.50 percent and 4.75 percent, reports Al-Jarida daily.

This move was in line with most market expectations and was driven by the continued decline in inflation rates.

The report highlights that the Fed has largely achieved its goal of controlling inflation, which is now on a downward trajectory toward the target of

Additionally, there are indications of a weaker labor market, though the unemployment rate remains

Despite the tight monetary policies, the US economy has shown resilience, with forecasts suggesting a potential growth of 2.8 percent in 2024 and 2.2 per-

These growth expectations outpace those of the Eurozone and its G7 partners (excluding Canada), with the International Monetary Fund (IMF) projecting a 2.4 percent growth rate for the Eurozone in

The report emphasizes that the likelihood of a "soft landing" for the US economy is higher than ever, but it also cautions that the Federal Reserve remains vigilant, monitoring variables to maintain a balance between controlling inflation, sustaining a strong labor market, and supporting economic growth.

A major uncertainty mentioned is the potential impact of a trade war, should President Trump's reelection lead to the implementation of protectionist policies. With the US and China representing roughly 43.1 percent of the global economy, such a development could have significant implications for global

Al-Shall also noted that the US Federal Reserve's rate cuts are positive for the Gulf countries, which had previously raised their interest rates to align with the US to protect their currencies, as their exchange rates are pegged to the dollar.

As a result, the Gulf countries reduced their interest rates for the second time this year by a quarter of a percentage point, except for Qatar, which opted for a 0.30 percent reduction. These cuts are expected to ease financing burdens and support economic activ-

However, Kuwait remains an outlier in this scenario because when the US Federal Reserve cut interest rates by 0.50 percent on September 18, the Central Bank of Kuwait followed by reducing the dinar's discount rate by 0.25 percent.

However, when the Fed made another 0.25 percent reduction on November 7, the Central Bank of Kuwait chose not to follow suit, keeping its discount rate at 4.0 percent.

Al-Shall considers both decisions to be valid, noting that they have effectively narrowed the interest rate margin between the US dollar and the Kuwaiti dinar from 1.00 percent-1.25 percent before September 18, to 0.50 percent-0.75 percent now. This, in turn, strengthens the Kuwaiti dinar's peg and currency stability.

The report suggests that while the other GCC countries have taken steps to align their rates with the US to support their economies, Kuwait's more cautious approach helps maintain the strength and stability of its own currency.

United States

Inflation in the US rose in October, with the yearover-year figure rising 2.6%, up from 2.4% the previous month. The month-over-month figure rose 0.2%, meeting expectations and matching the rise seen in the previous month. Meanwhile, core inflation rose 3.3% y/y, unchanged from the previous month. The monthly core price increase stood at 0.3%, meeting expectations and the same pace seen in September. The main contribution to the rise in the figures came from housing and shelter, which accounted to half of the monthly all items increase. Expectations for a rate

cut in December are currently around 58%. **US Producer Price Index**

In October 2024, US factory gate prices rose by 0.2% month-on-month, following a revised 0.1% increase in September, aligning with expectations. Service prices increased by 0.3% (up from 0.2% in September), driven significantly by a 3.6% rise in portfolio management costs. Other sectors with price increases included machinery and vehicle wholesaling, airline services, computer retailing, outpatient care, and cable services. Goods prices rose slightly by 0.1%, ending a two-month decline, with carbon steel scrap prices surging 8.4% and increases noted for meats, diesel, vegetables, and oilseeds. Year-on-year, the Producer Price Index (PPI) rose by 2.4%, above September's 1.9% and the 2.3% forecast. Core PPI increased by 0.3% monthly (up from 0.2%), and the annual core rate reached 3.1%, surpassing expectations of 3%.

Unemployment Claims

In the week ending November 9th, US unemployment benefit claims dropped by 4,000 to 217,000, the lowest since May, and below the expected increase to 223,000. Continuing unemployment claims decreased by 19,000 to 1,873,000 in late October. This data reinforces the strength of the US labor market despite recent Federal Reserve tightening, giving the central bank flexibility to slow monetary easing if inflation persists. The four-week average for initial claims, which smooths out fluctuations, decreased by 6,250 to 221,000. On a nonseasonally adjusted basis, initial claims rose by 16,735 to 229,478, mainly due to a rise in California offsetting a

In October 2024, US retail sales rose by 0.4% monthover-month, surpassing expectations of a 0.3% increase, following a revised 0.8% gain in September. The largest sales increases were seen in electronics & appliance stores (2.3%), auto dealers (1.9%), and food services & drinking places (0.7%). Gains were also recorded in

0.8756 0.8750 0.8917 0.8880 building materials, nonstore retailers, general merchandise, food & beverage, and gasoline stations. However, sales fell in categories like miscellaneous store retailers (-1.6%), furniture (-1.3%), sporting goods, and clothing. Excluding autos, sales edged up 0.1%. Core retail sales, excluding key categories tied to GDP calculations, de-

creased by 0.1% The US Dollar Index closed the week at 106.69.

Europe **Words From the ECB**

The European Central Bank (ECB) indicated a potential move towards rate cuts during its December meeting, driven by expectations of easing inflation, particularly from lower energy prices. However, concerns remain over domestic inflation pressures like strong wage growth and weak labor productivity. Despite a positive inflation outlook, the ECB emphasized the need for more data before making policy decisions. Policymakers highlighted that any rate cut would rely on the economic outlook and clear evidence of reduced inflation pressures, signaling a cautious, data-dependent approach.

United Kingdom

The UK economy slowed more than expected in the third quarter, following an unexpected contraction in September as concerns mounted over the Labor government's fiscal plans. According to the Office for National Statistics, GDP rose by just 0.1% compared to the previous quarter, falling short of the 0.2% growth economists had anticipated. In September alone, the economy shrank by 0.1%, contrasting sharply with the forecasted 0.2% expansion. The disappointing figures pose a challenge to Prime Minister Keir Starmer's pledge to boost UK growth to 2.5% annually, aiming to make it the fastest among the Group of Seven economies. After leading G-7 growth in the first half of the year and rebounding from last year's mild recession, the UK's growth slowed significantly from 0.5% in the second quarter. The decline appears linked to growing concerns over Labor's fiscal policies, with consumer and business confidence plunging in September amid fears of tax increases. These fears materialized on October 30, when Labor announced £40 billion (\$50.7 billion) in tax hikes, with businesses bearing most of the burden.

Australia's Unemployment

Australia's unemployment rate came in at 4.1%, marking the third month of steady unemployment after reaching 3.5% in June. The participation rate increased to 67.2%, while the underemployment rate remained at 6.3%. Meanwhile, markets are currently expecting no change from the Reserve Bank of Australia, with only 2.5 bps priced in for a December cut.

Australia's Wage Growth

Australia's wage growth showed signs of moderation in Q3 2024, with the seasonally adjusted wage price index rising 3.5% year-on-year, down from 4.1% in the previous quarter. This marked the weakest growth since late 2022 and fell short of expectations for a 3.6% increase. Public sector wage growth outpaced private sector growth for the first time since 2020, at 3.7% compared to 3.5%. Meanwhile, quarterly wage growth remained steady at 0.8%, unchanged from the prior two quarters, and below market forecasts of 0.9%. These figures underline a cooling in wage growth momentum.

Total revenues reach USD 475 million, reflecting stable performance

Egypt Kuwait Holding records USD 124 mln net income in 9 months

Egypt Kuwait Holding Company (EKH) announced its consolidated financial results for the period ending 30 September 2024, prepared in accordance with Egyptian Accounting Standards for the first nine months of 2024, EKH recorded revenues of USD 475 million, maintaining profitability levels throughout the period. Net profit was USD 139 million, with a net profit margin of 29%, while net income attributable to EKH shareholders reached USD 124 million.

In the third quarter of 2024, EKH reported revenues of USD 154 million, a 20% quarter-on-quarter growth, driven primarily by the Energy and Energy-Related segment. Net profit was USD 39 million in the third quarter of the year, with net income attributable to EKH shareholders totaling USD 34 million for the same period.

Commenting on the Group's performance during the first nine months of 2024, Loay Jassim Al-Kharafi, Chairman of EKH, stated that the results underscore the resilience of EKH's investment model and the strength of its operational capabilities. He added that this performance reflects EKH's success in delivering sustainable value to shareholders and advancing its growth trajectory, as the Group maintained strong profitability levels despite economic challenges.

concession, EKH has invested USD 247 million in exploration and development activities, adding approximately 223 billion cubic feet to gas reserves.

He added that the Group is focused on maximizing sustainable value for shareholders through a proactive capital recycling strategy. This approach involves optimizing the performance of its investment portfolio by leveraging competitive advantages and export potential, in addition to enhancing collaboration among subsidiaries.

Meanwhile, Jon Rokk, CEO of EKH, expressed pride in the strong results achieved by the Group during the first nine months of the current year, despite the adverse impact of the EGP devaluation against the USD on Group revenues. Fertilizers and Petrochemicals Sector

Rokk noted that revenues from the Fertilizers and Petrochemicals sector reached USD 74 million during the third quarter of 2024, while net profit totaled USD 28 million, with a 4-point improvement in the net profit margin to reach 38%.

He pointed out that the Group benefited from an increased stake in Alexandria Fertilizer Company (AlexFert), enabling the company to achieve positive results driven by an 11% quarter-on-quarter increase in urea export prices to USD 335 per ton. He expressed confidence in the company's ability to continue achieving strong results in the coming period, supported by global urea price increases and steady gas supplies thanks to recent Egyptian government efforts. Meanwhile, Sprea Misr recorded revenues of USD 27 million during the third quarter of 2024, reflecting a quarter-on-quarter increase of 3%, supported by gradual price recovery. Net profit reached USD 10 million, with the net profit margin expanding to 38% in the third quarter of 2024.

Energy Sector

On a related note, revenues from the Energy and Energy-Related segment totaled USD 57 million during the third quarter of 2024, marking a year-on-year increase of 12% and a 57% quarter-on-quarter increase. This performance was driven by strong results from both NatEnergy and the North Sinai offshore gas concession. The segment's net profit amounted to USD 15 million, with an increase in the net profit margin

NatEnergy reported revenues of USD 42 million in the third quarter of 2024, representing a yearon-year growth of 15%, supported by growth in Kahraba's electricity distribution activities, along with progress by Fayum Gas in its highpressure steel pipeline project. NatEnergy achieved net profit of USD 10 million in the third quarter of 2024, with positive future prospects supported by anticipated increases in natural gas connection fees and electricity tariffs, which will help improve profit margins.

Furthermore, the North Sinai offshore gas concession generated revenues of USD 15 million during the third quarter of 2024, representing a year-on-year growth of 5% and an 11% quarter-on-quarter increase, driven by successful commissioning of new wells that boosted production volumes. Net profit for the period reached USD 6.5 million, with a net profit margin of 43%.

Insurance Sector

Revenues from the Insurance and Diversified segment amounted to USD 22 million during the third quarter of 2024, supported by the segment's continued strong performance from the previous

Delta Insurance, the largest contributor to the segment's revenues, generated USD 18 million during the third quarter of 2024, a yearon-year growth of 20%, driven by revaluation of insured assets and rising insurance premiums, along with improved returns on the insurance portfolio supported by high interest rates. Delta Insurance's net profit contribution to EKH grew by 28% year-on-year to USD 4 million in the third quarter of 2024, translating to a growth of over 97% in EGP terms, reflecting the strong fundamentals and significant growth potential of the sector.

It is worth noting that Egypt Kuwait Holding Company, established in 1997 with issued and paid-in capital of USD 282 million and listed on both Boursa Kuwait and the Egyptian Exchange, is one of the Middle East's leading and fastest-growing investment entities. The company's diversified investment portfolio spans five main sectors, including fertilizers and petrochemicals, gas distribution, power generation and distribution, as well as insurance and non-banking financial services.

Boursa Kuwait wraps up on positive note

KUWAIT CITY, Nov 17, (KUNA): Boursa Kuwait concluded Sunday's trading session on a positive note, with gains observed across all major indices.

The General Index rose by 20.54 points (0.28%) to close at 7,319.38 points. Market activity remained robust, with 433.7 million shares changing hands through 19,967 transactions, totaling KD 72.2 million (approximately USD 220.2 million).

The Main Market Index showed

significant strength, climbing 33.07 points (0.50%) to reach 6,654.92 points. This segment saw 335.18 million shares traded through 14,778 transactions, valued at KD 42./ million (USD 130.2 million).

The Premier Market Index also advanced, gaining 18.21 points (0.23%) to close at 7,848.92 points. Trading in this market involved 98.5 million shares across 5,189 transactions, worth KD 29.4 million (USD 89.6 million).

Additionally, the Main 50 Index increased by 7.18 points (0.11%) to 6,545.33 points. This index saw 1/9.11 million shares traded through 8,068 transactions, valued at KWD 27.10 million (approximately USD 82.6 million).

Inflation stuck above target

Firm expands digital services with global OTT partnerships and growth

WASHINGTON, Nov 17, (AP): Chair Jerome Powell said Thursday that the Federal Reserve will likely cut its key interest rate slowly and deliberately in the coming months, in part because inflation has shown signs of persistence and the Fed's officials want to see where it heads next.

Powell, speaking in Dallas, said that inflation is edging closer to the central bank's 2% target, "but it is not there

At the same time, he said, the economy is strong, and the policymakers can take time to monitor the path of inflation.

"The economy is not sending any signals that we need to be in a hurry to lower rates," the Fed chair said. "The strength we are currently seeing in the economy gives us the ability to approach our decisions carefully

Economists expect the Fed to announce another quarter-point rate cut in December, after a quarter-point reduction last week and half-point cut in

But the Fed's steps after that are much less clear. In September, the central bank's officials collectively signaled that they envisioned cutting their key rate four times in 2025. Wall Street traders, though, now expect just two rate reductions, according to futures pricing tracked by CME Fed-Watch. And after Powell's cautious remarks Thursday, traders estimated the likelihood of a Fed rate cut in December at just below 59%, down from 83% a day earlier.

The Fed's benchmark interest rate tends to influence borrowing rates across the economy, including for mortgages, auto loans and credit cards. Other factors, though, can also push up longer-term rates, notably expectations for inflation and economic growth.

For example, Donald Trump's presidential election victory has sent yields on Treasury securities higher. It is a sign that investors expect faster growth next year as well as potentially larger budget deficits and even higher inflation should Trump impose widespread tariffs and mass deportations of migrants as he has promised.

In his remarks Thursday, Powell



The localization rate of offshore wind turbines in China has surpassed 90 percent.

In the future, the offshore wind power industry should innovate in its industrial integration models, strengthen core technology research and deepen coordinated industrial development, so as to form internationally competitive industrial clusters, said Shu Yinbiao, an academician of the Chinese Academy of Engineering.

G20 should lead global economic governance toward fairness

BEIJING, Nov 17, (Xinhua): As world leaders are to gather in Rio de Janeiro, Brazil, for the 19th G20 Summit, the moment calls fvor decisive steps toward creating a more just, sustainable, and inclusive global

Themed "Building a just world and a sustainable planet," this summit presents a critical opportunity to recalibrate global economic governance and chart a path toward sustainable and inclusive development.

The G20's influence is unparalleled. Boasting about 85 percent of global GDP, over 75 percent of international trade, and two-thirds of the world's population, the G20 possesses both the economic weight and the diversity to drive changes the world urgently needs.

This summit marks the first gathering of G20 leaders since the inclusion of African Union (AU) as a full member, a historic milestone that strengthens the voice of the Global South.

However, inclusion alone is insufficient. The G20 must ensure that the voice of the AU and the wider Global South is not merely heard but also translated into tangible influence.

As a forum representing the world's largest econo-

mies, the G20 has a responsibility to champion the genuine interests of the Global South by concrete steps, including prioritizing infrastructure funding tailored to the needs of the Global South countries and expanding access to green technologies.

Regrettably, in an increasingly divided world, some Western politicians have resorted to a smear campaign against development cooperation between China and Africa. Dismissing the transformative benefits these projects bring to local economies, they are given to baseless criticisms that reveal not only their bias but also a fundamental disregard for the development priorities of the Global South.

This shortsightedness underscores the urgency for the G20 to break away from such divisive rhetoric and foster a more inclusive and equitable global order.

The G20 must also take a strong stance against growing protectionism, which threatens to unravel the hard-earned progress of global prosperity.

Protectionist measures like tariffs, trade barriers, and other unfair practices are often sold as remedies for domestic challenges, but their true cost is borne by the global economy, particularly by developing nations that rely on open markets to fuel growth and

Far from providing solutions, protectionist policies exacerbate inequalities, stifle progress, and obstruct global efforts to tackle shared global crises.

Take as an example Washington and some of its allies' recent bid to suppress China's electric vehicle industry under the guise of addressing so-called "overcapacity." The maneuver not only undermines international cooperation in green technologies but also jeopardizes the global fight against climate

By erecting trade barriers, those countries heighten risks of slowing innovation, disrupting supply chains, and restricting access to affordable, sustainable solutions the world urgently needs.

It is self-evident that such steps are short-sighted as they not only harm specific industries but also sabotage the broader pursuit of sustainable development and climate goals.

At a critical time when the world faces a choice between division and cooperation, the G20 can lead by example, proving that global cooperation is not a zero-sum game but a shared effort to build a fairer and more prosperous future for all.

Austria secure for winter despite Gazprom gas cutoff

Gazprom cuts gas supplies to Austria after OMV stops payments "Once again Putin is using ener-

VIENNA, Nov 17, (AP): Russia's state-owned natural gas company Gazprom stopped supplies to Austria early Saturday, according to the Vienna-based utility OMV, after OMV said it would stop payments for the gas following an arbitration award.

The official cutoff of supplies before dawn Saturday came after Austrian Chancellor Karl Nehammer on Friday held a hastily called news conference to emphasize his country has a secure supply of alternative fuel for this winter.

OMV said it would stop paying for Gazprom gas to its Austrian arm to offset a 230 million-euro (\$242 million) arbitration award it won from the International Chamber of Commerce over an earlier cutoff of gas to its German subsidiary.

The Austrian utility said in an email that no gas delivery was made from 6 a.m. on Saturday.

OMV said Wednesday it has sufficient stocks to provide gas to its customers in case of a potential

disruption by Gazprom, and said storage in Austria was more than

gy as a weapon," EU Commission President Ursula von der Leyen wrote in a post on X, formerly known as Twitter. "He is trying to blackmail Austria & Europe by cutting gas supplies. We are prepared for this and ready for the winter." Russia cut off most natural gas

supplies to Europe in 2022, citing disputes over payment in rubles, a move European leaders described as energy blackmail over their support for Ukraine against Russia's invasion.

European governments had to scramble to line up alternative supplies at higher prices, much of it liquefied natural gas brought by

ship from the U.S. and Qatar. Austria gets the bulk of its natural gas from Russia, as much as 98% in December last year, according to Energy Minister Lenore Gewessler.

Imaging results revealed instances of fatty liver, gallbladder stones, hydronephrosis, uterine fibroids, and bladder stones, while breast cancer screenings identified 5 women for further evaluation.

'The Exorcist' and 'Heretic'

Why holy horror can be a 'hit' with moviegoers

LOS ANGELES, Nov 17, (AP): In the new horror movie, "Heretic," Hugh Grant plays a diabolical religious skeptic who traps two scared missionaries in his house and tries to violently shake their faith.

What starts more as a religious studies lecture slowly morphs into a gory escape room for the two door-knocking members of The Church of Jesus Christ of Latterday Saints, underscoring just how well-suited religion can be for terrifying and entertaining thrill-seeking moviegoers.

"I think it is a fascinating religion-related horror as it raises questions about the institution of religion, the patriarchy of religion," said Stacey Abbott, a film professor at Northumbria University in Newcastle, England, whose research interests

include horvamror, pires and zombies. "But it also questions the nature of faith and confronts the audience with a



debate about choice, faith and free will."

Horror has had a decades-long attraction to religion, Christianity especially in the US, with the 1970s "The Exorcist" and "The Omen" being prime examples. Beyond the jump scares, the supernatural elements of horror and its sublime nature pair easily with belief and spirituality - and religion's exploration of big existential questions, Abbott said. Horror is subversive. Real-life taboo topics and cultural anxieties are fair game.

"It is a rich canvas for social critique and it can also be a space to reassert traditional values," Abbott said in an email.

Religions and horror tackle similar questions about what it means to be human - how people relate to one another and the world, said Brandon Grafius, a Biblical studies professor at Ecumenical Theological Seminary in Detroit and an expert on Christianity and horror.

Religion

"So much of religion is about how we grapple with the reality of death. ... Helping us make meaning even in the face of that reality,' said Grafius. "Horror really serves that same process, as a way to reflect on death."

Not only does Christianity translate well for US audiences, it has a lot of raw material for moviemakers to work with, he said.

"Christianity emerged as a strongly dualistic religion, where forces are either good or evil," Grafius said. "Even though the US is moving away from being a nation dominated by Christianity, we still have that dualism deep in our bones.'

Among the more recent religionthemed horror films, "The Conjuring" franchise, including "The movies, show paranormal investigators battling demons, Abbott said, while "The First Omen" and "Immaculate" offer critiques of patriarchal attempts to control

women's bodies. "These films seem to be a direct response to many of the debates that are happening in the U.S. these days," Abbott wrote in her email. "These different approaches to religion in horror illustrate the way in which the genre is engaging with a very live debate around religion or more specifically how religion is being used to assert control (which is what 'Heretic' is all about).'

Grant, who plays Mr. Reed in the new movie, told The Associated Press that he shared some of his "Heretic" character's skepticism, although not necessarily from a religious perspective:

'There is a part of me - probably a not very attractive part of me - that likes to smash people's idols. Anyone I feel is being a bit too smug or too pretentious, I don't like to see that. I like to just take them apart a little bit."

Horror can be challenging. It acts as a dark mirror that can reveal things people don't want to admit and fears they don't want to face, said the Rev. Ryan Duns, a Jesuit priest and theology chair at Marquette University in Milwaukee.

If done well, both religion and horror are unsettling, he said.

Violence

"Religion, when it unsettles, asks us am I living up to the person I have been called to be or am I complicit in systems of violence, oppression, injustice, going with the status quo," said Duns, who wrote the "Theology of Horror" and teaches a course on it as well. "In the horror movie, the monster threatens normality - threatens to destroy our status quo."

But they deviate from there. In horror, there is no way out, Duns said. He pointed out that defeating a movie's monster doesn't prevent sequels, hence "Jaws 2," "Terrifier 3," "Return of the Killer Tomatoes" and more.

In Christianity, it is Jesus and the Gospels threatening the status quo, but they offer hope and a way out,

Ti West mixes religion into the narrative of his new movie, "MaXXXine," a horror film about an adult film star trying to break into mainstream movies. West, who also wrote and directed "The Sacrament," a horror movie inspired by the Jonestown Massacre in 1978, said he doesn't actively set out to tell stories with prominent religion narratives, but religion can

be ripe for mining. "It kind of depends on the story," West said, "Anything with morality wrapped up into it, they kind of go hand in hand at times. And it's like religion is such a major part of every culture everywhere that ... I feel like sometimes it's such a major part of life that gets put aside in

Beyond poor storytelling, the mixing of horror and religion can go wrong if the movie is meant to offend the believers of a particular faith, said Lisa Morton, an awardwinning horror author whose written books on Halloween and para-

normal history. But it can really go right. Morton's all-time favorite movie is "The Exorcist," a holy horror icon and a peak example of the genre.

"The Omen" followed it. "All of the contemporary bloodlines kind of trace back through those two," said Morton. "It's interesting how they keep getting rebooted over and over.

Abbott agrees religion should be portrayed respectfully, just as she expects accuracy and respect for science in movies, though not every detail needs to be perfect.

Indian director Kapadia sees another way

All We Imagine'

NEW YORK, Nov 17, (AP): Fiction moves stealthily through Payal Kapadia's films.

The Indian filmmaker's first movie, "Night of Knowing Nothing," is a documentary about the student strike at the Film and Television Institute of India, Kapadia's alma mater, following the appointment by Prime Minister Narendra Modi of a right-wing chairman. The film, though, is threaded through with fictional letters between two students who have split because they belong to separate castes. Kapadia's first fully narrative film,

"All We Imagine as Light," begins more like a documentary, surveying Mumbai, particularly at night, before gently gravitating toward three women, all of them hospital workers, who are juggling their workaday realities, and those of India's stratified society, with their own aspirations. "Real life is more interesting than

cinema can be. We just have to pick its fruits," Kapadia says, smiling. "There's a quote from Rilke that I really love: 'If your real life is poor, it means you are not poet enough to draw from its riches.

"All_We Imagine as Light," which opens Friday in theaters and expands in the coming weeks, is about as rich a movie experience as you'll find this year. The film, which won the Grand Prix (second prize) at the Cannes Film Festival, is an intoxicatingly atmospheric portrait of life in Mumbai - of its dreams, its illusions and its impossibilities.

As "All We Imagine as Light" moves along, it slowly accumulates the magic of fable. Prabha (Kani Kusruti) hasn't heard from her husband, who's working in Germany, in years.

Anu (Divya Prabha) is in love with a Muslim man, a relationship they have to hide and that, probably, is doomed. Their slightly older, recently widowed colleague, Parvaty (Chhaya Kadam), is being evicted after many years in her apartment.

Constrictions

But when they escape the city - Parvaty is forced to move back to her village - the three women shed the various constrictions that grip them. They begin to imagine possibilities and see a light hidden to them by the patriarchal inequalities of Mumbai. "All We Imagine as Light," begun in documentary, turns increasingly fictional, and yet truer.

"I wanted to get closer and closer to a dreamlike state toward the end of the film and then snap back to reality,'

Kapadia says. "I wanted the first part of the film to be very kind of nonfiction, with a documentary beginning. And the second half to feel as if time slows down. The landscape changes and the feeling of light changes.'

The luminous phases of "All We Imagine as Light" has made it one of the most acclaimed films of the year - and yet, curiously, not India's submission for best international film at the Academy Awards. In announcing its choice, Kiran Rao's "Laapataa Ladies," Ravi Kottarakara, president of the Film Federation of India, explained that the selection committee felt "that they were watching a European film taking place in India, not an Indian film taking place in India."

"What is Indian? It's a very big continent that we have. There's a lot of Indias," Kapadia said in a recent interview. "I'm really happy with the film they chose. It's a really nice film. I liked it a lot. But I feel like these kind of statements, I don't know what purpose they serve. The committee that made the selection was 13 men. Is that very Indian? Then I don't mind so much.'

Kapadia, 38, met a reporter at the Criterion Collection offices in New York while "All We Imagine as Light" was playing at the New York Film Festival. Her bag was stuffed with DVDs from a visit to the Criterion closet, including an Agnes Varda box set. Kapadia will chat naturally about arthouse inspirations or social ills but she's an ebullient, easy-going presence. That her film has inspired so much emotion (the festival press screening was the rare one where attendees burst into spontaneous applause at the end) is, for her, the thing that matters most.

"What else would you want as a filmmaker, that people watch it and like it and feel something when they watch it?" Kapadia says. "As somebody who loves to go to the cinema and cry - it's for me the greatest catharsis I can have - I just feel I want to make films where people also cry in the cinema."

"I cry a lot. I'm very easy," she adds. "I'm a bit of a romantic.

Not so unlike her characters, Kapadia is attempting to find another way as a filmmaker, operating outside the studio system of Bollywood. In Cannes, where "All We Imagine as Light" was the first Indian feature to play in competition in 30 years, she argued that Indian cinema is broader than the bigger budget productions churned out by its state centers of industry.

Al pinpoints key resistance genes in bacteria

Machine learning fights antibiotic resistance at its core

ntibiotic resistance is a growing public health problem around the world. AWhen bacteria like E. coli no longer respond to antibiotics, infections become harder to treat.

To develop new antibiotics, researchers typically identify the genes that make bacteria resistant. Through laboratory experiments, they observe how bacteria respond to different antibiotics and look for mutations in the genetic makeup of resistant strains that allow them to survive.

While effective, this method can be time-consuming and may not always

capture the full picture of how bacteria become resistant. For example, changes in how genes work that don't involve mutations can still influence resistance. Bacteria can also exchange resistance genes between each other, which may not be detected if only focusing on mutations within a single strain.

My colleagues and I developed a new approach to identify E. coli resistance

genes by computer modeling, allowing us to design new compounds that can block these genes and make existing treatments more effective.

To predict which genes contribute to resistance, we analyzed the genomes of various E. coli strains to identify genetic patterns and markers associated with resistance. We then used machine learning algorithms trained on existing data to highlight novel genes or mutations shared across resistant strains that might contribute to resistance.

After identifying resistance genes, we designed inhibitors that specifically target and block the proteins these genes produce. By analyzing the structure of the proteins these genes code for, we were able to optimize our inhibitors to strongly bind to these specific proteins.

To reduce the likelihood that bacteria would evolve resistance to these inhibitors, we targeted regions of their genome that code for proteins critical to their survival. By interfering with how bacteria carry out important functions, it makes it more difficult for them to develop mechanisms to compensate. We also prioritized compounds that work differently from existing antibiotics to minimize cross-resistance.

Finally, we tested how effectively our inhibitors could overcome antibiotic resistance in E. coli. We used computer simulations to assess how strongly a number of inhibitors bind to target proteins over time. One inhibitor called hesperidin was able to strongly bind to the three genes in E. coli involved in resistance that we identified,

suggesting it may be able to help combat antibiotic-resistant strains. The World Health Organization ranks antimicrobial resistance as one of the top 10 threats to global health. In 2019, bacterial antibiotic resistance killed an

estimated 4.95 million people worldwide. By targeting the specific genes responsible for resistance to existing drugs, our approach could lead to treatments for challenging bacterial infections that are not only more effective but also less likely to contribute to further resistance. It can also help researchers keep up with bacterial threats as they evolve.

Our predictive approach could be adapted to other bacterial strains, allowing for more personalized treatment strategies. In the future, doctors could potentially tailor antibiotic treatments based on the specific genetic makeup of the bacteria causing the infection, potentially leading to better outcomes.

As antibiotic resistance continues to rise globally, our findings may provide a crucial tool in the fight against this threat. Further development is needed before our methods can be used in the clinic. But by staying ahead of bacterial evolution, targeted inhibitors could help preserve the efficacy of existing antibiotics and reduce the spread of resistant strains. (AP)

Safer and simpler online logins

Replace passwords with passkeys for easier login experience: expert

LONDON, Nov 17, (AP): If you're tired of memorizing passwords, then give passkeys a try

You might have noticed that many online services are now offering the option of using passkeys, a digital authentication method touted as an easier and more secure way to log in. The passkey push started gaining major momentum after Google started accepting them about 18 months ago.

Passkeys are seen as eventual replacements for passwords, but if you're still not sure what they're all about, read on:

Forget about memorizing an optimized 14 character password consisting of letters, numbers and symbols. Passkeys do away with that because you never need to see them. Instead you are using existing biometrics like your face or fingerprints, digital patterns or PINs to access your accounts.

Passkeys are made up of two parts of a code that only makes sense when they're combined, kind of like a digital key and padlock. You keep half of the encrypted code, typically stored either in the cloud with a compatible password manager or on a physical security dongle. The other half is stored on the participating apps, services or accounts you want to access.

When you want to log in to your Gmail account, for example, both parts of the code will then communicate directly with each other and

A passkey won't work with any website except the one it has been created for, eliminating the security risks associated with traditional passwords.

That means bad actors carrying out phishing scams won't be able to trick you into entering your details into a copycat login page for your bank. And because passkeys use cryptographic security, they also can't brute force their way into your account by trying passwords exposed in previous data breaches or guessing them.

Some 20% of the world's top 100 websites now accept passkeys, said Andrew Shikiar, CEO of the FIDO Alliance, an industry group that developed the core authentication technology behind passkeys.

Passkeys first came to the public's attention when Apple added the technology to iOS in 2022. They got more traction after Google started using them in 2023. Now, many other companies including PayPal, Amazon, Microsoft and eBay work with passkeys. There's a list on the FIDO Alliance website.

Still, some popular sites like Facebook and Netflix haven't started using them yet.

Passkey technology is still in the "early adoption" phase but "it's just a matter of time for more and more sites to start offering this," Shikiar

I tried setting up passkeys for some of the major online services I use. It was fairly easy for some but confusing for others. Shikiar said his group is constantly working on ways to improve the user experi-

Passkeys

Google users can go to myaccount.google.com and under "How to sign in to Google", click Passkeys and security keys. Upon reaching the setup screen, I received a prompt to create a passkey while simultaneously my password manager's browser plug-in popped up offering to save it. I clicked to confirm and the setup work was all done automatically. So far, pretty easy

Then, I tried adding more Google passkeys to my Windows-based work laptop and a Yubico physical security key. This time, when I got to the Google setup screen, it asked for my existing passkey to confirm my identity. But then it somehow failed to authenticate through my

password manager. I tried again using other verification methods, including my Google authenticator app that I already had on my iPhone, and it eventually suc-

Adding multiple passkeys to my Microsoft account - one on my password manager, another on my Yubico key - involved some head scratching over a few of the prompts, but I eventually figured it

Setting up passkeys on LinkedIn and Amazon was much easier. And when I attempted to add a passkey to my WhatsApp account, I discovered I had, apparently, already created one months earlier when I acti-

vated the app lock feature requiring

a fingerprint scan.

Once set up, it was a breeze to sign in to some of my accounts with just a click or two. But there was some friction with my Pay-Pal account because its passkeys don't work on some browsers, like

When I tried to log in with my Amazon passkey, it asked for a one-time verification code from my authenticator app, which confused me because I thought passkeys were supposed to eliminate the need for multi-factor authentication.

Shikiar said it depends on the site, but, in theory, the passkey already has enough protection built in.

"When the primary factor's unphishable, other factors aren't necessary," he said.

If you've lost the device containing your passkey, that doesn't necessarily mean it's gone. That's because the typical method to store passkeys on phones is a cloud-based password manager from Apple, Google, or third-party providers. So just log back into the password manager from another phone or computer.

Passkeys stored on security dongles, on the other hand, aren't synced to the cloud so there's no way to recover them if they're lost. It'd be a good idea to get a second hardware key and keep it as a back-

And don't forget you can always mix both cloud and hardware methods to keep multiple passkeys for extra redundancy.

Based on my experience, setting up a passkey can be easy, or tedious and bewildering, depending on the service and what other security technology you want to layer in.

So I wouldn't recommend doing all your accounts right away.

Instead, choose a few of your most important and frequently used services or accounts and focus on a proper setup for those.

In theory, you could delete your old passwords. Some services like Microsoft already offer this option. Shikiar says it should be a "personal preference," because "some people may feel extremely nervous" about going passwordless.

It's fine to keep your password but make sure there's also multifactor authentication set up for it.

NEW YORK, Nov 17, (AP): Health

officials said Saturday they have confirmed the first US case of a new form of mpox that was first seen in eastern

The person had traveled to eastern Africa and was treated in Northern California upon return, according to the California Department of Public Health. Symptoms are improving and the risk to the public is low.

The individual was isolating at home and health workers are reaching out to close contacts as a precaution, the state health department said.

Mpox is a rare disease caused by infection with a virus that's in the same family as the one that causes smallpox. It is endemic in parts of Africa, where people have been infected through bites from rodents or small animals. Milder symptoms can include fever, chills and body aches. In more serious cases, people can develop lesions on the face, hands, chest and genitals.


Contact

Earlier this year, scientists reported the emergence of a new form of mpox in Africa that was spread through close contact including through sex. It was widely transmitted in eastern and central Africa. But in cases that were identified in travelers outside of the continent, spread has been very limited, according to the US Centers for Disease Control and Prevention. More than 3,100 confirmed cases

have been reported just since late September, according to the World Health Organization. The vast majority of them have been in three African countries - Burundi, Uganda, and the Democratic Republic of the Congo. Since then, cases of travelers with the

new mpox form have been reported in Germany, India, Kenya, Sweden, Thailand, Zimbabwe, and the United King-

Angola reported the first Mpox case

nationwide in the capital city of Luanda, the Ministry of Health announced Saturday evening.

According to the ministry's statement, the patient, a 28-year-old woman "of Congolese nationality," is in isolation with her close contacts under the health authorities' vigilance.

The ministry said it is implementing measures to disinfect affected areas, identify and trace contacts, and conduct a thorough epidemiological investigation.

The Angolan authorities urge the public to reinforce hygiene practices and seek medical attention if they experience symptoms such as fever, headache, muscle pain, joint pain, lymphadenopathy, or widespread skin rashes or mucosal lesions.

Authorities have also reaffirmed their commitment to keeping the public informed about the epidemiological situation and have called for calm and composure within the community.

Mpox, previously known as monkeypox, was first identified in laboratory monkeys in 1958. It is an infectious disease primarily spread through body fluids, respiratory droplets, and contaminated materials.

Kenya Medical Research Institute (KEMRI), the country's premier research institution, said Wednesday that it has signed a partnership deal with Tonix Pharmaceuticals, a U.S. biopharmaceutical company, to design and conduct a clinical trial on a vaccine designed to prevent mpox.

KEMRI said in a statement issued in Nairobi, the capital of Kenya, that the Phase I clinical trial of TNX-801, an investigational vaccine designed to prevent mpox will take place in Kenya, focusing on assessing the vaccine's safety, tolerability, and immunogenicity.

"The planned clinical trial of TNX-801 reflects our ongoing commitment to advancing scientific research that not only benefits Kenya but also contributes to global efforts to prevent and manage emerging infectious diseases, said KEMRI Director-General Elijah Songok.

JEDDAH, Nov 17, (KUNA): The fourth high-level global ministerial conference on antimicrobial resistance (AMR), Saturday, urged member States to commit to its pledge and work on achieving goals set in the Political Declaration of the UN General Assembly on AMR by 2030.

This came in the conclusion of the conference, which launched in Jeddah during 14 to 16 of November, where the Kuwaiti Health Minister Dr. Ah-

mad Al-Awadhi participated.
Saudi Health Minister Fahad Al-

Jalajel explained that the commitments included in the Jeddah Declaration represent the cornerstone of a program that reflects their decisions in the UN, that enable member states and international bodies to take effective and serious steps to fight antimicrobial resistance.

Jeddah Declaration adopted what was included in the International Declaration on AMR issued at the 79th UN General Assembly High-Level Meeting held last September, aiming to interpret international will into practical implementable steps.

The commitments of the Jeddah Declaration highlight the importance of international cooperation and the role of the Quadripartite Joint Secretariat on AMR (FAO, UNEP, WHO, and WOAH) in providing the necessary support to governments.

The declaration also included the establishment of a One Health Learning Center for AMR and a Regional Center for Access to Antibiotics and Logistics in Saudi Arabia, which aim to enhance global cooperation and improve access to essential antibiotics and diagnostics.



Klubnik's late TD run helps Clemson top Pitt 24-20

PITTSBURGH, Nov 17, (AP): Cade Klubnik wanted to get out of bounds. Needed to get out of bounds.

The clock was running. Clemson was trailing Pittsburgh and all of the Tigers' timeouts were gone. So the junior quarterback broke into the secondary on a designed run and then veered right for the safety of the sideline.

Klubnik never got there. He never had to. A well-timed block from wide receiver T.J. Moore gave Klubnik a lane that offered nothing but green grass and victory. Klubnik's instincts led him to cut up the field for a go-ahead 50-yard touchdown run with 1:16 remaining that lifted the 17th-ranked Tigers past the Panthers 24-20 on Saturday.

Klubnik's dash kept Clemson's outside hopes of reaching the ACC title game alive. The Tigers (8-2, 7-1 ACC) need No. 12 Miami to lose one of its final two games or No. 14 SMU to drop its last two contests to reach the championship game in Charlotte on Dec. 7.

No. 1 Oregon 16, Wisconsin 13

In Madison, Wis., Atticus Sappington broke a tie with a 24-yard field goal with 2:36 remaining and No. 1 Oregon rallied in the fourth quarter to beat Wisconsin.

Jordan James rushed for 115 yards and a tying touchdown on 22 carries to help Oregon (11-0, 8-0 Big Ten) win its first 11 games for the second time in school history. The Ducks also won their first 11 games in 2010 and went on to reach the BCS championship game before losing to Cam Newton-

Tawee Walker rushed for 97 yards on 20 carries for Wisconsin (5-5, 3-4) in its third straight loss. The Badgers fell to 2-15 in their last 17 games against Top 25 teams, going 0-6 mark in Luke Fickell's two-year coaching tenure.

Kolbe tries help Boks inflict another rugby win over struggling England

Hosts suffer 3rd straight loss

LONDON, Nov 17, (AP): South Africa winger Cheslin Kolbe hurt England once again by scoring a try in each half to propel the Springboks to a 29-20 win at Twickenham on Saturday, extending the English run of defeats to five. It was England's third straight

loss to a southern hemisphere power in this autumn series, after 24-22 to New Zealand and 42-37 to Australia, and some familiar faces administered the late crucial blows in an engrossing match that was in the balance after an hour.

Kolbe, one of the try-scorers in the Boks' World Cup final win over England in 2019, expertly finished off a crossfield kick for his first try in the 22nd minute and sprinted over for the clinching score in the 63rd following a piercing break by center Damien de Allende.

South Africa pushed two scores ahead thanks to a conversion by replacement flyhalf Handre Pollard, whose last-gasp penalty sealed the Boks' win over England in the World Cup semifinals last year, and the English couldn't respond despite territory and playing against 14 men for the final 10 minutes.

Since repeating as world champions a year ago, the Springboks have won 10 of 12 tests and lost the other two by only a point each. England, meanwhile, has lost six of its last seven tests and has a concerning penchant for finishing tight games weakly.

"What we're seeing is it's such a game of fine margins," England captain Jamie George said. "Large parts of all the last five games, we've looked good at times and the final piece wasn't there.' It is leaving England coach Steve

Kolbe took De Allende's pass and sprinted down the wing to score the try that broke English hearts, and Pollard naturally slotted the extras from the touchline.

Replacement Gerhard prop Steenekamp's 69th-minute sin-binning for repeated team infringements might have cost South Africa, but its defense stayed strong and England made errors and bad decisions.

"We didn't quite get to play the way we wanted to play," Springboks cap-tain Siya Kolisi said, "but when we needed something, we always found a way to get through. That's the mindset

France triumph over All Blacks for a record-tying third straight time

'We are extremely disappointed'

PARIS, Nov 17, (AP): France shook off a slow start to beat New Zealand 30-29 for a record-tying third straight time in a bruising autumn rugby test at Stade de France on Saturday.

The French matched their best winning streak against the All Blacks from 1994-95 in a breathless game that lived up to the hype. The 27 turnovers were testament to ferocious defense on both sides.

"This win will do us a lot of good, that's for sure. It's a prestigious win, France coach Fabien Galthié said. "The good thing is that the players showed a great spirit, even when they were struggling.

New Zealand shot out to 14-3 and 17-10 by halftime. But France flipped the momentum in the new half with converted tries by flanker Paul Boudehent and wing Louis Bielle-Biarrey, which was the turning point. They sent France ahead 24-17.

From there, France's defense tightened up and New Zealand ball-carriers weren't quite making the meters they were chewing up in the first half. France missed 34 tackles but ended up making 211, 100 more than New

France's Thomas Ramos and New Zealand replacement Damian McKenzie traded penalties to the end with the All Blacks always chasing, and within one point with five minutes to go. But they couldn't get out of their half.

"It gives you a lot of confidence to beat a great side like this, especially considering the form they were in and they players they have," France captain Antoine Dupont said. "There were a lot of times when we were struggling in defense. But we didn't panic (when we were behind) because we knew we could turn things around."

The commitment was evident from

Finau's replacement, Peter Lakai, scored the opening try after Ardie Savea bowled over three defenders. The New Zealand scrum was the platform for its second try, when scrumhalf Cam Roigard stopped No. 8 Grégory Alldritt, stole his intended pass to Dupont and scooted in.

Dupont made little impact until the 33rd when France phases narrowed New Zealand and he picked out Ramos to send fullback Romain Buros over for a try on debut.

Boudehent's brace of second-half tries in the 52-12 win against Japan last Saturday earned him a start and his try from a lineout maul in the 44th tied the score.

New Zealand swung back onto attack but a dropped pass on halfway was collected by Ramos who kicked upfield. Bielle-Biarrey then gassed two All Blacks to the ball and scored the decisive try.

France never trailed again. "We are extremely disappointed," Savea said. "We put ourselves right in there to win the game but we made

silly mistakes and turned the ball over

Jones posed and played to the crowd on top of the octagon in front of Trump, Elon Musk, picked by Trump to lead a new Department of Government Efficiency, and Robert Kennedy Jr., Trump's choice to lead the Department of Health and Human Services in his incoming administration. Trump walked out to a rousing ova-

tion in front of 20,200 fans just before the start of the pay-per-view card and seemed to bask in thrill of the fighters that throughout the night gave him props - including Jones. "I want to give a big, big thank you

to President Donald Trump being here tonight," Jones said to a roaring ovation that bled into a "USA! USA!" chant.

"I'm proud to be a great American champion," Jones said.

Widely considered the best fighter in the world, Jones (28-1-0; 1 NC) was the aggressor from the start and landed a series of shots to Miocic's head in the first round. Jones showed he he plenty of fight left in the tank.

British heavyweight Tom Aspinall looms as the next challenger for Jones. Aspinall won a fight for the interim heavyweight title last November in the Garden. UFC CEO Dana White had promised Aspinall, who chatted with Arizona Cardinals QB Kyler Murray, would challenge the winner of the main event in a unification bout.

"As far as my future in the octagon, I decided that maybe I will not retire," Jones said. "I know that we have op-

Miocic (20-5) failed in his bid to win the heavyweight crown for a third time and immediately announced his retire-

"I'm done," Miocic said. "I'm hanging 'em up."

His last fight was in front of the next

president.

White captioned a photo he posted on social media "the boys" that featured him with Trump, Kid Rock and Musk. Trump pumped a fist during an occasional outbreak of "USA! USA!" chants. He was flanked on his front-row seat by White on his right and Musk on his left and politely applauded the fight

UFC fans wore red Trump hats and some waved flags emblazoned with his image during breaks in the action.

In a lightweight bout that made every fan from Kid Rock to Jordan Knight to Anthony Kiedis go wild at the finish in the fifth round, Charles Oliveira beat Michael Chandler via unanimous decision. The fight was a rematch of their May 2021 fight when Charles Oliveira topped Chandler to win the lightweight title. Oliveira staked his claim to another title fight with the win

The fifth round was about as good as it gets inside the octagon highlighted by Chandler dropping Oliveira twice on his back. The 38-year-old Chandler stepped inside the cage for the first time in two years, in large part because he waited for a fight that never materialized with Conor McGregor. "We've been wondering where

you've been, Conor," Chandler bellowed in the cage. "Come back and beat me if you can."

McGregor has been sued by a woman who accused him of sexually assaulting her in a Dublin hotel in 2018.

Chandler shook Trump's hand after the fight on a card more charged with politics than punches.

Trump is tight with White, a relationship that dates to UFC's formative years before its rise into a billion-dollar promotion.

The Germans got off to a perfect start in their final home game of the year when Joshua Kimmich's cross allowed Jamal Musiala to head the opener into the right-hand corner.

But Germany wasn't done yet and made it seven in the 79th minute when Kleindienst latched on to Antonio Rudiger's long cross.

The thumping victory left Germany at the top of Group 3, League A, ahead of the Netherlands (8 points), Hungary (5 points) and Bosnia-Her-

Oly ski champ Noel wins season's first WC slalom

Hirscher fails to qualify

LEVI, Finland, Nov 17, (AP): Olympic champion Clement Noel dominated the first men's World Cup slalom of the season on Sunday for his first victory in 22 months. The Frenchman protected his opening-run lead to beat Henrik Kristof-

fersen of Norway by 0.80 seconds. Swiss allrounder Loic Meillard placed third, 0.95 behind.

Lucas Pinheiro Braathen came fourth, missing by one tenth what would have been the first ever World Cup podium result in Alpine skiing for Brazil.

Record eight-time overall champion Marcel Hirscher, a three-time winner in Levi, failed to qualify for the second run in his first slalom since coming out of retirement after five years.

Noel overcame what looked like a costly mistake in his opening run when he had to brake in the steep middle section of the Levi Black course, but he put in a nearly error-free second run. "It was a tough fight. Really, really happy about my second run," Noel said. "It

was quite some good skiing, I think. I knew that Henrik set the bar high. In the pitch he skied really, really well. So, I just tried to push really hard because I knew It was Noel's 11th career World Cup win and first since triumphing at a night race in

Austria in January 2023 - his only other victory since winning Olympic gold in Beijing. Kristoffersen posted the fastest time in a frenetic final run that saw him rise from 11th position. The two-time slalom world champion was aiming for his first World Cup win since January 2023, and called his runner-up finish "100 per cent a step in

Meillard, who missed the season-opening giant slalom three weeks ago after tweaking his back during warmups, was the runner-up to Swiss teammate Marco Odermatt in the overall standings last season.

Odermatt does not compete in slaloms Manuel Feller, the defending World Cup slalom champion, failed to score World

Cup points. The Austrian finished 1.18 seconds off the lead in the opening run before straddling a gate in the second.

Feller was fifth or better in each slalom race last season.

Pinheiro Braathen, returning this season and starting for Brazil after leaving the Norwegian federation a year ago, started 33rd but worked his way up to fourth, matching his achievement in the season-opening GS.

"It's such a relief that I get these results in slalom and GS, I'm so grateful," Pinheiro Braathen said. "It was really a tough race today, with this tricky ice, it was a brutal return to slalom.'

Gyokeres is the joint leading scorer of the Nations League with five along with Portugal's Cristiano Ronaldo and Slovenia's Benjamin Sesko. Gyokeres recently upstaged Erling Haaland by scoring a hat trick as Sporting beat Manchester City 4-1 in the Champions League.

The Netherlands joined Germany as the two teams from League A, Group 3 to advance to the quarterfinals in March. The Dutch easily won their game in Amsterdam, which

was briefly suspended in the first half for the medical evacuation of Hungary assistant coach Adam Szalai. The Hungarian Football Federation said the former player was in "stable" condition after being taken by ambulance to a local hospital.
