MEW needs to learn from neighboring countries

IN my recent article, I wrote "The carpenter's door is always broken". This saying perfectly applies to a number of sectors, most notably the Ministry of Electricity, Water, and Renewable

Despite Kuwait enjoying year-round sunshine, the country fails to harness solar energy for electricity generation and instead burns thousands of barrels of crude oil daily to produce electricity. Since the 1960s, Kuwait has been suffering from recurring power crises and blackouts every summer. Does this make any sense? Wouldn't it be more logical to find a sustainable solution rather than simply accept this ongoing dilemma?

Before each summer every year, discussions about solving this problem resurface. Yet, the scorching heat comes and goes with no real improvement, and thus the same old situation repeats

We keep hearing the same excuses such as interference from MPs, vested interests, influential figures, and the instability of the ministerial post, as if the minister, a holder of the political position, is the one personally "switching on the electricity", or the large work-force at the Ministry of Electricity, Water, and Renewable Energy plays no role, or they simply wait around for the minister's directives.

Years ago, the ministry's name was changed to include "Renewable Energy," yet no one has actually seen any sign of that energy, or renewal. What we have seen instead is the same ongo-

While it is true that political stability at the ministerial level matters, it is

not the root cause of the problems in

a service-oriented ministry with a clear

and specific mandate. Since 1991, 25 ministers have taken the helm of the ministry, with some serving for just a month or two.

In other countries, does work come to a halt every time leadership changes? Or is there a stable, well-established system in place?

Even during times of war, there are no power cuts because maintenance and operations continue around the clock. That's why electricity in these countries remains uninterrupted, even in the midst of crises.

Power outages are not a concern in countries like the UK, the United States, or even in smaller nations such as the Comoros and Bahrain.

On the other hand, some countries like Iraq and Syria experience power outages for obvious reasons, primarily security issues. In places like Lebanon and Somalia, the issue stems from corruption, political quotas, and senseless conflicts. So, what exactly is the reason behind Kuwait's persistent electricity problem?

Yes, it is a valid question every citizen has the right to ask. Why does Kuwait continue to face this crisis year after year? Is it because of influential figures or MPs?

Today, there is no National Assembly for the ministry to use as an excuse.



World mourns Pope Francis

VATICAN CITY, April 21, (AP): Pope Francis, history's first Latin American pontiff who charmed the world with his humble style and concern for the poor but alienated conservatives with critiques of capitalism and climate change,

died Monday. He was 88.
Bells tolled in churches from his native Argentina to the Philippines and across Rome as

news spread around the world.
"At 7:35 this morning, the Bishop of Rome, Francis, returned to the home of the Father. His entire life was dedicated to the service of the Lord and of his Church," Cardinal Kevin Farrell said from the chapel of the Domus Santa Marta, where Francis lived.

Francis, who suffered from chronic lung disease and had part of one lung removed as a young man, was admitted to Gemelli hospital on Feb. 14, 2025, for a respiratory crisis that developed into double pneumonia. He spent 38 days

there, the longest hospitaliza-tion of his 12-year papacy.

He made his last public ap-pearance on Easter Sunday - a day before his death - to bless thousands of people in St. Peter's Square, drawing wild cheers and applause. Beforehand, he met U.S. Vice President JD Vance.

Francis performed the bless-ing from the same loggia where

he was introduced on March 13, 2013, as the 266th pope. From his first greeting that night - a remarkably normal "Buonasera" ("Good evening") - to his embrace of refugees and the downtrodden, Francis sig-naled a very different tone for the papacy, stressing humility over hubris for a Catholic Church beset by scandal and accusations of indifference.

Bigger fines, swift arrest

Drug crimes face death

Kuwait eyes mandatory tests, massive fines and no second chances

KUWAIT CITY, April 21: The committee tasked to address procedural loopholes in the Anti-Narcotics Law has submitted its report; which includes a draft law containing amendments aimed at rectifying deficiencies, curbing the spread of drugs, and increasing penalties for related crimes.

Acting Prime Minister Sheikh Fahad Yousef Saud Al-Sabah formed the committee with Advisor Mohammad Rashid Al-Duaij as chairman.

Following are the important amendments in the draft law: Trafficking in narcotics and psychotropic substances is punishable by death penalty and a fine of up to KD2 million, increased from the previous maximum sentence of seven years imprisonment.

■ The death penalty applies to individuals who trade in drugs within a prison, as well as those who facilitate or contribute to the introduction of these substances into a prison.

Kuwait's 2025/2026 budget sees modest rise in non-oil revenues

KUWAIT CITY, April 21: The Ministry of Finance has estimated the non-oil revenues from 36 ministries and government agencies at KD242 million in the general budget of the State for fiscal 2025/2026 -- an increase of 1.86 percent compared to the 2024/2025 budget.

The newspaper obtained a copy of the budget report, stating that the estimated revenues in the current budget amounted to KD18.231 bil-

lion, including KD15.305 billion oil revenues (83.95 percent of the total revenues); while non-oil revenues amounted to KD2.926 billion or 16.05 percent.

The estimated non-oil revenues for the current budget year include taxes and fees amounting to KD631.26 million or 3.46 percent of the total, KD120 million for social security contributions or 0.66 percent, and other revenues amounting to KD2.068 billion or 11.34 percent.

GCC Capital Markets push for deeper integration

Taifuni stresses regulatory upgrades and digital connectivity at the 30th meeting

KUWAIT CITY, April 21: Chairman of the Board of Commissioners of Capital Market Authorities Emad Taifuni has affirmed that significant strides have been made in the realm of collaborative economic endeavors among the Gulf states since the establishment of the Gulf Cooperation Council (GCC) in the early 1980s.

In his speech while presiding over the 30th meeting of the Committee of Heads of Capital Market Authorities or their equivalent in the Gulf states hosted by Kuwait, Taifuni pointed out that the council has played a pivotal role in advancing the economies of the GCC states and enhancing their standing and competitiveentity capable of achieving sustainable development, ensuring economic and social stability, and addressing the escalating cross-border challenges and unrest prevalent in various locales.

He said the integration process within the securities and capital markets of the GCC countries has progressed substantially and yielded noteworthy accomplishments.

He elaborated that despite this progress, further concerted efforts are imperative to build upon these achievements and expedite integration among the GCC capital markets. "The objective is to attain the highest level of excellence in their regulatory and supervisory frameworks, culminating in the establishment of electronic connectivity between these markets in order to maximize the advantages of the prevailing digital revolution, especially since market integration is one of the pillars of the requisite comprehensive economic integration," he explained.

Japan Embassy launches 2026 MEXT scholarship drive for Kuwaitis

KUWAIT CITY, April 21, (KUNA): The Japanese embassy in Kuwait announced on Monday the launch of its government scholarship (MEXT 2026 for Research Students and Undergraduate Students), which allows Kuwaitis to

study at Japanese Universities. According to a press release by the embassy, the government of Japan was offering a scholarship for Kuwaiti students who wish to study or conduct research at Japanese Universities, registra-

tion starts from Thursday, May 1, 2025. On the qualifications and eligibilities, the embassy revealed that Kuwaiti applicants must be born on or after April 2, 1991 for research students, and April 2, 2001 for undergraduate students.

The embassy went on to say that, "Research student applicants must have completed 16 years of school education, and Undergraduate student applicants must have completed a 12-year school curriculum and have good academic standing."

Adding that, "Applicants must have a good command of English, and willing to learn Japanese language." The embassy revealed that all necessary information and application forms are available through the link: https://www.kw.emb-

japan.go.jp/itprtop_en/index.html It also noted that applications must be submitted to the Japanese Embassy by hand and after receiving the applications, the embassy would conduct the document screening, written exam in English and Japanese, and personal interview in

order to select the scholarship awardee. The embassy indicated that the deadline for submitting applications was Thursday, June 12, 2025 at 03:00 P.M., local-time Kuwait.

The Japanese Government Scholarship was established in 1954 in order to increase mutual understanding between the people of Japan and other countries as well as to make an international contribution to the intellectual field.

Lions of the Peninsula and Kuwaiti Penalties

Throughout history, punishments for violators, dissenters, and lawbreakers have taken many forms. With the advancement of civilization and legal systems, these penalties have largely been limited to three main types: fines, imprisonment, and the death penalty. The latter is still actively enforced by countries such as China, Iran, Saudi Arabia, Iraq, Egypt, many U.S. states, Yemen, and Kuwait.

Some countries, like India, Japan, Malaysia, Cuba, and Guyana, have retained the death penalty in law but rarely implement it. Globally, there is a growing movement toward either abolishing the death penalty or restricting its use to only the most heinous crimes or acts of high treason.

However, in Kuwait, there appears to be a unique and unofficial "fourth" form of punishment, one not seen anywhere else in the world, which is the suspension of the civil ID card. Whether done intentionally, by mistake, or due to any other reasons, the suspension of a civil ID effectively erases the individual from society. The affected person becomes physically, legally, and commercially invisible – cut off from their business dealings, financial access, and, in some cases, even their family life.

In Kuwait, perhaps unlike any other country in the world, there exists a unique fourth form of punishment: the suspension of the civil ID card. Whether done intentionally, accidentally, or due to any other reasons, this suspension renders the individual physically, legally, and commercially invisible. Those affected find themselves cut off from their businesses, finances, and in some cases, even their families.

The legal definition and interpretation of life imprisonment varies from one country to an-

other. In the United States, "life imprisonment" typically means the remainder of the prisoner's natural life. In some states it equates to 25 years. This 25-year model is also followed in countries like Kuwait, Egypt, and Canada. In Italy, life imprisonment is defined as 26 years, while in Turkey it is 24 years. In the UK, it ranges between 15 and 25 years, in Germany it is 15 years, and in Japan, it is the shortest, as it can be as short as ten years. Some countries leave the duration entirely to the discretion of the judge, and do not set a fixed term. Although Kuwaiti law

defines life imprisonment as 25 years, a recent remark by a preacher who had previously supported hardline approaches was both striking and troubling. Speaking to a group of recently pardoned prisoners, he said some had spent 26, 27, even 28 years behind

bars. This prompted me to investigate further, and to my surprise, I learned that some individuals have spent over 30 years in prison, simply because their case files were lost.

One of the notable achievements of this era has been the implementation of radical reforms, which even extended to the prison system. Pardon programs began to expand, and mercy was shown to many prisoners who had already served the majority of their sentences.

In December 2005, the Court of First Instance issued its verdict in the case of the "Peninsula Lions Cell," involving 37 defendants, including nine fugitives. The court sentenced

six individuals to death, one to life imprisonment, and the remaining defendants to varying

In June 2007, the Court of Cassation issued its final ruling in the case, commuting the death sentences of four defendants to life imprisonment and upholding the remaining sentences.

In January 2025, a decision was made to revoke the citizenship of five individuals convicted in connection with the cell. This was part of a measure targeting 38 individuals found guilty in terrorism-related cases, in accordance with a legal provision that allows for the revocation of citizenship from those proven to have engaged in actions contrary to national loyalty.

Personally, I believe, out of compassion, that it is important to expand pardon initiatives and release as many prisoners as possible, especially those who have already served nearly 20 years in prison, provided they have shown remorse for their crimes and proven their righteousness. This is especially relevant considering that their actions can be monitored and managed within specific boundaries. The recent decision to release the seven members of the Peninsula Lions cell may have stemmed from this very perspective.

Each prisoner imposes a huge cost on the public budget. Releasing those who no longer pose a threat, and requiring them to wear a security bracelet for a specific period, would not only save the government substantial financial resources but also reduce effort, and allow these individuals and their families to return to

DGCA approves, final licensing under review

Private jet firms await green light

KUWAIT CITY, April 21: The concerned officials at the Ministry of Commerce and Industry are currently studying two applications for the establishment of private jet companies, reports Al-Rai daily quoting reliable

sources. Sources revealed that one of the companies will be exclusive for 'high-class' clients -- luxury travel for VIPs; while the other will focus on private flight clients in the economy class, including wealthy individuals and business owners. Sources said both companies will provide their services to individuals and companies.

Sources stated that the two companies have obtained approval from the Directorate General of Civil Aviation (DGCA) to offer paid passenger transport services using private jets, apart from regular commercial flights. They explained that following this approval, the files of the two companies were referred to the ministry in order to review the final procedures for their establishment, such as the authorized capital and paid-up capital. They confirmed there is nothing preventing the establishment of the two companies, provided their founders complete the required procedures; indicating that the two licenses are independent from the investor submitting the applica-

Sources said one investor has made significant progress in fulfilling the regulatory requirements for a license, and that he has aircraft ready to take off as soon as he obtains the ministry's approval, which is expected to be issued soon. "Discussions are still open with the second investor, whose license is likely to be issued at a later date," sources clarified.

Sources pointed out that if the license

is granted to either of the two companies to operate private aircraft in the local market, it will be the first license granted for private air transport after a five-year hiatus. Sources believe this license will revitalize the private air-

craft business in the country Sources added if the ministry approves the license, both entities will be established as public shareholding companies. "This is likely to be done in accordance with the model for public subscription previously offered in the country; which stipulates offering 50 percent of the company to citizens and 20 percent to government investment entities, most likely Kuwait Investment Authority (KIA). Sources clarified this point is still subject to legal and procedural debate, and that one of the proposals is for the founder to commit to contributing 10 percent of the company's capital, with the possibility that the capital of the company will be offered for public subscription at a later stage

of operations. Sources said the business model of private aircraft companies is generally directed at the business and financial community; providing private aircraft that specify their destinations according to the customer's request, including landing at private airports.

Regarding the expected list of private jet charter prices the country, sources expect them to be competitive and they could vary greatly -- starting at around \$1,000 per hour up to \$25,000 or more; depending on the type of aircraft, services required, and the duration and route of the flight.

Sources said the establishment of new private jet companies in the country coincides with the current growing demand for private jet travel for busi-

ously increasing the dose of politi-

cal Islam.
"The religiosity and politicization of issues, events, files and conflicts is the specialty of the Muslim Brotherhood. They are cautiously selective and shrewd in seizing opportunities to mix re-

ligion with politics and exchange roles, strengthening the social and educational penetration of political Islam and their approach to life.

to the role of the Muslim Brother-hood in political life is not marginal, so we should ignore the margins. Its role sometimes arises at the will of a group of people and through proposals, through the window of the street's pulse, with the aim of achieving a goal and attacking conflicts, disputes, and events of all kinds and types.

"On the margins of questioning democracy, the issue of the Muslim Brotherhood should neither be neglected nor overlooked, and its role and significance should not be underestimated. It relies on the weakness of human memory and the reluctance of official stakeholders to confront and hold them politically and legally accountable, in order to spread its regional.

"Mubarak Al-Duwailah, a leader of the Muslim Brotherhood in Kuwait, wrote an article in a Kuwaiti newspaper more than two decades after the Iraqi invasion, about a message from the Deputy Supreme Guide of the Muslim Brotherhood International Organization, Mustafa Mashhour, to the Jeddah Popular Conference, which contradicts reality and the conference documents!

"Mr. Mubarak Al-Duwailah neither presented conclusive evidence of the Brotherhood's international message to the conference nor commented on what I previously published about this subject in the international electronic newspaper, 'Elaph', and on my X account; so that we all benefit from documentation, not fabrication.

not fabrication.
"The reference and leader of the Brotherhood in Kuwait, Mr. Mubarak Al-Duwailah, repeated this on Oct 24, 2023, after the 'Al-Aqsa Operation,' by broadcasting allegations about a meeting between HH the late Amir Sheikh Saad Al-Abdullah and a Hamas delegation in December 1990 in Jeddah; that is, during the Iraqi invasion!

"I investigated the alleged meeting of the Hamas delegation with Sheikh Saad Al-Abdullah, may Allah have mercy on him, from relevant and credible sources and figures in the Council of Ministers and the government during the Iraqi invasion. Everyone who witnessed the Kuwaiti political backstage denied the claim.

"Equally important is a leaked recording broadcasted by Al-Arabiya about another Brotherhood leader, Issam Al-Suwaidan, who talked about "training 70,000 youths in Sudan"; and about the Brotherhood's "freedom" to operate in Kuwait, passed without question or investigation!

"Question: Did Mr. Issam Al-Suwaidan's training in Sudan focused on Quran memorization and jurisprudential aspects, or on combat skills or civil disobedience? We do not know!

"Mr. Al-Suwaidan was a member of the Brotherhood delegation that visited Washington during the Iraqi invasion. Al-Suwaidan wanted to meet with representatives of the Ministry of Foreign Affairs to discuss the Iraqi invasion, but his wish was not fulfilled. He also sought funding with former Minister and Ambassador Sheikh Saud Al-Sabah (may Allah have mercy on him), and negotiated a deal to obtain "\$50 million, later reduced to \$5 million"!

"The former Minister and Ambassador, my dear brother Sheikh Saud AlSabah (may Allah have mercy on him), testified to these details and provided accurate information in several television interviews, statements and talks in Kuwait and abroad. However, the relevant official authorities failed to take action... to investigate and investigate!

"The Muslim Brotherhood has no other refuge but Kuwait. Will the government learn from the recent terrorist attack in Jordan and the group's direct connection to it?

"I leave the assessment of the importance of reading and investigating these facts and political and security developments to the Ministry of Interior to determine the feasibility of a political and security resolution to the Muslim Brotherhood's poisons in Kuwait and abroad"

"The head of state in any country views matters from a broader and more strategic perspective, much like someone standing atop a tall tower or mountain. True leadership lies in the art of finding solutions and reaching compromises.

"Relations between countries should not be governed by the "I win, you lose" mentality. Instead, the principle should be "I win, and you

gotiations require both sides to make concessions. The goal is to reach an outcome where neither party feels like a loser. As a result, the negotiation process often leads one

win too.

Al-Dawas one party to say, "I gave up on A, B, and C, but I gained C,

K, and Z."

"These concessions, though painful for all parties involved because they are based on the principle of "give and take," benefit the state. If Iran had adopted a more diplomatic approach, improved its relationships with its adversaries, and encouraged investments from Arab, American, European, and other nations, it could have prospered in various sectors, achieved significant economic growth, and improved the living standards of its people. Unfortu-

nately, this has not been the case.

"Recently, Hezbollah in Lebanon refused to negotiate regarding its disarmament, which continues to harm the country and its interests. One must ask: do its followers not realize that Lebanon's interests are in line with those of all Lebanese people, and that the Lebanese army should be the sole entity responsible for military affairs?

Similarly, the Houthis in Yemen, which we consider as a rebel group that emerged from the turmoil of 2011, took up arms against the legitimate government, caused huge damage to Yemen, and disrupted international shipping routes in the Red Sea, including those vital to Egypt. Would it not be in Yemen's best interest for the Houthis to consider negotiations, lay down their weapons, and work toward rebuilding the country?"

Safety concerns prompt legal action

PAAAFR cracks down on Illegal camel grazing along Kabd Road

KUWAIT CITY, April 21: The Public Authority for Agricultural Affairs and Fish Resources (PAAAFR) has announced that it has identified several camel herders violating the law by allowing their camel to graze in areas outside the designated zones along Kabd Road, from Al-Farda Roundabout to the Police Station Roundabout, as well as adjacent roads.

PAAAFR explained that such behavior threatens the safety of both citizens and road users, and necessary legal actions were taken against the violators. They were made to sign pledges not to repeat

the offense and to fully comply with the designated grazing areas, in accordance with Law No. 41/1988 on livestock grazing, and the decision of the Municipal Affairs Committee regarding the allocation of grazing areas.

The permitted grazing areas extend from Abdali in the north, along the western side of Abdali Road, merging into Al-Salmi Road, and continue south to the Wafra area and the southern international

The authority affirmed that prohibited areas, such as oil fields, pipeline routes, military bases, army installations, residential areas, and agricultural beautification projects, must be avoided.

Cassation Court upholds jail terms for ex-MPs in political controversies

Appeal fails in KD10.5K gift case

KUWAIT CITY, April 21: The Court of Cassation upheld the four-year prison sentence issued by the Court of Appeals against former MP Waleed Al-Tabtabaei in a case filed against him for challenging and interfering with the constitutional powers granted to His

Highness the Amir.

The Court of Cassation also sentenced former MP Hamad Al-Alayan to two-year imprisonment, after rejecting his appeal against the Court of Appeals' decision to refrain from pronouncing a penalty for his posts on the X platform that were deemed to challenge the powers of His Highness the

In another case, the Court of Cassation upheld the two-year prison sentence with hard labor issued against former MP Hussein Al-Qallaf on charges of offending the Amiri entity through a social media post in which he criti-

cized the Ministry of Interior's procedures on the organization of Husseiniyas and the practice of Shiite religious rituals.

The Court of Cassation also upheld the three-year prison sentence issued by the Court of Appeals against former MP Anwar Al-Fikr, after rejecting his appeal against the Court of Appeals' decision to refrain from pronouncing penalty in a case involving interference in the powers of His Highness the Amir, including his statements regarding the appointment of the Prime Minister

In the same context, the Court of Cassation upheld the Court of Appeal's ruling against former MP Abdullah Fahad, which suspended his six-month prison sentence for three years, with a bail of KD 3,000, on charges related to offending the judiciary

The Court of Cassation also upheld the Court of Appeal's ruling that sentenced former MP Musaed Al-Quraifa to four years in prison with hard labor on charges of offending the Amir and challenging the Amir's powers during his election campaign.

In another case, the Court of Cassation accepted the Public Prosecution's appeal against the acquittal of former MP Saadoun Hammad and others in a case related to vote-buying in

the 2023 National Assembly elections. The Court of Cassation overturned the acquittal, refrained from pronouncing a sentence, and required the defendants to sign a pledge of three years' good conduct.

Meanwhile, the Family Court of Appeals upheld the ruling of a lower court that dismissed the case filed by a citizen to compel a female compatriot to return KD10,500 in cash and inkind gifts he gave her during their engagement period. However, the female citizen claimed he did not propose to her.

Case files indicate the citizen demanded for the return of KD10,500 worth of gifts he gave to his female compatriot based on bank transfers and gift receipts. He stated his supposed fiancée is a divorcee, indicating he was surprised when she cut off all contacts with him.

Attorney Mohammed Al-Sayegh, who appeared in court on behalf of the female citizen, said his client denied being engaged to the plaintiff. He indicated they are just friends who exchanged gifts. He requested for dismissal of the case due to lack of factual and legal basis, as well as the absence of the element of debt.

Al-Kandari affirmed that inspection campaigns will continue and legal action will be taken against all violators.

News in Brief

411 residency violators arrested in crackdown

KUWAIT CITY, April 21: The General Department of Residence Affairs Investigations carried out intensive security campaigns in various governorates from April 13 to 17, which resulted in the arrest of 411 violators who have been referred to the relevant authorities for legal action, reports Al-

The Ministry of Interior affirmed its keenness to strictly enforce the law against all violators, stressing that responsibility lies with both the worker and the employer for maintaining public security and upholding the rule of law.

The ministry urged the public to cooperate with security personnel and report any violations, stressing that adherence to the law is a shared responsibility that plays a vital role in ensuring the safety and stability of society.

Temporary road closures: The General Traffic Department has announced the closure of the secondary exit on Abdulaziz bin Abdulrahman Al-Saud Road (Fahaheel Road) toward Sabahiya, as well as the entrance leading to the Fahaheel Club intersection on Road 212, from Sunday evening and to May 4, reports Al-Seyassah daily.

Egaila substation blast injures 2: An explosion in Egaila's main substation led to the injury of two engineers conducting periodic maintenance, and resulting in a power outage in all parts of the Egaila area, said the Ministry of Electricity, Water and Re-

newable Energy in a statement, Monday.

Ministry spokesperson eng. Fatima Johar Hayat said in a press release that the injured were immediately transferred to Al-Adan Hospital.

The statement added that Minister of Electricity, Water and Renewable Energy Dr. Sabeeh Al-Mukhaizeem and Undersecretary Dr. Adel Al-Zamel were present at the accident site to inspect and assess the damage.

Emergency teams of Kuwait Fire Force and the Ministry of Interior were immediately at the site as well and took all necessary measures to contain the situation and ensure safety of the workers.

Undersecretary Al-Zamel directed the formation of a specialized investigation committee to determine the causes of the accident, and take legal action against any proven faults in this matter. (KUNA)

CAPT approves KD25.75 mln tender for new SAB building

KUWAIT CITY, April 21: The Central Agency for Public Tenders (CAPT) has approved the request of the Ministry of Public Works to award the contract for the construction of the

State Audit Bureau (SAB) northern building at a cost of KD25.75 mln.

This decision was taken upon completion of procedural requirements and submission of an assessed budgetary allocation.

Reliable sources said this project is a vital construction endeavor to be

undertaken by the ministry for SAB -- one of the governmental entities whose infrastructure projects are executed by the Construction Projects Sector in the ministry.

Sources disclosed that the new building will incorporate a range of sophisticated technical and engineering specifications designed to effectively address the operational requirements of SAB.

Sources also confirmed the completion of the comprehensive study and design of the building that will be located in Shuwaikh Administrative Area on land measuring 10,000

Sources stated that the new building mirrors the existing structure; indicating it will include eight storeys, two basement levels, two storeys on top of the adjacent existing parking structure and a connecting bridge to the current building.

Sources added the ministry will complete all outstanding requirements stipulated by the agency, formulate an assessed budgetary allocation, finalize procedural steps to refer the tender to SAB for preliminary review and approval, and then start the implementation of the project.

Ministry finalizing new contracts

KUWAIT CITY, April 21: The Ministry of Education has started implementing the decisions of the Council of Ministers and the Civil **Service Commission (CSC)** on amending the status of female employees whose Kuwaiti citizenship was revoked in accordance with Article Eight of Nationality Law No. 15/1959 and its amendments.

In coordination with the relevant

sectors, the ministry is currently finalizing new employment contracts that guarantee the continuation of financial and other employment benefits for these women: similar to those enjoyed by their Kuwaiti colleagues like vacation days, allowances, bonuses and incentives.

This is in line with a governmental directive to make sure that the employment rights of these women are not neglected during the performance of their duties

Acting Assistant Undersecretary for Administrative Affairs and Administrative Development Mansour Al-Dhafiri issued a directive to all sectors in the ministry to follow up the amendment of the status of these employees, based on letters from the Secretariat General of the Council of Ministers and the CSC. He underscored the need to implement such decisions and circulate them to the concerned educational

authorities. The decision is in response to the letter of Secretary General of the Council of Ministers Saleh Al-Mulla to Minister of Education Dr. Jalal Al-Tabtabaei. The newspaper obtained a copy of the letter, which emphasized the necessity of adhering to Council of Ministers Resolution No. 67 issued in its Meeting No. 3/2025; indicating all government agencies must amend the status of these employees to ensure they continue to

receive financial and other employment benefits.

PAM opens Kuwaitization jobs in MoH

KUWAIT CITY, April 21: The Public Authority for Manpower (PAM) has announced job opportunities in the Ministry of Health's Kuwaitization program under the "Hospital Nutrition Contracts," aimed at supervising the ministry's cleaning staff,

reports Al-Rai daily.

It affirmed that applications for Kuwaiti nationals will be accepted from April 24 to May 8.

PAM stated that the positions are open to both men and women, provided they hold a high school diploma and are between the ages of 18 and 35.

The monthly salary is KD 400, in addition to the national labor subsidy. Work will be conducted in morning and evening shifts, six days a week, with one day off.

DGCA under fire over KD200m tender

KUWAIT CITY, April 21: The Directorate General for Civil Aviation's (DGCA) tender documents for the supply, installation and operation of a passenger registration and early information system for border security have raised serious concerns over a potential conflict of interest, reports Al-Jarida daily.

Sources told the daily that the documents included specifications and references that align closely with the systems and equipment of a company participating in the bid; suggesting the tender may have been tailored to favor that company.

Sources said the tender is intended to award a specialized firm a comprehensive 10-year contract to manage, operate and provide training for the passenger system, with an estimated project value ranging from KD150 million to KD200 million.

Sources revealed that the documents contain technical terminology and product descriptions uniquely associated with one of the bidders. "In a further indication of bias, the documents also featured direct links to the company's services to clarify certain requirements and definitions-raising red flags among other participants," sources said.

MEW needs

The government holds both legislative and executive powers. There is no one left for the government to clash with or blame. Tenders are fully under its control, and ministerial positions have been stabilized. So what excuses are left for the government to hide behind?

Have things become so entangled that no official is even considering a practical solution, let alone working to implement one?

Isn't there anyone willing to learn from other countries that have successfully entrusted production, maintenance, and bill collection to specialized companies?

Why don't we see power outages in Saudi Arabia, the UAE, or Qatar? Isn't it painfully obvious that the root of this issue is poor management?

In many countries, even those with limited resources, their governments have started generating electricity from solar energy and have facilitated the procedures for their citizens to obtain it. So why isn't solar energy widely available to everyone in Kuwait? Why can't owners of large and small homes and residential buildings use it for lighting, heating water, and running air conditioners for free, while conserving crude oil and gas for export instead?

The solution is simple. It requires nothing but strong will, sound decision-making, and a bit of common sense to tackle a chronic issue. I stress once again that the answer lies in studying the experiences of neighboring countries, as well as those in Europe and even Africa.

As the old saying goes, "Your knowledge is your capital, and your number one enemy is ignorance." There is no shame in learning from others' experiences.

- increased. ■ Police officers are authorized to make immediate arrests upon suspi-

- All judgments rendered in drugrelated cases are subject to immediate execution.
- Coercing another individual or providing another with narcotics

or psychotropic substances without their consent warrants a 15-year prison sentence, with the possibility of the death penalty if the victim is

Stricter Traffic

Furthermore, the new law also authorizes the enforcers to nab those driving in a reckless, negligent or dangerous manner; driving without or with an invalid license or driving a vehicle without registration plates.

It allows the arrest of those driving under the influence of intoxicating substances, those causing accidents resulting in injury or fatality, those participating in unauthorized vehicular races, individuals attempting to evade responsibility following an accident causing harm, and those who disregard a lawful order to stop.

Arrests may also take place for those exceeding speed limits by more than 50 kilometers per hour or driving recreational vehicles in un-

- authorized areas. The new law stipulates significant
- fine increases as follows:

 Running a red light: increased from KD50 to KD150
- Parking on spaces designated for persons with disabilities: increased from KD10 to KD150
- Using a mobile phone while driving: increased from KD5 to KD75 ■ Non-compliance with seat belt regulations: increased from KD10 to
- Reckless driving: increased from KD30 to KD150

Certain offenses are deemed nonreconcilable and will be referred to the appropriate judicial authority. These are categorized into three

- The first category includes those driving a vehicle under the influence of alcohol, drugs or psychotropic substances, with fines ranging from KD1,000 to KD 3,000 and imprisonment from one to two years.
- The second category addresses incidents involving driving under the influence and causing property damage, with fines between KD 2,000 and KD 3,000, and imprisonment from one to three years.
- The third category concerns driving under the influence resulting in personal injury or fatality, with fines ranging from KD 2,000 to KD 5,000, and imprisonment from two to five

The affirmed these augmented penalties aim to enhance road safety and safeguard all road users. Citizens and expatriates are strongly advised to exercise due diligence and adhere to all regulations to avert penalties and familiarize themselves with the details of these amendments.

An ongoing public awareness

campaign complements the implementation of this revised legislation to inform the public about the major amendments and reinforce traffic safety and security measures.

Meanwhile, the General Traffic Department (GTD) at the Interior Ministry continued its traffic campaigns in various governorates.

The campaigns carried out last week resulted in the issuance of 51,759 traffic violation citations, impoundment of six vehicles, arrest of 47 individuals, and referral of 58 juveniles to the Juvenile Prosecution for driving without a license.

The weekly statistics of GTD showed the impoundment of 56 wanted vehicles, and arrest of 66 individuals wanted by law for involvement in criminal and civil cases, and 37 individuals who violated the Residency Law.

The statistics also indicated that the department dealt with 1,204 traffic accidents, some of which led to 286 injuries.

Two African

The Ministry affirmed its continued pursuit of anyone attempting to undermine security and urged everyone to remain vigilant and not fall victim to fraudulent schemes aimed at achieving illegal gains.

World mourns

The Argentine-born Jorge Mario Bergoglio brought a breath of fresh air into a 2,000-year-old institution that had seen its influence wane during the troubled tenure of Pope Benedict XVI, whose surprise resignation led to Francis' election.

But Francis soon invited troubles of his own, and conservatives grew increasingly upset with his progressive bent and crackdown on traditionalists. His greatest test came in 2018 when he botched a notorious case of clergy sexual abuse in Chile, and the scandal that festered under his predecessors erupted anew.

And then Francis, the crowdloving, globe-trotting pope of the peripheries, navigated the unprec-edented reality of leading a universal religion through the coronavirus pandemic from a locked-down Vatican City.

"We have realized that we are on the same boat, all of us fragile and disoriented," Francis told an empty St. Peter's Square in March 2020. Calling for a rethink of the global economic framework, he said the pandemic showed the need for "all of us to row together, each of us in need of comforting the other.'

World leaders on Monday extolled Francis' commitment to the marginalized. French President Emmanuel Macron, whose country is largely Catholic, wrote on X: "From Buenos Aires to Rome, Pope Francis wanted the church to bring joy and hope to the poorest. ... May this hope forever outlast him."

Flags flew at half-staff in Italy, and crowds gathered in St. Peter's Square. When the great bells of St. Peter's Basilica began tolling, tourists stopped in their tracks to record the moment on their phones.

Johann Xavier, who traveled from Australia, hoped to see the pope during his visit. "But then we heard about it when we came in here. It pretty much devastated all of us,'

Francis' death sets off a weekslong process of allowing the faithful to pay their final respects, first for Vatican officials in the Santa Marta chapel and then in St. Peter's for the general public, followed by a funeral and a conclave to elect a new pope.

Stressing mercy, Francis changed the church's position on the death penalty, calling it inadmissible in all circumstances. He also declared the possession of nuclear weapons, not just their use, was "immoral.

In other firsts, he approved an agreement with China over bishop nominations that had vexed the Vatican for decades, met the Russian patriarch and charted new relations with the Muslim world by visiting the Arabian Peninsula and Iraq.

He reaffirmed the all-male, celibate priesthood and upheld the church's opposition to abortion, equating it to "hiring a hit man to solve a problem."

But he added women to important decision-making roles and allowed them to serve as lectors and acolytes in parishes. He let women vote alongside bishops in periodic Vatican meetings, following longstanding complaints that women do much of the church's work but are

barred from power. Sister Nathalie Becquart, whom Francis named to one of the highest Vatican jobs, said his legacy was a vision of a church where men and women existed in a relationship of reciprocity and respect.

"It was about shifting a pattern of domination - from human being to the creation, from men to women - to a pattern of cooperation," said Becquart, the first woman to hold a voting position in a Vatican synod.

Still, a note of criticism came Monday from the Women's Ordination Conference, which had been frustrated by Francis' unwillingness to push for the ordination

"His repeated 'closed door' policy on women's ordination was painfully incongruous with his otherwise pastoral nature, and for many, a betrayal of the synodal, listening church he championed. This made him a complicated, frustrating, and sometimes heart-breaking figure for many women," the statement said.

While Francis did not allow women to be ordained, the voting reform was part of a revolutionary change in emphasizing what the church should be: a refuge for everyone - "todos, todos, todos" ("everyone, everyone, everyone"). Migrants, the poor, prisoners and outcasts were invited to his table far more than presidents or powerful CEOs.



Election shrouded in secrecy

What are the church's rites after death of pope and election of a new one?

VATICAN CITY, April 21, (AP): The death of a pope starts a centuries-old ritual involving sacred oaths by the cardinals electing a successor, the piercing of ballots with a needle and thread after they're counted, and then burning them to produce either the white or black smoke to signal if there's a new leader for the world's 1.3

The election itself is shrouded in secrecy, with cardinals forbidden from communicating with the outside world what happened during the voting in the conclave behind the frescoed walls of the Sistine Chapel.

St. John Paul II rewrote the regulations on papal elections in a 1996 document that remains largely in force, though Pope Benedict XVI amended it twice before he resigned. Here is what happens when a pope dies, a period known as the "sede vacante," or the "vacant See.

If the pope has died, the camerlengo, or chamberlain, must certify the death and seal the papal apartment. He runs administrative and financial duties of the Holy See until a new pope takes over.

The largely ceremonial job of camerlengo is currently held by Cardinal Kevin Farrell, the Irish-born American head of the Vatican's laity office.

Nearly all prefects of Vatican offices lose their jobs when a pope dies, but a few stay on, including the foreign minister and the master of liturgical ceremonies, who plays a key role in assembling the conclave.

The dean of the College of Cardinals summons the cardinals for the funeral, presiding at the Mass before the conclave begins. That position is currently held by Cardinal Giovanni Battista Re, the retired head of the Vatican's office for bish-

In November 2024, Francis reformed the rites to be used for his funeral, simplifying them to emphasize his role as a mere bishop and allowing for burial outside the Vatican. Francis has chosen to be buried in St Mary Major Basilica, where his favorite icon of the Virgin Mary, the Salus Populi Romani, is located

The death of a pope begins a precise sequence of events that include the confirmation of death in the pontiff's home, the transfer of the coffin to St. Peter's Basilica for public viewing, a funeral Mass and burial. Interment must take place between the fourth and sixth day after his death.

After the funeral, there are nine days of official mourning, known as the "no-

During this period, the cardinals arrive in Rome. To give everyone time to assemble, the conclave must begin 15-20 days after the "sede vacante" is declared, although it can start sooner if the cardinals agree.

Only cardinals under age 80 are eligible, and current regulations limit the num-

ber of electors to 120. According to the most recently updated Vatican statistics, there were 135 cardinals under age 80 and eligible to vote, though that number may change before the conclave begins.

Those over 80 can't vote but can participate in pre-conclave meetings, known as general congregations, in which church problems are discussed. It was in these meetings in 2013 that then-Cardinal Jorge Mario Bergoglio spoke about the need for the church to go to the "existential peripheries" to find those who suffer - an off-the-cuff speech that helped his election.

Any baptized Roman Catholic male is eligible to be pope, but since 1378, only cardinals have been selected. Some current leading candidates:

■ Cardinal Pietro Parolin of Italy, 70, Francis' secretary of state and a veteran Vatican diplomat.

■ Cardinal Marc Ouellet of Canada, 80, head of the Vatican's bishops office from

■ Cardinal Christoph Schoenborn of Austria, 80, a student of Pope Benedict XVI, and thus ostensibly having appeal for conservatives.

■ Cardinal Luis Tagle of the Philippines, 67, brought by Francis to head the Vati-

can's massive missionary office. ■ Cardinal Matteo Zuppi of Italy, 69, a Francis protégé who headed the Italian

bishops conference. A first ballot is held in the Sistine Chapel on the afternoon after the initial Mass.

If no pope is elected, over the ensuing days two ballots are held each morning and The ballots are rectangular pieces of paper with the words: "Eligo in Summum

Pontificem" ("I elect as supreme pontiff") written on top, with a space for a name. Each cardinal makes his choice, folds the paper in half, walks to the front of the

He then puts the ballot on a tray and tips it into a receptacle.

Three designated cardinals, known as scrutineers, check each ballot to see if it is filled out correctly. Each name is read aloud and counted, with the results announced to the conclave after each round.

If no one gets the needed two-thirds of votes, the ballots are pierced with a needle and thread, which is then knotted and placed on a tray, and another round

Benedict modified some of John Paul's 1996 conclave rules, most notably excluding his vision that a pope could be elected by a simple majority if voting was stalemated. Benedict decreed that a two-thirds majority is always needed, no matter how long it takes. He did so to prevent cardinals from holding out for the 12 days foreseen by John Paul and then pushing through a candidate with a slim

Benedict also tightened the oath of secrecy in the conclave, making clear that anyone who reveals what went on inside faces automatic excommunication.

In John Paul's rules, excommunication was always a possibility, but Benedict revised the oath that liturgical assistants and secretaries take to make it explicit, saying they must observe "absolute and perpetual secrecy" and explicitly refrain from using any audio or video recording devices.

Cardinals also are bound by secrecy, although the threat of excommunication only hangs over them explicitly if they are found to have accepted payment for their vote, allowed secular powers to influence it, or entered into pacts with other cardinals to back a candidate.

Tornado-producing storm deals deadly weather to Oklahoma, Texas

WASHINGTON, April 21, (AP): A slow-moving, active storm system brought heavy rain, large hail and tornadoes to parts of Texas and Oklahoma and left three people dead as severe weather warnings Sunday continue to threaten parts of the south-central and Midwest US.

On Easter Sunday, communities in Texas and Oklahoma were beginning to assess the damage wreaked by tornadoes. There were 17 reported events Saturday, according to Bob Oravec, lead forecaster with the National Weather Service's Weather Prediction Center. Five were confirmed in southcentral Oklahoma, including one that inflicted substantial damage on a small town that was still recovering from a March tornado.

The storm also brought heavy rain to a broad swath of north-central Texas across central-eastern Oklahoma, much of which saw 2 to 4 inches (5 to 10 centimeters) accumulate Saturday into Sunday.

Police in Moore, about 10 miles (16 kilometers) south of Oklahoma City, received dozens of reports of "highwater incidents" over the weekend, including two cars stranded in flood waters Saturday evening.

One car was swept away under a bridge, and police said they were able to rescue some people, but a woman

and 12-year-old boy were found dead. "This was a historical weather event

that impacted roads and resulted in dozens of high-water incidents across the city," Moore police said in a statement Sunday. Moore has about 63,000

The storm also killed one person about 80 miles (129 kilometers) farther southeast after a tornado touched down in Spaulding, according to the Hughes County Emergency Manage-

The department wrote on Facebook that several homes and structures were destroyed and there were "numerous washouts" of county roads.

Democrats' leadership carousel turns

Anti-Trump resistance sees another leader in Van Hollen

NEW YORK, April 21, (AP): Now, it's Chris Van Hollen's turn.

The mild-mannered Maryland senator has suddenly emerged as a leading figure in the resistance to Donald Trump's norm-busting presidency, becoming the latest in a small but growing collection of Democratic officials testing the strength of their political power in a weakened party with no clear leader.

Van Hollen's rise follows his decision to travel 2,000 miles to El Salvador last week to meet with Kilmar Abrego Garcia, who was wrongly deported and federal courts have said should be returned.

Van Hollen did not secure the release of the Salvadoran citizen who had been living in Maryland. But simply by meeting with him, in defiance of Trump and his ally El Salvador President Nayib Bukele, Van Hollen created a new sense of hope and momentum for Abrego Garcia's family and the anti-Trump resistance.

"Sen. Van Hollen's leadership in this moment is exactly how Democrats should be pushing back against wannabe dictator like Donald Trump - calling for law and order over chaos and adhering to the Constitution instead of a tyrant," Democratic National Committee Chair Ken Martin told The Associated Press.

Ezra Levin, co-founder of the resistance group Indivisible, said the growing protest movement is directed both at Trump and "the Schumers of the world, those who want us to roll over and play dead."

"Courage is impressive and contagious," Levin said, noting that he's hearing "a ton of positive feedback for (Van Hollen) among our folks on the ground." He said the reaction is akin to the outpouring of support for Sen. Cory Booker, D-N.J., earlier in the

Booker had stepped into the leadership void by delivering a recordbreaking 25-hour speech on the Senate floor that briefly served as a rallying point for the frustrated anti-Trump movement. Concerned voters also have packed into rallies hosted by Sen. Bernie Sanders, I-Vt., and Rep. Alexandria Ocasio-Cortez, D-N.Y., who have launched a national "Stop Oligarchy" tour.

At the same time, potential 2028 presidential contenders such as Govs. Gavin Newsom of California and Gretchen Whitmer of Michigan have gone the other way by downplaying their Trump criticism at times. Others, including Govs. Josh Shapiro of Pennsylvania and Wes Moore of Maryland, have largely avoided stepping into the national debate.

Drones pose increasing risk to airliners near major United States airports

WASHINGTON, April 21, (AP): A commercial airliner was on final approach to San Francisco's international airport in November when the crew spotted a drone outside the cockpit window. By then it was too late "to take evasive action," the pilots reported, and the quadcopter passed by their windshield, not 300 feet away.

A month earlier, a jetliner was flying at an altitude of 4,000 feet near Miami's international airport when its pilots reported a "close encounter' with a drone. In August, a drone came within 50 feet of clipping the left wing of a passenger jet as it departed Newark International Airport

The incidents were all classified as "near midair collisions" - any one of which could have had catastrophic consequences, according to aviation safety experts. They were also not isolated encounters.

An Associated Press analysis of an aviation safety database reveals that drones last year accounted for nearly two-thirds of reported near midair collisions involving commercial passenger planes taking off and landing at the country's top 30 busiest airports. That was the highest percentage of such near misses since 2020, when air traffic dropped during the COVID-19 pandemic.

The first reports of near misses involving drones were logged in 2014, the AP found. The number of such

encounters spiked the following year. Over the last decade, drones accounted for 51% - 122 of 240 - of reported near misses, according to AP's analysis.

Passenger jets have long been subject to risks around airports - whether from bird strikes or congested airspace - as was made clear by the January collision between a military helicopter and commercial jet near Washington, D.C., that killed 67 people.

The threat from drones has become more acute in the last decade as the use of quadcopters and remote-controlled planes has exploded in popularity. The FAA estimates that Americans are operating more than a million drones for recreational and commercial purposes.

"If you have the money, you can go they really have no business being at," said William Waldock, a professor of safety science at Embry-Riddle Aeronautical University. The risk is most acute near airports because that is where the flight paths of drones and



The ceasefire expired at midnight (2100 GMT) following Easter Sunday. (AP)

Kosovo new lawmakers sworn in: Kosovo's legislature on Saturday swore in the 120 lawmakers who will sit in the newly elected Assembly, or Parliament, after procedural disputes between the political parties but failed twice to elect a new speaker, a process which may take the country

into a prolonged legislative crisis All parties who won seats in the Feb. 9 election voted unanimously in favor of taking up their mandates, opening the way to the election of the new speaker and deputy speakers. The left-wing Self-Determination Movement, or Vetevendosje!, of acting Prime Minister Albin Kurti won 48 out of 120 seats in the election, falling short of the majority needed to elect a new speaker or to form a cabinet on its own. In 2021, the party won 58 seats. (AP)

German police expands manhunt for suspect on loose after two shot dead

BERLIN, April 21, (AP): German police in a spa town north of Frankfurt were expanding a manhunt for one or more suspects still on the loose after two Turkish men were fatally shot a day earlier, reports said Sunday.

Police in the Hesse region said the two victims were gunned down in a residential area of Bad Nauheim, about 35 kilometers (about 22 miles) north of Frankfurt, and a motive was not immediately known. German news agency DPA said authorities could not rule out that one or more suspects might have been involved, and the crime appeared to have been motivated by personal reasons. Citing police and prosecutors, the agency said the two victims were a father-in-law aged 59, and a son-inlaw aged 28.

broadcaster, a large police contingent was deployed after the shootings on Saturday, and local residents indicated

that special forces had been sent to the site, along with emergency vehicles and a police helicopter.

US general says allied forces can repel Asia aggression as Philippines combat drills open

MANILA, Philippines, April 21, (AP): Thousands of allied American and Filipino forces opened annual combat drills Monday that are set to include repelling an island attack to simulate the defense of the Philippine archipelago and seas in a "full-scale battle scenario" that has antago-

The annual Balikatan military exercises between the longtime treaty allies are scheduled from April 21 to May 9 with about 9,000 American and 5,000 Filipino military personnel. Fighter jets, warships and an array of weaponry including a US Marine anti-ship missile system will be involved, US and Philippine military officials said.

China has steadfastly opposed such war drills in or near the disputed South China Sea and in northern Philippine provinces close to Taiwan, especially if they involve US and allied forces that Beijing says aim to contain it and, consequently, threaten regional stability and peace.

'We are ready," US Marine Corps Lt. Gen. James Glynn told a news conference when asked if US and Philippine forces have built up the capability to address any major act of aggression in the Taiwan Straits or the South China Sea after years of joint combat exercises.

"Our combined strength ... possesses a degree of lethality for a force that possesses an indomitable warrior ethos and spirit," Glynn said in a speech in the opening ceremony of the annual combat-readiness exercises. "It's all dedicated to one purpose, to ensure the defense of the Philippines and to maintain a free and open Indo-Pacific."

"All of us want to resolve any regional conflict peacefully but should deterrence fail, we need to be prepared," said Glynn, who previously helped lead special operations forces against the Islamic State and served in Fallujah,

Philippine army Maj Gen Francisco Lorenzo said the

excercises during Balikatan, meaning shoulder to shoulder in Tagalog, are not aimed at any particular country.

"It's joint training with the US forces to increase our capability in securing our territory and, of course, it will increase our capabilities and our preparedness and responsiveness to any eventuality," Lorenzo said.

The exercises are set to include a mock allied counterassault against an enemy attack on an island, the use of a barrage of artillery and missile fire to sink a mock enemy ship, joint navy sails in or near the disputed South China Sea and aerial combat surveillance, according to the Philippine military.

A Philippine military statement described this year's largescale combat exercises as "a full-scale battle scenario meticulously designed to rigorously test and enhance the combined capabilities of both nations' armed forces under the most realistic and challenging conditions.

Aside from US and Philippine military personnel, Australia plans deploy about 260 participants, an Australian military officer said. Several countries including Japan intend to send military observers.

A mid-range missile system, which was deployed to the northern Philippines by the U.S. Army last year, will be used again in the combat exercises, U.S. and Philippine military officials said without offering additional details.

China has repeatedly expressed alarm over the missile deployment and demanded the Philippines pull the weaponry from China's territory, which it said could spark an

The US Army's mid-range missile system consisting of a mobile launcher and at least 16 Standard Missile-6 and Tomahawk Land Attack Missiles has been repositioned in the Philippines, a Philippine official told The Associated Press early this year.

China, Indonesia agree to boost maritime security cooperation in South China Sea

TAIPEI, Taiwan, April 21, (AP): Indonesia and China said Monday they committed to maritime cooperation promoting safety and security in the South China Sea, amid longstanding Indonesian suspicions about China's actions in waters controlled by Jakarta.

The sides agreed to cooperate in infrastructure building, minerals development and joint security, the last being the most significant because of Indonesia's concerns over Chinese development near the Natuna island group in the South China Sea, which Beijing claims virtually in its entirety.

While neither side mentioned the islands directly, Chinese Foreign Minister Wang Yi said the officials agreed to further enhance their security cooperation in a comprehensive and sustainable way.

"We will enhance law enforcement and security cooperation to jointly combat transnational (inaudible) cooperation," Wang said following the first joint meeting of foreign and defense ministers from the two sides in Beijing.

"We agreed that safeguarding peace and stability in the South China Sea is in line with the interests of all parties, and we will set up an example in maritime cooperation," Wang said, adding that the coast guards signed a memorandum of understanding on maritime security and safety.

Indonesia borders the strategic waterway through which an estimated \$5 trillion in world trade passes annually, but it is not formally one of the six parties that share overlapping sovereign maritime claims with China. Such disputes have raised fears of a larger conflict that could put China and the US on a collision

Despite that, China's southernmost territorial claim lies within Indonesia's 370-kilometer (200-nautical-mile) exclusive economic zone, and Indonesian security patrols routinely drive off or seize Chinese fishing boats, fueling tensions between the countries. Meanwhile, officials in Jakarta are mulling over Beijing's plans for the Natuna island chain, part of which lies inside China's "nine-dash line," which it uses to roughly demarcate its claim to most of the South China Sea.

Chinese coast guard ships have escorted fishing vessels - some of which have been confronted by the Indonesian coast guard - while Indonesia has increased the number of patrols and size of garrisons on the hundreds of scattered islands.

Last year, during a state visit by Indonesian President Prabowo Subianto, the sides pledged to "joint maritime development" in the area, while having no effect on sovereignty claims, seemingly calming the situation somewhat.

While that appeared to apply mainly to economic opportunities, Chinese Defense Minister Adm. Dong Jun on Monday said the sides had also agreed to boost communication and stage joint counter-terrorism exercises later this year.

The South China Sea, especially its parts lying close to Indonesia, has at times become notorious for piracy in which ships are repainted, renamed and have their electronic identities altered in the countless ports and islands in the archipelago.

Indonesian Foreign Minister Sugiono and Defense Minister Sjafrie Sjamsoeddin largely echoed the Chinese sides' comments, underscoring their joint desire to smooth over economic and security divisions.

"We also agreed to stand united against terrorism, violent extremism and cyberthreats and we shared concerns over the threat of transnational crime in the region which increasingly targets our nationals," said Sugiono, who like many Indonesians uses just one name.

Indonesia is also in the process of establishing a consulate in the southwestern Chinese city of Chengdu, which has close relations with Southeast Asia, Sugiono

Indonesia's economic ties with China have flourished in recent years. China became Indonesia's largest trading partner and plowed billions into major infrastructure projects such as the Jakarta-Bandung high-speed railway and Cirata, Southeast Asia's largest floating solar power project, on a reservoir in West Java, 130 kilometers (80 miles) from the capital, Jakarta. HONG KONG: China will sanction United States officials, lawmakers and leaders of non-governmental organizations who it says have "performed poorly" on Hong Kong issues, the foreign ministry announced.

The US in March sanctioned six Chinese and Hong Kong officials who it alleged were involved in "transnational repression" and acts threatening to further erode the city's autonomy. The officials included Justice Secretary Paul Lam. security office director **Dong Jingwei** and former police commissioner **Raymond**

In a retaliatory move against **Washington**, **DC**, on Monday, Chinese foreign ministry spokesperson **Guo Jiakun** in **Beijing** said China strongly condemned the acts, calling them "despicable." The US has seriously interfered in the affairs of Hong Kong and violated international law principles, he said

"China has decided to impose sanctions on US congressmen, officials, and NGO leaders who have performed poorly on Hong Kong-related issues," Guo said, adding the response was made according to the anti-foreign sanctions law. He did not provide more details about who is being targeted.

Guo also issued a warning about Hong Kong, saying the southern Chinese city's affairs are not subject to US interference. Any actions considered wrong by the Chinese government that are taken on Hong Kong-related issues will be met with firm countermeasures and reciprocal retaliation, he said.

The tit-for-tat sanctions over Hong Kong's human rights issues are the latest sign of rising tensions between Beijing and Washington, which are already locked in a trade war that has rattled businesses on both sides.

Beijing separately warned other countries on Monday against making trade deals with the U.S. to China's detriment.

'Review progress in bilateral relations'

US VP Vance arrives in India for 4-day visit

NEW DELHI, April 21, (AP): US Vice President JD Vance arrived in India on Monday for a four-day visit as New Delhi looks to avoid US tariffs, negotiate a bilateral trade deal with Washington and strengthen ties with the Trump administration.

Vance was to meet Prime Minister Narendra Modi on the first day of his largely personal visit. The two leaders are expected to hold discussions on bilateral ties outlined in February when Modi met President Donald Trump in Washington

The US is India's largest trading partner and the two countries are now holding negotiations aiming to seal a bilateral trade agreement this year.

They have set an ambitious target of more than doubling their bilateral trade to \$500 billion by 2030. If achieved, the trade deal could significantly enhance economic ties between the two countries and potentially strengthen diplomatic ties as well.

Vance's first visit to New Delhi

comes amid the backdrop of Trump's now-paused tariff program against most countries, including India. It also coincides with a rapidly intensifying trade war between Washington and Beijing, which is New Delhi's main rival in the region.

Modi and Vance are expected to "review the progress in bilateral relations" and "exchange views on regional and global developments of mutual interest," India's Foreign Ministry said last week. On Monday, spokesperson Randhir Jaiswal said Vance's visit will "further deepen the India-US comprehensive global strategic partnership.

Vance was greeted with an Indian classical dance performance after he arrived at New Delhi's Palam airport on Monday, following his visit to Rome, where he met Pope Francis on Easter Sunday. He is accompanied by his wife, Usha Vance, a practicing Hindu whose parents are from India, along with their three children and officials from the U.S. administration.

The family visited the Akshard-ham Hindu temple in New Delhi after their arrival and are expected to tour the iconic Taj Mahal monument and the 12th-century Amer Fort - a UNESCO world heritage site - during their trip.

India is a close partner of the US and an important strategic ally in combating the rising influence of China in the Indo-Pacific region. It is also part of the Quad, which is comprised of the US, India, Japan and Australia and is seen as a counterbalance to China's expansion in the region. Trump is expected to attend a summit of Quad leaders in India later this year.

Washington has long sought to develop a deeper partnership with New Delhi, which is seen as a bulwark against China. Modi particularly established a good working relationship with Trump during his first term in office and the two leaders are likely to further boost cooperation between their countries.

'Attacks in N.Darfur caused displacement of population'

PORT SUDAN, April 21, (KUNA): United Nations Resident and Humanitarian Coordinator in Sudan, Clementine Nkweta-Salami stated Sunday that the recent attacks in North Sudan have caused mass displacement of people.

"The current mass displacement particularly from Zamzam, Abu Shouk, and other displaced camps - has pushed an estimated 400,000-450,000 people toward Tawila, areas surrounding Jebel Marra, and further," Salami said in a statement.

"These population movements are increasingly fluid, unpredictable, and fueled by ongoing hostilities and fears of a broader offensive on El Fasher.

She warned that the situation is further compounded by rising levels of food insecurity, with displaced populations increasingly cut off from supply chains and assistance, placing them at heightened risk of epidemic outbreaks, malnutrition and famine.

Salami laid it bare that the scale and gravity of reported violations,

Bukele proposes prisoner swap with Maduro for Venezuelan deportees

SAN SALVADOR, El Salvador, April 21, (AP): Salvadoran President Nayib Bukele proposed carrying out a prisoner swap with Venezuela on Sunday, suggesting he would exchange Venezuelan deportees from the United States his government has kept imprisoned for what he called "political prisoners" in Venezuela.

In a post on the social media platform X, directed at President Nicolás Maduro, Bukele listed off a number of family members of high-level opposition figures in Venezuela, journalists and activists detained during the South American government's electoral crackdown last year.

"The only reason they are imprisoned is for having opposed you and your electoral fraud," he wrote to Maduro. "However, I want to propose a humanitarian agreement that includes the repatriation of 100% of the 252 Venezuelans who were deported, in exchange for the release and surrender of an identical number (252) of the thousands of political prisoners you hold."

Al-Sager emphasized the government's commitment to advancing financial and economic reforms, highlighted by the recent adoption of key legislation such as the Financing and Liquidity Law (debt law) and the anticipated issuance of the mortgage law. These initiatives are expected to support economic growth and positively impact the business environment in Kuwait. However, he noted that the challenges posed by US tariffs, concerns over a potential global trade war, and ongoing geopolitical tensions will remain among the most significant uncertainties that are facing the markets in the near term.



Islamic Finance 2025-2026: Resilient growth amid upcoming headwinds

Kuwait's Islamic Finance sector set for steady growth amid GCC momentum

The Islamic finance industry experienced a rapid asset increase in 2024, mainly from growth in banking assets and sukuk owing to higher foreign currency-denominated issuances. S&P Global Ratings expects this growth to continue in 2025 barring any significant macroeconomic or intrinsic

We have recently revised our oil price assumption to \$65 per barrel for the remainder of 2025 and \$70 per barrel from 2026. This will likely continue to support some growth in most core Islamic economies. Simultaneously, financing needs driven by economic transformation programs will remain high, and the inherent preference for Islamic finance will persist. As a result, despite growing uncertainty, we expect the Islamic finance industry to grow in 2025.

However, a further decline in oil prices could reduce the growth prospects for core Islamic finance economies and markets. In addition, adopting Sharia Standard 62 could disrupt the sukuk market from 2026 by potentially reclassifying the instruments from debt-like to equity-like. But the extent of this will depend on whether the standard is approved, its content, and when it will be implemented. If Standard 62 is adopted as proposed, we anticipate the industry could become more fragmented and less attractive to investors and issuers due to higher sukuk pricing for issuers and fewer fixed-income investors.

Strong But Concentrated Growth In 2024, the Islamic finance industry's total assets increased by 10.6% compared with 2023, supported by growth in banking assets and the sukuk industry.

Banking assets account for more than half of this increase Islamic banking assets contributed 60% of industry growth in 2024 compared with 54% in 2023.

The Gulf Cooperation Council (GCC) accounted for 81% of this growth, with Saudi Arabia alone responsible for two thirds of it. This


strong performance results from opportunities created by the


Saudi government's Vision 2030 program and the deep integration of the Islamic banking industry in Saudi Arabia, which represented about three-quarters of banking system assets at year-end 2024. Bahrain also experienced significant Islamic finance industry growth, particularly due to Ahli

United Bank's (BBB+/Stable/--) conversion from conventional to Islamic banking. The United Arab Emirates (UAE) also contributed to this growth, thanks to the non-oil economy's strong performance. Elsewhere, we have observed some growth in other countries, particularly in Malaysia and Turkey.

We expect economic growth in Saudi Arabia and the UAE will continue supporting Islamic banking asset expansion in 2025, barring any significant disruptions from global trade tensions or a further decline in oil prices. Saudi Arabia's Vision 2030 will continue to translate into significant banking system growth, provided it attracts sufficient refinancing sources, including sukuk issuances from the international capital market. In the UAE, the non-oil economy's performance, along with capital expenditure needs across various sectors will further support financing requirements and sukuk issuances in 2025, assuming current market volatility does not have a major impact. In other GCC countries, we expect growth to continue thanks to reforms in Oman, Bahrain, and Kuwait, as well as anticipated increases in gas production in Oatar.

In Asia-Pacific, we expect the Islamic banking industry to grow by high single digits over the next couple of years. Robust demand for Islamic products and services in Malaysia and significant market potential in Indonesia, Bangladesh, and Pakistan support this trend. Nonetheless, we expect Malaysia to continue controlling the majority of Asia-Pacific's banking industry. The financing growth of Islamic banks will continue to outshine





conventional banks' credit growth, facilitating market share gains. However, this growth might be somewhat tempered by local currency volatility, which is also a concern for Türkiye and Egypt. We expect local currency growth in these countries to continue, but overall performance will depend on that of their respective currencies.

Although Türkiye's contribution to Islamic banking growth in 2024 was modest in absolute terms, it ranked as one of the largest contributor to the industry's growth in relative terms.

Outstanding sukuk issuance crossed the \$1 trillion mark Global sukuk issu-

ance is likely to reach about \$190 billion-\$200 billion in 2025, assuming current market volatility does not have a major impact, with foreign currency-denominated issuance contributing \$70 billion-\$80 billion. In 2024, total sukuk issuance declined slightly to \$193.4 billion from \$197.8 billion in 2023. However, a notable difference was the 29% rise in foreign currency issuance to \$72.7 billion as of Dec. 31, 2024.

We expect foreign currency-denominated issuance to remain elevated in 2025, provided there are no major disruptions due to the current volatility in global capital markets. Many issuers

sought to benefit from the improving global liquidity conditions in 2024. with major central banks easing their monetary policy. As it stands, we anticipate the Federal Reserve will lower its policy interest rate by just 25 basis points this year but widening spreads may result in higher overall financing costs. However, this is unlikely to significantly hinder the sukuk market's performance since it is primarily driven by high financing needs in core countries, pushing issuers to seize available market opportunities. A significant change in macroeconomic conditions, such as materially lower oil prices or increased geopolitical risks, could lead to a decrease in issuance volume.

Residential mortgage-backed securities could benefit Saudi Arabia's sukuk market. At year-end 2024, banks were sitting on more than \$180 billion in predominantly fixed-rate mortgages that were financed using sources--primarily domestic deposits--with short-term contractual maturities. While we note the behavioral maturity of these deposits is much longer than their contractual maturity, mismatches are still high

As interest rates decline, banks will be able to resell these loans in the secondary market without incurring losses. A key hurdle remains investor confidence regarding the capacity of banks to foreclose on mortgages in the event of a default. A stronger track record could help kickstart issuances in this segment. In the meantime, banks may rely on backup coverage to cater for the lack of asset foreclosure. provided Sharia scholars approve this. A residential mortgage-backed sukuk market in Saudi Arabia, denominated in rivals or U.S. dollars to leverage the credible peg between the two currencies, could also act as a catalyst for similar movement in the GCC region.

The takaful and fund industries play a small but an important role.

Although their contribution to the industry is small, we expect the asset base in the takaful and fund sectors will continue to grow. We expect takaful to expand annually by 10%-15%, sup-

ported by ongoing business growth and increasing insurance penetration. Investment returns may be volatile in 2025, but we still expect some growth in the fund industry given the dominance of money market and sukuk funds followed by equity funds. The industry could also benefit from stronger disclosure in the fund industry since we are still using estimates to assess its performance.

Overall, we think the industry is likely to experience 9%-10% growth in 2025. Its performance in 2026 will depend on whether Standard 62 is adopted, and if so, its impact on sukuk issuance volumes. We continue to exclude Iran from our calculations due to the lack of disclosure and volatility in the country's exchange rate.

Standard 62 Is Driving Preemptive Market Activity

In a recent public hearing, the Accounting and Auditing Organization for Islamic Financial Institutions (AAOIFI) announced it will likely give issuers more time to implement Sharia Standard 62. Issuers will likely have between one and three years to implement the new requirements, depending on AAOIFI's final decision. The standard is supposed to be approved this year, but it's still not clear whether AAOIFI will consider the significant concerns raised by market participants, such as effectively transferring the ownership of underlying assets.

We still think a retroactive application of the standard to existing sukuk is unlikely since it would be subject to investor consent. At the same time, we consider sukuk issuers who are already under financial strain may use the standard to restructure their existing sukuk on the grounds that they do not comply with the new requirements. However, this risk should be mitigated by the fact that a sukuk's legal documents generally include clauses that are designed to prevent the issuer from reneging on its contractual obligations based on noncompliance with Sharia law. Therefore, although we do not currently expect a significant number of sukuk restructurings once the standard is adopted, this could change depending on its final terms.



Ryan Coogler's film defies trends

'Sinners' surges past 'Minecraft Movie' to lead US box office

NEW YORK, April 21, (AP): Brand names, not filmmakers or stars, are said to rule the box office these days. But Ryan Coogler's "Sinners," led by twin Michael B. Jordans, proved a bloody exception to modern movie rules, launching with \$45.6 million in ticket sales in US and Canadian theaters, according to studio estimates

"Sinners," a Warner Bros. release that cost about \$90 million to produce, was a bold gamble on originality - albeit with genre elements - and one of the most bankable American directors in Coogler. The "Creed" and "Black Panther" director wrote and produced "Sinners," a 1932-set vampire movie about bootlegging brothers (both played by Jordan) who open a juke joint in their Mississippi hometown.

"A Minecraft Movie," the year's biggest Hollywood hit, followed close behind in second, collecting \$41.3 million in its third week of release. That gave Warner Bros., after a handful of disappointments, an enviable one-two punch at the box office with one original, director-driven movie and one IPbased property.

"A Minecraft Movie," which Warner Bros. co-produced with Legendary Pictures, has amassed \$720.8 million worldwide in three weeks of release.

Pam Abdy and Mike De Luca, cochairs of Warner Bros. Motion Picture Group, celebrated the two films' resonance with moviegoers. The studio accounted for a remarkable 64% of the domestic box office for the Easter

"Movies have the power to transport us to worlds only seen on the big screen, and Warner Bros. Pictures remains committed to bringing singular in-theater experiences to audiences looking for bold movies, both original and those based on beloved existing properties," Abdy and De Luca said in

But all eyes were on the performance on "Sinners," which Warner Bros. went to extreme lengths to secure. Abdy and De Luca agreed to give Coogler not just a cut of gross ticket sales but ownership of the film after 25 years - a virtually unheard of conces-

But Coogler and Jordan, whose col-

laborations stretch back to "Fruitvale Station," make up one of the industry's most potent director-actor duos. Reviews (98% "fresh" on Rotten Tomatoes) were stellar for "Sinners" and audiences, too, were enthralled by its supernatural twists. The film earned an "A" CinemaScore from moviego-

Overseas, "Sinners" faced a more uphill battle. It collected \$15.4 million in 71 international markets. Domestically, "Sinners" attracted a diverse audience: 38% Black, 35% white, 18% Hispanic and 5% Asian.

Before "Sinners," dual roles had been rough business for Warner Bros. The studio saw flops in both "The Alto Knights" (a period gangster film featuring a doubled Robert De Niro) and "Mickey 17" (a sci-fi movie with two Robert Pattinsons).

But the strong opening for "Sinners," which should be sustained in the coming weeks given the strong word of mouth, cements Coogler's place as one of a handful of filmmakers whose name draws big audiences. Another would be Jordan Peele, whose "Nope" (2022) debuted similarly with \$44.3 million.

Angel Studios' "The King of Kings," an animated tale of Jesus' life aimed at Christian audiences, capitalized on the Easter weekend, grossing \$17.2 million in its second week of release. That was nearly equal to its opening weekend (\$19.1 million), and brought "The King of Kings" to a domestic total of \$45.3 million.

Bleecker Street's "The Wedding Banquet," Andrew Ahn's reimagining of Ang Lee's 1993 queer comedy of errors, opened on 1,142 North American screens with \$922,906 in ticket sales. "The Wedding Banquet," a hit at the Sundance Film Festival, stars Lily Gladstone, Bowen Yang, Kelly Marie Tran and newcomer Han Gi-

'The Herds' takes audiences into the heart of climate change in Nigeria

MAKOKO, Nigeria, April 21, (AP): Several canoes paddle toward Makoko, a vast floating slum built on stilts in the lagoon at one end of Nigeria's economic hub of Lagos. Riding on the vessels are giant cardboard puppet animals along with their puppeteers dressed in black.

Once on the water, the animals - a gorilla, a leopard, an elephant, a wildebeest, a giraff and a donkey - all come alive. The gorilla hoots, the donkey brays and wags its tail as the leopard bends its neck toward the surface as if to drink but halts just before its face meets the water and then turns to look around.

It is Saturday, the second day of "The Herds" theatrical tour stop in Nigeria on a journey 20,000 kilometers (12,427 miles) from Africa's Congo Basin to the Arctic Circle with puppet animals. It's a journey organizers say is meant to bring attention to the climate crisis and "renew our bond with the natural

The tour started last week in Kinshasa, the capital of Congo, and will continue across the world with Dakar, the Senegalese capital, as the next stop.

The story goes that the animals will be forced out of their natural habitats due to global warming and displaced north, stopping in cities along the way and being joined by more animals.

The sprawling slum of Makoko - an old fishing village - was perfect to illustrate that because it has for many years shown resilience in the face of climate change, often finding

ways to adapt to extreme weather, said Amir Nizar Zuabi, "The Herds' artistic director.

Dubbed the Venice of Africa, the Makoko slum is a low-lying community vulnerable to rising sea levels and flooding. Lagos itself is no stranger to the impacts of climate change, with roads and houses across the coastal city often engulfed during annual flooding.

"We are on the edge of one of the greatest global crises, and ... I think the global south offers a lot of knowledge and a lot of resilience," Zuabi said, referring to developing countries in the Southern Hemisphere with lower incomes and higher poverty rates compared to the "global north."

Spread out beneath the Third Mainland Bridge that connects much of Lagos. Makoko came alive as "The Herds" moved in. People poked their heads out of windows in awe of the exhibition. Children and women stood on the plank porches outside their rickety wood houses, watching as the animals paddled in through the narrow waterways. Some mimicked the animals while others applauded and waved at them.

"It looked so real," Samuel Shemede, a 22-year-old resident of Makoko, said in awe of the puppets. "I had never seen something like that

before in my life. It is not real, but they made it look so real." As the tour left Makoko and moved to the Yaba suburb, the city's

notorious traffic stood still for the

puppets as they towered over people and vehicles. The big animals had been joined by smaller primates like monkeys who hoot noisily, prance around, and even dance.

The tour was punctuated by dance and choreography performances from a local theater group whose performers, clothed in beige sack material and straw hats, intermittently charged toward the puppets as though they were about to attack them.

As they journeyed through the streets, spectators were treated to chants from the Hausa language song "Amfara," which loosely translates to "We have started."

At a time when African nations are losing up to 5% of their gross domestic product every year as they bear a heavier burden than the rest of the world from climate change, "The Herds" organizers said it is important to break down climate change and its impacts in a way that many people can relate to.

"A lot of climate debate is about science ... and scientific words don't mean anything for most people," Zuabi, the artistic director, "I wanted to create a piece of art that talks about nature, beauty and how animals are wild and majestic."

The animals invading cities is a metaphor for abnormal things now becoming normal as the world deals with climate change, he said. 'And hopefully this becomes a way to talk about what we are going to lose if we continue burning fossil fuels.'

From heartbreak to hope

Davido's '5ive' ushers in a new era for Afrobeats icon

NEW YORK, April 21, (AP): Afrobeats may be the hot sound of the moment, but Davido remembers a very recent past when music from Africa wasn't embraced globally, amid a perception the continent was one of only destitute poverty and primitive lands.

"I remember when Africans used to lie that they were Jamaicans," laughed the Atlanta-born "Fall" singer, who grew up between the US and Nigeria. "The narrative has immensely changed. And thanks to the people who are behind this, because it's not governments ...

it's the innovators. The musicians. The entertainers. The lawyers. The doctors in America, pushing the narrative of

African. The Grammy-nominated artist, who has multiple 100 million-streamed songs on Spotify and is often credited as playing a vital role in the global expansion of Afrobeats, drops his new album, "5ive," on Friday. Following 2023's "Timeless," the 17-track project boasts an international flare with features from Grammy winners Chris Brown and Victoria Monét, as well as Becky G and Afrobeats heavyweights Omah Lay and Victory. Davido began with 80 potential songs, then crowdsourced opinions from family and friends, using a ranking system to help curate the album.

Suffering heartbreak in 2022 after his three-year-old son died from a drowning accident, the 32-year-old now looks at

life with new perspective. "My life was going so fast .. now, things are clearer," said Davido, who now has five living children. "After the crazy loss we had, God gave us twins: a boy and a girl. So, life is just different now - the importance of family and good people around you. I feel like the energy is very, very important, and I feel like that energy is what I

used to record this album." The Associated Press spoke

with the megastar about the popularity of Afrobeats, unity and inspiring through grief. The conversation has been edited for clarity and brevity.

Davido: It's my fifth album. But after I called it "5ive," I went to go and do more research on the number five and what it entails, which is a symbol of hope, grace, change, growth.

Davido: Not over-loving the conception of Western validation ... one song blows up, two songs blows up - only two songs - and they are running to America to do a tour. What happened to Ibado? What happened to the other places in Nigeria?

The most important thing that will make us last longer is if we don't forget where we came from.

Davido: Recently, the conversation has been had ... when I see Bad Bunny working with Peso (Pluma), and Peso working with Farruko, I'm like, yo, there's so much unity.

Imagine if all of us came together and busted out a tour? ... We're older now, we are more mature, so I feel like maybe in the greatest future, you might

see that happen.
Davido: They can't do it better than us! I say this to Chris (Brown) every time we play around, I'm like, "Chris, can't sing R&B like you, but never in your life can you sing Afrobeats like me!" (laughs) I don't see any problem with it as long as it's done right and everybody's credit is due ... at least come use an African producer.

Davido: Music-wise, I don't think it changed a bit because when I get to my artist mode, nothing distracts me. ... When I dropped the "Timeless" album and everything went crazy - like, the most streamed album in the (first) week in Africa ever - we celebrated the album with the people that were with us when we were in trying times.

I feel like that was the beauty of it. And apart from that, I just want people to just look at my story and know that you can overcome anything.

Cause sought

US probes rise in autism cases

WASHINGTON, April 21, (AP): Health secretary Robert F. Kennedy Jr. warned that children in the US are being diagnosed with autism at an "alarming rate," promising on Wednesday to conduct exhaustive studies to identify any environmental factors that may cause the developmental disorder.

His call comes the day after the Centers for Disease Control and Prevention released a report that found an estimated 1 in 31 US children have autism, a marked increase from 2020.

Autism experts applaud efforts to further understand the condition, but say the number of reported cases began to balloon as the definition of the condition expanded to include mild

"Autism destroys families," Kennedy said. "More importantly, it destroys our greatest resource, which is our children. These are children who

should not be suffering like this."

Kennedy described autism as a "preventable disease," although researchers and scientists have identified genetic factors that are associated with it. Autism is not considered a disease, but a complex disorder that affects the brain. Cases range widely in severity, with symptoms that can include delays in language, learning, and social or emotional skills. Some autistic traits can go unnoticed well into adulthood.

Those who have spent decades researching autism have found no single cause. Besides genetics, scientists have identified various possible factors, including the age of a child's father, the mother's weight, and whether she had diabetes or was exposed to certain chemicals.

Kennedy said his wide-ranging plan to determine the cause of autism will look at all of those environmental factors, and others. He had previously set a September deadline for determining what causes autism, but said Wednesday that by then, his department will determine at least "some" of the answers.

Kids improve motor skills, social interaction

Horse therapy program brings joy to children with learning disabilities

WINDHOEK, Namibia, April 21, (AP): Susan de Meyer's horses have different effects on different children. Hyperactive kids learn to be a little quieter around them while nonverbal children are moved to communicate and to bond with them.

De Meyer runs a program in the southern African country of Namibia that harnesses the power but also the gentleness of horses to help children with learning disabilities and conditions like ADHD and autism.

Each weekday morning, de Meyer's dusty paddock just outside the capital, Windhoek, is enlivened by a group of eight to 10 children from one of the special schools she helps. The children ride the horses, groom them, stroke them and often, de Meyer says, talk to them.

De Meyer grew up on a farm surrounded by horses and they've always been part of her life. She said they have a quality that is invaluable: They don't judge the children, no matter how different they are.

"The horse is the hero in this whole situation because these kids don't want to be around a lot of people," de Meyer said.

De Meyer's program, "Enabling Through the Horse," is supported by the Namibian Equestrian Federation and won an award last year from the International Equestrian Federation because it "underlines the wonderful

characteristics of the horse in exuding sensitivity and intuition."

Horse therapy has been promoted by autism groups and those that work with children with learning disabilities as having a positive impact. And animal therapy in general has been found to be useful in many instances, like dogs that help military veterans with post-traumatic stress disorder and therapy cats that are taken to hospitals and nursing homes.

Some survivors of the devastating 2023 Hawaii wildfires found relief in horse therapy while grieving loved ones they had lost.

De Meyer jokes she has "two-anda-half horses." These include two Arabians - a white mare named Faranah and a brown gelding, Lansha - while the "half" is a miniature horse called Bonzi, who is about head-high for a

Meta improves teen safety

Instagram uses AI to identify teens pretending to be adults

NEW YORK, April 21, (AP): Instagram is beginning to test the use of artificial intelligence to determine if kids are lying about their ages on the app, parent company Meta Platforms said on Monday.

Meta has been using AI to determine people's ages for some time, the company said, but photo and video-sharing app will now "proactively" look for teen accounts it suspects belong to teenagers even if they entered an inaccurate birthdate when they signed up.

If it is determined that a user is misrepresenting their age, the account will automatically become a teen account, which has more restrictions than an adult account. Teen accounts are private by default. Private messages are restricted so teens can only receive them from people they follow or are already connected to. "Sensitive content," such as videos of people fighting or those promoting cosmetic procedures, will be limited, Meta said. Teens will also get notifications if they are on Instagram for more than 60 minutes and a "sleep mode" will be enabled that turns off notifications and sends auto-replies to direct messages from 10 p.m. until 7 a.m.

Meta says it trains its AI to look for signals, such as the type of content the account interacts, profile information and when the account was created, to determine the owner's age

The heightened measures arrive as social media companies face increased scrutiny over how their platform affects the mental health and well-being of younger users. A growing number of states are also trying to pass age verification laws, although they have faced court challenges.

Meta and other social media companies support putting the onus on app stores to verify ages amid criticism that they don't do enough to make their products safe for children - or verify that no kids under 13 use them.

Instagram will also send notifications to parents "with information about how they can have conversations with their teens on the importance of providing the correct age online," the company said.

Meanwhile, a federal judge permanently struck down an Ohio law on Thursday that would have required children and teens under 16 to get parental consent to use social media apps US District Court Judge Alge-


non Marbley's decision came in a lawsuit filed by NetChoice, a trade group representing TikTok, Snap-chat, Meta and other major tech companies. The organization's complaint argued that the law unconstitutionally impedes free speech and is overly broad and vague. The state contends the law is

needed to protect children from the harms of social media. Marbley said that the state's effort, while laudable, went too far.

"This court finds, however, that the Act as drafted fails to pass constitutional muster and is constitutionally infirm," he wrote, adding that even the government's "most noble entreaties to protect its citizenry' must abide by the U.S. Constitution.

Bethany McCorkle, a spokes-person for Republican Ohio Attorney General Dave Yost, said, "We're reviewing the decision and will determine the next steps."

The law was originally set to take effect Jan. 15, 2024, but Marbley placed an immediate hold on enforcing it that he later extended. It is similar to ones enacted in other states, including California, Arkansas and Utah, where NetChoice lawsuits have also succeeded in blocking such laws, either permanently or temporarily.



Atalanta pips Milan to maintain hold on third place

Inter struggles at Bologna again, left level with Napoli atop Serie A

ROME, April 21, (AP): Inter Milan has a history of recent struggles at Bologna and Sunday proved no different.

Riccardo Orsolini's stoppage-time bicycle kick lifted Bologna to a 1-0 victory over the Serie A leader and left the Nerazzurri level with second-placed Napoli with five rounds remain-

"It hurts conceding a goal like that seconds from the end," Inter coach Simone Inzaghi said. "But the season doesn't end here in Bologna. We still have a lot of goals to chase and now we'll bounce back."

The defeat brought back memories of a goalkeeping blunder by Ionut Radu that gifted Bologna a victory three years ago, setting up the title for rival AC Milan. Inter also lost at Bologna the next season in a rain storm.

Inter won at Bologna last season but spent so much energy it couldn't recover in time before getting eliminated by Atletico Madrid in the Champions League four days later.

This time, the match was decided when a long throw-in was flicked on by Inter defender Yann Bisseck toward Orsolini, who turned it in with an acrobatic left-footed volley to send the Renato Dall'Ara into delirium.

Inter is chasing a treble this season and also faces big upcoming games in the Champions League and Italian Cup, but coach Simone Inzaghi had labeled the Bologna visit as the biggest match of the season.

Now the Nerazzurri are deadlocked with Antonio Conte's Napoli team, which isn't involved in any other competitions and can devote all of its energy toward chasing a second title in three

Napoli won 1-0 at last-placed Monza to heap more pressure onto Inter.

Inter next faces Milan in the second leg of the Italian Cup semifinals on Wednesday (the first leg finished 1-1). Then after Roma visits the San

Siro next weekend, Inter travels to face Barcelona in the first leg of the Champions League semifinals.


And there could be another meeting with Bologna in the Cup final, after Bologna beat Empoli 3-0 in the first leg of the other semi-

Thomas wins RBC Heritage in playoff to end 3-year drought

Lindblad claims title in 3rd start as LPGA Tour member

HILTON HEAD ISLAND, S.C., April 21, (AP): Justin Thomas ended nearly three years without a victory Sunday by making a birdie putt from just outside 20 feet in a playoff at Harbour Town to beat Andrew Novak in the RBC Heritage.

Thomas played bogey-free in dry, fast conditions for a 3-under 68, making a 25-foot birdie putt on the 16th that looked like it might be the winner until Novak, who grew up in South Carolina, matched him with a birdie of his own for a 68.

Novak, who has had three good chances to win in his last 14 tournaments, had an 8-foot birdie putt on the 18th hole in regulation that was left all

In the playoff, Novak missed from just inside 35 feet, setting the stage for Thomas. The putt was so pure that Thomas dropped his putter before the ball dropped, stooping over and clutching both arms to celebrate a 16th PGA Tour win that felt long overdue.

His previous win was the PGA Championship at Southern Hills in May of 2022. His game slipped and he missed the FedEx Cup playoffs for the first time in 2023, and he was left off the Presidents Cup team a year ago.

Thomas and Novak finished at 7-under 267 three shots

Ingrid Lindblad won the JM Eagle LA Championship in her third start as an LPGA Tour member, avoiding a playoff when fellow rookie Akie Iwai bogeyed the final hole at El Caballero Country Club.

Playing a group ahead of Iwai, Lindblad shot a 4-under 68 to finish at 21-under 277. The 25-year-old former LSU star from Sweden made the last of her six birdies on the par-5 11th and parred the final seven holes.

Iwai followed a third-round 64 with

Rune upsets Alcaraz in straight sets to win Barcelona Open

BARCELONA, Spain, April 21, (AP): Holger Rune upset home-crowd favorite Carlos Alcaraz in straight sets to win the Barcelona Open for his first title since 2023.

Rune defeated the Spaniard 7-6 (6), 6-2 for his first title since winning in Munich two years ago, and fifth overall. It was the Dane's first ATP 500 title.

"It means the world, it was such a great match," Rune said. "In the beginning, I was a little bit stressed, because Carlos obviously plays big-time tennis. I had to breathe a lot and find my rhythm. After he broke me, I got more into the match and played my tennis. The first set was a big battle, it was super important to win it and gain the momentum. I'm so proud of myself.

Alcaraz was coming off a nine-match winning streak that included his first Monte Carlo Masters title last weekend. He was searching for his third title of the year and 19th of his career. He won the Barcelona Open in 2022 and 2023.

Rune, runner-up to Jack Draper at Indian

Wells, rallied from a break down in the opener and converted his fourth set point. He cruised in the second set against Alcaraz, who twice needed treatment on his upper right leg.

"I'm very happy with how I stayed composed when it mattered, and I was really brave," Rune said. vAlcaraz will lose his No. 2 ranking to Alexander Zverev, who won his third Munich title on Sunday.

"Congratulations Holger on an amazing week," Alcaraz said. "Coming here and showing a great effort to make the people

We've been seeing each other since (we were) 12 years old. Time flies. I'm really happy to see us in this position, how far 've (come). Keep going." It was the first ATP tour-level final between two players aged 21-and-under since 2022. Both are 21. By reaching the final in Barcelona, Rune

Last-gasp Valverde keeps Real in title hunt

Suspended Mbappé jeered by fans

MADRID, April 21, (AP): Still upset at their team's midweek exit from the Champions League, Real Madrid fans jeered suspended Kylian Mbappé and then cheered Federico Valverde after he scored late in a 1-0 win over Athletic Bilbao in the Spanish league. Midtable Osasuna won 3-2 at last-placed Valladolid, which has lost 12 of its last 13 matches. Osasuna has won two in a row after nine matches without a win across all tournaments.

Sevilla, sitting in 15th place, drew 1-1 at home against 18th-placed Ala-

The narrow victory for second-placed Madrid kept some pressure on leader Barcelona.

Mbappé, serving a red-card suspension, was jeered by many fans at the Santiago Bernabeu stadium four days after he had already been booed in Madrid's 2-1 second-leg loss to Arsenal in the quarterfinals of the Champions League. The Spanish powerhouse was eliminated 5-1 on aggregate from

a competition it has won a record 15 times.
"We did well today," Madrid coach Carlo Ancelotti said. "We wanted to win again and rebound from the elimination. The team came through and Fede was key. This victory gives us a boost.'

Valverde scored with a well-placed shot into the top corner from the right edge of the penalty area three minutes into second-half stoppage time.

The Bernabeu was mostly behind the team on Sunday, but some fans jeered when Mbappé was shown in the stadium on the large video screens. The victory moved Madrid back within four points of Barcelona, which rallied to defeat Celta Vigo 4-3 on Saturday. Third-placed Atletico Madrid stayed 10 points off the lead after losing 1-0 at Las Palmas. Fourth-placed Athletic is six points behind Atletico.

"The goal didn't want to come until Valverde once again came up with a wonder goal, like he does best," Madrid goalkeeper Thibaut Courtois said. "This was a very important win, we want to keep fighting. Barça won yesterday and it was our turn to win."





Norris had started 10th following a crash in quali-It was the second win in a row for Piastri, who took the victory in Bahrain last week and has three wins from five races this year. He'd only won two

Piastri leads the standings by 10 points from Norris, with Verstappen two points further back

Piastri was three points behind Norris going into Sunday's race, partly because of a costly spin at his home race in Australia, the first GP of the
