



# Manslaughter...debt scams now carry heavier penalties

### Kuwait's Justice Ministry rolls out bold Penal Code reforms

KUWAIT CITY, April 23: Minister of Justice Nasser Al-Sumait announced on Wednesday that the Cabinet has approved a draft decreelaw that amends certain provisions of the Penal Code issued under Law No. 16/1960, reports Al-Seyassah daily.

In a press statement issued after the Cabinet's weekly meeting, Minister Al-Sumait explained that the proposed amendments are in line with real-world



for up to three years and/or a fine ranging from KD 500 to KD 1,000.

Article 164: Whoever unintentionally causes injury or tangible harm to another person due to recklessness, negligence, lack of concern, inattention, or failure to comply with laws and regulations, or the requirements of their job, profession, or trade, shall be punishable by up to one year of imprisonment and/or a fine ranging from KD 250 to KD 500.

Minister Al-Sumait further explained that Article 2 of the draft decree-law amending certain provisions of Penal Code No. 16/1960 includes the addition of two new articles, numbered "154 bis" and "164 bis", with the following provisions:

two or more persons. 3. The perpetrator's act results in permanent

The draft law aims to enhance penal policy, protect individual rights, and ensure effective deterrence. The Penal Code has not undergone any substantive amendments related to manslaughter and unintentional injury since its enactment in 1960, despite the emergence of new forms of negligence and recklessness that have caused severe harm or loss of life, particularly in cases involving alcohol or drug use, or where the offender fails to provide assistance.

The draft decree-law includes amendments to certain provisions of the Penal Code.

Article One of the draft states: "The provi-sions of Articles 44 (Clause 1), 154, and 164 of the aforementioned Penal Code shall be replaced with the following:

Article 44, Clause 1: An unintentional error shall be deemed to exist if the perpetrator, at the time of the act, behaves in a manner inMinister of Justice Nasser Al-Sumait

Article 154: Anyone who unintentionally causes the death of another person due to recklessness, negligence, carelessness, inattention, failure to observe laws and regulations, or failure to meet the obligations of their job, profession, or trade shall be subject to imprisonment

Article 154 bis: The offense described in the previous article shall be punishable by up to five years of imprisonment and/or a fine ranging from KD 1,000 to KD 2,000, or by either of these penalties, if the crime is associated with one of the following circumstances:

1. The perpetrator uses an intoxicating, narcotic, or psychotropic substance, or any other substance that impairs the person's natural abilities.

2. The perpetrator's act results in the death of two or more persons.

3. The perpetrator refrains from assisting the victim at the time of committing the act, despite being capable of providing help.

If two or more of the circumstances listed in the previous paragraph are present, the penalty shall be 10 years of imprisonment and/or a fine

disability for the victim

4. The perpetrator fails or neglects to assist the victim at the time of committing the act, even though he is capable of providing assis-

The penalty shall be imprisonment for a period not exceeding three years and/or a fine ranging from KD 1,000 to KD 2,000, if two or more of the factors stipulated in the previous paragraph are combined.

Article 3 of the draft decree-law that amends certain provisions of the Penal Code promulgated by Law No. 16/1960 stipulates the following: A new clause (No. 8) titled "Debtor's Evasion of Payment," is added to Chapter Three (Crimes Against Property) of Book Three (Crimes Against Individuals) of the aforementioned Penal Code. This new clause includes new articles numbered 283, 284, 285, and 286, with the following provisions:

## FMD detected in Kuwait, but meat and dairy 'safe'





# Falsifying history and stealing others' rights

few days ago, I addressed a topic that some in-A lew days ago, I addressed a topic and dividuals have seemingly become specialists in, which is producing and sharing videos that appear scientific, yet include statements and achievements falsely attributed to international scientists and celebrities, often in exaggerated praise of religious figures. These claims are frequently far from the truth.

The German orientalist Sigrid Hunke has been quoted as saying: "The achievements of Arab sci-

entists, including physicians, chemists, mathematicians, and astronomers, fell upon Europe like rain, reviving its barren land. However, it was difficult for Europeans to acknowledge the Arabs' right to science, authorship, and innovation. As a result, many inventions and discoveries in medicine, pharmacy, chemistry, physics, mathematics, astronomy, and other fields were attributed to

was a scholar who specialized in Islamic studies. Her most notable work, "The Arab Sun Shines on the West" (1960), explores the influence of Arab-Islamic civilization on Europe. Hunke contributed to shifting some Western perspectives on Islamic culture and history. However, her credibility has been the subject of significant controversy, largely due to her past affiliation with the Nazi Party.

Some serious researchers view her work as highly exaggerated and question both the value and the extent of the influence she attributes to Islamic civilization. It is important to note that there is no such thing as "Islamic civilization", like "Christian," "Jewish," or "Buddhist" civilization.

The problem with the spread of such exaggerations lies not with Hunke herself, but with us. Regardless of the accuracy of her claims, many of which are, of course, incorrect, it is religious institutions, and subsequently official institutions, that continue to promote her views uncritically. This is not due to scholarly conviction, but rather because they refuse to recognize the contributions of these Muslim scholars.

Before the rise of religious and political extremism led by the Muslim Brotherhood, it was common to name educational and medical institutions after scientists like Ibn Sina and Al-Razi. However, this practice came to a halt once the Muslim Brotherhood gained influence over many government institutions. They went so far as to block even minor public recognitions such as naming a side street after these scholars, simply because they did not conform to their ideological beliefs. Scientist Pierre Curie (1859-1906) is credited with the quote: "We were able to split the atom using the remaining 30 books we had access to from the Andalusian civilization. Had we been able to read the thousands of Muslim books that were burned, we would be traveling between galaxies today". However, this is a complete fabrication. Pierre Curie died in 1906, decades before the discovery of atomic fission in the late 1930s. It is simply not possible for him to have made such a statement, especially given that nuclear fission was the result of modern scientific research, not ancient texts. Unfortunately, fake quotes like this are commonly circulated in an attempt to glorify those who are not in need of such glorification. It reflects the mindset of those who feel powerless or uncertain about the strength of their own doctrine, and seek validation through exaggeration rather than truth.

# **Kuwait stands strong on Palestine's full UN status**

### Al-Yahya urges Arab unity, global support

CAIRO, April 23, (KUNA): Kuwait's Foreign Minister, Abdullah Al-Yahya, emphasized the critical importance of Palestine's full membership in the United Nations for securing the future of Palestinians and their right to an independent state within the 1967 borders.

Speaking at the 163rd meeting of the Arab League Foreign Ministers in Cairo on Wednesday, Al-Yahya reaffirmed that the establishment of a Palestinian state with East Jerusalem as its capital was a non-negotiable issue and a shared aspiration for both Palestinians and the Arab world.

He noted that the year began with a "beam of hope" following a ceasefire in the Gaza Strip brokered by the US, Qatar, and Egypt, which raised hopes of ending the ongoing war. However, Al-Yahya condemned the Israeli occupation's continued violations of international agreements and laws, describing its ongoing attacks on innocent Palestinians in Gaza and the West Bank as a ruthless campaign The Minister commended the outcome of the Arab Summit held on March 4 in Cairo, which devised a plan for the reconstruction of Gaza once the Israeli occupation ends, facilitated by international peace efforts. Al-Yahya also expressed Kuwait's strong support for the Cairo International Summit for early recovery and reconstruction of Gaza and praised the efforts of the United Nations Relief and Works Agency (UNRWA) despite ongoing harassment by the Israeli occupation. He welcomed the UN General Assembly's decision to refer the ban on UNRWA to the International Court of Justice, urging a verdict on the legality of halting the agency's vital operations. Al-Yahya also reiterated Kuwait's firm stance against Israeli attempts to alter the legal status and history of Jerusalem. Regarding Syria, he reaffirmed Kuwait's support for the Syrian people, highlighting the country's role in organizing three humanitarian donor conferences to assist Syria and expressing support for the formation of a new transitional government in Syria, hoping it will lead to a modern, prosperous state. In his remarks on Lebanon, Al-Yahya expressed Kuwait's solidarity with the Lebanese people, stressing the importance of fully implementing UN Security Council Resolution 1701 and ensuring the ceasefire agreement

holds, while calling for an end to Israeli military aggression against Lebanon, its people, and the United Nations Interim Force in Lebanon (UNIFIL).

Al-Yahya also reaffirmed Kuwait's commitment to monitoring developments in Sudan, urging the maintenance of ceasefire agreements to allow humanitarian aid to reach those in need and protect civilians in accordance with international resolutions. On Yemen, he reiterated Kuwait's support for the unity and stability of Yemen through a comprehensive political solution based on the Gulf Cooperation Council (GCC) initiative, the national dialogue conference's outcomes, and relevant UN Security Council resolutions, particularly Resolution 2216.

Regarding Libya, Al-Yahya expressed support for the country's unity and stability. On Somalia, he welcomed the agreement between Somalia and Ethiopia in Ankara, aimed at resolving border issues, and condemned the assassination attempt on President Hassan Sheikh Mohamud, reaffirming Kuwait's solidarity with Somalia in its fight against terrorism.

Al-Yahya also called for restraint in maritime routes on the Red Sea, urging respect for international laws, including the 1982 United Nations Convention on the Law of the Sea. He praised Oman's efforts in securing the release of the crew of the "Galaxy Leader," detained off Yemen's coast since 2023, and commended Oman for mediating high-level talks between the US and Iran on the latter's nuclear program, seeing such initiatives as steps toward a more stable and peaceful Middle East. individuals other than their original creators.



KUWAIT CITY, April 23: Official spokesperson of the Ministry of Electricity, Water and Renewable Energy Eng. Fatima Hayat revealed that the ministry noticed an unusual power consumption increase in several areas over the past two weeks.

She stressed that the ministry "will not hesitate to take legal action against any entity or individual proven to be involved in excessive electricity consumption through unlicensed activities affecting the stability of the electricity system of the country."

She revealed the ministry launched a largescale inspection campaign in Wafra Residential Area last Sunday, leading to the discovery of about 100 homes whose consumption data show extremely high rates that differ from the usual residential consumption pattern. She said this indicates the possibility of electricity being used for unauthorized activities, particularly cryptocurrency mining.

She added that a thorough technical analysis resulted in the discovery of the unusual power consumption pattern in certain locations, which lack the typical variation between day and night and between seasons. "Consistently high consumption is recorded throughout the day -- a clear indication of intensive and non-stop operation of devices and equipment," she explained.

She disclosed that data showed some homes in Wafra had electricity consumption exceeding 100,000 kilowatts in March. "This is equivalent to 20 times the usual rate in neighboring homes. This cannot be due to normal residential activities," she asserted.

The ministry will continue monitoring and analyzing consumption data in other areas. It appreciated the cooperation of the Communications and Information Technology Regulatory Authority (CITRA) in monitoring Internet Protocol (IP) addresses involved in suspicious activities like cyber mining. It also commended the role of the Ministry of Interior in this regard. It then urged the public to use electricity properly and fully cooperate with its teams in addressing the problem.

# Judge extends detention of 3 Asians in cyberattack plot

KUWAIT CITY, April 23: The detention renewal judge has extended the detention of a Malaysian and two Chinese nationals accused of engaging in activities deemed harmful to the interests of Kuwait and using illegal communication networks to access a large amount of banking data through cyberattacks.

Investigations revealed that the suspects entered the country in coordination with others in China, from whom they received instructions to carry out cyberattacks targeting telecommunications towers by using specialized electronic devices. This enabled them to send an unlimited number of fraudulent messages to the users of these towers; thereby, illegally accessing banking data through their mobile phones.

The Public Prosecution has started interrogating two defendants who confessed to committing the crime.

The prosecution also ordered the seizure of the electronic devices used in the attacks and their referral to the Criminal Evidence General Department in the Ministry of Interior for technical examination. Investigations are still ongoing in order to complete the remaining procedures.

## Traffic violations drop 71% after revised law

KUWAIT CITY, April 23: The Ministry of Interior has succeeded in implementing the new Traffic Law, considering that citizens and expatriates appear to be more committed to respecting the law.

The ministry announced a 71 percent decrease in automatically recorded violations on the first day of the implementation of the new law.

As part of efforts to enhance traffic discipline and raise the level of road safety; statistics issued by the General Traffic Department in the ministry showed a remarkable decrease in the number of violations detected by automated cameras on Tuesday.

The statistics revealed that the number of violations decreased by 71 percent, compared to the violations recorded on April 15.

The violations include not wearing a seatbelt, using a mobile phone while driving, disregarding lane line signs and turning against traffic.

### Council to review key land requests

Meanwhile, the Power Plants Sector at the ministry on Tuesday dealt with a sudden fault in Steam Unit One at East Doha Power and Water Plant, which resulted in rising smoke.

Official spokesperson of the ministry Eng. Fatima Hayat stated that "at exactly 1:00 pm on Tuesday, heavy smoke was detected rising from Steam Unit One during its trial operation after the comprehensive maintenance. Kuwait Fire Force (KFF) immediately responded and took the necessary measures. The incident neither resulted in human injuries and material damages nor affected the operations and electricity generation at the plant."

Gradually turn off central air conditioning units in all buildings from 12:00 pm to 6:00 pm.

Turning off all central heaters.

■ Installing sensors in washrooms to reduce water consumption.

■ Maintaining solar-powered lighting

on the internal roads of the Ministries Complex building.

Maintaining solar-powered lighting in the eastern and southern parking lots and ensuring proper lighting sensors.

Reducing internal and external lighting in the Ministries Complex building and maintaining only emergency lighting.

Turning off all lighting units for agricultural ponds and farms.

Confirm that all office apparatus, such as computing devices, printing systems and similar equipment, are fully powered off at the end of the workday.

Concurrently, the Attendance, Vacation and Scholarships Monitoring Department has established revised schedules for designated segments of the ministry, and has instructed personnel to record their times of arrival and departure accordingly. These schedules are implemented through three operational modalities: rotational shifts. flexible hours and fixed hours.

In a similar speech, the French Ambassador Olivier Gauvin expressed his pleasure at participating in this cultural event, stressing that the cooperation between NCCAL and CEFREPA institutions reflects the depth of the friendship between the two countries.

He pointed to the partnership with the Council on numerous archaeological projects, including excavations on Failaka Island and the preservation of the Hellenistic castle.

He also noted a specialized training program in the study of historic buildings, which was launched with joint support, and the signing of a memorandum of understanding with the World Heritage Fund in preparation for nominating Kuwaiti sites for the World Heritage List.

The ambassador emphasized the continuation and development of cooperation in the fields of research and heritage preservation, praising the efforts of all teams working in this field.

Meanwhile, Director of the French

Center for Arabian Peninsula Research Dr. Makram Abbas said that this important conference coincides with the selection of Kuwait as the Arab Capital of Culture and Media 2025, which gives it a symbolic and cultural dimension.

He explained that cooperation with the National Council includes various fields such as archaeological excavations, heritage conservation, scientific publishing, training of specialists, and data measurement, in addition to cultural initiatives, including work to nominate the Failaka site for inclusion on the World Heritage List.

He added that the cooperation also includes the humanities, the study of manuscript heritage, and related issues of preservation, processing, and access to knowledge, stressing that these efforts pave the way for a deeper expansion of cultural activities.

### Manslaughter ...

■ Article 283: Any debtor who commits any of the following acts shall be punished by imprisonment for a period not exceeding three years and/or a fine not exceeding KD 5,000:

1. The debtor conceals, smuggles, transfers, or disposes of his assets, whether by traditional or electronic means, with the intent to avoid paying his debts established by an enforceable instrument.

2. The debtor acknowledges debts that are not due from him, or reduces his assets or rights due from third parties, with the intent to avoid paying his debts established by an enforceable instrument.

The criminal case shall lapse in its original state if the accused pays the debt, reaches a settlement with the creditor, or the creditor pardons him. If the payment, settlement, or pardon occurs after a final judgment convicting the debtor has been issued, the court that issued the judgment may order the suspension of the sentence upon the request of the convicted person.

- Article 284: The same penalty stipulated in the previous article shall apply to anyone who receives, possesses, or acquires funds from a debtor, either through traditional or electronic means, while being aware of the debt established by an enforceable instrument, and with the intent of enabling the debtor to evade repayment.

This provision does not apply to individuals under the debtor's guardianship or trusteeship.

The criminal case shall lapse in its original state if the debtor surrenders the funds to the enforcement department or a relevant investigative authority in preparation for debt recovery, in accordance with the rules governing creditor disputes.

If the funds are surrendered after a final judgment convicting the debtor has been issued, the court that issued the judgment may order a stay of execution of the sentence upon the convicted person's request.

The effects of debt payment, settlement, or pardon, stipulated in the previous article, shall also extend to any individual who received, possessed, or was transferred the debtor's funds. - Article 285: Any debtor who disposes of their assets or rights at a value significantly lower than the market or fair value, with the intent to evade the payment of debts established by an enforceable instrument, shall be punished by imprisonment for a period not exceeding two years and/or a fine not exceeding KD 3,000.

The effects of debt repayment, settlement, or pardon as stipulated in Article 283 shall also apply to the accused under this article.

- Article 286: The Public Prosecution shall have jurisdiction to investigate, take action on, and prosecute the crimes referred to in this clause.

Creditor rights are protected through legal measures in accordance with binding provisions, so that they do not negatively affect the debtor's entire family.

'Advisers don't get along with each other'

# As controversies pile up, US President Trump allies increasingly turn on one another

WASHINGTON, April 23, (AP): The infighting and backstabbing that plagued President Donald Trump's first term have returned as a threat to his second, with deepening fissures over trade, national security and questions of personal loyalty.

The latest turmoil threatens to engulf the Pentagon, where Defense Secretary Pete Hegseth has pushed out top advisers and faces fresh controversy over sharing sensitive information about airstrikes in Yemen outside of classified channels. A former Pentagon spokesperson who was ousted last week wrote in Politico that Trump should fire Hegseth for presiding over a "full-blown meltdown."

Hegseth lashed out on Tuesday on Fox News Channel, where he was a weekend host before joining Trump's administration, by faulting the people who used to work for him.

"Those folks who were leaking, who have been pushed out of the building, are now attempting to leak and sabotage the president's agenda," he said.

The interpersonal drama is not at least yet - a dominant plot line of Trump's return to the White House. But its reemergence after a period of relative discipline in his ranks reflects a turbulent management style that has

been suppressed or papered over, not reformed. Trump's national security team

was recently rattled by an Oval Office visit from Laura Loomer, a far-right conspiracy theorist who has been questioning his staff's trustworthi-ness. The Republican president fired some of the officials, emboldening Loomer to continue scrutinizing people across the administration.

In an interview with independent journalist Tara Palmeri released on Monday, Loomer mocked the idea that the White House is "one big happy family."

"The advisers don't get along with each other," she said. "The heads of agencies don't get along with each other."

Much of the tension is connected to Trump's determination to use tariffs to rebalance the global economy, with officials often contradicting each other and occasionally turning to insults. Trump adviser Elon Musk, the billionaire entrepreneur whose companies could suffer from higher costs brought on by import taxes, sharply criticized Peter Navarro, Trump's top counselor on trade, as "dumber than a sack of bricks."

White House press secretary Karoline Leavitt dismissed the idea of growing dissension within the admin-

istration, saying there are "far more examples of the president's team working together enthusiastically and collaboratively to advance the administration's goals.

"The numbers and results of this administration speak for themselves," she said. "The president and his team are getting work done.'

Trump has always had a high

tolerance for chaos, shunning traditional policy deliberations to entertain divergent opinions and viewing unpredictability as a negotiating tool. He's spent years fostering a competitive atmosphere among his staff members, who are often chosen for their devotion and penchant for aggression.

But now the increasing strife un-

derscores the risks for more turmoil in the months ahead, as Trump presses forward with a dramatic overhaul of the federal bureaucracy, international trade, foreign policy and more.

John Bolton, who served as national security adviser in Trump's first term before writing a tell-all book critical of the president's inner circle, said the drama reflects the lack of a consistent ideology and the inexperience of many administration officials.

"The only thing they have in common is the belief that they should show personal fealty to Trump," Bolton said. "That got them the job. That may in fact keep them in the job. But it shows how fundamentally unserious they are.'

The situation is a test for Susie Wiles, the White House chief of staff, who helped run Trump's presidential campaign last year. She earned a reputation for imposing an unusual level of order on Trump's chaotic orbit - though she carefully avoided trying to control Trump or his impulses - and he praised her as "the ice maiden.

During Trump's first term, he had four chiefs of staff - one of them serving in an acting capacity for more than a year. The second, former U.S. Marine Gen. John Kelly, became a sharp critic of the president after he left the job, describing him as a fascist during the 2024 election.

With his new administration, Trump has surrounded himself with loyalists, and he's been reluctant to throw anyone overboard in response to negative coverage from the mainstream media, which he considers to be an enemy. Allies say the hesitance to make personnel changes in this term is meant to deny giving a win to critics, even if it means leaving troubled officials in place.

On Monday, the president brushed off reports that Hegseth participated in a second group chat to talk about pending airstrikes in Yemen last month. The first chat, which used the encrypted messaging application Signal, involved top administration officials as well as the editor of The Atlantic, who was accidentally included in the discussion.

The second, first reported by The New York Times on Sunday, included Hegseth's wife, who does not have a government job, and his brother and his personal lawyer, both of whom work at the Pentagon.

"Same old stuff," Trump said when reporters questioned him about it during the White House Easter egg roll. He said Hegseth is "doing a great job" and "it's just fake news."

Evacuation orders lifted as fast-moving New Jersey wildfire burns

A fast-moving wildfire was burning in New Jersey's Pine Barrens, but officials on Wednesday lifted earlier evacuation orders and a stretch of a major highway that was closed due to the blaze has reopened.

More than 1,300 structures were threatened and about 3,000 residents had been evacuated, the New Jersey Forest Fire Service Officials said Wednesday said. morning that evacuation orders

were lifted. Shelters were open at two high schools, according to the Barnegat Police Department. The Garden State Parkway, one

of New Jersey's busiest highways, reopened Wednesday morning after officials closed a roughly 7-mile (12-kilometer) stretch in the southern part of the state. The fire service planned to give

an update at a news conference late Wednesday morning. Video released by the state agency overseeing the fire service showed billowing white and black clouds of smoke, intense flames engulfing pines and firefighters dousing a charred structure.

Forest fires are a common occurrence in the Pine Barrens, a 1.1 million-acre (445,000-hectare) state and federally protected reserve about the size of the Grand Canyon lying halfway between Philadelphia to the west and the Atlantic coast to the east. (AP)

### Qatar PM, Rubio discuss strategic partnership

WASHINGTON, April 23, (Agencies): Visiting Qatari Prime Minister and Foriegn Minister Mohammad Al-Thani and US Secretary of State Marco Rubio discussed regional and international issues, including situation in Gaza and Lebanon as well as other issues of common interest.

In a press statement on Tuesday, State Department Spokesperson Tammy Bruce pointed to the important strategic partnership between the United States and Qatar, including security and economic cooperation and shared efforts to address regional challenges in Gaza, Lebanon, and Syria.

Secretary Rubio also expressed gratitude for Qatar's efforts in securing the release of American citizens from Afghanistan, she added. Bruce affirmed that the two reiterated both countries' support for greater security and stability in the Middle East and emphasized the importance of increased collaboration on bilateral and regional issues.

She also mentioned that Deputy Secretary of State, Christopher Landau, met with Qatari Minister of State, Dr. Mohammad Al-Khulaifi, in Washington, D.C and discussed President Trump's upcoming trip to Qatar and the importance of building strong economic and commercial relationship.

Marco Rubio unveiled a massive overhaul of the State Department on Tuesday, with plans to reduce staff in the US by 15% while closing and consolidating more than 100 bureaus worldwide as part of the Trump administration's "America First" mandate.

The reorganization plan, announced by Rubio on social media and detailed in documents obtained by The Associated Press, is the latest effort by the White House to reimagine US foreign policy and scale back the size of the federal government.

The restructuring was driven in part by the need to find a new home for the remaining functions of the US Agency for International Development, an agency that Trump administration officials and billionaire ally Elon Musk's Department of Government Efficiency have dismantled.

## London talks on ending Russia-Ukraine war pared down as drone attack on bus kills nine

KYIV, Ukraine, April 23, (AP): A planned meeting Wednesday between top US, British, French and Ukrainian diplomats to push forward a peace deal between Russia and Ukraine was scrapped at the last minute, with US-Vice President JD Vance saying negotiations are reaching a moment of truth

"We've issued a very explicit proposal to both the Russians and the Ukrainians, and it's time for them to either say yes or for the United States to walk away from this process," Vance told reporters during a visit Wednesday to Agra, India.

He said it was "a very fair proposal" that would "freeze the territorial lines at some level close to where they are today," with both sides having to give up some territory they currently hold. He did not provide further details of the proposal.

Vance's comments came a day after Ukrainian President Volodymyr Zelenskyy ruled out ceding territory to Russia as part of any potential peace agreement, calling it a nonstarter. The Ukrainian leader spoke Tuesday in response to reports the Trump administration was proposing a deal that would allow Russia to keep occupied Ukrainian territory as part of a poten-

#### tial peace agreement.

UK Foreign Secretary David Lammy announced the talks in London to find an end to the more than three-year war would involve only lower-ranking officials after the US State Department said Tuesday that Secretary of State Marco Rubio was unable to attend because of a scheduling issue.

Rubio's abrupt cancelation raised

doubts about the direction of the negotiations.

Commenting on those attending the London talks, Kremlin spokesman Dmitry Peskov said that "as far as we understand, they so far have failed to bring their positions closer on some issues

He said the Kremlin was still in consultations with American officials but wouldn't publicly discuss details.

US special envoy Steve Witkoff is expected to visit Moscow again later this week, according to Russian officials.

Even achieving a limited, 30-day ceasefire has been beyond the reach of negotiators, as both sides have continued to attack each other in a grinding war of attrition along the 1,000-kilometer (620-mile) front line and launch long-range strikes.

A Russian drone struck a bus carrying workers in Marganets, in eastern Ukraine's Dnipropetrovsk region on Wednesday morning, killing eight women and one man, regional head Serhii Lysak wrote on his Telegram channel. More than 40 people were injured, he said.

Lysak published photos of a bus with its windows blown out and shards of glass mixed with blood spattered on the bus floor.

# Spain govt to meet NATO's defense spending goal of 2% of GDP this year

MADRID, April 23, (AP): Spain will meet NATO's defense spending target this year, Spanish Prime Minister Pedro Sánchez said Tuesday, as pressure grows on the eurozone's fourth-largest economy to boost its military expenditure.

Sánchez said the government will raise defense spending by 10.5 billion euros (\$12 billion) to reach NATO's target of 2% of GDP. The spending will go toward telecommunications, cybersecurity and buying military equipment, he said, as well as raising salaries and adding troops. Spain spent the least of all NATO

members last year on defense as a share of GDP. It previously committed to reaching the 2% target by 2029. But it has come under pressure for not spending enough amid a widening chasm in the transatlantic alliance as the Trump administration says its security priorities lie elsewhere.

UŠ President Donald Trump has repeatedly taken European allies to task for not spending enough on their own defense and has pushed NATO allies to raise defense spending to as much as 5% of GDP.

While European allies consider Trump's 5% target to be unrealistic, NATO leaders are expected to set a fresh

spending target at the military alliance's next summit this summer in The Hague. NATO Secretary General Mark Rutte has said the new goal should be "north of 3%. Facing what he called a "changing era," Sánchez on Tuesday said that it was time for Spain to "take control of our own destiny" and contribute to Europe's rearmament.

"If you asked me years ago about my government's investment priorities in security and defense, it's obvious my response would have been different," Sánchez said. "That's not because our values have changed ... it's because the world has."

The Socialist leader heads a minority government with hard-left coalition partners that oppose defense and military increases. Sánchez said his plan to boost defense spending would not go through Parliament.

### Macron brings new promises to cyclone-battered Mayotte

PARIS, April 23, (AP): Traditional songs and dances welcomed French President Emmanuel Macron when he arrived this week on the Indian Ocean territory of Mayotte - unlike his last visit, when he was greeted by furious, desperate residents reeling from a devastating cyclone.

But while daily life is improving, the impact of Cyclone Chido in December still dominated Macron's latest trip to this archipelago near Madagascar, the poorest corner of France. Mayotte's worst cyclone in a century killed dozens and left more than 2,000 injured, flattened homes and cut off power, communications and water supplies.

After a contentious visit in December, Macron was careful as he toured Mayotte on Monday. He brought new promises for reconstruction aid for the territory's 320,000 residents, and for a crackdown on illegal immigration. French authorities estimate another 100,000 migrants live in Mayotte, many in tin-roof shantytowns easily flatted by storms.

Electricity and telephone service have now been restored, and the drinking water network is functioning again

- though with intermittent outages because of chronic production shortages that often left Mayotte thirsty even before the cyclone.

- known for a centuries-old mosque considered the oldest operating in France - still come to their mayor for reconstruction help. Some homes still need roofs replaced, or to be entirely rebuilt.

Bridge collapses in Beijing: A bridge in Beijing's northeastern Shunyi district collapsed Wednesday morning after a fire broke out in its structure, according to authorities and images circulating on social media.

No casualties were reported on the bridge, which was already closed to traffic, the Beijing Municipal Commission of Transport wrote on the social media platform Weibo.

The Chaobai River Bridge was damaged after a fire broke out in the morning, the commission said. The fire was later put out, and authorities were investigating its cause

A person answering the phone at Shunyi District Emergency Bureau said they didn't have extra details about the incident.

Access to the bridge was shut down in both directions and traffic was rerouted. Videos circulating on social media showed plumes of gray smoke coming out of the sides of the bridge. Police cars were seen blocking access to the bridge with fire trucks nearby.

An eyewitness interviewed by China National Radio said he was fishing near the bridge around 4 am when the lights on the bridge suddenly went off. About 40 minutes later, smoke started coming out from under the bridge. The witness said he reported a fire to emergency services shortly afterward. (AP)

S.Korea successfully launches spy sat: South Korea successfully launched its fourth homegrown military spy satellite from a US space base in Florida, the Defense Ministry said Tuesday.

Yonhap News Agency reported that this came in efforts to strengthen its independent surveillance capabilities on North Korea.

A SpaceX Falcon 9 rocket, carrying the spy satellite, lifted off at 8:48 pm Monday (US time) from Cape Canaveral Space Force Station as planned and placed the satellite into orbit 15 minutes after liftoff, according to the ministry.

The launched satellite succeeded in communicating with an overseas ground station at 11:27 pm, indicating the satellite's normal operation.

"This is anticipated to reinforce the grouped operation of the satellites, alongside the three satellites in normal operation, and enhance capabilities to detect signs of North Korea's provocations," the ministry said. (KUNA)

### China, Azerbaijan establish strategic partnership

political confidence, deepen practical cooperation and promote international coordination between China and Azerbaijan to open a new chapter of bilateral relations, according to Xinhua news agency. He added that both countries have committed to mutual respect, justice, fairness and win-win cooperation and exchanged support in issues pertinent to their essential interests. But, Xi warned that tariff and trade wars under-

### Police hunt for perpetrators

# Indian troops beef up security in Kashmir following deadly attack on tourists

SRINAGAR, India, April 23, (AP): Security has been beefed up across Indiancontrolled Kashmir a day after an attack killed at least 26 people, most of them tourists, as Indian forces launched a manhunt for the perpetrators of one of the deadliest attacks in the restive Himalayan region.

As investigators began probing the attack, many shops and businesses in Kashmir closed to protest the killings following a call from the region's religious and political parties.

Tens of thousands of armed police and soldiers fanned out across the region and erected additional checkpoints. They searched cars and in some areas summoned former militants to police stations for questioning, reports said.

Police called the incident a "terror attack" and blamed militants fighting against Indian rule. The group's messages could not be independently verified. Earlier this month, the local government told its legislature that 83,742 non-

local Indians were granted domicile rights in Kashmir in the last two years.

Indian Prime Minister Narendra Modi cut short his two-day visit to Saudi Arabia and returned to New Delhi early Wednesday. Some Indian media and some commentators immediately blamed Islamabad for directing such attacks, while Pakistan extended condolences to the victims' families.

Officials said 24 of the people killed were Indian tourists, one was from Nepal and one was a local tourist guide. At least 17 others were injured.

Separately, soldiers killed two suspected militants in a gunfight after they tried to cross into Indian side from Pakistan-controlled Kashmir in northwestern Baramulla district along the heavily militarized Line of Control dividing the region, the Indian army said in a statement on Wednesday. There was no independent confirmation of the incident.

Kashmir has seen a spate of deadly attacks on Hindus, including immigrant workers from Indian states, since New Delhi ended the region's semi-autonomy in 2019 and drastically curbed dissent, civil liberties and media freedoms.

New Delhi has vigorously pushed tourism and the region has drawn millions of

visitors to its Himalayan foothills and exquisitely decorated houseboats. Officials have claimed that as a sign of normalcy returning, despite the presence of ubiquitous security checkpoints, armored vehicles and patrolling soldiers. Until Tuesday, tourists were not targeted.

Following the attack, panicked tourists started to leave Kashmir.

Monojit Debnath, from the Indian city of Kolkata, said Kashmir was undoubtedly beautiful but his family did not feel secure anymore.

"We are tourists, and we should think about what safety we have here for us," Debnath told the Press Trust of India news agency as he was leaving Srinagar, the region's main city, with his family.

"It's heartbreaking to see the exodus of our guests from the valley after yester-day's tragic terror attack," Omar Abdullah, the region's top elected official, wrote on social media. "But at the same time we totally understand why people would want to leave."

On Wednesday, India's powerful home minister Amit Shah attended a ceremony at a police control room in Srinagar, where the slain tourists were paid floral tributes. He also met families of several victims.

Shah vowed to "come down heavily on the perpetrators with the harshest consequences.

Later, Shah visited the site of the killing at Baisaran meadow, some 5 kilometers (3 miles) from the resort town of Pahalgam.

The meadow in Pahalgam is a popular destination, surrounded by snow-capped mountains and dotted with pine forests. It is visited by hundreds of tourists every day.

Meanwhile, security officials intensified operations to search for the attackers and the Indian army said in a statement that its efforts "focused on bringing the attackers to justice

The military used helicopters to search the forested mountains for signs of the attackers.

Nuclear-armed rivals India and Pakistan each administer a part of Kashmir but both claim the territory in its entirety.

Militants in the Indian-controlled portion of Kashmir have been fighting New Delhi's rule since 1989. Many Muslim Kashmiris support the rebels' goal of uniting the territory, either under Pakistani rule or as an independent country.

# Ivory Coast court removes ex-Credit Suisse CEO from presidential ballot

ABIDJAN, Ivory Coast, April 23, (AP): A court in Ivory Coast ruled on Tuesday that Tidjane Thiam, a former CEO of Credit Suisse, is not eligible to run for president because of his dual





Ivorian-French nationality, according to a lawyer representing him.

Thiam won his party's primary on Fridav in an uncontested vote and was widely seen as the main challenger to President Alassane Ouattara.

In a video posted to social media Tuesday night, Thiam vowed to fight this decision.

"I will not accept this disbarment because it is unjust, unjustified and incomprehensible," he said. "I am absolutely determined to fight so that Ivorians can freely choose their next president.'

The latest court case follows the rejection on April 16 of 10 similar appeals by the Independent Electoral Commission, also known by its French acronym CEI. Although deemed admissible, these cases were declared "ill-founded" by the electoral institution.

Speaking to The Associated Press following the decision, Me Ange Rodrigue Dadjé, one of Thiam's lawyers, said that "the president of the tribunal delivered her decision.'

"She considered that ... Thiam had lost his Ivorian nationality when he acquired French nationality (in 1987), and therefore granted the petitioners' requests and ordered ... Thiam's removal from the electoral roll," Dadjé said.

Thiam's lawyers didn't offer any challenge to the ruling.

Ivory Coast is set to hold the vote in October. Ouattara won in 2020 after a disputed election left dozens dead and opposition candidates boycotted the election.

DAKAR, Senegal: Police raids have rescued 33 West Africans from a human trafficking ring in Ivory Coast that lured people into paying fees and providing coerced labor by promising them jobs in Canada, the international police agency Interpol said Tuesday.

Victims paid as much as \$9,000 to supposed recruiters who instead trafficked them to the city of Abidjan in the Ivory Coast, where they were held under physical and psychological coercion, the agency said in a statement.

They also were forced to help scam others with the same promise of finding a job abroad by taking photos of themselves in upscale restaurants and hotels and posting them online as though they were in Canada. The traffickers allowed them limited contact with their families to maintain the illusion of living overseas.

## **Costa Rica to give migrants deported from** US permits to stay in country for 3 months

MEXICO CITY, April 23, (AP): Costa Rica announced Tuesday it will allow some of the approximately 200 migrants deported from the United States and held in detention in the Central American country to stay and move about freely for three months.

The move comes just days after human rights lawyers sued Costa Rica, alleging the government violated the rights of 81 migrant children by detaining them in a rural camp without any legal recourse, access to education or psychological services.

There was no immediate word how many migrants - who are mostly from Afghanistan, Russia, China, Pakistan, India and other countries - would be given the permits but the children are expected to be among those allowed to stay

The government said the permits would be given "for humanitarian reasons" and would last for three months while the migrants seek asylum in Costa Rica or look for ways to leave the country.

The migrants were deported to Panama and Costa Rica this year as the Trump administration sought to ramp up deportations. What was once said to be a temporary stay in Central America stretched on for months, fueling criticisms by rights groups as many of the deportees expressed fear over returning to their own countries.

Critics warned the US was exporting its deportation process and that Panama and Costa Rica were becoming a "black hole" for deportees.

Migrants, whose passports were previously confiscated and who were detained in a former factory turned migrant camp along the Panama-Costa Rica border, were told they could have their passports returned upon signing a document accepting the government's conditions, said Silvia Serna Roman, one of the attorneys that filed the lawsuit at the United Nations.

"It's a step in the right direction," the lawyer said. The Associated Press has repeatedly been denied access to the camp since the deportees arrived.


# Brazilian judges accept charges against more Bolsonaro allies in alleged coup plot

SAO PAULO, April 23, (AP): A panel of Brazil's Supreme Court justices unanimously accepted criminal charges Tuesdav against six more key allies of former President Jair Bolsonaro over an alleged coup plot to keep him in office after his 2022 election defeat.

Last month, the panel unanimously accepted charges against Bolsonaro and seven close allies over the alleged coup plot following his loss to current President Luiz Inácio Lula da Silva, and ordered the former right wing leader to stand trial.

When Prosecutor-General Paulo Gonet accused Bolsonaro and 33 others of attempting a coup, he divided them into five different groups, based on their roles and positions in the alleged plot.

Bolsonaro and his closest allies, including running mate Gen. Braga Netto, were placed in the "core group," according to the charges. On Tuesday, the Supreme Court panel reviewed charges against the second group, which Gonet said held managerial roles

The second group includes former presidential foreign affairs adviser Filipe Martins, retired Gen. Mario Fernandes, former Federal Highway Police director Silvinei Vasques, former presidential aide Col. Marcelo Câmara and two federal police officers, Fernando Oliveira and Marilia Alencar.

# El Salvador slams Venezuela's Maduro for rejecting prisoner swap proposal

SAN SALVADOR, El Salvador, April 23, (AP): The Salvadoran president on Tuesday criticized Venezuelan President Nicolás Maduro 's rejection of a swap that would see Venezuelan deportees from the United States detained in El Salvador exchanged for what he said were "political prisoners" in Venezuela.

Maduro has demanded the immediate release of 250 Venezuelans held in an El Salvador mega-prison built by Salvadoran President Navib Bukele to house gang members. Maduro claimed in his weekly televised address on Monday that "Bukele is a serial violator of the right to freedom, fair treatment, and human dignity

He urged that Bukele, instead of an exchange, sign "a decree granting unconditional freedom" to the deportees.

For his part, Bukele in a post on X on Tuesday goaded Maduro, asking wasn't the Venezuelan leader the one who said he'd do "whatever it takes" to secure the

release of the Venezuelans detained in El Salvador.

Bukele and Maduro's comments un-

derscore the two leaders' longstanding animosity, rooted in diametrically opposed political visions. While both governments have faced fierce democratic and human rights criticisms in recent years, Bukele has increasingly cozied up to U.S. President Donald Trump while right-wing figures have long held up Maduro as a example of democratic decay.

Among those Bukele wants set free by Maduro are the son-in-law of former Venezuelan presidential candidate Edmundo González, several political leaders seeking asylum in the Argentine Embassy in Venezuela, and what he said were 50 detained citizens from a number of different countries across the world.

In his initial proposal on Sunday, Bukele also listed the mother of Venezuela's opposition leader María Corina Machado, whose house remains allegedly surrounded by Venezuelan police since January.

# Al Sager: NBK not only overcomes challenges – It transforms them into opportunities for stronger, more sustainable future

KUWAIT CITY, April 23: Mr. Isam Al-Sager, Vice Chairman and Group CEO of National Bank of Kuwait (NBK), expressed unwavering confidence in the bank's ability to swiftly adapt to the evolving economic landscape, all while maintaining its leadership position in the local market.

On the sidelines of the analyst conference call for the first quarter of 2025, Al-Sager stated, "We not only overcome these challenges, but we seize them as opportunities to build a stronger and more sustainable future." He emphasized that NBK continues to enhance its flexibility, investment, and technology, all while maintaining a steadfast commitment to the highest quality standards in addressing the evolving needs of its customers.

He highlighted that NBK's regional and international presence remains a key factor in mitigating risks, stabilizing revenue, and improving operational efficiency. He further stressed that the Group's ongoing goal is to drive value and profitability by strengthening the integration of its businesses and expanding cross-selling opportunities across the various markets in which it operates.

Al-Sager emphasized that the Group's wealth management business will continue to leverage its extensive experience in delivering a comprehensive approach to portfolio management, advisory services, and investment opportunities. Meanwhile, its Islamic banking arm, represented by Boubyan Bank, will further reinforce NBK's distinctive position in the local market and play a pivotal role in diversifying its sources of profitability.

He attributed the 8.5% year-on-year decrease in the bank's net profit for the first three months of 2025 primarily to the introduction of the new Domestic Minimum Top-up Tax (DMTT), which took effect this quarter. This led to an increase in the effective tax rate to 16.3% in 1Q2025, compared to 9.2% in the corresponding period of 2024. He noted that,

excluding the impact of the new tax, pre-tax profit actually saw a 0.8% year-on-year increase, reaching KD 173.4 million in the first quarter of 2025

Al-Sager stated that the Group's returns remained robust despite the impact of the new tax system, with the return on average assets reaching 1.33% in the first quarter of 2025. Meanwhile, the return on average shareholders' equity stood at 13.1%. He also highlighted that the Group's loan portfolio is strategically allocated, with 70% originating from Kuwait and 30% generated through its international presence.

"NBK reaffirms its unwavering commitment to sustainability and advancing its sustainable financial agenda. The successful issuance of the first green bonds in 2024 stands as one of the bank's most significant achievements, attracting strong interest from international investors and reaffirming the market's confidence in our ESG strategy," Al-Sager added.

He highlighted that the bank continues to

make significant strides in integrating climaterelated standards into its operations, with a particular focus on reducing the carbon footprint of its investment portfolio and effectively managing climate risks. He noted that these efforts align with leading international standards, strengthening NBK's role as a key player in supporting Kuwait's commitment to achieving carbon neutrality, while also reflecting its crucial role in driving the transition toward a lowemission economy.

#### Kuwait's Economy

On the performance of the Kuwaiti economy, Al-Sager stated that despite the slowdown in macroeconomic activity in 2024, the nearterm growth outlook for 2025 remains optimistic. He attributed this positive outlook to several key factors, including the anticipated easing of voluntary production cuts by OPEC+, the gradual recovery of consumer spending, credit growth, the resurgence of momentum in project market activities, and the potential acceleration of public investment.

He explained that, supported by these factors, Kuwait's GDP is expected to grow by 3.0% in 2025.

Regarding the projects market, Al-Sager noted, "The market experienced some slowdown in the first quarter of 2025, following a strong year of activity in 2024. The value of projects awarded in the first quarter reached over KD 400 million. However, the outlook remains promising, with projects in preparation estimated to exceed KD 10 billion, reflecting the government's strong commitment to advancing its development and reform agenda at an accelerated pace"

As for the short-term outlook for oil prices, Al-Sager remarked that as the government continues to focus on implementing its development plan, oil price fluctuations have become less impactful on capital spending. He explained that this type of spending now accounts for less than 10% of the total government budget, reducing the likelihood of significant savings should oil revenues face pressure. He also noted that the first two years of capital spending will primarily focus on addressing infrastructure gaps, with the provision of basic services to meet population growth remaining a key priority He stated that the recently approved Financing and Liquidity Law provides the government

with greater flexibility in managing its financial resources, enabling the issuance of debt instruments worth up to KD 30 billion.

On the mortgage law, Al-Sager explained that several important meetings have recently been held to approve the law, including discussions with the Public Authority for Population Welfare to sign advisory service agreements with real estate developers. He indicated that the law is expected to be approved due to its strategic importance, particularly given the more than 100,000 pending housing applications and the growing population of Kuwaiti youth, which adds approximately 10,000 new applications annually.

Furthermore, Al-Sager emphasized that the banking sector's strong liquidity position strengthens its ability to play a key role in ad-dressing the housing problem in Kuwait. The GCC & The Global Economy

Al-Sager pointed out that, supported by robust fiscal reserves, ambitious economic reform programs, continued progress in major projects, and strong demand, the economies of the GCC are expected to maintain relatively strong performance in 2025. However, he cautioned that tightening global financial conditions could dampen investment and trade flows, increase financing costs, and potentially lead to a decline in demand, along with volatile oil prices.

Regarding the global economy, Al-Sager noted that it has recently navigated a complex environment marked by shifting monetary policies and escalating geopolitical tensions. He pointed out that the recent trade war and tariffs imposed by the US administration have cast a shadow over the economic landscape, potentially contributing to higher inflation rates and a slowdown in growth, further deepening the uncertainty surrounding the global economic outlook.

#### **Robust Operational Performance**

In the meantime, Mr. Sujit Ronghe, NBK Group Chief Financial Officer, stated that despite the impact of the new tax regime, the Group maintained strong operating performance in the first quarter of 2025, driven by significant growth in business activities, particularly in lending and investment. He high-

Ronghe emphasized that NBK Group's financial position remains robust, characterized by high levels of credit quality, strong capitalization, and the bank's ability to generate operating profits that enhance its capacity to absorb credit losses.

He further noted that the Group continues to leverage its unique advantage among Kuwaiti banks, particularly through its broad geographical presence via a network of overseas branches and subsidiaries, along with its ability to offer both conventional and Islamic banking services.

He highlighted that operating income during the first quarter of 2025 was distributed across key business segments, with overseas branches and subsidiaries contributing 26%, Islamic banking 22%, consumer banking 20%, corporate banking 12%, and NBK Wealth 9%.

Ronghe further explained that overseas branches and subsidiaries accounted for 27% of the Group's net profit during the first quarter of 2025, while Islamic banking contributed 19%, corporate banking 17%, consumer banking 16%, and NBK Wealth's contribution reached 10%

He also noted that IBG and Boubyan Bank collectively contributed 44% and 23%, respectively, to the Group's total assets, reinforcing the Group's strategy of diversifying its revenue sources.

Ronghe noted that the Group's loans and advances saw impressive growth during the first quarter of 2025, reaching KD 24.6 billion, reflecting a 9.9% increase compared to March 2024 and a 3.8% rise on a quarterly basis. This growth was driven by higher loan volumes in both Kuwait and international markets, across conventional and Islamic banking services.

He further pointed out that, amidst the prevailing economic uncertainty, loan growth in 2025 is expected to remain in the single-digit range. However, any improvement in global conditions, a faster pace of project implementation, or the approval of the mortgage law in Kuwait could significantly boost the growth of loan activities.

Regarding the recently implemented DMTT tax in Kuwait and its impact on the bank's prof-its for the current year, Ronghe stated: "The executive regulations of the law are expected to be issued within six months of its adoption. In the absence of detailed regulations at this stage, current estimates suggest that the effective tax rate for 2025 will range between 16% and 17% of pre-tax profits.

He pointed out that the net interest margin for the first quarter of 2025 was impacted, reaching 2.45%, due to an unfavorable shift in the asset mix, along with the annual effect of the depreciation of the Egyptian pound and the decline in historically high interest rates. However, the recent approval of the Finance and Liquidity Law in Kuwait boosts expectations for the upcoming issuance of sovereign debt instruments this year, which will allow the bank to repurpose liquidity into interest-bearing assets.

He emphasized the bank's capacity to provide the necessary financing for development projects currently in the pipelines, supported by its diversified and stable financing base, which aligns with NBK's strategy for sustainable growth.

Regarding his outlook for the operating environment, Ronghe stated: "Despite the prevailing uncertainty in the economic landscape, we

lighted that the operating income mix remains well-balanced, with non-interest income comprising 24% of total revenue sources.

remain cautiously optimistic that the overall operating environment, although challenging, stabilize in due course during 2025".

TOKYO, April 23, (AP): Global shares mostly rose Wednesday, with markets showing relief after President Donald Trump indicated he won't dismiss the head of the U.S. Federal Reserve.

France's CAC 40 jumped 2.1%

in early trading to 7,480.99, while Germany's DAX rose 2.5% to 21,820.14. Britain's FTSE 100 gained 1.6% to 8,461.24. U.S. shares were set to drift higher with Dow futures up 1.5% at 39,960.00. S&P 500 futures rose 2.0% to 5,421.75.

In Asia, Japan's benchmark Nikkei 225 gained 1.9% to finish at 34,868.63. Australia's S&P/ASX

200 surged 1.3% to 7,920.50. South Korea's Kospi gained 1.6% to 2,525.56. Hong Kong's Hang Seng added 2.4% to 222,072.62, while the Shanghai Composite edged down 0.1% to 3,296.36.

Trump had previously said he could fire Fed chair Jerome Powell after the Fed paused cuts to short-term interest rates. But Trump told reporters Tuesday, "I have no intention of firing him.

Investors were also cheered by comments from U.S. Treasury Secretary Scott Bessent in a Tuesday speech. He said the ongoing tariffs showdown with China is unsustainable and he expects a "de-escalation" in the trade

war. "Of course, markets will continue to listen out for the latest White House rhetoric on tariffs and any hints of upcoming trade deals.

### Why is China not afraid of a tariff war? Here are the reasons and facts

THE US tariff policy recently sparked global controversy, due to the United States imposing unusually high tariffs on China.

China has made it clear that it does not seek to engage in any tariff or trade war. However, it has also emphasized that it is not afraid of such a war. In this context, I would like to explain to our Ku-

waiti friends why China is not afraid of a tariff war. The solid foundations and pillars of China's economic development:

China is the only country in the world that possesses all the industrial categories listed in the United Nations Industrial Classification. This gives China a manufacturing advantage that other countries cannot easily match in the short term.

Relying on its well-established supply chains, Tesla's Shanghai factory has an annual produc-tion capacity of 950,000 vehicles, nearly half of Tesla's global production.

China's strong economic resilience:

In 2024, total retail sales of consumer goods in China reached 48.8 trillion yuan (approximately 2.05 trillion Kuwaiti dinars), with consumption contributing 44.5 percent to economic growth. Domestic consumption, rather than exports, is now the primary driver of the Chinese economy.

China's foreign trade structure is steadily improving, and its exports to the United States account for only 14.7 percent of its total exports.

In the first quarter of 2025, China's GDP grew

by 5.4 percent, which showcased the resilience and strength of the Chinese economy. China is a staunch advocate of international fair-

ness and justice. It prioritizes the common interests of all nations. Committed to promoting high-level opening-up,

China shares its opportunities with the world. It has become a major trading partner for over 150 countries and regions, and has signed more than 20 free trade agreements with over 30 nations and re-

gions On December 1, 2024, China granted zero tariffs on the goods of 43 least developed countries (LDCs) with diplomatic relations, resulting in an 18.1 percent increase in their Zhang Jianwei exports to China.

In contrast, the United States uses tariffs as a weapon for exerting maximum pressure and pursuing its own interests. This action seriously infringes on the legitimate rights and interests of other countries, flagrantly violates WTO rules, and severely damages the rules-based multilateral trading system. It also destabilizes the global economic order, going against the interests of the entire world.

China, however, has taken the necessary measures to not only protect its own interests but also defend international justice, fairness, and the common interests of all countries. The US tariff policy harms others rather than benefiting itself. In today's highly integrated global industrial and supply chains, imposing high tariffs disrupts these networks, reduces the efficiency of various industries, and negatively impacts the economic development of all countries. The US's imposition of tariffs and its isolation-

ist policies will harm its cooperation with other countries and weaken the foundations of international collaboration. Its decisions have faced strong opposition and countermeasures from many countries, including its own allies.

Research conducted by the US-China Business Council shows that the first trade war launched by the United States against China in 2018 resulted in the loss of 245,000 jobs in the US. After the US announced a new tariff policy in early April 2025, former US Treasury Secretary Lawrence Summers warned that it could lead to losses of \$30 trillion. Also, JPMorgan raised the probability of a global recession to 60 percent. There is a Chinese proverb, "When the sun sets

in the east, the west rises."

China's economy is closely integrated with the economies of the Gulf Cooperation Council (GCC) countries, including Kuwait.

As the largest trading partner of the GCC, China is ready to collaborate with the GCC to expedite the completion of Free Trade Agreement negotiations and jointly promote the development of economic and trade cooperation between China, the GCC, and Arab countries.

China is also committed to strengthening practical cooperation with Kuwait, guided by the important consensus reached by the leaders of the two friendly countries, for the benefit of both the Kuwaiti and Chinese peoples.

"Some of you might know Tina Knowles as the mother of a superstar - as in Beyoncé - but she is also a highly success-ful entrepreneur, fashion designer, philanthropist, and now author of this fascinating memoir of her journey to become the global figure she is today," Winfrey said in a statement. "We learn how the strength and wisdom of the women who came before her fueled Tina's passion to achieve and gave her the ability to nurture her own daughters into the incredible women they are today.

Winfrey likes to surprise her book club choices when she tells them the news, sometimes even popping up during a Zoom conversation. Knowles said in a statement that she had been told that a printing company was on the phone, only to find herself speaking with Winfrey. She later told The Associated Press, during an interview Tuesday, that Winfrey's endorsement was "like a dream come true. I mean, that's the ultimate."

She also recalled appearing in 2002 on Winfrey's talk show, when Knowles was interviewed with her daughter and other members of Destiny's Child. Winfrey had insisted she join the conversation.

"I was like in the back with hair uncombed, no makeup. And I was like 'Oh god, no!'" she told the AP, remembering how frightened she was to go on camera. "But I came out, and it was my first time actually on a major show like that. I mean, my voice was shaking. I was so nervous, but you know, it got me past that fear.'

younger selves brought out the same in me. The book split into two, the first one being a personal memoir. The second one will come out next year, with a lot of new interview material."

Crowe, 67, is known for such films as "Jerry Magu-"Singles" and "Almost Famous," a fictionalized take ire.' on his years in the 1970s as a teen contributor to Rolling Stone that brought him an Academy Award for best original screenplay. Crowe is also the author of "Conver-sations with Wilder," a book of interviews with director Billy Wilder.

According to Avid Reader, a Simon & Schuster imprint, Crowe's memoir will offer "a front-row ticket to the 1970s.

"He spends his teens dodging bouncers and turning down cocaine from roadies and rock stars," the publisher's state-ment reads in part. "He talks his San Diego City College journalism teacher into giving him class credit for his road trip covering Led Zeppelin's 1975 tour, which lands him - and the band - on the front cover of Rolling Stone. He embeds with publicity-shy David Bowie for eighteen months as the sequestered genius transforms himself: 'Young enough to be honest!' Bowie declares of Crowe."

# **Harvey Weinstein's** retrial opens in NY

NEW YORK, April 23, (AP): Five years after Harvey Weinstein's original #MeToo trial delivered a searing reckoning for one of Hollywood's most powerful figures, the ex-studio boss is on trial again after an appeals court threw out the landmark rape conviction.

Opening statements are set for Wednesday in a trial that could take six weeks.

It's happening at the same Manhattan courthouse as his first trial, and two accusers who testified then are expected to return.

But Weinstein's retrial is playing out at a differ-ent cultural moment than the first, which happened during the height of the #MeToo movement. And along with the charges being retried, he faces an additional allegation from a woman who wasn't involved in the first case.

The jury counts seven women and five men - unlike the seven-man, five-woman panel that convict-ed him in 2020 - and there's a different judge.

The #MeToo movement, which exploded in 2017 with allegations against Weinstein, has also evolved and ebbed

At the start of Weinstein's first trial, chants of "rapist" could be heard from protesters outside.

TV trucks lined the street, and reporters queued for hours to get a seat in the packed courtroom. His lawyers decried the "carnival-like atmosphere" and fought unsuccessfully to get the trial moved from Manhattan.

This time though, over five days of jury selection, there was none of that.

Testimony Those realities, coupled with the New York Court Film



of Appeals' ruling last year vacating his 2020 conviction and 23-year prison sentence - because the judge allowed testimony about allegations Weinstein was not charged with - are shaping everything from retrial legal strategy to the atmosphere in court.

Weinstein, 73, is being retried on charges stemming from alleged assaults involving two women: a movie and TV production assistant, Miriam Haley, in 2006, and an aspiring actor, Jessica Mann, in a Manhattan hotel room in 2013.

Weinstein also faces a criminal charge related to an alleged incident involving a woman at a Manhattan hotel in 2006. Prosecutors stated that the woman, who has not been publicly identified, came forward shortly before his first trial but was not included in that case. They revisited her claims after his previous conviction was overturned.

The Associated Press does not generally identify people alleging sexual assault unless they consent to be named, as Haley and Mann have done.

Weinstein has pleaded not guilty and denies raping or sexually assaulting anyone. His acquittals on the two most serious charges at his 2020 trial predatory sexual assault and first-degree rape - still stand

Lindsay Goldbrum, a lawyer for the unnamed accuser, said Weinstein's retrial marks a "pivotal moment in the fight for accountability in sex abuse cases" and a "signal to other survivors that the system is catching up - and that it's worth speaking out even when the odds seem insurmountable.

This time around, the Manhattan district attorney's office is prosecuting Weinstein through its Special Victims Division, which specializes in such cases, after homicide veterans helmed the 2020 version. At the same time, Weinstein has added several lawyers to his defense team - including Jennifer Bonjean, who is involved in appealing his 2022 rape conviction in Los Angeles. She helped Bill Cosby get his conviction overturned and defended R. Kelly in his sex crimes case.

"This trial is not going to be all about #MeToo. It's going to be about the facts of what took place,' Weinstein's lead attorney, Arthur Aidala, said recently. "And that's a big deal. And that's the way it's supposed to be.'

### Ben Affleck returns as a dangerous CPA

# 'Accountant 2' isn't quite a write-off

LOS ANGELES, April 23, (AP): Hordes of horror films line up for Halloween and a sleigh full of Christmas movies arrive annually in December, but there is slightly less competition around the paper-pushing rite of Tax Day.

Yet on the heels of tax season, here is "The Accountant 2," Gavin O'Connor's sequel to the 2016 film that did not, exactly, leave audiences clamoring for another. But in a movie world where anything successful immediately gets a second one, "The Accountant 2" has the benefit of not having much to live up to. Just balancing the books a little would count as a win for "The Accountant 2."

And by the low standards of the original, O'Connor's film, an untidy thriller about a fastidious CPA (Ben Affleck) whose powers of deduction are enhanced by his autism, just succeeds at punching up the numbers for "The Accountant" in this belated follow-up.

It's a role that was always an odd fit for Affleck. In a way, that's the intention. Affleck's Christian Wolff is a monotone bean counter who used to help criminal organizations launder money and clean their books. Now, he's a combination of stickler and vigilante whose insight into tax filings and other paper trails helps him hunt down any clue. The best scene in "The Accountant 2" might be when he exposes a human trafficking scheme at a pizza company by rapidly calculating a dubious gap of underreported pizza box expenses. (There, if ever, is a reason to keep your receipts.)

Affleck, of course, has always been a more garrulous, charismatic screen presence. The role of savant wasn't for him; it was for his "Good Will Hunting" co-star, Matt Damon. Here, though, he's an emotionless android who speaks in clipped sentences and avoids eye contact. And while the "Rain Man" shtick of "The Accountant" always feels forced, you can tell Affleck is enjoying himself.

In "The Accountant 2," that's most true when he's paired up with Jon Bernthal. He plays Wolff's more outgoing and freewheeling brother, Braxton, who has a knack for bloody mayhem but harbors hurt feelings from his brother's distance in recent years. The two make a fine action duo of opposites. The problem? It takes a long time in Bill Dubuque's unhurried and disordered script to get to them.

#### Message

The movie begins with a set piece of misdirection that adds to the muddled nature of the first act. Retired FBI financial crimes boss Raymond King (J.K. Simmons) is meeting someone at a restaurant who might help in his search for a family of Central American refugees. It's a hit job, though, with snipers in position, and a separate, mysterious assassin (Daniella Pineda) lurking about. The scene ends with King's body taken out with a message he's written on his forearm: "Find the accountant."

Marybeth Medina (Cynthia Addai-Robinson), King's former protege and financial crimes deputy, takes up the case. She knows enough about Wolff to know how to summon him - not with a Bat signal, exactly, but by phoning a neurological research center in New England and leaving a message with a receptionist.

Wolff is living contentedly out of an Airstream RV, with an office back at the research center full of young autistic computer hackers. The scenes here are clunky and don't always move the story along - there's an aimless but moderately funny one of Wolff speed dating. But once Braxton shows up - another awkward and labored character introduction, by way of a "Wizard of Oz" surrounded by dead bodies - "The Accountant 2" clicks into idiosyncratic place.

What that place "The Accountant 2" occupies probably wouldn't stand up to scrutiny, let alone an audit. For a movie about a detail obsessive, it's curiously messy. But - and this might matter more - the film has a reasonably firm sense of just how serious and how knowingly silly a movie about an uber-talented accountant ought to be.

There is also just a wisp of real-life relevancy. By centering an accountant thriller on the fate of a migrant family, "The Accountant 2" might even be said to be timely. The Trump administration is in the midst of cutting IRS employees, some of whom, including acting commissioner Melanie Krause, have resigned in part over a decision to use IRS data to help deport undocumented immigrants. For departing IRS workers, "The Accountant 2"

might just be the most cathartic movie of the year. "The Accountant 2," an Amazon MGM Studios release that opens in theaters Thursday, is rated R by the Motion Picture Association for strong violence, and language throughout. Running time: 125 minutes. Two and a half stars out of four.

Even though he called countless college football and basketball games, he is best known for his work on ESPN's "Sunday Night Football" from 1987 through 2005.

NBC took over the Sunday night package in 2006 when ESPN became the home of "Monday Night Football.

Dick Vitale called Patrick "Mr. ACC" because of his love for doing big games from the conference.

"Mike had great energy and a keen knowledge of ACC basketball, and I truly enjoyed sitting next to him calling so many special games over the years," Vitale said in a statement.

# Jury finds The New York Times did not libel Sarah Palin

NEW YORK, April 23, (AP): The New York Times did not libel former Alaska Gov. Sarah Palin in a 2017 editorial that contained an error she claimed had damaged her reputation, a jury concluded Tuesday.

The jury deliberated a little over two hours before reaching its verdict. A judge and a different jury had reached the same conclusion about Palin's defamation claims in 2022, but her lawsuit was revived by an appeals court.

Palin was subdued as she left the courthouse and made her way to a waiting car, telling reporters: "I get to go home to a beautiful family of five kids and grandkids and a beautiful property and get on with life. And that's nice."

Later, she posted on the social platform X that she planned to "keep asking the press to quit making things up.

Danielle Rhoades Ha, a Times spokesperson, said in a statement that the verdict "reaffirms an important tenet of American law: publishers are not liable for honest mistakes.

Palin, who earned a journalism degree in college, sued the Times for unspecified damages in 2017, about a decade after she burst onto the national stage as the Republican vice presidential nominee.

Her lawsuit stemmed from an editorial about gun control published after US Rep. Steve Scalise, a Louisiana Republican, was wounded in 2017 when a man with a history of anti-GOP activity opened fire on a Congressional

baseball team practice in Washington.

In the editorial, the Times wrote that before the 2011 mass shooting in Arizona that severely wounded former US Rep. Gabby Giffords and killed six others, Palin's political action committee had contributed to an atmosphere of violence by circulating a map of electoral districts that put Giffords and 19 other Democrats under stylized crosshairs

The Times corrected the article less than 14 hours after it was published, saying it had "incorrectly stated that a link existed between political rhetoric and the 2011 shooting" and that it had "incorrectly described" the map.

During the trial, former Times editorial page editor James Bennet tearfully apologized to Palin, saying he was tormented by the error and worked urgently to correct it after readers complained to the newspaper.

Palin testified Monday that death threats against her increased and her spirits fell after the editorial was published.

In his closing argument Tuesday, Palin's attorney, Kenneth Turkel, had urged the jury to find the Times liable for defamation on the grounds that Bennet either knew what he was publishing was wrong or acted with "reckless disregard" for the truth.

He asked the jury to award Palin compensatory damages for the harm done to her reputation and private mental anguish, adding that they should "find a number and let her get some closure to this thing."

"To this day, there's been no accountability," he said. "That's why we're here.

He told jurors not to be deceived by Palin's "bouncy"

persona on the witness stand.

"She doesn't cry a lot," Turkel said. "It may have been to them an honest mistake. For her, it was a life changer."

Felicia Ellsworth, an attorney for the Times, told jurors in her closing that there was not "one shred of evidence showing anything other than an honest mistake.3

Ellsworth said Bennet and the Times "corrected the record loudly, clearly and quickly" once the error was discovered.

The lawyer pointed out that several Times editors testified consistently about the effort to correct the error and the importance they placed on accuracy while Palin's claims were "supported by nothing other than her say so."

"To Gov. Palin, this is just another opportunity to take on fake news. To James Bennet, the truth matters," Ellsworth said.

In February 2022, Judge Jed S. Rakoff rejected Palin's claims in a ruling issued while a jury deliberated. The judge then let jurors deliver their verdict, which also went against Palin.

The 2nd U.S. Circuit Court of Appeals in Manhattan restored the case last year

The appeals court said Rakoff's dismissal ruling improperly intruded on the jury's work. It also cited flaws in the trial, saying there was erroneous exclusion of evidence, an inaccurate jury instruction and a mistaken response to a question from the jury.

# Judge blocks VOA closure

WASHINGTON, April 23, (AP): A fed-eral judge agreed Tuesday to block the Trump administration from dismantling Voice of America, the 83-year-old international news service created by Congress

US District Judge Royce Lamberth ruled that the administration illegally required Voice of America to cease operations for the first time since its World War II-era inception.

Attorneys for Voice of America employees and contractors asked the judge



to restore its ability to broadcast at the same level before President Donald Trump moved to slash its funding. Lamberth agreed, ordering the administration to restore Voice of America and


mostly two of the independent broadcast

networks operated by the US Agency for Global Media - Radio Free Asia and Middle East Broadcasting Networks until the lawsuits are settled.

The judge denied the request for two other independent networks, Radio Free Europe/Radio Liberty and Open Technology Fund.

In a March 26 court filing, plaintiffs' attorneys said nearly all 1,300 of Voice of America's employees were placed on administrative leave, while 500 contractors were told that their contracts would he terminated at the end of last mor





## **Push to pardon** singer Jelly Roll

Tour ahead

NASHVILLE, Tenn., April 23, (AP): The Tennessee Board of Parole on Tuesday recommended a pardon for country music star Jelly Roll, a Nashville native who has spoken openly about his criminal record and what it has taken to overcome it. The board's action leaves the final decision on a pardon up to Gov. Bill Lee.

The rapper-turned-country singer wants to be able to travel internationally to perform and share his message of redemption, after spending time behind bars as a young person.

The board issued its nonbinding recommendation unanimously after a hear-ing that lasted about an hour and 45 minutes with several witnesses, including Nashville Sheriff Daron Hall, advocating for the 40-year-old musician named Ja-son DeFord. One board member recused themselves from voting.

Jelly Roll broke into country music with the 2023 album "Whitsitt Chapel" and crossover songs like "Need a Favor." He has won multiple CMT Awards, a CMA Award and earned four Grammy nominations, including for new artist of the year. "This was incredible," he said of the

board's decision. "I pray this goes through. But today was special for me, regardless."

His most serious convictions include a robbery at age 17 and drug charges at 23. In the first case, a female acquaintance helped Jelly Roll and two other young men enter a house in 2002. Both of the others were carrying guns, although Jelly Roll was unarmed. They demanded money, and received \$350 and a wallet with no money in it. Because the victims knew the female acquaintance, she and Jelly Roll were arrested right away. He was enced to serve a year in prison and additional time on probation.

The US Agency for Global Media, which runs Voice of America, has operated other broadcast outlets, including Radio Free Europe/Radio Liberty, Radio Free Asia and Radio Free Afghanistan. Congress has appropriated nearly \$860 million for the Agency for Global Media for the current fiscal year.

#### Funding

Voice of America went dark soon after Trump issued an executive order on March 14 that pared funding to the Agency for Global Media and six other unrelated federal entities. It also moved to terminate VOA contracts with news agencies, including The Associated Press.

Voice of America has operated since World War II, beaming news into authoritarian countries that don't have a free press. It began as a counterpoint to Nazi propaganda and played a prominent role in the US government's Cold War efforts to curb the spread of communism.

Trump and his Republican allies have accused Voice of America of having a "leftist bias" and failing to project "pro-American" values to its audience.

Plaintiffs' attorneys say it reports and broadcasts the news "truthfully, impartially, and objectively.

"That simple mission is a powerful one for those living across the globe without access to a free press and without the ability to otherwise discern what is truly happening," they wrote.

Government attorneys argued that the plaintiffs failed to show how they have been irreparably harmed.

"Rather, Plaintiffs take aim at what is best described as a temporary pause on its activities while Global Media determines how to bring Voice of America into compliance with the President's directive," they wrote.

The Agency for Global Media's leadership includes special adviser Kari Lake, a former TV news anchor and political candidate.

In his written ruling, Lamberth noted that the US Agency for Global Media never finalized its grant agreement with Radio Free Europe/Radio Liberty for the current fiscal year, and the Open Technology Fund withdrew its legal request for a temporary restraining order earlier this year.

Radio Free Asia and Middle East Broadcasting Networks do have current grant agreements in place, and like Voice of America, are funded by Congressional appropriations.

Lamberth said the funding cuts "reflect a hasty, indiscriminate approach" - particularly since they were made the same day that President Trump signed the congressional appropriation that funded Voice of America and the networks through September of this year.

Not only is there an absence of "reasoned analysis" from the defendants; there is an absence of any analysis whatsoever," Lamberth said.

# Elordi walks a 'Narrow Road' of war, love

BERLIN, April 23, (AP): Jacob Elordi is gearing up for another busy year.

He'll soon be seen in Guillermo del Toro's much-anticipated "Frankenstein" and is currently filming Emerald Fennell's "Wuthering Heights. But during a recent interview in Berlin, Elordi, complete with wild curly Heathcliff hair and sideburns, had his TV series "The Narrow Road to the Deep North" on the mind.

Fellow Australian Justin Kurzel directs the adaptation of Richard Flanagan's Man-Booker prizewinning novel of the same name, which tells the story of medical officer Dorrigo Evans (Elordi). Evans was forced to work on the Thai-Burma railway in the jungle of a Japanese prisoner of war camp during World War II.

Kurzel and Flanagan are friends from Tasmania, where they both live, and celebrated in London together when Flanagan won the esteemed literary award. But in true Australian style, the idea for the TV series came from a chat back home at a barbeque, Kurzel says with a chuckle.

Fittingly, "The Narrow Road to the Deep North" is showing on Prime Video in Australia, the US, Canada and New Zealand before reaching Sky and WOW in Germany this summer.

The story spans three different timelines - pre-, during and post-war - and three different points of view, which start to merge and overlap as the story unfolds.

Although the series is about the courage and horrors of war, a love story is at its heart. Through his ordeal, the married Dorrigo is both sustained and tormented by memories of a love affair he had with

his uncle's wife Amy, his one true love, played by Odessa Young.

While Kurzel describes the romance as "the absolute spirit of the whole series," Elordi admits he was initially "pretty frightened" about bringing it to the screen.

"I was worried that it would kind of overtake the elements of the novel that kind of interested me, which was the war parts," says Elordi.

But the way Kurzel shot and directed those scenes prompted a change of heart.

"He allowed us this space for it to be incredibly raw and real and gentle and it ended up becoming my sort of favorite part of the filmmaking process because we shot it in halves."

#### Cautious

Kurzel says he had never done a love story and was "extremely careful and cautious and fiercely curious about what that would be with Jacob and Odessa.

With the love story shot first, Elordi, who had a major year in 2023 after starring as Elvis Presley in "Priscilla" and Fennell's "Saltburn," adds he was better able to shape his portrayal of the haunted Dorrigo, when it came time to film the Japanese POW scenes.

"Being able to have those memories while we were shooting the camps, of shooting with Dess (Odessa Young) and Olivia (DeJonge), was a core part of the performance, which goes back to Richard's book. The two just inform each other, like it's a whole life.

Casting Elordi was easy for Kurzel who said he

"knew right away" that he was right for the role but adds that a special dedication and focus was needed from all the actors cast as soldiers, as they underwent dramatic weight loss to play prisoners of war.

### Move to ban synthetic dyes aims to protect kids

# US plans to phase out artificial dyes from food supply

WASHINGTON, April 23, (AP): US health officials on Tuesday said they would urge food makers to phase out petroleum-based artificial colors in the nation's food supply, but stopped short of promising a formal ban and offered few specifics on how they intended to achieve the sweeping change

Food and Drug Administration Commissioner Marty Ma-kary said at a news conference that the agency would take steps to eliminate the synthetic dyes by the end of 2026, largely by relying on voluntary efforts from the food industry. Health Secretary Robert F. Kennedy Jr., who joined the gathering, said he had heard from food manufacturers, but had no formal agreements with them.

"We don't have an agreement, we have an understanding," Kennedy said.

The officials said the FDA would establish a standard and timeline for industry to switch to natural alternatives, revoke authorization for dyes not in production within coming weeks and take action to remove remaining dyes on the market.

"Today, the FDA is asking food companies to substitute petrochemical dyes with natural ingredients for American children as they already do in Europe and Canada," Makary

The proposed move is aimed at boosting children's health, he added.

"For the last 50 years we have been running one of the largest uncontrolled scientific experiments in the world on our nation's children without their consent," he said.

The process to revoke approved additives from the food supply typically takes several years and requires public comment, agency review and final rulemaking procedures.

Industry groups said that the chemicals are safe and suggested they would try to negotiate with regulators to keep them available.

"FDA and regulatory bodies around the world have deemed our products and ingredients safe, and we look forward to working with the Trump Administration and Congress on this issue," said Christopher Gindlesperger, spokes-man for the National Confectioners Association. "We are in firm agreement that science-based evaluation of food additives will help eliminate consumer confusion and rebuild trust in our national food safety system.'

Health advocates have long called for the removal of artificial dyes from foods, citing mixed studies indicating they can cause neurobehavioral problems, including hyperactivity and attention issues, in some children. The FDA has maintained that the approved dyes are safe and that "the totality of scientific evidence shows that most children have no adverse effects when consuming foods containing color additives.'

The FDA currently allows 36 food color additives, including eight synthetic dyes. In January, the agency announced that the dye known as Red 3 - used in candies, cakes and some medications - would be banned in food by 2027 because it caused cancer in laboratory rats

Artificial dyes are used widely in U.S. foods. In Canada and in Europe - where synthetic colors are required to carry warning labels - manufacturers mostly use natural substitutes. Several states, including California and West Virginia, have passed laws restricting the use of artificial colors in foods.

The announcement drew praise from advocates who say the dyes carry health risks and serve no purpose beyond the cosmetic.

"Their only purpose is to make food companies money," said Dr. Peter Lurie, president of the Center for Science in the Public Interest and a former FDA official. "Food dyes help make ultraprocessed foods more attractive, especially to children, often by masking the absence of a colorful ingredient, like fruit.

Removing artificial dyes from foods has long been a goal of so-called MAHA moms, key supporters of Kennedy and his "Make America Healthy Again" initiatives. They were among protesters who signed petitions and rallied outside the Michigan headquarters of WK Kellogg Co. last year, demanding that the company remove artificial dyes from its breakfast cereals in the US.

Health officials insisted that food-makers wanted clarity on the issue and were receptive to the changes, but the response from industry groups was mixed.

### Scientists warn of permanent coral damage

# 84% of coral reefs hit by worst bleaching

NEW YORK, April 23, (AP): Harmful bleaching of the world's coral has grown to include 84% of the ocean's reefs in the most intense event of its kind in recorded history, the International Coral Reef Initiative announced Wednesday

It's the fourth global bleaching event since 1998, and has now surpassed bleaching from 2014-17 that hit some two-thirds of reefs, said the ICRI, a mix of more than 100 governments, non-governmental organizations and others. And it's not clear when the current crisis, which began in 2023 and is blamed on warming oceans, will end.

"We may never see the heat stress that causes bleaching dropping below the threshold that triggers a global event," said Mark Eakin, executive secretary for the International Coral Reef Society and retired coral monitoring chief for the US National Oceanic and Atmospheric Administration.

"We're looking at something that's completely changing the face of our planet and the ability of our oceans to sustain lives and livelihoods," Eakin said

Last year was Earth's hottest year on record, and much of that is going into oceans. The average annual sea surface

cause they support high levels of biodiversity - approximately 25% of all marine species can be found in, on and around coral reefs.

Coral get their bright colors from the colorful algae that live inside them and are a food source for the corals. Prolonged warmth causes the algae to release toxic compounds, and the coral eject them. A stark white skeleton is left behind, and the weakened coral is at heightened risk of dying.

The bleaching event has been so severe that NOAA's Coral Reef Watch program has had to add levels to its bleaching alert scale to account for the growing risk of coral death.

Efforts are underway to conserve and restore coral. One Dutch lab has worked with coral fragments, including some taken from off the coast of the Seychelles, to propagate them in a zoo so that they might be used someday to repopulate wild coral reefs if needed. Other projects, including one off Florida, have worked to rescue corals endangered by high heat and nurse them back to health before returning them to the ocean.

But scientists say it's essential to reduce greenhouse gas emissions that warm the planet, such as carbon dioxide and methane.

# **Dialysis patients struggle to get** treatment in 'blockaded Gaza'

Hundreds of kidney patients died

DEIR AL-BALAH, Gaza Strip, April 23, (AP): Twice a week, Mohamed Attiya's wheelchair rattles over Gaza's scarred roads so he can visit the machine that is keeping him alive.

The 54-year-old makes the journey from a temporary shelter west of Gaza City to Shifa Hospital in the city's north. There, he receives dialysis for the kidney failure he was diagnosed with nearly 15 years ago. But the treatment, limited by the war's destruction and lack of supplies, is not enough to remove all the waste products from his blood.

"It just brings you back from death,"

Many others like him have not made it. They are some of Gaza's quieter deaths from the war, with no explosion, no debris. But the toll is striking: Over 400 patients, representing around 40% of all dialysis cases in the territory, have died during the 18-month conflict because of lack of proper treatment, according to Gaza's Health Ministry

That includes 11 patients who have died since the beginning of March, when Israel sealed the territory's 2 million Palestinians off from all imports, including food, medical supplies and fuel. Israeli officials say the aim is to pressure Hamas to release more hostages after Israel ended their ceasefire.

COGAT, the Israeli military body in charge of coordinating aid, declined to comment on the current blockade. It has said in the past that all medical aid is approved for entry when the crossings are open, and that around 45,400 tons of medical equipment have entered Gaza since the start of the war. Attiya said he needs at least three dialysis sessions every week, at least four

hours each time. Now, his two sessions last two or three hours at most.

Israel's blockade, and its numerous evacuation orders across much of the territory, have challenged his ability to reach regular care.

He has been displaced at least six times since fleeing his home near the northern town of Beit Hanoun in the first weeks of the war. He first stayed in Rafah in the south, then the central city of Deir al-Balah. When the latest ceasefire took effect in January, he moved again to another school in western Gaza City.

Until recently, Attiya walked to the hospital for dialysis. But he says the limited treatment, and soaring prices for the mineral water he sl drinking, have left him in a wheelchair. His family wheels him through a Gaza that many find difficult to recognize. Much of the territory has been destroyed

He said he now has hallucinations because of the high levels of toxins in his blood.

"The occupation does not care about the suffering or the sick," he said, referring to Israel and its soldiers.

Six of the seven dialysis centers in Gaza have been destroyed during the war, the World Health Organization said earlier this year, citing the territory's Health Ministry. The territory had 182 dialysis machines before the war and now has 102. Twenty-seven of them are in northern Gaza, where hundreds of thousands of people rushed home during the two-month

the father of six said.

XPRIZE runs other contests to try to solve societal challenges. Executive director Nikki Batchelor said the organization is considering more climate-related competitions addressing such issues as removal of the potent greenhouse gas methane, reforestation and climate adaptation and resilience.

Mati Carbon CEO Shantanu Agarwal believes his company's relatively low-cost approach "has a potential to really solve some planetary scale problems" while helping small farmers who often bear the brunt of climate change, as extreme weather events like drought and floods destroy crops.



# Rising tennis star Eala stays focused at Madrid Open

MADRID, April 23, (AP): Teenage sensation Alexandra Eala is trying to stay grounded despite all the sudden attention she's attracted following her breakthrough run in Mi-

The 19-year-old Eala, a product of Rafael Nadal's academy, has climbed to No. 72 in the WTA rankings after reaching the Miami Open semifinals as a wild-card entry last month. She's the first Filipina to be ranked inside the top 100.

"Now that the dust has settled, I try not to think about Miami so much," she said. "Of course, it comes to mind when everyone's asking, but in my mind I have my whole life to look back at those moments and I'll always have those memories. But the tour goes on, competition goes on, so right now I'm fully focused on Madrid.

Eala defeated Viktoriya Tomova 6-3, 6-2 in her opening match at the clay-court Madrid Open , setting up a rematch against four-time French Open champion Iga Swiatek, whom she beat in straight sets in the Miami quarterfinals.

"I definitely think that each match is a different story," Eala said. "Even if it's against the same player every time - doesn't matter if I play her at the same time next year in Miami or in Madrid next year, it's going to be a different story than the last one."

The left-handed Eala also defeated two other Grand Slam champions - Jelena Ostapenko and Madison Keys - in Miami

"A lot of external factors have changed (since Miami)," Eala said. "More eyes on me. I guess there's more exposure. But in the day-to-day and how I feel internally, nothing has changed much because the work ethic always been there. My team has been so down to earth, keeping me grounded and reminding me what's important to focus on right now."

In Miami, Eala became the first Filipino player in the Open Era to win four main-draw matches at a WTA 1000 event.

"What was quite a shock to me was that I've won against top 10 and top five players. Happy shock, of course," she said. "But the mindset is still, especially before the matches, is that you can beat them."

Eala, who lost to Panna Udvardy in the round of 16 at a WTA 125 tournament last week in Oeiras, Portugal, clinched her first WTA 1000 win in Madrid last year.

Eala moved to Spain at age 13 after an invitation from

the Rafa Nadal Academy following one of her victories in a youth tournament.

"I definitely think it was a big milestone when I moved to the Rafa Academy. They've been a part of my journey, for sure," she said. "It was a it was a tough decision to send me to Spain, at such a young age, but I was super excited. I knew it was a big opportunity to get out of the Philippines and develop my tennis.

"They're very experienced people," she said. "The coaching staff have a lot of experience, a lot of knowledge. And and they have a structure that enables me to grow and to figure things out by myself and to develop as a player."

Nadal was among those congratulating Eala after her surprise run in Miami.

RIYADH, April 23, (AP): Cristiano Ronaldo has rested and now is returning his attention to winning his first major trophy in Saudi Arabia.

Despite breaking the Saudi Pro League's scoring record last season with 35 goals and leading the standings in this campaign, the 40-yearold Ronaldo is yet to collect any silverware since signing for Al-Nassr in December 2022.

On Saturday, he'll be leading Al-Nassr against Japan-based Yokohama F.Marinos in the Asian Champions League Elite quarterfinals.

The Riyadh club, still yet to win a continental championship, is expected to progress to the last four, particularly after Ronaldo was rested this week for Al-Nassr's domestic league win over Damac.

Even without the five-time Ballon d'Or winner, coach Stefano Pioli has a star-studded roster at his disposal. It includes Jhon Duran, signed from Aston Villa in January for over \$100 million, former Liverpool star Sadio Mane and Spanish international defender Aymeric Laporte.

Al-Nassr also has home advantage, as all playoff games are taking place in Jeddah along the Red Sea coast.

"We're now fully focused on Asia," Pioli said Tuesday. "We have been working hard to prepare for it

and I'm satisfied with the performance of the players." Yokohama was a beaten finalist last season but is struggling in last place in Japan's domestic league after collecting just two points from the last seven games. The club last week fired Steve Holland, a former England national team assistant to Gareth Southgate, after just four months as coach.

'To fill the void," the club said in a statement, Australian "Patrick Kisnorbo will serve as an interim manager for the time being.

Nassr's Riyadh rival Al-Hilal has won a record four Asian titles and plays Friday against Gwangju FC, a South Korean club making its first appearance in the tournament.

## Clubs didn't want to sign a player with kids says, Schult

BERLIN, April 23, (AP): As an Olympic gold medalist and Champions League winner, Almuth Schult was one of the top goalkeepers in women's soccer. She believes her career ended early because clubs were reluctant to sign a player with children. The 34-year-old former Germany goalkeeper announced her retirement in March, three months after her contract ended with the Kansas City Current in the National Women's Soccer League in the U.S. "I feel like in Europe it is still not yet normal for a female soccer player to have children. Whether the clubs admit it or not, that's my subjective impression," Schult told Germany's Kicker magazine in an interview published Tuesday. "Many clubs worry that there could be adversity and difficulties with mothers even though that doesn't have to be the case.' Schult said she felt she could have played another "one, two years at the highest level" and that she believes being a mother was "the main reason" talks didn't work out. Schult said top clubs only offered her the role of a third-choice backup. Schult gave birth to twins in 2020 and a third child in 2023. "I was already out of contract after my second pregnancy," said Schult, who played 66 times for the German national team. "No club believed I could still help, even though I had already proven it after my first pregnancy.'

Biles undecided on competing at LA Olympics, says 2028 'seems so far away'

PARIS, April 23, (AP): Simone Biles is unsure whether she will compete at the Los Angeles Olympics in 2028.

For now, the most decorated gymnast of all-time has other priorities and is listening to her body, too.

"I'm really trying to enjoy life, to spend time with my husband (Chicago Bears safety Jonathan Owens), go support him at his games, live my life as a woman," she said in an interview with French sports daily L'Equipe published on Tuesday. "I've accomplished so much in my sport. For me to come back, it would

really have to excite me."

The 28-year-old American will be in Los Angeles for the Games but does not yet know in which capac-

"Whether on the apparatus or in the stands, I still don't know that," she told L'Equipe. "But 2028 seems so far away, and my body is aging. I felt it in Paris."

The American gymnast won three gold medals and a silver at the Paris Olympics, taking her career tally to seven Olympic golds and 11 medals overall.

But her body cracked from the

strain

"I went back to the village, I took the elevator and my body literally collapsed. I was sick for 10 days,' she said, before recounting another experience. "The other day, we were sprinting in the garden with friends, I had aches and pains for three days. So, I honestly don't know. We'll see.

She praised her rival, Rebeca Andrade of Brazil, for recovering from injury and for "pushing me beyond my limits," but also said gymnastics no longer needs both of them.

"It only needs one of us, no? Es-

pecially since (Andrade) will not be alone," Biles said. "A young generation will knock at the door and everything will start again."

The interview took place before Monday's Laureus Awards in Madrid, where she was named sportswoman of the year.

Whatever she decides regarding her career, Biles will continue to speak about mental health.

"I am very proud of the work accomplished to reach this point," she said, "and I will continue to be the voice of the voiceless.<sup>3</sup>

#### MELBOURNE, Australia, April 23, (AP): Ex-Australia test vice-captain Keith Stackpole, one of Wisden's cricketers of the year in 1973, has died, Cricket Australia said Wednesday. He was 84.

Stackpole made his international debut in 1966 and played 43 tests, scoring 2,807 runs and taking 15 wickets with his wrist spin, in an era when batters usually didn't wear helmets or much in the way of protective clothing.

He also played in the very first one-day international, taking three wickets in Australia's fivewicket win over England at the Melbourne Cricket Ground in 1971.

He produced his best cricket in the Ashes, averaging 50.6 in 13 tests including his high score of 207 against England at the Gabba in 1970. He led the scoring in the 1972 Ashes series when he was deputy to Ian Chappell.

Stackpole had a long and distinguished career in the media and broadcasting after his international retirement in 1974.

Cricket Australia chairman Mike Baird said

Stackpole's "legacy will live long into the future." "Not only was he an outstanding player for Aus-

tralia and Victoria, his work in the media, radio and TV commentary and as a mentor to many players who followed in his footsteps demonstrated his enduring passion and influence in the game," Baird said. "It is testament to his talent and standing that he was one of the five 'Wisden Cricketers of the Year' in 1973.'

Merv Hughes, who was also from Victoria state and later became a fast bowler for Australia, paid tribute to Stackpole in a social media post.

"Very sad news indeed - Stacky was a fantastic cricketer. ... but more so a great bloke - and one hell of a cricket coach," Hughes said. "R.I.P. Keith.

Stackpole was initially selected as a legspinner and middle-order batter for Australia but he was quickly promoted to open the batting. Former Victoria and Australia bowler Damien Fleming said Stackpole, his former coach, revolutionized the approach to opening a test match innings.

# **Man City boost Champions League hopes**

MANCHESTER, England, April 23, (AP): Pep Guardiola celebrated wildly as Manchester City took a big step toward Champions League qualification with a 2-1 victory over Aston Villa in the Premier League.

With clenched fists, the City manager roared with delight after Matheus Nunes struck deep into stoppage time at the Etihad Stadium.

"I was so happy. I have to admit it," Guardiola said after a win that could help salvage a troubled season for his once dominant team.

The late winner moved four-time defending league champion City up to third in the standings, with the top five securing a place in European club soccer's top competition.

Nunes fired home from a tight angle in the fourth minute of added time after Jeremy Doku's low cross through the box.

The game had looked destined to end in a draw after Bernardo Silva's first-half goal had been canceled out by a Marcus Rashford penalty.

There is still likely to be a tense battle for the Champions League with a clutch of teams in contention going into the final weeks of the season and just four points separating third to seventh in the standings.

But City's fate is in its own hands after a troubled campaign that saw its title defense unravel before Christmas and its hopes of winning the Champions League end in the playoffs.

A top-five finish would go some way to ending the season on a high - and Guardiola's celebration was evidence of just how important the win could prove to be.

"We have a lot of pressure for the club to go to the Champions League," said Guardiola, whose City team won the competition for the first time in 2023.

"If we win the next four games, it will have been so important," he added.

Victory moved City up to 61 points and above Notting-

ham Forest in fourth and Newcastle in fifth.

Chelsea is sixth and Villa, with 57 points, is seventh. England's top flight will be given a bonus fifth Champions

League place because of the performances of English teams in Europe this season.

Both City and Villa have played a game more than their top-five rivals. But City knows a perfect record from its remaining four league games would guarantee a place in next season's Champions League.

It would be the 15th season in a row that City has qualified for the competition and would provide an uplifting finale to a campaign that brought an end to Guardiola's recent dominance of English soccer.

There is likely to be a rebuild in the offseason, with Kevin De Bruyne leaving and Silva and Ilkay Gundogan also in the latter stages of their careers.

But it was Silva who provided the opener for City in the seventh minute from close range after Omar Marmoush's cutback

Rashford had already hit the post for Villa by that point after bursting into the box seconds after kickoff.

And the on-loan Manchester United forward was on the score sheet in the 18th - equalizing from the penalty spot following a VAR review of Ruben Dias' foul on Jacob Ramsey in the box.

Defeat was a blow to Villa's hopes of making it backto-back seasons in the Champions League after returning to the competition for the first time in 41 years this term and advancing to the quarterfinals.

"Of course, today we lost, but there are still matches to play, still points to play (for). We will have chances to get the Champions League," Villa manager Unai Emery said. "I am happy how we are reacting, how every player is facing the moment we are (in).

Pogacar surges to victory: Cycling star Tadej Pogacar launched a trademark attack on a steep climb to win the Flèche Wallonne classic for the second time in his stellar career on Wednesday.

The three-time Tour de France champion won the Belgian race in 2023 and showed his outstanding climbing ability when he surged ahead on the final ascent up the Mur de Huy. None of his rivals could even follow and he crossed the line alone in 4 hours, 50 minutes, 15 seconds.

Frenchman Kévin Vauquelin was 10 seconds behind Pogacar in second place with British rider Tom Pidcock 12 seconds back in third.

Last year, Stephen Williams became the first British winner of the race after battling snowy conditions

This time the riders dealt with driving rain and wet roads along the 205.1-kilometer (127.2-mile) race that culminated in a short and sharp climb up Huy, which has an average gradient of 9.6% and sections as steep as 19%.



## **Zimbabwe tops Bangladesh** by 3 wickets in opening test

SYLHET, Bangladesh, April 23, (AP): Fast bowler Blessing Muzurabani claimed 6-72 and opener Brian Bennet scored 54 as Zimbabwe beat Bangladesh by three wickets in the first cricket test on Wednesday.

Offspinner Mehidy Hasan gave Bangladesh an outside chance at victory by tak-ing 5-50 on day four, but Zimbabwe's batters held their nerve to reach 174-7 for their first test victory since 2021.

Bangladesh was dismissed for 255, adding just 61 to their overnight 194-4, after Muzurabani hastened the collapse by becoming the joint-fastest to 50 test wickets for his country.

Zimbabwe appeared set for a comfortable victory by racing to 95 in the 21st over without losing a wicket as it chased a modest target of 174.

Mehidy then broke through with the wicket of Ben Curran, who made 44 off 75 balls.

Left-arm spinner Taijul Islam, who finished with 2-70, had Nick Welch legbefore for 10 as Bangladesh pulled itself back into the match.

Bennet clipped Taijul's full-length delivery past mid-wicket for two to raise his second half-century in the last over of the second session.

But Mehidy gave Bangladesh a genuine chance by dismissing Sean Williams and Bennet in consecutive overs before Taijul got the better of captain Craig Ervine
