Kuwait's rights blueprint gets UN seal of approval

Justice minister vows follow-up on recommendations

GENEVA, May 10. (KUNA): The UN Human **Rights Council (UNHRC)** endorsed unanimously on Friday Kuwait's fourth report in which it affirmed boosting its national system to safeguard human rights through field, constitutional



he said.

The report also highlighted tangible steps in human rights, topped with the national plan, to develop legislations, the State's most outstanding priority to boost the rule of law, he stated.

During his speech before the council, the minister affirmed Kuwait's eagerness to study 290 recommendations received by the member states, and to provide the council with the official response during the 60th session in a manner that shows Kuwait's keenness on serious follow-up. He highly expressed appreciation to Troika - Thailand, Czech Republic- and Benin - which supervised studying the report, and all national agencies and officials who contributed to the success of this report. In its report, the State of Kuwait affirmed a comprehensive legislative review of all laws totaling 983 that resulted in a series of new legal reforms.

Importance of the United Nations Human Rights Council

United Nations Human Rights Council (UNHRC) is an international body responsible for the promotion and protection of human rights around the world. Headquartered in Geneva, Switzerland, it is one of the United Nations' human rights arms.

Establishment of the Council:

The United Nations Human Rights Council was established in 2006 to replace the Commission on Human Rights, which had existed since 1946.It was established by the United Nations General Assembly pursuant to resolution 60/251.

Among the main reasons for Replacing the Human Rights Commission with the Human Rights Council include the fundamental shortcomings and repeated accusations against the previous Commission including

Weak credibility and legitimacy

The Human Rights Commission was heavily criticized for allowing countries with poor human rights records to become members, which led to the politicization of its work and inconsistent decisions.

Some countries used their membership to deflect criticism rather than reform their situations. 2. Politicization and double standards

Many observers believed that the Commission tended toward political bias, targeting some countries over others, while ignoring clear violations by powerful countries or allies of influential members.

3. Weak implementation mechanisms

The Commission lacked strong powers or effective mechanisms to hold countries accountable, and its decisions were mostly symbolic and non-binding. Its reports were not properly followed up and were often ignored.

4. The need for a more efficient and representative structure

The UN General Assembly wanted to establish a more geographically representative body with comprehensive periodic review mechanisms for all countries, something the Commission did not provide. Professionalism and effectiveness

This is achieved by introducing a comprehensive periodic review system for all countries without exception, defining clearer membership criteria, and allowing for the suspension of membership for coun-

tries that grossly violate human rights. The Comparison between the former Commission

on Human Rights (1946-2006) and the current Human Rights Council (2006-present), affiliated with the United Nations:



NEW YORK, May 10, (KUNA): Ku-wait's Coast Guard Commodore Sheikh Mubarak Ali Al-Sabah discussed on Friday strengthening bilateral cooperation and exchange of expertise in the field of maritime security, with Vice Adm. Brad Cooper, deputy commander of the U.S. Central Command.



Event transcends historical occurrence: Tajik envoy

KUWAIT CITY, May 10: The Embassy of the Russian Federation in the State of Kuwait hosted the commemoration of the 80th anniversary of victory over Nazism in World War II

Present at the event were numerous ambassadors, diplomats and representatives of international communities.

The event highlighted vital moments at such a remarkable period in human history and underscored the contributions of Soviet Union in defeating the Nazi regime

Speaking on behalf of the ambassadors of the Commonwealth of Independent States (CIS) -- Azerbaijan, Armenia, Kazakhstan, Kyrgyzstan, Tajikistan and Uzbekistan; Russian Ambassador to Kuwait Vladimir Zheltov stated "eight decades have passed since the conclusion of the Great Patriotic War, the term used in Russia to denote World War II, commencing with the Nazi German assault on the Soviet Union on June 22, 1941 and culminating in Germany's capitulation on May 9.1945.

He explained "this conflict remains deeply entrenched in the collective con-

sciousness of those who experienced it or inherited its legacy, notwithstanding the evolving geopolitical landscape and the dissolution of the Soviet Union.'

He added the events during those tumultuous years were not spontaneous, as they are rather the consequences of the major disruption of the global order following World War I and the endeavors of certain powers to exploit Nazism as a tool against the Soviet Union.

He pointed out that the Nazi offensive against the Soviet Union is considered the most brutal assault in history, with the Soviets confronting a force bolstered by the majority of European nations. "This conflict evolved into a protracted war of attrition lasting four years. During this period, the Red Army effectively dismantled the German war machine and liberated half of the European continent,' he revealed

He stressed that the Soviet Union bore the brunt of the war, incurring the loss of 27 million citizens, predominantly civilians; and that 78 percent of the Nazi Army casualties occurred on the Eastern Front alone. He said the Second Front was not established until June 1944, less than a year before the end of the war, illustrating the immense challenge that the Soviet forces faced independently

He vehemently condemned the attempts of some western entities to revise history and distort facts, asserting that "today, we observe disconcerting efforts to diminish the Soviet Union's role and absolve those who collaborated with the Nazis. This signifies a lapse in political memory and disregard for the lessons of history.' He affirmed that observing this anniversary is a moral imperative towards those who sacrificed their lives for liberty and a reminder to all generations that historical accuracy remains an impenetrable defense against falsehoods and distortion of facts.

Moreover, Ambassador of the Republic of Tajikistan to Kuwait Zubaydullah Zubaydov asserted that the observance of the 80th anniversary of the Great Patriotic War (1941-1945) holds national importance, as it allows Tajikistan to reaffirm its commitment to the considerable sacrifices made by its people in the fight against Nazism.

He said this anniversary transcends historical occurrence, as it is an essential element of the Tajik national identity. He disclosed that more than 300,000 Tajiks served in the Red Army -- a huge figure considering the Republic's population at the time was below 1.5 million.

He elaborated that Tajikistan, despite its geographical separation from the main areas of conflict, played a crucial role in the provision of military and humanitarian aid; thereby, contributing to the liberation of main areas such as Belarus and Crimea. He added some Tajik soldiers were among those who first entered the Reichstag in Berlin in 1945.

Cooperation eyed to fight human peddling, protect rights of labor

Kuwait, ILO top officials hold meeting

GENEVA, May 10, (KUNA): Kuwait's Assistant Foreign Minister for Human Rights Affairs, Ambassador Sheikha Jawaher Al-Sabah, met on Thursday with (Ms.) Manuela Tomei, Assistant Director-General for Governance, Rights and Dialogue at the International Labour Organization (ILO), discussing ways for enhancing cooperation on common issues. During her side meeting with the UN official, as part of Kuwait's delegation participating in the Universal Periodic Review held in Geneva, Sheikha Jawaher emphasized the strength of the historical ties between Kuwait and the ILO, dating back to Kuwait's accession to the organization in 1961, which was crowned by the opening of a regional office in Kuwait in 1972. The two sides discussed the best approaches and practices for enhancing labor rights and



market, in alignment with human rights standards, national laws, and international treaties ratified by Kuwait.

In this context, Sheikha Jawaher highlighted Kuwait's launch of the National Strategy to Combat Human Trafficking (2025-2028), which strengthens measures for prevention, protection, accountability, and the elimination of all forms of labor exploitation. This initiative reflects Kuwait's commitment to supporting contract workers.

She also added that Kuwait is currently undertaking a comprehensive legislative review of relevant national laws, including labor-related regulations.

eign Affairs of Kuwait will be allowed to enter Japan without a visa for a period exceeding not 90 consecutive days. Similarly, Japanese holders of valid diply invite Kuwaiti people, to visit Japan during this momentous event.

UN official lauds commitment to global pacts

Kuwait Dive Team effort in protecting environment hailed

BEIRUT, May 10, (KUNA): UN's Director and Regional Representative of West Asia Office Sami Dimassi affirmed that Kuwait has a clear environmental footprint, thanks to the Kuwait Dive Team in preserving the marine environment and protecting it from ruin.

In a statement to KUNA after Thursday's meeting with the Kuwait Dive Team and the UN's Office in Beirut, Dimassi said that the team's efforts reflect Kuwait's commitment to international environmental treaties, and its keenness to coordinate with appropriate organizations.

He explained that the meeting was held to review the team's 2024-2025 report as part of the global Clean Seas campaign to protect the seas from plastic, and to discuss future projects related to marine environment conservation

The report was full of outstanding environmental achievements and projects, including 130 environmental missions.

Dimassi praised the team's efforts to combat plastic waste, which has caused environmental damage and has become a global issue threatening the health of marine ecosystems, he also expressed his

pride in the team's recent win of the World Energy Foundation Award. For his part, team leader Waleed Al-Fadhel told KUNA that the team signed a memorandum of understanding with the office in 2018 as part of the global Clean Seas campaign. Al-Fadhel

Al-Fadhel explained that the team's achievements included recovering 12 ships, boats, and a marine vessel weighing 60 tons from several locations, they removed 120 tons of abandoned fishing nets and harmful waste from various coasts, and maintained 107 marine anchorages for safe mooring of boats and yachts to protect coral reefs.

He also noted its ongoing campaigns to clean Kuwait's coasts and islands, as well as the installation and comprehensive maintenance of all marine moorings at reef sites, they periodically monitor several locations in the Kuwaiti sea to ensure safe navigation.

They monitor the condition of coral reefs in the southern islands, coasts, and reserves, and submit reports to government agencies, international organizations, the Environment Public Authority, and the Coral Watch program at the University of Queensland in Australia.

For the 10th consecutive year, the team is organizing the weekly "Mobile Beach Cleaning Campaign" in cooperation with several bodies.

Valid card must for aid: The distribution of essential aid by charitable associations -- covering rent support, tuition fees, chronic illness treatment and hospital care for Bedouns -- is contingent on the validity of the recipient's security card, reports Al-Anba daily quoting a source from the Ministry of Social Affairs.

The source explained that if the security card is expired, assistance is suspended until the card is renewed and a copy of which is submitted to the concerned charity for record updates.

KUWAIT CITY, May 10: The Ministry of Higher Education has announced the mechanism for calculating the equivalent Grade Point Average (GPA) for students who intend to apply for external scholarships for the next academic year.

This announcement is part of the 'My Destination' media awareness campaign, which underscored the need for students to fully understand this mechanism to ensure proper preparation and accurately determine their preferences.

The ministry explained that the equivalent GPA is calculated by combining the percentage of the high school diploma with the results of the English language and Mathematics tests within the National Examination, whose weights vary depending on the major.

The National Exam is an essential part of a student's assessment, contributing around 10 percent to 35 percent of the equivalent GPA, depending on the major. This entails the need for students to be fully prepared in order to pass these tests.

Who cares ... food and humor clips preferred over politics?

"MOST people follow social media, but they tend to focus on content about food and humor. They show little interest in news or events that directly affect their future, their livelihood, or the fate of their country", columnist Ahmad Al-Dawas wrote for Al-Seyassah daily.

"Ask someone about current affairs, and they will often say, "I don't like politics." However, politics, in simple terms, is the state of a country and its relationships with others.

"Take the Houthis in Yemen, for example. They

are a group that felt marginalized and neglected by their government. With Iranian backing, they quickly turned to armed conflict and overthrew the legitimate gov which ernment, had relocated to Aden



"Their actions did not just damage Yemen but they also harmed Egypt and its people. By attacking ships in the Red Sea and disrupting navigation through the Suez Canal, Egypt lost an estimated \$800 million per month in vital revenue. Insurance costs on goods soared, leading to higher prices and hardship for people around the world.

"Recently, Israeli and American aircraft launched strikes on the port of Ho-deidah, a stronghold of the Houthis, in response to their occasional missile attacks on Israel and threats to international shipping in the Bab al-Mandab Strait.

"This is a clear example of how the internal situation in one country can harm the people of another. It is a reminder that everyone should pay attention to important global events, as they directly impact their future and the future of their children.

"Russian President Vladimir Putin sparked a war by invading eastern Ukraine, where people had been living in relative peace and security. He questioned the intentions of NATO countries due to the alliance's expansion toward Russia's western borders. In an at-tempt to halt NATO's advance and turn Ukraine into a buffer zone between Russia and Europe, Putin launched a military campaign against Ukraine. "The war resulted in heavy losses

and casualties on both sides. Ironically, Putin's actions led more European countries to join NATO, strengthening the alliance rather than weakening it. Meanwhile, both Ukrainians and Russians continue to suffer the devastating consequences of the conflict.

"Taiwan is a stable and economically advanced island, yet China repeatedly threatens its people with the possibility of invasion and annexation. As a result, the people of Taiwan live in constant uncertainty and fear for their safety.

"Due to the limited decision-making capacity among remaining leaders, ministers were frequently seen in the media making technical and administrative decisions that would traditionally fall under the authority of senior officials in each ministry.

"The continued delay in promptly filling these leadership vacancies further contributed to the poor performance of some government agencies, underscoring the urgent need for corrective action.

"In light of the huge challenges facing government administration, it is important to urgently fill leadership and supervisory vacancies with highly qualified, capable individuals who possess both administrative efficiency and a strategic vision. These leaders must be able to comprehend and effectively implement public policies and strategies.

"While the criteria for appointing individuals to leadership and supervisory roles in the civil service system are important, the actual performance of many in these positions suggests that these standards alone are insufficient. As a result, many administrative leaders remain unable to drive development or effectively deal with existing problems. This highlights the urgent need to implement comprehensive, integrated leadership development programs to better prepare candidates for these critical roles.

"Western culture refers to a set of values, principles, and cultural, social, and moral traditions, as well as scien-tific achievements.", Kuwaiti journalist Khaled Al-Janfawi wrote for Al-Seyassah daily.

"I believe that Western culture, in certain civilizational aspects, can serve as a model for Arabs and Muslims. However, it certainly cannot become a spiritual model for them for the following reasons:

Western culture and the spiritual void: Anyone who studies or frequently visits certain Western societies will notice the spiritual void many members of these societies experience. This is evident in the low rates of church attendance and the declining interest in reading their holy books. Spiritual hunger is often filled by converting to Islam or embracing certain Eastern spiritual philosophies. For a rational Muslim, it is difficult to emulate Western materialistic spirituality, as it simply does not exist.

- The condescending view of Ar-abs and Muslims: The rapid rise of the extreme right in many Western societies is a clear indication of the growing influence of a historical Crusader spirit directed against the Muslim world. The increase in hate crimes targeting Arabs, Muslims, and Eastern minorities further underscores the deep-seated prejudice against these groups, prejudice based solely on ethnic, religious, and cultural differences. How can a rational person look to emulate a culture that harbors such disdain for them? - Double standards in dealing with Arab and Islamic issues: The historical Western political bias against many Arab and Islamic issues is clear evidence of this. Part of this bias stems from a deep-seated prejudice within the contemporary Western political mindset, particularly against dark-skinned people and their historical causes. It is illogical for a rational person to emulate those who look down on them because of their skin color, especially when these same individuals would continue to despise them, even if they changed their appearance or mastered the language and dialect of their oppressors. Western psychological issues: Excessive imitation of the Western lifestyle can lead to the adoption of psychological issues prevalent in some Western societies, such as psychopathy, depression, anxiety disorders, gender identity issues, homosexuality, anorexia, Satanism, and other severe emotional disorders that stem from the materialistic Western lifestyle.

Asian man in 50s run over, dead in Messilah tragedy

KUWAIT CITY, May 10: An Asian man, in his 50s, died when a vehicle ran over him near Messilah.

According to a security source, the Operations Unit at the Ministry of Interior received information about the run-over accident near Messilah. Security and ambulance personnel rushed to the scene. Upon their arrival, it was confirmed that the Asian man succumbed to his injuries.

His body was referred to the Forensic Medicine Department, while the driver who caused the accident was referred to the police station for the necessary legal action

Traffic crackdown: The Ministry of Interior carried out a comprehensive security and traffic campaign in Sabah Al-Salem on Friday, with participation from several departments including the Traffic Affairs and Operations Sector, the General Department of Rescue Police, Central Operations, public and private security sectors, and the Women's Police.

The campaign resulted in the issuance of 804 citations for various traffic violations, the arrest of six individuals for violations of the residency and labor laws, 10 wanted individuals, five without identification, and one person in an abnormal condition, and the seizure of six vehicles wanted by the judiciary.

According to a press release issued by KFF, firefighters from Salmiya and Al-Bidaa fire stations rushed to the location and extinguished the fire before it spread further.

Foul play suspected in death of Asian expat

KUWAIT CITY, May 10: The Operations Unit at the ministry received a report about the discovery of a body at a dirt yard near the Kuwait-Saudi border, reports Al-Anba daily.

Upon arrival at the scene, the security personnel surmised that the body was that of an expatriate. They found multiple wounds and severe burns on the face, the source added.

The source affirmed that investigations are ongoing, hinting that there could be foul play in the death of the expat. He added the Forensic Medicine Department has the technology to identify bodies and establish the cause of death.

Official acquitted of helping person flee

Fugitive, aide get 4 yrs jail

KUWAIT CITY, May 10: The Court of Appeals upheld the ruling of the Criminal Court that acquitted an employee in the **Passports Department at Kuwait International Airport of forging** passenger entry and exit records in the automated system of the Ministry of Interior.

The charges stemmed from the alleged escape of a wanted individual who reportedly exited the country using the passport of a friend bearing a close physical resemblance. While the employee was cleared of all

charges, the court sentenced the fugitive in absentia and the individual who provided him with the passport to four years in pris-on with hard labor. Both were also ordered to be deported following the completion of their prison term.

The case originated from a report filed by a detective at a police station in Hawally Governorate. The officer stated that in July, he attempted to execute an arrest warrant issued by the Public Prosecution against the fugitive who was wanted in multiple fraud cases. Unable to locate him, the officer questioned the fugitive's mother, who revealed that her son left the country using a friend's passport due to their similar an

Meanwhile, the accused employee denied any wrongdoing, stating that he properly documented the passport's use and verified its details at the time of departure. He emphasized that he had no prior knowledge of the substitution and had no relationship with either individual involved.

In court, Attorney Abdullah Al-Blaihees argued that the elements of the alleged forgery offense were not met. He maintained that his client had no criminal intent and had no prior association with the suspects. He pointed out that there was no conclusive evidence linking the employee to any forgery of travel records.

Further supporting his defense, Al-Blaihees submitted official documentation showing that Kuwait International Airport did not employ a biometric fingerprint verification system at the time of the incident. He also provided evidence highlighting the strong physical resemblance between the fugitive and his accomplice, reinforcing the claim that the employee could not have reasonably identified the impersonation.

The court ultimately agreed, finding insufficient grounds to convict the employee and affirmed his acquittal.

The Council of Ministers has approved an amendment to Article 16 of Public Assistance Law No. 12/2011 allowing the assistance committee to form subcommittees of specialists, instead of forming a single subcommittee.

Article One of the revised law states that the first paragraph of Article 16 of Law No. 12/2011 shall be replaced with the following text: "The committee shall be formed from those concerned with family care by a decision from the minister. The decision shall specify its mandates, the method of convening it to meet, and the method of voting on its decisions.

"Trump threatened to impose tariffs on countries worldwide, to annex Canada as a US state, and even to purchase Greenland. The result was turmoil in the global economy, losses for countries and companies, harm to Americans due to his policies, and a decline in his popularity. We will limit ourselves to these examples to keep the article concise.

"Journalism carries a powerful message that can influence political decision-makers. It exposes fault lines and corruption in society. Yet, there are still those who say, "I don't like politics." For these individuals, following cooking shows on social media seems more important than staying informed about their own living conditions or the security of their country."

Also:

"During the brief tenure of the previous government, many senior officials in the public administration were either retired or asked to resign. This led to a problem that we continue to face: the loss of highly qualified leadership and a huge number of vacancies in leading leadership and supervisory roles. Most of these positions were either temporarily filled through assignments or secondments, or remain vacant to this day", columnist Eng. Adel Al-Jarallah Al-Kharafi wrote for Al-Seyassah daily

"As a result, and in conjunction with other contributing factors, the level of public services declined, productivity dropped, and transactions were delayed, while necessary decisions were either postponed or inadequately addressed.

"Oh my God ... What happened in just one day and one night that transformed our streets into sparkling pearls? The answer is the return of public awareness

and the renewed enforcement of the law", Kuwaiti writer Hamoud Al-Hattab wrote for Al-Seyassah daily

"Not long ago, I came across a sarcastic post on social media posted by a young

man claiming to Dr. Al-Hattab own an American

pickup truck. In his post, he mocked the small minority of drivers who actually use their turn signals, which are included in every vehicle. He wrote, "It is shameful for us, as U.S. truck drivers, to use turn signals when changing lanes," adding that only

clumsy and naive drivers do so. "I was deeply disturbed by this post, as it promotes reckless behavior and a blatant disregard for traffic laws.

"Following the amendment of traffic laws and the implementation of monitoring and surveillance measures, the situation changed dramatically. Streets began to resemble sparkling pearls, illuminated by the frequent use of turn signals, especially by women, many of whom, though not all, previously may not have been fully aware of where the signal controls were located in their vehicles.

Photos shared on media

Photographer acquitted of snapping two women

KUWAIT CITY, May 10: The Court of Appeals upheld the ruling of the First Instance Court that acquitted a sports photographer of charges of using a mobile phone and defamation after he photographed two female fans and posted their photos without their consent.

The defendant was referred to trial after the two female fans filed a complaint, in which they stated that they were surprised when he took photos of them and posted their photos on his Instagram account without their knowledge or consent.

The two complainants stated that the defendant defamed them by photographing them while they were in the fans' stands supporting the national team in a foreign tournament without wearing the hijab, despite the fact that they wear the hijab in Kuwait.

In court, Attorney Nawaf Al-Wahib argued that the material and moral elements of the crime were absent, noting that the Court of Cassation's ruling concluded that photographing people in a public place does not constitute a crime.

He explained that his client photographed the two complainants as a photographer in a public place, not private, for the purpose of media coverage and to highlight the Kuwaiti fans and express pride in them and their support for the national team.

He confirmed to the court that his client did not know that the two complainants are wearing hijab in the country; otherwise, he would have refrained from photographing them and publishing their photos out of consideration for their privacy and their desire not to appear without the hijab.

'Indecent act'

Bedoun threatens to kill owner of grocery

KUWAIT CITY, May 10: A 72-year-old expatriate man said an unidentified person committed an indecent act following a traffic dispute between them, reports Al-Anba daily.



KUWAIT CITY, May 10: Regional Director of the United Nations High Commissioner for Refugees (UNHCR) for the Eastern Horn of Africa and the Great Lakes Dr Mamadou Diagne Balde concluded his two-day official visit to Kuwait as part of his Gulf tour aimed at strengthening strategic partnerships and mobilizing support for the humanitarian response to the crisis in Sudan and neighboring countries.

Balde pointed out that more than two years after the outbreak of the conflict in Sudan around 13 million people have been displaced, including four million refugees in neighboring countries, while only 11 percent of the UNHCR and its partners' Regional

Response Plan has been funded. He made the statement at a press conference

Kuwait attends ACAO meeting

'Need to modernize regulations to improve Arab aviation sector'

RABAT, April 10, (KUNA): The State of Kuwait participated in the 72nd Executive Council meeting of the Arab Civil Aviation Organization (ACAO) held recently in Rabat.

The Kuwaiti delegation was led by Director General of the Directorate General of Civil Aviation (DGCA) Sheikh Hamoud Mubarak Al-Hamoud Al-Jaber Al-Sabah, alongside delegations from other member states.

In a statement to KUNA, Sheikh Homoud Al-Sabah emphasized that the meeting reflects ACAO's continued efforts to enhance the aviation sector in Arab countries by modernizing regulations to align with international standards.

He added that the meeting addressed various topics related to the opportunities and challenges facing the air transport sector in the Arab region. Additionally, discussions

included the review of recommendations and decisions from previous sessions, financial matters, and preparations for the upcoming General Assembly of the Organization.

The meeting also focused on key issues to be discussed at the upcoming International Civil Aviation Organization (ICAO) General Assembly in September, which will be held at ICAO's headquarters in Montreal, Canada.

Sheikh Hamoud extended Kuwait's congratulations on the inclusion of Yemen and Tunisia in the Executive Council following a decision to expand its membership.

The Executive Council, composed of 11 member states elected every two years by the General Assembly, serves as the governing body of ACAO, overseeing its administration and ensuring the implementation of decisions from the General Conference.

Court rejects PAHW move

'Citizen will get rent allowance'

KUWAIT CITY, May 10: The Court of First Instance has ordered the State Ministry of Housing to retroactively and continuously reimburse a rent allowance of KD11,300 to a citizen who previously replaced and waived his housing application multiple times.

In a landmark ruling, the court clarified that the criterion for suspending the rent allowance is not merely the allocation of a housing plot, but rather the completion of the construction period or the connection of electricity.

Details of lawsuit filed by Attorney Abdul Mohsen Al-Qattan indicated that the plaintiff was allocated a new plot in Al-Mutlaa on May 4, 2023. However,

as construction had not yet been completed and electricity was not connected -- conditions required for halting the rent allowance -- he remained entitled to receive the allowance.

The administrative authority's decision to stop the payments and demand repayment for that period was deemed erroneous.

The court ruled that the ministry must return the deducted amount and resume payment, as the plaintiff submitted a new housing application and had not yet benefited from the allocated plot.

The judgment further stated that rent allowances must be reinstated for all individuals whose payments were previously suspended due to substitution or waiver of alternative housing, starting from the month following the implementation of the relevant regulation.

It is true that the Iraqi government cannot curb the unbridled freedom of the media. I also emphasize that the official Iraqi decision has nothing to do with what is circulating on social media and in the media. However, at the same time, I affirm that no one can change a single letter in these relevant agreements. These individuals do not have the power to build a wall between Kuwait and Iraq, similar to what the United States did with Mexico or Israel with the West Bank and the Lebanese border.

In Kuwait, we understand that these media outlets are controlled by those outside Iraq's borders who seek to achieve their dubious interests at the expense of the Iraqi people. Media propaganda will not alter the facts on the ground and will have no impact on Kuwait. The geographical reality will remain unchanged.

This is what both the Iraqi presidents and prime ministers relied on in their appeal of the Federal Supreme Court's ruling, as they recognize that good neighborliness is one of the foundational principles of the new Iraqi state.

Therefore, any attempt to revive the border issue between Iraq and Kuwait is a suspicious act that conceals malicious intentions, which certainly do not represent the Iraqi people.

Unfortunately, and with great bitterness, we must acknowledge that some are trying to exploit this for regional interests aimed at undermining Iraqi national security, attempting to disrupt relations between Kuwait and Iraq, and divert attention from a matter that has been settled for a long time.

Here, we must emphasize once again: The failed experience of the "Qasr Al-Zohour" radio station, the propaganda of Abdul Karim Qasim, Saddam's Fedayeen, or the so-called Al-Quds Army, will not be repeated.

So, we say, be patient, and may God be the most helpful. Anyone familiar with the nature of relations between Kuwait and Iraq during King Faisal's reign will understand the significance of Kuwait's immediate assistance to Iraq after its liberation from Saddam's Ba'athist regime.

They will also realize that those beautiful cities on the Iraqi border near Kuwait were built with Kuwaiti funds to stimulate trade between the two countries. Moreover, they will realize that Mubarak Al-Kabeer Port and Al-Faw Port complement each other, and that Kuwait aims to transform the northern region into an integrated economic zone, including factories, commercial, and service institutions that will benefit Iraq more than Kuwait.

On this basis, the late Amir Sheikh Sabah Al-Ahmad Al-Jaber Al-Sabah, along with all Kuwaiti

With the Human Rights Council, a comprehensive periodic review of the human rights records of all member states every four years has also become possible. This was not possible under the Commission on Human Rights.

Membership and Credibility

With the establishment of the Human Rights Council, the Council has become more effective and transparent, with stronger accountability mechanisms. However, the Commission on Human Rights has lost its ability to address some human rights violations and issues.

The overall outcome of replacing the Commission with the Human Rights Council. The previous Commission was considered an outdated structure that was no longer effective and lacked decisiveness and credibility.

The current Council represents an attempt to rejuvenate the human rights machinery within the United Nations, with broader powers and stronger oversight tools, despite the persistence of some political challenges.

The most prominent functions of the Human Rights Council, according to the new mechanism established after the Council's establishment in 2006, are

Monitoring human rights violations in member states.

Conducting the Universal Periodic Review (UPR), which assesses each member state's human rights record every four years. Appointing special rapporteurs

and independent experts to investigate specific issues such as torture, freedom of expression, or racial discrimination.

Convening emergency sessions in times of crisis or grave violations.

Recommending international measures to protect civilians in situations of conflict or mass atrocities

Structure of the Council

The Human Rights Council has 47 members. States are elected for three-year terms, with a 33% annual turnover rate, meaning approximately 15 to 16 new members are elected each year depending on the expiration of their terms.

No state may serve more than two consecutive terms, but may reelect after a period of interruption. The principle of equitable geographical distribution among the continents is based on the allocation of 13 seats to Africa, 13 seats Asia and the Pacific, Latin America and the Caribbean, 6 seats to Eastern Europe, and 7 seats to Western Europe and other countries. The Council has a bureau consisting of a president and four vice-presidents representing each regional group. They serve for a one-year term, according to the Council's annual session.

■ The Special Rapporteur on the situation of human rights in the Occupied Palestinian Territory Monitors and reports on Israeli and Palestinian human rights violations in that territory.

■ The Special Rapporteur on the Right to Adequate Housing investigates issues of forced evictions, displacement, and precarious housing worldwide.

Since its establishment in 2006, the United Nations Human Rights Council has achieved a number of significant accomplishments in monitoring and protecting human rights around the world. The most notable of these accomplishments is the establishment of the Universal Periodic Review (UPR) mechanism, based on an internationally recognized system that includes the following:

The human rights record of each member state is reviewed every four to five years.

■ It allows states to hold each other accountable in a public and organized manner.

■ It includes all states without exception, a practice that was not previously implemented.

The Council established independent fact-finding missions to investigate serious violations, most notably:

Syria (since 2011): documented widespread violations by all parties to the conflict.

■ Myanmar (since 2011): Reports of ethnic cleansing against the Rohingya

■ Palestine: Repeated reports of excessive use of force and violations against civilians.

Ethiopia (Tigray in 2020): Investigations into alleged war crimes.

The Human Rights Council has appointed special rapporteurs and international experts to investigate alleged or ongoing violations in some countries, most notably issues such as freedom of expression, torture, the right to housing, women's rights, and racial discrimination. These experts submit periodic reports, visit countries, and address governments regarding violations. The Council has taken rare but

influential measures, such as: 1. Suspension of membership,

including: Libya's membership was sus-

pended in 2011 due to the suppression of the revolution.

Russia's membership was suspended in 2022 after the invasion of Ukraine.

This step reinforces the Council's seriousness in holding countries accountable.

2. Supporting complaints mechanisms for individuals and organizations:

The Council has opened the door for individuals to submit confidential complaints regarding serious violations via an independent

The fate of specific reports can be reviewed.

Gaza (2023-2024)

The latest report held Israel responsible for acts that may amount to genocide. The report was used in a case brought by South Africa against Israel before the International Court of Justice.

Some states called for action, but the Security Council did not take actual action due to division among the permanent members.

Yemen:

The UN Panel of Experts documented potential war crimes, but Its mandate was terminated in 2021 under pressure from some states.

Its reports did not lead to direct international accountability.

It is clear that the reports of commissions of inquiry play an important role in documenting and providing moral and political accountability, but they rarely translate into direct legal accountability due to:

The complexities of the international system.

The interests of some states, particularly major powers.

The absence of binding enforcement mechanisms within the Human Rights Council.

Perhaps the most prominent international trials or judicial cases in which reports of UN commissions of inquiry or human rights expert teams were used as primary evidence to prove war crimes or crimes against humanity related to the region are:

1. The 2024 Genocide Case against Israel - International Court of Justice which included the deliberate of civilians. The destru of civilian infrastructure and the forced transfer of populations.

Kuwait has been a member of the United Nations Human Rights Council twice so far, as follows:

1. First Term: 2011–2014 Kuwait was first elected to the Council in 2010, and its three-year term began in 2011.

2. Second Term (Current):2024-2026

Kuwait won a seat in the October 2023 elections. Its membership began in January 2024 and will continue until the end of 2026.

During its membership in the Human Rights Council, Kuwait played an effective and balanced role in supporting human rights issues, with a focus on Arab, Islamic, and humanitarian issues. Among its most notable contributions and positions during its two terms are the follow-

Strongly supported investigations into Israeli violations against Palestinians, especially during the aggression on Gaza.

Demanded the international community protect Palestinian civilians and halt settlement activity.

It emphasized the need to respect international humanitarian law and stop violence against civilians.

It adopted moderate positions calling for comprehensive political solutions to crises.

■ It highlighted Kuwait's role as a global humanitarian center, particularly in providing support to displaced persons and refugees

It supported some recommendations and expressed reservations on some provisions that conflict with sovereign or religious values.

■ It participated in sessions discussing freedom of religion and expression, emphasizing the need not to link terrorism to religions.

It supported resolutions promoting women's empowerment and combating violence against children, within a framework of respect for cultural specificities.

Kuwait adopts a non-confrontational approach in the Council, seeking to bring viewpoints closer together rather than confronting them. It expressed its support for developing the Council's mechanisms to make them more just, effective, and

non-politicized.

The Human Rights Council, on the other hand, is affiliated with the United Nations General Assembly, and the number of member states has increased to 47. Elections are direct and secret by the United Nations General Assembly, with an absolute majority of 97 votes out of 193 member states. The country's contribution to promoting human

It can issue resolutions and recommendations. Although these are not legally binding, they carry significant political and moral weight. Member States of the Human

The Council consists of 47 member states, elected by the United Nations General Assembly with due regard to equitable geographical distribution. In the elections held in October 2024, 18 new states were elected to the Council for the period from January 1, 2025, to December 31, 2027

African Nations: Benin, Democratic Republic of the Congo, Ethiopia, Gambia, Kenya.

Asia-Pacific States: Cyprus, Marshall Islands, Qatar, Republic of Korea (South Korea), Thailand Eastern European States: Czech Republic, North Macedonia

Western European and Other States: Iceland, Spain, Switzerland

Other states continue their membership until the end of their specified terms. For example, Kuwait continues its membership until 2026, after being elected in October 2023.

Although their reports and recommendations are not legally binding, they carry significant moral and political weight and are often used as a basis for international action or diplomatic pressure.

Special Rapporteurs and their areas of expertise:

The Special Rapporteur on Freedom of Opinion and Expression investigates restrictions on freedom of the media, arrests for expression, and publication bans.

The Special Rapporteur on Torture and Other Cruel, Inhuman, or Ill-Treatment or Punishment receives reports of torture in detention centers or during interrogation.

The Special Rapporteur on Violence against Women focuses on forms of domestic violence, sexual violence, and forced marriage.Reports on States' policies and compliance with women's rights conIt enhances the role of civil soci-

ety in international oversight. 3 - Enhancing international cooperation:

The Council provides a platform for dialogue between states and non-governmental organizations on critical issues such as:

Climate change and human rights

Discrimination against minori-

Post-conflict transitional justice Reports issued by the Human Rights Council and its committees:

quiry has issued several reports on human rights violations in Gaza, Yemen, and other countries.

Israel was accused of committing war crimes and crimes against humanity, including:

Wilful killing.Torture and inhuman treatment. Sexual and gender-based violence.

■ Targeting health facilities and medical personnel.

Systematic destruction of the health care system.

Forcible transfer of populations. Reports indicated that these acts may amount to the crime of genocide

Where as the Palestinian armed groups were accused of committing war crimes, such as:

Firing indiscriminate rockets at civilian areas in Israel.

Taking hostages, which constitutes a war crime.

■ The Commission called for the immediate release of all hostages and an end to attacks on civilians.

The United Nations established the Group of Experts on Yemen, which issued previous reports documenting violations by all parties to the conflict, including:

Indiscriminate killing of civilians

■ Torture and ill-treatment.

Restrictions on humanitarian aid.

The group's mandate was terminated in 2021 following a vote at the Human Rights Council.

The fate of the reports of the Human Rights Council's international commissions of inquiry is often influenced by international politics. Although they document serious violations of international law in their prepared reports, some are still influenced by geopolitical events in the region. The procedures for these reports can usually be summarized as follows:

The Court issued provisional measures requiring Israel to prevent and investigate acts of genocide.

2. The Syrian War: Trials have been filed in Europe under universal jurisdiction.Several European courts (Germany, Sweden, France) have tried former officials of the Syrian

regime. 3. The Yemen War:The UN Panel of Experts on Yemen documented:

Indiscriminate bombing.The blockade imposed on civilians. The recruitment of children.Some European human rights organizations attempted to bring cases against officials from the Arab coalition under the principle of universal jurisdiction, but political pressure prevented some cases from being accepted. The reports are still being used in legal and media campaigns.

4. Myanmar - The Genocide Case Against the Rohingya. Reports of the Fact-Finding Mission on Myanmar (2018) documented genocidal intent against the Rohingya minority. The Court agreed to hear the case and issued provisional measures to protect the Rohingyas.

The importance of these reports cannot be downplayed as the reports issued by the Human Rights Council are not merely symbolic. They can serve as key legal tools in building criminal cases and international lawsuits, and politically independent states are required to bring them before international or national courts.

Examples of how UN commissions of inquiry reports have been used as primary evidence in international trials include:

Anwar Raslan Trial in Germany (2022)

In January 2022, the Regional Supreme Court in Koblenz, Germany, sentenced former Syrian Colonel Anwar Raslan to life imprisonment after convicting him of crimes against humanity

The United Nations High Commissioner for Human Rights, Michelle Bachelet, described the verdict as a "historic step towards justice," noting that the trial highlighted the torture and inhumane treatment suffered by countless Syrians in detention facilities. These reports have been used as evidence in legal attempts in some European countries to hold those responsible for these violations accountable, although political pressure has prevented some cases from progressing.

Kuwait and its Membership in the Human Rights Council:

Kuwait made some key constitutional steps, including establishing centers to protect victims of family violence, a national office on childhood protection, national committee on women rights and enhance their roles and others.

The report stressed Kuwaiti women's key role in development, noting that they make up 58 percent of national workforce and have three ministerial portfolios in the current government.

The report shed light on utmost attention paid by Kuwait to boost rights of disabled, referring that the country has allocated USD 340 million to support the services of this segment.

On fighting corruption, the report pointed out that Kuwait prepared new bills to expand powers of Nazaha (Kuwait Anti-Corruption Authority), and enhance the role and independence of judiciary.

It referred to Kuwait's efforts on digital transformation, including the launch of "Sahel" app. that has achieved more than 60 million e-transactions.

Kuwait is working to enhance partnership with civil society, ensure the protection of vulnerable segments' rights and spread the culture of human rights, the report said.

Led by His Highness the Amir Sheikh Meshal Al-Ahmad Al-Jaber Al-Sabah and His Highness the Crown Prince Sheikh Sabah Khaled Al-Hamad Al-Sabah, Kuwait continues to honor its commitment to achieving reforms, and enhancing human rights and freedom, it noted.

The document also highlighted Kuwait's role as the center of humanitarian action, affirming commitment to continuing offering a wide-range of humanitarian aid, through the Kuwait Fund for Arab Economic Development, and backing relief efforts in the dispute-inflicted areas, mainly Gaza, Syria and Yemen, in addition to host and organize international donor conferences

The report said Kuwait responded to calls for field visits during 2023 and 2024 that included development field, violence against women, rights of those disabled and others.

The national report, which covered the period from 2020 to 2024, was prepared by governmental and civil society agencies, and the National Diwan for Human Rights.

Kuwait's delegation vowed to study the recommendations totaling 290 submitted by the UNHRC member states.

Trump signs executive order for self-deportation program

WASHINGTON, May 10, (KUNA): US President Donald Trump has inked an executive order encouraging illegal immigrants to leave the US willingly.

"Today, I signed an executive order to launch the first ever self-deportation program for illegal aliens. We are making it as easy as possible for illegal aliens to leave America," Trump said in a video posted by the White House late Friday.

"Any illegal alien can simply show up at an airport and receive a free flight out of our country. We have also launched a phone app called C, B P home. That's C, B P home, where illegals can book a free flight to any foreign country, as long as it's not here, you can go anywhere you want," he said.

"We're also adding a very important exit bonus for illegals to further incentivize their self-deportation. This deportation bonus will save American taxpayers billions and billions of dollars," he added.

"She's got a difficult decision to make about what she's going to do. I hope she stays engaged," Biden said, declining to share his specific advice. Biden rejected concerns about his cognitive decline prompted by a disastrous debate performance last June. He also declined to criticize the Democratic leaders who privately pressed him to abandon his campaign.

"The only reason I got out of the race was because I didn't want to have a divided Democratic Party," he said, adding that the broader party didn't buy into concerns about his age following the "terrible" debate performance "but the Democratic leadership and some of the very significant contributors did."

Polling, however, suggests that the concerns among Democrats were widespread.

In January 2022, just a year into Biden's first term, an AP-NORC poll found that only 48% of Democrats wanted him to seek reelection. That fell to 37% of Democrats in an AP-NORC poll conducted February 2023. And two after his debate flop, nearly two-thirds of Democrats said Biden should withdraw from the race.

Thursday's appearance also marked Biden's first joint interview with former first lady Jill Biden since leaving Washington. She rejected those who believe she created a protective cocoon around her husband while in office to protect him from scrutiny about his age.

"It was very hurtful especially from some of our so-called friends," she said of the criticism.

"I was with Joe day and night ... and I did not create a cocoon around him," she continued. "You saw him in the Oval Office. You saw him making speeches. He wasn't hiding somewhere."

Judge pauses much of WH massive downsizing of federal agencies

US Treasury secretary calls on Congress to raise or suspend debt ceiling by mid-July

WASHINGTON, May 10, (AP): The US is on track to run out of money to pay its bills as early as August without congressional action, Treasury Secretary Scott Bessent warned Friday.

He is calling on Congress to either raise or suspend the debt ceiling by mid-July.

"A failure to suspend or increase the debt limit would wreak havoc on our financial system and diminish America's security and global leadership position," Bessent wrote in the letter to House Speaker Mike Johnson. "Prior episodes have shown that waiting until the last minute to suspend or increase the debt limit can have serious adverse consequences for financial markets, businesses and the federal government."

Earlier this week, Bessent twice testified in front of congressional committees that the Treasury's debt ceiling is "on the warning track."

After the debt limit was reinstated in January, Treasury Secretary Janet Yellen - in one of her last acts in the position - said the agency would institute "extraordinary measures" intended to prevent the U.S. from reaching the debt ceiling.

Since then, the Treasury Department has stopped paying into certain accounts, including a slew of federal worker pension and disability funds, to make up for the shortfall in money. Bessent has continued to notify Congress about the use of extraordinary measures in an effort to prevent a breach of the debt ceiling. In his latest letter, Bessent attributed the August deadline, known as the "X-date," in part to receipts from the latest tax filing season. A Bipartisan Policy Center analysis

A Bipartisan Policy Center analysis released in March estimated that the US could run out of cash by mid-July if Congress did not raise or suspend the nation's debt limit.

SAN FRANCISCO: The **Trump** administration must halt much of its dramatic downsizing of the federal workforce, a **California** judge ordered Friday.

Judge Susan Illston in San Francisco issued the emergency order in a lawsuit filed last week by labor unions and cities, one of multiple legal challenges to Republican President Donald Trump's efforts to shrink the size of a federal government he calls bloated and expensive.

"The Court holds the President likely must request Congressional cooperation to order the changes he seeks, and thus issues a temporary restraining order to pause large-scale reductions in force in the meantime," Illston wrote in her order.

The temporary restraining order directs numerous federal agencies to halt acting on the president's workforce executive order signed in February and a subsequent memo issued by the Department of Government Efficiency and the Office of Personnel Management.

The order, which expires in 14 days, does not require departments to rehire people. Plaintiffs asked that the effective date of any agency action be postponed and that departments stop implementing or enforcing the executive order, including taking any further action.

They limited their request to departments where dismantlement is already underway or poised to be underway, including at the the U.S. Department of Health and Human Services, which announced in March it will lay off 10,000 workers and centralize divisions.

Illston, who was nominated to the bench by former President **Bill Clinton**, a Democrat, said at a hearing Friday the president has authority to seek changes in the executive branch departments and agencies created by Congress.

Pope Leo XIV lays out vision of papacy

VATICAN CITY, May 10, (AP): Pope Leo XIV laid out the vision of his papacy Saturday, identifying artificial intelligence as one of the most critical

In his remarks Saturday, Leo said he identified with his predecessor, who

matters facing humanity and vowing to continue in some of the core priorities of Pope Francis.

In his first formal audience, Leo repeatedly cited Francis and the Argentine pope's own 2013 mission statement, making clear a commitment to making the Catholic Church more inclusive, attentive to the faithful and a church that looks out for the "least and rejected."

Leo, the first American pope, told the cardinals who elected him that he was fully committed to the reforms of the Second Vatican Council, the 1960s meetings that modernized the church. He identified AI as one of the main issues facing humanity, saying it poses challenges to defending human dignity, justice and labor.

Leo referred to AI in explaining the choice of his name: His namesake, Pope Leo XIII, was pope from 1878 to 1903 and laid the foundation for modern Catholic social thought. He did so most famously with his 1891 encycli-

cal Rerum Novarum, which addressed workers' rights and capitalism at the dawn of the industrial age. The late pope criticized both laissez-faire capitalism and state-centric socialism, givaddressed the great social question of the day posed by the industrial revolution in the encyclical.

"In our own day, the church offers everyone the treasury of its social teaching in response to another industrial revolution and to developments in the field of artificial intelligence that pose new challenges for the defence of human dignity, justice and labour," he said.

Toward the end of his pontificate, Francis became increasingly vocal about the threats to humanity posed by AI and called for an international treaty to regulate it.

He warned that such powerful technology risks turning human relations into mere algorithms. Francis brought his message to the Group of Seven industrialized nations when he addressed their summit last year, insisting AI must remain human-centric so that decisions about when to use weapons or even less-lethal tools always remain made by humans and not machines.

Thousands join pro-EU rally in Romania's capital

Thousands of people gathered in Romania's capital on Friday for a pro-European Union march. It came a week before the final vote of a closely watched presidential election that pits a hard-right nationalist front-runner against the capital's pro-EU mayor.

Marchers converged in Bucharest in front of the government building, where many waved the blue and yellow flags of Europe. Many chanted slogans such as "We are in Europe" and "Bucharest is not Budapest," referring to Hungary's Prime Minister Viktor Orbán, a member but also a longtime critic of the EU.

A communist country until 1989, Romania joined the EU in 2007. But last year it was plunged into its worst political crisis in decades when a top court voided the previous election. The far-right outsider Calin Georgescu topped the first round following allegations of electoral violations and Russian interference, which Moscow has denied.

The rally was held nearly a week after the first round of a presidential election redo that saw hardright nationalist George Simion, 38, emerge as the front-runner. In second place was 55-year-old incumbent Bucharest Mayor Nicusor Dan. (AP)

Ukraine and allies push for 30-day ceasefire starting Monday: Sybiha

KYIV, Ukraine, May 10, (AP): Ukraine and its allies are ready for a "full, unconditional ceasefire" with Russia for at least 30 days starting on Monday, Ukrainian FM Andrii Sybiha said Saturday.

His remarks came as the leaders of four major European countries visited Kyiv, amid a push for Moscow to agree to a truce and launch peace talks on ending the nearly three-year war. It coincided with the last day of a unilateral three-day ceasefire declared by Russia that Ukraine says the Kremlin's forces have repeatedly violated.

In March, the United States proposed an immediate, limited 30-day truce which Ukraine accepted, but the Kremlin has held out for terms more to

Both sides also said attacks on their troops had continued on Thursday.

Ex-Supreme Court justice Souter dies: Retired Supreme Court Justice David H. Souter, the ascetic bachelor and New Hampshire Republican who became a favorite of liberals during his nearly 20 years on the bench, has died. He was 85.

Souter died Thursday at his home in New Hampshire, the court said in a statement Friday.

He retired from the court in June 2009, giving President Barack Obama his first Supreme Court vacancy to fill. Obama, a Democrat, chose Sonia Sotomayor, the court's first Latina justice.

Souter was appointed by Republican President George H.W. Bush in 1990. He was a reliably liberal vote on abortion, church-state relations, freedom of expression and the accessibility of federal courts. Souter also dissented from the decision in Bush v. Gore in 2000, which effectively handed the presidency to George W. Bush, the son of the man who put him on the high court. (AP)

India and Pakistan agree to ceasefire in United States-mediated talks

ISLAMABAD, May 10, (AP): India and Pakistan on Saturday confirmed a ceasefire deal after US-led talks to end a conflict between the nuclear-armed rivals.

It follows weeks of clashes, missile and drone strikes across their border that were triggered by a gun massacre on tourists last month that India blames on Pakistan, which denied the charge. It was their most serious confrontation in decades and left dozens of civilian dead on both sides.

The first word on the truce came from US President Donald Trump, who posted his Truth Social platform that he was pleased to announce that India and Pakistan had agreed to a full and immediate ceasefire. "Congratulations to both Countries on using Common Sense and Great Intelligence. Thank you for your attention to this matter!"

Pakistan's foreign minister said earlier Saturday that his country would consider de-escalation if India stopped further attacks. However, Ishaq Dar warned that if India launched any strikes, "our response will follow."

Dar told Pakistan's Geo News that he also conveyed this message to US Secretary of State Marco Rubio, who contacted him after Rubio spoke to New Delhi earlier.

"We responded because our patience had reached its limit. If they stop here, we will also consider stopping," Dar added.

India said it targeted Pakistani air bases early Saturday after Islamabad fired several high-speed missiles at military and civilian infrastructure in the country's Punjab state. Pakistan said it intercepted most missiles and responded with retaliatory strikes on India.

Rubio spoke to his Indian counterpart Subrahmanyam Jaishankar and emphasized that "both sides need to identify methods to de-escalate and reestablish direct communication to avoid miscalculation," State Department spokesperson Tammy Bruce said Saturday, and offered US support to facilitate "productive discussion."

Earlier Saturday, India's military held a press briefing in New Delhi, saying Pakistan targeted health facilities and schools at its three air bases in Indian-controlled Kashmir.

"Befitting reply has been given to Pakistani actions," said Indian Col. Sofiya Qureshi.

Wing Commander Vyomika Singh said India was committed to "non-escalation" provided that Pakistan reciprocated. However, Pakistani ground forces were observed mobilizing toward forward areas, she said, "indicating an offensive intent to further escalate the situation."

"Indian armed forces remain in a high state of operational readiness," she added. Singh said India carried out "precision strikes only at identified military targets" including technical infrastructure and radar sites.

Pakistan's military said it used medium-range Fateh missiles to hit an Indian

missile storage facility and air bases in the cities of Pathankot and Udhampur. The Associated Press could not independently verify all the actions attributed

to Pakistan or India.

Army spokesman Lt. Gen. Ahmad Sharif said Pakistan's air force assets were safe following the Indian assault.

Tensions have soared since an attack at a popular tourist site in India-controlled Kashmir left 26 civilians dead, mostly Indian Hindu tourists, on April 22. New Delhi has blamed Pakistan for backing the assault, an accusation Islamabad rejects.

Indian missiles Saturday targeted Nur Khan air base in the garrison city of Rawalpindi, near the capital Islamabad, Murid air base in Chakwal city and Rafiqui air base in the Jhang district of eastern Punjab province, according to Pakistan's military spokesman.

There were no immediate reports of the strike or its aftermath from residents in the densely populated Rawalpindi.

Pakistanis celebrated the missile launches on India.

"Thank God we have finally responded to Indian aggression," said Muhammad Ashraf, who had gone out in Lahore for breakfast. There were jubilant scenes in Peshawar and Karachi.

Following the announcement of Pakistani retaliation, residents in Indian-controlled Kashmir said they heard loud explosions at multiple places, including the two big cities of Srinagar and Jammu and the garrison town of Udhampur.

"Explosions that we are hearing today are different from the ones we heard the last two nights during drone attacks," said Shesh Paul Vaid, the region's former top police official and Jammu resident. "It looks like a war here."

Vaid said explosions were heard from areas with military bases, adding it appeared that army sites were targeted. Residents living near Srinagar city's airport, which is also an air base, said they were rattled by the explosions and booming sound of jets.

"I was already awake, but the explosions jolted my kids out of their sleep. They started crying," said Srinagar resident Mohammed Yasin, adding he heard at least two explosions.

S.Korea conservative party moves to switch presidential candidates

SEOUL, South Korea, May 10, (AP): South Korea's embattled conservative party has taken the unprecedented step of nullifying its primary and replacing presidential candidate Kim Moon Soo with former Prime Minister Han Duck-soo just one week after Kim's selection, deepening internal turmoil ahead of the June 3 presidential by-election.

Saturday's move by the People Power Party's leadership, which Kim denounced as an "overnight political coup," underscores the desperation and disarray within the party following the ouster of former President Yoon Suk Yeol over his ill-fated attempt to impose martial law in December.

Kim, a staunch conservative and former labor minister under Yoon, was named the PPP's presidential candidate on May 3 after winning 56.3% of the primary vote, defeating a reformist rival who had criticized Yoon's martial law. But the PPP's leadership, dominated by Yoon loyalists, has spent the past week pressuring Kim to step aside and back Han, whom they believe stands a stronger chance against liberal Democratic Party frontrunner Lee Jae-myung.

Han served as acting president after Yoon was impeached by the legislature in December and officially removed by the Constitutional Court in April. He resigned from office May 2 to pursue a presidential bid, arguing his long public

service career qualifies him to lead the country amid growing geopolitical uncertainty and trade challenges intensified by the policies of U.S. President Donald Trump.

After failed talks between Han and Kim to unify their candidacies, the PPP's emergency committee canceled Kim's nomination in the early hours of Saturday and officially registered Han as a party member and its new presidential candidate.

The replacement still requires confirmation through an all-party vote Saturday and approval by the party's national committee Sunday, which is the deadline for candidates to register with the election authorities.

Han in a message issued through the party claimed "if we unite, we can surely win."

Speaking at a news conference, Kim lamented "democracy in our party died" and vowed to take unspecified legal and political steps, but it remained unclear whether any realistic path existed to restore his candidacy without the party's cooperation.

Reducing student debt re-elected govt first priority, says Australia's Albanese

MELBOURNE, Austalia, May 10, (AP): Australian Prime Minister Anthony Albanese told his government colleagues on Friday that reducing student debt would be the first legislative priority for his administration that was returned to power in the nation's first election in which the Baby Boomer generation was outnumbered by younger voters.

Albanese addressed a crowded room full of center-left Labor Party lawmakers in Parliament House for the first time since his government won an emphatic election victory on May 3.

The struggle a growing number of young Australians - particularly those burdened with student loans - face to buy their first home, due to soaring real estate prices and a lack of new housing construction was a major election issue.

Albanese said a bill to reduce student debt by 20% would be the first legislation to be introduced when Parliament resumes in late July.

"I think that's important, not just in itself but for what it says about our commitment to intergenerational equity," Albanese said. Baby Boomers are often defined

as people born between World War II and 1964. Their needs have long dominated Australian election campaigns.

As vote counting continued on Friday, Labor was on track to win 88 seats in the 150-seat House of Representatives, the lower chamber where parties need a majority to form government.

The party held 78 seats in the last parliament.

The conservative opposition alliance of parties was likely to claim only 41 seats.

Albanese praised the diversity of Labor's elected lawmakers and said at least 57% of them are expected to be women once the vote counting is completed. The Australian population was 50.7% female at the last census in 2021.

"I... see people of different ethnicities, different backgrounds, different experiences, different faiths. I see a diverse group of people that are truly representative of our nation," Albanese told his government colleagues.

But the government has been criticized for dropping Attorney-General Mark Dreyfus and Industry and Science Minister Ed Husic, the government's most prominent Muslim, from the new Cabinet that will be sworn in on Tuesday.

Cabinet ministers are decided by party factions that are entitled to a proportion of ministerial seats that reflects their share of government lawmakers.

Rights groups sue to free Venezuelans deported from US, held in El Salvador

SAN SALVADOR, El Salvador, May 10, (AP): International human rights organizations on Friday filed a lawsuit with the Inter-American Commission on Human Rights asking that the commission order El Salvador's government to release Venezuelans deported from the United States and held in a maximum-security prison.

In March, the US government deported more than 200 Venezuelan immigrants alleged to have ties to the Tren de Aragua gang to El Salvador, paying the Salvadoran government to imprison them. Since then, they have had no access to lawyers or ability to communicate with their families. Neither the US nor Salvadoran governments have said how the men could eventually regain their freedom.

"These individuals have been stripped from their families and subject to a state-sponsored enforced disappearance regime, effectively, completely against the law," said Bella Mosselmans, director of the Global Strategic Litigation Council, which helped bring the suit.

One of them is Euder José Torres.

In September, Torres boarded a Houston-bound flight in Quito, Ecuador with his 21-year-old stepson after successfully completing a monthslong screening process that included health exams and criminal history checks.

The 41-year-old Venezuelan and the young man he had raised since early childhood had been approved for family reunification through the UN's International Organization for Migration and were headed to the US to join his longtime partner and his stepson's brother.

But at the airport in Houston, immigration agents saw a tattoo of a compass on the stepson's forearm with the initials of his mother, father and brother in place of the cardinal directions. They said it signaled him as a member of the Venezuelan gang Tren de Aragua. The next day he was on a flight back to Ecuador.

But Torres didn't have an Ecuadorian visa, so agents

placed him in immigration detention in Texas. He had tattoos too, the name of his saint Elegua in script on one forearm he is a practitioner of Santeria, a fusion of African religions and Catholicism - and skull on the other.

Torres sought US asylum and passed his credible fear interview, but at an immigration hearing in January the government lawyer told the judge, without providing evidence, he too was a member of Tren de Aragua. The judge issued a deportation order, according to his longtime partner, who requested anonymity due to fears of retaliation despite her legal status in the US.

In March, Torres found himself among more than 200 Venezuelans sent to a maximum-security prison in El Salvador.

His partner questions how the US government could send him to a prison there without any evidence that he had broken the law or has a criminal record.

El Salvador has been living under a state of emergency for more than three years, which has suspended some fundamental rights and given the administration of President Nayib Bukele extraordinary powers. More than 85,000 Salvadorans have been arrested over the period for alleged ties to the country's once-powerful street gangs.

The improvement in El Salvador's security has won Bukele widespread domestic support and some admirers in the region who seek to imitate his success. But the lack of due process and numerous arbitrary arrests have drawn international condemnation. Bukele has dismissed those critics as defenders of criminals.

A spokesperson for Bukele's office declined to comment Friday. With the administration of US President Donald Trump taking a hard line on immigration and portraying migrants broadly as criminals, neither government has been swayed by legal maneuvers in their own country to seek the men's release or return to the US.

Myanmar military govt chief meets China's Xi since taking power in '21

BANGKOK, May 10, (AP): The chief of Myanmar's military government, Senior Gen. Min Aung Hlaing, has for the first time since seizing power four years ago met with President Xi Jinping of China, a top ally of his military government, state-run media in the Southeast Asian nation reported Saturday.

The Global New Light of Myanmar newspaper reported that Xi pledged to provide assistance for recovery after Myanmar's devastating earthquake in March and aid in efforts to end the country's civil war. The two leaders met Friday in Moscow on the sidelines of the commemoration of the 80th anniversary of the defeat of Nazi Germany in World War II.

Its report said they also discussed "bilateral relations, enhancing cooperation in all sectors, and cooperating in regional stability and peace." China has been using its influence with ethnic rebel organizations to ease their pressure on the military government in an apparent effort to stabilize it.

China, along with Russia, is a major arms supplier to Myanmar's military in its war against pro-democracy and ethnic minority resistance forces. Beijing is also Myanmar's biggest trading partner and has invested billions of dollars in mines, oil and gas pipelines, and other infrastructure. Its interests in security in Myanmar are especially strong because the two nations share an 890-mile (1,440-kilometer) border


At least 20 killed in Sudan after suspected drone strike hits jail

CAIRO, May 10, (AP): A suspected drone strike launched by Sudan's paramilitary Rapid Support Forces hit a prison in the southern region of Kordofan on Saturday and killed at least 20 inmates, authorities said.

Fifty other detainees were wounded in the attack on the main prison in Obeid, the capital city of North Kordofan, Information Minister Khalid Aleiser said in a statement.

Aleiser, who is also the spokesman of the military-allied government, accused the Rapid Support Forces for the attack, which came as the militia escalates drone strikes on the military-held areas across the country.

Sudan plunged into civil war on April 15, 2023, when simmering tensions between the military and the RSF exploded into open warfare in the capital Khartoum and other parts of the country. Obeid is 363 kilometers (225 miles) south of Khartoum.

It is also one of the countries providing major relief and reconstruction assistance after the 7.7-magnitude March 28 earthquake that killed more than 3,700 people in Myanmar and injured more than 5,100. The quake worsened an already dire humanitarian crisis, with more than 3 million people displaced from their homes and nearly 20 million in need due to the war, according to the United Nations.

Beijing has been concerned about instability that threatens its interests in Myanmar since Myanmar's army suffered unprecedented battlefield defeats over the past few years, especially in areas near the Chinese border.

An offensive began in October 2023, by the "Three Brotherhood Alliance," comprising the Myanmar National Democratic Alliance Army, the Arakan Army and the Ta'ang National Liberation Army, was able to quickly capture towns and overrun military bases and command centers and strategic cities along the Chinese border in northeastern Shan state.

It was widely seen at the time as having Beijing's tacit support to help stamp out rampant organized crime activities in areas controlled by ethnic Chinese.

In early 2024, Beijing helped broker a ceasefire, but that quickly fell apart when the alliance launched new attacks. Myanmar's ruling generals and China's government showed concern as pro-democracy guerrillas and armed ethnic minority groups, sometimes working hand in hand, gained the initiative in fighting.

The alliance's offensive lost momentum after China shut down border crossings, cut electricity to Myanmar towns and took other measures to discourage the fighting.

OPEC+ aligns with Trump's push for lower oil prices?!

AST week, OPEC+ decided L'ho increase crude oil output for this month and the next. This appears to be in support of

the trend of lowering oil prices. Or perhaps it is a warning to member countries that have been exceeding their agreed production quotas in



violation of OPEC's resolutions. Currently, oil prices are around \$ 64 per barrel, a level few expected, and one for which there seems to be no real reason. The increase in supply since last month, continuing into June, could be interpreted as a signal to non-compliant members: either adhere to production limits or risk driving prices down further, which will cause hurt to everyone.

At \$ 64 per barrel, everyone loses. Member countries will suffer financially and will be forced to turn to international banks for funding. While banks may be willing to lend, the terms and credit ratings will likely worsen, especially as uncertainty grows over how long oil prices will remain weak, given

the abundant supply and the current U.S. administration's strong push for domestic oil exploration and production in America.

OPEC, on the other hand, is currently producing around 30 million barrels per day, which is an increase of 200,000 barrels per day compared to last year. However, this rise in output comes with lower daily revenue due to weaker oil prices, offering little to no financial benefit for OPEC member countries. The root of the issue lies in the noncompliance of two to three member states, whose overproduction has led to huge financial losses for the organization and, more importantly, damaged its reputation as a disciplined and coherent organization.

Events in the coming weeks may provide more clarity on the future of the oil market, particularly with the anticipated visit of the leader of the world's largest oil-producing country. His meetings with the heads of GCC countries could help stabilize the market, or potentially signal the beginning of a new oil order.

For now, we await the outcomes and their effect on global oil prices. One thing is clear: the current level of \$64 per barrel is unlikely to last. A rebound to around \$70 by year-end seems more probable.

US & China begin trade talks in Geneva amid growing tensions

Swiss govt monitors US tariff impacts on key industries

GENEVA, May 10, (AP): The U.S. Treasury Secretary and America's top trade negotiator began talks with high-ranking Chinese officials in Switzerland Saturday aiming to deescalate a dispute that threatens to cut off trade between the world's two biggest economies and damage the global economy.



Exports to other regions surge

China's exports to US plunge 21% as trade war intensifies

BEIJING, May 10, (AP): China's exports to the United States tumbled in April while its trade with other economies surged, suggesting that President Donald Trump's tariffs offensive is hastening a shakeup in global supply chains.

Total exports from China rose 8.1% last month from a year earlier, much faster than the 2% pace most economists had been expecting. That was much slower than the 12.4% year-on-year increase in March. Imports fell 0.2% in April from the year before.

Shipments to the U.S. sank 21% in dollar terms as Trump's tariffs on most Chinese exports rose to as high as 145%. With Chinese tariffs on U.S. goods at 125%, business between the two biggest economies has grown increasingly

Treasury Secretary Scott Bessent and U.S. Trade Representative Jamieson Greer have begun meetings in Geneva with a Chinese delegation led by Vice Premier He Lifeng.

Diplomats from both sides also confirmed that the talks have begun but spoke anonymously and the exact location of the talks wasn't made public. However, a motorcade of black cars and vans was seen coming and going from the home of the Swiss ambassador to the United Nations delegation in the wealthy city, and a diplomatic source, speaking on condition of anonymity because of the sensitivity of the meeting, said the sides met for about two hours before departing for a previously arranged luncheon.

Prospects for a major breakthrough appear dim. But there is hope that the two countries will scale back the massive taxes - tariffs - they've slapped on each other's goods, a move that would relieve world financial markets and companies on both sides of the Pacific Ocean that depend on U.S.-China trade.

U.S. President Donald Trump last month raised U.S. tariffs on China to a combined 145%, and China retaliated by hitting American imports with a 125% levy. Tariffs that high essentially amount to the countries' boycotting each other's products, disrupting trade that last year topped \$660 billion.

Even before the talks began, Trump suggested Friday that the U.S. could lower its tariffs on China, saying in a Truth Social post that "80% Tariff seems right! Up to Scott.

Sun Yun, director of the China program at the Stimson Center, noted it will be the first time He and Bessent have talked. She doubts the Geneva meeting will produce any substantive results.

"The best scenario is for the two sides to agree to de-escalate on the ... tariffs at the same time," she said, adding even a small reduction would send a positive signal. "It cannot just be words." Since returning to the White House in January, Trump has aggressively used tariffs as his favorite economic weapon. He has, for example, imposed a 10% tax on imports from almost every country in the world.

But the fight with China has been the most intense. His tariffs on China include a 20% charge meant to pressure Beijing into doing more to stop the flow of the synthetic opioid fentanyl into the United States. The remaining 125% involve a dispute that dates back to Trump's first term and comes atop tariffs he levied on China back then, which means the total tariffs on some Chinese goods can exceed 145%.

During Trump's first term, the U.S. alleged that China uses unfair tactics to give itself an edge in advanced technologies such as quantum computing and driverless cars. These include forcing U.S. and other foreign companies to hand over trade secrets in exchange for access to the Chinese market; using government money to subsidize domestic tech firms; and outright theft of sensitive technologies.

Those issues were never fully resolved. After nearly two years of negotiation, the United States and China reached a so-called Phase One agreement in January 2020. The U.S. agreed then not to go ahead with even higher tariffs on China, and Beijing agreed to buy more American products. The tough issues - such as China's subsidies - were left for future negotiations.

But China didn't come through with the prom-

ised purchases, partly because COVID-19 disrupted global commerce just after the Phase One truce was announced.

The fight over China's tech policy now resumes. Trump is also agitated by America's massive trade deficit with China, which came to \$263 billion last year. In Switzerland Friday, Bessent and Greer also met with Swiss President Karin Keller-Sutter.

Trump last month suspended plans to slap hefty 31% tariffs on Swiss goods -- more than the 20% levies he plastered on exports from European Union. For now, he's reduced those taxes to 10% but could raise them again.

The government in Bern is taking a cautious approach. But it has warned of the impact on crucial Swiss industries like watches, coffee capsules, cheese and chocolate.

"An increase in trade tensions is not in Switzerland's interests. Countermeasures against U.S. tariff increases would entail costs for the Swiss economy, in particular by making imports from the USA more expensive," the government said last week, adding that the executive branch "is therefore not planning to impose any countermeasures at the present time." uncertain.

China's imports from the U.S. dropped more than 13% from a year earlier, while its politically sensitive trade surplus with the United States was nearly \$20.5 billion in April, down from about \$27.2 billion a year earlier.

In the first four months of the year, China's exports to the United States fell 2.5% from a year earlier, while imports from the U.S. fell 4.7%.

A potential break in the tariffs stalemate could come as soon as this weekend. Treasury Secretary Scott Bessent and other senior trade officials are due to meet with Chinese officials in Geneva on Saturday. But Beijing and Washington are at odds over a raft of issues, including colliding strategic interests that will may impede progress in the talks.

Some of the punitive tariffs, including Beijing's retaliatory 125% tariffs on U.S. exports, could be rolled back, but a full reversal is unlikely, Zichun Huang of Capital Economics said in a report. "This means China's exports to the U.S. are set for further declines over

"This means China's exports to the U.S. are set for further declines over the coming months, not all of which will be offset by increased trade with other countries. We still expect export growth to turn negative later this year," Huang said.

Whatever the outcome of those discussions, the rapid increase in Chinese exports to other countries reflects a restructuring that began years ago but has gained momentum as Trump has raised barriers to exporting to the U.S.

Global manufacturers have been looking for alternatives to a near total reliance on manufacturing in China after disruptions from the COVID-19 pandemic highlighted the need for more diverse options.

The need for more versatile supply chains grew more apparent as Trump hiked tariffs on Chinese exports during his first term in office. Most of those remained during former President Joe Biden's term.

Exports to the United States accounted for about a tenth of China's total exports in April and the U.S. is still China's largest single-country market. But the European Union and Southeast Asia are larger regional export markets.

Trade with a broader grouping, the 15-nation Regional Comprehensive Economic Partnership (RCEP), which does not include the United States, is still bigger. And exports to countries participating in China's "Belt and Road Initiative," a vast network of Beijing-supported infrastructure projects, are bigger still.

In the first four months of the year, exports to the 10-nation Association of Southeast Asian Nations rose 11.5% from a year earlier, and those to Latin America also climbed 11.5%. Shipments to India jumped nearly 16% by value, and exports to Africa surged 15%.

Some of the fastest growth was in Asia, reflecting moves by Chinese and other manufacturers to diversify their supply chains outside of the Chinese mainland. Most notable were exports to Vietnam, which jumped 18% year-on-year. Exports to Thailand were up 20%.

Back in China, preliminary data have shown a sharp decline in shipping and other trade activity. Earlier this week, Beijing announced a barrage of measures meant to counter the impact of the trade war on its economy, which was already struggling to regain momentum after the pandemic and a lengthy downturn in its housing sector.

Federal Reserve official sees signs of slowing economy but not ready to cut rates

WASHINGTON, May 10, (AP): A top Federal Reserve official said Friday that massive uncertainty created by President Donald Trump's tariffs has caused some businesses to cut back on hiring and spending, threatening to slow the economy, but he added that it's not yet clear whether the central bank should cut its key interest rate.

Tom Barkin, president of the Federal Reserve's Richmond branch, said businesses have turned cautious, though are not yet engaging in steep job cuts or other behavior typical of a recession.

"The way I've been describing it is, it's really hard to drive when it's foggy," Barkin said in remarks to the Loudoun County, Virginia Chamber of Commerce. "That's what I'm seeing on the business side. Hiring freezes, discretionary spending being cut back, but not major layoffs."

Barkin and other Fed speakers Friday underscored the difficult challenge the central bank faces right now. If the tariffs push up inflation, the Fed would keep rates elevated - or raise them further. But if the duties worsen the economy, the Fed

would typically cut rates.

On Wednesday, Chair Jerome Powell said the risks of higher inflation and higher unemployment are rising and that the Fed would wait for greater clarity about where the economy is headed before making its next move. Powell spoke after the Fed kept its key rate unchanged for the third straight meeting.

Trump, however, has continued to assail Powell for not cutting rates, which over time could lower borrowing costs for consumers and businesses.

Trump is pushing for rate cuts because he argues that the economy no longer suffers from the high inflation that spurred the Fed to sharply raise borrowing costs in 2022 and 2023.

But the most likely reason for the Fed to reduce its key rate in the coming months, economists say, would be to offset a sharp slowdown in the economy stemming from the tariffs. As companies see their costs rise because of higher duties - about half of imports are parts used by American companies - they could institute widespread layoffs, pushing up unemployment and risking recession. Gregory Daco, chief economist at EY, a consulting firm, said he thinks the Fed should cut rates soon because "the economy is slowing and will continue to slow and flirt with the recession."

A key challenge for the Fed right now, however, is determining which risk is bigger for the economy, inflation or unemployment.

Barkin said it was too early to say that lower borrowing costs are needed to boost growth.

"We have risks on the inflation side, and if you see as I see that we have risks on the unemployment side, then declaring that one risk is more significant than the other right now feels almost like guessing," Barkin said.

Barkin is one of the 19 officials who participate in the Fed's eight yearly meetings to decide on interest-rate policy. Only 12 of those members vote on the decision. Barkin is not one of the voters this year.

Other Fed officials Friday echoed Barkin's cautious message.

Michael Barr, a member of the Fed's Washington-based board of governors,

Santa Fe celebrates Native designers

Indigenous fashion explores heritage in silk, hides

SANTA FE, N.M., May 10, (AP): Fashion designers from across North America are bringing together inspiration from their Indigenous heritage, culture and everyday lives to three days of runway modeling that started Friday in a leading creative hub and marketplace for Indigenous art.

A fashion show affiliated with the century-old Santa Fe Indian Market is collaborating this year with a counterpart from Vancouver, Canada, in a spirit of Indigenous solidarity and artistic freedom. A second, independent runway show at a rail yard district in the city has nearly doubled the bustle of models, makeup and final fittings.

Elements of Friday's collections from six Native designers ran the gamut from silk parasols to a quilted hoodie, knee-high fur boots and suede leather earrings that dangled to the waste. Models on the Santa Fe catwalks include professionals, dancers and Indigenous celebrities from TV and the political sphere.

Clothing and accessories rely on materials ranging from of wool trade cloth to animal hides, featuring traditional beadwork, ribbons and jewelry with some contemporary twists that include digitally rendered designs and urban Native American streetwear from Phoenix.

"Native fashion, it's telling a story about our understanding of who we are individually and then within our communities," said Taos Pueblo fashion designer Patricia Michaels, of "Project Runway" reality TV fame. "You're getting designers from North America that are here to express a lot of what inspires them from their own heritage and culture." The stand-alone spring fashion week for Indigenous design is a recent outgrowth of haute couture at the summer Santa Fe Indian Market, where teeming crowds flock to outdoor displays by individual sculptors, potters, jewelers and painters.

Designer Sage Mountainflower remembers playing in the streets at Indian Market as a child in the 1980s while her artist parents sold paintings and beadwork. She forged a different career in environmental administration, but the world of high fashion called to her as she sewed tribal regalia for her children at home and, eventually, brought international recognition.

Patterns

At age 50, Mountainflower on Friday presented her "Taandi" collection - the Tewa word for "Spring" - grounded in satin and chiffon fabric that includes embroidery patterns that invoke her personal and family heritage at the Ohkay Owingeh Pueblo in the Upper Rio Grande Valley.

"I pay attention to trends, but a lot of it's just what I like," said Mountainflower, who also traces her heritage to Taos Pueblo and the Navajo Nation. "This year it's actually just looking at springtime and how it's evolving. ... It's going to be a colorful collection."

More than 20 designers are presenting at the invitation of the Southwestern Association for Indian Arts.

Fashion plays a prominent part in Santa Fe's renowned arts ecosystem, with Native American vendors each day selling jewelry in the central plaza, while the Institute for American Indian Arts delivers fashion-related college degrees in May.

This week, a gala at the New Mexico governor's mansion welcomed fashion designers to town, along with social mixers at local galleries and bookstores and plans for pop-up fashion stores to sell clothes fresh off the fashion runway.

A full-scale collaboration with Vancouver Indigenous Fashion Week is bringing a northern, First Nations flair to the gathering this year with many designers crossing into the U.S. from Canada.

Secwépemc artist and fashion designer Randi Nelson traveled to Santa Fe from the city of Whitehorse in the Canadian Yukon to present collections forged from fur and traditionally cured hides - she uses primarily elk and caribou. The leather is tanned by hand without chemicals using inherited techniques and tools.

"We're all so different," said Nelson, a member of the Bonaparte/St'uxwtéws First Nation who started her career in jewelry assembled from quills, shells and beads. "There's not one pan-Indigenous theme or pan-Indigenous look. We're all taking from our individual nations, our individual teachings, the things from our family, but then also recreating them in a new and modern way."

April Allen, an Inuk designer from the Nunatsiavut community on the Labrador coast of Canada, presented a mesh dress of blue water droplets. Her work delves into themes of nature and social advocacy for access to clean drinking water.

Battled cancer

'Fifty Shades' director James Foley dies at 71

LOS ANGELES, May 10, (AP): **James Foley**, a journeyman director best known for "Glengarry Glen Ross," has died. He was 71.

He died earlier this week after a yearlong battle with brain cancer, his representative, Taylor Lomax, said Friday.

In his long and varied career, Foley directed Madonna music videos, 12 episodes of "House of Cards" and the two "Fifty Shades of Grey" sequels, but it was his 1992 adaptation of David Mamet's foulmouthed Pulitzer Prize winning play that stood above the rest. Although it wasn't a hit

at the time, "Glengarry Glen Ross" wormed its way into the culture and grew into an oft-quoted cult favorite, especially Alec Baldwin's madefor-the-film "always be closing" monologue.

Critic Tim Grierson wrote 20 years after its release that it remains "one of the quintessential modern movies about masculinity." He added, "while there are many

fine Mamet movies, it's interesting that the best of them was this one - the one he didn't direct."

Born on Dec. 28, 1953, in Brooklyn, Foley studied film in graduate school at the University of Southern California. Legend has it that Hal Ashby once wandered into a film school party where his happened to be playing at the time and he took a liking to him. Foley would later attribute his ability to make his first feature, "Reckless," a 1984 romantic drama about mismatched teenagers in love starring Daryl Hannah, Aidan Quinn and Adam Baldwin, to the Ashby stamp of approval. It was also the first screenplay credited to Chris Columbus, though there were reports of creative differences. He followed it with the Sean Penn crime drama "At Close Range," the Madonna and Griffin Dunne screwball comedy "Who's That Girl" and the neonoir thriller "After Dark, My Sweet," with Jason Patric. Critic Roger Ebert included "After Dark, My Sweet" in his great movies list, calling it "one of the purest and most uncompromising of modern film noir" despite having been "almost forgotten.'



He also directed several music videos for Madonna including "Papa Don't Preach," "Live to Tell," and "Who's That Girl," and an episode of "Twin Peaks."

Foley adapted John Grisham and worked with Gene Hackman on "The Chamber" and made the Reese Witherspoon and Mark Wahlberg teenage love-gone-scary thriller "Fear," as well as the largely derided Halle Berry and Bruce Willis psychological thriller "Perfect Stranger," which was released in 2007.

De Niro to receive an honorary Palme d'Or

CANNES, France, May 10, (AP): Robert De Niro will receive an honorary Palme d'Or at the Cannes Film Festival, a culmination for the 81-year-old actor whose history with the French film festival stretches back half a century.

In 1976, De Niro starred in two films - Martin Scorsese's "Taxi Driver" and Bernardo Bertolucci's "1900" - that premiered in competition at Cannes. "Taxi Driver" was an immediate sensation, and went home with the festival's top prize, the Palme d'Or.

Since then, De Niro has been a regular on the Croisette, returning with "The King of Comedy" in 1983, Sergio Leone's "Once Upon a Time in America" in 1984 and Roland Joffé's "The Mission" in 1986. Joffé's film also won the Palme, making De Niro the rare actor to star in two Palme d'Or winners.

A flavorful mix of comedy and drama

Schmaltzy and sweet, Vaughn leads 'Nonnas'

LOS ANGELES, May 10, (AP): The new Vince Vaughn movie "Nonnas" aspires to be a bit of cinematic comfort food. It's based on a heartwarming true story, features a lot of shots of simmering Sunday sauces and touts a lovable cast of veteran Italian American actors in Talia Shire, Lorraine Bracco, Brenda Vaccaro and Susan Sarandon. One would hope that those are the kind of ingredients that would be difficult to mess up too badly.

And "Nonnas," streaming on Netflix, is what it wants to be: A glossy, movie version of the local joint. Nothing's groundbreaking or particularly unexpected, the story beats are predictable, and the music choices and Italian American stereotypes a bit cliché. And yet it's done with an evident earnestness and kindness that makes it impossible to write off. Is it a sign of the times that a bunch of people just being kind to one another is basically enough?

"Nonnas" was directed by Stephen Chbosky ("Perks of Being a Wallflower") working off of a script by Liz Maccie, whom he is married to, and based on the true story of a New Yorker named Joe Scaravella (Vince Vaughn) who starts a Staten Island restaurant with Italian grandmothers as the chefs.

Joe has no business savvy or restaurant knowledge, just

an idea after the loss of his own mother and grandmother. He just wants to pay tribute to the way that they always made him feel with their cooking in the kitchen. There's a gauzy, sun soaked flashback to the neighborhood in the 1960s showing a young Joe watching his mother and grandmother make the Sunday sauce that's so idealized, so full of smiles as substitute for character, it might as well be a Prego commercial.

There is an obvious reverence for cultural predecessors like "Moonstruck" and "My Cousin Vinny" baked into "Nonnas," though it can't quite find the natural rhythm that might have made it work better. It whiplashes between big comedic swings (including a food fight between the feuding nonnas) and utter sincerity and it is in no rush to get anywhere fast.

But perhaps the greatest miscalculation is centering the story on Joe instead of the women. The nonnas are met where they are in life - a former nun (Shire), a hair salon owner (Sarandon), a retiree (Bracco) who's estranged from her kids and a widow (Vaccaro) who needs to get out of the house. It seems like there was a missed opportunity to get to know their stories and recipes more. If food is love, give the audience a chance to fall in love with them through their favorite dishes. Instead, they bond not over food or new appreciation of one another's heritage, but a makeover.

Still, it's worth noting that "Nonnas" is not nearly as gimmicky as it could have been. Vaughn is good in a more subdued role - the stereotypes-for-comedy's-sake are left for his friends (Joe Manganiello and Drea de Matteo) to live and die by. A love story with his old prom date (played by Linda Cardellini) feels a little tacked on to everything else, but I suppose is also just another layer to the second chances narrative.

Chbosky and his cinematographer Florian Ballhaus take care to shoot working class Staten Island beautifully, without gimmicks to overromanticize the reality. Even the "before" images of the restaurant have a glint to them, drawing the audience in to see the potential that Joe sees. Be sure to keep watching through the credits for a little real-life coda.

"Nonnas," like comfort food, may be a little obvious, a little safe, but that's the point.

"Nonnas," a Netflix release currently streaming, is rated PG by the Motion Picture Association for "suggestive material, language and thematic elements." Running time: 111 minutes. Two and a half stars out of four.

NEW YORK: Harvey Weinstein's lawyers sought Friday to raise doubts about an ex-model's allegation that he sexually assaulted her in her teens, portraying her as a wannabe actor who tried to leverage the former studio boss.

"You believed that consensual relation with Mr. Weinstein would help you get your foot in the door and become a movie star," defense lawyer Mike Cibella said.

"No, that's not what happened," Kaja Sokola responded. "I never had a consensual relation with Mr. Weinstein." Throughout a day of question-

Inroughout a day of questioning, Cibella sought to suggest that Sokola hadn't told the full story of her interactions with Weinstein. At

one point, Cibella repeatedly asked

whether she invited Weinstein up to a New York apartment - and into the bedroom - where she was staying in 2005. She denied it.

"I didn't want any shortcuts from Mr. Weinstein. I wanted him to be honest with me," Sokola testified at a later point, her voice growing heated.

She said the Oscar-winning producer promised to help her fulfill her acting ambitions but instead "broke my dreams, and he broke my self-esteem."

The Polish psychotherapist has accused Weinstein of re-

peatedly abusing her when she was a teenage fashion model. Some of those allegations fall outside the legal time frame for criminal charges, but Weinstein still faces a criminal sex act charge related to her 2006 claim of being forced into a sexual act. (AP)

NEW YORK: Sean "Diddy" Combs was not treated differently because of his race by prosecutors who brought racketeering and sex trafficking charges against him, a judge ruled Friday as he rejected a request to dismiss some charges three days before opening statements in the hip-hop mogul's trial.

Judge Arun Subramanian said Combs had shown no evidence of discriminatory effect or intent based on his race, when his lawyers made their arguments in Manhattan federal court in February. In a separate written opinion, the judge also refused to suppress evidence in the case.

The lawyers had written that the prosecution was unprecedented because, "most disturbingly, no white person has ever been the target of a remotely similar prosecution."

The judge agreed with arguments by prosecutors that the extent of criminal conduct by Combs from 2004 to 2024 - when he was alleged to have overseen a racketeering enterprise that enabled him to abuse women - was enough to separate the case against him from other prosecutions.

"It's the severity of what Combs allegedly did - not his race - that mattered," the judge wrote.

Subramanian noted that lawyers for Combs had alleged that the government sought to humiliate him through its news releases, the way search warrants were executed at his home, the refusal to let him surrender and alleged leaks to the media. (AP)

 LONDON: In late September 2023, as the first big storm of the fall was kicking up in the UK, a malicious plan was hatched to take down one of England's favorite trees.

Daniel Graham sent a message to his buddy, Adam Carruthers, telling him to "get the saws warmed up," suggesting they might get some work clearing fallen trees.

But it wasn't high winds that brought down the famous Sycamore Gap tree that night, jurors determined Friday. It was Graham and Carruthers — not cleaning up damage from the storm, but creating a mess of their own.

The pair were convicted of two counts each of criminal damage by a jury in Newcastle Crown Court after little more than five hours of deliberations over two days.

Even without the smoking chainsaw, prosecutors were able to prove the case through a trove of digital evidence that either put the men near the tree at the time it was felled or showed them excitedly discussing it the next day as the story of the tree's demise went viral.

The prime piece of evidence was a grainy video on Graham's phone of the crime being committed on the dark and stormy night.

Footage of the tree's last stand showed a solitary figure silhouetted beneath the towering canopy in a struggle with the trunk as the unmistakable sound of the chainsaw whined above the wind. With a single crack, the buzz of the saw died down, the person stepped back and the tree that had stood about 150 years crashed to earth.

Metadata pinpointed the location of the video at the tree's location in Northumberland National Park. Other data showed Graham's Range Rover had traveled there. (AP)

Bush family joins first lady in WH commemoration ceremony

Melania Trump leads stamp unveiling for Barbara Bush

WASHINGTON, May 10, (AP): In the White House's East Room on a rainy Thursday, First Lady Melania Trump and members of the Bush family gathered to unveil a US postage stamp bearing the portrait of for-mer first lady Barbara Bush.

Amid the anticipation of the unveiling, Trump, Bush's daughter Dorothy "Doro" Bush Koch and Judy de Torok, a vice president at US Postal Service, took turns sharing stories chronicling the former first lady's life and achievements.

Bush Koch held back tears recalling moments from her mother's early life. "Mom was never one to shy away from speaking the truth or taking a stand," she said. "With her signature white hair and pearls, she became an icon in her own right, and yet, even as a former first lady, she remained humble and humorous.

The image on the stamp is Barbara Bush's official White House portrait, which currently hangs in the entrance to the East Wing. She is depicted in a black suit and purple blouse, wearing her hallmark triple strand of pearls.

After a commemoration ceremony in Kennebunk-

After a commentoration ceremony in Kennebunk-port, Maine, where the Bush family compound is lo-cated, the stamp will go on sale June 10th. Bush notably championed literacy programs and helped destigmatized people with AIDS and HIV when she cradled an infant during a 1989 visit to a hospice for children with the disease. Trump said hospice for children with the disease. Trump said Bush "changed the national conversation on AIDS and took a stand supporting gay rights.

Trump also said she appreciated how Bush inspired people to pursue their personal dreams and was ahead of her time when she made the call for a female American president. "Who knows?" Trump said. "Somewhere out in

this audience may even be someone who will one day follow in my footsteps and preside over the White House, and I wish him well," she said to laughs.

Barbara Bush died in 2018 at 92 years-old. She was married to President George H. W. Bush. She is the mother of former President George W. Bush.

She was one of only two first ladies who had a

child who was elected president. The other was Abi-gail Adams, wife of President John Adams and mother of President John Quincy Adams.

And in 2016 - at 90 years-old - Barbara Bush cam-paigned for her son, former Florida Gov. Jeb Bush when he vied for the Republican presidential nomi-nation, according to the George H. W. Bush library.

She had strong words for Donald Trump - back in 2016 she said in a joint CNN interview with Jeb Bush that she was "sick" of the current president. "He's said terrible things about women, terrible things about the military. I don't understand why people are for him, for that reason," she said at the time.

Melania Trump attended Bush's funeral in 2018 while Donald Trump did not attend. The White House said he stayed away to avoid security disruptions.

Bush is the eighth first lady to be honored with a US postage stamp. Bush Koch said "it's unlikely that mom ever pictured herself on the postage stamp, and it's very likely that she would be wondering what all this fuss is about.

Lainey Wilson rules 2025 ACM Awards

NEW YORK, May 10, (AP): It was her night once again. Lainey Wilson took home the top prize at the 60th annual Academy of Country Music Awards - the title of entertainer of the year - for a second year in a row. And that was after she cleaned house, taking home trophies for both female artist and album of the year.

"I really do have the best fans in the world," she said in her final acceptance speech, admitting to experiencand speech, admitting to experienc-ing impostor syndrome. "I dreamed about entertaining. ... Country music has given me more than I deserve."

Beyond Wilson's dominance, the 2025 ACM Awards were packed with celebration. Earlier, first-time and leading nominee Ella Langley's duet with Riley Green, the ubiquitous "You Look Like You Love Me," was named single and music event of the year.

Both Langley and Green used their first acceptance speech to shout out classic country - songs with talking in them - that inspired their modern hit.

A revisitation of the past might have been a theme Thursday night, evidenced right at the top of the ceremony: a 14-minute medley of six decades of country classics, performed by giants of the genre.

Host Reba McEntire launched into Merle Haggard's "Okie from Musko-Merle Haggard's "Okle from Musko-gee," followed by Clint Black with Glen Campbell's "Rhinestone Cow-boy" and Wynonna Judd with The Judds' "Why Not Me." LeAnn Rimes returned to the ACM Awards stage for her 1997 ballad "Blue." Little Big Town tackled their 2014 track "Girl Crush and Dan + Shay delivered their "Tequila." It was an exciting way to kick off the ACM Awards, live from the Ford Center at The Star in Frisco, Texas, just north of Dallas. And it was a show highlight, rivaled only by the introduction of the ACM Alan Jackson Lifetime Achievement Award, the inaugural trophy given to its namesake, Jackson, after he performed "Remember When. In his acceptance speech, he joked that a fan named a dog after him. Having an award named after him? That isn't half bad, either. The first trophy of the night, the coveted song of the year, was awarded to Cody Johnson for his radio hit "Dirt Cheap. Performances followed, fast and furious. McEntire, Wilson and Miranda Lambert teamed up for the world premiere of their new single "Trailblazer," celebrating women in country music.

It's back on the bikes for Ewan and Charley

NEW YORK, May 10, (AP): The last time Ewan McGregor and Charley Boorman went on a motorcycle adventure, they rode cutting-edge, electric Harley-Davidsons. For their latest trip, they took a trip back in time.

The British best friends and actors chose to use vintage bikes this time as they ride through 17 European countries for Apple TV+'s "Long Way Home," the fourth installment of their popular road trip docuseries. It starts airing Friday.

McGregor picked a 1974 Moto Guzzi Eldorado, which was used as a patrol bike by the Los Angeles Police Department and California Highway Patrol. Boorman picked a rusted-out BMW R75/5 and scrambled to make it road worthy.

They spent about two months on the road before finishing at Boorman's home in England, taking time to enjoy the scenery more this time and reducing their speed.

"We were doing a loop of Europe. We weren't covering days and days getting across far eastern Russia, where the landscape barely changes. On those BMWs, we could ride at 80 miles an hour, 90 miles an hour," says McGregor. "We didn't need to do that on this loop. So riding at 60, 65 is a nice speed to go at," he adds.

Motörhead legend Lemmy's statue unveiled in England

LONDON, May 10, (AP): A decade after his death, Lemmy, the frontman of the legendary British heavy metal band Motörhead, will stand tall and proud in his hometown in the north of England.

Well, his statue will.

Inside the statue though will be some of Lemmy's ashes, so it will no doubt become a shrine for Motörhead's legion of fans around the world. And indeed it was on Friday, as the statue to the hard-living Lemmy - real name Ian Kilmister - was unveiled in Burslem, Stoke-on-Trent.

Black leather and denim jackets emblazoned with Lemmy's image were the norm for the day on a bright and sunny day in the northern English town. No wonder, many fans opted for a thirst-quencher at the local pub. There were even some Lemmy lookalikes.

Lemmy was the only continuous member of Motörhead, which he cofounded in 1975 after he was fired from another legendary rock band, Hawkwind, following a drug possession arrest at the Canadian border.

So he decided to go his own way and Motörhead helped pioneer heavy metal music in Britain - and around the world - with a string of high-octane albums, perhaps most memorably with 1980's "Ace Of Spades."

The statue was crafted by acclaimed local sculptor and lifelong Motörhead fan Andy Edwards - who is bestknown for his statue of the Beatles on Liverpool's Pier Head. It captures

Lemmy, who died from cancer in December 2015 at the age of 70, in his iconic pose with his bass guitar.

In December, following his will's instructions, another batch of Lemmy's ashes were installed in an urn shaped like his trademark cavalry hat at the Stringfellows gentlemen's club in London where he was "a regular."

That and Friday's ceremony are part of the "Lemmy Forever!" movement, which sees the rocker enshrined in many of his favorite spots around the world.

Lemmy's legendary status was evident at his funeral, which saw rock heavyweights including The Foo Fighters' Dave Grohl, Guns N' Roses guitarist Slash and Metallica members Lars Ulrich and Robert Trujillo pay tribute.

A new study looks at which types

Cancer diagnoses before age 50 increasing in the US

NEW YORK, May 10, (AP): Cancer before age 50 is rare, but increasing, in the United States and researchers want to know why

A new government study provides the most complete picture yet of early-onset cancers, finding that the largest increases are in breast, colorectal, kidney and uterine cancers. Scientists from the National Cancer Institute looked at data that included more than 2 million cancers diagnosed in people 15 to 49 years old between 2010 and 2019.

Of 33 cancer types, 14 cancers had increasing rates in at least one younger age group. About 63% of the early-onset cancers were among women.

"These kinds of patterns generally reflect something profound going on," said Tim Rebbeck of Dana-Farber Cancer Institute, who studies cancer risk and was not involved in the research. "We need to fund research that will help us understand.'

The findings were published Thursday in Cancer Discovery, a journal of the American Association for Cancer Research.

The researchers compared cancer rates in 2019 to what would be expected based on 2010 rates.

Breast cancer made up the largest share of the excess cancers, with about 4,800 additional cases. There were 2,000 more colorectal cancers compared with what would be expected based on the 2010 rates. There were 1,800 more kidney cancers and 1,200 additional uterine cancers.

Reassuringly, death rates were not rising for most cancers in the young adult age groups, although increasing death rates were seen for colorectal, uterine and testicular cancers.

Explanations will take more research. The big databases used for the study don't include information on risk factors or access to care. Theories abound and a big meeting is planned later this year to bring together experts in the area.

"Several of these cancer types are known to be associated with excess body weight and so one of the

leading hypotheses is increasing rates of obesity,' said lead author Meredith Shiels of the National Cancer Institute.

Advances in cancer detection and changes in screening guidelines could be behind some early diagnoses.

For breast cancer, the trend toward women having a first child at older ages is a possible explanation. Pregnancy and breastfeeding are known to reduce risk.

This isn't happening across the board. Cancer rates in people under 50 are going down for more than a dozen types of cancer, with the largest declines in lung and prostate cancers.

Cigarette smoking has been declining for decades, which likely accounts for the drop in lung cancer among younger adults.

The drop in prostate cancer is likely tied to updated guidelines discouraging routine PSA testing in younger men because of concerns about overtreatment

Al helps road rage victim confront 'killer' in court

CHANDLER, Ariz., May 10, (AP): There were dozens of statements submitted to the court by family and friends of Christopher Pelkey when it came time to sentence the man convicted of fatally shooting him during a road rage incident. They provided glimpses of Pelkey's humor, his character and his military service.

But there was nothing quite like hearing from the victim himself - even if it was an AI-generated version.

In what's believed to be a first in US courts, Pelkey's family used artificial intelligence to create a video using his likeness to give him a voice. The AI rendering of Pelkey told the shooter during the sentencing hearing last week that it was a shame they had to meet that day in 2021 under those circumstances and that the two of them probably could have been friends in another life.

"I believe in forgiveness and in God who forgives. I always have and I still do," Pelkey's avatar told Gabriel Paul Horcasitas

The AI version of Pelkey went on to share advice for people to make the most of each day and to love each other, not knowing how much time one might have left.

While use of artificial intelligence within the court system is expanding, it's typically been reserved for administrative tasks, legal research and case preparation. In Arizona, it's helped inform the public of rulings in significant cases.

Using AI to generate victim impact statements marks a new - and legal, at least in Arizona - tool for sharing information with the court outside the evidentiary phases.

Maricopa County Superior Court Judge Todd Lang, who presided over the road rage case, said after watching the video that he imagined Pelkey, who was 37 at the time of his killing, would have felt that way after learning about him.

First at-home test kit for cervical cancer approved by the US FDA

Ovarian cancer advisory group launched

WASHINGTON, May 10, (AP): US regulators have approved the first cervical cancer testing kit that allows women to collect their own sample at home before shipping it to a laboratory, according to a medical device company.

Teal Health said Friday the Food and Drug Administration approved its Teal Wand for home use, offering a new way to collect vaginal samples that can detect the HPV virus that causes cervical cancer. Currently, HPV tests and Pap smears are performed at a health clinic or doctor's office.

An influential federal panel recommended last year the use of self-collection of HPV samples to boost screening. The FDA also recently expanded the use of two older HPV tests for selfcollection, but those must be done at a medical office or mobile clinic.

HPV, or human papillomavirus, is very common and is spread through sex. Most HPV infections clear up on their own, but persistent infection can lead to cancer of the cervix. Most cervical cancers occur in women who are inadequately screened, diagnosed or treated.

To collect a sample, a swab or brush is inserted into the vagina and rotated, then the swab is put into a tube or container and processed at a lab. Teal Health's kit requires a pre-

scription, which customers can obtain through one of the company's online health providers. The San Francisco-based company said it will initially beginning selling the kits in California next month before expanding to other states. The company also said it is working with insurers on health coverage for the test.

Asbestos clinic forced to close

Plavix suit

BILLINGS, Mont., May 10, (AP): An asbestos screening clinic in a small Montana town where thousands have been sickened by toxic dust from a nearby mine has been abruptly shuttered by authorities following a court order to seize the clinic's assets to pay off a judgment to the railroad BŃSF.

The Lincoln County Sheriff's Office closed on Wednesday the Center for Asbestos Related Disease in Libby, about 50 miles (80 kilometers) from the US-Canada border. The town of about 3,000 people is near a mine that produced asbestos dust for decades, and the clinic has been at the forefront of efforts to help victims.

Courts in Montana have said BNSF contributed to the pollution when it brought contaminated material from the mine through town, and the railway separately faces numerous lawsuits from asbestos victims in Libby and surrounding communities.

But the Texas-based railway prevailed in a 2023 lawsuit alleging the clinic fraudulently made some patients eligible for government benefits when it knew they were not sick. The railway challenged the validity of over 2,000 diagnoses by the clinic and 337 were ruled false.

The railway brought the lawsuit on behalf of the federal government, which provides specialized Medicare services to Libby's asbestos victims. BNSF was entitled to a share of the \$6 million judgment against the clinic, and after adding in attorney fees, court costs and interest, the railway says it's now owed \$3.1 million.

Blood thinner: Pharmaceutical companies have agreed to pay Hawaii \$700 million to settle its lawsuit over the efficacy and safety of the blood thinner Plavix, the state attorney gen-

eral's office announced Friday.

US state to ban cellphone use in K-12 public schools

MONTGOMERY, Ala., May 10, (AP): Alabama will soon join the states that have banned or restricted the presence of cellphones in schools.

The Alabama Senate on Wednesday voted 30-2 for the bill to prohibit students in K-12 public schools from using phones during the school day. The phones must be "turned off and stored off their person in a locker, car or similar storage location" during the instructional day.

The bill now goes to Alabama Gov. Kay Ivey for her signature. Ivey used a portion of her State of the State address earlier this year to urge lawmakers to pass the cellphone ban. "In the school systems where this has been implemented, it has worked," Republican Sen. Donnie Chesteen said.

Many schools already ban the use of the devices. The legislation will require all school systems to do so. The Alabama bill leaves it up to schools on how to store the devices

NEW YORK, May 10, (AP): US regulators said Friday that they would allow three new color additives made from natural sources to be used in the nation's food supply.

It comes after health officials pledged a sweeping phase-out of petroleum-based dyes widely used in foods from cereals to sports drinks to boost health - though action is still pending.

The Food and Drug Administration said it is granting petitions to allow galdieria extract blue, a blue color derived from algae; calcium phosphate, a white color derived from a naturally occurring mineral; and butterfly pea flower extract, a blue color made from dried flower petals

The colors will be approved for use in a range of foods from fruit drinks and yogurt to pretzels, ready-to-eat chicken and candies. The move "will expand the palette of available colors from natural sources for manufacturers to safely use in food," FDA officials said in a statement.

Health advocates have long called for the removal of artificial dyes from foods, citing mixed studies indicating the dyes can cause neurobehavioral problems for some children, including hyperactivity and attention issues. The FDA has maintained

for decades that the approved dyes are safe and that "the totality of scientific evidence shows that most children have no adverse effects when consuming foods containing color additives.'

The new color approvals include a 2021 petition from the French company Fermentalg to allow galdieria extract blue; a 2023 petition from Innophos Inc. of Cranbury, New Jersey, to allow calcium phosphate; and a 2024 petition from Sensient Colors LLC of St. Louis, Missouri, to allow butterfly pea flower extract.

The approvals are set to be published in the federal register on May 12 and would take effect in June

In April, Health Secretary Robert F. Kennedy Jr. and FDA Commissioner Marty Makary announced that they would take steps to eliminate synthetic food dyes in the U.S. food supply by the end of 2026, largely through voluntary efforts from the food industry. The officials also said they would revoke authorization for two little-used artificial dyes, Citrus Red No. 2 and Orange B, and accelerate the timeline to remove Red 3, a food color banned in January because of a link to cancer in laboratory rats.

But before an appeal was decided, a settlement was reached for the lower amount, the attorney general's office said.

A statement distributed by Sanofi said the companies "are pleased to resolve this litigation, and to continue their companies' focus on discovering, developing, and delivering innovative medicines to patients.



India suspends IPL for a week as Pakistan postpones PSL

MUMBAI, India, May 10, (AP): India's biggest domestic cricket tournament was suspended for one week on Friday following the escalating military tensions with Pakistan.

The Indian Premier League, which features top players from around the world and attracts hundreds of millions of TV viewers, was halted with immediate effect, the Board of Control for Cricket in India said.

"Further updates regarding the new schedule and venues of the tournament will be announced in due course after a comprehensive assessment of the situation in consultation with relevant authorities and stakeholders." the BCCI said in a statement.

The decision came after a night of artillery exchanges between Indian and Pakistani soldiers across their frontier in Kashmir, amid a growing military standoff that erupted following an attack on tourists in the India-controlled portion of the disputed region.

The IPL is the most popular cricket tournament in the world and runs between March and May. This year it has featured 65 international cricketers from Australia, New Zealand, South Africa, Sri Lanka, West Indies, England and Afghanistan.

The 10-team competition still has 12 games to be played in the group stage before the knockout rounds. The final had been scheduled for May 25 in Kolkata. Overseas cricketers and broadcast staff were given permission to fly out to their

respective home countries, reducing the chance that the tournament would be resumed. There about 70 overseas players in the IPL this season.

The BCCI said the decision to suspend the tournament was made "in the collective interest of all stakeholders.'

"While cricket remains a national passion, there is nothing greater than the Nation and its sovereignty, integrity, and security of our country," the BCCI statement said.

The suspension comes after the match between Punjab Kings and Delhi Capitals in Dharamsala in northern India was abandoned on Thursday evening when the power went out during a government-mandated blackout. Players from both teams returned by train late Friday to New Delhi.

The Pakistan Cricket Board postponed its Pakistan Super League following rising military tensions between India and Pakistan.

'Cricket, while being a unifying force and a source of joy, must take a respectful pause," the PCB said in a statement.

The PCB said it acted on advice from Pakistan Prime Minister Shehbaz Sharif. The PCB had earlier confirmed the relocation of eight remaining PSL matches to Dubai, United Arab Emirates, citing growing concerns among overseas players and the need to prioritize their safety.

But the latest announcement said the PSL was being postponed and gave no indication whether this year's edition would resume at some point.

Rawalpindi, Multan and Lahore had been scheduled to host the remaining PSL games

On Thursday, an Indian drone fell inside the complex of the Rawalpindi Cricket Stadium hours before the start of a PSL game in which several cricketers from New Zealand, Australia, West Indies, South Africa and England were due to compete

PCB chairman Mohsin Naqvi, who is also interior minister in the Pakistan government, held meetings with foreign cricketers and six franchise owners of the PSL before initially saying the tournament was being moved to Dubai.

England cricketer Sam Billings, New Zealand's Colin Munro, South African Rilee Rossouw and Jason Holder of West Indies were among 43 foreign cricketers competing in the PSL.

"We have sincere regard for the mental well-being of participating players and the sentiments of our foreign players, and we respect the concerns of their families who want to see them back home," the PCB said.

The PSL, in its 10th edition, started in the UAE in 2016. UAE hosted the first two editions of the PSL, except for the final in 2017, and also some of the games in 2021 during the COVID-19 pandemic.

Rossouw's Quetta Gladiators leads the points table and has already qualified for the playoff stage while Multan Sultans, led by Pakistan's Mohammad Rizwan, was eliminated after losing eight of its nine league games.

Itoje picked as captain of Lions for Australia tour

LONDON, May 10, (AP): Maro Itoje will captain a British and Irish Lions squad for the rugby tour of Australia that contains 15 Irish players, just two Welshmen and an Englishman with only one international cap to his name.

The 38-man squad was announced on Thursday in front of an audience of more than 2,000 rugby fans at The O2 arena in London, with the 30-year-old Itoje becoming first English player to captain the Lions since Martin Johnson in 2001. The lock will be heading on his third tour, after 2017 and 2021.

When his name was read out by Lions coach Andy Farrell, Itoje walked out in full Lions uniform - holding the lion mascot, Bill - to warm applause.

"It's a tremendous honor and a tre-

mendous privilege," Itoje said. He revealed he got a phone call from Farrell on Tuesday but could barely hear him speak because it was a bad line. After hanging up, Farrell needed to phone Itoje back to offer him the captaincy.

Itoje is England captain but only since January. He has just led his country to a second-place finish in the Six Nations and has made 93 caps for England across nine years.

Itoje's path to the Lions captaincy might have been cleared by Caelan Doris, the Ireland captain, who inrugby since the 2023 World Cup, after which he stepped down from national duty to protect his mental health. He has since quit English rugby and moved to France to play for Racing 92 in Paris.

Only Ireland has more players than England's 13. Scotland will have eight representatives and just two are from Wales - scrumhalf Tomos Williams and flanker Jack Morgan - with their nation on a losing run of 17 tests stretching back to 2023. It's Wales smallest representation since World War II.

"It's the top of the mountain - you can't get higher than this achievement," said Williams, who shed a tear when he heard his name announced.

The Lions won the test series against the Wallabies the last time they toured Australia, in 2013. They have since drawn the series against New Zealand in 2017 and lost in South Africa in 2021.

For the latest tour, the Lions will play three tests against the Wallabies, along with six more games in Australia - against Western Force, Queensland Reds, NSW Waratahs, ACT Brumbies, an Invitational Australia and New Zealand XV, and a First Nations and Pasifika XV.

The tour begins with a match against Argentina in Dublin on June 20 and ends with the series-closing third test on Aug. 2.

The other NBA MVP front-runner, Shai Gilgeous-Alexander, also had a tough night, missing 15 of 22 shots, going 1 for 6 from deep and finishing with 18 points. Jalen Williams led OKC with 32 points and Chet Holmgren chipped in 18.

Game 4 is Sunday at Ball Arena. It was tied at 102 after regulation, and both Gilgeous-Alexander and Jokic missed potential winners in the closing seconds of regulation. SGA missed a 12-foot jumper with 3 seconds left, and Joker missed a 19-footer at the buzzer.

After getting blown out by 43 points in Game 2, the Nuggets knew

The Thunder took a 56-51 halftime lead thanks to Holmgren's 16 points and seven boards. Porter, who was a combined 3-for-18 from the floor in Oklahoma City, made his first five shots, three from deep, to keep Denver close.

Reminiscent of last year when

Jokic showed up for a playoff game at Ball Arena dressed as Gru from Despicable Me, the Joker arrived Thursday night dressed as, well, the Joker, the DC Comics villain version.

Cavaliers 126, Pacers 104

In Indianapolis, Donovan Mitchell refused to let another fourthquarter lead slip away from the Cleveland Cavaliers.

So with home fans on their feet, expecting their Indiana Pacers to cut what had been a 24-point deficit to single digits, Mitchell took the game into his own hands. He hit a 13-foot fadeaway, then a pull-up 3-pointer

and finally found Max Strus for another 3 and the Cavaliers went on to a 126-104 victory.

The road team has won all three games, and the Pacers will have another chance to break that trend Sunday in Game 4.

But Cleveland was desperate to avoid falling into a 3-0 hole and used everything in its arsenal to hold.
