

Kuwait Acting Prime Minister Sheikh Fahad Yousef Saud Al-Sabah on Tuesday held official round table discussions with Chief Executive of the Hong Kong Special Admin-istrative Region John Lee Ka-chiu at Bayan Palace

During the session, they reviewed the bilateral ties and ways to boost them, in addi-tion to exchanging visions and opinions on regional and international issues of common interest



Trio convicted of manslaughter

KUWAIT CITY, May 13: The Misdemeanor Court, presided over by Judge Anwar Bastaki, has sentenced three defendants in the Mangaf fire case to three years in prison on charges of manslaughter.

Two additional defendants received one-year prison sentences for perjury, while four others were each sentenced to one year in prison for harboring a fugitive.

The Public Prosecution referred the case -- related to a fire incident at a

The case was classified as a misdemeanor, not a felony, based on technical reports confirming that the fire was unintentional.

Earlier, the detention renewal judge ordered the release of eight defendants on bail of KD300 each -- one Kuwaiti, three Indians and four Egyptians.

Trump, Saudi Crown Prince initial landmark agreements

RIYADH, May 13, (AP): U.S. President Donald Trump signed a host of economic and bilateral cooperation agreements in Saudi Arabia on Tuesday as he kicked off a four-day Middle East trip with a focus on dealmaking with a key Mideast ally while shared concerns about Iran's nuclear program and the war in Gaza dragged on in the background.

Saudi Crown Prince Mohammad bin Salman Al-Saud warmly greeted Trump as he stepped off Air Force One at King Khalid International Airport in the Saudi capital. The two leaders then retreated to a grand hall at the Riyadh airport, where Trump and his aides were served traditional Arabic coffee by waiting attendants wearing ceremonial gun belts.

"I really believe we like each other a lot," Trump said later during a brief appearance with the crown prince at the start of a bilateral meeting

They later signed more than a dozen agreements to increase cooperation between their governments' militaries, justice departments and cultural institutions. Additional economic agreements were expected to be inked later Tuesday at a U.S.-Saudi investment conference convened for the occasion.

Crown Prince Mohammad bin Salman has already committed to some \$600 billion in new Saudi investment in the U.S., but Trump teased \$1 trillion would be even better.

The pomp began before Trump even landed. Royal Saudi Air Force F-15s provided an honorary escort for Air Force One as it approached the kingdom's capital - an exceptionally rare sight.

KFF warns public

180 lives lost to fires, accidents

KUWAIT CITY, May 13: Director of the Public Relations and Media Department at Kuwait Fire Force (KFF) Brigadier General Mohammad Al-Gharib revealed that the number of deaths resulting from fires and traffic accidents reached 180 last year and 44 in the first quarter of this year.

Al-Gharib said the main causes of fire during summer are high temperatures, misuse of electrical appliances, and unsafe storage of flammable materials.

In an interview with the newspaper, he affirmed that KFF and all of its centers are fully prepared to deal with various reports; citing the continuous upgrading of equipment and machinery.

KUWAIT CITY, May 13: Minister of Health Dr. Ahmed Al-Awadhi issued Ministerial Resolution No. 93/2025, stipulating the pricing structure for 69 medications and pharmaceutical preparations in private pharmacies.

This decision aims to ensure the safety and quality of treatment, while achieving balance between economic efficiency and the standard of healthcare provision.

Based on the recommendations of the Drug Pricing Committee, this resolution complements Ministerial Resolution No. 74/2023. Its principal objective is to heighten the ongoing regulatory oversight of the pharmaceutical market and to control prices;



GCC municipal officials nod proposals, before Thursday meeting

KUWAIT CITY, May 13, (KUNA): The 41st meeting of the Committee of Senior municipal officials in the GCC countries approved several important proposals in preparation to the 28th ministerial meeting scheduled to be held on Thursday.

In their meeting on Tuesday, chaired by Director Gen-eral of Kuwait Municipality Manal Al-Asfour, they approved the guide to waste management system, which was submitted by Kuwait in preparation for presenting it to the 28th ministerial meeting.

During the meeting, they also discussed urban environment, the guide to integrated waste management system towards a circular economy in the GCC, as well as the guide to afforestation of cities and sustainable mobility options.

The committee approved the Urban Design Guide in GCC States as a guide and assigned the General Secretariat to submit it to the ministerial meeting for adoption, in addition to approving the adoption of a report on sustainable mobility options.

The committee urged Member States to adopt guide for the use of solar panels in the GCC, and agreed to adopt the manual of the mechanism of classifying contractors in its second edition for the year 2024 as a guide and assign the General Secretariat to brief the ministerial meeting.

The committee also approved the establishment of the GCC Urban Research Center, which was sponsored by the Kingdom of Saudi Arabia and hosted at the College of Architecture and Planning at King Saud University in Riyadh.

Proposals

The meeting concluded with the adoption of many other recommendations and proposals.

Minister of Information and Minister of State for Youth Affairs Abdulrahman Al-Mutairi said on Monday the 28th GCC information ministers' meeting was held amid accelerated international variables and important regional developments that necessitate further coordination, integration and cooperation among GCC media.

Chairing the meeting, Al-Mutairi conveyed the greetings of His Highness the Amir Sheikh Meshal Al-Ahmad Al-Jaber Al-Sabah, His Highness the Crown Prince Sheikh Sabah Khaled Al-Hamad Al-Sabah and His Highness the Prime Minister Sheikh Ahmad Abdullah Al-Ahmad Al-Sabah to the conferees.

Media has become an effective factor in formulating paths and public opinions, and defending "our Gulf identity, security and stability", he said.

Thus, developing joint Gulf media action is a top priority and a strategic necessity implied by the current challenges, topped with the accelerating digital transformation and knowledge spreading, he noted.

'We have achieved, thanks to Allah and then the GCC leaders, tangible steps in developing media cooperation mechanisms," he noted.

He hoped that the meeting would be a new phase in boosting cooperation through backing common initiatives and projects, and unifying media messages as well increasing joint training and cooperating in technical legislations.

The minister reiterated the importance of the Gulf media's role in raising awareness of societies and transferring truth in a manner that shows "our principled" stances and embodies solidarity values.

He expressed congratulation on the re-launch of common application of GCC news agencies, an advanced move toward bolstering joint Gulf media action.

Al-Mutairi expressed appreciation to Qatar represented in head of Qatar Media Corporation Sheikh Hamad bin Thamer Al-Thani to the outstanding presidency of the previous period that showed Qatar's constant commitment to backing and boosting common efforts for

recovery in all fields. He also thanked GCC General Secretariat, topped with General Secretary Jassem Al-Budaiwi, for outstanding efforts made in preparing and organizing this meeting, and the staff of the Information Ministry.

Meanwhile, GCC chief Al-Budaiwi expressed great thanks to His Highness the Amir, the current President of GCC Supreme Council, for Kuwait's support to the joint Gulf action, and to the minister for hosting this gathering.

GCC states have a prestigious position on international and regional media map, thanks to the directives of GCC leaders who have paid much attention to Gulf media to be a tool and a bridge for communication, Al-Budaiwi pointed out.

Challenges

This comes in light of accelerated technical and media challenges in the world that require keeping pace with these developments through expanding the horizons of integration and cooperation among GCC media institu-tions, and building partnerships with international and regional media platforms, he stated.

The meeting was held, within the framework of the GCC leaders' directives, to enhance the pivotal role of common Gulf media in highlighting the council's achievements over four decades, he said.

Media challenges facing GCC States require closer collaboration and integration than ever, he said, referring to systematic media campaigns and false information that target the security of "our states, undermine their societies' cohesion and seek to drive a wedge among our nations".

Al-Budaiwi underlined the need of intensifying joint efforts to confront these hostile campaigns, and fake and offensive accounts that target Gulf unity, extolling the key and valuable endeavors of member states in supporting Gulf media initiatives and projects seeking to raise awareness, education, strengthen common Gulf identity, and highlight achievements.

He elaborated that the meeting's agenda included many deep and key topics, including joint Gulf media themes and initiatives formulated and presented by GCC States' media agencies committees.

Al-Budaiwi congratulated the GCC states on the relaunch of the new joint application of GCC States' news agencies.

Enemies within ... betrayals cause of regional 'disgrace'

"RECENTLY, a strange synergy has emerged, one that anyone familiar with media dynamics and its influence on public opinion would easily recognize", Kuwaiti journalist Sami Al-Enezi wrote for Al-Seyassah daily.

"This synergy involves a coali-tion of intellectual deviants, secularists, the weak-minded, and even some who claim to be Salafis, all uniting to attack the Muslim leader Salah al-Din al-Ayyubi. They accuse him of being an innovator and of mobilizing the army without consulting the ruler, despite the

fact that he himself was the ruler at the time

"These individuals are employing the same tactics they use against the Islamic Resistance Movement, Hamas. In doing so, they have revealed the depth

and the emptiness of their ideas, which will never revive the dignity or glory of this nation.

"As media professionals, we understand well that their ultimate aim is to mislead the public. Behind the scenes, there are clearly orchestrated plans underway to undermine Hamas. The objective appears to be the instigation of an armed conflict between Hamas and Mahmoud Abbas, followed by the intervention of Arab armies under the pretext of defending Abbas, who enjoys recognition by the UN Security Council. This would provide the perfect opportunity to weaken or eliminate Hamas and pressure it into surrendering its weapons.

"The claim that Palestinian women and children have suffered because of Hamas is false. In truth, they have paid the price because of betrayal and the shameful silence of the Arab League, which has shown sympathy toward every enemy of Hamas and Islamic Jihad in their struggle to liberate Al-Aqsa Mosque.

"Meanwhile, the Palestinian Authority in Ramallah appears to be preparing to hand over Fatah's weapons to the United Nations. The aim is to embarrass the mujahideen and pressure them into disarmament as well. After that, all we will hear are stories glorifying the supposed heroism of the Arab armies."

Also:

"Wise people should strive to be sincere in everything they say and do, always aiming to draw closer to God Almighty", Kuwaiti writer **Dr. Khaled Al-Janfawi** wrote for **Al-Seyassah** daily.

"However, they must also avoid excessive loyalty and devotion at the expense of their own well-being or that of their family. One cannot remain loyal and faithful to someone who does not reciprocate the same attitude.

"In today's turbulent world, wise individuals must practice balance and moderation in their loyalty. Some manifestations of excessive loyalty that should be avoided include: 1. One-sided loyalty and devotion - Loyalty and devotion in human relationships should be mutual. If the other party does not return the same sincerity and commitment, it is neither wise nor required to continue investing time and effort in an exploitative or toxic relationship. 2. Loyalty at the expense of personal and family priorities - Everything becomes harmful when taken to extremes. Prioritizing others to the extent that it negatively impacts one's personal and family responsibilities can lead to undue hardship. Loyalty should never exceed the bounds of reason or come at the cost of legitimate personal needs. 3. Loyalty to someone who breaks promises - A rational Muslim is required to be loyal and devoted to God through worship, good deeds, and adherence to religious obligations. However, there is no obligation to remain faithful to someone who constantly breaks promises and fails to uphold basic moral standards. Continuing to trust someone who repeatedly betrays you is not virtuous, but it is foolish. 4. Excessive remorse and self-blame - A conscientious person naturally feels guilt when they wrong others or fall short of their values. However, excessive self-reproach over human mistakes is unnecessary and harmful. Sincere repentance is sufficient.

"In the chaos and panic that follow a natural or man-made disaster, mobile phone networks transition from being tools for entertainment and communication to essential lifelines. In times of uncertainty and danger, these networks become vital links, connecting individuals to one another, to rescue and relief agencies, and to the outside world", columnist Waleed Saleh Al-Qallaf wrote for Al-Jarida daily.

"The continued operation of mobile phone networks during disasters is not just a luxury but it is a necessity to save lives, alleviate suffering, and expedite recovery. In the critical moments following a disaster, these networks enable people to contact loved ones, check on their well-being, and share information about their safety. They also allow those affected to request help and report injuries, damage, or missing persons to rescue and relief teams.

"This quick communication can be the difference between life and death. Rescue teams rely heavily on mobile phone networks to receive reports from affected individuals, identify the most severely impacted areas, and facilitate the exchange of vital information between various crisis management agencies, ensuring a more effective and efficient response

"The COVID-19 pandemic serves as a prime example of the importance of mobile phones. They played a key role in delivering reliable information to the public, reducing panic, and spreading warnings, alerts, and updates on the evolving situation. Mobile phones also helped monitor quarantined individuals, ensuring they stayed home and did not interact with others, thus protecting themselves and their families.

"Despite their importance, mobile phone networks face significant challenges during disasters, such as power outages, infrastructure damage, and a massive surge in call and data volume.

"I vividly recall the Kuwait Telecommunications Regulatory Authority hosting the United Nations International Telecommunication Union (ITU) conference in January 2016. Titled GET-2016, it highlighted the important role of telephone networks during disasters. Some developed countries, such as Japan, shared insights from their experience during the 2011 Tohoku earthquake and tsunami, which caused extensive infrastructure damage and left telecommunications networks out of service. This disruption hindered contact between affected people and relief agencies, contributing to an increase in the death toll.

"At the conference, some African countries shared their experiences about the importance of telecommunications networks in controlling the spread of epidemics. More importantly, they discussed how these countries learned from their experiences to mitigate damage in future crises.

"In late April, a sudden power outage

Wife of Asian ex-MP doing time in Kuwait arrested

KUWAIT CITY, May 13: Bangladeshi police have arrested former Member of Parliament Salina Islam, the wife of ex-lawmaker Mohammad Shahid Islam who is currently serving a prison sentence in Kuwait, reports Al-Rai daily.

According to local news reports in Bangladesh, Salina Islam is facing multiple criminal charges, including human trafficking and illegal sand extraction from Meghna River -- a major waterway in Bangladesh. Authorities have not yet confirmed which charges will be formally filed first.

The deputy commissioner of the Dhaka South Investigation Branch disclosed that "Salina is accused of involvement in several criminal cases, but we have yet to determine which of these cases will be referred to the prosecution first."

Salina Islam's arrest adds another layer to the ongoing legal saga involving her husband, who was previously convicted in Kuwait on charges related to human trafficking and money laundering.

Cheating man asked to divorce his spouse

Al-Khalidi 5-years jail upheld

KUWAIT CITY, May 13: The Family Court has issued a ruling compelling a Kuwaiti man to divorce his Kuwaiti wife and granting her custody of their children.

The court issued its ruling after confirming that the man suffered from sexual dysfunction caused by excessive use of hormones intended for muscle building, in addition to his repeated acts of infidelity.

Lawyer Muhammad Safar, who represented the woman, filed for divorce on grounds of harm and sought custody of the children.

He presented evidence proving the defendant's sexual dysfunction due to continuous hormone use, along with multiple documented instances of infidelity. These included content shared on social media, where the husband frequently displayed his physique and engaged in inappropriate relationships with several women.

Al-Khalidi jail upheld: The Criminal Court, presided over by Counselor Mutab Al-Ardi, has rejected the appeal submitted by Salman Al-Khalidi and upheld the five-year prison sentence imposed on him.

Al-Khalidi was charged with deliberately challenging the authority of His Highness the Amir, insulting the position of HH the Amir through statements posted on his account on the 'X' platform, and intentional misuse of social media. He denied all charges during the court proceedings.

The court previously ordered a psychiatric evaluation of Al-Khalidi at the request of his court-appointed defense counsel in the State security case. The psychiatric report concluded that the defendant was mentally competent and fully responsible for his actions at the time of the incident, which occurred outside the Kuwaiti Embassy in London.

In its ruling, the court stressed that showing respect for His Highness the

these principles must be addressed firmly and without leniency, as the supreme interests of the State outweigh all other considerations and are essential to its survival and stability.

Juveniles in theft case: Jahra security personnel referred two juveniles, aged 16 and 17, to the Juvenile Prosecution following a failed robbery attempt at a shopping center in Jahra, reports Al-Anba daily.

A machete, allegedly used by one of the suspects to threaten vendors and demand cash, was included in the case file.

According to a security source, the Operations Unit at the Ministry of Interior received a report late Saturday night about an attempted robbery at a local market. A patrol from the Jahra Security Directorate was immediately dispatched to the scene, where security guards already apprehended the two suspects.

Witnesses at the shopping center reported that the juveniles entered the premises, with one brandishing a machete in an effort to intimidate employees and steal from the sales of a supermarket. Staff members managed to subdue the pair before any theft occurred.

The Juvenile Prosecution is currently interrogating the suspects to determine their motives and any further legal action.

Crackdown continues: The General Traffic Department in the Interior Ministry continued its traffic campaigns in all governorates.

These campaigns led to the issuance of 9,838 citations for various traffic violations; referral of 36 minors to the Public Prosecution for driving without a license; and the impoundment of 32 vehicles, reports Al-Seyassah daily.

The weekly statistics of the department, covering the period from May 3-9, revealed that 40 reckless drivers were referred to traffic police stations, two individuals were arrested for driving under the influence of intoxicating substances, 25 were arrested for violating the Residency Law, 23 were arrested for failure

Fire safety inspection in 'Bneid Al-Gar' area

KUWAIT CITY, May 13: Kuwait Fire Force (KFF) carried out an inspection campaign on Monday evening in Bneid Al-Gar, in cooperation with several government entities including the Ministry of Interior, Ministry of Electricity and Water, Environment Public Authority, Kuwait Municipality, and Public Authority for Food and Nutrition, reports Al-Seyassah daily.

The campaign was aimed to identify the buildings and facilities that are in violation of fire safety and prevention regulations.

The campaign resulted in the issuance of citations and administrative closures of several establishments due to their failure to meet the safety requirements of KFF, as well as those of the other participating authorities.

Ban violated

Fishing vessel seized

KUWAIT CITY, May 13: Inspection teams from the Public Authority for Agriculture Affairs and Fish Resources (PAAAFR) seized a fishing vessel carrying shrimp during the fishing ban period specified in Resolution No. 1094/2024 that regulates fishing seasons, reports Al-Seyassah daily.

PAAAFR affirmed that necessary legal measures were immediately taken against the violators, including the confiscation of the shrimp and the issuance of a citation.

It affirmed the importance of adhering to decisions that regulate fishing seasons in order to preserve fish stocks and protect marine resources.

KUWAIT CITY, May 13: Assistant Undersecretary for the Mosques Sector at the Ministry of Awqaf and Islamic Affairs Badr Al-Otaibi issued an administrative circular to imams, preachers and muezzins prohibiting the collection of donations in mosques.

The newspaper obtained a copy of the circular, through which Al-Otaibi urged those occupying religious positions in mosques not to allow any entity or individual to collect donations inside the mosques without an official permit and written approval from the ministry.

Upload 'academic certificates' or face action, KFF chief warns

KUWAIT CITY, May 13: Kuwait Fire Force (KFF) Chief Major General Talal Al-Roumi has issued Circular No. 28/2025 on the need for all fire sector personnel holding higher education qualifications to upload their academic certificates for verification, reports Al-Anba daily.

The circular is based on the following:

■ Cabinet Resolution No. 650, which mandates the formation of a committee, chaired by the Legal Advice and Legislation Department and comprising of various government entities, to verify the academic qualifications of citizens and expatriates working in public and private sectors.

A letter from the chairman of the Committee for Examining Academic Certificates of Government Employees.

General work environment require-

ments and regulatory standards.

It requires the concerned KFF employees to do the following:

1. Access the designated platform by scanning the QR code or visiting www.kff. gov.kw.

2. Log in using their official credentials: username@kff.gov.kw.

3. Contact the Information Technology Department for technical assistance or inquiries.

4. Accurately complete all required fields.

5. Upload valid academic certificates for diplomas, bachelor's, master's or doctoral degrees obtained since Jan 1, 2000.

6. Submit the required documents on May 20-27.

Failure to comply will result in administrative and legal action.


to present valid identification documents, 35 street vendors were arrested, 37 wanted by law and the seizure of 93 vehicles.

Thailand deports Kuwaiti

Bad liquor killed expats found dead on rooftop

KUWAIT CITY, May 13: The forensic report on the deaths of two expatriates who were found on a rooftop of a house in Khaitan indicates alcohol poisoning as the likely cause, reports Al-Anba daily.

According to security sources, the report showed no signs of foul play or assault, and that the two expatriates may have consumed locally produced liquor.

Investigations are ongoing, with detectives working to identify the dealer who supplied the liquor that caused their deaths.

The sources explained that alcohol poisoning occurs when large amounts of alcohol are consumed in a short time or when unsafe alcohol is ingested.

It can severely affect breathing, heart rate, body temperature, and gag reflex, with potentially fatal consequences such as coma or death.

Meanwhile, the sources revealed that the death of another person, whose body was found in the Subiya desert, is believed to be the result of a criminal attack.

Kuwaiti held with drugs: Officers from the Airport Security Department referred a citizen to the Drug Control General Department (DCGD) at the Interior Ministry for the possession of narcotics, reports Al-Anba daily.

According to a security source, the Airport Security Department received information from the security authorities in Thailand that they deported a citizen, born in 1964, after being arrested in the capital, Bangkok, in possession of an undisclosed quantity of narcotics for personal consumption.

The report stated that the individual was deported on board a Kuwait Airways flight.

The source revealed that the DCGD will interrogate the citizen, confiscate his passport and submit a report on the interrogation, indicating the passport will most likely be suspended for up to three years as per a ministerial decision.

95% schools get smart meters

Move to help prevent energy waste

KUWAIT CITY, May 13: According to informed sources from the Ministry of Electricity, Water and Renewable Energy, smart electricity meters have been installed in approximately 95 percent of Kuwait's schools and mosques.

They said the installation in the re-

maining facilities is expected to be completed soon.

The sources explained that the installation of these meters enables the ministry to better manage electricity consumption by controlling power cuts in schools after school hours and in mosques after each prayer, helping to prevent unnecessary energy waste

Meanwhile, Undersecretary of the Ministry of Electricity, Water and Renewable Energy Dr. Adel Al-Zamel participated in the first session of the Kuwait Sustainable Energy Conference, titled "High-Level Dialogue on Regional Policies: Collaborative Pathways for Renewable Energy Solutions and Gateways for Hydrogen Trade.

The session highlighted Kuwait's national priorities in developing renewable energy sources and exploring hydrogen applications. Discussions also covered the ministry's agreement signed with the government of the People's Republic of China, represented by the Chinese company SPIC, to develop the Shagaya and Abdali Renewable Energy Projects, which aim to generate more than 3,000 megawatts of power.

Al-Zamel explained that the targeted pro-

duction capacity is expected to reach 4,800 megawatts by 2029 through the integration of various renewable energy systems. He emphasized that the energy transition

must be in line with the goals of prosperity and economic development in the region, without compromising the legitimate interests of its countries.

Al-Zamel highlighted the development of green and blue hydrogen industries as one of the most promising opportunities for maximizing the use of available renewable energy resources in the region, along with its hydrocarbon wealth.

MoSA, CSC join hands to up output, cut expenses

KUWAIT CITY, May 13: Acting Undersecretary of the Ministry of Social Affairs Dr. Khaled Al-Ajmi has commended the fruitful cooperation with the Civil Service Commission (CSC), confirming the adoption of the new organizational structure of the ministry.

This step is in compliance with government directives on strengthening governance, rationalizing expenditures and improving institutional performance.

Al-Ajmi affirmed that the ministry is among the first government entities to proactively streamline its administrative structure; demonstrating its commitment to cost reduction, procedural simplification, and expedited administrative and technical operations; especially in the context of digital transformation and evolving national priorities.

He described the restructuring as a qualitative shift in the ministry's operational efficiency; such that the number of sectors was decreased from six to two: Social Welfare and Development Sector and the Financial, Administrative and Cooperative Affairs Sector; while the total number of departments went down from 35 to 25 by merging or eliminating 10 main departments -- Technical, Councils and Committees, Research and Statistics, Psychological Counseling, Legal Studies, Activities and Media, Membership Affairs, Citizen Service, Administrative Affairs, and Women and Childhood.

He revealed the new structure includes a director general position, with five directors overseeing administrative groups based on their specializations. He said only two assistant undersecretaries will remain, each managing one of the two main sectors.

He said these reforms were developed through a detailed study in cooperation with the CSC, ensuring alignment with best practices in effective governance.

He added the ministry has started implementing the new structure, redistributing responsibilities in preparation for the issuance of final regulatory decisions that are in line with the CSC regulations and suit the modern requirements of government work

He disclosed that under the new framework, only two departments will report directly to the Office of the Minister and four will fall under the Office of the Undersecretary -- an approach designed to achieve greater administrative flexibility and accountability.

He affirmed that this comprehensive administrative transformation supports the government's vision for institutional rationalization and improved service delivery. He concluded that, as one of the country's largest service agencies, the ministry is committed to providing fast, efficient and high-quality services to a wide range of societal groups.

Restrictions on charities

India woos Kuwaitis for higher studies

KUWAIT CITY, May 13: Indian Ambassador to Kuwait Adarsh Swaika confirmed that India and Kuwait are keen on strengthening cooperation in the field of higher education in order to ease procedures for Kuwaitis who intend to study in Indian universities, reports Al-Jarida daily.

Speaking to the daily by telephone after his meeting with Minister of Education Dr. Adel Al-Tabtabaei, Swaika revealed "we discussed various avenues to deepen bilateral collaboration in the education sector.'

He said the meeting also touched on the development of educational partnerships between the two countries; including a review of the Indian school network in Kuwait, which currently consists of 26 schools serving more 60,000 students.

He affirmed that both sides underscored the importance of continued cooperation to serve mutual interests in education and cultural exchange. He added "we are working together to include Indian universities on Kuwait's National Bureau for Academic Accreditation and Education Quality Assurance (NBAQ) list, which will pave the way for Kuwaiti students to enroll in Indian institutions. It will also allow Kuwaiti universities to recruit qualified professors from India.'

In a related development, Swaika

disclosed that following the signing of a Memorandum of Understanding (MoU) to establish a Hindi language seat at a private university in Kuwait, a professor from New Delhi specializing in Hindi is expected to join the faculty by September; marking the official start of teaching Hindi language.

Restrictions on charities: A total of 84 charitable societies, with branches throughout the country, have signed new rent contracts for their branches in commercial buildings, reports Al-Jarida daily.

These charities informed the Charitable Societies and Endowments Department at the Ministry of Social Affairs about the new addresses of their branches after receiving eviction notices as per Ministerial Resolution No. 206/2009, which prohibits the use of buildings located in private residential and model housing areas for any purpose other than private housing.

This happened after the ministry instructed the Kuwait Municipality to strictly enforce the aforementioned ministerial resolution.

Sources pointed out that expanding branches is now a thing of the past for charities due to rising rents in commercial buildings.



Kuwait and India can achieve more together

India and Kuwait share a longstanding relationship rooted in

The strong presence of the Indian diaspora in Kuwaixt, which exceeds one million, has played a crucial role in fostering India-Kuwait relations. During his visit, Prime Minis-

He has affirmed that the council tackles hindrances and challenges facing the Kuwaiti entrepreneurs, coordinates with the Chamber of Industry and Commerce in Dubai, the UAE Ministry of Economy and other government departments

Elaborating, Al-Salem has revealed that value of the Kuwaiti businesses in the UAE amounts to USD 55 billion; mostly in real-estate, financial markets and other sectors.

The UAE hosts more than 44,000 Kuwaiti investors in the

financial markets and 22,000 in the realty sector, Al-Salem told KUNA. Moreover, there are non-estimated Kuwaiti stakes in the UAE commercial companies

There are 750 Kuwaiti companies registered in the Dubai Chamber, 250 at the Investment Administration in Sharjah and others in the free trade zones, in addition to a number of

firms operating in Ajman, Ras Al-Khaimah and Abu Dhabi. The UAE is the number one trade partner and the second one at the global level to the State of Kuwait, with the trade exchanges estimated at USD 13.5 billion, Al-Salem said, predicting sustainable growth of the commercial exchanges

between Kuwait and the UAE. Furthermore, the chairperson of the Kuwaiti Business Council has indicated that Kuwait-UAE agreements partly support the council, aim at averting double taxation and ensure that custom tariffs on the two countries traded products remain stable.

Furthermore, certain Arab states imitated the nationalization movement prevalent in socialist bloc countries, without realizing that this action would precipitate a significant conflict that they were ill-equipped to endure.

President Jamal Abdul-Nasser's nationalization of the Suez Canal in 1956 proved insufficient, leading to a tripartite invasion of Egypt by the United Kingdom, France and Israel.

The intervention faltered due to the Soviet Union's lack of support. Subsequently, US President Dwight D. Eisenhower, acting on the advice of Secretary of State John Foster Dulles, leveraged the crisis to reinforce American influence in the Middle East and counteract Soviet ambitions.

Consequently, President Eisenhower mandated an immediate cessation of hostilities, threatening US intervention. This ultimatum averted Egypt's potential collapse and precipitated the resignations of British Prime Minister unified position has remained elusive since 1948, and the collective power has not been leveraged for common goals, instead it is being utilized in internal conflicts.

Mr. President, during your first visit to the region, specifically to Riyadh, you concluded important political and investment deals and established the principle of a two-state solution through Washington's sponsorship of the 'Abraham Accords'.

Åmerican power became undoubtedly evident, leading Israel to recog-nize the centrality of Washington's influence, coinciding with the latter's utilization of Jewish financial resources and political leverage in various sectors; including the media, finance, economics and political establishments.

Conversely, the Arab nations did not fully utilize their potential to impact the decisions of major powers -- notably the United States -- whose objective since 1953 has been to transform the Middle East, particularly the Arab region, into an industrial and service base while securing consistent oil exports.

Your Excellency, the US President, successive initiatives aimed at establishing peace with Israel -- including the Rogers Plan of 1970, the King Fahad Peace Plan presented at the Fez Arab Summit, and the King Abdullah Plan proposed at the Beirut Summit -have consistently been met with rejection by Israel.

The rejection is predicated on Israel's assessment that Arab states lack significant concessions and its adherence to the Levi Eshkol Doctrine, which states: "Every 10 years we will be forced to fight so that the Arabs will give up the land they claim and demand new lands that we will occupy.

This doctrine has consistently guided Israeli administrations. Concurrently, Arab actors, particularly leaders of radical organizations and movements rooted in communist and nationalist ideologies, as well as more militant factions, persistently maintained the rhetoric of "throw the Jews into the sea." However, their objectives remained unrealized, failing to impede Israel's territorial expansion.

Nonetheless, the October 7 events significantly worsened the situation, effectively dispelling the remaining optimism generated by the 'Abraham Accords' and the two-state solution.

He added KFF also launched awareness campaigns targeting various segments of society to prevent fire incidents.

He disclosed that KFF typically receives reports on fire incidents in homes, vehicles, warehouses, farms and pile of waste; as well as people trapped in elevators or vehicles due to high temperatures. He stressed that KFF works hard in order to respond quickly to such reports, indicating that the response time ranges between four to eight minutes. He affirmed this range is within global averages.

Following is an excerpt of the interview:

Question: What are the latest preparations of KFF for the summer season?

Answer: Preparations are comprehensive; including increasing the readiness level at all centers, maintaining and upgrading equipment and machinery, and intensifying training programs for firefighters. We have also launched awareness campaigns targeting various segments of society to prevent fire incidents

Q: What are the most common causes of fire during summer?

A: The most common causes of fire during the summer include high temperatures, misuse of electrical appliances, unsafe storage of flammable materials, negligence in industrial facilities, dry grass and waste.

Q: Are there locations where fires are more prevalent, such as Naeem Scrapyard and others?

A: Yes, some locations have higher fire incidence rates like Naeem Scrapyard and some industrial areas and warehouses due to the nature of their activities and the accumulation of flammable materials.

Q: What are the usual reports that KFF receives during summer?

A: Reports vary from house, vehicle, warehouse, farm and waste fire incidents. We also receive reports about people trapped in elevators or vehicles due to high temperatures.

Q: How long does it take to respond to such reports?

A: Our response time ranges from four to eight minutes in urban areas, readiness includes personnel, modern equipment and technology; in addition to operations units that monitor reports in real-time.

Q: Is it true that filling a car's fuel tank to full capacity in the intense summer heat exposes it to fire?

A: This is a misconception. Completely filling the fuel tank does not cause fire, but it is important to ensure the tank cap is tightly closed and to refrain from smoking or using flame near gas stations.

Q: Do perfumes and power banks cause car fire in high temperatures?

A: Yes, leaving perfumes or portable phone batteries (power banks) in the car under direct sunlight may cause them to explode or catch fire. Therefore, we advise against leaving them inside the vehicle, especially during summer.

Q: Will there be new vehicles soon? A: Yes, a number of new firefighting and rescue vehicles will be operational soon. They are equipped with modern technologies to enhance efficiency.

Q: Is there a plan to open new fire stations?

A: Several new fire stations will soon open in various areas like Jaber Bridge and Al-Qairawan, with the aim of covering urban expansion and expediting response times.

O: How many deaths were caused by accidents -- fire or traffic accidents?

A: In 2024 and the first quarter of this year, we recorded 180 deaths due to fire and traffic accidents: while in the first quarter of this year, 44 cases were recorded. We are working hard to reduce these numbers through prevention and rapid intervention.

Q: What is your awareness message to citizens and expatiates now that summer is approaching? A: We would like to emphasize the

importance of everyone adhering to safety and fire prevention measures in order to protect lives and properties. The use of certain electrical appliances usually increases in summer; hence, the need for all of us to be careful and to strictly follow preventive guidelines. Important tips include avoiding leaving flammable materials such as gas cylinders or perfumes in vehicles exposed to direct sunlight, not overloading electrical connections, ensuring their serviceability and safety on a regular basis, maintaining air conditioning units and kitchen vents, and supervising children and preventing them from playing with matches or other sources of fire.

If you are traveling during the summer vacation, it is necessary to ensure that all electrical and gas appliances are turned off before leaving your home. Do not make fire in desert areas or beaches except in designated areas, and ensure that the fire is completely extinguished after use. It is also necessary to put a fire extinguisher in your vehicle and at the temporary accommodation.

He also pointed out that investing in human resources and training personnel specialized in food inspection and laboratory analysis are considered an invaluable and strategic investment in achieving sustainable food security.

Meanwhile, US Ambassador to Kuwait Karen Sasahara confirmed the strength of the economic and trade relationship between the United States of American and Kuwait. She revealed that bilateral trade in agricultural products reached \$275 million last year, while trade with the Gulf Cooperation Council (GCC) countries reached \$3.6 billion.

She said "the US Embassy is working closely with government agencies and farmers in Kuwait to discuss food security challenges and how American technologies can provide effective solutions.'

She explained that agriculture and food are not limited to being industries, but rather represent tools for communication and integration between peoples and engines of shared economic growth.

She believes the summit is an opportunity to exchange best practices and enhance a shared understanding of food security, food safety and nutrition issues. She stated that "for the first time, we are adding food security to the summit agenda; because an effective food safety policy is the foundation of food security, given its role in protecting public health and ensuring the stability and sustainability of food supplies."

She also pointed out that challenges such as obesity, diabetes and chronic diseases persist in Kuwait and the Gulf region; similar to those the United States is currently facing.

Furthermore, Chairperson and Director General of PAFN Dr. Reem Al-Fulaij disclosed that the fourth edition of the summit is important not only because of the discussion on food safety, but also the inclusion of food security, especially in light of the challenges that food supply chains are facing now and the spread of food-borne diseases.

Trump and Crown Prince Mohammad bin Salman also took part in a formal greeting and lunch at the Royal Court at Al Yamamah Palace, gathering with guests and aides in an ornate room with blue and gold accents and massive crystal chandeliers.

As he greeted business titans with Trump by his side, Crown Prince Mohammad bin Salman was animated and smiling as he rubbed elbows with high-profile business executives - including Blackstone Group CEO Ste-phen Schwarzman, BlackRock CEO Larry Fink and Tesla and SpaceX CEO Elon Musk - in front of the cameras.

Later, the crown prince will fete Trump with an intimate state dinner at Ad-Diriyah, a UNESCO heritage site that is the birthplace of the first Saudi state and the site of a major development project championed by the crown prince.

Saudi Arabia and fellow OPEC+ nations have already helped their cause with Trump early in his second term by stepping up oil production. Trump sees cheap energy as a key component to lowering costs and stemming inflation for Americans. The Republican president has also made the case that lower oil prices will hasten an end to the Russia-Ukraine war.

But Saudi Arabia's economy remains heavily dependent on oil, and the kingdom needs a fiscal break-even oil price of \$96 to \$98 a barrel to balance its budget. It's questionable how long OPEC+, of which Saudi Arabia is the leading member, is willing to keep production elevated. The price of a barrel of Brent crude closed Monday at \$64.77.

Trump picked the kingdom for his first stop, because it has pledged to make big investments in the U.S., but he ended up traveling to Italy last month for Pope Francis' funeral. Riyadh was the first overseas stop of his first term.

The three countries on Trump's itinerary - Saudi Arabia, Qatar and the United Arab Emirates - are places where the Trump Organization, run by Trump's two oldest sons, is developing major real estate projects. They include a high-rise tower in Jeddah, a luxury hotel in Dubai and a golf course

The administration didn't notify Israel - which the Houthis continue to target - of the agreement before Trump publicly announced it. It was the latest example of Trump leaving the Israelis in the dark about his administration's negotiations with common adversar-

In March, Israeli Prime Minister Benjamin Netanyahu wasn't notified by the administration until after talks began with Hamas about the war in Gaza. And Netanyahu found out about the ongoing U.S. nuclear talks with Iran only when Trump announced them during an Oval Office visit by the Israeli leader last month.

"Israel will defend itself by itself," Netanyahu said last week following Trump's Houthi truce announcement. "If others join us - our American friends - all the better."

William Wechsler, senior director of the Rafik Hariri Center and Middle East Programs at the Atlantic Council, said Trump's decision to skip Israel on his first Middle East visit is remarkable.

"The main message coming out of this, at least as the itinerary stands today, is that the governments of the Gulf ... are in fact stronger friends to President Trump than the current government of Israel at this moment," Wechsler said.

Trump, meanwhile, hopes to restart his first-term effort to normalize relations between the Middle East's major powers, Israel and Saudi Arabia. Trump's Abraham Accords effort led to Sudan, the UAE, Bahrain and Morocco agreeing to normalize relations with Israel.

But Riyadh has made clear that in exchange for normalization it wants U.S. security guarantees, assistance with the kingdom's nuclear program and progress on a pathway to Palestinian statehood. There seems to be scant hope for making headway on a Palestinian state with the Israel-Hamas war raging and the Israelis threatening to flatten and occupy Gaza.

Crown Prince Mohammad bin Salman last week notably hosted Palestinian Vice President Hussein al-Sheikh in Jeddah on the official's first foreign visit since assuming office in April.

Detained Philippines ex-prez Duterte wins mayoral race in home city

MANILA, Philippines, May 13, (AP): Former Philippine president Rodrigo Duterte was elected as mayor in his home city by a landslide, official results showed Tuesday, despite his detention by the International Criminal Court.

The Davao election board proclaimed Duterte won the race for Davao mayor, with the official tally showing that he garnered over 660,000 votes, or eight times as many as his closest rival. Elated supporters chanted "Duterte, Duterte' when the result was announced.

His youngest son, Sebastian, the incumbent mayor of Davao, was declared Davao vice mayor. His eldest son, Paolo, was reelected as a member of the House of Representatives, and two grandsons won in local races, an indication of the family's continued influence.

"Duterte landslide in Davao!" his youngest daughter Veronica posted on Facebook

Partial unofficial results showed at least five candidates backed by the Duterte family were also among those leading the race for 12 Senate positions, in a stronger-than-expected showing in Monday's midterm elections. Pre-election surveys had indicated only two of them would

MANILA, Philippines: A restive volcano in central Philippines briefly erupted Tuesday, spewing a 4.5-kilometer (2.8-mile) ash plume and debris into the sky as its rumblings were heard nearby. The Philippine Institute of Volca-

nology and Seismology said a moderately explosive eruption occurred at the summit crater of Kanlaon Volcano before dawn, lasting five minutes based on seismic and infrasound data. "The eruption generated a greyish voluminous plume that rose approximately 4.5 kilometers above the vent before drifting to the southwest," the institute's bulletin added.

Bangladesh interim govt strips ex-ruling party of registration, barring it from polls

DHAKA, Bangladesh, May 13, (AP): Bangladesh's Election Commission has cancelled the registration of the former ruling party of ousted Prime Minister Sheikh Hasina, preventing it from participating in the next national election, which is expected to be held by June next year.

The decision on Monday came hours after the country's interim government headed by Nobel Peace Prize laureate Muhammad Yunus issued an official notification banning the Awami League party and its affiliated bodies from conducting activities online and elsewhere.

Monday's formal notification from the Ministry of Home Affairs was issued two days after the interim Cabinet decided to ban all activities of the party under the country's Anti-Terrorism Act until a special tribunal concludes a trial for the party and its leaders.

In the notification, the government said it outlawed all activities "including any kind of publication, media, online and social media" as well as "any kind of campaign, procession, meeting, gathering (or) conference until the trial of the leaders and activists ... is completed.'

It said the decision was effective immediately.

Separately, the Election Commission said Monday it would not allow

the Hasina-led party to contest the next election. Political parties must be registered with the Election Commission to take part in elections.

A government adviser said Monday that anyone who posts comments online in support of the Awami League party would face arrest.

On Sunday, the Awami League accused the interim government of "stoking division" and trampling on "democratic norms" by banning its activities. It said in a statement that the ban "stoked division within society, strangled democratic norms, fueled ongoing pogrom against dissenters and strangled inclusivity, all undemocratic steps.

The Awami League is one of two major parties in Bangladesh, which has a fractious parliamentary democracy with a violent history of coups and political assassination.

'They lead in different roles and realms'

US President Trump and Pope Leo now Earth's most powerful Americans

WASHINGTON, May 13, (AP): The motto of one newly elected American world leader: "Fight! "The other introduced himself to the world with his first public word as pope: "Peace.

The contrast between US President Donald Trump and Chicago-born Pope Leo XIV couldn't be more stark - politically, personally or in their world views. They lead in different roles and realms

But Leo's historic election last week to lead the world's 1.4 billion Catholics as the first US-born pope means that the two most powerful people on the planet are Americans. That raises questions about American influence at a time when Trump's tariff wars and "one way or the other" threats have upended eight decades of global order and sparked distrust among allies toward the United States.

The prospect of too much American power in geopolitics is widely considered one reason that the Catholic Church had not elected an American to the papacy across the country's nearly 250-year history. Until, that is, the former Cardinal Robert F. Prevost of Chicago - Pope Leo XIV - was chosen last week to be the 267th pontiff.

"The irony of Leo's election is that many in the rest of the world will view it as a sign of hope - as an American who can speak for them rather than act against them," said David Gibson, director of Fordham University's Center on Religion and Culture.

The shock and delight of the notwell-known cardinal's election soon shifted into robust discussion about how the top of the global pecking order could be populated by two Americans.

Trump is known to not enjoy sharing attention or primacy, as his "America first" foreign policy approach makes clear. American Catholics chose Trump over his Democratic rival, Kamala Harris.

In one apparent appeal to them, Trump posted an AI-generated image of himself dressed as a pope during the days of mourning for Pope Francis, who died April 21. The move was not appreciated by some Catholics and Italians. Trump denied posting the image himself and said anyone who was offended "can't take a joke." He insisted that "the Catholics loved

Even so, Trump wished Leo well and called it a "great honor" that the

new pope was American.

Pope Leo, meanwhile, is in some senses a politician as well, with a calm manner and the approach of talking to his fellow cardinals in small groups before the conclave, they said. Though he was born in Chicago, Leo - then Prevost - spent two decades as a missionary in Peru before being appointed by Pope Francis in 2023 to lead the Vatican's powerful office that vets bishops around the world.

He wouldn't be the first pope to wade into world politics. Pope John Paul II, for example, is rightly credited with helping bring down communism. But Leo enters the papacy having already criticized Vice President JD Vance, the highest-profile Catholic in American politics, on social media. Leo is at odds with the administration on such policy issues as immigration - Trump's signature issue - and the environment.

Like Trump, Leo has turned his at-tention to the media. On Monday in Vatican City, he called for the release of imprisoned journalists and affirmed the calling for "all of us to safeguard the precious gift of free speech and of the press." In contrast, Trump's approach to journalists has been combative, from the White House to the courts.

Leo, speaking Italian to thousands gathered in St. Peter's Square, described a different vision for the Church and human relations: "We have to be a church that works together to build bridges and to keep our arms open, like this very piazza, welcom-

ing." Vance suggested the papacy is "big-

ger" than politics and social media "It's very hard to fit a 2,000-year-old institution into the politics of 2025 America," he said during an interview with conservative commentator Hugh Hewitt, adding that "it's better for all of us if we allow the church to be about the saving of souls."

"What both Francis and then Cardinal Prevost were doing was being bishops - teaching the Gospel, and reminding us the Gospel always is on the side of the poor, the afflicted, the suffering," Millies said in an email. "That's not Trump's lane as a president, a reality TV star or a businessman.'

Leo's decades in Peru - he is a citizen of both countries - can give him a broader view of humanity and power, and religion and politics, scholars say.

Beyond the obvious personality differences with Trump, Leo is expected to wield power differently - to the neediest people first, for example, whereas Trump cut off American aid. Leo did not mention his American roots during his first speech, nor did he speak in English - a sign, some Vatican watchers said, of his global priorities.

United Nations chief pleads with nations to pay their share for peacekeeping

Zelenskyy will be waiting for Russia's **Putin in Ankara on Thursday for talks**

KYIV, Ukraine, May 13, (AP): Ukrainian President Volodymyr Zelenskyy said Tuesday that he will be waiting for Russian counterpart Vladimir Putin in the Turkish capital this week to conduct face-to-face talks about the more than three-year war amid heavy pressure from the US and European leaders to reach a settlement.

Putin hasn't yet said whether he will be at the talks, which US President Donald Trump has urged the two sides to attend as part of Washington's efforts to stop the fighting.

Zelenskyy told reporters in Kyiv that he will be in Ankara on Thursday to conduct the negotiations. He will meet with Turkish President Recep Tayyip Erdogan and the two will wait for Putin to arrive, he said.

Zelenskyy said he would "do everything to agree on a ceasefire, because it is with (Putin) that I must negotiate a ceasefire, as only he can decide on it."

Zelenskyy said that if Putin chooses Istanbul to hold the meeting, then both leaders will travel there from Ankara.

"If Putin does not arrive and plays games, it is the final point that he does not want to end the war," Zelenskyy said.

The Ukrainian leader added that if Putin doesn't show up, European and US leaders should follow through with threats of additional and heavy sanctions against Russia.

Trump has been invited to the talks, because "it would give an additional push for Putin to fly in," but Trump hasn't confirmed his presence, Zelen-

skyy said. The American president will still be on his four-day Middle East trip on Thursday.

Washington has been applying strong pressure on both sides to come to the table since Trump took office in January with a promise to end the war.

Military analysts say that both sides are preparing a spring-summer campaign on the battlefield, where a war of attrition has killed tens of thousands of soldiers on both sides along the roughly 1,000-kilometer (620-mile) front line. The Institute for the Study of War, a Washington-based think tank, said Monday that Russia is "quickly replenishing front-line units with new recruits to maintain the battlefield initiative."

International pressure has been growing to push Ukraine and Russia into finding a settlement.

German Chancellor Friedrich Merz pressed again for an unconditional 30day ceasefire as he met his Greek counterpart in Berlin on Tuesday.

Merz welcomed Zelenskyy's readiness to travel personally to Istanbul, "but now it is really up to Putin to accept this offer of negotiations and agree to a ceasefire. The ball is exclusively in Russia.'

Overnight, Russia launched 10 Shahed and decoy drones at Ukraine, the Ukrainian air force said, in its smallest drone bombardment this year.

Also:

MELBOURNE, Australia: The Council of the International Civil Aviation Organization on Tuesday found Russia responsible for shooting down Malaysia Airlines Flight 17 over Ukraine with the loss of 298 lives more than a decade ago, in a ruling that raises the prospect of victims' families being paid compensation.

A Dutch-led international investigation concluded in 2016 that the Amsterdam-to-Kuala Lumpur airliner was shot down on July 17, 2014, from Ukrainian territory held by separatist rebels using a Buk missile system delivered from Russia. Moscow denies any involvement in the MH17 tragedy.

BERLIN, May 13, (AP): UN Secretary-General António Guterres told countries that the world body's peacekeeping operation is "only as strong as member states' commitment to it" as he pleaded with them Tuesday to pay their share.

The United Nations' peackeeping department currently leads 11 operations, in countries including Congo, the Central African Republic, South Sudan, Lebanon, Cyprus and Kosovo. The budget for nine of those operations during the fiscal year that ends on June 30 totals \$5.6 billion, 8.2% lower than a year earlier. Each of the UN's 193 member countries is legally obliged to pay its share toward peacekeeping.

Guterres argued that, with a budget "representing a tiny fraction of global military spending - around one half of one per cent - UN Peacekeeping remains one of the most effective and cost-effective tools to build international peace and security.'

"But it's only as strong as member states' commitment to it," he added at the opening of a two-day, Germanhosted conference of ministers to discuss the future of peacekeeping. "Unfortunately, peacekeeping operations

have been facing serious liquidity problems. It is absolutely essential that all member states respect their financial obligations, paying their contributions in full and on time."

Guterres didn't offer details of the problems, but acknowledged that "these are tough times for the financing of our work across the board."

More broadly, the UN has been scrambling to respond to funding cuts for aid operations from its biggest donor, the United States, under President Donald Trump's administration.

Countries seek to bolster ties

Macron to travel to UK for state visit in July

LONDON, May 13, (AP): French President Emmanuel Macron will make a state visit to the United Kingdom in July, as the two countries seek to bolster ties to counter Russian aggression and the economic fallout from US President Donald Trump's aggressive trade policy.

Macron and his wife, Brigitte, will stay at Windsor Castle for the visit, which will take place from July 8 to July 10, Buckingham Palace said Tuesday.

The dates mean that Macron will likely beat Trump to London. Charles in February invited Trump to make an unprecedented second state visit to Britain, but a date hasn't yet been set.

Charles and Queen Camilla traveled to France in September 2023 in a visit that highlighted the historic ties between Britain and its closest European neighbor. The trip came after years of sometimes prickly relations strained by Britain's exit from the European Union and disagreements over the growing number of migrants crossing the English Channel on small boats.

The Main Market Index edged up 9.35 points, or 0.13 percent, to close at 7,007 points, with 237.1 million shares traded through 10,924 deals valued at KD 36.9 million (USD 112.9 million).

KUWAIT CITY, May 13: Aayan Real Estate held its ordinary general assembly for the fiscal year ending Dec 31, 2024; which led to the approval of a cash dividend distribution to shareholders -- five percent of the nominal value of the share, equivalent to five fils per share.

During the assembly, the Board of Directors for the next session was elected, the board's report and financial statements were approved, and all the agenda items were approved, with an attendance rate of 71.78 percent.



Kuwaiti oil experts welcome **US-China tariff suspension**

Oil market confidence boosted by 90-day trade truce

KUWAIT CITY, May 13, (KUNA): Kuwaiti oil experts have welcomed the 90-days suspension of tariffs between the US and China, saying that the move has bolstered confidence in the global economy and could lead to increased demand for oil.

Experts told KUNA that oil prices had dropped significantly since the onset of the tariff dispute in April, driven by fears of a global economic slowdown, however, the recent agreement has triggered price increases and eased market concerns.

positive step towards resolving trade tensions that have pressured oil markets, and noted that OPEC estimates potential one to two percent annual increase in oil demand if trade relations stabilize.

Dr. Abdulsamee Behbehani, another energy expert, said that although OPEC decided to increase oil production in May and June -which could have caused oil prices to dropthe positive impact of the US-China tariff agreement was stronger. He added that the agreement led to market opti-

'Operational growth strong despite higher costs and tax provisions'

Agility Global PLC reports Q1 2025 EBIT of \$92 mln

ABU DHABI, May 13: Agility Global PLC, a multi-business owner and operator and long-term investor, today reported Q1 2025 earnings of \$21 million, or 0.21 cents per share. EBIT stood at \$92 million, EBITDA at \$173 million and revenue \$1,143 million.

As of March 31, 2025, Agility's investment segment has a carrying value of roughly \$5.1 billion, bringing the balance sheet to \$11.8 billion in assets and \$5.3 billion in total equity attributable to the shareholders of the parent company

Agility Global Chairman, Tarek Sultan said "The Group delivered good operational performance in Q1 2025, supported by organic growth across our core businesses. However, net profit was impacted by higher depreciation expenses from new operating leases required for business growth, and higher interest expense since the company was capitalized in May 2024 as part of the listing process as well as higher utilization of debt relative to Q1 2024. Furthermore, the company has taken tax provisions related to the implementation of Pillar Two (global minimum effective corporate tax rate). Despite this, the Group's underlying operational momentum remains positive, and we continue to advance our strategic priorities. Our investment segment is managed with steadfast discipline, and we are focused on the long-term fundamentals of the assets.

"We remain cautious of external uncertainties, which may introduce volatility in certain markets. However, the diversification of our businesses, combined with a disciplined and agile strategic approach, positions us well to capture emerging opportunities and deliver sustained value for our shareholders.'

Controlled Segment

For Q1 2025, the consolidated EBIT of the controlled businesses was \$79 million; EBITDA was \$160 million; and revenue was \$1,143 million.

Aviation Services: Menzies

Menzies Aviation revenue reached \$649 million in Q1 2025, representing 13% growth over the same period in 2024. This growth was mainly driven by an increase in volumes as a result of new operations in Portugal and Spain, expansion into Serbia, along with winter activity plus yield improvements. Over the same period, reported EBITDA grew by 4% with almost all material divisions and service lines showing growth. Adjusted for non-recurring items booked in 2024, adjusted EBITDA and EBIT for the quarter would have shown a 13% and 24% increase from same period last year.

Menzies recently agreed to acquire 100% of US-based G2 Secure Staff, an aviation service partner of choice for major airlines across the United States. The transaction is valued at \$305m plus a deferred consideration of \$10m payable in 2026, subject to G2 operations achieving certain agreed-upon performance targets. The deal strength-

Fuel Logistics: Tristar

Tristar, a fully integrated fuel logistics business, reported a \$340 million revenue increase of 35% from the first quarter in 2024. The top line increase was mainly driven by growth in the Fuel segment as a result of the new Sri Lanka retail fuel business, which began in the second half of 2024. EBITDA reached \$60 million, and EBIT was \$26 million, decreases of 7% and 33% respectively. This was driven by a one-off gain booked in 2024 and higher depreciation expense this quarter, from commitment to charter new vessels to activities intended to support business growth. The management is actively working on action plans to improve performance for the remainder of the year

Tristar group has a healthy pipeline of growth opportunities, especially in infrastructure capacity building. Those opportunities are concentrated in the Maritime and Fuel storage businesses

er of warehouse parks and light industrial facilities. reported revenue of \$14 million, an increase of 8%. EBIT was \$9 million for the quarter. Strong demand for world-class warehousing is fueling the growth of ALP, especially in Saudi Arabia where occupancy rates remained high.

ALP continues to benefit from strong market fundamentals driven by ongoing economic diversification initiatives in Saudi Arabia. ALP is currently developing a total of 226k sqm of new warehousing space in Jeddah and Riyadh to be delivered during 2025 and early 2026, and revenue will be booked accordingly. ALP will continue to look for opportunities in the markets where it operates and in new potential markets.

Investment Segment

Agility Global holds non-controlling minority stakes in a number of businesses, both listed and non-listed. As of 31 March 2025, the carrying value of those stakes was roughly \$5.1 billion. The company's largest holdings in this segment are in DSV and Reem Mall.

DSV is a Copenhagen-based logistics company that became the world's number one freight forwarder following its recently approved acquisition of DB Schenker. DSV announced expected synergies of DKK 9 billion (around \in 1.2 billion), higher than most analysts' expectations.

The share price has gained positive momentum following the announcement and continues to perform positively. Agility Global owns 19.3 million shares of DSV today, making it one of the Denmark-based company's largest shareholders. Agility Global maintains a positive long-term view on its investment in DSV because of the company's strong fundamentals, global market position, and proven track record of value-accretive growth.

Reem Mall - Agility Global is an investor in Reem Mall on Abu Dhabi's Reem Island. Agility Global's stake in Reem Mall consists of equity and convertible debt. The mega-mall had a soft opening to the public in February 2023 and launched formally in May 2024. As of March 2025, 198 units were trading, and almost 80% of Gross Leasable Area (GLA) was committed. More tenants are expected to announce openings in coming months. The mall is one of the region's first fully integrated omnichannel retail ecosystems with digital, e-commerce, and logistics capabilities. It brings together all consumer and retail services to ensure a seamless customer experience.

Al Ahli Bank of Kuwait Group holds Q1 2025 analyst conference call

KUWAIT CITY, May 13: Al Ahli Bank of Kuwait (ABK) recently hosted its Q1 2025 analyst conference attended by Abdulla Al Sumait, Acting Group Chief Executive Officer; Shiamak Soonawalla, Group Chief Finance Officer; Abdulaziz Jawad, Chief Strategy Officer; and Osama Ezzeldin, Assistant General Manager of Strategy and Follow Up.

Al Sumait began with discussing the financial highlights for Q1 2025. "ABK achieved a healthy net profit growth of 8% to KD 15.7 million. Earnings per share remained stable at 5 fils, and our capital adequacy ratio stood robustly at 16.78%.'

"On the lending side, ABK's loan portfolio expanded by 10% year-on-year, supported by our disciplined credit underwriting standards. Asset quality remains strong, with our NPL ratio well controlled at 1.38%, reflecting our continued focus on maintaining strong asset quality," Al Sumait said.

He added, "Our diversified footprint continues to drive our growth momentum. Our international operations, including our UAE branches and ABK-Egypt, contributed a solid 40% of operating income and accounted for 37% of total assets, highlighting the strength of our regional diversification strategy.'

Al Sumait shared that ABK launched key strategic initiatives during the quarter to reinforce its competitive advantage and enhance customer experience. Major achievements in Q1 2025 included the launch of its new mobile banking app in Kuwait, featuring enhanced features and a new design, the introduction of a free international call service for customer support, and an enhanced customer service model with virtual service available in branches.

He concluded, "As we look ahead, ABK remains focused on delivering sustainable, longterm value. We will continue to pursue strategic expansion opportunities, strengthen our regional presence, and introduce innovative financial solutions tailored to meet the evolving needs of our customers.

Financial Indicators

On his part, Soonawalla discussed ABK's financial high-lights for Q1 2025. He said, "We achieved a healthy net profit growth of 8% year-on-year, with KD 15.7 million net profit attrib-

while operating profit stood at KD 29.3 million. This was supported by proactive cost management and continued revenue momentum across business lines."

ABK's asset quality remains robust, with the Group's nonperforming loan (NPL) ratio maintained at a healthy 1.38%. The Group's loan loss coverage ratio held firm at 433%, confirming strong credit quality. Furthermore, provisions exceeded the IFRS 9 requirements, in accordance with Central Bank of Kuwait guidelines, as ABK continues to apply a prudent provisioning policy.

Soonawalla added, "We managed to maintain our net interest margin at 2.1% levels, although operating income marginally declined due to funding cost pressures and lower fees and commission income. Return on Average Equity (ROAE) delivered a healthy 8.1%, underlining ABK's strength in sustaining returns and driving long-term shareholder value. Liquidity continues to be a key strength for us, as evidenced

Customer deposits remained resilient, totaling KD 4.4 billion, which represents 66% of our total liabilities. This further reinforces the strength and stability of our funding base."

He highlighted that the Group's strong start to 2025 reflects ABK's effective execution of strategic priorities and the leveraging of our core banking franchise alongside diversified income streams to drive sustainable growth. Notably, operating profit grew by 5%, highlighting the Group's enhanced operational efficiency.

Commercial Banking remained the largest contributor to our operating income during the quarter, accounting for 49%, followed by Retail Banking at 39%, and Treasury and Investments at 12%. Our asset allocation remains strategically balanced, with 55% allocated to Commercial Banking, 12% to Retail Banking, and 33% to Treasury and Investments.

He added, "Our focus on operational excellence, digital transformation, and strategic investments continues to yield meaningful improvements. During Q1 2025, ABK's cost-to-income ratio significantly improved to 41.9%,

down from 46.4% year-on-year, reflecting greater efficiency and disciplined cost management across the Group.As of Q1 2025, total assets expanded to KD 7.4 billion, delivering strong yearon-year growth of 13%. Net loans and advances increased by 10% to KD 4.7 billion, demonstrating healthy lending activity and prudent balance sheet expansion.'

Soonawalla closed, "Our Q1 2025 results highlight our solid profitability, disciplined risk management, and strengthened balance sheet. ABK remains firmly positioned to deliver sustainable growth and create enduring value for shareholders. With a strong foundation and a clear strategic focus, we are confident in our ability to sustain momentum throughout 2025.'

The Local and Global Economy

Jawad mentioned that the sharp escalation in trade tensions and high policy uncertainty are expected to weigh heavily on global economic activity. According to the latest IMF projections, global GDP growth is now projected at 2.8% in 2025 and 3.0% in 2026. This marks a downward revision from the earlier forecast of 3.3% for both years. Global headline inflation is expected to decline at a slightly slower pace than what was expected in January, reaching 4.3% in 2025 and 3.6% in 2026.

When it comes to Kuwait, the IMF has revised its 2025 GDP growth forecast for Kuwait to 1.9%. The adjustment reflects a more measured recovery pace, although domestic demand remains strong and oil output continues to recover. Inflation is expected to

Kuwait introduced a new public debt law, setting a borrowing ceiling of KD 30 billion and permitting the issuance of financial instruments with maturities up to 50 years. The move aims to strengthen financial stability, support Kuwait Vision 2035, diversify funding sources, and enhance Kuwait's position as a regional financial hub."

Exceptional Results

Jawad continued, "Our strategic focus continues to be on salaried Kuwaitis and high-income expatriates, while placing growing emphasis on youth, who represent the future. We are continuously enhancing our youth offering to further strengthen our overall value proposition. As a result, our retail loan portfolio grew 1.75 times faster than the market in Q1 2025. We also enhanced our cards portfolio with a new prepaid card featuring a dual rewards program." Furthermore, he affirmed, "ABK maintains strong credit ratings of 'A' from Fitch and 'A2' from Moody's, reflecting its robust financial position, prudent risk management, and commit-

ment to long-term stability."

Egypt and the UAE

Regarding Egypt's macroeconomic landscape, the country is making progress on its macroeconomic reform agenda despite regional challenges. The IMF completed the fourth review of Egypt's Extended Fund Facility (EFF), disbursing USD 1.2 billion and approved an additional USD 1.3 billion under the Resilience and Sustainability Facility (RSF). Although Egypt's inflation rose slightly to 13.9% in April 2025, up from 13.6% in March, the rise remains in line with market expectations, Moving on, Jawad shed light on the UAE stating, "ABK, through its DIFC branch, has successfully closed a landmark USD 1 billion global syndicated term loan facility for a period of over 3 years, marking its largest debt facility to date. This significant achievement affirms ABK's robust standing in the financial markets."

The syndication was initially launched at USD 750 million; however, due to excessive over subscription by 60%, the facility was upsized to USD 1 billion. This positive response highlights the strong liquidity position and confidence that both regional and international lenders, including those from the Middle East, US, Europe, and Asia, have in ABK.

Jawad affirmed, "This achievement reflects the trust and confidence that our lenders have in our financial stability and strategic vision. We are committed to utilizing these funds to enhance our service offerings and continue to foster sustainable growth."

"Alongside our funding activities, ABK-UAE continued to advance its strategic agenda in the real estate sector. As a continuation of our Q4 2024 update, ABK-UAE successfully on boarded its first real estate escrow customer, marking a key milestone as the first Kuwaiti bank to offer this service in the UAE. With additional clients in the pipeline, we are now assessing the extension of these services to Abu Dhabi. This aligns with our strategy to strengthen our footprint and competitiveness in the UAE financial sector,"Jawad continued.

Complementing the real estate escrow rollout, a dedicated UAE mortgage service for Private Banking clients in Kuwait was also launched. To enhance this service, real estate brokers are being brought on board as key partners, ensuring a more streamlined client experience.

ABK continued to build momentum around its ESG agenda, laying the groundwork for future initiatives and enhancements. The Bank remains committed to further integrating ESG principles into key business areas. Looking ahead, ABK plans to publish its updated sustainability report, assess its ESG maturity, strengthen internal capabilities, and explore opportunities that support sustainable value creation.

Inflation cooled again last month

Wall St dips as euphoria over China-US trade truce fades

NEW YORK, May 13, (AP): Wall Street is on track to open with losses Tuesday as the initial euphoria over the 90-day truce in the U.S.-China trade war faded and markets turned their attention to corporate earnings and new inflation data.

Futures for the S&P 500 slipped 0.2% while futures for the Dow Jones Industrial Average fell 0.6%. Nasdaq futures ticked down just 0.1% ahead of the government's latest report on inflation at the consumer level.

UnitedHealth Group shares tumbled more than 10% after it suspended its full-year financial forecast due to higher-than-expected medical costs. The nation's largest health insurer also announced that CEO Andrew Witty was stepping down for personal reasons and that Chairman Stephen Hemsley will become CEO, effective immediately

Boeing shares got a small boost on media reports that China had lifted a ban on airlines there taking deliveries of the U.S. aerospace giant's planes. According to reports, China removed those obstacles as part of Monday's trade truce with the U.S. Boeing shares rose close to 2% in premarket trading Tuesday.

Stocks soared Monday after the United States said in a joint statement with China that it will cut tariffs on Chinese goods to 30% from as high as 145%, for 90 days.

European markets edged higher, with Germany's DAX and the CAC 40 in Paris each gaining 0.1%. Britain's FTSE 100 was flat.

Beijing's anger over the trade war remained apparent. Speaking to offi-cials from China and Latin America on Tuesday, leader Xi Jinping reiterated China's stance that nobody wins a trade war and that "Bullying or hegemonism only leads to selfisolation.

Tokyo's Nikkei 225 jumped 1.4% to 38,183.26. Automakers were among the big gainers after the U.S. dollar surged against the Japanese yen. Toyota Motor Corp. gained 3.5% and Suzuki Motor Corp. was

2.4% higher.

Nissan Motor Co. added 3% ahead of an announcement that it plans to lay off 20,000 of its workers as part of its restructuring efforts. The automaker said Tuesday that it racked up a loss of 670.9 billion yen (\$4.5 billion) in the last fiscal year.

The Kospi in South Korea was nearly unchanged at 2,608.42.

Hong Kong's Hang Seng, which gained 3% a day earlier after Chinese and U.S. officials announced the agreement to pause tariffs and reduce them, fell 1.9% to 23,108.27 on heavy selling of technology shares.

The Shanghai Composite index edged 0.2% higher to 3,374.87 and Taiwan's Taiex jumped 1%. India's Sensex fell 1.5%

In Australia, the S&P/ASX 200 climbed 0.4% to 8,2769.00.

In energy trading, U.S. benchmark crude oil added 64 cents to \$62.59 per barrel. Brent crude, the international standard, gained 60 cents to \$65.56 per barrel.

Inflation cooled for the third straight month in April even after some of President Donald Trump's tariffs took effect, though economists and many business owners expect inflation will climb in the coming months.

Consumer prices rose 2.3% in April from a year ago, the Labor Department said Tuesday, down from 2.4% in March and the smallest increase in more than four years. On a monthly basis, prices rose modestly, increasing 0.2% from March to April after falling 0.1% the previous month, the first drop in five years.

Grocery prices dipped 0.4%, pulled downward in part by a big 12.7% fall in the price of eggs. It was the biggest decline in food costs at home since September 2020, the government said.

The report suggests the tariffs haven't yet impacted the prices of many items. Clothing costs fell 0.2% from March to April, while new car prices were unchanged. Furniture costs jumped 1.5%, however.

Excluding the volatile food and energy categories, core prices were also muted, rising 2.8% in April compared with a year ago, the same as in March. On a monthly basis, they increased a mild 0.2%. Economists watch core prices because they typically provide a better read on where prices are headed.

AU students secure seventh place at the prestigious GOTECH 2025 AI Hackathon II



French movie giant gets 18-month suspended prison sentence

French actor Depardieu found guilty of sexual assault

PARIS, May 13, (AP): French movie star Gérard Depardieu's fall from grace is now complete.

Depardieu further moved down from the pinnacle of French cinema Tuesday as he was found guilty of sexually assaulting two women on the set of a movie in which he starred in 2021 and given an 18-month suspended prison sentence. He was also fined a total of 29,040 euros (around \$32,350), and the court requested that he be registered in the national sex offender database.

The actor, 76, has been convicted of assaulting a 54-yearold set dresser and a 34-year-old assistant during the filming of "Les Volets Verts" ("The Green Shutters"). The case was widely seen as a key post-#MeToo test of how French society and its film industry address allegations of sexual misconduct involving prominent figures.

Depardieu, who has denied the accusations, didn't attend the hearing in Paris. Depardieu's lawyer, Jérémie Assous, said that his client would appeal the decision.

"It is the victory of two women, but it is the victory of all the women beyond this trial," said Carine Durrieu Diebolt, the set dresser's lawyer. "Today we hope to see the end of impunity for an artist in the world of cinema. I think that with this decision we can no longer say that he is not a sexual abuser. And today, as the Cannes Film Festival opens, I'd like the film world to spare a thought for Gérard Depardieu's victims."

Depardieu's long and storied career - he told the court that he's made more than 250 films - has turned him into a French movie giant. He was Oscar-nominated in 1991 for his performance as the swordsman and poet Cyrano de Bergerac.

In recent years, the actor has been accused publicly or in formal complaints of misconduct by more than 20 women, but so far only the sexual assault case has proceeded to court. Some other cases were dropped because of a lack of evidence or the statute of limitations.

During the four-day trial in March, Depardieu rejected the accusations, saying he's "not like that." He acknowledged that he had used vulgar and sexualized language on the film set and that he grabbed the set dresser's hips during an argument, but denied that his behavior was sexual.

The court, composed of a panel of three judges, concluded that Depardieu's explanations in court were "unpersuasive" and "not credible" and stressed both accusers' "constant, reiterated and substantiated declarations."

The court also said that both plaintiffs have been faced with an "aggressive" defense strategy "based on comments meant to offend them." The judges therefore considered that Depardieu's lawyer comments in court aggravated the harm to the accusers and justified higher fines.

The set dresser described the alleged incident, stating that the actor blocked her path with his legs as she tried to pass through a narrow corridor.

The woman also testified that Depardieu made an offensive remark and a threatening suggestion of sexual violence. She told the court that the actor's calm demeanor during the incident was disturbing.

The other plaintiff, an assistant, said that Depardieu touched her inappropriately on three separate occasions on the film set. The Associated Press doesn't identify by name people who say they were sexually assaulted unless they consent to be named. Neither women has done so in this case.

"I'm very moved," one of the plaintiffs, the set dresser, told reporters after the verdict. "I'm very very much satisfied with the decision, that's a victory for me, really, and a big progress, a step forward. I feel justice was made."

Some figures in the French cinema world have expressed their support for Depardieu. Actors Vincent Perez and Fanny Ardant were among those who took seats on his side of the courtroom. French media reported last week that Depardieu was shooting a film directed by Ardant in the Azores archipelago, in Portugal.

The actor may have to face other legal proceedings soon. In 2018, actor Charlotte Arnould accused him of raping her at his home. That case is still active, and in August 2024 prosecutors requested that it go to trial.

For more than a half-century, Depardieu stood as a towering figure in French cinema, a titan known for his commanding physical presence, instinct, sensibility and remarkable versatility.

A bon vivant who overcame a speech impediment and a turbulent youth, Depardieu rose to prominence in the 1970s and became one of France's most prolific and acclaimed actors, portraying a vast array of characters, from volatile outsiders to deeply introspective figures.

'I need to live'

Kardashian testifies on 2016 Paris heist

PARIS, May 13, (AP): Kim Kardashian has arrived at a Paris courthouse to testify against the men accused of robbing her at gunpoint in 2016, an event that reshaped her life and redefined celebrity security in the age of social media.

This will be the first time she has faced the alleged assailants since that night, when she begged for her life as masked men bound her with zip ties and stole over \$6 million in jewelry.

Kardashian's appearance is expected to be the emotional centerpiece of a trial that has captivated France, where the suspects - mostly in their 60s and 70s - are nicknamed "the grandpa robbers."

Authorities say the group tracked her via her Instagram posts. Two defendants have admitted being at the scene. Her lawyers say she is ready to confront those who attacked her, with dignity.

Kardashian's childhood friend and then stylist told a Paris court Tuesday that she heard the celebrity beg for her life during a 2016 armed robbery that changed the star's sense of safety - and transformed the way the world viewed fame in the digital age.

Yelling

Simone Harouche, who was sharing their two-floor hotel suite during Fashion Week, said she heard a terrified Kardashian yelling: "I have ba-bies and I need to live.' That is what she kept on saying, 'Take everything. I need to live. "I was scared that she was raped or violated. I thought the worst," Harouche said. Kardashian was "screaming with terror in her voice.3 Kardashian is expected to take the stand later Tuesday, in what is likely to be the most emotionally charged moment of the trial. Her testimony will revisit the night she was zip-tied, held at gunpoint and locked in a marble bathroom while masked men stole more than \$6 million in jewels. One of the most recognizable figures on the planet, Kardashian is set to face 10 men accused of orchestrating the 2016 heist - a crime that shook the fashion world and redefined the risks of being visible, female and famous in the Instagram era. Harouche told the court the trauma "forever" changed her friend, whom she's known since age 12, robbing her of a basic human right: freedom. "She now has a completely different lifestyle," she said. "In terms of security, she can't go alone, she doesn't go alone to places anymore. To lose your sense of freedom ... it's horrible.' Kardashian's testimony is expected to recount how the attackers demanded her ring and left her fearing she would never see her children again. David De Pas, the lead judge, asked Harouche whether Kardashian had made herself a target by posting images of herself with "jewels of great value." "No," Harouche replied. "Just because a woman wears jewelry, that doesn't make her a target. That's like saying that because a woman wears a short skirt that she deserves to be raped."

Cannes opens with 3-film tribute to Ukraine

CANNES, France, May 13, (AP): The 78th Cannes Film Festival is opening Tuesday with expectations running high for what could be a banner edition.

All of the ingredients - an absurd number of stars, top-tier filmmakers, political intrigue - seem to be lined up for the French Riviera spectacular. Over the next 12 days, Cannes will play host to megawatt premieres including those of "Mission: Impossible - The Final Reckoning," Spike Lee's "Highest 2 Lowest" and Ari Aster's "Eddington."

Things get underway Tuesday with the unveiling of Juliette Binoche's jury, a three-film tribute to Ukraine and the opening night film, Amélie Bonnin's French romance "Leave One Day." At the festival's opening ceremony, Robert De Niro will receive an honorary Palme d'Or, 49 years after "Taxi Driver" won Cannes' top prize.

Cannes is coming off a 2024 festival that produced a number of eventual Oscar contenders, including "Emilia Perez," "The Substance," "Flow" and the best picture winner, "Anora." Asked if he's feeling the pressure this time around, festival director Thierry Frémaux said the only kind of pressure he believes in is in beer. (Beer on tap in France is "bière à la pression.")

"Indeed last year was a beautiful year," Frémaux said Monday. "But at the very time when I was with (journalists) as the festival started, we didn't know if it was going to be a good year or not."

Cannes is kicking off the same day Gérard Depardieu, one of France's most famous actors, was found guilty of having sexually assaulted two women on a 2021 film set. In one of France's most prominent #MeToo cases, Depardieu was given an 18-month suspended prison sentence. The 76-year-old has long been a regular presence at Cannes.

This year's Cannes Film Festival, the premier international cinematic gathering, is also unspooling following US President Donald Trump's call for tariffs on movies made overseas. While Frémaux expressed sympathy for the cause of strengthening local movie production, he said it was too soon to comment on the still-unformed plans. "It's far too early in the game," said Frémaux. "But if I say one thing here at the Cannes Film Festival, we wouldn't want the American cinema to cease to be strong. And right now, it's very strong."

Cannes will follow up Tuesday's festivities with the return Wednesday of Tom Cruise to Cannes. Three years after he brought "Top Gun: Maverick" to the festival, he's back with the latest "Mission: Impossible" movie.

Twenty-two films will vie for Cannes' top prize, the Palme d'Or. Those films include Wes Anderson's "The Phoenician

LOS ANGELES: Rapper **Tory Lanez** was hospitalized after an attack Monday at a California prison where he's serving a 10year sentence for shooting hip-hop star Megan Thee Stallion in the feet, authorities said.

Lanez, whose legal name is Daystar Peterson, was attacked at a housing unit at the California Correctional Institution in Tehachapi, at about 7:20 a.m., Pedro Calderon Michel, spokesman for the state Department of Corrections and Rehabilitation, said in an email. Cannes will also celebrate its opening by turning to an old favorite. A restoration of Charlie Chaplin's "The Gold Rush" is to debut Tuesday, timed to the film's centenary.

Meanwhile, Cannes red carpet is perhaps the most rigidly controlled red carpet in the world. Now, the festival has added a new stipulation: no nudity.

While nudity was never previously endorsed at the festival, Cannes updated its dress policy on the eve of its 78th edition to read that "nudity is prohibited on the red carpet, as well as in any other area of the festival."

While a no-shirt-no-service policy is standard in places far less glamorous than Cannes, the policy tweak sparked widespread attention Monday because of the recent trend of sheer and "nude dresses," such as Bianca Censori's Grammys appearance.

Asked for clarity on the policy, Cannes press officers said the festival "made explicit in its charter certain rules that have long been in effect."

"The aim is not to regulate attire per se, but to prohibit full nudity on the red carpet, in accordance with the institutional framework of the event and French law," it said.

Cannes also noted that "voluminous outfits, in particular those with a large train, that hinder the proper flow of traffic of guests and complicate seating in the theater are not permitted."

Still, skin has often been flashed at the French Riviera festival by celebrities like Bella Hadid, Naomi Campbell and Kendall Jenner, and dress policies have long been flouted by celebrities. For evening premieres at the Palais' Grand Théâtre Lumière, black tie and evening wear is required. Though not in recent years, Cannes security officials have sometimes turned away women for not wearing heels.

'Hunger, acute starvation and illness'

Half a million people in Gaza face catastrophic situation, WHO warns

GENEVA, May 13, (KUNA): The World Health Organization (WHO) warned on Tuesday that the ongoing blockade imposed on the Gaza Strip by occupation forces could result in "one of the worst humanitarian crises since World War II" with nearly half a million people facing a "catastrophic situation of hunger, acute starvation and illness.

Speaking from Gaza during a press conference in Geneva, WHO representative in the occupied Palestinian territories Rik Peeperkorn said that more than 55 children have died due to complications from malnutrition and related illnesses since March 2, according to WHO reports.

He added that approximately 71,000 children under the age of five are at risk of acute malnutrition in the coming months and more than 17,000 breastfeeding mothers are facing serious health risks due to continued food shortages and lack of healthcare.

He warned of long-term effects of malnutrition including stunted growth in children cognitive impairments and a general deterioration in health

Peeperkorn described the situation in Gaza as a "deadly spiral of food insecurity malnutrition a collapsing health

system scarce clean water and deteriorating sanitation services" emphasizing that "nine out of ten people" are unable to access safe drinking water.

The WHO representative also expressed concern over shortage of medical supplies stating that WHO warehouses in Gaza now hold enough

materials to treat only a few hundred children suffering from severe acute malnutrition.

According to a new report by the Integrated Food Security Phase Classification (IPC), the situation in Gaza is described as one of the worst hunger crises in the world.

Older US travelers advised against chikungunya shot

NEW YORK, May 13, (AP): The US government advised American travelers age 60 and older not get a chikungunya vaccine as it investigates possible side effects.

The Centers for Disease Control and Prevention and the Food and Drug Administration posted notices late last week on the vaccine, Valneva's Ixchiq.

Chikungunya, spread by the bites of infected mosquitoes, is a debilitating

precaution for people 65 and older about getting the vaccine.

They also recommended that a second chikungunya vaccine - Bavarian Nordic's Vimkunya - be made available for people age 12 and older who are traveling to countries where outbreaks of the mosquito-borne illness are occurring. CDC officials have not yet announced whether they will accent those recommendation



Jupiter's dazzling auroras are hundreds of times brighter than those seen on Earth, new images from the James Webb Space Telescope reveal

The solar system's largest planet displays striking dancing lights when high-energy particles from space collide with atoms of gas in the atmosphere near its magnetic poles, similar to how the northern lights are triggered on Earth.

But Jupiter's version has much greater intensity, according to an international team of scientists who analyzed the photos from Webb taken on Christmas in 2023

Webb previously captured Neptune's glowing auroras in the best detail yet, many decades after they were first faintly detected during a flyby of the Voyager 2 spacecraft. (AP)

The promise vs. reality of health tracking tools

Five essential tips for smartwatch users seeking better quality of life

Smartwatches and other wearable devices can feel almost magical. Strap on a Fitbit, Apple Watch or Samsung Gear and you're suddenly presented with a stream of data generated by - and about - your body: step counts, heart rate, blood oxygen level, calories burned and more.

Wearables offer tools that help people monitor and understand their bodies and, so the promise goes, improve their lives. Apple CEO Tim Cook has even said the technology company aspires to save your life.

As a professor who studies technology, I've spent the past decade researching smartwatches and other wearables. My new book, "Bringers of Order: Wearable Technologies and the Manufacturing of Everyday Life," considers the gap between what these products promise and what they actually do.

Wearables rely on complicated sets of sensors and computer systems to create data for each user. As these devices components measure how much the wearable moves, not the person. Shaking one's wrist very quickly can sometimes create a "step," while walking in place might not count steps.

2. Some skin tones don't 'work' as well as others Blood oxygen sensors have become incorporated into many smartwatches. They use a process called photoplethysmography, which uses tiny green LED lights on the underside of a nartwatch to track how blood flows through your wrist.

In 2022, a lawsuit alleged Apple was perpetuating racial bias, as its blood oxygen sensors didn't work as well on darker skin. The case was dismissed, partly because these limitations of blood oxygen sensors have been known to researchers and medical practitioners for years.

3. Your location may not be a secret

There's an entire industry made up of people called data brokers who buy large datasets from technology companies and then sell them to advertisers, market analysts or other groups that may be interested in acquiring them.

While some companies have taken more steps to reduce or eliminate the sharing of data with third parties, and government agencies have offered strategies for users to limit location sharing, others may still share data among affiliates and service providers.

It's important to check all settings for options to reduce or eliminate data sharing. Otherwise, your private information

become more common - and more complex - I worry that people may be tempted to think less about how they work. As a result, they might accept data at face value without considering how it was generated, whether it's accurate, or even if it could put them at risk.

So to get the maximum value from wearable technologies, it's worth reflecting on the differences between what these devices seem to do and what's actually happening behind the screen. Here are a few key points to remember.

1. Steps aren't really steps

Wearable fitness trackers gained popularity in the early 2010s for their ability to count steps and measure things such as distance, calories burned and flights of stairs climbed. While it's tempting to think so-called step counts reflect the number of times a wearer's feet have completed the action of taking a step, that is not the case.

In reality, a combination of sensors and algorithms work together to produce a data point called "a step." In most instances, something called an accelerometer measures change in the wearable's velocity. This is checked against an algorithm, which provides an automatic assessment of whether enough velocity has been reached to count as a step. These

4. Wearables for consumers aren't medical grade With wearables, as with other tech, it's important to look carefully at the terms of use.

Most devices include boilerplate language about how the data they provide the wearer should be used recreationally and not replace formal diagnostics from doctors. Even though Apple has received FDA clearance for some of its health testing features and they may be quite useful for monitoring purposes, if you're relying on data for health purposes, it's important to consult a doctor.

5. Wearables can't predict the future

OK, maybe this seems like it should be obvious. But it's not. Oura Ring, which pioneered measurements such as "restfulness" that try to measure how well you sleep, recently added a "symptom radar" to try to detect when you might be getting sick.

These technologies use sensors such as heart rate monitors and thermometers to detect changes in a wearer's baseline. While these sickness forecasts may be helpful, they're like weather reports for the body, detecting changes in the body's internal atmosphere using available sensors and algorithms. (AP)

Indian and Pakistan T20 Leagues resume after ceasefire

ISLAMABAD, May 13, (AP): The Pakistan Super League is set to resume this weekend after a ceasefire between Pakistan and India. The world's most lucrative T20 league - the Indian Premier League - also announced the resumption of the tournament. The IPL will run from Saturday until June 3. "PSL X picks up from where it left off! 6 teams, 0 fear,"

Pakistan Cricket Board chairman Mohsin Naqvi posted Tuesday on X.

"Let the aura take over as we unite and celebrate the spirit of cricket," he posted. "Get ready for 8 thrilling matches starting 17th May, leading up to the Grand Final on 25th May. Best of luck to all the teams!"

Pakistan and India agreed to a truce last Saturday after talks to defuse their most serious military confrontation in

decades

The Pakistan-based Twenty20 league was suspended last Thursday after an Indian drone fell near the Rawalpindi Cricket Stadium, which was due to host a game featuring foreign players from Australia, England, South Africa, West Indies, New Zealand and Afghanistan.

The organizers first proposed moving the tournament to Dubai but later decided to postpone it after foreign players showed their reluctance to participate in the tournament due to security concerns. Around 43 foreign cricketers - competing in six PSL teams - were flown out of Pakistan from an airbase in Rawalpindi.

It was not clear how many foreign players will return to Pakistan for the remainder of eight games, which are likely

to be played at Rawalpindi and Lahore.

Quetta Gladiators have already qualified for the playoffs and lead the standings with 13 points. Karachi Kings, Islamabad United, Lahore Qalandars and Peshawar Zalmi are in the running to fill the remaining three playoff spots.

Multan Sultans, led by Mohammad Rizwan, are already out of playoff race after losing eight of their nine league games. IPL officials made the announcement, three days after the

world's richest Twenty20 league was suspended owing to military strikes by both countries at each other.

No games will be lost. The Punjab Kings-Delhi Capitals game abandoned in Dharamsala in the 11th over on Thursday will be replayed.

Chandigarh and Dharamsala, Punjab's home and the near-

est venues to the border, have been ruled out for security and logistics reasons. Punjab will play its final two round-robin games in Jaipur.

While the government has reopened 32 airports that were closed in India's north-west corridor, the Board of Control for cricket in India is restricting the number of venues to six to be used when the IPL resumes.

The final, originally scheduled for May 25, will be con-tested on June 3. The first two knockout matches will be on May 29 and 30. Qualifier 2 will be on June 1

The league will resume with Royal Challengers Bengaluru taking on Kolkata Knight Riders in Bengaluru. India superstar Virat Kohli will be in action for the first time since his test retirement announcement earlier

'Ancelotti's impact goes beyond results; he is a strategist'

Brazil squad mired in trouble as time ticks for new coach before the 2026 World Cup

SAO PAULO, May 13, (AP): Carlo Ancelotti faces myriad problems as Brazil coach and only about a dozen games to deal with them before the World Cup if he wants to have a decent shot at the 2026 title. The initial challenges will be solving the defensive woes, bolstering the midfield and fielding a lineup that won't be over-reliant on Neymar, who has been struggling with injuries.

Brazil's soccer confederation on Monday said the 65-year-old Italian will leave Real Madrid one year before the end of his contract and take over Brazil's national team on May 26, the day after the final round of the Spanish league. Details of the deal were not released

"Ancelotti's impact goes beyond results; he is a strategist who turns teams into legends. Brazil, with its unique tradition, and Ancelotti, with his revolutionary vision, will make a partnership that will go down in history," CBF President Edualdo Rodrigues said. "He is the greatest coach in history and, now, he will be in charge of the biggest national team on the planet.'

Rodrigues' optimism doesn't entirely ring true for those who've watched Brazil over the last two years. Ancelotti's first challenge will be reigniting belief in a squad sitting fourth in South American World Cup qualifying after a heavy 4-1 loss at archrival Argentina. After a series of poor performances Dorival Júnior was fired as coach, just like his predecessors Ramon Menezes and Fernando Diniz.

Ancelotti's tenure reportedly has already started in conversations with two key Brazil players of the previous World Cup campaigns: Neymar, still recovering at Santos following his ACL tear, and Manchester United midfielder Casemiro.

There's no standout successor to either player in the national setup. If Ancelotti wants to bring the pair of 33-year-old veterans back into the squad, he'll need gameplans to play with and without them.

Brazil's creative midfield is also an issue, which has frustrated the team's several top strikers.

Lucas Paquetá, who seemed set to take that position in the starting line up, is facing charges by English soccer authorities amid allegations he had deliberately received cards during Premier League matches to influence betting markets. Paquetá denies any wrongdoing.

Other players tested in that role, including Madrid's Rodrygo, Fullham's Andreas Pereira, Flamengo's Gerson, haven't so far delivered performances

to reassure fans. That lack of a high performing creative midfield has limited the scoring ability of strikers Vinicius Júnior, Raphinha, Matheus Cunha, and Endrick

Brazil's defensive midfield is also expected to be an issue for Ancelotti - hence the call to veteran Casemiro, with whom he won several titles at Madrid. Newcastle's Bruno Guimarães and Joelinton were the latest attempt for a change.

There's other players who could take that role but no clear choices for Brazil. Ancelotti will have to go looking. Brazil's defensive woes are shocking compared

with the six years under coach Tite, between 2016 and 2022. The Selecao has conceded 31 goals in 25 matches since Qatar. That is one more than in 81 matches under Tite. Even if the team's stars don't deliver, Ancelotti's performance will be judged by how he fixes Brazil's defense, as he has done in the clubs where he's worked.

Unlike Brazil's attacking force, which has several top players and some good options for the bench, the team's defense has lacked talent at right- and left-back for years. None of the players tested since 2022 have echoed Brazil's tradition in those positions of attacking players who also know how to block opponents.

Australia is the defending WTC champion and finished the league stage with an away win over Sri Lanka after a home series victory against India.

"Those series capped a consistent performance across the two-year cycle and now presents us with the incredibly exciting opportunity to defend the World Test Championship," Australia's chief selector George Bailey said in a statement Tuesday. CAS rejects appeal from players: Sport's highest court rejected an appeal by five Uruguay players against their bans for clashing with fans after a Copa America semifinal in North Carolina last year, dismissing their claim that they acted in self defense to protect their families.

Five Uruguay players, including Liverpool forward Darwin Núñez, Barce-lona defender Ronald Araújo and Atletico Madrid defender José María Giménez, were banned for between three and five games by South American soccer body CONMEBOL after the brawl.

The players had clashed with fans in the stands at Bank of America Stadium in Charlotte after a 1-0 loss to Colombia last July. Tottenham midfielder Rodrigo Bentancur and Napoli defender Mathías Olivera also were involved and later banned.

The Court of Arbitration for Sport said Tuesday its judges dismissed appeals by the players and the Uruguayan soccer federation.(AP)



Tatum injured in final minutes

SAN FRANCISCO, May 13, (AP): Anthony Edwards scored 30 points for his second straight 30-point performance, Julius Randle had 31 points and the Minnesota Timberwolves beat the Golden State Warriors 117-110 on Monday night for a 3-1 lead in their Western Conference playoff series.

Now, it's back home to Minneapolis for the Wolves with a chance to clinch the best-of-seven Western Conference semifinal series in Game 5 on Wednesday night.

The Warriors will still be without Stephen Curry, who sat out his third game in a row and is scheduled to have his strained left hamstring re-evaluated that day.

Edwards made consecutive 3-pointers and scored 11 total points in a decisive 17-0 Minnesota run that put the Timberwolves ahead 85-68 late in the third. They led 97-77 going into the fourth and the Warriors couldn't catch up.

Edwards - coming off a 36-point performance in a Game 3 - hit a 30foot 3 to beat the halftime buzzer and pull Minnesota within 60-58 at the break. And the Wolves delivered in the second half again after also trailing by two points at halftime in a 102-97 victory in Game 3.

Jonathan Kuminga came off the bench to score 23 points and convert 11 of 12 free throws for the Warriors, following up his 30-point performance in Game 3 with another gem. Knicks 121, Celtics 113

In New York, Jalen Brunson and the New York Knicks had just taken control of the game with another fourth-quarter kick when Jayson Tatum fell to the court with a potentially severe right leg injury.

The specifics of Tatum's injury are uncertain but the situation in the Eastern Conference semifinals is clear. The Knicks need one more victory to reach the conference finals for the first time in 25 years. The Celtics need to match the biggest comeback in NBA history to extend their title reign.

"We have to turn that page quickly and do our first job, which is win on Wednesday. That's the mindset," Celtics veteran Al Horford said. "As a group, we just have to rally together because obviously we've lost our leader, the guy that gets us going.²

SHEFFIELD, England, May 13, (AP): Sheffield United eased past Bristol City 3-0 on Monday to qualify for the final of the Championship playoff.

Kieffer Moore's headed goal four minutes before halftime and another from Gus Hamer after the break killed the game off. A simple finish from Callum O'Hare late on confirmed Sheffield's dominance in what was a 6-0 aggregate triumph after their 3-0 win at Ashton Gate last week

The Black Cats are favorites to

meet Sheffield in the final at Wembley on May 25 after winning the first leg 2-1 in Coventry last Friday.

Sheffield was relegated from the top tier 12 months ago. Sunderland was last in the Premier League in 2017, while Coventry has been absent from the top division since 2001.

A return to the top tier ensures promoted clubs an estimated revenue uplift of around \$180 million in projected matchday, broadcast and commercial revenue - and much more if they survive the first season back

The playoff winner will join Leeds and Burnley in replacing relegated sides Southampton, Leicester City and Ipswich.

qqq Nottingham Forest striker Taiwo Awoniyi has undergone "urgent" surgery on an injury that was the subject of a heavily debated on-field discussion between the club's manager and owner after a Premier League game at the weekend.

The Nigeria international was injured when colliding with the goal frame after coming on as a secondhalf substitute during the 2-2 draw against Leicester on Sunday.

Forest didn't say Tuesday for how long it expects Awoniyi to be sidelined. The team has two games left in the Premier League - at West Ham and at home to Chelsea - as it seeks to qualify for the Champions League.

After the game against Leicester, Forest owner Evangelos Marinakis entered the field and remonstrated with manager Nuno Espirito Santo. Espirito Santo said Marinakis was

frustrated because of a miscommunication between the bench and medi-

cal staff after the injury to Awoniyi. After receiving treatment, the striker signaled he was OK to con-

tinue so Espirito Santo left him on and immediately made his final substitution, taking off Elliot Anderson for Jota Silva in the first minute of stoppage time.

However, Awoniyi was in discomfort for the rest of the game, effectively leaving Forest down to 10 players and hampering its hopes of a winner.

Marinakis relinquished his position as a person with significant control of Forest in recent weeks as the club closed in on unlikely Champions League qualification.

UEFA has rules to bar clubs from its competitions in any season if owners have "decisive influence" over two clubs which qualify. Marinakis is also president of Olympiacos, which has qualified as Greek champion.

With two rounds of the season to go, Forest is seventh - one point behind fifth-placed Chelsea. The top five will qualify for the Champions League.
