KUWAIT CITY, May 15: "Human rights in Kuwait are protected under the Constitution and existing laws. New legislation is being developed to ensure that Kuwait remains a pioneer, as it has long been," said Minister of Justice Nasser Al-Sumait in an exclusive interview.

He expressed his satisfaction with the unanimous approval of Kuwait's national report during the recent session of the United Nations Human Rights Council in Geneva, which was attended by representatives from approximately 115 mem-

Minister Al-Sumait said, "The unanimous approval of Kuwait's fourth national report reflects the extent of progress made recently, especially within the short tenure of the current government, regarding important issues included in the report, particularly those concerning citizenship, and civil and human rights, which Kuwait will never compromise.

Kuwait succeeded in fulfilling the Human Rights Council's recommendations ahead of the final session. The country is currently working to develop legislation related to other recommendations, in line with the directives of His Highness the Amir of Kuwait Sheikh Meshal Al-Ahmad Al-Jaber Al-Sabah, who always emphasizes the importance of ensuring that everyone enjoys their rights without discrimination.

Kuwait has taken note of the Human Rights Council's observations regarding freedom of opinion and expression. It is well known that media and expression freedoms are fully guaranteed in Kuwait under existing laws. However, there are red lines that cannot be crossed, such as

harming individuals' reputations or offending His Highness the Amir. Kuwait does not allow anything that contradicts Islamic law or is otherwise prohibited by law. Aside from these exceptions, freedom of opinion and expression is protected in Kuwait, and is based on firm and longstanding foundations that date back centuries, not merely decades.

Work is currently underway to amend some outdated laws, particularly those related to financial issues, most notably, the penalties for issuing bounced checks. There is an ongoing effort to either repeal or amend the relevant article to protect the human rights of individuals involved, including abolishing criminalization and imprisonment, as these are seen as restrictions on personal freedom.

The report also includes guarantees that the civil rights and freedom of work for individuals whose citizenship has been revoked will not be affected.

Measures are being taken in this regard under the directives of the supreme leadership. His Highness the Amir is keen about ensuring that no one is subjected to injustice. This matter is being closely and directly followed by His Highness the Amir, His Highness the Crown Prince, and His Highness the Prime Minister.

Kuwait has recently seen the emergence of new types of crimes that were not seen previously, and these require firm and effective legislation. For this reason, we are working with the relevant institutions to draft practical laws that reflect current realities as well as uphold human rights."

Regarding the Human Rights Council's recommendation to abolish the sponsorship (kafala) system, Minister Al-Sumait said, "Serious steps are being taken in that direction. These efforts aim to preserve national sovereignty, as well

as ensure workers enjoy their full rights, and to support the development of commercial, industrial, and service sectors.'

Minister Al-Sumait affirmed that positive steps have already been taken in response to the Human Rights Council's recommendation to strengthen legislation for combating domestic violence and to intensify efforts against intolerance, prejudice, and discrimination, particularly toward foreigners.

He added that a great deal of work is ongoing to meet the objectives of these recommendations.

Minister Nasser Al-Sumait concluded by stressing that, "We are working tirelessly to position Kuwait as a leader in the field of human rights. This mission requires great effort, and we are racing against time to meet the high standards and goals set by His Highness the Amir for the government upon taking the Constitutional oath."

Kuwait's tax vacuum hurts future stability

Curb waste, grow revenues: expert

KUWAIT CITY, May 15: Dr. Jumana Al-Sayrafi, an expert in public financial laws and tax legislation at the College of Law in Kuwait University, emphasized the importance of diversifying sources of income in light of regional and global economic changes.

Al-Sayrafi pointed out to the newspaper in a recent interview that "financial sustainability is emerging as a national necessity, not just an option; especially since Kuwait relies on oil for more than 85 percent of its public revenue. At the same time, ensuring long-term financial stability requires a radical shift in economic policies that enhance the State's ability to fulfill its obligations and prevent the burden from being passed on to future generations."

KUWAIT CITY, May 15: Acting Chief Executive Officer (CEO) of Kuwait Oil Tankers Company (KOTC) Sheikh Khaled Al-Sabah has announced that Kuwait is now producing 16 million gas cylinders annually using solar energy through the Umm Al-Aish and Shuaiba plants, which have a combined production capacity of seven megawatts without using electricity from the

towards using solar energy to generate electricity in order to reduce reliance on electricity loads.

Speaking at the inauguration ceremony for the conversion of production in both plants to solar power, Sheikh Khaled Al-Sabah affirmed that this step is in line with the strategic plan of the country to reduce carbon emissions and achieve carbon neutrality by 2050. He described the project as a vital part of the ongoing effort to reduce reliance on conventional energy and limit environmental impact.

DOHA: President **Donald Trump** said Thursday that the **United States** and **Iran** have "sort of" agreed to terms on a nuclear deal, offering a measure of confidence that an accord is coming into sharper focus.

Trump, in an exchange with reporters at a business roundtable in Doha, **Qatar**, described the talks between American envoy Steve Witkoff and Iranian Foreign Minister **Abbas Araghchi** as "very serious negotiations" for "long-term peace" and

were continuing to progress.
Still, throughout his visit with Arab Gulf leaders this week, the president has underscored that military action against Iran's nuclear facilities remains a possibility if the talks derail.

Panel urges online submission as grievances climb

Over 14,000 file appeals on citizenship revocations

KUWAIT CITY, May 15: Chairman of the Cabinet's Grievance Committee for Withdrawal, Revocation, and Loss of Kuwaiti Citizenship Counsellor Ali Al-Dhubaibi announced that the committee has received 14,360 grievances from the start of the submission period up to Wednesday, May 14, reports Al-Seyas-

He told the Kuwait News Agency (KUNA) that the grievance submission period is 60 days, starting from Sunday, May 4.

Al-Dhubaibi explained that the committee continues to accept grievances throughout the week, including official holidays, to ensure the process remains accessible and convenient for all.

It reviewed a presentation submitted by its secretariat, which included an overview of the submitted grievances, compiled statistics, and the measures taken to review the grievances submitted through the committee's electronic portal.

'Kuwait and developing world need statesmen renaissance'

"AS pressures on nations intensify and the gap between principle and interest narrows, there is a growing need to distinguish between a "politician" and a "statesman." This distinction is not merely semantic but it is a developmental necessity that can shape the destiny of nations at critical historical junctures", columnist Major General Engineer Faisal Musaed Al-Jazzaf wrote for Al-Seyassah daily.

"A "politician" is often a product of the political marketplace, skilled at

seizing the moment, shifting between masks. and adjusting his rhetoric to suit prevailing winds. He excels at turning crises into personal opportunities and is more focused on engineering alities to fuel his own rise than on ensuring the sta-

bility and progress of his nation.

"The politician elevates polls to a sacred status, thriving on division and propaganda, because his measure of success lies in the applause he receives. He is uninterested in the accuracy or long-term impact of his decisions.

"In contrast, a statesman is a rare figure in a world often dominated by political opportunism. The statesman does not negotiate the core principles of the state, nor does he bargain over established values. He does not rush toward power, but rather moves toward it only when duty calls, not when personal gain beckons.

"The statesman sees crises as a revelation of the underlying problems, not as an opportunity for personal advancement. He digs deeper, exposes corruption, and confronts the facts, even if it means bearing the cost alone.

"The statesman invests in building trust, a trust that remains unshaken when challenges arise. He is not concerned with public displays or self-promotion but works quietly in the background to protect the national vision from erosion.

"The statesman understands that division can never serve his nation's true interests. He sees it as a crack in the state's foundation, which can only be healed with honesty, integrity, and unwavering resolves."

"The statesman is often rejected, not because he has failed, but because his presence is uncomfortable and threatens to expose the false masks that others hide behind, as his honesty is too much for the political scene to bear.

"What Kuwait, and indeed the entire developing world, need most is not an abundance of politicians, but a renaissance of statesmen.

"States are not built through evasion, but through sound management. They are not preserved by empty slogans, but by effective governance, competence, and a long-term vision.

"History does not record the number of handshakes in front of cameras. It immortalizes those who saved an idea on the brink of failure, and those who prioritized the state's well-being over their own personal future. That is the essence of a statesman. Everything else, no matter how brilliant the slogans, remains mere superficiality and is unable to endure for long."

Also:

"Since gaining independence in 1947, India and Pakistan have been locked in a persistent cycle of tension and conflict that continues to this day. The historic partition of India, carried out under the supervision of the British colonial administration, was marked by immense bloodshed and suffering. Nearly one million people were killed, and more than 14 million were displaced in one of the largest forced migrations in modern history", Iraqi politician **Dr. Aid Al-Hilali** wrote for **Al-Seyassah** daily.

"Since then, hostility between the two nations has manifested in three major wars. The first, in 1947–1948, was fought over the disputed region of Kashmir. It ended with the United Nations' intervention and the establishment of a ceasefire line that divided Kashmir between India and Pakistan, without achieving a final resolution.

"The second war, in 1965, also broke out over Kashmir and ended with the Soviet-brokered Tashkent Agreement, though it failed to achieve a comprehensive resolution of the conflict.

"The third war, in 1971, was even bloodier and resulted in the secession of East Pakistan from West Pakistan, leading to the creation of Bangladesh with Indian support. This further complicated the already strained relationship between the two neighboring countries.

"However, despite these periods of conflict, relations between the two countries have also seen moments of détente, including:

The 1972 Simla Agreement, which established a framework for peaceful dialogue following the 1971 war.

■ The 1999 Lahore Process, a diplomatic initiative between Indian Prime Minister Atal Bihari Vajpayee and Pakistani Prime Minister Nawaz Sharif, which expressed a genuine desire to move beyond past hostilities. However, these hopes were quickly dashed by the Kargil

military operation later that same year.

"The official acquisition of nuclear weapons by both countries in 1998 added a new and more dangerous dimension

to their long standing rivalry.
"Thanks to mutual nuclear deterrence, a full-scale war has been avoided. However, this has not prevented ongoing tensions, frequent skirmishes along the border, or terrorist incidents attrib-

uted to militants from both sides

"Amid this backdrop, important questions arise: Where are the voices of reason? Is there still space for wisdom to salvage what remains of the relationship between the two nations? The answer lies with a significant segment of intellectuals, thinkers, and civil society organizations, who have long advocated for moving beyond the complexities of the past.

"In India, many recognize that true national security cannot be achieved through endless hostility. In Pakistan, more voices are calling for a shift in focus toward economic development and education, rather than military armaments and conflicts.

"The truth is that both countries face common challenges, including rising unemployment, climate change, terrorist threats, and declining quality of life in many rural areas.

"These pressing issues call for regional cooperation, not prolonged conflict. And perhaps, new opportunities are on the horizon.

"In an increasingly interconnected world, economic crises are pushing governments to prioritize stability and development. As awareness grows among the youth in both nations, a new generation may emerge, one that believes cooperation, not confrontation, is the path to a better future.

"With all this in mind, the question remains: Will voices of reason play a role in reaching a settlement? The answer depends on the willingness of political leaders to listen to their people, and on their courage to rise above the wounds of the past in order to build a shared, peaceful, and prosperous future."

"The ability to handle difficult and embarrassing situations with good manners requires shrewdness, intelligence, and quick wit. These qualities become even more necessary when displayed by rulers, dignitaries, or older individuals", Doctor of Law and Kuwaiti Lawyer **Dr. Nayef Al-Adwani** wrote for **Al-Seyassah** daily

"In such cases, the response requires even greater caution and consideration in different social or legal environments where it can easily be misinterpreted or could provoke anger. Sometimes, silence, ignoring the situation, or distancing oneself may be the best course of action to avoid embarrassment and

negative consequences.
"One of the difficult and embarrassing situations faced by a prominent Kuwaiti, known for his leadership and intelligence, occurred during a summer business trip to Britain.

"While waiting at a pedestrian crossing for the traffic light to turn green, an elderly British woman stood next to him. She gave him a suspicious look and asked where he was from. He politely replied, "I'm from Kuwait, on the Arabian Gulf." She angrily responded,

"You brought the heat with you."

"He responded politely and wisely, saying, "You colonized the region for more than 50 years, but you never

brought us any cold."

The elderly woman laughed, realizing she was face-to-face with a wise man.

She apologized and walked away.

Maslama replied, "He is between your brother Al-Walid and your grandfather Abd al-Malik, so judge as you see fit." Ibn Maslama meant that it was Caliph

Abd al-Malik, the grandfather, who appointed Hajjaj as governor of Iraq, and he continued in that position during the reign of his brother, Al-Walid ibn Abd al-Malik.

"Caliph Sulayman ibn Abd al-Malik fell silent and made no further comment.
"One day, while the Umayyad Caliph Umar ibn Abd al-Aziz was walking through the market, a man in a hurry pushed him aside and asked, "Are you blind?" One of the guards attempted to strike the man, but Umar ibn Abd al-Aziz stopped him and calmly replied,

"No, I am not blind."

"When the Caliph returned to the palace, the guard asked why he had prevented him from retaliating against the man who had insulted him. Umar replied, "He asked me, 'Are you blind?' I simply answered, 'No." And that was the straightforward response to his question.

"When Dr. Saleh al-Ojairi, the renowned Kuwaiti astronomer, was asked why Kuwait was so cold in winter compared to other countries in the region, he explained that it was due to an air passage coming from Siberia. One of the attendees, in an attempt to embarrass him, asked, "Why doesn't this passage come to Kuwait in the summer to relieve the intense heat?"

"Al-Ojairi responded immediately, "The reason is the Indian hot air passage, which blocks the cool air and causes the intense heat in Kuwait."

"During King Faisal bin Abdulaziz's visit to Britain in his youth, he was seated at a dinner table with several dignitaries. The British Foreign Secretary asked him about the political situation in Saudi Arabia. King Faisal replied, "I understand that the British do not discuss politics at the dinner table."

Bid to smuggle 110kg drugs foiled

KUWAIT CITY, May 15: The Criminal Court has acquitted media personality Fajr Al-Saeed of insulting the Iraqi Prime Minister.

In February 2025, the court released Al-Saeed on bail of KD 1,000 in connection

with the case. This followed a waiver submitted by Lawyer Hassan Al-Mousawi, representing the Iraqi embassy, in accordance with directives from the Iraqi Prime Minister, after Al-Saeed issued an official apology.

However, Al-Saeed remains in prison in execution of a separate Criminal Court ruling, which sentenced her to three years of hard labor for promoting normalization with Israel. **110 kg drugs seized:** Kuwaiti security forces on Wednesday foiled a plot to smuggle some 110 kilograms of cannabis onboard a cargo ship, saying that two individuals have been arrested in connection with the incident.

The substances seized include some 6,000 Captagon tablets and some five grams worth of methamphetamines, according to an interior ministry statement, saying the two men arrested have been referred to authorities, pending legal action.

Kuwaiti loses big amount in fake investment offer




According to the complainant, the suspect stopped communicating with him when he demanded the return of his money.

MoE sets date to submit bonuses

KUWAIT CITY, May 15: The Ministry of Education has started preparing budget estimates under Chapter One (Employee Compensation) of the draft budget for fiscal

The ministry confirmed that no bonuses will be included in the draft budget for the next fiscal year if they are not submitted on or before the deadline -- May 31, 2025; which is the final date for receiving responses from the concerned authorities.

The newspaper obtained a copy of the letter of Assistant Undersecretary for Administrative Affairs and Administrative Development Mansour Al-Dhafiri to the Public Éducation Sector, urging departments to submit their proposed bonus allocations

using a standardized model. This model requires categorizing bonuses into the following types: additional work, excellent performance, training, teaching and supervision, committee work and other work.

Al-Dhafiri stressed the importance of specifying the names of all committees and work teams expected to be formed in the upcoming fiscal year, along with the necessity of providing the Administrative Affairs Sector with a separate breakdown of the estimated cost for each committee or team, and a copy of the decision to form each committee or team immediately upon its issuance.

He also requested a detailed statement regarding 'other work' bonuses, if any, to be clearly included in the designated bonus table. "This is necessary to facilitate budget analysis and ensure the proper inclusion of these amounts in the draft budget," he clarified.

Legal experts views differ over execution of 'land usage' law

Constitutional Court set to issue ruling

KUWAIT CITY, May 15: The Law on Combating the Monopoly of Vacant Lands, Law No. 126/2023, has once again come into the spotlight, as the Constitutional Court is set to rule on appeals No. 15/2024 and 18/2024 filed against the Prime Minister and others. regarding the constitutionality of the law's provisions.

Amid rapid developments, the daily met

with several constitutional and real estate experts to gauge their opinions on the law in light of recent events, and to gain closer insight into the legal and constitutional perspectives surrounding it.

Constitutional expert Dr. Mohammad Al-Faili confirmed that the issue has been brought before the Constitutional Court on

several occasions, and the court upheld the law's constitutionality based on both substantive and procedural considerations.

He explained that the objective consideration is rooted in the fact that the Kuwaiti Constitution acknowledges the right to ownership in Article 18, while Article 16 emphasizes that this right carries a social function. The Constitution's explanatory memorandum clarifies that the social role of ownership right includes the right to build capital, and that the right to work allows imposing restrictions, not to abolish the right entirely, but to regulate it.

The constitutional right to ownership is not absolute; rather, it is subject to regulation in order to fulfill its intended social purpose. The question is - "Does the legislator still maintain a balance between the right to ownership and the reduction in owned land area?" This matter falls within the discretion of the Constitutional Court.

Meanwhile, real estate legal advisor Iman Al-Hashash stated that Law No. 126/2023, which aims to combat the monopoly of vacant lands, reflects a legislative effort to curb unproductive real estate speculation and encourage the effective utilization of residential land.

Al-Hashash explained that the law was introduced in line with several clearly defined state objectives, most notably combating the monopolization of vacant residential plots, which has contributed to inflated real estate prices and worsened the housing crisis. The law also seeks to motivate landowners to develop and make optimal use of their properties, thereby supporting urban growth.

The legislation aims to ensure justice in land distribution and prevent the concentration of land ownership among a small group of merchants. It also intended to strengthen the public budget through fair and progressive fees imposed on landowners.

Despite the legitimacy of its objectives, the law has sparked several constitutional concerns. Main among them is the argument that imposing progressive fees on unused vacant lands that generate no income places a financial burden on the owner and may conflict with the right to property as outlined in Article 16 of the Kuwaiti Constitution.

Some constitutional experts, including Dr. Ibrahim Al-Hamoud, Professor of Public Law at Kuwait University, believe the law may be unconstitutional. They believe that it imposes financial obligations on a non-income-generating asset, which violates the concept of taxation as defined in Article 48 of the Constitution.

Al-Hashash said the law raises legal debates regarding its lack of differentiation between various cases, for example, between those who own undeveloped plots but are unable to build due to delayed municipal planning or the lack of infrastructure. This, she stressed, may contradict the principle of equality before the law as guaranteed by Article 29 of the Constitution.

In addition, legal researcher Imad Khamis Al-Iqab stated that the law in question presents several constitutional concerns, most notably the provision stipulating its retroactive application.

He explained that retroactive legislation is a contentious issue in constitutional jurisprudence, as it undermines the ability of citizens to anticipate the laws that will govern their future actions.

From a constitutional standpoint, retroactive application may conflict with the principles of legal security and Islamic legitimacy, both of which are fundamental pillars of constitutional governance. Constitutional doctrine emphasizes that the legislature should refrain from enacting laws with retroactive effect, except in rare and exceptional cases justified by extreme necessity and clear public interest. Even in such cases, strict controls must be in place to prevent any misuse of legislative authority.

Legal action taken: KFF

'Don't tamper with gov't seal, sticker'

KUWAIT CITY, May 15: Director of the Public Relations and Media Department at the Kuwait Fire Force (KFF) Brigadier General Mohammed Badr Ibrahim revealed that a video circulating on social media shows an individual removing an official Kuwait Fire Force sticker and seal without legal justification.

In a press release issued by KFF, Brigadier General Ibrahim stressed that the individual's actions are criminalized under the country's laws and regulations, and constitute a violation of official property and documents, which are classified as legally protected symbols.

He confirmed that the relevant authorities have already initiated legal action against the perpetrator.

Brigadier General Ibrahim explained that tampering with any official logo or seal is a criminal offense punishable by law, as it undermines the authority of the official entity and constitutes a serious violation of regulations. Kuwait Fire Force will not tolerate such actions and will confront them firmly within the legal framework.

Brigadier General Ibrahim concluded his statement by stressing the importance of adhering to the laws in force.

He urged everyone to act responsibly, comply with regulations, cooperate in protecting official logos and seals, and report any similar violations.

5 years in terror case: The Criminal Court sentenced a citizen to five years in prison with hard labor for violating the State Security Law, reports Al-Anba daily. The citizen was referred to trial after security investigations revealed that he joined

Asians smuggling liquor: The Drug Control General Department (DCGD) has arrested three Asian expatriates for attempting to smuggle 1,120 bottles of imported liquor, reports Al-Seyassah daily.

The Ministry of Interior explained that the suspects attempted to smuggle the liquor into Kuwait in a professional manner via the country's maritime borders, specifically through a Kuwaiti port. The suspects, along with the seized items, have been referred to the concerned authorities for necessary legal action.

Kuwait's tax

She stated that despite the budget surpluses achieved by the State in recent years due to rising oil prices, the International Monetary Fund (IMF) reports confirmed that this abundance does not necessarily mean long-term stability.

"Fluctuations in oil prices and production, along with the global shift toward clean energy, entail that Kuwait must quickly adopt new mechanisms to diversify its sources of income and reduce its sensitivity to external shocks," she explained.

She said achieving financial sustainability requires a package of interconnected reforms; foremost of which is diversifying sources of income through the development of non-oil sectors, such as industry, tourism and digital services

'Second, there is a focus on increasing the efficiency of government spending by reducing waste and redirecting the budget toward development projects with a sustainable impact. Third and the most important, is the establishment of a modern and fair tax system that contributes to generating sustainable revenues, especially since taxes in Kuwait represent only a very small percentage of gross domestic product (GDP)," she elaborated.

She cited IMF reports to support her view; indicating that non-oil tax revenues remain the lowest among GCC countries, as the State relies primarily on investment profits, not taxes. 'The reports warned that this situation should not continue. In addition, Kuwait is not saving enough for future generations, which reinforces the need for financial and structural reforms that support long-term justice and stabil-'she revealed.

She added that recognizing the magnitude of the challenges, the State has adopted a package of important legislation to support sustainability; most notably Decree-Law No. 60 of 2025 on Financing and Liquidity, which allows the government to borrow up to KD 30 billion over 50 years to finance the general budget, manage debt and fulfill obligations.

She clarified that this step is considered a financial pillar to secure liquidity without compromising wealth funds or resorting to short-term solutions.

"As part of the tax reform, the State, through the Ministry of Finance, announced the preparation of a selective tax law, which will be imposed on goods considered harmful to health like tobacco, energy drinks and sweetened beverages," she stated.

She mentioned statistics from the Gulf Health Council, pointing out that implementing this tax at a moderate rate could generate revenues for Kuwait of approximately K 639 million between 2025 and 2029, while reducing cigarette consumption by around four billion cigarettes and sugary drinks by 220 million liters. "Revenues could reach KD 997 million if the tax is implemented at a higher rate,' she hinted.

"The Ministry of Finance is also preparing a draft law to impose a tax on local business profits, a move aimed at expanding the tax base and promot-Kuwait currently does not impose a profit tax on most local companies. This comes in parallel with the implementation of a global minimum tax on multinational companies. Decree-Law No. 157/2024 was issued regarding the imposition of a tax on multinational entities, known as the Domestic Transfer Tax (DMTT), in line with the second pillar of the Organization for Economic Co-operation and Development (OECD) initiative. This legislation aims to limit tax evasion by large companies by shifting their profits to low-tax countries. It is expected to generate annual revenues estimated at approximately KD 250 million starting in fiscal year 2027-2028, according to Ministry of Finance estimates," she added.

Regarding tax challenges in the digital age, Al-Sayrafi asserted that despite the legislative momentum, the tax system in Kuwait continue to face big challenges, especially with the acceleration of digital transformation and the emergence of new economic models that are not subject to traditional tax frameworks.

She said these challenges include the proliferation of cross-border digital services, which are provided without the need for a permanent physical presence or fixed headquarters in the country. "These services include streaming platforms, electronic applications, cloud software as a service (SaaS), and digital advertising," she revealed.

She affirmed that these activities generate profits from the local market without being subject to tax accountability, creating a clear gap in tax justice and reducing the revenue base.

"This is in addition to the widespread use of cryptocurrencies like Bitcoin and Ethereum, which represent decentralized assets that are difficult to track and are used in trading and investment without direct banking oversight," she asserted.

She explained all these aspects open the door to tax evasion and money laundering, as well as to challenges in asset classification. "Are they treated as currency, capital assets or commodities? There are practical complications in accurately determining their

"In the absence of a clear legal and regulatory framework in Kuwait to regulate these digital and virtual activities, there is an urgent need for modern, specialized legislation, accompanied by an integrated electronic infrastructure that links tax authorities with financial and technology service providers. This ensures transparency, compliance and closing loopholes in tax evasion in the digital age," she

She said Kuwait is currently facing a pivotal moment, as it possesses the

sovereign reserves and financial capabilities that qualify it to implement comprehensive tax and structural reforms from a position of strength, not under the pressure of crises.

"The IMF has warned that delaying these reforms increases the fragility of the financial system and undermines confidence in its ability to withstand future challenges," she stressed.

She went on to say that building a modern tax system is not just about collecting revenues, but also about achieving social justice and establishing an effective partnership between the State and society in financing development and securing the future of future generations. "It is a national responsibility that requires conscious political will, clear legislation and societal confidence that reform today guarantees stability tomorrow," she

Over 14,000

He referred to the decrees and decisions issued regarding the withdrawal, revocation, or loss of Kuwaiti citizenship, as well as those whose citizenship certificates were revoked between February 20, 2024, and April 30, 2025, as published in the official gazette "Kuwait Al-Youm"

Al-Dhubaibi emphasized that the committee will not consider any grievances previously submitted or those submitted through methods other than the method recently announced.

He urged individuals wishing to file a grievance against a decree or decision related to the revocation, cancellation, or loss of Kuwaiti citizenship, or the annulment of a citizenship certificate, to complete the official form available at the following link - https:// nationalitygrievances.cmgs.gov.kw/.

Al-Dhubaibi affirmed the committee's full readiness to assist anyone facing difficulties in submitting a grievance through the online platform, adding that support is available via the committee's contact numbers.

Kuwait's sun-driven

He also highlighted the aspiration of the company to expand its oil tanker fleet, which currently includes 31 vessels. He revealed a comprehensive strategy is being developed and will be announced soon, reaffirming that KOTC continues to meet all marketing demands and remains a key player in the energy logistics of the country.

He added the shipping operations of KOTCH remain stable, even amid global trade tensions, thanks to strategic planning for crisis scenarios. He confirmed that the current trade war has not affected the markets of Kuwait Petroleum Corporation (KPC). "Our distribution and marketing operations are built on long-term, strategic relationships," he asserted; while stressing the commitment of the country to fulfill all international contracts.

He added Kuwait maintains a strong overseas presence with seven million barrels of oil stored in Asia -- three million in Japan and four million in South Korea. He disclosed that KPC has a comprehensive strategic plan to study markets and market needs, determine development capacity and increase vessels based on market data.

Asked about the merger of the two gas plants into the Kuwait National Petroleum Company (KNPC), he confirmed that the integration of the Umm Al-Aish and Shuaiba gas plants into KNPC is moving forward as per an ambitious plan. He said KNPC currently provides gas to KOTC tankers, highlighting the synergy between national entities.

On the other hand, Director of the Projects and Maritime Agency Group at KOTC Yousef Al-Khamis stated that the solar energy conversion project cost around KD1.9 million; indicating this investment is expected to save about 16,000 barrels of oil annually and generate 11,000 megawatts of clean energy; thereby, easing pressure on the national electrical grid.

Al-Khamis also unveiled the plan to establish a third gas cylinder factory in Kabad, while the two existing plants can meet domestic demand until 2030. He said the expansion is part of the

company's long-term strategy. He also addressed concerns about misuse of household gas cylinders by restaurants. "We are coordinating with the Cooperative Societies Union and the Ministry of Commerce to implement mechanisms that prevent restaurants from using cylinders designated for residential use, instead of commercial cylinders," he added.

Tourism sector

Municipality to promote tourism in the Sultanate and unveil details of the Dhofar Khareef 2025 season.

Present at the press conference were representatives of various travel agen-

Al-Kharousi stated that the tourism sector has achieved remarkable growth over the past years, with nearly four million tourists visiting the Sultanate in 2024-- 1.2 million of whom were from the Gulf.

He added "the hotel sector generated revenues exceeding OMR 240,000,000 from 3- to 5-star hotels, with an occupancy rate of nearly 50 percent and a growth rate of six percent compared to 2023 -- around 2,000,000 hotel guests and 3,000,000 hotel nights.

On the tourism activity in Dhofar Governorate during the Khareef season -- from June to September each year, he confirmed the increase of tourism activity in the governorate; exceeding the 1,000,000 visitor mark in 2024. "It is the highest number to date. The Sultanate is considered one of the tourist destinations that attracts Kuwaiti tourists throughout the year,

ranking third after Emirati and Saudi tourists. More than 34,000 Kuwaiti tourists visited the Sultanate of Oman in 2024, with an average stay of four to six days. During the first quarter of this year, around 7,000 Kuwaiti tourists visited Oman -- a growth rate of seven percent compared to the same period in 2024," he narrated.

He affirmed that Oman is distinguished by its unique geographical diversity; placing it on the regional and international tourism map, with its towering mountains, picturesque beaches, authentic Omani heritage and culture, and the hospitality and welcoming nature of the Omani people.

He asserted that "the tourism sector in Oman is witnessing rapid growth. Hotel projects and tourist resorts provide an unforgettable tourist experience on the mountaintops and beaches, extending across various governorates. The St. Regis Hotel and the Mandarin Oriental Hotel opened recently. The Royal Opera House, National Museum, and Oman Through Time Museum are also among the most preferred tourist destinations that enrich the tourist experience."

He pointed out that Oman has been keen on developing adventure tourism by licensing and regulating this type of tourism through specialized companies licensed to practice adventure activities according to the highest international safety and security standards.

On the other hand, Assistant Director of Tourism Market Development at the Ministry of Heritage and Tourism Yousef bin Khalaf Al-Majizi confirmed the ministry's readiness for the 2025 Dhofar Khareef season by implementing numerous programs as part of the plan to promote the season, in cooperation with all the concerned authorities. He said Dhofar Governorate has 83 licensed hotel establishments providing 6,537 rooms and it is fully prepared to receive visitors during the season.

582 cases in Kuwait prompt alarm

KUWAIT CITY, May 15: The Cancer Aware Nation (CAN) has launched the 'Your Health, Your Decision' campaign to raise public awareness about colon cancer and highlight the risk factors that may lead to this disease; considering it ranks first among men and second among women in Kuwait after breast cancer, with a total of 582 cases - 326 Kuwaiti women and 256 expatriates.

Chairman of CAN Board of Directors and Head of the Colon Cancer Awareness Initiative Dr. Khaled Al-Saleh stated that holding such campaigns is good for the targeted groups, indicating that the majority of colon cancer cases occur in those over the age of 50.

He explained that the disease has seen progress in the past two decades in terms of prevalence among cancer types in the Gulf countries, including Kuwait. He stressed the importance of adopting a healthy lifestyle that includes a balanced diet rich in fruits and vegetables, as well as maintaining a physically active lifestyle.

He pointed out that awareness is the cornerstone of prevention and early detection of cancer, stressing that CAN is exerting tremendous efforts to change the misconception about cancer as a fatal disease and to raise awareness on the importance of early detection.

He revealed the recent statistics in Kuwait showed that the total number of cancer cases has reached 2,775 - 53.3 percent of whom are citizens (1,478 cases) and 46.7 per-

cent are expatriates (1,297 cases). He added that CAN trained about 1,729 doctors and 2,973 nurses on self-examination and early detection of breast cancer for female stu-

Democratic congressman pushes articles of impeachment against Trump

WASHINGTON, May 15, (AP): A Democratic lawmaker is launching a renegade effort to impeach President Donald Trump, pushing past party leaders on Wednesday with an attempt to force a procedural vote in the US House that is expected to fail.

Rep Shri Thanedar of Michigan announced his intention to charge ahead, saying that as an immigrant he wants to do all he can to protect America's Constitution and its institutions. His resolution contains seven articles of impeachment against the Republican president.

"Donald J. Trump has been committing crimes since day one - bribery, corruption, taking power from Congress, creating an unlawful office in DOGE, violating First Amendment rights, ignoring due process," the congressman said earlier from the House

It would be the historic third time Trump has faced impeachment efforts after being twice impeached during his first term as president - first in 2019 on charges related to withholding military aid to Ukraine as it confronted Russia and later on a charge of inciting insurrection over the Jan. 6, 2021, attack on the Capitol by a mob of his supporters. Trump was acquitted both times by the

Thanedar is not the only Democrat who has signaled impeachment efforts against Trump. But his decision to go it almost alone, without backing from party leadership, comes as he faces his own political challenges at home, with several primary opponents looking to unseat him in his Detroit-area congressional district.

Rep Pete Aguilar of California, chair of the House Democratic Caucus, said Democratic leadership would vote to sideline any effort to bring Thanedar's impeachment articles to a full vote, calling impeachment "not the right approach we should be taking.'

"Right now, our focus is on health care being stripped away from the

American people," Aguilar said. "That is the most urgent and dire thing that we could be talking about this week."

Aguilar added that Trump "is no stranger to impeachment" but said Thanedar's proposal is "not ripe and not timely" given the negotiations over Republicans' budget reconciliation budget reconciliation package.

Democrats who streamed out of their weekly caucus meeting were critical of the impeachment effort. They said the focus should not be on impeachment but on Republican efforts to cut spending on important programs that Americans rely on, such as Medicaid and nutrition assistance.

"There's no support for an impeachment resolution. There have been no hearings on compiling a record for which impeachment can be based. And this is just a procedure that's meaningless at this point," said Rep. Hank Johnson, D-Ga. "The sponsor is out of sync with the mood and the trajectory of House Democrats."

'The work that we need to focus on is that Republicans are stripping away access to health care, stripping away nutritional assistance for hungry kids, and giving tax breaks to the wealthiest Americans and large corporations,

said Rick Larsen, D-Wash, "This resolution has nothing to do with that."

Timing is also key. Thanedar's resolution claiming Trump committed "high crimes and misdemeanors" comes as Trump is traveling in the Middle East in his first major trip abroad of his second term, violating a norm in American politics of not criticizing the president once he leaves the US waters' edge.

But Thanedar said he was pressing ahead in part because of Trump's trip abroad and the potential conflicts of interest as the president appears to be mixing his personal business dealings with his presidential duties and is considering accepting a lavish gift of an airplane from the Qatari government.

'My constituents want me to act,' Thanedar told The Associated Press late Tuesday.

Militarized border zone spurs nat'l security charges against immigrants

SANTA FE, NM, May 15, (AP): Several hundred immigrants have been charged with unauthorized access to a newly designated militarized zone along the southern U.S. border in New Mexico and western Texas since the Department of Justice introduced the new approach in late April.

President Donald Trump's administration has transferred oversight of a strip of land along the US-Mexico border to the military while authorizing U.S. troops to temporarily detain immigrants in the country illegally - though there's no record of troops exercising that authority as US Customs and Border Protection conducts arrests. The designated national defense areas are overseen by U.S. Army commands out of Fort Bliss in the El Paso area in Texas and Fort Huachuca in Arizona.

The novel national security charges against immigrants who enter through those militarized zones carry a potential sentence of 18 months in prison on top of a possible six month sentence for illegal entry. The full implications are un-

The Trump administration is seeking to accelerate mass removals of immigrants in the country illegally and third-country deportations,

including Venezuelans sent to an El Salvador prison amid accusations of gang affiliation. The administration has deployed thousands of troops to the border, while arrests have plunged to the lowest levels since the mid-1960s

Harvard joins colleges moving to self-fund some research to offset fed funding cuts

WASHINGTON, May 15, (AP): Harvard University is putting up \$250 million of its own money to continue research efforts amid a federal funding freeze imposed by the Trump administration, but the school's president warns of "difficult decisions and sac-

The university joins a growing number of colleges moving to self-fund research as a way to compensate for at least some of the money lost to federal funding cuts.

Johns Hopkins University has started offering grants of up to \$150,000 a year to faculty facing "unexpected federal research funding disruptions.' Northwestern University said it's covering the cost of research projects that received stop-work orders from the federal government in April.

In a campus message Wednesday, Harvard President Alan Garber laid out a plan to maintain some research operations affected by the university's loss of more than \$2.6 billion in grants. Harvard has been fighting the government in court over the cuts.

Harvard's plan will redirect \$250 million as an initial stopgap for the coming year while officials explore

other options, Garber wrote. He called it a transition period for critical research programs, noting the Ivy League school "cannot absorb the entire cost of the suspended or canceled federal funds.

In light of the school's financial challenges, Garber will take a voluntary 25% pay cut during the upcoming fiscal year, a Harvard spokesperson said. Garber's current salary has not been made public, but Harvard presidents in the past have earned nore than \$1 million annually, the Harvard Crimson student newspaper

NATO weighs US demand to hike defense spending

ANTALYA, Turkey, May 15, (AP): NATO foreign ministers on Thursday debated an American demand to massively ramp up defense investment to 5% of gross domestic product over the next seven years, as the US focuses on security challenges outside of Europe.

At talks in Antalya, Turkey, NA Secretary-General Mark Rutte said that more investment and military equipment are needed to deal with the threat posed by Russia and terrorism, but also by China which has become the focus of US concern.

"When it comes to the core defense spending, we need to do much, much more," Rutte told reporters. He underlined that once the war in Ukraine is over, Russia could reconstitute its armed forces within three to five years.

Secretary of State Marco Rubio underlined that "the alliance is only as strong as its weakest link." He insisted that the US investment demand is about "spending money on the capabilities that are needed for the threats of the 21st century.

The debate on defense spending is heating up ahead of a summit of US President Donald Trump and his NATO counterparts in the Netherlands on June 24-25. It's a high-level gathering that will set the course for future

While the two figures add up to 5%, factoring in infrastructure and cybersecurity would change the basis on which NATO traditionally calculates defense spending. The seven-year time frame is also short by the alliance's usual standards.

Rutte refused to confirm the numbers under consideration, but he acknowledged that it's important to include infrastructure in the equation, "for example to make sure that bridges, yes, are there for you and me to drive our cars but also if necessary to make sure that the bridge will hold a tank. So all these expenditures have to be taken into account."

It's difficult to see how many members would reach a new 3.5% goal. Belgium, Canada, Croatia, Italy, Luxembourg, Montenegro, Portugal, Slovenia and Spain are not even spending 2% yet, although Spain does expect to reach that goal in 2025, a year past the

Ukraine's Zelenskyy arrives in Turkey for peace talks but Putin stays away

ANKARA, Turkey, May 15, (AP): Russian President Vladimir Putin didn't show up Thursday for proposed direct peace talks in Turkey with Ukrainian leader Volodymyr Zelenskyy, who was waiting for Putin in the capital Ankara after challenging him to face-to-face discussions on ending their countries' more than three-year

With Putin absent, the Russian delegation was in Istanbul and it wasn't clear whether the sides would meet for their first talks since March 2022, following Russia's full-scale invasion of its neighbor the previous month.

Zelenskyy said the Russian delegation appeared to be merely "decorative." Speaking at the airport in the Turkish capital, Ankara, he said the next steps for talks would be decided after his upcoming meeting with Turkish President Recep Tayyip Erdogan.

Putin's absence punctured hopes of

a breakthrough in peace efforts given a push in recent months by the Trump administration and Western European leaders. It also raised the prospect of intensified international sanctions on Russia that have been threatened by the US and European leaders.

"Now, after three years of immense suffering, there is finally a window of opportunity," Turkish Foreign Minister Hakan Fidan said at a NATO meeting taking place separately in Turkey. "The talks ... hopefully may open a new chapter."

The war of attrition has killed tens of thousands of soldiers and more than 12,000 Ukrainian civilians, according to the UN, and continues along the roughly 1,000-kilometer (620-mile) front line. Russian forces are also preparing to launch a fresh military offensive, Ukrainian government and West-

ern military analysts say. The Kremlin never gave a response to Sunday's challenge from Zelenskyy. That challenge came after Putin had proposed direct talks with Ukraine.

Żelenskyy will sit at the table only with Putin, Ukraine's presidential adviser, Mykhailo Podolyak, said.

US President Donald Trump said he was not surprised that Putin was a no-show. Trump had pressed for Putin and Zelenskyy to meet but brushed off Putin's apparent decision not to attend.

"I didn't think it was possible for Putin to go if I'm not there," Trump said in an exchange with reporters as he took part in a business roundtable with executives in Doha, Qatar on the third day of his visit to the Middle

Vladimir Medinsky, an aide to Putin, is leading the Russian team that will also include three other senior officials, the Kremlin said. Putin also appointed four lower-level officials as "experts" for the talks in Istanbul.

recover, British investigators said Thursday. Billionaire entrepreneur Lynch, 59, and his daughter Hannah, 18, were among the dead when the 56-meter (184 feet) Bayesian sank Aug. 19 last year. The boat trip was a celebra-

tion of Lynch's acquittal in a fraud case in the US in June. In an interim report on the disaster, Britain's Marine Accident Investigation Branch said the boat was "vulnerable" to winds that were even lighter than the ones that tipped it over. The report was based on "a limited amount of verified evidence" as a criminal investigation by Italian authorities has restricted its access to the wreck and other pieces of evidence, it said. (AP)

NZ's Parliament to debate suspending Maori lawmakers

WELLINGTON, New Zealand, May 15, (AP): A New Zealand parliamentary committee has recommended the unprecedented suspensions of three Maori law-makers for performing a protest haka in the debating chamber last year.

The haka is a chanting dance of challenge of great cultural importance in New Zealand, and the three lawmakers from Te Pati Maori, the Maori party, performed one to oppose a controversial bill that would have redefined the country's founding document

country's founding document.

A committee Wednesday recommended record suspensions and severe censure - the harshest penalties ever assigned to New Zealand parliamentarians - after finding the trio in contempt of Parliament.

Government bloc lawmakers, who hold the majority, are expected to endorse the penalties in a vote Tuesday. But Parliament's Speaker Gerry Brownlee took the unusual step Thursday of saying he would first allow unlimited debate before the vote due to the severity of the proposed punishments.

The recommendations were the latest twist in the fraught saga over the bill, now defeated, that opponents said would have provoked constitutional havoc and reversed decades of progress for Maori, New Zealand's Indig-

enous people.

"The process was grossly unjust, unfair, and unwarranted, resulting in an extreme sanction," Maori party spokesperson and lawmaker Mariameno Kapa-Kingi said in a statement. "This was not about process, this became personal."

Subianto praises Australia

Australian PM Albanese visits Indonesia seeking deeper economic, defense ties

JAKARTA, Indonesia, May 15, (AP): Australia's newly reelected Prime Minister Anthony Albanese met with Indonesian President Prabowo Subianto on Thursday in a visit aiming to strengthen his country's economic and defense ties with its closest major neighbor.

Albanese arrived in the capital, Jakarta, on Wednesday evening, a day after his new government was sworn in to a second three-year term following an emphatic election victory May 3.

"I am here in Indonesia because no relationship is more important to Australia than this one," Albanese said in a joint press statement with Indonesian President Prabowo Subianto after a meeting,

Albanese did not comment on media reports that Russia had told Indonesia it wants to base its long-range warplanes in Papua, the most eastern Indonesian province, a plan that was raised as a security issue during the Australian election campaign. Indonesia has told Australia that no such Russian base would be allowed.

"This is the fastest growing region of the world in human history and Indonesia is central to that growth," Albanese said, adding that Indonesia is projected to be the fifth largest economy by the end of the next decade.

Subianto praised Australia's support for Indonesia to become member of The

Organization for Economic Cooperation and Development and the Comprehensive and Progressive Agreement for Trans-Pacific Partnership.

Newly elected Australian prime ministers typically make their first bilateral

visit to Asia, usually Indonesia.

In his first visit to Indonesia after his inauguration in 2022, Albanese also visited Makassar, the capital of South Sulawesi province with close ties to Indigenous

Australians.

Given their geographical proximity, Indonesia and Australia have traditionally maintained close ties with each other, including in matters of security and defense, despite the fact that each country has chosen to respond differently to the rivalry

between the U.S. and China in the region.

The two neighbors last year signed a historic Defense Cooperation Agreement, or DCA, that will allow more complex joint activities and exercises. Canberra hailed the agreement as the "deepest and most significant" defense deal in the two

countries' bilateral ties.

"This is how we can build our shared prosperity and advance our national and regional security," Albanese said, "This treaty-level agreement, underpinned by



Statues and monuments to the 18th century naval officer are common in Aus-

tralia and are often defaced by opponents of Britain's settlement of the country without a treaty with its Indigenous people. In 1770, then Lt. Cook charted the Australian east coast where Sydney would become the first British colony on the continent

The granite and bronze monument to the master navigator and cartographer in an inner-city Melbourne park was vandalized days after the anniversary of the first British settlers' arrival at Sydney Cove was commemorated on Jan. 26. Opponents of Australia Day celebrations denounce the public holiday as "Invasion Day." There are growing calls for the country to find a less divisive national day.

The monument in Melbourne's Edinburgh Gardens was snapped at its base and spray painted with the words "cook the colony."

Mayor Stephen Jolly, head of the Yarra City Council, which is a municipality

Mayor Stephen Jolly, head of the Yarra City Council, which is a municipality near the heart of Melbourne, said his fellow councilors had voted unanimously on Tuesday night against spending 15,000 Australian dollars (\$9,700) on repairing the monument, which remains in storage.

Jolly said the decision to permanently remove the monument, which included

an image of Cook's face cast in bronze, was about economics rather than taking a position in Australia's culture wars.

"It's about being economically rational. It's AU\$15,000 a pop every time we

have to repair it and it's persistently getting either demolished or vandalized or tagged," Jolly told Australian Broadcasting Corp.

"It's just a waste of ratepayers money. We can't afford to do that," Jolly added.

But Victoria state's Melbourne-based conservative opposition leader Brad Battin condemned removing such memorials as surrendering to vandals.

"We need to stand strong and remember the fact that this is part of our history,"

Battin told reporters.

"If you start to remove the history of our state and our country because of activists, then you're actually giving in to those that are campaigning against it," Battin

added.

Jolly disagreed that his council had given the vandals what they wanted.

"No, I think they would've loved for us to put it back up and then they could've

just tagged it again or destroyed it again and just had this ongoing sort of little war going on in Edinburgh Gardens," Jolly said.

Bid to reset strategic relationship

S.African leader, Trump to meet next week

CAPE TOWN, South Africa, May 15, (AP): US President Donald Trump and South African President Cyril Ramaphosa are scheduled to meet at the White House next week following allegations by Trump - and denied by South Africa - that "genocide" is being committed against white farmers in the majority Black country.

The meeting, announced Wednesday by the South African government and set for May 21, also comes after the US welcomed 59 white South Africans as refugees this Monday, the start of what the Trump administration said is a larger relocation plan for minority Afrikaner farmers who Trump has claimed are being persecuted in their homeland because of their race. South Africa denies the allegations and says whites in the majority Black country are not being singled out for persecution.

Ramaphosa's office said he will be in the US from Monday to Thursday of next week, and will meet with Trump on Wednesday at the White House. Ramaphosa's trip would aim to "reset the strategic relationship between the two countries," his office said.

The White House had no immediate comment on the meeting, which would be Trump's first with the leader of a nation in Africa since he returned to office in January.

Trump has criticized South Africa's Black-led government on multiple fronts and issued an executive order Feb. 7 cutting all US funding to the country as punishment for what he said were its anti-white policies at home

and anti-American foreign policy.

The Republican president has singled out South Africa over what the U.S. calls racist laws against whites and has accused the government of "fueling" violence against white farmers. The South African government says the relatively small number of killings of white farmers should be condemned but are part of the country's problems with violent crime and are not racially motivated.

Trump said Monday - the same day that the first batch of Afrikaner refugees arrived at Dulles International Airport in Virginia - that there was "a genocide taking place" against white

Dugm Refinery to boost capacity to 270,000 bpd within two years

KUWAIT CITY, May 15: In a bid to strengthen cooperation and partnership for the largest joint project between two Gulf states in the field of refineries and petrochemicals, the management of Duqm Refinery -owned by Kuwait Petroleum International (KPI) and the Omani OQ Oil Group -- intends to increase the refining capacity of Duqm from 255,000 to 270,000 barrels per day in the next two years, say Omani sources.

Sources disclosed that the management is considering increasing capacity without the need for investment or financing; given the strong demand for Duqm Refinery products as its products are clean and high-quality like diesel, jet fuel, naphtha, liquefied petroleum gas, sulfur and petroleum

They said the Kuwaiti employees at the refinery have proven their competence and dedication to their work. "To fulfill the demand to attract more Kuwaiti employees, the management recently opened recruitment opportunities for fresh Kuwaiti graduates in the fields of Chemical Engineering, Mechanical Engineering, Chemistry, Accounting, Finance, Human Resources Management, Business Administration and Computer Engineering," sources confirmed.

Sources said the requirements for Kuwaiti job applicants are as follows: ■ Must not be registered with the Public Institution for Social Security (PIFSS) as an employer;

■ Copies of the civil identification nationality cards;

■ Certificate of military service, postponement or exemption for males;

Age must not exceed 28 years;

■ Not more than four years must have passed since graduation.

Sources stressed that applicants, who do not meet the conditions, will be excluded; adding that in case of the same results between more than one candidate for the job, the criteria for comparison will be oldest age, first to obtain the qualification, and a married person is preferred over the single person, provided they meet the required general graduation average, and pass the English language test and aptitude test. NBK publishes first green bond allocation & impact report

KUWAIT CITY, May 15: In line with its leading and responsible role in the banking industry, National Bank of Kuwait continues to advance confidently towards building a sustainable future by implementing its environmental, social and institutional governance strategy and launching initiatives as per international standards and practices.

In light of this, NBK published its first allocation and impact report for its debut USD 500 green bond issued in June 2024, which is the first issuance of its kind in Kuwait. The report provides relevant information that details the proceeds' allocation from the green bond as of 31 March 2025and the estimated environmental impact during the reporting period.

The report highlights the value of NBK's eligible green assets portfolio, which reached USD 625 million as of 31 March 2025, exceeding the value of its USD 500 million debut green bonds. The Bank's eligible green assets portfolio is distributed amongthree categories: 76% for green buildings, 17% for renewable energy, and 7% for

clean transportation.

Moreover, NBK's first green bond strongly supported the United Nations Sustainable Development Goals (UN SDGs), particularly goal 7 on guaranteeing that clean and affordable energy is accessible to all, and goal 11 on making cities inclusive, safe, resilient, and sustainable. The Bank's first green issuance also promotes its ESG strategy and affirms its support to projects that protect the environment and reduce climate change impact.

Asian shares mostly lower after a mixed session on Wall Street

BANGKOK, May 15, (AP): Asian shares and U.S. futures slipped Thursday after U.S. stocks drifted to a mixed close on Wall Street.

Oil prices fell more than \$1 a barrel.

China moved to reverse some of its "non-tariff" measures against the U.S. as agreed with Washington in their temporary trade war cease-fire and most mar-

kets traded in a narrow range.

Japan's Nikkei 225 index dropped 1.1%, however, to 37,705.74. Computer chip-related stocks were among the biggest decliners, with Disco Corp. falling 2.6% and Advantest down 1.8%.

Hong Kong's Hang Seng was the outlier, picking up 0.2% to 23,691.67. The Shanghai Composite index lost 0.3% to 3,393.29, while Taiwan's Taiex fell

In Australia, the S&P/ASX 200 was nearly unchanged at 8,278.30. South Korea's Kospi edged 0.1% lower.

On Wednesday, a choppy day of trading on Wall Street ended with a mixed finish as gains by several big technology stocks helped temper losses.

The S&P 500 edged up 0.1% to 5,892.58 and

the Dow Jones Industrial Average slipped 0.2% to 42,051.06. The Nasdaq composite rose 0.7% to

Super Micro Computer surged 15.7% after signing a partnership agreement with Saudi Arabian data center company DataVolt. Advanced Micro Devices gained 4.7% after announcing a \$6 billion stock buyback program.

Nvidia rose 4.2% and Google parent Alphabet added 3.7%

Other big gainers included eToro Group, a retail trading platform for stocks and cryptocurrency. It rose 28.8% in its first day of trading.

The U.S. will release its April report for inflation at the wholesale level on Thursday, and economists expect an easing of price pressures.

An update for retail sales is expected to reflect a sharp drop to 0.2% in April from 1.4% the previous

Retail giant Walmart will also report its latest financial results on Thursday and its financial forecasts will be closely watched.

The stock market has been relatively steady since

a 90-day pause in their trade war. The market gained more ground on Tuesday after the government reported that inflation unexpectedly cooled across the country in April. More updates on inflation and retail sales are expected on Thursday.

Trump has delayed a large swath of his most severe tariffs against America's trading partners, but some import taxes remain in place. Uncertainty over the path ahead continues to hang over businesses and consumers. The on-again-off-again nature of Trump's trade policy has left companies reluctant to make plans about investment and hiring and consumers nervous about spending.

Businesses continue to trim or withdraw their financial forecasts as they face unpredictable trade policy and cautious consumers.

American Eagle fell 6.4% after the retailer withdrew its financial outlook for the year citing "macro uncertainty." General Motors, UPS, Kraft Heinz and JetBlue are among the many companies representing a wide range of industries that have warned about the impact of tariffs and a weakening economy.

World Trade Organization chief says global free trade is in crisis

Ngozi on visit to Japan

TOKYO, May 15, (AP): Global free trade is in crisis, the head of the World Trade Organization chief said Tuesday while meeting Japanese Prime Minister Shigeru Ishiba on Tuesday.

Ngozi Okonjo-Iweala, Director-General of the World Trade Organization, told Ishiba that she has high expectations for Japan as a champion of open markets as U.S. President Donald Trump disrupts world commerce with his fastchanging tariffs and other policies.

"Trade is facing very challenging times right now and it is quite difficult," she said. "We should try to use this crisis as an opportunity to solve the challenges we have and take advantage of new trends in trade."

Japan, as "a champion of the mul-tilateral trading system" must help maintain, strengthen and reform the WTO, the Japanese Foreign Ministry cited her as saying.

Later Tuesday, the WTO chief

met with Japanese Foreign Minister Takeshi Iwaya and issued a joint statement, saying that "in a time of uncertainty and disruption, the value of the multilateral trading system is unquestionable." Japan said in the same statement the current trade turmoil "would have a significant impact on the global economy and the entire multilateral trading system" and called for promoting WTO reforms, including its rule-making function, dispute settlement and monitoring of the implementation of

agreements.

They met a day after the United States and China said they had agreed to slash recent sky- high tariffs for 90 days to allow time for negotiations.

Japan is among many countries yet to reach a deal with the Trump administration on hikes to U.S. tariffs, including those on autos, steel and aluminum.

The WTO played a pivotal role in past decades as the U.S. and other major economies championed the trade liberalization that facilitated

the growth of global supply chains, many of which are anchored in China. By dismantling many protectionist barriers to trade, it has aided the ascent of Japan and China, and many other countries, as export manufac-

turing hubs. Since taking office for a second time, Trump has prioritized higher tariffs to try to reduce U.S. imports and compel companies to locate factories in the United States, doubling down on a trade war that he launched during his first term.

Okonjo-Iweala and Ishiba agreed that WTO member countries should unite to restore the organization's capacity to address challenges.

The trade chief visited Japan to strengthen cooperation between the east Asian country and the WTO to maintain and reinforce the multilateral trading system, Japanese officials said.

She also met with Finance Minister Katsunobu Kato and Economy, Trade and Industry Minister Yoji

Longer-term deal eyed

Chinese businesses view tariff pause with caution, uncertainty

BANGKOK, May 15, (AP): While U.S. President Donald Trump has talked of victory after reaching a weekend deal with China to reduce the sky-high tariffs levied on each others' goods, businesses in China are reacting to the temporary deal with caution. The U.S. and China have cut the

tariffs levied on each other in April, with the U.S. cutting the 145% tax Trump imposed last month to 30%. China agreed to lower its tariff rate on U.S. goods to 10% from 125%. The lower tariff rates came into effect on Wednesday.

U.S. Treasury Secretary Scott Bessent, announcing the reduction in tariff rates this weekend in Geneva, had said, "We do want trade." While the markets have responded to the agreement with gusto, rebounding to the levels before Trump's tariffs, business owners remain wary.

Businesses like one kitchen utensil factory in southern Guangdong province were eager to get back to work. The business said they put at least four orders from their American clients back into production on Tuesday after the tariff pause was announced.

"We thought the negotiation would bring the tariffs down a bit, but didn't expect it would be so much," said Margaret Zhuang, a salesperson for the utensil factory in Guangdong province, one of China's manufacturing hubs.

The two countries are now planning to start negotiations for a longer-term deal.

Kahlee Yu, sales manager of Yangjiang Hongnan Industry and Trade Company, which also manufactures kitchen utensils, said he was reaching out to American customers again. "We're a little bit optimistic about the trade deal between the two sides. But it is still possible the tariff policies will change again, resulting in no orders from our

American clients," he said. However happy they were in the moment, the damage from tariffs announced in April has already been done, Zhuang added, as they are seeing fewer orders. Currently, she has orders for products up until June. Earlier this year, before Trump's trade war began, they had orders for production extending to August.

The uncertainty also means companies are less willing to make new investments. Kelvin Liao, sales director at Action Composites, a manufacturer of carbon fiber auto parts in Dongguan, a major city in Guangdong, said he was originally planning to buy a piece of land to build a new factory, but opted instead to rent because of the tariff situation.

"It is good to reach a trade deal between the two countries. But people have already lost confidence in Trump, and we will take a wait-and-see attitude," he said. "We believe the signing a trade deal is just a pause and the ultimate goal of the US is to curb China's development.'

Tariffs also remain in place for some industries, which are not part of the general deal. Hong Kong businessman Danny Lau, who owns an aluminumcoating factory, said his company still faces about a 75% tariff from tariffs levied at different points since 2018 by the U.S. Still he welcomed the news from the weekend, saying he would reach out to existing American customers to gauge their views.

"Although the policy change doesn't cover our industry, we hope talks will continue and there will be better news during the 90-day pause," he said.

In April, some Chinese businesses said they would focus their attention on exporting to other markets, given how high the American tariffs were. Analysts said previously that the tariffs could cause Chinese businesses to diversify their supply chains and move part of their manufacturing capacity abroad, including to the U.S.

Liao, the auto parts manufacturer, said his company already has a factory in Vietnam, and the products there were exported to the U.S.

Microsoft lays off about 3% of its workforce

WASHINGTON, May 15, (AP): Microsoft began laying off about 6,000 workers Tuesday, nearly 3% of its entire workforce and its largest job cuts in more than two years as the company spends heavily on artificial intelligence.

Hard hit was the tech giant's home

state of Washington, where Microsoft informed state officials it was cutting 1,985 workers tied to its Redmond headquarters, many of them in software engineering and product manage-Microsoft said the layoffs will be

across all levels, teams and geographies but the cuts will focus on reducing the number of managers. Notices to employees began going out on The mass layoffs come just weeks

after Microsoft reported strong sales and profits that beat Wall Street expectations for the January-March quarter, which investors took as a dose of relief during a turbulent time for the tech sector and U.S. economy.

"I think many people have this conception of layoffs as something that struggling companies have to do to save themselves, which is one reason for layoffs but it's not the only reason," said Daniel Zhao, lead economist at workplace reviews site Glassdoor. "Big tech companies have trimmed their workforces as they rearrange their strategies and pull back from the more aggressive hiring that they did during the early post-pandemic years.'

Microsoft employed 228,000 fulltime workers as of last June, the last time it reported its annual headcount. About 55% of those workers were in

Microsoft announced a smaller round

of performance-based layoffs in January. But the 3% cuts will be Microsoft's biggest since early 2023, when the company cut 10,000 workers, almost 5% of its workforce, joining other tech companies that were scaling back their pandemic-era expansions.

Microsoft's chief financial officer, Amy Hood, said on an April earnings call that the company was focused on "building high-performing teams and increasing our agility by reducing layers with fewer managers." She also said the headcount in March was 2% higher than a year earlier, and down slightly compared to the end of last year.

The layoffs are hitting all parts of Microsoft's business, including the video game platform Xbox and the career networking site LinkedIn. Some laid-off workers and the executives who made the cuts took to LinkedIn to talk about them.

"This is the first time I've had to lay people off to support business goals that aren't my own," wrote Scott Hanselman, a vice president of Microsoft's developer community. "I often have trouble separating my beliefs with the system that I participate in and am complicit in. These are people with dreams and rent and I love them and I want them to be OK.

He added: "This is a day with a lot

The company didn't give a specific reason for the layoffs, only that they were part of "organizational changes necessary to best position the company for success in a dynamic marketplace.

Chair of Tesla sold stock worth \$230m while profits at carmaker plunged

NEW YORK, May 15, (AP): The chair of Tesla sold more than \$230 million of company stock since Elon Musk's endorsement of Donald Trump triggered boycotts and protests against his cars, sending its profits and stock price

More than half of Robyn Denholm's cash haul came from sales in the first four months this year as Tesla stock fell by one-third, according to filings reviewed by The Associated Press. In total, she unloaded hundreds of thousands of shares - more than half her holdings as dictated by a pre-arranged selling plan filed with regulators as Musk began embracing right-wing

Denholm filed that plan on July 25, the day Musk endorsed Trump for president.

Denholm's profits were likely outsized, too. That is because many of the shares she sold had been acquired through so-called options granted to her by Tesla years earlier that, given recent stock prices, allowed her to buy at a deep discount, according to data from research provider FactSet. Nearly a million shares acquired through options were bought for \$25, less than a tenth of the market price for much of

the last nine months. The AP reached out to both Tesla and Denholm but did not receive an immediate reply.

A Denholm statement to The New York Times, which earlier reported on the insider sales, said that the share value of holdings by Tesla directors

has jumped because the stock itself has soared, creating "outsized returns" for all shareholders.

It's not clear why Denholm decided to cash out so much of her stake.

Pre-determined selling schedules are used by executives and directors as a way of telling investors that their selling isn't based on insider information, which is illegal, or necessarily a sign that they have turned pessimistic about a company.

Denholm isn't the only Tesla insider who has been selling. The chief financial officer and other directors have unloaded \$189 million in stock in the same nine-month period, according to

Tesla stock soared after Trump was elected in November on hopes that the president-elect's close relations with Musk would translate to less regulatory scrutiny and bigger profits.

But Musk's role as the government cost-cutting chief for Trump and his comments supporting extreme rightwing politicians in Europe have triggered a backlash among car buyers, and sales have sunk along with its stock.

Tesla reported last month that profits in the first three months of the year plunged 71%.

UK becomes fastest-growing economy after strong first quarter

LONDON, May 15, (AP): The British economy grew at its fastest rate in a year during the first quarter of 2025, official figures showed Thursday, in a welcome boost to the Labour government, which has made lifting the country's growth its

The Office for National Statistics said growth, as measured by gross domestic product, increased by 0.7% in the first quarter of the year from the final three months of 2024, with the country's dominant services sector doing particu-

The first quarter increase makes the British economy the fastest-growing among the Group of Seven leading industrial nations.

Growth was modestly ahead of market expectations for a 0.6% increase. It was also the biggest increase since the first quarter of 2024, when the economy expanded by 0.9%.

Treasury chief Rachel Reeves welcomed the growth leap, and said the figures showed the choices made by Labour since it was elected last July were beginning to pay off.

"We're set to be the fastest growing economy in the G-7 in

the first three months of this year and that's incredibly welcome, but I know that there is more to do," she said while on a visit to a Rolls-Royce factory in Derby, northern England.

Most economists think is likely to slow down in the second quarter of the year, partly because of the global uncertainty generated by U.S. President Donald Trump's tariff policies.

Though most tariffs were paused for 90 days following the ensuing market turmoil, including the 10% baseline tariff applied to U.K. goods entering the U.S., the backdrop for the global economy remains highly uncertain, particularly if the

U.S.-China trade war persists.

Some of that uncertainty, with regard to the British economy, lifted Thursday when both Trump and British Prime Minister Keir Starmer separately outlined details of a trade deal between the U.S. and the U.K. Though Trump kept the 10% baseline tariffs on U.K., he agreed to reduce the levies on British autos, steel and aluminum.

Sanjay Raja, chief U.K. economist at Deutsche Bank, said the growth uptick will likely be short-lived, especially during the second quarter when trade uncertainty will be at its peak.



Festival kicks off with a fierce race for the Palme d'Or

Cannes has already delivered drama - here's what's next

CANNES, France, May 15, (AP): This year's Cannes Film Festival has barely started, but it's already been an attention-grabbing affair, from new rules for its red carpets, nerves about potential US tariffs and the return of Tom Cruise.

And that says nothing about the films, expected to be a strong slate as Cannes is seen as increasingly important to the Oscars' best picture hopefuls.

Even in a normal year, Cannes is a lot to keep up with. Here's a handy guide of what's happened so far, what to expect and what it may mean.

Cannes opened Tuesday with a starry tribute to Robert De Niro, 49 years after "Taxi Driver" won the festival's top prize, the Palme d'Or. De Niro used the platform to assail US President Donald Trump, a frequent target of his criticism

He also basked in the adoration of some of film's

elite, including Leonardo DiCaprio and Quentin Tar-

Cannes debuted a complex 4K restoration of "The Gold Rush," one of Charlie Chaplin's most beloved silent masterpieces, timed to the film's 100th anniversary. "Our grandfather would be really proud to see this, a hundred years later, to see all you here and interested in seeing the film," said Kiera Chaplin to a packed screening Tuesday.

Tom Cruise took the spotlight on Day 2 with the test "Mission: Impossible" installment, "Final

For such a high-flying franchise, Cruise kept his feet on the ground (so far) ahead of the film's pre-

AP Film Writer Jake Coyle broke down some of the key things about the festival in a thorough primer. Among the things to watch out for: any effects of Trump's talk about tariffs on foreign-made films at the world's largest film market. The festival serves as the start of Oscar season and there's a packed field vying for this year's Palme d'Or.

Outside of competition, there's some starry first-time directors: Scarlett Johansson with "Eleanor the Great," Kristen Stewart with "The Chronology of Water" and Harris Dickinson with "Urchin."

Their films are not in the main competition, but as Brazilian director Kleber Mendonça Filho told Coyle about debuting a film at Cannes: "You release a film into that Colosseum-like situation." He noted premiering a movie at the festival is akin to "a potential invitation to a beheading."

One of the buzziest moves by Cannes this year so far has been its proclamation that nudity is banned by

festivalgoers and so too are "voluminous" outfits, in particular those with a large train.

The move to ban nude looks comes amid the "naked dress" trend on red carpets, including Bianca Censori's Grammys look and many of the outfits worn by Vanity Fair party attendees after the Oscars.

Cannes press officers said earlier this week the festival "made explicit in its charter certain rules that have long been in effect."

So how did stars at Cannes respond?

Halle Berry, who is on the festival jury headed by Juliette Binoche, told reporters she would abide by it and had changed her opening night look.

While risque looks were in short supply Monday, there were certainly some "voluminous outfits," including dresses worn by Heidi Klum, Chinese actor Wan OianHui and others.

Abuse claims

Cassie testifies against Combs

NEW YORK, May 15, (AP): The R&B singer Cassie testified Wednesday that Sean "Diddy" Combs physically abused her when she ended their decade-long relationship, after he threatened to release degrading videos of her.

Addressing the Manhattan courtroom for a second day in Combs' federal sex trafficking trial, Cassie said Combs forced his way into her Los Angeles apartment and raped her on the living room floor after she said she was breaking up with him.



Cassie also said she didn't feel could refuse demands Combs' for her to have 'hundreds" of encounters with male workers - which he watched and controlled for hours and even days because he would make her "look

like a ..." if he made the videos public. "I feared for my career. I feared for my family. It's just embarrassing. It's horrible and disgusting. No one should do that to anyone," said Cassie, whose legal name is Casandra Ventura.

Prosecutors showed the jury five still images from videos on Wednesday. Cassie said the images depicted her at various stages of what Combs referred to as "freak-offs." One juror's eyes widened, and another shook his head from side to side. She sued Combs in 2023, accusing him of years of physical abuse. Within hours, the suit was settled for \$20 million — a figure Cassie disclosed for the first time Wednesday-but dozens of similar legal claims followed from other

Accuse

Prosecutors accuse Combs of exploiting his status as a powerful music executive to violently force Cassie and other women to take part in sexual encounters. He is charged with crimes including racketeering and trafficking by force, fraud or coercion. Several other accusers are set to testify.

Combs denies all of the allegations. His attorneys acknowledge he could be aggressive at times but maintain that his actions were consensual and do not constitute a criminal enterprise.


Combs' lawyers were expected to begin cross-examining Cassie on Thursday, when they will get the chance to challenge her credibility or poke holes in her account of what happened.

Combs, 55, has been jailed since September. He faces at least 15 years in prison if convicted. The trial is expected to last about two months.

Cassie's testimony is exposing the dark underside of a relationship that, for years, played out publicly in pictures of the couple smiling on red carpets and celebrity events. She said she met Combs in 2005, when she was 19 and he was 37. Combs signed her to a 10year contract with his Bad Boy Records label. Within a few years, they started dating, Cassie said.

They were photographed in 2016 attending the premiere of the film "The Perfect Match," only two days after Combs beat and kicked Cassie at a Los Angeles hotel - an attack captured on security camera footage. After the footage was leaked last year, Combs apologized. Jurors were shown that footage as well as photos of the couple at the premier.

Cannes crowds go wild for Cruise, his 'Mission'

CANNES, France, May 15, (AP): Three years after flying into the Cannes Film Festival with "Top Gun: Maverick," Tom Cruise again kicked up a storm on the Croisette with Wednesday's premiere of "Mission: Impossible - Final Reckoning. Christopher McQuarrie's latest "Mission: Impossible" in-

stallment was the biggest Hollywood tentpole wading ashore in Cannes this year. It, and Cruise, stirred a frenzy at the French Riviera festival, which again played eager host to the American Just his arrival outside the premiere, beamed onto the screen

in the Grand Théâtre Lumière, drew a response. When Cruise stepped out his car, oohs and applause reverberated through the theater. Cruise spent several minutes signing autographs for fans lined up on the Croisette. Some had wondered whether Cruise might make a more dar-

ing arrival. When Cruise received an honorary Palme d'Or from the festival in 2022, the "Top Gun: Maverick" premiere included an impressively timed jet flyover. Instead, on Day 2 of the festival, he and the film's cast walked the red carpet accompanied by an orchestra performing Lalo Schifrin's "Mission: Impossible theme on the Palais steps. "Bravo!" cheered Cruise.

Though selfies are frowned upon on the Cannes red carpet, McQuarrie took several of the group, which included Hayley Atwell, Simon Pegg, Angela Bassett and Hannah Waddingham.

"Final Reckoning," the eighth "Mission: Impossible" movie and a follow-up to 2023's "Mission: Impossible - Dead Reckoning Part One," is again a heaping serving of outlandish stunts in a globe-trotting, world-saving plot that greatly relies on Cruise's sheer force of will to propel it.

The film, which draws to a close McQuarrie's extended AI apocalypse tale, drew mostly good reviews following its screening and garnered a five-minute standing ovation.

"To be here in Cannes and have these moments, as a kid when we were growing up, I really can't even dream about something like this happening," Cruise said, addressing the audience. "I'm very grateful for 30 years to be able to entertain you with this

Throughout much of the "Mission: Impossible" parade in Cannes, Cruise and McQuarrie lavished praise upon one another. Cruise told McQuarrie, who took over directing the franchise with 2015's "Rogue Nation" that he looked forward to making

"a bunch of other kind of movies with you." "When I was a kid growing up, I was one of those kids who didn't quite fit in. A lot of my life was imaginative play," said McQuarrie. "And I got to grow up and have my very own action figure, who was actually willing to do just about every crazy thing I could think of.'

Earlier in the day, Cruise joined McQuarrie midway through the director's masterclass talk. There was no press conference for the film, which meant Cruise and company faced no questions from reporters. But Cruise's surprise appearance allowed the 62-year-old star a moment to reflect on his 30 years with "Mission: Impossible." As to whether "Final Reckoning" is a last hurrah for him, he demurred, calling it "the culmination of three decades of work.

"I'd rather just people see it and enjoy," Cruise said.

Cruise, to no one's surprise, said he relishes the stunt work in "Mission: Impossible."

"I don't mind encountering the unknown. I like the feeling. It's just an emotion for me. It's something that is not paralyzing Cruise said.

Cruise, McQuarrie and Paramount Pictures, which will release "Final Reckoning" in North American theaters on May 23, are hoping the installment returns the franchise to boxoffice heights.

Diabetes research focuses on prevention and treatment solutions

Diabetes rate in Kuwait expected to reach 30 pct by 2050

KUWAIT CITY, May 15: The Swiss Embassy in Kuwait, in cooperation with the Kuwaiti-Swiss Business Platform, organized a scientific conference entitled "Diabetes Research: An International Partnership" at the residence of Swiss Ambassador Tiziano Balmelli.

A group of experts and researchers from Switzerland and Kuwait attended the conference to discuss developments in diabetes research and strengthen scientific cooperation to curb its spread.

During the conference, Dr. Abdullah Al-Kandari revealed that the percentage of people with diabetes in Kuwait has reached 20 percent and is expected to reach 30 percent by 2050 -- up from only seven percent in the 1990s.

He warned about the accelerating spread of the disease, especially among those over the age of 60, as about two-thirds of this age group is affected. He attributed the increase to unhealthy lifestyle; including inactivity, poor diet and smoking. He stressed the need to adopt effective prevention methods like regular exercise and a healthy diet. He also recommended that everyone aged 40 or 45 should undergo annual test for glycated hemoglobin (HbA1c) or fasting blood sugar.

Regarding treatment methods, Al-Kandari stated that traditional medicine has been proven effective; but he was quick to underscore the need to follow doctors' recommendations and prescribed medications, rather than relying on alternative medicine as the primary option.

Medical Director of Dasman Diabetes Institute Dr. Ebaa Ozeri gave a presentation on the institute's ongoing research projects, affirming the fruitful collaboration with Kuwaiti Danish Dairy Company (KDD).

Executive Manager of Research and Innovation at KDD Wolfram Alderson shed light on the efforts of the company to develop nutritional products that support diabetes control in collaboration with the institute.

Professor Pedro Marques-Vidal announced a collaborative project between the University of Lausanne in Switzerland and the institute to study genetic factors and their impact on the effectiveness of treatments. He is hoping that this collaboration will expand to include other medical fields.

Balmelli expressed his satisfaction with the level of the existing cooperation. "We are not just promoting improved management of diabetes; but also the effective bilateral cooperation between research institutions in both countries, such as Dasman Diabetes Institute,

KISR and University of Lausanne," he added. He then emphasized the importance of building lasting institutional partnerships that contribute to providing innovative scientific solutions to common health

Study warns on food labels

Calorie counts don't lead to healthier food choices

nowing the calorie content of foods does not help people understand which foods are healthier, according to a study I recently co-authored in the Journal of Retailing. When study participants considered calorie information, they rated unhealthy food as less unhealthy and healthy food as less healthy. They were also less sure in their judg-

In other words, calorie labeling didn't help participants judge foods

more accurately. It made them second-guess themselves.

Across nine experiments with over 2,000 participants, my colleague and I tested how people use calorie information to evaluate food. For example, participants viewed food items that are generally deemed healthier, such as a salad, or ones that tend to be less healthy, such as a cheeseburger, and were asked to rate how healthy each item was. When people did not consider calorie information, participants correctly saw a big gap between the healthy and unhealthy foods. But when they considered calorie information, those judgments became more moderate.

In another experiment in the study, we found that asking people to estimate the calorie content of food items reduced self-reported confidence in their ability to judge how healthy those foods were – and that drop in confidence is what led them to rate these food items more moderately. We observed this effect for calories but not for other nutrition metrics such as fat or carbohydrates, which consumers tend to view as

This pattern repeated across our experiments. Instead of helping people sharpen their evaluations, calorie information seemed to create what researchers call metacognitive uncertainty, or a feeling of "I thought I understood this, but now I'm not so sure." When people aren't confident in their understanding, they tend to avoid extreme

Information

Because people see calorie information so often, they believe they know how to use it effectively. But these findings suggest that the very familiarity of calorie counts can backfire, creating a false sense of understanding that leads to more confusion, not less. My co-author and I call this the illusion of calorie fluency. When people are asked to judge how healthy a food item is based on calorie data, that confidence quickly unravels and their healthiness judgments become less accurate.

These findings have important implications for public health and for the businesses that are investing in calorie transparency. Public health policies assume that providing calorie information will drive more informed choices. But our research suggests that visibility isn't enough and that calorie information alone may not help. In some cases, it might even lead people to make less healthy choices.

This does not mean that calorie information should be removed. Rather, it needs to be supported with more context and clarity. One possible approach is pairing calorie numbers with decision aids such as a traffic light indicator or an overall nutrition score, which both exist in some European countries. Alternatively, calorie information about an item could be accompanied by clear reference points explaining how much of a person's recommended daily calories it contains - though this may be challenging because of how widely daily calorie needs vary.

Our study highlights a broader issue in health communication: Just because information is available doesn't mean it's useful. Realizing that calorie information can seem easier to understand than it actually is can help consumers make more informed, confident decisions about

In our studies, we found that calorie information is especially prone to creating an illusion of understanding. But key questions remain.

For example, researchers don't yet know how this illusion interacts with the growing use of health and wellness apps, personalized nutrition tools or AI-based food recommendations. Future research could look at whether these tools actually help people feel more sure of their choices - or just make them feel confident without truly understanding the information. (AP)

Chronic heart blockages discussed in workshop

Kuwait hospital treats complex heart blockages with advanced techniques

KUWAIT CITY, May 15: The Cardiology Unit at Mubarak Al-Kabeer Hospital successfully dealt with seven complex cases to open calcified and chronically blocked coronary arteries during a workshop on such cases recently.

Doctors from the unit attended the workshop; which it organized in coordination with Consultant Cardiologist and Coronary Artery Diseases and Complex and Chronic Catheterization Procedures in the Kingdom of Bahrain Dr. Hussam Nour. This is under the supervision of Head of the Cardiology Unit at the hospital Professor Dr. Mohammed

Dr. Fahad Al-Hajri, Cardiologist and Therapeutic Catheterization Consultant at the hospital, stated that this type of operation requires the use of advanced techniques and specialized equipment -- different from conventional blockages. He pointed out that chronic non-communicable diseases; such as diabetes, high blood pressure, high cholesterol and

smoking are among the causes of arterial blockages. He said chronic blockages require drug treatment; and if the patient does not respond and the blockage persists, the doctor is forced to perform a catheterization procedure to try to open the artery

Dr. Abdullah Ismail -- Internal Medicine, Cardiology and Interventional Cardiac Catheterization Consultant at the hospital -- praised the participation of Dr. Nour from Bahrain. He affirmed the importance of the visit for exchanging experiences and participating in difficult operations.

He said the hosting of the workshop reflects the efforts of the hospital's Cardiology Unit to develop the skills of the Cardiac Catheterization Team and to review global developments related to this field.

Cardiology Consultant Dr. Ali Al-Sulaimi confirmed the high incidence of chronic calcified blockages in Kuwait and in other Gulf states; indicating that they constitute about 25 percent of all arterial patients due to the high incidence of chronic diseases like high blood pressure, diabetes, obesity and kidney failure.

Largest one-year decline ever seen

US overdose deaths fell 27% last year

NEW YORK, May 15, (AP): There were 30,000 fewer US drug overdose deaths in 2024 than the year before - the largest one-year decline ever re-

An estimated 80,000 people died from overdoses last year, according to provisional Centers for Disease Control and Prevention data released Wednesday. That's down 27% from the 110,000 in 2023.

The CDC has been collecting comparable data for 45 years. The previous largest one-year drop was 4% in 2018, according to the agency's National Center for Health Statistics.

All but two states saw declines last year, with Nevada and South Dakota experiencing small increases. Some of the biggest drops were in Ohio, West Virginia and other states that have been hard-hit in the nation's decades-long


Experts say more research needs to be done to understand what drove the reduction, but they mention several possible factors. Among the most

- cited: ■ Increased availability of the over-
- **Expanded addiction treatment.** ■ Shifts in how people use drugs.

dose-reversing drug naloxone.

- The growing impact of billions of dollars in opioid lawsuit settlement
- money. ■ The number of at-risk Americans is shrinking, after waves of deaths in older adults and a shift in teens and younger adults away from the drugs that cause most deaths.

Still, annual overdose deaths are higher than they were before the COV-ID-19 pandemic. In a statement, the

CDC noted that overdoses are still the leading cause of death for people 18-44 years old, "underscoring the need for ongoing efforts to maintain this progress." Some experts worry that the recent decline could be slowed or stopped by reductions in federal funding and the public health workforce, or a shift away from the strategies that seem to be working.

"Now is not the time to take the foot off the gas pedal," said Dr. Daniel Ciccarone, a drug policy expert at the University of California, San Francisco.

The provisional numbers are estimates of everyone who died of overdoses in the U.S., including noncitizens. That data is still being processed, and the final numbers can sometimes differ a bit. But it's clear that there was a huge drop last year.

Experts note that there have been past moments when U.S. overdose deaths seemed to have plateaued or even started to go down, only to rise again. That happened in 2018.

Naloxone has become more widely available, in part because of the introduction of over-the-counter versions that don't require prescriptions.

Meanwhile, drug manufacturers, distributors, pharmacy chains and other businesses have settled lawsuits with state and local governments over the painkillers that were a main driver of overdose deaths in the past. The deals over the last decade or so have promised about \$50 billion over time. with most of it required to be used to fight addiction

11 states hit

1,000 measles cases in the US

NEW YORK, May 15, (AP): Kansas logged eight more cases of measles in a week, as state health officials try to tamp down an multi-county outbreak that is linked to the large one in the Southwest.

The US surpassed 1,000 measles cases Friday, and Texas still accounts for the vast majority of cases in an outbreak that also spread measles to New Mexico, Oklahoma and Kansas.

Two unvaccinated elementary school-aged children died from measles-related illnesses in the epicenter in West Texas, and an adult in New Mexico who was not vaccinated died of a measles-related illness.

Other states with active outbreaks - which the CDC defines as three or more related cases include Indiana, Michigan, Montana, North Dakota, Ohio, Pennsylvania and Tennessee.

Outbreaks

North America has three other ongoing outbreaks. One outbreak in Ontario, Canada, has resulted in 1,440 cases from mid-October through May 6 up 197 cases in the last reported week. Alberta, Canada, also has a growing outbreak that has sickened almost 400 as of May 14. And the Mexican state of Chihuahua had 1,194 measles cases and one death as of Wednesday, according to data from the state health ministry.

Measles is caused by a highly contagious virus that's airborne and spreads easily when an infected person breathes, sneezes or coughs. It is preventable through vaccines, and has been considered eliminated from the U.S. since 2000.

As the virus takes hold in U.S. communities with low vaccination rates, health experts fear that spread could stretch on for a year. Here's what else you need to know about measles in the US.

There are a total of 717 cases across 32 counties, most of them in West Texas, state health officials said Tuesday. The state confirmed only eight more cases since its update Friday. The state also added one hospitalization to its count, for a total of 93 throughout the outbreak.

State health officials estimated about 1% of cases fewer than 10 - are actively infectious. Fifty-seven percent of Texas' cases are in Gaines County, population 22,892, where the virus started spreading in a close-knit, undervaccinated Mennonite community.

Dortmund, Frankfurt, Freiburg in Champions League shootout

DUESSELDORF, Germany, May 15, (AP): The final day of the Bundesliga season brings a Champions League shootout as Borussia Dortmund, Eintracht Frankfurt, and Freiburg battle it out for the last two qualifying spots for Europe's biggest club competition.

Bayern Munich secured the title two weeks ago, and its players were pictured partying on the Spanish island of Ibiza following the trophy presentation at last week's home game. Bayern may look at resting players bound for the Nations League and Club World Cup in the coming weeks. Bayer Leverkusen will finish second, no matter what happens in coach Xabi Alonso's

All of Saturday's nine games kick off at the same time on a hectic final

Dortmund hosts already-relegated Holstein Kiel and a win will almost certainly be enough for it to qualify for the Champions League. That would complete a remarkable comeback for a team which was 11th in mid-March.

Fourth-place Freiburg hosts thirdplace Frankfurt with a Champions League spot on the line. Freiburg will qualify for the first time ever with a win, while Frankfurt is safe with a win or a draw. Both qualify if Dortmund can't beat Kiel.

Alonso's Leverkusen was beaten by Dortmund in his last home game, but visiting Mainz offers the chance to sign off with a win.

After his emotional farewell to Bayern's fans at home last week, Thomas Müller can mark his 503rd - and possibly last - Bundesliga game at Hoffenheim. The experienced forward is leaving Bayern when his contract expires following the Club World Cup in the United States in June and July.

If Dortmund can qualify for the Champions League again, it will have striker Serhou Guirassy to thank. He's scored 20 Bundesliga goals this season and five in the last four games.

Ritsu Doan is the closest Freiburg has to a star in a team of hard-working, experienced players. His nine goals are the most of any Freiburg player in the league this season, and the Japanese winger has eight assists too.

Stuttgart's midfielder Angelo Stiller is out of Saturday's game against Leipzig with an ankle ligament injury. The club hopes he can return for next week's German Cup final.

Eric Dier is bidding farewell to Bayern after the England defender signed for Monaco on Wednesday. Forward Leroy Sané has just weeks left on his Bayern contract, though reports in German media indicate the forward may yet sign an extension.

Boxing great to fight Barrios

Pacman returning to the ring after losing senatorial race

MANILA, Philippines, May 15, (AP): Boxing great Manny Pacquiao is coming out of retirement to fight Mario Barrios for the WBC welterweight crown in July.

Pacquiao's team made the announcement on Thursday, just hours after he conceded defeat in a bid for another seat in the Philippines Senate.

"His comeback aligns with his scheduled induction into the International Boxing Hall of Fame in June, capping a storied sports legacy that continues to inspire millions of Filipino people," the press statement

It was not clear if the fight at a Las Vegas venue to be decided is a one-off or if 46-year-old Pacquiao is coming out of a four-year retirement to box full-time. Asked to clarify, his communications officer Joey Hernal said the media should wait for Pacquiao's own press conference. In the statement, Pacquiao promised to continue serving the country

despite losing in the mid-term elections. "I may not have won in my run for the Senate, but I am totally grateful for each vote, each prayer and support," Pacquaio said in Filipino.

He even thanked voters who did not choose him because "you were part of the process to strengthen our democracy.'

He said he remains committed to serve the country. "The fight continues. Service continues. For God. For the country. For each Filipino,"

Pacquiao previously served as a senator from 2016-22. He then made a bid for the presidency in 2022 elections but failed. In the mid-term elections on Monday, Pacquiao vied for a second stint in the Senate but finished 18th in voting when only the top 12 made it.

He joins the Canastota, New York-based Hall of Fame next month as one of the most decorated boxers in history.

A world champion in eight divisions from flyweight to super welterweight, he appeared to end a 26-year career in 2021 with a record of 62-8-2 (39 KOs).

Barrios retained the WBC welterweight belt with a draw against Abel Ramos last November in Arlington, Texas.

Haaland calls City season horrific as FA Cup final offers redemption

MANCHESTER, England, May 15, (AP): As "horrific" seasons go, Manchester City's could still end on a high note.

While English soccer's most dominant force for the past decade has been dispossessed of the Premier League crown, City's campaign could finish with the FA Cup and the title of world champion. City plays Crystal Palace in the

FA Cup final at Wembley on Saturday, looking for some shine on a season that spectacularly unraveled late last year. "This season has been tough,"

striker Erling Haaland told the BBC. "It is not nice to lose so many games, it is boring and not fun. That's why we need to finish well and get a trophy.
"We have the FA Cup final to

play for, and in a horrific season, we still managed to do this and that says it all.'

City's form has been so bad by its own remarkably high standards that Champions League qualification is still not certain with two rounds to go. But second place in the standings is still up for grabs, and the expanded Club World Cup kicks off in the United States next month and provides another opportunity for

major silverware

But the club that won six of the previous seven Premier League titles - including an unprecedented four in a row and the Champions League as part of a trophy treble in 2023 - is not in the mood to cel-

Manager Pep Guardiola said recently neither he nor his players deserve a bonus even if they win the Club World Cup, which has a prize pot of \$125 million for the champion. He also suggested no trophy would salvage the campaign after how his team surrendered the Pre-

mier League title, sitting 18 points adrift of champion Liverpool. City is in its third FA Cup final

in a row. It is Palace's third FA Cup final ever. It lost to Manchester United in the previous two- in 1990 and 2016.

So while the cup would be only a consolation prize for City, for Palace, it would mean everything as the London club's first major trophy. "Everybody needs to win this

final," Palace forward Ismaila Sarr said. "I'm working hard every day. I know it's not easy, but in my mind we're going to win this final. Yeah, Palace have never won this cup, but maybe this is the first time.'

The teams last played last month, when Palace led 2-0 at City but lost 5-2. Their previous match in December ended 2-2.

"They are a team that can cause problems, so we have to be prepared and focus on ourselves," City midfielder Mateo Kovacic said.

"At this club, you take it (success) for granted because we have been on top for so many years consistently. This season, although it's not been good, we can end it in a positive way, which could give us a big push for the Club World Cup.'

Bologna ends 51-year wait for major trophy

Milan beaten in Italian Cup final

ROME, May 15, (AP): Bologna ended a 51-year wait for a major trophy when it beat AC Milan 1-0 to win the Italian Cup.

Dan Ndoye returned from injury to score the only goal and help Bologna to its first Italian Cup since 1974. The club, which is owned by Canadian Joey Saputo, has only won two second-division titles in between.

It was also coach Vincenzo Italiano's first win in a final, having lost back-to-back Europa Conference League finals while in charge of Fiorentina and finishing runner-up in the 2023 Italian Cup. The result secured Bologna a spot

in next season's Europa League and left Milan with the very real likelihood of missing out on European competition. It could spell the end of Sérgio

Conceição's short stint in charge of the Rossoneri, with Milan eighth in Serie A after a disappointing sea-Both teams came to Rome looking to end an Italian Cup drought, as Milan last lifted the trophy 22 years

ago - losing two finals in the intervening years. The match was played at a high tempo from the start and both goalkeepers were called into making impressive saves in the opening 10

Tension threatened to boil over toward the end of the first half and Bologna captain Lewis Ferguson

Timberwolves reach Western finals for second straight year

MINNEAPOLIS, May 15, (AP): Anthony Edwards approached for a handshake during Julius Randle's postgame TV interview, the duo putting a seal on another dominant series for Minnesota in these NBA playoffs.

Randle scored 29 points on 13-for-18 shooting to send the Timberwolves to the Western Conference finals for the second straight year with a 121-110 victory over the Golden State Warriors

Edwards had 22 points and 12 assists for the sixth-seeded Wolves, who will face the Denver-Oklahoma City winner next. They could get five days off, if the Nuggets beat the Thunder on Thursday to force a Game 7 in the other

West semifinal series. Brandin Podziemski had a playoff career-high 28 points for the Warriors, who again played without star Stephen Curry because of the hamstring strain that forced him out of the second quarter in Game 1 and took the heart out of their entire offensive operation.

Jonathan Kuminga provided another energy boost off the bench with 26 points, but Podziemski's performance came too late and the production from Jimmy Butler and Buddy Hield was consistently too little after they led the series-opening win.

Golden State presented far more of a defensive challenge than the Los Angeles Lakers did for Minnesota during their five-game series in the first round. but the collection of every-level scor-

Rudy Gobert was a force around the rim with 17 points, Mike Conley had 16 points and eight assists, and Donte DiVincenzo snapped out of a slump with 13 points as the Wolves shot a staggering 77% on 2-pointers (36 for 47). They set franchise postseason records for assists (36) and field goal percentage (62.8%).

Series close-out games can sometimes be the toughest to win, but the Wolves played with a ferocity paired with their shooting touch that all but portended victory. Randle kept up his superb postseason, providing a constant source of energy and production.

Celtics 127, Knicks 102

In Boston, Before the Boston Celtics took the floor without their biggest star on a night they had to win, Joe Mazzulla implored his players to just pour everything they had into winning one

They did, and the defending NBA champions earned another chance to extend their season. Derrick White had 34 points, includ-

ing seven 3-pointers, to lead the Celtics to a 127-102 Game 5 win over the New York Knicks on Wednesday night that kept them alive in the Eastern Conference semifinals.

The Celtics connected on 22 3-pointers to post their first home victory of the series and first without Jayson Tatum following his season-ending Achilles tendon injury.

The Knicks will try again to win the series Friday in New York. If the Celtics win, Game 7 would be in Boston on

Monday. Jaylen Brown added 26 points and 12 assists. Payton Pritchard had 17 points and five 3-pointers. Luke Kornet finished with 10 points, nine rebounds and seven blocks. He started the second half for Kristaps Porzingis, who played just 12 minutes. Mazzulla said Porzingis was having trouble breathing as he continues to deal with a lingering viral
