Palestinian people's blood ... between Netanyahu and Hamas

A NEW holocaust, by all standards, is unfolding today in the Gaza Strip, but this time, the perpetrator is different.

While the world was horrified by Hitler's attempted genocide during World War II, what Netanyahu and his extremist government are doing is even more horrific than what has been reported about the Nazis.

Back then, the world, especially the victorious European powers, sought to atone for their guilt by accelerating the establishment of the Jewish state. This cause gained traction at a time when the Arabs lacked the power to defend their rights, as they were still reeling from the shock of Sykes-Picot and the calamities it had brought

Conversely, the Arabs failed to capitalize on UN Resolution No. 181, which called for the partition of Palestine, marking the first stage of the conflict, at a time when the Zionist propaganda was still relatively weak.

This situation remained unchanged during the subsequent wars Israel waged to expand its territory, culminating in the complete occupation of all Palestinian lands in June 1967.

As usual, the Arabs exchanged accusations and failed to formulate a unified strategy for confrontation. They rejected all initiatives, starting with that of the late Tunisian President Habib Bourguiba, who advocated for the principle of "take and demand." Bourguiba was accused of treason and ostracized. The same fate befell the Rogers Initiative in 1970, also known as the Second Rogers Plan, which was approved by the then-Egyptian President Jamal Abdel Nasser but rejected by the leaders of the Palestinian Liberation Organization

On the other hand, Tel Aviv seized upon these events to its advantage, spreading the narrative that the Arabs do not seek peace.

When King Fahd's initiative was approved at the Fez Summit, Israel immediately rejected it, just as it did with King Abdullah's initiative. Israel has never accepted, nor will it ever accept, the establishment of a self-governing Palestinian state as stipulated in the Camp David Accords.

Today, 147 countries around the world have recognized the Palestinian state, with four others declaring their intention to do so. Yet, none of these countries offered anything substantial to remove the Israeli "knife" from the Palestinians' throats. What they have provided are nothing more than political statements that can be retracted at any

We must acknowledge that the Palestinian division has played a significant role in prolonging the conflict and complicating the path to a resolution. Each Palestinian faction sought to fulfill the interests of its external supporters, which is why many of these groups emerged in the 1970s and 1980s as terrorist organizations and hijacked civilian planes, incited violent events such as Black September, and positioned themselves as a de facto authority during the Lebanese Civil War.



GCC-ASEAN set sights on free trade

KUALA LUMPUR, May 26, (KUNA): The regional bloc of Southeast Asian nations ASEAN and Gulf Cooperation Council (GCC) member states agreed on Monday, in a joint statement, to start negotiations over a free trade agreement.

The agreement was sealed on the sidelines of the ASEAN/GCC summit in the Malaysian capital, in which His Highness the Amir Sheikh Meshal Al-Ahmad Al-Jaber Al-Sabah is represented by His Highness the Crown Prince Sheikh Sabah Khaled Al-Hamad Al-Sabah.

The joint statement should serve as a launchpad towards talks on a free trade agreement between the two regional blocs, covering a wide array of sectors and

economic aspects that would further reinforce trade ties between Kuala Lumpur and Gulf Arab states, it under-

These talks come as per the directives of the leaders of GCC member states, which urge Gulf Arab countries to bolster their ties with "international partners," said the Riyadh-based bloc's chief Jassem Al-Budaiwi, hailing the agreement as a major step forward in a bid to bring

Leaders from the two regional blocs are assembling for talks in the Malaysian capital to discuss current developments and push forward bilateral relations.



Wara-Burgan well delivers over 500 bpd

KUWAIT CITY, May 26, (KUNA): The Governments of Kuwait and Saudi Arabia have declared new oil discovery in the partitioned zone, according to a joint press release, said the Kuwaiti Ministry of Oil on Monday.

The ministry added in a statement that governments of the Kingdom of Saudi Arabia and the State of Kuwait announced that Wafra Joint Operations have made a new oil discovery in (North Wafra Wara-Burgan) field, located five kilometers north of Wafra field.

Crude oil flowed from the Wara reservoir in the North Wafra (Wara-Burgan-1) well at a rate exceeding 500 barrels per day, with an API gravity of 26 to 27

This marks the first discovery since the resumption of production operations in the partitioned zone and its adjacent offshore area in mid-2020. The discovery is regarded as highly significant, given its positive impact on both countries standing as reliable global energy suppliers and their capabilities

in the exploration and production sector. API gravity is a scale expressing the gravity or density of liquid petroleum



'Reference book launched to gauge disability in a person'

KUWAIT CITY, May 26, (KUNA): Minister of Social Affairs, Family Affairs and Childhood Dr. Amthal Al-Huwailah on Monday affirmed that launch of "Kuwait Reference for Disability 2025" affirms Kuwait's adherence to relevant national legislations and international treaties.

In remarks to KUNA marking launch of the index, the minister said the move came in implementation of the Law 73/2020 that stipulates in its 48-19 items necessity of placing clear scientific criteria to diagnose the handicap case and compelling the Public Authority for Disability Affairs to publicize such information via its website.

The reference was the fruit of intensive efforts that had lasted for ten years; exerted in cooperation with experts of the United Nations and the World Health Organization, medical and technical committees at the disability affairs authority and MoH specialists.

It includes explicit and specific instructions and criteria to assess cases of mental, psychological, physical, mobility, visual and audio impairments, she said.

It is also partly aimed at aiding the specialists to take the right decisions, unify procedures and guide workers in the sectors of diagnosis, education and employment of the impaired.

MC nods requirements of service sector buildings

KUWAIT CITY, May 26: Municipal Council Vice-Chairman Khaled Al-Mutairi presided over the session of the council on Monday, which led to the approval of the final version of the proposed amendment to Item No. 16 regarding the requirements and specifications for service sector buildings (No. 16) in Shuwaikh and Al-Rai.

The council made the decision after discussing the most important items in the schedule for the multi-use zone (formerly the free zone).

The most crucial requirements are as follows: the building percentage should reach 130 percent, with three floors and a 100 percent basement that can be used for commercial purposes or parking, with heights not exceeding 12 meters and six meters per floor, and the size of showrooms and offices must not be less than 100 square meters.

The council specified the permitted activities -- administrative offices, shops, showrooms, banking services, health clubs, hotels and warehouses. It also approved the following:

- Request of the Public Authority for Sports to allocate an alternative site to the previously designated temporary and seasonal site for training and qualifying Kuwaiti youths in skydiving in East Sabah Al-Ahmad Coastal Area.

- Two requests of the Ministry of Electricity, Water and Renewable En-

ergy to allocate a water service route to supply fresh water to East Sabah Al-Ahmad Residential City and to allocate two routes to supply the main transformer station in Umm Al-Hayman. - Request of Kuwait Fire Force to reduce the size of the Firemen's Club,

located in Block Seven, due to natural obstacles. - Request of the Ministry of Islamic Affairs to allocate a site for a Quran

memorization center and parking spaces in Abdullah Al-Mubarak, opposite

- Objections of State Minister for Municipality Affairs Abdullatif Al-Mishari to certain decisions that the council issued on March 24. Meanwhile, the council rejected the request of the Ministry of Finance to transfer the allocation of a 5,000-square-meter plot in Dajeej, South Far-

Other decisions are under further review; including the request of the Public Authority for Roads and Transportation (PART) to develop a road connecting the Abdullah Al-Mubarak University campus and the Seventh Ring Road, and the proposal of Municipal Council Vice Chairman Khaled Al-Mutairi to expand Gate Two of Sabah Al-Salem University City on Road 602.

Logic of an 'isolated case' or naivety of upper echelons

"THE recent suspected corruption incident at a cooperative society has been described by the Minister of Social Affairs Dr. Amthal Al-Huwaila as an "isolated case." By that logic, corruption cases within the Ministry of Social Affairs, other ministries, and the cooperative sector are all merely "isolated cases" of fraud and misconduct", columnist Khaled Ahmed Al-Tarrah wrote for Al-Seyassah daily.

"What is not an isolated case, how-

ever, is the recurring display of political immaturity by some ministers, as well as their limited grasp of linguistic, media, and political communication . This reflects a deeper issue: a lack of understanding of the nature of corruption cases and

the impact that certain terms can have on both legal proceedings and the country's international reputation.

"If we accept Minister Al-Huwaila's statement describing the corruption incident at the cooperative society as an "isolated case," then by the same logic, the phenomenon of depression, alienation, lack of belonging, school and societal violence, and even the recruitment into terrorist groups must also be considered "isolated cases", and therefore not reflective of the situation in Kuwait.

"If the corruption incident is truly just an "isolated case," then it is the respon-sibility of the Minister of Social Affairs Dr. Amthal Al-Huwaila to present the context and justification for this claim to the U.S. Treasury Department and international agencies monitoring money laundering activities. This would help ensure that such agencies do not generalize or cast doubt on Kuwait's integrity or the reputation of its charitable work on a national scale.

"From a psychological, social, and political perspective, Minister Al-Huwaila's use of the term "isolated case" deserves to be translated into international languages and presented to the global community as a framework for addressing corruption and forgery. Framing such incidents as isolated could serve, in theory, to counter the growing wave of international reports on money laundering and corruption in Kuwait.

"Is the involvement of a consumer cooperative in organizing Quran competitions or promoting the Islamization of do-mestic workers really an "isolated case"? Is the attempt by certain religious groups to influence elementary school students and organize them into parties under the guise of Quran memorization and instruc-

tion, also merely another "isolated case"? "Is it the responsibility of individuals, or the duty of the state, to protect innocent children from the political agendas of religious groups such as the Muslim Brotherhood and others? And is the phenomenon of Quran memorization pro grams in cooperative societies truly an

"Does Minister Al-Huwaila's description of the incident as an "individual case" reflect her personal opinion and limited experience, or does it represent an official ministerial stance that downplays

the seriousness and nature of corruption? "Have we, perhaps, fallen into the trap of generalizing corruption cases, such as the embezzlement of public funds in state investments in Spain, the transportation sector, and social security funds, when, in reality, each is just an "individual case"?

"I may be as unfamiliar with politics and media as Minister Al-Huwaila, but even the most naïve line of questioning leads us to controversial hypotheses such as applying the term "individual case" to the situation involving the former Director General of the Public Institution for Social Security, Fahd Al-Raja'an. It raises a critical concern: could such terminology be legally exploited to downplay serious offenses like accepting commissions and embezzling public funds as mere instances of human error?

"Perhaps it would be useful to present the statement by the Minister of Social Affairs Amthal Al-Huwaila, describing corruption as an "individual case," as part of the defense argument in a corruption trial, to truly grasp the legal implications of such an ill-considered statement.

"I once mistakenly objected to the Civil Service Commission's training programs for teaching executive leaders etiquette and media communication . Today, I fully support not only those programs but also expanding them to include ministers, particularly in the areas of media handling and political communication."

"In a meeting I had with the late Minister of Communications Habib Johar Hayat (May God have mercy on him) he shared several insights, including that the Iranians had requested Kuwait to establish a free trade zone because Kuwait is the closest point of convergence between the Gulf and Iran", Kuwaiti journalist **Hassan Ali Karam** wrote for **Al-Seyassah** daily.

"After this, Kuwait established the socalled free trade zone at Shuwaikh Port, which initially inspired optimism. However, that optimism was short-lived as the government handed over the free trade zone to the so-called private sector.

"The free trade zone was transformed from a promising trade hub into a housing complex for bachelors and shops charging exorbitant rents, eventually becoming a playground for stray cats and dogs. Projects like this often fall victim to deliberate sabotage or envy, and the free trade zone suffered from both.

"The intention was clear - to prevent Kuwait from opening up and to keep it marginalized.

"Our brothers in the Gulf countries are immune to envy, and they focus on achieving their goals without wasting time looking back or paying heed to the words of enemies or the ignorant.

"By relying on God and through the efforts of patriot citizens, they reached agreements with their Indian and Iranian neighbors to connect their countries via sea tunnels.

"Qatar, for instance, decided to build an undersea tunnel linking Doha to Iran to facilitate trade and passenger transport. This idea emerged in the aftermath of the Gulf crisis, when Iran opened its markets

"The UAE has agreed with India to establish two sea tunnels: one connecting Abu Dhabi to India to supply the emirate with fresh water, and the other linking Dubai to Mumbai, which is India's commercial capital.

"I do not care about what others have accomplished but I care about what we are doing here in Kuwait. While it is true that we are working, our progress is lagging behind. We lack initiatives and standout projects. We must not deceive ourselves

by copying projects from other countries.

"The free zone was either a failed project or deliberately sabotaged. We remain stuck at the gate, while our government's activity is limited to transfers, secondments, reshuf-

fles, or promotions of employees.

"This is why we will continue to be on the margins of success if we operate with a mindset focused on trivial divisions such as searching for who is the son of a free woman and who is the son of a maiden. We will achieve nothing unless

we respect and empower creative minds. "Right now, we are burning our own papers with our own hands by under-mining the efforts of our dedicated and innovative citizens. The tunnel projects connecting countries are just one example of how others have advanced while we remain stuck.'

"I recently came across a global report that ranked the best cities in the world for walking. It highlighted several advanced cities that have successfully made walking a natural and comfortable part of daily life for both residents and visitors such as Copenhagen, Amsterdam, Paris, and Tokyo", former member of the Board of Directors of the Public Authority for Agriculture Affairs and Fish Resources Mohammad Ibrahim Al-Furaih wrote for Al-Sevassah daily

'The important features that define a walkable city include safe and wellmaintained sidewalks, minimal traffic congestion, easy access to public transportation, and the presence of public amenities such as shops, parks, cafés, and restrooms. Other important elements include clean air, green spaces, clear signage, and wide, unobstructed pathways free from physical barriers.

"It is also important to recognize that the success of major shopping malls and leading global capitals in attracting shoppers is largely due to the ease with which pedestrians can access exhibitions and stores, comfortably and without unneces-

sary obstacles. "It is in everyone's best interest - individuals, businesses, and municipalities alike - to invest in improving the walking environment along public streets, making them more attractive, safe, and comfort-

able for all. "Back in the 1960s, walking was a pleasant experience along streets like New Street and Fahad Al-Salem Street. Shoppers enjoyed shaded walkways provided by awnings in front of markets such

as Souq Waqif and Souq Al-Gharbally. "Today, the situation is markedly different. Inconsistent shop and building



elevations have made sidewalks uneven and difficult to navigate, especially for the elderly and people with special needs.

"During my visit to Tokyo, I ate a candy bar while walking along

a public street.

When I looked for a trash can to dispose of the wrapper, I found none. Yet, the street was remarkably clean. Curious, I asked the hotel staff the reason, and their response was simple and firm: "Our policy is clear... you take your trash home with you." It is a strict rule, but it reflects an effective and deeply rooted community culture.

"While studying in the United States, I also observed the strong emphasis on respecting pedestrians in cities across the country. Violating pedestrian rights, such as parking in a way that obstructs a sidewalk, can lead to your vehicle being towed, often just from a neighbor's complaint. This level of respect for public space demonstrates a high degree of urban awareness, something still lacking in many of our Arab cities.

"In contrast, the Kuwait Municipality could generate millions of dinars simply by enforcing strict littering laws and holding shop and building owners, who profit from renting their properties, responsible for maintaining the cleanliness of sidewalks and walkways in front of

their premises. "I also propose a practical exercise for members of the Municipal Council: walk from the Council building to Al-Hamra Tower along Shuhada Street. This will give them firsthand experience of the uneven sidewalks, the obstacles hindering pedestrian movement, and the advertising poles left protruding 5 to 10 centimeters above the ground - creating danger-

ous hazards, especially at intersections. "The streets of Shuwaikh, Al-Rai, Fahaheel, and Jahra are cluttered with obstacles, as if designed to discourage pedestrians from accessing nearby shops.

"Strict enforcement of cleanliness regulations is needed for all shops along public streets, and building owners who disregard pedestrian crossings must be held accountable. Cleanliness is a shared responsibility, and pedestrians are an essential part of the city's urban fabric.'

Asian commits suicide

Foul play suspected in death of Arab resident

KUWAIT CITY, May 26: Security forces in Hawally Governorate were mobilized recently in response to a report that the Operations Unit at the Ministry of Interior received regarding a deceased individual found inside a vehicle parked at a waterfront parking lot, reports Al-Jarida daily.

A security source informed the daily that upon receiving the report, emergency police units and officers from the Hawally Security Directorate were dispatched to the scene. Forensic experts and a forensic physician were also called in to examine the situation.

A preliminary inspection suggested that the death may be criminal in nature. The deceased was identified as an Egyptian, in his 30s.

Investigations are ongoing to determine the exact circumstances leading to the death of the Egyptian.

In another incident, an Asian was found dead in what appears to be a suicide at a barn where he was employed in Kabad.

Security sources revealed that the Asian consumed

Court acquits Moroccan citizen of trafficking in drugs and use

3 years jail upheld for blogger in libel suit

KUWAIT CITY, May 26: The Criminal Court acquitted a Moroccan of drug trafficking and consumption after finding out that the arrest and search warrant issued by the Public Prosecution was invalid, as it was based on frivolous investigations.

The court explained in its ruling that while the prosecution has the authority to issue the warrant, it is subject to judicial oversight to ensure that the investigations upon which it was based meet the requirements of seriousness and sufficiency.

The court accepted the arguments of the defendant's lawyer, Attorney Abdul-Mohsen Al-Qattan, who argued that the warrant was invalid based on the frivolity of the investigations and the inaccuracy and unreasonableness of the incident.

The lawyer also pointed out that the defendant has no connection to the seized items, not to mention the absence of physical evidence in the documents, invalidity of the nighttime search of his client's residence, and invalidity of the personal search, because it occurred prior to the issuance of the warrant.

The court stated in its reasoning that the investigation report lacked true or accurate information about the defendant's alleged drug activity, as it was based solely on information from an undisclosed confidential source.

The officer in charge of the investigation stated in his testimony to the prosecution that he monitored the defendant once for an hour from a distance at night, without catching her engaged in any drug buying or selling activity, nor did he identify the type of narcotics or the source from which she obtained them.

The court said these facts confirm the lack of a serious investigation to justify the issuance of the warrant, which invalidates the document and the resulting procedures; leading to the acquittal of the defendant.

3 years jail upheld: The Court of Cassation, headed by Judge Mohammad Al-Khalaf, dismissed the appeal of a citizen accused of insulting the country and upheld his three-year prison sentence as he was convicted of various crimes including the administration of a fake account.

In another case, the Criminal Section in the Court of Cassation upheld the five-year prison ISIS, insulting several heads of State, and disseminating information for the organization.

In this context, the Criminal Court, headed by Judge Mutab Al-Ardhi, sentenced a citizen and a Bedoun to five years in prison for joining ISIS, urging others to join the organization and insulting the emirate.

The court stated in its ruling that "the ideas

of the perpetrators, if communicated to the outside world through physical action such as communicating electronically with the terrorist group, creating websites and electronic accounts to support them, and inviting others to join them and pledge allegiance to their leader, fall within the scope of criminal acts. The perpetrators are punished for committing criminal physical acts, not just mental thoughts.

Mother retains custody: The Family Court (Jaafari Circuit) upheld a female citizen's custody of her children, even though they are of the age of being in their father's custody, due to his abuse. The court rejected the father's cus-

tody claim. Attorney Mohammad Safar filed the case on behalf of the mother, urging the court to grant her custody of the children from her ex-husband and that she should be protected from any interference in this regard.

He also requested that the ex-husband should be obligated to pay his client two types of alimony (food and clothing) for her children from the date of the issuance of the ruling; as well as the rent for the custody residence from the date of the ruling, which must continue, and the cost of furnishing the residence.

The court granted Safar's request, ruling to establish the mother's custody of the three children and obligating the ex-husband to pay the expenses and attorney's fees.

Police nab 402 criminals

KUWAIT CITY, May 26: Last week, police patrols referred 32 individuals to the Drug Control General Department (DCGD) in the Interior Ministry after arresting them during security campaigns conducted throughout the country.

The police also arrested 402 individuals wanted for criminal cases, absconding, expired residency and others; in addition to 104 individuals who were detained for failure to present valid identification documents.

The weekly statistics from police patrols indicated the seizure of 23 vehicles wanted by the judiciary, provision of assistance to 736 cases, controlling the parties involved in six fights, and handling 154 traffic accidents including four

KUWAIT CITY, May 26: Minister of Public Works Dr. Noura Al-Mashaan has announced the continuation of major maintenance work on the Fourth Ring Road as part of a comprehensive plan that includes a number of new contracts for the maintenance of highways and main roads.

In a press statement Sunday, the minister confirmed that these works are among the 18 contracts covering various governorates to improve the quality of road infrastructure and enhance safety and security standards, in

line with the best international standards and specifications.

She pointed out that major and periodic maintenance operations directly contribute to preserving the sustainability of roads by extending their lifespan and reducing the need for future reconstruction.

"This positively impacts the level of services provided to citizens and expatriates, and achieve cost savings in the long term," she explained.

Meanwhile, the Ministry of Public Works announced a tender for the construction and maintenance of roads, stormwater and sanitary drainage systems in the northwestern part of Jahra.

The Public Authority for Roads and Transportation (PART) will implement the project, which is included in its annual project plan. The tender will be floated in fiscal 2025/2026.

The project aims to provide infrastructure services and internal road networks, in addition to

the development and expansion of existing roads according to the approved cross-sections and structures.

The ministry explained, through the Official Gazette (Kuwait Al-Youm), that the scope of work includes connecting the internal road network to the main network, with a length of 8.72 kilometers; as well as the establishment of a sanitary drainage and stormwater network, with an implementation period of 24 months.

In another development, Undersecretary of the Ministry of Public Works Eid Al-Rashidi conducted an inspection visit to Al-Rai, accompanied by Assistant Undersecretary for Maintenance Affairs Fawaz Al-Shammari, and Director of the Laboratories Department at the Government Center Sector Mahdi Al-Qallaf, reports Al-Seyassah daily

During the visit, a comprehensive plan was reviewed to maintain and improve the road network in the area adjacent to Grand Avenue Mall.

KUWAIT CITY, May 26: Minister of Social Affairs, Family and Childhood Affairs Dr. Amthal Al-Huwaila issued Decision No. 86/2025, which was pub-

lished in the official gazette "Kuwait Al-Youm", regarding the appointment of an interim board of directors for the Women's Voluntary Society for Community Development, reports Al-Seyassah daily.

Article 1 of the deci-



sion stipulates the dissolution of the current board of directors of the Women's Voluntary Society for Community Development and the appointment of an interim board for a renewable one-year term.

The interim board will be chaired by

Bashayer Salah Al-Ghanim, with members Hawra Nader Al-Habib, Nahla Abdulaziz Al-Shamali, Abdulaziz Adel Al-Mannai, and Abdullah Yousef Al-Hairi

Article 2 of the decision stipulates that the former board of directors must hand over the society's headquarters, funds, and all related documents and records to the newly-appointed board within three days from the date of the decision's issuance.

Article 3 grants the appointed board all powers and authorities vested in the board of directors under Law No. 24/1962 and the society's bylaws.

Article 5 mandates the interim board to examine the society's budget, review its books and records, investigate any violations, and take the necessary measures to protect the society's funds.

Meanwhile, the Public Relations De-

partment at the Kuwait Municipality announced that the supervisory team in the Engineering Audit and Follow-up Department in the Municipality branch in Mubarak Al-Kabeer Governorate has completed its fifth round of field inspections, reports Al-Anba daily.

These inspections aim to ensure compliance with removal orders issued to charitable committees operating in residential areas.

The latest inspection campaign led to the issuance of 15 warnings. In coordination with the committees, several charitable activities conducted in private residences were relocated.

The department stressed that supervisory teams will strictly enforce all legal measures in accordance with municipal regulations. It also affirmed that many committees complied with removal orders immediately after receiving warnings.

This history is well-known across the world. Therefore, when Sinwar and Hamas orchestrated the events of October 7, 2023, we saw Western leaders, led by former US President Joe Biden, flock to Netanyahu's residence.

Today, the Israeli government in Tel Aviv resembles a "vampire regime" that is clinging to unattainable utopian

The establishment of a Palestinian state, with approximately 13 million Palestinians, while the Jewish population is only around 5.5 million, poses an existential threat to Israel. As a result, Israel has pursued policies aimed at either exterminating the population of the Gaza Strip or transferring them to another state, along with displacing the residents of the West Bank to Jordan. A new Yahya Sinwar will rise, and Hamas will continue to exploit the Palestinian cause, while innocent Palestinian civilians will continue to be slaughtered daily.

GCC-ASEAN

Gulf Cooperation Council (GCC) Secretary General Jassem Al-Budaiwi affirmed, Monday, that the Gulf states are a globally trusted partner and a key hub for international cooperation, thanks to their credibility and balanced political approach.

Contenders produce many hours of content already

2028 podcast primary well underway as US Democrats try to reshape image

WASHINGTON, May 26, (AP): The Democrats' 2028 podcast primary is well

From Govs Gavin Newsom of California, Andy Beshear of Kentucky and Gretchen Whitmer of Michigan to former Transportation Secretary Pete Buttigieg, potential presidential contenders are following the lead of President Donald Trump, who frequently went on podcasts appealing to younger men during his

Liberal strategists acknowledge Trump showed that Democratic candidates need to master the podcast space, which is typically looser and more freewheeling than a press conference or a traditional media interview.

"The way that politicians communicate and need to be seen by their audience is changing," said Liz Minnella, who fundraised for Democratic nominee Kamala Harris and this year launched Connect Forward, a group to support liberal influencers. "I hate to give him credit, but he found a way to connect with people, talk to them like human beings in non-political speak.'

Newsom, long derided by conservatives as a San Francisco liberal, has welcomed conservatives onto his podcast and agreed with them on issues such as trans participation in women's sports. Beshear, a lower-profile Democrat in a red state, hosted his teenagers to teach him how to use the youth slang "skibidi."

The likely 2028 contenders have produced many hours of content already. Here's a look at key moments and what we've learned about the field so far.

Launching "The Andy Beshear Podcast" earlier this year, the Kentucky governor now has hosted a donor, a former ambassador, businessmen he calls friends and US Sen Amy Klobuchar, who ran for the 2020 Democratic presidential nomi-

He even brought on his two children to explain slang words high schoolers are using, asking them to explain to him how to use terms like "skibidi" to say something looks good, or "doing it for the plot" to say you'll be taking a risk on something despite a potentially bad outcome.

From his first episode, the 47-year-old politician outlines some rules and says

the first is "be authentic, you be you, boo."

The governor did not respond to a request for comment on his strategy, but has mostly taken a position of dissecting and broadcasting opposition to Trump's poli-

cies, such as potential cuts to Medicaid and the use of the Signal messaging app by the president's national security team to discuss sensitive military operations. In one of Beshear's most recent episodes earlier this month, his producer asks the governor a frequent listener's question: Will you run for president?

"If it were three years ago, this was something that we would have never thought about," Beshear said, sitting beside his wife, Britainy. "But I'm committed to not leaving a broken country to my kids or anyone else's. Now, what that looks like going forward, I don't know. My job right now is to try to lift up as many leaders as possible all across the country that are hopefully focused on the right things with the right message to re-earn the faith of the American people.'

Whitmer recently appeared on "Pod Save America" for a shorter interview than other contenders have done on podcasts. Whitmer had received some backlash for sharing a hug with the president last month as he arrived in her home state, less than a month after she shielded her face from cameras during an Oval Office appearance alongside Trump.

Whitmer and Trump announced a new fighter jet mission at a National Guard

base outside Detroit that is seen as a major economic driver for the area.

"This is a BFD," she said on the podcast, referencing if not outright saying a profane phrase that starts with "big" and ends with "deal."

"It doesn't mean I've abandoned any of my values. It doesn't mean that I'm not going to stand my ground and fight where we have to, but this is one of those moments where as a public servant you're reminded your job is to put service above self and that's what it was all about."

In February, California's governor launched "This is Gavin Newsom" as what he called a mechanism for talking "directly with people I disagree with, people I look up to, and you - the listeners."

Thus far, he's had a wide array of guests, including former Trump strategist Steve Bannon and conservative influencer Charlie Kirk, as well as Klobuchar and Minnesota Gov. Tim Walz, Harris' 2024 running mate.

The conversations have mostly been chummy. Newsom - who has in recent weeks broken with California's legislature and faced liberal criticism for his positioning on trans issues, immigration and homelessness - has fielded backlash for giving a platform to some of his party's biggest critics.

Newsom has also drawn criticism for opposing the participation of trans athletes in women's sports.

"I think it's an issue of fairness, I completely agree with you on that," Newsom told Kirk in his debut episode. "It is an issue of fairness - it's deeply unfair."

The diverse guest list could be part of Newsom's attempt to self-brand as a centrist ahead of a possible 2028 run, hearing out conservative critics while trying to assume his party's mantle. In March, the governor told HBO's Bill Maher that Democrats had developed a "toxic" brand and criticized some in the party who are unwilling to "have a conversation" with their opponents.

Trump administration releases people to shelters it threatened to prosecute for aiding migrants

McALLEN, Texas, May 26, (AP): The Trump administration has continued releasing people charged with being in the country illegally to nongovernmental shelters along the US-Mexico border after telling those organizations that providing migrants with temporary housing and other aid may violate a law used to prosecute smugglers.

Border shelters, which have long provided lodging, meals and transportation to the nearest bus station or airport, were rattled by a letter from the Federal Emergency Management Agency that raised "significant concerns" about potentially illegal activity and demanded detailed information in a wide-ranging investigation. FEMA suggested shelters may have committed felony offenses against bringing people across the border illegally or transporting them within the United States.

"It was pretty scary. I'm not going to lie," said Rebecca Solloa, executive director of Catholic Charities Diocese of Laredo.

US Immigration and Customs Enforcement continued to ask shelters in Texas and Arizona to house people even after the March 11 letter, putting them in the awkward position of doing something that FEMA appeared to say might be illegal. Both agencies are part of the Department of Homeland Security.

After receiving the letter, Catholic Charities received eight to 10 people a day from ICE until financial losses forced it to close its shelter in the Texas border city on April 25, Solloa said.

The Holding Institute Community, also in Laredo, has been taking about 20 families a week from ICE's family detention centers in Dilley and Karnes City, Texas, Executive Director Michael Smith said. They come from Russia, Turkey, Iran, Iraq, Papua New Guinea and China. Annunciation House in El Paso, Texas, has been receiving five to 10 people day from ICE, including from Honduras and Venezuela, said Ruben Garcia, its executive director.

International Rescue Committee didn't get a letter but continues receiving people from ICE in Phoenix, according to a person briefed on the matter who spoke on condition of anonymity to discuss information that has not been made public. The releases include people who had been held at ICE's Krome Detention Center in Mi-

ami, the site of severe overcrowding. ICE's requests struck Solloa as a "little bit of a contradiction," but Catholic Charities agreed. She said some guests had been in ICE detention centers two to four weeks after getting arrested in the nation's interior and ordered released by an immigration judge while their challenges to deportations wound through the courts. Others had been flown from San Diego after crossing the border illegally.

Those released were from India, China, Pakistan, Turkey, and Central and South America, Solloa said.

Smith, a Methodist pastor, said that the FEMA letter was alarming and that agreeing to continue caring for people released by ICE was "probably not a good idea." Still, it was an easy choice.

"There's some things that are just right to do," he said. Tricia McLaughlin, the DHS spokeswoman, drew a distinction with large-scale releases under Republican President Donald Trump's predecessor, Democrat Joe Biden. The Biden administration worked closely with shelters but, during its busiest times, released migrants at bus stops or other public locations.

S.Carolina beach town shooting injures 11

At least 11 people were taken to hospitals after a shooting Sunday night in a South Carolina beach town, authorities said. Horry County Police did not give the conditions of anyone hurt or detail how they were injured in the incident, which happened about 9:30 p.m. in Little River.

Investigators were getting reports of more people arriving at the hospital in private vehicles, Horry County Police said on social media.

About 90 minutes after the shooting, police called it an isolated incident and said there is no risk to the community. They did not release any information on possible suspects or what led to the shooting. The shooting happened around a boat dock near the Intracoastal Waterway.

Video from the scene showed dozens of police cars and ambulances rushing in and out of the area.

A North Myrtle Beach police officer responding to the shooting accidentally shot himself in the leg at a marina about 3 miles (5 kilometers) away and is in the hospital in stable condition, North Myrtle Beach spokeswoman Lauren Jessie said. Little River is about 20 miles (32 kilometers) northeast

Russia sent record number of drones into **Ukraine as Trump says Putin has 'gone crazy'**

KYIV, Ukraine, May 26, (AP): Russia overnight launched the biggest drone attack on Ukraine in the more than three-year war, a Ukrainian official said Monday. President Donald Trump said Russian leader Vladimir Putin has gone "crazy" by stepping up the bombing of Ukraine just as the US tries to broker peace.

The Russian bombardment on Sunday night included 355 drones, Yuriy Ihnat, head of the Ukrainian air force's communications department, told The Associated Press.

The previous night, Russia fired 298 drones and 69 missiles of various types at Ukraine in what Ukrainians said was the largest combined aerial assault during the conflict. From Friday to Sunday, Russia launched around 900 drones at Ukraine, officials said.

The escalation appeared to thwart hopes that Trump's peace efforts might lead to a breakthrough in the near term, as Putin looks determined to capture more Ukrainian territory and inflict more damage.

Russia has this month broken its record for aerial bombardments of Ukraine three times. The expansion of its air campaign came after Kyiv in March accepted an unconditional 30-day ceasefire proposed by the US but Moscow effectively rejected it.

Russia is also still pushing along the roughly 1,000-kilometer (620-mile) front line, where it has made slow and costly progress, and is assembling its forces for a summer offensive, Ukraine and military analysts say.

"Only a sense of complete impunity can allow Russia to carry out such attacks and continually escalate their scale," Ukraine President Volodymyr Zelenskyy wrote on Telegram on Monday. "There is no significant military logic to this, but there is considerable political

He repeated his call for tighter international economic sanctions on Russia as a way of ending the war, because Russia's "desire to fight must be deprived of resources."

Pope Leo XIV declares 'I am Roman!

ROME, May 26, (AP): Pope Leo XIV declared himself a Roman on Sunday as he completed the final ceremonial steps cementing his role as the bishop of Rome. The first American pope formally took possession of the St. John Lateran Basilica, which is Rome's cathedral and seat of the diocese, with an evening Mass attended by Roman priests and faithful.

He then took the popemobile for a visit to St Mary Major, where he prayed before Pope Francis' tomb.

In his homily, Leo said he wanted to listen to them "in order to learn, understand and decide things together."

One of the many titles that Leo assumed when he was elected May 8 was bishop of Rome. Given his responsibilities running the 1.4-billion strong universal Catholic Church, popes delegate the day-to-day governance of running of the diocese of Roman to a vicar. Sunday's ceremonies at the St. John Lateran and a stop at St Mary Major basilicas follow Leo's visit last week to the St Paul Outside the Walls basilica. Together with St Peter's Basilica in the Vatican, the four papal basilicas are the most important basilicas in the West.

Australian state plans to ban sale of machetes following violent gang fight

MELBOURNE, Australia, May 26, (AP): An Australian state government is banning the sale of machetes after a violent gang fight in a suburban shopping mall injured a young man.

Victoria Premier Jacinta Allan announced Monday the ban on the sale of large knives would take effect Wednesday after machete-wielding gang members clashed at a Melbourne mall on Sunday afternoon.

A 20-year-old man was seriously injured in the fight that involved eight combatants armed with machetes, a police statement said. Four suspects had been arrested and charged by Monday.

"I will introduce as many laws (as needed) to get these dangerous knives off the streets," Allan told reporters.

"We will be bringing in place a ban on the sale of machetes here in Victoria and this ban will be in place from midday on Wednesday. Under consumer powers, using these powers, Victoria will be banning machetes from being sold anywhere in the state," she added.

Victoria is the only Australian

state or territory that plans to ban machetes, broadly defined as a cutting edge knife with a blade exceeding 20 centimeters (almost 8 inches) long. Kitchen knives are not included in the ban.

Possession of a machete will be banned with few exceptions in

Victoria, Australia's second-most populous state, from Sept. 1.

The ban on the sale of machetes was to have taken effect on that date. A three-month amnesty will give people time to dispose of their machetes at police stations and secure bins without penalty.

France's Macron on visit to Vietnam urges for greater cooperation in defense and trade

HANOI, Vietnam, May 26, (AP): French President Emmanuel Macron called on Monday for closer cooperation between Vietnam and France in an increasingly unstable global landscape as he visited Hanoi as part of a Southeast Asia tour focused on strengthening regional ties.

Macron emphasized the need for "an order based on law" at a time of "both great imbalance and a return to power-driven rhetoric and intimidation." He next heads to Indonesia and Singapore.

The visit comes amid trade tensions, with the US threatening steep tariffs on goods from Europe. Vietnamese imports to the United States were hit with 46% tariffs - among the highest rates applied to any country - in April.

Macron signed more than a dozen agreements on defense, nuclear power and trade, including one with the Vietnamese budget airline company Vietlet and Airbus to buy 20 A330-900 planes.

Malaysia stresses importance of preserving geo-economic cooperation at ASEAN summit

Southeast Asian nations want to discuss tariffs with Trump as unified bloc: Anwar

KUALA LUMPUR, Malaysia, May 26, (Agencies): Southeast Asian nations will forge a common front to face challenges including economic headwinds from US tariffs and a four-year civil war in Myanmar, Malaysian Prime Minister Anwar Ibrahim said Monday.

Opening an annual summit of the Association of Southeast Asian Nations, Anwar said he has sought a unified bloc meeting with US President Donald Trump to discuss the tariffs. Officials are hopeful it could happen later this year. Malaysia is the current chair of ASEAN.

"For ASEAN, our peace, stability and prosperity have often depended on an open, inclusive, rules-based international order... These foundations are now being dismantled under the force of arbitrary action," Anwar said.

ASEAN, which has agreed to avoid retaliatory measures, has formed a taskforce to coordinate a response to the US tariffs in parallel with bilateral negotiations by some member countries, Anwar said. ASEAN members include bigger economies such as Singapore, Indonesia, Malaysia, Thailand and the Philippines, as well as Vietnam, Cambodia, Laos and Myanmar.

The region relies on exports to the US and is hurt by the Trump administration's tariffs, which range from 10% for Singapore to as high as 49%

for Cambodia. Trump announced a 90-day pause on tariffs in April for most of the world, and this month struck a similar deal with key rival China, easing trade war tensions.

Anwar said an ASEAN leaders' meeting on Tuesday with Chinese Premier Li Qiang and the Gulf Cooperation Council - the first such tripartite meeting - would spur new cooperation that could help insulate ASEAN's economy. The GCC comprises Bahrain, Kuwait, Oman, Qatar, Saudi Arabia and the United Arab Emirates.

ASEAN leaders later Monday will launch a new 20-year vision to deepen their economic and social integration, Anwar said.

Analysts said China, which is ASE-AN's top trading partner, wants to expand its influence by presenting itself as a reliable ally in the region. But tensions persist over Beijing's aggressive stance in the disputed South China Sea that has led to frequent clashes especially with the Philippines.

Philippines President Ferdinand Marcos Jr. told the ASEAN summit that a "code of conduct" being negotiated by ASEAN and China to govern the busy sea passage must be binding one of the factors that has hampered

"We underscore the urgent need to accelerate the adoption of a legally binding code of conduct in the South

China Sea to safeguard maritime rights, promote stability and prevent miscalculations at sea," he said.

On the Myanmar crisis, Anwar said Malaysia has managed to "move the needle forward" after forming an informal advisory group headed by former Thai leader Thaksin Shinawatra. Anwar met last month with Myanmar military chief Gen. Ming Aung Hlaing

in Bangkok and held virtual talks with the opposition National Unity Govern-

Officials said the current emphasis on aid delivery following a March earthquake that killed 3,700 people could eventually pave the way for peace talks. But critics accuse the army of violating a self-proclaimed ceasefire with dozens of airstrikes, with aid not

freely allowed into areas not under the army's control.

The Myanmar war, which has killed thousands and displaced millions, is a challenge to ASEAN since refugees have fled across borders to neighboring nations. The region has also seen rising transnational crimes and cybercrimes. The bloc has made little headway after the Myanmar military refused to comply with its peace plan, including a ceasefire, delivery of humanitarian aid and negotiations.

Anwar said more engagement is being planned in Myanmar.

"Quiet engagement matters. The steps may be small and the bridge may be fragile but as they say: In matters of peace, even a fragile bridge is better than a widening gulf," Anwar said.

Thomas Daniel from Malaysia's Institute of Strategic and International Studies said ASEAN has no real leverage to push for reconciliation. The Myanmar military has reportedly lost control of a large part of the country, making the situation even more challenging

lenging.
"The conditions on the ground are extremely difficult. I don't think we have reached a stage where ASEAN can facilitate any kind of political dialogue between conflicting parties. They are not ready for that yet," he said.

Anwar stressed the importance of preserving the geo-economic coopera-

tion model between the Association of Southeast Asian Nations (ASEAN), the Gulf Cooperation Council (GCC), and China, emphasizing its role in building a more inclusive and sustainable future for the region.

In his opening remarks at the 46th ASEAN Summit, including the 2nd ASEAN-GCC Summit and the 1st ASEAN-GCC-China Summit, Ibrahim noted that this trilateral model represents a strategic pillar in a multipolar global reality.

He added that the trilateral summit reflects goodwill and enables regional blocs to work with a clear strategic vision, noting that this cooperation symbolizes the strength of regional unity, which will have a positive impact on the world.

'Argentina is bleeding from inequality'

Milei's austerity policies criticized

MEXICO CITY, May 26, (AP): The Archbishop of Buenos Aires fiercely criticized Argentine President Javier Milei during a religious ceremony the leader attended Sunday, saying that under the government's harsh policies "fraternity, tolerance and respect are dying."

Milei, a libertarian and staunch

Milet, a libertarian and staunch ally of President Donald Trump, has implemented austerity policies, a sort of fiscal shock therapy, in an attempt to reign in painfully high inflation in the South American nation. But the policies have also left poverty rates soaring and fueled waves of protests, which in some cases have been met with a violent response by police.

On Sunday, Archbishop Jorge Garcia Cuerva denounced those policies and the larger political atmosphere in Argentina in front of Milei, who was kneeling alone in the front row, and members of his Cabinet.

"Argentina is bleeding from inequality," he said. The government "is far away from the people in the streets. They don't feel their pain, nor their frustrations."

Milei watched the speech still faced.

Garcia Cuerva warned of hate and misinformation spreading through social media. He described it as "terrorism through social media," citing former Pope Francis, who hailed from Argentina. Milei's government often uses social media to attack critics, including politicians and journalists, calling them names like "degenerates" and "baboons"

India rushes to contain spill as cargo ship sinks off Kerala coast

India's southern state of Kerala on Monday issued a high alert along its coastal areas and asked fishermen not to venture near the site of an accident where a container ship carrying hazardous cargo sank off its coast in the Arabian Sea.

The Liberia-flagged MSC ELSA 3 was sailing between the Indian ports of Vizhinjam and Kochi when it sank about 38 nautical miles off Kerala early Sunday. All 24 crew members were rescued, India's defense

The vessel went down with 640 containers, including

13 with an unspecified "hazardous cargo" and 12 containing calcium carbide. It also had 84.44 metric tons of diesel and 367.1 metric tons of furnace oil in its tanks.

diesel and 367.1 metric tons of furnace oil in its tanks.

The Kerala chief minister's office on Monday urged people to stay away from some of the containers that began washing ashore. It also advised fishermen not to venture too close to the sunken ship.

Indian Coast Guard on Sunday said it had sent an aircraft with an oil spill detection system to survey the area. It also deployed a ship carrying pollution control equipment to the site of the accident. (AP)

US military shifts messaging in Africa, telling allies to prepare to stand more on their own

TAN TAN, Morocco, May 26, (AP): The US military is backing off its usual talk of good governance and countering insurgencies' underlying causes, instead leaning into a message that its fragile allies in Africa must be ready to stand more on their own.

At African Lion, its largest joint training exercise on the continent, that shift was clear: "We need to be able to get our partners to the level of independent operations," Gen Michael Langley said in an interview with The Associated Press.

"There needs to be some burden sharing," Langley, the US military's top official in Africa, said on Friday, the final day of the exercise.

For four weeks, troops from more than 40 countries rehearsed how to confront threats by air, land, and sea. They flew drones, simulated close-quarters combat and launched satelliteguided rockets in the desert.

Maneuvers mirrored previous editions of African Lion, now in its 21st year. But mostly gone now is language that emphasizes ideas the U.S. once argued set it apart from Russia and China

China.

Messaging about the interwoven work of defense, diplomacy and development once formed the core of Washington's security pitch. In their place now are calls for helping allies build capacity to manage their own security, which Langley said was a priority for President Donald Trump's Defense

"We have our set priorities now protecting the homeland. And we're

also looking for other countries to contribute to some of these global instability areas," he said, referencing U.S. support for Sudan.

The shift comes as the US military makes moves to "build a leaner, more lethal force," including potentially cutting military leadership positions in places like Africa, where America's rivals continue to deepen their influence.

China has launched its own expansive training program for African militaries. Russian mercenaries are recalibrating and cementing their role as security partner of choice throughout

North, West and Central Africa. In an interview a year ago, Langley emphasized what US military officials have long called a "whole of government approach" to countering insurgency. Even amid setbacks, he defended the U.S. approach and said force alone couldn't stabilize weak states and protect US interests against the risk of violence spilling out. "I've always professed that AFRI-

"I've always professed that AFRI-COM is not just a military organization," Langley said last year. He called good governance an "enduring solution to a number of layered threats whether it be desertification, whether it be crop failure from changing environments, or whether it be from violent extremist organizations."

CAIRO, May 26: National Bank of Kuwait - Egypt (NBK-Egypt) has reported net profits of EGP 2 billion (Equivalent to KWD 12.6 million) for the first three months of 2025, from the EGP 1.3 billion (Equivalent to KWD 11.7 million) reported in the corresponding period of 2024, showcasing an impressive growth rate of 58%

Net Operating Income stood at EGP 3.8 billion in 1Q2025, recording an increase of 38% from EGP 2.8 billion recorded in the corresponding period of 2024. In the meantime, Net Interest Income grew by 41%, reaching EGP 3.3 billion compared to EGP 2.4 billion in 1Q2024.

Meanwhile, Net Operating Income (excluding interests) increased to EGP 0.5 billion in 1Q2025, compared to EGP 0.4billion in 1Q2024, up by 20%, while Cost to Net Operating Income dropped from 26% in 1Q2024 to 25%

Total assets reached EGP 203 billion by the end of 1Q2025, up by 4% compared to EGP 196 billion by the end of 2024. Furthermore, total loans and credit facilities expanded to EGP 109 billion in 1Q2025, reflecting a growth rate of around 5% compared to EGP 104 billion recorded at the end of 2024. Additionally, customer deposits increased to EGP 164 billion by the end of 1Q2025, up from EGP 160 billion at the end of 2024, representing a growth rate of 3%. Furthermore, The Return on Average Assets (ROAA) improved to 4.1% in 1Q2025, compared to 3.6% in the corresponding period of 2024, while the Return on Average Equity (ROAE) increased to 35.8% in 1Q2025, up from 33.6% in the corresponding period of 2024.

Net interest income witnesses first q-o-q decline in eight quarters

CC banking sector bottom-line growth remained steady during Q1-2025 witnessing a q-o-q growth of 7.1% and a y-o-y growth of 8.6% to reach USD 15.6 Bn during the quarter, a new record high for the sector. The increase came despite a decline in net interest income during the quarter and was mainly led by higher non-interest income, lower operating expenses as well as a sharp seasonal decline in impairments during the quarter. The decline in net interest income reflected the impact of rate cuts during the second half of 2024 with aggregate yield on credit for the GCC banking sector falling by 5 bps to 4.16% in Q1-2025 as compared to 4.21% in Q4-2024.

At the country level, the q-o-q growth remained largely positive with five out of six country aggregates showing a sequential growth in net income while the aggregate for the Kuwaiti banking sector showed a marginal decline. UAElisted banks showed the biggest absolute growth in net profits with an increase of USD 639.6 Mn or 11.8% followed by Saudi and Bahraini banks with growth of USD 338.4 Mn and USD 72.6 Mn, respectively. The y-o-y growth in net income was also mixed with Qatar and Kuwaiti listed banks showing declines while Saudi Arabian banks showed double digit growth of 17.2%

In terms of topline performance, aggregate banking sector revenues reached a new record high during the quarter at USD 34.6 Bn, although the growth was the smallest in four quarters at 0.04%. The flattish growth was led by a decline in revenues reported by banks in Kuwait and Oman that almost fully offset the increase in revenues registered in other GCC countries. Qatari banks posted the biggest increase in revenues with a q-o-q gain of 2.1% followed by Saudi and UAE-listed banks with distinctly smaller growths of 1.6% and 0.6%, respectively.

Lending growth remained resilient during the quarter, with net loans registering a sequential growth of 4.1% in Q1-2025, the highest in 15 months, to reach USD 2.2 Trillion. The growth reflected resilient non-oil sector growth in the region with non-oil manufacturing consistently well above the growth mark for key economies in the region. Gross loans also showed a healthy growth of 3.6% during

Highlights - GCC Banking Sector

This report analyzes the financials reported by56listed banks in the GCC for the quarter ended Q1-2025. Data for individual banks have been aggregated to the country level. Some of the key observations from the most recent financial quarter for the GCC Banking Sector includes the following:

Resilient growth in lending by listed GCC banks... Aggregate lending by listed banks in the GCC continued to show q-o-q growth during Q1-2025, backed by growth in all GCC markets, barring Kuwait that registered a marginal decline during the quarter. Aggregate gross loans at the GCC level reached a new record high of USD 2.25 Trillion, recording the highest q-o-q growth in 15 quarters at 3.6% in Q1-2025 vs. 2.4% during the previous quarter. The y-o-y growth continued to remain steady in double digits at 12.5%. Banks in Saudi Arabia reported the biggest q-o-q growth in gross loan in the GCC during Q1-2025mainly led by healthy lending in almost all sectors. Gross loans growth for Saudilisted banks came in at 5.5% or USD 41.9 Bn to reach USD 801.5 Bn during Q1-2025.

UAE and Qatari banks were next with lending growth of USD 20.1 Bn (+3.2% q-o-q) and USD 14.4 Bn (+3.6% q-o-q) represtively with P. P. J. (19.8) 12.1 P. J. (19.8) 13.1 P. J. (o-q), respectively, while Banks in Oman and Bahrain registered marginal increase. Banks in Kuwait registered a marginal decline of 0.5% with gross loans reaching USD 256.9 Bn in Q1-2025. In terms of type of banks, conventional banks in the GCC registered a relatively healthy growth in lending during the quarter with gross loan growth of 4.2% to reach USD 1.6 Trillion while growth in Islamic bank lending came in at 2.4% to reach an outstanding gross loan of USD 677.9Bn at the end of the quarter.

Financial market volatility drives growth in customer

Total customer deposits reported by listed GCC banks reached a new record high level at the end of Q1-2025at USD 2.65 Trillion registering a q-o-q growth of 5.1%. This was one of the biggest quarterly growths recorded in the GCC and was most likely led by volatility in financial markets that led to an increase in flows towards regional banks deposits. The y-o-y growth when compared to Q1-2024 came in at 9.9%. The growth was broad-based as seen in higher q-o-q customer deposits in almost all countries in the GCC. At the country level, UAE-listed banks registered the strongest growth in deposits during the quarter that reached USD 903.8 Bn after a q-o-q growth of 6.7%. Qatari banks were next with a q-o-q growth of 6.1% to reach total customer deposits of USD 438.9 Bn followed by banks in Saudi



Arabia with a growth of 4.8%. Banks in Bahrain, Oman and Kuwait, reported slightly smaller customer deposit growth

Loan-to-deposit ratio declined q-o-q led by higher de-

The aggregate loan-to-deposit ratio for the GCC banking sector remained elevated above the 80% mark at the end of Q1-2025. However, the ratio declined sequentially to reach 81.6% when compared to 82.4% in Q4-2024. The ratio has remained consistently above the 80% mark over the last four quarters and reflects improving asset utilization as well as better margins to offset pressure from lowering interest rates. At the country level, banks in Saudi Arabia reported one of the highest levels of the loan-to-deposit ratio that reached 95.5% during the quarter, registering a growth of 70 bps as compared to Q4-2024. This was also the highest loan-todeposit ratio for the Kingdom when compared to historical levels. Banks in Kuwait also reported a healthy growth in the ratio that reached 76.6%, although it remains relatively low as compared to historical levels in Kuwait. Omani banks also registered a growth of 80 bps with the ratio at the third highest level in the GCC at 88.2%. UAE-listed banks, meanwhile, registered the biggest decline in the ratio with a fall of 220 bps to reach 67.3%, the lowest in the GCC. Qatari banks also registered a sizeable decline of 210 bps with the ratio going below the 90% mark at 89.6%.

A report from Bloomberg highlighted the pressure on increasing deposit growth in the case of Saudi banks given the tight liquidity situation. In the absence of cheaper CASA deposits, the lending growth in the Kingdom can decelerate to around 11%-12% in 2025 as compared to around 14% last year, as per Bloomberg consensus estimates. Banks in the Kingdom continue to benefit from project finance and mortgages, resulting in higher lending to these sectors while corporate overdrafts and trade finance fluctuated over the last few quarters. As per Bloomberg, the share of low-cost CASA deposits declined during Q1-2025 to 52% vs. 54% in Q4-2024 as government related entities as well as private sector shifted cash into interest bearing time deposits. This affected the banking sector's funding cost that remained elevated at 3.83% during Q1-2025, based on our calculations. Meanwhile, data for larger UAE-listed banks showed that they have increased lending in Saudi Arabia in order to support yields and at the same time easing pressure on banks in

Net interest income slides from all-time highs...

Aggregate net interest income reported by banks listed in the GCC declined from the record high levels seen in Q4-2024 registering a fall of 1.7% to reach USD 22.8 Bn during Q1-2025. The q-o-qdecline came after a greater share of lending was subject to lower interest rates implemented during the 2H-2024. At the country level, the trend remained mixed with four country aggregates showing declines in net

interest income while Saudi Arabia and Oatar continued to show growth. Saudi-listed banks showed a net interest income growth of 1.9% during Q1-2025 to reach USD 7.9 Bn followed by 0.8% growth recorded by Qatari banks reaching USD 3.5 Bn. The quarter also reflected a full 100 bps cut in interest rates implemented by almost all banks in the GCC by the end of the year, barring the Central Bank of Kuwait that slashed the discount rate by 25 bps during the year. The yield on credit also showed the impact of lower interest rates reaching 4.16% for the aggregate GCC banking sector at the end of Q1-2025 as compared to 4.21% at the end of 2024. Non-interest income drives quarterly revenue growth

After registering a healthy growth in revenues during the previous quarter, the sequential growth in total bank revenues for the GCC banking sector was flattish with a marginal growth of 0.04%, reaching USD 34.6 Bn during Q1-2025. The marginal increase was led by a mixed trend at the country level, with Kuwait and Oman registering declines that was more than offset by higher total revenues registered in rest of the GCC countries. Qatari banks registered the biggest growth in revenues with an increase of 2.1% followed by Saudi and UAE-listed banks with growth of 1.6% and

The flattish growth in total revenues was mainly led by a healthy growth in non-interest income during the quarter that more than offset a decline in net interest income. Noninterest income showed growth for the fourth consecutive quarter, registering an increase of 2.2% to reach SUD 11.8 Bn during Q1-2025. Kuwaiti and Omani banks once again registered a decline in non-interest income that was more than offset by an increase in the rest of the GCC countries. UAE-listed banks recorded the biggest absolute increase in non-interest income with a growth of USD 192.9 Mn or 3.9% to reach USD 5.2 Bn, the highest in the GCC. Qatari and Saudi listed banks were next with growth of 5.2% and

1.4%, respectively.

Impairments decline by a third during Q1... After showing increases for two consecutive quarters, impairments booked by banks in the GCC declined during Q1-2025. Total loan impairments declined by a third during the quarter to reach USD 2.1 Bn as compared to an eight-quarter high level of USD 3.2 Bn during Q4-2024. The decline during Q1-2025 was mainly led by fall in impairments in five out of six countries in the GCC. UAE-listed banks recorded the biggest decline in impairments that fell by two-thirds as few large-cap banks reported reversal of impairments during the quarter. Qatari and Saudi-listed banks also registered decline in impairments, but at a much smaller pace of 18.6% and 11.4%, respectively. On the other hand, Kuwaiti banks booked an increase in impairments during the quarter that reached USD 237.9 Mn in Q1-2025 after increasing by 14.8% vs. Q4-2024.

The steep decline in impairments also helped to lower the cost of risk for the GCC banking sector. The cost of risk (ratio of 12-month provisions vs. average loans) declined to one of the lowest levels in recent quarters to reach 0.45% for the aggregate GCC banking sector vs. 0.47% at the end of O4-2024. The low ratio as compared to historical levels indicates recoveries, strong economic indicators as well as stable asset quality. The ratio was highest in the case of Qatari banks at 0.79% in Q1-2025 followed by Bahraini banks at 0.62%. The ratio was the lowest in the case of Saudi and Kuwaiti banks at 0.30% and 0.32%, respectively, while UAElisted banks showed slightly higher cost of risk of 0.45%. The cost of risk has fallen for Saudi banks after peaking in 2020s led by steady economic growth, and the absence of default on payments to contractors and other sectors.

Operating expenses decline from record highs... Aggregate operating expenses for listed banks in the GCC witnessed a sharp seasonal decline during Q1-2025 after seeing one of the fastest paces of growth during the previous quarter. Total operating expenses for the GCC Banking sector stood at USD 13.6 Bn during Q1-2025with a q-o-q decline of 4.3% and a y-o-y growth of 10.6%. The q-o-q decline was broad-based and was mainly led by lower expenses reported in five out of six country aggregates in the GCC. Banks in UAE reported the biggest q-o-q absolute decline in expenses that dropped by USD 203.5 Mn or 4.0% to reach USD 4.9 Bn, the highest in the GCC. Saudi banks were next with an drop of USD 174.6 Mn or 3.8% to reach USD 4.4 Bn in expenses. Kuwaiti banks also reported a sharp decline of 9.9% or USD 168.9 Mn to reach USD 1.5 Bn in Q1-2025 as compared to USD 1.7 Bn in the previous quarter. Oatari banks, on the other hand, reported an increase in operating expenses by 3.7%.

The decline in operating expenses also resulted in a marginal drop in the cost-to-income ratio for the GCC banking sector by the end of Q1-2025. The ratio declined by 10 bps to reach 40.0% at the end of the quarter as compared to 40.1%during Q4-2024. The decline reflected adrop in the ratio for three of six country aggregates. At the country level, the aggregates for Saudi Arabia and Kuwait showed a decline in the ratio by 20 bps, respectively, while Qatar showed a bigger decline of 70 bps and boasted the lowest ratio at 37.7%

NIM declined led by the impact of rate cuts...

The aggregate net interest margin reported by GCC-listed banks continued to decline during Q1-2025 as a larger share of lending was repriced at the lower interest rates after the rate cuts announced during the second half of last year. The NIM at the GCC level reached 3.10% at the end of Q1-2025 falling marginallywhen compared to 3.14% at the end of Q4-2024. The ratio showed a broad-based decline falling in four out of six countries in the GCC. The ratio for Bahraini and Kuwaiti banks showed marginal increase during the quarter to reach 3.22% and 3.11% at the end of Q1-2025. On the other hand, banks in Qatar, Saudi Arabia, UAE and Oman registered declines.

UAE banks once again ranked first in the GCC in terms of NIMs that reached 3.34% in Q1-2025as compared to 3.39% during Q4-2024. The higher margins as compared to gulf peers reflect ample liquidity that allows UAE banks to capitalize on the tightening interest rate cycle with more modest asset growth. The composition of loan book in the UAE also helped in generating relatively higher NIM as personal loans accounted for close to a quarter of total banking credit facilities in the country.

GCC banking RoE continues to grow...

Aggregate return on equity (RoE) for the GCC banking sector declined marginally q-o-q during Q1-2025 from one of the highest levels recorded during Q4-2024. Aggregate RoE reached 13.6% during Q1-2025 as compared to 13.7% recorded during the previous quarter. The marginal decline in the ratio reflected a fall in the case of four out of six country aggregates in the GCC. Banks in Kuwait, Qatar, UAE and Oman recorded a slight decline in the ratio during Q1-2025 while Bahrain and Saudi-listed banks showed marginal improvements. Total shareholder equity reached USD 453.0 Bn at the end of Q1-2025, registering a growth of 0.8% as compared to Q4-2024.

At the country level, UAE-listed banks once again topped in the region with the highest RoE at the end of Q1-2025 at 16.6%, although it declined slightly by 10bps for the second consecutive quarter. Saudi-listed banks were next with an RoE of 13.0%, registering a quarterly increase of 10bps followed by Qatari banks with an RoE of 12.7% recording a decline of 30 bps from the previous quarter. The biggest y-o-y growth in RoE was also seen for Bahraini banks at 20 bps reaching 9.9%. ROEs for Kuwaiti banks stayed elevated at a double-digit level of 10.6%.

Euro shares gain as Trump pushes back planned 50 pct tariffs on EU

Germany's DAX added 1.7% to 24,020.48

HONG KONG, May 26, (AP): European shares have opened higher and U.S. futures also surged after U.S. President Donald Trump said he would delay a threatened 50% tariff on goods from the European Union to July 9.

Oil prices rose while Asian shares were mostly lower.

Trump announced the decision to push back the higher import duties after a call Sunday with Ursula von der Leyen, the president of the European Commission, who said she "wants to get down to serious negotiations," according to the U.S. president's retelling.

Last week, Trump said on social media that trade talks with the European Union "were going nowhere" and that "straight 50%" tariffs could go into effect on June 1.

The future for the S&P 500 gained 1.3% while that for the Dow Jones Industrial Average advanced 1.1%. Germany's DAX added 1.7% to 24,020.48 and the CAC 40 in Paris was 1.3% higher to 7,830.99.

Markets were closed in Britain for

In Asian trading, Tokyo's Nikkei 225 climbed 1% to 37,531.53, while the Kospi in Seoul picked up 2% to 2,644.40.

But most other regional markets declined.

Hong Kong's Hang Seng lost 1.4% to 23,282.33 and the Shanghai Composite Index fell 0.1% to 3 346.84

Australia's S&P/ASX 200 was

ers weighed whether Trump's latest threats were just negotiating tactics. The S&P 500 lost 0.7% to end

The S&P 500 lost 0.7% to end its worst week in the last seven. The Dow Jones Industrial Average dropped 0.6% and the Nasdaq composite sank 1%.

Apple dropped 3% and was the heaviest weight on the S&P 500 after Trump said he's been pushing Apple CEO Tim Cook to move production of iPhones to the United States. He warned a tariff "of at least 25% must be paid by Apple to the U.S." if it doesn't.

Trump later clarified his post to say that all smart phones made abroad would be taxed and the tariffs could be coming as soon as the

end of June.

"It would be also Samsung and anybody that makes that product," Trump said. "Otherwise, it wouldn't be fair."

Trump has been criticizing companies individually when he's frustrated with how they're acting because of his tariffs and because of the uncertainty his trade war has created. He earlier told Walmart it should "eat the tariffs," along with China, after the retailer said it would likely have to raise prices to cover the increased cost of imports.

Deckers Outdoor, the company behind the Hoka and Uggs brands, became one of the latest companies to say all the uncertainty around the economy means it won't offer financial forecasts for the full upcoming year.

Its stock shed 19.9%, even though

the company reported a stronger profit and revenue for the latest quarter than expected.

Ross Stores fell 9.8% after it pulled its financial forecasts for the full year, citing how more than half the goods it sells originate in China.

On the winning side of Wall Street was Intuit, which rose 8.1% after the company behind TurboTax and Credit Karma reported a stronger profit for the latest quarter than analysts expected.

Stocks in the nuclear industry also rallied after Trump signed executive orders to speed up nuclear licensing decisions, among other measures meant to charge up the industry. Oklo, which is developing fast fission power plants, jumped 23%.

Trump's latest tariff threats stirred up Wall Street after it had recovered most of the losses it had earlier taken because of the trade war. The S&P 500 dropped roughly 20% below its record at one point last month, when worries were at their height about whether Trump's stiff tariffs would cause a global recession. The index then climbed back within 3% of its all-time high after Trump paused his tariffs on many countries, most notably China.

In other trading early Monday, U.S. benchmark crude oil gained 43 cents to \$61.96 per barrel. Brent crude, the international standard, added 40 cents to \$64.61 per barrel.

The U.S. dollar advanced to 142.81 Japanese yen from 142.48 yen. The euro edged higher, to \$1.1388 from \$1.1367.

Europe is ready to advance talks...

Trump says he'll delay 50% tariff on the EU until July

WASHINGTON, May 26, (AP): President Donald Trump said that the U.S. will delay implementation of a 50% tariff on goods from the European Union from June 1 until July 9 to buy time for negotiations with the bloc.

That agreement came after a call Sunday with Ursula von der Leyen, the president of the European Commission, who had told Trump that she "wants to get down to serious negotiations," according to the U.S. president's retelling

"I told anybody that would listen, they have to do that," Trump told reporters on Sunday in Morristown, New Jersey, as he prepared to return to Washington. Von der Leyen, Trump said, vowed to "rapidly get together and see if we can work something out."

In a social media post Friday,

Trump had threatened to impose the 50% tariff on EU goods, complaining that the 27-member bloc had been "very difficult to deal with" on trade and that negotiations were "going nowhere." Those tariffs would have kicked in starting June 1.

But the call with von der Leyen appeared to smooth over tensions, at least for now.

"I agreed to the extension - July 9, 2025 - It was my privilege to do so," Trump said on Truth Social shortly after he spoke with reporters on Sunday evening.

For her part, von der Leyen said the EU and the U.S. "share the world's most consequential and close trade relationship." "Europe is ready to advance

talks swiftly and decisively," she said. "To reach a good deal, we would need the time until July 9."

Sri Lanka and New Zealand discuss ways to deepen ties

COLOMBO, Sri Lanka, May 26, (AP): Debt-stricken Sri Lanka hosted one of New Zealand's top ministers to discuss ways to deepen bilateral ties in areas such as trade, tourism and agriculture.

Winston Peters, New Zealand's deputy prime minister and foreign affairs minister, met Sri Lanka Foreign Affairs Minister Vijitha Herath in the capital Colombo on Monday. The five-day visit by Peters is scheduled to continue until Wednesday.

The visit comes as Sri Lanka struggles to emerge from its worst economic crisis, which began in the Indian Ocean island nation three years ago.

The countries have improved relations in recent years, establishing a New Zealand embassy in Colombo in 2021 and a Sri Lankan embassy in Wellington this year.

The discussion Monday focused on advancing ties in trade, investment, agriculture, education and tourism, Herath said.

"We also explored expanding trade links in high-potential sectors such as diary, processed food, fresh produce and discussed improving market access for Sri Lankan products," Herath told reporters.

He commended New Zealand's support in developing Sri Lanka's dairy industry, saying it had a "transformational impact on rural livelihood."

Sri Lanka has embarked on an effort to expand and modernize its domestic diary industry in recent years, but still produces only about 40% of the country's demand for milk and dairy products, while the balance is imported.

New Zealand is a key supplier of those dairy products, especially

milk powder. In 2024, New Zealand exported \$335 million in goods to Sri Lanka, with dairy products forming the bulk.

Trade balance between the nations favors New Zealand, which in 2024 imported goods worth \$64 million from Sri Lanka including tea, coffee, apparel and rubber products.

The discussion included reducing red tape at the border and how to "increase Sri Lanka's market access capabilities," Peters said.

"We discussed the growing number of New Zealand companies working with and investing in Sri Lanka or looking to work with Sri Lankan partners," said Peters, adding that those collaborations will benefit Sri Lanka's tourism, agriculture and healthcare sectors.

Sri Lanka declared bankruptcy in April 2022 with more than \$83 billion in debt, more than half to foreign creditors. It sought the help of the International Monetary Fund, which approved a \$2.9 billion, four-year bailout package in 2023 under which Sri Lanka was required to restructure its debt.

In September last year, Sri Lanka said it had concluded the debt restructuring process after reaching agreements with bilateral and multilateral creditors and private bondholders. Sri Lanka is seeking to obtain \$17 billion in debt service relief.

Sri Lanka's crisis was largely the result of economic mismanagement combined with fallout from the CO-VID-19 pandemic, along with 2019 terrorism attacks that devastated its important tourism industry. The pandemic also disrupted the flow of remittances from Sri Lankans working abroad.

Powell defends Fed in Princeton speech amid onslaught of attacks from Trump

WASHINGTON, May 26, (AP): Federal Reserve Chair Jerome Powell defended the central bank's response to the COVID-19 pandemic Sunday in a Princeton University speech in which he also praised government employees and U.S. universities, both of which have been targeted by the Trump administration.

Powell and the central bank have been subject to extensive criticism in recent weeks by President Donald Trump and a potential successor, former Fed governor Kevin Warsh.

Speaking at a baccalaureate service ahead of Tuesday's commencement, Powell, who noted he graduated from Princeton 50 years ago, specifically defended the central bank's decision to cut its key interest rate to nearly zero in response to the pandemic. It also launched an asset-purchase program that involved buying trillions of dollars of Treasury bonds and mortgage-backed securities,

intended to keep longer-term interest rates low.

terest rates low.

"With little warning, economies around the world came to a hard stop," Powell said, referring to the pandemic. "The possibility of a long, severe, global depression

the pandemic. "The possibility of a long, severe, global depression was staring us in the face. Everyone turned to the government, and to the Federal Reserve in particular as a key first responder." Powell also singled out longtime government employees for praise:

"Career civil servants at the Fed

who are veterans of previous cri-

ses stepped forward and said, 'We got this,'" he said.

Trump has subjected Powell to a stream of attacks for several months because the Fed has kept its key rate unchanged this year, after cutting it three times at the end of 2024. Trump has said there is "no inflation" so the Fed should

reduce borrowing costs.

Earlier this month, Trump called Powell a "fool" for not cutting rates and last week called the Fed

chair "Too Late Powell."

Powell has not response

Powell has not responded to Trump's attacks, which has previously won him support among Republicans on Capitol Hill.

In his Sunday speech, he defended American universities, which have come under sharp attacks from the Trump administration as research grants and other funding have been cut for several Ivy League universities, including Princeton.

"Our great universities are the envy of the world and a crucial national asset," Powell said. "Look around you. I urge you to take none of this for granted."

Late last month, Warsh, who served as one of the Fed's governors from 2006 to 2011, slammed the central bank for letting inflation spike to its highest level in four decades in 2022. Warsh is considered a leading candidate to become the next Fed chair when Powell's term ends in May 2026.

"Each time the Fed jumps into

"Through the joint efforts of

many, we avoided the worst outcomes," Powell said. "It is hard to imagine the pressure people face at a time like that. Their collective efforts saved our economy, and the career civil servants involved deserve our respect and gratitude; it is my great honor to serve along-side them."

Oddball duo captivates viewers in surprise hit

'Lilo & Stitch' joins Cruise for monster Memorial Day weekend

LOS ANGELES, May 26, (AP): "Lilo & Stitch" teamed with Tom Cruise for a monster Memorial Day box office weekend.

Disney's live action version of "Lilo & Stitch" earned a staggering \$145.5 million in North American theaters, according to studio estimates Sunday, the second biggest domestic opening of the year after "A Minecraft Movie."

The movie is a faithful remake of the 2002 original's story of a sixlegged alien and a Hawaiian girl that has created a big cult following in the decades since. But the duo was no little brother and sister to the better-known figures in Disney's parade of live-action remakes. It was second only to the \$185 million opening of "The Lion King" in 2019 and outshot all projections, wowing box of-

"This overperformed by a huge

margin," said Paul Dergarabedian, senior media analyst for Comscore.

"Lilo & Stitch" surpassed Cruise's 2022 "Top Gun: Maverick" as the biggest domestic Memorial Day weekend earner ever, and global estimates put it past \$300 million.

Paramount Pictures' "Mission: Impossible - The Final Reckoning," the eighth and (probably) last appearance of Cruise as Ethan Hunt in a nearly three-decade run, was a distant second, but still brought in a franchise record \$63 million through Sunday, outearning "Mission: Impossible - Fallout," which opened domestically to \$61 million

And the spy thriller with Cruise's frequent partner Christopher Mc-Quarrie in the director's chair for the fourth time in the franchise was the

top global earner with \$127 million. Cruise has been a relentless global

promoter of his movies, and he's been the industry's loudest cheerleader for going to theaters. This film, like its predecessor in the series, premiered at the Cannes Film

"The spectacle of what Tom and McQ put on the screen, it screams theatrical," said Chris Aronson, Paramount's president of domestic distribution. "The product they put out just screams, 'This has to be in

The previous film, 2023's "Mission: Impossible - Dead Reckoning Part One" launched with a franchisebest \$80 million over five days in a July opening, though it came in shy of industry expectations with a \$56.2 million haul over a three-day week-

This weekend as a whole blasted past last year, when the Memorial Day box office saw just \$132 million for all films in the Fridaythrough-Monday span. And it appears that it will top 2013 as the best Memorial Day the industry has had, with an estimated overall total of \$325 million.

Critics were wearying of Disney's live action and CGI remakes of its animated classics. Mark Kennedy of The Associated Press called this "Lilo & Stitch" "utterly unnecessary." There were signs audiences were agreeing. "Snow White" opened to a sleepy \$43 million in March, and several similar releases were tepid.

But this film tapped into a latent love for oddball pairing.

It also furthered a trend that includes "A Minecraft Movie" of PG-rated films outpacing the PG-13 movies that usually dominate, made all the more impressive by the lower kids' ticket prices the more familyoriented films bring.

Dergarabedian credits a strong lead-up of films that have put people in theaters and remain the box office top 10, including "Minecraft," "Sinners," "Thunderbolts" and "Final Destination: Bloodlines."

"I can't think of a better lineup of films to ignite leading up to Memorial weekend to ignite the spark that got us this record-breaking holiday frame," he said.

Action triumphs over storytelling

Cruise goes for broke in 'The Final Reckoning'

LOS ANGELES, May 26, (AP): Tom Cruise's Ethan Hunt is getting a bit of a savior complex. It's not exactly his fault after defying death and completing impossible missions time and time again. But in "Mission: Impossible - The Final Reckoning," there's a breathlessness to the naive trust from his growing band of disciples, including the US president (the formerly skeptical Erika Sloane of "Fallout," played by Angela Bassett), and Paris (Pom Klementieff), the once delightfully fun maniac assassin who has been reduced to brooding French philosopher. In a series that has often been best when it's not taking itself too seriously, these dour developments start to feel a little unintentionally silly. And, for at least the first hour, it's all we have to hang onto.

Perhaps this is part of the point in pitting a human man against a parasitic artificial intelligence set on inciting nuclear extinction, something we're meant to believe has been brewing in some way since the beginning of the franchise. You can almost see the behindthe-scenes wheels turning: Gravity is kind of a prerequisite when this much is on the line, and when so much pain has been taken to link 30 years and seven movies that were certainly never meant to

be connected by anything other than Ethan Hunt. But we don't come to "Mission: Impossible" movies for the bigger picture, and definitely not to learn what the rabbit's foot was in the third movie. We come to be awed by the thrills and Cruise's execution, whether he's speeding through Paris on a motorbike, driving one-handed through Rome in a tiny old Fiat, or hanging on the outside of an airbus, or bullet train, or helicopter, or the Burj

And unlike, say, the "Fast & Furious" movies, which long ago jumped the shark, the "Mission" stunts have always felt grounded in some reality and playfulness. It's not just Cruise's willingness to tether himself to all forms of high-speed transportation for our enjoyment. His reactions - surprise, panic, doubt - are unparalleled. Ethan Hunt is never too cool to look unsure.

"Final Reckoning," Christopher McQuarrie's fourth "Mission" movie in the director's chair, does deliver two truly unforgettable sequences. One is in a long-defunct submarine at the bottom of the sea that will have you squirming; another involves two classic biplanes careening at 170 miles per hour (274 kilometers per hour) over lush South African landscapes. Though they may induce vertigo on IMAX, these are the things that make the trip to the theater worth it. But be warned: It takes a good long while of labored exposition, manic flashbacks and Oscar broadcast-ready greatest-hits montages to get there.

Script

McQuarrie, who co-wrote the script with Erik Jendresen, might have learned the wrong lessons from the past decade of overly interconnected franchise filmmaking. Or perhaps it still seemed like the right call when this two-part finale was put into motion seven years ago. Not only does realizing one previously enjoyable character is related to and motivated by a character from the past do little to raise the stakes, it also bogs everything down.

"Final Reckoning" also overstuffs the cast with faces that are almost distracting (like Hannah Waddingham as a US Navy officer, though her American accent is quite good). Maybe it's overcompensating for the movie's flesh-and-bone villain Gabriel (Esai Morales), who seems to be there because Ethan needs someone to

There are some fun additions to the lot: "Severance's" Tramell Tillman as a submarine captain, as well as Lucy Tulugarjuk and Rolf Saxon, for anyone wondering what became of the poor guy in the Langley vault.

Simon Pegg, as the capably flustered tech wiz Benji, is still great, Ving Rhames gets to flex emotionally, and Bassett really makes you believe she's chosen a US city to destroy as an offering to "The Entity." But many get lost in the unnatural, one-size-fits-all dialogue, which is especially true in the bizarrely sweaty Situation Room where everyone is always finishing each other's sentences.

Maybe when you have a larger-than-life movie star, you need larger-than-life character actors. Besides, everyone knows they're there as side players supporting the Cruise show - no one more so than Hayley Atwell as Grace, the once inscrutable pickpocket turned wide-eyed Madonna supporting and tending to Ethan. The loss of Rebecca Ferguson is acutely felt here.

The "Mission: Impossible" movies, even when they're mediocre, remain some of the most effortlessly enjoyable cinematic experiences out there, a pure expression of "let's put on a show." There's nothing else quite like it and maybe they've earned this self-important victory lap, though it seems to have gone to the characters'

Saving the showstopper for last will certainly leave audiences exiting the theater on a happy high note. But it's hard to shake the feeling that in attempting to tie everything together, "Mission: Impossible" lost the plot.

"Mission: Impossible: The Final Reckoning," a Paramount Pictures released in theaters last Friday, is rated PG-13 by the Motion Picture Association for "bloody images, action, brief language, and sequences of strong violence." Running time: 179 minutes. Two and a half stars out of four.

'You attain a level of mastery'

Spelling Bee champs say it set them up for success

NEW YORK, May 26, (AP): Joanne Lagatta arrived at the University of Wisconsin in 1995 with a flawless academic record and an achievement on her resumé that she didn't like to talk about - but that no other undergrad on the sprawling Madison campus could claim: Scripps National Spelling Bee champion.

The bee winner in 1991 at age 13, Lagatta nonetheless struggled adjusting to life outside her rural hometown of Clintonville, Wisconsin - until she got a push from a professor who was a devoted spelling-bee fan.

"I went in thinking I was a smart kid who had won a National Spelling Bee, and I must be able to compete with the highest-level academic kids. I signed up for a bunch of advanced classes I clearly had no place being in. I thought I was going to fail my chemistry class," Lagatta says. "I went to my professor. He stared me down and said, 'I know who you are. I know what you're capable of. You are not failing my class.' He pushed me through that class. I certainly didn't get an A, but I didn't

Lagatta, now 47, turned out fine. She's a neonatologist at Children's Wisconsin, a hospital in Milwaukee. And like many former champions of the National Spelling Bee - which celebrates its 100th anniversary when it starts Tuesday at a convention center outside Washington - she says the competition changed her life for the better because it taught her she could do

Winners of the spelling bee aren't celebrities,

exactly. Those who competed before it was televised by ESPN - it now airs on Scripps-owned ION - aren't often recognized by strangers. But they have to accept being known forever for something they accomplished in middle school. Google any past bee champion, and it's one of the first things that pops up.

Many past champions have remained involved

with the bee. Jacques Bailly, the 1980 champion, is the bee's longtime pronouncer. Paige Kimble, who won a year later, ran the bee as executive director from 1996-2020. Vanya Shivashankar, the 2015 co-champ, returns each spring as master of ceremonies, and her older sister, Kavya, is one of several former champs on the panel that selects words for the competition.

Even for those former champs who've moved on entirely, the competition has remained a cornerstone of their lives. The Associated Press spoke to seven champs about their membership in this exclusive club.

Anamika Veeramani, the 2010 champion, graduated from Yale in three years and got her medical degree at Harvard. A resident in plastic and reconstructive surgery at Johns Hopkins Hospital in Baltimore, she is training to become a craniofacial surgeon, and the focused and disciplined approach that led her to the spelling bee title has been a throughline in her life since.

"You attain a level of mastery over a subject that you wouldn't have otherwise, and that feeling of mastery is very similar across fields," the 29-year-old Veeramani says. "Once you know a subject well enough, you're able to really just play with that subject and and come up with things, and there's just a joy and delight in what you're doing. ... I'm going to spend the rest of my career in surgery chasing that.'

Molly Baker was never uncomfortable about her past as the 1982 spelling-bee champion, and in the right context, she's happy to bring it up - as an icebreaker or a standout line on her resumé.

"Oh, I was never cool," Baker says. "I knew people who were state tennis champs, and they were, you know, in their own way equally as nerdy. I would always joke about it, that I was queen of the dorks.'

Baker, 55, worked as a staff writer at the Wall Street Journal and wrote a book, "High Flying Adventures in the Stock Market." She's now a freelance journalist, and she says there's no question her spelling bee title helped her career.

"One summer in college I was an intern at, it was called 'Real Life with Jane Pauley.' It was an evening magazine TV news show," Baker says. "And that, I'm sure, was partly a result of having been interviewed on the 'Today' show by Jane Pauley in 1982. I was not shy about saying that when I applied."

Jon Pennington knew he was socially awkward when he won the bee in 1986. He even wore his mother's bulky sunglasses on the bee stage because the bright lights bothered him.

When he was 40, he was diagnosed with autism, a condition he proudly embraces.

"I did not win the National Spelling Bee in spite of my autism. I did not win the National Spelling Bee by triumphing over my autism. I won the National Spelling Bee because of my autism," the 53-year-old Pennington says. "For me, it almost felt like if you hear a chord played on a piano but there's a dissonant note in that chord, that's what it felt like when you came across a misspelling."

Pennington, who lives in Minneapolis with his wife and dog, worked for years in corporate human resources and is now working as a writer, collaborating on an as-yet unpublished biography of songwriter Eden Ahbez.

'A trailblazer'

Feminist, author **Brownmiller dies**

NEW YORK, May 26, (AP): Susan Brownmiller, a prominent feminist and author of the 1960s and '70s whose "Against Our Will" was a landmark and intensely debated bestseller about sexual assault, has died. She was

Brownmiller, who had been ill, died Saturday at a New York hospital, according to Emily Jane Goodman, a retired New York State Supreme Court justice and

practicing attorney who serves as the executor of Brown miller's

Α nalist, anti-wa protester and civil

rights ac-

tivist before joining the "second wave" feminist movement in its formative years, Brownmiller was among many women who were radicalized in the '60s and 70s and part of the smaller circle that included Gloria Steinem, Betty Friedan and Kate Millett who radicalized others.

While activists of the early 20th century focused on voting rights, the second wave feminism transformed conversations about sex, marriage reproductive rights, workplace harassment and domestic violence. Brownmiller, as much as anyone, opened up the discussion of rape. "Against Our Will: Men, Women and Rape,' published in 1975 and widely read and taught for decades after, documented the roots, prevalence and politics of rape - in war and in prison, against children and spouses. She denounced the glorification of rape in popular culture, contended that rape was an act of violence, not lust, and traced rape to the very foundations of human history.

Memoir

"Man's structural capacity to rape and woman's corresponding structural vulnerability are as basic to the physiology of both our sexes as the primal act of sex itself," she wrote.

In her 1999 memoir "In Our Time," Brownmiller likened the writing of "Against Our Will" to "shooting an arrow into a bullseye in very slow motion." Brownmiller started the book in the early 1970s after hearing stories from friends that made her shriek "with dismay." It was chosen as a main selection of the Book-ofthe-Month Club and considered newsworthy enough for Brownmiller to be interviewed on the "Today" show by Barbara Walters. In 1976, Time magazine placed her picture on its cover, along with Billie Jean King, Betty Ford and nine others as "Women

Brownmiller's book inspired survivors to tell their stories, women to organize rape crisis centers and helped lead to the passage of marital rape laws. It was also received with fear, confusion and anger. Brownmiller remembered a newspaper reporter shouting at her, "You have no right to disturb my mind

Brownmiller was also faulted for writing that rape was an assertion of power that helped all men and was strongly criticized for a chapter titled "A Question of Race," in which she revisited the 1955 murder in Mississippi of Black teen Emmett Till. Brownmiller condemned his gruesome death at the hands of a white mob but also blamed Till for the alleged incident that led to his death: whistling at Bryant's wife, Carolyn Bryant.

From custom prosthetics to personalized drugs

How 3D printing changing the future of health care

Three-dimensional printing is transforming medical care, letting the health care field shift from mass-produced solutions to customized treatments tailored to each patient's needs. For instance, researchers are developing 3D-printed prosthetic hands specifically designed for children, made with lightweight materials and adaptable control systems.

These continuing advancements in 3D-printed prosthetics demonstrate their increasing affordability and accessibility. Success stories like this one in personalized prosthetics highlight the benefits of 3D printing, in which a model of an object produced with computer-aided design software is transferred to a 3D printer and constructed layer by layer.

We are a biomedical engineer and chemist who work with 3D printing. We study how this rapidly evolving technology provides new options not just for prosthetics but for implants, surgical planning, drug manufacturing and other health care needs. The ability of 3D printing to make precisely shaped objects in a wide range of materials has led to, for example, custom replacement joints and custom-dosage, multidrug pills.

Three-dimensional printing in health care started in the 1980s with scientists using technologies such as stereo-lithography to create prototypes layer by layer. Stereolithography uses a computer-controlled laser beam to solidify a liquid material into specific 3D shapes. The medical field quickly saw the potential of this technology to create implants and prosthetics designed specifically for each patient.

One of the first applications was creating tissue scaffolds, which are structures that support cell growth. Researchers at Boston Children's Hospital combined these scaffolds with patients' own cells to build replacement bladders. The patients remained healthy for years after receiving their implants, demonstrating that 3D-printed structures could become durable body parts.

As technology progressed, the focus shifted to bioprinting, which uses living cells to create working anatomical structures. In 2013, Organovo created the world's first 3D-bioprinted liver tissue, opening up exciting possibilities for creating organs and tissues for transplantation. But while significant advances have been made in bioprinting, creating full, functional organs such as livers for transplantation remains experimental. Current research focuses on developing smaller, simpler tissues and refining bioprinting techniques to improve cell viability and functionality. These efforts aim to bridge the gap between laboratory success and clinical application, with the ultimate goal of providing viable organ replacements for patients in need.

Three-dimensional printing already has revolutionized

the creation of prosthetics. It allows prosthetics makers to produce affordable custom-made devices that fit the patient perfectly. They can tailor prosthetic hands and limbs to each individual and easily replace them as a child grows.

Three-dimensionally printed implants, such as hip replacements and spine implants, offer a more precise fit, which can improve how well they integrate with the body. Traditional implants often come only in standard shapes and sizes

Some patients have received custom titanium facial implants after accidents. Others had portions of their skulls replaced with 3D-printed implants.

Additionally, 3D printing is making significant strides in dentistry. Companies such as Invisalign use 3D printing to create custom-fit aligners for teeth straightening, demonstrating the ability to personalize dental care.

Scientists are also exploring new materials for 3D printing, such as self-healing bioglass that might replace damaged cartilage. Moreover, researchers are developing 4D printing, which creates objects that can change shape over time, potentially leading to medical devices that can adapt to the body's needs.

For example, researchers are working on 3D-printed stents that can respond to changes in blood flow. These stents are designed to expand or contract as needed, reducing the risk of blockage and improving long-term patient outcomes.

Three-dimensionally printed anatomical models often help surgeons understand complex cases and improve surgical outcomes. These models, created from medical images such as X-rays and CT scans, allow surgeons to practice procedures before operating

cedures before operating.

For instance, a 3D-printed model of a child's heart enables surgeons to simulate complex surgeries. This approach can lead to shorter operating times, fewer complications and

In the pharmaceutical industry, drugmakers can threedimensionally print personalized drug dosages and delivery systems. The ability to precisely layer each component of a drug means that they can make medicines with the exact dose needed for each patient. The 3D-printed anti-epileptic drug Spritam was approved by the Food and Drug Administration in 2015 to deliver very high dosages of its active

Drug production systems that use 3D printing are finding homes outside pharmaceutical factories. The drugs potentially can be made and delivered by community pharmacies. Hospitals are starting to use 3D printing to make medicine on-site, allowing for personalized treatment plans based on factors such as the patient's age and health.

However, it's important to note that regulations for 3D-printed drugs are still being developed. One concern is that postprinting processing may affect the stability of drug ingredients. It's also important to establish clear guidelines and decide where 3D printing should take place - whether in pharmacies, hospitals or even at home. Additionally, pharmacists will need rigorous training in these new systems. (AP)

'It's like a suicide'

Haitians with HIV protest USAID cuts, med shortage

PORT-AU-PRINCE, Haiti, May 26, (AP): A video showing dozens of people marching toward the office of Haiti's prime minister elicited gasps from some viewers as it circulated recently on social media. The protesters, who were HIV positive, did not conceal their faces - a rare occurrence in a country where the virus is still heavily stigmatized.

"Call the minister of health! We are dying!" the group chanted.

The protesters risked being shunned by society to warn that Haiti is running out of HIV medication just months after the administration of U.S. President Donald Trump slashed more than 90% of USAID's foreign aid contracts and \$60 billion in overall aid across the globe

At a hospital near the northern city of Cap-Haitien, Dr. Eugene Maklin said he struggles to share that reality with his more than 550 HIV patients.

"It's hard to explain to them, to tell them that they're not going to find medication," he said. "It's like a suicide."

More than 150,000 people in Haiti

have HIV or AIDS, according to official estimates, although nonprofits believe the number is much higher.

David Jeune, a 46-year-old hospital community worker, is among them. He became infected 19 years ago after having unprotected sex. "I was scared to let people know because they would point their finger at you, saying you are infecting others with AIDS," he said. His fear was so great that he didn't

tell anyone, not even his mother. But that fear dissipated with the support Jeune said he received from nonprofits. His confidence grew to the point where he participated in Monday's protest. "Those Trump will change his mind"

"I hope Trump will change his mind," he said, noting that his medication will run out in November. "Let the poor people get the medication they need."

Patrick Jean Noël, a representative of Haiti's Federation of Associations of HIV, said that at least five clinics, including one that served 2,500 patients, were forced to close after the USAID funding cuts.

"We can't stay silent," he said.
"More people need to come out."
But most people with HIV in Haiti

are reluctant to do so, said Dr. Sabine Lustin, executive director of the Haitibased nonprofit Promoters of Zero AIDS Goal.

The stigma is so strong that many patients are reluctant to pick up their medication in person. Instead, it is sent via packages wrapped as gifts to not arouse suspicion, Lustin said.

Lustin's organization, which helps some 2,000 people across Haiti, receives funding from the U.S. Centers for Disease Control and Prevention. While their funding hasn't been cut, she said that shortly after Trump was sworn in, the agency banned prevention activities because they targeted a group that is not a priority. By that, Lustin said she understood they were referring to gay men.

Foreign universities roll out attractive offers

Scientists hit by job, grant losses in US find new opportunities abroad

NEW YORK, May 26, (AP): As the Trump administration cut billions of dollars in federal funding to scientific research, thousands of scientists in the US lost their jobs or grants - and governments and universities around the world spotted an opportunity.

The "Canada Leads" program, launched in April, hopes to foster the next generation of innovators by bringing early-career biomedical researchers north of the border.

Aix-Marseille University in France started the "Safe Place for Science" program in March - pledging to "welcome" US-based scientists who "may feel threatened or hindered in their research."

Australia's "Global Talent Attraction Program," announced in April, promises competitive salaries and relocation packages.

"In response to what is happening in the US," said Anna-Maria Arabia, head of the Australian Academy of Sciences, "we see an unparalleled opportunity to attract some of the smartest minds here."

Invention

Since World War II, the US has invested huge amounts of money in scientific research conducted at independent universities and federal agencies. That funding helped the U.S. to become the world's leading scientific power - and has led to the invention of cell phones and the internet as well as new ways to treat cancer, heart disease and strokes, noted Holden Thorp, editor-in-chief of the journal Science.

But today that system is being shak-

Since President Donald Trump took office in January, his administration has pointed to what it calls waste and inefficiency in federal science spending and made major cuts to staff levels and grant funding at the National Science Foundation, the National Institutes of Health, NASA and other agencies, as well as slashing research dollars that

flow to some private universities.

The White House budget proposal for next year calls to cut the NIH budget by roughly 40% and the National Science Foundation's by 55%.

"The Trump administration is spending its first few months reviewing the previous administration's projects, identifying waste, and realigning our

research spending to match the American people's priorities and continue our innovative dominance," said White House spokesperson Kush Desai.

Already, several universities have announced hiring freezes, laid off staff or stopped admitting new graduate students. On Thursday, the Trump administration revoked Harvard University's ability to enroll international students, though a judge put that on hold.

Research institutions abroad are watching with concern for collaborations that depend on colleagues in the US - but they also see opportunities to potentially poach talent.

Threats

"There are threats to science ... south of the border," said Brad Wouters, of University Health Network, Canada's leading hospital and medical research center, which launched the "Canada Leads" recruitment drive. "There's a whole pool of talent, a whole cohort that is being affected by this moment."

Universities worldwide are always trying to recruit from one another, just as tech companies and businesses in other fields do. What's unusual about the current moment is that many global recruiters are targeting researchers by promising something that seems newly threatened: academic freedom.

Ursula von der Leyen said this month that the European Union intends "to enshrine freedom of scientific research into law." She spoke at the launch of the bloc's "Choose Europe for Science" - which was in the works before the Trump administration cuts but has sought to capitalize on the moment.

Eric Berton, president of Aix-Mar-

Eric Berton, president of Aix-Marseille University, expressed a similar sentiment after launching the institution's "Safe Place for Science" program.

"Our American research colleagues are not particularly interested by money," he said of applicants. "What they want above all is to be able to continue their research and that their academic freedom be preserved."

It's too early to say how many scientists will choose to leave the US It will take months for universities to review applications and dole out funding, and longer for researchers to uproot their lives.

Plus, the American lead in funding research and development is enormous - and even significant cuts may leave crucial programs standing. The US has been the world's leading funder of R&D - including government, university and private investment - for decades. In 2023, the country funded 29% of the world's R&D, according to the American Association for the Advancement of Science.

China advances rare disease care

HAIKOU, May 26, (Xinhua): At the entrance of the 2025 International Conference on Rare Diseases, visitors are greeted by a poignant painting: a young girl lies in a hospital bed as a nurse approaches with a cart filled with medication. Outside the window, birds soar gracefully against a backdrop of blue sky that stretches endlessly over the open sea.

The artwork is by Liu Xinruo, a Chinese girl with an inherited disorder of bone growth. A small plaque beside her painting notes: "Pseudoachondroplasia. Orthopedic surgeries at age 8 and 15."

Liu's painting offers a quiet but powerful message -- even amid pain and uncertainty, there is strength and resilience. Her story mirrors the experiences of more than 300 million people worldwide living with rare diseases.

From Friday to Sunday, experts from across the globe, including clinicians, researchers, pharmaceutical representatives, policymakers, and patient advocates, convened in Haikou, capital of China's southern island province of Hainan, to discuss the future of rare disease diagnosis and care.

Globally, more than 7,000 rare diseases have been identified, yet only about 5 percent have approved treatments. In China alone, over 20 million people are affected by rare conditions.

Progress

However, progress is now clearly taking shape. As China works to fulfill its pledge of ensuring health for its 1.4 billion people, patients like Liu are starting to experience tangible improvements.

At the conference, Ma Xudong, an official with China's National Health Commission, highlighted a multifaceted strategy that is making significant strides in steadily advancing care for patients with rare diseases. Key measures include the creation of a national rare disease list, expanded insurance coverage, improved clinical guidelines, and accelerated drug development.

China has established a collaborative hospital network covering all provincial-level regions. The network, now comprising 419 hospitals, facilitates case referrals, telemedicine, and data sharing -- helping to reduce the average diagnostic time for rare diseases from four years to less than four weeks, while slashing costs by 90 percent.

Hyderabad beats Kolkata by 110 runs

Bottom side Chennai ends season in style by routing top team Gujarat

AHMEDABAD, India, May 26, (AP): Dewald Brevis scored 57 runs off 23 balls as bottom side Chennai Super Kings wrapped up its Indian Premier League season in style by routing firstplaced Gujarat Titans by 83 runs.

Also, Sunrisers Hyderabad scored 278-3 - the third-highest total in IPL history - and beat Kolkata Knight Riders by 110 runs. Heinrich Klaasen hit an undefeated 105 off 39 balls.

Chennai won the toss and scored 230-5 in its 20 overs with Devon Conway hitting a 35-ball 52. In reply, Gujarat was dismissed for 147 in 18.3 overs.

Gujarat, Punjab Kings, Royal Challengers Bengaluru and Mumbai Indians have already secured playoff spots.

Gujarat finished with 18 points from 14 games but its spot in the top two is under threat. Second-placed Punjab (17 points) and fourthplaced Mumbai (16 points) meet Monday in their last game, and Bengaluru (17 points) faces Lucknow Super Giants on Tuesday.

Opener Ayush Mhatre gave Chennai a

good start with a 17-ball 34. The big runs came from two overseas batters - Conway providing the base, with Brevis attacking toward the end.

Conway hit six fours and two sixes. Brevis got four fours and five sixes. Urvil Patel (37 off 19) and Ravindra Jadeja (21 not out off 18) also contributed as Chennai put up a strong total.

Gujarat's chase started badly - reduced to 30-3 in 4.3 overs - and its middle-order disappointed despite the chance to take an insurmountable points lead at the top. Sai Sudharsan top-scored with 41 off 28 balls.

Pacer Anshul Kamboj finished with 3-13, and wrist spinner Noor Ahmed 3-21. Ravindra Jadeja, who opened the bowling, took 2-17.

Chennai won four of its 14 IPL games. Klaasen, the league's most expensive overseas player, hit nine sixes and seven fours in his second IPL century to help Hyderabad pile on a massive 278-3 in 20 overs.

In reply, Kolkata was bowled out for 168 in 18.4 overs in Delhi.

Both teams had already been eliminated.

Hyderabad finished sixth with six wins in 14 games. It was a seventh loss in 14 games for 2024 champion Kolkata, which finished

Openers Abhishek Sharma (32 off 16) and Travis Head put on 92 off 41 balls after Hyderabad opted to bat first.

Head scored 76 off 40 deliveries, with six sixes. Klaasen was promoted to No. 3 and combined with Head to add 83 off only 35 balls for the second wicket.

Klaasen got to 50 from only 17 balls. The South African shared a partnership of 83 off six overs with Ishan Kishan (29 off 20).

Klaasen reached his ton off 37 balls. In reply, Kolkata's Sunil Narine scored 31 off 16 balls but didn't get support from the top-

Kolkata was down to 70-5 in eight overs and the chase was pretty much done. Manish Pandey top-scored with 37 off 23 balls.

Jaydev Unadkat (3-24), Harsh Dubey (3-34) and Eshan Malinga (3-31) did the damage.

Raza arrives just in time from England

LAHORE, Pakistan, May 26, (AP): Zimbabwe all-rounder Sikandar Raza flew in from England, arrived 10 minutes before the toss, and went on to lead Lahore Qalandars to its third Pakistan Super League title in four years.

Lahore's record successful chase saw it beat Quetta Gladiators by six wickets with a ball to spare in a thrilling final.

Raza had played in a test match against England at Nottingham, which Zimbabwe lost by an innings on Saturday.

He made a vital unbeaten 22 off seven deliveries on Sunday while Kusal Perera smashed a 31-ball 62 not out to carry Lahore to 204-4 in 19.5 overs after Quetta had chosen to bat first and scored 201-

Quetta mystery spinners Abrar Ahmed (1-27) and Usman Tariq (1-38) had squeezed Lahore, and when Raza arrived, the home team still needed 57 runs off the final 20 balls.

Raza showed no signs of fatigue after multiple flights to reach Lahore and smashed fast bowler Mohammad Amir for a four and a six off the first two balls he faced.

With eight runs needed off Faheem Ashraf's final three balls, Raza smacked the fast bowler over point for a six before hitting the winning boundary wide of mid-on.

Earlier, Pakistan's rising star T20 batter Hasan Nawaz smashed 76 off 43, and Ashraf (28) hit Salman Mirza for 23 runs off the final over to take Quetta past the 200-run mark.

The fast bowling duo of captain Shaheen Shah Afridi (3-24) and Haris Rauf (2-41) pegged back Quetta in the death overs when they claimed four wickets in the space of two runs but Ashraf's late onslaught gave Quetta hope to claim its first PSL title in six years before Raza stole the show.

Lahore won the PSL titles in 2022 and 2023, and with its third win, it equaled Islamabad United's record of three PSL titles.

Cabrera makes it two majors in week, rallying past Harrington at Senior PGA

BETHESDA, Md., May 26, (AP): Angel Cabrera sensed his opportunity when Padraig Harrington - playing a few groups ahead - faltered on the 15th hole with a double bogey.

"I was like, 'This is my turn,'" Cabrera said through a translator.

While Harrington was erratic down the stretch, Cabrera was steady, shooting a 3-under 69 on Sunday for a one-stroke victory in the Senior PGA Championship at Congressional. It was his second senior major in a week.

Cabrera, the 2007 U.S. Open and 2009 Masters champion, won the raindelayed Regions Tradition on Monday in Alabama, which was the Argentine's first senior major. Six days later at Congressional, he trailed Harrington by two strokes after Harrington rolled in a long birdie putt on No. 14.

But Harrington double bogeyed No. 15, and Cabrera birdied that same hole a short while later to take the lead. After a bogey by Harrington on the par-4 18th, Cabrera needed only a bogey on

that hole and got it. Cabrera spent 20 months in an Argentine prison after he was accused of making threats toward former partners. He was released on parole in August 2023 and won a PGA Tour Champions event last month before missing the cut

Ben Griffin has his first individual PGA Tour victory a month after winning a team event, hanging on to beat Matti Schmid at Colonial after breaking a tie with his co-leader for good on the first hole.

Griffin shot a 1-over 71 to finish at 12-under 268 in the Charles Schwab Challenge, one shot ahead of Schmid as both struggled through the final round on a warm day with wind gusts around 30 mph at Hogan's Alley.

Schmid forced Griffin to make a 4-foot par putt on the 72nd hole after his chip from the deep rough behind the green went in for birdie. Griffin saved par from the rough, standing in the bunker while choking way down on the club on his chip. Schmid shot 72.

Griffin and Schmid, the 27-year-old German seeking his first tour win in his 79th start, had matching scores each of the first three days.

Schmid was the one who surged in front early in the third round, taking a three-shot lead. Griffin had a fiveshot edge after just five holes in the final round, and finally let Schmid get within a stroke with a two-shot swing at 16 before getting the lead back to two with a hole to play.

CONCORD, N.C., May 26, (AP): Ross Chastain stood on top of his No. 1 Chevrolet in his white fire suit and held a watermelon above his head as the crowd at the Charlotte Motor Speedway roared with delight in anticipation.

Then, with a sense of ferocity, Chastain slammed it to the track, smashing it into pieces. Chastain began smashing watermelon as a way to uniquely honor his fam-

ily's legacy as eighth-generation watermelon farmers. The tradition began after his first NASCAR Cup Series race and has continued after every win as his own unique way to celebrate his strong ties to watermelon farming. But this win was extra special, his first at a crown jewel event.

"This thing is fresh from Florida," Chastain said with a laugh. "It just came up from our family farm. Man, for the Florida watermelon industry, that's your watermelons you're getting right now, so y'all better go buy a dang watermelon to celebrate. I want to see videos of smashed watermelons flood the socials. I want to see it. Florida watermelons are in season.' Chastain passed two-time Daytona 500 winner William Byron with six laps

left and won the Coca-Cola 600 on Sunday night at Charlotte Motor Speedway, capping a remarkable comeback and becoming the first driver to win the event after starting at the back of the field. NASCAR said he's the first driver to win from an official starting position of

last since Bobby Allison at the Richmond Fairgrounds in 1969. William Byron won the first three stages and led 283 laps, but surrendered the lead to Chastain, who started in 40th place and led just eight laps in his first

NASCAR Cup Series victory of the year. It was a huge boost to Trackhouse Racing, and a bitter disappointment for Byron, the Charlotte native who had signed a four-year contract extension Friday with Hendrick Motorsports. Byron has finished in the top three in the last

three Coca-Cola 600s without winning. Chastain said his crew stayed up all night to build him another car after a crash in practice on Saturday.

"To drive on that final run in the 600 and pass two cars that had been better than me all night, wow," said Chastain, who celebrated by standing on his car and slamming a watermelon down on the track as has become his tradition fol-

lowing a victory. "Holy cow! We just won the 600." Chastain said the plan was the fix the original car after the wreck, but NAS-CAR intervened. It might have been a good thing they did.

'We thought we were going to have to fix the primary, and NASCAR said, No, there is something bent (so go build another one," Chastain said. "That's

Chastain's crew chief, Phil Surgen, said it was "deflating" when a tire went down and Chastain crashed during practice because their original car had been running so well, finishing fastest among the field in 10-, 15-, and 20-lap aver-

Manchester United coach Erik ten Hag as Xabi Alonso's replacement.

The Bundesliga club said Monday that the 55-year-old Ten Hag had signed a contract through 2027, making his return to coaching after he was fired by United in October.

circumstances at times.' Ten Hag won two domestic cups in his two and a half years in charge at United but was fired after the club's worst start to a season, with four defeats in nine league

Hag's successor Ruben Amorim helped restore its former coach's reputation. Ten Hag was United's fifth manager in nine years when he took over.

"I've come to Leverkusen to continue with the ambition shown in recent years. It's an attractive challenge to set up something together in this period of change and develop an ambitious team," Ten Hag said in a club statement.

He previously succeeded in bringing the good times back to Ajax, leading the biggest team in the Netherlands to three Eredivisie titles and the Champions League semifinals in entertaining style in 2019.

Ajax reportedly wanted to bring Ten Hag back as Francesco Farioli's replacement after his team's late-season meltdown allowed PSV Eindhoven clinch the Eredivisie

At Leverkusen, Ten Hag will be charged with maintaining the team's upward trajectory under Alonso, though he will likely need to do it with a much-changed side.

The team's prospects will also hinge on the performance of Abdulrahman Al-Sahou, Youssef Burhama, Abdullah Ibrahim, and Hamad Al-Ali, in addition to the sharpshooting abilities of American Johnny Brahamskel and the inside presence of fellow professionals Joan Johnson and Dwayne Jackson.

In the second semifinal, national coach Fahad Barjas will look to orchestrate a surprise upset as Al-Sulaibikhat takes on powerhouse Al-Qadsia. The defending champion enters the match with strong momentum, boasting high technical and physical readiness and superior individual talents across their roster.

On the administrative side, the General Assembly of the Kuwait Basketball Association convened at the Association's headquarters in the Sheikh Saad Al-Abdullah Indoor Halls Complex. During the meeting, members approved both the financial and administrative reports for the fiscal year ending March 31, 2025. The Assembly also gave the green light to the Association's 2025–2026 work plan and proposed budget. Twelve of the thirteen affiliated clubs were present, with only Yarmouk Club absent.

Knicks trim series deficit after epic Game 3 win over Pacers

Towns drops 20 in 4th to rescue New York

INDIANAPOLIS, May 26, (AP): With the New York Knicks teetering on the brink of a third consecutive playoff loss and Jalen Brunson stuck on the bench with five fouls after three quarters, Karl-Anthony Towns took matters into his own hands.

The Knicks needed everything he could muster even on a sore knee.

Towns scored 20 of his 24 points in the fourth quarter as New York erased yet another 20-point deficit, and Brunson helped close out the 106-100 victory Sunday night to take Game 3 of the Eastern Conference finals, making it three straight wins for the road team.

"It's a true test when you're down 20-plus," Towns said. "Tonight was the kind of night where he had to have that never-say-die attitude.

New York still trails in the series 2-1 with Game 4 set for Tuesday night in Indianapolis.

But with the Knicks trailing by 16 midway through the third quarter and still down 10 entering the fourth, the dreaded 3-0 deficit looked like a real possibility-until Towns asserted himself by driving to the basket and muscling his way into position for more scores. He opened the fourth with a 3-pointer before making two layups to get New York within 82-79.

Brunson's layup with 7:10 to play finally gave New York

an 89-88 lead, and New York trailed only two more times the rest of the night. The Knicks never led by more than four until the final free throws with 2.6 seconds left. Brunson finished with 23 points despite spending most of the night in foul trouble.

"They put me in great spots to succeed, and I just wanted to capitalize on the opportunity," Towns said after also grabbing 15 rebounds. "All of us are just trying to do whatever it takes to win, get ourselves back in the game. We wanted to put ourselves in a position where, at the end of the game, we found ourselves with a chance of winning.

Tyrese Haliburton led the Pacers with 20 points and six assists. Myles Turner added 19 points as Indiana dropped to 0-4 all-time when playing on the same day the Indianapolis 500 was run. Two of those losses came to the Knicks.

Team officials handed out gold-and-blue T-shirts with the words "Vroom Baby" to celebrate the rare Pacers and racers doubleheader, and the winner, Spain's Alex Palou. made the short trek across town where he received during the second quarter, as Indiana started pulling away to a 55-35 lead late in the first half. Six players from Indiana's 2000 Eastern Conference champs, including Hall of Famer Reggie Miller, also were inside Gainbridge Fieldhouse.

But after rallying twice from fourth-quarter deficits to take the first two games in New York, and losing their top defender, Aaron Nesmith, with a sprained right ankle in the third quarter, Indiana failed to seal this one.

Fritz loses to Altmaier in first round at French Open

Swiatek and Alcaraz get off to good starts

PARIS, May 26, (AP): Iga Swiatek, who has struggled lately, and Carlos Alcaraz, who has not, got off to good starts in their French Open title defenses Monday, recording straight-set victories to reach the second round.

Swiatek was up first in Court Philippe-Chatrier and defeated 42nd-ranked Rebecca Sramkova 6-3, 6-3. Swiatek compiled 25 winners and 17 unforced errors in the 1-hour, 24-minute contest.

Alcaraz needed only about a half-hour more than that for a 6-3, 6-4, 6-2 win over Giulio Zeppieri, an Italian qualifier who is ranked 310th. Alcaraz won all 14 of his service games, saving the three break points he faced, at Court Suzanne-Lenglen.

Both Swiatek and Alcaraz sat in the Chatrier stands a day earlier to watch the farewell tribute to 14-time champion Rafael Nadal - and both active players wore the rust-colored T-shirts that read "Merci Rafa" distributed to spectators. Swiatek has often talked about her admiration for Nadal; Alcaraz is considered the 22-time

Grand Slam champion's heir apparent. Alcaraz is seeded No. 2 behind Jannik Sinner, who was scheduled to play Monday night, and is coming off a clay-court title at the Italian Open a little more than a week ago. Alcaraz beat Sinner in the final there.

Monday's result gave Alcaraz 28 wins in his past 30 matches on red clay, including going 7-for-7 a year ago at Roland-Garros. One of the losses came against Novak Djokovic in the gold-medal match at last year's Paris Olympics, held at the same site as the French

Swiatek has slipped to No. 5 in the rankings, her first time out of the top two spots in about three years. She hasn't reached a final at any tournament since collecting her third consecutive championship - and fourth in five years - in Paris in 2024.

The 23-year-old from Poland extended her French Open unbeaten streak to 22 matches and is trying to become the first woman to with four trophies in a row at the tournament in the professional era, which began in 1968. Monica Seles and Justine Henin also won three straight titles at Roland-Garros.

U.S. Open runner-up Taylor Fritz lost in the first round of the French Open as the tournament's No. 4 seed on Monday, eliminated 7-5, 3-6, 6-3, 6-1 by 66thranked Daniel Altmaier of Germany.

Altmaier broke Fritz's big serve five times at Court Simonne-Mathieu and ended the Californian's 15-match Grand Slam winning streak against players ranked outside the top 50.

Fritz's exit followed another by a top-10 American: No. 9 Emma Navarro was bounced from the women's bracket earlier Monday

In September, Fritz lost the U.S. Open trophy to Jannik Sinner, becoming the first U.S. man to reach a major final since Andy Roddick in 2009. In Paris, Fritz was the highest-seeded American man at the French Open since Roddick was No. 3 in 2007.

While hard courts are Fritz's preferred surface, he did have a run to the second week on the red clay of Roland-Garros a year ago, making it into the fourth round before losing to Casper Ruud.

This is not Altmaier's first big win at the French Open. He beat No. 8 seed Matteo Berrettini there in 2020, and

Emma Navarro, the ninth-seeded American who reached the U.S. Open semifinals last September, bowed out quickly in Paris, eliminated 6-0, 6-1 in just 57 minutes by Jessica Bouzas Maneiro of Spain.

Alonso officially takes over as Madrid's coach and vows to follow in the footsteps of Ancelotti

MADRID, May 26, (AP): Xabi Alonso officially took over Real Madrid's coaching job on Monday, vowing to follow in the footsteps of Carlo Ancelotti and saying he has "a good feeling" about the team's future under his command.

Madrid announced the hiring of Alonso on Sunday, a day after the club paid tribute to Ancelotti at the team's final Spanish league match of the season at the Santiago Bernabeu Stadium. Ancelotti is taking over the Brazil job after four mostly successful seasons in his second stint with the club.

"I'm here to take over from Carlo Ancelotti, who was my coach and is a great person," Alonso said. "He is a coach who left his mark on me and had a great influence. Without his guidance, I probably wouldn't be here. I'll pick up his legacy with pride and honor of now being in the position that Carlo was before, and I hope

to live up to the expectations and lead this club to achieve all of its objectives. He said he will try to instil his own style at Madrid, but did not give many hints about his tactics. He emphasized the desire to play ambitiously and with a proac-

"You have to be flexible in soccer today, you have to be dynamic," Alonso said. "I can move pieces during a game or before a game. I have an idea already of what I'm going to do, but it can change. What I want is for the team to transmit emotion, energy, to show that we want to be ambitious.

Alonso said it felt good returning home to Madrid, where he won six titles as a player from 2009-2014.

"Without a doubt this is a very special day for me," Alonso said. "I'm very happy to be at a place where I feel is my home. I may have been a few years away, but the link with Real Madrid and Madrid fans has always existed.'

The ceremony to introduce Alonso began with the showing of a video with some of Alonso's highlights as a player for Madrid, Spain and other clubs where he played as a midfielder. There were also highlights of his stints as a coach at Madrid's youth squads, Real Sociedad's "B" team and with Bayer Leverkusen,

which he left after this season. The 43-year-old Alonso, who arrives on a contract until June 2028, watched the video alongside his wife and other invitees.

"Today is a very special day for all of us, it's the start of a new phase," Madrid president Florentino Pérez said. "Because we have a new coach who already is one of the best in the world and who represents the values of Real Madrid because he knows exactly what this shield and this shirt means.

Alonso is returning to Real Madrid to take over a club that failed to meet expectations this season. It won the UEFA Super Cup title but mostly struggled after that, failing to lift another trophy and losing all four "clásico" matches against rival Barcelona, which clinched a league and cup double.

"We have a great team, with fantastic players," Alonso said. "I'm convinced that I can achieve important things, worthy of Real Madrid. I want to inspire the fans, make them proud of the team that they see on the field. I have a good feeling that we can start something great.'
