Keep Hamas' heretics away from the Palestinian cause

MADNESS is the logic of war, and reason is the foundation of peace. With this in mind, we can take into consideration the plan proposed by former U.S. President Donald Trump to resolve the Gaza crisis, which is now nearing its second year, sparked by Hamas' reckless actions.

Some naive individuals believed they could defeat Israel with a few rockets, ignoring the fact that the West, especially the United States, would never allow this at any cost.

If Hamas were guided by reason and truly concerned with the well-being of the people in Gaza, it would have been the first to accept a peace plan. Instead, it chose to escalate the conflict, leading to further death, destruction, hunger, and suffering.

By all rational assessments, Hamas and the other factions fueling this crisis face inevitable defeat, and their continued presence only deepens and prolongs the tragedy.

Some Arab leaders, especially those who met with Trump during the UN General Assembly, realized that their window of opportunity is closing, and that maneuvering is futile without possessing a force capable of

resisting the Israeli-American-Western alliance.

The region is now entering a new phase, different from the era of the Sykes-Picot Agreement that culminated in the 1967 war, when Israel expanded into Arab territories. Despite the presence of armies, there was no direct military confrontation. The outcome of that defeat marked the worst Arab catastrophe, the repercussions of which continue to this day.

Despite this, the Palestinians still have a chance to preserve some gains, especially in the Gaza Strip, where the Mediterranean Sea off its coast holds oil and gas resources that could help the people of Gaza overcome poverty and build an economy to support a future Palestinian



Kuwait welcomes US push to end Gaza war


Hamas reviewing Trump's 20-point proposal



During the meeting, the two sides reviewed the close historical relations between Kuwait and the US, affirming the strength of their strategic partnership and the commitment to further develop it in various fields.



Ministry expects KD 4 mln savings

MoE OK's staffing overhaul

KUWAIT CITY, Sept 30: The Ministry of Education announced that Minister Jalal Al-Tabtabaei has approved a ministerial decision concerning the regulatory procedures for supervisory and educational institutions, as well as

the criteria for selecting personnel assigned to work in adult education and literacy centers in the Educa-Affairs tional Sector, including educational zones, religious education, and special education, reports Al-



Seyassah daily. In an official statement, the ministry explained that the new decision is expected to achieve financial savings of approximately KD 4 million from the bonus budget. These savings result from restructuring assignments and controlling staff numbers while ensuring that assignments align with actual needs and workload. The decision is part of its

educational reform strategy and efforts to enhance the efficiency of supervisory and educational bodies in line with the New Kuwait 2035 vision. It also aims to strengthen the role of continuing education and literacy in serving society and enabling individuals to complete their educational journeys.

The ministry clarified that applications from those wishing to work in adult education and literacy centers will be accepted online via the ministry's official website from September 30 to October 6.

It affirmed its commitment to providing opportunities based on fair and transparent regulations.

The Ministry of Education emphasized its commitment to implementing strict measures to rationalize spending and control bonuses for supervisory and educational teams. Assignments will be limited to school staff and educational levels, based on the nature of the work and workload.

It confirmed that priority in assignments will be given to teachers in general, religious, and specialized education, followed by those in private education.

Diamonds are forever

Nothing brings a brighter smile to a woman's face or fills her eves with more joy than the gift of a precious diamond ring.

Diamonds, whether in the form of a ring, earring, necklace, or bracelet, have long been symbols of love, passion, and devotion. They embody eternal love, making

them one of the most cherished gifts and a powerful testament to

deep emotional connection. While diamonds

have always been highly prized, their

value is not rooted in rarity like a masterpiece painting or a one-ofa-kind sculpture. Instead, their allure stems from a combination of historical mining limitations, controlled supply by powerful market forces, and brilliant marketing strategies.

In fact, just 80 years ago in 1947, a diamond ring lacked the brilliance, global prestige, and romantic symbolism it holds today.

Good-quality diamonds, whose name comes from the Greek word "adamas", meaning "unbreakable" or "hard", are among the most abundant gemstones, especially in regions like Africa, Russia, Australia, and Canada. While highgrade diamonds make up only a small fraction of total production, the overall supply is sufficient to meet global demand, particularly with the growing availability of lab-grown diamonds.

The South African company De Beers has controlled diamond extraction, manufacturing, and pricing since in 1888. It was established by British businessman Cecil Rhodes after he acquired several mines, including one owned by the Dutch De Beers family, whose name he adopted for the company.

Within a few years, De Beers controlled 90 percent of the global diamond market, though its share has declined in recent decades.

De Beers has withstood crises, wars, natural disasters, and major financial collapses due to

its conservative policies, market dominance, and highly successful marketing campaigns, most notably the creation of the iconic slogan "A diamond is forever." This campaign sparked global demand and gave diamonds a modern, attractive appeal.

However, some critics consider De Beers' strategy to be one of the greatest marketing hoaxes of the 20th century. Diamonds, they argue, are not truly rare, and therefore not inherently as valuable as

the market suggests.

To ensure the success of their marketing strategy, De Beers deliberately linked diamond gifting and ownership to love and marriage, creating a deep desire in women to possess them.

The company employed various tactics such as featuring diamonds in popular novels, blockbuster films, and romantic songs, launching lavish and persuasive advertising campaigns, and enlisting famous women to wear them.

High-quality natural diamonds are much rarer than synthetic ones, even though both share similar geological origins.

Lab-grown diamonds, while chemically identical, often lack the clarity, color, and brilliance needed for fine jewelry and are typically unsuitable for cutting, grinding, or drilling tools. Only about 20 percent of mined diamonds each year are classified as high-quality, with an even smaller percentage considered exceptionally valuable due to their superior color, clarity, and size.

Diamond clarity is graded using the Gemological Institute of America (GIA) scale, which ranges from FL (Flawless), indicating no visible imperfections under magnification, to I (Included), where inclusions are clearly visible. Clarity is assessed based on the number, size, and position of internal flaws or inclusions under specialized magnification.

The belief in exchanging something valuable for a few otherwise worthless banknotes is not so different from our belief in the market value of diamonds. Just as currencies rely on central banks to maintain their value, diamonds have their own equivalent in the De Beers Corporation.

Bureaucracy burden: Stalling Kuwait's development drive

"GOVERNANCE is neither an intellectual luxury nor an irreplaceable accessory. If it were, it would not have received such global attention. The United Nations would not have prioritized it, and economists would not have recognized it as a condition for sustainable development," former director of the Arab Planning Institute Dr. Bader Othman Malallah wrote for Al-Seyassah daily.

"Good governance promotes the values of transparency, integrity, and a commitment to quality performance. True and lasting development, along with prosperous economic growth, can only be achieved through a well-governed public sector and a private sector built on strong foundations of good governance.

"The National Framework for Governance of the Governmental Administrative Apparatus in Kuwait and the National Program for Corporate Governance have yet to produce tangible results in achieving their intended goals.

"This may be due to two reasons - first, they are advisory frameworks without legal binding force, and second, there has been insufficient promotion and integration of these frameworks within public administration and the national culture.

"The Chandler Good Governance Index ranks Kuwait 53rd globally for 2025. While this reflects Kuwait's significant efforts in governance and digitization, it also highlights the shortcomings in public administration governance procedures and pro-

"Therefore, a new perspective and modern methods are urgently needed to advance this field, given its critical impact on development performance and the national economy.

"Government administration has become large complex, and both in terms institutional components and the number of employees. remains the primary employer of national labor, largely due to the trend in previous

decades of creating new agencies for every new government role.

"Studies indicate that this expansion far exceeds the scope of services and goods provided by the government administration and explains the significant decline in productivity.

"As a result, the government administration has become a burden on development rather than a driver of it. Beyond problems of size and low productivity, administrative costs continue to rise steadily, with salaries and wages accounting for the largest share of the general budget, estimated at approximately KD 14.8 billion for the fiscal year of 2024/2025, out of a total expenditure of around KD 24 billion (about 62 percent of total spending).

"Approximately 483,000 employees work in the government administration, with Kuwaitis making up about 77 percent. In addition to the high cost, this workforce size far exceeds the administration's actual

needs and capacity.
"The goal of "effective government administration" was one of the pillars of both the 2015–2020 Development Plan and the subsequent (current) plan. Both plans identified government administration reform as central to Kuwait's national development strategy and included policies aimed at reforming administrative and bureaucratic practices to enhance transparency, accountability, and performance efficiency. They also focused on building an effective civil service system, utilizing digital technologies in government operations, and reducing bureaucratic red tape

and paperwork. "However, traditional problems remain unaddressed because the vision and policies included in these plans did not fully engage with the root of

"Reducing the size of the public administration to align with the actual volume of public services and goods it provides requires creating job opportunities to ease the employment burden currently borne by the public sector, shifting this responsibility to the private sector.

'Addressing a major aspect of public finance imbalances, namely salaries and wages, is essential as a primary goal of financial reform. Governance of public administration must be aligned with that of the private sector, which has made significant strides in this area, particularly the banking sector, a key pillar of the national economy.

"The private sector must increase its contribution to productive industries and transform itself into a productive, rather than an importing,

"Judicial litigation is one of the fundamental pillars that govern the administration of justice and uphold

the rule of law. Understanding the difference between initiation and commencement of litigation is crucial to ensuring the proper and efficient conduct of judicial proceedings. The difference between these two concepts depends on the timing and procedures followed, as each plays a pivotal role in achieving justice," Kuwaiti writer Imad Khamis Al-Aqab wrote for Al-Seyassah daily.

"In the Kuwaiti legal system, judicial litigation is initiated when the plaintiff files



a statement of claim with the court clerk. This procedure marks the start of legal proceedings resolve the dispute between the parties involved. Filing the statement of claim requires submit-

ting all necessary documents and evidence supporting the plaintiff's case, along with a clear specification of the claims they seek to pursue through the judiciary.

"Litigation officially begins once the defendant is notified of the lawsuit filed against them. This notification is carried out by serving the defendant with a copy of the statement of claim and related documents. The notice must be served properly and legally to ensure the defendant is fully aware of the lawsuit and has the opportunity to present their defenses

"Thus, initiating a lawsuit is the first step taken by the plaintiff, while the commencement of the lawsuit represents the realization of justice by ensuring the defendant's right to defend themselves. Understanding this distinction is crucial for the proper administration of justice. Filing the lawsuit alone, without notifying the defendant, is not enough to achieve justice. Proper service of notice is essential to ensure the defendant is aware of the case and able to present their defense.

'Thus, this distinction ensures a balance of rights between the disputing parties and upholds the principle of fairness. These concepts demonstrate that the Kuwaiti judicial system places great importance on protecting the rights of all parties involved and relies on precise procedures to achieve this goal. Understanding the difference between filing a lawsuit and the commencement of the lawsuit is a key element in ensuring fair and effective justice."

"If citizens, especially those with limited income, wish to expand or build new homes to replace their small, old-fashioned houses that no longer reflect modern urban development, the government does not provide them with land plots. This leaves the citizen with no choice but to take a risky path - either sell the old home or mortgage it to banks that charge excessive interest. In reality, both options are like stepping into the fire, as these banks deduct steep installments directly from the citizen's salary, or pension, if retired," Kuwaiti journalist Hassan Ali Karam wrote for Al-

Seyassah daily. "Therefore, do not be surprised when you hear that half of Kuwait's citizens are working just to pay the banks. This means



a large portion of their income goes toward paying off accumulated housing debts, car loans, wedding expenses for their children, or tuition fees for for-

eign schools.

"Many ple, especially expatriate friends, imagine that the Kuwaiti citizen walks around with a checkbook and multiple bank cards in his pocket, unaware that, in reality, he is financially struggling.

"A citizen needs between KD 200,000 and KD 300,000 just to buy a plot of land suitable for building a modest family home, on top of a similar amount needed for construction. For the average citizen, owning a home means constant worry, sleepless nights, financial pressure, and a long, exhausting journey of paying off installments.

"O government, this is the reality for the low-income citizen. And here, I can't help but ask - Is now really the right time for the government to consider allowing foreigners to own real estate, despite the already limited availability of land? Selling land plots to foreigners is a disastrous plan that would subject poor citizens to the greed of merchants and real estate brokers.

"O Council of Ministers, fear God. Previous governments rejected this idea out of awareness of the citizens' hardship and their belief that the Kuwaiti citizens must remain at the heart of national priorities. I say this clearly - Kuwait is not for sale.

Traffic sweep nets reckless motorists

Bangladeshi man dies in Wafra

KUWAIT CITY, Sept **30: The Ministry of Inte**rior announced that the General Traffic Department, represented by the Traffic **Investigations Unit of Security Control** Department, conducted field campaigns that resulted in the issuance of 214 various traffic citations, and impoundment of 21 vehicles and 11 motorcvcles.

In an official statement, the ministry revealed that ten individuals were placed in precautionary detention, 12 juveniles were referred to the Juvenile Prosecution, and one vehicle wanted for judicial detention was seized.

The ministry explained that these campaigns are part of ongoing efforts to enhance road safety, deter reckless behavior that endangers lives and property, and track down violators and reckless drivers. It will not tolerate any leniency in taking legal action against violators.

It emphasized the importance of public cooperation in reporting traffic violations or reckless behavior through the hotline No.

112 of the ministry's Operations Room, the WhatsApp No. 99324092 of the General Traffic Department or the "Tawasul" platform, adding that such cooperation will help enhance traffic safety and reduce negative inci-

According to security sources, the recent arrests targeted reckless drivers, individuals riding quad bikes on public roads, and juveniles driving without licenses in several areas, all of whom have faced legal action. They indicated that the Secu-

rity Monitoring Department at the General Traffic Department is actively monitoring videos circulating on social media, including those showing red-light violations or other serious traffic offenses, adding that legal measures will be taken after verifying the authenticity and timing of the footage.

Meanwhile, a Bangladeshi expatriate in his fifties died in a traffic accident on Wafra Road, and his body has been referred to the Forensic Medicine Department.

According to a security source, when the Operations Room of the Ministry of Interior received information about the accident on Wafra Road, security personnel and paramedics rushed to the scene immediately, and discovered that the accident resulted in the death of a Bangladeshi man in his fifties. A case was registered.

In a statement posted on its official X account, Naz-

aha affirmed the importance of all individuals subject to financial disclosure provisions to complete their statements accurately and submit them within the legally specified deadlines. The authority stressed that this is essential to promoting transparency, integrity, and strengthening public trust in state institutions.

Mol warns of rising scams: "Ministry of Interior does not communicate through video calls and never requests personal or banking information from citizens or residents. In fact, no official entity will ask for bank account details or OTP codes via phone or text messages", reports Al-Anba daily quoting security sources

They explained that the ministry has recently identified multiple types of fraud and scams, including video calls from individuals impersonating security officers using altered phones and communication apps, as well as others posing as telecom company employees offering fake promotions and making unrealistic claims.

KUWAIT CITY, Sept 30: The Public Authority for Housing Welfare (PAHW) has approved the technical bids of four consulting firms for the Sabriya City project's consulting services competition.

According to a memorandum on the onsulting services competition for detailed studies, planning, design, and preparation of tender documents for the construction, completion, and maintenance of main roads and major infrastructure networks in Sabriya Residential City, four companies were selected after achieving a success rate of 70 percent or higher among the applicants.

Sources said PAHW will review the technical bids, adding that approval of these bids marks a major step toward the implementation of one of the largest housing projects in the country. The city will offer 55,000 housing units along with service, commercial, recreational, and public facilities, covering an area of 80 square kilometers. The consulting firms' scope of work

includes preparing detailed studies and designs for main roads and major infrastructure networks, as well as drafting struction, completion, and maintenance of these vital facilities.

The sources emphasized that this preliminary phase is a fundamental pillar for ensuring quality implementation in the future.

They highlighted the residential sector's commitment to adopting the highest technical and engineering standards and keeping pace with the latest global practices in urban planning and engi-

MOHE limits scholarship major changes

KUWAIT CITY, Sept 30: In response to student requests to change their major within scholarship programs, the Ministry of Higher Education has announced the official conditions for doing so, either after completing the preparatory year or during academic studies, reports Al-Jarida daily.

The ministry affirmed that students must first obtain academic acceptance from a university or institution recommended by the ministry, for a major listed within the scholarship program, and within the same academic year and country of

In a press statement on its official X account, the ministry explained the important requirements including meeting academic eligibility criteria based on their academic system, and completing at least 12 credit hours in a semester-based system with a minimum GPA of 2.00, or successfully completing the preparatory

or first academic year in an annual system. Students are allowed to change their major only once after actual enrollment, and only after receiving formal approval

from the ministry. A scholarship student may request to change their major more than once during their academic studies, up to a maximum of two times, if they are accepted into a distinguished program or transfer to a distinguished educational institution.

Students may request to switch to a field not listed in the ministry's scholarship program under the same conditions, provided the total number of changes does not exceed two.

However, students are not permitted to change their major after completing half of their academic program or before arriving in the host country. Also, any change requires approval from both the admitting institution and the Ministry of Higher Education.



A joint statement by the Foreign Ministers of Saudi Arabia and several Arab and Muslim countries welcomed late Monday US President Donald Trumps efforts to end the war in Gaza, and find a path to peace in

US President Donald Trump on Monday laid out a 20-point proposal supported by Israeli Prime Minister Benjamin Netanyahu that would end the war in Gaza and free remaining hostages, leaning heavily into conditions that Hamas has previously rejected.

The U.S. president, who has become increasingly frustrated by the bloody conflict, seems to be betting that the militants are now so decimated that they have no choice but to accept what he and Netanyahu are framing as a last, best offer.

"If Hamas rejects your plan, Mr. President, or if they supposedly accept it and then do everything to counter it, then Israel will finish the job by itself," Netanyahu said after meeting with Trump at the White House. "This can be done the easy way or it can be done the hard way, but it will be done.

Qatar's prime minister and Egypt's intelligence chief presented Trump's proposal to Hamas negotiators, who are now reviewing it in "good faith," according to a person familiar with the matter. The person was not authorized to comment and spoke on the condition of anonymity.

Kuwait strengthens air transport partnerships

WASHINGTON, Sept 30, (KUNA): Kuwait's Public Authority for Civil Aviation affirmed its commitment to strengthening international cooperation and expanding global air connectivity in order to develop the aviation sector and reinforce Kuwait **International Airport's** position as a key regional

This came during bilateral meetings held by the Public Authority for Civil Aviation delegation with several international counterparts on the sidelines of the International Civil Aviation Organization (ICAO) Assembly, taking place in Montreal, Canada, from Septem-

ber 23 to October 3. In a press statement, the Public Authority for Civil Aviation said the Kuwaiti delegation met with representatives from China to present Kuwait's latest aviation projects and encourage Chinese airlines to operate passenger and cargo flights to Kuwait International Airport. The two sides also discussed opportunities to benefit from China's expertise in airport management and cargo operations.

The delegation also met with Brazilian representatives, where talks focused on the possibility of opening new air routes between Kuwait and Brazil, either directly or through international hubs, to be operated by Kuwait Airways or

Brazilian carriers. The Public Authority for Civil Aviation delegation held discussions with Singaporean delegation, exploring prospects for direct flights between the two countries. The talks also covered knowledge exchange in airport management, air cargo city operations, and strengthening cooperation in train-

ing and capacity-building.

The statement added that the Kuwaiti delegation attended an official reception hosted by Qatar and South Korea in honor of the delegations participating in the ICAO meetings.

Meanwhile, the Kuwaiti Public Authority for Civil Aviation delegation took part in a session of the International Civil Aviation Organization's (ICAO) 42nd General Assembly in Montreal, Canada, to promote gender equality and strengthen women's participation in the aviation sector.

Deputy Director General for Aviation Safety and Air Transport Abdullah Al-Rajhi told KUNA late Monday that the delegation joined the meeting of the Gender Focal Points (GFPs) which discussed experiences, challenges, as well as international and regional initiatives to empower women in aviation.

after the shooting late Saturday night at the Kickapoo Lucky Eagle Casino in Eagle Pass, authorities said.

Jones was arrested Sunday morning following a pursuit by authorities near Stockdale, which is about 180 miles (290 kilometers) east of Eagle Pass, according to the Wilson County Sheriff's Office. Jones faces two counts of capital murder and five

counts of assault with a deadly weapon, Maverick County Sheriff Tom Schmerber said. It was unclear where Jones was being held and whether he had an attorney to speak on his behalf. (AP)

US President Trump and Hegseth declare end to 'politically correct' leadership in military

QUANTICO, Va., (AP): US President Donald Trump and Defense Secretary Pete Hegseth declared an end to "woke" culture in the military and targeted other policies of past administrations Tuesday before hundreds of top US military officials who were abruptly summoned to Virginia from around the world.

Hegseth announced new directives for troops that include "gender-neutral" or "male-level" standards for physical fitness, while Trump bragged about US nuclear capabilities and criticized the military leaders' previous commander in chief, President Joe Biden.

'We must be so strong that no nation will dare challenge us, so powerful that no enemy will dare threaten us," Trump said. "And so capable that no adversary can even think about beating us.

Hegseth had called military leaders to convene at the Marine Corps base in Quantico, near Washington, without publicly revealing the reason until this morning. Hegseth's address largely focused on his own long-used talking points that painted a picture of a military that has been hamstrung by "woke" policies, and he said military leaders should "do the honorable thing and resign" if

During his nearly hour-long speech, Hegseth said the US military has promoted too many leaders for the wrong reasons based on race, gender quotas and "historic firsts."

"The era of politically correct, overly sensitive don't-hurt-anyone'sfeelings leadership ends right now at every level," Hegseth said.

He said he is loosening disciplinary rules and weakening hazing protections, putting a heavy focus on removing many of the guardrails the military had put in place after numerous scandals and investigations

Hegseth said he was ordering a review of "the department's definitions of so-called toxic leadership, bullying and hazing to empower leaders to enforce standards without fear of retribution or second guessing.

He called for "changes to the retention of adverse information on personnel records that will allow leaders with forgivable, earnest, or minor infractions to not be encumbered by those infractions in perpetuity.'

"People make honest mistakes, and our mistakes should not define an entire career," Hegseth said. "Otherwise, we only try not to make mistakes.

US govt on brink of first shutdown in almost 7 years amid partisan standoff in Congress

WASHINGTON, Sept 30, (AP): A partisan standoff over health care and spending is threatening to trigger the first US government shutdown in almost seven years, with Democrats and Republicans in Congress unable to find agreement even as thousands of federal workers stand to be furloughed or laid off.

The government will shut down at 12:01 am Wednesday if the Senate does not pass a House measure that would extend federal funding for seven weeks while lawmakers finish their work on annual spending bills. Senate Democrats say they won't vote for it unless Republicans include an extension of expiring health care benefits, among other demands, while President Donald Trump and his fellow Republicans are refusing to negotiate, arguing that it's a stripped-down, "clean' bill that should be noncontroversial.

It's unclear if either side will blink before the deadline.

"It's now in the president's hands," Senate Democratic leader Chuck Schumer said Monday after a meeting with Trump at the White House that yielded little apparent progress. "He can avoid the shutdown if he gets the Republican leaders to go along with what we want."

Vice President JD Vance, who was also in the meeting, said afterward, "I think we're headed into a shutdown, because the Democrats won't do the right thing."

While partisan stalemates over government spending are a frequent occurrence in Washington, the current impasse comes as Democrats see a rare opportunity to use their leverage to achieve policy goals and as their base voters are spoiling for a fight with Trump. Republicans who hold a 53-47 majority in the Senate will likely need at least eight votes from Democrats to end a filibuster and pass the bill with 60 votes, since Republican Sen. Rand Paul of Kentucky is expected to vote against it.

Trump had shown little interest in entertaining Democrats' demands on health care, even as he agreed to hold a sit-down meeting Monday with Schumer, D-N.Y., Senate Majority Leader John Thune, R-S.D., House Speaker Mike Johnson, R-La., and House Democratic leader Hakeem Jeffries, D-N.Y.

As he headed into the meeting, Trump made it clear he had no intention to negotiate on Democrats' current terms.

"Their ideas are not very good ones," Trump said.

It was Trump's first meeting with all four leaders in Congress since retaking the White House for his second term, and he did more listening than talking, Jeffries told House Democrats at the Capitol afterward, according to a lawmaker who attended the private caucus meeting and insisted on anonymity to discuss it.

Schumer said after the closed-door meeting that they had "had candid, frank discussions" with Trump about health care. Vance also said Trump found several

points of agreement on policy ideas.

Schumer said Trump "was not aware" of the potential for health insurance costs to skyrocket once the subsidies end Dec. 31.

But Trump did not appear to be ready for serious negotiations. Hours later, Trump posted a fake video of Schumer and Jeffries taken from footage of their real press conference outside of the White House after the meeting. In the altered video, a voiceover that sounds like Schumer's voice makes fun of Democrats and Jeffries stands beside him with a cartoon sombrero and mustache. Mexican music plays in the background.

Jeffries posted in response that "Bigotry will get you nowhere."

He added, "We are NOT backing down." Democrats are pushing for an extension to Affordable Care Act tax credits that have boosted health insurance subsidies for millions of people since the COV-ID-19 pandemic. The credits, which are designed to expand coverage for low- and middle-income people, are set to expire at the end of the year.

"We are not going to support a partisan Republican spending bill that continues to gut the health care of everyday Americans," Jeffries said.

Thune has pressed Democrats to vote for the funding bill and take up the debate on tax credits later. Some Republicans are open to extending the tax credits, but

they want to place new limits on them. 'We're willing to sit down and work with them on some of the issues they want to talk about," Thune told reporters at the White House, adding, "But as of right now, this is a hijacking of the American people, and it's the American people who

Democrats are in an uncomfortable position for a party that has long denounced shutdowns as pointless and destructive, and it's unclear how or when it would end. But party activists and voters have argued that Democrats need to do something

Some groups called for Schumer's resignation in March after he and nine other Democrats voted to break a filibuster and allow a Republican-led funding bill to advance to a final vote.

Schumer said he voted to keep the government open because a shutdown would have made things worse as Trump's administration was slashing government jobs. He says things have changed since then, including the passage this summer of the massive GOP tax cut bill that reduced Medicaid.

Some of the Democrats who voted with Schumer in March to keep the government open were still holding out hope for a compromise. Michigan Sen. Gary Peters said Monday there's still time before the early Wednesday

"A lot can happen in this place in a short period of time," Peters said.

Federal agencies were sending out contingency plans if funding lapses, including details on what offices would stay open and which employees would be furloughed. In its instructions to agencies, the White House has suggested that a shutdown could lead to broad layoffs across the government.

Trump's budget director, Russ Vought, told reporters at the White House that a shutdown would be managed "appropriately, but it is something that can all be avoided" if Senate Democrats accepted the House-passed bill.

Before joining the administration, Vought had advised hard-line conservatives in Congress to use the prospect of a shutdown to negotiate for policy concessions. But on Monday, he berated Democrats for engaging in a similar ploy.

Starmer urges Britain to choose decency over division as PM tries to counter Farage

LIVERPOOL, England, Sept 30, (AP): Prime Minister Keir Starmer said Tuesday that Britain faces a stark choice between decency and division as he attempts to reset his government and stem the rising popularity of the hard-right party Reform UK.

Starmer told his center-left Labour Party that Britain faces "a fight for the soul of our country" as he tries to overcome dire approval ratings, a sluggish economy and the challenge posed by Reform's divisive leader, Nigel Farage.

"Britain stands at a fork in the road. We can choose decency or we can choose division. Renewal or decline,' Starmer told hundreds of lawmakers and Labour members at the party conference in Liverpool. He urged people to reject "snake

oil merchants on the right, on the left" who promise "a quick fix, a miracle

Since Labour won a landslide election victory in July 2024, its popularity has plummeted. The party promised economic growth, but has struggled to deliver. Inflation remains stubbornly high and the economic outlook subdued, frustrating efforts to repair tattered public services and ease the cost of living.

Treasury chief Rachel Reeves said Monday that wars in Ukraine and the Middle East and US President Donald

Farage's party has topped opinion polls for months, ahead of both Labour and the main opposition Conservatives, despite holding just five of the 650 seats in the House of Commons.

Airspace violations force NATO to tread tightrope

BRUSSELS, Sept 30, (AP): NATO is stepping up aerial surveillance in the Baltic Sea, while France, Germany and Sweden are bolstering Denmark's air defenses ahead of two summits in Copenhagen this week over a series of troubling drone incidents near the country's airports and military bas-

The number of serious airspace violations in Europe has spiked this month, including by Russian warplanes. But not all NATO allies agree on how to respond. Poland is ready to use lethal force. Others say that must only be a last resort.

Regardless of who is to blame in Denmark, European leaders believe that Russia is testing NATO. Military planners in Moscow can observe how Western forces react, and countering intrusions by relatively cheap drones is a financial burden on the allies.

In the wake of the drone incident in Poland, NATO launched operation Eastern Sentry, with Britain among the allies to send more air defense equipment. However, these deployments might also deprive Ukraine

Japan's outgoing PM Ishiba, South Korea's Lee commit to closer ties in final summit

SEOUL, South Korea, Sept 30, (AP): Japan's outgoing prime minister and his South Korean counterpart underscored the need to strengthen cooperation between their nations, as US President Donald Trump's transactional approach to allies and trade wars are bringing the often-feuding Asian neighbors closer.

Tuesday's meeting between Japanese Prime Minister Shigeru Ishiba and South Korean President Lee Jae Myung in the South Korean southeastern port city of Busan is their third and likely final summit. Earlier this month, Ishiba offered to resign over his ruling coalition's recent election defeat, triggering a contest to find his successor.

"I hope that (South) Korea and Japan can grow closer emotionally, economically, socioculturally, and in terms of security, just as they are in physical distance," Lee said at the start of the meeting.

Ishiba said that it was "deeply meaningful" to conclude his final diplomatic activities as prime minister with a summit with Lee. "By sharing each other's wisdom and experience, we can strengthen relations between our two countries while addressing our common challenges," Ishiba said through a translator.

The two leaders issued a joint statement vowing further bilateral consultations on shared issues like low birth rates, rural revitalization and enhanced disaster prevention steps. Lee's office said the two also reaffirmed their commitment to the complete denuclearization of the Korean Peninsula, a reference to efforts to end North Korea's nuclear program.

South Korea and Japan are both key US allies and major trading partners. But their ties have experienced constant shifts because of history disputes stemming from Japan's past colonial rule of the Korean Peninsula. Relations began improving under Lee and Ishiba's predecessors. But the impending departure of Ishiba, who has acknowledged Japan's wartime aggression and shown empathy toward the Asian victims, could pose a foreign policy challenge to Lee.

Both governments said the summit was part of earlier agreements to maintain close communication and high-level exchanges between the countries.

When Lee traveled to Tokyo in August for his second summit with Ishiba, he became the first South Korean leader to pick Japan as their first destination for a bilateral summit since the two countries established diplomatic ties in 1965. In Tokyo, Lee said he intended to pursue pragmatic diplomacy and build future-

South Korea and Japan have sought ways to tackle together challenges like North Korea's expanding nuclear arsenal and supply chain vulnerabilities. They are now being pushed closer together by Trump's push to reset global trade.

Lee's national security director, Wi Sung-lac, earlier told reporters that Tuesday's summit would provide a venue to expand discussions in the midst of "the rapidly changing geopolitical environment and trade order." He said that the meeting would also discuss Ishiba's possible active role in developing bilateral ties

South Korea and Japan have pledged hundreds of billions of dollars in US industrial investments in hopes of avoiding the Trump administration's highest tariffs. But South Korean officials acknowledge they remain at odds with Washington over how Seoul's proposed \$350 billion package would be structured and

South Korean officials have proposed delivering the investment through loans and loan guarantees and have balked at US demands for upfront payments, which they say would put the country at risk of a financial crisis given the size of its foreign-currency reserves.

UNITED NATIONS: A senior North Korean diplomat reiterated at the UN Monday that his country won't give up its nuclear weapons despite numerous international demands to do so, calling them crucial to keeping a "balance of power" with South Korea. "We will never walk away from this position," he said.

Under the spotlight of the General Assembly's annual meeting of world leaders, Vice Foreign Minister Kim Son Gyong amplified his country's longstanding complaints about US-led military exercises with South Korea and Japan. Complaining that the US and its allies are mounting a "growing threat of aggression," he portrayed his own country's arsenal as the reason "the balance of power on the Korean Peninsula is ensured.'

Still, his address was more tempered, especially toward the United States, than many of his country's prior remarks on the world stage and elsewhere. While Kim lambasted - without naming names - "hegemonic forces" and an "indiscriminate tariff war," there were no direct references to US President Donald Trump or personal insults, and there was more sternness than over-the-top bellicosity. Kim vowed that "we will never give up nuclear," noting that North Korea's

nuclear program is enshrined in its constitution. He asserted that security on the Korean Peninsula "is faced with serious chal-

lenges more than ever," saying that the US-Japanese-South Korean exercises "are breaking all the previous records in terms of scale, nature, frequency and scope." The North routinely characterizes such war games as preludes to an attack.

Rescuers run oxygen to survivors

Indonesia school building collapse kills 3

SIDOARJO, Indonesia, Sept 30, (AP): Rescuers ran oxygen and water to students trapped in the unstable concrete rubble of a collapsed school building in Indonesia, as they desperately worked to free survivors Tuesday a day after the structure fell. At least three students were killed, more than 100 were injured and dozens were presumed buried in the rubble.

Rescue workers, police and soldiers digging through the night pulled out eight weak and injured survivors more than eight hours after the collapse at Al Khoziny Islamic Boarding School in the East Java town of Sidoarjo. Rescuers saw additional bodies, indicating the death toll was likely to rise.

Rescue efforts were temporarily suspended at 10:15 a.m. as the collapsed concrete shook suddenly. People immediately ran for their lives, fearing another collapse, as rescuers urged everyone in the area to avoid the building, including more than a dozens of ambulances that parked near the scene. The work resumed around 1:45 p.m.

The students are mostly boys in grades seven to 11, between ages 12 and 18. Families anxiously awaited news at hospitals or near the collapsed building. A notice posted at the school complex Tuesday morning listed 65 students as missing. National Disaster Management Agency spokesperson Abdul Muhari revised the number of

people presumed buried in the rubble to 38 by midday.

Heavy slabs of concrete and other rubble and unstable parts of the building hampered search and rescue efforts, said Nanang Sigit, a search and rescue officer who lead the effort. Heavy equipment was available but not being used due to concerns that it could cause further

"We have been running oxygen and water to those still trapped under the debris and keeping them alive while we work hard to get them out," Sigit said. He added that rescuers saw several bodies under the rubble but were focused on saving those who were still alive.

Several hundred rescuers were involved in the effort and had equipment for breathing, extrication, medical evacuation and other support tools.

Islamic boarding schools are commonly called as "pesantren" in Indonesia, the world's most populous Muslim-majority nation, and its students who are called as "santri." Unlike students in public schools, the santri board in dormitories, because apart from studying formal education, they also study Islamic religious knowledge intensively, and they return home only during school holidays

FBI gives NZ officials 3D-printed guns illegal to possess under local laws

WELLINGTON, New Zealand, Sept 30, (AP): On a visit to New Zealand, FBI Director Kash Patel gave the country's police and spy bosses gifts of inoperable pistols that were illegal to possess under local gun laws and had to be destroyed, New Zealand law enforcement agencies told The Associated Press.

The plastic 3D-printed replica pistols formed part of display stands Patel presented to at least three senior New Zealand security officials in July. Patel, the most senior Trump administration official to visit the country so far, was in Wellington to open the FBI's first standalone office in New Zealand.

Pistols are tightly restricted weapons under New Zealand law and possessing one requires an additional permit beyond a regular gun license. Law enforcement agencies didn't specify whether the officials who met with Patel held such permits, but they couldn't have legally kept the gifts if they didn't.

It wasn't clear what permissions Patel had sought to bring the weapons into the country. A spokesperson for Patel told the AP Tuesday that the FBI would not comment.

Inoperable weapons are treated as though they're operable in New Zealand if modifications could make them workable again. The pistols were judged by gun regulators to be potentially operable and were destroyed, New Zealand's Police Commissioner

Richard Chambers told AP in a statement Tuesday.

Chambers didn't specify how the weapons had been rendered inoperable before Patel gifted them. Usually this means the temporary disabling of the gun's firing mechanism.

Three of New Zealand's most powerful law enforcement figures said they received the gifts at meetings July 31. Chambers was one recipient, and the other two were Andrew Hampton, Director-General of the country's human intelligence agency NZSIS, and Andrew Clark, Director-General of the technical intelligence agency GCSB, according to a joint statement from their departments.

A spokesperson for the spy agencies described the gift as "a challenge coin display stand" that included the 3D-printed inoperable weapon "as part of the design." The officials sought advice on the gifts the next day from the regulator that enforces New Zealand's gun laws, Chambers said.

Internet blackout hits Afghanistan

ISLAMABAD, Sept 30, (AP): An internet blackout hit Afghanistan on Monday, with local media reporting a potential nationwide cut of fiber-optic services as part of a Taliban crackdown on immorality.

It's the first time Afghanistan has experienced a shutdown of this kind since the Taliban seized power in Au-

Earlier this month, several provinces lost their fiber-optic connections after Taliban leader Hibatullah Akhundzada issued a decree banning the service to prevent immorality.

On Monday, internet-access advocacy group Netblocks said that live metrics showed connectivity in Afghanistan had "collapsed" to 14% of ordinary levels, with a near-total nationwide telecoms disruption in effect.

"The incident is likely to severely limit the public's ability to contact the outside world," the group added.

The Associated Press was unable to contact its Kabul bureau, as well as journalists in the eastern and southern provinces of Nangarhar and Helmand. There was no confirmation of the blackout from the Taliban government, which relies heavily on messaging apps and social media for its external and internal communications.

Colombia FM renounces US visa

BOGOTA, Colombia, Sept 30, (AP): Colombia's foreign minister has "renounced" her US visa to protest a decision by the US State Department to revoke the visa of Colombian President Gustavo Petro, the Colombian government said Monday.

The decision by Foreign Minister Rosa Villavicencio comes as tensions between both nations escalate over issues that include

drug policy, the war in Gaza and a US naval buildup in neighboring Venezuela. Colombia's

Foreign Affairs Ministry did not respond to questions about what kind of visa Vil-

Villavicencio lavicencio held, but said in a statement that it was not interested in "diplomatic visas that limit opinions" or curtail the nation's "sover-

Later on Monday, Colombian Finance Minister Germán Ávila wrote in an X message that he would stop using his visa in "solidarity" with Petro, and because of the "aggression" he was subjected to by the United States. "To work for our people, we do not need visas" Ávila wrote.

The US State Department revoked

Petro's visa Friday after he participated in a protest in New York against the war in Gaza, in which Petro called for the creation of an international army to liberate the West Bank and the Gaza

Holding a megaphone and wearing a kaffiyeh, the traditional Palestinian scarf, Petro called on U.S. soldiers to "disobey" President Donald Trump's orders, adding that they should "not point their rifles against humanity."

Hours after the protest, the State Department said on social media that it would cancel Petro's visa "due to his reckless and incendiary actions. Petro was back in Colombia when

the visa announcement was made, after having spent several days in New York attending the U.N. General Assembly. He wrote on X that he "didn't care" about the punishment because he is also an Italian citizen, and could possibly travel to the US without a visa.

The revocation of Petro's visa marks a new low in the leftist leader's relations with the Trump administration, which earlier this month placed Colombia on a list of countries that it says are not fulfilling their international commitments to curb drug trafficking.

Geoff Ramsey, a Colombia analyst at the Atlantic Council, said the foreign minister's decision to ban herself from visiting the United States places more obstacles in the relationship.

Car bomb outside Pakistan's security force HQ kills 10 and dozens injured

QUETTA, Pakistan, Sept 30, (AP): A powerful car bomb outside the headquarters of Pakistan's paramilitary security forces killed at least 10 people on Tuesday and wounded 30 others, authorities said. Before detonating their vehicle, as many as six militants

inside the car stepped outside and engaged troops in an in-

tense shootout, according to the police. All six attackers were reported to have been killed. Residents said the blast in the southwestern city of Quetta could be heard from miles away. Ambulances rushed to the

site in front of the Frontier Constabulary and rescuers transported the wounded to nearby hospitals. No group immediately claimed responsibility, though suspicion is likely to fall on separatists who often target civil-

ians and security forces in insurgency-plagued Balochistan, where Quetta is the provincial capital. Provincial health minister Bakhat Kakar said the death toll

could rise further. He told reporters that the attackers had targeted the security forces' headquarters, but most of those killed and injured were civilians.

Interior Minister Mohsin Naqvi said six attackers were involved in the assault and all of them were killed by the security forces.

Mohammad Usman, who lives near the paramilitary head-

quarters, said the blast shook the entire neighborhood. "The windowpanes of my house shattered, and part of the building was damaged, but thanks to God we are all safe," he said, adding he heard gunfire following the explosion.

Local television channels and CCTV footage from the site of the explosion showed images of a car stopping in front of the gate of the paramilitary compound. An explosion follows and gunfire is heard after the blast. Windows of surrounding buildings were shattered and nearby cars were damaged, according to the footage.

In Islamabad, Pakistan's President Asif Ali Zardari and Prime Minister Shehbaz Sharif denounced the bombing and praised security forces for quickly responding to the attack and eliminating the attackers.

Balochistan Chief Minister Sarfraz Bugti also condemned the attack, saying security forces returned fire and killed all the assailants involved in the deadly attack in the city. "Terrorists cannot break the nation's resolve through cow-

ardly acts, and the sacrifices of our people and security forces will not go in vain," Bugti said in a statement. He said that his government remains committed to making the province a peaceful and secure place.

Also:

ISLAMABAD: Gunfire erupted during a peace rally in Pakistan-administered Kashmir on Monday, killing at least one person and wounding over two dozen others, police and government officials said.

Local police officer Mohammad Afzal said the shooting happened as hundreds of people marched along a main road in Muzaffarabad, the regional capital. He said some of the wounded were listed in critical condition at hospitals.

Police, government officials and local media blamed armed members of the Awami Action Committee, a civil rights alliance that had called for a strike to demand subsidized food, electricity and other services, for initiating the violence. The government said most residents ignored the strike call, and demonstrations elsewhere remained largely peaceful.

However, the alliance's leader Shaukat Nawaz, in a speech to demonstrators in Kashmir, said most shops remained shut and the protest will continue until the acceptance of their demands. He accused members of the peace rally of initiating the gunfire.

Madagascar's president fires govt

ANTANANARIVO, Madagascar, Sept 30, (AP): Madagascar President Andry Rajoelina fired the prime minister and the rest of his government Monday in response to days of deadly Gen Z-led protests in the Indian Ocean island over the failure of the electricity and water supplies.

Rajoelina said in a speech on national television that Prime Minister Christian Ntsay and other government officials would stay on an interim basis until a new government is formed. He invited applications for government positions and gave a three-day time frame to review proposals for a new

prime minister.
"Your demands have been heard, and I apologize if there are members of the government who have not done the work that the people expected," Rajoelina said.

The protesters had called for the resignation of both Ntsay and Rajoelina, but Rajoelina gave no indication that

Corporation (KPC) declared on Tuesday new prices of liquefied natural gas (LNG), propane, and butane, for October.

In a statement to KUNA, the corporation said a metric ton of propane would be sold for USD 495, in October, and a metric ton of butane for USD 475.

Both propane and butane are used in the petrochemical industry, cooking, heating, and other purposes.

Exports hit 172,000 bpd

Kuwait's oil exports to Japan up 38.9% in Aug

TOKYO, Sept 30, (KUNA): Kuwait's crude oil exports to Japan jumped 38.9 percent in August from a year earlier to 5.33 million barrels, or 172,000 barrels per day (bpd), up for the first time in four months, government data showed

As Japan's third-biggest oil provider, Kuwait supplied 7.8 percent of the Asian nation's total crude imports, compared with 5.5 percent in the same month of last year, the Japanese Natural Resources and Energy Agency said in a preliminary report.

Japan's overall imports of crude oil in August shrank 1.9 percent year-on-year to 2.22 million bpd, down for the third month in a row. Shipments from the Middle East accounted for 95.8 percent of the total, up 1.0 percentage point from the year before.

Saudi Arabia returned to the top spot, with imports from the kingdom increasing 10.4 percent from a year earlier to 967,000 bpd, followed by the United Arab Emirates (UAE) with 908,000 bpd, down 11.3 percent. The US ranked fourth with 69,000 bpd and Qatar fifth with 48,000 bpd, respectively. Japan is the world's-third biggest oil consumer after China and the

KPC also announced, at the request of the Kuwait National Petroleum Company (KNPC), the launch of a tender for consultancy services to conduct technical and financial studies for establishing a new fuel filling station in Mutlaa City, in accordance with the general and special terms outlined in the tender documents. The deadline for submitting bids is October 23.

New regulations require AI firms to disclose safety protocols

California Governor Gavin Newsom signs groundbreaking AI safety law

SACRAMENTO, Sept 30, (AP): California Gov. Gavin Newsom on Monday signed a law that aims to prevent people from using powerful artificial intelligence models for potentially catastrophic activities like building a bioweapon or shutting down a bank system.

The move comes as Newsom touted California as a leader in AI regulation and criticized the inaction at the federal level in a recent conversation with former President Bill Clinton. The new law will establish some of the first-in-the-nation regulations on large-scale AI models without hurting the state's homegrown industry, Newsom said. Many of the world's top AI companies are located in California and will have to follow the requirements.

"California has proven that we can establish regulations to protect our communities while also ensuring that the growing AI industry continues to thrive. This legislation strikes that balance," Newsom said in a statement.

The legislation requires AI companies to implement and disclose publicly safety protocols to prevent their most advanced models from being used to cause major harm. The rules are designed to cover AI systems if they meet a "frontier" threshold that signals they run on a huge amount of computing power.

Such thresholds are based on how many calculations the computers are performing. Those who crafted the regulations have acknowledged the numerical thresholds are an imperfect starting point to distinguish today's highest-performing generative AI systems from the next generation that could be even more powerful. The existing systems are largely made by California-based companies like Anthropic, Google, Meta Platforms and OpenAI.

The legislation defines a catastrophic risk as something that would cause at least \$1 billion in damage or more than 50 injuries or deaths. It's designed to guard against AI being used for activities that could cause mass disruption, such

Companies also have to report to the state any critical safety incidents within 15 days. The law creates whistleblower protections for AI workers and establishes a public cloud for researchers. It includes a fine of \$1 million per violation

It drew opposition from some tech companies, which argued that AI legislation should be done at the federal level. But Anthropic said the regulations are "practical safeguards" that make official the safety practices many companies are already

"While federal standards remain essential to avoid a patchwork of state regulations, California has created a strong framework that balances public safety with continued innovation," Jack Clark, co-founder and head of policy at Anthropic,

The signing comes after Newsom last year vetoed a broader version of the legislation, siding with tech companies that said the requirements were too rigid and would have hampered innovation. Newsom instead asked a group of several industry experts, including AI pioneer Fei-Fei Li, to develop recommendations on

guardrails around powerful AI models.

The new law incorporates recommendations and feedback from Newsom's group of AI experts and the industry, supporters said. The legislation also doesn't put the same level of reporting requirements on startups to avoid hurting innovation, said state Sen. Scott Wiener of San Francisco, the bill's author.

"With this law, California is stepping up, once again, as a global leader on both technology innovation and safety," Wiener said in a statement.

Newsom's decision comes as President Donald Trump in July announced a plan to eliminate what his administration sees as "onerous" regulations to speed up AI innovation and cement the U.S.' position as the global AI leader. Republicans in Congress earlier this year unsuccessfully tried to ban states and localities from

Without stronger federal regulations, states across the country have spent the last few years trying to rein in the technology, tackling everything from deepfakes in elections to AI "therapy." In California, the Legislature this year passed a number of bills to address safety concerns around AI chatbots for children and the use of AI in the workplace.

Labor costs fuel price hikes

Home repair and remodeling costs rise 3.4% year-over-year

LOS ANGELES, Sept 30, (AP): If it seems like its getting more expensive to replace a broken door, kitchen fixtures or upgrade a major appliance, you're not wrong. The cost of home repair and remodeling projects is up compared to a year ago and running ahead of inflation overall, according to a report from data analytics company Verisk

The firm's latest Repair and Remodeling Index jumped 3.4% in the April-June quarter compared to the same period last year. That's a bigger annual increase than the 2.7% rise in inflation in the same period, as measured by the Consumer Price index.

The index, which tracks costs for more than 10,000 home improvement products, including appliances, doors, plumbing and windows, showed a roughly 0.6% increase from the January-March quarter.
"While costs did continue to rise,

they rose at a slower rate than in the first quarter,," said Greg Pyne, vice president of Pricing at Verisk Property Estimating Solutions.

Much of the increase in home repair and remodeling costs appears to be driven primarily by higher labor costs for repair and remodeling work, Verisk noted.

The second-quarter jump in costs for home improvement products coincided with the Trump administration's broad rollout of tariffs on imported goods from many of the nation's major trading partners. But the tariffs didn't have the expected impact given they were postponed several times and didn't fully take effect until early August, midway through the third quarter.

However, homeowners looking to replace cabinetry could soon see prices increase sharply, following a new vol-ley of tariffs announced by President Donald Trump last week that includes a 50% import tax on kitchen cabinets and bathroom vanities due to kick in on Wednesday.

The most labor-intensive types of home repair or remodeling work registered the biggest quarterly increases in labor costs. For example, the cost of replacing tile flooring rose 1.2%, while the cost of remodeling a primary bath or replacing vinyl siding each rose 1% in the April-June period from the previous quarter.

Nearly all of the 31 categories of repair and remodeling work tracked by Verisk saw costs increase at least slightly.

The latest index puts costs for repair and remodeling at almost 62% higher than they were 10 years ago and more than 73% higher than the first quarter of 2013, when the index debuted.

After declining the past two years, homeowner spending on maintenance and home improvement projects increased in the first half of this year, according to researchers at Harvard University.

The university's Joint Center for Housing Studies' most recent leading indicator of remodeling activity, or LIRA, estimates spending hit \$510 billion in the second quarter, a 1.8% increase from a year earlier. However, the researchers project that growth in spending on home improvement and maintenance will slow in 2026, citing weakness in the housing market and slower construction of new homes.

The housing market has been in a slump since 2022, when mortgage rates began climbing from historic lows. Sales of previously occupied U.S. homes sank last year to their lowest level in nearly 30 years. And, so far this year, sales are running below where they were at this time in 2024.

China's factory activity contracts for 6th month in Sept, PMI at 49.8

Experts note factories face margin pressure

HONG KONG, Sept 30, (AP): China's factory activity shrank for a sixth straight month in September, the longest slump since 2019, an official report said Tuesday.

The official manufacturing purchasing managers index, or PMI, improved to 49.8 from 49.4 in August. But it remained below the 50-cutoff level between contraction and expansion on a scale of 0 to 100.

A private sector PMI survey by the credit research and rating startup RatingDog was more upbeat, with September's overall PMI rising to 51.2 from 50.5 in August.

The mixed manufacturing measures reflect persisting sluggish domestic demand and uncertainties over trade tensions with the United

More detailed data measuring new orders and production saw month-on-month improve-

"The September PMI reads from China offered a picture that looked less like a coherent growth engine and more like a car with one cylinder firing while another misfires," Stephen Innes of SPI Asset Management said in a com-

Companies are under pressure from price cutting amid rough competition, he said.

"Factories are moving more goods, but they're being forced to do it at thinner margins, like street vendors selling more bowls of noodles at half price just to keep the crowd coming," Innes said.

The latest data show China's economy is gaining momentum with output accelerating slightly, said National Bureau of Statistics chief statistician Huo Lihui.

China's official manufacturing PMIs first slipped back into contraction in April as trade friction with U.S. President Donald Trump's administration heated up after he took office.

The two sides are still slowly working their way toward a broad trade agreement after exchanging threats of sky-high tariffs on each oth-

A pause in steep U.S. tariff hikes on China has been extended until November, while a Sept. 19 phone call between Trump and Chinese leader Xi Jinping offered glimmers of hope for improving relations.

A truce hinges largely on a widely anticipated U.S. proposal for transferring ownership of Tik-Tok to a U.S. company from its Chinese owner ByteDance. That would also require Beijing's A face-to-face meeting between Trump and

Xi is set for the end of October in South Korea on the sidelines of an annual summit of the Asia-Pacific Economic Cooperation forum. China's economy has remained in the d

drums, bogged down by a prolonged slump in the property sector, elevated unemployment and weak household spending.

Some economists are hoping that a rate cut by China's central bank by the end of the year could help encourage more spending and investment. This month, the People's Bank of China left its key lending rates unchanged following the U.S. Federal Reserve's rate cut for the first time this year.

ADB cuts developing Asia growth to 4.8% for 2025

TOKYO, Sept 30, (KUNA): The Asian Development Bank (ADB) on Tuesday cut its growth forecast for developing Asia to 4.8 percent for 2025 from its earlier projection amid a new global trade environment posed by US tariffs.

In an update of its Asian Development Outlook 2025, the Manila-based lender downgraded its April forecast of 4.9 percent growth for this year, and revised down next year's view to 4.5 percent from 4.7 percent.

Developing Asia covers 46 economies in Central Asia, East Asia, South Asia, Southeast Asia and the Pacific, but excludes the industrialized countries of Japan, Australia and New Zealand. "US tariffs have settled at histori-

cally high rates and global trade uncertainty remains at elevated levels," said ADB Chief Economist Albert Park in a statement. "Growth in developing Asia and the Pacific has remained resilient this year

thanks to strong exports and robust external environment is impacting the Amid the new global trade environment, it's crucial for governments to con-

tinue promoting sound macroeconomic management, openness, and further regional integration," Park said The ADB said higher tariffs im-

posed by the US and elevated trade uncertainty are expected to weigh on the region's growth.

"The main risks to developing Asia and the Pacific's outlook include continuing uncertainty around US trade policy, particularly regarding possible sectoral tariffs on semiconductors and pharmaceuticals, as well as unresolved US-China trade negotiations.'

China's growth prospects for both 2025 and 2026 are 4.7 percent and 4.3 percent, unchanged from April estimates, as policy support is expected to cushion the impact of higher tariffs and continued weakness in the property market, according to the ADB.

The bank trimmed its growth forecast for India by 6.5 percent this year and next year from its April forecasts of 6.7 percent and 6.8 percent, respectively.

The steep US tariffs levied on Indian exports starting in August are expected to weigh on growth, it explained. Economies in Southeast Asia are

seeing the largest downgrades to growth forecasts amid weaker global demand and elevated trade uncertainty. Growth in the subregion is now r

jected at 4.3 percent for 2025 and 2026 -- down 0.4 percentage points for each year compared with April's forecasts.

Algorithm stays in China, licensed to US

TikTok sale puts app's algorithm in spotlight – a social media expert explains how the For You Page works and what changes are in store

President Donald Trump announced on Sept. 19, 2025, a preliminary agreement for the sale of a majority stake in TikTok from Chinese tech giant ByteDance to a group of U.S. investors following Trump's negotiation with Chinese leader Xi Jinping.

The deal would create a new U.S.-only version of the app, bringing it into compliance with a law signed by former President Joe Biden on April 23, 2024, and upheld by the Supreme Court on Jan. 17, 2025. Specifics of the deal remain to be hammered out, but some details are emerging. These include what will happen to the video-sharing app's core algorithm - and what that means for TikTok's millions of U.S.

The Chinese government has indicated it will not permit ByteDance to sell the algorithm, because it is classified as a controlled technology export, per Chinese law. Meanwhile, U.S. tech industry executives and some lawmakers say compliance with the law requires the algorithm to be under American control. The deal as proposed includes licensing the algorithm so that it remains Chinese intellectual property while the U.S. version of the app continues to use the technology.

TikTok's For You Page algorithm is widely considered the most important part of the app. As one analyst put it: "Buying TikTok without the algorithm would be like buying a Ferrari without the

The algorithm's value lies in its uncanny capacity to anticipate users' content preferences. Many users claim it knows them better than they know themselves - a sentiment that has evolved into a curious mix of spiritual belief and conspiracy theorizing, as my colleagues

and I have documented. Other scholars have similarly noted that users feel more intimately seen and known by TikTok's algorithm than those powering other popular platforms.

I have studied social media algorithms for nearly a decade, exploring how our relationships with them have evolved as they become increasingly entwined with daily life. As both a social media scholar and Tik-Tok devotee, I want to shed some light on how the algorithm works and how the app is likely to change in the wake of its sale.

In some ways, the TikTok algorithm does not differ significantly from other social media algorithms. At their core, algorithms are merely a series of steps used to accomplish a specific goal. They perform mathematical computations to optimize output in service of that goal. There are two layers to the TikTok algorithm. First, there is the abstract layer that defines the outcome developers wish to accomplish.

An internal document shared with The New York Times specified that TikTok's algorithm optimizes for four goals: "user value," "long-term user value," "creator value" and "platform value." But how do you turn these goals into math? What does an abstract

concept like "user value" even mean? It's not practical to ask users whether they value their experience every time they visit the site. Instead, TikTok relies on proxy signals that translate abstract outcomes into quantifiable measures - specifically, likes, comments, shares, follows, time spent on a given video and other user-behavior data. These signals then become part of an equation to predict two key concrete outcomes: "retention," or the likelihood that a user will return to the site, and "time spent" on the app.

The TikTok For You Page algorithm relies on machine learning for predicting retention and time spent. Machine learning is a computational process in which an algorithm learns patterns in a dataset, with little or no human guidance, to produce the best equation to predict an outcome. Through learning patterns, the algorithm determines how much individual data signals matter for coming up with a precise prediction.

A Wall Street Journal investigation found that the amount of time users spend watching each video plays a large role in how the algorithm chooses videos it suggests to users. Using the equation it has generated to predict retention and time spent, the algorithm assigns a score to each video and ranks possible videos that could be shown to the user by this score. The higher the score for an individual user, the more likely the video will appear in their feed.

Of course, content characteristics and other users additionally inform recommendations, and there are other subprocesses folded into the equation. This step is where algorithmic moderation usually comes in. If a video looks like engagement bait or has excessive gore, for example, the content's score will be penalized.

The sale has not been finalized, but the algorithm's fate is coming into focus. According to reports, the United States-only version of the algorithm will be retrained on only U.S. users' data. Users won't need to download a new version of the app for the changed algorithm to

Even though the algorithm itself is the same as before, it's fairly certain that TikTok will change. I see two key reasons for change. First, the proposed app's U.S.-only user population will alter the

makeup of the underlying dataset informing algorithmic recommendations on an ongoing basis. As the kinds of content come to reflect American cultural preferences, values and behaviors, the algorithm may be slightly different as it "learns" new patterns.

Though users are more likely to stick with the app because they don't need to download a new version, not all users will choose to, especially if it is seen as under the control of Trump's allies. Under the current deal, Oracle Corp. and the U.S. government would oversee the algorithm's retraining. This arrangement suggests that the U.S. government may have significant influence over how the app works.

The deal would give an 80% share to U.S. investors, including 50% to new investors Oracle, Silver Lake and Andreessen Horowitz. These investors have connections to Trump, and an apparent provision of the

deal allows the U.S. government to select one board member. These influences raise the possibility of a boycott from left-leaning users and creators similar to earlier boycotts of Target for rolling back DEI measures and Disney after the since-reversed suspension of Jimmy Kimmel. This may result in a user population - and data - reflective of a narrower realm of interests and ideologies.

Second, it's possible that the majority shareowners of the new app will decide to adjust the algorithm, particularly when it comes to content moderation. The new owners may wish to modify TikTok's Community Guidelines according to their view of acceptable and unacceptable speech.

For example, TikTok's current Community Guidelines prohibit misinformation and work with independent fact-checkers to assess the accuracy of content. While Meta used to follow a similar approach for Instagram and Facebook, in January 2025 Meta announced that it would end its relationships with independent fact-checkers and loosen content restrictions. YouTube has similarly relaxed its content moderation this

With reports that the U.S. government would oversee retraining the algorithm, there's a possibility that not only the new investors but also the government itself could influence how content is prioritized and

The bottom line is algorithms are highly sensitive to context. They reflect the interests, values and worldviews of the people who build them, the preferences and behaviors of people whose data informs their models and the legal and economic contexts they operate within.

This means that while it's difficult to predict exactly what a U.S.-only TikTok will be like, it's safe to assume it will not be a perfect mirror image of the current app. (AP)

'Movie production has been stolen from Hollywood'

Trump threatens 100% tariff on films made outside US

WASHINGTON, Sept 30, (AP): President Donald Trump says he will slap a 100% tax on movies made outside the United States - a vague directive aimed at protecting a business that America already dominates.

Claiming that movie production "has been stolen" from Hollywood and the US, Trump posted on his Truth Social platform that "I will be imposing a 100% tariff on any and all movies that are made outside of the United States.

It was unclear how these tariffs would operate, since movies and TV shows can be transmitted digitally without going through ports. Also unclear is what it would mean for US movies filmed on foreign locations think James Bond and Jason Bourne or what legal basis the president would claim for imposing the tariffs.

The president had first issued the threat back in May. He has yet to specify when the tariff might go into effect.

Movies are an odd battleground for a US trade war. "Unlike any other country's film industry, US movies are

the most accessible, well-known, and best performing due to the numerous language options and worldwide reach provided by US-based studios," trade

analyst Jacob Jensen of the centerright American Action Forum wrote in a July commentary.

In movie theaters, American-pro-

duced movies overwhelmingly dominate the domestic marketplace. Data from the Motion Picture Association also shows that American films made \$22.6 billion in exports and \$15.3 billion in trade surplus in 2023 - with a recent report noting that these films "generated a positive balance of trade in every major market in the world" for the US.

Barry Appleton, co-director of the Center for International Law at the New York Law Center, warned that other countries may retaliate with levies on American movies or other services. In movies, "Brand America is way, way ahead," he said. "What this policy does is actually cook the golden goose that's laying the golden eggs.

Tariffs are Trump's go-to solution for America's economic problems, a tool he likes to use to extract concessions from other countries. Reversing decades of U.S. support for lower trade barriers, he's slapped double-digit tariffs on imports from almost every country on earth. And he's targeted specific products, including most recently pharmaceuticals, heavy trucks, kitchen cabinets and bathroom vanities.

Unlike other sectors that have recently been targeted by tariffs, movies go beyond physical goods, bringing larger intellectual property ramifications into question. Here's what we know.

Trump has cited national security concerns, a justification he's similarly used to impose import taxes on certain countries and a range of sector-specific

In May, Trump claimed that the American movie industry is "DYING to a very fast death" as other countries offer "all sorts of incentives" to draw filmmaking away from the US.

In recent years, US film and television production has been hampered between setbacks from the COVID-19 pandemic, the Hollywood guild strikes of 2023 and the recent wildfires in the Los Angeles area. Incentive programs have also long-influenced where movies are shot both abroad and within the US, with more production leaving California to states like Georgia and New Mexico - as well as countries like Canada.

At the same time, international markets make up a large chunk of Hollywood's total box office revenue - accounting for over 70% last year, according Heeyon Kim, an assistant professor of strategy at Cornell University. She warned that tariffs and potential retaliation from other countries impacting this industry could result in billions of dollars in lost earnings and thousands of jobs.

"To me, (this) makes just no sense,"
Kim previously told The Associated
Press, adding that such tariffs could
"undermine otherwise a thriving part

of the US economy."
The International Alliance of Theatrical Stage Employees, which represents behind-the-scenes entertainment workers across the U.S. and Canada, said in May that Trump had "correctly recognized" the "urgent threat from international competition" that the American film and television industry faces today.

Combs sentence

Prosecutors push for over 11 years

NEW YORK, Sept 30, (AP): Prosecutors urged a New York federal judge Tuesday to send Sean "Diddy" Combs to prison for over 11 years following his conviction on prostitution-related charges, citing one of his accusers who said she lives in fear of the music mogul's release from detention.



of conviction serious and have warranted sentences over ten years in multiple cases for defendants who, like Sean Combs,

"His crimes

gaged in violence and put others in fear," they wrote in a presentence submission requesting at least 11 years and

three months in prison. They filed their sentencing recommendation shortly after midnight, including letters from some of his accusers describing how his violence and demands had impact-

They called Combs "unrepentant" and said Combs had conceded his acts of violence and abuse throughout his trial but "incred ibly, ... he now argues that his victims should shoulder the blame."

Combs, 55, has remained in custody since his July conviction on charges related to arranging for men to travel to hotels or private residences, where they were directed to engage in intimate activities with his girlfriends.

These elaborate, days-long, drug-fueled gatherings were often recorded by Combs. Defense attorneys have requested a sentence of no more than 14 months in prison.

Sentencing is scheduled for Friday. In July, Combs was convicted of two charges for violating the Mann Act, which outlaws interstate commerce related to prostitution, for arranging the paid sexual encounters between his girlfriends and male workers. Each count carries a maximum penalty of 10 years in

The same jury acquitted the Bad Boy Records founder of racketeering conspiracy and sex trafficking charges that could have resulted in a life sentence.

Last week, the defense submitted its presentence arguments, saying Combs has suffered enough during his nearly 13 months behind bars that he should be freed soon.

They wrote that he became a changed man in a Brooklyn federal lockup, where he has been under constant suicide watch and learned to react calmly to threats rather than violently, even when a fellow inmate confronted him with a shiv.

They said Combs has realized that his overuse of drugs, including some prescribed by doctors. had contributed to violent acts he participated in.

Prosecutors said Combs was now trying to cast himself as a victim.

"He is not the victim," they wrote. "The Court should focus on the very real effects that the defendant's conduct had on the lives of the actual victims, his victims."

At trial, two of Combs' former girlfriends testified that they felt forced to participate in the drugfueled parties with male workers as Combs watched and sometimes filmed.

R&B singer Casandra "Cassie" Ventura described being physically abused by Combs when she upset him during their decadelong relationship. Another former girlfriend, testifying under the pseudonym "Jane," said she felt pressured to take part in intimate acts involving other men. She testified that Combs, in a fit of rage, once put her in a chokehold and punched her in the face

Rebellion reloaded in 'One Battle After Another'

Anderson's epic thriller lights a fire

LOS ANGELES, Sept 30, (AP): Paul Thomas Anderson spent about 20 years writing "One Battle After Another." After two decades, it's never felt more relevant.

The epic action thriller, inspired by Thomas Pynchon's "Vineland," hit theaters recently. With a running time of 2 hours and 50 minutes, "One Battle After Another" wastes no time immersing audiences in its politically charged world.

The revolution will not be televised, but it will be placed at the front and center of Anderson's film. The director isn't there to make his audience comfortable, star Teyana Taylor says, as he zeroes in on themes of immigration, racism and systemic corruption showcased at their most absurd.

"I feel like PTA calls out a lot of things that are trying to get swept under the rug," Taylor told The Associated Press, referring to the director by his nickname. "And that's what I respect. This is really waking, shaking and baking some s---. Like, you gotta shake the table."

Taylor's character, Perfidia Beverly Hills, is a member of the Weather Underground-inspired French 75 revolutionary group. From the film's first scene, we see the French 75 take matters into their own hands, liberating undocumented detainees, destroying corrupt political offices and launching their own form of justice, one right after the other. The group is peppered with members portraved by musicians-turned-actors like Dijon Duenas, Alana Haim, and Shayna McHayle and notable actors like Regina Hall and Wood Harris.

'I mean, this movie is based on some of the revolutionaries and anarchists of the late '60s, the Weathermen that were fighting for civil rights, environmentalism too at the time, capitalism, Viet-

nam," star Leonardo DiCaprio told the AP. "But it's about the implosion of that too, about the extremes that people go to for their own ideology."

DiCaprio portrays Bob Ferguson, known in the French 75's initial scenes as Ghetto Pat, a radical with deep knowledge of explosives and undying devotion to both Perfidia and the revolution. Together, Perfidia and Pat seem unstoppable, until the racist and xeno-phobic Col. Steven Lockjaw (Sean Penn) sets out to end the group to fuel his rise to power.

"And this is a movie, fast-forward, in today's day and age, where you see this sort of systematic breakdown that comes from it, if it's not done with grace and purity and consistently, the whole sort of- our revolution is dismantled and our past comes back to haunt us," said DiCaprio. "So that's what I love that Paul did. He shows extremity on both sides of the spectrum and how no one seems to be communicating or getting things done in the right way nowadays.

Future

The film jumps 16 years into the future. Perfidia has disappeared and DiCaprio's character lives under a new alias in a sanctuary city as a paranoid, stoner dad with his teenage daughter, Willa (newcomer Chase Infiniti). Everything is seemingly mundane until Lockjaw reappears, forcing the father-daughter duo on the run.

"There's a lot of moments where I was like, I don't know if I'm gonna be able to do this, but thankfully I had amazing scene partners and a great support system to kind of assure me that I was here to do my job and I knew exactly that I could do it,'

"One Battle After Another" is Anderson's most

expensive project to date and shot entirely in VistaVision - a decades-old format that's been revived in re-

cent years by movies like "The Brutalist." Benicio del Toro, who plays karate instructor Sensei Sergio St. Carlos, says blending improv scenes with DiCaprio and shooting in the antique format forced the actors and Anderson to have unwavering faith in each other's decisions, knowing they only had a limited amount of takes. His character, also the head of an undocumented migrant hideaway, hopes his storyline will be an example of showcasing compassion beyond political affiliation.

"I wouldn't be pompous enough to say movies change people. But it might just open a door that leads to another door that leads to a hallway to another door," he said.

DiCaprio says portraying Bob Ferguson is his own version of freedom of speech, allowing him to "shine a light on certain issues about humanity and different subject matters."

"I'm always searching for a movie that doesn't necessarily have meaning but is thought-provoking, that holds a mirror up to who we are as a society, as people, of humanity," said DiCaprio. "And that's what I think the heart of this movie is, is how to find humanity in a world that is incredibly divided. . It's not a film where there's a specific sort of ideology that Paul is putting into it. It's saying this is who we are, this is the world we live in.

For Taylor, the 20-year-old script's relevance is evidence of American history continuing to repeat

"It didn't need a change; it didn't need to be updated because it was all still so relevant," said Taylor. "It's time to wake up, and it's time to shed light

on the necessary conversations.

MADRID: Spanish club Valencia said on Monday it filed a lawsuit against Netflix claiming falsehoods in a documentary about Brazil player Vinícius Júnior.

Valencia said the documentary mistakenly accused a large group of Valencia fans of making racist chants against the Real Madrid forward in a La Liga match in 2023.

The club filed the lawsuit after its public demands for corrections by the documentary's production company were not fulfilled. The lawsuit is against Netflix

and the production company for damaging "Valencia's honor." It seeks financial compensation, corrections of the subtitles in the documentary, and the publication of the sentencing, the club said.

Valencia first threatened the lawsuit this year. At the time, Vinícius' representatives said the player would not get involved because the demand was against Netflix and the producers of the

documentary.

A request for comment sent to Netflix was not immediately an-

The documentary includes a social media video showing what appeared to be a large crowd at Mestalla Stadium chanting at Vinícius. The video has the word "mono," Spanish for monkey, in the subtitles. But Valencia claims the fans were actually chanting "tonto,"

which is Spanish for silly. Then-Real Madrid coach Carlo Ancelotti was quick to accuse the Valencia fans of racially insulting Vinícius, but later apologized after saying he realized it wasn't the entire stadium chanting the word monkey.

The museum currently presents more than 200 stolen cultural objects, ranging from historical artefacts and architectural elements to ancient inscriptions and currencies, as well as musical instruments, rare books, manuscripts and archives. (Xinhua)

Judge stops Trump plan to cut hundreds of VOA jobs

YouTube to pay \$24.5M in Trump account suspension case

NEW YORK, Sept 30, (AP): Google's YouTube has agreed to pay \$24.5 million to settle a lawsuit President Donald Trump brought after the video site suspended his account following the Jan. 6, 2021 attacks on the Capitol following the election that resulted in him leaving the White House for

The settlement of the more than four-year-old case earmarks \$22 million for Trump to contribute to the Trust for the National Mall and a construction of a White House ballroom, according to court documents filed Monday. The remaining \$2.5 million will be paid to other parties involved in the case, including the writer Naomi Wolf and the American Conservative Union.

Alphabet, the parent of Google, is the third major technology company to settle a volley of lawsuits that Trump brought for what he alleged had unfairly muzzled him after his first term as president ended in January 2021. He filed similar cases Facebook parent Meta Platforms and Twitter before it was bought by billionaire Elon Musk in 2022 and

Meta agreed to pay \$25 million to settle Trumps' lawsuit over his 2021 suspension from Facebook and X agreed to

settle the lawsuit that Trump brought against Twitter for \$10 million. When the lawsuits against Meta, Twitter and YouTube were filed, legal experts predicted Trump had little

After buying Twitter for \$44.5 billion, Musk later became major contributor to Trump's successful 2024 campaign that resulted in his re-election and then spent several months leading a cost-cutting effort that purged thousands of workers from the federal government payroll before the two had a bitter falling out. Both Alphabet CEO Sundar Pichai and Meta CEO Mark Zuckerberg were among the tech leaders who lined up behind Trump during his second inauguration in January in a show of solidarity that was widely interpreted as a sign of the industry's intention to work more closely with the president than during his first administration.

ABC News, meanwhile, agreed to pay \$15 million in December toward Trump's presidential library to settle a defamation lawsuit over anchor George Stephanopoulos' inaccurate on-air assertion that the president-elect had been found civilly liable for raping writer E. Jean Carroll. And in July, Paramount decided to pay Trump \$16 million to settle a lawsuit regarding editing at CBS' storied "60 Minutes" news

The settlement does not constitute an admission of liability, the filing says. Google confirmed the settlement but declined to comment beyond it.

Meanwhile, a federal judge agreed Monday to temporarily suspend the Trump administration's plan to eliminate hundreds of jobs at the agency that oversees Voice of America, the government-funded broadcaster founded to counter Nazi propaganda during World War II.

US District Judge Royce Lamberth in Washington, D.C., ruled that the U.S. Agency for Global Media cannot implement a reduction in force eliminating 532 jobs for full-time government employees on Tuesday. Those employees represent the vast majority of its remaining staff.

Kari Lake, the agency's acting CEO, announced in late August that the job cuts would take effect Tuesday. But the judge's ruling preserves the status quo at the agency until he rules on a plaintiffs' underlying motion to block the reduction in force.

Lamberth previously ruled that President Donald Trump's Republican administration must restore VOA programming to levels commensurate with its statutory mandate to "serve as a consistently reliable and authoritative source of news.' He also blocked Lake from removing Michael Abramowitz

Saint Laurent blooms with oversized drama in Paris

PARIS, Sept 30, (AP): At Saint Laurent, Anthony Vaccarello dialed up the drama Monday night at Paris Fashion Week with a set of gigantic white flowers that loomed like a cinematic backdrop. If the blooms hinted at delicacy, the clothes told another story: big, bold, and unafraid of excess. Madonna was in attendance, and at times she stole the focus - a burst of razzmatazz on and off the runway that amped the

show's already operatic charge. Floor-sweeping gowns rippled with frills, evoking 1970s archival pieces and petals unfurling at twilight. They weren't garments so much as visual arguments

- "beauty as plural," the house notes declared - gowns that embodied Vaccarello's belief that esthetics are a

The designer's penchant for oversize, a throughline of his tenure, reached new heights. Giant crisp bow collars, sharp enough to cut the air, swung the silhouettes firmly into the early '80s, echoing the exaggerated power shoulders that have become a Saint Laurent signature under his watch. Sheeny trench coats, meanwhile, clung lean and skeletal, their crinkled fabric folding like the contours of

Vaccarello mined Saint Laurent's heritage - echoes of John Singer Sargent's "Madame X," of Mapplethorpe's leather-clad heroines, of Rive Gauche's bourgeois chic but stripped it of nostalgia. He prefers what he has often called "no ornamentation, no decoration, no ... nothing," letting the silhouette itself speak.

It was pure theater. A Saint Laurent woman who is both heroine and classic, a figure of resistance and allure, swept across the runway. Vaccarello reminded the industry why his Saint Laurent is not just about clothes, but about style as discourse - garments as arguments, couture as conversation.

Latin representation meets NFL politics

Bad Bunny to bring Latin pride to Bowl show

LOS ANGELES, Sept 30, (AP): The selection of Bad Bunny to headline the Super Bowl halftime show is about more than music.

The move signals a cultural spotlight for Latin identity at America's mostwatched television event. It also raises fresh questions about how much space there will be for his trademark symbolism and social commentary - including his past criticism of President Donald Trump - given the NFL's history of keeping performances tightly managed.

Here are some things to know about the selection.

The halftime show is a collaboration between the NFL, Roc Nation and Apple Music.

Roc Nation, Jay-Z's entertainment company, has curated performers since 2019 and returns alongside veteran producer Jesse Collins. Apple Music distributes the performance, while the NFL ultimately controls the stage,

broadcast and branding. Artists don't get a paycheck for performing. However, their payoff is global exposure. That imbalance gives the league leverage, though history shows that high-powered stars sometimes defy the league's guardrails. The NFL has a track record of pushing back when artists get political. However, some performers don't always comply.

- In 2020, the league asked Jennifer Lopez to cut a segment featuring children in cages, a critique of US immigration policies. She refused.

- In 2022, it was reported that Dr. Dre and Eminem were both advised not to kneel or reference police, but they went forward.

- Rapper M.I.A. flashed a middle finger during Madonna's set, earning a hefty fine in 2012. She and the NFL ultimately reached a settlement ending their multimillion dollar dispute a couple years later.

While Bad Bunny is a known hitmaker, he's also an artist who ties his music to Puerto Rican identity, colonial politics and immigrant struggles. His Super Bowl announcement included a pointed dedication: "This is for my people, my culture, and our

That alone sets the stage for a performance that could carry layered meanings far beyond spectacle.

In his career, Bad Bunny has become one of the world's most streamed artists with albums such as "Un Verano Sin Ti," an all-Spanish-language

The 31-year-old artist born Benito Antonio Martínez Ocasio has won three Grammys and 12 Latin Grammys. He has become a global ambassador for Latin music, starred in films such as "Bullet Train," "Caught Stealing" and "Happy Gilmore 2," and collaborated with top fashion houses. He enters November's Latin Grammys as the leading nominee with 12, dethroning producer and songwriter Édgar

Bad Bunny has been vocal in his opposition to Trump and his policies. In the final weeks of the 2024 campaign, he backed former Vice President Kamala Harris after a comedian at Trump's Madison Square Garden rally mocked Puerto Rico as a "floating island of garbage.

Days later, Bad Bunny posted a video showcasing Puerto Rico's beaches and artists, captioned simply: "garbage."

Since Trump took office, Bad Bunny's criticism hasn't slowed. This year, he shared an Instagram video appearing to show immigration agents making arrests in Puerto Rico, with the voice behind the camera cursing the agents.

On July 4, he released the video for 'NUEVAYoL", featuring a Trumplike voice apologizing to immigrants: "This country is nothing without the

Promote 'healthy Al use'

ChatGPT gets 'parental' controls for teen safety

LONDON, Sept 30, (AP): OpenAI said Monday it's adding parental controls to ChatGPT that are designed to provide teen users of the popular platform with a safer and more "age-appropriate" experi-

The company is taking action after AI chatbot safety for young users has hit the headlines. The technology's dangers have been recently highlighted by a number of cases in which teenagers took their lives after interacting with ChatGPT

In the United States, the Federal Trade Commission has even opened an inquiry into several tech companies about the potential harms to children and teenagers who use their AI chatbots as companions.

In a blog post posted Monday, OpenAI outlined the new controls for parents. Here is a breakdown: Getting started

The parental controls will be available to all users, but both parents and teens will need their own accounts to take advantage of them.

To get started, a parent or guardian needs to send an email or text message to invite a teen to connect their accounts. Or a teenager can send an invite to a parent. Users can send a request by going into the settings menu and then to the "Parental controls" section.

Teens can unlink their accounts at any time, but parents will be notified if they do

Automatic safeguards Once the accounts are linked, the teen account will get some built-in protections, OpenAI said.

Teen accounts will "automatically get additional content protections, including reduced graphic content, viral challenges, sexual, romantic or violent role-play, and extreme beauty ideals, to help keep their experience age-appropriate," the company said.

Parents can choose to turn these filters off, but teen users don't

have the option.

OpenAI warns that such guardrails are "not foolproof and can be bypassed if someone is intentionally trying to get around them." It advised parents to talk with their children about "healthy AI use." Adjusting settings

Parents are getting a control panel where they can adjust a range of settings as well as switch off the restrictions on sensitive content mentioned above.

For example, does your teen stay up way past bedtime to use ChatGPT? Parents can set a quiet time when the chatbot can't be

Other settings include turning off the AI's memory so conversations can't be saved and won't be used in future responses; turning off the ability to generate or edit images; turning off voice mode; and opting out of having chats used to train ChatGPT's AI mod-

Get notified

OpenAI is also being more proactive when it comes to letting parents know that their child might be in distress.

It's setting up a new notification system to inform them when something might be "seriously wrong" and a teen user might be thinking about harming themselves.

A small team of specialists will review the situation and, in the rare case that there are "signs of acute distress," they'll notify parents by email, text message and push alert on their phone - unless the parent has opted out.

OpenAI said it will protect the teen's privacy by only sharing the information needed for parents or emergency responders to provide

help.
"No system is perfect, and we cometimes raise know we might sometimes raise an alarm when there isn't real danger, but we think it's better to act and alert a parent so they can step in than to stay silent," the company said.

Stevens postpones tour

Parton postpones Vegas shows over health issues

NEW YORK, Sept 30, (AP): Dolly Parton has postponed her first Las Vegas residency in 32 years, citing "health challenges," the country legend shared on social media Sunday night.

She did not provide specific details, writing, "As many of you know, I have been dealing with some health challenges, and my doctors tell me that I must have a few procedures. As I joked with them, it must be

time for my 100,000-mile check-up, although it's not the usual trip to see my plastic surgeon!'

Parton added that she is postponing the shows because she is "not going to be able to rehearse and put together the show that I want you to see. You pay good money to see me perform, and I want to be at my best for you."

She was scheduled to perform six shows at The Colosseum at Caesars Palace for "Dolly: Live in Las Vegas" between Dec. 4 and Dec. 13, overlapping with the National Finals Rodeo. Her dates have been moved to next year - Sept. 2026.

Tickets are valid for the new dates and refunds will be available, her state-

"Don't worry about me quittin' the business because God hasn't said anything about stopping yet," she said. "But I believe he is telling me to slow down right now so I can be ready for

more big adventures with all of you." Parton performs on occasion but hasn't toured since her "Pure & Simple Tour" ended in 2016. But she's remained as busy as ever: On. Nov. 11, she will release a new book, "Star of the Show: My Life on Stage." And a new stage musical inspired by her life story is set to land on Broadway

Cat Stevens, who also goes by Yusuf, has postponed the North American leg of his book tour due to unspecified visa issues, the singer announced on social media Monday The Rock & Roll Hall of Fame

member was set to tour in support of his book, "Cat on the Road to Findout," which will release in the US on Oct. 7 and was made available in the UK earlier this month. The book release won't be impacted, Stevens wrote, noting that "books don't need

Stevens is the latest in a string of international musicians and athletes impacted by visa issues, as fees have increased in the past year and processing times have slowed.

Stevens wrote that his team waited months for visa approvals, but "at this point, the production logistics necessary for my show cannot be arranged in time.'

"I am really upset!" Stevens wrote on social media. "Not least for my fans who have bought tickets and made travel plans to see me perform.

Representatives of Stevens did not immediately respond to The Associated Press' request for comment.

The singer's tour was set to start Oct. 2 in Philadelphia and had various stops scheduled across the country for the rest of the month. His Oct. 8 tour stop in Toronto, Canada was also postExperts to share research, treatment

KUWAIT CITY, Sept 30: The Kuwait Society of Hematology announced it will hold an advanced scientific meeting on "Proliferative Blood Tumors and Myelodysplastic Diseases" on Saturday at the Salwa Sabah Al-Ahmad Conference Hall, with the participation of prominent international and regional experts.

Head of the conference organizing committee Dr. Ahmed Al-Abdulkareem told reporters that the event aims to review the latest developments in diagnosing and treating myeloproliferative neoplasms (MPNs) and myelodysplastic syndromes (MDS).

Speakers from the United Kingdom and the United States, along with local specialists, will participate in the event to strengthen international scientific cooperation and improve healthcare for patients with these complex conditions.

Dr. Al-Abdulkareem stressed that the scientific program includes interactive sessions and specialized discussions on modern techniques in molecular genetics, early diagnosis, and innovative treatments, along with real-life clinical case reviews and the latest clinical trial results.

He expressed hope that the meeting will achieve its objectives by serving as an interactive platform for exchanging experiences, applying acquired knowledge in medical practice, and exploring new treatment strategies for patients with rare blood diseases in Kuwait and the Arab world.

Dr. Al-Abdulkareem emphasized that the course goes beyond being just a scientific meeting, as it is an open invitation to physicians and researchers to embark on an advanced knowledge journey aimed at pushing the boundaries of innovation and achieving a qualitative shift in the field of hematology.

Call for prevention, lifestyle change

Kuwait doctors urge action amid rising rates of heart and metabolic diseases

KUWAIT CITY, Sept 30: Head of the Lipid Diseases Unit at Sabah Al-Ahmad Cardiac Center and member of the Kuwait Cardiac Society Dr. Ahmed Al-Sarraf revealed the high rates of heart and metabolic diseases in Kuwait, and called for urgent action from both physicians and society, reports Al-Seyassah daily.

Dr. Al-Sarraf affirmed that early prevention and adopting a healthy lifestyle represent the first line of defense against these conditions.

He said this in a statement he issued on the sidelines of the Second Kuwait Conference on Cardiometabolic Diseases held recently with the participation of doctors and experts from Kuwait and abroad, as well as interna-

Dr. Al-Sarraf emphasized that hosting the Second Kuwaiti Conference on Cardiometabolic Diseases highlights Kuwait's commitment to promoting scientific research and exchanging expertise with international specialists, thereby contributing to the development of modern treatment and preventive strategies.

He highlighted that the statistics are alarming and that the conference covered several important scientific topics, including obesity and its cardiac and metabolic complications, diabetes and its impact on the heart, high cholesterol and triglycerides and methods of control, precision medicine and advances in modern treatments, as well as the use of Artificial Intelligence to predict heart disease risks.

845 dengue cases in Bangladesh

Pakistan's polio fight set back by two new cases

KARACHI, Pakistan, Sept 30, (Agencies): Pakistan reported two new polio cases in the southern province of Sindh, health officials said Monday, a blow to efforts aimed at eradicating the crippling disease among children. This brings the total to 29 cases across the country since January, despite several immunization drives.

The virus was detected in two young girls in the cities of Badin and Thatta, according to a statement from the Pakistan Polio Eradication Program.

Pakistan and neighboring Afghanistan remain the only two countries where transmission of the wild poliovirus has never been stopped, according to the World Health Organization. Some parents in Pakistan still refuse to vaccinate their children, while others live in hard-to-access areas, experts say.

Meanwhile, health workers sometimes suffer life-threatening attacks when trying to reach households in former militant strongholds in the country's restive northwest. In February, gunmen killed a police officer assigned to protect a vaccination team in Jamrud, a district in Khyber Pakhtunkhwa bordering Afghanistan. Since the 1990s, more than 200 polio workers and the police assigned to protect them

have been killed in attacks. Authorities said nearly 21 million children under the age of five were vaccinated during a campaign earlier this month. Another nationwide, weeklong door-to-door drive is set to begin Oct.

13, targeting 45 million children. Polio is a highly infectious, incurable disease that can cause lifelong paralysis. Pakistan has been reporting an average of about three new cases each month since January.

The WHO and its partners launched the global polio eradication initiative in 1988, following the notable precedent set by the elimination of smallpox in 1980. The effort came close several times, including in 2021, when just five cases were reported in Pakistan and Afghanistan. But cases have since rebounded, rising to 99 last year, and Pakistan has repeatedly missed eradication deadlines.

Dengue: A total of 845 people were diagnosed with dengue fever in Bangladesh in the past 24 hours on Sunday, the highest number in a single day so far this year, said the Directorate General of Health Services (DGHS) under the Ministry of Health.

Also in the same period, four people died due to the mosquito-borne disease. With the fresh infections reported as of 8 a.m. local time Sunday, the number of dengue cases has surged to 46,051 in Bangladesh so far this year,

the DGHS said. So far in September, 14,575 dengue cases were recorded after 10,496 people were infected with the disease in August, according to the DGHS, which confirmed 192 dengue deaths so far

While 70 deaths were reported so far in September, there were 39 deaths in August and 41 in July, the DGHS said.

Tips for easing separation anxiety in young kids as they start school NEW YORK, Sept 30, (AP): On her first full day of preschool, Alexander Lane's 3-year-old daughter stayed in the car for an hour at drop-off because she didn't want to go inside. On the

A parent's guide to first-day school struggles

second day, she entered class in tears. But by the third day, she eagerly ran into the classroom. Starting preschool or kindergarten is a milestone, but also a source of anxiety for some children, including many

who are experiencing their first extended period of time away from a parent or guardian. Lane already knew his daughter was nervous about being away from her parents. She had resisted going to a couple of classes several months ago,

so Lane decided to give her a break before enrolling her in preschool. "It's not productive to tell someone, 'You'll just enjoy this if you push through and do it.' Like, that's not very persuasive," said Lane, of Minneapolis.

Separation anxiety is not uncommon, especially for young children. In fact, experts say that it's a natural part of growing up.

"As we're starting a new school year, we're going into a new classroom, our routine is changing ... there's going to be some of this anxiety and time that you would expect that a child would need to transition," said Erica Lee, a psychologist at Boston Children's Hos-

But if a child demonstrates symptoms of separation anxiety for prolonged periods of time, it can hinder their daily activities and may need a clinical diagnosis. Here's some steps to acclimate young kids to school and make drop-off easier.

In almost two decades of teaching preschool, Kimberly Skukalek, of Pinellas County, Florida, would have a handful of children every year who experienced separation anxiety. Her goal was to show that school was a safe space where they could make new

And that message wasn't just for anxious children - it was for the parents too, she said.

"Some parents ... especially if it's their first kiddo, they're more scared than the kiddo is," Skukalek said. Parents who feel their children can-

not handle a difficult situation can prevent them from building resilience, said Izabela Milaniak, a psychologist at the Children's Hospital of Philadel-

phia. Giving into a child's fears, such as letting them avoid school, often worsens separation anxiety because the avoidance breeds more distress, Milaniak said.

That's why she reinforces with parents the importance of raising brave kids. Having children confront scary situations - being alone in this case shows them they are capable of doing tough tasks, even if it's uncomfortable.

"It's giving them opportunities to learn how to self-soothe, to learn how to be alone, which is part of what we all as humans need to learn," Milaniak

Milaniak suggests a two-pronged approach for a child already dealing with separation anxiety: Validate their feelings, but stay firm. Treating a child's anxieties with respect is important, but 'compassionate limit-setting" is essential to building their confidence.

When Patrick Edmondson's child, Miles, started preschool in 2023, the 3-year-old would resist getting ready in the morning and become emotional when it came time to separate from his parents. While Edmondson and his wife had empathy for their son's fears, he said they didn't want to indulge his anxiety by allowing him to skip school.

"If he was really having a problem, that option exists, but we don't really disclose that to him," said Edmondson, of Washington, D.C., said. "If that was the case, he would just say 'I don't want to do it. It's too scary, I don't want to go today."

Miles' parents implemented a few tactics to help their son, including offering reassurance that they would come back for him. Another tool was letting Miles choose a "bravery toy," that made him feel safer at school, such as a Hot Wheels car or a stuffed animal, Edmondson said.

Now in kindergarten, Miles rides the bus to school, and he loves it, Edmondson said.

Gradually exposing a child to separation can help them become more comfortable with it, Lee said. Parents can start by doing short bursts of separation - such as going into another room for 5 minutes - to build their child's tolerance. As a child gets used to it, parents can increase the length of time within reasonable limits.

Creating a brief goodbye ritual can

also benefit a child dealing with separation anxiety, Lee said, because it creates a sense of routine without dragging out a parent's departure. Lane, the father from Minneapolis,

eased his daughter's transition into formal preschool by having her attend half-day classes over the summer.

They spend Sunday night talking about what activities she might do in class, as well as packing her lunch and picking out her outfit together, which makes her more comfortable,

Drug abuse

Mongolia sees rise in suicide

ULAN BATOR, Sept. 30, (Xinhua): Suicide rates have increased during the last four years in Mongolia and remain high, according to a report released by the country's National Center for Mental Health on Tuesday.

Mongolia had an average suicide rate of 28.1 per 100,000 people in 2021-2025, most of whom were male, the report said.

Suicide is a leading cause of death for people aged 15 to 34, according to center.

The main causes of suicide are unemployment, socioeconomic instability, severe depression, drug addiction, alcoholism, and

Mongolian psychologists said the government must take urgent measures to prevent suicide among young men in the coun-

Drug-addiction: Sri Lanka's National Dangerous Drugs Control Board (NDDCB) said on Monday that Sri Lanka's Western Province records the highest number of drug-addicted schoolchildren, with Colombo district accounting for most cases.

The NDDCB said in a statement that children from low-income communities in Colombo and its suburbs are particularly vulnerable. Certain parts of the Kandy district, along with Gampaha, Kurunegala, Anuradhapura, Galle, Ratnapura, and Kalutara, were also identified as high-risk areas.

Peer influence has been cited as a major driver of drug use among schoolchildren, while weak implementation of school drug prevention policies and limited involvement of principals and education offices have worsened the problem, said the NDDCB. Stressful family environments, neglect, poverty, malnutrition, and the easy availability of drugs in communities are also contributing factors

To curb the trend, the NDDCB said it is rolling out programs through six streams, including school, youth, family, workplace, and community-based initiatives, along with environmental and media campaigns.

Nanosat nears end of mission

SpaceX eyes mid-Oct for Starship's 11th flight test

LOS ANGELES, Sept 30, (Agencies): SpaceX is targeting mid-October for the 11th flight test of its Starship rocket, the company announced on Monday.

The launch is scheduled for as early as Monday, Oct. 13, with a launch window opening at 6:15 p.m. Central Time (2315 GMT).

During the test, the booster will launch with 24 flight-proven Raptor engines to test a unique landing burn configuration planned to be used on future Super Heavy rockets. It will target an offshore landing point in the Gulf of Mexico rather than returning to the launch site for catch, according to

SpaceX Starship's upper stage will pursue several in-space objectives, including deploying eight Starlink simulators that are similar in size to the company's next-generation Starlink satellites. The simulators will follow the same suborbital trajectory as Starship and are ex-

pected to burn up upon reentry. The mission will also include a series of experiments and operational changes aimed at paving the way for future Starship flights to return the upper stage to the launch site. For this test, some heat-shield tiles have been deliberately removed to stress-test vulnerable areas of the vehicle during reentry.

To replicate the trajectory of future return missions to SpaceX's Starbase in the US state of Texas, the final phase of the test will feature a dynamic banking maneuver and evaluate subsonic guidance algorithms before a landing burn and splashdown in the Indian Ocean.

The W-Cube nanosatellite, developed in Finland for the European Space Agency (ESA), is nearing the end of its mission and will burn up in the Earth's atmosphere within days, Finland's VTT Technical Research Centre said recently. The satellite is currently orbit-

ing at about 200 km above the Earth's surface and rapidly losing altitude. Scientists expect its signal to be lost at any time as atmospheric friction increases, causing it to ignite and disintegrate. Launched on June 30, 2021,

the cube-shaped satellite, about the size of a 1.5-litre milk carton, was the first ESA spacecraft ordered from Finland. It has operated for more than four years, close to the typical lifespan of nanosatellites.

The mission marked the first demonstration in orbit of the 75 gigahertz frequency band for satellite communications, VTT said in a statement. The satellite collected data on how the Earth's atmosphere, especially rain and clouds, weakens high-frequency wireless

"The W-Cube satellite validated that much higher frequency bands than those used today can be utilised in satellite communications and achieve very high performance," said Jussi Saily, principal scientist at VTT. He said the technology could eventually deliver faster connections directly to smartphones in Europe.

The spacecraft carried a radio beacon system co-developed by VTT and Germany's Fraunhofer IAF. Signals were successfully received at ground stations in Finland, Austria and the Netherlands, enabling measurements of atmospheric attenuation critical for future high-frequency satellite

and you've heard you can buy these things called carbon offsets. Are they worth it? Let's explore. A roundtrip flight from New York to Los Angeles emits more than 1,300 pounds (about 614 kilograms) of planet-warming carbon dioxide per passenger, according to an emissions calculator from the International Civil Aviation Organization.

That's about the amount of pollution

flight's pollution. Or, maybe you're

an environmentally minded person,

you'd save if you swore off meat for 17 months. Jet engines burn fossil fuels, releasing planet-warming gases into the atmosphere. They also release water vapor, which turns into long, thin clouds called contrails that trap heat instead of letting it escape to space - additional warming that isn't typically included in a flight's emissions, said Diane Vitry, aviation director at a clean energy advocacy organization called the European Federation for Transport and Envi-

Reducing emissions from air travel is difficult. Batteries weigh too much and provide too little power for long flights. Sustainable aviation fuel - biofuels made from things like corn, oil seeds and algae that can be mixed with jet fuel - is currently more expensive than traditional fuel and lacking sufficient supply to be in

"Aviation is the problem child," Vitry said. "Aviation and shipping are not decarbonizing, and definitely not fast enough.'

That's where carbon offsets come

a permit to emit planet-warming gases. It's connected to something that stores or reduces carbon emissions for example, planting trees, or funding renewable energy.

The idea is that the program or action offsets your pollutive action. You drive a car that pollutes a certain amount, you buy a carbon offset that leads to the planting of a tree that sequesters the same amount, and bam: the pollutive action (driving) is offset (tree planting).

They've gotten popular enough that there's an entire marketplace that connects people and companies wanting to reduce their impacts with other companies that promise to do

Vitry doesn't think so. She calls them a fake climate solution. "Unfortunately, it is not what is

going to solve aviation's climate problem," she said. "You can't clear your climate conscience with an off-

Sure, you can plant a tree, but

Vitry said that doesn't stop your flight's emissions from entering the atmosphere. The tree may eventually absorb an equivalent amount of emissions. Or it may die. Or it may be sold as an offset multiple times by an unscrupulous company, meaning the tree can't possible absorb all the emissions it's supposed

Barbara Haya, director of the Berkeley Carbon Trading Project, has studied carbon offsets for more than 20 years. She said some offset schemes are overcounted by 10 to 13 times their actual value.

"There's so much over-crediting on the offset market, so many credits that either don't represent any emissions reductions at all or represent just a small fraction of what they claim," Haya said.

She said that's partly because the voluntary offset market is largely unregulated, and it's really difficult to measure offsets. The other problem is everyone involved ben-

efits from over-exaggerating the benefits of offsets. "The buyer of the credit wants the cheap credits, the seller of the credits wants to get more credits for the same activity and the third party verifier is hired by the project developer, so has a conflict of interest to be lenient," Haya said.

Jodi Manning, chief executive of the carbon offset nonprofit Cool Effect, said consumers should beware of offset programs that don't say clearly which project will benefit from your purchase or how much of your money is going to a project. But she said "high-quality" carbon credits can play an important role where emissions are unavoidable.

Manning said offsets have to be permanent, transparent, and unable to exist without the offset funding.

"When carbon is done correctly, it can provide a credible, immediate way to account for the emissions that travelers cannot otherwise reduce. We all create emissions at some point and it is certainly better to take action to compensate for it than to do nothing," she said.

Several airlines that offer offsets did not respond to requests from AP to talk about their use. One that did, Southwest Airlines, said in a statement that it does not plan to rely on carbon offsets to help it reach a goal of net zero emissions by 2050.

Fly less, take the train if you can, and pack light, Manning said.

If you have to fly, think about cutting your emissions in other ways, Haya said.

Instead of buying carbon offsets, Haya said she donates \$1,000 to an organization she cares about on the rare occasion she flies for work or family visits.

"We have an ethical obligation not to fly unless we really have to," she

'Challenges include fighting the complacency'

Gilgeous-Alexander and the Thunder aim to defend NBA title with familiar faces

OKLAHOMA CITY, Sept 30, (AP): Shai Gilgeous-Alexander knows the outside view of him and the Oklahoma City Thunder squad he leads have changed significantly in the past year.

Gilgeous-Alexander is the reigning MVP and the Thunder is the defending NBA champion - firsts for both. Now, a team that rarely was seen beyond its local market last season has a schedule filled with national television appear-

For all the new awards and attention, Gilgeous-Alexander is focused on what has remained the same. Most of the roster that won the title after a 68-14 regular season is intact. Gilgeous-Alexander, All-Star Jalen Williams and rising star Chet Holmgren all signed extensions in the offseason.

Gilgeous-Alexander hopes the familiar faces lead to familiar results. For that to happen, he believes that will require a familiar approach.

"How we get there is the same as it's always ever been - daily improvement and focusing on trying to get better at the things that we can control every day," he said. "And hopefully, we look up and we've accomplished the same

thing we just accomplished.

Williams, a first-time All Star last season, believes the approach can lead to bigger accomplishments.

'You are chasing greatness," he said. "You're chasing to achieve stuff that hasn't been done in our organization. And that's everybody's motivation. I think that's why we're a special group.'

Thunder guard Alex Caruso said the team would be naïve to ignore the risk of taking it easy after winning and said the challenges include "fighting the complacency, fighting the human nature of winning and not sitting back and resting but being on the front foot.'

Even with the championship, the Thunder remains one of the league's youngest teams with its best days potentially ahead.

Gilgeous-Alexander averaged 32.7 points, 5.0 rebounds and 6.4 assists per game last season. It's hard to imagine him getting better, but he's only 27. He said he's still seeking growth and little changed for him this offseason, other than the fact that it was shorter

"I was never a player that jumped out of the gym or had any insane talhad to craft and carve and mold myself into this player that I am today, and I'll never forget that. And because of that, I hold that very dearly and make sure if I'm doing anything, I'm working at my game and try to be better."

Williams, just 24, averaged 21.6 points, 5.3 rebounds and 4.1 assists last season and was a third-team All-NBA pick and a second-team all-defensive selection. He was a force in the NBA playoffs, despite playing through a wrist injury that required surgery after the season.

Williams said the surgery helped him focus in the offseason.

"It allowed me to be grounded and kind of focus on that and forget about the championship and everything else," Williams said.


Holmgren, 23, averaged 15.0 points, 8.0 rebounds and 2.2 blocks last season. He missed 50 regular-season games with a pelvic injury and never fully got back to form last season. Despite that, the versatile 7-foot-1 forward was still a key piece that helped the Thunder win the title.

The role players are back, too

much-needed bulk and averaged 11.2 points and 10.7 rebounds per game last season. Luguentz Dort was a first-team all-defensive selection who shot 41% from 3-point range. Caruso and Cason Wallace were among the league's top perimeter defenders. Aaron Wiggins averaged 12 points per game. Isaiah Joe shot 41% from 3-point range and averaged 10.2 points. Jaylin Williams, Ajay Mitchell and Kenrich Williams provided key minutes when needed.

The depth helped the Thunder keep winning last season, despite being among the league leaders in games missed because of injury. Coach Mark Daigneault said the Thunder mentality of being prepared for anything should help them manage the season.

"The circumstances are always changing year to year and even within the season," he said. "The challenges are always changing year to year and in the season. We try to have a very consistent and stable approach to that. And we try to have things that are pretty timeless and that can transcend circumstances. And we emphasize those

"Contract negotiations are never pretty," Warriors teammate Draymond Green said Monday. The unsettled situation for Kuminga


has dominated the offseason, preventing the franchise from making other moves, and then extended into media day. Golden State can match any offer for Kuminga.

"I just know from man to man, he didn't want to have to be in the way of anything. Let that situation play out. He can speak for himself."

France's court of auditors reports modest economic impact from Oly

PARIS, Sept 30, (AP): Hosting the 2024 Paris Olympics generated only moderate revenues for France, with an almost negligible impact on growth, while total public expenditure exceeded six billion euros (\$7 billion), the country's court of auditors reported.

Public spending linked to the Olympics organization included □3.02 billion for the event organization, and □3.63 billion for infrastructure investment, some \square 690 million more than the auditors' initial estimate published in June.

The Paris Games also generated public revenues from taxes and commercial activities, estimated at □293.6 million. According to the Cour des Comptes report released ahead of the 2030 Winter Olympics - also awarded to France - the organizing committee of the Paris Games, funded mainly through private resources, posted a profit of \Box 75.7 million.

"The Games' impact on annual economic growth in 2024 is estimated at +0.07 percentage point of GDP once indirect effects are factored in," auditors said. "The benefits have been modest, both in the run-up - when soaring prices limited the real effect of infrastructure spending - and during the

Games themselves, as regular tourism was partly crowded out. The medium to long-term economic benefits remain uncertain.

The Cour des Comptes said security for the Games was largely successful, except for sabotage of high-speed rail lines on the opening day. However, they criticized the under-budgeting of security costs, which ultimately reached □1.44 billion in state spend-

France's Interior Ministry argued that estimating security costs ahead of the Games was difficult due to the unprecedented urban security measures for the opening ceremony on the Seine and elevated threat levels.

The report came as opponents of the 2030 Winter Olympics and Paralympics in France have launched legal action to demand a public debate on the Games planned for the French Alps. The project is centered on Alpine ski resorts and ice-sport venues in Nice on the Mediterranean coast. The organizing committee has set a provisional operational budget of □2 billion (\$2.1 billion) - construction costs, including for a planned ice arena in Nice, will be additional expense.

Rugby expectations high for 2029 Women's WC in Australia

LONDON, Sept 30, (AP): Basking in the afterglow of the best Women's Rugby World Cup yet, World Rugby warned success may be gauged differently when Australia hosts the next tournament in 2029.

The England-hosted tournament, capped by the home team beating Canada 33-13 in the final at sold-out Twickenham on Saturday, smashed already-ambitious forecasts for revenue from tickets, brand and commercial partnerships, media rights and

merchandise sales. Playing standards improved and social media engagement was phenomenal.

"A lot to live up to," said Jilly Collins, Rugby Australia general manager - women's rugby.

She and Australian government representatives shadowed World Cup organizers to learn what made the women's event tick ahead of hosting the men's tournament in 2027 and

the women's two years later. "Our focus now is diversifying what the definition of success looks like, looking at the unique cultures" of future tournament hosts, Sally Horrox, World Rugby chief of women's rugby, said on Monday.

The 2029 Women's World Cup in Australia "will be an incredible but distinct sort of success story around their culture, their community, the First Nations (and) the Pacific legacy program that we're already build-

ing."
Collins was grateful for having

four more years to prepare.
"Australia is unique," she said. "We have our own challenges, geography being one, and next year we will be deciding what that looks like in terms of the tournament model.

"What we need to do is build that fan base, build the visibility. We need to make sure that our fans in Australia know the names of women stars from all around the world, not just the Wallaroos. And that's a big

The full 26-man squad includes Saud Al-Janai, Khalid Al-Rashidi, Saud Al-Hoshan, Abdulrahman Ajaj, Fahad Al-Hajri, Mishari Ghanem, Khalid Sabah, Mohammed Khalid, Rashid Al-Dosari, Khalid Ibrahim, Abdulwahab Al-Awadi, Nasser Khidr, Hasan Hamdan, Khalid Al-Murshid, Mahdi Dashti, Redha Hani, Ahmed Al-Dhafiri, Athbi Shahab, Sultan Al-Anzi, Fawaz Ayed, Badr Tareg, Talal Al-Qaisi, Youssef Nasser, Moath Al-Osaimi, Salman Al-Awadi, and Ahmed Al-Zanki

Dr. Abdulmajeed Albannai, head of the Kuwait Football Association's medical committee, confirmed that some absences are due to injuries. 
