

# Ministers, pay attention to the reports of some of your employees

SOME still mistakenly believe they can impose their will on others, even those of lower rank, just as they did in the days of the National Assembly because they were 'well-connected'.

However, this is no longer the case. Circumstances have changed dramatically. The previous lack of transparency in providing information for decision-making and attempts to bypass the law are no longer tolerated.

In the past, the lack of accountability among officials, coupled with pervasive interference, hindered progress. Individuals frequently sought protection from superiors. 'Well-connected' individuals could even incite the grilling of ministers or the Prime Minister, leading to a potential vote of no confidence.

This environment often stalled development projects. Members of Parliament might oppose projects due to lack of vested interest, dislike for the company involved or pressure from influential figures. Such actions inevitably came with a price,

as manifested in compromised services, appointments or other forms of gratification that tempted those with weak morals.

Consequently, Kuwait suffered enormous losses, falling behind on the global stage, particularly within the region. Numerous major deals that would have greatly benefited the State ultimately failed.

In contrast, some ministers lived at an ivory tower, not directly dealing with their ministry's affairs. Instead, they relied on advisors, directors and undersecretaries, many of whom were appointed by parliamentarians and influential figures whose interests conflicted with public interest.

# 73 go to court in draw 'foul play'

KUWAIT CITY, Oct 28, (KUNA): Kuwait's Public Prosecution referred 73 defendants to the criminal court implicated in commercial draw manipulation case, on charges including bribery, mediation, forgery of official and electronic documents, and money laundering.

The prosecution stated that cash and inkind assets valued at approximately KD 1.174,989 million (approx. USD 4 million) have been seized pending the necessary judicial procedures. The Public Prosecution on Tuesday issued

a statement regarding the case of manipulation in commercial draws conducted under the supervision of the Ministry of Commerce and Industry during the period from 2021 to

The Public Prosecution stated that, upon completion of investigations, it had referred the defendants to the criminal court after conclusive evidence established a common intent and criminal purpose among the perpetrators.

It added that both cash and in-kind assets had been seized as part of efforts to recover illicit proceeds, in preparation for taking the legal measures.

It further explained that the manipulation extended to 110 commercial draws that offered prizes including vehicles, cash sums, and in-kind assets, with an estimated total value of KD 1.244,467 million (approx. USD 4 million)

**KUWAIT CITY, Oct 28, (KUNA): During** its weekly session on Tuesday, chaired by His Highness the Prime Minister Sheikh Ahmad Abdullah Al-Ahmad Al-Sabah, Kuwait's Cabinet approved, a draft decree-law on combating drugs and psychotropic substances and the regulation of their use and trafficking.

The draft decree-law aims to merge Law No. 74 of 1983 on combating drugs and regulating their use and trafficking, with Law No. 48 of 1987 on combating psychotropic substances and regulating their use and

trafficking, which increases the penalties, to include the death penalty, coupled with hefty fines for smugglers, dealers, promoters, and barterers of drugs and psychotropic substances.

The merger will achieve numerous benefits that contribute to protecting society from the harms of drugs and psychotropic substances, including unifying the concepts and terminology, it also unifies legal provisions related to crimes, penalties, and procedures, facilitating its imple-

The Cabinet decided to refer the draft decree-law to His Highness the Amir Sheikh Meshal Al-Ahmad Al-Jaber Al-Sabah for approval.

# **PACI** female staff jailed five years in issuing IDs for cash

KUWAIT CITY, Oct 28: The Criminal Court, headed by Counselor Abdul Wahab Al-Maili, on Tuesday sentenced two female employees at the Public Authority for Civil Information (PACI) and an Egyptian representative to five years in prison with hard labor, while an accountant and another representative were sentenced to three years in prison in a forgery case.

The defendants were accused of forging transactions to change and update residential addresses, as well as the issuance of civil identification cards, in exchange for bribes, in addition to forging rent contracts.

Case files confirmed that the defendants exploited their positions to facilitate the issuance of civil identification cards based on false information and contracts, in exchange for money - a blatant violation of the law and official procedures.

The evidence presented by the Financial Crimes and Investigations Department proved that the defendants committed the crimes attributed to them, actions that harm public interest and undermine the integrity of administrative work and official State documents.

### 'MoIA nod must for mosque activities

# Kuwait's National Fund for SME boosts GCC partnerships

KUWAIT CITY, Oct 28: The State of Kuwait, represented by the National Fund for the Development of Small and Medium Enterprises, hosted the Gulf Pioneers Forum, which was held Tuesday under the patronage of Minister of Commerce and Industry Khalifa Al-Ajeel.

# GCC unifies social security plan

Kuwait backs 2030 strategy for citizens' welfare

**KUWAIT CITY, Oct 28: The heads** of civil retirement and social security agencies in the Gulf Cooperation Council (GCC) countries approved the comprehensive and unified strategic plan extending until 2030.

This plan aims to develop the joint social security system in a way that ensures the sustainability of the financial and administrative mechanisms, thus, affirming the strategic vision of the leaders of the GCC countries towards strengthening social security and welfare for their citizens.

The Public Institution for Social Security (PIFSS) in the State of Kuwait confirmed that the decisions resulting from the meeting will support the process of Gulf integration in this vital and important sector, and contribute to achieving sustainable development and welfare for Gulf citizens

In a speech delivered on behalf of Minister of Electricity, Water and Renewable Energy and acting Minister of Finance and Minister of State for Economic Affairs and Investment Dr. Subaih Al-Mukhaizeem at the opening of the 24th meeting of the heads of civil retirement and social security agencies in GCC countries, acting Director General of PIFSS Khaled Jassim Al-Mudhaf disclosed that Gulf institutions are witnessing tremendous developments and outstanding efforts to absorb global experiences, as well as develop them in the field of performance systems and investment practices, in order to apply the wise equation between calculated risk and individual prudence to maximize returns and secure the future of the funds.

He explained that "based on this vision, we meet today to coordinate our efforts and consultation on social security. We adopt a methodology of continuous review and search for creative ideas to have

more flexibility and efficiency. This meeting is an opportunity to unify proactive Gulf efforts to ensure that institutions and systems remain at the forefront of development and are able to keep pace with every change. Therefore, the decisions that will be taken will guarantee the continuous provision of services, prosperity, and stability for the Gulf systems in the long term." He pointed out that the expansion of social security cover entails the adoption of a methodology of continuous review and the search for creative ideas to enhance flexibility and efficiency.

On the other hand, Assistant Secretary General for conomic and Development Affairs at the GCC Secretariat General Secretariat Khalid Al-Sunaidi affirmed that "this celebration carries many meanings of pride and honor for the qualitative leap witnessed by the GCC countries in the social security sector in terms of legislation and regulations or in the areas of digital transformation and improving services provided to subscribers and retirees. The GCC countries are witnessing a manifestation of the rising awareness on the importance of aligning the social and economic dimensions, achieving

balance between financial efficiency and sustainability, protecting the rights of present and future generations, and reinforcing the concept of Gulf citizenship and the principle of equal opportunities and treatment among citizens of the GCC countries."

During the meeting, the continuous activation of capacity-building programs and the exchange of expertise among member states were approved. This is being done through the organization of periodic, specialized and intensive seminars aimed at improving institutional and individual performance, in addition to studying a number of new joint initiatives that will develop the social security system and provide comprehensive care befitting the Gulf citizen. The meeting yielded vital results related to devel-

oping mechanisms for implementing the unified system for expanding social security coverage. This is in addition to reaching agreement on practical steps to strengthen the collection and coverage mechanisms, and discussing and analyzing relevant statistical indicators to support comprehensive coverage for citizens working in any of the GCC countries.

### Kuwait Fund commits USD5 mln to UNICEF cholera response in Sudan WASHINGTON, Oct 28, (KUNA):

**Project aims to rehabilitate facilities** 

The Kuwait Fund for Arab Economic Development (KFAED) has signed an agreement with the United Nations Children's Fund (UNICEF), under which the Fund will provide USD 5 million to support UNICEF's Cholera Response Project in Sudan.

In a press statement, KFAED said the agreement was signed by Kuwait's Deputy Minister of Foreign Affairs, Sheikh Jarrah Al-Sabah, and UNICEF Executive Director Catherine Russell in New York.

According to the Fund, the project aims to limit the spread of cholera and reduce health risks resulting from deteriorating water and sanitation services. It will focus on improving access to clean water, rehabilitating 12 water treatment plants and 18 small water points, upgrading hospital sanitation systems, and providing solar energy systems to ensure sustainability.

The project will also promote hygiene awareness and behavioral change through community campaigns and field team training for cholera outbreak response.

The statement noted that the project falls within the framework of a Memorandum of Understanding signed on July 6 between the Kuwait Fund for Arab Economic Development, the Kuwait Ministry of Foreign Affairs, and the United Kingdom's Foreign, Commonwealth & Development Office (FCDO) to provide joint assistance in financing UNICEF's work to support primary healthcare, nutrition, water and sanitation, and essential child protection services in Sudan.

Under this memorandum, the United Kingdom and Kuwait, through the Kuwait Fund, will each contribute USD 5 million to finance the project, which is expected to directly serve around 1.5

million people in Sudan. This grant represents the tenth contribution of its kind between the two institutions in the field of humanitarian support. Since 2017, the Kuwait Fund

has provided approximately USD 23.5 million to UNICEF to finance nine humanitarian projects, the most recent of which, on March 20, aimed at supporting the overhauling of water and sanitation systems in the Gaza Strip with a grant of USD 1.5 million.

The State of Kuwait and UNICEF also held their first strategic dialogue on Monday in New York with a view to strengthening their partnership.

The meeting was co-chaired by Ku-wait's Deputy Minister of Foreign Affairs, Ambassador Sheikh Jarrah Jaber Al-Ahmad Al-Sabah, and UNICEF Executive Director Catherine Russell.

The strategic dialogue addressed the partnership between Kuwait and UNI-CEF and highlighted Kuwait's role as a model of solidarity in the service of children and humanity, as well as its historic support for UNICEF projects in key development areas such as education. health, nutrition, water, and sanitation.

The conferees also discussed ways to strengthen cooperation in light of the challenges, conflicts, and disasters the world is witnessing, which directly affect the well-being and safety of children. On the sidelines of the meeting, a

grant agreement was signed between the Kuwait Fund for Arab Economic Development and UNICEF to finance the response to the cholera outbreak in Sudan.

### **Kuwait Zakat House aid convoy of** 33 trucks reaches Rafah for Gaza

CAIRO, Oct 28, (KUNA): Kuwaiti aid convoy of 33 trucks loaded with food and basic necessities, donated by Zakat House, arrived in the Egyptian city of Rafah on Tuesday to support the Palestinian people in Gaza Strip.

Director of the Kuwaiti Office for Charitable Projects, Adnan Al-Sabti, told KUNA that ten aid trucks entered Gaza through the Rafah crossing, with the rest to follow per a schedule coordinated with Egyptian authorities.

Al-Sabti said the convoy included 33 trucks, 14 loaded with food baskets and 19 carrying essential items, provided as part of the "Kuwait by your side" campaign.

He added that Kuwait Zakat House, through its Cairo office, would continue delivering humanitarian aid to Palestinians, highlighting Kuwait's leading role in supporting Gaza through previous and ongoing aid convoys.

He reaffirmed Kuwait's commitment to providing urgent assistance and essential supplies amid the current humanitarian crisis.

Al-Sabti thanked the Egyptian authorities at Rafah crossing for facilitating the convoy and praised the support of the Orman Association and the National Alliance for Civil Development Action in ensuring aid reached those in need in Gaza.

### **SACGC** picks three innovators to represent Kuwait at Venture Day

KUWAIT CITY, Oct 28, (KUNA): Sabah Al- Ahmad Centre for Giftedness and Creativity (SACGC) announced the conclusion of the Engineering Ideas Incubation Program on Monday with the selection of three innovators to represent Kuwait at Venture Day, an event organized by Spain's global IE University next December.

The center, an affiliate to the Kuwait Foundation for the Advancement of Sciences (KFAS) centers, said in a press release that, following an intensive journey of learning, development, and innovation, the three innovators were selected at the end of the program from among the 21 participants who reached the final stage.

The first innovator, Fatma Al-Enzi, presented the idea (Brailliance), an educational device designed to empower blind and visually impaired students.

The second innovator Dhareaa Al-Jumaa proposed (SPX), a platform that enables professionals in design, contracting, and manufacturing fields to manage furniture supply strategies intelligently. The third innovator Ahmad Salmeen,

introduced (LIVE), an AI-supported design platform that allows architects and designers to create healthier and more sustainable spaces in minutes instead of hours. # **Beauty center in illegal** ops shut down by PAM

KUWAIT CITY, Oct 28: The Public Authority for Manpower (PAM), represented by the Labor Inspection Department, in cooperation with the Health Licensing Department, conducted a surprise field campaign recently targeting a women's beauty center after receiving information that medical services were being provided without the required licenses, reports Al-Seyassah daily.

PAM stated on its X platform account that the campaign led to the seizure of several medical devices, equipment, and supplies used for injections, cosmetic procedures, and skincare, along with various other medical materials.

It was found that workers were performing paramedical procedures without the required qualifications or approved medical supervision.

PAM stated that immediate legal measures were taken, the facility's file was closed, and the tools and supplies were seized pending further investigations.

The authority urged citizens and residents to verify the licenses of beauty centers and medical facilities before receiving any services, emphasizing that anyone violating laws and regulations will face legal accountability.

# Illegal 'hunters' fall in own trap

Arms dealer 'acquitted'

KUWAIT CITY, Oct 28: In compliance with the directive of First Deputy Prime Minister and Minister of Interior Sheikh Fahad Al-Yousef to take all the necessary measures against those proven to have violated laws and regulations, the environmental police officers arrested two individuals who entered Sabah Al-Ahmad Nature Reserve without a permit for the purpose of hunting wild animals.

In a press statement, the Ministry of Interior affirmed that as part of security efforts to protect wildlife and preserve nature reserves, the Environmental Police Department at the Security Directorates Sector apprehended two individuals who entered Sabah Al-Ahmad Nature Reserve without permission and were hunting wild animals using falcons.

The ministry said the suspects were spotted inside the reserve, and legal action was taken against them in accordance with the laws and regulations governing entry into protected environmental areas, which aim to preserve biodiversity and prevent any practices that harm the natural environment.

It explained that Article 105 of the Environmental Protection Law prohibits the introduction of any type of animal or plant not native to the environment into nature reserves, or engaging in any act that hinders conservation efforts, harms wild or marine life within the reserves, or damages their contents in any way, or hunting, capturing or pursuing wild animals. The law punishes anyone who violates the

provisions of Article 105 with imprisonment for a period not exceeding one year and a fine of not less than KD500 and not more than KD5,000, or any of these two penalties.

The suspects were referred to the concerned authorities for legal action.

While the ministry affirmed its commitment to strictly enforce the law regarding any violation that affects natural areas or endangers wildlife, it called on everyone to abide by the regulations and instructions and obtain the necessary permits before entering nature reserves.

Arms dealer acquitted: The Criminal Court acquitted an individual who was charged with trafficking and possessing illegal firearms and ammunition, as well as money laundering.

Lawyer Ayed Al-Rashidi, representing the defendant, confirmed that the ruling was issued after the court reviewed the evidence and legal arguments he had presented.

He stressed that the case lacked any material evidence to support the charges against his client, adding that the officer's statements had not been corroborated.

Lawyer Al-Rashidi affirmed that his client would soon return to normal life after a period of anxiety caused by the accusations leveled against him.

Butcher shop sealed

### **Indian frozen meat sold as fresh**

KUWAIT CITY, Oct 28: The Public Authority for Food and Nutrition (PAFN), in coordination with the Ministry of Interior and the Capital Security Directorate, sealed a butcher shop on Monday for allegedly tampering with and fraudulently selling meat products, reports Al-Anba daily.

Investigations revealed that the shop had forged sales and supply invoices for meat supplied to cooperative societies, selling meat that did not meet approved specifications and standards, including meat of unknown origin.

The shop also thawed frozen buffalo meat from India and resold it as fresh and chilled, and misrepresented Australian sheep meat, selling it fraudulently as

fresh, chilled, and authentic Australian. PAFN explained that, following the

inspection results, the violating butcher shop was closed. All seized meat that failed to meet specifications and standards was destroyed. The responsible employees were referred to the competent authorities to face legal action and be held accountable under applicable regulations.

PAFN, in coordination with the Ministry of Interior, reaffirmed its commitment to continue joint regulatory efforts to track violators and protect

Both authorities highlighted zero tolerance for breaches of health and food safety standards and emphasized that the strictest legal measures will be applied against anyone who tampers with food safety or endangers the health of citizens and residents

# Gazans, Gulf in quandary as aid falls in wrong hands

"THE Gulf states were not directly involved in the war that devastated the Gaza Strip, where reconstruction costs are estimated to exceed \$70 billion and could extend over a period of thirty years. Those responsible for the region are Hamas leaders, who live like billionaires in marble-floored palaces and luxury hotels, profiting from the misery and terrorism in poverty-stricken Gaza," columnist Ahmad Al-Dawas wrote for Al-Seyassah daily

"According to a report published by the British Daily Mail on September 9,

2025, supported by photographs and evidence, Hamas some leaders have amassed a net worth estimated in the billions, plundered from aid meant for Gaza.

"UN reports from 2023 re-Ahmad Al-Dawas vealed that more than \$7 billion has been disbursed to Gaza since 2006, including \$1 billion

provided by the Gulf states. "These funds were intended for building schools and hospitals, but most were diverted through illicit channels. Hamas confiscated the majority for its military projects, while only a small portion was spent on construction benefiting the movement's elite and leaders, leaving ordinary Palestinians in dire conditions

"Gulf funds and aid intended for civilian infrastructure were diverted to a network of military tunnels built by Hamas, at an estimated cost of around \$1 billion, according to European reports.

"Hamas reportedly seized about 40 percent of international aid, using it to purchase weapons and manufacture rockets.

"The United Nations documented the embezzlement of \$350 million over just two years, while the population of the Gaza Strip continued to suffer from hunger and poverty.

Transparency International ranked Gaza under Hamas rule as one of the most corrupt regions in the world in 2022. In 2018 alone, \$180 million in aid went missing, according to the World Bank.

"What happens when the sums reach tens of billions? The risk of embezzlement is very real. The massive reconstruction bill represents a longterm economic and political trap, for which citizens of the Gulf states may end up paying. Will they be obliged to shoulder a significant portion of the \$70 billion needed for reconstruction, destruction in which they played no part, especially given the risk that Hamas could embezzle these funds and use them for terrorist operations that might even target the Gulf states themselves?

"Why are the Gulf states, who are already victims of Hamas embezzlement, being asked to shoulder a huge portion of the \$70 billion reconstruction bill? While providing humanitarian aid to the people of Gaza is a moral responsibility, committing massive investments that are vulnerable to embezzlement is a risky and unwise venture.

"The Gulf states were not directly involved in the war that destroyed Gaza. Let all of the world's approximately 200 countries come together to contribute to its reconstruction. We must also remember that some in the region once mocked the Gulf states and did not support Kuwait during the Iraqi invasion. When they themselves faced attacks, they turned to the Gulf countries for

"In a generous move reflecting the legal leadership's commitment to family justice and the preservation of citizens' dignity, Minister of Justice Counselor Nasser Al-Sumait decided to transfer the responsibilities of child visitation centers from the Family Counseling Department to the Judicial Execution Departments." Kuwaiti writer **Bassam** Fahad Thunayan Al-Ghanim wrote

for **Al-Seyassah** daily.
"This step reflects a forward-looking vision, deep foresight, and a strong sense of social and human responsibility. The decision aims to alleviate the difficulties faced by parents affected by the shortcomings of visitation centers, which have often hindered rather than facilitated the implementation of judicial rulings.

"The Minister of Justice's decision ends the practices that used to occur in these centers, where fathers were often denied access to their children in the custody of their ex-wives under flimsy pretexts, exploiting the child's vulnerability and turning it against the father. Visitation centers were originally established to preserve family ties and reduce conflict, not to escalate

The role of the Judicial Execution Departments is now to correct such violations, ensuring that the centers serve as a tool for justice rather than an obstacle, and to deter anyone who seeks to use children for revenge or to exert psychological pressure on a parent.
"The Judicial Execution Depart-

ments must ensure that the double standards previously practiced by some employees of these centers are eliminated. Foster mothers were often treated as heroes, while fathers were unfairly portrayed as guilty, despite court rulings in their favor. These employees deliberately obstructed the enforcement of judicial rulings in an apparently systematic manner.

"These departments must establish a clear and binding mechanism for visitation centers to implement judicial rulings promptly and without leniency, ensuring that no center or employee can use flimsy excuses to delay or obstruct enforcement. The presence of such loopholes en-

ables some individuals to evade compliance with court rulings under flimsy pretexts, transforming the centers from neutral entities meant to enforce the rulings into tools that obstruct the rights of children and their parents.

Decree aims to enhance trade co-op

KUWAIT CITY, Oct 28: A decree was issued approving the Memorandum of Understanding (MoU) between the governments of Kuwait and the Arab Republic of Egypt in the field of developing industrial exports, within the framework of enhancing economic and trade cooperation between the two brotherly countries.

According to the decree published in the official gazette, 'Kuwait Al-

Youm', the two contracting parties are committed to making the necessary efforts to develop and facilitate trade exchange and provide all possible facilities in several areas, particularly the participation of the public and private sectors in international and specialized exhibitions held in both countries, encouraging participation in introductory and promotional activities such as conferences, seminars and discussion panels, and exchanging visits of official and private delegations that include representatives of the economic and industrial sectors in both countries.

Article Three of the memorandum stipulates the exchange of economic and commercial information related to the markets in the two countries, such as publications, statistics, electronic data and industrial information, while maintaining the confidentiality of the exchanged information and not transferring it to any third party unless a written consent is obtained from the information

The two parties also agreed to provide facilities for conducting market studies, and organizing media seminars, training programs and exploratory visits, with the aim of exchanging expertise and experiences in the development of industrial exports, thus, contributing to strengthening economic relations between Kuwait and Egypt

### **MEW advances major energy projects**

KUWAIT CITY, Oct 28: Officials in the Ministry of Electricity, Water and Renewable Energy held a meeting with their counterparts in Kuwait Oil Company (KOC) to discuss the implementation of the proposed establishment of Al-Ratqa Power Plant with a production capacity ranging from 1,200 to 1500 megawatts, through Kuwait Authority for Private Partnership Projects (KAPP)

Reliable sources said that the construction of the plant will improve the production capacity of the ministry and will benefit KOC by utilizing the quantities of steam generated from combustion processes to produce electricity.

Sources revealed the meeting focused on the procedures related to the tender and some technical matters, including the

source of fuel supply. They affirmed the keenness of the ministry officials to push for the completion of electricity and water production projects to meet the growing needs of the country, especially those related to the new residential cities and development projects.

They expressed optimism about the progress of electricity and water production projects within the specified timelines, as Minister of Commerce and Industry Khalifa Al-Ojail recently issued a decision on the establishment of a Kuwaiti shareholding company named, Gulf Alliance for Energy and Water, for the purpose of building, implementing, managing, operating and maintaining North Zour Power and Water Desalination Plant (phases two and three), tendering Khairan power plant project (phase one), and the third phase of Shagaya Power Plant.

### Ministers, pay

Some of these ministers are still in their positions, managing the interests of those who appointed them, rather than overseeing public work with integrity and transparency, as they are supposed to do. They should serve the State and the people, not work for one or the other.

The stalled Sabriya City project, intended to provide 55,000 housing units, serves as a clear example of the detrimental effects of bureaucracy and decision-making paralysis in Kuwait.

This is frustrating given that the Chinese company contracted for the project has a proven track record of successful large-scale developments in various countries, including Saudi Arabia, with a global business volume exceeding \$150 billion.

This setback is merely one instance among many that impede the development of Kuwait. There is a growing impatience for the nation to overcome its current stagnation and capitalize on regional and global opportunities, rather than remaining mired in inefficient paperwork and outdated bureaucratic processes

To break this vicious cycle, a significant step is necessary. While some may consider it small, it clearly indicates that things have changed and that no one is above the law, as everyone is subject to accountability.

The directive of the Minister of Education to form a committee of experts, including those from the Legal Advice and Legislation Authority and other legal bodies, to address the printing and delayed delivery of school textbooks primarily aims to foster transparency and uphold integrity. This action signifies a departure from past practices, emphasizing accountability as a crucial tool to overcome challenges.

It also shows that the political leadership is closely monitoring developments, and how public-interest-focused officials are implementing the higher directives.

### **Death penalty,**

The Cabinet held its weekly meeting under the chairmanship of His Highness the Prime Minister Sheikh Ahmad Abdullah Al-Ahmad Al-Sabah.

Following the meeting, Deputy

Prime Minister and Minister of State for Cabinet Affairs Shereeda Al-Mousherji made the following statement.

The Cabinet reviewed messages received by His Highness the Amir Sheikh Meshal Al-Ahmad Al-Jaber Al-Sabah from several heads of friendly and sisterly states concerning means of strengthening bilateral relations and enhancing cooperation across various fields.

The Cabinet was briefed on the upcoming official visit of His Highness the Prime Minister to Cairo to represent His Highness the Amir at the grand opening of the Grand Egyptian Museum and to hold bilateral talks between October 29 and November 1, 2025.

It also noted His Highness the Amir's directive assigning His Highness the Prime Minister to represent Kuwait at the Second World Summit for Social Development, to be held in Doha from November 4 to 6, 2025, upon an invitation from Qatari Amir Sheikh Tamim bin Hamad Al-Thani.

The Cabinet welcomed the forthcoming official visit of Chinese Vice President Han Zheng and his accompanying delegation to Kuwait on November 1, expressing hope that the visit would further strengthen bilateral cooperation between the two friendly countries.

Ministers also reviewed reports by Deputy Prime Minister and Defense Minister Sheikh Abdullah Ali Al-Salem Al-Sabah and Minister of Public Works Dr. Noura Al-Mashaan on the official opening of the new air traffic control tower and third runway at Kuwait International Airport, describing them as major milestones in the country's aviation infrastructure.

The Cabinet reviewed a presentation by Minister of State for Communications Omar Al-Omar on the framework agreement with Google Cloud and the recently signed contract with Microsoft, followed by an update from Sheikh Abdullah Sabah Al-Hamoud Al-Sabah,

Head of the Supervisory Committee for the Google Strategic Agreement, on progress made in implementing related digital projects.

The Minister of Higher Education and Scientific Research Dr. Nader Al-Jalal submitted a report on the achievements of Abdullah Al-Salem University's Founding Board (2021-2025), highlighting major milestones such as the adoption of the university's organizational structure, strategic plan, and academic programs, and the admission of its first student cohort in the 2023-2024 academic year.

Dr. Al-Jalal also noted that a ministerial decision was issued appointing Dr. Mona Al-Ahmad from Kuwait University's Faculty of Medicine as Acting President of Abdullah Al-Salem University.

The Cabinet approved a draft decreelaw on combating narcotics and psychotropic substances, merging existing laws to unify legal definitions and procedures while strengthening penalties up to capital punishment and heavy fines for traffickers and smugglers.

The Cabinet also approved a draft decree on a memorandum of understanding between the governments of Kuwait and the United Arab Emirates for cooperation in industry and advanced technology, and referred both drafts to His Highness the Amir for endorsement.

The Cabinet discussed several other agenda items and approved relevant recommendations, while referring others to specialized ministerial committees for further study and necessary action.

The statement noted that investigations were conducted by a specialized team of public prosecutors who examined the facts of the case, gathered evidence, and heard witness statements in coordination with relevant authorities to ensure that all financial, technical, and legal aspects were thoroughly addressed.

The Public Prosecution added that the investigations uncovered an organized criminal network that deliberately tampered with the results of several commercial draws, compromising the fairness of their procedures. The network exploited public office and weaknesses in oversight to obtain unlawful financial gains, which were later shared among its members.

"The investigations revealed that these acts were carried out within a complex, well-coordinated criminal structure characterized by planning and coordination among its members. Their aim was to unlawfully seize the prizes of the draws through systematic fraudulent practices based on deception and misrepresentation, constituting a grave violation of the principles of transparency and integrity stipulated by law," the statement added.

It continued, "Evidence confirmed that the defendants acted in concert to carry out the manipulation, using forged official documents and fictitious waivers to transfer the prizes to the actual beneficiaries of the fraud, in return for direct and indirect financial payments-some in the form of bribes, brokerage, or other monetary benefits derived from participation in these acts."

The statement further indicated that the proceeds of these crimes were reinvested in multiple financial transactions that were deliberately disguised to conceal their illicit nature in an attempt to evade legal scrutiny.

The Public Prosecution affirmed its firm commitment to upholding the rule of law, protecting rights, and ensuring justice with impartiality and integrity.

On March 27, the Public Prosecution

On March 27, the Public Prosecution had ordered the detention of a citizen and five expatriates following extensive investigations that revealed their involvement in serious crimes that shocked public opinion, including forgery of official documents, bribery of a public official, facilitation of embezzlement of state funds, money laundering, and other major offenses that caused severe harm to the country's national interests.

The statement noted that these decisive measures were taken in light of recent social media reports concerning the involvement of a public official at the Ministry of Commerce and Industry, who supervised the draws of the Kuwait

Shopping Festival, Ya Hala.

On March 28, Public Prosecutor Counselor Saad Al-Safran ordered that investigations into the Ya Hala Shopping Festival draws be conducted confidentially and that publication of any related news or statements be prohibited.

He said inspection teams surveyed the area to detect violating facilities, issuing citations and ordering the immediate closure of sites posing risks to public safety.

Al-Ghareeb added that the campaign revealed several breaches, including expired fire safety licenses, improper material storage, blocked emergency exits, exposed electrical wiring, and neglected fire equipment maintenance.

He urged property and business owners to adhere to fire safety regulations and cooperate with inspection teams to protect lives and property.

### **Kuwait targets**

He also noted that the discussions would focus on the international legal framework for combating terrorism financing, mechanisms for implementing Security Council sanctions, and mutual legal assistance in investigations related to targeted financial measures.

Among the participants were representatives from the Ministry of Foreign Affairs, Ministry of Interior, Ministry of Defense, Ministry of Commerce and Industry, as well as the Public Prosecution, Kuwait Central Bank, Kuwait Financial Intelligence Unit (FATF), and other relevant bodies.

Meanwhile, the Gulf Cooperation Council (GCC) hailed selection of world expert Dr. Waleed Al-Housani, Head of the GCC Economic Affairs Sector by Financial Action Task Force (FATF) as the first Arab and Gulf International Assessor in the fifth round of country evaluations for anti-money laundering and counter-terrorist financing systems.

In a press release on Monday, GCC Secretary-General Jasem Al-Budaiwi said this selection marks a significant Gulf and international achievement in combating money laundering and terrorist financing.

rorist financing.

He affirmed that this milestone reflects the distinguished standing and confidence that Gulf competencies have attained within the international community, through their capabilities in the fields of evaluation and compliance with international standards.

He added that this achievement comes as GCC countries prepare to undergo the fifth round of mutual evaluations, underscoring their readiness and commitment to safeguarding the integrity of the global financial system in line with best practices and international requirements to combat money laundering and terrorist financing.

Dr. Al-Housani joined a team of six international assessors, with the evaluation process spanning 18 months and including field visits and interviews with relevant authorities in one of the FATF member states, culminating in the preparation of the final report, which was discussed and approved during the General Meeting of FATF, held in the French capital, Paris.

### Only martyrs

Regarding traffic fines and the two-month impoundment of vehicles for parking violations, Sheikh Fahad stressed that Kuwait has laws that must be respected.

Concerning the issue of demographic imbalance, Sheikh Fahad emphasized that the top priority of His Highness the Amir of Kuwait is the establishment of labor cities.

He highlighted that each company has been assigned a specific quota for the number of its workers to ensure there is no favoritism toward any particular nationality.

Regarding anti-money laundering measures, Sheikh Fahad explained that all cash purchases, including gold, have been suspended for several months. Even pharmacies do not permit cash purchases of medicines exceeding KD 10.

# Dems set January deadline for states to apply for early '28 primary contests

COLUMBIA, SC, Oct 28, (AP): Not even a year out from the last presidential election, the Democratic National Committee has begun setting up a framework for the party's next round of presidential primary elections, which could upend the early-voting calendar yet again.

The Rules and Bylaws Committee of the Democratic National Committee on Monday approved a plan giving states until January 16 to submit applications to hold voting contests in the early window ahead of Super Tuesday, when a massive haul of delegates will be awarded.

Four or five states will get an early slot, and all four regions - East, Midwest, South and West - must be represented, according to the framework.

No huge tranche of delegates is necessarily at stake in the early-voting contests, but their heft has traditionally played a pivotal role for candidates seeking to lead their parties, with heavy travel rotations meaning high visibility for the states involved.

We are committed to executing a fair and transparent process that will deliver a battle-tested nominee who will win back the White House for Democrats," the committee co-chairs Minyon Moore and James Roosevelt, Jr. said in a joint statement.

It will be months - and potentially years - before the 2028 calendar is set. In June, several members of new DNC Chairman Ken Martin's leadership team said the party was considering scrambling its voting order for the next election cycle. That also happened in 2024, when at President Joe Biden's behest - South Carolina hosted the Democrats' first-in-the-nation contest, giving the

incumbent president a resounding win in the state that had helped resurrect his flagging campaign four years

That move was also a nod to the party's loyal base of Black voters, while adding Georgia and Michigan to the so-called early window.



# Republicans send Biden autopen report to Justice Dept, urging further investigation

WASHINGTON, Oct 28, (AP): US House Republicans on Tuesday unveiled their long-promised report on former president Joe Biden's use of the autopen, delivering a blistering critique of his time in office and inner circle that largely rehashes public information while making sweeping accusations about the workings of his White House.

The GOP report does not include any concrete evidence that aides conspired to enact policies without Biden's knowledge or that the president was unaware of laws, pardons or executive orders signed in his name. But Republicans said their findings cast doubt on all of Biden's actions in office. They sent a letter to Attorney General Pam Bondi urging a full investigation. President Donald Trump ordered a similar inquiry earlier this year. At its core, the report advances contested claims that Biden's mental state declined to a degree that allowed White House officials to enact policies without his knowledge. It focuses heavily on the pardons he granted in office, including to his son, Hunter Biden, based on depositions with close Biden aides.

'The cost of the scheme to hide the fallout of President Biden's diminished physical and mental acuity was great

but will likely never be fully calculated," the report reads. "The cover-up put American national security at risk and the nation's trust in its leaders in jeopardy." Biden has strenuously denied he was unaware of his administration's actions, calling such claims "ridiculous and false." Democrats on the House Oversight committee denounced the probe as a distraction and waste of time.

Republicans are shifting attention back to Biden at a politically tumultuous time, 10 months into Trump's presidency, with the government shut down and Congress at a standstill over legislation to fund it.

# Pressure builds on Congress to end shutdown, but quick breakthrough appears unlikely

WASHINGTON, Oct 28, (AP): The pressure to end the second-longest federal government shutdown is gaining new urgency this week as millions of Americans face the prospect of losing food assistance, more federal workers miss their first full paycheck and recurring delays at airports snarl travel plans.

The building strain on lawmakers to end the impasse was magnified by the nation's largest federal employee union, which called on Congress to immediately pass a funding bill and ensure workers receive full pay. Everett Kelley, president of the American Federation of Government Employees, said the two political parties have made their point.

"It's time to pass a clean continuing resolution and end this shutdown today. No half measures, and no gamesmanship," said Kelley, whose union carries considerable political weight with Democratic lawmakers.

Still, Democratic senators, including those representing states with many federal workers, did not appear ready to back down. Virginia Sen Tim Kaine said he was insisting on commitments from the White House to prevent the administration from mass firing more workers. Democrats also want Congress to extend subsidies for health plans under the Affordable Care Act.

'We've got to get a deal with Donald Trump," Kaine said.

But shutdowns grow more painful the longer they go. Soon, with closures lasting a fourth full week as of Tuesday, millions of Americans are likely to experience the difficulties firsthand.

The nation's 1.3 million active-duty service members are at risk of missing a paycheck on Friday. Earlier this month, the Trump administration ensured they were paid by shifting \$8 billion from military research and development funds to make payroll. But it is unclear if the Trump administration will be willing - or

Larger still, the Trump administration says funding will run out Friday for the food assistance program that is relied upon by 42 million Americans to supplement their grocery bills. The administration has rejected the use of more than \$5 billion in contingency funds to keep benefits flowing into November. And it says states won't be reimbursed if they temporarily cover the cost of benefits next month. The Department of Agriculture says the contingency fund is intended to help respond to emergencies such as natural disasters. Democrats say the decision concerning the Supplemental Nutrition Assistance Program, known as SNAP, goes against the department's previous guidance concerning its operations during a shutdown.

"The administration is making an intentional choice not to fund SNAP this weekend," said Senate Democratic leader Chuck Schumer of New York. "The emergency funding is there. The administration is just choosing not to use it."

At the Capitol, congressional leaders mostly highlighted the challenges many Americans are facing as a result of the shutdown. But there was no movement toward negotiations as they attempted to lay blame on the other side of the political aisle. "Now government workers and every other American affected by this shutdown have become nothing more than pawns in the Democrats' political games," said Senate Majority Leader John Thune, R-S.D.

The House passed a short-term continuing resolution on Sept. 19 to keep federal agencies funded. Speaker Mike Johnson, R-La., has kept the House out of legislative session ever since, saying the solution is for Democrats to simply accept that

But the Senate has consistently fallen short of the 60 votes needed to advance that spending measure. Democrats insist that any bill to fund the government also address health care costs, namely the soaring health insurance premiums that millions of Americans will face next year under plans offered through the Affordable

The window for enrolling in ACA health plans begins Saturday. In past years, the Centers for Medicare and Medicaid Services has allowed Americans to preview their health coverage options about a week ahead of open enrollment.

As of Monday, Healthcare.gov appeared to show 2025 health insurance plans and estimated prices, instead of next year's options. CMS was expected to temporarily bring back all its workers furloughed during the shutdown, in part to manage the ACA open enrollment period.

Twenty-eight senators, mostly Democrats, signed onto a letter urging Trump's administration to let ACA enrollees start previewing next year's health insurance options on its marketplace website.

Republicans insist they will not entertain negotiations on health care until the government reopens.

Schumer said Republicans would prefer to shut the government down than work with Democrats in preventing massive spikes in their health insurance costs. He said the average American doesn't want to pay an extra \$20,000 a year to cover their health insurance.

Vice President JD Vance was planning to visit a Republican luncheon on Capitol Hill Tuesday. But with President Donald Trump on a three-country Asia tour and congressional leaders dug into their positions, a quick deal appeared unlikely.

Meanwhile, some rank-and-file lawmakers urged their colleagues to consider the impact of their standoff on the lives of federal employees and Capitol police officers who are have not been paid for weeks.

'We have got to come together, which means we've got to talk to one another," Sen. Lisa Murkowski, an Alaska Republican, said in a floor speech urging leaders to stop focusing on who was winning the political fight.

# **Ukraine's long-range strikes cut Russia's** oil refining capacity by 20%: Zelenskyy

KYIV, Ukraine, Oct 28, (AP): Ukraine's long-range strikes on refineries inside Russia have reduced Moscow's oil refining capacity by 20%, Ukrainian President Volodymyr Zelenskyy said, citing intelligence from Western governments.

Over 90% of those deep strikes on Russian soil were carried out by Ukrainian-made long-range weapons, according to Zelenskyy. He said Ukraine needs additional foreign financial help to produce more of them.

"We just need to work on this every day," he said in comments to the media on Monday that were embargoed until Tuesday.

Oil exports play a key role in funding Russia's invasion of its neighbor Ukraine. While Ukrainian weapons take aim at the refineries, new sanctions from the US and the European Union are aiming to cut into Moscow's oil and gas export earnings

Despite renewed US-led peace efforts, the war shows no sign of ending after nearly four years. With the Kremlin showing no willingness to compromise, US President Donald Trump raised the stakes by announcing sanctions last week against Russian oil giants Rosneft and Lukoil. Those sanctions are due to come into force on Nov 21, and Zelenskyy says Trump "probably will use this as a tool of pressure

or dialogue with the Russians. China and India are the biggest customers for Russian oil. Zelenskyy said India "has definitely given all the signals that it will reduce imports of energy resources" from Russia

He said he is hopeful that Trump's planned meeting with his Chinese counterpart Xi Jinping in South Korea on Thursday will bring further reductions in purchases of Russian crude.

By holding nuclear drills and boasting about a successful test of a pioneering atomic-powered cruise missile, Russian President Vladimir Putin is sending a message to Trump: Moscow won't be cowed into making concessions on Ukraine.

Facing Trump's call for a quick ceasefire and bruising, new US sanctions on Russia's oil industry, Putin is again reminding the USand other

Western allies of Kyiv about his nuclear arsenal to back his longstanding, maximalist demands.

He has said Ukraine must pull back its forces from the four regions that Russia has annexed illegally but never fully captured, as well as abandon its bid to join NATO - demands rejected by Kyiv and its Western allies. The Burevestnik, which means "storm petrel" in Russian, is the world's first nuclear-powered missile. That propulsion gives it virtually unlimited range, allowing it to loiter for days, circling the enemy's air defenses and attacking from an unexpected direction.

Putin first announced the missile in a 2018 state-of-the-nation address, along with several other prospective weapons, declaring it would be able to dodge air defenses.

The development of the Burevestnik, which has been code-named "Skyfall" by NATO, has continued despite reported launch failures. On Sunday, Russia's chief military officer, Gen. Valery Gerasimov, reported to Putin that an Oct. 21 test of the Burevestnik was a complete success that proved its capabilities

The missile covered 14,000 kilometers (8,680 miles) during a 15-hour flight using nuclear fuel and conducted maneuvers "demonstrating its high capabilities in evading missile and air defense systems," Gerasimov said.

"The technical characteristics of the Burevestnik missile effectively allow it to be used with guaranteed accuracy against highly protected targets at any distance," he added.

### **Czech leader tasks Babis with forming new govt**

PRAGUE, Oct 28, (Agencies): Czech President Petr Pavel on Monday officially tasked Andrej Babis, leader of the ANO movement, with forming a new government.

Coalition negotiations among ANO, the Freedom and Direct Democracy (SPD) party, and Motorists for Themselves have been underway for about two weeks and are reportedly nearing completion.

Babis wrote on the social platform X that, following the presidential mandate, the coalition partners are now finalizing the coalition agreement and government program statement. "Once these documents are ready, we will move on to the composition of the cabinet," he said, adding that the goal is to form a new government by mid-December.

The SPD's leader Tomio Okamura also confirmed on X that the talks are progressing smoothly.

After a meeting with Pavel, Babis said the coalition agreement could be signed in the coming days.

**MADRID:** The sighting of a drone closed the airspace of a Spanish airport in a major tourist center for two hours Monday night, officials said Tuesday.

Since late September, mysterious drone overflights have caused closures and disruptions at airports across the European Union, including Munich, one of Germany's largest airports, and four in Denmark.

The flying drone was discovered near Alicante-Elche Miguel Hernández Airport, according to AENA, the company that manages Spanish airports.

Ten flights bound for Alicante, which is about 420 kil-

ometers (260 miles) southeast of Madrid, were diverted to cities including Valencia, Barcelona, Mallorca and Murcia, it added. Some flights were delayed, but there were no

The airport broke its monthly passenger record in September with more than 1.9 million visitors, mostly from the United Kingdom, Germany, the Netherlands and Bel-

# Germany's Rheinmetall to build gunpowder, ammo plant in Bulgaria

SOFIA, Bulgaria, Oct 28, (AP): Bulgaria signed an agreement Tuesday with Germany's defense company Rheinmetall to build a gunpowder and ammunitions factory as part of Europe's efforts to improve its defenses following Russia's invasion of

The factory, which will produce gunpowder, 155 millimeter artillery shells and modular charge systems, will be developed as a joint venture between Rheinmetall and Bulgaria's largest state-owned arms factory VMZ-Sopot. The plant will create nearly 1,000 high-skilled jobs, making it one of the largest industrial projects in Bulgaria in recent years, officials said.

The German company will hold a 51% share in the joint venture, and Bulgaria will finance its participation through loans under the European SAFE mechanism.

After signing the agreement, Rheinmetall CEO Armin Papperger said that the new facility could be ready within 14 months and start production of up to 100,000 artillery shells annually.

European Union and NATO member Bulgaria considers the project as part of the joint efforts to strengthen defense production and supply chains. Prime Minister Rosen Zhelyazkov

said the agreement was "a huge step forward in Bulgaria's industrial and defense capabilities.'

Bulgaria was one of the major arms producers in the former Soviet bloc during the Cold War, specializing in small arms, ammunition and light armored vehicles. The collapse of the

Warsaw Pact led to a steep decline in the sector, forcing many state-owned factories to shut down.

Russia's full-scale invasion of Ukraine in February 2022 has brought a new momentum for Bulgaria's arms production, making it an important supplier of ammunition for Kyiv.

# Trump praises Japan's new PM S.Korea's president faces high-stakes diplomacy at APEC summit

TOKYO, Oct 28, (AP): US President Donald Trump began one of his busiest days of his Asia trip on Tuesday by warmly greeting the new Japanese prime minister, and taking her with him as he spoke to US troops aboard an aircraft carrier.

Although Trump is visiting one of America's most steadfast allies in Asia, there's no shortage of uncertainty while he's there. Sanae Takaichi, who became the country's first female prime minister only days ago, must solidify her relationship with Trump while defending her country's economic interests. Trump is trying to nail down \$550 billion in Japanese investment as part of a trade agreement.

As Trump and Takaichi met on Tuesday, they shook hands and he paid her a compliment: "That's a very strong handshake.'

In return, Takaichi talked about watching the third game of the US World Series before the event. She added that Japan would give Washington 250 cherry trees next year to honor America's 250th anniversary, as well as fireworks from Akita Prefecture for July 4 celebrations

She used her early remarks to mention former Japanese Prime Minister Shinzo Abe, her archconservative mentor who forged a strong bond with

Trump during his first term through their shared interest of golf.

"As a matter of fact, Prime Minister Abe often told me about your dynamic diplomacy," she said. Trump called her role as Japan's first woman prime minister as a "big deal," putting an emphasis on the U.S. commitment to Japan.

SEOUL, South Korea, Oct 28, (AP): South Korea's new president will host leaders from 20 countries for the upcoming Asia-Pacific Economic Cooperation summit, where the American and Chinese leaders are set to hold a high-stakes meeting on the sidelines.

The two-day annual APEC summit, which opens in Gyeongju on Friday, is likely to test Lee Jae Myung's diplomatic abilities as he faces tough foreign policy challenges.

Lee, in office less than five months, seeks to get along with friends and rivals alike with his self-proclaimed "pragmatic diplomacy." But prospects for greater cooperation with Washington and Tokyo are in doubt due to Trump's tariff war and the election of a new ultraconservative leader in Japan. Tensions with North Korea remain high after Pyongyang snubbed Lee's overture and bolstered ties with Russia and China instead.

In Gyeongju, Lee is expected to hold one-on-one meetings with US President Donald Trump, Chinese President Xi Jinping and new Japanese Prime Minister Sanae Takaichi, while presiding over APEC events.

Experts say the summit may offer positive optics for Lee, but it doesn't guarantee long-term diplomatic suc-

This year's APEC summit, the first in South Korea in 20 years, is overshadowed by Thursday's Trump-Xi meeting, whose results are expected to have a major impact on the global economy. Trump will likely skip APEC's main conference, but experts say Lee could still align with other countries to promote free trade and

multilateralism.

South Korean officials say they've been holding ministerial-level communications with other countries to prod all 21 to issue a joint declaration at the end of the summit in an effort not to repeat the failure to reach one in 2018 in Papua New Guinea due to US-China discord over trade.

"Of course, there are some lingering issues, but many have been resolved We're making efforts toward the adoption of a 'Gyeongju Declaration' and acting as a mediator between the U.S. and China," South Korea's national security director Wi Sung-lac told local

broadcaster KBS on Sunday. Top South Korean officials have been recently flying in and out of Washington to finalize a trade agreement with the US, but it's unclear if the two countries can strike one in time for

the APEC summit.

South Korea's trade minister, Kim Jung-Kwan, told lawmakers Friday that Washington and Seoul remain "sharply divided" over how much of South Korea's promised \$350 billion U.S. investment package should be provided as direct cash payments under a July deal aimed at averting the Trump administration's highest

There are also worries that South Korea's ties with Japan could turn sour because of the recent inauguration of Japan's Takaichi, who has right-wing views on her country's wartime ag-

Relations between the Asian neighbors and their trilateral military cooperation with the U.S. have improved in

# Military-backed party in Myanmar holds rallies as campaign begins for Dec election

parties in military-run Myanmar on Tuesday kicked off their election campaigns, two months ahead of scheduled national polls that are widely seen as an effort to confer legitimacy on the military's 2021 seizure of power, even as the country's civil war precludes voting in many areas.

Campaigning began just a day after UN Secretary-General António Guterres, in a meeting with leaders of Southeast Asian nations, warned that the planned election could cause further instability and deepen Myanmar's

Critics of the military-led government charge that the polls, which are set to begin on Dec. 28, will be neither free nor fair.

Fifty-seven parties have registered for the contest but Aung San Suu Kyi 's National League for Democracy, which won the last two elections by landslides only to be ousted by the army, is not among them.

It was one of dozens of parties ordered disbanded by the army-appointed Union Election Commission more than two years ago after it refused to take part in what it saw as a sham pro-

On Tuesday, the military-backed Union Solidarity and Development

### Record rainfall causes major flooding in Vietnam, submerging ancient sites

HANOI, Vietnam, Oct 28, (Agencies): Heavy rains have caused major flooding in central Vietnam, with rivers swelling and inundating homes and farmland, and submerging tourist destinations including the historic cities of Hue and Hoi

By late Monday, rainfall in the central city of Hue reached 1,085.8 millimeters (42 inches) within 24 hours, the highest volume ever recorded in Vietnam, according to the country's meteorological depart-

By Tuesday morning, water levels in Hue's iconic Perfume River had risen to 4.62 meters (15 feet), while the UNESCO-listed former imperial capital and the ancient town of Hoi An experienced floods reaching waist-deep. Tourists were evacuated by boat on Monday from Hoi An's ancient town after persistent rainfall and releases from hydroelectric dams caused water in the Hoai River to rise nearly 2 meters (6.5 feet).

The floods in Hue submerged homes and cut off major streets as 32 of its 40 residential areas were flooded, state media reported, adding that residents navigated the submerged streets by using boats.

The train route between Hanoi in

the north and the financial capital of Ho Chi Minh city in the south was also suspended because of the floods, impacting thousands of passengers, state media said.

HANOI: Four people died of suffocation on Tuesday in Vietnam's central city of Da Nang after using a generator to produce electricity inside an enclosed house, Vietnam News Agency reported.

All eight people inside the house

were taken to local hospitals, where four were pronounced dead during emergency treatment, including a five-year-old child and a 75-yearold woman, the report said.

Local authorities have urged relevant agencies to inspect residential areas, especially households using generators, charcoal stoves or other heat-generating devices in enclosed spaces, and to strengthen public communication on safe use practices amid prolonged flooding and widespread power outages.

# India closes schools and evacuates thousands as cyclone approaches

NEW DELHI, Oct 28, (AP): Indian authorities have shut schools and evacuated tens of thousands of people from low-lying coastal areas as the country's eastern seaboard braces for the impact of Cyclone Montha later Tuesday.

Swirling over the Bay of Bengal, Montha has intensified into a severe cyclonic storm, and is expected to make landfall late Tuesday near the port city of Kakinada in southern Andhra Pradesh, the weather office said in its latest bulletin.

The storm hovered around 160 kilometers (99 miles) southeast of Machilipatnam in Andhra Pradesh.

It is expected to intensify, bringing winds of 90 kph to 110 kph (55-68 mph) as it pushes toward the country's eastern coastline.

The weather office issued so-called red alerts - the highest level of weather warnings - for 19 districts in Andhra Pradesh, forecasting extremely heavy rains. The neighboring states of Tamil Nadu, Telangana, Kerala and Karnataka are also expected to receive moderate to heavy showers.

Disaster teams in Andhra Pradesh have so far evacuated 38,000 people from low-lying areas to relief camps. according to a state disaster official.

The authorities have readied 1,906 relief camps and 364 school shelters as

evacuations continue in 1,238 vulnerable villages, the state's minister for communications Nara Lokesh said in a social media post.

Schools and colleges have been ordered to remain shut till Wednesday and fishermen warned not to venture into the sea for fishing. Trains and flight services were partially disrupted on Tuesday.

In Odisha, the state administration has begun shifting around 32,000 people from vulnerable areas to relief camps, a state disaster official said.

Climate scientists say severe storms are becoming more frequent in South Asia. Global warming driven by planet-heating gases has caused them to become more extreme and unpredict-

India's eastern coasts have long been prone to cyclones, but the number of intense storms is increasing along the country's coast. 2023 was India's deadliest cyclone season in recent years, killing 523 people and causing an estimated \$2.5 billion in damage.

Tropical cyclones, which are called hurricanes or typhoons in other regions, are among the world's most devastating natural disasters when they hit densely populated coastal areas.

### Kenya plane crash kills 11: airline

Eleven people, including 10 foreign tourists, were killed early Tuesday when a light aircraft crashed in Kwale County, Kenya's coastal region, while en route to the world-famous Maasai Mara National Reserve, the airline said.

Mombasa Air Safari confirmed that eight Hungarian and two German passengers, along with a Kenyan pilot, were on board the aircraft, registration number 5Y-

CCA, which had taken off from Diani, a popular tourist

"Sadly, there are no survivors," the airline said in a statement, noting that it has activated its emergency response team and is working closely with authorities to establish the cause of the crash.

"Our hearts and prayers are with all those affected by this tragic event," the company said. (Xinhua)

## **Peace talks hosted by Turkey between** Pakistan, Afghanistan hit impasse in Istanbul

ANKARA, Turkey, Oct 28, (AP): Peace talks between Pakistan and Afghanistan have hit an impasse in Istanbul after three days of negotiations, with state media in both countries Tuesday blaming each other for the failure to reach a deal while efforts by Turkey were still underway to end the

The Istanbul talks are part of a broader diplomatic push to ease months of heightened tension between Islamabad and Kabul over cross-border attacks and militant safe havens - issues that have strained relations since the Taleban's return to power in Afghanistan four years ago.

Delegations from the two neighbors remain in Turkey, but it was not immediately clear whether a fourth day of talks would be held.

Pakistan Television early Tuesday reported that Turkish officials and several other countries are working to preserve the ceasefire agreed on Oct 19 in Doha after the first round of negotiations. The agreement followed deadly cross-border clashes that killed dozens of soldiers,

militants and civilians on both sides.

Three Pakistani security officials who had direct knowledge of the negotiations told The Associated Press that there is a deadlock in the talks in Istanbul over the reluctance of Kabul in accepting what they described as Pakistan's logical and legitimate demands about assurances that Afghan soil not be used against Pakistan.

## US kills 14 in strikes on four alleged drug boats in Pacific

WASHINGTON, Oct 28, (Agencies): US Defense Secretary Pete Hegseth announced that the US military carried out three strikes Monday in the waters of the Eastern Pacific against boats suspected of carrying drugs, killing 14 and leaving one survivor.

The announcement made on social media Tuesday, marks a continued escalation in the pace of the strikes, which began in early September spaced weeks apart. This was the first time multiple strikes were announced in a single day.

Hegseth said Mexican search and rescue authorities "assumed responsibility for coordinating the rescue" of the sole survivor but didn't say if that person would stay in their custody or be handed over to the U.S.

In a strike earlier in October which had two survivors, the U.S. military rescued the pair and later repatriated them to Colombia and Ecuador. Hegseth posted footage of the strikes to social media in which two boats can be seen moving at speed through the water. One is visibly laden with a large amount of parcels or bundles. Both then suddenly explode and are seen aflame.

**CARACAS:** Venezuelan authorities on Monday arrested three individuals allegedly linked to the CIA, Interior Minister Diosdado Cabello Rondon said. During the arrests, authorities reportedly seized mobile phones and CIA operational manuals, Cabello

The minister said the suspects were involved in a suspected false-flag operation in the Caribbean Sea as the United States undertakes military exercises with Trinidad and Tobago. The plan aimed to fabricate an incident that could justify aggression against Venezuela, Cabello added.

Venezuela's government has information that they intend to "attack a US military ship stationed on that island and then blame Venezuela to justify an attack" on the South American country, Venezuelan Foreign Affairs Minister Yvan Gil said in a post on social



This will be confirmed following the completion of the requirements and implementation of the accounting standard and retaining the option of presenting this matter to the General Assembly for approval.

Due to the robust results of the first nine months of 2025, that saw earnings per share reach an exceptional 41 fils, the Board of Directors has declared a second interim cash dividend of 25 fils per share for profits achieved for period ending September 30, 2025. Registered shareholders will receive payments on November 19. This second interim dividend comes in addition to the earlier interim dividend of 10 fils per share for the first half of 2025. With these two distributions, Zain Group has fulfilled its obligations related to the dividend distribution policy.

Operational review of key markets for the Q3&9M period ended 30 September, 2025

Kuwait: Zain Group's flagship and most profitable operation maintained its market leadership, serving a customer base of 2.6 million. Q3 2025 revenue increased 5% YoY to KD 99 million (USD 323 million), while EBITDA reached KD 34.5 million (USD 113 million), reflecting an EBITDA margin of 35%. Q3 net income reached KD 20 million (USD 64 million) while 9M 2025 net income stood at KD 60 million (USD 196 million). Data revenue grew 4% YoY, representing 36% of total revenue. Continued investment in 5G-Advanced networks, coupled with enhanced customer experience, Aland monetization initiatives across individual, enterprise, and government segments, remain key drivers of growth.

Saudi Arabia: Revenue for Q3 2025 grew 6% YoY to reach USD 733 million, with EBITDA growing 0.3% to reach USD 229 million, reflecting an EBIT-DA margin of 31%. Net income for Q3 increased 2% to reach USD 41 million and 9M 2025 Net Income increased 16% to reach USD 99 million. The operator's 5G network, now covering 90 cities and 67% of the country, drove a 4% increase in data revenue, representing 40% of total revenue in 9M 2025, while customer base stood at 8.6 million. The launch of device sales by Yaqoot through online platform partners alongside key AI and monetizationinitiatives in Zain KSA were instrumental in accelerating customer growth and boosting revenues, while enhancements to its Fintech entity, Tamam, strengthened the platform's performance, resulting in higher loan approvals and volumes resulting in a 23% YoY increase in revenue.

Iraq: Zain Iraq recorded revenues of USD 342 million in Q3 2025, marking a 20% year-on-year increase, with nine-month revenues reaching USD 942 million, up 18% from 2024. Zain Iraq's customer base increased 5% year-on-year to reach 20.4 million, maintaining its market leading position. EBITDA grew 7% to USD 129 million with a 38% margin, while net profit rose 19% to USD 47 million in Q3 and 21% to JSD 113 million for the nine-month period.

Sudan: Revenue for Q3 2025 soared 147% YoY, to reach USD 143 million, EBITDA soared262% reaching USD 82 million, reflecting an EBITDA margin of 57%. Q3 Net income surged by 77% to reach USD 59 million while9M 2025 net income increased 92% to reach USD 171 million. Customer base expanded by 39% YoY, reaching 12.2 million. Stabilization of situation in Khartoum and several other major population centers marked a pivotal turning point for the operation. The restoration of over 650 sites and upgrade of 315 sites to 4G have enabled the return of approximately 7 million customers to the network. This combined with the ongoing monetization initiativesboosted commercial activity and revenue growth.

Jordan: Q3 2025 revenue grew 8% YoY to reach USD 152 million, with EBITDA for Q3 up3% to reach USD 58 million, reflecting an EBITDA margin of 38%. Net income for Q3 stood at USD 20 million while 9M 2025 net income stood at USD 59 million with growth of 7%. The ongoing expansion of 5G, FTTH and 4G services across the country led to data revenue growth of 14% for 9M 2025, which now represents 54% of total revenue. Zain Jordan served 4.3 million customers, up 1%, maintaining its market leadership.

Bahrain: Revenue for Q3 2025 grew 3% YoY to reach USD 52 million, with EBITDA reaching USD 16 million, reflecting an EBITDA margin of 31%. Q3 net income increased 1% to reach USD 4.4 million and 9M2025 net income increased 3% to USD 11 million. 9M2025 data revenue grew 5% to represent 46% of total revenue.

# Gulf Bank records KD 38.4 mln in net profit for the first nine months of 2025 with a 19.4% year-on-year growth in third quarter net profit

KUWAIT CITY, Oct 28: Gulf Bank K.S.C.P. announced its financial results for the first nine months ending 30 September 2025. The Bank reported a net profit of KD 38.4 million for the first nine months of 2025, a slight decline of KD 1.8 million or 5% when compared to 2024 first nine months net profit of KD

Additionally, Gulf Bank recorded an operating income of KD 140.5 million for the first nine months of 2025, representing a decline of 4% compared to the same period of last year. Moreover, operating profit before provisions and impairments was KD 69.0 million, representing a decline of 12% compared to the first nine months of 2024.

For the third quarter ending 30 September 2025, Gulf Bank reported a net profit of KD 14.3 million, reflecting a year-on-year increase of KD 2.3 million or 19.4%.

#### **Financial Performance**

The decline in net profit for the first nine months of 2025 is attributed to the decline in net interest income of KD 8.0 million or 6.8%, coupled with an increase in operating expenses of KD 4.1 million or 6.1%, compared to the same period of 2024. However, these declines were partially offset by an enhancement in non-interest income of KD 2.5 million or 8.7%, and the improvement in total provisions and impairments, which declined by KD 7.7 million or 21.1% year-on-year, reaching KD 28.8 million for the first nine months of 2025.

As for asset quality, the non-performing loans (NPL) ratio was 1.4% as of 30 September 2025, compared to the prior year level of 1.3%. Additionally, the Bank continues to have significant non-performing loans coverage ratio of 324% including total provisions and collaterals.

Total credit provisions as of 30 September 2025 reached KD 271 million whereas IFRS 9 accounting requirements (i.e., ECL or expected credit losses) were KD 172 million. As a result, the Bank has a healthy excess provision level of KD 99 million, above and beyond what is required by IFRS 9 accounting requirements.

Compared to 31 December 2024, total assets increased by 1.5% to KD 7.6 billion, whereas net loans and advances increased by 4.1% to KD 5.7 billion. On the other hand, total deposits stood at KD 5.6 billion and total Shareholders' equity reached KD 839 million.

The Bank's regulatory Tier 1 ratio of 14.3% was 2.3% above the regulatory minimum of 12% and the Capital Adequacy Ratio (CAR) of 16.4% was 2.4% above the regulatory minimum of 14%.

#### **Steady Progress**

Commenting on the financial results for the first nine months of 2025, Gulf Bank Chairman Mr. Ahmad Mohammad Al-Bahar stated: "Gulf Bank's performance over the first nine months of the year demonstrates continued progress in strengthening the Bank's financial position. This was driven by steady loan growth, stable asset quality, and a robust capital base.'

He continued: "The broader operating environment in Kuwait has become more favorable. The Central

The event coincided with the annual meetings of the International Monetary Fund (IMF) and the World Bank Group (WBG). Markaz was represented by Mr. Ali H. Khalil, Chief Executive Officer of Markaz, alongside a distinguished delegation from the company's Wealth Management and International Real Estate teams, represented by Mr. Abdullatif W. Al-Nusif, MD, Wealth Management and Business Development, and Mr. Sami Shabshab, President of Mar-Gulf Management Inc, the real estate arm of Markaz

During the event, Mr. Khalil participated in a panel discussion titled "Foundations for a New Era," where he discussed pathways to realize"New Kuwait 2035" vision, and the challenges involved in reallocating resources and creating an enabling environment for private sector investment. He emphasized that Kuwait's advanced economic ecosystem has created a deep and active financial market that successfully attracted foreign investors, resulting in a significant reduction in the cost of funding and thereby stimulating foreign investment in Kuwait.

Mr. Khalil commended the efforts of Kuwait Investment Authority (KIA) in developing the stock market in Kuwait, and praised Boursa Kuwait and the Capital Markets Authority (CMA) for creating an attractive and sustainable investment environment, and praised the vital role played by the Kuwait Direct Investment Promotion Authority (KDIPA) since its establishment in facilitating business operations and enabling full foreign ownership within a clear legal framework that encourages international joint investments through an appealing tax regime and efficient, fair dispute resolution mechanisms.

He also underscored the importance of adopting Environmental, Social, and Governance (ESG) principles, explaining that awareness and integration of ESG practices generate both direct and indirect benefits that create long-term added value through innovation and creativity. Powell balances weak hiring, high inflation

# Fed likely to cut key rate Wednesday and may signal another cut to follow

WASHINGTON, Oct 28, (AP): The Federal Reserve will almost certainly cut its key interest rate on Wednesday and could signal it expects another cut in December as the central bank seeks to bolster hiring.

A cut Wednesday would be the second this year and could benefit consumers by bringing down borrowing costs for mortgages and auto loans. Since Fed chair Jerome Powell strongly signaled in late August that rate cuts were likely this year, the average 30-year mortgage rate has fallen to about 6.2% from 6.6%, providing a boost to the otherwise-sluggish

housing market. Still, the Fed is navigating an unusual period for the U.S. economy and its future moves are harder to anticipate than is typically the case. Hiring has ground nearly to a halt, yet inflation remains elevated, and the economy's mostly solid growth is heavily dependent on massive investment by leading tech companies in artificial intelligence infrastructure.

The central bank is assessing these trends without most of the government data it uses to gauge the economy's health. The release of September's jobs report has been postponed because of the government shutdown. The White House said last week October's inflation figure may not even be compiled.

The shutdown itself may also crimp the economy in the coming months, depending on how long it lasts. Roughly 750,000 federal workers are nearing a month without pay, which could soon start weakening consumer spending, a critical driver of the economy.

Federal workers laid off by the Trump administration's Department of Government Efficiency efforts earlier this year may formally show up in jobs data if it is reported next month, which could make the monthly hiring data look even worse.

Powell has said that the risk of weaker hiring is rising, which makes it as much of a concern as stillelevated inflation. As a result, the central bank needs to move its key rate closer to a level that would neither slow nor stimulate the economy.

Most Fed officials view the current level of its key rate - 4.1% - as high enough to slow growth and cool inflation, which has been their main goal since price increases spiked to a four-decade high three years ago. The Fed is widely expected to reduce it to about 3.9% Wednesday. With job gains at risk, the goal is to move rates to a less-restrictive level.

Kris Dawsey, head of economic research at D.E. Shaw, an investment bank, said that the lack of data during the shutdown means the Fed will likely stay on the path it sketched out in September, when it forecast cuts this month and in December.

"Imagine you're driving in a winter storm and suddenly lose visibility in whiteout conditions," Dawsey said. "While you slow the car down, you're going to continue going in the direction you were going versus making an abrupt change once you lose that visibility." In recent remarks, the Fed chair has made clear that the sluggish job market has become a signficant

"The labor market has actually softened pretty considerably," Powell said. "The downside risks to employment appear to have risen."

Before the government shutdown cut off the flow of data Oct. 1, monthly hiring gains had weakened to an average of just 29,000 a month for the previous three months. The unemployment rate ticked up to a still-low 4.3% in August from 4.2% in July.

Layoffs also remain low, however, leading Powell and other officials to refer to the "low-hire, low-fire" job market.

At the same time, last week's inflation report - released more than a week late because of the shutdown - showed that inflation remain elevated but isn't accelerating and may not need higher rates to tame it.

Yet a key question is how long the job market can remain in what Powell has described as a "curious kind of balance."

"There have been some worrisome data points in the last few months," said Stephen Stanley, chief U.S. economist at Santander, an investment bank. "Is that a weakening trend or are we just hitting an air

The uncertainty has prompted some top Fed officials to suggest that they may not necessarily support a cut at its next meeting in December. At its September meeting, the Fed signaled it would cut three times this year, though its policymaking committee is divided. Nine of 19 officials supported two or fewer reductions.

Christopher Waller, a member of the Fed's governing board and one of five people being considered by the Trump administration to replace Powell as Fed chair next year, said in a recent speech that while hiring data is weak, other figures suggest the economy is growing at a healthy pace.

"So, something's gotta give," Waller said. "Either economic growth softens to match a soft labor market, or the labor market rebounds to match stronger economic growth."

Since it's unclear how the contradiction will play out, Waller added, "we need to move with care when adjusting the policy rate."

Waller said he supported a quarter-point cut this month, "but beyond that point" it will depend on what the economic data says, assuming the shutdown

Financial markets have put the odds of another cut in December at above 90%, according to CME Fedwatch - and Fed officials have so far said little to defuse that expectation.

Jonathan Pingle, chief U.S. economist at UBS, said that he will look to see if Powell, at a news conference Wednesday, repeats his assertion that the risks of a weaker job market remain high.

"If I hear that, I think they're on track to lowering rates again in December," he said.



be able to cut rates by another 50bps this year as the softening labour market tips the balance back to easing, but with sticky inflation and a relatively resilient economy supported by fiscal stimulus, we are not forecasting further Fed rate cuts in 2026 and 2027." Paul Mackel, HSBC Global Head of FX Research. added that "The USD has had a volatile

year so far, initially riding on a wave of optimism before suffering one of its largest defeats. The outlook still points to a soft USD in the months ahead."

Meanwhile, Simon Williams, HSBC Chief Economist for CEEMEA, commented, "Kuwait continues to lag some of its peers, and the pressure on oil prices is a concern. But the potential is clear, and if policymakers start to accelerate movement on reform, 2026 could be Kuwait's inflexion year." The Economist Roadshow continues

'Comedy Nerd'

### **Apatow shares his** hoarded memories

NEW YORK, Oct 28, (AP): Judd Apatow likes to keep stuff. He even goes as far as to say he's a hoarder. But unlike a regular hoarder, he insists all the things he keeps are awesome - and neatly collected.

"I save everything, but I don't have it in a mound in the middle of the house," the writer-director says. "I'm the Felix Unger of hoarding. Everything is taken care of very well."

Fans of Apatow - and fans of comedy in general - get the benefit of this personality quirk with the Tuesday publication of "Comedy Nerd," a bulging, 570-page, photo-filled memoir from every chapter of his storied career.

It's packed with behind-the-scenes snapshots from sets, script fragments, notes from network bosses, essays, movie posters and miniprofiles of his fellow comedians. There's his late-night ideas for "Knocked Up" typed into a BlackBerry and a photo of Adam Sandler's old fake ID.

"I feel like just making this book justifies the hoarding," Apatow says with a laugh. "I did save it for a reason. I wasn't wrong to not throw out my photograph of Billie Jean King from when I was 10

The producer, director and writer behind the movies "This is 40- and "The 40-Year-Old-Virgin," was inspired to make the book from similar memorabilia-filled offerings from the Marx Brothers and "Saturday Night Live."

He spent a year going through his photos - 400,000 of them - keepsakes and clippings, then scanned everything into his computer and laid out the entire book in a raw way. He spent the next year writing essays and captions.

"The idea was that the experience of looking at the book would be as if I was over your shoulder explaining what things were and telling you stories,' he says.

### Reminder

Apatow includes memos he got from network standards - "Just a reminder that Ben's gyrating dance not be sexual," one reads about "The Ben Stiller Show" - as well as Garry Shandling's note-filled revision to a script from "The Larry Sanders Show" and a page from an unproduced screenplay written by Owen Wilson. Apatow reveals Paul Rudd had a pretty funny but lost cameo from "Bridesmaids."

He includes the increasingly snarky email exchangs in 2001 between him and writer Mark Brazill beef ing over a long forgotten comedy sketch, and there's an alternate initial setup for "Anchorman" - a group of anchors on a plane crash into a snowy mountain that becomes a parody of the movie "Alive."

Andy Ward, Apatow's editor and executive vice president and publisher of Random House, said it was a book only Apatow could make - he being a visual thinker, a loving collector and a comedy ob-

"There's a photographic element to this. There's a sort of scrapbook-found object element. There's advice in it about a life in comedy," says Ward. "If you know him at all, it is very true to who he is and I think how he approaches what he does.

Apatow is even not afraid to show times where he was foolish. "I think a lot about all the people I got a chance to collaborate with and how magical a bunch of those times were. So I'm very happy to also show where I was an idiot or awful because that is part of the journey," he says.

There are pages dedicated to TV shows that never got made, like "North Hollywood," about three friends trying to break into show business that would have starred Amy Poehler, Kevin Hart, Jason Segel, January Jones and Judge Reinhold.

It seemed fun, at least judging from the photos at a party during the shooting of the pilot that shows folks getting stoned. "Do people want me to show the photos of them smoking enormous joints in the year 2002?" asks Apatow. The answer is yes.

Failures litter the pages of "Comedy Nerd" despite the author's bankable instincts, which have given us "Freaks and Geeks" and "Girls" on TV and the Oscar-nominated films "Bridesmaids" and "The Big Sick."

### 'The Lost King' filmmakers pay damages for misrepresentation

# Producers settle libel suit over King Richard III movie

LONDON, Oct 28, (AP): It was a true story stranger than fiction: The body of England's King Richard III, missing for centuries, was discovered under a parking lot after a search spearheaded by amateur sleuths.

Now a movie about the saga has been accused of stretching the truth too far.

The producers of "The Lost King" on Monday agreed to pay damages to an academic who sued for libel over his on-

Richard Taylor said he suffered "enormous distress and embarrassment" because of the 2022 film, which centers on amateur historian Philippa Langley's quest to find the king's remains despite what the movie depicts as indifference and condescension from the academic world.

A judge at a preliminary hearing last year said the film portrayed Taylor, the former deputy registrar at the University of Leicester, as "smug, unduly dismissive and patron-

The case had been due to go to a full trial, but on Monday a lawyer for Taylor announced that the dispute had been settled. Attorney William Bennett said the defendants - actor-writer Steve Čoogan, Coogan's production company Baby Cow and Pathé Productions - had agreed to pay Taylor "substantial damages" and legal costs. The amount was not disclosed.

The defendants said they would also add an on-screen clarification at the start of the film stating that the depiction is "fictional and does not represent the actions of the real Mr. Taylor."

Taylor, who is now chief operating officer at Loughborough University, said the settlement was vindication after "a long and grueling battle."

"There have been moments over the last three years when I thought, when Philippa Langley approached me for the university's support, I perhaps should have put the request in the bin," he said. "But I didn't, and I think I was right not

Coogan, who co-wrote "The Lost King" and played Langley's ex-husband, insisted that "this film is a true story, Philippa Langley's story. That is the story I wanted to tell, and I am happy I did.

"If it wasn't for Philippa Langley, Richard III would still be lying under a car park in Leicester," Coogan said. "It is her name that will be remembered in relation to the discovery of the lost king, long after Richard Taylor has faded into obscurity.' University of Leicester archaeologists worked with Lang-

ley in 2012 to locate Richard's skeleton in the city in central England, more than five centuries after he was killed at the Battle of Bosworth Field in 1485, the last act of a civil conflict known as the Wars of the Roses.

The victor took the throne as King Henry VII, and under the Tudor dynasty he founded, Richard was vilified. William Shakespeare depicted him as an evil, hunchbacked usurper who murdered his two young nephews because they were

Some historians, including Langley, believe Richard was unfairly maligned, arguing that he was a relatively enlightened monarch whose short reign between 1483 and 1485 saw reforms including the introduction of the right to bail and the lifting of restrictions on books and print-

Scientists from the University of Leicester worked to confirm the remains belonged to the medieval king, and in 2015 Richard was reburied with royal ceremony in a tomb at Leicester Cathedral.

Singer lets loose on 'It's Not That Deep'

# Lovato celebrates life's joy on new album

LOS ANGELES, Oct 28, (AP): On her ninth studio album, Demi Lovato has had a revelation: "It's Not That

It's the title of her energetic dance-pop record, and a celebration of life's joys and messiness - all of which appear across its 11 tracks.

"I've put so much energy and so much love into this album," Lovato told The Associated Press at rehearsals for a special One Night Only event at the Palladium in Los Angeles last week. "I just couldn't be more excited."

Next spring, she'll tour the album, hitting 23 cities across North America. The "It's Not That Deep" Tour kicks off April 8 at the Spectrum Center in Charlotte, North Carolina, and concludes May 25 at the Toyota Center in Houston.

Lovato will hit Orlando, Florida; Atlanta; Nashville; Washington, D.C,; Philadelphia; Toronto; Boston; New York; Columbus, Ohio; Detroit; Chicago; Minneapolis; Denver; Las Vegas; Anaheim, California; San Francisco; Seattle; Los Angeles; Glendale, Arizona; Dallas and Austin, Texas.

Artist presale begins Thursday at 10 a.m. local time. General sales begin Friday.

In an interview with The Associated Press, Lovato discussed her new album, her penchant for musical transformation and her forthcoming tour.

This interview has been edited for length and clarity. AP: You've said this new album, this new era, is a celebration of your journey. You're embracing the old, new, good, bad — from coming out on stage with the Jonas Brothers and singing "Camp Rock" stuff to the Poot meme. Are you reclaiming it?

**Lovato:** I think it's a bit of owning it. ... I guess I didn't realize that I've done iconic things. And if they are cringe to some people, they're fun to me. ... I think it's, like,

making peace with my past. ... I've made peace with my journey and now I'm celebrating where I am at today.

For instance: The Poot meme, when it first happened, I didn't realize it was photoshopped. I thought it was a bad angle of me. So, I like was really self-conscious about that meme and was like, "Oh my God, like, I can't believe people are laughing at a bad angle of me," and then I realized it was photoshopped and I was like "Wait, this is actually hilarious." ... Life is too short to take yourself too seriously, and I'm definitely not doing that anymore.

**AP:** That's refreshing to hear a pop star say. When you let go of those feelings, what does it unlock for you cre-

Lovato: I think there's something about your 30s, too, where you just take a second, and you are able to let go of some of the pressures that you once put on yourself, maybe in your 20s. And now I'm 33, and I'm not taking myself so seriously because I realize there's room for

Creatively, what it unlocks for me is spontaneity and taking risks and having fun and cherishing the moments. ... "Kiss," for instance, it's not the most intellectually stimulating song. It's a simple party, fun song, and it's sexy. And it's like, that's what it is. And I think so much of my past was, like, "I want to try and write, you know, deeply emotional songs about my past" and with this album, I was like, "I'm in a place where I'm having fun. I want my lyrics to reflect that, too."

**AP:** That's evident in the music — the party energy and the lyrical content. And there's a duality.

**Lovato:** It was exactly what I was hoping for. There's songs like "Sorry to Myself," too, which is another party moment but has a really powerful message. And it also bridges the gap between my old music and my music today, lyrically, where it is a bit emotional.

**AP:** You've played with a lot of genres like pop, rock, R&B and more. What drives these transformations for you?

Lovato: I think what drives the transformations for me are literally what is inspiring me musically at the moment. And so, I'm a fan of all genres of music pretty much, for the most part. When I was in my rock era, I was listening to a lot of rock music that was inspiring

I went into this album thinking, "I'm gonna make an even harder rock album. I wanna go even more rock." So, I started this process and I realized, I was like, "There's only so many happy rock songs that you can write." I'm in love, I'm feeling empowered, and I'm in this really great place, and I don't know how to write rock songs that are, you know, all sunshine and rainbows. And there's only so many of that that you can write. And so, I was like, "I need to switch up the genre." So, I tried a couple of their genres, but what was really inspiring me was all the pop girlies and the pop artists that are out there today.

AP: Let's talk about the tour. Your one night only show — an intimate 4,000 capacity room — was so popular, your team said over 200,000 people were in the Ticketmaster queue. You're in demand.

**BAGHDAD:** Iraqi Minister of Culture, Tourism, and Antiquities Ahmed Fakak al-Badrani announced on Monday the seizure of 185 Iraqi-origin artifacts in Britain, reaffirming the government's commitment to protecting its national heritage.

The minister made the announcement during his address at the 8th Scientific Conference, titled "The Civilizational Role of the City of Baghdad Through the Ages," held in the Iraqi capital. He credited the Iraqi cultural attache in London for notifying the ministry of the seizure.

"The Iraqi cultural attache in London formally informed the ministry about the seizure of the 185 artifacts. Archaeological experts subsequently confirmed their Iraqi origin," al-Badrani told the conference.

The minister noted that a significant number of antiquities have been recovered under the current and previous Iraqi governments, highlighting sustained efforts to repat-

The period following the 2003 US-led invasion of Iraq marked a catastrophic chapter for the nation's cultural heritage, as the ensuing security vacuum led to the massive and systematic looting of thousands of ancient artifacts, particularly from the Iraqi National Museum in Baghdad and countless unprotected archaeological sites

According to statistics from the Iraqi Ministry of Culture, Tourism and Antiquities, more than 40,000 artifacts smuggled abroad have been recovered since 2003, including more than 17,000 pieces recovered from the United

States. (Xinhua)

CANBERRA: Social media companies TikTok, Meta and Snap told the Australian parliament on Tuesday that they will comply with the nation's world-first social media ban for under-16s.

Under laws passed by the Australian government in 2024, children younger than 16 will be blocked from holding accounts on social media platforms from Dec. 10,

Addressing a senate inquiry on Tuesday, executives from TikTok parent company ByteDance, Snapchat owner Snap and Meta, parent company of Facebook and Instagram, said they would comply with the ban and start deactivating children's accounts once the law takes effect. Jennifer Stout, Snap's senior vice president of global policy, told the inquiry via video link that the company would comply despite its opposition to the law. (Xinhua)

**NEW YORK:** The brother of designer Kenneth Cole says

he was vindicated on Monday by a federal appeals court's decision to overturn his criminal fraud conviction.

Neil Cole said he's been fighting over a decade to clear his name after federal authorities claimed that he committed securities fraud while running Iconix Brand Group Inc., the company he founded that partnered with some big names in the entertainment world, including Madonna, Jay-Z and Pharrell Williams.

"It's wonderful," Cole said in a telephone interview about the written decision by the 2nd US Circuit Court of

Appeals in Manhattan.

Cole said one of the first people he spoke with after the appeals court ruled was New York City mayoral candidate Andrew Cuomo, whose sister is married to Kenneth Cole.

"I was really hoping to work with Andrew on the mayoral campaign," Cole said, though he kept his distance from the former governor, a Democrat, before the appeals court tossed his conviction.

Cole described what the government had put him through and the pressure on his friends over the last 11 years as "really horrible." "I lost so many friends. It was kind of me also just pull-

ing back. I got divorced," he said. "Everyone was basically uncomfortable talking to me." But he said his world was already brightening, with 100 text messages sent his way, many from "people I haven't

# Investing in employee mental health benefits everyone

Mental health challenges can affect anyone, regardless of background or circumstance, and they are becoming more common across the United States.

In 2022, a national survey found that about 60 million American adults - approximately 23% of the US adult population - were living with a mental illness, defined as a diagnosable mental, emotional or behavioral disorder.

This translates to a nearly 37% increase over the past de-

These conditions can have a profound and lasting effect on patients' lives, including their ability to engage meaningfully and sustainably in the workforce.

Globally, depression and anxiety are estimated to lead to 12 billion lost working days annually, costing an estimated US\$1 trillion per year in lost productivity worldwide and \$47 billion in the United States.

I am a medical director and practicing psychiatrist. I work with graduate students, residents, faculty and staff on a health science campus, supporting their mental health - including when it intersects with challenges in the workplace.

I often meet with patients who feel unsure about how to approach conversations with their schools, programs or employers regarding their mental health, especially when it involves taking time off for care. This uncertainty can lead to delays in treatment, even when it's truly needed.

Anxiety and depression are the most common mental

health conditions in the US. Nineteen percent of American adults suffer from an anxiety disorder, and more than 15% have depression.

Meanwhile, about 11% of Americans experience other conditions such as post-traumatic stress disorder, commonly known as PTSD, bipolar disorder, borderline personality disorder or obsessive-compulsive disorder.

Rates of anxiety and depression increased worldwide during the COVID-19 pandemic. But one positive consequence of the pandemic is that talking about mental health has become more normalized and less stigmatized, including in the workplace.

For those with mental illness, the traditional expectation of maintaining a strict separation between personal and professional life is not only unrealistic, it may even be detrimental. The effect of mental illness on a person's work varies depending on the type, severity and duration of their

For instance, severe depression can affect basic self-care, making it difficult to complete tasks such as bathing, eating or even getting out of bed. Severe anxiety can also be profoundly debilitating and limit a person's ability to leave the house due to intense fear or panic. The symptoms of such severe mental illness may make it difficult even to show up

On the other hand, someone struggling with mild depression or anxiety may have a hard time initiating or completing tasks that they would typically manage with ease and find it difficult to interact with colleagues. Both depression and anxiety may affect sleep, which can contribute to cognitive lapses and increased fatigue during the work day.

Someone with PTSD may find that certain environments remind them of traumatic experiences, making it difficult to fully engage in their work. And a person experiencing a manic episode related to bipolar disorder might need to take time away from work entirely to focus on their stabilization and recovery.

Identifying a trusted colleague, supervisor or human resources representative can be an important first step in managing your mental health at work. While selecting the right person to confide in may be challenging, especially given the vulnerability associated with disclosing mental health concerns, doing so can open pathways to appropriate resources and tailored support services.

For instance, it might encourage an employer to consider offering access to free or low-cost mental health care if it's not already available, or to provide flexible scheduling that makes it easier for employees to get mental health treatment.

It's also important to be aware of changes in your mental health. The earlier you can recognize signs of decline, the sooner you can get the support that you need, which might prevent symptoms from worsening.

On the other hand, sharing sensitive information with someone who is not equipped to respond appropriately could lead to unintended consequences, such as workplace gossip, unmet expectations and increased frustration due to perceived lack of support. However, even if your supervisor or manager is not understanding, that doesn't change the fact that you have rights in the workplace.

The Americans with Disabilities Act provides critical protections for individuals with disabilities in the workplace. Under the act, it is unlawful for employers to discriminate against qualified individuals based on a disability.

The law also requires employers to provide reasonable accommodations so that people who qualify are able to participate fully in the workplace provided that they do not impose undue burden on the place of employment.

There are many reasonable accommodations for workers with mental illness. These can include protected time to attend mental health appointments and flexibility in work schedules and workplace.

For instance, if your job allows for it, working from home can be helpful. If your job requires being on site, a private work space is another reasonable accommodation. Someone with anxiety might find that working in a quiet, private space helps reduce distractions that trigger their symptoms, making it easier for them to stay focused and get things done.

Other possible accommodations include providing sick leave or flexible vacation time to use for mental health days or appointments, or allowing an employee to take breaks according to their individual needs rather than a fixed schedule. Employers can also provide support by offering equipment or technology such as white noise machines or dictation software.

An organization's commitment to supporting employee mental health can play a large role in shaping how well employees perform at work - and, ultimately, the organization's

Relying on individual employees to manage their mental health is not a sustainable long-term strategy for employers and may lead to significant workplace disruptions, such as more missed work days and lower productivity.

Studies show that when employers lead targeted initiatives promoting mental health, overall workplace functioning and resilience improve. These initiatives might include educating employees on mental health, providing accessible care, helping employees have better work-life balance and designing supportive workplace policies for those who are struggling. These steps help reduce stigma and signal to employees that it's safe to seek support. (AP)

The newly discovered antibiotic, called pre-methylenomycin C lactone, was found "hiding in plain sight" as an intermediate chemical in the natural process that produces the well-known antibiotic methylenomycin A, according to a Monash University press release on Tuesday

"Methylenomycin A was originally discovered 50 years ago and while it has been synthesized several times, no one appears to have tested the synthetic intermediates for antimicrobial activity," said study co-lead author Professor Greg Challis from Australia's Monash University and Britain's University of Warwick.

"By deleting biosynthetic genes, we discovered two previously unknown biosynthetic intermediates, both of which are much more potent antibiotics than methylenomycin A itself," said Challis who conducted the study

under the Monash Warwick Alliance Combatting Emerging Superbug Threats Initiative, established in 2012.

When tested for antimicrobial activity, one of the intermediates, pre-methylenomycin C lactone, was shown to be over 100 times more active against diverse Gram-positive bacteria than the original antibiotic methylenomycin A, according to the study published in the Journal of the American Chemical

Specifically, it was shown to be effective against S. aureus and E. faecium, the bacterial species behind MRSA and VRE, respectively, it said, adding this finding is especially promising for VRE, a World Health Organization (WHO) High Priority Pathogen.

"This discovery suggests a new paradigm for antibiotic discovery. By identifying and testing intermediates in the pathways to diverse natural compounds, we may find potent new antibiotics with more resilience to resistance that will aid us in the fight against AMR (antimicrobial resistance)," Challis said.

With its simple structure, potent

activity, difficult-to-resist profile, and scalable synthesis, pre-methylenomycin C lactone represents a promising new candidate that could potentially help save some of the 1.1 million people worldwide who are victims of AMR every year, researchers said.

vation will curb it, and it's instead time for a "strategic pivot" in the global climate fight: from focusing on limiting rising temperatures to fighting poverty and preventing disease. A doomsday outlook has led the climate community to focus too much on

near-term goals to reduce emissions of carbon dioxide and other greenhouse gases that cause warming, diverting resources from the most effective things that can be done to improve life in a warming world, Gates said. In a memo released Tuesday, Gates said the world's primary goal should instead be to prevent suffering, particularly for those in the toughest conditions in the world's poorest countries.

If given a choice between eradicating malaria and a tenth of a degree increase in warming, Gates told reporters, "I'll let the temperature go up 0.1 degree to get rid of malaria. People don't understand the suffering that ex-

The Microsoft co-founder spends most of his time now on the goals of the Gates Foundation, which has poured tens of billions of dollars into health care, education and development initiatives worldwide, including combating HIV/AIDS, tuberculosis and malaria. He started Breakthrough Energy in 2015 to speed up innovation

in clean energy.

He wrote his 17-page memo hoping to have an impact on next month's United Nations climate change conference in Brazil. He's urging world leaders to ask whether the little money designated for climate is being spent

on the right things. Gates, whose foundation provides

financial support for Associated Press coverage of health and development in Africa, is influential in the climate change conversation. He expects his "tough truths about climate" memo will be controversial.

"It's kind of this pragmatic view of somebody who's, you know, trying to maximize the money and the innovation that goes to help in these poor countries.'

Every bit of additional warming correlates to more extreme weather, risks species extinction and brings the world closer to crossing tipping points where changes

become irreversible, scientists say. University of Washington public health and climate scientist Kristie Ebi said she thoroughly agrees with Gates that the UN negotiations should focus on improving human health and well-

being. But, she said, Gates assumes the world stays static and only one variable changes - faster deployment of green technologies - to curb climate change. She called that unlikely.

Jeffrey Sachs, director of the Center for Sustainable Development at Columbia University, called the memo "pointless, vague, unhelpful and confusing.' "There is no reason to pit poverty re-

duction versus climate transformation. Both are utterly feasible, and readily so, if the Big Oil lobby is brought under control," he wrote in an email. Stanford University climate scien-

tist Chris Field said there is room for a healthy discussion about whether the current framing of the climate crisis is typically too pessimistic. "But we should also invest for both

the long term and the short term," he wrote in an email. "A vibrant longterm future depends on both tackling climate change and supporting human development. Princeton University climate sci-

entist Michael Oppenheimer said he doesn't dispute the principle of making human well-being the primary objective of policy, but what about the natural world? "Climate change is already wreak-

ing havoc there," he wrote in an email. "Can we truly live in a technological bubble? Do we want to?" Gates is clear in his memo that every

tenth of a degree of warming matters: "A stable climate makes it easier to improve people's lives.'

### **Drug may reverse autism-like behaviors**

# Common BP drug shows promise for autism

MANHASSET, N.Y., Oct 28, (AP): Scientists at Northwell Health's Feinstein Institutes for Medical Research have made a significant discovery in Autism Spectrum Disorder (ASD): a widely used blood pressure medication, captopril, can restore healthy function to the brain's immune cells and reverse ASD-like behaviors in a preclinical animal model. This invaluable research focuses on a specific type of ASD believed to be triggered by a mother's immune system during pregnancy and could better understand autism and autism-like symptoms.

Published this week in Molecular Psychiatry, these findings build on mother's antibodies, if they target a specific brain protein during fetal development, can lead to ASD-related symptoms, especially in male offspring. In those studies, researchers found that the brain's immune cells, called microglia, became overactive and unhealthy, disrupting crucial brain cell connections and affecting social behavior.

The study, led by Lior Brimberg, PhD, associate professor in the Institute of Molecular Medicine at the Feinstein Institutes, and Ben Spielman, an MD/ PhD candidate at the Donald & Barbara Zucker School of Medicine at Hofstra/ Northwell, found that when capto-

pril - known for its ability to cross the blood-brain barrier – was given in this preclinical model of ASD, it significantly calmed the active microglia and increased social interaction. "Understanding Autism Spectrum

Disorder is incredibly complex, but for some individuals, research has shown that the condition may stem from immune system activation during early fetal brain development," said Dr. Brimberg, who is also corresponding author of the paper. "Our new work shows that a commonly used drug for blood pressure, captopril, can help quite down these brain immune cells, offering a promising new path for targeted treatment."

# Atletico extends unbeaten La Liga run

Madrid confirms Carvajal's knee surgery

SEVILLE, Spain, Oct 28, (Agencies): Atletico Madrid extended its unbeaten La Liga run to nine games by beating Real Betis 2-0 on Monday.

The result took the capital club to fourth place and means Diego Simeone's men have not lost in the league since an opening day reverse at Espanyol.

It has 19 points, eight behind league leader Real Madrid.

Betis, which came into the game unbeaten in eight games in all competitions, was in sixth place.

Atletico was on top for much of the away game and went ahead in the third minute. A long throw ricocheted around the Betis box before falling to Giuliano Simeone at the

edge of the area, and he swivelled to rifle a half volley into the bottom

Atletico doubled the lead with a controversial second on the stroke of halftime.

The referee waived penalty claims after Jan Oblak punched clear a Betis free kick and Julian Alvarez broke down the left. His deep cross found Alex Baena, who cut inside from the left flank and hammered home a sec-

Betis was more creative after the introduction of second-half substitute Giovani Lo Celso but the Argentine could not find a way past a composed Oblak in the Atletico goal.

Meanwhile, Real Madrid defender Dani Carvajal has undergone arthroscopic surgery and is expected to be sidelined for a couple of months.

Vinicius Jr has apologized for his behavior after being substituted in the second half of his side's 2-1 win over FC Barcelona.

Real Madrid coach Xabi Alonso replaced Vinicius by Rodrygo, which enraged the winger. Vinicius walked off the pitch, shouting and making angry gestures, before storming down the players' tunnel, in actions that provoked almost as many headlines as the match result.

Vinicius later returned to the Real Madrid dugout and picked up a booking after being involved in the angry scenes between both sets of players at the final whistle as the Real Madrid players recriminated with Lamine Yamal for comments, he had made before the match implying that Real Madrid "robbed" games.

Vinicius' behavior has renewed speculation the club could try to sell him as contract talks reportedly stalled, but in an interview with Real Madrid TV, the Brazilian tried to make light of the incidents.

# Reyna plans to reboot career with new club

MOENCHENGLADBACH, Germany, Oct 28, (AP): Gio Reyna went into the 2022 World Cup as one of United States' brightest young soccer stars. Controversy over his training effort and a family conflict with the team's thencoach overshadowed his performances.

A World Cup on U.S. soil next year is a guiding light for the 22-year-old Reyna to revive a career dogged by injuries

Reyna says he'd now handle the 2022 incident differently "in certain ways' and his actions stemmed from frustration, but the dispute wasn't "completely" his fault or that of his family.

Speaking to The Associated Press at his new club Borussia Moenchengladbach last week, the attacking midfielder wants to use this season to convince U.S. coach Mauricio Pochettino he still belongs.

"I do obviously think about (the World Cup) pretty often as it's somewhere where I need and want to be," he said. "But I try to focus daily here, stay present here, work here every day, and hopefully believe everything will fall into place.'

In Qatar in 2022, Reyna played only twice off the bench. Then-U.S. coach Gregg Berhalter said after the tournament that an unnamed player, later identified as Reyna, was nearly sent home for a lack of effort in training.

Reyna's parents - Claudio and Danielle Reyna, both former national team players - lobbied the U.S. Soccer Federation for more playing time for Gio and contacted the USSF about a threedecades-old domestic violence allegation involving Berhalter and the woman who later became his wife - Danielle's former college roommate.

Asked if he'd do things differently if he had that chance again, Reyna told the AP: "Maybe in certain ways, but I'm not

just going to sort of sit here and take all the blame for something that was made out to be completely my fault, which I believe it wasn't, and also my family's,

"At the end of the day, I was just upset that, you know, I wasn't really playing. I was playing at Dortmund. I thought that I wanted to play at the World Cup and ultimately in the end, I didn't do that, and that's really what it stemmed from,' he said. "I guess the frustration and the disappointment was just wanting to play and help my country. It's so far removed now and so far in the past, I don't even really want to talk about it any more.'

After the Islamic Solidarity Games, Kuwait will compete in the 22nd Asian Men's Handball Championship, which serves as the qualifier for the 2027 World Cup in Germany, to be hosted in Kuwait from

January 15-26. The draw placed Kuwait in Group C alongside UAE, Hong Kong, and India.

# Hendrick, Gibbs set for epic NASCAR title battle

WASHINGTON, Oct 28, (AP): Jeff Gordon was in the thick of dissecting Hendrick Motorsports' prospects for the NASCAR championship when he was interrupted by a text message from his team's chief rival.

This wasn't any typical trash talk about the title.

Joe Gibbs Racing president Dave Alpern instead was contacting the Hendrick vice chairman to convey how privileged JGR felt in facing a longtime adversary.

"He just beat me to the punch; I would have done the same thing," Gordon said Sunday night at Martinsville Speedway, where Hendrick locked up the final two berths in the title round of NAS-CAR's premier series. "It just goes to show you the respect we have for one another. We're honored as well. I'm really proud to have the relationship that we have with Gibbs. Off the track, we say we're teammates, but on the track, we're fierce competitors.

For the second time in four years, the Championship 4 in the Cup Series is an even split between the two winningest playoff teams in NASCAR history. The best finisher of four drivers in the Nov. 2 season finale at Phoenix Raceway will claim the crown.

Hendrick will be represented by 2021 champion Kyle Larson and William Byron, who beat Ryan Blaney at Martinsville for the team's record-extending 62nd playoff victory.
Ranking second with 42 playoff

victories (including wins in five of the first nine playoff races this season), Gibbs has Denny Hamlin and Chase Briscoe.

It's the third time that Hendrick has owned half the title field, and the fourth time with at least two Championship 4 drivers for JGR, which had a record three in 2019 (winning the title with Kyle Busch).

The powerhouses have combined for 547 Cup wins in a friendly rivalry dating back more than three decades, when Joe Gibbs consulted Rick Hendrick about starting a NASCAR team after winning three Super Bowls as a Hall of Fame football coach.

"I didn't have anything," Gibbs said during a news conference Monday. "Everybody referred me to Rick. He helped us a lot and gave advice. It was a huge deal for us to be able to get off the ground. Rick played a huge role in that. I just really appreciate that."

### Ski training dangers spark Olympic debate VIENNA, Oct 28, (AP): When Mikaela Shiffrin started skiing

again weeks after her terrifying crash last year, the American star was even more alert to the potential dangers of training Shiffrin's injuries - puncture wound to her abdomen and se-

vere damage to her abdominal muscles - came in a World Cup giant slalom race but the two-time Olympic champion knew that training could be just as risky. If not more.

"When I came back from injury I was aware of the fencing on the side and a hole in the course and where the trees were, Shiffrin told The Associated Press in a recent interview.

"We are often training in conditions where the variables are just too many to control and you have to decide sometimes: Is this unreasonably dangerous or is this within a reasonable level of danger that we need to train, we need to practice, and this is the only way we can do it?"

French skier Alexis Pinturault had similar experiences. "We are training in many places where it's not really safe, yes, that's 100% sure," the 2021 men's overall World Cup

champion said. Ongoing safety discussions in Alpine skiing came into fresh

focus in September, less than five months before the Milan-Cortina Olympics, when World Cup racer Matteo Franzoso died following a crash in preseason training in Chile.

The 25-year-old Italian crashed through two layers of safety

fencing on a course at La Parva and slammed into a wooden fence positioned six to seven meters outside the course. He died two days later from cranial trauma and a consequent swelling of his brain.

Franzoso was the third young Italian skier to die in less than a year, and a talented French skier died following a training Shiffrin, a five-time overall champion and winner of a re-

cord 101 World Cup races, dealt with lingering post-traumatic stress disorder when she got back on skis again after her in-Nearly three months after her crash, she returned to racing

in late February

"Athletes and coaches and everybody are so used to saying that the sport carries an inherent risk that you start to become blind to some of the risks that are actually life-threatening,' Shiffrin said.

"This was a challenge for me, that I felt so scared of the risk for the rest of the season. If you think too much about it you become paralyzed. But it's really important that we can assess what those risks are and try to find ways to mitigate that as much as possible. It's not OK to say risk is part of the sport and you take it or leave it."

The issue with training courses is that, for financial reasons, they usually lack the same safety standards that apply to race

Smaller crews of course workers are on the hill to maintain the condition of the snow surface; fewer safety netting is placed along the course to break the fall when racers crash; and less medical staff and equipment, like helicopters for immediate transport to a hospital, are available.

Sofia Goggia, the 2018 Olympic downhill champion, called ski racing "an extreme sport. At a high level, it's like F1 or MotoGP in downhill, super-G, but also giant slalom, because the speed is 80-90 kph (50-56 mph), the risk is there every time."

# **Hungarian teen Marton wins second world taekwondo title**

WUXI, China, Oct 28, (Xinhua): Hungary's 19-year-old Luana Marton captured her second world title at the World Taekwondo Championships on Tuesday, defeating Brazil's Milena Titoneli 2-0 in the women's 67kg final.

Marton took the opening round 8-1 with an aggressive attacking display. In the second round, she used her close-range advantage to maintain control and held her lead to the end, sealing a 2-0 victory and the gold medal.

Two years ago, Marton claimed her first world title in the women's 57kg at the Baku World Championships, becoming the first Hungarian woman to win a senior world championship gold in taekwondo.

This time she competed alongside her twin sister, Viviana Marton, an Olympic champion, who will take part in the women's 62kg

"My feeling is crazy. I don't know if this is real or not. It feels like a dream. I worked so hard for this moment, and I think it's magical," said Marton after the match.

"It was really tough. My opponent was very strong and professional. I just tried to stay focused and keep my rhythm. I told myself I wanted to be perfect, not just good, and that made the difference," she added.

Nigeria's Elizabeth Oluchi Anyanacho and Spain's Lena Moreno Reyes shared the bronze medals.

China's Song Jie faced Marton in the quarterfinals but lost 2-1, missing out on a semifinal berth. "Overall, I was in good form," said Song. "In the first round, I followed the coach's tactical plan, but in

the next two rounds, I focused too much on one point and failed to adjust in time. Compared with my first world championships, I felt more relaxed this time." In the men's 68kg final, Thailand's world No. 1 Banlung Tubtimdang defeated South Korea's Seong Yu-hyeon 2-0. Tubtimdang had previously won bronze in the men's 63kg event at the 2023 Baku World Championships. "I'm really happy. Last year I trained very hard, and now I finally achieved something. It feels incredible,"

he said. The United States' Maikol Rodriguez and Croatia's Matija Crep shared the bronze

The championships will continue on Wednesday with the men's 58kg and women's 62kg categories.

# Markkanen scores career-high 51 as Jazz outlasts Suns

SALT LAKE CITY, Oct 28, (AP): Lauri Markkanen scored a career-high 51 points, the first Jazz player to reach 50 in the regular season since Karl Malone in 1998, and Utah beat the Phoenix Suns 138-134 in overtime on Monday night.

Markkanen helped the Jazz recover after they blew a seven-point lead in the final 19 seconds of regulation, scoring seven points in the extra period. He also finished with 14 rebounds.

Markkanen made all 17 free throws and topped his previous best of 49 points set on Jan. 5, 2023. It was the most by a Utah player in the regular season since Malone had 56 against Golden State on April 7, 1998.

Keyonte George had 26 points and 10 assists, while Walker Kessler had 25 points, 11 rebounds and four blocks for the Jazz.

Celtics 122, Pelicans 90 In New Orleans, Anfernee Simons made six 3-pointers and scored 25 points, and the Boston Celtics earned their first victory over the season by pulling away to beat the New Orleans Pelicans.

### PSG made nearly \$1 billion in club-record revenue last season

PARIS, Oct 28, (AP): Champions League winner Paris Saint-Germain generated club-record revenue of 837 million euros (\$976 million) last season.

The figures released by the club on Tuesday include 175 million euros in matchday revenue and 367 million euros in commercial revenue, with six new partners joining the club.

The figures encompass the men's and women's soccer teams as well as handball and judo teams. By comparison, revenue for the 2023-24 season was 806 million euros, which was the third highest in Euro-

PSG's men's team won the domestic double and clinched the Champions League for the first time by routing Inter Milan 5-0 in the final, giving the club's Qatari investor QSI the trophy it craved after taking over the club in June 2011.

The club was valued by Forbes at \$4.6 billion in May, placing it seventh among the world's most valuable soccer teams. Real Madrid led with \$6.75 billion, followed by Manchester United (\$6.6 billion) and Spanish champion Barcelona (\$5.65 billion).

However, low television revenue in Ligue 1 and the Parc des Princes stadium's 48,000-capacity - considerably smaller than other leading clubs in Europe were hampering further financial growth for PSG.

The Parc des Princes was owned by Paris City Hall and Paris Mayor Anne Hidalgo does not want to sell

the stadium to the club, which hoped to buy it and expand it rather than go elsewhere.

"Our door is always open to expanding the Parc des Princes, which is owned by the City of Paris," Hidalgo told Le Parisien newspaper in June. "Not to sell, but to expand."

Plans for a new and bigger stadium away from Parc des Princes with a minimum capacity of 60,000 were still being considered in Passy or Massy, both on the outskirts of the city.

A decision on the new stadium was expected to be taken in autumn of next year.

Rawal ruled out of Cup semis: India's hopes of winning a first Women's Cricket World Cup title have been dented with the injury-enforced withdrawal of opening batter Pratika Rawal for the semifinal against defending champion

The in-form Rawal was forced off the field after injuring her ankle attempting to save a boundary in India's last league-stage game on Sunday, which ended in a washout against Bangladesh. "Tough to sit out due to injury, but my heart is with the team," Rawal said in a social media post. "Best of luck, India!"

She scored 308 runs in the league stage of the tournament - including a century in a decisive win over New Zealand - second only to teammate Smriti

The International Cricket Council approved Shafali Verma as a late replacement in the squad for Rawal. India placed fourth in the league stage, which included a high-scoring loss to Australia. (AP)
