To the Cabinet ... investors seek incentives, not obstacles

A LARGE segment of citizens is asking the Cabinet these questions - Does the government truly intend to encourage investment in Kuwait? Are the current measures intended to support this goal, or to intimidate investors instead?

This concern arises as banks have stopped approving loans for institutions and companies unless they submit a property description certificate in accordance with government require-

As a result, many projects and companies are stalled. While the requirement for this certificate seems unnecessary today, it is a legacy of fifty or sixty years ago, with the law unchanged.

While it is true that the Cabinet suspended the requirement for a property description certificate, it did not notify the banks to facilitate matters for their clients. As a result, some mortgage transactions, which previously helped encourage investment and ease the burden on business owners, have come to a halt.

Al-Omar explained that the initiative is in line with the directives of the political leadership to build an integrated digital ecosystem that enhances the efficiency of state institutions and supports sustainable development driven by innovation and knowledge. Equipping

Kuwaiti talent with advanced technical skills is now an important pillar for establishing Kuwait's position as a leading nation in the digital economy.

He urged government entities to take full advantage of this initiative, describing it as a significant step toward nurturing talent and developing professional capabili-

Al-Omar affirmed the ministry's commitment to supporting all efforts that help build a capable generation ready to lead the digital transformation and shape Kuwait's technological future.

Meanwhile, Microsoft Middle East Regional Director Charles Nahas explained that the initiative aims to train more than 30,000 employees, 4,000 technical experts, and 350 leaders, in addition to empowering over 100,000 users with artificial intelligence and cloud computing tools through the Center of Excellence at Co-Pilot

'China ready to enhance cooperation with Kuwait'

KUWAIT CITY, Nov 3, (Xinhua): China attaches great importance to China-Kuwait relations and stands ready to promote bilateral practical cooperation in various fields, said visiting Chinese Vice President Han Zheng.

During his stay in the Gulf state from Saturday to Sunday, Han met separately with Kuwaiti Amir Sheikh Meshal Al-Ahmad Al-Jaber Al-Sabah, Crown Prince Sheikh Sabah Al-Khaled Al-Sabah, and Prime Minister Sheikh Ahmad Al-Abdullah Al-Sabah.

When meeting with the Kuwaiti Amir, Han conveyed cordial greetings and best wishes from Chinese President Xi Jinping.

Han said that China always cherishes its friendship with Kuwait and attaches great importance to developing their relations.

Since 2022, President Xi and the Kuwaiti Amir have met twice and reached a series of important consensuses, providing strategic guidance for the development of China-Kuwait relations to higher levels, Han added.

He said that the fourth plenary session of the 20th Communist Party of China Central Committee has sent a clear signal that China is further advancing comprehensive reforms and expanding high-level opening up, which will create opportunities for the development of China-Kuwait relations.

China is ready to work with Kuwait to deepen political mutual trust, implement the bilateral cooperation documents signed in the presence of the two heads of state, and strive for substantive progress at an early date, so as to achieve in-depth and solid development of the China-Kuwait strategic partnership, Han said.

Han said the Global Governance Initiative proposed by President Xi has charted the course for reforming and improving the global governance system.

KFF contains massive Amghara factory blaze

KUWAIT CITY, Nov 3: Flames and thick plumes of smoke

rose into the sky over Amghara after a massive fire broke out inside a factory containing highly flammable materials such as aluminum, fiberglass and lithium batteries.

Seven firefighting teams controlled the blaze in record time, preventing it from spreading to neighboring buildings, and no injuries were reported.

Firefighters dealt with the flames courageously and efficiently, averting a disaster that would have engulfed the factory and surrounding areas. Director of Public Relations and Media at Kuwait Fire Force (KFF) Brigadier General Mohammad Al-Gharib confirmed to the newspaper that the firefighting teams controlled the fire within a short period.

KUWAIT CITY, Nov 3: The Ministry of Commerce and Industry issued Ministerial Decision No. 182/2025, prohibiting cash transactions for companies engaged in certain commercial activities, reports Al-Seyassah daily. Article 1 of the decision requires all institutions and companies under its supervision, operating in the gold, precious stones, precious metals, and related sectors, to refrain from conducting any cash transactions.

Minister issues orders on new car insurance policy

KUWAIT CITY, Nov 3: First Deputy Prime Minister and Minister of Interior Sheikh Fahad Al-Yousef issued Ministerial Decision No. 2116/2025 regarding the insurance policy for civil liability arising from traffic accidents, known as "Compulsory Insurance for Kuwaiti Vehicles", reports Al-Seyassah daily.

Article 1 stipulates that the standard insurance policy, as detailed in Appendix 1 of the decision, shall remain in effect until further notice. Article 2 states that the insurance

policy rates, as outlined in Appendix 2 of the decision, shall also remain in effect until further notice. Article 3 stipulates that the Insur-

ance Regulatory Unit shall establish an approved list of insurance companies qualified to issue the civil liability insurance policy for traffic accidents (compulsory vehicle insurance) and shall define the

sions or circulars.



conditions for inclusion on this list. The Insurance Regulatory Unit shall also regulate the

procedures for issuing this insurance policy Article 4 stipulates that the Insurance Regulatory Unit shall oversee the implementation of this decision and ensure compliance by all parties subject to it. The unit has the authority to receive and adjudicate complaints and to take all legal measures in accordance with the law on its establishment, executive regulations, and any related deci-

Article 5 states that the General Traffic Department shall refrain from issuing or renewing vehicle licenses, as stipulated in the Traffic Law, its amendments, and the relevant ministerial decrees, if the mandatory insurance policy for Kuwaiti vehicles has been issued in violation of this decision.

Article 6 clarifies that all insurance policies and their addenda issued prior to the implementation of this decision shall remain valid, with all associated rights, obligations, and guarantees.

Why and where did they migrate?

The first major wave of Arab and Muslim immigra-L tion to the United States occurred between 1870 and 1924. Most migrants were from Lebanon, with a smaller number from Syria, both then part of the Ottoman Empire. The majority were Maronite, Greek Orthodox, and

Catholic Christians. Muslims made up no more than ten percent of these early immigrants. The main reasons for migration were the search for job opportunities, as well as to avoid conscription into the Ottoman army, particularly for Christians and Shiites. Migration became a mass phenomenon in the early twentieth century but stopped in 1924 when restrictive U.S. immigration laws were enacted.

These Lebanese immigrants

settled mainly in New York, Boston, Detroit, and other Midwestern states. Most were young, unmarried men with limited education, taking on jobs in agriculture and a variety of other professions. Although Muslims have been present in America

since the 17th century, their numbers were small. Most Arab immigrants, aside from Lebanese and Syrians, were from Yemen and Iraq, particularly between 1900 and 1930, and worked in factories and on railroads in states like Michigan and California. Some settled in agricultural areas in the Midwest. Their presence in places like Fresno, California, was notably large, as I observed during a visit in the 1970s. Iraqi immigration increased further after World War II, especially during the 1950s and 1960s, driven by political events and economic changes in Iraq.

The first mosque in the United States was built in 1934 in Cedar Rapids, Iowa, by Syrian and Lebanese immigrants. Prior to 1915, Albanian Muslims had established a mosque in Maine, which was essentially a private home.

The majority of Shiite immigrants from southern Lebanon, who had suffered under successive rulers including the Ottomans, the French, the British, and local feudal lords, chose to migrate extensively to Africa and, to a lesser extent, to South America, particularly Brazil, Argentina, and Venezuela.

Their migration was driven by economic, political, social, and religious factors. Many opted for Africa during the French mandate period, encouraged by the French to work in their extensive colonies there. Civil society organizations also played a role in facilitating the migration of large numbers of these communities.

Due to the atmosphere of freedom in the West, many Lebanese immigrants there became highly creative. Some of the most notable among them emerged as pioneers of the modern Arab literary renaissance, excelling in poetry, novels, philosophy, and art, and leaving a lasting impact on modern Arabic literature. Among the most prominent is Gibran Khalil Gibran (1883-1931), the poet, writer, and painter, best known for his book "The Prophet," which remains one of the most famous

works in both the East and the West. There is also Amin al-Rihani (1876-1940), the traveler, thinker, writer, and philosopher. Rihani is considered one of the first advocates of dialogue between East and West and authored works in both Arabic and English. He is renowned for his writings on freedom and reform, as well as his travels throughout the Arabian Peninsula.

The poet Mikhail Naimy (1889-1988), a critic, writer, and philosopher, and contemporary of the great poet Elia Abu Madi (1889–1957), is regarded as one of the

most important poets of the Arab diaspora. Fawzi al-Maalouf (1899-1930) emigrated to Brazil, and his brother Shafiq al-Maalouf (1905-1976) was a poet and journalist. Elias Farhat (1893-1976), a selftaught poet, also emigrated to Brazil, among many oth-

The majority of these creative figures were Maronites, due to the church's early emphasis on compulsory education in their villages several centuries ago.

KRCS, ICRC ink \$2m Sudan healthcare deal

KUWAIT CITY, Nov 3, (KUNA): The Kuwait Red Crescent Society (KRCS) signed on Sunday a USD 2 million grant agreement with the International Committee of the Red Cross (ICRC) to help sustain the implementation of a program aimed at improving access to healthcare services for vulnerable communities in Sudan.

The signing ceremony took place at the Ministry of Foreign Affairs in the presence of Deputy Foreign Minister Sheikh Jarrah Jaber Al-Ahmad Al-Sabah. The agreement was signed by KRCS Chairman Khaled Al-Maqamis and ICRC President Mirjana Spoljaric Egger.

Following the signing, Al-Maqamis told KUNA that the grant reflects Kuwait's ongoing humanitarian approach and continued support for people in need, and explained that the agreement seeks to enhance the capacity of Sudan's healthcare system, and improve access to essential medical services for vulnerable populations.

He emphasized the KRCS' commitment to implementing sustainable projects that alleviate the suffering of those affected by crises, noting that the humanitarian situation in Sudan requires collective efforts to support healthcare and

Al-Maqamis added that KRCS has intensified its humanitarian efforts toward Sudan in recent months by sending multiple relief planes carrying food supplies, tents, and essential materials to assist displaced persons and families impacted by the ongoing humanitarian crisis.

He affirmed that KRCS continuously strives to promote the positive image of Kuwait's humanitarian and relief role

worldwide, stressing that support for Sudan aligns with the directives of Kuwait's political leadership and its constant dedication to humanitarian work.

It will also localize data storage and processing, improve performance, increase security, and provide greater control without relying on external parties.

"At the same time, it helps to enhance national capabilities through continuous training programs, equipping government employees and national talent to work in a more productive environment. It calls for university graduates to receive training in data management, cybersecurity, and artificial intelligence to support this transformation and create numerous technology-driven job opportunities.

"Overall, these efforts contribute to economic development and income diversification by fostering innovation and encouraging individual initiatives.

"Undoubtedly, this ambitious project requires substantial effort from government entities through legislative reforms, data governance, and the development of human resources in modern technologies. It will also stimulate entrepreneurship and support the management of institutional change, both culturally and operationally, in both

"Digital transformation has become essential not only for government service institutions but also for the private sector. It plays a major role in improving service performance, enhancing services, and making daily life easier for people. Today, a nation's progress is measured more by its digital capabilities than by traditional resources, despite their continued importance. The world has now entered the Fifth Industrial Revolution (Industry 5.0) based on technologies that support all aspects of production.

"This unprecedented transformation is not limited to the technologies of the Fourth Industrial Revolution, such as the Internet of Things and robotics. It reintegrates humanity into the production process by providing tools that enhance sustainability and flexibility in solving complex problems, integrating human insight with digital innovation. This approach strengthens individual capabilities to serve society and achieve greater well-being, emphasizing that such progress is only possible through educated and empowered individuals.

Through this ambitious initiative, Kuwait is reinforcing its developmental role in the region while preparing its citizens with the skills and capabilities needed to drive advancement in the future.

Also:

"The current generation has grown up in a world of technology, received education from prestigious institutions, and avoided many of the hardships faced by their predecessors. This is why they are different even in their approach to everything, and why their perspective often contrasts with the beliefs and societal norms shaped by past experiences. Some young people see these traditional concepts as less relevant, believing that focusing on more important matters is the priority today," columnist Eng. Adel Al-Kharafi wrote for Al-Seyassah daily

"There is a great deal of energy and enthusiasm driving young people, a greater capacity for innovation, and they are not afraid of experimentation or making mistakes. This is why young people are heavily involved in volunteer activities and entrepreneurship, as they possess the flexibility and quickness to learn and adopt new ideas

"This conviction took shape in my mind while preparing to travel to Oman. While waiting at the airport, I overheard a group of young Kuwaitis on a fishing trip. They were talking enthusiastically about fishing, fishing gear, and sports, all while impeccably dressed and interacting with the elderly with remarkable confidence. They never grew tired of explaining things.

"Despite their energy and curiosity, we must nurture their experiences to serve the future, understand their perspectives, and address their concerns. Nations are built on the will of their youth, not on their geographical size. When citizens are free to act without unnecessary restrictions, they can achieve remarkable things. Conversely, when citizens are preoccupied with trivial matters, society begins to crumble.

"The human mind is a vessel, and every vessel reflects what it contains. When a nation invests in quality education, it builds its future. The choice is clear - either build for the future or remain stuck in the past. Wealth and family ties alone cannot serve as a foundation. Wealth becomes a burden if it is not managed to benefit future generations.

'The young people I spoke with displayed the highest levels of culture and courtesy. Perhaps Kuwait, despite its small size and population, is stronger than many larger countries. Military power alone is not the foundation of strength, but freedom of thought is. For instance, Ukraine is smaller than Russia, both in size and population, yet Russia has not been able to defeat it, because freedom of thought empowers its people. Our youth have immense potential... they simply need opportunities to express their ideas. Is that really so difficult?

"In a world filled with existential questions and the search for meaning, certain phenomena exploit humanity's spiritual and intellectual needs. One of the most concerning of these is what has been termed "energy science," a misleading concept that carries serious risks," Kuwaiti writer Saud Bader Al-Azmi wrote for Al-Seyassah daily.

"A Japanese proverb says, "If you believe everything you read, stop reading."This reminds us of the importance of critical thinking and careful scrutiny of the information we encounter

"A recent incident highlighted the dangers of such beliefs. According to posts on social media, a Tunisian flight attendant deeply involved in so-called energy science and spirituality was in Egypt when she claimed to have received a divine revelation instructing her to ascend to heaven with her daughter. Tragically, she strangled her four-year-old daughter to death. Before she could take her own life by stabbing herself, she was saved at the last moment by her husband.

"What is "pseudo-energy science"? I am alarmed when I see people placing their trust in what is referred to as "energy science," or more accurately, "pseudo-energy science."

"It is called pseudo-science because it lacks any real scientific basis, unlike empirical science, which relies on the scientific method.

"Proponents of this practice describe energy science as a collection of unconventional rituals and techniques, claiming they can manipulate living bodies and infuse them with spiritual energy.

"The recent spread of this phenomenon can be attrib-

uted to several factors, including rising frustration and a growing sense of defeatism among young people in the face of economic and social challenges, as well as spiritual and intellectual emptiness and the human need for spiritual guidance in the absence of proper direction.

"What is particularly alarming is that some practitioners of so-called energy science claim that individuals can forego medical treatment.

"Among the dangers of this "pseudoscience" are its links to atheism, the distortion of Islamic beliefs through conceptual confusion, the promotion of dependency and a lack of motivation through false promises of change without effort, and the undermining of the scientific method by spreading unproven ideas without a clear scientific methodology.

"Researchers at Lund University in Sweden have found that people who believe in pseudoscience tend to be more narcissistic and score lower on IQ tests than others. This phenomenon calls for intellectual vigilance, critical thinking, and a return to sound scientific methods and correct beliefs to better understand our lives and the universe around us."

Decree abolishes Traffic Court

Memorandum introduces reforms, streamlines procedures

KUWAIT CITY, Nov 3: Decree Law No. 155/2025 was issued, repealing Law No. 22/1960 concerning the organization of the Traffic Court. The decree will come into effect three months after its publication in the official gazette "Kuwait al-Youm", on February 2, 2026, reports Al-Seyassah daily.

The explanatory memorandum accompanying the decree cites four reasons for repealing the Traffic Court. They are:

1. Article 7 of the Judicial Organization Law No. 23/1990 allows for the formation of specialized circuits within the Court of First In-

Article 8 of the same law grants the Minister of Justice the authority to establish criminal circuits by decree, subject to the approval of the General Assembly of the Court of First Instance, to hear specific types of cases and define their territorial jurisdiction.

Therefore, establishing specialized criminal circuits for traffic cases meets the need previously addressed by Articles 1 and 2 of the Traffic Court Organization Law, which dealt with creating a specialized court for traffic cases. This redundancy does not abolish the concept of a specialized judiciary for handling such

2. The provisions of Articles 148 and 149 of the Code of Criminal Procedure and Trials regarding penal orders can be applied to traffic misdemeanor cases. This eliminates the need for separate regulations for penal orders in the Traffic Court Law as well as the rationale for distinguishing traffic misdemeanors from other misdemeanors in terms of conditions, rules, and provisions. Traffic misdemeanors, like other misdemeanors, should be governed under a single legal framework, namely the Code of Criminal Procedure and Trials, which provides a concise method for adjudicating simple

3. The procedures outlined in Articles 6, 7, and 8 of the Traffic Court Law, relating to the issuance of judgments and appeals, are essentially applications of the rules and provisions of the Code of Criminal Procedure and Trials. The remaining procedures are specific to traffic misdemeanors. Therefore, repealing these articles and applying the Code ensures uniform procedures for all misdemeanor cases.

4. Article 9 of the Traffic Court Organization Law is no longer necessary, as it provides for reconciliation in certain traffic offenses in accordance with Article 41 of Decree-Law No. 67/1976 concerning traffic, which already permits accepting reconciliation from the accused in some traffic cases.

Bedoun caught with 50 kilograms drugs

KUWAIT CITY, Nov 3: A Bedoun resident has been arrested in Fahaheel in possession of approximately 50 kilograms of hashish ready for distribution, reports Al-Seyassah daily.

According to a press release issued by the Ministry of Interior, the Criminal Enforcement Department of the General Department for Sentences Enforcement, in coordination with the Drug Control General Department (DCGD) carried out the operation, after receiving confidential intelligence that the suspect was trafficking narcotics and storing large quantities for distribution within Kuwait.

During the investigation, the suspect admitted to receiving the drugs for KD 3,000 on behalf of a fugitive Kuwaiti citizen with a criminal record, who is wanted abroad in connection with multiple cases of drug trafficking and distribution.

The suspect and the seized narcotics have been referred to the concerned authorities for legal action. The Ministry of Interior affirmed its ongoing efforts to combat drugs and prevent attempts to pro-

mote or distribute them.

Kuwaiti duo held fishing in restricted area of sea

KUWAIT CITY, Nov 3: Two Kuwaiti citizens were arrested after a pursuit by Coast Guard patrols for engaging in illegal fishing in a restricted area, reports Al- Jarida daily.

These citizens were found to be in violation of the regulations of the Environment Public Authority (EPA), and legal measures have been initiated against them.

Expedite car repairs, provide replacement vehicle

KUWAIT CITY, Nov 3: Director of the Commercial Control and Consumer Protection Department at the Ministry of Commerce and Industry Faisal Al-Ansari revealed that an extensive meeting was held Sunday at the headquarters of the department, bringing together ministry officials and representatives of the Car Dealers Association.

Al-Ansari informed the newspaper that the meeting tackled key observations on how some car dealers deal with consumers and ways to enhance compliance with regulations governing sales contracts, warranties and technical services. He said the meeting is in line with the commitment of the ministry to protect consumer rights and regulate the relationship between consumers and car dealers in order to ascertain the accurate application of warranty terms and improve the quality of after-sales services.

He disclosed that the agenda of the meeting includes the delay of some dealers in repairing vehicles covered by warranty, as well as putting emphasis on the need to adhere to the specified repair timeframe and the failure to provide a replacement vehicle during the repair period, which violates the terms of the approved warranty. He stressed the need for dealers to provide replacements to consumers

Other issues include delays in the supply of spare parts, especially for Chinese vehicles. The ministry will require dealers to provide precise delivery dates and keep consumers informed. The difficulty in obtaining service appointments will also be addressed, along with exploring mechanisms to regulate and facilitate online booking.

The meeting also touched on other issues, such as the refusal of some dealers to accept imported vehicles, hence, the idea of obligating dealers to service all vehicles of the same brand and the termination of warranties upon transfer of vehicle ownership despite adherence to regular mainte-

The ministry is keen on addressing these issues, in addition to the need to guarantee consumer rights, lack of cooperation on the part of the legal representatives of some agencies in attending scheduled meetings, the need to emphasize adherence to official deadlines, and agencies failing to provide consumers with technical reports after maintenance or inspection, so the ministry will require agencies to submit clear and documented reports detailing the vehicle's condition and the procedures performed.



Amiri Decrees approve PAI, KPA final accounts

Agencies post solid surpluses

KUWAIT CITY, Nov 3: Two Amiri decrees were issued approving the final accounts of the Public Authority for Industry (PAI) and Kuwait Ports

Authority (KPA) for fiscal

2024/2025.

Decree No. 152/2025, published Sunday in the official gazette, 'Kuwait Al-Youm', states that the revenues of PAI amounted to KD154.4 million, compared to KD53.6 million in expenditures, resulting in a financial surplus of KD100.8 million, which was transferred to the reserve for existing projects based on Article 38 of Industry Law No. 56/1996.

Decree No. 153/2025 approved the final account of KPA, which recorded revenues of KD93 million against expenditures of KD46.8 million, achieving a net profit of KD64 million. The decree affirmed that KD36.9 million of the net profit was transferred to the State treasury, while KD9.2 million was retained in the allocations of the Authority.

In another development, PAI closed four industrial plots in Na'ayem for violating applicable regulations and laws by constructing buildings and auto repair shops without

The Authority granted the violators a one-month grace period to rectify their situations and warned of harsher penalties if the violations are not addressed within the specified timeframe

Sources revealed that the ministry intends to engage with the relevant authorities to tender the project through the Public-Private Partnership (PPP) model, mirroring the approach adopted for North Zour and Khairan power plants, as well as the Shagaya Re-

Cabinet, say reliable sources from the Ministry

newable Energy Project. Sources added the ongoing tender for the Nuwaiseeb Power Plant consultant at the Central Agency for Public Tenders (CAPT) will be reviewed. Sources explained that the most appropriate course of action -- cancel the tender or obtain the approval of KAPP to continue the tendering process upon completion of all the necessary legal procedures.

Sources confirmed that all electricity and water production projects are now tendered and awarded through PPP, except the 900-megawatt Subiya Power Plant (Phase Four) and Doha Reverse Osmosis Desalination Plant which has a production capacity of 60 million gallons per day.

Sources indicated that the ministry is prioritizing the rapid completion of these two projects over partnership projects, which are expected to take longer. Sources stressed that this expedited implementation is crucial in meeting the growing demand for electricity and water in the coming years, before the partnership projects become operational.

Meanwhile, CAPT approved the ministry's request to finalize the study on the lowest bid for the Doha desalination plant tender.

Sources added the Zakat House Board of Directors, in coordination with KIA, will issue a detailed operating system, outlining the mechanisms, pro-

Sources indicated that the decree aims to enhance the efficiency of investing the funds of Zakat House and to develop them in a safe and sustainable manner in line with the strategic directions of the State toward supporting responsible investment and ensuring that financial returns are utilized in an efficient and transparent manner to realize the social and humanitarian objectives of the institution.

The decree was published in the official gazette, 'Kuwait Al-Youm,' on Sunday.

Article One of the decree stipulates the addition of a clause to Article Four of the law, mandating the formation of a committee to develop and invest the funds of the financial and real estate investment portfolios of Zakat House. This committee shall be solely responsible for preparing investment strategies and policies for the funds of these portfolios, and for monitoring the implementation and practice of investment operations in all related fields, in accordance with the laws regulating this matter and in compliance with the provisions and principles of the Islamic Sharia. The Zakat House Board of Directors shall form this committee with KIA representatives as members, based on the nomination and approval of its Board of Directors. The Board, in coordination with the Authority, shall issue a decision regarding the committee's operating procedures, including its operational mechanisms and all other provisions necessary for fulfilling its responsibilities.

Article Two of the decree obligates the ministers, each within their respective jurisdiction, to implement the decree-law from the date of its publication in the offi-

To the Cabinet ...

This is why I have repeatedly warned that this certificate represents a major obstacle. For instance, if a citizen wants to sell a property, requesting a property description certificate is understandable. But why should companies or institutions that have been operating at full capacity for 40 or 50 years be required to obtain this certificate every time they submit an application to any government agency?

What purpose does it serve? It might as well be called a "disability certificate."

Ironically, a citizen installed a sunshade in front of his house on his own property. Municipal employees arrived and ordered him to remove it. He explained that his neighbor had installed a similar sunshade. The employees replied that his neighbor had a license and a property description certificate. The citizen agreed and said he would obtain the necessary license and certificate. At that point, the employees told him, "You must demolish the sunshade first and then apply for a license."

Another obstacle, more serious and complex than the first, is the decision to halt the issuance of commercial licenses for industrial, service, and agricultural plots, as well as the prohibition on selling usufruct rights, among other restrictions. This decision has negatively affected local markets. Does it truly encourage local investment, or has it simply added more burdens for citizens?

Another puzzling obstacle is that every business owner with a license in industrial zones must also rent a shop in the capital city, even if their entire operation runs from company headquarters in Shuwaikh Industrial Area, Subhan, or other locations. What purpose does forcing them to rent such a shop serve?

Do these procedures make life easier for people? Has the committee tasked with amending laws not yet addressed regulations that have been in place for decades, despite the world having changed greatly? Today, countries compete to attract investment by all means and avoid procedures that hinder business and economic activity.

Based on the above mentioned points, when an investor encounters 20 obstacles, each taking several months to resolve, they are likely to abandon their investment and escape this vicious cycle.

Alternative solutions must be explored, beyond the requirement for a property description certificate and restrictions on selling usufruct rights, as well as other measures that hinder commercial and industrial activity, in order to revitalize local markets.

Economic reports indicate a slowdown in buying and selling activities, accompanied by a decline in the Relative Strength Index.

I urge the Minister of Finance, the Minister of State for Municipal Affairs, the Minister of Commerce and Industry, and the Cabinet to take all necessary measures to facilitate investments in ways that encourage local economic activity, support the ongoing development process, help Kuwait reclaim its leading position, and strengthen its de-

velopmental role in the region. In the end, an important question to ask is - How many Kuwaiti companies have relocated to neighboring countries because they found facilities that allowed them to operate actively? Investors seek incentives, not obstacles.

'Kuwait Skills'

Federal judge again bars White House from deploying troops to Portland

PORTLAND, Ore., Nov 3, (AP): A federal judge in Oregon on Sunday barred President Donald Trump's administration from deploying the National Guard to Portland, Oregon until at least Friday, saying she "found no credible evidence" that protests in the city grew out of control before the president federalized the troops earlier this fall.

The city and state sued in September to block the deployment.

It's the latest development in weeks of legal back-and-forth in Portland, Chicago and other US cities as the Trump administration has moved to federalize and deploy the National Guard in city streets to quell protests.

The ruling from US District Court Judge Karin Immergut, a Trump appointee, followed a three-day trial in which both sides argued over whether protests at the city's U.S. Immigration and Customs Enforcement building met the conditions for using the military domestically under federal law.

In a 16-page filing late Sunday, Immergut said she would issue a fi-

nal order on Friday due to the voluminous evidence presented at trial,

including more than 750 exhibits.

The purpose of the deployment, according to the Trump administration, is to protect federal personnel and property where protests are occurring or likely to occur. Legal experts said that a higher appellate

court order that remains in effect would have barred troops from being deployed anyway.

Immergut wrote that most violence appeared to be between protesters and counter-protesters and found no evidence of "significant damage" to the immigration facility at the center of the protests.

Trump's testing plans for US nuke weapons won't include explosions: energy secretary

WEST PALM BEACH, Fla., Nov 3, (AP): New tests of the US nuclear weapons system ordered up by US President Donald Trump will not include nuclear explosions, Energy Secretary Chris Wright said Sunday.

It was the first clarity from the Trump administration since the president took to social media last week to say he had "instructed the Department of War to start testing our Nuclear Weapons on an equal basis."

"I think the tests we're talking about right now are system tests," Wright said in an interview on Fox News' "Sunday Briefing." "These are not nuclear explosions. These are what we call noncritical explosions."

Wright, whose agency is responsible for testing, added that the planned testing involves "all the other parts of a nuclear weapon to make sure they deliver the appropriate geometry and they set up the nuclear explosion."

The confusion over Trump's intention started minutes before he held a critical meeting in South Korea with Chinese President Xi Jinping. Trump took to his Truth Social platform and appeared to suggest he was preparing to discard a decades-old US prohibi-

Later that day, as he made his way back to Washington, Trump was coy on whether he really meant to say he was ordering the resumption of explosive testing of nuclear weapons - something only North Korea has undertaken this century - or calling for the testing of US systems that could deliver a nuclear weapon, which is far more routine.

Millions of people could lose food aid benefits

Govt shutdown could become longest ever as Trump says he 'won't be extorted' by Dems

WASHINGTON, Nov 3, (AP): The government shutdown is poised to become the longest ever this week as the impasse between Democrats and Republicans has dragged into a new month. Millions of people could lose food aid benefits, health care subsidies are set to expire and there are few real talks between the parties over how to end it

President Donald Trump said in an interview aired on Sunday that he "won't be extorted" by Democrats who are demanding negotiations to extend the Affordable Care Act subsidies that expire at the end of the year for millions of Americans. Echoing congressional Republicans, the president said on CBS's "60 Minutes" that he will only negotiate when the government is reopened.

Trump's comments signal that the shutdown could continue to drag on for some time as federal workers, including air traffic controllers, are set to miss additional paychecks and there is uncertainty over whether 42 million Americans who receive federal

food aid will be able to access the assistance. Senate Democrats have now voted 13 times against reopening the government, insisting that they need Trump and Republicans to negotiate with them first.

The president said that Democrats "have lost their way" and predicted that they will eventually capitulate to Republicans

Republicans.
"I think they have to," Trump said.
"And if they don't vote, it's their prob-

He also reiterated his pleas to Republican leaders to change Senate rules and scrap the filibuster. Senate Republicans have repeatedly rejected that idea since Trump's first term, arguing that the rule requiring 60 votes to overcome any objections in the Senate is vital to the institution and has allowed them to stop Democratic policies when they are in the minority.

"Republicans have to get tougher," Trump said in the CBS interview. "If we end the filibuster, we can do exactly what we want."

With the two parties at a standstill,

the shutdown, now in its 33rd day and approaching its sixth week, appears likely to become the longest in history. The previous record was set in 2019,

when Trump demanded that Congress give him money for a US-Mexico bor-

Trump's push on the filibuster could

prove a distraction for Senate Majority Leader John Thune, R-S.D., and Republican senators who have opted instead to stay the course as the consequences of the shutdown have become more acute.

Republicans are hoping that at least some Democrats will eventually give them the votes they need as moderates have been in weekslong talks with rank-and-file Republicans about potential compromises that could guarantee votes on health care in exchange for reopening the government. Republicans need five additional Democrats to pass their bill.

"We need five with a backbone to

say we care more about the lives of the American people than about gaining some political leverage," Thune said on the Senate floor as the Senate left Washington for the weekend on Thursday.

Virginia Sen. Tim Kaine, a Democrat, said on ABC's "This Week" on Sunday that there is a group of people talking about "a path to fix the health care debacle" and a commitment from

workers. But it's still unclear if those talks could produce a meaningful compromise.

Trump said in the "60 Minutes" interview that the Affordable Care Actoften known as Obamacare because it was signed and championed by former President Barack Obama - is "terrible" and that if the Democrats vote to reopen the government, "we will work on fixing the bad health care that we have right now."

Democrats feel differently, arguing that the marketplaces set up by the ACA are working as record numbers of Americans have signed up for the coverage. But they want to extend subsidies first enacted during the CO-VID-19 pandemic so that premiums won't go up for millions of people on Jan. 1.

"We want to sit down with Thune, with (House Speaker Mike) Johnson, with Trump, and negotiate a way to address this horrible health care crisis," Senate Democratic leader Chuck Schumer said last week.

Police separate opponents, loyalists of Vucic as tensions soar

Hundreds of riot police Sunday separated opponents and loyalists of Serbia's autocratic President Aleksandar Vucic in central Belgrade as political tensions boiled after a year of persistent anti-government protests.

Several thousand people faced off on both sides of the police cordons with officers in full gear standing in several rows between the shouting crowds who threw bottles, flares and stun grenades.

Tensions in Belgrade soared a day after tens of thousands of people joined a huge rally in the northern city of Novi Sad that marked the first anniversary of a train station disaster there which killed 16 people, and triggered a youth-led movement demanding political changes, which has challenged Vucic's firm

grip on power.

Anti-government protesters in Belgrade gathered in support of Dijana Hrka, the mother of Stefan Hrka, one of the Novi Sad station tragedy victims. Hrka earlier on Sunday said she was launching a hunger strike near a tent camp outside the parliament building which has been occupied by Vucic's loyalists since March. (AP)

Drone flights near air base could be part of spying op: Belgium defense minister

BRUSSELS, Nov 3, (AP): Belgium's defense minister expressed concern on Monday about a series of unidentified drone flights over the weekend near a military base where U.S. nuclear weapons are stored, saying that they seem to be part of a spying operation.

Defense Minister Theo Francken confirmed that drones had flown into the area near the Kleine Brogel air base in northeast Belgium in two phases on Saturday and Sunday night.

The first phase involved "small drones to test the radio frequencies" of Belgian security services, then later came "big drones to destabilize the area and people," Francken told public broadcaster RTBF.

"It resembles a spy operation. By whom, I don't know. I have a few ideas but I'm going to be careful" about speculating, he said. Last month, several drones were spotted above another Belgian military base near the German border. The operators were not identified.

Russia has been blamed for a number of airspace violations, notably in Estonia and Poland, in recent months. But the perpetrators of a series of mysterious drone flights in Denmark and Germany have been harder to pin down.

A late evening drone sighting at Berlin's Brandenburg airport on Friday suspended flights for nearly two hours. It was not clear who was responsible.

Francken ruled out that the weekend

drone flights in Belgium might have been a prank.

He said that the security services' "jammer didn't work because they tested our radio frequency, and they changed frequency. They have their own frequencies. An amateur doesn't know how to do that."

Asked why it wasn't possible to shoot the drones down, Francken said: "When they're over a military base we can shoot the drones down. When it's

nearby, we have to be very careful because they can fall on a house, a car, a person. That's completely different."

This can pose legal challenges too.
"It's not entirely clear. We have to clarify the legal grounds," he said.
Francken lamented that Belgium

Francken lamented that Belgium "is chasing after the threat" posed by such drone flights. "We should have bought air defense systems five or 10 years ago," that can deal with drones, he said

Top prosecutor stands trial

Spanish regional leader steps down

MADRID, Nov 3, (AP): The leader of Spain's Valencia region said Monday he was stepping down over his government's handling of the devastating flash floods that killed 229 people last year and whose response he is widely seen as having bungled.

Carlos Mazón has faced regular calls to resign since the Oct 29, 2024 floods, including last week at a state memorial ceremony held on the first anniversary of the disaster where family members of victims jeered and insulted him before the event began. "I know I made mistakes. I acknowledge them, and I will live with them for the rest of my life. I have apologized, and I apologize again today, but none of them were due to political calculation or bad faith," Mazón told reporters on Monday in Valencia announcing his resignation.

Mazón has been slammed by citizens and political rivals for his administration's slow response to the emergency, mainly for issuing a flood alert to people's cell phones hours after rushing waters were overflowing banks, sweeping away cars and destroying homes.

MADRID: Spain's Attorney General Álvaro García Ortiz went on trial Monday over allegations of leaking confidential information in an unprecedented and politically explosive case that looms large over Prime Minister Pedro Sanchez's left-wing government.

It's the first time in Spain's modern history that a top prosecutor faces a criminal trial. It's one of several cases that have implicated people close to Sánchez.

Ukraine receives more Patriot air defense systems to counter deadly Russian attacks

KYIV, Ukraine, Nov 3, (AP): Ukraine has received more American-made Patriot air defense systems to help it counter Russia's daily barrages, President Volodymyr Zelenskyy said, as Russian drones killed a man and injured five of his family members, including two children, in the latest nighttime attack.

Russia's relentless pounding of urban

Russia's relentless pounding of urban areas behind the front line following its full-scale invasion of Ukraine nearly four years ago has killed thousands of civilians. It has also targeted the energy supply to deny civilians heat and running water in winter, as well as disrupt industrial production of Ukraine's newly developed drones and missiles.

The sophisticated Patriot systems are the most effective weapon against Russian missiles. Zelenskyy has pleaded with Western partners to provide more of them, but production limitations and the need to maintain stockpiles have slowed their delivery.

"More Patriots are now in Ukraine and being put into operation," Zelenskyy said on social media late Sunday. "Of course, more systems are needed to protect key infrastructure sites and our cities across the entire territory of our state."

He thanked Germany and its Chancellor Friedrich Merz for the Patriots. Germany said three months ago it would deliver two more Patriot air defense systems to Ukraine. It agreed

to the move after securing assurances that the US will prioritize the delivery of new Patriots to Germany to backfill its stocks. Patriot systems are made only in the US.

5.8-magnitude quake hits Negros

Tens of thousands of people evacuate to safety as typhoon approaches Philippines

MANILA, Philippines, Nov 3, (Agencies): Philippine officials ordered tens of thousands of people to evacuate to safer grounds and prohibited fishermen from venturing out to sea in an east-central region Monday as a typhoon approached from the Pacific. Authorities warned of torrential rains and potentially deadly storm surges of up to 3 meters (nearly 10 feet).

Typhoon Kalmaegi was last spotted about 235 kilometers (146 miles) east of the town of Guiuan in Eastern Samar province, with sustained winds of up to 120 kilometers (74 miles) per hour and gusts of up to 150 kph (93 mph), and was forecast to slam into shore later Monday.

It was expected to blow westward overnight and on Tuesday and batter central island provinces, including Cebu, which is still recovering from a 6.9-magnitude earthquake that hit on Sept 30 and left at least 79 dead and displaced thousands of people after their houses collapsed or were severely damaged.

Kalmaegi, locally named Tino, was forecast to further strengthen over the Philippine Sea before making landfall in Guiuan town or nearby municipalities, where Eastern Samar Gov RV Evardone said he has issued mandatory evacuation orders starting Monday with the help of army troops, police, firefighters and disastermitigation contingents.

More than 70,000 people in the coastal towns of Guiuan, Mercedes and Salcedo were ordered to move to evacuation centers or concrete houses and buildings certified as sturdy enough to withstand the impact of the typhoon. The coastal areas were warned of tidal surges of up to 3 meters (nearly 10 feet) high, Evardone said.

Typhoon Haiyan, one of the most powerful tropical cyclones on record, slammed ashore into Guiuan in November 2013 then raked across the central Philippines, leaving more than 7,300 people dead or missing, flattening entire villages and sweeping scores of ships inland. Haiyan demolished about a million houses and displaced more than 4 million people in one of the country's poorest regions.

"Nobody's complaining among the residents because of their experience with Yolanda. They know it's better to be safe than sorry," Evardone told The Associated Press, referring to Haiyan's Philippine name. "They then saw bodies scattered everywhere on streets. Many lost everything.'

Thousands of villagers were also being evacuated from island provinces near Eastern Samar ,officials said, and disaster-response agencies, including the coast guard, have been put on alert.

The Philippines is battered by about 20 typhoons and storms each year. It is often hit by earthquakes and has more than a dozen active volcanoes, making it one of the world's most disaster-prone countries.

BEIJING: An earthquake with a magnitude of 5.8 jolted Negros, Philippines at 19:06 GMT on Sunday, the GFZ German Research Centre for Geosciences said. The epicenter, with a depth of 10.0 km, was initially determined to be at 9.66 degrees north latitude and 122.64 degrees east longitude.

MANILA: South Korean conglomerate DL Group's subsidiary, DL E&C, has been partnering with the Philippines' largest private-sector electric distribution utility company, Meralco, to pursue small modular reactor (SMR) projects in the Philippines, the Philippine Presidential Communications Office (PCO) said Sunday. A feasibility study was launched in August for a 320-megawatt SMR in the near

term, said the PCO in a news release. SMRs are compact nuclear plants that can safely produce clean, stable energy

using less land and shorter construction periods than traditional facilities. On Saturday, Philippine President Ferdinand Romualdez Marcos met with top officials of DL Group in Busan, South Korea, on the sidelines of the 32nd APEC Economic Leaders' Meeting to discuss the company's energy prospects and other ventures in the Philippines.

DL Group, with core businesses in construction, petrochemicals, and energy, was founded in 1939.

Hegseth visits DMZ ahead of security talks with South Korean officials

US Defense Secretary Pete Hegseth visited the Demilitarized Zone (DMZ) separating the two Koreas on Monday as he began a two-day visit to ally South Korea for security talks.

Hegseth and South Korean Defense Minister Ahn Gyu-back received a briefing from military officials at Observation Post Ouellette, a site near the military demarcation line that past US presidents, including Donald Trump during his first term in 2019, had visited to peer across the border into North Korea and meet with American

Hegseth and Ahn also visited the Panmunjom border village, where an armistice was signed to pause the 1950-53 Korean War. Ahn's ministry said the visit "reaffirmed the firm combined defense posture and close coordination" between the allies.

Hegseth did not mention North Korea, which has ignored Washington and Seoul's calls for dialogue in recent years while accelerating the expansion of its nuclear weapons and missile pro-

South Korea's military also said Monday that the country's Joint Chiefs of Staff Chairman Gen. Jin Yong-sung and his U.S. counterpart, Gen. Dan Caine, oversaw a combined formation flight aboard South Korean and US F-16 fighter jets above a major U.S.

Bus-truck collision kills 20 in India

A truck loaded with concrete stone chips rammed into a passenger bus in southern India early Monday, killing at least 20 people and injuring about two dozen others, local authorities said.

The state-run transport bus was carrying around 70 passengers en route to the city of Hyderabad in southern Telangana state when a

truck coming from the opposite di-rection collided with it near the town of Chevella, local district official K. Chandrakala told The Associated

The front of the bus was badly mangled, trapping several passengers inside. Heaps of stone chips or gravel were seen dumped inside the bus, burying alive at least one

passenger who was later counted among the dead.

The rescue teams struggled to cut through the bus to retrieve the

Rajendra Prasad, superintendent at Chevella hospital said 20 bodies were moved to the mortuary and will be handed over to their families after identification. (AP)

Powerful earthquake kills at least 20 and injures hundreds in northern Afghanistan

KABUL, Alghanistan, Nov 3, (AP): A powerful, 6.3 magnitude earthquake shook northern Afghanistan before dawn Monday, killing at least 20 people and injuring more than 640 others, a health official said, adding that the numbers could increase.

The U.S. Geological Survey said the quake's epicenter was located 22 kilometers (14 miles) west-southwest of the town of Khulm, and that it struck at 12:59 a.m. at a depth of 28 kilometers (17 miles).

Sharafat Zaman, a spokesperson for the Ministry of Public Health, said 534 injured people and 20 bodies had been brought to hospitals in Balkh and Samangan provinces. Rescuers were on the scene and the figures were changing, he added.

In the nearby province of Badakhshan, the quake partially or completely destroyed 800 houses in one village in the Shahr-e-Bozorg district, said Ihsanullah Kamgar, spokesperson for the provincial police headquarters. But with a lack of internet in the remote area, there were still no accurate casualty figures, he added.

Yousaf Hammad, a spokesman for Afghanistan's disaster management

agency, said most of the injured suffered minor wounds and were discharged after treatment.

In the Afghan capital of Kabul, the Ministry of Defense announced that rescue and emergency teams had reached the quake areas in Balkh and Samangan, which suffered the most damage, were transporting the injured and assisting others.

The Taliban government's chief spokesman, Zabihullah Mujahid, posted on X that the earthquake caused casualties and financial loss. He said government organizations were working to get needed help.

DR Congo president says peace talks with M23 rebels to resume in Doha

KINSHASA, Nov 3, (Xinhua): Peace talks between the government of the Democratic Republic of the Congo (DRC) and the March 23 Movement (M23) rebel group will resume next week in Doha, Qatar, DRC President Felix Tshisekedi has said.

According to the statement issued late Sunday by the Congolese presidency, Tshisekedi reaffirmed that the DRC remains committed to political and diplomatic means to end the conflict in the eastern provinces, while upholding the country's sovereignty and territorial integrity.

Doha has remained the only operational channel of dialogue between Kinshasa and the M23 for months In July, Kinshasa and the M23 signed a Declaration of Principles in Doha, a roadmap that initially set a start date for negotiations no later than Aug. 8 and the signing of a peace agreement before Aug 18. These timelines have now passed without being met.

Tshisekedi, who arrived on Sunday in Doha to participate in the Second World Summit for Social Development scheduled for Nov. 4-6, also praised the involvement of Qatari Emir Sheikh Tamim bin Hamad Al Thani in the ongoing

exchanges with the M23. The statement did not specify whether the president would take part directly in the upcoming talks with the rebels.

After re-emerging in late 2021, the M23, now part of the politicalmilitary Alliance Fleuve Congo (AFC), has extended its control over several strategic centers in eastern DRC, including Goma and Bukavu. In these areas, parallel administrative structures have been established, further weakening local institutions and worsening an already dire humanitarian situation.

According to the United Nations, more than 2.4 million people have been displaced since January 2025, bringing the tally of internally displaced persons to nearly 6 million.

Tanzania President Hassan sworn in after election sparks deadly protests

DODOMA, Tanzania, Nov 3, (AP): Tanzania's President Samia Suluhu Hassan was sworn in Monday at a ceremony limited to invited guests, following a disputed election that sparked deadly protests after two main opposition candi-

dates were barred from running. The ceremony was held on government-owned grounds in the administrative capital of Dodoma, a departure from the past, when president took the oath at packed football stadiums that were open to the public.

Tension remained high in the commercial capital, Dar es Salaam, following three days of election protests. Gas stations and grocery shops were closed with streets were nearly empty as government employees continued to work from home. In Dodoma, most people

The Oct 29 election was marred by violence as demonstrators took to the streets of major cities to protest the poll and stop the counting of votes. The military was deployed to help police quell riots. Internet connectivity has been on and off in the East African nation, dis-

rupting travel and other activities. The protests spread across Tanzania, and the government postponed the reopening of universities, which had been set for Nov. 3. Tanzanian authorities

have not said how many people were killed or injured in the violence.

A spokesman for the U.N. human rights office, Seif Magango, on Friday told a U.N. briefing in Geneva by video from Kenya that there were credible reports of 10 deaths in Dar es Salaam and Shinyanga and Morogoro towns. The election results were rejected by the main opposition party, Chadema.

"These results have no basis in reality, as the truth is that no genuine election took place in Tanzania," the party's statement read in part.

The attacker was killed at the scene, Federal Security Secretary Omar García Harfuch told journalists Sunday. The attack on the mayor was carried out by an unidentified man who shot him seven times, García Harfuch said. The weapon was linked to two armed clashes between rival criminal groups operating in the region,

"No line of investigation is being ruled out to clarify this cowardly act that took the life of the mayor," García Harfuch said. (AP)

to the International Energy Agency (IEA), global energy demand rose by 2.2% last year, outpacing the average annual increase of 1.3% recorded over the last decade. At the same time, the global population is projected to reach 9.8 billion by 2050, with over 750 million people still lacking access to electricity, and more than 2.1 billion people remain without access to clean cooking. These figures underscore both the scale of the challenge and the opportunity before us.

In this context, ADIPEC 2025 is being held under the theme of 'Energy. Intelligence. Impact'. It reflects a simple but powerful truth: meeting the world's growing need for secure, affordable and sustainable energy will depend on how intelligently we harness every resource to deliver meaningful results for economies and communities alike.

At its core, the theme recognises that intelligence both human and artificial – is transforming the way energy is produced, managed, and consumed. From AI-driven optimisation and digital integration to advances in hydrogen, LNG, and decarbonisation, intelligent innovation is reshaping the global energy landscape. ADIPEC serves as the meeting point for these forces, where ideas translate into action and impact can be measured in investment, policy, and progress.

Kuwait's equity markets continue to advance amid favorable economic developments: Markaz report

KUWAIT CITY, Nov 3: Kuwait Financial Centre "Markaz" released its Monthly Market Review report for October 2025. Kuwait equity market was positive in October 2025 amid favorable economic developments and an optimistic outlook on capital spending. Kuwait All Share Index continues to be the top-performing GCC market on YTD basis with a gain of 22.7%, supported by a 2.7% rise in October. Among sectors, oil and gas, and financial services were the top gainers, rising by 11.0% and 10.8% respectively. The banking sector index gained by 0.7% for the month. Among banking stocks, Commercial Bank of Kuwait was the top gainer, increasing by 11.4% during the month. The bank has announced 15.3% y/y increase in net profit for Q3 2025. The bank has also disclosed execution of off-market trades on about 4.8 million shares, at price of KD 0.6 per share, in October 2025. Among Premier Market stocks, GFH Financial Group and National Investments Co were the top gainers, rising 27.7% and 25.5% respectively during the month. GFH Financial Group received approval from Central Bank of Bahrain to repurchase treasury shares upto a maximum of 10% of its total issued shares and commenced to do so towards the end of the month. Central Bank of Kuwait (CBK) has main-

tained its discount rate at 3.75%, despite the U.S Fed's rate cut of 25 bps in October 2025. Kuwait's real GDP grew by 1.7% y/y in Q2 2025, supported by expansion in both oil and non-oil sectors. Following the passage of public debt law in April 2025, Kuwait issued bonds worth USD 11.25 billion in October 2025. The issuance was 2.5 times oversubscribed with the order book peaking at USD 28 billion. Kuwait has discovered new offshore natural gas field named Jazza that is estimated to hold about 1 trillion cubic feet of gas and over 120 million barrels of condensate crude. A new Amiri decree has been issued allowing listed companies with non-Kuwaiti shareholders, real estate funds, and investment portfolios to own property, provided the companies are listed on bourses, trade in property, and exclude private residential land. Capital expenditure on development projects in Kuwait has increased by 2.4 times on annual basis to KD 132 million in Q1 of FY2025-26. The bond issuance and increase in capital expenditure in Q1 2025 offer cause for optimism over further improvement in government capital spending.

All GCC equity indices, except Qatar, ended the month on a positive note with S&P GCC composite index registering a gain of 1.5%. The de-escalation of geopolitical tensions, a good start to the 9M earnings season and interest rate reductions in the U.S supported investor senti-



ment. Saudi Arabia's equity index registered a monthly gain of 1.3% supported by the positive performance of major blue-chip stocks. ACWA Power increased by 12.9% during the month following reports that the company has boosted its project portfolio to USD 115 billion with 110 projects across countries. Saudi Aramco has gained by 5.2% during the month in anticipation of positive earnings results for Q3 2025, which are likely to be announced on November 4th, 2025. Abu Dhabi's equity index increased by 0.9% in October 2025 supported by major bluechip stocks. First Abu Dhabi Bank gained11.5% after recording a 24% rise in net profit for 9M 2025. Dubai equity index increased by 3.8% during the month, supported by real estate stocks and few banking blue-chips. Emaar Properties rose 8.8% during the month amid launch of AED 100 billion masterplan with 40,000 luxury homes in Dubai and the company chairman's remarks that the company plans to enter the U.S. markets in the future. Emirates NBD rose by 15.6% as the bank's net profits grew by 12% y/y in 9M 2025. The bank entered into a definitive agreement to secure a majority stake in India's RBL Bank for USD 3 billion. Qatar equity index declined by 0.9% amid mixed corporate earnings releases.

UAE's real GDP is expected to expand by 4.8% in 2025, with growth accelerating to 5.0% in 2026, supported by service sectors such as tourism, financial services, and real estate, according to the IMF's Regional Economic Outlook - October 2025. Saudi Arabia's mortgage portfolio surpassed USD 240 billion in YTD-October 2025, owing to accelerating real estate transformation amid Vision 2030 initiatives.

Global markets were positive during the month

despite the U.S government shutdown, supported y the easing of trade tensions between U.S and China, and a rate cut amid softer-than-expected September inflation data. MSCI World and S&P 500 rose by 1.9% and 2.3% respectively during the month. Headline inflation in U.S. increased to 3.0% y/y in September 2025 from 2.9% y/y in August but was below the Bloomberg consensus estimate of 3.1%. Following the meeting between the U.S and Chinese Presidents, the U.S has agreed to lower tariffs on Chinese imports to 47%, from 57%, and China has agreed to pause export controls on rare earths. The countries have also agreed to work on issues around TikTok. Nasdaq Composite index rose 4.7% during the month buoyed by ongoing enthusiasm for companies with AI exposure. The U.S federal government offices shut down on October 1, 2025, because Congress failed to pass the necessary appropriations legislation to fund the government for FY 2026. Non-essential government operations were halted or reduced while essential services like Medicare continue. The shutdown has delayed reports on key economic data, including monthly jobs and inflation reports, which are watched by the Fed officials. MSCI EM index gained 4.1% during the month, with the Indian stock market gaining 4.6% . The U.S-China trade negotiations and the strength in tech stocks despite persistent deflationary pressures supported

Chinese stock markets. The yield on the 10-year US treasury notes declined by 5 bps during the month to 4.11%. While the U.S government shutdown and expectation of rate cut by U.S Fed in its October meeting contributed to the fall in the treasury yields for most part of the month, U.S Fed Chair's hawkish outlook on further rate cuts in the Fed meeting led to some pick up in yields towards the end of the month. In line with expectations, U.S Fed lowered rates by 25 bps in October 2025. While acknowledging the weakness in labor market, the Fed Chair also highlighted the risk in making further decisions on policy rate changes, given the absence of data due to government shutdown.

Oil (Brent) prices closed the month at USD 65.07 per barrel, declining by 2.9% during the month. The continued unwinding of OPEC+ oil production cuts and easing of geopolitical tensions in the Middle East weighed on oil prices. IEA expects the oil market to be oversupplied with a surplus of 4 million bpd. U.S. President Donald Trump's decision to impose Ukrainerelated sanctions on Russia targeting major oil companies Lukoi and Rosneft, which raised supply concerns and lent some support to oil prices during the month.

Delay in publication of U.S economic data owing to the federal government shutdown and difference of opinion among U.S Fed policy makers have increased uncertainty around further rate cut in December 2025. This could lead to higher volatility in markets. Resumption in U.S government operations, corporate earnings, especially M7, and directions on interest rate trajectory from Fed officials could drive market sentiment in the next month. The GCC market movements might hinge on corporate earnings and pace of OPEC+ oil production increase.

National Investments Company (NIC), one of Kuwait's leading investment firms, announced strong financial results for the first nine months of 2025, posting a net profit of KWD 20.7 million or 26 fils per share, compared to KWD 10.2 million and 12.8 fils per share for the same period in 2024. The results represent a 103% increase in net profit, reflecting exceptional financial growth and continued operational strength.

Khaled Waleed Al Falah, Chairman of the Board at National Investments Company (NIC), said the company's performance underscores the success of its operational strategy and its ability to deliver strong results despite economic challenges. He added that NIC remains firmly on track toward achieving sustainable growth and expanding its market presence.

NIC continues to advance its longterm strategy and ambitious 2025 objectives through disciplined asset management, strategic diversification, and a flexible approach to evolving market conditions. These efforts have driven steady improvements across key financial indicators.

By the end of the first nine months of 2025, total assets grew by 21% to reach KWD 344.4 million, compared to KWD 283.6 million at the end of 2024. Shareholders' equity (parent company) increased by 17% to KWD 231.0 million, compared to KWD 197.4 million at the end of 2024. Other comprehensive income recorded growth during the first nine months of the current year, reaching

KWD 30.4 million, an increase of 68% compared to KWD 18.1 million in the corresponding period of the previous year. This increase contributed to a 79% rise in the balance of accumulated changes in fair value, which grew from KWD 38.2 million as of December 31, 2024, to KWD 68.6 million by the end of the first nine months of 2025. The company's revenues amounted to KWD 35.2 million, marking a 60% increase compared to KWD 22.1 million in the same period of the previous year, along with a growth in total assets under management (AUM) to KWD 1.238 billion, up 15% compared to KWD 1.077 billion at the end of 2024. These results further reinforce NIC's position as one of Kuwait's and the region's leading investment companies, driven by strong governance, effective strategic execution, and a continued commitment to delivering sustainable value for shareholders and clients.

Strong Financial Performance

Khaled Waleed Al Falah affirmed that the company continues to strengthen its positive trajectory by achieving sustainable financial and operational results, driven by a balanced strategy focused on diversifying products and services while expanding its presence in local and regional markets. This approach has enabled NIC to maintain its leadership throughout the first nine months of 2025, supported by quality assets, prudent investments, and strong risk management capabilities. These factors have resulted in solid returns and robust performance indicators, reflecting the company's disciplined execution and steady progress toward its strategic objectives.

Al Falah also emphasized NIC's commitment to the highest standards of corporate governance and to fostering a culture of innovation and creativity across its organization. This, he noted, has enhanced operational efficiency and strengthened the company's readiness for future growth by enabling higher productivity and profitability while maintaining a balance between targeted profitability and measured expansion. As part of its forward-looking strategy, NIC continues to pursue new investment opportunities through an integrated and forward-thinking approach designed to deliver sustainable, diversified returns across multiple sectors. reinforcing its position as one of the

region's leading investment entities. Clear Strategic Vision

Al Falah noted that the company's Strategy Sector made remarkable progress in the third quarter of 2025 in implementing NIC's transformation plan, developed in partnership with a global management consulting firm. The first phase of the three-stage roadmap achieved a 76% completion rate, coinciding with the launch of the second phase, which includes assigning responsibilities across departments. By the end of Q3 2025, approximately 81% of second- phase initiatives had been completed.

The first phase recorded strong advancement in several key areas, including enhancing strategic partnerships and mergers, optimizing the operating model, and expanding distribution channels. Efforts also continued to develop new products and services aligned with NIC's long-term goals. Building on this momentum, the second phase is progressing steadily, with a focus on deepening operational efficiency, broadening offerings, and strengthening strategic collaborations to support growth and innovation.

Al Falah added that the third quarter saw major milestones in NIC's growth journey, most notably the successful expansion of its office at the Dubai International Financial Centre (DIFC). following receipt of a financial services license from the Dubai Financial Services Authority (DFSA) on October 7, 2025. This step further enhances NIC's regional presence and opens wider strategic horizons.

Simultaneously, the company launched the second phase of its transformation strategy, supported by the achievements of the Project Management Office (PMO) within the Strategy Sector during the first phase. The sector remains committed to leading NIC's transformation journey with discipline, flexibility, and integration across all organizational levels.

In closing, Al Falah expressed appreciation to the Board of Directors for its continuous support and visionary leadership, which have been pivotal in strengthening the company's position and sustaining its success. He also acknowledged shareholders' confidence in re-electing the Board for the 2025 - 2027 term and commended the professionalism of the executive management team and the dedication of NIC employees, who remain key contributors to the company's ongoing achievements and long-term vision.

Outstanding Achievements

Fahad Abdulrahman AlMukhaizim, Board Member and Chief Executive Officer of NIC, stated that the company concluded the first nine months of 2025 with strong results reflecting its sustainable growth trajectory. AlMukhaizim explained that NIC continues to prioritize evolving client needs through integrated investment solutions powered by advanced digital technologies, strengthening its competitiveness and reinforcing market leadership. This solid performance came despite ongoing global challenges, including persistent trade tensions, international market volatility, and regional geopolitical and military developments. The Al Wataniya Investment Fund achieved a return of 5.8% during the third quarter of 2025, compared to a 2.9% return recorded by the benchmark index for the same period.

NIC's financial instruments team also achieved notable progress in expanding the market-making program, adding one new listed company during the quarter, bringing the total to 12 companies by the end of Q3 2025. This aligns with NIC's strategy to enhance financial market services, increase liquidity, and strengthen trading efficiency, supporting market stability and investment appeal. The company remains a key strategic partner in the ongoing development of Kuwait's capital markets.

Strong Operational Performance

AlMukhaizim commended the Financial Advisory Division for its significant progress in executing several major strategic transactions with key partners. The team is currently advising on three major capital market deals valued at approximately USD 1.5 billion, all expected to conclude this year. Given the scale and importance of these deals, the division has adopted a focused approach targeting high-impact strategic opportunities where NIC can deliver exceptional value and measurable results. The division also recently advised firms in the investment and banking sectors and assisted a Kuwaiti shareholding company in evaluating its regional real estate portfolio. It is currently marketing select sale opportunities to a targeted group of

Looking ahead, the Financial Advisory Division is managing a robust pipeline of future transactions and preparing several new deals. This increased activity is driven by Kuwait's improving economic environment, rising investor confidence, and ongoing regulatory initiatives that are accelerating the development of capital markets and corporate restructuring efforts in the region. AlMukhaizim added that the Alternative Investments Division achieved notable progress during the third quarter of this year across several key initiatives. The NIC Real Estate Credit Fund I, with a capital of USD 37 million, secured significant contributions from several strategic investors, reflecting strong investor confidence and sustained demand for real estate credit opportunities. The division continues to maintain a strong portfolio of credit investments supported by favorable market conditions and solid performance of existing projects.

NIC further expanded its strategic partnerships through a new collaboration with Forman Capital, enhancing access to high-quality real estate credit opportunities. At the same time, the company is developing venture capital investment opportunities tailored for NIC clients, aligning with its strategy to diversify income streams and strengthen its investment portfolio.

Regarding the company's portfolio, the management continues to implement its strategy for divesting from previous investments. The company successfully completed one divestment during the third quarter of the current year and received preliminary offers for the sale of additional assets.

AlMukhaizim revealed that National

Investments Company achieved accelerated growth, underscoring its strong ability to enhance the wealth of its investors and clients while solidifying its position as one of the leading players in the financial sector both locally and regionally. Abu Dhabi hosts oil summit as OPEC+ halts production hikes planned for first quarter of 2026

ABU DHABI, Nov 3, (AP): Abu Dhabi opened a major oil summit Monday with officials offering bullish optimism that power demands for artificial intelligence and global aviation will boost energy prices, just hours after OPEC+ paused production increases planned for next year.

The comments at the annual Abu Dhabi International Petroleum Exhibition and Conference in the Emirati capital highlighted the contradictions in the market and in the United Arab Emirates, a major oil producer that hosted the United Nations COP28 climate talks in 2023.

Sultan al-Jaber, the head of the state-run Abu Dhabi National Oil Co. who led COP28, described the energy market as needing "reinforcement, not replacement." U.S. Interior Secretary Doug Burgum applauded al-Jaber's remarks and criticized what he described as "a set of policies that have been driven by an ideology around climate extremism.'

"The demand for power is going to go up and up and up," Burgum said. "Today's the day to announce that there is no energy transition. There is only energy addition.

On Sunday, OPEC+ met and decided to increase its production by an additional 137,000 barrels of oil beginning in December. However, it said other adjustments planned in January, February and March of next year would be paused "due to seasonality." OPEC+ includes the core members of the cartel, as well as nations outside of the group led by Russia.

Benchmark Brent crude sold Monday around \$65 a barrel, down from a post-

COVID high of some \$115 a barrel after Russia's full-scale invasion of Ukraine in 2022. It had fallen to \$60 a barrel in recent days over concerns that the market had too much production.

"Yes, OPEC+ is blinking, but it's a calculated move," said Jorge León, the head of geopolitical analysis at Rystad Energy. "Sanctions on Russian producers have injected a new layer of uncertainty into supply forecasts, and the group knows that overproducing now could backfire later. By pausing, OPEC+ is protecting prices, projecting unity and buying time to see how sanctions play out on Russian

Suhail al-Mazerouei, the Emirates' energy and infrastructure minister, however, dismissed any idea long-term of too much oil being in the market.

Kuwait's economy shows clear recovery signs where economic activity turned positive in Q1 2025, expanding 1.0% year-on-year. Full-year 2025 real GDP is projected to grow 2.6% supported by stronger private domestic demand.

Kuwait's projects market rebounded in Q3 2025, with awards up 33.8% year-on-year to USD 4.3 billion. Cumulative awards in the first nine months were up more than 25% from 2024, indicating stronger execution momentum.

Kuwait government returned to global debt markets pricing at among the tightest emerging-market spreads in 2025. This issuance strengthens the sovereign yield curve, deepens global capital markets integration, diversifies Vision 2035 project funding, sets improved pricing benchmarks for banks and corporates, and supports credit growth and financial-sector depth.

Annual inflation eased to 2.39% in July 2025 (projected to moderate to 2.2% by the end of 2025) from 2.9% average in 2024, reflecting the Central Bank of Kuwait's prudent monetary policy. The CBK cut its discount rate by 25 basis points in September 2025, from 4.00% to 3.75%, reflecting a cautious approach to support sustainable growth while maintaining macroeconomic stability.

Al-Mukhaizeem said: "KFH delivered strong Q3 results with growth in financing, deposits, and fee income, reflecting our diversified model and leadership in retail, corporate, and investment banking. Our liquidity coverage and capital adequacy ratios exceed regulatory requirements, ensuring resilience.'

KFH preserved its position as Kuwait's largest listed company, with market capitalization increasing to KWD 14.3 billion (27.2% of all listed companies totaling KWD 52.6 billion) as of end-Q3 2025, up 19.9% compared to Q3 2024, reflecting sustained investor confidence.

Halloween weekend sees one of its slowest Octobers in 25 years

'Regretting You' and 'Black Phone 2' tie at weekend box office

LOS ANGELES, Nov 3, (AP): The movie exhibition business is closing out one of. its slowest Octobers in over 25 years with a sluggish Halloween weekend. Studios avoided opening any major new films with the holiday falling on a Friday. Instead, there were several re-releases including "Back to the Future," which is celebrating its 40th anniversary, and the Netflix phenomenon "KPop Demon Hunters.

But even with a top 10 in which no films earned more than \$10 million, there was still a bit of excitement as two studios claimed the No.1 spot Sunday. Universal's horror sequel "Black Phone 2" was largely expected to top the charts in its third weekend in theaters, and the studio reported that it was going to be in first place with an estimated \$8 million. About 30 minutes later, Paramount reported that its romantic drama "Regretting You" had earned an estimated \$8.1 million, which would place it in the top spot instead. Box office tracker Comscore went by the numbers and gave the first place title to "Regretting You." Sunday numbers are based on estimates and projections, however, and sometimes Monday actuals

"Regretting You" is the latest Colleen Hoover adaptation to open in theaters since "It Ends With Us" became a runaway hit in theaters. With a running domestic total of \$27.5 million, this newest film is not going to match its predecessor, which made \$50 million its first weekend.

In three weekends "Black Phone 2" has made \$61.5 million domestically and \$104.7 million globally. Universal also handled the nationwide re-release of Robert Zemeckis's "Back to the Future" which earned \$4.7 million from 2,290 theaters - enough to snag a fifth-place spot on the North American charts. The 1985

time travel classic now has a domestic total of \$221.7 million.

Though there were plenty of HUNTR/X costumes on the streets this weekend, "KPop Demon Hunters" didn't do as well as it did when it played in theaters in August. That weekend, the streaming hit sold between \$16 and \$20 million in movie tickets. This weekend, it's estimated to have earned somewhere in the \$5 million range from 2,890 screens. Two distribution executives shared numbers on

the condition of anonymity because Netflix has a policy of not reporting ticket

Sony Pictures and Crunchyroll's "Chainsaw Man - The Movie: Reze Arc" dropped a steep 67% in its second weekend and is projected to add \$6 million from 3,003 locations, bringing its total to \$30.8 million.

Focus Features also launched "Bugonia" into wide release after several weeks in limited. With an estimated \$4.8 million from 2,043 theaters, it marks filmmaker Yorgos Lanthimos's best wide break to date. The darkly comedic thriller stars Emma Stone and Jesse Plemons and is expected to be an awards season player.

"Springsteen: Deliver Me from Nowhere" landed in sixth place, behind "Back to the Future," and down 57% in its second weekend. It earned \$3.8 million, putting its domestic total at \$16.3 million and its global tally at \$30.6 million.

This was a truly scary weekend," said Paul Dergarabedian, Comscore's head of marketplace trends. "It was this imperfect storm of Halloween on a Friday and the World Series on Friday and Saturday. But the studios and theaters knew this was on the horizon and they planned for it."

The weekend may net out to be one of the lowest grossing of the year, closing out an unusually slow October. With the exception of October 2020 during the COVID-19 pandemic, the month's total ticket sales (\$443 million) have not been this low since 1998 (\$455.5 million).

The next two weekends may bring some energy back to multiplexes, however, with releases like "Predator: Badlands" and "Now You See Me: Now You Don't," but the industry will likely have to wait until closer to Thanksgiving for a real blockbuster when "Wicked: For Good" and "Zootopia 2" enter the mix.

"This was always going to be a tough weekend. The audience was truly fragmented," Dergarabedian said. "There are weekends where the movie theaters are

the focus of the attention, and those are coming."

'Snocaps' out

Waxahatchee duo reunites

NEW YORK, Nov 3, (AP): For the recently converted Waxahatchee fan, Alabamaraised singer-songwriter Katie Crutchfield does not drum up the image of distorted riffs, scrappy lo-fi recordings and indie rock sensibilities. For many years, though, that was her reality. (Incisive, lyrical self-reflexivity and emotional acuity have always been present in her work, now delivered in a famil-

P.S. Eliot and Bad Banana. Those were led by her and her twin sister, Allison Crutchfield, also of the influential indie-punks Swearin'. It is impossible not to hear the impact of the pair's clever harmonies, their ambling riffs and keen storytelling in generations of indie rock bands that fol-

Those groups dissolved as Waxahatchee took over, reuniting here and there for one-off performances for their devout listenership, and only when music-making seemed fun again. But a new project with both Crutchfields seemed off

Unlikely, that is, until now: Snocaps, a surprise new project from Katie and Allison Crutchfield, released a self-titled debut album on Halloween. It is 13 tracks performed by the two, joined by close collaborators Brad Cook (longtime Waxahatchee producer) and guitarist MJ Lenderman (formerly of the band Wednesday, known to Waxahatchee fans as one-half of "Right Back to It," one of AP's favorite songs of 2024).

It would be an oversimplification to say Snocaps sounds as if no time has passed - but there is no doubt a sense of comforting familiarity. "Heathcliff" opens with a warming bass lick and Allison's spirited voice; that, and "Avalanche," possess the unimpeachable melodicism of Swearin'. It bleeds effortlessly into "Wasteland," a Katie-led song where hints of modern Waxahatchee is heard. The style exists elsewhere, with her evolved and experienced tone ("Angel Wings") and more subtly in swaying musical movements. The same is true of the sisters' other projects: "Over Our Heads" has echoes of Bad Banana, free of the scuzz and fuzz

And it isn't just Katie and Allison taking turns on the track list: "I Don't Want To," and, in particular, "Hide" feel like an evolution from P.S. Eliot, perhaps a ripened "Tennessee" - a lovely slow burn with a simple pop melody. Then they dive into the ascendant "Cherry Hard Candy" with its jaunty cluster of guitars and hooky harmonies. In the last few decades, they've only become more expert at the style, meticulous and appearing effortless.

Linklater brings classic cinema era to life

'Nouvelle Vague,' an ode to French New Wave

LOS ANGELES, Nov 3, (AP): Any time a notable figure of the French New Wave is introduced in Richard Linklater's "Nouvelle Vague," we're treated to a momentary straight-on shot of them, with a nameplate - Claude Chabrol, Jacques Rivette, Éric Rohmer - at the bottom of the screen. It's a little like Linklater, as he goes, is cataloging different species of the same 1950s genus, or playing a grand game of New Wave "Guess

"Nouvelle Vague" is principally about Jean-Luc Godard (Guillaume Marbeck) and the making of his landmark feature debut, "Breathless." But it is also a wider portrait of a moveable filmmaking feast, of an entire generation of French filmmakers who were passionately engaged, individually and as one, in changing cinema. In 1959, it's a movement that's on the move.

To a remarkable degree, Linklater's film, in French and boxed into the Academy ratio, black-and-white style of "Breathless," has fully imbibed that spirit, resurrecting one of the most hallowed eras of movies to capture an iconoclast in the making. The result is something endlessly stylish and almost absurdly uncanny, even if 'Nouvelle Vague" never adopts the brash daring of its subject.

Instead, "Nouvelle Vague" is more of a straightforward though deeply affectionate ode to a singularly unconventional filmmaker. The contrast makes "Nouvelle Vague" a curious thing: a meticulous recreation of a rule-breaking cinematic revolution. Godard would have hated it. That doesn't make it any less enchanting.

At the outset of the film, Godard and company have gathered for the premiere of François Truffaut's "The 400 Blows." For Godard, the last of the Cahiers du Cinéma crowd to transition from writing criticism to directing, anxiety is mounting. He's 29 and beginning to fear he's missed

But confidence is not lacking in Godard. (Marbeck, excellent, doesn't take off his sunglasses for the duration of the movie, including in movie screenings.) On the heels of the Cannes reception for "The 400 Blows," the producer Georges de Beauregard (Bruno Dreyfürst, tremendous) agrees to make "Breathless." Beauregard warily eyes Godard, likely aware of the trouble he's making for himself. He pleads for Godard to just make a sexy "slice of film noir."

Godard, though, knows his chance has finally come to transfer all his ideas into film. Before production starts, he visits the elder statesmen of European cinema at the time - Jean-Pierre Melville (Tom Novembre), Roberto Rossellini (Laurent Mothe) - for advice. "Shoot quickly," Rossellini tells him.

Soundstages

Godard wants no lights, no soundstages and no script. He'll go into each day not knowing what he's going to shoot. On the first day of production, he announces: "Time to enter the pantheon."

The bulk of "Nouvelle Vague" is the day-today shooting of "Breathless," for which Godard cast Jean-Paul Belmondo (Aubry Dullin) as the small-time gangster lead and Jean Seberg (Zoey Deutch) as the Herald Tribuneselling American student he wants to run off with. (These, like so many of the many roles of "Nouvelle Vague," are so well matched that casting director Catherine Schwartz deserves a

shot at the inaugural Oscar.) The thrill of following the making of "Breathless" day by day is seeing just how brazenly Godard disregards the assumed conventions of moviemaking. On the first day, he wraps after two hours. For Linklater ("Slacker," "Dazed and Confused," "Before Sunset"), these scenes have a special resonance. Few filmmakers believe more ardently in the benefits of a leisurely hangout. But Godard's methods have a purpose. "I'm

trying to seize reality at random," he explains. "Nouvelle Vague" captures Godard stealing from his influences (Ingmar Bergman, Duke Ellington, Humphrey Bogart) while striving to realize his own voice as an artist. "Breathless" is a movie poised between movie eras - a deconstructionist bebop riff on a Hollywood genre film. "Nouvelle Vague," more than anything, is about how becoming an artist requires both reverence for the past and a stubborn insistence on breaking

ground on the future. "Nouvelle Vague," which opens in theaters Friday and streams Nov. 14 on Netflix, is one of two artist portraits by Linklater this fall, the other being "Blue Moon," with Ethan Hawke as the tragic lyricist Lorenz Hart. Both, as it happens, have their Bogart quotes. And both are stirring, cigarette-smoking musings on what makes a great lyric, a memorable song or a movie that will live on forever.

Berg and Sheridan will co-write the script and produce together, with Berg directing. The longtime friends previously collaborated on "Hell or High Water," which received four Oscar nominations, and "Wind River."

The film will be live action, but no other details about the "Call of Duty" movie were immediately available. The first-person shooter game, which debuted in 2003 as a World War II simulation, has sold over 500 million copies globally. Subsequent versions have delved into modern warfare as well.

The news of Sheridan's involvement in a new Paramount project came as a bit of a surprise to the industry. Earlier this week, reports said that

the "Yellowstone" creator was leaving Paramount for an overall film and television deal at NBCUniversal valued at some \$1 billion across five years. Representatives for NBCUniversal declined to

The announcement also comes on the heels of mass layoffs at Paramount, just months after completing its \$8 billion merger with Skydance. Paramount initiated roughly 1,000 of a planned 2,000 layoffs company-wide recently.

Surgeries, radiation treatments and chemotherapy amid a cancer fight kept him off the airwaves for two years until his return shortly before March Madness. But on Tuesday, the 86-year-old Basketball Hall of Famer will call a marquee opener between No. 6 Duke and Texas in a new event named in his honor.

His fight to get here - armed with a contract through the 2027-28 season - has forced Vitale to change routines to best ensure his health. That includes learning to say "no" more often and talking less on the day of a game, all antithetical to Vitale's full-blast persona. (AP)

Who is Zico Kolter?

Meet OpenAl safety chief who can block harmful Al releases

NEW YORK, Nov 3, (AP): If you believe artificial intelligence poses grave risks to humanity, then a professor at Carnegie Mellon University has one of the most important roles in the tech industry right now.

Zico Kolter leads a 4-person panel at OpenAI that has the authority to halt the ChatGPT maker's release of new AI systems if it finds them unsafe. That could be technology so powerful that an evildoer could use it to make weapons of mass destruction. It could also be a new chatbot so poorly designed that it will hurt people's mental health.

"Very much we're not just talking about existential concerns here," Kolter said in an interview with The Associated Press. "We're talking about the entire swath of safety and security issues and critical topics that come up when we start talking about these very widely used AI systems."

OpenAI tapped the computer scientist to be chair of its Safety and Security Committee more than a year ago, but the position took on heightened significance last week when California and Delaware regulators made Kolter's oversight a key part of their agreements to allow OpenAI to form a new business structure to more easily raise capital and make a profit.

Safety has been central to OpenAI's mission since it was founded as a non-profit research laboratory a decade ago with a goal of building better-than-human AI that benefits humanity. But after its release of ChatGPT sparked a global AI commercial boom, the company has been accused of rushing products to market before they were fully safe in order to stay at the front of the race. Internal divisions that led to the temporary ouster of CEO Sam Altman in 2023 brought those concerns that it had strayed from its mission to a wider audience.

The San Francisco-based organization faced pushback - including a law-suit from co-founder Elon Musk - when it began steps to convert itself into a more traditional for-profit company to continue advancing its technology.

Agreements

Agreements announced last week by OpenAI along with California Attorney General Rob Bonta and Delaware Attorney General Kathy Jennings aimed to assuage some of those concerns.

At the heart of the formal commitments is a promise that decisions about safety and security must come before financial considerations as OpenAI forms a new public benefit corporation that is technically under the control of its non-profit OpenAI Foundation.

Kolter will be a member of the non-profit's board but not on the for-profit board. But he will have "full observation rights" to attend all for-profit board meetings and have access to information it gets about AI safety decisions, according to Bonta's memorandum of understanding with OpenAI. Kolter is the only person, besides Bonta, named in the lengthy document.

Kolter said the agreements largely confirm that his safety committee, formed last year, will retain the authorities it already had. The other three members also sit on the OpenAI board - one of them is former U.S. Army General Paul Nakasone, who was commander of the U.S. Cyber Command. Altman stepped down from the safety panel last year in a move seen as giving it more independence.

"We have the ability to do things like request delays of model releases until certain mitigations are met," Kolter said. He declined to say if the safety panel has ever had to halt or mitigate a release, citing the confidentiality of its proceedings.

Kolter said there will be a variety of concerns about AI agents to consider in the coming months and years, from cybersecurity - "Could an agent that encounters some malicious text on the internet accidentally exfiltrate data?" - to security concerns surrounding AI model weights, which are numerical values that influence how an AI system performs.

Specific

"But there's also topics that are either emerging or really specific to this new class of AI model that have no real analogues in traditional security," he said. "Do models enable malicious users to have much higher capabilities when it comes to things like designing bioweapons or performing malicious cyberattacks?"

"And then finally, there's just the impact of AI models on people," he said.
"The impact to people's mental health, the effects of people interacting with these models and what that can cause. All of these things, I think, need to be addressed from a safety standpoint."

OpenAI has already faced criticism this year about the behavior of its flagship chatbot, including a wrongful-death lawsuit from California parents whose teenage son killed himself in April after lengthy interactions with ChatGPT.

Kolter, director of Carnegie Mellon's machine learning department, began studying AI as a Georgetown University freshman in the early 2000s, long before

it was fashionable.

"When I started working in machine learning, this was an esoteric, niche area," he said. "We called it machine learning because no one wanted to use the term AI because AI was this old-time field that had overpromised and underdelivered."

Kolter, 42, has been following OpenAI for years and was close enough to its founders that he attended its launch party at an AI conference in 2015. Still, he didn't

expect how rapidly AI would advance.
"I think very few people, even people working in machine learning deeply, really anticipated the current state we are in, the explosion of capabilities, the explosion of risks that are emerging right now." he said.

Al music platform settles copyright claims

Udio offers brief window for song downloads

NEW YORK, Nov 3, (AP): Artificial intelligence song generation platform Udio said it would give its frustrated users 48 hours starting Monday to download their songs before the company shifts to a new business model to comply with a legal settlement.

The short reprieve comes after Udio on Wednesday said it had settled copyright infringement claims brought by Universal Music, a label with artists including Taylor Swift, Olivia Rodrigo, Drake and Kendrick Lamar.

AI companies are now fighting so many copyright lawsuits that a tech industry lobby group, the Chamber of Progress, last week called on President Donald Trump to sign an executive order directing federal attorneys "to intervene in legal cases" to defend the industry's practice of building generative AI tools by feeding them on copyrighted works.

Citing more than 50 pending federal cases, the group asked for help stopping court fights leading to "potentially company-killing penalties" that threaten AI innovation. But artists have warned that AI tools built on their works also threaten their livelihoods.

In the biggest settlement so far, AI company Anthropic agreed to pay \$1.5 billion - or \$3,000 per book - to settle claims from authors who alleged the company illegally pirated nearly half a million of their works to train its chatbot.

cial terms of their new music licensing agreements. They also said they will team up on a new streaming platform.

As part of the agreement, Udio immediately stopped allowing people to download songs they've created, which sparked a backlash and apparent exodus among paying users.

"We know the pain it causes to you," Udio later said in a post on Reddit's Udio forum, where users were venting about feeling betrayed by the platform's surprise move and complained that it limited what they could do with their music.

Udio said it still must stop downloads as it transitions to a new streaming platform next year. But over the weekend, it said it will give people 48 hours starting at 11 a.m. Eastern time Monday to keep their "past creations."

"Udio is a small company operating in an incredibly complex and evolving space, and we believe that partnering directly with artists and

songwriters is the way forward," said Udio's post.
The settlement deal was the music industry's first since Universal, along with Sony Music Entertainment and Warner Records, sued Udio and another AI song generator, Suno, last year over copyright infringement.

Udio and Suno pioneered AI song generation technology, which can spit out new songs based on prompts typed into a chatbot-style text box. Users, who don't need musical talent, can merely request a tune in the style of, for example, classic rock, 1980s synth-pop or West Coast rap.

Record labels have accused the platforms of exploiting the recorded works of artists without compensating them.

In its lawsuit filed against Udio last year, Universal sought to show how specific AI-generated songs made on Udio closely resembled Universal-owned classics like Frank Sinatra's "My Way," The Temptations' "My Girl," ABBA's "Dancing Queen" and holiday favorites like "Rockin' Around the Christmas Tree" and "Jingle Bell Rock."

India launches heaviest communication satellite

Indian space authorities announced on Sunday the successful launch of heaviest communication satellite from Indian soil

The Indian Space Research Organisation (ISRO) said that it successfully launched the CMS-03 communication satellite on board LVM3-M5 from the second launch pad at Sriharikota island in southern Indian state of Andhra Pradesh.

The satellite weighing around 4,400 kg is the heaviest satellite to be placed into the Geo-synchronous Transfer Orbit from India.

Announcing the successful launch of the heavy communication satellite, ISRO Chief V Narayanan said: The CMS-03 satellite is a multi-band communication satellite with coverage over a wide oceanic region, including the Indian landmass, and is designed for providing communication services for at least 15 years. The satellite incorporates a host of new technologies and yet another shiny example of self-reliance.

He congratulated the entire satellite team spread across various ISRO centres for realising this important

and complex satellite for the communication capability of the country. "Even under this difficult weather condition, we could come out successfully and accomplish this mission in a grand and successful manner," he

Announcing a major experiment carried out on the occasion, the ISRO Chief said: "For the first time, we have, after successfully injecting the satellite into orbit and reorienting the stage, successfully ignited the thrust chamber. This is going to be a great experiment, which is going to feed data for restarting the cryogenic stage in future for enabling the mission flexibility for placing multiple satellites in various orbits using the . Bahubali rocket LVM-3.

Lack of early detection fuels glaucoma cases

Blindness rates in Sudan increase to 30 pct amid health system collapse

KHARTOUM, Nov 3, (KUNA): The blindness crisis in Sudan has worsened since the outbreak of war, which destroyed medical facilities and naited treatment campaigns with estimates warning of rising cases from 10 to 30 percent within a short period, according to local medical institutions.

Director of the National Program for Ophthalmology at the Sudanese Ministry of Health, Dr. Atef Omar, told Kuwait News Agency (KUNA) that field estimates indicate rising blindness rates despite the absence of precise statistics, adding that "the situation is dire, yet the ophthalmology infrastructure remains capable of recovery if adequate support

He added that the ministry launched an emergency plan at the start of the conflict to secure essentials, and is seeking cooperation with private institutions.

Director of Makkah Hospital in Omdurman and representative of Al-Basar Charity Foundation in Khartoum, Dr. Amir Abu Qurun, told KUNA that field data confirm blindness rates have tripled to 30 percent in two years due to halted services, displacement, migration of staff, and shortage of medical supplies.

Similarly, Director of Programs and Partnerships at Kuwait Patients' Helping Fund Society, Dr. Mohammad Hajo, told KUNA that the rise in blindness results from the suspension of preventive care, halted cataract surgeries, and shortages of essential medicines.

He noted that "these figures represent thousands who could have been saved from blindness if resources were available.'

Medical data indicate that cataract remains the most common cause of treatable blindness in Sudan, accounting for about 70 percent of cases, though it is surgically curable when resources and infrastructure are available.

Trachoma, an infection linked to poverty and poor hygiene, remains a contributing factor, though its prevalence has significantly declined in many countries due to prevention and eradication programs.

Glaucoma, meanwhile, is among the leading causes of irreversible blindness in Sudan, attributed to lack of early detection and weak public awareness.

Even before the war, Sudan's vision loss indicators were alarming. In 2020, the International Agency for the Prevention of Blindness' "Vision Atlas" estimated about three million Sudanese suffered from visual impairment, including 210,000 who were completely blind, placing Sudan among

Africa's highest in blindness rates.

These figures reveal a stark gap between Sudan's situation and global blindness reduction efforts, as the World Health Organization (WHO) notes that 90 percent of visually impaired people live in low and middle-income countries, making Sudan a clear example of the intersection of poverty, conflict, and health collapse.

Sudan's health system had relied heavily on external support, with NGOs performing 56 percent of cataract surgeries before the war, compared to 36 percent by government institutions and only eight percent by the private sector.

Abu Qurun noted that Makkah Eye Foundation, since its establishment in 1993, has served more than 1.8 million patients; about 65 percent of national anti-blindness efforts, and through its hospital network continues intensive programs treating 4,000 patients.

This underscores the fragility of Sudan's health infrastructure before the war, explaining the rapid deterioration of services after the conflict and loss of international aid.

According to the WHO, the war has disrupted over 70

percent of hospitals in Sudan and halted about 45 percent of primary healthcare centers, leading to a near paralysis of medical services nationwide.

Mountain schools achieve zero myopia

China performs 5G eye surgery 4,000 km away

GUANGZHOU, Nov 3, (Xinhua): A Chinese medical team has performed a groundbreaking remote robotic eye surgery, using a 5G-connected robot to treat a patient over 4,000 ki-

The procedure, a retinal injection, was performed on Sunday by surgeons in the southern city of Guangzhou who remotely controlled a robotic arm at a hospital in Urumqi, northwest China's Xinjiang Uygur Autonomous Region.

The surgery, performed with micron-level precision, marked a significant step in leveraging technology to bridge the medical resource gap between developed coastal regions and remote areas.

After the robot in Urumqi positioned the microscopic needle on the patient's eye, surgeons in Guangzhou took remote control. They guided the needle to the surface of the retina, pierced it to a pre-determined depth, and injected the

The entire remote surgery took less than seven minutes, with the network remaining stable and the robot responding

smoothly without any tremor. Retinal sub-injection is a meticulously delicate microsurgical technique employed to salvage vision in blinding disorders such as submacular haemorrhage.

Meanwhile, in the remote mountains of southwest China's Yunnan Province, three elementary schools have achieved what seems like a fairy tale, with not a single student wear-

These schools, Wantang Primary School in Honghe Hani and Yi Autonomous Prefecture, Lafu Primary School and Gedi Primary School in Pu'er City, have maintained a zero myopia record among their students, thanks to a simple yet powerful routine of over three hours of daily outdoor activi-

At Wantang Primary School, principal Sun Fubiao would stand by the flagpole early every morning, watching the children do their morning exercises.

"Our school has always taken pride in students not wearing glasses," he said, adding that he regards it as a personal responsibility to protect his pupils' eyesight.

Mao Heming, a Chinese language teacher who also wears glasses, said his nearsightedness resulted from watching TV, playing video games and reading novels by flashlight during his childhood. "I've always believed that protecting students' eyesight is the most meaningful gift our generation of 'bespectacled teachers' can give them.

Ignoring pregnancy pain can harm mothers and babies, experts warn

Untreated pain tied to depression, suicide

bout half to three-quarters of ex-A pout nan to unce quality appetant mothers experience pain during pregnancy that is largely untreated, contributing to preventable suffering and harm. Many mothers avoid medications and treatments during pregnancy for fear that they may cause harm to their unborn baby. Yet, most are unaware of the harms that untreated pain in pregnancy may cause.

Like many women, I experienced severe pain in pregnancy. As a nurse researcher, I listen to women's stories and analyze data from across the United States. I share these findings through publications, presentations and the media to raise awareness and reduce the suffer-

ing of untreated pregnancy pain.

Mothers are often told that the pain that comes with pregnancy is a temporary discomfort that comes with the territory and ends as soon as the baby is born.

But when pain and discomfort persist to the point that mothers cannot sleep, work and care for their other children, mothers are experiencing pain that needs to be addressed. And for some mothers, the pain does not just eventually fade. Back pain and headaches, for example, can last longer than three months, becoming a chronic condition that affects overall health.

Normal changes that occur during pregnancy often lead to pain. Pregnancy pain normally occurs from hormonal changes that can cause headaches and loosening of pelvic joints. The loosening of joints and the weight of the unborn baby contribute to back pelvic pain. The weight of the developing baby also causes the spine to abnormally curve, a condition called lordosis.

Back and pelvic pain increase in the third trimester of pregnancy when the weight of the baby is at its greatest. This is why it's incredibly important for doctors and loved ones to believe mothers when they report pain. However, one meta-analysis, meaning an in-depth review of existing research, found that more than 50% of mothers who reported their pain received little to no treatment from their doctors.

Current treatments for pain during pregnancy are highly limited.

Tylenol, though safe - despite the current controversy - treats only mild pain and is ineffective for moderate to severe muscle pain.

Alternative treatments that are also recommended and can be effective.



such as heat or cold applications, massage, chiropractic adjustments, exercise and physical therapy, may need to be used in unison and on an ongoing basis. These treatments are not always covered by insurance.

The most effective approach combines several treatments, including exercise that may be provided through physical therapy. Unfortunately, this care may be costly for mothers without adequate insurance, and awareness of these options varies among providers.

My team's research reveals that when mothers report pain during pregnancy to their health care providers and loved ones, mothers are typically instructed to go home, rest, take Tylenol, go on maternity leave or a combination of these. However, this does not meet the needs of mothers who must work or care for other children. In addition, going on leave early is not an option for many mothers who desire to save their limited maternity leave for

after the baby is born.

Mothers will almost always continue to take care of their children or work at the expense of their health if they feel there are no other choices. However, when expectations from their work, family or themselves are not met, mothers may feel guilty about not being a good enough mother or employee. This cycle can contribute to mental health challenges.

When pain is left untreated, mothers may feel minimized, unheard and overwhelmed. In turn, they can start to feel helpless and hopeless, which are symptoms of depression. My colleagues and I found that approximately 44% of women with severe pain report moderate to severe depressive symptoms during the third trimester of preg-

Untreated depression can also lead

to suicide, which is responsible for 5% to 20% of maternal deaths in the US.

Equally important, opioid or narcotic pain relievers may be prescribed for pregnant mothers experiencing severe pain. Yet, 1 in 5 women with pain report misusing these prescribed medications during pregnancy to relieve pain. In turn, this increases the risk of newborns experiencing withdrawal from these medications after birth, causing significant suffering. Sadly, neonatal opioid withdrawal syndrome is becoming more common, costing the country over US\$462 million annually.

With suicide and drug overdoses now the leading causes of death in the year after childbirth, effective pain management in pregnancy is urgently needed.

Managing pregnancy pain starts with open communication between the mother and their health care provider. Our studies reveal that by gently adjusting expectations, sharing how they feel and asking about available treatments, mothers can take an active role in ensuring their pain is understood and addressed.

Pregnant mothers are strong, but it's natural to slow down. Pregnancy is a time to listen to your body and adjust expectations. I believe that balance matters. If pain prevents you from lifting your toddler, that's OK. What your child will remember the most are the moments you snuggled with them on the couch.

My team's studies reveal that talking to loved ones about pain may be a challenge. So choose a calm, quiet time without distractions - when everyone can listen and respond thoughtfully. Be open about how you feel and clear about the help you need. Using "I" statements such as "I feel ..." also helps. Allow for questions. (AP)

'Serious concerns'

US FDA's top drug regulator resigns amid investigation

WASHINGTON, Nov 3, (AP): The head of the Food and Drug Administration's drug center abruptly resigned Sunday after federal officials began reviewing "serious concerns about his personal conduct," according to a gov-

ernment spokesperson. Dr. George Tidmarsh, who was named to the FDA post in July, was placed on leave Friday after officials in the Department of Health and Human Services' Office of General Counsel were notified of the issues, HHS press secretary Emily Hilliard said in an email. Tidmarsh then resigned Sunday

"Secretary Kennedy expects the highest ethical standards from all individuals serving under his leadership and remains committed to full transparency," Hilliard said.

The departure came the same day that a drugmaker connected to one of Tidmarsh's former business associates filed a lawsuit alleging that he made "false and defamatory statements," during his time at the FDA.

The lawsuit, brought by Aurinia Pharmaceuticals, alleges that Tidmarsh used his FDA position to pursue a "longstanding personal vendetta" against the chair of the company's

board of directors, Kevin Tang. Tang previously served as a board member of several drugmakers where Tidmarsh was an executive, including La Jolla Pharmaceutical, and was involved in his ouster from those leadership positions, according to the lawsuit.

Messages placed to Tidmarsh and his lawyer were not immediately returned late Sunday.

Tidmarsh founded and led a series of pharmaceutical companies over several decades working in California's pharmaceutical and biotech industries. Before joining the FDA, he also served as an adjunct professor at Stanford University. He was recruited to join the agency over the summer after meeting with FDA Commissioner Marty Makary.

Tidmarsh's ouster is the latest in a string of haphazard leadership changes at the agency, which has been rocked for months by firings, departures and controversial decisions on vaccines, fluoride and other products.

China tests new space factory, eyes in-orbit manufacturing

BEIJING, Nov 3, (Xinhua): A team of Chinese scientists has completed the ground tests of an inflatable, reconfigurable module for a novel space manufacturing platform, in a significant step toward enabling large-scale industrial production in orbit.

The breakthrough module, details of which were announced on Monday, has an innovative design that is intended for launch in a tightly folded configuration and inflates once in orbit to form a large, stable workspace, according to the Chinese Academy of Sciences (CAS).

Test images have revealed that the ex-

panded module forms a cylindrical structure over 2 meters in diameter. Researchers say the expandable structure makes it an ideal candidate for future space-based manufacturing, including areas such as biopharmaceuticals, 3D printing and the production of novel materials

The field tests involved achieving a reliable, airtight connection between rigid structures and the flexible habitat; precise, controlled deployment in a microgravity environment; and ensuring the inflated module provides a sufficiently stable environment for highprecision manufacturing tasks.

Cases surge

Dengue deaths rise in Pakistan

ISLAMABAD, Nov 3, (Xinhua): Pakistan's southern Sindh province has reported three more deaths from dengue fever in the past 24 hours, raising the total number of fatalities this year to six, according to the provincial health department.

Two of the latest victims, a 30-year-old woman from Malir and a 65-year-old man from Karachi's West district, died at the Sindh Infectious Diseases Hospital, while an 18-year-old girl from Hyderabad district died at Liaquat University Hospital, officials said.

The department's latest data showed that more than 1.400 people tested positive for dengue in the province during the past 24 hours, including 618 cases in Karachi and 793 in Hyderabad. Over 200 patients were also admitted to hospitals across Sindh during the same period.

Authorities have urged citizens to avoid self-medication, maintain proper hydration, and seek timely medical advice to prevent complications such as internal bleeding and low platelet counts.

Officials said the true scale of the outbreak remains unclear, as many private hospitals and clinics do not report their data to government health authorities.

Meanwhile, Vietnam's capital Hanoi has reported a rapid increase in dengue fever cases over the past week, with 486 new infections recorded from Oct. 24 to 31, up 94 cases from the previous week, Vietnam News Agency reported Monday.

According to the Hanoi Center for Disease Control, the city recorded new outbreaks in 23 communes and wards, bringing the total number of active clusters to 32, with no deaths reported so far.

Gauff hits 17 double-faults in loss to Pegula, Sabalenka tops Paolini

RIYADH, Saudi Arabia, Nov 3 (AP): Top-ranked Aryna Sabalenka put on a dominant serving display in her opening match at the WTA finals, producing 10 aces in a 6-3, 6-1 win over No. 8-ranked Jasmine Paolini.

Sabalenka served four aces in the final game of the first set alone and overall put 82.7% of her first serves in play.

The match, which was Sabalenka's 500th at the WTA lev-

el, lasted 70 minutes. 'I was focused, I was calm and it felt like everything was in con-

trol," Sabalenka said. Sabalenka was presented with

a trophy for finishing the year at "I'm super happy and super

proud of the work that has been done and that things are working and I'm getting better and better every day," she said. "And I just hope that we're going to keep doing what we're doing and hopefully we can stay there.'

The season-ending tournament for the year's top eight players starts with two four-woman groups of round-robin play. The top two finishers in each group advance to the semifinals.

"I take this tournament as a regular tournament that I have to win five matches if I want to win the title," Sabalenka said. "So I'm just trying to bring my best tennis and fight for every point."

In the same group, Jessica Pegula beat defending champion Coco Gauff 6-3, 6-7 (4), 6-2 in an all-American matchup.

Gauff again struggled with her serve, hitting 17 double-faults - including one to hand the first set to Pegula, her former doubles partner.

Before she ultimately pulled it out in the tiebreaker, Gauff twice failed to serve out the second set. On her second such chance, she hit three consecutive doublefaults to let Pegula break her again and force a tiebreaker.

Three weeks ago, Gauff beat Pegula in the final of the Wuhan Open in China.

"Obviously, little frustrated with the serve today," Gauff said. "Overall, it was a tough match for me. Jess played well and I thought she was playing a bit smarter than she was when we played in Wuhan."

Added Pegula, "Coco is a great champion, great competitor, good friend. So it's always tough playing her. I don't think there's any secrets with this group of girls here."

Iga Swiatek and Elena Rybakina won their opening matches.

LAFC advances to West semifinals

AUSTIN, Texas, Nov 3, (AP): Denis Bouanga had two goals and an assist on Sunday night to help Los Angeles FC beat Austin FC 4-1 and sweep the best-of-three series in the first round of the MLS Cup playoffs

LAFC, which won Game 1 2-1, plays at second-seeded Vancouver in the one-game Western Conference

Son Heung-Min added a goal and an assist for No. 3 seed LAFC. Jeremy Ebobisse replaced Son in the 88th minute and capped the scoring in the third minute of stoppage time.

Son, on the counter-attack, hesitated to freeze defender Ilie Sánchez at the top of the area and then exploded toward the left end line and blasted a shot from the corner of the 6-yard box inside the back post to open the scoring in the 21st. About four minutes later, Son fed Bouanga for a finish the 30-year-old's 100th goal across all competitions for LAFC - into a wide-

open net to make it 2-0. Bouanga cut inside to evade defender Brendan Hines-Ike - who fell to the ground - and then flicked a shot into the net from the left center of the area

in the 44th minute. Bouanga is the only active player and is one of just nine in history - with at least 10 career goals in the MLS Cup

LAFC's Hugo Lloris - who was second in MLS with 12 shutouts in the regular season - had three saves, including a diving stop on a penalty kick by Myrto Uzuni in the 39th minute after a hand ball in the area by Bouanga.

Ryan Porteous was shown a yellow card for a foul in the area and Dani Pereira converted from the spot in the sixth minute of stoppage time to make it 3-1 at halftime.

CJ Fodrey appeared to have cut sixth-seeded Austin's deficit to 3-2 in the 71st minute but an offsides call nullified the would-be goal.

Max Arfsten had a goal and two assists and Dylan Chambost scored a first-half goal to help the Columbus Crew avoid elimination from the MLS Cup playoffs and beat FC Cincinnati 4-0 in Game 2 of the best-of-three first-

round series. The series returns to TQL Stadium, where Cincinnati won the opener 1-0, for Game 3 on Saturday. The winner advances to the one-game Eastern Conference semifinals against No.3 seed Miami or sixth-seeded Nashville.

Larson snatches 2nd NASCAR title as late caution crushes Hamlin's dream

AVONDALE, Ariz., Nov 3, (AP): Kyle Larson knew he wasn't going to catch Denny Hamlin in the final laps on Sunday, not without the sort of help that only a caution flag can bring.

Larson got his lucky break. Hamlin only got heartbreak.

Larson is now a two-time NASCAR champion after denying Hamlin what would have been his first career title when a late caution at Phoenix Raceway sent the championship-deciding finale into overtime.

Without that caution, which came with three laps to run, Hamlin had it locked up and was ready to finally shed the label of greatest NASCAR driver to never win a championship. But fellow title contender William Byron got a flat tire and hit the wall to bring out the caution, and a few minutes later, it was over.

"Just unbelievable," Larson said. "I cannot believe it." Neither could Hamlin.

"I really don't have much emotion right now. Just numb about it 'cause just in shock," Hamlin said after consoling his crying daughters on pit road. "We were 40 seconds away from a championship. This sport can drive you absolutely crazy because sometimes speed, talent, none of that matters.

When the caution for Byron came out, Hamlin led the field down pit road and got four new tires on his oyota; Larson only took two tires on his Chevrolet. It meant Larson was fifth for the two-lap sprint to the finish, with Hamlin back in 10th.

With so little time to run down Larson, Hamlin short with a sixth-place finish as Lar ished third. Ryan Blaney, who was eliminated from title contention last week, won the race.

"You do have to feel for that group and Denny. Doing a good job all day, it's not playing out for him. But that is racing. It sucks sometimes," Blaney said. They can hang their head about it, but they should be very proud of the effort. They had the fastest race car here. Just one of those things where it doesn't

work out. Looked like it was going into his favor, unfortunately for him, it didn't."

It is the second championship for Larson, who won his first title in 2021 when he joined Hendrick Motorsports. It is the 15th Cup title for the organization and came on the 30th anniversary of Jeff Gordon giving Hendrick its first championship in 1995.

As Larson celebrated, Hamlin sat in his car motionless for several seconds, then wiped his face with a white towel, never showing any emotion.

Larson, who has been in a slump since his disastrous Memorial Day attempt to race both the Indianapolis 500 and Coca-Cola 600 on the same day, was also in shock. 'We didn't lead a lap and won the championship,'

Larson said. "We had an average car at best and had

the right front (tire) go down, lost a lap, and got the wave around, saved by the caution with the wave around. It's just unbelievable. What a year by this motorsports team.' Team owner Rick Hendrick, Gordon, and Larson crew chief Cliff Daniels all said they did not believe

Larson still had a chance at the championship after so

many problems during the race. "I have to acknowledge that it was a pretty ugly day for us," Daniels said. "I think we were beaten on raw pace, and after we had the flat tire, there weren't a lot of good things coming our way. The way the team stuck together and continued to believe in each other, Kyle continued to believe that if we just had a

shot, we could close it out."

When Hamlin finally got out of his car, he emraced his crew members, but it was a scene of disbelief among the Joe Gibbs Racing crowd. Team members were crying, some sitting in shock on the pavement, Gibbs himself stood silent, one hand on his hip, and a look of disbelief on his face.

It is the sixth shot at a title to slip away from Hamlin in his 20 years driving for Gibbs. He led 208 of the 319 laps and started from the pole.

"Nothing I could do differently. I mean, prepared

as good as I could coming into the weekend, and my team gave me a fantastic car," Hamlin said. "Just didn't work out. I was just praying 'no caution' and we had one there. What can you do? It's just not meant to be.'

He said crew chief Chris Gayle made the correct call with four tires, but too many others only took two, which created too big a gap for Hamlin to close on Larson in so little time.

The 44-year-old Virginia native had been extremely jinxed in five previous championship finales, with bad luck, bad strategy, and bad cars breaking his heart in 2010, 2014, 2019, 2020, and 2021. Sunday marked his first time eligible in the winner-take-all race in four seasons. Hamlin was remarkably loose and calm all week, rented three houses in Scottsdale for 30 friends and family, won the pole, and then dominated Sunday's race.

He was the sympathetic favorite, the betting favorite, and who one most of the industry was pulling for - largely based on how much heartbreak he had faced. Hamlin burst onto the NASCAR scene in 2006, winning rookie of the year and finishing third in the championship.

On many levels, that promise has been fulfilled with 60 victories, three of them Daytona 500 wins. On the championship level, it still has not. He had a 15-point lead over Jimmie Johnson go-

ing into the 2010 finale, but was in a terrible mental space, struggled the entire weekend, and spun in that race. Johnson wound up winning his fifth straight title, and Hamlin settled for second.

He had a bad pit stop in 2014, overheated because the team put too much tape on the front grille in 2019, and a caution late in the 2021 finale doomed his chances that year. Ross Chastain's infamous wall ride in 2022 bumped Hamlin from the Championship 4 by mere inches at the finish, and now, this.

"Man, if you can't win that one, I don't know which one you can win," Hamlin said of his latest

Kipruto wins men's race by fraction of second

Obiri sets women's NYC Marathon course record

NEW YORK, Nov 3, (AP): The New York City Marathon made history on Sunday with a course record set in the women's competition and the closest race ever on the men's side, which was decided by a fraction of a second.

Hellen Obiri of Kenya broke the women's record while compatriot Benson Kipruto won the men's race by edging Alexander Mutiso by three-hundredths of a

Obiri, who also won the race in 2023, finished in 2 hours, 19 minutes, and 51 seconds. She was running with 2022 winner Sharon Lokedi until Obiri pulled away from her countrymate in the final mile, surging ahead and winning easily by 16 seconds to best the previous course record of 2:22.31 set by Margaret Okayo

"It feels so great. ... I am so happy to run the course record," Obiri said. "With 1K to go, I felt like I was so strong. I have something left in my tank.'

Defending champion Sheila Chepkirui finished third. All three beat the previous course best on a beautiful day for running, with temperatures in the 50s Fahrenheit when the race started. Kipruto and Mutiso separated themselves from the chase pack in the men's race

heading into Mile 24. Kipruto seemed to have put the race away, pulling away from Mutiso in the last 200 meters. But Mutiso, who is also from Kenya, wasn't done, surging in the last 50 meters before falling just short. Kipruto, who was running the New York race for the first time, finished in 2:08.40. That finish topped the 2005 race, which was decided by a second.
"I was aware that Mutiso was behind," said Kipruto, who also has won the Bos-

ton, Chicago, and Tokyo marathons. "It was so close, and I knew because I know Mutiso is a strong guy.' Albert Korir, who won in 2021, was third, giving Kenya a sweep of the top three

spots in both the men's and women's races. Joel Reichow was the top American, Eliud Kipchoge, who turns 41 next week, wrapped up a historic run as one of

the most accomplished marathoners in the sport. Kipchoge, who has won 11 major

world marathons, finished 17th in his first time running NYC.

On the women's side, the trio of former champions separated themselves heading into the Bronx at Mile 20. American Fiona O'Keeffe and Dutch runner Sifan Hassan had made it a pack of five once the group entered Manhattan a few miles earlier, but couldn't hang on for the final 6 miles.

This was the first time that the previous three women's winners had been in the same race since 2018. The trio didn't disappoint, putting forth stellar efforts. It was the second straight year that Kenyans took the top three spots.

O'Keeffe finished fourth, breaking the American course record as she finished

"Really exciting. I can't take too much credit for the time, that was all on the women ahead of me," O'Keeffe said. "Grateful to be back in the marathon. Feels like coming home." Fellow American Annie Frisbie finished fifth as four of the top nine finishers were from the U.S. Hassan, who won the Sydney Marathon two months ago, was sixth.

Chelsea Clinton was also one of the finishers, completing the course in just under 3:45. She was greeted at the finish line by her parents - former President Bill Clinton and former Secretary of State Hillary Clinton.

The 26.2-mile course took runners through all five boroughs of New York, starting in Staten Island and ending in Manhattan's Central Park. This is the 49th year the race has been in all five boroughs. Before that, the route was completely in Central Park. The first race had only 55 finishers, while a record 55,642 people finished last year, the largest in the history of the sport until the London Marathon broke it earlier this year.

Marcel Hug and Susannah Scaroni both won the wheelchair races dominantly. Hug, known as the Silver Bullet, has now won this marathon seven times. He finished 3:52 ahead of second-place finisher David Weir. Scaroni defended her title and was victorious for the third time in four years. She crossed the finish line 5:43 ahead of second-place finisher Tatyana McFadden, who has won the race

India celebrates historic women's World Cup title

'A defining moment'

NEW DELHI, Nov 3, (Agencies): India won its first-ever ICC Women's Cricket World Cup title on Sunday night, defeating South Africa by 52 runs in a pulsating final at the DY Patil Stadium in Navi Mumbai.

Celebrations erupted across India following the victory, which ended the country's 52-year wait for a maiden Women's World Cup title.

Cricket fans marked the win by setting off firecrackers, dancing in the streets and congratulating one another.

Indian leaders and sports personalities described the victory as a "defining" moment that could inspire an entire generation.

"Congratulations to our players. This historic win will motivate future champions to take up sports," Indian Prime Minister Narendra Modi in a statement posted on social media said.

The Board of Control for Cricket in India, the national governing body of the sport, announced the team would receive a reward of 5.8 million U.S. dollars. The Women's Cricket World Cup was first held in 1973.

India won the Women's Cricket World Cup for the first time with a 52-run victory over South Africa, led by brilliant all-round performances from Deepti Sharma and Shafali Verma.

Opening batter Verma, who was only called back into the squad as injury cover for the finals, scored a career-best 87 off 78 balls as the tournament cohost reached 298-7 in 50 overs after losing the toss and being sent in to bat.

South Africa was out for 246 in 45.3 overs in reply with its chase effectively over after skipper Laura Wolvaardt was out for 101. Spinner Sharma took the final wicket of the match and returned bowling figures of 5-39 from

"We were waiting for this moment, and now this moment has come," India captain Harmanpreet Kaur said, reflecting on a triumph after two previous finals defeats. "Now we want to make this a habit." India was the last of the four teams to qualify for the semifinals, but then beat defending champion and seven-time winner Australia by five wickets to reach the final. South Africa beat four-time champion England by 125 runs to reach the final for the first time.

Winning at home gave India its first major women's cricket title. Harmanpreet Kaur's squad was the first, first-time champion since 2000, when New Zealand ended the long dominance of Australia and England.

Verma - who was drafted in last week for the injured Pratika Rawal - took 2-36 with the ball and was voted player of the match.

Before her five-wicket haul, Sharma (58) posted her third half-century of the tournament to help India reached the second highest total in a World Cup final after Australia's 356-5 against England in 2022.

She finished the tournament with 22 wickets and 215 runs in nine matches

In Charlotte, Miles Bridges scored 29 points, Kon Knueppel added a careerhigh 24 and the Charlotte Hornets routed the Utah Jazz to snap a three-game losing streak.

High-energy backup center Moussa Diabate provided a huge spark for the Hornets with 17 points and 12 rebounds. Sion James, Knueppel's college teammate at Duke, also had a career-high 15 points.
