KUWAIT CITY, Dec 2, (KUNA): His Highness the Amir Sheikh Meshal Al-Ahmad Al-Jaber Al-Sabah and his accompanying delegation will depart on Wednesday, heading to Bahrain to chair the Kuwaiti delegation at the 46th Regular Session of the Supreme Council of the Gulf Cooperation Council (GCC).

Over decades, Bahrain has hosted seven GCC summits that marked major milestones in strengthening political, economic, and security integration among member states and advancing joint Gulf action.

These summits adopted landmark decisions that reinforced GCC institutional development and responded to the aspirations of Gulf leaders and peoples for deeper

The government needs to review everything written and spoken

THE stark contrast between the KD 4 billion Kuwaitis spent on tourism abroad last year and the mere KD 206 million generated from visitors to Kuwait highlights a major imbalance.

This huge disparity requires us to consider strategies for revitalizing domestic tourism, thereby reducing outbound spending, and redirecting it toward

Furthermore, action is needed to attract international visitors, bringing Kuwait in line with other GCC countries that have succeeded in the global

There is no doubt that the country is fully capable of implementing entertainment projects on both regional and global levels. Moreover, available unused land can be repurposed to support this goal.

Benefiting from these resources properly, free from administrative obstacles, will not only generate significant national benefits but also promote development in all regions of Kuwait.

This would facilitate the allocation of sovereign wealth funds toward such projects, along with contributions from the Social Security Fund and similar

It would also encourage private-sector participation and provide incentives to attract foreign investment, not to mention that banks possess substantial capital they are eager to invest.

Effective planning, sound decision-making, and ensuring equal opportunities for all are essential. This responsibility rests with the current government, which is unburdened by the pressures that hindered previous administrations.

Previous governments were susceptible to pressure and intimidation from members of parliament. These MPs pursued electoral gains, often misusing public funds and promoting wasteful spending to avoid parliamentary questioning.

This misguided approach created a budget deficit and impeded many of Kuwait's economic capabilities. As a result, several projects were halted and plans

shelved. While there is no need to revisit those losses in detail, it is necessary to take into consideration the potential to rectify the damage of the past, particularly now that the government holds both legislative and executive powers and is fully capable of restoring what was lost.

This governmental advantage grants great capacity to boost the Gross Domestic Product (GDP) through development projects in all sectors, including the entertainment industry.

Supplying drugs to minors now punishable by death

KUWAIT CITY, Dec 2: The Ministry of Interior announced that the death penalty for drug trafficking and the use of intoxicants will be enforced in several cases under the new anti-narcotics law, which will involving narcotic drugs or psychotropic substances. come into effect on December 15, 2025, reports Al-

Seyassah daily.

In an official statement, the ministry explained that the death penalty applies in the following circumstances:

■ If the accused established or ran an organization or gang to commit crimes

Kuwait revamps MoH operations

KUWAIT CITY, Dec 2: Minister of Health Dr. Ahmad Al-Awadhi has approved the updated organizational structure of the Ministry of Health, as part of ongoing efforts to enhance the efficiency of both health and administrative sectors.

The new structure includes an undersecretary, two assistant undersecretaries, and multiple directors general, all within an integrated administrative framework designed to enhance operational effi-ciency and clarify lines of responsibility across all sectors.

Under the new structure, the General Department of Legal Affairs will report directly to the minister, and the General Department of Hospitals and Health Centers will fall under the Undersecretary. This reflects the importance of this sector and its role in delivering medical and healthcare services.

Kuwait set to restore oil output

Al-Seyassah/Arab Times Staff KUWAIT CITY, Dec 2: Kuwait is expected to fully return to its OPEC+ production quota, reaching or surpassing 2.8 million barrels per day, the same level set before the COVID-19 pandemic, by the end of 2026 or early

According to informed sources, the Kuwait Petroleum Corporation (KPC) is preparing for a comprehensive revitalization of the oil sector beginning in 2026 through the adoption of five main

The first strategy is focused on in-

tensifying offshore exploration efforts currently being carried out by Kuwait Oil Company (KOC), which have already resulted in the discovery of three oil wells - Al-Julaia, Al-Nukhatha, and Jazah - , along with onshore explorations, the most recent being the Mutriba

The second strategy involves supporting international subsidiaries such as Kuwait Petroleum International (KPI), which owns thousands of service stations in Europe and is involved in multiple projects in Asia and Oman.






shared with him their hopes for a future filled with stability and

Minister lauds KFAED, KIA role in global stability

KUWAIT CITY, Dec 2: Minister of Foreign Affairs Abdullah Al-Yahya says Kuwait, since the start of its modern renaissance, has practically demonstrated a fundamental truth - soft power is both a part of the state's identity and a vital instrument of its foreign policy.

He said this during the "Across Borders" event hosted by the Saud Nasser Al-Sabah Diplomatic Institute on Monday evening, attended by officials and members of the diplomatic corps accredited to Kuwait.

The minister affirmed that Kuwait has long shared its culture, arts, and media globally through initiatives such as "Al-Arabi" magazine, which offered the Arab world a window to the world, and the "World of Thought" series, which encouraged dialogue, knowledge, and intellectual exchange.

Minister tours Al-Rai, Shuwaikh

'We will not allow anyone to exploit industrial plots'

KUWAIT CITY, Dec 2: The Public Authority for Industry (PAI) announced that the Minister of Commerce and Industry and Chairman of the Board of Directors of PAI, Khalifa Al-Ajeel, conducted an extensive inspection tour of several industrial and service plots in Al-Rai and Shuwaikh on Monday.

According to a press release issued by the Ministry of Commerce and Industry, the minister was accompanied by a team from the relevant regulatory bodies.

The tour aimed to assess compliance with designated land uses, evaluate the efficiency of operational processes, and address any violations or issues that could affect the quality of the country's industrial environment.

During the tour, the minister inspected several industrial, service, and commercial plots under PAI's jurisdiction, and reviewed the status of the plots, ongoing factory activities, expansion projects, and the operational challenges faced by industrial investors.

The tour was carried out in coordination with several relevant government agencies, including the Kuwait Fire Force, Kuwait Municipality, Environment Public Authority, Public Authority for Manpower, Ministry of Interior, and Ministry of Commerce and Industry. This was aimed to ensure strict enforcement of laws and regulations concerning security, safety, environmental protection, licensing, labor, and the designated uses of industrial plots. This joint effort reflects a new approach to multi-agency oversight, enabling prompt and comprehensive action to address any violations.

This tour follows the minister's decision to form specialized inspection committees, led by three judges, tasked with conducting comprehensive surveys of industrial plots, identifying all violations, and taking strict legal action against offenders without exception.

These efforts are part of a series of decisive measures implemented this year, during which more than 50 industrial, craft, and service plots, along with non-compliant work sites, were revoked in just one year.

This unprecedented action in the history of PAI underscores the ministry's and the authority's commitment to tackling violations and restoring order within the sector.

PAI has intensified its inspection campaigns recently through joint teams comprising representatives from relevant authorities. This is aimed to ensure the optimal use of industrial plots and prevent violations that could weaken the sector's competitiveness or compromise its operating environment.

The campaigns form part of a wide reform agenda led by the ministry, focused on enhancing governance, improving the quality of national products, and creating a safe and attractive industrial environment.

Co-ops ponder why shortage Modern tools needed of eggs crisis has come back to boost audit output

KUWAIT CITY, Dec 2: Head of the Union of Consumer Cooperative Societies (UCCS) Mariam Al-Awad held an expanded meeting to discuss the egg shortage crisis in cooperative societies, investigate its causes, and develop urgent solutions to ensure product availability for consumers.

Present at the meeting was the Director of Commercial Control at the Ministry of Commerce and Industry Faisal Al-Ansari, Financial Controller of UCCS from the Ministry of Social Affairs Dalal Al-Anzi, and General Supervisor at the Kuwait United Poultry Company under the Ministry of Commerce and Industry Duaij Al-Hussein, as well as representatives from companies in the poultry sector.

During the meeting, they discussed establishing a joint coordination mechanism with the Kuwait Poultry Producers Union to monitor the crisis and prevent its recurrence.

Representatives from the poultry sector explained that the current decline in supply is seasonal, and occurs each year between the start of winter and the reopening of schools. During this period, farms replace older, non-productive hens with new ones, which require one to one and a half months to reach full production. This leads to temporary reduction in availability. Production

is expected to return to normal levels by December 10, following the completion of the poultry renewal cycle. It was agreed to grant suppliers a grace period after this date for them to complete supply procedures.

The Ministry of Commerce and Industry and UCCS urged companies to submit clear plans to prevent a recurrence of the problem next year, and the companies assured that they will coordinate replacement operations to avoid simultaneous disruptions, especially among large producers, for ensuring stable

supply levels and preventing market gaps. It was highlighted that the suppliers compliance will be monitored regularly to ensure the continuous flow of required quantities and prevent any new shortages in the markets.

Meanwhile, Faisal Al-Ansari emphasized that the ministry is taking proactive measures to maintain the stability of essential

He stated that ensuring the availability of table eggs in adequate quantities at reasonable prices is a top priority and affirmed that any actions threatening market stability or creating artificial shortages will not be tol-

Al-Ansari noted that inspection teams monitor companies daily to ensure full compliance with pricing regulations.

He stressed that the ministry is prepared to take immediate action against any entity that violates pricing decisions or disrupts

For her part, First Vice President of the Tunisian Court of Accounts and ARABOSAI Deputy Secretary-General Fadhila Gargouri, highlighted the organization's efforts in recent years to enhance cooperation among member institutions, strengthen shared work mechanisms, and support the achievement of sustainable development goals.

She stressed the importance of expanding partnerships with the International Organization of Supreme Audit Institutions (INTOSAI) and peer organizations to advance audit quality in Arab countries.

Meanwhile, President of Egypt's Central Auditing Organization and President of the INTOSAI Counselor Mohammad Al-Faisal, said the assembly serves as a distinguished professional platform that embodies Arab cooperation in public

"Some of the wealthy and affluent in Kuwait have a rare hobby, one that is not shared by other wealthy individuals around the world. Their favorite pastime is to harass the poor, the working class, and the middle class of Kuwaiti society," Kuwaiti writer Hussein Al-Rawi

wrote for **Al-Seyassah** daily. "Recently, a Kuwaiti economic expert emerged to call for an end to the financial aid provided to university students. He went on with his so-called reform project by demanding the elimination of subsidized food items that thousands of families rely on. The issue was not the proposal itself, as differences over economic policies are perfectly legitimate, but rather the way it was presented. It was the kind of absurdity that drifts out from the windows of historic palaces when their inhabitants speak about the hunger of the poor. This wealthy individual seemed perplexed as to why ordinary citizens eat state-subsidized meals and why students receive assistance that enables them to complete their studies.

'These are questions typically asked only by those who have lived far removed from the struggles of ration-card holders, far from the families who depend on subsidized basic goods, and who know nothing of the reality faced by a student whose family works tirelessly to help him finish his studies, only for him to later seek a low-paying job to ease the financial burden. There is nothing wrong with discussing the effectiveness of government subsidies, but the problem arises when the discussion is carried out with cold indifference, without considering the plight of the citizen who thinks twice before purchasing the cheapest item, or the student who counts every dinar just to continue his education.

"The problem is when economic discourse turns into a moral guillotine, used by the affluent to strike at others simply because they have grown accustomed to luxuries that others do not have. The strangest thing about some of the wealthy is that they only feel the pleasure of wealth when the poor are deprived of their most basic needs. May God protect His Highness the Amir, the leader. May God protect our country and spare us from the evil of every miserable person who finds satisfaction only in humiliating others.'

"During the 1967 war, Ahmed Saeed, a broad-caster on the "Voice of the Arabs" radio station, claimed from the very first moment the fighting began that the Arab armies had advanced into specific areas of Palestine, captured thousands of Israeli soldiers, and made other similar statements that, six days later, proved to be entirely false propaganda. As a result, the Arabs are still dealing with the consequences of that aggression today, as is often the case in the Arab world," columnist Eng. Adel Al-Jarallah Al-Kharafi wrote for Al-Seyassah daily.

"I began with this introduction because numbers are not fiction, and the accuracy of figures is essential for building studies that reflect people's daily lives, particularly when the goal is to show the extent of specific damage inflicted on a particular country. Exaggeration only fuels public anxiety, while transparency is the only remedy, because the ultimate aim must always be the truth.

"When any figures are published in the media, they are taken seriously. It is standard practice in Western media, and in much of the Arab media, to verify data and consult specialists before broadcasting reports containing numbers, in order to avoid errors that could lead to sensationalism. People want the truth so they can form informed opinions. Therefore, official data leaves no room for exaggeration or myths. A few days ago, I came across exaggerated figures regarding the cost of education and healthcare borne by the state for certain individuals whose citizenship, obtained fraudulently, had been revoked. These figures contradict official reports, which estimate the cost of healthcare per citizen at approximately KD 499, and education at around KD 500 to
KD 2,200 annually.

"If we study the fig-

ures recently circulated, claiming that the state has spent four trillion dinars on education and healthcare since the liberation of Kuwait, we can easily see that these numbers are incorrect and unrealistic. Considering the average national income of approximately 25 billion dinars annually, the total

since liberation does not exceed 750 billion dinars. From this, it is clear that the circulated figures have no basis in reality and are intended solely to provoke public opinion. This benefits neither society nor the state. Undoubtedly, it also raises questions about the accuracy of other figures being circulated.

"My point is that transparency is essential when it comes to figures, indicators, and other data. People have the ability to research and understand the facts. Errors in published numbers do not serve the public interest. If the figures released last week are accurate, they point to a serious problem. But if they are merely rough estimates not based on actual statistics, then this is nothing more than unwarranted sensationalism.

Drug use spirals: lawyers

KUWAIT CITY, Dec 2: A number of legal experts praised the comprehensive awareness campaign launched by the Public Prosecution and the Ministry of Interior ahead of the implementation of Decree-Law No. 159/2025 on combating drugs and psychotropic substances and regulating their use and trafficking.

In this regard, Lawyer Inaam Haidar affirmed that the new law represents a huge leap in legislative policy against drugs, particularly in light of the rise in drug use and trafficking cases in recent years.

She explained that the harsher penalties are intended to deter anyone attempting to threaten societal security or exploit youth, as well as provide users with the opportunity to recover through treatment and rehabilitation programs that consider human and familial

KUWAIT CITY, Dec 2: The Court of Cassation has adjourned to January 26, 2026, the hearings of two embezzlement cases involving public funds in the Ministry of Interior and the Ministry of Defense, in which former Minister of Interior and Defense Sheikh Talal Al-Khaled is accused.

This decision to adjourn the cases was made after the court heard arguments from Sheikh Talal Al-Khaled's defense team.

Install gas, smoke detectors to prevent fire accidents

KUWAIT CITY, Dec 2: The Director of Public Relations at the Kuwait Fire Force (KFF) Brigadier General Mohammed Al-Gharib affirmed that KFF prioritizes prevention and safety to protect lives and property, reports Al-Rai daily.

He emphasized that following simple preventive measures can significantly reduce the number of accidents.

Brigadier General Al-Gharib stressed the need to install gas and smoke detectors in

homes, describing them as an effective tool for early detection of leaks that could lead to serious accidents.

He stressed the importance of closing the gas cylinder valve after each use and regularly inspecting the pipes to ensure they are intact and free from damage or cracks.

Brigadier General Al-Gharib emphasized the need to store the cylinder in a safe location, away from heat sources and open

In the event of a suspected leak, he advised evacuating the premises immediately, opening windows and doors for ventilation, and avoiding the use of electrical appliances or lighting any fires.

Brigadier General Al-Gharib highlighted the importance of keeping a fire blanket or suitable fire extinguisher at home and training family members on their proper use.

Kuwait tackles corporate gaps after revocations of citizenship

Plan aims to protect remaining partners

KUWAIT CITY, Dec 2: The practical experience of citizenship revocation cases, particularly those involving forgery, has revealed procedural challenges in companies where the affected individuals hold shares, impacting the rights and status of the remaining shareholders, reports Al-Rai daily.

Officials at the Ministry of Commerce and Industry are coordinating with relevant authorities, primarily the Ministry of Justice, to develop legal and procedural solutions that protect the interests of the remaining shareholders and prevent any negative effects on their financial and legal standing.

In this context, informed sources explained that the Ministry of Commerce and Industry recently received inquiries from owners of unlisted companies whose Kuwaiti citizenship was revoked due to forgery related to strategic shareholdings. These owners requested that the ministry develop procedures to resolve their cases, ensuring the renewal of their commercial licenses and the uninterrupted flow of funds to and from the company's accounts, as any disruption could negatively affect liquidity generated from the company's operations.

Among the cases under legal and procedural review by the ministry are companies where non-Kuwaiti shareholders hold approximately 49 percent of the shares, while the remaining 51 percent are owned by individuals whose Kuwaiti citizenship was revoked due to forgery. Although the 49 percent shareholders hold a general power of attorney for the affected partner, and one of them serves as the company's general manager, they face legal and procedural obstacles in renewing the commercial license and in implementing the process to replace the partner whose citizenship was revoked. This is due to the regulations of the Ministry of Justice, as the individual being removed is on a blacklist, preventing the disposal of any of his assets, including cash, company shares, or other funds.

The sources said, "Since the entry of new partners and the exit of existing ones requires official documents proving the eligibility of the partner and the consent of all parties, the 49 percent shareholder faces obstacles in removing the partner whose citizenship has been revoked or dissolving the partnership. This limits the ability of the remaining shareholders to fill the power gap necessary to ensure the company's continued operation at the same level of efficiency and to prevent potential legal disputes with the partner or the state. The general power of attorney issued in the name of the partner whose citizenship has been revoked is no longer valid with the Ministry of Justice. Consequently, the company's shareholders face challenges in renewing the commercial license, as the law requires a Kuwaiti partner holding 51 percent of shares, a requirement that cannot be fulfilled while the partner whose citizenship was revoked remains under a legal block.'

The sources indicated that officials of the Ministry of Commerce and Industry are exploring potential legal solutions to this unprecedented issue, which current company law does not adequately address, adding that the situation reflects recurring cases and therefore requires a proper procedural mechanism to protect the rights of all parties, including the state.

The sources explained that one proposal under consideration is to suspend the shareholder whose citizenship has been revoked, effectively freezing their share, while allowing the remaining owners to continue managing the company. These owners would assume responsibility for their decisions and protect the company's interests, as they currently hold a majority enabling them to operate the business.

Alternatively, authorities could permit the revoked partner to withdraw their share and appoint a guardian for the transferred share until a decision is made by the relevant authorities, whether for liquidation or continued freezing. During this period, a mechanism would be established to regulate the entry and exit of funds from the company's accounts, preventing circulation in cash or personal transactions and minimizing the risk of payment defaults that could adversely affect the company's financial stability and the interests of its shareholders.

One of the initial scenarios under discussion involves allowing the relevant state authorities to offer shares in companies, whose ownership was affected by citizenship revocation due to forgery, through a public auction. The proceeds from such sales would be allocated to the state treasury. This approach would protect the state's rights while simultaneously preserving the financial and legal standing of the remaining shareholders.

The sources emphasized that all these scenarios are preliminary proposals, and any action would require Cabinet approval, as it is the body responsible for authorizing mechanisms for handling citizenship revocation cases.

They clarified that the Ministry of Commerce and Industry and the Ministry of Justice would serve as the executive bodies tasked with implementing Cabi-

After October 7 attack

THE impact of the October 7 attack on Israel is difficult to overstate, as it affected the state itself, the perception of Jews both within and outside Israel, and the global image of Zionism, particularly in the United States.

Despite centuries of European anti-Semitism, there were periods when

Jews were regarded as victims deserving of compassion and protection. For generations, Jews admired were for their material success or intelachievements. Yet never in their more than three-thousand-



year history has the image of the Jewish people been so heavily tarnished as it has in the past two years, after many came to recognize the threat that Zionism poses, not only to the Palestinian and American peoples but to humanity as a whole.

The events of October 7th shattered long-held narratives and prompted a shift in the thinking of prominent leaders, philosophers, politicians, artists, thinkers, and media figures. These events lifted the veil from their eyes and freed them from the fear of being labeled antisemitic. The impact of October 7th even reached the heart of the Jewish community and those living outside Israel. Tucker Čarlson, the well-known American media personality and former far-right figure, was among the prominent voices that Zionism lost. The same was true of British journalist Piers Morgan, who, along with Carlson, played a significant role in raising public awareness in their respective countries.

Their positions helped deepen the divide now affecting the conservative, pro-Zionist movement, particularly among those aligned with former President Trump. His meeting with young American right-wing influencer Nick Fuentes had a notable impact, further widening the rift within the conservative movement. Both emphasized prioritizing American interests over those of Israel, arguing that Israel is irrelevant, a stance in stark contrast to the views of Trump and all his predecessors. Carlson described Israel as a country of no strategic importance and a burden on the United States.

Carlson expressed his bewilderment at the backlash over his hosting of Fuentes, saying he didn't understand what was so controversial about his guest. Conservative commentator Ben Shapiro, an Orthodox Jew, labeled Fuentes as antisemitic.

What surprised many during Carlson's interview with Fuentes was his apparent indifference to his guest's extreme views, including Holocaust denial, admiration for Adolf Hitler, and disdain for Black people, particularly the American Vice President's wife, who is of Indian descent.

Even when Fuentes expressed admiration for Joseph Stalin during the interview, Carlson merely suggested moving on without addressing it. He also remained silent when Fuentes voiced concerns about organized Judaism in America. Carlson had previously mocked the concept of "God's chosen people."

Ultimately, the interview marked, in many ways, the culmination of Carlson's growing antagonism toward Israel, a country he had long defended staunchly, and toward his fellow conservatives.

Carlson, along with dozens of others who champion similar causes, has gained significant influence over public opinion in many countries. Their positions have caused Israel considerable concern, especially as journalist and influencer Megyn Kelly has expressed support for Carlson while criticizing his detractors, including Shapiro and Mark Levine. President Trump and his vice president continue to maintain friendly ties with Carlson.

As for the third objective, it involves the corporation's participation, through its sub-sidiary Kuwait Gulf Oil Company, in a joint venture with Saudi Arabia to develop the Al-Durra offshore oil field. The fourth objective focuses on expanding

petrochemical activities through the Petrochemical Industries Company (PIC), which holds substantial investments both locally and internationally. PIC holds a 100 percent stake in the Kuwait-Vietnam Petrochemical Company and has acquired shares in more than eight companies operating in various petro-chemical sectors in South Korea, Bahrain, and several other countries.

The fifth objective is to expand the capacity of both local and international refineries, particularly in light of the steadily rising global demand for petroleum products.

It is worth noting that Kuwait's OPEC+ quota increased by 37,000 barrels per day over the past three months, according to an official document. The quota stood at 2.492 million barrels per day in August, rose to 2.515 million barrels per day in September, and further increased to 2.552 million barrels per day in

This increase is expected to positively impact the profits of KPC, which declined to KD 1.365 billion in the 2024/2025 fiscal year, compared to KD 1.46 billion in 2023/2024. KPC's annual profits had surged in 2022/2023, reaching KD 2.6 billion.

The sources attributed the fluctuation in the corporation's profits in recent years to

the OPEC+ decision to reduce the quotas of the 23 member countries in 2023, which Kuwait complied with, followed by voluntary cuts implemented by eight countries, including Kuwait. They stressed that the reduction in Kuwait's quota played a major role in the corporation's profit fluctuations, particularly given the significant contribution of oil revenues to the state budget as a whole.

The government

One of the most important benefits of entertainment is its ability to create jobs for citizens. It also stimulates increased consumer spending and encourages investment in vital infrastructure and related sectors such as hospitality and food services.

Kuwait must embrace investment strategies that have already proven successful internationally, as these models can be easily replicated domestically. Keeping pace with global developments is essential.

Furthermore, diversifying sources of income is no longer a matter of choice but an imperative, given the inherent risks of depending on a single revenue stream.

Therefore, to strengthen the national economy, the government should prioritize harnessing local investment opportunities rather than allowing national resources to be drained by overseas

Kuwait is in a strong economic position, supported by its profitable sovereign wealth funds and other local investment resources. These resources can be strategically deployed to launch a variety of projects, including service, agricultural, industrial, and entertainment ventures, which would boost the local economy and enhance regional competitiveness.

Kuwait empowers

While participants agreed on the Real Estate Authority's importance in regulating housing and real estate activities, the discussion highlighted a clear divergence of opinions regarding its role in shaping visions and establishing procedures for real estate developers.

Some viewed it as essential for the project's success, while others stressed that existing law already empowers the Public Authority for Housing Welfare (PAHW) to issue licenses and undertake related actions.

In this regard, Deputy Director General for Investment and Private Sector Proiects at PAHW Eng. Ahmed Al-Ansari explained that the authority has worked to transfer most risks beyond the investor's control to the state, while guaranteeing the rights of investors and financiers.

He explained that PAHW is currently focused on enhancing its performance and expanding its investor base both locally and internationally, drawing on successful experiences from other Gulf Cooperation Council (GCC) countries within a framework tailored to the Kuwaiti market. It has signed agreements with four international companies, each possessing strategic, technical, financial, and legal expertise gained through previous experience in other Gulf countries.

It recently launched three investment packages, comprising 5,000 residential units in the cities of Al-Mutlaa, Saad Al-Abdullah, and Jaber Al-Ahmad, as part of its efforts to strengthen partnerships with the private sector as a development

Al-Ansari indicated that the Real Estate Developer system is an optional track running parallel to the traditional method of providing plots to citizens, not

He stressed that residential lands in South Saad Al-Abdullah and South Sabah Al-Ahmad are still under development and distribution.

He highlighted that PAHW is working on transforming government lands into development projects through advanced partnership contracts, engaging consulting firms with proven Gulf experience, adding that these contracts help minimize risks for the private sector while ensuring clear obligations and responsibilities.

Meanwhile, Chairman of the Real Estate Union Ibrahim Al-Awadhi provided a detailed analysis of the ongoing housing transformations, emphasizing that the concept of a real estate developer differs fundamentally from that of a contractor.

He explained that a developer assumes responsibility for the entire project, from design and execution to construction, financing, sales, and management, whereas a contractor's role is limited to executing the construction work without bearing any financial risk.

In traditional housing projects, the government pays contractors the contract value in exchange for execution. In contrast, the real estate developer model relies on the developing company to finance the project independently, without imposing a direct financial burden on the government

The shift to the real estate developer system emerged in response to rising housing demand and the government's inability to keep pace. Currently, there are approximately 105,000 housing applications, a number projected to increase to 197,000 over the next ten years.

Real estate companies possess greater speed and efficiency in completing projects. The current trend extends beyond local firms to include foreign companies, which are already being attracted through established qualification mechanisms and approved pathways.

Al-Awadhi emphasized that the Real Estate Union played a fundamental role in drafting the 2023 law and its 2025 amendment in collaboration with

He highlighted that the current legislation represents an important transitional step, with practical experience serving as the ultimate guide for evaluating and developing any law.

Regarding the financing mechanism, Al-Awadhi explained that while the details are not yet fully defined, there is a clear direction toward two main channels through the Kuwait Credit Bank and through commercial banks, in tandem with the anticipated approval of the mort-

In response to concerns about rising prices, he said, "The law is not the cause of increasing costs. The real issue is the scarcity of projects, not the financing

mechanisms. Regarding the relationship between the Real Estate Authority and developers, Al-Awadhi emphasized that while the authority plays a vital role in regulating Kuwait's real estate market, it is not directly tied to the developers.

He explained that the law grants the authority full responsibilities, including obtaining approvals and issuing licenses. However, the main challenge facing the real estate sector is the absence of a comprehensive database and the essential information required to make informed

In addition, Lawyer Abdullah Al-Bakr emphasized the importance of the ongoing discussion about real estate developers following the 2025 law amendment. He noted that international experienc-

Kuwait should capitalize on. Lawyer Al-Bakr expressed his full support for establishing a Real Estate Authority to assist developers, stressing that specialization and centraliza-

es present significant opportunities that

He highlighted the need for a single entity responsible for issuing licenses, providing information, and protecting the interests of all stakeholders.

Lawyer Al-Bakr praised the authority's role as a partner, regulator, and overseer, asserting that the recent amendments have marked a qualitative leap in the real estate development sector.

GCC forms committee to fight money laundering

Al-Budaiwi outlines 2026-30 security strategy

KUWAIT CITY, Dec 2, (KUNA): GCC Secretary General Jassem Al-Budaiwi said Tuesday the bloc established a committee tasked with implementing the 2026-30 security strategy to combat money laundering, whose mandate would be based on five pillars.

The committee's operation will be based on legislation and security policies, joint investigations and security operations, technology and security analysis, international security cooperation and coordination, and training and building capabilities, he said.

Al-Budaiwi, in an interview with Kuwait News Agency (KUNA), said the committee would oversee the strategy's implementation and monitor performance in cooperation with the Secretariat's statistical center.

The strategy is part of collective efforts aimed at cracking down on terrorism and terrorism financing.

Al-Budaiwi said the Gulf Cooperation Council was bound to high-level security cooperation and coordination, citing formation of a committee designed to fight terrorism. This committee, he added, has a mandate of preparing leg-

islation, anti-terrorism plans, proposing training programs, participate in regional and international conferences and exchange visits between anti-terrorism experts. This is in addition to a 2010 strategy to fight extremism

associated with terrorism, all with the aim of eliminating violence, extremism, crime and ideologies The security cooperation amongst the GCC countries also

includes a unified electronic system that links traffic violations. "This project increased awareness among drivers which resulted in a decline in accidents," said Al-Budaiwi, adding that Gulf Traffic Week aimed at raising awareness of roads users.

Meanwhile, Al-Budaiwi said the upcoming GCC summit, due in Bahrain tomorrow, would be held amidst "critical and accelerated" developments in the Gulf and Middle East regions, which reflect importance of the high-level meeting. He said cooperation among the Gulf countries was an exam-

ple to follow in terms of integration, development and progress. "We witnessed the solid and wise decisions by the GCC countries during crises, and see how the member countries exert efforts to achieve common objectives," he said.

Al-Budaiwi said the Bahrain summit would discuss the Israeli occupation's aggression on Qatar, the Iranian nuclear program, free navigation and maritime security in the Gulf vaters and the Red Sea.

"We reaffirm importance of compliance with the UN Charter, international conventions, good neighborliness principles, respect of sovereignty of countries and non-interference in their domestic affairs, peaceful resolution of conflicts and not to use force of threaten to use force," he said.

Al-Budaiwi also called for rallying regional and international efforts to reach a comprehensive solution for the Palestinian cause in a way ending the grave violations against the civilians and preserve legitimate rights of the Palestinian people, foremost establishing an independent and viable state in line with the Arab peace initiative, UN resolutions and two-state solution on the June 4 1967 borders and East Jerusalem as its capital. On the other hand, Al-Budaiwi said the GCC sought to

enhance cooperation with other countries and organizations. The GCC held meetings with the European Union in October 2024, the US in May 2025, the ASEAN on one side and the GCC-ASEAN-China on the other last May. "These summits aim at cementing cooperation between

wider horizons. The GCC summit will discuss the outcome of these meetings, in addition to challenges, crises, global Al-Budaiwi, meanwhile, gave detailed answers over con-

the Gulf and these countries and organizations towards

tributions of the GCC to addressing conditions in Syria, Lebanon and the Iranian nuclear file. The GCC acted shortly after collapse of the Syrian regime, he said, and held an urgent ministerial meeting on December

26, 2024 in Kuwait to coordinate positions regarding Syria. The ministers agreed to send Kuwait's Foreign Minister Abdullah Al-Yahya, accompanied by Al-Budaiwi, to Syria and Lebanon to convey messages of solidarity and assess immediate needs of the two countries.

Four days later, Al-Yahya and Al-Budaiwi met with Syrian leader Ahmad Al-Sharaa, Foreign Minister Asaad Al-Shaibani and Intelligence chief Anas Khattab in Damascus to convey a message of solidarity with Syria and its people during the critical transition period.

Al-Budaiwi said they reaffirmed support to Syria's sovereignty and independence, and their readiness to extend support at political, economic, development and humanitarian

The GCC has ever since been discussing the Syrian issue in all its meetings and other meetings with regional and international partners, with the aim of supporting the Syrian government. The Gulf bloc intensified efforts to lift sanctions to enable economic recovery.

The "GCC believes Syria's stability is a strategic interest for the Middle East because it helps restore control of cross-border threat, drug smuggling and terrorist groups, while there are promising investment opportunities that the private sector and investment institutions could benefit from," he said.

Al-Yahya and Al-Budaiwi visited Beirut last January and met with the Lebanese political leadership, reaffirmed support to Lebanon's sovereignty, security, stability and territo-

The message the GCC conveyed to the Lebanese leaders that political and economic reforms were essential because they would help the country overcome its political and economic crisis. Lebanon should also not be a launch pad for terrorism and drug smuggling, affirmed Al-Budaiwi.

"We made it clear for the Lebanese leaders that it is important to implement UN Security Council resolution on Lebanon, especially resolution 1701, and the Taef agreement to restore security and stability.

Regarding Iran's nuclear file, Al-Budaiwi reiterated importance of continuing "constructive" negotiations to reach a comprehensive solution for this file, that the negotiations should include issues of concern to the GCC, need of the GCC's participation in relevant regional and international meetings, and that Tehran and the International Atomic Energy Agency should cooperate in a constructive spirit.

The GCC, said Al-Budaiwi, sought to boost confidence among all parties to achieve regional and international stability, citing the important role of the 5+1 group in achieving this goal despite the US withdrawal from the Iranian nuclear agreement in 2018. The Gulf Cooperation Council (GCC) countries are work-

ing on different fronts to further boost their economies, from connecting the six members by railroad, diversifying income, attracting foreign investments, which would eventually create more jobs for citizens, the bloc's chief said. "The railroad is one of the major joint Gulf projects and

has been progressing at different levels, as some members completed the tracks within their territories like the UAE and Saudi Arabia, and other countries are working on finalizing the necessary technical procedures," Secretary General Jassem Al-Budaiwi said Tuesday. Al-Budaiwi, in an interview with Kuwait News Agency

(KUNA), said the railroad project, scheduled to be operational by December 2030, would facilitate inter-GCC trade, create jobs, help domestic support industries, attract foreign investment, involve private sector and reduce highways maintenance cost. He said the train service was expected to carry around six

million passengers by 2030 and eight million in 2045. "This

will certainly contribute to increasing transport among the GCC countries, especially alongside huge investment in the tourism sector," he added.

Asked about the so-called "one-stop" travel system, Al-Budaiwi explained it allowed Gulf nationals to travel from one Gulf country to another without needing to pass through immigration counters at arrival points because passengers

would be identified by facial recognition cameras. The passengers, he added, who would walk through a special lane for the Gulf trips, could immediately head to collect his/her luggage and leave the airport.

"The advantage is reducing pressure on immigration counters and contributing to the smooth flow of passengers, reducing waiting time for passengers and making them hap-

py," said Al-Budaiwi.

This project would be implemented in phases, he said, and all Gulf citizens and expatriates would benefit from it.

Asked about reducing dependency on oil and diversifying income, Al-Budaiwi said the six-member GCC saw big progress towards diversifying income based on "ambitious visions and wide-scale economic reforms.'

These efforts, he went on, boost non-oil sectors, which contributed to 76 percent, or USD 1.7 trillion, to the GCC gross domestic product (GDP) in 2024, driven by noticeable growth in tourism, logistical services, technology, renewable energy and manufacturing industries. The GCC countries, he said, also improved their invest-

ment and entrepreneurship environments, as well as the role of the private sector. Despite progress in economic diversification, he said, oil would remain a key component in world energy security and stability. Al-Budaiwi also said the GCC made large strides towards renewable energy and green economy, as the region was witnessing huge solar and wind projects, considered among the biggest worldwide, like Mohammad bin Rashed Solar

Shaqaya solar energy park in Kuwait, as well as other ventures in Qatar and Bahrain. Arab Gulf countries adopted strategies aimed at improving energy efficiency, reducing emissions and increasing clean energy contribution, he said, making the GCC a driv-

Asked about compliance with the UN Sustainable Development Goals (SDGs) (2015-30), Al-Budaiwi said the GCC achieved 80-90 percent of the health and education goals, with over 70 percent compliance with other SDGs in the past He cited the 2025 global sustainable development report

which indicated that Gulf countries' compliance with SDGs was above average regarding clean energy (SDG Seven), innovation and industry (SDG Nine), which was driven by renewable energy projects and economic diversification. The Secretary General said GCC improved education, re-

duced child mortality rate, expanded social protection programs, while major cities witnessed less emissions. Asked how youth empowerment contributes to economic and social development, Al-Budaiwi said it resulted in more productivity, boosted entrepreneurship, innovation, transition to knowledge-based and digital economy, in addition to

reducing dependency on foreign workers. Empowerment, he added, promoted social stability and sense of belonging, improved voluntary initiatives and quality of life. Youth empowerment is a strategic choice supported by

White House releases doctor's memo

'Trump had preventative screening MRI on heart, abdomen with perfectly normal results'

WASHINGTON, Dec 2, (AP): US President Donald Trump's doctor says the president had MRI imaging on his heart and abdomen in October as part of a preventative screening for men his age, according to a memo from the physician released by the White House on Monday.

Sean Barbabella said in a statement that Trump's physical exam included "advanced imaging" that is "standard for an executive physical" in Trump's age group. Barbabella concluded that the cardiovascular and abdominal imaging was "perfectly normal."

The White House released Barbabella's memo after Trump on Sunday said he would release the results of the scan. He and the White House have said the scan was "part of his routine physical examination" but had declined until Monday to detail why Trump had an MRI during his physical in October at Walter Reed National Military Medical Center or on what part of his body.

"I think that's quite a bit of detail," White House press secretary Karoline Leavitt said Monday when announcing the memo's release.

The Republican president said Sunday during an exchange with reporters as he traveled back to Washington from Florida that the results of the MRI were "perfect." "If you want to have it released, I'll release it," Trump said. Trump added Sunday that he has "no idea" on what part of his body he got the MRI.

Doctors typically order an MRI to help with diagnosing symptoms or to monitor an ongoing health problem. So-called "preventive" cardiac and abdominal MRIs are not part of routine screening recommendations. What Trump's doctor called an "executive physical" generally refers to adding extra, non-routine tests including MRIs to pricey and lengthy exams, not covered by insurance, that are marketed to wealthy people.

Gentile had reported to prison on Nov. 14, just days before Trump commuted his sentence, according to a White House official who requested anonymity to provide details of the clemency action. Gentile had been the CEO and co-founder of GPB Capital,

which had raised \$1.6 billion in capital to acquire companies in the auto, retail, health care and housing sectors.

He had been sentenced to seven years in prison after an August 2024 conviction for his role in what the Justice Department at the time described as a scheme to defraud more than 10,000 investors by misrepresenting the performance of three private equity funds.

But the White House official said GPB Capital had disclosed to investors in 2015 that their capital might go to pay dividends to other investors, which the White House said undercut claims that the company had engaged in a "Ponzi" scheme in which new investments are used to reimburse previous

WASHINGTON: US President Donald Trump's former personal lawyer Alina Habba is disqualified from serving as New Jersey's top federal prosecutor despite his administration's maneuvers

to keep her in the role, an appeals court said Monday. A panel of judges from the 3rd US Circuit Court of Appeals sitting in Philadelphia sided with a lower-court judge's ruling after hearing oral arguments at which Habba was present on Oct. 20.

"It is apparent that the current administration has been frustrated by some of the legal and political barriers to getting its appointees in place. Its efforts to elevate its preferred candidate for US Attorney for the District of New Jersey, Alina Habba, to the role of Acting US Attorney demonstrate the difficulties it has faced - yet the citizens of New Jersey and the loyal employees in the US Attorney's Office deserve some clarity and stability," the court wrote in

a 32-page opinion.

It concluded: "We will affirm the District Court's disqualification order.'

The ruling comes amid the push by Trump's Republican administration to keep Habba as the acting US attorney for New Jersey, a powerful post charged with enforcing federal criminal and civil law. It also comes after the judges questioned the government's moves to keep Habba in place after her interim appointment expired and without her getting Senate confirmation.

Schumer said in a statement that local law enforcement received bomb threats referencing his offices in Rochester, Binghamton and Long Island with



"Local and federal law enforcement responded immediately and are conducting full security sweeps," Schumer said. "Everyone is safe, and I am grateful for their quick and professional response to ensure these offices remain safe and secure for all New Yorkers.

A law enforcement source confirmed that Suffolk County police responded to Schumer's Long Island office but could not confirm the details of the threat. The person requested anonymity because the investigation is ongoing. The U.S. Capitol Police declined comment, saying they do not discuss member security for safety reasons.

Schumer said in the statement that "these kinds of violent threats have absolutely no place in our political

President Donald Trump lost the 2020 election to former President Joe Biden but has falsely claimed since then that it was "rigged" or "stolen." But courts dismissed or ruled against the campaign in dozens of lawsuits and the votes were certified by election officials in all 50 states. (AP)

Barnes enters Wisconsin gov race: Democrat Mandela Barnes, who served four years as Wisconsin's lieutenant governor and narrowly lost a 2022 U.S. Senate bid, jumped into the battleground state's open race for governor on

Given his prominent name recognition and statewide funding network, Barnes enters the 2026 race as the presumptive front-runner in a crowded primary of lesser known candidates who have no built-in network of support. Wisconsin is a politically divided state that elected President Donald Trump

in 2016 and 2024 and President Joe Biden in 2020. All three elections were decided by less than a percentage point.

The message in Barnes' campaign launch video will likely appeal to many Democratic primary voters. He highlights his father's union background and attacks Trump, saying the Republican has focused on "distraction and chaos to avoid accountability." He says Trump is focusing on "lower taxes for billionaires, higher prices for working people." (AP)

Navy admiral ordered follow-up strike on alleged drug boat: WH

WASHINGTON, Dec 2, (AP): The White House said Monday that a Navy admiral acted "within his authority and the law" when he ordered a second, follow-up strike on an alleged drug boat in the Caribbean Sea in a September US military operation that has come under bipartisan scrutiny.

White House press secretary Karoline Leavitt offered the justifi-

cation for the Sept 2 strike as lawmakers announced there will be congressional review of the US milistrikes against vessels suspected of smuggling drugs in the Caribbean

and the eastern Pacific Ocean. The lawmakers cited a published report that Defense Secretary Pete Hegseth issued a verbal order for a second strike that killed survivors on the

Navy Vice Adm. Frank "Mitch" Bradley, who Leavitt said ordered the second strike, is expected to provide a classified briefing Thursday to lawmakers overseeing the

military.

Leavitt in her comments to report-

ers did not dispute a Washington Post report that there were survivors after the initial strike. Her explanation came after President Donald Trump a day earlier said he "wouldn't have wanted that - not a second strike"

when asked about the incident. "Secretary Hegseth authorized Admiral Bradley to conduct these kinetic strikes," said Leavitt. "Admiral Bradley worked well within his authority and the law, directing the engagement to ensure the boat was destroyed and the threat to the United States of America was eliminated." Late Monday, Hegseth posted: "Admiral Mitch Bradley is an American hero, a true professional, and has my 100% support. I stand by him and the combat decisions he has made - on the September 2 mission and all others since.'

A month after the strike, Bradley was promoted from commander of Joint Special Operations Command to commander of US. Special Operations Command

Northeast preps for major snowstorm

The Northeast was getting ready Tuesday for its first major snowstorm of the season, just as the Midwest began to escape snow and ice that snarled travel after the Thanksgiving holiday. Some parts of northern New England were expecting up to 10 inches (25.4 centimeters) of snow. A windy, potentially icy storm was headed to the region and could soak some parts of the area's six states while piling snow in others, forecasters said.

The National Weather Service issued winter storm warnings and winter weather advisories in states including Massachusetts, New Hampshire,

Vermont, Maine, Connecticut and New York ahead of the snow's arrival. The winter blast is set to arrive days after more than 8 inches (20.32 centimeters) of snow fell at Chicago O'Hare International Airport over the weekend, setting a record for the highest single calendar day snowfall in November at the airport, according to the weather service. The previous record was set in 1951. Snow in the Great Lakes region was tapering off, but the new storm was heading to the mid-Atlantic and Northeast, with up to a foot (30 centimeters) of snow by Tuesday, said National Weather Service meteorologist Andrew Orrison. UK plans to scrap some jury trials in attempt to clear court backlog

LONDON, Dec 2, (AP): The right to trial by jury will be pared back in Britain in an attempt to clear a backlog of cases clogging up the justice system, the government announced Tuesday.

Justice Secretary David Lammy said overload and delays had created "an emergency in our courts" that risks collapsing trust in British justice.

The UK court system has struggled to clear a backlog of cases built up since the COVID-19 pandemic. The government says there are almost 80,000 cases waiting to be heard in criminal courts in England and Wales, more than double the pre-pandemic figure, with some cases taking several years to reach trial.

Under the changes, crimes with a likely sentence of three years or less will be tried before a judge alone, up from the current two years. Judges will also be able to sit without a jury in some complex fraud and financial

Magistrates, who handle less serious offenses, will be able to impose sentences of up to 18 months, rather than the current 12 months, allowing them to handle more cases.

The changes apply to England and Wales. Scotland and Northern Ireland have separate judicial systems.

Lammy said the reforms would de-

liver swifter justice for victims. 'We're all proud of our justice system rooted in the Magna Carta, but we must never forget that it implores us not to deny or delay justice," Lammy told lawmakers in the House of Commons. "When victims are left waiting for years, justice is effectively denied to them.

He said the changes would reduce by about a quarter the number of cases heard by juries, but that "jury trials will continue to be the cornerstone of the system for the most serious of offenses," including murder, manslaughter, rape, serious assault and robbery.

US envoy Witkoff to meet Putin in Moscow

MOSCOW, Dec 2, (AP): US special envoy Steve Witkoff was due to meet with Russian President Vladimir Putin in Moscow on Tuesday, taking to the Kremlin an embryonic peace plan that Washington hopes can bring about an end to the nearly four-year war in Ukraine. Coinciding with Witkoff's trip,

Ukrainian President Volodymyr Zelenskyy went to Ireland, continuing his visits to European countries that have helped sustain his country's fight against Russia's invasion.

After months of frustration in his efforts to stop the fighting, US President Donald Trump is deploying officials to get traction for his peace proposals.

Jared Kushner, Trump's son-in-law, will join the meeting between Putin and Witkoff, Kremlin spokesman Dmitry Peskov told reporters. He said that the talks would take "as long as needed" and will involve only Witkoff, Kushner and an interpreter from the

U.S. side. So far, the talks have followed parallel lines, with US Secretary of State Marco Rubio sitting down with Ukrainian officials, and now Witkoff heading to Moscow.

Australia govt releases nat'l Al plan

CANBERRA, Dec 2, (Xinhua): The Australian government on Tuesday released a national plan to give guidance to industry, researchers, governments and the public on how to safely and beneficially use artificial intelligence (AI).

Under the National AI Plan, the government says it will prioritize supporting and reskilling workers whose roles are affected by AI, boost investment in data centers and share the productivity benefits of AI across the economy.

Tim Ayres, the minister for industry and innovation and minister for science, said that the plan would keep Australians safe as AI technology continues to evolve. From 2026, a new government-funded AI Safety Institute announced by Ayres in November will be responsible for evaluating emerging AI capabilities and supporting timely responses to address potential risks.

Lee orders full probe into HK residential fire

HONG KONG, Dec 2, (Xinhua): The Hong Kong Special Administrative Region (HKSAR) government will set up an independent commission chaired by a judge to conduct a thorough investigation into the recent residential fire and ensure full accountability for those responsible, John Lee, HKSAR chief executive, told reporters on Tuesday. The fire has claimed 151 lives and injured 79 people, said Lee, adding that the police are following up on approximately 30 remaining cases of missing individuals.

Three task forces established earlier are working relentlessly to pursue accountability, investigating all relevant parties and leaving no responsible person unpunished, Lee noted.

He emphasized that the HKSAR government is sparing no effort to support those affected. Measures include activating temporary shelters and arranging for some 2,500 people to take up temporary residence in transitional housing and hotels in phases.

The chief executive pointed out that the blaze has exposed failures across multiple links, making systemic reforms imperative. An independent commission will be set up to probe the fire, Lee said, adding that the HKSAR government will

provide all necessary data and other support required for the investigation, and the commission will submit recommendations and reports to him.

Meanwhile, Secretary for Labor and Welfare of the Hong Kong Special Administrative Region (HKSAR) government Chris Sun said on Tuesday that 10 foreign domestic helpers were killed and three others were injured in a major residential fire that broke out on Nov. 26 in Tai Po.

Sun told a press briefing that each of the foreign domestic helpers who died in the fire will receive about 800,000 Hong Kong dollars in compensation, including statutory compensation and one-off assistance.

'Hidden forces of insurrection should be revealed'

South Korean president proposes restoring communication channels with DPRK

SEOUL, Dec 2, (Xinhua): South Korean President Lee Jae Myung on Tuesday proposed restoring communication channels with the Democratic People's Republic of Korea (DPRK), according to the presidential office.

Lee made the remarks at the inauguration ceremony of the 22nd Peaceful Unification Advisory Council, which advises the president on unification issues, stressing that reviving the inter-Korean dialogue, suspended for seven years, will be the starting point for new inter-Korean relations of peaceful coexistence

He said inter-Korean meetings should begin to prevent accidental military clashes, resolve the sufferings of people caused by the divided Korean Peninsula and discuss various pending issues between the two sides, proposing the restoration of inter-Korean communication channels for the resumption of frank dialogue.

The president, who serves as chairman of the council, noted that the two sides can gradually start with inter-Korean exchange and cooperation projects in areas such as climate and environment, disaster and safety, and public health and medical services. Lee emphasized that his government will continue efforts to end the state

peace, vowing to end hostility and confrontation between the two Koreas and create new inter-Korean relations of peaceful coexistence. The peninsula technically remains in a state of war as the 1950-53 Korean

of war on the peninsula, pursue a nuclear-free peninsula and establish lasting

War ended with an armistice, not a peace treaty. Meanwhile, Lee Jae Myung said Tuesday that the forces of insurrection hidden in every corner should be fully revealed to truly open the door to a just

of insurrection are left unchecked, they will surely recur someday. Lee, who took office on June 4 through a snap presidential election, said his government will award meaningful certificates, such as commendations,

to people who joined in stopping the martial law and draw up measures to remember people's efforts and the spirit of popular sovereignty for genera-

Lee's approval rating rose 2.1 percentage points from a week earlier to 71.1 percent last week, a weekly poll showed Monday.

The negative assessment on Lee's conduct of state affairs declined 1.9 percentage points to 27.9 percent, according to computer assisted telephone interviewing (CATI) by local pollster Flower Research.

The ruling liberal Democratic Party's support advanced 1.6 percentage points to 56.2 percent, while the conservative opposition People Power Party's approval score decreased 4.5 percentage points to 24.5 percent.

Support rate for both the minor left-leaning Rebuilding korea Party and the minor rightist New Reform Party logged 2.8 percent last week. The pollster's separate survey of automated response system (ARS) showed

that Lee's approval rating edged down 0.2 percentage points to 61.9 percent last week compared to the previous week.

The CATI and the ARS surveyed 1,002 and 1,007 voters each from Friday to Saturday. The polls had plus and minus 3.1 percentage points in margin of error with a confidence level of 95 percent.

Hundreds flee gunfire, burning homes

Gangs launch large-scale attack in Haiti

SAINT-MARC, Haiti, Dec 2, (AP): Heavily armed gangs attacked Haiti's central region over the weekend, killing men, women and children as they set fire to homes and forced survivors to flee into the darkness.

Police made emergency calls for backup, asserting that 50% of the Artibonite region had fallen under gang control after the large-scale attacks targeting towns including Bercy and Pont-Sondé.

"The population cannot live, cannot work, cannot move," one of Haiti's police unions, SPNH-17, said Sunday on X. "Losing the country's 2 largest departments - West and Artibonite - is the greatest security failure in modern Haitian history

The bulk of Haiti's police force and the Kenyan officers leading a UNbacked mission to help repel gangs are in the capital, Port-au-Prince, which itself is largely held by gangs.

Guerby Simeus, a Pont-Sondé official, told The Associated Press by phone on Monday that he had confirmed nearly a dozen deaths, including a mother and her child and a local government employee.

"The gangs are still in Pont-Sondé,"

he said, noting that no additional police had arrived.

Many survivors fled to the coastal town of Saint-Marc, where hundreds of angry people on Monday demanded that the government take action against gangs who have repeatedly attacked Haiti's central region.

"Give me the guns! I'm going to fight the gangs!" said Réné Charles, who survived the attack. "We've got to stand up and fight!"

The crowd tried to break into the mayor's office with one unidentified man telling the AP that they weren't going to rely on the government any longer: "We're going to take justice into our own hands!"

Charlesma Jean Marcos, a political activist, said the gang announced last week that they were going to invade the area, and that they alerted authorities to no avail.

"For now, the only people really fighting (the gang) is the self-defense group," he said. "A country cannot run

Marcos urged all the survivors sleeping on the street and in public parks to instead sleep inside police stations and government offices until the government can take back Arti-

"A lot of people are going to be hungry," he warned. "We can support you today, we can support you tomorrow, but we won't be able to support you forever.'

Talks with Guinea-Bissau coup leaders to continue: ECOWAS

A delegation from the West African regional bloc known as ECOWAS made no headway in talks Monday with coup leaders in Guinea-Bissau, but said at the end of its visit that discussions would continue later this month.

The ECOWAS mission, led by its chairman, President of Sierra Leone Julius Maada Bio, came to Guinea-Bissau to appeal to the military - which seized power last Wednesday - for a "complete restoration of constitutional order."

The coup came three days after a closely contested presidential election which the two main contenders claim to have won.

Sierra Leone's Foreign Minister Timothy Musa Kabba described the discussions as "fruitful" and said both sides "expressed their different concerns." The ECO-WAS chairman condemned the coup while the military said it was necessary to "to restore order and security."

Trump weighs options on Venezuela after Maduro reportedly refuses to step down

WASHINGTON, Dec 2, (Xinhua): US President Donald Trump on Monday evening met with his top national security advisors at the White House Oval Office to weigh next steps, including potential land attacks on Venezuela.

According to media reports, Trump set last Friday as a deadline for Venezuelan President Nicolas Maduro to relinquish power and leave the oil-rich South American country with his family during a phone call between the two on Nov 21, but Maduro refused to comply

During the phone call, Maduro declined the ultimatum, demanding "global amnesty" for himself and others, according to reports published Sunday and Monday. Trump on Sunday confirmed that a call between the two leaders had occurred, telling reporters: "I wouldn't say it went well or badly, it was a phone call."

Sources told the Miami Herald, a US newspaper, that Trump sent a "blunt message" to Maduro during the phone call. "You can save yourself and those closest to you, but you must leave the country now," Trump allegedly said, offering safety to Maduro and his family "only if he agreed to resign right away.

However, Maduro allegedly refused to give up power and reportedly made his own demands, including global immunity from prosecution and being allowed to retain control of the military if he steps down.

The Miami Herald said no further contact between the two leaders has occurred, although Maduro supposedly asked for a second call after Trump closed Venezuela's airspace.

Venezuela does not want "a slave's peace," Maduro told supporters Monday as US military deployment has

been "testing" his country for months. "We want peace, but peace with sovereignty, peace with equality, peace with freedom; we do not want the peace of slaves or the peace of colonies. A colony never, slaves never," Maduro declared, noting that the 22-week US military "aggression" can be described as "psychological terrorism."

Maduro stressed that national power is grounded in citizen participation and "rests on the immense strength of its people, their awareness, their institutions, their rifles and their determination to build this homeland above any difficulty.'

India mandates pre-installation of govt cyber safety app on all smartphones

NEW DELHI, Dec 2, (AP): India's telecoms ministry has directed smartphone manufacturers to pre-install a government-run cybersecurity app on all new devices, according to a government order, raising concerns of data privacy and user consent in one of the largest handset markets in the world.

The Ministry of Communications' order issued Monday asked smartphone makers to pre-install the government's "Sanchar Saathi" app on all new devices within 90 days and to prevent users from deleting it. The order also requires manufacturers to push the app onto older models through a software update, extending the mandate beyond phones available in the market.

The ministry said the app, which is available to India's 1.2 billion smartphone users, was essential in "curbing misuse of telecom resources for cyber frauds and ensuring telecom cyber security." But privacy advocates say the order marks an effort to erode user privacy and consent.

"This is the beginning. It is government testing the waters," said Nikhil Pahwa, a digital policy expert and founder of the tech site MediaNama. "Once a government app is forcibly pre-installed on our devices, what's to stop them from pushing future apps

that could be used for surveillance?" Amid growing criticism, India's telecom minister, Jyotiraditya M. Scindia, on Tuesday called the app a "voluntary and democratic system" and said users can choose to activate it and "easily de-

lete it from their phone at any time. Scindia did not clarify Monday's directive instructing smartphone manufacturers to ensure the app's "functionalities are not disabled or restricted." The "Sanchar Saathi" app, which was released in January, was designed to let users block and track lost or stolen phones and to identify and shut down fraudulent mobile connections. Since its launch, it has drawn more than 5 million downloads and helped recover more than 700,000 lost devices, according to government data.

Property transactions fall sharply, commercial sector surges

Real estate deals drop 29% in weekly report

KUWAIT CITY, Dec 2: The weekly report from the Real Estate Registration and Documentation Departments at the Ministry of Justice showed a decline in real estate transactions to 119 deals worth KD 103.1 million, compared to 167 deals valued at KD 122.8 million the previous week. This marks a 28.7 percent drop in transaction volume and a 16 percent decrease in value.

Residential property transactions for the week of November 23 to 27 were modest, with 86 deals worth KD 36.2 million, compared to 118 deals valued at KD 50 million the previous week. This represents a 27 percent decline in the number of transactions and a 27.6 percent decrease in value, reflecting a slowdown in home and private residence purchases amid anticipation of new financing legislation.

Investment property transactions dropped sharply, with 26 deals worth KD 36.8 million, down 43.4 percent in number and 8.9 percent in value from 46 deals

totaling KD 41.5 million the previous week

In contrast, the commercial sector witnessed strong growth, recording five transactions worth KD 24.2 million, compared to just two deals worth KD 11.3 million. This represents a 114 percent increase in value and a 75 percent rise in the number of deals, reflecting the conclusion of large high-value commercial transactions.

The industrial sector recorded two deals totaling KD 4.9 million, while other segments, including shops and coastal plots, saw no activity.

'Al benefits unevenly'

UNDP warns AI could widen global inequality

BANGKOK, Dec 2, (AP): Behind the hoopla over the promise of artificial intelligence lay difficult realities, including how such technology might affect people already disadvantaged in a data-driven world.

A new report by the United Nations Development Program notes most of the gains from AI are likely to be reaped by wealthy nations unless steps are taken to use its power to help close gaps in access to basic needs, as well as such advanced know-how

The report released Tuesday likens the situation to the "Great Divergence" of the industrial revolution, when many Western countries saw rapid modernization while others fell behind.

Questions over how companies and other institutions will use AI are a near universal concern given its potential to change or replace some jobs done by people with computers and robots.

But while much of the attention devoted to AI focuses on productivity, competitiveness and growth, the more important question is what it will mean for human lives, the authors note.

"We tend to overemphasize the role of technology," said Michael Muthukrishna of the London School of Economics, the report's main author, told reporters. "We need to ensure it's not technology first, but it's people first," he said, speaking by video at the report's launch in

The risk of exclusion is an issue for communities where most people are still struggling to access skills, electric power and internet connectivity, for older people, for people displaced by war, civil conflict and climate disasters. At the same time, such people may be "invisible" in data that will not take them into account, the report said.

"As a general-purpose technology, AI can lift productivity, spark new industries, and help latecomers catch up," the report says.

Better advice on farming, analysis of X-rays within seconds and faster medical diagnoses, more effective weather forecasts and damage assessments hold promise for rural communities and areas prone to natural disasters.

Poverty

"AI systems that analyze poverty, health, and disaster risks enable faster, fairer, and more transparent decisions, turning data into continuous learning and public value," it says

Still, even in wealthy nations like the United States, the potential for data centers to devour too large a share of electricity and water has raised concerns. Ramping up power generation to meet higher demand may hinder progress in limiting the emissions of carbon from burning fossil fuels that contribute to global warming, while also causing health hazards.

The technology raises ethical, privacy and cybersecurity concerns: researchers have found hackers using AI to automate portions of cyberattacks. There also is the problem of deepfakes that can misinform or facilitate criminal activity.

Asian nations including China, Japan, South Korea and Singapore

are well placed to take advantage of AI tools, the report notes, while places like Afghanistan, the Maldives and Myanmar lack skills, reliable power and other resources needed to tap into the computing potential of AI. Inequalities between regions within countries mean some places even in advanced economies are prone to be left behind.

About a quarter of the Asia-Pacific region lacks online access, the report says.

If such gaps are not closed, many millions may be excluded from the kinds of devices, digital payment systems, digital IDs and education and skills that are required to participate fully in the global economy, falling further behind, said Philip Schellekens, the UNDP's chief economist for the Asia Pacific.

Other risks include misinformation and disinformation, surveillance that violates rights to privacy and systems that can act as "black boxes," reinforcing biases against minorities or other groups. So transparency and effective regulations are crucial guardrails for ensuring AI is used in fair and accountable ways, he said.

"We believe we need more balance, less hysteria and hype," Schelle-

AI is becoming essential for modern life, like electricity, roads, and now the internet, so governments need to invest more in digital infrastructure, education and training, fair competition and social protections, the report says.

"The goal," it says, "is to democratize access to AI so that every country and community can benefit while protecting those most at risk from disruption.'

World economy shows resilience amid Trump's trade wars: OECD

Global growth forecast to 3.2%

WASHINGTON, Dec 2, (AP): The world economy has proven surprisingly durable in the face of President Donald Trump's trade wars, the Organization for Economic Cooperation and Development said Tuesday, upgrading its outlook for global and U.S. economic growth this year.

The 38-country OECD now forecasts that the world economy will grow 3.2% this year, down a tick from 3.3% in 2024 but an improvement on the 2.9% it had predicted for 2025 back in June. The organization, which does economic research and promotes international trade and prosperity, expects global growth to slow to 2.9% next year.

The OECD also raised its forecast for U.S. growth this year - to 2%, up from the 1.6% it had forecast in June. Still, even with the upgrade, the American economy - the world's largest -- would have grown considerably more slowly than it did in 2024 (2.8%).

Since returning to the White House in January, Trump has overhauled U.S. trade policy, imposing taxes on imports to build a protectionist wall around the previously open American economy.

The trade barriers were widely expected to slow growth and push up costs. But his tariffs have come in lower than the ones he threatened to impose in the spring. Many companies beat the levies by importing foreign goods into the United States before they took effect. And the U.S. and world economies are getting a boost from massive investments in artificial intelligence.

"The global economy has been resilient this year, despite concerns about a sharper slowdown in the wake of higher trade barriers and significant policy uncertainty," OECD Secretary-General Mathias Cormann wrote in a commentary accompanying the forecasts. Still, he added: "We expect higher tariffs to gradually feed through to higher prices, reducing growth in household consumption and business in-

The OECD expects China, the world's No. 2 economy, to grow 5% this year, same as in 2024. It sees the 20 economies that share the euro currency collectively expanding 1.3% in 2025, lackluster but up from 0.8% in 2024.

India, which has supplanted China as the world's fastest-growing major economy, is expected to generate 6.7% growth this year, up from 6.5% in 2024.

Bitcoin briefly dips below \$85,000 in crypto rout

WASHINGTON, Dec 2, (AP): Bitcoin and companies tied to cryptocurrencies extended a nearly two-month swoon Monday, tracking with a broader market selloff in technology companies that many see as overvalued.

Bitcoin slid 5.6% after being down nearly 12% earlier in the day, settling in just

above \$86,000. Early Tuesday, it was trading around \$86,650.

The most-traded cryptocurrency is down about 33% since hitting a record \$126,210.50 on Oct. 6, according to crypto trading platform Coinbase. Bitcoin had soared since April in line with the stock market and driven partly by a more crypto-friendly tone in Washington.

Companies that enable investors to buy and sell cryptocurrencies, as well as the growing number of companies who have made investing in bitcoin their main business focus, were hammered in Monday's sell-off.

Coinbase Global fell 4.8% and online trading platform Robinhood Markets lost 4.1%. Bitcoin mining company Riot Platforms dropped 4%.

Strategy, the biggest of the so-called crypto treasury companies that raises money just to buy bitcoin, fell 3.3%. The company has reported holding 649,870 bitcoin. As of 4 p.m. EST Monday they were worth about \$55.7 billion. Earlier, Strategy said it expects bitcoin to end the year between \$85,000 and \$110,000, down from an Oct. 30 forecast of \$150,000. American Bitcoin, in which President Donald Trump's sons Eric Trump and Donald Trump Jr. hold a stake, fell 15.6% and is now down nearly 47% since Sept. 30.

Other Trump-related crypto ventures have declined as well. The market value for the World Liberty Financial token, or \$WLFI, has fallen to about \$4.14 billion from above \$6 billion in mid-September, according to coinmarketcap.com And the price of a meme coin named for President Donald Trump, \$TRUMP, is \$5.70, a

fraction of the \$45 asking price just before his inauguration in January

One popular way of investing in bitcoin is through spot bitcoin ETFs, or exchange-traded funds, which allow investors to have a stake in bitcoin without directly owning the cryptocurrency. According to data from Morningstar Direct, investors pulled \$3.6 billion out of spot bitcoin ETFs in November, the largest monthly outflow since the ETFs began trading in January 2024.

Bitcoin futures are down nearly 24% in the past month. At the same time, gold futures are up almost 7%. Analysts point to a number of factors that have led to the sell-off in bitcoin and other crypto investments, including a broad risk-off sentiment that has gripped markets this fall, sending investors toward safer

havens such as bonds and gold. In a research note to clients last week, Deutsche Bank analysts also attributed the recent declines in crypto to institutional selling, other long-term holders collecting profits and a more hawkish Federal Reserve. Stalled crypto regulation has

also contributed to the uncertainty, Deutsche Bank said. "While volatility remains inherent, these conditions indicate Bitcoin's portfolio integration is being tested, and raises questions of whether this is a temporary correction or a more prolonged adjustment," the analysts wrote.

On the regulatory front, the crypto industry received a boost in July when Trump signed into law regulations that set initial guardrails and consumer protections for stablecoins, which are tied to assets like the U.S. dollar to reduce price volatility compared with other forms of cryptocurrency. But a bill that creates a new market structure for cryptocurrency remains stalled in the Senate. The bill has been a top priority for the crypto industry since it spent heavily to elect Trump and install other allies in Washington.

Film offers satisfying finale amid a slow ride

'Wake Up Dead Man' mixes religion, mystery in 'Knives Out' film

LOS ANGELES, Dec 2, (AP): After two installments of his "Knives Out" franchise skewered old and new money, director and writer Rian Johnson targets religion in his third, a gloomy and clunky outing that may test fans' faith in the filmmaker.

"Wake Up Dead Man: A Knives Out Mystery" gets a new starry cast to orbit Daniel Craig's foppish detective Benoit Blanc, mixes operatic overacting with sly humor and bites off more than it can digest attempting cultural satire. The pacing is off, too. You won't exactly need to be nudged awake but it gets pretty soggy there for a while in the middle.

Blanc takes his sweet time to appear, which means that the first half of the movie is carried by the young Catholic priest Jud Duplenticy - a name Johnson apparently thinks is witty - who is sent to a troubled New York parish called Our Lady of Perpetual Fortitude run by a monsignor who is "a few beads shy of a rosary."

The young priest - played by a really winning and soulful Josh O'Connor - is a former boxer with a troubled past who in his new faith has found guidance and meaning. He preaches the gospel of love and calls himself "young, dumb and full of Christ"

What he finds is that the parish is run by a thunder-and-lightning monsignor who preaches the gospel of fear. Played deliciously by Josh Brolin, Monsignor Jefferson Wicks uses shame and guilt to keep his tiny flock in line against a permissive world. "Anger lets us fight back," he announces. "I hold the line." Johnson is making a leaden dig at those in power who inflame divisions for their own power.

When Wicks is found dead, Blanc finally shows up. The manner of the death is a classic detective book trope: The so-called locked-room mystery. Blanc calls this crime's "Holy Grail."

There are many suspects, of course: His devoted secretary (Glenn Close), an alcoholic doctor (Jeremy Renner), the groundskeeper (Thomas Haden Church), a sci-fi novelist in decline (Andrew Scott), a cellist with nerve pain (Cailee Spaeny),

and a MAGA-like political hack (Daryl McCormack), and the woman who raised him, a resentful lawyer (Kerry Washington). Johnson tries hard to give each depth, despite their sheer number, with telling details, like the way they tap a spoon on a tea cup.

Chief among the suspects is our bare-knuckle priest, whose relationship with the older Man of God has gone from bad to worse. "You're poisoning the church," he tells the monsignor and vows to "cut you out like a cancer." No wonder the town's police chief (Mila Kunis) quickly zeros in on the younger man.

There's no way you can solve this one so just relax and let it stutter-stop several times to its overcooked end. Along the way, Johnson makes jokes about Oprah, "The Phantom of the Opera" and even Netflix, the hand that feeds him, while dead bodies go headfirst down the stairs thunk-thunk, an \$80 million diamond appears and suspects scream, as storms swirl, that "Vengeance is mine!"

Perhaps the movie's best bits are when the young priest and detective team up to solve the crime. Blanc reveals himself to be a "proud heretic" who only "kneels at the altar of the practical" and believes religion is just storytelling, a means of control. The younger priest believes the opposite and is torn between sleuthing and his ministry, his open heart propelling the movie while Craig's Foghorn Leghorn, Southern-fried dandyism grows increasingly tiresome. (Although fans do get to hear him utter "Scooby Dooby Doo.")

Johnson has so far made a few glancing blows against cults of personality and the dynamics of in-groups, but nothing terribly crushing. He then comes to more tricky waters when the monsignor seemingly emerges alive from three days in a crypt, a riff from a foundational tenet of Christianity: the resurrection itself. It's the ultimate in glib.

A satisfying conclusion awaits but, truth be told, it has been a bit of a slog, with soft digressions into social critiques and the meaning of faith grafted onto a setup that, by the third movie in the franchise, shows its seams instantly. Wake up, indeed.

"Wake Up Dead Man: A Knives Out Mystery," a Netflix release in theaters now

that hits the streamer Dec. 12, is rated PG-13 by the Motion Picture Association for violent content, bloody images, strong language, some crude sexual material and smoking. Running time: 140 minutes. One and a half stars out of four.

CAIRO, Dec 2, (AP): Iran has sentenced acclaimed director Jafar Panahi to a year in prison in absentia, even as he received new awards for his latest movie.

The Tehran court also imposed a two-year ban on Panahi leaving Iran after convicting him on charges of "propaganda activities against the system," his lawyer Mostafa Nili said in a post on X. Nili said he would appeal the ruling.

Word of the sentence came as Panahi was in New York City on Monday evening, receiving three awards at the annual Gotham Awards for his movie "It Was Just an Accident," which also received the Palme d'Or at the Cannes Film Festival in September. Panahi did not comment on the sentence, and there was no immediate word if he planned to return to Iran.

Panahi is among the most celebrated of contemporary Iranian directors and has continued making movies despite repeatedly being imprisoned, banned from traveling and put under house arrest by Iranian authorities over the past 20 years. He filmed "It Was Just an Accident" clandestinely in Iran following a seven-month stint in prison that only ended in 2023 once he went on a hunger strike.

Jafar Panahi sweeps multiple honors

'One Battle After Another' tops Gotham Awards

NEW YORK, Dec 2, (AP): Paul Thomas Anderson's "One Battle After Another" was crowned best feature film and the dissident Iranian director Jafar Panahi won three awards Monday at the 35th annual Gotham Awards, a starry kickoff to the film industry's awards season.

The Gothams, presented by the Gotham Film & Media Institute, aren't considered an Oscar bellwether. But the black-tie affair, held at Cipriani Wall Street in downtown Manhattan, is known for celebrating smaller films while also dishing out generous helpings of tribute awards to Oscar hopefuls.

That made "One Battle After Another," a studio release that cost at least \$130 million to make, unlike any previous winner at the Gothams. Past winners include indies like "Past Lives," "Everything Everywhere All at Once" and the surprise 2024 winner, "A Different Man."

"I remember when the Gotham Awards were for low-budget movies," joked Adam Sandler, presenting a tribute to Noah Baumbach. "For 'The Squid and the Whale,' they paid Jeff Daniels in potato skins."

Protest

But in 2023, the Gotham Awards dispensed with their \$35 million budget cap for films. And this year, "One Battle After Another," a father-daughter tale of multigenerational protest, is widely seen as the best-picture front-runner and the movie to beat at March's Academy

"I didn't expect this, actually," said Anderson, accepting the award. "I started to think I didn't know what was going on."

"Thank you very much, everybody," added Anderson. "Let's go home or let's go to a bar somewhere or something."

or something."

While the Gothams help the industry get into the swing of awards season, they're quirkier than biggername ceremonies. Small juries select nominees and winners, which often leads to unexpected results. Both of the acting winners on Monday weren't even in attendance.

Best lead performance went to Sopé Dìrísù for the British-Nigerian drama "My Father's Shadow." His award was accepted by the film's director, Akinola Davies Jr., who also won for breakthrough director. Other nominees in the category included Jessie Buckley ("Hamnet"), Jennifer Lawrence ("Die My Love") and Ethan Hawke ("Blue Moon").

Best supporting performance went to Wunmi Mosaku of "Sinners," a victory that came over nominees such as Teyana Taylor ("One Battle After Another"), Stellan Skarsgård

("Sentimental Value") and Jacob Elordi ("Frankenstein"). "Sinners" director Ryan Coogler accepted her award.

Panahi won three awards for his revenge drama "It Was Just an Accident": best director, best original screenplay and best international film. Earlier Monday, Panahi's attorney, Mostafa Nili, said the director had been sentenced to one year in prison and a two-year travel ban.

Panahi was jailed for months shortly before making "It Was

Just an Accident" and only released after going on a hunger strike. In 2010, he was barred from filmmaking or traveling out of Iran. Yet he continued to make films without the government's permission. Since 2023, and until Monday's ruling, Panahi had been permitted to leave Iran. In May, his film won the Palme d'Or at the Cannes Film Festival.

"I would like to dedicate the honor of this award to independent filmmakers in Iran and around the world," said Panahi accepting the

screenplay award. "Filmmakers who keep the camera rolling in silence without support and, at times, risking everything they have, only with their faith in truth and humanity."

Other winners Monday included Harry Lighton ("Pillion") for adapted screenplay; Abou Sangaré ("Souleymane's Story") for breakthrough performer; and Julia Loktev's "My Undesirable Friends: Part 1 - Last Air in Moscow" for best documen-

Among the tribute honor-

ees were: Guillermo del Toro's "Frankenstein," Scott Cooper's "Springsteen: Deliver Me From Nowhere"; "Hedda" star Tessa Thompson; "Jay Kelly" director Noah Baumbach; the cast of "Sinners"; Luca Guadagnino and Julia Roberts of "After the Hunt"; and "Song Sung Blue" stars Hugh Jackman and Kate Hudson.

"This is a time for all of us to remember what unites us and what brings us together," said Jackman. "And that is awards season, everybody."

Lorenzo Bertelli to lead Versace's next chapter

Prada buys fashion rival Versace in nearly \$1.4bn deal

MILAN, Dec 2, (AP): The Prada Group announced Tuesday that it has officially purchased Milan fashion rival Versace in a 1.25 billion euro (nearly \$1.4 billion) deal that puts the fashion house known for its sexy silhouettes under the same roof as Prada's "ugly chic" aesthetic and Miu Miu's youth-driven appeal.

The highly anticipated deal is expected to relaunch Versace's fortunes, after middling post-pandemic performance as part of the US luxury group Capri Holdings.

Prada said in a one-line statement that the acquisition had been completed after receiving all regulatory clearances Prada heir Lorenzo Bertelli will steer Versace's next

phase as executive chairman, in addition to his roles as group marketing director and sustainability chief. The son of co-creative director Miuccia Prada and longtime Prada Group chairman Patrizio Bertelli has

said he doesn't expect to make any swift executive changes at Versace. But Bertelli has said that the company, which places among the top 10 most recognized brands in the world, has long been underperforming in the market.

Prada has underlined that the 47-year-old Versace brand offered "significant untapped growth poten-

Versace has been in the midst of a creative relaunch under a new designer, Dario Vitale, who previewed his first collection during Milan Fashion

Week in September. He had previously been head of design at Miu Miu, but his move to Versace was unrelated to the Prada deal, executives have said. Capri Holdings, which owns Michael Kors and

Jimmy Choo, paid \$2 billion for Versace in 2018, but had been struggling to position Versace's bold profile in the recent era of "quiet luxury. Versace represented 20% of Capri Holdings 2024

revenue of 5.2 billion euros. An analyst presentation for the Prada deal said that Versace would represent

13% of the Prada Group's pro-forma revenues, with Miu Miu coming in at 22% and Prada at 64%. The Prada Group, which also includes Church's footwear, reported a 17% boost in revenues to 5.4 billion euros

The Prada Group has already begun preparations to incorporate crosstown rival Versace into its Italian manufacturing system, a point of pride for the group.

"Making a bag for one brand or another, the know-how is the same,□ Bertelli told reporters last week at the group's Scandicci leather goods factory. which already makes bags for the Prada and Miu Miu brands and will soon add Versace.

The Prada Group's has invested 60 million euros in its supply chain this year, including a new leather goods factory near Siena, a new knitwear factory near Perugia as well as increasing production at its factory Church's footwear factory in Britain and expanding another Tuscan factory. That's on top of 200 million euros in investments from 2019-24.

Prada's efforts include an academy that has trained some 570 new artisans over the last 25 years in an in-house training academy operating in the Tuscany, Marche, Veneto and Umbria regions.

Last year, Prada hired 70% of the 120 artisans who trained in the academy. The number of trainees rose by 28% to 152 this year.

BAGHDAD: Iraq has launched a major reconstruction and heritage revival initiative, dubbed the "Mosul Pulse" project, to revitalize the historic alleys and neighborhoods of the war-battered old city of Mosul, a government official confirmed Monday

The key artery will link numerous areas, connecting vital landmarks like the iconic al-Nuri Mosque, al-Mufti said.

The initiative, which is planned to eventually encompass all of Mosul's areas, will be funded by the Iraqi government alongside contributions from the Iraqi Private Banks League and international organizations, he said. (Xinhua)

Deftly tugging their needles through the royal fabric, members of the Dumfries House Sewing Bee recently put the finishing touches on the festive decorations, which will be auctioned off to raise money for the King's Foundation. While the rain splattered against the windows of the 18th century mansion south of Glasgow, the women chatted amiably, hot drinks by their sides.

"It's been absolutely great," said Christine Wilson, 72, a retired finance of-ficer. "It's a great atmosphere in the sewing bee, a great group of friends, and we do a lot for charities as well." (AP)

WASHINGTON, Dec 2, (AP): Melania Trump on Monday unveiled the holiday decorations for her family's first Christmas back at the White House and her

theme is "Home Is Where the Heart Is." The decor also nods to next year's 250th anniversary of the signing of the Declaration of Independence in 1776 and founding of the United States of

Several dozen volunteer decorators from across the country helped deck the halls of the Executive Mansion with 75 wreaths, 51 Christmas trees, more than 700 feet (213 meters) of garland, more than 2,000 strands of lights, over 25,000 feet (7,620 meters) of ribbon, over 2,800 gold stars, more than 10,000 butterflies and 120 pounds (54 kilograms) of gingerbread.

BEIJING, Dec. 2, (Xinhua): At 65, Yang Su still plays the piano most evenings, just as he has for decades. The only change is that a phone propped beside him

quietly streams his music to the internet. Known online as Grandpa Su, the silver-haired pianist first found an unexpected audience on Douyin, China's short-video platform, after a young relative casually uploaded a 15-second clip of him playing

"Moscow Nights" in 2017. He did not chase attention, yet it arrived anyway. His following continued to grow -- at one point reaching 3.8 million -- simply because he kept doing what he had always done: sit down and play.

Now living in Hangzhou, the eastern city known for its booming livestream industry, Yang has uploaded more than 1,200 videos, earning over 23 million likes. On weekdays, he livestreams for about an hour and a

half, chatting lightly with viewers between songs. For Yang, what he has been doing is less about influence than connection -- a way to stay in tune with the world outside his door. "I don't worry about traffic data," he said. "I just play what people like and chat with people.

Chinese seniors making their mark in digital world

His experience is not unique, though others engage

differently. For 57-year-old Lu Caiyun, a domestic helper in Beijing for more than a decade, the camera serves a quieter purpose. Over the past year, she has posted more than 1,000 videos -- simple clips of cooking, square dancing, or resting after work -- for an audience of just over 50, most of them her friends from the same hometown.

"I use these videos like a journal," Lu said. "Life after work used to be boring, but recording it makes every day feel different."

Yang and Lu represent two ends of the same movement: older generations stepping into the digital age,

whether with millions of viewers or merely a dozen. At a time when aging is a global concern, their presence online signals a subtle but meaningful change. More seniors in China are declining to be defined solely as "grandpa" or "grandma." They seek connection, new skills, and a place to express themselves.

"Young people often overestimate seniors' need for basic comfort while underestimating their desire for self-fulfillment and for being recognized by others," said Zhang Xin, an associate professor at Peking University's School of Psychological and Cognitive Sciences.

Data from the National Bureau of Statistics show that by the end of 2024, China's total population aged 60 and older reached 310.31 million. According to a July report from the China Internet Network Information Center, China has 160 million internet users aged 60 and above. This means roughly one in two seniors in China is online.

A study by Beijing Normal University, surveying 2,000 seniors nationwide, highlights how digital life is taking root among older generations: over 75 percent have created short videos at least once, and 28 percent post content frequently.

Why humans are wired to give

The science behind why doing good also makes us feel good

WASHINGTON, Dec 2, (AP): The holiday season is a time for giving thanks, giving gifts - and for many, a time for giving back.

Food banks, services that deliver meals to seniors and other US charities typically see a surge in volunteering between Thanksgiving and the end of the year. But there are good reasons to volunteer at any time of the year

Alfred Del Grosso volunteers weekly to work the lunch shift at Shepherd's Table, a food bank in Silver Spring, Maryland. "I feel more connected to the broader community," he said

Most Thursdays, the retired chemist from Kensington, Maryland, also lends an unpaid hand to help clear fallen trees and brush from local trails with the Potomac Appalachian Trail Club. "It's mostly volunteers who help maintain the trails," he

Researchers who study human evolution and social psychology say that giving back is deeply rooted in human nature. Volunteers say they feel closer ties to the

"When we feel grateful for all we have, that motivates us to do good things for other people who have helped us, and also to do good things for new people," said Sarah Schnitker, a psychologist at Baylor University.

"There's a nice upwards reciprocal spiral between gratitude and generosity," often enhanced at holiday times, she said.

For many in the US, the season most associated with giving, receiving and volunteering runs from Thanksgiving and Christmas to New Year's.

But around the world, a giving season or festival is present in many cultures, said Amrisha Vaish, a developmental psychologist at the University of Virginia.

"Nearly all cultures have events or public festivals that allow people to express gratitude," she said. "In Hinduism, Divali is a time of lights and festiveness and good eating, but also a time in which people give gifts to really express what people have meant to them?

For Muslims, Ramadan, which ends with the festival of Eid al-Fitr, is a time for reflection, gratitude and acts of charity. Many Buddhist traditions also emphasize gratitude.

The common purpose of such seasons, which also include non-religious acts of service, is to reinforce our natural cooperative tendencies, Vaish said.

"In human evolutionary history over hundreds of thousands of years, we've had to become cooperative in order to work together and survive as a species,"

"We don't have sharp claws, high speed, many other natural abilities. But what we do have is that we're super cooperators; we can do more in groups than alone.' Of course, humans aren't always cooperative and generous - sometimes we're

The tension between selfishness and altruism was recognized even by Darwin, said Michael Tomasello, a psychologist at Duke University. "That's why life is so complicated. We have all these motives mapped together.

But reflecting with gratitude on what we have, and seeing others do good, can encourage our most generous tendencies, experts say.

On an individual level, "giving, volunteering and generosity have the ability to increase our sense of meaning and purpose in life," said Jenae Nelson, a develop-

mental psychologist at Brigham Young University "There's a quick dopamine hit sometimes called the 'helpers high.' But there's also that deeper reward of helping us to establish purpose and meaning," she said. "By helping other people and believing that small acts can change the world, you can bring coherence to your own life.

After Mia Thelen retired as a nurse in Owosso, Michigan, she began volunteering for the American Red Cross, starting out by minding the office phones during blood drives before gradually taking on more organizational and administrative

"It's a good way to spend your time, making the lives of others a little easier," Thelen said. "I wanted to do something that helps the community."

"And I'm learning a lot: learning computer skills, learning communication skills. I have great co-volunteers." She enjoys feeling more connected with her neighbors. Another common holiday tradition - sending greeting cards to family and old friends - also provides a chance to enhance or renew social ties, which people are often surprisingly reluctant to do, said Lara Aknin, a social psychologist at Simon Fraser University.

Her research has shown that "people are actually hesitant to reach out to old friends, they worry about being a burden or an inconvenience," she said. But on the flip side, "people who've just heard from old friends report it as a really positive experience.

So go ahead and write those cards or make those phone calls, she said. Use the holidays as an excuse to reconnect, and share a laugh or a warm mulled drink.

Why do people get headaches, migraines?

Why do people get headaches? - Evie V., age 10, Corpus Christi, Texas

Whether sharp and stabbing or dull and throbbing, a headache can ruin your day. But your brain doesn't actually feel pain. So what is going on when it feels like your head is in a vise or about to explode?

I am a child neurologist - that is, a doctor who specializes in diseases of the brain in kids. Most of my patients are kids and adolescents who are struggling with headaches

Head pain is complicated, and there is still a lot to learn about what causes it and how it can be treated. But researchers know there are a few key players that take part in generating

Nerves communicate information like pain through electrical signals between the body and the brain.

While the brain itself doesn't have any nerve sensors to feel pain, blood vessels in the head and structures that protect and surround the brain do sense pain. When these tissues detect injury or damage, they release chemicals that trigger transmission of electrical signals through nerves to tell the brain the head is hurting.

The brain will also use nerves to signal the body to respond to pain with symptoms like feeling tired, teary eyes, runny nose, upset stomach and discomfort in bright or loud environments. It's not clear why humans evolved to feel these symptoms, but some scientists theorize that this can lead to healthier lifestyle choices to decrease the chance of future headache attacks.

Often, headaches are a sign that the body is under some kind of stress. That stress triggers chemical and physical changes to the nerves and blood vessels around your brain, head and neck that can cause headaches

Many types of stresses can cause headaches, including an infection, allergies, hormone changes during puberty and menstrual cycles, not getting enough sleep, not drinking enough water, skipping meals or drinking too much caffeine or alcohol. Sometimes, headaches happen with emotional stress, like feeling anxious or depressed. Even pressure in your sinuses due to changes in the weather can cause your head to hurt.

One in 11 kids have had a type of severe headache called a migraine. They feel like a pulsing and pounding pain in your head and come with other symptoms, including nausea or being sensitive to lights and sounds. During a migraine, it can be hard to do everyday activities because they can make the pain worse. It is also very common to feel unwell or irritable before the head pain starts and after the pain is gone.

Migraines occur when the nerves and other structures used in signaling and interpreting pain aren't working properly, leading to pain and discomfort from stimulation that wouldn't normally provoke this. There are many environmental and genetic factors that contribute to this dysfunction. Some people are born with a higher risk of developing migraines. Most people with migraines have someone in their family who also experiences them. (AP)

Health authorities in the Gaza Strip announced on Monday the death of about 1,000 Palestinian patients while waiting for the border crossings to open to travel for treatment, despite having obtained administrative forms ensuring their medical transfer outside the strip.

Director-General of health authorities in Gaza Dr. Munir Al-Barsh, said in a statement that the joint medical referral committees with the World Health Organization (WHO) have received more than 22,000 cases since the beginning of the war, of which 18,100 were approved, including 5,000 cancer patients, 7,000 injured, and 5,000 children.

He added that "all the files are with the United Nations and the World Health Organization," emphasizing the importance of opening the Rafah land crossing as

He explained that the healthcare sector is suffering from a severe shortage of medicine and medical supplies, noting that the majority of essential and emergency medicines, medical supplies, bone fixatives and gauze are unavailable.

The available medical supplies are enough for only one month despite the declared ceasefire, noting that the "WHO has three thousand medical aid trucks ready in the Egyptian city of Al-Arish, but they have not been able to bring them in," added Al-Barsh. (KUNA)

Online pet trade growing

Endangered species convention proposes new rules for growing exotic pet trade

NEW YORK, Dec 2, (AP): A growing exotic pet trade has conservationists calling for stronger regulations to protect the reptiles, birds and other animals in the wild that are increasingly showing up for sale on internet marketplaces and becoming popular on social media.

The two-week Convention on International Trade in Endangered Species of Wild Fauna and Flora is scheduled to run through Friday in Samarkand, Uzbekistan. Several proposals related to the pet trade will be considered Tuesday

Participants have proposed tighter regulations or complete bans on the trade of several species including iguanas from the Galapagos Islands, more than a dozen species of Latin America tarantulas and an odd-looking turtle from Africa.

"What we're seeing is the pet trade much more looking at reptiles, amphibians. People want rare species and they don't have to go into a pet shop," said Susan Lieberman, vice president for international policy at the nonprofit Wildlife Conservation Society. "They go online and there are thousands of animals, including endangered species, illegally obtained species, all

available on the internet.' In the past, the trade was dominated by sales in animal parts like elephant ivory and tiger bones. But Matt Collis, the senior director of international policy at the International Fund for Animal Welfare, said live animals for the pet trade are increasingly turning up on the internet.

"The dramatic growth in online marketplaces has put consumers directly in touch with wildlife traders and criminals around the world," Collis said. "In today's society where pretty much

anything can be bought with a click of a button and shipped anywhere in the world in a matter of days, no wildlife is safe.

Several of the species proposed for greater protection at the CITES conference are in Latin America, where an IFAW report last year found illegal trade is on the rise. The report, covering 18 Spanish speaking Latin American countries, says there were more than 100,000 animals seized or poached from 2017 to 2022, with seizures increasing every year.

The report found the live pet trade accounted for a growing piece of the trade, with reptiles representing about 60% of the animals, while nearly 30% were birds and more than 10% were amphibians. Many animals were traded locally or regionally but there also was evidence of animals shipped to collectors in Europe, Asia and the United States

More than 90% of the seized wildlife destined for Europe were live animals, confirming the demand for pets was a key driver of the illegal trade, the report said. Among the reptile species up for tighter trade controls is Home's Hingedback Tortoise, a critically endangered turtle found in West Africa that has a unique hinge on its back allowing it to close off its back legs and tail.

There are proposals to regulate the trade in two vipers species endemic to Ethiopia, two species of rattlesnake found mostly in Mexico, the leaf-tailed gecko from Australia and two species of sloths from South America, which are increasingly turning up in sloththemed cafes in Asia.

A proposal from Ecuador would ban the trade in marine and land iguanas from the Galapagos, which are listed by the International Union for Conservation of Nature as critically endangered or vulnerable.

WHO issues global guidance on GLP-1 use for obesity

GENEVA, Dec. 2, (Xinhua): The World Health Organization (WHO) released on Monday its first guideline on the use of Glucagon-Like Peptide-1 (GLP-1) therapies for treating obesity as a chronic, relapsing disease.

The guideline aims to address the growing global health challenge of obesity, which affects more than 1 billion people and is associated with 3.7 million deaths worldwide in 2024. Without decisive action, the number of people with obesity is projected to double by 2030.

In September 2025, WHO added GLP-1 therapies to its Essential Medicines List for managing type 2 diabetes in high-risk groups. With the new guideline, WHO issues conditional recommendations for using these therapies to support people living with obesity in overcoming this serious health challenge, as part of a comprehensive approach that includes healthy diets, regular physical activity and support from health professionals.

"Obesity is a major global health challenge that WHO

is committed to addressing by supporting countries and people worldwide to control it, effectively and equitably. Our new guidance recognizes that obesity is a chronic disease that can be treated with comprehensive and lifelong care," said Tedros Adhanom Ghebreyesus, WHO director-general. 'While medication alone won't solve this global health

crisis, GLP-1 therapies can help millions overcome obesity and reduce its associated harms," he said. Obesity is a complex, chronic disease and a major

driver of noncommunicable diseases, such as cardiovascular diseases, type 2 diabetes and some types of cancer. It also contributes to poorer outcomes for patients with infectious

Beyond its health impacts, the global economic cost of obesity is predicted to reach 3 trillion U.S. dollars annually by 2030. The guideline can help efforts to reduce skyrocketing health costs associated with managing the condition and its related health complications.

BEIJING, Dec. 2, (Xinhua): A research team at the Wuhan University of Science and Technology (WUST) has recently developed a new targeted delivery system to send gene editing tools into cells. The tools will precisely locate the HIV virus and cut its genome into fragments, thereby achieving a functional cure, the China Science Daily reported on Tuesday

Current HIV treatment methods include the widely used cocktail therapy, as well as emerging approaches like immune cell therapy and gene therapy. Cocktail therapy aims to suppress viral replication to the greatest extent, improving the quality of life and survival rates of patients. However, it cannot eradicate the virus.

Immune cell therapy can only identify and eliminate cells that are actively replicating the virus, leaving dormant infected cells unchanged. Existing gene therapies, such as those using adeno-associated viruses as delivery vectors, suffer from shortcomings such as poor targeting capabilities

and toxicity due to excessive dosages. For the WUST study, the results of which have been published in the Molecular Therapy journal, a team led by Gu Chaojiang invented the exosome-mediated targeted CRISPR-Cas12a delivery system (EMT-Cas12a) based on engineered exosomes.

Meanwhile, marking World AIDS Day, South African Deputy President Paul Mashatile said Monday that the country's theme, "Renewed Efforts and Sustainable Commitments to End AIDS," underscores the need to reinforce HIV prevention and treatment programs at a time of tightening budgets.

Speaking at an official commemoration in Limpopo Province, Mashatile called the fight against HIVAIDS a longterm strategic investment, stressing the need to sustain momentum even as global priorities shift. The commemoration emphasizes "the importance of our commitment to accelerate our efforts to end AIDS," Mashatile noted.

England picks Will Jacks for second Ashes test

BRISBANE, Australia, Dec 2, (AP): In the only change from the first test, Will Jacks has been named in England's team for the second Ashes test against Australia, with the all-rounder preferred to Shoaib Bashir for the day-night match starting Thursday in Brisbane.

Jacks made two test appearances in Pakistan three years ago and has been used mostly in limited-overs cricket since.

With paceman Mark Wood out injured, England preferred a slow bowling option over back-up seamers Josh Tongue and Matthew

Bashir has been England's favored spinner for most of the last two years, taking 68 wickets in 19 appearances. The 22-year-old Bashir was the spare man in a squad of 12 for the first test which England lost in two days.

Hamlin breaks down in tears as 1st witness testifying at antitrust trial

CHARLOTTE, N.C. Dec 2, (AP): The landmark federal antitrust trial against NASCAR opened with three-time Davtona 500 winner Denny Hamlin breaking down in tears minutes into his testimony as the first witness in a case that could upend the venerable stock car series.

Hamlin's 23XI Racing, which he coowns with Michael Jordan, and Front Row Motorsports claim the series is a monopolistic bully that leaves its teams no option but to comply with rules and financing they don't agree with.

As Jordan watched from the gallery, Hamlin began to cry and had to stop and compose himself when asked how he got into racing. He disclosed to The Associated Press last month that his father is dying, and he said on the stand he was emotional because his dad "is not in great health.'

"We got to when I was about 20 and a decision had to be made, I could keep racing or go out and work for my dad's trailer business," Hamlin testified, adding that he later was thinking about what retirement looked like and found a team going out of business. He needed a partner and turned to Jordan, who he had developed a friendship with when the Basketball Hall of Famer owned the Charlotte Hornets and Hamlin was a season-ticket holder.

"If I can't be successful with Michael

as a partner, I knew this was never going to work," he said.

The references to his early days in auto racing and the sacrifices his family made were intended to show how difficult it is for both team owners and drivers to make it at the top level of the sport. He said he never would have been able to start 23XI in 2021 had he not partnered with Jordan.

Because of Jordan's presence with the team, Hamlin testified, 23XI has turned a profit in all but one of its five seasons

of operation. His attorney, Jeffrey Kessler, said in his opening statement that fast-food restaurant entrepreneur Bob Jenkins has never turned a profit since starting his Front Row team in 2004.


Front Row won the 2021 Daytona 500. At the heart of the lawsuit is NAS-CAR's revenue sharing model, which 23XI and Front Row argue is unfair to race teams that often operate at a loss. Hamlin testified it cost \$20 million to bring a single car to the track over a 38-race season, not including overhead

expenses such as driver salary. Kessler said a NASCAR-commissioned study found that 75% of teams lost money in 2024.

"So, why would these people do this if you are just going to lose money because NASCAR isn't giving you a fair deal?" Kessler said as Jordan watched from th gallery. "Because you love stock car racing, and there's nowhere else to do it."

The charter agreements signed for this year that triggered the lawsuit guarantee the teams \$12.5 million in annual revenue. NASCAR argues the guaranteed payouts are an increase from \$9 million from previous agreements, but Hamlin noted that 11 of the first 19 chartered teams are no longer in business. All three charters 23XI purchased came from teams that ceased operations.

The match pitted a home side unbeaten in 12 games against a visitor that lost its last three league matches by a combined score of 6-2.

Yet it was Cremonese that struck first after half an hour. Matteo Bianchetti's poised through ball put Martín Payero on goal and his assured finish gave the goalkeeper no chance.

Four minutes later, Jamie Vardy made it 2-0 with a carbon copy of the opener. Federico Bonazzoli's pass set him free of a leaden back four and he coolly slotted home from almost exactly the same position as Payero.

The club, which was founded in 1867 and was an original member of the Premier League in 1992, is 27 points from safety in the Championship and heading for relegation to England's third division. The latest punishment was for "multiple breaches of EFL regulations relating to payment obligations," the English Football League said in a statement on X. 2026 Giro to start in Bulgaria

ROME, Dec 2, (AP): Next year's Giro d'Italia will start with three stages in Bulgaria and will likely be decided in the Dolomites before the mostly cer-

The route for the 109th Giro, scheduled for May 8-31, was presented in

It's the 16th time the Italian Grand Tour is starting abroad. After the opening in Bulgaria, the peloton will fly to Calabria to begin a climb up boot-shaped Italy, passing through Naples and a difficult ascent to Blockhaus in Abruzzo.

The race's only time trial is a 40.2-kilometer (25-mile) individual race against the clock in Stage 10 from Viareggio to Massa along the Tuscan coast. The toughest leg, known as the queen stage, is slated to be Stage 19 from Feltre to Alleghe going over five climbs including the Passo Giau, which marks the "Cima Coppi" as the race's highest point at 2,233 meters (7,326

Then there are two ascents the next day to Piancavallo in the penultimate leg, which could decide the winner.
"This year we have designed a more modern Giro, with shorter stages that

are no less demanding for the general classification contenders, alternating with stages that will suit riders looking to make an impact with long-range attacks," race director Mauro Vegni said. "There will be seven summit finishes, the same number of stages for the sprinters."

The nine-stage Women's Giro will start in Cesenatico on May 30 and finish in Saluzzo on June 7. There are two summit finishes at Nevegal and Sestriere, with the latter stage including the famous climb to Colle delle Finestre.

Adam Yates and Elisa Longo Borghini won the Giro this year. Yates is expected to try and defend his title, and could be joined by Visma-Lease a Bike teammate Jonas Vingegaard, the two-time Tour de France champion. Other challengers could include rising Mexican rider Isaac del Toro, who lost the lead to Yates in the penultimate stage this year, and Primoz Roglic, the 2023 Giro champion.

The emotions I felt at the end of this (year's) Giro were incredible and I really hope to experience them again," Yates said.

Red Bull voices regret, Antonelli threatened over Norris incident

DOHA, Dec 2, (AP): Red Bull expressed regret following "clearly incorrect" comments alleging that Mercedes' Kimi Antonelli had let Lando Norris past at the Qatar Grand Prix, influencing the Formula 1 title fight, after the Italian rookie received death threats on social me-

Standings leader Norris was in fifth place behind Antonelli toward the end of Sunday's race when the Italian slid wide and Norris overtook him for fourth place. That allowed the McLaren driver to stay 12 points in front of Red Bull's Max Verstappen ahead of the season finale this week in Abu Dhabi.

Verstappen's race engineer Gianpiero Lambiase suggested to the Dutch four-time champion over the radio that it seemed Antonelli had let Norris pass him, and Red Bull adviser Helmut Marko claimed Antonelli "waved him by" in comments to Sky Sport Germany.

"Comments made before the end of and immediately after the Qatar GP suggesting that Mercedes driver Kimi Antonelli had deliberately allowed Lando Norris to overtake him are clearly incorrect," Red Bull posted on social media.

"Replay footage shows Antonelli momentarily losing control of his car, thus allowing Norris to pass him. We sincerely regret that this has led to Kimi receiving online

Mercedes said more than 1,100 comments described as "severe or suspect" were left on Antonelli's social media accounts, including death threats and comments wishing him harm, and more than 330 severe or suspect comments were left on the

Mercedes said the comments were


Pagou replaced Marc Brys, the veteran Belgian coach whose appointment last year seemed to be the sports ministry's choice against the wishes of the soccer federation led

KUWAIT CITY, Dec 2: Under the patronage of Minister of Information and Culture and Minister of State for Youth Affairs Abdulrahman Al-Mutairi, the inaugural West Asia Women's Volleyball Clubs Championship kicks off today at Salwa Al-Sabah Club Hall. The 10-day event features 12 participating clubs, divided into three groups:

Group 1: Qatar (Qatar), Al-Ula (Saudi Arabia), Al-Qalamoun (Lebanon), and Al-Fatat (Kuwait)

French league condemns attacks

Nice players attacked by fans after losing streak

PARIS, Dec 2, (AP): Nice and the French league have condemned "unacceptable" acts of fan violence after players and staff were attacked following another disappointing performance by the Riviera side over the weekend.

After suffering a sixth consecutive loss across all competitions on Sunday - 3-1 at Lorient in Ligue 1 - Nice players were confronted by a large number of their supporters when they returned to the club's training and academy center.

Fans shouted insults and demanded greater commitment from the squad as tensions escalated, with reports that some supporters even boarded the team bus.

'The club understands the frustration caused by the series of poor results and performances that fall short of its values," Nice said in a statement late Monday. "However, the incidents that occurred during this gathering are unacceptable. Several members of the club were confronted and targeted. OGC Nice offers them its full support and condemns these actions in the strongest possible terms."

L'Equipe reported some players and staff were spat on when they exited the bus, and even punched. Jérémie Boga and Terem Moffi were reportedly the most violently attacked, taking multiple blows, including to the head and groin, while sporting director Florian Maurice was also said to be assaulted.

L'Equipe and RMC reported that Boga and Moffi have been given medical leave. Nice did not immediately respond to a request for comments from The Associated Press.

The French league (LFP) said on Tuesday that the assaults were "completely unacceptable, undermining the integrity of the participants in the game and the values of football." The LFP added it will join as a civil party in the complaints filed by the players to ensure that the incidents are thoroughly investigated.

"The LFP expresses its full support for the affected players and OGC Nice, and reaffirms its determination to guarantee the safety of all football stakeholders.

After 14 rounds, Nice sits 10th in the table.

Haise signed a new two-year deal with the Ligue 1 club in September until 2029 despite a lackluster start to the season. Nice was knocked out of the Champions League after losing to Benfica in the third qualifying round and has since struggled to get its campaign going.

The 54-year-old Haise took over Nice during the 2024 summer and led the Riviera team to a fourth-place finish last season.

Nice's next faces Angers at home on Sunday.

Visa challenges loom

CAS clears Russian athletes for Milan Cortina Olympic qualifiers

LAUSANNE, Switzerland, Dec 2, (AP): Russian skiers and snowboarders won a court ruling on Tuesday to apply as neutral athletes for qualification events to the Milan Cortina Winter Olympics after nearly four years of being excluded during the war on Ukraine.

Russian sports minister Mikhail Degtyaryov posted on social media that an appeal from Russia to the Court of Arbitration for Sport overturned a blanket ban imposed by the International Ski and Snowboard Federation (FIS) within days of the full military invasion in February 2022. FIS renewed the ban in October.

CAS later published its ruling in another legal win for Russian and Belarusian winter sports athletes.

In October, a similar appeal to CAS by the Russian luge federation and athletes ruled against a long-standing blanket ban based on their passports.

Sports bodies have excluded Russians mainly for security reasons to protect athletes and prevent protests that also could disrupt the field of play.

Still, there is little time for FIS to process applications from ath-

letes to be approved with neutral status ahead of a Jan. 18 qualification deadline. The Milan Cortina Winter Olympics begin on Feb. 6.

Neutral status can be approved in most sports, following International Olympic Committee guidance, for athletes who have not publicly supported the military invasion of Ukraine and do not have ties to military or state security

Russian athletes and team officials also face challenges getting visas to enter some countries that host qualifying events such as on the World Cup circuit in Alpine, cross-country and freestyle skiing, and snowboarding.

FIS runs almost half of the entire Winter Games program - 57 of 116 gold medal events.

CAS said its judges gave an urgent ruling combining separate appeals that Russian and Belarusian athletes who meet eligibility standards set by FIS should be allowed to enter international

"Both panels (of judges) found that the FIS statutes protect individuals from discrimination and require the FIS to be politically neutral," the Lausanne-based court said in a statement.

Some Russian and Belarusian athletes competed at the Paris Summer Games last year without their national identity of flag, anthem and team colors. Both countries were banned from team

The IOC must also assess the neutral status of Russian and Belarusian athletes before inviting them to compete at the Milan Cortina Winter Games.

Two Russian figure skaters and one from Belarus were invited to the Olympics by the IOC last

Degtyaryov has said he expects as few as 15 Russian athletes to compete at the Winter Games.

Kuwait pushes Egypt to the brink in Arab Cup thriller

DOHA, Dec 2: Kuwait opened its Arab Cup campaign with a valuable point after holding Egypt to a 1-1 draw on Tuesday night at Lusail Stadium in Qatar, in the first round of Group C matches.

Fahad Al-Hajri put Al-Azraq ahead in the 64th minute, before Mohamed Afsha leveled for Egypt from the penalty spot in the 88th.

Helio Sousa made several adjustments to the Kuwaiti lineup compared to the playoff win over Mauritania, handing starting roles to Saud Al-Hoshan, Al-Hajri, Abdulwahab Al-Owadhi, Sultan Al-Enzi, Fawaz Ayed, and Youssef Majed, while dropping Khaled Al-Rashidi, Rashed Al-Dosari, Hassan Hamdan, Redha Hani, Athbi Shahab, and Eid Al-Rashidi.

Egypt took control from the opening whistle, seeking an early breakthrough and pressing Kuwait deep in their

Al-Hoshan pushed away Ghanem Mohamed's shot inside the first minute, then collected a header from Mohamed Elneny (4'). Yassin Marai headed narrowly wide (6'), while Rajab Nabil sent another header over the bar

Kuwait's first chance came when Yousef Nasser fired over from a promising position (20').

Egypt won a penalty after Islam Issa was tripped by Al-Owadhi, but captain Amr Al-Sulaya wasted it by sending his effort wide (38'). Daham tried his luck from distance without success (40'), and Al-Hoshan denied Elneny once more just before halftime.

The second half followed a similar pattern early on, with Egypt pushing forward but failing to beat Kuwait's compact defense and alert goalkeeper. Sousa then refreshed his side by introducing Rashed Al-Dosari, Nasser Falih, and Eid Al-Rashidi.

The changes sparked Kuwait into life, allowing them to grow into the match. Al-Hajri broke the deadlock with a well-placed header (64'), and Daham came close to a second after excellent work from Falih, only to shoot straight at the keeper (81').

But a late mistake proved costly. Al-Hoshan brought down substitute Marwan Hamdy inside the box, earning a second yellow card as Norwegian referee Eskas Espen pointed to the spot. Afsha converted confidently to rescue a draw for the Pharaohs (88').

The Syrian national team began its2025 Arab Cup journey with a 1-0 victory over Tunisia, highlighting an unusual source of motivation for the "Eagles of Qasioun": the social deduction game Mafia.

The match-winning goal came from Omar Khrbin in the 48th minute with a perfectly executed direct free kick during the first round of Group A matches.
