RIYADH: Secretary General of the Gulf Cooperation Council (GCC) Jasem Al-Budaiwi congratulated Friday His Highness the Amir Sheikh Nawaf Ahmad Al-Jaber Al-Sabah on the third anniversary of assuming power.

In a statement, Al-Budaiwi wished happy returns of this occasion, which has many achievements and development in all domains, thanks to Allah and the wise leadership.

He also wished Kuwait further progress and His Highness the Amir everlasting well-being. (KUNA)

MANAMA: The General Command of the Bahrain Defense Force (BDF) announced Friday the death of the fourth service-man after Monday's Houthi attacks on coalition forces on the Saudi southern borders.

'The BDF mourns Lieutenant Hamad Khalifa Al Kubaisi, who valiantly sacrificed his life in the line of duty," the General Command said in a statement today.

"Al Kubaisi succumbed to the injuries he had suffered as a result of the Houthi act of aggression last Monday, while performing his sacred patriotic duties defending the southern borders of Saudi Arabia," it added. (KUNA)

RIYADH: GCC Secretary General Jassim Al-Bedaiwi announced free trade with Pakistan.

According to a statement by the GCC General Secretariat on Friday, Al-Bedaiwi signed the agreement with Pakistan's Federal Minister for Industries and Production Division Dr. Gohar

The agreement will play a big role in developing commercial ties between the GCC and Pakistan, said Al-Bedaiwi in a press statement. (KUNA)

BRUSSELS: The death toll in the Dutch port Rotterdam hospital shooting rose to three on Thurs-

day evening when a 14-year-old

girl died of her injuries. The girls mother died earlier in the afternoon, as did a lecturer at Rotterdams Erasmus teaching hospital, Dutch News. nl portal

reported Friday. Police have arrested a 32-yearold man, a student at the universi-

ty, in connection with the shooting. (KUNA)

KUALA LUMPUR: Malaysia's authorities called on the international community to hold Israel accountable for its continued aggression against Palestinians, saying that the attack would aggravate situation, which is already tough, in the occupied Palestinian territories.

In a statement, Malaysia's foreign ministry slammed the recent storming of Al-Aqsa Mosque that was carried out by some Israeli settlers. (KUNA)

RAMALLAH: Two young Palestinians were wounded Friday tonight after Israeli occupation forces opened gunfire at a vehicle near the Israeli settlement of **Pesagot**, to the east of **Al-Bireh** city in the occupied West Bank.

The Palestinian news agency reported that Israeli troops set up an ambush for the vehicle at the entrance to the settlement, before they opened fire at two young men who were inside the vehicle and subsequently arrested them.

Israeli occupation soldiers were seen carrying the injured young men on stretchers into the settlement for detention. (KUNA)

CAIRO: At least six people were killed and six others were wounded in a suicide bombing attack at a cafe in Howlwadaag District in the Somali capital on Friday, according to Mogadishu Police.

Police Spokesman Sadiq Adam told the Somali National News Agency that the attack was carried out by a member of the Al-Shabab terrorist group. (KUNA)

Death toll 54

KUWAIT CITY, Sept 30, (Agencies): His Highness the Amir Sheikh Nawaf Al-Ahmad Al-Jaber Al-Sabah has sent a cable to Pakistani President Dr. Arif Alvi on Friday expressing wholehearted condolences on the suicide attacks that took place in Baluchistan, southwestern the country and Khyber Pakhtunkhwa province bordering Afghanistan, claiming scores of lives and injuring many people.

His Highness the Amir affirmed the State of Kuwait's robust condemnation of this abhorrent terrorist act, which contradicts all humane beliefs and values, praying to Almighty Allah to bestow mercy upon souls of the victims

and wishing the wounded swift recovery.

His Highness the Crown Prince Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah and His Highness the Prime Minister Sheikh Ahmad Nawaf Al-Ahmad Al-Jaber Al-Sabah sent similar cables.

National Assembly Speaker Ahmad Al-Sadoun sent two cables of condolences Friday to Chairman of Pakistan's Senate Mohammad Sadiq Sanjrani and Speaker of National Assembly Raja Pervez Ashraf.

In the cables, Al-Sadoun expressed heartfelt condolences over victims of suicide blasts throughout Pakistan earlier today, condemning such terrorist acts.

The top lawmaker prayed to Almighty Allah to bestow mercy upon the souls of the victims, wishing speedy recovery to the wounded. The Foreign Ministry expressed Friday Kuwait's con-

demnation and denunciation of the treacherous deadly attacks on religious gatherings in a number of provinces in the Islamic Republic of Pakistan. In a statement, the Foreign Ministry re-affirmed Ku-

wait's unequivocal rejection of all forms of violence and harm to innocent people.

It expressed Kuwait's solidarity with the friendly Islamic Republic of Pakistan in the measures it takes to preserve its internal security.

The Ministry extended Kuwait's sincere condolences and sympathy to the Pakistan and to the families of the innocent victims. It also wished a speedy recovery for those injured.

Bombing

The death toll from a bombing in southwestern Pakistan as people celebrated the Prophet Muhammad's (PBUH) birthday rose to 54 after two critically wounded patients died in hospitals overnight, officials said Saturday.

A suspected suicide bomber or bombers blew themselves up Friday among a crowd in the Mastung district. It was one of the deadliest attacks targeting civilians in Pakistan in months. Nearly 70 people were wounded, including five who remain in very critical condition, authorities said. No one has claimed responsibility for the attack in Mas-

tung, a district of Baluchistan province. But suspicion is likely to fall on the Islamic State group's regional affiliate, which has claimed previous deadly bombings around Pakistan. IS carried out an attack days earlier in the same area

after one of its commanders was killed there. Also Friday. a blast ripped through a mosque located on the premises of a police station in Hangu, a district in the northwestern Khyber Pakhtunkhwa province, killing at least five people and wounding seven. Officials said two suicide bombers approached the po-

lice station mosque. Guards shot and killed one, but the other managed to reach the mosque and set off explosives. The mud-brick building collapsed with about 40 people inside, officials said. No arrests have been made in connection with Friday's bombing in Mastung, according to Jawed Lehri, the po-

mosque where some 500 faithful were gathered after Friday prayers for a procession to celebrate the birth of the Prophet, an observance known as Milad-un-Nabi. Most of the dead were buried in local graveyards and the remains of others were sent to hometowns, Lehri said. Body parts recovered from the site of bombing are under-

lice chief for the area. It happened in an open area near a

going DNA testing to determine if they belonged to the suspected perpetrator or perpetrators, he said. Mir Ali Mardan Domki, the caretaker chief minister of Baluchistan province, told reporters that all indications from the investigation so far suggest the attack was a suicide bombing. Counter-terrorism investigators were working to reach conclusions that would be shared with the nation soon, he said.

"We will take stern action against these terrorists and will not let them play with innocent lives," Domki said. The government intends to transfer critically wounded patients to Karachi for better treatment, and everyone injured and the families of the people killed will receive financial compensation, he said.

Assembly mulls overhauling residency law for foreigners

Amendments on domestic workers

KUWAIT CITY, Sept 30: Parliament's Committee for Interior and Defense Affairs will hold a meeting on Sunday to discuss the bill on amending the law related to foreigners' residency in Kuwait.

The bill, which consists of 37 articles split into seven chapters, allows Kuwaiti women to grant their non-Kuwaiti husbands and children permanent residency but under one condition, which is that she must not have obtained Kuwaiti citizenship as per article 8, i.e., acquiring citizenship because of getting married to a Kuwaiti


citizen. Former non-Kuwaiti wives or widows of Kuwaiti men are allowed to obtain permanent residency as long as they have children from that marriage.

According to the bill, hotels and furnished rental apartments must inform the relevant department at the Ministry of Interior about the names of their foreign clients and the dates of their check-in and check-out.

The fees for residency renewal and entry visa will be determined by a ministerial decision to be issued by the minister of Interior.

The bill imposes penalties of maximum three-year imprisonment and/ or a fine ranging from KD 5,000 to KD 10,000 against individuals who are accused of human trafficking by bringing in expatriate workers after receiving money from them.

Recent declaration 'baseless'

Academics refute Iraqi court's Khor decision

KUWAIT CITY, Sept 30, (KUNA): Academics have refuted the historic and legal allegations in the recent baseless declaration made by Iraq's supreme federal court regarding the treaty for regulating navigation in Khor Abdullah - inked by Kuwait and Iraq in 2012.

The academic figures, in an interview by Kuwait News Agency and Kuwait Television organized by the Kuwaiti Research and Studies Center on Saturday, lauded United Nations Security Council Resolution 833 issued in 1993 on demarcating the international borders between the two countries and respecting the international

law regarding the international navigation. In this respect, Dr. Ali Al-Rashidi, a law professor at Kuwait University, said during the interview that the treaty had been worked out after consultations between the two countries, and that it was endorsed by the Iraqi parliament and published by the official Iraqi gazette. It had also been delivered to the UN by Iraq's permanent delegate at the international organization, while affirming that it was compulsory and that Iraq was determined to implement it.

Dr. Al-Rashidi added that the Iraqi federal court in 2014, following a challenge forwarded by a member of the Iraqi parliament, stated that the law issued by the parliament for endorsing

the treaty was sufficient from a legal perspective in line with the Iraqi Constitution, thus the tribunal explained that it did not contravene the

Clarifying further, Dr. Al-Rashidi noted that following the court decision in 2014, there was consensus on the agreement by the three authorities in Iraq, where the government approved it, the parliament endorsed the accord and the supreme court issued an irreversible rule, stipulating soundness of the treaty constitutional status.

Moreover, he affirmed that four factors challenge the latest court rule, noting that the recent appeal was presented by the same Iraqi MP who had filed the previous one; reasons of the new contestation are the same of the past ones. Additionally, the latest court decision contradicted the Vienna convention for treaties (1969) that affirmed that any treaty is compelling to the sig-

Meanwhile, KU's history professor Dr. Abdullah Al-Najdi said it was not the firt time that Iraq would make such allegations against Kuwait, would try to belittle the State of Kuwait and ransack its historic rights along the borders.

The controversial historic narration presented by the Iraqi tribunal should not have come from

a court that issues technical rules that take into consideration the constitution and its provisions, "unless there is an illicit desire that reminds us of the night ahead of the flagrant Iraqi aggression in 1990," and the previous breaches by the Iraqi governments that attempted to belittle Kuwait's role and abstain from demarcating the borders between the two countries.

Dr. Al-Najdi indicated that 1973 maps showed that Kuwait's borders stretched to Khor Abdullah. A map by a German scientist in 1818 showed the Arab Peninsula including Kuwait with its borders totally covering Khor Abdullah. During era of Sheikh Mubarak Al-Sabah,

a treaty was signed with Britain and Kuwait's borders were drawn before emergence of mod-Dr. Rashed Al-Sanea, a professor of prime education, said the 1963 treaty stipulated the

demarcation of the borders between Kuwait and Iraq and it was endorsed by Kuwaiti and Iraqi Refuting claims that Iraq has no access to the

sea, he said that the country has six ports and a shore stretching from Ras Al-Bisheh to Khor Al-Zubair.

'We embraced energy transition 20 years ago'

UAE's AI Jaber defends nation hosting climate talks DUBAI, Sept 30, (AP): The Emirati president-designate for

the upcoming United Nations COP28 climate conference offered a full-throated defense Saturday of his nation hosting the talks, dismissing those who "just go on the attack without knowing anything, without knowing who we are.'

Climate activists roundly criticized Sultan Al Jaber's appointment as the president-designate of the talks because he serves as the CEO of the Abu Dhabi National Oil Co., which is seeking to boost its production of carbon-emitting crude

oil and natural gas. Back before a quiet, hometown crowd and an amenable moderator after attending the U.N. General Assembly, Al Jaber pointed to his 20 years of work on renewable energy as a sign that he and the Emirates represent the best chance to reach a consensus to address climate change worldwide.

"The world only, for whatever reason, views us as an oil-and-gas nation," he said. "We have moved beyond oil and gas 20 years ago. We embraced the energy transition

He added: "We don't become passionate or ideological or so emotional. We're business-oriented. We're results-

Al Jaber, a 50-year-old longtime climate envoy, is a trusted confidant of UAE leader Sheikh Mohammed bin Zayed Al Nahyan. He's been behind tens of billions of dollars spent or pledged toward renewable energy in the federation of seven sheikhdoms on the Arabian Peninsula - but also leads an oil company that pumps some 4 million barrels of crude a day and hopes to expand to 5 million daily.

Addressing the world's reliance on crude oil, Al Jaber issued a challenge to the audience listening to him at Dubai's visually striking Museum of the Future: Tell him how to immediately stop the use of all fossil fuels.

"Some are promoting the fact that we can just unplug the world from the current energy system and with a flick of a switch, we can just initiate a new energy system," he said. "That doesn't work. It won't work. ... So we need to sober up and be more realistic and more practical."

Public benefit associations say event held without inviting them

Info expresses appreciation over symposium on 'New Media Law'

KUWAIT CITY, Sept 30: The Ministry of Information expressed appreciation for the public symposium that was organized to present its views on the proposed amendments to the laws on printing and publishing, audio-visual, and electronic crimes under the so-called "New Media Law", reports Al-Seyassah daily.

However, the public benefit associations expressed their dissatisfaction with the fact that the symposium was held without inviting them, despite their essential role in empowering society in order to promote it to the reality of citizenship and their participation in building and de-

In a statement issued on Friday by a total of 13 public benefit associations, it was said, "This marginalization, which has become a trait in the government agencies' dealings with civil society organizations, indicates a real defect in understanding roles and responsibilities, despite the government's inclusion in the provisions of the Kuwait Development Plan 2035, and its work program titled "The necessity of joint cooperation between the government, the private sector and civil society.'

The associations denounced the Ministry of Information's neglect to issue an official invitation to them to attend the media symposium on the "New Media Law" and the accompanying media misinformation regarding civil society sector's approval of the proposed amendments.

They demanded empowerment as their inherent right to participate in proposing the required amendments, stressing that any real construction process requires the partnership of civil society organizations.

The associations appealed to the National Assembly to stand in solidarity with their principled position, calling for an end to the approach of marginalizing the role of civil society organizations and protecting their right to participate in building and development.

They stressed that it is the responsibility of the media to defend public freedoms, guarantee people's right to knowledge, manage free discussions, transmit them transparently to the public, defend the interests of society, respect its values, and respect society's right to administer justice, but this can only be achieved by adopting the principle of partnership and respect for all parties.

The statement was signed by Kuwait Transparency Society, Women's Cultural and Social Society, Kuwait Society of Graduates, Kuwait Society of Lawyers, Kuwait Association for Protecting Public Funds, Kuwait Society For National Fraternity, Kuwait Association for Information Security, Kuwait Society for Human Rights, Kuwait Society for Education Quality, the National Association of Familial Security "Rawasi", National Society for Child Protection, Developmental Entrepreneurship Association, and the National Fund for SME Development.

No human casualties ... huge traffic jam reported

Truck collides with bridge under construction

Al-Seyassah/Arab Times Staff KUWAIT CITY, Sept 30: A truck collided with a bridge under construction on the Fifth Ring Road opposite Ardiya

area yesterday afternoon, resulting in a massive traffic jam but no human casualties. Due to the traffic jam, vehicles had to be diverted to Mohammed bin Al-Qasim Street. According to the Public Relations and Media Department of the Kuwait Fire Service Directorate, when the

Operations Room received information about the accident. officers from the Ministry of Interior and firefighters from Ardiva Fire Station were dispatched to the location. The team discovered upon arrival that the accident occurred as a result of the truck colliding with the bridge under construction, which led to one of the iron columns falling on a vehicle. Within two hours, they were able to

reopen the road, after shifting one of the iron columns that In this regard, the Public Authority for Road and Transportation (PART) issued a press statement to explain that the truck was carrying bricks at a higher height than what is authorized. This caused the vehicle to hit the bridge and get stuck under one of the temporary metal beams of the bridge on the Fifth Ring Road (H T/266), which led to the

Department to secure the road to remove the metal bars and then reopen the road.

Municipality answers questions on development of Kabd Road

KUWAIT CITY, Sept 30: The executive branch of Kuwait Municipality issued a statement in response to the questions presented by the Deputy Chairman of the Municipal Council Khaled Al-Mutairi regarding the development of the Kabd Road, which extends from the Sulaibiya Bridge to the Kabd's livestock pens, and is considered one of the vital and important roads in Kuwait because it serves West Abdullah Al-Mubarak, the Sulaibiya Water Pump, the Sulaibiya Farms, the Farwaniya Stables, and the camel racing

Kabd Road, despite experiencing high traffic density, is a neglected road consisting of only two lanes, in very poor condition, and has not been developed since its con-

In response to Al-Mutairi's question about the existence of a plan to rehabilitate and develop the road, the municipality said part of the Kabd-Sulaibiya road falls within the advisory agreement for studying, designing and supervising the construction and maintenance of the development of the Kabd-Sulaibiya road, from which two contracts emerge.

When asked about the scheduled date for implementing the project and the expected time period for completing its development, the municipality reported that the Municipal Council approved the final design of the project, and documents are being prepared for the tender.

As for the expected date for tendering each of the two contracts for the project, one of them was included in the draft budget of the Public Authority for Roads and Transportation for the 2023/2024 fiscal year and has not been approved yet, while the other contract will be included in future budgets.

KUWAIT CITY, Sept 30: Sabaa Al-Dousari, Head of the Voluntary Committee of the People of Mutlaa City, warned of an environmental catastrophe to be witnessed in the Mutla City due to lack of sewage stations in two areas, especially after establishing between 300 and 500 housing plots and operating some services, during the upcoming rainy season.

In a press statement, he explained that the concept of the tender No. H/208, which stipulates the establishment, operation, and maintenance of the Mutlaa purification station, was formulated more than six years ago. Unfortunately, its delay happened due to the companies' struggle over the tender. There is nothing new except "floating and canceling. Now, according to the latest information, the tender was floated on August 30, 2023 but without achieving anything significant.

Temporary

The current situation in Mutla City urgently requires finding a temporary sewage station, especially after delivering electricity to the people's plots, which exceed 300 in number. There is no way to dispose of the sewage except after the citizens connected the sewage connection to the main sewer.

The biggest problem is the lack of a water treatment plant, even if it is temporary, in Mutla city. The emergence of unpleasant odors due to the high level of

sewage water there is expected. Al-Dousari said, "We continue to send our message to His Highness the Prime Minister and to the Minister of Public Works to expedite the work of a temporary water treatment plant, award the tender, and follow up with the implementing contractor, as the duration of the implementation of the plant is not less than two

years" He stressed that the citizens received their plots according to the "paper" plan eight years ago, but they are not able to live there, and the rent allowance will be cut due to the connection of electricity, and the deduction of the Credit Bank installment.

Al-Dousari called on the government to postpone the deduction of the rent allowance and the Credit Bank installment until the establishment of all necessary services are completed

MPW responds to SAB's observations

MPW affirms keenness to issue tenders for projects listed for implementation

KUWAIT CITY, Sept 30: The Ministry of Public Works affirmed its keenness to issue tenders for projects listed for implementation following the completion of the design, reports Al-Seyassah

In response to the State Audit Bureau's observations regarding the delay in completion of a number of projects, the ministry explained that the project to expand the main building of the Public Authority for Civil Information (PACI) will be implemented from the budget of the beneficiary entity. To date there is no approval for it from the authority itself, even though it had previously been addressed in this regard.

Regarding the establishment, completion, maintenance and furnishing of the back area coordination command building project, the ministry said a notification had previously been submitted by the Ministry of Interior to the Ministry of Public Works that the project comes after correctional institutions and information systems in priority, and it was contacted to include the project in the 2024/2025 budget.

With regard to the establishment, design and supervision of the implementation of the correctional institutions complex project, the ministry said the Ministry of Finance and the beneficiary party have been addressed in several correspondences to provide the necessary budget to put the project forward for implementation. Measures are being taken to include it in the 2024/2025 budget.

Licenses

Regarding the study, design and supervision of the project of the General Administration of Inspection buildings, the ministry explained that licenses are being renewed for the possibility of offering it for implementation. The Ministry of Interior requested that the project be given second priority after correctional institutions.

The Ministry of Interior changed the location of the project after completing the design. The change order for the office will be issued, as the Ministry of Finance approved it recently. It is expected to be issued in the next fiscal

The Ministry of Public Works stated that the project to study, design and supervise the implementation of the Farwaniya Cultural Center building is included in the budget of the beneficiary, adding that there is no allocation to date for the project implementation budget from the beneficiary, which has previously been contacted in this re-

Regarding the study, design and su-pervision of the implementation of the Voluntary Work Center building in Capital Governorate, the ministry said that the beneficiary party requested to postpone the launch of the project. A letter was received from the ministry requesting the launch of the project in the 2024/2025 fiscal year.

As for the study, design and supervision of the implementation of the Safat Post Office Building project, the ministry said, "To date, there is no allocation for the project implementation budget. The beneficiary party has been addressed in this regard. The project implementation budget is on the beneficiary party.

Beneficiary

The ministry confirmed that it is currently coordinating with the beneficiary entities regarding the possibility of presenting projects for implementation.

In its latest report, the State Audit Bureau criticized what it described as 'the Ministry of Public Works' shortcomings in studying and preparing, and its lack of good coordination with the relevant authorities," which resulted in eight contracts not being offered for the establishment and completion of construction projects in four tenders, despite the completion of the design work for some of them more than five

The completion of some other consulting agreements emanating from these contracts, amounting to a total of KD 7,315,969, was delayed, which exposes these contracts to the occurrence of amendments due to the passage of time between the design and implementation work, and leading to an increase in the total cost of the contracts and failure to benefit from the projects in the times specified for them.

Police nab citizen on run with 15 years imprisonment for thefts

KUWAIT CITY, Sept 30: A Kuwaiti citizen, who was wanted by law after being sentenced to 15 years in prison in connection with a number of vehicle theft cases, was arrested by Jahra police officers. They also arrested six other individuals who were sentenced to imprisonment. The seven individuals were referred to the concerned authorities.

According to a security source, the detectives, after discovering the whereabouts of the car theft suspect, they managed to set a trap into which the suspect fell. Upon further inquiry, it was discovered that he was wanted by the law to serve a 15-year jail sentence for stealing cars.

The officers also managed to arrest a Bedoun

resident who was wanted to serve a jail term of six years for similar crimes. Both were referred to the concerned authorities for necessary legal

Imprisonment upheld: The Court of Cassation upheld the verdict issued by the Court of Appeals for the imprisonment of two Kuwaiti citizens for a period of three years and four months each after they were convicted of causing two individuals permanent disability by intentionally colliding with their car and damaging it.

The Public Prosecution had accused the two defendants of intentionally causing serious harm to the two victims, which led to the first victim suffering a permanent disability and the second suffering various injuries, by intentionally hitting the two victims with two cars. In her complaint, the plaintiff counsel Lawyer Elaf Al-Saleh said the defendants, after a quarrel with the victim's family, planned to kill the two victims, and headed to their house to bring two cars. The first one collided with the first victim's car twice, back and forth, and the second car hit the second victim's car once, which led to the injuries reported in the foren-The Criminal Court ruled that the defendants

be imprisoned for five years, and the Court of Appeals ruled to amend the ruling to imprison them for three years and four months. The Court of Cassation upheld the ruling of the Court of Appeals, and referred the civil case to the concerned court to determine the value of the compensation.

'Fundamental structure of family breaks up with divorce rates rise'

"THE Kuwaiti woman led a serene and content life for a while, enveloped by the warmth of her family. She found happiness in fulfilling personal duties, pausing in prayer, displaying tenderness to her child, or engaging in comforting conversations with neighbors," columnist **Dr Abdul Rahman Al Jeeran** wrote for **Al-Rai** daily.

"Every action carried honor for her, grounded in her obedience to her father, trust in her husband's guidance, and her willingness to compromise when necessary.

"She comprehended the essence of family love but remained unaware of romantic love's intricacies. The allure of romantic relationships eluded her. Her affection for her husband mirrored her love for her son – pure, familial, and uncomplicat-

ed. While society emphasized love as the foundation of marriage, she believed that marriage was the bedrock of love.

"However, modern influences deceived her by asserting that love should precede marriage. Consequently, she began to gaze at men, seeking love, which distracted her from the sanctity of marriage. She fell prey to this deception, seeking new companions to rekindle

what previous relationships had extinguished, unable to hold onto the old or fully embrace the new.

"Yet another deception portrayed a woman's happiness as contingent on her husband being her lover. Unfamiliar with this perspective, she sought new partners, hoping for a fulfilling love life. Society's standards warped her self-image, urging her to pursue cosmetic enhancements to meet contemporary beauty ideals. She immersed herself in the digital world, striving to satisfy societal whims, but often faced rejection in an oversupplied market.

"Encouraged by the concept of coeducation, she learned a variety of skills but overlooked nurturing her child. The patriarchal society's influence loomed large, undermining her confidence in managing her affairs. Unjustified authorities arose within the family, contrary to the intended guardianship outlined by God. This led her to rebel against traditional authorities, disrupting the once warm and harmonious household.

"Further deception suggested that she should choose her own spouse to secure future happiness. However, the courtship path often led her to undesirable matches, diminishing the initial happiness of marriage and culminating in divorces, legal battles, and lingering misery.

"With the escalating divorce rates, the fundamental structure of the family disintegrated. Both genders fell short of fulfilling their roles, and family spaces turned somber. Homes transformed into isolated spaces, housing fearful men disenchanted with marriage and unmarried women."

Also:

"Observing the current state of public affairs in the country, one is struck by the deteriorating state of political work both in the executive and parliamentary domains. Both have descended into a realm of chaos and confusion in decision-making and directions," columnist **Dr. Muhammad Al-Maqati** wrote for **Al-Jarida** daily.

"Matters crucial to the nation's existence, sovereignty, and the protection of its citizenship and identity are disregarded. Deliberately orchestrated plans ensure these matters are concealed, delayed, and even neglected, becoming subjects for bargaining and electoral gain at the expense of the state's independence and sovereignty.

"A clear example of this neglect can be seen in the handling of nationality and citizenship issues across all aspects. Kuwaiti nationality and national identity have been subject to conspiracies and calamities, manipulated through political naturalization to establish loyalties and gain immediate favor.

"This tampering evolved into planned political strategies aimed at destabilizing the state's political fabric. Shockingly, we have seen individuals holding positions in the National Assembly who acquired citizenship through dubious naturalization practices.

"The catastrophic implications on national existence and identity are evident when legislators, responsible for legislation, face suspicions and questions regarding their citizenship acquisition. This is particularly concerning when citizenship is granted contrary to Article 1, which is only proven by Law No. 15 of 1959 for those from the generation of the founders or their children.

"Legislators infiltrated the Parliament, and many of them hastily proposed laws for naturalization that violated loyalty and belonging rules, undermining national identity. Laws were enacted to grant citizenship annually, deviating from established executive and sovereign authority.

"Furthermore, amendments wrongly changed the status of a naturalized person to an "originally" Kuwaiti, contradicting the constitutional text defining Kuwaiti status in 1962 in Article 82. The Constitution, based on Law No. 15 of 1959, defined this status, and attempts to alter it through legislative tampering disregard constitutional provisions.

"In this atmosphere of uncertainty and the composition of the nation's assemblies, the country witnessed numerous cases of nationality forgery, leading to court rulings and government decisions to withdraw hundreds of such cases.

"The issue of dual citizenship poses a substantial threat to state sovereignty, evident in the significant increase in voters over the years, highlighting the imbalance and risks associated with citizenship and national identity.

"Unfortunately, Parliament's priorities and actions don't align with safeguarding the nation's independence and identity. Those expected to protect national identity remain silent, while new citizens, due to naturalization tampering, openly push for further naturalization, obstructing the correction of citizenship conditions.

"The priorities of Council members reflect a misguided focus that does not serve the public interest and disregards the Constitution, undermining national identity.

"Regrettably, their attention is more drawn towards electoral gains and irrational populist demands, making parliamentary work lose its essence, focusing on superficial remedies rather than defending the homeland and its citizens. Equally concerning is a government that seems to have lost its direction, lacking the ability to implement, confront, or shoulder its responsibilities.

"The government's program reflects these misguided priorities, failing to address critical issues and instead emphasizing less significant concerns like establishing the Public Authority for Citizenship and the Central Policy Agency."

"The visit of His Highness the Crown Prince Sheikh Mishal Al-Ahmad Al-Sabah to China, in response to the invitation extended to him by the Chinese President with the aim of strengthening bilateral relations and opening new horizons in areas of close cooperation between the two countries, has ended," columnist **Dr. Bahija Behbehani** wrote for **Al-Qabas** daily.

"Kuwait can not forget the support it received from China during the brutal Iraqi invasion in 1990, and its participation in extinguishing the

burning oil wells.

"For your information, Kuwait was the first Gulf country to establish full diplomatic relations with China in 1971. It was also the first Arab country that was keen to strengthen cooperation with China in various fields, and enhance the bonds of common interests, especially with the presentation of its strategic development vision "New Kuwait 2035", which seeks to develop a diversified and sustainable economy.

"The former Amir of Kuwait Sheikh Sabah Al-Ahmad had also made an official visit to China to strengthen the political and economic partnership between the two countries.

"Kuwait is considered the seventh largest exporter of crude oil imports to China. The number of Chinese companies currently operating in Kuwait is about 60 companies that contribute to more than 80 projects, and participate in building infrastructure and economic development in Kuwait.

"During the current visit, a joint statement was issued regarding the five-year plan for bilateral cooperation between the two countries for the years 2024 to 2028. About seven memorandums of understanding were signed between Kuwait and China, which include large construction projects to be carried out by Chinese companies in Kuwait, including renewable energy and the Mubarak Al-Kabeer Port, in addition to cities, housing and sanitation, after the majority of officials failed to manage government institutions and were unable to achieve quality through productivity.

"We, the citizens, have almost given up on development and reform, after the efforts of the majority of officials failed to reduce corruption with the continued reliance on oil as the sole source of income, the deterioration in the fields of health and education and their lack of quality productivity, continuation of the housing issue, the tragic imbalance in the demographic composition, and the preoccupation of the representatives of the National Assembly with matters that are completely far from the content of sustainable development, in addition to other deviations from the correct path of development and from rising the country to the ranks of major countries."

"The Deputy Prime Minister, Minister of Oil, and Minister of State for Economic Affairs and Investment Dr. Saad Al-Barrak says the government of Kuwait seeks to update the New Kuwait 2035 vision and make it 2024-2040," columnist **Jassem Al-Homar** wrote for **Al-Anba** daily.

"The justification for this update of Kuwait's vision is to include the changes that occurred in the last three years in health, economic and political fields in order to make it better and reflect more clearly in the plan.

"We can say that the vision of the New Kuwait 2035 in its previous form was created during the era of His Highness the late Amir Sheikh Sabah Al-Ahmad (May God have mercy on him) who visited China in 2018 and concluded many agreements in many fields. Eight people arrested in 'raid' on illegal eatery serving pork, liquor

Securitymen nab 343 law violators in several areas

KUWAIT Sept 30: As part of the efforts of the **Criminal Security** Sector to arrest violators and outlaws, the General Department of Criminal Investigation arrested eight individuals for transforming a private residence into an unlicensed restaurant in Mangaf area, and serving patrons imported and locally manufactured liquor and pork, reports Al-Seyassah daily.

The Criminal Investigation and Licensing Department, through daily activity and intensification of search and investigation operations, discovered that several people were operating an unlicensed restaurant, and serving customers pork and alcoholic beverages.

Permission

After obtaining the necessary legal permission, a team was formed by the Criminal Investigation and Licensing Department and all those responsible for managing the restaurant were arrested.

A total of 489 bottles of locally manufactured alcoholic beverages, 54 plastic containers of alcoholic materials, ten imported alcoholic bottles, and 218 kilograms of pork meat were confiscated by the Public Authority for Food and Nutrition. The sums of money generated from this illegal business were also seized.

The suspects and the seized items were referred to the concerned authorities for necessary legal measures.

343 expats arrested: The Investigations Department of the General Administration of Residency Affairs reported the arrest of 343 individuals from different nationalities in a security operation targeting violations of residence and labor laws, reports Al-Anba daily.

These operations were carried out across several areas including the Shuwaikh Industrial Area, Farwaniya, Hawalli, Mubarak Al-Kabeer, Salmiya, and Al-Mirqab.

All offenders have been handed over to the appropriate authorities for requisite legal actions.

7 held for car racing: The security personnel from the General Traffic Department have arrested seven individuals for orchestrating unauthorized racing events in the Saad Al-Abdullah suburb on Friday, reports Al-Anba daily.

A security source informed the daily that this operation was conducted under the oversight and guidance of Major General Abdulah Al-Rajaib, the Undersecretary of the Ministry of Interior for Public Security Affairs, and Brigadier General Saleh Uqla Al-Azmi, the Acting Director General of Jahra Security.

In the course of the crackdown, the General Traffic Department personnel issued 16 traffic citations and seized seven sports cars and fourwheel drive vehicles, towing them to the GTD garage.

PoA to travel: The General Administration of Customs announced the launch of the service for issuing power-of-attorney to travel in a Kuwaiti vehicle through the "Services" menu in the Al-Sahel app, thus allowing citizens to travel by vehicle to the Gulf Cooperation Council countries using someone else's vehicle, reports Al-Rai doily.

Withdrawal of licenses 'arbitrary'

Pharmaceutical Association criticizes ministry for its decisions over closure

KUWAIT CITY, Sept 30: A member of the Board of Directors of the Kuwait Pharmaceutical Association Muhammad Nahis Al-Enezi affirmed that the manner in which more than 60 pharmacies were violated was marred by haste, selectivity, and discrimination in applying the law.

In a press statement, he stressed that the decisions to close pharmacies and withdraw licenses were arbitrary and unprecedented.

Al-Enezi praised the existence of an impartial judiciary that all resort to in the State of Kuwait, revealing that the decisions resulted in submitting more than 60 grievances to the Minister of Health and filing fast-track cases at the Administrative Court against the Ministry of Health and the Ministry of Commerce and Industry to stop the harm and abuse inflicted on pharmacy owners.

He indicated that such decisions harm the reputation of pharmacists and license holders.

It is noteworthy that the Ministry of Health had issued a decision to close about 65 private pharmacies in mid-August, which led to the affected pharmacists resorting to the Administrative Court and filing a lawsuit to cancel the decision. A few days ago, the pharmacists succeeded in obtaining an urgent judicial ruling from the Administrative Court to cancel the decision of the Ministry of Health and reopen their pharmacies.

Meanwhile, Al-Enezi appealed to His Highness the Prime Minister Sheikh Ahmad Al-Nawaf to hold accountable any minister or undersecretary who issues wrong administrative decisions that result in the wastage of state funds (or the ministry concerned) in the form of financial compensation in the event that final judicial rulings are issued.

He stressed the importance of every state official bearing the consequences of his or her decisions.

Al-Enezi said, "The laws regulating the sector of pharmacy and distribution of medicines are still under review in the relevant ministerial committee. The Kuwait Pharmaceutical Association is represented in this committee, but it does not hold its meetings regularly, and is rather slow in reviewing the laws."

He also called for amending the laws and placing them in a sound legal framework to improve the work environment.

However, Al-Enezi said he wondered about the reasons for the "harsh campaign against pharmacy owners in the private sector despite their commitment to many new circulars regulating the sale of medicines" including electronic payment.

Furthermore, Kuwaiti pharmacist Shaima Abdul Hussein affirmed that the decision to withdraw licenses and close pharmacies was the result of simple administrative errors that do not amount to closure and do not affect the lives and health of patients.

She praised the rulings of "the honest Kuwaiti judiciary" and congratulated her colleagues in the profession for the return of their rights and the opening of their pharmacies.

In addition, pharmacist Bashayer Al-Mahrous expressed her happiness with the Administrative Court's decision to cancel the decisions of the Ministry of Health.

She said, "We were completely confident about the fairness and integrity of the Kuwaiti judiciary in supporting private sector pharmacists and lifting injustice against them.

The decision to close pharmacies was made in an arbitrary manner, causing severe material and moral losses to pharmacists, patients, and the state." She praised the fairness of the Kuwaiti judiciary.



Kuwait's southern coral islands at a crossroads

Environmentalists call for urgent action to protect fragile island ecosystems

KUWAIT CITY, Sept 30: Several environmental activists have emphasized the importance of conducting a thorough assessment of the condition of the islands and their capacity to accommodate visitors, reports Al-Rai daily

They point out that the coral reefs on these islands are at risk due to human activities, necessitating a serious effort to preserve them. They argue that there is an urgent need to either regulate visits to these islands or consider complete closures. They also propose the conversion of these islands into natural reserves to ensure their environmental sustainability.

In contrast to these environmental concerns, others advocate for finding solutions that do not involve banning visits to these atolls

They stress the importance of preserving the living organisms on the islands while permitting visits. One proposed solution is the deployment of police or environmental observers from the Environment Public Authority, tasked with preserv-

Jinan Behzad, the Secretary-General of the Kuwaiti Society for Environmen-

tal Protection, calls for a comprehensive study of the southern Kuwaiti islands to evaluate their sensitivity and fragility to human activities and climate change, with a focus on biodiversity and ecosystem health. She acknowledges that these islands attract a significant number of visitors, potentially exceeding their carrying

Behzad highlights the significance of coral islands as Kuwait's natural resources and suggests that converting them into marine natural reserves can help reduce waste and protect marine life. She emphasizes the need for an integrated network of reserves at a national or regional scale to maintain and enhance coastal ecosystems and food chains.

Behzad also mentions the potential for developing natural and artificial sea islands, such as Jisr Jaber and Green Island, with existing infrastructure and proximity to tourists, making them suitable for innovative projects and advanced technology implementation.

Mahmoud Ashkanani, an environmental projects officer with the diving team,

shares the successful example of the Maldives, where the private sector invested in offshore islands, provided environmental monitoring offices on each island, and rehabilitated coral reefs. He identifies boat anchoring as a major source of island damage and suggests designating parts of the islands as reserves to prevent access by boats, cruisers, or people.

Walid Al-Fadil, the head of the Kuwaiti diving team, supports projects for the southern coral islands that protect the marine environment and its organisms while allowing people to enjoy these places. He suggests deploying special police or environmental observers to protect the islands.

Al-Fadil also recommends learning from foreign experiences, particularly the Australian model, where similar islands have been transformed into eco-resorts while maintaining conservation efforts. He emphasizes the need for stricter environmental control and severe punishment for violators, as well as considering sustainable development and tourism projects after conducting thorough studies and ensuring compliance with regulations.

Kuwait expedites govt digitalization

CAIT to drive digital transformation

KUWAIT CITY, Sept 30: The Council of Ministers has delegated the Central Agency for Information Technology (CAIT) with the task of establishing regular coordination with all government ministries, agencies, and institutions. The goal is to facilitate the seamless implementation of automatic connectivity among these entities, reports Al-Rai daily.

This initiative aims to achieve and advance digital transformation within the State of Kuwait, enhance government information security across all domains, and streamline and simplify government procedures for citizens. This, in turn, contributes to efficient oversight by state entities and expedites the collection of dues from various sources.

Secretary-General of the Council of Ministers, Saleh Al-Mulla, communicated this decision through a letter to the ministers, including Dr. Adel Al-Manea, the Minister of Education and Minister of Higher Education and Scientific Research. He noted that the Audit Bureau has put forth certain proposed findings and recommendations concerning the automatic linking of government agencies.

Commitment

In this context, he elaborated on the importance of the Bureau's role and its commitment to shedding light on the matter of automatic connectivity among government agencies. This significance lies in the development of a comprehensive system to enhance electronic transactions, tighten internal control systems, and target areas of fiscal waste within government spending. To achieve these goals, several critical steps and procedures are necessary:

1. Accelerating the development of strategic policies and plans for technological development at the state level, encompassing digital transformation and cybersecurity, with input from relevant authorities.

2. Automating work processes and fostering automated connectivity within government entities, especially for transactions directly related to providing services to citizens and other organizations

3. Updating existing automated systems in certain government agencies to align with the latest advancements in information services.

4. Modernizing and enhancing the information technology infrastructure to keep pace with evolving transformations and developments.

5. Strengthening oversight to ensure allocated funds in the general budget are utilized for their intended purposes, controlling and optimizing expenditures, and diversifying revenue sources.

6. Empowering the Central Agency for Information Technology to exercise its designated powers in accordance with its establishment Decree No. 266 of 2006, amended by Decree No. 322 of 2006.

7. Promptly activating the powers of the Communications and Information Technology Authority by developing and updating plans and programs in alignment with the state's overarching policies.

8. Implementing the decisions issued by the Council of Ministers concerning automatic connectivity among government agencies.

9. Enabling the National Center for Cybersecurity to expeditiously fulfill its responsibilities as outlined in its establishment Decree No. 37

Additionally, the report highlighted two separate reports prepared by the Audit Bureau, which were based on assignments from the National Assembly. These reports addressed the reasons for government agencies' delays in digital and technical transformation and the topic of cybersecurity and information technology.

Four proposals from the Audit Bureau were presented to the Public Services Committee during its meeting on September 5th:

1. Assign the Central Agency for Information Technology to formulate an automated connection plan within three months, in collaboration with relevant entities such as the General Authority for Civil Information, Civil Service Bureau, Ministry of Health, Birth and Death Records, Ministry of Justice, Contract and Marriage Documentation, Public Authority for Manpower, Labor Support, Ministry of Social Affairs, Public Aid, Ministry of Interior, and other pertinent government bodies.

2. Establish a detailed timetable outlining specific procedures and delineating the responsibilities of each relevant party.

3. Grant the Central Agency for Information Technology the authority to invite any government agency that can assist in the process of automatic linking between government entities.

4. Mandate the Audit Bureau, in accordance with the Council of Ministers' directive, to present a follow-up report every three to six months to the Council of Ministers, assessing the adherence of relevant authorities to the approved

Kuwait University's rankings dip

The Kuwait University recorded a decline in the the World University Rankings for the year 2024, reports Al-Qabas daily.

The university's position has witnessed fluctuations between rises and falls in this classification over the past years, as during the years 2023 and 2022, it ranked between 801 and 1000, while in 2021 its position was 1001+ and in 2020 it was ranked 801-1000. The university obtained a score of 19.5 in the

teaching standard, 9.9 in the research environment standard, 55.5 in the research quality standard, and 66.4 in the international reputation standard. This decline comes after the university achieved

progress in the QS World University Rankings for the year 2024, issued last July.

The sources disclosed that withholding licenses for setting up camps in the forthcoming season for foreigners is conceivable, especially since some individuals have exploited the system for internal trade. The municipality aims to promote public camping, but simultaneously, certain violations and transgressions cannot be tolerated.

Faisal Al-Otaibi, the head of the spring camps committee, told the daily that the committee will convene a meeting early next week with the sanitation departments and road works in the municipality. Additionally, relevant authorities will be involved to devise an action plan for the complete removal of camps, whether licensed in the previous spring camping season or existing without a license.

Al-Otaibi explained that following the committee meeting, violators will be granted a 48-hour grace period to dismantle their tents; otherwise, necessarv actions will be taken. The municipality's bulldozers will be on standby, particularly since some camp locations pose significant dangers due to their proximity to gas and oil pipelines, high-voltage overhead power lines, and military and security installations.

Regarding penalties, Faisal Al-Otaibi, Chairman of the Spring Camps Committee, outlined that those with expired camp licenses will face the penalty of being deprived of camping in the upcoming season, in addition to the legal actions taken against them. As for unlicensed camps, the municipality and the Environment Public Authority will impose appropriate penalties and fines on their owners, along with the confiscation of tents.

PADA allocates 226 mln dinars for FY 2024-2025

KUWAIT CITY, Sept 30: The Planning Committee of the Public Authority for the Disabilities Affairs, chaired by the acting director, Al-Humaidi Al-Mutairi, and attended by deputy directors overseeing various sectors including educational, rehabilitation, medical, psychological, social, human, and financial aspects, estimated a budget of 226 million dinars for the upcoming fiscal year 2024-

This budget is earmarked to sustain a diverse array of services for 59,000 individuals with disabilities, reports Al-Rai daily.

Insider sources from the authority disclosed that each sector presented its financial requirements for the upcoming year, to ensure the provision of educational, rehabilitation, medical, psychological, and social services.

financial allocations These align with the stipulations in Law (8/2010) concerning the rights of persons with disabilities.

The budgetary increase to 226 million dinars is a result of the growing number of new individuals with disabilities and additional financial grants recently disbursed by the Authority.

The grants were sanctioned by the Financial Allocations Committee, comprising representatives from the Fatwa and Legislation Department and the Ministry of Finance.

Notably, the committee recently agreed to a 50-dinar per month increase in the basic pension for individuals with disabilities who are under 21 years old and receive their allowances from the Authority, as well as for adults aged 21 and above receiving a monthly pension from the Public Institution for Social Security

Airport passengers soar by 15 percent during summer season, DGCA reports

KUWAIT CITY, Sept 30: The Acting Director General of the Directorate General for Civil Aviation (DGCA) Emad Al-Jalawi affirmed that the airport witnessed an increase in the number of passengers this year compared to last year, indicating that an operational plan has been prepared based on the operational density of airlines and the increasing number of passengers, reports Al-Qabas daily.

He said, "Despite some of the negatives that occurred during the summer period such as delays in some flights and the expiry of some contracts concluded with companies implementing some logistical work, we were able to address many of these problems within a short period. We addressed some airline companies, and also the regulatory authorities to renew and offer some contracts for the airport."

Al-Jalawi explained that the number of passengers during the months of June, July and August amounted to about 4.365 million onboard 37,487 flights. The total number of passengers in

June reached 1.341 million, including 573,000 arrivals and 768,000 departures on 12,200 flights. The number of passengers in

July reached 1.446 million, including 640,000 arrivals and 806,000 departures on 12,468 flights.

The number of passengers in

August reached about 1.578 million passengers, including 774,000 arrivals and 804,000 departures, onboard 12,819 flights.

The increase in the rate of traffic this summer compared to last year amounted to 15 percent. The total number of passengers from June until the end of September is expected to reach about six million passengers. These numbers are similar to the levels in 2019, before the COVID-10 pandemic, which confirms the recovery of the air transport sector again.

'Fault lies in pervasive acceptance of corruption within the societal culture'



During the era of Cray Mackenzie, non-Muslims used to receive a monthly allowance of liquor which some would then sell to others, be they citizens or non-citizens. Today, citizens receive subsidized food from the Ku-

wait Supply Company and later sell it to expatriates at a significant profit. This has intensified the burden on security forces as the smuggling of subsidized food has witnessed a notable increase recently. Every month, attempts to smuggle tens of tons of subsidized food are thwarted at the borders.

The Kuwait Supply Company initially aimed to provide essential food items to citizens at cost price to assist them in managing their living expenses.

Over time, the company expanded its offerings to include unnecessary items. In the future, this list might encompass products like cigars and caviar, in addition to the already provided smoked salmon and Zubaidi fish. While the company has partially achieved its goal of assisting low-income citizens, it has inadvertently fostered corruption. Some citizens who do not require the assistance sell their share for smuggling.



food only highlight expatriates, without mentioning the citizens who sold these goods, despite the Ministry of Interior's clear stance on taking strong action against anyone manipulating the national economy.

Due to the escalating corruption at the Kuwait Supply Company, suspicion has fallen on its branch workers. They face accusations of selling subsidized food to smuggling gangs, supported by instances of lost or cancelled citizens' supply cards.

A cooperative union chairman proposed a corruptionfighting solution of replacing expatriate workers at Supply Company branches with nationals.

However, it's crucial to recognize that corruption, leading to infrastructure damage and spreading in various sectors, is not exclusive to any nationality.

The issue lies in the pervasive acceptance of corruption within the societal culture. In a society where cheating in exams is tolerated, smuggling subsidized milk powder is unfortunately not considered a significant issue.



Will pass on price hike to the final consumers

OIL prices are heading towards the ultimate level of \$100 per barrel. When it does, everybody will feel it. There is no doubt about that.

In the meantime, it is the best ever legitimate excuse to blame oil producing countries at any time, not knowing that oil producers will feel the pain of higher prices for all goods and services, as most of them import between about 50 to 95 percent of their needs from outside.

in oil prices in Al-Harami the end should be a breakeven scenario for efficient oil producing about expenditures and budgets, but

they are few in number. Now it seems that a level of \$100 is closer than before. Some oil producing countries have surpassed the \$99 level depending on the type of their crude oil that yields better and high-rated petroleum products in the global markets, or they charge premium over OPEC basket of \$97.50 per barrel.

Again, the concern is the expected critics of OPEC+ and its decision to curb supply and production, as some will claim this as the reason. The oil producers are not allowed to move oil prices forward but are struggling with higher cost of living, especially food and grain mainly because of the Russian occupation of Ukraine.

The other factor that markets are beginning to realize is that China has woken up and increased its call for oil. This will push the prices further until it reaches its peak by the end of 2025 when electric vehicles will take over. It is also supported by coal and natural gas, which are abundantly available, instead of depending on imported oil and to go for in US cur-

Also, the Russian Urals crude is now traded in the range of \$100, despite the G7 boycott and restriction on it to have a selling price of \$60 a barrel. It seems nobody is paying attention to such a level, and is buying instead at the market price of \$100 with seemingly an open hand.

The oil market will remain strong in the coming months with an increase in demand rate. It also seems other suppliers like USA producers will not be willing to invest more money into drilling and looking for new oils. It seems they are looking for better returns and dividends for the shareholders, and seeking to keep them happy and satisfied. This is possible as long as the price stays strong and the responsibility is passed on to OPEC+, and until the petroleum organization itself starts to leak or relax its rules on the voluntary cuts.

For the time being, we must wait for the \$100 level, and we will later hear about the global reactions, noises and the pointing of fingers. In the end, everybody will gain a little, but for sure not the entire \$100.

Cyprus hails Moody's two-notch credit rating upgrade

Cyprus on Saturday hailed a two-notch upgrade by credit rat-ings agency Moody's to bring the east Mediterranean island nation back into investment-grade territory a decade after a financial crisis left the country on the brink of bankruptcy.

President Nikos Christo-doulides said he was "deeply satisfied" with the upgrade that he said was the culmination of years of fiscal discipline and will translate into attracting quality foreign investment and creating new jobs.

"We unwaveringly continue on this path as a government ... and so we will carry on with our governance," Christodoulides said in a written message. "We will carry on buttressing our economy and

expanding its dynamic course." Moody's said in its statement the upgrade from Ba1 to Baa2 with a concurrent change in outlook from positive to stable is due to previous and continuing economic, fiscal and banking reforms, as well as a significant drop in bad bank loans.

The agency pointed to "sustained structural improvements" in the labor market, a rebound in public and private investments, a continuing drop in public debt and a jump in productivity that resulted in economic growth by more than 4% between 2014-2023. (AP)

Inflation drops to a two-year low in Europe

Drop offers hope, but higher oil prices loom

FRANKFURT, Germany, Sept 30, (AP): Inflation that has plagued Europeans declined sharply in September to the lowest level in two years, strengthening hopes that consumers will get relief from costlier groceries, vacations and haircuts - and that the European Central Bank won't have to further restrict the economy by raising interest rates from already-record highs.

The annual rate was 4.3% this month, a drop from 5.2% in August, and the lowest since October 2021, the European Union's statistics agency, Eurostat, said Friday. But recently higher oil prices are casting a shadow over prospects for quickly beating inflation down to the central bank's target of 2%.

Core inflation, which excludes volatile fuel and food prices, fell more than analysts expected - to 4.5% from 5.3%. The ECB closely watches this figure to assess how inflation is coming down.

The fall in core inflation "reinforces our view that the ECB has finished raising interest rates," said Jack Allen-Reynolds, deputy chief eurozone economist at Capital Economics. He predicted that the overall inflation rate would tumble to 3.5% by the end of the year.

While inflation is lower in the U.S., a measure closely tracked by the Federal Reserve accelerated in August to 3.5% compared with a year earlier, from 3.4% in July, boosted mainly by higher gasoline prices.

Meanwhile, eurozone energy prices dropped 4.7% in September, while food price inflation remained uncomfortably high at 8.8%

Readings across the major economies that use the euro currency were a mixed bag. Germany's annual inflation fell to 4.3% in September from 6.4% a month earlier, while Spain's increased to 3.2% from 2.4%.

Economists warn, however, that the large drop in Germany, the 20-country eurozone's largest economy, was exaggerated by a statistical quirk - the end of a subsidized transportation ticket and a fuel subsidy in September 2022 that had raised consumer prices that month.

The latest inflation figures follow what may have been the final interest rate increase by the ECB in its swift series of hikes. It brought its benchmark deposit rate to a record high of 4% this month, up from minus 0.5% in July 2022. ECB President Christine Lagarde said that if interest rate levels are maintained

for a "sufficiently long duration," that would make a substantial contribution to returning inflation to 2%, a goal the bank does not expect to reach until 2025.

High prices have been holding back the European economy because people's paychecks don't go as far as they used to in covering their bills, forcing them to cut back on other spending.

Economic growth has stagnated to just above zero in the first six months of the year, with some indicators pointing to a downturn in the current July-to-September quarter.

This burst of inflation was set off as the global economy rebounded from the COVID-19 pandemic, leading to shortages of parts and raw materials. It got worse when Russian invaded Ukraine, sending energy prices soaring as Moscow cut off most natural gas to Europe.

Supply chain bottlenecks and energy prices have eased, but inflation has worked its way through the economy. Prices are higher for services such as haircuts and hotel stays, and workers have demanded pay raises to make up for their lost purchasing power.

The ECB has been trying to get a handle on inflation by raising interest rates, which make it more expensive to borrow for big purchases such as houses or new factory equipment to expand a business. That reduces demand for goods and, in turn, inflation.

But higher rates also can weigh on economic growth, leaving the central bank facing a balancing act over how far to go.

Many economists think the ECB has finished raising rates unless something drastic happens to keep inflation from falling further. That could be a further increase in oil prices, which have risen recently after major producers Saudi Arabia and Russia extended production cuts.

Higher gas prices lift Fed's preferred inflation gauge

WASHINGTON, Sept 30, (AP): An inflation gauge closely tracked by the Federal Reserve rose in August, boosted mainly by higher gas prices. But measures of underlying inflation slowed in the latest sign that overall price pressures are still

moderating. Friday's report from the Commerce Department showed that prices rose 0.4% from July to August, up from just 0.2% the previous month. A 10% monthly spike in prices at the gas pump drove the increase.

Excluding volatile food and energy prices, though, "core" inflation rose by the smallest amount in nearly three years, evidence that inflation pressures continue to ease. Fed officials pay particular attention to core prices, which are considered a better gauge of where inflation might be headed. Last month's modest rise in core inflation could raise the likelihood that the Fed will leave interest rates unchanged at its next meeting Oct. 31-Nov. 1.

Core prices edged up 0.1% from July to August, down from July's 0.2%. It was the smallest monthly increase since November 2020. Compared with a year ago, core prices were up 3.9%, below July's reading of 4.2%. That was the slowest such increase in two years.

Borrowers reassessing budgets as student loan payments to resume

NEW YORK, Sept 30, (AP): Millions of Americans must start repaying their federal student loans again in October, with monthly payments averaging hundreds of dollars. To get ready, borrowers are cutting expenses, taking on additional work, and looking for options to reduce their monthly payments.

Megan McClelland, 38, said she has

started asking for October shifts with a catering company and a winery to help supplement her income.

McClelland's main job is as a counselor at Petaluma High School in California. During the more than three years payments were suspended because of the pandemic, she paid off her car loan and was able to save for the first time. She'll put the \$235 she was spending on her car payment toward her student loan, but that still leaves another \$270 or so she'll have to reallocate or earn.

"It had been a huge relief the past few years to not have that financial burden," she said. "In the next months, I'm looking to see where I can scale back in my budget. Probably less going out to eat, and more picking up side gigs."

Justin Cole, 35, of Little Rock, Arkansas, said he doesn't know how he's going to come up with the \$166 a month he'll owe starting in October. That's the estimated payment on his roughly \$19,000 of loans from paying for college more than 10 years ago.

"I'm already in a mountain of debt, and while I just got a raise at work, it doesn't go into effect until we're full staffed at my family practice clinic," he said.

Cole works the front office at a medical practice, checking in patients, handling records and managing payment collection. Some of his other debt comes from medical expenses after a car accident early in the pandemic. "If those loans were forgiven, I could

finally work on getting my credit up and actually saving money for once, he said. "If they were forgiven out of the blue, I'd be ecstatic.

The Supreme Court in July rejected a plan by President Joe Biden's administration to wipe away \$400 billion in

student loan debt. For now, Cole has applied for adjustments to his payments based on both the new SAVE plan and prior income-driven repayment options, which are listed as processing and "in review" on his account. The SAVE, or "Saving on a Valuable Education," plan allows borrowers to make lower payments based on a percentage of their discretionary income.

His major household expenses are "rent, car payments, groceries, and utilities - the same as everybody else,"

he said. Not yet clear is how millions of people suddenly having less discretionary

income might affect the economy. On an earnings call last month, the chief financial officer of Target said said workers are taking on more hours, and, for the first time, credit card debt

Other sources for relief for borrowers include: false certification, borrower defense, closed school, total/ permanent disability discharges, and alternate repayment programs like income-driven repayment.

McClelland, for her part, said she now spends a lot of time counseling high school students on how to avoid taking on burdensome loans.

"I had no financial guidance when I was younger, from my own parents or from school," she said. "I didn't ever understand the long term impact.'

Despite working while in school and since - moonlighting at Starbucks, wineries and restaurants as well as counseling - McClelland still has a balance of about \$38,000 in debt, from original loans of \$10,000 towards her undergraduate studies and \$40,000 for her masters in counseling at Sonoma State.

"I knew I wanted to go to college, and my parents didn't have any money," McClelland said. "I tell kids all the time, openly, 'As someone who was once in your shoes, I highly recommend finding a way to avoid taking out loans.' When you're 17 or 18 years old, you think, 'Oh, sure, I'll figure this out.' Then it's frustrating to still be in this financial situation.

Biden calls for up to 3 oil and gas lease sales in the Gulf of Mexico

WASHINGTON, Sept 30, (AP): President Joe Biden's administration on Friday proposed up to three oil and gas lease sales in the Gulf of Mexico, but none in Alaska, as it tries to navigate between energy companies seeking greater oil and gas production and environmental activists who want Biden to shut down new offshore drilling in the fight against climate change.

The five-year plan includes proposed sales in the Gulf of Mexico - the nation's primary offshore source of oil and gas - in 2025, 2027 and 2029. The three lease sales are the minimum number the Democratic administration could legally offer if it wants to continue expanding offshore wind develUnder the terms of a 2022 climate

law, the government must offer at least 60 million acres of offshore oil and gas leases in any one-year period before it can offer offshore wind leases

The provision tying offshore wind to oil and gas production was added by Democratic Sen. Joe Manchin of West Virginia, a top recipient of oil and gas donations and a key vote in favor of the climate law, which was approved with only Democratic votes in Congress. The landmark law, the Inflation Reduction Act, was signed by Biden as a key step to fight climate change but includes a number of provisions authored by Manchin, a centrist who represents an energy-producing state.

Qatar Airways exec says invasive examinations of passengers won't be repeated

CANBERRA, Australia, Sept 30, (AP): A senior Qatar Airways executive told an Australian Senate inquiry on Wednesday there would be no repeat of an incident at Doha's international airport in 2020 in which female passengers were subjected to invasive gynecological examinations.

Australian Transport Minister Catherine King said three weeks ago that the examinations of 13 Australian women who had boarded a Qatar Airways plane to Sydney were a factor in her decision in July to refuse the Qatar government-owned airline additional flights to Australia.

Qatar Airways Senior Vice President Matt Raos described the incident, which occurred when authorities were looking for the mother of a newborn baby found abandoned in a Hamad International Airport trash can, as "a one-off incident, a very extreme incident.'

"We've had nothing like it previous-

ly in our history and we're completely committed to ensuring nothing like this ever happens again," Raos told the

Raos was responding to government Sen. Tony Sheldon, who had asked for a guarantee on behalf of female passengers who feared they would be subjected to such treatment.

The Doha-based executive declined to detail the incident because five women are suing the airline in Australian Federal Court. "The outcome of that Federal Court

case is something that we will honor and abide," Raos said. The five Australian women, whose

names are suppressed by a court gag order, say they were taken off the flight to Sydney at Doha at gunpoint by guards and were searched without consent. Qatar Airways provided no response to their complaints and offered no apology, the women said.

Dubai World Challenge for Self-Driving Transport winners honored

Five universities were selected for the finals in the Local Academia category: Heriot-Watt University, Dubai, Khalifa University - Abu Dhabi, University of Dubai, University of Bolton - Ras Al Khaimah, and the American University of Sharjah.

His Highness Sheikh Hamdan bin Mohammed bin Rashid Al Maktoum honoured King Long Company from China who clinched the first place in the Industry Leaders category and was awarded US\$1 million. They presented a self-driving bus, six metres in length,

capable of reaching maximum speeds of 69 kilometres per hour and can accommodate 12 passengers. The bus is equipped with 27 cameras and sensors, with a battery that can be fully charged in 120 minutes.

Bright Drive Company from Egypt secured second place, garnering US\$750,000, for presenting a self-driving bus that is six metres in length and has a top speed of 69 kilometres per hour. This bus can accommodate up to 15 passengers and is uniquely equipped with 16 cameras and sensors and can be fully charged in 180 minutes. (AP)

US businesses see drop in cyberattacks, but risk high

STAMFORD, Conn., Sept 30: US businesses on the whole are gaining ground against cyber criminals after several years of increasingly severe threats, but the Las Vegas cyberattacks are a stark reminder of the cost of a

GetApp's 5th Annual Data Security Report reveals that the ransomware rate remains alarmingly high at 37%, despite meaningful improvements over the last year. While there is still work to be done, increased investments and training are likely behind these impressive gains: the study shows that, since last year, phishing links clicked by workers decreased 25% while ransomware attacks dropped 30%. Alarmingly, however, the report finds that only one in three businesses (34%) are training staff on social engineering techniques.

Survey

This survey of 872 workers including IT professionals and IT security managers uncovers six key trends on the cyber threat landscape as US businesses turn a corner with data

Most security leaders view AI as more friend than foe.

A key question is whether AI is doing more to help prevent attacks - or to launch them. According to 59% of IT security leaders, AI is more likely to help security teams enhance their defenses than it is to strengthen cyber criminals. However, IT leaders still voice security concerns about AI.

Phishing is down, but the overall threat remains high.

Phishing effectiveness has cooled from last year's critical high: 80% of businesses report receiving phishing emails this year (from 89% in 2022). and 61% say their employees clicked on a malicious link (from 81% in 2022). While this is promising news, IT security managers consider advanced phishing attacks as the top threat heading into 2024.

Ransomware attacks decline as decryption rate nearly doubles.
Ransomware attacks have dropped

from 53% to 37% year over year, while the rate of victims paying the ransom has plummeted from 67% to 36%. This can be attributed to a sharp rise in businesses decrypting ransomware on their own, along with rising adoption of incident response plans.

Data access privileges are becoming more restricted.

In past years, the rate of companies restricting employee data access remained relatively steady, but this year's report indicates a shift toward more data restriction. Only 16% of businesses allow employees access to all company data, a drop of more than 50% from 2022.

Tech cuts indoor temp by 12°C

Sahara-inspired nanofiber vows to cool buildings in searing summers

HSINCHU, Taiwan, Sept 30: The summer of 2023 was by far the hottest in history. People were seeking solace in air-conditioned spaces or donning cooling attire. Here's some food for thought: Can buildings also be outfitted with similar cooling solutions?

Led by Professor Dehui Wan from the Institute of Biomedical Engineering at National Tsing Hua University (NTHU) in Taiwan, a research team drew inspiration from the silver ants inhabiting the Sahara Desert and created a biomimetic material called "supercooling nanofiber."

Covering roofs with this thin, pliable, and durable fiber membrane, which is resistant to UV rays and acid rain, is like adorning buildings with cooling attire. This innovation can lead to a reduction of over 12°C in indoor temperatures, resulting in significant savings in electricity costs. Furthermore, it aligns with the broader goals of energy efficiency, carbon reduction, and ultimately, the protection of our

Professor Wan pointed out that Saharan silver ants manage to thrive in scorching temperatures of up to 70°C primarily because of their triangular prism-like hairs. These hairs reflect a significant portion of the sunlight that hits them. Most of the absorbed energy from visible light is converted to longer wavelength infrared light, which is then emitted through the hairs, leading to an efficient cooling effect.

Taking cues from the hairs of these desert-dwelling ants, the research team embarked on a comprehensive exploration of diverse materials, configurations, dimensions, and hues. Using advanced optical engineering techniques, they employed ceramic materials to create white fibers measuring just a few hundred nanometers in diameter. These fibers possess the ability to reflect 97% of sunlight, resulting in a substantial cooling effect.

Develop sound strategies to adapt to climate change

Experts probe global warming's role in extreme flooding events

Torrential downpours sent muddy water racing through streets in Libya, Greece, Spain and Hong Kong and flood parts of New York City in September 2023. Thousands of people died in the city of Derna, Libya. Zagora, Greece, saw a record 30 inches of rain, the equivalent of a year and a half of rain falling in 24 hours.

A few weeks earlier, monsoon rains triggered deadly landslides and flooding in the Himalayas that killed dozens of people in India.

After severe flooding on almost every continent this year, including mudslides and flooding in California in early 2023 and devastating floods in Vermont in July, it can seem like extreme rainfall is becoming more com-

So, what role does global warming play in this? And importantly, what can we do to adapt to this new reality? As a climate scientist with a background in civil engineering, I am interested in exploring the links between the science of climate change and extreme weather events on one hand and the impacts those events have on our daily lives on the other. Understanding the connections is crucial in order to develop sound strategies to adapt to climate change.

Intensity

As temperatures rise, the warmer atmosphere can hold more water vapor. Evaporation of water from land and oceans also increases. That water has to eventually come back to land and

Simply, as the atmosphere absorbs more moisture, it dumps more precipitation during storms. Scientists expect about a 7% increase in precipitation intensity during extreme storms for every 1 degree Celsius (1.8 degrees Fahrenheit) of warming. This increase in the amount of mois-

Study reveals large-scale flood risks at old US industrial areas

Research urges to rethink cleanup approaches

Floodwaters are a growing risk for many American cities, threatening to displace not only people and housing but also the land-based pollution left behind by earlier industrial activities.

In 2019, researchers at the US Government Accountability Office investigated climate-related risks at the 1,571 most polluted properties in the country, also known as Superfund sites on the federal National Priorities List. They found an alarming 60% were in locations at risk of climate-related events, including wildfires and flooding.

As troubling as those numbers sound, our research shows that that's just the proverbial tip of the iceberg.

Many times that number of potentially contaminated former industrial sites exist. Most were never documented by government agencies, which began collecting data on industrially contaminated lands only in the 1980s. Today, many of these sites have been redeveloped for other uses such as homes, buildings or parks.

For communities near these sites, the flooding of contaminated land is worrisome because it threatens to compromise common pollution containment methods, such as capping contaminated land with clean soil. It can also transport legacy contaminants into surrounding soils and waterways, putting the health and safety of urban ecosystems and residents at

We study urban pollution and environmental change. In a recent study, we conducted a comprehensive assessment by combining historical manufacturing directories, which locate the majority of former industrial facilities, with flood risk projections from the First Street Foundation. The projections use climate models and historic data to assess future risk for each property.

The results show that the GAO's 2019 report vastly underestimated the scale and scope of the risks many communities will face in the decades

We started our study by collecting the location and flood risk for former industrial sites in six very different cities facing varying types of flood risk over the coming years: Houston; Minneapolis; New Orleans; Philadelphia; Portland, Oregon; and Providence, Rhode Island.

These former industrial sites have been called ghosts of polluters past. While the smokestacks and factories of these relics may no longer be visible, much of their legacy pollution likely remains. (AP)

Some school administrators adopt 'green cleaning' approach

From pests to pollutants, keeping schools healthy is no simple task

Parents send their children to school to learn, and they don't want to worry about whether the air is clean, whether there are insect problems or whether the school's cleaning supplies could cause an asthma attack.

But a research collaborative, of which I'm a member, has found that schools might not be ready to protect students from environmental contaminants.

I'm an extension specialist focused on pest management. I'm working with a cross-disciplinary team to improve compliance with environmental health standards, and we've found that schools across the nation need updates in order to meet minimum code requirements.

Everything from a school's air and water quality to the safety of the pesticides and cleaning chemicals used there determine the safety of the learning environment. Environmental health standards can help a school community ensure each potential hazard is accounted for.

Air, water & food quality

So, what aspects of the school environment and student health need attention? For one, the air students and teachers breathe every day.

Understanding and controlling common pollutants indoors can improve the indoor air quality and reduce the risk of health concerns. Even small things like dust and dander, dead insects and artificial scents used to cover up smells like mold and mildew can trigger asthma and allergies.

Improving ventilation, as well as a school's air flow and filtration, can help protect building occupants from respiratory infections and maintain a healthy indoor environment. Ventilation systems bring fresh, outdoor air into rooms, filter or disinfect the air in the room and improve how often air flows in and out of a room.

Upgrading ventilation in school buildings can improve air quality and reduce potential contaminants, including viral particles, in indoor spaces.

It may seem like maintaining proper food safety and drinking-water quality would be common practices. But many schools do have some level of lead contamination in their food and water.

In 1991, the US Environmental Protection Agency published a regulation, known as the lead and copper rule, to minimize lead and copper in drinking water. The EPA's 2021 revised lead and copper rule aims to reduce the risks of childhood lead exposure by focusing on schools and child care facilities and conducting outreach.

But in December 2022, a team of scientists published a report on lead and copper levels in drinking water, and they found evidence that lead is still showing up in drinking water in Massachusetts schools. No amount of lead is safe to have in the water.

To combat contamination and ensure safe food and water, the Food and Drug Administration overhauled the Food Safety Modernization Act in 2016. This act has transformed the nation's food safety system by shifting the focus from responding to foodborne illnesses to preventing them. It gives local health officials more authority to oversee and enforce supply chain safety.

Per these new regulations, every school cafeteria must be inspected by the local registered sanitarian at least twice a year to meet the minimum standards for their state and federal guidelines.

These inspections now include look-

ing for entry points that might allow mice or rats to come in, finding areas with moisture buildup where flies, roaches or other insects can breed, and determining whether storage rooms are properly sanitized.

Pest management

Even if a school has clean air, water and food, it still may not meet all the required health standards. Many schools have insect infestations, and many combat these pest problems with harsh chemicals when there's a simpler solution.

Integrated pest management is an environmentally sensitive approach to pest management. Known as IPM, it combines commonsense practices like keeping doors and windows closed and making sure no food is left in classrooms overnight with other ways to help prevent pests from coming in.

IPM programs consider the pests' life cycles and their larger environment, as well as all the available pest control methods, to manage pest infestations economically and scientifically.

Common pests in schools include ants, cockroaches and bedbugs. Ants enter looking for food, and cockroaches can travel in with backpacks or enter through small openings under doors or cracks in the seals around a window. Mice, cockroaches and ants can come into a kitchen or bathroom from plumbing pipes that aren't properly sealed.

In the fall, cockroaches reside in custodial closets, kitchens and other areas where floor drains might be. These bugs use the sewer drains to move about, so an IPM approach might include making sure the drains have plenty of water flooding through them and clearing out organic matter that the cockroaches might feed on.

Green cleaning

School administrators also determine what products to use for pest control and cleaning. With the intent to prioritize the safety of both the people inside the building and the environment, some schools have adopted a "green cleaning" approach.

Green cleaning uses safer - or less harsh - chemical and pesticide products, since studies have found that the repeated use of harsh chemicals indoors can lead to chronic health effects later in life for anyone directly exposed.

Products that contain ingredients like hydrogen peroxide, citric acid and isopropyl alcohol are generally safer than products that contain chlorine or ammonia.

But the school's job isn't done, even after the infestation has been dealt with. Schools need a plan to manage their pollutants long term - these pollutants might be cleaning chemicals and pesticides or chemicals used in science classes. Preserving the school's air quality requires a plan for storage and disposal of these materials. But finding the funds to correctly dispose of legacy chemicals can challenge already thin budgets.

Over the past decade, the US Centers for Disease Control and Prevention has worked with a variety of groups to develop the Whole School, Whole Community, Whole Child initiative. This approach pulls together professionals, community leaders, parents and others to support evidence-based policies and practices.

The initiative has also led some states to develop school health advisory councils that work with state departments of education and health to assist their local school districts with managing the indoor environment and student health.

When the school building is safe, students and educators are more able to get down to the business of learning, undistracted. (AP)

More race-based data needed

Majority of Canadians want earlier screening for breast cancer: survey

TORONTO, Sept 30: Breast Cancer Canada (BCC), a national charity dedicated to saving lives through breast cancer research, has released new data that highlights Canadian perspectives on breast cancer screening and the need for diverse, lived experiences in research.

The survey, conducted among members of the Angus Reid Forum, found that there is a significant national demand for earlier routine breast cancer screening. Also identified is a need for more race-based data and a willingness among Canadians to share their experiences to improve patient outcomes.

Kev findings

Lowering the age for routine breast cancer screening: 89 per cent of Canadians believe routine breast cancer screening should begin before the age of 50.

■ Gathering race-based data: Canada does not routinely track race-based data around breast cancer screening rates, however studies in the US have found black people have clear, poorer outcomes when it comes to breast cancer, especially young black women. BCC's study found that 79 per cent of Canadians believe that Canada should prioritize gathering race-based data on cancer screening rates to address a lack of information on racial disparities.

Canadians' desire to help future patients: Four-in-five Canadians (80 per cent) wish their experiences with health challenges could inform research on improving health outcomes for others.

Parminder Punia of Brampton has heard the words "you have breast cancer," and knows what it's like to have her life changed forever. In August 2021, at the age of 46, Parminder felt a lump in her right breast. After weeks of exploration and tests, she was diagnosed with breast cancer.

If routine screening was accessible to Parminder beginning at age 40, her breast cancer could have been caught earlier, before the disease had the opportunity to advance. 'I can't stress the importance of routine mammograms enough. Screening detects breast cancer in its very early stages, ahead of a lump or any other symptoms present."

1 in 8 women will be diagnosed with breast cancer in their lifetime. Treatments for breast cancer are more effective and are better tolerated when started early.

Japan's Murakami hosts ghost story reading ahead of Nobels

TOKYO, Sept 30, (AP): Japanese novelist Haruki Murakami hosted a ghost story reading event in Tokyo amid growing attention before the announcement of this year's Nobel Prize in literature, an award he is a perennial favorite to win.

Murakami said at Thursday's reading that he enjoys scary stories and wanted to write more of them. The event featured one from the 18-century collection "Tales of Moonlight and Rain," which intrigued Murakami since his childhood and is known to have inspired his work.

The classic collection written by Akinari Ueda and called "Ugetsu Monogatari" in Japanese explores a blurry borderline between the real and surreal, which Murakami said in a guide he contributed to a 2021 magazine made him wonder which side he was on.

Borders and walls are important motifs in Murakami's writing. Protagonists in his stories often travel through walls or between two worlds and encounter mysterious, exotic characters. While Murakami has said he grew up mostly reading Western novels, some experts have also noted the influence of Ueda's stories in some of Murakami's work

Murakami has been a candidate for the Nobel Prize in literature for more than a decade, and the winner of the 2023 prize is scheduled to be announced on Oct. 5. If he wins, he would will be first Japanese writer since Kenzaburo Oe in 1994 to be named a Nobel laureate

Japanese media also have mentioned novelists Yoko Ogawa and Yoko Tawada as possible contenders in recent years, and international media also have put Chinese fiction writer Can Xue and American novelist Thomas Pynchon on the list of this year's potential winners.

The pending Nobel Prize did not come up at Thursday's ghost story event. Kayoko Shiraishi, a veteran actress known for ghost tale monologues, performed Ugetsu's "The Kibitsu Cauldron," a story of an imprudent man who marries a priest's good daughter despite a cauldron's fortunetelling revealing a bad omen. The protagonist meets a horrendous end after betraying his wife, who becomes a vengeful spirit.

Murakami said he enjoyed Shiraishi's "scary" performance of multiple roles and said he would like her to try "The Mirror," one of the short horror stories he wrote in 1983.

Murakami wrote his first published novel, 1979's "Hear the Wind Sing," after being inspired to write fiction while watching a baseball game at Meiji Jingu Stadium, which is now part of a controversial redevelopment of Tokyo's historic Jingu Gaien park area, to which opposition is growing.

Murakami, who voiced opposition to the project in his radio show last month, repeated his concern at the story reading event, noting the plan involves removing about 1,000 trees. An avid runner, Murakami also noted that the area is part of his running course, and that the stadium is home to his favorite team, the Yakult Swallows.

"Jingu Gaien is a very important place for me," Murakami said. "I will continue to raise my voice of opposition to this redevelopment, and any of you who agree with me, please support." The audience ap-

NEW YORK: A former aide in **Donald Trump**'s White House says chief of staff Mark Meadows burned papers so often after the 2020 election that it left his office smoky and even prompted his wife to complain that his suits smelled "like a bonfire."

Cassidy Hutchinson, who was a prominent congressional witness against former President Trump before the House Jan. 6 committee, described the burning papers in a new book set to be released Tuesday. The Associated Press obtained a copy of the book, "Enough."

Hutchinson was a White House staffer in her 20s who worked for Meadows and testified for two hours on national television about the White House's inner workings leading up to and including the Jan. 6, 2021, insurrection at the U.S. Capitol.

Trump and Meadows tried to challenge the former president's election loss in several states. Both are under indictment in Georgia for what prosecutors have called an illegal conspiracy to overturn the results.

In her book, Hutchinson writes that starting in mid-December, Meadows wanted a fire burning in his office every morning. She says that when she would enter his office to take him lunch or a package, she "would sometimes find him leaning over the fire, feeding papers into it, watching to make sure they burned.'

Hutchinson had previously testified to the House Jan. 6 committee that she had seen Meadows burning documents in his office about a dozen times. Hutchinson said she did not know what papers he was burning but said it raised alarms because federal law regarding presidential records requires staff to keep original documents and send them to the National Archives.

She said one day when Republican Rep. Devin Nunes of California went to meet with Meadows, the congressman asked Hutchinson to open the windows in Meadows' office because it was smoky. She said she warned Meadows he would set off a smoke alarm.

Later, in the days after the Jan. 6 attack on the Capitol, when the Republican president's staffers began packing to move out of the White House, Hutchinson said Meadows' wife arrived to help and asked the aide to stop lighting the fireplace for Meadows because "all of his suits smell like a bonfire" and she could not keep up with the dry cleaning.

Turkey film fest canceled over docu dispute

MEMPHIS, Tenn: A man has been arrested in a shooting that wounded one person at a Memphis concert headlined by rapper Lil **Baby**, police said.

Kevin Young, 22, was arrested Wednesday on charges including reckless endangerment and unlawful possession of weapons and drugs at a home in Memphis, police said on social media.

Police responded to the Sept. 7 shooting at the FedExForum, located just steps from the popular Beale Street tourist destination in downtown Memphis. The 19,000-seat arena is home to the NBA's Memphis Grizzlies and the University of Memphis men's basketball team. The arena is also used as a concert venue.

Lil Baby was rushed off the stage when shots were fired. A man was wounded and taken to a hospital. No other injuries were reported.

The concert was canceled and the building was evacuated. Police have not said how the suspect was able to bring a gun into the arena, which contracts with a private security company to screen people for weapons. The arena has since instituted a clear bag policy for patrons.

Officers found guns, ammunition and drugs in the home where Young was arrested. Two other men who were in the home were also arrested on drug charges.

Online court records do not list a lawyer for Young. After the shooting, Lil Baby posted a message on X, formerly

> The ministry objected to the film "Kanun Hükmü" or "Decree," a documentary which focuses on the hardships of a teacher and doctor who were dismissed from their jobs following an attempted coup in Turkey on

> "It is extremely sad that in such an important festival, the power of art is used to make propaganda for the FETO terrorist organization through the perception of victimhood," the Culture Ministry said in a statement.

> FETO is an acronym the Turkish government uses for a movement led by US-based cleric Fethullah Gulen, whom the government blames for the failed coup. Gulen denies any involvement. More than 130,000 alleged supporters in Turkey were fired from their jobs under emergency decrees declared after the military

> The ministry added that it would "not be part of the effort to discredit the epic struggle of our beloved nation on July 15 and to use art as an element of provocation."

In a video posted on X, the platform formerly known as Twitter, Bocek, a member of Turkey's opposition party, blamed the festival's administrators and artistic team for mishandling the controversy and not engaging in crisis management.

"Due to the mess created by their own hand," the festival administration, artistic director and the entire artistic team were fired, he said.

"Nobody should doubt that I will not allow our festival to be used for anyone's political agenda," the mayor said. Critics have alleged the post-coup terminations and arrests represented a general crackdown against anyone viewed as its opponents.

Organizers had said they would remove "The Decree" from the film festival program. Festival director Ahmet Boyacioglu initially announced the film was removed from the national documentary category due to ongoing

legal proceedings against one of the people featured. But the documentary's director, Nejla Demirci, said that was an "excuse" and "outright censorship." Twenty members of the festival jury quit in protest of the film getting pulled. On Wednesday the producers and directors of 27 festival entries said they were withdrawing

from the event. The film was later reinstated to the program after it was discovered that the trial of the featured person had

ended. The festival, which has run since 1963 in the Mediterranean city of Antalya, is a highlight of the Turkish cultural calendar. This year it is due to run Oct. 7-14.

Momentum has lately been hard to come by at the movies. The big trio of fall film festivals — Venice, Telluride, Toronto — came and went without the usual amount of buzz. With actors on strike, red carpets have been mostly bare. It's almost like since the heady highs of "Barbenhe-

imer," the movies have been sleeping off a hangover. As the 61st New York Film Festival opened Friday night, things may finally be stirring once again. There is movement on the labor stoppage. Screenwriters are poised to ratify a new contract after nearly five months of striking. The actors union, SAG-AFTRA, is to recommence talks with the studios next week.

At the same time, the New York Film Festival will play host to easily the best assemblage of movies this year. Each major festival has had their highlights, but for the next two weeks, a large share of the fall's best films will screen at Lincoln Center. "The unsettled state of the industry is an unavoidable

talking point these days, but my hope is that our festival, as it has done through its 61-year history, will serve as a reminder that the art of cinema is in robust health, **Dennis Lim**, artistic director of the festival, said when unveiling the lineup.

Breakthrough arrest in Shakur's murder case

LOS ANGELES, Sept 30, (AP): An arrest has been made in **Tupac Shakur**'s killing, the latest twist in one of the biggest unsolved cases in hip-hop history.

Duane "Keffe D" Davis was arrested on suspicion of murder early Friday morning and has been indicted on a murder charge in Las Vegas.

The case returned to the spotlight in July when Nevada authorities served a search warrant in connection with the rap star's shooting death.

Here's what to know about one of the most infamous fatal shootings in hip-hop history:

Authorities on Friday arrested Davis, who's name has long been linked with Shakur's death. He is the relative of a man who emerged as a suspect shortly after the rapper's killing.



and died two years later in an unrelated gang shooting in Compton, California. Details from the warrant obtained by The Associated Press shows detectives collected multiple computers, a cellular telephone, "documentary documents," a Vibe magazine that featured Shakur, several .40-caliber bullets, two "tubs containing photographs" and a copy of Davis' 2019 memoir, "Compton Street

Shakur was gunned down while riding in a car on the Las Vegas strip on Sept. 7, 1996. In July, authorities executed warrant in the nearby city of Henderson at Davis' house. He's the uncle of Orlando Anderson, one of Shakur's known rivals who authorities long suspected shot the rapper. Anderson denied involvement in Shakur's killing at the time,

The 25-year-old rapper was traveling in a black BMW driven by Death Row Records founder Marion "Suge" Knight in a convoy of about 10 cars, apparently headed to a nightclub, after watching Mike Tyson knock out Bruce Seldon in a championship fight at the MGM Grand.

After the bout, Shakur, Knight and associates were involved in a fight at the hotel.

While driving down the Las Vegas Strip, a white Cadillac with four men inside pulled alongside the BMW while it was stopped at a red light. One person opened fire, riddling the passenger side of Knight's car with bullets, police said. Sitting in the passenger seat, Shakur was shot four times, at least twice in the chest. Knight was grazed by a bullet fragment or shrapnel from the car.

Shakur was rushed to a hospital, where he died six days later.

Shakur is one of the most prolific figures in hip-hop, also known by his stage names 2Pac and Makaveli. His professional music career only lasted five years, but he sold more than 75 million records worldwide, including the diamond-certified album "All Eyez on Me," which was packed with hits including "California Love (Remix)," "I Ain't Mad at Cha" and "How Do U Want It."

Shakur had five No. 1 albums including "Me Against the World" in 1995 and "All Eyez on Me" in 1996, along with three posthumous releases: 1996's "The Don Killuminati: The 7 Day Theory," 2001's "Until the End of Time" and 2004's "Loyal to the

The six-time Grammy-nominated artist was inducted into the Rock & Roll Hall of Fame by Snoop Dogg

As a rising actor, Shakur starred in several popular films such as John Singleton's "Poetic Justice" with Janet Jackson and Ernest Dickerson's "Juice." He also played major roles in "Gang Related" and "Above the

In April, a five-part FX docuseries called "Dear Mama: The Saga of Afeni and Tupac Shakur" delved into the past of the rapper's mother, Afeni Shakur, as a female leader in the Black Panther Party, while exploring Tupac's journey as a political visionary and becoming one of the greatest rap artists of all time.

Earlier this year, Shakur received a posthumous star on the Hollywood Walk of Fame.

"He defied the distinction between art and activism," said radio personality Big Boy, who emceed the ceremony.

Shakur has been remembered with museum exhibits, including "Tupac Shakur. Wake Me When I'm Free" in 2021 and "All Eyez on Me" at the Grammy Museum in 2015. Oakland officials have said a stretch of an Oakland street will be renamed after him.

Shakur's death came amid his feud with rap rival the Notorious B.I.G., who was fatally shot six months later. At the time, both rappers were in the middle of the infamous East Coast-West Coast rivalry, which primarily defined the hip-hop scene during the mid-

Shooting

The feud was ignited after Shakur was seriously wounded in another shooting during a robbery in the lobby of a midtown Manhattan hotel in 1994. He was shot several times and lost \$40,000.

Shakur openly accused B.I.G. and Sean "Diddy" Combs of having prior knowledge of the shooting, which both vehemently denied. The shooting sparked enough of a feud that created a serious divide within the hip-hop community and fans.

The New York-born Shakur represented the West Coast after he signed with the Los Angeles-based Death Row Records. He often traded verbal jabs with New York-natives B.I.G. and Combs, who hailed from the East Coast while representing New York City-based Bad Boy Records.

Diss tracks were delivered to drive home their ferocious points across. Shakur released the aggressive single "Hit 'Em Up," which took aim at B.I.G., who on the other hand returned with "Who Shot Ya?," a record that was received as a taunt. However, B.I.G. claimed the song was not directed toward Shakur.

Shakur was born June 16, 1971, in New York City. He later moved to Baltimore and attended the Baltimore School for the Arts, where he began writing raps. He eventually made his way to Marin City, California, near San Francisco, and continued to write and record.

As a member of the Grammy-nominated group Digital Underground, Shakur appeared on the 1991 track "Same Song" from "This Is an EP Release" and

on the album "Sons of the P." That same year, Shakur achieved individual recognition with the album "2Pacalypse Now," which spawned the successful singles "Trapped" and "Brenda's Got a Baby."

Hearst exits Chloé on a joyful note

PARIS, Sept 30, (AP): In a bold departure from the somber farewells often seen in fashion, designer Gabriela Hearst literally danced her way out of Chloé at her final show Thursday, radiating pure, unapologetic joy. Rather than poignant goodbyes, Hearst opted for lively samba beats, prompting tears of endearment from onlookers as she lithely pirouetted past guests carefree alongside one of Brazil's most reputed Samba schools. Patients' safety priority

FDA seeks oversight for 'unregulated' lab tests

WASHINGTON, Sept 30, (AP): The Food and Drug Administration on Friday laid out a proposal to begin regulating laboratory medical tests, a multibillion-dollar industry that the agency says poses a growing risk to patients because of potentially inaccurate results.

The proposed rule would end decades of regulatory ambiguity and formally bring thousands of tests performed in large laboratories under FDA oversight. FDA Commissioner **Robert Califf** said the change will help ensure tests used to diagnose cancer, heart disease and many other conditions are safe, accurate and reliable.

"A growing number of clinical diagnostic tests are being offered as laboratory-developed tests without assurance that they work," Califf said in a statement. He added that the agency has long worried that many tests offered by labora-

tories are not as accurate or reliable as those that undergo FDA review.



Here's a look at the history and background of the testing issue:

Most Americans are familiar with medical tests like those used to screen for COVID-19, strep throat and other health conditions. Those tests are developed by a handful of large manufacturers that undergo FDA review before selling their test kits to hospitals, doctors offices or pharmacies.

The tests targeted by the FDA's latest action are developed and used by high-tech laboratories, including those at academic medical centers and companies such as Quest Diagnostics. They include tests for complex diseases like cancer, as well as simpler conditions like high cholesterol and sexually transmitted infections.

In the 1970s and '80s, most lab-based tests were "lower risk, small volume" products used mostly for local patients, the FDA noted Friday.

Over time, laboratory-developed tests have grown into a multibillion-dollar nationwide business, with labs processing thousands of blood, urine and other samples per week from hospitals and clinics. Others advertise directly to consumers - including some claiming to measure the risk of developing ailments like Alzheimer's and autism.

Concerns

Laboratory-developed tests have long skirted FDA oversight, though the agency has always maintained that it has the authority to step in. Debate over regulating the space stretches back to the 1990s, with several government advisory groups recommending greater FDA oversight.

Many lab-developed tests are staples of medical care, used to make important decisions about pregnancy, nutrition and many other health issues.

FDA officials have long voiced concerns about the accuracy of some tests, pointing to patients who have received inaccurate results for heart disease, Lyme disease, cancer and other conditions. Inaccurate tests can lead to patients getting an incorrect diagnosis, skipping treatments or receiving unnecessary medication or surgery.

More than a decade ago, the agency drafted tougher

guidelines for the industry, but they were never finalized.

The tests attracted new scrutiny with the downfall of Theranos CEO and founder Elizabeth Holmes, who was sentenced to prison last year for misleading investors about the potential of her company's blood testing technology.

During the pandemic, the FDA also flagged accuracy problems with dozens of COVID-19 tests that were rushed out by U.S. laboratories without federal oversight.

Recent scrutiny has focused on pregnancy tests that purport to screen for mutations that can lead to Down syndrome, cystic fibrosis and genetic defects. Several studies and reports have identified tests that misstate or exaggerate the risks of those problems.

The laboratory industry has long argued that FDA regulation would stifle their ability to quickly innovate and develop new tests. They also say that additional federal regulation is unnecessary because it would duplicate existing

requirements.

Under a quirk of federal law, testing laboratories are currently overseen by the same agency that runs Medicare and Medicaid, the government health plans for seniors, the disabled and the poor. Inspectors evaluate the general conditions and procedures at labs, but not specific tests or the

claims used to market them.

Lawmakers in Congress drafted a bill last year - backed by FDA officials - that would have given the FDA explicit authority to regulate high-risk tests. But the measure failed to pass the House or the Senate amid opposition by testing industry lobbyists.

Under the new proposal, FDA would gradually phase in tighter regulation of lab tests over five years. The agency is considering exempting some existing tests already on the market from review but is seeking public input on its approach. At the end of the process, most new tests would be subject to FDA standards and regulatory review before

The new regulations should reduce health care costs due to fewer "unsafe or ineffective tests, including tests promoted with false or misleading claims," the agency says.

The agency will take comments on its proposal for 60 days before beginning to draft a final rule. There is no deadline for completion and the process can typically take months or years.



Law strengthens animal rights: A new animal welfare law that took effect Friday in Spain outlaws the use of animals for recreational activities that cause them pain and suffering but allows bullfights and hunt-

Spain's first specific animal rights legislation is intended to crack down on abuses. The law particularly targets the mistreatment of domestic animals, introducing fines of up to 200,000 euros (\$212,000).

It bans the buying of pets in stores or online, but gives stores a grace period to find homes for their animals. In the future, it only will be legal to purchase pets from registered breeders. The new rules allow pets into most establishments, including restaurants and bars.

The law bans the use of wild animals at circuses and gives owners six months to comply. It allows zoos to keep using the marine mammals in their dolphin shows until the animals die.

Bullfights are regarded as part of Spain's cultural heritage. A proposal to include hunting dogs in the law prompted an outcry in some rural communities, and the government backed down.

Government statistics estimate some 29 million animals are kept as pets in Spain, most of them dogs. But around 300,000 are abandoned each year, and about one-third of those are put down. (AP)

Bison roundup draws crowd: South Dakota cowboys and cowgirls rounded up a herd of more than 1,500 bison Friday as part of an annual effort to maintain the health of the species, which has rebounded from

near-extinction.

Visitors from across the world cheered from behind wire fencing as whooping horseback riders chased the thundering, wooly giants across hills and grasslands in Custer State Park. Bison and their calves stopped occassionally to graze on blond grass and roll on the ground, their sharp hooves stirring up dust clouds.

"How many times can you get this close to a buffalo herd?" said South Dakota Game, Fish and Parks Secretary **Kevin Robling**, who was among 50 riders herding the animals. "You hear the grunts and the moans and (see) the calves coming and running alongside mamas."

Custer State Park holds the nation's only Buffalo Roundup once a year to check the health of the bison and vaccinate calves, park Superintendent Matt Snyder said.

As many as 60 million bison, sometimes called buffalo in the US, once roamed North America, moving in vast herds that were central to the culture and survival of numerous Native American groups.

They were driven to the brink of extinc-

They were driven to the brink of extinction more than a century ago when hunters, US troops and tourists shot them by the thousands to feed a growing commercial

Experts find gene behind body's medical devices rejection Hope for safer, longer-lasting implants

B iomedical implants - such as pace-makers, breast implants and orthopedic hardware like screws and plates to replace broken bones - have improved patient outcomes across a wide range of diseases. However, many implants fail because the body rejects them, and they need to be removed because they no longer function and can cause pain or discomfort.

An immune reaction called the foreign body response - where the body encapsulates the implant in sometimes painful scar tissue - is a key driver of implant rejection. Developing treatments that target the mechanisms driving foreign body responses could improve the design and safety of biomedical implants.

I am a biomedical engineer who studies why the body forms scar tissue around medical devices. Along with my colleagues Dharshan Sivaraj, Jagan Padmanabhan and Geoffrey Gurtner, we wanted to learn more about what causes foreign body responses. In our research, recently published in the journal Nature Biomedical Engineering, we identified a gene that appears to drive this reaction because of the increased stress implants put on the tissues surrounding them.

Researchers hypothesize that foreign body responses are triggered by the chemical and material composition of the implant. Just as a person can tell the difference between touching something soft like a pillow versus something hard like a table, cells can tell when there are changes to the softness or stiffness of the tissues surrounding them as a result of an implant.

The increased mechanical stress on those cells sends a signal to the immune system that there is a foreign body present. Immune cells activated by mechanical pressure respond by building a capsule made of scar tissue around the implant in an attempt to shield it off. The more severe the immune reaction, the thicker the capsule. This protects the body from getting an infection from injuries like a splinter in your finger.

All biomedical implants cause some level of foreign body response and are surrounded by at least a small capsule. Some people have very strong reactions that result in a large, thick capsule that constricts around the implant,

impeding its function and causing pain. Between 10% to 30% of implants need to be removed because of this scar tissue. For example, a neurostimulator could trigger the formation of a dense capsule of scar tissue that inhibits electrical stimulation from properly reaching the nervous system.

To understand why the immune systems of some people build thick capsules around implants while others do not, we gathered capsule samples from 20 patients whose breast implants were removed - 10 who had severe reactions, and 10 who had mild reactions. By genetically analyzing the samples, we found that a gene called RAC2 was highly expressed in samples taken from patients with severe reactions but not in those with mild reactions. This gene is found only in immune cells, and it codes for a member of a family of proteins involved in cell growth and structure.

Because this protein seemed to be linked to a lot of the downstream reactions that lead to foreign body responses, we decided to explore how RAC2 affects the formation of capsules. We found that immune cells activate RAC2 along with other proteins in response to mechanical stress from implants. These proteins summon additional immune cells to the area that combine into a massive clump to attack a large invader. These combined cells spit out fibrous proteins like collagen that form scar tissue.

Immune

To confirm RAC2's role in foreign body responses, we artificially stimulated the mechanical signaling proteins surrounding silicone implants surgically placed in mice. This stimulation produced a severe and humanlike foreign body response in the mice. In contrast, blocking RAC2 resulted in an up to threefold reduction in foreign body responses.

These findings suggest that activating mechanical stress pathways triggers immune cells with RAC2 to generate severe foreign body responses. Blocking RAC2 in immune cells may significantly reduce this reaction.

Implant failure is conventionally treated by using biocompatible materials that the body can better tolerate, such as certain polymers. These don't completely remove the risk of foreign body reactions, however.

My colleagues and I believe that treatments that target the pathways associated with RAC2 could potentially mitigate or prevent free body responses. Heading off this reaction would help improve the effectiveness and safety of medical implants.

Because only immune cells express RAC2, a drug designed to block only that gene would theoretically target only immune cells without affecting other cells in the body. Such a drug could also be administered via injection or even coated onto an implant to minimize side effects.

A complete understanding of the molecular mechanisms driving foreign body responses would be the final frontier in developing truly bio-integrative medical devices that could integrate with the body with no problems for the recipient's entire life span.

TOLEDO, Ohio: A former director of an Ohio memory-loss clinic accused by dozens of patients of falsely diagnosing them with Alzheimer's disease has been sentenced on federal fraud charges, along with her physician husband.

Sherry-Ann Jenkins received nearly six years in prison on Tuesday, while Oliver Jenkins got a 41-month sentence. The couple was convicted in March on conspiracy, mail fraud, wire fraud and health-care fraud charges after being indicted in May 2020.

The US Justice Department has said Sherry-Ann Jenkins was not trained or licensed to provide any medical care but presented herself as a doctor and billed patients for unneeded treatments.

The indictment did not directly ac-

cuse the couple of falsely diagnosing her patients, but more than 60 people filed lawsuits beginning in 2017 that said Sherry-Ann Jenkins lied and told them they had Alzheimer's or another form of dementia.

The patients said they spent months

undergoing treatment while planning out their final years, thinking they would die soon. Some quit their jobs or took one last special trip. One killed himself; others said they considered suicide.

The patients who sued the couple

and the clinic resolved the cases out of court. Nearly all of those diagnosed by Sherry-Ann Jenkins began seeing her after suffering traumatic brain injuries or worsening cognitive issues.

Sherry-Ann Jenkins operated the To-

ledo Clinic Cognitive Center through the Toledo Clinic, a multi-specialty medical center, for slightly more than two years, according to court records. (AP)

They were gifted to Cyprus by the autonomous community of Extremadura in Spain which hosts 90-95% of all vultures in Europe. Cyprus Game and Fauna Service spokesman Nicos Kasinis told The Associated Press the tracking devices are necessary to

observe whether the young birds are integrating well in the first, crucial weeks with the island's 29 other griffon vultures. Officials will monitor whether they're frequenting the same feeding and watering areas.

Griffon vultures are a resident species in Cyprus but their population has dwindled to

Cyprus but their population has dwindled to dangerously low numbers. The local population has not been naturally replenished because the vultures, like other large bird species, avoid traveling long distances over water, Kasinis said. (AP)

Ramos scores own goal to gift Barcelona 1-0 win over Sevilla

BARCELONA, Spain, Sept 30, (AP): So long the scourge of Barcelona, Sergio Ramos unwittingly came to its aid on Friday.

The former Real Madrid defender scored an own goal that handed Barcelona a 1-0 win over Sevilla in the Spanish league.

The veteran center back inadvertently turned in a headed pass by Lamine Yamal into Sevilla's goal in the 76th minute.

The 37-year-old Ramos returned to Sevilla, his boyhood club, this month after leaving Paris Saint-Germain. Barcelona's fans jeered Ramos early in the game because of his past stint with Madrid, where he played 45 "clasico" games against the Catalan club between 2005-21.

After an evenly matched first half, Barcelona was pressing Sevilla into its box when the 16-year-old Lamal helped produce the breakthrough. Yamal was trying to head a lobbed pass by substitute Ferran Torres to teammate Fermin López when it hit Ramos and deflected into the net.

During the game, a video clip was played on Spanish news websites from a Barcelona vs. Madrid game in 2016 when Ramos was accompanied onto the field by Yamal

when he was a young boy.
"Circumstance of life," Barcelona coach Xavi Hernández said about Yamal and Ramos now playing against one another.

"Who would have predicted that Yamal would be playing him at age 16, and it is to Sergio's credit that he is still playing at this level," said Xavi, who was Ramos' rival at Barcelona and his teammate on the Spain team that won the 2010 World Cup. "Sergio is a great player and he had a played a great game, but he was just unlucky."

This month, Yamal became the youngest player to score in a European Championship qualifier and also became the youngest player to appear for Spain.

Sevilla midfielder Ivan Rakitic drew a leaping save from Marc-Andre ter Stegen in the 16th minute. The visitors went closer to scoring in the 30th, but Gavi Páez blocked the goal-bound shot by Lucas Ocampos.

'This Barcelona has lots of talented players, and we just weren't able to defend them until the very end," said Rakitic, whose Sevilla was left in 12th place. "We have lots of little things to improve so that these details that decide matches can go our way.'

Barcelona's best chance in the first half came in the 20th when João Félix hit the woodwork after being set up by João Cancelo.

Barcelona lost Brazil forward Raphinha to an apparent leg injury in the first half. Fermin replaced him and impressed once again after he scored his first goal against Mallorca in a 2-2 draw midweek.
