ements. These elements include enacting laws that serve the future, striving for advancement through industrial and food self-sufficiency, preventing



abuse of authority, and ensuring the state is open to others in order to benefit from their expertise and economics, until the state achieves social stability.

Therefore, the most important element that the executive leader relies on is doing the right thing so that the administrative system becomes sound. Unfortunately, this has been lacking in the State of Kuwait for

about 30 years, especially in recent years when the encroachment of parliamentarians on the powers of the Council of Ministers worsened.

This is why we saw "wasta" become the upperhand of the leaders who followed what the parliamentarians dictated for them, instead of serving the interests of the state and society.

On this basis, let us consider the example of the law that was imposed to ban co-education. It was aimed at "purifying" society based on a backward and outdated ideological plan, which is an attempt to transfer the "Qandahari-Taliban" experience to Kuwait. This was helped by the weakness of successive Cabinets, which worked to establish strict legislation, including the so-called negative phenomena, prohibiting parties and occasions of joy, and demolishing entertainment facilities and preventing the construction of new ones.

This also led to the exodus of millions of money to neighboring countries during each holiday in order for people to enjoy a joyous moment that is forbidden to them in Kuwait. On the other hand, crimes, social violence, the rate of people addicted to drugs, travel bans and physical coercion in the name of preserving rights have increased.

Citizens no longer have an outlet to release their stress. For instance, it is a laughing matter that Kuwaiti physical education teachers in government schools are the highest in number but the rate of obesity among Kuwaiti children is also the highest in the world due to the lack of facilities that will help them in finding entertainment.

The rate in music lessons is close to its sports counterpart but the law prohibits musical concerts. As for the numbers in Islamic education, it is almost close to the two above mentioned rates.

Also, we have the highest rate of certificate forgery in the world. Fraud is almost sweeping through all Kuwaiti schools. Employee attrition and lack of employee productivity are prevalent in most government institutions.


This indicates a systematic industry of backwardness that was established by the fanatic movement when it took control of the laws and made the ministers its Trojan horses to work according to its visions.

### UK minister to seek Gaza truce. Kuwait key stop in Mideast tour

LONDON, Feb 12, (KUNA): British Minister of State for the Middle East, North Africa, South Asia and the UN, Lord Tariq Ahmed, is heading to Oman Monday on a tour that includes Kuwait and Saudi Arabia, said UK Foreign Ministry.

In a statement, the British Minister stated that he aims for an immediate ceasefire in the Gaza Strip, stressing that the escalation and instability in the region are not in anyone's interest.

"The Middle East's partners, including Oman, Kuwait, and Saudi Arabia, are crucial in achieving a permanent ceasefire in Gaza and enhancing regional security," he added.

The statement mentioned that Lord Ahmed is set to discuss strategies during the tour to improve the humanitarian situation in Gaza, including implementing an immediate truce and a permanent ceasefire. Lord Ahmed has visited

Lebanon, Saudi Arabia and the United Arab Emirates to urge an immediate ceasefire in Gaza, allowing for humanitarian aid and the release of prisoners

Elsewhere, the Amir of Qatar Sheikh Tamim bin Hamad Al-Thani, met President of Palestine Mahmoud Abbas, at the Sheikh Abdullah bin Jassim majlis in the Qatari Amiri Diwan, Monday.

In a statement, the Qatari Amiri Diwan said that during the meeting, they discussed bilateral relations and ways to enhance them, the latest developments in the Gaza Strip and the occupied Palestinian territories, the expanded cycle of violence in the region, in addition to its repercussions on regional and global security and stability.

The eight men were accused of spying while working at Al Dahra, a consulting company in the oil-rich Gulf state that advises the Qatari government on submarine acquisitions. (AP)

WASHINGTON: Iraq and the U.S.-led military coalition resumed meetings Sunday on how to draw down troops who have been deployed there for years combating the Islamic State.

The first long-awaited meeting took place Jan. 27, but had since been put on pause after Iran-backed militants struck a U.S. outpost in **Jordan** the very next day with a drone that killed three U.S. service members.

In the weeks since, the U.S. has launched multiple retaliatory strikes in Iraq and Syria including a strike last week that killed a high-ranking commander of the powerful Kataib Hezbollah militia who the U.S. said is responsible for "directly planning and participating in attacks" ' on American troops in the region. KUWAIT CITY, Feb 12, (KUNA): His Highness the Amir Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah will head to the Kingdom of Bahrain, Tuesday, on a state visit.

Kuwaiti Ambassador to the Kingdom of Bahrain, Sheikh Thamer Jaber Al-Ahmad Al-Sabah said on Monday that the upcoming visit of His Highness the Amir Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah to Bahrain would further strengthen the historical ties between the two nations.

Sheikh Thamer told KUNA that His Highness the Amir's visit would be within the framework of enhancing cooperation and coordination in all fields, which serves the interests of both countries.

Sheikh Thamer He noted that the relations were deep-rooted and harmoni-

ous as they go back generations and exceed all political and diplomatic rhetoric. Sheikh Thamer said that the visit of His Highness the Amir to the Kingdom of Bahrain and the expected meeting with King Hamad bin Isa Al-Khalifa would surely add to another milestone in the Kuwaiti-Bahraini ties.

Meanwhile, Bahraini Ambassador to Kuwait Salah Ali Al-Malki on Monday stressed the importance of His Highness the Amir Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah's visit to Bahrain and his planned meeting with King of Bahrain Hamad bin Essa Al Khalifa and Crown Prince and Prime Minister Prince Salman bin Hamad Al Khalifa.

In a statement to KUNA, Al-Malki noted that this visit is a consolidation of the bilateral ties, and the historical brotherhood, and it will undoubtedly strengthen further bonds of interdependence between the two countries and develop the strategic partnership in various fields.

This is the first visit to be made by His Highness to Bahrain after assuming office.

The Kuwaiti-Bahraini relations has always been described as strong, as the two ruling families are linked together which is a reflection of the strong relation between their people.

The history between both countries goes back and is known for the agreement and visions of their political leadership regarding their firm stance on regional and international issues based on the rational approach and the principle of dialogue.

The official visits aim to enhance the bilateral relation in various fields of common interests including trade, economy, cybersecurity and others, noting that the most recent visit was when the Bahraini King offered his condolences on the passing of the late Amir.

Bahrain's honorable stand was evident during the Iraqi invasion in 1991, when their leadership and people stood with the Kuwaiti right by welcoming their citizens and providing them with all necessities, as well as contributing to the liberation of Kuwait.

### Grand Mosque ... eye-catching architectural landmark

KUWAIT CITY, Feb 12, (KUNA): The State Grand Mosque, situated in the heart of the Kuwaiti capital, is a distinguished Islamic edifice, with diverse ornamentations and artistic shapes, opposite the sea panorama.

Skilled architects joined hands to build the large mosque in response to an order by the late Amir Sheikh Jaber Al-Ahmad Al-Jaber Al-Sabah. Construction started in 1979 and the mosque was inaugurated in 1987.

It is one of the largest mosques in Kuwait, occupying a 45,000 square meters land plot opposite the seaside Seif Palace. It includes 20,000 uncovered spaces with water canals and green and tree-shaded patches. It can accommodate 70,000 people.

The mosque includes three prayer halls; the main hall, the daily one, and the women section, in addition to the Amiri Hall, said Ali Shedad, the mosque director, in an interview with Kuwait News Agency (KUNA).

A huge dome is in the center of the 10,000 people's capacity. It is 43 meters above the ground. There is a dome in its center: adorned with Allah's Husna Names in Kufi calligraphy and blended with Quranic verses spanning for 80 meters.

The large dome is surrounded by Allah's Husna Names. It is also surrounded by four small domes, decorated with engraving's made from Moroccan gypsum and four dangling chandeliers.

Light seeps into the inner part of the mosque through 144 windows, in addition to the light emitted by the four large chandeliers -- each contains 102 bulbs, in addition to wall chandeliers.

The large dome is surrounded by four 22-m-high columns, covered with Italian marble. In the lower section, there are wooden oriel ventilation windows.

The main prayer section includes several mihrabs (prayer niches), covered with Moroccan zellij (mosaic tilework) and Islamic engravings topped with Quranic verses. The mosque's 22 doors are made from the Indian saaj wood, decorated with Quranic verses.

The women prayer section, with surrounding mashrabiyas. is located above the main one. It can accommodate some 1,000 worshippers.

The daily prayers hall accommodates 500 individuals. The minaret is surrounded by four 72-m-high columns.

The Amiri Hall, adjacent to the main prayer place, was built two years after completing the mosque construction. The Amir receives well-wishers on religious occasions at this section.

Bid to mitigate housing crisis

### **Effectiveness of law remains uncertain**

KUWAIT CITY, Feb 12: Since the implementation of the anti-monopoly law on vacant lands in late November, discussions have arisen within real estate circles and among citizens regarding its potential impact on addressing the housing issue, reports Al-Qabas daily.

More than two months into its enactment, questions persist about the law's efficacy in curbing residential property speculation, particularly as the number of pending residential applications exceeds 91 thousand. While some view the law as a positive step, others argue that it needs to be accompanied by supportive legislation such as mortgage laws, developer regulations, and housing city initiatives.

The anti-monopoly law imposes an annual fee on unbuilt private housing plots exceeding 1,500 square meters, incrementally rising to deter land speculation. However, its impact remains subject to debate, with some expecting a decline in property prices while others maintain that it alone will not alleviate the housing crisis.

Ibrahim Al-Awadi, head of the Real Es-

tate Union, emphasizes the need for a comprehensive approach, suggesting taxation on multiple property owners and promoting real estate development and mortgage systems

Suleiman Al-Dulaijan, a real estate expert, expresses skepticism about the law's effectiveness, arguing that supply and demand dynamics are primary drivers of market fluctuations.

Imad Haider, head of the Real Estate Brokers Union, criticizes the law's focus on individual landowners, advocating for market regulation instead.

Abdulaziz Al-Daghishim, another real estate expert, predicts potential loopholes and unintended consequences of the law.

Tawfiq Al-Jarrah, also a real estate expert, calls for government intervention to regulate the real estate market and provide affordable land options to citizens.

While the anti-monopoly law represents a step towards addressing land speculation, its effectiveness in mitigating the housing crisis remains uncertain without complementary measures and broader economic reforms.

## Nothing much has changed in Kuwait of yesterday and today

"THE Kuwait of today is not the Ku-wait of yesterday. Most of the successive ministries reflect the reality of the situation, and it is also a natural reflection of the outcomes of the Kuwaiti Parliament. ## Indian party takes up case of 3 fishermen

KUWAIT CITY, Feb 12: An Indian political party has taken up the cause of three fishermen who fled aboard a Kuwaiti fishing vessel. As the controversy unfolds, with allegations and denials swirling between India and Kuwait, the situation has garnered attention from both countries, reports local Arabic daily Al-Seyassah.

In response to claims made by the Indian press, Abdullah Al-Sarhid, a member of the Kuwaiti Fishermen's Union and the owner of the boat in question, vehemently denied accusations of mistreatment and withholding wages from the fishermen. He labeled the allegations as fabrications, asserting that the three individuals were not victims but rather described them as "thieves" with a history of alcoholrelated issues. Al-Sarhid presented documents, including receipts and court orders, to support his stance, indicating that the fishermen had received salaries and that two of them were legally prohibited from traveling due to prior legal issues

On the Indian side, "The Hindu" newspaper reported that a prominent member of the All India Anna Dravida Munnetra Kazhagam

(AIADMK) party, Thalavi Sundaram, visited the families of the fishermen. Sundaram assured support for the fishermen, stating that legal assistance would be provided, and their families' expenses covered until their rights are vindicated.

Meanwhile, the Indian police apprehended the fugitive fishermen, charging them with theft of the boat, illegal departure from one country, and unauthorized entry into another. The situation continues to unfold as both sides present their perspectives and pursue legal recourse.

## **Jail & KD 4mln fine maintained in Bnaider network gang conviction**

Tunisians detention extended again in 'terror' case

KUWAIT CITY, Feb 12: The detention renewal judge in the High Court, for the second time in a row, had yesterday decided to extend for 14 more days the detention of three Tunisian defendants until a court hearing is scheduled for them.

These defendants were charged with belonging to a banned organization (ISIS), carrying out a hostile act against Kuwait, and planning to commit operations against places of worship for the Shiite sect in the country. However, they denied all the charges leveled against them.

The legal counsel representing the defendants had demanded that they be released with any guarantee the court deems appropriate until the investigations into the case are completed, stressing that they do not fear fleeing the country due to the issuance of travel ban orders against them by the Public Prosecution.

Jail, fine maintained: The Court of Cassation presided over by Judge Sultan Buresli rejected the petition to reconsider the ruling that sentenced 16 members of the Bnaider network gang to prison and imposed a fine of KD 4 million after they were convicted of money laundering and forgery.

It ruled to imprison the defendants, including an Iranian expatriate, in the Bnaider Network case, after convicting them of money laundering and forging official documents.

The Court of Cassation overturned the ruling of the Court of First Instance and the Court of Appeals, which acquitted the defendants of money laundering, and decided to sentence 13 of them to ten-year imprisonment, and the rest to five-year imprisonment with hard labor, impose a fine of a total of more than KD 4 million on all of them, and confiscate the cars, jewelry, and watches retrieved from the site of the incident.

The court upheld the first-degree ruling to imprison the Iranian expatriate for 4 years for the crime of forging a vehicle license, bringing his total years of imprisonment to 14 years with hard work, followed by his deportation from the country

It is worth highlighting that the Public Prosecution had accused the suspects of committing money laundering crimes,

### 19 abandoned vehicles lifted

Field trips conducted by the Mubarak Al-Kabeer Governorate Municipality Branch's Public Cleanliness and Road Works Department yielded the removal of 19 abandoned vehicles, boats, groceries, and commercial containers, reports Al-Rai daily.

Throughout these excursions, 42 stickers were affixed to abandoned items, signaling their impending removal once the



"Some believe that the ambiguity in a person's personality gives him a kind of strength and distinction, and that his personality should not be an open book that everyone enjoys reading. "There are people who have an ambiguous personality and try to stay away from sharing the opinions of others because they see that their principles and ideas do not suit everyone, so they flee from confrontation and rely on introversion. I believe that this behavior is marred by a grave mistake and a misunderstanding, because a person cannot.

"To convince all people of his opin-

"As for the rest, their first and last understanding is to punish the Kuwaiti in any way they can. The hands of Minister Sheikh Fahd Al-Yousef must be freed to save what can be saved, starting with the young members ... Good.'

## **Big quantity of drugs** found in sheep belly

KUWAIT CITY, Feb 12: In a recent crackdown on drug smuggling, law enforcement authorities, led by Major General Hamid Al-Dawas, Assistant Undersecretary of the Ministry of Interior for Criminal Security Affairs, and Brigadier General Muhammad Qabazard intercepted a shipment of narcotics.

The operation thwarted the smuggling attempt of 5 kilos of shabu, one kilo of hashish, and 20,000 narcotic pills concealed inside live sheep skins arriving from Iran via the Doha Port.

Following intelligence reports received by the Ministry of Interior regarding a shipment of sheep suspected of containing drugs, a security team was assembled to monitor the situation.

Upon the shipment's arrival at Doha Port, destined for an unidentified person linked to a criminal syndicate comprising three individuals of Asian descent, the suspects were picked up from a suburb in Kabad.

Upon investigation, it was revealed that the defendants had ingeniously hidden the drugs inside the entrails and skin of the sheep

The seized contraband with a street value of thousands of dinars and the suspects were handed over to the concerned authorities

due to the lack of connection between them and the funds confiscated by the defendants. Therefore, it ruled that the Iranian suspect be imprisoned for only four years, a ruling that was upheld by the Court of Appeals. However, the Court of Cassation canceled that acquittal.

Earlier, the security services arrested an Iranian expatriate who owned a chalet in Bnaider. After confiscating his vehicles, they found large sums of money in the chalet.

They also followed the movement of his bank accounts and discovered that they were linked to a number of businessmen, one of whom had previously been accused in the case of seizing the funds of the Ports Fund, to which the two social security institutions contribute.

Lawyer suspended: The Lawyers'

for one month because he failed to op judgment in absentia for his client.

It also decided to suspend a lawyer who failed to handover the key to a property to the court treasury and incurred rents even though he did not use the rented property.

It is noteworthy that the Kuwait Lawyers Society referred the lawyers to the Disciplinary Department of the Court of First Înstance and recommended their disbarment due to their repeated professional breaches of the profession's charter.

'Shooter' stays in jail: The detention renewal judge ordered to extend for another two weeks the detention of an officer accused of shooting a Kuwaiti citizen in Abu Fatira due to a financial dispute.

The officer submitted a waiver from the complainant to the renewal judge after he denied the charges leveled against him.

Supervisor of Afiya Insurance Dr. Hisham Kalanda said after adding three new categories, there are more than 200,000 beneficiaries of health insurance services, according to law No. 71/2023.

He explained that the health insurance cards were delivered to the new categories benefiting from insurance from 18 locations identified by the Ministry of Health in all governorates of the country.

The segments to which the provisions of the new law No. 71/2023 apply after amending article 2 of the previous law No. 114/2014 are:-

1. Retired citizens registered with the Public Institution for Social Security,

2. A married Kuwaiti woman subject to the public assistance law,

3. A Kuwaiti widow subject to the public assistance law, or a Kuwaiti widow who receives her share from her deceased husband according to the law on the Public Institution for Social Security Law, and is not less than 50 years of age.

4. A divorced Kuwaiti woman who is subject to the public assistance Law and is not less than 50 years old.

Dr. Kalanda indicated that the number of people who are benefiting from this law after the new segments were added exceeds 40,000, and they will enjoy coverage of up to KD 15,500, adding that there are more than 400 service providers, including hospitals, centers, clinics and pharmacies affiliated with the private health sector.

### KU to host Committee of Deans meet

KUWAIT CITY, Feb 12: The College of Medicine announced the thirty-seventh meeting of the Committee of Deans of Colleges of Medicine at Universities and Higher Education Institutions in the Gulf Cooperation Council countries will be held on Feb 15 at the Kuwait University, under the auspices of the KU's Acting Director, Dr. Mishari Al-Harbi, reports Al-Jarida daily.

Minister Al-Adwani appointed the director of Administrative Affairs in the Ahmadi Educational Zone to carry out the work of the assistant undersecretary for Legal Affairs in addition to his work.

### Major victory for Agility

## ICSID Cmte makes rare annulment of previous judgment, only 5% of annulment applications granted in the history of ICSID, Agility will refile claims against Iraq

KUWAIT CITY, Feb 12: Three years ago, an international arbitration tribunal constituted under the auspices of the International Centre for the Settlement of Investment Disputes (ICSID) denied claims filed by Agility that Iraqi officials had expropriated more than \$380 million invested by Agility in an Iraqi telecom company. On Thursday (8 February 2024), an annulment committee of ICSID upheld Agility's challenge to the original award and partially annulled it. The annulment committee agreed with Agility that the original Tribunal had erroneously shielded Iraq's actions from scrutiny, thereby failing to examine whether Iraq's actions and omissions violated the protections afforded to Agility under the BIT.

As a result of this award, Agility will now refile its claims before a freshlyconstituted arbitral tribunal who will be able to determine Agility's claims. Background to the case

In February 2017, Agility filed its claims with ICSID, a World Bank organization that serves as a forum for investor-state dispute resolution. Iraq expropriated its investment in Korek Telecom, and denied it due process and fair and equitable treatment in breach of the Kuwait-Iraq bilateral investment treaty

Agility's indirect investment in Korek had been approved by Iraq's Communications and Media Commission in 2011 but, after many hundreds of dollars had been invested (including by way of license fees paid to the CMC), three years later in 2014 the CMC unilaterally decided to annul its own prior approval and declare Agility's transactions as null and void. That decision of the CMC was then forcibly implemented in 2019 by Iraq stripping Agility's indirect shareholding in Korek and transferring its stake to Iraqi shareholders including Sirwan Saber Barzani.

The original ICSID tribunal was comprised of Chairman Cavinder Bull and members John Beechey and Sean Murphy.

In the original ruling, the tribunal failed to exercise jurisdiction over Iraq's implementation of the CMC decision despite clearly having jurisdiction and it failed to answer whether the manner in which Iraq implemented the CMC decision violated the Kuwait-Iraq bilateral investment treaty. The original decision was obviously flawed.

As a result of the self-evident error in the original ruling, Agility applied for annulment before an ad hoc committee constituted by ICSID. The members of the annulment committee comprised Professor Ricardo Ramirez (President), Professor Hi-Tak Shin, and Dr. Jacmijn van Haersolte van Hof.

Annulment of the original ruling

On 8 February, 2024, the Annulment Committee (by majority) upheld Agility's challenge to the original award and partially annulled it. The Annulment Committee agreed with Agility that the original Tribunal had erroneously shielded Iraq's actions from scrutiny, thereby failing to examine whether Iraq's actions and omissions violated the protections afforded to Agility under the BIT. In so doing, and in failing to state the reasons on which its decision was based, the original Tribunal committed an annullable error pursuant to Article 52(1)(b), as well as Article 52(1)(e), of the ICSID Convention.

The committee stated, "By focusing solely on the 'expropriation claims that arise solely as a result of the faithful implementation of the CMC Order,' the Tribunal failed to address or scrutinize the way in which the CMC Order was implemented by Iraq and, thus, committed an excess of powers." The Committee went further to state, "The Committee considers that this

finding is reinforced by the fact that, not exercising jurisdiction over the con-

sistency with the BIT in terms of the expropriation claims had also rippling effects on the other claims raised by Agility, which ultimately rendered all of them unresolved.'

As a result of this award, Agility will now have the opportunity to re-file its claims before a freshly-constituted arbitral tribunal at ICSID who will be able to determine Agility's claims relating to Iraq's expropriation of Agility's investment, its failure to treat Agility fairly and equitably, and its failure to accord Agility with full protection and security as required by the BIT.

Following the recent annulment decision, Agility said: "Three years ago, the ICSID tribunal clearly got it wrong. They shielded from review Iraqi conduct that plainly violated the basic assurances against expropriation and unfair and inequitable conduct enshrined in the bilateral investment treaty between Kuwait and Iraq: protections of which Agility was the beneficiary. We are cognizant that less than 5% of BIT awards are annulled, and are incredibly thankful to Professor Ricardo Ramirez (President) and Professor Hi-Tak Shin for their courage in annulling this patent travesty of justice.

To date, there have been four claims against Iraq filed with the ICSID. Three of those claims have been in connection with the actions of the CMC, and three stem from investments in companies based in the semi-autonomous Kurdish area of northern Iraq. Separately, Agility is also moving expeditiously to enforce its arbitral award of more than US\$1.6 billions directly against Korek, Sirwan Barzani and others.



They requested the Assembly to assign the Health, Social and Labor Affairs Committee to study the delayed registration of new medicines and medical equipment by the Ministry of Health. They pointed out that such a delay deprives the patients of their right to benefit from the new medicines and medical equipment made by the concerned companies and research centers. They said the committee's report should include the procedures and average time needed for the registration of one new medicine. reasons behind the delay and recommendations to shorten the period.

MPs Osama Al-Shaheen, Hamad Al-Obaid, Badr Nashmi, Abdullah Fehad and Shuaib Shaaban submitted a bill on amending Housing Welfare Law No. 48/1993. The bill stipulates amending Clause One of Article 29bis to allow the citizens who sold their houses three times to obtain a housing loan from Kuwait Credit Bank (KCB). The current law states that only those who sold their houses once can obtain a housing loan from KCB.

In another development, MP Muhammad Al- Mahan said he met with Chairman of the Public Authority for Applied Education and Training (PAAET) Hassan Al-Fagam to discuss the establishment of PAAET's headquarters in the South. He affirmed that preparation of the tender for the project is ongoing. He added an agreement was reached not to use the buildings of special needs schools as temporary headquarters, because these schools are needed.

He also contacted Undersecretary of the Ministry of Education Anwar Al-Hamdan to inquire about the vacant schools in the South, which can be used as temporary headquarters for PAAET. He is following up the renewal of contracts for transporting students from the South to the schools in the other parts of country.

MP Shuaib Shaaban forwarded queries to Deputy Prime Minister, Minister of Defense and acting Minister of Interior Sheikh Fahd Yusuf Al-Sabah about the latter's visit to Al-Rabia Police Station on Feb 1, 2024. He asked if the minister ordered the detention of a securityman for being tardy, if this is a legal procedure and if the military personnel are imprisoned without investigation or trial.

According to sources, Shaaban is

preparing a two-point grilling motion against the minister; but the lawmaker has yet to confirm this.

KUWAIT CITY, Feb 12: Director of the Medical **Emergency Department Dr.** Ahmad Al-Shatti affirmed that Gulf solidarity in the field of health care helped in successfully overcoming the COVID-19 crisis without falling into the trap of pressure on health services and facilities that many countries of the world suffered from.

In a press statement issued after the opening of the GCC Quality and Safety of Medicines, Devices and Medical Care Conference yesterday, Dr. Al-Shatti expressed his pride in Kuwait passing the COVID-19 pandemic period successfully.

He indicated that Kuwait had a surplus of clinical capacity of about 25 percent compared to some developed countries around the world, which were subjected to severe pressure on health services during the pandemic period

Dr. Al-Shatti stressed the importance of highlighting the regulatory and supervisory frameworks in ensuring the safety and security of medicine, devices and medical care, as well as the importance of strengthening oversight over them and supporting and localizing the pharmaceutical industry.

In a speech he delivered during the conference, he explained that such GCC medical conferences work to create a participatory platform to present successful experiences and exchange experiences among the GCC countries, and seek to achieve medicine security, and strengthen joint cooperation between the Gulf countries in a way that serves the health system.

The conference serves as a platform for scientific and practical discussion, during which the latest technical and scientific developments in the areas of safety and quality of medicines, devices and medical care are presented, in addition to transferring and localizing expertise, enriching knowledge with pharmaceutical education, and digitizing the

Furthermore, the Assistant Director General of the Primary Health Care Corporation in Qatar Musallam Al-Nabit said, "Our participation in the conference comes from our belief in the importance of enhancing the digital transformation of the medical and pharmaceutical sector in the GCC countries. We are participating in finding solutions and modern technologies in the pharmaceutical sector, medical devices and equipment, and health care that GCC countries need.

Al-Nabit highlighted the scientific and technical developments and digital transformation witnessed in the past period, which necessitate attracting important solutions and expertise from countries around the world to meet the region's technical and technological needs in the field of medical progress, treatments, and smart systems.

Meanwhile, Assistant Undersecretary for Contracts and Supply in the Ministry of Health of Saudi Arabia Dr. Marai Al-Qahtani said in his speech that the conference witnessed a review of Saudi Arabia's experiences, and discussions on several important axes in raising the level of supply and organization of medical supplies, in line with national strategies to achieve the security and availability of medical supplies.

He praised the level of health that Saudi Arabia has reached, stressing that prevention, public health, innovation and sustainability are four priorities that the health sector transformation program places at the forefront of its goals, and it works to expand the provision of e-health services and digital solutions and improve the quality of health services while adhering to the highest international standards in providing health services.

Dr. Al-Qahtani explained that Saudi Arabia is one of the first countries to establish independent bodies such as the Food and Drug Authority, which is concerned with monitoring, registration and safety of medicines.

It also established an electronic tracking system called "Rasd" for pharmaceutical preparations as part of its plan to contribute to achieving the New Kuwait 2030 vision by adopting the latest technical means and using them to track and trace all human medicines manufactured within Saudi Arabia or imported from abroad.

This system contributes to strengthening the authority's role in protecting society, enhancing oversight, and ensuring the safety of medicines by knowing their source and the stages they went through from manufacturing until they reach the consumers.

Dr. Al-Qahtani highlighted the establishment of the Health Holding Company, which handles about 23 health clusters and more than 300 hospitals.

He also highlighted the existence of the National Unified Purchasing Company, stressing the importance of cooperation among the GCC countries in this aspect, and unifying procurement processes for government programs for the health sector through the Gulf Health Council.

## **Tusk heads to France Ex-PM Stubb wins** Finnish presidency

HELSINKI, Feb 12, (AP): Finland has a new president after former Prime Minister Alexander Stubb narrowly won a runoff vote Sunday for the key post in this Nordic country. Stubb, who takes over in March, will steer Finland's foreign and security policy, including integrating the NATO newcomer into the alliance's core structures.

The final tally shows Stubb, of the center-right National Coalition Party, had 51.6% of the votes, while independent candidate and former Foreign Minis-



ter Pekka Haavisto from the green left got 48.4% of the votes. The two were the contenders in the second round of the election. Haavisto had served as Finland's top diplomat in 2019-2023.

Stubb is taking over from the hugely popular President Sauli Niinistö, whose second six-year term expires next month and who wasn't eligible for reelection. A runoff was required after

none of the original nine candidates got a majority of the votes in the first round on Jan. 28. In tradition with consensus-driven Finnish politics and no belowthe-belt attacks during the campaign, Stubb visited Haavisto's election party event late Sunday after the result was clear.

Tusk heads to France. Germany: Poland's Prime Minister Donald Tusk was traveling to Paris and Berlin on Monday in a diplomatic effort to rebuild key alliances as fears grow that former US president Donald Trump could return to power in the United States and give Russia a free hand to expand its aggression in Europe.

The meetings on Monday come after Trump shocked many in Europe on the weekend by inviting Russia to invade any NATO member not spending enough on its own defenses.

These comments are irresponsible and even play into Russia's hands," German President Frank-Walter Steinmeier said Monday during a visit to Cyprus, remarks carried by the German dpa news agency. "And no one in our alliance can have an interest in that."

The words were particularly shocking for frontline NATO countries like Poland, which has endured Russian control and occupation, and where anxieties run high over the war just across its eastern border in Ukraine.

'Plan incompatible with human rights': The British government's plan to send some asylum-seekers on a one-way trip to Rwanda is "fundamentally incompatible" with the U.K.'s human rights obligations, a parliamentary rights watchdog said Monday, as the contentious bill returned for debate in the House of Lords.

Parliament's unelected upper chamber is scrutinizing a bill designed to overcome the U.K. Supreme Court's ruling that the Rwanda plan is illegal. The court said in November that the East African nation is not a safe country for migrants.

## GOP works to recruit female, minority candidates Will Biden, Trump face one another in debates?

WASHINGTON, Feb 12, (AP): Nikki Haley is challenging Donald Trump to debate. Trump is challenging Joe Biden to debate. And Biden is laugh-

But there are real questions about whether any of them will confront each other on a stage this year.

Biden's reelection campaign has repeatedly declined to commit to joining debates with Trump, his likely opponent in the November general election. Trump, meanwhile, has feuded with the Republican National Committee and refused to join its primary debates. In 2020, he objected to the rules of the nonpartisan commission that has hosted general election debates since 1976.

While any disputes could be resolved by the fall, the uncertainty reflects how both Biden and Trump are increasingly choosing to reach voters in environments they control at the expense of nonpartisan interviews or events where they might face unfriendly questions. Both the 81-yearold Biden and 77-year-old Trump have at times confused names and countries and face widespread doubts from voters about their age and readiness.

Debates are not mandatory, but they are considered a traditional test for candidates where they have no aids or teleprompters. The first televised presidential debate was in 1960 between Richard Nixon and John F. Kennedy, but it didn't become a recurring event until 1976 when the League of Women Voters begin sponsoring presidential debates. They are now sponsored by the Commission on Presidential Debates, a nonprofit established in 1987 that outlines the rules for each debate and selects the location, dates and moderators.

Frank Fahrenkopf, co-chair of the commission, says it's too early to entirely write off the prospect of debates in 2024.

King Charles III attends church: King Charles III cheerfully waved to well-wishers on Sunday as he left church services near his country estate in eastern England, making his first public appearance since his cancer diagnosis was announced last week.

Wearing a tan overcoat against the February chill and carrying a rolled-up umbrella, Charles was joined by Queen Camilla at StMary Magdalene Church, just a few hundred yards from Sandringham House where the king is recuperating after his first treatment for an unspecified form of cancer.

The 20,000-acre Sandringham estate, some 110 miles (180 kilometers) north of London, is a favorite refuge of the king's and offers a place of shelter where he can isolate from the risk of infection.

Fire breaks out at water park: A fire broke out Monday at a waterpark under construction at one of the Nordic region's biggest amusement parks, sending a huge plume of black smoke drifting over Goteberg, Sweden's second-largest city.

The blaze spread across several yet-to-be-opened waterslides at Liseberg park, and police and fire officials could not immediately say whether there were any casualties.

The fire department urged people in the area affected by the smoke to "go indoors and close doors, windows and ventilation" and listen to the local radio.

Shooting at Greek shipping co kills 4: Three people were fatally shot Monday in the offices of a shipping company near Athens and the suspected gunman also took his life as police special forces prepared to confront him, authorities said.

The shooting occurred in the shipping company office in Glyfada, a seaside suburb of the capital. The alleged gunman, an unidentified company employee, entered the building armed with a shotgun and handgun, according to several witnesses.

Police spokesperson Consantia Dimoglidou said the owner of the company was among the victims.

"The suspected perpetrator, who worked for the family, was found dead in a different area from the three deceased people at the company. He had his assault weapon next to him and appears to have shot himself in the head," Dimoglidou said.

She said police and special forces officers had entered the building before the suspected shooter was found and had been making sure other employees were moved safely out of the building.

Greek authorities rescue 84 migrants: Greek authorities found 84 migrants arriving by sea and arrested four individuals, accusing them of being the traffickers that transported them, the coast guard said Sunday.

Both incidents occurred early Saturday, it said.

In the first incident, the coast guard was alerted to a boat drifting, due to mechanical failure, at sea, 46 nautical miles (85 kilometers) south of the island of Crete.

A Greek Navy frigate found the boat and rescued a total of 72 individuals, 58 of them men and 14 minors, transporting them to Crete.

**'Officer killed in stabbing':** A New Mexico police officer died after he was stabbed by a suspect, who was shot and killed by a witness to the attack on Sunday evening, police said. Las Cruces Patrol Officer Jonah Her-

nandez was stabbed at least once shortly before 5 p.m. after responding to a report of a trespasser on South Valley Drive, the Las Cruces Police Department said in a statement posted on social media. A witness to the attack used the offic-

er's police radio to call for help after the stabbing, but Hernandez died after he was transported to MountainView Regional Medical Center in Las Cruces, police said.

The suspect, a 29-year-old man, was believed to have been shot and killed by the same witness, according to police, who did not release the suspect's identity pending notification of his next of kin. (AP)

Woman killed in shooting: A woman in a trenchcoat opened fire with a long gun Sunday inside celebrity pastor Joel Osteen's megachurch in Texas, sending worshippers rushing to find safety while two off-duty officers confronted and killed the shooter. Two other people were shot and injured, including a 5-year-old boy who was in critical condition.

The violence erupted shortly before the Houston church's 2 pm Spanish service was set to begin, just as the rest of the country was preparing for the Super Bowl. The woman entered the enormous Lakewood Church - a building with a 16,000-person capacity that was previously an arena for the NBA's Houston Rockets -- with the boy who was later hurt in the shootout with police. A man in his 50s was also wounded.

Details of the confrontation remain unclear in the hours after the tragedy, and police have not released the woman's identity or a possible motive. It's also unknown what relationship, if any, the woman had to the boy, and who actually shot him and the man. (AP)

CARACAS, Venezuela, Feb 12, (AP): The government of Venezuela accused neighboring Guayana Sunday of granting illegal oil exploration concessions in territory the two nations are disputing. Venezuela said it would reserve the right to take any diplomatic actions necessary. The comments Sunday came after Guyana said

Saturday that it has satellite imagery showing Venezuelan military movements near the South American country's eastern border with Guyana.

Venezuela's statement did not deny Guyana's claim of a military and infrastructure buildup. Rather, it said it was within its rights to beef up its border forces.

Venezuela claimed Guayana had granted "illegal oil concessions ... in a maritime area that is indisput-



ably Venezuelan." Öil giant ExxonMobil has said it will keep ramping up production in offshore fields off Guyana despite the escalation of the territorial dispute.

The two sides have feuded over border lines for decades. Venezuela has been laying claim to the mineral-rich Essequibo region, which covers about two thirds of Guyana's surface area

Persaud

Both sides accused the other of breaching a peace agreement signed in the Caribbean in December to ease tensions over border demarcation lines

Under the Argyle Agreement signed on the island of St. Vincent in December, the two countries agreed not to use force or to threaten each other. The talks were brokered by Brazil and Caribbean governments.

The latest developments came hours after satellite images posted by the US Center for Strategic and International Studies (CSIS) showed Venezuela is extending its base on Ankoko Island, half of which Venezuela seized from Guyana in the mid-1960s, and nearby Punta Barima, less than 50 miles (80 kilometers) from the Guyana border.

### Improvement

The images showed significant infrastructure improvement of roads and other facilities near the two areas, the CSIS said. Foreign Secretary Robert Persaud noted that "Guyana will continue to respect the Argyle Declaration and hopes that Venezuela will do the same.

Guyana argues that an 1899 international boundary commission settled the border demarcation once and for all

But for more than 60 years Venezuela has accused the commission of cheating it out of the Essequibo region.

Guyana has taken the issue to the World Court in the Netherlands for a definitive ruling, while Venezuela has said it prefers direct bilateral talks as the way forward

On Friday, the Venezuelan defense ministry accused Guyana of threatening the St. Vincent agreement by irresponsible actions and media deception, maintaining that the "Essequibo is ours."

It also said that ExxonMobil, which is producing 645,000 barrels of offshore oil daily from Guyana, is collaborating with the government and the US mili-

BANGKOK, Feb 12, (AP): Myanmar's military government on Saturday activated for the first time a decade-old conscription law that makes young men and women subject to at least two years of military service if called up, effective immediately. The announcement of the measure on state television amounts to a major, though tacit, admission that the army is struggling to contain the nationwide armed resistance against its rule.

Under the 2010 People's Military Service Law, passed under a previous military government, men aged 18 to 45 and women 18 to 35 can be drafted into the armed forces for two years, extendable to five years during national emergencies. The upper age of people in the population at large subject to conscription is 35 for men and 27 for women, and the higher age ranges apply to men and women in certain professional categories, such as medical doctors and engineers, and their service term is three years.

Human rights activist held: The administration of Venezuelan President Nicolás Maduro has arrested human rights activist Rocio San Miguel, the government confirmed Sunday.

Tarek William Saab, Venezuela's attorney general, wrote in his social media accounts that San Miguel had been arrested on charges of conspiracy against Maduro, but did not offer any details of the supposed case against her.

San Miguel, 57, is a lawyer and rights activist who has specialized in studying Venezuela's shadowy, often corrupt armed forces.

Saab claimed San Miguel had been linked to a plot to kill Maduro or other officials and attack the armed forces

San Miguel was arrested Friday at an airport in Caracas, and rights activists say they do not know where she was taken.

"We do not know where she is now," said Gonzalo Himob, a leader of the rights and civic group Foro Penal, which estimates the Maduro regime is holding 261 political prisoners.

Woman killed in apparent crossfire: An American woman and a man from Belize have been killed in what appears to have been a dispute between drug dealers at a beach club in the Mexican resort city of Tulum, officials confirmed Sunday.

Prosecutors in the Caribbean coast state of Quintana Roo stressed the American woman had no connection to an alleged drug dealer also killed in the shooting Friday night. Prosecutors didn't provide the woman's name or hometown, and the US Embassy did not respond to a request for comment.

The woman may have simply been caught in the crossfire. Prosecutors denied reports in local media that the two may have been a couple, saying a photo of the Belizean man showed him with a completely different woman.

The Central American country of Belize shares a border with Mexico on the Caribbean coast. Tulum is located south of Cancun and Playa del Carmen, closer to Belize

Plane crash kills one: A plane carrying four Canadian skydivers came down on a beach Sunday in southern Mexico, killing one man who was on the beach.

There was no immediate information on why the plane went down, but it appeared to have made a forced landing and was largely intact.

However, it fell in a relatively populated section of the beach at the Pacific coast town of Puerto Escondido, and landed almost on top of the victim, whose nationality was not disclosed.

The four Canadians and one Mexican man aboard the small aircraft were removed from the plane and taken for treatment. The Oaxaca state civil defense office said they were in "stable" condition.

There was no immediate information on the names or hometowns of the Canadians.

The office said the dead man's wife had been nearby but was unharmed.

Nigeria mourns Wigwe's death: Nigerian leaders Sunday mourned the death of the CEO of one of the country's largest banks after he and five others were killed Friday in a helicopter crash in Southern California's Mojave Desert.

Herbert Wigwe, chief executive of Access Bank, and his wife and son were among the six people on board when the aircraft went down shortly after 10 p.m. near Interstate 15. All six people were killed, including two pilots and Bamofin Abimbola Ogunbanjo, former chair of NGX Group, the Nigerian stock exchange

Nigeria's president, Bola Ahmed Tinubu, grieved the deaths in a post on X, formerly known as Twitter.

"Their passing is an overwhelming tragedy that is shocking beyond comprehension, he wrote. "I pray for the peaceful repose of the departed and ask God Almighty to comfort the multitude of Nigerians who are grieving and the families of the deceased at

this deeply agonizing moment." The death of Wigwe, 57; his wife, Chizoba; and son, Chizi, shocked many in Nigeria and in the banking sector. He was widely seen as an industry leader, having been involved in two of the country's biggest banks, including Guaranty Trust Bank, where he was previously executive director. (AP)

**Ghana artifacts returned:** Seven royal artifacts looted 150 years ago by British colonial forces from Ghana's ancient Asante kingdom and kept by a United States museum have been returned and presented to the kingdom on Thursday, the latest of a series of stolen treasured items being repatriated to several African countries.

Looted from British-colonized Ghana in the 19th century before being transferred to Fowler Museum at the University of California, Los Angeles, in the 1960s, the artifacts included an elephant tail whisk, an ornamental chair made of wood, leather and iron, two gold stool ornaments, a gold necklace and two bracelets.

"We are here ... (because) the white man came into Asanteman to loot and destroy it," Otumfuo Osei Tutu, the king of the Assante kingdom in Ghana's largest city of Kumasi, said at a presentation ceremony that brought joy and relief to the kingdom.

After decades of resistance from European and Western governments and museums, cil, came to power in 2021 after ousting the elected civilian government of Aung San Suu Kvi.



### Kuwait's GDP drops by 11.7% in Q3 2023

Data released by the Central Administration of Statistics reveals a significant downturn in Kuwait's gross domestic product (GDP) during the third quarter of 2023, plunging by approximately 11.7% compared to the same period in the previous year, re-ports Al-Qabas daily.

According to the report, the GDP value at current prices plummeted to 12.7 billion dinars in Q3 2023, down from 14.3 billion dinars in Q3 2022. This decline is largely attributed to a staggering 22.1% decrease in the value added of the oil sector, propelled by a downturn in global oil prices.

However, amidst this downturn, the non-oil sector wit-nessed a 2.4% growth at current prices in Q3 2023 compared to the same quarter of 2022, reaching a value of 6.2 billion dinars. Nevertheless, the GDP at constant prices experienced a 3.7%

decline in Q3 2023, totaling 9.8 billion dinars, with the oil sector's added value decreasing by 9% while the non-oil sector's added value expanded by 2.8%

Analyzing specific economic activities, oil and natural gas extraction activities and related services continued to dominate GDP contributions at current prices, albeit with a reduced relative share from 57.6% to 50.8% compared to the previous year.

## US service sector picks up, labor market maintains resilience

### Highlights

• US service sector growth picked up in January, with the non-manufacturing PMI increasing to 53.4 from 50.5 in December.

• Data in the last two weeks continues to illustrate a robust US labor market. The unemployment rate has remained below 4% for two consecutive years while wage growths continues to run ahead of the 3-3.5% range.

• Consumer prices in China suffered the biggest drop since 2009, with the CPI dropping by 0.8% y/y in January. The weak figure is likely due to distorted figures as January 2023 coincided the Lunar New Year.

• The greenback is trading at a 2-month high and has gained significant strength against the Japanese yen which has suffered a 6.2% drop year-todate. Meanwhile the euro and pound are trading just below the 1.08 and 1.27 marks.

### **United States**

### Service Sector Picks Up, Labor Market Maintains Resilience

Growth in the US services sector picked up in January amid an increase in new orders and a rebound in employment. However, suppliers fell behind, resulting in input prices rising to an 11-month high. The Institute for Supply Management said its non-manufacturing PMI increased to 53.4 last month from 50.5 in December, indicating growth in an industry which accounts for more than two-thirds of the economy.

The data is in-line with the prior week's employment figures which revealed acceleration in January's job growth and wages by the most in nearly two years. The unemployment rate has remained below 4% for two consecutive years - the longest stretch in more than 50 years. Meanwhile, wage growth is running ahead of the 3-3.5% range that policymakers view as consistent with the Federal Reserve's 2% inflation target. Overall, Janu-

ary's powerful job report eliminated prospects of a rate cut next month, and the odds of a May cut were lowered.

More labor data revealed the number of Americans filing new claims for unemployment benefits fell slightly more than expected last week, illustrating underlying labor market strength despite a recent surge in layoffs mostly in the technology industry. Initial claims decreased by 9,000 to 218,000 in the week ending February 3rd, according to the Labor Department. Continuing claims dropped to 1.87 million in the week that ended on January 27th. While the labor market has proved remarkably robust in recent months, powering consumer spending, recent high-profile jobcut announcements from companies across the tech industry may signal slower demand for workers in the coming months.

### **Asia-Pacific**

**China Sinks Deeper into Deflation** Consumer prices in China slid deeper into deflationary territory last month, suffering the biggest drop since the global recession in 2009. The country's Consumer Price Index dropped by 0.8% y/y in January, marking the steepest fall since September 2009 and marks a fourth consecutive month of decline.

The National Bureau of Statistics attributes the weak figure to the strong demand in January 2023 for the Lunar New Year when CPI rose 2.1%. This year the Lunar New Years falls in February, causing distortions to the base. Beijing is currently struggling to revive both consumer and investor confidence as it faces many challenges, including a real estate slump, stock market meltdown and weaker exports. Nevertheless, many analysts believe consumer prices are likely to rise from February onwards.

### Reserve Bank of Australia cites "Uncertain" Outlook

The Reserve Bank of Australia held its policy interest rate steady at 4.35% in a widely anticipated decision which followed 13 consecutive rate hikes since 2022. It noted that goods inflation was lower than forecast, but that services inflation remained high, with overall inflation at 4.1%.

RBA Governor Michelle Bullock held a press conference after the meeting stating that the country was on track to get inflation within the bank's 2% to 3% target band by 2025, and to reach the midpoint of that range by 2026.

Bullock added that while there were "encouraging signs," the RBA remains "vigilant" to upside risks that would make it difficult to achieve its target. In its statement announcing its decision, the RBA said it didn't exclude further rises. "We're not ruling in or out anything," Bullock said. 'We are focused on bringing inflation down. We still think the risks are balanced but, as you would know, the further out we go with our forecasts, the more uncertainty there is around them."

A total of 243 million shares were traded through 14,404 cash deals, amounting to 80.4 million dinars (approximately 245 million dollars). This led to a rise in the market value of the stock exchange to 542 million dinars (1.76 billion dollars), reaching 43.307 billion dinars compared to the previous session's 42.849billion dinars.

Notably, the main market index climbed 24.3 points to reach 5,943 points, reflecting a 0.4% increase, with 103 million shares traded through 6,856 cash transactions worth 20 million dinars (about 61 million dollars). Additionally, the primary market index rose by

dinars (approximately 184 million dollars).

The Main 50 index witnessed a 0.2% increase, rising by 13 points to reach 5,875 points, with trading activity involving 75.4 million shares through 4,235 cash deals worth 16 million dinars (around 48.8 million dollars).

The session observed a positive performance in 9 sectors, notably in consumer services, which surged by approximately 2.41%.

Conversely, 3 sectors, primarily consumer goods, experienced a decline of 11.66%, while the healthcare sector remained stable. Among individual stocks, 70 saw gains, with "Nakheel" leading the pack with a remarkable increase of 126.97%, while 47 stocks, led by "Unicap," declined by about 8.85%. Meanwhile, the prices of 6 stocks remained unchanged.

Trading activity was dominated by "KFH" stock, which rose by 2.19%, accounting for a volume of 33 million shares and liquidity of 26.05 million dinars.

### External shocks likely to trigger downturn

Majority of analysts predict no recession in US this year

WASHINGTON, Feb 12, (AP): Just a quarter of business economists and analysts expect the United States to fall into recession this year. And any downturn would likely result from an external shock - such as a conflict involving China - rather than from domestic economic factors such as higher interest rates.

But respondents to a National Association of Business Economics survey released Monday still expect year-over-year inflation to exceed 2.5% -- above the Federal Reserve's 2% target - through 2024.

A year ago, most forecasters expected the U.S. economy - the world's largest - to slide into a recession as the Fed raised interest rates to fight a burst of inflation that began in 2021. The Fed hiked its benchmark rate 11 times from March 2022 to July 2023, taking it to the highest level in more than two decades.

Inflation has fallen from a peak of 9.1% in June 2022 to 3.4% in December. But the economy unexpectedly kept growing and employers kept hiring and resisting layoffs despite higher borrowing costs.

The combination of tumbling inflation and resilient growth has raised hopes - reflected in the NABE survey - that the Fed can achieve a so-called soft landing: vanquishing inflation without the pain of a recession.

"Panelists are more optimistic about the outlook for the domestic economy," said Sam Khater, chief economist at mortgage giant Freddie Mac and chair of the association's economic policy survey committee.

The Fed has stopped raising rates and has signaled that it expects to reduce rates three times this year.

But a growing share of business forecasters worry that the Fed is keeping rates unnecessarily high: 21% in the NABE survey called the Fed's policy "too restrictive," up from the 14% who expressed that view in August. Still, 70% say the Fed has it 'about right.'

What worries respondents are the chances of a conflict between China and Taiwan even if it isn't an outright war: 63% consider such an outcome at least a "moderate probability." Likewise, 97% see at least a moderate chance that conflict in the Middle East will drive oil prices above \$90 a barrel (from around \$77 now) and disrupt global shipping.

Another 85% are worried about political instability in the United States before or after the Nov. 5 presidential election.

The respondents are also increasingly concerned about U.S. government finances: 57% say budget policies - which have created a huge gap between what the government spends and what it collects in taxes - need to be more disciplined, up from 54% in August.

They say the most important objectives of government budget policy should be promoting medium- to long-term growth (cited by 45% of respondents) and reducing the federal deficit and debts (42%). Coming in a distant third - and cited by 7% -- is the goal of reducing income inequality.

## WGS creates new priorities for governments

'50% of global growth comes from China and India'

DUBAI, Feb 12, (KUNA): Chairman of the World Governments Summit (WGS) Mohammad Al-Gergawi said on Monday that 50 percent of global growth comes from China and India and that those countries would shape the future of global economic growth.

Al-Gergawi added during the opening speech of the WGS 2024 in Dubai that the global economy compass point to China and India, the rest of Asia-Pacific region would contribute up to 25 percent of global growth, meaning that more than 70 percent of global economic growth will come from the East, questioning how can humanity cooperate to benefit from this rising global economic engine.

The summit, which began today, focused on opportunities and vast areas of growth and development as governments always need a pause to arrange their priorities and direct their energies towards building a better future for the upcoming generations.

The participants of the summit included 85 important international organization, 120 governments, more than 25 heads of state and government, 700 heads of major international companies and more than 4,000 specialists and officials.

Al-Gergawi reviewed four indicators of positives the world experiences today, the first of which is the doubling of human life and health, as human lifespan has doubled in the last 200 vears.

The second indicator was the continuous decline in poverty, the number of poor countries has shrunk by half in just 20 years, and poverty rates have been reduced by 50 percent in 25 other countries.

The third of indicator was the large breakthrough of knowledge, where 120,000 new books get published every month and 6 million articles are posted on blogs daily, illiteracy has been eradicated in 86 percent of people, and the world has registered 33 million patents within one decade, and education has become transcontinental, regardless of age and time.

The fourth indicator was the easy interconnection and ability to travel, the creation of hundreds of millions of new jobs and connected millions of people to each other, as the size of the global logistics sector has reached about eight trillion dollars.

Al Gergawi expressed his hope that The WGS would achieve ex-

ceptional success in creating new priorities for governments and redirect the world's attention towards new and great opportunities that benefit everyone.

His Highness the Prime Minister Sheikh Dr. Mohammed Sabah Al-Salem Al-Sabah received a letter that included an invitation to attend the summit from the UAE's Prime Minister and Ruler of Dubai, Sheikh Mohammad Al-Maktoum.



Jamal Al-Humairi, Acting Group Chief Financial Officer (AGCFO) and General Manager Financial Control and Regulatory Reporting presented the financial performance of KFH group for the year ended 31 December 2023.

He said that the Group has achieved Net Profit After Tax attributable to Shareholders for the year ended 31st December 2023 of KD584.5mn higher by KD 226.8mn or 63.4% compared to 2022 of KD 357.7mn.

The higher profit is mainly from increase in total operating income, lower provision and lower net monetary loss that resulted from the application of IAS-29 "Financial reporting in Hyperinflationary Economies" on the financial statements of Kuwait Turkish Participation Bank (KTPB). Partly offset by an increase in operating expenses and taxation.

Al-Humairi explained that financing income has increased by KD 871.9mn or 65.9% compared to last year due to consolidation of AUB for full year 2023 and increase in yield and average profit earning assets.

Net financing income at KD 965.9mn increased by KD 165.4mn or 20.7% compared to last year mainly due to an increase in financing income by KD 871.9mn offset by increase in finance cost and distribution to depositors by KD 706.4mn.


Meanwhile, Eng. Fahad Al-Mukhaizeem, Group Chief Strategy Officer covered highlights of the Kuwait operating environment with an overview on KFH. He also shared KFH's strategy, as well as Full Year-2023 results.

Al-Mukhaizeem explained that in 2023, Kuwait's Central Bank (CBK) increased its discount rate by 75 basis points to 4.25%, as part of its efforts to preserve monetary and financial stability, boost the growth of the various economic sectors, especially the non-oil sectors, contain local inflationary pressures, and maintain the competitiveness and attractiveness of the national currency.

Al-Mukhaizeem added "Kuwait's GDP was estimated to reach KWD 39.6 billion in 2023 and increase to KWD 40.8 billion in 2024 according to the most recent International Monetary Fund (IMF) report released in October 2023. It is also expected that the annual average inflation rate to decline to 3.4% in 2023. Kuwait's crude oil price stood at USD 79.6 pb as of the end of December 2023, down by 0.72% from the same period of the previous year."

He pointed out that Kuwait's economic development in 2023 was driven by its diversification efforts, infrastructure investments, and commitment to sustainability. As the country continues to work on attracting foreign investment, fostering non-oil sectors, and prioritizing sustainable practices, Kuwait is well-positioned to achieve long-term economic prosperity. The leadership shifted smoothly, after the passing of the Late Amir, His Highness Shaikh Nawaf Al Ahmad Al Jaber Al Sabah – May Allah have Mercy on his soul- to His Highness the Amir of Kuwait Shaikh Meshal Al Ahmed Al Jaber Al Sabah in December of 2023, May Allah protect him. This contributes to the stability of the local environment in addition to the formation of a new government led by His Highness the Prime Minister Shaikh Dr. Mohamed Sabah AlSalem Al Sabah to complete the development path.

Nevertheless, it is imperative for Kuwait to continue work on improving the business environment and investing in human capital to

ensure sustainable growth. With the right strategies in place, Kuwait can successfully navigate the dynamic global economic landscape and emerge as a model for economic development in the region.

Al-Mukhaizeem said that KFH's long term

Al-Humairi said that KFH cautious approach towards provisioning have contributed to credit provision balance exceeding ECL required as per CBK IFRS 9 by KD 548mn as of 31 December 2023.

Al-Humairi highlighted that total Assets at KD 38bn increased by KD 1.04bn or 2.8% in 2023.

Net financing receivables at KD 19.4bn increased by KD 625mn or 3.3%.

Investments in debt securities at KD 7bn has increased by KD 921mn or 15.1%

Additionally, deposits for 2023 at KD 21.8bn are higher by KD 782mn or 3.7% compared to FY 2022.

The contribution from CASA deposits to total group customer deposits as at the end of 2023 is 42.1% and on overall basis group continues to benefit from a large pool of low-cost deposits.

Contribution of customer deposits to total funding is 71.7% compared to 71.4% in 2022.

## Gulf Bank records net profit of KD 71.2 mln in '23, increase of 15.2% over '22

KUWAIT CITY, Feb 12: Gulf Bank K.S.C.P. ("Bank") announced its financial results for the year ended 2023. The Bank reported a net profit of KD 71.2 million, an increase of 15.2% compared to the year 2022.

Gulf Bank recorded an operating profit before provisions and impairments of KD 103.4 million for the year 2023, an increase of 9.0% compared to the year 2022.

Earnings per share were up 13.2% to 21fils and the Board of Directors is recommending a distribution of a cash dividend of 12fils per share, representing a 57% cash payout ratio, in addition to 5% bonus shares, for shareholders' approval at the Annual General Meeting to be held in March 2024.

The increase in the net profit was mainly driven by KD 8.2 million or a 5.8% increase in net interest income, a 2.5% or KD 1 million improvement in non-interest income, and a decline of 4.7% or KD 1.4 million in total provisions and impairments.

As for asset quality, the non-performing loans (NPL) ratio stood at 1.2% as of 31 December 2023, compared to the prior year level of 1.1%. Additionally, the Bank continues to have significant non-performing loans coverage ratio of 466% including total provisions and collateral.

Total credit provisions ended 2023 at KD 312million whereas IFRS 9 accounting requirements (i.e., ECL or expected credit losses) were KD 187 million. So, the Bank has very healthy excess provisioning level of KD 125 million, above and beyond what is required by the IFRS9 accounting requirements.

Compared to 31 December 2022, total assets increased by 4.7% to KD 7.2 billion, loans and advances climbed by 1.3% to KD 5.2 billion, and shareholders' equity increased by 13.4% to reach KD 817 million. In addition, total deposits increased by 6.9% to reach KD 5.4 billion for the year ended 2023.

Looking at the Bank's regulatory capital ratios as of 31 December 2023, Tier 1 ratio was 15.8%, that is 3.8% above the regulatory minimum of 12% and the Capital Adequacy Ratio (CAR) was 18.0%, that is 4.0% above the regulatory minimum of 14%.

Commenting on the results, Mr. Jassim Mustafa Boodai, Gulf Bank's Chairman said: "Our 2023 performance demonstrates excellent results with Gulf Bank delivering strong and consistent net profit growth momentum. 

## Kramer's legacy of music and activism

LOS ANGELES, Feb 12, (AP): The tributes that poured in following Wayne Kramer's death last week came from musicians praising the MC5 guitarist's contributions to rock music, as well as from prison reform advocates who extolled his legacy of bringing music to incarcerated people.

Kramer, who died Feb. 2 at age 75 of pancreatic cancer, influenced generations of artists with his screaming guitar chords on hardcore anthems like 1969's "Kick Out the Jams."

Rage Against the Machine guitarist Tom Morello said MC5, with an uncompromising sound that fused music to political action, "basically invented punk rock.



Not long after the band broke up in 1972, Kramer was arrested on drug charges and spent two years in prison. Determined to straighten out his life while maintaining his activism, Kramer co-founded Jail Guitar Doors USA, based on a British charity that provided inmates with musical instruments. Kramer's nonprofit is named after a Clash

song that refers to his struggles: "Let me tell you 'bout Wayne and his deals of cocaine.

Kramer recruited famous friends like Morello, Slash and Perry Farrell to perform concerts at prisons in California and his home state of Michigan, where he would leave behind guitars.

Gradually he began spending one-on-one time with inmates, helping them craft their own songs and "watching the creative lights go on in their heads," said Jason Heath, a close friend and executive director of Jail Guitar Doors USA.

"Working with inmates was cathartic for him because music had saved his life when he was inside," Heath said this week.


"Creativity is the solution for the challenges we face," Kramer told Mojo magazine in December.

### Mentorship

His group ultimately distributed thousands of instruments and created a songwriting mentorship program that expanded to lockups nationwide. Its work was cited in research by University of San Francisco professor Larry Brewster that found introducing arts to incarcerated people led to fewer disciplinary actions, increased self-esteem, improved emotional health and reduced rates of recidivism.

"He invited people to tell their story via music, that was Wayne's gift," said Elida Ledesma, director of the California-based nonprofit Arts for Healing and Justice Network. "He knew that everyone was worthy of respect and dignity.

In recent years, Jail Guitar Doors USA spun off a partner nonprofit, the Community Arts Programing and Outreach Center. Its headquarters in Hollywood include a recording studio and teaches multimedia production to young people recently released from custody and trying to start their lives over. A federally approved apprentice program for formerly in carcerated people offers a 2 1/2 year curriculum for audio recording and a shorter one for film editing. One of the young apprentices, 24-year-old Joseph Jimenez, said it never occurred to him that he could be a filmmaker after spending more than five years in juvenile halls and other correctional facilities. One day, he tagged along to the center with one of the residents of his halfway house.

## Show highlights iconic hits and star-studded lineup Usher shines on halftime throne

LOS ANGELES, Feb 12, (AP): Usher emerged at Las Vegas' Allegiant Stadium for the Super Bowl halftime show seated on a throne, joined by a marching band and a trove of Vegas performers - but stayed its center.

It was an immediate confirmation of his position as the ideal halftime performer: one with timeless, well-known hits, masterful choreography, and a devoted audience.

He started with "Caught Up," moving into "U Don't Have to Call," "Superstar," and "Love in the Club."

Then Alicia Keys joined in front of bright red piano for her song "If I Ain't Got You," which morphed into "My Boo," Usher losing a glove in an apparent tribute to Michael Jackson - notable for a performance during Black History Month.

Press in a recent interview. In his first Super Bowl performance, he descended from the stadium ceiling to perform "OMG" in Arlington, Texas.

"Don't take the moments for granted because you only get 13 of them," he said in advance of his 2024 performance, referring to the usually allotted 13-minute run time. "The hardest part is trying to figure out how to squeeze it all in when you actually have a large catalog, or a lot of records people celebrate and love.'

With a doubt - he figured out exactly how to do just that.

The Kansas City Chiefs were crowned victorious over the San Francisco 49ers in this year's Super Bowl and, off the field, big-name advertisers

On Sunday, scores of advertisers tapped into light humor and nostalgia to give game breaks a mostly "feel good," whimsical energy. Still, there were also a few serious and somber moments.

Kris Jenner "twists on it" with Oreo. The face behind Pringles' iconic mustache is unveiled to be none other than Chris Pratt. And Ben Affleck and Jennifer Lopez returned for Dunkin' cameos, while Ice Spice sips on Starry.

In typical Super Bowl fashion, an array of companies' adverts were adorned by stars - often with numerous celebrities stuffed in a single spot. T-Mobile, for example, showcased big names like Bradley Cooper, Common, Jennifer Hudson, Laura Dern and "Suits" stars Gabriel Macht and Patrick J. Adams all in one ad for its "Magenta Status" customer appreciation program. And the "Suits" homecoming didn't stop there. In another ad stuffed with celebrity cameos - including "Judge Judy" Judy Sheindlin - e.l.f. cosmetics brought together Gina Torres, Rick Hoffman and Sarah Rafferty in a courtroom spoof. NBC sitcoms had quite a few reunion moments during the game. In an Uber Eats ad, which shows people forgetting things so they remember Uber Eats can deliver a wide variety of items, Jennifer Aniston seemingly forgets she ever worked with her 'Friends" co-star David Schwimmer. And in an ad for Mtn Dew Baja Blast, Aubrey Plaza says she can have a 'Blast' doing anything - including reuniting with her "Parks and Rec" boss Nick Offerman as they fly on dragons. Although star power in Super Bowl commercials isn't new, it did feel especially heightened this year. "It used to be that you'd have a celebrity pop up that would sort of be the spokesperson of the commercial," said Virginia Commonwealth University Brandcenter's Jessica D. Collins. "Now you're seeing collaborations of celebrities... all in the same commercial, even (when) they have absolutely nothing to do with each other."

"They handed me a camera, and I just started learning," Jimenez said.

He recently shot and produced a music video for a rap song written, performed and recorded by him and fellow students. He said the program has instilled in him an ambition he didn't know he possessed.

"Now I want to have my own production company," Jimenez said. "I want to do independent film."

Jack Bowers, who ran the arts project at California's Soledad prison for 25 years, credits Kramer with helping restore funding for cultural programs in state lockups. Amid a budget crisis in 2003, the state slashed all money for arts within the California corrections system. Nine years later, a group of nonprofits including Jail Guitar Doors started lobbying for restoration. Kramer eventually delivered testimony before a joint committee on the arts, along with actor Tim Robbins and others.

"Wayne just gave this moving speech about how important it was to have music and arts in prisons,' said Bowers, who's now a mentor at the William James Association Prison Arts Project. "Because he had been incarcerated, he understood it from the point of view of somebody who was inside. His voice carried a tremendous amount of weight.'

It was out of that meeting that the program was restored, Bowers said. The state provided \$1 million in 2014, and the prison arts budget has since been increased to \$8 million, he said.

Heath said the next steps for the Community Arts Programing and Outreach Center is to provide onsite housing for the paid apprentices, where they can focus on the work to avoid the temptations of repeating behaviors that got them in trouble.

"We can sign the youths up while they're still incarcerated. Then when they're released they go straight to the house, where they have a place to live, and straight to the center, where they've got a job,' he said. "That puts them on the right path.

Jimenez, the young apprentice, admits that as a hip-hop fan he didn't realize that Kramer, the unassuming guy mentoring people and running the program at the center, was a rock star.

"I Googled him, and it kind of blew my mind," Jimenez said. "He was so cool and so down to earth with the work that he did with us. He's a legend."

LEXINGTON, Ky.: Wilhelmenia Wiggins Fernandez Smith, a renowned soprano known for her performance in the 1981 French cult-classic film "Diva" and who sang through the US and Europe during her operatic career, has died at age 75.

Funeral services were held Friday for Fernandez Smith at a church in Lexington, Kentucky, where she had moved after residing for years in her native Philadelphia. She died of cancer Feb. 2 at her home in Lexington, daughter Sheena Maria Fernandez told The Philadelphia Inquirer. Billed as Wilhelmenia Wiggins Fer-

nandez, she opened the movie directed by Jean-Jacques Beineix wearing a white gown and singing in an aging theater the aria "Ebben? Ne andrò lontana" from the opera "La Wally." It became the signature aria of her 25-year career that took her to the great opera houses in Europe and made her the centerpiece of gala occasions.

She graduated from the Academy of Vocal Arts in Philadelphia and continued her education at the Juilliard School in New York. Filmmakers for "Diva" approached her while she sang "La boheme" in Paris, leading to a film shoot for the thriller that would change her life, the Inquirer reported.

"The film gave me an exposure that I could not have imagined, and I had to catch up with my own fame when the floodgates opened to do countless operas," she recalled. "My repertory simply wasn't that great, and there was so much expectation to do everything well." (AP)

NEW YORK: Dr. Anthony Fauci has a memoir coming out in June, a look back at his long career as an infectious disease expert and the many outbreaks he contended with, from HIV/AIDS to the COVID-19 pandemic that made him famous.



## A mother's gift and a daughter's miracle: Power of organ donation

RIYADH, Feb 12, (KUNA): Najlaa Al-Sudairi, a consultant in international media relations, never thought that she would one day embark on two different journeys: donate an organ to one of her closest relatives, or she would have to wait for a donor to save her beloved daughter.

These two experiences turned her life upside down.

More than two decades ago, Najlaa, who was leading a normal life like any other girl, found herself compelled to make a life-saving decision at a young age. She de-cided to donate her kidney to her sister, Seetah, who was suffering from kidney failure. Despite her fear of hospitals and doctors, and her limited understanding of organ transplantation, Seetah's struggle with dialysis and the hardships she endured day after day made Najlaa opt for the only choice that would put an end to her sister's tragedy: donate a kidney.

"When I underwent examinations at the hospital, all my previous fears vanished completely, and I began to live with hope, envisioning my sister Seetah leading a normal life. And that is exactly what happened," Najlaa said.

"The operation was successful, thank God, and I felt an indescribable sense of fulfillment for relieving my sister's suffering. Witnessing her full recovery filled me with immea-

surable joy," she added. After all these long years

was frequenting hospitals, clinging to life. As his condition worsened, a liver transplant became necessary to save him.

"I am a man who is satisfied with Allah's fate and decree, and my concern was not so much for myself but for my family, who needed me. I constantly prayed to Allah to take care of them after I go," Abdullah said, recalling the bleak times.

"After going through utter darkness, a glimmer of light shone upon my life and the lives of my family. Allah blessed me with recovery after I received the liver of a brain-dead patient through the Saudi Center for Organ Transplantation," he said with visible relief.

### Initiative

The Saudi Center for Organ Transplantation (SCOT), a beacon of hope for patients in need of organ transplant.

The history of organ transplantation in Saudi Arabia dates back to 1979, when the first kidney transplant was performed at Prince Sultan Military Medical City. It is, however, the establishment of the National Kidney Center, through an initiative by King Salman bin Abdulaziz Al-Saud when he was governor of the Riyadh Region, that marks the actual beginning of the organ donation and transplantation program in the Kingdom.

A Royal Decree was issued establishing the National Kidney Center. Another decree changed its name to organ donation and transplantation in the Kingdom. It sets policies and procedures for donation, standards and conditions for licensing transplant operations, monitors and evaluates facilities, registers and follows up on cases of patients with organ failure before and after transplantation, is informed about cases of brain death, and supervises waiting lists and determines the priority of those who are eligible.

SCOT regulates the practice of

Over the past 40 years, organ donation and transplantation has grown significantly throughout the Kingdom, with transplant centers spread across the country and performing various types of organ transplants, such as kidney, heart, liver, lung, pancreas, intestine, and tissues such as bones and corneas

The Kingdom ranks second globally in organ donation among living people, according to the Global Observatory on Donation and Transplantation statistics for 2022.

The center launched the Athar electronic platform to digitize donation procedures and the organ supply chain, employ Artificial Intelligence (AI) to match tissues between donor and potential recipient, get easy access to therapeutic procedures, and equal opportunities in obtaining services, and calculate performance indicators on the donation and organ

The platform also enables elecronic connectivity and integration with health information systems, and follows up on the status of donation from the time a case is reported until the completion of the donation procedures, in a digital form, providing a value-added service to donors. The first phase of the platform was launched on January 7, 2024. Regarding the sequence of case follow-up at SCOT, clinical organ transplantation coordinator Dr. Khaled Al-Ruqi said that it starts with the reception of a report from a hospital that has a potential brain death case. Once the report is received, the follow-up process commences with the involvement of attending and monitoring doctors who oversee the diagnosis of brain death and ensure its accuracy.

MIAMI, Feb 12, (AP): Jayson Tatum had 26 points, 10 rebounds and nine assists and the Boston Celtics withstood a late rally to beat the Miami Heat 110-106 on Sunday. Kristaps Porzingis had 25 points, Jaylen Brown had 20 points and Jrue

Holiday scored 15 for Boston, which hit 16 of 39 3-point attempts.

"I felt my shoulder pop out on the floor and then it popped back in laying on the ground, so thank goodness for that," Richardson said. "I'll know more tomorrow.

Robinson also favored his left shoulder after Brown pushed him off into the stands when both tangled for position early in the fourth quarter. Brown

and Robinson exchanged words and Brown was assessed a flagrant 1 foul.

Miami rallied from a 15-point deficit in the third quarter and cut it to 106-104 on Herro's 3-pointer with 1:49 remaining. But Porzingis and Tatum each converted two free throws to secure the win.

## Pan swims fastest 100m in 'history' as China win gold

Italy finish a second behind

DOHA, Qatar, Feb 12, (AP): Despite the absence of many of the sport's biggest names, the first day of the swimming events saw a world record at the World Aquatics Championships on Sunday.

Teenager Pan Zhanle swam the fastest 100 meters in history as he led off China's gold medal-winning 4x100 freestyle relay team.

His time of 46.80 seconds - with a split time of 22.26 - took six hundredths off Romanian David Popovici's world record from 2022 and established the 19-year-old as one to beat in swimming's marquee race at this year's Paris Olympics.

"Actually, I wasn't feeling in great form," Pan said. "I would've been happy with just getting on the podium. This morning (in heats), the U.S., Great Britain and Italy were all quicker than us, and I just wanted to focus on doing my job well.



SCOTTSDALE, Ariz., Feb 12, (AP): Nick Taylor made an 11-foot birdie putt to beat Charley Hoffman on the second hole of a playoff after birdieing three of the last four in regulation Sunday, capping another wild week at the Phoenix Open with his second memorable victory

Taylor closed with a 6-under 65 to reach 21-under 263, with the 35-year-old Canadian forcing the playoff with a 9-foot birdie putt on the par-4 18th. Last year, he took the Canadian Open with a 72-foot eagle putt on the fourth playoff hole to become the first Canadian in 69 years to win his national open.

Both players birdied the extra hole and hit the green on No. 18 a second time - Taylor from the right rough, Hoffman from the left fairway bunker. Hoffman left his birdie putt short and Taylor birdied the hole for the third time in less than an hour as the sun dipped below the horizon.

Taylor won his fifth PGA Tour title to end a chaotic week of weather delays and the rare decision to close the gates - and, gulp, cut off liquor sales - when things started to get out of hand Saturday.

Taking advantage of the first pleasant day of the week in the desert, Hoffman moved into contention by finishing off a 64 on TPC Scottsdale's Stadium in the morning to complete his weather-delayed third round. He was 4 under in a three-hole stretch on the back nine and had a three-shot lead when he finished.

Taylor shot a course-record 60 in the opening round. He finished off a third-round 68 in Sunday morning.

Two-time defending champion Scottie Scheffler shot a 66 to tie Sam Burns for third at 18 under.

Rikuya Hoshino of Japan captured his first European tour title by closing with a 4-under 68 to win the Qatar Masters by one shot.

The 27-year-old Hoshino rolled in a par putt from 5 feet at the 18th hole and punched the air after holding off playing partner Ugo Coussard, who made birdie at the last for a 69 to finish alone in second place.

Hoshino previously won six times on the Japan Golf Tour. This was his 34th appearance on the European tour tour and he already two runner-up finishes this season, at the Australian Open and the Australian PGA Championship.

He is the fourth Japanese winner in European tour history, after Isao Aoki, Hideki Matsuyama and Ryo Hisatsune

## Marathon world record-holder Kiptum, who was set to be a superstar, has died

NAIROBI, Kenya, Feb 12, (AP): Marathon world record-holder Kelvin Kiptum, who was set to be a superstar of long-distance running and was a top contender for gold at the Olympics in Paris this year, was killed along with his coach in a car crash in Kenya.

Their vehicle was the only one involved in the crash late Sunday and Kiptum was driving when it veered off a road and into a ditch before hitting a tree, police said.

Kenya's Kiptum was 24 and one of the most exciting prospects to emerge in road running in years, having broken the world record in only his third appearance in an elite marathon. His record, set at last year's Chicago Marathon, was ratified by international track federation World Athletics just last week.

His death reverberated through Kenya, where runners are the biggest sports stars. Kenyans have also gotten used to tragic tales involving their top athletes after a number have died in road crashes, other accidents and domestic violence cases. "He was only 24," Kenyan President William Ruto said in a statement offering his condolences. "Kiptum was our future."

Kiptum and his Rwandan coach, Gervais Hakizimana, were killed in the crash at around 11 p.m., police said. It happened near the town of Kaptagat in western Kenya, in the heart of the high-

altitude region that's renowned as a training base for the best distance runners from Kenya and across the world. Kiptum was born and raised in the

area. A third person, a 24-year-old woman, was also in the car and was taken to a hospital with serious injuries, police said. Kiptum and Hakizimana died at the scene.

Athletes and family members, including Kiptum's father, gathered at the hospital mortuary where the bodies of Kiptum and his coach were taken. One of the athletes, former women's steeplechase world champion Milcah Chemos, struggled to speak while breaking down in tears.

"I have no words to explain the loss of Kelvin," she said.

## Record Saudis take part in Riyadh Marathon

RIYADH, Saudi Arabia, Feb 12, (AP): More than 20,000 participants from 125 countries, including a record 60% Saudi nationals, took part in the third edition of the Riyadh Marathon on February 10 - an increase of more than 33%, with 15,000 runners in 2023.

Prizes for elite runners in the half marathon started at US\$5,000 for first place.

Khaled Melhem, explained the team's initial performance challenges in the league. Argentina finished the tournament with five points, two more than Brazil, which only managed to beat Venezuela in the final stage.

Argentina had the upper hand in the first half but the defensive stance of Brazil, coached by Ramon Menezes, didn't help bring much emotion to the match. World Cup winner Thiago Almada hit the post in the 16th minute.

Argentina's Leandro Brey made the best save of the game in the 61st, when substitute Gabriel Pec struck hard from close range. Brazil did not keep up the pressure, with striker Endrick once more playing below par. And then Gondou's header made the difference between the two teams.

"We deserved this. We didn't lose a single match at the qualifying," said Gondou, who scored four goals in the tournament in Venezuela. "We suffered, we waited for this goal, but at the end we got it.'

Brazil last failed to make the men's soccer Olympic tournament in 2004.

"It is a very bad feeling, we prepared well for this," Brazil midfielder Andrey Santos said. "We struggled to keep the ball throughout the tournament. It didn't go as we expected."

Argentina won the gold at men's soccer at the games in Athens 2004 and Beijing 2008, with Lionel Messi leading the team in Beijing. Paraguay's surprising spot in Paris

came after Diego Gómez scored from the spot early in the second half and Marcelo Pérez pushed the ball with his head to an empty goal in the 75th minute after a bizarre mistake of the Venezuelan defense.

Paraguay's men's soccer team has given the small South American nation one of its few medals in Olympic history; a silver in 2004 after losing the final against Argentina.

ABIDJAN, Ivory Coast, Feb 12, (AP): Let the party begin.

Sébastien Haller scored late to lead host nation Ivory Coast to a remarkable Africa Cup of Nations title with a 2-1 victory over Nigeria in the final.

Haller fired in from close range in the 81st minute to complete the turnaround after Franck Kessié drew the Elephants level in the 62nd.

It was Ivory Coast's third title after wins in 1992 and 2015, both won on penalties.

Veteran Ivory Coast midfielder Max Gradel, now 36, was part of the 2015 championship team.

"Representing the national team is everything, and to have brought joy to all Ivorians with what I've done is

## **AI-Qadisiya Vice President receives a** stadium ban until the end of season



KUWAIT CITY, Feb 12: The Football Association's Disciplinary Committee has taken strict actions against individuals associated with Al-Qadisiya Club following the controversial events during the semi-finals of the Amir Cup. Vice President Sheikh Fahd Talal Al-Fahd faces a stadium ban until the end of the season along with a 10,000 dinars fine. Additionally, Al-Qadisiya Club itself incurs a 10,000 dinars fine.

Further sanctions include Saud Abu Al-Hassan, Head of the Marketing Committee, receiving a stadium ban until season-end and a 2,000 dinars fine. Muhammad Al-Awadi, a member of the Al-Qadisiya General Assembly, is prohibited from entering stadiums for a year. Faisal Abu Al-Hassan, the club's aquatics director, faces a stadium ban until the season concludes along with a 2,000 dinars fine.

That match had been just the start of the Elephants' troubles as Ivory Coast was almost eliminated in its next game. It fired its coach but recorded late comeback wins over defending champion Senegal and Mali in Al-Qadisi sident Sheikh Fahd Talal Al-Fahd

the knockout stage, before Haller fired the team into the final with the winning goal against Congo in the semifinals.

Ivory Coast's unlikely progression through the knockout stage as it overcame setback after setback convinced many devout Ivorians that God was on the team's side.

"It was an extraordinary tournament," said interim coach Emerse Faé, the previous assistant who took over on his 40th birthday.

Nigeria conceded as many goals in the final as it had in all its previous games in the tournament. Coach José Peseiro had banked on a mean defense to earn what would have been the Super Eagles' fourth title.

"We played a fantastic tournament, but today Côte d'Ivoire was better," Peseiro said. The Portuguese coach said the pressure got to his players and commended the home team for showing none.

In the final, Ivory Coast's pressure finally paid off when Kessié's header to Adingra's corner set off a tumult of joy in the 60,000-capacity Alassane Ouattara Stadium. Kessié ran to the corner and raised his hand to his forehead in salute as the sea of orange-clad fans rippled in delight.

The Disciplinary Committee justi-

fied these penalties by citing the events surrounding the Al-Qadisiya versus Al-Arabi match during the Amir Cup semi-finals, emphasizing that they were deemed insults to the sports system in Kuwait. The committee referenced Articles 61, 70, and 79 of the Disciplinary Regulations as the basis for these actions. In a separate incident, Al-Qadisiya manager Abdullah Al-Haqqan is forbidden from accompanying the team for two matches, coupled with a 500 dinars fine, due to his remarks directed at the refereeing team during the Amir Cup quarter-finals against Al-Fahaheel.

Additional fines were imposed on Kuwait Club coach Nabil Maaloul, who received a 500 dinars penalty for verbal abuse against the referee.Firas Al-Khatib, was also given a 1,000 dinars fine and a two-match suspension for similar actions. Hussein Al-Asfour, the director of professionalism in Al-Fahaheel, also received disciplinary measures.

Barcelona was jeered at home following a 3-3 draw against second-tolast Granada, a setback that saw the Catalan club move 10 points behind leader Real Madrid, which defeated second-place Girona 4-0.

Barcelona trails Girona by five points and is three ahead of fourthplace Atletico Madrid, which lost 1-0 at Sevilla earlier Sunday.

The draw is likely to add more pressure on Barcelona coach Xavi Hernández, who recently said he will not return after the end of the season.

"It was already tough for us in the league, and now it's two points tougher." Xavi said. "It's a big gap but we are not going to throw in the towel. We have to stop making mistakes."

Barcelona was heavily favored to

win against a Granada team that has only one win in its last 13 matches in all competitions. Teenager Lamine Yamal was the man of the match for Barcelona, scoring twice.

"We tried until the end but couldn't
