No foreign currency shortage in Kuwait

Central Bank affirms country's economic vigor

KUWAIT CITY, Dec 3: The Central Bank of Kuwait has affirmed that the country is not facing a shortage of foreign currency levels, attributing this to the majority of state revenues being derived from oil, which is paid in US dollars, reports Al-Rai daily.

The bank emphasized that the liquidity is supported by reserves in the form of foreign assets. When the Ministry of Finance purchases dinars from the Central Bank for the state budget, the equivalent is deposited in dollars, bolstering foreign reserves crucial

for exchange rate policy stability.

The Ministry of Finance's role in this mechanism is pivotal. When acquiring dinars from the Central Bank to meet the requirements of the state's general budget, the Ministry ensures an equivalent deposit in dollars. This practice not only facilitates the seamless execution of the budget but also actively contributes to the continuous augmentation of foreign reserves. These reserves, in turn, play a crucial role in implementing the exchange rate policy, a strategy designed to maintain the relative stability of the dinar exchange rate and ensure overall monetary stability.

Kuwait advances on climate action

DUBAI, Dec 3, (KUNA): Kuwait is now in the final stages of presenting its 2050 low-carbon strategy and plans to ensure it reaches carbon neutrality by 2060, said Undersecretary of the Kuwaiti Ministry of Oil, Sheikh Dr. Nimer Al-Fahad Al-Sabah.

In a statement to KUNA, Sheikh Nimer Al-Sabah congratulated the UAE for hosting the 28th Conference of the Parties (COP28), considering it an opportunity to shed light on how the GCC and Arab countries are suffering from the negative effects of climate change.

Sheikh Nimer Al-Sabah stressed that Kuwait attaches the utmost importance to managing the climate change file at the national level through the formation of a supreme national climate committee headed by the Deputy Prime Minister, the Minister of Oil, and the Minister of State for Economic and Investment Affairs. It aims to develop programs and plans to reduce, emissions and enhance flexibility in facing the effects of climate change.

He stated that Kuwait is working to develop low-carbon development strategies in the sectors of oil, gas, energy, transportation, industry, land use, and the promotion of agriculture. These strategies include a roadmap to achieve sustainable economic growth through the principles of the circular carbon economy.

Amiri reassurance statements ... and 'social media' abuses

IN his book "La Psychologie Sociale" (Social Psychology), the French sociologist and psychologist Jean Maisonneuve wrote, "A rumor is a form of social pressure of unknown origin that is generally shrouded in mystery and vagueness, and usually attracts the attention of broad sectors of society.'

Rumor used to be one of the weapons used to destabilize coun-Some rutries. were even mors used to ignite wars, and there is much evidence of this, although time does not allow us to state them at the moment.

On the other hand, transparency is the weapon used to refute all the rumors and fight against the rumormongers and their goals. However, it needs a way to create the appropriate atmosphere for it to be ef-

Therefore, in countries where administrations understand the meaning of stability, their officials work to avoid any delay in refuting rumors so that the public is not misled, especially in a time when the influence of social media has become great, and sometimes even shapes public opinion.

It is true that freedom in Kuwait is great, but the delay in announcing an event opens the way for the spread of rumors, which undoubtedly create confusion among the public, and provide an opportunity for external parties with their own interests to create more confusion on the internal situation. Therefore, promoting transparency is the only way to maintain stability.

The Amiri Diwan did well by issuing daily statements about the health condition of His Highness the Amir, after reports that he is not feeling well had emerged.

Nonetheless, while all of Kuwait is praying that Almighty Allah will grant His Highness good health and wellness, the delay in issuing the first statement and limiting it to a brief daily statement gave way to rumors flooding the social media.

In fact, it did not just stop at the health status of His Highness, but rather reached the arrangements in the hierarchy of power, and the distribution of positions to some individuals, in addition to linking what is happening in the region and the political atmosphere based on rumors in the country.

In Kuwait, we went through such events in the past. Prior to social media, news was limited to the press, print, audio and visual back then, and so things were fine despite the many observations in this regard at that time.

However, today the situation has changed to such a degree that it is not possible to be satisfied with daily brief press

Hopes for another truce dim

Gaza's south braces for escalation

KHAN YOUNIS, Gaza Strip, Dec 3, (AP): Israel's military on Sunday ordered more areas in and around Gaza's second-largest city of Khan Younis to evacuate, as it shifted its offensive to the southern half of the territory where it says many Hamas leaders are hiding.

Heavy bombardments were reported overnight and into Sunday in the area of Khan Younis and the southern city of Rafah, as well as parts of the north that had been the focus of Israel's blistering air and ground campaign.

The U.N. human rights chief urged for an end to the war, saying the suffering of civilians was "too much to bear."

Many of the territory's 2.3 million people are crammed in the south after Israeli forces ordered civilians to leave the north in the early days of the 2-month-old war, sparked by an Oct. 7 attack by Hamas and other militants that killed about 1,200 people, mostly civilians, in southern Israel. Around 240 more were taken hostage

With the resumption of fighting, hopes for another temporary truce receded. A weeklong cease-fire, which expired Friday, had facilitated the release of dozens of Gaza-held Israeli and foreign hostages and Palestinians imprisoned by Israel.

'We will continue the war until we achieve all its goals, and it's impossible to achieve those goals without the ground operation," Prime Minister Benjamin Netanyahu said Saturday.

On Sunday, the Israeli military widened evacuation orders in and around Khan Younis, telling residents of at least five more areas and neighborhoods to leave.

Iran-linked cyber attacks affect multiple US states

HARRISBURG, Pa., Dec 3, (AP): A small western Pennsylvania water authority was just one of multiple organizations breached in the United States by Iran-affiliated hackers who targeted a specific industrial control device because it is Israeli-made, U.S. and Israeli authorities say.

"The victims span multiple U.S. states," the FBI, the Environmental Protection Agency, the Cybersecurity and Infrastructure Security Agency, known as CISA, as well as Israel's National Cyber Directorate said in an advisory emailed to The Associated Press late

They did not say how many organizations were hacked or otherwise describe them.

Matthew Mottes, the chairman of the Municipal Water Authority of Aliquippa, which discovered it had been hacked on Nov. 25, said Thursday that federal officials had told him the same group also breached four other utilities and an aquarium.

Cybersecurity experts say that while there is no evidence of Iranian involvement in the Oct. 7 attack into Israel by Hamas that triggered the war in Gaza they expected statebacked Iranian hackers and pro-Palestinian hacktivists to step up cyberattacks on Israeli and its allies in its aftermath. And indeed that has happened.

of the Public Authority for Cooperatives, which

will be affiliated to the State Ministry for Cabinet The bill stipulates the following description and tasks of the authority: ■ An independent legal institution that will lav

down general strategies for cooperative work in order to develop this field; ■ Improve the performance of the cooperative

■ Protect the shareholders' money; Follow up and monitor the execution of inte-

grated cooperative policies; ■ Conduct studies on developing cooperative

Review the international and regional treaties

concerning cooperative work; ■ Present recommendations to join or withdraw

from these treaties: ■ Raise the citizens' awareness about the impor-

tance of cooperative work; ■ Lay down comprehensive strategies to protect the market from any crises threatening food security in collaboration with the Consumer Coopera-

tive Societies Union (CCSU); ■ Improve social services in coordination with the cooperative societies;

■ Lay down an integrated strategy for training nationals to engage in cooperative work;

■ Discuss and make decisions regarding applications for the establishment of cooperative societies; ■ Replace Ministry of Social Affairs and Ministry of Commerce and Industry in terms of over-

sight and following up cooperative societies; ■ Lay down the general rules and regulations for organizing cooperative work while giving every cooperative society the right to issue certain regulations through their general assembly provided they

are in line with the general rules and regulations;

Appoint an employee who will monitor the performance of each cooperative society and represent the authority in the general assembly of each cooperative;

■ Specify the dates for the elections of the board of directors of cooperative societies and announce the results of such elections:

■ Request for plots for the establishment of cooperative societies and farms to increase food production: ■ The authority's Board of Directors shall inves-

Bomb blast in Philippines south claims four Catholic worshippers

Marcos blames foreign militants

MANILA, Dec 3, (AP): The Philippine president blamed "foreign terrorists" for a bomb blast that killed four people Sunday, wounded dozens of other Catholic worshippers in the south and sparked a security alarm, including in the capital, Manila, where

state forces were put on alert. The suspected bomb, which the police said was made from a mortar round, went off and hit students and teachers who attended a Mass in a gymnasium at Mindanao State University in southern Marawi city, Taha Mandangan, the security chief of the state-run campus, told The Associated Press by telephone.

Dozens of students and teachers dashed out of the gym and the wounded were taken to hospitals.

Regional military commander Maj. Gen. Gabriel Viray III said four people were killed by the explosion, including three women, and 50 others were brought to two hospitals for treatment.

Six of the wounded were fighting for their lives in a hospital, said Gov. Mamintal Adiong Jr. of the Islamic province of Lanao del Sur, which has Marawi as its capital.

Paris knife attack kills 1, wounds 2

PARIS, Dec 3, (AP): French police arrested a man who targeted passersby in Paris on Saturday night, killing a German tourist with a knife and injuring two others, France's interior minister said.

Police subdued the man, a 25-year-old French citizen who had spent four years in prison for planning a violent offense. After his arrest, he expressed anguish about Muslims dying, notably in Afghanistan and the Palestinian territories, and claimed that France was an accomplice, French Interior Minister Gerald Darmanin said. The attacker apparently cried "Allahu Akbar" (God is great), Darmanin

"This person was ready to kill others," Darmanin told reporters.

Workshop to shed light on latest in nuclear medicine: Dr Al-Shammari

'Providing best care for heart patients among MoH priorities'

KUWAIT CITY, Dec 3: Chairman of the Council of Nuclear Medicine Departments and Head of the Nuclear Medicine Department at the Kuwait Cancer Control Center Dr. Abdul-Redha Abbas affirmed the keenness of the Ministry of Health, especially the Kuwait Cancer Control Center, to continuously develop the performance of the health system and update health care policies and protocols in various fields, in accordance with the latest global developments, especially when it comes

to cardiovascular dis-

During the opening of the workshop titled "The latest developments in nuclear medicine in imaging heart diseases' which was organized by the center under the patronage of the Minister of Health Dr. Ahmad Al-Awa-

dhi, Dr. Abbas explained that the workshop focuses on the latest developments in heart imaging techniques using radioactive materials. It will discuss modern applications in diagnosing heart diseases and focus on the mechanism of their development, which would lead to a greater understanding of how to provide better healthcare.

He expressed appreciation for the interest and dedication of the ministry's leaders and employees and their endeavor to improve the scientific knowledge of doctors and workers through endless care and support for establishing such scientific activities.

Dr. Abbas said the workshop is an example of the contribution to the cognitive advancement of services provided to patients.

He highlighted that the workshop will exchange ideas, enrich discussions with specialists in clinical heart diseases and their diagnosis using radioisotopes, gain knowledge that will contribute to professional growth, improve health care, and form a different and advanced vision for diagnosing and imaging heart diseases and their modern applications.

Dr. Abbas stressed that the ministry continues to strive to develop medical teams and train them on the latest protocols used globally by holding specialized scientific workshops and medical conferences.

He expressed appreciation for the cooperation of doctors in other specialties, specifically cardiologists, which has contributed to choosing the best and most appropriate treatment plans.

Meanwhile, the Nuclear Medicine Consultant and Head of the Nuclear Medicine Department at the Amiri Hospital Dr. Al-Shaima Al-Shammari explained in her speech that the workshop will shed light on the latest developments in nuclear medicine for imaging heart diseases with the aim of

raising the efficiency of workers to provide high-quality health services. It provides the possibility of detecting the disease in its early stages and determining the extent of response to medical intervention.

Treating patients suffering from cardiovascular diseases is among the priorities of the Ministry of Health, which has paid great attention to combating the disease. It has developed multiple programs and strategies aimed at ensuring the development of the health services system in terms of early detection, treatment, and support for scientific research.

Furthermore, a Nuclear Medicine specialist at the Amiri Hospital Dr. Abrar Ashkanani stressed the ministry's keenness to provide the latest research and studies, and keep pace with their application on the

ground in the hospitals in Kuwait.

She explained that the medical and technical staff represent the backbone of the medical sector due to which it was necessary to present a number of research and studies that ultimately aim at educating doctors and nuclear medicine technicians about the latest diagnostic devices and protocols through a workshop that aims primarily to help reduce catheterization operations in light of the presence of a large number of heart patients.

The ministry, represented by the Kuwait Cancer Control Center, is keen to use the latest diagnostic imaging methods for cardiovascular diseases to evaluate the condition of the heart and arteries and the severity of their dysfunction, hence the importance of the workshop.

Heart diseases are among the priorities of the ministry, which has paid great attention to combating them and has developed multiple programs for them in terms of early detection, treatment, and support for scientific research.

In addition, a consultant cardiologist from the Kingdom of Saudi Arabia Dr. Ahmed Al-Jaziri said heart disease is still the main cause of death globally and in the Middle East and Gulf region.

He explained that the rapid development witnessed by the Gulf countries has led to an increase in the rates of causes of heart disease such as diabetes, high blood pressure, and cholesterol. This increase has led to an increase in heart disease and subsequently an increase in deaths resulting from it. This circle must be broken with knowledge of the causes and advanced accurate diagnosis before the disease reaches a point of inability to treat. This is what the workshop serves.

Dr. Al-Jaziri also highlighted the importance of the workshop in dealing with the latest developments in diagnosis without resorting to interventional cardiac catheterization in an attempt to know and control the disease before it leads to complications either illness or death.

He said heart and arterial diseases are diseases that recur annually, adding that trying to obtain the latest developments requires hosting and exchanging experiences.

KUWAIT CITY, Dec 3: As part of a series of measures aimed at making it easier for citizens and residents, the General Traffic Department (GTD) says vehicle ownership transfer in addition to renewing the vehicle registration will soon be available on the government application

Informed sources told Al-Seyassah daily that the General Traffic Department pays great attention to the importance of converting all its services electronically, noting that it is working on the possibility of adding the services of transferring vehicle ownership and renewing its insurance on the "Sahel" application in coordination with the concerned authorities, for the benefit of citizens and residents.

Meanwhile, citizens must book an appointment on the Sahel platform if they want to meet any of the Civil Service Commission (CSC) officials while everyone is allowed to enter the reception hall where the staff and officials are keen on providing the best services to the public, reports Al-Anba daily quoting a reliable

The source emphasized that the one completing a transaction or making an inquiry must be the concerned person or someone authorized to act on his behalf. He explained this is aimed at protecting information and maintaining the privacy of individuals. He added the implementation of flexible working hours for the CSC employees started on Sunday.

On the other hand, sources affirmed that the CSC started the nomination of people with disabilities for employment in their chosen government agency immediately after the development of the systems at the Public Authority for Disabled Affairs (PADA) and re-establishment of the automated link with the CSC for verifying the data of job applicants.

No 'igama' teachers

KUWAIT CITY, Dec 3: Acting Assistant Undersecretary for the Administrative Sector at the Ministry of Education Faisal Al-Jutaili has announced that some administrators and teachers under the sponsorship of the Ministry of Education (MoE) have no valid residency permits, reports Al-Anba daily.

The daily obtained a copy of the letter that Al-Jutaili sent to the undersecretary of the ministry stating: "We would like to inform you that we have received official communication from the Ministry of Interior stating that a group of employees -- administrators and teachers -- under the sponsorship of the Ministry of Education have no valid residency permits to date. Based on Decree 17/1959 or the Foreigners Residency Law, it is prohibited to harbor, house or employ any foreigner whose residence in the country is illegal. It is considered a violation of the Residency Law, which obstructs the legal documentation process due to their status not being settled.

"Accordingly, you are kindly requested to circulate to the assistant undersecretaries in all sectors of the ministry about the need to ensure the validity of the residency and conformity with legal procedures.
"In the event that an expatriate em-

ployee is proven to have violated the Residency Law, please coordinate with the Passports Section at the Human Resources Department to complete the legal procedures to settle their

KUWAIT CITY, Dec 3: The Court of Cassation yesterday revealed the rationale of its ruling in the "Misuse of Army Fund Funds" case, which it issued last week, including the imprisonment of former Minister of Defense and Interior Sheikh Khaled Al-Jarrah and five other defendants for seven years with hard labor, and refraining from pronouncing the sentence on former Prime Minister Sheikh Jaber Al-Mubarak.

The court confirmed in the facts that it was proven from the case papers that the crime of seizing public funds had occurred.

It refrained from punishing Sheikh Jaber Al-Mubarak and ruled that he be dismissed and fined, as well as he return the amount of KD 53.9 million.

The court explained that its ruling was close to achieving its goal, and what it established is what was confirmed in its certainty. The case papers showed a deposit made by the first defendant in the amount of KD 59,900,600 in the Public Prosecution's treasury on April 27, 2021 for the benefit of the Ministry of Defense without restriction or condition.

According to what happened, the text of Article 81 of the Penal Code stipulated that if the court concluded that the perpetrator had committed a crime requiring a prison sentence and he was found guilty of it, it may decide in the report to refrain from pronouncing his punishment if it deems certain circumstances related to the offender or his crime give rise to the belief that he will not return to crime, and hence its ruling stops at that point.

Stipulated

The same article stipulated that in order to use this authority, the offender is required to provide a pledge, with or without bail, through which he will commit to good con-

If he violates the terms of the pledge, the court, upon the request of the indictment authority or the person appointed to supervise the offender or the victim, may proceed with the trial to impose on the offender the penalty prescribed for the crime that it is proven was committed by the offender, and convict him, and to confiscate the bail that may accompany his previously-mentioned pledge

It is also decided, as stated in Article 1/20 of Law No. 1/1993 regarding the protection of public funds, that Article 81 of the Penal Code may not be applied in any way to the crimes mentioned in the first law unless the perpetrator takes the initiative of refunding the funds that are the subject of the crime in full before closing the case in cases where restitution is required.

It was also decided, based on the Court of Cassation's ruling, that the report to abstain from pronouncing the punishment has limited effect to the original penalties without the supplementary penalties that must be imposed, even if the court decides to refrain from pronouncing the punish-

What was stipulated in the text of Article 16 of Law No. 1/1993 mentioned above is that, in addition to the penalties prescribed for the crimes mentioned in Articles 9, 10, 11, and 12, the offender shall be sentenced to dismissal and restitution with a fine equivalent to twice the value of the amount he embezzled, appropriated, or facilitated for someone else's benefit.

The purpose of issuing the dismissal penalty, as this court has done in cases where this is legally permissible, is that the person committed the crime while holding the job, and his continued stay in the job has no effect until the ruling is issued or the termination or expiry of his tenure.

The objective of the judiciary behind issuing this punishment in this last case is to prevent the perpetrator from assuming public office again.

Given the above, it is clear that the first accused (Sheikh Jaber Al-Mubarak) paid the aforementioned amount, which is sufficient to return the funds that are the subject of the crimes for which this ruling convicted him and which are mentioned in the first, fourth, and fifth paragraphs of Clause First of the indictment report.

The same applies to what the third defendant (Jassar Al-Jassar) and the fifth defendant (Samir Marian) were convicted of, which is mentioned in the fourth and sixth paragraphs of item six in the same report.

Based on the circumstances of the case regarding these crimes, the court believes that these three defendants should seek clemency in their regard by deciding to refrain from pronouncing their punishment in accordance to Article 1/20 of Law No. 1/1993 regarding the protection of public funds, in addition to imposing fines and dismissal penalties on them, which does not preclude the judiciary from deciding to abstain from pronouncing the punishment and adjudicating them as stated in the text. There is no place for the judiciary to impose a penalty of restitution after it appears to this court that the money that is the subject of these crimes has been paid.

Car transfer of dead: In the second case of its kind related to the transfer of vehicles owned by deceased people, the family members of a deceased individual submitted a report to the Public Prosecution demanding that those who transferred the ownership of vehicles of the deceased be held accountable after they found that the vehicles in question were not under the name of the deceased.

Representing the family members was Lawyer Mustafa Mulla Yousef, who explained to the Public Prosecutor that his clients, days after the death of their loved one, were surprised that his vehicles were no longer registered under his name after the issuance of his property data, but were transferred to the names of others. They therefore urged it to summon those responsible and take legal measures

Lawyer Yousef stressed that this case is not the first of its kind, adding, "We heard that there are dead people whose names were used in the elections of one of the unions. This case is also still pending with the judiciary.

He said, "If the accused are discovered, they must serve as a deterrent for others. At the same time, we appeal to the employees who refuse to carry out these transactions, even if the owners of those vehicles are the people closest to them. This is due to the fact that it will lead to their imprisonment, and there is nothing better than favoritism apart from protecting oneself from restricting their freedom and putting them in prison."

'Hostage deal seen, but Israel brutal policies against Palestinians to continue'

"THE Egyptian-Qatari mediation and American pressure on Israel succeeded in consolidating a truce agreement in Gaza after 40 days of continuous brutal bombing by the Zionist entity on Gaza, which left an unprecedented number of deaths and destruction. The truce included a ceasefire, an exchange of prisoners between Hamas and Israel, and the entry of humanitarian aid, fuel and medicine into the Strip," columnist Dr Noura Saleh Al-Majim wrote for Qabas daily.

"The war in Gaza this time was completely different from its predecessors that began in 2008. This was in terms of its impact on the reputation and pride of Israel, the Israeli interior, and the future of Netanyahu and the Israeli right as a whole; also, in terms of its impact and reflection on the armed resistance, the balance of power in the region and at the international level, especially the American

"Therefore, it is not easy to say with certainty -- as it was in the past -- that this truce will be extended, or will pave the way for a comprehensive ceasefire followed by a comprehensive settlement or the revival of a broader peace process, as the various international parties, led by the United States, seek.

"By reading the course of the war in Gaza since October 7 until the truce agreement, as well as the determinants and data, some of which were imposed by the war, we can deduce three expected scenarios for the war in Gaza after the truce:

First: Completely ending the war in Gaza. In politics, everything is possible and constantly changing according to changing interests, equations, and pressures. However, we believe that this scenario is the weakest and is very difficult to achieve. The slap that Israel received on October 7 is considered the most humiliating since it was forcibly planted in the region in 1947.

"In addition to its disastrous repercussions on Israel in various aspects, its negative repercussions, whose manifestations are now beginning to become clear, have on the immigration of Jews, and the dissipation of the dream of a greater Jewish state. Nearly one million Jews have left Israel since October 7.

"In light of this, Israel's primary declared goal from the first day of its operations in Gaza was to liquidate the Hamas movement and end its complete control over the Gaza Strip.

"In order to remove this threat that has become existential to Israel, restore

its dignity, and reassure the Jewish people about Israel's strength. Regardless of the tactics followed by Israel in Gaza, most notably the issue of displacing the people of the north to the south, the ultimate goal is to facilitate the process of eliminating Hamas. Hence, the idea of eliminating Hamas will not fall from Israel's future calculations in the Gaza Strip, only the tactics may differ, as we will explain later.

"Second: By ending the truce and continuing brutal operations in the Gaza Strip two main things come to the forefront -- Israel's failure to achieve any major goal in Gaza after 49 days of its brutal operations, while Israel's economic losses continue to bleed -- and the pressure from powerful parties on Israel, led by Washington, to end these operations, which have severely tarnished the reputation of Israel and Washington in the world. We can say that this scenario is likely not to last long. It is possible, but it is difficult for it to continue for a long time.

"Especially since Israel has submitted to the truce due to the strong internal pressure that Netanyahu faces from the families of the prisoners, after a miserable failure to liberate them through the destructive force of the Gaza Strip and this will not be allowed by many parties, especially Washington and Israel will need to destroy the entire Strip to free the rest of the hostages

"Third: The cessation of brutal operations in Gaza, with the continuation of specific operations in the Strip against Hamas leaders, individuals, and places. We believe that this scenario is likely after the truce or in the coming period.

The elimination of Hamas -- as we said -- will never fall from Israel's calculations, even if the leftist and moderate parties take the lead in Israel. But at the same time, continuing the brutal operations has proven to the Jews and their allies to be an impractical option.

"Therefore, Israel may acquiesce to a comprehensive deal to exchange all prisoners, but as usual, it will recapture more or carry out assassination operations on some of them, while following a long-term policy of targeting Hamas leaders and ending their rule in the Gaza Strip.'

"No to the reconstruction of Gaza ... Kuwait and the citizen come first. A bank robbery occurred in the Swedish capital, Stockholm, in 1973, during which four hostages, including a woman, were held captive for six consecutive days. During the abduction, the kidnappers talked to the hostages. Little by little, the woman fell in love with one of the kidnappers -- her attacker. Since then, this behavior has become an illness known as 'Stockholm Syndrome', columnist Ahmad Al-Dawaas wrote for Al-Seyassah daily.

"Is it not strange that the victim sympathized with her kidnapper or the perpetrator, that is, to love the person who wronged her? This expression applies to our country. Kuwait was oppressed by Arab countries during the Iraqi occupation, but they continued to help and defend the latter.

"During the occupation, we felt that we were a displaced, humiliated people seeking refuge in this or that country. We lived those days with our hearts breaking in pain over the loss of our homeland, Kuwait. The Palestinians, whom Kuwait helped for a hundred years, yes, 100 years, starting with the smuggling of weapons to them in World War I, did not stand with us. This has been the case up to the present.

"After the liberation, Kuwait continued to defend these people politically, help them financially, and fight for people who stabbed it in the back -- Palestine, Jordan, Tunisia and Yemen. We even named a street near Rabieh after Jordan. We named a residential area and a commercial complex after Kairouan, known as Tunis Street

"Kuwait continues to support Tunisia financially, while the Maghreb countries did not give Kuwait any importance, and the evidence is that a street or even a 'street corner' there was not named after Kuwait! We also helped Yemen, where we established hospitals and the University of Sanaa, and paid its teachers with Kuwaiti money, yet it stood against us during the occupation. We did not hold back on Lebanon, yet in the end, the criminal 'Hezbollah'

"Considering that the Stockholm syndrome continues to affect our government, the former speaker of the National Assembly defended the traitors and those ungrateful to Kuwait at the International Parliament Conference held in

"In October 2019, Kuwait paid \$15 million for the infrastructure in Gaza. This is how we defend it. We give money to the ungrateful people who have wronged us... Oh, oppression!

"As an example, within just five years -- until the year 2016, Kuwait spent more than \$42 billion in support for the economy of Arab countries. Kuwaiti charitable associations give their money to help them, while the Kuwaiti citizen suffers from difficult living conditions, the youths of Kuwait stand in a long line waiting for a job, and Kuwait's roads are damaged and need repairs. Relatives are more deserving of kindness. Kuwait's people are more deserving of its money, especially since they suffer from hardship and the high cost of living.

"Our country has not noticed something dangerous. The world will soon use electric cars to a large extent, which means that the world's demand for oil will gradually decrease. We will then enter a cycle of poverty and we will regret the astage of State funds on ungrateful Arab and foreign parties.

"Our government did not pay attention to this danger, so it began wasting public money and rushing to save this or that Arab country. They make mis-

"Come on, government, rush to the aid of Palestinians, waste the country's money on them. Kuwait will not spend three million dollars on them or even 20 million. Rather, it will deduct an amount that may reach 500 million dollars from the people's money, and then the government will cry about the budget

"We said in a previous article: Kuwait does not distinguish its friend from its enemy. Young representatives, who did not live through the occupation period, wear the Palestinian 'keffiyeh' -- the 'keffiyeh' of the graved Arafat whose wife did not fight with the Palestinians, but rather fled from her country and resided in France, just as the leaders of 'Hamas' fled and lived in Baghdad Gulf society.

When we were in poverty and destitution before the discovery of oil, and when we were children and paid tax to the Palestinians when we went to the cinema, the people of the West Bank did not send even a single apple to us here in Kuwait. When Saddam invaded us, they rushed to support him and wished for the disappearance of Kuwait.'

KUWAIT CITY, Dec 3: The Public Cleanliness Supervisor at the Jahra Governorate Municipality Branch, Dahham Al-Enezi, announced 7 violations of the cleanliness regulations were issued and 18 abandoned vehicles were removed, as part of a wide campaign carried out by the Public Cleanliness and Road Works Department at the Jahra Governorate Municipality Branch, reports Al-Seyassah daily.

The daily added, the officials targeted several locations in the Jahra Industrial Area, Saturday, in order to raise the level of cleanliness and to remove everything that obstructs the aesthetic view of the governorate and prevent waste from being thrown outside the containers.

Docus forged for job

10-year jail for nurse

KUWAIT CITY, Dec 3: The Criminal Court sentenced to ten-year imprisonment an Egyptian nurse who forged her documents in order to be appointed by the Ministry of Health, and imposed a fine of KD 21,000 for undeserved salaries she received in five years. It also imposed a fine of KD 5,000 on another person for forging the nurse's appointment.

The Public Prosecution had charged the two suspects of forging official documents for employment at the Ministry of Health, using unofficial papers, and seizing sums of money they were not entitled to as a result of this crime. However, the two suspects denied the accusations attributed to them by the prosecution.

Salem Al-Rashidi argued that the charge was not brought against his client, stressing that Article 10, Paragraph 2 of Law No. 6 of 2010 regarding work in the private sector, the legislator distinguished between two types of violations that could be committed by the employer and cited Article 138 of the same law as a punishment.

'Phone tapping not allowed'

Rules on eavesdropping devices

KUWAIT CITY, Dec 3: State Minister for Municipal and Communication Affairs Fahd Al-Shoula issued a decision on the use of communications equipment and eavesdropping devices, reports Al-Anba daily.

Article One: It is not permissible for any party to place any telephone under surveillance or provide any party with data and information about calls made or received from or to any telephone device unless a permit is issued by the Public Prosecution, approving the monitoring of specific telephone(s) within a specific period, that is, during investigation of cases.

Article Two: The permission stated in Article One shall be issued through an official letter from the Attorney General or by one of the public attorneys, if the permission is related to cases being investigated by the Criminal Investigations General Department or written permission issued by a member of the district or prosecution offices. This is in the event that permission is issued by the competent prosecution based on investigations conducted by the Criminal Investigations General Department or State Security Service.

Article Three: Results of the monitoring carried out based on permission of the Public Prosecution in the two cases mentioned in Article Two shall be sent directly to the party that requested the issuance of this permission, provided that the Public Prosecution is given a copy thereof.

Article Four: Results of the monitoring, as well as all procedures and correspondences that take place, shall be kept strictly confidential in order to ensure that the sanctity and privacy of the telephone communications being monitored or recorded are not infringed.

Article Five: It is prohibited to use, trade, possess, sell or display all types of audio or visual eavesdropping devices. The Central Agency for Information Technology (CAIT) is responsible for determining the type and nature of these devices and their technical specifications.

Article Six: The Communication and Information Technology Regulatory Authority (CITRA) shall receive the requests of offi-



cial authorities for the possession and use of eavesdropping devices. It then studies these requests and submits its recommendations to the competent minister in preparation for presenting them to the Council of Ministers.

eavesdropping vices except after the issuance of the relevant decree. It is also not permissible for any of these parties to use eavesdropping devices without obtaining permission from the Public Prosecution.

Article Eight: Calls may be transmitted to and from the State of Kuwait via satellite, Internet or any other technical means of connection, subject to the approval of CITRA.

Article Nine: CITRA is responsible for licensing international carriers to transport international traffic to and from the State of Kuwait and through the licensees' international gateways, in accordance with the appropriate controls, rules and means determined by CI-

Bashar & 'righteous' decision

a terrorist, another who stole donation funds, a tenth known sectarian killer, and a group of those who escaped from prison sentences, and others.

alsarraf include citizens, for reasons unknown to the insider. Only the doctor, Bashar Adnan Al-Baghli, remained alone and distinguished in his case, as he had previously been included in a pardon, and a case similar to the case in which he had previously been pardoned remained in his record.

Dr. Bashar was accused, while studying medicine in Britain, where he still works in hospitals, of sending a tweet that harmed national unity, and another tweet related to insulting a Gulf

Dr. Bashar says he admits to one of the two tweets, while the other was from a fake account attributed to him, but he was sentenced to a prison term in absentia, and his circumstances did not allow him to return and face the charge, for fear of the prison sentence being executed against him.

As for the other, it was dropped when a pardon was issued, and one is pending. However, a pardon had previously been issued to anyone who tweeted something similar, or he was sentenced to pay financial fines, and

the last of these rulings was for a wellknown tweeter. I do not know Bashar Al-Baghli, and

none of his family or friends contacted me to ask me to write about him, his circumstances, and his misfortune. I have never met him, and there are only two or three messages between me and him on the X platform, but I am aware that he is a person of good conduct and the son of a noble and well-known fam-

Brother of the late MP and Minister Ali Al-Baghli, I know, of course, that he has been living in exile for many ears, far from his homeland, his family, and his loved ones.

He is over forty years old, and his return to his homeland does not pose a threat to anyone. Also, the country is in dire need of someone with his experience, and we hope that those concerned will seek to issue a high paternal pardon

It appears from the data, his entitlement to pardon, and the lack of seriousness of his "crime" compared to the majority of those who were issued generous pardon, that an "administrative oversight" may have dropped his name from being included in the pardon lists, as he is indeed, according to the data available to me, the first to deserve the princely honor, regardless of his accusation or because of his good conduct, or because of his rare knowledge and specialization.

Truth, reality, and justice require, after all that has happened, the zeroing out of the prisons, and the dropping of even the cases of debtors from the days of the climate crisis, who have had forty lean years. It is not permissible, with reason and justice, for a single prisoner convicted of cases other than murder and drugs to remain in prison after reviewing "the history of some of those who were recently pardoned."

statements, because social media wants more fuel for the fire.

Unfortunately, this is what eludes the concerned officials. During the time when the late Amir Sheikh Sabah Al-Ahmad was ill, the spread of rumors about it at that time should have served as a lesson for us to change the way we handle such events.

The health of senior officials is important, because it affects the political situation both locally and regionally, as well as the economy, stock market indicators, and other aspects

Therefore, when an official statement is delayed, as it is supposed to be issued more than once a day, this directly affects everyone, because each has its own calculations in light of developments, especially in a region witnessing sensitive situations, and each of its countries has its own

Also, all the forces and groups lurking in Kuwait have a vision of what they can achieve through the political poisoning of the situation in order to destroy faith in the homeland and weaken social cohesion, which then leads to inciting tribal and sectarian strife.

If all these calculations are not in the minds of the state officials, they are indirectly contributing to sprinkling more salt on the wound of national unity, which leads to further weakness.

However, when frankness is the basis, and the local public opinion, which is the incubator of the political system especially in a country like Kuwait, is exposed, all of this leads to the demolition of the structure of lies on the heads of those who

Finally, it must be emphasized that the threat of referring to the Public Prosecution those who spread lies is a form of fiction, as all of these people are either publishing from outside Kuwait, or under fake names. Therefore it is not possible to refer all of them to the Public Prosecution, but the correct path is through transparency, moment by moment.

Addressing the data flow between local banks and the Central Bank, the statement clarifies that banks provide transaction data for statistical purposes and monitoring comparative growth. Contrary to any misconceptions, this data is not employed to impose restrictions on transfers. Kuwait maintains an open economy, and there are no restrictions on external transfers. The positive economic indicators in the country reinforce the idea that there is no need for the imposition of such restrictions on foreign transfers.

Despite a slight decrease in the

value of Kuwait's official reserve assets by the end of October, the Central Bank asserts that the exchange rate policy has been efficiently managed. This policy pegs the dinar to a weighted basket of foreign currencies and is underpinned by the continued accumulation of foreign

In terms of supporting the exchange rate policy, the Central Bank actively directs monetary policy at the interest rate level. This strategic approach is aligned with providing a favorable environment for economic growth while simultaneously enhancing the attractiveness of the dinar against foreign currencies. Additionally, the bank is committed to fortifying the deposit base in the dinar, a fundamental source of financing for various sectors of the national

Turning attention to concerns related to combating money laundering and terrorist financing, the statement elucidates the role of banks in monitoring and reporting suspicious transactions. Banks, when having sufficient evidence to suspect any external or internal transfers to customers, carry out their responsibilities as outlined by Law No. 106 of 2013. This law mandates financial institutions, including banks, to notify the Kuwait Financial Investigation Unit directly about any transactions associated with criminal activity or posing a risk of money laundering or

terrorist financing.
Importantly, the statement emphasizes that decisions regarding suspicions about external transfers to customers or inward transfers are made by individual banks based on continuous monitoring of the movement in the customer's account. This data is not available to the Central Bank, as it falls within the purview of the banks' responsibilities as specified by Law No. 106 of 2013. The Central Bank does not engage in monitoring or tracking the movement of external and internal transfers for customers, as such accounts are not within its mandate.

In providing this comprehensive overview, the Central Bank seeks to reinforce confidence in Kuwait's financial system, regulatory framework, and the prudent management of its economic policies

On the other hand, Rapporteur of the Budgets and Final Accounts Committee MP Osama Al-Zaid disclosed that the committee on Sunday met with the representatives of the concerned institutions to discuss the final account of the Ministry of Education for fiscal 2022/2023. He said Minister of Education, Higher Education and Scientific Research Adel Al-Manea neither attended the meeting nor sent his representative as a sign of respect for the National Assembly. He added the senior officials who represented the Ministry of Education in the meeting are acting officials, indicating they cannot respond to the committee's queries as they assumed the interim post recently. He called on HH the Prime Minister Sheikh Ahmad Nawaf Al-Ahmad Al-Jaber Al Sabah to follow up this issue and instruct the ministers to respect the Assembly and not to ignore the parliamentary meetings. He highlighted the importance of the meeting since the Ministry of Education ranks second in terms of budget allocation -- KD 2.2 billion.

Chairman of the Public Facilities Committee MP Muhammad Al Mahan confirmed that the committee on Sunday approved the proposal of MP Dawoud Maarefi to transfer the supervision of public parks from the Public Authority for Agriculture Affairs and Fish Resources (PAAAFR) to the cooperative so-

The proposal stipulates the provision of more services for citizens, especially those residing in the southern areas where public services are limited. It mandates the cooperatives to supervise the public parks, allot spaces for citizens who want to establish small businesses at a low cost, and provide jobs for the retirees under the wages chapter without reducing their pension. The Ministry of Electricity, Water, and Renewable Energy also secured the eighth tender for annual maintenance of cranes and handling tools, valued at 62 thousand

Jailed Putin 'critic' faces new charges

MOSCOW, Dec 3, (AP): Imprisoned opposition leader Alexei Navalny has been handed new charges by Russian prosecutors

The 47-year-old is already serving more than 30 years in prison after being found guilty of crimes including extremism - charges that his supporters characterize as politically motivated. In comments passed to his associates, Navalny said he had been charged under article 214 of Russia's penal code, which covers crimes of vandalism.

"I don't even know whether to describe my latest news as sad, funny or absurd," he wrote in comments on social media Friday via his team. "I have no idea what Article 214 is, and there's nowhere to look. You'll know before I do."

Navalny is one of President Vladimir Putin's most ardent opponents, best known for campaigning against official

corruption and organizing major anti-Kremlin protests. The former lawyer was arrested in 2021, after he returned to Moscow from Germany where he had recuperated from nerve agent poisoning that he blamed on the Kremlin. He has since been handed three prison terms and has faced months in solitary confinement after being accused of various minor infractions.

Several Navalny associates have also faced extremism-related charges after the politician's Foundation for Fighting Corruption and a network of regional offices were outlawed as extremist groups in 2021, a move that exposed virtually anyone affiliated with them to prosecution.

Ex-president barred from leaving Ukraine: Former Ukraine president Petro Poroshenko was denied permission to leave Ukraine for a planned meeting with Hungarian Prime Minister Viktor Orban, Ukraine's security service said Saturday.

Poroshenko announced Friday that he had been turned away at the border despite previously receiving permission from Parliament to leave the country. Under martial law, Ukrainian men between 18 and 60 years of age are not allowed to leave the country without special approval.

The 58-year-old, who lost his re-election bid in 2019 to current Ukrainian president Volodymyr Zelenskyy, said that he had planned to meet with U.S. House Speaker Mike Johnson, and the Polish parlia-

ment during his trip.

But security officials said that Poroshenko had also agreed to meet Orban, who has previously praised Russian President Vladimir Putin and refused to support Kyiv's bid for EU accession. In a statement on social media, they said such talks would make Poroshenko a "tool in the hands of the Russian special services."

Police in Greece arrest father, son: A father and son duo in Greece were arrested for selling adulter ated sunflower oil marketed as olive oil, police said

A raid in a warehouse outside the northern city of Thessaloniki on Friday yielded over 13 tons of the oil, with slightly more than half already packaged in tin cans

and plastic bottles and the rest in a tank, police said. The pair, aged 80 and 36, bought the sunflower oil in Bulgaria, not far from Thessaloniki, and added coloring agents to pass it off as extra virgin olive oil. Some of it they sold in Bulgaria and the rest in Greece, police said.

The pair were provisionally released after interrogation by a magistrate. Oil samples have been sent to a laboratory to determine whether the coloring agents are dangerous.

Tens of thousands attend military parade: Tens of thousands of people turned out in Romania's capital on Friday to watch a military parade that included troops from NATO allies to mark the country's national day.

The annual parade at the Arc de Triomphe in Bucharest brought together thousands of marching soldiers as dozens of combat jets and helicopters flew overhead. Many spectators waved Romanian tricolor flags: red, yellow and blue.

Friday's ceremony celebrated the 105th anniversary of Great Union Day of 1918 when modern-day Romania was formed after its unification with the neighboring regions of Transylvania, Bessarabia and Bukovina. After communism ended in 1989, Dec 1 was declared a national holiday to commemorate the ethnic Romanians in Alba Iulia who declared a union of Transylvania with Romania.

Trucking boss gets 7 years: A trucking company boss who claimed he thought he was smuggling booze into Britain was sentenced to seven years in prison for his role in a human trafficking ring in which 39 Vietnamese migrants suffocated in a cargo container

Caolan Gormley was the last of 11 people to be convicted in London in the migrant smuggling scheme. Five of the suspects were convicted of manslaughter.

Gormley, 26, from Armagh, Northern Ireland, was convicted of conspiracy to assist unlawful immigration by a jury that deliberated for little more than an hour in the Central Criminal Court, known as the Old Bailey.

Sweden halts adoptions from SKorea: Sweden's main adoption agency said it was halting adoptions from South Korea, following claims of falsified papers on the origins of children adopted from the Asian

Swedes have been adopting children from South Korea since the 1950s. The head of Adoptionscentrum - the only agency in Sweden adopting children from South Korea - said the practice is now ending.

Kerstin Gedung referred to a South Korean law on international adoptions passed earlier this year, which aims to have all future adoptions handled by the state.

Idaho baby found dead: An Idaho baby was found dead by police on Saturday, one day after an Amber Alert was issued for him, authorities said. The baby's father was taken into custody on an arrest warrant issued in connection with the death of his wife.

Police found the body of 10-month-old Zeke Best about 24 miles (39 kilometers) east of Idaho Falls after a hunter called to report a man in a sleeping bag on the side of the road. The man was identified as Jeremy Albert Best and was wanted in the alert issued Friday on suspicion of kidnapping the child in Teton County, the Bonneville County Sheriff's Office said.

Officers located Best's car in an embankment off the road and found the baby dead at the scene, the office said in a news release. Idaho State Police and the FBI were among the agencies processing the scene, authorities said. The investigation

The man was also wanted as part of an investigation into the death of his wife, Kali Jean Randall, whose body was found in her Victor residence on Thursday. The Teton County Sheriff's Office said on its Facebook page Randall's death was being investigated as a homicide. (AP)

Family pet kills 3-month-old boy: A 3-month-old boy was killed as his parents tried to rescue the baby from the family pet, a hybrid animal that was part dog,

part wolf, authorities said. The boy had been bitten but was alive when first responders arrived shortly be-fore 1 pm Thursday at the home in Chelsea. He was transported to Grandview Medical Center where he was later pronounced dead, news outlets reported.

Trump calls Biden 'destroyer' of democracy

DeSantis hits Iowa campaign milestone

NEWTON, Iowa, Dec 3, (AP): Ron DeSantis completed his campaign promise to visit each of Iowa's 99 counties, crossing a symbolic but also tactical threshold by telling his audience in a central Iowa town "this should show you that I consider myself a servant, not a ruler.

Former President Donald Trump, who still remains far ahead of DeSantis, mocked him at a larger rally about 100 miles away and said the Florida governor's campaign was falling "like a very seriously wounded bird.

In that way, the Florida governor's moment, much like the months of campaigning so far, took place under Trump's towering shadow.

The presence of Trump on DeSantis day of accomplishment underscores the challenge he and other Trump rivals face in Iowa. DeSantis has said he expects to win the caucuses. He's focused much of his campaign on the state and a super PAC supporting him has invested more than \$16 million in advertising and more on building a campaign organization for the Jan. 15 caucuses.

But even with the endorsement of Iowa Gov Kim Reynolds, DeSantis has not cut into Trump's huge lead and is facing new pressure from the campaign of former United Nations Ambassador Nikki Haley.

Discuss

His political operation lost another top official on Saturday. Kristin Davison resigned from the Never Back Down super PAC less than two weeks after taking over from the previous CEO following his departure, according to two people familiar with the matter who spoke on condition of anonymity to discuss internal operations. Politico first reported Davison's

Never Back Down spokesperson Jess Szymanski said that Scott Wagner would serve as the new CEO and that the group still has "the most organized, advanced caucus operation of anyone in the 2024 primary field."

DeSantis portrayed the timeworn

feat for presidential candidates of visiting all of Iowa's counties as an adventure for his family. On one visit, he went to the "Field of Dreams" baseball movie set and pitched to his children on a baseball diamond cut into a corn-

Stops at famous bakeries and ice cream parlors made for quaint stories about his family, including wife and three young children, trekking across Iowa since May. But the mission taught him more, he said.

"You meet people, rustle up some votes," he said at an events center in Jasper County, just east of Des Moines in central Iowa. "But is it just all about politics?"

Trump has savaged DeSantis, mostly criticizing him as disloyal for running against Trump after seeking his endorsement when DeSantis first ran for governor.

"We hit him very hard and he's been falling out of the air like a very seriously wounded bird," Trump said during his Cedar Rapids event, twirling his right index finger to symbolize what he says was DeSantis' fall.

DeSantis advisers argue that making stops in each county on Iowa's sprawling checkerboard can squeeze critical support out of small rural counties while also demonstrating a commitment to courting all parts of the state.

But he is facing internal problems within his political operation - with two key officials leaving the major super PAC supporting him - and a challenge from Haley as the chief competitor to Trump. She has been rising in early-state polls and picked up the support of Americans for Prosperity, the political arm of the powerful Koch network.

Former US president Donald

Trump on Saturday attempted to turn the tables on his likely rival in November, President Joe Biden, arguing that the man whose election victory Trump tried to overturn is "the destroyer of American democracy.'

Trump's allegations about Biden, a Democrat, echo the ones that Biden has been making for years against his predecessor. As Trump has dominated the Republican presidential primary and talked about targeting his rivals and the news media if he wins the White House again, Biden has stepped up his own warnings, contending Trump is " determined to destroy American democracy."

Misusing

On Saturday, Trump made his most explicit argument to date on why voters should instead see his rival as the bigger democratic threat. Trump repeated his longstanding contention that the four criminal indictments against him show Biden is misusing the federal justice system against his rival.

He's been weaponizing government against his political opponents like a Third World political tyrant," Trump said to a crowd in Cedar Rapids, Iowa. "Biden and his radical left allies like to pose as standing up as allies of democracy," Trump continued, arguing: "Joe Biden is not the defender of American democracy, Joe Biden is the destroyer of American democracy.'

Ammar Moussa, a Biden campaign spokesman, responded: "Donald Trump's America in 2025 is one where the government is his personal weapon to lock up his political enemies. You don't have to take our word for it -Trump has admitted it himself."

Trump has long promised to prosecute Biden in retaliation should he return to the White House. On Saturday, though, the former president extended his arguments about Biden's threat to democracy to lawsuits filed by two liberal organizations seeking to rule him ineligible for office under a rarely used Civil War-era constitutional provision that prohibits those who "engaged in insurrection" from returning to office.

All of the suits to date have failed. Biden has no involvement in them, but Democratic donors who back him also help fund the liberal groups filing the

nation's most prominent conservative groups, has been accused of rape, leading Gov Ron DeSantis to call for his resignation, roiling the state's conservative politics and creating accusations of hypocrisy from Democrats.

3rd party candidate leaves Mexico 'race'

MEXICO CITY, Dec 3, (AP): A third-party candidate announced Saturday he is leaving Mexico's 2024 presidential race, practically ensuring the country 's next president will be a woman.

Samuel García, the governor of the northern border state of Nuevo Leon, said Saturday he won't run for president in the June 2 elections. He had been polling below 10% in the race, and was given almost no

chance of actually winning.

That leaves only the ruling Morena party and the opposition coalition's candidates, both of whom are women. While García's small Citizen's Movement party could yet nominate another male candidate, García's troubled exit suggests the party won't be able to find anyone of much stature to run.

Gov. García's decision came after one of the wilder

On Friday, the border state across from Texas briefly saw two interim governors designated to replace García, who had asked for a six-month leave of absence to campaign for president.

"I have decided not to participate in the campaign for president," García wrote in a decree announcing his decision.

García's decision will almost certainly be a disappointment for President Andrés Manuel López Obrador. López Obrador had openly expressed sympathy for García, whose Citizen's Movement party has been a sometimes ally of the president's Morena party.

López Obrador claims his sympathy for García stemmed from supposed attempts to keep the governor from running, which the president said paralleled his own experience in 2005 and 2006, when a court briefly stripped him of his right to hold office.

But critics say López Obrador was encouraging García's doomed candidacy - as Mexican ruling parties have done frequently in the past - as a way to split the opposition vote.

Nuevo Leon, across the border from Texas, is an important industrial hub and García, 35, had hoped his youthful, social media-savvy campaign style would attract younger voters,

Since he took office in 2021, García has faced a severe water crisis that left much of Monterrey, the state capital, without service for weeks. He has also bragged about his friendship with Elon Musk, and has touted hopes that a Tesla plant will be built in his state.

SAN SALVADOR, El Salvador: El Salvador's Congress granted President **Nayib Bukele** leave for six months to allow him to campaign for reelection despite a constitutional prohibition and approved the president's selection of his private secretary to be the country's interim leader.

Bukele will seek a second five-year term for the New Ideas party in the Feb 4 national elections. Vice President **Félix Ulloa** was also granted leave to campaign again as Bukele's running mate.

Lawmakers voted 67 in favor to 12 against to approve Bukele's request for leave.

Congress then voted to approve Bukele's selection of Claudia Juana Rodríguez de Guevara, his private secretary, to fill in until his current term ends May 30, 2024. Rodríguez de Guevara has been a close collaborator of Bukele since his political start as mayor of Nuevo Cuscatlan.

7 miners dead in landslides: Seven miners were confirmed dead and more than 20 others were missing and presumed dead after heavy rains caused landslides that buried them inside tunnels they had been digging illegally at a copper mine in Zambia, police and local authorities said Saturdav.

No bodies had yet been retrieved after the landslides late on Thursday night, police said. Many of the victims were believed to have drowned. The miners were digging for copper ore

The miners were digging for copper ore at the Seseli open-pit mine in the copper-belt city of Chingola, around 400 kilometers (250 miles) north of the capital, Lusaka, according to police. The landslides happened some time between 9 pm and 10 pm on Thursday, police said.

Police gave names or partial names of seven confirmed victims and said all of the miners in the tunnels are "suspected to have died."

Neither police nor government officials could say exactly how many miners were trapped in the tunnels, but Chingola District Commissioner Raphael Chumupi told The Associated Press that there were at least 36. "We are saddened to hear about the tragic

accident at a makeshift mine site in Chingola that has claimed many lives," Zambian President **Hakainde Hichilema** said in a post on his official Facebook page. "Our

Myanmar military losing ground against attacks

Strong quake kills 1 in southern Philippines

MANILA, Philippines, Dec 3, (AP): A powerful earthquake that shook the southern Philippines killed at least one villager and injured several others as thousands scrambled out of their homes in panic and jammed roads to higher grounds after a tsunami warning was issued, officials said Sunday.

The US Geological Survey reported that the quake Saturday night had a magnitude of 7.6 and struck at a depth of 32 kilometers (20 miles). The Pacific Tsunami Warning Center said it expected tsunami waves to hit the southern Philippines and parts of Indonesia, Palau and Malaysia, but later dropped its tsunami warning.

In Japan, authorities issued evacuation orders late Saturday in various parts of Okinawa prefecture, including for the entire coastal area, affecting thousands of people.

Collapsed

A pregnant woman died after she, her husband and daughter were hit by a 15-feet (4.5-meter) concrete wall that collapsed in their neighborhood as the ground shook and prompted them to flee from their house in Tagum city in Davao del Norte province, the city's disaster-mitigation chief, Shieldon Isidoro, told The Associated Press.

Her husband and daughter were injured. Two other children and their parents jumped from a second-floor window in panic as their house swayed but were not injured after landing on a grassy lot, said Isidoro, who was at his home when the ground started to shake.

"Initially the swaying was weak. Then it quickly became stronger and I could hardly stand. My perfume bottles fell off a table, pictures on my wall swung and I heard people screaming outside: 'Get out, get out, earthquake, earthquake!" Isidoro said.

while he feared the roof of his house would collapse on him, Isidoro said he was more worried that there could be many casualties in Tagum, a city of about 300,000 people, where he had led regular earthquake drills that he thought helped prevent more deaths and injuries.

Hundreds of patients were evacuated from a Tagum hospital but later were escorted back after an inspection showed no major damage to the building, officials said. Thousands of resi

Thousands of residents stayed outside their homes for hours in many towns due to the earthquake and tsunami scare, including in some that were drenched by an overnight downpour, officials said. Defense Secretary Gilberto Teodoro Jr told a news conference that authorities were assessing the quake's impact but initial reports indicated there were no major damages except for two damaged bridges and pockets of power outages. One death was reported with a few injuries, he said.

Teresito Bacolcol, the head of the Philippine Institute of Volcanology and Seismology, told The AP shortly after the quake hit that his agency advised residents along the coast of Surigao del Sur and Davao Oriental provinces, which were near the epicenter of the undersea quake, to immediately evacuate to higher ground or move farther inland. Pictures posted on the Facebook account of Hinatuan town in Surigao del Sur province show residents fleeing to higher ground on foot or aboard cars, trucks, motorcycles and tricycle taxis overnight.

Many villagers who fled to evacuation centers returned to their homes on Sunday, officials said.

After undertaking inspections, civil aviation officials said there was no major damage in several airports in the south and there was no disruption in flights operations.

The Philippines, one of the world's most disaster-prone countries, is often hit by earthquakes and volcanic eruptions due to its location on the Pacific "Ring of Fire," an arc of seismic faults around the ocean. The archipelago is also lashed by about 20 typhoons and storms each year.

BANGKOK: About two weeks into a major offensive against **Myanmar's** military-run government by an alliance of three well-armed militias of ethnic minorities, an army captain, fighting in a jungle area near the northeastern border with **China**, lamented that he'd never seen such intense action.

His commander in Myanmar's 99th Light Infantry Division had been killed in fighting in **Shan** state the week before and the 35-year-old career soldier said army outposts were in disarray and being hit from all sides.

"I have never faced these kinds of battles before," the combat veteran told The Associated Press by phone. "This fighting in Shan is unprecedented." Eight days later the captain was dead himself, killed defending an outpost and hastily buried near where he fell, according to his family.

The coordinated offensive in the northeast has inspired resistance forces around the country to attack, and Myanmar's military is falling back on almost every front. The army says it's regrouping and will regain the initiative, but hope is rising among opponents that this could be a turning point in the struggle to oust the army leaders who toppled democratically elected **Aung San Suu Kyi** almost three years ago.

"The current operation is a great opportunity to change the political situation in Myanmar," said **Li Kyar Win**, spokesperson for the Myanmar National Democratic Alliance Army, or MNDAA, one of the three militias known as the Three Brotherhood Alliance that launched the offensive on Oct. 27.

"The goal and purpose of the alliance groups and other resistance forces are the same," he told the AP. "We are trying to eliminate the military dictatorship."

Caught by surprise by the attack

caught by surprise by the attack dubbed Operation 1027, the military has lost more than 180 outposts and strongpoints, including four major bases and four economically important border crossings with China.

Both sides claim they have inflicted

heavy tolls on the other, though accurate casualty figures are not available. Nearly 335,000 civilians have been displaced during the current fighting, bringing the total to more than 2 million displaced nationwide, according to the United Nations.

In the latest assault, a coalition

In the latest assault, a coalition of militia forces attacked a town in southeastern **Kayin** state on Friday, blocking the main road to a key border town with Thailand. Residents said the military responded with artillery and airstrikes.

"This is the biggest battlefield challenge that the Myanmar military has faced for decades," **Richard Horsey**, the International Crisis Group's Myanmar expert, said of the offensive.

nent human rights defender in Burkina Faso has been abducted by unknown individuals, rights groups have announced, in what activists say could be the latest attempt by the military government to target dissidents using a controversial law.

Daouda Diallo, a 2022 recipient of the Martin Ennals international human rights award, was abducted on Friday in Burkina Faso's capital of Ouagadougou after visiting the passport department where he had gone to renew his documents, according to the local Collective Against Impunity and Stigmatization of Communities civic group, which Diallo founded.

His captors - in civilian clothing - accosted him as he tried to enter his car and took him to "an unknown location," the group said in a statement on Friday, warning that Diallo's health could be at risk and demanding his "immediate and unconditional" release.

Amnesty International's West and Can

Amnesty International's West and Central Africa office said Diallo's abduction was "presumably (for him) to be forcibly conscripted" after he was listed last month among those ordered to join Burkina Faso's security forces in their fight against jihadi violence as provided by a new law.

"Amnesty International denounces the use of conscription to intimidate independent voices in #BurkinaFaso and calls for the release of Dr Diallo," the group said via X, formerly known as Twitter.

Earlier this year, Burkina Faso's junta announced the "general mobilization" decree to recapture territories lost as jihadi attacks continue to ravage the landlocked country.

GCC index sees biggest gain in sixteen months led by a global rally... CC equity market index witnessed GCC equity market mides with the first gain in four months after benchmarks across the GCC countries witnessed gains during the month. The MSCI GCC index was up by 5.2% during November-2023 mainly led by optimism in the global markets following expectations that interest rates have peaked and central banks may start cutting rates next year, most likely during the second half. Qatar was the best performing market in the GCC with a return of 5.4% followed by Saudi Arabia and Dubai with gains of 4.6% and 3.0%, respectively. The monthly gains lowered the YTD2023 decline for the region to 2.4% as four out of the seven regional benchmarks still showed declines while Dubai followed by Saudi Arabia showed healthy YTD gains of 19.7% and 6.7%, respectively

On the sectoral front, almost all regional indices showed gains during November-2023, barring the GCC Insurance index that dropped marginally by 0.4%. On the gainers side, Pharma & Biotech was leading with a gain of 21.4% followed by Consumer Durable & Apparel and Healthcare indices with gains of 14.0% and 11.7%, respectively. Large-cap sectors like Banking showed impressive gains of 6.6% while Energy and Materials indices showed relatively smaller gains of 1.8% and 4.3%, respectively.

On the international front, almost all key global markets were up during the month with healthy gains. The optimism pushed the MSCI World index to the highest in almost four months with a gain of 9.2%, the biggest monthly gain in 3 years. The YTD-2023 gain

for the index stood at 16.2%. US Tech stocks were the best performing during the month with the NASDAQ Composite index gaining 10.7% during the month while the S&P 500 index was up by 8.9%. Emerging market index also witnessed a healthy gain of 7.9% during November2023.

Boursa Kuwait returned to growth with all the four benchmark indices witnessing gains during the November-2023. The gains were mainly seen in large-cap stocks as the Premier Market Index outperformed other indices on the exchange with a gain of 2.1% to close at 7,291.7 points. The Main 50 Index witnessed a slightly smaller monthly growth of 1.6% while the Main Market Index was up 1.1%. The All-Share Market Index reported a monthly growth of 1.9% and closed at 6,653.84 points. In terms of YTD-2023 performance, all the market segments were in red with Premier Market Index down by 10.2% followed by 8.8% decline for the All-Share Market Index. The Main 50 Index and Main Market Index dropped by 6.3% and 2.6%, respectively.

The monthly sector performance chart favored gainers. The Basic Materials index topped during Novemeber-2023 with a gain of 6.5% followed by Energy and Financial Services indices with returns of 4.7% and 4.1%, respectively. On the decliner's side, the Insurance index witnessed the biggest decline of 1.7% during the month followed by the Consumer Discretionary index with a decline of 0.9%. All the constituent stocks of the Basic Materials index witnessed gains during the month. Shares of Al Kout for Industrial Projects and Boubyan Petrochemicals reported gains of 10.0% and 5.9%,

respectively. Gains for the Energy index was mainly led by strong gain in shares of The Energy House at 43.3%, further supported by gains of 7.2% and 4.3% in shares of NAPESCO. and Independent Petroleum Group, respectively. NAPESCO reported a net profit of KWD 6.4 Mn in 9M-2023 compared to a net profit of KWD 5.4 Mn in 9M-2022 led by the increase in the operating revenue. The Telecom index was supported by a 7.4% gain in shares of STC Kuwait followed by 5.8% and 3.7% gain in shares of Ooredoo Kuwait and Hayat Comm., respectively. Large-cap indices like Banking was up by 1.2% after shares of four out of ten Kuwaiti banks declined.

In terms of monthly stock performance, IFA Hotels & Resorts topped with a gain of 98.6% followed by Int'l Financial Advisors and The Energy House with gains of 47.1% and 43.3%, respectively. On the decliner's side, Kuwait Cement topped with a decline of 15.5% followed by Dar Al Thuraya Real Estate and Arkan Al-Kuwait Real Estate with declines of 13.5% and 13.4%, respectively. In terms of trading activity, Total monthly volume traded increased by 9.2% to 4.0 Bn shares as compared to 3.6 Bn shares during the previous month, while monthly value traded also increased by 4.8% to KWD 1.0 Bn as compared to KWD 970.2 Bn during October-2023. US economy continues to show signs of resilience

North America

CB Consumer Confidence n November 2023, the US economy witnessed a rebound in consumer consecutive monthly declines. This rise in sentiment was primarily driven by an improvement in expectations, despite persistent concerns over inflation and interest rates. The Consumer Confidence Index, as reported by the Conference Board, climbed to 102.0 from a downwardly revised 99.1 in October, and above expectations of 101.0. The surge in confidence was predominantly observed among older households, while younger consumers remained more cautious about their financial prospects

Prelim GDP q/q

The US Gross domestic product showed expansion in the third quarter, coming in at 5.2% compared to the initial reading of 4.9% and exceeding expectations of 5%. The news release, which followed a higher-thanexpected Conference Board consumer confidence data, indicates that the US economy continues to show signs of resilience and sustained growth despite the tightening policies. The growth marks a significant increase from the second quarter's rate of 2.1%. The news was also followed by an easing in unemployment rate which dropped from 233k to 209k in November, further supporting the argument that the US economy is withstanding higher rates. The data seems to support the narrative that a possible soft landing is achievable for the Fed.

Core PCE Price Index

The latest core personal consumption expenditure price index, which excludes the volatile food and energy components advanced 3.5% YoY the Fed's preferred gauge of underlaying inflation. Meanwhile, overall PCE price index is running at 3.00%, the smallest gain since March 2021 yet still above the feds 2% target. One of the FOMC's hawks signaling no more hikes and even potentially opening the door to policy easing. Fed gov. Chris Waller said that "If you see this [lower] inflation continuing for several more months, I don't know how long that might be -3 months? 4 months? 5 months? — you could then start lowering the policy rate because inflation's lower

US unemployment claims

US unemployment claims rose to 218,000 last week, up 7,000 claims from 211,000 the week prior on a seasonally adjusted basis. About 1.9 million workers continue to claim unemployment benefits, the highest level in two years. That number had been generally on the rise over the past two months, suggesting unemployed workers are increasingly having a harder time finding new jobs. In her recent speech, European Central Bank President Christine Lagarde emphasized the ECB's vigilant and focused approach to monetary policy amid current economic challenges. This stance comes after a significant hike cycle in interest rates by 450 basis points over the last year to counter inflation. Despite these measures and the current economic data, the ECB remains cautious, closely monitoring inflation trends, wage dynamics, and labor market conditions. In a meeting with EU lawmakers, European Central Bank President Christine Lagarde warned that now "is not the time to start declaring victory." Additionally, she warned that the central bank will "need to remain attentive to the different forces affecting inflation and firmly focused on our mandate of price stability." Lagarde also reiterated the ECB's guidance that current rates would need to be held for a "sufficiently long" period of time. Furthermore, she acknowledged that the

current environment of elevated rates, slow growth, and softening labor market will be key to bring inflation down to their 2% target.

Asia Pacific

Australian CPI y/y Australia's inflation eased in Novem-

ber more than expected. With the consumer price index coming at 4.9%, significantly lower than the previous rate of 5.6%, and lower than the expected 5.2%. The drop is mainly contributed by a fall in the prices of goods, while core inflation also edged down. The fall in inflation affirms that the central bank's approach is yielding results, hinting that higher interest should be kept at the current rates. The Australian dollar dipped to 0.6637 before currently stabilizing at around 0.6645 against the US dollar.

OPEC+

OPEC+ meeting

The organization of petroleum exporting countries and its allies, also known as OPEC+, assembled for a meeting to decide their next production policy steps on Thursday. They have agreed to make an additional voluntary cut to oil production in 2024 in an attempt to support the current market conditions. Saudi Arabia pledged to extend an existing voluntary cut of 1 million barrels per day until the end of the first quarter while Russia also announced that they will deepen its existing voluntary cuts in exports to 500,0000 barrels per day from the previous of 300,000 mainly due to rise in supply from rival producers. In addition, other members including the UAE's state news agency saying it would voluntarily cut by 163,000 bpd in the first quarter, while Iraq and Kuwait said they would cut by 211,000 bpd and 135,000 bpd respectively. Oman, Algeria, and Kazakhstan also pledged additional reductions. With that said Brent Crude fell by 0.2% to \$80.72 a barrel, while U.S. West Texas Intermediate crude fell by 0.2% to \$75.84.

Gold hits record highs surpassing \$2,070/oz

KUWAIT CITY, Dec 3: Gold soared to record-breaking heights, surpassing the \$2,070 per ounce threshold by the close of last week's trading session, reports Al-Seyassah daily.

The surge came in response to disappointing US economic data and escalating military tensions in the Middle East. Adel Al-Fadhli, Head of Strategic Planning at Kuwaiti Dar Al-Sabaek Company, revealed that the precious metal marked its third consecutive week

of gains amid sluggish American economic indicators.

Al-Fadhli cited a sustained contraction in US factory activity, a slowdown in personal consumption expenditures, and a sub-level decline in the inflation rate as key factors driving gold's

Gold futures contracts for February delivery climbed by 1.6 percent to \$2,089 per ounce, while the US dollar index, measuring the currency against major counterparts, dropped

by 0.35 percent to reach 103.1 points. Analysts' pessimistic outlook on US spending and production growth for the coming year prompted investors to seek refuge in gold.

Al-Fadhli highlighted expectations of a 25 basis points interest rate reduction by the Federal Reserve in March 2024, predicting "significant rises" in gold prices if the central bank implements a total reduction of 135 basis points by the end of the

Rail union: Lay-off jeopardizes safety

The head of the union that represents track maintenance workers says Union Pacific is jeopardizing safety by delaying nearly 1,200 planned projects until next year and laying off more than 1,000 workers, but the railroad says the seasonal move shouldn't be alarming. The president of the Brotherhood of Maintenance of Way Employes Division union has been sending letters to regulators for more than a month raising concerns about the layoffs, but the the Surface Transportation Board hasn't intervened.

"Chaos and disruption with Union Pacific's Maintenance of Way forces can only lead to one outcome - deferred maintenance and catastrophic outcomes," Tony Cardwell, who leads the union, said in his letters. "These furloughs will affect the safety of Union Pacific operations and pose serious safety risks for the general public and the communities surrounding Union Pacific's

infrastructure. Union Pacific said the decision to delay these projects is a reflection of the fact that the railroad went over budget after dealing with several unexpected weather events like the tropical storm that hit California this year and last summer's extreme heat. The railroad said it remains committed to safety and improving its track network across the western U.S. (AP)

Chinese developer Evergrande risking liquidation

A Hong Kong court will convene a hearing Monday on troubled Chinese property developer Evergrande's plans for restructuring its more than \$300 billion in debts and staving off liquidation.

The company, the world's most indebted property developer, ran into trouble when Chinese regulators cracked down on excessive borrowing in the real estate sector. Last month, the company said Chinese police were investigating Evergrande's chairman, Hui Ka Yan, for unspecified suspected crimes in the latest obstacle to the company's efforts to resolve its financial woes.

The Hong Kong High Court has postponed the hearing over Ever-grande's potential liquidation several times. Judge Linda Chan said in October that Monday's hearing would be the last before a decision is handed down.

Evergrande could be ordered

to liquidate if the plan is rejected by its creditors.

In September, Evergrande abandoned its initial debt restructuring plan after authorities banned it from issuing new dollar bonds, which was a key part of its plan. The company first defaulted on its financial obligations in 2021, just over a year after Beijing clamped down on lending to property developers in an effort to cool a property bubble. (AP)

Company sees arrival of higher margin models

GM believes it will start making money on EVs in 2025

DETROIT, Dec 3, (AP): General Motors is losing money on every electric vehicle it sells, but the company says it's on track to generate mid single-digit pretax profit margins in 2025 as it produces more higher margin EVs, works out kinks in battery manufacturing, and sees battery cost reductions.

That's what Chief Financial Officer Paul Jacobson told analysts at a Barclays conference in New York on Thursday, conceding that the company has struggled to ramp up electric vehicle manufacturing. "While the ramp has been a little bit bumpy, we have worked through that," he said.

Specifically, the company has had trouble with machinery that stacks battery cells into modules at its assembly plants after the cells are produced at a battery plant near Warren, Ohio, a joint venture with LG Energy Solution of

Jacobson said current margins on electric vehicles are "substantially negative" as the company builds battery plants, retools factories and then underutilizes them as EV production and demand grow.

Demand

While the rate of electric vehicle sales growth has slowed in the U.S. this year, Jacobson said demand continues to rise. The company still plans to build factory capacity to manufacture 1 million EVs per year by the end of 2025, but it won't make all of them if the demand isn't there. "I don't want to stuff vehicles into a market that doesn't want them," he said, adding that GM also doesn't want to sell EVs at big discounts.

The growth of U.S. electric vehicle sales has slowed sharply since last year.

In June 2022, EV sales were growing about 90% year over year. By June of this year the 12-month growth rate had slowed to about 50%, and it remained there at the end of October. Automakers have become increasingly fearful that the pace may weaken further due to consumer concerns about high prices, a lack of charging stations and whether they will run out of juice.

GM is rolling out a series of electric SUVs including an Chevrolet Equinox with a starting price of close to \$30,000, as well as a Chevy Silverado EV pickup truck, GMC Hummer EVs and some Cadillac SUVs. It also plans to come out with a new version of the Chevrolet Bolt in 2025.

The company expects to make the EVs profitable by spreading costs over more vehicles as sales increase, by selling more higher-cost/higher profit EVs, and with battery cost savings, Jacobson said.

Shares of GM, which on Wednesday announced a \$10 billion stock buyback program and a 33% dividend increase, rose about 1% to \$31.82 Thursday.

Role in global warming

US admin targets oil & gas industry

WASHINGTON, Dec 3, (AP): The Biden administration on Saturday issued a final rule aimed at reducing methane emissions, targeting the U.S. oil and natural gas industry for its role in global warming as President Joe Biden seeks to advance his climate legacy.

The Environmental Protection Agency said the rule will sharply reduce methane and other harmful air pollutants generated by the oil and gas industry, promote use of cuttingedge methane detection technologies and deliver significant public health benefits in the form of reduced hospital visits, lost school days and even deaths. Air pollution from oil and gas operations can cause cancer, harm the nervous and respiratory systems and contribute to birth defects.

EPA Administrator Michael Regan and White House climate adviser Ali Zaidi announced the final rule at the U.N. climate conference in the United Arab Emirates, Separately, the president of the climate summit announced Saturday that 50 oil companies representing nearly half of global production have pledged to reach near-zero methane emissions and end routine flaring in their operations by 2030.

Vice President Kamala Harris, the top American representative at the summit, said the U.S. and other nations must act boldly to confront the fallout from climate change.

"The urgency of this moment is ear," Harris said. "The clock is no longer just ticking. It is banging. And we must make up for lost time.

The U.S. rule on methane emissions is part of a broader effort by the Biden administration that includes financial incentives to buy electric vehicles and upgrade infrastructure - spending that Harris said will total roughly \$1 trillion over 10 years.

Oil and gas operations are the largest industrial source of methane, the main component in natural gas and far more potent than carbon dioxide in the short term. It is responsible for about one-third of planet-warming greenhouse gas emissions. Sharp cuts in methane emissions are a global priority to slow the rate of climate change and are a major topic at the conference, known as COP28.

Presidents, prime ministers and royals from nations rich and poor have vowed to reduce how much their countries spew heat-trapping gases and asked their colleagues to do better.

"On Day One, President Biden restored America's critical role as the global leader in confronting climate change," Regan said, referring to Biden's actions returning the U.S. to the Paris climate agreement and ordering an immediate review of environmental regulations rolled back by the previous administration.

The methane rule finalizes a proposal Biden made at a UN climate conference in Scotland in 2021 and expanded a year later at a climate conference in Egypt. It targets emissions from existing oil and gas wells nationwide, rather than focusing only on new wells, as previous EPA regulations have done. It also regulates smaller wells that will be required to find and plug methane leaks. Such wells currently are subject to an initial inspection but are rarely checked again for leaks.

Studies have found that smaller wells produce just 6% of the nation's oil and gas but account for up to half the methane emissions from well sites.

The plan also will phase in a requirement for energy companies to eliminate routine flaring, or burning of natural gas that is produced by new oil wells. The new methane rule will help ensure that the United States meets a goal set by more than 100 nations to cut methane emissions by 30% by

2030 from 2020 levels, Regan said. The EPA rule is just one of more than 100 actions the Biden administration has taken to reduce methane emissions, Zaidi added. "From mobilizing billions in investment to plug orphaned wells, patch leaky pipes and reclaim abandoned mines, to setting strong standards that will cut pollution from the oil and gas sector, the Biden-Harris Administration is putting the full throw-weight of the federal government into slashing harmful methane pollution," he said.

Masdar to develop 150MW solar plant in Angola

DUBAI, United Arab Emirates, Dec. 3, (PRNewswire): Abu Dhabi Future Energy Company PJSC - Masdar, one of the world's leading renewable energy companies, has announced plans to develop a major 150 megawatt (MW) solar PV project in Angola to deliver renewable energy to 90,000 homes while creating hundreds of jobs, spurring economic growth, and cutting car-

As global leaders engaged in climate negotiations at the UN's climate change conference COP28 in Dubai, Masdar - the UAE's clean energy powerhouse - signed a concession agreement with Angola's Ministry of Energy and Water to build and operate the ground-mounted solar power project in the Quipungo region, Hulia province, southern Angola. The area enjoys strong solar irradiation levels but struggles with a lack of access to reliable electricity.

Energy insecurity remains one of the most significant constraints on Africa's development. In Angola, less than half of the population has access to electricity, that proportion falls even further in rural areas. This project will significantly support Angola's goal of increasing its national electrification rate to around 60 percent by 2025.

The agreement was signed by HE Joao Baptista Borges, Angola's Minister of Energy and Water and Masdar's Chief Executive Officer, Mohamed Jameel Al Ramahi.

HE Dr Sultan Al Jaber, UAE Minister of Industry and Advanced Technology, Chairman of Masdar and COP28 President, said: "Africa has what it takes to become the world's renewable energy powerhouse. At COP28 and beyond, we will continue to work with Africa for Africa. The UAE stands shoulder-to-shoulder with our friends in Africa as we strive to secure a just energy transition at this COP of action and COP for all. We are delighted to be moving forward with plans to build this solar power plant in Angola that will bring vital clean energy and jobs to communities. We look forward to developing this strong partnership with Angola as we work together to maximize the

country's huge clean energy potential." Mohamed Jameel Al Ramahi, Chief Executive Officer of Masdar, said: "Developing renewable energy capacity is the key to unlocking Africa's enormous economic potential, and Masdar is excited to be playing a major part in this effort. Masdar is the largest renewables energy company in Africa, through our platform Infinity Power. To accelerate a just energy transition, Masdar recently joined forces with Africa50, a pan-African infrastructure investment platform. Our mission is to fast-track and scale projects so we can deliver 10GW of clean energy in Africa by 2030. The solar plant will support homes and businesses to leapfrog from patchy, traditional-fuel powered electricity to accessing continuous clean energy. The project will boost the local economy too. Up to 600 jobs are expected to be created during the construction phase. Afterward, the supply of reliable, clean energy is expected to help grow sectors including agricul-

The solar project in Quipungo forms part of a wider commitment made by Masdar in January, during Abu Dhabi Sustainability Week 2023, to develop 5 gigawatts (GW) of renewable energy projects across Angola, Uganda and Zambia. The Agreements were signed under the umbrella of Etihad 7 - a global development fund launched by the UAE to provide 100 million people across the African continent with clean electricity by 2035.

In New Mexico, the route was modified after the U.S. Defense Department raised concerns about the effects of the high-voltage lines on radar systems and military training operations. Environmentalists also were worried about impacts on wildlife habitat and migratory bird flight patterns in the Rio Grande Valley.

There are similar ecological concerns in the San Pedro Valley. The transmission line is at the heart of a legal challenge pending before the Arizona Court of Appeals over whether state regulatory officials there properly considered the benefits and consequences of the project.



Farewell to reality: Kiss become first US band to go virtual

NEW YORK, Dec 3, (AP): On Saturday night, Kiss closed out the final performance of their "The End of the Road" farewell tour at New York City's famed Madison Square Garden.

But as dedicated fans surely know - they were never going to call it quits. Not really.

During their encore, the band's current lineup - founders Paul Stanley and Gene Simmons as well as guitarist Tommy Thayer and drummer Eric Singer - left the stage to reveal digital avatars of themselves. After the transformation, the virtual Kiss launched into a performance of "... Gave Rock and Roll to You."

The cutting-edge technology was used to tease a new chapter of the rock band: after 50 years of Kiss, the band is now interested in

a kind of digital immortality.

The avatars were created by George Lucas' special-effects company, Industrial Light & Magic, in partnership with Pophouse Entertainment Group, the latter of which was co-founded by ABBA's Björn Ulvaeus. The two companies recently teamed up for the "ABBA Voyage" show in London, in which fans could attend a full concert by the Swedish band - as performed by their digital avatars.

Per Sundin, CEO of Pophouse Entertainment, says this new technology allows Kiss to continue their legacy for "eternity." He says the band wasn't on stage during virtual performance because "that's the key thing," of the future-seeking technology. "Kiss could have a concert in three cities in the same night across three different continents. That's what you could do with this.'

In order to create their digital avatars, who are depicted as a kind of superhero version of the band, Kiss performed in motion capture

Experimentation with this kind of technology has become increasingly common in certain sections of the music industry. In October K-pop star Mark Tuan partnered with Soul Machines to create an autonomously automated "digital twin" called "Digital Mark." In doing so, Tuan became the first celebrity to attach their likeness to OpenAI's GPT integration, artificial intelligence technology that allows fans to engage in one-on-one conversations with Tuan's avatar.

Immortalized

Aespa, the K-pop girl group, frequently perform alongside their digital avatars - the quartet is meant to be viewed as an octet with digital twins. Another girl group, Eternity, is made up entirely of virtual characters - no humans necessary.

"What we've accomplished has been amazing, but it's not enough. The band deserves to live on because the band is bigger than we are," Kiss frontman Paul Stanley said in a roundtable interview. "It's exciting for us to go the next step and see Kiss immortalized.'

"We can be forever young and forever iconic by taking us to places we've never dreamed of before," Kiss bassist Gene Simmons added. "The technology is going to make Paul jump higher than he's ever done before.

And for those who couldn't make the Madison Square Garden show - stay tuned, because a Kiss avatar concert may very well be

MEXICO CITY: Nicaraguan police said Friday they want to arrest the director of the Miss Nicaragua pageant, accusing her of intentionally rigging contests so that antigovernment beauty queens would win the pageants as part of a plot to overthrow the government.

Miss Nicaragua, Nicaragua's Sheynnis Palacios won the Miss Universe competition. The government of President **Daniel Ortega** briefly thought it had scored a rare public relations victory, calling her win a moment of "legitimate joy and pride.

The protests were violently repressed, and human rights officials say 355 people were killed by government forces. Ortega claimed the protests were an attempted coup with foreign backing, aiming for his overthrow. His opponents said Nicaraguans were protesting his increasingly repressive rule and seemingly endless urge to hold on to power.

A statement by the National Police claimed Celebertti "participated actively, on the internet and in the streets in the terrorist actions of a failed coup," an apparent reference to the 2018 protests.

Celebertti apparently slipped through the hands of police after she was reportedly denied permission to enter the country a few days ago. But some local media reported that her son and husband had been taken into custody.

Celebertti, her husband and son face charges of "treason to the motherland." They have not spoken publicly about the charges

Popular in its own right, the novel has also served as the inspiration for a number of movies, including "Willy Wonka & The Chocolate Factory" - the classic 1971 movie starring the late Gene Wilder - a 2005 reboot starring Johnny Depp, and "Wonka," the 2023 version. As a child of the 1980s, I had voraciously consumed

Dahl's novels, so I knew the book well. But the illustrations in this particular edition looked unfamiliar. Once I brought the worn and tattered book home and began to read it aloud to my kids, I realized that some

passages looked unfamiliar as well. My voice faltered as the Oompa-Loompas - the pint-sized workers in Wonka's chocolate factory - appeared and Charlie asked, "Are they really made out of chocolate, Mr. Wonka?" To which Wonka replied: "Nonsense!" "They belong to a tribe of tiny miniature pygmies

known as Oompa-Loompas," Wonka explains in this version of the book. "I discovered them myself. I brought them over from Africa myself - the whole tribe of them, three thousand in all. I found them in the very deepest and darkest part of the African jungle where no white man had ever been before.

The accompanying black-and-white illustration of several dark-skinned Oompa-Loompas left me stunned. Dahl's book is part of a long history of children's books that feature racist stereotypes - a list that includes six Dr. Seuss books that were removed from publication in 2021. Other children's classics, such as "Peter Pan" and "Mary Poppins," have also been criticized for perpetuating racism.

As an English lecturer who specializes in decoding some of the hidden meanings and dark realities in popular children's stories, I looked deeper into the blatant racism in the 1964 edition of "Charlie and the Chocolate

Factory," comparing it to a more recent copy from 2011. Notably, the description of the Oompa-Loompa's skin had been changed from "almost black" to "rosywhite." And rather than coming from Africa, they came from "Loompaland." I learned that these changes were made by Dahl for the 1974 edition after criticism by the NAACP and others. Dahl's response was to remove the

Black characters altogether. Yet as philosophy lecturer Ron Novy points out, even the latest editions of the book still perpetuate racist and imperialist ideologies.

When Wonka describes how he "smuggled" the Oompa-Loompas into the country in "large packing cases with holes in them," the image clearly recalls slave ships navigating the Middle Passage. Wonka's promise to pay the Oompa-Loompas' wages in cacao beans, and the admission that no one ever sees them come in or out of the factory, reinforces the Oompa-Loompas' subjugation to Willy Wonka, who plays the role of their "Great White Father," as fourth grade reading teacher Katherine Baxter noted in 1974.

Revised

Historian Donald Yacovone has pointed out that, even in its revised form, "Charlie and the Chocolate Factory" has long contributed to the perpetuation of white supremacist ideology. Not only do the Oompa-Loompas immediately appear - ready to obey - whenever Wonka clicks his fingers, but Wonka is also repeatedly dismissive of them. He calls them "charming" but tells his visitors not to believe a word the Oompa-Loompas say. "It's all nonsense, every bit of it!"

Wonka even uses the Oompa-Loompas as experimental subjects. He feeds them gum that turns them into blueberries and fizzy drinks that send one unfortunate man aloft until he "disappeared out of sight" and was never seen again. These experiments seem a grotesque parody of the myriad cases of enslaved and free Black Americans who have been subjected to experimental surgeries, treatments and medical neglect.

In both the book's current version and in the origi-

nal, he smuggles them into his factory and pays them in cacao beans because they were "practically starving to death" and cacao was "the one food that they longed for more than any other ... but they couldn't get it" on their own.

It's an absurd assertion that this community of people, originally located in the heart of Africa, cannot access a crop that, while native to the Amazon, is primarily grown in West African countries. That they need Wonka to give them access to the resources of their own land is a damaging colonialist fantasy - one which, as Yacovone notes, has historically buoyed, rather than diminished, the popularity of the novel and the 1971 and 2005 films.

Unfortunately, the latest Wonka movie also engages in the type of implicit racism that remains in the revised 1974 version of the novel. The most prominent Black character, a girl named Noodle, played by the talented Calah Lane, takes a back seat to Wonka in the major events of the film.

The new Wonka almost broke from the tradition of having Wonka played by white men. Early in the new film's conception, Newsweek reported that actor, comedian and musician Donald Glover was under consideration for the lead role, a choice that could have at least begun to force a rewrite of the original novel's racist

narrative. Instead, the film casts Noodle in the position of an unfortunate Black girl who can only hope for a ride on

Wonka's velvet coattails. "I know things haven't been easy for you," Wonka says in the movie. "They're going to get better."

'You promise?" Noodle replies, hopefully, and he does promise, highlighting his role as her white savior. Another character in voice-over agrees: "You could

change her life, Mr. Wonka. Change all their lives." I was initially hopeful about the prospect of a movie that moves away from the novel's racist origins, yet still imparts the power of imagination on a new generation. Unfortunately, moviegoers may find themselves having to hold their breath and make a wish, as Gene Wilder

stated in a song from the 1971 movie, for a version that holds no remnants of its racist past. (AP)

New twist in 'Mutts'

'Eyeliner' chronicles defiance and beauty

NEW YORK, Dec 3, (AP): Zahra Hankir opens "Eyeliner: A Cultural History" by marveling over her mother's elegant beauty process as she delicately sweeps black kohl on her waterline, dreaming of displaying that same confidence one day.

For Hankir, eyeliner is more than just a cosmetic product. It provides protection and empowerment. It provides cultural connection. It exists beyond borders, gender roles and Western beauty standards. Lining one's waterline or drawing a delicate black line across an eyelid is more than aesthetics. For many of the underrepresented groups and communities of color highlighted in Hankir's book, applying the product is a ritual deeply rooted in



spirituality, culture, identity and more. To loosely quote Audre Lorde, if self-care is an act of resistance, then an eyeliner is a tool in the rebellion throughout Hankir's novel.

The Lebanese-British jour-nalist seamlessly takes her readers on a global investigation of how the cosmetic product is used worldwide. Through intimate narratives with varied characters from

different cultures and communities, we learn more about the product's rise in prominence while having a fly-on-the-wall inside look at the ways it serves medicinal purposes, fuels spiritual practices, uplifts selfexpression and how its mere existence on someone's eyelid can be viewed as a form of defiance.

Hankir begins this thoroughly researched journey by educating her readers on Egypt's Queen Nefertiti and her rise as a symbol of "ideal feminine beau-ty." The Egyptian queen posthumously influenced mainstream culture, leading eventually to the beauty item's spot in shopping mall stores and in makeup ads across Western society. But while detailing Nefertiti's legacy, Hankir does not shy away from reflecting on how the queen's thick-lined trademark became twisted and co-opted by white Western culture. She addresses it head-on and shares the complete history of its popularity. All of the good and the bad that follows popularity.

Information

The book is a little over 300 pages long and packs enough information for readers to walk away with more in-depth knowledge of the staple product sitting idly inside their makeup bag. As readers twist open their liner applicator, they'll be reminded of the Wodaabe men who wear kohl to enhance their appearance and attract a partner in a ritual ceremony. They'll think of artists like Shirin Neshat, who wear the item as a form of solidarity for the women back home who cannot publicly line their eyes. They'll remember the drag queens who drew on their bold, exaggerated liner as they prepared to perform and the stories of the Cholas in Mexican-American culture who wore the product, expressing their dual femininity and strength.

"Eyeliner" comes full circle, highlighting today's beauty influencers and allowing viewers to see the ripple effects of popularity and cultural exchange as this one beauty product carries the constant line of simultaneously emphasizing the beauty and power each person possesses as they line their eyes and prepare to embark on their personal journeys.

Something is different on the comics pages this week. In the panels of "Mutts," there's the longdelayed sight of freedom.

Patrick McDonnell, the cartoonist who draws the popular strip, is freeing his character Guard Dog, liberating an animal who has become for decades a symbol of the cruelty of dog chaining.

"I think it just hit me that I can't do it forever and that it has to happen," McDonnell told The Associated Press ahead of the publication of Thursday's panel showing Earl's owner kneeling beside the dog and announcing: "We have to remove this chain." On Friday's strip, it will be gone.

"I had a vague idea what the story was going to be, but I finally took some time and said, 'Well, what is that story?' And I was happy with what I came up with. So I said, 'Now's the time to do it.'

"Mutts" premiered in 1995 with two heroes - the small canine Earl and the feline Mooch, fond of saying "Yesh." There's also Woolfie, Sid the fish, Crabby, Sourpuss and Butchie, the ever-vigilant owner of the Fatty Snax Deli.

Character

Guard Dog was added about a year after launch as McDonnell explored the idea of having an antagonist for his heroes.

"I started in my sketchbooks drawing a tough dog," he says. "I drew a big gruff dog and I put a studded collar on him. And then I drew a chain. And when I did that, it changed everything. I realized that it wasn't a villain. It was a tragic character."

For years, Guard Dog sat in the unmowed grass of a neighborhood lawn or howled at the moon, alone and philosophical. In one strip he holds a piece of paper that reads "Guard Dog's To Do List" with only one item: "Remind people of man's inhumanities.

Doozy, a neighborhood girl, regularly visits the mutt on her way to and from school, bringing something to brighten his day: an umbrella, treats, a hug, a kind word and a reminder that he isn't alone. One frigid night, he was shivering and she brought a blanket and a kiss.

Fans of Guard Dog would regularly plead with Mc-Donnell to free the mutt but the artist was also lobbied by animal welfare groups to keep the dog chained as a way to increase the spotlight on the issue.

"I always felt like, 'Geez, if I inspired even one family to bring the dog in the house, that it was worth doing. I know it was tough on the readers and it was tough on Guard Dog," he said.

"You know, whenever I drew him in my sketchbooks or if I did a talk, I always drew Guard Dog free. So part of me felt like he was an actor playing a part.'

In the lead-up to Guard Dog's freedom, McDonnell crafted a multi-comic seven-week storyline in which the owner of Guard Dog moves away, leaving the dog utterly alone. The other animals and kids rally to save him.

'Killers of the Flower Moon' named best film by NY film critics

Martin Scorsese's "Killers of the Flower Moon" has been named the best film of the year by the New York Film Critics Circle.

It's the third time that Scorsese has been given the best film award from his hometown's critics, who named 1990's "GoodFellas" their top movie, as well as 2019's "The Irishman." On Thursday, the group also awarded Lily Gladstone, who stars alongside Leonardo DiCaprio in "Killers of the Flower Moon," best actress

"Killers of the Flower Moon," a \$200 million Apple Studios production based on David Grann's nonfiction bestseller, chronicles the Osage murders of the 1920s.

"Oppenheimer," Christopher Nolan's blockbuster drama about J. Robert Oppenheimer and the Manhattan Project, picked up several awards: best director for Nolan and best cinematography, by Hoyte van Hoytema.

The New York Film Critics Circle, founded in 1935, is the oldest critics group in the country. The awards will be handed out at a dinner on Jan. 3. Last year, the critics named Todd Field's "Tár" the best film of 2022.

MILAN: Italy's culture minister is reportedly refusing a request by the German State Antiquities Collection in Munich to return an ancient Roman statue that embodied Hitler's Aryan aesthetic, calling it a national treasure.

The Discobolus Palombara is a 2nd Century Roman copy of a long-lost Greek bronze original. Hitler had bought the Roman copy from its private Italian owner in 1938 under pressure from Italian dictator Benito Mussolini and against the wishes of the education minister and cultural officials. The statue, unearthed at a Roman villa in 1781, was returned to Italy in 1948 as part of works illegally obtained by the

The dispute arose when the director of the National Roman Museum requested the statue's 17th Century marble base be returned from the Antikensammlungen state antiquities collection. The German museum instead asked for the return of the Discobolus Palombara, saying it had been illegally transported to Italy in 1948, the Corriere della Sera newspaper reported Friday.

Italy's culture minister, Gennaro Sangiuliano, expressed doubts that the German culture minister, Claudia Roth, was aware of the Bavarian request.

"Over my dead body. The work absolutely must remain in Italy because it is a national treasure," Sangiuliano was quoted

R&B singer takes back control in music and life

Ledé on healing through music

NEW YORK, Dec 3, (AP): Kiana Ledé is one of R&B's brightest rising stars but that doesn't mean she always embraces the compliment.

"I kind of have mixed feelings about because it gets me in my head about me needing to do more or me being more invested in my craft, or I just don't have the right (industry) politics surrounding me," said Ledé, who's launching the international leg of her "Grudges" tour Tuesday starting in Auckland, New Zealand. "(But) it also makes me feel great because they're clearly appreciating me and understanding that I do this for healing purposes and that the music is just good."

It's a pivotal moment in the career of the 26-year-old songstress whose upcoming tour stops include London, Paris, Sydney and Berlin. Ledé, who wrapped up her 21-date North American tour in October and recently parted ways with her record label, Republic, has built a loyal fanbase and respect from industry contemporaries. But she doesn't always garner the same attention as some of the leading ladies of

R&B's new generation. "I probably get at least four tweets every day with my name mentioned next to 'underrated'...that is a constant conversation that people have about me," said Ledé.

Album

Crafting popular songs like "Wicked Games "and "EX," which reached No. 9 on Billboard's hot R&B songs chart, the Phoenix-raised artist released her sophomore album, "Grudges," during the summer. The 17-track project has features from Bryson Tiller, Khalid and Ella Mai, and is executive produced by Nija Charles who scored a non-classical songwriter of the year Grammy nomination for her work on Beyoncé's "Renaissance."

'Grudges" follows Ledé's critically-acclaimed debut, "Kiki," which reached No. 30 on the Billboard 200 and No. 7 on the top R&B album charts. Her latest work unabashedly recounts her experiences with love and unhealthy relationships, a musical composite sometimes referred to as an unofficial genre, toxic R&B.

"Grudges,' I think, is...me just being able to be honest about what I was going through in that moment, knowing that it's healthy and okay to be upset," said Ledé, who has writing cred-

its on every track. "I've been so happy with the response to 'Grudges'....l always say this almost every show, I have two goals: to make you twerk and to make you cry."

Part of what draws whose previous collaborations include with Usher, Kehlani and Offset, is a combination of raw transparency and skilled writing, conveying sensitive emotions through the music

"It's her being so relatable and being so real...I feel like a lot of artists are robots - artists are just moving on what people are telling them to do," said Christine Sanchez, Ledé's manager. "We've all been in a place where we've just been bitter after a relationship. But for someone to acknowledge it and be so honest about it, you're just like, wow, OK, I see myself in her.

Session

While Ledé introduced the album with the Ella Mai-assisted "Jealous" and the sultry track "Deeper," songs like "Same Type" highlight her vulnerability, as she laments about significant men in her life, including her father, all being the same type and the emotional scars they've caused. And on "Deserve," Ledé addresses being sexually assaulted.

"I remember crying almost that whole session... I needed to help myself heal from that situation because that was about me being raped a few years before," recalled Ledé. "There's some people I told about that experience that either didn't believe me or never went through it, so they didn't really empathize or sympathize. And with...almost every person in that room being a woman, I felt so heard and seen and loved."

Ledé says she's been working to heal from painful experiences from her

"There's still a lot of ways it affects me to this day...most of my sexual experiences have been traumatic," revealed the singer. "But I'm a lot more balanced and healed than I was even six months ago, a year ago. So, I think over time, it gets a little bit quicker but I also have a great therapist.'

Ledé first experienced depression at age 12 and was diagnosed with bipolar disorder during the coronavirus pandemic. The singer, who has Black, Native American, Mexican and white heritage, initially rejected the diagno-

sis, saying "she was a white therapist, so I didn't trust her with half the stuff that I was telling her about," sharing the mistrust many people of color have toward medical professionals. Actor Jennifer Lewis, who has bipolar disorder, also hinted to Ledé that she might have the same mental health issue, but it wasn't until Ledé found a Black female therapist that she accepted it.

"The way that she said it just felt so gentle...she showed me basically a road map of how I can feel more healthy mentally, and how I didn't have to struggle as much as I was," said Ledé as tears formed in her eyes.

Describing her sound as alternative R&B, Ledé grew up listening to an eclectic mix of musicians. Citing Alicia Keys as a significant inspiration, she was also influenced by artists such as Ne-Yo, Ryan Leslie, Mariah Carey and Whitney Houston, along with pop and alternative acts like The Spice Girls, Justin Timberlake, John Mayer and Sara Bareilles.

Record

Ledé's entrance into the music industry began at 14 after she won KIDZ Star in 2011, the annual Kidz Bop talent contest. That led to a record deal with RCA, and at 21, she joined Republic Records. In addition to her two studio albums, Ledé has released several EPs, including 2018's "Selfless" which birthed "EX" and "Wicked Games." She's also an actor, securing roles on "Scream: The TV Series" and "All About the Washingtons."

While "Grudges" hasn't garnered the commercial success of "Kiki," Ledé has been taking back control of her life in all aspects, and her manager says momentum is moving in the right direction.

"The music's always been her, but as far as putting it out into the world, it's always been a bunch of people helping... kind of really (being) told what to do. And ("Grudges") was taking control back," said Sanchez, who understands Ledé's apprehension over the underrated title. "Nobody needs to change her. We just need to amplify her, and that's the next step...her moment is coming.'

Ledé is also optimistic about her future, both in her career and personal life, but she's also laser-focused on the present - and that includes connecting with those who love her music the most, at home and abroad.



World's top flyer faces radiation equivalent to 1,000 chest X-rays

Air travel exposes you to radiation – and cancer risk

In 2017, business traveler Tom Stuker was hailed as the world's most frequent flyer, logging 18,000,000 miles of air travel on United Airlines over 14 years.

That's a lot of time up in the air. If Stuker's traveling behaviors are typical of other business flyers, he may have eaten 6,500 inflight meals, drunk 5,250 alcoholic beverages, watched thousands of inflight movies and made around 10,000 visits to airplane toilets.

He would also have accumulated a radiation dose equivalent to about 1,000 chest x-rays. But what kind of health risk does all that radiation actually pose?

You might guess that a frequent flyer's radiation dose is coming from the airport security checkpoints, with their whole-body scanners and baggage x-ray machines, but you'd be wrong. The radiation doses to passengers from these security procedures are trivial.

The major source of radiation exposure from air travel comes from the flight itself. This is because at high altitude the air gets thinner. The farther you go from the Earth's surface, the fewer molecules of gas there are per volume of space. Thinner air thus means fewer molecules to deflect incoming cosmic rays - radiation from outer space. With less atmospheric shielding, there is more exposure to radiation.

The most extreme situation is for astronauts who travel entirely outside of the Earth's atmosphere and enjoy none of its protective shielding. Consequently, they receive high radiation doses. In fact, it is the accumulation of radiation dose that is the limiting factor for the maximum length of manned space flights. Too long in space and astronauts risk cataracts, cancer and potential heart ailments when they get back home.

Indeed, it's the radiation dose problem that is a major spoiler for Elon Musk's goal of inhabiting Mars. An extended stay on Mars, with its extremely thin atmosphere, would be lethal due to the high radiation doses, notwithstanding Matt Damon's successful Mars colonization in the movie "The Martian."

Cumulative

What would be Stuker's cumulative radiation dose and what are his health risks?

It depends entirely on how much time he has spent in the air. Assuming an average flight speed (550 mph), Stuker's 18,000,000 miles would translate into 32,727 hours (3.7 years) of flight time. The radiation dose rate at typical commercial airline flight altitude (35,000 feet) is about 0.003 millisieverts per hour. (As I explain in my book "Strange Glow: The Story of Radiation," a millisievert or mSv is a unit of radiation dose that can be used to estimate cancer risk.) By multiplying the dose rate by the hours of flight time, we can see that Stuker has earned himself about 100 mSv of radiation dose, in addition to a lot of free airline tickets. But what does that mean for his health?

The primary health threat at this dose level is an increased risk of some type of cancer later in life. Studies of atomic bomb victims, nuclear workers and medical radiation patients have allowed scientists to estimate the cancer risk for any particular radiation dose.

All else being equal and assuming that low doses have risk levels proportionate to high doses, then an overall cancer risk rate of 0.005 percent per mSv is a reasonable and commonly used estimate. Thus, Stuker's 100-mSv dose would increase his lifetime risk of contracting a potentially fatal cancer by about 0.5 percent.

The question then becomes whether that's a high level of risk. Your own feeling might depend on how you see your background can-

Most people underestimate their personal risk of dying from cancer. Although the exact number is debatable, it's fair to say that about 25 percent of men ultimately contract a potentially fatal cancer. Stuker's 0.5 percent cancer risk from radiation should be added to his baseline risk so it would go from 25 percent to 25.5 percent. A cancer risk increase of that size is too small to actually measure in any scientific way, so it must remain a theoretical increase in risk.

Cancer

A 0.5 percent increase in risk is the same as one chance in 200 of getting cancer. In other words, if 200 male travelers logged 18,000,000 miles of air travel, like Stuker did, we might expect just one of them to contract a cancer thanks to his flight time. The other 199 travelers would suffer no health effects. So the chances that Stuker is the specific 18-millionmile traveler who would be so unlucky is quite small.

Stuker was logging more air hours per year (greater than 2,000) than most pilots typically log (under 1,000). So these airline workers would have risk levels proportionately lower than Stuker's. But what about you?

If you want to know your personal cancer risk from flying, estimate all of your commercial airline miles over the years. Assuming that the values and parameters for speed, radiation dose and risk stated above for Stuker are also true for you, dividing your total miles by 3,700,000,000 will give your approximate odds of getting cancer from your flying time.

For example, let's pretend that you have a mathematically convenient 370,000 total flying miles. That would mean 370,000 miles divided by 3,700,000,000, which comes out to be 1/10,000 odds of contracting cancer (or a 0.01 percent increase in risk). Most people do not fly 370,000 miles (equal to 150 flights from Los Angeles to New York) within their lifetimes. So for the average flyer, the increased risk is far less than 0.01

To make your exercise complete, make a list of all the benefits that you've derived from your air travel over your lifetime (job opportunities, vacation travel, family visits and so on) and go back and look at your increased cancer risk again. If you think your benefits have been meager compared to your elevated cancer risk, maybe its time to rethink flying. But for many people today, flying is a necessity of life, and the small elevated cancer risk is worth the price. (AP)

A researcher's prescription for better health care

'Inject humility into medical practice'

Better health care for patients begins with humility - a term not often associated with medicine.

I witnessed displays of humility firsthand eight years ago, the night my son was born, in the way the doctor and doula worked together to deliver our baby.

Neither tried to assert dominance over the other. Instead, they openly communicated with each other, respected each other's roles, trusted each other and worked as a team. And what was most meaningful to us - they included my wife on that team by actively listening to her and putting her needs at the forefront.

Together, the team's professional humility helped create the most unforgettable moment of our lives: the birth of a healthy baby boy.

Our experience with them made a significant impression on me because I'm a social scientist who studies how clinicians collaborate. Specifically, I explore how doctors, nurses and the entire health care team can better show professional humility to ensure better outcomes for patients and for health care work-

Support

Put simply, professional humility in the health care setting is when doctors, nurses, physician assistants, pharmacists, physical therapists, support staff - basically every health care provider - see each other as playing on the same team.

That means team members share the same goals, understand the limitations of their own profession, see the strengths offered by others and include the patient and their caregivers in decision-making.

That willingness to make the patient part of the team is key to professional humility. Instead of talking about the patient among themselves, the providers address the patient directly and actively listen. They openly admit when they don't know the answer or if they were incorrect. And rather than talking down to the patient, they explain things calmly, using everyday language and avoiding arcane medi-

A growing body of research demonstrates that clinicians' humility positively affects patient satisfaction, health outcomes and overall care. Additionally, emerging evidence indicates that having humility is good for health care providers as well - serving as a protective factor against burnout and even clinical un-

But if humility is so beneficial, why isn't there more of it in health care? And why is it not formally taught in medical, nursing and other health profession schools?

Most people have likely experienced or witnessed scenarios where clinicians exhibit the opposite of humility, such as when providers show open disrespect for each other or engage in power struggles, or when a patient feels ignored, rushed, dismissed or spoken to rudely. Democratic Gov. Gavin Newsom, is part of a massive push to address the homelessness crisis in California. It empowers family members and first responders to file a petition on behalf of an adult they believe "is unlikely to survive safely" without supervision and whose condition is rapidly deteriorating. They also can file if an adult needs services and support to prevent relapse or deterioration that would likely result in "grave disability or serious harm" to themselves or others.

A special civil court in each county reviews each petition to determine eligibility before asking the individual to participate in a voluntary plan that includes housing, medication, counseling and other social services. If all parties cannot agree to a voluntary plan, the statute says the court will order they work on a plan. Among the ongoing petitions, some have entered the court process and are working on creating their care plans, while other referrals are still being reviewed, Ghaly said. Some cases have also been dismissed, the Los Angeles Times reported.

is home to more than 171,000 homeless people - about 30% of the nation's homeless population. But critics worried the program will be ineffective and punitive because it could coerce people into treatment.

The administration didn't give specific data on the number of petitions submitted in each county. San Francisco, Orange, San Diego, Riverside, Stanislaus, Tuolumne and Glenn counties launched the court Oct. 1, with Los Angeles County beginning its program Friday. The rest of the state has until December 2024 to establish mental health courts.

Counties are trying different approaches to implementation. San Diego County is integrating CARE Court with its conservatorship system to help divert people off of conservatorships, while Orange County is moving the mental health court away from the typical courtrooms and into community spaces, Ghaly said.

"I'm pretty pleased with the level of engagement, the level of partnership, the level of, you know, belief and optimism that's growing in our counties," he said.

Representatives from Disability Rights California, a nonprofit that sued the state arguing the program would violate due process and equal protection rights under the state constitution, said CARE Court could result in unintended consequences.

"While officials express optimism, the rushed implementation may overlook critical aspects of community engagement and careful consideration," said community organizer Vanessa

Newsom signed a law in October to expand the definition of "gravely disabled" to include people who are unable to provide themselves basic needs such as food and shelter due to an untreated mental illness or unhealthy drugs and alcohol use, which makes it easier for authorities to compel treatment.

"rank" by collectively assessing the wound, openly seeking their colleagues' opinions and engaging me directly about possible next steps - all while jokingly noting the serendipity of the situation - clearly reflected professional humility.

Researchers are just starting to scratch the surface of understanding precisely how professional humility leads to teamwork and more effective care. But the early research suggests that it's an essential ingredient.

If you do find yourself or a loved one in the hospital, you may be confronted with hard decisions and frightening uncertainties about the future. When that happens, you will no doubt want a health care team that is harmonious, communicative and connected. That sense of calm in the chaos provides patients and family with reassurance, hope and healing.



Brignone wins World Cup giant slalom

TREMBLANT, Quebec, Dec 3, (AP): Federica Brignone of Italy picked up her first World Cup victory in two seasons by winning a women's giant slalom on Saturday. Mikaela

Shiffrin finished in third place.

Brignone covered the two legs on foggy Mont Tremblant - which hadn't hosted a World Cup ski race in 40 years - in a combined time of 2 minute, 14.95 seconds. Petra Vlhova of Slovakia was second fastest in 2:15.16, followed by overall World Cup leader Shiffrin in 2:15.24.

SKIING

Shiffrin was denied what would have been a record-extending 91st career World Cup win.

Brignone had the quickest opening leg in the morning and held on for the win with the third-best run in the afternoon. The only better second legs were turned in by Vlhova and Shiffrin.

Sara Hector of Sweden was second fastest in the first run but faded to fourth, and Lara Gut-Behrami of Switzerland went from third place to fifth.

Brignone was the 2020 World Cup overall champion and the silver medalist in the giant slalom at last year's Beijing Olympics, behind Hector. Gut-Behrami took the bronze at the Winter Games.

Gut-Behrami was seeking a third consecutive GS win to start the season after coming in first in the

season-opening race in Austria in October - where Brignone was the runner-up - and at Killington, Vermont, last weekend.

Shiffin won the GS season title last season while setting the record for most career wins in the discipline with 21. She finished sixth in this season's opener, then was third in Killington.

Michigan blanks Iowa in Big Ten championship game

ATLANTA, Dec 3, (AP): Alabama is again the top dog in the Southeastern **Conference - and perhaps** headed to the College Football Playoff - after ending Georgia's 29-game winning streak with a 27-24 victory over the No. 1 Bulldogs in the SEC championship game Saturday.

Now, the big question: Is Georgia's bid for a third straight national title


Georgia closed the gap to 20-17 after a 28-yard punt return by Anthony Evans III set up Carson Beck's sneak into the end zone.





LAFC to play for back-to-back MLS Cup titles after beating Houston in West final

LOS ANGELES, Dec 3, (AP): After the longest season in Major League Soccer history, Los Angeles FC still has one more week of work to do.

If the club completes its final assignment as well as it handled Saturday night, the reward will be historic.

Ryan Hollingshead scored late in the first half and defending champion LAFC advanced to its second straight MLS Cup Final with a 2-0 victory over the Houston Dynamo

Houston's Franco Escobar scored an own goal in the 80th minute to seal the Western Conference Final for LAFC, which will travel to Columbus next weekend to play for the title. The Crew beat FC Cincinnati 3-2 in a thriller.

LAFC, an expansion club in its sixth year of competition, has the chance to become MLS' first back-to-back

SOCCER

champions since the LA Galaxy (2011-12). LAFC never faded or wilted in its 52nd match of 2023 - an MLS record for games in a calendar year, thanks to the club's competition in several nonleague tournaments.

Maxime Crépeau made five saves in his third consecutive shutout for LAFC, which hasn't allowed a goal since October. An offensive powerhouse since the club's inception, LAFC is looking more like a dominant defensive team over the last several weeks.

Although Houston had more than 70% possession, the LAFC defense led by Giorgio Chiellini and Diego Palacios frustrated the Dynamo, whose ninegame winning streak ended just shy of the franchise's first MLS Cup Final since 2012.

The Black and Gold have reached the brink of a second straight title despite their heavy workload and despite losing several key players from last season's championship team, including high-scoring Chicho Arango and the retired Gareth Bale.

LAFC's home finale felt momentous for reasons beyond the win.

Escobar, who played 19 games for LAFC last season, grabbed his head in his hands while his teammates attempted to boost his spirits after the crushing

Germany open against Scotland

'Titleholders' Italy join Spain and Croatia in tough group at Euro '24

HAMBURG, Germany, Dec 3, (AP): Italy and Spain will add to their storied European Championship rivalry next year, after the defending champions and two-time recent winners were drawn together in a tough group with World Cup semifinalists Croatia and

Euro 2020 winners Italy fulfilled predictions as the most difficult and dramatic option to come from the pot of lowest-ranked teams at the back end of a draw ceremony that was pranked by a British social media comedian as its name was called.

Italy beat Spain in the semifinals to win their European title, and the winning back-to-back titles in 2008 and 2012, including a 4-0 rout in the final nine years ago in Kyiv, Ukraine.

"It is surely the most difficult group," said Croatia coach Zlatko Dalić, whose team went deep at the past two World Cups despite hard

The draw ensured the other Euro 2020 semifinal also will be a rematch in Germany next year. England will again face Denmark, which they beat to reach the final. Their group also includes Slovenia and Serbia.

France, the World Cup finalists a year ago, were drawn with Austria, the Netherlands and the winners of a playoff bracket in March involving Poland, Estonia, Wales and Finland. Kylian Mbappé scored twice in each of France's home and away wins over the Dutch in their qualifying group this year.

Germany, on a run of poor results, will open their home tournament against Scotland on June 14 at Bayern Munich's stadium. The group includes Hungary and Switzerland.

Germany lost six of their 13 friendlies this year and will not play a competitive game until facing Scotland to start the month-long tournament.

Portugal, still led by Cristiano Ronaldo, were the only team to come through qualifying groups with a perfect winning record and will play Turkey, the Czech Republic and the playoff winners from Georgia, Luxembourg, Euro 2004 champion Greece, and Kazakhstan. Ronaldo will be 39 when Euro 2024 starts and likely the only player still around from when Portugal, Turkey and the Czechs all

were in the same group at Euro 2008. Then, Portugal and Turkey advanced. Belgium were grouped with Romania, Slovakia, and the playoff winners from Israel, Iceland, Bosnia-Herzegovina and Ukraine. That playoff bracket could see a final between Ukraine and Israel with a place at Euro 2024 at stake. Just 21 of the 24 tournament teams are confirmed, with three placeholders in the draw for the eventual winners of qualifying playoffs. The 12 teams in three knockout brackets will play single-leg semifinals and finals from March 21-26.

At the finals tournament, third-place teams in four of the six groups must advance to make a balanced bracket in

The 24-team format started at Euro 2016 and history shows earning three points from three games with a goal difference that is not negative is enough to reach the knockout stage.

The draw was made at a waterside concert hall in the northern port city Hamburg, and was disrupted by unexplained noises clearly heard on stage and in the international broadcast. A British social media prankster posted footage showing how he placed cell phone calls to make the noise.

Hamburg is among 10 cities that will host the 51 games, and only Düsseldorf's stadium was not also used at the 2006 World Cup.

The final is on July 14 at the Olympic Stadium in Berlin which also staged the final in 2006. That, of course, was won by Italy.

Nantes supporter dies 'before' league game

NANTES, France, Dec 3, (AP): A supporter from Nantes died on Saturday following a fight that took place before the club's 1-0 win over Nice in the latest outbreak of violence to mar French soccer this season.

Nantes said in a statement overnight that the fan was "fatally injured" close to the club's stadium. According to the L'Equipe newspaper, the fan was a member of the Brigade Loire, Nantes' main group of diehard fans.

"In circumstances which are the subject of an ongoing judicial investigation, the 31-year-old collapsed, hit in the back," the club said. "Despite the intervention of emergency services, the fan could not be saved."

Nantes said the public prosecutor's office has launched an investigation into voluntary manslaughter.

Nantes public prosecutor Renaud Gaudeul said the incident took place shortly before 8 p.m. local time, when several private hire vehicles carrying Nice fans on their way to the match were attacked by groups of Nantes

The very first forensic investigations show that the victim had a wound on his back, possibly caused by a bladed weapon," the prosecutor said, quoted by French media.

Local newspaper Ouest France said the suspected assailant initially fled the scene before turning himself in at a police station.

French sports minister Amélie Oudéa-Castéra expressed her "great sorrow" in a message posted on X, the social network formerly known as Twitter.
