Iran to cooperate on 'new activities'

Tehran to coordinate with IAEA

DUBAI, May 24, (AP): The head of Iran's nuclear program insisted Wednesday that his government would cooperate with international inspectors on any "new activities." His statement followed an exclusive Associated Press report about Tehran's new underground tunnel system near a nuclear enrichment facility.

The AP outlined this week how deep inside a mountain, the new tunnels near the Natanz facility are likely beyond the range of a last-ditch U.S. weapon designed to destroy such sites.

The report sparked wider conversation across the Middle East about the construction, with Israel's national security adviser saying Tuesday the site would not

be immune from attack even if its depth put it out of range of American airstrikes. Speaking to journalists Wednesday after a Cabinet meeting, Mohammad Eslami of the Atomic Energy Organization of Iran sought to describe the interest in the site as a case of Israel feeling pressured.

"The Islamic Republic of Iran is working under the IAEA safeguards, and whenever wants to start new activities, it will coordinate with the IAEA, and acts accordingly," Eslami said, using an acronym for the International Atomic Energy Agency

The IAEA did not respond to questions from the AP about the construction at Natanz, about 225 kilometers (140 miles) south of Tehran. Natanz has been a point of international concern since its existence became known two decades ago.

point of international concern since its existence became known two decades ago. Satellite photographs of the piles of dirt from the digging and experts who spoke to the AP suggest the new tunnels will be between between 80 meters (260 feet)

and 100 meters (328 feet) deep.

Such underground facilities led the U.S. to create the GBU-57 bomb, which can plow through at least 60 meters (200 feet) of earth before detonating, according to the American military. U.S. officials reportedly have discussed using two such bombs in succession to ensure a site is destroyed. It is not clear that such a one-two punch would damage a facility as deep as the one at Natanz.

With such bombs potentially off the table, the U.S. and its allies are left with fewer options to target the site. If diplomacy remains stalled as it has for months over Iran's tattered nuclear deal, sabotage attacks may resume.

Iran says the new construction will replace an above-ground centrifuge manufacturing center at Natanz struck by an explosion and fire in July 2020. Tehran blamed the incident on Israel, long suspected of running sabotage campaigns against its program.

O Commerce and Finance Ministers, again, 'knowledge has come to you'

ONCE again we address the Minister of Commerce and Industry.

Land has no value if it is not used in building facilities. Its value is based on what is built on it, and what is produced from the industry existing on it.

This is what all countries in the world do. Land is granted to industrialists and entrepreneurs in order to invest their ideas and build industries on it, create more employment opportunities for the people, support the national product through exports, and provide the materials that the people in the country need.

In all countries of the world, there is a system known as B.O.T., which is the acronym of Build-Operate-Transfer system. Through this system, land is granted by the state to the investor in order to build a facility on it and run it for 40 or 50 or even 99 years.

This is the case in some European countries. After the expiry of the period, its fees are either reconsidered, or the ownership of that land is returned to the state. This is applicable in Saudi Arabia, the Emirates, and currently in Qatar and Bahrain. There are no obstacles impeding the investor like raising the fees every year as is the case in Kuwait.

An official targets a particular facility because his "cronies" want it. He hence works to impose unrealistic conditions on the investor and the industrialist to push him to leave the facility with its buildings and equipment, displace his workers, and throw them on the street, as it happens in Kuwait.

Given that the country imports 92 percent of its needs from abroad, it is necessary to reconsider the investment, industrial, agricultural and financial policy. This observation is addressed also to the Minister of Finance. This is because a country like Kuwait, whose annual oil revenues amount to USD 98 billion, has not built an industrial or agricultural system for decades, or developed an advanced infrastructure.

This means that it is sterile in ideas and visions, and its executive authority did not comprehend its basic role. The ministers responsible for finance, trade, public works, and health, in fact all ministers, were not qualified for the task that was entrusted to them.

Is it reasonable that we import tissues, gauze, and medical cotton from abroad, while the neighboring countries have begun the stages of military industrialization after they were crowded with manufacturing industries?!

Is it reasonable that an emirate such as Sharjah was able to cultivate vast areas of wheat, which made the UAE reduce the amount of imports from it in pursuit of self-sufficiency in the next few years?

Push on for removal of climate talks head

BERLIN, May 24, (AP): Scores of members of Congress and the European Parliament called Tuesday for the designated chair of the next United Nations climate summit to be replaced over his ties to the fossil fuel sector and for the industry's influence at the upcoming talks to be sharply lim-

The United Arab Emirates has been strongly criticized by environmental advocates for nominating Sultan al-Jaber, the head of the state-owned Abu Dhabi National Oil Company, to preside over the Nov. 30 - Dec. 12 meeting in Dubai known as COP28

In an open letter, the lawmakers urged U.N. Secretary-General Antonio Guterres, U.S. President Joe Biden, European Commission President Ursula von der Leyen and U.N. climate chief Simon Stiell to "engage in diplomatic efforts to secure the withdrawal of the president-designate of COP28."

Citing the presence of hundreds of oil and gas industry lobbyists at last year's climate talks in Egypt, the lawmakers also called on leaders to "take immediate steps to limit the influence of polluting industries, particularly major fossil fuel industry players whose business strategies lie at clear odds with the central goals" of the 2015 Paris climate accord.

Anti-immigrant party backs Erdogan rival

ANKARA, May 24, (AP): A hard-line, anti-migrant party on Wednesday threw its weight behind the opposition candidate who is running against Turkish President Recep Tayyip Erdogan in this weekend's runoff presidential race.

Umit Ozdag, the leader of the far-right Victory Party, announced his support for main opposition party leader Kemal Kilicdaroglu, who will be facing off against Erdogan on Sunday. He said he decided to back Kilicdaroglu after the two reached a consensus on the need to repatriate millions of migrants within a year.

Kilicdaroglu "has stated very clearly that refugees should return to their homeland and that this is the policy he will implement," Ozdag told reporters following several rounds of talks with Kilicdaroglu. "Therefore, as the Victory Party, we decided to support Mr. Kilicdaroglu in the second round of the presidential election"

Ozdag added that the two agreed on "a model that is in line with international laws and upholds human rights, that would ensure the security of Syrians in Syria but lift the heavy burden on Turkey's economy and that would make our streets safe again."

Ozdag's announcement came just days after Sinan Ogan, the third-placed contender in the first round of the presidential election on May 14, endorsed Erdogan in the upcoming runoff. Ogan was the joint candidate of an alliance of small conservative parties, led by Ozdag's Victory Party.

According to a seven-point protocol signed between Kilicdaroglu and Ozdag, the two also agreed on the need to maintain an "effective and determined" fight against the outlawed Kurdistan Workers' Party, or PKK, and other groups that Turkey considers to be terrorists. The two said they would uphold the country's secular traditions and fight corruption.

Erdogan received 49.5% of the votes in the first round of the presidential race - just short of the majority needed for an outright victory - compared to Kilicdaroglu's 44.9%. Ogan received 5.2%.

Erdogan's ruling party and its nationalist and Islamist allies also retained a majority in the 600-seat parliament - a development that increases Erdogan's chances of reelection because voters are likely to vote for him to avoid a splintered government, analysts say.

In an apparent attempt to woo nationalist voters in the runoff, Kilicdaroglu had hardened his tone last week, vowing to send back refugees and ruling out any peace negotiations with Kurdish militants if he is elected. Kilicdaroglu had previously said he planned to repatriate Syrians within two years, by creating economic and safety conditions conducive to their return.

Kilicdaroglu, 74, is the joint candidate of a six-party opposition alliance, which has pledged to reverse Turkey's authoritarian drift under Erdogan and return the country to a parliamentary democracy with increased checks and balances.

Turkey is home to the world's largest refugee community, including 3.7 million Syrians. Anti-migrant sentiment is running high in the country amid economic turmoil, including high inflation, and the issue of the repatriation of migrants has become a main campaign issue.

Erdogan has remained in power for 20 years by repeatedly surmounting political crises: mass protests, corruption allegations, an attempted military coup and a huge influx of refugees fleeing Syria's civil war.

Now the Turkish people and economy are being pummeled by sky-high inflation, and many are still recovering from a devastating earthquake in February made worse by the government's slow response.

Clue hope on McCann girl

ARADE DAM, Portugal, May 24, (AP): Police searching for clues regarding the disappearance of Madeleine McCann, the British child who went missing in 2007 in Portugal, were concentrating operations Wednesday in several areas around a dam, including one where media reports say a lead suspect in the case often staved.

The latest search for clues regarding the disappearance started Tuesday following a request by German authorities. Some 30 Portuguese, German and British police are taking part in the operation at the Arade dam, which is located about 50 kilometers (30 miles) from the resort of Praia da Luz, where the 3-year-old girl was last seen 16 years ago.

In Germany, Braunschweig prosecutor Christian Wolters told German public broadcaster NDR, "We have indications that we could find evidence there. I don't want to say what that is exactly, and I also don't want to say where these indications come from.

"The only thing that I would clarify is that it doesn't come from the suspect - so we don't have a confession or anything similar now, or an indication from the suspect of where it would make sense to search, "Wolters said, adding that "it was other indications that prompted us to conduct this search." But Wolters appeared to calm expectations of what might be found, saying, "We never said that the girl disappeared where we

are now searching."
Police on Tuesday were studying an area where Portuguese and Spanish media say the suspect stayed around the time that Madeleine went missing.

Officers could be heard using a motor saw to clear trees and bushes in the zone, which is located on the far side of the reservoir from the base camp that police set up Monday.

Police have given no details on the progress of the searches so far, but leading Portuguese daily Expresso said Wednesday that the first day ended with no significant results, adding that police had collected some objects including fabrics and garments.

Khartoum calm

KHARTOUM, May 24, (KUNA): Cautious calm prevailed the Sudanese capital city on Tuesday a few hours after the ceasefire came into force between the Sudanese National Army and the Rapid Support Forces.

The new ceasefire deal is the first such deal sponsored by the peace mediators.

The clashes subsided and military sorties ceased but bursts of sporadic distant gunfire were heard in some parts of Khartoum, witnesses told KUNA.

Both sides traded accusations of violating the truce deal.

RIYADH: The Saudi Cabinet on Tuesday instructed minister of transport and logistic services to launch talks with the **Kuwait** side on an agreement for railway linkage between the two Gulf neighbors.

The Saudi Press Agency reported that the Cabinet, headed by King Salman bin Abdulaziz Al Saud, also assigned the minister of energy to sign the Pan-Arab Electricity Market agreement. (KUNA)

RIYADH: The Secretariat of the Gulf Cooperation Council (GCC) marked at its headquarters in Riyadh on Wednesday the 42nd anniversary of council's establishment.

In the event, attended by the governor of Riyadh Prince Faisal bin Bandar, GCC Secretary General **Jassem Al-Budaivi** said that the council -- since establishment on May 25, 1981 -- had played a pivotal role in promoting cooperation amongst members of the GCC.

The foundation of the council reflected the vision of the leaders in the region and hopefully, the GCC would continue on its mission as a beacon of cooperation, development, and stability in the region. (KUNA)

ADEN: The Yemeni government warned Tuesday international companies against dealing with Houthi militias, as they do not have any constitutional right to put the country's properties and wealth under their disposal.

This came in a statement made by Minister of Information Muammar Al-Eryani, Yemen's news agency (Saba) reported.

The statement came a day after a Chinese private-sector company announced the cancellation of a deal it signed a few days ago with parties linked to the Houthis to invest in the oil sector.

The cancellation of this deal is a strong blow to the Houthi militias, he said, adding that they try to show false victories to mislead their members that they have taken de facto control of the areas under their fist. (KUNA)

KABUL: The bodies of 18 Afghan migrants who died while being smuggled into **Bulgaria** were returned to **Afghanistan**'s capital, Kabul, on Wednesday, a spokesman for the Taliban government's Foreign Ministry said.

Bulgarian authorities discov-

ered the bodies in a secret compartment below a load of lumber in the back of a truck left on a highway not far from the capital, **Sofia**, in February.

They confirmed all 18 had died of suffocation. Bulgarian authorities detained seven people in connection to the deaths. The director of Bulgaria's National Investigation Service described the case as the country's deadliest involving migrants. (AP)

HONG KONG: Hong Kong Chief Executive John Lee said police will investigate suspicious applications from people seeking to withdraw from the city's organ donation system, condemning the alleged attempt to damage the program as shameful.

The city's organ donation registration system received nearly 5,800 withdrawal applications in the five months since December, when the government raised the possibility of establishing an organ transplant mutual assistance program with mainland **China**. More than half of the withdrawal applications were found to be invalid, either as duplicate applications or coming from people who had never opted in. (AP)

WASHINGTON: The White House on Tuesday announced new efforts to guide federally backed research on artificial intelligence as the Biden administration looks to get a firmer grip on understanding the risks and opportunities of the rapidly evolving technology.

Among the moves unveiled by the administration was a tweak to the **United States**' strategic plan on artificial intelligence research, which was last updated in 2019, to add greater emphasis on international collaboration with allies. (AP)

'UN must redouble efforts to prevent wars'

Civilians bear the brunt of conflicts worldwide: Kuwaiti diplomat

NEW YORK, May 24, (KUNA): Kuwait's Permanent Representative to the United Nations Ambassador Tareq Albanai said late Tuesday that civilians always bear the brunt of the burden of conflicts worldwide.

Albanai made the remark in a speech he delivered on behalf of the Group of Friends of the Protection of Civilians in Armed Conflict at the Security Council Open Debate on "Ensuring the security and dignity of civilians in conflict: addressing food insecurity and protecting essential services" under the agenda item "Protection of civilians in armed con-

Burden

"Civilians are consistently shouldering the burden of conflicts around the world. Today, 2 billion people - a quarter of humanity - live in places affected by armed conflict. Record numbers of civilians are facing the humanitarian consequences of conflict, including displacement, and food and nutrition insecurity," he said.

"Among all civilians who are affected in armed conflicts, those who require our particular attention are people in vulnerable situations that are disproportionally prone to suffering, especially children,

He called on the United Nations Security Council (UNSC) to redouble its efforts to break the cycle of armed conflict, which drives and sustains many humanitarian crises around the world.

"And together, as the United Nations, we must do all we can to use the full range of tools at our disposal to prevent and end conflicts," he said.

He added that this years Secretary-General Protection of Civilians report focuses strongly on conflict and hunger and identifies a continuously high number of persons facing crisis levels of acute food and nutrition insecurity, primarily caused

by the consequences of armed conflicts.

It notes that in 2022, more than a quarter of a billion people faced acute hunger in 58 countries and territories, many of which were in armed conflict.

Furthermore, conflict and insecurity were the most significant driver of high levels of acute food insecurity for around 117 million people in 19 countries and territories. Stronger efforts are required to prevent and alleviate hunger in armed conflicts, including by protecting food sources and respecting and protecting humanitarian relief objects and personnel in line with their obligations under International Humanitarian Law (IHL), he added.

The Kuwaiti diplomat went on to say armed conflicts also inevitably contribute to the degradation of the environment, which in turn affects essential services such as those related to the delivery of food and water. Those consequences for civilians are compounded by the effects of climate change, food systems and supply chains collapse.

The Group of Friends echoes the Secretary-Generals concern, which is described in his report, about the humanitarian consequences resulting from armed conflicts involving the use of explosive weapons in populated areas.

Protection of civilians must also be strengthened through the protection of objects indispensable to the survival of the population, which include the civilian infrastructure critical to the delivery of interconnected and essential basic services. Too often, the lack of electricity, water and other basic commodities, hamper the delivery of the most essential services such as education and medical care, placing the health and welfare of civilians at risk, he emphasized.

It is important to recall that this Council has adopted Resolution 2286, which strongly condemns attacks against medical facilities and personnel in conflict situations, Resolution 2573 on the protection of civilian infrastructure, and Resolution 2601, on the protection of schools, educational facilities, and civilians connected with schools, including children and teachers, Albanai added.

The Group of Friends calls on Member States and other relevant actors to advance the implementation of these important resolutions of the Council and the IHL obligations that underpin them,

Humanitarian organizations work tirelessly to preserve and re-establish access to essential services for the affected civilian population, he said, adding there is an urgent need to redouble efforts, including in this Council, to allow and facilitate full, safe, timely and unhindered humanitarian access, and the safety and security of all humanitarian personnel, in accordance with IHL.

The Group of Friends commends the Security Council on the adoption of Resolution 2664, regarding humanitarian exemption to asset freezes under UN sanctions regimes. This is a pivotal step for the facilitation of humanitarian assistance in some of the most complex circumstances, he pointed out.

"We are deeply concerned about the growing number of missing persons as a result of armed conflict. Efforts to prevent family separation and disappearances, to search and identify the missing and the dead, and to address the needs of affected families, should be an integral part of our response," he added.

Albanai underlined that taking early action at the onset of an armed conflict is crucial and the regional and national implementation of relevant IHL and IHRL obligations, as well as of UNSC Resolution 2474 on missing persons, is key.

Technologies

Lastly, the use of new technologies is becoming increasingly important for efficient and effective humanitarian operations and the protection of civilians. However, modern technologies, including social media, are all too often misused for false narratives about humanitarian organizations and their work, as well as the work of UN missions, he noted.

Misinformation and disinformation endanger the security of humanitarian and UN mission staff as well as of those they are supposed to serve. It has to be vigorously combatted, including by advocating for IHL and humanitarian principles, he concluded.

Mol bans use of GHB substance

KUWAIT CITY, May 24, (Agencies): The Interior Ministry on Wednesday warned against the use of Gamma-hydroxybutyrate (GHB), a psychoactive substance banned internationally.

The ministry's Public Relation and Media Department said that the substance was used medically at hospitals for sedation before surgery, saying that it also could be used as a narcotic.

GHB is a colorless and scentless liquefied substance that when mixed with other ingredients could be used as a psychoactive drug and is actually illegal according to Law 48, 1987.

The American FDA and UN agencies warned against GHB and banned across the globe, indicated the department, urging citizens to stay vigilant and report any use of the drug in Kuwait.


Banks shut on June 6: The Union of Kuwaiti Banks has announced that local banks will be closed on June 6 -

Court rejects challenge to '22 **Assembly nullification verdict**

'Poll-runners must focus on family issues'

KUWAIT CITY, May 24: The Constitutional Court has dismissed the appeal filed by former MPs Muhammad Al-Mutair, Hamad Al-Matar, Fares Al-Otaibi, Mubarak Al-Hajraf, Muhammad Al-Ajmi and Yousef Al-Bazzali to cancel its ruling to nullify the 2022 National Assembly.

The court pointed out that the appeal violates the law on its establishment, stating its verdicts can neither be appealed nor debated. It said the appeal included wrong information, particularly the allegation that the ruling removes some of the Amiri powers stipulated in Article 107 of the Constitution. It also argued that the ruling took into consideration the errors in the dissolution of the 2020 Assembly, clarifying it did not exercise oversight on the authority granted to His Highness the Amir in terms of the assessment of political conditions.

On the other hand, member of the nullified 2022 Assembly and Second Constituency candidate Alyaa Al-Khalid asserted there is no provision preventing female MPs from running for speakership, which she intends to do in case she wins in the upcoming election. She said this position is not exclusive for certain personalities.

She added she has no intention to assign her representatives in the polling centers on Election Day, as she completely trusts the judiciary.

'Cut on consultancy contracts'

In a circular sent to various ministries and government agencies, the Ministry of Finance explained that it was noticed that many government agencies expanded contracts with consulting companies to provide consultation in various specialties. The costs of those contracts are deducted from the consulting item in Chapter Two (Goods and Services), and not from Chapter One (Compensation for workers). It was done without following the regulations that control the number of consultants who are hired despite their lack of

'Saudi summit ... a silver lining in the Arab-Arab relations'

"THE Kingdom of Saudi Arabia is the safe haven for the Arabs. It would not be possible to talk about the Arab summit, which was held last Friday, without referring to the endeavor of the Kingdom of Saudi Arabia because Riyadh works according to a vision based on zeroing on Arab problems and crises, keeping in mind the stability which forms the basis for development that every Arab aspires to," columnist and CEO of the Arab Times and Al-Seyassah newspapers Sattam Ahmed Al-Jarallah wrote for the daily.

'On this basis the efforts were exerted by the Crown Prince of Saudi Arabia, Mohammed bin Salman, for the success of the summit, because he had realized from the beginning that development in the Arab world can only take place through stability and normal and healthy relations among all peoples of the region, and that the future cannot be prosperous in light of the crises that afflict the Arab world, and the consequences we all are witness to during the past three decades. For everyone to be a winner is much better than losing one team on points at the expense of another.

"This year has culminated in a series of great efforts and activities, whether in terms of internal development,

the consolidation of social stability in the Kingdom, or at the regional level through an agreement with Iran, and the dismantling of hotbeds of tension created by Tehran over four decades in the past, especially after the Iranian leadership realized that there is no solution to the crises in the region except through an agreement with Saudi Arabia, as the Arab and Islamic incubator, and that stability in relations with Riyadh can undoubtedly be reflected in the rest of the region.

"During the last Arab summit, there were a number of files that Riyadh worked on, and with the efforts of Crown Prince Muhammad bin Salman, it succeeded in resolving them, and the most important of which is the return of Syria to the Arab embrace, as part of a package of measures that will undoubtedly lead to more regional stability.

'Syria's return to the Arab fold and the world at large can be considered a cornerstone of joint Arab action and the activation of all regional development agreements that have been collecting dust in the drawers over the past decade.

"All credit goes to the Saudi leadership and Crown Prince Mohammed bin Salman, and at the same time who spearheaded efforts to bring the Syrian leadership to the Arab fold, in the midst of events unfolding as President Bashar Al-Assad asserted in his speech to the leaders at the summit saying 'Syria's past, present, and future is Arabism, and that Syria's Arab affiliation is constant and does not change'

"There is no doubt that this position is what every Syrian feels – bonding with the Arab nation, which cannot be well unless all countries bode well. It goes without saying that the recent summit is a major turning point in Arab-Arab relations, and efforts must continue to purify the Arab atmosphere.

"There is no doubt that Saudi Arabia, with its great position, regionally and internationally, and above all in the Arab world, is able to play this role with great success in light of a vision characterized by action for the future.'

Also:

"At a certain time, and I mean here the sixties, questions arose about Kuwaiti women, surprising that the laws of election and candidacy were ignored, and these questions did not get an adequate answer such as proposals for national action and proposals to open the door for women's political participation," columnist Dr. Nada Suleiman Al-Mutawa wrote for Al-Jarida daily.

"Then came the wave of change in the 1990s. This change, which the press writings referred to as a soft reformist change, then the Gulf states began to appoint women in advisory, diplomatic and legislative councils as well.

"Kuwait had a share of that without conceding the democratic approach, so it took place during 1992, 1994 and 1996 submitting proposals to the National Assembly for laws to grant women their political rights, and in mid-1999 the proposals culminated in the Amiri desire of the late Sheikh Jaber Al-Ahmad to grant women their political rights to cast their ballots and contest elections.

"At that time, women suffered due to two things - the bitterness of waiting for the formation of a majority to support their right, and the bitterness of confrontation with amateurs who were obstructing change.

"In 2009, the elections were finally marked by the victory of four women who broke the barrier of fear of women assuming leadership and legislative

"Today, the scenario returns again amidst women contesting for parliament membership, and their competition with men, in addition to attempts to prevent women from reaching parliament, such as spreading rumors and bullying through social media, the latest of which was the launching of a document that

carried in its title values, and in its lines fragile reactionary ideas.
"Here I wonder: Will the women's scenario return and win a membership of Parliament in 2023? Or will the document stand as a barrier between her and leadership positions? Will the minister of information implement the strategy of reviving the celebrations, or will he be subject to the Values Document?

"And what about the licenses granted to private universities, will they be required to double the cost of construction subject to a document that has nothing to do with education or educational institutions?

"Last but not least, the government must activate its leadership role and fill the void through which reactionary documents may slip from time to time.'

"From the 1950s to the 1970s, the Nasserite regime created a new Arab regime whose internal pillars were socialism, nationalization, oppression and visitors of the dawn, while the external pillars were hostility toward the Western and Arab countries, and thwarting the greatest project that would have prevented wars in the region strengthened and enriched countries, and included them in an alliance with Turkey, Iran, Pakistan and Britain," columnist Sami Al-Nisf wrote for Annahar daily.

"The Baghdad Pact and Eisenhower's economic project were similar to the military alliances and economic projects implemented in Western Europe and East Asia that brought them peace, renaissance and progress.

"From 1970 to 1990 in the absence of Abdel Nasser, regional projects emerged for personalities such as Saddam Hussein and Muammar Gaddafi. These projects created pretexts and excuses for waging wars, impoverishing peoples, and interfering in the affairs of other countries. They have had problems with countries in the regional periphery and the international community until they fell through external interference, which was not regrettable.

"The advantage and importance of the new regional system for countries in the Middle East, led by Saudi Arabia, is that, unlike the previous systems and projects, it prohibits wars and prevents interference in the affairs of other countries, just as the country incubating the project, which is the 'new' Kingdom of Saudi Arabia, has become closer to the role model in what it does for its people in terms of development and openness or balanced relations with countries in the region and major countries around the world without aggravation or spasm.'

PART and losses incurred

Ten years ago, the government submitted a bill to the National Assembly to establish the Public Authority for Roads and Land Transport (PART). No less than five billion dinars of public money spent on this authority, after which the government decided to call it a failed idea, purge it and transfer its tasks to a management in the Ministry of Public

Works. We predicted from day one the failure of this tion, proposed two months ago to revive it and restore powers to it, but no one heard us, not for



nor before announcing its death officially a few days ago.

The committee came to life as dead, as it was given the amount of powers and responsibilities that exceed the capacity of any person to manage it efficiently, especially after the 'Brotherhood' took over, and here are the appointments from their cadres from day one.

The Ministry of Works hesitated for years before agreeing to hand over the authority the right to supervise the roads, which was like a hen laying golden eggs, and it did so, after reluctance, not before the Ministry left all the internal roads to itself.

The Ministry of Interior also refused to hand over to PART the right to supervise traffic lights, the right to issue vehicle licenses, the right to supervise land transport, the right to give licenses, the right to collect road fines, as stipulated in its founding law, and the right to set technical examination standards for all vehicles, develop, manage, li-

cense and supervise them. This is in addition to the right to issue and renew driving licenses, the right to inspect mass transport systems and ensure their safety, the right to build and supervise technical examination centers and their licensing, the insurance requirements for all vehicles, their technical condition, the requirements for those who drive them, their driving experience, the management and operation of truck weight systems and coordination with the concerned authorities.

Also the right to establish joint-stock companies or participate in them to implement their projects, and all these "rights" are mentioned in the Authority's law in the presence of the Minister of Interior personally, and ministers of other parties and none of them issued a single objection.

The authority was also entrusted with the responsibility of establishing railway and metro projects, places for rest and the right to own or rent real estate, materials and equipment, select and test all computer programs necessary to perform its work, monitor the movements of each sector, determine transportation tariffs and impose fees, draw up the state's transportation policy, and implement the related projects, supervising all activities that fall within the right of way, and many other things that cannot be mentioned here.

It suffices to know that the volume of road projects under implementation or agreed to be implemented in the years following the establishment of the authority has exceeded \$20 billion.

The matter did not take long, as it proved impossible for any party to manage a body of this size, and as happened in Hemingway's novel "The Old Man and the Sea", the various parties began to nibble at the authority, leaving nothing for it, especially after the corruption involving some of the 'Brotherhood' members and the corruption of some in the Ministry of Works and the road contractors mafia.

It was not surprising, therefore, that the last head of the authority and his deputy had to submit their resignations and go home even before hearing their acceptance from the minister.

Billions were lost following the establishment of PART, and the experience can be repeated, without any doubt.

Note: The interview of Professor Muhammad al-Yaqout, a member of the Roads Committee, more than ten years ago, with Muhammad al-Washhihi revealed that the road crisis is deeper than we imagined, and we have to return to the subject.

Violence against parents rises

Drugs, various apps, brutal films boost crime

KUWAIT CITY, May 24: How cruel is it for children to disown and disobey their parents?! How difficult are the moments when you hear or read about the crimes of children assaulting their parents? How tragic is the frequency of such crimes which are chilling and unacceptable to the mind and humanity?, reports Al-Anba daily.

These fathers and mothers spend their lives raising their children, but in the end, what they receive in return is ingratitude and denial from their children. However, what is worse and more damning is being assaulted and even murdered by them. The most recent of these heinous crimes was what Firdaus area had witnessed recently when a young man shot and killed his father because of a domestic dispute.

The Public Prosecution had ordered the detention of the perpetrator pending this case, which is not the first of its kind. In just two years, there have been five cases of fathers being murdered by their children. Also, about 1,400 felonies and misdemeanors of assault have occured on fathers and mothers by their children in these two years.

According to officials and specialists in psychology and sociology, the use of narcotics is the main reason why such violent crimes are being committed, especially the crime of children as-

They highlighted the statistics that reveal a 100 percent increase in crimes, cases of domestic violence and children's disobedience during the year

In addition, a psychological researcher at Kuwait University Dr. Amthal Al-Huwailah explained that the phenomenon of children assaulting parents is subject to psychological factors, like the rest of the crimes. This is because every crime has a bad psychological motive behind it, such as hysterical anger and outbursts. The killer loses control of his emotions, especially if he is under the influence of liquor or any types of drugs that affect the mind and hinder it from sound and balanced thinking. Some of these crimes indicate a psychological and social imbalance. Other causes are mental illnesses and behavioral disorders.

Assaulting parents is considered the most severe and heinous crime because parents represent a great status with children, and also because of their status with Allah, as they are considered one of the gates of heaven. Dr. Al-Huwailah said, "Whoever commits such

crimes either suffers from family pressures and has a difficult and unbalanced social upbringing or suffers from psychological and mental disor-

KUWAIT CITY, May 24: An investigator at Abu Fatira Police Station ordered the extradition of an Egyptian for swindling a female citizen, reports Al-Anba daily.

She added that the proliferation of modern technologies, various applications, and the effects of violent films are the biggest source of deviant

They explained that the use of psychotropic substances can cause psychological imbalance and push its user to commit any crime. The imbalance in the system of values requires a decisive stand by the authorities and civil society institutions to address the imbalance. There is a need to support the efforts exerted by the Ministry of Interior in combating the scourge of drugs, which requires supportive community efforts.

Security

In terms of security, informed sources from the General Department of Criminal Investigation said the research and investigation departments in the six governorates, in addition to other security departments, dealt with about 1,400 felonies and misdemeanors related to children assaulting their parents in the last two years.

One of the sources said, "The crime of the son killing his father in Firdous area with a firearm a few days ago brought back to mind the murder of a mother by her two daughters in Doha area in March 2022. It reopened the file of heinous crimes committed by children against their parents, something that has become a threat to society, especially in light of the spread of narcotic substances, the targeting of Kuwaiti youth with toxic substances, and the incitement to violence on some social media sites.

The outposts are now receiving complaints from parents against their children on an almost daily basis. Most of these complaints have a common factor, which is the use of mentally affecting substances or drugs and intoxicants, as sudden bouts of violence, and mental and nervous disorders may occur in the users.

Modern technologies and some communication sites have isolated family members from each other, along with bad companionship, satellite channels, the Internet, and social networking sites that are abound with violence.'

They said investigations are ongoing with the accused, who has been detained based on orders from the Public Prosecution Office, adding that a guard has been posted outside the residence of the dead man's family.

After the accused was arrested, he confessed to having committed the incident. He admitted to shooting his father with a firearm and killing him after disagreements and altercations.

An informed source said the accused also admitted that he was planning to kill all members of his family.

Lawyer Osama Al-Sanad said the punishment for children who kill their parents is the punishment prescribed in the Penal Code.

In a press statement, he explained that the punishment depends on the legal characterization of the crime. It can even reach a death sentence in case of intentional killing, and a maximum of ten years in case of beating that leads to death. There are also penalties not exceeding three years in other cases.

The two crimes of parents killing their children and children killing their parents are considered equal in law, as they are considered a crime punishable by the Penal Code according to the adaptation of the crime to each incident separately. It could be intentional killing, or a fatal beating that led to death, or wrongful death.

Lawyer Al-Sanad revealed that the number of domestic violence crimes and assaults against parents doubled during the year 2022, increasing from 1,292 in 2021 to 2,223 crimes in 2022.

He said, "Many recent legislations in other countries pay great attention to the motive behind

Furthermore, former Sharia lecturer and head of the Ashraqat Amal Center for Psychological and Social Counseling, and Lawyer in the courts of Cassation and Constitution Dr. Saad Al-Anzi affirmed that disobedience towards parents is considered a great sin.

Jobless man, woman leave children to die

Egyptian couple, six kids face deportation

KUWAIT CITY, May 24: The First Deputy Prime Minister, Minister of Interior and Acting Minister of Defense Sheikh Talal Al-Khaled directed not to renew the residency of an Egyptian couple and their six children and to grant them a temporary residency that expires at the end of the academic year, reports Al-Anba daily.

This happened after a report was submitted by the police to Al-Khaled, indicating the couple was involved in a family dispute and as a result of this dispute the father stayed with one of his friends and the mother also left the apartment leaving her children behind without any food, which necessitated the two elder children taking turns going to school to take care of their infant sister, who was less than 3 months old.

According to a security source, the daughter called the operations room of the Ministry of the Interior, and said that her parents left her and her five siblings alone and that they were hungry and did not find anything

to eat for two days.

The source told the daily, the Assistant Undersecretary of the Ministry of Interior for Public Security Affairs, Major General Abdullah Al-Rajeeb, was immediately informed, who directed that the six children be cared for, taken to the police station and provided with meals.

The community police, who took care of the children, were notified, and the husband was summoned, and he said he was laid off and was jobless and suffering from financial problems, and as a result, disputes occurred with the wife, which forced him to leave the home four months ago and live with his friend, claiming that he is committed to the expenses of his children and pays the tuition fees and the bus that transports them from school back and forth. As for the wife, she said that she was no longer able to take care of the children and that she had nothing to spend on them, and she went to stay with her friend.

A case of negligence was filed against the

parents and a report was submitted to Sheikh Talal Al-Khaled and he ordered to grant the whole family temporary residence following which they will be deported to their country.

It is noteworthy to mention the husband was born in 1981 and the wife in 1985. Their six children, 4 girls, were born in 2011, 2016, 2019 and 2023, and the other were born in 2009 and 2020.

While some Gulf countries have reached the point of sending astronauts into space, we are still drowning in polemics and disagreements between parliamentarians and ministers. The documentary cycle is still stuck in the "our letter and your letter" box, and what the Ministry of Commerce licenses, the municipality prohibits it.

As for the Minister of Finance, managing the state's finances is not like managing a shop. While the country seeks to turn into a global financial center, it must have an attractive policy for investment and investors, and be able to meet people's needs. From 2017, a vision known as "New Kuwait 2035" vision was approved. We wonder what plans your ministry has made in this regard, and what steps have been taken.

Frankly, nothing. In fact, the successive cabinets, including the current one, have worked to suffice with issuing decisions that increase the closure of the country, burden the expatriates

In Saudi Arabia, the percentage of expatriates is about 50 percent. In the Emirates, the percentage of expatriates is 83 percent and citizens is 17 percent. 

Ministry 'reorganizes' licenses for activities of special nature

Decision serves large segment of micro-business owners

KUWAIT CITY, May 24: In a development that serves a large segment of microbusiness owners, the Minister of Commerce and Industry Muhammad Al-Aiban issued a decision through which he reorganized licenses for activities of a special nature in a way that would reduce the burden of rents for headquarters for a large segment of business owners, reports Al-Qabas daily.

According to informed sources, the number of activities expected to be covered by the decision exceeds 60 commercial and handicraft activities. There is no need for the owners of these activities to rent official premises to practice their commercial activity, provided that the they undertake it without the need for workers, a commercial store, or the approval of other regulatory authorities such as the municipality, the Ministry of Interior, the Public Authority for Industry, and others. The activities intended in the decision cannot register or recruit expatri-

Regarding the entitlement of holders of commercial licenses of a special nature to support national manpower, the sources said the decision to disburse labor support is not in the hands of the Ministry of Commerce and Industry, as they will not be granted "national manpower support" for these activities, unless the Public Authority for Manpower issues a decision allowing them to do so.

The sources said this decision would restrict the activity of fictitious office rental brokers, as there are those who rent a fake office or for a short period with the aim of obtaining a commercial license. adding that this measure will stop tampering

The following was stated in resolution No. 82/2023 regarding licensing activities of a special nature:

In the application of this decision, it means companies carrying out activities of a special nature by their owners without the need for workers, a commercial store, or the approval of other regulatory authorities. It is within the framework of facilitating and supporting projects, and as an exception to the requirements stipulated in the executive regulations of the aforementioned commercial store licensing law. Article 2:

The application for licensing the companies mentioned in the previous article should be submitted through the ministry's "single window center" along with the required documents in accordance with the laws and decisions in force, with the exception of submitting a rental contract or receipt if the following data is submitted:

1. A proof of the legality of the home address of the applicant, or the chosen domicile of the applicant, whether it is a law firm or an auditor's office.

2. Any other documents for which a decision is issued by the minister or whomever he authorizes.

The provisions of this decision apply to companies established before and after its issuance. The license is issued for a period of three years

Article 4: With the exception of the provisions contained in this decision, the provisions of the relevant ministerial decisions remain

Article 5:

The concerned authorities - each within the scope of their competence - shall implement this decision. It shall come into effect from the date of its issuance. It shall be published in the

Conditions for obtaining a license are as follows:

1 - Commercial licenses of a special nature are not issued to public sector employees, and are granted to citizens only registered under chapters 3 and 5, and to retirees. 2 - Permitted commercial licenses must require approvals

from bodies other than the Ministry of Commerce and Industry 3 - The applicant for a license who is registered under Chapter 5 is not entitled to labor support for the activity of a special

4 - The owner of the license must practice the work himself. It is forbidden to register or recruit workers for the license.

Coke's single largest contribution to climate change comes from its refrigeration equipment

Coca-Cola's biggest challenge in greening operations is its own marketing strategy

Yoca-Cola is one of the world's most widely recognized brands. Its global Creach, spanning more than 200 countries, was the theme of a 2020 commercial that showed families drinking Coke with their meals in cities from Orlando, Florida, to Shanghai, London, Mexico City and Mumbai, India.

Operating on that scale creates a big carbon footprint. The company uses over 200,000 vehicles to distribute its products every day and runs hundreds of bottling plants and syrup factories across the globe.

But Coke's single largest contribution to climate change comes from its refrigeration equipment.

Running refrigerators uses a lot of electricity, and some coolants in these systems are greenhouse gases that trap heat in the atmosphere. Almost two-thirds of the climate impact of refrigeration comes from electricity consumption, and refrigerants account for the rest. As of 2020, refrigeration produced nearly 8% of global greenhouse gas emissions.

History suggests that the most effective way to shrink Coca-Cola's refrigeration emissions may be to question whether the company needs that cooling equipment running around the clock at convenience stores on street corners worldwide. That's a heretical notion for a company obsessed with making sure Coca-Cola is always within "an arm's reach of desire," as one Coke president put it.

As I show in my new book, "Country Capitalism: How Corporations from the American South Remade Our Economy and the Planet," major companies like Coca-Cola have profited handsomely by making their products readily available worldwide. In doing so, they have created a fast-paced, long-distance form of commerce that is a major driver of our planet's current ecological crisis.

Refrigerants first became an environmental issue because of concerns about ozone loss, not climate change. Before the 1980s, the primary coolants used in refrigerators were chlorofluorocarbons, or CFCs. Discovered in the 1920s by a

chemist at General Motors, these compounds were odorless, nonflammable and seemingly nontoxic - all properties that made them useful to industry. In the following decades, CFCs became the chief refrigerant used to keep things cool.

Then, in the 1970s, researchers at the University of California found that CFCs could destroy stratospheric ozone, a gas in the atmosphere that protects life on Earth from the Sun's ultraviolet radiation. Nations ultimately moved to ban use of CFCs through the 1987 Montreal Protocol, one of the most successful environmental treaties on record.

Chemical companies such as DuPont led the way in promoting new chlorinefree refrigerants, called hydrofluorocarbons or HFČs, that would not deplete the ozone layer. Like CFCs, HFCs appealed to industry because they were odorless, nonflammable and posed no serious threats to human health.

But HFCs had a big drawback: They were powerful greenhouse gases that trapped heat in the Earth's atmosphere, warming the planet's surface. Some HFCs had warming impacts more than 1,000 times greater than carbon dioxide, the most abundant greenhouse gas.

Companies like Coca-Cola knew about HFCs' climate-warming effects when they began transitioning to this new refrigerant in the 1990s. Bryan Jacobs, a Coca-Cola engineer who worked on this transition, told me in an interview that early on, refrigeration technicians in Europe recommended another promising path instead.

Greenpeace advocates in Germany had worked closely with refrigeration engineers to develop what came to be known as Greenfreeze cooling equipment: machines that used hydrocarbons, including isobutane and propane, as refrigerants. These refrigerants, which had a global warming impact radically lower than HFCs, offered the prospect of protecting both the ozone layer and the climate.

Jacobs told me that Coca-Cola was "pretty dismissive," largely because his team feared that these refrigeration units filled with flammable material might explode - especially in rural areas lacking technical support. Instead, Coca-Cola shifted to HFCs.

In response, Greenpeace launched a major campaign at the 2000 Sydney Olympics to expose how Coca-Cola's HFC units were warming the planet. Doug Daft, an Australian who was Coke's CEO at the time, committed the company to eliminating HFC refrigeration from its systems in the years ahead.

Since 2000, Coca-Cola has become a world leader in developing HFC-free refrigeration equipment. At first it invested heavily in a novel type of refrigerator that used carbon dioxide as the key refrigerant. Soon, however, the company recognized that hydrocarbon refrigerants posed fewer safety risks than they had initially feared, and began adopting these units as well.

Coca-Cola also convinced other companies to shift away from HFCs. Partnering with Unilever, Pepsi, Red Bull and other big firms, the company launched Refrigerants, Naturally!, an organization committed to transitioning major food and beverage companies toward HFC-free refrigeration. In 2010, Coke CEO Muhtar Kent persuaded some 400 consumer goods companies to commit to eliminating HFCs from their refrigeration systems.

By 2016, Coke reported that 61% of all new cooling equipment it purchased was HFC-free. Four years later, that figure reached 83%

Still, as of 2022, more than 10% of Coke's new refrigeration units contained HFCs, and refrigeration remained its single largest greenhouse gas emissions source. Part of the problem is that all of these units run on electricity, much of which is generated by burning fossil fuels. With Coca-Cola selling roughly 2.2 billion drinks every day, keeping Coke cold still has an enormous carbon footprint. The same is true for Coke's competitors.

In an interview with Coca-Ĉola's former chief sustainability officer, Jeff Seabright, I asked him whether the company had ever considered thinking more broadly about the necessity of cooling all those Cokes around the clock. Seabright's response was an emphatic "No," and that the company was still driven by the mantra of making Coke available for immediate consumption at the point

Despite the resources that Coca-Cola has invested in changing refrigerants, its cooling equipment is still warming our planet. As I see it, perhaps it's time for Coke to question whether it needs all those machines in the first place - and for consumers to consider whether their have-it-now expectations are worth the environmental costs they impose. (AP)

Debt ceiling talks grind on, but GOP says there's lack of urgency from WH

Leaders staring down a financial crisis

Asian stocks slide as US debt worries mount

WS drops as markets tumble globally

NEW YORK, May 24, (AP): A worldwide swoon for financial markets is carrying over to Wall Street, and stocks are falling further on Wednesday.

The S&P 500 was 0.9% lower in afternoon trading, a day after dropping 1.1% as the U.S. government creeps closer to a possibly disastrous default on its debt. The Dow Jones Industrial Average was down 272 points, or 0.8%, at 32,783, as of 12:21 p.m. Eastern time, while the Nasdaq composite was 1% lower.

Other markets around the world were hit even harder as discouraging figures piled up on the economy. Stock indexes tumbled 1.7% in London, 1.9% in Frankfurt and 1.6% in Hong Kong.

Inflation in the United Kingdom remains worse than expected, raising worries that the Bank of England may keep hiking interest rates and squeezing its economy. In Germany, business confidence fell in Europe's largest economy. And in China, worries remain about a weaker-than-hoped reopening from COVID restrictions as tensions rise with the United States over technology and security.

On Wall Street, the focus is squarely on Capitol Hill and the White House, where the latest battle between Democrats and Republicans is threatening to cause the nation's first-ever default on its debt. The U.S. government could run out of cash to pay its bills as soon as June 1 unless Congress allows it to borrow more, and the widespread expectation is that a default would result in tremendous economic pain.

The stock market for the most part has remained resilient despite the worries. Fear has been concentrated mostly in corners of the bond market, where prices have dropped for Treasury bills due to pay out around the possible date of default.

That's largely because the widespread belief on Wall Street has been that Congress would come to an agreement at the 11th hour, as it's done several times before, because a default would benefit no one. But fear is rising that Congress may not feel urgency to

A measure of fear among stock investors on Wall Street climbed 9.6% and is near its highest level since March. That's when worries were flaring hottest about the strength of the banking system, as it creaked under the weight of much higher interest rates.

Rates are so high because the Federal Reserve has yanked them up at the fastest pace in decades in hopes of getting high inflation under control. High rates do that by putting the brakes on the entire economy and hurting prices for stocks, bonds and other investments. That has many investors bracing for a recession even if Congress reaches a deal on the debt limit.

Traders are hopeful just one more hike may be on the way this summer, if any at all. The Fed may offer more clues on its intentions after it releases the minutes from its last policy meeting in the afternoon.

Helping to limit Wall Street's losses were several companies that reported stronger results for the start of the year than analyst expected.

Kohl's jumped 5% after reporting a surprise profit for its latest quarter, helped in part by momentum at its Sephora beauty shops. Analysts had expected it to turn in a loss.

Resilient spending by U.S. consumers has helped to keep the economy out of a recession even as manufacturing and other areas struggle with higher interest rates. With the job market remaining solid, economists at Goldman Sachs said they expect consumer spending to remain a source of strength for the economy through this year.

Homebuilder Toll Brothers rose 2.1% after reporting much better results than analysts expected for the latest quarter.

Most companies have been topping expectations for the first quarter of the year, but much of that is because analysts set the bar particularly low. S&P 500 companies are still on track to report a second straight quarter of weaker profits from year-ago levels. That has Wall Street focused even

more on what companies say about their future prospects than how they performed over the past several months.

A recent poll by The Associated Press-NORC Center for Public Affairs Research found that 66% of Americans said they're very or extremely concerned about the impact on the U.S. economy if the debt limit is not raised and the government defaults, though only 21% said they're follow-

ing the debate closely. Robert Gault, 63, who depends on a \$1,900 monthly Social Security disability payment, says an economic default "would make life so real awfully hard on me." The former longtime factory worker said he suffers from chronic back pain caused by degener-

ating disks in his spine. Gault, who lives in Bradford, Pennsylvania, near that state's border with New York, said he thinks about the debate - and the stalemate - in Wash-

ington a lot. He hasn't made any drastic changes to the way he lives, but said, "I'm more conscientious of everything and I think about everything I do now.

Intergrated computing addresses main barriers

New approach to teaching computer science could 'broaden' subject's appeal to students

Despite growing demand for computer science skills in professional careers and many areas of life, K-12 schools struggle to teach computer science to the next generation

However, a new approach to computer science education - called integrated computing - addresses the main barriers that schools face when adding computer science education. These barriers include a lack of qualified computer science teachers, a lack of funds and a focus on courses tied to standardized tests.

Integrated computing teaches computer science skills like programming and computer literacy within traditional courses. For example, students can use integrated computing activities to create geometric patterns in math, simulate electromagnetic waves in science and create chatbots for literary characters in language arts.

As a professor of learning technologies, I have been designing integrated computing activities for K-12 students for the past five years. I work with faculty and students in teacher training programs to create and test integrated computing activities across all academic subjects.

In my research, I have found that integrated computing solves three major

hurdles to teaching computer science education in K-12 schools.

Fitting a new academic discipline into an already crowded curriculum can be a challenge. Integrated computing allows computer science education to become part of learning in other classes, the way reading skills are also used in science, math and language arts classes.

Teacher knowledge is another difficulty when it comes to teaching computer science in K-12 schools. While people who specialize in computer science are often recruited to more lucrative careers than teaching, integrated computing develops all teachers' computer science knowledge. Teachers do not need to become computer science experts to teach computer literacy and programming skills to their students.

Surprising

In fact, the most surprising result of my research is how quickly teachers learn to teach integrated computing activities. In about two hours, teachers can use a pre-made computer science lesson in their classrooms. In the future, I will teach them to use artificial intelligence to create their own lessons for their students. For example, a science teacher recently asked me how she could create a data analysis activity for her class. AI tools would allow her to quickly design the technical aspects of this activity.

And finally, integrated computing also addresses students' reluctance to take elective computer science classes when they have little knowledge of computer science. In 2022, over half of U.S. public high schools offered computer sci-

ence, but just 6% of students took these classes. Students who do take computer science in high school typically have had early exposure to computer science. Integrated computing can give all students early exposure to computer science, which I believe will increase the number of students who take computer science courses later in school.

Early exposure to computer science in school is especially important for students from groups underrepresented in computer science. A 2022 report from Code.org, a nonprofit that advocates for more computer science education in K-12 schools, found that students who are Latino, female or from low-income or rural areas are less likely to be enrolled in foundational computer science courses

Teachers who want to build their computer science knowledge and apply it to their classroom can try these free self-paced, online integrated computing courses that I developed, and which are tied to micro-credentials. Also, this sortable list of integrated computing activities provides free lesson plans. The activities require only a computer - no prior knowledge is needed, and young learners can complete them outside of class, too.

Integrated computing provides a path to increase computer literacy for all K-12 students. As technology advances at an increasing rate, I believe schools must take care that our young people do not fall behind.

Ready for a digital euro? At 25, European **Central Bank 'preps' for future of money**

Some smaller economies have set the ball rolling

FRANKFURT, Germany, May 24, (AP): As it marks its 25th anniversary Wednesday, the European Central Bank is readying a proposed design for a digital version of the euro, responding to pressure from developing technology that could change how money is used over the bank's next decades.

ECB President Christine Lagarde says a digital euro could offer a way for people to buy things without depending on payment service providers controlled by non-European companies. Those could include Mastercard, Visa, Apple Pay and Google Pay.

The European Union's executive Commission is expected to come up with proposed legislation on the idea in the next several weeks, ECB officials say, while the central bank will publish a detailed proposal for the design of a digital currency in October.

Central banks worldwide, including the U.S. Federal Reserve, are cautiously studying digital currencies as cash increasingly gives way to electronic payments. Some smaller economies such as Nigeria, the Bahamas and Jamaica already have introduced digital currencies, while China is holding trial

Emergence

Central banks also are responding to the emergence of cryptocurrencies, which have raised concerns that someday people could turn to rival forms of digital money that would undercut national currencies.

Digital currency backed by a central bank would be a safe and stable means of payment - unlike voltatile crypto, whose price crashes over the past year and collapses of exchanges like FTX have spurred calls for regulation. The EU became a global leader by giving final approval last week to rules for the freewheeling crypto sector.

As Europe considers its own central bank-based digital currency, the biggest question is: How would it improve on what's already available for consumers?

"Nobody is able to answer this question, not even the ECB," said Philipp Sandner, head of the Blockchain Center at the Frankfurt School of Finance & Management.

"As the user I ask myself, 'What is the benefit, why do we need another solution?" he said.

Apple Pay, for instance, allows people to buy their morning coffee - and anything else - by tapping twice on their phones, a seamless experience the digital euro would have to match.

"You have to be at least as good as Apple Pay and Mastercard, which is difficult, otherwise people will not use it," he said.

The goal of a digital euro would be Europe's autonomy and resilience when it comes to the largely unseen but critical systems that move money from consumers to merchants through

She drew an analogy to Europe's previous reliance on Russian oil and natural gas, which led to an energy crisis when the invasion of Ukraine disrupted that supply.

"It's very unhealthy to rely on one single source of energy, it's very unhealthy to rely on one single source of payment," she said.

A digital euro also could help people who don't have bank accounts, the thinking goes, because they could hold money on their phones.

The move toward increased digitalization comes as the ECB marks 25 years since its creation on June 1, 1998, seven months ahead of the introduction of the euro currency. An anniversary ceremony with German Chancellor Olaf Scholz and former ECB Presidents Mario Draghi and Jean-Claude Trichet is planned Wednesday at the bank's Frankfurt headquarters.

The ECB envisions a digital euro for retail use that could even be transferred offline using a digital wallet on people's phones. Early designs call for a standard app, along with use through existing online banking apps. It wouldn't replace cash but add another way to hold euros.

Even after the proposal is made, there would be three years of testing. A decision to actually introduce the digital euro would only come after that and require EU approval.

Fabio Panetta, a member of the ECB's executive board and head of the digital euro task force, says it wouldn't replace cash and people would have the option, not the requirement, to use

A boost from the US Supreme Court

More than two dozen cities, states suing 'Big Oil' over climate change

Honolulu has lost more than 5 miles of its famous beaches to sea level rise and storm surges Sunny-day flooding during high tides makes many city roads impassable, and water mains for the public drinking water system are corroding from saltwater because of sea level rise.

The damage has left the city and county spending millions of dollars on repairs and infrastructure to try to adapt to the rising

Future costs will almost certainly be higher. More than US\$19 billion in property value, at today's dollars, is at risk by 2100 from projected sea level rise, driven by greenhouse gas emissions largely from the burning of fossil fuels. Elsewhere in Honolulu County, which covers all of Oahu, many coastal communities will be cut off or uninhabitable.

Unwilling to have their taxpayers bear the full brunt of these costs, the city and county sued Sunoco LP, Exxon Mobil Corp. and other big oil companies in

Their case - one of more than two dozen involving U.S. cities, counties and states suing the oil industry over climate change - just got a break from the U.S. Supreme Court. That has significantly increased their odds of

succeeding.
At stake in all of these cases is who pays for the staggering cost of a changing climate.

Local and state governments that are suing want to hold the major oil companies responsible for the costs of responding to disasters that scientists are increasingly able to attribute to climate disruption and tie back to the fossil fuel industry. Several of the plaintiffs accuse the companies of lying to the public about their products' risks in violation of state or local consumer protection laws that prohibit false advertising.

The governments in the Honolulu case allege that the oil companies "are directly responsible" for a substantial rise in carbon dioxide emissions that have been driving climate change. They say the companies should contribute their fair share to defray some of the costs.

The gist of Honolulu's complaint is that the big oil companies have known for decades that their products cause climate change, yet their public statements continued to sow doubts about what was known, and they failed to warn their customers, investors and the public about the dangers posed by their products.

Were it not for this deception, the lawsuit says, the city and county would not be facing mounting costs of abating the damage from climate change.

Importantly, the complaint is based on state - not federal law. It alleges that the defendants have violated established common law rules long recognized by the courts involving nuisance, failure to warn and trespass.

The city and county want the companies to help fund climate adaptation measures - everything from building seawalls and raising buildings to buying floodprone properties and restoring beaches and dunes.

Not surprisingly, the oil companies have thrown their vast legal resources into fighting these

On April 24, however, they lost one of their most powerful arguments.

The U.S. Supreme Court declined to hear challenges in the Hawaii case and four others involving the seemingly technical question of which court should hear these cases: state or federal.

The oil companies had "removed" the cases from state court to federal court, arguing that damage lawsuits for climate change go beyond the limits of state law and are governed by federal law.

That theory would have derailed all five cases - because there is no federal common law for greenhouse gases.

The court made that position clear in 2011 in American Electric Power Co. v. Connecticut. Several state and local governments had sued five major power companies for violating the federal common law of interstate nuisance and asked for a court order forcing these companies to reduce their emissions. The Supreme Court refused, holding that the federal Clean Air Act displaced federal common law for these gases.

In Native Village of Kivalina v. Exxon Mobil Corp., a federal court of appeals extended that holding to also bar claims for monetary damages based on federal common law.

To avoid this fate, Honolulu and the other plaintiffs focused on violations of state law, not federal law. Without exception, the federal courts of appeals sided with them and sent the cases back to state court.

A computer scientist explains the carbon footprint of ChatGPT

Is generative AI bad for the environment?

Generative AI is the hot new technology behind chatbots and image generators. But how hot is it making the planet?

As an AI researcher, I often worry about the energy costs of building artificial intelligence models. The more powerful the AI, the more energy it takes. What does the emergence of increasingly more powerful generative AI models mean for society's future carbon footprint?

"Generative" refers to the ability of an AI algorithm to produce complex data. The alternative is "discriminative" AI, which chooses between a fixed number of options and produces just a single number. An example of a discriminative output is choosing whether to approve a loan application.

Generative AI can create much more complex outputs, such as a sentence, a paragraph, an image or even a short video. It has long been used in applications like smart speakers to generate audio responses, or in autocomplete to suggest a search query. However, it only recently gained the ability to generate humanlike language and realistic photos.

The exact energy cost of a single AI model is difficult to estimate, and includes the energy used to manufacture the computing equipment, create the model and

use the model in production. In 2019, researchers found that creating a generative AI model called BERT with 110 million parameters consumed the energy of a round-trip transcontinental flight for one person. The number of parameters refers to the size of the model, with larger models generally being more skilled. Researchers estimated that creating the much larger GPT-3, which has 175 billion parameters, consumed 1,287 megawatt hours of electricity and generated 552 tons of carbon dioxide equivalent, the equivalent of 123 gasoline-powered passenger vehicles driven for one year. And that's just for getting the model ready to launch, before any consumers start using it.

Size is not the only predictor of carbon emissions. The open-access BLOOM model, developed by the BigScience project in France, is similar in size to GPT-3 but has a much lower carbon footprint, consuming 433 MWh of electricity in generating 30 tons of CO2eq. A study by Google found that for the same size, using a more efficient model architecture and processor and a greener data center can reduce the carbon footprint by 100 to 1,000 times.

Larger models do use more energy during their deployment. There is limited data on the carbon footprint of a single generative AI query, but some industry figures estimate it to be four to five times higher than that of a search engine query. As chatbots and image generators become more popular, and as Google and Microsoft incorporate AI language models into their search engines, the number of queries they receive each day could grow exponentially.

A few years ago, not many people outside of research labs were using models like BERT or GPT. That changed on Nov. 30, 2022, when OpenAI released ChatGPT. According to the latest available data, ChatGPT had over 1.5 billion visits in March 2023. Microsoft incorporated ChatGPT into its search engine, Bing, and made it available to everyone on May 4, 2023. If chatbots become as popular as search engines, the energy costs of deploying the AIs could really add up. But AI assistants have many more uses than just search, such as writing documents, solving math problems and creating marketing campaigns.

Another problem is that AI models need to be continually updated. For example, ChatGPT was only trained on data from up to 2021, so it does not know about anything that happened since then. The carbon footprint of creating ChatGPT isn't public information, but it is likely much higher than that of GPT-3. If it had to be recreated on a regular basis to update its knowledge, the energy costs would grow

One upside is that asking a chatbot can be a more direct way to get information than using a search engine. Instead of getting a page full of links, you get a direct answer as you would from a human, assuming issues of accuracy are mitigated. Getting to the information quicker could potentially offset the increased energy use compared to a search engine.

The future is hard to predict, but large generative AI models are here to stay, and people will probably increasingly turn to them for information. For example, if a student needs help solving a math problem now, they ask a tutor or a friend, or consult a textbook. In the future, they will probably ask a chatbot. The same goes for other expert knowledge such as legal advice or medical expertise.



People prioritize physical proximity

Travelers will refuse an upgrade to sit near a loved one: research

The Research Brief is a short take about interesting academic work. People will often sacrifice a

better experience and opt for one that's less enjoyable if it means they can do it alongside a loved one whether that's a romantic partner. close friend or relative. That's the main finding of our research published in the Journal of Consumer Psychology in April 2023.

For example, when taking a flight, two friends might decide to sit in adjacent seats in coach rather than accept a free upgrade to nonadjacent seats in first class. Failing to choose togetherness can have consequences, as in the "Seinfeld" episode in which Elaine suffers the indignities of economy class, leading to rage against Jerry after he chooses to

accept an upgrade.

We conducted five studies in a variety of settings and featuring different social bonds, including friendships and romantic relationships. In one study, just over half of people chose two adjacent seats far from the stage over two nonadjacent seats closer to the stage when imagining they were attending a Cirque du Soleil performance with a close friend, compared with only about one-third who chose the adjacent seats when imagining attending with an acquaintance.

In another study, we asked students whether they wanted to eat one chocolate with another person - either a new friend or a stranger - or two chocolates alone. Half the people chose the shared experience - but only if the other person was a friend. Fewer people - 38% - opted for the shared experience if the other person was a stranger.

One reason people prioritize physical proximity with close partners is because they want to create shared memories. Importantly, people believe that physical distance can disrupt the creation of shared memories, and so they forgo enjoyable experiences apart from their loved one.

This also matters for companies seeking to improve customer experience, such as an airline offering free upgrades or shorter wait times. Our findings suggest that, for example, consumers traveling with a companion might not take advantage of services like TSA or a free upgrade if it is available only for themselves. It also helps explain why consumers do not like when airlines split up families in their seat assignments.

However, we also tested a few initiatives marketers can use to encourage people to choose a higherquality experience that requires them to be apart from their companion. In another experiment, we described a train ride as either a fun part of an excursion or as a practical way to reach a final destination. More participants accepted a free upgrade - even though it required sitting apart from their romantic partner - when they perceived the train ride as utilitarian. That's because they cared less about creating shared memories during the

We still don't know how this preference affects relationship quality. For example, when can time

apart from your partner actually strengthen the relationship? And how should couples split their time between lower-quality activities done together and higher-quality activities done alone? One option for separate activities, for example, might be when one partner's desired activity does not interest the

Also, given that people believe physical proximity is a prerequisite for creating shared memories, how can partners who live in different places also cultivate shared memories? This question is especially important in light of how COV-ID-19 has enabled more people to work and study remotely.

2 Ukrainian amputees walk to raise funds for a military hospital

KYIV, Ukraine, May 24, (AP): The task for the Ukrainian war veterans was clear: From different cities, Oleksandr Shevtsov and Serhii Khrapko would walk 120 kilometers (75 miles) and meet somewhere in the middle in honor of their comrades wounded in Russia's war against their homeland

Their walk was shared on social media and they started collecting donations to raise funds to supply medical equipment to Ukraine's main military hospital. Their walk was also an inspiration for many across the country - both the men were severely wounded in Russia's last major war with

Ukraine in 2014 and had to have limbs amputated.

Unable to participate in the current war, the men found another way to contribute to the fight.

"I got a call from my brother in arms, Serhii Khrapko. We've known each other for a long time. He said: 'Sania, our hospital needs aid,'" said Shevtsov. Sania is his nickname. "This is truly our dear hospital, the one that saved our lives. It saved my right leg," he said.

"This is how we can help our brothers and sisters in arms, and in some way our country. Because our country is really fighting right now. We are all fighting in the ways we can.

Khrapko, missing an arm and running with one prosthetic leg, left Kyiv on May 15 at 3:05 p.m. Shevtsov, who has a prosthetic leg, had begun the race from Zhytomyr three hours earlier. Five days later they met on the road, having walked a total of 165,156 steps toward each other over five days.

They raised 3.1 million hryvnias (\$84,000), just short of the 500,000 hryvnias (\$14,000) needed to purchase a new gastroscope for Ukraine's National Military Medical Clinical Center.

Shevtsov, 38, was called up for military service nine years ago when pro-Russian separatists seized government buildings in Ukraine's eastern Donbas region and proclaimed the Donetsk People's Republic and Luhansk People's Republic, as independent states, starting the war for the region.

On July 4 that same year, he was struck by shrapnel from an incoming attack in the outskirts of Luhansk, which caused severe damage to a major

Doctors in the hospital worked frantically to revive blood flow to his limbs. Despite their best efforts, surgery did not work and his left leg was

He was released, with one leg salvaged after six months of surgical inter-

But that is when Shevtsov's private battle started.

He could not stand to wear the prosthetic leg provided to him. It stood in his bathroom, by his bed, for a long time, he said. What would other people think? He thought. He believed his friends would pity him, and he couldn't bear the feeling. He was ashamed to even go outside and sit in his wheelchair in the yard, he said, in case anyone would see what became of him.

Rehabilitation

Then, he was sent to Austria to attend rehabilitation training. The experience changed him. He saw how people from all walks of life, from children to the elderly, walked with their prosthetic limbs with confidence.

He told himself, "I will never sit in a wheelchair again."

Before the war kicked off in 2014, Khrapko, 45, was a carpenter, making furniture for kindergartens. At the start of the war he was mobilized and served in the 30th Mechanized Brigade of the army.

In July 2015, a year after Shevtsov was injured, Khrapko was hit during a mortar attack, also in the outskirts of Luhansk.

His injuries were much more severe. The entire left side of Khrapko's body was wounded. He had lost both an arm and a leg when he was admitted to the military hospital. He underwent over 20 operations.

The walk was Khrapko's idea; it occurred to him when an employee at the hospital told them they desperately needed a gastroscope. So he called Shevtsov and told him they needed to raise, "a few million" hryvnias. "How many exactly is a few?" asked his friend on the other end, accord-

ing to Shevtsov's account. "More than 3," his friend answered. "You will walk from Zhytomyr by foot, and I will walk to Kyiv to meet you. That's how we will raise this money."

Khrapko conceded he may have acquired some calluses after the long jaunt. "But that's not a high price," he said. "It's a drop in the ocean compared with what is happening in the east."

Al tool outperforms man in identifying stroke: study

MUNICH, May 24: Researchers from Denmark have developed a new artificial intelligence (AI) framework to address the number of strokes that go unrecognised by human emergency call handlers. The framework outperformed emergency call handlers in recognising stroke for both sexes and across all age groups studied, indicating its potential as a supple-mentary tool for early and precise stroke identification in the future.

The retrospective study, presented at the European Stroke Organisation Conference (ESOC) 2023, drew from the Danish Stroke Registry and a dataset of over 1.5 million calls made to the Copenhagen Emergency Medical Services between 2015 and 2020, including over 7000 stroke-related calls. Researchers utilized this data to train an AI framework to transcribe the call audio and then predict the risk of stroke based on the transcribed

The results, evaluated on calls from 2021, revealed that the AI framework performed more effectively than emergency call handlers in identifying stroke cases. The AI framework achieved a recall (sensitivity) of 63.0% and a precision (positive predictive value) of 24.9%, which resulted in an F1 score of 35.7. In contrast, emergency call handlers had a recall of 52.7% and precision of 17.1%, resulting in an F1 score of

Dr Jonathan Wenstrup, one of the lead authors of the study from Copenhagen University Hospital, commented, "As one of the first points of contact for patients seeking medical assistance, emergency call handlers play a critical role in facilitating early and accurate stroke recognition. Many stroke cases can go undetected at this stage, leading to delays in treatment that can have potentially life-threatening consequences for patients."

Across Europe, stroke is the second leading cause of death and a major cause of adult disability, affecting over 1 million people each year. As populations continue to grow and age, the number of people living with stroke is projected to increase by 27% between 2017 and 2047 in the EU. Despite this, many strokes can be prevented, and if treated early, the likelihood of a positive outcome can be greatly improved.

"With the implementation of this new, cost-effective supporting tool, we can enhance stroke identification and ensure more patients receive appropriate and timely care, ultimately improv-ing patient outcomes," added Dr Wenstrup.

A first-time filmmaker makes a mark in Cannes competition

CANNES, France, May 24, (AP): Most filmmakers in the Cannes Film Festival's top-rung competition lineup are well-known directors who have been around for decades. One dramatic exception this year is Ramata-Toulaye Sy, a French-Senegalese filmmaker whose first film, "Banel & Adama," landed among the 21 films competing for the Palme d'Or.

"It's only now that I realize that being in competition means being in a competition," Sy said, laughing, in an interview shortly after "Banel & Adama" premiered in Cannes. "Now that we're really in the middle of it, I realize there's a lot of passion going around."

Sy, 36, is the sole first-timer in Cannes' main lineup this year. She is also only the second Black female director to ever compete for the Palme, following Mati Diop, also a French-Senegalese filmmaker, whose "Atlantics" debuted in 2019. For the Paris-raised Sy, it's not a distinction of significance.

"I'm a filmmaker and I really wish we stopped being counted as women, as Black or Arab or Asian," said Sy.

In "Banel & Adama," also the only Africa-set film competing for the Palme this year, Sy crafts a radiant and languorous fable tinged with myth and tragedy.

Banel (Khady Mane) and Adama (Mamadou Diallo) are a deeply in love married couple living in a small village in northern Senegal. In their intimate romantic idyll, they wish to pull away from the local traditions. Adama is set to become village chief but is uninterested in doing so. Banel dreams of living outside the village, in a home buried under a mountain of sand.

Independence

While Banel and Adama slowly work to sweep away the sand, their yearning to live on their own causes angst in the village, especially when a drought arrives that some take as a curse for their independence. Though often opaque, the film stays largely with the psychology of Banel, whose single-mindedness grows increasingly

"I was quite reluctant at the start to acknowledge that Banel is me," says Sy. "Now I have to confess that it's definitely me. I see myself, my questions, my struggle in her journey. How to do become an individual inside a community is really my own question.

Sy began writing "Banel & Adama" in 2014 as a student at La

Fémis, the French film school. Sy, the daughter of Senegalese immigrants, says she was first drawn to literature. Novels like Toni Morrison's "Sula" and Elena Frenate's "My Brilliant Friend" inspired "Banel & Adama."

"The love story was a pretext for to deal with myth," she says. "I wanted to have this kind of mythological female character that you find in Greek tragedy.

Sy co-wrote Atiq Rahimi's "Our Lady of the Nile" and Cagla Zencirci and Guillaume Giovanetti's "Sibel" - both of which played at international festivals. Her first short film, "Astel," was wellreceived.

But little prepared her for the stresses of shooting in rural Senegal. Along with heat, sandstorms and bouts of illness among the crew, Sy struggled to find her Banel. In the end, she found Mane while walking around.

"We had all the cast except for her. We started five months before shooting and one month before shooting we still didn't have her. One day I was walking down the street and my eyes locked on this girl," says Sy. "It was the way that she looked at me. Her gaze had something a bit wise and a bit crazy."

Film to give fresh fodder for social-media replicas

Anderson on his '50s-set film 'Asteroid City'

CANNES, France, May 24, (AP): When Wes Anderson comes down from Paris for the Cannes Film Festival in the south of France, he and his actors don't stay in one of Cannes' luxury hotels but more than an hour down

the coast and well outside the frenzy of the festival. "When we arrived here yesterday, we arrived at a calm, peaceful hotel," Anderson said in a interview.

"We're one hour away, but it's a total normal life." Normal life can mean something different in a Wes Anderson film, and that may be doubly so in his latest, "Asteroid City." It's among Anderson's most charmingly chock-full creations, a much-layered, '50s-set fusion of science fiction, midcentury theater and about a hundred other influences ranging from Looney Tunes to "Bad Day at Black Rock."

"Asteroid City," which Focus Features will release June 16, premiered Tuesday in Cannes. Anderson and his starry cast - including Jason Schwartzman, Scarlett Johansson, Tom Hanks, Steve Carell, Margot Robbie, Bryan Cranston, Jeffrey Wright and Adrien Brody - arrived all together in a coach bus.

The film, which Anderson wrote with Roman Coppola, takes place in a Southwest desert town where a group of characters, some of them nursing an unspoken grief, gather for various reasons, be it a stargazing convention or a broken-down car. But even that story is part of a Russian Doll fiction. It's a play being performed -

which, itself, is being filmed for a TV broadcast. All of which is to say "Asteroid City" is going to give all those Tik Tok videos made in Anderson's distinct, diorama style fresh fodder for new social-media replicas, both human-made and AI-crafted. Anderson spoke about those Tik Toks in an interview the day before "Asteroid City" debuted in Cannes, as well as other questions of style and inspiration in "Asteroid City," a sun-dried and melancholic work of vintage Anderson density.

"I do feel like this might be a movie that benefits from being seen twice," Anderson said. "Brian De Palma liked it the first time and had a much bigger reaction on the second time. But what can you say? You can't make a movie and say, 'I think it's best everyone sees it twice.' **AP:** It's quite a treat to read in the movie's opening

know there's an alien. That seems to announce some-

Anderson: We naturally were debating whether this is necessary in the opening credits. I said, "You know, it's a good thing." It's a little foreshadowing. In our story, it's not a expansive role. But part of what the movie is to me and to Roman, it has something to do with actors and this strange thing that they do. What does it mean when you give a performance? If somebody has probably written something and then you study it and learn and you have an interpretation. But essentially you take yourself and put it in the movie. And then you take a bunch of people taking themselves and putting themselves in the movie. They have their faces and their voices, and they're more complex than anything than even the AI is going to come up with. The AI has to know them to invent them. They do all these emotional things that are usually a mystery to me. I usually stand

back and watch and it's always quite moving. **AP:** The alien may signal doom for the characters of "Asteroid City," and there are atomic bomb tests in the area. Is this your version of an apocalyptic movie?

Anderson: The apocalyptic stuff was all there. There probably were no aliens, but there certainly was a strong interest in them. There certainly were atom bombs going off. And there had just been I think we can say the worst war in the history of mankind. There's a certain point where I remember saying to Roman: "I think not only is one of these men suffering some kind of posttraumatic stress that he's totally unaware of, but he's sharing it with his family in a way that's going to end up with Woodstock. But also: They should all be armed. So everybody's got a pistol.

AP: Since maybe "Grand Budapest Hotel," you seem to be adding more and more frames within frames for Russian doll movies of one layer after another. Your first movies, "Bottle Rocket" and "Rushmore" are starting to seem almost realistic by comparison. Do you think your

films are getting more elaborate as you get older? Anderson: Ultimately, every time I make a movie, I'm just trying to figure out what I want to do and then figure out how to make it such that we do what I want. It's usually an emotional choice and it's usually quite mysterious to me how end up with how end up. The most improvisation aspect of making a movie to me is writing it. I have a tendency to obsess over the stage directions. which are not in the movie. With "Grand Budapest" we had multiple layers to it, and "French Dispatch" certainly had that. This one is really split in two but there's more complex layers. We know the main movie is the play. But we also have a behind-the-scenes making of the play. We also have a guy telling us that this is a television broadcast of a hypothetical play that doesn't actually

exist. It's not intention to make it complicated. It's just me doing what I want.

AP: Have you seen all the TikTok videos that have

made in your style? They're everywhere. Anderson: No, I haven't seen it. I've never seen any TikTok, actually. I've not seen the ones related to me or the ones not related to me. And I've not seen any of the AI-type stuff related to me.

AP: You could look at it as a new generation discov-

ering your films. Anderson: The only reason I don't look at the stuff is because it probably takes the things that I do the same again and again. We're forced to accept when I make a movie, it's got to be made by me. But what I will say is anytime anyone's responding with enthusiasm to these movies I've made over these many years, that's a nice, lucky thing. So I'm happy to have it. But I have a feeling I would just feel like: Gosh, is that what I'm doing? So I protect myself.

AP: People sometimes miss in your films that the characters operating in such precise worlds are deeply flawed and comic. The ornate tableaux may be exact but the people are all imperfect.

Anderson: That's what I would aspire to, anyway. In the end, it's a lot more important to me what it's about. I spend a lot more time writing the movie than doing anything to do with making it. It's the actors who are the center of it all to me. You can't simulate them. Or maybe

you can. If you look at the AI, maybe I'll see that you can. AP: In "Asteroid City," you combined an interest in really disparate ideas - the '50s theater of Sam Shepard with the automat. How does a combination like that happen?

Anderson: We had an idea that we wanted to do a '50s setting and it's got these two sides. One is New York theater. There's a picture of Paul Newman sitting with a T-shirt on and a foot on the chair in the Actors Studio. It was about that world of summer stock, behind the scenes of that, and these towns that were built and never moved into. That becomes the East Coast and the West Coat and the theater and the cinema. There's a series of dichotomies. And one of the central things was we wanted to make a character for Jason Schwartzman that was different from what he's done before. The things that go into making a movie, it eventually becomes too much to even pin down. So many things get added into the mix, which I like. And part of what the movie is about is what you can't control in life. In a way, the invention of a movie is one of those things.

It's something Holofcener thinks a lot about in her own relationships. Some years ago, she actually had the experience of dating a man who was crazy about her but didn't seem to like or get her movies.

"I tried really hard to have that not matter," she said. "But in the end, it really mattered."

After watching "Please Give," her 2010 film about a couple who fill their pricey furniture store with bargain estate sale findings, she remembered the first thing he said was that the old woman was really cranky. She was floored that that was the takeaway.

"My movies are so personal to me," she said. "I couldn't understand how someone could get me or get my sense of humor or my values or what's important to me and not enjoy my films. I still don't have an answer to that."

In "You Hurt My Feelings," Beth (Louis-Dreyfus) is a moderately successful author living in New York City with her husband Don (Tobias Menzies), a therapist whose confidence has also been shaken at work, with some memory gaps and unsatisfied patients (Amber Tamblyn and David Cross play a very unhappily married couple). Beth and Don also worry about their son (Owen Teague) who, in their eyes, is floundering in his career and personal life.

Louis-Dreyfus was able to draw on her own 35-year marriage to help paint a believable picture of this couple, who like to share food — even ice cream cones much to the horror of their son.

"We both felt very strongly that we really wanted to depict a couple who have been married for a long time but were still in love in a believable way, you know? Not saccharine and lovey-dovey," Louis-Dreyfus said. "They're very bonded to one another."

The film contains acute observations about family, marriage, gift-giving, artistic neuroses, mid-life crises and parenting adult children. It's funny and poignant and sometimes gnawingly uncomfortable and has an enviable cast of great actors, including Michaela Watkins as Beth's sister and Arian Moayed as her husband.

Filming in Manhattan with famous people can be its own headache too. Louis-Dreyfus remembered one difficult scene in which her character has just overheard her husband's confession and has to walk out of a sporting goods store looking nauseated and dry heaving on the city sidewalk. Across the street, there were paparazzi taking pictures.

"It made me feel very self-conscious," Louis-Dreyfus said. "Why would I want pictures of myself vomiting on the street?"

But they got through it and on the whole it was a lovely experience. Holofcener even said it's the most fun she's ever had on a film.

Innovate

"Maybe it's getting older," she said. "I'm calmer. A little more confident.

She loved when Louis-Dreyfus would ad-lib and innovate in scenes. One of the biggest laughs in the film is one of those impromptu additions (without spoiling, it involves a conversation about Botox).

'She gets the tone. She always surprises me," Holofcener said. "And her face just kills me."

And both were delighted to get the chance to work with Jeannie Berlin, who plays Beth's mom. It was a particular coup for Holofcener who cites Elaine May's "The Heartbreak Kid" as the movie that made her want to make movies. She even got to meet May,

Berlin's mother, at a screening.

May has seen, and loved, the film. And she's not alone. After it premiered at the Sundance Film Festival earlier this year to fantastic reviews and audience reactions, A24 decided to give the film a nationwide launch. This is both exciting and a source of anxiety for Holofcener, used to smaller openings.

Since her first film put her on the map in 1996, Holofcener has always done supplemental work, writing scripts or directing episodes of television, from "Gilmore Girls" to her most recent gig doing two episodes of "Lucky Hank" with Bob Odenkirk. But they're not just paychecks — she would do it more if that were the reason.

Holofcener grew up with a significant connection to the business: Her stepfather, Charles H. Joffe, was a talent manager and producer of most of Woody Allen's films, including "Annie Hall" and "Hannah and Her Sisters." Her mother occasionally worked as a set decorator too.

LOS ANGELES: Walter Royal, the chef of a destination steakhouse in North Carolina who triumphed as a challenger on "Iron Chef America" by cooking mostly Southern dishes with ostrich meat, has died.

The Angus Barn in Raleigh, where Royal served as executive chef since the 1990s, announced his passing on its website. The restaurant's statement said Royal died Monday at the age of 67. The announcement did not provide a cause or say where the chef had died.

The grandson of farmers, Royal grew up in rural Alabama and worked as a social worker before honing his craft under acclaimed Southern chefs, The Raleigh News & Observer reported.

Royal was already well established as a chef in the Raleigh area when he cooked before a national audience in a 2006 episode of "Iron Chef America." Judge Joel McHale said Royal used one of the world's "ugliest birds" to create one of the best desserts. It was a chocolate soufflé made with an ostrich egg.

Royal led a team challenging celebrity chef Cat Cora in a kitchen stadium format where their "secret ingredient" turned out to be ostrich. The trick, he said, was not to overcook it.

Royal prepared a Southwesternflavored ostrich burger with horseradish ketchup, Creole mustard and homemade potato chips, according to a 2007 News & Observer article. Other dishes included a soy-and-ginger ostrich satay rounded off with a peanut dipping sauce and spicy coleslaw, and a pot pie with ostrich cubes and an herbed puff pastry.

He enhanced the meat's flavor with

a rich whiskey-shallot-ostrich broth reduction, serving wilted watercress and mashed turnips and rutabagas on the side

Regarding the soufflé, Royal told The Fayetteville Observer: "The yoke of the egg is almost like butter. It's just incredible and the consistency of a wonderful

Royal was born in Eclectic, Alabama, about 30 miles (48 kilometers) northeast of Montgomery, according to his biography on the website for The National Association of Chief Executive Officers In a 2017 interview with the North

State Journal, Royal recalled a childhood of eating pecan pie, country cured ham with a glaze, fresh turkeys from his grandparents' farm and apple cobblers that were "oh, divine."

Play 'Prima Facie' challenges the legal system

Comer scales heights on Broadway

NEW YORK, May 24, (AP): The script for the play "Prima Facie" didn't languish after landing in Jodie Comer's inbox. Fitting for an urgent call for change, the script demanded action. It would not be denied.

"Sometimes when things present themselves, it's impossible to say no," says the "Killing Eve" actor. "This piece felt very, very clear to me. There was no hesitation that I felt. Sometimes that kind of gut-tural instinct really doesn't lie." It didn't matter that the script

represented Comer's first stage role. No matter that she'd be alone for some 90 minutes, even asked to move her own props. "I read it within the hour and I was like, Comer leapt in and has found

herself winning an Olivier Award in London for her performance and now a Tony nomination for best actress in a play. She's also raising her fist for women in a work that challenges the status quo.

The script was from Suzie Miller, a former criminal defense and human rights lawyer who uses the one-woman show to illustrate how current laws fail terribly when it comes to sexual assault cases.

Comer plays Tessa Ensler, a young, clever barrister who has developed a knack for getting her male clients off the hook in assault cases until she spends a night drinking with another barrister and he rapes her.

Now, instead of donning a fancy wig as a crown prosecutor, she's left shaking in the witness box. Why isn't her evidence presented in a clean, logical package? She must relive her nightmare in court with her motives questioned. And justice may hinge not on the actions, but on whether the perpetrator believed he had consent.

"A woman's experience of sexual assault does not fit the male-defined system of truth. So it cannot be truth, and therefore there cannot

be justice," she says in the play.
"Prima Facie" - a legal term
meaning "on the face of it" - has
already created shock waves in England. A filmed version is now compulsory viewing for new judges, and Miller says a judge who saw her play has redrafted the spoken directions juries are given in sexual assault matters. The play has inspired efforts to change Brit-

Both Comer and Miller get hundreds of messages a week from women telling their own stories of assault, some telling about it movement fueled by #MeToo.

Comfort

"I'm really trying to savor every second of it because not every piece of work creates this sort of conversation or space," says Comer. "That is the biggest reward of all -when you are a part of a piece like this and people genuinely feel represented. That it is a source of comfort."

To win a Tony on June 11, Comer must beat Jessica Chastain in "A Doll's House," Jessica Hecht in "Summer, 1976" and Audra McDonald from "Ohio State Murders."

In terms of sheer physicality, Comer earns it every night. She moves tables together, jumps up on them, sits in rain, uses various voices and performs her own character's rape.

"It really helped me build my kind of mental resilience, even though I have moments that is absolutely challenged," she says. "I would say what I've learned from this experience is that you have to take care of vourself.'

Miller was inspired to write "Prima Facie" by the years she spent as a lawyer taking statements from hundreds of women who had been sexually assaulted. "Not a single one of them who went to trial actually ended up having a conviction," she says. "The worst things is they're all so similar."

Her first play, "Cross Sections," was about the homeless and the desperate living in the red-light district in Sydney, Australia, a work which humanized what many believed were throw-away people.

"After I wrote that there was a lightning bolt moment for me, which was, 'Oh, wow, stories really can make people empathize hink about things

Miller has since taken up the baton of V - the "Vagina Monoplaywright formerly logues" known as Eve Ensler, who brings social messages to her work. It is no coincidence that Miller named the heroine of "Prima Facie" Tessa

The idea of battling the establishment also attracted Comer, an Emmy Award and BAFTA winner, who grew up in the working class of Liverpool and has had to shapeshift in order to succeed, like her character. When she was auditioning for

theater roles, she was rebuffed because she hadn't attended drama school. "There was a lot of feedback of like, 'She's not trained. It's too big a task,'" she recalls.

The producers of "Prima Fa-

cie" didn't ask her to audition and didn't mind she hadn't attended drama school.

'They didn't see it as this kind of hindrance. And so I guess the stars all aligned at the right time," Comer says. "This is beyond anything I could have ever dreamed."

in Britain that he was once granted the rare privilege of painting a portrait of Queen Elizabeth II. But his TV career, which spanned

half a century, collapsed in 2013, when he was arrested in Britain in relation to sexual abuse allegations. Many were left in disbelief when in July

2014 Harris was found guilty of 12 counts of indecent assault on four young girls from the 1960s to the '80s. Prosecutors said he had a "Jekyll and Hyde" personality and used his fame to exploit his victims.

Among the victims was a friend of Harris' daughter, who claimed he molested her from age 13 to 19.

But a jury convicted him of all charges, and a judge sentenced him to five years and nine months in prison.

Harris was released on license in May

2017. Harris had enjoyed a 60-year career as a successful television presenter. songwriter and artist. He was best known for his children's television shows such as "Rolf's Cartoon Time" and "Animal Hospital," and had a number of hit songs in the 1960s.

Born in 1930, Harris grew up in a suburb of Perth, Australia, and was an award-winning swimmer as a teenager. After several failed attempts at art school, Harris launched his television career with a slot on a BBC show in 1952.

As well as hosting children's shows like "Rolf's Cartoon Club," Harris was also known in the '60s for performing popular songs including "Two Little Boys," which became a No. 1 Christmas hit in Britain. (AP)

DEA dragged feet

US drug distributors fueled 'opioid crisis'

SHREVEPORT, La., May 24, (AP): The US Drug Enforcement Administration has allowed one of the nation's largest wholesale drug distributors to keep shipping highly addictive painkillers for nearly four years after a judge recommended it be stripped of its license for its "cavalier disregard" of thousands of suspicious orders fueling the opioid crisis.

The DEA did not respond to repeated questions from The Associated Press about its handling of the case against Morris & Dickson Co. or the involvement of a high-profile consultant the company had hired to stave off punishment and who is now DEA Administrator Anne Milgram's top deputy.

But the delay has raised concerns about how the revolving door between government and industry may be impacting the DEA's mission to police drug companies blamed for tens of thousands of American overdose deaths.



'If the DEA had issued its order in a timely manner, one could then credibly believe that its second-in-command was not involved despite an obvious conflict of interest," said Craig Holman, an ethics expert at the watchdog group Public Citizen in Washing-The mere fact that its action has been delayed four years just raises red flags. It casts the entire process under grave suspicion.' Last week, after the AP reached

out to the DEA for comment, the agency broke its silence on the issue

and abruptly notified Morris & Dickson that it has decided to revoke its registration to distribute controlled substances, according to two people familiar with the development who spoke on the condition of anonymity to discuss the exchange. However, no final order has yet been published. The company has described revocation as a "virtual death sentence" and is almost certain to challenge the decision in

Louis Milione, who was named DEA's principal deputy administrator in 2021, did not respond to requests for com-

Controls

He retired from the DEA in 2017 after a storied 21-year career that included two years leading the division that controls the sale of highly addictive narcotics. Like dozens of colleagues in the DEA's powerful-but-little-known Office of Diversion Control, he quickly went to work as a consultant for some of the same companies he had been tasked with regulating, including Morris & Dickson.

Milione was brought in by Morris & Dickson as part of a \$3 million contract to save its registration to supply painkillers after the DEA accused the company in 2018 of failing to flag thousands of suspicious, high-volume orders.

Testifying in 2019 before federal Administrative Law Judge Charles W. Dorman, Milione argued that Morris & Dickson "spared no expense" to overhaul its compliance systems, cancel suspicious orders and send daily emails to the DEA spelling out its actions.

But those efforts were too little, too late, the judge wrote in a 159-page recommendation which has not been previously reported and was recently obtained by the AP. Anything less than the most severe punishment, he said, "would communicate to DEA registrants that despite their transgressions, no matter how egregious, they will get a mere slap on the wrist and a second chance so long as they acknowledge their sins and vow to sin no more.

"Acceptance of responsibility and evidence of remediation are not get-out-of-jail-free cards that erase the harm caused by years of cavalier disregard," Dorman wrote. "Allowing the respondent to keep its registration would tell distributors that it is acceptable to take a relaxed approach to DEA regulations until they are caught, at which point they only need to throw millions of dollars at the problem to make the DEA go away.

Shreveport, Louisiana-based Morris & Dickson, the na tion's fourth-largest wholesale drug distributor with \$4 billion a year in revenue and nearly 600 employees, did not respond to requests for comment. But the company repeatedly said in court filings that losing its license would effectively shut it down and have a "catastrophic" effect on patients in

Neither Milgram nor two DEA administrators who preceded her have taken any enforcement action since Dorman's 2019 recommendation, allowing Morris & Dickson to continue operating even as it pursued a potential settlement. Former DEA officials told AP a nearly four-year wait in such a case is highly unusual, noting it rarely takes the agency more than two years to issue a final order.

Milgram's management of DEA has been called into question on another front. AP reported last month that a federal watchdog is investigating whether the agency improperly awarded millions of dollars in no-bid contracts to hire Milgram's past associates.

As for Milione, federal ethics rules bar government employees from taking part in decisions that could benefit companies where they previously worked, but DEA did not respond to questions about whether Milione recused himself from the matter. He would have also faced restrictions on his interactions with the DEA when he left government as a senior official - an issue the agency's own lawyers raised in an attempt to disqualify his testimony in support of Morris & Dickson.

Compliance

Milione, a lawyer and former bit Hollywood actor, impressed fellow DEA agents for his risk taking and toughness. Among his achievements was running the overseas sting that in 2008 nabbed Russia's notorious arms trafficker Viktor Bout, aka "The Merchant of Death."

But after taking over as the head of Diversion Control in 2015, he ended his predecessor's refusal to meet with drug manufacturers and distributors and opened the DEA's doors to the industry it was charged with regulating.

Among those Milione met with on at least two occasions was Paul Dickson Sr. - then-president of Morris & Dickson. That included a 2016 visit to the Louisiana headquarters with DEA investigators to discuss the company's compliance pro-

John Gray, the head of the Healthcare Distributors Alliance, a lobbying group that includes Morris & Dickson, recounted in a 2015 email how Milione, under orders from then-incoming DEA Administrator Chuck Rosenberg, wanted to "reset" relations with the drug industry. And Milione even delivered the keynote speech at the group's annual

"Overall, he was engaging, exceedingly pleasant and seemed genuinely concerned that we had lost touch with each other," Gray wrote. "It is a very different tone and approach than we have all seen in the past 8-10 years."

Morris & Dickson had been punished for its mishandling of addictive drugs before. In 2019, before Dorman issued his recommendation, the company agreed to pay \$22 million in civil penalties to resolve federal prosecutors' claims that it violated the Controlled Substances Act by failing to report suspicious orders of hydrocodone and oxycodone. The company also agreed to multimillion-dollar upgrades of its compliance program to ensure it reports suspicious orders mov-

The case drew far less attention than the enforcement actions DEA took in recent years against Morris & Dickson's larger competitors, a trio of pharmaceutical distributors who have agreed to pay the federal government more than \$1 billion in fines and penalties for similar violations. Cardinal Health, AmerisourceBergen and McKesson also agreed to pay \$21 billion over 18 years to resolve claims as part of a nationwide settlement.

Rita scales Everest for 28th time: Veteran Sherpa guide Kami Rita has scaled Mount Everest for the 28th time Tuesday, beating his own record less than a week after setting it, as two guides compete with each other for the title of most

climbs of the world's highest peak. Kami Rita, considered one of the greatest mountain guides, reached the 8,849-meter (29,032-foot) summit at 9:20 a.m. local time Tuesday, according to ex-

pedition organizer Seven Summits Treks. His latest climb comes a day after fellow Sherpa guide Pasang Dawa matched his record of 27 trips to the summit.

The race for the title began with Pasang Dawa climbing the peak for the 26th time on May 14, equaling Kami Rita's previous record. Kami Rita went on to the peak three days later for the 27th time.

With a few more days left in the spring climbing season, both Sherpa guides were on the mountain helping their clients up the snowy peak. May is the busiest month to make the dangerous climb since it has the best weather conditions.

Kami Rita first summitted Everest in 1994 and has been making the trip nearly every year since. He is one of many Sherpa guides whose expertise and skills are vital to the safety and success each year of foreign climbers who seek to stand on top of the mountain. (AP)

Foam contaminates public water: Firefighting foam used in battling a fatal fire in an apartment building entered the public water system, prompting the water district to order thousands of residents not to drink the water.

The do-not-drink order went into effect Monday for about 9,000 Kennebec Water District customers in Waterville, Winslow, Benton, Fairfield and Vassalboro. Testing was being conducted Tuesday to determine whether the water is safe to

The foam used by Waterville fire-fighters is presumed to contain PFAS chemicals, a group of compounds that are widespread, dangerous and expensive to remove from drinking water, but the foam is advertised as being free of fluorine, another compound sometimes used in firefighting foam, said Fire Capt. Edward Moult.

"While the extent of the contamination is unclear, out of an abundance of caution, Kennebec Water District is issuing a system-wide Do Not Drink Order," the water district announced Monday.

The foam entered the public water distribution system as firefighters battled a blaze in an apartment building for seniors.

New easy-to-use therapy to reverse overdoses

FDA approves overdose nasal spray

WASHINGTON, May 24, (AP): US health regulators on Monday approved a new easy-to-use version of a medication to reverse overdoses caused by fentanyl and other opioids driving the nation's drug crisis.

Opvee is similar to naloxone, the life-saving drug that has been used for decades to quickly counter overdoses of heroin, fentanyl and prescription painkillers. Both work by blocking the effects of opioids in the brain, which can restore normal breathing and blood pressure in people who have recently

The Food and Drug Administration endorsed Opvee, a nasal spray update of the drug nalmefene, which was first approved as an injection in the mid-1990s but later removed from the market due to low sales. Naloxone comes as both a nasal spray and injection.

It's not immediately clear how the new drug will be used differently compared to naloxone, and some experts see potential downsides to its longeracting effect. The drug will be available via prescription and is approved for patients 12 and older.

In studies funded by the federal government, Opvee achieved similar recovery results to Narcan, the leading brand of naloxone nasal spray.

Opvee was developed by Opiant Pharmaceuticals, which was recently acquired by rival Indivior, maker of several medications for opioid addiction. Indivior expects to launch Opvee in October at the earliest.

As the opioid epidemic has shifted to fentanyl and other synthetic opioids, researchers in the pharmaceutical industry and the U.S. government saw a new role for the drug.

Because fentanyl stays in the body longer than heroin and other opioids, some people may require multiple doses of naloxone over several hours to fully reverse an overdose.

Scientists at the National Institutes of Health worked with pharmaceutical researchers on a nasal spray version of nalmefene that would quickly resuscitate users, while also protecting them from relapse. Testing and development was funded by more than \$18 million in grants from the U.S. government's Biomedical Advanced Research and Development Authority and the NIH, which also helped design the studies.

"The whole aim of this was to have a medication that would last longer but also reach into the brain very rapidly, said Dr. Nora Volkow, director of the National Institute on Drug Abuse.

Still, some experts see potential downsides.

A side effect of all opioid reversal drugs is that they create intense withdrawal symptoms including nausea, diarrhea, muscle cramps and anxiety. With naloxone, those symptoms might last 30 to 40 minutes.

Dr. Lewis Nelson of Rutgers University says those problems can last six hours or more with nalmefene, requiring extra treatment and management by health professionals.

"The risk of long-lasting withdrawal is very real and we try to avoid it," said Nelson, an emergency medicine physician and former adviser to the FDA on opioids.

Nelson said it's easy enough to give a second or third dose of naloxone if it wears off.

"We're not suffering from a naloxone shortage where we need to use an alternative," he said. "We have plenty of it and it works perfectly well.

Pandemic

The FDA approval comes as drug overdose deaths inched up slightly last year after two big leaps during the pandemic. More than 109,000 fatal overdoses were recorded in 2022, according to the latest figures from the Centers for Disease Control and Prevention.

More than two-thirds of those deaths were linked to fentanyl and other synthetic opioids, which have largely replaced heroin and prescription opioids.

Naloxone has long been at the center of government efforts to fight the overdose crisis at the federal and local levels. Police, firefighters and other first responders routinely carry the drug. And officials in all 50 states have given orders to pharmacists to sell or dispense the drug without a prescription to anyone who wants it. In the latest federal push, the FDA re-

cently approved Narcan to be sold over the counter. The change will allow the new version of the drug to be stocked in grocery stores, vending machines and other retail locations. The nasal spray which includes updated instructions for regular users - is expected to launch this summer. Emergent Biosolutions hasn't yet announced a price for the over-thecounter version.

Indivior said it is still considering what to charge for its drug. It will compete in the same market as naloxone, where most buyers are local governments and community groups that distribute to first responders and those at risk of overdose. Indivior has told investors that Opvee could eventually generate annual sales between \$150 million to \$250 million.

MADRID, May 24, (AP): Valencia will appeal the partial closure of its stadium following the racial abuse directed at Real Madrid forward Virginia in a Stantish leaves Vinícius Júnior in a Spanish league match, saying the punishment is "unfair and disproportionate."

Spanish soccer's competition committee late Tuesday fined Valencia in 45,000 euros (\$48,500) and closed one of the sections of Mestalla Stadium for five games in what is the strongest ever punishment for a club in a case of racism in Spain.

The punishment was part of a strong response by soccer officials and Spanish authorities following an outpouring of support for Vinícius after he was targeted by Valencia fans on Sunday.Late Tuesday, about 100 Brazilian protestors gathered outside the Spanish consulate in Sao Paulo to condemn the racist abuse against Vinícius. The protesters chanted "La Liga is racist" and "end with racism in Spain and in Brazil" for about an hour.

Vinícius, who is Black, has been subjected to repeated racial insults since he arrived to play in Spain five years ago. The 22-year-old Brazil forward heavily criticized Spain and its lack of action against racism after the latest incident against him.

"Valencia wants to express its complete disagreement and indignation over the unfair and disproportionate penalty imposed by the com-petition committee," the club said in a statement early Wednesday. "Valencia wants to publicly denounce that the evidence shown by the committee contradicts what the police and La Liga say. This sanction is based on evidence that the club has not been able to see.

Valencia also complained that it was not given a chance to defend itself before the ruling was made. The club said it has been cooperating with police from the start and has acted strongly to condemn what happened at its stadium.

Valencia said not long after the game it would work with authorities to identify those responsible for the abuse, and a day later it banned one person for life for being involved in the incident against Vinícius.

With the club's cooperation, police arrested three people on suspicion of a hate crime for their allege abuse against the Brazilian on Sunday, with all being banned for life from the stadium. The the club said that was the maximum punishment it could impose.

"To punish fans who were not involved in these lamentable incidents is a measure completely disproportionate, unfair and unprecedented," Valencia said. "We will fight against it until the end."

The three people spoke to police and were set free as the investigation against them continues. Four other people were detained in Madrid after being accused of hanging an effigy of Vinícius off a highway bridge in

Fans have been fined and banned

Spain created a specific law against violence, racism, xenophobia and intolerance in sports in 2007, and since then an anti-violence commission composed of several entities has been in charge of monitoring and denouncing cases that may break the

But the current legislation stipulates that not all cases of racism can be punished criminally, only those in which there is an extra element affecting the victim. Most cases, including many similar to the ones involving the fans in Valencia, end up falling into a category in which punishment only includes fines and bans from stadiums.

Valencia, which is still fighting against relegation to the second division, has one home game left in the league this season, against Espanyol on Sunday. Espanyol is also trying to avoid demotion. Valencia is in 13th place, five points from the relegation

The section of Mestalla that will be closed is where the insults against Vinícius came from, behind one of the goals. It's also where the club's more hardcore fans usually are lo-

The committee late Tuesday also rescinded the red card shown to Vinícius after an altercation with Valencia players late in the game, saying video review did not show the referee images of the full altercation, including the part in which the Brazilian was grabbed from behind by an opponent.

The highly unusual decision drew

surprise by many. Acts of racism and insults must be censored, but what happens on the field is different," Barcelona coach Xavi Hernandez said. "It's clear that there was an aggression by Vinícius and I am surprised that they took away the red card. One thing has nothing to do with the other."

Vegas 1 win from another Stanley Cup Final

Golden Knights shut out Stars in Game 3

DALLAS, May 24, (AP): The Vegas Golden Knights kept their composure and got the best payback after an ugly hit early against their captain.

They have a 3-0 series lead in the Western Conference Final and are now just one more win away from making it to another Stanley Cup Final.

Ivan Barbashev scored a powerplay goal after Dallas Stars captain Jamie Benn was ejected because of his hit on Mark Stone less than two minutes into the game. That was the second of three goals the Golden Knights had in the first 7 1/2 minutes, leading to an early exit for goalie Jake Oettinger as they won 4-0 in Game 3 on Tuesday night.

"You keep your composure," said Alex Pietrangelo, who added a goal midway through the second period.

After the two captains collided near the blue line and Stone fell to the ice, Benn lunged forward with both hands on his stick and made contact near Stone's neck as he was sliding over the center line.

"We're upset when we see that, he's our captain," coach Bruce Cassidy said. "But at the end of the day, they make a call that gives us a chance to make them pay for the penalty. And we did with one goal anyway, so we've doubled our lead. ... Do it the right way. That's been our mindset all along." While Oettinger had the shortest start of his career, Vegas goalie Adin Hill stopped 34 shots in his first career postseason shutout. Hill also became the second Knights goaltender with a five-game winning streak this postseason - Laurent Brossoit won five in a row before an injury.

ICE HOCKEY

After four consecutive comeback victories in these playoffs, including two overtime wins at home to start the best-of-seven series, the Golden Knights were in control all of the way in this one

Game 4 is Thursday night, when Vegas will have the opportunity to advance to its second Stanley Cup Final in the franchise's six seasons.

The Golden Knights were Western Conference champions during their inaugural 2017-18 season, then lost the Cup Final in five games after winning the opener against the Washington Capitals. Vegas missed the playoffs for the only time last season, before coach Pete DeBoer was fired and became the Stars coach.

Johnathan Marchessault scored only 71 seconds into the game, which was only 42 seconds before Benn was assessed a game misconduct after a five-minute major for cross-checking.

Oettinger was pulled and replaced by Scott Wedgewood after William Carrier's backhander made it 3-0 with 12:50 left in the first period.

The 24-year-old Oettinger has now lost three starts in a row. He has lost four of five overall, the win being when he had 22 saves for the Stars in their 2-1 win in Game 7 of Western semifinal against Seattle.


Wedgewood stopped 10 of 11 shots, with Pietrangelo's goal coming just a second after the end of a power play as Miro Heiskanen was coming out of the penalty box.

Stars center Max Domi got a game misconduct with 21 seconds left in the second period. After his cross-check against Nicolas Hague, Domi started throwing punches.

"I think you guys know exactly what was being discussed," Hague said when asked about what led to that incident. "There's no reason for me to get involved in anything. Pricing defended

6.8 million tickets sold so far: organizers of Paris Oly

PARIS, May 24, (AP): Organizers of the Paris Olympics said they have sold available with 14 months left before the opening ceremony and brushed off criticism that prices are too high.

Tony Estanguet, the organizing committee president, said the second ticketing phase that ended last week exceeded expectations despite some fans - and athletes - complaining about hefty prices.

The most expensive tickets are 2,700 euros (\$2,900) for the opening ceremony, and the sports with the highest prices are the athletics, swimming and basketball finals. The cheapest tickets are 24 euros (\$26) and were quickly snapped up, leaving just 200,000 low-cost seats available in a later round to the frustration of many buyers.

A key goal was to keep a large amount of tickets affordable, said Estanguet, citing that the 5.3 percent of tickets that cost 400 euros each are guaranteeing that four million seats can be bought for 50 euros

"There is a very big appetite among the public, French and international," Estanguet said. "It is an important success in terms of sales. It's rather a good news for the Paris 2024 Games.'

A total of 5.2 million tickets have been sold to the general public million going to corporate partners

During the second phase only for the sale of individual tickets and which saw four million people register for the draw - a total of 1.89 million tickets were sold in 178 countries. Fifty-eight percent of those went for 100 euros or less.

"Our goal was to sell 1.5 million tickets and we were more successful than expected," Estanguet said. Some

610,000 seats were sold at 24 euros, he added. More tickets will



be put on the market this summer, without a lottery, and a resale platform is set to open in 2024. Estanguet said "in volume and price,

there are very affordable tickets that have been put on sale, and bought." More than 3.25 million tickets were sold in the first phase earlier

this year, featuring packages for multiple sports. Organizers did not give a detailed

breakdown by country but said the

Sociedad strengthen hold on final CL spot MADRID, May 24, (AP): Barcelona

forward Raphinha took off his jersey and revealed his message of support for fellow Brazilian Vinícius Júnior.

The message, which included antiracism words in Portuguese and the phrase "we are together, Vini," was on his undershirt and visible when Raphinha was substituted off in the second half of Barcelona's 3-1 loss to Valladolid. He raised his right fist while leaving the field.Real Sociedad strengthened its hold on the final Champions League spot with a 1-0 home win over 10-man Almeria.

It was the first matchday in the Spanish league since the outpouring of support for Vinícius Júnior following the latest case of racial abuse against the Real Madrid star forward on the

weekend. Vinícius, who is Black, has been subjected to repeated racist taunts since he arrived in Spain five years ago. Since the Spanish league season began in September, he has experienced racist abuse by fans of at least five rival teams, including Valencia on Sunday.

Barcelona's second consecutive defeat since clinching the title with games to spare was overshadowed by

the fallout from that. Players from Barcelona and Valladolid held a banner before the match with the words "racists out of football." which is one of the slogans of a campaign against racism launched jointly by the Spanish league, Spanish federation and the government's top sports authority.

Anti-racism slogans were also shown during the national and international broadcast of the game.

The win moved Valladolid three points clear of the relegation zone. The club owned by former Brazil striker Ronaldo can stay safe going into the last two rounds if Getafe fails to win at Real Betis on Wednesday.

Barcelona was coming off a 2-1 loss to Real Sociedad at home after securing its first Spanish league title since 2019 in the previous round.

Valladolid, which had lost five straight matches, took a 3-0 lead with an own-goal by Barcelona defender Andreas Christensen and with goals from Cyle Larin and Gonzalo Plata. Robert Lewandowski, the league's leading scorer, netted late for Barce-

"Beating Barcelona gives us a lot of confidence going forward," Plata said. "Now we have two finals left and hopefully we can reach our goal of
