



Palestine needs liberation leadership, not profiteers

DESPITE all the Arab and Palestinian appeals, the Israeli voice is still dominant in the world. Many of the world leaders declared "Israel's right to defend itself" as a result of the attack of the "Al-Qassam Brigades" on the colonies and military bases adjacent to the Gaza Strip.

It is true that the barbaric Israeli aggression cannot be tolerated. However, what did the leaders of the Palestinian factions and the Arab and Islamic governments do other than condemn and denounce it?

In fact, even aid is still prevented from reaching the residents of the Gaza Strip, and in return, all we do is insult and distrust

It is clear from the reports published in the media and social media, which is immersed in the game of insult and distrust, that

what is required of the people of the Gulf Cooperation Council alone is to rise up for martyrdom, while the blood investors are amassing their wealth. Irrespective of whether they are lead-

ers of factions or countries, or parties that have dominated the media scene for years and portrayed themselves as a regional power, claiming that they are "ready to throw the Israelis into the sea", when the hour of truth came, they contented themselves with resonant speeches!

This has been the Arab reality for seven decades, as more than one million and one hundred thousand people were killed and about six million Pal-

estinians were displaced in the diaspora. There are factions and leaders still emerging on a daily basis. Since 1917, the Palestinian arena has witnessed dozens of those who led the resistance to defeat the "Balfour Project" and then

liberate the occupied territories. However, they used to and still continue to exploit the issue for their personal interests. Irrespective of the current situation, it is the result of historical consequences in which the issue was misunderstood, which led to it being wasted on the altars of regional and international interests.

We therefore ask the Palestinians - What do they expect from the Arab people when they see that the leaders of the factions have devoted themselves to serving Iranian interests?

This issue was a Libvan investment, during the days of Gaddafi, Saddam Hussein and before him Abdul Karim Qasim, the Iraqis, Syria and others. They carried out killings, assassinations

and bombing in Kuwait, Saudi Arabia, and the Emirates. Today, they have sided with the Houthi group, the Iraqi militias, and the Lebanese "Party of Satan" in the aggression against Saudi Arabia, the UAE, and Bahrain in response to Iran's orders. All of this happened because the leaders of the Palestinian factions abused their cause and put their personal interests ahead of the interests of millions of their people.

Today, they are brazenly asking for more, not to save Gaza, but to exploit the suffering of its people in the hideous bidding market. Let us say it openly - Israel, and the Western world should not have been silent about what happened on October 7, and what happened 17 years before that.

This reminds us of what the United States did when the Japanese "kamikaze" attacked Pearl Harbor in 1941. At that time, Japanese estimates were that Washington, which had not yet entered the war, could pose a threat in the future, so this was a major attack. However, retaliation was postponed until the United States possessed nuclear weapons. The response thus came four years later with the dropping of two atomic bombs on Hiroshima and Nagasaki, which forced the emperor to announce defeat via the radio, and occupation of Japan.

The world did not remain silent despite the scenes of destruction and hundreds of thousands of deaths, because it considered what it did as "self-defense."

I cite this example to indicate that, when you are not in a position to realize the reaction to what you intend, you should not commit a destructive act, as happened in the "Al-Aqsa Flood." Therefore, there is no benefit now in crying over spilled milk.


What is required is to learn lessons, especially with regard to the Palestinian issue, whose leaders have done more harm than others, and to realize that "vinegar eel is in it and is part of it."

It remains to say that Palestine must have one capable authority that can make decisions without the interference of blood merchants and paid faction leaders.

Kuwait deplores Israeli attack on Qatar aid center

US sanctions target money transfers from Iran to Gaza

WASHINGTON, Nov 14, (Agencies): The United States on Tuesday said it imposed a third round of sanctions on a group of Hamas officials, members of the Palestinian Islamic Jihad who work to transfer money from Iran to Gaza, and a Lebanese money exchange service

that facilitates the transfers. The Treasury Department sanctions, coordinated with the United Kingdom, come in response to the surprise Oct. 7 attack by Hamas on Israel that left roughly 1,200 people dead or kidnapped. The sanctions block access to U.S. property and bank accounts and prevent the targeted people and companies from doing business with Americans.

This and two previous rounds of sanctions against Hamas and its affiliates are aimed at protecting the international financial system from abuse by Hamas militants and their enablers, the Treasury Department said.

The State Department also is designating a Palestinian Islamic Jihad military leader for diplomatic sanctions.

quality post-invasion damage KUWAIT CITY, Nov 14, (KUNA): Improving the quality of Kuwaiti soil that had largely been contaminated as a result of

crude spills caused by the 1990 Iraqi invasion is a significant part of environmental protection, the oil ministry said on Tues-Such a measure will be instrumental in rectifying the damage inflicted on Kuwaiti soil more than three decades ago, the oil ministry's public relations chief Dr. Tamather Al-Sabah

told a ministry-organized panel discussion on future environ-

mental endeavors. Iraqi forces had set more than 700 oil wells ablaze to trigger the "biggest environmental catastrophe" in history, according to Dr. Mohammad Al-Qahtani, who is in charge of the ministry's soil-related projects, most of which are being carried out in northern and southern areas, he said.

Numerous innovative techniques are utilized in these projects that aim to improve the quality of Kuwaiti soil, he underlined, citing biological treatment as one of many effective cleansing methods that go into such endeavors.

State-run Kuwait Oil Company's soil-related projects chief Muthana Al-Mumen listed a number of recent programs that have been completed, chief among them a "green cover project" that covers some 30 square kilometers, he said.

WASHINGTON: The US Special Envoy for Yemen Tim Lenderking is traveling to the GCC this week to advance ongoing UN-led peace efforts in Yemen and support regional coordination to reach a durable end to the conflict, said the State Department late Monday.

The State Department added in a statement "the United States is committed to securing a peaceful resolution to the Yemen conflict. We are working closely with our partners to support peace efforts under UN auspices and alleviate the immense suffering the conflict has caused." (KUNA)

LUCKNOW, India: Rescuers are working around the clock Tuesday to remove debris to extract 40 workers who have been trapped for over two days after an underconstruction tunnel collapsed in

northern India. A 2.5-foot (0.76 meter)-wide steel pipe will be pushed through an opening of excavated debris with the help of hydraulic jacks to safely pull out the stranded workers, authorities said. (AP)

KATHMANDU: Nepal's government decided to ban the popular social media app TikTok on Monday, saying it was disrupting "social harmony" in the country.

The announcement was made following a Cabinet meeting. Foreign Minister Narayan Prakash Saud said the app would be banned immediately. (AP)

KUWAIT CITY, Nov 14: The Minister of Health Dr. Ahmad Al-Awadhi affirmed that Kuwait is striving to improve the provision of excellent health care services to all citizens and

He stressed the keenness of the Ministry of Health to host specialized medical conferences, enhance cooperation, and exchange of experiences among specialists with the aim of improving methods of prevention and treatment of diseases

This was said in a speech delivered by the Assistant Undersecretary for Allied Medical Services Affairs Dr. Abdullah Al-Faras on behalf Dr. Al-Awadhi yesterday afternoon at the opening of the 45th Kuwait Conference on Ear, Nose and Throat Surgery.

The minister said, "The conference was attended by an elite group of specialized doctors from around the world, which enhances maximum benefit in the scientific and medical fields, as well as enhances cooperation to discuss matters of common interest."

Job lost for disobeying orders

KUWAIT CITY, Nov 14: The Misdemeanor Court, presided over by Judge Abdul Rahman Al-Huraiji, ruled to remove the Secretary-General of the General Secretariat of Awqaf from his job and fine him KD 3,000 for refraining from implementing a million-dinar ruling in favor of a Kuwaiti citizen.

The citizen confirmed in his complaint that this crime was stipulated in article 58 (bis) of the Kuwaiti Penal Code, as follows: The penalty shall be imprisonment for a period not exceeding two years and termination of any competent public employee who intentionally abstains from implementing an enforceable judicial ruling 30 days after

'Chronic crowds, odd work hours at MoH clinics cause for concern'

"Ensuring the highest level of performance in the government health sector, aligned with international standards, is imperative, especially in an oil-rich country like ours," columnist Eng **Ahmad Abdel Hadi Al-Sadhan** wrote for **Al-Rai** daily.

"The availability of medical services should be seamless, accurate, and expeditious. Recognizing the pivotal role of the Ministry of Health in our society, responsible for all medical services, is crucial for maintaining health stability, combating epidemics, and overseeing the establishment of hospitals and medical centers.

"The commendable efforts of the medical and supportive staff during the (Corona) pandemic underscore their significant contribution.

"However, based on my perspective and firsthand experiences, this vital sector requires enhanced organization and arrangement. For instance, some emergency clinics in hospitals experience severe and chronic overcrowding.

"Another notable concern is the limited working hours of the clinic in Al-Siddiq area, which oper-

ates only in the morning despite the substantial local population. The absence of dental or laboratory specialization during that period necessitates residents to travel to the Al-Zahra'a area clinic, further burdening it and contributing to overcrowding. Similar challenges exist in vari-



"Additionally, the dental center affiliated with Jaber Hospital Eng. Al-Sadhan faces significant delays in dental

implant appointments, spanning months. Attempting to contact the internal clinic number for inquiries or appointment modifications often proves nearly impossible, leading individuals to wait for

"Some suggest resorting to the private sector for faster service, despite the associated costs. Engineering observations also reveal subpar finishes related to the flooring in some areas of Jaber Hospital and the new Farwaniya Hospital. These finishes should be of the highest quality, durable, and serve for decades, raising concerns about their current

"This message underscores the need to address engineering matters comprehensively. The Committee for Treatment Abroad requires development, and various topics and files within the Ministry of Health demand decisions and reforms.

"The collaboration of the government and the National Assembly is vital to advancing the medical sector, given its direct impact on people's lives, illnesses, and pain. Timely and decisive action is imperative, and we seek the guidance and support of God Almighty in all circumstances.'

"At the recent meeting of the Interior Ministers of Gulf Cooperation Council (GCC) countries, decisions were taken to address security issues and implement ambitious projects that will diversify sources of income to wean the nation from its dependence on oil," columnist Tariq Hamada wrote for **Al-Anba** daily.

a comprehensive Gulf strategy to combat drugs is extremely important at this stage. I have previously called for Gulf coordination to confront the drug scourge, especially in the presence of organized gangs trying various ways to pump huge quantities of narcotic substances into GCC countries.

"The unified security strategy could strengthen cooperation and integration. It relies heavily on the rapid exchange of information, expertise and the latest smuggling methods, all of which contribute to tightening control over innovative smuggling methods, drying up the sources of this scourge, and prosecuting perpetrators.

"In addition, the unified Gulf tourist visa project contributes to the smooth movement of residents and tourists between the six GCC countries. Undoubtedly, there will be a positive impact on the economic and tourism sectors, especially Kuwait, which is heading towards obtaining an important share of global tourism. This will play a role in saving hundreds of millions of Kuwaiti dinars that citizens spend annually on external

"Tourism is a major source of income for many countries. It is an industry with foundations and rules, hence, the need to prioritize it. The local tourism sector should be developed by promoting Kuwait's winter weather to attract more tourists who want to enjoy the winter atmosphere that distinguishes the country

"Linking traffic violations electronically has positive effects, because it has achieved traffic safety goals. It is a clear signal for any violator that he will be prosecuted when he violates the Traffic Law when he is in any Gulf country. He will pay the corresponding fine. If he is sentenced to jail, the sentence will be implemented even if he is in his home country, so there is no choice for anyone but to strictly comply with the Traffic Law.

"First Deputy Prime Minister and Minister of Interior Sheikh Talal Al-Khaled caught my attention when he highlighted the cybercrimes committed by organized international gangs and professional hackers, as well as Kuwait's efforts to establish a specialized center for cybersecurity.

"Transnational fraud crimes cannot be controlled alone, because they are often carried out in other countries – outside the countries where victims are residing. Gulf, regional and international cooperation is needed to confront and limit them. Kuwait started such confrontation by attracting national competencies armed with technological expertise and skills to form a wall against the repeated attempts of piracy gangs."

"Most members of our society are retirees. They do not benefit from certain privileges, considering the heavy pressure and obligations on their shoulders," columnist Dr Essa Al-Omairi wrote for Al-

"Those who belong to this segment, which is dear to all of us, have served the State honestly and sincerely. They created and laid down foundations for the generations after them. They gave time and effort to this country and spent their lives serving it, so the State is obligated to do everything necessary

"In terms of monthly obligations, there have always been proposals to support retirees and make life easier for them. One of the important suggestions is to find an effective mechanism for alleviating the suffering of those who defaulted in their loan installments by canceling all or a large percentage of their unpaid loans or establishing a fund for insolvent retirees. The fund shall be responsible for retired members who are selected according to their work experience. It will be a distinctive gesture of real assistance for them.

"Most importantly, the State could benefit from appointing retirees to social insurance committees based on their experience and their salary could help them fulfill a large number of obligations.

"In this context, we thank the government for the good and positive initiative to increase the pension of retirees who are currently receiving less than KD1,000 a month. It is a commendable step. Once approved and implemented, it will improve the living conditions of this important segment in the country that deserves our appreciation and respect. They also deserve assistance and attention from the government, as a way of showing appreciation and gratitude for their valuable contributions to the na-

"Also, we call on the government to take similar steps to improve the lives of other citizens. At the same time, we must not forget to emphasize the need for the government to monitor the economic movement and the consequences of the pension increment.

high temperature. He warned this could lead to a catastrophe like the incident at Beirut Port in Lebanon. He stated that several trucks transporting small rocks are allowed to leave the ports and enter the local market without inspection, which could pave way to the smuggling of drugs and weapons.

He also criticized the appointment of the chairman of Kuwait General Administration of Customs (KGAC) although the latter has nothing to do with KGAC and did not advance his career in the field, considering he worked in the private sector most of the time.

He accused the minister of trying to deceive the citizens by pretending to be pro-reform through the withdrawal of industrial plots from tenants. He argued this is a regular procedure followed by the minister's predecessors. He added the Public Authority for Industry Law states that the tenants whose plots were withdrawn have the right to complain and then reclaim their plots or address the violations.

He went on to say that the minister appointed consultants from other ministries, citing as an example a consultant from the Ministry of Finance and another who used to work as the driver of a senior official. He revealed an employee from the Public Authority for Civil Information (PACI) was appointed as manager of the Office of the Minister of Commerce and Industry. He pointed out that such appointments burden the public fund.

He said Al-Aiban violated the Civil Service Commission (CSC) regulation banning the secondment of employees. He revealed the minister obtained exceptions for certain individuals to be appointed as officials even if they did not meet the con-

On regulating the prices, Al-Hamdan asserted everyone feels the seasonal hike in the prices of various commodities; stating that fish prices usually increase in summer, school supplies at the beginning of every academic year and meat during Eid holidays.

Meanwhile, Al-Aiban stated that the motion consisted of fallacies and wrong information; stressing Al-Azmi went beyond the law, Constitution and traditions when he described him as a thief and a swindler. He pointed out the lawmaker alleged that the salary of a consultant is KD 6,000 per month; emphasizing this is absolutely wrong. He urged the lawmaker to prove his allegations, including the supposed appointment of a driver as consultant. He clarified that the consultant he appointed was an official at PACI, while the one from the Ministry of Finance served as a consultant at the Ministry of Commerce and Industry only after resigning from his previous job. He added that he asked the CSC to reduce this consultant's salary -- lower than his salary at the Ministry of Finance. He affirmed all the consultants in his ministry are dedicated Kuwaitis who are highly qualified in the

field of combating corruption. On the increasing number of trucks transporting flammable substances at Shuwaikh Port, the minister pointed out this is the result of the hard work of KGAC employees who are keen on preventing the smuggling of diesel. He disclosed the number of trucks at the port has increased from 120 to 470, indicating he asked Kuwait Oil Company (KOC) to address the

About the accusation that he disrupted meetings of the Board of Directors of the said the regulations state that four meetings per year are enough; yet he had eight meetings in the first quarter of 2023 alone.

On misleading SAB, he asserted that all the grilling points are based on the reports of SAB before he assumed office; so it seems Al-Azmi tried to grill another minister. He explained there is a big difference between recording violations and comments; as the latter are open for discussion, correspondence and exchange of information.

On the mismanagement of the National Fund for Small and Medium Enterprises, he disclosed that he issued a directive to postpone the collection of loan installments from beneficiaries facing financial difficulties, and formed a committee tasked to study the high risk enterprises to stop the fund from approving them and look for safer and more profitable projects in the interest of the beneficiaries and the public treasury. He added it is unacceptable to be questioned about issues that the fund has been facing in the last 10 years as he assumed office only six moths ago.

Regarding the failure to regulate prices, Al-Aiban asserted all the accusations in this regard are baseless. He pointed out the number of citations issued against traders proven to have committed violations and the number of establishments which were closed due to unjustified price hikes are much higher than the figures recorded last year; confirming some of those who committed violations were referred to the Public Prosecution. He revealed the revenues of the Ministry of Commerce and Industry in the first half of 2023 reached KD4 million -- higher than the previous year.

Then, Assembly Speaker Ahmed Al-Saadoun allowed one MP to speak in support of the grilling motion and another in support of the minister. MP Khalid Al-Tamar, who supports the grilling motion, said the citizens have been complaining about the unjustified price hikes, which negatively affected families. He argued the minister is obligated to issue decisions and follow up the implementation, warning that the pension and salary increments might lead to a remarkable increase in

MP Badr Al-Mullah, who spoke in support of the minister, clarified that he supported the previous grilling motions of Al-Azmi; but this time, he is against the motion. He pointed out that as an eyewitness, he confirmed the minister was referred to the Public Prosecution when Boursa Kuwait filed a case after his ministerial appointment. "In April 2023, Al-Aiban assumed office and decided to reform Boursa Kuwait in May 2023. In June 2023, Boursa Kuwait reported him to the prosecution for accusations related to his work in a private company 10 years ago. The fact that Boursa Kuwait took such a step only after all those years means it is due to the minister's reform

decision," the lawmaker added. Speaking about the diesel trucks in his

capacity as former Minister of Oil, Al-Mullah revealed the KGAC employees complained about the accumulation of trucks transporting flammable substances. He emphasized the need for HH the Prime Minister Sheikh Ahmad Nawaf Al-Ahmad Al-Jaber Al-Sabah to interfere in order to address the issue, protect the ministers and support their decisions. He added that during his term as oil minister, he received many requests from individuals to establish thinner factories and he found out that they purchased subsidized kerosene to sell the product to Jabal Ali or Jordan at international prices. He said this harms the public treasury; as certain individuals earn very high profits by purchasing a shipment of kerosene for KD 60,000 and then sell it for KD250,000 the following month without exerting any effort.

After this, Al-Saadoun announced that he did not receive any no-confidence motion; so he decided to tackle other items in the agenda.

The National Assembly approved Tuesday in its first deliberation, the amendment to Article 19 of the Amiri Decree 61 (1976) issuing the Social Security Law regarding increasing the minimum retirement pension.

Finance Minister Fahad Al-Jarallah confirmed Tuesday that based on the directives of His Highness the Amir Sheikh Nawaf Al-Ahmad Al-Jaber Al-Sabah, His Highness the Crown Prince Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah, His Highness the Prime Minister Sheikh Ahmad Nawaf Al-Ahmad Al-Sabah, and the decision of the Council of Ministers, the minimum pensions will be increased.

This came in Al-Jarallah's remarks after the National Assembly's regular session to discuss the report of the Parliamentary Financial and Economic Affairs Committee. This law works to improve living standards, starting with the segment of retirees who have the minimum pension, in accordance with the government parliamentary consensus, he said.

This law will not affect the continued disbursement of the annual increase of KD 20, he said, pointing out the government's keenness to complete its studies connected to improving the lives of citizens before the end of this year and referring them to the Parliamentary Financial and Economic Committee.

He underlined the government's endeavor to achieve justice and equality for retirees, and one of the foundations of that justice is not to increase one segment and leave another segment.

National Assembly Speaker Ahmad Al-Saadoun announced Tuesday parliament's approval of amending article (19) of the Amiri order (61) for the year 1976 regarding social insurance, to raise the minimum pension wage.

The amendment was agreed upon by all 63 attendants of the ordinary session, in both first and second deliberations and was referred to the government.

The national assembly's session had moved on to discuss financial and economic parliamentary committee report on amendments proposed by government on social insurance law.

The first article stipulated that minimum pension wage for those supporting seven children and more is KD 1,615.

The second article specified raising retirement wages to a minimum of KD 1,000 or a 10 percent increase as those with a previous salary near KD 1,000 would not stand to benefit from the amendment as much as those with lesser salaries thus prompting the addition of the 10 percent

As for retirees with wage between KD 1,000 and maximum wage, the amendment grants them a five percent increase, to ensure gain to all pensioners.

Israel and Hamas. But those efforts have faced massive setbacks.

More than 11,000 Palestinians, twothirds of them women and children, have been killed since the war began, according to the Health Ministry in Gaza, which does not differentiate between civilian and militant deaths.

The shadowy leader of Hamas' military wing, Mohammed Deif, said the Oct. 7 assault on Israel was in response to the 16-year blockade of Gaza, Israeli raids inside West Bank cities over the past year, increasing attacks by settlers on Palestinians and the growth of settlements, among other reasons.

Israeli Prime Minister Benjamin Netanyahu, who declared Israel to be at war, said its military would use all of its strength to destroy Hamas' capabilities. "All the places that Hamas hides in, operates from," he said, "we will turn them into ruins.'

In other news, Kuwait condemned an attack by Israeli occupation forces on the headquarters of Qatar's Committee for the Reconstruction of Gaza, slamming the incident as another "crime" against Palestinian civilians and their facilities.

The attack by Israeli forces on a Qatari committee meant to provide aid for the Palestinians typifies Israel's "aggressive tendencies" towards the Palestinians, said a foreign ministry statement.

These actions are "gross violations" of international laws and principles, the statement underlined, urging the international community to intervene and put an end to "Israeli transgressions,"

Elsewhere, Palestinian authorities proposed a Red Cross-supervised evacuation of a hospital beset by fighting in Gaza on Tuesday, as health officials warned that the only way to save three dozen newborns trapped there would be to call a cease-fire and transport them out of the besieged territory.

After days of battles with Palestinian militants, İsraeli forces have encircled Shifa Hospital, where hundreds of patients, medical staff and displaced people are trapped with dwindling supplies and without electricity to run incubators and other equipment.

Gaza's largest hospital has emerged as a symbol of Palestinian suffering in the war between Israel and Hamas that extends far beyond its walls. Only one hospital in the territory's north is still capable of receiving patients, and about 200,000 Palestinians have streamed out of the area toward worsening conditions in the south in recent days, the U.N. humanitarian office said Tuesday.

77pct delay cited for 2023/'24 plan projects implementation

KUWAIT CITY, Nov 14: The annual plan follow-up report 2023/2024 during the period from April to last September monitored 13 projects that have not been started yet, while the percentage of delays in projects behind the schedule reached 77 percent, and the total challenges facing the authorities in implementing their projects reached 674, however, about 76 percent of them have been overcome and resolved, reports Al-Jarida daily.

Charles marks b'day with a 'full' schedule

LONDON, Nov 14, (AP): At an age when many of his LONDON, Nov 14, (AP): At an age when many of his contemporaries have long since retired, **King Charles III** is not one to put his feet up.

The marks his 75th birthday on Tuesday by busily highlighting causes close to his heart.

With Queen Camilla at his side, Charles will visit a project that helps feed those in need by redistributing food that might otherwise go to landfills. Then he'll

food that might otherwise go to landfills. Then he'll host a party for 400 nurses and midwives, saluting the National Health Service's own 75th birthday. For good measure, the king appears on the cover of this month's Big Issue, which gives marginalized people the opportunity to earn money by selling the magazine

It's the sort of day that's been typical of the king's first 14 months on the throne.



After the seven-decade reign of his late mother, Queen Elizabeth II, Charles has rushed to show that the monarchy remains relevant in modern British society. He's made three overseas visits, pledged to open the royal archives to researchers investigating the crown's links to slavery and expressed "sorrow and regret" for "abhorrent and unjustifiable

acts of violence" committed against Kenyans during their struggle for independ-

Charles's reign has gotten off to a steady start, but he still needs to set out a clear vision for the future, said Ed Owens, an historian and author of "After Elizabeth: Can the Monarchy Save Itself?"

Concerns

Charles' long apprenticeship meant he was a greyhaired septuagenarian when he finally took the throne, fueling concerns he would have a hard time connecting with a country that no longer takes deference to the monarchy for granted.

But all those decades also gave him more training and experience to draw upon than his mother, who was just 25 when she became queen.

While Elizabeth, like all British monarchs before her, was educated by tutors, Charles was bundled off to Hill House School in London before his eighth birthday to begin experiencing the world outside the

As Prince of Wales, the future king founded a charity that helps young people get jobs and training.

But it is his heir, Prince William, who is now focused on the younger generation, seeking a leading role in the environmental movement with his Earthshot Prize, a global competition to find ways to combat climate change.



Spain parliament to vote on PM's re-election: The investiture debate and vote to reelect acting Socialist Prime Minister Pedro Sánchez will take place later this week, Spain's Parliament speaker said Mon-

Speaker Francina Armengol said Sanchez's candidacy will be discussed by party leaders Wednesday and the vote will take place after the debate Thursday.

Sánchez, who has been in office since 2018, is expected to be voted in with no problems given that his Socialist party has reached deals with a bunch of small parties to ensure he has the backing of 179 legislators, three more than the 176 majority required in Parliament in a first vote.

Spain's July 23 inconclusive elections left all parties without a clear path to form government.

Poland's parliament choses speaker: Poland faced a contentious and protracted transition of power on Monday as the president designated the outgoing prime minister to lead the new government in a caretaker capacity, angering a pro-European Union alliance with a strong majority in the new parliament. The chamber overwhelmingly chose a speaker from

the alliance that must wait longer to lead. Political opponents accused President Andrzej Duda, who is allied with Prime Minister Mateusz Morawiecki's right-wing Law and Justice party, of acting against the will of voters by giving Morawiecki up to four more weeks to lead. They accused Morawiecki's conservative government, in power for eight years, of hanging on to appoint allies to state po-

Morawiecki had offered his conservative government's resignation as required after his party lost its parliament majority in last month's election, but Duda within hours redesignated him as prime minister candidate.

Envoys shoot back at Western criticism: Western countries on Monday repeatedly called on Russia to end domestic repression of dissident voices and end its war in Ukraine - and human rights violations related to it - as Russia came under a regular review at

the UN's top rights body. A delegation from Moscow, led by State Secretary and Deputy Justice Minister Andrei Loginov, defended Russia's right to ensure law and order by restricting some forms of protest or voices that might threaten domestic security. He also said Russia's "special military operation" in Ukraine had "no relation to the subject matter" at issue in the review.

Monday's 3 1/2-hour hearing in Geneva was part of an exercise known as the universal periodic review, or UPR, which all UN member states face about every four or five years in connection with the U.N.-backed Human Rights Council.



Russia jails an associate of Navalny: A court in the Siberian city of Tomsk on Monday jailed an associate of imprisoned opposition leader Alexei Navalny pending trial on extremism charges, according to an ally, part of an unrelenting crackdown on Russian political activists, independent journalists and rights

Ksenia Fadeyeva, who used to run Navalny's office in Tomsk and had a seat in a local legislature, was placed in pre-trial detention several months after her

trial began. According to her ally Andrei Fateyev, who reported the development on his Telegram channel, Fadeyeva was placed under house arrest three weeks ago over an alleged violation of restrictions imposed on her earlier. The prosecutor later contested that ruling and demanded she be put in custody, a move the judge supported, Fateyev said.

The activist has been charged with running an extremist group and promoting "activities of an organization that infringes on people's rights."

'Fire was likely arson': Arson was the cause of a massive weekend fire that charred and indefinitely closed a vital section of a Los Angeles freeway, causing major traffic headaches for hundreds of thousands of commuters, California authorities said. Gov Gavin Newsom said investigators

were trying to determine if one person or more were involved. He gave no other details. "I have to stress that we have determined

what started the fire," Newsom told reporters Monday.

The fire erupted Saturday in two storage lots under Interstate 10 where construction materials combusted quickly and the fire grew. It left many columns charred and chipped and the deck guardrails twisted. Crews shored up the most damaged section for the safety of workers clearing the debris. It's still unclear what structural damage, if any, the blaze caused to the freeway. (AP)

Mich Dems adjourn legislature to ensure primary date

2024 GOP presidential field rapidly shrinking

COLUMBIA, SC, Nov 14, (AP): The Republican Party's once-crowded 2024 presidential primary field has suddenly shrunk to just a handful of viable candidates.

But a day after Sen. Tim Scott of South Carolina stunned many of his own staff by suspending his campaign, it's unclear whether the GOP is any closer to coalescing behind a clear alternative to former President Donald Trump. Instead, the fight between Nikki Haley and Ron DeSantis for a distant second place appears to be intensifying. And some lower-tier candidates insist on battling for relevance, despite growing pressure to bow out of the race altogether.

Meanwhile, Trump's team is cheerng on the muddle for second place with Iowa's Jan. 15 kickoff caucuses iust two months away.

Signs

Still, there were new positive signs on Monday for Haley, Scott's South Carolina rival, who had been rising in the Republican contest even before the senator's sudden announcement.

Billionaire investor Stanley Druckenmillier, who had given money to Scott, pledged his support for Haley during a Monday interview as he spoke publicly about the 2024 race for the first time. He emphasized the need for the GOP to coalesce behind the former United Nations ambassador before primary voting begins.

"Now I'm hoping the field clears and it's Nikki Haley one-on-one with the former president," Druckenmillier told The Associated Press. "As long as the field is cleared before the actual prima-

ries, I think that's what's important." But DeSantis is showing no signs of going away as he narrows his focus on Iowa's leadoff caucuses.

The Florida governor's spokesperson, Andrew Romeo, says he has a new opportunity in Iowa with Scott and former Vice President Mike Pence out of the race. He pointed to Iowa's influential group of religious conservatives who have warmed to DeSantis' strong opposition to abortion as part of his aggressive "war on woke." Just last week, DeSantis scored the

biggest endorsement of the 2024 campaign by nabbing the backing of Iowa Gov. Kim Reynolds, who promises to lend the Florida governor her folksy charm - and her statewide political machine. "Tim Scott and Mike Pence were

surging resources in Iowa, looking to attract evangelical supporters, and unlike Nikki Haley, Ron DeSantis is making headway with those voters," Romeo said. "In the coming weeks, these voters will see that Nikki Haley's record and values don't match her rhetoric.

Feud

The prominence of the Halev-DeSantis feud underscores just how quickly the 2024 Republican field has winnowed compared to the last time Trump was on the ballot.

At this time in the 2016 primary season, 13 Republican presidential candidates were still competing on the debate stage across two nights. The 2024 primary season opened with eight Republicans in the opening debate this August, while no more than four are expected to qualify for next month's debate in Alabama: Haley, DeSantis, conservative entrepreneur Vivek Ramaswamy and former New Jersey Gov. Christie.

North Dakota Gov Doug Burgum and former Arkansas Gov. Asa Hutchinson failed to qualify for the last debate, although they're still in the race. Pence, who would not have qualified for the last debate, suspended his campaign last month facing a similar dilemma.

Trump's team is cheering on the feud between Haley and DeSantis, who are largely focused on tearing down each other, while the former president remains the overwhelming GOP front-runner.

Privately, Trump's allies believe that Haley will see the biggest short-term polling bump as a result of Scott's departure. But they also believe that Trump, who has a substantial lead, is likely to extend his already huge advantage.

LANSING, Mich: Michigan Democrats who were passing legislation at a historic pace will abruptly end their session Tuesday as they grapple with internal divisions and a temporarily deadlocked state House.

Lawmakers are adjourning nearly month early and delaying key legislation until next year to ensure that new legislation will take effect making Michigan the fifth state to hold its presidential primary on Feb 27.

The decision to end early also comes after two Democratic state representatives won mayoral races, erasing the House's slim Democratic majority. The chamber is split 54-54 until special elections can be held in several months.

Michigan Democrats had worked at a record pace at the start of the year after regaining full control of the Legislature while already holding the governor's mansion last year for the first time since 1983. They passed a number of pent-up policy priorities, such as a gun safety package and abortion rights. They also repealed a union-restricting law known as "right to work."

But party unity has wavered in recent months and Democrats were unable to pass several key pieces of legislation before the end of the year that would have implemented paid family and medical leave, lowered prescription drug costs and increased auto insurance reimbursement rates. Gov Gretchen Whitmer had called on the Legislature to pass paid leave in her "What's Next Address" in August.

Democrats were facing a Nov. 29 deadline to finish the session or miss out on becoming one of the states that will kick off the party's presidential primary starting next year. The legislation that moved the state's primary will not take effect until 90 days after the Legislature adjourns.

Michigan is also one of the only states where the Legislature and governor's office are not open to records requests, shielding lawmakers from "sunshine" laws that give the public insight into what they do.

The European Union Parliament, some American lawmakers and United Nations human rights experts have long demanded the release of Leila de Lima, who was detained as an opposition senator in February 2017 in what they called political persecution by Duterte and his allies and a major blow to Philippine

Duterte, whose stormy six-year term ended in June last year, insisted on her guilt, saying witnesses testified she received payoffs from

De Lima immediately called her ailing 91-year-old mother and, with her voice breaking, told her she was

Facing a throng of cameras, de Lima later thanked her family, lawyers, supporters, the judge and the administration of President Ferdinand Marcos Jr. "for respecting the independence of the judiciary and the

Japanese vice min resigns over tax scandal: A Japanese vice finance minister stepped down on Monday, amid criticism from Prime Minister Fumio Kishida's Cabinet, after admitting his company's repeated failures to pay taxes, a further setback to Kishida's unpopular government.

Deputy Finance Minister Kenji Kanda, in charge of government bonds and monetary policy, is the third member of Kishida's Cabinet to resign within two months following a Cabinet shuffle in September.

Kishida later told reporters that he takes responsibility for the appointment of Kanda. "I must apologize to the people that a vice finance minister had to resign soon after he assumed his position," Kishida said. "I'm determined to concentrate on our work more seriously, as I believe that's the only way to regain the people's trust."

3 candidates OK'd for presidential poll: Indonesia's Election Commission announced Monday that it has approved all three presidential candidates for next February's election, including a former special forces general whose vice-presidential running mate is the son of outgoing President Joko Widodo.

The commission said all of the candidates had passed the legal requirements. Last month, the Constitutional Court in a controversial 5-4 ruling allowed Widodo's son, 36-year-old Gibran Rakabuming Raka, to run despite not meeting the minimum age requirement of 40 for presidential and vice-presidential can-

The court, headed by Widodo's brother-in-law, said it granted an exception for Raka because he is currently mayor of Surakarta. Pro-democracy activists criticized the decision as nepotism that undermined the democratic process. The chief justice was later dismissed after the court's ethics council found him guilty of a serious violation.

Myanmar army faces a new challenge: Myanmar's military government faced a fresh challenge Monday when one of the armed ethnic groups in an alliance that recently gained strategic territory in the country's northeast launched attacks in the western state of Rakhine.

The Arakan Army launched surprise assaults on two outposts of the Border Guard Police, a paramilitary force, in Rakhine's Rathedaung township, according to independent online media and area residents. The attacks took place despite a yearlong cease-fire with Myanmar's military government.

Khaing Thukha, a spokesperson for the Arakan Army, told The Associated Press that two military security outposts in Rathedaung were seized by his group and more than 20 police officers from a station in another township, Kyauktaw, had laid down their weapons.

"Ŝome officers of Myanmar's army have been arrested," Khaing Thukha said by phone.

Local media outlets reported fighting between the Arakan Army and the military in Minbya, Maungdaw, Mrauk-U and Kyauktaw townships.

3 murderers freed in Australia: Three murderers are among 81 foreigners recently released in Australia after the High Court ruled their indefinite detention in migrant centers was unconstitutional, the immigration

minister said on Tuesday.

The court hasn't released the reasons behind its ruling last week that overturned a 2004 precedent that stateless people could be detained indefinitely.



Gang leader killed: A powerful and feared gang leader in Haiti who was once a math and physics teacher was killed in a neighborhood within a sprawling seaside slum that he controlled for years, local media reported on Monday.

The death of Iskar Andrice, who also has been identified as Iscar Andris, raised concerns that already rampant gang violence could spike further in the vacuum his death

Andrice ruled the Belekou community within the Cite Soleil slum where he died, former mayor Esaïe Beauchard told Radio

"It's regrettable that this guy had to be involved in gang activity, because he's a very intelligent man," Beauchard said. It wasn't immediately clear what day An-

drice died. Jean-Frédérique Islain, the current mayor of Cite Soleil, declined to comment when

contacted by The Associated Press. The gang that Andrice led was involved in murder, robbery, extortion, rape and the hijacking of goods and trucks, according to a recent UN report. He later joined forces with renowned gang leader Jimmy Chérizier, known as Barbecue, who formed the "G9 Family and Allies" alliance, Haiti's biggest and most power-

ful gang group.

Media interviews granted by Chérizier first had to be approved by Andrice.

The UN said that Andrice, like other gang leaders, created a social foundation in 2015 known as the Siloé Foundation to win over the community he controlled and present a positive image of himself. (AP)

Sailor asks family to pray for him: During the first minutes of Oct. 25 when Hurricane Otis roared into Acapulco Bay with 165 mph winds, sailor Ruben Torres recorded a 10-second audio message from a yacht called the Sereno.

"All things considered I'm alright, but it's really horrible, it's really horrible, it's really horrible," he said over the howling wind and the boat's beeping alarms. "Family, I don't want to exaggerate, but pray for us because it's really awful out here.

The Sereno was one of 614 boats yachts, ferries, fishing boats - that according to Mexico's Navy were in the bay that night and ended up damaged or on the ocean floor. Of those aboard the Sereno, one person survived, while Torres and the boat's

captain remain missing.

Yoon slams Moscow-Pyongyang arms deal

SKorea, UNC states warn NKorea over N-threat

SEOUL, South Korea, Nov 14, (AP): Senior defense officials from South Korea, the United States and other nations on Tuesday warned North Korea over its nuclear ambitions and threats, vowing an unspecified collective response to any war-like aggression by the North toward its rival.

Their joint statement came after a meeting in Seoul involving US Secretary of Defense Lloyd Austin, South Korean Defense Minister Shin Wonsik and officials from 16 other countries under the US-led United Nations Command (UNC), which provided combat or medical forces in support of the South during the 1950-53 Korean

The meeting came a day after Austin and Shin held annual defense talks where the allies updated a bilateral security agreement with the aim of more effectively countering North Korea's evolving nuclear and missile threats.

In the statement, the defense ministers and other representatives of the UN Command's member states strongly condemned North Korea's "unlawful" nuclear and ballistic missile programs which violate multiple UN Security Council resolutions and called for Pyongyang to recommit to diplomacy aimed at defusing the nuclear standoff.

United

The UN Command's member states also declared "they will be united upon any renewal of hostilities or armed attack on the Korean Peninsula challenging the principles of the United Nations and the security of (South Korea)."

Shin during a speech at the meeting said the North would face a "strong response from the international community centered on the UN Command' if it ever attempts to invade the South again. He also issued a veiled warning against Pyongyang's growing alignment with Russia and China, as North Korean leader Kim Jong Un tries to break out of diplomatic isolation and insert Pyongyang as part of a united front against Washington.

"If the countries that supported North Korea during the Korean War offer to do so again, they too will face the same punishment as North Korea,' Shin said.

The UN Command has since remained in the South to enforce and maintain the armistice.

Before Tuesday's meeting, North Korea's Foreign Ministry condemned the event as reflecting a "dangerous scheme to ignite a new war of aggression." The North's state media also criticized the visits by Austin and US Secretary of State Antony Blinken, who traveled to Seoul last week, calling them "warmongers' "new war cloud" to Asia.

Concerns

US Defense Secretary Lloyd Austin on Tuesday expressed concerns over North Korea's growing nuclear and cyber threats, and its expanding military cooperation with Russia for its war in Ukraine, Yonhap News Agency reported.

Animosity between the Koreas has spiked in recent months after Kim ramped up his weapons demonstrations, including events he described as simulated nuclear attacks on the South. He also authorized his military to launch preemptive nuclear strikes against enemies if it perceives Pyongyang's top leadership to be under threat.

South Korea has responded by expanding its combined military exercises with the United States as well as trilateral security cooperation with Japan, Seoul has also been seeking stronger public assurances from Washington that the United States would swiftly and decisively use its nuclear weapons to protect the South in case of a North Korean nuclear at-

"North Korea's provocations will not only fail to achieve its intended goal but also result in immediate and strong retaliation from the ROK-U.S. alliance," he said.

There are concerns that Russia's protracted war on Ukraine and the raging conflict between Israel and Hamas are adding to complexities and uncertainties over the security situation on the Korean Peninsula.

Some experts say North Korea's reported pursuit of sophisticated Russian weapons technologies in return for its supply of conventional arms for Russia's war in Ukraine could help the North modernize its nuclear-capable missiles targeting South Korea and the U.S. The experts also worry that Washington's preoccupation with Ukraine and Israel might prompt North Korea to conclude that the U.S. security posture on the Korean Peninsula has weakened and launch surprise attacks or other provocations against South Korea.

'Gross external debt in GCC set to triple, reaching \$660 bln annually'

Kuwait banks expected to reduce share in external liabilities

By S&P Global Ratings

 $\mathbf{S}_{(GCC)}^{\&P}$ Global Ratings expects Gulf Cooperation Council (GCC) countries will need to roll over more gross external debt in the coming years, with banks accounting for a large proportion as they support government plans to accelerate nonhydrocarbon economic activity.

We expect short-term external funding, mainly in the form of interbank and nonresident deposits (including intra-GCC liabilities), to account for an average of just over 70% of combined GCC banking sector external debt in 2023. While regulators and individual banks try to lengthen the tenor of these facilities, we expect GCC banking systems' external liability growth to push combined national rollover requirements to nearly \$700 billion per year by 2025, with the United Arab Emirates (UAE; not rated) and Qatar (AA/Stable/A-1+) together comprising over half of the total. The \$660 billion is equivalent to roughly 40% of estimated combined 2023 current account receipts and usable reserves, compared to the \$250 billion in 2013, which was about 14% (Brent oil prices averaged \$108 per barrel that year, compared to an average of close to \$82 per barrel through 2023 so far)

In our calculations, we assume the majority of interbank and nonresident deposits are short term. We typically view this type of funding as less stable and more confidence-sensitive, raising rollover risks. However, most systems' external liquidity profiles are solid and in substantial net external asset positions. We note that the overall system may not be representative of the liquidity positions of individual banks. However, even in stressed situations, we expect most banking systems to meet external funding outflows under their own resources (see Page 10 "What A Regional Escalation Could Mean For MENA Banks' External Funding," published Nov. 13, 2023, on RatingsDirect).

Furthermore, even as bank-driven external liabilities increase, we expect most regional governments will remain in a position to prevent and, if needed, cover any outflows. In this, their capacity to do so is linked to the underlying sovereign rating.

Banks' External Balance Sheet Growth Is Increasing **National Rollover Requirements**

Combined, we calculate GCC banking systems' external liabilities coming due within the year will total \$465 billion in 2023, more than two-thirds of national requirements. We


forecast this will increase toward \$500 billion by 2025. Notably, banks' external balance sheets have not developed at the same pace across the board. The UAE and Qatar display by far the largest net external balance sheet expansion, which is mostly concentrated on specific banks, with government-backed national champions predominating. In Qatar, the build-up of external debt was mainly channeled to finance large domestic projects. In the UAE, it was predominantly recycled in high quality external assets.

However, the situation is evolving, and we expect the greatest increases in banking system external rollover requirements to be in the UAE and Saudi Arabia (unsolicited Å/Stable/A-1). For the latter, we expect bouts of relatively tight domestic liquidity and the need to fund Vision 2030 projects to increase foreign-funded bank credit. We expect the UAE will continue attracting external deposits, alongside oil-driven domestic liabilities being placed abroad. On the other end of the scale, we expect Kuwait's (A+/Stable/A-1) banks to reduce their contribution to the country's overall external liabilities in the next few years, with public sector external debt increasing.

Strong Net External Positions Can Mitigate Tighter

While banks are driving annual national financing needs, regional economies' net external positions are mostly still dominated by formidable, and expanding, fiscal reserves. Moderate to low levels of gross external debt characterize most--but not all--economic sectors. Apart from Qatar, banking systems are also in net external asset positions, implying an ability to cover outflows of external liabilities without government support in a stressed scenario, depend-

ing on the liquidity of the external asset. However, we note the region's strong and supportive governments have a track record of extending financial aid to



entities, or even entire industries including banking systems, before funding strains become problematic. This remains our working assumption for all GCC systems aside from Bahrain (B+/Positive/B) and Oman (BB+/Stable/B), due to their more modest levels of government assets

We expect gross and net external asset growth to continue for most sovereigns, reflecting large hydrocarbon-revenuedriven external surpluses, which are invested abroad. Our oil price assumptions are steady at \$85 per barrel over the next three years (see "S&P Global Ratings Has Raised Its Henry Hub Natural Gas Price Assumptions For 2024 And 2025," published Nov. 7, 2023)

Most Governments Can Cover External Liability Outflows In Our Hypothetical Scenario

Using our hypothetical stress scenario from "What A Regional Escalation Could Mean For MENA Banks' Ex-

ternal Funding", we compared stressed banking sector liability outflows to liquid government assets. We found all systems, apart from Bahrain's retail banking sector, had very comfortable coverage. In other words, government assets (which include our estimates of external sovereign wealth fund assets) account for multiple times the stressed liability outflows.

Regional banking systems are driving up national gross external debt and we expect related rollover risks to banks and sovereigns will naturally increase as a result. However, most regional governments have liquid assets well exceeding hypothetical outflows and, if ever required, we expect sovereign resources would be rapidly deployed to reinforce confidence. Additionally, our hypothetical stress test highlights regional banking systems are well positioned to meet these requirements without presenting a direct claim on fiscal resources.

Petrobras eyes new reserves with \$6.9 bln investment

Oil titans fail to impress at climate summit with inadequate green transition roadmaps

NEW YORK, Nov 14, (AP): In 2022, Brazilian oil and gas company Petrobras had 68 places staked out for oil exploration off the South American coast, searching for new reserves while spending \$6.9 billion in oil development projects. About the same time, Algeria-based Sonatrach proclaimed its ambition to ramp up production to become a top five national oil company by 2030. And Abu Dhabi National Oil Co. opened 68 new gas stations in Saudi Arabia and the United Arab Emirates, noting in its 2022 annual report that there were now more than 500 across the UAE.

All these companies, along with 33 others focused on oil and gas, sent delegations to Egypt for last year's annual climate summit, known as COP27, aimed at moving the world away from the burning of fossil fuels like oil and gas. Many will likely be at the upcoming conference, COP28, being hosted in the UAE, which appointed Sultan al-Jaber, chairman of the nation's oil company, as president of the summit.

Faced with criticism about their presence at negotiations, leaders of such companies argue they are part of the transition to renewable energies, an argument that negotiators like U.S. Climate Envoy John Kerry have cautiously endorsed. But an Associated Press review of how much these companies invest in green energies, along with the priorities laid out in their annual reports, cast doubts on genuine commitments to transi-

Most companies only have small, if any, investment in solar or wind power, the most established green technologies. Most of their investments, billions of dollars, are in further exploration, extraction and refining of oil - with plans laid out in some cases over the next decades. That's long beyond when scientists say the world must move away from fossil fuels.

"These are companies with enormous profits at present, enormous engineering capabilities and have been producing oil and gas for a very long time," said Jason Bordoff, director of the Center on Global Energy Policy at Columbia University. "It is reasonable to expect leadership in how quickly they lead and move and develop new technologies and drive the cost down of renewables.

The companies at last year's summit don't look to be making such efforts in any big way. Many that publish annual reports have sections entitled "sustainable" or "green" that do include some renewables. However, in such sections they also include biofuels, hydrogen development and carbon capture, all things that at best have long-term potential to reduce emissions. Many also tout natural gas which, while cleaner-burning than fuels like coal, still emits significant amounts of methane, a potent

Almost all the companies focus on reducing emissions in their operations, and don't address the emissions that will result when customers use their products to power cars, heat homes, move ships and planes, and so

Those emissions are known as "Scope 3" and they are commonly seen as both the biggest share of a company's emissions and the most difficult to solve, with many companies arguing they are out of their control. (Scope 1 refers to a company's direct emissions, and

Scope 2 are indirect emissions that come from production of the energy a company

acquires to use in its operations.) Amir Sokolowski, global director of the that asks companies to disclose their climate impact, said fossil fuel companies are reluctant to take on emissions from their products after they're out the door.

But that reluctance isn't rational "because the point is that oil and gas cause most of the combustion in the world in terms of emissions." Sokolowski said.

Petrobras, majority-owned by the Brazilian government, specializes in deep water exploration, drilling and extraction. Its 2023-27 strategic plan earmarks \$4.4 billion in investments "to strengthen our low carbon position." Petrobras' planned investments in crude oil exploration and production for the period are more than 10 times higher than its low-carbon investments, according to the World Benchmarking Alliance, which tracks

companies on sustainability goals. Meanwhile, the company's commitment toward those core products is clear. The scores of exploratory leases and billions invested in searching for new oil deposits fit a strategy that expects oil and gas production "will still be necessary to guarantee the energy security of Brazil and the world in the coming decades, the company says on its website.

Sixteen of the oil companies that went to last year's climate summit have publicly responded in recent years to questionnaires prepared by CDP, which invites companies and countries to be transparent about what they're doing on carbon and the climate. One question was how much of their spending was aimed at helping with the global goal to limit warming to 1.5 degrees Celsius since pre-industrial times, which scientists warn is necessary to stave off the worst impacts of climate change, like increasing extreme weather events.


Equinor, a Norway-based oil and gas company, answered in 2022 that 11% of its capital spending could be classified this way, with a goal of 30% by 2025. Notably, Equinor was also one of a minority of companies with a plan to tackle Scope 3 emissions -those caused by consumers' use of its products - to get to net zero emissions by 2050.

Equinor's plan includes a big focus on renewables. The company is building out the world's largest offshore wind farm, aimed at powering 6 million British homes one day. But the plan also depends on carbon capture and carbon offsets, or the equalizing of emissions by paying to capture them somewhere else. Equinor also says it will be necessary to continue to produce oil and gas "for the foreseeable future," in part to avoid global shocks.

Al-Jaber's company, ADNOC, earlier this year began using drones to scatter mangrove seeds across Abu Dhabi, part of what it touted as a sustainability effort to plant some 2.5 million of the carbon-storing plants. Yet the company's investment in low-carbon projects amounts to just 10% of its reported plans for \$150 billion in capital spending through 2027.

ADNOC, Petrobras, Equinor and Sonatrach declined or did not respond to interview requests to talk about their energy

Exxon Mobil dives into lithium

LITTLE ROCK, Nov 14, (AP): Exxon Mobil on Monday announced it's drilling for lithium in southern Arkansas, with the oil giant expected to begin production of the critical material for electric vehicles by 2027.

Exxon in early 2023 acquired the rights to 120000 gross acres (48562 gross hectares) of the Smackover formation in southern Arkansas, considered one of the most prolific lithium resources of its type in North America. Exxon said that by 2030 it aims to produce enough lithium to supply the manufacturing needs more than 1 million electric vehicles.

"Lithium is essential to the energy transition, and ExxonMobil has a leading role to play in paving the way for electrification," Dan Ammann, president of ExxonMobil Low Carbon Solutions, said in a news

Exxon didn't disclose how much it's spending on the project, which is expected to be a boost for a part of Arkansas that has a history as an oil and gas pro-

"I'm not being dramatic when I say this has the potential to transform our state," Arkansas Gov. Sarah Huckabee Sanders said at a news conference with Exxon and local officials about the project.

Columbia County Judge Doug Fields said the county has already been working with Exxon to ensure

roads to the well are prepared. "Just seeing some of this come in like it is, it's going

to be a big pick me up for the area," Fields said. The announcement comes as the U.S. faces a greater need for lithium to meet its clean energy goals, with

production of electric vehicles rising. Exxon said it will use conventional oil and gas drilling methods to access lithium-rich saltwater from reservoirs about 10000 feet (3.05 kilometers) underground. It will then use "direct lithium extraction"

technology to separate lithium from the saltwater, and convert saltwater onsite to battery-grade material. The remaining saltwater will be re-injected into the underground reservoirs. Exxon Mobil said its extraction process produces fewer carbon emissions than

hard rock mining and requires significantly less land.

What a regional escalation could mean for MENA banks' external funding

The latest Israel-Hamas war has brought investor risk perceptions of the Middle East, including regional banks, back into focus. The situation is rapidly evolving, with uncertain outcomes. However, currently S&P Global Ratings believes that the economic and credit impacts are likely to be contained to Israel and its neighboring countries.

Against this backdrop, we have designed a hypothetical stress test to quantify the resilience of some rated Middle Eastern banking systems--including those in the Gulf Cooperation Council (GCC) countries, Jordan, and Egypt--to external funding outflows. For this, we use assumptions on the liquidity of external assets and outflows of external liabilities based on the most recent numbers published by regional central banks.

Under our standardized assumptions, external funding outflows could reach about \$220 billion, or about 30% of the tested systems' cumulative external liabilities. However, banks have sufficient external liquidity to cover these out-

Based purely on the quantitative results, Qatar, Egypt, and to a much lesser extent Jordan, display an external funding deficit. For Egypt, this relates to the recent build-up of external debt in the banking system. For Jordan, it is due to banks' activities in the Palestinian territories, which could prove resilient in the current context because any unexpected escalation may prompt more Palestinians to transfer their money to Jordan. For Qatar, it is due to the banking system's significant external debt and a shift in composition toward interbank deposits, although we note the strong track record

of government support.
While other systems look resilient, it is important to note that this depends on the capacity to liquidate their external assets abroad in a timely fashion and with manageable haircuts.


Why Were Some Countries Excluded? We have excluded Tunisia and Morocco's banking systems from our sample due to the limited external debt of these systems, which are dominated by nonresident deposits from nationals. We have also excluded Turkiye's banking system, despite its significant external debt, because of our view that the system is more sensitive to domestic events and investor confidence has been tested several times over the past five years. Moreover, a substantial portion of Turkish banks' foreign-currency-denominated assets are placed with the central bank

Our Adverse Scenario Of External Funding Outflows Under our base-case scenario, we assume that the war will remain centered in Israel and Gaza, but there are risks that it spreads. If there is a wider regional escalation (for example, through proxy conflicts), investors' risk perception of the Middle East may prompt some confidence-sensitive funds to leave, as seen during previous stress.

We note that banking system external debt has increased in some sample countries over the past few years. However, in most cases, this external debt was recycled into external assets, leaving the system in a net external asset position. Bahrain, Oman, Qatar, Egypt, and Jordan have recycled some external debt into domestic assets, such as lending to the local economy or investments in local assets. For Egypt, in particular, this shift is very recent.

To assess the potential implications of the recent escalation of geopolitical risk, we have examined the impact of external funding outflows under the following assumptions:

■ Outflows of external liabilities: A 50% outflow of interbank liabilities because these are generally more volatile than nonresident deposits--except for those due to banks' head offices and branches, for which we used an outflow rate of 20%. For nonresident deposits, an outflow of 30%. Furthermore, for capital market liabilities, an outflow rate of 10%, since these are mainly medium- to long-term instruments. No outflows in other liabilities. Where the breakdown of liabilities was not granular, an outflow of 50%, which was the case for Egypt and Jordan.



To fund these outflows, banks will have to liquidate their external assets. In a stressed environment, such liquidation could result in lower valuations for these assets, with our assumptions below:

■ Liquidation of external assets: A haircut of 10% on interbank deposits--20% for those due to head offices and branches since we assume that banks will keep some liquidity there. Regional banks tend to place their money with highly rated institutions. A haircut of 20% on investment portfolios abroad, typically held for liquidity management and mostly fixed-income instruments with good credit quality. Furthermore, a 100% haircut on loans to nonresidents and other assets, which we assume will be much more difficult to liquidate in a stress scenario. We applied these haircuts because we assume that banks may incur some reduction in the value of their assets if they want to liquidate them prematurely

Most Systems Can Absorb Outflows By Liquidating External Assets

The results of this hypothetical scenario suggest potential external funding outflows of about \$220 billion from the region, or about 30% of the selected systems' cumulative external liabilities (see chart 3). These are concentrated mainly in Qatar and the United Arab Emirates (UAE), followed by the offshore banking sector in Bahrain, because of the significant gross external debt of these countries (see chart 4). For the remaining systems, our assumed external funding outflows range from a limited \$3.5 billion for Oman to a manageable \$22.1 billion in Saudi Arabia.

Hyundai joins Honda and Toyota in 'raising' wages

SEOUL, Nov 14, (AP): South Korean automaker Hyundai has joined Honda and Toyota in raising factory worker wages after the United Auto Workers union reached new contract agreements with Detroit automakers.

Hyundai said Monday it will raise factory worker pay 25% by 2028, matching the general wage increase won by the UAW during that period. Toyota raised factory pay 9% to 10% starting in January, while Honda said it will increase wages 11% during the same pe-

Labor experts say the increases are at least in part aimed at thwarting UAW President Shawn Fain's strategy of trying to organize U.S. auto plants run by foreign automakers and Tesla in order to increase the union's bargaining power. Fain said terrified auto executives at nonunion plants are raising wages, and he called Toyota's pay increase the UAW bump.

"UAW, that stands for 'You Are Welcome," he said.

About 146,000 UAW members are voting on new contracts with General Motors, Ford and Jeep maker Stellantis that give them 25% general wage increases over the next four years and eight months. When cost of living wages are factored in, workers will get about 33% raises, with the top assembly line employee making about \$42 per hour.

Toyota and Honda also accelerated the time it takes for a starting employee to reach the top pay rate, also matching or coming close to the time period in the new UAW contracts.

Harry Katz, a professor of collective bargaining at Cornell University, said it's likely the UAW settlement contributed to the raises at the nonunion factories.

"There's also a strong labor market, the companies are doing very well,' Katz said. "They've always wanted to stay nonunion, and they try to stay close to the Detroit top-tier wages."

In announcing its factory pay increases, Hyundai wouldn't say how much the hourly wage is at its factory in Montgomery, Alabama, or how much it will pay at an electric vehicle factory under construction near Savannah, Georgia. By early next year the company said it will have increased factory worker pay 14% in the past

Katz estimated that Hyundai now pays around \$25 per hour, and he says the nonunion plants' retirement, health care and other benefits are typically not as good of as what UAW workers get.

'Hyundai continuously strives to maintain competitive wages and benefits commensurate to industry peers,' Jose Munoz, Hyundai's chief operat-

Talks on a landmark treaty to end global plastic pollution are advancing in Nairobi

NAIROBI, Kenya, Nov 14, (AP): Efforts to create a landmark treaty to end global plastic pollution advanced Monday in Kenya's capital as nations, plus petrochemical companies, environmentalists and others affected by the pollution gathered to discuss draft language for the first time.

The gathering in Nairobi is the third in a compressed five-meeting schedule intended to complete negotiations by the end of next year.

"The urgency of addressing plastic pollution cannot be overstated," said Gustavo Adolfo Meza-Cuadra Velasquez, chair of the negotiating committee, at the headquarters of the United Nations Environment Programme in Nairobi. "To bring a difference at the scale required, we must work collec-

Kenya's President William Ruto called the treaty "the first domino" in a shift away from plastic pollution.

But the negotiations have been strained by concerns over delays in discussing the plastics issue at hand. In the last round of talks in Paris, talks stalled for about two days as some

The power dynamics and positions of different delegations became clear in the first two rounds of talks in Paris and Punta del Este, Uruguay. They echo some of the same positions as in international climate talks, and with good reason - many of the players are the same. Plastic is largely made from crude oil and natural gas, giving oil-producing countries and companies a large stake in any treaty.

Global negotiators last met in Paris in June and agreed to produce initial treaty text before reconvening in Nairobi. The draft was published in early September. The U.N. Intergovernmental Negotiating Committee on Plastic Pollution is charged with developing the first international, legally binding treaty on plastic pollution on land and at sea.

Kenya is a global leader in fighting plastic pollution, and in 2017, the country banned the manufacture, sale and use of single-use plastic bags. In what is one of the strictest bans on the products, lawbreakers face fines and up to four years in jail.

Two years later, Kenya banned single-use plastic like cutlery, straws and PET bottles from parks, forests, beaches and other protected areas. Kenya is also an important player in environmental matters as home to UNEP's headquarters. The country generates more than 70% of its electricity from renewable sources.

Norway and Rwanda are leading a "high ambition coalition" of governments that want to end plastic pollution by 2040 by cutting production and limiting some chemicals used in making plastics.

The two countries issued a ministerial joint statement this month calling for an ambitious and effective treaty to protect human health and the environment from plastic pollution by addressing the full life cycle of plastics. They expressed "deep concern" about significant increases in plastic production, plastic litter and greenhouse gas emissions. Plastic production is forecast to triple by 2060, according to UNEP.

El Salvador slaps a \$1,130 fee on African and Indian travelers

El Salvador's government has begun slapping a \$1,130 fee on travelers from dozens of countries connecting through the nation's main airport, amid U.S. pressure to help control migration flows to its southern border.

Since the end of October, citizens of 57 largely African countries and India have had to pay the fee, according to El Salvador's aviation authority.

Aviation officials did not say whether the measure was aimed at reducing migration and have described the tariff as an "airport improvement fee," but El Salvador's government acknowledged an uptick in travelers from those countries this year.

Also, the U.S. has been pressuring Central American countries to curb migration flows to its border with Mexico. U.S. authorities say they stopped migrants there more than 2 million times during the fiscal year that ended Sept. 30.

El Salvador's aviation authority said most passengers who have to pay the fee are headed to Nicaragua on the commercial airline Avianca. Because of its lax visa requirements, Nicaragua is a transit point for migrants from Haiti and Cuba, as well as from Africa, who are trying to reach the U.S.

Earlier this year, for example, U.S. officials were surprised by an increase in Mauritanian migrants arriving at the southern border. No natural disaster, coup or sudden economic collapse could explain it. Rather, travel agencies and social media influencers were promoting a multileg trip that took migrants from the west African nation to Nicaragua.

A flight itinerary of one Senegalese migrant seen by The Associated Press showed the migrant passing through Morocco, Spain and El Salvador before landing in Managua. The last two legs were aboard Avianca flights.

El Salvador's aviation authority and immigration agency both said they did not have data on how many migrants from the listed countries had transited the country this year.

A U.S. embassy spokesperson declined to say whether the U.S. had requested the fee. But the ability to help the U.S. control migration could be a political boon for El Salvador President Nayib Bukele as he seeks reelection despite a constitutional prohibition and faces scrutiny for his human rights record.

President Donald During Trump's administration, U.S. policy toward El Salvador prioritized reining in migration above all else and Bukele heard no public criticism from the U.S. as he began to consolidate power. Under President Joe Biden, the U.S. has been openly critical of Bukele's record on democracy and human rights.

The U.S. State Department alleged that Bukele's war against powerful street gangs has resulted in "torture and other cruel, inhumane or degrading treatment or punishment, and other related abuses" to tens of thousands of people detained. His government has also gone after journalists, activists and critics.

But migration now appears to be back at the top of the bilateral agenda for the two countries as Biden also seeks reelection.

While the Biden administration has said Central American nations ' need to step up and do more" to control migration, not all of them have received the request with open arms.

"Most governments have recognized that what is of clear interest to the United States is migration and so therefore it becomes a bargaining chip," said Pamela Ruiz, Central America analyst for International Crisis Group. "They will either become partners or adversaries on this is-

Guatemala, Costa Rica, Colombia and Ecuador have worked with the U.S. to open centers for migrants looking to request asylum, apply for family reunification or temporary work permits.

On the other hand, Nicaragua has opened its doors to hundreds of charter flights carrying tens of thousands of U.S.-bound Cuban and Haitian migrants in recent months.

The flights - which one analyst described as Nicaragua "weaponizing migration as a foreign policy" - were met by a fierce warning from the Biden admin-

istration. "We are exploring the full range of possible consequences for those who facilitate this form of irregular migration," wrote U.S. Assistant Secretary of State for Western Hemisphere Affairs Brian A. Nichols in a post on X, formerly Twitter, this month. Haiti's government announced the charter flights were being temporarily suspended.

As Bukele again came under criticism in recent weeks as he registered to seek reelection in 2024. the Biden administration was cautious in its remarks.

"There has to be a broad debate about the legality and legitimacy of the election, but it is a debate for Salvadorans," Nichols said during a recent visit to El Salvador and ahead of a meeting with Bukele.

The comments were a sharp contrast to condemnations of "antidemocratic behavior" in neighboring Guatemala's elections months earlier.

Bukele "is willing to cooperate on immigration by banning certain nationalities by charging them a ridiculous fee in order to not get critiqued on the international level," said Ruiz, of Crisis Group. "Part of me wonders ... we will not critique the Bukele administration as much because it's supposedly reducing the levels of migrants?" (AP)



Prince's items auction

Dylan visits '78 Tokyo shows with flute & all

LOS ANGELES, Nov 14, (AP): Bob Dylan with flute and saxophone isn't for everyone

But that's what you get with "The Complete Budokan 1978," a deluxe box set presenting two live shows at Tokyo's Nippon Budokan Hall, from a tour that has been derided in some corners as "Dylan going Vegas."

The extravagantly packaged four-disc set expands upon the 1979 "Bob Dylan at Budokan" live record that caught Dylan in Japan on just the second week of his 1978 world tour that would run for 10 months.

The tour started after the widely acclaimed Rolling Thunder guerilla tours across the United States in 1975 and 1976, and just before Dylan's conversion to Christianity in 1979.



In fact, Dylan has pointed to a fan throwing a small silver cross on stage in November 1978 as helping to spur his conversion. But that's a story for another time, and one that was explored deeply in the "Trouble No More" box set released in 2017.

"The Complete Budokan 1978" includes full concerts from Feb. 28 and March 1, 1978 with Dylan breaking out dramatically reworked ver-

sions of his well-known songs complete with backing singers, violin, flute and saxophone. Even today, 45 years later, the arrangements are striking for how far afield they are from the recorded versions.

A chipper, violin-heavy instrumental version of "A Hard Rain's A-Gonna Fall" opens both concerts and sets the mood.

On "Mr. Tambourine Man," Dylan speeds up the tempo with the flute front and center. And on "I Threw it All Away," the backing singers are given a prominent role as Dylan tinkers with the lyrics. If you ever wanted to hear "All Along the Watchtower" with flute, now is your chance.

It can be jarring for those not already well-versed with the original 1979 live release. But for Dylan fans who have eschewed this period of his career, there are

hidden gems here worth uncovering.
"The Man in Me," in just its sixth time played live and with new lyrics, is beautifully delivered, complete with a saxophone solo. "One of Us Must Know (Sooner or Later)," from 1966's "Blonde on Blonde" also shines under a dramatic reworking, with the backing singers and sax giving the song new dimensions.

The packaging is top notch, with an expansive 12-by-12 inch photo book, liner notes and a box of memorabilia that includes two posters, replicated tour program, tickets and flyers.

Not quite dark pop, not quite techno, not quite any genre at all, Poppy's fifth studio album, "Zig," is rather a mix of several different styles and an example of how far she's come since her debut five years ago.

"Zig" strays far from Poppy's old bubblegum pop sound for those who remember her 2017 debut, "Poppy.Computer," which followed her earliest introductions to the cute-but-strange, pseudo-AI Poppy character - first discovered via surreal performance art YouTube videos in 2015. The bleach-blonde android is nowhere to be seen in "Zig," but that's not a surprise - she's been gone for some time now.

Poppy's style and sound started to shift with her second album, 2018's "Am I a Girl?" which started to take a heavy metal turn, followed by the even darker "I Disagree" in 2020. She scaled it back for the more alternative "Flux," and now she's back with "Zig," the evolved combo of her past works.

Backed by synths and electric beats, the sugarysweet vocals of the 28-year-old singer-songwriter, born Moriah Rose Pereira, are heard on "Zig" in several different forms, from heavy metal screaming to soulful serenading. She may still be figuring out her sound, but there's a confidence to "Zig" that implies she knows exactly what she is doing.

Highlights of the album can be found in "Knockoff," a bumping pop-ish anthem, and "Motorbike," a zooming description of a free spirit on a motorcycle. ("Girl on a motorbike/No one can confine her/Epitome of freedom/I'm following behind her," she sings.)

The duds lie in the songs with lackluster, repetitive lyrics like "1s + 0s," and, disappointingly, namesake

"Zig," the chorus of which goes as follows:
"When you zig I zag/When you zig I zag/I zig zag."

It's especially dumbfounding when other tracks' lyrics are nothing but pure poetry. Take these lines from the lovely "Linger," for example: "In the whites of your eyes/I can see my next life/Smell the lilies at night/Tell me what you will remember me by.'

'Zig" is overall an interesting, experimental mix that demonstrates how Poppy has grown over the years. Since it blends so many different genres, this album just might have a song for everyone, so it's definitely worth a listen.

BOSTON: Fans of **Prince**, who was known nearly as much for his extravagant wardrobe as for his charttopping hits, will have a chance to bid on some of the late musician's sartorial splendor in an online auction this week.

The collection, including more than 200 lots up for sale, was assembled by a French collector who initially hoped to open a museum celebrating the musician but later scrapped the plan, according to RR Auction of Boston, which is overseeing the sale.

The collector had reached out to individuals who worked closely with Prince to gather the items, believing that the trendsetting artist, who died in 2016, was not only a musical virtuoso but also a fashion icon, according to the auction house.

One of the highlights of the auction is a white ruffled shirt worn by Prince during his 1985 American Music Awards performance of the song "Purple Rain.

The auction house estimated its value at \$15,000. The auction traces Prince's evolution in music and fashion from his "Purple Rain" era through to his death, according to Bobby Livingston of RR

'What this auction really does is it shows the influence and legacy of Prince with his fashion choices and how it relates today, when you see all these artists on tour, you know, different costumes, different outfits, reinventing themselves for each tour," he said.

Also up for auction is the outfit Prince wore from "Under the Cherry Moon," a 1986 film starring Prince that also marked his debut as a director. The auction house placed an estimated value on the outfit of

Daniel Sancho Bronchalo, 29, was indicted by prosecutors last month over the death of Edwin Arrieta Arteaga, whose remains were found stuffed in plastic bags at a landfill on **Ko Pha** Ngan, an island famous for its rave-style "full moon parties." The indictment laid out the charges of premeditated murder, concealment of the body and destruction of other people's documents.

The Ko Samui Provincial Court and the local prosecutor said Sancho pleaded not guilty to two of the charges. The Spanish news agency EFE reported that sources close to his family said he pleaded not guilty to the murder and destruction of documents charges but pleaded guilty to the charge of hiding the victim's body. Logic of vulture brain remedies and bloodletting lives on today

Modern medicine has its scientific roots in the Middle Ages

Nothing calls to mind nonsensical treatments and bizarre religious healing rituals as easily as the notion of Dark Age medicine. The "Saturday Night Live" sketch Medieval Barber Theodoric of York says it all with its portrayal of a quack doctor who insists on extracting pints of his patients' blood in a dirty little shop.

Though the skit relies on dubious stereotypes, it's true that many cures from the Middle Ages sound utterly ridiculous - consider a list written around 800 C.E. of remedies derived from a decapitated vulture. Mixing its brain with oil and inserting that into the nose was thought to cure head pain, and wrapping its heart in wolf skin served as an amulet against demonic possession.

"Dark Age medicine" is a useful narrative when it comes to ingrained beliefs about medical progress. It is a period that stands as the abyss from which more enlightened thinkers freed themselves. But recent research pushes back against the depiction of the early Middle Ages as ignorant and superstitious, arguing that there is a consistency and rationality to healing practices at that time.

Innovation

As a historian of the early Middle Ages, roughly 400 to 1000 C.E., I make sense of how the societies that produced vulture medicine envisioned it as one component of a much broader array of legitimate therapies. In order to recognize "progress" in Dark Age medicine, it is essential to see the broader patterns that led a medieval scribe to copy out a set of recipes using vulture organs.

The major innovation of the age was the articulation of a medical philosophy that validated manipulating the physical world because it was a religious duty to rationally guard the body's health.

The names of classical medical innovators like Hippocrates and Galen were well known in the early Middle Ages, but few of their texts were in circulation prior to the 13th century. Most intellectual activities in northern Europe were taking place within monasteries, where the majority of surviving medical writings from that time were written, read, discussed and likely put into practice. Scholars have assumed that religious superstition overwhelmed scientific impulse and the church dictated what constituted legitimate healing - namely, prayer, anointing with holy oil, miracles of the saints and penance for sin.

However, "human medicine" - a term affirming human agency in discovering remedies from nature - emerged in the Dark Ages. It appears again and again in a text monks at the monastery of Lorsch, Germany, wrote around the year 800 to defend ancient Greek medical learning. It insists that Hippocratic medicine was mandated by God and that doctors act as divine agents in promoting health. I argue in my recent book, "Embodying the Soul: Medicine and Religion in Carolingian Europe," that a major innovation of that time was the creative synthesis of Christian orthodoxy with a growing belief in the importance of preventing disease.

Establishing an intellectual framework for medical study was an accomplishment of early medieval scholars. Doctors faced the risk of being lumped together with those who dealt in sorcery and pagan folklore, a real possibility given that the men who composed the Greek medical canon were pagans themselves. The early medieval scribes responsible for producing the medical books of their age crafted powerful arguments about the respectability and piety of the doctor. Their arguments manifest in illustrations that sanctified the human doctor by setting him parallel to Christ.

This sanctification was a crucial step in including medicine as its own advanced degree program at the first universities that were established around 1200 in Europe. Thus began the licensing of healers: the elite "phisici" - the root of the English word "physician" - trained at the university, along with empirical practitioners like surgeons, herbalists and female healers who claimed a unique authority to treat gyne-

cological illnesses.

Today, religious dogmatism is often equated with vaccine hesitancy and resistance to basic scientific truths like evolution. But deeply religious thinkers of the past often saw rational medicine as an expression of faith, not something endangering it. Herbal remedies were scribbled into the margins of early medieval works on theology, history, church sacraments and more. This suggests that book owners valued such knowledge, and people of all classes were actively exchanging recipes and cures by word of mouth before writing the most useful ones down.

Though the Dark Ages is a period from which no case histories survive, we can still form a picture of an average healing encounter. Texts from that period emphasize the need for the doctor to be highly learned, including being well read in philosophy, logic, arithmetic and astronomy. Such knowledge enabled healers to situate their observations of sick bodies within the rules that governed the constant transformations of nature.

There was no way to perceive the internal state of the body via technology - instead, healers had to be excellent listeners and observers. They sought to match the patient's description of suffering with signs that manifested externally on the body. The inside of the flesh could not be seen, but the fluids the body excreted - sweat, urine, menstrual blood, mucus, vomit and feces - carried messages about that invisible realm to the outside. The doctor's diagnosis and prognosis relied on reading these "excreta" in addition to sensing subtle changes in the pulse.

Medieval people were detailed investigators of the natural world and believed the same forces that shaped the landscape and the stars operated inside bodies formed from the same four elements of earth, water, air and fire. Thus, as the moon's waxing and waning moved the ocean tides, so did it cause humors inside the body to grow and decrease.

The way the seasons withered crops or provoked tree sap to flow might manifest in the body as yellow bile surging in the summer, and cold, wet phlegm dripping in the winter. Just as fruit and meats left untouched began to rot and putrefy, so did dregs and undigested material inside the body turn poisonous if not expelled. Standing water in ponds or lakes generated slime and smell, and so were liquids sitting stagnant in the body's vessels seen as breeding grounds for corrupt vapors.

Seasons

In this sense, the menstrual cycle was representative of all bodies, undergoing internal transformations according to seasonal cycles and periodically purged in order to release pentup fluids.

According to this logic, health depended above all on maintaining the body's relationship to the physical environment and ensuring that substances were passing through their proper transformations, whether it was food turning into humors, blood disseminating throughout the body, or excess fluids and wastes leaving the body. Bloodletting was a rational therapy because it could help rebalance the fluids and remove toxins. It was visible and tangible to the patient, and, to the extent that we now better understand the placebo effect, it may well have offered some kind of relief.

Fasting, purging, tonics and, above all, monthly dietary regimens were also prominent tools healers used to prevent and relieve sickness. Several medical books, for instance, specified that consuming drinks with cinnamon in November and pennyroyal in August could recalibrate the body's temperature in winter and summer because one drink was warming while the other was cooling.

Some medieval remedies - such as one produced from wine, cow bile, garlic and onion to heal eye infections - were later proven to be likely effective in treating sickness. But whether these remedies worked isn't the point. For medieval doctors, vulture brains and cow bile operated according to the same logic that continues to inform research today: Nature operates in mysterious ways, but rational deduction can unlock the hidden mechanisms of disease. The M.D. has direct roots in the Dark Age el-

evation of "human medicine."

Before mocking medieval doctors, consider how popular juice cleanses and detox regimens are in the 21st century. Are we really so far from humoral medicine today? (AP)

Nations make minor progress on climate action

UN chief calls for an 'ambition supernova'

NEW YORK, Nov 14, (AP): Countries' climate action plans are still far behind what's needed to curb human-caused warming and limit the devastating effects of extreme heat, storms and droughts, but some nations have taken marginal steps toward slashing emissions, a United Nations analysis of national plans found Tuesday.

The report looked into the climate plans of 195 countries and found that emissions from the burning of coal, oil and gas will go up 9% by 2030 compared to 2010 levels, but will be 2% lower than 2019 levels because of some climate action from countries switching to cleaner energy. But climate scientists warn that the world needs to spew around 45% less by then.

"The world is failing to get a grip on the climate crisis," United Nations Secretary-General Antonio Guterres said in a statement. "Inch by inch progress will not do. It is time for a climate ambition supernova in every country, city, and

He called for "net-zero" - when countries only spew as much carbon into the atmosphere as they can take back out - in developed countries to happen by "as close as possible" to 2040, and 2050 for developing nations.

The UN climate chief, Simon Stiell, urged that upcoming international climate talks in Dubai become a "turning point" where governments can get on track with plans to cut emissions in line with capping warming at 1.5 degrees Celsius (2.7 degrees Fahrenheit), as agreed by nations in Paris in 2015.

"Governments must not only agree what

stronger climate actions will be taken but also start showing exactly how to deliver them," Stiell said in a press statement. He said that billions around the world expect governments to act on climate change.

Sultan al-Jaber, president of the COP28 climate talks in Dubai and chief of the Abu Dhabi National Oil Company, said the report shows "there is simply no time left for delays."

Extreme weather events charged by the warming atmosphere are increasing in magnitude and frequency around the world. The last 12 months were the hottest yearlong period ever recorded, according to a recent analysis. Many recent droughts, floods and storms were found to have fingerprints of human-cause climate change, according to attribution scientists.

When countries meet in Dubai, they'll review their climate action for the last three years as part of what's been called a "global stock-

take." Negotiators plan to use this report and discussions later this year to figure out what nations need to do next to fight climate change.

Climate activists said the report is just one

more reason why global leaders should be held accountable for their inaction at the talks.
"It's already hell for a lot of people," said Disha Ravi, an Indian activist with the youth climate group Fridays for Future, of current

extreme weather. "I sometimes wonder if they (leaders) care about lives at all."

"Leaders have continued prioritizing profits over the health and safety of our planet and its inhabitants," she said. "We cannot continue this

way."

The world is off track in its efforts to curb global warming in 41 of 42 important measurements and is even heading in the wrong direction in six crucial ways, a new international

Warming

report calculates

The only bright spot is that global sales of electric passenger vehicles are now on track to match what's needed - along with many other changes - to limit future warming to just another couple tenths of a degree, according to the State of Climate Action report released Tuesday by the World Resources Institute, Climate Action Tracker, the Bezos Earth Fund and others.

On the flip side, public money spent to create more fossil fuel use is going in the wrong direction and faster than it has in the past, said study co-author Kelly Levin, science and data director at the Bezos Earth Fund.

"This is not the time for tinkering around the edges, but it's instead the time for radical decarbonization of all sectors of the economy," Levin said.

"We are woefully off track and we are seeing the impact of inaction unfold around the world from extensive wildfire fires in Canada, heatrelated deaths across the Mediterranean, record high temperatures in South Asia and so on," she

Later this month, crucial international climate negotiations start in Dubai that include the first time world negotiators will do a global stocktake on how close society is to meeting its 2015 climate goals. In advance of the United Nations summit, numerous reports from experts are coming out assessing Earth's progress or mostly the lack of it, including a United States national assessment with hundreds of

indicators. Tuesday's 42 indicators offers one of the grimmest report cards, detailing multiple failures of society.

The report looks at what's needed in several sectors of the global economy - power, transportation, buildings, industry, finance and forestry - to fit in a world that limits warming to 1.5 degrees Celsius (2.7 degrees Fahrenheit) over pre-industrial times, the goal the world adopted at Paris in 2015. The globe has already warmed about 1.2 degrees Celsius (2.2 degrees Fahrenheit) since the mid 19th century.

Six categories - the carbon intensity of global steel production, how many miles passenger cars drive, electric buses sold, loss of mangrove forests, amount of food waste and public financing of fossil fuel use - are going in the wrong direction, the report said.

"Fossil fuel consumption subsidies in par-

\$1 trillion, driven by the war in Ukraine and the resulting energy price spikes," said report co-author Joe Thwaites of the Natural Resources Defense Council environmental group.

Another six categories were considered "off track" but going in the right direction, which is the closest to being on track and better than the 24 measurements that are "well off track." Those merely off track include zero-carbon electricity generation, electric vehicles as percentage of the fleet, two- and three-wheel electric vehicle sales, grazing animal meat production, reforestation and share of greenhouse gas emissions with mandatory corporate climate risk reporting requirements.

People should be worried that this report is one of ''too little, too late," said Arizona State University climate scientist Katharine Jacobs, who wasn't part of the report but praised it for being so comprehensive.

"I am not shocked that at a global scale we are not meeting expectations for reducing emissions," Jacobs said in an email. "We cannot ignore the fact that global commitments to (greenhouse gas) reductions are essentially unenforceable and that a number of major setbacks have taken a toll on our progress."

When trying to change an economy, the key is to start with "low-hanging fruit, i.e., the sectors of the economy that are easiest to transition and give a big bang for your buck," said Dartmouth climate scientist Justin Mankin, who isn't part of the report. But he said the report shows "we're really struggling to pick the low-hanging fruit."


In Knoxville, Tennessee, Sara Puckett scored a career-high 24 points and Tennessee closed out overtime with a 9-0 run to beat Memphis.
