Thank you Minister of Information and whoever said the word of truth to 'decarbonization' targets

FROM 33 articles in the press and publications law issued in 2006 to 104 articles in the unified media law, there is a milestone decline in how freedom is dealt

If this proposal gets passed by the Ministry of Information, which will soon be in the custody of the Education Committee and the General Secretariat of the National Assembly, there will be a long journey of torment and horror awaiting

Many observations were made by journalists, writers, and editors-in-chief regarding the old law. Now this is being followed by a draft that contains nothing but darkness.

Therefore, what had been raised more than once in the past 17 years regarding media openness, and despite many cases that were filed regarding articles and news, the judiciary was merciful in dealing with them because that's how the society was at that time.

Today, we are getting a law that combines the media and the penal laws. This only exists in repressive police states, not in a country that is supposed to be democratic, and where freedom of opinion is constitutionally guaranteed.

All of this is the same as in the new proposal. We therefore say "thank you' to the Minister of Information Abdul Rahman Al-Mutairi for understanding the demands of academics, editors-in-chief, and journalists, and eliminating some of the poisonous spikes in the new law.

Nonetheless, this proposal remains silent, even outside the framework of the era because it simply did not realize in its depths that the world had changed, and the open spaces prevented any repression.

Therefore, the fraud in some of its articles, which refers the writer to State Security in line with article 15 of the Penal Code, and imposes the most severe penalty of up to 15 years in prison on him, undermines freedoms from the start.

We beg to ask - What is the fault of the institution, its employees, and the editorin-chief for a word or phrase that was inadvertently mentioned in an article or news, and for the newspaper to be closed for a week, month, or year?

This only happens in repressive countries, where intelligence services count people's lives, and where injustice and abuse are widespread with the matter sometimes leading to security unrest, uprisings, and revolutions.

Kuwait affirms commitment

Undersecretary Sheikh Nemr Fahad Al-Sabah agreements supporting decarbonization efforts and boosting cooperation to meet future demands, as per leadership's directives on heading towards renewable energy.

Undersecretary Al-Sabah stated this to KUNA following ADIPEC 2023 opening ceremony. ADIPEC is a conference and exhibition handling challenges faced by the energy sector, including decreasing carbon emissions by 2050 as well as prepping for COP28 to be held in Dubai from November 3 to December

The Ministry official underscored the importance of such an event saying that he is looking forward to the constructive discussions and fruitful negotiations it would promote, especially as leading figures in the sector will be in attendance.

ADIPEC, sponsored by President of the United Arab Emirates Sheikh Mohammad bin Zayed Al-Nahayan, is a platform allowing energy sector to come together with other sectors to find solutions and arrive at future

COP28 President-Designate Dr. Sultan Al Jaber called on the oil and gas industry to rally around ambitious decarbonization targets as part of the COP28 Presidency's Action Agenda to fast-track the energy transition and

keep 1.5C within reach. Dr. Al Jaber reiterated calls on industry to "step up, align around net zero by or before 2050, zero-out methane emissions, and eliminate routine flaring by 2030." He welcomed recent progress and action from over 20 oil and gas companies, including both international and national oil companies (IOCs and NOCs), which have "positively answered the call" to take the challenging but achievable steps to curb emissions from the production of energy.

Describing the progress, Dr. Al Jaber said, "This took time, effort and many months of hard work, negotiation and collaboration. We are counting on many more to come onboard and start taking action to decarbonize further and faster. I urge everyone to make this commitment at COP28, a COP where I am calling on everyone to set the highest ambitions, follow through with practical actions and deliver real results.

Dr. Al Jaber issued his call to action at the beginning of the 2023 Abu Dhabi International Petroleum Exhibition & Conference (ADI-PEC), the largest and most inclusive energy industry gathering. The event was attended by HH Shiekh Mansour bin Zayed Al Nahyan, Vice President of the United Arab Emirates. along with 160,000 energy professionals, 2,200 exhibiting companies, 54 NOCs, IOCs,

and IECs. Setting off the event which runs from 2-5 October, Dr. Al Jaber said that "This industry can and must help to drive the solutions. For too long, this industry has been viewed as part of the problem, that it is not doing enough and, in some cases, even blocking progress. This is your opportunity to show the world

that, in fact, you are central to the solution." Noting the scale of the climate challenge, Dr. Al Jaber stated that "the world must reduce emissions by at least 43% over the next 7 years to keep 1.5 within reach. And that is our north star. It is our destination. It is simply respecting the science. And we must do this while also ensuring human prosperity by meeting the energy needs of the planet's growing population.

Describing the necessary actions, Dr. Al Jaber highlighted three key areas that he was prioritizing, including: curbing emissions from the production of energy, scaling up renewables, and decarbonizing hard-to-abate sectors, such as steel cement, aluminum and heavy transportation.

Telecommunication companies give KD 3,000 per year to the owner of such houses, taking advantage of the private nature of these houses, as it is not easy to be inspected. They also get another advantage of the subsidised cost of electricity.

MP Al-Matar stressed that the Council of Ministers is the relevant institution because of the fact that the issue concerns several ministries and public institutions including the Communications and Information Technology Regulatory Authority (CITRA).

'Internet crimes under **Kuwait legal authority**


ernment administrations have proposed laws that impact these freedoms. Comparing our standards with Western countries suggests a more limited freedom of expression in Kuwait.

In practice, the Ministry of Interior's role in overseeing digital communications is increasing. Does its jurisdiction solely rest on formal complaints, or does it also consider factors like societal sensitivities, public sentiment, and media reverberations? While formal complaints are essential for cases of slander or defamation, the digital realm has broadened the spectrum of possible offenses. These range from inciting hostility, questioning societal norms, spreading deceptive narratives, to crossing religious lines. Unfortunately, people in many times face legal consequences for their digital content, even when their statements are truthful and unbiased.

This raises a pivotal question: How should we legally define these digital platforms? Drawing from various judicial precedents, we can view these platforms as public spaces. Therefore, digital communicators, whether they are tweeters or publishers, might encounter legal consequences regardless of where the offense took place. Kuwait's Cassation Court contends that the Penal Code applies to Kuwaiti citizens who commit offenses overseas. Recognizing the internet's global reach, the court maintains that, because of its universal access, digital infringements fall under Kuwait's jurisdiction.

In monitoring these digital platforms, the dedicated Electronic and Cyber Crime Police consistently spot users involved in dubious online

Cabinet congratulates Kuwait Amir on third anniversary of rule

KUWAIT CITY, Oct 2, (KUNA): Kuwait's Cabinet on Monday congratulated His Highness the Amir Sheikh Nawaf Al-Ahmad Al-Jaber Al-Sabah on the third anniversary of his rise to power, saying his "wise leadership" has placed the nation firmly on the path towards prosperity and development.

During the Cabinet's customary session, presided over by Acting Prime Minister and Interior Minister Sheikh Talal Al-Khaled Al-Sabah, Information Minister Abdulrahman Al-Mutairi spoke of national preparations



ahead of "Expo 2025 Osaka," a global Japan-hosted event in which Kuwait will be represented through a special

The minister heaped praise on statewide efforts aiming to depict the nation in a "positive light" at the expo, saying that Kuwait was the first Arab nation and the eighth globally to have agreed on setting up a booth at an event of such magnitude.

Minister of Commerce and Industry Mohammad Al-Aiban, who doubles as Minister of State for Youth Affairs, briefed the Cabinet on his recent visit to Hangzhou, China, the site of the ongoing 19th Asian Games, where he met his compatriot athletes to check on their level of preparedness as they represent national colors.

The minister personally surveyed the facilities in the Chinese city, while he has also attended a number of contests in which Kuwaiti athletes took part, saying he was confident in their abilities to elevate the nation to the upper echelons on international sports.

Discussing current regional and global happenings, the Cabinet deplored a recent drone attack perpetrated by Yemen's Houthi movement against forces of the Saudi-led coalition, where some four Bahraini troops lost their

Tent market at slaughterhouse?

KUWAIT CITY, Oct 2: The Municipal Council, during its regular session yesterday, headed by Abdullah Al-Mahri, approved the Public Markets Committee's proposal to change the slaughterhouse site to a temporary tent market site in Shuwaikh Industrial Area.

In the same context, Head of the Municipal Council Abdullah Al-Mahri said, "The council supports any project managed or owned by a Kuwaiti citizen. It supports any

amendment that is in the interest of the investor.

Meanwhile, Director of the Legal Department Hussein Al-Ajmi said, "Changing the location of the slaughterhouse to a temporary tent market, or adding any conditions or texts, is up to the Municipal Council,



while the signing of the contracts will be with state property.

Also, Êngîneer Hassan Al-Kandari, a member of the Municipality's Tents Marlongs to the Kuwait Municipality, but the previous one belonged to the State Property Administration.

He stressed that the KD 50 fee collected by the municipality is not a rental value, but rather an estimate in exchange for cleaning. security and monitoring services for the market.

Eng. Al-Kandari revealed that the market in the past lacked safety requirements, but in the new location, there is coordination with the fire department, and the operation will be different from the previous one.



'Charge your EV at fuel stations'

KUWAIT CITY, Oct 2: The Kuwait National Petroleum Company (KNPC) is currently developing a plan to provide charging points for electric vehicles at

Informed sources from the Ministry of Electricity, Water and Renewable Energy affirmed the ministry's readiness to cooperate and coordinate with the concerned company to implement its strategy aimed at providing vehicle charging points as an additional service at the fuel stations affiliated with the Kuwait National Petroleum Company starting from 2030.

They explained that the ministry had finished preparing the list of chargers for electric vehicles in Kuwait in September last year. It included the strategies, regulating rules, principles, and standards for the charger system for electric vehicles. It also included the principles of connecting the system to the network of the Ministry of Electricity, Water and Renewable Energy, in accordance with the technical conditions and standards appropriate to the climatic conditions of Kuwait with regard to electric car chargers.

The trend towards providing vehicle charging points in a number of sectors and locations across the country, including government and private institutions, comes within the framework of the ministry keeping pace with the global shift towards electric cars with the aim of using clean energy for transportation, and reducing carbon dioxide emissions and other pollutants in line with the New Ku'Better living'

Allowance hike eyed

KUWAIT CITY, Oct 2: The government is studying the possibility of increasing the cost of living allowance for Kuwaitis from 120 to 250 dinars. reports Al-Qabas daily quoting reliable source.

The source said: "The government will work first to stabilize prices, before approving any financial increases in the country," noting that "it will implement a joint mechanism whose duration does not exceed 90 days to control any high prices for consumer goods and products in cooperative societies, retail stores, and supermarkets.

The source explained that "the strategic alternative is still under study, and requires time," pointing out "several points that require lengthy study, the most prominent of which is that there are approximately 400 government job titles and more than one job grade, which needs to be researched, so that they are equal in all government institutions.

The source indicated that the alternative would cost the state at least one billion dinars annually and there are several economic studies underway in this regard.

'Iraqi Federal Supreme Court's ruling is an attack on history'

"THE recent ruling by the Iraqi Federal Supreme Court concerning the agreement governing maritime navigation in Khor Abdullah between Iraq and Kuwait brought back memories of the political tensions experienced in the 1960s and 1970s," columnist **Abdullah Bishara** wrote for **Al-Qabas** daily.

"During that era, we grappled with heightened anxiety and tension in our interactions with the Iraqi government, countering its ambitions in Kuwaiti territory through its "programmed advance" plan.

"This plan incrementally encroached upon Kuwaiti territory, and Kuwait's response primarily entailed summoning the Iraqi ambassador and conveying dissatisfaction and anger. The Iraqi ambassador would promise to escalate the matter to higher authorities in Baghdad.

"This state of affairs persisted from 1963 until the Iran-Iraq war, during which Kuwait displayed tolerance to enable Iraq to defend itself against Iranian attacks. Kuwait dedicated its ports, airports, and roads to this cause. Following the ceasefire in 1988 until the invasion in August 1990, Kuwait rejected an Iraq-proposed draft border security agreement that aimed to provide Iraq ports and a special road, with Iraq responsible for security, extending from the north to the port of Shuaiba in southern Kuwait.

"This period highlighted Sheikh Sabah Al-Ahmad's steadfast rejection of such attempts and his insistence on Kuwait's commitment to the defense agreement. However, Saddam Hussein remained undeterred, ultimately invading Kuwait to subdue its rejection of his ambitions.

"In the aftermath of the invasion, Kuwait's leadership made the historic decision to forge a strategic partnership with the United States and Britain to ensure Kuwait's stability, integrity, and regional stability. This move marked a significant departure from Kuwait's diplomatic philosophy between 1961 and 1990, which relied on Arab solidarity, unity of Arab positions, respect for the Charter of the Arab League, and the integrity of member states' legitimacy.

With this strategic shift, Kuwait's diplomacy has since provided a robust security deterrent, a crucial element missing since its independence in 1961.

"I have reviewed the Federal Supreme Court's record regarding the agreement, initiated by a member of Parliament, that was nullified due to not garnering the required two-thirds majority for parliamentary approval. The historical narrative presented in the record lacked accuracy, was riddled with distortions of facts, and contained additions that held no substantive weight.

"In response to the Iraqi court's decision, Kuwait promptly reacted during a meeting between His Highness the Prime Minister and the Prime Minister of Iraq, Mr. Muhammad Al-Sudani, in New York City on the twentieth of September 2023. During this meeting, His Highness emphasized the imperative of upholding security, independence, and territorial integrity for both nations. He reiterated the importance of honoring agreements and relevant international resolutions, particularly Security Council Resolution No. 833, which outlined the land and sea borders between the two countries up to maritime mark No. 162

"Kuwait expressed its eagerness to finalize the demarcation of the Kuwaiti-

Iraqi maritime borders beyond mark 162 in the days to come, following international laws and conventions.

"Iraq's Prime Minister promptly responded to Kuwait's call, affirming Iraq's unwavering commitment to pertinent international resolutions. He reiterated his government's dedication to Kuwait's sovereignty, territorial integrity, and adherence to international laws and Security Council resolutions.

"Al-Sudani restated this commitment in his statements to The National, an Emirati newspaper, following the New York meeting. He confirmed Iraq's position and desire to sustain the joint committees' efforts, facilitating continuous mutual visits between officials and experts from both countries in various fields to enhance cooperation and foster confidence.

"Al-Sudani acknowledged Kuwait's concerns, particularly related to the 1990 invasion, emphasizing that Iraq has transformed significantly post-2003. Iraq is actively working on cross-border projects and developing relations with all its neighbors, including Kuwait.

"Addressing the Federal Supreme Court's decision to invalidate the Khor Abdullah Agreement, Al-Sudani highlighted a division among Iraq's branches of authority, clarifying that the matter is currently in the judicial domain.

"Iraq's National Security Advisor, Qasim Al-Araji, had previously affirmed Iraq's profound respect for Kuwait's sovereignty across past, present, and future. This affirmation followed his meeting with the Kuwaiti Ambassador to Baghdad, Mr. Fahd Al-Fadhli. Al-Araji emphasized understanding and dialogue as the means to resolve all issues, emphasizing the principle of good neighborliness and the involvement of legal committees. The New York meeting, where the prime ministers of both countries convened, underscored their stance of love and respect towards Kuwait Iraq and its officials acknowledge that the Security Council resolutions under Chapter Seven of the United Nations Charter are unequivocal and not subject to hesitation or manipulation.

"Furthermore, we have profound confidence in the sincere intentions of Baghdad's officials, especially the Prime Minister and his influential aides. We firmly believe that the process of delineating maritime borders will remain unaffected by this decision. What matters most is our ongoing communication with Baghdad's officials on all fronts, not only to resolve outstanding issues but to elevate our relations to a collaborative stage.

"Kuwait is resolute in building a comprehensive trade and investment system within various Iraqi cities, driven by a sense of neighborliness, aligned interests, and a commitment to enhancing communication in the next phase. This ambition stays with us, fully cognizant of the potential for its realization as long as the Iraqi situation continues to be guided by the constitution and the rule of law.

"We place our trust in the Iraqi political consciousness that endured the tragedy of Saddam's disruptive actions in Iraqi affairs, wreaking havoc on Iraq and causing suffering to the Iraqi people, who bore the burdens of his recklessness.

"Perhaps the Iraqi people grasp Kuwait's sensitivity stemming from the invasion and its eagerness for future steps to be secure and free of loopholes through which adventurers could exploit. They understand the necessity of shifting relations between the two countries towards mutual gains in trade and development. I anticipate that this ambition will materialize after the completion of maritime

demarcation, paving the way for both countries to enter a comfortable space characterized by mutual trust, aligned interests, and rational behavior.

"In addition, Kuwait extends its heartfelt condolences for the passing of Sheikh Mubarak Abdullah Al-Ahmad. His demise represents a loss of a reservoir of noble values.

'The late Sheikh Mubarak Abdullah Al-Ahmad was a steadfast champion of truth and justice, consistently employing dignified language and committing to his convictions.

"His presence significantly enriched society, and we remember his esteemed legacy with admiration and respect. We pray for his eternal peace and offer solace to his honorable family during this challenging time.

"Despite his illness, he remained exceptional, displaying resilience in suffering and believing that everyone facing it will eventually find peace in the divine presence of honor and majesty.

Also:

"In short, the country is exhausted by the different kinds of conflicts, particularly the political conflicts between sheikhs and merchants, and among sheikhs, commercial conflicts between large business families, sports-related conflicts, government-parliament conflicts, and inter-parliamentary conflicts. All these conflicts have a major negative impact on the country and its development", columnist Eng. Talal Al-Enezi wrote for Al-Rai daily.

The nature of these conflicts is neither praiseworthy nor positive. Rather, they are fierce, and all permissible and non permissible weapons are used in them. Each party in the conflict has its followers, including MPs, writers, and social media users. Therefore, we find the Kuwaiti arena more like a war zone with everyone waiting for opportunities to exclude their opponents and keep them

"Everyone is trying to harness all the capabilities of the state for himself and his followers. We therefore find unequal opportunities and brash appointments, the result of which is the destruction of the country, its delay and the disruption

"Our ears have become accustomed to hearing the terms "conflicts", "disagreements", "exclusion", "termination", "theft" and "embezzlement". We unfortunately do not hear words such as "a project has been launched", "a development project has been signed", "a large factory has been opened", or "the railways project has been completed".

"Our neighbors and brothers in the Gulf countries are interested in developing their countries and making them qualitatively better. They have succeeded, while we are still immersed in our conflicts and disagreements. We get upset when someone criticizes our situation even if it is done with compassion and love.

"In short, there is no one whose heart is against the country! Political and commercial conflicts and disagreements have exhausted the country, disrupted it, frustrated its people, and made them pessimistic. We do not see any glimmer of hope for reform, development, achievement, and progress of our country"

PAFN and the expiry dates

Kuwait stands out as a unique country globally, mandating manufacturers and importers of food products to specify expiry dates, limited to a maximum of 2 years, regardless of the product's inherent nature.

Interestingly, foods like honey and mustard, known to remain

consumable for centuries according various scientific sources, are also subject to expiry dates. The disposal of canned foods after their expiry, given their prolonged shelf life, rep-



resents an extravagant waste. In a New York Times article on February 24, 2023, American chef and food writer James Kenji López Alt emphasized the importance of being aware of the expiry dates before discarding food items.

According to the US Department of Agriculture (USDA), defining expiry dates for most food products, except those meant for children, is optional and unrelated to food safety. Expiry dates in the US are essentially the producer's best estimate of when the product maintains its optimal quality. Most producers tend to be conservative with these estimates.

Certain food items such as honey, vinegar, vanilla, sugar, salt, corn syrup, molasses, rolled oats, and grits possess an extended shelf life with minimal change in quality and therefore do not require much concern regarding their expiry.

White rice, in contrast to brown rice, can remain viable for years due

to the lower fat content. Unrefined substances like walnuts decay relatively quickly due to their higher fat content, but if stored in the fridge, they can last for a few years. Bread with oils and preservatives might retain its texture for weeks in the fridge, while yeast-based components might degrade within 10 days.

Dried beans and lentils retain their viability for years, although they may harden over time, necessitating longer cooking duration. Spices may lose some flavor but remain viable for extended periods. Canned foods stored in metal

containers have a longer shelf life compared to those in glass or plastic containers. Signs of spoilage, such as swelling, mold, odd smells, or tastes, are absent in canned fruits, vegetables, and meats, allowing them to last for years.

Carbonated beverages maintain their effervescence for a considerable time, with those in glass bottles lasting longer than those in plastic ones. Oils, when stored away from heat, can last for a prolonged duration, and their suitability for consumption can be determined by their smell or taste.

Honey and mustard possess an indefinite shelf life, and ketchup remains viable for approximately one year, even if there's a change in color. Mayonnaise without lemon and garlic can last for a significant period. Soy sauce takes a long time to spoil, but refrigeration is advisable.

Eggs have a lengthy shelf life and can be identified as spoiled by their smell. Only expiry dates on children's food items accurately represent their actual validity. I urge the Public Authority for Food and Nutrition (PAFN) to adopt a flexible approach regarding expiry dates.

Zero tolerance for fake goods

Companies shut as raids pick up steam

KUWAIT CITY, Oct 2: The Ministry of Commerce and Industry (MoCI) in its relentless work is determined to clean the markets of adulterated products, reports Al-Rai daily.

The daily added after restricting the markets for food, spoiled meat, and counterfeit goods of various kinds, the scope of work of commercial control inspectors has increased.

Informed sources told the daily the inspectors recently shut down two companies and their stores selling tobacco (molasses), one in Salmiya and the other in Al-Ardhiya, after they were caught tampering with the expiry dates of the molasses prepared before putting the products for sale, indicating that the two companies will be referred to the prosecution.

Fraud

The sources indicated that the commercial fraud included all different types, flavors, and trade names of molasses, two tons of seized products had all expired in since 2021 and 2022.

The sources pointed out that "according to the field inspectors the violators had concealed the expiry date on the original boxes of the seized molasses containers, and tampered with it by extending other valid consumption dates, and then sold it to customers directly or to cafés."

The sources explained that "the seized quantities and the method of manipulation reflected a clear case of tampering carried out by officials in the warehouses, in violation of the law and regulatory instructions regulating consumer protection and health.'

The sources stated, that "there are clear directives from the Minister of Commerce, Muhammad Al-Aiban, and Undersecretary Ziyad Al-Najem to all inspection teams in the ministry to increase inspection tours and restrict violators to the maximum possible degree," noting that "the directives in this regard include working to intensify campaigns and expand their scope to include all consumer markets without focusing on one market at the expense of another.'

'All Kuwaitis in Public Prosecution'

Fire Dept shuts down 57 facilities

KUWAIT CITY, Oct 2: The Public Relations and Media Department of the Directorate-General of Fire Department (DGFD) has shut down 57 facilities and during administratively September, reports Al-Rai daily.

The Farwaniya Governorate topped the list of violators, followed by the Capital Governorate.

The statistics indicated the Farwaniya Governorate accounted for 105 violations, followed by Hawalli with 87. The statistics also showed that the prevention sector issued 207 licenses for facilities, and 191 approvals for architectural studies for projects, while 2,193 units were licensed, and 824 approvals for vouchers were issued during the past month.

Kuwaitizing Prosecution: The Public Prosecutor, Counselor Saad Al-Safran. issued a decision yesterday to completely "Kuwaitize" the Public Prosecution office, and transfer non-Kuwaitis to the full Prosecution, as of yesterday, reports Al-Seyassah daily. Resolution No. 77 of 2023 stipulated the

transfer of all non-Kuwaiti heads and members of the Public Prosecution from all partial and specialized prosecutions to the full prosecution, as of Sunday.

The Public Prosecution said in a statement on its account on the 'X' platform, that the decision comes within the framework of the Public Prosecution's efforts to rely on national cadres in forming partial and specialized prosecutions.

Kuwaiti child dead, 3 others 'injured' in fire

KUWAIT CITY, Oct 2: Sabah Al-Salem area woke up at dawn yesterday to a house fire that resulted in the death of a six-year-old Kuwaiti child and the suffocation of two of his siblings and a woman who were taken to

According to a security source, when the Operations room of the Ministry of Interior received information about a house on fire, security officers and firefighters from two fire stations were immediately dispatched to the location. They rescued four people from the house, and referred them to paramedics at the site who referred them to the nearest hospital.

The Public Relations and Media Department of the Kuwait Fire Service Directorate explained that the fire had broken out in a house in Sabah Al-Salem area, and firefighters from Al-Qurain and Mishref fire stations rushed to the location to realize the fire broke out in an apartment on the first floor of the house. The teams immediately worked on extinguishing the fire. Four people suffered from suffocation and were transported to the hospital, but one of them - a six-year old child - had died.

Investigations have been launched in this regard.

Minor girl guardianship annulled

Verdict upheld in inheritance case

Appeals upheld the verdict issued by the Court of First Instance,

which rejected the lawsuit filed by the Minors' Affairs Authority as the guardian of a minor girl, and demanded the invalidation of a house ownership document and a "gift contract" from the Kuwaiti citizen to his children and



The facts of the case were presented by the Director General of the Public Authority for Minors' Affairs, in his capacity as the guardian of the deceased citizen's minor daughter, demanding the invalidation of the home ownership document and the "gift contract" from the deceased man to his children and wife, for violating public order, circumventing the rules of legal inheritance, and considering the contract as if it did not exist, by removing him from the Real Estate Registration and Authentication Department.

During the court session, lawyer Jassim Al-Tuwaitan, representing the family members of the deceased, said the father of his clients gave the property to them when he was alive 17 years ago. He also had a minor daughter under the guardianship of the Minors' Affairs Authority. During his lifetime, he did not return or amend the gift, which confirms the effectiveness of the gift

in favor of his clients. Lawyer Al-Tuwaitan demanded that the ruling of the Court of First Instance to reject the case be upheld.

Govt spends only 10 pc of KD1.02 bln on development projects, shows data

Total number of projects in annual dev plan reaches 130

KUWAIT CITY, Oct 2: Despite giving priority to spending on development projects, and granting them facilities that would contribute to the speed of their completion, official figures revealed that the total amounts spent on development projects during the first half of the current fiscal 2023/2024 is only 108 million dinars of the 1.02 billion dinars -- only about 10 percent, reports Al-Qabas daily.

According to the same data, the total number of projects in the annual development plan reached 130, of which 13 projects have not been started yet, while there are about 52 projects in the preparation stage, 60 projects in the implementation stage, while there are five projects in the delivery stage.

Relevant sources indicated that the low rate of disbursement and completion of projects raises fears of a repeat of last year's failure, in which only 10 projects were completed, and the rate of disbursement did not exceed 50 percent, knowing that it is the lowest rate historically since the launch of the development plan projects in 2010. /2011.

The lawmaker revealed that there are many other dangerous effects of communications towers, even those installed in open

He explained that diesel is used to run these towers, and they sometimes leak into the soil, causing pollution to the underground water. According to the Environment Public Authority, 140 out of 164 towers are found to be violating environmental requirements.

The issue also has a security aspect as eight towers were discovered to not belong to any of the three telecommunication companies. This arouses suspicions about the reasons behind installing them, which were done so by unknown individuals or bodies for unknown purposes.

London, for example, is completely free of communications towers as part of the efforts to protect citizens' health.

Al-Matar concluded by revealing that another meeting will be held to hear from the relevant institutions including Ministry of Health, Kuwait Municipality, CITRA and Environment Public Authority.

Furthermore, MP Hamdan Al-Azmi submitted parliamentary questions to the Minister of Commerce and Industry and the State Minister for Youth Affairs Muhammad Al-Aiban, asking if the ministry has issued any regulations to standardize the delivery charge collected by delivery platforms and applications. If so, he wanted to be provided with a copy of those regulations. If not, he wanted to know the reasons.

Al-Azmi asked if there is a defined maximum charge for delivery, and if the delivery platforms and applications are covered by the regulations that organize the delivery of orders from restaurants and coffee shops at a rate of 250 fils for delivery within the same area and 500 fils for the delivery outside the

He asked for the plan of the ministry to enhance Islamic education to the residents of Abdullah Al-Mubarak area.

Meanwhile, the National Assembly Speaker Ahmad Al-Saadoun sent a cable to the Speaker of the House of Representatives of Nigeria Tajuddin Abbas and the President of the Senate of Nigeria Godswill Akpabio to congratulate them on the National Day of Nigeria.

In another development, MP Fayez Al-Jomhour submitted a bill to amend the second clause of article 33 of the Municipality law No. 33/2016.

The bill is aimed to exempt the joint ownership houses located in Jleeb Al-Shuyoukh from the regulation of the first clause of article 33 of the above mentioned law, which prevents Kuwait Municipality from issuing description certificate or survey letters to the owners of violating houses with joint ownership.

lating houses with joint ownership.

He said the bill will allow the owners of the houses located in Jleeb Al-Shuyoukh to obtain the description certificates and survey letters needed to sell their houses, as part of the procedures aimed at developing Jleeb Al-Shuyoukh.

The lawmaker stressed that, in case the government does not approve the bill, the State Minister for Municipal Affairs will bear political responsibility for disturbing the citizens' interest.

In addition, MP Hamad Al-Medlej highlighted that the cooperation of the parliament with the government is linked to the achievement of popular legislation, especially those concerning citizens' interest.

He urged the government, particularly the Minister of Finance Fahad Al-Jarallah, to show cooperation for improving the citizens' standard of living by ratifying the relevant bills related to reforming salaries' scale and increasing pension.

and increasing pension.

MP Al-Medlej warned against the issuance of negative reports whenever the MPs call for enhancing the citizens' income.

He stressed the fact that KD 2.5 billion was scheduled to be referred to the Public Institution for Social Security for investment purposes.

MP Al-Medlej asked Minister Al-Jarallah to verify the information that the witnesses against the former chairman of the institution Fahad Al-Rajaan, who was convicted of stealing huge amounts of the institution's funds, have been rejected and exposed to abusive procedures.

The lawmaker asked if the Public Institution for Social Security addressed the Public Prosecution to change the description of the lawsuit against Al-Rajaan, and if the institution delayed in responding to the requests of Public Prosecution for reports on Al-Rajaan's case.

He also asked for verification about the violations recorded by the State Audit Bureau concerning the conflict of interest through the dismissal of the Legal Affairs Director of the Public Institution for Social Security and his replacement with a relative of Al-Rajaan.

Political strain

European FMs meet in Kyiv to support Ukraine

KYIV, Ukraine, Oct 2, (AP): Some of Europe's top diplomats gathered Monday in Kyiv in a display of support for Ukraine's fight against Russia's invasion as signs emerge of political strain in Europe and the United States about the 19-month-old war.

European Union foreign ministers converged on the Ukrainian capital for an unannounced informal meeting that officials said would review the bloc's support for Ukraine and discuss Ukrainian President Volodymyr Zelenskyy's proposed peace formula.

EU foreign policy chief Josep Borrell said the foreign ministers' first joint meeting outside EU borders signaled that the 27-nation bloc's support is "unwavering" and underscored the EU's commitment to



The United States, the EU and the United Kingdom have provided massive military and financial support to Ukraine, enabling it to stand up to the Kremlin's attack. The assistance is crucial for Ukraine's weakened economy and has so far been open-ended.

But uncertainty has set in over how long Kyiv's allies will keep sending it aid worth billions of dollars (euros).

US President Joe Biden on

Sunday reassured allies of continued US financial support for the war effort, after Congress averted a government shutdown by adopting a short-term funding package that dropped assistance for Ukraine in its battle against Russia.

Ensure

Ukrainian Foreign Minister Dmytro Kuleba told reporters that Ukraine held discussions with representatives of both parties in the US Congress to ensure more help will arrive. "The decision was taken as it was, but we are now

working with both sides of the Congress to make sure that it does not repeat again under any circumstances,' Kuleba said.

"The question is whether what happens in the US Congress last weekend is an incident or a system. I think it was an incident," he added.

The EU meeting in Kyiv took place after the weekend election victory in EU member Slovakia of Robert Fico, whose pro-Russian agenda has increased the question marks about the EU's continued support for Kyiv

The small eastern European country could bring more tension to the EU's discussions on Ukraine, as has happened with Hungary's at-times cool attitude toward Kyiv. Budapest has maintained close relations with Moscow and argued against supplying arms to Ukraine or providing it with economic assistance. Slovakia operates a key rail line used to transport western military hardware to Ukraine

The foreign ministers of Hungary and Poland were not at the Kyiv gathering. However, it is not unusual for diplomats to skip such informal meetings.

Danish Foreign Minister Lars Løkke Rasmussen said Europe must be ready to provide further help "for many good reasons.

"First of all, in order to support Ukraine, but also to send a strong trans-Atlantic signal that what's going on on our own soil is something we have to take on a reat responsibility for," Løkke Rasmussen said

Ukraine is bent on becoming a member of the EU, and EU officials have encouraged that course even though it could take years amid a war of attrition with no end in sight.

"With every village, with every meter that Ukraine liberates, with every meter in which it rescues its people, it is also paving its way to the European Union," German Foreign Minister Annalena Baerbock told reporters in Kyiv.

Deliver

Luxembourg Foreign Minister Jean Asselborn said Western allies must keep up the military aid "because if we don't deliver any weapons from the EU, from NATO, from other countries, then this war is over but with the wrong consequences."

Meanwhile, Britain's new defense secretary has suggested that British military training of Ukrainian soldiers, which currently takes place at UK bases, could move into western Ukraine.

In an interview with the Sunday Telegraph, Grant Shapps said he was in discussions with the British army about "eventually getting the training brought closer and actually into Ukraine as well.'

Prime Minister Rishi Sunak was quick to rule out speculation of an imminent deployment of British soldiers to Ukraine. Shapps' suggestion was not for the "here and now," Sunak told reporters, but a possibility "for the long term."

"There are no British soldiers that will be sent to fight in the current conflict. That's not what's happening," Sunak said.

Russian politicians immediately criticized the proposal. Former President Dmitry Medvedev, who is deputy secretary of Russia's Security Council, claimed Shapps was actively pushing "towards a Third World War."

The British minister "will be turning his instructors into a legal target for our armed forces, knowing perfectly well that they'll be mercilessly destroyed - not as mercenaries, but as NATO specialists," Medvedev wrote on social media.

Since Russian President Vladimir Putin sent troops into Ukraine more than 19 months ago, Medvedev, a law school graduate, has emerged as one of the most hawkish Russian officials, regularly issuing blustery remarks that combine Latin mottos and legal expressions with four-letter words.

Observers have interpreted Medvedev's rhetoric, which sounds tougher than the statements of even old-time Kremlin hardliners, as an apparent attempt to

curry favor with Putin. Yan Gagin, advisor to the head of the Russian-occupied part of eastern Ukraine's Donetsk region, also dismissed Shapps' idea but without Medvedev's fiery warnings. "Even if British instructors do organize training for Ukraine's armed forces inside Ukraine, it won't bring any results," Gagin told Russian state news agency RIA Novosti.

"Ukraine's failed counter-offensive has already shown the level of such training," he added.

More than 23,500 recruits from Ukraine have received combat training at army bases across the UK since the start of 2022, receiving instruction on skills that include weapons handling and battlefield first aid. Earlier this year, Britain's government committed to training another 20,000 recruits. The training is part of a broader package of support for Ukraine that includes a pledge of 2.3 billion pounds (\$2.8 billion) of anti-tank weapons, rocket systems and other hardware this year.

Sánchez's party finished second behind the Popular Party in July 23 elections. The elections produced a splintered parliament made up of 350 legislators from 11 parties, making the path to power difficult for any party.

If no government is in place by Nov. 27, another national election will be held

Feijóo's bid was rejected by a vote 177-172 on Friday. Sánchez, whose party holds 122 seats, hopes he can now persuade the legislators that voted against Feijóo to back him and capture at least the required 176 votes for a majority. (AP)

The Council of Europe's Group of States against Corruption (GRECO) said in a report that Cypriot laws appear strong on paper but are undercut by institutional flaws including numerous anti-corruption bodies that lack coordination, resources and authority.

According to GRECO, Cyprus needs a stronger system of accountability in gov-ernment to prevent influence-peddling and to stymie the risk of politicians serving the interests of big business and the

Efforts to combat this relationship between government and private interests are "narrow in scope," it said, adding that more transparency is needed regarding politicians' assets and that people need better access to information. (AP)

No troop buildup near Kosovo: Serbia's president on Sunday denied US and other reports of a military buildup along the border with Kosovo, complain ing of a "campaign of lies" against his country in the wake of a shootout a week earlier that killed four people and fueled tensions in the volatile Balkan region.

Biden urges Congress to approve Ukraine aid

WASHINGTON, Oct 2, (AP): US President Joe Biden said Sunday that American aid to Ukraine will keep flowing for now as he sought to reassure allies of continued US financial support for the war effort. But time is running out, the president said in a warning to Congress.

"We cannot under any circumstances allow America's support for Ukraine to be interrupted," Biden said in remarks from the Roosevelt Room after Congress averted a government shutdown by passing a short-term funding package late Saturday that dropped assistance for Ukraine in the battle against Russia.

"We have time, not much time, and there's an overwhelming sense of urgency," he said, noting that the funding bill lasts only until mid-November. Biden urged Congress to negotiate an aid package as soon as possible.

The vast majority of both parties - Democrats and Republicans, Senate and House - support helping Ukraine and the brutal aggression that is being thrust upon them by Russia," Biden said. "Stop playing games, get this

Momentum

But many lawmakers acknowledge that winning approval for Ukraine assistance in Congress is growing more difficult as the war grinds on. Republican resistance to the aid has been gaining momentum and the next steps are ahead, given the resistance from the hard-right flank.

While Senate Majority Leader Chuck Schumer, D-NY, has begun a process to potentially consider legislation providing additional Ukraine aid, House Speaker Kevin McCarthy, R-Calif., faces a more difficult task in keeping the commitment he made over the objections of nearly

half of his GOP majority.
He told CBS' "Face on the Nation" that he supported "being able to make sure Ukraine has the weapons that they need," but that his priority was security

at the U.S.-Mexico border. "I firmly support the border first," he said. "So we've got to find a way that we can do this together.'

By omitting additional Ukraine aid from the measure to keep the government running, McCarthy closed the door on a Senate package that would have funneled \$6 billion to Ukraine, roughly one-third of what has been requested by the White House. Both the House and Senate overwhelmingly approved the stopgap measure, with members of both parties abandoning the increased aid in favor of avoiding a costly government shutdown.

Now Biden is working to reassure US allies that more money will be there for Ukraine.

Trump attends New York trial 'scrutinizing' his biz practices

NEW YORK, Oct 2, (AP): With control over some of his most prized real estate holdings in jeopardy, former president Donald Trump says he will make a rare, voluntary trip to court in New York on Monday for the start of a civil trial in a lawsuit that already has resulted in a judge ruling that he committed fraud in his business dealings.

Trump lashed out in his po New York Attorney General Letitia James, who is suing him, and Judge Arthur Engoron, who is presiding over the non-jury trial and

made the fraud ruling last week. "This whole case is a sham!!!" Trump wrote. "See you in Court -Monday morning."

The trial is the culmination of a yearslong investigation by James, who accused Trump and his company of habitually lying about his

wealth in financial statements. Last week, Engoron resolved the lawsuit's top claim before the trial even began, ruling that Trump routinely deceived banks, insurers and others by exaggerating the value of assets on paperwork used in mak-

ing deals and securing loans. The former president and a who's who of people in his orbit his two eldest sons, Trump Organization executives and former lawver-turned-foe Michael Cohen are all listed among dozens of potential witnesses.

Trump isn't expected to testify for several weeks. His trip to court Monday will mark a remarkable departure from his past practice.

Trump didn't come to court as either a witness or a spectator when his company and one of its top executives was convicted of tax fraud last year. He didn't show, either, for a trial earlier this year in which a jury found him liable saulting the writer E. Jean Carroll in a department store dressing room. In some ways, though, this new

trial comes with higher stakes. James, a Democrat, is seeking \$250 million in penalties and a ban on doing business in New York.

Engoron's ruling of last week, if upheld on appeal, would also shift control of some of his companies to a court-appointed receiver and could force him to give up prized New York properties such as Trump Tower, a Wall Street office building, golf courses and a suburban estate.

Trump called it a "a corporate death penalty.'

"I have a Deranged, Trump Hating Judge, who railroded this fake case through a NYS Court at a speed never before seen," Trump wrote on his Truth Social platform

10 migrants die in truck crash: At least 10 migrants have died and about 15 other people were injured when a freight truck they were riding in crashed on a highway in southern Mexico near the border with Guatemala.

It was the latest in a series of migrants deaths in Mexico amid a surge in migrants traveling toward the U.S. border.

The civil defense office of the state of Chiapas said the truck

crash happened Sunday on a highway near the town of Pijijiapan, about 110 miles (175 kilometers) from the Guatemalan

The office posted photos showing a small truck with an open cargo box tipped on its side, and victims thrown onto the side of the highway

The office did not confirm the nationalities of the victims, but an employee of the state prosecutor's office said they were largely Cuban migrants who had been hitching rides on passing vehicles. The employee was not authorized to speak on the

It was also not clear how many of the 15 injured were migrants. There was no immediate information on their condition. or nationalities. Mexican authorities generally prohibit migrants without

proper documents from riding buses, so those without the money to hire smugglers often walk along the side of highways, hitching rides aboard passing trucks. There have been a number of migrant deaths over the last

A migrant from Ecuador died and 10 others from Colombia

and Guatemala were injured in an crash Saturday that occurred while they were being taken for processing in a van operated by Mexico's immigration agency.

Mexico's National Migration Institute said the van was involved in a collision with a bus in the the city of Mexicali, across the border from Calexico, California.

Police scuffle with justices: Policemen shoved and wrestled with justices of Guatemala's top electoral tribunal Saturday, as prosecutors sought to seize the tally sheets of votes from the August presidential elections. There were harrowing scenes of justices holding tight to

boxes, as police tried to wrestle them away as part of raids to investigate spurious claims of voting fraud. Observers at the time said they saw no evidence of any such

fraud, and most in Guatemala see it as an attempt to weaken or disqualify the winning candidate, Bernardo Arévalo.

Seventy-year-old Justice Maynor Franco, wearing a suit and tie, refused to give up his grip on a vote box, even as a much younger agent tried to wrestle it away. Justice Blanca Alfaro pleaded with officers not to take the

boxes, because they represented the will of voters. She was shoved and briefly fell to the floor during the fracas. Saturday's events came during the latest round of raids by Attorney General Consuelo Porras and prosecutor Rafael Cur-

ruchiche, efforts that international groups have said are aimed at overturning or tarnishing the electoral results. Porras took over as attorney general in 2018 and in 2021 was sanctioned by the U.S. government for being an undemocratic actor and undermining investigations into corruption. She has

'31 transits per day': The Panama Canal announced Saturday it will reduce the maximum number of ships travelling the waterway to 31 per day, from 32 in August, due to a drought that has reduced the supply of fresh water needed to operate the locks.

That compares to daily averages of 36 to 38 ships per day under normal operation.

Nine ships per day will be allowed to use the new, bigger NeoPanamax locks and 22 per day will be handled through the older Panamax locks. The Canal Authority guaranteed a draft of 44 feet for ships,

in part because 70% of ships using the waterway need at least that depth. In August, the canal implemented a measure capping the number of ships passing through its locks daily to a maximum

Nigeria leader ups wages: Nigeria's leader increased the wages of some government workers in last-minute efforts to appease labor unions whose planned strike this week could shut down government offices in all sectors of Africa's largest economy.

Chiwenga

Low-grade workers will in the next six months be paid an additional 25,000 naira (\$32) a month, President Bola Tinubu said Sunday in a nationwide broadcast to mark Nigeria's 63rd independence anniversary.

The increase expected to take effect this month takes the minimum wage to 55,000 naira (\$71), still far below the 200,000 naira (\$258) the unions had requested. The labor unions did not immediately comment on Tinubu's announcement.

The unions representing Nigeria's government workers announced they will go on an indefinite strike starting Tuesday to protest the government's austerity meas-

In office since May 29, Tinubu's policies aimed at fixing Nigeria's ailing economy have more than doubled the cost of living for more than 210 million people who already were grappling with a surging inflation. It hit an 18-year high of 25.8% in August.

After he ended the yearslong expensive subsidies for gas on his first day in office, the price of petrol more than doubled, resulting in a similar hike in the price of other commodities. (AP)

Algeria expands English classes:

More than a year after Algeria launched a pilot program to teach English in elementary schools, the country is hailing it as a success and expanding it in a move that reflects a widening linguistic shift underway in former French colonies throughout

Students returning to third and fourth grade classrooms this fall will participate in two 45-minute English classes each week as the country creates new teacher training programs at universities and eyes more transformational changes in the years ahead. Additionally, the country is strengthening enforcement of a preexisting law against private schools who operate primarily in French.

Teaching English is a strategic choice in the country's new education policy, Education Minister Abdelkrim Belabed said last week, lauding the move as an immense success.

English is the world's most widely spoken language, accounts for the majority of content on the internet and remains a lingua franca in business and science. And as France's economic and political influence wanes throughout Africa, Algeria is among a longer list of countries gradually

'Army will stop flying European-designed Taipan copters'

Early voting begins in NZ's general poll

WELLINGTON, New Zealand, Oct 2 (AP): Early voting began on Monday in New Zealand for the nation's Oct 14 general election, with conservative contender Christopher Luxon casting his ballot.

Early voting also began in some parts of Australia in a referendum that would enshrine in Australia's constitution a mechanism for Indigenous people to advise Parliament on policies that affect their lives.

In New Zealand, the campaign of Prime Minister Chris Hipkins faced a setback on Sunday when he tested positive for COVID-19. He said he would isolate for five days or until he returned a negative test, but planned to continue with some engagements over Zoom.

Hipkins and his liberal Labour Party have been lagging behind the opposition National Party, led by Christopher Luxon, in opinion polls..

"After a rough night I woke up this morning feeling pretty unwell and just got this test result," Hipkins work twice as hard when he got back out on the campaign trail.

Rebuild

Luxon on Sunday released a 100day action plan he said would deliver tax relief, rebuild the economy and restore law and order. "New Zealanders have waited six long years for a government that focuses on what matters to them, and gets things done," Luxon said.

In Australia, where voting is compulsory, some 98% of eligible Australians have signed up to vote in the referendum on the Indigenous Voice to Parliament.

Early voting began in four states or territories Monday, and the remaining four will vote on Tuesday after observing a public holiday Monday.

The "Yes" campaign is lagging behind in opinion polls but Prime Minister Anthony Albanese, who supports the potential change, said he

remains hopeful. "I know a lot of people have not made up their mind, and what I know is that the feedback, when people talk through these issues, they arrive at a 'Yes' vote pretty comfortably," Albanese told reporters in Melbourne. "I sincerely think the key to the next fortnight is those one-on-one conversations with people to accept this request of the overwhelming majority of Aboriginal and Torres Strait Islander peoples."

Political opponents say the referendum effort should have been bipartisan and that many unanswered questions remain on the details of how the Voice would work in practice.

It's a coincidence the elections are taking place on the same day.

CANBERRA, Australia: The Australian army will never again fly its fleet of MRH-90 Taipan helicopters following a crash in July that killed four soldiers, the defense minister said Friday.

Australia's fleet of more than 40 European-designed Taipans has been grounded since July 28 when one crashed into the Pacific Ocean during a nighttime training operation in the Whitsunday Islands off the northeast Australian coast.

Defence Ministe les told Nine Network television that permanently ending Taipan flying operations was the "only decision that makes sense."

"We're making this decision today. In many ways it was inevitable, but it's an important step to take so that we can get our Black Hawks in the air as quickly as possible," Marles said, referring to the U.S.-built helicopters that will replace Australia's Airbusmanufactured fleet.

The government announced plans in January to replace the Taipans with 40 UH-60M Black Hawks. The Taipans' retirement date of December 2024 would have been 13 years earlier than Australia had initially planned.

The government made the decision now to stop flying the Taipans because one of the four investigations into the crash will take another 12 months, Marles said. After the cause of the crash is explained and any faults in the Taipan fleet are rectified, that would have left only a few weeks for them to fly before they were retired, he said.

Since the January announcement, the Taipan fleet was grounded in March after a helicopter ditched off the southeast Australian coast during

a nighttime counterterrorism training exercise.

JAYAPURA, Indonesia: Five Papuan independence fighters were killed in a clash between security forces and a rebel group in Indonesia's restive Papua region, police and rebels said Monday.

A joint military and police force killed the five fighters from the West Papua Liberation Army, the armed wing of the Free Papua Movement, in a battle on Saturday with dozens of rebels armed with military-grade weapons and arrows in the hilly Serambakon village in Papua Highland province, said Faizal Ramadhani, a national police member who heads the joint security force.

Security forces seized two assault rifles, a pistol, several arrows, two mobile phones, cash, more than 300 rounds of ammunition and a "morning star" flag - a separatist symbol after the clash, Ramadhani said.

Clashes between the two sides gan in mid-April when attackers from the liberation army ambushed dozens of government soldiers in Nduga district and killed at least six Indonesian troops who were searching for Phillip Mark Mehrtens, a New Zealand pilot who was abducted by the rebels in February.

Rebels in Papua have been fighting a low-level insurgency since the early 1960s, when Indonesia annexed the region, a former Dutch colony.

Papua was incorporated into Indonesia in 1969 after a UN-sponsored ballot that was widely seen as a sham. Since then, the insurgency has simmered in the region, which was divided into five provinces last year to boost development in Indonesia's poorest region.

Sebby Sambom, a spokesman for the liberation army, confirmed the police claim but said that losing five fighters "would not make us surren-

"They were the national heroes of the Papuan people," Sambom said in a statement provided to The Associated Press on Monday. "They died in defending the Papuan people from extinction due to the crimes of the Indonesian military and police who are acting as terrorists.'

Tesla Q3 sales rise 27% but fall short of expectations

Tesla's summertime deliveries of electric vehicles surged 27% from last year but still fell below analyst projections as Elon Musk's car company navigated through softening customer demand as well as factory upgrades.

The Austin, Texas, automaker sold 435,059 vehicle s during the July-to-September period, up from 343,830 at the same time last year. Analysts had predicted Tesla would sell about 461,000 vehicles during the latest quarter, according to FactSet Research.

As usual, Tesla's sales consisted primarily of its Model 3 and Model Y vehicles, which have been made even more attractive by rounds of price cut-

ting that have eaten into the company's profit margins. The third-quarter sales also marked a step back from Tesla's 466.140 vehicle deliveries during the April-to-June period. The company blamed the sequential sales de-

cline on planned downtime to upgrade its factories. Tesla said it made 430,488 vehicles in the latest quarter, slightly below the number it delivered.

The company will need a big finish to 2023 to realize CEO Musk's stated goal of increasing its sales by 50% annually. To hit that target, Tesla will have to sell 1.97 million vehicles this year. Through the first nine months of the year, Tesla has delivered just over 1.3 million vehicles. Analysts are anticipating Tesla will sell 1.84 million vehicles for the full year.

Tesla has been slashing prices most of this year to keep attracting buyers who now have a wider selection of electric vehicles as more automakers shift away from gasoline-powered cars and trucks. The discounts range from \$4,400 on Tesla's topselling vehicles to as much as \$20,000 on its most expensive models.

Just how much the latest round of cost cutting has trimmed Tesla's profit margins will be detailed Oct. 18 when it plans to release its third-quarter earnings. (AP)

Kuwait plans to spend \$22.4 bn on oil and gas projects, ranks 5th among GCC states

Kuwait's share about 7%

KUWAIT CITY, Oct 2: The "Oil and Gas Report in the spending, amounting to \$84.4 billion. Middle East and North Africa - MENA 2023-2024" revealed that the planned spending in the Gulf countries on oil, gas and petrochemical projects is about \$325 billion, while Kuwait's share is about 7% of the total spending, at 22.4 billion dollars, reports Al-Anba daily.

The UAE topped the volume of future spending on oil and gas in the Gulf, accounting for about 29% of spending, amounting to \$93.9 billion, and Saudi Arabia came in second place, accounting for about 26% of

Oman ranked third with a volume of planned spending on oil and gas projects amounting to about \$79 billion, representing 24.3% of the total future spending on projects in the region, while Qatar ranked fourth with about \$40.1 billion, representing 12.34% of the total spending. Bahrain ranked sixth with \$5.1 billion.

The report pointed out that the oil, gas and petrochemical sectors combined constitute the second largest sectors historically in the Gulf Cooperation Council countries, as contracts worth more than \$280 billion were awarded during the past decade, while reviewing the size of active oil, gas and petrochemical projects in the region, specifically 14 countries, which reached a size of Its projects amount to 868.7 billion dollars, with the six Gulf states alone receiving about half the value

of those projects, amounting to 415.5

billion dollars. Saudi Arabia topped the volume of active projects in the Gulf region with about \$176 billion, constituting in total more than 42% of the projects in the Gulf. The UAE came in second place with about \$82.9 billion in the volume of active projects, and Qatar came in third place in the Gulf with about \$79.6 billion. Oman ranked fourth with \$38.4 billion, Kuwait ranked fifth with \$22.3 billion, and Bahrain came

in sixth place with \$16.3 billion. At the regional level, Iran ranked second after Saudi Arabia with a project volume of \$141.9 billion, followed by Iraq with \$137.9 billion, and Egypt

fourth with \$87.6 billion. MEED stated that in light of the world abandoning its centuries-old dependence on fossil fuels, and since oil producers in the region are concerned with this matter as a result of the importance that hydrocarbon revenues pose to their economies, the global shift towards clean energy represents a fundamental change in their business model. Therefore, as their customers' tenden-

cies change, they must also change. In response to these developments, the leading national oil companies in the region are taking the initiative to implement new policies and investments that enable them to maintain their position at the forefront of the global energy sector. The policy fo-cuses on diversifying investments in new technologies and types of fuel, on preserving hydrocarbon reserves, and on reducing greenhouse gas emissions through clean technology and reduced consumption.

At the same time, oil companies in the region are turning away from their traditional customers in the West towards new markets in China, India and Southeast Asia, which will bring new customers, suppliers and financiers to the region's oil and gas sector.

But even as such deep-rooted changes occur, the region's oil and gas producers know that hydrocarbons will remain the world's largest energy source for decades to come, even after oil demand growth begins to slow, and they know that low production costs give them a significant advantage. As a result, they are investing heavily to expand their production capacity, whether in the exploration and production sector or refining, distribution, storage and transportation.

Ex-crypto king to face former lieutenants

Bankman-Fried must now prove to a jury that he was not a crook

NEW YORK, Oct 2, (AP): For a while, Sam Bankman-Fried tried to convince politicians and the public that he was the next J.P. Morgan. Now, he has to convince a jury that he wasn't, in reality, the next Bernie Madoff.

The trial of Bankman-Fried, the founder of the failed cryptocurrency brokerage FTX, will begin Tuesday with jury selection. Prosecutors from the Southern District of New York are expected to lay out a case against Bankman-Fried that shows he stole billions of dollars in FTX customer deposits and used the money to fund his hedge fund, buy real estate, and

make millions of dollars of illegal campaign donations Democrats and Republicans in an attempt to buy influence over cryptocurrency regulation in Wash-

ington.

Bankman-Fried the While case will involve the complicated world of cryptocurrencies, prosecutors are expected to try to boil it down to the simplest of terms for jurors: Bankman-Fried took money from customers and used it in ways he wasn't supposed to.

"Prosecutors are going to say, 'look at where the money went and how it was spent," said Michael Zweiback, co-founder of the law firm Zweiback, Fiset, & Zalduendo LLP, and a former federal prosecutor. "This case is less about the complicated investments and all about garden-variety fraud."

Before FTX collapsed and filed for bankruptcy last November, Bankman-Fried was one of the most powerful people in the cryptocurrency industry. 'SBF" had an estimated net worth of \$32 billion last year, at least on paper. He interacted with former presidents, politicians on both sides of the aisle, celebrities, and CEOs. When smaller crypto firms started imploding in early 2022, Bankman-Fried told the public he would help prop up the market, prompting the comparisons with J.P.

The 31-year-old Bankman-Fried founded FTX in 2019, and it grew rapidly. The son of Stanford University professors, who was known to play the video game "League of Legends" during meetings, Bankman-Fried attracted investments from the highest echelons of Silicon Valley. FTX quickly became the second-largest crypto brokerage behind Binance.

Bankman-Fried and his inner circle of executives ran their then-growing crypto empire from The Bahamas, out of the luxury apartment complex Albany, where celebrities like Tiger Woods and Justin Timberlake have vacation homes.

FTX had effectively two lines of business: a brokerage where customers could deposit, buy, and sell cryptocurrency assets on the FTX platform, and an affiliated hedge fund known as Alameda Research, which took highly speculative positions in various cryptocurrency investments. As Alameda started to pile up losses during last year's cryptocurrency market declines, prosecutors allege Bankman-Fried directed funds to be moved from FTX's customer accounts to Alameda to plug holes in the hedge fund's balance sheet.

The house of cards that Bankman and his lieutenants built came crashing down in early November, when reports surfaced about the condition of Alameda's balance sheet. Spooked investors, who had already seen several crypto firms collapse during the year, quickly pulled their money out of FTX and within days the firm was bankrupt.

John Ray III, the restructuring expert who was tasked with cleaning up FTX in bankruptcy, described the conditions inside of FTX as worse than Enron, long considered the benchmark for corporate malfeasance

in popular culture. Bankman-Fried is expected come face-to-face with his former lieutenants at FTX for the first time since its collapse. Several of them have agreed to plead guilty to lesser crimes in exchange for testifying against him. This includes Caroline Ellison, who was the CEO of Alameda and Bankman-Fried's off-and-on girlfriend, as

well as FTX co-founder Gary Wang. Ryan Salame, another top executive at FTX, pleaded guilty on Sept. 7 to making illegal campaign contributions to Republicans on behalf of Bankman-Fried, who was publicly making contributions to Democrats. It is not known whether Salame will testify against Bankman-Fried.

Most of Wall St slips as bond market 'cranks up' pressure

NEW YORK, Oct 2, (AP): Most U.S. stocks are drifting lower Monday as the constrictor of higher interest rates tightens its coils around Wall Street.

The S&P 500 was 0.4% lower in midday trading, coming off its worst month of the year. The Dow Jones Industrial Average was down 193 points, or 0.6%, as of noon Eastern time, and the Nasdaq composite was 0.3% high-

Slumps for oil-and-gas stocks weighed on the market after crude prices gave back some of their sharp gains since the summer. The majority of stocks fell alongside them, with 80% of S&P 500 stocks dropping, but gains for Apple and some other influential Big Tech stocks helped limit the market's losses

Stocks have broadly given back about 40% of their strong gains for the year since the end of July. The main reason is Wall Street's growing acceptance that high interest rates are here to stay a while as the Federal Reserve tries to knock high inflation lower. That in turn has pushed Treasury yields to their highest levels in more than a decade, which makes investors less willing to pay high prices for stocks and other investments

The yield on the 10-year Treasury climbed again Monday, up to 4.69% from 4.58% late Friday, and is near its highest level since 2007. High yields send investors toward bonds that are paying much more than in the past, which pulls dollars away from stocks and undercuts their prices. Stocks that pay high dividends with

relatively steady businesses see particular pain because their investors are more likely to switch between stocks and bonds. That puts a harsh spotlight on utility companies. PG&E dropped 5.7%, and Dominion Energy sank 5.3% for some of the sharpest losses in the

High interest rates also make bor-

rowing more expensive for all kinds of companies, which can pressure their profits. Since the Federal Reserve indicated last month it likely won't rates as much in 2024 as earlier expected, the value of the U.S. dollar has also climbed against other currencies. That can mean a painful hit for S&P 500 companies, which get a big chunk of their revenue from abroad.

More encouraging for Wall Street was that the report also indicated prices were easing in September. That could mean less pressure on inflation, which has been feeling heat recently from fastrising oil prices.

Crude oil prices pulled back on Monday after charging mostly higher from \$70 during the summer. A barrel of U.S. crude fell 1.5% to \$89.44. Brent crude, the international standard, sank 1.2% to \$91.12.

The drop for oil dragged stocks lower across the energy sector. Exxon Mobil fell 2.1%, and Chevron lost 1.8%. SmileDirectClub plunged 62% to 16

On the winning side of Wall Street, Discover Financial Services jumped .7% for the biggest gain in the S&P 500. The company gave details about a consent order it received from the Federal Deposit Insurance Corp, requiring Discover Bank to improve its consumer compliance management system. Analysts pointed to how Discover did not receive a fine, which could be seen as a positive for the stock.

Congress over the weekend avoided a shutdown of the federal government, which threatened to hurt the economy and disrupt the publication of economic data Wall Street finds crucial. But Capitol Hill only temporarily delayed the threat, promising another showdown. Plus, traders are well aware the stock market has held up rather well through past shutdowns.

In stock markets abroad, indexes were lower across much of Europe. In Asia, Japan's Nikkei 225 slipped 0.3% despite a survey from the central bank showing business confidence is on

UK's Treasury chief raises the minimum wage

Hunt angers some colleagues by ruling out tax cuts

MANCHESTER, England, Oct 2, (AP): Britain's Treasury chief announced a hike in the national minimum wage on Monday, as the governing Conservative Party tries to persuade voters it is on the side of those who are struggling financially.

But Chancellor of the Exchequer Jeremy Hunt ruled out tax cuts, saying they would fuel inflation.

"I do want us to have lower taxes," Hunt told Sky News before his speech. But he said "it's very difficult to see" it happening this year.

That message was not what many Conservatives at the party's annual conference wanted to hear. Hundreds of them packed a room to applaud as former Prime Minister Liz Truss - whose seven weeks in office last year plunged Britain's economy into crisis - demanded Hunt slash taxes in his fall budget next month.

Hunt told conference delegates that the hourly rate for workers 23 or older will rise in April from 10.42 pounds (\$12.70) to at least 11 pounds (\$13.40). The exact amount will be set after a recommendation by the Low Pay Commission, an advisory body. Hunt said that will mean a raise for more than 2 million workers.

Hunt also pledged to freeze civil service recruitment to cut costs and toughen the rules on social benefits in an attempt to stem the flow of working-age people out of the workforce, a trend that has accelerated since the coronavirus pandemic.

"It isn't fair that someone who refuses to look seriously for a job gets the same as someone trying their best," he said, in remarks that drew concern from anti-poverty groups.

The party is trying to sprinkle voter-pleasing measures such as the pay increase at the conference, which may be the last before a national election due in 2024. But the government's spending power is constricted by the U.K.'s sluggish economy and stubbornly high inflation that hit double digits last year and now stands just below 7%.

The result was a grab-bag of generally inexpensive policy announcements: a ban on children using cell phones in school, a curb on local authorities slapping "excessive fines on motorists," a push for "smarter

Opponents

Opponents see a government that has run out of big ideas and a party heading for defeat. The right-of-center Tories, in power since 2010, are lagging far behind the center-left opposition Labour Party in opinion polls. Voters are weary after years of political turmoil over the U.K.'s exit from the European Union, the coronavirus pandemic and a cost-of-living crisis fueled by Russia's invasion of Ukraine last year. Prime Minister Rishi Sunak, who took office just under a year ago, is facing grumbling - and even open rebellion - from some Conservative members and lawmakers.

Sunak steadied the economy after his predecessor Truss crashed the pound and trashed Britain's reputation for fiscal prudence with her taxslashing economic plans. She left office after just 49 days.

Many Conservatives doubt whether Sunak - the party's fifth leader since 2016 - can restore its popularity to the level that saw the party win an 80seat majority in the 650-seat House of Commons in 2019. The prime minister then, Boris Johnson, resigned in mid-2022 amid scandals over his ethics

In recent weeks, Sunak has sought to take the initiative with a clutch of measures depicted as easing the economic burden on taxpayers. He has delayed a ban on selling new gas and diesel cars and watered down other green measures that he said imposed "unacceptable costs" on ordinary people. Critics say the measures will have little impact on people's pocketbooks and will make it harder for Britain to reach its goal of cutting greenhouse gas emissions to net zero by 2050 in order to limit climate change.

Hundreds of party lawmakers, activists and officials attending the fourday conference in Manchester, northwest England, are being wooed by rivals to Sunak, positioning themselves for a party leadership contest that could follow election defeat.

Home Secretary Suella Braverman and Business Secretary Kemi Badenoch are both addressing meetings and receptions as they vie for the support of the party's populist right wing, which wants tough curbs on irregular migration and a war on liberal social values derided as "woke." Foreign Secretary James Cleverly is popular with more centrist Conservatives.

Even Truss, who resigned in disgrace less than 12 months ago, is on hand to offer her opinion, keep her name in the headlines and make life difficult for her successor.

At a packed meeting attended by several high-profile lawmakers on the party's right wing, Truss, called for everyone to "unleash their inner Conservative" and back a platform of lower taxes, less environmental regulation - including removing a ban on fracking - and a smaller state,

Truss, whose plan for billions in unfunded tax cuts spooked the financial markets last year, got loud applause for her mantra that "government is too big, that taxes are too high and that we are spending too much."

"Let's stop taxing and banning things," she said.

Tourism arrivals nearing pre-pandemic levels

Manufacturers upbeat about economy, BoJ survey shows

TOKYO, Oct 2, (AP): Business sentiment among big Japanese manufacturers improved in July-September for the second straight quarter, according to a central bank survey released Monday.

The Bank of Japan's "tankan" quarterly survey measured business sentiment among major manufacturers at plus 9, up from plus 5 in June.

Sentiment among major nonmanufacturers rose four points to plus 27, in the sixth consecutive quarter of improvement and the most positive result in about three decades.

The tankan survey, conducted every three months, measures corporate sentiment by subtracting the number of companies saying business conditions are negative from those replying they are positive.

Tourism, which has lifted the world's third largest economy in recent years, was hit by the pandemic. But incoming travelers have gradually returned to near pre-pandemic levels.

The negative effects of COVID-19 on supplies of computer chips and other key parts for manufacturers have also gradually eased, with production recovering, according to ana-

"The recent cheap yen that came on top of the gradually improving supply chain is believed to have worked as a factor to brighten sentiments among manufacturers," Nagahama, Toshihiro chief economist at Dai-ichi Life Group.

For non-manufacturers, the return of foreign tourists and healthy domestic tourism during the summer holidays likely boosted sentiments, he said.

For the past decade, the Japanese economy has stagnated overall, with slow wage increases. Another negative has been soaring energy prices due to Russia's war in Ukraine. That's tough for Japan, which imports almost all its oil, at a time when the Japanese yen is weakening.

But the weak yen has worked as a positive, too, boosting the value of overseas earnings by exporters like Toyota and Nintendo. The dollar has been trading recently at about 149 yen, up from below 130 yen in January.

For the tankan's projection of business sentiment three months from now, large manufacturers are expecting an improvement of 1 point at plus 10.

What the Bank of Japan will do to interest rates in coming months is being closely watched. The central bank has kept interest rates at zero or in minus territory for years to wrest Japan out of its economic doldrums. The BOJ is targeting stable price rises



Malaysia's government on Monday reassured the country there is sufficient rice in the market and urged people not to hoard locally produced rice after recent panicbuying led to empty shelves in supermar-

kets and grocery stores nationwide. Agriculture and Food Security Minister Mohamad Sabu said the government will increase distribution to rural areas to address a supply issue sparked by a hike in the price of imported rice. Malaysia and many countries are grappling with rising rice prices and low supplies after India's curb on rice sales cut global supplies by a fifth.

Mohamad said Malaysia's locally produced rice is capped at 2.60 ringgit (\$0.55) per kilogram (2.2 pounds), the cheapest in the region. So when sole importer Padiberas Nasional Berhad raised the price of imported white rice by 36% on Sept. 1, it prompted many Malaysians to switch from imported rice to cheaper lo-

He said the higher price of imported rice cannot be helped after after 19 countries,

including India, restricted rice exports to cater for domestic needs. Malaysia imports about a third of its rice supply.

"Actually, we don't have a shortage of rice in the country. It's just that the price of imported rice has risen sharply. Many people have shifted to buying cheaper local rice," he said, adding that the government is taking steps to address this issue.

"I want to remind the people again to keep calm and just buy what you need. Don't panic-buy.

Malaysians urged not to panic-buy local rice

Mohamad said the government will increase distribution of local rice to rural areas. He said the government will also subsidize the price of imported rice to two poorer states on Borneo island to ensure adequate supply. From Tuesday, he said, authorities will step up surveillance of rice wholesalers and shops to ensure there is no hoarding of local rice.

He said samples will also be taken to ensure that sellers are not repackaging local rice as imported rice or mixing the grains for higher profits, warning that stern action will be taken against anyone

found to be doing so.

Mohamad's press conference was held ahead of this week's meeting of Southeast Asian agriculture and forestry ministers that begins Wednesday. He said the rice crisis and food security will be discussed at their meeting. The minister of the 10-member bloc, known as the Association of Southeast Asian Nations, will also meet their counterparts from China, Japan and South Ko-

Late-night talk shows back on air as writers' strike eases

LOS ANGELES, Oct 2, (AP): Late-night talk shows are returning after a five-month absence brought on by the Hollywood writers strike, while actors will begin talks that could end their own long work walk-

CBS's "The Late Show With Stephen Colbert," ABC's "Jimmy Kimmel Live!" and NBC's "The Tonight Show Starring Jimmy Fallon" were the first shows to leave the air when the writers strike began on May 2, and now will be among the first to return on Monday night.

Comedian John Oliver got his first take on the strike out, exuberantly returning Sunday night to his "Last Week Tonight" show on HBO and delivering full-throated support for the strike. Oliver cheerily delivered a recap of stories from the last five months

before turnings serious, calling the strike "an immensely difficult time" United Auto Workers strikes spread as 7,000 more workers at two

plants join the picket line "To be clear, this strike happened for good reasons. Our industry has seen its workers severely squeezed in recent years," Oliver said. "So, the writers guild went to strike and thankfully won. But, it took a lot of

sacrifices from a lot of people to achieve that.' "I am also furious that it took the studios 148 days to achieve a deal they could have offered on day (expletive) one," Oliver said. He added that he hope the writers contract would give leverage to other entertainment industry guilds – as well as striking auto workers and employees in other industries – to negotiate better deals.

Warner Bros. Discovery, which owns HBO, is among the studios on the other side of the table in the writers and actors strikes.

Network late-night hosts will have their returns later Monday. Colbert will have Astrophysicist and author Neil deGrasse Tyson on his first show back. Kimmel will host Arnold Schwarzenegger. Matthew McConaughey will be on Fallon's couch.

All the hosts will surely address the strike in their monologues.

Agreement

"I'll see you Monday, and every day after that!" an ebullient Colbert said in an Instagram video last week from the Ed Sullivan Theater, which was full of his writers and other staffers for their first meeting

The hosts haven't been entirely idle. They teamed up for a podcast, 'Strike Force Five," during the strike.

The writers were allowed to return to work last week after the Writers Guild of America reached an agreement on a three-year contract with an alliance of the industry's biggest studios, streaming services and production companies.

Union leaders touted the deal as a clear win on issues including pay, size of staffs and the use of artificial intelligence that made the months off worth it. The writers themselves will vote on the contract in a week of balloting that begins Monday.

Meanwhile, the Screen Actors Guild-American Federation of Television and Radio Artists will begin negotiations with the same group, the Alliance of Motion Picture and Television Producers, for the first time since they joined writers in a historic dual strike on July 14.

Actors walked off the job over many of the same issues as writers, and SAG-AFTRA leaders said they would look closely at the gains and compromises of the WGA's deal, but emphasized that their demands would remain the same as they were when the strike began.

It was just five days after writers and studios resumed talks that a deal was reach and that strike ended, though an attempt to restart negotiations a month earlier broke off after a few meetings.

The late-night shows will have significant limits on their guest lists. Their bread and butter, actors appearing to promote projects, will not be allowed to appear if the movies and shows are for studios that are the subject of the strikes.

But exceptions abound. McConaughey, for example, is appearing with Fallon to promote his children's book, "Just Because."

And SAG-AFTRA has granted interim agreements allowing actors to work on many productions, and with that comes the right of actors to publicly promote them.

DaCosta shines in Marvel's 'The Marvels'

NEW YORK, Oct 2, (AP): Nia DaCosta, director of the upcoming "The Marvels," has a diagnosis for the recent struggles of superhero movies. It basically comes down to, she says, "Mo' money, mo' prob-

Success inevitably breeds bigger budgets. Boxoffice expectations get inflated. Even superhero spandex can't sustain endless cycles of wash, rinse and repeat.

"Growth has to stop at some point," says DaCosta. "As you make more and more films, you want those films to be more interesting, more dynamic and to appeal to different audiences. But that requires risk. And there's a conundrum where you're so big that you can't take risks. I think that's what the audience is feeling. They're like: 'I've seen it before, and I liked it the first time."

When "The Marvels" opens in theaters Nov. 10, it will be debuting in uncommonly uncertain times for superhero films. There's talk of over-saturation. DC and Warner Bros. are in makeover mode. Box office-dominance this year has been ceded to Barbie

While no one's doubting the supersized place of superheroes in Hollywood, mass success for Marvel no longer seems quite so automatic. For DaCosta, whose two previous films were the Jordan Peeleproduced horror remake "Candyman" and the acclaimed 2018 indie crime drama "Little Woods," it's imperative that superhero movies aspire to be fresh and daring - like "Across the Spider-Verse."

"The more we can do that as an industry, the better," DaCosta said in a recent interview, praising the originality of that animated Marvel movie released earlier this year. "I also think you have to not set your sights on such a big box-office return so then you can comfortably take risks.'

"The Marvels," which stars Bree Larson, Teyonah Parris, Iman Vellani and Samuel L. Jackson, isn't anyone's idea of going far out on a limb. It's loosely a sequel to 2019's "Captain Marvel," which surpassed \$1.1 billion worldwide. By any measure, "The Marvels" is one of the fall's most anticipated

titles. But it's also a big-budget attempt to try some new things. It's the first Marvel movie to feature not just all-female leads but a female villain (Zawe Ashton plays Dar-Benn), as well. DaCosta, 33, is the youngest filmmaker to helm an MCU release. She's also

the first Black woman to do so. "Day to day, I don't really think about it. But it is nice to finally have a Black woman directing one it just happens to be me," DaCosta says, laughing. 'What was cool about realizing that, I was sort of like: Wow, I'm the first Black woman. But I'm also the third woman and the fourth or fifth person of color. It was cool to see that I wasn't just stepping into an all-white, all-male world."

Powers

"The Marvels" brings together Carol Danvers/ Captain Marvel (Larson), Monica Rambeau/Photon (Parris) and Kamala Khan/Ms. Marvel (Vellani). While originally conceived as a post-"Endgame" follow-up to "Captain Marvel," Marvel chief Kevin Feige was drawn to the chance to unite Captain Marvel with Rambeau from "WandaVision" and Ms. Marvel of her standalone Disney+ series.

In "The Marvels," the trio has become linked. Every time they use their powers, they swap places with each other, causing their worlds to collide in comic and surreal ways.

"When I was reading the outline that they sent me initially before I was pitching, I was like, 'This is insane," DaCosta says. "It felt so comic book-y. I

was like, 'Wow, they're really going for it.' DaCosta was drawn to what she calls "a really crazy, sci-fi space opera" that was wacky and tonally

different from most MCU films. "I wanted to honor what they set out to do, which is make something very frankly strange," she says. The heart of the film for DaCosta is about the dichotomy of Danvers and Ms. Marvel. While Danvers has been tirelessly doing the solitary work of Captain Marvel out in deep space, Ms. Marvel's foundation

is her family. DaCosta, a self-described workaholic, can relate.

"I mean, this my third film in six years and I'm onto my fourth," she says. "I'm from New York City and my family's mostly there and I've never shot there since I've been working. My mom once forgot to invite me to a family thing because she forgot I was in town. Stuff like that makes me go, 'I need to connect more."

That's hard, though, when you're one of Hollywood's fastest rising directors. DaCosta's ascent has been meteoric but steady, even though she's more comfortable with self-deprecation than self-promotion. Instead, her level-headed filmmaking talent particularly for conjuring atmosphere and playing

with perspective - has fueled her success. DaCosta was speaking from London where she's preparing to make an adaptation of Henrik Ibsen's "Hedda Gabler," with "Little Woods" star Tessa Thompson. With the SAG-AFTRA strike holding up all studio productions, DaCosta was itching to get going - and only occasionally pacified by her half-

Yorkie, half-Maltese dog named Maude. After making "Candyman," a Marvel movie was, DaCosta says, "definitely not in my near future." But it also wasn't entirely off her radar. She's wanted to direct one since she started making films and traces her interest directly to Sam Raimi's "Spider-Man." She saw it

when she was 12. "And I still love it," she says. When DaCosta was tapped to helm "The Marvels," Feige encouraged her to reach out to other Marvel movie directors for advice. The bit that most stuck with her came from "Black Panther" director

Ryan Coogler. He said simply: "Be yourself." "I was like, 'Wait, what?' Then I kind of got it," says DaCosta. "He was like: Just bring yourself to it. It's a big thing. It's really a Kevin Feige movie, it's a Marvel film. But they chose you for a reason."

movie financed by New Regency and distributed by Disney's 20th Century Studios, was easily the biggest film to launch in theaters over the weekend but struggled to catch on. It grossed a modest \$14 million at 3,680 theaters while adding \$18.3 million internation-

The film, directed by Gareth



Edwards, stars John David Washington as an undercover operative in an AI-dominated future. "The Creator" drew mostly positive reviews and a B+ CinemaScore from audiences.

Sony Pictures' "Dumb Money," expanded nationwide after two weeks of limited release but failed to ignite the kind of

populist movement it irreverently dramatizes. The film, directed by Craig Gillespie, came away with a disappointing \$3.5 million in 2,837 locations.

"Dumb Money," starring an ensemble of Paul Dano, Pete Davidson, Seth Rogen, American Ferrera and Anthony Ramos, turns the GameStop stock

frenzy into a ripped-from-theheadlines underdog tale of amateur traders rattling Wall Street. While all of the weekend's new releases were hampered by the ongoing SAG-AFTRA strike, "Dumb Money" would have especially benefitted from its cast hitting late-night shows and other promotions. (AP)

Beats censorship

Japanese feminist's book tops in China

HONG KONG, Oct 2, (AP): In the last few years, China's government has promoted increasingly conservative social values, encouraging women to focus on raising children. It has cracked down on civil society movements and made laws to drive out foreign

So a 75-year-old Japanese feminist scholar who's not married and does not have children is an unlikely celebrity on the country's tightly censored internet.

But Chizuko Ueno, a professor emeritus at the University of Tokyo, is a phenomenon. She leapt to fame in China in 2019 with a speech that criticized social expectations for women to act cute and the pressure they face to hide their success.



Ueno's popularity reflects a surge in interest in women's rights, said Leta Hong Fincher, a research associate at the Weatherhead East Asian Institute who has written about gender discrimination and feminism in China.

About a decade ago, China had a rambunctious feminist movement that staged protests like occupying a men's restroom to demand more toilets for women, or marching

in wedding dresses spattered with fake blood to draw attention to domestic violence. But that movement has been silenced as President Xi Jinping's administration has tightened controls on civil society and promoted conservative family values in a bid to boost child-

Ueno declined multiple requests to be interviewed for this story

In mainland China, Ueno's books sold more than half a million copies in the first half of 2023, according to sales tracker Beijing OpenBook, and 26 were available in Chinese bookstores as of September. They cover topics ranging from "misogyny" in Japanese society to feminist approaches to elder care is-

sues in an aging society.
"Starting From the Limit," a collection of letters between Ueno and Suzumi Suzuki, a writer who used to act in Japanese porn, topped the 2022 Books of the Year list on the popular Chinese review platform Dou-

Fans said Ueno's openness about choosing not to marry or have children makes her a role model.

Retaliation

Edith Cao, a writer who spoke on the condition of being identified by her English nickname due to fear of government retaliation, said seeing an East Asian woman succeed without a family helped her decide not to marry. Yang Xiao, a graduate student, said Ueno's example helped assuage her anxieties about being single and inspired her to start booking holidays alone to build confidence.

Relationships are a divisive issue even among Ueno's Chinese fans. Earlier this year, fans attacked a Chinese video blogger who asked Ueno if she hadn't married because "she'd been hurt by men," saying the blogger had reinforced traditional assumptions. That started a series of online conversations about marriage and feminism that lasted for months, with reated hashtags drawing some 580 million views on the Twitter-like social media platform Weibo.

Ueno doesn't write about China, and that's probably one key reason her books have escaped censorship, said Hong Fincher.

Feminist ideas are not banned in China, but authorities view all activism with suspicion.

Police regularly summon owners of bookstores and cafes and pressure them to cancel feminismthemed events, several organizers and founders told The Associated Press. Online, posts that refer to the #MeToo movement are deleted, and nationalist bloggers attack feminists with a public presence as foreign agents.

Chinese journalist and activist Huang Xueqin, who helped spark China's first high-profile #MeToo case, was tried last week for allegedly inciting subversion of state power. According to a copy of the indictment published by supporters of Huang, she was accused of publishing "seditious" articles and facilitating training activities on "non-violent movements."

Protest and campaigning are no longer possible, said Lü Pin, a Chinese feminist activist based in the U.S., meaning feminism is confined to individual action and small groups. The Ueno boom, she said, has helped keep feminist ideas in the "lawful" main-

Megan Ji, a 30-year-old financial analyst, said it wasn't until she read one of Ueno's books that she began taking an interest in the ideas of feminists.

That helped her confront her boss when he began caressing her back at an after-work karaoke party with colleagues and potential business partners. She works in a competitive industry in which fitting in at afterwork parties is widely considered vital to her job, and another woman hadn't said anything when a drunken manager placed his arm over her shoulder.

But when her boss began badgering her to sing, she shouted: "Do you respect me? Who do you take me for?" Her colleagues were shocked, but Ji's boss apologized, both on the spot and again the next day. Ji said she didn't suffer retaliation, and no awkward parties have happened in the office since then.

The AP could not independently verify Ji's account, and she requested to be identified by her English name to avoid repercussions from her company.

Guo Qingyuan, a 35-year-old copywriter, said that reading Ueno led him to question how he saw women. He stopped talking about women's looks with his buddies, he said, and sought out children's books for his daughter that didn't promote stereotypical gender

NEW YORK: The Pulitzer Prize Board has revised its longtime rules on eligibility for many of its arts and letters awards and will now allow those not born in the **US** and other non-citizens to compete.

The 12-time Grammy Award winner arrived at MetLife Stadium about 40 minutes before kickoff Sunday night to watch Kelce and his Kansas City Chiefs defeat the New York Jets 23-20.

SNY posted video of Swift, wearing blue jean shorts, a long-sleeved black top and leather jacket, entering the stadium' security area with actors Ryan Reynolds, Blake Lively and Hugh Jackman. NBC's telecast cut to Swift several times during the game, including a shot of the pop superstar with her arm around Kelce's mother, Donna, who was wearing her son's No. 87 jersey.

Swift's appearance comes a week after she was at Arrowhead Stadium - decked out in red and white - to watch the Chiefs' 41-10 rout of the Chicago Bears at home in a suite alongside Donna Kelce. Swift took advantage of an invitation from the All-Pro tight end to watch the game, and apparently had to see more of Kelce and the Chiefs in action.

Swift is on a break from her Eras Tour, which resumes Nov. 9 in Buenos Aires, Argentina. NBC played a commercial for the tour about 20 minutes before kickoff.

MetLife Stadium is a familiar spot for Swift, who performed three sold-out concerts there in May. Among those in attendance for two of those shows was Jets quarterback Aaron Rodgers, who returned to the team this weekend after tearing his left Achilles tendon on the fourth play of his debut with **New York** on Sept. 11.

Rodgers attended a team meeting Saturday night and was at the stadium watching player warmups from the sideline Sunday

Neither Swift nor Kelce have revealed any details about their relationship. Kelce said on his "New Heights with Jason and Travis Kelce" podcast earlier this week that Swift "looked amazing" at the game.

"Everybody was talking about her and in a great light," Kelce said of her time spent in the suite. "And on top of that, you know, the day went perfect for Chiefs fans. Of course, we script it all, ladies and gentlemen. Kelce had invited Swift to that game

Burton bids farewell at McQueen

Valentino visits Les Beaux-Arts with a twist

PARIS, Oct 2, (AP): Valentino took a sentimental journey to Les Beaux-Arts this Sunday, revisiting the prestigious Parisian art school where its founder, Valentino Garavani, was once a stu-Dive into the highlights of this

Spring/Summer 2024 ready-to-wear collections from Paris, including the end of an era at Alexander McQueen as its lauded designer Sarah Burton presented her final show. Amid the backdrop of Mannerist statues and the names of great artists

gracing the storied walls of Les Beaux-Arts, where Garavani, 91, once honed his craft, the runway was - in contrast unmistakably contemporary. Strategically positioned boxes filled with rocks, sand, and earth transformed into platforms for a troupe of sinewy, scantily clad contemporary dancers who writhed alongside a performance by British singer FKA Twigs.

Designer Pierpaolo Piccioli's collection focused on the body - in a vivid "celebration of femininity and creativity." Bursting onto the scene were fresh, sporty minidresses adorned with intricate white florals and foliage. The elegance of an open tuxedo baring flesh, and the simplicity of flowing silk caped dresses made a statement, but there was a sense of familiarity. A pastel gray cape minidress captured attention with its minimalist charm. A chainmail disco mesh-dress shimmered and revealed inches of body.

Yet, the dynamic dance performances often drew eyes away from the fashion. Could it be that the collection, while undeniably modern, needed that extra dose of novelty to truly captivate?

While Piccioli's designs were a testament to Valentino's evolving aesthetic, some elements felt reminiscent of past collections or even lacking in fresh ideas, a point that's been leveled by critics at the designer in the past. Nonetheless, spring marked a blend of the brand's intrinsic elegance and a desire to pare down styles to their essentials.

As the Parisian runway glinted under the weight of expectation, Sarah Burton, with a profound respect for legacy and an unmistakable innovative touch, presented her magnum opus for Alexander McQueen Saturday night. Her task had always been titanic - to step into shoes left empty by the enigmatic

genius of Lee Alexander McQueen. The fashion maestro's unexpected departure wasn't just a personal loss; it marked the end of an era of theatrical, emotion-laden masterpieces. But Burton, rather than just filling a void, lit it up. She wielded her tapestry of design, interweaving McQueen's audacious spirit with her softer, more feminine aesthetic.

Collection

This dance of duality was evident in her farewell collection, where each piece told its story. The slashed bodices, the evocative blood-red laced spines, and the influence of Polish artist Magdalena Abakanowicz's work showcased an artistry that was both fierce and tender.

The shimmer of glossy leather corsets contrasted with the ethereal shredded gossamer skirts, while other designs teased at deconstruction, with trailing embroidery and dripping silver organza that echoed McQueen's rebellious early days.

No detail was left untouched. From the profound artistry of Kate Middleton's wedding gown - a garment that transcended royal expectations - to her final collection's poignant motifs, Burton proved her mettle time and again. The iconic rose, emblematic openheart embroidery, and the magnetic close by Naomi Campbell in a sculpted silver bugle bead dress, all converged in a collection that was both homage and evolution.

And as the last piece sashayed down the runway, the room -- filled with powerful editors and actresses like Cate Blanchett and Elle Fanning -- rose in a rousing standing ovation, not just for Burton's final act but for a legacy beautifully continued and enriched under her stewardship.

Fujishima did not appear at Monday's news conference and had a letter read aloud. The letter said she was "brainwashed" by her mother Mary, who insisted Kitagawa was innocent, even after the Japanese Supreme Court ruled two decades ago that the sexual allegations against him were accurate.

"I want to erase all that remains of Johnny from this world," she wrote. "I do not forgive what Johnny has done.'

Some victims say they have suffered for decades in silence, unable to confide in family or friends, while experiencing flashbacks.

Most of the attacks took place at Kitagawa's luxury apartment, where several youngsters were handpicked to spend the night. The following morning, he would thrust 10,000 yen (\$100) bills into their hands, according to various testimony.

Rumors about Kitagawa were rampant over the years, with several tell-it-all books published. A recent U.N. investigation has said that the number of victims is at least several hundred, and called on the Japanese government to act. When BBC did a special on Kitagawa earlier this year, the scandal jumped into the spotlight.

Cheaper, more effective

UN OKs second malaria shot, but doubts persist

LONDON, Oct 2, (AP): The World Health Organization authorized a second malaria vaccine on Monday, a decision that could offer countries a cheaper and more effective option than the world's first shot against the parasitic

WHO Director-General Tedros Adhanom Ghebreyesus said the UN health agency was approving the new malaria vaccine based on the advice of two expert groups, recommending its use in children at risk of the disease.

"As a malaria researcher, I used to dream of the day we would have a safe and effective vaccine against malaria. Now we have two," Tedros said.

Oxford University developed the new three-dose vaccine with help from the Serum Institute of India. Research

suggests it is more than 75% effective and that protection is maintained for at least another year with a booster. Tedros said the shot would cost about \$2 to \$4 and could

be available in some countries next Earlier this year, regulatory authorities in Ghana and Burkina Faso approved the vaccine.

'This is one more tool we will now have, but it's not going to replace bed nets and spraying insecticides," said John Johnson with Doctors Without Borders. "This is not the vaccine

that's going to stop malaria.' Johnson was not part of the WHO expert group that gave the Oxford vaccine the green light.

Tedros

In 2021, WHO endorsed the first malaria vaccine in what it described as a "historic" effort to end the devastating toll the mosquito-transmitted disease has on Africa, home to most of the world's estimated 200 million cases

But that vaccine, known as Mosquirix and made by GSK, is only about 30% effective, requires four doses and protection fades within months.

Recommend

The Bill & Melinda Gates Foundation, one of the vaccine's biggest backers, stepped back last year from financially supporting Mosquirix's rollout, saying it was less effective than officials would like and that funding would be better used elsewhere.

"The big difference with these two vaccines is access," Johnson said, noting that only about a dozen countries are scheduled to get limited quantities of the GSK vaccine in the next few years.

GSK has said it can only produce about 15 million doses a year. The Serum Institute has said it could make up to 200 million doses of the Oxford vaccine a year.

Alister Craig, an emeritus professor at the Liverpool School of Tropical Medicine, said he would recommend countries trying to get the GSK vaccine switch to the Oxford vaccine instead. Craig noted that no big funders have yet agreed to buy the Oxford vaccine for poor countries and it's still unclear how effective the shot might be in the

If the new vaccine is rolled out widely across Africa, it could dramatically reduce the amount of severe illness and deaths caused by malaria in a few years, Craig said.

Neither of the malaria vaccines stop transmission so immunization campaigns alone won't be enough to stop epidemics. Efforts to curb the disease are also being complicated by increasing reports of resistance to the main drugs used to treat malaria and the spread of invasive mosquito

"You would be foolish to think that this vaccine is going to be the end of the malaria story," Craig said.

In a separate decision, WHO's expert group also authorized the dengue vaccine made by Takeda, which was previously approved by the European Union drug regulator.

There is no specific treatment for dengue, common in tropical Latin American and Asian countries. While most infections are mild, severe cases of the mosquito-spread disease can lead to internal bleeding, organ damage and

WHO's expert groups advised that the Takeda dengue vaccine be used in children aged 6 to 16 in countries with a high prevalence of the disease.

Previous studies have showed Takeda's vaccine was about 84% effective in preventing people from being hospitalized with dengue and about 61% effective in stopping symptoms four years after getting immunized.

Nearly 1,000 people have been killed by dengue this year in an ongoing epidemic in Bangladesh, the country's worst outbreak of the disease.

Season's 1st snow forecast: The first snowfall of the season is expected this weekend in the central Sierra Nevada, including Yosemite National Park, where as much as 10 inches (25 centimeters) is possible at the highest elevations.

The National Weather Service in Reno, under its Governor of California Gavin **Newsom**, issued a winter weather advisory on Saturday effective through 8 p.m. Sunday for California's Mono County along the Nevada line. Slick conditions could make travel difficult over eastern Sierra mountain passes, especially over Tioga and Sonora Passes on the edge of Yosemite, the service said.

Late-season backcountry enthusiasts should anticipate light snow accumulations over area trails and campgrounds, with up to a half foot of snow (15 cm) in some areas and as much as 10 inches (25 cm) above 10,000 feet (3,048 meters).

Rain is forecast to move into the Lake Tahoe area Saturday with some thunderstorms and a dusting of snow above 8,000 feet (2,438 meters). Overnight lows are expected to drop below freezing at lake level.

2 win Nobel for work on COVID vaccine

STOCKHOLM, Oct 2, (AP): Two scientists won the Nobel Prize in medicine on Monday for discoveries that enabled the development of mRNA vaccines against COVID-19 and could be used in the future to create other shots.

Katalin Karikó, a professor at Sagan's University in Hungary and an adjunct professor at the University of Pennsylvania, and Drew Weissman, of the University of Pennsylvania, were awarded the prize for "their groundbreaking findings, which have fundamentally changed our understanding of how mRNA interacts with our immune system," the panel that awarded the prize said.
"The laureates contributed to the un-

precedented rate of vaccine development during one of the greatest threats to human health in modern times," the Karikó said her husband was the first

to pick up the early morning call, then handed it to her to hear the news. "I couldn't believe it," she said. "I was very much surprised. But I am very happy." Before COVID-19, mRNA vaccines

were already being tested for other diseases like Zika, influenza and rabies but the pandemic brought more attention to this approach, Karikó said.

Traditionally, making vaccines required growing viruses or pieces of viruses - often in giant vats of cells or, like most flu shots, in chicken eggs and then purifying them before next steps in brewing shots.

The the messenger RNA approach is radically different. It starts with a snippet of genetic code that carries instructions for making proteins. Pick the right virus protein to target, and the body turns into a mini vaccine factory.

Dr. Paul Hunter, a professor of medicine at Britain's University of East Anglia, described the mRNA vaccines as a 'game changer" in helping to shut down the coronavirus pandemic, crediting the shots with saving millions of lives.

"If it hadn't been for the mRNA technology, COVID would have been much worse," he said. "Vaccines generally were the turning point in slowing down COVID and the mRNA vaccines were just so much better than all the others," he said, noting that the main vaccine used in the U.K., made by AstraZeneca, is barely in use any-

"We would likely only now be comout the mRNA vaccines," Hunter said.

Karikó was a senior vice president at BioNTech, which partnered with Pfizer to make one of the COVID-19 vaccines. The BioNtech website says that since 2022 she has been an external consultant. She is the 13th woman to win the Nobel Prize in medicine. Weissman is a professor and director of the Penn Institute for RNA Innovations at the University of Pennsylvania.

Dr. Bharat Pankhania, an infectious diseases expert at Exeter University, said that a major advantage of mRNA technology was that vaccines could be made in extremely large quantities since their main components are made in laboratories. Pankhania predicted that the tech-

nology used in the vaccines could be used to refine vaccines for other diseases like Ebola, malaria and dengue, and might also be used to create shots that immunize people against certain types of cancer or auto-immune diseases like lupus.

"It's possible that we could vaccinate people against abnormal cancer proteins and have the immune system attack it after being given a targeted mRNA shot," he explained. "It's a much more targeted technology than has been previously available and could revolutionize how we handle not only outbreaks, but non-communicable diseases.



The fallout from Luis Diaz's wrongly-disallowed goal in Liverpool's 2-1 loss at Tottenham on Saturday resulted in the Merseyside club issuing a statement, saying it would "explore the range of options available given the clear need for escalation and resolution."

It is not clear what those "options" are and The Associated Press has contacted Liverpool and the Professional Game Match Officials Limited (PGMOL), the referees' governing body, for clarification.

But the tone of Liverpool's statement on Sunday revealed the club's frustration after Video Assistant Referee (VAR) Darren England failed to award Diaz's goal, despite replays clearly showing the forward was onside.

The PGMOL later acknowledged the mistake was a case of "significant human error" and England and his assistant Dan Cook were stood down from further duty over the weekend.

Diaz's goal would have put Liverpool 1-0 up against Tottenham and a win would have seen Jurgen Klopp's team move to the top of the standings, above defending champions Manchester City.

"It is clear that the correct application of the laws of the game did not occur, resulting in sporting integrity being undermined," Liverpool said. "We fully accept the pressures that match officials work under but these pressures are supposed to be alleviated, not exacerbated, by the existence and implementation of VAR.

Saturday's error appears to have been one of concentration and communication.

"It wasn't human error, it was not understanding your job," Arsenal manager Mikel Arteta said at the time and his team ended the season five points behind Man City in second Earlier this season Wolverhampton was denied a clear

penalty against Manchester United when Andre Onana crashed into Sasa Kalajdzic in stoppage time at Old Trafford. Wolverhampton manager Gary O'Neil said he received an apology from the PGMOL.

Apologies, however, do not make up for costly errors. "We will not get points for it so it doesn't help," Klopp said Saturday. "Nobody expects 100% right decisions onfield, but we all thought when VAR comes in that it might
