CAIRO, Oct 28, (AP): A passenger bus slammed into a parked vehicle on a foggy Saturday morning on a highway linking the Egyptian capital, Cairo, and the Mediterranean city of Alexandria, killing at least 32 people, authorities

'War enters new stage'

UNITED NATIONS, Oct 28, (Agencies): The U.N. General Assembly approved a non-binding resolution Friday calling for a "humanitarian truce" in Gaza leading to a cessation of hostilities between Israel and Gaza's Hamas rulers, the first United Nations response to the war.

The 193-member world body adopted the resolution by a vote of 120-14 with 45 abstentions after rejecting a Canadian amendment backed by the United States. It would have unequivocally condemned the Oct. 7 "terrorist attacks" by Hamas and demanded the immediate release of hostages taken by Hamas, which is not mentioned in the Arab-drafted resolution. Riyad Mansour, the Palestinian U.N. ambassador, called the General Assembly "more courageous, more principled" than the divided U.N. Security Council, which failed in four attempts during the past two weeks to reach agreement on a resolution. Two were vetoed and two failed to get the minimum nine "yes" votes required for approval. Israel's U.N. Ambassador Gilad Erdan called it "a day that will go down in infamy," saying after the vote: "Israel will not stop the operation until Hamas terror capabilities are destroyed and our hostages are returned. ... And the only way to destroy Hamas is root them out of their tunnels and subterranean city of terror.' Frustrated Arab nations went to the General Assembly, where there are no vetoes - just as Ukraine did after Russia's February 2022 invasion because of Moscow's Security Council veto power - to press for a U.N. response. And the United Arab Emirates Ambassador Lana Nusseibeh, the Arab representative on the Security Council, expressed delight at the result. "120 votes in this kind of geopolitical environment is a very, very high signal of the support for international law, for proportionate use of force, and it is a rejection of the status quo that is currently happening on the ground," she said. The State of Kuwait has underlined that the Israeli occupation's war crimes against Palestinians under the pretext of 'self-defense" show disregard for the relevant UN resolutions and the international law

US strikes Iran-linked sites in Syria in retaliation for attacks

WASHINGTON, Oct 28, (AP): U.S. fighter jets launched airstrikes early Friday on two locations in eastern Syria linked to Iran's Revolutionary Guard Corps, the Pentagon said, in retaliation for a slew of drone and missile attacks

The multi-car pileup, which set some vehicles ablaze, left at least 63 others injured, said the Health Ministry. Ambulances rushed to the scene of the crash on the Cairo-Alexandria desert road to transport the injured to nearby hospitals, it said.

Local media reported that the bus was on its way to Cairo when it hit the parked vehicle. Other cars slammed into the bus with some catching fire.

Footage circulating online showed many burned vehicles on the side of the road with firefighters extinguishing the fire. In one footage many vehicles were seen on fire with thick plumes of smoke billowing from them.

DUBAI: An Iranian teenage girl injured weeks ago in a mysterious incident on **Tehran**'s Metro while not wearing a headscarf has died, state media reported Saturday.

The death of **Armita Geravand** comes after her being in a coma for weeks in Tehran and after the one-year anniversary of the death of 22-year-old **Mahsa Amini** which sparked nation-wide protests at the time.

Geravand's Oct. 1 injury and now her death threaten to reignite that popular anger, particularly as women in Tehran and elsewhere still defy **Iran**'s mandatory headscarf, or hijab, law as a sign of their discontent with Iran's theocracy. (AP)

BRUSSELS: An international conference hosted by the EU's police agency, Europol, at **The Hague**, concluded that tackling the criminal use of cryptocurrencies is a race against time.

The two-day event on Thursday and Friday organised in a hybrid format, was attended by representatives from law enforcement, the public and private sectors, policy institutions and academia from more than 100 countries.

The aim was to explore trends and strategies to tackle crimes involving cryptocurrencies, said Europol in a press release. (KUNA)

NEW DELHI: India and the European Union on Friday discussed ways of enhancing safe and regular migration between India and the EU and ways of countering irregular migration, smuggling of migrants and trafficking in human beings.

The Indian Ministry of External Affairs said in a statement that in the framework of the 7th India-EU High Level Dialogue on Migration and Mobility, both sides discussed ways of further deepening cooperation in the field.

The meeting was co-chaired by Additional Secretary of the Ministry of External Affairs of India **Anurag Bhushan** and Deputy Director General of the European Commissions Directorate-General for Migration and Home Affairs **Johannes Luchner**. (KUNA)

War crimes

The international community must immediately intervene and hold the Israeli occupation accountable for its blatant war crimes and continued violations of international law, said Diplomatic Attache Reem Al-Sharhan, of Kuwait's Permanent Delegation to the UN, at the UN General Assembly's First Committee meeting on Disarmament Machinery.

She slammed the occupying entity for its "lies and continuous denial of war crimes".

Al-Sharhan expressed Kuwait's deep concern about the ongoing escalation in the Gaza Strip "which claimed the lives of more than 6,000 Palestinian civilians, including more than 2,000 children."

She reiterated her country's respect for international agreements, especially those related to disarmament, international security and peace.

"Despite Kuwait's commitment, we express our concern due to the lack of tangible progress in terms of disarmament and the implementation of the relevant obligations," Al-Sharhan regretted.

She criticized the international community double standards on disarmament and non-proliferation of nuclear weapons and other weapons of mass destruction. It is quick to condemn some countries but remains silent towards others, she said.

The 14 countries that voted against the resolution include Israel and its closest ally, the United States, five Pacific island nations and four European countries - Austria, Croatia, Czechia and Hungary, all European Union members. Eight EU members voted in favor.

France's U.N. Ambassador Nicolas De Riviere said his country supported the resolution "because nothing could justify the suffering of civilians," and he urged collective efforts to establish a humanitarian truce.

Mansour said the European votes indicate they can be "very helpful" in pursuing a Security Council resolution "or in maximizing pressure in Israel to stop this war."

The Arab Parliament affirmed that the UN General Assembly's approval of an Arab draft law on an immediate ceasefire, protecting civilians and opening humanitarian passages, must be followed by serious measures to pressure Israel to abide by the resolution.

MP seeks clarity on CAIT and 'stolen public funds'

KUWAIT CITY, Oct 28: MP Mehalhal Al-Mudhaf has forwarded queries to Minister of State for Municipal and Communication Affairs Fahd Al-Shaulah about the administrative and legal violations in the Central Agency for Information and Technology (CAIT).

He wants to know the reasons behind the resignation of the CAIT chairman in November 2022 with the vice-chairman being appointed as acting chairman as per ministerial decision number 304/2022 issued on Nov 22, 2022; why a new chairman has not been appointed till date considering the vital role of CAIT in maintaining national cybersecurity; if the list of officials nominated for the position was forwarded to the Council of Ministers and reasons if the answer is 'no': assessment requirements for employees at CAIT since 2019 till date; number of employees who were terminated for failing the assessment: number of employees hired since 2019 till date; if it is true that the assessment requirements are subjective such that the senior administration officials can fire employees according to their whims; if the assessment procedures are in line with Civil Service Commission (CSC) decision number 36/ 2006; if the assessment scores of employees were reduced in 2019, 2020, 2021 and 2022; if there are reports on the assessment of employees in the last five years comparing their scores with the previous years; if action on employees? complaints regarding promotions has been suspended; if the CSC approved the new organizational structure despite the violation of the law on establishing CAIT; if the agency's system has been hacked but it was not revealed to the public; and losses incurred due to the incident if the answer is in the affirmative.

He also asked Deputy Prime Minister, Minister of State for National Assembly and Cabinet Affairs Essa Al-Kandari about the total amount spent on recovering the public funds stolen by the former Public Institution for Social Security (PIFSS) chairman, including the cost of hiring attorneys and travel of the representatives of monitoring institutions to follow up the case.

MP Soud Al-Asfour asked Deputy Prime Minister, Minister of Oil and State Minister for Economic and Investment Affairs Saad Al-Barrak about the completion percentage of Abdullah Port, date of opening the port, its capacity, total cost of the project, factors leading to the delay if any, number of variation orders, cost, reasons and fine imposed on the contractor. against U.S. bases and personnel in the region that began early last week.

The strikes reflect the Biden administration's determination to maintain a delicate balance. The U.S. wants to hit Iranian-backed groups suspected of targeting the U.S. as strongly as possible to deter future aggression, possibly fueled by Israel's war against Hamas, while also working to avoid inflaming the region and provoking a wider conflict.

Air Force Brig. Gen. Pat Ryder said Friday that the strikes near Boukamal by F-16 and F-15 fighter aircraft targeted a weapons storage facility and ammunition storage facility used by the IRGC and affiliated groups. "Both facilities were destroyed," he said. "We currently assess there were no casualties in the strikes."

A senior U.S. military official said there had been Iranian-aligned militia and IRGC personnel on the base and no civilians. The official would not say how many munitions were launched by the jets.

Å senior defense official said the sites were chosen because the IRGC stores the types of munitions there that were used in the strikes against U.S. bases and troops. The two officials briefed reporters after the strikes on condition of anonymity to provide details on the mission that had not yet been made public.

Syrian opposition activists confirmed the U.S. strikes in Syria's eastern province of Deir el-Zour. Omar Abu Layla, a Europe-based activist who heads the Deir Ezzor 24 media outlet, said the main target was an area known as "the farms" outside the town of Mayadeen. He said it is an important transit site where weapons from Iran are stored before being shipped to Lebanon.

He said the second strike hit an area known as the "green belt" in the Boukamal area that borders Iraq. According to Abu Layla, some people were evacuated before the strikes because the retaliation was expected. The Britain-based Syrian Observatory for Human Rights, an opposition war monitor, said ambulances were seen rushing to the area but it wasn't clear if there were casualties.

Meanwhile Friday, an Iranian semiofficial news agency, Tasnim, said gunmen in east Syria fired 10 rockets on a base housing American troops in retaliation for the U.S. airstrikes. A U.S. official confirmed the rocket attack and said there were no reported casualties.

And the Islamic Resistance in Iraq, an umbrella group for several Iranbacked groups, said fighters attacked al-Assad airbase in western Iraq with a suicide drone. U.S. officials said it was shot down a few kilometers away and did not hit the base.

According to the Pentagon, as of Friday there had been at least 20 attacks on U.S. bases and personnel in Iraq and Syria since Oct. 17. Ryder said 21 U.S. defense strikes are a response to a series of ongoing and mostly unsuccessful attacks against U.S. personnel in Iraq and Syria by Iranian-backed militia groups that began on October 17."

In a letter sent Friday to congressional leaders, President Joe Biden wrote: "The strikes were intended to establish deterrence and were conducted in a manner to limit the risk of escalation and avoid civilian casualties. I directed the strikes in order to protect and defend our personnel, to degrade and disrupt the ongoing series of attacks against the United States and our partners, and to deter Iran and Iran-backed militia groups from conducting or supporting further attacks on United States personnel and facilities."

The senior defense official told reporters that the airstrikes will have a significant impact on the ability of Iranian proxy groups to continue to attack U.S. forces. Asked what groups were targeted, the official said there are several that can have different names, but the U.S. holds Tehran responsible for funding, arming, equipping and directing the proxies. The official said the airstrikes were not designed to expand the conflict in the region, but to compel Iran to direct the militia groups to cease the attacks on American bases and personnel.

The Biden administration has not accused Iran of having a direct role in the Oct. 7 Hamas attack on Israel and has said it appears so far that Tehran was not aware of it beforehand. But the U.S. has noted that Iran has long supported Hamas and has raised concerns that Iran and its proxies could turn the conflict into a wider war.

Austin said the U.S. does not seek a broader conflict, but if Iranian proxy groups continue, the U.S. won't hesitate to take additional action to protect its forces.

According to the Pentagon, all the U.S. personnel hurt in the militant attacks received minor injuries and all returned to duty. In addition, a contractor suffered a cardiac arrest and died while seeking shelter from a possible drone attack.

The retaliatory strikes came as no surprise. Officials at the Pentagon and the White House have made it clear for the past week that the U.S. would respond, with Ryder saying again Thursday that it would be "at the time and place of our choosing."

The latest spate of strikes by the Iranian-linked groups came in the wake of a deadly explosion at a Gaza hospital, triggering protests in a number of Muslim nations. The Israeli military has relentlessly attacked Gaza in retaliation for the devastating Hamas rampage in southern Israel nearly three weeks ago, but Israel has denied responsibility for the al-Ahli hospital blast and the U.S. has said its intelligence assessment found that Tel Aviv was not to blame.

Iraq must remain committed to agreement: Senate VP Gasparri

Kuwait MP touts Italy support for Khor Abdullah accord

ROME, Italy, Oct 28, (KUNA): A Kuwaiti member of parliament on Friday commended and appreciated Italy's support for Kuwait regarding the Khor Abdullah Agreement that regulates maritime navigation in Khor Abdullah waterway.

Speaking to KUNA, MP Mohammad Al-Huwaila, who is a member of a Kuwaiti parliament delegation visiting Italy as part of a joint parliamentary friendship committee, spoke highly of the outcomes of the delegation's successful visit.

He added that the delegation's meetings with Italian members of parliament were so fruitful and positive that issues of special significance were addressed.

Al-Huwaila added that the visit had focused on several core issues, mainly Iraq's unilateral termination of the Kuwaiti-Iraqi maritime treaty which obtained parliamentary approval and was deposited with the United Nations in 2013.

He voiced gratitude to the Italian parliamentary leadership for supporting the Kuwaiti stance and international law, remarking that discussions had also covered the prime Kuwaiti and Arab cause of Palestine, including the serious occupation aggression on the Gaza Strip in a blatant breach of international humanitarian law and the international humanitarian law.

Regarding Kuwait's position on the Palestinian issue and what the Gaza Strip is being exposed to, he said that at this extremely difficult moment in the Middle East, hopefully, it will be possible to confirm the principle of a twostate solution between the Palestinians and the Israelis.

In a similar statement, Datis said that Italy and Kuwait are very close to each other, noting Kuwait's historical presence in Italy on the commercial and economic levels through the most widespread network of gas stations Q8. He commended the bonds of friend-

ship and solidarity for many years, even since the nineties when Kuwait went through one of the worst periods in its history during the Iraqi invasion, and Italy's strong support for the freedom and independence of Kuwait.

In this context, he stressed the mission of the Italian-Kuwaiti Parliamentary Friendship Group in consolidating the relationship between the legislators of the two countries, and then through these parliamentary relations, strengthen cultural and economic relations, as well as mutual solidarity in difficult times.

Datis underscored the commitment of the Parliamentary Friendship Group to support the activities of the Kuwaiti National Assembly and its movements in everything that could be useful to the Italian Parliament.

Public Works (MPW) reported that necessary measures were taken to launch the design phase of the Medical City project in Sabah Ål-Åhmad Residential City. The ministry received the technical bids for the project from the Central Agency for Public Tenders (CAPT), and a decision was issued to form a committee to study the bids. At the same time,

the technical bids are being studied. The awarding procedures will begin as soon as the budget is approved, and the project is being sponsored by the Ministry of Finance.

Memorandum

It is worth highlighting that the Council of Ministers assigned the project to the Ministry of Public Works through Resolution No. 838 issued during its meeting No. 234/2022 held on 29/08/2022. question about non-submission of old housing applications, PAHW stressed that this is due to the citizen's desire to be allocated or not.

In response to the third item of the question regarding the solutions available to PAHW to reduce the number of applicants for old housing and its continuing approach to implementing integrated housing cities, PAHW explained that it sets five-year plans for its housing projects with focus on reducing the waiting period and addressing the increasing number of housing requests. These plans are developed according to the development plan and the state's structural plan. They can reduce the number of housing applications and reduce the waiting period for citizens to obtain housing.

Implementing

PAHW has begun implementing housing cities. It is moving forward with the completion, construction, maintenance and implementation of the South Sabah Al-Ahmad City project. The procedures for signing the infrastructure contract for the South Saad Al-Abdullah City are being completed to begin implementation.

PAHW said there are sites for housing projects allocated to it, which its Board of Directors will decide to include, in light of what was stated in the latest structural plan for the State of Kuwait, which are as follows:

1. Nawaf Al-Ahmad City, which contains approximately 52,000 plots.

2. The city of Sabriya, which contains approximately 52,000 plots.

3. Khairan City, which contains approximately 45,000 plots 4. South Saad Al-Abdullah ex-

pansion, which includes approximately 3,000 plots.

PAHW affirmed that coordination is underway with the Kuwait Municipality to allocate a number of additional sites for housing projects, and in light of the issuance of law No. 118/2023 (the Housing Cities Law).

It stressed that this law contributes to the involvement of the global private sector and the entry of experienced people to contribute to accelerating the pace of completion of housing projects, reducing waiting periods, and creating job opportunities for Kuwaiti youth in those companies that are planned to be established in accordance with the law.

'Foreign party stays unharmed in random emotional boycott'

"A FEW days ago, I wrote a sentence that some people liked: "Never give a child a gun, and do not give a fool a microphone," meaning that the danger of a gun in a child's hand is equivalent to a microphone given to a fool or an incompetent person who makes decisions and demands that people do such and such," columnist Hamad Al-Hamad wrote for Al-Rai daily.

"The history of the call for a boycott is not new to us, and we know that it is official, issued by the state after studying the course of events, approved by the Parliament, and takes effect on the ground as a boycott of the Zionist entity. "However, there are random emotional boycotts issued by persons or entities

who have no capacity and do not have the right to issue them. Even though some of them have fundamental reasons, they are issued without qualification and without study

"We mention here the boycott of Danish, Swedish or other products that were issued and accepted by parties such as the Union of Cooperative Societies and not by the state, but its effect is temporary and has no effect in the future.

"A cooperative society announces that it is removing the products of such-and-such country from its shelves, and people respond to it at the time, but because it is not studied, the one harmed by the boycott decision is the local merchant who owns the goods, because he has paid for them in advance, and the merchant of the country of

origin is not harmed at the time, but if the decision was practical and thoughtful, it would have been from an official body, and its effect would take effect, for example, after a period of time and not at the moment of the event, but what happens is a boycott for a week and the local supplier is harmed. After two weeks, it is as if nothing had happened, and the products return to the shelves with full force.

"The harm of this random emotional boycott is double, as the foreign party is not harmed, but the greatest harm is to the local parties that were boycotted, and we are talking about what is happening these days in the painful events in Gaza.

"Someone grabs the microphone or the Snapchat and takes a decision to boycott such-and-such by name because he is a foreigner, and demands people are actually the same, here he has no description when he mentions the name of a specific café or restaurant, and he does not mention other cafés or restaurants. and people respond to him, especially young people.

"Rather, what is more dangerous than that is that a number of teenagers going on rounds to find out who is not implementing the decision, and even vandalize the facades and private facilities, and according to a source, if only one café closed its doors if the boycott lasted for a long time, 14,000 Arab people would lose their means of livelihood when they were laid off.

"Our boycott is only in food, restaurants, cafes, and food products, even though the countries that we will boycott produce all the products in our lives, including cars, electrical appliances, medicines, telephones, channels, and others. But when we boycott, we boycott all what is eaten, this is really a strange matter and requires study.

"Why is the boycott random and selective, even though all Western and Asian countries strongly stood by Israel? What is more dangerous than that is that billboards spread in Kuwait on the streets from an unknown party and with the approval of the state, represented by the municipality, calling for a boycott, but it has not been specified which countries to boycott.

"A tweeter mentioned that India is more a country that supported Israel, why were there no calls to boycott biryani restaurants and lay off servants and drivers from our homes or workers in our companies?

"Whoever grabbed the microphone or his position on Snapchat or Instagram and other things, and demanded a boycott of a specific product by name, does he not realize that after the end of the war or crisis, the employer or the affected company can file a complaint against him and sue him legally?

"Of course, it has the right and is supposed to do that. Such calls from unqualified people for a boycott must not go unnoticed and cause losses and reputation.

"The most dangerous thing about the state's complete silence is that most of those calling for the boycott and those who are strongly drawn towards it are young people, teenagers, children, many adults, and elected representatives whom we used to fool with reason, as if they do not realize that the security of the nation depends on God and then on treaties with the countries that many call for a boycott while their camps on our lands...that's why where are the bright minds, as if we had never gone through a harsh experience before.

"Therefore, in conclusion, we must look at our interests before drifting towards our emotions, and God is the protector.'

Also:

"We have often described the Arab world as being in a period of tumultuous and rapid change. This transformation, marked by events such as the Arab Spring a decade ago, has seen both progress and setbacks," Dr Muhammad Hussein Al-Dallal wrote for Al-Qabas daily.

"The Arab Spring ignited hope but eventually receded due to counter-revolutionary forces and a lack of effective reform initiatives. It is clear that this period of transformation in the Arab world is ongoing, and we can expect to witness further changes in terms of countries, regimes, and regional and international political dynamics.

"Previously, we believed that this turmoil and instability were limited to the Middle East region. However, it has spilled over into the international arena, with the entire world experiencing significant upheaval.

"The United States, once the global leader after the Cold War, is currently grappling with a decline in its influence and international support. It faces global criticism for its foreign policy decisions and human rights violations.

"Additionally, other major powers, including China, Russia, and India, are increasingly seeking to assert themselves on the global stage, challenging the dominance of the United States and its interests.

"Analyzing the "Al-Aqsa Flood" events in Palestine that began on October 7 requires considering the global context of transformation and instability. In the Arab world, these events are just one facet of the ongoing transformation, and it's likely that they will elevate the Palestinian issue to the forefront of global attention for an extended period.

"This upheaval will produce a range of outcomes, including changes in the internal Palestinian landscape and implications for Arab countries and international relations.

"The Zionist occupation state is expected to face internal and external crises, while Western powers may experience a decline in confidence in their secular and liberal principles and their global roles.

"These transformative and uncertain times demand vigilance and adaptability, as events and surprises continue to shape our world.

"Despite the distinctions between global, regional, and internal developments, Kuwait finds itself in a similar state of transition and political turmoil. The performance of most state institutions has suffered due to a chronic lack of reform and capable leadership within the executive branch. Disagreements and internal conflicts have further hindered effective governance.

"The absence of political experience in managing government affairs exacerbates these challenges. While occasional positive steps have been taken, they do not represent a sustained or institutionalized effort.

Therefore, Kuwait appears likely to remain in a period of unstable and unproductive transition for an indeterminate duration.

"As we approach the commencement of the National Assembly's second session, it is important to acknowledge and appreciate the positive stance of the government, parliament, and the public on the issue of Palestine. This Arab-Islamic and humanitarian position should be lauded and supported.

"It is imperative that the National Assembly and the government work together in close coordination to uphold the Palestinian cause without creating unnecessary divisions. Kuwait must demonstrate its unity in supporting the just Palestinian cause to the world."

Study eyed on special increase for govt sector workers: official

'Concept discussed with CSC, to be submitted to Cabinet'

KUWAIT CITY, Oct 28: In conjunction with the issuance of the Council of Ministers' decision regarding the regulation for Kuwaitization of government contracts, and in confirmation of what Al-Seyassah published in its issue on August 18 developing regarding an integrated program to review public sector salaries known as the "strategic alternative," the Undersecretary of the Ministry of Finance Aseel Al-Munaifi revealed a study that the ministry is currently preparing with the cooperation of the Civil Service Commission (CSC) to approve a "special increase" for workers in the government sector.

In a special press statement to Al-Seyassah, Al-Munaifi said, "The study on

the "special increase" came under the directives of His Highness the Prime Minister Sheikh Ahmed Al-Nawaf to improve the standard of living of citizens. The concept was discussed with CSC and is in its final stages, and will be submitted to the Council of Ministers soon.

The expected step is also part of a series of decisions that were recently issued in which the Ministry of Finance participated and whose financial cost was approved, including disbursing labor support for micro-activities or activities of a special nature, and continuing to disburse labor support to the patient and the patient's companions working in the private sector during overseas medical treatment trip.

aIt will also be disbursed to scholarship students from the private sector to complete their studies or training, in addition to agreeing to postpone loan installments for small and medium enterprise owners financed by the National Fund for Small and Medium Enterprises Development for a period of six months.

On a related level, Al-Munaifi reported that there are efforts being made by the Subsidies Committee with the aim of rationalizing subsidies and directing them to those who are deserving.

She explained that the study is specifically related to subsidies for diesel and kerosene, and when it is completed, it will be submitted to the Council of Ministers to issue a decision. The matter comes in the context of studying the development of non-oil revenues and rationalizing the state's general budget. Meanwhile, the Government Communication Center announced the approval of the

Council of Ministers of a draft decision for obligating public entities to include the provisions of the Kuwaitization of government contracts regulations among the contracting requirements.

Through its account on the X platform, the center said, "The step was based on a letter from the Chairman of the National Demographics Committee, the First Deputy Prime Minister and Minister of Interior Sheikh Talal Al-Khalid.

The regulation aims to create more job opportunities for national cadres to work for government contractors and gain practical experience and develop technical skills while achieving continuity, development and transition between contracts.

The benefits of the government contracts list include a wage scale starting at KD 450 per month for a recent university graduate, health insurance for the worker and his family, a social allowance (employment support), and an annual increase ranging from KD 20 for the recipient of a "Very Good" rating and KD 30 for the recipient of a "Excellent" grade, in addition to a 40-day paid annual vacation, and an annual bonus."

KUWAIT CITY, Oct 28, (KUNA): Kuwaiti Assistant Foreign Minister for Europe's Affairs Ambassador Sadeq Maarefi and Director of the Gulf and Middle East Unit at the Irish Department of Foreign Affairs Sean O Regan on Friday tackled ways of cementing bilateral relations in all fields.

During the meeting, they also addressed the regional developments, mainly Gaza, stressing that it is essential to reach a ceasefire, open humanitarian aid passages and condemn targeting civilians and breaking international and humanitarian laws, the Foreign Ministry said in a press release.

US targets Hamas' secret investment portfolio

KUWAIT CITY, Oct 28: According to the American CNN news network, the United States is intensifying its efforts in the region to target a "secret" investment portfolio for the Hamas movement amounting to one billion US dollars and generating money for the organization, which is classified as a "terrorist", according to the network's statement, reports Al-Seyassah daily.

The network explained that the global portfolio includes companies operating under the guise of legitimate businesses in Sudan, Algeria, Turkey, the United Arab Emirates and other countries.

After the Hamas attacks on October 7, American officials held an emergency meeting recently in Riyadh at the terrorist financing targeting center, which includes the United States and the Gulf Cooperation Council countries, to discuss procedural steps in this regard. This meeting was supposed to be held in November, but the attacks expedited

The US Treasury Undersecretary for Terrorism and Financial Intelligence Brian Nelson said, "After the attack, efforts have been redoubled using the Terrorist Financing Targeting Center, which was established in 2017, to pursue Hamas, Hezbollah, and other armed groups allied with Iran, including exchange of information.

The US Treasury Department imposed sanctions last week on individuals who manage assets in a secret Hamas investment portfolio whose value is likely to range between USD 400 million and USD 1 billion. The portfolio generates large amounts of revenue for Hamas.

We cannot tolerate a world in which Hamas and other terrorist organizations' fundraisers live and operate with impunity, abusing the financial system, to sustain their terror.'

Nelson urged the Gulf states to exchange more information about the parts of Hamas' financial system that are "vulnerable to disruption", and called on the member states to take the necessary measures.

On the other hand, the news network revealed that the Financial Crimes Enforcement Network of the US Treasury Department last week put in place new rules targeting Hamas' ability to use cryptocurrencies to raise money.

Undesirable consequences over resorting to govt bonds

Lack of a long-term strategy on tackling budget deficit poses significant high risks: Audit Bureau

KUWAIT CITY, Oct 28: According to a government report, the state's general budget deficit and its reliance on issuing government bonds for financing are concerning high-risk factors. The report highlights various observations and risks that directly impact both the state's general budget and the national economy. The practice of resorting to government bonds to address budget shortfalls has led to undesirable consequences, including the imposition of additional burdens on public finances when budget deficits occur as a result of budget execution, reports Al-Rai daily.

In a recently issued report, the daily has learned that the State Audit Bureau touched on the most important risks resulting from shortcomings in dealing with this issue, which can be summarized as follows - the presence of high risks resulting from not preparing a long-term strategy to deal with the expected deficits in the state's general budget; the lack of representation of the General Secretariat of the Supreme Council for Planning and Development in the Public Debt Committee to contribute to drawing up the borrowing strategy and directing it in implementing development plans and

the risks resulting from not completing the organizational structure of public debt management in a manner commensurate with the powers assigned to that department, despite the passage of nearly five years since its establishment.

The Audit Bureau provided a comprehensive analysis, highlighting critical outcomes that pose significant risks. Among these, the most prominent risk is the burden placed on the state's general reserve due to interest and expenses related to foreign bond issuances, resulting in higher costs of external borrowing compared to the returns on net general reserve assets.

Furthermore, in contracts executed with banks and companies, the Kuwait Investment Authority breached the regulations outlined in Article No. (2) of Law No. (25) of 1996, which pertains to the disclosure of commissions in state contracts.

Despite a considerable amount of time since its establishment, the organizational structure for managing public debt remains incomplete.

As part of its vision for treatment, the Audit Bureau presented a number of recommendations in this regard, which are:

1. The necessity of working to improve Kuwait's credit rating and reform the current situation by addressing all observations that have a negative impact on the national economy and the state's general budget.

3. Full coordination between the competent authorities in completing borrowing operations to implement capital projects.

4. Completing the legal legislation related to public debt in implementation of the provisions of Article No. (136) of the Kuwaiti Constitution and ensuring resort to borrowing when needed and in accordance with specific technical controls and conditions.

5. Improving revenues, rationalizing spending, and diversifying sources of income, which contributes to eliminating the deficit and achieving investment surpluses.

6. Developing the state's general reserve funds and not charging them with any expenses outside the budget. 7. The need to take the necessary steps towards completing the organizational structure for public debt management.

KUWAIT CITY. Oct 28: The Misdemeanor Court acquitted the Kuwaiti owner of a commercial company from charges of bringing workers into the country without needing them.

Representing the defendant was Lawyer Zayed Al-Suwait, who said during the court session that his client's indictment was invalid due to ignorance of the company's data.

He stressed that the elements of the crime attributed to his client were invalid, given that his company exists and carries out its work in a known location, in addition to its obligation to pay the salaries of its employees.

modesty and harming her honor. During the court session, the defense attorney Lawyer Shahad Khaled Al-Khalidi argued that the elements of the crime were absent and that the accusation leveled against her client was malicious, adding that the court had no jurisdiction to hear the dispute because the incident in question occurred outside the territorial scope of the State of Kuwait, based on article 11 of the Kuwaiti Penal Code.

She said the investigations by the incident officer confirmed that the incident was committed outside the country, and not inside it.

Mechanism to streamline disbursement of aid

KUWAIT CITY, Oct 28: In response to the recent annual report issued by the Audit Bureau, which highlighted concerns and shortcomings in the audit, examination, and review processes of the Ministry of Social Affairs for fiscal 2022/2023, Sarah Al-Dosari, the Assistant Undersecretary for Social Development Sector Affairs at the ministry, has affirmed that the automatic linkage between the ministry and various government agencies involved in aid provision has substantially reduced the improper disbursement of aid, reports Al-Jarida daily.

This mechanism has also aided in identifying cases of duplicate aid recipients, who receive assistance from multiple government agencies, allowing for immediate intervention. Al-Dosari noted that 13 government agencies have completed the automatic linkage with the ministry, with four more agencies yet to be linked. Al-Dosari explained that the ministry has seen a consistent increase in the collection of aid debts, particularly due to the routine review by the committee established to monitor the ministry's debt balances and take necessary actions for debt recovery.

Meanwhile, Israel on Saturday expanded its ground operation in Gaza, sending in tanks and infantry backed by massive strikes from the air and sea. Israel's defense minister said that "the ground shook in Gaza" and that the war against the territory's Hamas rulers entered a new stage

The bombardment, described by Gaza residents as the most intense of the war, also knocked out most communications in Gaza. This largely cut off the besieged enclave's 2.3 million people from the world, while enabling the Israeli military to control the narrative in a new stage of fighting.

The military released grainy images Saturday showing tank columns moving slowly in open areas of Gaza, many apparently near the border, and said warplanes bombed doz-ens of Hamas tunnels and underground bunkers. The underground sites are a key target in Israel's campaign to crush the territory's ruling group after its bloody incursion in

Israel three weeks ago. "We moved to the next stage in the war," Defense Minister Yoav Gallant said in remarks broadcast Saturday. "Last evening, the ground shook in Gaza. We attacked above ground and underground. ... The instructions to the forces are clear. The campaign will continue until further notice.

His comments signaled the gradual ramping up toward what is expected to evolve into an all-out ground offensive in northern Gaza.

Early in the war, Israel had already amassed hundreds of thousands of troops along the border. Until now, troops had conducted brief nightly ground incursions before returning to Israel

The Palestinian death toll in Gaza on Saturday rose to just over 7,700 people since Oct. 7, with 377 deaths reported since late Friday, according to the territory's Health Ministry. A majority of those killed have been women and minors, the ministry said.

Ministry spokesman Ashraf al-Qidra told reporters that the disruption of communications has "totally paralyzed" the health network.

Residents had no way of calling ambulances, and emergency teams were chasing the sounds of artillery barrages and airstrikes to search for people in need.

Some civilians were using their bare hands to pull injured people from the rubble and loading them into personal cars or donkey carts to rush them to the hospital. In a video posted by local media, Palestinians were sprinting down a ravaged street with a wounded man covered in the

Other residents traveled by foot or car to check on their relatives and friends. "The bombs were everywhere, the building was shaking,' said Hind al-Khudary, a journalist in central Gaza and one of a few people with cell phone service. "We can't reach anyone or contact anyone. I do not know where my family is."

Israel says its strikes target Hamas fighters and infrastructure and that the militants operate from among civilians, putting them in danger. Across Gaza, terrified civilians

were huddling in homes and shel-ters with food and water supplies running out. Electricity was knocked out by Israel in the early

stages of the war. More than 1.4 million people have fled their homes, nearly half crowd-ing into U.N. schools and shelters. Aid workers say the trickle of aid Israel has allowed to enter from Egypt the past week is a tiny fraction of what is needed. Gaza hospitals have been scrounging for fuel to run emergency generators that power incubators and other life-saving equipment.

The U.N. agency for Palestinian refugees, which runs an extensive network of shelters and schools for nearly half the displaced Gaza residents, has lost contact with most of its staff, spokeswoman Juliette Touma said Saturday. She said that coordinating aid efforts was now "extremely challenging."

The intensified air and ground campaign also raised new concerns about dozens of hostages dragged into Gaza on Oct. 7. On Saturday, hundreds of relatives of hostages gathered in a square in downtown Tel Aviv, demanding to meet with Prime Minister Benjamin Netanyahu and Defense Minister Yoav Gallat.

Some in the group demanded that Israel push for the release of all hostages before proceeding with the campaign against Hamas. Protesters wore shirts emblazoned with the faces of their missing relatives under the word "kidnapped" and the words "Bring them back."

The families "feel like they're they're left behind and no one is really caring about them," said Miki Haimovitz, a former lawmaker and spokeswoman for the group. "No one is talking to them. No one is explaining what's going on." Gallant later said he would meet

with the families Sunday.

In Cairo, Egyptian President Abdel Fattah el-Sissi said his government was working to de-escalate the conflict through its talks with the warring parties to release prisoners and hostages. He didn't provide further details.

PM warns of AI risks EU leaders reaffirm support to Ukraine

BRUSSELS, Oct 28, (Agencies): European Union (EU) leaders Friday ended their two-day summit after discussing Ukraine, migration and economy issues and also held a Euro Summit.

"The European Union will continue to provide strong financial, economic, humanitarian, military and diplomatic support to Ukraine and its people for as long as it takes," said the European Council (EU summit) in its conclusions this afternoon.

"In particular, the European Union and its Member States will continue to provide sustainable military support to Ukraine," it stressed.

On economy, the EU leaders said "in the face of increasingly complex challenges, including a chang-



ing demographic landscape and growing global competition, the European Union needs a strong economic base that ensures its long-term competitiveness and a level playing field both internally and globally."

In a separate statement, the Euro Summit said they discussed the economic and financial situation. "Our economies have shown

Zelenskyy

remarkable resilience in the face of numerous economic shocks and continue to grow, albeit with reduced momentum. Inflation remains a key concern," it noted.

The Euro Summit brings together the heads of state or government of the 20 EU countries which use euro as a common currency.

On external issues, the European Council said it "is deeply concerned about the security situation in the north of Kosovo "and strongly condemned the violent attack against Kosovo Police in September.

Advancing

The European Council underlined its continued support for advancing a sustainable and lasting peace between Armenia and Azerbaijan based on the principles of recognition of sovereignty, the inviolability of borders and territorial integrity. The European Council held a strategic discussion

The European Council held a strategic discussion on the situation in the Sahel and expressed its concern about the continuing deterioration of the security and humanitarian situation in the Sahel, aggravated by political instability.

It was a good thing Ukrainian President Volodymyr Zelenskyy had his video conference address to the European Union summit pre-slotted for the opening session.

Immediately afterward, EU leaders switched off and went to the order of the day - the Israel-Hamas war. They didn't come back to the issue of Russia's war in Ukraine again before Friday's closing day of the summit.

Sunak warns of Al risks: As authorities around the world scramble to draw up guardrails for artificial intelligence, British Prime Minister Rishi Sunak warned against moving too fast on regulating the rapidly developing technology before it's fully understood.

Sunak warned about acting too quickly even as he outlined a host of risks that AI could bring, from making it easier to build chemical or biological weapons to its use by terrorist groups to spread fear, or by criminals to carry out cyberattacks or fraud. He said AI has the potential to transform life but it should be a global priority to mitigate the risks of human extinction it could bring, similar to pandemics and nuclear war. Governments are the only ones able to keep people safe from AI's risks, and it shouldn't be left up to the tech companies developing it, he said in a speech ahead of a summit he's hosting next week on AI safety.

The Army reservist who opened fire in a bowling alley and then at a bar in Lewiston, Maine, killing 18 people, was found dead Friday from a selfinflicted gunshot, ending an intensive two-day search that had the state on edge.

Robert Card, a firearms instructor who grew up in the area, was found dead in nearby Lisbon Falls, Gov. Janet Mills said at a Friday night news conference.

"Like many people I'm breathing a sigh of relief tonight knowing that Robert Card is no longer a threat to anyone," Mills said.

April Stevens, a Lewiston resident who knew one of the victims, said she was relieved to learn that the "monster and coward" who inflicted so much pain was no longer a danger. "I'm relieved but not happy," she said. "There was too much death. Too many people were hurt. Relieved, yes, happy, no.3 Maine Department of Public Safety Commissioner Mike Sauschuck said Card was found at 7:45 p.m. near the Androscoggin River, about 8 miles (13 kilometers) southeast of where the second shooting occurred Wednesday evening. He declined to divulge the location but an official told The Associated Press the body was at a recycling center from which Card had been fired. The official was not authorized to discuss details of the investigation publicly and spoke on condition of anonymity.

2022. In Lewiston, the 37,000 residents and those in surrounding communities were told to stay in their homes as hundreds of police officers, sheriff's deputies, FBI agents and other law enforcement officials swarmed the area.

Card, 40, of Bowdoin, was a US Army reservist. Leo Madden, who said he ran Maine Recycling Corp for decades, told the AP that Card worked there for a couple of years and nothing about him stood out. Madden said he didn't remember when Card was employed or whether he was fired or quit.

Last summer, Card underwent a mental health evaluation after he began acting erratically during training, a US official told the AP. A bulletin sent to police across the country shortly after the attack said Card had been committed to a mental health facility for two weeks after "hearing voices and threats to shoot up" a military base.

Russia names new air force head: Russia has named a replacement for the former head of the country's Aerospace Forces, who was dismissed in the wake of this summer's brief rebellion against the military establishment, according to information on the Defense Ministry website.

The website on Friday showed Col. Gen. Viktor Afzalov, who reportedly had been acting head of the air force since mid-August, was given the full post. He replaces Gen. Sergei Surovikin.

The ministry's intent to make the appointment was reported last week by state news agencies.

Surovikin was believed to have had close ties with Yevgeny Prigozhin, head of the Wagner mercenary group, who mounted a rebellion in June seeking the dismissal of Defense Minister Sergei Shoigu and military chief of staff Valery Gerasimov. Prigozhin accused both of undermining Wagner forces who were key fighters in eastern Ukraine.

After the uprising disintegrated, Surovikin was not seen in public for months. Reports of his dismissal came one day before Prigozhin and several top lieutenants died in a private plane crash widely regarded as suspicious.

Surovikin had commanded Russia's forces in Ukraine from October 2022 until January, when he was replaced in that role by Gerasimov.

Belarus leader asks Orban to visit: The authoritarian president of Belarus invited Hungary's prime minister to visit his country, which has faced increasing isolation over the government's relentless crackdown on dissent and support of ally Russia's war with Ukraine.

President Alexander Lukashenko extended the invitation to Prime Minister Viktor Orban at a meeting with Hungarian Foreign Minister Peter Szijjarto, who arrived in Belarus earlier this week. Lukashenko expressed readiness "for a dialogue with European countries" and invited Orban over "to discuss serious matters."

Orban's press chief, Bertalan Havasi, said the prime minister would consider the invitation once he returns from a European Union summit in Brussels.

Belarus has come under a barrage of Western sanctions since 2020, when Lukashenko won his sixth term in an election the West and the opposition denounced as rigged.

The vote sparked an unprecedented wave of mass protests, to which Lukashenko's government and law enforcement agencies responded by arresting more than 35,000 people and violently beating thousands.

State police took Card to the Keller Army Community Hospital at West Point for evaluation, according to the official, who was not authorized to publicly discuss the information and spoke to the AP on condition of anonymity.

On Wednesday, Card attacked the bowling alley first, then went to the bar. Police were quickly sent to both locations but Card was able to escape. For the next two days authorities scoured the woods and hundreds of acres of Card's family-owned property, and sent dive teams with sonar to the bottom of the Androscoggin River.

Law enforcement officials had said they hadn't seen Card since his vehicle was left at a boat ramp Wednesday shortly after the shootings.

Hours before Card⁵s body was found, the names and pictures of the 15 men, two women and 14-year-old boy who died in the shootings were released at a news conference.

The victims of the shootings include Bob Violette, 76, a retiree who was down the Maine gunman who killed 18 people.

Biden said the shooting and anxious search for the gunman has been tragic "not just for Lewiston, Maine, but for our entire country."

The shooting spree has been devastating for the families of those killed and injured, leaving "scores of family and friends praying and experiencing trauma no one ever wants to imagine," he satd in a statement late Friday.

He praised the police for their intense search over two days,

"Numerous brave law enforcement officers have worked around the clock to find this suspect and prevent the loss of more innocent life - all while risking their own. They are the best of us," he said,

He thanked Maine Gov Mills for "her steady leadership during this time of crisis." And he said his administration "would provide everything that is needed to support the people of Maine." And he asked for congressional help.

help. "Americans should not have to live like this," he said. "I once again call on Republicans in Congress to fulfill their obligation to keep the American people safe. Until that day comes, I will continue to do everything in my power to end this gun violence epidemic. The Lewiston community - and all Americans - deserve nothing less."

Fishing boat rescues fisherman: A Canadian fishing boat rescued an American man one day after the US Coast Guard ended its search for a missing commercial fishing boat from Washington state with two people board, authorities said.

US Coast Guard Petty Officer Steve Strohmaier said the Canada-based Ocean Sunset spotted a covered life raft drifting in open ocean about 75 kilometers (46 miles) off the west coast of Vancouver Island on Thursday.

Strohmaier said the Ocean Sunset's crew found the man conscious on the raft, which was from the Evening fishing boat based in Gray's Harbor, Washington. The man was taken to shore by the Canadian Coast Guard and was reported in stable condition. His identity was not released.

The fate of the Evening and the other person aboard were unknown. Strohmaier said Coast Guard officials hoped to speak with the survivor soon to determine whether to renew the search. (AP)

SKoreans hold subdued celebrations: Halloween celebrations in South Korea were subdued on the eve of the anniversary of the harrowing party crush that killed about 160 people.

Many restaurants, bars, department stores and amusement parks are avoiding Halloween-themed events as a sign of respect for the victims. Few people clad in Halloween costumes were seen in Seoul's popular nightlife Itaewon neighborhood, the site of last year's deadly surge when a large number of revelers and others packed an alley, causing people to fall on each other like dominos.

The walls of the narrow, sloped alley in Itaewon were plastered with numerous post-it notes with condolence messages, while white flowers were placed on the ground.



Authorities have deployed thousands of police, emergency and other officials since Friday for crowd control and safety of pedestrians in Itaewon and 15 other major nightlife districts in Seoul. About 200 police officers were separately mobilized to monitor narcotics use and violent crime as well, according to Seoul police

"I offer a deep apology again by bearing the sorrow and heavy responsibility for the disaster in my heart," Seoul Mayor Oh Se-hoon

said in a statement Friday. "The way to overcome the pains and sorrow of the disaster is preventing this kind of incident from happening again.'

Bereaved families are to hold a formal memorial service on Sunday.

In January, a police special investigation team concluded that police and municipal officials failed to work out effective crowd control steps despite correctly anticipating a huge number of people in Itaewon. (AP)

Shibuya district raises alarm: Tokyo's busy shopping, business and entertainment district of Shibuya is trying hard to shoo away visitors ahead of this year's Halloween weekend.

Banners across town say no drinking and no Halloween events on the street, and town officials are cordoning off the famed statue of Hachi - an unceasingly loyal dog - behind protective walls.

"Shibuya streets are not party venues for Halloween," Shibuya Mayor Ken Hasebe said in an interview Friday with the Associated Press. "Anyone who is thinking about visiting Shibuya for Halloween, please be aware that the situation has changed this year ... security will be tighter and it won't be enjoyable."

Hasebe, a native of Shibuya, says his 91-year-old town founded by people from around Japan - prides itself as an inclusive, innovative and diverse place open to visitors, but there should be a fine balance between freedom to enjoy the public space and the residents' right to live peacefully.

"We just want to stress, as a rule of our town and morale of this country, that street drinking can cause trouble and should be avoided," Hasebe said. "It's time to reconsider partying on public streets for Halloween."

Fear that a large number of partygoers and tourists across Japan and the world following the COVID-19 pandemic could cause a disaster similar to last year's fatal crowd crush in South Korea's capital, Seoul, has been running high. (AP)

Sudden death of Li shocked many: The sudden death of China's former second-ranking leader, Li Keqiang, has shocked many people in the country, with tributes offered up to the ex-official who promised market-oriented reforms but was politically sidelined.

Li, who died early Friday of a heart attack, was China's top economic official for a decade, helping navigate the world's second-largest economy through challenges such as rising political, economic and military tensions with the United States and the COVID-19 pandemic.

WASHINGTON, Oct 28, (AP): US President Joe Biden and Chinese President Xi Jinping have agreed to meet on the sidelines of next month's Asia-Pacific Economic Cooperation summit in San Francisco, according to a US official familiar with the planning.

The two sides worked out an agreement in principle to hold a meeting during the summit as Chinese Foreign Minister Wang Yi met Friday with Secretary of State Antony Blinken and White House national security adviser Jake Sullivan, according to the official, who was not authorized to comment and spoke on the condition of anonym-

The official added that the two sides have still not worked out details on the exact day of the meeting, venue and other logistics.

The White House said in a statement following Friday's meetings that the two sides were "working toward" a Biden-Xi face-to-face on the sidelines of APEC, a forum of 21 Pacific countries

Calif governor's trip shows US-China engagement 'possible' on state level

BANGKOK, Oct 28, (AP): California Gov Gavin Newsom's trip to China, with the stated goal of working to-gether to fight climate change, resulted in a surprise meeting with leader Xi Jinping and was filled with warm words and friendliness not seen in years in the China-US relationship.

The trip was seen as one of the steps in paving the way for US President Joe Biden and Xi to meet in San Francisco in November during the Asia-Pacific Economic Cooperation summit, but it also highlighted the existing relationship that China has with California, showing that even when tensions are high between the two countries, collaboration is still possible on some levels

The reception from China "sends a very clear signal that working with California is desired and, at minicountries at the national level, and for state-level engagement.

States' involvement with China has fallen off rapidly in the past five years, as the bilateral relationship deteriorated under the Trump administration and further soured with the pandemic, according to research from Kyle Jaros, a professor of global affairs at University of Notre Dame. Yet, that engagement is what

China wants, he said, as it views U.S. states as pragmatic partners in business without having to wade into politics.

California has a steady and long working relationship with China.

Arnold Schwarzenegger, a Republican governor, started the formal relationship with China over climate cooperation a decade ago, Jaros said. His successor, the Democrat Jerry Brown, continued the re-

lationship even as the U.S. started

Thaksin's daughter named Pheu Thai head: Thailand's ruling party on Friday selected as its leader the daughter of Thaksin Shinawatra, the country's divisive former prime minister, highlighting the family's continuing influence more than two decades after Thaksin entered politics.

Paetongtarn Shinawatra, 37, who is Thaksin's youngest daughter, was voted into the position at a meeting of executives and other members at the Pheu Thai Party's Bangkok headquarters. Pheu Thai is the latest in a string of parties believed to be supported by Thaksin and serving his political interests.

The party's previous leader, Chonlanan Srikaew, resigned for breaking a pledge that Pheu Thai would not form a government with any military-aligned parties. Pheu Thai finished second in May's election, but the winning Move Forward Party failed to win enough support from conservative lawmakers to form a government, opening a path for Pheu Thai to take power by joining with former political foes.

"We will not give up the original DNA of Pheu Thai, which is bringing policies that we promise to the people to reality. We will make dreams come true. We will make the impossible become possible. We will erase all insults with our irrefutable performance," Paetongtarn told party members after the vote. (AP)

27 suspected militants arrested: Indonesian police said Saturday they arrested at least 27 suspected militants believed to have links to banned extremist groups, in a nationwide crackdown as the world's most populous Muslim-majority country gears up for elections in 2024.

The police's elite counterterrorism squad, known as Densus 88, made the arrests on Friday in the capital, Jakarta, and in West Java and Central Sulawesi provinces, said National Police spokesperson Ahmad Ramadhan.

"We are still investigating and interrogating all those arrested in search for other possible suspects," said Aswin Siregar, the spokesperson of Densus 88 told The Associated Press.

Most of the arrested are suspected of being members of a homegrown militant outfit affiliated with the Islamic State group known as Jemmaah Anshorut Daulah, or JAD, he said.

The arrests were made after the interrogation of 18 suspected militants arrested since Oct. 2, Ramadhan said.

Some local media reports said those arrested were linked to an alleged plot of militant attacks meant to disrupt the elections in February 2024, but Ramadhan quickly downplayed them. (AP)

Rebel groups launch attacks: An alliance of ethnic rebel groups on Friday launched a coordinated offensive in northeastern Myanmar to seize military targets in areas near the Chinese border, the groups and residents of the area said.

The Arakan Army, the Myanmar National Democratic Alliance Army and the Ta'ang National Liberation Army, calling themselves the Three Brotherhood Alliance, said in a joint statement that they have begun "Operation 1027" in Myanmar's Shan state. The offensive could become a new major front in the strife-torn Southeast Asian nation.

Major coordinated attacks initiated by opponents of Myanmar's military government are relatively rare, partly because the army has a great advantage in weaponry and trained manpower. (AP)



Families hunt for loved ones: Desperate families made missing posters Friday and joined online groups to look for loved ones out of touch since Hurricane Otis devastated the Mexican Pacific coast city of Acapulco.

Officials said they were moving in supplies and evacuating people from the devastated metropolis of 1 million people.

As cellphone service returned to some parts of the city, many residents had help from friends and relatives living in other parts of Mexico and in the United States.

On Thursday there were some 1,000 people in 40 chats, which grew in number through the day. Late Thursday, Guerrero state Gov Evelyn Salgado followed their lead, urging people to send messages to government WhatsApp accounts about the missing. (AP)

Bukele registers for re-election: El Salvador's President Nayib Bukele registered as his party's candidate to seek reelection in the country's presidential vote next year, a decision already raising eyebrows Friday because the constitution prohibits it.

Bukele and his running mate, current vice president Félix Ulloa, were the last to register before the deadline at midnight Thursday. In typical Bukele fashion, the last-minute registration became a spectacle, coming amid rumors the president had been hospitalized. Instead, he exited electoral offices to a crowd of cheering supporters. (AP)

Machado winner of oppn primary: Venezuelan government critic María Corina Machado was declared the winner Thursday of an opposition-organized primary to choose a presidential candidate, in polling last weekend that was denounced by the self-proclaimed socialist government as illegitimate.

The voting Sunday organized by the National Primary Commission drew more than 2.4 million voters in Venezuela and abroad and was aimed at choosing a candidate to run against President Nicolás Maduro next year.

But despite some assurances by Maduro's government that the opposition would be allowed to choose a candidate. it has cast heavy doubt on any outcome of the weekend primary. Prosecutors have opened a criminal investigation into primary organizers on charges including identity fraud and usurping authority, and on top of that the government has maintained a ban on Machado running for office. (AP)

Earlier Friday, Biden met with Wang, holding an hourlong talk with the senior Chinese official in the Roosevelt Room at the White House. The meeting, with Blinken and Sullivan present, was the latest in a series of high-level contacts between the two countries as they explore the possibility of stabilizing an increasingly tense relationship at a time of conflict in Ukraine and Israel.

The White House said Biden "emphasized that both the United States and China need to manage competition in the relationship responsibly and maintain open lines of communication," and he "underscored that the United States and China must work together to address global challenges.'

White House National Security Council spokesman John Kirby said Biden viewed his meeting with Wang as "a positive development, and a good opportunity to keep the conversation going.

Biden had been widely expected to talk with Wang, a reciprocal action after Xi met with Blinken in June.

Beijing has yet to confirm if Xi will travel to San Francisco for the annual APEC summit, which runs from Nov 11 to Nov 17.

Wang is in the midst of a three-day visit to Washington, where he's been meeting with top US officials. He sat

Analysts polled by Zacks Investment Research predicted higher earnings of \$2.36 per share, but Exxon does not adjust its reported results based on one-time events such as asset sales as most companies do.

Revenue slipped to \$90.76 billion from \$112.07 billion, but still topped Wall Street's estimate of \$89.29 billion. Production dipped 0.8% to 3,688 thousand oil-equivalent barrels per day.

Exxon said Friday that it delivered its best ever thirdquarter global refinery throughput at 4.2 million barrels per day.

"We delivered another quarter of strong operational performance, earnings and cash flows, adding nearly 80,000 net oil-equivalent barrels per day to support glob-al supply," Chairman and CEO Darren Woods said in a prepared statement. Exxon's results come just a few weeks after announc-

ing that it would acquire Pioneer Natural Resources for nearly \$60 billion. It's the company's largest buyout since acquiring Mobil two decades ago. (AP)

Prices up 0.4% from August to September

US consumer spends briskly, as inflation holds steady

WASHINGTON, Oct 28, (AP): An inflation gauge that is closely monitored by the Federal Reserve showed price increases remained elevated in September amid brisk consumer spending and strong economic growth.

Friday's report from the Commerce Department showed that prices rose 0.4% from August to September, the same as the previous month. And compared with 12 months earlier, inflation was unchanged at 3.4%.

Taken as a whole, the figures the government issued Friday show a still-surprisingly resilient consumer, willing to spend briskly enough to power the economy even in the face of persistent inflation and high interest rates. Spread across the economy, the strength of that spending is itself helping to fuel inflation.

In a cautionary note, consumers relied increasingly on savings to fuel their shopping last month. Income growth slowed. Adjusted for inflation, income actually fell slightly. Yet spending jumped 0.4%, after adjusting for inflation. The saving rate fell to 3.4%, down from the 6%-plus average before the pandemic.

"That is clearly unsustainable, and we expect spending growth will slow sharply in the quarters ahead," said Michael Pearce, lead U.S. economist at Oxford Economics, a consulting firm.

September's month-to-month price increase exceeds a pace consistent with the Fed's 2% annual inflation target, and it compounds already higher costs for such necessities as rent, food and gas. The Fed is widely expected to keep its key short-term interest rate unchanged when it meets next week. But its policymakers have flagged the risk that stronger growth could keep inflation persistently high and require further rate hikes to quell it.

Since March 2022, the central bank has raised its key rate from

near zero to roughly 5.4% in a concerted drive to tame inflation. Annual inflation, as measured by the separate and more widely followed consumer price index, has tumbled from the 9.1% peak it reached in June of last year. On Thursday, the government reported that strong consumer spending drove the economy to a robust 4.9% annual growth rate in the July-September quarter, the best such showing in nearly two years. Heavy spending by consumers typically leads businesses to charge higher prices.

New principles for strengthening global economy defined by heads of state, IMF, politicians & CEOs

RIYADH, Oct 28, (Business-wire): At the Future Investment Initiative (FII), a global summit, in Riyadh today, leading international figures including ministers from Europe, the Middle East, and an African head of state looked at new principles that can help strengthen the international economy amidst the growing volatility and disruption seen over this decade.

Mehmet Şimşek, Minister of Finance, Republic of Türkiye along with ministers from the Kingdom of Bahrain and the United Kingdom explored how to improve global trade, which declined to 1.7% in 2023 from 2.7% in the previous year.

Kristalina Georgieva, Managing Director, International Monetary Fund said, "One of the big changes happening in a world of repetitive exogenous shocks - Covid, war, cost of living crisis - is the increase in our financial strength. Even in a world of more geopolitical tensions, we are able to take decisions to make the firm stronger."

In a lunchtime special session, President Paul Kagame gave an address to delegates to highlight how his country has become a continental economic success story, but sounded a warning about what is required for the future. President Kagame said: "We hope that more Africans can work together and make the investment as ourselves we made to others. It is also about cooperation. The theme of cross-cultural collaboration was also highlighted in an afternoon session featuring French footballer, Karim Benzema of Al-Ittihad and formerly of Real Madrid, and former FIA President and UN Secretary-General's Special Envoy for Road Safety, Jean Todt. The panellists discussed how governments and institutions can harness sport's unparalleled influence to demonstrate visionary leadership, inspire citizens, and ultimately bring the world closer together.

Richard Attias, CEO of the Future Investment Initiative Institute said:

"This year, our data shows a dramatic drop in life satisfaction across the world. We surveyed 53,000 people in 23 countries and the results of our Priority Compass report make sobering reading. This data has informed many of the deliberations and conversations here at FII this week. With the world's leaders and biggest investors in the room and innovation continuing apace, it is our responsibility to humanity to act with vigour and speed."

Kuwait's credit rating was recently published by Fitch at AA- with a stable outlook. Central Bank of Kuwait (CBK) decided to raise the discount rate by 0.25% from 4.0% to 4.25% effective July 27, 2023.

He added that Kuwait's economic recovery is continuing, and inflation is under control, due to strong oil prices. Financial soundness indicators and stress tests conducted by the regulators indicate that the

banking system is robust and resilient to severe shocks. Banks are adequately financed and liquid. Non-performing loans are still sufficiently provisioned. Profitability is also improving. The economic recovery continues, but there are significant elements that need to be taken into consideration. Non-oil growth stays strong in 2023, with headline inflation falling and an expected current account surplus. Nonetheless, other factors surround the baseline economic forecast, particularly those connected with oil prices and production volatility caused by global forces.

Al-Mukhaizeem pointed out that KFH's long term credit rating stands at A by Fitch with Stable Outlook, and at A2 by Moody's with Stable outlook. In addition, KFH Group was recently named as the Best Islamic Financial Institution in the World and in the Middle East by Global Finance Magazine and received the Sustainability award in Middle east by EMEA Finance, and Best Islamic Bank for ESG by Euromoney.

He explained that KFH ranked

JPMorgan CEO selling shares of the bank

Jamie Dimon will do something he has never done before in nearly0 two decades as the head of JPMorgan Chase & Co. - sell shares in the company.

The top executive of the nation's largest bank will sell 1 mil-lion shares starting next year, according to a regulatory filing this week. JPMorgan sought to reassure investors that the stock sale is not a matter of concern. "Mr. Dimon continues to believe the company's prospects are very strong and his stake in the company will remain very significant," the filing said. Dimon and his family currently

hold about 8.6 million shares of the bank

And JPMorgan has become a titan under Dimon's leadership. Dimon became CEO of JP-Morgan in January 2006 and added on the chairman role a year later. The value of the bank,

with \$3.2 trillion in assets, has tripled during Dimon's tenure, and it now as a market capitalization of more than \$409.1 billion, according to FactSet.

The value of JPMorgan's shares have also tripled in that time and they are up another 10% in the past year. The New York bank reported

a 35% surge in profits during its most recent quarter, fueled by a rapid rise in interest rates. (AP

Russia hikes interest rate for 4th time this year

Russia's Central Bank on Friday raised its key lending rate for the fourth time in half a year in an effort to bring down surging inflation. The bank raised the rate to 15%, up 200 basis points. The interest rate in the first half of the year was 7.5%.

"Current inflationary pressures have significantly increased to a level above the Bank of Russia's expectations," the bank said in a statement. It said seasonally

adjusted price growth in the third quarter exceeded an annualized 12% and inflation for the year is expected to be about 7%. The bank said it expected inflation to

fall to about 4% in 2024. Raising interest rates is in-tended to impede inflation by increasing the cost of borrowing and encouraging savings.

"Steadily rising domestic demand is increasingly exceeding the capabilities to expand the production of goods and the provision of services. Inflation expectations remain elevated. Lending growth paces are invari-ably high," the bank said.

Sanctions imposed over Russia's military operation in Ukraine and increased defense spending have taken a toll on the Russian economy, notably on the ruble's exchange value, which has dropped about 25% against the US dollar this year. (AP)

Interest rates left unchanged for first time in over a year

ECB halts rate hikes as Mideast conflict spreads gloom

FRANKFURT, Germany, Oct 28, (AP): The European Central Bank left interest rates unchanged Thursday for the first time in over a year as the Israel-Hamas war spreads even more gloom over already downbeat prospects for Europe's economy.

It is the bank's first meeting with no change after a torrid pace of 10 straight increases dating to July 2022 that pushed its key rate to a record-high 4%. The ECB joins the U.S. Federal Reserve, Bank of England and others in holding borrowing costs steady - albeit at the highest levels in years - as inflation has fallen

ECB President Christine Lagarde pointed to a "broad based" decline in inflation to 4.3% in September, with fuel costs dropping and spikes in food prices easing. She reiterated that high rates would help drive back inflation to the bank's goal of 2% if "maintained for a sufficiently long duration."

She would not say how long that might take but told reporters in Athens, where the bank held one of its regular meetings away from its Frankfurt headquarters, that "even having a discussion on cuts is totally, totally premature."

Lagarde also did not rule out further rate increases, depending on how the fight against inflation progresses, saying, "I am not going to pass a judgment to say we are at peak.

The ECB's "message seems clear," Holger Schmieding, chief economist at Berenberg bank, said in an analyst note. "In the absence of any major surprise, rates will stay at their current levels for the foreseeable future.

Inflation peaked at a painful 10.6% in October for the 20 countries that use the euro currency as Russia's war in Ukraine took a toll. Those high prices have been poison for consumer spending, draining household finances with added costs for necessities such as food, heat and electricity.

Growth

With inflation down considerably, worries now are sharpening about weakening economic growth and even the risk of a recession. Rate hikes are a central bank's chief weapon against inflation, but they can weigh on economc growth by raising the cost of credit for consumer purchases, particularly homes, and for companies to buy new equipment and facilities.

Lagarde noted that the economy was expected to stay weak through the end of the year, while the wars in Ukraine and the Middle East could create uncertainty about the future and further hurt economic growth in Europe.

Surveys of purchasing managers by S&P Global indicate that economic activity fell in October. Analysts at ABN Amro bank foresee a 0.1% drop in economic output in the eurozone for the July-to-September quarter and minus 0.2% for the last three months of the year. The EU will publish third-quarter figures on Tuesday.

Inflation's impact on consumers was a big reason why Europe has seen almost no growth this year, recording zero in the first quarter and 0.2% in the second. Its biggest economy, Germany, is forecast by the International Monetary Fund to shrink by 0.5% this year, making it the world's worst performing major economy. Even Russia is expected to grow this year, the IMF says.

And there's little prospect of improvement for Europe this year.

The war in the Middle East has threatened to raise oil prices, though there hasn't been a major spike or an interruption in supplies so far. But the conflict adds uncertainty because Europe is heavily dependent on imported energy, which could be affected if the Israel-Hamas war widens to include Iran or its proxy fighters in Arab countries.

"The ECB has never been more worried about the growth outlook," said Carsten Brzeski, global head of macro at ING bank. The bank also seems "relatively relaxed about potential new inflation waves stemming from oil prices."

As a result, he said he expects Thursday's rate pause "to eventually be seen as the end of the hiking cycle."

X struggles with misinformation, advertising and decline in usage

X looks and feels something like Twitter, but the more time you spend on it the clearer it becomes that it's merely an approximation. Musk has dismantled core features of what made Twitter, Twitter - its name and blue bird logo, its verification system, its Trust and Safety adviTwitter takeover: One year on



FTX founder denies fraud

Bankman-Fried acknowledges in court that customers were 'hurt'

NEW YORK, Oct 28, (AP): Sam Bankman-Fried, testifying at his fraud trial Friday, cast himself as a bumbling cryptocurrency visionary who knew nothing about the industry when he started FTX or about marketing when he became the face of his company and not enough about his businesses to see they were \$10 billion in the hole until shortly before they collapsed.

In Manhattan federal court, the onetime cryptocurrency golden boy denied defrauding anyone. Bankman-Fried, 31, acknowledged

some failures, saying he made mistakes, large and small, but he also contested testimony by four former top executives who blamed him for the collapse of his businesses last year when a rush of customers withdrew their money, exposing that billions of dollars were missing.

"We thought that we might be able to build the best product on the market" and move the crypto ecosystem forward, he said.

"It turned out basically the opposite of that. A lot of people got hurt - customers, employees - and the company ended up in bankruptcy," Bankman-Fried said.

Asked by his lawyer, Mark Cohen, if he defrauded anyone or took cus-Bankman-Fried tomers funds, answered, "No I did not." Mostly unemotional on the witness stand, Bankman-Fried, who could face decades in prison if he is convicted of all charges, said: "I don't tend to show a lot of freakoutness.' As the day wore on, testimony focused on what happened as Bankman-Fried's businesses sank deeper in debt, even as he spent hundreds of millions of dollars on marketing that included a 2022 Super Bowl commercial featuring comedian Larry David, a partnership with quarterback Tom Brady and a firm that linked him to celebrities. Bankman-Fried said he was "very surprised" when he learned in October 2022 that Alameda had an \$8 billion debt that he didn't know about, which meant the company's total debt was roughly \$10 billion. Cohen said he expected to finish questioning his client on Monday. A prosecutor said cross-examination would last into Tuesday. The jury was unlikely to get the case until late next week at the earliest. The California entrepreneur has pleaded not guilty to conspiracy charges accusing him of diverting billions of dollars from clients and investors to make risky investments, buy luxury housing, engage in a star-studded publicity campaign, and make large political and charitable donations. His testimony became the centerpiece of a defense that has tried to convey that Bankman-Fried had no criminal intent in actions prosecutors say were directly to blame for the collapse last November of businesses Bankman-Fried began creating in 2017 and eventually ran from the Bahamas. Bankman-Fried told the jury that when he started his first company, Alameda Research, he knew "basically nothing. "I knew that a bitcoin was digital," he said.

introverted naturally," but explained that he accidentally became the face of FTX when several interviews "ended up going better than I thought they would.

He said he testified three times before Congress to persuade legislators to create cryptocurrency regulations that would allow products to be marketed directly to Americans.

As requests for interviews became overwhelming, "It was too late to find a new public face for the company. I was the public face," he said.

"I had absolutely no background in marketing. Absolutely no idea," he said.

His lawyer showed jurors a picture of Bankman-Fried with singer Katy Perry, actress Kate Hudson and others at the 2022 Super Bowl in Los Angeles while his client explained that he went to the game because he "thought maybe it would be interesting" and then ended up in the box with celebrities when they saw him and "invited" him in.

Most of Bankman-Fried's testimony focused on the explosive growth and collapse of FTX, a cryptocurrency exchange, and Alameda, but Cohen occasionally strayed into asking about his client's personal life and quirks, including his penchant for wearing casual clothing and letting his hair grow. Bankman-Fried blamed himself for the breakdown of his on-off romantic relationship with Caroline Ellison, Alameda's chief executive, saying "I didn't have the time or the energy to put in what I think she wanted from a relationship." "It's not something I've been great at, being able to sustain a romantic relationship for a long period," he said. Still, he cast Ellison as a villain in his company's collapse, saying she failed to follow his instructions for over a year to create a hedge to protect Alameda. He said he considered shutting down the company at one point because "there might not be the right management in place for Alameda to justify its risk going forward." When the jury was shown a photograph of Bankman-Fried with a deck of cards, he explained that he used them to satisfy his urge to "compulsively fidget with things" - a habit from his college years that grew so severe that he said he'd wear out a deck in a week. He has since switched to fidget spinners. Bankman-Fried, wearing a suit and tie in court and short hair, said he frequently wore shorts and T-shirts because he found them comfortable. As for the scattered long hair he had until weeks ago, he said: "I was busy and lazy and didn't bother getting haircuts for long periods of time.' Before Bankman-Fried testified Friday, Judge Lewis A. Kaplan mostly shut down his lawyers' plans to show Bankman-Fried made many decisions about his businesses in consultation with lawyers, saying evidence of that would falsely imply that lawyers with full knowledge of all facts "blessed what the defendant is alleged to have done.

He also fired, laid off or lost the majority of its workforce - engineers who keep the site running, moderators who keep it from being overrun with hate, executives in charge of making rules and enforcing them.

The result, long-term Twitter watchers say, has been the end of the platform's role as an imperfect but useful place to find out what's going on in the world. What X will become, and whether Musk can achieve his ambition of turning it into an "everything app" that everyone uses, remains as unclear as it was a year ago.

"Musk hasn't managed to make a single meaningful improvement to the platform and is no closer to his vision of an 'everything app,' than he was a year ago," said Insider Intelligence analyst Jasmine Enberg. "Instead, X has driven away users, advertisers, and now it has lost its primary value proposition in the social media world: Being a central hub for news.'

Experience

As one of the platform's most popular and prolific users even before he bought the company, Musk had a unique experience on Twitter that is markedly different from how regular users experience it. But many of the changes he's introduced to X has been based on his own impressions of the site - in fact, he even polled his millions of followers for advice on how to run it (they said he should step down).

"Musk's treatment of the platform as a technology company that he could remake in his vision rather than a social network fueled by people and ad dollars has been the single largest cause of the demise of Twitter," Enberg said.

The blue checkmarks that once signified that the person or institution behind an account was who they said they are - a celebrity, athlete, journalist from global or local publication, a nonprofit agency - now merely shows that someone pays \$8 a month for a subscription service that boosts their posts above un-checked users. It's these paying accounts that have been found to spread misinformation on the platform that is often amplified by its algorithms.

On Thursday, for instance, a new report from the left-leaning nonprofit Media Matters found that numerous blue-checked X accounts with tens of thousands of followers

Higher fuel costs could spell pricier fares Airlines expect heavier drag on profit growth

NEW YORK, Oct 28, (AP): Major airlines expect fuel costs to keep rising through the end of the year, putting a dent in profits for an industry that has seen earnings growth in 2023

United Airlines, Delta and American have all seen fuel costs rise since the beginning of the year along with commodity prices for oil. Strong demand has so far helped profits grow each quarter. But all three airlines are forecasting yet another increase in costs during the current quarter and warning that it could hurt their bottom lines.

The higher fuel costs could potentially lead to pricier fares for travelers at a time when high inflation is still squeezing consumers. Airlines are also worried about travel demand slumping because of global conflicts, particularly the war in Gaza. The U.S. has issued a global advisory for citizens overseas because of rising tensions and the potential for violence.

Fuel prices and the war's impact

claimed that the mass shooting in Maine was a "false flag," planned by the government. Musk took the company private, so its books are no longer public - but in July, the Tesla CEO said

"However, I fully expect the market will adjust to higher costs as it has his-torically and re-establish equilibrium," he said.

Overall, the sector has been reporting earnings growth throughout 2023 while the broader S&P 500 contracted. Now, Wall Street expects the airline

the company had lost about half of its advertising revenue and continues to face a large debt load.

"We're still negative cash flow," he posted on the site on July 14, due to about a "50% drop in advertising revenue plus heavy debt load."

"Need to reach positive cash flow before we have the luxury of anything else," he said.

In May, Musk hired Linda Yaccarino, a former NBC executive with deep ties to the advertising industry in an attempt to lure back top brands, but the effort has been slow to pay off. While some advertisers have returned to X, they are not spending as much as they did in the past - despite a rebound in the online advertising market that boosted the most recent quarterly profits for Facebook parent company, Meta, and Google parent company, Alphabet.

Insider Intelligence estimates that X will bring in \$1.89 billion in advertising revenue this year, down 54% from 2022. The last time its ad revindustry to lag with shrinking earnings in the fourth quarter, while the broader S&P 500 notches a quarter of growth.

"Even though the cultural relevance of Twitter was already starting to decline," before Musk took it over, "it's as if the platform no longer exists. And it's been a death by a thousand cuts," Enberg said.

"What's really fascinating is that almost all of the wounds have been self-inflicted. Usually when a social platform, starts to lose its relevance there are at least some external factors at play, but that's not the case here.

Albinism pageant winner says event instilled beauty and purpose

HARARE, Zimbabwe, Oct 28, (AP): A glittering crown on her head and a bouquet of flowers in her hands, Andreia Solange Sicato Muhitu beamed at being named the co-winner of the the inaugural Mr. and Miss Albinism Southern Africa pageant. The 28-year-old Angolan model has competed in beauty pageants

in her home country since her teens and won some of them. But none made her feel more beautiful or purposeful as the pageant for people with albinism that was held this month in Zimbabwe's capital, Harare. "I can be that inspiration for young girls, especially those with albinism, to feel comfortable and beautiful in their own skin," Muhitu said.

"That is the strong message we are hoping to send out there. Albinism, an inherited genetic condition that reduces melanin pig ment production, is "still profoundly misunderstood," according to the UN human rights agency. People with the condition have pale-colored skin, hair and eyes, are vulnerable to sun exposure and bright light, and often have eyesight problems and are prone to developing skin cancer. Although traditional beauty pageants have come under criticism for objectifying women's bodies, Muhitu thinks the Oct. 14 event where she was crowned could bring about positive change in parts of Africa where people with albinism are treated with disdain, ridicule and even violence driven by dangerously misguided superstitions.

"This crown gives me the opportunity to change the lives of people living with albinism in ways I never imagined, not just in my country, but in the entire region. I don't feel shamed, I feel empowered," she said, shaking hands with people eager to congratulate her

The superstitions include the belief that having sex with a person with albinism can cure HIV or that their skin, hair, feet, hands, eyes,

genitals or breasts have supernatural powers to bring good luck or boost the effectiveness of witchcraft potions, according to the UN and rights activists. In Malawi and Tanzania, people with the condition are sometimes killed for their body parts.

They typically face daily prejudice despite anti-discrimination laws. She and other pageant participants talked about rejection by families and fathers who denied paternity once they realized a child had albinism

The contestants also highlighted how they need affordable skincare services and cancer treatment but more often receive hate, mocking or insults

Dreams

Muhitu, who works as head of the tourism department in southeastern Angola's Cuando Cubango province, said ridicule at school almost derailed her dreams, but celebrating her skin color is helping her and others push back against stereotypes and stigma.

"The progressive laws on paper and the ugly reality on the ground are miles apart," Muhitu said, adding: "It is time for soft power. We can change mindsets through modeling contests, storytelling, music and any outlets that are interesting. Art forms can be a powerful tool to change mindsets.'

Albinism is more common in sub-Saharan Africa, where it affects about 1 in 5,000 people. The prevalence can reach 1 in 1,000 in some populations in Zimbabwe and in other ethnic groups in southern Af-rica, compared to 1 in every 17,000 to 20,000 in North America and Europe, according to the UN Office of the High Commissioner for Hu-

man Rights.

The 18 contestants who participated in the regional pageant in Zimbabwe came from countries that also included South Africa, Zambia, Mozambique, Malawi, Angola and Tanzania. They included fashion designers, health workers and professional models.

Waving their national flags, they entertained a small audience with poetry, song and dance performances. They elegantly cat-walked in professional wear, evening gowns and African animal skin outfits before answering questions from a panel of judges on a variety of social and economic topics.

Held under the theme, "Into the light," the pageant was aimed at shining a spotlight on the "boundless talents" of people with albinism in a region where they often face harsh treatment and stigma, event organizer Brenda Mudzimu, who also has albinism, said.

"We are mentally and physically tortured, yet we are no different from any other person except skin color," said Mudzimu, whose Miss Albinism Trust founded the event as a local Zimbabwean contest in

The contestants were judged for their charisma, confidence, poise, quality of walk and intellect. The Mr. Albinism Southern Africa title was claimed by Zimbabwean Ntandoyenkosi Mnkandla, 26, a trainee paralegal.

Winners also received cash prizes, trophies, medals and flowers for categories such as Miss Personality and the People's Choice awards.

Muhitu, who received \$250 for winning the Miss Albinism prize, commended the growing number of events that celebrate people with albinism in Africa.

He voiced Scorpion on the 1990s' "Spider-Man: The Animated Series" and had small parts in 1994's "The Flintstones," the Arnold Schwarzenegger comedy "Jingle All the Way" and "Scary Movie 2.'

The towering actor - he was 6-feet 8-inches tall - did not join the reboot of "Night Court" starring Larroquette. The original "Night Court" finale ended with his character being abducted by aliens who needed someone tall to reach the things on their highest shelves.

A gripping opioid drama in 'Pain Hustlers'

LOS ANGELES, Oct 28, (AP): The wife of a man who nearly died of an opioid overdose comes bursting into the office of the sleazy doctor who prescribed it, wrongly, in exchange for personal gain. She slugs the doctor, in her agony.

The scene comes deep into the new Netflix film "Pain Hustlers," and it feels bracingly real and tragic.

If only the rest of the movie, the latest in a string of opioid-themed films, felt the same. Instead, despite a high-powered cast featuring a reliably solid Emily Blunt, an expertly low-life Chris Évans and the gifted Catherine O'Hara, the film tries too hard to be something it isn't, or shouldn't be: slick and breezy and too clever for its own good, filled with mockumentary interviews, wild montages, and other tricks used to more disciplined effect in more accomplished films.

Not that Blunt isn't an effective presence here as Liza Drake, a struggling, single Florida mom who works at a strip club but wants to move up in life - to be treated with respect, and to support her ailing teen daughter and her flighty mother. Indeed, Blunt carries the film with her intelligent and likable presence.

But that speaks precisely to the other big problem with the film, which is directed by "Harry Potter" vet David Yates and inspired by the article and book by Evan Hughes, telling the real-life tale of an opioid startup that intentionally mis-marketed a fentanyl spray meant for severe cancer pain. Here, the bare bones are the same, but Yates and screenwriter Wells Tower invent their own corrupt company and their own characters.

And the filmmakers seem determined to make their protagonist likable. In giving Liza a fairly ironclad excuse for her actions - her sweet, plucky daughter needs costly brain surgery - they take an easy way out. Not to mention that through most of the film, Liza believes (unbelievably, really, given her smarts) that she's merely helping patients get the right drug. Wouldn't it have been more interesting to see Blunt play a character who knew exactly what she was doing?

Instead, Liza claims at the start, looking back: "I did it for the right reasons." And here's sales rep Pete, her unscrupulous colleague: "This was 2011. Strictly speaking, we were not part of the opioid crisis." Evans, leaning into the sleaze, is fun to watch throughout, though the filmmakers care oddly little about his backstory.

Then there's Jackie, Liza's mom, wacky but also steely, and, in the hands of a wonderful comic actor like O'Hara, vivid in everything she does. Lest you think Mom doesn't approve of Liza's slippery new career, heck, she joins her at the company, and even makes moves on the boss but we're getting ahead of ourselves.

Environment

When we first meet Liza, she's living in her sister's garage. At the strip club, she meets Pete, who, mid-flirtation, suggests she come work for him, promising \$100k in commissions in one year.

Liza's daughter, Phoebe (Chloe Coleman, in a lovely performance) gets in trouble at high school, engaging in what one might call, um, arson. We also learn she suffers from epilepsy. She requires a stable environment, the doctor says. And then Liza and daughter get kicked out of the garage and move into a cheap motel, eating instant noodles. Liza reconsiders that job offer.

Outfitted with a fake resume - Pete, with a quick edit, gives her a biochem degree - Liza gets hired by Zanna, the company run by eccentric billionaire doctor Jack Neel (Andy Garcia, efficiently creepy) and proves a quick study. Against all odds, she finds a doctor (Brian D'Arcy James, playing against type as a sleazeball pain doc in need of a hair transplant) to write a prescription for Lonafen, a sublingual fentanyl spray. Soon she's corralled him into a "speakers program" designed to bribe more doctors.

Moving quickly from sundresses to colorblocked power ensembles, Liza starts raking in commissions, and she and Pete hire a team of hungry salespeople. Pete likens what they're doing to driving a few miles over the speed limit - technically illegal, but everybody does it. Meanwhile, Liza's suddenly able to afford a condo fit for a king, buy Mom a car, and enroll Phoebe in private school.

Zanna, named for Neel's own late wife, goes public, and is the industry's new kid on the block. The company's celebratory slogan, shouted at decadent parties: "We Own Cancer!"

But things start getting uncomfortable. Neel, increasingly paranoid, rejects Liza's proposed compliance plan. Then, he decides the best way to improve flat sales is to market Lonafen off-label for any kind of pain, even headaches.

Liza is aghast - Pete, not so much - but her daughter's condition worsens, and Medicaid won't cover the operation. She needs cash. Then, patients start overdosing. The look one man's widow gives a weeping Liza, wordless, is chilling.

The pace picks up as the law starts bearing down. But ultimately, "Pain Hustlers" feels like a retreading of the same ground covered in other recent works, bringing nothing especially new to the table and, in splitting the stylistic difference between slick/breezy and poignant/authentic, succeeding fully at neither.

"Pain Hustlers," a Netflix release that begins streaming Friday, has been rated R by the Motion Picture Association "for language throughout, some sexual content, nudity and drug use." Running time: 122 minutes. Two stars out of four.

Debut act Miami duo return to their country roots

MIAMI, Oct 28, (AP): Growing up in Miami in the '80s and '90s, Leo Brooks had a secret love that he always was afraid to share with his friends: He was a country music fan.

While hanging out with his friends in high school, Brooks listened to rap, hip hop, alternative rock and other popular music, but at home with his family, he listened to country. Now Brooks is returning to Miami as half of the country duo Neon Union. They are slated to perform at the Country Bay Music Festival scheduled for Nov. 11-12 at the historic Miami Marine Stadium, just southeast of downtown on Virginia Key in Biscayne Bay.

The headliners scheduled for the event are Thomas Rhett, Sam Hunt, Chris Young, Lee Brice and Lainey Wilson. Other performers include Randy Houser, Chris Lane, LOCASH, Elle King, Restless Road, Blanco Brown, Josh Ross, Hailey Whitters, David J. and Kat & Alex. "This is a big thing for me," Brooks said. "I never

would have thought that I would be performing at a country festival as an artist in Miami, being from Miami. I'm going to feel like I'm floating when I perform that day for sure."

Brooks said he never really thought about being anything other than a musician, but it took a while to start his country career. Growing up with country music allowed Brooks to lock into the feel of it, but he can't ignore the Latin influence of his Miami upbringing, he said.

"That gives it a little flavor in our sound for sure," Brooks said.

Miami already is considered a hub for Latin, hip hop and electronic music, but Country Bay organizer Nelson Albareda, the CEO of Loud and Live, said South Florida has no shortage of country fans.

More than a third of all country music fans in the U.S. identified as people of Latin descent and Miami's reputation as a cultural melting pot, as well as an entertainment capital, encouraged promoters to bring a massive country music event to South Florida, Albareda said.

"We believe that this could become a destination festival, where people come for Miami and country music," Albareda said. "And we're seeing that in our tickets sales. We are selling an equal amount of tickets in South Florida as we are outside of South Florida.

Albareda said his company began testing the Country Bay concept in 2017, though plans were delayed by the COVID-19 pandemic in 2020. Back on track, Loud and Live is already working on the lineup of performers for next year and Albareda hopes the festival can become a permanent, annual event.

Country Bay is scheduled to be held at the Miami Marine Stadium, taking advantage of the view across Biscayne Bay toward Miami's skyline. City officials and historic preservationists have worked to restore and renovate the structure. and Albareda said his company wants to support those efforts.

"We have a long-term commitment to Country Bay as a festival, and we have a long-term commitment to Miami." Albareda said.

Besides hosting one of the largest country events in Miami's music history, the Country Bay Music Festival will include a country-themed bar, games, food, line dancing, a mechanical bull and a giant Ferris wheel. The festival also has been selling anchorage access passes enabling fans to attend the event by boat or yacht. Organizers expect as many as 20,000 people.

Virginia Key, the site of Miami Marine Stadium. is a small barrier island in Biscayne Bay linked to the mainland by a single causeway.

The limited access created transportation problems for the Ultra Music Festival when the electronic music event temporarily moved from Bayfront Park in downtown Miami to the Miami Marine Stadium in 2019.

MEMPHIS, Tenn.: A judge removed himself from the Young Dolph murder case Friday after he was ordered to do so by a Tennessee appeals court, which questioned whether he could be impartial to a man charged with killing the rapper two years ago.

Shelby County Criminal Court Judge Lee Coffee asked the court clerk to assign a new judge in the high-profile case. The Tennessee Court of Appeals issued its order Sept. 28 after Coffee refused to step down at the request of the lawyer for Justin Johnson, who is charged with two other men in the fatal shooting of Young Dolph in November 2021.

The lawyer, Luke Evans, had argued that Coffee could not be impartial after the judge failed to inform him about an order limiting Johnson's ability to communicate with people outside the jail other than Evans.

Johnson and Cornelius Smith have pleaded not guilty in the killing of Young Dolph, whose real name was Adolph Thornton Jr. The rapper, producer and independent music label owner was gunned down in a daylight ambush at a Memphis bakery, where he was buying cookies while back in is hometown to visit a sick relative and hand out Thanksgiving turkeys. MAYVILLE, N.Y.: Author Salman Rushdie could take the stand against the man charged with repeatedly stabbing him before a lecture when the defendant goes on trial early next year, a prosecutor said Friday. "He is on the people's witness list

right now heading into trial," Chautauqua County District Attorney Jason Schmidt said, following a court hearing in which the judge scheduled the trial for Jan. 8.

Hadi Matar, 25, has pleaded not guilty to charges of assault and attempted murder. Authorities said the New Jersey resident left the audience and rushed the stage where the "The Satanic Verses" author was about to speak in August 2022, stabbing him more than a dozen times before onlookers intervened.

Rushdie, 76, who was left blinded in his right eye and with a damaged left hand, wrote about the attack in a memoir: "Knife: Meditations After an Attempted Murder," due out April 16.

WASHINGTON: The National Zoo's three

celebrity giant pandas will be heading home a little earlier than expected. Zoo officials told The Associated Press on Thursday that adult bears Mei Xiang and Tian Tian and their cub Xiao Qi Ji will be returning to China sometime in mid-November.

The zoo's exchange agreement with the Chinese government, originally brokered by President Richard Nixon 50 years ago, expires Dec. 7. Ongoing negotiations to extend the agreement haven't produced results, amid speculation from Chinawatchers that **Beijing** is gradually pulling its pandas from Western nations due to deteriorating diplomatic relations with the US and other countries.

Panda-philes around the country had circled the December date as the last chance to view the iconic bears. But the zoo, for undisclosed reasons, said the departure would happen about three weeks earlier.

"Discussions with our Chinese partner. the China Wildlife Conservation Association, to develop a future giant panda program will likely start after the current pandas have returned to China," zoo spokesperson Annalisa Meyer said in an email. "After 51 years of success, we remain committed to giant panda conservation. ... It's our intention to have giant pandas at the Zoo again and continue our research here and conservation work in China." (AP)

Kuwait ranks first in Arab world for overweight, obese population

Stomach botox is new cutting-edge obesity therapy: Dr Al-Hashash

KUWAIT CITY, Oct 28: According to a consultant in internal medicine and gastroenterologist Dr. Wafaa Al-Hashash, Kuwait is considered the first in the Arab world for the highest number of overweight and obese people with a rate of 77 percent overweight and 40 percent obese.

In an exclusive interview with Al-Seyassah daily, she affirmed that obesity is the fifth risk factor causing death in Kuwait.

Dr. Al-Hashash praised the techniques for treating obesity and weight gain in Kuwait and around the world, stressing that "Stomach Botox" is considered one of the latest obesity treatments, and is suitable for overweight patients with a body mass between 27 and 40.

At the beginning of the inter-view, Dr. Al-Hashash highlighted the dangers of obesity by saying, "There is no doubt that obesity rates around the world have increased significantly. In Kuwait, obesity is considered the fifth major risk factor for deaths. Reducing its rate is necessary for treatment and prevention of its diseases. It is no secret that the rate of obesity is more widespread among adolescents and children, and constitutes a warning bell for the next generation.

The prevalence of overweight and obesity is widespread among the Kuwaiti population in the age group between 18 and 29 years. Kuwait ranks first in the Arab world in terms of obesity and overweight, with a rate of 77 percent overweight and 40 percent of the population.

The risk of obesity in general lies in the diseases and symptoms that accompany it, the most important of which are general fatigue, shortness of breath, difficulty in sleeping, snoring, joint and spine pain, and esophageal reflux, as well as early puberty in girls, irregular menstruation in girls, and delayed puberty in boys.

Diseases

When asked "You recently mentioned that Stomach Botox is the latest technology in treating obesity. What do you mean by Stom-ach Botox?", she replied, "It is a non-surgical procedure, performed through gastroscopy. It helps accelerate weight loss by using Botox injections into the stomach to relax its muscles. This temporarily reduces muscle contractions in the stomach, in addition to helping the patient feel full for a longer period than usual to reduce food intake.

The effect of Botox lasts from five to six months, and the injections can be repeated after six months. Botox injections are considered a new revolution in the world of weight loss and obesity treatment. It is a non-surgical procedure that helps people who are overweight or obese and have exhausted all attempts without any success.' When asked if Stomach Botox is suitable for all patients, or if there are exceptions, Dr. Al-Hashash replied, "Stomach Botox is not suitable for all patients. People who suffer from significant weight gain are not eligible for this procedure. This technique is suitable for patients who are overweight and obese, with a body mass index

(BMI) between 27 and 40, who suffer from poor appetite control, and who have had previous at-tempts to follow a healthy lifestyle without benefit.

Botox is also not suitable for pregnant or breastfeeding women, children younger than 18 years, or people who suffer from an allergy to Botox.

It is suitable for people who have undergone gastric sleeve surgery and gained weight after the operation, people who suffer from binge eating and addiction, and people who suffer from health problems as a result of obesity, such as high blood pressure or pain in the joints, bones, and spine.

When asked if Botox treatment is safe, and if there are any side effects associated with it, Dr. Al-Hashash said, "Stomach Botox is a global treatment, and was recognized in Kuwait recently. It is approved in many countries of the world, such as America and Europe, and some Arab countries as well such as Egypt and Jordan.

Injection

It is a safe treatment and does not cause any health problems for patients in general and there are no cracks or external wounds as a result of the injection.

As for the side effects of Botox injections, they are actually what we need for stomach injections, meaning that they cause indigestion for the patient when he starts eating, and this is what we need to lose weight.

The patient begins to gradually reduce the amount of food and then lose weight, and the symptoms continue for two weeks.

It must be noted that Botox injections do not increase fat burning, but rather help the person feel full. The effect of Botox is temporary and can be restored after six months. It is necessary to follow up with a nutritionist, exercise, and

follow a diet after the injection." When asked "What is the injection mechanism?", Dr. Al-Hashash said, "Botox is injected through a gastroscope. The patient undergoes the injection after fasting for at least 12 hours to ensure that the stomach is empty of food.

The doctor then injects certain amounts of Botox into the muscles in the stomach wall, which are the places that send signals of satiety and fullness, after which the person begins to feel full for a long time.

The duration of the injection takes between 10 to 15 minutes, and does not require complete anesthesia, but only local anesthesia. The patient does not need to stay in the hospital, and the results of the injection do not appear immediately after the operation, but rather it takes between two to three weeks for the results to appear."

Wembanyama posts 21 points, 12 rebounds as Spurs knock off Rockets

SAN ANTONIO, Oct 28, (AP): Victor Wembanyama made the tying basket with 20 seconds left in regulation, the opening basket in overtime and finished with 21 points and 12 rebounds in his first NBA victory, helping the San Antonio Spurs beat the Houston Rockets 126-122 on Friday night.

Wembanyama had 16 points, eight rebounds and three blocks in the second half and overtime.

Devin Vassell scored 25 points and Keldon Johnson added 20 for the Spurs, who lost to Dallas on Wednesday in Wembanyama's highly anticipated debut and trailed late in this one before the No. 1 pick helped them pull it out.

Wembanyama's layup while de-fended by Jabari Smith Jr. made it 111-111 all and his jumper sent San Antonio to a 6-0 run to begin OT.

Houston center Alperen Sengun scored 25 points, Fred VanVleet added 24 and Jalen Green had 22. The Rockets have dropped their first two games of the season

In Boston, Derrick White had 28 points, including five 3-pointers, and Boston rallied to beat Miami in a rematch of last season's Eastern Conference finals.

England finish 3rd at World Cup after holding out hard-charging Argentina

PARIS, Oct 28, (AP): England finished third at the Rugby World Cup for the first time by stopping waves of late Argentina attacks and prevailing 26-23 in their tense playoff.

The Pumas brought the game alive by rallying from 13-0 down to lead by one point straight after halftime. England hit straight back and just stayed in front enough thanks to the boot of captain Owen Farrell, who was mercilessly booed all night.

In the last five minutes, the Pumas missed a penalty to tie the score and England replacement George Ford pulled off a try-saving tackle on wing Mateo Carreras.

Curry was superb in a week when he and his family were abused online for complaining he was the subject of a racial slur from South Africa during the semifinals last weekend. Underhill. an emergency replacement playing his first test in more than a year, finished with a game-best 24 tackles. "Surreal," was how he summed up his last three weeks.

Marcus Smith sent No. 8 Ben Earl through a gap and soft defense for the opening try. Farrell's conversion and two penalties sent England ahead 13-0.

Argentina thought they were playing a Barbarians game and gave up two kickable penalties to try a lineout and scrum, both of which were wasted. The next penalty, though, was kicked over by Emiliano Boffelli, which pleased a crowd of 77,647 giving the Pumas partisan support.

England seek face-saving turnaround against India

Defending champions still mathematically alive

LUCKNOW, India, Oct 28, (AP): When the Cricket World Cup schedule was announced in July, India vs. England on Sunday was expected to be a marquee match.

It will be anything but.

England's poor showing at the World Cup so far has befuddled even their most ardent fans. One win from five games is the worst showing for a defending champions since 1999, when 1996 winners Sri Lanka won two out of five league games and failed to qualify for the next stage of that tournament.

England's only win so far came at Dharamsala - beating Bangladesh by 137 runs. They are ninth in the points table with a minus 1.634 run-rate.

CRICKET

"I am not a mathematician but it is over now - with our net run-rate and too many teams who are going to take games off each other, we have to come to terms with that from now. We are (only) playing for a lot of pride," England coach Matthew Mott said after an eight-wicket loss to Sri Lanka.

Despite what Mott said, England are still mathematically alive. If they win four games in a row and reaches 10 points, then depending on other results, they could still be in with a

better run-rate.

Meanwhile, India have been flying high - the only unbeaten side with five wins in a row. They have beaten Australia, Afghanistan, Pakistan, Bangladesh and New Zealand, accruing 10 points and a positive run-rate of 1.353. It is currently second on the table, after 5-1 South Africa - also on 10 points after they beat Pakistan in Chennai on Friday - took over first place with a

At this stage, there couldn't be a greater disparity between the teams. India have two big names in the top run-scorers' list - Virat Kohli with 354 runs, and Rohit Sharma with 311 runs, in five games. They also have two bowlers in the top wicket-takers' list - Jasprit Bumrah with 11 wickets and Kuldeep Yadav with eight wickets.

England's top scorer is Dawid Ma-

lan with 220 runs in five innings - 140 of them came against Bangladesh alone. Sam Curran - player of the tournament in the 2022 Twenty20 World Cup - has failed to make a mark and was dropped after three games.

"A lot of experienced guys who are fantastic cricketers - look at our dressing room. It is not a lack of talent. But this tournament hasn't gone the way we wanted to. It has been a huge disappointment," said England's Jos Buttler.

Meanwhile, India's changes have worked out well. Star allrounder Hardik Pandya is out because of a left ankle injury, and his replacement Mohammed Shami took 5-54 against New Zealand.

Pandya is still missing for India and the hosts will play a similar combination as in Dharamsala. The only question pertains to conditions in Lucknow - the slower turning pitch could see Ravichandran Ashwin play his second game of the tournament.

Ashwin last played against Australia on Oct. 5 in India's tournament opener at Chennai. In that scenario, pacer Mohammed Siraj is expected to make way, with Shami teaming up with Bumrah for the new ball.

The off-spinner's return will mean a three-spinner attack and it will only make the task tougher for beleaguered England.

previously won the traditional season opener on an Austrian glacier in 2013 and 2016.

SKIING

"I'm happy as it's my third win after 10 years," Gut-Behrami said. "It's nice, it's an amazing slope, I really like to ski in Soelden. It was a tough one today.

Gut-Behrami became the third skier to claim at least one women's World Cup win in 13 different seasons, after Austria's Renate Goetschl (14) and American standout Lindsey Vonn (13) accomplished that feat.

Australia hold nerve to beat New Zealand

DHARAMSALA, Oct 28, (AP): Mitchell Starc held his nerve and defended 19 off the last over as Australia beat New Zealand in a high-scoring affair at the Cricket World Cup.

James Neesham scored 58 off 39 balls but was run-out on the penultimate ball of the game as the Black Caps slipped at the last hurdle. Australia won the trans-Tasman battle by five runs.

This was after Travis Head made an explosive entry into the tournament with a blazing 109 off 67 balls as Australia went on a run rampage and had reached 360-6 in 47 overs.

Head, who recovered from fractured thumb, and David Warner smashed New Zealand pace bowlers with an aggressive 175-run opening wicket stand off 117 balls.

In reply, Rachin Ravindra scored his second World Cup century and almost helped his team chase down the tall target in an epic last game of the tour-

nament at Dharamsala.

New Zealand finished with 383-9 in 50 overs, with Ravindra scoring 116 off 89 balls. It stays third with eight points but ahead of Australia (8 points) on net run-rate.

Opting to bat, Australia made a flying start to its innings. The Head-Warner partnership amassed 50 runs in only 4.1 overs. At the end of 10 overs, the duo had crossed 118-0 - just one run short of the record for first power-play in World Cups. Head reached 50 off only 25 balls, the fortest in this toursmont, after

the fastest in this tournament, after Warner scored 50 off 28 balls. For the latter, it was a continuation of his previous two knocks - centuries against Pakistan and the Netherlands.

Warner missed out on his third hundred, though, out caught and bowled by Glenn Phillips for 81 off 65 balls. He hit five fours and six sixes, including one smashed off Lockie Ferguson's 154 km/h delivery.

Australia went from 175-0 to 200-

2 in the space of 26 balls. Head was out bowled in the 24th over, again off Phillips, after completing his hundred. Mitchell Santner had earlier dropped Head on 70 not out off his own bowling. It was an important marker as New

Zealand found the breathing space to fight back. Australia lost its 10 wickets for 213 runs, after the Warner-Head stand came to an end.

Phillips was New Zealand's most successful bowler - picking 3-37 in 10 overs. Santner proved to be expensive, taking 2-80. Trent Boult recovered from the initial onslaught to finish with 3-77.

Nketiah scores hat trick, Arsenal 'rout' last-place Sheffield United

LONDON, Oct 28, (AP): Eddie Nketiah scored his first Premier League took the lead in the 53rd when Palace hat trick as Arsenal brushed aside lastplace Sheffield United 5-0 on Saturday to keep pace in the title race. The England striker made sure Arsenal didn't miss the injured Gabriel Jesus as he opened the scoring in the 28th minute from close range and completed his hat trick in the 58th with a fierce shot from outside the area to put Arsenal 3-0 up. Substitute Fabio Vieira netted the fourth from the penalty spot in the 88th and Takehiro Tomiyasu completed the rout deep into stoppage time from a corner. Jesus had been the architect of Arsenal's win at Sevilla in the Champions League in midweek with a goal and an assist, but also sustained a hamstring injury that is expected to sideline the Brazilian for a few weeks. That gave Nketiah another chance to impress and he made full use of it against a team that has now conceded a league-high 29 goals in 10 games. In a tepid first half that saw Arsenal continually pass the ball around but struggling to break down a compact defense, Nketiah broke the deadlock when Declan Rice picked him out in the area and the striker used one touch to go past a defender and the second to slot the ball past goalkeeper Wes Foderingham. The second came five minutes after the halftime break, when Foderingham flailed at a corner and the ball landed at the feet of Nketiah, who hammered it into the far corner. The 24-year-old Arsenal academy product saved the best for last, collecting a pass from Emile Smith Rowe and setting himself up for a shot from 25 yards that he smashed into the top corner. The striker, who received his first England call-up earlier this season, celebrated by kissing the yellow game ball and lifting it to the sky with one hand as the Emirates crowd chanted his name. Arsenal were awarded a penalty after a lengthy VAR review for a foul on Vieira as he broke into the area, and the Portuguese midfielder stepped up to the spot himself to slot in the fourth. Tomiyasu was then on hand to slot home the fifth after a corner in the sixth minute of added time.

After a sluggish start, Tottenham defender Joel Ward turned a crossshot from James Maddison into his own net. Son then netted his eighth league goal of the season to ensure Tottenham stayed unbeaten after 10 games. Defending champions Manchester City can draw level with the Gunners on 24 points by beating crosstown rival Manchester United in Sunday's derby.
