# Kuwait greenlights part-time work

#### Does justice, fairness exist in Kuwait?

WHAT does justice mean? How can the law become a standard for the progress of nations?

To answer these questions, there is a practical lesson that happened in one of the American universities. Without any introduction, a professor asked one of the students: What is your name? When the student responded, the professor asked him to exit the lecture hall. When the student attempted to defend himself, the professor rebuked him and chased him out. As the student left feeling mistreated, everyone in the lecture hall remained silent.

The professor went on with the class. He asked the students: Why were the laws put in place? The students gave various answers. One said: "Laws exist to control people's behavior." Another added: "They are there to

be implemented," while another said: "So that the strong do not oppress the weak.

The professor said: "All of the answers are true, but not sufficient." A fourth student replied: "Laws exist in order to achieve justice." Then the professor responded: "Yes, this is the

He asked again: "Now what is the point of laws if justice is not achieved?"
He added: "Now answer without

fear. Did I treat your classmate unjustly and unfairly when I expelled him from

They all replied: "Yes"

He furiously asked: "Then, why did you remain silent? What is the benefit of laws if we do not have the courage to implement them? When someone is subjected to injustice and you do not defend the truth, you lose your humanity. Humanity is not negotiable.'

Ever since democracy existed, its foundation has been based on justice. For 60 years until this day, we have fell short of how to deal with the concept of democracy. This is due to the fact that our society lives on farms between tribes and sects. Thus, loyalties varied and conflicts of interests prevailed; making our democracy more like groupings closer to cantons.

This anomalous situation has produced national assemblies based on deals -- whether in buying votes, or tribal and sectarian terror; while the weak governments have been unable to exercise their natural powers.

In addition, the Constitution granted the ruler the right to suspend it for a specific period in order to correct the political course, as required by the supreme interests of the State

There is no doubt that Kuwait, as it has done for 400 years, has proven its ability to overcome obstacles; because the relationship between the ruler and the ruled is based on transparency, frankness and national loyalty.

Unfortunately, all of these changed six decades ago due to the lack of understanding democracy on one hand, and the exploitation of loopholes in the Constitution to consolidate the influence of the powerful on the other hand. This happened through some sheikhs, wealthy people or sectarian and tribal components. Despite all this experience, we still appear as amateurs.

Nonetheless, to get out of this impasse, a developed vision is necessary, whether through the Constitution or laws. What we are witnessing today is a number of urgent obstacles -- whether in the National Assembly as if it were the ruler, or the ruling family which, in recent years, seemed isolated from society as a result of conflicts between some of its members, paving the way

## JN.1 coronavirus variant detected in Kuwait

persist or increase in severity

KUWAIT CITY, Dec 28: Official Spokesman of the Health Ministry and Director of the Health Communication Center Dr Abdullah Al-Sanad has confirmed that the country detected the new coronavirus variant – JN.1 – through the results of the genetic testing carried out by the ministry's teams recently, indicating these teams have been monitoring the prevailing patterns or variants of

coronavirus and other viruses. Al-Sanad reassured citizens and residents that monitoring such mutations is expected and does not cause concern, as the health situation is stable and there are no unusual preventive measures at present; pointing out that this time of the year is the period for active seasonal respiratory viral diseases. He reiterated the advice for those who show signs or symptoms of infection not to mingle with others, and to seek medical help when symptoms

He affirmed that the ministry provides seasonal vaccinations for influenza and bacterial pneumonia or the updated version of the Covid vaccine through 42 centers in all governorates; especially for groups most vulnerable to infection and complications like those above 60 years old, those with chronic diseases such as respiratory system problems and diabetes, and those with heart, kidney and immunodeficiency diseases.

#### Migratory birds settle at an abandoned ship in Kuwait

Every winter, thousands of migrating birds travel across Kuwait's coastline to reach their winter home.

However, Omar Al-Said Omar, a member of the Kuwait Environmental Lens team, has seen something different this year. At an abandoned ship near Usheirej, a flock of Loha

birds settled, creating an aestheti-

cally stunning scene.

Omar told KUNA thousands of Loha birds migrate to Kuwait during the winter months due to the country's suitable environment, from Um Al-Namel Island to Al-Judailiyat bay, Jahra and Sulaibikhat.

Unexpectedly, Omar discovered that the birds had been preserved on the same ship for six years after tracking and snapping pictures at the same location. Omar also described the seabirds' capacity to live in groups, dive to a depth of 45 meters and catch fish. (KUNA)

## 'With employer's nod'

KUWAIT CITY, Dec 28: First Deputy Prime Minister and Minister of Interior Sheikh Talal Al-Khaled Al-Ahmad Al-Jaber Al-Sabah has issued a ministerial decision on allowing private sector employees to work part-time for a third party (another employer) on the condition that they obtain approval from the original employer.

The decision is in line with the provisions of the Council of Ministers' resolution on addressing the demographic im-

It stipulates that employees in the private sector are now allowed to engage in part-time work with another employer for a maximum of four hours per day, provided they obtain a part-time work permit from the Public Authority for Manpower (PAM). It exempts the contracting sector from the maximum hours condition due to the market's manpower needs.

This decision aims to take advantage of the skills and experience of the workforce inside Kuwait as an alternative to guaranteeing rights over recruitment, which contributes to addressing the demographic imbalance issue and meeting the labor market needs in the current period.

The decision shall take effect at the beginning of January 2024, so that the employers can develop their businesses. This step contributes to investing in the strength of existing workers in a bid to meet the manpower needs of the labor market.

In addition, PAM continues to take the necessary steps to regulate the labor market and cover its manpower needs.

Sheikh Talal Al-Khaled has also instructed PAM to allow employers to permit a group of their employees to work remotely; that is, if the employees can complete their tasks without the need to be present at the workplace in accordance with the regulations laid down by the authority for employers and employees in the These decisions and directives aim to support the employers and

develop work mechanisms in the private sector in line with the technological developments and in order to improve the business environment, as well as enable employers to grow their businesses and meet the needs of the Kuwaiti market.

## MPs slam attempts to **suspend Constitution**

KUWAIT CITY, Dec 28: A number of MPs have reacted angrily to calls for the suspension of the Constitution, stressing that commitment to the Constitution is the safety valve of the nation.

MP Shuaib Al-Muwaizri argued such calls are unjustifiable and are made by people who could have done something against the Constitution. He said some of these people consider the Constitution a hindrance to their personal interests, while others adopt such calls in a hypocritical manner since they shun legislation and monitoring. He affirmed that only Allah and commitment to the Constitution can ensure the stability of Kuwait.

MP Abdullah Fehad pointed out that he and his colleagues took the oath to respect the Constitution and protect the people's freedom and interests; hence, they must stand against calls to suspend the Constitution, which is the most outstanding achievement of the nation. He said vibrant nations never take backward steps, as they always seek for more freedoms and reforms. He urged those calling for the suspension of the Constitution to stop what they are doing, emphasizing that their attempts to disrupt the constitutional security will definitely fail.

MP Osama Al-Shaheen asserted that such calls are utterly rejected; indicating Kuwait is a democratic nation and those behind these calls must be sued as per Article 29 of the Penal Code, considering they are pushing for the collapse of the regime.

MP Meteb Ayed Al-Raathan warned that the suspension of the Constitution has always led to unforgettable disasters in the country. He said those making such calls want to promote sectarianism and racism, stating these people must read history carefully in order to learn a valuable lesson; particularly when the entire people of Kuwait faced the Iraqi invasion. He added the Constitution is a safety valve for the people and the political leadership.

#### Stagnation

MP Soud Al-Asfour asserted this is not the first time and it will not be the last to hear calls aimed at attacking the citizens' right to play their role in managing their country. He thinks those calling for suspension of the Constitution ignored the previous experience when such a move led to nothing but deterioration and stagnation. He argued that correction means developing both the executive and legislative authorities without marginalizing any of them.

MP Adel Al-Damkhi rejected the calls to suspend the Constitution, stressing this is tantamount to a coup aimed at causing cracks in the social fabric that could lead to massive chaos. He added that only the envious and anti- democracy people want to benefit from such calls, because they cannot live in justice and freedom.

Former MP Marzouq Al-Khalifa said the ongoing systematic campaign against the Constitution is the partner of futile campaigns. He observed that whenever the corrupt are hurt, the green light is turned on for suspicious campaigns to kick off. He asserted that whoever adopts the idea of suspending the Constitution is considered a traitor to the social contract between the ruler and the ruled. He added that only the Constitution protects the rights of the people and keeps the nation safe. He said the corrupt traders are exhausted due to the recent legislative achievements, so they want to take revenge by disrupting the legislative process.

In a related development, five political blocs issued a joint statement rejecting attempts to suspend the Constitution. These blocs include the Islamic Constitutional Movement (ICM), Kuwait Democratic Forum (KDF), Kuwaiti Progressive Movement (KPM), National Islamic Alliance (NIA) and National Charter Group (NCG).

These blocs reaffirmed their commitment to adhere to the Constitution, since it is the basis of democracy and the legitimate channel for public political participation. They pointed out that commitment to the Constitution has always been the life jacket of the nation whenever it faces exceptional crises.

#### 'New visa system to be introduced in Feb 2024'

## Kuwaitis will not require visa to travel to UK soon: British envoy

KUWAIT CITY, Dec 28: The United Kingdom announced that all countries of the Gulf Cooperation Council will move to the electronic travel authorization (ETA) system as of February 2024, reports Al-Qabas daily.

The British government indicated that citizens of the Gulf countries will not need visas when visiting the United Kingdom, as the British authorities will work to improve border operations to facilitate the entry of tourists, students and businessmen.

Meanwhile, the British Ambassador to Kuwait, Belinda Lewis, told Al-Qabas that the new visa system will be introduced from the beginning February 2024 and indicated that the application of the ETA for Kuwaiti citizens will make

travel to the United Kingdom much easier and more flexible, and there will be no need to get a visit visa.

The British envoy confirmed the UK government readiness to implement the new visa system, expressing her hope that this new system will encourage more Kuwaitis to visit the United Kingdom, explaining that tourists can apply for an electronic travel permit valid for two years for 10 British pounds, i.e. It is equivalent to 3.7 Kuwaiti dinars, whether for adults, children or infants, starting from February 1, 2024, and said it takes about three working days to complete the application.

She added, a large number of people have applied for the old Visa Waiver Scheme (EVW) but the Home Office does not keep figures on the number of people from each country.

Lewis praised the depth of bilateral relations between the two countries, explaining that the United Kingdom and Kuwait will continue to benefit from the close friendship "we share to develop new areas of cooperation, noting that the volume of trade has witnessed remarkable growth after reaching 5.1 billion pounds sterling, an increase of 66.8% over last year."

She went on to say, "Our defense and security partnerships have also flourished, including cybersecurity, air and maritime security, military cooperation,

## Accidents kill, maim scores

Entry prohibited for 7 sports cars seized at border

KUWAIT CITY, Dec 28: Official spokesman of the Ministry of Health Dr Abdullah Al-Sanad has warned about the rising number of injuries and deaths resulting from road incidents, especially in the North and South, including the camping sites, reports Al-Seyassah daily.

In a press statement, Al-Sanad disclosed that the concerned departments have received 700 accident reports since the beginning of December 2023; indicating the victims were transported through land and air ambulances. He said most of those involved in road accidents are young men and women who sustained different injuries like cuts, bone fractures, bruises and internal bleeding while others died. He added the ministry dealt with 130 motorcycle and all-terrain vehicle accidents in December alone, as well as 50 run over cases. He urged the parents to guide their children and raise their awareness about the need to be careful to avoid such accidents.

He also unveiled the ministry's plan to invite internationally renowned doctors from different countries to Kuwait every month, clarifying that the purpose is not to handle critical cases but to pass on the experience and expertise to Kuwaiti doctors through training programs, lectures and workshops, which will contribute to ongoing efforts to reduce the need for overseas treatment. He said the ministry hosted 93 doctors from various countries in the last three months.

In another development, Al-Sanad confirmed the commitment of the ministry to implement the digitalization of services; stating the employees can now obtain certificates through the Sahel application including 'To Whom It May Concern', job, experience and continuous salary payment certificates. He pointed out that Assistant Undersecretary for Administrative Affairs Abdulrahman Al-Fares announced these electronic services earlier. He affirmed it is now easy for the employees to obtain the aforementioned documents, stressing that certificates obtained through Sahel are approved by all public institutions and banks.

KUWAIT CITY, Dec 28, (KUNA): The Kuwait Insurance Regulatory Unit announced Wednesday launching a website for issuing and renewing the mandatory third-party motor insurance certificates for private cars and motorbikes as of January 1, 2024.

The website (www.beema.iru.gov.kw) allows car and motorcycles owner to issue new or to renew their insurance certificates through simple steps, Head of the IRU Mo-

hammad Al-Otaibi said in a press statement. The move is part of the state strategy for digital transformation of government services, he pointed out.

Al-Otaibi noted that during the website pilot period, car and motorbike owners have the choice to renew their insurance documents through the website or visiting an office of one of the authorized insurance firms across the country.

## **Kuwaiti and Saudi laid to rest**

KUWAIT CITY, Dec 28: Kuwaiti citizen Faisal Al-Mutairi and Saudi citizen Anwar Al-Dhefairi, who died while they were on a hunting trip in a desert near Anbar, Iraq, were buried in Sulaibikhat Cemetery on Thursday.

A large crowd of media figures, intellectuals, politicians and ordinary citizens attended the funeral. They called for a thorough investigation of the case by the ministries of Interior and Foreign Affairs to establish the actual circumstances leading to death of Al-Mutairi and Al-Dhefairi.

Media personality Saleh Al-Mutairi, uncle of the late Faisal, disclosed that he feels so sad. He stressed that his nephew and his

companion were murdered, stating they did not die due to a bomb explosion as claimed by the Iraqi Authorities. He confirmed holding pieces of evidence that the vehicle of the victims was targeted. According to what he obtained from Iraqi media institutions, guns were fired at the vehicle.

She clarified that submitting an application does not guarantee acceptance, and students interested in registering are urged to apply through the institute's website. The deadline for personal interviews is set for January 7, allowing for a comprehensive evaluation process to select participants for this educational opportunity.




## Prayer, meditation and workers' loss

**D**iverse cultures around the globe pursue various avenues to fulfill their spiritual needs, whether through religious prayers or meditation. Prayer is often structured around specific texts, designated times and places, and sometimes involves specific attire and preparatory rituals.

To the contrary, meditation is a practice devoid of religious affiliations and is undertaken for personal needs. Despite my attempts to align with the

Unlike prayer, meditation remains relatively unknown to the majority despite its

simplicity. It can be performed at any time, in any attire, and in any location with relative tranquility. It is believed to alleviate daily stresses, reducing preoccupation with life's challenges.

I observed that many meditation practitioners had navigated through difficult life circumstances, such as financial loss, the demise of a loved one, failed relationships, depression, or despair over illness or addiction, leading them to discover solace in meditation.

In contrast, my relatively smooth journey may explain why my need for such practices did not crystallize as prominently.

It appears that prayer fulfills a fundamental need for individuals and adherents of various faiths. Each faith prescribes its unique approach to prayer, serving as a ritual for organizing people's lives, instilling religious duties, and providing spiritual sustenance. Individuals may seek mercy, forgiveness, health, wealth, security, and express gratitude for divine blessings through prayer.

The society of the island, the birthplace of Islam, was a challenging environment, compelling its inhabitants to secure sustenance, safety, and family through invasion -- the only known method of sur-

Islam introduced prayer at specific times of the day to align with the circumstances of that era. People would pray the evening prayer and then retire early due to a lack of means to stay awake for extended periods.

As the human body requires around eight hours of sleep, the biological clock naturally prompts awakening at dawn for the morning prayer, initiating the day, followed by the remaining prayers.

Shiite Muslims, representing around 20% of the Muslim population, adopted a practice of combining the noon and afternoon prayers, as well as the sunset and evening prayers, reducing the daily prayer frequency to three times instead

The origin and reasons for this "combination" practice remain unclear, though it has historical precedence during times of war, travel, and disas-

Some argue that the conventional method of prayer is challenging in modern life, characterized by continuous work hours requiring creativity. It is essential to approach prayer with sincerity, avoiding a routine recitation of the same words throughout one's life.

The concern is not the brief duration of each prayer but rather the psychological and mental preparation preceding it -- often overlooked, particularly in the face of today's fast-paced and demanding lifestyles.

Over three decades, I dealt with a paw factory in Malaysia, founded by a Chinese immigrant supported by a Malaysian Muslim workforce. The advent of the petrodollar era brought preachers who convinced the workers to perform their prayers in mosques, leading to the construction of numerous mosques around each farm, disrupting work schedules. Faced with the dilemma of either closing the factory or replacing Muslim workers with Chinese counterparts, the latter option was chosen, resulting in significant job losses.

### Local brew sold as foreign liquor

KUWAIT CITY, Dec 28: A security force from the Public Security Sector, upon instructions from the Undersecretary, Major-General Abdullah Al-Rujaib, raided a local liquor factory, yesterday, in Salmiya and took into custody an unidentified expatriate and seized from him 123 bottles of booze, 3 barrels full of raw material, and tools and equipment for making, bottling, and packaging liquor.

During initial investigation interrogation, the suspect admitted to manufacturing approximately 150 bottles of alcohol per day, filling them inside imported liquor bottles, pressing the lids and sealing them, making the buyer believe that the stuff is imported liquor and selling them for 60 dinars per bottle.

The suspect and the contraband have been referred to the Directorate General od Drugs and Alcohol Control.

Meanwhile, the Operations Sector of the General Traffic Department organized a security campaign yesterday evening against violators of traffic laws and reckless drivers in several areas of Al-Ahmadi, including Al-Sabahiya, Umm Al-Haiman, and Fahd Al-Ahmad, and arrested 16 people were, including 6 Kuwaiti juveniles, reports Al-Anba daily.

Some of those arrested were caught driving without license and others for installing exhausts to make annoying sounds and driving recklessly putting their lives and the lives of others in jeop-

The 6 juveniles were referred to the Juvenile Prosecution and the others were referred to the General Traffic Department. During the campaign 32 traffic violations were issued and 15 cars were impounded and towed to the traffic detention garage.

## Who will compensate them for their losses?

"THE country and its citizens mourned the death of their Amir, of whom only goodness, love, and simplicity of life are remembered," columnist Iqbal Al-Ahmad wrote for Al-Qabas daily.

'Mourning was declared in Kuwait, and many adhered to it during

period, not only out of commitment, as much as it was real feelings and sadfor the ness of this loss great human being. "Life in Ku-

wait stopped Iqbal Al-Ahmad almost com-

pletely, when official departments were suspended and many places, a large part of which were not entertainment, were closed for a few days.

"However, there are aspects of life that work cannot stop in such circumstances, because their work never falls within the category of entertainment, relaxation, and joy.

"Question: Did the export of Kuwaiti oil stop since the first day of mourning?

'Certainly not, and it is impossible for this to be done because this will certainly affect the source of life and livelihood of Kuwait, which will affect important matters in the country. Therefore, there are interests that cannot be excluded from mourning, because they are not joy, mirth, or dancing.

"I know that there are "good intentions" efforts and attempts that have been published and circulated, such as expressions of mourning, in a way that we have not seen before, in commitment to declaring official mourning for the death of the prince, such as the type of clothing, listening to music in cars, and so on.

This raises an important question: Is there a clear framework for public and official mourning that is required of everyone living in Ku-

"For example: Why do customs operations stop due to the disruption of all government agencies, as well as parks, cultural and scientific centers, and entertainment for children?

"Many business owners complained about the accumulation of their goods, which arrived in the country one day before the declaration of mourning, as they were piled on the ground, and left for the three ays of mourning on the customs floor, which caused confusion and chaos when they went to receive them, and some of them were even surprised that they were damaged because they require special conditions. Special storage, such as roses and some food products, causing losses to them, so who will compensate them for their losses?

"Al Shaheed Park closed its doors for three days. Why? It is a place for sport, calm and relaxation. I understand that the cafes and music are closed? But its doors must remain open, especially with all forms of entertainment stopping during the three days of mourning.

'We need an accurate and clear definition of the manifestations of official mourning in the country in the event of the death of the Amir of the country, or any figure of standing locally or externally, and for the issue not to be left to people's judgments and guesses.

"It is necessary to take into account the losses that could befall some businesses, in which the cessation of work for one day is considered a major loss for its owners, let alone three days (activities far from the areas of entertainment and nor-

"Not leaving the arena open for

any action ... without framing and clarification for everyone, will avoid many repercussions.

"As we noted, and this was a source of admiration and appreciation for the Amiri Diwan and the responsible authority, the good arrangement and order in the mourning demonstrations, we hope that this will also apply to the issue of official mourning, and the classification of official and unofficial bodies that are concerned with official

mourning.
"May God reward Kuwait for its dear loss, and grant success to its new Amir for the benefit of the country and its people.'

#### Also:

"In the aftermath of His Highness the Amir Sheikh Meshal Al-Ahmad Al-Jaber Al-Sabah's speech during the oath session, a faction advocating for progressive population openness has introduced the notion that we are all essentially children of the same lineage," columnist Youssef Al-Jalahma, wrote for Al-Rai daily.

'According to this theory, there is no intrinsic Kuwaiti identity, no differentiation between indigenous and naturalized citizens, and no room for false claims or dual nationalities. This perspective stems from a paragraph in His Highness's speech that alludes to an agreement between the government and the Council potentially harming the nation's interests, leading to a shift in Kuwaiti identity.

"To those espousing this theory, we pose the question: "Should we alter the indigenous population as the Americans did, in line with your support for Western ideals of civilization, openness, and democracy?" Interestingly, within two days, news surfaced about an individual with dual citizenship (Kuwaiti/Saudi) attempting to cross the Kuwaiti border using a Saudi ID, leading to his ar-

"Skeptics may dismiss this as an isolated case, but a significant portion of news outlets remains oblivious to such incidents. Another report tells the story of an Egyptian woman, may she rest in peace, who was recorded with no specified nationality in all her transactions in the State of

"To those advocating for change and openness, we question why you persist in addressing the issue of counterfeiters, duplicators, and those who transitioned from naturalization to establishment. Whenever a Kuwaiti citizen raises concerns about this, it seems to intensify the scrutiny on your part. Is there a particular reason for this?

"If resolving this matter is your objective, it is not an insurmountable challenge. We propose that there will be no revocation of citizenship. Instead, you will retain all existing privileges, with the only alteration being your eligibility for nomination and voting in the National and Municipal Councils. The outcomes of these elections will reflect the public's sentiment. Housing, employment, labor support, supplies, and other benefits will remain unchanged

"Should a citizenship review body be established, its authority would extend to examining all files, both original and naturalized statuses. Subsequently, individuals would have the option to retain their original nationality or choose Kuwaiti nationality through naturalization. Similarly, those who engaged in forgery would have their original nationality reinstated. There is no need for apprehension; we are a nation of compassion, and your well-being is assured, God willing."

## Car transfer service goes online starting Feb 1, 2024

KUWAIT CITY, Dec 28, (Agencies): The Ministry of Interior launched a vehicle renewal service for citizens and residents through the unified government application "Sahel," starting next January 2, through a 6-step mechanism, which exempts vehicle owners from going to insurance company offices and obtaining a paper copy of the registration book, reports Al-Rai daily.

The Ministry also launched a vehicle transfer service, starting next February 1.

A statement from the General Department of Security Relations and Media at the Ministry of Interior stated that the launch of this service came under direct directives from the First Deputy

Prime Minister and Minister of Interior, Sheikh Talal Al-Khaled, as part of the ministry's efforts and steps towards completing the process of digital transformation and digitizing services provided to the public.

The ministry pointed out that these services come within the framework of alleviating the effort and facilitating the public in

the process of renewing and registering vehicles, through the government "Sahel" application.

The ministry identified the following six steps: ■ Log in "online" to purchase the insurance policy, enter vehicle ownership data. The insurance value is paid, whether for one or two years, according to the client's desire.

■ Approval occurs after determining and pay ing the value of the insurance policy, and officially approving it by sending a special "code" to the vehicle owner, confirming the validity of the

■ Visit the technical inspection departments in the governorates or companies accredited by the General Traffic Department, where it is done; show the insurance policy number, after which the

## Moderate, partly cloudy weather expected in weekend; cool nights

KUWAIT CITY, Dec 28, (KUNA): The Meteorological Department anticipates a moderate and partly cloudy weekend weather forecast with a tendency for cool to cold conditions at night, accompanied by the possibility of scattered rain, occasionally thundery. Director of the Department, Abdulaziz Al-Qarawi, informed Kuwait News Agency (KUNA) that weather indicators and numerical models suggest the

country is under the influence of a surface depression extension coinciding with an upper atmosphere cold air depression. This situation is causing the proliferation of low and medium clouds, interspersed

cumulonimbus clouds. Al-Qarawi noted the likelihood of scattered light to moderate rain,

occasionally thundery in specific areas. along with possible fog formation, reduced horizontal visibility, and sea waves rising to more than 6 feet. Today's weather, Thursday, is expected to be moderate and cloudy with variable winds shifting to the northeasterly direction. Wind speeds will be light to moderate, occasionally active at 8 to 40 kilometers per hour, with a chance of scattered light rain, possibly thundery at times. Maximum temperatures are fore-casted between 21 and 23 degrees Celsius, and the sea conditions will be light to moderate, with waves occasionally reaching heights of 2 to 6 feet.

For tonight, the weather is anticipated to be cold to cold and cloudy, with northwesterly to variable winds at light to moderate speeds (8 to 28 kilometers per hour). There is a possibility of scattered rain and fog in some areas, and the expected minimum

temperature will range between 13 and 15 degrees Celsius. The sea is projected to have light to moderate waves, occasionally reaching heights of 1 to 3 feet.

Looking ahead to tomorrow, Friday, the weather is predicted to be moderate, partly cloudy to cloudy, with northwesterly to variable winds at light to moderate speeds (8 to 32 kilometers per hour). There is a chance of scattered rain, potentially thundery at times, and maximum temperatures are expected to range between 21 and 23 degrees Celsius. The sea conditions will be clear with light to moderate waves, occasionally reaching heights of 1 to 4 feet. Friday night is expected to be cold to cold and partly cloudy, with northwesterly to variable winds at light to moderate speeds (8 to 30 kilometers per hour). There is a possibility of scattered rain, and the expected minimum temperature will be between 12 and 14 degrees Celsius. He also reiterated the Public Health Sector's recommendation for medical and technical support staff in hospitals and centers to cover the mouth and nose while at work.

In addition, reliable sources from the health sector affirmed the slight increase in the number of infections in various governorates in December. Sources cited an increase in the number of infections by one to two cases during the current month compared to previous months, stating that the rate of Covid infections in Kuwait during the year 2023 ranges between 600 to 900 cases with an average of 100 to 150 cases in each governorate.

Sources added the daily average of infections ranges from 10 to 12 in each governorate - an affirmation of the small number of infections in the

country compared to infections during the Corona pandemic, which was recording daily four times the current monthly infection rate. Sources said this means there is no reason to fear or worry about the spread of Coronavirus in the country.

It is worth mentioning that the World Health Organization (WHO) recently announced a high rate of infection with the virus around the world, recording 854,673 infections and 3,005 deaths worldwide within four weeks, with Russia ranking first among the countries -- 279,359 infections.

The organization's data indicated a heterogeneous picture of infections and deaths in the regions, as new cases of the virus in Southeast Asia rose by 88 percent in four weeks and the death rate more than tripled.

In a related development, acting Undersecretary of the ministry Dr Abdul Rahman Al-Mutairi issued a circular obliging medical and technical assistant staff in hospitals, specialized medical centers and primary health care centers to wear masks during the official working period. This is in addition to the need to maintain clean hands by frequently washing them with water, soap and disinfectant. It is also recommended to complete seasonal respiratory vaccinations, especially the updated version of the Covid vaccine and the flu vaccine.

He indicated that a preparatory meeting was held for the AP plenary session due on Thursday that discusses situation in Palestine and Palestinians' sufferings.

Al-Asoumi underlined that the AP continues backing the Palestinian cause via parliamentary diplomacy, urging all agencies that could put pressure on the occupying Israeli entity to halt its aggression and violation on Gaza, and the citizens of the West Bank and Jerusalem.

The Arab League called on Thursday for an immediate ceasefire and halt of Israeli occupation aggression against the Gaza Strip, which would open the doorway for the safe delivery of necessary

relief aid to the war-torn region. In a speech to the Arab Parliament special session on supporting Palestine and the Gaza Strip, the league's Assistant Secretary for Palestinian Affairs and Occupied Arab lands Ambassador Saeed Abu-Ali said, "All those who opposed an immediate ceasefire in the Gaza Strip are partners in the heinous crimes and have blood on their hands."

The misery connected with the Palestinian cause could only be solved through ending occupation and establishing an independent state of Palestine within the June 1967 borders and east Jerusalem as capital of the country, indicated Abu-Ali, stressing that any military solution to the situation would be detrimental to the Palestinian people and their rights for dignity and freedom.

Abu-Ali followed by saying that the Israeli occupation government, for years, had been committing acts of horror against the Palestinian people, killing them, abusing them, and destroying their lives and honor.

The separation of the issue of the Gaza Strip from what was occurring in the West Bank is another attempt to de-legitimize the Palestinian cause, but this would not take place, affirmed the Arab League official.

The two state solution would only come via a true international determination to bring it into reality, indicated the official who affirmed that the maiority of the world was in support of the step save a few countries who stand against justice and truth.

The Israeli war machine is committing and act of genocide that must be stopped at all cost and the world must implement international resolutions to

halt these crimes, he added. He went on to say that, 2.5 percent of the Gaza population were either massacred, wounded, or missing, revealing that 60 percent of total infrastructure in the Strip was completely

Abu-Ali called for implementing UNSC Resolution 2720 allowing for the increased delivery of crucial humanitarian relief aid into Gaza before the matters slide into uncharted terri-

Meanwhile, Israeli forces bombarded cities, towns and refugee camps across Gaza overnight and into Thursday, killing dozens of people in a widening air and ground offensive against Hamas that has forced thousands more to flee from homes and shelters in re-

cent days. The war has already killed over 20,000 Palestinians and driven around 85% of the population of 2.3 million from their homes. Much of northern Gaza has been leveled, and it has been largely depopulated and isolated from the rest of the territory for weeks. Many fear a similar fate awaits the south as Israel expands its offensive to

most of the tiny enclave. Israel has vowed to dismantle Hamas - which is still putting up stiff resistance, even in the north - and bring back more than 100 hostages still held by the militants after their Oct. 7 attack into southern Israel, in which some 1,200 people, mostly civilians, were killed.

Israeli officials have brushed off international calls for a cease-fire - saying it would amount to a victory for Hamas.

The United States - while providing crucial support for the offensive - has urged Israel to take greater measures to spare civilians and allow in more aid. But humanitarian workers say the amount of food, fuel and medical supplies entering is still far below what is needed, and 1 in 4 Palestinians in Gaza are starving, according to U.N.

An Israeli airstrike on a home in the northern town of Beit Lahiyeh - one of the first targets of the ground invasion that began in October - buried at least 21 people, including women and children, according to a family member.

Bassel Kheir al-Din, a journalist with a local TV station, said the strike flattened his family house and severely damaged three neighboring homes. He said 12 members of his family - including three children aged 2, 7 and 8 were buried and presumed dead, and that nine neighbors were missing.

## **Deadly pileup on Turkish** motorway claims 10 lives

Dense fog leads to fatal chain collision

ANKARA, Turkey, Dec 28, (AP): A chain-reaction crash Thursday involving seven vehicles on a motorway in northwest Turkey killed at least 10 people and injured 57 others, officials said.

The pileup occurred in dense fog and low visibility on the Northern Marmara Highway in Sakarya province, some 150 kilometers (93 miles) from Istanbul.

An investigation has been launched into the accident but Gov. Yasar Karadeniz of Sakarya said it likely occurred when a vehicle hit a truck in poor visibility, triggering other crashes at the rear.

At least three intercity buses were involved in the crash.

Authorities believe some passengers died when they left their vehicles and were struck by another vehicle, Karadeniz told reporters at the

## **Qatar court reduces death sentence** handed to eight Indian navy officers

Court of Appeal reduced Thursday the death sentence handed in October to eight retired Indian navy officers on spy charges, the Indian foreign ministry said. #### **Glock developer dies**

#### Architect of 'Modern EU' Delors passes away at 98

BRUSSELS, Dec 28, (AP): Jacques Delors, a Paris bank messenger's son who became the visionary and builder of a more unified Europe in his momentous decade as chief executive of the European Union, has died in Paris, the Delors Institute think tank told The Associated Press on Wednesday. He was 98.

"The whole of Europe mourns the death of one of its greatest architects," the institute said in a statement. "The best results of European integration cannot be dissociated from the vision, the courage, the conviction, the perseverance and the relentless work which characterized Jacques Delors' work during his 10 years at the head of the European Commission.'

Paying tribute, the office of French President Emmanuel Macron said: "This grandson of farmers and the son of a bank employee, whose rise was entirely due to his talent, never allowed the lofty heights to

corrupt his human righteous-Delors "became the builder

of the EU as we know it today," German Chancellor Olaf Scholz wrote on X, formerly Twitter. "It is our responsibility to continue his work today for the good of Europe.' For many, the owlish but hard-driving Socialist and

Catholic was simply "Mr. Eu-**Delors** rope." The EU, which stretches these days from Finland to Portugal and is home to some 450 million people, was

dubbed "the house that Jacques built" by a popular Under his 1985-1995 tenure at the head of the EU's bureaucracy in Brussels, member countries agreed to

tear down barriers that prevented the free movement of capital, goods, services and people. Delors was also key in drawing up the blueprint for economic and monetary union, which led to the creation of the European Central Bank and the euro

#### Masterpiece

The latter, considered by many to be Delors' masterpiece, is now official tender for 20 of the 27 EU

But in the years leading up to his death, some of Delors' handiwork came under threat. A narrowly averted crisis over Greece shook the eurozone, while the EU's borders came under pressure from hundreds of thousands of refugees and other migrants, revealing fault lines within the bloc. In 2016, the U.K. voted to leave the EU in a repudiation of the "ever-closer union" the former EU Commission president toiled to

Further expansion eastward of the EU into territory once controlled by Moscow had been halted by ferocious Kremlin opposition. And the economies of many of the bloc's member nations appeared to be stuck in idle, with persistent low growth rates and millions of people unable to find work.

In remarks that may ring as true today as when he left office, Delors in 1995 cautioned fellow Europeans that "we have a future filled with danger." He insisted their countries, which spent centuries at one another's throats in devastating and bloody wars, must continue to strive for "agreements at political, social and eco-

For many, the moody Frenchman with big ideas yet painstaking attention to detail was the most influential figure in constructing a more united Europe since the postwar founders of the Common Market decided to bind their nations together to prevent another war.

Wim Kok, a former Dutch prime minister, admiringly called Delors the man "who for 10 years determined the face of Europe like no other.'

"I am satisfied like an artisan from whom someone ordered a table and chairs, who did everything he could to craft a fine work, and who today sees it in front of him," Delors told a newspaper reporter in 1998, three years after leaving Brussels. He added: "I consider myself to be only one element in the chain."

The EU - called the European Community when Delors took the helm - grew from 10 nations to 12 during his tenure, with a clear promise of the far greater expansion that has since taken place.

After the Berlin Wall fell in 1989, Delors moved quickly to prepare the organization for the admission of former communist countries from Eastern Europe.

From a narrowly focused trade bloc, it branched out into areas that were once the jealously guarded purview of individual governments, like foreign policy, customs and border controls, justice and home affairs.

But for many, especially in countries like Britain, Delors became the reviled personification of the overreaching Eurocrat bent on meddling in virtually all aspects of people's lives. One London tabloid called on readers to show their hostility to "the French fool" by assembling and shouting in unison: "Up Yours De-

British Prime Minister Margaret Thatcher, though using more genteel language, insisted on her country's sovereign right to fix its own course in many areas.

Delors pushed the grouping of countries far beyond its original role as an economic club toward his dream of a united Europe. He wanted to give it the institutions and tools to rival the United States and Japan, and to make it a force for peace, prosperity and security. "By the time you get to the mid '90s, there are signs of a significant backlash against European integration," said N. Piers Ludlow, associate professor at the London School of Economics and Political Science. "A potential European superstate was always thought of as science fiction, but that specter becomes a lot more credible.

Ludlow said Delors was "in a league of his own' as EU Commission president but that he overreached at the end, alienating some European leaders who became "fed up with this guy who hogged the limelight." A German businessman once likened Delors to the autocratic King Louis XIV of France.

VIENNA: Gaston Glock, the Austrian developer of the handgun that bears his name, died on Wednesday. He was 94.

The Glock company announced his death, the Austria Press Agency reported. Glock, a reclusive engineer, founded the company

in 1963 in Deutsch-Wagram, near Vienna. It has since expanded around the world, including a U.S. subsidiary founded in 1985.

Glock handguns are used by police and some countries' military forces, as well as private users. The weapon was significantly lighter, cheaper and more reliable than the models available when it was created.

Glock said on its website that its founder "not only revolutionized the world of small arms in the 1980s, but also succeeded in establishing the Glock brand as the global leader in the handgun industry.'

#### US delegation meets with Mexico's government on migrant influx

Mexican officials moved to clear a migrant encamp-ment on the banks of the Rio Grande river Wednesday as U.S. officials met with Mexico's president to press for measures to limit a surge of migrants reaching the U.S. southwestern border.

Mexico began clearing tents, both occupied and un-occupied, from the encampment in the border city of Matamoros, across from Brownsville, Texas, starting Tuesday. The effort, backed by bulldozers and workers with machetes, continued Wednesday as U.S. Secretary of State Antony Blinken talked with President Andrés Manuel López Obrador in Mexico City.

López Obrador has said he is willing to help, but he wants to see progress in U.S. relations with Cuba and Venezuela, two of the top sources of migrants, along with more development aid for the region.

But Mexico's top priority appeared to be getting the United States to reopen border crossings that were closed because of the migrant surge.

"We spoke about the importance of the border, and about the economic relationship ... the importance of reopening the border crossings, that is a priority for us," Foreign Relations Secretary Alicia Bárcena said following the meeting in Mexico City, which was also attended by U.S. Homeland Security Secretary Alejandro Mayorkas and homeland security adviser Liz Sherwood-Randall. #### **Colorado GOP takes appeal to US Supreme Court**

## Trump's presidential eligibility challenged

DENVER, Dec 28, (AP): The Colorado Republican Party has appealed that state's supreme court decision that found former President Donald Trump is ineligible for the presidency, the potential first step to a showdown at the nation's highest court over the meaning of a 155-year-old constitutional provision that bans from office those who "engaged in insurrection."

The first impact of the appeal is to extend the stay of the 4-3 ruling from Colorado's highest court, which put its decision on pause until Jan. 4, the day before the state's primary ballots are due at the printer, or until an appeal to the U.S. Supreme Court is finished. Trump himself has said he still plans to appeal the ruling to the nation's highest court as well.

The U.S. Supreme Court has never ruled on Section 3 of the 14th Amendment, which was added after the Civil War to prevent former Confederates from returning to government. It says that anyone who swore an oath to "support" the constitution and then "engaged in insurrection" against it cannot hold government office.

The Colorado high court ruled that applies to Trump in the wake of his role in the Jan. 6, 2021, attack on the U.S. Capitol, intended to stop the certification of President Joe Biden's victory in the 2020 presidential election. It was the first time in history that the provision was used to block a presidential contender's campaign.

"The Colorado Supreme Court has removed the leading Republican candidate from the primary and general ballots, fundamentally changing the course of American democracy," the party's attorneys wrote. The filing was

posted on the website of a group run by Jay Sekulow, a former attorney for Trump representing the Colorado Republican Party who announced he was filing the appeal Wednesday. Colorado Republican Party chairman Dave Williams also said the appeal was filed Wednesday.

The attorneys added: "Unless the Colorado Supreme Court's decision is overturned, any voter will have the power to sue to disqualify any political candidate, in Colorado or in any other jurisdiction that follows its lead. This will not only distort the 2024 presidential election but will also mire courts henceforth in political controversies over nebulous accusations of insurrection.'

#### Campaign

The U.S. Supreme Court is expected to take the case, either after the Colorado GOP's appeal or Trump's own appeal. If Trump ends up off the ballot in Colorado, it would have minimal effect on his campaign because he doesn't need the state, which he lost by 13 percentage points in 2020, to win the Electoral College in the presidential election. But it could open the door to courts or election officials striking him from the ballot in other must-win

Sean Grimsley, an attorney for the plaintiffs seeking to disqualify Trump in Colorado, said on a legal podcast last week that he hopes the nation's highest court hurries once it accepts the case, as he expects it will. "We obviously are going to ask for an extremely accelerated timeline because of all the reasons I've stated, we have a primary coming up on Super Tuesday and we need to know the answer," Grimsley said.

More than a dozen states, including Colorado, are scheduled to hold primaries March 5 - Super Tuesday.

To date, no other court has sided with those who have filed dozens of lawsuits to disqualify Trump under Section 3, nor has any election official been willing to remove him from the ballot unilaterally without a court or-

The Colorado case was considered the one with the greatest chance of success, however, because it was filed by a Washington D.C.-based liberal group with ample legal resources. All seven of the Colorado high court justices were appointed by Democrats.

However, the unprecedented constitutional questions in the case haven't split on neatly partisan lines. Several prominent conservative legal theorists are among the most vocal advocates of disqualifying Trump under Section 3. They argue the plain meaning of the constitutional language bars him from running again, just as clearly as if he didn't meet the document's minimum age of 35 for the presidency.

The half-dozen plaintiffs in the Colorado case are all Republican or unaffiliated voters.

Trump has been scathing about the cases, calling them "election interference." He continued that on Wednesday as he cheered a ruling earlier that day by the Michigan Supreme Court leaving him on the ballot, at least for the primary, in that state.

'The Colorado people have embarrassed our nation with what they did," Trump said on Sean Hannity's radio

Hong Kong man jailed: A Hong Kong man was sentenced Thursday to six years in prison after pleading guilty to a terrorism charge under a Beijing-imposed national security law for his involvement in a foiled plot to bomb court buildings.

Prosecutors said Ho Yu-wang, 19, was the plot mastermind who planned to manufacture explosives and target court buildings in 2021. The plot, involving mostly secondary students back then, was foiled due to a police investigation, while no bombs were made and no casualties occurred, the prosecution earlier said. Police said they raided a guesthouse room in 2021 and seized equipment believed to be used for making explosives.

They also alleged Ho had written notes saying that his goal was to destabilize Hong Kong, promote conflicts between the central government and others, and build up a resistance group. Two other defendants received a jail term of up to six years for an alternative charge. (AP)

#### UAE carries GCC RE transactions in 2023

Real estate sale transactions in the GCC over Jan-Oct 2023 reached USD 171.6 Bn, up 21.1% y-o-y from USD 141.7 Bn over the same period in 2022, based on our analysis of available official estimates. Dubai's transactions contributed 52.1% of the region's total transacted value and was able to offset the decline of the other key markets such as Saudi, Qatar and Kuwait. RE value transacted in Dubai increased almost 57% y-oy over Jan- Oct 2023 based on data from DXB Interact, mainly driven by strong pricing for leading developers and off-plan demand of luxury properties and single-family, multi-family homes of above AED 5 Mn. While data for Abu Dhabi was only available until 9M-2023, transacted value of Abu Dhabi real estate also reportedly jumped by 56% over 9M-2023. Both UAE markets pushed the aggregate value transacted in the GCC over Jan-Oct 2023 beyond the full year estimate for 2022 of USD 165.8Bn. The number of transactions in the GCC however remained broadly stable yo-y (-0.8%) over the first ten months of 2023 and reached 495,872 deals, despite a jump of over 43% and 36% witnessed in Dubai & Abu Dhabi's RE transactions.

Nevertheless, the average value per transaction achieved over Jan-Oct 2023 for GCC real estate was up by 22.1% y-o-y, as investors continued to see value for market leading real estate products despite the strong pricing demanded by developers. In Dubai, off-plan transactions continued their strong momentum with offplan volumes jumping by over 40%

over Jan-Nov 2023 when compared to full year 2022 estimates, while registering a healthy 9.8% increase in average off-plan value per transaction

# **Central Bank of Kuwait reports** 2.9 pct increase in total deposits

Govt deposits in local banks rise by 30.5% over 11 mths

#### **KUWAIT CITY, Dec 28:** In November, the Central Bank of Kuwait released its monthly statistics, showcasing a 2.9% increase in total deposits throughout the first 11 months of 2023. The surge amounted to approximately 1.35 billion dinars, elevating the total deposits from 46.91 billion dinars in December 2022 to 48.269 billion dinars by the end of November.

Breaking down the data, the Central Bank categorizes deposits into private sector, government, and public institution deposits. Private sector deposits rose by 1.26%, reaching 37.38 billion dinars in November from 36.914 billion dinars in December. Government deposits in local banks witnessed a substantial 30.5% increase over the 11-month period, soaring from 3.37 billion dinars in December 2022 to 4.405 billion dinars in November. Conversely, deposits of public institutions experienced a 2% decrease, declining from 6.62 billion dinars in December to 6.482 billion dinars in November.

In the realm of credit facilities, the aggregate cash credit facilities provided by banks across various sectors demonstrated a 1.9% growth during the first 11 months of 2023, reaching 53.463 billion dinars by the end of November. This monthly balance increased by 0.6%, marking a rise of about 338 million dinars from October's 53.125 billion dinars. On an annual basis, the balance grew by approximately 1.099 billion dinars compared to 52.364 billion dinars in No-

#### KSE rebounds after 4 consecutive red sessions

KUWAIT CITY, Dec 28: The Kuwait Stock Exchange indices finally rebounded after four red sessions yesterday, the indices recorded an increase, and liquidity was also at high levels, reports Al-Jarida daily.

The general market index achieved gains of 0.80 percent, or 54.04 points, to close at the level of 6786.92 points, with liquidity amounting to 48 million dinars as 173.4 million shares were traded through 11,297 transactions. 120 shares were traded, of which 58 gained and 39 lost, while 23 remained unchanged.

The Premier Market Index gained 0.91 percent, or 66.76 points, to close at 7,439.75 points, with liquidity amounting to 36.2 million dinars; 97.5 million shares were traded through

6,601 transactions. 31 shares were traded, of which 22 gained and 5 lost, while only 4 settled without change.

The main market index also rose by 0.42 percent, or 23.09 points, to close at the level of 5,556.08 points, with liquidity amounting to 11.8 million dinars; 75.9 million shares were traded through 4,696 transactions. 89 shares were traded, of which 36 gained and 34 lost, while 19 remained unchanged.

Good bounce and high liquidity Kuwait Stock Exchange trading began to be stable and declined during the first hour, and the shares of the Eva Block and the Unicap shares were the best.

Rasiyat shares also moved and were in green in addition to common, while the leading shares were stable with no significant changes except for a decline in Boubyan Petrochemicals shares by more than 1 per cent but the situation did not last long, as it was the penultimate session of this year, as the leading stocks moved significantly during the second half of the session, led primarily by Human Soft stock, as it achieved a large jump of 5 percent.

Boubyan Petrochemical's stock also rebounded and entered the green zone, and KFH rose, then NBK stock followed them during the auction periods and turned green, with gains exceeding a percentage point, with the green color prevailing in most of the leading stocks and the Premier Market Index.

Likewise, the main market stocks, especially the EVA bloc, all turned green with varying gains, most of which were limited and headed in profit.

Personal cash facilities, specifically advances from banks, experienced a 1.7% increase since the beginning of the year, totaling 18.796 billion dinars in November from 18.477 billion dinars in December. Consumer loans rose by 0.18%, reaching 1.971 billion dinars, while housing facilities increased by 2% to 16.05 billion dinars. However, private and typical housing loans decreased by 9.7%, amounting to 294.6 million dinars.

Despite the overall growth, new credit facilities witnessed a decline of about 2.6%, falling from 21.27 billion dinars in the first 11 months of 2022 to 20.72 billion in the same period of


2023. Monthly consolidated personal facilities dropped by 29.8%, amounting to 3.38 billion dinars from 4.822 billion dinars, with consumer loans decreasing by 6.6% to 852.2 million dinars. Housing loans also saw a 37% decline, reaching 1.759 billion dinars from 2.79 billion dinars.

Examining bank assets, local banks experienced a 3.2% growth in total assets during the 11 months, reaching 87.189 billion dinars by the end of November from 84.486 billion dinars in December. Net foreign assets of local banks grew by 13.9%, amounting to 11.797 billion dinars. Shareholders' equity in local banks increased by 0.3% to 14.41 billion dinars.

In terms of official reserve assets, the State of Kuwait witnessed a 2.17% decline, with reserves totaling \$45.9 billion at the end of November 2023. This reflects a decrease from \$46.974 billion in November 2022 and a 4.67% decline since the beginning of 2023.

Settlement operations between local banks surged by about 59.14% in November 2023 compared to the previous year, reaching 27.789 billion dinars. Despite a 0.57% annual decrease in transactions via checks, the total value of executed checks declined by 2.84% to 1.504 billion dinars. The average transaction conducted by checks decreased by 2.31% to 7.20 thousand dinars, despite a monthly growth of 1.69%.

Prime office spaces in Dubai (+29%) and Riyadh (+11%) witnessed significant rental increases as demand continued for superior quality office premises, and as certain industries continued to expand their footprint in these markets. Both markets also represent aspirations of becoming the regional headquarters for corporates. Saudi Arabia launched the regional headquarters program (RHQ Program) and announced tax incentives for foreign companies that locate their regional headquarters in the kingdom, including a 30-year exemption for corporate income tax. In Dubai, Asteco reported that there was increased demand, strong rents and waiting lists for well-managed and superior fully fitted office spaces from companies looking to expand their ex-

isting footprint.

Aggregate office space in GCC's key markets is expected to reach 29.85 Mn sq.m by the end of 2023, from 28.54 Mn sq.m in 2022, based on our analysis of consultant data. As a result of the lower supply of quality spaces, prime office spaces in Abu Dhabi (+9%), Jeddah (+11%) and Kuwait (+3.5%) also witnessed gains in rents y-o-y at the end of Q3-2023. BFSI (banking, financial services and insurance) and O&G (oil & gas) and newer sources of demand such as TMT (Technology, Media & Telecom) remain primary drivers of additional take-up of quality spaces. BFSI re-established itself as the key sector driving office space demand within key office markets such Riyadh, Dubai, and Abu Dhabi in 2023, while we expect TMT, AI, Robotics, Healthcare/Pharm and Legal corporates to remain active occupiers, on a continuation of a trend which emerged since 2020. Moreover, certain multi-national corporates will continue to prefer sustainable and energy-efficient office spaces that are LEED certified, with allocation towards wellness components and better infrastructure connectivity.

#### Suitability still underserved in industrial warehouses

Quality and specialized industrial warehouse spaces remained in demand throughout the GCC and in short supply. Rents for such spaces moved higher, widening the rental gap with lower quality spaces, while underserved markets such as Riyadh witnessed YTD rental gains of +30% at the end of Q3-2023 as per CBRE. Demand for warehouses with international specifications remains strong, and owners who can retrofit older assets are able to command a premium, based on consultant data across the

Saudi Arabia introduced the Logisti platform - a transport and logistics initiative under the National Industrial Development and Logistics Program (NIDLP) that targets to provide 59 logistics centers of over 100 Mn sq.m across Saudi Arabia by 2030. Vacancy rates in Riyadh and Jeddah have reportedly reached low single digit percentages. Demand continues from ecommerce, as Modon has signed a deal to build 14 new high-tech warehouses that will be operated based on a public-private sector partnership model. In the UAE, industrial warehouse activity reportedly remained relatively subdued, due to the lack of available stock, as per CBRE. They mentioned that this resulted in a market, where tenants are pushed to comply with landlords' terms with lower incentives. Knight Frank mentioned that international funds and investors were drawn towards the 8.50-8.75% yield in H1-2023 and estimate demand to compress yields by 50bps by the end of 2023. They further expect the yield compression to potentially lower investor demand for industrial assets going forward if interest rates remain high causing yield compression to slow or even reverse.

#### Super-regional malls comeback strong in 2023

All retail real estate markets in the GCC barring Doha (ValuStrat:-7.6%) witnessed rental growth y-o-y at the end of Q3-2023, as per consultant data. Kuwait's retail malls witnessed rental growth of 6%-7% y-o-y by Dec-2023 as per REMI, while JLL mentioned that UAE retail mall owners continued to optimize their spaces to attract footfall and tenant demand which has pushed rents higher by 5% y-o-y in Dubai and Abu Dhabi. Mall space owners across markets continue their focus on increasing their Family Entertainment (FEC) footprint to

retailers are constantly evaluating their mall space expansion plans and the potential impact from increasing omnichannel strategies such Click & Collect, and influencer-driven marketing campaigns to maintain profitability and market share. Nevertheless, we believe that brick-and-mortar retail has established its place in the overall retail market in 2023, and the risk of retail ecommerce largely pinning hopes of achieving continuous market share gains has clearly stabilized. Further, mall space owners of best-in-class super regional malls and community-linked retail spaces should keep natural vacancy rates of 4%-5% and witness rental growth as retail returns as late-cycle favorites. In such landmark mall spaces, retailers would continue to look for more strategic locations for their outlets and will be willing to pay a premium for better visibility. Mall owners of such spaces should be able to mitigate tenant portfolio risks by monitoring KPIs such as footfalls, tenant sales and occupancy cost ratios (OCRs), that should be enable them to achieve contract renewals or tenant rollover at favorable rental rates. In markets such as Dubai, mall operators have reportedly been able to repurpose spaces that witness lower footfall into vibrant service hubs that offer a range of amenities such as clinics and gyms.

#### Developer RE equities to end 2023 as outperformers

Real estate equity indices in the UAE and Saudi Arabia's RE Management & Development index continued their outperformance and witnessed strong gains over Jan-Nov 2023. The Refinitiv GCC Real Estate Total Return Index gained by 19.2% outperformed the MSCI GCC index (-2.4%) over the first eleven months of the year, driven by strong performances from Dubai (+32.9%) and Abu Dhabi (+29.0%) and Saudi Arabia's RE Management & Development (+21.4%) indices. The Saudi REITs index (-12.3%) and Qatar (-8.8%) were major decliners in the regional real estate listed space.

The outperformance of the UAE and Saudi RE Management & Development index is largely restricted to developers who are sector leaders with strong pricing growth and pipelines, who continue to witness robust demand and sell-through of their projects. In 2024, we expect the rally to continue for select developer names and prefer them over REITs and income generators as strong liquidity on their balance sheets would enable them to maintain market share and achieve higher IRR projects and opportunistic cross-border M&A activity. Further, share price sensitivity to potential interest rate cuts and fluctuation of occupancy rates could potentially impact secondary income generating properties more in our view.



ESG Risks and the Kuwaiti Financial Sector

The Kuwait Institute of Banking Studies (KIBS) has recently published a research paper titled "ESG Risks and the Kuwaiti Financial Sector" that discusses the evolution of ESG issues, main frameworks used for reporting, the backlash against the adoption of these issues in various economic activities, and the progress if ESG implementation in GCC countries and Kuwait. The research pointed to the strong scores of Kuwaiti banks in the governance pillar, while highlighting the low score of these banks in the environmental pillar given that the banks are still in an early stage compared to banks in advanced economies. However, the Kuwaiti Boursa issuance of the ESG guide, the central bank support, and banks commitment to sustainability issues could help in raising their scores across different rating agencies over the medium to long term.

What is the definition of the ESG?

The Environmental, Social, Governance (ESG) term could be traced back to the UN's "Who Cares Wins" report, which focused on explaining the interconnectedness between the environmental, social and governance issues to investors. The ESG issues became more prevalent with the developing of the Principles for Responsible Investment (PRI) with the number of signatories growing from 63 to 4,902 by March 2022 and assets under management reaching \$121.3 trillion, up from \$6.5 trillion in 2006 (See chart 1). Rising attention towards climate-related issues, the adoption of the Paris agreement, and the UN 2030 agenda for sustainable development have resulted in increasing the focus of international organizations and central banks to incorporate ESG factors into their supervisory frameworks. However, no uniform definition nor standard disclosure format of ESG has been adopted globally to support assessing ESG criteria across companies and countries. Therefore, the ESG term is often used to express the frameworks used for caring about the environment on a global scale without failing to notice the economic and financial viability. It's also used interchangeably with sustainable investing, denoting an investment approach in which analysis goes beyond purely financial factors. The development of the ESG concepts have led to a growing number of ESG rating agencies that assign ESG scores, as well as new and evolving reporting frameworks, all of which are aiming at improving the transparency and consistency of the ESG reporting. In addition, many ESG investment vehicles have emerged, including green bonds, mutual funds, ETFs, and index funds. These instruments make it easier for investors to align their investment decisions more closely with ESG factors to enhance their sustainability while attracting more investments and customers. Financial institutions have also sought to incorporate ESG issues into their frameworks as they are considered a main pillar for ensuring the adoption of ESG principles in the economy through access to finance, which could help in achieving a smoother transition toward a low carbon economy.

#### Main frameworks for ESG implementation

Growing attention toward environmental and social issues has increased reporting pressures on companies to communicate their ESG commitments and standards, contributing to the development of the ESG reporting standards and frameworks. These frameworks offered a structured approach to evaluating a company's practices and ESG-related business risks and opportunities, including its impact on the environment and society. However, navigating through these frameworks amid rising complexity became increasingly important for companies and financial institutions in recent years given that each framework focuses on different aspects of ESG and has its own reporting requirements. For example, the Carbon Disclosure Project (CDP) focuses specifically on the institution's carbon footprint, whereas the GRI covers the reporting of inclusiveness of stakeholders, sustainability, and integrity. Moreover, the Task Force on Climate Disclosure (TCFD) is primarily focused

on the renewable energy and financial ESG disclosures, while Sustainability Accounting Standards Board (SASB) aims at providing relevant information eligible for comparing the performance related to sustainability issues across companies and countries. Therefore, companies should first determine their ESG goals before choosing a suitable reporting framework given the lack of standardization and the continuous development of reporting frameworks overtime, which could increase the scope of coverage into new areas that

The pushback against implementing ESG standards

The increased focus on ESG issues has drawn criticism to the attempts to incorporate them with businesses operations and investments. Critics often refer to limited ability of the private sector to reverse climate change without having adequate regulations, they also point to the incompatibility of ESG standards with profit maximization as they imply taking additional investment risk to promote social and environmental policy goals. Moreover, ESG metrics and the lack of reporting standardization while some companies engage in "greenwashing", which include exaggerating their ESG commitments for marketing purposes, making it difficult to compare ESG performance among different companies. In addition, some companies focus on superficial shortterm changes rather than addressing core systemic issues. Criticism has also reached ESG analytics, and their materiality topics focus on the environmental and social issues instead of focusing on the impact of ESG factors on firm valuation. However, supporters of ESG standards see criticism as a necessary step that helps in refining strategies while reconciling controversial topics including climate change, energy transition, profitability, and shareholder's value. Moreover, regulators around the world are encouraging firms to focus on their long-term sustainability and value creation while aiming to prevent greenwashing through holding businesses accountable for their ESG commitments. Also, many steps to standardize the ESG metrics are underway such as the SASB, the TCFD, and the GRI are working on creating consistent frameworks for measuring and reporting ESG performance. By standardizing metrics, implementing regulatory oversight, promoting long-term approach, engaging with stakeholders, and finding the right balance between profit and purpose, ESG can evolve into a powerful tool for sustainable and ethical business practices. Accordingly, the outlook for ESG policies adoption remains positive though efforts are being made to

address the legitimate concerns of ESG critics to ensure its long-term viability. The state of ESG implementation

in the GCC countries The GCC economies are more vulnerable to the challenges of sustainability and the impact of climate change. In response to these challenges, countries visions included multiple elements that emphasize diversifying economies away from oil dependence, increasing the share of renewables in energy mix, achieving SDG goals, and align their emission with Paris agreement baseline scenario. Sustainable finance emerges as a crucial tool to achieve these targets, which allows the GCC to align policy

making with international development

priorities. However, ESG standards have yet to register a sufficient impact on the banking industry despite the shift towards enhanced ESG reporting and rising awareness of its benefits.

The banking sector in the GCC economies remains a significant contributor to GDP and the main source for financing. Therefore, this presents an opportunity to accelerate the transition in these countries through vigorous adoption of sustainable finance policies and ESG standards. Banks in the region are advancing in this area as most banks nul sh sustainahility while adhering to the ESG disclosure standards published by stock exchanges around the region, which include a recommended set of metrics that shows the company's ability to hed ity related risks and ide portunities to create long stakeholders.Nevertheles forms and standards in

implementation Banks in Kuwait have made a solid progress towards the adoption of sustainable policies. Almost all banks publish annual sustainability reports that tackle their efforts in reducing carbon footprints, the responsible usage of water and energy resources, and their climate-related policies and materiality topics. Moreover, listed banks in the Kuwaiti Boursa adhere to the ESG voluntary disclosure guidelines, which helps in unifying reporting practices while being in line with United Nationsled Sustainable Stock Exchanges (SSE) initiative, and the KPIs from the World Federation of Exchanges (WFE). The Central Bank of Kuwait (CBK) also played a supporting role through issuing various laws, directives, and instructions for data protection, updating corporate governance regulations, and cybersecurity initiatives. In addition, the recent ESG directives, which included imbedding ESG factors within banks' governance, strategy, and risk management while stressing the need for including climate-related factors in the process of the Internal Capital Adequacy Assessment Process (ICAAP) These directives were in line with Basel core principles of effective supervision as they are sufficiently broad and resilient to include supervisory responses to climate financial risks. Furthermore, the CBKgave priority to green products in its regulatory sandbox tests. However, Kuwaiti banks adoption of ESG practices is relatively recent, same as other banks in the GCC region, putting them at the early stages compared to other major banks in the advanced economies

and emerging markets. However, Kuwaiti banks' ESG scores remain within the GCC banks average, ranging between medium to high risk (Sustainalytics), average (MSCI), and satisfactory ESG performance (Refinitiv) (See table 1), which points to the need for more efforts to align their ESG targets and goals with the international standards, have clear targets, especially in the environmental front, and be more specific in defining their materiality topics. For example, Refinitiv ESG scores (which is based on FY2021 and FY2022 data) show that Kuwaiti banks strength relies in the governance pillar, which could be explained by the strong supervisory framework adopted by the central bank and the recommendations of the Basel committee following the GFC (See table 2). Social pillar sub-groups scores have a high variation between banks, while the environmental pillar scores are low especially within the innovation subgroup, driving the attention towards the need for new sustainable finance related products and encourage banks to set medium term GHG emission and resource use targets (See Chart 2). In addition, Moody's rating agency have rated Kuwaiti banks credit impact score (output of the rating process that indicates ESG factors impact on the rating of an issuer or transactions) from "moderately negative (CIS-3)" to "neutral to low (CIS-2)", reflecting a limited impact of ESG factors on banks ratings. Moody's ESG analysis include the issuer profile scores (transaction outright exposure to ESG risks/ benefits and ESG specific mitigants) which gave most Kuwaiti banks a "neutral to low (G-2)" in the governance pillar, "moderately negative (S-3)" score in the social pillar, and a "highly negative (E-4)" score, highlighting that dependence on oil, transition. and social risks related to regulatory and litigation risks represents the largest risks that banks are exposed to (See table 3). These scores point to the Kuwaiti banks need to further adopt sustainable finance strategies while identifying transitional and physical risks, their impact on operations, the cost of interruptions, and other factors that allows for a better understanding of financial exposure related to such issues and their effects on the balance sheet components. However, we expect these scores to increase over time given the rising banks awareness about the importance of these scores, and the banks efforts in developing their disclosure formats to better communicate their ESG targets to investors and stakehold-

#### Main conclusions and recommendations

Rising awareness on climate related issues with the need to achieve development pathways that are inclusive and resilient, global financial systems are undergoing a transformation to incorporate sustainability factors into their operational frameworks. Therefore, a growing number of financial institutions have adopted policies, regulations, guidance, and practices to reduce and manage ESG risks stemming from financial activities-including climaterelated risks, and to encourage the flow of capital that have environmental, climate, and social benefits. The growing exposure of the GCC region, including the Kuwaiti banking system, to the global financial markets and the growing share of ESG financial assets to a systemically relevant share across key markets and assets classes have pushed the GCC region to include the incorporation of ESG issues and sustainable finance into their future vision agendas while propelling banks to communicate their ESF commitments to investors and customers. However, the incorporation of the ESG factors and materiality topics within Kuwaiti banks' frameworks is still at an early stage, especially in the environmental pillar. Nevertheless, a holistic approach is needed to ensure a more grounded approach in ESG advancement. The issuance of the Kuwaiti Boursa voluntary guide will help in unifying the disclosure formats across sectors, while the CBK's update of corporate governance, the new cybersecurity framework, and the CBK circulars related to sustainable finance and ESG risks will strengthen banks ESG ratings overtime. Nevertheless, disclosure guides should be subject to continuous updates given the evolution of new concepts and frameworks. Moreover, banks should align their targets and disclosures with international standards while fostering ESG training and capacity building to enhance their capabilities and the integration of ESG

practices in their strategic objectives.

#### court rejects Alibaba's effort to quash case

A judge in New York has ruled that Alibaba must face a lawsuit by a U.S. toymaker alleging that the Chinese ecommerce giant's online platforms were used to sell coun-

There was no immediate comment by Alibaba, China's biggest ecommerce company. Among other things, Alibaba based its motion to dismiss on how it was named in the lawsuit as Alibaba.com instead of its formal corporate name. In its complaint, Kelly Toys said

sales of faked Squishmallows by merchants using Alibaba sites continued despite earlier lawsuits

demanding they be stopped. The company had earlier filed the case to stop about 90 ecommerce companies from selling counterfeit versions of the toys. Alibaba was named as a defendant in March.

#### 2 models of Apple Watch can go on sale again

Two higher-end models of the Apple Watch can go on sale again after a federal court temporarily lifted a sales halt ordered by the International Trade Commission over a

patent dispute.

The ITC, a federal agency, ordered the halt in October to block Apple from using specific technologies underpinning a blood-oxygen measurement system in its Series 9 and Ultra 2 watches. Apple has been embroiled in an intellectual property dispute with

the medical technology company Masimo over those technologies. Apple cut off online sales of the watches in the U.S. last week just days from the Christmas holiday

to comply with the ITC ruling. The court's action will allow sales of the two Apple Watch models pending its decision on whether to also permit sales as it weighs Apple's ap-

The two watch models will be available at Apple's online store by noon Pacific Time on Thursday,

according to the company. They will return to some Apple stores Wednesday, with wider availability expected by Saturday.

This isn't the first patent road-block the Apple Watch has run into as the company morphs its watches into health-management devices.

Last year, the ITC ruled that Aple had infringed on the wearable EKG technology of AliveCor - a decision the Biden administration declined to overturn. (AP)

#### Rapid development of AI threatens to significantly upend publishing industry

## NY Times sues OpenAI, Microsoft for using stories to train chatbots

NEW YORK, Dec 28, (AP): The New York Times is striking back against the threat that artificial intelligence poses to the news industry, filing a federal lawsuit Wednesday against OpenAI and Microsoft seeking to end the practice of using its stories to train chatbots.

The Times says the companies are threatening its livelihood by effectively stealing billions of dollars worth of work by its journalists, in some cases spitting out Times' material verbatim to people who seek answers from generative artificial intelligence like OpenAI's ChatGPT. The newspaper's lawsuit was filed in federal court in Manhattan and follows what appears to be a breakdown in talks between the newspaper and the two companies, which began in April.

The media has already been pummeled by a migration of readers to online platforms. While many publications - most notably the Times - have successfully carved out a digital space, the rapid development of AI threatens to significantly upend the publishing industry.

Web traffic is an important component of the paper's advertising revenue and helps drive subscriptions to its online site. But the outputs from AI chatbots divert that traffic away from the paper and other copyright holders, the Times says, making it less likely that users will visit the original source for the information.
"These bots compete with the con-

tent they are trained on," said Ian B. Crosby, partner and lead counsel at Susman Godfrey, which is representing The Times.

#### **Committed**

An OpenAI spokesperson said in a prepared statement that the company respects the rights of content creators and is "committed" to working with them to help them benefit from the technology and new revenue models.

"Our ongoing conversations with the New York Times have been productive and moving forward constructively, so we are surprised and disappointed with this development," the spokesperson said. "We're hopeful that we will find a mutually beneficial way to work together, as we are doing with many other publishers.

Microsoft did not respond to re-


quests for comment. Artificial intelligence companies scrape information available online, including articles published by news organizations, to train generative AI chatbots. The large language models are also trained on a huge trove of other human-written materials, which helps them to build a strong command of language and grammar and to answer questions correctly.

But the technology is still under development and gets many things wrong. In its lawsuit, for example, the Times said OpenAI's GPT-4 falsely attributed product recommendations to Wirecutter, the paper's product reviews site, endangering its reputation.

OpenAI and other AI companies, including rival Anthropic, have attracted billions of dollars in investments very rapidly since public and business interest in the technology exploded, par-

ticularly this year. Microsoft has a partnership with

OpenAI that allows it to capitalize on the company's AI technology. The Redmond, Washington, tech giant is also OpenAI's biggest backer and has invested at least \$13 billion into the company since the two began their partnership in 2019, according to the lawsuit. As part of the agreement, Microsoft's supercomputers help power OpenAI's AI research and the tech giant integrates the startup's

technology into its products. The paper's complaint comes as the number of lawsuits filed against OpenAI for copyright infringement is growing. The company has been sued by several writers - including comedian Sarah Silverman - who say their books were ingested to train OpenAI's AI models without their permission. In June, more than 4,000 writers signed a letter to the CEOs of OpenAI and other tech companies accusing them of exploitative prac-

tices in building chatbots. As AI technology develops, growing fears over its use have also fueled labor strikes and lawsuits in other industries, including Hollywood. Different stakeholders are realizing the technology could disrupt their entire business model, but the question will be how to respond to it, said Sarah Kreps, director of Cornell University's Tech Policy Institute.

**CAMBRIDGE**, Massachusetts, Dec 28, (AP): Social media companies collectively made over \$11 billion in U.S. advertising revenue from minors last year, according to a study from the Harvard T.H. Chan School of Public Health published on Wednesday.

The researchers say the findings show a need for government regulation of social media since the companies that stand to make money from children who use their platforms have failed to meaningfully self-regulate. They note such regulations, as well as greater transparency from tech companies, could help alleviate harms to youth mental health and curtail potentially harmful advertising practices that target children and adolescents.

To come up with the revenue figure, the researchers estimated the number of users under 18 on Facebook, Instagram, Snapchat, TikTok, X (formerly Twitter) and YouTube in 2022 based on population data from the U.S. Census and survey data from Common Sense Media and Pew Research. They then used data from research firm eMarketer, now called Insider Intelligence, and Qustodio, a parental control app, to estimate each platform's U.S. ad revenue in 2022 and the time children spent per day on each platform. After that, the researchers said they built a simulation model using the data to estimate how much ad revenue the platforms earned from mi-

KFC China's parent company opened its 10,000th restaurant

in China last month and aims to have stores within reach of half of China's population by 2026. McDonald's is planning to open 3,500 new stores in China over the next four years. And Starbucks invested \$220 million in a manufacturing and distribution facility in eastern China, its biggest project outside the U.S.

#### Investments

This is surely not what Chinese President Xi Jinping had in mind as he made the case to American CEOs about the upside of China's "superlarge market" last month while he of world leaders. The investments in fast food and other consumer goods, while Washington is curbing exports of computer chips and other advanced technology, don't fit into China's own blueprint for modernizing its economy.

"As you try to interpret the signals from McDonald's and Starbucks" and other chains, says Phil Levy, chief economist at the supply chain management firm Flexport, "note what the industries are: These are not high-tech burgers.'

And while some U.S. companies are increasing investments in the world's second-largest economy, overall foreign investment began falling this year. In the July-September quarter, net foreign direct investment in China sank to a deficit of \$11.8 billion, the first quarterly deficit since Beijing began publishing the data in 1998.

As tensions simmer between China and its Western trading partners, many multinational companies are shifting investments to other places, such as Southeast Asia or India, or repatriating their earnings. That has sapped China of a key engine when its economy has yet to fully recover from the disruptions of the pandemic and a property industry crisis that has been a drag on growth.

Beijing puts some of the blame on U.S. government policies.

Commerce Ministry spokesperson Shu Jueting said recently, The U.S. side has repeatedly politicized economic, trade and technology issues and overstretched the concept of security, abused export control measures, and restricted trade and investment in China by its own enterprises, which is forcing enterprises to give up opportunities in the Chinese market and opportunities for win-win cooperation."

US companies are picky

about investing in China

A survey released in September by the U.S.-China Business Council, which represents American companies in China, suggested that the uncertainty has taken a toll: 43% of its members said China's business environment had deteriorated in the past year, and 83% said they were less optimistic about China than they had been three years ago. Twenty-one percent said they were investing fewer resources in China, versus just 10% who were investing more.

Surveys of European and Japanese companies have shown similar results

While China's market is gigantic, it's ailing. Unemployment among young Chinese rose to over 20% by June, the last time the government released that data. Housing prices are falling and the stock market is down nearly 15% since the summer. That's left many Chinese feeling nervous about spending.

Still, bullishness for China as other industries try to de-risk and detangle from Beijing may be a profit-increasing strategy for the fast-food industry.

"We believe there is no better time to simplify our structure, given the tremendous opportunity to capture increased demand and further benefit from our fastest-growing market's long-term potential," McDonald's CEO Chris Kempczinski said as the Chicagocompany announced in November it was increasing its minority 20% ownership of its McDonald's licensed stores in China, Macau and Hong Kong to 48%.

Burgers and lattes don't raise the sorts of friction that more high-tech industries have in the complicated U.S.-China relationship. Those strains have persisted under the presidency of Joe Biden, who took office vowing to do more to counter China's expanding military clout and its menacing of neighbors, to improve the country's treatment of Uyghur and other ethnic minorities, and to crack down on intellectual property theft.

#### **Relations**

Relations hit a low point in February when Biden ordered a Chinese spy balloon that traversed the continental United States to be shot down. Beijing, which claims self-governed Taiwan as its own territory, also protested a stopover in the U.S. by the island's president, Tsai Ing-wen, earlier this year. China answered fresh U.S. controls on exports of advanced computer chips and the technology to make them with limits of its own on exports of vital commodities like graphite, gallium and germanium, all metals used in making semiconductors, solar panels, missiles and radar.

The relationship appears to be stabilizing somewhat as 2023 winds down, highlighted by last month's Biden and Xi meeting outside San Francisco. But since then, Biden's top advisers have said there are no plans to shift the strategy of tightening regulations and blocking U.S.-based high-tech investments in China, citing the need to safeguard national security.

## **New Mexico native will oversee state's \$49 bln** savings portfolio amid windfall from petroleum

SANTA FE, N.M., Dec 28, (AP): A state cabinet secretary and former economist to the Legislature was selected Wednesday to oversee New Mexico's \$49 billion nest egg of savings and trust accounts at the State Investment Council.

As state investment officer, Albuquerque native Jon Clark will oversee financial assets including the New Mexico land grant permanent fund built largely from petroleum production on state trust lands since the 1970s to benefit schools, hospitals and other public institutions.

The 11-member investment council - a board of elected and appointed officials with Gov. Michelle Lujan Grisham serving as chair - conducted a nationwide search that generated more

than 80 applications. Clark in 2019 joined the Economic

Development Department and rose this year to acting cabinet secretary at an agency that administers annual incentives worth hundreds of millions of dollars aimed at creating private employment opportunities, from jobtraining grants to film production "rebates" that can offset nearly one-third

of local spending.

Prior to that, he worked as an analyst and chief economist to the budget and accountability office of the Legis-

Steve Moises retired on Oct. 1 after a 13-year stint as state investment officer. Clark starts work at an annual salary of \$285,000.

Management of New Mexico's state investments has taken on increasing significance amid an unprecedented surge in state government income from oil and natural gas production in the Permian Basin that overlaps southeastern New Mexico and portions of western Texas.

Voters last year approved an increase in annual distributions from the land grant fund to public schools and early childhood education programs. At the same time, state lawmakers have been setting aside billions of dollars in surplus state income each year in a variety of trust accounts for the future, in case the world's thirst for oil

The State Investment Council oversees New Mexico's early childhood education trust, created in 2020 to generate investment earnings and underwrite an ambitious expansion of public preschool, no-cost child care and home nurse visits for infants. The fund already holds rough-

Instagram, meanwhile, derived the greatest ad revenue from users aged 13-17 (\$4 billion), followed by Tik-Tok (\$2 billion) and YouTube (\$1.2 billion).

The researchers also estimate that Snapchat derived the greatest share of its overall 2022 ad revenue from users under 18 (41%), followed by TikTok (35%), YouTube (27%), and Instagram (16%).

#### Reinvented 'Globes' back with new start

BEVERLY HILLS, Calif., Dec 28, (AP): The Golden Globe Awards are back on the first Sunday in January with plenty of behind-the-scenes changes aimed at cementing a yearslong comeback effort.

The show is known for its celebration of film and television and as an early stop for awards season contenders. Scandals have led to a membership revamp and a new broadcaster for the Jan. 7 show, but a key question remains: Will viewers tune in?

Here's what to know about the 81st Golden Globe

Viewers in the United States can catch the ceremony, broadcast live from the Beverly Hilton Hotel, beginning at 8 p.m. Eastern. It will air beginning at 5 p.m. on the West Coast.



The three-hour show will have a strong lead-in since CBS is airing an NFL game directly before the Globes.

CBS says the show will air on its app and stream on Paramount+, but there's an important caveat. Only Paramount+ subscribers with the Showtime add-on will be able to watch the show live. Otherwise, it'll be available on the streaming platform on Monday.

The 81st Golden Globe Awards will be the first maior broadcast of awards season, with a new home on CBS. And while to audiences it might look similar on the surface, it's been a tumultuous few years behind the scenes following a bombshell report in the Los Angeles Times. The 2021 report found that there were no Black members in the Hollywood Foreign Press Association, which voted on the awards.

Stars and studios boycotted the Globes and NBC refused to air it in 2022 as a result. After the group added journalists of color to its ranks and instituted other reforms to address ethical concerns, the show came back in January 2023 in a one-year probationary agreement with NBC. The network did not opt to renew.

In June, billionaire Todd Boehly was granted approval to dissolve the HFPA and reinvent the Golden Globes as a for-profit organization. Its assets were acquired by Boehly's Eldridge Industries, along with Dick Clark Productions, a group that is owned by Penske Media whose assets also include Variety, Deadline, The Hollywood Reporter, Rolling Stone and Billboard.

Comedian Jo Koy, who has headlined several Netflix specials and starred in last year's comedy film "Easter Sunday," will host the Globes.

Organizers cited his "infectious energy and relatable humor" in announcing Koy would headline the event. Hosting the Globes typically requires serving a mix of biting humor to the audience of film and television stars and keeping the ceremony from getting too sloppy.

#### **Categories**

Previous hosts include Ricky Gervais, whose jokes were particularly caustic, the duo of Tina Fey and Amy Poehler and last year's emcee, Jerrod Carmichael. "Barbie" is the top nominee this year, followed

closely by "Oppenheimer."

The films reflect one unique aspect of the Globes they split the top film winners into two categories. With Greta Gerwig's "Barbie" and Christopher Nolan's "Oppenheimer" leading the way, it gives the show a chance to capitalize on the Barbenheimer craze that boosted theaters in 2023.

Films nominated for best motion picture drama include "Oppenheimer," Martin Scorsese's "Killers of the Flower Moon," Bradley Cooper's "Maestro," Celine Song's "Past Lives," Justine Triet's "Anatomy of a Fall" and Jonathan Glazer's "The Zone of Interest."

In the best motion picture musical or comedy category, "Barbie" was joined by Ben Affleck's "Air," Cord Jefferson's "American Fiction," Alexander Payne's "The Holdovers," Todd Haynes' "May December" and Yorgos Lanthimos' "Poor Things."

"Succession" was the top-nominated television program, with nine nods including for series stars Brian Cox, Jeremy Strong, Sarah Snook and Kieran Culkin, followed by Hulu's "The Bear."

The Golden Globe Awards had long been one of the highest-profile awards season broadcasts, second only to the Oscars.

The show was touted as an A-list party whose hosts often took a more irreverent tone than their Academy counterparts. It also only honored the flashiest filmmaking categories - picture, director, actors among them - meaning no long speeches from visual effects supervisors or directors of little-known shorts.

But the voting body was a small group of around 87 members who wielded incredible influence in the industry and often accepted lavish gifts and travel from studios and awards publicists eager to court favor and win votes.

Some years, the HFPA were pilloried for nominating poorly reviewed films with big-name talent in hopes of getting them to the show - the most infamous being "The Tourist," with Angelina Jolie and Johnny Depp. In the past decade, they've more often overlapped with the Oscars. The show also recognizes television.


Before the expose and public relations crisis though, no one in the industry took much umbrage with who was voting on the awards. The show had become an important part of the Hollywood awards ecosystem, a platform for Oscar hopefuls and was, until recently, a reliable ratings draw. As of 2019, the broadcast was still pulling in nearly 19 million viewers. In 2023, NBC's Tuesday night broadcast got its smallest audience ever for a traditional broadcast, with 6.3 million viewers.

The group nominating and voting for the awards is now made up of a more diverse group of over 300 people from around the world.

**JOHANNESBURG:** Renowned South African playwright, producer and composer Mbongeni Ngema has died in a car crash at the age of 68, his family said

"Ngema was killed in a head-on car accident while returning from a funeral he was attending in Lusikisiki in the Eastern Cape this evening," his family said in a statement Wednesday. The celebrated playwright was a passenger in the vehicle

involved in the crash. He was best known for creating the hit Sarafina! which first premiered on Broadway in 1988. It was adapted into a musical drama starring Whoopi Goldberg in 1992, becoming an international success and was nomi-

nated for the Tony and Grammy Awards. Sarafina! told the story of a young student and how she inspired her peers to fight against racial segregation in apartheid South Africa after her teacher was thrown in jail.

Apartheid was an institutionalized system that discriminated against non-whites and ensured South Africa was ruled by the minority white population from 1948 till the early 1990s.

Ngema's body of work included the lauded theatre production Woza Albert, which first showed in 1981 and went on to win more than 20 awards across the world. The political satire explored the second coming of Jesus Christ as a black man, returning to **South Africa** as a black man. (AP)

#### **Comedy legend leaves a laughter-filled legacy**

## Comedian Tom Smothers dies at 86

LOS ANGELES, Dec 28, (AP): Tom Smothers, half of the Smothers Brothers and the co-host of one of the most socially conscious and groundbreaking television shows in the history of the medium, has died at 86.

The National Comedy Center, on behalf of his family, said in a statement Wednesday that Smothers died Tuesday at home in Santa Rosa, California, following a cancer battle.

"Tom was not only the loving older brother that everyone would want in their life, he was a one-of-a-kind creative partner," his brother and the duo's other half, Dick Smothers, said in the statement. "Our relationship was like a good marriage - the longer we were together, the more we loved and respected one another. We were truly

When "The Smothers Brothers Comedy Hour" debuted on CBS in the fall of 1967 it was an immediate hit, to the surprise of many who had assumed the network's expectations were so low it positioned their show opposite the top-rated "Bonanza."

But the Smothers Brothers would prove a turning point in television history, with its sharp eye for pop culture trends and young rock stars such as the Who and Buffalo Springfield, and its daring sketches - ridiculing the Establishment, railing against the Vietnam War and portraying members of the era's hippie counterculture as gentle, fun-loving spirits - found an immediate audience with young baby boomers. The show reached No. 16 in the ratings in its first season.

#### Creative

It also drew the ire of network censors. After years of battling with the brothers over the show's creative content, the network abruptly canceled the program in 1970, accusing the siblings of failing to submit an episode in time for the censors to review.

Nearly 40 years later, when Smothers was awarded an honorary Emmy for his work on the show, he jokingly thanked the writers he said had gotten him fired. He also showed that the years had not dulled his outspokenness.

"It's hard for me to stay silent when I keep hearing that peace is only attainable through war," Smothers said at the 2008 Emmy Awards as his brother sat in the audience, beaming. He dedicated his award to those "who feel compelled to speak out and are not afraid to speak to power and won't shut up and refuse to be silenced.

During the three years the show was on television, the brothers constantly battled with CBS censors and occasionally outraged viewers as well, particularly when Smothers joked that Easter "is when Jesus comes out of his tomb and if he sees his shadow, he goes back in and we get six more weeks of winter." At Christmas, when other hosts were sending best wishes to soldiers fighting overseas, Smothers offered his to draft dodgers who had moved to Canada.

In still another episode, the brothers returned blacklisted folk singer Pete Seeger to television for the first time in years. He performed his song "Waist Deep in the Big Muddy," widely viewed as ridiculing President Lyndon Johnson. When CBS refused to air the segment, the brothers brought Seeger back for another episode and he sang it again. This time, it made the air.

After the show was canceled, the brothers sued CBS for \$31 million and were awarded \$775,000. Their battles with the network were chronicled in the 2002 documentary "Smothered: The Censorship Struggles of the Smothers Brothers Comedy Hour."

#### Talent

"Tom Smothers was not only an extraordinary comedic talent, who, together with his brother Dick, became the most enduring comedy duo in history, entertaining the world for over six decades - but was a true champion for freedom of speech, harnessing the power of comedy to push boundaries and our political consciousness," National Comedy Center Executive Director Journey Gunderson said in a statement.

Thomas Bolyn Smothers III was born Feb. 2, 1937, on Governors Island, New York, where his father, an Army major, was stationed. His brother was born two years later. In 1940 their father was transferred to the Philippines, and his wife, two sons and their sister, Sherry, accompanied him.

When the Japanese bombed Pearl Harbor, the family was sent home and Maj. Smothers remained. He was captured by the Japanese during the war and died in captivity. The family eventually moved to the Los Angeles suburb of Redondo Beach, where Smothers helped his mother take care of his brother and sister while she worked.

The brothers had seemed unlikely to make television history. They had spent several years on the nightclub and college circuits and doing TV guest appearances, honing an offbeat comedy routine that mixed folk music with a healthy dose of sibling rivalry.

They would come on stage, Tom with a guitar in hand and Dick toting an upright bass. They would quickly break into a traditional folk song - perhaps "John Henry" or "Pretoria." After playing several bars, Tom, positioned as the dumb one, would mess up, then quickly claim he had meant to do that. As Dick, the serious, short-tempered one, berated him for failing to acknowledge his error, he would scream in exasperation, "Mom always liked you best!

They continued that shtick on their show but also surrounded themselves with a talented cast of newcomers, both writers and performers.

Among the crack writing crew that Smothers headed were future actorfilmmaker Rob Reiner, musician Mason Williams and comedian Steve Martin, who presented Smothers with the lifetime Emmy. Regular musical guests included John Hartford, Glen Campbell and Jennifer Warnes.

Bob Einstein had a recurring role as Officer Judy, a dour Los Angeles police officer who once cited guest Liberace for playing the piano too fast. Leigh French, as the hippie earth mother in the segment "Share a Little Tea With Goldie," always appeared to have been drinking something brewed with more than just tea leaves.

The brothers had begun their own act when Tom, then a student at San Jose State University, formed a music group called the Casual Quintet and encouraged his younger brother to learn the bass and join. The brothers continued on as a duo after the other musicians dropped out, but began interspersing comedy with their limited folk music repertoire.

Their big break came in 1959 when they appeared at San Francisco's Purple Onion, then a hot spot for new talent. Booked for two weeks, they stayed a record 36. Booked into New York's Blue Angel, they won praise from The New York Times, which described them as "a pair of tart-tongued singing comedians." But to their disappointment, they couldn't get on "The Tonight Show," then hosted by Jack Paar.

"Paar kept telling our agent he didn't like folk singers - except for Burl Ives," Smothers told The Associated Press in 1964. "But one night he had a cancellation, and we went on. Everything worked right that night."

#### Audience

The brothers went on to appear on the TV shows of Steve Allen, Ed Sullivan, Garry Moore, Andy Williams, Jack Benny and Judy Garland. Their comedy albums were big sellers and they toured the country, especially colleges.

Television first came calling in 1965, casting them in "The Smothers Brothers Show," a sitcom about a businessman (Dick) haunted by his late brother (Tom), a fledgling guardian angel. It lasted just one season.

Shortly after CBS canceled the "Comedy Hour," ABC picked it up as a summer replacement, but the network didn't bring it back in the fall. NBC gave them a show in 1975 but it failed to find an audience and lasted only a season. The brothers went their separate ways for a time in the 1970s. Among other endeavors, Smothers got into the wine business, launching Remick Ridge Vinevards in Northern California's wine country.

"Originally the winery was called Smothers Brothers, but I changed the name to Remick Ridge because when people heard Smothers Brothers wine, they thought something like Milton Berle Fine Wine or Larry, Curly and Mo Vineyards," Smothers once said.

They eventually reunited to star in the musical comedy "I Love My Wife," a hit that ran on Broadway for two years. After that they went back on the road, playing casinos, performing arts centers and corporate gatherings around the country, remaining popular for decades.

**LONDON: Bill Granger**, the Australian chef, food writer and restaurant owner who brought Aussie-style food to international capitals from London to Seoul, has died.

Granger's family said on social media Tuesday that the chef died in a hospital in London on Christmas Day.

"A dedicated husband and father, Bill died peacefully in hospital with his wife Natalie Elliott and three daughters, Edie,





**Inès** and **Bunny**, at his bedside in their adopted home of London," the family statement said. It gave no further details.

Born in 1969 in Melbourne, Australia, Granger was a self-taught cook who launched a chef's career over three decades after dropping out of art school. He opened his first restaurant in 1993 in the Sydney suburb of Darlinghurst, where he soon became known for his breakfasts served at a central communal table. (AP)

# **Steep rise in elder deaths amid pandemic struggles**

HARRISBURG, Pa., Dec 28, (AP): Pennsylvania recorded a steep increase in the deaths of older adults following an abuse or neglect complaint the last few years, as COVID-19 ravaged the nation, complaints grew and agencies struggled to keep caseworkers on staff.

The staggering increase shown in state data - from 120 deaths reported in 2017 to almost 1,400 in 2022, a more than tenfold increase - may have had several contributing factors, and the state and county-level agencies that field and investigate complaints gave varying answers explaining why.

Mostly, Pennsylvania's Department of Aging and county-level agency officials speculated that it had to do with a growing population of people 65 and older, an increase in complaints and the devastating impact of the COVID-19 pandemic on older adults.

One county said errors in its data entry procedure - now corrected - led to undercounting in the initial years. Another pointed to cases staying open longer.

Some county agencies wouldn't an-

swer questions about it at all.

The increase came as agencies in Pennsylvania and nationwide struggled to keep caseworkers on staff through the pandemic and manage caseloads.

The Department of Aging said it has no data to suggest that a lack of caseworkers contributed to the increase in deaths, and suggested that the data could be misleading since the deaths may have had nothing to do with the original abuse or neglect complaint.

"The data does not make any correlation between the provision of protective services and how the older adult died," the agency said.

#### **Causes**

The department doesn't track causes of death, and individual county-level agencies aren't required to provide that information to the state. When caseworkers enter data on a case, they are given a choice of reasons for why a case was closed, including death.

If anything changed in recent years, state efforts to train caseworkers likely improved how data on cases was recorded and entered, former department employees and county officials said.

It's not clear to what extent better data collection helps explain Pennsylvania's increase, but evidence suggests that other similar jurisdictions did not see a similarly steep increase.

Officials from the National Adult Protective Services Association said they had not heard discussion of such a steep increase in deaths among the state programs that investigate abuse and neglect complaints of adults.

Although states have different practices for investigating complaints and collecting data, two states with similar-sized populations - Illinois and Michigan - also reported significant increases in deaths.

But those increases - roughly triple during the pandemic - were nowhere near the proportion of Pennsylvania's.

The broader death rate of older adults did not increase nearly as steeply during the pandemic, going from about 4% of those 65 and older in 2018 to 4.5% in 2021, according to federal statistics.

All told, Pennsylvania's data shows caseworkers reported closing 120 neglect or abuse cases due to death in 2017.

That number rose steadily every year. It reached 784 in 2020, 1,284 in 2021 and then 1,389 in 2022 - rising by more than 10 times in five years, or more than 1000%.

The number of complaints called into caseworkers rose over that period, too. But it rose by a much smaller proportion - by about half, or 55%, accord-

This year, the pace of cases closed due to death slowed a bit, but still remained well above 2020's pace. Through the first six months of 2023, the number of deaths was 528, on pace for 1,056 over the full year.

The department also doesn't disclose the details of case investigations or what shortcomings it finds when it inspects the performance of the 52 county-level "area agencies for aging" across Pennsylvania.

Some agencies are county-run while others are nonprofits, and field calls about elder abuse or neglect under state contracts. They employ caseworkers to investigate complaints and coordinate with doctors, service providers and if necessary, law enforcement.

Most calls involve someone who lives alone or with a family member or caregiver. Poverty is often a factor.

The department released the deaths data in response to a request filed by The Associated Press under Pennsylvania's open records law.

#### Records

The AP submitted the request after reviewing internal emails - also released through an open records request - showing that state protective services staff had become alarmed at how Philadelphia's agency had handled the cases of three people in 2021.

The department refused to disclose the fate of the three people - including when a state lawmaker asked about it following AP's story on it.

In Pennsylvania, state data shows caseworkers took longer to close some cases as the pandemic wore on and often handled more cases than state regulations allow.

The shortage of caseworkers during the COVID-19 pandemic became so extreme that, in 2021, then-Gov. Tom Wolf's administration took the extraordinary step of marshaling state employees to handle investigations for Philadelphia's agency.

The agency, the nonprofit Philadelphia Corporation for Aging, reported four cases closed due to death in 2017. By 2020, that number rose to 220. In 2021, it hit 472 before dropping to 295 in 2022.

Bob Burns, the director of Dauphin County's Area Agency on Aging, said he wasn't surprised by the increase in deaths, considering the ravages of the

COVID-19 pandemic.

The shortage of caseworkers leads to higher caseloads because it might take longer to close out a case, Burns said. But, he said, counties began using experienced caseworkers up front to quickly investigate complaints to determine right away if a person was in a

dire situation.

Gov. Josh Shapiro's secretary for the Department of Aging, Jason Kavulich, told lawmakers in a March hearing that many county-level agencies "are struggling for a variety of reasons, from not having adequate staff to a high number of staff turnover to some serious training issues, that we need to get them up to an acceptable level of understanding."

Even before the pandemic, the performance of area agencies on aging had drawn criticism.

In 2018, the state's internal investigation agency, the Office of Inspector General, issued a report that criticized how the state and counties handle abuse and neglect reports. That report pointed to failures to properly investigate complaints under timelines required by state law and inadequate staffing of the Department of Aging office that monitors those agencies. "And three years after the first COVID-19 vaccines were developed, billions of people remain unprotected - overwhelmingly in developing

"When the next pandemic arrives, we must do better. But we're not yet ready. We must prepare and act on the lessons of COVID-19.

"Working together, the world must improve surveillance of viruses, strengthen health systems, and make the promise of Universal Health Coverage a reality.

"We must renounce the moral and medical disaster of rich countries hoarding and controlling pandemic healthcare supplies,

and ensure everyone has access to diagnostics, treatments and vaccines. And we must strengthen the World Health Organization's authority and financing.

"These efforts are making progress. The High-

"These efforts are making progress. The Highlevel meeting on Pandemic Prevention, Preparedness and Response in September agreed a robust political declaration. This complements the nego-

tiations on a pandemic accord in Geneva.

"On this International Day of Epidemic Preparedness, I urge countries to build on this momentum by delivering a strong, comprehensive accord, focused on equity, by next year's World Health Assembly in May.

"Together, let's act on the lessons of COV-ID-19, prepare, and build a fairer, healthier world for all," the Secretary-General concluded.

The International Day of Epidemic Preparedness is observed annually by the UN member states on December 27.

# Customizing mRNA is next frontier for personalized medicine: expert

While using mRNA as medicine is new, mRNA has been inside you for your entire life. The cells in your body create mRNAs that serve as instructions to make specific proteins you need to function. Researchers can create new mRNAs to correct those instructions when they aren't working.

I am a molecular biologist who studies how cells control their mRNAs to make the proteins they need, a basic question of how life works at the cellular level. While most scientists studying mRNAs are not creating new drugs, this fundamental understanding of how mRNA works laid the foundation for other scientists to create effective mRNA medicines like COVID-19 vaccines.

By tweaking these instructions, scientists can create powerful new medicines to repair a variety of problems in your cells.

To understand what the mRNAs in your cells are doing for you, let's start with its more well-known relative, DNA.

DNA is like a set of cookbooks full of different recipes, or genes, to make proteins. People make about 100,000 different proteins that are essential for normal function, such as breaking down nutrients and carrying out other important chemical reactions.

When cells need to make one of those proteins, they don't read the recipe directly from DNA. Instead, they make a copy in the form of a similar molecule - that's the mRNA. The "m" stands for messenger, as mRNA contains the message, or recipe, that codes for a protein. About one-third of a cell's energy is devoted to maintaining the proteins you need, so cells are well equipped to recognize, use and then destroy mRNA once it's no longer needed.

The language of mRNA is made of four building blocks called nucleotides, nicknamed A, U, C and G. The recipe to make a protein contains only three-letter words, meaning there are just 64 possible words. Scientists know exactly which words correspond to each protein building block, so they can easily read an mRNA recipe and know what protein will be made. Mutations in the DNA cookbook can alter or delete an mRNA recipe, leading to disease-causing mistakes in critical proteins.

While mRNA has been within us all along, it took decades of research for scientists to understand how cells recognize mRNA and use it to

make protein. But it eventually became clear that mRNA could be a powerful medical tool.

Since scientists understand how mRNAs code for proteins, they can easily create recipes for any protein. These recipes can be edited to meet the needs of the patient, whether this means providing a whole new mRNA recipe or tweaking an existing one to make a slight variation of the protein.

Producing mRNA treatments is also scalable because scientists can make large amounts of mRNA in the lab. The method to make one mRNA is the same for all mRNAs, unlike typical drugs where each compound has its own unique chemistry and requires different manufacturing methods. It's like learning how to make risotto: Once you've learned the basic recipe, you can make endless variations.

Another benefit of using mRNAs as drugs are cells' natural ability to destroy them when they aren't needed. Since mRNAs aren't permanent, doses can be easily changed to meet the changing needs of the patient.

#### Immune

The COVID-19 vaccines from Moderna and Pfizer-BioNTech are the first mRNA-based medicines to gain FDA approval. When these vaccines are injected into your arm, the mRNA is absorbed into some of your cells, which read the mRNA recipe and make the spike protein the virus uses to invade cells. Your immune system recognizes this spike protein as foreign and makes antibodies that prepare your body to attack the virus if you encounter it later.

These mRNA vaccines demonstrate the flexibility of mRNA-based therapies. As the virus that causes COVID-19 mutates, new viral variants can evade existing antibodies and cause new waves of illness. However, scientists are able to sequence new mRNA recipes based on these variants and tweak the vaccine recipes to match them. Boosters containing these edited recipes teach your body to make new antibodies that target the latest versions of the viral spike protein.

There are already clinical trials underway for other mRNA-based vaccines, including vaccines for seasonal flu, herpes and respiratory syncytial virus.

There are also many more vaccines in earlier stages of development to combat diseases like nor-ovirus, Lyme disease, Zika and shingles.

The potential for mRNA-based medicine extends beyond vaccines to prevent infectious disease. One example is the use of mRNA to treat cancer.

Some mRNA cancer treatments work like vaccines by training your immune system to specifically target cancer cells. As cancer cells grow, they rapidly gain mutations in many genes. Cancer vaccines contain mRNA recipes based on mutations commonly found in certain types of tumors. When injected into the body, the mRNAs from the vaccines allow normal cells to make those mutated proteins and broadcast them to the immune system, ramping up production of antibodies. These antibodies bind to cancer cells and mark them for immune attack.

Finding the correct protein target for a given cancer is essential. Ideally, the target is unique to the cancer cell so the immune system doesn't attack healthy cells. The target protein should also be easy for the immune system to sense, making surface proteins good targets. Cancer vaccines, like BioNTech's BNT-111 for melanoma, target the most common cancer mutations in hope of helping many patients. But patients won't benefit from the treatment if their cancer cells don't have those particular mutations.

Because it is so easy to change the mRNA recipes, cancer vaccines can be part of a personalized medicine plan where doctors sample a patient's tumor, sequence key genes and adjust the mRNA treatment to include recipes specific to that patient's cancer. Clinical trials using this personalized approach for pancreatic cancer are underway.

Many diseases arise from cells making the wrong protein, a mutant version of protein or too little of the normal protein. If scientists can deliver a corrected version of the mRNA recipe to enough affected cells, then the mRNA will provide the means to make the proper protein.

Scientists are exploring the use of mRNA to treat heart disease, neurodegenerative disease, bone loss and much more. Although most of these studies are still very early in development, they provide hope for future treatments using mRNA for protein replacement therapies.

For example, one mRNA drug increases the formation of new blood vessels, which can improve wound healing in diabetic patients who have poor blood circulation and higher amputation risks. Another example is using mRNAs to treat propionic acidemia, a disease where children have low levels of two liver proteins that normally prevent toxic byproducts from building up in the body.

The ability to easily customize and produce mRNA increases their potential as effective, personalized therapies - with fewer side effects - that can help many people. (AP)

Captain Pat Cummins took his 10th five-wicket total in test matches earlier to help Australia earn a 54-run first-innings lead. But Pakistan came back from the innings break to take the wickets of Usman Khawaja for a duck and Marnus Labuschagne for five, leav-

## LawConnect edges Comanche in 'Sydney-Hobart' yacht race

HOBART, Australia, Dec 28, (AP): LawConnect won line honors in the 78th edition of the Sydney to Hobart yacht race on Thursday, holding off defending champion Andoo Comanche by less than a minute in an exciting finish between the super maxis.

The pair of 100-foot yachts had dueled for much of the race and were well ahead of the rest of the fleet of 103 yachts that started the race on Tuesday in Sydney harbor.

LawConnect, which was runnerup in the last three editions of the race, finished in 1 day, 19 hours, 3 minutes, 58 seconds. Comanche's time was 1 day, 19 hours, 4 minutes, 49 seconds - a margin of just 51 seconds.

#### **SAILING**

It was the second-closest finish in Sydney to Hobart history after Condor of Bermuda beat Apollo by seven seconds in 1982.

Both yachts performed several late jibe tactics as they attempted to secure the lead.

"I can't believe that result. Honestly, it is a dream come true," LawConnect's skipper and owner Christian Beck said. "They took the lead pretty close to the line and we thought there was no way we could get it back.

"A wind gust came around. It was a complete surprise. There were guys who couldn't watch. It was very nerve wracking.'

Comanche holds the race record of 1 day, 9 hours, 15 minutes, 24 seconds, set when it won the race

Comanche and LawConnect were clear front-runners from just out of Sydney harbor. The pair began the trip down the New South Wales south coast at a fast clip but



## India crash to innings defeat in first Test against South Africa

CENTURION, South Africa, Dec 28, (AP): Debutant left-arm pacer Nandre Burger took 4-33 as India crashed to a stunning innings' defeat to South Africa on day three of the first test on Thursday.

Burger's burst combined with two wickets each for Kagiso Rabada and Marco Jansen saw India bowled out for a paltry 131 runs in its second innings. That meant South Africa won the first test by an innings and 32 runs, taking a 1-0 lead in the twomatch series.

Burger finished with a match haul of 7-83 on his test debut, while Rabada finished with 7-91 across both innings. The latter had picked 5-59 in the first innings.

The Proteas earlier finished the first innings on 408, thanks largely to a marathon 185-run knock from Dean Elgar. India had been bowled out for 245 in its first innings.

Trailing by 163 runs, India's second innings got off to the worst possible start and never recovered.

Opener Yashaswi Jaiswal had been dropped at slip off the very first ball, but he didn't survive long. He was caught behind off a rising delivery by Burger for five runs off 18 balls.

Skipper Rohit Sharma was bowled for an eight-ball duck when Rabada broke through his defence in the third

Shubman Gill played some attractive shots but was bowled playing across the line against Burger, out for 26 off 37 balls.

Gill had added 39 runs with Kohli for the third wicket. Even so, it wasn't a comfortable partnership and India went to tea at 62-3.

#### Rare home victory for Chelsea

LONDON, Dec 28, (AP): **Trailing 1-0 to Everton** at halftime, Manchester City didn't much look like the newly crowned Club World Cup champions despite the new golden FIFA badge on the front of the players' shirts.

But Pep Guardiola had a simple message to his players at the break.

"The manager (told us) at halftime to just keep believing, we haven't got this badge for no reason," City midfielder Phil Foden said. "In the second half, yeah, wow, I think we blew them away with the way we played.'

Foden started the comeback by equalizing in the 53rd minute, before Julian Alvarez's penalty and a late goal by Bernardo Silva secured a 3-1 win at Everton to put the defending champions back into the Premier League's top four.

The trip to Saudi Arabia for the Club World Cup was perhaps a bit of a distraction and allowed rivals Liverpool and Arsenal to widen the gap at the top. But City now can now fully refocus on the task of winning an unprecedented fourth straight Premier League title, and this was a vital first step in showing that it can't be counted out despite a recent poor run of form.

Even with Erling Haaland still out with a foot injury, City showed it has more than enough attacking threat to turn things around against a team that had beaten Newcastle and Chelsea in its last two league home games. But it came as a cost as center back John Stones had to go off with an ankle injury before halftime.

"It doesn't look good," Guardiola said about the injury, "but we will see." League victories at Stamford Bridge have been hard to come by for Chel-

sea in 2023. But their last home game

of the year ended in a 2-1 win over Crystal Palace after substitute Noni Madueke converted a late penalty for the hosts.

It was just Chelsea's sixth home league win of the calendar year, and Mauricio Pochettino's team once again struggled to turn possession into goals for much of the game. With Chelsea fielding the club's youngest ever starting lineup for a Premier League game thanks to a slew of injuries and suspensions - the Blues took the lead through Mykhailo Mudryk in the 13th minute. But the hosts missed several chances to double their advantage before Michael Olise equalized just before the break.

Just as it looked like Chelsea's inefficiency up front would cost it again,

The rest of the standings include Al-Salmiya in fifth with 15 points, Kazma with 13 points, Al-Fahaheel with 12, Al-Shabab with 11, and Khaitan with 6 points. Al-Jahra sits in tenth and last place with only two points.

In the first match, Al-Qadsia aims to maintain pressure on the top two teams and assert its dominance over Al-Fahaheel, having previously defeated them 3-0 in the first division. The team is currently guided by Serbian assistant coaches Degan Arsov and Saleh Al-Sheikh due to the health issues of head coach Muhammad Ibrahim.

The second match features Al-Arabi, determined to continue its winning streak despite a tough battle in the last round against Al-Shabab, securing victory with a lone goal in stoppage time.
