NEW U.K. SANCTIONS ON IRAN ENTITIES, INDIVIDUALS UN clash on Iran enrichment, drones

Russian fighter jets have 'harassed' American drones over Syria for the third day in a row this week, the U.S. military said. Tension between Russian and U.S. troops is not uncommon in Syria as both countries conduct patrols on the ground as well as overflights. Syria's 12-year conflict has left half a million people dead and over 1 million wounded. The U.S. military said in a statement that Friday's encounter lasted for about two hours during which three MQ-9 drones were 'once again harassed' by Russian fighter aircraft while flying over Syria. Kill, kidnap attempts rise

UNITED NATIONS, July 8, (Agencies): The United States and its Western allies clashed with Russia and Iran at the U.N. Security Council on Thursday over Tehran's advancing uranium enrichment and its reported supply of combat drones to Moscow being used to attack Ukraine.

The sharp exchanges came at the council's semi-annual meeting on implementation of its resolution endorsing the 2015 nuclear deal between Iran and six major countries known as the Joint Comprehensive Plan of Action, which the U.S. under then-President Donald Trump left in 2018.

At the start of the meeting, Russia's U.N. Ambassador Vassily Nebenzia accused Britain, which hold the council presidency, of seeking to hold "an openly politicized show" by inviting Ukraine to take part in the meeting when it is not part of the JCPOA. He demanded a procedural vote on its participation.

U.S. deputy ambassador Robert Wood countered, accusing both Iran and Russia of participating in the transfer of drones used in Ukraine without prior Security Council approval in violation of the 2015 resolution.

'This is a matter of life or death for the Ukrainian people," Wood said. "It would be unconscionable to deny Ukraine the opportunity to speak at this meeting when it is experiencing the devastating effects of Iran's violation of resolution 2231 firsthand."

Britain's U.N. Ambassador Barbara Woodward, who was chairing the council meeting, then called for a vote on whether Ukraine could participate. Twelve members voted "yes," while China and Russia voted "no" and Mozambique abstained.


In other news, UK Foreign Secretary James Cleverly announced plans for a new sanctions regime to hold Iran to account for its 'hostile and destabilising behaviour around the world."

He outlined, in a press release on Thursday, new action in response to Iran's "threats to the UK and our partners, including a new sanctions regime which will give the UK greater powers to target Iran's key decision makers.

"Iran has increased its efforts to kill or kidnap individuals perceived to be enemies of the regime outside of Iran, including in the UK, the statement reads.

"Since the start of 2022, the UK has responded to more than 15 credible threats to kill or kidnap British or UK-based individuals by the Iranian regime.

"The regime has publicly called for the killing or capture of these individuals and in some cases detained and harassed the individual's families in Iran.

Most seizures in issues of debt

Highest ever, travel ban imposed on 20,939 persons in '23 Ist quarter

KUWAIT CITY, July 8: In an indication of the increase in judicial claims of all kinds, statistics issued by the Statistics and Research Department of the Ministry of Justice for the first quarter of this year revealed that the number of procedures related to travel ban amounted to 20,939, which is the largest number in terms of procedures of the ruling execution departments, reports Al-Seyassah daily.

The statistics explained that the total procedures implemented in the various execution departments in all governorates during the month of April alone amounted to 538,958, which are distributed as follows: Capital 142,851, Hawally 86,226, Ahmadi 76,485, Jahra 65,134, Mubarak Al-Kabeer 64,492, Farwaniya 102,569, then the airport by 1,201.

The procedures for requesting executive seizure of what the debtor owes to others accounted for the largest number of procedures, amounting to 32.3 percent, followed by the procedures for the minutes of executive attachment of what belonged to the debtor with others by 15.4 percent. The procedures for opening a file to adjust alimony constituted the least number of procedures, which is 0.01 percent.

In terms of the branches, the statistics indicated that the procedures of the Capital branch represented the largest number in April, with 26.5 percent, followed by the procedures of the Farwaniya branch by 19 percent, and then the procedures of the Hawally and Ahmadi branches with 16 percent and 14.2 percent respectively. It was followed by the procedures of the Jahra and Mubarak Al-Kabeer branches with 12.1 percent and 12 percent respectively, and finally the airport branch with 0.2 percent.

By comparing the procedures of the execution departments during the month of April 2023 with the same month in the previous year, the following seems clear:

The total number of procedures in April increased by 61.6 percent compared to the corresponding month of the year 2022 due to an increase in the number of procedures in most branches, with the highest increase in the Farwaniya branch reaching 130.9 percent, followed by the Mubarak Al-Kabeer branch with 106.5 percent, then Jahra branch with 60.7 percent, the Capital and Ahmadi branches with 45.7 percent and 44.9 percent respectively and finally the Hawally branch with 35.3 percent. A decrease was only witnessed in the airport branch by 58.2 percent during this month compared to the corresponding month the previous year.

KUWAIT CITY, July 8, (KUNA): Kuwait's women have been playing, throughout history, their leading and effective role in the

country's development in all fields.

They have overcome challenges and achieved outstanding successes that enabled them get leadership regionally and interna-

They proceeded with their role in building society until they obtained their political rights on May 16, 2005, when they ran for, and elect, the National Assembly in 2006 for the first time.

Meanwhile, MP Marzouq Al-Ghanim has submitted a proposal to increase the allowance for higher education students up to KD300 per month. He suggested that the allowance for excellent students should be increased to KD 350 for those under class B, KD400 for class A1 and KD450 for class A.

MPs Shuaib Al-Muwaizri, Shuaib Shaaban, Abdullah Fehad, Osama Al-Zaid and Soud Al-Asfour have proposed obligating banks to refund the interest illegally collected from clients since 1992.

MPs Shuaib Al-Muwaizri, Shuaib Shaaban, Abdullah Fehad, Hamad Al-Medlej and Soud Al-Asfour have submitted a bill to amend Civil Service Law number 15/1979 on granting equal salaries to employees with the same job scale in different institutions; in addition to specifying the minimum salary at KD1,000.

Kuwait last among GCC on 'cost of living' index

KUWAIT CITY, July 8: Numbeo, one of the largest databases covering cost of living prices in the world, ranked Kuwait as the cheapest Gulf country on the cost of living index for the first half of 2023, and ranked 14th in the Arab world on the same index, reports Al-

Every half year, Nambio issues the cost of living index, which is a relative index that measures consumer prices in 139 countries, including prices for groceries, restaurants, transportation and utilities, while the index does not include accommodation expenses such as rent or mortgage.

At the level of the most expensive Arab cities, Dubai came first, followed by Al-Khobar, then Abu Dhabi, Doha, Manama, Beirut, Riyadh, followed by Ramallah, Jeddah, Muscat, Sharjah, Dammam, then Amman and Kuwait.

On the other hand, Kuwait ranked fourth in the Arab world and second in the Gulf, after Amman, Beirut and Dubai, in the crowding index during the first six months of 2023.

Nambio stated that the average time it takes an individual in Kuwait to move his car from one place to another within a city or region takes 34.7 minutes, while in Dubai, for example, it takes 36.6 minutes, and Istanbul 51.8 minutes.

In the quality of living index for the first half of 2023, Kuwait ranked last in the Gulf and seventh in the Arab world, while Muscat came first, followed by Abu Dhabi, Dubai, Doha, Jeddah and Riyadh.

The quality of living index measures the general quality of life in a city or country, and takes into account various factors that affect an individual's quality of life, including purchasing power, pollution levels, housing affordability, cost of living, safety, health care quality, travel times and climatic conditions.

Filipino gang held in fraud case

KUWAIT CITY, July 8: (KUNA): The Ministry of Interior has busted a gang counterfeiting official documents for the Philippine community in the coun-

The ministry said in a statement that the counterfeiters had been apprehended upon guidelines by the Deputy Prime Minister and Minister of Interior Sheikh Talal Khaled Al-Ahmad Al-Sabah to clamp down on any violators of the country's laws.

Personnel of the MoI department of combating counterfeiting succeeded, in collaboration with the Ministry of Foreign Affairs and the Philippine embassy, in holding 33 Filipinos who issued fraudulent documents for members of the community -- such as study certificates, marriage contracts and driving

They have been referred to the relevant authorities for further legal procedures against them.

Assets undeclared: According to a recent report by the Kuwait Anti-Corruption Authority (Nazaha), its audit committees inquired about balances, accounts, securities, and the movement of accounts and local banks for 515 who are covered by financial disclosure statements. About 5,253 leaders and individuals who are required to submit their financial disclosure statements to Nazaha failed to do so in the last six years - between 2017 and 2022. They

were referred to the Public Prosecution,

six times more than those registered

from 2017 to 2019. The files of those who defaulted were referred to the Public Prosecution, but it was noted that they recorded an increase during the last three years, as 1,426 failed to submit their declarations in 2022, 1,038 in 2021, and 2,062 in

In this context, the total declarations submitted during the first three months of this year amounted to approximately 3,350. The total declarations received by Nazaha since the approval of its executive regulations six years ago amounted to 33,347 declarations, of which 51 percent submitted their declarations for the first time, 11,000 were covered with the declarations until March, and 5,232 left

The audit committees inquired about 430 balances and movements of local bank accounts belonging to those subject to financial disclosure, with the aim of examining the elements of ownership of securities through the Kuwait Clearing Company.

The committees also inquired about the balances and movement of accounts for 85 securities covered by the financial disclosure statement through the Kuwait Investigations Unit of the National Committee for Combating Money Laundering and Terrorist Financing. All the required data were received.

Nazaha, through the initiative to review and enhance accountability in state-owned companies, is working in partnership with the State Audit Bureau to strengthen efforts to implement a guide for auditing the application of governance rules in this type of com-


Japanese Shiro, stubborn goat

The Japanese, Shiro Oguni, was visiting a shelter for elderly people with memory impairment or memory loss. He was saddened by their psychological condition, their complete isolation from society and

everyone's neglect of them, and the harsh loneliness that shrouded the hearts of the shelter's inmates. Then, he got a





tasty food to attract the customers in addition to the humanitarian factor that is to hire elderly suffering dementia.

Dementia is the case which makes the elderly forgetful because of many reasons including some suffering from chronic diseases. As for Alzheimer's, it is one of the most common types of dementia, and it is characterized by a gradual decline in memory and the deterioration of mental and executive functions in particular, and it occurs as a result of the formation of abnormal deposits in the brain that affect neurons.

The restaurant project succeeded, commercially and humanely, in a way that exceeded the expectations of its owner, although 37% of the customers' orders were contrary to what they asked for, and that was the source of laughter for both parties, which made the project special, but 99% of its visitors came out happy with the experience, the distinctive food, with promises to come back.

Civilization is not a religion, a fancy car, an ornate temple with high ceilings, wide streets, huge schools, organized and complex educational structures characterized by advanced technology, excellent infrastructure, implementation of governance, and cultural development among the population. Humanly, this is what we are missing, with great regret, in our societies.

The story of the restaurant reminded me of an old anecdote that I touched on years ago about a couple who always complained of poor memory, and that was the reason for their disagreement a lot over small matters.

They, on the advice of their children, visited a number of doctors, and performed various blood tests and examinations, but they did not seem to worry much, and the last mental health consultant advised them to accept the matter as it was, and to try to write down what they had to do, to avoid being forgetful.

They returned from the doctor's office, and on the evening of that day the man told his wife that he wanted to prepare himself a tomatoes and cheddar cheese sandwich, and he asked her if she wanted him to prepare the same for her, and she said she would love to have one but with cucumber and white

She told him to write her request on a piece of paper so that he remembers what she wanted, but he repeated the request and promised her that he would not forget, because he did not vet suffer from dementia, but she insisted on her request, and he also insisted on his position and left the room angry.

He returned after a short absence, carrying a plate containing a tomato sandwich with cheddar cheese, and another plate containing two fried eggs, and placed it in front of her. She nodded in acceptance, saying; but you forgot to add the fries and ketchup, like I asked

'End justifies means ... reading of political scenario in Kuwait'

"FIVE years ago, and before that another three, I wrote about the beginning of new-old political alliances, and it was a monitoring and follow-up of those soft political harbingers, which hide under their shadows -- an alliance between allies on the one hand and rivals on the other, alliances imposed by a new political reality in the past eight years, which got rid of the traditional political forces, in

successive stages since 2003, with two parallel paths, the first representing the straw that broke the back of the political currents and forces, with a qualitative breakthrough -- this time -- for their leaders through the policy of carrots and sticks, benefiting from the disappearance of the generation of traditional leaders, and the rise of the generation of leaders who seek



personal gains and glory," columnist Dr. Mohammad Al-Meqatei wrote for Al-Jarida daily.

"The second is the elitist and artificial regression that has been inflated by the rising leadership, despite its shallow formation, the decline of its national and principled positions, and its rush to look for crumbs from under the bargaining table, and this has been largely achieved.

"This coincided with the continuation of the old and new individual leaders, who have flexibility similar to the agility of a butterfly when it comes to its colors, disguise, and pretending contrary to the truth, in order to preserve their continuity and survival, which was the case for those leaders, who maintained their continued political presence, and revolved in the orbit of all stages with a remarkable change to dress gracefully.

"It simulates the changes of the political scene, at times it wears the clothes of the opposition, and at other wears the garb of loyalty, the third invisibility, the fourth wisdom and good luck, and sometimes in the victim and the orphan, so they get what they want.

"After the end of the tactical hibernation stage, voluntary or forced or both at the same time, its return or political presence began to follow, including those people who thought they had retired from public life, theorizing, mobilizing and opening un-

"I spotted early in my previous articles, these changes, so whoever believed or considered people to be rivals, at some point, it was apparent that they would return as allies, a departure from all expectations and analyses, which missed the softness of the bear and the gracefulness of the coloration of those personalities. It is clear in all of this that political pragmatism is the political style that has proven its success through the persistence of its personalities in all stages of political work, especially since 1985.

"The end justifies the means, which governs and directs that understood pragmatism. Literature, treatises and terminology have been used to express the agility of pragmatism.

"Politics in Kuwait and the smoothness of its approach, the last of which was called "politics is the art of the possible", and despite the validity of the principle and the soundness of its content, it was used and employed poorly, so it became a pretext to justify political Machiavellianism and interest pragmatism, and the public interest was dissipated unheeded, and the papers of national and moral principles and values were blown away by the winds

"In order to achieve the aim, until all considerations were lost and mixed, and began to openly adopt these trends, which represent a political apostasy in the national and even parliamentary action, and the employment of this path will be exacerbated, as the private interest and gains at the expense of the country have become the goal, and faces and personalities that we thought were destined to fade. The national will not change and will not be accepted for bargaining, so our bet on it went unheeded.

"In the same context, other terms appeared to justify the thought and principles of the end justifying the means, and the term national reconciliation was used in reverse for the same purpose. We also have the terms exchange of roles, the jurisprudence of the stage, the soft side, reform from within, and political flexibility, all of which appear to justify the behaviors and paths of political apostasy.

"In its shadow is a state of jumping into the political scene, so staying in this scene, even if it was through devices to revive the national sense, is the worm, and the national sense and the practices associated with it from these personalities and their suspicious and changing alliances have become artificial and complex manifestations that quickly discover their falsity, in front of unacceptable national issues bargain.'

Also:

"The warnings that came from the national drug prevention project "Ghiras" should be taken very seriously given the dangerous nature, as Kuwait is classified as a target country and a consumer of drugs, after it was for a short time a transit point,' columnist Dr. Issa Mohammad Al Omairi wrote for **Al-Anba** daily.

"Away from the numbers, levels, and statistics related to this scourge in our beloved country, we can briefly review some of its numbers, as statistics show there are about 20,000 drug addicts in Kuwait, which is a very dangerous figure for a small country, and therefore we must pause and look carefully at these figures, and the efforts exerted by the state in this regard and must pay tribute to the concerned authorities so that they increase their role and be more stringent with traffickers and consumers. Also, the state is required to deal with this issue according to its size since the issue is much bigger than what we see and hear.

Therefore, we stress the maximization of the role in combating everything that would limit the effect of this devastating scourge, whether going after the merchants of death or those who use, promote and distribute it etc. It is undoubtedly a difficult task but in this case, the state's efforts must include the use of international expertise and strengthen its cooperation by concluding agreements with several countries to combat this phenomenon.

"Also, the state must tighten and toughen the pen-

alties, as is the case in some countries that have enacted death laws for anyone related to this scourge, whether close or far, abusers, addicts, and so on.

"On the other hand, we say that the efforts in this country must be joint among the community and the family itself in terms of raising awareness and warning of the dangers of this scourge, and moreover, what some have called for is the necessity of conducting an addiction test or drug abuse test for some of the activities that take place in the country, such as during marriage or applying for a job and so on.

"These things undoubtedly contribute to greatly limiting its spread. Also, the state must closely examine new arrivals to see if they abuse or show traces of abuse, which is important in curbing this

"Prices have increased without any reason, other than the greed and desire of some to empty the pockets of citizens and expatriates. Some greedy people have resorted to the most heinous exploitation of others, sucking their blood. How did these people become 'vampires', desiring the blood of others?" columnist Adel Al-Mezaal wrote for Al-Anba daily.

"Where is price control? Where are the trade teams and their pillars, especially the consumer protection?! Why do they let these people eat the flesh of others? Will we remain captives and dependent on every importer who sets prices that suit him and satisfies his greed, without regard for the

people's purchasing power?
"Who will save us from such greedy people who do not fear God and His Messenger? They they did not find anyone that forbids them and hold them accountable. Why?!

"For example, cooperative societies were established to provide the daily needs of every citizen and expatriate at the lowest price and without much profit. But why do some cooperatives allow unscrupulous companies to increase prices and provide them with space to display their products? If only the cooperatives stopped dealing with such companies, and have not provided them with the opportunity to market or offer their products, we would have closed the window through which these companies look at the consumer who has no one to protect him. Why do you deal with the exploiters of people, companies and prices?

"This also applies to other markets. Is it possible that the price of fish had been increasing insanely until it reached the level that no one could believe? God blessed us with a beautiful sea, yet the price of

"Likewise, the price of meat keeps on increasing. These exorbitant prices have been emptying people's pockets, in addition to the fact that the prices of plane tickets have doubled.'

"This is an invitation and advice to the esteemed members of the National Assembly — to codify priorities in the current round, as they have only six or seven sessions, that is, if quorum is achieved and the government attends," columnist **Yousif Hajji** wrote for **Annahar** daily.

"This means limited discussion of the issues raised, in light of the increase in priorities. I believe that the priorities they announced, which keep on increasing daily, need dozens of sessions to discuss and approve them.

"Citizens want a real and tangible achievement in order to trust the Assembly during the next stage. The government's statement bodes well — that it will extend a hand of cooperation with the current

"This is why we ask the MPs to refrain from expanding the space for populist issues and demands. They should meet with the government through the specialized committees before raising any issue or demand, and to find out whether the government can discuss these issues and approve them. It is better than wasting time and effort, without any real and tangible achievement in the end.

"We hope the MPs will meet among themselves and coordinate their priorities. They have to determine what is important and the most important. We noticed that every lawmaker has a priority and a populist proposal, wanting to include it to the list of priorities.

Some demands and proposals are impossible. It is difficult for the government to agree on them, hence, the need for discussions and meetings, while referral to the specialized committees must be post-

"On issues that the government expressed interest and willingness to cooperate with the Assembly to approve them, these must be put forward, discussed and approved in the next sessions."

"Does every big and small step really need direct instructions from His Excellency the Minister?" columnist Iqbal Al-Ahmad wrote for Al-Qabas

"Is it very important and necessary that no one in any position in the ministry should speak or say anything about any achievement, except after he precedes his words with...'under the directives of His Excellency the Minister and Undersecretary so and so...'? Is it necessary that any presentation of the efforts of the interior men in any field comes with this introduction?

"Yes, the Minister of Interior is in charge of laying down a general strategy aimed at accomplishing the tasks of the ministry. He is thanked for it, but is it not necessary for every interior man of various military ranks to inform us whether he did the job alone or as a task force under the directive of His Excellency the Minister?

"Everyone is talking about this...It would have been good to hear from the decision-making officials or whoever issues such instructions in the ministry, if any.

"I am almost certain that this policy was an act of diligence on the part of one of the public relations officials - to publicize the activities and achievements of the ministry.

"This trend may be a form of 'courtship' or distinction, but it seems to have continued and become a norm for all interior ministers."

Drop in crime rate as Mol efforts bear fruit

New security plans prove successful

KUWAIT CITY, July 8: It seems that the plans for security deployment and rounding up lawbreakers in the country, which were being implemented by the Ministry of Interior for some time, are bearing fruit, reports Al-Qabas daily.

The security plans, which were recently implemented in the country and were based on the development of the field and informational security monitoring system, contributed to the rapid discovery of many crimes. It imposed a disciplined security reality according to which the percentage of serious criminal offenses decreased by 20 percent from January 2023 to May 2023, compared to the same period in 2022.

According to informed security sources, this visible decrease in serious criminal crimes, which are classified as "disturbing crimes" such as premeditated murder, robbery and armed robbery, is the result of the great efforts exerted by the security services with the aim of strengthening secu-

rity and stability in the country.

The security leaders and personnel, on their various capacities, have demonstrated a distinct ability in dealing positively with challenges and the accelerating changes. With a solid security doctrine, governed by legal controls, they have been able to advance their national message.

The sources revealed an estimated 20 percent decrease in serious criminal offenses in the country during the period from January 2023 to the end of May, compared to the same period in 2022.

This decrease in the occurrence of such serious crimes, which are classified by security authorities as "disturbing crimes" such as premeditated murder, armed robbery, theft of bank customers, robbery with violence, impersonation of police officers, burglaries and use of firearms, comes as an inevitable result of the efforts exerted by the security services in the country during this period.

The huge seizures of narcotics, psychotropic substances and liquor bottles, and the clampdown on drug dealers, smugglers and pushers are among the main reasons that led to a decrease in serious crimes.

Among the reasons are also the wide and intensive security deployment, the continuous security campaigns, the arrest of residency violators, those wanted by the security forces, and fugitives, the tightening of security control over the land, air and sea ports, and the expansion of the circle of receiving information.

The sources praised the development of the field and informational security monitoring system, affirming that it contributed to the speedy detection of many crimes recently. They also praised the efforts exerted by the police officers, especially those working in the field.

They highlighted that one of the most prominent posi-

tive factors that emerged recently is the great cooperation between the security sectors and relevant authorities such as the General Administration of Customs, the Public Author-

ity for Manpower, and other parties.

The sources affirmed that the success of the police in discovering some of the crimes that occurred recently happened because of the use of modern and sophisticated methods to entrap criminals, and working as much as possible to prevent crime before it occurs, as well as using modern technology to combat crimes.

798.000 traffic violations: According to the half yearly statistics issued by the General Traffic Department, the number of direct traffic violations recorded during the first half of this year amounted to 798 thousand, reports Aljarida daily.

half of this year was 37 thousand. These accidents were dealt with by the patrol officers of the General Traffic Department and the supporting security agencies.

On the other hand, in implementation of the decisions of the ministers of Interior from the Gulf Cooperation Council and based on the strategy of the Ministry of Interior to complete the development of the bilateral electronic link system with the aim of exchanging data between Kuwait and the United Arab Emirates, a third meeting was held on Tuesday at the headquarters of the General Administration of Information Systems to discuss the stage of the bilateral traffic link proposals, the exchange of fingerprints of the deportees, and the development of the networking system between the two countries. The meeting was held in the presence of a number of representatives of the Human Resources and Information Technology sectors, the traffic sector, the criminal security sector, and the general administration for following up the affairs of ministerial councils and committees, as well as in the presence of a number of security leaders within the Emirati delegation.

The meeting aimed at completing the linking of all other traffic and security services, which contribute to linking the traffic and security system among the GCC countries.

49 corruption reports received: The Acting Head of the communications reception office at the Kuwait Anti-Corruption Authority (Nazaha) Fahad Al-Daihani revealed that Nazaha received 49 reports of corruption incidents this year, some of which are currently under formal and substantive studies, and some others are subject to investigation procedures, reports Al-Rai Daily.

2 in murder probe: The Public Prosecution has referred a citizen and an expatriate to the Criminal Court for the abduction, illegal detention and premeditated murder of Mubarak Ali Al-Rashidi, as well as the possession of drugs for trading and personal consumption, reports Al-Qabas daily.

The prosecution started investigations since the victim was reported missing, in cooperation with various State agencies like the Criminal Security Sector at the Ministry of Interior and judicial authorities in Egypt.

"The crime of illegal gain is one of the new corruption crimes that are not stipulated in the Penal Code or complementary laws. The criminalization of this act coincided with the development of modern means that are used to commit crimes against public funds or abuse of office to gain individual interest.

The goal is to set penalties that are enough to deter anyone who tempts to loot public money or tamper with the integrity of the public office, so that it affects every act committed inside or outside the country.

The proof of this crime happens by vetting committees in the authority that are specialized in analyzing the data of the financial disclosure statement of the subject, as for this purpose, it may make a number of inquiries about the components of the financial disclosure and exercise its powers to view bank accounts of the one who shifts the burden of proving the sources of funds that are not commensurate with his resources

Whenever he is unable to justify the increase in the elements of his financial liability or the decrease in his obligations due to his assumption of a job capacity, he is considered to have committed the crime of illegal gain. The penalties for this reach imprisonment for a period less than five years, confiscation of the illegitimate gain, and a fine equivalent to the value of the confiscated funds as well as dismissal from public office."



PAM launches new electronic services for domestic workers

'Domestic worker can file two types of complaints'

KUWAIT CITY, July 8: The Public Authority for Manpower (PAM) has launched new electronic services through the "electronic forms" portal for domestic worker disputes, which includes nine types of complaints, reports Al-Qabas daily.

It is now possible for a domestic worker to file two types of complaints - the first against the employer, and the second against the recruitment agency

In addition, an informed source explained that PAM has provided an electronic form for domestic workers, which will enable them to submit a complaint, either related to "claiming late salaries, financial dues, receiving documents, leaving the country or transferring". The form also allows workers to register a complaint with the recruitment office, irrespective of whether it is related to final cancellation of travel, human trafficking, illegal employment, or dealing with a refund.

The authority maintains the right of the employer by giving him the right

to file complaints with the recruitment office, irrespective of whether his claim is related to final cancellation of travel, refund of the value of the deportation ticket, or refund of the recruitment amount. He will also have the right to complain about the worker if the latter escapes from work or does not have the desire to perform his duties.

Through the portal, a domestic worker can apply for a residence extension if he had registered a previous complaint. It is also possible to issue a clearance certificate for the domestic worker through electronic forms


Kuwaiti photographer wins 2 awards in Italy

relationships with organised criminal gangs in UK and across Europe to expand the capability of its networks. The UK will not tolerate such threats," according to the statement.

The United States, Britain, France and Ukraine have urged U.N. Secretary-General Antonio Guterres to send investigators to Ukraine to examine debris from drones used in Russia's attacks, insisting that resolution 2231 gives him a mandate to open an investigation.

Russia insists he has no such authority and Nebenzia warned the U.N. Secretariat against taking any such action. Iran's U.N. Ambassador Amir Saeid Iravani added that any U.N. findings "based on such illegal activities is null and void."

U.N. political chief Rosemary DiCarlo said in her briefing to the council that France, Germany, Ukraine, the U.K. and U.S. had written letters concerning alleged transfers of drones from Iran to Russia and had provided photographs and their analyses of the recovered drones.

"The Secretariat continues to examine the available information," DiCarlo said, giving no indication of when or if a U.N. investiga-

tion would take place. Ukraine's U.N. Ambassador Sergiy Kyslytsya told the council that more than 1,000 drone launches over Ukraine had been recorded and

that analysis by Ukrainian and international experts confirmed their Iranian origin. Russia's Nebenzia accused Ukraine and

the West of fomenting misinformation and dismissed the evidence as comical. France, Germany and the UK, which are

parties to the JCPOA, said in a joint statement that Iran has also been in violation of its nuclear commitments under the 2015 deal for four years.

They pointed to the International Atomic Energy Agency's reports that Iran's total stockpiles of enriched uranium are now 21 times the amount permitted under the 2015 nuclear deal - and the IAEA's detection in January of uranium particles enriched to 83.7%, which is almost at weapons-grade levels of 90%. Any stockpile of uranium at that level could be quickly used to produce an atomic bomb if Iran chooses.

The 2015 nuclear deal limited Tehran's uranium stockpile to 300 kilograms (661 pounds) and enrichment to 3.67% - enough to fuel a nuclear power plant. But following the U.S. withdrawal, Tehran escalated its nuclear program and has been producing uranium enriched to 60% purity - a level for which nonproliferation experts already say

Tehran has no civilian use. Iran informed the IAEA that "unintended fluctuations" in enrichment levels may have occurred accounting for the particles enriched to 83.7%, and Iravani, the Iranian ambassador, and Russia's Nebenzia both said the issue has been resolved.

Univ forced to open 2nd slot for registration

5,285 students register to study at Abdullah Al-Salem University

KUWAIT CITY, July 8: While Abdullah Al-Salem University is preparing to embark on its first academic year as a new academic institution in the country, the university is conducting admission tests and the number of those who registered for the admission tests in the first phase reached 5,285, which forced the university to open a second slot for registration, reports Al-Qabas daily.

Member of the founding board of directors of the university and head of the planning and strategy committee, Dr. Fawaz Al-Enezi, said the second three-day slot for registration opened on Friday and will close the window on Sunday (tomorrow).

According to the conditions, the minimum rates for admission to the university are 85% for students in the literary section and 80% for students in the scientific section, while the required rates for students with special needs are 80% for the literary section and 75% for the scientific section.

Al-Enezi told Al-Qabas that the university, which aspires to be among the most advanced and developed universities in the world, has adopted international tests for admission in English and mathematics, by adopting the IELTS test or its equivalent, provided that the student obtains 5 degrees as a minimum, and the accuplacer test for mathematics and the condition that the student obtains 238 degree as a minimum for admission.

The university starts with 3 colleges: "Engineering and Energy", "Computer and Systems" and "Entrepreneurship", which includes 10 different majors. A differential rate is calculated for accepted students according to the college they will enroll in.

Al-Enezi explained that the differential average for the student applying for "Engineering and Energy" or "Computer and Systems" is by specifying a criterion of 65% for the high school average, 20% for the mathematics test, and 15% for the English

Kuwait to invest more than \$300 bln in energy in the long term until 2040

OPEC chief lauds Kuwait's participation in symposium

KUWAIT CITY, July 8: Deputy Prime Minister, Minister of Oil and Minister of State for Economic Affairs and Investment Dr. Saad Al-Barrak has revealed Kuwait will invest more than \$300 billion in energy in the long term until 2040, reports Al-Rai daily.

On the sidelines of the eighth international symposium of the Organization of Petroleum Exporting Countries (OPEC), which was held in Vienna over two days, Al-Barrak said in a statement to Kuwait TV and KUNA that "the world needs today 500 billion dollars annually to invest in the field of energy, while it invested only 300 billion dollars in 2022."

He added, this shows there is a gap estimated at more than 40 percent, which creates difficulties in the global energy market. He called for a further increase in the volume of investment in the energy market to protect it from price fluctuations and achieve stability in the global economy.

He pointed to the importance of the role played by Kuwait, the founding member of OPEC, in the field of energy since the founding of the organization on September 14, 1960, and its contribution to strengthening the stability of global oil markets. He noted that Kuwait made many sacrifices in order to control and determine production levels according to market needs, and prevent price fluctuations.

In statements to the Emirates News Agency, WAM, Al-Barrak affirmed Kuwait's readiness to cooperate with the brothers in the UAE for the success of its hosting of the Conference of the Parties (COP 28), which is the most important climate and environmental event hosted by the region.

Commitment

He stressed Kuwait's commitment to achieving zero carbon emissions by 2050, noting that it aims to invest in alternative and environmentally friendly energy, in order to enhance its position as a global energy center.

On the other hand, the official Iranian news agency "IRNA" reported that Iranian Energy Minister Javad Oji met his Saudi counterpart, Prince Abdulaziz bin Salman, on the sidelines of the "OPEC" conference in Vienna, noting that the two sides discussed bilateral issues between the two countries, including investment in the oil sector and exploring the possibility of joint investment in oil and gas.

The agency stated that "the topics of discussion

also included issues such as hydrocarbon trade and the development of common areas."

Meanwhile, Secretary-General of OPEC Haitham Al Ghais spoke highly of Kuwait's active participation in the eighth Vienna energy symposium currently organized by the bloc.

Speaking to KUNA on Thursday, Al-Gais praised participation of Kuwait's Deputy Prime Minister, Minister of Oil and Minister of State for Economic and Investment Affairs Saad Al-Barrak in the symposium and its ministerial session, which focused on raising output capacity through increasing investment.

Al-Gais further expressed gratitude to the Ministry of Information for its effective partaking to cover this

Human rights committee raises observations about social welfare homes

KUWAIT CITY, July 8: The Complaints and Grievances Committee of the National Bureau for Human Rights made seven observations on the progress of work in the Juvenile Welfare Department. It recommended that officials should review these observations in order to raise the level of efficiency of the work and workers, provide a safe and supportive work environment for employees and inmates alike, and improve the rate of application of human rights in all social welfare homes, reports Aljarida daily.

This was highlighted during a visit by the committee's delegation to the Juvenile Welfare Department a few weeks ago. The delegation was received by the Director of the Juvenile Welfare Department Dr. Jassim Al-Kandari and a number of its officials.

The visit was aimed at implementing paragraph 9 of article 6 of the bureau establishment law, which stipulates "follow-up of the various institutions, detention centers, and care homes through periodic or surprise field visits and issuance of reports on their conditions."

The delegation also visited the social welfare home for boys, where they toured the observation house and met six inmates of ages between 14 and 16 years. They also spoke to 12 inmates of the placement homes who have been sentenced in various criminal cases. They observed the vocational and rehabilitative activities provided by the administration to them such as carpentry, printing, mechanics, computer and agricultural workshops, in addition to the recreational activities, mosques and schools.

The delegation also visited the correctional house, which receives those of ages between 18 and 21 years who have been sentenced by additional judicial rulings and are placed there in preparation for their transfer to the Central Prison.

They also visited the social welfare home for girls where six inmates were staying, identified the reasons for their placement and observed the activities offered to them.

After the tour ended, the committee delegation held a meeting with Dr. Jassim Al-Kandari, who stated that the total number of inmates of both genders in the social welfare homes is 39.

It was highlighted that the department is in the process of moving to a new building in the next few months, where the provision of services and activities to inmates will be expanded.

The committee made a number of observations on the workflow in the department, most notably the nature of the work in the Juvenile Welfare Department, which is considered un-

The committee will also look into the technical reports issued by the committees, examine the complaints from the bidders and the responses given by the Ministry of Works and the Public Authority for Roads and Land Transport (PART), to those complaints and the extent to which they meet the contractual and legal aspects.

The minister's decision to form the committee confirms her keenness to ward off any suspicions or doubts in the course of the procedures for issuing and awarding the two tenders, which enhances the concept of transparency that Boqmaz is keen to pursue in all issues related to the ministry's projects confirming the ministry's commitment to honor the findings and recommendations of the committee.

average long-term US mortgage rate climbs to 6.81% this week

The average long-term U.S. mortgage rate climbed to a new high for the year this week, pushing up borrowing costs for homebuyers already facing heightened competition in a housing market short on

The average rate on the benchmark 30-year home loan rose to 6.81% from 6.71% last week, mortgage buyer Freddie Mac said Thursday. A year ago, the rate averaged 5.30%.

It's the second consecutive week of higher rates, lifting the average rate to its highest level since it surged to 7.08% in early November. High rates can add hundreds of dollars a month in costs for borrowers, limiting how much they can afford in a market already unaffordable to many Americans.

"These high rates combined with low inventory continue to price many potential homebuyers out of the market," said Sam Khater, Freddie Mac's chief economist.

The latest uptick in mortgage rates follows a sharp upward move in the 10-year Treasury yield, which climbed above 4% this week for the first time since early March. More surprisingly hot jobs data Thursday pushed yields on the 10-year Treasury to 4.05% from 3.94% late Wednesday, which will influence mortgage rates and other important loans.

Mortgage rates don't necessarily mirror the Fed's rate increases, but tend to track the yield on the 10-year Treasury note. Investors' expectations for future inflation, global demand for U.S. Treasurys and what the Fed does with interest rates can influence rates on home loans. (AP)

President says his policies add jobs in GOP states

Biden makes economic case in deep-red South Carolina

WEST COLUMBIA, S.C., July 8, (AP): Making his case for 2024, President Joe Biden declared in deep-red South Carolina on Thursday that Republican-led states are gaining factory jobs because of economic measures he pushed through Congress despite stiff GOP opposition.

In a nod toward next year's elections, Biden argued that government investments in computer chips, batteries and electric vehicles will help the U.S. outcompete China and that his agenda has delivered in ways that former President Donald Trump could not.

"I didn't get much help from the other team, but that didn't stop us from getting it done," the president said, speaking in a state that he lost by nearly 12 percentage points in 2020. "Every Republican member of Congress voted against the Inflation Reduction Act."

White House officials maintain that if Republicans had their way, South Carolina, like many other Republican-controlled states, would have lost out on billions of dollars in investments and thousands of jobs.

However, GOP lawmakers counter that Biden's initiatives have fueled higher inflation and thus have left people worse off.

Biden's visit showcased a new clean energy manufacturing partnership between solar firm Enphase Energy and manufacturer Flex Ltd. that is projected to create 600 jobs in the state and 1,200 more throughout the country. Enphase, which is making a \$60 million investment to open six new manufacturing lines, including two in South Carolina, is benefitting from tax incentives included in Biden's Inflation Reduction Act that passed last August.

The trip also showed an increasing partnership between the administration and technology companies. These relationships complicate GOP criticism that Democratic policies have hurt businesses, as some corporate leaders say that White House initiatives are helping them.

But the Biden administration also faces a balancing act as it simultaneously

talks up union labor at projects and other initiatives that some companies say could

Enphase President and CEO Badri Kothandaraman thanked Biden for signing into law last year's legislation, which he said "provides incentives for domestic manufacturing of energy products that not only increase the overall supply and demand in the U.S. but also accelerated domestic production to cater to that increased demand."

The White House has repeatedly castigated Republicans for voting against the legislation and for efforts to claw back tax incentives it contained, arguing that the efforts would hurt their own constituents.

"I made a commitment that I'd be president for all Americans," Biden said. "I've kept my promise. In fact, some analyses have said that laws I've signed are going to do more to help red America than blue America. That's OK with me, because we're all Americans.

The nonpartisan Congressional Budget Office initially estimated that the law would reduce deficits by \$238 billion over 10 years. It contains about \$400 billion worth of spending and tax incentives related to clean energy and the environment, but the popularity of the climate-related tax breaks suggests that spending will be higher than initially forecast and possibly reduce the estimated deficit savings.

Republican Rep. Joe Wilson, who represents an area that will benefit from Enphase's new investment, took to Twitter after the law was approved on a party-line vote to say it passed to "the detriment of American families," calling it a "waste" of money. Wilson also voted in April to overturn the clean energy tax credits in the legislation that incentivized the Enphase investment.

The White House also took note of another South Carolina Republican, Rep. Nancy Mace, who congratulated the Charleston Area Regional Transportation Authority for winning nearly \$26 million to build and repair clean energy transporta-

tion projects under the \$1 trillion infrastructure legislation. She voted against the

Sen. Tim Scott, who is running for the 2024 GOP presidential nomination, also voted against the infrastructure bill, saying it included "reckless spending on unrelated pet projects.

In a Thursday interview with Fox News, the South Carolina senator said that Biden has triggered higher gasoline, food and utilities prices as overall inflation has largely outpaced wage growth.

"We've done better, we can do better," Scott said.

The visit to South Carolina - a state that hasn't supported a Democrat in a general presidential election since Jimmy Carter in 1976 - comes less than a week after Trump, the leading contender for the 2024 Republican nomination, visited the small town of Pickens for a rally that drew tens of thousands of people.

Biden criticized Trump as a policy lightweight whose multiple declarations of an "infrastructure week" never produced the promised investments, while Biden steered a bipartisan deal on infrastructure through Congress.

But for all his optimism, Biden has seen his public approval rating - and public sentiment about his handling of the economy - dragged down by stubborn inflation that hit a 40-year high last summer.

Still, White House officials are embracing ownership of the economy, arguing that legislative action during the first two years of the Democratic administration has kept the economy strong in the face of headwinds caused by the war in Ukraine and the coronavirus pandemic. Biden also argues that his legislative wins have set the scene for further growth if voters give him four more years and that he's committed to work with areas that oppose him politically.

South Carolina, which has a low 3.1% unemployment rate, has seen \$11 billion in new investment in manufacturing and clean energy since the start of the Biden administration, according to a White House tally.

Production cuts not helping in improving the oil prices!

WHILE more OPEC+ production cuts are coming into effect, more crude oils are entering the market from various sources. This is not helping the oil price reach the unannounced target level of \$80 per barrel.

USA, Canada, Brazil and Norway are pushing the crude oil

production, especially the US producers who are earning as much as possible for their barrels, regardless the price level being \$45 or \$75 and above, as they are free and not committed to

any budget constraints, unlike the OPEC+ producers.

In addition, Iran is pushing its production to the highest level with export rate reaching about 1.8 million barrels to China, Venezuela, Svria, African and Latin American countries, along with transshipment in the middle of the sea to unknown destinations. Iran's production rate is reaching close to three million barrels per day, the highest since 2018, with the USA administration doing some sort of eye blinding. This is in contrast to OPEC's desire and its efforts with its members to curtail crude oil production, particularly with Russia to commit its production level, as agreed with OPEC+. It cannot do so, as it faces boycott from G7 and a forced price level of \$60 per barrel for its Ural crude oil. It per-

With OPEC's volunteer oil cuts not impacting oil prices, despite its efforts, the economic situation falls into the demand situation, with China being the main player to move the oil price to a level of \$80 per barrel. Even though it has today edged up to \$77, it is not enough for OPEC producers, as most of its members need a level of \$80 and above to breakeven with the annual budget. Otherwise, they have to cut down on their spendings and cancel infrastructure projects. It seems like a nonstop hidden

dilemma between OPEC+ producers and other oil producers that can run their upstream efficiently every day and try to minimize cost by finding ways and means to become more cost effective, and upgrade on their earnings as well as have a free hand to do so.

This is unlike OPEC+, which relies on others' know-how and technology without much rewards for the operators, which raises concerns for the owners. If we are not in command of our wells and the latest technology, our costs will always be much higher than others.

It will be a hard task for the oil price to hit the desired level of \$80, but OPEC+ members are fully committed to sticking to their quotas by every barrel, and full sort of uplift in oil demand, hoping for China to witness some sort of economic pickup. Otherwise, there will be a hard struggle for oil price today and next year with more oils coming into the markets, despite the ongoing war in Ukraine and the boycott of Russian oils.

W. St drifts after jobs report comes in warm but hopefully not too hot

Asian shares fall as strong US data dash hopes for an end to rate hikes

NEW YORK, July 8, (AP): Wall Street drifted to a mixed finish Friday after data suggested the U.S. job market is still warm enough to keep the economy growing but maybe not so hot that it stokes inflation much higher.

The S&P 500 lost 12.64 points, or 0.3%, to 4,398.95, though slightly more stocks within the index rose than fell. The Dow Jones Industrial Average gave up 187.38, or 0.6%, to 33,734.88, and the Nasdaq composite edged down by 18.33, or 0.1%, to 13,660.72.

A lot is riding on whether the economy can navigate the narrow pathway to avoid a long-predicted recession. It needs to keep growing despite much higher interest rates instituted by the Federal Reserve to bring down inflation. But it can't grow so quickly that the Fed feels pressure to brake much harder on the economy to prevent inflation from spiraling higher.

Friday's report showed U.S. employers added 209,000 jobs last month, a slowdown from May's hiring of 306,000. Perhaps more importantly, it wasn't far off economists' expectations. That's unlike a report from Thursday, which sent stocks dropping after it suggested U.S. hiring could be much stronger than expected

Besides the slowdown in overall hiring, some numbers underneath the report's surface also showed some loosening in the job market. More people are working part-time because their hours have been cut, for example, said Brian Jacobsen, chief economist at Annex Wealth Management.

"The job market is healthy, for now, but it's not red hot," he said.

Not only do investors see them as moving more closely with the strength of the U.S. economy than big multinational companies, smaller stocks are also viewed as more dependent on lower interest rates. The Russell 2000 index of smaller stocks rose 1.2%

On the losing side of Wall Street was Levi Strauss, which tumbled 7.7% despite reporting slightly stronger profit for the latest quarter than analysts expected. It cut its forecasted range for earnings for the full year, as its U.S. wholesale business remains under pres-

US Treasury Secretary meets with Chinese counterpart

Yellen appeals to China for coop on climate, other global challenges

BEIJING, July 8, (AP): Treasury Secretary Janet Yellen appealed to China on Saturday for cooperation on climate change and other global challenges and not to let disagreements about trade and other irritants derail relations.

In a meeting with her Chinese counterpart, Vice Premier He Lifeng, Yellen defended U.S. restrictions on technology exports that rankle Beijing. She said the two governments shouldn't let such disagreements disrupt thriving economic and financial rela-

□We also face important global challenges, such as debt distress in emerging markets and developing countries and climate change," Yellen said. "We have a duty to both our own economies and to other

countries to cooperate." Yellen is one of a series of U.S. officials who are due to visit Beijing as part of efforts to revive relations that are at their lowest level in decades due to disputes over technology, security, and Taiwan

among other issues.

Yellen has received a warm welcome from leaders including Premier Li Qiang, the No. 2 figure in the ruling Communist Party, though they gave no sign they will change policies that irk Washington and other governments.

Treasury officials said the goal of the trip was to encourage communication and no agreements on big disputes were expected. They said Yellen wasn't scheduled to meet Chinese leader Xi Jinping.

Beijing broke off climate discussions with Washington last August in retaliation for a visit by then-Speaker Nancy Pelosi of the House of Representatives to Taiwan, the self-ruled island democracy

claimed by China as part of its territory. President Joe Biden's climate envoy, John Kerry, is due to become the next senior U.S. official to visit China next week. China and the United States are the world's top emitters of climate-changing carbon. He, who is Xi's top economic adviser and the

chief Chinese envoy to the United States on trade and financial issues, said the two governments should return to an agreement reached last November by Biden and Xi to improve relations.

The two countries should act with a sense of responsibility for history, for the people and for the world," the vice premier said. He added that the United States should "adopt a rational and pragmatic attitude and work with China to stay committed to the common understandings" by Xi and Biden.

China, which has lent billions of dollars to governments in Asia and Africa under Xi's Belt and Road Initiative to build ports and other infrastructure, signed on an agreement last month to reduce the debts of Zambia in southern Africa. Treasury officials earlier pointed to that as an area where cooperation produced results. Also Saturday, Yellen met with the incoming governor of China's central bank, Pan Gongsheng, and people who work in China's climate-related finance industry.

The Chief Executive added: "This record increase in FDI inflows is supported by Team Bahrain's swift agility in successfully driving in solid investments and securing value-adding projects across priority sectors. I am confident in our ability to maintain a strong

Ant Group fined \$985 million by Chinese regulators

Chinese regulators are fining Ant Group 7.123 billion yuan (\$985 million) for violating regulations in its payments and financial services, an indicator that over two years of scrutiny and crackdown on the firm that led it to scrap its planned public listing may have come to an end.

The People's Bank of China imposed the fine on Friday, stating that Ant had violated laws and regulations related to corporate

governance, financial consumer protection, participation in busi-ness activities of banking and insurance institutions, payment and settlement business, and attending to anti-money laundering obligations. The fine comes over two years after regulators pulled the plug on Ant Group's \$34.5 billion IPO - which would have been the biggest of its time. been the biggest of its time - in 2020. Since then, the company had been ordered to revamp its

business and behave more like a financial holding company, as well as rectify unfair competition in its payments business

"We will comply with the terms of the penalty in all earnestness and sincerity and continue to further enhance our compliance governance," Ant Group said in a statement. The move is widely seen as wrapping up Beijing's probe into the firm and to allow Ant to revive its initial public offering. (AP)

Shell CEO calls it 'irresponsible' to cut oil & gas production now

World economy still dependent on fossil fuels

LONDON, July 8, (AP): The head of global energy giant Shell says it would be "irresponsible" to cut oil and gas production at a time when the world economy is still dependent on fossil fuels.

In an interview with the BBC released Thursday, Shell CEO Wael Sawan also refused to rule out moving the company's headquarters and stock market listing from Britain to the United States.

'The reality is, the energy system of today continues to desperately need oil and gas," Sawan said. "And before we are able to let go of that, we need to make sure that we have developed the energy systems of the future - and we are not yet, collectively, moving at the pace (required for) that to happen."

The comments conflict with the recommendations of climate scientists and U.N. Secretary-General Antonio Guterres, who has called on the fossil fuel industry to "drive, not obstruct" the transition to renewable energy. Burning fossil fuels is the biggest source of the carbon emissions blamed

for global warming. Even Sultan al-Jaber - who is head of Abu Dhabi National Oil Co., one of the world's largest oil producers, as well as president of this year's U.N. climate talks - urged the oil and gas industry to reach net zero greenhouse gas emissions by or before 2050.

Guterres has said achieving the U.N.'s goal of limiting global temperature increases to 1.5 degrees Celsius above pre-industrial levels was still possible, but only if countries accelerate their efforts to cut carbon emis-

"Investing in new fossil fuels infrastructure is moral and economic madness," Guterres said in April. "Such investments will soon be stranded assets - a blot on the landscape and a blight on investment portfolios.

Sawan said he disagreed with that position. "I think what would be dangerous and irresponsible is actually cutting out the oil and gas production so that the cost of living - as we saw just last year - starts to shoot up again," he told the BBC.

Sawan added that the transition to renewable energy must be "globally responsible," so that it doesn't favor one part of the world over another.

As energy prices soared last year following Russia's invasion of Ukraine, wealthy countries bought up much of the world's supply of liquefied natural gas, taking it away from places like Bangladesh and Pakistan, where children were forced to study by candlelight, he said.

Sawan took over as Shell's chief executive in January. Under his predecessor, Ben van Beurden, the company set a target of eliminating net carbon emissions from both its operations and the products it sells by 2050. Sawan also took aim at the British

George Soros' OSF to lay off 40 pct of staff under son's new leadership

human rights organizations are conabout Open Foundations plans to lay off 40% of their global staff - the nonprofit's second major cut in three years - as billionaire investor George Soros hands over leadership to his son.

"We are most concerned for social justice movements, which now have to wait for the impact on their sustainability," said Kellea Miller, executive director of the Human Rights Funders Network. "In the field of philanthropy, decisions at the top can have an outsized ripple effect on those enacting

Open Society Foundations, the umbrella organization for Soros' charitable work, said its board of directors "approved significant changes to the Foundations' operating model." The layoffs will comply with local regulations, the foundations said, but they have not said where or when they will

take place.
"This will involve some difficult decisions," said Mark Arena, a spokesperson for the Open Society Foundations. "We anticipate that implementing the proposed new model would involve the redesign and retooling of our existing operations, and a substantial reduction in headcount of no less than 40% globally."

In 2021, the foundations offered buyouts to dozens of employees and sought to streamline their internal structures while maintaining roughly the same level of grant funding. The foundations say they currently employ around 800 staff members and maintain offices in more than 20 countries.

Kenneth Roth, the former longtime leader of investigative advocacy nonprofit Human Rights Watch, which was a major recipient of OSF funding, said he has no reason to think the OSF layoffs will mean a decline in support for human rights work. It may mean OSF makes fewer, larger grants in the future because the staffing decline makes it harder to handle multiple smaller grants.

According to The Human Rights Funders Network, which researches funding on human rights, OSF was the sector's third largest funder in 2019, the most recent year it has analyzed.

'We also consider the humanity of those losing jobs at OSF," Miller said. "This is not nominal, and it also means that movements that have longstanding relationships with program officers there now have to rebuild their access

Photography serves as helpful lens

Generative AI is a minefield for copyright law

In 2022, an AI-generated work of art won the Colorado State Fair's art competition. The artist, Jason Allen, had used Midjourney – a generative AI system trained on art scraped from the internet – to create the piece. The process was far from fully automated: Allen went through some 900 iterations over 80 hours to create and refine his submission.

Yet his use of AI to win the art competition triggered a heated backlash online, with one Twitter user claiming, "We're watching the death of artistry unfold right before our eyes.

As generative AI art tools like Midjourney and Stable Diffusion have been thrust into the limelight, so too have questions about ownership and author-

These tools' generative ability is the result of training them with scores of prior artworks, from which the AI learns how to create artistic outputs.

Should the artists whose art was scraped to train the models be compensated? Who owns the images that AI systems produce? Is the process of finetuning prompts for generative AI a form of authentic creative expression?

On one hand, technophiles rave over work like Allen's. But on the other, many working artists consider the use of their art to train AI to be exploita-

We're part of a team of 14 experts across disciplines that just published a paper on generative AI in Science magazine. In it, we explore how advances in AI will affect creative work, aesthetics and the media. One of the key questions that emerged has to do with US copyright laws, and whether they can adequately deal with the unique challenges of generative AI.

Existing

Copyright laws were created to promote the arts and creative thinking. But the rise of generative AI has complicated existing notions of authorship. Generative AI might seem unprecedented, but history can act as a guide.

Take the emergence of photography in the 1800s. Before its invention, artists could only try to portray the world through drawing, painting or sculpture. Suddenly, reality could be captured in a flash using a camera and

As with generative AI, many argued that photography lacked artistic merit. In 1884, the US Supreme Court weighed in on the issue and found that cameras served as tools that an artist could use to give an idea visible form; the "masterminds" behind the cameras, the court ruled, should own the photographs they create.

From then on, photography evolved into its own art form and even sparked new abstract artistic movements.

Unlike inanimate cameras, AI possesses capabilities – like the ability to convert basic instructions into impressive artistic works – that make it prone to anthropomorphization. Even the term "artificial intelligence" encourages people to think that these systems have humanlike intent or even self-aware-

Wonder

This led some people to wonder whether AI systems can be "owners." But the U.S. Copyright Office has stated unequivocally that only humans can hold copyrights.

So who can claim ownership of images produced by AI? Is it the artists whose images were used to train the systems? The users who type in prompts to create images? Or the people who build the AI systems?

While artists draw obliquely from past works that have educated and inspired them in order to create, generative AI relies on training data to produce outputs.

This training data consists of prior artworks, many of which are protected by copyright law and which have been collected without artists' knowledge or consent. Using art in this way might violate copyright law even before the AI generates a new work.

For Jason Allen to create his award-winning art, Midjourney was trained on 100 million prior works.

Was that a form of infringement? Or was it a new form of "fair use," a legal doctrine that permits the unlicensed use of protected works if they're sufficiently transformed into something new?

While AI systems do not contain literal copies of the training data, they do sometimes manage to recreate works from the training data, complicating this legal analysis.

Will contemporary copyright law favor end users and companies over the artists whose content is in the training data?

To mitigate this concern, some scholars propose new regulations to protect and compensate artists whose work is used for training. These proposals include a right for artists to opt out of their data's being used for generative AI or a way to automatically compensate artists when their work is used to train an AI

Training data, however, is only part of the process. Frequently, artists who

use generative AI tools go through many rounds of revision to refine their prompts, which suggests a degree of originality.

Answering the question of who should own the outputs requires looking into the contributions of all those involved in the generative AI supply chain.

The legal analysis is easier when an output is different from works in the training data. In this case, whoever prompted the AI to produce the output appears to be the default owner.

However, copyright law requires meaningful creative input – a standard satisfied by clicking the shutter button on a camera. It remains unclear how courts will decide what this means for the use of generative AI. Is composing and refining a prompt enough?

Matters are more complicated when outputs resemble works in the training data. If the resemblance is based only on general style or content, it is unlikely to violate copyright, because style is not copyrightable.

The illustrator Hollie Mengert encountered this issue firsthand when her unique style was mimicked by generative AI engines in a way that did not capture what, in her eyes, made her work unique. Meanwhile, the singer Grimes embraced the tech, "open-sourcing" her voice and encouraging fans to create songs in her style using generative AI.

Output

If an output contains major elements from a work in the training data, it might infringe on that work's copyright. Recently, the Supreme Court ruled that Andy Warhol's drawing of a photograph was not permitted by fair use. That means that using AI to just change the style of a work – say, from a photo to an illustration – is not enough to claim ownership over the modified

While copyright law tends to favor an all-or-nothing approach, scholars at Harvard Law School have proposed new models of joint ownership that allow artists to gain some rights in outputs that resemble their works.

In many ways, generative AI is yet another creative tool that allows a new group of people access to image-making, just like cameras, paintbrushes or Adobe Photoshop. But a key difference is this new set of tools relies explicitly on training data, and therefore creative contributions cannot easily be traced back to a single artist.

The ways in which existing laws are interpreted or reformed – and whether generative AI is appropriately treated as the tool it is - will have real consequences for the future of creative expression. (AP)

Efforts hit speed limit

Digital future may rely on ultrafast computers

If you've ever wished you had a faster phone, computer or internet connection, you've encountered the personal experience of hitting a limit of technology. But there might be help on the way.

Over the past several decades, scientists and engineers like me have worked to develop faster transistors, the electronic components underlying modern electronic and digital communications technologies. These efforts have been based on a category of materials called semiconductors that have special electrical properties. Silicon is perhaps the best known example of this type of material.

But about a decade ago, scientific efforts hit the speed limit of semiconductor-based transistors. Researchers simply can't make electrons move faster through these materials. One way engineers are trying to address the speed limits inherent in moving a current through silicon is to design shorter physical circuits - essentially giving electrons less distance to travel. Increasing the computing power of a chip comes down to increasing the number of transistors. However, even if researchers are able to get transistors to be very small, they won't be fast enough for the faster processing and data transfer speeds people and businesses will need.

My research group's work aims to develop faster ways to move data, using ultrafast laser pulses in free space and optical fiber. The laser light travels through optical fiber with almost no loss and with a very low level of noise.

Published

In our most recent study, published in February 2023 in Science Advances, we took a step toward that, demonstrating that it's possible to use laser-based systems equipped with optical transistors. which depend on photons rather than voltage to move electrons, and to transfer information much more quickly than current systems - and do so more effectively than previously reported optical switch-

At their most fundamental level, digital transmissions involve a signal switching on and off to represent ones and zeros. Electronic transistors use voltage to send this signal: When the voltage induces the electrons to flow through the system, they signal a 1; when there are no electrons flowing, that signals a 0. This requires a source to emit the electrons and a receiver to

Our system of ultrafast optical data transmission is based on light rather than voltage. Our research group is one of many working with optical communication at the transistor level – the building blocks of modern processors – to get around the current limitations with silicon.

Our system controls reflected light to transmit information. When light shines on a piece of glass, most of it passes through, though a little bit might reflect. That is what you experience as glare when driving toward sunlight or looking through a window.

Transmitted

We use two laser beams transmitted from two sources passing through the same piece of glass. One beam is constant, but its transmission through the glass is controlled by the second beam. By using the second beam to shift the properties of the glass from transparent to reflective, we can start and stop the transmission of the constant beam, switching the optical signal from on to off and back again very quickly.

With this method, we can switch the glass properties much more quickly than current systems can send electrons. So we can send many more on and off signals zeros and ones - in less time.

Our study took the first step to transmitting data 1 million times faster than if we had used the typical electronics. With electrons, the maximum speed for transmitting data is a nanosecond, one-billionth of a second, which is very fast. But the optical switch we constructed was able to transmit data a million times faster, which took just a few hundred attoseconds.

We were also able to transmit those signals securely so that an attacker who tried to intercept or modify the messages would fail or be detected.

Using a laser beam to carry a signal, and adjusting its signal intensity with glass controlled by another laser beam, means the information can travel not only more quickly but also much great-

For instance, the James Webb Space Telescope recently transmitted stunning images from far out in space. These pictures were transferred as data from the telescope to the base station on Earth at a rate of one "on" or "off" every 35 nanosconds using optical communications.

A laser system like the one we're developing could speed up the transfer rate a billionfold, allowing faster and clearer exploration of deep space, more quickly revealing the universe's secrets. And someday computers themselves might run on light. (AP)

Tens of millions sign up for text version of IG What's Threads? All questions about

Meta's new Twitter rival, answered

NEW YORK, July 8, (AP): Threads, a text-based app built by Meta to rival Twitter, is live

The app, billed as the text version of Meta's photo-sharing platform Instagram, became available Wednesday night to users in more than 100 countries - including the US, Britain, Australia, Canada and Japan. Despite some early glitches, 30 million people had signed up before noon on Thursday, Meta CEO Mark Zuckerberg said on Threads

New arrivals to the platform include celebrities like Oprah, pop star Shakira and chef Gordon Ramsay - as well as corporate accounts from Taco Bell, Netflix, Spotify, the Washington Post

Threads, which Meta says provides "a new, separate space for real-time updates and public conversations," arrives at a time when many are looking for Twitter alternatives to escape Elon Musk's raucous oversight of the platform since acquiring it last year for \$44 billion. But Meta's new app has also raised data privacy concerns, and is notably unavailable in the European

Here's what you need to know about Threads.

Threads is now available for download in Apple and Google Android app stores for people in more than 100

Threads was built by the Instagram team, so Instagram users can log into Threads through their Instagram account. Your username and verification status will carry over, according to the platform, but you will also have options to customize other areas of your profile - including whether or not you want to follow the same people that you do on Instagram.

Because Threads and Instagram are so closely linked, it's also important to be cautious of account deletion. According to Threads' supplemental privacy policy, you can deactivate your profile at any time, "but your Threads profile can only be deleted by deleting your Instagram account.'

Accounts

For now, only Instagram users can create Threads accounts. If you want to ccess Threads, you will have to sign up for Instagram first.

While this may receive some pushback, VP and research director at Forrester Mike Proulx said making Threads an extension of Instagram was a smart move on Meta's part.

"It's piquing (user) curiosity," Proulx said, noting that Instagram users are getting alerts about their followers joining Threads - causing more and more people to sign up. "That's one of the reasons why Threads got over 10 million people to sign up in just a seven hour period" after launch-

Still, Proulx added, maintaining momentum and continuing to capture user attention past the initial curiosity bump will be crucial down the line noting "the long term nature of threads is what's going to ultimately predict its success or failure." Threads' microblogging experience

is very similar to Twitter. Users can repost, reply to or quote a thread, for example, and can see the number of likes and replies that a post has received. Threads" can run up to 500 characters compared with Twitter's 280-character threshold - and can include links, photos and videos up to five minutes

'Clone' or competitor? Lawyers and users compare Twitter and Threads

NEW YORK, July 8, (AP): Just how similar is Instagram's chatty new app, Threads, to Twitter?

Posluma can help identify location of prostate cancer

MONROE TOWNSHIP, N.J., July 8: Blue Earth Diagnostics, a Bracco company and recognized leader in the development and commercialization of innovative PET radiopharmaceuticals, has announced inter- and intra-reader reproducibility results from its Phase 3 LIGHTHOUSE trial of Posluma ® (flotufolastat F 18) injection (formerly referred to as 18F-rhPSMA-7.3) in newly diagnosed prostate cancer. Results showed high inter-reader agreement across all 3 trained, blinded readers. The inter-reader agreement for Posluma PET/CT in 352 evaluable scans was ≥95% across pair-wise inter-reader comparisons. Overall intrareader agreement was ≥96% for each reader. Recently approved by the US FDA, Posluma is indicated for positron emission tomography (PET) of prostate-specific membrane antigen (PSMA) positive lesions in men with prostate cancer with suspected metastasis who are candidates for initial definitive therapy or with suspected recurrence based on elevated serum prostate-specific antigen (PSA) level. The results were reported in an oral presentation at the 2023 Society of Nuclear Medicine and Molecular Imaging (SNMMI) Annual Meeting.

"Up to 25% of patients with primary prostate cancer may have detectable regional pelvic lymph node metastases, which are correlated with a risk for recurrence and associated overall survival," said Phillip H. Kuo, MD, Ph.D., Departments of Medical Imaging, Medicine, and Biomedical Engineering. "Effective staging in primary disease – determining its presence and whether it may have metastasized - is critical to establishing optimal clinical management strategies for patients. Conventional imaging techniques are limited in the information they may provide, so the demonstrated performance of PSMA-PET imaging fits an important unmet need. As well, reliable and consistent interpretation of PET imaging is foundational to informed decision-making and has the potential to substantially impact patient care. These findings from the LIGHTHOUSE study showed high reader agreement in interpreting Posluma PET/CT scans among a patient population of men with unfavorable intermediate- to very high-risk prostate cancer prior to initial therapy. The high reproducibility of reader results across all regions is clinically valuable, with the potential to influence patient management prior to surgery for patients with newly diagnosed disease."

"We are pleased to present these reader interpretation results from the Phase 3 Lighthouse trial at SNMMI's 2023 Annual Meeting," said David E. Gauden, D.Phil., Chief Executive Officer of Blue Earth Diagnostics. "In designing the Posluma image interpretation training, we drew upon Blue Earth Diagnostics' proven expertise and experience in designing PET image interpretation programs and training for our first commercialized product, Axumin® (fluciclovine F 18). Newly FDA-approved Posluma represents a new class of purposely engineered, high-affinity PSMA-targeted PET radiopharmaceuticals based on novel radiohybrid technology. It is labeled with the radioisotope 18F to provide readily available patient access and leverage the high image quality of 18F-labeled PSMA PET imaging to facilitate detection of disease. In a post-hoc Phase 3 analysis, as well as in preclinical and Phase 1 studies, Posluma demonstrated low urinary bladder activity, providing the potential for enhanced image evaluation in the prostate and regions near the ureters for patients

with prostate cancer."

The findings presented at SNMMI discussed inter- and intra-reader agreement for the interpretation of Posluma PET scans. Overall agreement between three blinded read-

ers who received identical training was assessed for 352 evaluable PET scans; in addition, regional agreement was assessed for the prostate/ prostate bed, pelvic lymph nodes, and other (extra-pelvic) sites (lymph nodes outside pelvis, soft tissue/parenchyma, and bones). Intra-reader agreement was based on a sample of 70 (20%) randomly selected scans and consisted of re-reads 4 weeks following the initial reads. The overall inter-reader agreement for Posluma PET/CT in 352 evaluable scans was ≥95% across pair-wise, inter-reader comparisons, with the highest agreement seen in the prostate/prostate bed region (also ≥95%). Overall intrareader agreement was ≥96% for each reader. It should also be noted that the interpretation of Posluma PET in patients with suspected prostate cancer recurrence may differ depending on imaging readers, particularly in the prostate/prostate bed region. The Lighthouse Phase 3 clinical

trial (NC04186819) was a prospective, Phase 3, multi-center, single-arm, imaging study conducted in the United States and Europe to evaluate the safety and diagnostic performance of Posluma PET in men with newly diagnosed prostate cancer. Results for the co-primary endpoints of efficacy and safety for the LIGHTHOUSE trial were previously presented at the 23rd Annual Scientific Meeting in Urologic Oncology (SUO) in December 20221 and at the ASCO Genitourinary Cancers Symposium (ASCO GU) in February 2023.2

Study shows TAK-755 more effective than plasma-based therapy for cTTP

OSAKA, Japan & CAMBRIDGE, Mass, July 8: Takeda (TSE: 4502/NYSE:TAK) has presented favorable interim results from a global pivotal Phase 3 randomized, controlled, openlabel, crossover trial evaluating the safety and efficacy of TAK-755 (recombinant ADAMTS13) replacement therapy for the prophylactic treatment of congenital thrombotic thrombocytopenic purpura (cTTP), and pharmacokinetics (PK) characteristics of TAK-755, as well as long-term data on TAK-755 prophylaxis from a Phase 3b continuation study.

cTTP is an ultra-rare, chronic and debilitating blood clotting disorder caused by a deficiency in ADAMTS13 enzyme. Clinical presentation of cTTP lies on a spectrum of severity ranging from severe acute TTP events to chronic, recurring TTP manifestations (e.g., thrombocytopenia, hemolytic activity, headache, abdominal pain). Acute TTP events have a mortality rate of >90%, if left untreated. These studies were designed to evaluate the clinical benefit of TAK-755 in patients with cTTP across multiple clinically relevant endpoints and based on the totality of the evidence provided by efficacy, PK, safety and tolerability data. Both acute and subacute TTP events, including TTP-related organ-specific signs and symptoms were evaluated.

In the pivotal trial, no patient had an acute TTP event while receiving TAK-755 prophylactic treatment. TAK-755 also reduced the incidence of thrombocytopenia by 60%, as compared val 0.3 to 0.7). Thrombocytopenia, an important marker of disease activity, was the most frequently observed TTP manifestation. In addition, the results show that TAK-755 demonstrated a favorable safety and tolerability profile, with a potential safety advantage over plasma-based therapies. In the pivotal trial, treatment-emergent adverse events (TEAEs) were reported in 10.3% of patients ages 12-68 receiving TAK-755 compared to 50% of patients receiving plasma-based therapy. TAK-755 is an investigational therapy that has not been approved by the US Food & Drug Administration (FDA), European Medicines Agency (EMA) or other Regulatory authorities. The FDA has accepted and granted Priority Review for Takeda's Biologics License Application (BLA) for TAK-755 for the treatment of cTTP.

TAK-755 is the first and only re-

TAK-755 is the first and only recombinant ADAMTS13 protein in development. It provides targeted therapy to address an unmet medical need in patients with thrombotic thrombocytopenic purpura (TTP), by replacing the missing or deficient ADAMTS13 enzyme.

The TAK-755 cTTP clinical development program includes one first-in-human, Phase 1 study, 281101 (NCT02216084),3 and two ongoing Phase 3 studies: a pivotal Phase 3 study, Study 281102 (NCT03393975), and one Phase 3b continuation study, Study TAK-755-3002 (NCT04683003).4,5 TAK-755 is also being investigated in immune-mediated TTP (iTTP) and sickle cell disease, with Phase 2b (NCT05714969) and Phase 1 (NCT03997760) trials ongoing, respectively, with the Phase 1 trial due to provide data in 2023.6,7

Treatment

TAK-755 was granted Orphan Drug Designation (ODD) by the U.S. Food and Drug Administration (FDA) for the treatment (ODA-08-2622) and prevention (ODA-08-2652) of TTP including its congenital, acquired idiopathic and secondary forms; and by the European Medicines Agency (EMA) and Japan's Ministry of Health, Labour and Welfare (MHLW) for the treatment of TTP (EU/3/08/588). The FDA has also granted TAK-755 Fast Track Designation (FTD) for the treatment, prevention and routine prophylaxis of acute episodes of TTP in patients with congenital ADAMTS13 deficiency and granted its Biologics License Application (BLA) Priority Review.

cTTP is an ultra-rare, chronic and debilitating blood clotting disorder associated with life-threatening acute episodes and long-term chronic symptoms.8,9 cTTP is a sub-type of TTP that has an estimated prevalence of 1 cases/million, with cTTP accounting for ≤5% of patients with TTP. It develops due to deficiency in ADAMTS13 enzyme, a von Willebrand factor (VWF) cleaving protease, which results in the accumulation of ultra-large VWF multimers in the blood.8 The accumulation of ultra-large VWF multimers leads to uncontrolled platelet aggregation and adhesion. This can lead to abnormal clotting in the small blood vessels of the body and is associated with hemolytic anemia and low platelet levels (thrombocytopenia).

cTTP has both acute and chronic manifestations (including stroke and cardiovascular disease) and is associated with a significant disease burden. Patients' quality of life and lifespan are significantly reduced compared to the general population, due to serious, ongoing widespread organ damage and other co-morbidities resulting from an ADAMTS13-deficient state. TAK-755 (recombinant ADAMTS13) is a novel investigational therapeutic approach for cTTP.

There are no medications specifically approved by regulatory authorities for routine prophylactic treatment of cTTP. Current treatment centers around plasma-based therapy, either by infusion or plasma exchange. Plasma-based therapy is time consuming and can be associated with severe treatment complications. These can include treatment-limiting volume overload and allergic reactions.







Knoxville on the art of pranking, adjusting to life after stunts

LOS ANGELES, July 8, (AP): Johnny Knoxville is no stranger to head injuries. In the decades since he rose to fame as the daredevil ringleader of "Jackass," he has had more than a dozen concussions - that he knows of. But his most recent one was different.

Now, by doctor's orders, he has to get creative to chase that adrenaline fix through safer means. His latest attempt is with his "Jackass Forever" co-star Eric Andre and Oscar nominee Gabourey Sidibe on their new series, "The Prank Panel," which premieres Sunday on ABC.

Doing work tame enough to be on network television has been a major, but necessary, lifestyle adjustment for the 52-year-old thrillseeking stuntman.

He suffered serious brain injuries after getting rammed by a bull for the fourth and final "Jackass" film, which was released in 2022. That led to nearly a year of depression and mental health struggles - a turn of events that made him permanently swear off those kinds of stunts despite his love of doing them.

"I think I got a little addicted to it, to the point where, you know, I scrambled my brains," he said. "I can do little stunts where if I, you know, break a hand or an ankle or whatever, no one cares about that. I just can't - no more concussions for me.'

Knoxville isn't quite sure what it is about stunts that is so gratifying - is it the attention people give him or the thrill of pulling it off?

"It's complicated," he said, pensively. "Being with everyone, all my friends around and, you know, it's just a real moment. But don't make me start romanticizing it."

So, for now, "The Prank Panel" will have to suffice. It's a kind of spoof on reality competition shows, where people come on and pitch ideas for pranks to the three hosts. If either Knoxville, Andre or Sidibe - billed on the series as the "world's greatest pranksters" - is convinced of the idea's merits, the hopeful prankster will get money, resources and help from their sponsor to execute the caper on an unsuspecting

Knoxville, shown in the trailer hitting Andre between the legs, said he was pleasantly surprised when his attempts to push boundaries on the network show were met with purportedly little resistance.

"I didn't worry about me being more buttoned up. They can beep my words and cut around when I'm really naughty. But I was just more concerned about what we could get away with on ABC," he recalled. "In hindsight, we got away with a lot more than I thought we were

Objectives

The show even signed off on a prank that resulted in Knoxville being sued by a handyman who said he was subjected to a "terrifying ordeal" after being hired for a job listed on TaskRabbit. Knoxville's publicist interjected when he was asked to elaborate but not before he jokingly asked, "Which lawsuit?"

The art of the prank can take on many forms and objectives. There are some who have garnered recognition for their social or political commentary - à la Sacha Baron Cohen's "Borat" - or there are pranks

that are meant to make the victim its champion: Think the recent cult series "Jury Duty," which sought to construct a hero's journey for the one being tricked.

But as Knoxville refined his theory of pranking over the years - a vital component of the "Jackass" franchise - his intentions crystalized

into a simple aspiration: He just wants to be shocking. "I like to confuse more than anything else. I don't want to make someone look stupid," he explained. "I just want to create a really bi-

zarre situation where they're like, 'What is happening?'" That approach has made him and the rest of the "Jackass" stars immune, in a lot of ways, to the complaints that some comedians have

expressed about political correctness or cancel culture. Some might find it distasteful, and some may find it over the line, but it's not like anything that is going to truly upset anyone," he said. "But I know in other areas of comedy it's a little dicier these days."

In addition to realizing he has to restrain himself with stunts and physical comedy, Knoxville said his experience with having a longterm brain injury has also made him aware of the importance of mental health more broadly, something he is candid about with the hopes that it will help others.

By Jocelyn Noveck If you're like me, there comes a moment of truth in

raunchy film comedies when you decide whether to fully join in the fun - or ride it out on the fence. It often comes in a key early comic scene. Can

they pull it off? If so you'll be putty in their hands for two hours, ready to chuckle along no matter how gross it gets (think of that bridal dress fitting in "Bridesmaids.") If not, you'll shuffle uncomfortably on the sidelines, feeling rather like a prude.

In first-time director Adele Lim's ebullient, chaotic, nothing's-too-gross-if-it's funny road comedy "Joy Ride," that moment came for me when watching Ashley Park swallow a disgusting concoction in a drinking contest, pretending all's fine as her insides erupt. Expert comic chops cannot be faked. Park had me from that guzzle (and cemented it later with her Gollum impression.)

Yet the impressive thing about "Joy Ride," a comedy that more than earns its R rating - folks is that there are some moments for each of the superb quartet of actors that make this film buzz along.

Park, playing an ambitious and uptight lawyer, has the trickiest job, being funny while remaining the narrative center, and tasked with making us not only laugh but cry. But each of her co-stars - comic Sherry Cola as a cheerfully profane, struggling artist, Sabrina Wu as her awkward, K-pop obsessed cousin, and a fabulous Stephanie Hsu as a soap opera diva pulls their weight in comedy gold. A viewer's grossout tolerance may vary; what unites is the laughter. Funny how simple it is when that works.

We first meet Audrey as a child in suburban Washington state, the adopted daughter of white parents who delightedly welcome Lolo, from a Chinese family, as a playmate for their daughter. When the bolder Lolo makes mincemeat of a white racist bully in the park, the girls launch a lifelong friendship.

Back to the present. Audrey, a lawyer so competitive she demolishes her boss at squash (he keeps

'Joy Ride' soars with its terrific cast claiming he's "an ally" while tossing off racially insensitive asides), is living in the same hometown - not for nothing is it called White Hills - and Lolo is nearby. Audrey's boss promises a big promotion and

a move to Los Angeles if she can seal an important

A cheerfully gross-out comedy

deal in Beijing. Problem is, Audrey doesn't speak Mandarin, so she enlists Lolo as a translator. As far as Lolo's concerned, Audrey's problems run deeper than her lack of language; she lacks any connection to her Asian roots. What a perfect time, Lolo thinks, for Audrey to make inroads. Maybe she can even find her birth mother.

Outlandish

In Beijing, Audrey survives a brutal night of competitive drinking with her potential client, who likes her until he finds out she has little connection to China. Suddenly, in an effort to save the big deal, Audrey and company are off on a road trip to find Audrey's birth mother. This includes Deadeye, Lolo's cousin, and Kat, Audrey's former college roommate, now a very sexually frustrated soap star. Hsu, after her breakout performance in "Everything Everywhere All at Once," shows huge comic potential here.

The plot - outlandish and sometimes contrived as it is - offers plenty of room for comic possibility. And more. Screenwriters Cherry Chevapravatdumrong and Teresa Hsiao explore themes of identity, assimilation and anti-Asian racism both overt and casual - and within the Asian community itself.

When, for example, the foursome hops on a train, they search for a compartment with people who seem "safe." Audrey rejects a number of Chinese travelers but settles happily in with a blonde American woman - who turns out to be a drug dealer. The scene involves hiding copious amounts of cocaine in ungodly places, but also reflects on Audrey's subconscious racism.

Kicked off the train in the middle of the countryside but rescued by a basketball team (yeah, just go with it), the foursome has a ridiculously raunchy

night (sorry for overusing the word, but "raunch" says it so well) before getting marooned again. The comic energy reaches its apotheosis in a K-pop number whose lyrics we cannot repeat here. The group has been forced to disguise itself as a band so they can get to Korea without passports. (Why? Too complicated). Their song is so overtly sexual you might find yourself blushing - except, as usual, the laughter is what wins out.

Even when the above-mentioned X-rated tattoo is staring you in the face. Which it is.

And then we pivot, dramatically, when Audrey's trip to see her birth mom has an unexpected result. And suddenly, the laughter turns to tears. I know those were sniffles I heard at my screening, and not just mine. How did THAT happen, we wonder.

Well, it's easy: Park earned it. They all did. "Joy Ride," a Lionsgate release, has been rated R by the Motion Picture Association of America "for strong and crude sexual content, language throughout, drug content and brief graphic nudity." Running time: 95 minutes. Three stars out of four.

Stars 'Running Wild'

Grylls goes into the wild with celebrities

NEW YORK, July 8, (AP): For his latest role, Bradley Cooper leapt onto a hovering helicopter, rappelled down a 400-foot cliff and pulled himself across a 100-foot ravine in one of the harshest climates in North America.

His reward wasn't an Oscar nomination or a big box office hit. It was a hug from adventurist Bear **Grylls** and some words of encouragement. "He smashed it," Grylls says.

Cooper is one of several celebrities - includ-

ing Benedict Cumberbatch, Cynthia Erivo, Russell Brand, Troy Kotsur, Rita Ora, Daveed Diggs and Tatiana Maslany - who put their survival skills to the test in a new season of Nat Geo's "Running Wild with Bear Grylls: The Chal-



"I'm really proud of this season. We've had incredible guests who pushed the boundaries in terms of terrain and the challenge," Grylls told The Associated Press. "When there's real

lenge," premiering Sunday.

tough weather with fun people, it's often really compelling TV

The series pairs Grylls with a celebrity for 48 hours in a harsh environment. The first day, Grylls teaches key skills - climbing techniques, waterfinding tips and fire-setting, among them - and then the guest must do them alone the second day.

Kotsur, who won an Oscar for "CODA," was tested in the Scottish Highlands, descending 2,500 feet (760 meters) across eight miles (13 kilometers) of harsh terrain and freezing rivers, including a 150-foot (45-meter) rappel down a waterfall. Because Kotsur is deaf, the two men used rope tugs to communicate. Kotsur's reward: haggis, a Scottish delicacy in which organ meat is put inside a sheep's stomach and cooked.

Diggs, a city kid, finds himself in the inhospitable Great Basin Desert in Nevada.

"I don't know how this is going to go and that's why I'm doing it," he says. Diggs learns how to use anchor points, track a target and make a signal fire. His dinner is a tarantula.

Unpredictable

"It's not what I was hoping for, I'm not going to lie to you," Diggs says.

Grylls told the AP the best guests are always those who come with a willingness to go with it,

not to look good. "The wild is so unpredictable and stuff is always happening. You can't look cool all the time in the wild," he said.

The show is not just about survival. Grylls' guests usually open up and show a different side. Ora talks about her ties to Kosovo, Cooper seems unfazed eating mule deer tongue and Cumberbatch reveals stories about his grandfather. Over a campfire, Grylls goes deeper than many TV in-

"It's as much about the stars and their own personal journeys and struggles and battles as it is about the adventure and the places," he says. "I think that combination works well because it doesn't feel like a performance, like a chat show does, where you're dressed up and made up and you get three minutes.'

Cumberbatch is taken to the Isle of Skye, where his grandfather trained as a submariner. He learns how to use climbing talons and how to tie an Ital-

"It's not the same as doing a stunt on a Marvel film. It's a lot more real," Cumberbatch says. His meal is seaweed and limpets - "Definitely al dente," he jokes - and his bed is a wet field.

Ora arrives at the Valley of Fire in Nevada following a 15,000-foot (4,570-meter) skydive, learns a chimney climb, butchers a dead pigeon, sacrifices her lip balm to make a fire and uses a sock to soak up water. She and Grylls even dance on a rock ledge, casting their shadows tall.

Adventure

"The wild strips us all bare, doesn't it?" Grylls told the AP. "It's like a grape when you squeeze us, you see what we're made of. And that's always the appealing part of 'Running Wild' - getting to know the real people."

One commonality among the guests is that viewers will often hear it was the celebrity's parents who instilled in them a sense of adventure and testing themselves.

"It's a reminder just how important parenting is," Grylls said. "Almost invariably when I ask stars, 'Where does it come from?' they go, 'Oh, my dad was amazing when I was really struggling at school.' Or, 'My mum was just such inspiration holding down three jobs."

"Running Wild with Bear Grylls" is only one of several shows the adventurist is juggling. On TBS this year, he debuted "I Survived Bear Grylls," a competition series that bridges the survival and game show genres by having regular contestants recreate some of Grylls' stunts - like digging through poop or drinking urine. Younger fans can also enjoy "You vs. Wild," an interactive Netflix show that asks viewers to choose how Grylls will make it out of the wilderness alive.

"I'm not going to be doing these shows forever but hopefully having an adventurous spirit and knowing the value of great friends and the power of a never-give-up attitude in the world - hopefully those things will keep going," the 49-yearold said.

He seems to have tapped into something deep in the human DNA - a need to be able to start a fire, use tools and master the wild. But Grylls thinks it's more than that.

"I really believe it's a state of mind. We don't have to be in the wild to live an adventurous life,' he said. "It's how we live our life, how we approach our work, our relationships, our dreams, our aspirations, our interactions with people. Are we leaning on the adventure side? Are we always pushing the boundaries, taking a few risks?"

LAS VEGAS: No charges will be filed following a brief investigation of the altercation involving pop star Britney Spears, San Antonio Spurs rookie Victor Wembanyama and a member of the player's security team, Las Vegas police said Friday after determining she inadvertently "hit herself in the face.'

Spears said she was struck by a security guard as she tried to approach Wembanyama near a restaurant in a Las Vegas casino complex on Wednesday night. Wembanyama said a person, who he later found out was Spears, grabbed him from behind.

The Las Vegas Metropolitan Police Department said Spears had actually struck herself when someone pushed her hand off Wembanyama as she reached up to tap the No. 1 overall pick.

In its investigation, which is now over, police determined that the security guard did not willfully or unlawfully use force or violence against Spears. No arrests were

made and no one was cited, the report said. In the report, police said surveillance footage of the event "showed Britney going to tap the Spurs player on the shoulder When she touched the player (redacted) pushes her hand off of the player without looking which causes Britney's hand to hit herself in the face."

Spears filed a police report after the incident outside the restaurant, alleging battery. On Friday, she posted a reaction to Instagram with a caption that said "Either way I'm still a huge fan of the NBA player .. it's not his fault his security hit me

Wembanyama was making his NBA Summer League debut for the Spurs in Las Vegas on Friday night. The 7-foot-3 French teen was the No. 1 pick in last month's NBA draft and is entering the league with as much acclaim as anyone since LeBron James in 2003. The altercation happened Wednesday

night; Spears said she recognized Wembanyama at another hotel earlier in the evening and when seeing him again entering a restaurant at the Aria Resort & Casino she "decided to approach him and congratulate him on his success.'

Spears said Thursday, "His security then back handed me in the face without looking back, in front of a crowd. Nearly knocking me down and causing my glasses off my face." (AP)

LONDON: A man who says Kevin Spacey subjected him to a torrent of verbal abuse and grabbed him denied claims by the Hollywood star's lawyer that he had concocted the assault allegations, saying he'd kept the "horrific" incident bottled up for years.

Singer takes control of her own songs

'Speak Now (Taylor's Version)' is here

LOS ANGELES, July 8, (AP): In 2010, newly anointed as a Grammy winner, Taylor Swift released "Speak Now," her third studio album and her first without a single songwriting collaboration.

Her 2006 self-titled debut and 2008's "Fearless" had inspired both acclaim and criticism for her bold bridges and keen lyricism - these are masterful countrypop songs, critics argued, but surely a teen idol wasn't responsible for them. Swift proved her detractors wrong on "Speak Now," an album that arrived just before her pivot from country's youngest hope to pop's freshest voice.

The album served as a close document of her nascent fame and future career ambitions, and now, 13 years on, it's back. "Speak Now (Taylor's Version)," released Friday, is the third release of the six albums Swift plans to re-record. The Taylor's Version albums, instigated by music manager Scooter Braun's sale of her early catalog, represent Swift's effort to control her own songs and how they're used - a fitting ethos for "Speak Now," a record

built exclusively of her own voice. In preparation for "Speak Now (Taylor's Version)," The Associated Press reached out to Taylor Swift scholars to discuss all the ways listeners can and should think about the release.

Before "Speak Now" became "Speak Now," the working title was "Enchanted," named after the power ballad of the same name. The mythology (folklore, anyone?) behind the shift is that Swift's label president at the time, Big Machine Records CEO Scott Borchetta, told her to move on from whimsy and fairytale iconography - she was entering her 20s and this

LP warranted a more mature title. Transition creates an interesting framework for thinking about this album: Written largely between the ages of 18 and 20, released when she turned 21. "Speak Now" is a collection of songs on a precipice - of adulthood, of fame, of declaring ownership but still concerned with the subject matters that concern a young adult. There are crushes ("Superman," "Sparks Fly") and bittersweet breakups ("Back to December," "If This

Was a Movie"), alike. "You hear a youngness when you listen to these songs," says musicologist Lily Hirsch, author of "Can't Stop the Grrrls: Confronting Sexist Labels in Music from Ariana Grande to Yoko Ono." "It's all about these romantic relationships. The world hinges on all of that, which is so typical of that age. So, it is interesting hear the re-recordings bring a more mature voice to those earlier preoccupations.'

Elizabeth Scala teaches a course on Taylor Swift's songbook at the University of Texas at Austin as an introduction to literary studies and research methods.

"I think 'Speak Now' is still in the vein of 'I don't have enough life experience at my ripe age of 18 to give you a fully autobiographical anything, but I'm going to use what I read and what I know from other people," she says of the songs' lyrical content, which still manage to "make really beautiful, coherent things out of the messiness and inaccuracy of our memories.'

Coming a year after Kanye West interrupted her acceptance speech at the 2009 MTV Video Music Awards, "Speak Now" is the moment in Swift's career where she began to use her celebrity as a mirror to her interior life.

'Mean," a takedown of a rock critic, becomes a banjo-led treatise on antagonism of any kind; the blues-y "Dear John" centers on a young woman's tumultuous relationship with an older

Confronting

"Insults are everywhere in music, and men don't get the same flak for it," Hirsch says, in reference to "Dear John" and "Mean." "There's this idea that women especially are supposed to take the high road, turn the other cheek and all of that, and men can get away with the low road, and they certainly do in music. It's a kind of double standard. Women are labeled 'catty' when confronting bad behavior, like in 'Dear John.

A common pastime among Swift fans is to unearth the identities of her songs' subjects. But, to Scala, "the most boring way to think about Taylor Swift is in terms of her biography.

At a recent stop of her Eras Tour in Minneapolis, Swift seemed to agree, playing "Dear John" live for the first time in 11 years after delivering this introduction:

"I'm 33 years old. I don't care about anything that happened to me when I was 19 except the songs I wrote and the memories we made together. So what I'm trying to tell you is, I'm not putting this album out so you should feel the need to defend me on the internet against someone you think I might have written a song about 14 billion years ago.'

Scala sees a throughline between this album and its successors, with "Dear John" as a precursor to "All Too Well" and "Mean" as prescient to "Blank Space," a song that parodies how she's been portrayed in the media.

Much online chatter surrounding the re-recording of "Speak Now" has centered on "Better Than Revenge," a pop-punk song that takes aim at another woman instead of the man that wronged them both. It takes both sonic and thematic cues from Paramore's 2007 pop-rock hit "Misery Business," a similar song about the same subject. (In fact, on "Speak Now (Taylor's Version)," Paramore singer Hayley

Williams lends vocals to a "vault" song, "Castles Crumbling.")

In the original chorus of "Better Than Revenge," Swift sings, "She's an actress / She's better known for the things she does on the mattress," a rare lyrical misstep in a career underscored by poetic turns of phrases (in the opener "Mine," she sings "You made a rebel of a careless man's careful daughter"). In her 2023 "Better Than Revenge" version, the lyric becomes "He was a moth to the flame / She was holding the matches.

"If we think about 2010, slut-shaming rhetoric certainly existed in movies and snows. She's certainly not the only who has done this at that time," Hirsch argues, quick to point out that Swift has also been the target of sexist vitriol.

Swift's alteration of the song in her re-recording follows a lineage of other pop stars doing the same. Lizzo and Beyoncé recently changed lyrics to songs deemed offensive. Weird Al no longer performs his Michael Jackson parodies. And because Swift hasn't performed "Better Than Revenge" live for well over a decade, she hasn't needed to confront this particular song, in this particular way.

"We are willing to replace the old version with Taylor's Versions because they are exact replicas, as much as they can be," Scala argues. "If she does something different, it becomes a different song." A different song, this time, owned by Swift.

"From a literary historian's point of view, when you first hear 'Speak Now,' you could only look at her career up to that point: It meant something in her creative timeline," says Scala. "And now we have the rest of her career to compare it to, so it's hard to listen to the record the same way. You can compare it to the older recording, but its deeper and richer."
Technology has changed from 2010.

So has Swift: Her voice has matured. no longer possessing the sweet selfrestraint that colored her earliest re-

Each release comes with a few "From the Vault" tracks, unreleased songs from each album's period reimagined for the current moment. They, too, give a fuller picture.

Beyond all of the music and cultural considerations, the fact is: Taylor Swift is re-recording this album to own her work, like she is doing with so many of her records - but this is the only album in her discography that is entirely selfpenned, the one celebrated for its dismissals of exploitative male characters and poetic embrace of girlhood.

In fact, it's hard not to think of "Could've, Would've, Should've" from her 2022 LP, "Midnights," where Swift sings "Give me back my girlhood, it was mine first," as a self-reflection of her "Speak Now" self.

FDA fully approves Alz's drug Leqembi

WASHINGTON, July 8, (AP): US officials granted full approval to a closely watched Alzheimer's drug on Thursday, clearing the way for Medicare and other insurance plans to begin covering the treatment for people with the brain-robbing

The Food and Drug Administration endorsed the IV drug, Leqembi, for patients with mild dementia and other symptoms caused by early Alzheimer's disease. It's the first medicine that's been convincingly shown to modestly slow the cognitive decline caused by Alzheimer's.

Japanese drugmaker Eisai received conditional approval from the FDA in January based on early results suggesting Leqembi worked by clearing a sticky brain plaque linked to the disease.



The FDA confirmed those results by reviewing data from a larger, 1,800-patient study in which the drug slowed memory and thinking decline by about five months in those who got the treatment, compared to those who got a dummy drug.

"This confirmatory study verified that it is a safe and effective treatment for patients with Alzheimer's disease,' said FDA's neurology drug director, Dr. Teresa Buracchio, in a statement.

The drug's prescribing information will carry the most serious type

of warning, indicating that Leqembi can cause brain swelling and bleeding, side effects that can be dangerous in rare cases. The label notes that those problems are seen with other plaquetargeting Alzheimer's drugs.

The process of converting a drug to full FDA approval usually attracts little attention. But Alzheimer's patients and advocates have been lobbying the federal government for months after Medicare officials announced last year they wouldn't pay for routine use of drugs like Leqembi until they receive FDA's full approval.

There were concerns that the cost of new plaque-targeting Alzheimer's drugs could overwhelm the program's finances, which provide care for 60 million seniors. Leqembi is priced at about \$26,500 for a year's supply of IVs every two weeks.

Safety

The vast majority of Americans with Alzheimer's get their health coverage through Medicare. And private insurers have followed its lead by withholding coverage for Leqembi and a similar drug, Aduhelm, until they receive FDA's full endorsement. An FDA decision on full approval for Aduhelm is still

Medicare administrator, Chiquita Brooks-LaSure, said in a statement Thursday the program will begin paying for the drug now that it has full FDA approval. But the government is also setting extra requirements, including enrollment in a federal registry to track the drug's real-world safety and effectiveness.

Medicare "will cover this medication broadly while continuing to gather data that will help us understand how the drug works," Brooks-LaSure said.

Some Medicare patients could be responsible for paying the standard 20% of the cost of Legembi, though the amount will vary depending on their plans and other coverage details.

Hospitals and medical clinics have cautioned that it may take time to get people started on the drug.

Doctors need to confirm that patients have the brain plaque

targeted by Leqembi before prescribing it. Nurses need to be trained to administer the drug and patients must be monitored with repeated brain scans to check for swelling or bleeding. The imaging and administration services carry extra costs for hospitals beyond the drug itself.

Eisai has told investors that about 100,000 Americans could be diagnosed and eligible to receive Leqembi by 2026. The drug is co-marketed with Cambridge, Massachusetts-based Biogen.

We want to ensure that appropriate patients only are the ones that get this product," said Alexander Scott, a vice presi-

Eisai studied the drug in people with early or mild disease who were evaluated using a scale measuring memory, thinking and other basic skills. After 18 months, those who got Leqembi declined more slowly - a difference of less than half a point on the scale - than participants who received a dummy infusion. Some Alzheimer's experts say that delay is likely too subtle for patients or their families to notice.

But federal health advisers said the difference could still be meaningful and recommended that FDA fully approve the drug at a public meeting in June.

Human remains are at the center of tangled litigation involving a major regional health care system and the company contracted to dispose of its medical waste.

Monarch Waste Technologies sued Sanford Health and the subsidiary responsible for delivering the health care system's medical waste, Healthcare Environmental Services, saying the latter "brazenly" deposited a human torso hidden in a plastic container to Monarch's facility in March. Monarch discovered the remains four days later after an employee "noticed a rotten and putrid smell," according to the company's complaint.

Monarch rejected the remains and notified North Dakota's Department of Environmental Quality, which is investigating. An agency spokeswoman declined to comment during an active investigation.

The Texas-based company also claims an employee of Sanford Health's subsidiary deliberately placed and then took photos of disorganized waste to suggest that Monarch had mismanaged medical waste, part of a scheme that would allow the subsidiary to end its contract with the facility.

Waste

"Put simply, this relationship has turned from a mutually beneficial, environmentally sound solution for the disposal of medical waste, and a potentially positive business relationship, to a made-for television movie complete with decaying human remains and staged photographs," Monarch's complaint states.

In its response, Sanford Health has said the body part was "clearly tagged" as "human tissue for research," and "was the type of routine biological material inherent in a medical and teaching facility like Sanford that Monarch guaranteed it would safely and promptly dispose (of)."

Sanford described the body part as "a partial lower body research specimen used for resident education in hip replacement procedures." A Sanford spokesman described the remains as "the hips and thighs area" when asked for specifics by The Associated Press.

Monarch CEO and co-founder David Cardenas said in an interview that the remains are of a male's torso

"You can clearly see it's a torso" in photos that Monarch took when it discovered the remains, Cardenas said.

He cited a state law that requires bodies to be buried or cremated after being dissected. He also attributed the situation to a "lack of training for people at the hospital level" who handle waste and related documentation.

Cardenas wouldn't elaborate on where the body part came from, but he said the manifest given to Monarch and attached to the remains indicated the location is not a teaching hospital.

"It's so far from a teaching hospital, it's ridiculous," he said. It's unclear what happened to the remains. Monarch's complaint says the body part "simply disappeared at some point."

Sanford Health's attorneys say Healthcare Environmental Services, which is countersuing Monarch and Cardenas, "never removed body parts" from Monarch's facility, and that Monarch "must have disposed of them."

The Sanford spokesman told the AP that "the specimen was in Monarch's possession when they locked Sanford out of their facilities."

Greta Thunberg charged: Swedish prosecutors have charged climate activist Greta Thunberg with disobedience to law enforcement in connection with a protest in Malmö last month.

Local newspaper Sydsvenskan reported Wednesday that Thunberg was detained with other activists after they stopped traffic in the oil terminal of the port in Malmö on June 19.

A short statement by Swedish prosecutors has said a "young woman" was charged with disobedience because she "refused to comply with police orders to leave the scene" during the protest. The statement didn't identify the woman, but Swedish Prosecution Authority spokeswoman Annika Collin confirmed that it was Thunberg. Sydsvenskan said the 20-year-old Swed-

ish activist will be called to trial at the end of July. Prosecutor Charlotte Ottosen told the paper that the crime of disobedience is typically punishable with fines.

Thunberg's media team didn't immediately answer a request for comment.

Thunberg inspired a global youth movement demanding stronger efforts to fight climate change after staging weekly protests outside the Swedish Parliament starting in 2018. (AP)

Artifacts back in Kenya: The Illinois State Museum have returned nearly 40 sacred artifacts to Kenya so they can go back to their rightful owners. Museum officials said in a statement

that they have completed transferring 37 wooden statues to the National Museums of Kenya so they can be returned to Mijikenda communities. The statues are considered sacred and are believed to carry the spirits of deceased male Mijikenda elders.

The Illinois State Museum said the statues were removed from Mijikenda villages and sacred sites in the 1980s, acquired by art collectors and later transferred to the museum as part of its African collection. Museum staff discovered in 2006 that one of the statues had been stolen and returned it to its owner.

The Illinois State Museum's curator of anthropology, Brooke Morgan, plans to visit Kenya this month and meet with Mijikenda elders to learn more about efforts to protect statues and restore them to their communities. (AP)

Aging is complicated

'Why no 2 people age the same way'

You likely know someone who You likely know someons seems to age slowly, appearing years younger than their birth date suggests. And you likely have seen the opposite - someone whose body and mind seem much more ravaged by time than others. Why do some people seem to glide though their golden years and others physiologically struggle in midlife?

I have worked in the field of aging for all of my scientific career, and I teach the cellular and molecular biology of aging at the University of Michigan. Aging research doesn't tend to be about finding the one cure that fixes all that may ail you in old age. Instead, the last decade or two of work points to aging as a multi-factoral process - and no single intervention can stop it all.

There are many different definitions of aging, but scientists generally agree upon some common features: Aging is a time-dependent process that results in increased vulnerability to disease, injury and death. This process is both intrinsic, when your own body causes new problems, and extrinsic, when environmental insults damage your tissues.

Your body is comprised of trillions of cells, and each one is not only responsible for one or more functions specific to the tissue it resides in, but must also do all the work of keeping itself alive. This includes metabolizing nutrients, getting rid of waste, exchanging signals with other cells and adapting to stress.

The trouble is that every single process and component in each of your cells can be interrupted or damaged. So your cells spend a lot of energy each day preventing, recognizing and fixing those problems.

Aging can be thought of as a gradual loss of the ability to maintain homeostasis - a state of balance among body systems - either by not being able to prevent or recognize damage and poor function, or by not adequately or rapidly fixing problems as they occur. Aging results from a combination of these issues. Decades of research has shown that nearly every cellular process becomes more impaired with age.

Most research on cellular aging focuses on studying how DNA and pro-

teins change with age. Scientists are also beginning to address the potential roles many other important biomolecules in the cell play in aging as well.

One of the cell's chief jobs is to maintain its DNA - the instruction manual a cell's machinery reads to produce specific proteins. DNA maintenance involves protecting against, and accurately repairing, damage to genetic material and the molecules binding to it.

Proteins are the workers of the cell. They perform chemical reactions, provide structural support, send and receive messages, hold and release energy, and much more. If the protein is damaged, the cell uses mechanisms involving special proteins that either attempt to fix the broken protein or send it off for recycling. Similar mechanisms tuck proteins out of the way or destroy them when they are no longer needed. That way, its components can

Function

The cross-talk between the components inside cells, cells as a whole, organs and the environment is a complex and ever-changing network of in-

When all processes involved in creating and maintaining DNA and protein function are working normally, the different compartments within a cell serving specialized roles - called organelles - can maintain the cell's health and function. For an organ to work well, the majority of the cells that make it up need to function well. And for a whole organism to survive and thrive, all of the organs in its body need to work well.

Aging can lead to dysfunction at any of these levels, from the sub-cellular to the organismal. Maybe a gene encoding an important protein for DNA repair has become damaged, and now all of the other genes in the cell are more likely to be repaired incorrectly. Or perhaps the cell's recycling systems are unable to degrade dysfunctional components anymore. Even the communication systems between cells, tissues and organs can become compromised, leaving the organism less able to respond to changes within the body.

Random chance can lead to a growing burden of molecular and cellular damage that is progressively less wellrepaired over time. As this damage accumulates, the systems that are meant to fix it are accruing damage as well.

This leads to a cycle of increasing wear and tear as cells age. The interdependence of life's cellu-

lar processes is a double-edged sword: Sufficiently damage one process, and all the other processes that interact with or depend on it become impaired. However, this interconnection also means that bolstering one highly interconnected process could improve related functions as well. In fact, this is how the most successful anti-aging interventions work.

There is no silver bullet to stop aging, but certain interventions do seem to slow aging in the laboratory. While there are ongoing clinical trials investigating different approaches in people, most existing data comes from animals like nematodes, flies, mice and nonhuman primates.

One of the best studied interventions is caloric restriction, which involves rewould normally eat without depriving them of necessary nutrients. An FDAapproved drug used in organ transplantation and some cancer treatments called rapamycin seems to work by using at least a subset of the same pathways that calorie restriction activates in the cell. Both affect signaling hubs that direct the cell to preserve the biomolecules it has rather than growing and building new biomolecules. Over time, this cellular version of "reduce, reuse, recycle" removes damaged components and leaves behind a higher proportion of functional components.

Other interventions include changing the levels of certain metabolites, selectively destroying senescent cells that have stopped dividing, changing the gut microbiome and behavioral modifications.

What all of these interventions have in common is that they affect core processes that are critical for cellular homeostasis, often become dysregulated or dysfunctional with age and are connected to other cellular maintenance systems. Often, these processes are the central drivers for mechanisms that protect DNA and proteins in the body. There is no single cause of aging. No

two people age the same way, and indeed, neither do any two cells. There are countless ways for your basic biology to go wrong over time, and these add up to create a unique network of aging-related factors for each person that make finding a one-size-fits-all anti-aging treatment extremely challenging. Lillard still waiting

Hawks agree to 4-year extension with Murray

ATLANTA, July 8, (AP): The Atlanta Hawks have agreed to a four-year, \$120 million contract extension with guard Dejounte Murray, a person with knowledge of the deal told The Associated Press on Friday.

The deal preserves his Hawks backcourt pairing with Trae Young and keeps Murray on the roster for five years, through the 2027-28 season, according to the person who spoke to the AP on condition of anonymity because the extension has not been announced.

Murray hinted at the agreement on his Twitter account when he posted late Thursday "ATLANTA. Been Locked In From The Moment Y'all Accepted Me" and added " LOYAL-

TŶ OVER EVERYTHING Let's G0000000000000000!!!!!! The Hawks helped to clear cap space for the extension on June 26,

when they traded forward John Collins to the Utah Jazz for veteran forward Rudy Gay and a conditional 2026 second-round draft pick. Collins is guaranteed \$25.3 million in the 2023-24 season. Gay, 36, is due approximately \$6.5 million. On Friday night, the Hawks of-

ficially announced the Collins trade, which creates a \$25.3 million trade exception for Atlanta. The exception, currently the largest in the NBA, can be used to acquire a player in a future deal within a year.

"Being able to create financial flexibility moving forward was a major priority for us," Hawks general manager Landry
Fields said in a statement released by the team. "The added flexibility will give us greater optionality as we look at opportunities to improve our team."

The extension was especially important for the Hawks following their significant commitment to Murray. On June 29, 2022, the Hawks traded Danilo Gallinari and three first-

round picks to the San Antonio Spurs for Murray.

Murray, 26, averaged 20.5 points and 6.1 assists for the Hawks last season, creating the high-scoring backcourt duo with Young that was expected. Even so, the Hawks suffered another first-round loss in the playoffs following their mid-season firing of coach Nate McMillan and the hiring of Quin Snyder as his replacement.

The Hawks finished 41-41, again unable to regain the promising form they showed when they advanced to the 2021 Eastern Conference finals.

Damian Lillard's position has not and will not change: The seven-time All-Star wants to be traded to the Miami Heat.

Lillard's agent, Aaron Goodwin, confirmed that stance Thursday and said he hopes that the Portland Trail Blazers - the team that Lillard has spent the entirety of his 11-year NBA career with - can engage with the Heat on steps toward a deal in the coming days, especially with virtually everyone from the NBA gathering in Las Vegas for Summer League that started on Friday.

BASKETBALL

The Trail Blazers publicly revealed this past weekend that Lillard had asked for a trade, an announcement that ended weeks of speculation about his future in Portland. Lillard had told the team that he wanted a chance to contend for a title; the Blazers have won only four playoff series in his 11 seasons and missed the playoffs in each of the last two years by wide margins.

"I'm hopeful that at least talks will initiate since they're all going to be in one place," Goodwin said. "That's my hope." It will obviously take a significant package of players and picks to make any trade happen. Lillard will make almost \$46 million this coming season and could make as much as \$216 million over the next four years if he exercises his option for the 2026-27 season.

'The solution comes in Miami actually having a chance to sit down and talk with Portland," Goodwin said. "I think if they can ever sit down and get in a room, there could be a deal to be made.

Lillard averaged 32.2 points this past season, has averaged at least 24 points in each of the last eight seasons, and has an offensive ignitability that few players in the NBA possess.

He became just the seventh player in NBA history to score more than 70 points in a game when he finished with 71 against the Houston Rockets on Feb. 26. The other names on that list: Wilt Chamberlain (who did it five times), Kobe Bryant, David Thompson, David Robinson, Elgin Baylor and Donovan Mitchell.

All six of the other players on that list were between 23 and 28 when they had their games of 71 points or more; Lillard was 32, a clear indicator that - even after 11 NBA seasons - he's far from past his prime.

The Heat are the reigning Eastern Conference champions, have been to the NBA Finals twice in the last four years and have been in the East finals three times in that span.

Murphy homers as red-hot Braves edge Rays

Cubs shut out Yankees

ST. PETERSBURG, Fla., July 8, (AP): On a night when they were held to just two hits, the red-hot Atlanta Braves kept on winning.

With right-hander Charlie Morton pitching into the seventh inning and Sean Murphy extending a power surge that has seen Atlanta homer in 24 straight outings, the MLB-best Braves began a weekend series between teams with the top two records in baseball with a 2-1 victory over the Tampa Bay Rays on Friday night.

Murphy backed Morton (9-6) with a two-run homer as Atlanta won for the 19th time in 21 games to improve its record to 59-28.

UEFA clears Brighton, Toulouse & Aston Villa for European entry but limits future transfer deals

Clubs prohibited from exchanging players

GENEVA, July 8, (AP): Under threat of losing European competition places, Brighton, Toulouse and Aston Villa were cleared by UEFA to play next season despite their owners having ties to other clubs that qualified, including AC Milan.

However, UEFA also prohibited the partner clubs - Brighton and Union Saint-Gilloise; Toulouse and Milan; Villa and Vitória Guimarães from exchanging players via sales or loans through the end of the summer transfer window next year.

UEFA drafted rules on multi-club ownership 25 years ago to protect the integrity of its competitions when the teams could be drawn to play each

September after persuading UEFA's club finance panel that its owner Tony Bloom does not also have decisive influence at Union. The Belgian club is in the Europa League qualifying playoffs.

Union president Alex Muzio said in a statement "it became clear that certain changes needed to be made to the ownership structure" to comply with UEFA regulations. As a result, Muzio said he increased his investment to become Union's majority owner, with Bloom's ownership reduced to a minority stake.

French Cup winner Toulouse goes into the Europa League despite its ties to American investment firm RedBird Capital Partners, which also owns Champions League team Milan.

Aston Villa's American owners reduced their stake last week in Portuguese club Vitória and both teams will now enter qualifying rounds for the third-tier Europa Conference

League. In multi-club ownership cases, UEFA rules give priority to the team that placed higher in its domestic league last season. The lower-ranked team risked being removed.

Brighton was in jeopardy because it placed a club-best sixth in the Premier League while Union was third in the Belgian league. Aston Villa was seventh in England, Vitória was fifth in Portugal.

The multi-club rules were most famously tested in 2017 by Leipzig and Salzburg which UEFA let enter the Champions League together despite both being part of the Red Bull group. In that case, no transfer limits were imposed and the clubs have continued to trade often between each other.

The UEFA ruling on Friday ended the hopes of Tottenham, eighth in the Premier League, being upgraded to European competition.

The threat posed by multi-club ownership to integrity in soccer and the transfer market was flagged by UEFA researchers this year in their annual analysis of the industry. They identified more than 180 clubs worldwide in a multi-club structure and a trend driven by American investors.

The biggest project is Abu Dhabicontrolled City Football Group which includes Manchester City among five European teams in a 13-club global project. The new Champions League winner is the only one of those teams which qualifies for UEFA competi-

Brighton's entry into the Europa League could be the most lucrative among the three clubs who were at

Brighton should earn at least 15 million euros (\$16 million) in UEFA prize money with more on offer from win bonuses and advancing through the knockout rounds. In the 2021-22 season, Europa League winner Eintracht Frankfurt got 38 million euros

(\$41 million) from UEFA. Playing and winning in European competitions is also seen as key to developing a club's ambitions, attracting players and earning UEFA ranking points that ensure more prize money and better seeding in future

seasons. Villa, the 1982 European Cup winner, has not qualified for any UEFA competition for 13 years and not played in any group stage since 2008. Toulouse last played in the 2009-10

Djokovic makes quick work of Wawrinka

Murray exits Wimbledon with uncertainty

WIMBLEDON, land, July 8, (AP): Novak Djokovic moved into the fourth round as he pursues some more significant numbers - a fifth consecutive title at Wimbledon; an eighth overall there; a 24th from all majors - by making quick work of Stan Wawrinka 6-3, 6-1, 7-6 (5). Djokovic trailed 5-3 in the closing tiebreaker before reeling off the last four points.

Andy Murray didn't know.

As he was asked to dissect his loss to Stefanos Tsitsipas in the second round of Wimbledon - a rollicking five-setter that lasted more than 4 1/2 hours spread over two days before a packed Centre Court filled with thousands of his

closest and loudest friends - Murray started answers to question after question at his news conference Friday with some variation of that theme.

It was, likely, a verbal crutch, something used to gather his thoughts before offering a more complete response. It also embodied the uncertainty that seems to surround a former No. 1 player who owns three Grand Slam titles, two at the All England Club, but also is now 36 and with an artificial hip after two operations.

Was it harder to accept this 7-6 (3), 6-7 (2), 4-6, 7-6 (3), 6-4 defeat, given both how close it was and all he's been through? "I don't know, to be honest," Murray's reply began.

Did the match change because it was suspended Thursday at 10:40 p.m., right after he'd taken a two-sets-to-one lead, because rules prevent play after 11 p.m.? "I don't know, to be honest." How frustrating was it that the contest was put on hold for nearly 18

hours? "Well, you never know what would have happened.'

Does the player ahead in that circumstance want to keep playing, while the player trailing prefers to stop? "I don't know.'

Will he return to Wimbledon next year? "I don't know."

"I'm obviously very disappointed just now. You never know how many opportunities you're going to get to play here," Murray said. "The defeats, maybe feel a bit tougher. But, to be honest, every year that Wimbledon's not gone how I would like, it's been

This was his second consecutive

exit in the second round at the site of three of his greatest triumphs: the 2012 Olympic gold medal and the 2013 and 2016 Wimbledon championships. His trophy a decade ago was the first for a British man at the All England Club in singles in 77 years.

Murray has not been past the third round at any major since getting to the 2017 quarterfinals at Wimbledon.

All in all, Friday was rough for the local fans: The other two British men left in the bracket, No. 12 Cam Norrie and wild-card entry Liam Broady, were sent home, too. Norrie was defeated by Chris Eubanks of the United States 6-3, 3-6, 6-2, 7-6 (3), and Broady lost

to No. 26 Denis Shapovalov of Canada 4-6, 6-2, 7-5, 7-5.

Iga Swiatek, made her way into the fourth round - she's never been further at the All England Club - as did No. 4 Jessica Pegula; No. 2 Aryna Sabalenka, two-time champion Petra Kvitova and 2022 runner-up Ons Jabeur moved into the third round. But No. 5 Caroline Garcia was a 7-6 (0), 4-6, 7-5 loser against No. 32 Marie Bouzkova.

Beatriz Haddad Maia, a 13th-seeded Brazilian who reached the semifinals at this year's French Open, beat Sorana Cirstea 6-2, 6-2 in the third round on No. 3 Court.

Two-time Wimbledon champion Petra Kvitova nearly made it in time, leading Natalija Stevanovic 6-3, 4-5 on No. 2 Court when the rain started. Kvitova needed only a few minutes after play resumed to complete the victory

Only Centre Court and No. 1 Court have roofs at the All England Club. Play in those two stadiums started as scheduled.

Verstappen takes pole at British GP

SILVERSTONE, England, July 8, (AP): Lando Norris nearly delighted the British Grand Prix crowd with pole position. There was just one problem: Max Ver-

"Ît's always Max. He always ruins everything for everyone,' Norris joked after the Dutch driver beat his time for his fifth pole position in a row on Saturday.

The British crowd roared in celebration when Norris briefly took over the top spot late in the qualifying session, before Verstappen went yet faster to take it back by .241 seconds.

The result may be routine in Formula One - Red Bull has taken pole in nine out of 10 races - but it followed a session of tension, another failure for Verstappen's teammate Sergio Pérez, and a moment of jeopardy for the Dutch driver himself.

MOTOR RACING

Verstappen made contact with the pit wall and broke his front wing while leaving his garage during a red-flag stoppage in the first part of qualifying. "I just understeered and it just didn't grip," he told the team over the radio.

Red Bull replaced the wing and checked there was no other damage before Verstappen continued, but he was at the back of a line of cars and worked his way through the field to set up for a fast lap, going side-by-side with old rival Lewis Hamilton on the way.

De Gea joined United from Atletico Madrid in 2011 and made 545 appearances for the Premier League club which included 190 clean sheets - both club records for

In a message on social media on Saturday, De Gea thanked United fans for their support but said: "Now, it's the right time to undertake a new challenge, to push myself again in new surroundings.'

On its website, United said "Thank you David" and called him a "record breaker." It said De Gea
