MPs approve 'Audit' resignation

KUWAIT CITY, July 11: The Cabinet on Monday ratified the government's 2023-2027 action plan.

Titled (correcting the course: product-based economy and sustainable wellbeing), the five-pronged plan breaks down into a number of programs and projects reflecting the government's goals based on the state's developmental plan, noted Deputy Premier Essa Al-Kanderi after the Cabinet's session.

This would contribute in accelerating pace of achievement, as well as further fruitful cooperation between the executive and legislative branches, pointed out Al-Kanderi, also Minister of State for National Assembly Affairs. The plan is to then be forwarded to the National Assembly.

The Cabinet also congratulated His Highness the Amir Sheikh Nawaf Al-Ahmad Al-Jaber Al-Sabah, His Highness the Crown Prince Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah, the Kuwaiti people and Arab and Muslim nations on the new Islamic year, which would start on Wednesday July 19.

On this occasion, the Cabinet decided that the government bodies would take Wednesday July 19 as a public holiday and Thursday July 20 as a rest day, and they would resume work on Sunday

The Cabinet also ordered the publication of 100,000 of copies of the Holy Quran translated into the Swedish language to be distributed in Sweden in coordination with the Foreign Ministry.

The move is meant to let people in Sweden get first-hand knowledge about Islam's Holy Book and the Islamic values and teachings of peace and tolerance as well as to help promote the values of peaceful co-existence between peoples of different faiths and to

Palestinian family evicted

Oh leadership ... situation is as it has been despite 13 parliaments and 30 governments

IF you count the number of parliaments that we have had since liberation to this day, the governments that have been formed since then, and the outputs since then, you will definitely be surprised. None of them either worked to meet the aspirations of the people, nor developed a productive renaissance plan that could meet the

Most of them instead fell into the trap of hiding behind the guise of arguments and disagreements with the parliamentarians. Since 1992 to this day, there have been 14 National Assemblies and about 30 governments, but none of them put in their program a responsible and realistic plan that can achieve the popular demands. Therefore, is it possible to bet on the two authorities now for the advancement of the country?

Let us take for instance the housing crisis that has been ongoing since before the liberation. What did successive governments do to solve it? How did the parliament perform? Did any of them do anything that could be relied on?

The housing crisis still exists and is in fact getting worse day by day, because none of those who are responsible for this matter care about it. In short, it is a source of profit for many of them, and therefore any solution will be at their

expense. That is why despite the random distribution of plots in some areas, the crisis continues. On the other hand, other countries resolved it with little effort through realistic decisions that meet the needs of the state first, and the population second, and grant social stability to citizens through self-sufficient housing cities in which all services

These goals were not achieved in Kuwait, because the idea behind the establishment of the Kuwait Credit Bank remained ink on a paper. Currently, the bank's capital stands at about KD 3.3 billion, and lends citizens about KD 3 billion, but still it falls under the inability to fulfill the many applications submitted to it, in addition to the administrative routine between the Ministry of Oil, Kuwait Municipality and the Ministry of Finance with regard to the allocation of land,

which made the citizens wait for over 20 years to get their "dream house."

On the other hand, there are several solutions, including amending the bank law so that commercial banks - both local and international - participate in it by guaranteeing the state the interest of soft loans, and these institutions can then work to grant them to citizens. Also, approved international companies can be chosen to pay the cost of construction of cities from scratch until securing housing for the citizens, just like the way some Gulf countries did. If the borrower is unable to pay the installments, he then can mortgage the house.

There is no doubt that the need for housing puts pressure on citizens, some of whom are forced to borrow in order to obtain a house.

On the other hand, this constitutes a new obstacle to meeting the needs of citizens with limited income, which pushes them to acquire

That is why consumer loans also constituted an eternal problem that led to a crisis of inability to pay, and caused some to resort to issuing cheques without balance, or trust bonds, which benefited the stakeholders who are part of the deep state by investing in the pains and concerns of the people.

When all these governments and parliaments are unable to meet the needs of the people, the defect is not in the laws, but in the wrong strategy on which political practice and the approach to people's problems were built. This in itself calls for reconsidering the mentality of dealing with

This is due to the fact that the authorities exist to manage the affairs of the people, and work to solve the expected problems. This is what a state does, and where officials always look ahead, and not at their ego and their own interests.

Home lost after 45-year battle

'I will not stay quiet'

JERUSALEM, July 11, (AP): Israeli authorities evicted a Palestinian family from a contested apartment in Jerusalem's Old City on Tuesday, capping a decades-long legal battle that has come to symbolize the conflicting claims to the holy city.

Activists say the Ghaith-Sub Laban family's removal is part of a wider trend of Israeli settlers encroaching on Palestinian neighborhoods with the government's backing and cementing Israeli control by seizing property in contested east Jerusalem. Israel describes the eviction as a simple

battle over real estate, with settlers claiming the family was squatting in an apartment formerly owned by Jews.

Earlier this year, Israel's Supreme Court struck down the family's final appeal, ending a 45-year-long legal battle and clearing the way for the eviction. Police officers came to Nora Ghaith-Sub

Laban's apartment in Jerusalem's Old City early Tuesday morning, forced open the door and removed the family. Her son, Ahmad Sub-Laban, said the family was barred from reentering the premises. "When we got back in front of the house,

we faced the new reality that our main entrance had been closed and we don't have the right to use it anymore," he said. "They took the key and changed the lock.

Several dozen protesters gathered and chanted "Occupation no more" at passersby outside the block of apartments as police stood by. Jewish settlers also gathered outside, dancing and smiling as they stared at the distraught family. Other settlers poured water down on family members from windows above.

Nora Ghaith-Sub Laban, the family matriarch, said she was in the hospital when police arrived. She accused Israel of trying to "ethnically cleanse" the area of Palestinians and vowed to continue fighting the eviction.

"My tears and all my crying is just sadness for losing my home, I'm parting with my entire life and all my memories that are

in this house. But I'm not weak," she said. But Arieh King, a settler leader and deputy mayor of Jerusalem, said it was a day to celebrate.

"At last after 40 years," he said. "They should be ashamed for using the property that does not belong to them

The family says it moved into the property in the early 1950s and rented it from a "general custodian" for abandoned propthen under Israel after the 1967 Mideast war. The case dragged on for decades, as the Israeli custodian and then the Kollel Galicia trust, the original property owner, contested the family's "protected" status.

Among the trust's claims was that the family did not use the property for extended periods. The family has said its members moved out for periods due to illness or attempts to repair the property.

Jerusalem's Old City, home to holy sites

of three monotheistic faiths, was captured by Israel along with the rest of east Jerusalem during the 1967 war and later annexed in a move unrecognized by most of the international community.

Israel considers the entire city its capital, while the Palestinian seek east Jerusalem as the capital of a future independent state. Today, more than 220,000 Jews live in

east Jerusalem, largely in built-up settlements that Israel regards as neighborhoods of its capital. Most of east Jerusalem's 350,000 Palestinian residents are crammed into overcrowded neighborhoods where there is little room to build.

The Ghaith-Sub Laban family said authorities did not let them back into the house to recover furniture or medicine for the mother and another son, Rafat. They were only able to grab one item as the authorities forced them out - a plant that has been in the family for 17 years.

"We decided to take it to remember that we lived here, our children grew up here and that we are looking forward to returning to the house," Ahmad Sub Laban said.

Ahmad and his siblings were evicted from the house in 2016. For now, Nora and her husband, Mustafa, plan to stay with their children until they can find a permanent place to live, Rafat Sub Laban said.

Across the city's eastern half, particularly in and around the Old City, settler organizations and Jewish trusts are pursuing other court battles against Palestinian families to clear the way for settlers

An Israeli law passed after the annexation of east Jerusalem allows Jews to reclaim properties that were Jewish before the formation of the Israeli state in 1948. Jordan controlled the area between 1948

and the 1967 war. "I will not stay quiet," Nora Ghaith-Sub Laban said. "If I find any loophole in the law, I will use it and I will sue them, because this is my right, and this is my home, and this is my land, and this is my country.

'Is preparing'

WASHINGTON, July 11, (AP): A U.S. intelligence assessment says Iran is not pursuing nuclear weapons at the moment but has ramped up activities that could help it develop them.

The assessment from the Office of the Director of National Intelligence released Monday says Iran has moved to increase its capacity to produce an atomic bomb since 2020 but has stopped short of that so far.

The findings corresponded with previous U.S. assessments about Iran's nuclear program, although many in Congress and elsewhere have been skeptical of those.

The Biden administration has been defending its desire to return to the 2015 nuclear deal with Iran, known as the Joint Comprehensive Plan of Action or JCPOA, since it first took office. That effort has been complicated in recent months by the suspension of its chief negotiator, Rob Malley, who was placed on unpaid leave last month pending an investigation into claims he mishandled classified information.

"Iran is not currently undertaking the key nuclear weapons-development activities that would be necessary to produce a testable nuclear device," according to the two-page unclassified synopsis of the report.

However, Iran is also pursuing "research and development activities that would bring it closer to producing the fissile material needed for completing a nuclear device following a decision to do so," the report said.

In that regard, Iran continues to violate the terms of the 2015 nuclear deal regarding uranium enrichment that it agreed to with world powers, the report said. The Trump administration withdrew from that agreement in 2018.

"Iran continues to increase the size and enrichment level of its uranium stockpile beyond JCPOA limits," the report said, adding that it also continues to exceed JCPOA restrictions on advanced centrifuge research and development.

These findings have been generally supported by inspections from the UN's nuclear watchdog, the International Atomic Energy Agency.

In addition to the nuclear find-

ings, the U.S. intelligence report sile programs continue to pose a significant threat to countries around the Middle East. "Iran has emphasized improving the accuracy, lethality, and reliability of its missiles," it said.

TEHRAN: Iranian President Ebrahim Raisi did not depart on a three-nation tour to Africa as planned, state media reported without elaboration. Raisi was supposed to travel

from Tehran on Tuesday morning, but no Iranian news outlets reported him leaving. The country's media said re-

peatedly over the past week that the president planned to visit Kenya, Uganda and Zimbabwe. State media did not elaborate on why he hadn't departed.

Kenya's foreign ministry said in a brief statement that the visit was delayed until Wednesday morning so key memoranda of understanding could be finalized "that are central to the furtherance of relations." The statement said the presidents would have a bilateral meeting after Raisi arrived.

It would be unusual for Iran's president to call off a foreign trip, though domestic visits sometimes are canceled.

In 2018, Iran canceled a visit by Iraq's then-prime minister, Haider al-Abadi, after he said he had no choice but to abide by renewed U.S. sanctions on Tehran even though he opposed them.

Iran's then-foreign minister, Mohammad Javad Zarif, reportedly canceled a trip to Italy amid tense nuclear talks, citing his tight schedule.



TEHRAN: Fire erupted at an oil refinery in southern Iran and injured eight firefighters Monday, the official IRNA news agency reported.

The news agency did not say what caused the fire but reported the firefighters were hurt while trying to put out the blaze burning in two of the five tanks at an oil depot near Iran's port of Bandar Abbas.

Authorities said there was concern the fire might spread to more tanks. The port, located at the mouth of strategic Strait of Hormuz, is a major import and export hub.

Similar fires were reported there in the past and at other oil facilities in Iran. Authorities blamed them on decades of international sanctions as well as hot summer weather.

VILNIUS: U.S. President Joe Biden on Tuesday hailed an agreement for Sweden to join NATO as more work remained to determine a path forward for **Ukraine**'s future with the alliance. Ukrainian President Volodymyr Zelenskyy criticized as "absurd" the absence of a timetable for his country's entry.

Biden described the summit as a "historic moment" and said the United States agreed with a proposal, yet to be released publicly, to outline a path for Ukraine's eventual membership. (AP)

ANKARA: Turkiye agreed on Monday to clear the way for Sweden's accession to NATO and Sweden vowed full support to Turkiye's bid to join the EU, a according to a tripartite statement.

"Given the imperatives of the deterrence and defence of the Euro- Atlantic area, Turkiye will transmit the Accession Protocol for Sweden to the Grand National Assembly, and work closely with the Assembly to ensure ratification," reads the statement issued following a meeting in Vilnius. (KUNA)

Nearly 50,000 Russians may have died

Data reveals carnage of human loss

Nearly 50,000 Russian men have died in the war in Ukraine, according to the first independent statistical analysis of Russia's war dead. Two independent Russian media outlets, Mediazona and Meduza, working with a data scientist from Germany's Tübingen University, used Russian government data to shed light on one of Moscow's closestheld secrets - the true human cost of its invasion of Ukraine.

To do so, they relied on a statistical concept popularized during the COVID-19 pandemic called excess mortality. Drawing on inheritance records and official mortality data, they estimated how many more men under age 50 died between February 2022 and May 2023 than normal.

Neither Moscow nor Kyiv gives timely data on military losses, and each is at pains to amplify the other side's casualties. Russia has publicly acknowledged the deaths of just over 6,000 soldiers. Reports about military losses have been repressed in Russian media, activists and independent journalists say. Documenting the dead has become an act of defiance; those who do so face harassment and potential criminal charges.

Despite such challenges, Mediazona and the BBC's Russian Service, working with a network of volunteers, have used social media postings and photographs of cemeteries across Russia to build a database of confirmed war deaths. As of July 7, they had identified 27,423 dead Russian soldiers.

"These are only soldiers who we know by name, and their deaths in each case are verified by multiple sources," said Dmitry Treshchanin, an editor at Mediazona who helped oversee the investigation. "The estimate we did with Meduza allows us to see the 'hidden' deaths, deaths the Russian government is so obsessively and unsuccessfully trying to hide."

To come up with a more comprehensive tally, journalists from Mediazona and Meduza obtained records of inheritance cases filed with the Russian authorities. Their data from the National Probate Registry contained information about more than 11 million people who died between 2014 and May 2023.

According to their analysis, 25,000 more inheritance cases were opened in 2022 for males aged 15 to 49 than expected. By May 27, 2023, the number of excess cases had shot up to 47,000.

That surge is roughly in line with a May assessment by the White House that more than 20,000 Russians had been killed in Ukraine since December, though lower than U.S. and U.K. intelligence assessments of overall Russian deaths.

In February, the U.K. Ministry of Defense said approximately 40,000 to 60,000 Russians had likely been killed in the war. A leaked assessment from the U.S. Defense Intelligence Agency put the number of Russians killed in action in the first year of the war at 35,000 to 43,000.

"Their figures might be accurate, or they might not be," Treshchanin, the Mediazona editor, said in an email. "Even if they have sources in the Russian Ministry of Defense, its own data could be incomplete. It's extremely difficult to pull together all of the casualties from the army, Rosgvardia, Akhmat battalion, various private military companies, of which Wagner is the largest, but not the only one. Casualties among inmates, first recruited by Wagner and now by the MoD, are also a very hazy subject, with a lot of potential for manipulation. Statistics could actually give better results."

Many Russian fatalities - as well as amputations - could have been prevented with better front-line first aid, the U.K. Ministry of Defense said in an intelligence assessment published Monday. Russia has suffered an average of around 400 casualties a day for 17 months, creating a "crisis" in combat medical care that is likely undermining medical services for civilians in border regions near Ukraine, the ministry said.

Independently, Dmitry Kobak, a data scientist from Germany's Tübingen University who has published work on excess COVID-19 deaths in Russia, obtained mortality data broken down by age and sex for 2022 from Rosstat, Russia's official statistics agency.

He found that 24,000 more men under age 50 died in 2022 than expected, a figure that aligns with the analysis of inheritance data.

The COVID-19 pandemic made it harder to figure out how many men would have died in Russia since February 2022 if there hadn't been a war. Both analyses corrected for the lingering effects of COVID on mortality by indexing male death rates against female deaths.

Sergei Scherbov, a scholar at the International Institute for Applied Systems Analysis in Austria, cautioned that "differences in the number of deaths between males and females can vary significantly due to randomness alone."

"I am not saying that there couldn't be an excess number of male deaths, but rather that statistically speaking, this difference in deaths could be a mere outcome of chance," he said.

Justice working overtime

France stern after thousands of teen arrests

At 19, he was the oldest of the group of teens accused of lobbing Molotov cocktails at the police station of their suburban hometown. "Why?" the judge asked Riad, who was taken into custody after he was identified in video surveillance images of the group from June 29, the second night of nationwide unrest following the police shooting of another suburban tennager outside Paris

another suburban teenager outside Paris.

"For justice for Nahel," Riad said. Slumped and slightly disheveled after five nights in jail, he said he didn't know about the peaceful march organized by Nahel Merzouk's family. He explained the cellphone photo of him holding a Molotov cocktail was "for social media. To give an image."

In all, more than 3,600 people have been detained in the unrest across France since the death of Nahel on June 27, with an average age of 17, according to the Interior Ministry. The violence, which left more than 800 law enforcement officers injured, has largely subsided in recent

French courts are working overtime to process the arrests, including opening their doors through the weekend, with fast-track hearings around an hour long and same-day sentencing.

The prosecutor noted that Riad had learned where to acquire incendiary devices on Snapchat, the social network which the French government has singled out along with TikTok as fueling the unrest. Riad's lawyer noted his record was clean, and he was blamed for no significant damage or any injuries.

By the end of Tuesday, Riad's sentence was fixed: three years, with a minimum of 18 months behind bars, barred from his hometown of Alfortville for the duration of the term.

He collapsed on the stand: "I'm not ready to go to prison. I'm really not ready." He threw a furtive kiss at his mother as he was led away.

Outside the packed courtroom, a pair of girls asked someone exiting what sentence he'd received. "Three years? That's insane!" one ex-

France's highest court has rejected a request by three groups seeking reparations for slavery in a case that originated on the French Caribbean island of Martinique.

The court's decision on Wednesday said that no one produced evidence showing they had "suffered individually" any damage from the crimes that their ancestors had been subjected to.

One of the lawyers pursuing the case, Alain Manville, called it a "political decision" and said he believed the large amount of money that France would have to pay in reparations was a major consideration for the court. He expressed hope for making the case more global, bringing in "all Afro-descendants" in a move that he believes would lead French judges to

see the case differently.

"We will succeed in this process," Manville said. "I don't know when."

Groups to appeal ruling

Supreme Court rejects requests for slavery reparations

Slavery was abolished in France in 1848, but before that had a significant slave trade, shipping more than 1 million Africans to colonies in the Americas. The International Movement for Reparations and two other groups launched efforts in pursuit of reparations in 2005. French courts have repeatedly rejected their request, but the European Court of Human Rights kept their efforts alive by making their claims admissible.

Another lawyer pursuing the case for reparations, Patrice Spinosi, in an emailed statement said the groups would approach the European Court of Human Rights for a new appeal.

The issue of reparations is widely debated across the Caribbean, where an estimated 5 million slaves were brought over by colonial powers, including Britain and France, and forced to toil on sugar plantations and other fields under brutal conditions.

In 2022, an appeals court in Martinique, which is an overseas department of France, rejected the groups' request, noting that there's a statute of limitations for those crimes and that a French law already allows the implementation of certain measures meant to "bring a memorial contribution to the recognition of slavery and the slave trade" and that it is not for the judiciary to decide if those measures are sufficient. (AP)

Russians who are missing but not officially recognized as dead, as well as citizens of Ukraine fighting in units of the self-proclaimed Donetsk and Luhansk republics, are not included in these counts.

Kobak acknowledged that some uncertainties remain, especially for deaths of older men. Moreover, it's hard to know how many missing Russian soldiers are actually dead. But he said neither factor is likely to have a huge impact.

"That uncertainty is in the thousands," he said. "The results are plausible over-

Asked by the Associated Press on Monday about the Meduza and Mediazona study, Kremlin spokesman Dmitry Peskov said during a conference call with reporters he wasn't aware of it as the Kremlin had "stopped monitoring" Meduza. Peskov also refused to comment on the number of deaths mentioned in the study, saying only that "the Defense Ministry gives the numbers, and they're the only ones who have that prerogative."

Meduza is an independent Russian media outlet that has been operating in exile for eight years, with headquarters in Riga, Latvia. In April 2021, Russian authorities designated Meduza a "foreign agent," making it harder to generate advertising income, and in January 2023, the Kremlin banned Meduza as an illegal "undesirable organization.'

Moscow has also labeled independent outlet Mediazona as a "foreign agent" and blocked its website after Russia's full-scale invasion of Ukraine. (AP)

demanded a " strong, firm and systematic" judicial response. Hearings began the next day, as the unrest continued into

"This is not hasty justice. The message I want to send is that justice is functioning normally in the face of an exceptional situation," said Peimane Ghaleh-Marzban, the president of the tribunal in Bobigny.

"You have many first-time offenders people who are not deep in delinquency, many minors in school who don't (engage in) habitual criminal activity," Ghaleh-Marzban said.

Despite that, the inclination to convict with jail time appeared to prevail.

In Lyon, France's second-largest metropolitan area by population, the prosecutor said Thursday that of 26 adults who have appeared before the fast-track courts so far, 22 were convicted and sentenced to jail, three requested more time to prepare a defense, and only one was acquitted. According to BFM television on Thursday, 76% of people in the fast-track

trials were placed in detention. The U.N. rights office said the unrest showed it was time for France to reckon with its history of racism in policing, rather than just lash out in punishment, saying the government needed to ensure the use of force "always respects the principles of legality, necessity, proportionality, nondiscrimination, precaution and accountability.

Many French lawmakers demand the maximum penalty - and fast.

Olivier Marleix, a lawmaker from the conservative Republicans party, called for all cases involving the unrest to be handled within 100 days.

"Not to punish this would be an injury to all our law enforcement. Not to punish this would be a failure to understand the gravity of the threat to France," he said

Tuesday in the National Assembly.

The officer accused in the death of 17-year-old Nahel, meanwhile, is charged with voluntary homicide but has yet to appear in a courtroom or even have a court date set.

Rayan, an 18-year-old man detained with a group of about 30 young people throwing fuel on his local police station, was accused of filming a 14-second video of incendiaries being hurled at the building in Kremlin-Bicetre. In the footage, he cries out "Light them up!"

It was the first time he'd ever been arrested. He was taken to Fleury-Merogis prison, the European Union's largest, and he wept on the stand on Tuesday. Prosecutors, who accused him of tripping a police officer while fleeing, asked for a 30-month sentence and for him to be barred from his hometown.

"I'm a good person. I've never had a problem with police. I have a family, I work," he said, burying his face in his hands. "I don't even know what I'm do-

His brief hearing ended with a 10-month suspended sentence. His parents picked him up the same night from prison to take him home. (AP)

KUWAIT CITY, July 11: The Ambassador of the Republic of China to Kuwait, HE Zhang Jianwei, said the Al-Durra field crisis, if any, must be resolved through what he called negotiations and friendly consultations, while at the same time affirming his country's respect

for Kuwait's sover-eignty, reports Al-Qabas daily.

In a statement to the daily, the Chinese envoy said, "The Kuwaiti and Saudi leaderships and their people have the wisdom and ability to solve this problem through consultations

and negotiations, and we respect Kuwait's

sovereignty and territorial integrity," indicating that his country calls for the settlement of international problems through consultations and political negotiations.

In reply to a question if the Chinese side was asked to play a mediating role to resolve the "Durra field" crisis, he said, "China has played its constructive role in improving relations between the Kingdom of Saudi Arabia and Iran, but with regards to the Durra oilfield, there is no official Chinese position so far, and in principle, we respect the sovereignty and territorial integrity of every country in the region.

Asked if Saudi-Iranian rapprochement could solve this file, the Chinese ambassador said, "We believe that solving problems is through friendly consultations, and negotiation is the best way.'

He pointed out that China continues to make efforts to support stability and peace in the region, and to push for a good-neighborhood policy, stressing that the Chinese president put forward last year the global security initiative. Therefore, we will make great efforts to translate this initiative, which will serve the interest of the region in general and the Gulf in particular.

He noted the close relations and historical partnership between China and the Gulf states, stressing that his country is a strategic partner for the GCC countries.

He pointed out that China played a positive role in resuming and restoring Saudi-Iranian relations, which received wide Arab, regional and global support, in a step that contributes to strengthening security and stability in the region, and works to consolidate relations be-

tween countries and peoples. The natural resources of the Durra field are fully owned by Kuwait and the Kingdom of Saudi Arabia, said Kuwaiti Minister of Foreign Affairs Sheikh Salem Abdullah Al-Jaber Al-Sabah Tuesday, according to KUNA.

Beware fake messages

KUWAIT CITY, July 11, (KUNA): The Interior Ministry warned the public on Monday against SMS messages sent by scammers asking people to pay traffic fines through a sent link or face bigger fines.

In a press statement, the ministry said that it does not send messages to threaten people with larger fines if they did not pay traffic violation fines.

These are scamming operations that use a website cloning the ministry's website to deceive people, the ministry cautioned.

It noted that it only sends alert messages of the traffic violations to violators on the government digital platform, Sahel applica-

It urged the public to make sure that they deal with the ministry's official website before any payment operation.

KUWAIT CITY, July 11: The Finance Minister Manaf Al-Hajri has resigned as Minister of Finance less than a month after the formation of the government, reports Al-Qabas daily. The daily added, he has submitted his resignation to

His Highness the Prime Minister Sheikh Ahmed Nawaf Al-Ahmad Al-Sabah, allegedly following disagreements within the government over 'floundering' decisions that have been taken that affected the country's economic and financial sides.

Reliable sources, told the daily, of particular interest were the differences over the transfer of the affiliation of the Kuwait Investment Authority to the Minister of Economic and Investment Affairs, stressing at the same time that "the separation between the Ministry of Finance and the Ministry of Economic and Investment Affairs caused a state of confusion and lack of clarity among a number of affiliated authorities, which prompted it to address the concerned authorities to clarify its affiliation with any min-

The resignation of Al-Hajri, who is known for his competence, high professionalism, and his ability to deal with thorny financial files and his expertise in economic affairs, shocked the economic and financial circles in the country, after he was blessed to assume the Ministry of Finance portfolio which carried the task of implementing radical economic and financial reforms to form a bridge towards sustainable budget that enhances the strength of the state's public finances and preserves prosperity for future genera-

The Council of Ministers had decided to maintain the affiliation of the Kuwait Investment Authority with the Deputy Prime Minister, Minister of Oil and Minister of State for Economic Affairs and Investment Sa'ad Al-Barrak, and not to return it to the Minister of Finance.

Salaries cut directives set to be applied soon

KUWAIT CITY, July 11: According to informed sources, government directives to reduce the salaries of chairpersons and members of the boards of directors of government bodies and agencies will come into effect soon. These directives were issued after monitoring the performance of many of those bodies that did not achieve the desired level of achievement and performance during the last period, reports Al-Rai daily.

They explained that the application of the directives will be within the framework of granting monthly salaries to the boards of directors at the rate of KD 6,000 to the chairman of the authority, KD 5,000 to his deputy, KD 4,000 to a fulltime member, and an annual salary of KD 4,000 only to a part-time member.

This trend includes all institutions and bodies that issue decrees, such as Kuwait Anti-Corruption Authority (Nazaha), the Direct Investment Promotion Authority, the Public Authority for Industry, the Capital Markets Authority, the Public-Private Partnership Authority, and other bodies.

There are two scenarios subject to research and study. The first is the possibility of applying soon to the existing boards so that salaries are reduced and packages of allowances, travel and other benefits are limited to specific items and within a very narrow spending range. As for the second scenario, it pushes towards applying the decision to the new boards of directors that are expected to issue decrees.

Such trends will have different dimensions and repercussions, as they will limit the placement of vacancies in many bodies to workers in the public sector. Technical problems may face the application related to the mechanisms of dealing with the second row of leaders of those agencies who receive salaries that will become more than what the chairpersons and members of its boards of directors receive, according to the expected procedures.

The next stage requires flexible mechanisms for implementation through gradual procedures, as the dealings of heads of bodies and their members with people working in the same entity and receiving higher salaries than them will raise a state of reservation. Therefore, it is possible to follow a policy of referring some of them to retirement, ending services, or assigning advisory tasks, in addition to reducing allowances and benefits as acceptable exits.

The sources stressed that the idea of compromising on the salaries of employees of the second and third ranks will be faced with legal texts that prevent them from being carried out, at a time when the government is interested in providing a stable business model that will be reflected in the performance of these bodies to achieve the required

public opinion and put the privacy of individuals and institutions in jeopardy.

In this context, Dr. Ahmad Al-Kandari, a professor of media and public relations at Kuwait University, said digital transformation has enabled everyone to gain easy access to media platforms in order to communicate with fans.

Speaking to KUNA, he listed the advantages of media digitalization as primarily helping governmental institutions to have their own media platforms to directly communicate with people and steer public opinion.

Media revolution

But, the Kuwaiti professor admitted that with this swiftly developing media revolution, it has become very uneasy for people in general and media specialists and academics in particular to keep abreast of this transformation.

"It has become inevitable to read and always follow up on new research (in media digitalization) with a view to developing learning in the media space," he underlined.

Concerning the role of social media in society, the Kuwaiti academic stressed that social media platforms, including ones with specific agendas and purposes, are now playing a big role in influencing people and that's why rules and controls should be set

for the virtual space.

For his part, Al-Jareeda Managing Editor
Naser Al-Otaibi said media digitalization
would lead to the "birth of new Kuwaiti media" including both public and private sectors, and would combine between both old

and new mass media.

Digital media platforms play an amazing supportive role for paper media and reflect media institutions' orientations, he said, believing that social media has an undeniable role to play in reporting and influencing audiences and even decision-makers.

But, he casted doubts about the credibility of new stories and content covered by social media in general, sounding the alarm that

this point, in particular, could negatively affect public opinion

in any society.

Boftein opined that both digital and conventional media entities are playing a complementary role in digital media

'Arab states reaction to Sweden's act of attacking Islam should be strong'

"THE State of Sweden has always surprised us with acts attacking Islam and Muslims, claiming that it applies its law and legislative principles that guarantee freedom of expression, and the strange thing is that that country that claims its ability to protect freedoms is unable to protect the citizens themselves, as the owner of the title of the happiest country in the world has turned into the capital of the use of violence among the citizens, after leaving the field for criminal gangs to carry out their activities, especially in the capital, Stockholm, and the fact of the matter is that there is a clear case of hostility towards Islam and Muslims in particular, and this is interfering with freedoms so that hostility is not focused only on Muslims directly," columnist **Mishari Al-Mutairi** wrote for **Al-Anba** daily.

"And I will present to you another evidence of the existence of this state of hostility towards Islam, if Sweden claims that it respects all forms of expression of opinion, even if it affects religious books and sanctities, but rath-

er that it gives its citizens and refugees a permit to do so while it considers that harming the flag of the state a crime punishable by law, and here lies the duality that shows its intentions towards Islam, which does not stop at this only, but the matter came to the kidnapping of children from Muslim families under flimsy and strange pretexts and handing them over to other families even if those families consisted of deviants, and this is what actually happened with a family of Arab refugees.



"Sweden's hostility to Islam may be classified by some as a case of Islamophobia, which is the fear of Islam, especially in light of its spread in Sweden, so that about 10% of Swedes embrace Islam, and thanks to God Almighty, this rate takes an upward curve every day, and this is what prompted intellectually extremist groups in Sweden to attack Islam and insulting Muslims in any way, and in their provocative attempts, they burned the Holy Qur'an more than once, and in one of the incidents, the Qur'an was burned in front of the embassy of one of the countries whose population embraces Islam.

"In fact, Kuwait's position on this was strong, as the Ministry of Foreign Affairs summoned the Swedish ambassador and submitted a protest note against that incident, which reveals the baseness of its perpetrator.

"In the context, the Federation of Associations in Kuwait announced that it had made an inventory of all Swedish products, circulated them to cooperatives, and launched a boycott campaign. And try to avoid the anger of Muslims.

"How I hope that the reaction of the Arab countries will be strong to make Sweden bite the fingertips of remorse for attacking Islam, this valuable religion.

"If Sweden had known the provisions of Islam that guarantee human beings the highest levels of freedom and dignity, they would have burned their constitution instead of burning the Holy Qur'an."

"In the first week of February 1991, I was in Riyadh in my office at the General Secretariat of the Cooperation Council, when the late Prince Faisal bin Fahd, Head of Youth Welfare in the Kingdom of Saudi Arabia, called me, inquiring about the validity of the news about the martyrdom of Sheikh Fahd Al-Ahmad Al-Jaber, in Kuwait," columnist Abdullah Bishara wrote for Al-Qabas daily.

'My answer was to confirm the veracity of the news about his death, which occurred at the gates of Dasman Palace, with bullets fired by an Iraqi group heading towards the palace. Prince Faisal replied that he would publish in the Saudi press condolences for the family, Kuwait, and sports fraternity in the Gulf and Asia, then he asked me to hold an emergency meeting for the heads of the Olympic committees in GCC countries to confirm the selection of his son, the young athlete Ahmed Fahd Al-Ahmad, to be the Gulf candidate to head the Asian Olympic Committee.

"In order not to waste time, I immediately contacted Sheikh Isa bin Rashid Al Khalifa in Bahrain, Sheikh Saud Al Thani in Qatar, Ahmed Bu Hussain in the Emirates, and Mr. Al Ghamari in the Sultanate of Omen, and we agreed to meet in the middle of February at the headquarters of the Secretariat in Riyadh.

"Sheikh Ahmed Al-Fahd came to Riyadh, determined to be ready to carry the burden that his father had chosen, and although the atmosphere of the meeting was fraught with sorrows for the loss of the martyr Fahd Al-Ahmad, the collective certainty that Sheikh Ahmed Al-Fahd is the best to succeed his father in his mission in Asia, brought satisfaction to the atmosphere of the meeting.
"The meeting ended with the collective allegiance of

the Gulf, and the responsibility for the victory of the Gulf candidate shifted to be sponsored by Prince Faisal bin Fahd, who knows the rules that lead the candidate to win without controversy, and His Highness Prince Faisal bin Fahd successfully led it as a royal contractor with extensive experience in the paths of success within the Asian network

"And we blessed Sheikh Ahmed with certain confidence in his worth and his belief in good behavior with Asians, and contacts quickly expanded to hold an urgent meeting of the Asian Committee, and with an intense Gulf presence, Sheikh Ahmed Al-Fahd was blessed as Chairman of the Asian Committee, and the vitality of the committee moved from central Asia to its west, where it settled in Kuwait, where Sheikh Ahmed provided it with a new approved headquarters in a private compound in Salmiya, east of Kuwait City, with an income guarantee for the course of work, reassuring the president of the solidity of his budget.

"Sheikh Ahmed, in the midst of this transformation, was confident of success and walked the steps of ambition calmly, relying on a gradual method of peaceful elevation to the highest platforms, preserving the dignity of the position he occupies. One of the most prominent threads of this map is the strong presence within the Qadisiya Sports Club, which was led by his brother Sheikh Talal, who carries broad indicators in the space of ambition, and is in harmony with what the older brother Sheikh Ahmed Al-Fahd thinks.

"It is noticeable that the two brothers, Ahmed and Talal, adhered to good vocabulary in dealing and tones of humility in communication while maintaining constant intimacy with assistants and close associates, not only with close Kuwaitis, but this approach remained closely with his Asian assistants and with sportsmen in the Asian continent.

"I met him in the framework of the sports meetings of the Gulf Cooperation Council, where his character helped him gain respect from others, and his cheerful spirit was a positive factor in the appreciation of societies, not only in sports, but in all locations, not only in Kuwait but wherever he was.

"His steps were on the path of ambition, in which he was dominated by a lot of softness, unlike his late father, Sheikh Fahd Al-Ahmad, who was always in a hurry in his steps, and he used to express his positions politely, devoid of the influences of dreams that were caressing him in every path of his life, so he drew up a map of action the most important of which is preserving his seat, which turned into a starting point for sports and political stations, so he came as Minister of Information in February 2001, and I was among those who were comfortable with his choice.

"His choice of the Ministry of Information was a reflection of his broad relations with Kuwaiti youth,

the breadth of his social contacts and his excellence in building friendships with various colors of Kuwaiti society and his ability to evoke intimacy with others, and he was, despite the high waves of his ambitions.

"Sheikh Ahmad has become the strong voice of the Kuwaiti youth, knowing what he wants and studying what he needs. According to the estimates of the Kuwaiti public opinion, he has become the entrusted person to fulfill the dreams of the youth, and the safe bridge between these youth and the higher leadership.

"His performance as Minister of Information during the years 2001-2003 was devoid of crises. He was aware of the need to preserve freedom of expression, be open to intellectual developments, and reduce taboos from publications. He was a successful minister who possessed social charisma, preserving his position, being present in various Kuwaiti arenas, and understanding political and social diversities and taking into account the sensitivity of Kuwaiti public opinion.

"He gave up the media, moving to the Ministry of Energy, which combined oil with electricity. That was in 2003, and he remained its minister until 2006, when he did not escape the arrows of the interrogations, so the divergence occurred with the submission of his resignation, and the many accusations with indications that he was a man of aggravation, and he was absent from the political scene but was back in May 2009, as Deputy Prime Minister for Economic Affairs, Minister of State for Housing Affairs, Minister of State for Development Affairs, and continued his activity in his association with the threads of athletes in various games and clubs.

"Signs of change appeared in his life in 2011, with the escalation of divergence in jurisprudence, and the noise of thunderbolts rising in political disputes with some centers with the accumulation of rumors, and with analyzes about the political goals he wanted to reach.

"Like others, I did not expect his determination to pass through that media political turmoil, with some influential gatherings, and I remembered the human ability to harmonize with changes, and in front of me was King Sihanouk, King of Cambodia, who did not accept a constitutional monarchy, and became a prince who assumed the presidency of the ministry, and then fell into disputes which kept him away for years in Beijing, and suddenly he came back as a representative of Cambodia in the Security Council, at a time when I was a representative of Kuwait, and engaged in a clash with the representative of Moscow, criticizing his behavior in a sarcastic manner, and invited me to a private meeting to discuss his case, and I listened to him, impressed by his flexibility and his ability to tame dangers and I can say that Sheikh Ahmed Al-Fahd is one of the best tamers

On June 21, 2023, Sheikh Ahmed Al-Fahd returned as Deputy Prime Minister and Minister of Defense, after twelve years of absence, and listened to the tones of his voice during oath-taking ceremony, confident of his future, and sure of his ability to tame the storms.

"The incidents and misfortunes that passed through the Arabian Gulf region have always demonstrated the common destiny of Kuwait and the brotherly Kingdom of Saudi Arabia, since the emergence of the region's star that caught the attention of the entire world," columnist Dr Essa Al-Omairi wrote for Al-Anba daily.

"Serious incidents always demonstrate the value of the relationship between brothers in the two countries. This value is demonstrated by each country whenever they stand by each other every time there is danger. They provide appropriate assistance and support for each other whenever the need arises.

"The Kuwaiti-Saudi relations are characterized by strength and durability always and forever. The ties between the two countries extended for various periods. These relations were established by the rulers of the two countries and passed through prominent stations full of goodness and blessings, while contributing to the consolidation of good and solid relations since a long time ago. These are embodied in many ties, customs, traditions and common history. These relations continue with the passage of time, and became an example of fraternal relations between countries united by common factors and issues of mutual concern.

"We must remember and praise them on every occasion and memory. Let us not forget that the Kingdom of Saudi Arabia stood heart and soul with its sister Kuwait during Saddam's brutal invasion at the end of the last century.

"The Kingdom and its brotherly people opened the doors of their homes to Kuwaitis during that period of Kuwait's life. The crisis proved the value of the people and leadership of the Kingdom during the reign of the late King Fahd bin Abdulaziz, may God give rest to his soul.

"Therefore, the current situation in the Gulf region and our talk about the Durra field, in which Iran entered its line and showed an unacceptable interference. It did not demarcate the borders until after reaching an agreement on its share in Durra field, which is originally Saudi-Kuwaiti.

"The issue did not stop at this point, but reached the intervention of Iraq through the statement of one of its representatives about Iraq's entitlement to Durra field, which is surprising and not based on facts.

"We say here that the joint will of the Kingdom and Kuwait will succeed, God willing, in confronting this crisis, just as we returned through solidarity and common destiny.'

"Perhaps, one of the most important steps to control inflation is the availability of basic data, so we have to support the Central Statistics Bureau and strengthen its role in carrying out periodic price surveys and statistics to monitor all types of inflation," columnist **Dr Abdu**laziz Al-Turki wrote for Al-Jarida daily.

'This is in addition to the provision of inflation data for decision makers, so the consequences and risks of government decisions and plans, and parliamentary legislation are linked to inflation predictions.

'Whenever too much money is chasing too few commodities, we reach the beginning of inflation. Traditionally, inflation is associated with increase in the prices of goods and services over a specific period due to lack of supply and an increase in demand, coupled with an

increase in money supply.

"Central banks usually implement their monetary policies by raising interest rates to reduce liquidity levels, but inflation is a chronic economic disease.

"Among these steps is subsidizing the prices of strategic food commodities, along with fuel, electricity, water and infrastructure services such as communications, transportation, and a safe and secure road network, while breaking the monopoly over food, livestock and construction materials, because the inflation of the price of residential real estate (construction, purchase, rent) burdens the family budget, and destabilizes and accelerates family disintegration.

"Price inflation is not only related to the basket of food, medicine and basic services, or human needs at the bottom of Maslow's hierarchy! Cancerous inflation attacks all aspects of life, hence, the need to combat it in terms of food, services, industry, real estate, education and the economy. In this manner, its devastating consequences will not be reflected on the body of the State, and the pocket of the citizen and his health.

DGDC seizes 3.5 kg drugs, 1,000 narcotic pills; 10 people nabbed

25 labor law violators arrested from fish market

KUWAIT CITY, July 11: The Criminal Security Sector of Directorate-General for Drugs Control has arrested ten people for possessing of approximately 3.5 kilograms of different types of drugs, reports Al-Jarida daily.

The DGDC personnel have also seized from them 1,000 Captagon pills and 21 types of psychotropic substances.

During interrogation the suspects are said to have admitted to the confiscated items with the intention of trafficking and consuming.

Consequently, both the suspects and the seized contraband have been handed over to the concerned authority for further legal action.

In this context, the Ministry of Interior has affirmed its commitment to actively combat drug dealers and smugglers and the spread of this scourge in the country.

25 law violators held: The continuous security campaigns organized by the General Department of Residence Affairs Investigations in collaboration with the so-called Tripartite Joint Committee - the Public Authority for Manpower, the Ministry of Commerce and Industry and the Interior Ministry -- 25 violators of the residence and labor laws were arrested from the Souk Sharq fish market, reports Al-Rai

All violators are being referred to the competent authorities to take all necessary legal measures against them.

Bachelors housing targeted: The Hawalli municipality's emergency team and rapid intervention force, in collaboration with several government agencies, targeted bachelor housing in model areas in Salmiya Sunday, which resulted in issuing warning notices and cutting power supply to six residential apartment buildings, reports Al-Anba daily.

The team also issued warnings to investment property owners for modifying structures and illegal power connections, and trespassing on government property.

The head of the Hawalli Municipality Emergency and Rapid Intervention Team, Ibrahim Al-Sabaan told the daily, the team has discovered several properties that have tampered with electrical connections, and the current has been cut off from these prop-

Al-Sabaan said that the municipality's campaigns against housing bachelors are under the supervision and follow-up of the Director-General of the Municipality, and that any property that is found to be renting to bachelors will be issued a violation according to the established procedures.

He pointed out that the power supply has been cut off for 25 violating properties in Hawalli since the start of the campaign and urged citizens to report any violating property so that the committee can take legal action against them.

4 injured in fire: The Public Relations and Media Department of the General Fire Force stated that after a report was received by the Central Operations Department at dawn today, stating that a kitchen fire had occurred in an apartment in a building in the Farwaniya area firemen rushed to the site of the fire and did the needful, reports Al-Rai daily.

According to fire sources a gas leak in the cooking gas cylinder was the cause of the fire and as a result the kitchen roof caved in and also damaged the adjoining

The building residents were evacuated as a precautionary measure and the fire was put out. Four people who were injured were taken to a hospital.

Meta's Threads is surging, but mass migration from Twitter is likely to remain an uphill battle

Twitter's move on July 1, 2023, to limit the number of tweets users can see in a day was the latest in a series of decisions that has spurred millions of users to sign up with alternative microblogging platforms since Elon Musk acquired Twitter last year.

In addition to a surge in numbers on Mastodon, the acquisition and subsequent changes boosted small existing platforms like Hive Social and has spawned brand new upstarts like Spoutible and Spill.

Most recently the microblogging platform backed by Twitter founder Jack Dorsey, Bluesky, saw a surge of sign-ups in the days following Twitter's rate limit, and Meta launched its microblogging platform Threads on July 5. Threads claimed 30 million users on its first day. Even very different forms of social media such as TikTok are benefiting from what many see as Twitter's imminent de-

As an information scientist who studies online communities, this feels like something I've seen before. Social media platforms tend not to last forever. Depending on your age and online habits, there's probably some platform that you miss, even if it still exists in some form. Think of MySpace, Live-

Journal, Google+ and Vine. When social media platforms fall, sometimes the online commus that made their homes there fade away, and sometimes they pack their bags and relocate to a new home. The turmoil at Twitter is causing many of the company's users to consider leaving the platform. Research on previous social media platform migrations shows what might lie ahead for Twitter users who fly the coop.

Several years ago, I led a research project with Brianna Dym, now at University of Maine, where we mapped the platform migrations of nearly 2,000 people over a period of almost two decades. The community we examined was transformative fandom, fans of literary and popular culture series and franchises who create art using those characters and settings.

We chose it because it is a large community that has thrived in a number of different online spaces. Some of the same people writing Buffy the Vampire Slayer fan fiction on Usenet in the 1990s were writing Harry Potter fan fiction on LiveJournal in the 2000s and Star Wars fan fiction on Tumblr in the 2010s.

By asking participants about their experiences moving across these

platforms - why they left, why they joined and the challenges they faced in doing so - we gained insights into factors that might drive the success and failure of platforms, as well as what negative consequences are likely to occur for a community when it relocates.

Regardless of how many people ultimately decide to leave Twitter, and even how many people do so around the same time, creating a community on another platform is an uphill battle. These migrations are in large part driven by network effects, meaning that the value of a new platform depends on who else is there.

In the critical early stages of migration, people have to coordinate with each other to encourage contribution on the new platform, which is really hard to do. It essentially becomes, as one of our participants described it, a "game of chicken" where no one wants to leave until their friends leave, and no one wants to be first for fear of being left alone in a new place.

For this reason, the "death" of a platform - whether from a controversy, disliked change or competition tends to be a slow, gradual process. One participant described Usenet's decline as "like watching a shopping mall slowly go out of business.

The current push from some corners to leave Twitter reminded me a bit of Tumblr's adult content ban in 2018, which reminded me of LiveJournal's policy changes and new ownership in 2007. People who left LiveJournal in favor of other platforms like Tumblr described feeling unwelcome there. And though Musk did not walk into Twitter headquarters at the end of October and turn a virtual content moderation lever into the "off" position, there was an uptick in hate speech on the platform, as some users felt emboldened to violate the platform's content policies under an assumption that major policy changes were on the way.

What makes Twitter Twitter isn't the technology, it's the particular configuration of interactions that takes place there. And there is essentially zero chance that Twitter, as it exists now, could be reconstituted on another platform. Any migration is likely to face many of the challenges previous platform migrations have faced: content loss, fragmented communities, broken social networks and shifted community norms.

But Twitter isn't one community, it's a collection of many communities, each with its own norms and motivations. Some communities might be able to migrate more successfully than others. So maybe K-Pop Twitter could coordinate a move to Tumblr. I've seen much of Academic Twitter coordinating a move to Mastodon.

Reluctant Twitter users, others flocking to new Threads app

NEW YORK, July 11, (AP): Celebrities, lawmakers, brands and everyday social media users are flocking to Meta's freshly minted app Threads to connect with their followers, including many Twitter refugees tired of the drama surrounding Elon Musk's raucous oversight of that platform.

But the real question is: Will they stay?

Instagram head Adam Mosseri said in a Threads post Monday that in the five days since its launch, 100 million people have signed up for Threads, which was rolled out as a companion app to Instagram.

Ann Coleman is among them. The 50-year-old, who lives in Baltimore, said she joined Threads after hearing about the platform from a comedian she follows on social media. She said she loves Twitter and has been using it for more than 10 years. She even met her husband on there.

But Coleman, who is politically progressive, has been looking to switch to a new platform because of Musk's political views and changes he's made to Twitter, like upending its verification system. She previously joined the decentralized social network Mastodon, but found it a bit confusing to use.

She said she likes Threads but wishes she could

easily follow all her Twitter friends there. Threads gives Instagram users the option to automatically fol-low the same accounts they do on the photo-sharing app, which makes it easier for active Instagram users to replicate a similar type of engagement on Threads. But others starting from the ground up will have to do more work.

"If I'm going to leave Twitter entirely, I'm going to have to try and find some of these people" from Twitter, Coleman said.

While she said she has her own concerns about Meta - specifically pointing to the Cambridge Analytica privacy breach, among other things - "it's not with the depth of concern that I do with Musk.'

Michael Evancoe, 28, said he hasn't used Twitter much since his personal page was suspended years ago for what the platform attributed to violations of its rules on spam. Evancoe, who now works in production, said he agrees with some of the changes Musk has been making on Twitter and he created a new account earlier this year. But he wasn't able to gain many followers or interactions.

He joined Threads last week, and says he's been able to interact more with other users. But he hopes that Meta does not moderate the platform overly aggressively.

"I think that would be a deterrent to both interest and engagement as well," Evancoe said.

For its part, Meta has said it will moderate using Instagram's content guidelines. In the past few days, the company has been positioning the much-hyped platform as a new digital town square that's a less toxic version of Twitter, with some executives indicating their aim isn't to replace Twitter but to offer something more palatable to a vast array of users.

"The goal is to create a public square for communities on Instagram that never really embraced Twitter and for communities on Twitter (and other platforms) that are interested in a less angry place for conversations," Mosseri said Friday.

In the first two full days that Threads was broadly available - Thursday and Friday of last week - traffic on Twitter was down 5% compared with the same period a week ago, and down 11% compared with the same period a year ago, according to the web analytics company SimilarWeb. But it also said Twitter traffic has experienced an overall decline even in the

Asian shares rise ahead of a US inflation update

Be wary of scams as Amazon Prime Day rolls off, experts warn shoppers

NEW YORK, July 11, (AP): Amazon Prime Day is here. And, once again, experts are warning consumers of scams.

Scams targeting online shoppers often by impersonating companies like Amazon and other major retailers - are nothing new. But phishing attempts increase amid busy spending seen during significant sales events - from Black Friday to, of course, Prime Day, according to the Better Business Bureau.

"This is a huge moment on the retail calendar," Josh Planos, vice president of communications and public relations at the Better Business Bureau, told The Associated Press. "And because of that, it represents an enormous opportunity for a scammer, con artist or even just an unethical business or organization to capitalize on the moment and separate folks from their hard-earned money.'

Prime Day, a two-day discount event, kicks off on Tuesday and runs through Wednesday. In guidance published last week, the Better Business Bureau reminded consumers to watch out for lookalike websites, too-good-to-be-true social media ads, unsolicited emails or calls and more near Prime Day and other sales events this month beyond Amazon's.

Scott Knapp, director of worldwide buyer risk prevention at Amazon, identifies two scams that the company has

seen in recent years around Prime Day: Prime membership and order confirmation hoaxes.

Last year, for example, people reported getting unsolicited calls or emails saying that there was something wrong with their Prime membership. Then, they were asked for payment information, like a credit card, and sometimes login credentials as well, Knapp explained - adding that Amazon "or any reputable business" wouldn't ask for those details in that way.

Urging consumers to confirm an order they didn't place is also a common tactic at this time of year, he adds. Scammers might pick something expensive, like a smartphone, to get attention - and again ask for payment information or send a malicious link.

"We sell a lot of stuff and people know the (Amazon) name," Knapp told the AP. "Bad actors try to take advantage of that.'

Of course, there's loads of additional scams out there - it's hard to identify more specifics for this year's Prime Day before it begins. Still, experts add, scams will often iterate year after year.

"Typically, the bones remain the same," Planos said, pointing to repeating fake delivery scams, email phishing and more. "It's always a ploy to separate consumers from (their) personal and payment information.'

NEW YORK, July 11, (AP): Stocks are ticking higher Tuesday as Wall Street waits for updates later in the week on inflation and corporate profits.

The S&P 500 was 0.3% higher in midday trading and looks to be on track for another quiet day after a listless Monday. The Dow Jones Industrial Average was up 141 points, or 0.4%, at 34,085, as of 11 a.m. Eastern time, and the Nasdaq composite was 0.2% higher.

Salesforce helped to prop up indexes after climbing 3.3%. The company said it's raising list prices for products by an average of 9%. Amazon was also pushing upward on the market, rising 1.2% on the first day of the annual Prime Day sales event it created. Activision Blizzard jumped 5% after a judge declined to stop Microsoft's \$69 billion takeover of the video game maker.

The week's main event will arrive on Wednesday, when the U.S. government will offer the latest update on inflation at the consumer level. Economists expect to see another slowdown, with prices 3.1% higher in June than a year earlier, down from inflation of 4% in May and just above 9% last summer.

The hope on Wall Street is that a continued easing in inflation will convince the Federal Reserve to stop its hikes to interest rates soon. High rates have helped pull down inflation, but they've also caused cracks in the banking, manufacturing and other industries while also pulling down on prices for stocks

and other investments.

Later in the week, companies will begin telling investors how much profit they made during the spring, and expectations are largely dim. Analysts are forecasting the sharpest drop in earnings per share for S&P 500 companies since the pandemic was crushing the global economy in the spring of

This upcoming reporting season could mark the trough for corporate profit declines, according to strategists at Bank of America. They point to some resilient trends in the economy, as well as how many companies are offering forecasts for upcoming results that are above analysts' expectations.

Forecasters expect inflation in June to fall to 3.1% from the previous month's 4%. That still would be higher than the Fed's 2% target but down sharply from last year's peak above 9%.

"They will have a hard time justifying further rate increases if headline inflation - which is their mandate - is moving convincingly towards target," said Rubeela Farooqi of High Frequency Economics in a

China, US agree to maintain high-level economic exchange

China and the US have agreed to maintain high-level exchanges and communications on all levels in the economic field, China's Finance Ministry said Monday.

The exchange, according to state-run Xinhua News Agency, comes in accordance with the consensus reached by the two heads of state during their meeting in Bali last November.

The ministry made the remarks when commenting on the US Treasury Secretary Janet Yellen's four-day visit to China that concluded Sunday.

During meetings with Yellen, the Chinese side has expressed the hope that the US will be rational and pragmatic in bringing bilateral ties back to the right track at an early date, the ministry said. It expounded on China's stance on bilateral economic issues and common global challenges, including the mutuallybeneficial nature of China-US economic relations, concerns over the US economic sanctions and suppression of China. China's position on healthy economic competition and China's willingness to work with

the US in addressing global challenges.
To achieve sound China-US economic relations, China believes that it is necessary to fully respect the legitimate development rights and interests of all parties and conduct healthy competition in accordance with the principles of market economy and WTO rules. China and the US should seek consensus on important bilateral economic issues through candid communications to inject stability and positive energy into the bilateral economic relations, the ministry said. UK wages rising at a record pace, making higher interest rates more likely

LONDON, July 11, (AP): Wages in the U.K. are rising at a record high rate amid stubbornly high inflation, official figures showed Tuesday, bolstering expectations that interest rates will increase again - to the worry of homeowners who are seeing their mortgage payments spike to levels not seen since the global financial crisis 15 years ago.

The Office for National Statistics said wages, excluding bonuses, rose by 7.3% in the three months to May, matching the highest rate since records began in 2001. The private sector was the main driver behind the increase

For months, workers have been seeking pay that keeps pace with high inflation, which is running at 8.7% despite declines in energy prices and a series of interest rate hikes from the Bank of England.

The central bank has been raising rates since late 2021 to get a grip on rising prices, which were first stoked by supply chain problems caused by the coronavirus pandemic and then Russia's invasion of Ukraine, which sent energy and food prices surging.

The bank lifted its main interest rate by half a percentage point to a 15-year high of 5% last month and warned of further increases if inflation fails to show signs of falling back toward its target of 2%. By making borrowing more expensive, the bank is trying to keep a lid on spending, which should get inflation down.

But with unemployment low, workers have been able to demand higher pay as inflation erodes their spending power, threatening to further fuel price spikes. That's despite the jobless rate rising to 4%, when economists had anticipated an unchanged reading of

"Soaring wage growth gets us into the kind of wage-price spiral dynamics that central banks absolutely hate and usually do anything to avoid,' said Neil Wilson, chief markets analyst at Markets.com.

The new wages data cemented expectations that the bank will lift its key interest rate to 5.25% next month, pos-

sibly to 5.5%. That was evident in the fact that the pound rose after the figures were released to a 15-month high against the dollar of \$1.29.

Expectations of higher borrowing rates are having a knock-on effect across lending markets, particularly in the housing market.

For example, the average two-year fixed mortgage rate rose to 6.66% on Tuesday, according to financial information company Moneyfacts. That's the highest level since August 2008, just before the collapse of U.S. investment bank Lehman Brothers.

Around 2.4 million fixed-rate mortgages are due to expire by the end of 2024, according to figures from trade association U.K. Finance. Households will be looking to lock in new deals, which as things stand, will be substantially more expensive.

"There is a significant increase in rates for customers maturing off their original product," Henry Jordan, home commercial director at Nationwide Building Society, told lawmakers in

Countries, companies can now apply for 'provisional' licenses

UN debates deep sea mining

SAN JUAN, Puerto Rico, July 11, (AP): A U.N. agency tasked with regulating the deep sea is debating whether to open the Earth's watery depths to countries and companies that as of Monday were allowed to start applying for provisional mining licenses.

The International Seabed Authority, based in Jamaica, launched a two-week conference on the issue Monday, a day after it missed a deadline to approve a set of rules and regulations to govern deep sea mining in international waters.

"We have a lot of work ahead of us," said Juan José González, the authority's council president.

The authority has issued more than 30 exploration licenses but no provisional licenses - so far. The debate on whether to allow

companies to extract precious metals from the deep sea that are used in electric car batteries and other green technology comes as more than a dozen countries call for a ban or moratorium given environmental concerns. Scientists have said that minerals

in the deep sea take millions of years to form, and that mining could unleash noise, light and suffocating dust storms. However, companies have argued that deep sea mining is cheaper and has less of an impact than land

Most of the current exploration is focused in the Clarion-Clipperton Fracture Zone, which covers 1.7 million square miles (4.5 million square kilometers) between Hawaii and Mexico. It is occurring at depths ranging from 13,000 to 19,000 feet (4,000 to 6,000 meters).

On Monday, Canada announced that it supported a moratorium because there is no regulatory framework in place nor a deep understanding of the environmental impacts of deep sea

"It is critical that the international community recognize its collective responsibility to safeguard the health and integrity of our shared global ocean for future generations," the government said in a statement. The 36-member council of the Inter-

national Seabed Authority is expected to debate the issue on Friday. But it's unclear when or if it would actually vote on whether to allow mining in deep international waters given sharp divisions over the issue. "There's really no appetite to vote,"

said Duncan Currie, an international and environmental lawyer and legal adviser to the Deep Sea Conservation Coalition, a Netherlands-based alliance of environmental groups. Currie, who was at the conference.

said in a phone interview that he envisioned three scenarios: the authority agrees on a legal and technical framework by the end of the year; the issue goes to Germany's International Tribunal for Law of the Sea if there's no consensus; or, a metals company submits a work plan to one of the authority's commissions, which would then have to submit it to the council for a vote.

González, the president of the council, urged members to "stay open and attempt to reach consensus" as he began the conference.

Rivals not only 'clashing' on the ground but battling economically for revenue from ports

'17.3 million of Yemen's 21.6 million people need aid'

UNITED NATIONS, July 11, (AP): Sporadic armed clashes between Yemen's Houthi rebels and government forces are straining peace efforts, and the rivals are now also battling over revenue from ports, trade, banking and natural resources, the country's U.N. envoy said Monday.

Special Representative Hans Grundberg told the U.N. Security Council that the fight over economic wealth "has become inseparable from the political and military conflict."

While fighting has decreased markedly in Yemen since a truce in April 2022, he said, "continued sparks of violence alongside public threats to return to large-scale fighting increase fear and tensions.'

Grundberg said Yemenis have enjoyed the longest period of relative calm since the civil war erupted in 2014, but "the situation on the ground remains fragile and challenging." He pointed to clashes in five frontline areas, including Hodeida where Yemen's main port is and the oil-rich eastern province of Marib which Iran-backed Houthi rebels attempted to seize in 2021.

Yemen's conflict began when the Houthis swept down from their northern stronghold and chased the internationally recognized government from the capital of Sanaa. A Saudi-led coalition intervened the following year on behalf of the government and in time the conflict turned into a proxy war between Saudi Arabia and Iran.

The war has devastated Yemen, already the Arab region's poorest country, and created one of the world's worst humanitarian disasters. More than 150,000 people, including fighters and civilians, have been killed.

The restoration of Saudi-Iran ties in April has raised hopes of progress in ending the conflict.

Grundberg said that although the truce was not renewed when it expired last October, the lessening of combat has opened the door for serious discussions with the parties on ending the war. He urged both sides to take "bold steps" toward peace.

"This means an end to the conflict that promises accountable national and local governance, economic and environmental justice, and guarantees of equal citizenship for all Yemenis, regardless of gender, faith, background or race," he said.

On the economic front, Grundberg said, the value of the Yemeni riyal has dropped more than 25% against the U.S. dollar in the past 12 months in the southern port city of Aden, which is now the seat of the internationally recognized government. Conflict-related road closures have more than doubled the cost of transporting goods, he said.

Joyce Msuya, the U.N. assistant

secretary-general for humanitarian affairs, said 17.3 million of Yemen's 21.6 million people need aid. She said one of the main reasons for the immense level of humanitarian needs is the deteriorating economy.

"Only by stabilizing the economy

can we reduce the staggering number of people in need," she said. She said that includes "the long overdue resumption of oil exports from government-held areas" and an end to the "obstruction to the transport of commercial goods from government- to Houthi-controlled areas."

Halfway through the year, Msuya said, the \$4.3 billion U.N. appeal for Yemen is only 29% funded and the World Food Program's operation to help the severely malnourished is reaching just 40% of needs. Without more funding by September, she said WFP "may be forced to cut as many as five million people from food assis-

tance." humanitarian coordinator David Gressly reported a key step in efforts to avoid an environmental disaster in the Red Sea, telling the council that the Houthis provided authorization Monday for the transfer of 1.1 million barrels of crude oil from the Safer, a rusting tanker moored 50 kilometers (31 miles) northeast of the Houthi-controlled port of Hodeida.

The Yemeni government bought the tanker in the 1980s to store up to 3 million barrels of oil pumped from the Marib oil fields. Because of the war, the tanker was not maintained since 2015, with seawater seeping into the hull causing damage that increased the risk of sinking and a major oil spill.

Gressly said that since the salvage ship Ndeavor arrived at the Safer site May 30 it has stabilized the tanker so its oil can be transferred. He said the tanker Nautica is preparing to sail from Djibouti and should start taking on oil from the Safer by early next week. The operation will take about two weeks, he said.

"The completion of the shipto-ship transfer of the oil will be a moment when the whole world can heave a sign of relief," Gressly said.

Just ask ex-Tumbir users

Mass migration from Twitter is likely to be an uphill battle

Elon Musk announced that "the bird is freed" when his US\$44 billion acquisition of Twitter officially closed on Oct. 27, 2022. Some users on the microblogging platform saw this as a reason to fly

Over the course of the next 48 hours, I saw countless announcements on my Twitter feed from people either leaving the platform or making preparations to leave. The hashtags #GoodbyeTwitter, #TwitterMigration and #Mastodon were trending. The decentralized, open source social network Mastodon gained over 100,000 users in just a few days, according to a user counting bot.

As an information scientist who studies online communities, this felt like the beginning of something I've seen before. Social media platforms tend not to last forever. Depending on your age and online habits, there's probably some platform that you miss, even if it still exists in some form. Think of MySpace, LiveJournal, Google+ and Vine.

When social media platforms fall, sometimes the online communities that made their homes there fade away, and sometimes they pack their bags and relocate to a new home. The turmoil at Twitter is causing many of the company's users to consider leaving the platform. Research on previous social media platform migrations shows what might lie ahead for Twitter

users who fly the coop. Several years ago, I led a research project with Brianna Dym, now at University of Maine, where we mapped the platform migrations of nearly 2,000 people over a period of almost two decades. The community we examined was transformative fandom, fans of literary and popular culture series and franchises who create art using those characters and settings.

We chose it because it is a large community that has thrived in a

number of different online spaces. Some of the same people writing Buffy the Vampire Slayer fan fiction on Usenet in the 1990s were writing Harry Potter fan fiction on LiveJournal in the 2000s and Star Wars fan fiction on Tumblr in the

By asking participants about their experiences moving across these platforms - why they left, why they joined and the challenges they faced in doing so - we gained insights into factors that might drive the success and failure of platforms, as well as what negative consequences are likely to occur

for a community when it relocates. Regardless of how many people ultimately decide to leave Twitter, and even how many people do so around the same time, creating a community on another platform is an uphill battle. These migrations are in large part driven by network effects, meaning that the value of a new platform depends on who else is there.

In the critical early stages of migration, people have to coordinate with each other to encourage contribution on the new platform, which is really hard to do. It essentially becomes, as one of our participants described it, a "game of chicken" where no one wants to leave until their friends leave, and no one wants to be first for fear of being left alone in a new place.

For this reason, the "death" of a platform - whether from a controversy, disliked change or competition tends to be a slow, gradual process. One participant described Usenet's decline as "like watching a shopping mall slowly go out of business.

The current push from some corners to leave Twitter reminded me a bit of Tumblr's adult content ban in 2018, which reminded me of LiveJournal's policy changes and new ownership in 2007. People who left LiveJournal in

favor of other platforms like Tumblr described feeling unwelcome there. And though Musk did not walk into Twitter headquarters at the end of October and turn a virtual content moderation lever into the "off" position, there was an uptick in hate speech on the platform as some users felt emboldened to violate the platform's content policies under an assumption that major policy changes were on the way. New adjunct therapy disrupts tormenting thinking patterns

FTP delivered thru mobile games fights depression

WASHINGTON, July 11: Americans keep their smartphones close, as any mental health therapist knows from watching patients cradle their devices and check them furtively for messages. The Gallup Poll found that 91% of people between ages 30 and 49 "keep it near almost all the time during waking hours."

The neuroscientists and digital experts who founded Hedonia saw an opportunity in this modern-day penchant, a chance to provide a novel-yet-simple therapy for patients with depression, anxiety, and other mood disorders.

That's the basis for facilitating thought progression, FTP for short. FTP is a new adjunct therapy delivered through mobile games that patients play for 15 to 30 minutes daily.

FTP is designed to disrupt tormenting thinking patterns, lack of motiva-tion, and the inability to experience pleasure, which are characteristic of mood disorders. And it's grounded in years of neuroscientific research at Harvard Medical School and elsewhere.

Neurotransmitters like serotonin and dopamine are the brain's chemical messengers. They affect mood, sleep, appetite, and memory. Depression, for instance, has long been attributed to a chemical imbalance in the brain.

Improve

Medicines for depression known as selective serotonin reuptake inhibitors (SSRIs) work by blocking serotonin reuptake into nerve cells after it carries a message, making more serotonin available to pass messages between nerve cells. SSRIs like Prozac (fluoxetine), Lexapro (escitalopram), and Celexa (citalopram) have been proven to improve the lives of many with depression and anxiety

Over the years, however, it's become clear to medical and mental health professionals that depression and anxiety are also thought disorders, according to Moshe Bar, Ph.D., the chief scientific officer of Hedonia and former director of the Cognitive Neuroscience Lab at Harvard Medical

"Ask anyone with depression, and they will tell you: Beyond a negative mood, the sources of their suffering are tormenting thinking patterns, lack of motivation, and lack of pleasure in

Therapists recognize the self-defeating thinking that is typical of people with depression. Bar identifies those

■ A tendency to ruminate, to dwell on negative feelings, their causes and consequences in an inescapable loop. ■ Narrow and slow-moving think-

ing.

• Inhibition about what they should do or say.

Focusing on little details with difficulty seeing "the big picture."

Those behaviors are not only observable in patients' behavior; they also revealed themselves in magnetic resonance imaging (MRI) studies of the brains of participants. In one such study Prof. Bar's lab found that:

1. People with depression act the brain's network supporting expansive thinking significantly less than those without depression.

2. People who ruminate and have constricted thinking experience a "critical loss" in neuron volume in the regions of the brain central to mood and memory

'The effect of depression is evident in all levels of brain functioning, from molecules to brain structures, to cognition," Bar says.

Over nearly two decades, Prof. Bar and other researchers have tested their hypotheses that changing the flow of thought could affect symptoms of depression for the better. In other words, facilitating thought progression could improve individuals' moods through noninvasive, simple exercises that would encourage them to:

■ Broaden their thought patterns to be more associative.

■ Think fast.

■ Widen their thinking to become more global and "big-picture."

"Mood affects the way we think. But can the way we think affect our mood?" wrote Prof. Bar and Malia F. Mason, professor in the Columbia School of Business, writing about results of their research that indicated the answer is a resounding, "Yes."

Mason and Bar measured the moods of two groups of study participants:

One group read chains of words that circulated around the same topic, imitating ruminative thinking. An example of such a "constrained" chain of words: lettuce, tomato, green, head, vegetable, cabbage, carrot, food, leaf, salad, hamburger.

A second group read chains of words in which the associations from word to word expanded and progressed. For example: thread, needle, shot, nurse, drugs, alcohol, wine, cheese, mouse, cat, dog, bone.

In the researchers' analysis, the participants who read the progressive word chains showed significant improvement in mood when compared with the group whose word chains were constrained.

In another study, participants were divided into two groups: One group read some text at a slow-to-normal pace, and the other read the same text at an increasing speed. The results: Fast reading significantly improved the readers' mood.

Other researchers asked a group of study participants to focus on a global landscape. They asked a second group to focus on small details within the landscape. The first group, which looked at the "big picture," had improved mood.

Research

These and other studies, published in peer-reviewed journals, form a body of research demonstrating that facilitating thought progression (FTP) by expanding people's thinking patterns and speed can improve their mood without the cost, risks, or side effects of medications.

Prof. Bar knew that millions could benefit from FTP if he could lift it out of labs and into their hands. He teamed up with Adi Pundak-Mintz, a longtime friend and investor, and Samuel Keret, a founding team member at Waze, a wildly successful app that Google eventually acquired.

For his next project, Keret wanted to do something with social impact. The Waze experience demonstrated how "sticky" apps are ones that people find fun, entertaining, and useful.

A digital application appealing to people with mood disorders could engage them in FTP exercises daily for 15 to 30 minutes. Mobile gaming, the Hedonia founders concluded, could do

"If you can deliver FTP with a game, it will stick," Keret says. "A game can create engagement and retention. And this is a good way for people who are unmotivated and lethargic to come back and use the treatment again and again.'

Importantly, Hedonia's FTP-based games are not meant to spark only moments of feeling good. Instead, through repeated play, they aim to increase the volume of neurons in the cortical regions of the brain that regulate mood and memory. These are the same regions that medications like SS-RIs affect.

"So we have a new approach and a new way to make it accessible to

Franklin's sons clash over her wishes in trial over dual wills

PONTIAC, Mich., July 11, (AP): Two sons of the late singer Aretha Franklin gave opposing opinions Monday about the Queen of Soul's final wishes, testifying in an unusual trial that will determine whether a 2014 handwritten document found in couch cushions will lead her

Franklin died in 2018 at age 76 without a formal, typewritten will, and five years later her legacy still is tied up in a suburban Detroit court

after a niece found different sets of handwritten papers at her home. The issue for a jury: Does a 2014 document count as a will under Michigan law? If so, it could trump a 2010 handwritten will that was found in a locked cabinet at the same time. The older version, however, was notarized and repeatedly signed by Franklin.

Ted White II, a son who played guitar during his mother's performances, favors the 2010 document.

"With all the time I spent working with her administratively ... every other document that she ever signed was something that was done conventionally and legally" and with assistance from a lawyer, White, 60,

He, acknowledged, however that the 2010 will found at the same time in 2019 was also written by his mother's hand.

There are differences between the documents, though they both appear to indicate that Franklin's four sons would share income from music and copyrights.

Four large posters showing pages from the 2014 document were presented to the jury.

That version crossed out White's name as executor of the estate and

named another son, Kecalf Franklin, in his place. Kecalf Franklin and grandchildren would get his mother's main home in Bloomfield Hills, which was valued at \$1.1 million when she died but is worth much more today

Kecalf Franklin, 53, said he doesn't consider it unusual that important papers like a will would be discovered in the living room.

Asked by his attorney where Aretha Franklin often read mail, made important phone calls, signed documents and even slept, Kecalf Franklin repeatedly said, "on the couch."

Testimony

A niece, Sabrina Owens, who managed the estate immediately after Franklin's death, did not appear in court Monday, but her testimony from a formal interview was read aloud. She explained how she was determined to search Franklin's house for critical records.

"She would use the kitchen and living room - that was about it," Owens said. "So when I got to the sofa, I lifted up that far right cushion and there was three notebooks there. The jury will hear closing arguments Tuesday.

The last public accounting filed in March showed the estate had income of \$3.9 million during the previous 12-month period and a similar amount of spending, including more than \$900,000 in legal fees to various firms.

Overall assets were pegged at \$4.1 million, mostly cash and real estate, though Franklin's creative works and intellectual property were undervalued with just a nominal \$1 figure.



Killer Mike keeps his amplified voice active

LOS ANGELES, July 11, (AP): It might have taken Killer Mike a decade to offer a solo music project, but the rapper hailing from Atlanta has certainly kept his amplified voice active.

As a member of Run the Jewels, Killer Mike, along with producer El-P, pumped out four critically acclaimed albums. He made noise outside of music as a social-political activist who has spoken out against inequality for Black people, race relations and became a vocal supporter of Sen. Bernie Sanders' 2016 US presidential campaign.

The Grammy-winner hosted Netflix's "Trigger Warning with Killer Mike," a 2019 documentary series about issues that affect the Black community. He



Now, Killer Mike wants to offer an extension of his efforts with the recently released "Michael," his first solo album since 2012. He calls his sixth studio offering an audio movie about a "prodigal son" filled with church, soul music and Southernisms.



In an interview with The Associated Press, Killer Mike talked about his grandparents' influence, comparing himself to Logan - aka Wolverine — from X-Men, and the reason elected officials should be leaned on more than him.

The rapper was about to kick off his 19-city tour on July 10, before he and El-P goes on a four-city Run the Jewels tour to celebrate their 10th anniversary in

AP: Why compare yourself to Logan?

Killer Mike: Logan was gruff as a defense mechanism, and he loved hard. He went hard for his people. He could heal quickly. He was resilient. At first, it was just bones, and it was pain. That's not all my life. But as a Black man in America, we can identify with that character. You can identify with Logan.... I was always attracted to that character. A lot of times, we get looked at as indestructible - whether it's playing sports, being an advocate or being a martyr for a cause. I just wanted to show that I'm a human being. I'm flesh and bones under here.

AP: Why did it take more than a decade for you to release a solo album?

Killer Mike: You set a goal. You're one half of what you feel could potentially be one of the greatest rap groups ever. If you see it through and you and your rap groups ever. If you see it through and you and your rap partner set a marker that in order to be an official rap group, you have to do like the groups that you looked up to — from EPMD, Outkast and Led Zeppelin. You got to put out four classic records. I think Run the Jewels accomplished that. Over the course of a decade, we forged away and created what I would say is arguably the greatest rap group active today.

AP: Where did you learn to become outspoken for important causes?

Killer Mike: I was shaped because my grandmother was active. I didn't have a choice but to be active. It's like flying home from a tour with Rage Against the Machine to testify on behalf of small Black club ownem strange. But if you grew up in Atla in my neighborhood, that's what you're supposed to do. You show up on behalf of your community

AP: What lessons were ingrained into you? Killer Mike: I'll give you what my grandfather gave me: Take care of yourself and your sisters. Don't embarrass yourself, me and your grandmama's name. Build a family name that you don't want to embarrass. Build goodwill in your community on a hyperlocal level. And lastly, he told me don't embarrass Black people. That meant to be noble and honest. I'm sincere in the things I do. I'm not a prostitute. I'm not selling myself out for issues. I'm not selling myself out for clout. I'm sincere in the things I'm about. All I ever wanted to be was an emcee. God gave me what I wanted. Everything I'm called to be in addition to that, I consider just a repay on the promise that God gave me. It's my way of repaying and showing thanks and gratitude for what my ancestors and God have given

AP: Should you be the primary voice on political and social issues?

Killer Mike: I'm not prostituting myself for every social campaign. We have a group of people who are qualified to do that. You have an amazing amount of people doing the work on an everyday basis that you should be following and reaching out to. I'm not here to replace them. Attorney Benjamin Crump is out there doing a noble job like Johnnie Cochran. We need to be standing with him. We don't need to try to replace him. I am simply trying to make sure that I help to mobilize those that are actually organizing on a daily basis. We have organizers that deserve to be followed. As athletes and entertainers and common people, we should be making sure they have a platform to do that - more so trying to be the next one.

AP: Would your grandmother be proud of how far you've come?


Killer Mike: She'd be proud. She used to say "That's my grandson, Killer Mike." I imagine her somewhere with her ancestors or with her sweet white Jesus saying, "That's my grandson."

AP: What do you want people to take away from

Killer Mike: Listen to this with your eyes closed from start to finish. I guarantee you're going to feel something. You're going to see the characters come to life before you. You're going to see the smell. You're going to see the sights. I sent the album to Jay-Z about a year ago when it was still unfinished. He sent back "I loved it!!" He said it felt like I had went to my aunt's house and watched a movie. Your aunt will let you watch the movies your momma won't. I was very flattered by that compliment. I hope others take the chance to participate in listening.

AP: You're a co-founder of Greenwood, a majority Black and Latinx-owned bank. How's business been

going since it launched in 2020? Killer Mike: It's growing with over 100,000 accounts now. I'm excited to have ventured into helping people get out of the industry of payday loans and into real accounts. I've been happy when I walk into a store and someone says, "Mike, I'm going to buy you a water. I've got my Greenwood card." That's absolutely amazing. From a business perspective, my wife and I want to expand. We want to expand the Swag Shop barbershop. We have three locations including one in State Farm Arena. On a homebound basis, I hope to help Frederick Douglass High School, my alma mater, to continue to be a school that produces great leaders. I want to be a cornerstone in my own community.

LONDON: An aspiring actor who accused Kevin Spacey of being a "vile sexual predator" who drugged and assaulted him when he sought his mentorship acknowledged Monday that he later joked with friends. The man testified that he used humor to

cope with the trauma he experienced after he fell asleep or passed out at the Hollywood star's flat.
"It became a running joke and that's me running with the joke," he said of the

mockery he made of the incident for a 'sense of catharsis.' The man is the fourth and final alleged victim to accuse the two-time Academy Award winner at trial of sexual assaults in **Britain** between 2001 and 2013 when Spacey worked

at the Old Vic Theatre in London. Spacey, 63, is on trial in a London court on 12 charges that include sexual assault, indecent assault and causing a person to engage in activity without consent. He denies all the allegations, and his lawyer has suggested the accusers are looking for

payouts from Spacey.

The witness said he hadn't complained about Spacey for nearly a decade after the 2008 incident because he wanted to work in the industry. He said it was a David vs. Goliath kind of situation and he feared "getting slammed by his lawyers."

'Beyond the Story' gives singular access to band

BTS memoir a love letter to their fans

LOS ANGELES, July 11, (AP): Like most releases from the world's biggest band, the debut memoir from the seven-member K-pop group BTS, "Beyond the Story: 10-Year Record of BTS", was a smashing success from moment the public learned of an anonymous, forthcoming text.

But unlike most BTS drops, the 544page book became a bestseller before the subject matter was even revealed. thanks in large part to Taylor Swift

In May, a listing for "4C Untitled Flatiron Nonfiction Summer 2023" inspired online speculation from Swift's cohort: an author and title was going to be revealed on June 13, and they believed the popstar was leaving them numerical easter eggs, or hints, as she often does in her rollout campaigns. Thirteen is Swift's favorite number. The page count, 544, when added individually, equals 13, like in the equation 5 + 4 + 4 = 13.

But there was a more obvious connection to be made. June 13, 2013 was the day BTS debuted, sharing their first ever single, the rebellious trappop, "No More Dream." So, when it was revealed that the text was actually an oral history of the band, written by journalist Myeongseok Kang with the members of BTS (RM, Suga, V, Jung Kook, Jin, Jimin, J-Hope) to celebrate their 10 years together, enthusiasm shifted to the K-pop audience.

And the excitement is warranted. "Beyond the Story: 10-Year Record of BTS", is an exhaustive archive of the boy band, a definitive document for diehard ARMY, the name of BTS'

Translated into 23 language and re-leased on July 9, or "ARMY Day" for BTS fans, the book details the band's entire career chronologically, leaving no moment unexcavated.

Kang serves as the reader's guide, offering necessary context to BTS'

revolutionary approach to the culture of the K-pop idol industry. At each turn, the band speaks from a personal perspective, outlining their hopes, thoughts, feelings, and experiences - the unrivaled access that sets this official biography apart from the countless unofficial others. Many of these stories will be familiar to ARMY, but the band's personal recollections provides a feeling of freshness.

More often than not, BTS' quotes lead with a waited emotionality, though there's quite a bit of humor as well. Fans will surely react when reading Jin describing Suga's 2013 dietary habits, which included blending chicken breasts, grape juice, and bananas for quick protein.

Challenges

Throughout "Beyond the Story" are 330 QR codes to inspire fans to pause their reading and reacquaint themselves with a video's choreography or re-listen to a single, like after learning Suga cried while writing and recording "Outro: Tear." It might not be the prettiest feature of a book filled with glossy images of the band throughout their distinct eras, but it does solve a problem unique to pop culture books. How can a reader experience the subject while learning about it?

For the casual and curious fan, "Beyond the Story" may present a few challenges. It requires some familiarity with the mechanics of the idol industry to fully appreciate how BTS challenged those expectations. As an example: the reader must understand that before a K-pop idol group is put together and presented to the world publicly, or "debuted," they enter a training process and are labeled "trainees," who live in dormitories together, where they are educated on dancing, singing, speaking to the media and be-

Only then can they appreciate BTS'

unique approach to the formulaic star system: That the band held their own "classes" for each other; Suga, RM, and J-hope teaching the others about hip-hop.

At one point, they were only trainees at their company HYBE (then known as Big Hit Entertainment), which limited networking opportunities and mentorship typically necessary for success. They focused on an American music market early on in unexpected ways, laying the foundation for their success in this country. Spacey, who is free on unconditional bail, could face a prison sentence if he's convicted.

'Model organism'

Zebrafish share 'skin' similarities with people

Melanocytes are a small subset of epidermal cells that play an outsize role in protecting your skin from the damaging effects of sun exposure. They do this by synthesizing melanins, which are pigments sent to other skin cells to shield them from harmful ultraviolet light. A lack of functioning melanocytes causes a wide range of skin conditions, including skin cancer and vitiligo, an autoimmune condition in which the

body attacks melanocytes and causes patches of depigmented skin.



For nearly 20 years, I have been studying melanocytes and the role they play in disease. Difficulties growing human melanocytes in cell cultures have led researchers like me to use alternative models to study them.

My lab and others have pioneered the use of zebrafish to study melanocytes. Using this small freshwater fish as a model organism, my team and I recently discovered a new way in which melanocytes regenerate. This process enables flexibility for these cells to recover from injuries and

may be applicable to other types of tissues. New students and nonscientists often ask me, "Why zebrafish?" There are several reasons why zebrafish are good models to study melanocytes.

Melanocytes in zebrafish are similar in many ways to those in people. These cells develop in embryos in the same way those in humans do, use the same genetic programs and make the same melanins. Melanocyte dysfunction in zebrafish also leads to the same diseases and cancers found in people.

Unlike melanocytes in mouse or human skin, zebrafish melanocytes are externally visible in their dark stripes and spotted scales. Researchers can place the whole fish directly under a microscope and see the cells without the need for a biopsy.

Experiments

Importantly, researchers can manipulate and perform experimportantly, researchers can manipulate and perform experiments on zebrafish melanocytes in ways that are unethical or not feasible to do with people. Unlike studies that use isolated melanocytes in a petri dish, these experiments can take place in the context of a whole animal, where we can monitor the surrounding skin and other biological factors for their influence on how replacements below and function. on how melanocytes behave and function. In work spearheaded by Tyler Frantz, a graduate student in

my lab, our team has focused our attention on the process by which new melanocytes regenerate after injury.

Melanocyte regeneration is important for recovering from skin disorders such as vitiligo. It's also relevant to age-related conditions like hair graying, in which melanocyte stem cells either die or become dormant and no longer produce the mature melanocytes that give hair its color.

To study melanocyte regeneration, we removed these cells from zebrafish and followed their process of regrowth. Since melanocyte stem cells in zebrafish are externally visible, we tracked these cells in real time to see how they divided and matured. Additionally, we measured which genes were expressed in individual melanocyte stem cells and their descendants during regeneration.

We found that dying melanocytes trigger this regenerative process by sending the signal for melanocyte stem cells - cells that can give rise to new melanocytes - to activate. Surprisingly, we identified two types of stem cells that each took a different route to make new melanocytes. One type of stem cell directly converted into melanin-producing melanocytes. The other type of stem cell divided to create two types of daughter cells. One type was new melanocytes, and the other was new stem cells ready to respond to future injury.

Researchers have known that a single stem cell is capable of making the multiple types of cells needed to regenerate tissue. Our zebrafish studies indicate that multiple different stem cells in skin, and potentially other tissues, can together reconstruct one particular cell type after injury. The involvement of multiple stem cells likely enables regeneration to nimbly adjust to different types of injuries.

Our findings from zebrafish are likely relevant to human skin. When we examined cells taken from the fluid within a blister in human skin, we found cells that look remarkably similar to zebrafish melanocyte stem cells. We are planning to see whether these human cells are activated in skin regeneration to make new melanocytes, which would confirm their identity as melanocyte stem cells.

Ultimately, we envision using these findings to develop treatments that reinvigorate melanocyte stem cells, which could help reverse skin color loss in vitiligo and other diseases. Such treatments may also help counteract age-related pigment loss in hair and skin.

The unique features of zebrafish have allowed us to uncover a new mode of cellular regeneration. Because of cross-species similarities, we expect that these and many other findings from research using zebrafish may be applied to human biology.

WASHINGTON: Federal officials on Tuesday called for more testing and research on xylazine, the powerful animal sedative that's spreading through the nation's illicit drug supply, but they stopped short of recommending new restrictions on the veterinary medication.

A six-point plan from the White House's drug control office aims to scale up testing, treatment and efforts to intercept illegal shipments of xylazine, which is being mixed into fentanyl and other illicit opioids.

The White House declared xylazine-laced fentanyl an "emerging threat" in April and called for a national strategy to combat its use. Xylazine, sometimes known as tranq, can cause breathing and heart rates to fall to dangerous levels when used in humans. When injected it can cause large open sores and infections, sometimes leading to amputation.

In the report released Tuesday, drug czar Dr. Rahul Gupta said administration officials will "explore" making xylazine a scheduled drug, subject to regulatory restrictions similar to opioids and amphetamines.

While some states have already scheduled the drug, those efforts have faced pushback from veterinarians, farmers and others who regularly work with it. Federal scheduling limits how drugs can be prescribed, dispensed and stored. Several bills in Congress aim to tighten use of xylazine without limiting its legitimate use in sedating horses, sheep and other animals.

The bulk of the White House's plan focuses on improving how use of the drug is tracked and treated by health profes-

"We need more testing to get a national picture of the threat," Gupta told reporters.

Current testing for xylazine is a patchwork of different approaches, with some medical examiners and health departments regularly detecting the drug in deceased overdose victims and collected drug paraphernalia. Recent federal figures suggest use has mushroomed in recent years. But a standardized testing approach is needed to understand the trajectory and scope of the drug's spread.

The plan also calls for the development of rapid tests for use by hospital staff and community workers who treat patients experiencing overdoses. Developing medical billing codes for the treatment of xylazine-impacted patients is another step needed to complete the data picture, officials said.

Most distant black hole found: Astronomers have discovered the most distant black hole yet using the Webb Space Telescope, but that record isn't expected to last.

The black hole is at the center of a galaxy dating to within a mere 570 million years of the Big Bang. That's 100 million years closer to the beginning of the cosmos than a black hole identified in 2021 by a Chinese team using a telescope in Chile.

Webb already has spotted other black holes that appear to be even closer to the Big Bang nearly 14 billion years ago, but those findings are still under review, said University of Texas at Austin astronomer Steven **Finkelstein.** one of the lead researchers. The finding has been accepted for publication by the Astrophysical Journal Letters.

Because the signals from this particular black hole are weak, more observations are needed, according to the Texas-led team.

There are untold numbers of dormant black holes, some even more distant than this one. But without any glowing gas, they are invisible, Finkelstein said. Detected in February, this particular one

is active and actually puny as black holes go - equivalent to about 9 million times the mass of our sun. That's close in size to the one in our own Milky Way galaxy, according to the team. Using Webb, the team also spotted two

other small black holes from the early universe, dating to around 1 billion years after the Big Bang. The observations suggest that these downsized versions may have been more common as the cosmos took shape than previously thought. "There are probably many more hid-

den little monsters out there waiting to be found," Colby College's Dale Kocevski, who was part of the team, said in an email.

'Know the warning signs of heat illness'

Extreme heat takes a toll on mind, body

ALBUQUERQUE, N.M., July 11, (AP): The Southwestern US is bracing for another week of blistering temperatures, with forecasters on Monday extending an excessive heat warning through the weekend for Arizona's most populated area, and alerting residents in parts of Nevada and New Mexico to stay indoors.

The metro Phoenix area is on track to tie or to break a record set in the summer of 1974 for the most consecutive days with the high temperature at or above 110 degrees Fahrenheit (43 Celsius). Even the morning low temperatures are tying historic records.

Along the US-Mexico border, federal agents reported that extreme temperatures over the weekend contributed to 45 people being rescued and another 10 dying.

With so many consecutive days of excessive heat, forecasters, physicians and local health officials throughout the Southwest are recommending that people limit their outdoor exposure and know the warning signs of heat illness.

Knowing the signs

From heavy sweating and dizziness to muscle spasms and even vomiting, experts say heat exhaustion and heat stroke are likely to become more common. In coming decades, the US is expected to experience higher temperatures and more intense heat waves.

Heat stroke is the most serious heatrelated illness and happens when the body loses its ability to sweat.

The skin gets hot and red, and the pulse quickens as the person's body temperature climbs to 103 F (39 C) or higher. Headaches set in, along with nausea, confusion and even fainting.

Jon Femling, an emergency medicine physician and scientist at the University of New Mexico, said the body tries to compensate by pumping blood to the skin as a way to cool off. And the more a person breathes, the more they lose fluids, becoming increasingly dehydrated.

Important electrolytes like sodium and potassium also can be lost when sweating.

"So one of the first things that happens is, your muscles start to feel tired as your body starts to shunt away," he said. "And then you can start to have organ damage where your kidneys don't work, your spleen, your liver. If things get really bad, then you start to not be perfusing your brain the same

Experts say it's important to recognize the signs of heat stroke in others, as people may not realize the danger they're in because of an altered mental state that may involve confusion.

In the case of heat stroke, experts suggest calling 911 and trying to lower the person's body temperature with cool, wet cloths or a cool bath.

With heat exhaustion, the body can become cold and clammy. Other signs include heavy sweating, nausea, muscle cramps, weakness and dizziness. Experts say the best thing to do is to move to a cool place, loosen clothing and sip some water.

Older people, children and those with health conditions can face greater risks when the temperatures are high.

During extreme heat events, one of the most common ways people can die is from cardiovascular collapse, experts said, because of the extra energy the heart has to expend to help the body compensate for the hot tempera-

In general, health officials say staying indoors, seeking air-conditioned buildings and drinking more water than usual can stave off heat-related illnesses. Caffeine and alcohol are nonos. Eating smaller meals more often throughout the day can help.

Learning the limits

Researchers at Arizona State University are trying to better understand the effects of extreme heat on the body and what makes hot weather so deadly.

They're using a special thermal mannequin called ANDI that is outfitted with nearly three dozen different surface areas that are individually controlled with temperature sensors and human-like pores that produce beads of sweat.

"A lot of research that I and my colleagues do is just really focused on understanding how people are responding to higher levels of extreme heat over longer periods of time and then what we can do about it," said Jenni Vanos, an associated professor at ASU's School of Sustainability.

There are 10 thermal mannequins in existence, with most used by athletic clothing companies for testing. ASU's manikin is the first that can be used outdoors thanks to a unique, internal cooling channel.

The university also has developed a new "warm room," or heat chamber where researchers can simulate heatglobe. Temperatures can reach 140 F (60 C) inside the room - and wind and solar radiation can be controlled for experiments. Vanos said measuring short- and

exposure scenarios from around the

long-wave radiation in the environment can also tell researchers how much a surface - or a person - in a specific location of a city would heat up.

"And so under these extreme conditions, what's going to really be able to be modified or changed within the urban environment is shade," she said. "In a place like Phoenix or really any sunny hot area, shade is a really critical factor to be able to reduce that overall heat load of the human body.'

Finding relief

While air conditioners are cranked up and fans are blowing full blast, residents across the region are anxiously awaiting the start of the monsoon season, hoping it will help to keep the heat

But so far, the summer thunderstorms - which usually bring cloud cover, lightning and downpours to the Southwestern desert - are absent due to the ongoing El Niño weather pattern, National Weather Service meteorologist Sam Meltzer said.

"It looks like things are going to be abnormally dry over the next couple of months," Meltzer said, noting that storms that might break the heat depend on wind patterns drawing moist air from the Gulf of California into Arizona, New Mexico and Nevada.

"But that doesn't mean we aren't going to get thunderstorm activity," Meltzer said. "It just might be delaved.

Meltzer worked in Phoenix before transferring last winter to Las Vegas. He noted that while temperatures rose last month in the Phoenix area, June stayed abnormally cool in southern Nevada.

The official daytime temperature at Harry Reid International Airport in Las Vegas remained below 100 F (37.8 C) for a record 294 days before temperatures reached 102 F (38.9 C) on June 30. The previous record of 290 days, from 1964 to 1965, had stood for 58 years.

Still, it's not just the air temperature that people need to worry about, Vanos said. Humidity can make it more difficult for the body to produce sweat as a way to cool off.

The airport remained open Monday and no flights were affected. "The eruption is small and there is pres-

ently no emission of ash to the atmosphere," the Icelandic Meteorological Office said. Lava is emerging as "a series of fountains"

from a 200-meter (656-feet) long fissure on the slopes of the mountain, it added.

"The lava fissure appears small at first sight," television reporter Kristjan Unnarsson, who was aboard a helicopter about an hour after the eruption began Monday after-

World Athletics shows no sign of budging and says its rules 'remain in place'

Semenya wins appeal against testosterone rules

STRASBOURG, July 11, (AP): Champion runner Caster Semenya won a potentially landmark legal victory on Tuesday when the European Court of Human Rights decided she was discriminated against by sports rules that force her to medically reduce her natural hormone levels to compete in major competitions.

The ruling by the Strasbourg, Francebased court questioned the "validity" of the contentious international athletics regulations in that they infringed Semenya's human rights.

But the two-time Olympic champion's first legal success after two failed appeals in sports' highest court and the Swiss supreme court came with a major caveat. Amid her bid to be allowed to run again without restriction and go for another gold at next year's Olympics in Paris, Tuesday's judgment, while major, did not immediately result in the rules being dropped. That might still take years.

The South African athlete's challenge against the testosterone rules be-

gan in 2018

It has gone from the Switzerland-based Court of Arbitration for Sport to the Swiss supreme court and now the European rights court. The 4-3 ruling in Semenya's favor by a panel of human rights judges merely opened the way for the Swiss supreme court to reconsider its decision.

That might result in the case going back to CAS in Lausanne. And only then might the highly controversial rules enforced by World Athletics be possibly removed.

The 32-year-old Semenya, who has been barred by the rules from running in her favorite 800-meter race since 2019 and has lost four years of her career at her peak, has only 13 months until Paris. In a statement soon after the European rights court's decision was

published, World Athletics showed no sign of budging and said its rules would "remain in place."

"We remain of the view that the ... regulations are a necessary, reasonable and proportionate means of protecting fair competition in the female category as the Court of Arbitration for Sport and Swiss Federal Tribunal both found," World Athletics said.

World Athletics also said it would be "encouraging" the government of Switzerland to appeal the ruling. Switzerland was the respondent in the case because Semenya was challenging her last legal loss in the Swiss supreme court. Switzerland's government has three months to appeal.

The Swiss government was also ordered to pay Semenya 60,000 euros (\$66,000) for costs and expenses. There was no immediate reaction from Semenya or her lawyers in South Africa.

While Semenya has been at the center of the highly emotive issue of sex eligibility in sports and is the issue's

figurehead in challenging the rules, she is not the only athlete affected. At least three other Olympic medalists have also been impacted by the rules that set limits on the level of natural testosterone female athletes may have if they want to compete. World Athletics says there are "a number" of other elite athletes who fall under the regulations.

There are no testosterone limits in place for male athletes. Semenya's case is not the same as the debate over transgender women who have transitioned from male to female being allowed to compete in sports, although the two issues do have crossover.


Semenya was identified as female at birth, raised as a girl and has been legally identified as female her whole life. She has one of a number of conditions known as differences in sex development, or DSDs, which cause naturally high testosterone that is in the typical male range.

Semenya says her high natural testosterone should be considered a genet-

ic gift in the same way as a basketballer's height or a swimmer's long arms.

While track authorities can't challenge Semenya's legal gender, they say her condition includes her having the typical male XY chromosome pattern and physical traits that make her "biologically male," an assertion that has enraged Semenya. World Athletics says Semenya's testosterone levels give her an athletic advantage that is comparable to a man competing in women's events and there needs to be rules to address that.

To do that, track has enforced rules since 2019 that require athletes like Semenya to artificially reduce their testosterone to below a specific mark, which is measured through the amount of testosterone recorded in their blood. They can do that by taking daily contraceptive pills, having hormone-blocking injections, or undergoing surgery under the rules. If athletes choose one of the first two options, they would effectively need to do it for their entire careers to remain eligible to compete regularly.

'We still have a ways to go'

ZURICH, July 11, (AP): A group of players across the globe asked FIFA late last year to increase the prize money for this summer's Women's World Cup. There had been pleas from the women to boost those funds before, but this time it was different.

The players not only wanted a prize pool equal with the men's World Cup, they also sought a guarantee that a percentage of the prize money would go directly to the players themselves.

While it wasn't true equity with the men's World Cup, FIFA indeed raised the prize pool for the women's tournament by more than three times that of the 2019 event in France.

But more than that, soccer's governing body agreed in June that a chunk of those funds should be paid straight to the players - all 732 of them. Every player will earn at least \$30,000, with the amount increasing the further along that teams progress in the tournament. The 23 players in the title-winning squad will each get \$270,000.

That's significant for many of the players, who in some cases don't

have club teams that pay salaries, are semi-pros or even amateurs. FIFA released a report last year that said the average salary for female players was \$14,000 a year.

And not only that, the conditions the players will experience on the ground in Australia and New Zealand - such as travel and accommodations - are now equitable to those provided the men.

"We still have a ways to go, but having them direct the payments to players is huge - it's a life-changing thing for many of these players entering the tournament. Coming away with each player making \$30,000 is huge because usually that money goes to federations and those players don't see any, or much of that money," U.S. forward Alex Morgan said.

A \$152 million fund was set for the first 32-team Women's World Cup. The total covers prize money, team preparation and payments to players' clubs. That's a big boost from the 2019 Women's World Cup in France, which had a \$40 million fund, with \$30 million in prize mon-

In contrast, the prize money pool for the men's World Cup last year in Qatar was \$440 million. The nations that got knocked out after the group stage made \$9 million apiece.

FIFPRO, the global players union, backed the effort by 150 players from 25 nations - including the United States, Japan and Germany - to push FIFA for more equitable terms. The result was a letter to FIFA President Gianni Infantino dated Oct. 19, 2022. The Associated Press obtained a copy of the letter.

"it's really positive that we have shown them (the players) what's possible through their collective voice - through their collective action and the solidarity that they have between each other - and this really intrinsic, inherent drive to want to push the women's game forward and create sustainable models for themselves and for the industry more broadly," said Sarah Gregorius, FIFPRO's director global policy and strategic relations for women's soccer.

"It just shows what happens when

players come together united behind very clear principles for change for themselves, but also a legacy for

players to come," she added.
Earlier this year, Infantino said that the ultimate goal is equity between the men's and women's games by the 2026 Men's World Cup and the 2027 women's edition.

The U.S. bargained for equal pay with their male counterparts in a groundbreaking agreement reached last year that will split tournament winnings equally among all players. But the United States is the only country that has such an arrangement.

For many teams at the World Cup, that kind of equality isn't realistic. So the \$30,000 can mean a college education, even a down payment on a home. And for those who aren't paid well - or at all - by their clubs, it can mean a chance to play without having another job.

"That is a lot of money, and it can be used for a lot of things. I know definitely a lot of my teammates are happy for that money. I'm definitely happy for that money," said Michelle Alozie, who plays for Nigeria and the Houston Dash of the National Women's Soccer League. The prize money pool trickles down to all participating teams. The 16 nations that exit the group stage will get a total of \$2.25 apiece million from FIFA -- \$690,000 to share among the players and \$1,560,000 for the federation.

FIFA will pay \$10.5 million to the title-winning nation. The majority of that, \$6.21 million, will be distributed among the players with the remaining \$4.29 million going to the federation.

In addition to helping pay the players, the teams and federations that haven't often seen the big stage will benefit, too. Each team is receiving nearly \$1 million in preparation funds.

"It means a lot to every player stepping into that tournament because it really means that the women's game has finally taken the steps that we've been fighting for," U.S. defender Crystal Dunn said. "We're playing for federations to do better by their players. And I think this prize money is a testament to all of our fights - the collective fight.

"When we step on to the field, yes, we are opponents, but at the end of the day we're all fighting for this game to grow, and for everybody."

WCup showcases inequity within the women's game

LONDON, July 11, (AP): As the Women's World Cup approached, Jamaican players started to panic.

They were uncertain about training camps, accommodations and even pay heading into what for many would be the biggest tournament of their careers. So they took to social media.

A number of the Reggae Girlz, as they are affectionately known, went public with their concerns, pleading with the Jamaican Football Federation to address "subpar" conditions.

The mother of one player took it a

The mother of one player took it a step further: She started a GoFundMe page to raise money to make sure the team and the support staff is provided what they need to be successful - such as adequate hotels and compensation.

"These girls deserve better. They have proven themselves on an international platform that they belong. And they need support, whether it's from parents, friends, or fans, to let them know that we see what they've accomplished, and we're proud of them," said organizer Sandra Phillips-Brower, the mother of midfielder Havana Solaun.

The World Cup always draws attention to the inequities between men's and women's soccer. But it also highlights the inequity within the women's game itself.

Teams like the United States and England, with greater support from their federations, enjoy the best that money can buy: Things like sports psychologists, massage therapists and team chefs.

Other teams, like Jamaica and South Africa, are uncertain they'll even get paid. So they're using social media and collective action to draw attention to their plight.

"All the teams are using their voices a lot more. We know these things because players are talking about it," U.S. forward Megan Rapinoe said. "Even when they're subjected to the discrimination and unequal treatment, they're still speaking out. They're still using their voice. That's really important."

The Reggae Girlz felt compelled to speak out at a time when their attention should be solely focused on competing in the World Cup.

"On multiple occasions, we have sat down with the federation to respectfully express concerns resulting from subpar planning, transportation, accommodations, training conditions, compensation communication, nutrition, and accessibility to proper resources," players said in a post on social media. "We have also showed up repeatedly without receiving contractually agreed upon compensation. We were told that all out requests and concerns would be resolved in a

timely manner."

The GoFundMe site has raised more than \$45,000, and Phillips-Brower was figuring out how to distribute the funds to best serve the players and staff. The Jamaican Football Federation did not respond to emails seeking comment.

Jamaica hasn't gone as far as South Africa's women, who boycotted a preparation match against Botswana near Johannesburg. Thulaganyo Gaoshubelwe, the president of the South African Football Players Union, said the incident was partly caused by poor pay for the players.

"They are fighting for their rights," Gaoshubelwe said in a video posted on

his union's Twitter account. "SAFA doesn't want to include money in their contracts. We must fight for the rights of these players."

A foundation set up by African soccer president and billionaire businessman Patrice Motsepe responded by creating a fund to be shared by the players.

Haiti, making its World Cup debut, has no sponsors as the country reels amid political disarray and poverty. The team's training center was closed because of the threat of a local gang. The teams' supporters donate equip-

Even Canada is in a dispute with its federation over pay. Players say they weren't paid in 2022 - which included qualifying - until an interim funding agreement with Canada Soccer was reached in March. The team headed off to Australia without a funding agreement in place.

FIFPRO, the global players union, backed an effort by players from across the globe who urged FIFA to increase prize money, equalize accommodations and other conditions enjoyed by players at the men's World Cup, and compensate players directly for participation.

FIFA agreed, doubling preparation funds for the teams, increasing prize money by nearly 300% and guaranteeing that every player at the event will be paid at least \$30,000, and more based on performance.

FIFPRO said it is working closely with FIFA to make sure those funds indeed go to the players, addressing concerns that the money could be realized by foderations.

pocketed by federations.

Despite the disparity between teams, there are success stories.

Costa Rica's women took a stand, successfully securing a contract last year that defined bonuses, allowances, travel and other basic needs - modeled off of the men's agreement with the federation. The deal is the first of its kind in Latin America.

"A lot of federations now are slowly getting into the trend of being better. Because now you see a lot of girls in those countries have been professional athletes, so they have an idea of what it means to be a professional athlete. And when they go back to the respective national teams, they are able to also help and say 'Hey, we need this, we need that, it helps us because we have it in our teams," said South Africa forward Thembi Kgatlana, who plays for Racing Louisville in the National Women's Soccer League.

Agnelli banned for another 16 months

ROME, July 11, (AP): Former Juventus president Andrea Agnelli was banned from soccer for another 16 months after he was charged with fraud for the way he handled player salary cuts during the coronavirus pandemic

It adds to a two-year ban already inflicted on Agnelli for a false account-

ing case

Agnelli was also fined 60,000 euros (\$65,000) by the Italian soccer federation on Monday after being judged responsible for wrongdoing in relationships with player agents and partnerships with other clubs.

Juventus and seven other former Juventus directors agreed to a plea bargain with the federation in May over the salary case, while Agnelli was the only figure in the case who decided

to be judged.
At the start of the pandemic,

Juventus said 23 players agreed to reduce their salary for four months to help the club through the crisis. But prosecutors claim the players gave up only one month's salary.

Juventus, which was docked 10 points last season for false accounting in a separate legal case, risked a further points deduction.

Agnelli and Juventus have denied wrongdoing. He and the entire Juventus board resigned in November following the investigation by Turin prosecutors into false accounting.

It's developing into a busy week of legal cases for Agnelli, whose latest appeal over the two-year ban stemming from the false accounting case is due to be heard on Tuesday.

Also, UEFA is expected to decide soon if Juventus should be banned from the Conference League next season due to its legal troubles.

LAS VEGAS, July 11, (AP): Damian Lillard wants to be traded to the Miami Heat. The Portland Trail Blazers know this yet haven't abandoned hope that the seven-time All-Star changes his mind

And whether he does or not, the Blazers insist that they're in no hurry. General manager Joe Cronin, at the news conference where the team unveiled its new five-year, \$160 million contract with Jerami Grant, spoke at length about the impasse with Lillard. He offered no specifics on talks - not

"We're going to be patient," Cronin said Monday. "We're going to do what's best for our team. We're going to see, you know, how this lands. And if it takes months, it takes months."

Lillard's trade request became publicly known on July 1, the first full day of free agency in the NBA. After the Blazers revealed that Lillard - who has

spent all 11 of his pro seasons in Portland - asked out, agent Aaron Goodwin confirmed days later that the seventime All-NBA selection wants to go to

"Dame's position won't change," Goodwin told The Associated Press last week. "This entire situation was about building an opportunity for Portland to win or giving him another opportunity that he wants, which is Mi-

The entire matter is complicated on so many levels - that the trade request became public, that Lillard wants to be traded only to Miami (he doesn't have a no-trade clause, and Portland is under no obligation to honor that request), that he is beloved as an all-time great in Portland and that not having him on the roster simply means the team probably won't have enough to truly compete in the loaded Western Conference.

"As a team, you always hope that you have more options," Cronin said.
"To have limited options like that, I

vents you from perhaps getting the best return. So, it's something that we'll have to work through."

And in his eyes, there's still hope that Lillard changes his mind - although there's been no indication that will happen.

"I haven't lost hope, just because I understand this league is complicated and things change very quickly sometimes." Cronin said.

The Blazers have a core of young talent - Anfernee Simons just turned 24, Shaedon Sharpe is going into his second season after being the No. 7 pick in 2022 and point guard Scoot Henderson is entering the league as the No. 3 pick in this draft. Cronin said he gets why Lillard would look at the Blazers, as currently constructed, and feel like there isn't a clear path to contending for a title this coming season.

at it and say, 'Well, this isn't a winnow opportunity, or at least as much of a win-now opportunity in some other places," Cronin said. "So, from that regard, I understand his position and I respect it and it makes sense to me why he would like to go elsewhere.

But Cronin also believes that great days are coming for Simons, Sharpe and Henderson.

"Those guys are going to impact winning very soon in this league," Cronin said.

Lillard is coming off a season in which he averaged 32.2 points for the Trail Blazers. He is a member of the NBA's 75th anniversary team, but he has never been close to a title in his 11 seasons in the league.

He met with Portland multiple times, asking for the roster to be upgraded to the point where he can compete for a championship. But those efforts did not go to Lillard's liking. And now, the trade watch is on.

"It's just hard. How do you replace

the marketplaces that is available that is a better player than Dame?" Cronin said. "No team more than us knows what this market looks like. We've been trying for 18 months to find the Dame equivalent at another position or someone that's 80% of Dame, even. So, that's the challenge and that's why we've got to keep working.'

The **Detroit Pistons** and Isaiah Stewart have agreed on a \$64 million, four-year contract extension, according to a person familiar with the deal.

Stewart averaged a career-high 11.3 points and 8.1 rebounds last season. He has averaged nine points and 7.8 rebounds over his three-year career and was entering the last year of his

The Portland Trail Blazers drafted the former Washington star with the No. 16 pick in 2020 and within the next week, he was traded to Houston and Detroit.

The 6-foot-8 Stewart provides a much-needed physical presence for the

Detroit's rebuilding hopes are tied largely to Cade Cunningham's comeback from shin surgery, along with secondyear pros Jaden Ivey and Jalen Duren, and rookie wing Ausar Thompson.

The Pistons won an NBA -low 17 games last season, and Dwane Casey stepped down as coach with one year left on his contract to take a role in the front office. The three-time NBA championship-winning franchise has earned a spot in the playoffs just twice in 14 years.

Shooting to speed up a turnaround, team owner Tom Gores gave Monty Williams a six-year contract shortly after the 2022 NBA Coach of the Year was fired by the Phoenix Suns.

Arozarena beaten in final round

SEATTLE, July 11, (AP): Of course a Junior had to do something special in Seattle.

Vladimir Guerrero Jr. won the All-Star Home Run Derby on Monday night, matching Vladimir Sr.'s 2007 title to become the first father-son duo to accomplish the feat.

As far as who might win a head-to-head swing-off, well, that depends.

"It's kind of difficult right now," the Toronto Blue Jays star said with a wide grin, speaking through a translator. "With the time, with the minutes, I'll win. If it's by outs, he'll win."

In a ballpark made famous by the Mariners' Ken Griffey Jr. a generation earlier, Guerrero beat Tampa Bay's Randy Arozarena 25-23 in the final round. He was 8 when his father won the crown in San Francisco.

"I don't remember much about 2007," Vladimir Jr. said. "I guess I was too young.'

BASEBALL

Guerrero totaled 5 1/2 miles of homers - 29,390 feet to be exact. He defeated Julio Rodríguez 21-20 in the semifinals after the Mariners star hit a record 41 in the first round in front of his hometown fans.

Batting against Blue Jays manager John Schneider, Guerrero was the last semifinalist to swing and the first finalist, setting a final round record for homers to top the mark Pete Alonso set when he beat Guerrero 23-22 in 2019.

With Guerrero Jr. catching his breath while watching, Arozarena hit against Tampa Bay field coordinator Tomas Francisco.

Arozarena had 21 homers in his initial 2 minutes. He had 23 with 7 seconds left in his automatic 30 seconds of bonus time before lining and popping up on his final four swings.

Guerrero had 1 minute of bonus time, earning an additional 30 seconds because he twice reached 440 feet.

"Obviously, the power that he has was incredible," Arozarena said through a translator. "For me, I felt good going into that round. But also he was able to get a minute of bonus time. I only had the 30 seconds of bonus time."

Vladimir Guerrero Sr. won the 2007 derby while with the Los Angeles Angels, beating the Blue Jays' Alex Rios 3-2 in the final.

Arozarena had the most overall homers over the three rounds, 82 to Guerrero's 72, and the most distance at 33,077 feet. Arozarena overcame Luis Robert of the Chicago White Sox 35-22 in the semifinals. Robert hit the longest drive of the night, a 484-foot shot to left in the second round. That topped the high of 476 feet by Barry Bonds in the 2001 derby in

Trying to become the youngest Derby winner at age 22, Rodríguez knocked out Alonso, a two-time champion who hit 21. Rodríguez beat Corey Seager 32-24 in the first round last year at Dodger Stadium, then knocked out Alonso 31-23 before losing to Juan Soto 19-18 in the final.

Arozarena beat Texas' Adolis García 24-17 in the opening pairing before a crowd of 46,952 at T-Mobile Park. García is the godfather to Arozarena's daughter, and the two jumped into each other's arms during warmups.

Robert knocked out Baltimore's Adley Rutschman 28-27 in the opening round. Rutschman hit 21 left-handed, and the switch hitter then turned around to the right side and hit six more right-

handed during a 30-second bonus round. From Portland, Oregon, Rutschman grew up attending Mariners games.

Guerrero, back for the first time in four years, defeated the Los Angeles Dodgers' Mookie Betts 26-11 in the first round. Four years ago at Cleveland, Guerrero hit 29 in the first round and 40 in the second, then lost to Alonso in the final.

Alonso was trying for his third title in four years. Griffey Jr. is the only three-time winner, taking the title in 1994, '98 and '99.

Guerrero Sr. was a nine-time All-Star but never won a World Series. He was inducted into the Hall of Fame in 2018.

Guerrero Jr. is a three-time All-Star and was MVP of the game two years ago in Denver. What's in the future? A World Series ring? Joining dad in the Hall?

"I'm a little bit too young to think about that right now," he said. "When I get there, then I'll think about it, I'll see if I match my dad or was better than my dad

'He needs a chance to rest'

Spurs decide that Wemby SL is over after two games

LAS VEGAS, July 11, (AP): Victor Wembanyama's first, and likely last, Summer League is over.

The San Antonio Spurs said Monday that they have seen all they needed from the No. 1 pick in this year's draft and won't play him during their remaining games in Las Vegas.

Wembanyama's final numbers from two games: 36 points, 20 rebounds, eight blocks and three assists on 41% shooting from the floor. He played about 54 minutes.

The shutdown wasn't a surprise; the Spurs never planned for Wembanyama to play the entirety of Summer League, and now they'll have a chance to use the minutes he would have gotten to take a look at other players.

"I'm going to sit down with the Spurs to know what the next months are going to be like," Wembanyama said Sunday night after what became his summer finale. "When to go on vacation, when to start back working out, where I'm going to practice, in San Antonio or somewhere else. I just know I've got two to three months - two to three great months - that are coming and they're going to change

my life. Shutting him down from games -San Antonio has either three or four games left in Las Vegas - starts what will be a needed break for the 19-yearold from France whose last professional season in his homeland started nearly a year ago. He was in the French playoffs up until a few days before the draft in June, and his schedule has been crazed since.

BASKETBALL

Put simply, the Spurs believe he needs a chance to rest and reset to get ready for training camp that starts in early October and then an 82-game

regular season. "In the past month, I think basketball wasn't even 50% of my schedule, Wembanyama said. "I can't stand it. I know it's a special moment in my life, but I'm glad it's over. Honestly. I just want to hoop. I just want to work out, lift because this is my life. Obviously, every first pick is going to go through this. And

it just makes me better for the future." It has been a whirlwind few days in Las Vegas for the Spurs. Wembanyama's debut on Friday night had a circus-like atmosphere with a sold-out crowd and enormous attention; Sunday's game wasn't quite the same, but the crowd was still huge. And more big news came between those games on Saturday when Gregg Popovich's new five-year contract to remain coach and president of the team was announced.

As would be expected, the Popovich

signing delighted Wembanyama.
"There's something great going on, starting," Wembanyama said. "We kind of knew it was going to happen, but now it's, let's get it rolling. We can get started now.'

Wembanyama took part in the NBA's required rookie transition program on Monday, where he spoke with NBA Commissioner Adam Silver who has raved about the 7-foot-3 star many times since first meeting him in Paris in January.

"I'm not sure if anything else I'd say could put more pressure on him, because there's already so much pressure on him and attention," Silver said Monday while speaking to the Associated Press Sports Editors convention in Las Vegas. "But it seems, at least initially, that he's well equipped to

handle it."

And everyone from teammates, opponents and even NBA greats like Kareem Abdul-Jabbar and Jerry West have raved about what they've seen

from Wembanyama in recent days. "The difficulty is learning how you can best contribute to a winning effort," Abdul-Jabbar told him. "That's what you've got to learn how to do with your skill set. You will find out what that is basically in preseason. You'll find out a lot about that.'

Vegas is a showtown. Wembanyama put on a show, and the Spurs said it was enough. And now his focus shifts to his first real season.

"He's amazing," San Antonio guard Blake Wesley said. "He's an amazing person on and off the court.

Chris Paul worked out with new teammate Stephen Curry on Sunday morning in Las Vegas. His assessment of the session: They didn't miss too many shots.

Evidently, Paul's time with the Golden State Warriors is off to a fly-

The veteran point guard revealed more than a few things in his first official interview session as a member of the Warriors: He isn't ready to concede that he's no longer a starter, he doesn't expect this to be his final season as a player and he gleans the same joy from the game now as he did when he was

And as for how it'll all fit, he doesn't expect that to be a problem.

'Not to like sound crazy or whatnot, but at the end of the day, it's basketball," Paul said. "You know, it's not brain surgery. I'm going into a situation with a bunch of guys who've been playing together for a long time.'

Paul got traded twice this summer, first from Phoenix to Washington as part of the move that sent Bradley Beal to the Suns, and then again to Golden State as part of the move that sent Jordan Poole to the Wizards.

It's a move that the Warriors hope leads to both short- and long-term gains. The 38-year-old Paul can still play; the 12-time All-Star averaged 13.9 points and 8.9 assists this past season for Phoenix, effective still in his 18th season in the league.

He's also not under contract after this coming season. Poole is entering a four-year deal; the big-spending Warriors just couldn't keep all their highest-paid players together given the constraints of the new Collective Bargaining Agreement.

Union sign Fofana on Ioan from Chelsea for next season

BERLIN, July 11, (AP): Union Berlin bolstered its Champions League preparations on Tuesday by signing Ivorian forward David Datro Fofana from Chelsea on loan for next season.

The 20-year-old Fofana rarely played for Chelsea after the English Premier League club signed him for a reported fee of around 12 million euros (\$13.1 million) from Norwegian team Molde FK in January. He made only three short league appearances for Chelsea. Union hopes to give him more chances to shine in the Bundesliga.

"David's speed and his flexible offensive qualities are highly interesting for us," Union sporting director Oliver Ruhnert said. "We want another goal-scoring player who will give our attacking game additional impetus

Fofana is Ruhnert's second signing in three days from English clubs following United States midfielder Brenden Aaronson's arrival on loan from Leeds on Sunday.

Union, which was promoted to the Bundesliga for the first time only in 2019, finished fourth in the league last season to clinch Champions League qualification for the first time. It will play its European games at Olympiastadion, a venue traditionally used by city rival Hertha Berlin. Hertha was relegated from the Bundesliga last season.

Tottenham signs Israel forward Manor Solomon as free agent from Ukrainian champion Shakhtar

Manor Solomon joined Tottenham as a free agent on Tuesday after leaving Shakhtar Donetsk which is pursuing legal action against FIFA for losing its players during the war on Ukraine.

Tottenham said the Israel international, who spent last season in the English Premier League on loan at Fulham, has signed a deal through 2028. It is subject to receiving a work permit.

FIFA passed emergency transfer rules last year, and renewed them through the 2023-24 season to allow foreign players and coaches contracted to Ukrainian and Russian clubs to unilaterally suspend their contracts because of the Russian military invasion.

Svitolina stuns Swiatek to reach semis

Vondrousova ousts Pegula

WIMBLEDON, land, July 11, (AP): Three months after returning from maternity leave, Elina Svitolina reached the Wimbledon semifinals by beating top-ranked Iga Swiatek

7-5, 6-7 (5), 6-2 Tuesday. The 28-year-old Ukrainian gave birth to her daughter in October and returned to the WTA tour in April. She received a wild-card entry to the grass-court tournament one month after reaching the quarterfinals at the French Open.

"First of all I'm going to have a beer, probably," Svitolina said on court. "At the beginning of the tournament if someone would tell me that I will be

in the semifinal and beating world No. 1, I would just say that they're crazy.'

Swiatek, a four-time major champion, won her third French Open title last month but was playing in the Wimbledon quarterfinals for the first time.

At one point, Svitolina won 20 of 22 points against Swiatek on Centre Court, including 16 of the final 18 points in the first set.

Svitolina will next face Marketa Vondrousova for a spot in Saturday's final. It will be the Ukrainian player's second appearance in the Wimbledon semifinals. She lost to eventual champion Simona Halep at that stage in 2019.

"I'm just going to enjoy tonight and then get some treatment, get some massage, much needed and then just regroup and be ready for the next big battle," Svitolina said.

Svitolina has been ranked as high as No. 3 in the world and also reached the U.S. Open semifinals in 2019. She is currently ranked 76th. To reach the semifinals this year, she has beaten four Grand Slam champions - Venus Williams in the first round, Sofia Kenin in the third, Victoria Azarenka in the fourth and Swiatek in the quar-

Vondrousova won five straight games in the final set to beat fourthseeded Jessica Pegula 6-4, 2-6, 6-4 on No. 1 Court. The left-handed Czech who reached the French Open final in 2019 trailed 4-1 in the third set but didn't lose another game after that.

"I'm just trying to stay in every game. It can change pretty quickly," Vondrousova said. "She got so much better in the second set. She was push-

Pegula is now 0-6 in Grand Slam quarterfinals. The 29-year-old American was playing at this stage at Wimbledon for the first time.

Vondrousova had won only four matches on grass heading into the tournament at the All England Club. But she has won five in a row on the surface over the last eight days.

"My best result here was second round. It's amazing. I'm just loving grass now," Vondrousova said. The victory for Vondrousova is

her fourth over a seeded player at this year's Wimbledon tournament. She beat No. 12 Veronika Kudermetova in the second round, No. 20 Donna Vekic in the third round and No. 32 Marie Bouzkova in the fourth round.

Pegula was leading 3-1 in the third set when play was suspended so that the roof over No. 1 Court could be closed with rain approaching. Pegula then held serve in the next game to lead 4-1 before Vondrousova took over.

Ons Jabeur is getting another shot at

Elena Rybakina, a year after losing to her in the Wimbledon final.

Jabeur has been a Grand Slam runner-up twice - both times last year. After losing to Rybakina in three sets at Wimbledon, she lost to Iga Swiatek in straight sets at the U.S. Open - falling just short of becoming the first African or Arab woman to win a major tennis tournament in the sport's professional

Bangladesh earn 'consolation' win

CHATTOGRAM, Bangladesh, July 11, (AP): Left-arm pacer Shoriful Islam's career-best 4-21 helped Bangladesh avoid being swept when it beat Afghanistan by seven wickets in a one-day international on Tuesday.

Afghanistan won the first two ODIs, including a record total of 331-9 on Saturday. But three days later, the visitors were bowled out for 126 in 45.2 overs. Bangladesh raced to the target

in 23.3 overs, reaching 129-3 with an unbeaten 53 from captain Liton Das.

A change of bowlers by Bangladesh made the difference. Shoriful came in, along with fast bowler



While Levy might not want to be the man who sold Kane, the prospect of losing him for nothing would surely be worse.

That is why interest from Bayern may be more tempting than Tottenham is ready to admit - especially if it draws out other bidders and ultimately drives up his price.

In an ideal world for Levy and

Tottenham fans, the meeting with Postecoglou this week will convince Kane he can achieve his ambitions of winning silverware right where he is. That despite the London club having had five managers in the last four years and failing to qualify for the Champions League last season, success is within reach.
