CABINET REAFFIRMS PLEDGE TO COOPERATE WITH ASSEMBLY MPs give 'thumbs up' to work plan

ber of suggestions pitched by lawmakers dealing with the government's newly-unveiled work plan, which mainly include the launch of a website providing the intricacies behind

of the work plan, in addition to other ideas dealing with the feasibility of transforming Kuwait into a regional financial hub, which entails "relying on the expertise" of individuals who have found success in such endeavors

The Cabinet on Monday reaffirmed commitment to "commendable" cooperation between the executive and legislative

Deputy Premier and Minister of State for National Assembly Affairs Essa Al-Kanderi, underlined after the Cabinet meeting the government's keenness to sustain cooperation with parliament.

Meanwhile, the National Assembly on Tuesday elected by acclamation, MP Dr. Hamad Al-Mutar as head of parliament caucus and MP Dr. Mohammed Al-Mahaan as secretary and Hamad Al-Obaid as treasurer. The voting came during the 1st annual meeting of the parliament caucus in the regular session of the 17th legislative term.

The parliament also elected by acclamations MPs Dawood Marfie, Shuaib Shaaban and Fahd Bin Jamea as members of

the caucus The Kuwaiti government's new work program for the 17th legislative term (2023-27) un-

equivocally bespeaks "Kuwait 2035 Vision," which is mainly designed to transform Kuwait into a regional and global financial and trade hub. The Gulf country's primarily economic vision is also meant to, inter alia, create an attractive in-

vestment environment where the private sector leads the economy, to create competition, promote production efficiency, achieve human development and provide a congenial and updated legislative and business infrastructure.

His Highness the Prime Minister Sheikh Ahmad Nawaf Al-Ahmad Al-Sabah, introducing the program, said that the government had presented its work plan to the parliament in line with Article 98 of the constitution and the principle of constructive cooperation between both legislative and executive authorities.

Cooperation

He added that the plan is considered a document of cooperation between both legislative and executive authorities, and aims at putting national interest first, wiping out obstacles and ad-

dressing challenges. He also regarded it as a document of partnership with the private sector and civil society organizations, which have a central role to play in achieving progress and development as part of the country's future economic devel-

opment drive. His Highness the Prime Minister cited the plan as including major economic and development projects aiming at ensuring economic diversification. oving devel mance and addressing economic and financial challenges, as well as establishing an independent

electoral commission. The government's work program consists of five axes involving a set of programs that are divided into executive projects that reflect the government's 2023-27 orientations, and are based on the pillars of the development drive.

This program's priorities are centered on building a developed and sustainable economy, supporting human capital and improving quality of life, and enhancing government efficiency

and boosting production. Regarding the program's pillars, the list mainly embraces a fruitful partnership between the public and private sectors, prudence in public financial management, efficiency in resource management, a clear-cut government structure that enhances accountability and defines responsibilities, responsible and sustainable prosperity, an encouraging stimulus framework, unequivocal and implementable projects, accurate timetables, measurable outputs and effective management of gov-

ernment projects. The government's work program has five axes, notably stability of public finance, economic agenda, job creation and capability-building, sustainable prosperity and solid human capital and productive government.

Government statement of pipe dreams, difficult to implement

HAVE we entered the era of ruminating on slogans and the pointlessness of shedding light on problems that the country suffers from? Or is the reality that we live in different from that of the government whose program is devoid of any reference to a number of crises and the way to solve them?

From 1992 until today, with each one of them, we have read words that inspire hope, rendering one to almost say that this Council of Ministers relies on it to reform and get the country out of its crises. However, as soon as the ink of the government statement dries up and the National Assembly discusses it, it goes back to its usual state of bickering and quarreling with the parlia-

Indeed, the current Cabinet suffered from two successive setbacks in less than two weeks and has become lame through successive resignations, which do not indicate the possibility of achieving what can be relied upon.

Citizens are fed up with the slogans coined by successive governments, because reality has always belied them.

While people are waiting for openness, the past governments permitted the heresy of negative phenomena, which was preceded by the ban on co-education in schools and universities, and the financial repercussions it left on the state.

When the country was closed as a result of shortsighted approaches in this regard, another heresy appeared - to ban pregnant women and those over 60 years of age from visiting

Despite the successive governments wasting \$200 billion over a period of ten years, the infrastructure is still the worst, at least among the Gulf states and the countries that possess wealth such as Kuwait.

When voices called for awarding major tenders to world-renowned companies, which have implemented many major projects in various countries of the world, the governments instead clung to the local agent. The result was an increase in the costs of infrastructure projects. becoming much higher than that of similar projects executed in other Gulf countries, which eliminated the phenomenon of bribery and corruption through firm decisions and the abandonment of the local agent.

Also, those countries did not turn a blind eye to any of the corrupt, because their goal is the future, continuity, and the strength of the state, not the interests of individuals.

It is true that one of the parliamentary committees recommended the abolition of the local agent. Here we say it explicitly - This law will witness many obstacles and will not see the light, or at least there will be a great delay. This is because "companies and money sharks" will be waiting for it in fear of losing their ability to control projects, which are like a luxury cake that they monopolize.

With these facts, how can an economy be promoted through slogans? How can a country with all the capabilities, but lacks the right decision, use reasonable and scientific plans to manage the country if the executive officials do not have a

In this regard, there are many questions that observers and citizens ask. For example, what is the wisdom behind closing the country?

Israelis 'recognizing' Moroccan sovereignty on Western Sahara

JERUSALEM, July 18, (AP): Israel announced it was recognizing Moroccan sovereignty over Western Sahara, joining the United States as the only countries to acknowledge the kingdom's annexation of the disputed north African territory.

The announcement came shortly after Morocco's Foreign Ministry issued a statement saying King Mohammed VI had received a letter from Prime Minister Benjamin Netanyahu recognizing Morocco's claim over the territory.

Netanyahu's office later confirmed the

announcement. Israeli Foreign Minister Eli Cohen said recognition of Western Sahara as Moroccan territory "will strengthen relations between the countries and the nations" and advance regional stability.

Israel and Morocco reestablished diplomatic relations as part of the "Abraham Accords" brokered by former President Donald Trump between Israel and Arab states. The two countries had low-level diplomatic ties in the 1990s that were disrupted by the Palestinian uprising that began in 2000.

Fighters, 'Hudner' headed for Hormuz

WASHINGTON, July 18, (AP): The U.S. is sending additional fighter jets and a warship to the Strait of Hormuz and Gulf of Oman to increase security in the wake of Iranian attempts to seize commercial ships there.

The Pentagon said Monday that the USS Thomas Hudner, a destroyer, and a number of F-35 fighter jets will be heading to the area. The Hudner had been in the Red Sea.

Defense officials last week announced the deployment of F-16s to the area over the past weekend, and there have been A-10 attack aircraft there for nearly two weeks in response to the Iranian

'Interference' **Education Minister quits**

KUWAIT CITY, July 18: Minister of Education, Dr. Hamad Al-Adwani, has submitted his resignation to the Council of Ministers for a number of reasons most

notably his adherence to his powers and interference in the affairs of his specialties from outside the ministry, in addition to the parliamentary pressures he was subjected to recently, reports Al-Qabas daily.

The minister in his resignation letter claimed he was not given the opportunity to implement the reform plan that he set to advance education and address problems at the higher

Al-Adwani education and other education sectors, in addition to the government's failure to provide sufficient support in the face of these pressures and continuous interference in his work

The sources indicated Al-Adwani also refused concessions and did not bow to pressure, indicating that the Council of Ministers is heading towards appointing the Minister of Electricity, Water and Renewable Energy, Dr. Jassim Al-Ustad, as acting Minister of Education.

Al-Adwani's resignation from the government is the second within a week, after the resignation of Finance Minister Manaf Al-Hajri, which was accepted

Another decree was issued appointing Deputy Prime Minister, Minister of Oil, Minister of State for Economic Affairs and Investment Saad Al-Barrak as acting Minister of Finance.

The sources explained that the boat was intercepted at the border area, and the injured person was handed over to the emergency medical personnel, while the concerned authorities took all necessary measures to deal with the situation.

Inflation rate up 3.83 pct last June

KUWAIT CITY, July 18, (KUNA): The consumer prices on an annual basis grew by 3.83 percent last June, according to the Kuwait Central Statistical Bureau (KCSB).

In a statement to KUNA on Tuesday, the bureau said that the inflation rate in Kuwait rose 0.54 percent last June, on a monthly basis, due to the increase of prices of all main groups that influence the movement of key indices, particularly food, education

Record number of the first group (food and beverages) last June went up by 6.25 percent, compared to the same month in 2022, while the price index of the second group (cigarettes and tobacco) slightly rose by 0.37 percent on an annual basis.

The consumer price index (CPI) for the clothing group rose 6.76 percent, and the (housing services) rose by 3.23 percent,

Kuwait FM's visit to Italy successful, fruitful: Ambassador Baldocchi

'All Kuwaiti, Gulf and Arab tourists are welcome and safe in France'

KUWAIT CITY, July 18: The French Ambassador to Kuwait Claire Le Flecher has reassured all Kuwaiti, Gulf and Arab tourists that the events and protests taking place in France have not affected, and will not affect, the demand for visa applications, reports Al-Qabas daily.

In an interview, she said her country will remain one of the most popular tourist destinations, and that Paris will do its best to ensure the safety of the tourists, as per what was affirmed by the French Minister of Economy, Finance, Industrial and Digital Sovereignty Bruno Le Maire in his interview with "The Telegraph" newspaper.

Ambassador Le Flecher stated that all foreign tourists, regardless of their nationalities, are welcome and safe in

She called for the need to ensure accuracy and avoid believing all the information circulating on the Internet, especially social media as it regularly publishes fake and unverified news and information.

Ambassador Flecher highlighted the high demand for visa applications, especially in the summer months, revealing that the embassy, since the beginning of the year, processed more than 23,000 applications, which is an increase

of 18 percent compared to the same period last year.

She explained that the fees imposed by France on domestic workers accompanying Kuwaiti tourists (for sponsors and employers) as social insurance for them as they are employees in the private sector according to the French Labor Law, did not affect the desire of Kuwaitis to visit France. This is based on the number of visa applications, which is on the rise.

These fees are not collected by the embassy, but by a specific party in France, due to which the embassy is not sure about the amounts collected. These fees are included in the state budget, as is the case in many European countries, and they do not apply only to Kuwaitis, but include all nationalities.

Regarding the facilities provided by the embassy to avoid overcrowding in submitting applications, Ambassador Le Flecher said, "In addition to Kuwait's Ministry of Foreign Affairs, whom we thank, we communicated widely about the possibility of submitting applications for a period of up to six months before the

She praised the role played by the Ministry of Foreign Affairs and its cooperation with the embassies of European countries in its continuous communication, and the renewal of its claims and calls for those wishing to travel to France to submit their requests early, which contributed to organizing the work well, even if the delays remained high.

Ambassador Le Flecher said, "We continue to open new appointments regularly, and provide a VIP mobile service to collect requests for those wishing to travel to France from their homes or wherever they are in order to facilitate their comfort.

Regarding the measures taken against the violating offices, she said, "With the cooperation of our European colleagues, we asked the Kuwaiti authorities to regulate the work of travel agencies, especially the regulation of

the imposed prices."

Ambassador Le Flecher reiterated that the French Embassy works exclusively with the service provider in the "Cabago" office to collect visa applications, and there are no other offices accredited to is-

Also, Ambassador Le Flecher praised the recent visit of Foreign Minister Sheikh Salem Al-Abdullah to Paris, describing it as an important and fruitful visit, as he chose France as the first country on his European tour.

She said, "The two countries signed a memorandum of understanding to continue the strategic dialogue between them to develop and strengthen bilateral relations. The strategic dialogue meeting, which Sheikh Salem Al-Abdullah will soon co-chair with his French counterpart Catherine Colonna includes sub-working committees on various topics such as education, security, trade and health.'

Hunt for qualified professionals

MoH new exam for doctors' jobs

KUWAIT CITY, July 18: The Ministry of Health has approved the unified electronic test which is an additional test to tests already in place for applicants who wish to join the healthcare profession in Kuwait, reports Al-Qabas daily.

The Ministry stated that this step came within the framework of its keenness to achieve quality performance and said the test is an extension of the "efficiency assessment" test that is currently being conducted before hiring doctors and techni-

It includes at the beginning of the application phase some specializations of the medical professions, and then includes the rest of the specializations gradually, adding that the test is done electronically, and it can be done from outside Kuwait through the relevant website, if the applicants are from abroad.

The ministry stated that the additional test comes within several criteria for acceptance and granting a license to practice the profession in Kuwait, including the standardized (electronic) theoretical test, in addition to the personal interview, and the practical professional test.

The Ministry added that this step is similar to many countries in the region, and is done within the framework of ensuring quality performance. This test is mandatory for applicants who wish to join the public and private health sectors, while continuing to develop it periodically, to include larger categories, in order to ensure the application of the best evaluation standards before granting a license to practice the medical profession.

The ministry indicated that it is possible for non-citizen health practitioners wishing to work in the government or priKuwaitis top list

9,000 seek KU joining

KUWAIT CITY, July 18: The Acting Director of Kuwait University Dr. Fayez Al-Dhufairi announced that the number of applications to join Kuwait University has reached approximately 9,000 within three days of launching registration, adding that most of the applications came from Kuwaiti students, reports Al-Qabas daily.
On the sidelines of his visit to the

admission hall in Sabah Al-Salem University City on Monday, Al-Dhufairi said the Deanship of Admission and Registration received applicants on the third day of registration, and provided assistance and guidance in entering some data for those who were unable to enter it in the electronic system.

He said, "It is obvious from the number of applications for admission to the university that Kuwait University is the first to attract the desires and aspirations of the Kuwaiti society for their children to be members of this ancient institution.

Kuwait University, represented by the Deanship of Admission and Registration, announced the approved timeline for submission for the next academic year 2023/2024 during the period from July 15 to 26, 2023.

Biometric system not canceled: Mol

The Ministry of Interior announced the continuation of the biometric system, refuting the reports circulating regarding its cancellation, reports Aljarida daily.

In this regard, sources affirmed that the ministry is pushing for the expansion of the campaign and is working on implementing this after the summer vaca-

They revealed that the ministry has actually launched biometric centers for citizens and residents in the designated centers, which the ministry had previously announced in all governorates.

The sources stressed that work is

underway to open new centers in some commercial complexes and the Ministries Complex in order to facilitate eve-

They explained that the biometrics registration was carried out for those entering through the land border posts. Work was carried out partially at the airports during the summer period in order to avoid congestion that might result due to the large number of arrivals and departures.

The introduction of the biometric system will be applied effectively after the end of the summer vacation for all those leaving and arriving in the country.

KUWAIT CITY, July 18: During a tour of the customer service sector in the Ministry of Electricity, Water and Renewable Energy, it was discovered that an amount of KD 132 million was collected from the beginning of the current fiscal year until July 4, i.e. within 94 days. On the other hand, the collections during the last fiscal vear amounted to KD 460 million, reports Al-Oabas daily.

The Assistant Undersecretary of the sector and Acting Director of Customer Service Department Eng. Falah Al-Mutairi explained that the total bill is currently estimated at approximately KD 800 million. The delay in adopting the budget during the past year led to the delay of some government agencies in paying at the time. The share of government agencies in the debt is currently estimated at KD 470 million, i.e.

equivalent to 57 percent of the bill.

Topping the government agencies in terms of arrears is the Kuwait Oil Company (KOC). Its total bill is estimated at KD 225 million, which are accumulated bills since 2017. The arrear amounts vary from the rest of the government

Government agencies, from whom the total collections during the current fiscal year amounted to KD 73 million, are still paying. The ministry is working hard in carrying out the collection either from regular customers in various sectors or from government agencies. Regarding ways to speed up collection, delayed govern-

ment agencies are addressed and urged to pay. In the event of further delays, the matter is submitted to the Council of Ministers. As for the rest of the sectors - private, investment, commercial, or industrial housing, they are notified via

the Sahel app. After all the communication channels are

used for sending reminders and warnings, water service is disconnected from private housing, and electricity is cut off from those who delay in paying in the rest of the The customer service sector is currently working on configuring the smart meters, which were installed in the investment and commercial sectors in Hawally and Farwaniya

governorates, to operate on a prepaid system. Part of those meters have been activated. Eng. Al-Mutairi added that all smart meters installed in the two sectors are scheduled to become prepaid by the end

of the first quarter of the year 2024. Regarding cases of disconnection, the tour revealed that the total of those who were cut off from water and electricity during the last fiscal year amounted to about 200,000 utilities. It is known that, at the level of private housing, the law allows only water to be cut off, while electricity is cut off from those who are late in the investment and commercial

Meanwhile, Eng. Al-Mutairi stated that 90 percent of the sector's services can currently be used electronically without paying bills, connecting electricity, removing the meter, and other services, referring to Article 2 of Law No. 20/2016, which gives the right to obtain these services for someone who achieves rationalization in consumption of electricity in the private housing.

The private housing sector is on a rationalization incentive, and the number of participants in the program has reached more than 3,000 customers so far. The amounts due are placed in the accounts of the beneficiaries at the end of

Furthermore, the collection manager in the sector Eng. Muhammad Al-Otaibi highlighted four sections in the monitoring collections, indicating that the ministry facilitates payment methods for customers by making payment available in the main building, and in external

He stressed that the electronic payment system is available around the clock, adding that the completion of the transaction starting from entering the reading and issuing the invoice takes a few minutes.

Eng. Al-Otaibi said the focus is on collecting dues along with providing the customer with means of comfort for the completion of his transaction, adding that the collection control in the ministry building receives on a daily basis about 100 to 150 clients from private, investment or government housing and other sectors.

In addition, Head of the follow-up team for customer affairs offices Batel Al-Fadhli revealed that the sector currently has about 45 offices in various governorates.

He said the Sabah Al-Ahmad office was recently opened, and a customer service office is expected to open in West Abdullah Al-Mubarak shortly.

Al-Fadhli stressed that the process of following up the external offices is carried out on a daily basis by the team, which consists of six individuals who carry out daily rounds to a number of offices to monitor compliance with attendance and departure, facilitate procedures, as well as

Mol commences installing biometric devices in malls

KUWAIT CITY, July 18: The Ministry of Interior has taken the first step to install biometric fingerprint devices inside commercial malls, reports Al-Rai daily.

The Avenues Mall was the first of the five complexes to provide those wishing to take their fingerprints indicating that about 500 Kuwaitis have taken their biometric fingerprints over the past two days.

These devices will be placed also in the 360 and Al Kout malls from Monday. The complexes that have already been equipped with the system apart from the Avenues, 360 and Al Kout are the Al-Asima Mall and the Ministries Complex. Those wishing to take the biometric fingerprint in these

complexes do not need prior appointments, and can simply find the devices, take a token number, and do the fingerprint. The waiting period does not exceed five minutes.

The number of people who will take their fingerprints is expected to increase in the coming days, as more complexes announce the installation of these devices.

There are currently 10 fingerprinting devices in five major shopping malls, with two devices in each complex. The devices are also distributed in the governorates and at the land,

'Need to strengthen Audit Bureau's role, transparency in enacting laws'

"I PRESENT to the Speaker of the National Assembly, Ahmed Al-Saadoun, with two appeals: the first with the aim of fortifying and developing the vital role played by the Audit Bureau, and the second with the aim of enhancing transparency and professionalism in the procedures for enacting laws in the National Assembly," **Dr. Abdul Latif bin Nakhi** wrote for **Al-Rai** daily.

"The objective of establishing the Audit Bureau is to achieve effective control over public funds. This goal cannot be achieved if the man in charge is involved in or influenced by political tensions.

"Evidence for this is numerous, including negative attitudes by deputies - who swore to defend the people's money – towards suspicions of encroachment by some of their peers on public money, and the suspicious roles played by deputies in investigation commit-



tees regarding suspicions of corruption in contracting companies owned by their comrades in political blocs.

"Therefore, despite the importance and necessity of the condition of high professionalism (specialization and experience) in selecting the head of the bureau, it is preceded by the condition of independence, especially when exposed to pressures of most severe forms and

Accordingly, and in order to enhance the chances of selecting the most qualified person to head the Audit Bureau, and in line with the repeated demands of the representatives to ration the selection of leaders, I appeal to Speaker Ahmed Al-Saadoun to invite experts and experienced people to run for the position of president of the Audit Bureau through the portal of the General Secretariat of the National Assembly online.

"Then the comparison table to be published among the candidates - without mentioning their names - in accordance with the conditions and criteria for comparison that are determined and announced by the Council's office before the door for candidacy opens.

"This is in respect of the right of the people, "the source of the authorities," to be acquainted with the selection procedures.

"As for my second appeal, it is to expedite the availability of parliamentary committee reports on the Internet, through the "Parliamentary Information System" platform of the Secretariat of the National Assembly, especially reports on draft laws.

'This is because the observers have noticed a wide discrepancy in the time taken to provide the reports, extending the dates until the time of publication on the

"For example, during the third annulled council, it was noted that the report of the committee concerned with one of the draft laws – which has popular priority was available on the Internet well before the date of its first deliberation, allowing those interested to evaluate it and submit their views and observations on it.

"However, the committee's report on the draft law itself was published weeks later than the original date for its second deliberation, a date that was repeatedly postponed due to the government abstaining from the sessions during that time.

"Therefore, specialists interested in the draft law wondered if the delay in publishing the report was deliberate in order to disrupt their natural role in approving

"It is unacceptable today, after all these rapid advances in information and communication technologies, and after all these rhetoric about the partnership between the parliament and the people, for the parliament to deliberate on bills before the people are able to view the reports of the committees in this regard. Unfortunately, over the past few days, many of the parliament's committees

have issued reports on bills. "During this week, the Council began holding its regular and special sessions. In these sessions, the Council deliberated, and the Council will deliberate on a set of

"However, last Wednesday, at the time of writing the article, the "Parliamentary Information System" platform was devoid of committee reports.

"In conclusion, I call on all reformists to support the previous two appeals, and all the positive initiatives that are put forward inside and outside the Council, by expressing objective views and initial observations regarding them, in order to develop them or adapt them.

"I warn them against the consequences of excessive support for those they consider to be reformists and show extremism in their hostility to those they consider corrupt, at the expense of reform itself, by questioning intentions -- for example -- with the aim of reducing responsibility for a person or a parliamentary or political

Also:

"In recent years our nation's councils have changed, deputies have changed, ministries have changed and ministers have changed, but the situation has remained as it is," columnist Iqbal Al-Ahmad wrote for Al-Qa-

"Our problems are the same and their solutions are the same. The relationship between the executive and legislative branches is still hampered by many bumps.

We assumed and believed that the change of some deputies and heads of councils, and the absence of some from the parliamentary scene, would solve the dilemma.

"We assumed and believed that the change of some ministers and the absence of some prime ministers would solve the dilemma, and open the way for development projects to flow and enjoy the long-awaited political stability.

"But it seems that this belief and this assumption has become today a fantasy, as the period of political stalemate has prolonged, which requires us to ask this question: What is the reason?

"What MP Muhalhel Al-Mudhaf preferred, in last Wednesday's session, was a needle that pricked a wound whose inflammation increased, and increases day by day. It was not said by many 'silent' members and he was followed by a pause, when he indicated that Kuwait, since the promulgation of the constitution in 1962, has been experiencing successive crises, especially in recent periods, as any initiative for real and serious reform has been absent from the political scene with the agreement and understandings of all parties, in all sincerity, to make all the changes required by real reformers, and not by those who claim that.

"All of this requires today, after enough is enough, a bit of courage and audacity, without any hesitation to correct and amend what needs to be amended at all lev-

"What MP Al-Mudhaf preferred was a bell that rang in the silence of the graves. But just as MP Al-Fadel criticized the government side, there is more than criticism and disappointment from the parliamentary side as well.

"At least the people did not choose the members of the executive authority. Many proposals presented in the National Assembly have nothing to do with the constitution, since they go beyond its provisions and texts, and occupy the country's authorities and waste their time.

"They are proposals far from the people and far from the reality, their rights and freedoms, and close to the destruction of the country and the loss of the people.

"This is all a reflection of an unhealthy political reality. A reality that suffers from a phobia that it cannot overcome and is unable to confront it and take the right decision regarding it.

"Is it destined for the Kuwaiti people to endure conflicts greater than them, and to live the repercussions of these conflicts on their reality and on all intentions of development and progress to catch up with countries that once looked at us with fear, not because of our military strength and authority, but because of our excellence in every field and aspect, rich human resources and and the most harmonious between dreams and reality, which contributed to our renaissance before others, and imposed our reality that no one could deny at the time.

"One of the most difficult and most dangerous things for societies is preoccupying his authorities with concerns that turn into parliamentary proposals that are far from the citizen and his rights and from developing the state and illuminating its future.

"At the height of all these crises, a group of deputies proposes to naturalize 4,000 people every year, at a time when the Kuwaiti people are waiting for a solution to their housing, health, educational, and economic problems, and...and ...and so on.

"Are these your priorities, our honorable deputies? Is this issue your concern in the midst of the pains that we suffer from in many fields?

"Your Excellency MP Muhalhel Al-Mudhaf, what you said about the government side is also paralleled by many negatives on the parliamentary side, of which you and all the members of the current parliament, and before it and other parliaments also contributed to the frustration and pessimism we have reached.

"Unfortunately, those who suffer today and suffer from the fire of this absurdity and the preoccupation of decision-makers, authorities and responsibilities with matters far from the interest of the homeland and the requirements of the Kuwaiti people, present and future is the people and their homeland.

"One of the most difficult and cruel things is that people pay the price for something that is not in their hands and conflicts are greater than them.

"What MP Muhalhel Al-Mudhaf said, and what came in my comment on him, is said by everyone, the youth in their gatherings, the old men in their offices, and the women in their gatherings and events. Everyone expresses their dissatisfaction and complaining about this reality on a daily basis waiting for a solution.

"May God protect Kuwait and all those who love it and are faithful to it, and see nothing but its security and stability. Amen.'

"Every year, parents encounter a problem at the beginning of the summer vacation, especially those who cannot travel due to their financial or social conditions and other reasons related to families, that is, how do children of different ages and orientations spend their free time," columnist Mubarak Al-Harbi wrote for Al-Anba daily.

Man, brother, wife & partner jailed for selling fake chalets

MoSA responds on SAB query over computers

KUWAIT CITY, July 18: The Ministry of Social Affairs responded to the observations made in the annual report issued by the State Audit Bureau, which included all the observations and shortcomings that marred the auditing and review of its work for the 2022/2023 fiscal year, regarding the failure to account for 50 computers belonging to the computer department in the ministry, reports Aljarida daily.

According to informed sources, the incident has been referred for investigations to take the necessary legal measures and hold the employees responsible for its occurrence accountable.

The bureau's report indicated that there was destruction and loss of documents related to the aforementioned department, and the failure to observe the professionalism required to restore backup copies of these documents.

They stressed the need for the ministry to take the necessary legal measures regarding the matter, to find out the reasons for the destruction and loss of documents, and to try to search for the backup copies.

The sources said the ministry assured the bureau of the referral of the incident to the investigations, which ended with the filing of report, due to the inability to fulfill the legal elements of the subject matter of the claim, the lack of legal capacity for the former officials of the administration because of the issuance of an administrative decision to accept their resignations.

They said, "Regarding the observations that marred the implementation of Contract No. 10- 2019/2020 concerning the supply, installation, operation, and maintenance of 170 computers at an amount of KD 41,000, the incident was referred to the committee formed by the minister of Social Affairs at the time to investigate the matter and take the necessary action regarding it."

The sources explained that the bureau demanded the ministry to provide it with the reasons for renewing licenses for security devices and protecting their networks, at a total cost of KD 149,000, despite the inclusion of another contract for the supply and maintenance of the integrated security system for the ministry's infrastructure, which cost KD 1.156 million and is considered a waste of public money and a violation of the rules for implementing the budget of government agencies for the 2022/2023 fiscal year. The ministry informed the bureau about referring the case for investigations to take the necessary action.

It was the Ministry of Social Affairs that initiated, under the leadership of the assistant undersecretary for Planning and Administrative Development Affairs, to inform the supervisory authorities in the country about the aforementioned facts, after reviewing and auditing the contracts concluded in this regard, to determine their importance and the goals to be achieved as a result of their conclusion, as well as to ensure that they match the size of its financial value compared to the services it provides. This was based on its keenness to implement the directives of the Council of Ministers aimed at rationalizing spending and stopping unjustified financial waste.

The ministry was able to reduce the estimated value of some mechanization projects, cancel others, and achieve financial savings for the state treasury by about KD 1.5 million in a way that does not affect all services provided to the

The team, which was formed to respond to all the observations and shortcomings included in the report of the State Audit Bureau and was headed by the ministry's undersecretary and with the assistant undersecretaries as members, will submit to the bureau at the end of this week the final report with the ministry's statements on these observations.

The sources indicated that the team will continue with its meetings, the last of which was held last week, with the bureau's representatives to refute the observations separately.

They affirmed the ministry's serious keenness to avoid all the observations of the oversight authorities in the country, led by the State Audit Bureau, the Civil Service Commission, the Financial Controllers and Employment Affairs.

Family of fraudsters: The Court of Appeal, headed by Counselor Salah Al-Houti, put behind bars for 10 years the director of an Iraqi company, his Kuwaiti wife for 5 years, the brother of the director for 5 years, and their Kuwaiti partner for 8 years, and fined them a total of 30 million dinars, for selling fake chalets in the Khairan area and money laundering, reports Al-Rai daily.

The court decided to protect the rights of those affected who bought chalets in the Khairan area during exhibitions organized by the company licensed by the Ministry of Commerce, but it was found that the company did not own the land, and that the buildings were built without permits, and the electric current was connected on the strength of forged licenses.

The daily added, more than one thousand Kuwaitis had bought chalets and shops for tens of millions of dinars.

Attorney Ali Al-Attar said, "The judiciary today, with this ruling, placed responsibility on the government and the National Assembly to implement judicial rulings and implement the law by tracking the money and returning it to its owners and compensating those affected by this process, as well as holding government officials accountable who failed in their role to monitor real estate exhibitions.

Al-Attar called on the office of Mashari Al-Osaimi, both the National Assembly and the government, to quickly address the effects of real estate fraud operations that took place through real estate exhibitions that were held under the umbrella of the Ministry of Commerce.

Court Cases

Court sets 9/11 hearing in case of 'Luxury Cars'

KUWAIT CITY, July 18: The Criminal Court has decided to postpone the hearing of the so-called Luxury Cars Office case, in which 455 plaintiffs are citizens, to September 11, 2023, to review the documents and pay the civil lawsuit fees, reports Al-Qabas daily.

The court refused to release the owner of the office and one of his partners, and release 9 other employees. It also refused the request of the defense council to release the company's funds which the defense claimed will help their client to pay the defendants or reduce the number of claims.

The criminal court was packed to capacity and an unprecedented number of people crowded the courtroom expecting the court to issue a verdict.

Two Kuwaitis, believed to be the main accused, were placed inside the cage in the courtfoom, as dozens of citizens demanded KD 5,001 temporary compensation for each of them.

The office had allegedly fraudulently sold cars to the victims at a price lower than the agency, but failed to deliver the goods.

Egyptian jailed: The Criminal Court, headed by Judge Nayef Al-Dahoum, sentenced an Egyptian to seven years in prison followed by deportation

for encouraging others to join the Islamic State of Iraq and the Levant (ISIS) and be among its fighters through Telegram and video clips; in addition to taking advantage of an event in a mosque in Salmiya to promote ISIS, reports Al-Qabas daily.

During investigations, the defendant affirmed his belief in the ideologies of ISIS; including the excommunica-



tion of anyone who violates its ideals even if they are Muslims.

Fake ID used: The Public Prosecution has clarified that Attorney General Saad Al-Safran has no personal account on any of the social networking platforms, reports Al-Anba daily.

The prosecution made the clarification after the spread of social media posts attributed to Al-Safran.

New cases registered: The semi-annual statistics issued by the Ministry of Justice for 2023 revealed about 424,000 new cases were registered at the Court of First Instance, reports Al-Qabas daily.

The copy of statistics obtained by daily indicates that the most prominent cases registered during the first half of this year were 1591 crimes, 16 state security cases, and 486 domestic violence cases. The sources stated that the Court of First Instance

registered 12 cases of "money laundering", 954 juvenile cases, 531 information technology cases, in addition to 46 complaints against lawyers. It pointed out that 298 traffic violations, 2,196

environmental cases, 908 dud cheque cases, and 4,864 passport misdemeanor cases were record-

volvement in drug cases, reports Al-Qabas daily. Those arrested included seven citizens, four Arabs, three

Asians, six Bedouns and two other nationalities. The officers also confiscated 16.500 kilograms of various narcotic substances; 2,400 psychotropic pills and an undis-

closed amount of cash. During investigation, those arrested admitted ownership of the confiscated items, indicating the drugs were for trading and personal consumption.

The ministry emphasized that security efforts are continuing to track down drug dealers and users.

Two drug addicts caught: The Najdat Al-Ahmadi patrols arrested two bedoun in front of the Mahboula area in a state of abuse and for possessing narcotics and drug paraphernalia, reports Al-Anba daily. The daily said both men have been referred to the General

Administration for Drug Control.

The daily added, the police patrol suspected the men after seeing them drive slowly on a highway and when the man behind the wheel was asked to pull over for driving below the permissible speed limit, the officer discovered the man was under the influence of drugs. Police records also showed the man was wanted by law in

theft cases and the car he was driving was wanted by the judiciary. After the search of the vehicle police found narcotics, - pills, sachets of shabu, chemical and hashish - and the drug paraphernalia.

The decision stipulates all commercial shops in the designated areas must close by 1:00 am. The decision states that a new Article No. 2 bis shall be added to Administrative Resolution No. 3212/2022 GM regarding determining the working hours of shops located in private housing areas, which reads as follows.

"The working hours of shops located in these areas are determined until one in the morning maximum, direct sales are not allowed.

The decision calls on all concerned authorities and sectors to start implementing the decision 30 days after the date of its publication in the Official Gazette.

Rationalization of power consumption in schools

KUWAIT CITY, July 18: The Assistant Undersecretary for Educational Facilities and Commissioning Planning, Eng. Mohammed Al-Khalidi during a joint coordination meeting recently with representatives from the Ministry of Electricity and Water, headed by the Assistant Undersecretary for Monitoring, Control and Oversight Centers, Chairperson of the Electricity and Water Rationalization Strategy Committee Eng. Fatima Hayat, in the presence of representatives of the educational districts and engineers from the Ministry of Electricity and Water, shed light on the campaign to rationalize power consumption, reports Al-Jarida daily.

During the meeting, he spoke of the ways to enhance work between the two sides, joint cooperation and exchange of experiences and professional practices were discussed, in order to achieve success during the practical course of both sides.

He added, the campaign to rationalize electricity consumption was initiated through the process of closing and controlling air-conditioning systems during the recession period (summer), except for schools where summer clubs, server rooms, technology rooms, theaters, and halls are held as required.

Moreover, in schools in which there is a so-called preventive maintenance of airconditioning systems, in light of the Ministry of Education's readiness for the new academic year, he added.

He stressed that the Ministry of Education seeks to improve energy efficiency by selecting energy saving devices to be a substitute for those currently being used in some schools to rationalize optimal consumption in all sectors of the MoE facilities, which contributes to supporting and rationalizing electricity consumption during the summer period 2023, and the increasing

demand for energy.

Meanwhile, Minister of Education, Dr. Hamad Al-Adwani, recently submitted an urgent memorandum to the Civil Service Commission with regards to the organizational structure of the schools in accordance with the tasks entrusted to this vital educational in40 yrs in service

Al-Shula retires 10 consultants

The ministry spokesman, Ahmed Al-Wahida, said in a press statement that this measure comes to ensure the sustainability of work in schools without legal or technical deficiencies and to stop financial waste, saying the approval of this structure will fortify many decisions and work mechanisms, the most important of which is the mechanism for evaluating the efficiency of workers in the educational process and the application of the fingerprint system in schools, which the educational sector will face difficulty in applying them in the absence of an organizational structure and clear job description that define the individual tasks.

He pointed out that the ministry is awaiting coordination between the CSC and the Ministry of Education regarding the organizational structure of schools.

'Legal legislation needed'

Move to purchase energy from GIA

KUWAIT CITY, July 18: With a crucial meeting on the cards between the Ministry of Electricity and Water officials and the Fatwa and Legislation Department to discuss the latest developments in purchasing energy from the Gulf Interconnection Authority, informed MEW sources suggested that it would be necessary to enact legislation that would allow this step, since the purchase process here is considered with an institution external, even if Kuwait is a member of the same body, reports Al-Qabas daily.

The sources said that the ministry has been working for months to speed up the procedures for allowing it to purchase 600 megawatts from the authority, a step for which nearly 30 million dinars were allocated, but the Central Agency for Public Tenders had previously informed the ministry that it was not competent in this matter, because the discussions with the fatwa department were still ongoing

The sources indicated that if it was de-

cided to resort to enacting a law that allows the purchase of energy from the Gulf interconnection, similar to the amendment that took place regarding the decree establishing the ministry, which introduced amendments allowing it to purchase energy from others inside the country, then the purchase process will most likely take place from the authority after the end of the current peak season, which lasts until mid-August.

The sources pointed out that with the rise in temperatures during the coming days, and it is expected that the loads will increase significantly with them, rationalizing consumption becomes the best option, to ensure safe operation and stability in the electrical network.

She explained that controlling air-conditioning devices in homes, which consume about 70% of the electricity of private housing during the current period, and promoting the concept of energy efficiency at the level of all devices used would make a noticeable difference in consumption.

Kuwait up four notches in '23 Henley Passport Index

Major shake-up in world's passport power ranking

KUWAIT CITY, July 18, (Agencies): Kuwait ranked 55th with a visa-free score of 99 in the 2023 Henley Passport Index released Tuesday.

This means that Kuwaitis can travel to 99 destinations around the world without the need to obtain a visa. The country's ranking went up four notches compared with its rank in 2022 when it landed on the 59th spot with a visa-free score of

According to Henley & Partners - the institution behind the index. "countries are ranked based on information obtained from the International Air Transport Authority (IATA). The index, which includes 199 passports and 227 travel destinations, is considered the standard reference tool for global citizens and sovereign states when assessing where a passport ranks on the global mobility spec-

Travel destinations

Japan has been knocked off the top spot on the Henley Passport Index for the first time in five years and bumped into 3rd place, according to the latest ranking, which is based on exclusive data from the International Air Transport Association (IATA). Singapore is now officially the most powerful passport in the world, with its citizens able to visit 192 travel destinations out of 227 around the world visa-free. Germany, Italy, and Spain all move up into 2nd place with visa-free access to 190 destinations, and Japanese passport holders join six other nations - Austria, Finland, France, Luxembourg, South Korea, and Sweden - in 3rd place with access to 189 destinations without a prior visa.

The UK appears to have finally turned the corner after a six-year decline, jumping up two places on the latest ranking to 4th place - a position it last held in 2017. The US, on the other hand, continues its now decade-long slide down the index, plummeting a further two places to 8th spot with access to just 184 destinations visa-free. Both the UK and the US jointly held 1st place on the index nearly 10 years ago in 2014 but have been on a downward trajectory ever since. Afghanistan remains entrenched at the bottom of the index, with a visafree score of just 27.

Dr. Christian H. Kaelin, Chairman of Henley & Partners, says the general trend over the his-

Bank of America net income jumps 19%

Bank of America said its profits grew 19% in its most recent quarter, the latest of the big banks to see its bottom line boosted by higher interest rates. The nation's second-largest bank by assets posted a profit of \$7.4 billion in the three months ended June 30, up from \$6.2 billion in the same period a year earlier. On a per-share basis, BofA earned 88 cents, compared with 73 cents one year ago. Analysts were expecting profit of 84 cents per

share, according to a poll by FactSet.

Revenue of \$25.2 billion came in just ahead of target.

Like its major competitors, BofA has benefitted from wealthy clients, businesses and other customers moving deposits to the bank in search of safety after this spring's bank failures. The nation's biggest banks are seen as having an implicit government backstop, due to their "too big to fail" status among the country's financial institutions.

The Federal Reserve has raised its benchmark interest rate to a range of 5% to 5.25% from near zero starting in March 2022. Those higher interest rates have allowed banks to charge more for customers

to borrow. Bank of America's net interest income rose 14% to \$14.2 billion in the second quarter.

BofA set aside roughly \$602 million to cover potentially bad loans in the quarter. Many banks have been increasing their socalled loan loss reserves the last few quarters as customers start borrowing again after not doing so during the pandemic, and inflation starts stretching household budgets. Shares of Bank of America Corp. rose slightly before the opening bell Tues-

Privacy concerns in user advertising the issue

Meta faces \$100K daily fine from Norway regulator

NEW YORK, July 18, (AP): Meta will face a hefty fine over advertising practices that violate user privacy, Norway's data protection authority said Monday, unless the Facebook and Instagram owner takes action to comply with the law.

Norwegian regulator Datatilsynet says that behavioral advertising - a common marketing model that profiles users by collection information like their physical locations, among other data - without consent is illegal. Because of this, Datatilsynet imposing a "temporary ban" of such practices on Facebook and Instagram.

During the ban, which starts August 4, Meta risks a fine of up to 1 million Norwegian kroner (nearly \$100,000) each day. The ban will "last for three months, or until Meta can show that it complies with the law," Da-

This decision "does not ban Facebook or Instagram in Norway," Tobias Judin, the Norwegian Data Protection Authority's international department head, stated in a release. "The purpose is rather to ensure that people

in Norway can use these services in a secure way and that their rights are safeguarded."

In a statement sent to The Associated Press on Monday, Meta said that the company will review Datatilsynet's decision - and added that there is "no immediate impact" to its services.

Debate

"The debate around legal bases has been ongoing for some time and businesses continue to face a lack of regulatory certainty in this area," Meta said. "We continue to constructively engage with the Irish (Data Protection Commission), our lead regulator in the EU, regarding our compliance with its decision."

Norway is not a member nation of the European Union, but is included in the European Economic Area (EEA).

In Monday's announcement, Datatilsynet pointed to a December decision from the Irish DPC, which ordered Meta to bring behavioral advertising in line with European law by April. The regulator also nodded a recent judgement from the EU's top court, which outlined how Meta's practices still didn't comply with the law.

"Nonetheless, Meta continues its practices," Judin told The AP over email. "Considering the recent legal developments and Meta's inaction, we consider it urgent to intervene. If not, we fear that Meta would continue delaying compliance.

A behavioral advertising ban beyond Norway is possible. Datatilsynet says it may take the matter to the European Data Protection Board, which could extend the three-month ban and led to wider implications across the continent.

Meta has been under fire over data privacy for some time. In May, for example, the EU slapped Meta with a record \$1.3 billion fine and ordered it to stop transferring users' personal information across the Atlantic by October. And the tech giant's new text-based app, Threads, has not rolled out in the EU due to privacy concerns.

Microsoft & British regulators win more time to resolve blocked deal

Judge approves joint request

LONDON, July 18, (AP): Microsoft and British regulators won more time from a court Monday as the U.S. tech company uses a rare second chance to overcome opposition to its \$69 billion bid for video game maker **Activision Blizzard.** Judge Marcus Smith condition-

ally approved a joint request from Microsoft and the Competition and Markets Authority to delay the appeal that the company set in motion after the CMA initially rejected the deal. The regulator later pushed back its final decision so it can consider Microsoft's argument that new developments mean its blockbuster purchase of the Call of Duty game maker should go

Also on Monday, a group of gamers who've described themselves as Activision fans made a last-ditch effort to stop the deal in the U.S., asking the Supreme Court for an emergency order that would block Microsoft from imminently closing the deal before its self-imposed Tuesday deadline.

The deal has already won approval in the European Union and a slew of countries but has faced opposition from antitrust regulators in Britain and the United

The U.K. blocked the deal on concerns that it would stifle competition in the small but fast-growing cloud gaming market. It also faced stiff resistance from rival Sony, which makes the PlayStation console that is a rival to Microsoft's Xbox game

But those positions appeared to be softening. Microsoft said Sunday it signed a 10-year agreement with Sony to keep the popular Call of Duty video game series on the PlayStation if the merger goes through.

Flashpoint

Activision's Call of Duty series of games has been a flashpoint in the merger battle fuelled by Sony's fears it would lose access to the ti-

As it tried to win over regulators around the world, Microsoft has been signing provisional agreements to license Activision titles like Call of Duty to Nintendo and some cloud gaming providers. Sony had been holding out until

The British watchdog said last week that it's giving itself six extra weeks to consider Microsoft's submission outlining new developments and "special reasons" why the deal should be approved.

Smith said his ruling was conditional based on the CMA providing written explanations to address some points he raised. He said it would also help if Microsoft provided a statement "explaning the significance of the Sony transac-

The judge acknowledged the need to come up with a speedy decision before Tuesday, which marks an important deadline for the deal. Both Microsoft and Activision had agreed that either party could walk away from the planned merger if it hasn't closed by then, triggering Microsoft to potentially

Ford 'cuts' prices for F-150 Lightning electric vehicles

The sticker price on Ford's F-150 Lightning electric pickup is being lowered by thousands of dollars due to increased plant capacity, falling costs for battery raw materials and internal efforts to scale production by the Detroit automaker.

Ford Motor Co. said Monday that final upgrades at its Rouge Electric Vehicle Center in Michigan being completed now will lead to greater availability of a built-to-order truck as early as October at a manufacturer's suggested retail price closer to initial Lightning pricing.

The updated MSRP for the Pro model, it's lowest priced electric pickup, will be \$49,995, down from \$59,974. The Lariat 510A's MSRP will decline to \$69,995 from \$76,974.

"Shortly after launching the F-150 Lightning, rapidly rising material costs, supply constraints and other factors drove up the cost of the EV truck for Ford and our customers," said Marin Gjaja, chief customer officer, Ford Model e. "We've continued to work in the background to improve accessibility and affordability to help to lower prices for our customers and shorten the wait times for

their new F-150 Lightning."

The price cuts arrive two days after Tesla said its first production Cybertruck electric pickup had rolled off the assembly line, nearly two years behind the original schedule.

The truck's 2019 unveiling veered off course when a window that was touted as unbreakable was spider-cracked when hit by a big metal ball, which prompted an expletive from Musk.

Tesla originally said it would make three versions of the truck, ranging from about \$40,000 to \$70,000. Later the company removed prices from the page where customers can decide whether to plunk down \$100 and place an order.

Ford CEO Jim Farley and Tesla CEO Elon Musk announced in March that all of Ford Motor Co.'s current and future electric vehicles will have access to about 12,000 Tesla Supercharger stations in the U.S. and Canada starting next spring. Commercial customers can also access Ford Pro Charging solutions to keep their F-150 Lightning powered up whether charging at home or onsite at work. (AP)

Investment scammers prey heavily on people feeling lonely

NEW YORK, July 18, (AP): Scammers targeting investors are using fears of a recession and high inflation to put new wrappers on their ruses, but the underlying scams are still pretty much the same, says Andrew Hartnett. He is president of the North American Securities Administrators Association, a group devoted to protecting investors. He is also deputy commissioner in the Iowa Insurance Division.

Hartnett recently told The Associated Press that the key, as always, is to be wary of anything that sounds too good to be true. He also said scammers prey heavily on people feeling lonely, something that's becoming more common. The conversation has been edited for length and clarity.

Question: How much are investment scammers using high inflation and recession worries to their advan-

Answer: We're definitely seeing that as part of the pitch or the way that the scammer creates fear in the person they're pitching.

One of the traditional scam types that we see is an investment that offers a guaranteed rate of return. Not just a guaranteed rate of return but an abnormally high rate of return, like 15%. So you can see how those two things



Actors, writers on strike united in the face of long standoff

LOS ANGELES, July 18, (AP): Solidarity and stamina were picket-line themes Monday as striking screenwriters and actors in New York and Los Angeles braced for a long, hot summer standoff with

Picketers emphasized unity between writers, who have been on the lines for more than two months, and performers, who are only on Day 2 of striking - as well as camaraderie between highly paid actors and those with spare screen credits who struggle to scrape

Kevin Bacon, who was among the famous faces picketing among unknowns outside Viacom headquarters in New York, said his presence was about "seeing people out here and being aware that not all actors are super high paid actors, that they are working class

people who are trying to make a living."

One such working actor, Whitney Morgan Cox, who has appeared on the CBS series "Criminal Minds," said it was "powerful" to see writers and actors come together who don't often work simultaneously in production.

"I don't think people necessarily realize the energy that writers and actors have," Cox said outside Walt Disney Studios in Burbank, California, "and the stamina, and our ability to commit, that's all our entire job is about is just committing to something and following through. So it's been a really beautiful sense of community.' Leaders of the Screen Actors Guild-American Federation of Television and Radio Artists (SAG-AFTRA) voted unanimously on Thursday that when their contract expired they would start striking the following day, joining the Writers Guild of America, who walked out on May 2.

"It's been amazing to be out here now that we have the second wind of SAG members coming," said Paul Scheer, who was already striking as a writer, and is now doing the same as an actor, outside Netflix headquarters in Hollywood. "I'm on strike two times, which means I have to walk double the steps, which is hard, but I'm willing to do it."

Support

On Monday temperatures were in the high 80s in New York, and well above 90 degrees F (32 C) in parts of Los Angeles, where some afternoon pickets were called off because of the extreme heat.

A union rally was planned for later in the day in Atlanta, where many productions have moved in recent years because of tax breaks and other lower costs.

The issue also came up in Washington, when White House press secretary Karine Jean-Pierre responded to a question during Mon-

day's briefing about whether the Biden administration supports the aims of striking entertainment workers.

"The president believes all workers, including the writers, including the actors, they deserve fair pay. And they deserve fair benefits," Jean-Pierre said. "We sincerely hope that both actors and writers strikes get resolved, and that the parties come together and have a mutually beneficial agreement as soon as possible.


While actors and writers also emphasized the need to reach a deal, few believed any such agreement would be coming soon, given the vast distance between the unions and the Alliance of Motion Picture and Television Producers - which represents studios, streamers and production companies in negotiations that are currently neither happening nor planned.

Key issues for both unions include residual payments, which have been nearly wiped out by the switch to the streaming system, and the unpaid use of their work and likeness by artificial intelligence avatars.

The AMPTP said it has offered fair terms on those and other issues.

"These things are things that I personally can negotiate for," Bacon said. "But I'm here for the working class, middle class part of our union who needs these basic provisions in the basic contract."

NEW YORK, July 18, (AP): To get a sense of just how much animosity is flying around Hollywood these days, watch how Ron Perlman responded to a report that the studios aimed to prolong a strike long enough for writ-

ers to lose their homes. Perlman, the hulking, gravel-voiced actor of "Hellboy," leaned into the camera in a since-deleted Instagram live video to vent his anger. "Listen to me, mother-(expletive)," Perlman said. "There's a lot of ways to lose your house.

Three years after the pandemic brought Hollywood to a standstill, the film and TV industry has again ground to a halt. This time, though, the industry is engaged in a bitter battle over how streaming - after advancing rapidly during the pandemic - has upended the economics of entertainment.

Having weathered plague, Hollywood is now fully at war in its own "Apocalypse Now" double feature. When tens of thousands Screen Actors Guild-American Federation of Television and Radio Artists hit the picket lines last week, joining 11,000 Writers Guild of America screenwriters who have been on strike since May, a smaller clash went nuclear just in time for the release of "Oppenheimer." As striking actors and writers mobilized to mob studio lots and streamer headquarters, Puck's Matthew Belloni wrote, "The town is burning to the ground."

'You cannot change the business model as much as it has changed and not expect the contract to change, too," said Fran Drescher, SAG-AFTRA president, in a fiery press conference announcing the strike. "We're not going to keep doing incremental changes on a contract that no longer honors what is happening right now with this business model that was foisted upon us.

"What are we doing?" she added. "Moving around furniture on the Titanic?"

Disaster also loomed in Hollywood when COVID-19 in March 2020 shuttered movie theaters, emptied TV studios and shut down all production. The recovery is still ongoing. Over the weekend, one of the first major film productions shut down by the pandemic - "Mission: Impossible - Dead Reckoning Part One" - only just reached theaters. And as its big-but-not-blockbust-

25% off the pre-pandemic pace. "We've talked about disruptive forces on this business and all the challenges we're facing, the recovery from COVID which is ongoing. It's not completely back," Disney CEO Bob Iger said Thursday. "This is

the worst time in the world to add to that disruption." Though many of the demands of SAG-AFTRA and the WGA are longstanding, much of the current dispute gathered force in the helter-skelter days of the pandemic. A digital land rush to streaming ensued, as studios, in many cases, hurried to craft their Netflix competitors. Subscriber growth became the top priority.

Rahul Telang, a Carnegie Mellon University professor and co-author of the book "Streaming, Sharing, Stealing: Big Data and the Future of Entertainment," says an entire era of change was condensed into two years.

"What is happening right now was bound to happen. With streaming, the whole business got disrupted," says Telang. "So naturally, they're complaining, 'We need our fair share.' But how do you decide what's a fair share? There has to be a transparency about where the money is coming from and where it's going. Until this gets resolved, this issue will keep coming up.

Protections

The last time screen actors and writers struck simultaneously, in 1960, the guilds established royalty (later residual) payments for replays of films and TV episodes, among other landmark protections. If that strike reckoned with the dawn of television, this one does much the same for the streaming era.

But streaming, especially when companies carefully guard audience numbers, offers no easy metric like box office or TV ratings to establish residuals - long a foundational part of how writers and actors make a living. SAG-AFTRA is seeking a small percentage of subscriber revenue, with data measured by a third party, Parrot Analytics.

The Alliance of Motion Picture and Television Producers, which negotiates on behalf of the studios, hasn't agreed to that but says the studios have offered actors "historic pay and residual increases," along with pen-

sion contributions and other protections. Meanwhile, actors are sharing images of their paltry residual payments for streaming hits. Kimiko Glenn of Netflix's "Orange Is the New Black" posted a clip of residual payments totaling \$27.30.

"You used to be able to work on a broadcast show, one show and you're good for the year because of the residuals," said actor Nachayka Vanterpool on the picket lines. "And then you have streaming coming along

and you got 20 cent residual checks. That impacts you. Increasingly, it's looking like everyone lost in the socalled streaming wars that went into hyperdrive under COVID-19. Since Wall Street last year began souring on subscription numbers being the be-all-end-all, most media companies have suffered stock declines. Wall

Street's message turned to: Show us the profits. At the same time, the drive to streaming has accelerated the demise of traditional television and its ad-based revenue. That's led analysts like Michael Nathanson of MoffettNathanson to survey a fragmented entertainment business and forecast a "scary" second half of the

year for media companies. With traditional TV increasingly eroded by streaming, many studios have been cutting costs. Disney, Warner Bros. Discovery and Netflix all slashed jobs over the past year and a half. Streaming profitability has remained elusive. The Walt Disney Co. says Disney+ will get there in fall 2024. WarnerBros. Discovery, which has taken the extreme step of canning finished productions to reshape its streaming strategy, says Max will start making money this year.

Many are now girding for a prolonged stoppage that, if carried into September, would greatly impact the fall TV schedule and the film festivals (Venice, Telluride, Toronto) that launch awards season contenders. Drescher said she "couldn't believe" how far apart her union and AMPTP are.

Ronny Regev, who penned the book "Working in Hollywood: How the Studio System Turned Creativity into Labor," thinks this strike could play out similarly to the 1960 stoppage, when actors struck for about a month but the writers strike dragged on.

Final witness

John lends celebrity 'support' to Spacey

LONDON, July 18, (AP): Kevin Spacey's lawyers enlisted the help of an A-list star Monday in his sexual assault trial, calling on Elton John and his husband to cast doubt on one of the Oscar winner's accusers at the end of the defense case.

John appeared briefly in the London court by video link from Monaco after his husband, David Furnish, testified that Spacey did not attend an annual gala ball at their Windsor home at the time that the accuser said he was attacked in a car.

John was the final witness for the defense and was followed by character testimonials from colleagues, friends and family that had Spacey in tears in the dock when they were read aloud by his lawyer in Southwark Crown Court.



Spacey, 63, has pleaded not guilty to a dozen charges that include sexual and indecent assault counts and one count of causing a person to engage in penetrative sexual activity without consent.

One of the alleged victims said he was driving Spacey to the White Tie & Tiara Ball in 2004 or 2005 when the actor grabbed his crotch so forcefully that he almost ran off the road

Furnish supported Spacey's own testimony that the only year he had attended the event was 2001. Furnish said he had reviewed photographs taken at the party from 2001 to 2005 and Spacey only appeared in images that one year. He said all guests were photographed each year.

graphed each year.

John, who was wearing yellow tinted glasses, a dark jacket and light blue open-collar shirt, said the actor attended the party once in the early 2000s and arrived after flying to England on a private jet.

Spacey's appearance was a surprise and memorable because it was a big deal, said Furnish, a filmmaker and John's manager, who also appeared from Monaco.

"He was an Oscar-winning actor and there was a

"He was an Oscar-winning actor and there was a lot of buzz and excitement that he was at the ball," said Furnish.

Auction

John said the actor spent the night at their house after the event. He also confirmed that Spacey bought a Mini Cooper at the auction held that night for the Elton John AIDS Foundation.

Spacey said he spent the most money "ever" on that model of car and he kept it in John's garage until he could pick it up later.

The alleged victim said he may have gotten the year wrong, but that he would not have forgotten the incident because it took his breath away and he was driving and almost crashed the car.

The timeline, however, is important because the man testified that Spacey had fondled him over several years beginning in the early 2000s. The incident was the final occasion, he said. He threatened to hit the actor and after that avoided him.

Spacey said the two were friends and they engaged in some romantic contact but the man was straight, so the actor respected his wishes not to go further. He said he was crushed when he learned the man had complained to police about him and said the man had "reimagined" what had been consen-

sual touching.
Furnish said he was familiar with the accuser and described him as "charming," the same term Spacey

Over two days of testimony last week, the two-time Academy Award winner insisted that he never sexually assaulted three of the four accusers who described disturbing encounters between 2001 and 2013. The acts allegedly escalated from unwanted touching to aggressive fondling to one instance of performing oral sex act on an unconscious man.

Spacey dismissed one man's fondling claims as "pure fantasy" and said he shared consensual encounters with two others who later regretted it. He accepted the claims of a fourth man, saying he had made a "clumsy pass" during a night of heavy drinking, but he took exception to the "crotch-grabbing" characteriza-

Defense lawyer Patrick Gibbs rested his case after reading statements from 10 character witnesses who praised the actor's work and compassion toward oth-

Spacey dabbed at his eyes with a tissue as Gibbs read the words of actor Robert Sean Leonard, known for his role on the TV show "House" and the movie "Dead Poets Society." Leonard said Spacey was "positive, supportive and respectful" and someone he

"He's more than a successful actor, he's a movie star, but unlike every other movie star I've worked with, he doesn't know it," Leonard said. "Stardom was never his goal. He loves and respects the work, and he loves and respects the people he works with.'

Closing arguments are expected later in the week. Spacey is free on bail.

John's testimony came just over a week after he wrapped up his 50-year touring career with a show in

It's the second time the "Rocket Man" star and Furnish have made appearances in a London courtroom this year. The two also showed for hearings in March at the High Court in their phone hacking lawsuit with Prince Harry against the publisher of the Daily Mail newspaper.

NASHVILLE, Tenn: Nashville music executive Jerry Bradley, who signed Alabama and Ronnie Milsap and helped brand the outlaws style of country music during a 40-year career, died Monday.

Bradley died peacefully in Mt. Juliet, Tennessee, according to an obituary released by his family.

Bradley began his career in the 1960s, working in his family's music publishing business alongside his famous producer father, Owen Bradley. As an engineer, his clients included Loretta Lynn, Dinah Shore, Gordon Lightfoot and The Who, according to the obituary.

Bradley struck out on his own in 1970 joining RCA Records under Chet Atkins before taking over as head of the label's Nashville branch from 1973-1983. That is where he signed Alabama and Milsap. He helped market the outlaws of country music in a platinum-selling album called "Wanted: The Outlaws." Under his leadership, the careers of Dolly Parton and Charley Pride flourished.

After leaving RCA, Bradley ran the Opryland Music Group, whose song catalogs included the classics of Hank Williams, Roy Orbison and the Everly Brothers. But Bradley wanted more and acquired new staff, song pluggers, and songwriters, including **Kenny Chesney**, according to the obituary. Bradley retired in 2003 after the company was acquired by Sony/ATV Music.

Chesney said in a statement that Bradley "had a profound and unmeasurable impact on my life. But not just in my life. ... He helped change the lives of so many people that had a song in their heart. Jerry's impact on our creative community will be felt for years.'

Bradley was inducted into the Country Music Hall of Fame in 2019. (AP)

RIO DE JANEIRO: Brazilian composer and pianist **João Donato**, who helped lay the groundwork for bossa nova but throughout his career defied confinement to any single genre, died Monday. He

His death was announced on his verified Instagram account. Local media reported that he had been hospitalized and intubated with pneumonia.

Donato was prolific and inventive, collaborating with top artists at home and abroad, including Chet Baker, João Gilberto, Sergio Mendes, Tito Puente, Gilberto Gil, Gal Costa and countless others.

"Today we lost one of our greatest and most creative composers," Brazilian President Luiz Inácio Lula da Silva wrote on Twitter. "João Donato saw music in everything. He innovated, he passed through samba, bossa nova, jazz. forro and in the mixture of rhythm built something unique. He kept creating and innovating until the end.

Donato was born in the Amazonian state of Acre on Brazil's western border, far from the cultural hubs of **Rio de** Janeiro and Sao Paulo. He showed prodigious musical ability as a boy upon

Ronson details how film's score came together

'Barbie' soundtrack is rich, diverse

LOS ANGELES, July 18, (AP): Mark Ronson is showing off his Barbies

Scattered throughout his studio, the executive producer of the "Barbie" soundtrack - and a musical polymath known for his work with art-ists like Amy Winehouse and Lady Gaga - has a few "leftovers" scattered across the room. One doll is placed in a permanent split, stretched across a Moog synthesizer. Another is styled to look like primatologist Jane Goodall.

"I went to Toys R Us and I couldn't find a single Ken," he laughs. Fittingly, "that's the theme of the movie." Mattel HQ did end up sending over a few; the Ken that remains in Ronson's studio is, appropriately, shirtless.

Finding the sound of "Barbie," poised to become one of 2023's biggest blockbusters, required careful consideration and research for a film with such a rich visual palette. In the track that included Lizzo, Billie Eilish, Dua Lipa (who also acts in the movie) and more.

But it started with a simple text message.

The music supervisor on the project, George Drakoulias, shot Ronson a quick, "Barbie?" Ronson read the script and was in. He also scored "Barbie" with collaborator Andrew Wyatt. Ronson is no stranger to working on music for film, but executive producing a soundtrack album and scoring an entire movie, let alone, a movie of this size, was new territory. "It was a lot of learning on the job," he says.

Assignment

The soundtrack assignment began with two tracks: a pop song for a big dance number and an '80s power ballad for Ken (name a genre with more "self-aware, bombastic silliness," as Ronson calls it).

The former came first. Ronson came up with a chorus and beat - a detour from his first, far too obvious plan on writing "'80s, sugar-y pop," and instead landing on a "groovy, melodic thing ... with some toughness," perfect for Dua Lipa. It became "Dance the Night," the Lipa track featured in

the film's main trailer. The Ken song came about differently. For the most part, Ronson works on instrumentals: When he wrote "Shallow" with Lady Gaga and Bradley Cooper for "A Star Is Born," for example, he only contributed lyrics to fill in gaps - the "surface, don't hurt us," line, as he recalls. But for the song that would become Ryan Gosling's "I'm Just Ken," Ronson couldn't shake the lyric: "I'm just Ken, anywhere else I'd be a 10."

So he sent director Greta Gerwig a demo with a few lines - including a deliciously mouthy lyric about "blonde fragility." She sent it to Gosling, who plays Ken in the film, and knew immediately he needed to sing it. What could have soundtracked any scene in the film became

Swift has more No. 1 albums than any 'woman in history'

LOS ANGELES, July 18, (AP): Congratulations are in order for Taylor Swift and her loyal fans, known as Swifties. The pop star officially has more No. 1 albums than

any woman in history.
"Speak Now (Taylor's Version)" released earlier this month, is the third in her endeavor to re-record her first six albums, instigated by music manager Scooter Braun's sale of her early catalog. It has officially debuted at No. 1 on the Billboard 200, becoming her 12th

album to reach the top spot.
Previously, Barbra Streisand held the record, with 11 No. 1 al-

Swift ties Drake's record of 12 No. 1 records, but sits just behind Jay-Z, who has 14 No. 1 albums to his name, and the Beatles, who have 19.

In addition to hitting this incredible milestone, Swift has 2023's biggest album release to date, with 716,000 equivalent album units, according to Luminate. An impressive 506,600 are in traditional album sales (a combination of 410,000 physical and 96,600 digital sales.)

With those figures, Swift has dethroned country singer Morgan Wallen, whose album "One Thing at a Time" sold 501,000 units in its

its own musical moment. Early on, Gerwig used the Bee Gees and '70s discos as a reference point for Ronson.

"You know the Chicago (Disco Demolition) thing, where everyone burned their disco records, "Saturday Night Fever" had reached its apex and the poor Bee Gees were like, 'All we wanted to do was make people dance! What did we do wrong?'

says Ronson. "That's 'Barbie." If anything, that idea is more of a thematic one than a sonic guideline. The mood board was vast, and also included "Dolly Parton, Olivia Newton John, 'Nine to Five," Ronson explains.

It speaks to why the "Barbie" soundtrack spans pop genres, including a reggaeton track courtesy Karol G, "Watati," bubblegum K-pop from girl group Fifty Fifty featuring Kaliii in "Barbie Dreams," and the falsetto-led piano ballad "What Was I Made

For?" by Billie Eilish. Collaboration

For Atlantic Records, who released the soundtrack, collaboration and diversity was key

"All of these artists were brought in early on to do screenings with Mark, Greta, and the filmmakers. They would see scenes they were going to write their music to," says Brandon Davis, executive vice president and co-head of pop A&R at the label. "Each of these artists wrote lyrics about the specific ways Barbie was important to them.

Ronson echoes the sentiment. "Karol G was like, 'I'm here because I love Barbie. I wasn't expecting this incredible film. This is awesome," he says. "And HAIM had this encyclopedic knowledge. The only VHS they were allowed in the '90s, when they were kids, was this one Barbie thing. They knew every song."

Others were tasked with a prompt: Lizzo's "Pink", which ends with a voiceover from Helen Mirren, was inspired by the lead Barbie, played by Margot Robbie, living through her perfect day. And because the

film is a comedy with real-world complications, humor informed a lot of the songwriting: It's in Dominic Fike's "Hey Blondie" as well as the many samples of Charli XCX's "Speed Drive."

Acquisition (cross head)

"(Soundtracks) are an area where we cracked the code and figured out how to make it work in a way where we support our partners creatively,' says Kevin Weaver, president of Atlantic Records West Coast, citing Atlantic's work on other major soundtracks like from the "Fast & Furious" franchise, "The Fault in Our Stars," and "The Greatest Showman," which produced massive hits like Wiz Khalifa and Charlie Puth's "See You Again," Charli XCX's "Boom Clap," and "This Is Me," respectively.

But unlike those films, part of the acquisition process for "Barbie" required a trip to the doll factory, where Atlantic executives got to witness the doll-making process from inception to completion. (Davis and Weaver are both producers on the soundtrack.)

When working with legendary intellectual property, a soundtrack comes with some risks. Do you bring back Aqua's 1997 hit "Barbie Girl," or do you reimagine it? Surely Nicki Minaj must be featured - her fans are called Barbz.

"I remember - no offense - that I had a song on the "Ghostbusters" remake and I think six of the 12 songs were reinterpretations of Ray Parker Jr.('s "Ghostbusters" theme)," says Ronson. "It all dovetailed into the single we have with Nicki Minaj and Ice Spice," he continued, referencing the reworking of "Barbie Girl."

"I've never really executive produced something before," Ronson says. "I love this film. We had an amazing partner in Atlantic Records."

"And then doing the score, but it was a lot of learning on the job. It was still a job that I've never really done before. ... It's fun to show people different scenes and getting them to dream big."

Deadly flooding hit 'several countries'

NEW YORK, July 18, (AP): Extreme rainfall accompanied by deadly flooding hit the United States and several other countries over the weekend and last week.

There were several dozen fatalities in central and southern regions of South Korea, including the Chongju region where an underpass flooded and drowned motorists who became trapped in their submerged vehicles.

În the US, flooding claimed five lives in Upper Makefield Township, Pennsylvania, where a search is ongoing for two missing children. Flooding also struck parts of New Hampshire, Massachusetts, Connecticut, New York and New Jersey this past weekend. A state of emergency was declared in New Jersey by Gov. Phil Murphy following significant damage from flooding and landslides

This follows last week's relentless flooding in India, Japan, China, Turkey

Although the destructive floods are occurring in different parts of the world, atmospheric scientists say they have this in common: With climate change, storms are forming in a warmer atmosphere, making extreme rainfall a more frequent reality now. The additional warming that scientists predict is coming will only make it worse.

That's because a warmer atmosphere holds more moisture, which results in

storms dumping more precipitation that can have deadly outcomes. Pollutants, especially carbon dioxide and methane, are heating up the atmosphere. Instead of allowing heat to radiate away from Earth into space, they hold onto it.

While climate change is not the cause of storms unleashing the rainfall, these storms are forming in an atmosphere that is becoming warmer and wetter.

"Sixty-eight degrees Fahrenheit can hold twice as much water as 50 degrees Fahrenheit," said Rodney Wynn, a meteorologist at the National Weather Service in Tampa Bay. "Warm air expands and cool air contracts. You can think of it as a balloon - when it's heated the volume is going to get larger, so therefore it can hold more moisture.

For every 1 degree Celsius (1.8 degrees Fahrenheit) that the atmosphere warms, it holds approximately 7% more moisture. According to NASA, the average global temperature has increased by at least 1.1 degrees Celsius (1.9 degrees Fahrenheit) since 1880.

Storms

"When a thunderstorm develops, water vapor gets condensed into rain droplets and falls back down to the surface. So as these storms form in warmer environments that have more moisture in them, the rainfall increases," explained Brian Soden, professor of atmospheric sciences at the University of Miami

Along Turkey's mountainous and scenic Black Sea coast, heavy rains swelled rivers and damaged cities with flooding and landslides.

At least 15 people were killed by flooding in another mountainous region, in southwestern China.

"As the climate gets warmer we expect intense rain events to become more common, it's a very robust prediction of climate models," Soden added. "It's not surprising to see these events happening, it's what models have been predicting ever

Gavin Schmidt, climatologist and director of the NASA Goddard Institute for Space Studies, said the regions being hit hardest by climate change are not the ones that emit the largest amount of planet-warming pollutants.

The bulk of the emissions have come from the industrial Western nations and the bulk of the impacts are happening in places that don't have good infrastructure, that are less prepared for weather extremes and have no real ways to manage this," said Schmidt.

In last week's flooding, schools in New Delhi were forced to close on July 10 after heavy monsoon rains battered the Indian capital, with landslides and flash floods killing at least 15 people. Farther north, the overflowing Beas River swept

vehicles downstream as it flooded neighborhoods. In Japan, torrential rain pounded the southwest, causing floods and mudslides that left two people dead and at least six others missing. Local TV showed damaged houses in Fukuoka prefecture and muddy water from the swollen Yamakuni

River appearing to threaten a bridge in the town of Yabakei. In Ulster County, in New York's Hudson Valley and in Vermont, some said the flooding is the worst they've seen since Hurricane Irene's devastation in 2011.

Meanwhile, heavy downpours lashed South Korea for a ninth day on Monday as rescue workers struggled to search for survivors in landslides, buckled homes and swamped vehicles in the most destructive storm to hit the country this year.

At least 40 people have died, 34 others are injured and more than 10,000 people have had to evacuate from their homes since July 9, when heavy rain started pounding the country. The severest damage has been concentrated in South Korea's central and southern regions.

In the central city of Cheongju, hundreds of rescue workers, including divers, searched for survivors in a muddy tunnel where about 15 vehicles, including a bus, were trapped in a flash flood that may have filled up the passageway within minutes Saturday evening.

The government has deployed nearly 900 rescue workers to the tunnel who have so far pulled up 13 bodies and rescued nine people who were treated for injuries. It wasn't immediately clear how many people were in the submerged

Emergency

As of Monday afternoon, rescuers had pumped out most of the water from the tunnel and were searching the site on foot, a day after they used rubber boats to move and transport bodies on stretchers.

Hundreds of emergency workers, soldiers and police were also looking for any survivors in the southeastern town of Yecheon, where at least nine people were dead and eight others listed as missing after landslides destroyed homes and buckled roads, the county office said.

Photos from the scene showed fire and police officers using search dogs while wading through knee-high mud and debris from destroyed homes.

Nearly 200 homes and around 150 roads were damaged or destroyed across the country, while 28,607 people were without electricity over the past several days, the Ministry of the Interior and Safety said in a report.

Severe weather was also affecting many other places around the world. In the United States, An already saturated Northeast began drying out Monday after a second round of heavy rain in a week, including a flash flood in Pennsylvania that claimed at least five lives over the weekend.

Schools and the stock market were closed in Hong Kong on Monday as Typhoon Talim sideswiped the city and headed toward the Chinese mainland and the island province of Hainan.

This year has seen record-breaking stretches of high heat across large parts of China, South Korea and Japan. China's National Meteorological Administration reported that temperatures in the oasis city of Turpan in the northwestern Xinjiang region hit a record 52.2 Celsius (125.9 Fahrenheit)

Italian health officials intensified heat warnings as southern Europe began a brutally hot week on Monday with temperatures expected to top 40 C - or 104 F - on a continent already overburdened by tourists. The third heatwave in a month was expected to affect much of the Mediterranean and last until Wednesday.

Oregon's Cannon Beach reopens: A

Both Alzheimer's drugs come with safety risk

New drug slows Alz's by 4-7 months

WASHINGTON, July 18, (AP): Another experimental Alzheimer's drug can modestly slow patients' inevitable worsening - by about four to seven months, researchers reported Monday.

Eli Lilly and Co. is seeking Food and Drug Administration approval of donanemab. If cleared, it would be only the second Alzheimer's treatment convincingly shown to delay the mindrobbing disease - after the recently approved Leqembi from Japanese drugmaker Eisai

"Finally there's some hope, right, that we can talk about," Lilly's Dr. John Sims told reporters Monday at the Alzheimer's Association International Conference in Amsterdam.

"We don't cure the disease," he said. "Diabetes doesn't have a cure either it doesn't mean you can't have very meaningful treatments for patients."

Lilly announced in May that donanemab appeared to work, but on Monday the full results of a study of 1,700 patients was published by the Journal of the American Medical Association and presented at the Alzheimer's conference.

Infusions

Both donanemab and Leqembi are lab-made antibodies, administered by IV, that target one Alzheimer's culprit, sticky amyloid buildup in the brain. And both drugs come with a serious safety concern - brain swelling or bleeding that in the Lilly study was linked to three deaths.

Scientists say while these drugs may mark a new era in Alzheimer's therapy, huge questions remain about which patients should try them and how much benefit they'll really notice.

"The modest benefits would likely not be questioned by patients, clinicians or payers if amyloid antibodies were low risk, inexpensive and simple to administer. However, they are none of these," Dr. Eric Widera of the University of California, San Francisco, wrote in a JAMA editorial accompanying Lilly's new data.

Lilly's study enrolled people ages 60 to 85 who were in early stages of Alzheimer's. Half received once-amonth infusions of donanemab and half dummy infusions for 18 months.

The results: Both groups declined during the 18-month study but overall those given donanemab worsened about 22% more slowly. Some patients fared better - those with low to medium tau levels saw a 35% slower decline, reflecting that the drug appears to work better in earlier stages of the disease.

How much difference does that make? It means donanemab slowed patients' worsening by about four to seven months, the JAMA report concluded.

Another way of measuring: Among the donanemab recipients with lower tau levels, 47% were considered stable a year into the study compared with

under the brand name Beyfortus, is a laboratory-made version of an antibody that helps the immune system fight off RSV. Under the FDA approval, babies - including preterm infants - can receive a single injection to protect against their first season of RSV, which typically lasts about five months. Children up to age 2 can receive another dose to protect them during their second season facing the virus.

Beyfortus, which will be marketed in the US by Sanofi, is already approved in Canada, Europe and the UK Sanofi did not immediately ment.

FDA officials approved the drug based on three studies showing Beyfortus reduced the risk of RSV infection between 70% and 75% among infants and children 2 and younger.
Advisers to the Centers for Dis-

ease Control and Prevention will meet early next month to recommend exactly who should get the drug.

The main safety concern is brain swelling or bleeding, which often causes no symptoms but sometimes can be serious, even fatal. About a quarter of donanemab recipients showed evidence of that swelling, and about 20% had microbleeds.

Scientists already know that patients getting any amyloid-targeted therapy need repeat brain scans to check for those side effects - a costly and timeconsuming hurdle.

Widera noted that the possibility of stopping donanemab treatment at least temporarily in people who respond well would help limit some of those challenges. For comparison, Leqembi is given by IV every two weeks and researchers didn't test a similar stop-

It's too soon to know if some patients might need to resume donanemab, said Lilly's Dr. Mark Mintun.

Dingoes attack woman: A pack of dingoes drove a woman who was jogging into the surf and attacked her in the latest clash between native dogs and humans on a popular Australian island, sparking new warnings Tuesday to visitors ventur-

ing out.
The 24-year-old woman was attacked by three or four dingoes on Monday while she was jogging on a beach at Queensland state's K'gari, the world's largest sand island formerly known as Fraser Island, officials said.

The World Heritage-listed national park is home to some of Australia's purest dingoes, which are also known by their Indigenous name wongari, because domestic dogs have long been banned. Tourists returned to the island after pandemic restrictions were lifted, and have found the dingoes have become less wary of humans. That's raised the danger to both species, wildlife ranger Linda Behrendorff said.

Two passersby rescued the woman from the dingoes after they chased her into the surf, using the same hunting technique they use for larger prey such as wallabies, Behrendorff said. (AP)

Stepping into that cauldron to face the Matildas on Thursday is Ireland, on debut at the World Cup and playing in its first major global tournament.

"We feel like underdogs and we embrace it," Ireland forward Marissa Sheva said. "I think it gives us a little bit of energy and we know the pressure is not on us, it's on them for this game. The match was initially scheduled for a smaller downtown

stadium but had to be switched to Stadium Australia, at Sydney Olympic Park, which is also the venue for the Aug. 20

"Ever since they moved stadiums we knew that it was going to be a massive crowd," Sheva said. "Having the opening game of the tournament against the hosts is an incredible

The hype around Sam Kerr and the Matildas has been growing Down Under as the countdown to the tournament

The Matildas beat France 1-0 in a friendly played in front of a record 50,629 fans in Melbourne last week

Australia is 10th in FIFA's rankings, and fans in the host country are confident the Matildas will advance to the knockout stages.

"We're ready and confident to give them a game," Sheva said. "They're in good form, but so are we."

WELLINGTON, Zealand, July 18, (AP): There could be some some surprises at the Women's World Cup.

Sure, the U.S. is still considered dominant, and those elite European teams have developed even more with the rise of competitive clubs. Then there's Brazil, which always seems on the

verge of a breakout. But an expanded field of 32 teams at the tournament starting Thursday in Australia and New Zealand means more players will see the international spotlight - and they no doubt want

to prove they belong. Consider Japan.

Back in 2011, Japan wasn't expected to make the semifinals, let alone the championship match. But the Japanese, reeling from the earthquake and tsunami that devastated their country earlier that year, rallied and beat the Americans on penalties after a 2-2 draw, and in the process became the first Asian team to win soccer's top prize.

That was the last Women's World Cup that wasn't won by the United States. The No. 1-ranked Americans aim to make it three in a row.

U.S. coach Vlatko Andonovski is well aware that other countries are catching up. He pointed to Zambia's exhibition victory over Germany in the run-up to the tournament.

"The top 10 have always been there. The world that is catching up is Wales, is Vietnam, is Zambia, Portugal. These are these are the countries that are catching up. The 7-0, 8-0 games are gone. And we can see that Germany plays against Zambia, loses 3-2. Those games are going to happen," Andonovski said. "And that's what we are preparing ourselves for, so we don't run into into a game like that with the mentality that it's gonna be easy. No game is gonna be easy. It doesn't matter who's in front of us."

Canada is considered among those top teams, particularly after winning the Olympic gold medal at Tokyo. But coach Bev Priestman suggested that growing parity means there are no givens.

Victoria state withdraws as host of the 2026 Commonwealth Games

MELBOURNE, Australia, July 18, (AP): Australia's Victoria state has withdrawn as host of the 2026 Commonwealth

Games because of a blowout in projected costs. Victoria Premier Daniel Andrews on Tuesday said his government last year agreed to host the next edition of the multi-sports event, "but not at any cost."

He said his government initially budgeted 2.6 billion Australian dollars (\$1.8 billion) to stage the Games in five regional cities but recent estimates put the potential cost as high as 7 billion Australian dollars (\$4.8 billion).

Andrews told a news conference he'd notified Commonwealth Games organizers of his government's decision to pull out of the hosting contract.

"Today is not about finding fault with those cost estimates," he said, declining to outline the reasons for the cost blowouts. "Frankly, AU\$6-AU\$7 billion for a 12-day sporting event, we are not doing that - that does not represent value for money, that is all costs and no benefit.'

The Commonwealth Games Federation issued a statement saying it was taking advice on its options

The CGF said the estimated cost escalation was mainly due to the regional, multi-city host model and the Victoria government's decision to change plans for venues and include more sports.

"We are disappointed that we were only given eight hours' notice and that no consideration was given to discussing the situation to jointly find solutions prior to this decision being reached by the government," the CGF statement said.

The 2026 Games had been scheduled for March 17-29 in the regional centers of Geelong, Bendigo, Ballarat, Gippsland and Shepparton.

The state government had promoted the multi-city model as a game changer, with the five regional centers hosting 20 sports and nine fully-integrated Para sports

The government's website had promoted Victoria 2026 as a showcase of "what makes the people of our state tick: our unity, our diversity, our sense of community, our welcoming attitude and our love of sport."

Commonwealth Games Australia chief executive Craig Phillips said the government's decision was a "comprehensive let down" on a concept it had pitched to organizers.
"The stated costs overrun, in our opinion, are a gross

exaggeration and not reflective of the operational costs presented to the Victoria 2026 organising committee board as recently as June," Phillips said in a statement. "Beyond this, the Victorian Government willfully ignored recommendations to move events to purpose-built (venues) in Melbourne and in fact remained wedded to proceeding with expensive temporary venues in regional Victoria.

It's the second time in as many editions there's been issues with hosting the Commonwealth Games.

Birmingham stepped in late to host the 2022 Games in England to replace Durban, South Africa.



Vingegaard closes in on Tour de France victory

Defending champ extends lead

COMBLOUX, France, July 18, (AP): Defending champion Jonas Vingegaard may have timetrialed his way to a second straight Tour de France victory.

A sensational time trial from Vingegaard on Tuesday saw the overall leader extend his advantage over two-time winner Tadej Pogacar to nearly two minutes with just five stages remaining - including Sunday's largely ceremonial, final procession to Paris.

Vingegaard, who rides for the Jumbo-Visma team, started the day only 10 seconds ahead of Pogacar after little could separate the duo in a fascinating duel over the last two weeks.

However, when it came down to a direct head-to-head battle, Vingegaard was in a class of his own.

The Danish cyclist finished the 22.4-kilometer (14-mile) hilly route from Passy to Combloux 1 minute, 38 seconds ahead of Pogacar. Wout van Aert was third at the end of the 16th stage, 2:51 behind Vingegaard.

The 26-year-old Vingegaard now leads Pogacar by 1:48 overall and it will take something equally sensational from the Slovenian cyclist to wrest the yellow jersey from his rival. Adam Yates moved into third overall, almost nine minutes behind

Riders face a mammoth mountain stage, the hardest of the race, on Wednesday. The last of four climbs of the 17th stage is a 28.4-kilometer (17.6-mile) slog up Col de la Loze, before sweeping downhill to the Courchevel ski station which hosts World Cup slalom races.


Tuesday's time trial had been seen as a potential tiebreaker but few could have imagined such a large gap.

Pogacar himself put in an impressive performance and flew through the first time check 26 seconds up

on the rest of the field. However, Vingegaard - who had rolled down the ramp last - was 16 seconds faster than Pogacar at that point, after just 7.1 kilometers, and had extended that to 30 seconds after 12 kilometers of racing.

Pogacar opted to change from his time-trial bike to a lightweight road bike at the foot of the second-category climb, with 5.3 kilometers remaining, and that helped him on the ascent. But he was unable to match an extraordinary ride from Vingegaard, who could almost see his rival on the approach to the finish line, such was his time gain.

Shakeel double hundred has Pakistan in command Truex wins at New Hampshire

GALLE, Sri Lanka, July 18, (AP): Saud Shakeel became the first Pakistan batter to make a double hundred in Sri Lanka as the visitors took control of the first test after making 461 on Tuesday.

Behind by 149 runs on the first innings, Sri Lanka reduced that to 135 when it was 14 for no loss by stumps on day three.

Shakeel was stranded on 208 not out, his second century in two tests, when Pakistan was all out after tea.

In six tests since his debut in December, he has scored a double hundred, a hundred and five half-centuries. He has a Bradmanesque average of 98.5.

Shakeel was the mainstay of Pakistan's innings by stitching valuable partnerships with the lower middle order and the tail after the top order

collapsed. At 101-5, a first-innings lead was the last thing on Pakistan's mind, but Shakeel added 177 runs with Agha Salman to rescue his side. The partnership was a record for Pakistan for the sixth wicket against Sri Lanka, improving on the 173-run stand between Sarfaraz Ahmed and Asad Shafiq in

Dubai in 2017. "When I went in to bat, I wanted to attack," Shakeel said. "If I had tried to be defensive we would have got bowled out for 150. That's the reason I attacked and was able to take the game deep.

"We have been working to play this kind of attacking cricket back in the camp at home. The coaching staff backed me. Pretty pleased with the ef-

Australia recall Hazlewood, retain for 4th Ashes Test

MANCHESTER, England, July 18, (AP): Australia fast bowler Josh Hazlewood will return to try and help them secure the Ashes series against England at Old Trafford this week with a match to spare.

Captain Pat Cummins also said on Tuesday the top five batters will remain but they were considering not playing rookie spinner Todd Murphy.

That could mean a recall of first-choice allrounder Cameron Green, who was fit after missing the third test at Headingley with a hamstring issue.

Mitch Marsh filled in for Green and hit a brilliant century to pose a selection headache for the selectors. Australia will confirm its side at the toss on Wednes-

day. Even after losing at Headingley by three wickets, Australia still leads the series 2-1. Scott Boland will make way for Hazlewood after tak-

ing no wickets in Leeds. Boland has only two wickets in the series from the opening win at Edgbaston. Hazlewood has eight wickets after also playing in the second win at Lord's. But he was rested from Heading-

ley to manage his workload. Retaining the top five means David Warner will continue opening. Warner is averaging 23.5 in six innings but has contributed to opening stands of 61, 73 and 63

with Usman Khawaja. "(Warner) has been going really well," Cummins said. "I thought at Lord's, he was really impressive. Last

week, like many of us, he probably didn't contribute as much as he would have liked with the bat.

"He's been out there over the last couple of days putting in a lot of work, but I think this tour he has shown a lot of good signs and hasn't quite kicked on to make that big score. Some of those innings he's played under really tough circumstances has made it easy for (Steve) Smith to come in and score runs, or

Australia has not gone into a test without a frontline slow bowler since January 2012 but with Nathan Lyon injured and Murphy considered more dispensable, it was considering a significant change to the balance of the side. Playing Green and Marsh will shore up the batting but diminish their options in the field. An all-seam attack will have to be complemented by Travis Head's

Murphy bowled only 9.3 overs for one wicket at Headingley

"It's all really conditions based," Cummins said. "I would have loved to bowl him a bit more but there wasn't a heap of overs in the game, the ball seemed to swing and seam a little bit, so that's certainly something to weigh up this week."

Only two overseas players - West Indies' Chris Gayle (333) and England's Joe Root (228) - have higher innings in Galle than Shakeel.

Mendis finished with a five-wicket haul, his fifth in 13 tests, while Prabath Jayasuriya claimed three wickets. Overall, the Sri Lanka bowlers struggled against the clever batsmanship of

Sri Lanka's openers faced 3.4 overs without trouble before bad light forced an early end to play. But they have a huge ask at their hands on day four.

"It's an important day in the test match," Sri Lanka coach Chris Silverwood said. "We have to come out and put our best foot forward.

"We continue with enthusiasm and serenity in a bid to achieve this goal," Estanguet said, adding that ticket sales have also been successful, with 6.8 million tickets already

The overall budget for the Paris Olympics, including the cost of building and renovating venues, is about 8 billion euros (\$8.2 billion).
