

Iran offers UN eyes details on 2 N-sites

DUBAI, July 26, (AP): Iran said Wednesday it gave new details to the United Nations about two sites near Tehran that inspectors say bore traces of man-made uranium, part of a wider probe as tensions remain high over the Islamic Republic's advancing program.

The comments by Mohammad Eslami, the head of Iran's civilian nuclear program, come as Iran's 2015 nuclear deal with world powers remains in tatters and as Tehran enriches uranium closer than ever to weapons-grade levels. Resolving questions from the International Atomic Energy Agency could see Iran avoid further censure as an October deadline approaches that would lift international restrictions on its ballistic missile program as well.

Speaking after a Cabinet meeting, Eslami said Iran had sent "detailed answers" to the International Atomic Energy Agency.

"If those answers are not accepted and there are any ambiguities or doubts, as we have always said, we will clarify and revise the documents," Eslami said in comments carried by state television. "We are now in that phase now, and we have given the IAEA more evidence and documents and will give more so that it can move past this issue."

KUWAIT CITY, July 26, (KUNA): The Ministry of Finance announced on Wednesday recording a surplus in the State final account amounting to KD 6.4 billion (USD 20.8 billion) in the fiscal year 2022-2023, vis a vis actual deficit of KD 4.3 billion (USD 14 billion) in the previous fiscal year.

The Ministry of Finance said in a press release that actual revenues reached KD 28.8 billion (USD 93.8 billion), rising by 54.7 percent, in the fiscal year 2022-2023, noting that oil proceeds stood at 92.7 percent of the achieved income.

Actual oil revenues amounted to KD 26.7 billion (USD 87 billion), rising by 64.7 percent, while actual non-oil proceeds reached KD 2.1 billion (USD 6.8 billion), falling by 12.8 percent.

Total actual expenditures reached KD 22.4 billion (USD 73 billion), with a fall of 2.6 percent, the press release said, also noting that the budget saving was estimated at KD 1.1 billion (USD 3.5 billion) as compared to projections of the budget for the fiscal year 2022-2023.

Average oil price was recorded at USD 97.1 per barrel, rising by 21.4 percent, while daily output of the crude reached 2.693 million barrels a day.

Payments and subsidies constituted 78 percent of the whole expenditures and actual capital spending reached nine percent of the total expenditures.

The press release quoted Deputy Prime Minister, Minister of Oil and Minister of State for Economic Affairs and Investments and the Acting Minister of Finance, Dr. Saad Al-Barrak, as saying Kuwait enjoys a solid financial status, huge reserves and monetary and financial stability.

These factors solidify the State vis a vis oil market's jitters in the short term "and enable us to rise above the interim challenges and seize opportunities emanating from these challenges," the minister said.

The government is fully ready to discuss the final account with the legislative authority, he said, expressing gratitude to the cabinet for supporting the ministry of finance and the State financial apparatus.

O leadership ... end the plunder of public wealth

ALMOST everyone is certain that the country is being plundered. Therefore, firm measures must be taken to stop the depletion of national wealth, and start an earthquake that would topple all those who worked and are still working to milk Kuwait either through major projects, or arms deals, or even services, and various other ways and means for tampering with the public money.

Yes, there are good intentions, but they cannot be relied upon if they are not interpreted by holding the seniors accountable before the juniors, because time passes and does not wait for anyone.

Therefore, the statements issued by more than one party stay as words until they go hand-in-hand with actions. These statements can be from the Deputy Prime Minister, Minister of Defense Sheikh Ahmed Al-Fahad, who put his finger on the wound and pulled the pus out of it, or the statements of other officials regarding the reform that was expected for several governments but it passed in the history of Kuwait, and nothing was done with regard to its slogans for the advancement of the country.

If the arms deals and warplanes once represented the wonders of wonders, the same saying also applies to other major projects, but with the difference that none of the corrupt went to prison, and the looted money was not recovered. This is a serious indication that accountability is optional.

What the Ministry of Defense was subjected to previously affected the Ministry of Interior, the Ministry of Public Works, the Ministry of Commerce and Industry, the Ministry of Health, the Ministry of Education, Kuwait Municipality, and other ministries and institutions.

This situation is not healthy at all, as corruption has affected all institutions, causing them to suffer from great paralysis.

That is why it is important to follow the closure of the shops of public relations companies and representative offices in Switzerland and other countries, which award tenders through a game that has become exposed.

A tender, or rather a project, which is worth about KD 300 million is sold at a hundred and fifty million to foreign companies that have to pay fees and guarantees, and secure employment and implementation that does not exist. It will be in accordance with the conditions set in the tender book, and then the journey of executive orders and corruption in the specifications begins.

Well, there is a proposal to cancel the concept of local agent, but according to the data, it will not be on the agenda of the National Assembly in the near future.

This is because the parliamentary priorities differed under the pressure of the desires of the influential, so proposals were submitted that could be postponed, while other important ones were delayed.

That is why it is expected that the systematic looting will continue, and by law, until time comes to pass.

In neighboring countries, all this tampering was stopped by order of the state's leadership, the countries recovered huge sums of money, and the projects were implemented on time. There were no longer arms deals that were more like "Ali Baba's Adventure and the Hundred Thieves," and most of them were influential, sheikhs and princes.

In all of this, the government can agree with foreign companies and factories directly with regard to weapons, equipment and supplies of all security services, as well as through the "B.O.T" (Build-Operate-Transfer) system, and within a period to be agreed upon, whether in housing cities, major projects such as the metro and railway, the development of islands, or the Silk City, and others, while the role of the state is supervision and follow-up.

In all of this, there must be a decision and determination to implement it. An official should not fall under any pressure from an influential person, even if it is an MP or a minister.

The interest of Kuwait and the continuity of its wealth and development are much more important than people, because future generations will hold the present generations accountable for everything they have done. History is a merciless judge.

Government keen to support co-op sector

MPs amend Constitutional Court provisions

KUWAIT CITY, July 26, (KUNA): Kuwait's National Assembly Wednesday agreed on amending some provisions of the Law No. 14 of 1973 on establishing the constitutional court.

The amendments, winning 58 votes against one, stipulate that in "all cases the constitutional court may not consider the decrees on dissolving the National Assembly and the call for elections after the result is declared.

The court, however, would rule on appeals regarding the MPs election within 30 days after the end of the plea period, according to the amendments.

The modifications also immunize the National Assembly after the voting process and organize the appeals' time and rule on the two decrees: dissolving the parliament and the call for election separately.

Earlier in the day, Minister of Justice and Minister of State for Housing Affairs Faleh Al-Rguba said the Kuwaiti government supports amendments.

During a regular National Assembly session, the minister lauded efforts of the head and members of the parliamentary legal and legislative affairs committee in preparing its report on this matter.

This amendment may end the measures and appeals submitted over the last years, he said.

In other news, the Constitutional Court on Wednesday overruled all appeals presented against the National Assembly elections in 2023 held on June 6.

The tribunal had set July 26 as the date to rule in the case of the nine challenges against the elections. Meanwhile, National Assembly Speaker Ahmad Al-Sadoun started on Wednesday, the Parliament's complementary session to look into the day's agenda.

The Parliament will continue discussing the Amiri Decree in the first regular session of the 17th legislative term (2023-2027).

MPs kicked off today's agenda by asking for dedicating two hours to discuss the "strategic alternative," control of the increase in product prices, as well as the criteria in appointments of senior positions.

Other topics on the table include forming interim committees regarding solutions for problems suffered by the population in Sabah Al-Ahmad, Al-Wafra, Ali Sabah Al-Salem and Al-Khairan, as well as cybersecurity and artificial intelligence.

The National Assembly during its Wednesday's follow-up session agreed to refer the Amiri Address that marked inauguration of the first regular session of the 17th legislative term to the parliamentary Amiri Speech commission

The referred Amiri Address included MPs remarks. Its submission is a prelude to presenting a report in this respect to the assembly.

The Amiri Address marked the inauguration on June 20.

Minister of Social, Family and Childhood Affairs, Sheikh Feras Al-Sabah, highlighted Wednesday the government's keenness on supporting the cooperative sector in the country.

The Minister, while speaking during the complementary session, affirmed the social affairs ministry's full cooperation with the parliament members to further develop this sector.

Diverse economy sought

Kuwait SMEs fund urges more cooperation


KUWAIT CITY, July 26, (KUNA): Kuwait's National Fund for Small and Medium Enterprises (SMEs) on Wednesday called for greater cooperation between state bodies and non-governmental organizations (NGOs) alike, saying it would be instrumental in supporting aspiring entrepreneurs.

State support for SMEs ranges from funding these endeavors to advisory aid, the fund's chief Adel Al-Hasawi said amid a signing ceremony to clinch a deal with the Federation of Kuwaiti Professionals and Business Associates for Small and Medium Enterprises (BPW), most of whom

were hit hard by the ramifications of the COVID pandemic.

SMEs form an integral component of the national economy's growth and development, he underlined, saying it would help create a "multidimensional and diverse" economy that would place on the nation firmly on the road towards prosperity.

Echoing his sentiments, BPW chief Sheikhha Hessa Al-Sabah emphasized that the body fully backs owners of SMEs and would-be entrepreneurs, helping translate their ambitions into national success stories.

This document is a summary of the draft FY22/23 Closing Accounts, approved by the Cabinet and submitted to Parliament for ratification.

KUWAIT CITY, July 26: The Kuwait Ministry of Finance today announced the State of Kuwait’s closing accounts for the fiscal year ending March 31, 2023. The State’s accounts recorded KD28.8 billion in revenue, KD22.4 billion in expenditure, and closed with a fiscal surplus of KD6.4 billion.

The State of Kuwait’s fiscal year starts on April 1st and ends on March 31st. (By law, the Closing Accounts do not include revenue from the Future Generations Fund (FGF, also known as the Kuwait Sovereign Wealth Fund), which is managed by the Kuwait Investment Authority. All investment gains from FGF activities are re-invested into the FGF as mandated by its governing law.)

H.E. the Deputy Prime Minister, Minister of Oil, Minister of State for Economic Affairs and Investment, and Minister of Finance (Acting) H.E. Saad H. Al-Barrak said:

“The State’s accounts have experienced a healthy recovery in terms of liquidity, driven mostly by rebounding crude oil prices during the fiscal year and aided by controlled expenditure. Today, Kuwait has one of the strongest sovereign balance sheets in the world, with one of lowest sovereign debt to GDP levels globally, and a

strong rebounding economy”.

'Social media reports on high temp unreliable'

Kuwait temp to peak last week July, first week August: Dr. Dashti

KUWAIT CITY, July 26: Head of the Meteorology Department at the Directorate General for Civil Aviation (DGCA) Dr. Hassan Dashti says, "The temperatures in Kuwait will hit the peak during the last week of July and continue until the first week of August. July is usually the hottest month in Kuwait and the rest of the world," reports Al-Rai daily.

Regarding the video being circulated about the temperatures exceeding 56 degrees Celsius, Dashti said in a press statement that, "This method of measuring temperatures is not reliable, and does not reflect the official temperatures that have conditions and specifications for their measurement. Measuring temperatures in such an unapproved and non-conforming way may make us record degrees such as 60, 70, or even 80."

Commenting on the heat waves that affected Europe, Dashti stated that, "Europe is affected by the heat dome due to the atmospheric heights that cause heat waves. Temperature that reaches, for example, 35 degrees Celsius is felt as if it is

45 degree Celsius, due to the high degree of humidity and the descent of hot air currents."

Regarding his explanation for the high temperatures this year, Dashti explained that, "The matter is due in part to global warming, in addition to the El Niño phenomenon (a climatic pattern affecting the Pacific Ocean), which usually lasts from two to seven years, and may make the next year hotter than the current one."

He said, "There are general tips that must be adhered to in the event of high temperatures, including avoiding direct exposure to sunlight, especially for those who suffer from health problems, and drinking plenty of water."

In the same context, meteorologist Issa Ramadan affirmed that people's reading of temperatures in their cars, on the street, or in buildings is scientifically inaccurate and incorrect.

He said, "In all countries of the world, it is well known that temperatures are the temperature of the air, not the bodies. If the air temperature reaches 60 degrees Celsius, I do not think we can afford to go out into the streets."

In addition, Head of the Kuwaiti Astronomical Society and Astronomer Adel Al-Saadoun, said, "Temperatures can reach 60, 70 and 80 degrees Celsius under the sun."

Huge spike in expat licenses

Minister acts to curb fraud, forgery

KUWAIT CITY, July 26: According to the Head of the Kuwait Society for Traffic Safety, Bader Al-Matar, the decision of the First Deputy Prime Minister and Minister of Interior Sheikh Talal Al-Khaled to use the driving license and the vehicle registration on the "My Identity" application in all transactions is considered an important step to detect fraud and forgery, as there has been a terrifying increase in the number of those who obtained driving licenses in Kuwait, reports Al-Rai daily.

In a press statement, Al-Matar affirmed that Sheikh Talal Al-Khaled's decision contributes to limiting the unjustified increase in the number of driving licenses, which has negatively affected the traffic situation in Kuwait globally.

Increase

He indicated that the terrifying increase in the number of those who obtained driving licenses, some of which do not commensurate with the size of the need granted to him or those who were not entitled to it, is not hidden from anyone.

Al-Matar highlighted the importance of continuing the campaigns carried out by the Ministry of Interior's General Traffic Department in line with the ministerial decision to prosecute violators who drive vehicles despite the suspension of their licenses for violating the law, and those who obtained them fraudulently.

He revealed that there are more than one and a half million driving licenses, which are not in line with the population, stressing that the increase in driving licenses for expatriates more than citizens has caused confusion on the road network, which confirms that the application of this procedure is heading towards the right path to limit the imposed increase in the number of unjustified driving licenses and thus reduce traffic congestion.

Call for independent election commission

KUWAIT CITY, July 26: The Chairperson of Kuwait Transparency Society (KTS) Majed Al-Mutairi says, "Amending the election laws and electoral constituencies, and approving the appointment law for leadership positions is the necessary base for establishing an independent election commission. This commission must be managed by specialists with knowledge of international experiences and the required international standards. This requirement can be in line with some government agencies, including the Ministry of Foreign Affairs", reports Al-Rai daily.

In a press statement, Al-Mutairi said, "The assembly has a written vision about the proposed amendment of the election law. We presented it to the Council of Ministers, and we are in the process of presenting it to the National Assembly. We contacted the National Assembly about the need for the Kuwait Transparency Society's meeting with the Legislative Committee prior to its issuance.

We want this body to be empowered. The head of the commission cannot be creative in light of the existence of an election law that has many flaws. It did not cover many issues such as electoral propaganda, cyberspace, and electoral rumors. It also has many loopholes, which must be amended before establishment of the commission.

Approved

The second important law to be approved is the electoral constituency law and the voting system. We have problems in the distribution of constituencies and the voting system. There is almost unanimity on the unfair distribution of electoral constituencies and the voting system. The approval of the leadership appointment law guarantees the independence and impartiality of the commission before its creation.

The approval of the Election Commission will raise Kuwait's level in international indicators, since this commission is the real gateway to democratic reform.

The Independent Electoral Commission cannot work in isolation from the civil society sector or the private sector. The Tunisian experience in this regard is worth contemplating and studying."

Regarding the role of the commission after the elections, Al-Mutairi stated that, "Its role after the elections is to raise awareness and educate. All Arab countries have an independent commission for elections in accordance with international standards, except for Kuwait."

In response to a question about whether the commission requires a large number of employees, he said, "The Independent Electoral Commission in the Netherlands has only 12 employees and everything is done through electronic communication. In many countries of the world, the commission is the one that sets standards and is responsible for municipal and cooperative elections."

Al-Mutairi said he is expecting the approval of the Election Commission before August, adding, "I hope that it will not be born dead, and it will emulate international standards. We have an excellent experience, which is the Capital Markets Authority, which enjoys complete independence. I hope to benefit from its experience."

'Accurate, reliable info provided'

'27 weather stations in country'

KUWAIT CITY, July 26, (KUNA): Although Kuwait is one of the countries that witnesses the most noticeable rise in temperatures, even exceeding the 50-degree mark in the Jahra station, the forecasts for these days as well as the upcoming days remain open for other regions.

In an interview with KUNA Wednesday, climate observer at the Meteorology Department of the Directorate General of Civil Aviation (DGCA) Dr. Hassan Dashti said that the department is keen to provide all accurate and reliable information on weather conditions and temperatures with internationally accredited scientific measuring devices through 27 land and sea surface monitoring stations in various regions of the country.

These stations measure temperatures

transparently and in a scientific way, according to the standards approved by the World Meteorological Organization (WMO), and through monitoring stations that are followed up 24 hours a day, monitoring their readings and analyzing them using advanced computers in a scientific way, Dashti added.

He pointed out the administration's keenness to provide all accurate and reliable information and data on weather phenomena and its elements such as temperatures, atmospheric pressure, wind speeds and direction, and rainfall amounts through internationally accredited scientific measurement devices through these stations, noting that all these centers and stations are subject to international standards that must be met so that the desired degree can be calculated and based on it.

IICO not devoid of corruption

The International Islamic Charitable Organization (IICO) is one of the largest organizations working in the humanitarian field in the Islamic world, and it is an independent organization. Its website says that it provides its services and assistance without discrimination or intolerance, away from interference in politics or ethnic conflicts, and this is not entirely accurate.

The establishment of the commission dates back to 1984, and had it not been for the support of Sheikh Jaber Al-Ahmad, it would not have seen the light, and attributing credit to others is also incorrect.

Although it was the Kuwaiti National Assembly that approved the authority's law, it was lax, as it reduced supervision over it to the lowest levels, and therefore its biography was not devoid of administrative corruption, theft of its property by some members of its board of directors, and the issuance of prison sentences against them, and against employees working for it!

In the end, the authority is a charity organization that owns a lot of money, and it is run by someone who represents the State of Kuwait. The rest of the members of its board of directors, who belong to several countries, have no choice but to attend a few of its meetings, and Kuwait is the most generous with it!

Due to the loss of prior or immediate control over its work, the greed of some of those in charge of it, and its recent endeavor to collect the largest possible collection of donations, despite its great wealth, it was not difficult recently for representatives of the Department of Charitable Societies and Foundations, in the Ministry of Social Affairs, to monitor the establishment of the International Islamic Charitable Organization by publishing fundraising advertisements on its official website and various social media, without submitting an official request from the Ministry, nor obtain-

ing its prior approval before publishing, the last of which was announcing the collection of donations for the benefit of the "urgent relief for Jenin camp - Palestine" project.

According to the Social Affairs sources such advertisements are considered an explicit violation of the laws, decisions, controls and requirements for regulating charity work in the country, as individuals or groups may not collect donations from the public by any means for the purpose of spending them, or helping the afflicted, except after obtaining a prior license from the Ministry, at least one month before the start of the collection campaign, provided that the duration, method and purpose of the collection are determined by the project organizer.

It was stated by the Ministry of Social Affairs that it will take the necessary and speedy legal measures against unauthorized individuals or entities, who announce the collection of donations, or launch charity projects without its prior approval, and away from the eyes and oversight of the state, in order to preserve charitable work, and to ensure that it is not exposed to any impunity.

The ministry had also warned, and it is well known who you mean, that some are taking advantage of the instinct of Kuwaiti society and its love for helping the needy to reach private goals that are completely far from charity work. Therefore, we urge donors, citizens and residents, to be careful when donating, not to succumb to such invitations, and to direct their donations to well-known parties in the country, especially since these funds may fall into the hands of those who misuse them and distort Kuwaiti charity work!

I am really baffled by this association that is full of money, and which operates with absolute freedom, especially outside Kuwait, without any "actual" control over its activities, and the "temptations" that this activity usually includes. There is an authority that monitors its work, as even some of the ministries concerned with the matter, which have been entrusted with the task of monitoring the bodies, may themselves need, before others, someone to monitor their work!



KUWAIT CITY, July 26: In an effort to promote data transmission and internet infrastructure investment, the Communications and Information Technology Regulatory Authority (CITRA) has initiated a pathway for international companies specialized in communications and the internet to obtain administrative licenses for establishing undersea or land cables in the country, reports Al-Qabas daily.

According to a document, a copy of which has been obtained by the daily, the authority outlined that cable landing points in the country would be granted through administrative licensing contracts between CITRA and the licensee, adhering to all relevant laws and conditions governing the establishment of sea or land cable points.

Commitment

CITRA emphasized its commitment to fostering investment in capacities and international landing stations. The introduction of multiple international cables and stations connected within the country is expected to significantly enhance data volume and local network connectivity to the internet and global networks.

Addressing the needs of the local market, CITRA stressed the importance of expanding Kuwait's capacity to connect with the world, facilitating the exchange of communication traffic and seamless data transfer through main exits via land and sea fiber optic cables.

Sources revealed to Al-Qabas that due to technical issues, two licenses to establish, operate, and manage international access structures – one on land and the other at sea – were canceled. However, CITRA is now proposing the establishment of a new international communications access structure through the implementation of both marine and land cables, following the specific requirements outlined in the administrative license document concerning the landing of sea or land cable points.

Presently, Kuwait is connected to two marine cables that facilitate international communications traffic. Unfortunately, one of these cables is damaged and ineffective due to its age, while the country also relies on three other land cables.

For companies seeking an administrative license to establish cables in Kuwait, CITRA has defined five essential requirements – a clear plan for the company's participation and involvement in the country's telecommunications market; market forecasts covering the first five years of operation, including proposed services and associated pricing; a comprehensive plan for customer care, after-sales support services, and service levels; a continuous service quality improvement plan and submission of a detailed technical proposal, encompassing engineering descriptions and an annual maintenance plan.

Huawei makes offer

Kuwait intends to exploit sovereign cloud services

KUWAIT CITY, July 26: Informed sources confirmed Kuwait's intention to benefit from the technologies of sovereign cloud services designed on advanced security bases to protect data, in agreement with the Chinese company Huawei, reports Al-Qabas daily.

On the sidelines of a recent tour of a number of Kuwaiti media outlets at the headquarters of the giant Chinese company, and its main exhibition in Beijing, the sources explained that this trend comes in line with the Kuwaiti government's endeavor to complete its plans aimed at digital transformation in government agencies in all its sectors and data protection according to strict principles and standards.

Sovereign cloud services will give these government agencies greater ability to control and preserve their data and the data of their customers, and meet the highest standards of information security. Huawei made an offer, and hopes to reach an agreement regarding it with Kuwait, especially since the company has a deeper understanding of Kuwaiti needs in this regard than its competitors.

These modern technologies include providing practical solutions for cloud storage and other services in artificial intelligence.

The sources stressed the company's aspiration to implement this huge strategic project, affirming that the company believes it has high chances of reaching an agreement on it with Kuwait.

Meanwhile, the sources revealed that Huawei has formed a team that is currently working on completing a project to provide the new Kuwait Airport Terminal "T2" with the required technological networks and means.

In its statement, the company explained that talks in this regard are ongoing and on the verge of conclusion. It referred to a number of other projects that the company is working on implementing in Kuwait with various entities, including the Ministry of Interior, the National Guard and the Ministry of Health. The sources said Huawei is working

World Aquatics 're-elects' Al-Musallam as President

KUWAIT CITY, July 26, (KUNA): The World Aquatics organization re-elected Hussain Al-Musallam of Kuwait as its president to a new eight-year term during its General Congress in the Japanese city of Fukuoka Tuesday.

"I feel very proud and also very humbled that you have shown your confidence in me to continue leading you as your President," Al-Musallam said following his unopposed election. "It has been the privilege of my life to serve as the President for the past two years."

He pointed that he had worked as hard as he can to serve the organizations and athletes.

The World Aquatics organizations elected Al-Musallam to four-year term during its General Congress in Doha in 2021, to be the first-ever president of the global organization from Asia.

Though Al-Musallam's original 4-year term has not expired, a new election was held after the approval of a new constitution.

Under the new constitution, he will still be allowed the 4-year re-election term at the end of his eight years.

Center boasts of a dedicated medical team that handles dermatological consultations

KUWAIT CITY, July 26: The Asaad Al-Hamad Center receives approximately 74,300 patients across various general and specialized departments, making it a significant referral destination for dermatology cases. Dr. Atfal Al-Lafi, the head of the dermatology department, shared this information with Al-Qabas daily, emphasizing the center's commitment to providing excellent medical care.

The center boasts a dedicated medical team that handles dermatological consultations for 21 centers and hospitals in the Al-Sabah region daily.

Dr. Al-Lafi mentioned that the Ministry of Health continuously introduces advanced treatments for skin diseases, while the medical staff educates patients and their families on disease management.

Chronic skin conditions make up 3 to 5% of the total population, with around 30% of cases at the center requiring periodic follow-up for conditions like psoriasis, bullous diseases, eczema, hidradenitis suppurativa, and vitiligo.

During the summer, certain skin diseases become more prevalent due to increased outdoor activities and swimming in public pools and the sea. Conditions like sunburn, fungal infections, skin exfoliation, rosacea, viral warts, and molluscum contagiosum require treatment and preventive measures to avoid recurrence.

The Asaad Al-Hamad Center specializes in diagnosing stubborn skin cases using the latest methods. In the future, the center plans to expand collaboration with other medical specialties like rheumatology, pediatrics, dentistry, plastic surgery, and gastroenterology, aiming to offer high-quality multidisciplinary medical services under one roof.

The center is well-equipped with outpatient and specialized clinics, phototherapy and skin correction units, and high-accuracy laboratory services, including immunology, fungi, biochemistry tests, and contact sensitivity assessments using a patch.

Dr. Atfal Al-Lafi mentioned that the center holds extensive and periodic scientific meetings every three months, where dermatologists from the Ministry of Health and the private sector gather to review and discuss difficult and rare cases.

The center's pharmacy is fully stocked with medicines for skin diseases, including some that are available in Kuwait before other developed countries.

Established in 1996 with a generous donation from the late Khaled Al-Hamad and inaugurated under the auspices of former Minister of Health Dr. Abdul Rahman Al-Muhailan on Sept 30, 1996, the Asaad Al-Hamad Center provides diagnostic and treatment services for referred skin patients from all regions through its outpatient clinics.

The Vienna-based IAEA did not immediately respond to a request for comment from The Associated Press. However, Eslami's comments mark a change in tone as Iran has limited inspections, held surveillance footage and taken years to respond to the IAEA after then-President Donald Trump unilaterally withdrew the United States from the nuclear deal in 2018.

Eslami did not name the sites, though the IAEA has identified them as Turqubad and Varamin just outside of Tehran. At Varamin, the IAEA in a March report said that inspectors believe Iran used the site from 1999 until 2003 as a pilot project to process uranium ore and convert it into a gas form, which then can be enriched through spinning in a centrifuge. The IAEA said buildings at the site had been demolished in 2004.

Tehran insists its program is peaceful, though the West and the IAEA say Iran had an organized military nuclear program until 2003.

Turqubad is where the IAEA believes Iran took some of the material at Varamin amid the demolition, though it said that alone cannot "explain the presence of the multiple types of isotopically altered particles" found there.

In 2018, the site became known publicly after Israeli Prime Minister Benjamin Netanyahu revealed it at the United Nations and called it a clandestine nuclear warehouse hidden at a rug-cleaning plant. Iran denied that, though IAEA inspectors later found the man-made uranium particles there.

‘Focus attention on genuine issues, not on plastic surgeries & tattoos’

“These ungrounded proposals, which lack scientific rigor and long-term planning, lead to the depletion of budgets on unnecessary expenditures, solely aimed at gaining popularity and applause from certain factions. Consequently, it becomes difficult to retract the unwarranted financial favors once bestowed, as individuals grow accustomed to increased expenses and luxuries.

“The expansion of the “Afa Insurance” system to include individuals, who never contributed during their working years, and the generous ration card offerings from essential foods to luxurious delicacies, raise concerns about fairness and accountability.

“Similarly, providing salaries to women who choose not to work may be applauded by some, but it disregards the efforts of hardworking women who balance their careers with familial responsibilities and have earned their wages.

“Deputies who focus on extravagant spending under the “Is there any more?” principle receive praise, while those with a genuine long-term vision for the nation’s future, who prioritize the welfare of the people, are unjustly accused of neglecting citizens’ interests. The idea of saving for the future and being fiscally responsible seems overshadowed by the allure of immediate gifts and expenditures.

“Some deputies promote proposals unrelated to urgent issues, such as plastic surgery and book censorship, diverting attention from the genuine concerns of the Kuwaiti people about their grandchildren’s and future generations’ prospects.

“The citizens of Kuwait are responsible, educated, and capable of making their own choices without unnecessary interference.

“It is heartening to see certain deputies firmly rejecting such proposals as they represent a departure from intellectual and cultural integrity. However, silence from others on these matters raises doubts about their commitment to genuine progress.

“Civil society institutions, including the Kuwait Writers’ Association and the Kuwait Economic Society, should unite in their opposition to such proposals to prevent their revival through our silence. Emphasis should be placed on education and intellectual growth to empower society to handle the challenges of absolute freedoms, rather than imposing restrictions on tattoos and plastic surgeries.

“In conclusion, it is disheartening to witness some deputies prioritize superficial matters over the nation’s pressing issues. While the future of our homeland remains uncertain, we must focus on real solutions and foster an intellectually resilient society, capable of facing the realities of an open and uncontrolled media space. The pursuit of short-term gains and neglecting our nation’s long-term welfare is indeed a cause for concern.”

“As per international agreements, state sovereignty is recognized as an inherent right for independent and internationally recognized states,” columnist **Alia Faisal Al-Khaled** wrote for **Al-Anba** daily.

“This means that a state has the right to safeguard its security, territory, people, and governing system. Kuwait, like other countries, has the right to protect its sovereignty and take necessary actions to achieve this objective.

“However, the current situation seems to indicate a different reality, where individuals who do not genuinely deserve nationality are challenging the state and its institutions. They do so either under the pretext of rights or by accusing state institutions of manipulation and forgery. Some even threaten the state by submitting complaints to international organizations.

“The state’s failure to uphold its role in preserving sovereignty and yielding to baseless demands poses a significant threat to its system and continuity. The Central Apparatus for Resolving the Status of Illegal Residents possesses evidence that discredits the claims of many individuals who are attacking the state and its sovereignty.

“What is astonishing is the officials’ reluctance to make decisive and stringent decisions to resolve this issue, despite being aware that some of these claim-

ants have ulterior motives and may be working for foreign agendas.

“This situation is unique and has not been witnessed in other countries. No other nation gives up its sovereignty under the guise of vague and ambiguous terms such as civil rights, human rights, racism, discrimination, and others.

“These terms are framed by international agreements. Throughout its history, Kuwait has been built on coexistence and brotherhood and is innocent of these accusations. The underlying motives behind these fabrications are likely unrelated to any of these false allegations.

“Today, it is imperative for the government to take serious and decisive actions to address the issue of illegal residents and resolve the longstanding problem of illegal citizenship. Continuing to remain silent and procrastinating will only exacerbate the complexity of the matter and pose a greater threat to the state and its future.”

Today, I would rather look at the positive side. Nevertheless, the negative aspects will hold us back unless the program is amended,” columnist **Asrar Jawhar Hayat** wrote for **Al-Qabas** daily.

“The government included an ambitious cybersecurity project in its program. We hope this will continue within the normal period of four years. The program is under the axis of a productive government project entitled, ‘Launch the Comprehensive Cybersecurity System’. This is part of the strategies of the National Center for Cybersecurity and it is scheduled for launching in the first year of the lifespan of the program.

“Here, I take the opportunity to salute the government for having thought of this project and including it in the work program. Despite our position on it — ignoring other important projects like landscaping for example, the existence of a comprehensive system for cybersecurity is one of the long overdue priorities of the country.

“According to the program, this step comes with a number of digitization and automation projects in government agencies.

“Although we applaud the government’s launching of this project, we have to give it advice. Perhaps, the first and most important advice is to launch the system only after covering all the vital aspects of cybersecurity, especially since we recently sensed the government’s desire to quickly announce the project while neglecting several aspects — the same manner it announced its program.

“This kind of security system needs experts and a strong and solid information structure. This system is related to information security and it is not less important than national security. It is rather part of national security, especially after we witnessed numerous breaches of our databases, which were then sold in the black market.

“We are still suffering the consequences of receiving messages that allegedly came from government agencies. Undoubtedly, this requires us to build an integrated system that is robust, impenetrable, strong and secure.”

Early preparation for next Hajj season vital: Ministry of Awqaf

‘Number of mechanisms to be adopted’

KUWAIT CITY, July 26: The Ministry of Awqaf, represented by the Department of Hajj and Umrah Affairs, circulated to approved Hajj expeditions the need for early preparation for the next Hajj season, based on recommendations from the concerned Saudi authorities, reports **Al-Qabas** daily.

According to reliable sources, a number of mechanisms and procedures will be adopted, most notably the completion of housing contracts and holy sites on February 25. The issuance of Hajj visas will begin on March 1. The electronic track and the issuance of visas will be closed on April 29. The arrival of pilgrims to the holy land will begin on May 9. Electronic registration through the designated platform will open on September 1 for a period of two months.

The sorting process will be according to three proposals, which will be submitted to the Higher Committee for Hajj to approve one of them. Priority will be given to those who have not performed Hajj previously.

- The three proposals are:
- The first proposal - according to the lottery system.
 - The second proposal - according to the age ratios, which are -
 - From the age of 50 years and over - by 25 percent of the 8,000 pilgrims
 - From the age of 30 to 49 years - by 50 percent
 - From the age of 18 to 30 years - by 25 percent.
 - The third proposal - according to the oldest.

Another proposal will be presented to the Higher Committee for Hajj, which is to divide the campaigns into three categories, namely:

1. The golden category - five percent of the pilgrims, as it will be required to provide five-star services, most notably modern cars of no less than 2024 model, and hotels overlooking the Haram and close to the central area, in addition to all VIP services.
2. The silver category - it is obligated to provide services such as housing near the sanctuary and not overlooking it, or in the central area, and cars of no less than 2021 model to pilgrims of this category.

3. The bronze category - it is obligated to provide four-star services only. The sources stressed that the Ministry of Religious Endowments will

That's partly because searching on variations of the term "text post" largely turned up examples of a popular video genre - those focused on text message phone conversations, typically selected for humorous effect. There were also a few brave users offering video explanations on how to make text posts. (AP)

EU adopts three regulations to reduce energy consumption

The European Union Council Tuesday adopted three regulations to reduce energy consumption and promote alternative energy sources.

Firstly, it adopted new rules to reduce final energy consumption at EU level by 11.7 percent in 2030.

EU Member states will collectively ensure a reduction of final energy consumption of at least 11.7 pct in 2030, compared with the energy consumption forecasts for 2030 made in 2020.

This translates into an upper limit to the EU's final energy consumption of 763 million tons of oil equivalent and of 993 million tons of oil equivalent for primary consumption, said a Council statement.

Secondly, more recharging and refueling stations for alternative fuels will be deployed in the coming years across Europe enabling the transport sector to significantly reduce its carbon footprint following today's adoption on the alternative fuel infrastructure regulation.

From 2025 onwards, fast recharging stations of at least 150kW for cars and vans need to be installed every 60 km along the EU's main transport corridors, the so-called 'trans-European transport (TEN-T) network'.

Maritime ports welcoming a minimum number of large passenger vessels, or container vessels, must provide shore-side electricity for such vessels by 2030. (AP)

Employment held up well in 1Q23

Softer real estate and credit data point to easing economic activity

Economic activity showed signs of further moderation in 2Q23 amid the higher interest rate environment, global uncertainties, and oil production cuts. Household and business credit growth remained weak, while real estate sales stayed on a downward trajectory. Oil production also declined during the quarter with the introduction of voluntary output cuts in May to halt sliding oil prices (which showed signs of working as prices rose in July). On a brighter note, although project awards eased in 2Q23, affected by seasonal factors, they remained above 2022 levels, while employment in 1Q23 was still rising at a fairly solid pace. On the policy front, following the election of a new parliament in June, the new government sent its 2023-27 work plan to the legislature for review. It includes five main pillars covering the economy, jobs, welfare and governance through measures to develop key sectors, boost productivity including in the public sector, address the housing shortage and put the public finances on a sustainable path. Meanwhile, as of mid-July/ the government,s expansionary draft budget for FY23/24 was yet to be signed off by parliament.

Oil prices pressured lower on global recession fears

Oil prices retreated during 2Q23 amid intensifying global recession concerns. Tighter global monetary policy to combat inflation, uninspiring Chinese economic metrics and ample crude stock cover amid resilient Russian supply all combined to push market sentiment in a more bearish direction during the quarter. Having traded sideways through June, Brent crude closed the quarter down 6.1% q/q to \$74.9/bbl (-12.8% ytd). (Chart 1.) Local marker Kuwait Export Crude fared better, maintaining a premium over Brent during the quarter, dropping by 1.9% q/q to end 2Q23 at \$77.8/bbl (-5.1% ytd). With prices heading south through 2Q23 and OECD crude stocks not drawing down at the rate expected, oil producers in the OPEC+ group, led by Saudi Arabia, moved to extend the previously announced voluntary production cuts to end•2024. Saudi went further, with a unilateral, additional cut of 1 mb/d for July, later rolled over into August.

For Kuwait/ its participation in OPEC+'s additional voluntary production cuts saw its official output reduced by 128 kb/d in May to its quota target of 2.548 mb/d, slightly above the assessment by OPEC secondary sources. Kuwait will need to keep output steady at this level—the lowest since December 2022—through to the end of the year/ which poses a challenge for the country's plan to steadily ramp up crude throughputs in the newly commissioned 1.4 mb/d Al-Zour refinery in pursuit of higher low-Sulphur fuel oil and diesel exports. Kuwait could pare back crude exports in favor of domestic refining and higher refined exports.

Government launches four-year plan to drive growth

Following its appointment in June, the government published its proposed work agenda for the coming four years (2023-27) in July, with the aim of kick-starting a more aggressive period of reforms which have lagged versus Kuwait,s GCC peers in recent years. The plan contains five overall pillars: public finance stability, the economic agenda (including diversification away from oil and promoting the role of the private sector), creating job opportunities, sustainable welfare & strong human capital, and productive government. Each pillar contains a number of goals, with a broad timeline relating to each year of the plan.

Key year-one highlights in our view are the targeted passing of the public debt law, the real estate financing law, laws to facilitate the build of large residential cities and distribute 15,000 more plots of residential land, a mass program of road maintenance works, the launch of a plan for economy-wide carbon neutrality by 2060 and measures to boost healthcare capacity. Also eye-catching was the proposal to create a sovereign fund ('Ciyada,) to invest in the local economy/ which could help spearhead key megaprojects and initiatives. A feasibility study on the fund to be completed over the next year. The government's program has been sent to the National Assembly for debate and review, and parliament,s response will be monitored for signs of a more co-operative and productive relationship with the government in the upcoming period than previously.

Real estate activity continues to soften

Real estate sales dropped to KD672 million (-38% y/y) in 2Q23, their lowest since 3Q20 (Chart 2). Residential sales fell by 28% on lower transactions (-37%), which could be related to the ongoing high valuations within this segment as well as the higher interest rate environment. Investment and commercial segment sales fell by 35% and 60%, respectively, on rising borrowing costs and perhaps uncertainty about the restructuring of utility pricing. The average transaction value only saw a mild decline, supported by the residential segment, where transactions rose by 14.7% y/y. Real estate activity could remain soft throughout this year mainly due to ongoing high residential valuations, tighter financial conditions, elevated construction costs and global macroeconomic uncertainties. The government,s four-year plan, which includes the distribution of around 43,000 building permits and 15,000 land plots, could help in easing the housing shortage by absorbing incremental demand over the medium term. Though by itself it would not eliminate the large backlog of existing applications estimated at above 90,000 in mid-2023.

Project activity slows in Q2 on Ramadan/Eid effect

After a strong 1Q23, project momentum eased

- Domestic activity showed signs of moderating in 2Q23 amid global uncertainties, higher interest rates and oil output cuts.
- Real estate sales reached their lowest since 3Q20, while credit growth slowed to 2.7% in May amid weak household borrowing.
- Project activity also eased in 2Q23, albeit after a strong Q1 and likely affected by seasonal factors.
- But encouragingly, employment held up well in 1Q23, a continuation of the post-pandemic recovery.
- Following the June elections, the new government outlined its four-year work agenda aimed at boosting economic development.

in 2Q23, with the value of awards falling for the first time since 3Q22 to KD426 million (-19.2% q/q; +54% y/y). The Ramadan and Eid period likely played a part. (Chart 3.)

Projects overseen by the Ministry of Electricity and Water and the Ministry of Public Works accounted for the bulk of awards signed off on in the quarter. Despite the slower 2Q23, compared to the previous quarter, the market appears to be improving, albeit from a low base. MEED Projects expects KD5.2 billion worth of contracts will be awarded this year, though half this figure relates to KIPIC,s Al-Zour Petrochemicals project packages (1&2) (KD2.4 billion). The outlook remains heavily influenced by events in the political sphere, and in particular cooperation between government and parliament in executing the development plan.

Employment grows; public sector drives Kuwaiti job gains

According to the latest data from the Labor Market Information System (LMIS) and Central Bureau of Statistics (CSB), total employment continued to recover in 1Q23 from its trough seen at the end of 2021, increasing by 10% y/y due to the influx of foreign workers following the resumption of economic activities post-pandemic. (Table 1.) The number of expatriate workers (excluding domestic workers) rose by 12.3% y/y in 1Q23, while growth among Kuwaiti nationals eased to 2.3%. Jobs gains among Kuwaitis were driven by the public sector, which saw a net addition of 11K jobs, while private sector jobs fell by 1,000 over the last four quarters. Expatriate employment was boosted by gains in the private sector (+173K y/y), mainly low paid workers in labor-intensive sectors such as construction (+121K) and manufacturing (+26K). Meanwhile, domestic workers also recorded a sharp rise of 27% y/y (+167K).


Inflation edges up in June on higher housing rents

Consumer price inflation rose to 3.8% y/y in June, up slightly from 3.7% in March and 3.3% at the beginning of the year. (Chart 4.) Prices in the 'housing services' category (+3.2% y/y in June) have risen, largely reflecting a pickup in rents, while inflation in clothing and miscellaneous sub-segments continued to trend upwards. Nevertheless, price growth in food and beverages, the second largest component by weight, eased to its lowest rate this year in June (6.3% y/y) amid softening global food prices. Meanwhile, the core inflation rate, which excludes food and housing, has also moved up versus the start of the year, but remained lower than the headline rate at 3.3% y/y in June. With consumer and credit activity softening against a backdrop of tighter monetary policy (relative to last year), inflationary pressures will likely ease as we progress through the year. Nevertheless, since it has come in slightly higher than expected so far this year, we now see year-average inflation at 3.4% versus the previous 3.1%.

Weak credit growth in 2023, especially household credit

Domestic credit growth continues to soften as the mid-point of the year approaches. Growth was essentially flat over the first five months of 2023/ with May,s reading of 2.7% y/y significantly down on the double-digit growth recorded a year earlier. (Chart 5.) Higher interest rates, banks, lower price competition in terms of retail lending and normalizing growth following a very strong 2022 are some of the factors behind this year,s weaker readings.


Business credit increased by just 1.1% in the year to May, cutting the annual growth rate to 2.1%. This relatively muted business credit growth is partly due to weakness in the particularly interest rate-sensitive real estate sector and in the oil/gas sector, which are both down year-to-date. Excluding these two sectors, business credit would have expanded by a relatively decent 2.9% ytd and 7.0% y/y. In fact, several sectors, such as 'construction, and 'other services, have been resilient so far this year, posting ytd growth of 4.5% and 3.8%, respectively. The slowdown is even sharper in household credit, which is broadly flat year-to-date, cutting the y/y increase to 5.3% in May. Overall, such subdued growth does not bode well for the remainder of the year, knowing that the second half of the year has historically been weaker than the first.









Resident deposit growth has been stronger than credit growth, increasing by 3.2% in the year to May (+3.0% y/y). Growth over the past year has been driven by both private sector (+6%) and government deposits (+10%), in contrast to deposits from public institutions, which fell by 15% y/y in May. Within private-sector KD deposits, current and saving accounts (CASA) continued to decrease (-11.8% y/y) while time deposits remained on an upward trend (+26%), which is unsurprising given the higher interest rate environment.

The Central Bank of Kuwait has hiked the discount rate by a cumulative 2.5% since March 2022, half of the 5% implemented by the US Fed. However, the Fed is close to ending its rate hiking cycle, with the futures market currently expecting a final 25 bps hike on 26 July.

Equities pare losses on a partial recovery in bank sector

Kuwaiti equities ended a lackluster 2Q23 little changed (-0.3% q/q)/ with May,s steep banking sec-

tor losses (-6.0% m/m) partially recouped in June after the Fed,s rate hike pause eased investor concerns. (Chart 6).

Sentiment was also helped by less political uncertainty given the conclusion of the parliamentary elections and signs of improvement in global and regional economic data. Market capitalization subsequently recovered to KD 45.7 billion as of end-June from an 8-month low of KD 43.7 in May, while turnover by value eased to a monthly average of KD 798 million reflecting lower trading activity and prices. Despite the recent pickup, the market is still far from a full recovery given that the market capitalization and index level are well below their November 2022 peaks. Further, Boursa continued to underperform GCC peer markets with the MSCI GCC up 3.3% q/q. Looking forward, though there have been signs of improving sentiment, investors remain cautious as still elevated valuations, lagging reform progress, peer market relative strength and the absence of a catalyst pose downside risks.

Indoor farming company files for bankruptcy

AppHarvest, a Kentucky-based indoor farming company that was backed by Martha Stewart when it began shipping tomatoes in early 2021, has filed for bankruptcy, officials announced on Monday.

The Chapter 11 filing on Sunday came following several months of financial difficulties, including the potential foreclosure of its greenhouse in Richmond and concerns about cash flow, news outlets reported. In addition, AppHarvest Founder Jonathan Webb was replaced earlier this month as chief executive officer and chairman of the board.

The company said in a statement that it is looking to restructure while business operations continue at its four farms.

"The AppHarvest board of directors and executive leadership evaluated several strategic alternatives to maximize value for all stakeholders prior to the Chapter 11 filing," said AppHarvest CEO Tony Martin. "The Chapter 11 filing provides protection while we work to transition operation of our strategic plan, Project New Leaf, which has shown strong progress toward operational efficiencies resulting in higher sales, cost savings and product quality." Visa profits rise

Visa Inc said its adjusted third-quarter profits rose by nearly double digits, as the global payments company continues to benefit from the broad shift by consumers to using credit and debit cards instead of cash.

The company said Tuesday that it earned a profit of \$4.2 billion, or \$2 a share, in its fiscal third quarter compared with a profit of \$3.4 billion, or \$1.60 a share, in the same period a year earlier. Last year's results included a \$456 million legal expense. Excluding that one-time cost, Visa's adjusted profits rose 7% from a year earlier.

Visa said its payments volume rose 9% from a year earlier, while the number of processed transactions on Visa's network increased 10% from a year earlier. Visa gets a fee from merchants and businesses who use its payment network to process transactions, so Visa's profits rise and fall with

the global economy as well as customers choosing to use a Visa debit or credit card over its competition or cash.

Roughly \$3.799 trillion was processed on Visa's network last quarter, with the biggest growth coming from Central and Eastern Europe, the Middle East and Latin America. In the U.S., which accounts for roughly half of Visa's global payments volume, the number of payments rose 4.9%. (AP)

Weak yen helped Nissan’s bottom line

Japan automaker Nissan reports profit rise, outlines Renault alliance

TOKYO, July 26, (AP): Nissan and Renault have formally redefined their French-Japanese auto alliance into a more equal one in cross-shareholdings, both sides said Wednesday.

The disparity between the holdings has long been a cause of friction in the alliance, set up in 1999. At the start, Nissan, based in the Japanese port city of Yokohama, had been on the verge of bankruptcy.

Under the latest terms, which still need regulatory approval expected by the end of the year, Nissan Motor Co will invest 600 million euros (\$663 million) in Ampere, Renault's electric vehicle and software entity in Europe.

Renault Group and Nissan will retain cross-shareholdings of 15% in

each other, and Renault will transfer 28.4% of its Nissan shares into a French trust, so that voting rights of both sides will be capped at 15% of the total, they said in a statement.

“The agreements that have been signed today allow us to step into the next chapter of the alliance,” said Jean-Dominique Senard, chairman of the alliance.

The deal initially announced earlier this year also calls on the companies to work together on marketing, vehicles and technology in Latin America, India and Europe.

Nissan also announced financial results, which showed that April-June net profit more than doubled to 105.5 billion yen (\$753 million). While Nissan's vehicle sales volume in China

declined because of the negative effects of the coronavirus pandemic, other regions' sales grew significantly.

Converted

The weak yen also helped Nissan's bottom line. The weak yen generally helps the results of Japanese exporters like Nissan by raising the value of overseas earnings when converted into yen.

Quarterly sales grew 36% to 2.92 trillion yen (\$20.8 billion). Nissan lowered its sales forecast for the year through March 2024 to 3.7 million vehicles, down from an earlier projection of 4 million vehicles. The lowered target is still better than the 3.3 million vehicles sold the previous fiscal year.

The maker of the Leaf EV and Infiniti luxury brands still expects fiscal result to hold up because of the boost from a favorable currency exchange rate. Nissan is forecasting 340 billion yen (\$2.4 billion) net profit for the fiscal year through March 2024.

It had previously forecast 310 billion yen (\$2.2 billion) profit. It earned nearly 222 billion yen the previous fiscal year.

The alliance has had its ups and downs. Carlos Ghosn, sent in by Renault to lead a turnaround at Nissan, was a star executive until his arrest in Japan in late 2018 on various financial misconduct charges.

The alliance, which also includes smaller Japanese automaker Mitsubishi Motor Corp., has been eager to put

the Ghosn scandal behind it.

Ghosn now lives in Lebanon, after jumping bail in late 2019. He recently filed a \$1 billion lawsuit against Nissan. Lebanon has no extradition treaty with Japan.

Ghosn, who is wanted in Japan and France, has repeatedly said he is innocent of all charges, which include underreporting income, using investment funds for personal gain and illicit use of company expenses, including overseas homes and a yacht. He says he could not expect a fair trial in Japan. Ghosn has French, Brazilian and Lebanese citizenship.

A hearing date in the case by Lebanon's prosecution is set for Sept. 18. Ghosn said half the money he is seeking is for damages, while the other half

is for compensation including salary, retirement funds and stock options.

Nissan has declined comment.

Chief Executive Makoto Uchida said the latest move on the alliance is positive for the automakers' electrification drive.

“With the finalization of the definitive agreements, we have entered the next phase of collaboration with Renault and Mitsubishi Motors in mutually beneficial areas of innovations,” he said.

He also acknowledged China remains a challenge.

“As the business environment in China is changing drastically and competition is becoming fiercer, it will be difficult to rebuild our business overnight,” said Uchida.

Teamsters hail deal as ‘historic’

UPS and Teamsters reach labor deal, averting strike

NEW YORK, July 26, (AP): UPS has reached a tentative contract with its 340,000-person union, potentially averting a strike that threatened to disrupt package deliveries for millions of businesses and households nationwide.

The agreement was announced Tuesday, the first day that UPS and the Teamsters returned to the table after contentious negotiations broke down earlier this month.

Negotiators had already reached tentative agreements on several issues but continued to clash over pay for part-time workers, who make up more than half of the UPS employees represented by the union.

The Teamsters hailed the agreement as “historic.”

Under the tentative agreement, which still needs union members' approval, full- and part-time union workers will get \$2.75 more per hour in 2023, and \$7.50 more by the end of the five-year contract. The agreement also includes a provision to increase starting pay for part-time workers - whom the union says are the most at risk of exploitation - from \$16.20 per hour to \$21 per hour. The average pay for part-timers had been \$20.

Teamsters General President Sean M. O'Brien said in a statement that UPS put \$30 billion more on the table due to the negotiations, saying the deal “sets a new standard in the labor movement.”

The two sides had already tentatively agreed to make Martin Luther King Jr. Day a full holiday and to end forced overtime on drivers' days off. Tentative agreements on safety issues were also reached, including equipping more trucks with air conditioning.

Eliminate

UPS had also agreed to eliminate a lower-paid category of drivers who work shifts that include weekends, and convert them into regular full-time drivers. Under the agreement, the company will create 7,500 full-time jobs and fill 22,500 open positions, allowing more part-timers to transition to full-time.

“Together we reached a win-win agreement on the issues that are important to Teamsters leadership, our employees and to UPS and our customers,” Carol Tomé, UPS CEO, said in a written statement.

Voting on the new contract begins Aug 3 and concludes Aug 22.

Industry groups, the US Chamber of Commerce, labor leaders and President Joe Biden applauded the deal.

The White House said Biden spoke via phone with Tomé and O'Brien and pointed to their agreement as evidence that collective bargaining works and offered his best wishes for a smooth ratification.

Union members, angered by a contract they say union leadership forced on them five years ago, argued that they have shouldered the more than 140% profit growth at UPS as the pandemic increased delivery demand. Unionized workers said they wanted to right what they saw as a bad contract.

Union leadership was upended two years ago with the election of O'Brien, a vocal critic of union president James Hoffa - son of the famed Teamsters firebrand - who signed off on that contract.

The 24 million packages UPS ships daily amount to about a quarter of all US parcel volume, according to the global shipping and logistics firm Pitney Bowes. According to UPS, that's equivalent to about 6% of the nation's gross domestic product.

During the last breakdown in labor talks a quarter of a century ago, 185,000 UPS workers walked out for 15 days, crippling the company. A walkout this time would have had much further-reaching implications, with millions of Americans now accustomed to online shopping and speedy delivery.

Handle

The consulting firm Anderson Economic Group estimated a 10-day UPS strike could have cost the US economy more than \$7 billion and triggered “significant and lasting harm” to the business and workers.

Logistics experts warned that the other US shipping companies do not have the combined capacity to handle all the packages that would come their way during a UPS work stoppage, and that prices of shipping and goods would inevitably increase. Meanwhile, customers who shop online could have faced higher shipping fees and longer waits.

In recent weeks, large and small businesses worked to create contingency plans in the event of a strike.

Joseph Debicella, a small business owner who sells bridesmaids' gifts online, said his company ships roughly 50% of its orders through UPS. He hasn't used FedEx, but he created an account with the company two weeks ago as chatter over a strike picked up. He was also hearing about the negotiations from his UPS driver, who told him his deliveries were getting lighter as the July 31 deadline for a new contract neared.

Macy's CEO Jeff Gennette told The Associated Press that the department store chain was considering its options and that its supply chain team was mapping out what a strike would look like and how it would affect shipping.

If ratified, the deal could prevent major disruption just as retailers are in the throes of the back-to-school shopping season - the second largest sales period behind the winter holidays.

The Retail Industry Leaders Association, a national retail trade group that counts retailers including Best Buy, CVS Health and Kohl's as members, called the tentative pact “an enormous relief to retailers, who have been navigating the possibility of a strike and the associated uncertainty for weeks.”

“We're grateful that this challenge, which would have had a price tag in the billions of dollars and a long runway for recovery, was avoided,” the group said in a statement.

NEW YORK, July 26, (AP): Microsoft reported a 20% spike in quarterly profits Tuesday, helping to fuel its battle to get ahead of rivals like Google, Amazon and Facebook parent Meta in selling the latest artificial intelligence technology.

The software giant said its fiscal fourth-quarter profit was \$20.1 billion, or \$2.69 per share, beating analyst expectations for \$2.55 per share.

It posted revenue of \$56.2 billion in the April-June period, up 8% from last year. Analysts polled by FactSet Research had been looking for revenue of \$55.49 billion.

CEO Satya Nadella said the company remains focused on “leading the new AI platform shift,” though its push to add AI features to its existing products - among them cloud computing services, workplace software and its Bing search engine - are not yet making an obvious mark on its financial results.

Microsoft was an early mover in this year's hype around “generative AI” tools that can help people write documents and create new images and other media. It capitalized on its multibillion dollar investments in ChatGPT-maker OpenAI to launch a Bing chatbot and similar tools tailored to its business customers. It said last week that it would start charging \$30 per user for business accounts that sign up for its new AI “Copilot” that integrates with existing software such as Word, Excel and email.

“Organizations are asking not only how - but how fast - they can apply this next generation of AI to address the biggest opportunities and challenges they face - safely and responsibly,” Nadella said in a prepared statement.

Despite beating Wall Street analyst expectations for profit and revenues, Microsoft's stock dropped slightly in after-hours trading after it released its financial report upon the market's close Tuesday.

Macquarie analyst Sarah Hindlian-Bowler said investors have been focused on Microsoft's early revenue from those artificial intelligence investments, the performance of the Azure cloud computing platform and the likelihood that Microsoft will close its deal to buy video game company Activision Blizzard, which could help boost gaming revenue and drive more users to the Xbox game system and other Microsoft platforms.

Google rebounds from unprecedented ad revenue drop to push stock higher

SAN FRANCISCO, July 26, (AP): Google snapped out of an unprecedented advertising slump during its latest quarter, signaling a return to growth cycle needed to fuel investments in artificial intelligence technology that expected to reshape the competitive landscape.

The results for the April-June period released Tuesday by Google's corporate parent, Alphabet Inc., reversed a financial downswing that had raised fears Google was losing its financial steam at the same time advances in artificial intelligence, or AI, threatened to undercut the dominant search engine that powers its digital ad empire.

But after Google's ad revenue suffered year-over-year declines in consecutive quarters for the first time in its history, ad sales rose 3% from a year ago to \$58.1 billion during the second quarter. That was better than analysts had been anticipating, according to FactSet Research.

Those gains helped lift Alphabet's total revenue for the period by 7% from last year to \$74.6 billion. The company posted a profit of \$18.4 billion, or \$1.44 per share, a 15% increase from the same time last year. Both those numbers also surpassed the analyst estimates that steer investors.

The Mountain View, California, company also announced that Chief Financial Officer Ruth Porat will take on the newly created role of president and chief investment officer. Alphabet will

seek a new CFO to take over a job that Porat, a former investment banker, has handled for the past eight years.

Alphabet's stock price surged nearly 10% in Tuesday's extended trading after the results came out. The shares have climbed nearly 50% so far this year, with much of the gains since Google provided a deeper dive into its AI products and strategy during a May conference. That presentation helped alleviate concerns that Google is being outmaneuvered in a pivotal field of technology by Microsoft, which is backing and deploying some of the breakthroughs made by Open AI and its popular chatbot, ChatGPT.

Innovation

“We are in a period of incredible innovation in search,” Alphabet CEO Sundar Pichai said Tuesday during a conference call he conducted from London, where he said he was visiting with the DeepMind division overseeing the company's AI efforts.

The brewing battle for AI supremacy is expected to require billions of dollars in investments in the years to come - money that Alphabet should be able to get from Google's advertising machine, as long as it can continue the steady growth of the past 20 years. But Google has recently been facing more daunting challenges, not only from the ChatGPT-like technology that Microsoft has been embedding in its Bing search engine, but also from Amazon

in shopping, and TikTok and Reddit in hot topics.

Insider Intelligence analyst Evelyn Mitchell-Wolf said the past quarter showed Google remains on “the high ground. All it has to do now is keep increasing revenues while executing its carefully-laid plans to lead advertisers and consumers into the AI-powered future without any catastrophes.”

After YouTube saw its ad sales fall year-over-over in three straight quarters as TikTok's audience swelled, Google's popular video site also bounced back with a 4% increase in ad revenue from last year. Meanwhile, the Google Cloud division that provides the behind-the-scenes technology for a wide swath of websites posted a 28% increase in revenue from last year. The Cloud division also posted its second consecutive profitable quarter in a development that has pleased investors.

Porat's promotion signaled Alphabet is looking to pare the losses in its long-unprofitable “Other Bets” division that includes self-driving car pioneer Waymo and other far-flung projects working on technology expected to take many years to yield a return. When she takes on her new role as Alphabet's president, Porat will oversee the Other Bets portfolio as part of a commitment to “drive financial discipline and returns for shareholders, while spearheading investment to create sustainable, long-term value,” Pichai said in a statement.

competition. The U.S. Federal Trade Commission also opposed the transaction but lost a court fight to stop it.

“We still expect a successful close as the company works toward an amenable solution that satisfies the U.K.'s concerns,” Hindlian-Bowler said in an analyst note ahead of Tuesday's earnings.

Quarterly sales were highest in Microsoft's cloud business segment, which the company said grew 15% from the same time last year to \$24 billion. Much of that was driven by its flagship Azure platform “and other cloud services revenue,” which grew 26%.

Microsoft doesn't reveal the total revenue for its Azure business, though a document inadvertently disclosed during its recent court fight with the FTC showed it as \$34 billion last year, Hindlian-Bowler said. Microsoft has declined to comment on that number.

It's long been seen as the runner-up to Amazon's dominant cloud platform, Amazon Web Services.

Microsoft's second-biggest business segment - centered on productivity software led by its Office suite of workplace products - grew 10% to \$18.3 billion in sales for the April-June quarter.

While AI has captivated the attention of the public and investors, Microsoft is also still heavily reliant on its personal computing business centered around the licensing fees paid by the makers of computers running its Windows software.

Microsoft made \$13.9 billion from its personal computing business segment in the quarter, down 4% from the same time last year. While that segment also includes other products, including Xbox games and consoles, it's been the Windows revenue dragging the overall numbers down.

Worldwide shipments of PCs from various manufacturers in the April-June quarter dropped 16.6% from the same time last year, marking the seventh consecutive quarter of year-over-year decline, according to market research group Gartner. However, the market is starting to stabilize and demand could grow again in 2024, Gartner said.

With most of its revenue coming from sales to business clients, Microsoft hasn't been as affected by economic troubles that have hit consumer-focused sectors or advertising-dependent tech rivals like Google and Meta. But Microsoft has still laid off hundreds of workers in recent months, including many around its headquarters in Redmond, Washington, according to notices it sent to government agencies. That's on top of the 10,000 employees, almost 5% of its workforce, that it cut earlier this year.

Stock transactions made millions for Tottenham owner’s cronies

UK billionaire Lewis charged with insider trading in US

NEW YORK, July 26, (AP): British billionaire and Tottenham soccer team owner Joe Lewis has been indicted on charges of slipping confidential stock tips to his romantic partners, private pilots and other pals, US prosecutors said Tuesday.

Lewis exploited his entrée to various corporations to reap lucrative secrets, passed them on to people in his own inner circle and prompted them to trade on the knowledge, prosecutors said. They said the stock transactions made millions of dollars for Lewis and his cronies.

“As we allege, he used insider information as a way to compensate his employees and shower gifts on his friends and lovers,” Manhattan-based

US attorney Damian Williams said in a Twitter video announcing the insider trading case. “It's cheating, and it's against the law.”

David M. Zornow, an attorney for Lewis, said his client had come to the US “to answer these ill-conceived charges” and would fight them vigorously.

“The government has made an egregious error in judgment in charging Mr Lewis, an 86-year-old man of impeccable integrity and prodigious accomplishment,” Zornow said in a statement. The charges include securities fraud and conspiracy.

With a fortune that Forbes estimates at \$6.1 billion, Lewis has investments that span from real estate to biotech-

nology, energy to agriculture - and, of course, sports. He bought Tottenham, one of England's most storied soccer clubs, in 2001.

Stakes

Lewis' Tavistock Group has stakes in more than 200 companies around the world, according to its website, and his art collection boasts works by Picasso, Matisse, Degas and more. His business connections include Tiger Woods, Ernie Els and Justin Timberlake, with whom he built a Bahamian oceanside resort that opened in 2010.

According to the indictment, Lewis' investments in various companies gave him control of board seats, where he placed associates who let him know

what they learned behind the scenes. Prosecutors say Lewis improperly doled out that confidential information between 2019 and 2021 to his chosen recipients and urged them to profit on it.

At one point, according to the indictment, he even loaned his two private pilots \$500,000 apiece to buy stock in a cancer-drug company that he knew had gotten - but not yet publicly disclosed - encouraging results from a clinical trial.

“Boss is helping us out and told us to get ASAP,” the pilot texted when advising a friend to buy the stock, too, according to the filing. In later texts telling the friend about the loan, the pilot reasoned that “the Boss has inside info” and “knows the outcome.”

Stars give fiery speeches, show solidarity with Hollywood strike

Cranston, Chastain join star-studded rally in Times Square

NEW YORK, July 26, (AP): SAG-AFTRA held its largest and most star-studded rally yet Tuesday in Times Square in a picket sign-waving show of solidarity 12 days into the actors strike.

A day after a Variety report questioned the lack of A-listers that have hit picket lines thus far, the rally Tuesday boasted more star wattage than perhaps any single strike action yet. Among those joining throngs of demonstrators were Jessica Chastain, Bryan Cranston, Brendan Fraser, Ellen Burstyn, Wendell Pierce, Steve Buscemi, Rachel Zegler, Michael Shannon, Jane Curtin, Christian Slater and Chloe Grace Moretz.

Taking up a full city block, actors and representatives from the actors union took turns giving fiery speeches on a stage in the heart of Times Square while tourists gawked and passing trucks honked in support. At times, the actors took aim at the corporate lights and billboards around them, including the Walt Disney-owned ESPN and ABC studios that sat alongside the rally.

“We’ve got a message to Mr. Iger,” said Cranston, directing his comments at Disney CEO Bob Iger. “I know, sir, that you look through things from a different lens. We don’t expect you to understand who we are but we ask you to hear us, and beyond that, to listen to us when we tell you we will not be having our jobs taken away and given to robots. We will not have you take away our right to work and earn a decent living.”

The rally took place a stone’s throw from Broadway theaters and,

given the talent involved, featured a higher degree of show business than your usual labor rally. “Avatar” actor Stephen Lang quoted Frederick Douglass. Wendell Pierce recited Samuel Beckett. Tituss Burgess didn’t speak; he sang Stephen Sondheim.

Arian Moayed, who played the investor Stewy Hosseini in “Succession,” compared the characters of the HBO series to the studio executives the actors are negotiating with.

“It’s like these people haven’t seen (expletive) ‘Succession,’” Moayed exclaimed. “It’s about you!”

Christine Baranski of “The Good Wife” and “The Good Fight” likewise drew from her own credits.

“We will not live under corporate feudalism. It is time, it is just simply time to make things right. Our contribution will not be undervalued, and we will not be robbed,” said Baranski before concluding: “Let’s fight the good fight!”

Streaming

Earlier this month, actors joined striking screenwriters who walked out in May. It’s the first time both unions have been on strike at the same time since 1960. The stoppage has shuttered nearly all film and television production. Actors say the streaming revolution has altered pay in entertainment, stripping them of residuals and remaking working conditions. They are also seeking guardrails against the use of ar-

tificial intelligence, along with increases to the union’s health care and pension programs.

“Our industry has changed exponentially,” said Cranston. “We are not in the same business model that we were in even 10 years ago. And yet, even though they admit that that’s the truth in today’s economy, they are fighting us tooth and nail to stick to the same economic system that is outmoded, outdated. They want us to step back in time.”

The Alliance of Motion Picture and Television Producers, which is negotiating on behalf of studios, has said it presented actors with a generous deal that included the biggest bump in minimum pay in 35 years among other benefits. Since talks broke off and Screen Actors Guild-American Federation of Television and Radio Artists commenced the strike, the sides have not negotiated and no talks are scheduled.

“We may be on strike but I said to them on July 12 we are ready to continue talking tomorrow and every day after until we reach a deal,” said Duncan Crabtree-Ireland, chief negotiator for SAG-AFTRA. “And I’ve said that every day since to the media, to them, to anyone who would listen. SAG-AFTRA is ready, willing and able to return to the bargaining table.

“The only reason we aren’t there now is because those companies said that they didn’t want to deal with people who were uncivilized and because those companies said they wouldn’t be ready to talk for quite some time,” added Crabtree-Ireland.

Films by Pine, Kendrick to premiere at Toronto fest

Venice unveils A-list lineup amid strikes

NEW YORK, July 26, (AP): Bradley Cooper’s Leonard Bernstein drama “Maestro,” Sofia Coppola’s Priscilla Presley movie, Michael Mann’s “Ferrari,” David Fincher’s “The Killer” and Ava DuVernay’s “Origin” will make their world debuts at the Venice International Film Festival this fall.

Organizers announced the lineup Tuesday for the 80th edition of the festival, which - despite the flashy names behind the films - could have a little less Hollywood glamour than usual gracing its picturesque docks and red carpet come September if the Hollywood actors and writers strikes stretch on. As part of the strike, actors cannot promote projects from the studios and streamers with whom the union is negotiating.

The prestigious film festival already lost one high-profile premiere to the labor disputes in the US in Luca Guadagnino’s tennis drama “Challengers,” starring Zendaya, which had been set to play in the opening night slot but has now been pushed to 2024. But Alberto Barbera, the director of the Venice Film Festival, said Tuesday that the strikes’ effects on the festival lineup had otherwise been minimal.

“Priscilla,” an A24 film based on Priscilla Presley’s memoir “Elvis and Me,” stars Cailee Spaeny and Jacob Elordi and was widely expected to be in the festival. Coppola also launched “Somewhere” in Venice in 2010. “Priscilla” will be competing for the Golden Lion alongside “Ferrari,” the buzzy racing drama starring Adam Driver as Enzo Ferrari, and Penelope Cruz as his wife Laura, based on Brock Yates’ biography.

Yorgos Lanthimos’ highly anticipated “Poor Things,” with Emma Stone and Mark Ruffalo, will also have its bow on the Lido. Lanthimos previously launched “The Favourite” at Venice in 2018; it would go on to score 10 Oscar nominations and win one.

DuVernay’s film, “Origin,” meanwhile, is based on the book “Caste” and the life of its author, Pulitzer winner Isabel Wilkerson. The movie stars Aunjanue Ellis-Taylor.

Netflix will once again have a big presence at the festival with “Maestro,” directed by and starring Cooper as the legendary composer, opposite Carey Mulligan as Felicia Montealegre, and Fincher’s “The Killer,” with

Michael Fassbender playing an assassin. The streamer is also bringing Pablo Larrain’s “El Conde,” a dark comedy in which Augusto Pinochet is a vampire, as part of the competition titles.

Another high-profile competition title is Michel Franco’s “Memory,” with Jessica Chastain and Peter Skarsgaard, as is “Drive My Car” director Ryūsuke Hamaguchi’s “Evil Does Not Exist.”

Venice has never been a festival to shy away from controversial directors and has programmed new films from both Roman Polanski and Woody Allen.

Polanski is back for the first time since 2019 with “The Palace,” about a New Year’s Eve in 1999 in a Swiss hotel, with John Cleese and Mickey Rourke. Allen is debuting his first French movie, “Coup de Chance.” Luc Besson, who was recently cleared of charges in a rape case, will also be on the Lido with “Dogman,” starring Caleb Landry Jones.

Competition

The jury presiding over the main competition this year is full of high-profile directors, including Damien Chazelle, Jane Campion, Martin McDonagh and last year’s Golden Lion winner Laura Poitras.

In addition to the Polanski and Allen films, also playing out of competition are Wes Anderson’s Roald Dahl-inspired “The Wonderful Story of Henry Sugar” with Benedict Cumberbatch, Dev Patel and Ralph Fiennes; Harmony Korine’s “Aggro Drift”; Richard Linklater’s “Hit Man”; Frederick Wiseman’s “Menus Plaisirs - Les Troisgros”; and William Friedkin’s “The Caine Mutiny Court-Martial.”

Venice is a top launching ground for awards hopefuls and has, in recent years, debuted Oscar-nominated films like “The Whale,” “The Banshees of Inisherin,” “Tár,” “The Power of the Dog,” “A Star is Born” and “La La Land.” It’s also the first major stop of the busy fall film festival season, with Toronto, Telluride and the New York Film Festivals close behind.

Like the Cannes Film Festival, celebrity is a huge part of the Venice iconography: Think of Lady Gaga perched on the side of a water taxi in her black Jonathan Simkhai bustier dress, or Timothée Chalamet vamping

in that backless red halter top by Haider Ackermann. Last year there were also viral moments aplenty thanks to the cast of “Don’t Worry Darling” and the alleged “spit-gate,” in which internet spectators wondered if Harry Styles had spit on his co-star Chris Pine at the film’s premiere.

It remains unclear whether any Hollywood talent will be able to make the journey this year. Barbera said at this point that some actors and actresses will not be able to attend but, without getting specific, said that talent from independent fare will be able to grace the red carpets and press conferences.

The Venice Film Festival runs from Aug. 30 through Sept. 9.

NEW YORK: The Toronto International Film Festival unveiled a starry lineup to its 48th edition on Monday, even if remains unclear if stars will be there to walk red carpets due to the ongoing actors and writers strikes.

Among the films making their world premieres at TIFF this year are **Craig Gillespie’s** GameStop drama “Dumb Money,” with **Paul Dano** and **Pete Davidson**; **Ellen Kuras’** “Lee,” starring Kate Winslet at war photographer **Lee Miller** and **Tony Goldwyn’s** Ezra,” with **Robert De Niro** and **Rose Byrne**.

Also headed to **Toronto** are **Michael Keaton’s** “Knox Goes Away,” starring **Al Pacino** and **James Marsden**; **Kristen Scott Thomas’** “North Star,” featuring **Scarlett Johansson** and **Sienna Miller**; **David Yates’** Netflix drama “Pain Hustlers,” starring **Emily Blunt** and **Chris Evans**; and **Maggie Betts’** “The Burial,” with **Jamie Foxx** and **Tommy Lee Jones**.

Those films, and many more including directorial debuts by **Anna Kendrick** (“Woman of the Hour”) and **Chris Pine** (“Poolman”), will make up some of the gala premieres at TIFF, the largest film festival in **North America**.

The festival is a key platform for **Hollywood** to debut its fall fare and awards hopefuls. But like the Venice Film Festival, which begins about a week before TIFF launches on Sept. 7, Toronto organizers are anxiously following the SAG-AFTRA and WGA strikes.

LOS ANGELES: Pete Davidson has entered a diversion program to resolve a reckless driving charge for crashing into a **Beverly Hills** home and will perform 50 hours community service, authorities said Tuesday.

The 29-year-old “Saturday Night Live” and “King of Staten Island” actor and comedian will likely do his community service with the **New York** Fire Department, where his late father worked, Los Angeles County prosecutors said.

Davidson was 7 years old when his father, **Scott**, a New York firefighter, died responding to the 9/11 attacks.

Davidson pleaded not guilty to the misdemeanor and was put in an 18-month diversion that also includes 12 hours of traffic school, an order to obey all laws and restitution that was not specified.

When Davidson was charged on June 16, prosecutors called the March 4 crash a “serious collision.” No one was reported injured.

Davidson’s latest show, “Bupkis,” debuted on Peacock in May, and he stars in the forthcoming film “Dumb Money.” (AP)

LOS ANGELES: A California appeals court on Wednesday will consider reviving the dismissed lawsuits of two men who allege **Michael Jackson** sexually abused them as children for years, a move the court appears likely to make after a tentative decision that would order the cases back to a lower court for trial.


The suits were filed after Jackson’s 2009 death by **Wade Robson** in 2013 and **James Safechuck** the following year. The two men became more widely known for telling their stories in the 2019 HBO documentary, “Leaving Neverland.”

Both sued MJJ Productions Inc. and MJJ Ventures Inc, two corporations for which Jackson was the sole owner and lone shareholder.

In 2021, Superior Court Judge **Mark A. Young** ruled that the two corporations and their employees had no legal duty to protect Robson and Safechuck

from Jackson and threw out the suits. But in a tentative decision last month, California’s 2nd District Court of Appeal reversed that judge and ordered the cases back to trial.

Lawyers for the Jackson estate on Wednesday will try to convince the appeals court to reverse course.

The lawsuits have already bounced back from a 2017 dismissal, when Young threw them out for being beyond the statute of limitations. A new California law that temporarily broadened the scope of sexual abuse cases led the appeals court to restore them. Jackson’s personal estate - the assets he left after his death - was

thrown out as a defendant in 2015.

Robson, now a 40-year-old choreographer, met Jackson when he was 5 years old. He went on to appear in Jackson music videos and record music on his label.

His lawsuit alleged that Jackson molested him over a seven-year period. It says that

he was Jackson’s employee, and the employees of two corporations had a duty to protect him the same way the Boy Scouts or a school would need to protect children from their leaders.

Safechuck, now 45, said in his suit that he met Jackson while filming a Pepsi commercial when he was 9. (AP)

Group sings the blues

Kenney’s album hits right emotional note

Madeline Kenney, “A New Reality Mind” (Carpark Records)

Madeline Kenney’s new album “A New Reality Mind” is a neatly woven ethereal treatise on rebuilding after a relationship collapse.

The Oakland-based singer-songwriter fused her thoughts and music together during the pandemic, sorting through it all in a basement she once shared with her partner. The result is a lush, sonic exploration that would not be out of place on a playlist heavy with Cocteau Twins.

Early tracks like “Plain Boring Disaster” and “Superficial Conversation” offer melodies that meander and flow as if conceived underwater. They deal with innocent missteps and the personal ability to move past them.

Kenney hits her best stride on “It Carries On,” a gorgeous song about working through personal pain. Musician Jeff Kolhede plays a nice featured saxophone section on this deftly mixed track.

Sudden solitude following a breakup clearly moved Kenney to explore her raw emotions through art and sound. Choosing to create and not wallow is the precise kind of process that can deliver good music in the right hands.

“A New Reality Mind” feels sincere and personal and hits the right emotional mark. Kudos to Kenney for her passion and vulnerability.

“**Everything Is Alive,**” Darlingside (Thirty Tigers)

Even the percussion is pretty.

Darlingside’s “Everything Is Alive” achieves a melancholy-inducing beauty from the sum of its parts. That includes the quartet’s vocals, whether individually or in harmony, and arresting arrangements with chiffon textures that make a kick drum sound tender.

There’s variety thanks to the Boston-based band’s democratic approach - lead vocals are shared by all four members, as are writing credits. Don Mitchell evokes fire and rain contemplating mortality on “Darkening Hour,” and Auyon Mukharji’s tenor shines atop baroque strings on “Down Here,” which has the subtle sway of a courtly Sarabande. Harris Paseltiner offers “Green Light” as an Irish blessing paired with an intricate melody, while David Senft somehow creates an ethereal mood on “All the Lights in The City” even as he sings of boustrophedon.

Keep the dictionary handy: There are also lofty lyrics about a Robitussin dream and cerulean embrace, which perhaps is to be expected with a band from a college town. Recurring themes of loss and darkness, however, are plain enough.

“Lose the keys, the marbles, lose a parent, lose the count, lose the plot,” Mitchell laments on “Lose the Keys.”

Darlingside sings the blues with a lovely, inviting intimacy. These are songs made for bedroom headphones - good ones, not the cheap kind. “Everything Is Alive” is worth the investment.

“**In the End it Always Does**” by The Japanese House (Dirty Hit)

More than four years have passed since the first studio release by Amber Bain, known professionally as The Japanese House. Her second album, “In the End it Always Does,” was conceived in a burst of creativity after the disintegration of a relationship. The result is a sweetly melancholic chronicle of a cycle of falling in and out of love, and a celebration of the dog who got her through it.

The album slides smoothly between dreampop, ‘70s-infused folk rock and a half dozen other genres to fit comfortably into an emergent London sound alongside artists such as Arlo Parks and Etta Marcus. Bain produces and writes or co-writes all of the songs, and plays nearly all of the instruments, including bass, guitar, keyboard, piano and percussion.

George Daniel of The 1975 and Chloe Kraemer share production credit. The 1975’s Matty Healy adds production, vocals and guitars on some tracks, and Muna’s Katie Gavin sings on one. But this album is largely the product of Bain’s singular talent and vision, and she establishes coherent musical and emotional themes that run its full length.

The opening track, “Spot Dog,” sets the rules on Bain’s terms, blending analog instruments with intermittently heavy production and distortion. As in many of the songs, it is slow to resolve, starting with jazzy piano noodling, and adding in other instrumentals that search for and usually find their melodies.

“Sad to Breathe” highlights the extent of her toolkit. It starts soft and simple but confidently layers rhythms and complex instrumentation under the chorus, “it’s sad to breathe the air when you’re not there.” Throughout the album, lyrics are consistently simple, devastating and relatable. On the following track, “Over There,” she sings “She stops by/ From time to time/ She keeps her coat on.”

“Sunshine Baby” is a lovely bit of summertime sadness with bright instrumentals and wistful delivery. She sings, “I don’t know what’s right anymore/I don’t wanna fight anymore,” but finds her grounding, “Sitting by the seafont/Lying with my sunshine baby.” (Sunshine is her nickname for her dog.)

BAYREUTH, Germany: The Bayreuth Festival intends to present “Rienzi” for the first time in 2026 for its 150th anniversary, going outside the canon of **Richard Wagner’s** final 10 operas for the first time.

Wagner’s family still runs the festival in Bayreuth Germany, and until now has limited it to only what are considered his mature works.

Katharina Wagner, a great-granddaughter who directs the festival, announced future plans during a Zoom news conference on Monday, a day before this year’s schedule opens.

“Rienzi” will be staged along with the 10 other operas in 2026. “Rienzi,” Wagner’s third completed opera, opened in 1842 and is based on the 14th century Italian politician **Cola di Rienzo.**

Wagner said the 2024 festival will feature a new staging of “Tristan und Isolde” directed by **Thorleifur Orn Arnarsson,** conducted by **Semyon Bychkov** and starring **Andreas Schager** and **Camilla Nylund.**

The 2025 festival will have a new production of “Die Meistersinger von Nürnberg (The Mastersingers of Nuremberg)” directed by **Matthias Davids,** conducted by **Daniele Gatti** conducting and starring **Georg Zeppenfeld** and **Michael Spyres.** (AP)

Singer sings from the heart in ‘Parallel’

Hoying celebrates love in solo debut

LOS ANGELES, July 26, (AP): During a two-month break in the a cappella group Pentatonix’s world tour, baritone Scott Hoying became a new-lywed. He also went out on his own, with his most personal music to date.

The 31-year-old Grammy winner sings from the heart about falling in love and losing his best four-legged friend in his seven-track solo debut “Parallel,” which is out Friday.

Other members of Pentatonix have released solo albums before, and going at it alone is something Hoying has thought about for many years, but with much hesitation. Still, the process of finally doing it has been therapeutic. It’s given Hoying an opportunity to fortify his creativity and build confidence.

“I have always been a little bit scared to be vulnerable and kind of put myself out there as a solo act,” Hoying told The Associated Press. “And I feel like this timing is just so perfect because I’m entering this very beautiful era of my life, like producing and making music and being more motivated than ever. And then I’m in love ... and I’ve just had a lot of personal growth over the past couple of years.

“It’s just like this really big new chapter that’s starting. And it feels kismet and amazing.”

The COVID-19 pandemic was an underlying reason for the project. Because Pentatonix couldn’t record together due to social distancing, the five-member a cappella group laid down tracks separately, having learned how to use digital audio technology. Once Hoying became comfortable with the process, he was captivated by it. He constantly watched tutorials on YouTube and it led to a flurry of personal songwriting.

The pandemic process “was super energizing and inspiring, and I ended up writing hundreds of songs,” Hoying said.

Produced by Jon Levine, four of the seven songs are about love, including the title track “Parallel,” which was released as a single in June.

Personal

“Parallel” is about Hoying’s relationship with his husband, Mark, their shared qualities and being in sync with one another. It recalls a time when the couple was supposed to attend an event but ended up laying side by side on the floor of the kitchen talking long into the night. Hoying directed the song’s video, filmed in Iceland after Pentatonix had performed the last show on its European Tour there in June.

Mark Hoying appears in the videos for “Parallel” and “Mars,” a single released last September.

Scott Hoying also pays tribute to his dog that passed away in “Bubs.” There’s also “King Kong,” about personal growth and finding confidence, and “Trust Fall,” which “is about diving into the scary, unknown parts of life. It’s only scary because we don’t know what’s to come, but exciting. More like a nervous butterfly,” he said.

And just like that, Hoying will be back on tour with Pentatonix when it starts a North American leg of their tour in August.

The group has been together since 2011. It began with Hoying, tenor Mitch Grassi and mezzo-soprano Kirstin Maldonado as high school classmates in Arlington, Texas. They added bass Avi Kaplan and beatboxer Kevin Olusola prior to competing - and winning - on the television competition program, “The Sing-Off.” Kaplan left Pentatonix in 2017 and was replaced that year by Matt Sallee.

The group’s popularity is as strong as ever. Pentatonix sang the national anthem at college football’s national championship game in January and was honored with a star on the Hollywood Walk of Fame in February.

“I think with any genre of music, if it’s bringing emotion and bringing joy to people, it’s going to stick around,” Hoying said. “And so, I think that if we keep pushing the limits of a cappella, and if we keep doing interesting things that makes people feel, I think that we can do it for a long time.”

Hoying and Grassi formed the group “Superfruit” several years ago for a comedy YouTube channel. The pair produced a couple of albums, including the popular upbeat song “GUY.EXE.”

Hoying currently is working with others to develop “The Life of Death,” a musical about the Grim Reaper and his daughter. Hoying says is right up his creative alley.

MOSCOW: The Russian prosecutor-general’s office on Tuesday declared independent TV channel Dozhd to be an undesirable organization, continuing the country’s wide crackdown on news media and groups regarded as threats to **Russia’s** security.

The designation outlaws Dozhd from operating in Russia and exposes its journalists, staff and donors to potential criminal charges.

Dozhd, which is often critical of the **Kremlin,** closed its operations in Russia soon after the beginning of the **Ukraine** conflict, moving first to **Latvia** and then to the **Netherlands.** The prosecutor-general’s office said Dozhd had spread extremist material and discredited authorities.

The channel frequently offended authorities with its coverage of Russia’s political opposition and criticism of the Kremlin. It was removed from Russian cable TV systems in 2014 after conducting a controversial poll of whether viewers thought the Soviet Union should have surrendered in the World War II siege of Leningrad in order to save civilian lives.

It then transmitted programs on a subscription internet site and through YouTube. (AP)

Warming blamed

Cases of ‘tick-borne’ illnesses on the rise

NEW YORK, July 26, (AP): In 2022, doctors recorded the first confirmed case of tick-borne encephalitis virus acquired in the United Kingdom.

It began with a bike ride. A 50-year-old man was mountain biking in the North Yorkshire Moors, a national park in England known for its vast expanses of woodland and purple heather. At some point on his ride, at least one black-legged tick burrowed into his skin. Five days later, the mountain biker developed symptoms commonly associated with a viral infection - fatigue, muscle pain, fever.

At first, he seemed to be on the mend, but about a week later, he started to lose coordination. An MRI scan revealed he had developed encephalitis, or swelling of the brain. He had been infected with tick-borne encephalitis, or TBE, a potentially deadly disease that experts say is spreading into new regions due in large part to global warming.

For the past 30 years, the UK has become roughly 1 degree Celsius warmer (1.8 degrees Fahrenheit) on average compared to the historical norm. Studies have shown that several tick-borne illnesses are becoming more prevalent because of climate change. Public health officials are particularly concerned about TBE, which is deadlier than more well-known tick diseases such as Lyme, due to the way it has quickly jumped from country to country.

Gábor Földvári, an expert at the Center for Ecological Research in Hungary, said the effects of climate change on TBE are unmistakable. “It’s a really common problem which was absent 20 or 30 years ago,” he added.

Ticks can’t survive more than a couple of days in temperatures below zero, but they’re able to persevere in very warm conditions as long as there’s enough humidity in the environment. As Earth warms on average and winters become milder, ticks are becoming active earlier in the year. Climate change affects ticks at every stage of their life cycle - egg, six-legged larva, eight-legged nymph, and adult - by extending the length of time ticks actively feed on humans and animals. Even a fraction of a degree of global warming creates more opportunity for ticks to breed and spread disease.

Contact

“The number of overwintering ticks is increasing and in spring there is high activity of ticks,” said Gerhard Dobler, a doctor who works at the German Center for Infection Research. “This may increase the contact between infected ticks and humans and cause more disease.” Since the virus was first discovered in the 1930s, it has mainly been found in Europe and parts of Asia, including Siberia and the northern regions of China. The same type of tick carries the disease in these areas, but the virus subtype - of which there are several - varies by region. In places where the virus is endemic, tick bites are the leading cause of encephalitis, though the virus can also be acquired by consuming raw milk from tick-infected cattle. TBE has not been found in the United States, though a few Americans have contracted the virus while traveling in Europe.

According to the World Health Organization, there are between 10,000 and 12,000 cases of the disease in Europe and northern Asia each year. The total number of cases worldwide is likely an undercount, as case counts are unreliable in countries where the population has low awareness of the disease and local health departments are not required to report cases to the government. But experts say there has been a clear uptick since the 1990s, especially in countries where the disease used to be uncommon.

“We see an increasing trend of human cases,” Dobler said, citing rising cases in Austria, Germany, Estonia, Latvia, and other European countries.

TBE is not always life-threatening. On average, about 10 percent of infections develop into the severe form of the illness, which often requires hospitalization. Once severe symptoms develop, however, there is no cure for the disease. The death rate among those who develop severe symptoms ranges from 1 to 35 percent, depending on the virus subtype, with the far-eastern subtype being the deadliest. In Europe, for example, 16 deaths were recorded in 2020 out of roughly 3,700 confirmed cases.

Up to half of survivors of severe TBE have lingering neurological problems, such as sleeplessness and aggressiveness. Many infected people are asymptomatic or only develop mild symptoms, Dobler said, so the true caseload could be up to 10 times higher in some regions than reports estimate.

While there are two TBE vaccines in circulation, vaccine uptake is low in regions where the virus is new. Neither vaccine covers all of the three most prevalent sub-types, and a 2020 study called for development of a new vaccine that offers higher protection against the virus. In Austria, for example, the TBE vaccine rate is near 85 percent, Dobler said, and yet the number of human cases continues to trend upward - a sign, in his opinion, of climate change’s influence on the disease.

In central and northern Europe, where for the past decade average annual temperatures have been roughly 2 degrees Celsius above pre industrial times (3.6 degrees Fahrenheit), documented cases of the virus have been rising in recent decades - evidence, some experts say, that rising global temperatures are conducive to more active ticks. The parasitic arachnids are also noted to be moving further north and higher in altitude as formerly inhospitable terrain warms to their preferred temperature range. Northern parts of Russia are a prime example of where TBE-infected ticks have moved north. Some previously tick-free mountains in Germany, Bavaria, and Austria are reporting a 20-fold increase in cases over the past 10 years.

The virus’s growing shadow across Europe, Asia, and now parts of the United Kingdom throws the dangers of tick-borne disease into sharp relief. The UK bicyclist who was the first domestically acquired case of the disease survived his bout with TBE, but the episode serves as a warning to the region: though the virus is still rare, it may not stay that way for long.

PHOENIX: Longtime Phoenix residents know that sweltering Julys are to be expected, but no one could have predicted the brutal heat wave that has enveloped the country’s fifth largest city this summer.

Phoenix this month shattered its record for consecutive days in which the temperature reached at least 110 degrees Fahrenheit (43.3 Celsius), standing at 26 days and counting as of Tuesday, when the forecast called for a high of 118 (47.8 C). The record was likely to grow Wednesday, with a high of 119 degrees (48.3 C) expected. A bit of relief might be on the horizon, though, after this week.

“It seems unlikely we’ll see over 110 every day through the end of the month,” said meteorologist Isaac Smith, of the National Weather Service in Phoenix. “We are expecting to see the highs fall through this weekend, with chances for monsoon rains rising to 40-50%.”

Smith said by next Monday, the high was expected to be 108 (42.2 C).

NASA power outage temporarily halts contact with space station

A NASA power outage disrupted communication between Mission Control and the International Space Station on Tuesday.

Mission Control couldn’t send commands to the station and talk with the seven astronauts in orbit. The power outage hit as upgrade work was underway in the building at Houston’s Johnson Space Center.

Space station program manager Joel Montalbano said neither the astronauts nor station were ever in any danger and that backup control systems took over within 90 minutes. The crew was notified of the problem through Russian communication systems, within 20 minutes of the outage. It’s the first time NASA has had to fire up these backup systems to take control, according to Mon-

talbano. He said NASA hoped to resolve the issue and be back to normal operations by the end of the day.

NASA maintains a backup control center miles from Houston in the event a hurricane or other disaster requiring evacuations. But in Tuesday’s case, the flight controllers stayed at Mission Control since the lights and air-conditioning still worked. (AP)

For many docs, essential oil doesn’t pass the smell test

Millions believe aromatherapy works

The history of using essential oils and their aromas to improve health and well-being dates back thousands of years. Like today, patients would inhale or topically apply these oils, which were typically extracted from plants - from leaves to flowers to roots to bark.

But not until the 1930s was this form of therapy considered to have true potential in mainstream health care. That was when Rene Maurice Gattefossé, a French chemist who coined the word aromatherapie, wrote extensively about the properties of essential oils.

Today, depending on whom you talk to, aromatherapy comprises anything from pleasant odors associated with personal hygiene and cleaning products to a serious therapy practiced by aromatherapists.

As a nurse and educator for more than 30 years, I’ve taught nursing students everything from intensive care to end-of-life support. Since becoming an aromatherapist in 2016, I’ve tried to determine how this practice could fit into the health care community and how hospitals and clinics might use aromatherapy as adjunct support for different kinds of ailments.

Aromatherapy is not approved by the US Food and Drug Administration for treatment of any medical condition. This is one reason why many clinicians are reluctant to use aromatherapy in their practice. They also say there’s not sufficient evidence to show that it works - nor do most have any training in aromatherapy.

Conversely, public acceptance of aromatherapy has never been higher. But this is not always a good thing. Al-

though information about aromatherapy abounds on the internet, many of the claims are based on personal experience. This is not scientific evidence.

Yet millions of Americans subscribe to expensive multilevel marketing strategies that seem to suggest anything and everything is treatable with essential oils. But as with any substance, there are risks as well as benefits to using them - and sometimes, the information found online neglects to mention those risks.

Though studies supporting the efficacy of aromatherapy are increasingly visible in peer-reviewed journal articles, they do not always stand up to scrutiny. In my own research, I have found that many studies on aromatherapy are flawed.

Studies

Here are just some of the problems: Exactly which essential oil was used is often not mentioned in these studies. How much essential oil was used, and for how long, is not always accurately described. The qualifications of the practitioner are frequently missing. Study participants may have a poor sense of smell, or a personal aversion to certain smells, which could skew results. The studies don’t always provide clear explanations on how they control for bias. Some have few participants, and many are done only on animals.

Also, some essential oils have many varieties; for example, some types of lavender may have calming properties, yet others are known for clearing of the sinuses. This is a critical distinction that may not be understood by the authors of these studies.

The good news: Efforts are underway to improve the quality of research, and the future for this therapy appears promising.

According to the National Cancer Institute, a growing body of studies shows aromatherapy can improve the physical, mental and spiritual well-be-

ing of cancer patients and help reduce anxiety, nausea and vomiting.

The National Center for Complementary and Integrative Health notes that essential oils may be used for insomnia, pain, anxiety and for cancer treatment - though, again, rigorous research is lacking.

Researchers are exploring whether aromatherapy can help dementia and substance use disorder patients.

A 2021 meta-analysis of clinical trials revealed that the essential oil bergamot can reduce anxiety in humans. Based on this, it is reasonable to think that using bergamot via inhalation may reduce anxiety. It is also “generally recognized as safe” by the FDA.

The Aromatic Research Quality Appraisal Taskforce was founded in 2021 and has created a checklist to assess the quality of aromatherapy studies. This is foundational work to try to get aromatherapy research up to the highest standards.

Inhalation of the essential oil often incorporates aroma sticks - small cylinder-shaped tubes about the size of a lipstick container with a wick containing essential oils - or patches worn by the patient, or diffusers using either cool water vapor or ultrasonic dispersal. For topical applications, essential oils do not dissolve in water, so use of a vegetable or other oil is necessary to dilute and decrease their concentration.

But before introducing essential oils into your life, you first have to find accurate information about them. There are professional organizations working to maintain a standard of practice for aromatherapy.

There is nothing wrong with searching for natural and clean products that might help you. This is why so many people are attracted to beautiful essential oils and their lovely aromas. Just remember that natural and beautiful does not mean they work - or that the oils are without risk. (AP)

Museum gifted art collection: A Vermont museum has acquired a more than 200-piece collection of Native American art and is planning to construct a \$12.6 million facility to house the pieces that make up a rare national collection in the Northeast.

The collection donated to the Shelburne Museum is comprised of late 19th and early 20th century pottery, beadwork, clothing and weavings predominantly from Plains and Southwest communities, and combined with its existing Native American collection represents nearly 80 tribes, the museum said.

“Together, the two collections are over 500 items and that’s a center of gravity, which is fairly important for northern New England,” said museum director and CEO Thomas Denenberg.

The 9,750-square-foot (906-square-meter) building - called the Perry Center for Native American Art - will be designed by Adjaye Associates, an internationally known firm that designed the Smithsonian National Museum of African American History and Culture in Washington, D.C. The building is slated to open in the spring of 2026 and “planned to be a highly sustainable pavilion designed to support the culturally appropriate interpretation and care of Indigenous material culture,” the museum said in a statement.

Museum officials have consulted on the project with the leaders of the four bands of the state-recognized Abenaki tribes in Vermont. (AP)

Volunteers saving whales: Volunteers worked frantically on a second day Wednesday to save dozens of pilot whales that have stranded themselves on a beach in Western Australia, but more than 50 have already died.

Nearly 100 long-finned pilot whales, stranded themselves Tuesday on the beach by the city of Albany, on the southern tip of Western Australia, south of Perth.

They were first spotted swimming Tuesday morning near Cheynes Beach east of Albany. As the day progressed, the pod began moving closer to the beach, sparking the concern of conservation officers. By 4 pm, a large stretch of the shoreline was covered in beached whales.

Reece Whitby, Western Australia’s environment minister, said it was particularly frustrating because it’s not known why the phenomenon occurs.

“What we’re seeing is utterly heartbreaking and distressing,” he told reporters. “It’s just a terrible, terrible tragedy to see these dead pilot whales on the beach.”

Fifty-two whales had perished, and volunteers are doing what they can to try and save 45 still alive, he said.

“People are committed to doing what they can to save as many whales as they can,” Whitby said.

Western Australia state’s Department of Biodiversity, Conservation and Attractions set up an overnight camp to monitor the whales.

Peter Hartley, a manager from the department, told the Australian Broadcasting Corp. that the volunteers were trying to get the living whales back into the water and encourage them to swim away.

“We are optimistic that we will save as many as we can,” Hartley said.

The team tasked with helping the whales includes Perth Zoo veterinarians and marine fauna experts. They have been using specialized equipment, including vessels and slings.

Hundreds of volunteers also offered to help - so many that officials said they had enough registered volunteers and urged other members of the public to stay away from the beach.

Drone footage released by the department showed the whales clustering and forming into a heart shape before stranding themselves on the beach.

“This is just an amazing event,” Joanne Marsh, the owner the Cheynes Beach Caravan Park told the ABC. “We’ve never seen


anything quite like this.”

Wildlife experts said the unusual behavior of the whales could be an indicator of stress or illness within the pod. Pilot whales are highly social animals and often maintain close relationships with their pods throughout their lives.

Macquarie University wildlife scientist

Vanessa Pirotta said the drone footage could suggest the whales had become disoriented, although she said the exact reasons for mass strandings remain unclear.

“The fact that they were in one area very huddled, and doing really interesting behaviors, and looking around at times, suggests that something else is going on that we just

Mets win Subway Series opener

NEW YORK, July 26, (AP): Pete Alonso homered twice and drove in a season-high five runs, Justin Verlander pitched six shut-out innings and the New York Mets beat the New York Yankees 9-3 on Tuesday night in their Subway Series opener.

Jeff McNeil had three RBIs and Francisco Lindor added three hits and three runs for the disappointing Mets (47-53), hoping for a big week that might persuade ownership not to sell at the Aug. 1 trade deadline.

Alonso and Daniel Vogelbach connected back-to-back to begin the sixth against Domingo Germán, who fell to 0-2 in four starts since throwing the 24th perfect game in major league history June 28 at Oakland.

BASEBALL

Germán (5-7) struck out nine in six innings at Yankee Stadium but was tagged for three homers and seven hits. McNeil’s run-scoring single made it 7-0 in the seventh after a throwing error by rookie shortstop Anthony Volpe.

The 40-year-old Verlander (5-5) was touched for just two hits. He struck out six and issued four walks - three to DJ LeMahieu. The three-time Cy Young Award winner is 5-0 in his last eight regular-season starts versus the Yankees.

Verlander was pulled after 98 pitches, and it took three relievers to get the next four outs. David Robertson entered with the bases loaded in the eighth and got two quick outs, leaving New York ahead 7-3 heading to the ninth.

Dodgers 8, Blue Jays 7, 10 innings
In Los Angeles, James Outman doubled in the 10th inning to score Chris Taylor and Los Angeles rallied to beat Toronto.

The Dodgers sent it into extra innings with four runs in the ninth. Taylor tied it on a two-run single with the bases loaded when Vladimir Guerrero Jr. dove but had the liner deflect of his glove, allowing both runs to score.

Mookie Betts had an RBI single and Miguel Rojas scored on a bases-loaded walk to Max Muncy to get the Dodgers within striking range.

Taylor was on second base as the automatic runner in the 10th inning. After Yonny Hernandez was unable to advance the runner, Outman hit a long drive off Mitch White (0-1) that popped out of the glove of right fielder Jordan Luplow, who jumped at the wall to try to make the catch.

BOSTON, July 26, (AP): The Boston Celtics have answered their most pressing question of the offseason. Jaylen Brown will be part of the franchise for the foreseeable future.

The Celtics’ wing has agreed to terms on a five-year supermax contract extension that will pay him up to \$304 million, his agent said Tuesday.

It’s the richest contract in NBA history, surpassing the \$264 million deal signed by Nuggets center Nikola Jokic last summer.


The deal was first reported by ESPN and confirmed to The Associated Press by Brown’s agent, Jason Glushon.

It keeps Brown with the team that drafted him third overall in 2016 and watched him develop into a two-time All-Star.

He averaged career highs of 26.6 points, 6.9 rebounds and 3.5 assists last season. But those numbers went down in the playoffs, when the Celtics lost to the Miami Heat in the Eastern Conference finals. In Game 7, Brown had 19 points on 8-of-23 shooting, making just one of nine 3-point attempts.

Still, the totality of his time in Boston has made him a key piece of the franchise’s current core that management wasn’t willing to risk seeing depart when his current four-year deal expires after next season.

By virtue of making the All-NBA second team - Brown’s first such honor in his career - he was eligible for the supermax extension.

From the moment this past season ended, Celtics president of basketball operations Brad Stevens has been adamant that he wanted to see Brown sign a long-term deal.

CALIFORNIA, July 26, (AP): Bronny James, the oldest son of NBA superstar LeBron James, was hospitalized in stable condition on Tuesday, a day after going into cardiac arrest while participating in a practice at the University of Southern California, a family spokesman said.

The spokesman said medical staff treated the 18-year-old James on site at USC’s Galen Center after he went into cardiac arrest on Monday morning. He was transported to a hospital, where he was in stable condition Tuesday after leaving the intensive care unit.

“We ask for respect and privacy for the James family and we will update media when there is more information,” the spokesman said. “LeBron and (his wife) Savannah wish to publicly send their deepest thanks and appreciation to the USC medical and athletic staff for their incredible work and dedication to the safety of their athletes.”

USC spokesman Jeremy Pepper declined a request from The Associated Press for comment or additional details, citing student privacy concerns. The AP also left a message seeking comment from the Los Angeles County Fire Department.

A representative for USC outside the Galen Center on Tuesday said the school would not have a briefing or issue a statement about James’ health scare.

Bronny James announced in May that he would play college basketball for the Trojans, whose campus is less than two miles from the downtown arena of his father’s Los Angeles Lakers. USC’s basketball team is holding off-season practices in preparation for a two-week European tour next month.

His father is the leading scorer in NBA history and a four-time champion, but Bronny James is an elite talent in his own right, establishing himself as one of the nation’s top point guard recruits before he chose the Trojans late in the commitment cycle.

Buffalo Bills safety Damar Hamlin, who suffered cardiac arrest during an NFL game last season, tweeted his support: “Prayers to Bronny & The James Family as well (prayer emoji) here for you guys just like you have been for me my entire process.”

Sports figures across the world also sent messages of support. Jayson Tatum, Trae Young and Donovan Mitchell were among many NBA stars tweeting prayers for James, while former Lakers forward Metta Sandiford-Artest wrote: “Prayers for Bronny. What a great kid. Come back stronger young fella. Get better and feel better.”

Bronny James was stricken just over a year after USC freshman 7-footer Vincent Iwuchukwu collapsed during a practice. Iwuchukwu not only survived but returned to play for the Trojans in the second half of the season.

Dr. Sameer Amin, a cardiologist and the chief medical officer at L.A. Care Health Plan, is not treating Bronny James, but he says the teenager’s move out of intensive care is encouraging.

“It’s a really positive sign that they didn’t sustain too much brain damage or any brain damage, or any major heart damage in the setting of their heart stopping,” Amin said. “Usually we see that when somebody’s heart gets restarted very quickly after it stops. Also, in young people, you tend to get these bounce-backs a lot faster. It’s a really positive outcome that he’s already out of the ICU.”

Amin said it’s too soon to speculate on whether Bronny James can return to basketball, or how quickly it could happen.

“If (the cardiac event) is happening because of a unusual blow to the chest like in the Damar Hamlin case, oftentimes those people can have a positive outcome because it’s a rare and unusual event that led to the heart stopping,” Amin said. “In those where there’s an underlying genetic problem or an underlying electrical issue, it can be a little bit more tricky to get somebody back on the playing field.”

With his family fame and huge social media following, Bronny James has the top name, image and likeness valuation in sports at \$6.3 million, On3.com estimates.

LeBron James has spoken frequently about his desire to play a season in the NBA with Bronny, the first of his three children with his wife. The elder James recently confirmed he will play his 21st NBA season in the fall with the Lakers, his home since 2018.

Bronny’s decision to stay close to home was a coup for USC, which is expected to have one of college basketball’s most compelling teams next season after making its third straight NCAA Tournament appearance last March.

Bronny, whose name is LeBron James Jr., was one of the top college prospects in the country

Mollie sets world record at worlds

Hafnaoui stars in 800 freestyle

FUKUOKA, Japan, July 26, (AP): Australian swimmer Mollie O’Callaghan picked up a knee injury about five weeks ago, described as anything from a dislocation to a simple tweak. She said it slowed her some in practice, and modified her training schedule.

But heck, what’s a little injury matter. The 19-year-old O’Callaghan broke the world record on Wednesday in the 200-meter freestyle at the world championships, clocking 1 minute, 52.85 seconds to erase Federica Pellegrini’s mark of 1:52.98 set in 2009 in the fast-suit era.

SWIMMING

“I’m just really shocked,” O’Callaghan said. “I was just expecting to have fun tonight and whatever I did I was going to be really happy. To come away with a world record is just amazing.” She also picked up a check for \$30,000, which goes to any record setter at this year’s worlds. O’Callaghan overtook Australian teammate Ariarne Titmus - she set a world record in the 400 free on Sunday - in the final 20 meters. Titmus finished in 1:53.01 and 16-year-old Summer McIntosh of Canada took bronze in 1:53.65. Here’s what O’Callaghan said she told herself over the last 50. “Right now I just need to go. I don’t care how hard it is or if it hurts. I’m just going to push and if I come last and completely die, then that’s all right. At least I gave it a crack,” she said. It took O’Callaghan a few minutes after the race to compose herself and digest the moment. “I was a wreck afterwards,” she said. “I couldn’t really explain it - those tears of happiness, very mixed

TOKYO, July 26, (AP): Bayern Munich’s president confirmed Wednesday that the club is aware of “initial talks” around a reported move for forward Sadio Mané from the German champion to Saudi Arabian club Al-Nassr, where he could team up with Cristiano Ronaldo.

“FC Bayern is informed about this,” club president Herbert Hainer said in Japan during a pre-season tour, in

quotes reported by German news agency dpa. “But these are initial talks, you have to wait and see.” His comments followed a report in German tabloid newspaper Bild that an adviser to Mané would meet representatives of Al-Nassr to discuss a possible deal. A Premier League and Champions League winner with Liverpool, Mané would be the latest in a series of big-name players in Saudi clubs’ signing spree. COLOMBO, Sri Lanka, July 26, (AP): Opener Abdullah Shafique hit a career-best 201 as Pakistan built a huge 397-run lead over Sri Lanka on the third day of the second test. Pakistan was 563-5 in its first innings at stumps Wednesday at the Sinhalese Sports Club. Shafique’s total came off 326 deliveries and contained 19 fours and four sixes. He improved on his previous best score in test cricket - 160 last year, also against Sri Lanka - reaching his first double hundred with a pulled single off Asitha Fernando, who took 3-133 in 24 overs. Soon after completing his double hundred, Shafique took on Prabath Jayasuriya (2-181) but failed to clear long-off as Dilshan Madushanka took the catch.

Pakistan won the first test in Galle by four wickets and is heading for a 2-0 sweep. advantage and we need to see how well we can wrestle back the initiative in the next two days,” Sri Lanka spin bowling coach Piyal Wijetunga said. FORT LAUDERDALE, Fla., July 26, (AP): Inter Miami co-owner Jorge Mas has one lasting memory from Lionel Messi’s debut: the image of Messi running to embrace his family after delivering the game-winning free kick and cementing a new era for the club and Major League Soccer. “That was for the fans. This community is hungry,” Mas said.

Messi’s follow-up performance Tuesday night against Atlanta United in the Leagues Cup showed the impact that one player - the right player - can have on an entire club. Messi scored twice and had an assist in his first start for Miami, bringing his total to three goals in two games. Inter Miami had a 3-0 lead by halftime, the first such lead in club history. “There’s going to be a before and after Messi in football for this country,” Mas said. Miami went on to win 4-0. Messi exited in the 78th minute to a standing ovation, with many in the crowd wearing his No. 10 jersey. Many also headed for the exits themselves once Messi was on the bench. “With the type of player that he is, it’s justified that this happens,” Miami coach Tata Martino said. “I would have preferred that the public stayed and pay tribute to the entire team, but I can also understand it.” Miami swept its group and moved on to the round of 32 in the Leagues Cup, in which it will host a to-be-determined opponent. In the eighth minute, Messi took a pass from his long-time Barcelona teammate Sergio Busquets, surged forward and sent a strike off the right post before tapping in his own rebound. Then, in the 22nd minute, Messi put Miami ahead 2-0 off a pass from Robert Taylor. “Since those two have gotten here, the spirit has changed,” Miami’s DeAndre Yedlin said, referring to Messi and Busquets. “Obviously, guys are really excited. But I think just their presence gives everybody more confidence. And I think also the teams that we’re playing against now have a bit of fear in their eyes. When those two are on the field, you know you’re in for a tough game.”



And he provided a moment fans had hoped for when the seven-time Ballon d’Or winner and World Cup champion for Argentina decided to take his talents to MLS. Messi converted the game-winning free kick in stoppage time in front of a crowd estimated at 21,000. Yedlin had placed the skipper’s armband on Messi when he checked in on Friday, but Messi entered Tuesday’s match wearing the armband just below his right shoulder. “He’s my teammate now. He’s our teammate,” Yedlin said. “He’s part of this team and he wants to win like everybody else. And he’s been a joy to be around, obviously not just on the field. He’s obviously an amazing talent but off the field he really helps a lot of the younger guys, even older guys like myself.” Brazilian midfielder Gregore had been the club’s captain before suffering a foot injury in March.

With Messi rightly commanding much of the attention from Atlanta’s defenders, opportunities opened for other Miami players. Taylor scored in the 44th minute, then made it 4-0 in the 53rd after being set up by Messi. “There’s times when the coach prepares a certain game in a certain way, but these two players are so good at what they do that they create space,” Martino said about Messi and Busquets. Goalkeeper Drake Callender preserved the shutout when he stopped a penalty shot by Thiago Almada in the 86th minute. “There are things that of course after review of the game that we can do way better,” Atlanta coach Gonzalo Pineda said. “I think we also had some chances to score. ... We couldn’t capitalize.” Messi had entered holding hands with the son of hip-hop artist DJ Khaled.

US face a tougher task against Dutch

AUCKLAND, New Zealand, July 26, (AP): The United States and the Netherlands meet again on the Women’s World Cup stage - with smaller stakes than the 2019 title game won by the Americans - and the Dutch team collecting injuries at a terrible time of the tournament. The Netherlands will most likely be without forward Lineth Beerensteyn, who was hurt early in her team’s 1-0 victory over Portugal to open the tournament, when they play the Americans on Thursday in New Zealand’s capital city of Wellington. The Americans are the two-time reigning World Cup champions and Netherlands coach Andries Jonker said on the eve of the match “we would need a miracle” for Beerensteyn to be ready to play.

“And if that doesn’t happen, then she won’t participate,” he said. The Netherlands came to the tournament in Australia and New Zealand already missing leading scorer Vivianne Miedema, who ruptured her ACL while playing for Arsenal in December. The forward is the Netherlands’ leading scorer with 95 goals. Just before the team’s first match against Portugal in Dune-din, Miedema posted a photo of herself on social media as a little girl cheering for her team. She’s cried, she said, watching the Netherlands play without her. “Although I’ve known I won’t be able to play in this World Cup for about seven months now, it’s still been pretty tough and emotional,” she wrote.

Japan, Spain move on to knockout stage

Canada hold off Ireland

DUNEDIN, New Zealand, July 26, (AP): Hikaru Naomoto and Aoba Fujino scored two minutes apart in the first half to lead Japan to a 2-0 Women's World Cup victory over Costa Rica on Wednesday, and the Japanese qualified for the knockout stage later when Spain beat Zambia.

Japan and Spain - 5-0 winners over Zambia - were the first teams in the tournament to move on to the round of 16. They are tied for the top spot in Group C with six points each, and seeding will be determined by the outcome of their Monday match.

Japan and Costa Rica kicked off in front of a sparse crowd of 6,992 at Dunedin Stadium, a huge differential from the record sales of over 1.5 million tickets for this year's tournament. High fan turnout in Auckland and Sydney - there were 117,000 combined at opening night in those cities - have been partly offset by much smaller crowds in Dunedin, where attendance has dropped with each match from an initial high of 13,711.

Las Ticas kept the pressure high throughout the match, but the Japanese dominated with precision in ball handling and passes.

Mina Tanaka passed the ball to Naomoto, who dribbled past a Costa Rican defender before scoring on outstretched goalkeeper Daniela Solera in the 25th minute. Fujino then snuck the ball in on an angle into the far left corner of the net. Costa Rican defenders Maria Paula Elizondo and Mariana Benavides failed to stop Fujino from scoring.

Japan came close to scoring earlier in the match off the rebound of a save by Solera. Hinata Miyazawa collided with Japanese teammate Aoba Fujino as they both went in for the kick, causing them to miss the shot.

Costa Rican midfielder Raquel "Rocky" Rodriguez, the star of the team, didn't come into the game until midway through the second half. She missed her team's last match against Spain due to an undisclosed injury.

Solera went down midway through the second half after taking a shoulder to the head, but she remained in the game.


Japan has now qualified for the knockout stage for the fourth time in the nation's history.

Japan won the tournament in 2011, beating the United States, and lost to the Americans in a rematch in 2015.

Costa Rica was eliminated from contention with its second loss of the group stage.

"There are some players who are at the World Cup for the first time, but they are so energetic and that makes me so happy. The team is working together as one unit," Japan head coach Futoshi Ikeda.

"Honestly, it makes me a little emotional because, I don't know, sometimes people within our own country, they're the harshest critics for us. But to see people who come and support (us) all the way, it means the world to us," Rodriguez on fan support for Costa Rica.

Spain 5, Zambia 0

In Auckland, Jennifer Hermoso scored twice and assisted in her 100th international appearance to push Spain past Zambia.

Hermoso, Spain's all-time leading scorer, deposited a one-time header off a perfect cross from Alexia Putellas in the 13th minute. She then gathered a rebound and scored on an empty net in the 70th minute. The goal was initially wiped away for offside, then eventually confirmed after a lengthy review.

Teresa Abelleira launched a 58-mph strike from well outside the box in the ninth minute and beat Eunice Sakala to the top side of the net, her second goal with the Spain national team.

Like Hermoso, Alba Redondo also scored twice, in the 69th and 85th minutes. Her first goal was an impressive run off of a long pass, while her second was on a rebound in front of an empty net.

Spain's attack benefitted from facing Zambia's third-string goalkeeper. Sakala started Monday night after the starting goalie and her backup were injured and received a red card, respectively.

The game was played before 20,983 fans in chilly Eden Park, the lowest attendance of the four games played so far in New Zealand's largest city.

Barbra Banda registered Zambia's first shot on goal of the tournament in the eighth minute, a good chance to turn early momentum toward the Copper Queens. Spain's Misa Rodriguez saved the rolling shot.

Abelleira scored in the next minute, and Spain held a clear advantage through the rest of the match.

Costa Rica are eliminated from advancing out of Group C.

Canada 2, Ireland 1

In Perth, Canada recovered from conceding directly from a corner kick to seal a come-from-behind 2-1 win against Ireland.

Adriana Leon's second-half strike at Perth's rain-soaked Rectangular Stadium boosted Olympic champion Canada's hopes of advancing to the round of 16 by moving to the top of Group B.

Defeat for Ireland saw it eliminated from the tournament after back-to-back losses on its first appearance at a World Cup.

Bach invokes John Lennon's memory

Paris marks 1-year countdown to Olympic Games

PARIS, July 26, (AP): The president of the International Olympic Committee on Wednesday formally invited the world's nations but not Russia or its military ally Belarus to gather in one year in Paris for the Olympics - launching the final countdown to the 2024 Games against the backdrop of war in Ukraine.

IOC president Thomas Bach accompanied his invite with a plea for togetherness and invoked the memory of John Lennon as he argued that "our fragile world, with conflicts, divisions and wars rising," needs the Olympics' "unifying power more than ever."

"The Olympic Games must always build bridges. The Olympic Games must never erect walls. Imagine. You may say we are dreamers. We are not the only ones," Bach said, borrowing from Lennon's famous peace anthem, "Imagine."

Bach has heaped praise on Paris' preparations this week as the French capital marked the year-to-go milestone to the opening ceremony on July 26, 2024.

"Paris is maybe at this stage the best-prepared city ever," Bach said.

Without the usual worries about whether Olympic venues will be ready, the biggest unknown this time is whether Bach and the IOC will let athletes from Russia and Belarus compete.

In Paris this week, the IOC president has not deviated from his line that there may be a pathway for some of them to compete as "neutral athletes," without their countries' flags, names or colors, but that the

final decision will come later.

"There's still one year to go," Bach said Wednesday. "We have not taken any decision about the participation of individual neutral athletes yet."

The sending out of formal invites for national Olympic committees and their best athletes to take part in the July 26 to Aug. 11 Olympics is an IOC tradition to mark the year-to-go milestone of both Summer and Winter Games. This time, 203 NOCs are getting them. Some picked up their invites from Bach in person Wednesday at a ceremony at the Paris Games headquarters. An invite also went to the IOC's team of refugee athletes.

Guatemala joined Russia and Belarus on the list of NOCs that aren't invited. Guatemala is suspended from the Olympic movement because of alleged government interference with the independence of its NOC.

Other year-to-go events this week have been less formal than the ceremony where Bach spoke about Olympic values and where a violinist played France's national anthem and Lennon's "Imagine."

On a visit to the Olympic village that will house many of the 10,500 Olympians and 4,400 Paralympic athletes, Bach got to test one of the cardboard beds they'll sleep on. Cardboard beds were also used at the pandemic-delayed Tokyo Games in 2021 and became something of a hit when athletes posted videos of themselves testing their durability.

"I can assure them that they will sleep very well in these beds," Bach said.

He also rubbed shoulders with eight-time gold-medal winner Usain Bolt, who was the star guest

World swim body re-elects Al-Musallam for 8 years, agrees to move to Hungary

FUKUOKA, Japan, July 26, (AP): Swimming officials gave World Aquatics president Husain al-Musallam an eight-year mandate on Tuesday to lead them and backed his plan to move the organization's headquarters to Hungary, where the government has offered a 15-year rent-free deal and legal protection.

The election on the sidelines of the world championships in Japan resets al-Musallam's presidential term in reforms enacted after he was first elected unopposed two years ago. The reforms allow for two terms - the first for eight years and a second for four years.

The Kuwaiti official now can be in office through 2031, taking in the Paris Olympics next year and the 2028 Los Angeles Olympics, with the possibility then to seek a final four-year term ending in 12 years' time.

zerland - which has been its home for 37 years - to the Hungarian capital before the swim worlds returns to Budapest in 2027.


