Kuwaitis vote with hopes for reform

Non-governmentals to monitor poll

KUWAIT CITY, June 5: Kuwaiti eligible voters are set to flow to polling stations nationwide tomorrow (Tuesday) in order to elect a new National Assembly (Parliament), pinning high hopes that the country's aspired reforms and development would be notched up.

As many as 793,646 eligible voters involving 386,751 males and

406,895 females are poised to pick 50 out of 207 candidates to represent them at the new legislature for a term of four years.

Vote centers will open at 8:00 am local time (5:00 GMT) and close at 8:00 pm local time (5:00 GMT). Vote counting will begin immediately at polling places. The fresh electoral race followed an order made in May to dissolve the former parliament "only out of respect for the people's will and return to the nation, which is the source of all power and authority'

Another edict was then announced, calling on voters to stand prepared to cast their ballots in a new electoral process slated for June 6 (Tuesday).

Thirty-four male and female rivals are vying in the Fist Constituency, where there are a total of 99,779 eligible voters, including 48,348 males and 51,431 fe-

The Second Constituency has 45 male and female candidates contesting the race to win the votes of 90,394 people (44,289 males and 46,105 females).

There are 34 hopefuls, both males and females, in the Third Constituency, which has 137,978 voters (66,226 males and 71,752 females.

Forty-seven male and female candidates are competing for the votes of 208,740 people (100,832 males and 107,908 females) in the Fourth Constituency.

The Fifth Constituency includes 47 rivals and 256,755 eligible voters (127,056 males and 129,699 females).

ISTANBUL: NATO Secretary-General Jens Stoltenberg made no breakthrough on Sunday in talks about Sweden's membership in the military organization with Turkish President Recep Tayyip Erdogan, with officials from the two countries to meet in just over a week to try to bridge their differences.

NATO wants to bring Sweden into the fold by the time U.S. President Joe Biden and other allied leaders meet in Lithuania on July 11-12, but Turkey and **Hungary** have yet to endorse the move. (AP)

PESHAWAR: Pakistani troops and militants exchanged fire in a northwestern region along the border with Afghanistan in a shootout that killed two soldiers and two militants, the army said Monday.

The shootout took place late Sunday in North Waziristan, a district in Khyber Pakhtunkhwa province that is a former stronghold of the Pakistani Taliban, a militant group also known as Tehreek-e-Taliban Pakistan or TTP. (AP)

JERUSALEM: A Palestinian toddler who was shot by Israeli troops in the occupied West Bank last week died of his wounds, Israeli

hospital officials said Monday. Mohammed al-Tamimi was shot in the head last Thursday near his village of Nebi Saleh while riding in a car with his father. He was airlifted to Israel's Sheba Hospital, which announced the 2-year-old boy's death. (AP)

Maduro welcomed

TEHRAN, June 5, (Agencies): Iran's foreign ministry announced it would reopen its diplomatic missions in Saudi Arabia this week, restoring diplomatic ties after a seven-year rift, state-run media reported on Monday.

The foreign ministry's spokesman, Nasser Kanaani said that the Iranian Embassy in Riyadh, its consulate general in Jeddah, and office of the permanent representative to the Organization of Islamic Cooperation would officially reopen on Tuesday and Wednesday.

In March, Iran and Saudi Arabia agreed to establish diplomatic ties, in a Chinese-brokered deal, representing a major breakthrough in the region.

Saudi Arabia broke ties with Iran in 2016 after protesters invaded Saudi diplomatic posts in Tehran and the northeastern city of Mashhad during demonstrations triggered by the execution of a prominent Shiite cleric and 46 others in the oil-rich Kingdom. Kanaani added that Iran's Embassy in Riyadh and

its consulate general in Jeddah had already begun operating to help Iranian pilgrims heading to Saudi Arabia to perform Hajj, or Islamic pilgrimage, set to commence by the end of June. Saudi Minister of Foreign Affairs Prince Faisal

bin Farhan bin Abdullah last week met with his Iranian counterpart Hossein Amir-Abdollahian in Cape Town, South Africa, on the sidelines of the Ministerial Meeting of Friends of BRICS Group. They explored ways to enhance the bilateral re-

lations in various fields, and reviewed the steps to implement the agreement between the two countries signed in Beijing, the Saudi Press Agency (SPA) re-Both sides also discussed ways to ensure peace

DUBAI: Saudi Arabia has welcomed Venzuelan President Nicolas Maduro on an official visit, reaching out to yet another U.S. foe as the oil-rich kingdom engages in a flurry of diplomacy.

Maduro arrived late Sunday in the Red Sea city of Jeddah, where he was greeted by Saudi officials, according to the state-run Saudi

Press Agency.

It did not give a reason for the visit or elaborate on his schedule, but Saudi Arabia is hosting an international conference on combating extremism later this week in the capital, Riyadh. The gathering will be co-chaired by U.S. Secretary of State Antony Blinken.

Saudi Arabia has been a close U.S. ally for decades, but rela-


tions have been strained in recent years. Over the last few months, the kingdom has restored relations with Iran's theocracy and Syria's President Bashar Assad - both seen as pariahs in the West

Last month, the Saudis welcomed Ukraine's President Volodymyr Zelenskyy, a close Western ally, to an Arab League summit. But days later, they hosted a senior Russian official who is under Western sanctions.

The Saudis say they are pursuing their own national interests in a world increasingly defined by great power competition. Experts say the diplomatic surge is aimed at shoring up regional stability and improving the kingdom's image as it seeks international investment for massive development

Maduro was re-elected in 2018 after judges banned his main opponents from competing, plunging the country into a severe political and economic crisis. Most opposition parties refused to recognize the election results and challenged Maduro's rule by creating an interim government, a push for change that fizzled out over the past

Washington backed the opposition and imposed heavy sanctions on Maduro's autocratic government, hoping that would spark change. But Maduro's government dug in and resisted the sanctions with support from Russia, Turkey and Iran.

Guard fast-attack boats 'harassed' ship

The U.S. Navy said Monday its sailors and the United Kingdom Royal Navy came to the aid of a ship in the crucial Strait of Hormuz after Iran's Revolutionary Guard "harassed" it.

Three fast-attack Guard vessels with armed troops aboard approached the merchant ship at a close distance Sunday afternoon, the U.S. Navy said in a statement. It offered black-andwhite images it said came from a U.S. Navy Boeing P-8 Poseidon overhead, which showed three small ships close to the commer-

The U.S. Navy's guided-missile destroyer USS McFaul and the Royal Navy's frigate HMS Lancaster responded to the incident, with the Lancaster launching a helicopter.

"The situation deescalated approximately an hour later when the merchant vessel confirmed the fast-attack craft departed the scene," the Navy said. "The merchant ship continued transiting the Strait of Hormuz without further incident."

The Strait of Hormuz, the narrow mouth of the Arabian Gulf, sees 20% of the world's oil pass through it. (AP)

Kuwait commends OPEC+ decision

Oil output cuts extended till 2024 end

VIENNA, June 5, (Agencies): Oil ministers of the OPEC and non-OPEC oil producing alliance, known as OPEC Plus, extended on Sunday the participating countries voluntary oil crude production cuts till end of 2024.

In a press statement following their meeting in Vienna today, the ministers said they decided to "adjust the level of overall crude oil production for OPEC and non-OPEC Participating Countries in the Declaration of Cooperation (DoC) to 40.46 mb/d, starting 1 January 2024 until 31 December 2024".

They argued that the move was taken in light of the continued commitment of the alliance to achieve and sustain a stable oil market and to provide long-term guidance for the market.

"And in line with the successful approach of being precautious, proactive, and pre-emptive, which has been consistently adopted by OPEC and non-OPEC Participating Countries in the DoC," they added.

The ministers extended the mandate of the Joint Ministerial Monitoring Committee (JMMC) and its membership, to closely review global oil market conditions, oil production levels, and the level of conformity with the DoC and this Statement, assisted by the Joint Technical Committee (JTC) and the OPEC Secretariat.

They pointed out that the JMMC would hold a meeting every two months and the OPEC and non-OPEC Ministerial Meeting (ONOMM) would be held every six months.

They granted the JMMC the authority to hold additional meetings, or to request an OPEC and non-OPEC Ministerial Meeting at any time to address market developments, whenever deemed necessary.

The ministers re-affirmed that the DoC conformity is to be monitored considering crude oil production, based on the information from secondary sources, and according to the methodology applied for OPEC Member Countries.

They reiterated the critical importance of adhering to full conformity, and subscribe to the concept of compensation by those countries who produce above the required production level, in addition to their already decided production levels.

The ministers said the 36th OPEC and non-OPEC Ministerial Meeting would be held on Sunday 26 November 2023, in Vienna.

Meanwhile, Kuwait will continue its voluntary oil output reduction by 128,000 bpd until the end of 2024, Minister of Oil Manaf Al-Hajri

This voluntary cut comes as a precautionary

measure taken in coordination with the countries partaking in the OPEC+ deal on the decrease announced last April, Al-Hairi, also Minister of State for Economic Affairs and Investment and Acting Minister of State for National Assembly Affairs, added in a statement issued by the Ministry of Oil.

This reduction will be from the output level agreed upon in the 35th ministerial meeting of the OPEC held earlier in the day. Al-Hairi, also Chairman of the Board of Directors of the Kuwait Petroleum Corporation, stressed. Kuwait's Minister of Oil Manaf Al-Hajri Sun-

day lauded the decision made by the OPEC+ group on reducing oil output by two million bpd until the end of 2024.

The decision is in favor of market balance and offers required reassurance, Al-Hajri, also Minister of State for Economic Affairs and Investment and Acting Minister of State for National Assembly Affairs, made the statement issued by the Oil Ministry.

Al-Hajri, also Chairman of the Board of Directors of Kuwait Petroleum Corporation, headed Kuwait's delegation to the 186th OPEC ministerial meeting held Saturday and the 35th OPEC and non-OPEC producing countries held in Vienna earlier in the day.

Upgrade seeks to counter China

US, India agree to cement defense ties during meeting

NEW DELHI, June 5, (Agencies): India and the US agreed on Monday to cement their defense relationship after holding extensive talks on se-

curity issues. The Indian Defense Ministry said in a statement that its minister Rajnath Singh held bilateral meeting with US Secretary of Defense Lloyd Austin who arrived in New Delhi yesterday on a two-day official visit.

Both the ministers discussed several bilateral defense cooperation issues with special focus on ways to strengthen industrial cooperation.

"The two ministers' explored ways of building resilient supply chains. Both sides will identify opportunities for co-development of new technologies and co-production of existing and new systems and facilitate increased collaboration between defense start-up ecosystems of the two countries," the ministry said.

It also added that both the countries concluded a roadmap for US-India Defense Industrial Cooperation which will give a clear policy direction in the defense sector for the next few years.

"Both sides reviewed the robust and multifaceted bilateral defense cooperation activities and agreed to maintain the momentum of engagement. They welcomed the inaugural dialogues held recently focusing on Defense Artificial Intelligence and Defense Space," the statement

Peace and stability in the Indo-Pacific region and other regional security issues were also tak-

en up during the discussion. In the meeting Indian Chief of Defense Staff General Anil Chauhan, Defense Secretary Giridhar Aramane and Secretary, Department of Defense R&D and Chairman Defense Research and Development Organization Samir V Kamat were

The visit of US Secretary of Defense assumes importance as India and the US are firming up their regional security understanding especially through QUAD and other multinational bodies which China suspects is aimed at countering its increasing regional and global influence.

Austin on Monday discussed upgrading partnership with India, a major arms buyer, and set a roadmap for cooperation for the next five years as both countries grapple with China's economic rise and increased belligerence, officials said.

Austin's visit comes as India strengthens its domestic defense industry by acquiring new technologies and reducing reliance on imports, particularly from Russia, its largest supplier of military hardware despite the ongoing war in

Schools admission hits crisis

'Not allowed to violate student density'

KUWAIT CITY, June 5: Some parents are facing a crisis in registering their children in some private schools for the 2023/2024 academic year. They have been placed in waiting lists, after being told that the capacity in these schools are limited and the registration process is limited by some regulations, reports Al-Rai daily.

According to an official source in the General Administration of

'Hot, dry, dust-laden winds'

'Al-Bawareh' and unstable weather

KUWAIT CITY, June 5: The Meteorological Department of the Directorate-General of Civil Aviation said Kuwait witnesses what is known as the Al-Bawareh season, which starts from the second week June and continues until mid-July, reports Al-Jarida

Dr. Hassan Dashti, observer at the DGCA Met department told KUNA today, the Al-Bawareh winds are seasonal and are known as the beginning of the summer season, as they are followed by a very hot, dry weather and frequent hot, dustladen winds making the weather condition throughout this period unstable, reports Al-Jarida daily.



He added the desert climate of Kuwait is characterized by a long summer period, high temperatures, long hours of daily solar radiation, and an increase in rate of evaporation, and it begins clearly with the beginning of June, in which the high air recedes and the Indian seasonal depression advances with its expansion to Africa and continues until the end of next September.

He indicated the average wind speed is between 50-60 kilometers per hour, and its gusts may exceed 90 kilometers per hour, causing dust to rise, which causes a decrease in horizontal visibility.

He stated the region has witnessed in recent years an increase in the frequency of dust storms associated with the Al-Bawareh winds due to the lack of rainfall, the dryness of the soil, the lack of vegetation cover and the fragmentation of the soil. Dashti warned of the negative effects of these dust storms, which require finding quick scientific and practical solutions and mitigating them or adapting to their negative effects, especially amid the climatic changes taking place in the region.

Nod to allowance: The Civil Service Commission in the Ministry of Health, has given the final nod to grant infection allowance to Kuwaiti civilian employees working at the Airport Security, the Airport Passports departments of the Directorate-General of Civil Aviation and employees of the General Administration of Land Ports Security, who are in charge of completing entry, exit and fingerprinting procedures for travelers at the Al-Nuwaiseeb, Al-Salmi and Abdali ports", reports Al-Jarida daily.

The CSC approval came based on the proposal submitted by the First Deputy Prime Minister, Minister of Interior and Acting Minister of Defense Sheikh Talal Al-Khaled, who asked for the speedy completion of the disbursement procedures for the beneficiaries, reports Al-Jarida daily.

Private Education, some private schools already have high student densities, while others seek to maintain the quality and distinction of their educational system by organizing admission tests for new students. In both cases, the administration cannot oblige these schools to register students, as they have special regulations and conditions that determine the admission process.

The source said, "The Ministry of Education has set the density ceiling in each educational system. Any transgression in this regard is not permitted and is considered a violation that is recorded on the school, for which

legal measures are taken.".

He explained that the ministry excluded some schools from the density ceiling during the last academic year due to the fact that no new schools were opened during the COVID-19 crisis, including Arab and model schools. In Arab schools, there are more than 42 students in one class, and in model schools, there are more than 28 students in one class. This situation is exceptional due to the lack of investment in this system.

The educational systems are many and varied. Parents an register in other schools despite the difference in their tuition fees. Schools are not obligated to register old students who fall behind the deadline set for the end of registration. A student is not considered registered if he does not pay the registration fees for the next academic year. All schools set their registration dates and publish them either by text messages, e-mails, or by posting bulletins at their

The source attributed the apology of some schools for the non-registration of students to the severe shortage of human cadres working in them, including cleaning workers and educational and administrative bodies.

In this regard, President of the Foreign Schools Union Nora Al-Ghanim affirmed that the reasons for this are many and varied, including the presence of great pressure.

Adhere

She said these schools are closed because of student densities, or because schools adhere to a specific number of students per class, or are unable to open additional classes due to a shortage of teachers or the small spatial capacity of the school itself.

Al-Ghanim stressed that these schools cannot have overcrowded classrooms; otherwise they will lose the recognition of the international oversight bodies.

She explained that, "The solution lies with the responsible government agencies, including the Ministry of Finance and the Ministry of Education, in granting distinguished private schools, regardless of their educational system, whether it is typical Arab or foreign, to approve expansion. This is better than granting new licenses to other schools that may take time to prove their excellence and the quality of their educational system.

Schools do not prevent students from getting admitted if they were able to accept them. However, each school has special circumstances that prevent it from doing so. The elements of school success lie not only in a good teacher or curriculum and good management, but also in other factors that contribute to success, including the number of students in the class.

A class that has 20 to 25 students is not the same as one with 40 to 45 students. The educational quality will certainly differ, especially with the significant increase in student demand for private schools in recent years.

Furthermore, Al-Ghanim explained that investing in education has become repellent instead of being attractive to many investors. This is because many obstacles and decisions are placed before them, making them ponder many times about investing in this field or in another field that brings a greater return. Investment in education, if it does not stem from an educational thought, affects the general social interest over private commercial interest, and the school will not be as distinguished as it will be.

Some distinguished foreign schools have set conditions for accepting students, including passing a placement test in order to maintain the quality of their educational system in compliance with the standards and controls approved by international bodies. Some cannot accept an additional number that exceeds their capacity due to their commitment to a specific number of students per semester. Any increase in this number is unacceptable and damages the reputation of its educational system.

In addition, an educational source stressed the necessity of facilitating government procedures regarding the issuance of licenses and granting the necessary approvals for the vertical and horizontal expansion of distinguished private schools, especially in residential areas that suffer from a small number of schools.

He highlighted that there is a great demand from Kuwaiti students to enroll in private schools.

The daily added, the applicant must bring along the original civil card or a recent certificate issued by the Public Authority for Civil Information and 4 personal photos measuring 6x4, during official working hours.

The administration added, no one wil be allowed to cast the ballot without the original Kuwaiti nationality certificate or a replacement for a lost or damaged document is obtained.

Meanwhile, around 3,500 trainees, officers and non-commissioned officers are eligible to vote in the upcoming parliamentary election; since their names are included in the lists of voters, reports Al-Rai daily quoting sources.

Sources confirmed this is legal, given that the abovementioned citizens have yet to complete their courses and no decision has been issued regarding their appointment as military personnel.

Sources clarified that all those enrolled in military colleges under the ministries of Defense and Interior are allowed to vote, because they have not graduated from the colleges.

'Hospitals in Kuwait should be managed with int'l expertise'

"IF YOU are very ill, you have no choice but to visit a hospital in Kuwait and unfortunately you may not come out much better. In fact, in some cases for the elderly and other people with chronic problems, complications from the disease can lead to death," columnist Dr Youssef Abdul Mohsen Al-Haroun wrote for Al-Qabas daily.

'We have heard many stories from relatives, friends and others of how a loved one could have been hospitalized and doctors prescribe broad spectrum antibiotics not knowing exactly what the problem is but hoping this might fix it.

"This may work for some patients but may put other patients in worse conditions. They may have allergic reactions to these medi-

"Then the medical team tries to solve the problem they created by performing surgery or putting patients on ventilators which eventually leads to death. Or they develop hospital-acquired infections, which contribute significantly to illness and death, affecting up to 30 percent of ICU

"So why do hospitals make us more sick? Why do hospitals make us more likely to die? The main reason for this is - far from generalizing - a combination of hospital mismanagement, negligence of physician and nursing care, and finally bad architectural design.

"There are good doctors and great nurses who are praised for their hard work and giving to improve people's lives for the better.

"However, there are also some who don't care and don't do their duty diligently. I call on the Ministry of Health in all its sectors to employ qualified Kuwaitis or foreign doctors who graduated from the best universities and have strong experience in their fields.

"Don't hire bad doctors! You deal with people's lives, parents and children. Likewise, hospitals must be managed with international expertise with decades of experience, not local individuals who do not know how to manage. Management is an art and not every good doctor has the ability to run a hospital.

"What is the point of building billions of hospitals across Kuwait with poor management? It's like buying a fancy and expensive car and giving it to someone who doesn't know how to drive it. It will lead to an accident in the end.

"Hospitals are among the most expensive facilities to build, with complex infrastructure, technologies, systems and safety rules. But the evidence suggests we've built them all wrong — and that the shortcomings aren't simply

"All of these design flaws could kill us. There is also a lot we can do to improve the patient experience, which, of course, is closely related to how comfortable and well patients are.

"Some of the most interesting research on the way hospitals are built points to nature's role in promoting healing. The research, spearheaded by Roger Ulrich, now a professor of architecture at the Health Care Building Research Center at Chalmers University of Technology in Sweden, suggests that when it comes to recovery from illness, the more nature the better.

"But all too often, patients and doctors find themselves trapped in dark rooms and sterile corridors with little natural light or views of nature: too much concrete, not enough jungle and trees.

"Some research has studied patients who recovered after surgery based on whether they were assigned to a room with a window facing nature or a wall. "The study, now one of the most widely cited in the hospital design literature, found that patients looking at trees had shorter hospital stays and took less pain

medication than those viewing a wall. "We need to completely rethink how we care for health and patients in Kuwait, introduce more natural sunlight and green spaces in and around hospitals and more environmental psychology approaches to make people more positive

and thus speed up recovery, God willing. "I hope that one day the government and the Ministry of Health will take people's lives seriously not only by building new hospitals, but how to design them, put the right person in the right place in their management, and choose only the best in the world to work in them to serve everyone who lives in this

"So the next time we really need to go to the hospital, we can really feel safe and, God willing, feel better. Until that happens, we have nothing but supplication. Oh God, change the conditions, change our situation to the best."

Also:

"A referendum is a healthy process that usually accompanies elections in advanced democracies. It comes with very important conditions to achieve the goal, hence, it is not considered a tool for negatively influencing the course of elections — a crime severely punished by the Kuwaiti law," columnist Sami Al-Nisf wrote for Annahar daily.

"The first conditions of an honest referendum are laid down by parties known for their impartiality. For example, it is not permissible for profitable or biased

parties to be entrusted with the referendum, since they will maneuver the process for the benefit of those they support, pay for or believe in.

"It is also necessary to ensure the scientificity and transparency of the sample

of participants, so the result reflects the constituency concerned. It is important as well to clearly indicate the number of members of the segment before determining the percentage obtained by each candidate.

"Therefore, choosing a sample of 20 voters in a constituency whose total number of voters is tens or hundreds of thousands will definitely mislead the voters and the observers, because a candidate who gets only two votes will appear as if he has a double chance of winning compared to the one who gets one vote from the sample. This is misleading because the percentage drawn from such a very small number means nothing at all."

"We are going through days of a lot of talk about the political issue, given the general condition of the State, individuals, societies, and government and private institutions, as well as the upcoming 2023 National Assembly election," columnist Abdulrahman Aba Zera wrote for Annahar daily.

"Social mobility characterizes the State of Kuwait, considering the large space that the government sometimes gives to the candidate to present his sup-

"Undoubtedly, the voter could be affected by this general condition of the State, as the political arena might become a large space and a wide arena for rumors, gossip, false promises and the adoption of issues without the slightest knowledge of these issues - neither the candidate nor the voter. Thus, psychological chaos is formed for everyone associated with such a confusing scene, which may directly and indirectly affect the individual, in addition to our collective attitude

"It is the duty of a fully sane citizen, who knows his rights, to express his aspirations by choosing his representative in this scene for a period of four years. The State has enabled him to exercise his democratic right. He must know who he chooses, how he chooses and why he chooses this or that candidate.

"In this manner, our thoughts are not based on negative choices that reflect on our psychological state. This psychological crisis may accompany us for four years, so we must choose carefully. We should not be courteous in choosing who will represent us, and become part of our future aspirations and the visions we aspire to achieve in order to serve the people and the country."

680 Asians, Africans from 8 nations ousted in 3 days

New biometrics center opened

KUWAIT CITY, June 5: The Public Relations and Security Media Department of the **Ministry of Interior** said 680 expatriates belonging to eight Asian and African countries have been administratively deported to their respective countries within three days, from May 27 to May 29, reports Al-Oabas daily.

The security sources told the daily, the deportees were held at the Talha Prison and that before being deported they were fingerprinted and photographed and all procedures related to their deportation process were completed within a record time and flown out of the

country. The reasons for their deportation varied between administrative deportation and verdicts issued by the criminal court, in addition to those caught for violating the residence and labor

laws. sources indicated that the deportation of this large number of expatriates in just 3 days is seen as the first in recent years in terms of numbers, which confirms the deportation prison works for the speedy completion of deportation procedures to ensure deportees don't stay behind bars for long periods unlike what used to happen a few years back.

New center opened: Director for Human Resources and Information Technology at the Interior Ministry Sheikh Mubarak Salem Al-Ali recently inaugurated the biometric fingerprint center at the Police Force Affairs General Department in Mubarak Al-Abdullah, reports Al-Rai daily.

The center operates 24 hours a day to serve the ministry's employees and their immediate families.

'Avoid airborne gases, dust and fumes'

'Pollution causes cancer, heart disease'

KUWAIT CITY, June 5: In reaction to a report titled "Air pollution in residential areas threatens health" that was published recently, health experts affirmed that pollution in general and inhalation of some types of fumes and gases may cause lung cancer, heart disease, and other illnesses, reports Al-Oabas daily. These experts said some diseases

caused by continuous exposure to pollutants may not show symptoms in the They stressed the need to tighten

control for improving air and water quality, and protecting the environment from pollution. In this regard, gastroenterology,

internal medicine, liver and endoscopy consultant Dr Ghanem Al-Salem warned against direct exposure to toxic fumes and gases in the event of their spread in any oil or other areas, after the concerned authorities announce their presence, in order to ensure the preserva-

tion of public health for citizens and residents. She explained that the most prominent diseases associated with environmental and air pollution that last for several years are chronic obstructive pulmonary disease, lung cancer, cardiovascular disease, pulmonary fibrosis, stomach and pancreatic cancer, and eye infections. Exposure to polluted air can render pregnant women more vulnerable to the risks of premature birth. The risk ratios diminish with a decrease in the period of exposure to polluted atmospheres in the vicinity of the areas.

Dr. Al-Salem advised workers who are exposed to polluted air to avoid exposure to airborne gases, dust and fumes. She insisted that children, the elderly, and people suffering from asthma, chronic obstructive pulmonary disease and other lung disorders should avoid outdoor exercise when the air contains high levels of pollutants, based on the announcement of reliable government sources in the country at the

Dr. Al-Salem stressed the need to stay home until the air quality improves in the event of pollution, as well as ensure the house is clean, ventilated constantly, and are free of dust, in addition to using specialized devices to detect the accumulation of carbon monoxide gas in homes, if possible.

She also stressed the need to follow the instructions of the Ministry of Health and the concerned authorities in this

Dr. Al-Salem highlighted the keenness of Kuwait about transparency and publishing important information in this field on official websites, documented newspapers and official social networking sites

In addition, Assistant Professor of Environmental Studies at the International College of Law, Dr. Muhammad Al-Aimi affirmed the need to address the problems of environmental pollution in the country in order to pre-



'Valid ID card mandatory'

KUWAIT CITY, June 5: The Central System for Remedying the Status of Illegal Residents (CSRSIR) informed the Ministry of Education and the Ministry of Higher Education to suspend dealing with transactions of Bedoun residents except for those holding a valid identification/security card, reports Al-Qabas

According to informed sources, CSRSIR stressed the need to return to the previous decision, as per which no transaction pertaining to the Bedoun residents will be completed without the presence of a valid security card issued by CSRSIR.

The three-month period for the exception issued by the Council of Ministers for the exclusion of expired card holders from completing their transactions in the Ministry of Education, Ministry of Higher Education and Ministry of Health has passed, due to which it is necessary to return to the decision which was issued prior to the exception.

CSRSIR demanded the Ministry of Education and the Ministry of Higher Education to instruct the concerned authority to notify 31 Bedoun employees regarding the need to visit the CSRSIR office in order to take the necessary procedures according to their legal status and obtain valid cards, as well as the need to complete the procedures for renewing their

Envoy affirms strength of bilateral relations between Russia, Kuwait

New ambassador briefs press after presenting his credentials

KUWAIT CITY, June 5: The Ambassador of the Russian Federation Vladimir Zheltov affirmed the strength of the bilateral relations between his country and Kuwait, reports Al-Qabas daily.

In his first interview with the local press after presenting his credentials, he praised the Kuwaiti policy, which he described as "wise, balanced and pragmatic."

The ambassador said, "We noticed that the current Kuwaiti leadership has continuity and persistence in approaching conflicts between all major countries in the world without any exception.

Kuwait is one of the first Arab countries to recognize Russia. Even during the days of the Cold War, the days of friction and competition between the two poles, the Kuwaiti leadership did not put eggs in one basket. This is a balanced, pragmatic and wise policy."

Respect

He expressed his country's respect for this approach and for Kuwaiti politics.

Ambassador Zheltov affirmed his keenness to strengthen the political, economic, humanitarian, military and technical files, highlighting that the Russian-Kuwaiti political dialogue is still ongoing, and there is a mechanism for political consultation.

He stressed that Kuwait's Ministry of Foreign Affairs is concerned with dialogue with all parties in the world.

The ambassador revealed that the third session of the Russian-Gulf dialogue will be held in July in Moscow, with Kuwait's participation in it.

He affirmed that his country was and will remain on the side of Arab friends, and has

principled positions on the basic issues of the Arab world, especially the Palestinian issue and the Arab-Israeli conflict.

Ambassador Zheltov said, "Russia is an important country for Kuwait, so nothing could affect our relationship from any external side. In the former Soviet-Kuwaiti and the Russian-Kuwaiti relations, the Kuwaiti side attached great importance due to the balanced and pragmatic policy. This is the main message that I extracted from my meeting with the Crown Prince which took a third of an hour and during which the focus was solely on the bilateral relations."

Exemption

Regarding Kuwait's position with Russia in the Ukrainian crisis, he reiterated that Kuwaiti policy is balanced, pragmatic and wise, adding, "Irrespective of the external pressures, Kuwait still practices a neutral policy regarding what is going on in Ukraine." Regarding the mutual agreement for visa exemption, Ambassador Zheltov said, "We are in the process of attracting tourists to Russia. We are working on a policy for canceling visas with countries that bring tourists.

There are countries in the Arabian Gulf, such as the UAE, Oman, Saudi Arabia and

Kuwait for which we are interested in canceling entry visas not only for holders of diplomatic and special passports, but for all citizens, in return for treating our citizens reciprocally.

We submitted a draft decision for canceling visas for these countries. This issue is now with the Kuwaiti side. Thousands of visas have been issued to Kuwaitis and residents from Kuwait, There is a daily flight operated by Jazeera Airways between Moscow and Kuwait."

Investments

Ambassador Zheltov sent a message of reassurance to the Kuwaiti investors, saying, "There are no external restrictions imposed on trade or investments. Russia is a country that respects the rules of international law regarding ownership, as investments are safeguarded. However, the devil is always in the details.

All Kuwaiti and Gulf investments are respected by the Russian state, despite the sanctions imposed by Western countries on us, and on Arab and non-Arab investors. Investment needs security and stability, and foreign sanctions against Russia have affected the level of trade between Russia and Kuwait."

Ambassador Zheltov welcomed the cooperation with the Kuwaiti press, stressing that it enjoys a great degree of freedom due to the sensitivity of the Arab media in this region.

He indicated that government agencies pay more attention to social media, given the base of access to it and the base of people interested in obtaining accurate information

Regarding the military cooperation between his country and Kuwait, Ambassador Zheltov revealed that there are some Russian-made weapons in Kuwait, such as missile launchers and armored vehicles, and there is talk about a tank deal. He added, "We are open to all Kuwaiti requests."

All ministries, authorities and state bodies have been working together for weeks in order to ensure the country's electoral race by taking all required measures and putting all potential at the disposal of voters.

The Ministry of Information, for its part, has invited 50 media representatives from all over the world to cover the parliamentary vote

The Kuwaiti cabinet has recently asked several non-governmental organizations (NGOs) to partake in watching the country's forthcoming parliamentary elections due on June 6, only out of its commitment to ensuring fair and transparent elections.

The Health Ministry affirmed that it was ready for the 2023 parliamentary elections on June 6, Tuesday, via providing 123 fully equipped clinics at polling stations with the participation of 740 medical staff in addition to 30 ambulanc-

es.
In a press statement, the ministry's spokesperson Dr. Abdullah Al-Sanad said that five medical clinics will operate at the main voting centers, while 118 clinics would be at the subcommittee's head-quarters.

He noted that 30 ambulances were dispatched according to the flow of the voters in each constituency.

Meanwhile, National Assembly Election number 35/1962 prohibits the circulation of election-related messages 48 hours before Election Day; but it does not stipulate penalties for whoever violates this stipulation, says constitutional expert Professor Muhammad Al-Fili.

According to Al-Fili some fake accounts on social media and other newspapers are taking a chance to violate the law, as they believe they are safe since there is no punishment for such a viola-

tion.

Nevertheless, he affirmed that well-known media institutions remain committed to the law in line with the Code of Conduct.

The campaigns of the candidates ended on Sunday, including the public meeting organized by former Assembly Speaker and Second Constituency candidate Marzouq Al- Ghanim with the theme, 'The way towards stability'.

During his campaign, Al-Ghanim stressed that he has always been committed to the Constitution and National Assembly Law. He said it is unacceptable to describe the previous era as the period of corruption, because this is tantamount to offending HH the late Amir Sheikh Sabah Al-Ahmad Al-Jaber Al-Sabah. He pointed out that an era is not attributed to a prime minister or Assembly Speaker, as it is attributed to the head of State.

He also confirmed having evidence of a bank transfer made by a senior official at the office of HH the Prime Minister Sheikh Ahmad Nawaf Al-Ahmad Al-Sabah in favor of an individual who administers fake accounts on social media to curse some individuals while the latter is outside Kuwait. He was quick to clarify that he is sure the premier is not aware of such an incident.

He added that the Internet service was disrupted during a parliamentary session when the number of attendees decreased

from 40 to 10. He explained the reason was that some MPs monitored social media and decided to vote according to the trend, not their own opinion.

He went on to say that in case he wins in the election slated for Tuesday, he will cooperate with the Prime Minister — either HH Sheikh Ahmad Nawaf Al-Ahmad Al Sabah or anyone else as part of his constitutional commitment.

'How to do Business with the US Military'

ABCK-AmCham Kuwait, US Military host 2-session workshop

It is required for vendors to do business with the U.S. government to have an active and complete JCCS registration for all contracts in the CENTCOM AOR. Consequently, the U.S. Air Force 386th ECONS presented on the topics of the Government Purchase Card (GPC) Program, Base Operations Support and Services (BOSS), Infrastructure (construction), Air Force Contract

Augmentation Program (AFCAP), and SAM registration. The speakers mentioned that the Government Purchase Cards (GPCs) are used for lower dollar purchases of supplies, services, and constructions, however, the BOSS Flight also makes purchases of communication support, camp support, engineering operations/security services, logistical support services, and airfield support.

Presenters provided an in-depth presentation on how to register as a vendor in SAM, which is mandatory for vendors to be eligible for contract awards above the \$35,000 USD micro-purchase threshold. They also discussed technical aspects of SAM such as creating a Sam.gov Login, creating NCAGE, and requesting a UEID number.

Furthermore, speakers discussed the importance of the Synchronized Predeployment Operational Tracker (SPOT). SPOT is the U.S. federal government database for tracking and accountability of contractor personnel and equipment during contingencies, as he mentioned that it is important for CENT-COM Commanders to know how many, where, and what type of contractor personnel are in their AOR. Vendors who are not already registered in SPOT should reach out to their local contracting office for direction

and update their Contracting Office representative whenever the POC and/or others entered in SPOT change(s). To finalize the presentations, the U.S. mili-

tary spoke about their efforts in combatting human trafficking (Counter Trafficking in Persons (CTIP), Federal Acquisition Regulations as well as compliance and meeting minimum requirements when it comes to vendors doing business with the U.S. Military and their employees. Presenters highlighted that companies get an annual CTIPS compliance certification based on their review, and explained the process of remediation if a company is found to be in violation

The event concluded with a workshop in which vendors were able to meet with several entities from the U.S. military including the 408th Contracting Support Brigade, the U.S. Army's Regional Contracting Center- Kuwait (RCC-KU), The Air Force's 386th ECONS, the Joint Contingency Contracting System (JCCS), The Theater Contracting Center (TCC - SWA), RCC-OIR, The Army & Air Force Exchange Service and Host Nation.

CITRA seeks 'hidden client' feature

KUWAIT CITY, June 5: According to informed sources, the Communications and Information Technology Regulatory Authority (CITRA) is preparing to contract with a company specialized in providing "hidden client" service, in preparation for conducting more field monitoring visits to telecommunication companies through this feature, with the aim of ensuring their compliance with the regulations and laws regulating for the sector, reports Al-Rai daily.

They explained that CITRA had previously applied this service, but it plans to expand its use and rely on it to a greater extent, especially after the success of the initial experiment launched by the authority last year. The value of the fines it collected from this experiment was close to a quarter of a million dinars. The submitted reports contributed to correcting many wrong

The "hidden client" feature is a new way to protect the consumer in the telecommunications sector, as it conducts field visits in the form of a regular customer and goes through the customer experience to learn about the strengths and weaknesses in performance. He then carries out the evaluation process that he had been trained on previously. and prepares detailed reports regarding his experience and observations on the services provided and the employees' dealings with customers.

Contract

The previous contract involved undercover clients making 30 visits per month to the three telecommunication companies at an equal rate, i.e. about ten visits to each company. The variable that is expected to occur in the new CITRA contract is the doubling of the field visits of these clients to the telecom companies, and to limits that may reach the rate of making a daily visit to each telecom company at least

Meanwhile, the sources stressed that CITRA, within the framework of its supervisory move to enable all customers of telecommunications services, seeks to oblige telecommunication companies to contract with all customers with special needs, unless the person has a mental illness.

They indicated that the sponsor requirement is to be dropped, which is what some telecommunication companies require from customers when contracting, especially from blind people. The sources explained that it has

Students on waiting lists for admission at private schools face uncertain future

KUWAIT CITY, June 5: Some parents are facing a problem to register their children in some private schools for the 2023-2024 academic year and one of the reasons is the Ministry of Education has set the density ceiling in each educational system, and any transgression is looked upon as a violation committed by the school in which case the school is liable to be punished, reports Al-Rai daily.

Moreover, the General Administration of Private Education cannot oblige these schools to register more students, as they have special controls and conditions that deter-

mine the admission process. The daily added, most of the students are now on waiting lists since the schools have a limited capacity and to add insult to injury the capacity of schools is limited, the registration process is limited by some controls and an official source in the General Administration of Private Education said some schools already have high student densities, while others seek to maintain the quality and distinction of their educational system by organizing admission tests for new students.

The sources indicated that the ministry excluded some schools from the density ceiling during the last academic year due to the fact that no new schools were opened during the Corona pandemic.

KUWAIT CITY, June 5, (KUNA): Kuwait Red Crescent Society (KRCS) said on Thursday that they distributed Eid clothes for 4,000 families in need, that are registered in KRCS records, in Kuwait.

Labor market partially recovers from pandemic slump

Consumer spending in Kuwait strong in Q1

The underlying drivers of consumer activity in Kuwait I remain solid, including sustained job gains, government measures, and favorable demographics, with spending registering another firm rise in 1Q23. Nevertheless, growth has eased from previous quarters, as the effects of previous government stimulus and the post-pandemic demand rebound fade. Overall consumer spending is likely to continue to benefit from the government's intention to maintain an expansionary fiscal stance, supported by high oil revenues. That said, in the near term, spending growth could moderate further amid the volatile and overall weaker global macroeconomic environment and tighter monetary policy, which could weigh on consumer sentiment

Spending robust despite easing growth, signaling

Consumer spending, measured by total credit and debit card transactions (including ATM cash with-drawals), grew by 14% y/y in 1Q23, the same rate as the previous quarter and by 3.8% q/q. (Chart 1.) While growth has slowed from its peak of more than 30% early last year, it remains solid compared to pre-2019 levels, where growth averaged 7% y/y during 2014-19.

The initial trend of particularly strong overseas spending in the wake of the lifting of pandemic restrictions has now settled at more 'normal' levels. (Chart 2.) Card transactions outside of Kuwait did jump 20% y/y in 1Q23 (compared to a 7% rise in 4Q22), a quarter marked by a strong uptick in National Day overseas travel; although overseas spending still represents less than 6% of total consumer spending. As for local spending, growth further softened to 13% y/y

Household credit softening amid higher interest rates

Household lending (excluding loans for the purchase of securities) has been providing solid support to consumer spending. The rate of increase in household credit has weakened in recent quarters, however, to 7% y/y at the end of 1Q23 (from 14% y/y in 1Q22), amid tighter monetary conditions. Lending growth in the 'consumer loans' sub-segment – which strips out housing loans and may be most closely related to the purchase of consumer durables - had slowed to 5.7% at the end of Q1 from a peak of 15.1% early last year.

Population and employment recovering Population and labor markets both recorded a

sharp recovery in 2022, following the return of some expats after their Covid•linked departures. The boost to private consumption from an expansion in the labor force and population growth, while undoubtedly positive, may not be so pronounced, given that most of the recent additions to the expat population and jobs are concentrated in labor-intensive and possibly lower-end jobs. Sustained job gains among Kuwaitis continue to be a solid driver of consumption growth, though.

According to data from the Kuwait Public Authority for Civil Information (PACI), the total popula■ Consumer spending growth remained robust in 1Q23 at 14% y/y, the same as 4Q22, but lower than its peak in 2022.

■ Support for spending from strong household lending appears to be declining, with credit growth slowing in Q1.

The labor market has partially recovered from the pandemic slump, with continued job growth among Kuwaiti nationals seen providing underlying support for spending growth going forward.

■ Still, spending growth could slightly ease over coming quarters, amid a further normalization from Covid-era patterns, moderate economic growth and the tighter monetary policy

tion of Kuwait reached 4.74mn in 2022, increasing by 8% y/y. The number of non-Kuwaitis rose by 11.1% y/y, outpacing the increase in Kuwaitis (+1.9%). Overall employment grew by 8.1% during the last six months of 2022, predominantly driven by the return of some expatriate jobs following the resumption of economic activity post-Covid. (Table 1.) Still, expat employment levels across many sectors are some way below their peak in 2019, suggesting a full recovery is yet to happen. Meanwhile, employment among Kuwaiti nationals inched up by 1.4% in the six months to December 2022 to 455K on mainly public sector job gains.


Average wages of Kuwaiti public sector workers rose by 1.8% y/y in 4Q22, the fastest growth rate in over two years, according to Kuwait Central Statistical Bureau and Labor Market Information System data. Broadly, increasing employment and growing


Consumer sentiment ebbing on unclear global


As measured by ARA Research and Consultancy's Consumer Confidence Index, consumer sentiment has also been trending lower. (Chart 4.) Growing worries about the global economic outlook and moderating oil prices have contributed to the recently softer readings of the broad consumer sentiment index. The index for durable goods (consumer discretionary category) has been more volatile but is also broadly softening. The overall moderating trend in consumer confidence outlines some easing in growth in consumer activity.

Inflation elevated, with food prices a main driver Inflation in Kuwait in April stood at 3.7% y/y, unchanged from March but up from 3.2% at the end of 2022. Consumer prices have seen some renewed upward pressures this year across several key categories including food & beverages, clothing and housing services. (Chart 5.) Ramadan-related seasonality could explain some of this increase. Nevertheless, the overall inflation trend we see for the remainder of the year is one of moderation on easing consumer











ing support for the consumer sector going forward. The election of a new parliament in June could be followed by the approval of the draft budget for







FY23/24 proposed earlier this year. The draft outlined a 12% y/y increase in budgeted public expenditures, driven by a 13% rise in salaries and a 34% rise in subsidies. A part of this spending, however, consists of accrual payments to ministries for previous years' outlays so the positive impact on demand this year may be somewhat less. The government also aims to hire around 20K additional Kuwaiti employees in the public sector this fiscal year, which should support rising consumer demand.

WS drifts after report on economy

Asian stocks follow Wall St

NEW YORK, June 5, (AP): U.S. stocks were drifting Monday to begin what could be a quiet stretch following their best week since March.

The S&P 500 edged up 0.3% in morning trading. The Dow Jones Industrial Average was down 61 points, or 0.2%, at 33,705, as of 12:31 p.m. Eastern time, while the Nasdaq composite was 0.6 higher.

The indexes were listless after a report showed businesses in the accommodation, construction and other U.S. services industries grew in May for a fifth straight month, though by less than economists expected. It's the latest mixed reading on the U.S. economy, which has begun to slow under the weight of higher interest rates but has defied forecasts for a recession so far.

Stocks were roughly split between gainers and losers in the S&P 500. A gain for market heavyweight Apple helped lift Wall Street. It rose 1.7% ahead of an event where it's expected to unveil a long-rumored headset that will place its users between the virtual and real world,

In the oil market, crude gained after Saudi Arabia said it would cut back production in hopes of boosting its price. A barrel of U.S. crude rose 1.5% to \$72.84, and a barrel of Brent crude, which is the international standard, climbed 1.6% to \$77.36.

Both were close to \$120 a year ago, and their prices have fallen on worries that a strapped global economy would burn less fuel.

Elsewhere, Wall Street was relatively quiet. This upcoming week is light on earnings reports and top-tier economic data. That leaves few clues for the dominant question hanging over the market: Which will come first, the economy falling into a recession or inflation easing enough for the Federal

Reserve to cut interest rates?

That's why much attention is on next week, when the government will release the latest monthly undates on inflation at the consumer and wholesale levels. It's also when the Fed will meet next on interest rate policy. Traders are largely betting that it will stand pat on rates, which would mark the first meeting where it hasn't hiked in more than a year.

The bet on Wall Street, though, is that it could resume hiking rates in July. The reason for such a pause would be to give the Fed time to assess its furious pace of rate hikes over the last year. The goal of high rates is to lower in-

flation by slowing the entire economy and dragging down prices for stocks, bonds and other investments. With rates at their highest level since 2007, several high-profile U.S. bank failures since March have already shaken the market, while the manufacturing industry has been contracting for months.

The job market, though, has managed to remain remarkably solid de-

spite them. That's helped U.S. households continue to spend, which has kept the economy out of a recession. Last week, data showed that U.S. employers unexpectedly accelerated their hiring in May, while increases in workers' wages slowed to keep some pressure off inflation.

Despite all the uncertainty about the economy, Wall Street remains on the the edge of what's called a "bull market" following weeks of gains.

The S&P 500 is sitting just above

4,290, and if it finishes the day above 4,292.44, it will be more than 20% above where it was in mid-October. That would mean Wall Street's main measure of health has transformed from its frigid "bear market," when it fell more than 20% over nine months, into a powerful bull.

In the bond market, the yield on the 10-year Treasury fell to 3.69% from 3.70% late Friday.

The two-year Treasury, which moves more on expectations for the Fed, dropped to 4.49% from 4.51%.

In early trading, the FTSE 100 in London rose 0.4% to 7,641.19 and the DAX in Frankfurt gained 0.2% to 16,087.01. The CAC 40 in Paris was unchanged at 7,270.84.

In Asia, the Nikkei 225 in Tokyo advanced 2.2% to 32,217.43 and the Shanghai Composite Index added less than 0.1% to 3,232.44. The Hang Seng in Hong Kong gained 0.7% to 19,089.47.

The Kospi in Seoul was 0.5% higher at 2,615.41 and the S&P ASX 200 in Sydney jumped 1% to 7,216.30.

India's Sensex opened up 0.5% at 62,844.36. Singapore and Jakarta gained. Markets in New Zealand and Thailand were closed for holidays.

In energy markets, benchmark U.S. crude rose \$1.64 to \$73.38 per barrel in electronic trading on the New York Mercantile Exchange. The contract gained \$1.64 on Friday to \$71.74. Brent crude, the price basis for international oil trading, advanced \$1.65 to \$77.78 per barrel in London. It added \$1.85 the previous session to \$76.13.

The dollar rose to 140.24 yen from Friday's 139.94 yen. The euro fell to \$1.0694 from \$1.0712.

GCC Markets Monthly Report ---- May 2023

Decline in large-cap sectors pull GCC into the red...

After two consecutive months of gains, the aggregate GCC index declined during May-2023 mainly led by decline in large cap sectors like Materials, Banks, Energy and Telecom. The MSCI GCC index dropped by 4.1% during the month reflecting declines in most markets in the region. Kuwait's All Share Market Index reported the biggest decline during the month registering a fall of 4.8% followed by Abu Dhabi and Saudi Arabia with declines of 3.9% and 2.6%, respectively. On the other hand, Dubai and Bahrain recorded gains of 0.9% and 3.1%, respectively, partially off-setting the overall GCC decline. The monthly decline once again pulled the MSCI GCC index in the red in terms of YTD-2023 returns that stood at -2.4%.

The sector performance chart for the month showed declines in large-cap sectors like Materials (-3.7%) Banks (-3.3%), Energy (-3.1%) and Telecom (-3.4%) that were partially offset by gains in Pharma & Biotech (#48.6%) and Insurance (#5.8%) sectors. However, in terms of YTD-2023 performance, most of the sectors were in the green while Banks and Capital Goods were the only underperformers with declines of 4.1% and 7.1%, respectively.

Global equity markets mostly showed a downward trend during the month with the MSCI World index registering a decline of 1.2%. The UK and European markets were some ofthe biggest decliners during the month while US showed a mixed trend with the S&P 500 Index and the Nasdaq Composite showing gains while the DJIA dropped by 3.5%. On the other hand, the global emerging market index showed a decline of 1.9% after the decline in China (- 3.6%) was partially offset by gains in most other emerging markets in Asia with Taiwan seeing the biggest gain of 6.4% followed Korea with a gain of 3.0%. India's Sensex also showed a gain of 2.1% during the month.

Kuwait Boursa

Kuwaiti benchmarks receded during May-2023 after seeing gains during the previous month. It is pertinent to note that the headline All Share Market Index and the Premier Market index have declined in five out of the last six months since December-2022. In terms of market segments, the Premier Market Index witnessed the biggest monthly decline of 5.3% during May-2023 as performance of constituent stocks in the index showed a downward skew. The Main 50 Index and the All-Share Market Index reported a monthly decline of 4.9% and 4.8% followed by the Main Market index that receded 3.0% during May-2023. The declines affected YTD-2023 performance for the market with the All-Share Index showing the second-biggest decline in the GCC at -6.8%. The Premier Market index declined by 7.7%, whereas the Main 50 Index receded 6.2% vs. 2.8% drop for the Main Market Index.

The sector performance chart was mixed during the month. The gainer's side was topped by the Technology and the Consumer Staples indices with double-digit gains of 18.6% and 10.1%, respectively, followed by Consumer Discretionary index with a gain of 5.7%. The gains in the Technology index was led by an equivalent gain in the sole constituent stock in the index, Automated Systems Co. In the Consumer Staples sector, shares of Mezzan Holding posted a monthly gain of 8.0% supported by strong Q1-2023 earnings. The company announced a net profit of KWD 4.3 Mn for Q1-2023 compared to KWD 2.9 Mn in Q1-2022 supported by 9.4% y-o-y growth in revenues. Meanwhile, large-cap indices like Banking and Telecom witnessed steep declines during the month despite posting strong earnings for Q1-2023. The Banking sector index was down by 6.0% during the month after shares of all the Kuwaiti banks declined. In the earning releases, KFH posted a net profit of KWD 162.1 Mn in Q1-2023 compared to a profit of KWD 70.0 Mn in Q1-2022. The Telecom index declined by 6.7% reflecting decline in 4 out of 5 constituent stocks in the index with Ooredoo leading the decline with a drop of 7.7%.

In terms of monthly stock performance, Hayat Communications Co. topped with a gain of 45.1% followed by Kuwait Foundry Co. and Senergy Holding Co. with gains of 33.1% and 28.5%,respect ively. On the decliner's side, Equipment Holding Co. topped with a decline of 30.4% followed by Dar Al Thuraya Real Estate Co. and National Investment Co. with declines of 28.3% and 23.4%, respectively. In terms of trading activity, aggregate volumes traded increased by 40.1% to reach 3.0 Bn traded shares during May-2023. Monthly value traded showed a stronger growth of 46.2% to reach KWD 941.2 Mn in May-2023. On the monthly value traded chart, KFH topped with KWD 215.3 Mn traded shares followed by Boubyan Bank and NBK at KWD 107.5 Mn and KWD 97.8 Mn worth of traded shares, respectively.

Saudi Arabia (Tadawul)


Saudi Arabia's headline equity index TASI reported monthly decline during May-2023 reflecting recent earnings announcements that affected investor sentiments coupled with broader economic woes regarding the U.S. debt ceiling deal. The benchmark TASI peaked at a closing high of 11,392.78 points at the end of the first week of the month but mostly trended downward during the rest of the month to close with a decline of 2.6% at 11,014.1 points. Despite the decline, Saudi Arabia ranks second in the GCC in terms of YTD-2023 performance with a gain of 5.1%.

The monthly sector performance chart favored decliners during May-2023. The Media sector witnessed the steepest decline of 7.4% followed by the Utilities and Health Care Equipment & Svc indices with declines of 6.3% and 4.4%, respectively. The gainers side was led by the Pharma, Biotech & Life Science index with a double-digit gain of 49.8% followed by Transportation and Capital Goods with gains of 7.6% and 6.1%, respectively. The gains in the Pharma, Biotech & Life Science index was led by the equivalent gain in the sole stock in the index, Saudi Pharmaceutical Industries and Medical Appliances Corporation. Meanwhile, large-cap sectors like Energy and Bank reported monthly declines of 4.2% and 3.0%. In the Telecom sector, all the constituent stocks declined with ZAIN KSA leading with a decline of 8.4%. Shares of Aramco was also in the red with a decline 4.5% during May-2023.


The monthly gainer's chart was topped by Saudi German Health with a gain of 50.6% followed by Saudi Pharmaceutical Industries and Medical Appliances Corp. and Al Sagr Cooperative Insurance Co. with gains of 49.8% and 33.8%, respectively. On the decliner's side, Tihama Advertising and Public Relations Co. topped with a decline of 20.6% followed by Saudi Arabian Amiantit Co. and Saudi Electricity Co. with declines of 12.5% and 12.2%, respectively.

Trading activity on the exchange witnessed strong monthly gains during May-2023. Monthly volume of shares traded witnessed a m-o-m increase of 50.9% in May-2023 to reach 4.7 Bn shares. Monthly value of shares traded increased at a much bigger pace of 53.0% to reach SAR 136.0 Bn. Americana Restaurants topped the monthly volume chart with 421.2 Mn shares followed by Aramco and Zain KSA with 164.7 Mn shares and 162.2 Mn shares traded, respectively. On the monthly value traded chart, Al Rajhi Bank topped with SAR 6.6 Bn worth of shares traded during the month followed by STC and Aramco with trades worth SAR 6.1 Bn and SAR 5.4 Bn during the month, respectively.

In terms of primary market IPOs, The First Milling Company of Saudi Arabia, also known as First Mills, is intending to list a 30% share on the Tadawul. A market capitalization of between SAR 3.05 Bn and SAR 3.3 Bn is implied by the company's sale of 16.65 Mn shares at a price range between SAR 55 and SAR 60 (USD 14.66) per share. The IPO is anticipated to be this year's second-largest in Saudi Arabia after Jamjoom Pharmaceutical which was also priced during the second half of May-2023 at the top end of the

range. Similarly, the other companies which issued prospectus to list on Tadawul are Almawarid Manpower Company, Morabaha Marina Financing and Olam Agri Holdings. Olam Group is expecting to launch the dual IPO of Olam Agri Holdings with a primary listing in Singapore before a potential concurrent listing in Saudi Arabia during the year.

Abu Dhabi Securities Exchange

The FTSE ADX index dropped by 3.9% during May-2023 after witnessing a growth of 3.8% during April-2023 underlining the second highest decline since July-2022. In terms of sectoral indices, eight out of the ten sectors recorded declines during the month while the remaining two recorded gains. On the decliners' side, the Industrial index led the way with 11.2% index drop followed by the Utilities index which recorded a 7.7% drop to close the month at 11,893.4 points as the sectors only constituent company, Abu Dhabi National Energy Co, witnessed an equivalent share price decline of 7.7% during the month. The Energy index followed with the third highest drop of 7.6% as all the three constituent companies witnessed share price declines during the month led by Adnoc Drilling's 15.4% share price slide during the month. Trading activity in the ADX exchange witnessed gains during the month supported by the IPO of Adnoc Logistics & Services which is estimated to have raised around USD 770 Mn for 15% of company's shares offered in the IPO.


In terms of monthly stock performance, Bank of Sharjah topped the monthly gainers chart for May-2023 with a gain of 32.2% followed by Abu Dhabi National Takaful and National Corp for Tourism & Hotels which recorded gains of 15.5% and 14.9%, respectively. Bank of Sharjah has recently announced that it is boosting its capital by USD 218 Mn to USD 820 Mn to enhance its position and foster future growth. The bank's investment arm, Sharjah Asset Management, will be the primary beneficiary of the capital raise. On the decliner's side, Ras Al-Khaimah Co for White Cement lead the way registering 23.6% fall in its share price during May-2023 followed by Ras Al Khaimah Poultry & Feeding Company and Hayah Insurance which saw share price declines of 20.8 % and 18.2%, respectively.

Trading activity increased m-o-m during May-2023. Total volume of shares traded reached 5.6 Bn shares in May-2023 vs. 3.3 Bn shares traded during April-2023. Monthly value traded witnessed a slightly lower growth of 44.9% to reach AED 26.1 Bn in May-2023. Eshraq Investments overtook Multiply Group at the top of the most active stocks table during the month with 1.1 Bn traded shares followed by Multiply Group and Dana Gas which traded 565.7 Mn shares and 333.3 Mn shares, respectively. In terms of value traded, IHC topped the table for the fourth month in a row with AED 5.9 Bn worth of shares changing hands during the month followed by Abu Dhabi Islamic Bank and Alpha Dhabi Holding Company at AED 2.9 Bn and AED 1.9 Bn, respectively.

In economic news, the Emirates real GDP growth during 2023 is expected to expand at the slower rate of 3% as compared to the 7.6% pace it achieved in 2022, according to a report by GlobalData. The UAE's subdued GDP growth was attributed to a decline in oil output due to the OPEC+agreed production cutbacks and a deceleration of the Emirates non-oil economy induced by higher interest rates among other reasons. On a positive note, the Abu Dhabi economy has been recognized as the fastest growing economy in the Middle East with 9.3% GDP growth in 2022 according to the Statistics Centre – Abu Dhabi (SCAD). The Emirates' robust economic growth reflected the success of its diversification strategy. Moreover, Abu Dhabi's AED 10 Bn industrial strategy program launched in the middle of last year has played a major role in strengthening the Emirates economic output during 2022.

Dubai Financial Market

The DFM General Index recorded its second consecutive monthly gain in May-2023 recording a 0.9% growth to close the month at 3,576.63 points as the second best performing market in the GCC during the month. The monthly index performance was induced by increases in five out of the eight sectoral indices including Financials, Real Estate, and Industrials sectors. The Consumer Discretionary Index recorded the biggest monthly gain of 3% to close the month at 1,003.8 points mainly driven by TAALEEM Holdings 5.3% share price gain during May-2023. The Communications Services Index followed with a 2% gain during the month due to Emirates Integrated Telecom's (du) 2.2% share price increase during the month. The 0.8% decline of the Utilities index which has large market cap constituent companies such as DEWAA and Empower - Emirates Central Cooling Systems Corporation affected the growth of the DFM General Index during May-2023. Moreover, the Materials index which has only one constituent company (National Cement Co.) recorded a 2.1% fall during May-2023 to close the month at 96.8 points.



According to Bloomberg data, Gulf Navigation Holding led the monthly gainers table with an 84.5% increase in share price followed by Ajman Bank and Arabian Scandinavian Insurance Company with gains of 31.7% and 30.2%, respectively. Gulf Navigation Holding has recently sold a petrochemical tanker and announced to use the proceeds of the sale to settle its debt and improve liquidity. Moreover, Gulf Navigation Holding has reported it is not going to distribute dividends for the fiscal year 2022. Meanwhile, the gain in shares of Ajman Bank came on the back of its USD 13.3 Mn net profits during the first quarter of this year. The bank has also disclosed that its total assets reached USD 6.2 Bn during Q1-2023. On the decliner's side, Amlak Finance topped the table recording a share price decline of 12.3 during May-2023 followed by Aramex and Dubai Investment Company with share price declines of 10.7% and 10.2%, respectively. Aramex's Q1-2023 net profits declined 49% yoo-y to AED 24 Mn due to several factors including currency devaluation in some markets and growth in interest expense with the nurchase of platform MyUS.

In terms of monthly trading activity, total volume traded increased by 81.6% to reach 5.7 Bn shares in May-2023 as compared to 3.1 Bn shares during April-2023. Total value traded of shares traded during the month also witnessed double-digit growth recording 60.1% increase to reach AED 9.7 Bn in May-2023 as compared to AED 6.0 Bn during April-2023. Deyaar Development topped the monthly volumes traded chart recording 1.3 Bn shares which changed hands during the month followed by Union Properties and Ajman Bank which saw 1.0 Bn and 651.4 Mn of their shares change hands during the month, respectively. On the monthly value traded chart, Emaar Properties topped the list with AED 1.7 Bn worth of shares changing hands during the month, followed by Ajman Bank and Gulf Navigation Holding which saw AED 1.26 Bn and AED 1.25 Bn values of their shares traded, respectively.

In economic news, a report from S&P Ratings showed that Dubai government's debt burden is expected to fall this year. The debt owed to the Dubai government is forecasted to decline by 78% of GDP in 2020 to 51% of GDP (USD 66 Bn) by the end of 2023. One of the main reasons for the Emirates debt recovery, according to S&P, is its emergence as a safe investment haven after the end of the global pandemic. Moreover, Dubai has also benefited from the Russia-Ukraine conflict as its Real Estate sector reaped the influx of Russian property buyers which propelled Dubai's property sales to a record.

Qatar Exchange

The declining streak in Qatar Stock Exchange continued during May-2023 with the QE General Index registering a decline for the fourth consecutive month. The large-cap index dropped marginally by 0.3% during the month mainly after a steep decline of 1.8% seen on the last trading day of the month. However, the decline was mainly focused on large-cap stocks as seen from the 1.1% monthly gain registered in the QE All Share Index. This difference was also reflected in the YTD-2023 performance of the two indices with the QE General index seeing a bigger decline of 4.9% whereas the QE All Share index registered a marginal drop of 0.5%. The sector performance chart for the month also showed contrasting performance with all sectors in the green and merely the Industrials index in the red with a decline of 4.1%. The Insurance sector recorded the biggest monthly gain of 11.0% during May-2023 followed by Telecoms and Real Estate with gains of 8.9% and 5.7%. The Telecom index was also the top performers in terms of YTD-2023 gains at 21.0% followed by Transportation and Insurance indices with gains of 7.9% and 3.7%. On the other hand, the Banks & Financial Services index was the biggest decliner with a decline of 4.6% followed by Consumer Goods & Services and Real Estate indices with declines of 2.0% and 0.9%, re-

The monthly stock performance chart was topped with Qatar German for Medical Devices with a gain of 110.3% followed by the Dlala Brokerage and Widam Food with gains of 72.8% and 52.0%, respectively. On the decliners side, Gulf International Services topped with a decline of 8.1% followed by Industries Qatar and QLM Life & Medical Insurance with declines of 7.5% and 7.4%, respectively. In Q1-2023 earnings releases, total net profits decreased by 10.04% y-o-y to reach QAR 12.5 Bn during Q1-2023 as compared to QAR 13.9 Bn during Q1-2022. Profits growth for companies in the Industrial and Consumer & Services sector declined by 44.2% and 17.5%, whereas the Banks & Financial sector and Insurance sector posted growth of 1.5% and 79.0%, respectively.

Trading activity witnessed significant growth during May-2023. Monthly volume traded almost tripled to reach 6.5 Bn shares in May-2023 as compared to 2.5 Bn shares in April-2023. On the other hand, monthly value traded also showed strong gains of 142.1% to reach QAR 16.1 Bn vs.

QAR 6.7 Bn during the previous month. In terms of monthly volume, Mazaya Real Estate Development topped with 756.2 Mn shares traded during the month followed by Salam International and Dukhan Bank with 596.9 Mn and 476.9 Mn shares traded, respectively. On the monthly value chart, Dukhan Bank topped with QAR 1.75 Bn worth of trades during the month followed by QNB and the Masraf Al Rayan at QAR 1.66 Bn and QAR 991.6 Mn, respectively. In terms of sector contribution, the Banks and Financial Services sector led trading value during May- 2023, accounting for 43.3% of the total traded value, followed by Industrials sector at 22.1% and the Consumer Goods & Services Sector at 15.8%.

In the Economic news, according to the minister of finance, Qatar has recorded a surplus of QAR 19 Bn (USD 5.2 Bn) in Q1-2023. The government intends to use this surplus to pay the public debt and support the reserves of the Qatar Central Bank. Non-oil sector grew by 6.7%, while the oil sector grew by 1.5% during the Q1-2023.

Bahrain Boursa

The Bahrain Bourse All Share Index recorded the biggest gain in the GCC during May-2023. The index was up for the second consecutive month with a growth of 3.1% during May-2023 to close the month at 1,963.51 points underlining its fourth monthly growth in the first five months of the year. In terms of sectoral performance, four out of the seven indices recorded gains during the month. The Communications Services index registered a 10.6% gain during May-2023 to close the month at 2,576.8 points after Batelco's shares gained 11.5% during the month. Batelco has recently signed partnerships with Bahrain's Ministry of Telecommunications and Bahrain's Public Transport Company to provide a new channel for recharging Go cards, enabling its Prepaid and Lucky customers to top-up their cards via SMS messages. The Materials index, which only has one constituent company (Aluminum Bahrain), followed with a gain of 6.7% during May-2023. The gain in shares of Alba came after the company has recently been strengthening its ties with Egypt's Aluminum sector. The Financials Index was the third biggest gainer among the indices registering 1.9% gain during May-2023 to close the month at 6,970.1 points mainly due to the performance of companies such as Esterad Investment Company and Al Salam Bank Bahrain which posted monthly share price gains of 16.8% and 9.1%, respectively

In terms of share price performance, according to Bloomberg data, Nass Corp topped the list of gainers with 38.9% share price gain during the month followed by Esterad Investments and Bahrain Telecommunications Company with gains of 16.8% and 11.5%, respectively. Esterad Investments reported Q1-2023 net profits of BHD 0.36 Mn (USD 0.96 Mn) up 45% due to growth on its trading portfolio. On the decliners side, APM Terminals Bahrain topped the list recording 11% share price decline during the month followed by Arab Banking Corp and Bahrain Flour Mills with share price declines of 7.7% and 6.4%, respectively.

Trading activity on the exchange increased during May-2023 recovering from a decline during April-2023. Total volume traded on the exchange rose 35.1% to 79.2 Mn as compared to 58.7 Mn in April-2023. Moreover, total value traded on the exchange witnessed a surge of 148.0% to reach BHD 29.7 Mn in May-2023 as compared to BHD 12.0 Mn during April-2023. Al Salam Bank-Bahrain topped the monthly volumes chart with 31.2 Mn traded shares followed by Aluminum Bahrain and GFH Financial Group at 14.2 Mn and 9.6 Mn shares, respectively. On the monthly value traded chart, Aluminum Bahrain topped this list with BHD 15.1 Mn worth of shares changing hands during the month followed by Al Salam Bank Bahrain and Kuwait Finance House - Bahrain which witnessed BHD 4.3 Mn and BHD 3.5 Mn values of their monthly shares traded, respectively

In market news, Fitch Ratings affirmed Beyon's (Batelco) long-term issuer default rating (IDR) at B+' with stable outlook, reflecting Bahrain's sovereign rating which currently stands at (B+/Stable) due to the over three-quarters of the company being owned by the Bahraini government. Moreover, in terms of the general Bahrain economy a recent business confidence survey has shown that most investors are optimistic about the Kingdoms economy. Around 94% of Business Confidence Environment Survey takers have responded positively, expressing stability in Bahrain's investment climate during Q1-2023.

Muscat Securities Market

The MSX 30 index witnessed a monthly decline of 1.9% during May-2023 to close the month at 4,626.4 points recording its second consecutive monthly fall. In terms of sector performance, all the three sector indices recorded declines during May-2023. The Industrial Sector Index, which recorded the biggest monthly growth of 3.7% during April-2023, recorded the biggest monthly fall of 4.9% during May-2023 closing the month at 5,989.9 points. The decline was primarily driven by a small number of top decliners including Al Hassan Engineering Company which witnessed a share price drop of 22.2% during May-2023 and Al Anwar Ceramic Tiles Company which recorded a 21.2% fall in share prices. Similarly, the Services Sector Index registered a 2.6% drop to close the month at 1,701.6 points while the Financial Index witnessed the smallest decline of 0.6% to close the month at 7,558.74 points. The fall in share prices in certain energy companies such as Sohar Power (-15%) and Voltamp Energy (-14.5%) has mainly contributed to the decline in Services Index during the month.

In terms of company performance, Al Mad ina Investment Holding Company topped the gainers list with a share price gain of 100% followed by Dhofar Cattle Feed and Muscat Gases Co with 20% and 13.2% monthly share gains, respectively. On the decliner's side, Al Batinah Hotels Co topped the monthly losers list with a share price drop of 77.1% followed by Barka Water and Power and Oman Fisheries Company which recorded 74.5% and 23.1% share price declines during the month, respectively.

Trading activity on the exchange decreased during May-2023 after witnessing growth for the previous two consecutive months. Total volume of shares traded in the exchange fell 37.1% to 235.9 Mn shares as compared to 375.2 Mn in April-2023. Similarly, total value traded in the exchange declined by 53.1% to OMR 53.6 Mn against OMR 114.5 Mn in April-2023. Oman Telecommunications Company topped the monthly value traded chart with trades at OMR 9.6 Mn followed by Bank Muscat and National Bank of Oman with total value traded at OMR 9.0 Mn and OMR 2.7 Mn, respectively. In terms of monthly volume traded, Bank Muscat topped the table with 33.6 Mn shares followed by Al Anwar Investment and Phoenix Power Company with volumes at 29.3 Mn shares and 10.7 Mn shares, respectively.

Meanwhile, during the month, news related to M&As in Oman featured in headlines. In the banking sector, Sohar International Bank and HSBC Oman have started the process of merging after signing a binding agreement to undertake the necessary steps towards a merger by incorporation. The pending deal entails that after completing all the process, all the assets and liabilities of HSBC Oman will be transferred to Sohar International Bank and HSBC Oman will then be dissolved. In the investment sector, Dhofar International Development and Investment has approved its merger with Oman Investment and Finance company by way of share swan ratio.

In terms of economic news, the Sultanate recently established the Oman Future Fund with capital of OMR 2 Bn (USD 5.2 Bn) to enhance and encourage economic activity. The Fund will also accelerate and finance public-private feasible partnerships to achieve diversification targets set for the Oman Vision 2040.

Forecasting, monitoring and KI - Swarm intelligence for the energy transition at EM-Power Europe

With millions of solar installations, wallboxes and heat pumps, home storage systems and car batteries that will someday be able to feed electricity back into the grid, today's utility grid system is already so complex that utilities and grid operators would be lost without their digitalized systems. The more they know about when, where and how much electricity is being produced, fed into the grid and demanded by consumers, the

more precisely can they match their supply to the demand. This also makes it more profitable, as making up for shortages is expensive. When generation does not cover consumption within a balancing group, grid operators are forced to pay balancing costs. The more accurate the weather and yield forecasts for wind and solar power plants, the more successful the companies will be. Individuals who want to optimize

their self-consumption using bat-teries or controllable consumers like e-cars or heat pumps also require forecasts to determine what the electricity should be used for. The same goes for the energy management of buildings.
At EM-Power Europe, the in-

ternational exhibition for energy management and integrated energy solutions, companies from all around the world present their digitalization concepts as well as innovative technologies and services for the optimized grid of the future. "Machine learning and AI play a crucial role in the irradiation forecast," Jan Remund, Head of the Department for Energy and Climate at Meteotest AG, a Swiss weather forecast provider, explains. The company is able to predict cloud movements by combining physical models with self-learning algorithms based on satellite images. "The accuracy for

the next few hours is quite high. The longer the time span, the less accurate the forecasts are," says Remund. His company collects irradiation and temperature data and uses it to make analyses, profiles and forecasts that can be integrated into the respective PV monitoring or control software. Companies can use the weather forecasts as a basis for calculating solar irradiation using dedicated software, or they can buy

such calculations. Grid operators rely on irradiation forecasts to balance the grid's feed-in and feedout based on the production and demand forecasts

Meteocontrol, a monitoring and forecast specialist company from the South of Germany makes yield calculations based on the data of different weather forecast providers. The company also investigates how aerosols like ash or sand affect cloud formation.

GCC markets negative in May mainly due to short-term volatility

KUWAIT CITY, June 5: Kuwait Financial Centre "Markaz" recently released its Monthly Market Review report for the month of May 2023. Kuwait's All Share Index declined in May, posting a monthly loss of 4.8%. Among Boursa Kuwait's sectoral indices, Telecom and Banking sector lost 6.7% and 6.0% respectively for the month. Among Premier Market stocks, Mezzan Holding and Ali Alghanim Sons saw the biggest gains for the month, up by 12.4% and 7.7% respectively, on account of stronger earnings growth in O1 2023. National Investments Co. fell the most for the month, down by 23.4%.

Kuwait consumer price inflation (CPI) rose by 3.7% y-o-y in April, the same

pace as in the previous month and 0.2% m-o-m primarily driven by food and clothing prices. Food inflation climbed to a nine-month high of 7.7% y-o-y. The World Bank expects Kuwait's economic growth to slow to 1.3% in 2023, down from 7.3% in 2022. The decline in oil and gas revenues and the slowdown in global economic activity are the main reasons for the fall in Kuwait's growth forecast. Kuwait's non-oil sector is expected to grow by 4.4% in 2023. On the positive side for the economy, the World Bank also expects Kuwait's inflation to decrease to 2.6% in 2023 and the current account surplus to reach 22% of GDP, compared to 26% in 2022.

Regionally, GCC markets were negative in May, with the S&P GCC composite index down 3.1% for the month. The decline was driven by the fall in oil prices, which weighed on investor sentiment. All equity indices, except Dubai and Bahrain, were negative for the month. Bahrain market rose 3.1% in the month, due to strong Q1 2023 corporate earnings and the positive sentiment surrounding the upcoming listing of Mumtalakat Holding Company. The listing, scheduled for the second half of 2023, is expected to attract foreign investors to the Bahraini stock market. Dubai market mildly gained 0.9% for the month, majorly driven by blue-chip stocks. Saudi markets witnessed a 2.6% monthly decline, primarily due to losses in the energy and banking sector stocks. Qatar National Bank and Emaar Properties were the top gainers among GCC blue chips, rising 4.6% and 3.7% for the month respectively.

The World Bank's Gulf Economic Update report has projected the GCC economies to experience slower growth in 2023 due to lower oil and gas earnings, and a global economic slowdown. The GCC region's economic growth is projected at 2.5% in 2023 and 3.2% in 2024. Qatar confirmed that the state's general budget recorded a surplus of QR19 billion (USD5.2 billion) in Q1 2023. The surplus will be utilized for purposes such as paying public debt, supporting the reserves of the Qatar Central Bank, and strengthening the assets of the Qatar Investment Authority. The International Monetary Fund (IMF) predicts that Qatar's medium-term growth will rise to around 4-4.5% after the expansion of the North Field boosts LNG production. Moody's Investors Service has upgraded Oman's ratings and maintained a positive outlook based on improvements in the country's fiscal surplus and spending restraint.

Renewable energy surges on, driven by solar boom: report

BERLIN, June 5, (AP): The world is pecially in China. to add a record amount of renew able electricity capacity this year as governments and consumers seek to offset high energy prices and take advantage of a boom in solar power, according to a new report Thursday.

The International Energy Agency said high fossil fuel prices - resulting from Russia's attack on Ukraine - and concerns about energy security had boosted the rollout of solar and wind power installations, which are expected to reach 440 gigawatts in 2023.

That's about a third more than the world added the previous year, taking the global installed capacity to 4,500 GW, roughly the combined total power output of the United States and China, the Paris-based agency said.

"The global energy crisis has shown renewables are critical for making energy supplies not just cleaner but also more secure and affordable," said Fatih Birol, the IEA's executive director.

"Governments are responding with efforts to deploy them faster," he said. Recent incentives to install renewables introduced by the Biden administration are already driving a significant uptake in the United States.

About two-thirds of this year's increase in renewable power capacity will come from photovoltaic, with both large-scale solar farms and consumer rooftop installations seeing significant

IEA said manufacturing capacity for PV components was also surging, es-

Construction of new wind farms is predicted to rebound after a period of low growth. However, in contrast to solar manufacturing, the supply chains for wind turbines aren't growing fast enough to meet demand, the agency

Birol also cautioned that power grids must be upgraded and expanded to cope with the intermittent nature of solar and wind power, which require a fundamentally different approach by network operators compared with existing coal, gas or nuclear plants.

The report forecast that several European countries, including Spain, Germany and Ireland, will see wind and solar's combined share of their overall annual electricity generation top 40% by 2024.

Shifting the global economy away from fossil fuels is one of the most important steps for reducing greenhouse gas emissions that cause global warm-

Experts say that to meet the Paris climate accord's goal of limiting temperature rise since pre-industrial times to 1.5 degrees Celsius (2.7 Fahrenheit), emissions need to be halved by 2030 and cut to "net zero" by mid-century.

The International Renewable Energy Agency, a separate body, has called for a major increase in wind and solar investments. Nations are expected to discuss setting an international target for the rollout of renewable energy at this year's U.N. climate summit in

Al chips are hot – here's what they are

Investors see hot gold in them

SAN FRANCISCO, June 5, (AP): The hottest thing in technology is an unprepossessing sliver of silicon closely related to the chips that power video game graphics. It's an artificial intelligence chip, designed specifically to make building AI systems such as ChatGPT faster and cheaper.

Such chips have suddenly taken center stage in what some experts consider an AI revolution that could reshape the technology sector - and possibly the world along with it. Shares of Nvidia, the leading designer of AI chips, rocketed up almost 25% last Thursday after the company forecast a huge jump in revenue that analysts said indicated soaring sales of its products. The company was briefly worth more than \$1 trillion on Tuesday.

So what are ai chips, anyway? That isn't an easy question to answer. "There really isn't a completely agreed upon definition of AI chips. said Hannah Dohmen, a research analyst with the Center for Security and Emerging Technology.

In general, though, the term encompasses computing hardware that's specialized to handle AI workloads - for instance, by "training" AI systems to tackle difficult problems that can choke conventional computers.

Video game origins

Three entrepreneurs founded Nvidia in 1993 to push the boundaries of computational graphics. Within a few years, the company had developed a new chip called a graphics processing unit, or GPU, which dramatically sped up both development and play of video games by performing multiple complex graphics calculations at once.

That technique, known formally as parallel processing, would prove key to the development of both games and AI. Two graduate students at the University of Toronto used a GPU-based neural network to win a prestigious 2012 AI competition called ImageNet by identifying photo images at much lower error rates than competitors.

The win kick-started interest in AIrelated parallel processing, opening a new business opportunity for Nvidia and its rivals while providing researchers powerful tools for exploring the frontiers of AI development.

Modern AI chips

Eleven years later, Nvidia is the dominant supplier of chips for building and updating AI systems. One of its recent products, the H100 GPU, packs in 80 billion transistors - about 13 million more than Apple's latest high-end processor for its MacBook Pro laptop. Unsurprisingly, this technology isn't cheap; at one online retailer, the H100 lists for \$30,000.

Nvidia doesn't fabricate these complex GPU chips itself, a task that would require enormous investments in new factories. Instead it relies on Asian chip foundries such as Taiwan Semiconductor Manufacturing Co. and Korea's Samsung Electronics.

Some of the biggest customers for AI chips are cloud-computing services such as those run by Amazon and Microsoft. By renting out their AI computing power, those services make it possible for smaller companies and groups that couldn't afford to build their own AI systems from scratch to use cloud-based tools to help with tasks that can range from drug dis-

those that deal with personal information, is increasingly drawing the attention of politicians, the U.S. government and national security experts - especially as tensions rise between the U.S. and China. What remains unclear, however, is if this seemingly rou-

tine business acquisition was reviewed by the Committee on Foreign Investment in the U.S., which has authority to examine transactions involving foreign investment. The committee is largely prohibited from publicly disclosing any information filed with it, including if it is reviewing a transaction or if one was referred for review.

While the committee is hardly a household name, its mission and expanding oversight have important implications for the U.S. economy and national security.

The Committee on Foreign Investment, a U.S. government interagency committee established in 1975 by President Gerald Ford, is tasked with studying and coordinating the implementation of policy on foreign investment in

Investment by foreign countries greatly benefits the U.S., supporting 10.1% of the total labor force in 2019. Yet beginning in the 1980s, the federal government grew increasingly concerned about potentially harmful effects of foreign investment in the U.S. For example, if a foreign firm gets control of sensitive technologies, it could hurt national competitive advantages or even threaten national security.

The primary objective of the committee is to review selected foreign investments and some real estate transactions by foreigners in the U.S. for their national security implications. Real estate transactions are generally scrutinized only when a transaction involves land that is either close to a military base or near an airport or seaport.

In the 1980s, political concern grew about Japanese investment and, specifically, the proposed purchase by Japanese computer giant Fujitsu of chipmaker Fairchild Semiconductor. The purchase of Fairfield Semiconductor was considered a sensitive industry, with potential defense applications, and prompted Congress in 1988 to pass the Exon-Florio amendment to the Defense Production Act of 1950.

This amendment empowered the committee to not just review foreign investment deals but also to recommend rejecting them. Acting on its recommendation, a U.S. president could block a foreign transaction on "national security" grounds. For instance, in 1990, President George H. W. Bush voided the sale of MAMCO Manufacturing, which made metal parts for airplanes, to a Chinese agency, ordering the China National Aero-Technology Import & Export

Corporation to divest itself of the Seattle-based company. In the context of a committee review, the term national security typically refers to foreign transactions that could cause significant outsourcing of jobs, a loss of control over agricultural supply chains, the sharing of sensitive technologies, control of a firm that satisfies defense needs, or the impairment of critical infrastructure.

In 2006, Dubai Ports World, owned by the United Arab Emirates government, was about to gain managerial control of six U.S. ports in a major deal. Because of terrorism-related concerns, Sen. Chuck Schumer led a campaign against this proposal and the transaction was eventually called off, even though it had initially been approved by both the committee and President George W. Bush.

OpenAI boss is 'heartened' by talks with world leaders over will to contain Al risks

TEL AVIV, Israel, June 5, (AP): OpenAI CEO Sam Altman said Monday he was encouraged by a desire shown by world leaders to contain any risks posed by the artificial intelligence technology his company and others are developing.

Altman visited Tel Aviv, a tech powerhouse, as part of a world tour that has so far taken him to several European capitals. Altman's tour is meant to promote his company, the maker of ChatGPT - the popular AI chatbox - which has unleashed a frenzy around

"I am very heartened as I've been doing this trip around the world, getting to meet world leaders," Altman said during a visit with Israel's ceremonial President Isaac Herzog. Altman said his discussions showed "the thoughtfulness" and "urgency" among world leaders over how to figure out how to "mitigate these very huge risks."

The world tour comes after hundreds of scientists and tech industry leaders, including high-level executives at Microsoft and Google, issued a warning about the perils that artificial intelligence poses to humankind. Alt-

man was also a signatory. Worries about artificial intelligence systems outsmarting humans and running wild have intensified with the rise of a new generation of highly capable AI chatbots. Countries around the world are scrambling to come up with regulations for the developing technology, with the European Union blazing the trail with its AI Act expected to be approved later this year.

"With the great opportunities of this incredible technology, there are also many risks to humanity and to the independence of human beings in the future," Herzog told Altman. "We have to make sure that this development is used for the wellness of humanity."

Israel has emerged in recent years as a tech leader, with the industry producing some noteworthy technology used across the globe.

Among its more controversial exports has been Pegasus, a powerful and sophisticated spyware product by the Israeli company NSO, which critics say has been used by authoritarian countries to spy on activists and dissidents.



Harry's lawyer said the Duke of Sussex would be unavailable to tes-

tify following opening statements because he'd taken a flight from Los Angeles after the birthday of his 2-year-old daughter, Lilibet, on Sunday. "I'm a little surprised," Justice Timothy Fancourt said, noting he had directed Harry to be in court for the first day of his case.

Mirror Group Newspaper's lawyer, Andrew Green, said he was "deeply troubled" by Harry's absence on the trial's opening day. The case against Mirror Group is the first of the prince's several law-

suits against the media to go to trial, and one of three alleging tabloid publishers unlawfully snooped on him in their cutthroat competition for scoops on the royal family.

Harry's lawyer, David Sherborne, said phone hacking and forms of unlawful information gathering were carried out on such a widespread scale, it was implausible the publisher's newspapers used a private investigator to dig up dirt on the prince only once, which is what they

"The ends justify the means for the defendant," Sherborne said. Stories about Harry were big sellers for the newspapers, and some 2,500 articles had covered all facets of his life - from his illnesses at school to ups and downs with girlfriends, Sherborne said.

"There was no time in his life when he was safe from these activities," Sherborne said. "Nothing was sacrosanct or out of bounds." Mirror Group has said it used documents, public statements and

sources to legally report on the prince. But Sherborne it was not hard to infer that Mirror journalists used the

same techniques on Harry - eavesdropping on voicemails and hiring private eyes to snoop - as they did on others.

Harry had been scheduled to testify Tuesday, but his lawyer was told last week the duke should attend Monday's proceedings in London's High Court in case the opening statements concluded before the end

Harassment

When he enters the witness box, Harry, 38, will be the first member of the British royal family in more than a century to testify in court. He is expected to describe his anguish and anger over being hounded by the media throughout his life, and its impact on those around him.

He has blamed paparazzi for causing the car crash that killed his mother, Princess Diana, and said harassment and intrusion by the UK press, including allegedly racist articles, led him and his wife, Meghan, to flee to the US in 2020 and leave royal life behind.

The articles at issue in the trial date back to his 12th birthday, in 1996, when the Mirror reported Harry was feeling "badly" about the divorce of his mother and father, now King Charles III.

Harry said in court documents that ongoing tabloid reports made him wonder whom he could trust as he feared friends and associates were betraying him by leaking information to the newspapers. His circle of friends grew smaller, and he suffered "huge bouts of depression and paranoia." Relationships fell apart as the women in his life - and even their family members - were "dragged into the chaos."

He says he later discovered that the source wasn't disloyal friends but aggressive journalists and the private investigators they hired to eavesdrop on voicemails and track him to locations as remote as Argentina and an island off Mozambique.

Mirror Group Newspapers said it didn't hack Harry's phone and its articles were based on legitimate reporting techniques. The publisher admitted and apologized for hiring a private eye to dig up dirt on one of Harry's nights out at a bar, but the resulting 2004 article headlined "Sex on the beach with Harry" is not among the 33 in question at trial.

Phone hacking that involved guessing or obtaining security codes to listen in on celebrities' cell phone voice messages was widespread at British tabloids in the early years of this century. It became an existential crisis for the industry after the revelation in 2011 that the News of the World had hacked the phone of a slain 13-year-old girl.

Owner Rupert Murdoch shut down the paper and several of his executives faced criminal trials.

Nolan breaks down the best ways to watch a movie **NEW YORK:** "Spider-Man: Across the Spider-Verse" opened in US and 'Oppenheimer' made to be seen on big screen Canadian theaters with a massive \$120.5 million, more than tripling

> LOS ANGELES, June 5, (AP): It's no secret that Christopher Nolan made "Oppenheimer" to be seen on the big screen. But not all big screens are created equal. That's part of the reason why Universal Pictures has made "Oppenheimer" tickets available early for over a thousand "premium large format" (or PLF) screens, with options including IMAX 70mm, 70mm, IMAX digital, 35mm, Dolby Cinema and more.

Knowing that even those words can get overwhelming and technical, Nolan went a step further: In an exclusive interview with The Associated Press, he offered a guide to his favorite formats, explaining why it matters and even where he likes to sit so that audiences don't feel like they need a film school degree (or one in

theoretical physics) before settling on a theater. 'You rarely get the chance to really talk to moviegoers directly about why you love a particular format and why if they can find an IMAX screen to see the film on that's great," Nolan said. "We put a lot of effort into shooting the film in a way that we can get it out on these large format screens. It really is just a great way of giving people an experience that they can't possibly get in the home.

In a film about J. Robert Oppenheimer, the theoretical physicist who oversaw the development of first atomic bomb during World War II, this will be especially pivotal in viewing the Trinity Test, the first detonation of a nuclear weapon. Nolan and his effects teams recreated the blast, with all its blinding brilliance.

"We knew that this had to be the showstopper," Nolan said. "We're able to do things with picture now that before we were really only able to do with sound in terms of an oversize impact for the audience-an almost physical sense of response to the film.'

"Oppenheimer," starring Cillian Murphy, opens in theaters on July 21.

"Oppenheimer" was shot using some of the highest resolution film cameras that exist. Like "Dunkirk" and "Tenet," "Oppenheimer" was filmed entirely on large format film stock, meaning a combination of IMAX 65mm and Panavision 65mm (think David Lean/"Lawrence of Arabia"), that's then projected in

"The sharpness and the clarity and the depth of the

image is unparalleled," Nolan said. "The headline, for me, is by shooting on IMAX 70mm film, you're really

and you're filling the peripheral vision of the audience. You're immersing them in the world of the film." Nolan has been shooting with IMAX cameras since "The Dark Knight." Audiences would regularly gasp at seeing its first shot projected in IMAX 70mm. Though it's "just a helicopter shot" of some buildings in Chi-

cago, it helps explain the ineffable power of the format. On a technical level, the IMAX film resolution is almost 10 times more than a 35mm projector and each frame has some 18,000 pixels of resolution versus a

home HD screen that has 1,920 pixels. The 5mm difference goes back to when that extra space on the film had to be reserved for the soundtrack. With digital sound, that's unnecessary and it is "purely a visual enhancement," Nolan explained.

Disappears

"We have to plan very carefully because by shooting an IMAX film, you capture a lot of information," he said. "Your movie is going to translate very well to all the formats because you're getting the ultimate amount of visual information. But there are different shapes to the screen - what we call aspect ratios. What you have to plan is how you then frame your imagery so that it can be presented in different theaters with equal suc-

Starting with "The Dark Knight," they developed a system that they call "center punching the action" so that nothing is lost.

Cinematographer Hoyte van Hoytema is also always aware of the "frame lines for the different theaters" when looking through the camera. On the biggest presentations, IMAX 1.43:1 (the mas-

sive square screen) the screen essentially disappears for the audience. For other formats like 35mm, the top and the bottom get cropped.

But, Nolan said, "from a creative point of view, what

we've found over the years is that there's no compromise to composition.

"I knew that I had two timelines that we were running in the film," Nolan said. "One is in color, and that's Oppenheimer's subjective experience. That's the bulk of the film. Then the other is a black and white timeline. It's a more objective view of his story from a different character's point of view.'

Nolan's desire for the black and white portions to be of equal image quality to the rest of the film led to the development of the first ever black and white IMAX film stock, which Kodak made and Fotokem developed.

"We shot a lot of our hair and makeup tests using black and white. And then we would go to the IMAX film projector at CityWalk and project it there," he said. "I've just never seen anything like it. To see such a massive black and white film image? It's just a wonder-

ful thing."

For Nolan, the "best possible experience" to view "Oppenheimer" in theaters is the IMAX 70mm film presentations. These are also among the rarest, currently set for 25 locations in North America including the AMC Universal CityWalk in Los Angeles, the AMC Lincoln Square in New York, the Cinemark Dallas, the Regal King of Prussia near Philadelphia and the Auto-Nation IMAX in Fort Lauderdale.

The prints span over 11 miles of film stock, weigh some 600 pounds and run through film projectors horizontally.

There will also be over one hundred 70mm prints ("a fabulous presentation," Nolan said) sent to theaters around the world, with over 77 (and more to come) on sale in North America at major chains and many independent locations like the Music Box in Chicago and the AFI Silver in Washington D.C.

"The two formats are sort of different and I love them both," he said.

The sequences projected in IMAX 70mm really "come to life" on those screens, and vice versa for the 70mm sequences on those specific projectors. In IMAX theaters, for example, things shot with IMAX film cameras will expand vertically to fill the entire screen.

HK journo wins appeal

Chuck Todd is leaving NBC 'Meet the Press'

NEW YORK, June 5, (AP): **Chuck Todd** said on Sunday that he'll be leaving "Meet the Press" after a tumultuous near-decade of moderating the NBC political panel show, to be replaced in the coming months

by Kristen Welker.
Todd, 51, told viewers that "I've watched too many friends and family let work consume them before it was too late" and that he'd promised his family he wouldn't do that.

Todd has often been an online punching bag for critics, including Donald Trump, during a polarized time, and there were rumors that his time at the show would be short when its executive producer was reassigned at the end of last summer, but NBC gave no

indication this was anything other than Todd's decision. It's unclear when Todd's last show will be, but he told viewers that this would be his final summer.
"I leave feeling concerned

about this moment in history but reassured by the standards we've set here," Todd said.
"We didn't tolerate propagandists, and this network and program never will."

Welker, a former chief White House correspondent, has been at NBC News in Washington since 2011 and has been Todd's chief fill-in for the past three years. She drew praise for moderating the final presidential

debate between Trump, a Republican, and Joe Biden,

a Democrat, in 2020. Her "sharp questioning of lawmakers is a master-class in political interviews," said Rebecca Blumen-stein, NBC News president of editorial, in a memo

announcing Welker's elevation on Sunday.

Now Welker, 46, will be thrust into what promises

to be another contentious presidential election cycle.

The Sunday morning political interview show has aired since 1947, led by inventor and first host Martha Rountree. Its peak came in the years that Tim Russert moderated, from 1991 until his death in 2008, with its footing less certain since then. Tom Brokaw briefly filled in after Russert's death, and David Gregory replaced him until being forced out in favor of Todd.

Moderator

Welker will be the first Black moderator of "Meet the Press" and the first woman since Rountree left in

Todd said that he was proud of expanding the "Meet the Press" brand to a daily show, which initially aired on MSNBC but was shifted to streaming, along with podcasts and newsletters, even a film festival.

"He transformed the brand into a vital modern-day franchise, expanding its footprint to an array of new mediums, and kept 'Meet the Press' at the forefront of

medians, and kept wheet the Fress at the foreign of political discourse," Blumenstein said.

It didn't stop critics from jumping on to social media when they didn't like an interview Todd conducted. Trump even anointed Todd with one of his signature nicknames, Sleepy Eyes, and later called on NBC to fire Todd in 2020 over its airing of a CBS interview clip with his then-Attorney General William Barr. Todd later said the show had been unaware at the time of a longer soundbite of the interview that would have provided more context, and he apologized for the mistake.

Todd was roasted at the White House Correspondents' Association dinner in 2022 by Trevor Noah, who pointed him out in the audience and said, "How are you doing? I'd ask a follow-up, but I know you don't know what those are."

Todd alluded to his critics in announcing his exit on Sunday

"If you do this job seeking popularity, you are doing this job incorrectly," he said. "I take the attacks from partisans as compliments. And I take the genuine compliments with a grain of salt when they come from partisans.

The goal of each show, he said, is to "make you mad, make you think, shake your head in disapproval at some point and nod your head in approval at oth-

In the just-concluded television season, "Meet the Press" was third in viewers after CBS' "Face the Nation" and ABC's "This Week," each of them averaging between 2.5 million and 2.9 million viewers, the Nielsen ratings company said.

HONG KONG: An award-winning Hong Kong journalist won an appeal quashing her conviction related to work on her investigative documentary Monday in a rare court ruling upholding media freedom in the territory

Bao Choy was found guilty in April 2021 of deceiving the government by getting vehicle ownership records for journalistic purposes after she had declared in her online application that she would use the information for "other traffic and transport related issues.'

The investigative journalist was trying to track down perpetrators of a mob attack on protesters and commuters inside a train station during the massive anti-government protests in 2019 for her documen-

Choy was fined 6,000 Hong Kong Dollars (\$765) for two counts of making false statements at that time and called it "a very dark day for all journalists in Hong Kong." That ruling also sparked outrage among local journalists over the city's shrinking press free-

On Monday, judges of the city's top court unanimously ruled in Choy's favor in a written judgment, quashing her conviction and setting aside the sentence.

'The issues of falsity and knowledge were wrongly decided against the appellant because her journalistic investigation into the use of the vehicle on the dates in question did fall into the wide catchall category of 'other traffic and transport related matters'," the judgment read.

Even if it did not, it was "not an irresistible inference that she knew that to be false," the judgment said. There is no reason that "bona fide journalism" should be excluded from the phrase, it added.

Chov told reporters outside the court the she was happy to learn about the judgment, saying it had stated the importance of the city's constitutionally protected freedom of press and speech.

AMSTERDAM: The blockbuster exhibition of paintings by Dutch Master Johannes Vermeer closed its doors for the final time on Sunday, with the art and history national museum of the Netherlands hailing the show as its most successful ever. The Rijksmuseum said the exhibition

that drew on collections around the world to bring together 28 of the 37 paintings generally ascribed to Vermeer attracted 650,000 visitors from 113 countries during its 16-week run that started in early February.

The large number of visitors - including French President Emmanuel Macron, movie director Steven Spielberg and Oscar winner Jamie Lee Curtis - came despite the museum limiting numbers to ensure everybody got a good view of masterpieces such as "Girl with a Pearl Earring" and "The Milkmaid."

"Vermeer is the artist of peacefulness and intimacy. We wanted the visitors to enjoy it to the fullest," museum general director Taco Dibbits said. "This was only possible by limiting the number of

The exhibition included seven paintings that had never previously been displayed publicly in the Netherlands, among them three from The Frick Collection in New York.

For art lovers who didn't manage to get their hands on one of the highly-sought-after tickets, six Vermeer paintings will remain on show in the Rijksmuseum's Gallery of Honor - four from the museum's own collection along with "The Girl with the Red Hat" from the National Gallery of Art in Washington and "Young Woman Seated at a Virginal" from The Leiden Collection in New York. (AP)

LOS ANGELES: A former model who alleges Bill Cosby drugged and sexually assaulted her and another woman at his home in 1969 sued him under a new California law that suspends the statute of limitations on sex abuse claims.

In her lawsuit, Victoria Valentino, 80, says she was an actress and singer 54 years ago, when she met Cosby, now 85. The comedian and actor later approached her at a Los Angeles café, where he spotted her crying over the recent drowning death of her 6-vear-old son.

Young artist doesn't dodge his father's legacy

Prine makes his own way in music

NASHVILLE, Tenn., June 5, (AP): Standing before a packed house at The Basement, one of Nashville's most intimate music venues, Tommy Prine talked about the death of his

"It sucks to lose a parent at any age - in my case when he was the world's greatest songwriter," he said during a recent sold-out show.

Prine's father, singer-songwriter John Prine, died of complications from the coronavirus in April 2020 at the age of 73. His death prompted a surge of worldwide mourning remarkable even for a time in which grief had become an everyday thing.

The heartbreak was especially acute in the music world. John Prine's kindness to aspiring musicians only added to the connections he made with his music. Many channeled their grief into tribute songs, straining to process the unthinkable.

It turns out something similar was happening in Prine's own family.

Last year, Tommy Prine released "Ships in the Harbor," a song as moving and vulnerable as anything written by anyone about Prine's father. It doesn't run from what he lost but pushes back against the impulse to curl up in the fetal position. It comes as close as any song out there to putting the colossal weight of grief caused by the pandemic in its proper place.

Now 27, Tommy Prine is poised to put out an entire album of songs about loss, love and and growing up. "This Far South," set for release on June 23, is brave not only in the head-on way it deals with his father's death, but in how the son of a legend confronts the inevitable questions that come with practicing the same craft.

In an undertaking laced with risk, Tommy Prine neither turns away nor tries too hard. He's made an album that's all his own and it's mesmer-

"Honestly, even if my Dad wasn't who he was, I feel like I would've made the same record," Prine said in an interview with The Associated Press. "I didn't include these songs because of who he is, and I also didn't shy away from them because of who he is."

Writing songs helped Prine sort through all he had lost. The intimacy of that journey makes his father's legendary status feel almost like a distraction.

"I'm Tommy Prine and I lost my Dad in the pandemic, and that's going to be a focal point of what I'm trying to get across," he explained. "And like, I understand that it was a pretty public thing, and most people are going to have that context - and I think it will actually serve the record that they have that context - but you know, I don't think that they need to.

"I think they can just listen to it from the perspective of a young man who lost his father too soon."

Experience

The occasional references are vivid but never cloying: The card games they won't play, the conversations they won't have. In a beautiful song called "By the Way," he touches on the unique experience of hearing his father's voice in unexpected moments.

"I don't want to talk about the day you slipped away," Prine sings. "It's still hard to hear your voice in the songs that we used to sing.

But Prine shares other vulnerabilities, and the influences of people who aren't his father figure in as much or even more. The hand of co-producer Ruston Kelly, for example, can be heard in the album's anthemic flourishes and confessional lyrics. A song called "Reach the Sun" starts with a late-night panic attack but ultimately soars in a style reminiscent of Kelly's

best work, including the excellent album he just released. Kelly joined Prine on stage at The

Basement, and in an interview afterward mentioned another influence on both of them, Sufjan Stevens. Kelly had steered Prine toward Stevens' "Carrie & Lowell" album, and Prine heard a sound suited to the wistful urgency he wanted to convey.

Prine said he never set out to be a singer-songwriter - "It was probably the last thing I wanted to do for the rest of my life" - but it proved to be a "saving grace" when he confronted the challenge of losing his father.

Given the shadow that looms over anyone named Prine who dares to try his hand at creating original music, listeners would do well to imagine how they would respond if they didn't know this album came from the son of a legend. It's possible, maybe even likely, that Prine's music will find a whole new audience, on social media and in other ways music passes from hand to hand these days. Some listeners his age and younger may never have heard of his father, but these songs will make connections on their own.

But anyone who listens will hear the promise of an artist following his heart with uncommon courage. John Prine fans might hear something familiar in the album's disarming honesty, but they'd also encounter a new voice delivering music that crackles with intensity.

Prine says he doesn't think about the legacy question much, though it has crossed his mind. But that's just one more thing that he has put in its proper place.

"Î'm just making the music that I want to make, and music that is a representation of who I am as a person," he said. ""I had a completely different set of experiences growing up than my father had, and I have my own story to tell."

heels of lawsuits last year by six Cosby accusers in New York under a similar provision known as a "lookback" law that allows adults to file sexual abuse cases for allegations that had fallen outside the statute of limitations.

The former "Cosby Show" star, who has been accused of rape, sexual assault and sexual harassment by at least 60 women, has denied all allegations involving sex crimes. He was the first celebrity tried and convicted in the #MeToo era - and spent nearly three years at a state prison near Philadelphia before a higher court threw out the conviction and released him in 2021.

His spokesperson, Andrew Wyatt, said that Valentino's lawsuit lacks "any proof or facts" and that so-called lookback laws violate constitutional rights aimed at protecting crime victims and "those that are accused of a crime."

"What graveyard can Mr Cosby visit, in order to dig up potential witnesses to testify on his behalf?" Wyatt asked in a statement. "America is continuing to see that this is a formula to make sure that no more Black Men in America accumulate the American Dream that was secured by Mr Cosby.

The lawsuit in LA County Superior Court was filed nearly two years after Cosby left prison when the Pennsylvania Supreme Court overturned his 2018 sexual assault conviction. (AP)

'Avoid off-brand drugs'

Hormone patches have lower BP risk than pills

WASHINGTON, June 5, (AP): Women often use hormone therapy to relieve hot flashes and other menopause symptoms - and new research suggests patches or creams may be safer for their blood pressure than pills.

As women's bodies produce lower levels of reproductive hormones during menopause their risk for heart disease rises. High blood pressure further increases that risk — but it's not clear whether there's a link with hormone therapy for meno-

Canadian researchers wondered if the way hormones are absorbed - orally, vaginally or through the skin -- could play a role.



a 19% greater risk than vaginal versions.

The University of Calgary team examined health records of more than 112,000 women ages 45 and older who filled prescriptions for at least six months' worth of estrogenonly hormone treatment between 2008 and 2019. They tracked which women went on to develop high blood pressure at least a year after starting treat-

While the differences weren't huge, women who took estrogen pills had a 14% higher risk of developing hypertension compared to those using skin patches or creams, the researchers reported Monday. Oral estrogen carried

The findings were published in the journal Hypertension. Hormone therapy has a mix of risks and benefits that mean it's not for everyone. Today it's prescribed not to prevent disease but to relieve menopause-related symptoms - generally using the lowest possible dose for the shortest time. Most commonly used are combination pills of estrogen and another hormone, progestin. (Estrogen-only pills typically are prescribed to women without a uterus.)

Different versions of hormone therapy may work better for different menopause symptoms, something the study didn't

But it adds important clues to understanding the complex relationship between hormone therapy and blood pressure, said Dr. Garima Sharma, a women's heart specialist with Virginia's Inova Health System and the American Heart Association.

Sharma would like to see a more rigorous trial that compares different hormone versions. But she pointed to a possible biological explanation: Maybe oral estrogen affects enzymes linked to blood pressure as it's being processed, while skin and vaginal versions have much more limited activity in the body.

Still, "these findings are very clinically relevant," Sharma said in an an email, and suggest it's especially important to monitor blood pressure in women who use oral hormone therapy.

Obesity: The US Food and Drug Administration is warning consumers not to use off-brand versions of the popular weight-loss drugs Ozempic and Wegovy because they might

and may not be safe or effective. Agency officials said this week that they have received reports of problems after patients used versions of semaglutide, the active ingredient in the brand-name medications, which have been compounded, or mixed in pharmacies. Officials didn't say what the problems were.

not contain the same ingredients as the prescription products

The trouble is that those versions, often sold online, contain a version of semaglutide that is used in lab research and has not been approved for use in people.

"Compounded drugs are not FDA-approved, and the agency does not verify the safety or effectiveness of compounded drugs," the notice said.

Sales of semaglutide products have soared in the past few years after the drug was shown to spur fast and significant weight loss. The drugs manufactured by Novo Nordisk include brands Ozempic and Rybelsus, used to treat diabetes, and Wegovy, approved to treat obesity.

Demand for the medications has outstripped supply. As of May, Ozempic and Wegovy remain on the FDA's list of drug shortages. When drugs are in short supply, compounding pharmacies are permitted to produce versions of those

Consumers should only use drugs containing semaglutide with a prescription from a licensed health care provider and obtained from a state-licensed pharmacy or other facilities registered with the FDA, the agency said.

Births: US births were flat last year, as the nation saw fewer babies born than it did before the pandemic, the Centers for Disease Control and Prevention reported Thursday.

Births to moms 35 and older continued to rise, with the highest rates in that age group since the 1960s. But those gains were offset by record-low birth rates to moms in their teens and early 20s, the CDC found. Its report is based on a review of more than 99% of birth certificates issued last year.

A little under 3.7 million babies were born in the U.S. last year, about 3,000 fewer than the year before. Because the numbers are provisional and the change was small, officials consider births to have been "kind of level from the previous year," said the CDC's **Brady Hamilton**, the lead author of the report.

U.S. births were declining for more than a decade before COVID-19 hit, then dropped a whopping 4% from 2019 to 2020. They ticked up about 1% in 2021, an increase experts attributed to pregnancies that couples had put off amid the

early days of the pandemic. More findings from the report:

■ The highest birth rates continue to be see in women in their early 30s. The number of births for women that age was basically unchanged from the year before. Births were down slightly for women in their late 20s, who have the second-

■ Births to Hispanic moms rose 6% last year and surpassed 25% of the US total. Births to white moms fell 3%, but still accounted for 50% of births. Births to Black moms fell 1%, and were 14% of the total.

■ The cesarean section birth rate rose slightly, to 32.2% of births. That's the highest it's been since 2014. Some experts worry that C-sections are done more often than medically

■ The US was once among only a few developed countries with a fertility rate that ensured each generation had enough children to replace itself — about 2.1 kids per woman. But it's been sliding, and in 2020 dropped to about 1.6, the lowest rate on record. It rose slightly in 2021, to nearly 1.7, and stayed there last year.

More complete and detailed 2022 numbers are expected later this year. That data should offer a better understanding of what happened in individual states and among different racial and ethnic groups, Hamilton said.

It also may show whether births were affected by the U.S. Supreme Court decision last June overturning Roe v. Wade, which allowed states to ban or restrict abortion. Experts estimate that nearly half of pregnancies are unintended, so limits to abortion access could affect the number of births.

If such restrictions are having an affect on births, it didn't show up in the national data released Thursday.

It's possible the abortion restrictions will lead to higher births rates in 2023 — more likely among younger women than older moms, said Ushma Upadhyay, a reproductive health researcher at the University of California, San Francisco. But even if there is a rise, it may not bring the nation back to pre-pandemic birth levels, given other trends, she added. "I don't know if we'll ever get back there," she said.

Island marks 1,000th bday: France's beloved abbey of Mont-Saint-Michel has reached a ripe old age. It's been 1,000 years since the laying of its first stone.

The millennial of the UNESCO World Heritage site and key Normandy tourism magnet is being celebrated until November with exhibits, dance shows and concerts. French President Emmanuel Macron is heading there on Monday.

Macron plans to deliver a speech and to see a new exhibit tracing the Romanesque abbey's history via 30 objects and pieces, including a restored statue of Saint Michael. Legend has it that the archangel Michael appeared in 708, duly instructing the bishop of nearby Avranches to build him a church on the rocky outcrop.

The exhibit, two years in the making, opened last month. It covers the complex process of building what is considered an architectural jewel on a rocky island linked to the mainland only by a narrow causeway at high tide.

Four crypts were constructed on the granite tip along with a church on top. The exhibit explains how the original structure. built in 966, became too small for pilgrims, spurring on the builders to create the 11th century abbey that stands to this day.

France has spent more than 32 million euros (\$34 million) over 15 years to restore the building, and the work is nearing completion. Authorities have also tried in recent years to protect the monument's surrounding environment from the impact of mass tourism.

One of the most popular French destinations outside Paris, Mont-Saint-Michel island attracted 2.8 million visitors last year, including 1.3 million for the abbey. It was not closed to visitors for the presidential visit, but local authorities were taking measures for it to go as smoothly as possible. (AP)

Stem cell therapies can provide new ways to stop tumors

Triggering cancers to become normal cells

How cells become cancerous is a process researchers are still trying to fully understand. Generally, normal cells grow and multi-ply through controlled cell division, where old and damaged cells are replaced after they die by new cells. Sometimes this process stops working, leading cells to start growing uncontrollably and develop into a tumor.

Traditionally, cancer treatments like chemotherapy, immunotherapy, radiation and surgery focus on killing cancer cells. Another type of treatment using stem cells called differentiation therapy, however, focuses on persuading cancer cells to

become normal cells. We are researchers who study how stem cells, or immature cells that can develop into different types of cells, behave in states of health and disease. We believe that stem cells can provide potential treatments for cancer of all types in many different

ways. Stem cells are unspecialized cells, meaning they can eventually become any one of the various types of cells that make up different parts of the body. They can replenish cells in the skin, bone, blood and other organs during development, and regenerate and repair tissues when they're dam-

There are different types of stem cells. Embryonic stem cells are the first cells that initially form after a sperm fertilizes an egg, and can give rise to all other cell types in the human body. Adult stem cells are more mature, meaning they can replace damaged cells only in one type of organ and have a limited ability to multiply. Researchers can reprogram adult stem cells, or differentiated cells, in the lab to act like embryonic stem cells.

Because stem cells can survive

longer than regular cells, they have a much higher probability of accumulating genetic mutations that can result in loss of control over their growth and ability to regenerate. This is why many tumors harbor a small subpopulation of cells that function like stem cells. These socalled cancer stem cells are thought to be responsible at least in part for cancer initiation, progression, metastasis, recurrence and treatment resistance.

Accumulating evidence is also showing that cancer stem cells can differentiate into multiple cell types, including noncancerous cells. Researchers are taking advantage of this fact through a type of treatment called differentiation therapy.

Differentiation

The concept of differentiation therapy originated from scientists observing that hormones and cytokines, which are proteins that play a key role in cell communication, can stimulate stem cells to mature and lose their ability to regenerate. It followed that forcing cancer stem cells to differentiate into more mature cells could subsequently stop them from multiplying uncontrollably, making them become normal

cells. Differentiation therapy has been successful in treating acute promyelocytic leukemia, an aggressive blood cancer. In this case, retinoic acid and arsenic are used to block a protein that stops myeloid cells, a type of blood cell derived from the bone marrow, from fully maturing. By allowing these cells to fully mature, they lose their cancerous quali-

Furthermore, because differentiation therapy doesn't focus on killing cancer cells and doesn't surround healthy cells in the body with harmful chemicals, it can be less toxic than traditional treatments.

There are many other potential ways to use stem cells to treat cancer. For example, cancer stem cells

can be directly targeted to stop their growth, or turned into "Trojan horses" that attack other tumor cells.

Quiescent cancer stem cells, which don't divide but are still alive, are another potential drug target. These cells typically play a big role in treatment resistance for various cancer types because they are able to regenerate and avoid death even better than regular cancer stem cells. Their quiescent quality can persist for decades and lead to a cancer relapse. They are also challenging to distinguish from regular cancer stem cells, making them difficult to study.

Researchers can also genetically engineer stem cells to express a protein that binds to a desired target in a cancer cell, increasing the efficacy of treatments by releasing drugs right at the tumor. For example, mesenchymal stem cells derived from bone marrow naturally migrate toward and stick to tumors, and can be used to deliver cancer drugs directly to cancer cells.

Stem cells can also be used to make organoid models, or miniature versions of organs, to screen potential cancer drugs and study the underlying mechanisms that lead to cancer.

Although, stem cells hold numerous advantages in their use in cancer therapy, they also face various challenges. For example, many current stem cell therapies that aren't used in combination with other drugs are unable to completely eliminate tumors. There are also concerns about stem cell therapies potentially promoting tumor growth.

Despite these challenges, we believe that stem cell technologies have the potential to open new avenues for cancer therapy. Integrating genetic engineering with stem cells can overcome the major drawbacks of chemotherapeutics, such as toxicity to healthy cells. With further research, cancer stem cell therapies may one day become part of the standard of care for many types of

Benzema scores in final game with Real

MADRID, June 5, (AP): Karim Benzema converted his penalty kick and received a standing ovation from fans before being substituted at the Santiago Bernabeu Stadium, bringing an end to his memorable career with Real Madrid.

Benzema was replaced after scoring the 72nd-minute equalizer in Madrid's 1-1 draw against Athletic Bilbao in his final game with the Spanish powerhouse after 14 seasons. Madrid had announced earlier Sunday that the French striker would not return next season.

The last round of the Spanish league also saw Vinícius Júnior's return to action for the first time since he was racially abused in a league match against Valencia two weeks ago, as well as Valladolid's rel-

Vinícius hadn't played in the last two Madrid games following the latest incident of racist insults targeted at him in Valencia on May 21, prompting a widespread reaction from Spanish authorities and the soccer world. The club had said he was sidelined with a minor knee problem.

The Brazil forward wasn't able to score, having a 79th-minute goal disallowed for offside

Benzema did find the net in his farewell

He fired in a low shot from the spot, then celebrated by sending kisses to the crowd at the Bernabeu. He was immediately substituted by Madrid coach Carlo Ancelotti, receiving a big ovation from the fans.

in the world and one of the best strikers," Ancelotti said. "We can't be pleased about his departure, but we have to respect his decision. He's earned the right to choose and we all thank him for everything he's done for this club. He's been a legendary, unforgettable figure, and he'll remain forever in the memory of this club." Benzema's farewell came amid reports he will play in Saudi Arabia next season.

After the match, Madrid players threw Benzema up in the air a few times, as they did for the other players not returning next season - Marco Asensio, Eden Hazard and Mariano Díaz.

Still wearing the captain's armband, Benzema went near the stands and applauded the fans.

The result allowed Madrid to finish in second place ahead of Atletico Madrid, which drew 2-2 at Villarreal after conceding a stoppage-time equalizer.

"It was a pleasure to play with him," Madrid goalkeeper Thibaut Courtois said of Benzema. "He is an excellent player, a legend. It's a pity that he is leaving but we understand that he has the right to choose his destiny." The 35-year-old striker has been with Madrid since 2009. He helped the club win a record 25 titles, including five Champions Leagues, five Club World Cups and four Spanish leagues.

Benzema ended his career with Madrid with 354 goals - the second-most all-time - and 648 appearances, which is the fifthmost all-time.

Valladolid became the last team to be relegated after it was unable to get more than a 0-0 draw at home against Getafe.

A win would have been enough for the club owned by former Brazil striker Ronaldo, which was in the top flight after spending a year in the second division in 2021-22.

"There is not a lot to explain, we tried but couldn't score the goal that we needed," Valladolid goalkeeper Jordi Masip said. "It's a disappointment for the club, the fans and the entire city." Hovland closed with a 2-under 70 on another brutal test on a course baked all week by sun, forcing the playoff with a 30-foot birdie on the 17th - the only one on that hole in the final round - and saving par from behind the 18th green.

Back to the 18th in the playoff, Hovland barely got onto the front of back pin, and two-putted by holing a 7-foot par putt.

It was his fourth PGA Tour victory and first on American soil, this one with a \$3.6 million winner's check and a handshake from host Jack Nicklaus. The Norwegian's previous wins were in Mexico twice and Puerto Rico.

It was a crushing loss for McCarthy, one of the purest putters on the PGA Tour. He showed his touch by saving crucial pars and playing bogey-free on a day when the average score was just under 75. His only bogey came on the 18th hole - twice.

Rory McIlroy chipped in from below the fourth green for birdie and had the lead on the front nine, but he gave away far too many shots on the back - three bogeys in a row - for a 75 that

took him out of the picture.

Saudi Arabian soccer 'league' to get more funding from Kingdom

RIYADH, Saudi Arabia, June 5, (AP): Cristiano Ronaldo is already in Saudi Arabia. Karim Benzema looks sure to be next. And as the oil-rich kingdom pursues Lionel Messi as well, it is making sure that money continues to

flow into the domestic soccer league. Saudi Arabia on Monday made its already obvious intentions in world soccer even clearer by announcing a "privatization project" for companies to spend more on clubs - part of the Vision 2030 national development policy promoted by Crown Prince Mohammed bin Salman, who is also prime

Saudi public sector organizations also will be encouraged to invest in sports with teams in the national soccer league a top priority.

"The Saudi Pro League ... will be supported in its ambition to be amongst the top 10 leagues in the world," the state-owned Saudi Press Agency said

in a news release. Ronaldo has been the headline attraction so far, joining the Al Nassr club in January on a reported salary of

\$200 million a year. Benzema's move to join his former long-time Real Madrid teammate in the Saudi league is expected to be confirmed after he played an emotional farewell game Sunday after 14 years

with the 14-time European champion. Messi played his last game for Qatar-owned Paris Saint-Germain on Saturday and is weighing offers from Saudi Arabia and Inter Miami in Major League Soccer. He is also reportedly considering a potential return to Barcelona, where he spent 16 years before reluctantly leaving the financially troubled club for PSG in 2021.

The Saudi league has players from "over 40 different countries and has seen attendances increase by nearly 150% in the last year," the statement from the SPA said. "The privatization and ownership transfer of clubs aims to accelerate progress in a variety of sports across the kingdom further growing participation, providing cutting edge facilities, increasing competition and nurturing future champi-

Saudi Arabia's domestic soccer and homegrown players are also flourish-

The national team stunned Messi and Argentina with a 2-1 victory in their opening game at the World Cup in Qatar in November, and the Al-Hilal club won the Asian Champions League title in 2019 and 2021.

Busch, who had held off Kyle Larson on each previous restart, had one last phenomenal jump in him. He was well ahead of the rest of the field by the backstretch with just over a lap left and was never seriously challenged by Hamlin after he took the white flag, giving Richard Childress Racing another victory after triumphs at Talladega and Auto Club Speed-

"Any time we give him a car capable of winning, he's going to win it," Chil-dress said. "Those last three or four or however many restarts, I thought that was pretty tough, but I knew he would do his job." The win was especially gratifying for Busch's crew chief, Randall Burnett, who not only produced a car fast enough to win the pole in his hometown but also made all the right calls on Sunday. Burnett hails from nearby Fenton, Missouri, and had plenty of friends and family in a sellout crowd of about 60,000 on a brutally hot late spring day.

"It means a lot to me coming home,"

Hamlin finished second while Joey Logano, the winner a year ago in the Cup Series debut at the track, got around Larson on the final lap for third. Martin Truex Jr. rounded out the top five ahead of Ryan Blaney, last week's winner at Charlotte.

"Long day for sure," Logano said after climbing out of his car. "There were four or five cars that were just better than us. We made some good adjustments at the end and we were in the hunt." It was a long day for Corey LaJoie, who filled in for Chase Elliott in the No. 9 car for Hendrick Motorsports and spent most of the day near the back before finishing 21st. Elliott was suspended for the race for intentionally wrecking Hamlin last week.

It also was a long day for everyone on pit stands. There were some technical issues that not only prevented them from having communication with teams back at their shops, but also limited the amount of data that they were

León 'claim' maiden **Champs League title**

LOS ANGELES, June 5, (AP): Lucas Di Yorio scored in the first half, and Club León secured its first CON-CACAF Champions League title with a 1-0 victory over Los Angeles FC on Sunday night.

León won the first leg of the fi-nal 2-1 in Mexico on Wednesday night, and the Liga MX club thrilled its thousands of traveling supporters with another winning effort at LAFC's daunting BMO Stadium, highlighted by Di Yorio's goal in the 20th minute.

León finished sixth in the Liga MX standings last month, but took out the defending Major League Soccer champions with superior play in both legs. León is the ninth Mexican club to win the Champions League in its current format, which began in 2002.

SOCCER

LAFC won both the Supporters' Shield and the MLS Cup last fall, but fell short of an unprecedented treble for an MLS club. A year ago, the Seattle Sounders became MLS's first Champions League winner in the current format, making another argument for the leagues' increasing equality.

But LAFC lost the Champions League final for the second time in four seasons. The club also lost the 2020 final to Tigres after knocking off León with a second-leg comeback victory earlier in that competition.

With a hunger to gain international recognition for their remarkable success in just six seasons of existence, LAFC's coaches and executives had described this final as the most important match in team history, although most acknowledged the MLS titles mean more to fans.

The Heat didn't care. They outscored Denver 17-5 in the first 3:17 of the fourth to take the lead for good, eventually went up by 12, then frittered most of it away and had to survive a 3-point try by Jamal Murray as time expired.

"This is the finals," Adebayo said. "We gutted one out."
