## Oh leadership: Read Haroun Al-Rashid's letter to Nicephorus

WHEN there is determination to make a decision, all obstacles will fade away if the leader is aware of the capabilities of his country and his people, and if he is able to accept risks - internal or external and transform them into opportunities to impose the prestige of the state.

A testimony to this is the fifth Abbasid Caliph Haroun Al-Rashid, who faced the most powerful international powers in the ninth century AD at that time, which was the Roman Empire.

Al-Rashid turned its threats to the Muslim State into opportunities to defeat it, and prevent the repeated attacks and occupation of some areas adjacent to the borders, and its expansion to the shores of the Mediterranean that day.

In the year 782, a truce was concluded with the Roman Queen Irene for payment of an annual tribute to the Abbasids. She continued to pay the tribute until her

When Nicephorus succeeded her in the year 802, he sent a letter to Haroun Al-Rashid, asking him to return the tribute paid by the former queen. He wrote, "From Nicephorus I, the King of the Romans, to Haroun, the King of the Arabs.

The weak and faint-hearted Irene had submitted to pay you tribute. She ought to have made you pay tribute to her. Return to me all that she paid you, otherwise the matter would have to be settled by the sword."

When Haroun read the letter, he became furious. He then sent his famous message immortalized in history. Behind Nicephorus' letter, he wrote, "From Haroun Al-Rashid, the Commander of the Faithful, to Nicephorus, the Roman dog, I have read your letter. You shall not hear, but you shall SEE my reply."

In the year 803, Al-Rashid headed his army to Heraclea, a city on the shores of the Black Sea, where the battle of Krasos took place. In this battle, Nicephorus was defeated, and he was forced to pay tribute just as his predecessor did.

One year later, the Byzantine emperor once again thought of refraining from paying tribute to the Abbasid caliph. Al-Rashid returned and waged a new war with the Byzantines, in which 40,000 of their soldiers were killed. They were forced to pay 30,000 gold coins annually, and set free all of the Muslim prisoners who had fallen under the grip of Byzan-

This would not have happened if Al-Rashid had followed the advice of the state advisors, especially since the internal situation in the Caliphate was not conducive to that confrontation, in their perception. However, the leader's faith in his people and the ability of his army prompted him to take such a decision.

In this regard, Al-Rashid's message was not only directed at the Romans, but indirectly at the Muslims as well. That level of firmness in confronting the enemies requires a unified effort, especially with the security and political unrest in

# **Tunisia push for 'aid'** to cap migration flow

TUNIS June 11 (AP): Tunisia's in a week to Tunisia Italy is the increasingly autocratic president hosted the leaders of Italy, the Netherlands and the European Union on Sunday for talks aimed at smoothing the way for an international bailout and restoring stability to a country that has become a major source of migration to Europe.

On the eve of the talks, Tunisian President Kais Saied made an unannounced visit to a migrant camp in the coastal city of Sfax, a central jumping-off point for boat journeys crossing the Mediterranean to Italy. Saied spoke with families living in the camp, and pleaded for international aid for Africans who converge on Tunisia as a transit point

to reach Europe. His caring words, and sympathetic images posted on the president's Facebook page, contrasted sharply with Saied's stance earlier this year, when he stoked racist abuse of Black African migrants in Tunisia with a speech railing against a perceived plot to erase his country's Arab identity.

Support from Tunisia's president is crucial to any European deal to curb migration. Tunisian Prime Minister Najla Bouden met Sunday with Italian Premier Giorgia Meloni, Dutch Prime Minister Mark Rutte and European Commission President Ursula von der Leyen, according to images released by Meloni's office.

Stemming migration is a top priority for the far-right Meloni,

destination for most Europebound migrants leaving from the North African nation, whose economy is teetering toward col-

Saied has balked at conditions for \$1.9 billion in stalled International Monetary Fund support, which include cuts to subsidies on flour and fuel, cuts to the large public administration sector, and the privatization of loss-making public companies.

The president warns such moves would unleash social unrest, and bristles at what he calls Western diktats. The population is already restive, and disillusioned with both Saied's leadership and the country's decadelong experiment with democracy.

That has pushed more and more Tunisians to risk dangerous boat journeys across the Mediterranean to seek a better life in Europe. Tunisia is also a major transit point for others seeking to migrate: sub-Saharan Africans make up the majority of those who leave from Tunisia's shores.

"Tunisia is a priority, because destabilization in Tunisia would have serious repercussions on the stability of all Northern Africa, and those repercussions inevitably arrive here," Meloni said Thursday.

The European leaders brought a packet of initiatives to improve security in Tunisia, easing the way for the International Monetary Fund's help, Meloni said

## RIYADH, June 11, (KUNA):

Riyadh touts strategic role for China

Saudi Investment Minister Eng. Khaled Al-Faleh on Sunday announced the launch of a new modern Silk Road connecting the Arab world and China.

Al-Faleh, while speaking at the Arab-China Business Conference held in Riyadh, stated that it is time for China to become an essential strategic partner to development in the region.

The Saudi Minister spoke of the growth in trade exchange with China saying it creates promising opportunities for investments.

On behalf of Crown Prince Mohammad bin Salman, Saudi Foreign Minister Faisal bin Farhan had inaugurated the 10th edition of the conference earlier today, held under the slogan "Cooperation for Prosperity"

In his inaugural speech, bin Farhan mentioned China's role as the region's largest economic partner with bilateral trade exchange having reached USD 430 billion in the year 2022.

Saudi Minister of Foreign Affairs Prince Faisal bin Farhan said on Sunday that China is the Arab world's top trade partner with USD 430 billion.

The minister made the remark while addressing the 10th edition of the Arab-China Business Conference, which kicked off in Riyadh earlier in the day.

He underlined the joint willingness of Arab countries and China to develop their partnership and cooperation, based on the outcomes of the forum since it was created.

The Saudi minister added that the gathering's theme: "Cooperation for Prosperity" reflected the paramount significance, great potential and joint visions regarding Arab-Sino investment and trade relations.

He commended the conference as an opportunity to promote shared consensus, share expertise and realize growth that could contribute to achieving the prosperity, development and welfare of the people of the region and the world.

# **Taleban slam talk of split**

ISLAMABAD, June 11, (AP): The Taleban condemned on Sunday a 'baseless and biased" report from the U.N. Security Council highlighting rifts within the group's ranks.

The last seven months have seen a greater shift of power from the capital Kabul to the southern city of Kandahar, a Taleban heartland and the base of the group's supreme leader Hibatullah Akhundzada.

A report - issued earlier in June - by the U.N. Security Council's Analytical Support and Sanctions Monitoring Team said that the Taliban governance structures remain "highly exclusionary, Pashtun-centred and repressive" toward all forms of opposition.

It also said Kandahar's return as the seat of power - like it was during the Taleban's rule of Afghanistan in the 1990s - circumvents senior Taleban ministers in Kabul, the center of the current government, because of the way decisions are made.

Key figures, such as the Taleban's main spokesman, have set up offices in the south of Kandahar. Monumental decrees such as those excluding women and girls from education and work were issued from the city instead of Kabul.

The report also said the group was battling internal conflict over key policies, the centralization of power and the control of financial and natural resources in Afghanistan. Ongoing power struggles are further destabilizing the situation, to the point where an outbreak of armed conflict between rival factions is a manifest risk, the report

The Taleban's main spokesman Zabihullah Mujahid rejected the report's "accusations" of strife, saying they were baseless and demonstrated "obvious hostility" to Afghans.

# **Kurds to try IS 'expats'**

QAMISHLI, Syria, June 11, (AP): The Kurdish-led authority in northeast Syria announced Saturday that hundreds of fighters with the Islamic State group held in prisons around the region will be put on trial after their home countries refused to repatriate them.

The statement by the Autonomous Administration of North and East Syria said it still calls for the creation of an international tribunal to put those fighters on trial. It called on the United Nations, international rights groups and local organizations to help facilitate the trials.

The U.S.-backed and Kurdish-led Syrian Democratic Forces, or SDF, is holding over 10,000 captured IS fighters in around two dozen detention facilities - including 2,000 foreigners whose home countries have refused to repatriate them. The statement said the fighters from about 60 nationalities had entered Syria years ago and were captured in battles against the extremists.

'The terrorist organization carried out horrific crimes and mass massacres against people in the region," it said, adding that such acts are considered crimes against humanity and war crimes. It said the trials will be "fair and transparent in accordance with international and local laws related to terrorism."

The SDF and the local Kurdish police force known as Asavesh also oversee some 51,000 family members of IS fighters, mostly women and children in the al-Hol camp. Many of those family members remain die-hard IS supporters, and killings by militants have taken place in the camp over the years.

Saturday's announcement came two days after U.S. Secretary of State Antony Blinken co-hosted a meeting in Saudi Arabia of foreign ministers from the global coalition battling IS during which he announced nearly \$150 million in new U.S. funding for stabilization efforts in Syria and Iraq. The extremist group no longer controls any territory, but its affiliates still carry out attacks across Africa, Asia and the Middle East.

The Global Coalition to Defeat ISIS, as IS is also known, includes more than 80 countries to coordinate action against the extremists, who at their height controlled large parts of Syria and Iraq. Blinken said the U.S. pledge is part of new funding amounting to more than \$600 million.

Blinken did not specify, but U.S. aid to Syria is expected to flow through Kurdish allies, the United Nations or international aid groups, as the U.S. and other Western countries maintain sanctions on Syrian President Bashar Assad's government.

The Kurdish-led authority did not say where exactly the trials will be held or when they will start. They are believed to take place in areas controlled by the SDF in northeast and eastern Syria. The U.S. military has a presence in the region controlled by SDF fighters.

On any given day there are at least 900 U.S. forces in Syria, along with an undisclosed number of contractors.

U.S. forces advise and assist the SDF, including in securing the detention facilities, and they also conduct counterterror missions against IS.

Elsewhere, Islamic State group militants attacked an Iraqi army position in the northern governorate of Kirkuk, killing two military officers and wounding three soldiers, Iraq's security media office said in a statement Sunday.

The Iraqi Security Media Cell said militants belonging to the extremist group late Saturday targeted the military position in the district of Dibis with light and medium weapons but did not provide further details.

# 'Kuwait keen to empower women socially, economically'

KUWAIT CITY, June 11: In a speech delivered during the second regular session of the Ministerial Council of the Women's Development Orga-

nization, which is being held in Cairo, Acting Undersecretary of the Ministry of Social Affairs Abdulaziz Al-Mutairi, who is heading the Kuwaiti delegation participating in the session, affirmed the keenness of the State of Kuwait to empower and develop women in all fields. He said this keenness comes from the belief in the importance of the role of women and their position in society, reports Al-Qabas daily.

He expressed his happiness to participate in the session, which aims to discuss efforts to advance the status of women in various fields.

Al-Mutairi highlighted the country's legislative endeavor to bridge the gender gap in line with article 29 of the Kuwaiti Constitution, and the fifth goal of the Sustainable Development Goals 2030, which guarantees Kuwaiti women an equal status with men.

He pointed out the modernization of legislation to combat violence and discrimination, and the development of family services and counseling.

On Thursday last week, Acting Undersecretary of the Ministry of Social Affairs Abdulaziz Al-Mutairi affirmed Kuwait's keenness to empower and develop women in all fields, especially in the social and economic

He said, "Kuwait has made all efforts to address violence and protect women's rights in accordance with law No. 63/2015 for combating information technology crimes, which protects both women and men from electronic blackmail.

In line with the state's policy, the Ministry of Social Affairs has implemented many measures that seek to enhance the status of women and empower them socially and economically.'

In this context, Al-Mutairi reviewed the most prominent procedures, highlighting the ministry's role in alleviating the suffering of women who are going through financial conditions that cause them to experience below minimum standard of living and protecting them socially by disbursing financial aid in order to improve their financial situation and meet their basic needs.

He revealed that this income "is spent on a temporary basis to end the circumstances that caused the request for assistance.'

Al-Mutairi said, "The ministry was not satisfied with just providing aid to women, but rather sought to support and train them to turn them into an effective and self-reliant element. This was done by enrolling them in training courses that were provided for free through a project known as "Earning with my hands", then incubating and supporting projects of this category through the "Boutique 33" business incubator to enable them economically and support their entry into the labor market.

The ministry has established many social shelters that serve and care for women who do not have a family, such as children of family custody, juveniles and the elderly, by providing psychological, social and health

Al-Mutairi affirmed the ministry's interest in establishing community development centers in various governorates of the country, through which social services and family counseling are provided to women of all categories, adding, "This contributed to the development and education of the female component."

He highlighted Kuwait's full readiness to extend a hand of cooperation in everything that contributes to the development and empowerment of women in every field.

# Ice making machine and DDT

Life in Kuwait, at the beginning of the fifties, was simple, even for the well-to-do, there was no cold water, no air conditioners, no refrigerators, and few had ceiling

fans, and there was a factory to make ice slabs, the only source of cooling.

drink-The ing water came to us from the Shatt al-Arab in wooden boats, and we got some of the other from



the two hearts, or the wells. The effects and blessings of oil revenues had not yet appeared, and its harbingers came with the start of the government buying homes and properties of citizens within the borders of the capital, and subsequently in other villages and suburbs, such

as Jahra, Fahaheel and others. Seventy or eighty years ago, the government's interest in education and many other things was distinguished and modern, and much better than it is now, whether in terms of teachers, curricula, or administra-

As students, we felt that concern. and the desire of officials to change our overall conditions for the better, in terms of education, food and health, by taking care of the quality of food that was served to us, the quality and style of what we wore in school, our behavior and hygiene, and even the style and quality of our

As for now, attention is almost focused on prolonging holidays, stuffing the curricula with sick backward ideas, and recruiting an army of teachers, imbued with political and religious ideas, so that the teaching profession has become, among creative people, repulsive.

The summer months were harsh with all their heat. Then, we did not really miss air conditioners, and the reason was that we did not even know they existed, and man by nature does not demand something that he does not know of, but as soon as it entered our lives, it became very difficult to live without it.

Ceiling or table fans were few, and yet they did a good job, and then they gradually disappeared from our lives completely, with the advent of the modern cooling system.

In order to reduce the temperature in the markets and neighborhoods, the government resorted to spraying it with water from the municipal tanks that roamed the markets and neighborhoods, and we saw the vapor of the sprayed water rising from the dusty ground, and we were having fun running behind those tanks while they were spraying their wa-

ter, and we were very excited. In order to get rid of the large amount of flies that were breeding strangely during the summer, the Ministry of Health, or perhaps the municipality, sprayed the markets with DDT to get rid of flies and mosquitoes, with the help of vehicles equipped with a tank of DDT and a generator that converted the liquid into a thick white vapor, shot through a cannon-like nozzle for a

distance of ten meters or more. As children, we were running after those vehicles, and the happy one was the one who succeeded in reaching the throat of the crater and completely disappearing into the white cloud that was behind it. This irritated the others and prompted them to run faster, and as we ran faster it increased our heartbeats, and increased our need for oxygen.

Almost two decades later, the United States banned the use of this substance due to its harmful effects, and we later learned that it is composed of toxic substances used to exterminate insects, and I do not know how our small lungs resisted the harmful health effects of inhaling this substance in such relatively large quantities?

**KUWAIT CITY, June 11: The Ministry of** the Interior announced the cancellation of 66.854 valid driving licenses for expatriates whose work permits have been permanently canceled, reports Al-Rai daily.

In the first decisions that come based on the recommendations of the committee which was formed to examine the authenticity of the driving licenses that had already been issued ensures that they comply with the ministerial decisions, indicating that other ministerial decisions will be issued later within the same frame-

The ministry stated that the committee is still continuing its work in examining the driving licenses that have already been issued and ensuring that they meet with the ministerial conditions, and added the ministerial decisions will be issued as soon as the committee issues its recommendations.

The First Deputy Prime Minister, Minister of Interior and Acting Minister of Defense Sheikh Talal Al-Khaled has issued Ministerial Resolution No. 277/2023 regarding the formation of a committee to examine the issue of driving licenses and ensure their compliance with the conditions stipulated in Ministerial Resolution No. 270 of 2020 regarding amending some provisions of Ministerial Resolution No. 81/1976 regulations of the traffic law.

The initial recommendations of the committee that has been formed in this regard came after the committee concluded that there are 66,584 valid licenses for workers whose residency has been canceled as a result of death or they having left the country, and accordingly all those valid licenses have been canceled through the regulations.

When the expatriate returns to Kuwait again, he starts from scratch the procedures for obtaining a new license if he/she fulfills the conditions for entitlement to a driving license but they will not be allowed to renew the license based on the fact that they were issued the license earlier by the

Whistle-blowers protected: A legal assistant working in the Department of Corruption Examination and Money Recovery of the Public Authority for Anti-Corruption "Nazaha" Fatima Abdulaziz Blam revealed that the authority "currently protects 16 people in various corruption cases, pursuant to the provisions of Law No. 2 of 2016 regarding the establishment of the authority and the provisions for fi-

nancial disclosure, reports Al-Rai daily. In a statement to the daily, Blam stated that "the law establishing the authority and its executive regulations has put in place the rules and provisions for the protection of whistleblowers and witnesses to encourage their exercise of the national duty to report and combat corruption crimes, while ensuring that they are not subjected to personal, administra-

tive or legal harassment. She stressed, "The authority follows a specific procedural mechanism to protect the whistleblowers and witnesses, starting with personal protection by keeping the identity of the whistleblower secret including those in his jurisdiction and not revealing his whereabouts from the moment he pro-

vides informtion to the competent authorities. She stressed, "The authority is keen to provide administrative and functional protection by preventing any administrative action from being taken against the whistleblower by his employer, ensuring salary and benefits remain untouched during the period specified by the authority when it is proven to be connected to his role in reporting and combating cor-

She noted at the same time that "the authority provides legal protection to the whistleblower and those in his position by preventing criminal, civil or disciplinary recourse



Hope for family visit visas: The First Deputy Prime Minister, Minister of Interior and Acting Minister of Defense Sheikh Talal Al-Khaled issued a decision to add a new clause to article 4 of ministerial resolution No. 957/2019, which stipulated the introduction of a new type of entry visa to Kuwait, which is an entry visa to practice sports, cultural or social activities. Informed sources indicated that this signals a move to re-allow family entry visa applications after a hiatus that lasted several months, reports Al-Rai daily.

They explained that the move to open the door for family visas comes after completing a number of procedures related to the mechanism for issuing visas, and the conditions required for those who apply for them in terms of salary and job. It will be limited to first-degree relatives only.

Regarding the entry visa for sports, cultural or social activities, the sources explained that the visa will be issued by the Directorate General of Residence Affairs based on a request submitted by a one of the sports clubs or accredited cultural and social institutions, bodies and associations in the country, in accordance with the controls set by the Directorate General of Residence Affairs.

According to the decision, the visa allows its holder to temporarily reside in the country for a period of three months. It may be renewed for a period not exceeding one year from the date of entry, in accordance with the provision of article 11 of Amiri decree No. 17/1959.

The sources praised the move to grant visas for sports, cultural or social activities for a period of three months, and to allow their extension in accordance with regulations and procedures for a period not exceeding one year, affirming that this step will contribute to facilitating various related activities, as well as allowing the openness required to stimulate the economic and commercial movement in the country.

They said the Ministry of Interior is currently working on setting up a special mechanism to receive visa applications by taking online appointments to visit the residence affairs departments according to the procedures.

## Cancel summer vacation, vital bills await ratification, says MP

Hani Shams has recommended canceling the parliamentary summer vacation, as the citizens have waited so long for the ratification of important bills and they willingly went to the polling stations in spite of the hot weather.

He said the most important bills submitted to the 2022 Parliament are ready for voting, especially since most of the members of the nullified Parliament retained their seats; hence, the required majority is available. He added that ratifying the urgent bills will determine the extent of the government's cooperation with the legislature.

MP-elect Majed Al-Mutairi called on Minister of Finance and Minister of State for Economic and Investment Affairs Manaf Al- Hajri and the Central Bank of Kuwait governor to reduce the interest on deposits. He pointed out that his request is aimed at reducing the extra deposits in banks and encourage individuals to put their money in investments. He believes the interest reduction will help defaulters pay their loans.

MP-elect Muhammad Al-Mutair disclosed that his top priority is to amend the Constitutional Court Law in order to foil attempts to nullify the Parliament.

MP-elect Fayez Al-Jomhour asked the Civil Service Commission (CSC) chairman to form a committee to investigate the exams of applicants to legal

jobs. He said rumor has it that the exams were made to match the laws of Jordan, not Kuwait.

MP-elect Muhammad Hayef Al-Mutairi invited his colleagues to a meeting

in his diwaniya on Monday to discuss the priorities stated in the so-called 'Nation's Agenda Document'. These priorities include the political reform bills; such as the amendment of the National Assembly Law, Election Law

and establishment of the Higher Commission for Elections. The priority economic bills include the establishment of the North Economic Zone, cancellation of exclusive local agencies, and reforming small and medium enterprises (SMEs). The freedom related bills include the amendment of the Remand Law, disqualification of candidates and amendment of the Publishing and Printing Law. Other priorities are amendment of the Civil Service Commission and Constitutional Court laws, restructuring the salary scale, amendment of the Private Sector Law, and allowing citizens to work in both the public and private sectors.

The document also stressed the need to address the housing issue by combating the monopoly of plots and establishment of a shareholding company for the construction of residential cities.

# **MoH issues guidelines for pilgrims**

KUWAIT CITY, June 11, (KUNA): The Kuwaiti Ministry of Health issued Saturday guidelines for pilgrims of the upcoming Hajj

season (1444 ÅH-2023 AD). In its guidelines, the ministry said that pilgrims must be fully vaccinated against COVID-19, meningitis, bacterial pneumonia and seasonal influenza at least 10 days before heading for Hajj and urged pilgrims to carry their vaccination certificates during

It called on pilgrims, who suffer from chronic diseases such as diabetes, heart disease, etc, to consult their doctors before traveling and take with them a sufficient amount of their medicines and detailed and up-to-date reports of their health condition including information about their health problems, medicines and their prescribed doses.

It advised pilgrims to don face masks, use tissues when coughing or sneezing, wash their hands with soap, water, and disinfectants during their spiritual journey to prevent respiratory infection. Pilgrims are also asked to avoid touch-

ing their eyes, mouths, or noses with their hands, and avoid direct contact with those who show symptoms of illness.

The ministry encouraged pilgrims to drink large quantities of water, liquids, and juices and to eat water-rich foods such as fruits and vegetables in order to avoid dehydration as well as avoid direct exposure to the sun, heat, and crowding. It called on the pilgrims to adhere to the

precautionary measures and instructions issued by the relevant Saudi authorities to preserve their health and safety.

## 'Setting up health system focusing on 'patients safety' vital to avoid errors'

"YES, this is a global fact, and it is found in the best health systems, and no one with scientific knowledge can deny it. Health institutions differentiate between them in the way they deal with medical errors, and not by denying them and practicing lack of transparency," columnist **Dr Hish-am Kalender** wrote for **Al-Jarida** daily.

"I am here not calling for avoiding health institutions, but rather I am their first supporter and a warrior for those who encroach on it, but I aim to develop the health system.

"According to one scientific study, nearly 444,000 people die every year due to errors that occur in hospitals that can be avoided by establishing a health system that focuses on patient safety.

"Patient safety activities include avoiding errors and reducing the possibility of making them through planning that enhances communication and reduces injury rates, reduces

errors, and if they occur, there are mechanisms in place to limit the damage that may result.

"I will mention principles and tips that, if implemented by health organizations, will contribute to achieving this goal: First, a safety management system must be established. Caregivers should formulate guidelines that define the performance of the occupational safety and health management

"To encourage compliance with safety protocols, it is important that this system includes officials and all managers and employees in appropriate decision-making processes and regular reviews of institutional performance.

"It is also important to build a rapid response system through strategies, tools and rapid response teams that aim to enhance the performance and patient safety.

"A culture of safety must be disseminated by ensuring that employees and employers know and understand their roles in organizational safety, as well as training every new employee on safety policies.

"Moreover, every medical organization must clearly define safety policies and procedures and develop a plan to ensure compliance with them.

"Hospital officials must also constantly monitor and evaluate how employees follow established

"Maintaining and developing a safety compliance plan contributes to organizations promoting safe treatment environments. In addition, the practice of patient-centered care, and all health care facilities must be centered and focused on the patient because this helps to enhance the quality and safety of health services.

"Empowering patients and educating them in their recovery plans is important for them to receive safer treatment.

"Caregivers must be empowered to be able to ask the right questions and notice potential prob-

'Today's health practitioners must realize that educated patients can help reduce medical errors. Last but not least, safety policies must be integrated into hospital design, as in the past, traditional hospital design focused on operational efficiency rather than patient safety.

"Therefore, it is time to pay attention to patient safety and make it a priority, and this requires planning, commitment, and work to maintain a safe hospital environment transforming local hospitals into hospitals that are friendly to the principles of patient safety through the implementation of safety programs and standards.'

#### Also:

"At the outset, I congratulate the Kuwaiti people on their democratic wedding, and I ask God Almighty to make the people of Kuwait harness it and make decisions that will prosper in this good country. "On this occasion, I would like to share with you the sound educational approach that instills the important basics that raise children to know how to make decisions," columnist Nada Mudhaf wrote for Al-Qabas daily.

"To raise your son and teach him the skill of making the right decisions, you can follow these

- Enhancing self-confidence: Help your son build his self-confidence and respect his personal abilities. Encourage him to try new things and achieve small successes, which will boost his confidence in his ability to make decisions.
- Providing incentives and information: Provide your son with the information and knowledge necessary to make the right decisions. Help him understand the potential consequences of each choice and evaluate situations accordingly. Offer him incentives and rewards when he makes the right decision.
- Teaching critical thinking: Teach your son critical thinking skills and evaluate things from different angles. Ask open-ended questions that motivate him to think logically and analyze the options available.
- Encouraging participation in decision-making: Encourage your son to participate in making decisions related to his daily life. Give him a chance to choose between specific options and take respon-

sibility for the results.

• Accept mistakes and negative experiences: You must have an understanding to accept mistakes and negative experiences, as part of the learning and decision-making process. Help your son analyze mistakes and draw lessons from them, rather than criticize or get emotional.

• Providing support and guidance: Be supportive of your son and provide him with guidance when he encounters difficulties in making decisions.'



"In deliberation, there is safety. In haste, there is remorse. Whoever deliberates gets what he wished for. It is customary that judgments are made only after a thorough study, research and deliberation. It is not possible for anyone to make a judgment that is not based on reality and evidence, so we must slow down and deliberate on issues, columnist Misha'al Al-Saeid wrote for Al-Anba daily.

"Some time ago, Minister of Education and Higher Education Dr Hamad Al-Adwani issued a decision to stop the medical field scholarships in Egypt and Jordan. This is within the framework of the Ministry of Higher Education's endeavor to control the quality and advancement of education and ensure the validity and safety of certificates. This decision is in the interest of education and we have waited for it for so long.

"Like any other important decision, it drew mixed reactions from politicians, academicians and Twitter users. They objected to this decision, asserting this is the right of everyone and it is subject to discussion. Nevertheless, important questions are raised: Does anyone imagine that such a decision was issued without study, research and scrutiny? Does the minister of education not have the justifications and reasons for issuing this deci-

"Commenting on the criticism of this decision, newly elected MP Hamad Al-Olayan said: 'As a specialist in the education file and after examining and researching, not rushing, and searching for the full truth and the public interest, I see that the decision is in the interest of the quality education.'

"This is a successful beginning for this young representative. We appeal to him, as every person has the right to object to any decision, that he must take note of all aspects of the decision.

'The truth is that the former minister, Adel Al-Subaih, pointed out this matter in more than one statement. He said these testimonies are not reliable and the people of Makkah know better about its paths, so I hope that we do not predict events and quickly make judgments."



"Congratulations to the newly elected members of the National Assembly. We congratulate them for their victory in the 'Nation 23' election. We hope they will extend a hand of cooperation to the next government and avoid aggravation for years,' columnist Yousif Hajji wrote for Annahar daily.

"We call on the nation's representatives to cooperate with each other first and to put their personal differences outside the dome of Abdullah Al-Salem. They should coordinate their efforts in the election of committees, where they will select members whose specializations and expertise are related to the tasks of committees. They must coordinate among themselves first and then extend a hand of cooperation to the next government.

"I also wish that the representatives will not raise the ceiling of populist demands. They should demand for what can be achieved and accomplished by the government. # New network seized

Mol gets tough on exam cheats

KUWAIT CITY, June 11: After an exclusive revelation about monitoring the activities of the "cheating groups", which were on standby after increasing the "subscription" fees to obtain questions, as well as the answers, for the 12th grade exams that started today on Sunday, the Ministry of Interior managed to arrest another network of three people accused of promoting the leaking of exams, reports Aljarida daily.

In a press statement issued recently, the Ministry of Interior explained that the criminal investigations officers were able to seize the network after following up what it published on social media in terms of advertising and promoting the creation of groups on WhatsApp through which the exam papers are published.

The culprits were divided into two groups, each of which receives sums of money from the participating students. Accordingly they were arrested. When confronted with the results of the investigations, they admitted to what was attributed to them. They were referred to the concerned authorities where necessary measures will be taken.

#### **Culprits**

According to informed sources, the three culprits two Bedoun residents and one Saudi national - charge each student KD 50 in exchange for providing them with answers to the exams via WhatsApp. The names of the 250 students were obtained from the group, and will be referred for investigations to reveal the circumstances of the leak, especially since the detectives found bank transfers via links to the culprits. The detectives also obtained details from the culprits about how the exams were leaked.

The sources revealed the existence of a secret group that includes teachers, supervisors and mentors in the Ministry of Education, and deals with caution with certain people to facilitate leakage of exam papers, including exam papers for the 12th graders, as well as for the ninth, tenth and eleventh graders.

They explained that the culprits admitted during the investigations that they had "another offer" related to

providing students with a hearing device, the price of which ranges between KD 30 and KD 100. Through this device, he is fed with the answers. This constitutes an alternative option for students in the event that their phones are seized or prevented from entering the examination hall. Exam questions are solved by private teachers who photograph them and send them to the 'group".

The defendants also admitted that they had worked in "cheating groups" two years ago, but they were the "callers", adding that they developed their work, became independent, and established their own "group".

#### Affirmed

Meanwhile, educational sources affirmed that instructions were issued by the Minister of Education the level of coordination with the Ministry of Interior regarding "cheating groups", especially since these groups have begun to adopt precautionary measures to avoid being caught.

They are now setting the seating of the students who wish to be part of these groups due to their fear of the presence of "ambushes" whereby security forces impersonate students to apprehend the culprits.

These groups had information from the Ministry of Education about the students' names and their seating numbers, and resorted to cooperating with teachers, whose services were terminated and left the country, to solve the questions and send answers to the participating students.

The Ministry of Education expressed appreciation for the efforts of the Ministry of Interior, which resulted in seizing the network that promoted and facilitated the leaking of high school exam papers.

It affirmed that this new blow to the leakage and cheating gangs is the result of cooperation between the two ministries to eliminate the negative phenomena that accompany the exams. On Friday, the official spokesman of the Ministry

of Education Ahmed Al-Wahida stated that seizing the network confirms the seriousness of the various state agencies and their cooperation to eradicate the phenomenon, and access to fair tests that give every student his right to achieve its objectives, in coordination and cooperation with the Ministry of Interior and relevant state institutions. Al-Wahida affirmed that the Ministry of Education will spare no effort to prevent any matter that may affect the conduct of the exams and their proper organization.

# **Conditions set for Kuwaiti doctors** to work in private medical facility

'Days and times should not conflict with duties of his govt job'

KUWAIT CITY, June 11: The Minister of Health,

Dr. Ahmed Al-Awadi, has issued a list of requirements which allow Kuwaiti medical specialist practitioners working in the government medical sector to work in their private clinics or private health facility outside official working hours, reports Al-Rai daily.

According to the Ministry of Health the Kuwaiti doctor should have the title of a specialist or above, and should not occupy any supervisory position or work as head of any department and not combine his government job with work outside official working hours.

The decision allows the authorized physician to work outside the official working hours on days and times that do not conflict with the duties of his government job and the duties he is assigned to. It also allows him to work in hospitals, medical centers, private clinics, laboratories or any other health facility in the private medical sector.

The decision also allows the Kuwaiti doctor to combine work in his private clinic and one of the other private health facilities, or combine work outside official working hours in more than one private health facility.

Meanwhile, the Al-Jarida daily said the Minister of Health, Dr. Ahmed Al-Awadi has issued a decision to approve the amended general requirements

for licenses public and private sector medical professionals.

The Ministerial Resolution No. 220 of 2023 states that the applications for issuing, renewing, transferring and canceling a license to practice the profession in the government and private sectors, must be accompanied by the required documents, and should be submitted to the Health Licensing Department, and added the license renewal application must be submitted at least sixty days before the expiry of its period, failure to do so the applicant will have to pay twice the original fee stipulated in the ministerial decision regulating licensing fees for each application submitted thereafter.

The decision states that it is not permissible to grant or renew a license to practice medicine, dentistry, and related professions for workers in the

private sector for those over 65 years of age, except after conducting medical examinations determined by the ministry to verify that all the required medical fitness conditions are met.

He pointed out that the duration of licenses to practice the profession in the government sector, which are granted to practitioners of the medical profession and allied professions, is valid until the end of his services in the ministry. pointing out that it is permissible to convert the license issued to doctors to practice medicine in the government sector after the end of their services to the private sector, provided that the prescribed fee is collected for this, and the eligibility body in which the work will be practiced is determined, with the exception of doctors whose services are terminated due to dismissal from service or medical disability.

The decision stated that a visiting doctor may not be authorized to practice the profession in more than one private health facility in a single visit.

## Info minister examines plans to overhaul cultural facilities

KUWAIT CITY, June 11, (KUNA): Information Minister, Minister of State for Youth Affairs and Chairperson of the National Council of Culture, Arts and Letters (NCCAL) Abdulrahman Al-Mutairi has examined various tasks of the council and its buildings that need renovation.

It had been designated to be listed among world's top heritage sites.

the state, and the events that the caliphate witnessed at the time. Getting out of such a situation was possible only by imposing the prestige of the state without provoking strife in it.

Today, with the change of the political scene in a group of countries in the Gulf region and the Arab world, as well as the revolution of media and social communication, the weakness in confronting governments, and harming the symbols and leaders of countries, the local and external conditions are intertwined, and countries are facing risks on two fierce lines - external and internal - as a result of dependence on the advisors and the personal tendencies of the officials who are terrified of losing their interests due to which they opt for opinions that do not commensurate with the interest of the state.

Over the past 100 years, the leaders of some countries in the region have been able to work to fortify them, despite many internal and external threats, due to the national zeal that was raging at that time. In light of the struggle between the superpowers, it was imperative for them to face the dangers with sophistication, firmness and confrontation. For this reason, they were able to build countries, some of which today have become great powers economically, politically and developmentally, including the Kingdom of Saudi

On the other hand, what some leaders consolidated from the pillars of a strong state at that time was wasted by relying on advisors and not addressing local conflicts and sectarian and tribal blocs, until they were almost lost through weakness in confronting transient unrest, and not benefiting from past lessons. There are many examples in this regard.

There is no doubt that the prestige of the state happens only by imposing the decision from a man of decision. Without it, it opens its doors to risks both internally and externally, as is the case in Lebanon, Iraq, Yemen, Libya, and other countries where the leadership has lost the compass in the right direction.

ahead of Sunday's meetings. The European Commission said talks would center on making progress on an EU-Tunisia agreement focused on the economy, energy and migration.

Saied has said that addressing his country's problems requires not only improved security but also "tools to eliminate misery, poverty and deprivation.

The Fitch ratings agency further downgraded Tunisia's default rating from

CCC+ to CCC- on Friday, meaning the country is inching closer to potentially defaulting on its debt. The agency cited the government's failure to pursue the reforms needed to free up the IMF funds.

Tunisia's budget deficit was aggravated by the COVID-19 pandemic and fallout from Russia's war in Ukraine, and the IMF aid was stalled amid political tensions and Saied resistance to the required reforms. Saied disbanded parliament and had the constitution rewritten to give more power to the presidency, and has overseen a crackdown on opposition figures and independent media.

Saied said Tunisia is struggling to cope with migrants from other African countries who settle in Tunisia or transit through, and called for international aid to fight migrant smuggling networks that "consider these immigrants as merchandise thrown into the sea or the sands of the desert."

During his visit to the Sfax camp Saturday, the president described African migrants as "victims of a global system that treats them not as human beings, but as mere numbers, and it is unacceptable for us to play the policeman for other countries. The solution must be collective ... (and) this situation that Tunisia is going through is abnormal, and we must put an end to this inhuman situation."

#### gold prices stable at USD 1,960 per ounce last week

Gold prices stood at USD 1,960 an ounce by the end of last week's trading due to diverging expectations about the decisions of the US Federal Reserve (US Central Bank) as to whether it will raise or keep interest on the US currency.

Most investors and analysts in the gold markets are awaiting the next meeting of the Federal Reserve, which will be held the day after tomorrow, Tuesday, in

which it will decide its future directions regarding monetary policy, as this will directly affect the gold prices to go up or down, the Kuwaiti-based company Dar Al-Sabaek said in a report Sunday.

This upcoming meeting coincides with similar meetings of the European Central Bank and the Bank of Japan, as they are scheduled to take similar decisions about interest rates and any cessation of raising interest rates will be immediately followed by a rise in gold price and vice versa, it added.

Head of Dar Al-Sabaek's strategic planning Adel Al-Fadhli said, according to the report, that investors were cautious in trading last week after the issuance of the International Monetary Fund report, in which it urged major central banks to continue their monetary policy and monitor inflation closely. # US jobless claims reveal biggest increase in two years

The Reserve Bank of Australia and the Bank of Canada surprised the market by raising rates last week signaling that the next phase of global central banks tightening is underway. Investors will turn their focus this week toward meetings by the Federal Reserve, the European Central Bank (ECB) and the Bank of Japan (BoJ) for further clues on the path of global interest rates.

Ahead of these meetings, The US debt ceiling has been extended, and fears about the US banking sector have subsided. While global economic data has softened, inflation remains high which is expected to keep major central banks in a hawkish stance. The Fed is expected to 'skip' a rate hike in June and raise rates by 25 bps in July. Investors will be closely watching the Fed's press conference, updated forecasts and dot plot for clues about the bank's plans for future rate hikes. While the ECB is expected to hike by 25 bps in its meeting, the BoJ is expected to maintain its wait and see stance as wage growth in Japan remains stagnant despite GDP surprising to the upside.

FX markets remained range bound in a quiet week in terms of economic indicators. The Dollar index reached a high of 104.36 at the start of the week but lost its gains amid higher than expected jobless claims to close at 103.553. This week the outcome of the Fed's meeting and the upcoming US CPI data will dictate the Dollar's path going forward. The euro and pound recovered and closed the week at 1.0747 and 1.2569 respectively. The Japanese yen closed at 139.34 after testing the high of 140.45 twice during last week's session.

#### North America

US Jobless Claims Increase More Than Expected Applications for US unemployment benefits jumped last week, reaching the highest level since October 2021. Initial jobless claims rose by 28K to 261K in the week ending June 3 according to the Labor Department report released on Thursday. The increase was the biggest since July 2021 and exceeded market forecasts. Meanwhile continuing claims, which include people who have received unemployment benefits for a week or more and are a good indicator of how hard it is for people to find work after losing their jobs, fell to 1.76 million in the week ended May 27, the lowest level since mid-February. The report highlights that the resilient labor market may be showing signs of cooling as US companies announced more layoffs in the first 5 months of 2023 than in all of 2022.

#### 022. US Services Nearly Stagnates

month, from 51.9 in April. The above-50 level indicates growth in the services industry that accounts for more than two-thirds of the economy. Economists had forecast the non-manufacturing PMI would edge up to 52.2. The services sector benefited largely from consumers shifting away from goods during the height of the coronavirus pandemic. However, following the 500 bps worth of interest rate hikes delivered by the Federal Reserve since March 2022, consumers appear to be focusing more on basic needs. Switching to manufacturing, the ISM reported last week that its PMI was stuck below the 50 threshold for the seventh straight month, representing the longest stretch of contraction since the Great Recession.

BoC Hikes Rate to 22-Year High

The Bank of Canada hiked its overnight rate to a 22-year high of 4.75% after staying on hold since January to reassess the impact of previous hikes. The central bank hiked rates eight times since March 2022, representing the fastest tightening cycle in the bank's history. Shockingly robust consumer spending and a rebound in demand for services illustrates excess demand is more persistent than anticipated, according to a statement by the BoC.

Highlighting an uptick in inflation in April and the fact that three-month measures of core inflation remained high, the central bank said that "concerns have increased

that CPI inflation could get stuck materially above the 2% target." Annual inflation accelerated for the first time in 10 months to 4.4% in April, while first-quarter GDP rose 3.1% versus the 2.3% forecast by the BoC. Money markets are now pricing in a 65% probability of a 25 bps hike at the bank's July meeting.

#### Europe

#### **Swiss Core Inflation Below 2%**

Rates - 11th June, 2023

Swiss National Bank Chairman Thomas Jordan reiterated his commitment to bring down inflation after data revealed annual inflation dipped to 2.2% in May. "Inflation is above our threshold for price stability," Jordan said on Thursday in Switzerland. "We have second-round effects, third-round effects, so inflation is more persistent than we initially thought." Meanwhile, a measure of underlying inflation slowed more than expected to below the central bank's target, providing comfort to officials aiming to ensure consumer prices stay under control. The core gauge, which strips out volatile elements like energy and food, fell to 1.9% in May, down from 2.2% the previous month.

So far, the SNB has lifted borrowing costs by 225 basis points in nine months, and officials have consistently voiced the need for another hike despite the country registering the lowest inflation in the developed world. In contrast, other central banks such as the Fed are reassessing their path as inflation slows globally and economies head to weaker growth. The current Swiss interest rate of 1.5% "is relatively low, and it's not a really good idea to wait and then have higher inflation later," Jordan said. The Swiss franc jumped on the Chairman's comments, ending the week 0.90% higher against the USD.

#### Asia Pacific

#### RBA Defies Expectations, Hikes by 25 bps

Australia's central bank raised interest rates to an 11-year high, while warning that further tightening might be required to ensure that inflation returns to target. Markets had been leaning towards a pause for the June policy meeting, however priced in a sizeable 40% probability of a 25 bps hike. The hawkish message that accompanied the decision sent the Aussie and bond yields spiking as markets moved to overwhelmingly price in a further rate increase next month. Ending its June policy meeting, the central bank hiked the cash rate to 4.1%, saying inflation is still too high and removed a reference that stated, "medium-term inflation expectations remain well anchored," which had been in policy statements since July of 2022. Although the RBA increased interest rates by 400 bps since last May, headline inflation was last seen at 7% in Q1 of 2023. Markets are now pricing in a 67% probability of a 25 bps hike in July.

Australia's Economy Expands 2.3% in Q1

First quarter gross domestic product expanded by 2.3% year-on-year in Australia, slightly below analyst expectations. The figure represented the weakest pace in 1-1.5 years as high prices and rising interest rates exhausted consumer spending. Data from the Australian Bureau of Statistics showed real gross domestic product rose 0.2% in the first quarter, easing from 0.5% in the previous quarter and under forecasts of 0.3%.

# 'Dollarization' of North Korean economy a threat to Kim's rule

Banning use of dollar and yuan could backfire

SEOUL, South Korea, June 11, (AP): Before fleeing North Korea in 2014, Jeon Jae-hyun kept U.S. dollars as a store of value and used Chinese yuan to make everyday purchases at markets, restaurants and other places. He used the domestic currency, the won, only occasionally.

"There were not many places to use the won, and we actually had little faith in our currency," Jeon said during a recent interview in Seoul. "Even the quality of North Korean bills was awful as they often ripped when we put them in our pockets."

North Korea has tolerated the widespread use of more stable foreign currencies like U.S. dollars and Chinese yuan since a bungled revaluation of the won in 2009 triggered runaway inflation and public unrest.

The so-called "dollarization" helped ease inflation and stabilize exchange rates, enabling leader Kim Jong Un to establish a stable hold on power after he inherited that role in late 2011. But the trend poses a potential threat to Kim as it has undermined his government's control over money supply and monetary policies.

The isolation of the pandemic badly hurt the North's economy but still gave Kim a chance to solidify social controls by restricting market activities and limiting influence from capitalist, democratic South Korea. Now, observers say Kim is trying to roll back use of the dollar and yuan to tighten his grip on power as the North grapples with pandemic-related hardships, long-standing U.N. sanctions and tensions with the U.S.

"He has no other choice but to strengthen the command economy as he's been locked in confrontations with the U.S. while maintaining a border shutdown," said Lim Eul-chul, a professor at Kyungnam University's Institute for Far Eastern Studies in Seoul. "The current direc-

## Recession ahead? By this metric, one's already here

NEW YORK, June 11, (AP): The latest round of corporate earnings is leaving Wall Street with a confounding sense

of relief and lingering anxiety.

Companies are in the midst of an "earnings recession," meaning profits have contracted for two straight quarters, starting with a 4.6% drop at the end of 2022.

Profits for S&P 500 companies shrank just over 2% last quarter, compared with forecasts of a 6.7% drop. That brought some relief to Wall Street that the quarter wasn't as bad as it could have been. But, analysts also expect more pain ahead.

Analysts polled by FactSet now expect a 6.4% contraction for profits in

## Problem still lurks, not left behind

# US has a child labor problem – recalling an embarrassing past

At the University of Maryland, Baltimore County's Special Collections, where I am head curator, we've recently completed a major digitization and rehousing project of our collection of over 5,400 photographs made by Lewis Wickes Hine in the early 20th century.

Traveling the country with his camera, Hine captured the often oppressive working conditions of thousands of children - some as young as 3 years old.

As I've worked with this collection over the past two years, the social and political implications of Hine's photographs have been very much on my mind. The patina of these black-and-white photographs suggests a bygone era - an embarrassing past that many Americans might imagine they've left behind.

But with numerous reports of child labor violations, many involving immigrants, occurring in the U.S., along with an uptick in state legislation rolling back the legal working age, it's clear that Hine's work is as relevant today as it was a century ago.

A sociologist by training, Hine began making photographs in 1903 while working as a teacher at the progressive Ethical Culture School in New York City. Between 1903 and 1908, he and

his students photographed migrants at Ellis Island. Hine believed that the future of the U.S. rested in its identity as an immigrant nation - a position that contrasted with escalating xenophobic fears.

Based on this work, the National Child Labor Committee, which advocated for child labor laws, hired Hine to document the living and working conditions of American children.

By the late 19th century, several states had passed laws limiting the

age of child laborers and establishing maximum working hours. But at the turn of the century, the number of working kids soared - between 1890 and 1910, 18% of children ages 10 to 15 were employed.

In his work for the National Child

Labor Committee, Hine journeyed to farms and mills in the industrializing South and the streets and factories of the Northeast. He used a Graflex camera with 5-by-7-inch glass plate negatives and employed flash powder for nighttime and interior shots, hauling upward of 50 pounds of equipment on his slight frame.

To gain entry into factories and other facilities, Hine sometimes disguised himself as a Bible, postcard or insurance salesman. Other times he'd wait outside to catch workers arriving for or departing from their shifts

Along with photographic records, Hine collected his subjects' personal stories, including their ages and ethnicities. He documented their working lives, such as their typical hours and any injuries or ailments they incurred as a result of their labor.

Hine, who considered himself "an investigator with a camera," used this information to create what he termed "photo stories" - combinations of images and text that could be used on posters, in public lectures and in published reports to help the organization advance its mission.

Hine's muckraking photographs exemplify the genre of documentary photography, which relies upon the perceived truthfulness of photography to make a case for social change.

The camera serves as an eyewit-

The camera serves as an eyewitness to a societal ill, a problem that needs a solution. Hine portrayed his subjects in a direct manner, typically frontally and looking straight into the camera, against the backdrop of the very factories, farmland or cities where they worked.

By capturing details of his sitters' bare feet, tattered clothes, soiled faces and hands, and diminutive stature against hulking industrial equipment, Hine made a direct statement about the poor conditions and precarity of these children's lives.

# Five simple ways to 'step up' your business's TikTok game

**D**an Oliver, founder of Dan-O's Seasoning, was slinging his signature blends at trade shows and flea markets around the country when COVID-19 hit, shutting down his primary sales channel and forcing a hard pivot. Oliver turned to TikTok, going all-in on the video-sharing platform, and struck gold.

First, a video of him making crab cakes went viral. Daily sales increased sevenfold. A few months later, his bacon-wrapped jalapenos caught fire (figuratively), catapulting sales again.

Three years, hundreds of videos and millions of views later, Dan-O's Seasoning has expanded from an e-commerce business to a supermarket staple and overall revenue has increased nearly 10,000%.

#### Sponsored

Dan-O's success isn't a one-off case. Thousands of entrepreneurs have seen their businesses take off on the social video platform. After all, with TikTok you're only one viral video away from becoming the next big thing. But you have to play your cards right.

#### 1. Start strong

"The most important part of your video is the first three to five seconds," Oliver says. Jump in, make a splash and get to the point before people start to tune out.

"Start with something that's attractive, like slapping a piece of meat," Oliver says. More than a few of Oliver's TikToks start with him dropping a monster slab of beef or pork onto the cutting board (and yes, he's slapped a brisket or two). "Make it interesting and don't waste people's time.

#### 2. Pitch your business

Video views are literally worth nothing if you don't translate them into dollars. Sprinkle your business's value props into your videos and tell viewers where to go next, whether that's to your website, online storefront or email list.

"Social media followers are great, but you have to strategically move people to your other platforms, whether it be your email list or another high-leverage pipeline," said Elise Darma, a marketing specialist turned influencer who now coaches entrepreneurs on how to grow their social media presence, in an email. 3. Work smarter, not harder

#### "Batch create content if you can," Darma said. "This is the most efficient way to use

What does that look like? Rather than drumming up ideas and shooting videos on the fly, create an editorial calendar that outlines what you're going to post and when. Film and edit multiple videos in one session, rather than one at a time. Then, squeeze as much juice out of each video as possible.

"Repurpose one video as much as you can — across TikTok, Instagram, YouTube Shorts and Pinterest Idea Pins for maximum

#### impact," Darma said. 4. Define your goals

Any good social media strategy should be anchored in specific goals, whether that's views, comments, clicks or some other type of engagement, says Danielle Wiley, founder and chief executive officer of Sway

Group, an influencer marketing agency. "Social media is amazing from a metrics perspective - you can get so much data but that data is meaningless if you don't create goals," Wiley says. "If you don't know what the goal is from the beginning, you won't create the right type of content.

#### 5. Lean in to what works

Posting anything and everything makes sense at the start; you need to throw everything at the wall and see what sticks. But when videos start gaining traction, it pays to follow that thread.

"A big thing I see is that once people see success with one video, they forget to continue their momentum by creating videos similar to the one that took off," Darma said. "You know what style and what topic resonates with your followers, so make more of that. Invest in what works."

For Dan-O's Seasoning, the thread was recipes. TikToks of Oliver making everything from sushi to deep-fried mac and cheese to parmesan potatoes to prime rib rack up hundreds of thousands of views. If one really takes off, like a recent video for pulled pork tacos, views are in the millions.

Videos of Oliver sharing his entrepreneur story or scouting out Dan-O's on store shelves did well, but didn't strike the same chord. So his team made a strategic decision: The official account for Dan-O's Seasoning would only feature recipes.

"It's definitely working. I follow all these other creators, people we're in competition with, and their accounts are kind of stagnant. Ours is not," Oliver says. "We continue to grow, anywhere from 2,000 to 10,000 followers a day.

# Car-dependent Calif seeks to follow New York's 'lead'

SACRAMENTO, Calif., June 11, (AP): Sadaf Zahoor has bucked California's car culture by never owning one, yet she and other residents who rely on public transit worry its bleak financial outlook could soon leave them standing at empty train stations and bus stops.

The agencies running the public transit systems, particularly in San Francisco and Oakland, where Zahoor lives, have been living off billions of dollars in federal aid that will soon expire.

Ridership plummeted by as much as 94% during the COVID-19 pandemic, leaving a gaping budget deficit. Fare box revenues have rebounded a bit, but with more people working from home, some systems haven't returned to even half their previous levels.

The transit agencies have asked Democrats who control California's government to rescue them, much like Democrats in New York recently did with a \$227 billion spending plan. The request is proving to be a much tougher sell in the nation's most populous state, where majestic mountain highways and seas of suburban single-family homes have made it far more automobile-reliant than much of the Northeast.

"If there were any sort of major changes, that would definitely affect my ability to get to work," said Zahoor, 36, who figures she would have to team up with friends to buy a group car because she couldn't afford one on her own.

The California Transit Association says transit agencies will have a collective shortfall of about \$6 billion over the next five years. The state, which relies heavily on taxes paid by wealthy

Bid to save public transit people, is projected to have a \$31.5 billion budget deficit this year amid a struggling stock market

and layoffs in the tech industry. Instead of bailing out public transit agencies, Democratic Gov. Gavin Newsom has proposed slashing \$2 billion from their infrastructure funding to help balance the books.

H.D. Palmer, spokesperson for the California Department of Finance, said Newsom's proposed budget cuts to numerous agencies "were necessary to address the shortfall" but the governor has pledged to restore the money if revenues rebound

Bay Area Rapid Transit has warned if the state doesn't help out, it could force the agency to stop running after 9 p.m. and on weekends, while limiting regular service to just one train per hour.

Activists for transit say scaling back services is

sure to only exacerbate the problem. "It's kind of like the chicken and the egg," said Stephanie Lotshaw, acting executive direc-

tor at TransitCenter, an advocacy group for public transportation systems across the U.S. "If you disinvest in it, then people won't use it. But if you invest in it, arguably more people will use it because it actually becomes a service that's usable." The pandemic was particularly damaging to Bay

Area Rapid Transit because as much as 70% of its revenue came from fares - far higher than most other transit systems, said Janice Li, president of the transit system's board of directors. Los Angeles, the nation's second-largest city, relies less on public transit than San Francisco, although voters have expressed support for it in recent years

At the very least, Li said, California legislators should pass a stopgap measure to keep transit afloat until the 2026 election, when local voters could decide whether to pay more.

"We are not asking for the world, and we are not asking for the world indefinitely, either," Li said.

The White House has said states have flexibility to redirect some of the federal money typically used for road construction and repairs to transit operations, but many drivers call that a non-starter.

"We have the highest gas tax in the nation, and our roads are still in very poor condition," said Jon Coupal, president of the Howard Jarvis Taxpayers Association, a California group opposing tax hikes. "If we're looking at transportation generally, the money is better spent on those systems that people actually use, which in California is roads and highways. Transit officials are making their pitch by ap-

pealing not just to regular riders but also to drivers who could face much more congested traffic if other options are gone. According to Bay Area Rapid Transit, almost twice as many people travel at rush hour under the Bay Bridge by train than

Supporters have turned to creative marketing selling flip flops featuring a picture of BART's service map and even staging a mock funeral for transit last weekend in Oakland. "We're doing our best but not sure what is pos-

sible at this point," said Vinita Goyal, executive director of San Francisco Transit Riders, a nonprofit advocacy group.

Legislative leaders have pledged to reject Newsom's \$2 billion in cuts and make it OK for agencies to use some of that money for operations. State Sen. Scott Wiener, a Democrat who represents San Francisco, said that's still not enough.

"In every community in California, there are people who rely on the bus, and they are not the most powerful people. They tend to be lower income. They tend to be nonwhite. They tend to be disproportionately seniors or students," Wiener said. "Why on Earth we would for a minute contemplate allowing these systems to fall apart is beyond me.'



#### No federal law requires employers to accommodate menopausal symptoms

## Millions of women working during menopause, but US law isn't clear

While she was interviewing Jen-nifer Aniston and Adam Sandler in March 2023, Drew Barrymore suddenly exclaimed: "I'm so hot ... I think I'm having my first hot flash!"

She took off her blazer and fanned herself dramatically.

While most hot flashes aren't televised, the entertainer's experience was far from unique. Barrymore, age 48, is one of approximately 15 million US women from 45 to 60 who work full time and may experience menopausal symptoms

Unlike Barrymore, most women are silent about their menopausal symptoms. Yet their symptoms, even when concealed from employers and coworkers, are a burden on them, their workplaces and on the overall US economy. Lost work productivity due to menopausal symptoms - measured by missed work hours, job losses and early retirement - add up to about \$1.8 billion annually, the Mayo Clinic esti-

The three of us write and teach about employment discrimination and feminism, and two of us have written a book about menstruation. Because of our shared interests, we are currently writing a book about menopause and the law. We've observed that although Gwyneth Paltrow, Oprah Winfrey, Michelle Obama and other celebrities are speaking out about their own menopausal transitions, work accommodations are rare and employers typically don't even acknowledge this stage of life.In the lead-up to menopause, which typically begins between the ages of 45 and 55, levels of reproductive hormones change, and menstrual cycles become irregular and then eventually cease. This transition, called perimenopause, typically lasts for seven years.

#### **Disturbances**

Common symptoms of perimenopause include hot flashes, sleep disturbances, heart palpitations, excessive bleeding and irregular periods. Technically, menopause occurs after women don't have a period for an entire year, and postmenopause is the stage after that. Transgender men and nonbinary people assigned female at birth can experience menopause too.

Employees who experience menopausal symptoms are often reluctant to talk about them at all, let alone tell their bosses. They may feel stigma and shame, and they may worry that it could hurt their chances for a promotion, their co-workers will see them as less capable or that their status at work will be otherwise jeopardized. These concerns are not unfounded.

In a series of studies, researchers asked workers and college students to describe their initial impressions of potential co-workers, including "a menopausal woman." The participants described her as "less confident and less emotionally stable" than the nonmenopausal women.

Employees who do speak up and seek accommodations for their menopausal symptoms, which might include dress code adjustments to deal with hot flashes, are often out of luck. No federal law requires employers to

accommodate menopausal symptoms.

Although the Americans with Disabilities Act requires employers to provide "reasonable accommodations" for workers with disabilities, U.S. courts have consistently held that menopause, by itself, is not a disability, even when its symptoms are seriously affecting someone's ability to do their job.

That's what happened to Georgia Sipple, a food product demonstrator who had a doctor's note requesting Crossmark, her employer, refused, Sipcourt dismissed her case.

punished for their menopausal symptoms or status.

#### **Standards**

When 911 operator Alisha Coleman experienced heavy perimenopausal bleeding that seeped through onto the office carpet, she was fired for failing to "maintain high standards of personal hygiene". She sued, but the Middle District of Georgia dismissed her case, refusing to recognize her termination as a form of sex discrimination.

Instead, the judge drew a specious distinction, saying that Coleman had been fired for "being unable to control the heavy menstruation." With the help of the American Civil Liberties Union, she appealed, later obtaining a confidential settlement.

Employees have far fewer legal protections for menopause today than for pregnancy and breastfeeding.

Congress first directly addressed pregnancy discrimination in the workplace in 1978 with the Pregnancy Discrimination Act. That law made it clear that pregnancy discrimination is a form of sex discrimination. This means that an employee who was fired because her water broke and she went into labor at work would, unlike Coleman, have a winning sex discrimination claim.

Congress also passed the Pregnant Workers Fairness Act in December 2022, which goes into effect on June 27, 2023. That law requires reasonable accommodations for pregnancy, childbirth and related medical conditions unless doing so would impose an undue hardship on employers.

Since 2010, Congress has required most employers to provide breastfeeding employees with reasonable break times to pump milk for one year after their children's births, and also to provide them with a private place that isn't a bathroom to do so. Most recently, in December 2022, the Providing Urgent Maternal Protections for Nursing Mothers Act expanded those protections.

In our view, pregnancy and breastfeeding offer a potential model for protecting workers from menopauserelated discrimination and providing reasonable accommodations. Until Congress is ready to pass such legislation, there are other possibilities.

First, the Equal Employment Opportunity Commission, the agency responsible for enforcing anti-discrimination laws, could issue "best practices" guidelines. These guidelines can be modeled on practices in the United Kingdom, where many business have adopted menopause policies. Climate-controlled break spaces, dress codes that incorporate short-sleeve options and breathable fabrics, dedicated menopause support and the like can all make a positive difference. The Equal Employment Opportunity Commission could also issue guidance highlighting menopause-based discrimination as a form of sex or age discrimination.

Additionally, even if the commission does not act, companies can adopt these kinds of policies on their own. That is already starting to happen, as U.S. businesses like the tech company Nvidia and the drugmaker Bristol Myers Squibb begin to establish some accommodations for menopause, including help with finding treatments. BUENOS AIRES, Argentina, June 11, (AP): Movie director James Cameron says he feels he "walked into an ambush" this week during a visit to Argentina in which he believes there was an attempt to use his image as an environmentalist to give a positive spin to lithium mining operations despite Indigenous opposition.

Cameron, the director of "Avatar" and "Titanic," said Friday he would now devote attention and money from his Avatar Alliance Foundation to support Indigenous communities opposing lithium operations in South America.

"Ironically, the outcome of this is that I am now aware of the problem and we will now assist through my foundation with the issue of Indigenous rights with respect to lithium extraction," Cameron told a group of journalists gathered in his hotel room in the capital of Buenos Aires Friday evening.

Cameron came to Argentina this week to speak at a sustainability conference in Buenos Aires on Friday.

"I believed that I was coming here to make a kind of motivational speech about environmental causes," Cameron said.

As part of the visit, Cameron traveled to northern Jujuy province Thursday to visit a large solar power plant with Gov. Gerardo Morales and says he was never told lithium would be part of the discussion.

After Cameron's visit, Morales wrote a message on social media thanking Cameron for the visit, writing that the province was looking to "transform the energy matrix" through projects such as the solar power plant and "lithium extraction."

The director received a letter that a group of 33 Indigenous communities from the area had written to him a few days earlier asking him to either cancel his trip or meet with them so they could explain their long-held opposition to lithium mining projects they say affect their land rights and negatively impact the environment.

"I feel like I walked into an ambush," Cameron told journalists after meeting with local environmentalists, saying he was unaware of controversy involving lithium projects. "I feel like I was put into an optic that had meaning that I wasn't aware of."

Although Cameron says he "doesn't know the exact architecture" of how the "ambush" happened, he feels there was an effort to use his image not just because of his support for environmental causes but also because of the overarching message of "Avatar."

#### Conflict

"Avatar' is the highest grossing film in history. It is about the conflict between an extraction industry and the rights of Indigenous people," Cameron said. "If you could generate an optic where I appear to be approving of lithium mining, then you have a mandate of some sort or an approval of some sort.'

In their letter to Cameron, representatives of the Indigenous communities made a direct reference to "Avatar" to appeal for the director's support. "Jujuy is Pandora, and it is under the threat of the greed of the mining industry, and we are the Na'vi," reads the letter, referring to the

## 3 sopranos on Strauss' most 'complex opera'

SAN FRANCISCO, June 11, (AP): Part fairy tale, part psychodrama, Richard Strauss's "Die Frau Ohne Schatten" (The Woman Without a Shadow) calls for three big-voiced sopranos who can do justice to a long and difficult score.

That's one reason the opera, which premiered in 1919, is a relative rarity, though many consider it Strauss's masterpiece. Now the San Francisco Opera is presenting it for the first time in 34 years with a cast that includes three leading Wagner and Strauss singers: Nina Stemme as the Dyer's Wife, Camilla Nylund as the Empress and Linda Watson as the Nurse.

Another reason the work is a challenge is Hugo



Hofmannsthal's which mixes fantastical events with psychological insights.

In the story, the Empress, who comes from the spirit world, must acquire a shadow (enabling her to bear children) or else her human husband will be turned to stone in three days. She and her Nurse try to entice the unhappy wife of Barak the

Dyer to give up her shadow and thus remain childless in exchange for a life of luxury. But gradually, the Empress learns to appreciate humanity and changes her mind. And the Dyer's Wife pulls back from the brink of trading away her shadow. Everything ends happily for the two couples.

The day after the production opened on June 4 (performances continue through June 28), the AP sat down with the three sopranos to talk about the challenges and rewards of their roles. Here are edited excerpts from the conversation:

**AP:** The story is so complicated and laden with murky symbolism that even its admirers sometimes scratch their heads. What do you say when someone asks you what this opera is about?

Nylund (the Empress): It's a fairy tale for adults. Hofmannsthal and Strauss were influenced by the situation of women in their society, and especially the empresses in Europe. They had to marry and they had to bear children. That was their job. And that's still a big issue for women: Are you going to have children, are you not going to have children, how does that affect your position, your life.

Watson (the Nurse): It's very complicated. I tell people to read the synopsis five times and then just go see it. I've done this piece for 20 years and somebody came up to me last night and said, OK, we understand most of it, but how DID the Empress get a shadow? And I was like, I don't know.

Stemme (the Dyer's wife): Hofmannsthal and Strauss, they loved to leave questions like this. I mean, who is 'Die Frau'? The Empress doesn't have a shadow at the beginning, and the Dyer's Wife loses hers for a moment. Is it important? No, because I also think the opera is about relationships. And I'm intrigued by my character being based on Strauss's own wife. But to tell the story, no, nobody can really do it.

AP: How do the relationships between each married couple play out in the opera?

Watson: It's about the miscommunication that happens in any marriage, any relationship between two people in love. Their goals may be the same but they fall out for the wrong reasons.

**Nylund:** The Empress and the Emperor, they don't have any communication at all when the opera begins. Only at the end, when she has to save him because of her strength and the development she has gone through. She becomes a human being, she understands what is empathy, what is love.

**Stemme:** I think that the Dyer's Wife wants to move up through this marriage, so she wants more. She's really trying to make her husband understand that she is about to leave him if he doesn't change and start to see her. Of course she doesn't see him for his struggles and what he is either. Until she goes too far and he tries to kill her. She finally gets a reaction from Barak that she never got before and it makes her begin to understand him.

**Nylund:** It's really fantastic that two men have written this opera and it says so much about how a woman thinks and acts. Its really something very,

**AP**: The vocal parts for all three of you are notoriously difficult. What challenges did you encounter when you first started to sing your roles?

**Stemme:** I fell in love with the character, but not exactly with the music, because this role requires a range of 2½ octaves. It took a long time to learn. It's very tricky and the tonality is complicated, just like her personality. I understand why he composed it like this, to explore the complexity of her personality and also to show that she doesn't

understand herself as a person. Watson: It's excruciating. I had sung the Dyer's Wife, and when I decided to switch I thought, ah, OK, I'll sing a mezzo role and this will be one step easier, lower. And that's a joke. Is it a mezzo role? It is, and it's not. It's very high, and very low, down to a low E-flat. If you don't have the technique, you can ruin your voice in a second. You're just going to yodel through the whole piece.

**Nylund:** When I first started studying my role I thought, Oh my God, what is he doing here? Because you have to start like some kind of coloratura with a really light top that goes up to high D, and then you have to also have power in your voice, so the role is very complex.

AP: What do you imagine happens to your character after the opera ends?

Watson: I think she dies. The Empress rejects her and she is sent off to live among "mankind," which she detests. It's death for her.

Nylund: I see her living happily ever after. The Emperor has finally noticed that they are equal, because of what she did for him. They can communicate on the same level now.

Stemme: Maybe not happily ever after, but Barak and his wife will start to talk, communicate. Because they have found each other as human be-

**MOSCOW:** An American musician who has lived in Russia for more than a decade has been arrested on suspicion of drug trafficking, Russian news media reported

The reports said Michael Travis Leake is suspected of selling mephedrone, whose effects are similar to those of cocaine and MDMA. A Moscow court ordered him to be held for two months in pre-trial detention, the reports said.

He faces charges of production or distribution of drugs, which carry a sentence of up to 20 years in prison.

An Instagram page under the name Travis Leake Instagram identifies him as the singer for the band Lovi Noch (Seize the Night). News reports said Leake is a former paratrooper with the U.S. military and has lived in Moscow since 2010.

Russian drug laws are strict. WNBA star Brittney Griner was arrested in February 2022 after vape canisters containing cannabis oil were found in her luggage at a Moscow airport. She was sentenced to nine years in prison, but was released in December in an exchange for U.S.-imprisoned Russian arms dealer Viktor Bout.

The U.S. State Department said in an emailed statement to The Associated Press that it was aware of the reports that a U.S. citizen had recently been arrested in Moscow. It said when a U.S. citizen is detained overseas, the department "pursues consular access as soon as possible and works to pro-

vide all appropriate consular assistance. The department said it would have no further comment due to privacy considerations. (AP)

# Rose proud of album's vulnerability

LOS ANGELES, June 11, (AP): During a recent performance at the Fonda Theater in Los Angeles, indie musician Caroline Rose disappeared from the stage and emerged moments later atop a table in the back of the room.

"We're going to do a trust fall," they told the audience, encouraging concertgoers to gather around before plunging backward into the sea of people and letting it carry her back to the

The stunt was emblematic of her latest album - admittedly, their most unguarded yet - about a breakup and its aftermath. One to always hide behind humor, Rose said this level of vulnerability was new for her and that she is still processing whether it was even the right choice.

"When I'm writing the material, it feels really cathartic. And I'm like, 'Wow, I made something beautiful from this really dark time.' But performing the songs has been totally different," they said of having to recount those dark memories over and over.

But despite having some "huge moments of regret," the singer, songwriter and multi-instrumentalist tends to think it was ultimately worth it. "Because I'm fine. And, you know, hopefully, my ex is fine," they grinned sheepishly.

The thoroughgoing melancholy sound of "The Art of Forgetting," Rose's third studio album, is complemented by lyrics of grief and frustration, such as her allusion to arguments with her mom in the song, "Miami."

"Your father and I are in the last stage of our lives, so for God's sake, no more talk of how you imagine dying," she sings of her mother's grievances and counsel to be stronger.

But the breakup and her ways of dealing with it were not the only intimate aspects of the album. Woven between songs are voicemails from her

grandmother, who died shortly after the album was finished and would often call in the months before her passing, sometimes forgetting she was on the phone.

"There were like these different motifs that came up throughout the album. One of them was this theme of memory," they said. "She's losing her memory and all she wants to do is like, remember everything. And I'm just like, 'I want to forget my life ever

Rose has always known they wanted their personal life to inform her art, though they initially struggled with how best to balance the two.

After graduating from Wellesley College with a degree in architecture, they formally began their music career in Americana, a combination of country, bluegrass and folk music. But they eventually left after struggling with how to be frank about their sexuality within the genre.

#### Rejection

"It was really confusing too, because I was dating a guy and I've known I was gay since I was, like, three," they recalled of how much more difficult it was to come out just a decade ago. "I would have been very alone in that world."

But Rose's departure from any genre would have perhaps been inevitable, given their rejection of what they refer to as the "McDonald's hamburger mentality.

"You develop a brand and then you sell that brand. I never really do that. All my records sound different," she said. "So long as people are cool with that and just let me kind of do my thing and express myself in whatever way comes naturally in that moment, that's really all I want. It's just freedom."

street busker, Rose maintains they are motivated more by a love for art and self-expression than by money and fame. "I'm not really out there looking to fill stadiums," they said.

That ethos frees her from a lot of what many consider to be part and parcel of the job nowadays, such as maintaining a strong social media presence or making songs that go viral on Tik-

But their aversion to social media is not necessarily a reflection of Luddite tendencies. As both a producer and savvy instrumentalist, she knows music has and always will evolve with

"Musicians are already kind of cyborgs," she said when asked if they object to recording artists using artificial intelligence in production. "Everybody tunes their vocals. There's machines all over music and there has been for decades now."

Although ostensibly not utilizing their degree - Rose said if they could do it over, they would skip college and go straight into making music - she relied heavily on her knowledge of architecture and her days as a "theater nerd" to design the set for this tour.

"I've always been a person with very unbridled emotions," they said of the growing pains this album has laid bare. "I've learned so much in the process of the last few years of how to handle stuff better, difficult things and letting them go.'

# El Nino to add heat to a warming world

NEW YORK, June 11, (AP): An early bird El Nino has officially formed, likely to be strong, warp weather worldwide and give an already warming Earth an extra kick of natural heat, meteorologists announced.

The National Oceanic and Atmospheric Administration Thursday issued an El Nino advisory, announcing the arrival of the climatic condition. It may not quite be like the others.

It formed a month or two earlier than most El Ninos do, which "gives it room to grow," and there's a 56% chance it will be considered strong and a 25% chance it reaches supersized levels, said climate scientist **Michelle L'Heureux**, head of NOAA's El Nino/La Nina forecast office.

"If this El Nino tips into the largest class of events ... it will be the shortest recurrence time in the historical record,' said Kim Cobb, a climate scientist at Brown University. Such



a short gap between El Ninos leaves communities with less time to recover from damages to infrastructure, agriculture, and ecosystems like coral reefs.

Usually, an El Nino mutes hurricane activity in the Atlantic, giving relief to coastal areas in states from Texas to New England, Central America and the Caribbean, weary from recent record busy years. But this time, forecasters don't see that happening, because of record hot Atlantic temperatures that would counteract the El Nino winds that normally decapitate many storms.

Hurricanes strengthen and grow when they travel over warm seawater, and the tropical regions of the Atlantic Ocean are "exceptionally warm," said Kristopher Karnauskas, associate professor at the University of Colorado Boulder. So this year, NOAA and others are predicting a near-average Atlantic hur-

In the past, a strong El Nino has led to record global warmth, like in 2016 and 1998. Scientists earlier this year had been saying next year is more likely to set a record heat, especially because El Ninos usually reach peak power in winter. But this El Nino started even earlier than usual.

#### **Implications**

"The onset of El Nino has implications for placing 2023 in the running for warmest year on record when combined with climate-warming background," said University of Georgia meteorology professor Marshall Shepherd.

An El Nino is a natural, temporary and occasional warming of part of the Pacific that shifts weather patterns across the globe, often by moving the airborne paths for storms. The world earlier this year got out of an unusually long-lasting and strong La Nina - El Nino's flip side with cooling - that exacerbated drought in the US West and augmented Atlantic hur-

What this in some ways means is that some of the wild weather of the past three years - such as drought in places will flip the opposite way.

"If you've been suffering three years of a profound drought like in South America, then a tilt toward wet might be a welcome to development," L'Heureux said. "You don't want flooding, but certainly there are portions of the world that may benefit from the onset of El Nino.'

For the next few months, during the northern summer, El Nino will most be felt in the Southern Hemisphere with "minimal impacts" in North America, L'Heureux said.

El Ñino strongly tilts Australia toward drier and warmer conditions with northern South America - Brazil, Colombia and Venezuela - likely to be drier and Southeast Argentina and parts of Chile likely to be wetter, she said. India and Indonesia also tend to be dry through August in El Ninos.

While traditionally El Nino means fewer hurricanes in the Atlantic, it often means more tropical cyclones in the Pacific,

El Nino hits hardest in December through February, shifting the winter storm track farther south to the equator. The entire southern third to half of the United States, including California, is likely to be wetter in El Nino. For years, California was looking for El Nino rain relief from a decades long megadrought, but this winter's seemingly endless atmospheric rivers made it no longer needed, she said.

The US Pacific Northwest and parts of the Ohio Valley can go dry and warm, L'Heureux said.

Some of the biggest effects are likely to be seen in a hotter and drier Indonesia and adjacent parts of Asia, L'Heureux said. Also look for parts of southern Africa to go dry.

On the other hand, drought-stricken countries in northeast Africa will welcome beneficial rainfall after enduring drought conditions for several years due to prolonged La Nina events, said Azhar Ehsan, associate research scientist at Columbia

Some economic studies have shown that La Nina causes more damages in the United States and globally than El Nino.

One 2017 study in an economic journal found El Nino has a "growth-enhancing effect" on the economies of the United States and Europe, while it was costly for Australia, Chile, Indonesia, India, Japan, New Zealand and South Africa.

But a recent study says El Nino is far more expensive globally than previously thought, putting damage estimates in the trillions of dollars. The World Bank estimated that the 1997-1998 El Nino cost governments \$45 billion.

The United States also faces hazards from El Nino despite some benefits. Ehsan noted that the increased rainfall in California, Oregon, and Washington heightens the risk of landslides and flash flooding in these areas. "While El Nino brings benefits in terms of water resource recharge, it poses certain hazards that need to be considered and managed," he added.

#### Also:

BONN, Germany: Environmental campaigners called recently for fossil fuel producers to contribute to a new fund intended to help poor countries cope with climate disasters.

The so-called loss and damage fund was a key achievement of last year's UN climate summit in Egypt. Developing nations have long demanded more financial support for the impacts from global warming, which is historically driven by pollution from rich countries.

"It is the prime responsibility for countries to fill that fund, particularly those with the greatest historic responsibility," said **Rebecca Newsom**, of the environmental group Greenpeace.

"But in order to fill that fund at scale now, we need to really ramp things up," she said. "The most obvious starting point is, of course, the fossil fuel industry, the creators of the crisis that we are now facing.

Oil, gas and coal firms have faced mounting criticism in recent years for continuing to extract fuels that, when burned, release planet-warming greenhouse gases into the atmosphere. U.N. Secretary-General António Guterres called earlier this year for fossil fuel companies to be held to account for the damage they caused despite knowing about the harmful effects of their products.


Negotiations on setting up the loss and damage fund are a main focus of international climate talks taking place in Bonn, Germany, this week. Some countries have pushed back against the idea of getting Big Oil to chip in from the start.

Mohamed Nasr, Egypt's lead negotiator, said there was a risk of "overloading the very delicate and, I would say, very sensitive discussion that is happening" before this fall's UN summit in **Dubai**.

While Nasr said he wasn't opposed to contributions from the fossil fuel or aviation industry, these could be difficult to implement and the main focus should be on rich nations.

But Newsom, of Greenpeace, contrasted the recent surge in oil company profits with the rising damage expected worldwide from climate change.

"It doesn't take a rocket scientist to join the dots between growing climate loss and damage around the world and exorbitant fossil fuel company profits," she said.

#### Thunberg vows to still protest: Swedish environmental activist Greta Thunberg said Friday she will no longer be able to skip classes as a way to draw attention to climate change because she is graduating from high

Thunberg, 20, started staging Friday protests outside the Swedish parliament building during school hours in 2018. Teenagers from around the world followed her lead. leading to an international student move-

ment called Fridays for Future. Because she won't be a student anymore, Thunberg noted that her future Friday activities that "technically" won't be school striking. But in a tweet, she vowed to continue protesting, saying, "The fight has only just begun?

"We are still moving in the wrong direction, where those in power are allowed to sacrifice," Thunberg wrote on Twitter. "We're rapidly approaching potential nonlinear ecological and climatic tipping points beyond our control.'

As a teenager Thunberg was invited to speak to political and business leaders at U.N. conferences and the annual World Economic Forum in Davos. She also was named Time magazine's youngest Person of the Year in 2019 and received several nominations for the Nobel Peace Prize.

For her final school strike outside parliament, Thunberg posed with a Swedish-language sign while wearing the cap that high school graduates typically wear in Sweden.

#### Philippines evacuates thousands:

Thousands of people who fled their homes in the central Philippines to escape a restive volcano have to contend with another threat that's complicating the ongoing evacuations: monsoon rains that could be unleashed by an approaching typhoon.

More than 6,000 villagers have been forced to leave rural communities within a 6-kilometer (3.7-mile) radius of Mayon volcano's crater in northeastern Albay province. Thousands more need to be moved to safety from the permanent danger zone, officials said.

Others living outside the perimeter have packed their bags and voluntarily left with their children for evacuation centers in Albay, which was placed under a state of calamity on Friday to allow more rapid disbursement of emergency funds in case a major eruption unfolds. Authorities raised the alert level for the

volcano on Thursday after superheated streams of gas, debris and rocks cascaded down its upper slope, indicating activity below the surface that could precede a hazard-

#### **Reefs dying in warming seas**

## UAE uses coral nurseries to revive reefs

ABU DHABI, United Arab Emirates, June 11, (AP): On a boat off the coast of an island near Abu Dhabi, marine scientist Hamad al-Jailani feels the corals, picked from the reef nursery and packed in a box of seawater, and studies them carefully, making sure they haven't lost their color.

The corals were once bleached. Now they're big, healthy and ready to be moved back to their original reefs in the hope they'll thrive once more.

"We try to grow them from very small fragments up to - now some of them have reached - the size of my fist," al-Jailani said, who's part of the Environment Agency Abu Dhabi's coral restoration program.

The nursery gives corals the ideal conditions to recover: clear waters with strong currents and the right amount of sunlight. Al-Jailani periodically checks the corals' growth, removes any potentially harmful seaweed and seagrass, and even lets the fish feed off the corals to clean them, until they're healthy enough to be relocated.

The Environment Agency Abu Dhabi, or EAD, has been rehabilitating and restoring corals since 2021, when reefs off the United Arab Emirates' coast faced their second bleaching event in just five years. EAD's project is one of many initiatives - both public and private - across the country to protect the reefs and the marine life that depend on them in a nation that has come under fire for its large-scale developments and polluting industries that cause harm to underwater ecosystems. There's been some progress, but experts remain concerned for the future of the reefs in a warming world.

Coral bleaching occurs when sea temperatures rise and sun glares flush out algae that give the corals their color, turning them white. Corals can survive bleaching events, but can't effectively support marine life, threatening the populations that depend on them.

The UAE lost up to 70% of their corals, especially around Abu Dhabi, in 2017 when water temperatures reached 37 degrees Celsius (99 degrees Fahrenheit), according to EAD. But al-Jailani said 40-50% of corals survived the second bleaching event

Although the bleaching events "did wipe out a good portion of our corals, he said, "it did also prove that the corals that we have are actually resilient ... these corals can actually withstand these kind of conditions.'

Bleaching events are happening more frequently around the world as waters warm due to human-made climate change, caused by the burning of oil, coal and gas that emits heat-trapping gases into the atmosphere. Other coral reef systems around the world have suffered mass bleaching events, most notably Australia's Great Barrier Reef.

How to limit global warming and its effects will be discussed at length at the United Nations climate conference, which will be held in Dubai later

#### **Emissions**

The UAE is one of the world's largest oil producers and has some of the highest per capita greenhouse gas emissions globally. The country has pledged to have net zero carbon emissions by 2050, which means all carbon dioxide emissions are either slashed or canceled out somehow, but the goal has been met with skepticism from

But bleaching due to warming weather is not the only threat to coral reefs around the gulf. High oil tanker traffic, fossil-fuel related activities, offshore installations, and the exploitation of marine resources are all putting marine life under intense stress, according to the UN Environment Programme, causing them to degrade.

Environmentalists have also long criticized the UAE, and Dubai in particular, for its large-scale buildings and huge coastal developments.

The building of the Palm Jebel Ali, which began more than a decade ago and has been on hold since 2008. caused an outcry among conservationists after it reportedly destroyed about 8 square kilometers (5 square miles) of reef.

"More than 90 million cubic meters (23.8 billion gallons) of sediments were dredged and dropped, more or less on top of one of the remaining reefs near Dubai," said John Henrik

a house painter, told The Associated Press.

Mayon's slopes.

Stahl, the dean of the College of Marine Sciences at Khorfakkan University in Sharjah, UAE. The project was meant to be similar

to the Palm Jumeirah - a collection of small, artificial islands off the coast of Dubai in the shape of a palm tree.

Still, environmental projects persist across the coastline and throughout the emirates.

Development company URB has announced it wants to grow 1 billion artificial corals over a 200-square-kilometer area (124 square miles) and 100 million mangrove trees on an 80-kilometer (50-mile) strip of beaches in Dubai by 2040.

Still in the research and development phase, the project hopes to create 3D technology to print materials that can host algae, much like corals.

Members of Dubai's diving community are also encouraging coral protection efforts.

Diving course director Amr Anwar is in the process of creating a certified coral restoration course that teaches divers how to collect and re-plant corals that have fallen after being knocked off by divers' fins or a boat's anchor.

"I don't want people to see broken corals and just leave them like that," said Anwar. "Through the training we give people, they would be able to take these broken corals that they find and plant them elsewhere, and then see them grow and watch their progress."

But experts say that unless the threat of overheating seas caused by climate change is addressed, coral bleaching events will continue to occur, damaging reefs worldwide.

Countries have pledged to limit the global average temperature rise to 1.5 degrees Celsius (2.7 degrees Fahrenheit) since pre-industrial times, after which scientists say the effects of warming on the planet could be much worse, and some even potentially irreversible. But analysts say most nations - including the UAE - are still way off that target.

"You have to make sure that the cause for the degradation of the coral reefs in the first place is no longer a threat," said Stahl, the Khorfakkan University scientist. "Otherwise the restoration effort may be for nothing.'

Pictures of the bear and its capture touched off a frenzy on social media. The bear was discovered roaming the Brookland neighborhood, less than 5 miles from the Capitol and White House. Authorities formed a perimeter near the 1300 block of Franklin Street NE to keep curious onlookers away. When the young male bear climbed a tree, police used their sirens to discourage him from climbing down until capture crews were ready.

Undeterred by the noise, the bear came down around 10 a.m. and started wandering area yards. Humane Rescue Alliance staffers were able to tranquilize the approximately 200- pound animal and load it into a huge metal crate. The young male will now receive a medical check and be released back into the wild, "somewhere in Maryland," said Chris Schindler, vice president of field services for the Humane Rescue Al-

## Lopez dominates Taylor for 140-pound title

NEW YORK, June 11, (AP): Teofimo Lopez was so unimpressive in his last fight that he was caught on camera afterward asking if he still had it.

Well, he definitely does.

Lopez captured a title in a second weight class Saturday night, beating formerly unbeaten Josh Taylor by unanimous decision to win the WBO's junior welterweight belt.

Lopez, the former lightweight champion, hadn't looked sharp lately after moving up to 140 pounds. But he delivered a superb performance inside Madison Square Garden, with punches that were just quicker and stronger than the champion's.

Lopez (19-1) won by scores of 115-113 on two cards and 117-111 on the other, and he threw power shots throughout the final round in hopes of not even getting to the scorecards

# Australia win World Test Championship

Aussies rout India by 209 runs

LONDON, June 11, (AP): Australia earned **World Test Championship** after bowling out India for 234 and winning the final by 209 runs at the Oval on Sunday.

Despite a world-record target of 444, India started the fifth and last morning with hope at 164-3 and linchpin Virat Kohli and Ajinkya Rahane in the middle.

But Kohli was gone after half an hour and Rahane's demise started a collapse of the last five India wickets in the half-hour to scheduled lunch.

Scott Boland, playing instead of the injured Josh Hazlewood, started Australia celebrations with a twowicket over including Kohli, and Mitchell Starc and Nathan Lyon also took two each for the first-time world test champion. Hazlewood will replace in the Ashes is a good dilemma for Australia.



Boland and spinner Nathan Lyon, who finished off the India second innings with 4-41, took five wickets each in the match and Cummins, despite his no balls, Starc and Green contributed mightily to bowling out India twice after they put up 469 and 270-8 declared.

Wicketkeeper Alex Carey was also key with scores of 48 and 66 not out, and seven catches.

"We came into this having different preparations but everyone was switched on," Cummins said. "We'll savor this and then turn our attention to the Ashes.

SUNRISE, Fla., June 11, (AP): With no time left on the clock in Game 4 of the Stanley Cup Final, helmets, gloves, sticks and plastic rats littered the ice, the result of a fracas started in the final seconds of an emotional showdown.

For all the punches, pushes and shoves that accumulated in the melee, none of them changed the result: The Vegas Golden Knights are on the verge of winning their first Stanley Cup title.

Vegas held on to beat the Florida Panthers 3-2 on Saturday night, staving off a rally that culminated with one final shot block and a big save at the end to take a 3-1 series lead in the Cup

"Obviously, that was a battle till the last second," Vegas forward Nicolas Roy. "They pushed back there. We knew they would. They've been doing it all series. But it's nice to get that one, for sure.

The Golden Knights can win the NHL championship on home ice Tuesday night.

We've played really well at home here in the playoffs, so you've got to feel pretty good going home with a 3-1 lead," defenseman Alex Pietrangelo

Getting to this point wasn't easy. Chandler Stephenson scored twice for the Golden Knights, and William Karlsson broke through to end his series-long goal drought to build a 3-0 lead. The Panthers scored twice - Brandon Montour on a pinball goal late in the second period, and Aleksander Barkov's first of the series early in the third - to claw back into it.

But their rally fell short and put Florida, eighth seed in the Eastern Conference and final team to qualify for the playoffs, on the brink of this improbable run coming to an end.

'We've earned the right to play our best hockey," Panthers coach Paul Maurice said. "Where we've been at our strongest is at the most critical time. I think you'll see that."

# Ferrari topples Toyota in return to 24 **Hours of Le Mans after 50-yr absence**

LE MANS, France, June 11, (AP): Ferrari ended a 50-year absence from the 24 Hours of Le Mans by toppling mighty Toyota in the centenary running of the most iconic sports car race in the world.

Ferrari last competed at Le Mans in 1973 but returned to Circuit de la Sarthe this year as part of a new hyperclass category that features hybrid technology. The hyperclass came from a rules convergence that both

allowed competitors from the United States' sports car series, IMSA, to compete at Le Mans, and also created an enticing platform automakers viewed as an opportunity to showcase their street car technology.

Ferrari developed its program - a two-car effort that competes in the World Endurance Championship - over several years in a strategy similar to what was depicted in "Ford v Ferrari," the film that focused on the boardroom pressures and drama surrounding Ford's 1963 successful effort to end Ferrari's reign at Le Mans.

Only this time it was Ferrari trying to knock down a giant; the two-car Toyota Gazoo effort, which had entered the twice-round-the-clock race that ended Sunday on a five-year

Toyota was dealt a blow before the race even began when race officials this week added additional weight to the dominant GR010s in a controversial "balance of performance'

adjustment designed to level the playing field. Ferrari in a pair of 499Ps pounced and swept the front row in qualifying and handled every challenge from Toyota. Its chances were aided overnight when Kamui Kobayashi was

wrecked out of the race, making it two versus one in favor of Ferrari.

The trio of Alessandro Pier Guidi, James Calado and Antonio Giovinazzi - with Ferrari Formula One driver Charles Leclerc in the garage watching - were the easy winner. The trio had a solid lead even before defending race winner Ry□ Hirakawa locked the brakes on his Toyota and hit the wall with 1 hour, 44 minutes remaining.

It took roughly three minutes for repairs to the car, not enough time to help Chip Ganassi Racing, which carried the American flag at Le Mans for IMSA.

The centenary marked the first year IMSA's top class was

granted participation at Le Mans, and the new hyperclass brought Cadillac back to both IMSA and WEC with Ganassi, same for Porsche with Roger Penske in the 86-yearold's attempt to win one of the very few races missing on his list. It also brought a slew of new manufacturer interest to sports car racing, which helped draw a sold-out crowd of 300,000-plus spectators to the sprawling 8.467-mile

(13.626 km) track. The Ganassi Cadillacs were running third and fourth when Hirakawa spun - eliminating the defending champions' chances at a repeat. But it briefly created an opportunity for one or both Cadillacs to improve their finishing

# City end wait for first Champs League title

#### Citizens complete a rare treble

ISTANBUL, June 11, (AP): Billions of dollars have been spent and many tears shed on Manchester City's journey to the summit of European soccer.

The mission was completed in Istanbul's Ataturk Olimpiyat Stadium as the Abu Dhabi-backed club won the Champions League title for the first time and perhaps heralded the start of a new era of dominance in the competition.

"It was written in the stars. It belongs to us." said Pep Guardiola after the 1-0 win against Inter Milan, as tears flowed again from the manager, his players and a sea of blue-shirted fans.

On this occasion, the emotion was pure ecstasy.

The victory, courtesy of Rodri's 68th minute goal, has been 15 years in the making since Sheikh Mansour bin Zayed Al Nahyan transformed City into one of the richest teams in the world overnight.

This was the final frontier for Pep Guardiola's team, which also completed a rare treble of trophies after winning the Premier League title and FA

Cup this season. The Champions League had always been a step that seemed out of reach even for a team that has spent more than \$1.5 billion on the world's best players and hired probably the greatest coach of his generation in Guardiola.

With that psychological barrier broken and the spending power to further improve a team that has already proved too good for the rest, the potential is there to win European club soccer's biggest prize on multiple occasions.

Guardiola joked about being "just 13 Champions Leagues away" from Real "If you sleep a little bit we will catch you," he said. "But I don't want after one Champions League to disappear, so work harder next season and be in there. There are teams that win the Champions League and after one or two seasons disappear. This is what you have to avoid. Knowing me this is not going to happen. But at the same time I have to admit it, it is a big relief for the club, for the institution, for everyone to have this trophy. Because now, finally, they don't have to ask me if we are going to win the Champions League or not.

This trophy will also strengthen the case to declare Guardiola the greatest coach ever as he collected his third

Champions League title and 30th maior piece of silverware.

It was his second treble of trophies, having emulated that feat with Barcelona in 2009. City became just the second English club to complete a sweep of the three biggest trophies after Manchester United did it in 1999.

There were questions about whether Guardiola could ever win the Champions League again without the aid of Lionel Messi, who was the inspiration of his Barcelona team that was twice crowned champions of Europe.

Those questions have been now been answered, yet for all the talk of City's superiority leading up to the game, it was won by the finest of margins through Rodri's strike.

Even after that goal, Inter had great chances to force extra time.

The best one fell to substitute Romelu Lukaku in the 89th minute but he headed straight at Ederson from about four meters (yards) out.

# Djokovic wins historic 23rd Grand Slam title

PARIS, June 11, (AP): Novak Djokovic made clear for years that this was his goal. What drove him. What inspired him. The biggest titles from his sport's biggest stages were Djokovic's main aim and now he finally stands alone - ahead of Rafael Nadal, ahead of Roger Federer, ahead of every man who ever has swing a racket.

If Djokovic could wait this long to hold this record, he certainly could wait for the half-hour or so it took to straighten out his strokes in the French Open final. And so, after a bit of a shaky start in thick, humid air and under foreboding charcoal clouds Sunday, he imposed himself. The opponent at Court Philippe Chatrier, Casper Ruud, never really stood a serious

chance after that Djokovic earned his men's-record 23rd Grand Slam singles championship, breaking a tie with Nadal and moving three in front of the retired Federer, with a 7-6 (1), 6-3, 7-5 victory over Ruud that really was not in doubt for most of its 3 hours, 13

Djokovic, a 36-year-old from Serbia, puts this one alongside the French Open titles he earned in 2016 and 2021, making him the only man with at least three from each major event. He has won 10 trophies at the Australian Open, seven at Wimbledon and three

at the U.S. Open. Also worth noting: Djokovic is again halfway to a calendar-year Grand Slam - winning all four majors in one season - something no man has achieved since Rod Laver in 1969. Djokovic came close to pulling off that feat in 2021, when he won the Austral-

ian Open, French Open and Wimbledon and made it all the way to the title match at the U.S. Open before losing to Daniil Medvedev.

Djokovic will resume that pursuit at Wimbledon, which begins on the grass of the All England Club on July 3.

He has now clutched the trophy at 11 of the last 20 Slams, a remarkable run made even more so when considering that he did not participate in two majors during that span because he did not get vaccinated against COVID-19.

At 20 days past his 36th birthday, Djokovic is the oldest singles champion at Roland Garros, considered the most grueling of the majors because of the lengthy, grinding points required by the red clay, which is slower than the grass or hard courts underfoot else-

Nadal's 22nd major arrived in Paris a year ago, two days after he turned 36. He has been sidelined since January by a hip injury and had arthroscopic surgery on June 2.

As if all of that weren't enough, Diokovic's triumph on Sunday also means he will return to No. 1 in the ATP rankings on Monday, replacing Carlos Alcaraz. Djokovic already has spent more weeks at the top spot than any player - man or woman - since the inception of computerized tennis rankings a half-century ago.

It was Djoković who eliminated Alcaraz in the semifinals on Thursday, wearing him down over two thrilling sets until the 20-year-old Spaniard's body cramped up badly. Alcaraz continued to play, but the scores of the last two sets of the four-set match told the story: 6-1, 6-1.
