

Heat could cool ambitions

Climate may impact Hajj plans

MAKKAH, Saudi Arabia, June 22, (AP): Saudi Arabia has ambitious plans to welcome millions more pilgrims to Islam's holiest sites. But as climate change heats up an already scorching region, the annual Hajj pilgrimage - much of which takes place outdoors in the desert - could prove even more daunting.

The increased number of pilgrims, with the associated surge in international air travel and infrastructure expansion, also raises sustainability concerns, even as the oil giant pursues the goal of getting half its energy from renewable resources by 2030.

Next week, Saudi Arabia hosts the first Hajj pilgrimage without the restrictions imposed during the coronavirus pandemic. Some 2.5 million people took part in the pilgrimage in 2019, and around 2 million are expected this year.

Under Crown Prince Mohammed bin Salman's wide-ranging plan to overhaul the kingdom's economy, known as Vision 2030, 30 million pilgrims would take part in the Hajj and Umrah - a smaller, year-round pilgrimage. That would be an increase of more than 10 million from pre-pandemic levels.

It will require a vast expansion of hotels and other infrastructure in Makkah and Madinah, ancient cities already largely obliterated by high-rises and shopping malls. The additional pilgrims will require more long-distance flights,

KUWAIT CITY: Weather in Kuwait is forecast to be quite hot in the coming days but temperature will drop by some degrees at night, the meteorology department reported on Thursday.

Abdulaziz Al-Qarawi, the

weather monitor, told KUNA that Kuwait would be affected by the seasonal Indian low wave, along with dust-triggering northwesterly winds that lower visibility.

Temperature tonight is forecast to drop to a maximum 31-33 degrees, but will soar tomorrow Friday to 47-49 degrees in daytime and will get stronger on Saturday, hitting 48-50 degrees. (KUNA)

JERUSALEM: Israeli police on Wednesday fired tear gas, spongetipped bullets and a water cannon during mass demonstrations by Druze Arabs in the Golan Heights - a rare burst of violence in the normally quiet area. At least 20 people were reported injured.

Thousands of Druze residents of

the Golan took part in the demonstrations against the construction of massive wind turbines. The windswept area is an ideal spot for the turbines, but residents fear damage to their properties and landowners have said they did not understand the agreements they signed with a local power company, according to Israeli media.

Israeli police said a large crowd attempted to storm a police position in the town of Masade, throwing stones, fireworks, setting tires on fire, vandalizing police cars, blocking roads and even shooting live fire into the air. (AP)

IRBIL: Assistant Secretary-General and Director of the Regional Bureau for Arab States of the United Nations Development Programme (UNDP) Abdallah Al Dardari discussed with Iraqi governments officials and Kurdistan Regions officials the importance of diversifying sources of income.

In a statement, Kurdistan Region government said that this came during a meeting between UN delegation headed by Al-Dardari and President of Kurdistan Region Nechervan Barzani, where the UN delegation affirmed that they aim to help Kurdistan Region to diversify sources of income rather than just relying on oil.

Barzani affirmed that the future of Iraq and Kurdistan Regin depends on diversifying sources of income and economy, as the two sides discussed the climate change and its serious effect on Iraq, while the UN delegation affirmed support for Iraq and Kurdistan to face it. (KUNA)

MADRID: The bodies of a man and

a child were retrieved from waters off the western coast of Morocco and 24 people were rescued after a rubber dinghy carrying migrants sank, **Spain**'s Maritime Rescue service said Wednesday.

A Spanish NGO, Caminando Fronteras (Walking Borders), says more than 60 people were aboard and that more than 30 were reported missing. It accused Spanish authorities of failing to assist the migrants in time.

The NGO monitors migrant boats in the area to try to help them and receives calls from people on the boats or their relatives. (AP)

STOCKHOLM: The shipwreck last week off Greece that is feared to have killed hundreds of people may be the "worst ever tragedy" of its kind in the Mediterranean Sea, the European Union's migration

chief said Wednesday. The tragedy comes as migrant crossings from eastern Libya to Europe have surged, said Ylva Johansson, the EU's migration and home affairs commissioner. (AP)

ize the aspirations of both nations. They exchanged views on a range of regional and international issues, with emphasis on the latest developments of the situation in the occupied Palestinian territories and recurrent Israeli attacks on the Palestinian people.

Sheikh Salem and Amir-Abdollahian also discussed the situations in Yemen, Iraq, Syria and Afghanistan, as well as the nuclear dossier of Iran and war in Ukraine.

They stated a shared desire to enhance cooperation and back the international efforts to preserve regional and international

peace, security and stability.
In latest development, the president of the United Arab Emirates met with Iran's visiting foreign minister on Thursday in the latest sign of improving relations between Arab Gulf countries and the Islamic Republic.

The UAE, Saudi Arabia and other Gulf countries have long harbored suspicions about Iran because of its nuclear program and support for militant groups across the region, and have cultivated close defense ties with the U.S. But in recent months they have charted a more independent path, reaching out to U.S. adversaries as Washington increasingly focuses on Russia and China

Sheikh Mohammed bin Zayed Al Nahyan and Iranian Foreign Minister Hossein Amir Abdollahian "discussed the importance of building on positive developments to benefit the people of the region and enhance regional stability and prosperity," the UAE's state-run WAM news agency reported.

Iranian state TV said the two met for 90 minutes and discussed further cooperation in different fields. It said the Iranian foreign minister invited Sheikh Mohammed to visit Iran and that the UAE president invited Iran's President Ebrahim Raisi to visit the Emirates.

The meeting follows similar recent outreach by Saudi Arabia, which agreed to normalize relations with Iran for the first time in seven years in a deal brokered by China in March. The two countries have since reopened embassies and held high-level official visits.

The UAE, home to the futuristic cities of Dubai and Abu Dhabi, is a close U.S. military ally that hosts some 2,000 American troops at the Al-Dhafra Air Base. U.S. forces based there and in other Arab Gulf countries have long been seen as a deterrent to Iran.

The UAE was also the driving force behind the so-called Abraham Accords, in which it and three other Arab countries forged ties with Israel. Israel views Iran as its greatest threat and hopes to further isolate it by pursuing closer ties with Arab states.

Israel and the U.S. are keen to reach a normalization agreement with Saudi Arabia. Saudi officials say any such agreement would have to be linked to resolving the Israeli-Palestinian conflict.

Meanwhile, the European Union and Iran held talks in Doha on Wednesday on a number of regional and international issues, according to Enrique Mora Deputy Secretary General, and the Political Director at the European External Action Service of the EU's diplomatic service.

"Intense talks vesterday and today with Vice Minister Bagheri Kani in Doha on a range of difficult bilateral, regional and international issues, including the way forward on the JCPOA," said Mora, who is also EU's negotiator on Iran nuclear deal, on

his twitter message. He said they had a "good exchange "on the Gulf, including the new EU strategy for the Gulf, the appointment of the new EU

LET us talk about the ruling house and the path that the people are aspiring for. This is essential especially after the speech delivered by His Highness the Deputy Amir and the Crown Prince with his optimistic words and the directives issued to the two authorities, as well as the election of the National Assembly Speaker by acclamation, and the speech of His Highness the Prime Minister in which he extended his hand of cooperation to the National As-

Undoubtedly, the participation of Sheikh Ahmad Al-Fahad and Sheikh Firas Al-Malik in the new Council of Ministers is the beginning of the disruption of the mines that were planted in the process of government work years ago. Their participation increases the prestige and strength of the ruling house in its presence at the public level, as it is known that these houses are coherent and in harmony

between its members and the people.

Indeed, Sheikh Ahmad Al-Fahad has disputes, but in return he has his supporters, and he has his presence in public affairs. When a page is turned over, it means the start of stable work in the ruling house. However, the question remains - Why did these disputes occur? Why are ing bribery and corruption?

It must firstly be emphasized that royal families or rather monarchs are far from the commercial front or other public works. This is due to the fact that the goal is to keep them away from direct negative contact with people. That is why they have their own schools, which are interested in educating their members until the seventh generation of potential kings. This is the case in Norway, Sweden, Belgium, the Emirates, Qatar, Saudi Arabia, the Sultanate of Oman and Bahrain, and many others that I am unable to recall at the moment. For this reason, sufficient funds are allocated for them so that none of them need to crowd out people in their business, which is an indicator that Kuwait is not accustomed to.

This happens mainly because there is a failure in fulfilling their rights, given that the budget of the Amiri Diwan - which takes care of members of the ruling family - is KD 50 million. This is not enough to quell the urge of the sheikhs to earn more through work. Realistically, in the eyes of the people, the members of the ruling family are the elite, and they have prestige that cannot be deviated from.

It is natural that these houses have their secrets and rituals that cannot be deviated from also. Therefore, preserving their prestige is a task that cannot be taken lightly. This is what the Emirates, as well as other monarchical states, are accustomed to in their ruling houses.

On the other hand, the first thing that threatens any state is harm towards the ruling family. In Saudi Arabia, for example, the state was on the brink of bankruptcy. There was a time when there were vigorous attempts to spread corruption in the country through princes who did not realize the dangers of their interference in people's private and public affairs.

Rather, external conspiracies were plotted to divide the kingdom. This is no longer a secret. However, all of them were thwarted by the reformist steps pioneered by King Salman and his directives to Crown Prince Mohammed bin Salman, who was distinguished by firmness and rigor in implementation. The "Ritz Riyadh" operation was a blow not only to the corrupt among the public, but also for the princes who thought they were outside the circle of accountability.

US reiterates call for de-escalation

Israelis demolish attacker's home

JERUSALEM, June 22, (Agencies): Israeli troops on Thursday demolished the home of a Palestinian who is suspected of killing an Israeli soldier last year, in the latest military operation in the increasingly volatile occupied West Bank,

which has been gripped by surging violence. The demolition came during a week of rising tensions and unrelenting violence in the West Bank and just hours after Israel carried out a rare airstrike that killed three Palestinian militants near the city of Jenin and Israeli settlers attacked Palestinian villages in retaliation for the killing of four Is-

raelis a day earlier. A daylong Israeli military raid on Monday killed seven Palestinians, including two teens, near Jenin, a militant stronghold in the West Bank. A day later, a mass shooting by Palestinian gunmen killed four Israelis, including a 17-yearold boy. On Wednesday, hundreds of Israeli settlers stormed into a Palestinian village adjacent to the scene of the shooting and torched homes and cars.

The army said late Wednesday it had "identified a terrorist cell inside a suspicious vehicle" that was allegedly responsible for recent shooting attacks on Jewish settlements. The Palestinian Islamic Jihad militant group on Thursday claimed the three men killed in the drone strike were its members and vowed to carry out more attacks in revenge.

Meanwhile, the US Department of State reaffirmed resolve to continue to work with the Israelis and Palestinians to promote steps towards de-escalation of the conflict. Assistant Secretary of State for Near Eastern Barbara A.

Leaf is in the region now continuing to be "directly engaged with the parties on efforts to restore calm," said Vedant Patel - the Principal Deputy Spokesperson of the State Dept, in a press briefing on Wednesday. "This is, of course, something the Secretary (Antony J.

Blinken) and others across the Department are deeply engaged with as well," Patel noted.

"And we remain steadfast in our work to promote de-es-

calation and even beyond this environment, which vou've heard me say before, and where Israelis and Palestinians are afforded equal measures of security, peace, and prosperity.

We take steps through dialog, through our engagement in the region, through raising this directly with Israeli officials as well as officials in the Palestinian Authority. "We've been very clear that any kind of activity or actions

that will incite tensions will take us away from our ultimate goal of a negotiated two state solution," he added. It was the first Israeli airstrike in the West Bank in nearly

two decades and marked a significant escalation of Israel's more than year-long crackdown on Palestinian militants in the occupied territory. Early Thursday, the Israeli army released a video showing

troops carrying out the controlled demolition of the suspected gunman's apartment. The military reported that troops came under attack during the operation in the city of Nablus, but no injuries were reported. The house belonged to Kamal Jouri, one of two Palestinians suspected of killing Staff Sgt. Ido Baruch in a drive-by

shooting in the northern West Bank in October. He and a second suspect were arrested by the military in February, and the army demolished the second suspect's home earlier this month. A Palestinian militant group called the Den of Lions claimed the attack.

Israel says that demolishing the homes of Palestinian attackers serves as a deterrent, while critics say the tactic amounts to collective punishment.

Mayor Lafi Adeeb said some 30 houses and 60 cars were partly or totally burned. At least eight Palestinians were hurt during clashes, which the army tried to disperse by firing rubber bullets and tear gas.

Palestinian medical officials said one man - identified as 27-year-old Omar Qatin - was killed by army fire. Residents said Qatin was a father of two small children and worked as an electrician for the local municipality.



Cooperation or competition?

China industry sees US, not AI, as bigger threat

Tech innovation has become the main battlefield of international geopolitics.

A fter years of breakneck growth, China's security and surveillance industry is now focused on shoring up its vulnerabilities to the United States and other outside actors, worried about risks posed by hackers, advances in artificial intelligence and pressure from rival governments.

The renewed emphasis on self-reliance, combating fraud and hardening systems against hacking was on display at the recent Security China exhibition in Beijing, illustrating just how difficult it will be to get Beijing and Washington to cooperate even as researchers warn that humankind faces common risks from AI. The show took place just days after China's ruling Communist Party warned officials of the risks posed by artificial intelligence.

Looming over the four-day meet: China's biggest geopolitical rival, the United States. American-developed AI chatbot ChatGPT was a frequent topic of conversation, as were U.S. efforts to choke off China's access to cutting-edge technology.

"This new technology contains a great potential danger," said Fan Weicheng, Director of Tsinghua University's Center for Public Safety Research. He clicked through a presentation featuring an AIgenerated figure of Barack Obama speaking, illustrating the risks of deceptive images and video that can now be digitally created.

"The United States has a 21st century national security strategy. Russia has a national security strategy. Germany has a strategy. So does Japan," Fan said. "We in China are also working on this."

chinese academics, Fan says, are working on an "early warning system" to identify and manage potentially disruptive technology, creating indexes and formulas to measure the impact emerging technology could have on China's national security.

In the past decade, China's AI technology has made rapid advances, fueled in part through cooperation with American research institutes and tech firms. As in the U.S., Chinese leaders are worried about advances in artificial intelligence

But there's an additional challenge. As geopolitical tensions have reached a fever pitch in recent years, Washington has moved to cut China's access to American technology - pushing Chinese tech firms towards self-reliance.

Remarks from a meeting chaired by Chinese leader Xi Jinping last month urged a renewed focus on potential risks from new technologies.

"The complexity and severity of national security problems faced by our country have increased dramatically," said a readout of the meeting by the official Xinhua news agency. "We must be prepared for worstcase and extreme scenarios."

China needs to develop locallymade products and become selfreliant, while keeping an eye on new developments coming out of the West, exhibition-goers said.

"It's the AI era. The future has arrived," said Liu Caixia, a director at a Chinese policing research institute. "Those in the academic community are feeling fear."

"We've seen in some sci-fi blockbusters, there's only intelligent machines left in the world, and human beings are kept like pets," said Liu. "What kind of attitude should we adopt to deal with it?"

Liu's answer was clear and in line with China's determination to lead in cutting edge technologies: Push forward, and deploy AI in new fields.

But it also reflects a contradiction between China's technology ambitions and deepening concerns about the possible social and political risks of such technologies. China's tech firms have approached chatbots like ChatGPT with caution, for example, because of heavy censorship, having AI generate politically sensitive content is a no-go.

But ChatGPT begs the question:

Should China rush to embrace AI and possibly fall prey to its pitfalls, or tiptoe cautiously and risk falling behind the United States?

Across the Pacific, American tech executives and policymakers are grappling with the same questions. Waves of U.S. sanctions have targeted Chinese chipmakers and AI companies to restrict Beijing's access to cutting-edge technology. Politicians worry about China's growing prominence in the field.

With Sino-U.S. frictions at a boiling point, Secretary of State Antony Blinken visited Beijing this week to stabilize ties, seeking to assure Chinese counterparts that Washington was not looking to decouple from China - only "de-risk and diversify."

Though both sides declared the trip a success, Beijing expressed frustration with U.S. sanctions, with China's top foreign affairs official Wang Yi demanding the U.S. "abandon suppression of China's technological development."

Some experts believe cooperation, not conflict, is necessary to confront what they see as a threat to all humanity. Earlier this month, OpenAI CEO Sam Altman dialed into a conference hosted by the Beijing Academy of Artificial Intelligence to encourage collaboration between Chinese and American researchers to mitigate the risks of AI.

"The stakes for international cooperation have never been higher," Altman said, noting that China was home to some of the world's top AI researchers. "We must manage the risk together."

Such concerns were mirrored at the conference in China, where executives expressed concern about the potential for AI-generated voice and imagery to be used in fraud, hacking, and disinformation campaigns.

campaigns.

"The potential for fraud is very high," said Li Congting, chief Al scientist at video surveillance manufacturer Uniview. "Many people have already played around with ChatGPT. Everyone thinks its ability to interact is really good, like there's a real person behind it."

Scientists and tech industry leaders in the U.S., including high-level executives at Microsoft and Google, recently warned about the potential perils of artificial intelligence.

Many Chinese researchers echoed

Many Chinese researchers echoed those concerns. But at the Beijing expo, there was little talk of cooperation with the United States.

"Tech innovation has become the

main battlefield of international geopolitics," said Gao Lei, a top official at a state-run enterprise managed by China's Ministry of Public Security. The US has "escalated its suppression" of China's tech industry, Gao said, saying it was "imperative" to replace American technology with local computer chips.

Though both countries grapple with concerns about AI, stark differences in their approaches to the technology make cooperation difficult.

China has built one of the most intrusive digital surveillance systems in the world, blanketing city streets and rural villages with cameras and tracking citizens through chat apps and mobile phones.

chat apps and mobile phones.

The U.S. government has sanctioned many Chinese tech companies for their role in Beijing's high-tech crackdown in China's far west Xinjiang region, where digital technology was used to flag ethnic minorities for arrest on often spurious grounds.

Many of the companies at the expo had been sanctioned, including telecoms giant Huawei, cameramaker Hikvision and surveillance specialist Meiya Pico. A representative for Meiya Pico declined an interview with The AP, citing a blanket ban on speaking with foreign media.

Use of policing technology in the U.S. is constrained by civil society and legal challenges. But that has not prevented many from deploying questionable privacy-infringing tech including facial recognition and predictive policing, feeding charges of hypocrisy and fueling suspicions in China that U.S. sanctions are politically motivated.

Meanwhile, Chinese companies are continuing to deploy technology in ways that Western lawmakers find concerning.

At the conference, one China Mobile researcher discussed drones his company was providing to the Hong Kong police. They were used to monitor protesters during 2019

Confidence plunges, says business group

Foreign companies shifting investment out of China

There's no expectation that the regulatory environment is really going to improve over the next five years.

Poreign companies are shifting investments and their Asian headquarters out of China as confidence plunges following the expansion of an anti-spying law and other challenges, a business group said Wednesday.

The report by the European Union Chamber of Commerce in China adds is one of many signs of growing pessimism despite the ruling Communist Party's efforts to revive interest in the world's No. 2 economy following the end of antivirus controls.

Companies are uneasy about security controls, government protection of their Chinese rivals and a lack of action on reform promises, according to the European Cham-

ber. They also are being squeezed by slowing Chinese economic growth and rising costs.

Business confidence in China is "pretty much the lowest we have on record," the European Chamber president, Jens Eskelund, told reporters ahead of the report's release.

"There's no expectation that the regulatory environment is really going to improve over the next five years," Eskelund said.

President Xi Jinping's government, trying to shore up economic growth that sank to 3% last year, is trying to encourage foreign companies to invest and bring in technology. But they are uneasy about security rules and plans to create competitors to global suppli-

ers of computer chips, commercial jetliners and other technology. That often involves subsidies and market barriers that Washington and the European Union say violate Beijing's free-trade commitments.

Two-thirds of the 570 companies that responded to the European Chamber's survey said doing business in China has become more difficult, up from less than half before the pandemic. Three out of five said the business environment is "more political," up from half the previous year.

Companies are on edge after police raided offices of two consultancies, Bain & Co. and Capvision, and a due diligence firm, Mintz Group, without public explanation. Authori-

ties say companies are obliged to obey the law but have given no indication of possible violations.

Companies also are uneasy about Beijing's promotion of national self-reliance. Xi's government is pressing manufacturers, hospitals and others to use Chinese suppliers even if that raises their costs. Foreign companies worry they might be shut out of their markets.

out of their markets.

Last month, the government banned using products from the biggest U.S. maker of memory chips, Micron Technology Inc., in computers that handle sensitive information. It said Micron had unspecified security flaws but gave no explanation.

One in 10 companies in the

European Chamber survey said they have shifted investments out of China. Another 1 in 5 are delaying or considering shifting investments. In aviation and aerospace, 1 in 5 companies plan no future investment in China.

China has long been a top investment destination due to its huge and growing consumer market, but companies complain about market access restrictions, pressure to hand over technology and other irritants. The ruling party has tightened control since Xi took power in 2012, pressing foreign companies to give the party board seats and a direct say in hiring and other decisions.

anti-government protests, the researcher said. Advances in 5G telecommunications technology mean officers no longer need to pilot the drones in the field, but can do so from the comfort of their offices.

"With the click of a mouse, they can get drone footage from the field sent to their computer," said the researcher, Su Yu. "This improves efficiency."

With tensions at an all-time high, experts say, it's an open question whether the two countries can find a way to work together.

"How do the U.S. and China coexist with such fundamentally different norms around the use of technology and society?" said Samm Sacks, a senior fellow at Yale Law School studying Chinese tech policy. "We have to find a way forward. Politically, it is not going to be easy to do.'

The European Chamber noted it wasn't just foreign companies that are moving: 2 out of 5 in its survey reported Chinese customers or suppliers are shifting investments out of the country.

A separate group, the British Chamber of Commerce in China, said last month its members were waiting for "greater clarity" about anti-spying, data security and other rules before making new investments.

The biggest concern is the ruling party's sweeping expansion of its definition of national security to include the economy, food, energy and politics, Eskelund said.

"What does qualify as a state secret? Where does politics begin and the commercial world stop?" Eskelund said. That "creates uncertainty" about "where we can operate as normal businesses.

In the European Chamber survey, the top destination for companies moving their Asian headquarters out of China was Singapore, with 43% of companies that moved, followed by Malaysia. Only 9% went or plan to go to Hong Kong.

Leaders including Premier Li Qiang, China's top economic official, have promised to improve operating conditions, but businesses say they see few

concrete changes. "Our members are not really convinced that we are going to see tangible results," Eskelund said. (AP)

Neutral labs to monitor asphalt factories

Road maintenance projects to begin in August: MPW

KUWAIT CITY, June 22: In preparation for the launching of road repair projects and contracting with international companies, the Ministry of Public Works has approved the new mechanism for neutral laboratories to monitor asphalt factories as the road maintenance contracts with international companies will start in early August, reports Al-Qabas daily quoting sources.

Sources disclosed the mechanism includes checking the quality and validity of tests without the intervention of a consultant or contractor. It also prevents conflicts of interest, because the results of the contractor's laboratory tests are for his use only in order to control the quality of his work; such that the ministry and the consultant cannot rely on the results of such tests.

Sources affirmed that the on-site laboratories will be neutral and they have ISO certificates. These laboratories will play the role of conformity assessment bodies as a third party to monitor the results of on-site tests on mixtures, asphalt layers and components of the mulching process during the implementation of the projects, sources explained.

Sources said the new mechanism is one of the recommendations of the previous technical committees, including the need to follow up projects without the interference of contractors or consultants. Sources added the neutral laboratories are obliged to upload the results of tests on the ministry's website upon completion to serve as a guide in the implementation of projects. Once the results are uploaded on the website, the information will be available to project officials, supervisors, contractors, consultants, quality controllers and experts,

Inspection visits Sources revealed there will be regular inspection visits to ensure strict compliance with the regulations. In case a laboratory violates the regulations; its accreditation will be suspended, sources warned

Sources added the Government Center for Testlaboratories, and the accreditation of the third labo-

In addition, the number of international companies that purchased bidding documents has reached

Equality eyed in public sector

Panel holds talks on legislative priorities

KUWAIT CITY, June 22: The Parliament-Government Coordinating Committee held its first meeting at the National Assembly building on Thursday.

Present at the meeting were MPs Hassan Jowhar, Abdullah Fehad, Adel Al-Damkhi, Fahd Falah Bin Jame'e, Fahd Al-Masoud, Meteb Al-Ra'athan, Abdullah Al-Anbaie, Soud Al-Asfour and Osama Al-Shaheen; while the government side consisted of Deputy Prime Minister, Minister of State for National Assembly and Cabinet Affairs Essa Al-Kandari; Deputy Prime Minister, Minister of Oil and Minister of State for Financial Affairs and Investment Saad Al-Barrak; Minister of Justice and State Minister for Housing Affairs Faleh Al-Raqaba; and Minister of Social Affairs and State Minister for Family and Children Affairs Sheikh Feras Al-Sabah.

They discussed the legislative priorities for the first year of the 17th parliamentary term, which in-

Earlier, during its inaugural session, the Assembly approved the proposal to extend the first parliamentary round until the ratification of priority bills; that is, before the parliamentary summer break.

Meanwhile, MP Jenan Bu Shehri called on HH the Prime Minister Sheikh Ahmad Nawaf Al-Ahmad Al-Sabah to instruct the concerned minister to speed up the issuance of the executive regulations for the Conflict of Interests Law. She pointed out that the nullified Parliament ratified the law, which was published in Kuwait Gazette in January 2023. She cited Article 20 of the law, stating the executive regulations must be issued within three moths of publication. She highlighted the fact that the government, represented by HH the Prime Minister, sent a letter to the nullified Parliament to expedite the ratification of the law. Thus, she finds it strange that the government delayed the issuance of the executive regulations for six months and it could be delayed further. She then stressed the need to implement the law in order to expand the authority of Kuwait Anti-Corruption Authority (Nazaha) to cover the categories stipulated therein, such as the ministers and lawmakers.

MP Fayez Al-Jomhour submitted a bill on amending the first clause of Article One of Premarital Medical Checkup Law number 31/2008. The bill obliges couples planning to get married to obtain a medical certificate, proving they are free of infectious and genetic diseases, as well as drugs and intoxicants.

MPs Osama Al-Zaid, Ahmed Lari and Hamad Al-Medlej have proposed amending Article Two of Retirees Health Insurance Law number 114/2014. The bill is aimed at adding beneficiaries of the insurance like the Kuwaiti widows, divorcees and

KUWAIT CITY, June 22: Few days after the government took the oath before His Highness the Deputy Amir and Crown Prince Sheikh Mishaal Al-Ahmad, the concerned state authorities identified the most important priorities on the "research and approval agenda", including the strategic alternative to salaries, reports Al-Qabas daily.

In confirmation of the article titled "The Strategic Alternative to Salaries in the Final Touches" published by the daily on April 20, a government source revealed that the Civil Service Council had completed a study on the strategic alternative to salaries and submitted it to the Economic Committee of the Council of Min-

The source explained that the cost of the strategic alternative is close to one billion dinars annually, representing about 15 percent of the total allocations for the first chapter of the state budget.

The strategic alternative to salaries aims at achieving justice among all job specializations in all government agencies, as well as equality between those with

the same specialty in each agency. Regarding the salary increase mechanism and its rate, the source explained that an initial vision was set for the increase in the basic salary to be between 50 percent and 70 percent, according to unified standards for all Kuwaiti employees in the state agencies.

The strategic alternative will be applied to current and new employees. More than 320,000 employees will benefit from it. Its implementation mechanism

will include supporting employment at the same level. The strategic alternative will include employees of a general cadre according to the basic salary, and will

not include those of special cadres. The source indicated that this matter will be a top priority for the new government.

He affirmed that the study carried out by the Civil Service Council showed that the strategic alternative would transform the public service system from the traditional system of seniority into a merit-based system linked to years of professional experience, functional competence and ability to achieve.

The source noted that the strategic alternative to salaries will restore job groups and gradation with every job title in all jobs in the country, adding that a mechanism will be determined to amend or approve it as it is. He stressed that the most prominent aspect of the strategic alternative is that the potential increase will

The source explained that this mechanism is not just a financial increase in the salaries of employees, but rather an entry point for restoring job groups and grading with each job title in all jobs in the country.

be unified for all workers in the state agencies.

The strategic alternative aims at the salary due in exchange for all the tasks and responsibilities associated with a specific job title and to transfer the general position system and the salary system from the traditional seniority system to the merit-based system in order to develop the performance of workers in the state agencies, achieve a boom in productivity, motivate national cadres to exert more efforts and acquire the necessary skills to raise the level of government

Curse of the land of pure

In 1947, Britian decided to end its occupation of India. Britain approved the request of Muslim leaders, headed by Muhammad Ali Jinnah, to have their own State, so Pakistan or the land of pure was established in August 1947.

The insistence of founders to es-tablish their own country on ideological foundations cost the people billions; in addition to the loss of properties, lives and memories as a result of the biggest and unprecedented displacement

modern age against millions of individuals from India to Pakistan and vice versa. The process was aimed at fulfilling the dream of Muslims to live in peace.

Nevertheless, this aim was proved false later as the western part of Pakistan persecuted the eastern part to end with separation, creating a new State - Bangladesh. Both parties sharing one religion did not prevent one of them to exploit and massacre the weaker one.

Pakistan was established in a chaotic situation, which continues till date. Relations between Pakistan and its giant neighbor - India - have not been settled. This prompted Pakistan to exhaust its limited resources to procure armament and nuclear bomb. Thus, Pakistan was involved in several wars, which have had miserable consequences. Kashmir is still bleeding. Perhaps, it will do so forever.

Pakistan has not enjoyed peace and stability since its independence 75 years ago. A total of 28 leaders ruled Pakistan. Only a few of them have not been subjected to humiliation, accusation, imprisonment, exile and even murder. These situations reflected on the economic conditions, making Pakistan totally dependent on foreign aid.

Moreover, Pakistan has become a source of religious extremism, a refuge for Taliban gangs and a safe haven for whoever escapes from international justice. My colleague, Muhammad Al-Rumai-

hi, inquired about the reasons behind the survival of India; enjoying political stabil-

ity in spite of the similarity of its social fabric with that of Pakistan. Then, he said India enjoys multiple religions, ethnicity, languages, social sects and classes. He pointed out that such a case required India to have a modern social declaration through the Constitution, which organized relations and saved India from civil wars despite the deep differences among components of the Indian society. He added that the role of the Army was under control from the beginning, unlike the case of Pakistan where the military figures interfered in politics under the pretext of protecting it from the enemies. This led to rejecting democracy and adopting sucessive dictatorial military regimes.

The worst crisis happened in 1977 when Muhammad Zia-ul-Haq came to power and imposed Islamization to step over democracy. He supported Afghanistan in its war against the then Soviet Union for some aid provided by the USA. He died in a plane crash later.

Then, the era of former cricket player Imran Khan came marked by extremist Islamic symptoms, starting from his home and spreading all over Pakistan. He did not study the lesson from his predecessors.

According to Al-Rumaihi, these factors rendered Pakistan incapable of living away from problems. The disputes among extremist religious parties, tribes and the Army and the dispute with India over Kashmir, prevented stability and encouraged corrupt governments to take advantage of the national wealth at the expense of citizens.

Apparently, the backbreaking battle will continue for long. Moreover, states established based on certain ideologies often fail. Pakistan needs to be a normal State like many other countries.

To some extent, Bangladesh did so, as it has become more stable and richer than Pakistan, which comes second after Afghanistan in terms of illiteracy among South Asian countries. Pakistani exports are almost zero, compared to those of India. Pakistan is not a touristic destination for any country. Perhaps, the independence from India was a great affliction for Pakistan. To prove this point, compare the average standard of living of Indian Muslims with that of the Pakistanis.

Arab information ministers gather in Morocco to discuss cooperation

RABAT, June 22, (KUNA): Undersecretary of Kuwait's Ministry of Information Dr. Nasser Al-Mheisen said Wednesday his country was keen on promoting the media role in preserving the national identity and combating the trans-border extremist ideology.

"Media plays a key role in protecting the young generation against extremism, and promoting the values of tolerance and coexistence among members of the community," he said in a speech to the 53rd ordinary session of the Arab Information Ministers' Council being hosted by Morocco.

He called the Arab media organizations to keep abreast with the latest developments of information technology.

Growing impact

Noting that social media networks have a growing impact on the various segments of the community, Dr. Al-Mheisen urged rational manipulation of these networks so as to serve the interests of individuals and communities

He added that sound use of artificial intelligence could also serve the noble objectives of media amid accelerated changes and transformations worldwide.

"The State of Kuwait back every effort to modernize the Arab media," Al-Mheisen said, noting that Kuwait sponsored the seventh session of the Arab award for excellence in environment media themed "climate change and the future."

These initiatives, which include a

"joint platform" linking information ministries across the region, form a "comprehensive strategy" that seeks to usher in greater cooperation in field of media, said the Cairo-based Arab League's media department chief Ahmed Khatabi.

Unified strategy

Arab information ministers had recently given the thumbs up to a "unified strategy" to regulate social media outlets and media platforms across the region, according to Karam Jabar, who serves as Egypt's chief media organizer.

The ministers are meeting in the Moroccan capital to discuss how far progress has come on a plan to build a media "roadmap" towards sustainable development goals.

The Arab Information Ministers' Council adopted a number of resolutions, including one to continue support for Palestine question, at the core of which is the status of the occupied city of Jerusalem.

Concluding its 53rd ordinary session in Marrakesh, Morocco, on Wednesday, the Council endorsed all draft resolutions relating to media support to the Palestinian people and to the efforts meant to preserve the legal, historical and spiritual status of the holy city of Jerusalem.

The Council mandated its

The Council mandated its Secretariat to follow up the implementation of the integrated observatory and portal project as a means of Arab media leverage overseas.

The Secretariat is also tasked with overseeing the launching of the single website of the Arab electronic media, proposed by Watani Al-Emarat Foundation, of the UAE.

The Council approved a resolution on the Arab media roadmap for sustainable development 2030, including the executive procedures and single strategy for dealing with international media corporations.

It also approved a recommendation to name Kuwait City as Arab Media Capital 2025 and appreciate Kuwait patronage of Arab media award.

The Council session elected the members of the Council's Executive Bureau for the coming two years with Saudi Arabia being the presidency, Egypt - the vice presidency, and Kuwait, Morocco, Bahrain, Libya, Palestine and Algeria serving as members of the Bureau.

Undersecretary of Kuwait's Ministry of Information Dr. Nasser Al-Mheisen attended the session as representative of the Minister of Information.

'Kuwait's 1st Impella 5.5 artificial heart pump implant successful'

KUWAIT CITY, June 22, (KUNA): The Ministry of Health announced the success of artificial heart pump implant, type Impella 5.5, the first of its kind in the country and second in the Arab world.

The surgery was for a patient in his sixties who also had a left ventricular assist device installed. The ministry explained in statement that the patient was overcome with an acute heart attack and taken directly to the chest disease hospital.

He was resuscitated for about 50 minutes, and had to undergo necessary procedures of cardiac catheterization and installation of five stents in the arteries.

The patient was then put on ECMO, an artificial life support device to help his lungs function properly, until his condition stabilized. The team at the Amiri hospital took up the case later on to follow up ensure smooth recovery



by members of the ruling families on people, public affairs, or public funds. This is because the state has honored them, and they are no longer in need.

In all these houses, we have neither heard of corruption nor have there been any law-suits or trials against their members due to preservation of their prestige. This can only be achieved through self-sufficiency in order for the children of these families to devote themselves to public philanthropic work, and to foster and cement good relations with the people.

Undoubtedly, Arab experiences represented a harsh lesson in preserving the stability of ruling houses as the compass for the stability of the state.

Following the monarchy era, Egypt suffered a lot. Also, Iraq witnessed bloodbaths, and is probably paying the price even today. The same is the case in Libya after Senussi and Yemen after the Imamate monarchy. Tunisia was much better during the rule of the Bey than today.

Here it must be emphasized that the members of ruling houses are symbols that must be given their due, and given full care because any danger to them is a threat to the state as a whole.

Therefore, after this new development and reconciliation today, it is necessary to reconsider the past stage and the bitter experiences that it left behind, and learn from them because the press will not be responsible for any error published, and the blame will not be directed at the parliamentarians, or even the ministers, despite their responsibility. Rather, it is directed at the premiership and the ruling family.

Hence, it is crucial to act according to the golden rule - "If he says he does" - given that the premiership is the front for the state and the one concerned with preserving it.

The question that preoccupies many Kuwaitis is - Will the reign of His Highness Sheikh Nawaf Al-Ahmad and his deputy His Highness Crown Prince Sheikh Mishaal Al-Ahmad represent a redevelopment of the role of the ruling family, re-calibrate its relationship with the homeland, and follow its rituals to prepare a generation that has the capabilities to practice governance and confrontation, manage sovereign ministries, and maintain a good image in governance? Of course, this is not much. Everything is possible if there is a will.

The trains whip through the arid landscape at top speeds of 300 km/h (186 mph), carrying pilgrims in air-conditioned comfort from Jeddah to Makkah. But they stop several kilometers away from the Grand Mosque, meaning pilgrims must either walk at least an hour or take a bus or car to the holy site. The \$19 one-way price from Jeddah's airport to Makkah may also be out of reach for pilgrims on lower incomes.

The Hajj is one of the five pillars of Islam, and all Muslims who are able to are required to undertake it at least once in their lives. For pilgrims, retracing the footsteps of the Prophet Muhammad (PBUH) is a profound religious experience that wipes away sins, deepens one's faith and unifies Muslims the world over.

'Hope for wise and informed gov't that work to end corruption'

"AS Kuwaitis, we renew our hope at the beginning of each term of the National Assembly! We all find ourselves facing the broad and recurring question: Will we overcome the stumble, confusion and tension in parliamentary work and governmental path? The disease in all of this is the loss of rationality and practical harmonization in parliamentary practice, as it has been mere reaction and passion. Perhaps, this is the demagoguery of the masses and the state of denial and revenge that control the parliamentary behavior of the members," columnist Dr Mohammad Al-Maqati wrote for Al-Jarida daily.

"Without introductions or justifications, and without taking into account the balanced or appropriate political considerations, the parliamentary impulsiveness jumps to the highest levels -- legislatively to 'achieve' embarrassment for the government in terms of legislation that needs delay and deliberation due to its importance, or in terms of security and sovereign sensitivity, and at other times, a frantic race among members. The main concern is to obtain a legislative precedent over their colleagues. Sometimes, they need to keep up with the escalation of the masses, in addition to the unstable demagoguery that makes parliamentarians lose their political sense and wisdom in making legislation.

"The result is the country being afflicted with an ill-advised legislative impulse dominated by the stereotypical improvisation in the enactment of legislation. This is the worst example of legislation that parliaments can put in place in any country and at any time. It exceeds the legislative limits drawn by the Assembly. Worst, there is a race to drain the country's wealth and capabilities. This indicates that the legislator is just a passerby who settles in the State to take whatever can be taken or divided, and flee to another country. He then settles there, without caring for the development and sustainability of the country, as well as the needs of its people and the successive generations!

"The supervisory path that the legislature is toeing does not differ from the previous course, as it is also governed by impulsiveness, excitement, competition, an attempt to tickle the masses and respond to demagoguery among them, far from the desired parliamentary wisdom and rationality. Good governance and administration are essential components of responsible and rational parliamentary practice.

"Is it reasonable for the members to ask dozens of questions daily, on topics that have nothing to do with the parliamentary course, going beyond its borders and invading fields and areas that are within the reach of the Parliament and its competence? Parliamentary investigations follow useless committees, without any benefit other than showcasing the power and tickling the feelings of the masses without parliamentary prudence.

"It is the speed generated by reaction, emotion and impulsiveness in submitting interpellations to prove their existence, get the attention of the masses and obtain electoral gain without care and deliberation to avoid aggravation. Collision ultimately causes losses for the country. It could have been avoided through wisdom and farsightedness in parliamentary alignment and prudence which, if missed by the questioned member, must not be missed by majority of the members and the leader!

"The legislative term started after the dire repercussions we witnessed in the past as a result of impulsiveness, excitement and parliamentary racing, far from wisdom and political correctness. Perhaps, all these are present today in order to avoid the recurrence of distraction and instability, which negatively affected the Kuwaiti parliamentary practice and

"Finally, we are hoping to find a truly wise and informed government that will lead the country with developmental, legislative and corrective initiatives to end corruption and sluggishness in governmental work and get out of the state of dormancy, negativity and inadequacy with a strong and practical presence based on the institutional and systematic political program, as was the case in 2022... We are waiting.

"Not everyone who rants about patriotism is patriotic in the truest sense of the word. Instead, those who know the people credited for establishing the homeland at a time there were no 'drawings' by those who claimed artificial patriotism are aware that the people of Kuwait are honest and transparent. Civilization needs stability as its pillar, so they are the makers of civilization. This is a linguistic and idiomatic concept. The first people of Kuwait settled on its coasts and made their prosperous civilization," columnist Dr Saud Mohammad Al-Asfoor wrote for Al-Qabas

"The two main jobs of the people of Kuwait prior to the discovery of oil were pearl diving and sailing. Kuwaitis depended on them as the main sources of income, in addition to other jobs such as fishing, carpentry, blacksmithing, making nets and fishing tools, and agriculture. Their settlement added originality and distinction to the history of Kuwait.

"Whoever was naturalized recently might have missed this fact, or he may know it but deliberately ignores it, because his father and grandfathers did not know about the sea, its supplies and accessories. Therefore, you find him talking about the history of the homeland, focusing on the political and military aspects only. He talks about the emergence of Kuwait, succession of rulers and battles as well as the victorious and the loser. He does not address other aspects of civilization. Most probably, he does not know the customs of the people of Kuwait, details of their celebrations, their offices, famous councils, the popular games they used to play and their famous cuisines that he never tasted, or if he tasted them, he does not know their names and the ingredients.

"Even from an economic point of view, he may not know the details of the marine activity, such as the ships, their owners, names and famous makers, their captains and the men on board, the crafts that were based on this activity, the marine terms that created many Kuwaiti proverbs, details of pearl diving trips, sailing and imported goods.

"Perhaps, he does not know the beginnings of education in Kuwait and its men, and those who occupied academic positions from beginning to end. He does not know the beginnings of the literary movement, the writers and what they wrote as a cultural legacy for generations. He does not know the cultural activities that schools organized and the services that the Ministry of Education provided to its students like food, clothing, transportation and healthcare.

"Perhaps, he does not know the history of the mosques, names of famous old personalities who established them, who undertook the rhetoric, the imams among the righteous sheikhs and sermons during religious celebrations.

"This is the tip of the iceberg, exposed to those who know the old regions of Kuwait – Jableh, Al-Wasat, Al-Mirqab and their neighborhoods, the near and far suburbs, what is in Al-Jahra, Al-Mangaf, Al-Ras, Abu Halifa and Al-Fintas and other farms frequented by the people of Kuwait and were part of their tourist areas.

"Indeed, patriotism has its foundations. If the foundations were not lost in the minds of those who claim to be patriotic among those naturalized recently, they would realize their shortcomings and urgent need to know more about the details. They link the present with the distant past. They should know the virtuous among the people who excelled throughout the

"Fusion of the newly naturalized with the old is necessary, in addition to authenticity in a harmonious society, in which each individual knows the rights of others in terms of merit and advancement, especially since the early founders were the builders and protectors of the homeland. They distributed the income between them and the newly naturalized with open arms and kindness. Their virtues should not be denied. They never played the strings of tribalism, sectarianism, partisanship, familial, regionalism and others, because all these lead to division and fragmentation.

"Al-Rai daily gave us a dangerous piece of news entitled, 'Kuwait Index in Anti-Money Laundering is in Danger'. It seems that we did not move a finger towards improving our classification in Anti-Money Laundering. We may be unaware of the importance of this indicator and combating money laundering,"columnist Assrar Johar Hayat wrote for Al-Qabas daily.

"First of all, we must be aware that all these international indicators are important, especially for a country that has a vision to transform into a financial and economic center. The anti-money laundering rating and other indicators affect Kuwait's credit rating in one way or another. More importantly, these indicators are closely linked with Kuwait's international reputation. How can we transform into a financial center that attracts foreign investment if our reputation in combating corruption or money laundering is 'bad'?!

"It is painful for me to say that we are lax, whether we are aware of it or not. Since the money laundering 'outbreak' about two and a half years ago, events have revealed loopholes in the laws, paving way for money laundering. This then leads to impunity.

'The questions are: If realized this shortcoming and we read about it in the newspapers, what happened from that day until now?! Have the legal loopholes been closed? Has a new law been enacted to control the violators and those wishing to turn Kuwait into an arena for money laundering, illegal trade, drug trade, organ sales and other suspicious sources of funds?! Or were we in conflict? Did the government attend the National Assembly session or not? Is the session held or not?

"These events distracted us from disrupting parliamentary life, obstructing the adoption of important laws and tightening the law's grip on

"Here, the blame does not rest solely on what and who caused the disruption of political life in Kuwait. The most important questions are: Where is the role of the Financial Investigation Unit? Did it limit its role to referring files of money laundering suspicions?! Is it not supposed to submit a proposal to address the legal loopholes, so the money launderers do not get away with their action?!

'Amend the law and address the loopholes that make money laundering criminals escape easily. Every step, apart from that, is like indirectly saying to the owners of suspicious money: 'Goodbye... they laundered your money with us.

Entities affirm completion of Hajj season preparations

KUWAIT CITY, June 22: The Minister of Finance and Minister of State for Economic Affairs and Investment Manaf Al-Hajri issued a decision to amend article No. 2 of the ministerial Resolution No. 40/2016 regarding the regulation of the allowance for usufruct of the state's private real estate property and service fees for chalets, reports Al-Rai daily.

The new Decision No. 39/2023, included amendments to the Decision No. 109/2022 of the former minister of Finance Abdul Wahhab Al-Rasheed, which was issued on December 13 last year and published in the official gazette on December 18, as Al-Hajri's decision reduced fees for four services.

The decision introduced three items related to the heirs, as it stipulated that the request to transfer the chalet to the heirs, for chalets and plots of land (first or second line), should be free of charge within three years from the date of issuance of the first license for the heirs.

While the decision exempted the heirs from paying any fee when requesting exit from chalets and plots of land (first line within three years from the date of issuance of the first license for the heirs), a fee of KD 3,000 per linear meter of the waterfront was specified when requesting exit after three years have passed from the date of issuance of the first license to the heirs.

As for the heirs' request for their exit from the chalets and plots of land - second line, the decision stipulated that it be free of charge within three years from the date of issuance of the first license for the heirs. It specified a fee of KD 1,500 for the longitudinal meter of the front façade (the side parallel to the sea) when requesting an exit after passing three years from the date of issuance of the first license to the

The decision also introduced a fee for licensing an accommodation space (a chalet only) amounting to KD 300 per application, while keep-

The centers that will operate 24 hours a day in Farwaniya Health Zone are South Firdous, West Farwaniya, Andalus, Rabiya, and Abdullah Al-Mubarak clinics.

As for the centers that will operate from 7:00 am to 12:00 midnight, they are Manahi Al-Osaimi in Khaitan, South Ardiya Clinic, South Jleeb Al-Shuyoukh Clinic, and

Sabah Al-Nasser Clinic.
In Ahmadi Health Zone, West Sabahiya Clinic, Sabah Al-Ahmad Center in Khairan, Khairan Residential Clinic, Wafra Residential Clinic, Wafra Agricultural Clinic, Abdulaziz Al-Rashed Center in Bnaider, Ali Sabah Al-Salem Clinic, Al-Raqqa Clinic, Jaber Al-Ali Clinic, and Fahaheel Clinic will operate around the clock, along with Fintas Specialist, Sabah Al-Ahmad Marine City, and Khairan Coast health centers.

Hajj season: Deputy Director General for Planning and Projects Affairs and official spokesperson of the Directorate General of Civil Aviation (DGCA) Saad Al-Otaibi has affirmed the completion of preparations for the Hajj season, in cooperation with the concerned government agencies; such as the Ministry of Interior, Ministry of Endowments and Islamic Affairs, Kuwait General Administration of Customs (KGAC), Kuwaiti Hajj caravans and companies, aviation and ground service providers, reports Al-Qabas daily.

Al-Otaibi said the first trip to Saudi Arabia for the Hajj season is scheduled for Friday, indicating the pilgrims will be on board five Kuwaiti and Saudi airlines. He disclosed the Kuwait Airways flights will take off from Terminal 4, Jazeera Airways at Terminal 5; while the Saudi, FlyNas and FlyaDeal flights will be at the main passenger Terminal T 1. The DGCA had earlier announced that 75 flights will be operated for the current Hajj season to transport 9,000 pilgrims to the Holy House of God.

Al-Otaibi praised the coordinated efforts of all parties involved in the operational plan for the Hajj season; citing the direct follow up of Public Works Minister Dr Amani Bukmaz and supervision of acting DGCA Director General Imad Al-Jalawi. He wishes for the success of the movement of pilgrims from Kuwait International Airport to King Abdulaziz Airport in Jeddah, Saudi Arabia.

Swiss chank raises key interest rate

Switzerland's central bank raised its key interest rate Thursday as it seeks to combat inflation and said "it cannot be ruled out" that more hikes will be necessary.

Inflation declined significantly to 2.2% in May but is above the target set by the Swiss National Bank, which warned that price pressures persist and would make themselves felt in coming months without action.

It said the decision to hike its key rate by a quarter-percentage point

to 1.75% was "countering inflationary pressure which has increased again over the medium term.'

Central banks around the world have sharply raised interest rates to combat an outbreak of inflation triggered by the rebound from the pandemic, higher energy prices and Russia's invasion of Ukraine.

The Bank of England and Turkey's central bank also are both holding rate meetings Thursday.

Central Bank of Kuwait (CBK) announced Thursday that the broad money supply (M2) went up by 0.3 percent last May to settle at KD 39.6 billion (around USD 130.6

Local banks' private sector deposits increased by 0.6 percent to settle at KD 36.2 billion (around USD 119.4 billion), said the CBK's economic research department in a release to KUNA, including statistical tables.

Private sector deposits in foreign currency dropped by 2.8 percent to reach KD 1.7 billion (around USD 5.5 billion), while total local banks claims on the CBK represented by CBK bonds rose by 6.2 percent, settling at KD 3.4 billion (around USD 11.2 billion).

Total local banks' assets fell by 0.1 percent to record KD 84.9 billion (around USD 280 billion), while the net foreign assets decreased by 0.2 percent to KD 10.4 billion (around USD 34.3 billion).

Meanwhile, time deposits with the CBK settled, in May, at KD 2.6 billion (around USD 8.5 billion), whereas balance of utilized cash credit rose by 0.1 percent to KD 52.2 billion (around USD 172.5 billion).

Average interest rate on one-year treasury bonds settled at 4.5 percent in November, while financing of Kuwaiti imports went up 75.9 percent to reach KD one billion (around USD 1.8 billion), and US Dollar exchange rate against Kuwaiti Dinar rose by 0.1 percent to 306.7 fils.

Claims numbers for past two weeks highest since Oct of 2021

Weekly US applications for unemployment aid remain relatively elevated

WASHINGTON, June 22, (AP): The number of Americans applying for unemployment benefits remained relatively elevated last week, potentially another signal that Federal Reserve rate hikes are beginning to cool a surprisingly resilient labor market.

U.S. applications for jobless claims were 264,000 for the week ending June 17, the same as the previous week's revised number, the Labor Department reported Thursday. That's slightly more than analysts were expecting. The claims numbers for the past two weeks are the highest since October of 2021.

The four-week moving average of claims, which smooths out some of the week-to-week volatility, rose by 8,500 to 255,750. That's the highest level since November of 2021

Jobless claims in the past three weeks have pushed closer to 300,000 after mostly being in the high 100,000 to low 200,000 range for since the fall of 2021. But that's likely not enough for Fed officials, who have said in the past that the unemployment rate needs to rise well past 4% to bring inflation down.

The labor market remains broadly healthy with the U.S. economy adding jobs at a furious pace since more than 20 million jobs vanished when the pandemic struck in the spring of 2020. Americans have enjoyed unusual job security, despite the Federal Reserve's aggressive campaign to cool the economy and labor market in its attempt to extinguish persistent inflation not seen since the early 1980s.

Last week, Fed officials chose not to increase the central bank's benchmark borrowing rate for the first time in 15 months, though some said they expect to add another half-point to rates by the end of the year. Fed Chair Jerome Powell reiterated that likelihood in testimony to Congress on Wednesday.

The rate hikes have slowly helped to suppress inflation, though perhaps not as quickly as intended. The labor market has remained unusually strong throughout

Home sales inch up in May amid record-low inventory

LOS ANGELES, June 22, (AP): Sales of previously occupied U.S. homes edged higher in May and the national median sale price posted its biggest annual drop in more than a decade, even as the supply of available properties sank to an all-time

Existing home sales rose 0.2% last month from April to a seasonally adjusted annual rate of 4.3 million, the National Association of Realtors said Thursday. That's slightly above what economists were expecting, according to FactSet.

Sales sank 20.4% compared with May last year. That marks 10 consecutive months of annual sales declines of 20% or more. The annual drop was steepest

the more than year-long rate hike campaign designed to cool it.

U.S. employers added a surprising 339,000 jobs last month, well above expectations, painting a mostly encouraging picture of the job market, even as the unemployment rate rose to 3.7%. In April, employers posted 10.1 million job openings, up from 9.7 million in March and the most since January. Economists had expected vacancies to decline.

There are other signs that the Fed's policies are taking hold. The U.S. economy grew at a lackluster 1.3% annual rate from January through March as businesses wary of an economic slowdown trimmed their inventories. That's a slight upgrade from its initial growth estimate of 1.1%.

The manufacturing sector has been contracting and three bank failures have

in markets across the West and Northeast, where sales slumped more than 25% The national median home price fell 3.1% from May last year to \$396,100, the NAR said. The year-over-year decline is the biggest since December 2011, when the housing market was still on the mend following the mid-2000s housing bust.

The latest housing market figures are more evidence that even with prices declining after heading higher for more than a decade many house hunters are being held back by a persistently low inventory of homes for sale.

"There's simply not enough inventory," said Lawrence Yun, the NAR's chief

Overall, 1.76 million people were collecting unemployment benefits the week that ended June 10, about 13,000 less than the previous week.

Wall St drifts as cbanks keep up rate hike 'pressure' on inflation

Asian shares mixed after Fed chair inflation comments

NEW YORK, June 22, (AP): Stocks are drifting on Wall Street as central banks cranked up interest rates in their ongoing fight against inflation.

The S&P 500 rose less than 0.1% in afternoon trading Thursday. The majority of stocks in the benchmark index were slipping, but gains from some big technology stocks coun-

tered losses elsewhere. The Dow Jones Industrial Average fell 55 points, or 0.2%, to 33,895 and the Nasdaq rose 0.4% as of 12:14 p.m.

The Bank of England raised its main interest rate by a half a percentage point to a 15-year high of 5%. Banks in Norway, Switzerland and Turkey also raised borrowing rates. The interest rate hikes come a day after Federal Reserve Chair Jerome Powell told Congress that he believes inflation still isn't under control.

The Fed held interest rates steady at its June meeting after raising rates aggressively throughout 2022 and into 2023 to tame inflation that had reached record levels. Inflation has been slowly cooling, but the Fed has signaled that it may have to raise rates two more times this year as it tries to push inflation down to its stated goal of 2%.

Powell appeared before a House of Representatives committee on Wednesday and is appearing before a Senate committee Thursday.

Central banks have been raising interest rates to make borrowing more difficult and slow economic growth in order to stifle inflation. The strategy risks going too far in stalling growth and dragging economies into a recession. Economists and analysts have been warning that the U.S. could slip into a recession before 2023 ends, but resilient consumer spending and a strong jobs market have been bolstering the economy.

High interest rates, though, have slowed other parts of the U.S. economy, particularly the manufacturing and housing sectors, and helped cause three high-profile failures in the U.S. banking system. The banking industry remains under pressure, even after the federal government acted quickly to provide support.

Bond yields rose. The yield on the 10-year Treasury rose to 3.79% from 3.73% late Wednesday.

Benchmarks in Europe fell following the most recent rate increases. Britain's FTSE 100 slipped 0.8%. The latest interest rate increase from the Bank of England was more than analysts had anticipated and marked its 13th rate hike in a row in its effort to combat stubbornly high inflation.

in the U.S. to look forward to for the remainder of the week. The Labor Department reported the number of Americans applying for unemployment benefits remained elevated last week, a possible sign that the Fed's rate hikes are beginning to cool a surprisingly resilient labor market.

Markets have been "taking a little bit of a breather" following a five-week rally, said Chris Zaccarelli, chief investment officer for Independent Advisor Alliance. The big focus in the coming weeks will likely be any economic data, including a big report on inflation next week, that could give investors a better sense of how the Fed will proceed.

"The Fed is pretty close to done, if not done already," he said. "The stock market is in a holding pattern wait ing to see new economic data and the Fed's reaction.'

Several companies made big moves on a mix of news. Spirit Aerosystems, a major supplier to the world's largest aircraft manufacturers, slumped 9.2%. It is suspending operations at a critical Kansas plant after union workers there rejected a proposed four-year contract and authorized a strike.

Office furniture maker Steelcase rose 8.5% after reporting strong financial results.

Europe

Benchmarks in Europe slid in early trading as the central banks of Switzerland and Norway raised their benchmark interest rates to counter inflation, while the Bank of England was expected to do so.

The British central bank is fighting to quash stubbornly high inflation that has failed to retreat from its peak as quickly as expected. The consensus among analysts was that it will raise its main interest rate by a quarter-percentage point - hitting a new 15-year high of 4.75%. But some worried it might opt for a bigger half-point increase, heaping pain on people with loans, especially the 1.4 million or so households in the U.K. that will have to refinance their mortgages over the rest of the year.

France's CAC 40 shed 1.2% in early trading to 7,174.46, while Germany's DAX fell 0.7% to 15,907.25. Britain's FTSE 100 slipped 0.8% to 7,495.94.

Asia

Asian shares were trading mixed Thursday following a retreat on Wall Street after the Federal Reserve chair made comments that indicated inflation still isn't under control.

Japan's benchmark Nikkei 225 fell 0.9% to finish at 33,264.88. Australia's S&P/ASX 200 declined 1.6% to 7,195.50. South Korea's Kospi gained 0.4% to 2,593.70. Trading was closed in Hong Kong and Shanghai for Dragon Boat Festival, a national holiday. Shares fell in India.

The Chinese markets being closed provided a break from jitters about China relationship after President Joe Biden referred to Chinese President Xi Jinping as a dictator. That pushed "back against the idea that the U.S.-China relationship could be warming with Secretary of State Antony Blinken's visit," said Yeap Jun Rong, market analyst at IG.

possible renewed tensions in the U.S.-

During Blinken's Beijing visit earlier this week, both sides agreed to stabilize badly deteriorated ties. But Blinken said China was not ready to resume military-to-military contacts.

Fitch Ratings said in its June Global Economic Outlook that the global growth outlook for next year has deteriorated, given the prospects of higher interest rates around the world.

"Global growth is showing nearterm resilience but with core inflation remaining stubbornly high, central banks will have to continue tightening policy in the coming months," it said.

In energy trading Thursday, benchmark U.S. crude fell 18 cents to \$72.35 a barrel in electronic trading on the New York Mercantile Exchange. Brent crude, the international standard, lost 21 cent to \$76.91 a barrel.

In currency trading, the U.S. dollar edged up to 141.86 Japanese yen from 141.81 yen. The euro cost \$1.0983, little changed from \$1.0990.

Turkey cbank sharply 'hikes' interest rates

ANKARA, Turkey, June 22, (AP): Turkey's central bank delivered a large interest rate hike Thursday, signaling a shift toward more conventional economic policies to counter skyhigh inflation following criticism that President Recep Tayyip Erdogan's approach has made a cost-of-living crisis

The bank raised its key rate by 6.5 percentage points, boosting it to 15%. The increase - a jump from the current 8.5% - is the first since March 2021 but is lower than market expectations.

It came at the bank's closely watched first interest rate-setting meeting since Erdogan appointed two internationally respected officials to lead the bank and the finance ministry. The rate hike is an indication that the country is moving away from Erdogan's unorthodox belief that lowering interest rates fights

Traditional economic theory says just the opposite, and central banks worldwide have rapidly raised rates to combat spikes in consumer prices tied to the rebound from the pandemic and Russia's invasion of Ukraine. There were several hikes across Europe on Thursday, ranging from the Bank of England to the Swiss National Bank.

Erdogan - a self-declared "enemy" of high borrowing costs - has said he would "accept" his new finance minister's policies but also insisted that his views have not changed. That led to questions about whether Turkey's central bank could act independently.

Policy Committee said it had decided to begin "the monetary tightening process in order to establish the disinflation course as soon as possible.' "Monetary tightening will be further

A statement from the bank's Monetary

strengthened as much as needed in a timely and gradual manner until a significant improvement in the inflation outlook is achieved," it said. Hamish Kinnear, senior analyst at

the risk intelligence company Verisk Maplecroft, said increase from 8.5% to 15% "marks a return to more orthodox monetary policymaking."

But it was lower than market expectations of an increase of 17% to 20%,

"This is a sign that the new governor is looking to tread carefully to avoid a clash with President Erdogan," Kinnear said in a note.

Under pressure from Erdogan, the central bank had cut its key interest rate from around 19% in 2021 to 8.5% earlier this year, despite soaring inflation that hit an eye-watering 85% last

Inflation has eased to 39.5% last month, according to official figures, but independent research group ENAG says the true rate is 109%.

Economists say Erdogan's unconventional belief has exacerbated economic turmoil, leading to currency and cost-of-living crises that have brought hardship to many households struggling to afford food, housing and other necessities. Erdogan says his economic model prioritizes growth, exports and employment. Experts also say the central bank has

depleted its foreign currency reserves as it tried to prop up the Turkish lira ahead of elections last month. The currency has lost around 21% of its value against the dollar since the start of the year.

On Thursday, the lira weakened by 3% against the dollar due to the lowerthan-expected rate hike.

Erdogan, who won a third term in a runoff election May 28, reappointed Mehmet Simsek to the helm of the economy. The former Merrill Lynch banker had previously served as Erdogan's finance minister and as a deputy prime minister until 2018.

Simsek said soon after his appointment that Turkey had no other option but to return to a "rational ground."

In another sign of a move toward more pragmatic policies, Erdogan appointed Hafize Gaye Erkan this month as Turkey's first female central bank governor. A former co-chief executive of the now-failed San Francisco-based First Republic Bank, Erkan replaced Sahap Kavcioglu, who oversaw a series of rate cuts.

"For now, Erdogan is happy to cede economic policymaking power to Governor Erkan and the new finance minister, Mehmet Simsek, so that Turkey can draw in much-needed foreign investment," said Kinnear, the analyst.

Norway proposes opening its waters to deep sea mining

Norway said it wants to open parts of the Norwegian continental shelf for commercial deep sea mining in line with the country's strategy to seek new economic opportunities and reduce its reliance on the oil and gas industry. Terje Aasland, Norway's minister for petroleum and energy, said in a statement the country needs minerals to help transition to a more green economy. The Norwegian seabed is reportedly rich with minerals including copper, zinc,

manganese and cobalt.

"Currently the resources are controlled by a few countries, which makes us vulnerable," he said. But the Norwegian government's plan is controversial and environmental groups are warning that mining the sea bed would threaten the biodiversity of the vulnerable ecosystems in the area.

Louisa Casson, global project leader for Greenpeace's Stop Deep Sea Mining campaign, said

that "to forge ahead and unleash deep sea mining in the Arctic would be criminal.

"Norway talks about leading the world but they clearly didn't get the memo of the growing opposition to this industry," she said in a statement. "Companies at the forefront of the green transition are already calling for a halt to this destructive industry, as are citizens and governments from Europe to the Pacific." (AP)

EU unveils plans to boost economic security

The European Union unveiled plans called the "European Economic Security Strategy", but said that it is not directed against China or any other country and is not

a protectionist move.
"Until recently, security was related to armies. The armies provide defence and you secure yourself through the capacity of fighting. But now, security has multiple new dimensions, and the economy is one of these dimensions," EU High Representative

Josep Borrell told a press conference presenting the plans. "It is of paramount importance that our partners understand our message and that they do not see this economic security strategy as a protectionist move. It is not," he said.

"It is not about China. We are not in a confrontational mood with China," stressed Borrell.

On her part, EU Competition Commissioner Margrethe Vestager told the joint press conference that the strategy proposes

a framework, which starts with defining the risks. It outlines four types of risks, risk to supply chains, risk to critical infrastructure, risk to technology security and leakage and risk of economic

However, the EU will use a "geopolitical filter" when assessing risks: "We cannot treat supply dependencies on a systemic rival the same as we would treat the dependency on an ally," she noted. (KUNA)

EPA boosts use of biofuels but holds steady for corn-based ethanol production

WASHINGTON, June 22, (AP): The Biden administration on Wednesday increased the amount of biofuels that must be blended into the nation's fuel supplies over the next three years, but held production totals steady for cornbased ethanol, disappointing the biofuel industry and farm advocates.

A plan finalized by the Environmental Protection Agency sets biofuel blending volumes at 20.94 billion gallons in 2023, 21.54 billion gallons in 2024 and 22.33 billion gallons in 2025. The totals under the federal Renewable Fuel Standard are higher than levels set for 2022 and earlier years, but include just 15 billion gallons of corn-based ethanol in all three years.

Most gasoline sold in the U.S. contains 10% ethanol, and the fuel is a key part of the economy in Iowa, Nebraska and other Midwest states.

EPA Administrator Michael Regan said the final rule would reduce reliance on foreign sources of oil by up to 140,000 barrels per day and support continued growth of biofuels that produce fewer greenhouse gas emissions than traditional gasoline or diesel.

Ethanol and other renewable fuels 'play a critical role in diversifying our country's energy mix and combatting climate change, all while providing good paying jobs and economic benefits to communities across the country,' Regan said in a statement. "Today's

final rule reflects our efforts to ensure stability of the program for years to come, strengthen the rural economy ... and help reduce greenhouse gas emissions" that contribute to global warm-

The final figures represent a decline from a proposal announced last year and drew immediate criticism from the biofuels industry.

"EPA's decision to lower its ambitions for conventional biofuels runs counter to the direction set by Congress and will needlessly slow progress toward this administration's climate goals," said Emily Skor, CEO of Growth Energy, an ethanol industry

"The bioethanol industry has more than adequate supply to meet" an expected increase in demand, Skor added. "Choosing not to put that supply to good use in decarbonizing the transportation sector runs counter to this administration's previously-stated commitments and undermines the goal of reaching net-zero (greenhouse gas emissions) by 2050."

Michael McAdams, president of the Advanced Biofuels Association, called the EPA plan "a missed opportunity to invest in and expand the adoption of low-carbon advanced biofuels" such as algae, switchgrass, cellulosic ethanol or landfill waste.

"By choosing not to reflect the avail-

able and growing supply of advanced biofuels in this three-year rule, the EPA is overlooking a chance to reduce 7 trillion pounds of CO2 from our atmosphere," McAdams said, referring to planet-warming carbon dioxide emissions. "This rule reneges on the Biden administration's proclaimed vision for carbon reduction.

Environmental groups also were disappointed, saying the EPA's continued push for ethanol and other biofuels push will hamper U.S. climate efforts rather than bolster them.

"Our future will not be propelled by corn - though you might think otherwise based on the Renewable Fuel Standard set by the EPA," said Dan Lashof, U.S. director of the World Resources Institute, a global nonprofit.

Biofuels were long thought to be a climate solution, Lashof said, "but today we know that converting crops to fuel is a disaster for the planet. It increases emissions, raises food prices and is a terrible use of prime farmland.

About 40% of corn produced in the U.S. is used to make ethanol, a figure Lashof called "an incredible waste.

The federal government "should be supporting farmers to adopt climatesmart agriculture practices that produce food, store carbon and conserve biodiversity - not incentivize them to use their land to produce fuels that make the climate crisis worse," he said.

'Improving health and protecting biodiversity are particularly off-track'

WASHINGTON, June 22, (AP): The world is falling well short of the progress needed to meet the United Nations' sustainable development goals by 2030 in areas ranging from poverty to clean energy to biodiversity, with a growing gap between wealthy and developing nations, according to a report from the nonprofit tracking the goals.

The coronavirus pandemic stalled the limited progress made in the years after United Nations member states adopted the goals in 2015. Now, halfway through the 15-year time frame, not a single one of the goals is on target to be met.

Sustainable

"We're at the risk of a lost decade for sustainable development," said Guillaume Lafortune, a lead author of the report and vice president and head of the Paris office of the Sustainable Development Solutions Network, the nonprofit launched by the UN to foster and track sustainable development. "And there's actually a risk that the gap between rich and poor countries on sustainable development might be bigger in 2030 than it was in 2015.'

The goals, which the authors described as "an ethical imperative," cover a range of areas, including threats to the climate and environment but also basic human rights such as food, health and education.

The authors noted that goals for reducing hunger, improving health and protecting biodiversity are particularly off-track. They said changing global governance mechanisms and global finance architecture are critical for improving progress on all

Lafortune pointed to the global finance summit that opens Thursday in Paris as an important moment for the world. A main focus of the summit is how international finance can be reformed to help the developing

to climate change but least able to raise capital for things like transition-The report analyzed countries' progress on the sustainability goals by assigning them scores from zero to 100. They examined factors like pov-

erty, hunger, disease, carbon dioxide emissions, subjective well-being scores and dozens of other indicators. Finland, Sweden, Denmark, Germany and Austria ranked highest. South Sudan ranked lowest, followed by the Central African Republic, Chad, Yemen and Somalia. Lafortune called particular attention

to the "disappointing" United States scorecard, which he said was below average for developed countries. He said the U.S. was one of the worst performers in terms of its commitment efforts and was one of only five member countries that did not present action plans and priorities to the international community. But Lafortune did note that some U.S. cities voluntarily provided local reviews.

Kimberly Marion Suiseeya, an associate professor of political science and environmental policy and culture at Northwestern University who did not work on the report, said that while she sees pressing global development shortfalls on issues like the climate emergency, she thinks the Biden administration is taking climate seriously. She also saw signs of optimism in China's progress on renewable energy. Though the country ranked below the U.S. in the report, it has invested more in clean energy, according to research firm BloombergNEF.

Surprised

Anita Ramasastry, a law professor and director of the Sustainable International Development graduate program at the University of Washington, said she wasn't surprised that the sustainable development goals are off track. Ramasastry, who had no part in the report, said she doesn't think many governments with more advanced economies, like the U.S., have embraced the goals or made them

relevant to citizens' daily lives. She questioned whether the goals

were overly ambitious and added that it will be important to examine how the 2030 agenda is financed, as well as the role of the private sector.

"Business has been asked to fill a role. And I think there's just an ultimate question, which is should we have asked business to fill that role?" she asked. "Because ultimately the SDGs are meant to be about governments and states."

The report made the same point repeatedly, singling out several "basic failures" in global governance. Those included voluntary implementation of the goals with no enforcement mechanisms when countries fall short, international trade and finance rules not geared to sustainability, and national governments not coordinating well with smaller

units of government on the goals. Lafortune called for countries to keep the sustainable development goals in mind as they approach the Paris summit and other global confer-

Leaders' resolve on climate to be tested

Summit in Paris 'aims' to shake up financial system

WASHINGTON, June 22, (AP): Heads of state, finance leaders and activists from around the world will converge in Paris this week to seek ways to overhaul the world's development banks - like the International Monetary Fund and World Bank - and help them weather a warmer and stormier world. While restructuring debt and reduc-

ing poverty will be part of the summit Thursday and Friday, climate will be the main driver, with representatives from developing nations in Africa, Asia and elsewhere having a prominent seat at the table. The World Bank and IMF have

been criticized for not factoring climate change into lending decisions and being dominated by wealthy countries like the U.S., with the neediest nations most at risk of global warming left out of calling the shots.

While those are the primary problems to solve, some doubt the splashy summit led by French President Emmanuel Macron will be able to take major strides to correct those chal-

Still, the Summit for a New Global Financing Pact will draw roughly 50 heads of state and government - from Germany, Brazil, Senegal, Zambia and more - with more than 100 countries represented.

Barbados Prime Minister Mia Mottley will play a major role as a leader of the Bridgetown Initiative, a plan to reform development lending by freeing up money after climate disasters and targeting the higher borrowing costs and debt that developing nations

Treasury Secretary Janet Yellen, Chinese Premier Li Qiang, new World Bank President Ajay Banga, IMF Managing Director Kristalina Georgieva, and climate activists Greta Thunberg and Vanessa Nakate also are set to attend.

Masood Ahmed, president of the Center for Global Development think tank in Washington, isn't expecting much concrete action from the gathering but a broad agreement that "we've got to think much bigger, much bolder. We need to be willing to change.'

It's been hard, however, to summon the political will to spend taxpayer money to combat climate change, said Ahmed, a former senior official in both the IMF and World Bank.

For example, "in the United States, we don't have in Congress today the kind of the support that you would want to have for a major global initiative on climate," he said. "That makes it harder for people to translate what is a sensible strategy, a necessary strategy, a critical set of actions into legislative action that puts money on the table.

French organizers want to show they can keep fighting poverty and meet the challenges of climate change at the same time, said a top French official said, who was not authorized to be publicly named according to the country's presidential policy.

Organizers say the summit will end with a summary of commitments, including a roadmap for what to expect from this year's meeting of the Group of 20 major economies and U.N. cli-

mate conference.

But climate advocates say they want to see more meaningful commitments - like new money to help climate-vulnerable nations build sustainable infrastructure or reallocating existing funds to new climate-related projects.

Andrew Nazdin, director of the activist group Glasgow Actions Team, said the development banks "need to expand their lending - and fast - if we're going to avoid the worst impacts of the climate crisis. A U.S. Treasury official told The

Associated Press that big new monetary pledges should not be expected from the summit - rather it's viewed as a chance to push the case for an evolution of the development banks. The official spoke on the condition of anonymity to preview planning for the gathering.

Earlier this year, the World Bank announced that it would increase its lending by \$50 billion over the next 10 years to combat extreme poverty and mitigate and adapt to climate change.

The World Bank is trying to bounce back from comments by former President David Malpass seeming to doubt the science that burning fossil fuels causes global warming. He stepped down this year amid criticism and has been replaced by Banga - who is attending his first big international

meeting since taking the helm. The World Bank and IMF did not

immediately offer comment. Yellen, for her part, has called for climate to be factored into finance since at least 1997, when she chaired the White House Council of Economic Advisers. She's been vocal about the need to reform the multilateral banks and bringing lower-income countries

into the conversation. She has described climate change as an "existential crisis" that no one country could fight alone.

"We must also help developing countries transition their economies away from carbon-intensive energy sources and expand access to clean energy," she said last October.

Justin Mankin, a Dartmouth climate scientist, hopes those at the summit take into account the inequities that climate-vulnerable nations face and avoid reinforcing them.

Apple engaged in 'coercive' interviews, other anti-union tactics

Apple illegally subjected employees to "coercive" interviews and interfered with the distribution of union leaflets at a New York City Apple Store, a U.S. labor board judge ruled Tuesday.

The finding represents the first time that an administrative law judge at the National Labor Relations Board, a federal agency, has ruled against Apple. But it is not the last word on the subject; Apple is free to appeal the ruling to the agency's full board or to federal appeals court.

Apple had no comment on the ruling

Wednesday.

Lauren Esposito, the judge in the case, found that an Apple Store supervisor at the World Trade Center location had improperly asked an employee about his discussions with other workers about wage levels and about the employee's opinion of unionization efforts across the company. Such activities ran afoul of U.S. labor law that protects the right of workers to organize, the judge

Similarly, Esposito ruled that Apple

managers had singled out union literature, which is legally permitted in non-working spaces such as break rooms, for removal and disposal that sometimes involved shredding pamphlets.

The ruling requires Apple to "cease and desist" from activities that the judge found to violate established labor protections and to post workplace notices in the company's name acknowledging the court's findings, informing employees of their labor rights and pledging that the company will honor them. Online safety watchdog demands answers from Twitter on how it tackles online hate

Australia's eSafety Commission takes on Musk

CANBERRA, Australia, June 22, (AP): Australia's online safety watchdog has issued a legal notice to Twitter demanding an explanation of what the social media giant is doing to tackle a surge in online hate since Tesla CEO Elon Musk bought the platform.

Australia's eSafety Commission describes itself as the world's first government agency dedicated to keeping people safer online. The agency said Thursday that it received more complaints about online hate on Twitter in the past 12 months than any other platform and had received an increasing number of reports of serious online abuse since Musk took over the company in October.

The Australian agency's boss, eSafety Commissioner Julie Inman Grant, said she sent a notice to the San Francisco-based company Wednesday with 36 detailed questions on how Twitter's policies about hateful conduct are enforced.

If Twitter does not respond with factual and truthful responses to all questions within 28 days, an Australian judge could fine the company up to 700,000 Australian dollars (\$476,000) for every day of delay, Inman Grant said.

"The whole idea of the basic online safety expectations is that global companies like Twitter are enforcing their own policies ... and that they've got people and

technology to keep their platforms safe," Inman Grant said. "They have a Hateful Conduct policy that says you may not directly attack other people on the basis of race, ethnicity, gender, etc., and I want to know if fundamentally they are enforcing this policy and how effectively they are doing so," she added.

Twitter did not immediately respond to a request for comment Thursday. The eSafety notice followed Musk's announcement in November that he was granting "amnesty" for suspended accounts. This led to 62,000 banned or suspended users being reinstated to the platform, including 75 accounts with more than 1 million followers each, eSafety said in a statement.

Twitter's global workforce had been slashed under Musk from 8,000 employees to 1,500, with trust and safety teams shed. Twitter had removed all public policy staff from Australia.

Inman Grant said Indigenous Australians, disabled people and those who identify as LGBTQ+ experience online hate at double the rate of other Aus-"A third of all reports into our office of online hate are coming from Twitter. It's

been a huge surge since October '22 when Elon Musk took over," Inman Grant told Australian Broadcasting Corp. "Twitter has always been flery in terms of discourse, but it's turned into an absolute bin fire." "A lot of the changes to the algorithms have made people feel like you see more

toxicity, much more coarse discourse. But without lifting the hood and using these transparency powers, we really don't know what's happening and this is where we're trying to get to the bottom of things," she added.

Australians are not alone in their increasingly hostile experience with Twitter. American advocacy group GLAAD said last week that all major social media plat-

forms do poorly at protecting LGBTQ+ users from hate speech and harassment. But Twitter was the worst.

In its annual Social Media Safety Index, GLAAD gave Facebook, Instagram, TikTok, YouTube and Twitter low or failing scores, saying the platforms don't do enough to keep their users safe. That said, most improved from a year ago.

Twitter was the only exception. GLAAD's scorecard called it "the most dangerous platform for LGBTQ people" and the only one that saw its scores decline from last year - to 33% from 45% a year ago.

British rights group Center for Countering Digital Hate found instances of racial slurs on Twitter soared immediately after Musk bought the company.

A racial epithet used to attack Black people was found more than 26,000 times in the week following Musk's takeover - three times the average for 2022, the center found. The center also found users who pay for a Twitter Blue Check seemed to enjoy

a level of impunity from the platform's rules on online hate. Inman Grant chairs the Global Online Safety Regulators Network, which was

formed with British, Irish and Fijian online harms regulators in November to coordinate on online safety issues. Each of the 27 European Union states will soon have its own online harms regulator.

Inman Grant said Australia was discussing with other national regulators sharing information and how they might take joint regulatory actions.

"We will be working with other governments to make sure that we're shining a spotlight on these companies and getting them to improve their standards in doing the right thing," she said.

Wind farm to be country's biggest yet

Build begins on Wyoming-to-California power line despite growing 'concerns'

RAWLINS, Wyo., June 22, (AP): Portrait photographer Anne Brande shoots graduation and wedding engagement photos at scenic spots throughout southeastern Wyoming's granite mountains and sprawling sagebrush valleys. But she worries what those views will look like in a few years, when hundreds more wind turbines dot the landscape. Wind energy is booming here.

"Dandelions in my yard, you know, when there's four or five, it's OK,' Brande said. "When my whole yard is dandelions, I'm just not too excited."

In a state where being able to hunt, fish and camp in gorgeous and untrammeled nature is a way of life, worries about spoiled views, killed eagles and disturbed big-game animals such as elk and mule deer have grown with the spread of wind turbines.

On Tuesday, state and federal officials beneath fluttering flags formally broke ground on the TransWest Express, a transmission line that will move electricity from the \$5 billion, 3,000-megawatt, 600-turbine Chokecherry and Sierra Madre wind farm to southern California, a place legally mandated to switch to clean energy. The wind farm will be the country's biggest yet.

Federal regulators gave the goahead to TransWest in April. The International Energy Agency and other experts say wind power is crucial to attaining a carbon-neutral world by 2050. Developers here estimate the wind farms will prevent the emission of between 7 and 11 million tons of carbon dioxide a year and provide enough carbon-free electricity to power 1 million homes.

"We want people to say yes - yes to clean energy in the same way that people said yes to fossil energy," Energy Secretary Jennifer Granholm said at the groundbreaking that also brought out Interior Secretary Deb Haaland and Wyoming Gov. Mark Gordon, a

Republican. Gordon has pledged to make Wyoming not just carbon neutral but carbon negative, looking to renewable energy and technologies such as carbon capture to make it happen.

"As we see climate change, we know we don't have time to waste," said Gordon at the event on a treeless Wyoming expanse where not just TransWest Express but two major PacifiCorp transmission lines will soon extend over the horizon.

But in Wyoming, despite extensive wildlife studies and lengthy federal environmental reviews, there's more skepticism about wind power than when TransWest Express and Chokecherry and Sierra Madre were first proposed 17 years ago.

"I think it's just as simple as too much of a good thing," Brande said.

As elsewhere, opposition to wind farms in Wyoming correlates with proximity to homes and cabins: Chokecherry and Sierra Madre is massive but isolated, and has generated less opposition than some others. But Brande and rural property owners opposed a 500-megawatt, 120-turbine wind farm soon to be built near the Colorado state line. They lost, but the matter reached the Wyoming Supreme Court.

The contentious county approval process included a five-hour public hearing in a packed courtroom in Laramie in 2021. Residents expressed a range of concerns, from turbine blades killing birds to construction blasting

damaging home foundations. In neighboring Carbon County, the county commission on June 6 held off permitting for a 280-megawatt, 79-turbine project called Two Rivers, after hearing from people with concerns.

Commissioners told the developers to get federal approval first.

The local opposition to a wind farm is a recent development in an area that previously welcomed the economic benefits with few questions, Carbon County Commission Vice Chairman Sue Jones said. Named for its coal reserves that once fueled steam engines, Carbon County adopted an official seal in 2021 that features a wind turbine.

Yet county officials recently required wind farms to turn off their red warning lights except when aircraft approach, responding to public com-

The regulation wasn't retroactive. But PacifiCorp, which serves customers in Wyoming, Utah and the Pacific Northwest, retrofitted its wind turbines in the area with the on-and-off pilot warning system anyway, Jones said.

"The companies do try to be good neighbors," Jones said. "But it is starting to show and it is reaching a point where maybe it's too much. It's affecting wildlife habitat. It's affecting the birds and the bats."

In just four years, wind generation capacity in Wyoming has doubled, adding about 600 turbines - the bulk of them in the southeast - since 2020, according to the U.S. Geological Survey.

Chokecherry and Sierra Madre alone will double that amount again and at least five more wind farms are planned, according to a 2022 University of Wyoming report. If they all stay on schedule, Wyo-

TransWest Express will move the Chokecherry and Sierra Madre electricity 732 miles (1,178 kilometers) from south-central Wyoming to just outside Las Vegas. Along the way, it will cross northwestern Colorado and Utah, with conversion from direct to alternating current in central Utah.

The wind farm and transmission lines, both projects of The Anschutz Corporation owned by Denver oil and gas billionaire Phil Anschutz, are scheduled to come online around the same time, starting in late 2027.

The transmission line's direct-current section allows efficient, long-distance electricity transfer with no tie-ins to other power lines, while the alternating current segment is less efficient but connects to the rest of the grid.

Wyoming wind averages almost 13 mph (21 kph) day and night, yearround, matching well with daytime solar generated elsewhere. But so far there aren't a lot of ways to get wind power from Wyoming onto the western U.S. power grid, said Roxane Perruso, TransWest Express executive vice president and chief operating of-

"So we're going to enhance the ability to move renewables and other power, carbon-free power in the future, around the grid," Perruso said.

Paralleling TransWest Express in places, Pacificorp's Gateway South transmission lines connecting Wyoming wind farms to southern Utah are scheduled for completion next year. Pacificorp's Gateway West lines, already partly built across southern Wyoming, will stretch all the way to the Pacific Northwest sometime after 2030.

Dispute over \$69b deal that could reshape video gaming

Microsoft, U.S. regulators head to court

SAN FRANCISCO, June 22, (AP): Microsoft on Thursday will try to gain clearance to complete a \$69 billion takeover of video game maker Activision Blizzard in a legal showdown with U.S. regulators that will reshape a pastime that's bigger than the movie and music industries combined.

The battle will pit Microsoft's ambition to expand its video game imprint beyond its Xbox console against the U.S. Federal Trade Commission's bid to block a deal that it contends will stifle competition and innovation to the detriment of consumers.

It's the latest twist in a deal that was announced 17 months ago. Both Microsoft CEO Satya Nadella and Activision Blizzard CEO Bobby Kotick are expected to testify at some point during five days of hearings in San Francisco before U.S. District Judge Jacqueline Scott Corley that will conclude June 29.

FTC lawyers will call upon experts and a top executive for Sony, the maker of the industryleading PlayStation video game console, to show why Microsoft will gain an unfair advantage if it is allowed to blend its Xbox franchise with an Activision acquisition that will give it ownership of popular video game titles such as Call of Duty, World of Warcraft and Candy

After all the evidence and arguments are presented, Corley will decide whether or not to grant the FTC's request for a court order that would keep the deal in a holding pattern until a more exhaustive administrative trial that's scheduled to begin in Washington D.C. on August 2. The judge isn't expected to rule until after the Fourth of July holiday.

If Corley declines to issue an injunction, Microsoft could move to close the deal ahead of a July 18 deadline and avert a \$3 billion breakup

The wrangling over the deal has cast a spot-

light on the growing importance of video gam-

ing, a pursuit that has already garnered an es-

timated of audience of about 3 billion people worldwide who play at least some of the time on a console, personal computer or, increasingly, smartphone. The market is expected to swell to

4.5 billion people by 2030. All those gamers are willing to pay upwards of \$70 to own marquee titles like Call of Duty or fork over a steady stream of recurring subscriptions to services such as Microsoft's Xbox Game Pass, Amazon's Luna and Nvida's Ge-

Microsoft is framing the proposed Activision deal as a way to make inroads against Sony's PlayStation, which has a far larger market share, while providing new benefits for video game players. Among other things, Microsoft cites a 10-year commitment to make Call of Duty available on Nintendo's Switch console and a willingness to make a similar decade-long deal with PlayStation, and also argues video gamers will gain more access to even more games on its Xbox subscription service.

The FTC has countered the deal will give too much power to Microsoft, already one of the world's richest companies because of a personal computer software empire that the U.S. Justice Department tried to break up in landmark antitrust case more than 20 years ago. Regulators

also allege Microsoft can't be trusted not to gradually make the most popular video games exclusive to its own Xbox console and subscription services, based on its handling of titles after buying video game maker ZeniMax Media in 2021.

The hearings will also be another test of the FTC's amped-up oversight of Big Tech under Chairperson Lina Khan, who has been outspoken about her belief that U.S. regulators were too lenient in past deals that helped increase the power of companies such as Amazon, Google and Facebook. The courtroom tussle with Microsoft comes six months after the FTC took Facebook owner Meta Platforms to court in Silicon Valley to try to stop a takeover of a virtual reality fitness company only to be rebuffed by the judge in that case.

The FTC could face challenges convincing Corley to block the Activision deal. The judge previously showed skepticism about the need to prevent the takeover in March when she dismissed a lawsuit brought by a group of gamers who sued to stop the acquisition.

Like regulators are now, the gamers argued that Microsoft's takeover of Activision would stifle competition and reduce consumer choice. They later brought an amended lawsuit, but Corley in May denied their request for an injunction to block the deal.

Another major regulator, the U.K.'s Competition and Markets Authority, also has taken action to thwart Microsoft's takeover.

But European regulators representing the 27-nation bloc approved the deal last month on condition that Microsoft make some promises meant to boost competition in the cloud-based gaming market. A number of other countries, including China, Japan, Brazil and South Korea, have also approved it.

Microsoft has lashed back against the British regulators standing in its way with an appeal of their decision, as well as voicing strong opposition to U.K. government officials.

Masimo, Clinton Fdn host roundtable addressing addiction crisis



Rivera says he's quitting Fox News' political combat show 'The Five' NEW YORK, June 22, (AP): Geraldo Rivera has quit as one of the

lonely liberal voices on Fox News' popular political combat show "The Five," saying Wednesday that "a growing tension that goes beyond editorial differences" made it no longer worth it to him.

The last scheduled appearance on "The Five" for the television

veteran, whose 80th birthday is on July 4, is next week. "It has been a rocky ride but it has also been an exhilarating adventure that spanned quite a few years," he said in an interview with The Associated Press on Wednesday. "I hope it's not my last

Rivera said that it was his choice to leave "The Five," but that Fox management "didn't race after me to say, 'Geraldo, please come back." There was no immediate comment from Fox.

Despite airing in the late afternoon instead of prime time, "The Five" has become Fox's most-watched program, with an average of more than 3 million viewers last year. Its conceit is simple - five people, four of them conservative and one liberal - kick around the issues of the day.

Greg Gutfeld, Jesse Watters, Dana Perino and Jeanine Pirro are the regular conservatives. Rivera has rotated as the liberal voice with Jessica Tarlov and Harold Ford Jr., a former congressman from Tennessee.

Rivera said he planned to remain as a "correspondent at large" at Fox, with a contract that expires in January 2025.

He said he'd been suspended a handful of times, most recently in early May. He had tweeted shortly after Fox fired Tucker Carlson on April 24 that he found Carlson's theories about the Jan. 6 Capitol insurrection to be "bullshit," leading Gutfeld to respond via tweet, "You're a class act Geraldo, a real man of the people." Carlson had downplayed the violence on Jan. 6, calling people who invaded the Capitol "sightseers."

Tension

Rivera and Gutfeld had a handful of particularly contentious exchanges. In late April, Rivera told him "stop pointing at me" when they argued over electric vehicles. He called Gutfeld "an arrogant punk" on the air last year during a fight about abortion.

Rivera would not comment directly about Gutfeld. "There has been a growing tension that goes beyond editorial differences and personal annoyances and gripes," he said. "It's not

worth it to me.' Rivera, once a friend of Donald Trump who split with him over the former president's false claims of winning the 2020 election, said that "under no circumstances do I think Donald Trump should

be president of the United States again and that's an important message I am committed to bringing to the American people between now and November 2024."

Although "The Five" and its large viewership would seem a prominent place for him to deliver that message, he said "you can

imagine the friction that role by definition" would provoke. "I'm 80 years old," he said. "I don't want the friction. 'The Five' is too intimate a place and it gets too personal."

The argument over electric vehicles illustrated the challenge faced the liberal voice on "The Five." As he talked, onscreen chyrons below him read "Biden pushing pricey electric cars on Americans" and "Americans not buying Biden's EV hype."

Rivera had a colorful syndicated talk show that aired from 1987 to 1998, and hosted an evening news and interview show at CNBC in the late 1990s. He was brought to Fox shortly by then-chairman Roger Ailes after the September 2001 to be a war correspondent at first and has remained. On Wednesday he expressed some regret, in retrospect, for not leaving the network after the killing of Osama bin Laden in 2011.

He said his relationship with his colleagues on "The Five" is "a reflection of what the country is going through. ... It's not an easy job if you take it as personally as I do.'

Hollywood writers at rally say they'll win

A vibrant riot-grrrl energy in 'Nimona'

powerful, shapeshifting teenage girl and a dis-A graced knight-in-training suspected of killing a beloved queen are at the heart of "Nimona," a vibrant and irreverent animated adventure set in a futuristic fantasy kingdom.

It is a familiar story — a society governed by ancient rules and a crippling fear of outsiders — even by recent Netflix animation standards (see "The Sea Beast"). But "Nimona" is wrapped in new, exciting packaging with a wildly fun soundtrack featuring the likes of Metric, Dope Saint Jude and Judas Priest themes that aren't clumsily subtle, and charismatic lead voice actors in Chloë Grace Moretz and Riz Ahmed. There's also a supporting character named Ambrosius Goldenloin. Ambrosius. Goldenloin. He has blonde, swooped hair and is voiced by Eugene Lee Yang of The Try Guys.

The fraught saga of getting "Nimona" to audiences could be its own epic movie. ND Stevenson's popular graphic novel first went into development in 2015 at Blue Sky Studios and was inherited by Disney in 2019 as part of the Fox acquisition. Despite seismic shifts and leadership changes, work continued. Then in 2021, when the film was reported to be 75% complete, Disney announced that Blue Sky Studios was shuttering and "Nimona" was to be shelved. In addition to the economic hardships of the pandemic, Business Insider reported that Disney leadership took issue with a same-gender kiss. Then Annapurna and Netflix stepped in, with new directors (Nick Bruno, Troy Quane), and got "Nimona" to the finish line (though also without a kiss).

Moretz is the voice of Nimona, a chaos-loving radical who sees a fellow outsider's horrifying fall from grace and thinks "I need to collab with this guy." The outsider in question is Ballister Boldheart (Ahmed), a kid from the streets who dreamt of being a knight, a position traditionally reserved for members of a certain class or descendants of an ancient, revered warrior named Gloreth, who 1,000 years ago saved the kingdom from a monster. Despite the odds, and prejudices, he rose the ranks and almost made it. On the "Night to Knight Knights" a big, televised event with futuristic Super Bowl halftime showmeets-"Blade Runner"/"Hunger Games" production levels, the public still isn't convinced about Ballister they sneer that he doesn't deserve it and won't

keep them safe. The only people on his side are his boyfriend, the aforementioned Ambrosius Goldenloin, and the queen. But things go south quickly at the ceremony: The sword he's given kills his most public champion, the queen, in front of everyone and no one gives him the benefit of the doubt. He's a queen killer and that's that.

Innocence

Ballister is reluctant to team up with Nimona — he wants to prove his innocence and she doesn't seem like the best way back into society. But she also has some very useful skills, namely being able to morph into anyone and anything — an adult, a child, a rhinoceros — and single-handedly defeat a dozen men without much strain. Plus, she's a lot more fun than the small-minded bros and icv leaders back at the Institute. Moretz, it should be noted, is an excellent voice actor who brings real life and punk energy to Nimona. And there are some real twists and turns on the way to the resolution that would be best to just

experience yourself. Certainly the release has been plotted to coincide with Pride, but it happens that LGBTQ+ rights are also once again under seige in the country. This may not push the envelope much further than recent animated forays into more blatant depictions of same sex relationships, but it's another tiny step in the right direction which is always helped when the

movie is good, too. Netflix might not have initiated "Nimona," but it won by getting it out in the end.

"Nimona," a Netflix release in limited release Friday and streaming June 30, is rated PG by the Motion Picture Association for, "violence/action, rude humor, thematic elements and some language." Running time: 101 minutes. Three stars out of four.

LOS ANGELES: Fifty days into a strike with no end in sight, about 1,000 Hollywood writers and their supporters marched and rallied in Los Angeles for a new contract with studios that includes payment

guarantees and job security. Speakers at the Writers Guild of America's WGA Strong March and Rally for a Fair Contract on Wednesday emphasized the broad support for their cause shown by other Hollywood unions — including actors in their own contract negotiations — and

labor at large. "We're all in it together, we're all fighting the same fight, for a sustainable job in the face of corporate greed," **Adam Conover**, a writer and a member of the guild's board and its negotiating committee, told a crowd at the end of the march at the La Brea Tar Pits. "We are going to win because they need us. Writers are the ones who stare at a blank page. We are the ones who invent the characters, tell the stories and write the jokes that their audiences love. They'd

have nothing without us." Talks with the Alliance of Motion Picture and Television Producers, the group representing studios in negotiations, have not resumed since breaking off hours before the writers' contract expired on May 1. The strike began a day later. with more and more productions shutting down as it has gone on.

A similar deadline now looms for actors, whose union, SAG-AFTRA, is negotiating with the AMPTP on a contract that expires June 30. Members voted overwhelmingly to authorize guild leaders to call a strike if no deal is reached.

Streaming and its ripple effects are at the center of the dispute. The guild says that even as series budgets have increased, writers' share of that money has consistently shrunk.

The AMPTP says writers' demands would require they be kept on staff and paid when there is no work for them, and that its contract proposals have been

generous. "We are here for the sake of the profession we love," writer Liz Alper said at Wednesday's rally. "The industry we work in, our audiences, our fellow sister unions in Hollywood, and all the workers across America who have been hurt and disenfran-

chised by Wall Street and big tech." (AP)

'Downey's Dream Cars' a show for gearheads

LOS ANGELES, June 22, (AP): Robert Downey Jr. knows he has amassed an impressive collection of classic cars - one he self-deprecatingly refers to as artifacts of his success.

Despite his expectations of what the "accouterments are supposed to be" when one reaches a certain level of fame and wealth, trophies, it turns out for the actor, are not all they are cracked up to be. It's that dissatisfaction that helped to inire "Downey's Dream Cars," his latest project was to debut Thursday on Max.

"The cash and prizes, it's never been what motivated me. So, I shouldn't be surprised that it's still not," Downey said at the show's premiere, held last week at the Petersen Automotive Museum in Los Angeles.

While "Downey's Dream Cars" is very much a show for gearheads, it isn't restricted to that audience. Downey experiments with genre in a kind of eco-friendly "Pimp My Ride" that is also part memoir and a documentary about the latest advancements in clean technology.

"That was certainly the idea, was to try to innovate a little bit in this kind of storytelling," he said. In each episode, Downey relinquishes control of his prized

possessions, letting experts modify his classic cars to be more environmentally sustainable by making them electric, converting them to run on biodiesel fuel or even affixing them with mushroom leather. Downey hopes it will be a glimpse into the future of sustainability and espouses optimism by featuring what's attainable now as well as what technological progress promises.

It is indeed a show about cars and technology, but in it Downey conveys a surprising amount of tenderness and introspection. It's a window into the ways he's grown from very public struggles with drug addiction that informed his image for years before "Iron Man" and the Marvel Cinematic Universe came calling.

He exhibits a self-awareness of the "machismo" cinematic influences and capitalistic values that prompted him to build such a collection. Throughout the show, Downey weaves in reflections on his life, family and shifting priories in recent years, specifically as they relate to the future of the planet.

Collaborates

Susan Downey, a producer who frequently collaborates with her husband, shares his commitment to environmental activism and worked as an executive producer for the

Although she said they both feel a personal responsibility in the fight against climate change, she praised her husband for his efforts to hold corporations accountable.

"It's not to absolve the everyday person of any responsibility they have, but really recognizing, to make the significant changes, they have to operate at a much higher level," she said.

The actor has in recent years become widely associated with his activism, particularly after he founded FootPrint Coalition, a venture capital fund that invests in climate technology and artificial intelligence.

In the series, Downey bemoans society's inefficiency and lack of collective will in making progress on these fronts, a frustration that contributed to his decisions to create both the company and the series.

And despite many people's concerns over the uncharted

territory AI has already traversed, Downey believes in its ability to fight climate change and suspects fears of its capabilities may be to some extent unwarranted.

WINCHESTER, Va: A wild animal trainer featured in the popular Netflix series "Tiger King" has been convicted of wildlife trafficking in Virginia, the attorney general's office announced

Bhagavan "Doc" Antle was accused of illegally buying endangered lion cubs in **Frederick County**, **Virginia**, for display and profit at his South Carolina zoo, Attorney General Jason Miyares said in a news release. A jury convicted Antle on Friday of two felony counts each of wildlife trafficking and conspiring to wildlife

traffic. Antle, who owns the Myrtle Beach Safari, appeared in "Tiger King: Murder, Mayhem and Madness," a Netflix documentary miniseries that focused on tiger breeders.

The jury acquitted Antle of five counts of animal cruelty and Judge Alexander Iden dismissed four additional animal cruelty charges against Antle and all charges against his two adult daughters, The Winchester Star reported.

Prosecutor Michelle Welch said Myrtle Beach Safari's lucrative petting zoo motivated Antle to maintain a steady supply of immature lion cubs that he purchased from Wilson's Wild Animal Park near Winchester, calling the arrangement a "cub pipeline" from

Virginia to South Carolina. When Antle and Keith Wilson, the park's former owner, began doing business in 2015, it was still legal to buy and sell lions, Welch said. But after lions were designated as an endangered species in December 2015, lions could only be traded between zoos and wildlife preserves that were part of an established breeding program and had permits. There were three illegal cub exchanges in 2017, 2018 and 2019,

Welch said. (AP)



NEW YORK: Actor **Jonathan Majors'** domestic violence case will go to trial Aug 3, a **Manhattan** judge said Tuesday, casting him in a real-life courtroom drama as his idled **Holly**wood career hangs in the balance.

Majors' accuser alleges he pulled

NATO climate change fight faces dilemmas

BRUSSELS, June 22, (AP): NATO faces a series of dilemmas in its attempts to fight climate change while ensuring the effectiveness of its combat forces, as Europe's biggest land war in decades ravages Ukraine, the head of the military alliance told The Associated Press in an interview on Wednesday

The world's armed forces are among the greatest consumers of hydrocarbons - fuel and oil - that contribute to greenhouse gases. They have been in much demand recently as global warming fans conflicts and crises because of resource and food scarcity.

The main dilemma NATO is contending with, Secretary-General **Jens Stoltenberg** said, is the difficult choice "between either having a green or a strong military."

He said that NATO needs to "reconcile the need for an ef-



fective, strong, armed forces with the need to have climate-friendly armed

Last year, in its new Strategic Concept - essentially NATO's mission statement - the world's biggest security organization recognized, for the first time, climate change as "a defining challenge of our time, with a profound impact on Allied security.

The document acknowledged that the 31-nation alliance's "infrastructure, assets and bases are vulnerable to

its effects." It warned that NATO armies are being forced to operate in more extreme climate conditions and are increasingly called upon to take part in disaster relief operations.
"Climate change is a crisis multiplier. It increases compe-

tition over scarce resources like water and land, and it drives millions of people to leave their country. So, all this impacts our security," Stoltenberg told the AP at NATO's headquarters in Brussels.

Last week, NATO began an air deployment exercise in Germany billed as the biggest in the alliance's history. Some 250 aircraft - a major source of emissions - from 25 nations responded to a simulated attack on a NATO member. The United States alone sent about 100 aircraft.

The exercise was long-planned, but remains part of NATO's deterrence and defense strategy; its ongoing effort to dissuade Russian President Vladimir Putin from expanding his war against Ukraine to any member of the alliance. Wargames are not likely to be halted.

Stoltenberg said that the best way to achieve a balance is "to develop technology and to ensure that the armed forces are part of the energy transition which is going on." NATO has established an "innovation fund" and a center for excellence on climate change to help develop such technology.

The United Kingdom has also begun to use more climatefriendly fuels, biofuels, for some of its aircraft. Other allies are working on ways to reduce their dependency on diesel, which is also particularly vulnerable to air or land attacks when being transported.

But Stoltenberg said that NATO cannot simply "go 100% from fossil technologies to zero-emission technologies in one stroke." That raises another dilemma.

"Over time we will have parallel systems that will increase costs and there will be additional problems with logistics,' when it comes to supplying motors, battle tanks and ships

with different kinds of fuels and parts, he said.

"The other dilemma (is) to make sure that the systems can work together," Stoltenberg said. "If different nations (use) different systems that are partly fossil and partly new technologies, then the issue of the interchangeability and interoperability will be even harder."

The fight against climate change has, in some ways, been postponed by the heavy reliance of many European countries on Russia for oil and natural gas before it invaded Ukraine last year. Some, like Poland, are slowing their transition away from coal, while others, such as Belgium, plan to keep using nuclear energy for longer.

Stoltenberg warned that nations must be wary of creating new dependencies, notably on authoritarian countries like China, for rare earth minerals like lithium and cobalt used in the manufacture of batteries and solar panels and windmills.

Security though is at the heart of the battle against climate change, Stoltenberg told the AP, and peace is a precondition for that, whether in Ukraine or elsewhere. We need peace and stability, he said, so countries can co-

operate among themselves and incur a meaningful global effort to reduce emissions. "If allies or Ukraine were forced to choose between a climate-friendly or an effective armed force, then everyone would choose a strong and effective military because that's

BRUSSELS: The European Union achieved a small political breakthrough Tuesday when a majority of the 27 member states backed controversial plans for restoring nature across the continent.

The 27-nation EU has long been at the forefront of fighting climate change and protecting the environment but is struggling to push the latest piece of legislation through a long-winding legal procedure. Some member states and the biggest party in the legislature, the right-wing European People's Party, turned against the proposed plans because of fear they would negatively affect the economy.

"It's been hard work from all parties involved," said Swedish Environment Minister Romina Pourmokhtari, who chaired the meeting. "It is a good day for nature," she

The plans proposed by the EU's executive commission set binding restoration targets for specific habitats and species, with the aim by 2030 to cover at least 20% of the region's

For the next step, the file would go to the EU parliament where it would face a committee vote next Tuesday before going to the full plenary debate next month. Based on those results, the member states and legislators would seek to broker a final compromise text over the next year.

At stake is the EU's role as a guiding light to climate issues. It was instrumental in pushing through global rules aimed at containing climate change over the past years.

"We were among those pushing a global agenda towards higher ambition, and we've managed to accomplish that,' said EU Environment Commissioner Virginijus Sinkevicius. "It was an extremely important message, also to the world, that we also can deliver at home."

But countries like the **Netherlands** objected to parts of the proposals and a one-size-fits-all approach saying that could hurt national industries like farming, or hem nations into a legal straightjacket that could force them into decisions their electorate would strongly oppose.

Dutch Environment Minister Christianne van der Wal-Zeggelink called it "micromanagement per square meter" that would ultimately hurt nature.

The nature restoration plan is part of a far bigger project for the EU to become climate neutral by 2050. It includes a wide range of measures, from reducing energy consumption to sharply cutting transport emissions and reforming the EU's trading system for greenhouse gases.

The EU's executive Commission said it wanted to keep all actions interlinked for optimal impact, which is why the nature restoration plans had to remain as fully intact as pos-

'Protect forests': Greenpeace activists on Wednesday called on the Polish prime minister to take action to protect Poland's forests, asking the government to limit the harvesting of timber in the vast old-growth forests of the Carpathian Mountains.

During a news conference held outside the office of Prime Minister Mateusz Morawiecki, Greenpeace activists held a section of a fir tree trunk that they took from the forest. It was the conclusion of a 40-day expedition to try to raise awareness about the threats to a forest which is home to bears, lynx and other wildlife. They delivered it to the prime minister's office after the conference.

According to Greenpeace, a forested area the size of five soccer fields disappears every hour from the Carpathians, which run through parts of Poland, Slovakia, Hungary, Romania and Ukraine.

Activists on the expedition witnessed up to 40 trucks full of timber per day being transported out of the Bieszczady Mountains, which form part of the Carpathians, on one road alone, said Greenpeace spokesman Marek Jozefiak.

He said the government has not fulfilled its promise to put more of the country's forests under protection by declaring them

Logging in the Carpathians is highly problematic, he added, because it is the home to the only population of brown bears in Poland and to the biggest population of lynx, wolves and others species.

"It's really mindboggling. We are talking about the most precious mountain forest that we have," Jozefiak said. Greenpeace says that the biggest obstacle

to protecting the Polish Carpathians is the appropriation of the state forests by a party in the right-wing government. Greenpeace argues that politicians from a party that belongs to the governing coalition

led by Justice Minister Zbigniew Ziobro "have de facto privatized Polish forests and treat them like money-making machines.' Jozefiak said large-scale logging is taking place in all the countries, and activists are

asking governments and the European Commission to take action. (AP)

'Bear didn't have rabies': A bear that fatally attacked a 66-year-old Tucson man at a campsite in central Arizona last week tested negative for rabies and had no apparent signs of disease, authorities said Wednesday.

Anne Justice-Allen, the Arizona Game and Fish Department's wildlife veterinarian, conducted a necropsy on the carcass of the adult male black bear that killed Steven Jackson on Friday at his property about 100 miles (161 kilometers) north of Phoenix.

Jackson was killed in the Groom Creek

Is it chicken?

How does 'cell-cultivated' meat taste

When I told friends and family I was reporting on the first chicken meat grown from animal cells, their first comment was "Eww." Their second comment was: "How does it

The short answer (you've probably heard this sentence before in other contexts): Tastes like chicken.

The longer answer, which folds in the "Eww" response, is more nuanced. Yes, it's strange to think of eating a totally new kind of meat - chicken that doesn't come from a chicken, meat that will be sold as "cell-cultivated" chicken after the US Agriculture Department on Wednesday gave the green light to two California firms, Upside Foods and Good Meat.

But it's also interesting (and exciting!) to taste test the first offerings of a new era in meat production, which aims to eliminate harm to billions of animals slaughtered for food - and to dramatically reduce the environmental effects of grazing, growing feed for those animals and dealing with their animal waste.

I'm a lifelong meat eater. I'm also a victim of the "meat paradox," a term scientists use to describe the psychological conflict that occurs in people who like to eat meat but don't like to contemplate the animals that died providing it.

As someone who has reported on food-borne illness outbreaks and slaughterhouse safety, I'm keenly aware that the chicken on my dinner plate probably suffered to get there. And that fact makes me uneasy if I dwell on it too much.

So I was open to trying a different kind of meat - and also curious to see if it would taste like the real thing.

Substitutes

I've tried plant-based options like the Beyond Meat sausage and the Impossible Burger and liked them, even though I didn't think they were perfect substitutes. To be honest, the Beyond Meat sausage tasted good, but a little mealy. And the Impossible Burger was dry, although I may have cooked it too long. In both cases, I enjoyed the taste of the products but was still aware that I wasn't actually eating beef.

What about the artificiality of it all? It didn't bother me that this new cultivated meat is made from cells that grow to epic proportions in big steel vats, only to be shaped and formed - "extruded" is the somewhat unfortunate verb that came to mind - into familiar cutlets, filets and nuggets that

'Meat' grown from animal cells? Here's what it's & how it's made

NEW YORK, June 22, (AP): The US government is allowing the sale of chicken made from animal cells.

California companies Upside Foods and Good Meat were granted permission on Wednesday to sell their products by the Agriculture Department. Livestock doesn't need to be

raised and killed to produce this new type of meat, which proponents say is better for the animals and for the environment because land does not need to be cleared for grazing or growing feed.

Currently, the US. uses over 1

billion acres of land for agriculture, or just over half of total land -- the majority of which is used for grazing cattle. It's meat grown from the cells of

animals in steel tanks. Though it's known in the industry as cultivated meat, it's sometimes called cultured meat, lab-grown meat or cellbased meat. There are more than 150 companies around the world trying to develop these food products. They're working on a variety of meats: chicken, beef and lamb.

At this point, you can't buy these new meats at the grocery store - they will be initially rolled out at restaurants. Consumers can expect cultivated meat to be sold at a growing number of restaurants and small retailers within the next two to five years and on supermarket shelves within seven to 10 years,

said Sebastian Bohn, a project manager specializing in cell-based food for CRB, a Missouri firm that designs and builds facilities for pharmaceutical, biotech and food companies. It starts with cells, which can

come from a fertilized egg, a special bank of stored cells or tissue initially taken from a living animal. The cells are mixed with a broth of nutrients that the cells need to grow and divide. Cells are triggered to turn into skeletal muscle, fat and connective tissues. After days or weeks, the cells are removed from the tanks and shaped into products such as nuggets.

The easiest products to make this way are those usually made with ground meat, such as hamburgers and chicken nuggets. Some companies are working on products with more structure, such as chicken breasts and steaks. Those need a scaffold, or structure for the cells to grow on, which can be vegetable-based or made of animal products like collagen.

Experts say it's real meat created in a different way. It's not the same as plant-based products such as Impossible burgers, which do not contain animal cells. Some versions of cultivated meat - including Good Meat chicken products - do contain a small amount of vegetable proteins. Upside Foods officials say their meat does not.

would look right at home on the dinner table.

But as with all food, in the end it would come down to taste. And in this case, to the larger question behind it: Is this new material in fact chicken, or is it an impostor?

In January, I traveled to the Upside Foods manufacturing plant in Emeryville, California. There, chef Jess Weaver sauteed a cultivated chicken breast in a white wine butter sauce with tomatoes, capers and green onions. The aroma was enticing, just like

any filet cooked in butter would be. And the taste was light and delicate with a tender texture, just like any chicken breast I'd make at home - if, that is, I were a chef trained at the Culinary Institute of America.

Last week, I visited the Alameda, California, plant where Good Meat is poised to begin production of its chicken products. Chef Zach Tyndall was ready with a smoked chicken salad with mayonnaise, golden raisins and walnuts. He followed it with a chicken "thigh" dish - darker meat served on a bed of potato puree with a mushroomvegetable demi-glace, golden beets and tiny purple cauliflower florets. The taste was richer than a chicken

breast, more like the dark meat of a thigh. And the texture was both tender and chewy, like a well-cooked chicken thigh should be. That, says Tyndall, is the whole

point.

"It needs to be as lifelike as possible for it to catch on," he said.

IOC banishes boxing governing body IBA from Olympics

ternational Boxing Association was banished from the Olympic family on Thursday, ending a years-long dispute fueled by defying advice and instructions from the IOC. Boxing, however, will keep its status as an Olympic sport at the 2024 Paris Games.

The International Olympic Committee voted to derecognize the IBA at a specially called meeting - an outcome that was inevitable after being recommended two weeks ago by the executive board, a body chaired by IOC president Thomas Bach.

The vote was 69-1, with 10 members abstaining.

Boxing was never really in danger of being kicked out of the Olympics over the four years since the IOC suspended the sport's governing body in an effort to force changes.

"We highly value the sport of boxing. We have an extremely serious problem with IBA because of their governance," Bach told IOC members during their online meeting.

The dispute centered on the IBA's management under presidents from Uzbekistan and Russia who the IOC disapproved of, its finances being backed by Russian state energy firm Gazprom, plus the integrity of bouts and judging.

"The boxers fully deserve to be governed by an international federation with integrity and transparency," the IOC president said.

The IOC is already overseeing boxing competitions for the Paris Olympics without IBA involvement, as it did for the Tokyo Games in 2021.

It was unclear if boxers representing national federations who stay affiliated to the IBA will be classed as eligible for the Paris competition.

Boxing can now be confirmed on the 2028 Los Angeles Olympic program, which the IOC and Bach withheld as leverage against IBA. Boxing is "guaranteed" to be in Los Angeles, members

The sport is good for Olympic business with broad appeal - 25 different countries won boxing medals in Tokyo, with nine taking gold - and the IOC repeatedly said its problem was with boxing officials, not its athletes.

"We appreciate boxing as one of the most global sports. We embrace the values of boxing," Bach said, praising the sport's "important social role promoting inclusion.'

OLYMPICS

The IBA had not published a response more than two hours after the IOC decision, which it can challenge at the Court of Arbitration for Sport.

Olympic boxing has had a tainted reputation for decades, typified by notorious judging at the 1988 Seoul Games that denied American light-middleweight Roy Jones Jr. the gold medal

against home fighter Park Si-hun. Jones, who now has Russian citizenship, was enlisted by the IBA last year to support its fight for Olympic status.

There were allegations ahead of the 2012 London Olympics of cash deals planned to fix medals, and further doubt cast by fighters on the integrity of bouts at the 2016 Rio de Janeiro Games.

At those Olympics, the president of boxing's governing body, then known by its French acronym AIBA, was a long-time IOC member C.K. Wu of

After Wu was ousted by boxing officials in 2017, the sport's problems with the IOC intensified

National federations defied IOC warnings in 2018 by electing Gafur Rakhimov as president. The businessman from Uzbekistan allegedly had ties to organized crime and heroin trafficking.

Umar Kremlev's election to replace Rakhimov in 2020 followed another round of IOC election warnings that

The IBA's debts approaching \$20 million were cleared under Kremlev and the IOC objected to the boxing

body's financial reliance on Gazprom. Kremlev announced last month at the men's world championships that the IBA was no longer sponsored by Gazprom, and his rhetoric against Olympic officials got more confrontational.

Thursday's meeting went ahead after a late appeal by the IBA to CAS against the IOC board's recommendation failed this week.

Wizards trading Porzingis to Celtics, Smart headed to Grizzlies

WASHINGTON, June 22, (AP): The Washington Wizards have agreed to trade center Kristaps Porzingis to the Boston Celtics as part of a three-team trade that also includes Marcus Smart heading to the Memphis Grizzlies, two people with knowledge of the deal said Thursday morning.

The people spoke to The Associated Press on condition of anonymity because the agreements hadn't been announced. The trade comes with Porzingis accepting his player option for next season

The deal also includes the Grizzlies acquiring Smart, the 2022 Defensive Player of the Year, from Boston in exchange for first-round draft picks in 2023 and 2024. ESPN reported the Wizards are also receiving guard Tyus Jones from Memphis, and forwards Mike Muscala and Danilo Gallinari and a second-round pick this year from

The Celtics add the 7-foot-3 Porzingis after they lost in seven games to Miami in the

> Eastern Conference finals. Porzingis is coming off a solid season in Washington in which he averaged a career-high 23.2 points per game along with 8.4 rebounds. Most importantly, he



stayed healthy enough to play in 66 games, his most since 2016-17 when he was with the New York Knicks.

Porzingis' departure completes a swift breakup of Washington's core after the Wizards agreed to trade Bradley Beal to Phoenix, and Kyle Kuzma declined his option. Washington has missed the playoffs the past two seasons and is now clearly in a rebuilding mode under new team president Michael Winger.

Smart has played in Boston all nine of his NBA seasons, was its longesttenured player and one of the strongest presences in the locker room. He also ranks fourth on the franchise's career lists for 3-pointers (911) and assists (2,700). His departure leaves the Celtics with Derrick White and reigning Sixth Man of the Year Malcolm Brogdon as the top two candidates to replace Smart.

Smart brings much needed experience to a young Memphis team that needs help at point guard following the announcement of Ja Morant's 25-game suspension for next season. Smart also brings postseason experience to the Grizzlies, who have won only one playoff series despite finishing second in the West the past two seasons.

The Celtics reached the NBA Finals in 2022, but were unable to make it back this season despite their talented tandem of Jayson Tatum and Jaylen

Boston becomes Porzingis' fourth NBA team. Drafted in 2015 by New York with the fourth overall pick, he played three seasons with the Knicks before being traded to Dallas before the deadline in 2019 - when he was recovering from knee surgery. The Wizards acquired him from Dallas 16 months ago.

Bruce Brown is set to become a free agent after declining his \$6.8 million player option with the NBAchampion Denver Nuggets, a person with knowledge of the decision said Wednesday.

The person spoke to The Associated Press on the condition of anonymity because the move hasn't been announced. The NBA free agency period opens next week.

Brown signed with Denver last summer and became an integral piece off the bench for the Nuggets. He can play either guard position or small forward and averaged 12 points and four rebounds in a postseason that culminated with Denver knocking off Miami in five games during the Finals to win its first NBA title.

Nuggets coach Michael Malone said at the Nuggets' championship parade last week the team wants to keep Brown in their bid to defend their title. But the Nuggets cannot offer him more than \$7.8 million for next season; if he stays, Brown would be eligible for a four-year deal in Denver starting in 2024-25, with an initial salary of about \$14 million.

The 26-year-old Brown was a second-round pick in 2018 by Detroit out of the University of Miami. He played two seasons with the Pistons, and two more with Brooklyn, before joining a Nuggets team that includes a core of Jamal Murray, Michael Porter Jr., Aaron Gordon and Finals MVP Nikola

Issues mounting for England to add to pain of nail-biting loss in Ashes opener

LONDON, June 22, (AP): Losing the opening match of the series in a finalday nail-biter isn't England's only concern at the start of the Ashes.

In fact, issues already are mounting for captain Ben Stokes.

Stokes himself came into the series with lots of scrutiny about the state of his left knee - and he only bowled seven overs in a desperate bid to win the match for England late in the fourth innings at Edgbaston. Indeed, he barely celebrated dismissing Australia opener Usman Khawaja.

Is the knee still affecting him?

Moeen Ali, the replacement for injured spinner Jack Leach, has a problem now, too, because of a blister on his spinning finger that led to him dropping out of England's attack at times in both innings.

Then there are a couple of selection

dilemmas that have cropped up.
Jimmy Anderson, England's most successful bowler of all time, had a poor test by his standards and wasn't trusted with the new ball in those key final overs Tuesday as Australia squeezed out a two-wicket win.

Will taking only one wicket in two in-

nings at Edgbaston lead to the 40-yearold Anderson getting dropped for next week's second test at Lord's, with the likes of Mark Wood, Chris Woakes and newcomer Josh Tongue as options?

There might also be a conversation to be had about the wicketkeeper, too, after a couple of dropped catches and a missed stumping by Jonny Bairstow proved costly.

Bairstow was recalled after injury

and replaced Ben Foakes, a specialist behind the stumps, in the team. Might there be room for both, with Bairstow playing as an out-and-out batter?

That's plenty of things for Stokes to ponder while he attempts to get over an agonizing loss that puts England in a tough position in the series. The English must win it to regain the Ashes because a drawn series would see Australia retain the urn.

Stokes' team, then, must go on the attack to win at least two tests. That fits England's new approach just fine.

"The way in which we applied ourselves, literally from ball one, proves we are able to stand up to Australia in the way in which we want to play,' Stokes said. "There was a big question before coming to the series about how we are able to still continue with the style of play against such a good Aus-

UEFA bans Mou for abusing ref

GENEVA, June 22, (AP): José Mourinho was banned by UEFA from four European games for verbally abusing the Europa League final referee in a stadium garage after Roma lost to Sevilla.

Footage circulated after the May 31 final of the Roma coach approaching English referee Anthony Taylor in the garage in Budapest and calling him a "disgrace" with an expletive.

Roma lost a penalty shootout to Sevilla after a 1-1 draw which was the Italian club's last chance to qualify for the Champions League next season

Mourinho is set to serve the ban in the Europa League group stage starting in September, after being found guilty of "directing abusive language at a match official," UEFA said in a statement announcing its disciplinary panel's verdict.

SOCCER

The ban is double the minimum two-game ban required by UEFA disciplinary rules.

One day after the final, Taylor and his family were harassed by Roma fans at the airport in Bu-

UEFA also fined Roma 50,000 euros (\$55,000) and will block the club selling tickets for its next away game in the Europa League. The charges included "lighting of fireworks, throwing of objects, acts of damage and crowd disturbances," UEFA said.

Roma must also contact the Hungarian soccer federation to settled damages caused by its fans at Puskas Arena. Roma was fined a further 80,500 euros for fan disorder and stadium organization issues in the first leg of the semifinals against Bayer Leverkusen.

UEFA ordered Roma to close two sections of Stadio Olimpico totaling 6,000 seats at its first Europa League home game in September. At the Europa Conference League final on June 7, Fiorentina captain Cristiano Biraghi was struck and cut by an object thrown from the West Ham fans' section of the stadium in Prague and left with a bloodied head.

Hjelle (2-1) allowed three hits and had five strikeouts, including one of Tatis, who went down swinging to end the top of the fifth with runners at second and third. Four relievers followed Hjelle. Camilo Doval got the final three outs for his 20th save.

Trent Grisham had two hits and a RBI for San Diego. The Padres have lost five of seven.
