Biometric system installed to forestall ID forgery

All borders covered

KUWAIT CITY, May 10: The land, air and sea borders in the country on Wednesday started using the central biometric system to verify the face prints, fingerprints and electronic signatures of all departing and arriving travelers - Kuwaiti, Gulf and other nationalities, reports Al-Anba daily quoting sources.

Sources confirmed that the General Department of Information Systems, in cooperation with the General Department of Criminal Evidence and Borders Security Sector, installed the biometric devices last week with the aim of creating the largest database for travelers.

Sources disclosed the system is connected with the borders of all Arab and Gulf countries to ease coordination and follow up in terms of security. Sources said this will prevent those wanted by law from forging documents, as their data will be revealed immediately through the system.

Select committee to deplete, diversify labor demographic

Panel vows fresh determination

KUWAIT CITY, May 10: Barely 10 days after the formation of the National Committee for Regulating the Demographics, headed by First Deputy Prime Minister, Minister of Interior and Acting Minister of Defense Sheikh Talal Al-Khaled, the Al-Qabas daily said the government of Kuwait is determined to uproot vice from society, purify the labor market of menial workers and clamp down on visa traders.

Moreover, the committee is tasked with looking into the Kuwaitization of jobs in the state institutions. The sources indicated that Al-Khalid has instructed the Public Author-

ity for Manpower and other concerned institutions to exert more efforts to modify the demographics and intensify the efforts of the Ministry of Interior to arrest thousands of expatriates who are violators of the residence and labor

laws and identify and eliminate fake companies and also

identify those who sell visas

and work permits. The Minister of Interior also stressed -- according to the sources -- the need to accelerate opening up to new countries that

export skilled labor.

Meanwhile, the sources revealed that the Public Authority for Manpower and the concerned authorities referred to the Public Prosecution 139 cases of visa trade over a period of four years-from 2019 until the end of 2022.

The sources told the daily during the past year alone 16 cases of visa trade were referred to the Public Prosecution constituting eight times more since in 2021 only two such cases were identified.

According to the sources, 2019 and 2020 were the highest records of referrals to the Public Prosecution Office, with a total of 121 visa trade cases.

In the same context, the head of the Migrant Workers Committee at the Kuwaiti Human Rights Society, Mishari Al-Sanad, told Al-Qabas that the sponsorship system causes some workers to live in a tragic situation, as a result of the employer's delay in paying their salaries, forced laoor and filing malicious reports without the worker's knowledge which contributes to the high volume of this type of issues.

Al-Sanad added that forcing workers to work overtime without additional pay and housing are not suitable for human life due to the large number of workers huddled in a small place and to add insult to injury the owners of companies circumvent the law to their benefit, in addition to closing the company file without informing the worker and as a result the worker falls foul with the law.

Al-Sanad referred to the report of the US State Department that was issued last year, as Kuwait's rating decreased due to these issues, stressing that there was a failure to provide evidence of increasing efforts to combat such issues, indicating that the number of victims is large and increasing, and the government has not taken concrete and

sufficient measures to protect them. Al-Oabas learned that the tripartite committee was able, in iust eight days in May, to arrest 205 violators of the Labor and Residence Law, 89 of whom were included in the list of those prohibited from renewing work permits, after confirming that they had purchased residency

Informed sources said that the committee referred those in charge of the fictitious company seized in the Jleeb Al-Shuyoukh area, which sells visas to the competent authorities, while 13 fictitious offices managing domestic workers were raided in the Farwaniya and Mubarak Al-Kabeer Governorates.

Next parliament without programs

of candidacy for the parliamentary elections until next Sunday, a number of aspirants announced their withdrawal from the race.

There is no doubt that each of them have their own base of supporters, and a way to test the political pulse of the people and discover the extent of the people's reluctance and tedium towards the lack of productivity of the previous parliamentarians. It may also be because they saw that the atmosphere was different from before, and therefore they chose to stand on the sidewalk of time, waiting for a better opportunity.

Irrespective of the results, there is evidence that these elections are different in form compared to the previous ones. However, the content is the same and cannot be relied upon. This is due to the fact that the title of a book tells a lot about the book itself. When looking at those who are presenting themselves to be part of the next parliament, nothing is promising at all.

Popular discontent has reached its extreme. Of course, the government will not be able to perform miracles in the remaining few years of its life. Rather, it is working on lost time, due to which we will not witness any reliable changes from the two authorities.

On this principle, the political leadership can play a role by issuing major decisions to change the situation in Kuwait, either in resolving the housing problem, or working to revive the industrial sector, enhance food security, reduce unemployment among Kuwaiti youth, restore the political situation, and open the country in front of the investors. The people have been waiting for years for decisions in this regard, but neither the successive governments nor the parliaments have made laws that deserve people's approval.

Based on what Kuwait is going through today, it is not possible to get out of this situation except with a will greater than an employee at the level of a minister, not a MP who is only concerned with investing in people's votes to enhance his financial and electoral assets. It is not possible to remain convinced that constitutional institutions alone bear responsibility for failures.

As per logic, we all bear the burden of what the country has reached, so the leadership alone can get the country out of this situation because it has actual powers that no one can override.

There is no doubt that the world is changing in these major political moments that the events ended with. There are new rules drawn in economics, politics and even geography. All of this requires confronting it with precision and a correct assessment of the positions.

Consequently, it affects Kuwait negatively if it does not prepare for the coming events, and works to fortify its internal front in all aspects particularly economically, socially, security, and politically. It impacts Kuwait positively if it has prepared its tools for confrontation, and worked to enjoy great capabilities to deal with any emergency.

For instance, last Monday, the government approved a draft law to abolish the Public Authority for Roads and Transportation. Although it is of no practical importance, it is a clear indication of how matters may end up.

It is true that it is just a proposal, but it needs to be approved by the National Assembly, that is, a return to the same vicious circle, while necessary decrees may be issued that can end this cycle.

What people are waiting for today is a firm decision that can end their problems and the crises caused by each of the successive governments and parliaments.

Time is pressing, and the acceleration of events in the world and the region does not allow the luxury of entertaining the outcome of the coming elections.

Rather, it is necessary to work quickly to bridge the gaps and take firm decisions to prevent what could further weaken Kuwait. This is what the people hope for from the political leadership because it is clear that we will be faced with a parliament without programs, but with just rhetoric that neither nourishes nor avails against hunger.

KUWAIT CITY: The Foreign Ministry Tuesday expressed Kuwait's condemnation and denunciation of the Israeli occupation forces' aggression on the besieged Gaza Strip and the storming of Nablus

In a statement, the ministry stressed Kuwait's absolute rejection of this dangerous escalation and repeated attacks that constitute a continued series of crimes committed by the Israeli occupation forces against the brotherly Palestin-ian people and a flagrant violation of international humanitarian law.

The Ministry renewed its call for the international community and the Security Council to bear their responsibilities and take an action to immediately stop those attacks and provide full legal and civil protection to Palestinian brothers, in accordance with the UN Charter and international laws, the statement said.

KHARTOUM: As part of "Kuwait by your side" humanitarian campaign, the first batch of support containing 75 tons of material arrived in Sudan met by the

people's praise and adulation. Speaking to KUNA on this occasion, Kuwaiti Ambassador to Sudan **Dr. Fa-**had Al-Dhafiri told KUNA that his country was keen on supporting Sudan during such turbulent times, saying that additional relief aid material would be sent in coordination between Kuwaiti and Suda-

nese authorities. The Sudanese doctors union revealed that 69 percent of medical services and clinics near the areas of conflict had ceased operations, while 27 hospitals were struggling to operate due to the lack of staff and material.

The Kuwaiti and Sudanese red crescents societies had delivered thus far thousands of relief aid material, foodstuff, and medical supplies to those affected by the violence in Sudan. (KUNA)

WASHINGTON: The Justice Department said Tuesday that it had disrupted a longrunning Russian cyberespionage cam-paign that infected computer networks in dozens of countries, including in the United States, and resulted in the theft of

sensitive information from governments. Prosecutors linked the spying operation to a unit of Russia's Federal Security Service, or FSB, and accused the hackers of stealing documents from hundreds of computer systems belonging to governments of NATO members, an unidentified journalist for a U.S. news organization who reported on Russia, and other select targets of interest to the Kremlin.

'For 20 years, the FSB has relied on the Snake malware to conduct cyberespionage against the United States and our allies - that ends today," Assistant Attorney General Matthew Olsen, the head of the Justice Department's National Security Division, said in a statement. (AP)

WASHINGTON: President Joe Biden will host Indian Prime Minister Narendra Modi next month as part of Modi's trip to the **United States** that will include honors


at an elaborate White House state dinner. White House press secretary Karine Jean-Pierre said Wednesday that Modi's June 22 visit "will affirm the deep and close partnership between the United States and India and the warm bonds of family and friendship that link Americans and Indians together.

Biden last hosted Modi at the White House in September 2021.

Modi is the third world leader to be invited on a U.S. state visit by Biden, following French President Emmanuel Macron late last year and South Korean President Yoon Suk Yeol in April. (AP)

TUNIS: The number of people killed in a gun attack on a synagogue on the Tunisian island of **Djerba** during an annual Jewish pilgrimage has risen to five, Tunisia's TAP news agency said Wednesday. The victims were two Jewish pilgrims and three Tunisian police guards.

A police guard who had been hospitalized after Tuesday's attack died from his injuries on Wednesday, according to a medical official cited by TAP. Four other members of the security forces remain hospitalized in Djerba, including one in critical condition, according to TAP. (AP)

Beards balk as women brandish beauty

TEHRAN, May 10, (AP): Billboards across Iran's capital proclaim that women should wear their mandatory headscarves to honor their mothers. But perhaps for the first time since the chaotic days following Iran's 1979 Islamic Revolution, more women - both young and old

Such open defiance comes after months of protests over the September death of 22-year-old Mahsa Amini in the custody of the country's morality police, for wearing her hijab too loosely. While the demonstrations appear to have cooled, the choice by some women not to cover their hair in public poses a new challenge to the country's theocracy. The women's pushback also lays

bare schisms in Iran that had been veiled for decades. Authorities have made legal threats and closed down some businesses serving women not wearing the hijab. Police and volunteers issue verbal warnings in subways, airports and other public places. Text messages have targeted drivers who had women without head covering in

However, analysts in Iran warn that the government could reignite dissent if it pushes too hard. The protests erupted at a difficult time for the Islamic Republic, currently struggling with economic woes brought on by its standoff with the West over its rapidly advancing nuclear program.

Some women said they've had enough - no matter the consequence. They say they are fighting for more freedom in Iran and a better future for their daughters.

Some suggested the growing numbers of women joining their ranks might make it harder for the authorities to push back.
"Do they want to close down all businesses?" said

it was rare to see women without headscarves, though some occasionally let their hijab fall to their shoulders. Today, it's routine in some areas of Tehran to see women without headscarves.

For observant Muslim women, the head covering is a sign of piety before God and modesty in front of men outside their families. In Iran, the hijab - and the all-encompassing black chador worn by some - has long been a political symbol as well.

Iran's ruler Reza Shah Pahlavi in 1936 banned the hijab as part of his efforts to mirror the West. The ban ended five years later when his son, Shah Mohammad Reza Pahlavi, took over. Still, many middle and upperclass Iranian women chose not to wear the hijab.

By the 1979 Islamic Revolution, some of the women who helped overthrow the shah embraced the chador, a cloak that covers the body from head to toe, except for the face. Images of armed women encompassed in black cloth became a familiar sight for Americans during the U.S. Embassy takeover and hostage crisis later that year. But other women protested a decision by Grand Ayatollah Ruhollah Khomeini ordering the hijab to be worn in public. In 1983, it became the law, enforced with penalties including fines and two months

Forty years later, women in central and northern Tehran can be seen daily without headscarves. While at first Iran's government avoided a direct confrontation over the issue, it has increasingly flexed the powers of the state in recent weeks in an attempt to curb the practice.

In early April, Iran's Supreme Leader Ayatollah Ali Khamenei declared that "removing hijab is not Islamically or politically permissible."

Khamenei claimed women refusing to wear the hijab are being manipulated. "They are unaware of who is behind this policy of removing and fighting hijab,' Khamenei said. "The enemy's spies and the enemy's spy agencies are pursuing this matter. If they know about this, they will definitely not take part in this

Hard-line media began publishing details of "immoral" situations in shopping malls, showing women without the hijab. On April 25, authorities closed the 23-story Opal shopping mall in northern Tehran for several days after women with their hair showing were seen spending time together with men in a bowling al-

'TRACES OF NOSTALGIA'

OST&TOUNC A BIT OF BOTH

On April 29, Sadu House hosted the opening of an exhibition titled 'Traces of Nostalgia' by Studio SADI artist-in-residence Hanadi Al Marzouq at 7 pm. "This Studio SADI with resident artist Hanadi Al Marzouq has been a beautiful process that has come to life," observed Sheikha Bibi Duaij Al Sabah, Chairperson of Sadu House. "The artist went into deep layers of the deep-rooted symbolism and traces of this traditional art. She searches for its modern-day references and invites artists to be inspired and more inclined to use it within their design process."

SADI is an ambitious program the Al Sadu Society envisioned to encourage creativity and innovation in contemporary textile arts and design for artists in Kuwait. The diverse textures and techniques, rich colours, and bold symbolism in textile art led the Al Sadu team to introduce the Sadu Art and Design Initiative (SADI). This program strives to encourage out-of-the-box thinking and cultural exchange in the field of textile arts.

During the SADI residency, artists undergo an immersive mentorship program that includes weekly talks, workshops, research exercises, and access to the Sadu House permanent archives and library that expand their understanding of textile arts.

Shahad Bishara, an art consultant and curator, worked with Hanadi for three months on the ideation and execution. "There were different ideas, and we turned them into a full-on story, ensuring that each work is somehow connected." Shahad has curated exhibitions since 2009 and worked with many artists locally and regionally. "You have to look below the surface in this exhibition," she said. "We have worked hard on the text and the descriptions to relay the uniqueness of the exhibits. It is one thing to look at. To understand it, you must read the description.

Hanadi Al Marzouk, an MFA from the Sotheby's Institute of Art, is an experienced product designer skilled in art and graphic design. In the exhibition 'Traces of Nostalgia', Hanadi has explored different mediums and motifs to explore the deep meanings of heritage, culture, its transience, and relevance. The exhibition includes five installations which are research-based and go beyond mere aesthetics. It acknowledges the discovery of oil as a catalyst for modernization. At the same time, the blessing is not unalloyed but has its share of loss.

The premise of 'Traces of Nostalgia' is that the abundance of material wealth and increasing consumerism due to oil wealth have rendered heritage in terms of locally crafted objects irrelevant. Sudden oil wealth has also affected the country's built landscape, leading to the demolition and bulldozing of traditional buildings, creating a state of imbalance and impermanence. The exhibition draws attention to this imbalance and examines the shifts.

Heritage

The exhibition, which features textiles, video and installation art, urges the audience to reflect on the importance of preserving heritage and recontextualizing the narrative of heritage craft. Explaining the lone sculpture of a man carrying symbols of lost heritage on him like medals, Hanadi said, "Everything became an event with the coming of oil. It was both a blessing and a curse that bound us in cycles of consumerism. What I am trying to do with my art is rethinking those symbols and transforming them into functional motifs." The mixed media sculpture installation titled 'The Prophecy' fuses various materials such as ceramic, brass, and collage, transporting oil from static to living, drawing attention to the fact that the purpose of the exhibition is not to recover what has been lost but to expand the potential of contemporary identities of Kuwaitis influenced by this dichotomous

When asked about the importance of conserving cultural heritage, Hanadi said, "I hope this exhibition will create shifts in social and environmental behaviour. What we are trying to do is raise some

"Social transformation starts with culture, and culture is more important than ever before," observed Sheikha Altaf Al Sabah, noted anthropologist, researcher, author, cultural advocate, and co-founder and patron of Sadu House. "There will come a time when boundaries will cease to exist. It is important that communities preserve their own special characteristics in an inclusive way. We are all the same, but each culture or community has its own story, its own smell. It's important to preserve that."

May Al Marafie, a designer and artist who collaborated with Sadu House on her capstone project, was part of the large, engaged audience flocking the courtyard. May was poring over 'The Trace' Hanadi's main installation, which features tire tracks on a pathway of sand made up of Sadu Motifs. In this installation, Hanadi deconstructs the language of traditional symbols found in Sadu textiles and uses them as functional motifs. The central part of this installation is a tire, a symbol of a consumerist mindset, manufactured from recycled rubber whose tracks reveal the ephemeral Sadu symbol impressions on the sand. "To every person in this room, the centrepiece will be different, but this installation draws my attention," said May. "Sadu was born out of necessity, but it is now a historical document about society and the struggles the weaver faced in her journey.

SADI as a cultural project has drawn attention since its introduction. On Saturday evening, Bayt Al Sadu, which has a spirit of its own, basked under the attention of the large crowd and well-wishers who flocked to its courtyards to view the exhibition. "SADI; Sadu Art and Design Initiative was formally introduced as a program in 2016. It has two components the collective SADI residency for emerging artists and the Solo Studio SADI residency, where we support artists to explore, engage and reimagine the cultural heritage of traditional Sadu weaving," noted Sheikha Bibi Al Sabah. "Since inception, we have more than 30 artists who have completed the residency and continue to build a community of artists and designers. We continue to grow this community by providing platforms, opportunities and programming."

By-elections prohibited

Decision on media poll coverage issued

KUWAIT CITY, May 10: In confirmation of a recently-published article titled "Media: An integrated plan to keep pace with the elections", the Minister of Information Abdul Rahman Al-

Mutairi issued a decision regarding the conditions and controls for media coverage, advertising, and promotion of the National Assembly elections, reports Al-Qabas

As per the decision, electronic media, audio-visual channels, and licensed newspapers will be allowed to conduct opinion polls that deal with electoral affairs, in line with three conditions:

1. Polls related to elections are to be conducted after obtaining a license from the Ministry of Information and the approval of the concerned au-

2. They should be characterized by objectivity and adherence to generally accepted scientific and professional principles.

3. They should not include any of the prohibitions stipulated in the law.

The decision prohibited the organizing of byelections, and the printing, publishing, broadcasting or re-broadcasting of anything that would call for their organization or participation. It also bans any advertising or promoting any news or data re-

The decision also called on all electronic media, audio-visual channels, and print newspapers to distinguish between media news and electoral advertisements, when covering the activities of election candidates, by indicating the advertising character of the latter.

It banned coverage of anything that could harm the electoral process or candidates directly or in-

It forbade specifying the method of advertising or coverage as presenting financial inducements or giving, offering or pledging to give the voter something to induce him to vote in a certain way or to abstain from voting.

The decision asked all media outlets, when publishing, broadcasting or re-broadcasting statistics, opinion polls and their results, to commit to mentioning the authorized party that conducted them, the date of their conduct and the number of respondents in the poll, in addition to not announcing the election results or their official final averages and percentages, before announcing them from the competent authorities.

The decision prohibits all media outlets from broadcasting, rebroadcasting or publishing any interviews, programs, or reports related to candidates on polling day and the day preceding it, which is known as electoral silence.

It is forbidden to broadcast, rebroadcast or publish any of the reports or audiovisual works that include propaganda or media coverage about any of the candidates or about the general elections, unless they are in accordance with the provisions of the relevant laws.

The decision stipulated that the media outlets of all kinds must apply to the Ministry of Information (press, publishing and publications sector) for permits for their journalists who will participate in covering the electoral process, through a form that has been prepared for this purpose, and in accordance with the conditions and controls specified

Minister opens poison control center

Anti-smoking campaign launched

KUWAIT CITY, May 10, (KUNA): Minister of Health, Dr. Ahmad Al-Awadhi, inaugurated Wednesday the Kuwait Center for Poison Control as the first center specialized in following up on poisoning cases, providing advice and treatment plans, controlling toxic substances, and coordinating with the concerned state institutions.

In a press statement, the minister said that the center carries out a number of tasks and provides information based on scientific evidence regarding poisoning cases.

For his part, the Center's Head, Dr. Abdullatif Al-Oumi, affirmed that the center specializes in organizing laboratory tests related to toxins, preparing studies on poisoning cases, coordinating with the concerned authorities to monitor toxic substances, and training medical staff.

Meanwhile, constitutional expert Professor Ibrahim Al-Homoud said the explanatory memorandum of the Constitution states that members Al-Sabah Family are not allowed to run for parliamentary elections. He added the Constitution regulates the ruling family's contribution in the government by allowing them to occupy ministerial positions and the prime minister post. He clarified the Al-Sabah Family members are banned from running for election, because those who drafted the Constitution wanted to keep the family away from political disputes which usually happen in elections.

In addition, the Constitutional Court has confirmed receiving the appeal filed by former MPs and members of the nullified 2022 Parliament - Muhammad Al-Mutair, Hamad Al-Obaid, Yousef Al-Bazzali, Mubarak Al-Hajraf and Fares Al-Otaibi as well as Muhammad Al-Mahan - to reinstate the 2022 legislature. They demanded for the cancellation of the decision to nullify the 2022 Parliament, because the ruling was based on the erroneous decree for holding fresh elections. They argued this is not part of the authority of the court, since it is a sovereignty issue.

On the other hand, former MP Marzouq Al-Khalifa, who submitted his candidacy to the General Department for Election Affairs at the Ministry of Interior, is currently in prison for participating in the tribal primary election.

Fourth Constituency candidate Abdulrahman Al-Aqwani, who is blind, disclosed that his electoral agenda focuses on issues concerning people with disabilities including the blind.

Former MP Shuaib Al-Muwaizri told journalists after filing his candidacy that "the ratification of laws is not necessary in solving urgent issues like education, housing and health. The government must take decisions and measures in this regard. In the 2022 Parliament, we started forming fact- finding committees to conduct investigations, but we were not given the chance to complete the task due to the nullification of that leg-

Suspension ordered: Acting Undersecretary of the Ministry of Social Affairs Abdulaziz Al-Mutairi has confirmed that the ministry decided to suspend the general assemblies and elections of the board of directors of cooperative societies from June 8-16 in light of the National Assembly election on June 6, reports Al-Anba daily.

Al-Mutairi revealed in a press statement that the ministry took this decision after receiving a letter from its Interior counterpart on the need to suspend the above-mentioned activities due to the upcoming parliamentary election.

'60-yr-olds decision not right way to modify demographics'

"OVER the past few years, the government has taken ill-considered decisions, and all the social, legal, administrative, and economic aspects of those decisions have not been studied, and the extent of their impact on business owners and company owners, including, for example, the 60-year employment decision, which forces a worker, who is over 60 years old, to leave the country or to pay unreasonably high fees for his one-year renewal of residence permit if he does not hold a university degree," columnist Fawaz Ahmed Al-Hamad wrote for Al-Qabas daily.

"This is not the right way to modify

the demographics. It was possible to set a "quota" or a specific percentage for each nationality to enter Kuwait, and not by specifying the age of 60, because there are workers with a lot of experience, and their exit from Kuwait will not reduce or



improve the demographics. 'Many technicians have completed 60 years of age, and do not have a university degree. Some of them left the country, and others will leave soon, including those with specializations and technical professions, as they obtained these experiences through years of work in Kuwait, so why should they be dispensed with so easily?

"There are professions that the Kuwaiti worker cannot currently fill or practice, due to the lack of government support for these professions, including the plumber, blacksmith, carpenter, air conditioning work, ceramic installation, surveying work, roofing installation, wall painting, electrical work, and insulation work. This miserable decision created a gap and caused a problem in the labor market.

"The prices of some jobs for professions have increased due to the 60-yearold decision, so there is a big problem in the labor market in Kuwait because of this decision, so the simple citizen will pay the price dearly from his own account because of this ill-conceived decision.

"Many countries pay millions to attract tourists and workers to work on their lands, and Kuwait expels workers for no apparent reason.

"Kuwait has become a repelling environment for investment and for business owners and company owners, due to laws that do not encourage work in Kuwait. Many business owners moved their trade and business abroad because of the attractive investment opportunities, and the ease of executing and completing business in those countries, in contrast to the obstacles and bureaucracy that exist in Kuwait.

Kuwait continues to fl enter a dark tunnel, and there are no signs of reform. The road is long, and I hope that decisions will be taken to correct the course and develop Kuwait before it is too late, because the current road is dark. Will the current government be able to fix what was corrupted by some previous governments?"

Also:

"In this period, we are witnessing the registration for the upcoming elections 2023, and the candidates' statements are juicy filled with promises to look into the development files of the country, and the question that deserves consideration and research in this milieu is the democratic process," columnist Dr Ghadir Muhammad Asiri wrote for Al-Qabas daily.

"Why are elections held in such atmosphere which is not conducive to democracy? Is the rule of the majority always right? We find an explanation for this question that the majority of society does not necessarily have to be right or correct, and elections in many countries do not achieve the desired result for building societies, and do not

represent the general will. "It is important before any elections that many important rules be made available, such as integrity and transparency, and an emphasis on guaranteeing voters' freedom of choice, freedom of competition, and equal opportunities between candidates, and that there be equal opportunities for presenting

candidates' ideas, visions, and future perceptions, and that there be a ceiling for spending on electoral campaigns to stop exorbitant trading and buying votes indirectly, such as payment to workers in the campaign or delegates, unfortunately, in exchange for money that violates the rules of equality in electoral competition.

"There is a legislative deficiency in some laws that contain loopholes, such as the rampant behavior in the elections by the voter, who offers his vote for sale. There is no law that protects the candidate from these prevailing behaviors, as the vote is presented by the voter to the candidate in some electoral

"The most important factors of democracy and true citizenship are the cohesion of all the poles and citizens of the state. If there are groups that have a separatist tendency or a sense of external ethnic or sectarian affiliations, a successful democracy cannot be established in that country.

"It is also important that there be an independent body that is not related to any affiliation or political pressure to supervise the elections, so that there is no influence on the choices and the voting results, and it is a good idea to change the polling sites to be accessible to all, and it is known as an easier mechanism than the voting being ef-

'We must propose and demand a change in polling places, and that voting be prohibited in schools, so that the educational process is not disrupted because it affects the concept of neglect in education, as some countries tend to encourage voting by the presence of polling stations in shopping centers, malls or social events halls and not to disrupt the educational or community

"One of the foundations of democracy is an organized political society that is capable of practicing meaningful political action, and with the existence of these elements, there must be a fair and impartial electoral system that is appropriate to the nature of the citizens in the country.

"This is in addition to a system that reflects all groups without discrimination in society, including women. It is logical that 52% of the population are women, i.e. the majority, and they are almost non-existent, or are timid if they exist with modest success. Here it is important to have an electoral system that supports their presence and representation in society, so that justice and equality can be achieved in their issues and interests so that society can advance.'

"We hope the next National Assembly will set priorities, implement projects and ratify laws in the interest of the country and citizens, as well a new stage, especially after the disruption of many projects and laws due to political crises, division into two teams - for and against, and distribution of national bonds. We wish it will raise the slogan of fighting against corruption and corrupt people in the State," columnist **Dr Thayer Hadi** wrote for **Al-Anba** daily.

"Realistic reform can be achieved only through constitutional and legislative channels, including an agreement between members of the Assembly and government to work on a rescue plan for the country. This starts with the common points between the Assembly and government to issue laws on the advancement of the development process that was stalled due to the fabrication of crises

"The people are fed up and tired of squabbles on social media – a virtual world, while repercussions, causes and accusations are reflected in the real

"Indeed, we need a real reform vision and efforts of State agencies and institutions to support the reform process. In this manner, the citizen becomes the basis for construction and reform. Kuwait is full of youths who are competent in scientific and practical fields. They are capable of making the impossible possible and facing future

Positions weren't filled in various faculties

SAB urges Kuwait University to expedite appointment of leaders

KUWAIT CITY, May 10: The State Audit Bureau has called on Kuwait University to expedite the appointment of the leadership positions in the various faculties of the university, reports Al-Anba daily.

According to informed sources, the State Audit Bureau, in its annual report, referred to the observations that marred the appointment of deans and heads of academic departments.

It explained that leadership positions were not filled in the various faculties of the university in accordance with the approved organizational structure, and what was stated in the law has not been implemented, which may negatively affect the flow of work in colleges.

The university did not do what was stated in articles 11, 17 and 21 of law No. 76/2019 regarding public universities and article 3 of its executive regulations regarding the requirement to announce the vacancy of the dean's position. The university council did not issue a decision to select candidates for the position of dean, announce the vacancies for the positions of heads of practical departments in colleges, and open the door for candidacy for such fields.

This happened despite the approval of the Council of Public Universities on the conditions, criteria and procedures for candidacy for the following positions university rector, deputies of the rector, deans of specific faculties and deanships, assistant deans, assistant deputies of the university rector, heads of scientific departments, and the like - and the issuance of the decision No. 90/2021 by the Minister of Higher Education on May 23, 2021 and its amendments in this regard, the second article of which stipulates that the decision be implemented as of its date on which the Commission made a statement to that effect

Its strategy in the next phase is based on preparing means of stability for the city's residents, by providing road lighting, water services, and coordination with the relevant government agencies to take over and operate service public buildings so that they are available in the city, so that citizens do not need to move around in search of basic services that they need.

Meanwhile, the exhibition coordinator Engineer Khaled Al-Otaibi said, "The aim of holding this exhibition, in which more than 70 sectors



Wall St. mixed after inflation report

Asia dips ahead of US report

NEW YORK, May 10, (AP): Wall Street is mixed on Wednesday after a report showed inflation is making strides toward easing, even if it remains too high.

The S&P 500 was 0.2% higher in midday trading after giving up most of an earlier gain. The Dow Jones Industrial Average was down by 104 points, or 0.3%, at 33,457, as of noon. Eastern time, and the Nasdaq composite was 0.7% higher.

Bond prices climbed after the highly anticipated report said inflation at the consumer level edged down to 4.9% last month, its lowest level in two years. That was slightly better than economists expected, and other underlying measures of inflation also came in very close to forecasts.

Because the inflation data was roughly as expected, Wall

Default 'not an option'

Debt meeting 'productive'

WASHINGTON, May 10, (AP): President Joe Biden and congressional leaders confronted each other on the debt limit impasse Tuesday, ending their meeting with no breakthrough but agreeing to meet again this week to try to avert the looming risk of an unprecedented government default.

Speaking at the White House, Biden described the talks as "productive" even though House Speaker Kevin McCarthy said after the high-stakes Oval Office meeting that he "didn't see any new movement" toward resolving the stalemate.

Lawmakers and their staffs were to continue discussions on the annual federal budget at Biden's encouragement. Biden and the congressional leaders are to meet again Friday.

After the hourlong discussion in the Oval Office, Biden said he was "absolutely certain" that the country could avert a default, declaring that failure to meet America's obligations "is not an option."

Still, time is short. The government is bumping up against its legal limit for borrowing and will not be able to pay all of its bills as soon as June 1 if Congress doesn't agree to raise the debt ceiling. That failure would send the country into default with wide-reaching economic impact at home and around the world.

Republicans came to the White House hoping to negotiate sweeping cuts to federal spending in exchange for allowing new borrowing to avoid default. Biden, on the other hand, reinforced his opposition to allowing the country's full faith and credit to be held "hostage" to negotiations - while affirming his willingness to hold talks on the budget only after default is no longer a threat.

"I told congressional leaders that I'm prepared to begin a separate discussion about my budget, spending priorities, but not under the threat of default." Biden said.

Outside the White House, McCarthy said, "I asked the president this simple question: Does he not believe there's any place we could find savings?"

any place we could find savings?"

As the president welcomed McCarthy, House Democratic leader Hakeem Jeffries, Senate Majority Leader Chuck Schumer and Minority Leader Mitch McConnell, he quipped to reporters, "We're going to get started, solve all the world's problems."

Biden later described the meeting's tone as "very measured and low-key," adding, "Occasionally there would be a little bit of an assertion that maybe was a little over the top from the speaker."

He especially took issue with McCarthy's branding as a lie the Democrats' assertion that the Republicans' budget restraints would hurt veterans.

Still, Biden added, "I trust Kevin will try to do what he says."

There seemed to be at least a bit of daylight between McConnell, who has let his House counterpart take the lead in
negotiations and backed him up ahead of the White House
meeting, and McCarthy.

The Senate leader said: "The United States is not going to

The Senate leader said: "The United States is not going to default. It never has and it never will." The speaker, though, simply said, "I've done everything in my power to make sure we will not default."

Democrats said there is room to "come together" on spending cuts as part of the budget process, but quickly jumped on McCarthy's refusal to rule out the possibility of default, with Schumer saying the Republican is "greatly endangering America."

"To use the risk of default, with all the dangers that has for the American people, as a hostage and say it's my way or no way, are mostly my way or no way, is dangerous," Schumer said.

McCarthy said Biden had directed their staffs to continue discussions, and said the leaders themselves would convene again in person Friday at the White House.

While Biden ruled out default, he also all but dismissed trying to unilaterally prevent it. He said he didn't believe invoking the 14th Amendment of the U.S. Constitution, which says the validity of the federal debt shall not be questioned, was a solution to the current impasse.

White House lawyers will pursue the idea further, he added, but "the problem is it would have to be litigated."

Before the White House meeting, both McCarthy and White House press secretary Karine Jean-Pierre insisted it would be simple to avert default - if only the other side capitulated.

The chasm between these opposite postures had fomented uncertainty that is roiling financial markets and threatens to turn into a tidal wave that swamps the country's economy. Default, officials say, threatens to disrupt Social Security payments to retirees, destabilize global markets and tilt the nation into a potentially debilitating recession.

Last month, House Republicans passed a sweeping bill to slash spending, an opening offer in negotiations. But that legislation has no chance in the Democratic Senate and the White House has threatened to veto it. Republicans hope that bill would achieve \$4.5 trillion in deficit savings through cuts in spending, eliminating tax breaks for investing in clean energy, and reversing Biden's plans to reduce the burdens of student loan debt.

Referring to the House bill, McCarthy said, "We both said default is not an option - but only one of us took action."

Already looking past the meeting, Biden on Wednesday is to go to Westchester County, New York, where he plans to deliver a speech on how proposed spending cuts approved by House Republicans could hurt teachers, older adults needing food aid and veterans seeking health care.

It's part of a broader campaign by Biden to try to paint the Republican cuts as draconian. Aides believe that message both strengthens his position in talks with the GOP and boosts his nascent 2024 reelection effort. His Wednesday visit will be to a congressional district won by Biden in 2020

but now represented by a Republican, Rep. Mike Lawler.

Because the House Republican bill does not specifically spell out which federal programs would be cut, Democrats have gone on offense warning of steep hits to popular programs. The Democratic-aligned group House Majority Forward announced a \$1 million campaign Tuesday amplifying such cuts, while the House Republicans' campaign committee countered with its own effort portraying Democrats as "addicted to spending."

Street sees the door still open for the Federal Reserve to leave interest rates alone at its next meeting in June. That would be the first time it hasn't raised rates at a meeting in more than a year, and a pause would offer some breathing room for the economy and financial markets.

"The concern coming in was that it would be hotter than feared," said Ross Mayfield, investment strategy analyst at Baird. "While not exactly an exciting report, I think there was enough good news baked in that it shouldn't impact the Fed or the economic trajectory all that much."

Japan's benchmark Nikkei 225 lost 0.4% in afternoon trading to 29,136.92. Australia's S&P/ASX 200 inched down 0.1% to 7,255.70. South Korea's Kospi slipped 0.9% to 2,488.42. Hong Kong's Hang Seng dipped 0.4% to 19,783.56, while the Shanghai Composite shed 1.4% to 3,309.98.

Market watchers are also worried about any signs of economic woes in China after recent data showed imports were lagging, even as exports continued to grow, although at a slower pace than before. Focus remains on what the U.S. Federal Reserve might do on interest rates. Although the general consensus is that hikes are over for now, that view could quickly change.

"Market reaction is expected to be skewed in the event of a miss on the data, as the Fed has indicated it is prepared to raise interest rates again if needed," said Anderson Alves at ActivTrades. In the bond market, the 10-year Treasury yield rose to 3.52% from 3.51%.





WASHINGTON, May 10, (AP): Facing growing pressure to show progress in their investigations, House Republicans on Wednesday plan to detail what they say are concerning new findings about President Joe Biden's family and their finances.

The smoking gun, according to the GOP, is "thousands of pages" of recently obtained financial records that include more than 150 suspicious activity reports connected to the president's son Hunter Biden and brother James Biden, as well as

a growing number of associates. The confidential reports, called SARs for short, are often routine, with larger financial transactions automatically flagged to the government. The filing of a SARs

report is not evidence on its own of misconduct. But Republicans in Congress, notably Rep. James Comer, the chairman of the House Oversight Committee leading the probe, believe the records could potentially show an effort by the president and his family to trade off his name.

The White House has continuously dismissed the investigation as "yet another "Congressman Comer has a history of playing fast and loose with the facts and

spreading baseless innuendo while refusing to conduct his so-called 'investigations' with legitimacy," White House spokesperson Ian Sams said in a statement. Here's a deeper look at suspicious activity reports and how Republicans are using them as a roadmap to investigate the Biden family:

What is a suspicious activity report? Financial institutions are required to file a suspicious activity report to the Financial Crimes Enforcement Network (FinCEN) no later than 30 calendar days from when it detects a suspicious transaction that could have links to money laun-

dering or terrorism financing. First originated as a "criminal referral form," suspicious activity reports were established through the 1970 Bank Secrecy Act. In 1996, according to FinCEN, the form became the standard way to report suspicious activity in the financial system.

The rules around the reports were later amended under the U.S. Patriot Act.

Today, banks and credit unions routinely submit SARs.

SARs can also be filed by individuals or entities outside the financial sector, including law enforcement, public safety workers, city or state officials, business wners, and even the general public.

In recent years, electronic SARs reporting has increased through FinCEN's Bank Secrecy Act e-filing system. Nearly 42,000 reports were filed by the loan and financial services industry in 2021, according to data compiled by FinCEN, a huge jump from the more than 1,500 reports filed in 2015.

History of SARs against political actors The filing of suspicious activity reports against elected officials is not uncommon. During the Trump administration, Deutsche Bank's anti-money laundering division recommended filing suspicious activity reports on transactions conducted by Trump companies, including the Trump Foundation, and firms owned by his Michael Cohen, a one-time attorney for former President Donald Trump, had several suspicious activity reports filed against him, including one that recorded a \$500,000 deposit from a company connected to a Russian oligarch who donated money to Trump's inauguration fund.

Most SARs are never made public. The records connected to Trump and Cohen were revealed through leaks to the media and as part of federal investigations.

Confidentiality in the reporting process Suspicious activity reports are cloaked in secrecy to make them useful for law

enforcement. The person suspected of triggering a SARs is not routinely informed about the pending report. Any discussion or disclosure about SARs to outside groups such as news outlets

would be considered an unauthorized disclosure and is punishable as a federal criminal offense In the case involving Cohen, Trump's former personal lawyer, an IRS employee

was charged by federal prosecutors in 2019 with leaking banking records that had been flagged as suspicious activity. The confidentiality rules have come up again as Comer conducts his probe into

supposed suspicious activity reports by Biden family members. The Kentucky lawmaker and some committee members and staff were recently able to view some of the thousands of pages of the Biden family's financial records through subpoenas made to the Treasury Department and various financial institutions since January. A handful of lawmakers immediately began talking on social media and cable

news about what they had seen in the reports, asserting evidence of misconduct. House Democrats have accused Comer and other Republicans on the committee of potentially violating the Bank Secrecy Act.

What are Republicans investigating? Republicans vowed after winning the House majority last year that they would use their subpoena power to investigate foreign entities that did business with the family during Biden's time as vice president and during the Trump administration, including a specific focus on his son Hunter.

Hackers aim to find flaws in Al – with White House 'help'

DEF CON hacker convention expected to draw several thousand people

WASHINGTON, May 10, (AP): No sooner did Chat-GPT get unleashed than hackers started "jailbreaking" the artificial intelligence chatbot - trying to override its safeguards so it could blurt out something unhinged or obscene.

But now its maker, OpenAI, and other major AI providers such as Google and Microsoft, are coordinating with the Biden administration to let thousands of hackers take a shot at testing the limits of their technology.

Some of the things they'll be looking to find: How can chatbots be manipulated to cause harm? Will they share the private information we confide in them to other users? And why do they assume a doctor is a man and a nurse is a woman?

"This is why we need thousands of people," said Rumman Chowdhury, lead coordinator of the mass hacking event planned for this summer's DEF CON hacker convention in Las Vegas that's expected to draw several thousand people. "We need a lot of people with a wide range of lived experiences, subject matter expertise and backgrounds hacking at these models and trying to find problems that can then go be fixed.'

Learned

Anyone who's tried ChatGPT, Microsoft's Bing chatbot or Google's Bard will have quickly learned that they have a tendency to fabricate information and confidently present it as fact. These systems, built on what's known as large language models, also emulate the cultural biases they've learned from being trained upon huge troves of what people have written online.

The idea of a mass hack caught the attention of U.S. government officials in March at the South by Southwest festival in Austin, Texas, where Sven Cattell, founder of DEF CON's longrunning AI Village, and Austin Carson, president of responsible AI nonprofit SeedAI, helped lead a workshop inviting community college students to hack an AI model.

Carson said those conversations eventually blossomed into a proposal to test AI language models following the guidelines of the White House's Blueprint for an AI Bill of Rights - a set of principles to limit the impacts of algorithmic bias, give users control over their data and ensure that automated systems are used safely and transparently.

There's already a community of users trying their best to trick chatbots and highlight their flaws. Some are official "red teams" authorized by the companies to "prompt attack" the AI models to discover their vulnerabilities. Many others are hobbyists showing off humorous or disturbing outputs on social media until they get banned for violating a product's terms of service.

"What happens now is kind of a scattershot approach where people find stuff, it goes viral on Twitter," and then it may or may not get fixed

He also added that Indonesia offers 96 ready-made investment opportunities with feasibility studies in the fields of hydroelectric, wind and solar energy, as a commitment to reducing greenhouse gas emissions, expressing his hope that Kuwaiti companies specialized in these projects will contribute to achieving the goals aspired by the Indonesian

if it's egregious enough or the person calling attention to it is influential, Chowdhury said.

In one example, known as the "grandma exploit," users were able to get chatbots to tell them how to make a bomb - a request a commercial chatbot would normally decline - by asking it to pretend it was a grandmother telling a bedtime story about how to

In another example, searching for Chowdhury using an early version of Microsoft's Bing search engine chatbot - which is based on the same technology as ChatGPT but can pull real-time information from the internet - led to a profile that speculated Chowdhury "loves to buy new shoes every month" and made strange and gendered assertions about her physical appearance.

Chowdhury helped introduce a method for rewarding the discovery of algorithmic bias to DEF CON's AI Village in 2021 when she was the head of Twitter's AI ethics team - a job that has since been eliminated upon Elon Musk's October takeover of the company. Paying hackers a "bounty" if they uncover a security bug is commonplace in the cybersecurity industry - but it was a newer concept to researchers studying harmful AI bias.

This year's event will be at a much greater scale, and is the first to tackle the large language models that have attracted a surge of public interest and commercial investment since the release of ChatGPT late last year.

Chowdhury, now the co-founder of AI accountability nonprofit Humane Intelligence, said it's not just about finding flaws but about figuring out ways to fix them.

Feedback

"This is a direct pipeline to give feedback to companies," she said. "It's not like we're just doing this hackathon and everybody's going home. We're going to be spending months after the exercise compiling a report, explaining common vulnerabilities, things that came up, patterns we saw.

Some of the details are still being negotiated, but companies that have agreed to provide their models for testing include OpenAI, Google, chipmaker Nvidia and startups Anthropic, Hugging Face and Stability AI. Building the platform for the testing is another startup called Scale AI, known for its work in assigning humans to help train AI models by labeling data.

'As these foundation models become more and more widespread, it's really critical that we do everything we can to ensure their safety," said Scale CEO Alexandr Wang. "You can imagine somebody on one side of the world asking it some very sensitive or detailed questions, including some of their personal information. You don't want any of that information leaking to any other user.

Other dangers Wang worries about are chatbots that give out "unbelievably bad medical advice" or other misinformation that can cause serious

Anthropic co-founder Jack Clark said the DEF CON event will hopefully be the start of a deeper commitment from AI developers to measure and evaluate the safety of the systems they are building.
"Our basic view is that AI systems

will need third-party assessments, both before deployment and after deployment. Red-teaming is one way that you can do that," Clark said. "We need to get practice at figuring out how to do this. It hasn't really been done before.'

Soaring costs hurt bottom line

Toyota's profits rise as global chips supply crunch subsides

TOKYO, May 10, (AP): Toyota's January-March profit edged up 3% from the previous year on robust sales as a chips supply crunch gradually Toyota Motor Corp. racked up

552.2 billion yen (\$4 billion) in quarterly net profit, up from 533.8 billion yen (\$3.9 billion), according to results released Wednesday. Quarterly sales soared nearly 20% to 9.69 trillion yen (\$72 billion). For the fiscal year ended in March,

profit at Japan's top automaker fell 14% on-year to 2.45 trillion yen (\$18 billion). But it's forecasting profit to rise 5.2% for the current fiscal year to 2.58 trillion yen (\$19 billion).

Automakers worldwide have been hurt by a shortage of computer chips and other auto parts because of restrictions over the coronavirus pandemic that crimped production in various

Toyota said soaring raw material costs also hurt its bottom line.

The automaker's sales for the fiscal year that ended in March rose across global regions, including Japan, the United States, Europe and other markets, such as Asia, the Middle East and South America.

Toyota, based in Aichi prefecture's Toyota city in central Ĵapan, sold 10.56 million vehicles for the fiscal year through March, including its group makers like Daihatsu and Hino, and expects to boost that to 11.38 million vehicles for the fiscal year ending in March 2024.

The results underline the challenges that lie ahead, as well as the ongoing resilience of the maker of the Prius hybrid, Camry sedan and Lexus luxury

Toyota has acknowledged falling behind in the burgeoning shift to electric vehicles, especially in key markets like China, as well as the U.S. and

Toyota had long insisted on offering models that appeal to customers in various markets, noting EVs still made up a tiny portion of the market. But recently, that has changed dramatically, catapulting players like Tesla and BYD to stardom.

Toyota pioneered hybrids, which switch back and forth between a gasoline engine and electric motor to deliver an efficient ride. It pushed hybrids for decades as a viable green solution, and still does. But it's also expanding its low-emissions options with work on hydrogen-fed fuel cell electric vehicles. Such zero-emissions vehicles have already hit the road in various Toyota models in Japan, including buses and delivery vehicles.

In a statement. Toyota said it's committed to further growth and will continue to offer diverse options in ecological models, including hybrids and plug-ins as well as battery electric vehicles to "make sure to meet a wide range of global demand.'

Toyota officials, including the new president and CEO, Koji Sato, have acknowledged the company must play catchup in delivering EVs.

All eyes are on Sato to see if he'll

live up to his job. Sato replaced Akio Toyoda, the grandson of the automaker's founder. Toyoda remains a chair

of the company. Sato promised to work closely with Toyoda to speedily respond to market demands, including EVs, so Toyota can continue to grow.

"The foundation for this is carbon neutrality," he said.

Sato stressed Toyota would stay aggressive, launching 10 EV models in China and the U.S. by 2026. Toyota will secure a steady supply of batteries for EVs by boosting in-house production and working closely with partners, said Sato.

Airbnb posts \$117 million profit

WASHINGTON, May 10, (AP): Airbnb said Tuesday that it earned \$117 million in the first quarter as revenue rose during the ongoing recovery in travel, but the company's outlook for late spring and early summer disappointed investors.

The San Francisco-based company's shares fell nearly 12% in extended trading hours after Airbnb posted the forecast. The weak outlook overshadowed Airbnb's first profit in the first three months of the year, a seasonally slow period for travel.

The company's profit compared with a loss of \$19 million a year earlier and worked out to 18 cents per share. Revenue climbed 20% to \$1.82 billion, beating Wall Street's forecast of \$1.79 billion, according to a FactSet survey.

Nights and experiences booked, a closely watched measurement for Airbnb, increased 19% to 121 million, and the company valued the bookings made in the quarter at \$20.4 billion, a 19% increase.

"We have seen our highest number of active bookers ever despite continued macroeconomic uncerainty," CEO Brian Chesky said during a call with analysts.

However, Airbnb said second-quarter bookings growth won't look as robust as they did a year earlier, when consumers were busy booking travel after hunkering down at home during the outbreak of COVID-19's omicron variant. The company said bookings will grow more slowly than revenue in the April-through-June period, and the average daily rental rate will be "slightly lower" than a year earlier.

The company predicted that revenue

in the second quarter, which includes the start of the peak summer travel season, would be around \$2.40 billion. That was below analysts' average prediction of \$2.42 billion. In a letter to shareholders, Airbnb

said its revenue and the gross value of bookings are both double what they were before the pandemic.

Airbnb is getting a lift from people who are traveling while they take advantage of the ability to work remotely and stay away from the office. More of those people are booking international stays. The company said crossborder bookings grew 36% over last year's first quarter, helped by travel to and within the Asia-Pacific region and bookings into North America.

The average nightly rate paid by Airbnb customers was \$168, level with a year earlier, the company said. Price hikes in some places were offset by a slight shift toward in-city rentals, which tend to be lower in price than whole-house rentals in beach and mountain destinations.

Airbnb has grown increasingly concerned about rising rates, which could be pricing out some consumers.

Last week the company announced a renewed emphasis on renting rooms in hosts' houses, which it said would provide rentals averaging \$67 per room per night. Chesky said rooms would be particularly appealing to younger travelers who can't afford to rent an entire house.

Bank reports quarterly financial results

Burgan Bank posts net income of KD 7.6 million for Q1 of 2023

KUWAIT CITY, May 10: Burgan Bank ("Burgan" or "the Bank") announced its financial results for the first quarter ending March 31, 2023. The Bank reported KD 54.7 million in Revenue for Q1 '23, up 4% from Q1 '22, driven by growth in Net Interest Income of KD 34.4 million(+8% yo-y) and Net Fees Income of KD 10.2 million (+9% y-o-y). Burgan generated Operating Profit of KD 25.8 million for Q1 '23 while its Loan Provision charges for Q1'23 significantly reduced to KD 4.3 million (improvement of 69% y-o-y) driven predominantly by improved performance of the bank's portfolio in Turkey. Ac-cordingly, Burgan's cost of credit for Q1'23 reduced to 40bps as compared to 130bps in Q1'22. Burgan's Net Income for Q1'23 fell to KD 7.6 million primarily because of the Net Monetary Loss of KD 6.5 million recorded due to hyperinflationary accounting treatment

for its subsidiary in Turkey.

During Q1'23, Burgan's asset quality metrics continued to be solid with a Non-performing Loan (NPL) ratio of 1.8% and Provision Coverage Ratio of 219%. Additionally, the Bank's Capital Ratios for Q1 2023 were strong with a Tier 1 ratio of 14.2% and Capital Adequacy Ratio (CAR) of 18.0%, well above the regulatory minimum requirement of Tier 1 ratio of 12.0% and CAR of 14.0%.

Commenting on Burgan's Q1 results, the Bank's Chairman, Sheikh Abdullah Nasser Sabah Al Ahmad Al-Sabah, said: "We remain confident of our strategy and the direction of our franchise. The performance for this first quarter set a stable foundation for the year ahead and we expect improvement in the Bank's financials as the year progresses."

Sheikh Abdullah also noted that

Burgan remains focused on strengthening its focus on its core market, Kuwait. Therefore, and as part of the Bank's asset reallocation strategy, the Group successfully concluded the sale of Burgan's Iraqi subsidiary, Bank of Baghdad.

In terms of digitalization, which remains a core part of the Bank's strategy, the Bank expanded its digital payment offerings in Q1 by launching Google Pay and Apple Pay to allow its

Concerns raised over unnecessary use of antimicrobial chemicals

Disinfectants, cleaning products lack screening for health hazards

oncerns about unnecessary use of a common class of antimicrobial Chemicals used in disinfectants reinforces recommendations to opt for soap and water or safer products, my colleagues and I determined in our recent critical review of the scientific literature.

Quaternary ammonium compounds, or QACs, are increasingly marketed and used in homes, schools and workplaces with limited evidence for their appropriateness or safety. These chemicals can be found in common disinfectant solutions, wipes, hand sanitizers, sprays and even foggers.

Laboratory animal studies have found that some QACs can have developmental and reproductive toxicity with sustained exposure, may contribute to weight gain, and can impair energy production in cells.

Surprisingly, despite these concerns, studies on people have been limited to patients with allergic contact dermatitis and workplace-induced asthma among workers in hospitals and other facilities that require a sterile environment. We were even more surprised to find a lack of comprehensive screening for health hazards in the majority of this large class of common and widely used chemicals.

One of the top reasons to use antimicrobials only when needed is that

overuse leads to the rise of antimicrobial resistance, which contributes to millions of deaths per year worldwide. QACs and other antimicrobials create "superbugs" that not only can't be killed by disinfectants but can also become resistant to lifesaving antibiotics.

When the COVID-19 pandemic began, recommendations circulated in the news and social media to disinfect almost everything, from doorknobs to desks to groceries. Because COVID-19 is not primarily transmitted from surfaces, many of these disinfection practices don't substantially reduce transmission risk.

Adverse

Our team became concerned that frequent disinfectant use could lead to adverse health effects from QACs. Most people probably don't know about existing health concerns regarding QACs, or aren't aware that QACs can remain on surfaces and in indoor air and dust long after the product has dried, exposing more people to these chemicals than just the initial user. Researchers have found that the average levels of these chemicals in people's bodies have risen since the pandemic began.

One of the most commonly used QACs is benzalkonium chloride. Others may be identified on ingredient labels with names that end in "ammonium chloride" or similar terms.

While reading labels can help consumers identify QACs, some products

may not require disclosure of these chemicals in the ingredient list. For example, pesticide labels are required to list QACs whereas paint labels are not. QACs can be used in a wide variety of consumer products where they may or may not be listed when used, including personal care products, textiles, paints, medical instruments and more.

Reducing the harm of QACs requires their disclosure in all products, comprehensively screening them for health hazards and closely monitoring their broader effects in people and on the environment.

In the meantime, my colleagues and I recommend that individuals, schools and workplaces take a close look at their cleaning practices to see where disinfectants can be replaced with safe cleaners or safer disinfect-

Cleaning with soap or detergent removes most types of harmful germs like COVID-19 from surfaces. While disinfection can help kill any remaining microbes, it should be limited to situations where people have been actively ill, such as vomit on a surface, and during certain disease outbreaks.

For disinfectants to work properly, they must be left on the surface long enough to kill the germs, and this required contact time may be noted on the product. When you use or handle disinfectants you should wear protective gloves and eyeglasses or safety glasses, and you should open windows and doors to ventilate indoor spaces. (AP)

Thermo Fisher and Pfizer team up on global access to 'cancer DNA testing'

Cancer tied to 4.5 million deaths worldwide

WALTHAM, Mass, May 10: Pfizer and Thermo Fisher Scientific Inc. (NYSE: TMO) has announced they have entered into a collaboration agreement to help increase local access to next-generation sequencing (NGS)-based testing for lung and breast cancer patients in more than 30 countries across Latin America, Africa, the Middle East and Asia where advanced genomic testing has previously been limited or unavailable. Access to local NGS testing can help to provide faster analysis of associated genes, empowering healthcare providers to select the right therapy for that individual pa-

Cancer is a leading cause of death globally, accounting for nearly 10 million deaths in 2020, or around one in six deaths. Breast and lung cancer are the leading types of cancer diagnosed and are responsible for almost 4.5 million deaths worldwide. By 2040, the global burden for cancer is expected to grow to 27.5 million new cancer cases and 16.3 million cancer deaths.

Cancer is a disease in which some of the body's cells grow uncontrollably and spread to other parts of the

Cancer can start almost anywhere in the human body, which is made up of trillions of cells. Normally, human cells grow and multiply (through a process called cell division) to form new cells as the body needs them. When cells grow old or become damaged, they die, and new cells take their place.

Sometimes this orderly process breaks down, and abnormal or damaged cells grow and multiply when they shouldn't. These cells may form tumors, which are lumps of tissue. Tumors can be cancerous or not cancerous (benign).

Cancerous tumors spread into, or invade, nearby tissues and can travel to distant places in the body to form new tumors (a process called metastasis). Cancerous tumors may also be called malignant tumors. Many cancers form solid tumors, but cancers of the blood, such as leukemias, generally do not.

Large

Benign tumors do not spread into, or invade, nearby tissues. When removed, benign tumors usually don't grow back, whereas cancerous tumors sometimes do. Benign tumors can sometimes be quite large, however. Some can cause serious symptoms or be life threatening, such as benign tumors in the brain.

Under the agreement, Thermo Fisher will identify local labs that will be using the company's NGS technology and ensure they have the necessary infrastructure, trained staff, and quality control measures to meet industry standards for NGS testing services for breast and lung cancer. Pfizer will explore ways to enable affordable patient access for NGS testing for these types of cancer and work to raise healthcare provider awareness regarding the benefits of advanced testing. The two companies will continue to evaluate opportunities to expand geographically and to expand testing for other types of cancer.

"Anyone facing a cancer diagnosis should have access to cutting-edge testing that can match them with an appropriate, optimized treatment plan and better inform their care. Today, we aim to bring rapid NGS testing to an increased number of decentralized labs, closer to where patients are treated," said Gianluca Pettiti, executive vice president at Thermo Fisher Scientific. "We are moving one step closer to delivering precision insights to underserved patients so they can receive a more tailored path for their care no matter where they are in the world.'

"The more we understand the

complex science behind cancer, the better we can treat it. Our experience has taught us that cancer cannot always be treated with a broad brush and often requires an individualized approach based on precise disease characteristics," said Nick Lagunowich, Pfizer Global President of Emerging Markets. "In many parts of the world, access to next-generation sequencing may be limited or unaffordable for cancer patients. This program aims to improve their treatment journey and help increase their chances for improved outcomes."

Single gene testing has historically been used to match patients with appropriate targeted therapies. However, this can be a time intensive process if sequential tests are needed and there may not be enough tissue to run every test - which may require additional biopsy procedures. As more targeted therapies are available that can be matched through a broader set of genomic markers, next-generation sequencing is quickly replacing sequential, single biomarker tests. By screening a single tumor tissue or blood sample for multiple biomarkers simultaneously, NGS can provide clinical teams with rapid and actionable genomic insights to help inform precision oncology treatment decisions for eligible patients.

Survival

A retrospective observational real-world data study looked at newly diagnosed stage IV non-small cell lung cancer patients, and found outcomes such as apparent survival and time to next treatment were significantly compromised if actionable mutations were identified after systemic treatment was initiated (e.g. chemotherapy and immunotherapy). However, when treatment was initiated based on molecular results, patients experienced better outcomes compared to patients who were treated prior to receiving molecular results, supporting the need for rapid molecular testing to inform better treatment decisions.

UK tabloid group admits it unlawfully gathered info on Harry

LONDON, May 10, (AP): The publisher of British tabloid the Daily Mirror has acknowledged and apologized for unlawfully gathering information about Prince Harry in its reporting, and said it warrants compensation, at the outset of the prince's first phone hacking trial Wednesday.

The admission was made in court filings outlining Mirror Group Newspapers' defense.

The group continued to deny that it hacked phones to intercept voicemail messages, and said that Harry and three less-well-known celebrities brought their claims beyond a time limit.

But it acknowledged there was "some evidence of the instruction of third parties to engage in other types of UIG (unlawful information gathering) in respect of each of the claimants," which includes the Duke of Sussex. It said this "warrants compensation" but didn't spell out what form that might take.

"MGN unreservedly apologizes for all such instances of UIG, and assures the claimants that such conduct will never be repeated," the court papers said.

The publisher said its apology was not a tactical move to reduce damages but was done "because such conduct should never have occurred." The trial is Harry's opening salvo in his legal battle against the British press. Harry and the other celebrities are suing the former publisher of the Daily Mirror for alleged invasion of privacy

The case is the first of the duke's three phone hacking lawsuits and threatens to do something he said his family long feared: put a royal on the witness stand to discuss embarrassing revelations.

The activities in question stretch back more than two decades, when journalists and private eyes intercepted voicemails to snoop on members of the royal family, politicians, athletes, celebrities and even crime victims. A scandal erupted when the hacking was revealed.

Harry is expected to testify in person in June, his lawyer has said. It won't be his first time in the High Court, following his surprise appearance last month to observe most of a four-day hearing in one of his

He did not show up for opening statements in the trial. Harry breezed through London for Saturday's coronation of his father, King Charles III, before leaving immediately after the ceremony to fly back to California to be with his family for his son's birthday.

The prince has waged a war of words against British newspapers in legal claims and in his best-selling memoir "Spare," vowing to make his life's mission reforming the media that he blames for the death of his mother, Princess Diana. She died in a car wreck in Paris in 1997 while trying to evade paparazzi.

Harry has also sued the publishers of the Daily Mail and The Sun over the phone hacking scandal that metastasized after a year-long inquiry into press ethics in 2011 revealed that employees of the now-defunct News of the World tabloid eavesdropped on mobile phone voicemails.

Harry has outlined his grievances against the media in court papers, saying the press hounded him since his earliest days and created a narrative that portrayed him as "the 'thicko,' the 'cheat,' the 'underage drinker." His relationships with girlfriends were wrecked by "the entire tabloid press as a third party.

"Looking back on it now, such behavior on their part is utterly vile,"

he said in a witness statement in a similar case.

His lawsuits could further roil family relations that have been strained since Harry and his wife, Meghan, left royal life in 2020 and moved to the United States after complaining about racist attitudes

Mirror Group Newspapers and other publishers have primarily defended themselves by asserting that Harry failed to bring his cases within a six-year year time limit. The duke's lawyer has argued that an exception should be applied because publishers actively concealed the skullduggery. In a stunning revelation last month that dredged up an embarrassing chapter in his father's life, Harry blamed his delay in bringing suit, in part, on his family.

He asserted he was barred from bringing a case against The Sun and

other newspapers owned by media magnate Rupert Murdoch because of a "secret agreement" - allegedly approved of by Queen Elizabeth II - that called for reaching a private settlement and getting an apology.

"The reason for this was to avoid the situation where a member of the royal family would have to sit in the witness box and recount the specific details of the private and highly sensitive voicemails that had been intercepted," Harry said in a witness statement against News Group Newspapers.

"The institution was incredibly nervous about this and wanted to avoid at all costs the sort of reputational damage that it had suffered in 1993," he said, alluding to a transcript of a leaked recording - published in the Sunday Mirror - of an intimate conversation his father, then Prince of Wales, had with his paramour, now Queen Camilla, in which he compared himself to a tampon.

Gather around, young ones. Silence your iPhones and Samsungs. We're here to learn about the Before Times, when the hottest tech device was nicknamed "CrackBerry.

The gripping and hugely enjoyable "BlackBerry" is about the famous - and later infamous - Research in Motion gadget that helped trigger the global smartphone era as we know it, before sliding into obsoles-

The BlackBerry may seem quaint now in the days of sleek water resistant 5G phones with face ID, but it was the first mobile device with a pager, cellphone and email capability all in one thing. No idea? Ask your parents.

"BlackBerry" tells the standard rise and fall of a tech startup that blows up, naturally leading to insider infighting - think "Silicon Valley" and "The Social Network" - but there's a twist here: The main money guy, while very shouty, is not the sleazy, bad guy you might expect.

Director and co-writer Matt Johnson recounts a breathless decade or so starting in 1996, when Research in Motion was just an office filled with tech geeks in Canada. Johnson also stars as Doug Fregin, a headband-wearing, movie-quoting uber-geek, an amalgam of a few Research in Motion people.

with a trackpad. The film is adapted from Jacquie McNish and Sean Silcoff's "Losing the Signal: The Untold Story Behind the Extraordinary Rise and Spectacular Fall of BlackBerry." It is said to be "a fictionalization inspired by real people and real events."

Geek

The second half of "BlackBerry" is heartbreaking the loss of geek culture, the loss of principles and the loss of friendships. It's the Icarus story, except instead of wings they had autocomplete while typing with your thumbs.

The funniest bits of the movie are when the geeks are king, like NASA engineers on Apollo 9 gathering around a table figuring out data puzzles or soldering together hardware and writing code. The filmmakers use clips of "Star Trek" and "Inspector Gadget" to show what they were doing was futuristic.

Johnson makes the film even more enjoyable as the soundtrack moves from Joy Division, the Strokes and Moby to MC Hammer and The White Stripes. There are also small but great acting turns by Saul Rubinek, Cary Elwes and Michael Ironside.

Johnson's nicely plotted and sympathetic eye is in every frame, and he sets the tone early on in the first image from 1996: It's a car driven by the BlackBerry co-creators and it is passing a horse.

SANTA FE, N.M.: A New Mexico judge has approved a \$1.15 million settlement between a medic who worked on the "Rust" film set and one of several defendants she accused of negligence in the fatal 2021 shooting of a cinematographer by Alec Baldwin during a rehearsal.

Court records show the partial settlement between Cherlyn Schaefer and prop master Sarah Zachry was approved during a hearing Monday. Schaefer told the judge there's not a day that goes by when she doesn't think about what happened, the Santa Fe New Mexican reported.

In her civil complaint, Schaefer said she fought desperately in a failed attempt to save the life of cinematographer Halyna Hutchins. She said the shock, trauma and emotional distress that followed has made

it impossible for her to continue working in her field. Prosecutors dismissed an involuntary manslaughter charge against the actor and producer last month, citing

new evidence and the need for more time to investigate. State District Judge Kathleen McGarry Ellenwood had entered a default judgment against Zachry in November after the film worker failed to file re-

sponses within court deadlines. Zachry's current attorney, Nathan Winger, told the court Monday that her previous attorney, William Waggoner, let deadlines pass without her permission, and she intends to seek damages from him to fund her settlement with Schaefer. Waggoner disputes the claim.

Justin Rodriguez, one of several attorneys representing Schaefer, said the settlement "is a small portion of what we expect to receive in the future." The remaining defendants include Rust Movie Productions, weapons supervisor Hannah Gutierrez-Reed and assistant director **David Halls**, but not Baldwin.

Schaefer's complaint claims Zachry and Gutierrez-Reed failed to ensure there were no live rounds in Baldwin's weapon. An involuntary manslaughter charge remains pending against Gutierrez-Reed, but her attorneys have said they fully expect her to be exonerated. (AP)

Versatile artist

Brazil's 'queen' of rock Rita Lee dies

BRASILIA, Brazil, May 10, (AP): **Rita Lee Jones**, Brazil's million-selling "Queen of Rock" who gained an international following through her colorful and candid style and such hits as "Ovelha Negra," "Mania de Você" and "Now Only Missing You." has died at 75.

Otherwise known as Rita Lee, she died at her home in Sao Paulo on Monday evening, according to a statement posted to her official Instagram account.

With a career spanning six decades, the Sao Paulo native left a lasting mark with her irreverence, creativity and compositions containing messages that helped introduce Brazilian society to feminism,

while also candidly addressing her struggles with drug



Although she regarded her voice as "weak and a little out of tune," like a sparrow's, she enjoyed a long run of top-selling albums, including "Rita Lee" and "Rita Lee & Roberto de Carvalho," and dozens of her songs were featured in widely watched telenovelas in Letin America. The bake

Rita Lee in Latin America. The behemoth television network Globo used her rendition of the song "Poison Weed" (Poison Ivy) in three of its programs.

"I was not born to get married and wash underwear. I wanted the same freedom as the boys who used to play in the street with their toy cars," she told the Brazilian edition of Rolling Stone in 2008. "When I got into music, I realized that the "machos" reigned absolute, even more in rock music. 'Wow', I said, 'this is where I'm going to let my fangs out and, literally, give them a hard time.""

She was a singer and songwriter praised for her versatility, playing at least five instruments: drums, guitar, piano, harmonica and autoharp. She was also one of the first Brazilian musicians to use electric guitar.

Admired

Eventually, her popularity extended beyond Brazil. She performed in Portugal, England, Spain, France and Germany. In 1988, the British newspaper Daily Mirror revealed that then-Prince Charles admired her song "Lança Perfume" and considered her his favorite singer. She won a Latin Grammy in the Best Portuguese Language Album category in 2001, for her album "3001."

Rita Lee rose to fame with the group Os Mutantes (The Mutants), starting in 1966. Colors and creativity, as well as irony and irreverence, were Lee's trademarks from the start, evident in the flamboyant costumes she performed in her shows. By the mid-1970s, after selling 200,000 copies of the album "Forbidden Fruit," Lee began to be called the "queen of rock" on the music scene. Hits on "Forbidden Fruit" include "Now Only Missing You" and "Ovelha Negra," long played on radio stations and Brazilian soap operas.

In an interview with the music website I Have More Records Than Friends! in 2017, Lulu Santos, judge of the Brazilian version of The Voice, recalled seeing Rita Lee play autoharp at a concert.

"She brought that thing on stage, in those clothes... it was completely mythological," the musician said. "There really is a lineage of 'girls' tied to rock in Brazil, of which she is a legitimate representative. But I see her as an element that distances herself from the clichés of rock." She, from her feminine point of view, sees the clumsiness of the worn-out cliché of the male rocker, the one who plays with his legs open. She saw right through him."

She was one of the first public figures in Brazil to popularize feminist themes, such as infusing the lyrics of her 1979 song "Mania de Voce" (Mania for You) with female sexuality and pleasure. Similar songs followed, such as "Amor e Sexo" (Love and Sex) which contrasted the two in detail and "Lança Perfume" (Spray Perfume), an ode to unbridled hedericated.

Later in life, she became a vegan and animal rights activist. For decades, she kept her hair bright red and often wore matching lenses, a popular look that she discarded in recent years as she allowed her gray to grow out. She resolved in 2015 to reinvent herself as a white butterfly.

Abuse

In her autobiography, published the following year, she didn't shy from describing the sexual abuse she suffered as a child at the hands of a man who had come to fix her mother's sewing machine.

She also referred to herself as a "rebel" and "hippie communist," and wrote of sneaking out the windows of her house as a teenager to play, being arrested during the dictatorship for possession of marijuana, and her multiple stints in rehab clinics for drugs and alcohol.

"I recognize that my best songs were written in an altered state, and my worst too. I only regret my delay in realizing that the 'medicine' had long since expired," she wrote. "My generation suffered the claustrophobia of a brutal dictatorship, and using drugs was a way to breathe airs of freedom."

In an interview with the television program Fantastico in 2020, she explained that physical frailty had prompted her to leave the stage eight years earlier.

"Getting old, for me, was a surprise, because I've never been old in my life," she told the show. "I was left wanting to live my old age away from the stage, without sharing it with the public."

A public wake will be held at the planetarium in Sao Paulo on May 10, according to the Instagram post.

She is survived by her three children and her husband, musician Roberto do Carvalho, with whom she shared a 44-year musical partnership. In 2021, they released a new song, Change, together, and a remix of some of the singer's biggest hits.

Years before, she imagined her future death, as if prophesying:

"I will be in heaven," she wrote, "with my soul present playing my autoharp and singing to God, 'Thank you, Lord, finally sedated.' Epitaph: She was never a good example, but she was good peo-

OXFORD, Miss: Thousands of country music fans were awaiting singer **Morgan Wallen** when he suddenly canceled his performance Sunday night at Vaught Hemingway Stadium.

WTVA-TV reported video boards inside the Ole Miss football stadium showed a message saying the "Thought You Should Know" singer had lost his voice and was unable to perform, adding that people would be refunded their money where they bought the tickets.

Some people expressed anger on social media because the announcement of the cancellation came after the opening acts had performed.

While Wallen is one of country music's biggest stars, he's no stranger to controversy. He was caught on camera in 2021 outside a home in Nashville, Tennessee, yelling profanities and a racial slur. He apologized at the time but was suspended indefinitely from his label and his music was pulled by radio stations and streaming services.

The year before, Wallen was arrested for public intoxication and disorderly conduct after getting kicked out of a downtown Nashville bar.

The sudden cancellation concluded what was supposed to be two consecutive nights of performances by one of the hottest stars in country music. Saturday night's show appeared to be a huge success with thousands showing up for the first concert in the stadium's history. (AP)

Song contest returns to Britain after 25 years

UK hosts Eurovision for Ukraine

LONDON, May 10, (AP): Last week, Britain crowned a king. This week, it will help bestow Europe's pop crown.

will help bestow Europe's pop crown. The Eurovision Song Contest is returning to the UK for the first time in 25 years, but the heart of the glitzy music competition will be in Ukraine.

Britain is hosting the event on behalf of the war-battered country, and organizers have vowed to make it a celebration of Ukrainian spirit and culture

tion of Ukrainian spirit and culture.

The contest will see musical acts from 37 countries perform original songs in the English city of Liverpool, with semi-finals Tuesday and Thursday and a grand final on Saturday watched by an estimated 160 million people.

For fans and first-timers alike, here an essential Eurovision guide:

an essential Eurovision guide:
First staged in 1956, Eurovision was founded to help unite a shattered continent after World War II and to test nascent live-broadcasting technology.

Initially a sedate affair featuring crooners in ballgowns and tuxedos, it began to let its hair down during the swinging 60s and reached pop perfection in 1974, when ABBA won with "Waterloo," propelling the band toward superstardom and jump-starting Sweden's music industry.

Since then, the contest has expanded across Europe and beyond - Israel and Australia are both entrants - with ever-more elaborate staging and eyepopping costumes.

Eurovision also has become a celebration of diversity, with a huge LG-BTQ+ following that celebrated when Israel's Dana International became the contest's first transgender winner in 1998.

Above all, the competition is a crash course in the continent's wonderfully varied musical tastes. Winners have ranged from Canadian chanteuse Celine Dion, who competed for Switzerland in 1988, to fright mask-wearing Finnish metalheads Lordi in 2006 and bearded Austrian drag performer Conchita Wurst in 2014.

Italian rock band Måneskin parlayed its 2021 Eurovision victory into a substantial international career, with gigs at major US festivals and a stint opening for the Rolling Stones on tour.

Last year, Ukrainian folk-rap band

Kalush Orchestra triumphed, delivering a morale boost for a country battling Russia's invasion.

Paul Jordan, an expert on the con-

test who is known as "Dr. Eurovision," said the competition has become a treasured part of European culture.

"You can go to Spain, Slovenia, wherever -- everyone's heard of it," he

wherever -- everyone's heard of it," he said. "They may not love it, they may not like it, they may not watch it, but everyone's heard of it. Everyone's got an opinion. I think it's really powerful, and it's a brilliant icebreaker."

Eurovision is about much more than music. It's diplomacy with a disco beat, a forum in which countries can boost their profiles and play out regional rivalries.

Organizers strive to keep pop and politics apart; overtly political symbols and lyrics are prohibited. But global tensions have often imposed themselves on the contest. Ukraine has several times used its entries to criticize Russia, winning in 2016 with a song about the expulsion of Crimea's Tatars by Stalin in 1944.

Platform

Russia was banned from the contest last year after it invaded Ukraine. Belarus had been kicked out the previous year over its government's clampdown

Dean Vuletic, an academic expert on Eurovision, said that by banning Russia, Eurovision lost one of its biggest national audiences and "one of its most enthusiastic participants."

"But Eurovision is also a platform on which values are expressed, around which values are constructed," Vuletic said, and pressure from member nations forced the European Broadcasting Union, which runs Eurovision, to

Eurovision "has always reflected cultural, political and social change in Europe," he said. "(It's) a way to measure the zeitgeist in Europe."

Eurovision was long associated with fluffy 3-minute pop songs - previous winners include the likes of "La, La, La" and "Boom Bang-a-Bang."

But Vuletic says it's no longer "the contest with silly songs, innocuous lyrics that it perhaps used to be." He says

a third of this year's entries deal lyrically with "toxic relationships, anxiety" and other mental-health issues. Another batch of songs are about war.

Musically, contestants range from pop ballads like "Power" by Iceland's Diljá and relationship-breakup dance track "I Wrote a Song" by Britain's Mae Muller to the electronica of "Heart of Steel" by Ukraine's Tvorchi. Austrian duo Teya & Salena offer an offbeat tribute to Edgar Allen Poe, "Who the Hell is Edgar?" while Croatia's Let 3 belts out antiwar rock opera "Mama ŠČ!"

Eurovision's complex voting system, which awards points from juries of music industry professionals as well as viewers across Europe, makes winners notoriously hard to predict.

Bookmakers' favorites include Finnish entry Käärijä's pop-metal party tune "Cha Cha Cha" and power ballad "Tattoo" by Sweden's Loreen, who previously won the contest in 2012. Singer La Zarra, competing for France, is also highly ranked for her Edith Piaf-esque chanson "Évidemment"

The UK stepped in to host the contest for Ukraine after last year's British entry, Sam Ryder, finished second. As Ryder put it: "It's Ukraine's party. We're just inviting them to throw it at our house."

The final will be co-hosted by Ukrainian singer Julia Sanina and will feature a performance by Kalush Orchestra and other representatives of Ukrainian culture. Several thousand Ukrainian refugees in Britain have received tickets to attend.

Ryder's strong showing last year with "Spaceman" helped transform Eurovision's image in the UK. Long viewed as a guilty pleasure - amid perennial grumbling over the country's poor results -- it now a source of pride and celebration.

Several UK cities competed to host the event, and winner Liverpool is in party mood. The port city that gave birth to The Beatles went through tough times as UK industry collapsed in the late 20th century. It has since reinvented itself as a hub for sports, culture and nightlife - a resilience that fits well with Ukraine, Jordan says.

LOS ANGELES: A California judge on Tuesday threw out key sections of Marilyn Manson's lawsuit against his former fiancee, "Westworld" actor Evan Rachel Wood, claiming she fabricated public allegations that he sexually and physically abused her during their relationship and encouraged other women to do the same.

Manson's suit, filed last year, alleges that Wood and another woman named as a defendant, Illma Gore, defamed Manson, intentionally caused him emotional distress and derailed his career in music, TV and film. It says they used false pretenses, including a phony letter from the FBI, to convince other women to come forward with sexual abuse allegations and coached them on what to say about Manson, whose legal name is Brian Warner.

Los Angeles Superior Court Judge Teresa A. Beaudet dismissed the part of the suit dealing with the disputed FBI letter, which Wood denies forging. Beaudet also tossed out a section that alleges Wood and Gore used a checklist found on an iPad for other women to use to make abuse claims about Manson. (AP)

Cancer deaths declining

Start mammograms at 40, not 50: panel

WASHINGTON, May 10, (AP): Women should start getting every-other-year mammograms at age 40 instead of waiting until 50, according to a draft recommendation from a federal task force.

The US Preventive Services Task Force has long said women can choose to start breast cancer screening as young as 40, with a stronger recommendation that they get the X-ray exams every two years from age 50 through 74.

Tuesday's update — if the draft proposal is finalized — would mark a shift in the influential panel's guidelines although it's not likely to end confusion. Other health

groups differ over when and how often to screen. "This new recommendation will help save lives and pre-



vent more women from dying due to breast cancer," said former task force chair **Dr. Carol Mangione**.

The task force noted that Black women are 40 percent more likely to die of breast cancer than white women, making mammograms at 40 an especially important step — but also urged more research to better understand and combat the disparity.

The task force also noted that nearly half of all women have dense breasts, which means mammograms may not work as well, and called for more research into

whether additional types of testing would help.

The draft recommendation applies to women at average risk of breast cancer but not those at very high risk due to certain genetic or other factors. It is open for public comment through June 5, after which the task force will decide whether to finalize it.

While cancer deaths have been declining for years, breast cancer remains the second leading cancer killer of US woman, behind lung cancer.

Health organizations have long had different screening recommendations, seeking to balance catching breast cancer early while avoiding too many false alarms, when the X-rays spot non-cancerous blips.

The American Cancer Society says women ages 45 to 54 should get mammograms every year — but can choose to start at 40 and then at 55, can choose to switch to every other year.

The American College of Radiology recommends annual mammograms starting at 40 for women at average risk of breast cancer -- but urges that young women get assessed for risk factors that require even earlier screen-

'Forever chemicals': Minnesota is on the verge of banning non-essential uses of "forever chemicals." And lawmakers say they are naming the legislation after a woman who spent the last months of her life campaigning for re-

strictions that will be some of the toughest in the country.

Legislators, environmentalists and family members paid tribute Tuesday to Amara Strande. She died two days shy of her 21st birthday last month from a rare form of liver cancer. She grew up in a St. Paul suburb where the groundwater is contaminated by PFAS and believed the chemicals were part of what caused her cancer, which was diagnosed when she was 15.

'Through her pain and exhaustion, Amara was willing to be a voice of those who have become the victims of illnesses that are linked to these forever chemicals," said her father, Michael Strande. "Amara called on the lawmakers of Minnesota to do what is right in passing laws that will not only protect our environment, and human lives, but also force industries to find alternative ways of manufacturing their products without these deadly chemicals."

PFAS, or per- and polyfluoroalkyl substances, have spread around the globe and don't break down in the environment. They have been linked to a broad range of health problems, including low birth weights and certain cancers. The chemicals have been used since the 1940s in many consumer and industrial products, including nonstick pans, fast-food packaging, fabrics and firefighting foam.

"I have spent the last five years fighting cancer with every ounce of my being. And I will for the rest of my life," Amara Strande said at an emotional news conference with lawmakers and her parents back when they announced the legislation in January. "Corporations must stop the production of these toxins and be held accountable and pay for the damage they've done. Through no fault of my own, I was exposed to these toxic chemicals. And as a result, I will die with this cancer."

"Amara's Law" will allow only limited exceptions to the ban, such as firefighting foam used at airports and oil refineries and in protective clothing for firefighters. It also will require companies to disclose if the products they sell in Minnesota contain the chemicals. The ban would take effect in 2025 for a long list of products including carpets, cleaning products, cookware, cosmetics, dental floss, fabrics and fabric treatments, furniture, products for children, menstruation products and ski wax.

A House-Senate conference committee that is negotiating the details of a broad environment and natural resources bill agreed last Thursday to the PFAS language that will be included. Democratic Gov. Tim Walz and his administration support the ban. He is expected to sign it after the House and Senate complete work on the final package.


"This will be the strongest PFAS legislation in the nation," said Democratic Rep. Sydney Jordan, of Minneapolis, who went on to say: "Minnesota invented PFAS. By passing this, Minnesota is going to invent the solu-

Supporters said Minnesota has a special responsibility because the chemicals were invented by Maplewoodbased 3M, which announced in December that it is exiting PFAS manufacturing and discontinuing their use in its

"We have a duty to lead the charge in their eradication from the environment, from our bodies, from our consumer products, from our water," said Democratic Sen. **Judy Seeberger**, of **Afton**, the lead sponsor in the Senate. She said the issue is personal because her home well is contaminated with PFAS, forcing her to use a filtration system to get safe water.

Andrea Lovoll, legislative director of the Minnesota Center for Environmental Advocacy, said the Minnesota legislation goes farther than any other state's and has the strictest list of what counts as non-essential uses. For example, she said, California's restrictions don't cover cookware or require as many comprehensive disclosures. Up until now, she said, Maine has had the strongest restrictions. But Maine's 2021 law mandates a phaseout by 2030 while Minnesota's law kicks in faster.

The US Environmental Protection Agency last year designated the chemicals as hazardous substances under the Superfund law. But the EPA stopped short of an outright ban, after warning that the compounds were more dangerous than previously thought and pose health risks even at extremely low levels.

The State Meteorological The State Meteorological Agency, known by the Spanish acronym AEMET, said Monday the average daily temperature in April was 14.9 degrees Celsius (58.8 Fahrenheit), that is 3 degrees Celsius above the average.

AEMET said average maximum temperatures during the month were up by

4.7 Celsius. Rainfall was a fifth of what would normally be expected in the month, making it

the driest April on record in Spain. Last year was Spain's hottest since record-keeping started in 1961, and also the country's sixth driest.

Three years of scant rainfall and high temperatures put the country officially

into long-term drought earlier this year. A flash study by a group of international scientists last week found that recordbreaking April temperatures in Spain, Portugal and northern Africa were made 100 times more likely by human-caused climate change and would have been almost impossible in the past. Prime Minis-

ter of Spain is **Pedro Sánchez**. (AP)

Civil Guard raid illegal wells: Record-breaking April temperatures in Andalusia have coupled with a chronic lack of rainfall. Water reservoirs in the Guadalquivir river basin, which runs through the territory, are only about a quarter full, at 27.95%, even before summer has begun. Farmers in the region have had their water allowance for irrigation cut by up to 90% in some cases.

The situation in the vast agricultural heartland and in northeastern Catalonia means that Spain's total water reserves nationally have dipped to 48.9%.

April was also Spain's driest ever. Currently, 27% of Spanish territory is in either the drought "emergency" or "alert" category. Farmers across the Western Mediterranean have warned that crop fail-

ures are likely.
Water resources in Spain have meanwhile become increasingly politicized ahead of May 28 local elections. The leftwing central government has criticized Andalusia's right-wing regional administration for attempting to declare an amnesty for illegal wells around the region's Doñana wetlands, in contravention of European Union law.

Meanwhile, the far-right in Spain has used social media to perpetrate disinformation about a government official falsely ordering reservoirs to be emptied. (AP)

Some evidence-based ways to counter virus

Many still grappling with long COVID

A patient of mine, once a marathon runner, now gets tired just walking around the block. She developed COVID-19 during the 2020 Christmas holiday and saw me during the summer of 2021. Previously, her primary care doctor had recommended a graded exercise program. But exercise exhausted her. After months of waiting, she finally had an appointment at our post-COVID-19 clinic at the University of Virginia.

She is hardly alone in her extended search for answers. Studies suggest that from 10% to 45% of COVID-19 survivors have at least one of the following symptoms three months after recovery: fatigue, cough, shortness of breath, difficulty sleeping, difficulty with daily activities or mental fogginess, otherwise known as "brain fog.'

There are many names for this condition: long COVID, long-haul COVID, post-acute COVID-19 syndrome and chronic COVID. Patients report that their symptoms, or the severity of them, fluctuate over time, which makes diagnosis and treatment difficult.

Researchers and doctors have seen similar recovery patterns from other viruses, including Ebola and Middle East Respiratory Syndrome, or MERS, which is another coronavi-

This suggests that the illness we see following a bout with COV-ID-19 may be part of a patient's response to the infection. But doctors and researchers do not yet know why some patients go on to have persistent symptoms.

My clinical practice and academic research focus on critically ill patients. Most of my patients now are people who had COVID-19 with various levels of severity.

I often tell these patients that we are still learning about this disease, which wasn't part of our vernacular before 2020. Part of what we do at the clinic is help patients understand what they can do at home to start im-

Chronic fatigue can greatly affect quality of life. Exercise limitations can have their roots in problems with the lung, heart, brain, muscles or all

Graded exercise therapy works for some but not all patients. Graded exercise is the slow introduction of exercise, starting slowly and gradually increasing in load over time. Many are frustrated because they feel more exhausted after exercising or even doing the routine tasks of daily living. The lack of progress leads to feelings of depression.

The condition of feeling more ex-

hausted after exercise is called postexertional malaise, which is defined as physical and mental exhaustion after an activity, often 24 hours later, that is out of proportion with the ac-

For example, you feel good today and decide to go for a walk around the block. Afterward you are fine, but the next day your muscles ache and all you can do is lie on the couch. Some patients don't even have the energy to answer emails. Rest or sleep do typically relieve the fatigue. There is no one-sizefits-all approach to treatment; the severity and frequency of post-exertional malaise varies from person to person.

Fatigue following any illness is common, as is exercise intolerance. So when should you see a medical professional? Diagnostic testing for post-exertional malaise exists, but it's not readily available to all patients. These questions may provide clues to whether or not you are expe-

■ Does it take more than one day to recover to your usual baseline activ-

■ Do you feel unwell, weak, sleep poorly or have pain when recovering

from activity? ■ Are you feeling limited in your ability to do your daily tasks after

activity? ■ Does exercise activity affect you

positively? ■ Do you have soreness and fatigue after nonstrenuous days, or mental fatigue after strenuous or nonstrenu-

ous activities? All of these can be clues to discuss with your primary care provider, who may want to do additional testing to confirm the diagnosis, such as a two-day cardiopulmonary exercise

Before your appointment, there are a few things you can do at home that may help.

Activities

One of those techniques is pacing, or activity management, an approach that balances activities with rest.

The Royal College of Occupational Therapists and the Intensive Care Society, both in the UK, developed what they call the 3Ps - Pace, Plan and Prioritize. Pacing yourself means breaking

down activities into smaller stretches with frequent breaks rather than doing it all at once. An example would be to climb a few steps and then rest for 30 seconds, instead of climbing all the stairs at once. Planning involves looking at the

week's activities to see how they can be spread out. Think about the ones that are particularly strenuous, and give yourself extra time to complete them.

This helps with prioritizing - and recognizing those tasks that can be skipped or put off.

Some patients with long COVID develop abnormal breathing patterns, including shallow rapid breathing, known as hyperventilating, or breath-holding. Either of these patterns can make you feel short of breath.

Symptoms of abnormal breathing patterns include frequent yawning, throat-clearing, experiencing pinsand-needles sensations, palpitations and chest pain. Don't ignore these symptoms, because they can be signs of serious medical problems like heart attacks and abnormal heart rhythms. Once those are ruled out, it is possible to relearn to breathe prop-

You can practice these techniques at home. The simple version: Find a comfortable position - either lying down or sitting upright with your back supported. Place one hand on your chest and the other over your belly button. Exhale any stale air out of your lungs. Then breathe in through your nose and into your abdomen, creating a gentle rise in the

You should feel the hand resting on your belly button move up and down. Try to avoid short, shallow breaths into the upper chest. Slowly exhale all the air out of your lungs. The goal is to take around eight to 12 breaths per minute.

Focus on a longer exhale than inhale. For example, inhale as described for a count of two, then exhale for a count of three, as a starting point. If you take one breath every five seconds, you will be breathing 12 breaths per minute. As you get more comfortable with this, you can increase the time to further reduce your breaths per minute.

A more advanced tool is called box breathing: Breathe in for a count of four to five, holding your breath for a count of four to five, breathing out for a count of four to five and hold that for a count of four to five.

Long COVID patients who use these techniques show improvement in symptoms of breathlessness and sense of well-being.

The patient I referred to earlier did all of these things. As we worked with her, we discovered she had multiple reasons for her symptoms. In addition to overbreathing and symptoms of post-exertion malaise, she had a new cardiac problem, possibly related to her COVID-19 illness, that made her heart work less well during exercise. Now she is recovering; while not back to marathon running, she is feeling better.

Currently there is no cure for long COVID, though we hope research will lead to one. Clinical trials looking at potential therapies are continuing. In the meantime, people should be cautious about using medications that are not proved to help - and if you're having symptoms, get evaluated. (AP)

Former Vikings, Cal QB Joe Kapp dies at age 85

WASHINGTON, May 10, (AP): Joe Kapp, the hard-nosed quarterback who routinely ran into tacklers instead of away from them while leading the Minnesota Vikings to their first Super Bowl and California to its last Rose Bowl, has died. He was 85.

Cal confirmed that Kapp died on Monday. He had suffered from Alzheimer's disease for the last 15 years and was residing in an assisted living facility, his son J.J. Kapp said.

The family made plans to send his brain to UC San Francisco researchers for study of the potential connection between his dementia and hits he took to the head with his punishing playing style.

After a stellar collegiate career at Cal that was capped by an appearance in the 1959 Rose Bowl, Kapp went on to star in Canada before making it to the NFL. He took over for Fran Tarkenton in Minnesota and led the Vikings to a Super Bowl appearance in the 1969 season before losing to Kansas



Kapp is the only quarterback to lead his team to a Rose Bowl, Grey Cup and Super Bowl. He still holds a share of the NFL single-game record with seven touchdown passes, in a 1969 win over Baltimore.

"It was kind of like having your own superhero living in your house," J.J. Kapp said in a phone interview with The Associated Press.

Known as a fighter on the field,

Kapp was the subject of a Sports IIlustrated cover story that dubbed him "The Toughest Chicano." That was the title of Kapp's autobiography published in 2019 and co-

authored by J.J. Kapp and two other friends. Kapp, whose mother was Mexican American, was a fierce advocate for the Latino community who worked with activist Cesar Chavez for farmworker rights. He also dabbled in acting, with credits that include a role in the 1974 film "The Longest Yard" about a prison football team.

He was a trail blazer as one of the first Mexican-American stars in pro football and remains with Jim Plunkett one of only two Mexican Americans to start at quarterback in a Su-

Kapp also later coached his alma mater for five seasons and was on the sideline for one of the most memorable plays in school history when the Golden Bears returned a kickoff with five laterals to beat rival Stanford on the final play in 1982, scoring the touchdown with the Cardinal band on the

When he was hired to coach at Cal before the 1982 season, he vowed not to drink his favorite alcoholic beverage tequila until the Bears made another appearance in the storied bowl game. They never made it back in his lifetime. Kapp had a 20-34-1 record in five years at Cal, his final game being the biggest upset in the history of the rivalry with Stanford when the Golden Bears won as 21-point underdogs.

Jaguars to play twice in London

WASHINGTON, May 10, (AP): Trevor Lawrence and the Jacksonville Jaguars wilvl become the first NFL team to play two international games in the same season when they spend back-to-back weeks in London this year.

The Jaguars will "host" the Atlanta Falcons at Wembley Stadium on Oct. and "visit" the Buffalo Bills at Tottenham Hotspur Stadium on Oct. 8. The Jaguars were set to play two designated home games in London in 2020 but the pandemic canceled those plans.

"Hosting the Falcons at Wembley Stadium will be awesome only to be followed by playing on the road against the Bills at Tottenham Hotspur Stadium," Lawrence said in a statement. "I'm pumped for the experience and know the support from Duval will be strong at both games."

The Jaguars have played nine games in London, including a 21-17 loss to the Denver Broncos last October in front of an NFLrecord international crowd of 86,215 fans at Wembley Stadium. Under first-year coach Doug Pederson, who guided Philadelphia to a Super Bowl title in 2017, the Jaguars last year became the first team to win a playoff game after having the worst

The Tennessee Titans will "host" the Baltimore Ravens at Tottenham Hotspur Stadium on Oct. 15. It'll be the second trip to London for the Titans.

"It's exciting to witness and play a role in the NFL's rise in popularity across the globe," Ravens president Sashi Brown said. "This is an incredible opportunity to play in front of and connect with Ravens fans in the United Kingdom and

throughout Europe." NFL MVP Patrick Mahomes and the defending Super Bowl champion Kansas City Chiefs will "host" the Miami Dolphins in Germany at Eintracht Frankfurt Stadium on Nov. 5. The New England Patriots will the Indianapolis "host" Colts on Nov. 12, also in Frankfurt.

"We are thrilled to be headed to Frankfurt this fall to play the Dolphins,' Chiefs owner Clark Hunt said. "The Chiefs have a long history of helping to grow the game of football around the world, and we have been eagerly anticipating our chance to play in Germany.

The Patriots are 3-0 in international games while the Chiefs are 2-0.

"Germany has some of the most passionate sports fans in the world and has always been an international leader in enthusiasm for American football and the NFL," Patriots owner Robert Kraft said. "I'm thrilled to play a home game in this new market and to continue to build upon our team's long history and engagement with German fans. Our goal is to connect with fans at the local level and I look forward to expanding that fan base and fostering additional relationships and opportunities for partnership in Germany as well as Austria and Switzerland."

The Tampa Bay Buccaneers defeated the Seattle Seahawks in Munich in the NFL's first regular-season game in Germany last sea-

There will be no international game in Mexico in 2023 because of renovations taking place at Estadio Azteca in Mexico City.

The five international games in 2022 set recordbreaking attendance and viewership. Each game was sold out with a total of 356,116 in attendance.

"We are excited to bring three games to London once again, a city with a huge love for the sport and a passionate fan base across the UK," said Peter O'Reilly, NFL executive vice president, club business, major events and international. 'We are also pleased to confirm that the two games in Germany will be played in Frankfurt, a city steeped in NFL heritage. We look forward to staging both games at Eintracht Frankfurt's Stadium, building on the incredible atmosphere experienced at last season's game in Munich."

Roma vs Leverkusen in Europa League semifinal

Alonso takes on his former coach Mourinho

DUESSELDORF, Germany, May 10, (AP): A decade after he last played under José Mourinho at Real Madrid, Xabi Alonso takes on his old boss as a coach.

A win over Mourinho's Roma in their Europa League semifinal first leg in Italy Thursday would further boost Alonso's growing reputation following a remarkable turnaround in Bayer Leverkusen's fortunes this

Leverkusen hasn't got this far in Europe since losing the 2002 Champions League final to a Madrid side led by Zinedine Zidane. That's one of several near misses that earned the club its "Neverkusen" nickname in Germany during the 30 years since its last trophy.

SOCCER

A two-time Champions League winner as a player, Alonso played for Mourinho at Madrid from 2010 through 2013, winning the Spanish league and cup.

Alonso later recalled how he was instantly convinced by Mourinho's ability when the Portuguese coach took over at Madrid.

"I remember the first meeting with Mourinho. He came from Inter (Milan), we came from the World Cup that we won in South Africa (with Spain) and we met in Los Angeles. The first meeting, five minutes, you already know why

he's there and why he's so good,' Alonso said in a 2016 interview with British broadcaster Sky Sports. Mourinho tipped Alonso as a potential coach of the future in a 2019 interview to promote the Top Eleven video game.

"His father was a manager, so he grew up similar to me. He was born with a father-player, he grew up with a father-manager, then he became a player, of course much better than I was," Mourinho said, highlighting Alonso's experience playing for coaches like Pep Guardiola, Carlo Ancelotti and Rafa Benítez.

"So, I think if you put all this together, Xabi has conditions to be a very good coach."

Alonso took over in October with Leverkusen in the relegation zone and has now hauled it up to sixth in Germany. Previous coach Gerardo Seoane had qualified the club for the Champions League the season

before, but results then slumped.

There were doubts when Alonso won one of his first seven games in a tough schedule. However, he built momentum after the World Cup and turned the young squad known for its fast players into a powerhouse in both Germany and the Europa League. Highlights include a comefrom-behind win over Monaco on penalties and a 2-1 win over Bayern Munich swiftly followed by Bayern firing coach Julian Nagelsmann.

Leverkusen's 14-game unbeaten run ended Friday in a 2-1 loss to local rival Cologne, but Mourinho's Roma is coming off its own bruising 2-0 loss to Inter. For both teams, winning the Europa League is their best chance of playing Champions League games next season.

Sergio Busquets to leave 'Barca' at end of season

MADRID, May 10, (AP): Sergio Busquets is ending his "unforgettable journey" of nearly two decades with Barcelona, he said Wednesday.

Busquets, whose contract ends this season, announced his decision with a video released on social media.

Busquets arrived at Barcelona in 2005 and made it to a "B" team coached by Pep Guardiola after two seasons with the under-19s. He helped the "B" team gain promotion and eventually made his first-team debut in

He has played 718 matches for Barcelona, putting him third all-time behind Xavi and record-holder Lionel Messi. Busquets has won 31 titles with the Catalan club, including three Champions Leagues and eight Spanish leagues. He is about to finish his career with anoth-

er league title as Barcelona holds a 13-point advantage at the top with five games remaining.

'There's everything to play for next week'

MADRID, May 10, (AP): Real Madrid's Vinícius Júnior and Manchester City's Erling Haaland were relaxed and laughing as they embraced after the final whistle at the Santiago Bernabeu Stadium.

They both seemed satisfied following an even first leg that ended in a 1-1 draw and left the Champions League semifinal wide open going into next week's return match in Manchester.

Vinícius and Kevin de Bruyne scored with long-range strikes in a match in which Madrid's defense successfully kept Haaland - the Champions League's leading scorer - from being decisive.

"I think both teams have the feeling that it was a good result," said Madrid coach Carlo Ancelotti, who took charge of his 190th Champions League match as coach. "Maybe we played a bit better to deserve a victory, but it's a series that will be even until the last minute.

Madrid beat City in last year's semifinals and went on to win a record-extending 14th Champions League title while the English club again fell short of European success.

"It was an even match," City coach Pep Guardiola said. "They scored when we were better and we equalized when they were better. It will all be decided in Manchester.

"Both teams played well. It's a good draw," Madrid goalkeeper Thibaut Courtois said. "There's everything to play for next week."

City controlled possession but couldn't translate it into significant scoring opportunities. Haaland wasted a few chances early but wasn't much of a threat throughout the game at the Santiago Bernabeu Stadium. The Norwegian came into the match having scored 12 of City's 26 goals in the Champions League this season and was five short of Cristiano Ronaldo's single-season record of 17 for

Madrid in 2013-14. Vinícius created problems for the City defense and opened the scoring in with a shot into the top corner in the 36th minute for his seventh Champions League goal this season. The Brazil forward picked up a pass by Eduardo Camavinga and used one touch to set up his right-footed shot from

outside the area. City struggled to come close to Madrid's goal but De Bruyne found the net in the 67th with a powerful onetimer from outside the area after Madrid lost possession because of a poor pass across the field by Camavinga.

Madrid complained that it was not awarded a corner in the buildup of City's goal. "It was a shame that we conceded that goal," Madrid midfielder Luka Modric said. "I think we deserved more. They had more possession but didn't create a lot of chances. It's still 50-50 and we will go into the
