COP28 latest UAE invite to Israel

Netanyahu, Herzog yet to accept

JERUSALEM, May 23, (AP): Emirati leaders extended a long-sought invitation to Israeli Prime Minister Benjamin Netanyahu to attend the U.N climate conference, known as COP28, in November.

The United Arab Emirates' President Sheikh Mohamed bin Zayed Al Nahyan and Prime Minister Sheikh Mohammed bin Rashid Al Maktoum also invited Israel's figurehead President Isaac Herzog and dozens of other leaders including Syrian President Bashar Assad to COP28, in Dubai.

The Israelis did not immediately accept the invitation, but Netanyahu thanked the Emiratis for the gesture.

The invitation falls short of the high-profile bilateral visit Netanyahu has sought. But a trip to the Gulf Arab country would nonetheless give an important boost to the Israeli leader who has established official ties with the UAE as part of the 2020 Abraham Accords, normalizing relations between the two countries. Netanyahu has repeatedly called for closer ties with Arab countries across the region, but has vet to pay the UAE an official visit since the accords were signed.

Netanyahu, Israel's longest-serving leader, has sought to return to

the world stage. Since returning to office late last year, he has made official visits to Italy, Germany and Britain.

He had hoped to visit the UAE shortly after his right-wing government took office, but the plan was postponed after national security minister and ultranationalist Itamar Ben-Gvir last January visited the compound known to Jews as the Temple Mount in Jerusalem. The same site is home to the Al-Aqsa Mosque compound to Muslims. Such visits are widely viewed as provocations that could lead to new clashes between the Israelis and Palestinians.

The UAE condemned Ben-Gvir's actions at the time. He visited the site again on Sunday, declaring Israel "in charge" and drawing renewed criticism from the UAE, Saudi Arabia, Bahrain, Turkey, Qatar, Jordan, Egypt and the United States.

Netanyahu's alliance with far-right figures like Ben-Gvir has drawn repeated criticism from close allies. He remains uninvited to visit U.S. President Joe Biden in Washington, which some interpret as a White House snub. The U.S. administration has criticized Israel's settlement policies in the occupied West Bank, Ben-Gvir's visits to the disputed compound and the government's push to overhaul Israel's judiciary system.

'Parliament majority decider'

IT is like hatching an egg but without any chick coming out of it. This is how we can describe the decision of the Minister of Commerce and Industry regarding licensing some activities even though they have no headquar-

In many countries of the world, especially those seeking to attract investments and capital, the investor, not only the citizen but even the foreigner, does not need a headquarter for his or her establishment. Instead, the address of the activity is the same address of the attorney authorized to complete the procedure for issuing the license.

Therefore, the activities permitted by the ministerial decision are not sufficient. This is due to the fact that they do not lead to attracting investment. Instead, it is more like a license to practice the profession that is issued by the authorities concerned with the tallying of workers in the countries of the world. Kuwait needs to first work on liberating investment from the long documentary cycle, and secondly, there should be a vision to attract businesses into the country.

For decades, the Ministry of Commerce and Industry's concern was to increase commodity subsidies for citizens. This happened sometimes by adding cheese, salmon fillet and tea. However, when it comes to thinking of how to get the country out of the bottle of monopoly and activate commercial activities, this matter is not on its agenda at all.

Nonetheless, if the Ministry of Commerce and Industry is under the influence of some opinions whose owners do not see more than their noses, then the Ministry of Finance did not take any step towards activating its role in promoting the diversification of national income. It instead contented itself with either fighting the increase in employee salaries, or drawing up a budget that is devoid of any step that would generate capital for the country.

In all countries of the world, when the B.O.T. system is used, the agreement is with the state, and not with officials whose only concern is jealousy and seeking to impede people's businesses, as is the case in Kuwait where the practices of the government and official institutions are characterized by much shortsightedness

For example, the Public Authority for Industry resorted to increasing the fees of the land granted to industrialists, and imposing new conditions on them, bearing in mind that industry is one of the pillars of the renaissance of any country.

If there was a serious vision to push investors into this sector, it would have been similar to what the Kingdom of Saudi Arabia, the Emirates, Bahrain, Qatar, and other countries did by giving this sector the utmost importance, in addition to revitalizing work in the food security sector. In all international reports, Kuwait is seen

as repelling investment, while in the Emirate of Dubai alone, about five billion dollars entered in the year 2021 in the form of investments owing to the flexible laws issued by the United Arab Emirates. The Emirate was thus able to overcome the consequences of the COVID-19 pandemic.

On the other hand, what did Kuwait do? The ministries increased the documentary cycle. Any establishment that needs a loan or issuance of even work visas requires a statement from Kuwait Municipality and the Public Authority for Manpower, as well as a "certificate of specification", as if it builds facilities on the plot every week.

All this only leads to impeding people's business and restricting them, and further expelling both local and foreign investors, while other Gulf countries are preceding us by light years. All the efforts that we put in are adding

All that remains to be said is that the state needs a change in its business, financial and economic mentality, and decisions in general. This can only be done through innovative work as several Gulf countries have done. For this, we say to the Minister of Commerce and Industry - "Knowledge has come to you" from other countries so what are you going to

Erdogan wins runoff endorsement

Russian minister in Saudi

A top Russian official who faces sanctions in the West over Moscow's war on Ukraine visited Saudi Arabia and held talks with his counterpart in the kingdom early on Tuesday, state media re-

Russian Interior Minister Vladimir Kolokoltsev's visit to Riyadh came just days after Ukrainian President Volodymyr Zelensky addressed an Arab League summit held in Saudi Arabia's Red Sea port city of Jeddah on Friday. The visits underline how the kingdom and Gulf Arab states, traditionally the security clients of the United States, have been maintaining their relations with Moscow amid the Ukraine war.

The state-run Saudi Press Agency said Kolokoltsev met with Saudi Interior Minister Prince Abdulaziz bin Saud.

"During the session, they discussed ways to enhance security cooperation paths between the two countries' ministries of interior, in addition to discussing a number of issues of common interest." the report said, without elaborating.

Russian media did not immediately report on the visit.

Kolokoltsev, 62, has been sanctioned by the U.S. since 2018 as part of a slew of sanctions over Russia's activity in both Syria and Ukraine. The U.S. Treasury says that Australia, Canada, the European Union, Japan, New Zealand and the United Kingdom all separately have sanctioned Kolokoltsev as well. The U.S. also refused to grant him a visa to participate in a United Nations chiefs of police summit in 2022, something criticized by MosANKARA, May 23, (AP): The third-placed contender in the Turkish presidential elections formally endorsed President Recep Tayyip Erdogan on Monday for the second-round runoff vote to be held

The nationalist presidential candidate Sinan Ogan, 55, has emerged as a potential kingmaker after neither Erdogan nor his main challenger, opposition leader Kemal Kilicdaroglu, secured the majority needed for a first-round victory on May "I declare that we will support Mr. Re-

cep Tayyip Erdogan, the candidate of the People's Alliance, in the second round of the elections," Ogan said, referring to the Erdogan-led alliance that includes nationalist and Islamist parties.

"We believe that our decision will be the right decision for our country and nation," Ogan stated. Ogan, a former academic who was

backed by a far-right anti-migrant party, won 5.17% in the May 14 vote and could hold the key to victory in the runoff now that he's out of the race. Erdogan received 49.5% of the votes in

the first round - just short of the majority needed for an outright victory - compared to Kilicdaroglu's 44.9%. Erdogan's ruling AK party and its na-

tionalist and Islamist allies also retained a majority in the 600-seat parliament. That increases Erdogan's chances of reelection because voters are likely to vote for him to avoid a splintered government, analysts say

Ogan cited Erdogan's parliamentary majority as a reason for his decision.

"It is important that newly elected president is under the same (leadership) as the parliament," Ogan said. "(Kilicdaroglu's) alliance on the other hand, could not display sufficient success against the People's Alliance which has been in power for 20 years, and could not establish a perspective that could convince us about the future.'

His endorsement of Erdogan came days after he held a surprise meeting with the Turkish leader in Istanbul. No statement was made following the one-hour meeting on Friday.

Ogan insisted on Monday that he did not engage in any horse trading with the Turkish leader. Ogan had attracted votes from people

who disapproved of Erdogan's policies but didn't want to support Kilicdaroglu, who leads Turkey's center-left, pro-secular main opposition party.

Analysts say that despite Ogan's endorsement, it is not certain that all of his supporters would go to Erdogan. Some were likely to shift to Kilicdaroglu while others might choose not to vote in the runoff race.

Umit Ozdag, the leader of the antimigrant Victory Party that had backed Ogan, appeared to dissociate himself from the decision to endorse Erdogan.

Israel demolishes home

The Israeli army said on Tuesday it demolished the home of a Palestinian involved in an attack in Tel Aviv that killed one and wounded two others in March.

Video footage of the attack shows a man the army says was Moataz Khawaja, 23, shooting three men from behind, including one in the head - in one of Tel Aviv's busiest streets - before being shot and killed by Israeli police. Hamas claimed him as a member of its

On Tuesday, the army destroyed Khawa-ja's home in the town of Naalin, northwest of Ramallah in the occupied West Bank. The army said people burned tires, threw stones and shot fireworks at Israeli forces who were razing the site.

Israel demolishes the homes of attackers in an attempt to deter others, a tactic critics say amounts to collective punishment. (AP)

Facility not immune: Israel

'Iran N-unit within reach'

JERUSALEM, May 23, (AP): The Israeli government's national security adviser on Tuesday said a new nuclear facility being built by Iran would not be immune from attack, despite assessments by experts it will be beyond the reach of last-ditch

U.S. bunker-busting bombs. Tzachi Hanegbi made the comments in response to an Associated Press report that said the new facility appears to be as deep as 100 meters (328 feet) below ground.

Hanegbi, speaking at a security conference near Tel Aviv. said he was not surprised by the report, noting that Iran has other underground facilities. While he acknowledged the location would complicate any potential military strike on the facility, he said there are still solutions to the challenge

"What is possible to say about this matter is that there is no place that can't be reached," he

He declined to say whether Israel had the ability to do this on

"We hope we won't get to a situation where the solution to the story of a nuclear weapon in Iran is a kinetic solution, a solution involving an attack," he said, adding that Israel prefers to see the international standoff with Iran resolved through diplomatic

Israel considers Iran to be its greatest enemy and Prime Minister Benjamin Netanyahu has repeatedly said he will not allow Iran to develop a nuclear weapon. He has said international diplomacy should be accompanied by a serious military option and hinted that Israel would be prepared to strike Iran on its own if necessary.

Photos and videos of Iran's new facility from Planet Labs PBC show Iran has been digging tunnels near the Natanz nuclear site, which has come under repeated sabotage attacks over the years. Excavation mounds at the site suggest the facility could be between 80 meters (260 feet) and 100 meters (328 feet) under the ground, according to experts and AP's analysis.

MADRID: Spain has opposed Israeli National Security Minister Itamar Ben-Gvir's speech on Al-Aqsa Mosque in Jerusalem, calling for respecting the sacred places.

In a statement issued on Monday, Spain's foreign ministry said it rejected the speech of Ben-Gvir who broke into Al-Aqsa Mosque, in a call for controlling over it, under the protection of the Israeli

The statement called on the parties to do their best in order to avoid tension at the Mosque's compound, maintain stability and support **Jordan**'s efforts in this matter. (KUNA)

The source said the latest statistics of the Ministry of Interior showed that the number of expatriates under Article 18 visa (private sector employees) reached 1,408,030; while those under Article 20 (domestic workers) reached 783,372 and those under Article 22 (family or dependent visa) reached 512,306.

The source added that the Indian community is still the largest in the country, followed by the Egyptian community and then the Filipino community.

'Supplies only for needy'

'No donations from ration food'

KUWAIT CITY, May 23: The Ministry of Social Affairs' Department of Charitable Societies and Foundations issued a circular to the boards of directors of all well-known associations to prohibit them from receiving donations in the form of subsidized food items, based on an official letter that the Ministry of Social Affairs recently received from the Ministry of Commerce and Industry in this regard, reports Aljarida daily.

According to informed sources, the associations that violate the circular will be subject to legal accountability, and the necessary measures will be taken by the ministry.

Receiving donations that include food supplies is an explicit violation of the executive regulations of law No. 117/2013 that amended some provisions of decree law No. 10/1979 concerning the supervision of goods and services.

The aim of this step is to preserve the commodity stock of these materials that the state supports in huge sums annually, especially since they are provided to relieve some of the financial suffering of those who deserve it, instead of donating them to charitable organizations.

The sources affirmed that the ministry will continue to "screen" all well-known charitable donations to determine the extent of their effectiveness and the services they provide to the community, in addition to the extent of their commitment to the controls and requirements regulating charitable work, and achieving the goals for which

they were publicized. They revealed the issuance of decisions to withdraw the publicity of a number of justifications in the near future, either at the request of their publicists due to their lack of time in managing their affairs, or due to their violation of the regulations and requirements of advertising, including closing their bank account for a long time and not carrying out any activities on the ground for many years, in addition to not providing the ministry with the estimated budget,

Food poisoning denied

KUWAIT CITY, May 23: The Ministry of Health has vehemently denied the allegation that some people suffered from food poisoning after eating chicken from restaurants, reports Al-Rai daily.

The ministry made the clarification after the audio clip of the alleged food poisoning went viral on social media, indicating the issue emerged in May 2022 and it also denied the allegation at the time. It then advised the public to refrain from spreading false information.

Meanwhile, the Ministry of Social Affairs has launched new services on the Sahl application - issuance of 'To Whom It May Concern' certificates for obtaining social assistance and accessing shareholder numbers in cooperative societies, reports Al-Anba daily.

The ministry confirmed that it intends to add all services on the platform to ease procedures and expedite the completion of transactions.

Call to choose reform

Independent judiciary vital: ex-MP

KUWAIT CITY, May 23: Former MP and First Constituency candidate Saleh Ashour has stressed the need to reform the legislative, executive and judicial authorities.

He pointed out that reforming the judiciary should be done through the amendment of the Constitutional Court Law and method of appointing judges, in addition to enhancing the autonomy of the authority.

He said the legislative authority is reformed by amending the National Assembly Law and Election Law No. 35/1962, while the reformation of the executive authority is done by appointing a prime minister and ministers in accordance with the parliamentary election results. He believes this procedure guarantees cooperation and harmony between the legislative and executive authorities.

He added the top priority is for the Sabah Family members to lessen disputes among themselves and such disputes should not affect the political arena. He urged the Sabah Family to appoint pro-reform personalities to leadership positions, and convey a clear message to anyone who violates the laws and threatens the citizens' interests that he will be penalized as per the law. He concluded that members of the family must serve as a model to the whole world in terms of commitment to the law and the Constitution.

Former Minister of Public Works, former MP and Third Constituency candidate Jenan Bu Shehri affirmed that the violations in the distribution of State properties in favor of certain individuals and companies are recorded in the reports of the State Audit Bureau (SAB) as per the directives of the National Assembly and Council of Ministers. She disclosed these reports include recommendations to address the issue, but

they have remained in the drawers. She asserted the unfair distribution of State properties has had a negative impact on youths who want to start their own businesses, prompting them to cancel such plans.

Former MP and Second Constituency candidate Ahmed Al-Hamad stressed the need to fix the political environment after the exchange of accusations and doubts between political opponents. He added the society needs reconstruction of the concept of loyalty to the homeland. He also emphasized the importance of restoring citizens' trust in public institutions and lawmakers, while the decision-makers must adhere to the Constitution.

Flexible work hours: The Council of Ministers is currently looking into the possibility of permanently implementing a new flexible working hours mechanism in State institutions to solve the traffic crisis, starting from August – before the new academic year, reports Al-Qabas daily quoting a reliable source.

The source explained that the new mechanism will be applied in all State agencies, indicating the starting time will be set from 7:00 am to 8:30 am from Sunday to Thursday. He said each entity will choose the appropriate time to start their flexible working hours; such that, employees will not go to work at the same time.

Citing an example, the source stated that public sector employees usually work for seven hours a day or 35 hours per week; so if they start at 7:00 am, their work will end at 2:00 pm; while those who start at 8:00 am shall leave at 3:00 pm.

The source affirmed that the council is keen on implementing well-studied mechanisms to prevent traffic congestion without disrupting the flow of work in State institutions in the interest of citizens.

He revealed the concerned authorities are currently coordinating their efforts, including the Civil Service Commission and the ministries of Interior and Education, to evaluate the new mechanism and address loopholes, if any.

Diwaniyas play role seekers for top posts in parliament polls

KUWAIT CITY, May 23, (KUNA): Diwaniyas, a sort of socially based town halls, are very famous in Kuwait for bringing people together. During elections, they play an important role in shaping public opinions and even influencing voters.

In interviews with Kuwait News Agency (KUNA), several experts stressed that Diwaniyas would once again play a pivotal role in the election especially the upcoming 2023 National Assembly elections scheduled on June 6, via encouraging the democratic process in the country and also boosting the importance of political awareness.

Diwaniyas help shape public opinion and it has an impact on the voting process, said professor of psychology at Kuwait University (KU) Dr. Kamal Al-Farraj.

Political discourse at Diwaniyas help educate the masses on the vitality of partaking in the political and democratic process that help shape the future of the country, he argued, indicating that issues pertaining to society, the economy, and other important aspects of life were usually discussed during Diwaniya

He noted that Diwaniyas also provided a place for people to network, share opinions, and collaborate on a multitude of

Providing his outlook, professor of public relations and media at Kuwait University (KU) Dr. Hussein Ibrahim claimed that sometimes Diwaniyas have a stronger media voice than media outlets themselves.

Diwaniyas help move the proverbial democratic wheel in Kuwait, steering individuals - through dialogue and arguments - towards certain candidates and ideals, he added.

He argued that Diwaniyas could also be digitized in a sense that candidates could hold virtual Diwaniya gatherings on any Social Media platforms online to directly connect with people and get their opinions through. Also commenting on the importance of the Diwaniyas in

society, professor of social studies and services at KU Dr. Yaqoub Al-Kandari said that such venues could plant the initial political seeds of an individuals and groups. He also said that Diwnaniyas would be sometimes referred to as "miniature parliaments" due to the vast political opinions

and discussions on how to deal with social and economic problems facing Kuwait. While Diwaniyas in the past were gathering places to the well-known figures in society prior to the discovery of oil,

nowadays any normal citizen could establish his Diwaniya and all were welcomed to attend, he added. Diwaniyas in Kuwait, since the 1920s that, were venues dedicated to gatherings amongst people to discuss life in gen-

eral and also find solutions to problems facing society as a whole, he pointed out. He noted that currently, Diwaniyas played a part in monitoring MPs and letting them know what the people were really

thinking about them and their efforts at parliament. Speaking thoroughly on the history of Diwaniyas, historian Dr. Yaqoub Al-Ghunaim revealed that actually Diwaniyas ex-

isted in Kuwait for some 300 years. The modern version of the Diwaniya as we know today began around 1921 with the establishment of the Shura (consul-

tation) Council, he indicated, adding that Diwaniyas continued to develop as the political scene in grew with between 1961-63 after independence and the first National Assembly elections. Despite the active role of social media that provides services

in promoting election campaigns, headquarters still appeal to the attention of voters of all ages and are their favorite places as a meeting spot for direct communication with candidates. While some candidates in the 2023 Kuwaiti National As-

sembly elections announced that they would not set up campaigns at headquarters and go with social media, others still prefer direct communication with voters to present their pro-

MoH withdraws licenses

KUWAIT CITY, May 23: As part of its responsibilities to supervise and regulate private health institutions; the Ministry of Health has confirmed the closure and withdrawal of the licenses of five private health centers, 40 private clinics and 20 private pharmacies for committing violations, reports Al-Qabas daily.

The ministry took this step as per the recommendation of specialized inspection committees that uncovered the violations and the results of investigations conducted by the Medical Liability Authority.

According to the ministry, the abovementioned pharmacies were proven to have violated law number 28 of 1996 on regulating the pharmacological profession and its amendment - law number 30 of 2016,. It has been discovered that some of these pharmacies are managed by other people, not the owners or holders of a license to operate pharmacies.

The closed health centers and clinics violated Medical and Allied Professions Law number 70 of 2020, as well as the decisions on regulating the private medical sector and health

"THERE are negative political and social behaviors that shorten a person's life, psychologically, intellectually, physically, and even spiritually, because they destructively consume all his mental and physical powers and potentials, and undermine his innate dignity, and here we mention the following," **Dr. Khaled Ayed Al-Jenfawi** wrote for **Al-Seyassah** daily.

"Inciting political discourse is the provocative discourse used by those seeking political domination over others, which is characterized by incitement to strip the different human characteristics, especially every narcissistic political discourse in which he incites violence in society for personal, political, or ideological reasons at the expresses of eaciletability.

"This will inevitably lead to an increase in the rate of psychological disorders and stress among other members of society, which may lead to higher rates of blood pressure and heart diseases, depression, hostility, irritability, and chronic stress, which will lead to shortening the lives of the victims who live in an environment in which inciting political discourse is spread.

"Exaggerated courtesy is an umbrella from which flattery and ingratiation to people of money and ideological, political and social influence hangs, with the aim of getting close to them, especially with the intention of obtaining money, gifts, and illegal privileges.

"This leads to a decline in the moral level of those who practice these behaviors that kill the living human conscience.

"Tribal, sectarian, and factional fanaticism are but negative pursuit of racial biases and incitement to tribal, sectarian, or factional polarization in a national society characterized by an identity and a national culture that includes all spectrum of a pluralistic society leads to high rates of alienation, disintegration, delinquency, and social violence.

"Speed of anger and irritability are the fastest way to shorten a person's life in today's world and to this his willful indulgence in rage and negative emotion, which inevitably leads to high blood pressure (the silent killer)."

"On Tuesday, May 16, 2023, the media and social media dealt with the news of the signing by the Acting Director General of the Public Authority for Manpower, Mr. Marzouq Al-Otaibi, of a joint memorandum of understanding between the Public Authority for Manpower and the Ministry of Social Affairs aimed at Kuwaitization of supervisory and leadership positions in the cooperative sector, columnist **Dr Mohammad Al-Duwaihis** wrote for **Al-Shahed** daily

"This memorandum comes within the framework of the directives of the First Deputy Prime Minister, Minister of Interior and Acting Minister of Defense Sheikh Talal Khaled Al-Ahmad Al-Sabah to activate the policy of Kuwaitization of jobs in line with the government's directives and to increase the rates of employment of Kuwaitis in the private sector.

"If we want to review the impact and importance of signing this memorandum on the ground, we find that the total number of supervisory positions (a general manager and two deputy general managers) in the cooperative sector ranges from 210 to 220 jobs, assuming that the number of cooperative societies is between 70-73.

"Likewise, the number of department heads' jobs in the cooperative sector ranges are between 210-290 supervisory jobs, assuming that the number of department heads' jobs in each association is 3-4, and most of these jobs

are assumed to be occupied by Kuwaitis currently, according to Resolution No. 16 of 2016, which requires the Kuwaitiization of supervisory positions in cooperative associations.

"In short, this news suggests that it will open many opportunities for Kuwaitis to work in the cooperative sector, and this is far from reality.

"The Ministry of Social Affairs issued Resolution No. 68/2023, Article 50 of which stipulates that the applicant for the supervisory position should not be retired personnel for any reason, and thus all retired Kuwaitis are deprived from working in the cooperative sector.

"In general, we can seek an excuse for the ministry if the aim of not hiring Kuwaiti retirees is to give an opportunity and priority to recent Kuwaiti graduates who wish to work in the cooperatives sector, but that the Kuwaiti retirees be expelled only because they are retired, this is a wrong approach that could empty the cooperative sector of some Kuwaiti expertise in this field and open the cooperative field for expatriate workers to increase their presence in this vital sector.

"The national duty requires that all jobs in cooperative societies be for Kuwaitis, whether they are retired or not, and the matter is not limited to bright jobs in this vital sector.

"On this occasion, I hope that those responsible for demographics will review the study prepared by the demographics team formed under the chairmanship of His Excellency former Minister Ahmed Al-Kulaib on 8/23/2020 and the numerous and valuable recommendations proposed by the team in its report in the security, educational, economic, social, humanitarian and organizational fields."

"Only a few days separate us from the National Assembly election, which is considered a democratic wedding that Kuwait and its people started celebrating 60 years ago," columnist **Ziben Al-Bazal** wrote for **Al-Anba** daily.

"Without a doubt, it was a pivotal stage in the political history of Kuwait, as it brought about many changes. Civil life and the new modern State emerged through it, especially since the drafting of the Constitution coincided with the independence, and Kuwait's membership in many international, Arab and Islamic organizations. This was followed by preparations for the first democratic election of the legislature.

"The constituent body was the nucleus of parliamentary work and democratic life, through which the constituencies were distributed, legislative elections were called, and the government was formed after the announcement of results. This system is being implemented up to the present day.

"It is natural that many events took place throughout the years, resulting in the adoption of several projects and laws. Today, we see the results in many aspects of life, such as urban planning, health and education. This is an indication of the importance of the legislature, which gave people the right to run for election and to vote. This is the main tool used in assessing outputs.

"If the choice is correct and based on awareness and realization, a strong legislature will come out for us. It meets the people's demands and needs.

'Accused attacked sister over breakfast'

Securitymen arrest father's killer

KUWAIT CITY, May 23: An unidentified individual was arrested for murdering his father inside the family house in Firdous area, reports Aljarida daily.

According to security sources, the

Criminal Security sector, represented by the General Department of Criminal Investigation's Research and Investigation Department in Farwaniya Governorate, was able to arrest an individual after preparing an elaborate ambush for him on the Sixth Ring Road with the help of one of his friends.

The accused confessed to the use of

The accused confessed to the use of narcotic drugs. In his confessions, which had surprised the detectives and the deputy public prosecutor, he explained that when he woke up on the day of the crime, he asked his sister to prepare breakfast for him. Not liking the breakfast, he attacked his sister, which caused a severe head injury. His father then intervened to free his sister from his hands, which prompted him to clash with him. His father was also severely injured in the head after he hit him with an ashtray.

He then escaped to a livestock pen in Kabd area and took his firearm – a Kalashnikov with 90 rounds - with the intention of killing all members of his family, starting with his sister.

However, when he arrived at the house, his father confronted him. He shot his father in the chest, and the second bullet hit a window of the house which

broke. After that, the gun malfunctioned, prompting him to flee the scene.

After the murderer escaped, officers began tracking all his movements until they found one of his friends who helped them. He told them he would call him and meet him on the Sixth Ring Road to hand him a sum of money. The friend called the killer and they met on the Sixth Ring Road and that was when the detectives arrested him. Inside his vehicle, they found the weapon used in the crime. He was referred to the Public Prosecution.

Mol warns: The Ministry of Interior has warned against responding to messages from unknown social media accounts and telephone numbers, as some gangs call through international or local numbers or social networking sites impersonating certain individuals to request for bank or identification data to swindle others, reports Al-Jarida daily.

The ministry urged the public to refrain from responding to such messages and to report them immediately through the WhatsApp number of the Anti-Cybercrime Department (97283939) to avoid falling victim to fraudsters. It also advised the public neither give their bank account number or password to anyone, nor photograph the bank card or password and then send the photos to other people.

Attempt foiled to smuggle out large quantities of subsidized foodstuffs

Mechanism for employing citizens in co-ops to be okayed

KUWAIT CITY, May 23: The Kuwaiti authorities have foiled an attempt to smuggle 550 cartons of government subsidized milk and other foodstuffs. The incident highlights the ongoing efforts to combat illicit trade and protect the integrity of the local supply chain, reports Al-Rai daily

Abdullah Al-Hajri, Director of the Sulaibiya and Vegetable Customs Administration, told the daily that, from January 1, 2022 to May 6, 2023, tons of food supplies were seized, including 8,800 cartons of milk, 1,173 bags of sugar, 224 boxes of infant formula, 5,036 boxes of oil, and 4,490 bags of bread and rice, 1,492 bags of lentils, 486 cartons of tomato paste, 5,100 bags of flour, 11,882 bags of pasta, and 3,675 boxes of ghee which the suspects were attempting to smuggle out of the country.

He stated that these seizures are part of a series of customs seizures that took place within about 16 months, pointing out that customs seizure reports were recorded and handed over to the Supply Department at the Ministry of Commerce to take the necessary action in this regard.

He stressed that the customs personnel stand on the lookout for the smugglers of supply materials at all customs outlets, explaining that they have strict instructions to check the departing goods and vehicles to prevent the smuggling of these subsidized foodstuffs.

Al-Hajri added that the customs personnel, in cooperation with the ministries of Commerce and the Interior, carry out preemptive checks on shipping companies, which resulted in the detection of some of those involved in smuggling supplies by hiding them in personal belongings when shipped.

This is in addition to the Ministry of Commerce tightening control over workers at the ration distribution centers at the cooperative societies, as well as through the automatic link between the distribution centers and the ministry.

From January 1, 2022 to May 6, 2023 the authorities have seized 8,800 cans of powder milk, 1,173 bags of sugar, 224 boxes of infant formula, 5,036 cans of oil, 4,490 bread bags, 1,492 bags of lentils, 486 cartons of tomato paste, 5,100 bags of flour, 11,882 bags of pasta and 3,675 boxes of local ghee.

According to reports, the confiscated powdered milk tins were intended to be smuggled out of Kuwait in violation of import regulations. The authorities, vigilant in their duties, intercepted the shipment at a port of entry, preventing the illegal entry of the goods.

Kuwaiti authorities remain committed to combating smuggling activities and maintaining the integrity of the local market. Such acts undermine the efforts of the government to provide essential supplies to its citizens and can have adverse effects on the economy and public welfare.

Employment in co-ops: The mechanism for employing citizens in cooperative societies will be approved within this week in accordance with the ministerial decision on appointing citizens in supervisory positions, reports Al-Anba daily quoting a reliable source from the Ministry of Social Affairs.

The source confirmed that the mechanism is in line with the protocol signed by the ministry, Union of Cooperative Societies and Public Authority for Manpower (PAM) last week.

The source said the Quadripartite Committee concerned

with employment is expected to hold its meeting this week as per the protocol, indicating the launching of the employment platform is within the jurisdiction of PAM.

He added the conditions for appointment to supervisory positions are as follows: should be a Kuwaiti, and hold appropriate academic certificates obtained from a public or private university inside or outside the country or institutes accredited by the Ministry of Higher Education.

will also auction 202 parcels containing various goods, next Wednesday (May 23) at the Bait Al-Mal in Sulaibiya.

In a press release, the customs administration said it has the right to stop the sale, postpone it, or hold it at another date and time in the event of not obtaining the appropriate price or for any reasons it deems contrary to its interest.

KUWAIT CITY, May 23: Economist Steve Hanke of the Johns Hopkins University says Kuwaitis are the happiest Arab people and the second happiest people in the world, after Switzerland on a list of 157 countries as shown by the Misery Index, reports Al-Rai daily.

The Hanke annual Misery Index sums up unemployment, inflation and bank lending rates minus the change in the real per capita GDP.

In his annual index, Hanke attributed the main reason for the happiness of Kuwaitis to low unemployment rates, which is the same factor for the happiness

According to the index, Kuwait, despite the country's political differences, achieved a strong performance in all fields in 2022. Based on Hanke's calculations, the negatives were minimal, while the good indicators were strong (annual real GDP growth reached 4.5 percent).

Thanks to the strong economic performance, Switzerland, Kuwait, Ireland, Japan, Malaysia, Taiwan, Niger, Thailand, Togo and Malta occupied the top ten positions as the happiest countries in the world in 2022

In contrast, Zimbabwe, Venezuela, Syria, Lebanon, Sudan, Argentina, Yemen, Ukraine, Cuba, Turkey, Sri Lanka, Haiti, Angola, Tonga and Ghana were the 15 most miserable countries in the world.

The idea of the Misery Index was originated by the well-known economist Arthur Okun, who served as Chairman of the Council of Economic Advisers during the Johnson administration and developed the original Misery Index for the United States. The Okun index is equal to the sum of inflation and unemployment rates.

The index was later modified by Harvard University professor Robert Barrow who modified the misery index by also including the 30-year government bond yield and the output gap to real GDP.

Then Steve Hanke also modified Barrow's version of the misery index by replacing the output gap with the real GDP per capita growth rate and replacing the 30-year government bond yield with the lending rate. Hanke argues that the higher the interest rates, the higher the cost of credit, and with it the more miserable the borrowers.

MoC approves excellent job 'bonus'

KD 180 screen allowance okayed for 'pandemic time' Gulf teachers

KUWAIT CITY, May 23: The Civil Service Commission has approved a screen allowance of 180 dinars for each teacher from the GCC countries - those who worked during the distance learning period at the height of the corona crisis -working in public education schools similar to their Kuwaiti counterparts who are eligible for this allowance, reports Al-Rai daily quoting an educational source.

The source stated that the administrative sector in the Ministry of Education had submitted a list of the names to the CSC and is awaiting approval.

Meanwhile, the educational areas have completed the task of listing the names of teachers who are shortlisted to be replaced and their services will be terminated before May 31.

The source said that the financial sector in the ministry will pay teachers' dues and salaries until next September and not at the end of the year as has been rumored by some sources. In the meantime, the Ministry of Com-

munications has approved the excellent job performance bonus of 2,272 employees for the year 2022, reports Al-Rai daily.

The total amount of the bonus is estimated at KD1 million and it will be deposited into the accounts of eligible employees in the coming days – upon approval of the performance assessments.

Acting Undersecretary Eng Ahmed Al-Majren has approved the list of beneficiaries which, for the first time in the history of the ministry, excluded the undersecretary and assistant undersecretaries due to retirement or interim status.

Sources disclosed the bonus amount is based on the job grade and title, in addition to the Civil Service Commission regulations, as follows: KD1,500 for the department director and office manager; KD 1,250 for the observer; KD 1,000 for the department head and office manager; KD 850 for the division head; KD 800 for Kuwaitis occupying first to fourth degree jobs; KD 600 for Kuwaitis with the fifth to eighth degree jobs; KD 300 for Kuwaitis occupying auxiliary and assistant technical positions; KD 300 for non-Kuwaitis receiving lump sum salary; and KD 200 for non-Kuwaitis under the piecework

Meanwhile, the Civil Service Commission (CSC) has announced the launching of social allowance services on the unified government online platform (Sahl), reports Al-Qabas daily.

The CSC posted on its official Twitter account that these new services are as follows: request to stop social allowance for children, request to stop social allowance for the wife, request to amend the health

'Kuwait Airways' adds Manageesh to fleet - official

KUWAIT CITY, May 23: The Kuwait Airways announced that it had received the eighth Airbus A320neo aircraft, the Manageesh, which comes as part of a deal that includes nine aircraft of the same type, reports Al-Rai daily.

Ali Al-Dukhan, Chairman of the Board of Directors of Kuwait Airways, said the plane, which arrived from the Airbus factory in the French city of Toulouse, is among the desired goals pursued by the KAC as part of its strategic plan to expand its airline network around the world.

Al-Dukhan added that the presence of the A320neo in the Kuwait Airways fleet enhances its position as a regional and global leader, stressing the keenness to continuously follow up on customer requirements to provide the best and latest

He explained that with the arrival of the "Manaqeesh", the Kuwait Airways fleet now includes 32 aircraft, including three Airbus A330-200s, seven Airbus A200-320seo, 10 Boeing 777-300ERs, and 8 Airbuses, Airbus A320neo and four Airbus A330-800.

He pointed out that Kuwait Airways has agreed with Airbus to receive six Airbus A321neo aircraft with a capacity of 169 seats and three A321neo-LR aircraft with a capacity of 169 seats in the coming years, since they are characterized by high technical specifications and modern technology.

Al-Dukhan stated that the Airbus A321neo aircraft contains additional advantages that achieve the company's goals in terms of profitability and sustainability, in addition to "significant savings" in operating costs.



Palestinian Amb. praises Kuwait's support in int'l forums



He affirmed that Kuwait enjoys the confidence, respect and appreciation of the Palestinian leadership, led by President Mahmoud Abbas, and that it is always present in the conscience of the Palestinian people.

In his speech during a press conference held at the embassy headquarters on the occasion of the 75th anniversary of the Nakba, Ambassador Tahboub

said, "As to what is required of Kuwait in the next there stage, is nothing required of Kuwait, as it does not wait for us to ask, but always takes initiative



all possible ways. Coordination between the two countries is permanent and continuous. Our confidence in the Kuwaiti foreign policy is very great. Kuwait plays an important role in the regional and international arenas. We are always keen to inform the Kuwaiti side of everything related to the Palestinian issue and everything that happens in Palestine or about any Israeli violations against our people.'

Facilities

Regarding the Kuwaitis who visited Palestine and the facilities provided to them by the embassy, Tahboub explained that 500 Kuwaitis, in addition to official and private Kuwaiti institutions, visited Palestine during the past five years after they submitted requests in this regard to the Civil Affairs Unit for the necessary permits to enter Palestine.

When asked about the Palestinian teachers contracted by Kuwait's Ministry of Education, he said, "The total number of Palestinian teachers recruited since 2017 to date has reached 1,250. A new batch of 70 teachers will arrive within days. This confirms Kuwait's confidence in the Palestinian teachers, and we are proud of it. We are very proud of our teachers who have proven their worth, sincerity and loyalty to their work since 2017 to this day."

Tahboub explained, "There are some properties owned by Kuwaitis in Palestine and registered under their names officially in all Palestinian departments. Strict instructions were issued by President Abbas to preserve the properties of Kuwaitis and not to dispose of them in any way. If there is anyone who wishes to go to Palestine in order to receive his real estate and properties, we are ready to make the necessary arrangements to facilitate his entry into Palestine to receive their property.

Since the opening of the Palestinian embassy in Kuwait, the number of files in our possession is 54 files. This means 54 families have property in Palestine. A number of owners of these properties have disposed of their property.

Regarding the changes in the last 75 years after the Nakba, Tahboub said, "The Palestinian Nakba is continuous from 1948 to the present day. It is a crime that is still happening every day. The Israeli occupation is trying to empty all of Palestine of its people and wants to keep us in a state of permanent Nakba.'

He went on to say, "The issue of Palestine is a central issue for all Arabs and Muslims. The Arab peace initiative has become a basic document of the Security Council and the United Nations, and a reference for the peace process or the political process in the Middle East. It is a basis for resolving the Palestinian-Israeli conflict from our point of view, in addition to peace references and various UN Security Council resolutions regarding the Palestinian cause.

Jerusalem and Al-Aqsa Mosque are a red line for us as Palestinians first and also as Arabs and Muslims. Protecting Al-Aqsa Mosque, protecting Jerusalem in general, and protecting Islamic and Christian sanctities from violations is a duty for all of us.

The ambassador thanked the Kuwait Red Crescent Society for restoring more than 20 shops in one of the most important markets in the Old City of Jerusalem, which led to the return of life to the Old City.

Regarding the Palestinian-Palestinian reconciliation, Tahboub indicated that there is a permanent dialogue among the Palestinian factions, expressing his hope that this reconciliation will come soon and the Palestinian people will unite with its various factions.

OIC strongly condemns Israeli crime in Nablus

Why America has a debt ceiling: 5 questions answered

Republicans and Democrats are again playing a game of chicken over the U.S. debt ceiling - with the nation's financial stability at stake.

Treasury Secretary Janet Yellen recently said that June 1, 2023, is a "hard deadline" for raising the debt limit, currently set at US\$31.38 trillion, to avoid an unprecedented default. The government hit the ceiling back in January and has been using "extraordinary measures" since then to keep paying its bills.

Last-minute negotiations between the White House and Republicans have been mostly fruitless as conservatives in the House push for big spending cuts and policy changes, while President Joe Biden has insisted on lifting the ceiling with no strings attached. They are expected to continue to meet in the coming

Economist Steven Pressman explains what the debt ceiling is and why we have it - and why it may be time to abolish it.

Like the rest of us, governments must borrow when they spend more money than they receive. They do so by issuing bonds, which are IOUs that promise to repay the money in the future and make regular interest payments. Government debt is the total sum of all this borrowed money.

The debt ceiling, which Congress established a century ago, is the maximum amount the government can borrow. It's a limit on the national debt.

The U.S. government debt of \$31.38 trillion is about 22% more than the value of all goods and services that will be produced in the U.S. economy this year.

Around one-quarter of this money the government actually owes itself. The Social Security Administration has accumulated a surplus and invests the extra money, currently \$2.8 trillion, in government bonds. And the Federal Reserve holds \$5.5 trillion in U.S. Treasurys.

The rest is public debt. As of October 2022, foreign countries, companies and individuals owned \$7.2 trillion of U.S. government debt. Japan and China are the largest holders, with around \$1 trillion each. The rest is owed to U.S. citizens and businesses, as well as

state and local governments. Before 1917, Congress would authorize the government to borrow a fixed sum of money for a specified term. When loans were repaid, the government could not borrow again without asking

Congress for approval. The Second Liberty Bond Act of 1917, which created the debt ceiling, changed this. It allowed a

continual rollover of debt without congressional approval.

Congress enacted this measure to let then-President Woodrow Wilson spend the money he deemed necessary to fight World War I without waiting for oftenabsent lawmakers to act. Congress, however, did not want to write the president a blank check, so it limited borrowing to \$11.5 billion and required legislation for any increase.

The debt ceiling has been increased dozens of times since then and suspended on several occasions. The last change occurred in December 2021, when it was raised to \$31.38 trillion.

Whenever the U.S. nears its debt limit, the Treasury secretary can use "extraordinary measures" to conserve cash, which she indicated began on Jan. 19. One such measure is temporarily not funding retirement programs for government employees. The expectation will be that once the ceiling is raised, the government would make up the difference. But this will buy only a small amount of time.

If the debt ceiling isn't raised before the Treasury Department exhausts its options, decisions will have to be made about who gets paid with daily tax revenues. Further borrowing will not be possible. Government employees or contractors may not be paid in full. Loans to small businesses or college students may stop.

When the government can't pay all its bills, it is technically in default. Policymakers, economists and Wall Street are concerned about a calamitous financial and economic crisis. Many fear that a government default would have dire economic consequences - soaring interest rates, financial markets in panic and maybe an economic depression.

Under normal circumstances, once markets start panicking, Congress and the president usually act. This is what happened in 2013 when Republicans sought to use the debt ceiling to defund the Affordable Care Act.

But we no longer live in normal political times. The major political parties are more polarized than ever, and the concessions McCarthy gave right-wing Republicans may make it impossible to get a deal on the debt ceiling.

One possible solution is a legal loophole allowing the U.S. Treasury to mint platinum coins of any denomination. If the U.S. Treasury were to mint a \$1 trillion coin and deposit it into its bank account at the Federal Reserve, the money could be used to pay for government programs or repay government bondholders. This could even be justified by appealing to Section 4 of the 14th Amendment to the U.S. Constitution: "The validity of the public debt of the United States ... shall not be questioned."

McCarthy both said they had a productive debt ceiling discussion late Monday at the White House, but there was no agreement as negotiators strained to raise the nation's borrowing limit in time to avert a potentially chaotic federal

It's a crucial moment for the Democratic president and the Republican speaker, just 10 days before a looming deadline to raise the debt limit.

As soon as June 1, Treasury Secretary Janel Yellen said in a letter to Congress, "it is highly likely" the government will be unable to pay all the nation's bills. Such an unprecedented default would be financially damaging for many Americans and others around the world relying on U.S. stability, sending shockwaves through the global economy.

Each side praised the other's seriousness, but basic differences remained. They are at odds over how to trim annual budget deficits. Republicans are determined to cut spending while Biden's team offered to hold spending levels flat. Biden wants to increase some taxes on the wealthiest Americans and some big companies, but McCarthy said early on that that is out of the question.

In a brief post-meeting statement, Biden called the session productive but merely added that he, McCarthy and their lead negotiators "will continue to discuss the path forward." Upbeat, McCarthy said their teams would work "through the night."

Biden said all agreed that "default is not really on the table.'

Though there is no agreement on basic issues, the contours of a deal seem within reach. A budget deal would unlock a separate vote to lift the debt ceiling, now \$31 trillion, to allow more

Negotiations are focused on finding compromise over a 2024 budget year cap that would be key to resolving the standoff. Republicans insisted next year's spending be less than it is now, but the White House instead offered to hold spending flat at current 2023

Republicans initially sought to roll back next year's spending to 2022 levels, and impose 1% caps on spending growth for 10 years, though a later proposal narrowed that to about six years. The White House wants a twoyear budget deal, keeping 2024 spending flat. They proposed a 1% cap on spending growth for 2025, according to a person familiar with the talks and granted anonymity to discuss them.

A compromise on those topline spending levels would enable McCarthy to deliver for conservatives, while not being so severe that it would chase off the Democratic votes that would be needed in the divided Congress to pass

Wall St slips as debt worries hang

NEW YORK, May 23, (AP): Wall Street is slipping Tuesday as the U.S. government creeps closer to the edge of a potentially disastrous default on

The S&P 500 was 0.6% lower in its first trading after President Joe Biden and House Speaker Kevin McCarthy closed a meeting late Monday that they called productive but ultimately ended with no deal.

The Dow Jones Industrial Average was down 56 points, or 0.2%, at 33,225, as of 1:03 p.m. Eastern time, while the Nasdaq composite was 0.7%

Washington is facing a deadline as early as June 1, when the U.S. government could run out of cash to pay its bills unless Congress allows it to borrow more. Economists and investors widely believe a default would send shockwaves through the global economy and financial markets.

The stock market has remained resilient despite the concerns, largely because this scenario has played out many times before with Congress ultimately agreeing to a deal. The alternative simply seems too dire for anyone to allow.

But a worry on Wall Street is that Washington may not feel urgency to act until financial markets shake hard enough to show the stakes for politi-

Some areas are showing more concerns, particularly in the bond market where some Treasury bills are supposed to get repaid around the date of a possible default. Prices for those bonds have fallen, in part because of the debt-ceiling worries, which in turn has pushed up their

The worries about the debt ceiling are coming on top of concerns that the slowing economy may already be heading for a recession. A preliminary report released Tuesday morning suggested the economy remains split, with manufacturing remaining under pressure while growth for travel and other service businesses is strengthen-

"The US economic expansion gathered further momentum in May, but an increasing dichotomy is evident," said Chris Williamson, chief business economist at S&P Global Market Intelligence.

On Wall Street, electric vehicle maker Lordstown Motors fell 5.9% to 28 cents after it announced a reverse stock split in order to boost its share price. Investors will get one new share for every 15 they currently hold. Its stock has remained below \$1 since mid-March.

On the winning side of Wall Street was Lowe's, which rose 1.7% after reporting stronger profit and revenue for the latest quarter than analysts expected. But it also cut its financial forecasts for the year partly because of lower-than-expected sales to do-it-

Retailers are among the last companies to report their results for the first three months of the year, and most companies have been beating expectations. Retailers in particular have gotten lots of attention because resilient spending by U.S. households has been one of the main positives keeping the

economy out of a recession. Manufacturing and other areas of the economy are struggling under the weight of much higher interest rates meant to get inflation under

High interest rates have also meant stress for the U.S. banking system. Three high-profile bank failures since March have rattled the system, and Wall Street has been on the hunt for the next bank that could suffer a debilitating drop in confidence by its

customers. Some of the heaviest scrutiny has been on PacWest Bancorp, but it's rallying for a second day after announcing the sale of a \$2.6 billion portfolio of realestate construction loans. It's up another

13.4% after jumping 19.5% Monday. Other banks also rallied, including a 5.7% jump for Zions Bancorp. and a

4.9% climb for Comerica. Also helping to limit losses for Wall Street were energy stocks, which climbed with the price of crude oil. Exxon Mobil gained 2.7%, and Chevron rose 3.2%. In the bond market, the 10-year Treasury yield ticked up to 3.73% from 3.72% late Monday. It helps set rates for mortgages and other important loans.

The two-year yield, which moves more on expectations for the Fed, rose to 4.37% from 4.32%.

Most stock markets abroad fell, including a 1.3% drop for Hong Kong and a 1.5% slide for Shanghai.

Asian stock markets were mixed Tuesday after more talks in Washington on government debt ended with no deal to avoid a potentially jarring default.

Shanghai, Tokyo and Hong Kong sank. Oil prices rose.

The Shanghai Composite Index lost 1.4% to 3,251.72 and the Nikkei 225 in Tokyo shed 0.4% to 30,957.77. The Hang Seng in Hong Kong retreated 1.3% to 19,419.55. The Kospi in Seoul advanced 0.4%

to 2,567.55 and Sydney's S&P-ASX 200 was less than 0.1% lower at 61,963.68. India's Sensex opened up 0.4% at 62,207.50. New Zealand and Bangkok declined while Singapore and Jakarta advanced.

Worries about a potential U.S. debt default have added to investor unease about the health of the global economy following interest rate hikes to cool inflation and high-profile bank failures in the United States and Switzerland.

In energy markets, benchmark U.S. crude gained 11 cents to \$72.16 per barrel in electronic trading on the New York Mercantile Exchange. The contract rose 44 cents on Monday to \$71.99. Brent crude, the price basis for international oil trading, advanced 8 cents to \$76.07 per barrel in London. It added 41 cents the previous session to \$75.99.

Car seats and baby formula are regulated. Is social media next?

WASHINGTON, May 23, (AP): The U.S. Surgeon General is warning there is not enough evidence to show that social media is safe for children and teens - and is calling on tech companies, parents and caregivers to take "immediate action to protect kids

With young people's social media use "near universal" but its true impact on mental health not fully understood, Dr. Vivek Murthy is asking tech companies to share data and increase transparency with researchers and the public and prioritize users' health and safety when designing

their products. "I recognize technology companies have taken steps to try to make their platforms healthier and safer, but it's simply not enough," Murthy told The Associated Press in an interview. "You can just look at the age requirements, where platforms have said 13 is the age at which people can start using their platforms. Yet 40% of kids eight through 12 are on social media. How does that happen if you're actually enforcing your policies?"

To comply with federal regulation, social media companies already ban kids under 13 from signing up to their platforms - but children have been shown to easily get around the bans, both with and without their parents

Other measures social platforms have taken to address concerns about children's mental health are also easily circumvented. For instance, TikTok recently introduced a default 60-minute time limit for users under 18. But once the limit is reached, minors can simply enter a passcode to keep watching. It's not that the companies are unaware of the harms their platforms are causing.

WASHINGTON, May 23, (AP): If the fight with Congress over raising the government's debt limit is such a dire threat, why doesn't President Joe Biden just raise the borrowing ceiling himself? It's theoretically possible, but he's all but ruled it out

The administration has been searching for possible ways to allow the U.S. to keep borrowing if Congress can't come to an agreement. One potential option Biden and his advisers have been looking at: Would he have the power to go around lawmakers by relying on the Constitution's 14th Amendment in a last-ditch move to

Maybe. But the main problem now, as Biden sees it, is the short time frame from now until the U.S. could default on its debts. It is almost certain to get tangled up in the courts, which would likely push the country beyond June 1, which is when the Treasury Department says the U.S. could be unable to pay its bills.
"We have not come up with a uni-

lateral action that could succeed in a matter of two weeks or three weeks," Biden told reporters during a news conference in Hiroshima, Japan, on Sunday as he concluded the Group of Seven summit. "That's the issue."

Biden has viewed the 14th Amendment route as a problematic, untested

legal theory to ensure the country can meet its financial obligations. Treasury says if Congress fails to act before the June 1 date, it could kick the country into a painful recession.

Why Biden is wary of using the 14th Amendment to address the debt limit crisis

Still, with the White House and Republican legislators at loggerheads over whether Congress should simply allow the government to incur more debt so the country can pay its bills as Biden wants - or insist on pairing it with deep spending cuts, as demanded by the GOP, it's no surprise that the president might be looking at emergency alternatives.

Biden over the weekend signaled the 14th Amendment option isn't completely off the table for the future.

"It's up to lawmakers," Biden said in Hiroshima. "But my hope and intention is: When we resolve this problem, I'd find a rationale to take it to the courts to see whether or not the 14th Amendment is, in fact, something that would be able to stop it.' WHAT DOES THE 14th AMEND-

MENT SAY?

The amendment, ratified in the aftermath of the Civil War, is better known for its provisions addressing citizenship and equal protection under the law. It has been used by the Supreme Court to mandate racial integration in schools in Brown v. Board of Education and same-sex marriage recognition in Obergefell v. Hodges.


The activists, including members of Greenpeace and Extinction Rebellion, say Shell and other fossil fuel firms are making record profits at the cost of the

Shell reported a record \$39.9 billion profit for 2022. Fossil fuel companies have posted bumper earnings as global oil and natural gas prices soared after Russia's invasion of Ukraine, driving up inflation and helping create a cost-of-living crisis.

That sparked public anger in the U.K., where millions of households and businesses have struggled to cope with soaring energy bills.

"Shell is continuing to drill new oil and gas fields here in the U.K. and around the world in some of the most biodiverse regions in the Philippines and in the Niger

Delta," said Carina Manitius, 27, a protester from the group Fossil Free London.

Almost half of consumers in the Mideast prefer chat apps and SMS over email for brand communications

Five users sue state

Montana is banning TikTok, but can it enforce the law and fend off lawsuits?

NEW YORK, May 23, (AP): TikTok is challenging Montana's first-of-its kind law that makes it illegal for people to use the social media app in the state. It's the second lawsuit since the ban was adopted.

Montana Republican Gov. Greg Gianforte signed the law Wednesday expecting a legal fight. The law, scheduled to take effect Jan. 1, 2024, also faces questions over whether it can be

Five TikTok users sued the state last week saying the law is unconstitutional. TikTok made similar arguments in its lawsuit Monday in federal court in Missoula.

Montana's rules are more farreaching than restrictions on TikTok in place elsewhere, which include bans on government-issued devices in nearly half the states and within the U.S. federal government.

There are 200,000 TikTok users in Montana and 6,000 businesses that use the video-sharing platform, according to company spokesperson Jamal Brown.

Here's what you need to know: Why is Montana banning TikTok?

Proponents of the law in Montana claim the Chinese government could harvest U.S. user data from TikTok and use the platform to push pro-Beiiing misinformation or messages to the

That mirrors arguments made by a bipartisan group of lawmakers in the U.S. Senate, as well as the heads of the FBI and the CIA, all of whom have said TikTok could pose a national security threat because its Beijing-based parent company ByteDance operates under Chinese law.

Critics have pointed to China's 2017 national intelligence law that compels companies to cooperate with the country's governments for state intelligence work. Another Chinese law, imple-

mented in 2014, has similar mandates. TikTok says it has never been asked to hand over its data, and it wouldn't

do so if asked. What does TikTok argue in the

legal challenge?
The lawsuit filed Monday by Tik-Tok, which is owned by Chinese tech company ByteDance, says the new law violates the Constitution's right to free speech. It says the law is based on unfounded speculation that the Chinese government could access users' data.

"The state cites nothing to support these allegations," the company's attorneys wrote. "The state's bare speculation ignores the reality that (TikTok) has not shared, and would not share, U.S. user date with the Chinese gov-

Emily Flower, spokesperson for the Montana Department of Justice, said the legal challenges were expected. She said the Chinese Communist Party was using TikTok as a tool to spy on Americans by "collecting personal information, keystrokes, and even the locations of its users.

The case could serve as a testing ground for the TikTok-free America many national lawmakers have envi-

How does Montana plan to ban TikTok?

The law will prohibit downloads of TikTok in the state and fine any "entity" - an app store or TikTok - \$10,000 per day for each time someone accesses, downloads or is offered the ability to access TikTok.

That means Apple and Google, which operate app stores on Apple and Android devices, would be liable for violations. Penalties would not apply to users.

The statewide ban would be void if the social media platform is sold to a company that is not based in a country designated as a foreign adversary.

Montana Attorney General Austin Knudsen has pointed to technology used to restrict online sports gambling apps as a way to curtail TikTok from operating in the state. Those violations can be reported by anyone. And once the state verifies a breach has taken place, it sends a cease-and-desist letter to the company involved, said Kyler Nerison, a spokesperson for Knudsen's office

So, could the TikTok ban work?

Cybersecurity experts say that, other than avoiding the fine, there's nothing incentivizing the companies involved to comply and it will be extremely difficult - if not impossible - to adequately enforce the law.

The U.S. doesn't have anything equivalent to the type of control countries like China have on what their citizens access on the web. Compounding that, internet service providers are out of the picture. Before the Montana law passed

lawmakers rewrote portions of the bill to let them off the hook after a lobbyist for AT&T said during a February hearing the legislation was "not workable" to put into effect.

Could tech companies block it?

A representative for TechNet, the trade group that counts the two tech giants as its members, said app stores don't have the ability to "geofence" apps in different states and it would be impossible to prevent TikTok from being downloaded in Montana. The group has said the responsibility should be on an app to determine where it can operate, not an app store.

Telecoms analyst Roger Entner, of Recon Analytics, says he believes the app stores could have the capability to enforce the law, but it would be cumbersome to implement and full of loopholes. Apple and Google's addresslinked billing could be bypassed with prepaid cards and IP geolocation easily masked by using a VPN service, which can alter IP addresses and allows users to evade content restrictions, said mobile security expert Will Strafach, the founder of Guardian, which makes a privacy protection app for Apple de-

Oded Vanunu, head of products vulnerability research at the cybersecurity firm Check Point, agreed it would be difficult for app stores to isolate a single state from downloading an app. He suggested it would be more feasible for TikTok to comply since it controls the software and can "adjust the settings based on the geographical location or IP addresses" of users

Could TikTok block itself?

When users allow TikTok to collect their location information, it can track a person to at least 3 square kilometers (1.16 square miles) from their actual location. If that feature is disabled, TikTok can still collect approximate location information - such as the region, city or zip code in which a user may be located - based on device or network information, like an IP ad-

Florida sued over law blocking Chinese citizens, others from buying property

TALLAHASSEE, Fla., May 23, (AP): A group of Chinese citizens living and working in Florida sued the state Monday over a new law that bans Chinese nationals from purchasing property in large swaths of the state.

The law applies to properties within 10 miles (16 kilometers) of military installations and other "critical infrastructure" and also affects citizens of Cuba, Venezuela, Syria, Iran, Russia, and North Korea. But Chinese citizens and those selling property to them face the harshest penalties. The prohibition also applies to agricultural land.

The American Civil Liberties Union says the law will have a substantial chilling effect on sales to Chinese and Asian people who can legally buy property. The suit says the law unfairly equates Chinese people with the actions of their government and there is no evidence of national security risk from Chinese citizens buying Florida property.

The law "will codify and expand housing discrimination against people of Asian descent in violation of the Constitution and the Fair Housing Act," the ACLU said in a news release announcing the suit. "It will also cast an undue burden of suspicion on anyone seeking to buy property whose name sounds remotely Asian, Russian, Iranian, Cuban, Venezuelan, or Syrian."

U.S.-China ties are strained amid growing tensions over security and trade. In nearly a dozen statehouses and Congress, a decades-old worry about foreign land ownership has spiked since a Chinese spy balloon traversed the skies from

Alaska to South Carolina last month. Republican Gov. https://apnews com/hub/ron-desantis, who is expected to launch a presidential campaign this week, signed the bill May 8. His of-

fice didn't immediately respond to an email seeking comment. The law is set to take affect July 1.

It will be a felony for Chinese people to buy property in restricted areas or for any person or real estate company to knowingly sell to restricted people. For the other targeted nations, the penalty is a misdemeanor for buyers and sellers.

It applies to military instillations as well as infrastructure like airports and seaports, water and wastewater treatment plants, natural gas and oil processing facilities, power plants, spaceports, and telecommunications central switching offices.

Lebanese prosecutor summons central bank chief following Interpol warrant

prosecutor Lebanon's public Monday summoned the country's embattled central bank governor for questioning following an international arrest warrant issued against him in France over corruption charges, judicial officials

Riad Salameh is to answer the summons later this week, although no specific date was given. France, Germany and Luxembourg are investigating Salameh and his associates over myriad alleged financial crimes, including illicit enrichment and laundering of \$330 million. A French investigative judge on May 16 issued an international arrest warrant, or Interpol red notice, for the 72-yearold Salameh after he failed to

show up in Paris for questioning. Officials in Beirut said that Public Prosecutor Ghassan Oueidat will formally ask France to hand over the governor's case files to decide on future measures against Salameh.

Asked whether it is possible to hand the former governor over to France, the officials - who spoke on condition of anonymity - said Lebanon does not hand its citizens to foreign countries and the case will be overseen in Lebanon. They added that once Queidat receives the case files from France. he will decide whether Salameh should face justice in Lebanon or

elsewhere

In 2020, the Lebanese prosecution received two Interpol red notices for tycoon Carlos Ghosn, who faced financial misconduct charges in Japan. Ghosn remains in Lebanon.

Salameh has repeatedly denied all corruption allegations, saying he made his wealth from his years working as an investment banker at Merrill Lynch, inherited properties, and investments. (AP)

Al changing how Americans find jobs, get promoted, succeed at work

Whether we realize it or not, advancements in artificial intelligence are increasingly influencing the paths of our careers.

Advancements in human capital management systems, more strategic and datadriven human resource and talent management practices, and increased attention to bias are all factors that are changing how people are hired, developed, promoted

I teach and work in talent management and leadership development. I've used these programs and practices in the real world and continue to learn and research how these practices are changing. Artificial intelligence and systems are already big business, grossing over US\$38 billion in 2021. Without a doubt, AI-driven software has the potential to advance quickly and change how companies make strategic decisions about their employees.

Here's what that acceleration may mean to you.

Imagine you apply for a job in the very near future. You upload your carefully written résumé through the company website, noting that the platform looks eerily similar to other platforms you've used to apply for other jobs. After your résumé is saved, you provide demographic information and complete countless fields with the same data from your résumé. You then hit "submit" and hope for a follow-up

Your data now lives within this company's human capital management system. Even if they collect them, very few companies are looking at résumés anymore; they're looking at the info you type into those tiny boxes to help make comparisons between you, dozens or hundreds of other applicants, and the job requirements. Even if your résumé demonstrates that you are the most qualified applicant, it alone is unlikely to catch the eye of the recruiter, because the recruiter's attention is elsewhere

Let's say you get the call, you ace the interview and the job is yours. Your information hits another stage within the company's database, or HCM: active employee. Your performance ratings and other data about your employment will now be tied to your profile, adding more data for the HCM and human resources

Enhancements in AI, technology and HCMs enable HR to look at employee data on deeper levels. The insights gleaned help identify talented employees who could fill key leadership roles when people quit and guide decisions about who should be promoted. The data can also identify favoritism and bias in hiring and

As you continue in your role, data on your performance is tracked and analyzed. This may include your performance ratings, supervisor's feedback, professional development activity - or lack thereof. Having this large amount of data about you and others over time now helps HR think about how employees can better support the growth of the organization.

For example, HR may use data to identify how likely specific employees are to quit and evaluate the impact of that loss.

Platforms that many people already use every day aggregate productivity data from sign-in to signoff. Widely available Microsoft tools including Teams, Outlook and SharePoint can help provide insight to managers via their workplace analytics tool. The Microsoft productivity score tracks overall usage within the platform.

Even the metrics and behaviors defining "good" or "bad" performance may change, relying less on the perception of the manager. As data grows, even the work of professionals like consultants, doctors and marketers will be quantitatively and objectively measured. A 2022 New York Times investigation found that these systems, designed to improve worker productivity and accountability, had the effect of damaging morale and instilling fear.

It's clear that American employees should begin to think about how our data

is being used, what story that data is telling, and how it may dictate our futures. Not every company has an HCM or is advanced in using talent data to make decisions. But many companies are becoming savvier and some are incredibly advanced. At a recent Microsoft Viva summit I attended, chief human resources officers from companies like PayPal and Rio Tinto outlined ways they are using

Some researchers claim that AI could promote equity by removing implicit bias from hiring and promoting, but many more see a danger that AI built by humans will just repackage old issues in a new box. Amazon learned this lesson the hard way back in 2018 when a résumé-sorting AI it built had to be abandoned when it favored men for programming roles.

What's more, the increase of data collection and analysis can leave employees unclear on where they stand while the organization is very clear. It's best if you understand how AI is changing the workplace and demand transparency from your employer. These are data points that employees should consider asking about dur-

Do you see me as a high-potential employee?

• How does my performance compare with others'?

• Do you see me as a successor to your role or others'?

Just as you need to master traditional aspects of workplace culture, politics and relationships, you should learn to navigate these platforms, understand how you are being assessed, and take ownership of your career in a new and more data-

UK economy to avoid recession but inflation still a worry, IMF says

LONDON, May 23, (AP): The British economy will avoid falling into recession this year, according to upgraded growth forecasts Tuesday from the International Monetary Fund.

In its latest assessment of the U.K. economy, the Washington-based fund said domestic demand had proven more resilient than anticipated in the

face of the surge in energy costs. The IMF now thinks the British economy will grow by 0.4% this year, up from its previous prediction of a 0.3% decline. The forecast aligns with that from the Bank of England, which also upgraded its economic outlook this month.

However, the IMF said inflation is likely to remain stubbornly high over the coming years and only return to the Bank of England's target of 2% in mid-2025, six months longer than it

predicted earlier this year.

Like other central banks, the Bank of England has been raising interest rates aggressively over the past 18 months or so after inflation spiked sharply, first because of bottlenecks caused by the coronavirus pandemic and then Russia's invasion of Ukraine, which sent energy and food prices surging.

Figures on Wednesday are expected to show inflation in Britain falling back below 10% for the first time since August, largely because the sharp spike in prices caused by the invasion of Ukraine will fall out of the annual

The IMF also praised the British government for reestablishing credibility following the "stress episode" of last September's big tax cuts of the short-lived government of former Prime Minister Liz Truss.

Define and refine what you want

Kimberly Palmer: How to 'set' and vet money goals midyear

If you set money goals for 2023 back in January, now can be a smart time to check in on your progress. And if you didn't, it's not too late to create goals for the next six months and beyond.

"If you don't have your goals, everyone is so busy with life that a year will whiz by and you'll have forgotten to start," says Dan Casey, owner of Bridgeriver Advisors, a financial firm in Bloomfield Hills, Michigan.

With many people's money goals inflation and economic uncertainty, it's easy to get discouraged if you haven't made as much progress as you'd hoped. Financial experts offer these five strategies for using the midyear point as a way to get back on track, or to embrace a slightly altered course.

Rebecca Eve Selkowe, New York City-based accredited financial counselor and owner of the financial counseling firm RebeccaEve.com, urges people to first define what they want their money to accomplish, noting that those goals can shift over time. That discussion can lead to unexpected discoveries, such as realizing what you actually want is not just to pay off debt but to work fewer hours or change jobs.

"Just articulating the goal with that specificity can be enough to start looking at the numbers more

deeply," she says. **Define the action steps**

Once you've refined or established your goals, Selkowe says, it's time to come up with a specific plan to achieve them. If you know you need a certain down payment to buy the home you want, then you can create a budget and start setting aside money each month in a high-yield online savings account, for example.

Valerie Rivera, certified financial planner and founder of First-Gen Wealth, a virtual financial planning firm in Chicago, suggests setting a timeline, too. "We make a spending worksheet because a lot of people don't know where their money goes. That gives you accountability," she says.

Opening a separate savings account for each specific goal can also help, says Keith Spencer, CFP and owner of Spencer Financial Planning in Spokane, Washington. "Whether it's saving for a home improvement, vacation or wanting to pay off the mortgage sooner, I find it helpful to set up a dedicated account for that so it's more tangible," he says, adding that clients can more easily watch the money saved grow over time and track

In addition to the midyear check-in, Casey suggests making quarterly or even monthly checkins for yourself. "We get overyear, so create micro-timelines instead," he suggests. You could set a mini-goal for what you want to have saved by the end of the month or quarter, for example.

Then, you can make adjustments to catch up to your bigger goal if you fall behind or find you have the flexibility to increase your savings rate. "You can even automate the savings so it's out of sight, out of mind," he adds. Follow up with an account-

ability buddy

Sharing your goals with a friend, coach or financial professional who can help keep you on track can be a natural way to find some extra motivation, Rivera says. "It needs to be someone you would feel a little uncomfortable with if you had to cancel or not give them an update," she says. A partner can also serve as an accountability buddy, especially if you are working on goals together.

Jonathan Kiehl, CFP and founder of Evenkiehl Financial Planning in Lancaster, Pennsylvania, urges clients to make accountability check-ins as enjoyable as possible so it's an activity they look forward to. "That could mean going to a favorite coffee shop or dinner date, as long as it provides an atmosphere where you can review spending plans," he says.

Rivera suggests looking back on how you've gotten closer to achieving your goals while also acknowledging why progress might have been slower than you envisioned. "Maybe there were other obligations or other unexpected things that came up," she says. Higher prices for many consumer goods, including groceries, have strained many people's budgets, making it harder to save, for example.

Tool sparks enthusiasm

ChatGPT flunks American College of Gastroenterology exams: Feinstein

MANHASSET, N.Y., May 23: While the popular artificial intelligence (AI) ChatGPT is seen as a potential educational tool, it won't be getting its medical specialty certification anytime soon. To test its abilities and accuracy, investigators at The Feinstein Institutes for Medical Research asked the consumer-facing ChatGPT (Chat Generative Pre-trained Transformer, OpenAI) to take the 2021 and 2022 multiple-choice self-assessment tests for the American College of Gastroenterology. ChatGPT failed to make the grade, scoring 65.1 percent and 62.4 percent compared to the required 70 percent to pass the exams. Full details of the study were published today in the American Journal of Gastroenterology.

ChatGPT is a 175-billion-parameter natural language processing model that generates humanlike text in response to user prompts. The tool is a large language model (LLM) trained to predict word sequences based on context. ChatGPT has been tested before, even passing the United States Medical Licensing Exam. In this study, the Feinstein Institutes' researchers wanted to challenge ChatGPT's (versions 3 and 4) ability to pass the ACG assessment, which is supposed to gauge how one would fare on the actual American Board of Internal Medicine (ABIM) Gastroenterology board examination.

"Recently, there has been a lot of attention on ChatGPT and the use of AI across various industries. When it comes to medical education, there is a lack of research around this potential groundbreaking tool," said Arvind Trindade, MD, associate professor at the Feinstein Institutes' Institute of Heath System Science and senior author on the paper. "Based on our research, ChatGPT should not be used for medical education in gastroenterology at this time and has a ways to go before it should be implemented into the health care field."

Copied

Each ACG test consists of 300 multiple-choice questions with real-time feedback. Each question and answer was copied and pasted directly into the ChatGPT versions 3 and 4. Overall, ChatGPT answered 455 questions (145 questions were excluded because of an image requirement). Chat GPT-3 answered 296 of 455 questions correctly (65.1 percent) across the two exams, and Chat GPT-4 answered 284 questions correctly (62.4 percent).

"ChatGPT has sparked enthusiasm, but with that enthusiasm comes skepticism around the accuracy and validity of AI's current role in health care and education," Andrew C. Yacht, MD, senior vice president, academic affairs and chief academic officer at Northwell Health. "Dr. Trindade's fascinating study is a reminder that, at least for now, nothing beats hitting time-tested resources like books, journals and traditional studying to pass those all-important medical exams."

ChatGPT does not have any intrinsic understanding of a topic or issue. Potential explanations for ChatGPT's failing grade could be the lack of access to paid subscription medical journals or ChatGPT's sourcing of questionable outdated or non-medical sources, with more research needed before it is used reliably.



Major Cannes draw

Liv Ullmann, major royalty, looks back

CANNES, France, May 23, (AP): Very few are capable of capturing people's attention at the Cannes Film Festival like **Liv Ullmann**.

At 84, Ullmann is unabashed cinema royalty, and directors have flocked to greet her at this year's festival. Pedro Almodóvar sought her out at a luncheon. Todd Haynes endeavored to get word to her that his latest film, "May December," is inspired by "Persona," the 1966 film that began her decade with Ingmar Bergman.

After meeting Ullmann, "The Zone of Interest" director Jonathan Glazer pressed his hand against his chest to catch his breath

Ullmann has been coming to Cannes longer than



she can remember. She's pretty sure there's a hotel suite somewhere named after her. But after being here in just about every capacity with "Cries and Whispers' in 1973, her own "Faithless" in 2000, president of the jury in 2001 - she was in Cannes for a different reason. Dheeraj Akolkar's documentary series, "Liv Ullmann: A Road Less Travelled," played in the Cannes Classics section.

"I've never been here when someone else has made a movie about me or my life," says Ullmann. "That makes it so different and maybe a little shameful, somehow. Because I'm an actress and a direc-

In an interview, the Norwegian actor, who lives in Boston, reflected on the passing of time and her halcyon decade with Bergman, one of cinema's great collaborations. Ullmann starred in 10 of Bergman's films, including "Scenes From a Marriage" and "Saraband," and she directed two of his screenplays. "A Road Less Travelled" streams on Viaplay beginning June 22nd.

AP: Having been such a central part of arthouse heyday when filmmakers like Bergman, Godard and Truffaut were such a part of culture, do you ever lament that today's most daring movies seem to reside less in the spotlight?

Ullmann: They make incredible movies now. You know, I saw Cate Blanchett last year. What an actress. Art, it's made today. But so many other films are also reflection of this time. And I mean, everything that won Oscars this year, I didn't even understand them all. It doesn't mean that there's something wrong with them or there's anything

I sometimes miss that there aren't more of the movies we used to call classical. That's about aging, too, maybe. What I'm most nervous for is that all these serials that are everywhere is removing us so far from what film really was. The art of the lighting, the art of the cinematographer, the art of the director - that kind of language. I like where I came from.

AP: How clearly do you remember meeting Berg-

Ullmann: Bibi Andersson, who was my best friend and we had done some movies together, I visited her in Sweden. We were walking on the street, and that's where Ingmar came and spoke with her. He knew who I was because I had filmed a lot. He said, "Oh, well, I'd like you to be in one of my films." And so maybe that's why I also experienced everything (in film) more personally because it happened like that, Ingmar and me.

AP: He was immediately struck by you in that meeting, but what was your first impression of

Ullmann: Oh, I was so impressed. I'm shy and then I was really shy. I never spoke. When he said he wanted me in one of his movies, I was shocked. Luckily, I didn't have any lines in the movie. It's strange he did that with me because I was 25. I was young. I see the movie as about him having reached middle age and wanting to stop life and go into himself. Then he picked me. I was him. And I think I was him in many of the movies. We were not alike each other but in certain ways we were. There is a reason he then used me continually until he died.

AP: How would you describe how deep your connection was?

Ullmann: He said that. You and I are painfully connected. We lived together for five years but maybe the most wonderful connection was when we lived separately. We became more connected that way. I came to Fårö (the island he lived on) the night he died and he was already on his way.

AP: Did you share any words on his death bed? **Ullmann:** He was already on his way. One thing I did say. The last film we did together was "Saraband." That's about a woman who comes to her husband many years after it's over. And he asks her, "Why did you come to me?" She says, "You called for me." When I was sitting there on the bed, I said, "If you're wondering why I'm here, you called for me." He may have heard that, I don't know.

AP: You've often been described as his "muse" but that doesn't seem the right word for your collaboration.

Ullmann: I don't think I was a muse but you can say that. I did a lot of things that he wanted to do that he didn't do. I traveled. I went into the world. I became famous. The strange thing with all these actors who he loved dearly, he didn't like them to go. Bibi Andersson and Max von Sydow. But he thought it was fun with me. I don't know why. When I did "A Doll's House," he came to New York. He hated to travel. He enjoyed what I did. There was so much I got to do because I wasn't him, and maybe he would have loved to do. All his seriousness, of course that

AP: You consider yourself at heart a theater actor, but what was your relationship to the camera? In the documentary, Blanchett says you were "looking up at the world sort of with a face of unconditional

Ullmann: If you're really close to somebody you love, when you look at each other, you know everything about each other. I see the camera that way. I don't have to be shy. You are an actor from the inside. Your soul, your your heart can come out if you want to show the camera the real truth. It tells what is under there. It's nothing you can act or do Stanislavski about. It's not your brain. Your brain is not the actor. It's from here (points to heart). If you relax your body, the camera will take it.

LOS ANGELES: Ray Stevenson, who played the villainous British governor in "RRR," an Asgardian warrior in the "Thor" films, and a member of the 13th Legion in HBO's "Rome," has died. He

Representatives for Stevenson told The Associated Press that he died Sunday but had no other details to share on Monday.

Stevenson was born in Lisburn, Northern Ireland, in 1964. After attending the Bristol Old Vic Theatre School and years of working in British television, he made his film debut in Paul Greengrass's 1998 film "The Theory of Flight." In 2004, he appeared in Antoine Fuqua's "King Arthur" as a knight of the round table and several years later played the lead in the pre-Disney Marvel adaptation "Punisher: War Zone."

Though "Punisher" was not the bestreviewed film, he'd get another taste of Marvel in the first three "Thor" films, in which he played Volstagg. Other prominent film roles included the "Divergent" trilogy, "G.I. Joe: Retaliation" and "The Transporter: Refueled.'

A looming presence at 6-foot-4, Stevenson, who played his share of soldiers past and present, once said in an interview, "I guess I'm an old warrior at heart."

On the small screen, he was the roguish Titus Pullo in "Rome," a role that really got his career going in the United States and got him a SAG card, at the age of 44. The popular series ran from 2005 to 2007.

'That was one of the major years of my life," Stevenson said in an interview. "It made me sit down in my own skin and say, just do the job. The job's

'Brokeback Mountain' draws mixed reviews

Play brings rising US stars to London stage

LONDON, May 23, (AP): "Brokeback Mountain" was a star-making story onscreen. It may turn out to be the same onstage.

Rising American stars Lucas Hedges and Mike Faist are making their London theater debuts in an adaptation of Annie Proulx's short story about two star-crossed Wyoming shepherds whose love is stifled by the strictures of their society.

Proulx's tale of homophobia on the range, first published in 1997, reached a huge global audience through Ang Lee's Academy Awardwinning 2005 film, which cemented the stardom of Jake Gyllenhaal and the late Heath Ledger.

A new stage version at London's Soho Place theater, stars Hedges as taciturn ranch hand Ennis Del Mar and Faist as livewire cowboy Jack Twist, who fall passionately in love during a 1960s summer on an isolated mountainside.

Both are already acclaimed young actors. Hedges got an Oscar nomination for playing a bereaved teenager in 2016 drama "Manchester by the Sea," and Faist is a Tony Award nominee for "Dear Evan Hansen" and made a splash as gang leader Riff in Steven Spielberg's "West Side Story."

Still, Hedges admitted he was "pretty nervous" before opening night.

"It's constantly a process of feeling like I've discovered the character and then losing the character and then finding it again," Hedges told the Associated Press.

"We're always nervous," added Faist. But he said the actors trusted that director Jonathan Butterell had cast them for a reason.

"It's because he sees those qualities in us," he said. "I think all of us in general have both of them. We're all Ennises and we're all Jacks, in our way. So the duality exists within all of us and part of our job is to just find those parts and bring them to the surface and make them the most accessible as possible."

Ashley Robinson's script aims to match the gut-wrenching economy of Proulx's 35-page story. It covers two decades in 90 minutes, as the pair struggle to convert their passion into something sustainable and sus-

Hedges said the director had compared the show to the last production to run at Soho Place, Euripides' Greek tragedy "Medea."

"Of course it's not ancient Greek theater, but there's something deeply fundamental about it, about these two characters, about the way in which they need each other and can't ultimately be together," Hedges said. "There is something classic about the dynamic, and the stakes.'

The actors are accompanied onstage by a live band that includes Scottish singer Eddi Reader and legendary British pedal steel player B.J. Cole. But don't call it a musical - this version of Wyoming is a long way from "Oklahoma!"

Characters

"These characters bursting into song would make no sense at all," said Dan Gillespie Sells, who composed the show's plaintive, country-tinged songs. "These characters don't have an inner dialogue.

"They can't express themselves, and they can't express themselves to themselves.'

Instead, "a pedal steel guitar and a harmonica - those things can deliver you into landscape" both interior and exterior, said Sells, whose theater work includes songs for the musical "Everybody's Talking About Jamie."

"Brokeback Mountain," which runs until Aug. 12, has drawn mixed reviews. The Guardian thought the play had a "distilled purity," but the Times of London said the production "smolders fitfully" rather than catching fire. But there has been wide praise for the two leads, as well as for British actor Emily Fairn, making her professional stage debut as Ennis's disappointed wife, Alma.

What's undeniable is the power of the "Brokeback Mountain" story, which also was adapted into an opera, first staged in 2014, with music by Charles Wuorinen and libretto by Proulx. Some see it as a classic love story - but director Butterell thinks that is a misunderstanding.
"It's not a love story," he said.

"It's a story about fear. It's a tragedy, because fear wins out.

This story is still very, very, very relevant," he added. "We have not shifted so far."

NEW YORK: Jeremy Strong is going from a corporate boardroom on TV to a whistleblower on Broadway.

The actor who plays **Kendall Roy** in the HBO television series "Succession" has signed on to play a man who tries to expose water contamination in a Norwegian spa town in Henrik Ibsen's 1882 play "An Enemy of the People."

The play — with a rewrite from **Amy Herzog**, whose adaptation of Ibsen's "A Doll's House" just won a Tony nomination — will premiere on Broadway in early 2024 at a theater to be revealed later, producers said. It will be Strong's second time on Broadway. He was in "A Man for All Seasons" in 2008 with Frank Langella and Patrick Page. Since then, his work on "Succession" has earned him an Emmy and a Golden Globe.

'Early warnings help'

2m killed, \$4.3trl losses from 'extreme weather'


GENEVA, May 23, (AP): The economic damage of weatherand climate-related disasters continues to rise, even as improvements in early warning have helped reduce the human toll, the UN weather agency said Monday.

The World Meteorological Organization, in an updated report, tallied nearly 12,000 extreme weather, climate and waterrelated events over the past half-century around the globe that have killed more than 2 million people and caused economic damage of \$4.3 trillion.

The stark recap from WMO came as it opened its four-yearly congress among member countries, pressing the message that more needs to be done to improve alert systems for ex-

treme weather events by a target date of 2027. "Economic losses have soared. But improved early warnings and coordinated disaster management has slashed the hu-

man casualty toll over the past half a century" WMO said in a statement. The trend of rising economic damage is expected to continue.



WMO says early warning systems have helped reduce deaths linked to climate and other weather-related catastrophes.

Most of the economic damage between 1970 and 2021 came in the United States - totaling \$1.7 trillion - while nine in 10 deaths worldwide took place in developing countries. The economic impact, relative to gross domestic product, has been felt more in developing countries,

WMO Secretary-General Petteri Taalas said the cyclonic storm Mocha that swept across Myanmar and Bangladesh this month exemplified how the "most vulnerable communities unfortunately bear the brunt of weather, climate and waterrelated hazards.

Disaster

"In the past, both Myanmar and Bangladesh suffered death tolls of tens and even hundreds of thousands of people," he said, alluding to previous catastrophes. "Thanks to early warnings and disaster management these catastrophic mortality rates are now thankfully history.

"Early warnings save lives," he said.

The findings were a part of an update to WMO's Atlas of Mortality and Economic Losses from Weather, Climate and Water Extremes, which previously had covered a nearly 50year period through 2019.

WMO acknowledges some caveats to its report: While the number of disasters has risen, some of that may be due to improvements in reporting about extreme weather events that might have been overlooked in the past.

While the findings account for inflation, WMO cautioned that estimating the economic toll can be an inexact science, and the reports could understate the actual damage

Worldwide, tropical cyclones were the primary cause of reported human and economic losses.

In Africa, WMO counted more than 1,800 disasters and 733,585 deaths related to weather, climate and water extremes - including flooding and storm surges. The costliest was Tropical Cyclone Idai in 2019, which ran to \$2.1 billion in damages. Nearly 1,500 disasters hit the southwest Pacific, causing 66,951 deaths and \$185.8 billion in economic losses.

Asia faced over 3,600 disasters, costing 984,263 lives and \$1.4 trillion in economic losses - that cost mostly due to the impact of cyclones. South America had 943 disasters that resulted in 58,484 deaths and over \$115 billion in economic

Over 2,100 disasters in North America, Central America and the Caribbean led to 77,454 deaths and \$2 trillion in eco-

Europe saw nearly 1.800 disasters that led to 166.492 deaths and \$562 billion in economic losses.

Last week, WMO forecast a 66% chance that within the next five years the Earth will face a year that averages 1.5 degrees Celsius (2.7 degrees Fahrenheit) warmer than in the mid-19th century, reaching a key threshold targeted by the Paris climate

Heat wave: Swathes of **India** from the northwest to the southeast braced for more scorching heat Monday, with New Delhi under a severe weather alert, as extreme temperatures strike parts of the country.

The Indian Meteorological Department issued a heat wave alert for seven southern and central states last week and broadened it to the capital and some northern states on Monday as sizzling temperatures breached normal levels.

It warned that blistering heat will continue for the next few days before rains bring some relief. The southwest monsoon is slightly delayed this year and will hit in the first week of June, causing temperatures to stay high longer than usual, it said.

As temperatures crossed 45 degrees Celsius (113 degrees Fahrenheit) in the northern state of **Uttar Pradesh**, some parts suffered blackouts lasting more than 12 hours despite a March order for all power plants in the country run at full capacity to reduce power cuts. The heat wave in the state is likely to continue for two more days, a weather official said.

Hundreds of frustrated residents protested outside power stations near the state capital, Lucknow, and blocked roads over the weekend.

"Power cuts mean no ACs, no fans, and even no water. The scorching heat has made our lives unbearable and the lack of power is adding to our misery," said Ramesh Gupta, a Lucknow resident. He said his wife was forced to sleep in the car over the weekend with the air conditioning on high so their 9-month-old baby would stop crying.

The searing heat forced many residents of the city to seek refuge indoors. "We have become prisoners to the relentless summer as no one wants to venture out," said Sudhir Sehgal,

Sukhai Ram, a gardener who is paid only when he works, was forced to set down his tools. "I cannot work anymore now. I will work once the sun goes down," he said, drenched

Temperatures

Dairy workers wrapped their cans with jute to keep the milk from spoiling. Construction workers hosed themselves down for a temporary respite from the soaring heat. Nighttime temperatures are also rising, sparking increased

demand for electricity to run air conditioners and fans. The main summer months - April, May and June - are al-

ways hot in most parts of India before monsoon rains bring cooler temperatures. But temperatures have become more intense in the past decade. During heat waves, the country usually also suffers severe water shortages, with tens of millions of its 1.4 billion people lacking running water.

A study by World Weather Attribution, an academic group that examines the source of extreme heat, found that a searing heat wave in April that struck parts of South Asia was made at least 30 times more likely by climate change.

The heat caused 13 people to die at a government event last month in India's financial capital of Mumbai, and prompted some states to close all schools for a week.

Scientists say temperatures are at least 2 degrees C (3.6 degrees F) hotter in South Asia than in pre-industrial times because of climate change. Currently, the world is averaging about 1.1 to 1.2 C (2 to 2.2 F) warmer.

"Access to healthcare and to cooling solutions like fans and air conditioners is missing for a lot of the population in this region," said Emmanuel Raju, director of the Copenhagen Centre for Disaster Research at the University of Copenhagen.

Popocatepetl spewing ash: Mexico's Popocatepetl volcano spewed gas, smoke and ash Monday, leading education authorities to suspend in-person classes in parts of three states, a day after the government raised the warning level on the vol-

cano's activity. In this phase, large domes develop and explode in increasing intensity, launching incandescent rock into the air and pyroclastic flows down its flanks.

Velázquez said only three of the volcano's 565 explosions since September had been big, and the current activity was not the greatest of this century. (AP)

New brain stimulation therapy to treat disorder

Brain signals can measure chronic pain

Using a brain implant that can record neural signals over many months, my research team and I have discovered objective biomarkers of chronic pain severity in four patients with chronic pain as they went about their daily lives.

Pain is one of the most important and basic subjective experiences a person can have. While there is plenty of evidence that perception of pain takes place in the brain, there is also a major knowledge gap regarding where and how pain signals are processed in the brain. Even though pain is universal, there has not been a way to objectively measure its intensity.

Most prior studies on the brain signais responsible for pain have relied on laboratory experiments in artificial environments. Until now, most research on chronic pain has used indirect measures of brain activity such as functional magnetic resonance imaging or electroencephalography. Furthermore, although doctors widely recognize that chronic pain is not just an extension of acute pain - like stubbing your toe - it remains unknown how the brain circuits behind acute and chronic pain relate to each

Our study was part of a larger clinical trial aimed at developing a new brain stimulation therapy to treat severe chronic pain. My team surgically implanted electrodes in the brains of four patients with post-stroke pain and phantom limb pain to record neural signals in their orbitofrontal cortex, an area of the brain associated with planning and expectation, and cingulate cortex, an area associated with emo-

We asked the patients about their pain severity levels several times a day for up to six months. We then built machine learning models to try to match and predict each patient's self-reported pain intensity scores with snapshots of their brain activity signals. These brain signals consisted of electrical waves that could be decomposed into different frequencies, similar to how a musical chord can be broken down into

Reading aloud can make the text easier to understand when you're a beginning reader or when you are reading something that's challenging. Listening to yourself as you read helps with com-After that, you might "mumble read."

move your lips as you read. But this practice slowly fades as your reading skills develop, and you start to read silently "in your head." That's when your inner voice comes into play. As experts in reading and language, we see this transition from reading out

mal part of the development of reading skills. Usually, kids are good at reading silently by the fourth or fifth grade. The shift from reading out loud to reading silently is very similar to how

Young children often speak to themselves as a way to think through challenges. Lev Vygotsky, a Russian psychologist, called this "private speech." And kids aren't the only ones who talk to themselves. Just watch an adult try to put together a new vacuum cleaner. As kids become better thinkers, they shift to talking inside their heads instead of out loud. This is called "inner speech.

Once you're a good reader, it's a lot easier to read silently. Reading becomes faster because you don't have to say each word. And you can jump back to reread parts without disrupting the flow of reading. You can even skip over short familiar words. Silent reading is more flexible, and

it allows you to focus on what's most important. And it's during silent reading that you may discover your inner

Hearing an inner voice while reading is relatively common. In fact, one study found that 4 in 5 people say they often or always hear an inner voice when they read silently to themselves. (AP)

individual sounds of different pitches. From these models, we found that low frequencies in the orbitofrontal cortex corresponded with each of the patients' subjective pain intensities, providing an objective measure of chronic pain. The larger the shift in low-frequency activity we measured, the more likely the patient was experiencing intense pain.

Next, we wanted to compare the relationship between chronic pain and acute pain. We examined how the brain responded to short-term, intense pain caused by applying heat to the patients' bodies. Based on data from two participants, we found that the anterior cingulate cortex was more involved in processing acute pain than chronic pain. This experiment provides the first direct evidence that chronic pain involves information-processing areas of brain distinct from those involved in acute pain.

Chronic pain, defined as pain lasting more than three months, affects up to 1 in 5 people in the US. In 2019, the incidence of chronic pain was more common than that of diabetes, high blood pressure or depression.

Neuropathic pain resulting from damage to the nervous system, such as stroke and phantom limb pain, often doesn't respond to available treatments and can significantly impair physical and emotional function and quality of life. Better understanding how to measure brain activity to track pain could improve the diagnosis of chronic pain conditions and help develop new treatments such as deep brain stimula-

Although our study provides a proof of concept that signals from specific brain regions can serve as an objective measure of chronic pain, it is more likely that pain signals are distributed over a wide brain network. (AP)

This year, more than 100 pine snakes — a species the federal government lists as threatened will be released into the central Louisiana

"We provide the snakes in our snake factories, which are funded by the US Forest Service, into habitat that the Fish and Wildlife Service and Forest Service have developed," said Steve Reichling, the Memphis Zoo's Director of Conservation and Research. "It's just a perfect marriage,

Reichling said the characteristics of the area where the snakes were released - a high tree canopy dominated by longleaf pine, little mid-level vegetation, grassy ground and sandy soil — are all vital to the snakes' survival. The forest is also home to gophers that are both a food source for the snakes and the creators of the burrow system where the snakes live and hibernate.

"Unlike some of the other snakes that are here that can survive in different habitats, Louisiana pines, they cannot," Reichling said as the snakes were being released. Although they bear a resemblance to rattlesnakes, pine snakes are non-venomous constrictors and aren't considered dangerous to humans. (AP)

Valencia ban a fan for life

7 people arrested in Spain linked to racial abuse cases against Júnior

MADRID, May 23, (AP): Seven people accused of racially abusing Real Madrid player Vinícius Júnior have been arrested in Spain, police said Tuesday

Three were detained in Valencia for alleged abuse against Vinícius in a Spanish league match on Sunday. Four were arrested in Madrid for allegedly hanging an

The arrests come after an outpouring of support for Vinícius after he said he was abused in Valencia. The case prompted widespread reaction from sports figures and government officials in Spain and worldwide.

effigy of the player off a highway bridge in January.

The nation has been criticized for its lack of action in racism cases in soccer. Brazilian government officials, including President Luiz Inácio Lula da Silva, had publicly expressed their concerns.

Vinícius, who is Black, has been subjected to repeated racist taunts since he arrived in Spain five years ago, and especially this season after he began celebrating his goals by dancing.

The Brazilian has heavily criticized Spanish soccer for not doing more to stop racism.

The match against Valencia was temporarily stopped after Vinícius said a fan behind one of the goals called him a monkey and made monkey gestures toward him. Vinícius considered leaving the field but eventually continued playing.

The effigy of Vinícius was hanged by the neck on the morning of a derby match between Real Madrid and Atletico Madrid in the Copa del Rey. Along with it was a banner with the words "Madrid hates Real

The perpetrators used a black figure with Vinícius' name on it, tied a rope around its neck and hanged it from an overpass while still dark in the Spanish capital.

Police said three of those arrested belonged to one of Atletico's fan groups, and the other was a follower of the group. Some had prior bookings with police for other crimes.

The hate message on the banner is often used by Atletico's hardcore fans, though at the time they denied being responsible for the display.

The men arrested are between the ages of 19 and 24. Authorities said some were previously identified during matches considered at high risk of violence. Police prepared." showed images of them arriving in handcuffs and escorted by agents on Tuesday.

Spanish media said police had used security cameras to identify the perpetrators but no action had been taken until now. Police did not say if the timing of the arrests had to do with the widespread attention being received by the latest abuse against Vinícius on Sunday.

The lights at the Christ the Redeemer statue in Rio de Janeiro were turned off Monday night in a show of solidarity for Vinícius.

"It's an action of solidarity that is moving," Vinícius said on Twitter. "But more than everything, what I want is to inspire and bring more light to our fight." Vinícius thanked all the support he has received in

the last months in Brazil and abroad. "I know who you are," he said. "Count on me, be-

cause the good ones are the majority and I'm not going to give up. I have a purpose in life, and if I have to keep suffering so that future generations won't have to go through these types of situations, I'm ready and

Valencia banned for life a fan identified of insulting Vinícius during the game. Real Madrid took the case to prosecutors as a hate crime.

The Spanish league has filed nine criminal complaints of cases of racial abuse against Vinícius in the last two seasons, with most of them being shelved by prosecutors. The league said Tuesday it will seek to increase its authority to issue sanctions in cases of hate crimes during games. It had been saying it can only detect and denounce incidents to authorities and the country's soccer federation.

Supporters have been fined and banned from stadiums for their abuse against Vinícius, but so far only a Mallorca fan may end up going on trial for allegedly racially insulting the Brazilian during a game.

The first trial against a fan accused of racial abuse in Spanish professional soccer is expected to happen at some point this year; the case involved Athletic Bilbao forward Iñaki Williams, who was insulted by an Espanyol supporter in a match in 2020.

Windhorst's money dried up during pandemic

Hertha, burned by ambition, must rebuild after relegation

BERLIN, May 23, (AP): Though it had long seemed likely, Hertha Berlin's relegation from the Bundesliga still felt like a blow out of nowhere when it

The "Old Lady" was leading against Bochum deep into injury time on Saturday - in a game it had to win - and hopes of another dramatic escape were rising. Hertha's fans were already celebrating the chance to fight again on the last day of the season.

Then Keven Schlotterbeck - a former Union Berlin player - scored Bochum's equalizer for 1-1. There was no time for a response.

Hertha was relegated after a 10-year

stint in the top division and, all around Olympiastadion, the club's fans stood in stunned silence with their hands on their heads.

Hertha's But downfall arguably started years earlier, when billionaire Lars Windhorst started

Klinsmann backing the team in 2019 and declared it a "big city club" that could challenge the traditional gi-

Windhorst invested 374 million euros (\$405 million) in Hertha, fueling a spending spree and prompting a managerial merry-go-round that started badly when the inexperienced Ante Čović was fired and his replacement, Jurgen Klinsmann, quit after seven games.

Klinsmann had said Hertha was the "most exciting soccer project in Eu-

Coaches came and went, managing directors departed, sporting directors and chief executive officers, too. There were scandals and renewed low points, and Hertha never came close to Windhorst's dream of challenging Europe's

Instead, the team found itself fighting relegation every season, and the "big city club" moniker became a term of derision.

Windhorst's money dried up during the coronavirus pandemic, when restrictions impacted ticket sales, and suddenly Hertha found it needed to cut costs. Å team that was already struggling was progressively weakened. Hertha staved up only after a playoff last year. Then it got rid of more players.

Windhorst sold his stake to American investors 777 Partners in March.

"We weren't relegated today," Hertha coach Pál Dárdai said, referring to

Brady to buy stake in Raiders – owner

HENDERSON, Nev., May 23, (AP): Recently retired and seven-time Super Bowl champion quarterback Tom Brady will become a minority owner of the Las Vegas Raiders, pending NFL approval, principal owner Mark Davis told ESPN on Monday.

"We're excited for Tom to join the Raiders, and it's exciting because he will be just the third player in the history of the National Football League to become an owner," Davis said.

George Halas and Jerry Richardson were the other two.

Brady and Davis also have a business relationship with the WNBA's Las Vegas Aces. Davis is the majority owner, and Brady has a stake in the club.

At least 24 NFL owners will need to approve Brady's deal with the Raiders. He also has a 10-year, \$375 million broadcasting contract with Fox Sports than begins in 2024.

Brady won six Super Bowls with the New England Patriots and one with the Tampa Bay Buccaneers. On the way to his first title, in 2002, Brady beat the

Raiders in an AFC playoff game after having a fumble overturned in the famous "Tuck Rule" game.

Eyes on European prizes

Inter, Fiorentina meet in final

MILAN, May 23, (AP): Both Inter Milan and Fiorentina head into Wednesday's Italian Cup final with their eyes on even bigger prizes this

Inter plays Manchester City in the Champions League final on June 10, three days after Fiorentina takes on another Premier League side in West Ham in the Europa Conference League final.

First they'll have to focus on the match at the Stadio Olimpico in Rome.

Inter is looking to defend the Italian Cup title and maintain its bid for a trio of trophies this season under coach Simone Inzaghi, who has become known as something of a cup specialist.

Inzaghi has won six of seven previous finals as coach. He led Lazio to the Italian Cup in 2019 as well as two Italian Super Cup trophies.

He's also won two Italian Super Cup titles with Inter - including beating city rival AC Milan t his season

- as well as last year's Italian Cup.

Despite Inzaghi's cup success, the 47-year-old has constantly been under pressure this season and had to face questions about his future, with the team perceived to have underperformed in the league.

However, Inter CEO Giuseppe Marotta recently said that Inzaghi would "100%" still be the Nerazzurri coach next season.

"It's great that the club has faith in me," Inzaghi said. "Four games remain, two of which are finals.

"We're on a path of growth; our fifth final in two years is coming up, and these finals are very helpful in terms of helping the team grow even more."

Inter lost 3-1 at Serie A champion Napoli on Sunday to end a run of eight straight wins in all competitions. But it can nevertheless ensure a top-four finish and a spot in next season's Champions League with a draw against Atalanta at the weekend.

Inter's winning run was aided by Romelu Lukaku's return to form. After a season beset by injuries, Lukaku is back to something akin to his best and has netted four goals in his past three league matches.

"Lukaku is feeling really good, and this also applies to all of his teammates," Inzaghi said. "In the last two months, he's returned to being the Romelu that we all know. I'm using him and all our other strikers, who are doing just as well.

"Today was our 15th game in 50 days. I need the whole squad because the fixture list is, quite frankly, incredible, but I've had excellent responses from all the lads."

Lukaku's strike partner, Lautaro Martínez, is the only player to have appeared in all 53 of Inter's match this season. The Argentine World Cup winner has netted 25 goals for the Nerazzurri this campaign, equalling his personal record he set last year

Fiorentina will be especially wary of Martínez as he scored twice against them back in October, in a 4-3 victory for Inter. Fiorentina won 1-0 at San Siro at the start of last month.

While Inter has become used to contesting finals in recent years, Fiorentina has had to wait almost a decade - and now two have come along at once.

The Tuscan team last contested a final when it lost to Napoli in the 2014 Italian Cup.

With little to play for in the league, however, Fiorentina coach Vincenzo Italiano had the luxury of completely revamping his team or Sunday's draw at Torino and giving players some much-needed rest after its extra time victory over Basel midweek.

"We are tired, mental tiredness is also part of tiredness, it's not just hard on the legs but on everything else," Italiano said. "We let players rest that hadn't recovered at all from the 130 minutes because, as I have heard said, on Wednesday we're playing the match of our lives

lives.

"We tried to spare players who weren't even able to get on the train. Now we have three days to prepare this final, and I am convinced we will recover all our energy to face a team that is one of the strongest in Italy and we have to try to put them in difficulty." The last of Fiorentina's six Italian Cup titles came in 2001. Eight-time champion Inter has won five since then.

SUNRISE, Fla., May 23, (AP): The chants of fans in Florida drowned out the public-address announcer at the end of the game Monday night, making it impossible to hear his call of the first star of the game.

Then again, they already knew who it was going to be.

who it was going to be.

Sergei Bobrovsky earned those cries from the 20,000 or so who chanted in unison, after leaving no doubt in Game 3 of the Eastern Conference final - and putting the Panthers are on the brink of their first trip to the Stanley Cup Final in 27 years. Bobrovsky stopped 32 shots for his first playoff shutout, and the Panthers blanked the Carolina Hurricanes 1-0 on Monday night.

ICE HOCKEY

"No matter what the score is, we're just trying to make it as easy as possible for him," said Panthers forward Sam Reinhart, who got the game's lone goal on the power play midway through the second period.

He's rewarded their work, and then some. Bobrovsky is now 10-1 in his last 11 appearances and has been almost perfect in the last eight games. Going back to Game 1 of Round 2 against Toronto, Bobrovsky has not allowed more than two goals in any contest, with 296 saves on 309 shots - a .958 save percentage.

And if that doesn't sound absurd enough, try this one: Out of the last 110 shots he's faced, Bobrovsky has stopped 109 - starting in the third period of the four-OT win in Game 1.

"We're happy with the 'W,' we're happy with the win, but the next game is going to be a big game," Bobrovsky said. It could be Florida's biggest since 1996. That was the last year in which the Panthers played for the Stanley Cup, but they can clinch a trip to the title round with a win in Game 4 on Wednesday.

This marks the 205th time that a team has taken a 3-0 series lead in NHL playoff history. Of the first 204,

200 went on to win the series. The Panthers are 2-0 when taking the first three games of a series; the Hurricanes are 0-5 when dropping the first three.

"We can't do much more," Hurricanes coach Rod Brind'Amour said. "We like how we're playing, clearly. It's just, we've got to find a way to

put one in."

Matthew Tkachuk and Sam Bennett had the assists on Reinhart's goal for Florida. It wasn't a perfect night for Florida, however: Captain Aleksander Barkov left with about 7 minutes left in the first period with a lower-body injury and did not return, even though the team listed him as questionable. Panthers coach Paul Maurice did not have an update on

Barkov's condition after the game. Frederik Andersen stopped 16 shots for Carolina. The Hurricanes pulled him with 3:22 left, desperate for the tying goal, but barely even managed to test Bobrovsky the rest of the way. And when it was over, the Hurricanes' Jesperi Kotkaniemi was seen smashing his stick on the way to the locker room, the frustration so obvious.

That's what a night of facing Bobrovsky does right now.

"He's been incredible, all playoffs long," Bennett said.

The 3-0 lead matches the one that the eighth-seeded Miami Heat have in their Eastern Conference final against the Boston Celtics, with a chance for South Florida's other storybook team right now to clinch an NBA Finals trip and a matchup with the Denver Nuggets on Tuesday night. Monday's contest was the first East final game in the Panthers' current arena - the franchise's only other time going this deep into the playoffs was 1996, when it played in Miami at a building that was demolished long ago.

that was demolished long ago.

It also likely was the first time that they played with the Wanamaker Trophy in attendance. Newly crowned PGA champion Brooks Koepka - a South Florida native and Panthers fan - put on a jersey and brought the big silver cup to the game.

The crowd roared when they saw him displaying the trophy he won Sunday. Of course, there is another silver trophy that Panthers fans would prefer seeing someone in their jersey

30,000 officers per day

Fans will need to pre-register for free tickets to Paris Oly opening ceremony

PARIS, May 23, (AP): To pull off the most audacious opening ceremony in Olympic history, French organizers are now - literally - on the same page

the same page.

France's government, the organizing committee president for the 2024 Paris Games and the French capital's mayor signed an 11-page security protocol Tuesday that for the first time publicly laid out some of the gritty details of their planning to shield the unprecedented July 26 opening ceremony from the threats of terrorism, drone attacks and other risks for the massive crowds and 10,500 athletes.

A notable change is that the hundreds of thousands of spectators who will watch the open-air gala for free, spread along a 6-kilometer (3 1/2-mile) parade route on the River Seine, will need to pre-register for tickets. French Interior Minister Gerald Darmanin, in charge of Olympic security, had been pushing for that shift so throngs of non-paying spectators can be allocated designated spots on the river's upper embankments, separated from 100,000 other guests paying for a closer waterside view

closer, waterside view.

In the face of experts' misgivings about the size and complexity of the security operation, Darmanin, organizing committee president Tony Estanguet and Paris Mayor Anne Hidalgo spoke at a news conference in defense of France's decision to use the center of the city as the venue for the extravaganza, ditching the safety of a traditional stadium setting for the first time.

It promises great television if all goes well, showcasing iconic monuments and the Seine that is being cleaned up for Olympic swimming. But the unique logistical and secu-

rity requirements could backfire spectacularly in front of a global audience for France if there are major problems.

Paris' plans are gargantuan in other ways, too:

- The athletes will be paraded from east to west along the river aboard 91 boats, with 25 other craft in reserve for breakdowns or other needs. There will also be about 30 boats for security; the river could get crowded. There will be trial runs starting this July. The whole event, including the water-borne parade to the foot of the Eiffel Tower, an artistic and musical show, and the official ceremony with the lighting

of the Olympic flame and attended by heads of state is expected to last about 3 1/2 hours.

■ With a planned deployment of 35,000 police officers - swallowing up a sizable chunk of France's total of 250,000 - Paris' ceremony will dwarf "Operation Golden Orb," Britain's huge policing operation for the coronation of King Charles III. It mobilized nearly 13,000 police officers. London's police commissioner said it was the largest security operation that his 194-year-old Metropolitan Police force had ever led.

■ In all, 30,000 officers will be mobilized on average per day during the July 26-Aug. 11 Olympics, rising to as many as 45,000 on the busiest days in the Paris region, Darmanin told senators in October. Police vacations will be canceled in June, July and early August with "very rare exceptions" and other events that would have needed policing will be postponed, he said.

Thomas boosts bid to become oldest Giro winner

MONTE BONDONE, Italy, May 23, (AP): Geraint Thomas boosted his bid to become the Giro d'Italia's oldest winner by moving back into the leader's pink jersey on Tuesday as the race exploded into life at the start of a dramatic and decisive final week in the Dolomites.

João Almeida won the tough 16th stage atop Monte Bondone for his first victory in a Grand Tour. The Portuguese cyclist crossed the summit finish just ahead of Thomas, who also picked up valuable bonus seconds. Primož Rogli was third 25 seconds further behind.

CYCLING

The result saw Thomas move back into the lead, 18 seconds ahead of Almeida and 29 in front of Rogli.

Thomas turns 37 on Thursday, three days before the race ends in Rome. The

oldest Giro winner is Fiorenzo Magni, who was 34 when he won in 1955.

Tuesday marked the beginning of a brutal final week. It was one of three of the last six stages that have been given the maximum difficulty rating of five

There was more than 5,000 meters of elevation and five categorised climbs along the 203-kilometer (126-mile) route from Sabbio Chiese, including the topcategory climb to the finish.

LOS ANGELES, May 23, (AP): Nikola Jokic is a player unlike almost anything the NBA has ever seen, and now he's taking his Denver Nuggets somewhere they've never been. Jokic had 30 points, 14 rebounds and 13 assists, and the Nuggets advanced to the NBA Finals for the first time in team history Monday night, sweeping the Western Conference finals with a 113-111 victory over the Los Angeles Lakers.

came LeBron James' 31-point first half and a 15-point halftime deficit with a tenacious finish in Game 4 to earn their first conference title in their 47 NBA "It's incredible," Murray said. "It's a lot of fun. It's surreal. We're going to keep making history, that's the thing.

We're going to keep that mindset." Jokic earned his eighth triple-double of the playoffs by the third quarter, breaking Wilt Chamberlain's 1967 NBA record for triple-doubles in a single postseason. The bulky Serbian center with a point guard's grace also led the Nuggets' gritty defensive effort despite picking up his fifth foul mid-

way through the fourth quarter. Jokic didn't leave the floor for the final 33 minutes of Game 4 - and when Denver needed a big basket, Jokic delivered that as well. He muscled past Anthony Davis for the game's final points on a layup with 51 seconds to play.

BASKETBALL

James finished with 40 points, 10 rebounds and nine assists after the highest-scoring postseason half of his career, but even the top scorer in NBA history couldn't keep the deep, dynamic Nuggets from their sixth con-

secutive victory overall.

James missed two tying shots in the final seconds, with Aaron Gordon getting official credit for blocking his tying try at the buzzer.

The Nuggets will cap their superb season by playing for their first NBA championship. Denver both eliminated the Lakers for the first time in eight playoff meetings and swept a playoff series for the first time, likely earning several days off before the finals.

Unless the Boston Celtics make basketball history by rallying from their 3-0 deficit in the East finals, Denver will host the eighth-seeded Miami Heat to open the NBA Finals, beginning June 1.

The Lakers erased a seven-point deficit and tied it with five minutes to play, but Jokic hit a 25-foot fallaway 3-pointer - the kind of ridiculously impressive shot for a big man that Jokic makes routinely. After Davis hit two free throws to tie it with 1:13 left, Jokic put the Nuggets ahead again.

James then badly missed a strange fallaway jumper with 26 seconds left. Murray missed a turnaround to give the Lakers one last chance, but James' drive at the buzzer was thwarted by Murray and Gordon, who scored 22

James scored 21 points in the first quarter and worked desperately to keep the Lakers competitive in the final game of his 20th NBA season. But the Lakers couldn't even force a Game 5, with an apparently exhausted Davis scoring 10 of his 21 points in the fourth quarter and adding 14 rebounds.

Austin Reaves scored 17 points for the Lakers, who were swept in a playoff series for the 11th time in team history, including nine best-of-seven series.

James began the final game of his 20th NBA season with the highestscoring postseason half of his matchless NBA career.

He ended the night by questioning retirement after his Los Angeles Lakers were swept out of the Western Conference finals.

James set a personal record with 31 points in the first half of Game 4 on Monday night, but he missed two potential tying shots in the final minute as the Denver Nuggets ended the Lakers'

season with a 113-111 victory.

The 38-year-old James finished with 40 points, 10 rebounds, nine assists and immense frustration after Los Angeles' remarkable late-season surge ended with four consecutive defeats. Although the top scorer in NBA history spoke about himself as part of the Lakers next season, James also said he hasn't made up his mind.

"We'll see what happens going forward," James said in the final answer of his postgame news conference. "I

Newcastle qualify for CL for first time in 20 years

NEWCASTLE, England, May 23, (AP): Newcastle qualified for the Champions League for the first time in 20 years after drawing with Leicester 0-0 in the English Premier League on Monday, a milestone moment for a Saudi-controlled club with the resources and ambition to become a major force in European soccer.

The point ensured Newcastle cannot be denied a top-four finish heading into its final game of the season, at Chelsea on Sunday.

Leicester's campaign-closing game has far more riding on it, with the team still in the relegation zone and needing a win at home to West Ham to avoid falling into the second-tier Championship - seven years after winning the Premier League at preseason odds of 5,000-1 in a sporting fairytale.

Newcastle swarmed all over Leicester at St. James' Park, hitting the post on three occasions - through Callum Wilson, Miguel Almiron and Bruno Guimaraes - and forcing a series of saves from goalkeeper Daniel Iversen.

Still, it was job done for Newcastle, which was last in Europe's top club competition in 2003 when it reached the second group stage before finishing below Barcelona and Inter Milan. These are the types of European heavyweights Newcastle's players will be mixing with next season.

"We beat Juventus here 1-0 and I've seen that on DVDs - to hopefully be a part of it and be involved in those nights is something special," New-castle midfielder Sean Longstaff said.

Third-placed Newcastle moved a point ahead of Manchester United, which can also guarantee a top-four spot by avoiding defeat at home to Chelsea on Thursday.

United is the only team fifth-placed

Liverpool can catch now. Playing in the Champions League so soon is probably beyond the expectations of Saudi Arabia's sovereign wealth fund, which completed a 300-million-pound (\$409 million) buyout of Newcastle in October 2021 and has spent methodically rather than lavishly since.

Bad day for Juve with points penalty and loss at Empoli

Juventus hopes of qualifying for CL implode

MILAN, May 23, (AP): A bad day for Juventus turned worse when a 4-1 loss at Empoli saw its hopes of qualifying for the Champions League implode.

Before kickoff, Juventus was hit by a 10-point penalty for false accounting. That dropped the club to seventh in Serie A, five points behind fourthplaced AC Milan. Juve hosts Milan next weekend in one of its final two

Juventus thought it took an early lead when Arkadiusz Milik headed a corner off the crossbar and Federico Gatti bundled in the rebound but it was ruled out for a foul by Bremer on the goalkeeper.

Instead, Empoli went in front from a Francesco Caputo penalty in the 18th minute after Milik had fouled Nicolò Cambiaghi.

Sebastiano Luperto doubled Empoli's lead three minutes later, tapping in the rebound after Juventus goalkeeper Wojciech Szcz sny brilliantly parried Jean-Daniel Akpa Akpro at close

After the break, Akpa Akpro stole the ball off Bianconeri defender Alex Sandro and bore down on goal before rolling across for Caputo to dink it over Szcz sny.

The only good news for Juventus came late when Federico Chiesa scored his first league goal in more than a year. Chiesa was out for 10 months last year with a knee injury.
