Two ministers appointed

Sweden lauds decision

Iran among uninvited to Nobel award ceremony


STOCKHOLM, Sept 3, (AP): The Nobel Foundation on Saturday withdrew its invitation for representatives of Russia, Belarus and Iran to attend this year's Nobel Prize award ceremonies after the decision announced a day earlier "provoked strong reactions

Several Swedish lawmakers said Friday they would boycott this year's Nobel Prize award ceremonies in the Swedish capital, Stockholm, after the private foundation that administers the prestigious awards changed its position from a year earlier and invited representatives of the three countries to attend, saying it "promotes opportunities to convey the important messages of the Nobel Prize to everyone.'

Saturday's announcement was widely praised in Sweden by politicians. Even the Swedish Royal House reacted with spokeswoman Margareta Thorgren saying, as quoted by newspaper Aftonbladet, that "we see the change in the decision as positive." She added that King Carl XVI Gustaf was planning to hand out this year's Nobel awards at ceremonies in Stockholm "as before."

This year's Nobel prize winners will be announced in early October. The laureates are then invited to receive their awards at glittering prize ceremonies on Dec. 10, the anniversary of award founder Alfred Nobel's death in 1896.

KUWAIT CITY: The Directorate of Moral Guidance and Public Relations in the Army has called on sea-goers -- fishermen and hiking enthusiasts to be careful, given that the Naval Force will be carrying out exercises with live ammunition with the participation of the Air Force, from September 5 to 7, from seven in the morning until six in the evening, at the naval shooting range - 16.5 nautical miles east of Ras Al-Julaiah, extending to Qarwa Island, and 6 nautical miles east of Ras Al-Zour, extending to Umm Al-Maradim Island, reports Al-Rai daily.

The Directorate of Moral Guidance and Public Relations has called on citizens and residents who go to the sea not to approach the aforementioned area during the announced period, out of concern for everyone's safety.

Former two-time Premier Giuliano Amato appealed to French President Emmanuel Macron to either refute or confirm his assertion about the cause of the crash on June 27, 1980, which killed all 81 persons

aboard the Italian domestic flight. In an interview with Rome daily La Repubblica, Amato said he is convinced that France hit the plane while targeting a Libyan military jet.

> While acknowledging he has no hard proof, Amato also contended that Italy tipped off Gaddafi, and so the Libyan, who was heading back to Tripoli from a meeting in Yugoslavia, didn't board the Libyan military jet. What caused the crash is

> one of modern Italy's most enduring mysteries. Some say a bomb exploded aboard the Itavia jetliner on a flight from Bologna to Sicily, while others say examination of the wreckage, pulled up from the seafloor years later, indicate it was hit by a missile.

> Radar traces indicated a flurry of aircraft activity in that part of the skies when the plane went down.

> "The most credible version is that of responsibility of the French air force, in complicity with the Americans and who participated in a war in the skies that evening of June 27," Amato was quoted as saying.

NATO planned to "simulate an exercise, with many planes in action, during which a missile was supposed to be fired" with Gaddafi as the target, Amato said.

In the aftermath of the crash, French, U.S. and NATO officials denied any military activity in the skies that night.

According to Amato, a missile was allegedly fired by a French fighter jet that had taken off from an aircraft carrier, possibly off Corsica's southern coast.

Macron, 45, was a toddler when the Italian passenger jet went down in the sea near the tiny Italian island of Us tica. "I ask myself why a young president like Macron, while age-wise extraneous to the Ustica tragedy, wouldn't want to remove the shame that weighs on France," Amato told La Repubblica. "And he can remove it in only two ways - either demonstrating that the this thesis is unfounded or, once the (thesis') foundation is verified, by offering the deepest apologies to Italy and to the families of the victims in the name of his government." Amato, who is 85, said that in 2000, when he was premier, he wrote to the then presidents of the United States and France, Bill Clinton and Jacques Chirac, respectively, to press them to shed light on what happened. But ultimately, those entreaties yielded 'total silence," Amato said. When queried by The Associated Press, Macron's office said Saturday it wouldn't immediately comment on Amato's remarks. Italian Premier Giorgia Meloni called on Amato to say if he has concrete elements to back his assertions so that her government could pursue any further investigation. Amato's words "merit at-tention," Meloni said in a statement issued by her office, while noting that the former premier had specified that his assertions are "fruit of personal deductions." Assertions of French involvement aren't new. In a 2008 television interview, former Italian President Francesco Cossiga, who was serving as premier when the crash occurred, blamed it on a French missile whose target had been a Libyan military jet and said he learned that Italy's secret services military branch had tipped off Gaddafi. Gaddafi was killed in Libya's civil war in 2011. A few weeks after the crash, the wreckage of a Libyan MiG, with the badly decomposed body of its pilot, was discovered in the remote mountains of southern Calabria.

'Always go forward, always progress'

Papal shout-out to 'noble' Chinese

ULAANBAATAR, Mongolia, Sept 3, (AP): Pope Francis sent a special greeting to China's "noble" people on Sunday, giving them a special shout-out at the end of a Mass celebrated in neighboring Mongolia during the first-ever papal visit that was largely overshadowed by Beijing and its crackdown on religious minorities.

Francis brought up to the altar the retired and current bishops of Hong Kong, Cardinal John Hon Tong and Cardinalelect Stephen Chow, clasped their hands and told the crowd that included many mainland Chinese pilgrims that he wished them all well.

"I want to take advantage of their presence to send a warm greeting to the noble Chinese people," Francis said. "To all the (Chinese) people I wish the best and to always go forward, always progress."

"I ask Chinese Catholics to be good Christians and good citizens," he added, to cheers from the crowd in the Steppe Arena, in the capital, Ulaanbaatar.

It was the first and only time that Francis has publicly mentioned China during his four-day visit, despite the large shadow that Beijing has cast over the trip and Mongolia.

China's ruling Communist Party has been waging a years-long, sweeping crackdown on religion, tightening controls, especially on Christianity and Islam that are viewed as foreign imports and potential challengers to Communist authority.

KUWAIT CITY: The British authorities have addressed their Kuwaiti counterparts in Kuwait, inquiring why there is no request for disbursement of money seized from some British banks for the benefit of Kuwait, reports Al-Jarida daily. The sources indicated that the

British authorities confirmed some money in British banks belonging to Kuwaiti citizens have been seized or have been frozen and to be returned to the Kuwaiti authorities in return.

This is done in line with the judicial prosecutions carried out by Kuwait against a number of those convicted in criminal cases and live outside the country.

TEL AVIV: Israeli Prime Minister Benjamin Netanyahu said Sunday he wants Eritrean migrants involved in a violent clash in Tel Aviv to be deported immediately and has ordered a plan to remove all of the country's African migrants.

The remarks came a day after bloody protests by rival groups of Eritreans in south Tel Aviv left dozens of people injured. Eritreans, supporters and opponents of Eritrea's government, faced off with construction lumber, pieces of metal and rocks, smashing shop windows and police cars. Israeli police in riot gear shot tear gas, stun grenades and live rounds while officers on horseback tried to control the protest-

ers. The violence on Saturday returned to the fore the issue of migrants, which has long divided Israel. Its resurgence comes as Israel is torn over Netanyahu's judicial overhaul plan, and supporters cite the migrant issue as a reason why the courts should be reined in, saying they have stood in the way of pushing the migrants out. (AP)

RIYADH: GCC Secretary General Jassem Al-Budaiwi lauded on Sunday the efforts of the Saudi Digital Cooperation Organization (DCO), an entity geared towards achieving global sustainable development within the digital domain especially digital economy.


The GCC Secretariat said that Al-Budaiwi's statement came during his visit to the DCO's headquarters in Riyadh.

Rentals niche an investment draw

KUWAIT CITY, Sept 3: The Trei Real Estate GmbH ("Trei"), an international developer and asset manager and KINGSTONE Real Estate ("KINGSTONE"), an investment management group for institutional capital, is in the process of establishing an exclusive long-term collaborative venture for shaping tomorrow's landscapes and developing rental housing projects in major Polish cities. In the near term, it is intended to create an investment vehicle for the onboarding of interested investors.

KINGSTONE is tasked with managing the fundraising efforts, which entails identifying and engaging potential investors. They will also establish the appropriate investment framework and assume responsibility for fund and asset management.

Meanwhile, Trei will participate as a co-investor and developer. Their role encompasses acquiring the land parcels, overseeing the entire construction process, and working in tandem with KINGSTONE to facilitate the eventual sale of investments upon project completion. Specific parcels of land in Warsaw and Poznan have already been designated for this collaborative venture.

Pepijn Morshuis, the CEO of Trei Real Estate, says, "Demand for modern rental apartments is definitely strong in Poland, where-



as supply is very tight. The vast majority of Poles owner-occupy their homes, as the private rented sector is only just beginning to evolve.

Yet the younger generation prefers to rent modern, high-quality apartments over owner-occupancy in order to remain mobile and to keep from tying up their capital.

However, demand for rental apartments outpaces supply, especially in the major cities. The shortfall on the Polish housing market is estimated to approximate 1.5 million rental apartments, which compares

to a present stock of about 10,300 as-new rental apartments – highlighting the urgent need for investments."

A pipeline with the first secured projects to be developed within the scope of the collaborative venture is already in place. Here, Trei and KINGSTONE concentrate on the development of smaller apartments in inner-city locations that are tailored to the needs of young professionals, students, expats and young families.

With successful ownership apartment projects already completed and ongoing developments in Łódz, Wrocław and Warsaw, Trei is now moving ahead with its first rental apartment developments in the next step. Its initial two rental housing projects in Warsaw and Poznan have progressed to an advanced stage. Actual construction will start in Poznan in Q4 2023 and in Warsaw during the first half of 2024. Other cities with high potential for rental apartment developments include Krakow, Wrocław, Łódz, Katowice and Gdansk.

Poland's private rental housing market offers serious growth opportunities. The main reason for this is that it accounts for just one percent of the entire housing market, and that it therefore plays so far a negligible role in the formerly socialist country. Until the end of the Cold War in the late 1980s, all housing was municipally owned, and nearly all of it began to be sold off as ownership apartments in the 1990s.



KUWAIT CITY, Sept 3: MP Osama Al-Zaid has proposed the inclusion of Bioinformatics to the list of courses in the overseas scholarship plan of the Higher Education Ministry starting from the next academic year.

He suggested categorizing Bioinformatics as a rare specialization in the first five years of its inclusion in the annual overseas scholarship plan of the ministry. He said the Civil Service Commission (CSC) should specify the job title for Bioinformatics graduates.

Meanwhile, MP Fayez Al-Jomhour has forwarded queries to State Minister for Municipality Affairs and Communications Fahd Al-Shulah about the decision of Kuwait Municipality to refrain from issuing description certificates to the owners of houses in Jleeb Al Shuyoukh. He wants to know the rationale behind such a decision, considering it prevents the owners of houses in the aforementioned area from selling the properties. He argued this is a violation of the Constitution and it is a big problem for many Kuwaiti families currently staying in Jleeb Al Shuyoukh who want to sell their houses in order to relocate to other areas due to the social and security issues and other problema in Jleeb.

He asked if the State Ministry for Municipality Affairs took measures to determine the prices of real estate properties in Jleeb in order to buy them and then modernize the area. If yes, he wants to know the date of completing these measures.

He also inquired if Al-Shulah carried out studies to determine and address the worsening problems in Jleeb, including the deterioration of infrastructure and the security issues.

MP Osama Al-Zaid asked Al-Shulah to provide him with the number of male and female Kuwaitis in and outside the country, as well as the number of male and female expatriates in the country as of Dec 31, 2022 according to the records of the Ministry of Interior, Ministry of Health, Public Authority for Civil Information (PACI) and Central Statistics Bureau (CSB).

He wants to know if there are Kuwaitis who have no address, if CSB carries out its tasks as per the relevant law such as unifying the statistical data of all public institutions, if there is an automated link between CSB and other concerned institutions like the Births and Deaths Central Registry, Land Borders General Department and PACI.

He also asked if CSB has recorded individuals without identification documents - whether valid or expired and issued by Kuwait or foreign authorities; way of dealing with these individuals if any; and if CSB reported them to the concerned authorities.

MP Abdulkareem Al-Kandari forwarded the same queries to Deputy Prime Minister, State Minister for National Assembly and Cabinet Affairs Essa Al-Kandari; as well as Minister of Justice and State Minister for Housing Affairs Faleh Al-Raqaba about the news that Al-Jarida daily published Sunday quoting reliable sources as saying: "The British authorities asked their Kuwaiti counterparts why the latter did not request for the con-fuence of Kuwaiti citizers as per fiscated and frozen financial assets of Kuwaiti citizens as per the request of Kuwait because of court verdicts against some Kuwaitis staying abroad for committing various crimes.

The lawmaker wants to know why the concerned Kuwaiti

institutions did not deny the news if it is erroneous, if there are correspondences between the British and Kuwaiti authorities on this issue including the names of convicted Kuwaitis abroad, and copies of such correspondences if the response



is in the affirmative. MP Dawoud Ma'arafi asked Minister

Following is a breakdown of the needed teachers from Jordan:

Male teachers: 35 for English in the intermediate and secondary levels, 25 for French and 55 for Mathematics in the primary and secondary levels, 25 for Science in the primary level, 10 for Chemistry, 15 for Physics, 10 for Biology and 10 for Geology – a total of 185 male teachers. Female teachers: 60 for Mathematics in the intermediate

and secondary levels, and 10 for Physics – a total of 70.

Sources said the ministry's plan was to hire 255 teachers from Jordan, but the Jordan Recruitment Committee failed to hire the specified number of teachers; because only 120 applicants were recruited, indicating the ministry might hire the remaining number of required teachers from Palestine.

Sources stated that the Palestine Recruitment Committee is supposed to hire 230 male teachers - 45 for English in the middle and highschool levels, 25 for French, 65 for Mathematics in the middle and highschool levels, 35 for Science in the intermediate level, 15 for Chemistry, 20 for Physics, 15 for Biology and 10 for Geology. The required female teachers are 90 for Mathematics in the middle and highschool stages and 15 for Physics. Sources disclosed this committee's work ended Sunday.

Sources affirmed the ministry is coordinating with the concerned authorities to ease the procedures for the arriving teachers, so they can assume their duties as soon as

possible.

He inquired about the manpower

needs of the ministry, number of Kuwaiti graduates recruited since 2020 till date including their specializations, number of vacant supervisory positions, and number of expatriate and Kuwaiti consultants at the offices of the minister and assistant undersecretaries including their nationalities.

On the other hand, MP Mehalhal Al-Mudhaf commented on the response of HH the Prime Minister Sheikh Ahmad Nawaf Al-Ahmad Al-Sabah to his queries on the resignation of Finance Minister Mnaf Al-Hajri, and the strategy for putting public authorities and institutions under the supervision of ministers. He expressed dismay over the premier's response, which he considers arrogant and indicates that the premier does not respect the parliamentary tools granted to MPs as per the relevant laws and the Constitution. He quoted the premier as saying that assigning public authorities and institutions to ministers is not part of the general policy of the State and that such queries should be forwarded to the concerned ministers. He retorted, "if this is not the task of HH the Prime Minister, who is responsible then?" He pointed out that the Public Authority for Agriculture Affairs and Fish Resources (PAAAFR) has been under three different ministers in the government of Sheikh Ahmad Nawaf.

He added that during the tenure of HH the late Amir Sheikh Saad Al-Abdullah as Prime Minister and Crown Prince, he was asked about the resignation of a minister in his government and he responded to the query. Al-Mudhaf said the response of Sheikh Ahmad Nawaf indi-

cates that he is not aware of his responsibilities and the limits of the authority granted to him. He added this attitude indicates that the rumor about the government being managed by someone else is true

Conditions for higher studies Scholarships tailored for job needs

KUWAIT CITY, Sept 3: The scholarship programs are being meticulously tailored to fit the specific needs and requirements of government agencies for employees interested in pursuing further education which is an ongoing process, reports Al-Anba daily.

According to the daily, an informed source emphasized that the scholarship program is individually customized for each entity, with close alignment between the stipulations laid out in the scholarship regulations and the additional conditions deemed necessary by the government entity including the granting of study leaves.

These conditions are vital given the objectives for sending its employees to further their education, whether within the country or overseas.

Furthermore, the source noted that the Civil Service Commission is actively engaged in the enhancement, examination, and revision of the scholarship regulations to incentivize employees who aspire to continue their education both domestically and internationally. Currently, the semi-final formulation and drafting of these amendments are in progress, having received preliminary approvals from the relevant authorities regarding new benefits and conditions.

In response to inquiries about financial benefits, it was clarified that such considerations are taken into account, with scholarship students receiving increased benefits funded by the Ministry of Higher Education.

Regarding the appointment of leadership positions, the source explained that the procedures for selecting leaders are conducted in a phased manner, commencing with the requirement that candidates meet specified criteria, including years of service and accomplishments accrued over their tenure.

This initial step falls under the jurisdiction of the CSC, which subsequently presents the list of candidates for evaluation.

The CSC carries out additional steps before endorsing the nominated individuals. The source stressed that these procedures and stages require some time, while also mentioning that certain leadership appointments have been prepared in accordance with the recommendations of the competent authority.

Financial and administrative attachés to take up foreign postings soon

KUWAIT CITY, Sept 3: The Ministry of Health has finalized the names of financial and administrative attachés to work in health offices abroad.

The sources told Al-Jarida that all the names of the financial and administrative attachés to work in Egypt, Britain, Germany and France have been identified by the Ministry of Health but are awaiting approval by the Ministry of Foreign Affairs. A few days ago, the Minister of Health had issued a number of decisions ap-

pointing health attachés for Kuwaiti offices abroad, and the decisions included naming Dr. Muhammad Awaida Al-Ajmi, head of the health office in Egypt, and Dr. Tariq Al-Kandari, health attaché to the London office, and Dr. Ahmed Al-Moussawi, health attaché to the Germany office, and Dr. Mahdi Al-Fadhli, health

attaché to the France office.

On the other hand, the Director of the Jahra Health District, Dr. Jamal Al-Duaij checked on the work progress in the departments and units of the new hospital, including the pharmacy, accident departments and police stations with the aim of finding mechanisms to develop work in the hospital and improve the health services provided to citizens.

Informed health sources said the district director discussed the challenges facing work in hospital facilities, with the aim of developing urgent solutions to develop work for the benefit of patients and visitors.

The district director a few days ago met with officials and technical and ad-

ministrative staff of the Jahra Hospital, to discuss plans and projects related to the region after he was assigned to assume the duties of district director.

It is worth noting that the Prime Minister, His Highness Sheikh Ahmed Nawaf Al-Ahmad, visited the Al-Jahra Hospital a few days ago, where His Highness met with patients who singled out to the minister the problem of medicine shortages, the accumulation of appointments, overcrowding in outpatient clinics, and other problems.

His Highness also listened to the comments made by some employees, who confirmed that the hospital suffers due to shortage of administrative employees, and lack of information signboards due to which movement within the hospital's departments and units is hampered.

Government to fortify strategic food & commodity stocks to prevent shortage

Move reassures citizens on availability of items in long run

KUWAIT CITY, Sept 3: In a government move to fortify the strategic food and commodity stocks to prevent shortage and reassure citizens on the availability of these items in the long run, Minister of Commerce and Industry and Minister of State for Youth Affairs Muhammad Al-Aiban issued three decisions within the framework of a comprehensive strategy regarding warehouses in the country, reports Al-Rai daily.

Al-Aiban formed a committee task to work on mechanisms for ensuring ample supply of food and other commodities withTariq Al-Sharrah as Chairman, Saleh Al-Dhafiri as Vice-Chairman, and Faisal Al-Ansari, Ghazwa Al-Anzi and Ibrahim Al-Sultan as members while Saad Al-Adwani serves as a

member and rapporteur.

The committee, whose work period is set at three months, will study the mechanisms in place to maintain food and commodity stocks, lay down a comprehensive vision for maintaining and developing stocks in cooperative societies and parallel markets, and organize

public awareness campaigns on the

need to rationalize food consumption and reduce waste.

Provision

In addition, the minister formed an 11-member committee that will follow up the contents of the report of the Government

Performance Follow-Up Agency regarding the provision of strategic areas for the establishment of warehouses and setting up a manual of procedures for organizing and supervising these areas.

According to the decision, the committee will lay down a plan and create an automated system to monitor the strategic stock and link it with the Kuwait Flour Mills and catering companies, as well as coordinate with Kuwait Municipality and other concerned authorities to allocate plots for the construction of multi-storey buildings for selling and distributing subsidized and discounted supplies.

The committee will be in charge of following up and facilitating procedures for establishing the government company for strategic stocks, studying the new supply centers project and proposing the best practices for the implementation of the project.

Al-Aiban also issued a decision to restructure the Standing Committee, consisting of nine members, for the selection and inclusion of food and discounted items in the ration card system.

PPP project making significant progress

'Sanitation projects' in Kuwait keep pace with development, says MEED

KUWAIT CITY, Sept 3: The developer of the largest independent publicprivate partnership project in the Gulf region is making significant progress in the field of wastewater treatment, as clips of the Kuwait branch of the German company WTE Wassertechnik, the main private developer and contractor in the Umm Al-Hayman wastewater treatment plant project, show that sections of various projects could be approaching the operating stage, reports Al-Qabas daily quoting MEED.

The magazine said that the facility was designed to treat wastewater from the southern part of Kuwait, to supply agriculture and various other industries with highly treated wastewater (TSE).

Capacity

MEED added the wastewater treatment plant, which has an initial capacity of 500,000 cubic meters per day and can be expanded to 700,000 cubic meters per day, is being developed on the basis of the build-operate-transfer (B.O.T) system, and the huge network of wastewater pipelines are being laid to carry sewage pipes to pumping stations and tanks on the BDO model.

WTE will operate and maintain the Umm Al-Hayman wastewater treatment plant for 25 years, and the canal network for three years.

MEED indicated that at the time of signing, the Umm Al-Hayman Wastewater Treatment Plant was the second project to be awarded under Kuwait's current public-private partnership law, after the contract to develop the North Al-Zour 1 Independent Water and Power Project was awarded in 2012.

The magazine added, the project demonstrates the ability of stakeholders in the public and private sectors to implement a huge infrastructure project in a country where successful partnerships between the public and private sectors are still few and far between.

It is worth noting that other sanitation projects are moving forward in Kuwait as well.

Companies recently submitted bids to expand and develop the sewage treatment plant in North Kabd, affiliated with the Ministry of Public Works. Unlike the Umm Al-Hayman wastewater treatment plant project, this long-awaited scheme is being developed using the traditional engineering, procurement and construction (EPC) route.

The Ministry of Public Works also recently called on technically qualified companies to submit their commercial bids for the contract to build the sewage treatment plant project in South Al-Mutla'a by October 29.

Ministry already passed critical stage

MEW to set up three main power stations to serve Google centers

KUWAIT CITY, Sept 3: Assistant Undersecretary for the Electricity Transmission Networks Sector in the Ministry of Electricity and Water Eng Faisal Al-Sumait has revealed that the ministry, Kuwait Direct Investment Public Authority (KDIPA) and some other concerned entities are currently coordinating to establish three main power stations to serve three Google centers that the global company intends to open in the country soon, reports Al-Rai daily.

Speaking on the sidelines of the opening of the first summer electricity exhibition with the theme: 'Oh, our sweet heritage, Al-Sumait disclosed: "The three stations will have a total capacity of 72 megawatts. Google requested for 60 megawatts - 20 megawatts for each center."

Agreement

He affirmed an agreement has been reached to establish Google centers in three locations - Sulaibiya Agricultural Area, South Saad Al-Abdullah City and South Al-Mutlaa City.

Regarding the tariff that will be calculated for the company, he said: "The tariff will be studied and evaluated by experts in the ministry to determine the appropriate value, followed by coordination with the concerned authorities.'

On the status of electricity consumption this summer, Al-Sumait confirmed that the ministry already passed the critical stage - when power consumption records were broken. He pointed out there are only 10 days left in summer, stressing the ministry started the maintenance works at the beginning of September and will continue until the end of April next year.

He added the power consumption decreased significantly in recent days; indicating the consumption index recorded 15,140 megawatts last Sunday - 1,800 megawatts lower than the highest recorded on Aug 2 (16,940 megawatts).

KFAED launches program to enhance newly grad's skills

KUWAIT CITY, Sept 3, (KUNA): Kuwait Fund for Arab Economic Development declared on Saturday start of receiving applications for joining its program for training and habilitating newly graduated architects and engineers as of tomorrow Sunday.

It said in a statement that applications can be posted on the website: www.Kuwait-fund.org. Applicants should come to the fund headquarters as of tomorrow until September 17.

The program kicks off on December 13 and proceeds for 13 months. It includes workshops and field training in Kuwait and abroad.

The statement affirmed that the program is of paramount significance for it backs up human resources' development in Kuwait. Since its onset in 2004, participants acquired added skills and potentials, paving the way for them to meet the local market employment needs.

'Expansion of the BRICS group ... connotations and repercussions'

"THE process of expanding the BRICS group, through the accession of Saudi Arabia, Egypt, the Emirates, Iran, Ethiopia and Argentina, in January 2024, represents a turning point in the history of international relations at various levels. After the inclusion of these pivotal countries, BRICS has become the largest economic organization in the world, whose membership -- until now -- is limited to the countries of the East and South and the rising non-Western power. It includes approximately half of the world's population, and its economy represents ap-

proximately 30% of the global economy," columnist Dr Nou-ra Saleh Al-Majim wrote for Al-Qabas daily.

"So we are facing a radical historical transformation in the system and map of international balances and alliances that have emerged since the end of World War II. For the first time in the international system, since the end of World War II, a giant non-Western

global bloc has emerged, and even surpasses it in all aspects of comprehensive capabilities. Thus, BRICS also consolidates true pluralism in the international system away from the single Western hegemony led by the United States that has emerged since the end of the Cold War.

"The BRICS expansion process was carried out with strong support and backing from China, the group's de facto leader, to serve many strategic purposes. BRICS represents the pressing force to achieve the joint endeavor of China and Russia, for which BRICS was established, which is the establishment of a multipolar international system, with China being the leader of one of the powerful poles in this system.

"BRICS also represents one of the most important aspects of China's strength to confront the American alliances, which have grown during the Biden era to weaken China, such as the Quad and Oaks alliance. Moreover, through BRICS, China opens more markets for its products. The five countries that have joined the BRICS, in addition to the original BRICS countries, represent a huge market to absorb Chinese products.

"The expansion of BRICS will certainly have many positive and negative repercussions as well, and it will also face many challenges. Most of the positives come from breaking Western hegemony over global political and economic interactions, as BRICS will establish a broad global trading system - anti-Western - from which developing countries and emerging markets will benefit greatly. Perhaps this explains the rush of most developing countries to join the group.

'Among the strategic goals of BRICS is to alleviate the absolute dominance of the dollar in international trade transactions, and to consolidate barter in local currencies in trade between members of the group. Thus, developing countries reduce the burden of trade and debts in US dollars, and have a wider scope and more markets for export and import. Perhaps the Ukrainian war has proven the disasters of the absolute dominance of the dollar in the international system.

difficulty in establishing a unified currency for the group -- as BRICS plans -- as well as creating comprehensive economic integration between the countries of the group similar to the European Union.'

Also:

"Today's thieves are not like their predecessors who used to break the locks of homes and break into their windows to loot what was light in weight and expensive. The new generation of these people is able to climb the walls of banks and penetrate their impenetrable fortresses," columnist **Riyad Abdullah Al-Mulla** wrote for **Al-Anba** daily.

"They penetrated the accounts of the wealthy and plundered the funds of ordinary citizens, engaging in perilous schemes and thrilling episodes that kept banks on edge, diverted the attention of police stations, and spurred investigations. As of the time of writing this article, these "thieves" continue to tamper with financial institutions, eroding confidence in the banking systems and the custodians of bank deposits.

'The zeroing of bank balances and illicit cash withdrawals, which encompass embezzlement, robbery, intrusion, and exploitation of citizens, residents, youth, and retirees, calls for officials from relevant authorities to convene around a discussion table. They must scrutinize the vulnerabilities in the fortresses of wealth and shield customers from the clutches of robbery and fraud syndicates.

"Incidents of misappropriation of people's finances unfold before us daily, adopting various tactics and disguises. These range from impersonating individuals, banks, and corporations, employing deceptive communications filled with false business propositions to coax clients into revealing their account details for theft. This culminates in the presence of counterfeit websites resembling government platforms on the internet, exploiting payment irregularities or transaction fees to obtain account numbers and siphon away savings.

'The responsibility for addressing this escalating crisis, akin to a snowball gaining momentum, should be shouldered by multiple stakeholders involved in overseeing money transfer and transaction operations. They must grasp the reins on which account thieves ride, decipher the codes of organized criminal networks, bring them to justice, and confine them to their rightful place - maximum security prisons.

'Telecommunication companies should also assume responsibility by disconnecting phone lines of individuals who have permanently left and combating the illicit sale of numbers and lines on social media platforms without proper registration of owner information and identities. Those who steal our funds often employ Kuwaiti numbers to make contact.

"Banks should recognize that, while customer awareness is crucial, it is no longer sufficient to prevent financial theft today. They should establish a mechanism in coordination with the Central Bank to halt repetitive withdrawals or transfers during specific hours, freeze any reported financial transactions, and heighten the sensitivity of smart applications.

"These apps should technically and automatically block any suspicious transactions until customer identity is verified with clarity, including voice and facial recognition, and they should restrict large transfers except through the bank or direct communication with its management, or via more precise and discreet techniques.

Mol foils bid to smuggle huge quantity of drugs into country

Female doctor dismissed, fined KD 300,000

KUWAIT CITY, Sept 3, (KUNA): The Ministry of Interior, in a statement, said the anti-drug squads detained a gang – a citizen, five nationals of an Asian country and two illegal residents.

The personnel were first tipped about a bid by a couple of persons trying to smuggle narcotics into the country by the sea. After monitoring them round the clock, a warrant was issued and they were nabbed and that they confessed to trying to smuggle five bags packed with 120-kg of hashish and 50,000 Capatagon pills into Kuwait.

Moreover, they received information about an incoming ship boarding narcotics.

After watching the vessel sailing into the Kuwait waters, it was intercepted and four persons of an Asian country were nabbed for trying to bring in illicitly 20 kgs of hashish. Furthermore, two illegal residents who were waiting for the ship upon anchoring were arrested and 30 grams of "shabu" were found in their possession.

Female doctor dismissed: The Court of Cassation recently issued a ruling on the dismissal of a female Kuwaiti doctor from the Ministry of Health and fined her KD300,000 for forging her university certificate, through which she worked as a doctor for six years and received the salary she does not deserve, reports Al-Qabas daily.

The Public Prosecution had earlier charged the accused, in her capacity as a public sector employee, of unlawfully receiving public funds by submitting the forged certificate to the Civil Service Commission (CSC) and she received a total salary of KD150,000 based on the forged document.

Attempt to end his own life 35-yr-old kills his girlfriend

KUWAIT CITY, Sept 3: A horrifying incident unfolded in the Omariya area, where a 35-yearold Filipina resident tragically lost her life at the hands of a 35-year-old Indian expatriate. The assailant brutally stabbed her multiple times, resulting in her untimely demise, after which he attempted to end his own life using a knife. He was subsequently rushed to Farwaniya Hospital, where his health condition remains critically unstable.

According to a reliable security source, the Ministry of Interior's Operations Room received a distressing report, alerting

'The BRICS also faces a number of challenges, including the chronic historical conflict between China and India. Perhaps this issue is the main weakness of BRICS. India and China within BRICS unite on key issues, the most important of which is the expansion of global trade liberalization, but they differ on many issues

"India will never accept absolute Chinese leader-ship over the BRICS, nor will it accept raising tensions with the United States, its main ally. Therefore, the muted Indo-China conflict within BRICS is likely to hinder the advancement of the group's power. In the same vein, it is also not unlikely that Moscow will accept absolute Chinese hegemony over the BRICS, as well as push the group in directions that do not serve Russia's strategic interests.

"Among the main challenges is also the extreme

Immediate freezing or suspension of transferred funds should be implemented if reported within a short timeframe.

Al-Faris' actions distinguish him as a young individual who cares deeply for his nation, works diligently, and is attuned to the needs of the public. Thank you, and may there be more like you.

MoE to receive complaints via WhatsApp, e-mail

KUWAIT CITY, Sept 3: The concerned authorities in the Ministry of Education have intensified their efforts to complete the work related to readying the schools as the new 2023/2024 scholastic year is set to kick in next Sunday, reports Al-Jarida daily

In this context, educational sources said the Ministry has allocated an "online" communication center to receive any complaints from school administrations regarding maintenance and air conditioning units, explaining that receiving written notes is done via WhatsApp and email for the establishments sector.

The sources pointed out the phone numbers of maintenance engineers in all educational areas have been provided to all schools and one engineer has been allocated to each area who will be responsible for following up on maintenance and air conditioning work in these schools who can be contacted directly by school administrations.


The sources stated that complaints numbers have been allocated for each of the two educational districts to report any observations in the event of failure to take action or inaction by those responsible for school maintenance, pointing out that the school administrations have more than one means of reporting breakdowns and necessary maintenance to ensure its completion in the required time.

Regarding air conditioning maintenance work, the sources confirmed that companies are currently working to complete air conditioning maintenance in schools, whether with the "central" system or separate units and "chillers," pointing out that according to reports, the completion rates have exceeded 85% of the total number of air conditioning devices.

The sources added all work on air conditioning units is expected to be completed before the end of this week. The sources stated that the existence of air conditioning contracts contributed to solving the problems of maintenance and operation of the devices.

Regarding the maintenance of water coolers, the sources it is ongoing and water filters have been delivered to schools which will be replaced prior to the beginning of school to ensure that the water tanks are cleaned well before installing the new filters.

The sources indicated that the facilities sector is working with all its crews of engineers and assistant engineers in cooperation with the companies responsible for implementing contracts to ensure the completion of maintenance and air conditioning work, pointing out that the teams formed by the public education sector from school administrations for follow-up have a responsibility in this aspect.

US labor data shows both resilience and moderation

Signs of Easing in the US Labor Market

Non-farm employment change came in at 187,000 ver-sus an expected figure of 170,000 marking the 39th month of job creation in the US. The report offered fresh signs that hiring has not been as strong as previously reported. The previous two month figures were revised significantly lower by a combined 110,000.

Labor participation, which measures the share of population that is working or seeking work, rose to 62.8%, its highest level since February 2020. The figure indicates that the supply-demand dynamics are coming into balance which might help soften wage pressures. Average hourly earnings were up 0.2% on a monthly basis lower than the expected 0.3% and the previous 0.4%. Annually, wages grew at 4.3% as expected and lower than the previous figure of 4.4%. Meanwhile, the unemployment rate climbed to 3.8% from 3.5%, largely reflecting an increase in participation.

JOLTS Job Openings

The number of available jobs in the US shrank for the third consecutive month, dropping below 9 million for the first time since early 2021. Job openings fell to a seasonally adjusted 8.827 million, from 9.165 million in June, reaching the lowest level of total openings since March 2021. Economists expected openings would drop to 9.465 million. For the Federal Reserve, signs the labor market is continuing to cool might push the central bank to end its campaign of rate increases sooner.

ADP Non-Farm Employment Change

ADP non-farm employment in the US slowed down significantly more than expected in August, with the figure coming in at 177,000 jobs added versus an expectation of 200,000 and a previous figure of 371,000 jobs. **Unemployment Claims**

The number of Americans filing for unemployment claims dropped to 228,000 from an upwardly revised 232,000 amid a series of mixed employment data coming over the week

Consumer Confidence Eases

US consumer confidence fell more than expected in August after marking two straight monthly increases. The Conference Board said its consumer confidence index dropped to 106.1 this month from a downwardly revised 114.0. The decline in confidence is mainly attributed to renewed concerns regarding inflation.

US GDP Revised Lower

Second quarter GDP in the US was revised lower to a 2.1% increase down from 2.4% reported last month. This still represents a slight increase from the first quarter GDP growth of 2.0%, in a sign that despite 525bps

Additionally, personal saving was revised upward by \$22.7 billion to \$892.3 billion, as employers scramble to keep a hold of their employees following troubles hiring due to COVID by increasing their annual wages. Consumer spending continues to be the lifeblood of economic growth, and was revised up to 1.7% from 1.6% initially.

Market Reaction

On Friday, treasury yields, equity futures and the dollar traded in a volatile manner following a US jobs report that offered a mix picture of both a resilience and moderation in the labor market. Market participants continue to see the Fed leaving interest rates unchanged this month, and they also lowered the probability of a hike in November. US 10-year yields initially dropped to a low of 4.054% only to recover significantly and closed the week at 4.178%. The Dollar Index lost some grounds initially, as data continues to moderate but managed to close the week higher at 104.26 as yields recovered.

The Euro took a hit last week as worsening activity data put a dent on the bloc's economic outlook, mounting pressures on the European Central Bank's rate path. The prospect of a less hawkish ECB weighed on the Euro, causing it to pull back sharply after reaching weekly highs against the US Dollar. The single currency closed the week at 1.0777.

Similarly, Sterling closed the week lower at 1.2591 amid worsening data and demand for the safety of the greenback. The Japanese Yen, the most sensitive to US interest rates, gained to 144.45 on Friday. The Yen lost

Europe

Inflation Remains Sticky

Eurozone inflation stopped slowing in August, presenting European Central Bank officials with a dilemma as they evaluate whether pressures are too persistent to risk a pause in interest-rate hiking. Consumer prices rose 5.3% from a year earlier, holding more than 2.5 times above the 2% goal sought by policymakers, mainly on the back of rising energy prices. Meanwhile, economists had anticipated weakening. The core figure which strips out volatile items slowed to reach 5.3%, in line with expectations and lower than the previous 5.5%. Markets are currently pricing in an 80% chance of a pause for the September ECB meeting as officials vow to remain data dependent.

United Kingdom

UK Manufacturing PMI Contraction Continues British factories in August underwent their weakest month since the COVID-19 crisis, with orders dropping dramatically due to the rise in interest rates at home and abroad. The S&P Global/CIPS UK manufacturing Purchasing Managers' Index (PMI) dropped for a sixth month in a row, falling to 43.0 from 45.3 in July. It was the lowest reading in 39 months, although it was slightly above the estimated 42.5. The figure marks the 13th month in a row the PMI has stayed below the 50 mark delimiting growth from contraction.

China **China Manufacturing PMI**

China's manufacturing contraction eased slightly in August, providing some hope that the worst of the sector's slump may be ending. The official manufacturing

purchasing managers' index rose to 49.7, topping estimates and edging closer to the 50 level that would signal activity has stopped contracting. While market reaction to the figures was muted, they offered tentative evidence that targeted efforts to shore up the economy are having some effect.

The nation's manufacturers have been struggling for months because of a slump in global demand and subdued domestic spending. Policymakers have so far been reluctant to roll out massive stimulus, with some economists suggesting the official annual growth target of about 5% is at risk.

China Continues to Gradually Unveil Stimulus Measures

China increased efforts to stimulate the economy and support its currency, as investor concerns over the growth outlook continue. The central bank will reduce the amount of foreign currency deposits banks are required to hold as reserves for the first time this year, the People's Bank of China said Friday. The move came hours after authorities announced fresh stimulus for the struggling property sector and unveiled plans to expand tax breaks for child and parental care and education. The steps are the latest efforts to shore up confidence in the world's second-largest economy, which is sagging under the weight of the persistent housing crisis, waning global demand and rising unemployment. Authorities have so far resorted to a drip-feed of targeted measures, avoiding the bazooka style stimulus approach they deployed during the 2008 global financial crisis amid concerns over elevated debt levels.

Survey reveals only 6% of companies have policies for responsible use of AI

73% recognize the importance of clearly established guidelines

SAN MATEO, Calif., Sept 3, (AP): Conversica, Inc., the leading provider of conversational AI solutions for enterprise revenue teams, has announced the results of its newest survey conducted with business owners and leaders to get a perspective on enterprise preparedness regarding AI Ethics and Corporate Responsibility.

While governing bodies around the world are still considering AIspecific regulations, giving AI providers the power to launch services and products with various degrees of reliability, almost every organization is falling short of formulating in-house, well-defined principles and guidelines for their own responsible and ethical implementation of this technology. But this is inevitable, as business leaders need to get ahead of potential risks and issues given the disruptive possibilities of this technology.

For organizations already adopting AI, a whopping 86% agree on the critical importance of having clearly established guidelines for the responsible use of AI; the percentage was 73% among all respondents.

However, only 6% of companies have policies in place for the responsible use of AI. And among organizations planning to adopt AI in the next 12 months, it's even lower: 5% have policies.

One in five business leaders at companies that use AI have limited or no knowledge about their policies concerning critical AI issues including security, transparency, accuracy, and ethics. The main concerns for companies who adopted AI are: the lack of transparency (22%), false information (21%), and the accuracy of data models (20%).

The survey data shows that companies that already utilize AI or those with plans for its adoption within a year are more likely to acknowledge the importance of having clear ethical guidelines for the responsible use of the technology.

86% of business leaders at organizations already adopting AI say that having AI ethics policies in place is crucial, compared to 73% of the overall group. However, despite being more likely to recognize the importance of these policies, only 5% of the leaders at companies adopting AI currently have clear guidelines in place.

One in five business leaders at companies who use AI have limited or no knowledge about their company's policies concerning the critical issues associated with the use of AI including security, transparency, accuracy, and ethics. Even more alarming, 36% claim to be only 'somewhat familiar' with these issues. This is a widening risk factor that businesses will have to address in the near future, especially those already using AI, as they likely are already experiencing the challenges and opportunities posed by this technology.

"From an enterprise perspective, these figures are concerning, especially considering the vast array of AI products and services expected to become available in the coming years and the potentially significant impact they will have on the future of business," said Jim Kaskade, CEO of Conversica. "This could represent a problematic trend for companies that haven't started planning to enforce responsible and ethical use of AI. Business leaders must get ahead of these issues now."

According to respondents, the most challenging aspects of making informed decisions about the use of AI in their companies are the lack of resources for data security and transparency (43%), and difficulty with finding a provider that has ethical standards that are aligned with those of the company (40%).

"The main elements business leaders should be looking for are the safe, brand-protective, and compliant use of AI that protects their end users. The minimum AI factors include governance, diverse and representative training data, bias detection and mitigation, transparency and accuracy," said Kaskade. Within the following year, business

Within the following year, business leaders said they intend to use AI for 'external engagement', i.e. customer service/support, and marketing/sales outreach (39%). 'Insights' including fraud detection, data analytics, and predictive modeling came in at a close second (36%).

Currently, the top concerns about AI vary according to where their companies are in adopting the technology. Among those that have already adopted the technology, the top three concerns about its use are the lack of transparency (22%), the accuracy of data models (20%), and false information (21%).

Respondents whose companies had no plans to adopt AI-powered services in the next year mostly said they don't have any concerns about AI (29%). For the respondents who did express a concern, their top choice was 'legal implications, patent infringements, plagiarism, and copyright violations' (11%).

When asked to what extent they viewed false information generated by AI as a significant concern for their company, 77% of total respond-

ents rated this as either 'Concerning' or 'Very concerning.' This figure was higher – 88% – for respondents whose companies already have AIpowered solutions in place, indicating that business leaders with more business experience with AI have better awareness of the possible brand risks associated with improper usage.

When it comes to employee use of popular AI-based tools like ChatGPT, the majority of respondents (56%) said that their company either already has rules in place, or is considering implementing a usage policy.

"When we talk about the use of AI, disclosure is power. The more companies are transparent and upfront about how they use AI, deploy vigilant systems, and include humans in the loop, the more they can significantly reduce the risks associated with its adoption and protect their brands, employees and end users," added Kaskade.

The survey was conducted online using a random sample of 500 business owners and leaders within the United States by SurveyMonkey on behalf of Conversica in July 2023.

The Kremlin refused to renew the grain agreement six weeks ago. The deal - brokered by the United Nations and Turkey in July 2022 - had allowed nearly 33 million metric tons (36 million tons) of grain and other commodities to leave three Ukrainian ports safely despite Russia's war.

However, Russia pulled out after claiming that a parallel deal promising to remove obstacles to Russian exports of food and fertilizer hadn't been honored.

Moscow complained that restrictions on shipping and insurance hampered its agricultural trade, even though it has shipped record amounts of wheat since last year.

Since Putin withdrew from the initiative, Erdogan has repeatedly pledged to renew arrangements that helped avoid a food crisis in parts of Africa. the Middle East and Asia. Ukraine and Russia are major suppliers of wheat, barley, sunflower oil and other goods that developing nations rely on.

The Turkish president has maintained close ties to Putin during the 18-month war in Ukraine. Turkey hasn't joined Western sanctions against Russia following its invasion, emerging as a main trading partner and logistical hub for Russia's overseas trade

NATO member Turkey, however, has also supported Ukraine, sending arms, meeting Ukrainian President Volodymyr Zelenskyy and backing Kyiv's bid to join NATO.

Erdogan angered Moscow in July when he allowed five Ukrainian commanders to return home. The soldiers had been captured by Russia and hand-

signed seven min tracts Thursday amounting to \$6.5 billion in investment, in the biggest such round of deals since seizing power two years ago.

The seven contracts are with locally based companies, many of whom have foreign partners in countries including China, Iran, and Turkey. They include the extraction and processing of iron ore, lead, zinc and gold in four provinces: Herat, Ghor, Logar and Takhar.

A statement on the contracts from Deputy Prime Minister for Economic Affairs Abdul Ghani Baradar Akhund gave few details, but said they would create thousands of jobs and significantly improve the economic situation of the country.

Adani Group's stocks, financials unaffected by misleading reports

AHMEDABAD, India, Sept 3: The misleading reports on Adani Group, India's largest critical infrastructure developer that has undertaken several projects which are of strategic priorities for the country's development have been unsuccessful in having any substantial impact on the group's business performance as well as its ability to create shareholder value.

The Adani Group's stocks have rebounded strongly since the release of a short-selling report in January 2023. Four of the group's largest companies-Adani Enterprises, Adani Ports, Adani Green, and Adani Power-have gained over 100% from their lows. Adani Ports, the most widely held institutional stock in the Adani portfolio, is now trading above its pre-report price. Likewise, Adani Power is also trading above pre-report price levels. Despite the recent reports, the leading group stocks closed in the green on Friday, indicating a lack of trust in these misleading reports

Significant investments by large global institutions in recent months, including a sovereign wealth fund, have bolstered confidence in the group's businesses. It is worth noting that these investors which include Qatar Investment Authority and GQG Partners are repeat investors which were already large shareholders in the group's businesses. Furthermore, none of the long-only investors including France headquartered Total Energies, Abu Dhabi based IHC, Qatar based QIA and US headquartered GQG Capital Partners have exited their investments from the group businesses and have continued to support, some through increased participation. This is because the group has been a huge value creator for each of these investors.

Stake sales to these investors have also enhanced li-

quidity at the promoter level, which can be utilized for strategic priorities. The group has raised nearly USD 10.5 billion through strategic stake sales to long-only investors. Around USD 5 billion is posted in the short-seller report. The Adani Group remains committed to attracting more such investors as part of its 10-year capital program initiated in 2016 to participate in the world's largest and fastest-growing infrastructure development platform.

In addition, the rating agencies have reaffirmed the ratings of all the listed group companies. This has allowed continued market access. In the first quarter of the current financial year alone, the group has raised INR 17949 crore from international as well as domestic banks and capital markets.

The trust and confidence demonstrated by these investors underscore the strength of the group's businesses and its commitment to high governance standards. Financially, the group continues to perform well, reporting record profits in the first quarter of FY24 following the short-seller report. The group's portfolio of listed companies achieved an EBITDA of INR 23,532 crore, a 42% increase year-onyear, almost matching the entire FY19 EBITDA of INR 24,780 crore.

For FY23, EBITDA reached INR 57,210 crore, a 42% YoY increase, with improved debt metrics, boasting a netdebt to EBITDA ratio of three times. The portfolio companies also held INR 42,115 crore in total liquidity.

Importantly, the Adani Group operates within the bounds of the law and under the scrutiny of regulatory authorities in respective jurisdictions. The allegations are based on false information and only targeted to malign the group's image but have no substantial impact on the group's day-to-day operations.

Technology blamed for regulatory difficulties

After outrage over Swift tickets, reform still slow across US



SACRAMENTO, Calif., Sept 3, (AP): When thousands of fans couldn't get tickets for megastar Taylor Swift's summer stadium tour, some diehards paid upwards of 70 times face value to see their favorite artist in person - an outrage that prompted congressional hearings and bills in state legislatures to better protect consumers.

After 10 months, Swift's US tour is finished, but so are most of the meaningful reforms consumer advocates and industry groups had hoped to pass this year. A proposal has so far failed to advance in the US Senate. Legislation in Colorado was vetoed by the Democratic governor at the urging of some consumer groups.

And in California, home to iconic recording studios like Capitol Records and influential clubs like the Whiskey A Go Go and Hollywood Bowl, none of the ticketing proposals will pass this year in the aftermath of an intense lobbying campaign by both industry and consumer groups.

"We should do so much better than this," said Robert Herrell, executive director of the Consumer Federation of California.

The slow progress over changing how tickets should be sold and resold highlights not just the strength of industry opposition, but the regulatory difficulties in a market upended by technology. Gone are the days of standing in line at a box office to find out what seats were available and how much they cost.

Today, nearly all tickets are sold online and downloaded to phones or other devices. Consumers often don't know how much they will pay until just before they click the purchase button and fees and charges, which can sometimes be almost as much as the ticket price, are applied. Venues often don't say how many seats are available for a specific event, according to consumer groups, but instead release tickets in



batches, making consumers spend more out of the mistaken fear they'll miss out.

Some bad actors use software to quickly bulk-buy tickets for resale at much higher prices. They will even sell tickets before they have them, a practice known as "speculative ticketing" that consumer groups say is dangerous and does not guarantee the ticket. Some go so far as to mimic venue websites so consumers believe they are buying tickets directly.

Some states, including New York and Connecticut, have passed bills to ban hidden fees. But all of the major players in the ticketing industry have already agreed to do that, minimizing its impact.

Addressing the other problems have been more difficult. Sharp disagreements among venues, ticket sellers, consumer groups and artists have muddied what may seemingly straightforward consumer rights issues.

Inventory

Artists and venues want to restrict how fans can resell tickets, an attempt to crack down on "the secondary market to sweep the inventory, inflate the price and price gouge our fans," said Jordan Bromley, who sits on the board of the Music Artist Coalition, an advocacy group representing artists.

Consumer groups argue buyers can do what they want with their tickets, including selling them for a profit. That disagreement is partly why Colorado Democratic Gov. Jared Polis vetoed a bill earlier this year, despite the bill also containing consumer-friendly policies like banning hidden fees, price increases and speculative ticket sales. In California, consumer groups have mostly focused their ire on

Live Nation Entertainment, the company that owns Ticketmaster and controls the bulk of ticket sales and venues in the US for touring music artists. But the debate is spreading to artists, major men's professional sports teams like the Los Angeles Dodgers and San Francisco 49ers, and independent venues with capacity for 1,000 people or fewer, including more than 600 in California alone.


Most people are being vocal about "how this is an attempt to shoot at Ticketmaster and Live Nation," said Julia Heath, president of the California chapter of the National Independent Venue Association. "What's actually happening is they are aiming at them, but they are hitting everybody else, too."

The biggest disagreement was over whether to allow teams, venues and artists to restrict how fans could resell tickets they purchased. A bill that would have allowed restrictions on resales passed the state Senate but failed to pass the Assembly this year after drawing concerns from consumer groups.

A bill by Assembly member Laura Friedman would have banned venues and artists from restricting resales. That measure also would have required venues to disclose how many tickets were available for an event to prevent "holdbacks." Ultimately, the bill was changed to remove both of those provisions after attracting strong industry opposition.

"It's been very difficult. It had a very strong and concerted effort from the very beginning lobby against this bill," Friedman said.

California lawmakers have vowed to continue working on the issue next year. But by then, the memory of the outrage over Taylor Swift's concern tickets will have likely faded, depriving consumer advocates of the public pressure they had hoped would spur change.

LONDON: An independent body will unveil plans for a permanent memorial to **Britain's Queen Elizabeth II** in 2026, to mark what would have been the late monarch's 100th birthday, the government said Sunday.

The Cabinet Office said **Robin** Janvrin, Elizabeth's former private secretary, has been appointed as chairman of the Queen Elizabeth memorial committee to consider proposals for a "fitting tribute" to Britain's longest-reigning monarch following her death in September 2022.

The queen died in **Balmoral**, her beloved Scottish castle estate, at 96 years old after 70 years on the throne.

Janvrin and other officials on the committee will consider Elizabeth's life of public service and the causes she supported, and recommend plans for a national legacy program in the late queen's honor.

"It will be a unique challenge to try to capture for future generations Her Late Majesty's extraordinary contribution to our national life throughout her very long reign," said Janvrin, who worked at **Buckingham Palace** in various roles from 1987 to 2007. The recommendations will be

presented to Elizabeth's heir **King Charles III** and the prime minister.

In 1955 Elizabeth unveiled a statue of her father, **George VI**, on The Mall outside Buckingham Palace.

Charles III is King of the United Kingdom and the 14 other Commonwealth realms. (AP)

RENO, Nev: Authorities in Nevada were investigating a death at the site of the Burning Man festival where thousands of attendees remained stranded Saturday night as flooding from storms swept through the **Nevada** desert.

Organizers closed vehicular access to the counterculture festival and attendees trudged through mud, many barefoot or wearing plastic bags on their feet. The revelers were urged to shelter in place and conserve food, water and other supplies.

Filmmaker Fuqua takes 'Equalizer' overseas

Washington's assassin goes to Italy

LOS ANGELES, Sept 3, (AP): Filmmaker Antoine Fuqua has been dreaming about taking the Equalizer abroad for years. The action franchise (very loosely based on a 1980s television series) starring Denzel Washington as the reluctant assassin Robert McCall had rooted itself in humble domestic beginnings, in Boston. But after two films and \$382.7 million in box-office receipts in the past decade, the time seemed ripe to travel.

"Denzel is an international movie star," Fuqua told The Associated Press. "We thought it would be nice to see a man of color in a story that's more international. Why not take this character around the world? Luckily, Sony loved the idea."

And there was only one place that was ever seriously on the list: Italy. Washington, Fuqua said, goes every summer and has since his kids were babies. He loves the culture, the people, the food. He even speaks some Italian.

"He just feels right there," Fuqua said.

And for Fuqua, it was the stuff of filmmaking dreams to get to shoot in Cinecittà Studios in Rome and bump up against cinema history walking where Fellini and so many other greats have before him. In Naples, they found an authentically 1970s New York grittiness that required little to no production design for a pivotal showdown. And on the Amalfi coast, they stumbled on the small village of their, and McCall's, fantasies in the picturesque Atrani.

It's the kind of place you'd believe someone like McCall (or anyone really) might feel immediately tied to and protective of, which is what happens in "Equalizer 3," debuted in theaters Friday. The difference is McCall is more uniquely suited to take on the Camorra. Single-handedly, of course.

"When we went to that small town, we knew that was the place," Fuqua said. "The people were so beautiful, we were sitting around and they would just bring us coffee and espresso. We didn't even ask for it. Or big giant lemons because it was so hot. You fall in love with the people in a town like that." The only complaint, which isn't even really a

complaint, was about the steps. One of the jewels of Atrani is a medieval church perched on the mountainside high above the beach that they decided would be perfect for an important scene between McCall and Dakota Fanning's CIA analyst. But the only way to get there is to climb up over 700 steps. It wasn't a pleasant journey with all the equipment necessary to shoot a scene, but it was a good reminder of purpose for Fuqua and his cinematographer, three-time Oscar winner Robert Richardson. They wanted to show a real place, not a vacation destination.

"It's not a travelogue," Fuqua said. "It's beautiful in the Mediterranean, but for the people who live there it's real life. The fisherman live off what they catch. They live in small houses. They walk up those steps every day."

History

The film brings together a core team with decades of history, including producers Todd Black and Jason Blumenthal. In addition to the "Equalizer" films Fuqua directed Washington in "Training Day," which would win him his first lead actor Oscar, as well as in the recent remake of "The Magnificent Seven."

And Black has produced all of the films Washington has directed as well as several others. It was Washington who introduced Black and Fuqua for the first "Equalizer", which all assumed would just be one film, not a franchise.

"You can't think about franchises, or awards, when you're making a movie. If you're making a movie to win an award, or even to get nominated, or have a franchise, you're dead in the water going in probably," Black said. "Not 100% of the time, but you shouldn't think that way."

Instead, they took it one script at a time and "let the audience decide." The audience, it seemed, liked seeing Washington as McCall more than once. Both the first and second film made over \$190 million each against production budgets that didn't exceed \$65 million and Sony was interested in a third. It helped also that Black and Fuqua had become friends, with the priceless trust that comes along with it. Both know that on their films, everything will be safe and controlled, whether that's handling an unexpected fan situation for their star or making sure that it's not too dangerous to shoot in Naples at night.

"We've never had an incident at our movies because we are so vigilant," Black said. "And Antoine really protects actors."

Now Black and Fuqua have found themselves in the unusual situation of having to be the primary voices promoting "Equalizer 3" in lieu of their movie stars, who along with Hollywood writers, are deep into a long strike. But while some films released without the help of a star's late-night anecdotes and red carpet appearances have faltered at the box office over the past month, Black feels confident in "Equalizer 3."

"I have other movies coming out that definitely need my actors to promote them, but everyone knows Denzel Washington is the 'Equalizer," Black said. "We're very, very confident, thanks to Antoine for making a gorgeous film that works and that audiences love so far. We're in really good shape."

Both just mostly miss having Washington by their side for the press tour. The 68-year-old star, Black said, is much "mellower" now than years ago and is fun to do publicity with. Fuqua also observed that McCall in "Equalizer 3" might even mirror a bit where Washington is in his life too. Both are a little more quiet and a little more patient.

"He'll call me and Todd at 4 in the morning to look at the sunrise," Fuqua said. "That wasn't Denzel before. It's nice to see him really stopping and appreciating life."

Afterward, he and a buddy headed to the Margaritaville restaurant in Times Square part of the Buffett business empire - which describes itself as "an islandinspired oasis in the middle of New York

City." When "Margari-taville" played, **Reid Johnson** sang along. By no means a Parrothead, he said, "I'm very familiar with his music.'

Jeanne Fetner had traveled from Northern Virginia with her daughter Avery to visit colleges in New York City when she heard the news. 'Extinction threat'

Study links emissions to polar bear survival

NEW YORK, Sept 3, (AP): Fifteen years after polar bears were listed as threatened, a new study says researchers have overcome a roadblock in the Endangered Species Act that prevented the federal government from considering climate change when evaluating impacts of projects such as oil and gas drilling.

The act requires agencies to ensure projects they approve don't further harm listed species. But a 2008 Department of Interior legal opinion said greenhouse gas emissions didn't have to be considered because the impact from specific pro-jects couldn't be distinguished from that of all historic global emissions.

A study published Thursday in Science's Policy Forum says scientists for the first time are able to directly quantify the impact of human-caused greenhouse gas emissions from specific sources on polar bear cub sur-



It "just seems odd" that polar bears were listed because of the loss of sea ice due to global warming "but emissions have not been considered," said lead author Steven C. Amstrup, chief scientist emeritus at Polar Bears International and a professor at the University of Wyoming.

Polar bears, which occur in 19 subpopulations throughout the Arctic,

BIZ rely on sea ice to hunt for seals. As ice melts, they either end up on land or must swim farther from shore to find ice, which has a state of the sealer and the sealer from shore to find ice, which hurts their ability to find food and leads to long periods of fasting that deplete fat reserves. Human-caused global warming means there are fewer days of sea ice to help build up those reserves and longer fasting periods, and scientists have said most polar bears could become extinct by the end of the century unless warming is curbed.

A 2020 study found the number of fasting days, determined by the number of ice-free days every summer, directly affected cub survival. The new study, authors said, took that a step further and quantified the number of ice-free, fasting days caused by a specific amount of human-caused greenhouse gas emissions - distinct from what's already in the atmosphere.

Projects

"What's really relevant for policy is emissions," rather than atmospheric concentrations, said co-author Cecilia M. Bitz, a climatologist and director of the climate change program at the University of Washington.

Researchers estimated the relationship between how long bears fasted and each gigaton of cumulative emissions, which they said allowed them to calculate the impact of emissions from specific projects on future polar bear cub survival.

"It's basically connecting the dots" from emissions to icefree days to impacts on polar bears, said Amstrup, who believes the method can be applied to many other species, such as sea turtles or coral reefs. He also believes the study makes a case for rescinding the 2008 opinion barring climate considerations, because the Endangered Species Act requires federal agencies to use the best available scientific data.

Interior officials could not be reached immediately for comment

Todd Atwood, a wildlife biologist who leads the US Geological Survey's polar bear research program and was not involved in the study, said it is an important initial step in quantifying the relationship between greenhouse gas emis-sions and polar bear survival, and "is successful in the sense that it provides a framework for beginning to do that."

But the lack of consistent estimates of population trends and survival rates for some polar bear subpopulations, which are distributed over a very large geographic area with differences in sea ice and food sources, can be "problematic when

GOFFSTOWN, N.H., Sept 3, (AP): A group of friends and neighbors meets for a weekly meal, choosing from a special menu of nutritious foods paid for by social programs meant to keep

enjoying butternut squash soup, sandwiches, oats and eggs, they chat and poke fun about families, politics, and the news of the day.

But if you're imagining people gathering for lunch in a senior center, think again.

Long before COVID put a pause on social gatherings, some senior centers were losing their lunch appeal. Others didn't reopen after the pandemic.

Enter this elegant solution that's gained popularity: give some of the federal and state money set aside to feed seniors to struggling restaurants and have them provide balanced meals with more choices, flexible timing and a judgment-free setting that can help seniors get together to

chat and stem loneliness. "Isolation is the new pandemic," said Jon Eriquezzo, president of Meals on Wheels of New Hampshire's Hillsborough County, which runs one such program, in addition to delivering meals to homebound seniors and senior centers. "Knocking on doors and seeing somebody who's homebound is helpful. But getting people out to do this - the mutual sup-

are encouraged.

Even though she's eating out more, LaBarre, 67, lost weight as she prepared for a recent surgery. But what's most important for LaBarre is that she's interacting with others. Retired after years working as a plumbing and heating business office manager, she's concerned about Alzheimer's disease.

"My mother had it, and she was always in the house. She never left," she said. "I'm deathly afraid of it, so I said I guess I'm going to be as social as I can be.'

LaBarre takes a friend - a recent widower who is blind - to a different restaurant in Merrimack, New Hampshire, that participates in the program. "He says, 'I never go out unless you take me," LaBarre said.

Nutrition

From a nutrition standpoint, "we eat better in groups," nutrition consultant Jean Lloyd said. "Studies are out there that we eat healthier surDepartment of Health and Human Services.

Some programs offer grab-and-go options for seniors, grocery dining services, food trucks, hospital facilities, and catering at senior centers and other community locations in addition to or in place of in-house restaurant dining.

The partnerships originate at the local level. The federal Administration for Community Living, which oversees the nutrition services program and provides grants for innovative projects, does not keep data on how many restaurants and people take part and overall costs. It is working on a research project to learn more about them.

Federal funds are distributed to states based on a formula. States coordinate with local area agencies on aging and related nonprofits to distribute funds, and states provide matching funds for some programs. Nonprofits also seek out grants and donations.

2 plead guilty to smuggling: Wildlife traffickers pleaded guilty this week in federal court in California to illegally importing endangered sea cucumbers which are prized in China for food and medicine and as a reputed aphrodisiac from Mexico. Zunyu Zhao and Xionwei Xiao were charged with conspiracy and illegal importation of brown sea cucumbers worth over \$10,000 from 2017 to 2019 and are scheduled to be sentenced in September and November, respectively. Prosecutors haven't said where in the ocean the sea cucumbers were obtained. But the defendants were allegedly found with the smuggled bottom-feeders as they crossed from Mexico into the U.S. at Čalexico. Zhao and Xiao agreed to pay restitution to the Mexican government's environmental protection agency. They could get up to 25 years in prison.

'This is not a critique of them, but ... there's a lot of subpopulations that are really hard to get to," he said, adding that there's not enough funding to do that.

Another expert believes the study shows a correlation between emissions and polar bear cub survival, but not a direct cause and effect.

"I think it takes us a little bit closer to understanding some of those relationships, but ... I just don't know that this paper pushes it over a new threshold," said Andrew Derocher, a polar bear expert and biological sciences professor at the University of Alberta, who believes polar bears are at risk of extinction long-term. "I just don't think that this is the smoking gun that is going to change opinion.'

Dan Rohlf, a professor at Lewis and Clark Law School in Portland, Oregon, and an expert on the Endangered Species Act, said the study makes important advances in understanding the effects of cumulative emissions on polar bears.

'I completely agree with the authors that it's essentially ludicrous that ... we list polar bears as threatened because of climate change, and then we turn around and say we can't consider the impacts of these federal actions that will increase greenhouse gas emissions," Rohlf said. "It makes no sense whatsoever.'

But federal agencies will only consider emissions from one project at a time - each of which would have relatively small impacts - and won't account for cumulative emissions of federal actions, Rohlf said.

Agencies such as the Fish and Wildlife Service have the authority to determine that polar bears already are in jeopardy and that greenhouse gas emissions should be reduced, Rohlf said. Project evaluations then could consider whether emissions are consistent with a goal of reducing greenhouse gases - but "it wouldn't fly politically."

ANCHORAGE, Alaska: Researchers have concluded there is a "rare but real risk" that an earthquake-produced tsunami could inundate parts of coastal Anchorage under certain conditions, a newspaper reported, a shift from the prior understanding of the risk posed to Alaska's largest city.

Previously, researchers said the shallow waters of Upper Cook Inlet would work to diminish the power of a tsunami wave. But that was not based on scientific modeling, said Elena Suleimani, an author of the report and a tsunami modeler with the Alaska Earthquake Center, the Anchorage Daily News reported.

"Úp until now, our understanding of the risk or level of hazard exposure was just anecdotal," Suleimani said.

The findings from the study by the University of Alaska Fairbanks and the Alaska Division of Geological and Geophysical Surveys stem from a first-time effort to model potential tsunami impacts on Anchorage based on various earthquake scenarios, according to the newspaper.

"A rare combination of earthquake magnitude, location, and timing must be satisfied for tsunami wave energy to reach upper Cook Inlet coincident with a natural high tide,' the study states.

Part of the reasoning for the belief that Anchorage was not susceptible was that during a magnitude 9.2 earthquake in 1964, there was no observation of a tsunami in the city. the researchers said. But they found through modeling that the earthquake did produce a 10-foot (3-meter) tsunami one that went unnoticed because it arrived at 2 a.m. during a minus-16-foot (minus-4.9-meter) low tide that resulted in the water level staying below normal high tide levels.

The modeling of future tsunami potential for Anchorage evaluates hypothetical situations involving a quake above 8.5 in magnitude.

Attorneys for Zhao and Xiao did not respond to requests for comment.

After seizing the sea cucumbers at the border, investigators found text messages and images sent between Zhao and Xiao about the transactions. The sea cucumbers are being held as evidence by the California Department of Fish and Wildlife.

"This office is committed to upholding the twin pillars of marine biodiversity and conservation," acting US Attorney Andrew R. Haden said in a statement. "Criminals considering poaching protected species should be aware that this office will diligently investigate, thoroughly prosecute, and seek restitution no matter the species.

Sea cucumbers are in the same family as sea stars and sea urchins and can measure up to 7 feet. Brown sea cucumbers have a smooth body dotted by warts and can grow to 2 feet.

The animals operate as a vacuum on the sea floor, breaking down particles that become part of the ocean's nutrient cycle, said Gordon Hendler, Museum of Natural History in Los Angeles curator of echinoderms.

Prosecutors haven't said where the cucumbers were headed. But a thriving black market frequently gets them to China, where they are a delicacy. They are traditionally served dried or fresh and often braised with fish, vegetables and traditional sauces. They are also sought to treat join pain, prevent cancer and serve as anti-inflammatories - medical uses sometimes validated by science. They're also considered an aphrodisiac.

But the brown sea cucumber - Isostichopus fuscus - is overfished, and that's cause for regulations around their harvest. (AP)

Target

Some restaurant programs target seniors in rural communities. Others benefit people with limited access to transportation. Some are geared toward minority communities.

"Everybody does something a little bit different when they're having a gap in services," said Lisa LaBonte, a nutrition consultant based in Connecticut.

According to information compiled by Meals on Wheels America, one in four Americans is at least 60 years old, with 12,000 more turning 60 every day. Those on fixed incomes also are living longer with less money; one in two seniors living alone lacks the income to pay for basic needs.

Debbie LaBarre looks forward to the weekly gathering with her pals at a bright, bustling restaurant a short drive from her New Hampshire apartment. The special menu at the White Birch Eatery in Goffstown lists the calories, carbohydrates and sodium content for the meals, which have to meet a dietician-approved one-third of the USDA recommended daily requirements for adults under the federal Older Americans Act Nutrition Program. LaBarre and others sign up for the program and swipe credit- and keychain-style cards with QR codes for their allotted meals. There's no charge for the meals, but donations

rounded with people who eat healthy And older adults are a vulnerable population.'

She cited one from 2020 about the health impact of loneliness on seniors. Recently, the US surgeon general noted that widespread loneliness in the US poses health risks as deadly as smoking up to 15 cigarettes daily.


The program focuses on goals of the wide-ranging Older Americans Act - to reduce hunger and food insecurity and promote the socialization, health and well-being of seniors.

Back in the 1980s, the restaurant was considered a little-explored, unpopular option to the traditional meal gatherings at senior centers and church basements. As of early this year, there were at least 26 states where some restaurants and other food providers partnered locally with an area agency on aging or a nonprofit such as Meals on Wheels.

"We get to see people and check in on them and they bring new friends, and we get to meet all new faces, sometimes," said Cyndee Williams, owner of the White Birch Eatery, which opened in March 2020, right before the pandemic shut down everything. It restarted limited operations that summer. "And then, while we have a small profit margin, that helps us, too. It keeps my staff here and working."

Restaurant partnerships in New Hampshire and in states like South Carolina, Iowa, and New Jersey, for example, started as COVID-19 restrictions were being lifted, along with the urgency of curbside pickups. Meanwhile, communities in Massachusetts, upstate New York, and northern California, which have established, pre-pandemic programs targeting rural areas and ethnic communities, are seeing additional restaurants coming on board.

"The pandemic had created an opportunity for us because it just made everyone aware of the need to think in a different way, to not provide services the way they always had in the past," said Edwin Walker, deputy assistant secretary for aging under the



The programs have to adjust to costs of food and labor, which can be challenging. The restaurants are reimbursed, but the funding sources are limited, especially as COVIDrelated emergency money has come to an end.

Donations

"For every meal we serve, we get \$8.11," Eriquezzo said. "The meal costs us \$13. We suggest a \$4 donation. Even if we get donations, we're still short 80 cents.

Restaurants might need to adjust menus, perhaps by offering smaller portion sizes, lowering the maximum monthly meals to save money and more specifically target who is using the meal programs the most.

Still, partnering with the restaurants costs less than contracting with a town hall or a church for the community dining option, said Janet Buls, nutrition director, Northeast Iowa Area Agency on Aging.

Bents Smokehouse & Pub in Westgate, Iowa, population 200, was the first restaurant in Bul's territory to sign on after cooking meals for Meals on Wheels recipients during the worst of the pandemic.


Before any of that happened, though, times were tough.

"We would sit here all day and not even have 100 bucks in the till," restaurant owner Sheila Bents said. 'They saved us."

And it's saving seniors, too.

Robert Mays, 65, started going with his wife and mother-in-law to the The Lizard's Thicket in Columbia, South Carolina, for weekly "Senior Lunch Bunch" gatherings.

"It allowed people living in the same neighborhood that normally don't see one another and even different races to come together to find out that we're way more alike than we are different," he said.



In an email, Sanborn said he strongly disagrees with the commission's findings and welcomes the chance to challenge them at a hearing.

Rookie Aberg stakes Cup 'claim' with title

CRANS-MONTANA, Switzerland, Sept 3, (AP): Swedish rookie Ludvig Aberg surged to a twoshot win at the European Masters on Sunday and right into the Ryder Cup picture for Europe when the six captain's picks are announced Monday.

Aberg stunned long-time leader Matt Fitzpatrick by reeling off four straight birdies from Nos. 14 to 17 to card a 6-under 64 for a 19-under total of 261.

Fitzpatrick faded to a tie for third, three shots back, though secured direct qualification for the Ryder Cup team to face the United States on a year-long points rank-ing. So too did Robert MacIntyre.

The 23-year-old Aberg turned professional only in June after being named the best college player in the United States for a second straight year at Texas Tech University.

In the sun-bathed Swiss Alps on Sunday, Aberg made himself a great option for Europe captain Luke Donald for the Ryder Cup in

four weeks' time in Rome, Italy. "I figured a win would put me in a good position," Aberg acknowledged. "Honestly, I've done a pretty good job of not thinking about it too much.'

Aberg's potential for the Ryder Cup was clear on the PGA Tour since June - four top-25 finishes including tied for fourth at the John Deere Classic. He also was tied for fourth at the Czech Masters last weekend.

Still, victory on Sunday looked unlikely until deep into the final hour of play at Crans-sur-Sierre club. Fitzpatrick had led by three strokes when he birdied the par-5 14th but just 30 minutes - and back-to-back bogeys - later, a fiveshot turnaround left Aberg clear by two.

"It's a pretty surreal feeling to be honest," Aberg said of his first win after just 75 days as a pro golfer that earned him a 425,000 euros check (\$458,000). "I always

Pegula outlasts Svitolina, faces Keys

Alcaraz's variety makes it tough to choose shots

NEW YORK, Sept 3, (AP): Jessica Pegula and Madison Keys kept noticing their names near each other in tournament draws this summer.

"We were like, 'I think the world just wants us to play,' Pegula said.

At the U.S. Open, they finally will. Pegula beat Elina Svitolina 6-4, 4-6, 6-2 on Saturday, setting up a fourth-round matchup against the No. 17-seeded Keys.

Pegula, the No. 3 seed, is still trying to advance beyond the quarterfinals of a Grand Slam tournament. First, she'll have to get by the 2017 runner-up in Flushing Meadows who also needed three sets to move on.

Keys came back to eliminate No. 14 Liudmila Samsonova 5-7, 6-2, 6-2. Pegula and Keys could have met

early in both Montreal and Cincinnati, but Keys had to withdraw with a hip injury in Canada - where Pegula won the title - and lost her opening match in Ohio. So they've still played only

once, a victory for Pegula last year in San Diego.

"I think we kind of are opposites a little bit," Keys said. "But I mean, she's been playing some amazing tennis the past few years.'

Other winners on the women's side Saturday included No. 2 Aryna Sabalenka, who routed Clara Burel 6-1, 6-1, and No. 23 Zheng Qinwen of China, who outlasted Lucia Bronzetti 6-3, 4-6, 6-4.

Pegula then found herself in a tough test with Svitolina, the No. 26 seed from Ukraine who reached the U.S. Open semifinals in 2019. It was tied 2-2 in the third set before the 29-yearold from Florida broke serve to start a run of four straight games to win the match.

That put her in the fourth round of the U.S. Open for the second time. Pegula had her best result at the tournament in 2022, falling to eventual champion Iga Swiatek in the quarterfinals. She's gone that far in each Grand Slam tournament but is still seeking to reach the final four.

"She's been showing great results," Svitolina said. "I think she's ready to do an extra step forward."

Ever since Carlos Alcaraz was 12 or so - OK, not forever ago, considering he's still just 20 - he made sure variety was a key element of his game.

Back then, he explained, there were so many options at his disposal that he might encounter a bit of trouble figuring out which to employ. And, he acknowledged, that can even be the case to this day.

Alcaraz was by no means perfect during a 6-2, 6-3, 4-6, 6-3 victory over the 26th-seeded Dan Evans in the U.S. Open's third round on Saturday - there was that wayward set, after all - but the defending champion produced enough moments of brilliance to keep himself smiling and his many fans in New York roaring in approval. To hear the No. 1-seeded Alcaraz explain it, "a lot of different" possibilities enter his mind in the midst of a point - "the dropshot, big forehand, go

to the net, multiple things" - before he selects which stroke to try. It can make things "difficult" on occasion, he said.

"Most of the time, I find the right one," the Spaniard said, "but sometimes I struggle to hit good shots because of that.

His opponent in Arthur Ashe Stadium on Saturday noticed.

"If anything, he probably plays too many shots," Evans said. "He let me out of jail a few times playing the wrong shot, which was good for me."

But there also were those "How did he do that?!" highlights that Alcaraz conjures up with frequency. One in particular helped swing

Saturday's match his way for good. Evans was seemingly in control of what would become a 12-stroke point, sending Alcaraz scrambling to his left for a defensive backhand. On his follow-through, Alcaraz stumbled a bit, nearly tumbling to the blue court. But he gathered himself and quickly switched direction, sprinting to his right with seven lengthy strides before sliding wide of the doubles alley as he flicked a down-the-line forehand.

The ball caught the back of the baseline for a winner that converted a break point for a 4-2 edge in the fourth set. Evans chucked his racket toward the bottom of the net, grimaced and placed his hands on his hips. Alcaraz raised his arms, using his left index finger to make a "No. 1" gesture. "Took the wind out my sails," Evans said.

to overturn a two-set deficit to win in a match that ended a tad after 1:30 a.m. on Saturday, Alcaraz progressed to the fourth round at Flushing Meadows for the third consecutive year.

Alcaraz improved to 14-1 over his nascent career in New York and is trying to become the first man to win two titles in a row in New York since Roger Federer took five straight from 2004-08.

Matches Monday that will put the winner in the quarterfinals include No. 3 Daniil Medvedev, who won a second straight late-night match, against No. 13 Alex de Minaur; No. 8 Andrey Rublev against Jack Draper, a 21-yearold left-hander from Britain who has never been this far at a major, and No. 6 Jannik Sinner against No. 12 Alexander Zverev.

The women's fourth round No. 2 Aryna Sabalenka against No. 13 Daria Kasatkina, No. 5 Ons Jabeur against No. 23 Zheng Qinwen, and No. 9 Marketa Vondrousova against unseeded American Peyton Stearns.

Sabalenka - who won the Australian Open in January and can overtake Iga Swiatek at No. 1 in the WTA rankings depending on their results at the U.S. Open - defeated Clara Burel and has dropped a total of just 12 games through three matches so far.



Pérez, Sainz complete podium

Max wins Italian GP for record 10th straight victory

MONZA, Italy, Sept 3, (AP): Runaway Formula One leader Max Verstappen secured a record 10th straight win with victory at the Italian Grand Prix on Sunday, with a Red Bull one-two on Ferrari's home track.

"That's a nice stat," Verstappen said on team radio immediately after the win.

Another flawless performance from the two-time defending champion saw Verstappen beat teammate Sergio Pérez by 6.802 seconds. Carlos Sainz Jr. was third, 11.082 behind Verstappen and just ahead of Charles Leclerc as the two Ferrari drivers battled for the final spot on Monza's iconic podium.

"I never would have believed that was possible but we had to work for it today and that made it definitely a lot more fun," Verstappen said.

Verstappen had started second, behind Sainz, but eventually got past him at the start of lap 15 and from then on - just like the rest of the season - no one could match the Red Bull pace.

The record became all but a foregone conclusion as Verstappen began to pull away, swiftly building an advantage of more than five seconds five laps later.

"Very tough, very tough. It can't get any tougher than it was today," Sainz said. "To keep up with the Red Bulls, I paid the price with the rear tires but I did everything I could to defend."

The victory also saw Verstappen increase his huge championship lead to 145 points in a crushingly dominant season for the 25-yearold Dutchman.

Verstappen has won 12 of the 14 races for unbeaten Red Bull and matched Sebastian Vettel's F1 record of nine straight victories last weekend at the Dutch GP. Pérez has the other two victories.

It was a second straight victory for Verstappen at Monza. Before last year he had never finished the Italian GP higher than fifth.

His record bid got off to a slightly delayed start, however, as Yuki Tsunoda went off on the formation lap with a suspected power unit failure. There had to be an aborted start and, with the drivers effectively doing three formation laps, the race was shortened by two laps.

Ferrari was hopeful of its first win at the Temple of Speed since 2019 and Sainz, who turned 29 on Friday, got off to a great start as he held off Verstappen into the first corner - much to the delight of the thousands of passionate red-clad tifosi.

Sainz managed to defend several attempts by Verstappen to get past in a tense battle between the two. That didn't last long, however, as Sainz locked his brakes going into the first chicane on lap 15 and that

allowed Verstappen to get past him on the exit and pull away.

Sainz was left to fend off Perez for second place but lost that battle too with four laps remaining and was then forced to fight hard again to keep Leclerc behind for the final podium place.

George Russell was fifth, ahead of Mercedes teammate Lewis Hamilton, who kept his place despite a five-second penalty for colliding with Oscar Piastri.

Alex Albon was seventh with Lando Norris, Fernando Alonso and Valtteri Bottas completing the top 10.

USA qualify for Paris Olympics

MANILA, Philippines, Sept 3, (AP): For the first time in 25 years, Italy is going to the quarterfinals of the Basketball World Cup. Latvia is going for the first time ever, and Serbia is on its way there as well.

So is Canada - which ousted defending champion Spain to claim the last spot.

The final spots in the knockout round were decided Sunday, with Italy, Latvia, Canada and Serbia grabbing their quarterfinal spots.

Slovenia, Germany, Lithuania and the U.S. all qualified on Friday. And Lithuania pulled off a stunner on Sunday, topping the U.S. in its second-round finale.

Stefano Tonut and Giampaolo Ricci each scored 15 points and Italy reached the World Cup quarterfinals with win over Puerto Rico on the final day of second-round play at FIBA's biggest tournament.

Italy (4-1) will play either the U.S. or Lithuania in Tuesday's quarterfinals in Manila. The Italians are assured of their best World Cup finish since placing sixth in 1998. They were ninth in 2006, 10th in 2019 and didn't qualify in 2002, 2010 and 2014.

Simone Fontecchio added 12 points and 12 rebounds for Italy, and Luigi Datome scored 11. Italy used a 15-0 run in the first quarter to take some control, wound up losing that lead in the third quarter, rallied to take a slight edge into the final period and pulled away from there.

Tremont Waters scored 13 points and had nine assists for Puerto Rico (3-2), and Jordan Howard scored 11. Puerto Rico was bidding for its first World Cup quarterfinal trip since 2002.

Indonesia, Shai Gilgeous-Alexander scored 30 points and Canada rallied from 12 points down entering the final quarter to not only clinch a quarterfinal berth but grab a spot in the Paris Olympics as well. Dillon Brooks scored 22 points and RJ Barrett added 16 for Can-

ada (4-1), which watched Alex Abrines' shot from near halfcourt bounce off the rim as time expired.

Willy Hernangomez scored 25 for Spain (3-2), Santi Aldama had 20 and Abrines added 11.

At Jakarta, Latvia - in the World Cup for the first time - ran away from Brazil in the second half to turn a close game into a rout and made the quarterfinals.

Andrejs Grazulis scored 24 for Latvia (4-1) and Arturs Zagars added 17 for the winners, who will play Germany or Slovenia in Wednesday's quarterfinals. Latvia led by three at the half, then outscored Brazil 36-21 in the third quarter.

Davis Bertans scored 14 for Latvia, which outscored Brazil 48-21 from 3-point range. Bruno Caboclo scored 20 for Brazil (3-2), which was seeking its third quarterfinals trip since 1990.

Bogdan Bogdanovic scored 20 points and Serbia advanced to the quarterfinals, a result that eliminated the Dominican Republic and clinched an Olympic berth for the U.S.

Servia (4-1) had six players in double figures, with Vanja Marinkovic and Nikola Milutinov scoring 16 and Filip Petrusev adding 14.

The Dominican Republic (3-2) was led by Karl-Anthony Towns with 25 and Jean Montero with 15. Serbia shot 66% in the game.

Lithuania made its first nine 3-pointers and knocked off the U.S. in a matchup of teams that entered the day unbeaten and already had their quarterfinal berths secured.

Anthony Edwards scored 35 points for the U.S.

Dennis Schroder scored 24 points and Germany (5-0) rolled past Slovenia in a matchup of teams that knew they were headed to the quarterfinals.

Daniel Theis added 14 points and seven rebounds for the winners.

Luka Doncic led Slovenia (4-1) with 23 points and Klemen Prepelic had 12. Germany outscored Slovenia 45-21 on 3-pointers.

Patty Mills scored 19 points and Australia had five players reach double figures in a relatively easy

Dante Exum had 18, Duop Reath added 16, Josh Giddey scored 15 and Joe Ingles finished with 10 for the Boomers (3-2).

Both teams were previously eliminated from advancing to the quarterfinals. Australia, the Olympic bronze medalist two summers ago in Tokyo, saw its hopes end Friday with a 90-81 loss to Slovenia. But Australia achieved one goal at this World Cup: clinching a spot in next summer's Paris Olympics.

Playing in its first World Cup, Georgia was led by Goga Bitadze with 20. Thaddus McFadden had 18 points and nine assists for Georgia (2-3).

Nikola Vucevic scored 19 points, Dino Radoncic added 12 and Montenegro (3-2) ended its World Cup by hanging on for a win in a classification round game.

Ioannis Papapetrou had 16 points for Greece (2-3) in its finale, while Lefteris Bochoridis and Kostas Papanikolaou each scored 13.

LIVERPOOL, England, Sept 3, (AP): Arsenal underlined their title credentials after they beat Manchester United 3-1 in the Premier League at

the Emirates Stadium on Sunday. The visitors drew the first blood through Marcus Rashford in the 27 minute but their celebration was short lived as Arsenal struck back in less than a minute time through Martin Odegaard.Decan Rice and Gabriel Jesus completed the comeback deep in injury time.

Mohamed Salah put aside intense speculation about his future by scoring again for Liverpool in its dominant 3-0 win over Aston Villa that made it three straight victories in the Premier League for Jürgen Klopp's team on Sunday

Salah, the subject of a reported bid on Friday worth 150 million pounds (\$188 million) by Al-Ittihad in Saudi Arabia, tapped home a finish in the 55th minute to round off the scoring at Anfield as Liverpool built on recent wins against Bournemouth and Newcastle.

Dominik Szoboszlai drove in the opening goal in the third minute before Villa right back Matty Cash unwittingly guided the ball into his own net in the 22nd after Darwin Núñez hit the post and the ball rebounded out.

Liverpool stayed unbeaten and on 10 points from four games heading into the international break. By the time the Premier League returns in two weeks, Liverpool fans will be hoping Salah is still at the club.

With the transfer window not closed for Saudi clubs until Thursday, Al-Ittihad could yet come back with an even bigger bid for Salah, the Egypt superstar who is the world's most high-profile Arabic player. Liverpool insists the 31-year-old forward is not for sale but its resolve could still be tested.

Salah has scored two goals so far this season and Liverpool's attack is purring, with seven goals in its last three games. There could have been many more Sunday as the Reds repeatedly got in behind Villa's high line that was also exposed in a 5-1 openinground loss at Newcastle.

The negative for Liverpool was the sight of Trent Alexander-Arnold limping off in the 71st minute with a leg muscle injury that could see him withdrawn from England's squad for the upcoming games against Ukraine and Scotland.

It was Alexander-Arnold - captain for the day in the absence of the suspended Virgil van Dijk - who sent over the corner from the right that missed everyone in the area and fell to Szoboszlai, who smashed the ball left-footed and diagonally into the bottom corner. It was the Hungary captain's first goal since joining Liverpool from Leipzig in the offseason.

SOCCER

Cash scored twice for Villa at Burnley last weekend, and again in Europa Conference League qualifying in midweek, but this time found his own net after Núñez raced onto Salah's pass and struck the post.

Joel Matip headed wide from pointblank range and Núñez hit the crossbar after chipping goalkeeper Emi Martinez as Liverpool threatened more goals.

Núñez, who started after two goals as a substitute last weekend against Newcastle, was narrowly wide with a volley from Salah's cross and the two then linked up for the third goal. Núñez glanced on Andrew Robertson's corner and Salah was at the back post to tap in.

start, with all five goals coming in the second half.

A superb run and cross from Tyrick Mitchell down the left saw Edouard picked out, and the striker got between two defenders to steer the ball past Sa and give Palace a 56th-minute lead.

Wolves hit back in the 65th when Hee-chan made an immediate impact shortly after his introduction from the bench when he made contact with Neto's superb free kick with his shoulder. The ball looped over Johnstone and into the net.

But Palace always looked the more likely to score with Eze becoming all the more influential, and it was the playmaker who made it 2-1 in the 77th. His superb touch and finish from Jean-Philippe Mateta's flick put him oneon-one with Sa and Eze prodded in a finish on the stretch.

Six minutes later, Edouard wrapped up the win after Mateta's back-heel fooled the Wolves defense, with the former Celtic striker burying the ball past Sa.

Eze almost added a fourth for Palace after another jinking run into the box, but Sa saved well to his left and palmed the ball wide of the post.

Wolves pulled a goal back in the sixth minute of stoppage time when Neto's cross was met in the box by Cunha.

Evan Ferguson's first career hat trick helped Brighton cap a memorable week with a 3-1 win over Newcastle that inflicted a third straight league defeat on the visitor

The 18-year-old Irish striker curled home his second goal from range to add to a simple first-half finish. Ferguson completed his treble with the aid of a hefty deflection off Fabian Schar.

The win came a day after Brighton was drawn to face Ajax, Marseille and AEK Athens in the club's first Europa League campaign. The club pulled off a transfer coup on Friday by signing Ansu Fati on loan from Barcelona, and has won three of its opening four league games following last weekend's loss to West Ham.

Newcastle lost only five league games in all of last season but this loss came on the heels of defeats to Manchester City and Liverpool - which staged a late comeback at Anfield last weekend with 10 men.
