To the Minister of Commerce ... also 'Knowledge has come to you' again

THE industrial sector is of great importance to any country due to its contribution to the nation's self-reliance in terms of providing necessities for its citizens, and also for solving unemployment problems.

The more effective and well-established the industrial sector is, the greater strength it gives the economy in the face of crises, as well as to the trade movement, which depends on local consumption. It also enhances trade exchange with countries.

Here we turn to the Minister of Commerce Mohammed Al-Aiban, who occupies a sensitive position because his ministry represents the backbone of the state through its supervision of commercial and economic activities in the country, and the provision of goods and services.

In the absence of a Ministry of Industry, it supervises this sector, which is sensitive to national security. It is also as important as the internal, defense, and financial sectors; in fact, its role exceeds the other three in protecting food and indus-

Your Excellency the Minister, justice for people begins with eliminating injustice against them, starting with providing job opportunities and social protection for citizens. In this regard, your role is great, especially when reconsidering the decisions of the Public Industry Authority that obstruct the development of this important sector

Given the fact that the ministry is under the control of importing merchants, who are fighting local industries from needlework to cars, your role should be to work on revitalizing the local industries, manufacturing and others, and even building integrated industrial cities, as well as not allowing merchants to expand by exploiting commodity subsidies in order to accumulate their wealth. These billions spent on this sector can build dozens of farms and factories. That is why we said yesterday to your colleague, the Minister of Finance, that a bag of rice will not enrich the poor, nor will a box of tea.

Rather, citizens want security of livelihood. This can only be achieved by lifting subsidies on goods and services, and allocating financial brackets to the needy, retirees, and those with low limited incomes, as well as not enriching merchants and the rich through subsidies. This is because waste has become an established characteristic of governmental and commercial behavior. We do not know whether the entire quantities reach the stores and the needy, or whether a major fraud operation is taking place with them, as is the case with projects that cost public funds many times above their actual cost.

In all countries of the world, the ministries of Commerce and Industry work to stimulate local production by facilitating procedures and providing services to stakeholders. This is why the UAE. for example, has become an industrial hu, as has Saudi Arabia, and they now have many factories. including medicines, that are exported to the Arab

Here's a look at the latest developments.

Daniel, an unusually strong Mediterranean storm, caused deadly flooding in towns across eastern Libya, but the worst-hit was Derna. As the storm pounded the coast Sunday night, residents said they heard loud explosions when two dams outside the city collapsed. Floodwaters washed down Wadi Derna, a valley that cuts through the city, crashing through buildings and washing people out to sea.

A U.N. official said Thursday that most casualties could have been

"If there would have been a normal operating meteorological service, they could have issued the warnings," World Meteorological Organization head Petteri Taalas told reporters in Geneva. "The emergency management authorities would have been able to carry out the evacuation.

The WMO said earlier this week that the National Meteorological Center had issued warnings 72 hours before the flooding, notifying all governmental authorities by email and through media.


Officials in eastern Libya warned the public about the coming storm but did not suggest the dams could collapse or present an evacuation plan.

The startling devastation reflected the storm's intensity, but also Libya's vulnerability. Oil-rich Libya has been divided between rival governments for most of the past decade - one in the east, the other in the capital, Tripoli - and one result has been widespread neglect

The two dams that collapsed outside Derna were built in the 1970s. A report by a state-run audit agency in 2021 said the dams had not been maintained despite the allocation of more than 2 million euros for that purpose in 2012 and 2013.

Libya's Tripoli-based Prime Minister Abdul Hamid Dbeibah acknowledged the maintenance issues in a Cabinet meeting Thursday and called on the Public Prosecutor to open an urgent investigation

into the dams' collapse. The disaster brought a rare moment of unity, as government agen-

UAE nets over \$1b Captagon

DUBAI, Sept 14, (AP): Police in Dubai seized 86 million tablets of the amphetamine known as Captagon hidden in a shipment of doors and decorative building panels, authorities said Thursday, estimating its street value at just over \$1 billion.

The bust comes as sales of the amphetamine have become a Mideastwide problem during Syria's long war.

A surveillance video released by the Interior Ministry in the United Arab Emirates shows suspects trying to bring the Captagon tablets through Dubai's massive Jebel Ali Port. They were hidden in five shipping containers of doors and panels, with the drugs themselves weighing over 13 tons, authorities said.

The UAE "stands as an impenetrable fortress against any threat aimed at jeopardizing the security and wellbeing of the Emirati society," Interior Minister Sheikh Saif bin Zayed Al Nahyan said in a statement.

Authorities did not identify the arrested suspects but described their operation as an "international criminal organization," without saying the source of the drugs. A Dubai police anti-narcotics official, Maj. Gen. Eid Mohammed Thani Hareb, said the drugs were to be transferred to an unidentified third nation.

The value of the seizure given by authorities put the price of a pill at nearly \$12. Costs can be as high as \$25 a pill in neighboring Saudi Arabia.

Syria has become the world's leading trafficker of Captagon, a highly addictive amphetamine, during the war. Hundreds of millions of pills have been smuggled over the years into Jordan, Iraq, Saudi Arabia and other Gulf Arab countries, where the drug is used recreationally and by people with physically demanding jobs to keep them alert.

The United States, Britain and European Union accuse Syrian President Bashar Assad, his family and allies, including Lebanon's militant Hezbollah group, of facilitating and profiting from the trade.

Rebuilding begins in Marrakech

Many families shelterless

AMIZMIZ, Morocco, Sept 14, (AP): Rachid Alachoun, a 40-year-old plumber, washes clothes on the roof of his home. Half of it remains standing while the other half can be found in piles of rocks visible from the roof.

Alachoun is among the survivors near the epicenter of an earthquake that hit Morocco last Friday. Authorities have reported 2,946 deaths and several thousand injuries.

Though he has to walk through boulders and wires to get to his kitchen or bedroom, he has stayed in his family's home in Amizmiz near the Mellah, the old Jewish quarter. He said the tent that authorities gave them is too small for his entire family. So his life at home goes on.

Chairs in the remnants of the family home are

covered with the dust of broken walls and possessions that are too large to carry out - a washing machine, tables and a fridge - are still trapped inside.

He cooks chicken, carrots and olives in a clay pot on the gas stove in an area he's kept tidy. The situation is especially precarious when aftershocks strike, such as a 4.6-magnitude tremor on Thursday morning.

The Alachouns were told last Saturday that as-

Food and water arrived but they lacked shelter until Tuesday, when authorities allocated them one of about 30 small yellow tents set up in a square near the center of town - one of several encampments near Amizmiz.

"They told us not to come to get supplies and that supplies would come. So we waited," Alachoun's sister, Loubna, said from the coated polyester tent she is sharing with another brother, father, mother and a close family friend.

The Alachouns are among many Moroccans now asking questions about their futures, particularly as nights get colder and winter approaches. Though many villagers have been provided food and water, officials have said it could take five to six years to rebuild towns in the High Atlas and have created a special fund for recovery.

Rebuilding has already begun in parts of the old city of Marrakech, including the old Jewish Quarter, that are frequented by tourists, while efforts in Al Haouz - the province hardest hit by the earthquakes are still focused on immediate humanitarian needs.

People from the region's mountain villages may move before their homes are rebuilt, but the Alachouns are dedicated to staying. Most people in the region identify as part of Morocco's largest indigenous group, Amazigh, and cling tightly to their homeland. The Alachouns doubt that any financial assistance could get them an apartment large enough to house their family in Marrakech, more than an hour away.

Such is the case for many families with small


Until Friday, Naima Ait Brahim Ouali, a house cleaner, lived on the third floor of an apartment building with her five children in Sourejdid, a now-destroyed neighborhood in Amizmiz. She and her daughter fell down the staircase as the earthquake shook their building, ripping the top floor straight off, she said.

Now her entire neighborhood has relocated to a corner of a tent city in the center of town. She worries about the future for her five children - ages 25. 20. 19, 14 and 10 - some of whom had just started school last week.

Her daughters enjoy studying Arabic, with one passionate about reading the Quran. Her sons have penchant for drawing and theater. But now fear strikes around 11 p.m., the time the earthquake hit last Friday.

"They saw death," she says of her five children, including a daughter who has experienced night-

Plans for 30 million religious tourists a year

Saudi's bank on the call of prayer

Billboards line the Umm Al Qura highway leading to the Grand Mosque in Makkah, displaying manicured public spaces, glassfronted stores and sleek towers. It's part of a \$26 billion project to bring more Muslims to the holy city's high-end hotels, residences, retailers and restaurants.

Makkah is being rapidly pushed to an even grander scale. An ambitious plan to reshape the economy aims to bring in more than 30 million religious tourists a year by 2030, and for tourism to contribute up to \$80 billion, or 10% of GDP, as the kingdom reduces its reliance on oil.

The government is homing in on religious tourism because the demand already exists. Saudi Arabia is home to Islam's two most sacred cities, Makkah and Madinah.

Muslims around the world are required by their faith to perform the Hajj pilgrimage to Makkah at least once in their lives if they are able. Millions more come for the Umrah, a lesser pilgrimage that can be done any time during the year. Together, the Hajj and Umrah drew some 20 million pilgrims in 2019, before the pandemic.

Neighboring Dubai and Qatar can never compete with this offering, even as they host global events and major sporting competitions. Tourism currently contributes 4.45% to Saudi Arabia's GDP. Although there are no official figures on how much revenue the Haii

though there are no official figures on how much revenue the Hajj generates, it is considered to be upward of \$12 billion.

"Saudi Arabia never has to worry about foreign competition, as

there is only one Makkah and only one Madinah," said Bahrain-based economist Omar Al-Ubaydli. "This is a great foundation for building a successful income source. Enabling people to shop, visit museums, attend conferences while performing Umrah is a great strategy for income growth."

For more than a decade, furious development has transformed the center of Makkah with fields of towers surrounding around the Grand Mosque, housing the Kaaba, Islam's holiest site. Facing the mosque's main entrance is the centerpiece, the monumental Makkah Royal Clock Tower, the fourth tallest building in the world. Makkah is an alternative spelling of the city's name.

Hotels within walking distance or a view of the Grand Mosque charge eye-watering amounts during the Hajj and Ramadan seasons. The best spots are already taken by a Pullman, a Raffles, and other luxury hotels.

So companies are targeting areas northwest and northeast of the

Grand Mosque. And Umm Al Qura Road is ripe for development.

Behind the bright billboards along the highway are a jumble of cranes, craters and piles of grey rubble in the ongoing construction of the \$26 billion Masar Makkah development project. The plan is to lay down a 3.5-kilometer-long (2-mile) swath of hotels, residential buildings, parks and malls leading up to the Grand Mosque area. Local media report that the company leading the project demolished thousands of homes and paid out more than \$2.9 billion in compensation to their residents over a period of five years.

On the other side are low-rise and dingy pilgrim lodgings, budget eateries, and tiny stores crammed with pilgrimage essentials -- a world away from the shiny and upscale future for Makkah envisioned by Saudi Arabia. Scores of pilgrims, mostly from developing countries, sit on the sidewalks. The curb appeal improves the closer you get to the Grand Mosque.

The Associated Press reached out to several Saudi officials and construction firms with detailed questions about religious tourism and plans to develop Makkah's hospitality sector but received no response.

At a press conference in Makkah, Hajj Ministry spokesman Ayedh al-Ghweinim spoke about the work taking place, saying the government "is always keen to develop the Hajj and Umrah experience and improve the services provided." He said development is ongoing "to keep pace with the numbers" of pilgrims coming from abroad and "provide an exceptional experience."

Twenty-seven projects, each valued at \$25 million or more, are underway in Makkah, according to the Global Data Construction Intelligence Centre. Of these, 13 are in the hospitality, retail and residential sectors, and the rest in transport.

Other multi-billion-dollar projects of tower complexes, like Jabal Omar and Thakher Makkah, talk about "lively, all-inclusive communities" and "balanced spirituality."

The attempt to blend religious tradition and innovation requires sensitive handling by Saudi Arabia's leadership, as well as the developers and companies moving in. Makkah is revered by Muslims around the world as the place where the Prophet Muhammed (PBUH) was born and preached 1,400 years ago. Any perceived harm to the sanctity of the holy sites, even unintentional, could upset the faithful.

At the same time, Saudi Arabia's leadership wants to emphasize the modern, new Makkah by showing off the grandiose new construction and projects in the pipeline. At the 24-hour Starbucks near the Grand

Security intensified at roads around schools

KUWAIT CITY, Sept 14: In conjunction with the Ministry of Interior's preparations for the upcoming academic year, Acting Prime Minister and Minister of Interior, Sheikh Talal Khalid Al-Ahmad Al-Sabah, chaired a security meeting at the Ministry of Interior's headquarters, reports Al-Rai daily.

During the meeting, which was attended by assistant undersecretaries and Lieutenant General Anwar Al-Barjas, the Undersecretary of the Ministry of Interior, Minister Al-Khaled received a comprehensive briefing on the Ministry of Interior's field sectors' readiness for the 2023-2024 academic year and the coordination mechanisms among them. He also examined the deployment strategy for security and traffic operations across the country, including the deployment of both stationary and mobile patrols on main and secondary roads, intersections, and in the vicinity of educational institu-

The Acting Prime Minister and Minister of Interior emphasized the importance of promptly addressing traffic congestion, maintaining a firm stance against any violations, and fostering a culture of courtesy and assistance to motorists to ensure their safety on the roads.

He directed the intensification of security presence on highways and all key intersections leading to residential areas, as well as near educational institutions, to prevent traffic disruptions and unauthorized parking in front of schools. He also called for the consistent presence of supervisory and leadership personnel to monitor security and traffic conditions

Furthermore, he stressed the importance of conducting awareness campaigns for vehicle drivers and guardians to promote compliance with traffic regulations, rules, and safe road behaviors that enhance road user safety.

He revealed that the construction of a customer service office building in Mutla'a will also begin soon in order to make it easier for citizens and residents to complete their electricity transactions without going to the ministry's headquarters in South Surra and enduring the bur-

den of effort and time. He explained that, "The customer service sector has developed many plans to collect the ministry's dues from citizens. In view of the advent of the academic year and its requirements, we have reduced the

pace of collections, so that it will return to its pace in the middle of October.

The ministry's keenness to collect from citizens the dues owed to the ministry is in the interest of the citizens so that these dues do not accumulate on them. There are also plans in the Customer Affairs Sector to collect dues from the government and oil sectors and all other

The ministry and its work teams are proactive in completing tasks. Evidence of this is the opening of the customer service office in Sabah Al-Ahmad area, as it is the first government services office for citizens in the new cities, especially in the Sabah Al-Ahmad area, which is a great distance from the city.

Directives were given to the ministry's officials regarding the necessity of completing all private electricity transactions through the new office to save citizens time and effort.

Dr. Al-Ostad stressed the ministry's keenness to make all its services digital, even though there are many services now available to people that contribute to facilitating procedures and saving time and

He said the tender for phase two of the project for smart electricity and water meters is currently in the process of being tendered and will be installed in all housing sectors.

Non-compliant face closure

KUWAIT CITY, Sept 14: Chairman of the parliamentary Values Enhancement Committee MP Muhammad Havef disclosed that the committee had a meeting with Minister of Education, Higher Education and Scientific Research Adel Al-Mane, Kuwait University President Professor Fayez Al-Dhefairi and a number of senior university officials recently.

Hayef confirmed that an agreement has been reached on strictly implementing Gender Segregation Law number 24/1996 at the university. He quoted Al-Dhefairi as

saying that the departments, which are not segregated will be closed until the completion of the registration of new students as per the aforementioned law. He hailed Al-Dhefairi and the senior university officials for responding to the committee's demand, which is based on the law and Kuwaiti traditions.

On the other hand, MP Adel Al-Damkhi asked State Minister for Municipal and Communication Affairs Fahd Al-Shulah about the decision of Kuwait Municipality to collect fees from citizens who built car sunshades. He wants to know if the Municipality considered law number 79/1995, which stipulates the need for the National Assembly to ratify a special legislation on such fees.

MP Majed Al-Mutairi forwarded queries to Al-Shulah about the Communication and Information Technology Regulatory Authority (CITRA). He inquired why the Mohammed Hayef authority has not established its



permanent headquarters till date despite the allocation of a special budget for this purpose; if the concerned institutions including the Municipality have approved the establishment of the permanent headquarters; copies of approvals if the response is in the affirmative and reasons if the answer is 'no'; if a tender was floated for this purpose; copies of the tender and approval of the concerned monitoring institutions if the reply is 'yes'; if the rent contract for the temporary headquarters of CITRA in Al-Hamra Mall is still valid; if the contract was renewed for a longer term; rent amount; if the delay in establishing the permanent headquarters and continuous renting of a temporary headquarters are considered squandering of public funds; why CITRA has only one branch (located at Kuwait International Airport); why it has no offices at the land borders, as citizens passing through the land borders have to go to its office at the airport to process their transactions and then return to the land borders to collect their commodities; and strategy of CITRA after abolishing the Cyber Security Department and establishing the National Center for Cyber Security

Accounts movement under supervision

Local banks seek CBK opinion on banking control mechanism

KUWAIT CITY, Sept 14: The local banks have sought the opinion of the Central Bank of Kuwait regarding the required control mechanism for banking operations between bank employee accounts and customer accounts, reports Al-Rai daily.

The sources explained that the banks have asked the supervisory regulator to provide them with the adequacy of the procedures followed by them to monitor their employees' accounts, and whether the central bank had any directives that should be taken into account.

Due diligence

In this regard, the Central Bank stated that banks must fulfill due diligence requirements to verify the integrity of the funds and information available to them, whether about the movement of customer or employee accounts, and compare it with their financial data recorded in the Know Your Customer form, to ensure the extent of its consistency with the transactions executed on their accounts.

The Central Bank asked banks to rely on the instructions that were issued previously and amended last February, which specified the frameworks and concepts that banks must take into account when setting policies and work procedures that must be followed to verify compliance with fulfilling the requirements of the instructions for monitoring the accounts of their employees and customers.

The sources indicated that banks rely,

in implementing oversight instructions on employee and customer accounts, on the instructions of the Central Bank and their established internal control systems, especially with regard to unusual money flows that are transferred to the customer's accounts, whether he is an employee or a customer from outside the bank, with Taking into account increased due diligence with the employee client.

The sources said that the banks follow a more careful policy in accordance with the instructions of the Central Bank on employee accounts, as once any unusual amounts pass into the employee accounts, they are immediately inquired about the source of these funds, and any evidence confirming their safety, especially if the liquidity flowing to the employee's account is high compared to the size of the money.

According to sources, banks maintain a comprehensive review process for customer account opening documents, including a thorough examination of any negative records, before authorizing new accounts or processing financial transactions.

Furthermore, banks meticulously inspect incoming fund transfers to customer accounts. During this process, they consider the regular income sources or request evidence of their legitimacy if they surpass conventional financial thresholds. This scrutiny is particularly applicable to funds that are regularly deposited into the client's

'Nations eager to participate in shaping new chapter of history'

"THE world wakes up every day to a new variable that shapes the features of a different world order that is inevitably coming, posing a challenge to countries that are part of the new history-making movement or outside of it. It seems clear that the successive summits and major meetings in the recent period, which were based on the economic and development dimension, and went beyond the stage of political theorizing, to move toward giant economic blocs, practical projects, and realistic alliances, are changing the international scene politically, economically, and geopolitically," columnist Azzam Al-Sabah wrote for Al-Rai daily.

"The Ukrainian conflict triggered a series of repercussions that unfolded across various dimensions, encompassing the realms of politics, economics, and beyond. Yet, the pivotal moment lies in the war's role in postponing the emergence of a new, multipolar world order. The continued conflict hints at the presence of international actors working to manage the Ukrainian crisis rather than staunching the ongoing wounds of war. Their



motivations appear to be driven by political and economic goals. "This shadow cast by the Ukrainian crisis looms over

recent global events like the BRICS summit and the G20 summit. At these gatherings, participants displayed a concerted effort to advance new economic alliances that could exert substantial influence on global affairs and chart their own trajectories.

"Notably, the expansion of the BRICS group from 5 to 11 countries, with the recent invitation extended to Saudi Arabia, the United Arab Emirates, Egypt, Iran, Argentina, and Ethiopia, was a significant development. These additions were carefully selected based on their regional and international significance. This expansion solidifies the group as a formidable force, representing roughly half of the world's population and boasting the presence of major oil-producing nations.

"The G20 summit introduced yet another noteworthy facet to this evolving landscape, proposing a novel model for global integration. Perhaps the most striking concept unveiled was the idea of establishing an economic corridor linking India to Europe via the Middle East.

"Amidst these rapidly evolving dynamics, China's ambitious project continues to unfold, aiming to position itself as a colossal economic, technological, and military power. This effort encompasses both bilateral alliances and international blocs that view China's project as a promising future within the emerging world order.

"The introduction of the "economic corridor" concept by the G20 harks back to the "Chinese Silk Road," which serves as a magnetic force drawing the world's economies toward China through substantial investments. The Gulf nations, including Kuwait, are poised to play a pivotal role in this project, contributing to regional stability and development.

"Another facet of the emerging world order is manifested in the succession of military coups in several African countries, reflecting a desire to break free from the past. As traditional global powers relinquish their spheres of influence to rising players, these coups represent an important shift in the geopolitical landscape.

"Although the contours of the new world order remain uncertain, it is clear that nations are eager to actively

participate in shaping this new chapter of history rather than passively observing from the sidelines. Achieving security, stability, and peace will be instrumental in the realization of this evolving global order, a sentiment echoed by the evolving landscape of political alliances."

"Changes in the region and the world are happening at an increasingly rapid pace. Each day brings surprising shifts in international politics and the emergence of new organizations. It all began with the formation of the "BRICS" group in 2009, and we've seen economic trends pushing for the inclusion of countries with significant financial and economic influence, as exemplified by the recent developments at the BRICS summit in India, particularly the proposal for an economic corridor linking India with the Middle East and Europe," columnist Abdul Rahman Al-Otaibi wrote for Al-Rai daily.

"China, with its substantial economic power and expanding global footprint, has raised concerns not only for the United States but also to some extent, the European Union. Recent military coups in countries with European support, such as France, may align with China's interests.

"Russia remains entangled in the Ukrainian conflict, and the world is unmistakably shifting towards multipolarity. In this context, countries must strategically reposition themselves to mitigate risks and pursue their long-term interests.

"The question we face is: Where do we stand amid these developments? Do we have a strategic plan that anticipates these variables and offers a strategic vision to safeguard against negative hesitations and maximize the benefits of these new alliances, employing a principle of strategic maneuvering?

"Countries with limited geographical size must maintain a balanced distance from various alliances, emphasizing economic ties as a means to enhance stability and security. However, this balance can be compromised in a hostile economic and investment climate, potentially impeding their flexibility in safeguarding strategic security, especially in the face of internal tensions that suggest instability to outsiders.

"Freedom and democracy in any state should serve to advance interests, not undermine them. Therefore, it is crucial to pay attention to internal affairs, acknowledging that frustrations may arise from issues rooted in the past. Expecting quick fixes from the government is unrealistic, as it lacks a magic solution and relies on the sincere cooperation of all stakeholders.

"Succumbing to voices of unknown entities on social media which often serve specific agendas by criticizing government efforts, is unwise and acknowledging the need for improvements in selection processes, accountability, and government media transparency, it's essential to recognize that constructive criticism should be objective, not driven by personal gain or political vendettas.

"We've heard calls for change and reform in the past, but results have been elusive. Aristotle wisely noted that self-awareness is a challenging pursuit, while teaching others is easier. In the face of regional and international changes, Kuwait's security and interests must be pre-

"Kuwait is not merely a source of income; it is our homeland, our sanctuary, and the very air we breathe. It embodies dignity over wealth, spiritual richness over financial gains.'

Taxi driver nabbed for helping maids escape from sponsors

Two-vehicle collision kills woman

KUWAIT CITY, Sept 14: After an extensive week-long operation involving searches, investigations, and surveillance, officers from the General Administration of Residence Affairs Investigations have arrested an Egyptian mobile taxi driver for helping female domestic workers from their sponsors' homes and aiding them work on hourly or daily basis, reports Al-Qabas daily.

According to a security source the arrest was based on reports from concerned citizens about female workers fleeing from their homes.

In response, an investigative task force was assembled to monitor areas associated with these reports and the diligent efforts of the task force culminated in the arrest of the suspect as he was attempting to smuggle a domestic worker from her sponsor's residence in Abu Futaira. Subsequently, he was detained and subjected to further investigation.

The source revealed that the suspect had confessed to engaging in this illegal activity for an extended period of time and had cooperated with investigators by disclosing the location of an apartment in Jleeb Al-Shuyoukh where absconding workers were being sheltered. Dur-

Health centers issue 6 m sick leaves in 20 months

KUWAIT CITY, Sept 14: According to the Ministry of Health in 2022 and until August 2023 the primary health care centers have issued a total of 3,377,106 sick leave certificates, while they amounted to 2.7 million sick leaves as of last August, reports Al-Seyassah daily.

The announcement said the ministry has now approved the proposal put forth by the Minister of Health, Dr. Ahmed Al-Awadhi about the new electronic platform to issue sick leaves and that the specific details of this mechanism will be clarified in the upcoming weeks, prior to the service's implementation.

Dr. Abdullah Al-Sanad, the ministry's spokesperson, elaborated that the proposal presented to the Civil Service Commis-



Chevron reports LNG outage

A Chevron Corp. liquefied natural gas plant in Australia reported a production outage Thursday as workers escalated a strike action against facilities that provide more than 5% of global LNG supplies.

The U.S. energy giant said in a statement that it was working to resume full production at its Wheatstone facility "following a fault which has impacted about 25% of LNG production."

The cause has been identified and restart activities have commenced," the statement said Chevron's Wheatstone and Gorgon plants in Western Australia state account for more than 5% of global LNG supply.

Chevron did not link the disruption to an escalation Thursday in the strikes at its Wheatstone and Gorgon LNG plants. Around 500 workers at the two Chevron sites have been taking limited strike actions since Sept. 8 in a dispute over wages and conditions. (AP)

applications for US jobless benefits tick up

The number of Americans applying for unemployment benefits last week ticked up modestly after falling to the lowest level in seven months the week before, as companies continue to retain employees despite the Federal Reserve's

efforts to cool the economy. U.S. applications for jobless claims rose by 3,000 to 220,000 for the week ending Sept. 9, the Labor Department reported Thursday. Jobless claim applications are seen as representative of the number of layoffs in a given week.

The four-week moving average of claims, a less volatile measure, fell by 5.000 to 224.500.

The Federal Reserve is well into the second year of its battle against inflation, having raised interest rates 11 times since March of last year. At 5.4%, the Fed's benchmark borrowing rate is at the highest level in 22 years. The Fed's rate hikes are meant to cool the job market and bring down wages, which many economists believe helps to ease pressure on price growth. (AP)

Europe's central bank hikes key interest rate to record high even as recession threat grows

'Inflation has declined and we want it to continue to decline'

FRANKFURT, Germany, Sept 14, (AP): The European Central Bank hiked its key interest rate to a record high Thursday, pressing its fight against stubbornly high inflation that has been plaguing consumers - even as worries grow that higher borrowing costs could help push the economy into recession.

The increase of a quarter-percentage point comes as central banks around the world, including the U.S. Federal Reserve, try to judge how much anti-inflation medicine is too much - and what's the right point to halt their swift series of rate rates before the economy tips into a downturn and people lose their jobs.

'Inflation has declined, and we want it to continue to decline and to reinforce that process," ECB President Christine Lagarde said at a news conference. "And we are doing that not because we want to force a recession, but because we want price stability to be there for people who are taking the brunt of inflation.

Nevertheless, the bank signaled that its 10th straight hike could be its last, shifting its emphasis from raising rates to keeping them high enough for long enough to beat down inflation

Thursday's decision raises the ECB's benchmark deposit rate to 4%, up drastically from minus 0.5% just a little more than a year ago and the highest since the euro was established in 1999.

Lagarde reiterated that interest rate levels "will make a substantial con-

tribution to bringing down inflation" and that borrowing costs would stay high "for as long as necessary." Analysts said those statements indicate that this rate hike would likely be the last.

"The ECB's communication was clear: today was the last hike in the current cycle," said Carsten Brzeski, chief eurozone economist for ING

"Looking ahead, a further weakening of the economy and more traction in a deflationary trend will make it very hard to find arguments for yet another rate hike before the end of the year," Brzeski said.

Annual inflation of 5.3% in the 20 countries that use the euro currency is well above the bank's target of 2%, robbing consumers of purchasing power and contributing to economic stagnation. But there is the growing awareness that higher borrowing costs are

weighing on decisions by consumers and businesses to invest and spend and are becoming a burden on the economy. Interest rates combat inflation by raising the cost of credit for things

people want to buy, particularly houses, and for business investment in buildings and equipment. That cools off demand for goods and relieves upward pressure on prices.

The flip side is that rate hikes can hurt economic growth if they're over-

Europe's major economies - Germany, France, Spain and Italy - saw shrinking activity in August in the services sector even at the tail end of a strong tourism summer in Spain and Italy, according to S&P Global's surveys of purchasing managers. Services is a broad category that includes hotel stays, haircuts, car repairs and medical treatment.

That comes on top of a slowdown in global manufacturing that is hitting Germany, Europe's biggest economy, particularly hard.

The eurozone economy has been teetering on the edge of recession since last year, barely growing in each of the first two quarters of this

Yet the economic picture does not resemble a typical recession because unemployment is at a record low of 6.4%. Labor shortages have sent people's pay higher - one factor complicating the ECB's inflation

Also weighing on the outlook is a weaker euro against the strengthening U.S. dollar as investors take the view that economic weakness will hit Europe and China. They are betting that the U.S. Federal Reserve might manage a "soft landing" by finishing its rate hikes without pushing the

The Fed made its 11th rate increase in July, bringing its key rate to the highest level in 22 years after pausing in June. Economists and investors generally expect the Fed to skip a rate hike at its meeting next week, but it could increase again in November.

Inflation is lower in the U.S. - at 3.7% - than in Europe despite an upward bump from gasoline prices in August.

Central banks around the world have been hiking rates to stamp out inflation that broke out after the sharp economic rebound from the COV-ID-19 pandemic strained supply chains and Russia's invasion of Ukraine sent food and energy prices higher.

Wall Street climbs as stocks worldwide rise

NEW YORK, Sept 14, (AP): Stocks are rising on Wall Street Thursday after a blizzard of reports suggested the U.S. economy is still humming, though inflation may be The S&P 500 was 0.7% high-

er in midday trading. The Dow Jones Industrial Average was up 243 points, or 0.7%, at 34,819, as of 11 a.m. Eastern time, and the Nasdaq composite was 0.8% higher.

Some of the strongest action was in the bond market, where Treasury yields swung in opposite directions several times following the mixed economic data.

One report said U.S. shoppers spent more at retailers last month than economists expected. Such spending has been a linchpin keeping the economy out of a recession, but it could also be encouraging retailers to keep trying to raise prices

The strong spending is a result of a remarkably resilient job market, which has withstood a steep jump in interest rates since early last year. A separate report Thursday morning said fewer workers applied for unemployment benefits last week than expected, which implies the number of layoffs remains low.

A third report said prices getting paid at the wholesale level rose more last month than economists expected. That could be a discouraging signal for households if the higher-than-expected inflation gets passed on to shoppers at the consumer level.

To try to get inflation back down to its 2% target, the Federal Reserve has been increasing interest rates sharply. The hope on Wall Street is that a slowdown in inflation since last summer means the Fed is done with its rate hikes, which slow the economy and hurt investment prices.

Treasury yields initially jumped following Thursday's reports on fears they could push the Fed to raise rates again or at least to keep rates higher for longer. But economists pointed out much of last month's acceleration in wholesale inflation was due to higher fuel prices, which can shift direction sharply and quickly.

Ignoring those and other particularly volatile prices, underlying inflation trends in Thursday's report were closer to economists' expectations. That echoed a report from a day earlier on inflation at the consumer level, which showed overall inflation accelerated to 3.7% in August largely because of a leap in fuel prices.

The yield on the 10-year Treasury initially jumped to nearly 4.30% immediately after the eco-

nomic data's release Thursday morning. But it later eased back, only to swing again. It was sitting at 4.25%, roughly where it was late Wednesday.

The two-year Treasury yield, which more closely tracks expectations for the Fed, also bounced up, down and back again following the reports. It was sitting at 4.96%, down from 4.98% late Wednesday, after briefly leaping above 5.02%.

Traders pared back expectations for the Fed to raise rates again some time this year, though they're still betting on a nearly 42% chance of that, according to data from CME

Optimism that the Fed may be done hiking rates may be overdone, warned Mike Loewengart, head of model portfolio construction at Morgan Stanley Global Investment Office.

"The Fed is still likely to remain on hold next week, but if the economy continues to surprise to the upside, all bets are off as to what they'll do after their final two policy meetings of the year," he said.

In the stock market, shares of chip designer Arm Holdings are set to begin trading later in the day. It priced its stock at \$51 per share in an initial offering, The offering valued Arm at \$54.5 billion and could be an encouraging signal for the IPO market, which has slowed since the stock market began tumbling early last year on fears about higher interest rates.

Stocks of energy producers were helping to lead the market after oil prices rallied. Crude has been climbing for months as oil-producing countries try to support its price by curtailing their supplies. A barrel of U.S. crude rose 1.6% to \$89.90. Brent crude, the international standard, climbed 1.8% to

Fossil fuel is still in 'demand' despite contrary claims: **OPEC**

VIENNA, Sept 14, (KUNA): OPEC said on Thursday that fossil fuel was still in demand despite claims contrary

On the International Energy Agency's (IEA) recent Op-Ed published on September 12, 2023, asserting that fossil fuel demand would peak before 2030. OPEC noted in a statement that consistent and databased forecasts do not support this assertion.

It is an extremely risky and impractical narrative to dismiss fossil fuels, or to suggest that they were at the beginning of their end, indicated OPEC.

"In past decades, there were often calls of peak supply, and in more recent ones, peak demand, but evidently neither has materialized.' OPEC went on to say, "The dif-

ference today, and what makes such predictions so dangerous, is that they are often accompanied by calls to stop investing in new oil and gas projects. "Such narratives only set the global

energy system up to fail spectacularly. It would lead to energy chaos on a potentially unprecedented scale, with dire consequences for economies and billions of people across the world," said OPEC Secretary General, Haitham Al-Ghais.

This thinking on fossil fuels is ideologically driven, rather than fact-based. It also does not take into account

the technological progress the industry continues to make on solutions to help reduce emissions. Neither does it acknowledge that fossil fuels continue to make up over 80 percent of the global energy mix, the same as 30 years ago, or that the energy security they provide

is vital. Technological innovation is a key focus for OPEC, which is why Member Countries are investing heavily in hydrogen projects, carbon capture utilization and storage facilities, the circular carbon economy, and in renewables too.

While some may suggest that a number of these oil-focused technologies are still immature, they ignore the fact that many technologies referenced in net-zero scenarios are at an immature, experimental or even theoretical

"In recent years, we have seen energy issues climb back to the top of the agenda for populations as many glimpse how experimental net zero policies and targets impact their lives. They have legitimate concerns. How much will they cost in their current form What benefits will they bring Will they work as hyped Are there other options to help reduce emissions And what will happen if these forecasts, policies and targets do not

materialize' "Thankfully, there has been a reawakening across many societies of the need for energy security and economic development to go hand-inhand with reducing emissions. In turn, this has led to a reevaluation by some policymakers on their approach to energy transition pathways," OPEC said.

"Cognizant of the challenge facing the world to eliminate energy poverty, meet rising energy demand, and ensure affordable energy while reducing emissions, OPEC does not dismiss any energy sources or technologies, and believes that all stakeholders should do the same and recognize short- and long-term energy realities," said Al-

In the interests of contributing to future overall global energy stability, OPEC will continue to cooperate with all relevant stakeholders to foster dialogue, that includes the views of all peoples, so as to ensure inclusive and effective energy transitions moving

Oil Markets Monthly Report ----- September 2023

Output cuts and rate pause talks pushes oil to over USD 92/b...

Oil prices reached the highest level in 10 months and traded above the USD 90/b mark following consistent gains since the last week of August-2023. Initial gains were led by consistent decline in crude oil inventory in the US that reached the lowest level since December-2022. Lower stock of refined products across the globe also supported prices. In addition, the announcement from Saudi Arabia and Russia to extend the ongoing voluntary cuts aggregating to 1.3 mb/d until the end of the year have provided a boost to oil prices since the start of this month. The cuts have also resulted in a sharp decline in crude oil at sea that reached 1.04 billion barrels, the lowest since the start of August-2022, as per Kpler.

On the demand front, growing optimism of a rate hike pause by the US Fed and in the EU, as per a survey of global economists, resulted in expectations of a stronger crude oil demand recovery along with soft landing in economic growth later this year. In addition, China's crude oil imports remained strong last month, although other macroeconomic data suggested a slowing economy that the government is trying to counter with the help of various reforms announced recently. Oil demand in the US also remained steady during May and June-2023, according to revised data from the EIA. Consumption rose to a 5-year seasonal high of 20.7 mb/d during June-2023 led by record summer consumption of natural gas liquids, although consumption in the transportation sector remained below pre-pandemic

On the supply front, the oil market overlooked the consistent rise in crude oil output in the US over the last few weeks, as per data from the EIA. Weekly data showed production staying at 12.8 mb/d since the last three weeks, the highest since the start of the pandemic and inching towards the pre-pandemic record of 13.1 mb/d. Oil rig count data from Baker Hughes also showed the first increase in 13 weeks last week. A report from Rystad Energy backed up this increase saying that US independent shale oil producers have increased investments to grow output at the fastest rate in three years during Q2-2023. However, this could be a temporary spike as shale output has been shrinking at a faster-than-expected pace, especially in the Permian Basin and New Mexico, with output is expected to fall to 5.8 mb/d this month to the lowest since February-2023.

Meanwhile, OPEC crude oil production showed a marginal increase during August-2023, as per data from OPEC secondary sources. Aggregate OPEC production reached 27.44 mb/d during the month as per OPEC monthly report, registering an increase of 113 tb/d. The increase was led by higher output mainly from Iran, Nigeria, Libya and Iraq that was partially offset by decline in production mainly in Saudi Arabia, Angola and Venezuela. With the ongoing production cuts, the OPEC monthly report showed an expected supply gap of more than 3 mb/d in Q4-2023, the biggest deficit in more than a decade.

Oil Prices

Crude oil futures reached 10-month high levels and traded around USD 92/b following consistent gains since the last week of August-2023. Brent oil future prices are more than 10% over the last three weeks despite downward pressure coming from talks of a thaw between US relations with Venezuela and Iran. There were reports that the US government is in talks with Venezuela to explore easing sanctions whereas production and exports from Iran have increased recently led by back-door diplomatic efforts, according to a Bloomberg report. The net gain in prices, however, highlighted a tightening market for both crude oil as well as re fined products globally. In addition, despite concerns on the broader economy, demand from China remained robust as the country once again focused on filling strategic reserves as well as increasing exports of refined products. A rebound in the country's aviation sector also supported demand for

Moreover, expectations of lagging shale output in the US also supported prices. A report from the US EIA forecasted a second consecutive month of decline in US shale output, although monthly production in the remained elevated at 12.8 mb/d. Higher production was also reflected in the first increase in oil rig count in the US in 13 weeks to reach 513 rigs during the week ended 8-September-2023. However, higher export-focused refinery runs in the US resulted in consistent withdrawals from the inventory reserves. According to the latest weekly report, total crude oil inventory in the US reached 416.6 million barrels, the lowest since December-2022, following four straight weeks of declines.

Daily oil price data showed one of the longest running positive streaks in prices since last month. As a result, average monthly OPEC crude oil basket prices witnessed the second consecutive m-o-m growth in August-2023 with an increase of 7.7% to average at USD 87.33/b. The gains in average Brent crude oil was slightly smaller at 7.6% to average at USD 86.1/b while Kuwait crude grade saw a gain of 7.7% to average at USD 88.8/b during August-2023.

World Oil Demand

World oil demand growth forecast for 2023 was kept unchanged from the last month at 2.45 mb/d in OPEC's latest monthly report with demand expected to reach 102.1 mb/d this year. However, adjustments were made at the country level for Q3-2023 based on actual data for July-2023 with upward revisions to demand data for China, US and OECD Europe. These upward revisions were completely offset by downward revisions to 2H-2023 data mainly for the Other Asia region. Demand growth forecast for 2024 was also kept unchanged at a growth of 0.3 mb/d to reach 104.3 mb/d. Near term expectations for US oil demand shows a slight decline in driving activity in the coming months, following a seasonal pattern. However, air travel is expected to remain strong and as such gasoline and jet fuel are expected to drive demand. In Europe, supply chain bottlenecks and sluggish manufacturing activity are expected to weigh on demand during Q3-2023, but improve marginally in Q4-2023.

Oil demand in China remained robust during August-2023 with crude oil imports reaching 12.43 mb/d, the third-highest daily rate and up 20.9% vs. July-2023, as per data government data. Imports since the start of the year was up 14.7% y-o-y. The growth was mainly led by strong demand for transportation fuel, including gasoline and jet oil, further supported by efforts to build strategic inventory as well as higher refinery runs that are aimed at exporting refined products.

Oil demand in India is estimated to have grown by 118 tb/d or 2.5% during August-2023, according to a report by S&P Global Commodity Insights, led by better factory activity and increased mobility. A report from ET showed that the country reported a steep decline in imports from Russia and Iraq that was replaced mainly by supplies from Saudi Arabia. The decline in imports from Russia was mainly due to refinery maintenance.

In the European region, demand for refined products have seen a sharp increase. According to data from Vortexa, Europe's diesel imports are set to reach the highest level in eight months this month. Much of the supplies are originating from Middle Eastern suppliers, although the second a half of September-2023 may see a dip due to refinery maintenance.

World Oil Supply

Global liquids production remained broadly unchanged in August-2023 after seeing a decline during the previous month. According to preliminary data, global oil supply



Non-OPEC liquids supply growth forecast for 2023 saw an upward revision in OPEC's latest monthly report. Supply is now expected to grow by 1.6 mb/d this year to reach 67.4 mb/d as compared to a growth of 1.5 mb/d expected in the previous month's report. The revisions mainly included upward revisions to supply forecast for Russia (+71 tb/d), the US (+63 tb/d) and Brazil (+40 tb/d) that was partially offset by downward revisions to supply forecast data for Norway (-28 tb/d), Canada (-25 tb/d) and UK (-22 tb/d).


Supply forecasts for 2024 was kept unchanged with an expected growth of 1.4 mb/d to average at 68.8 mb/d. However, upward revision was made to supply data for Norway that was offset by downward revisions to the US. The OPEC expects slow and steady growth in US crude oil production this year, although there are uncertainties related to shale oil production and unplanned refinery maintenance for the rest of the year. A Bloomberg report showed that oil drillers in the Permian Basin reduced rig use at the fastest pace in three years as the basin shrinks amid consolidation and the slow return in oil demand.


OPEC Oil Production & Spare Capacity
















decline in more than three years during July-2023. Average production during the month reached 27.8 mb/d, according to Bloomberg data, with a m-o-m increase of 40 tb/d. The production data from OPEC secondary sources showed a slightly bigger increase of 113 tb/d with production averaging at 27.45 mb/d. Saudi Arabia once again recorded the biggest monthly decline in production during the month followed by Angola, Venezuela, Algeria and Congo. These declines were more than offset by higher production mainly in Iran, Nigeria, Iraq and Libya. The ongoing production cuts by OPEC+ coupled with voluntary cuts mainly by Saudi Arabia and Russia could result in a global crude oil supply shortfall of more than 3 mb/d in Q4-2023. This could be the biggest shortfall in more than a decade.

Oil production in Saudi Arabia went below the 9 mb/d mark during August-2023 and reached 8.98 mb/d, the lowest in 24 months, according to Bloomberg. The implementation of 1 mb/d of additional output curbs has also affected the Kingdom's crude oil exports that reached the lowest level in 29 months at 5.55 mb/d. In terms of destination, exports to China and US reached multi-year lows during the month while it increased to India.

Meanwhile, Iran reported the biggest m-o-m increase in production during August-2023. Average production during the month breached the 3 mb/d mark for the first time in almost five years to reach 3.07 mb/d, registering an increase of 90 tb/d as compared to previous month. Oil exports from the country have also picked up in recent months with a Bloomberg report saying flows from Iran are currently running at around 2 mb/d, close to the country's capacity. However, most of the increase is led by seasonal demand and may taper in coming months.

Oil production in swing producers Nigeria and Libya also witnessed a sharp increase during the month. Oil production in Nigeria was up by 80 tb/d to reach 1.34 mb/d led by resumption of loading from the Forcados terminal following an underwater leak that affected loading for a month. Oil production in Libya increased by 40 tb/d to reach 1.14 mb/d in August-2023. However, production during this month is expected to be affected by the a hurricane that led to the closure of four oil ports.

wholesale price inflation accelerated in August

U.S. wholesale prices increases accelerated in August, a sign that inflation remains stubbornly persistent despite a series of sharp interest rate hikes by the Federal Reserve. The Labor Department said Thursday that

its producer price index - which measures inflation before it hits consumers - increased 1.6% last month from a year earlier. That is up from a small 0.8% yearly increase in July and just 0.1% in June. Sharply higher gas prices drove much of the increase.

Excluding the volatile energy and food categories, core inflation rose 2.2% in August from a year earlier, down from a 2.4% yearly increase in July.
Wholesale prices are still rising more slowly than consumer costs, a sign that inflation may continue to cool as the weaker wholesale price gains translate into smaller price increases for the consumer. The Thursday data reflect prices charged by manufacturers, farmers and whole-

The government said Wednesday that the consumer price index, the most widely-followed inflation gauge, rose 3.7% in August from a year ago, up from a 3.2% yearly gain in July. Yet excluding the volatile energy and food components, core inflation fell to 4.3% in August from 4.7% in July.
Also Thursday, the government said retail sales rose 0.6% in August, largely because sharply higher gas prices pushed up gas station sales. Excluding fuel, retail sales rose just 0.2%.

On a month-to-month basis, wholesale prices rose 0.7% in August, the biggest gain in more than a year, up from a 0.4% increase in July. Core wholesale prices ticked up 0.2% last month, down from 0.3% in July. The Federal Reserve, which is fighting inflation by raising interest rates, closely monitors core prices because they are considered a better measure of

Offshore wind energy projects advance in NJ amid opposition

Project will not injure marine life

ATLANTIC CITY, N.J. Sept 14, (AP): Two major offshore wind power projects are taking steps forward in New Jersey as the owners of one project agreed to bring the federal government in on their environmental monitoring plans at an earlier stage than has ever been done, and federal regulators said plans for another project are not expected to kill or seriously injure marine life.

They come as New Jersey continues to grow as a hub of opposition to offshore wind projects from residents' groups and their political allies, mostly Republicans. The state's Democratic governor and Democratic-controlled Legislature want to make the state the East Coast leader in offshore wind energy.

Community Offshore Wind, a joint venture between Essen, Germanybased RWE and New York-based National Grid Ventures, on Thursday announced a five-year partnership with the National Oceanic and Atmospheric Administration to promote the exchange of data and expertise on environmental monitoring for offshore wind projects.

The agreement will bring the federal agency into the company's planning process at a much earlier stage than is currently done in the offshore wind industry, an arrangement that could become the new industry standard, according to company president Doug

gether to make sure that it's efficient in the data they collect," he said. "It creates the opportunity, the avenue for us to engage with them, and for them to engage with us, to make sure that our plans, how we're sampling, where we're sampling, when we're sampling, fits with what they do and with what will be required of the industry.'

Jon Hare, director of NOAA's Northeast Fisheries Science Center, praised the proposed collaboration.

"With help from a number of collaborators and the fishing industry, our agency maintains some of the world's most comprehensive data sets on large marine ecosystems," he said. "Our goal is to bring offshore wind energy monitoring activities into this partnership. This agreement is our first chance to make these partnerships a reality and show by example that effective scientific monitoring benefits

Community has leased a 125,000 acre site 60 miles (97 kilometers) off Long Island, New York, and 37 miles (60 kilometers) off Little Egg Harbor in New Jersey. Its project has yet to be designed but is likely to include at least 100 wind turbines. It could be active by 2030 or 2031, Perkins said.

On Wednesday, NOAA released a letter of authorization for Denmarkbased Orsted's Ocean Wind I project in southern New Jersey.

It involved approval of plans for unintentional harassment or injury of marine mammals during construction of the project, which would build 98 turbines about 15 miles (24 kilometers) off the coast of Ocean City and Atlantic City. The impact is referred to by the agency as "take," which refers to harassment or injury of animals.

"Ocean Wind did not request and

(the National Marine Fisheries Service) neither expects nor authorizes incidental take by serious injury or mortality,'

the agency wrote. Opponents of offshore wind blame the deaths of 70 whales along the East Coast since December on offshore wind site preparation work. But three federal scientific agencies say there is no evidence that such work is responsible for the deaths, about half of which have been attributed to vessel strikes.

NOAA is requiring Orsted to take a number of steps designed to avoid harm to whales, including a moratorium on the detonation of undersea explosives from Nov. 1 through April 30; visual and acoustic monitoring of the waters near such explosions before, during and after them; shutting down pile driving "if feasible" if an endangered North American right whale or other marine mammal enters certain prescribed zones; and noise mitigation steps including using the least amount of hammer force possible for foundation installations.

David Shanker, a spokesman for the Save the Right Whales Coalition, called the decision "appalling." The group recently sent NOAA the results of a study by an independent acoustics company asserting that offshore wind survey vessels have been exceeding approved decibel levels and appear to

be using other-than-approved devices.

"There has been a complete breakdown in the system designed to protect marine wildlife and protect the North Atlantic right whale from extinction,'

Shanker said. NOAA declined comment.

Earlier this week, Republicans in the state Senate called for a moratorium on all offshore wind projects. They asked for a special session of the Legislature to consider measures to prohibit further tax breaks for offshore wind companies beyond one already given to Orsted. Senate Democrats declined comment.

Why humans can't trust AI: Don't know how it works, its intentions

There are alien minds among us. Not the little green men of science fiction, but the alien minds that power the facial recognition in your smartphone, determine your creditworthiness and write poetry and computer code. These alien minds are artificial intelligence systems, the ghost in the machine that you encounter daily.

But AI systems have a significant limitation: Many of their inner workings are impenetrable, making them fundamentally unexplainable and un-predictable. Furthermore, constructing AI systems that behave in ways that people expect is a significant chal-

If you fundamentally don't understand something as unpredictable as AI, how can you trust it?

Trust is grounded in predictability. It depends on your ability to anticipate the behavior of others. If you trust someone and they don't do what you expect, then your perception of their trustworthiness diminishes.

Systems

Many AI systems are built on deep learning neural networks, which in some ways emulate the human brain. These networks contain interconnected "neurons" with variables or "parameters" that affect the strength of connections between the neurons. What is USB-C? The one device connector to rule them all

Apple announced on Sept. 12, 2023, that it plans to adopt the USB-C connector for all four new iPhone 15 models, helping USB-C become the connector of above 15th connector of choice of the electronics industry, nine years after its debut. The move puts Apple in compliance with European Union law requiring a single

connector type for consumer devices. USB-C is a small, versatile connector for mobile and portable devices like laptops, tablets and smartphones. It transfers data at high speeds, transmits video signals and delivers power to charge devices' batteries. USB stands for Universal Serial Bus. The C refers to the third type, following types

The USB Implementers Forum, a consortium of over 1,000 companies that promote and support USB technology, developed the USB-C connector to replace the older USB connectors as

well as other types of ports like HDMI, DisplayPort and VGA. The aim is to create a single, universal connector for a wide range of devices.

The key features and benefits of USB-C include a reversible connector that you can insert in either orientation. It also allows some cables to have the same connector on both ends for connecting between devices and connecting devices to chargers, unlike most earlier USB and Lightning cables.

USB-C's widespread adoption in the electronics industry is likely to lead to a universal standard that reduces the need for multiple types of cables and adapters. Also, its slim and compact shape allows manufacturers to make thinner and lighter devices.

USB-C refers to the physical connector. Connectors use a variety of data transfer protocols - sets of rules for formatting and handling data - such as the USB and Thunderbolt protocols. USB-C supports USB and Thunderbolt, which makes it suitable for connecting laptops, smartphones, tablets, monitors, docking stations and many other devices

The latest USB protocol, version 4, provides a data transfer rate of up to 40 gigabits per second, depending on the rating of the cable. The latest Thunderbolt, also on version 4, supports up to 40 gigabits-per-second data transfer and 100 watts charging. The newly announced Thunderbolt 5 will support up to 80 and 120 gigabits-per-second transfer and 140 to 240 watts power transfer over a USB-C connector.

Due to the fragmented nature of technology evolution, computer users a decade ago were struggling with too many connectors: USB for data; power cables for charging; HDMI, Display-Port or VGA for video; and Ethernet

all-purpose connector.

C has gained widespread popularity and has already become the connector of choice for most non-Apple devices. Apple converted the iPad Pro to USB-C in 2018 and now is doing the same for the best selling Apple device, the iPhone. Some market forecasts suggest there will be close to 4 billion USB-C connector sales by 2025 and 19 billion by 2033. Thanks to the industrywide adoption

of USB-C, consumers soon won't have to ask "Is this the right connector?" when they reach for a cable to charge or sync their portable devices. And if you're an iPhone user and find yourself with a new model, you can recycle your no-longer-needed Lightning cables by, for example, bringing them to an Apple store. (AP)

Trust relies not only on predictability, but also on normative or ethical motivations. You typically expect people to act not only as you assume they will, but also as they should. Human values are influenced by common experience, and moral reasoning is a dynamic process, shaped by ethical standards and others' perceptions.

Unlike humans, AI doesn't adjust its behavior based on how it is perceived by others or by adhering to ethical norms. AI's internal representation of the world is largely static, set by its training data. Its decision-making process is grounded in an unchanging model of the world, unfazed by the dynamic, nuanced social interactions constantly influencing human behavior. Researchers are working on programming AI to include ethics, but that's proving challenging.

The self-driving car scenario illustrates this issue. How can you ensure that the car's AI makes decisions that align with human expectations? For example, the car could decide that hitting the child is the optimal course of action, something most human drivers would instinctively avoid. This issue is the AI alignment problem, and it's another source of uncertainty that erects barriers to trust.

Convinced

One way to reduce uncertainty and boost trust is to ensure people are in on the decisions AI systems make. This is the approach taken by the US Department of Defense, which requires that for all AI decision-making, a human must be either in the loop or on the loop. In the loop means the AI system makes a recommendation but a human is required to initiate an action. On the loop means that while an AI system can initiate an action on its own, a human monitor can interrupt or al-

While keeping humans involved is a great first step, I am not convinced that this will be sustainable long term. As companies and governments continue to adopt AI, the future will likely include nested AI systems, where rapid decision-making limits the opportunities for people to intervene. (AP)

eters. In this way, the AI system learns to classify data it hasn't seen before. It doesn't memorize what each data point is, but instead predicts what a data point might be.

Many of the most powerful AI systems contain trillions of parameters. Because of this, the reasons AI systems make the decisions that they do are often opaque. This is the AI explainability problem - the impenetrable

black box of AI decision-making. Consider a variation of the "Trolley Problem." Imagine that you are a passenger in a self-driving vehicle, controlled by an AI. A small child runs into the road, and the AI must now decide: run over the child or swerve and crash, potentially injuring its passengers. This choice would be difficult for a human to make, but a human has the benefit of being able to explain

their decision. Their rationalization shaped by ethical norms, the perceptions of others and expected behavior - supports trust.

In contrast, an AI can't rationalize its decision-making. You can't look under the hood of the self-driving vehicle at its trillions of parameters to explain why it made the decision that it did. AI fails the predictive require-

Al essential 'part' of creative toolkit

SAN FRANCISCO, Sept 14: Canva, the world's only all-in-one visual communication platform, has released new insights from more than 4,000 marketing and creative leaders on their attitudes towards generative AI. The company commissioned Morning Consult to survey marketers and creatives from the US, UK, France, Germany, Spain, Brazil, Mexico, India, and Australia to understand how AI is transforming their organizations and their roles.

Tech industry leaders endorse

regulating AI at summit in DC WASHINGTON, Sept 14, (AP): The

nation's biggest technology executives on Wednesday loosely endorsed the idea of government regulations for artificial intelligence at an unusual closed-door meeting in the US Senate. But there is little consensus on what regulation would look like, and the political path for legislation is difficult. Senate Majority Leader Chuck Schumer, who organized the private forum on Capitol Hill as part of a push to legislate artificial intelligence, said cluding almost two dozen tech executives, advocates and skeptics - whether government should have a role in the oversight of artificial intelligence, and "every single person raised their hands, even though they had diverse views," he said.

Among the ideas discussed was whether there should be an independent agency to oversee certain aspects of the rapidly-developing technology, how companies could be more transparent and how the United States can stay ahead of China and other coun-

Discussion

"The key point was really that it's important for us to have a referee,' said Elon Musk, CEO of Tesla and X, during a break in the daylong forum. "It was a very civilized discussion, actually, among some of the smartest people in the world."

Schumer will not necessarily take the tech executives' advice as he works with colleagues on the politically difficult task of ensuring some oversight of the burgeoning sector. But he invited them to the meeting in hopes that they would give senators some realistic direction for meaningful regulation.

Congress should do what it can to maximize AI's benefits and minimize the negatives, Schumer said, "whether that's enshrining bias, or the loss of jobs, or even the kind of doomsday scenarios that were mentioned in the room. And only government can be there to put in guardrails."

Other executives attending the meeting were Meta's Mark Zuckerberg, former Microsoft CEO Bill Gates and Google CEO Sundar Pichai. Musk said the meeting "might go down in history as being very important for the future of civilization.

First, though, lawmakers have to agree on whether to regulate, and how. Congress has a lackluster track record when it comes to regulating new technology, and the industry has grown mostly unchecked by government in the past several decades. Many lawmakers point to the failure to pass any legislation surrounding social media, such as for stricter privacy standards.

Schumer, who has made AI one of his top issues as leader, said regulation of artificial intelligence will be "one of the most difficult issues we can ever take on," and he listed some of the reasons why: It's technically complicated, it keeps changing and it "has such a wide, broad effect across the whole world," he said.

Sparked by the release of ChatGPT less than a year ago, businesses have been clamoring to apply new generative AI tools that can compose humanlike passages of text, program computer code and create novel images, audio and video. The hype over such tools has accelerated worries over its

potential societal harms and prompted calls for more transparency in how the data behind the new products is collected and used.

Republican Sen. Mike Rounds of South Dakota, who led the meeting with Schumer, said Congress needs to get ahead of fast-moving AI by making sure it continues to develop "on the positive side" while also taking care of potential issues surrounding data transparency and privacy.

"AI is not going away, and it can do some really good things or it can be a real challenge," Rounds said.

The tech leaders and others outlined their views at the meeting, with each participant getting three minutes to speak on a topic of their choosing. Schumer and Rounds then led a group

During the discussion, according to attendees who spoke about it, Musk and former Google CEO Eric Schmidt raised existential risks posed by AI, and Zuckerberg brought up the question of closed vs. "open source" AI models. Gates talked about feeding the hungry. IBM CEO Arvind Krishna expressed opposition to proposals favored by other companies that would require licenses. In terms of a potential new agency for regulation, "that is one of the biggest questions we have to answer and that we will continue to discuss," Schumer said. Musk said afterward he thinks the creation of a regulatory agency is likely.

Outside the meeting, Google CEO Pichai declined to give details about specifics but generally endorsed the idea of Washington involvement.

"I think it's important that government plays a role, both on the innovation side and building the right safeguards, and I thought it was a productive discussion," he said. Some senators were critical that the

public was shut out of the meeting, arguing that the tech executives should testify in public.

Sen. Josh Hawley, R-Mo., said he would not attend what he said was a "giant cocktail party for big tech." Hawley has introduced legislation with Sen. Richard Blumenthal, D-Conn., to require tech companies to seek licenses for high-risk AI systems. "I don't know why we would invite all the biggest monopolists in the world to come and give Congress tips on how to help them make more money and then close it to the public," Hawley said.

Xylazine spreads to every region of US, says Millennium Health

SAN DIEGO, Sept 14: According to the Millennium Health Signals Report the powerful, veterinary tranquilizer xylazine—also known as "tranq"—was detected in urine drug tests from every region of the country, with the highest rates in the Eastern US. This analysis of the nationwide spread of xylazine is the most current and substantiative to date since xylazine use rose to prominence.

Increased awareness of the threats posed by xylazine is needed among clinicians and public health officials across the U.S. and geographical changes in xylazine use should be monitored closely with timely and reliable sources of surveillance data," says Scott Walton, CEO. "Although xylazine use among those who use fentanyl is currently concentrated in the East, a 2022 DEA report suggested that xylazine appears to be following the same east-to-west path as fentanyl. Time will tell if this becomes the case. We will continue to closely monitor xylazine and provide real-time updates about any shifting use as part of our commitment to help prevent drug overdose deaths.

According to Leonard Kamen, DO, Clinical Associate Professor of Physical Medicine and Rehabilitation, Sidney Kimmel Medical College, Thomas Jefferson University Hospital, Philadelphia, "Xylazine has devastated our local community. The challenges it has brought are many because at present there are no treatments specifically approved for xylazine use nor any xylazine-specific overdose reversal agents approved for xylazine-involved overdoses. Clinicians should carefully monitor patients who report unusual drug effects when taking what they thought was fentanyl, or those who have the telltale skin wounds associated with xylazine use.

Use

The report also identified that the use of multiple substances (i.e., polysubstance use) is significantly higher among those testing positive for fentanyl and xylazine compared to those who had used fentanyl but not xylazine. Specifically, prescription opioid, heroin, gabapentin, benzodiazepine, cocaine, fentanyl analogue, and methamphetamine use were all greater among those who had used fentanyl and xylazine.

"This is a substance no human being was meant to ingest and often people may be exposed to it without their knowledge, which increases the risk. Though the effects of xylazine cannot be reversed using naloxone, xylazine often is used alongside opioids, which naloxone can reverse, so it should be administered in a suspected overdose," said Chief Clinical Officer Dr. Angela G. Huskey at Millennium Health. "This is a dangerous situation, and it's spreading rapidly. We are trying to sound the alarm on the need to integrate clinical monitoring into our national response so we can provide advance warning and know in real-

time where people need help."

'RSO-021' may block, reverse progression of mesotheliomas

CAMBRIDGE, Mass, Sept 14: RS Oncology, a clinical stage biotechnology company developing innovative therapies to eradicate mesothelioma and other diseases, was part of a collaboration that recently shared new preclinical data at the IASLC 2023 World Conference on Lung Cancer in Singapore. The data, presented by Dr. Dean Fennell, represented a partnership between RS Oncology and other lead research institutions, including the University of Leicester and the Cunniff Laboratory at the University of Vermont Cancer Center.

Mesotheliomas can transform from a less aggressive epithelioid malignancy to a more aggressive sarcomatoid form. Using biphasic mesotheliomas as a model containing both epithelioid and sarcomatoid features, investigators at the University of Leicester, led by Dr. Fennell, conducted a geospatial analysis of patient tissues to explore the molecular signatures associated with the histological regions.

Using sophisticated spatial analysis tools coupled with machine learning approaches, the group found that the more aggressive sarcomatoid regions had distinct molecular signatures driving pro-tumor pathways, drug resistance, and increased metastatic poten-

Increased

These findings were validated across an independent cohort of 150 mesothelioma patient tissues. Notably, tumor regions containing sarcomatoid tissue showed features of increased resistance to oxidative stress – a critical tumor cell adaptation for survival.

In collaboration with Dr. Brian Cunniff's laboratory, the team then evaluated molecular signatures of human biphasic mesothelioma tumor cells following treatment with the irreversible PRX3 inhibitor RSO-021, which is currently being evaluated in a Phase 1/2 clinical trial in patients with malignant pleural effusion caused by advanced/metastatic solid tumors (NCT05278975). RSO-021 treatment reversed the gene signatures associated with epithelial-to-sarcomatoid transition, including downregulation of hypoxia, glycolysis, and epithelial-tomesenchymal transition (EMT)-associated genes. These results suggest that this transition, thought to be unidirectional in nature, may be PRX3-dependent, druggable, and now reversible.

"Sarcomatoid tumors are highly resistant to anti-cancer therapies, and many patients run out of available treatment options. Our findings might have unveiled a druggable 'Achilles Heel' against this terrible disease," said Dr. Fennell, presenting author on the study. "The ability to treat such tumors with RSO-021 and revert them to epithelioid malignancies could delay or even prevent emergence of the most aggressive features associated with mesothelioma. Further, RSO-021 could potentially sensitize them to other treatments."

Nurse Lindsay gets first new updated 'COVID-19 vaccine'

NEW HYDE PARK, NY, Sept 14: The first American to receive the CO-VID-19 vaccine in 2020 repeated the feat again as part of a public health awareness event. Sandra Lindsay, RN, became a global phenomenon on Dec 14, 2020, when the Northwell Health critical care nurse director received the Pfizer-BioNTech COVID-19 vaccine.

Nearly three years later, Nurse Lindsay volunteered to be the first American to receive this season's shot: Pfizer-BioNTech 2023-24 COVID-19 vaccine. This mRNA formulation offers protection against BA.2, BA.2.86 "Pirola," EG.5 "Eris," XBB.1.5 COVID variants – needed immunity as COVID hospitalizations begin to rise ahead of the fall and winter season.

Despite serving on the front lines of the pandemic, Nurse Lindsay has yet to be infected with COVID-19. "It's important that people understand that COVID is still around and can still severely affect an individual," said Nurse Lindsay. "Having worked through the darkest days of the pandemic and seen the devastating effects it can have, I tell people not to take chances. We have powerful weapons like vaccines to prevent those devastating outcomes."

This was the third COVID-19 vaccine – and sixth, including boosters – taken by Nurse Lindsay, who has since been elevated to the role of vice president of public health advocacy at Northwell. The FDA approved Pfizer's vaccine on Monday followed by the CDC's Advisory Committee on Immunization Practices on Tuesday

munization Practices on Tuesday.

Michelle Chester, FNP-BC, DNP, senior director of Employee Health Services at Northwell, administered the shot. She also gave Nurse Lindsay the vaccine in 2020. Also joining Nurse Lindsay in receiving vaccinations were: Adam Berman, MD, associate chair of emergency medicine at Long Island Medical Center in New Hyde Park; Mozhdeh Mehrabian, a

"Vaccination is and has proven to be an important tool to fight against the severity of COVID-19," said Jill Kalman, MD, chief medical officer and deputy physician in chief at Northwell Health. "We're here now to reinforce that there is extra protection available against the newest COVID-19 variants as the FDA and CDC have approved a new seasonal vaccine."

Northwell has administered about 800,000 doses of COVID-19 vaccine since the end of 2020. The FDA and CDC have said the vaccine is safe and effective for anyone ages 6 months and older. Northwell Health will offer both Pfizer and Moderna vaccines to its employees and the general public through

Gannett, which owns more than 200 daily papers, will employ these new hires through USA Today and The Tennessean, the company's Nashville-based newspaper. The chain is looking for "modern storytellers" adept in print, audio and visual journalism, said Michael Anastasi, the Tennessean's editor and Gannett's vice president for local news.

'Seeing both the facts and the fury, the Taylor Swift reporter will identify why the pop star's influence only expands, what her fanbase stands for in pop culture, and the effect she has across the music and business worlds," the company said in its job description.

Similarly, the company wants a journalist who can capture Beyoncé Knowles-Carter's effect on society and the industries in which she op-

Anastasi said the Tennessean already has a three-person music team and "I put our sophisticated coverage up against anybody." Gannett is always looking for opportunities to make itself essential for paying customers, he said

Critics of the new roles cited layoffs at Gannett, where the workforce has shrunk 47% in the last three years due to layoffs and attrition, according to the NewsGuild. At some newspapers, the union said the headcount has fallen by as much as 90%. Last year alone, Gannett cut about 6% of its roughly 3,440-person US media division. Some journalists said that while hiring these massively popular

artist-specific roles reflect their influence in pop culture, they do fail to invest in local journalism at a company known for its local dailies. Some journalists criticized the job listings for presenting superfan behavior as a full-time journalism job. Music writer Jeremy Gordon

said on social media that it "doesn't feel great to see 'full-time stan' go out as an actual journalism job." Stan is slang for "superfan." If the hire acts more like a fan than a journalist, the decision could

backfire on Gannett. But if the job is done well, and the reporters can penetrate tightly-controlled operations to glean insights, they can establish themselves as national authorities on important cultural figures.

Positive

Omise'eke Tinsley, academic and author of "Beyoncé in Formation: Remixing Black Feminism," says this type of role makes space for more positive stories about Black women.

But also, she adds, the existence of both jobs directly reflects Beyoncé and Swift's economic power. "If there wasn't that component to it, there wouldn't be a Beyoncé reporter," Tinsley said.

It is not uncommon for journalists to develop a beat on a specific figure, particularly in politics - as evidenced by Amy Chozick, who the New York Times hired in 2013 to cover Hilary Clinton exclusively.

But most entertainment journalists are responsible for reporting on a wide range of talent - even if they are subject matter experts on a specific artist.

That was the case for Los Angeles Times reporter Suzy Exposito, who called herself an "unofficial" beat reporter on popular reggaetonero Bad Bunny because she spent a disproportionate amount of time in

a previous job covering him compared to other priorities. She said a major challenge for entertainment journalists is the sheer volume of releases from pop artists. "The business of music is a numbers game," Exposito said. "Hit records become deluxe editions become sold-out world tours, and it can be dizzying for a general music journalist to keep up.

So, are artist-specific jobs the future of music journalism?

If a reporter takes the job seriously and provides more than breathless concert coverage, their established expertise could be valuable for a news organization, Grode said. Still, there are very few musicians who have such a wide cultural reach.

The likelihood of fans to click on stories about Swift or Beyoncé makes it an obvious motivating factor in designing the new jobs, Ex-

Top artists prioritize the attention and work of expert reporters, leading to what critic Soraya Roberts has called a "culture of sameness " - yet another barrier to local arts coverage.

Branagh crafts a 'beautiful' horror film

'Haunting in Venice,' sumptuously spooky

LOS ANGELES, Sept 14, (AP): Kenneth Branagh indulges in the kind of macabre theatricality that only a crumbling Venetian palazzo on a stormy Halloween night can provide in "A Haunting in Venice."

Moviegoers probably long ago made up their mind one way or another about Branagh's stately and flawed Hercule Poirot franchise, but should there be any curiosity left for this third installment is worth it. It is spooky, fun and features Tina Fey, looking smart and sleek in post-war suits as the fast-talking author of wildly successful whodunnits who says things like "I'm the

smartest person I know" in a mid-Atlantic accent. Set in 1947 on a particularly foggy night in the city of canals, "A Haunting in Venice" is beautiful to look at, with costumes by Sammy Sheldon, production design by John Paul Kelly and cinematography by Haris Zambarloukos. And it's embellished with moody but palatable scares that feel reminiscent of classics like "The Innocents" and "The Others," that are enhanced by Hildur Guðnadóttir's score. In other words, this might not excite a "Saw" enthusiast, but for the more easily scared and skittish it hits just the right notes.

Agatha Christie takes a bit of a backseat here, as Branagh and screenwriter Michael Green take only the loosest inspiration from her 1969 book "The Hallowe'en Party" for their haunting, firstly by moving it to Venice. It's where Poirot has chosen to live out his self-imposed retirement (an enviable exile if there ever was one). His whereabouts are hardly a secret though desperate folks line up outside of his picturesque apartment hoping he'll take a stab at their cases. But for now, a handsome Italian bodyguard (Riccardo Scamarcio) is there to make sure they don't get close enough to ask.

Fey's Ariadne Oliver gets through the gates, though, with a different kind of offer: She wants Poirot to accompany her to a séance. This medium, she says, appears to be the real deal and only he'll be able to figure out if it's all a trick. Soon he, reluctantly, finds himself at a Halloween party for the city's orphans, held by a famous opera singer, Rowena, (Kelly Reilly) with a famously dead daughter whom they hope to contact later that evening when the children depart.

Branagh recruited a few of his "Belfast" stars into this ensemble, including Jamie Dornan as doctor still haunted by the war and Jude Hill as his precocious son Leopold. Camille Cottin is a housekeeper, Kyle Allen is the dead girl's ex-fiancé, and Michelle Yeoh is the theatrical medium Mrs. Reynolds, who seems to be having a grand time chewing the scenery as a possible femme fatale. It is a distinct shift in tone from the previous films - sadder and more serious, with grief and death everywhere. Even before Alicia's mysterious death (off a balcony, into the canal with a horrific scrape on her back) the grand palazzo had a body count: Ît's where doctors are said to have locked up children to die during the plague.

Phenomena

And this crew is in for a long, stormy, claustrophobic night with finger pointing, more deaths and some inexplicable phenomena at play. Poirot's existential crisis is probably the least interesting aspect of the whole thing, despite its centrality to the plot, but Branagh doesn't waste too much of his time diving into those self-indul-

Maybe Branagh should have been leaning more into horror this whole time with this franchise. Or maybe it's a case of underestimating a director whose work is prolific and not always personal. It can be hard to take stock of a filmmaker's career when they've made great Shakespeare and Cinderella adaptations as well as 'Thor" and "Artemis Fowl." But it's always a pleasant surprise when it works as "A Haunting in Venice" very much does.

"A Haunting in Venice," a 20th Century Studios release in theaters Friday, is rated PG-13 by the Motion Picture Association for "some strong violence, disturbing images and thematic elements." Running time: 107 minutes. Three stars out of four.

Trump's 1st interview

'60 Minutes' expands to 90 Minutes for fall

NEW YORK, Sept 14, (AP): The iconic stopwatch won't be reset, but for six episodes this fall, "60 Minutes" will become 90 minutes.

The CBS newsmagazine is stretching on some Sundays when CBS airs an NFL doubleheader, starting Oct. 8. Often, the show doesn't air until 7:30 p.m. on the East Coast those nights (it usually starts at 7 p.m.).

The request to Bill Owens, the show's executive producer, came from top CBS executive George Cheeks, and predated the strikes that have paralyzed Hollywood and left networks looking for more content. Owens said he needed to weigh whether the three extra hours across the six episodes would dilute

the broadcast.



"My job is to protect the place," he said. "I don't ever want to harm a hair on the head of '60 Minutes.'

There will generally be two extra pieces on the 90-minute nights, and correspondents are already lobbying for more time to tell their stories. Extra producers have been brought in. Owens said the additional stories would likely lean to-

ward feature or adventure fare, like one Bill Whitaker is preparing about a motorcycle race on the Isle of Man in the Irish Sea.

More than a half century in, "60 Minutes" remains the most popular show in television news. It averaged close to nine million viewers each week last season, ranking first among non-sports, prime-time programs in live viewing, seventh when a time-delayed audience of up to a week is added, the Nielsen company said.

The show's stories get an additional 15 million views each week on various digital platforms, CBS said. That's a different measurement than "viewers," however, and doesn't necessarily correspond to 15 million extra people.

"60 Minutes" has almost completely turned over its correspondent corps since its glory years, with Lesley Stahl remaining as the elder stateswoman. She began in 1991.

Stories

The latest newbie is former ABC correspondent Cecilia Vega, who joined earlier this year. A bit starstruck, she admits that "I still take videos and send them to my mom when I'm walking around the hallways in my office.'

She spoke via phone from Poland, where she is working on what she expects will be one of the most important stories in her career, about Ukrainian children who were kidnapped and sent to Russia during the war. She was following one woman who had been working for months to retrieve a relative.

"We are telling what is going on in the war through the eyes of women and children," she said, "and I can't think of anything that is more gut-wrenching."

Owens said that "60 Minutes" has eight stories about the war in Ukraine in the works for its 56th season, which starts Sunday. Besides Vega, Whitaker and Scott Pelley - who won an Edward R. Murrow award for four stories he has done from the war - are

The show is keeping a close eye on how American money is being spent in Ukraine, for example, and examining how the country's arts and culture has been affected by the Russian invasion.

"We're doing shows about the entirety of the country so people have a sense of what it's like when you're invaded," Owens said.

The attention is intentional. Owens, entering his fifth year as the newsmagazine's top executive, said he believed the Russian invasion of a neighbor in Europe is not getting enough coverage in the US media, either because it's too expensive to devote resources or executives are worried that viewers are getting fatigued about the topic.

The show is not trying to send a political message at a time some are questioning how much American resources should be devoted to the effort, he said.

"The thing that's inspired me the most is the people of Ukraine and their resilience," Whitaker said.
"They refuse to be bowed. They refuse to be knocked down. ... It's almost a defiant normalcy.

Besides Whitaker, Stahl, Vega and Pelley, the current "60 Minutes" correspondent team includes Sharyn Alfonsi, Anderson Cooper and Jon Wertheim.

Owens, who began with "60 Minutes" in 2003 as a producer with Pelley, said he often keeps some of the show's legends in mind when running the broadcast - such as Morley Safer, who died in 2016 eight days after announcing his retirement following 46 years as a correspondent.

"I think, often, about what Morley would think about a story because Morley would give it to you right between the eyes and tell you the truth," he said. "I think Morley would be proud of this show."

WASHINGTON: Former President Donald Trump will give his first broadcast network interview since leaving office, sitting down this week with Kristen Welker as she debuts as host of NBC's "Meet the

The network said in a release that the interview will be pre-taped at Trump's Bedminster, New Jersey, golf club Thursday and that the same invitation had been extended to President Joe Biden. Trump last appeared on the show in 2019.

The former president has largely steered clear of mainstream media interviews during his third campaign for the White House. Instead, he frequently calls in to conservative podcasts, radio shows and far-right cable outlets, and shares his thoughts in posts and videos on his Truth Social site.

The interview comes as Trump remains the clear front-runner for the Republican nomination, even after being indicted four times on a slew of charges, including many connected to his efforts to try to overturn the results of the 2020 election.

Trump will also be appearing Thursday on former Fox News host **Megyn Kelly**'s SiriusXM show. The interview, taped Wednesday in New Jersey, will be her first with him since the 2016 campaign. Trump and Kelly memorably clashed during a 2015 Republican primary debate, when Kelly pressed him on his history of derogatory comments about women.

Welker is set to debut as host of "Meet the Press" this Sunday, taking over from Chuck Todd.

Trump has previously praised Welker's performance moderating the second presidential debate between him and Biden in 2020.

NEW YORK: Incoming music director Gustavo Dudamel will conduct the New York Philharmonic at its spring gala on April 24, the orchestra said Tuesday as it announced a \$40 million gift from cochairman Oscar L. Tang and wife Agnes **Hsu-Tang** that will endow his position.

Dudamel was hired in February to become the Philharmonic's music director for the 2026-27 season. He conducted the orchestra last May in three performances of Mahler's Ninth Symphony but was not scheduled to lead it in the 2023-24 season which opens Sept 27. The program of Dudamel's concert was not announced.

As part of the gift, the music director will become The Oscar L. Tang and H.M. Agnes Hsu-Tang Music and Artistic Director Chair starting with the 2025-26 season, when Dudamel becomes music director designate.

The 42-vear-old Dudamel has been music director of the Los Angeles Philharmonic since 2009, a tenure that will end after 17 seasons when he starts in New York. He quit as music director of the Paris Opéra in May, two seasons into a six-year contract scheduled to run through the 2026-27 season.

Oscar Tang, 85, has been part of the philharmonic board since 2013 and has been co-chairman with Peter W. May, since 2019. Tang was CEO of the asset management company Reich & Tang for 20 years before retiring in 1993. (AP)

NEW YORK, Sept 14, (AP): Celebrity stylist Law Roach has refilled his cup, emerging out of retirement this week for a New York Fashion Week collaboration with luxury Indian fashion brand Falguni Shane Peacock.

The New York It Girl-meets-Mumbai collection shown Monday blended Falguni Shane Peacock's opulent craftsmanship of sequin embroidery and delicate flower detailing with Roach's edgy vision of black baseball caps, hoop earrings and bold golden bangles.

As creative director for the collection, the image architect (a term Roach trademarked) delivered once again. Roach may be into his sixth month of "retirement," but his stardom shows no signs of slowing down.

He sent shock waves through the fashion industry in March, when he announced in a since-deleted Instagram post that his "cup was empty" and that he was tired of the "politics and lies" of celebrity styling.

Now, he says, he is only taking on work that fills his cup.

"Moving forward I will only do certain things that I really feel like will feed me," he told The Associated Press. "And this was one of those

Each piece Monday exuded the chic and glamorous style that Roach and his clients like Zendaya have made famous. Roach, one of the few Black stylists in Hollywood, has dressed everyone from Ariana Grande to Celine Dion to Megan Thee Stallion and is often credited with bringing some of the best looks to red carpets.

Roach wore a red pleated skirt with a white button-up shirt and a dupatta over his shoulder as he gleefully strutted in his Air Jordans with the designers at the end of the show, his waistlength straight black hair flowing behind him.

Falguni Peacock said Roach brought a "cool girl" vibe to the collection. After eight years, the husband-and-wife designers returned to New York Fash-

ion Week to showcase their "2.0" collection and, much like Roach, the reinvention of their brand. Sarah Jessica Parker recently wore an eye-catching Falguni Shane Peacock lehenga and choli on an episode of "And Just Like That," and the duo were co-hosts of a

ritzy Diwali gala last year in the city.

At Spring Studios, models catwalked down the runway in looks that could easily be worn off the subway to a gala, from gray sweatpants paired with a shimmery silver beaded blazer or an oversized gray sweatshirt with bubblegum pink feathered skirt or embroidered sheer bottoms

Since announcing his retirement, Roach has not strayed far from his fashion roots. A day after his retirement post, he modeled in a show for Hugo Boss. He continues to work as a stylist with Zendaya, whom he calls family.

But he's focusing on himself and his mental health.

"What I learned in the months, I learned how to truly love myself and I learned that happiness is a habit, and you have to work on it," he said.

Roach got his start in fashion by collecting women's vintage and then opening a store in Chicago where Kanye West would frequent. He went

on to make a name for himself as a celebrity stylist taking on several celebrity clients, including Zendaya, whom he transformed from a former Disney star into a style icon. The duo went onto collaborate on the brand Daya by Zendaya and on Tommy Hilfiger's Tommy x Zendaya collection, where Roach served as creative director. Encouraging interest in coding and other STEM (science, technology, engineering and math) disciplines has become increasingly important throughout education, especially after students' science and math test scores declined during the pandemic.

Bob Hughes, director of K-12 Education for the Bill & Melinda Gates Foundation's United States Program, recently told The Associated Press that improving STEM education is a high priority for the nonprofit, which is not connected to Clover, but last year donated \$1 billion to improve math education in the next four years.

"Math is a such a gatekeeper for future success — and not just success for becoming a physicist, but for your day to day life," Hughes said. "It's a very tough subject for many kids. It's emotional for many kids. And if they don't succeed in mathematics, they can start to develop a mindset and an identity that suggests that not only are they not good at math, but at other academics as well. So math is fundamental.

Clover was developed to help with those fundamentals by increasing students' exposure to subjects like math and science in a less stressful, more entertaining way, Bramble said.

"The pandemic was an inflection point showing what kids need today," she said. "We feel that Clover can support a way to catch up, but it can't do it alone. It's so valuable to have an in-person program that goes along with it — the mentoring aspect that comes with 4-H. It helps bring that sense of belonging that helps a young person catch up to where they need to be." (AP)

'Planet is sick'

Earth past its almost all 'safe limit' for humans

NEW YORK, Sept 14, (AP): Earth is exceeding its "safe operating space for humanity" in six of nine key measurements of its health, and two of the remaining three are headed in the wrong direction, a new study said.

Earth's climate, biodiversity, land, freshwater, nutrient pollution and "novel" chemicals (human-made compounds like microplastics and nuclear waste) are all out of whack, a group of international scientists said in Wednesday's journal Science Advances. Only the acidity of the oceans, the health of the air and the ozone layer are within the boundaries considered safe, and both ocean and air pollution are heading in the wrong direction, the study said.

"We are in very bad shape," said study co-author **Johan Rockstrom**, director of the Potsdam Institute for Climate Impact Research in Germany. "We show in this analysis that the planet is losing resilience and the patient is sick."

In 2009, Rockstrom and other researchers created nine different broad boundary areas and used scientific measurements to judge Earth's health as a whole. Wednesday's paper was an update from 2015 and it added a sixth factor to the unsafe category. Water went from barely safe to the out-ofbounds category because of worsening river run-off and better measurements and understanding of the problem, Rockstrom said.

These boundaries "determine the fate of the planet," said Rockstrom, a climate scientist. The nine factors have been "scientifically well established" by numerous outside studies,

If Earth can manage these nine factors, Earth could be relatively safe. But it's not, he said.

In most of the cases, the team uses other peer-reviewed science to create measurable thresholds for a safety boundary. For example, they use 350 parts per million of carbon dioxide in the air, instead of the Paris climate agreement's 1.5 degrees (2.7 degrees Fahrenheit) of warming since preindustrial times. This year carbon in the air peaked at 424 parts per million.

Biodiversity

The nine factors are intermingled. When the team used computer simulations, they found that making one factor worse, like the climate or biodiversity, made other Earth environmental issues degrade, while fixing one helped others. Rockstrom said this was like a simulated stress test for the

The simulations showed "that one of the most powerful means that humanity has at its disposal to combat climate change" is cleaning up its land and saving forests, the study said. Returning forests to late 20th century levels would provide substantial natural sinks to store carbon dioxide instead of the air, where it traps heat, the study said.

Biodiversity - the amount and different types of species of life - is in some of the most troubling shape and it doesn't get as much attention as other issues, like climate change,

"Biodiversity is fundamental to keeping the carbon cycle and the water cycle intact," Rockstrom said. "The biggest headache we have today is the climate crisis and biodiversity crisis.

University of Michigan environmental studies dean Jonathan Overpeck, who wasn't part of the study, called the study "deeply troubling in its implications for the planet and people should be worried.

"The analysis is balanced in that it clearly sounds a flashing red alarm, but it is not overly alarmist," Overpeck said. "Importantly, there is hope.

The fact that ozone layer is the sole improving factor shows that when the world and its leaders decide to recognize and act on a problem, it can be fixed and "for the most part there are things that we know how to do to improve the remaining problems, said Carnegie Mellon chemistry and environment professor Neil Donahue.

Some biodiversity scientists, such as Duke's Stuart Pimm, have long disputed Rockstrom's methods and measurements, saying it makes the results not worth much.

But Carnegie Mellon environmental engineering professor Granger Morgan, who wasn't part of the study, said, "Experts don't agree on exactly where the limits are, or how much the planet's different systems may interact, but we are getting dangerously close.

"I've often said if we don't quickly cut back on how we are stressing the Earth, we're toast," Morgan said in an email. "This paper says it's more likely that we're burnt toast.

PARIS: France is sending military forces to distribute water on the French Indian Ocean territory of Mayotte, which is facing an unprecedented water crisis prompted by the island cluster's most severe drought in decades.

Troops with the French Foreign Legion and French navy based in the region will work with local authorities to ensure water supplies to local populations, the Defense Ministry said in a statement on Thursday.

Authorities have ordered water cuts two days out of three on Mayotte, a territory northwest of Madagascar that is the poorest part of France. The water woes come on top of migration tensions around people arriving from the neighboring

Residents protested Saturday outside the Mayotte water management headquarters, carrying banners reading "Mayotte is Thirsty!", according to local media reports. When the water taps are working, families fill up buckets and tubs as they can, but supplies quickly run low, especially in more remote areas.

Around 30% of the population doesn't have access to running water at home, according to regional health authorities. They have noted an increase in the number of people suffering diarrhea, and diseases such as typhoid were already far more widespread than in mainland France.

Authorities appointed a special "water prefect" this summer to deal with Mayotte's most severe drought since 1997. Insufficient rainfall resulted in low water levels in reservoirs that residents rely on to get through the dry season from May to November.

MADRID: Spain this year recorded its third hottest summer since official records began 62 years ago, authorities said Thursday, with temperatures peaking at 46.8 C (116 F) as the country's severe drought dragged on.

The average summer temperature was 1.3 degrees Celsius (2.34 degrees Fahrenheit) above normal, the Spanish weather agency AEMET said.

The World Meteorological Organization said last week that last month wasn't only the world's hottest August scientists ever recorded by far. It was also the second hottest month measured after July 2023.

Since 1961, mainland Spain's average temperature has risen 1.6 degrees C (2.88 degrees F), according to AEMET. Spain's two hottest summers were in 2022 and 2003.

This year's January-August period in Spain equaled the same periods in 2022 and 2020 as the country's hottest ever recorded over those months, AEMET said.

At the same time, this summer was the rainiest since the turn of the century, AEMET said, though most of Spain is still in the grip of an extended drought. Northeast Spain is enduring its most extreme drought since records began.

Also, between January and August Spain's coastal waters heated up more than ever previously recorded, according to

Van Gogh painting recovered: More than three years after it was stolen from a museum that was shut to prevent the spread of the coronavirus, a painting by Dutch master Vincent van Gogh has been recovered, a little worse for wear, the Groninger Museum in the Netherlands

said Tuesday. Van Gogh's "The Parsonage Garden at Nuenen in Spring," which was painted in 1884, was snatched in an overnight raid in March 2020 from The Singer Laren museum east of Amsterdam. It was there on loan from the Groninger Museum.

"The Groninger Museum is extremely happy and relieved that the work is back. its director, Andreas Blühm, said in a statement. "We are very grateful to everyone who contributed to this good out-

The museum paid tribute to Dutch art sleuth Arthur Brand for his "key role in

It declined to provide further details about how it was found. It said "the painting has suffered, but is - at first glance - still in good condition." The work will be scientifically examined in coming months. It's being kept temporarily at the Van Gogh Museum in Amsterdam.

Its value was not provided. On the rare occasions when Van Gogh's paintings come up for sale, they fetch millions at auction. However, an insurance company had paid the Groninger Museum for the loss and is now the formal owner, although the museum says it will exercise

its right to first purchase of the work. It said that it hopes to have "The Parsonage Garden at Nuenen in Spring" back on display soon, although this "could take weeks, if not months.

The 25-by-57-centimeter (10-by-22inch) oil on paper painting shows a person standing in a garden surrounded by trees, with a church tower in the background.

It dates to a time when van Gogh had moved back to his family in a rural area of the Netherlands and painted the life he saw there, including with his famous work "The Potato Eaters," in mostly somber tones.

Later, he moved to southern France. where he developed a far more colorful, vibrant style of painting as his health declined before his death in 1890. (AP)

'No sign of COVID mandates in US'

Americans can get 'updated' shot

NEW YORK, Sept 14, (AP): As Americans fend off a late summer COVID-19 spike and prepare for a fresh vaccine rollout, Republicans are raising familiar fears that governmentissued lockdowns and mask mandates are next.

It's been a favorite topic among some of the GOP's top presidential contenders. Florida Gov. Ron DeSantis told reporters that people are "lurching toward" COVID-19 restrictions and "there needs to be pushback." South Carolina Sen. Tim Scott posted online that the "radical Left" seeks to bring back school closures and mandates. And former President Donald Trump urged congressional Republicans to stop the Biden administration from bringing back COVID-19 "mandates, lockdowns or restrictions of any kind."

"The radical Democrats are try-ing hard to restart COVID hysteria," Trump told supporters in Rapid City, South Dakota, during a recent campaign stop. "I wonder why. Is there an

election coming up by any chance?" While some individual schools and colleges have implemented temporary mask requirements, there is no sign that anyone in federal or state leadership is considering widespread COVID-19 restrictions, requirements or mask mandates. The administrations of several Democratic governors denied that any such moves are even under discussion. The overriding sentiment is to leave the decisions to individuals.

"No COVID-19 public health restrictions or mask requirements are being considered by the Murphy administration," said Christi Peace, spokesperson for New Jersey Gov. Phil Murphy.

"There are no impending mass lockdowns or mask mandates for New Mexico," said Jodi McGinnis Porter, spokeswoman for the New Mexico Department of Public Health.

It was largely the same message from Democratic governors' offices in several other states that responded to an inquiry about whether any COV-ID-19 mandates were under consideration. That included Connecticut, Kansas, Louisiana, Massachusetts. Michigan and Oregon.

Pennsylvania Gov. Josh Shapiro, a Democrat, made clear his opposition to COVID-19 lockdowns as well as mask and vaccine mandates when he was campaigning for office last year: "This is an area where I think folks got it wrong," he said of school and business shutdowns. His office echoed the

In the two most populous Democratic-led states, California and New York, the state health departments recommend getting the updated vaccine, but have no requirements for the shot or mask wearing. New York Gov. Kathy Hochul was asked during a news conference Wednesday about whether she would consider mask or vaccine mandates: "We are in a place where we're seeing low numbers; not requiring such actions today," she said.

Elisabeth Shepard, spokesperson for Oregon's Democratic governor, Tina Kotek, noted that the federal public health emergency for the virus outbreak ended in May

"Currently, COVID-19 lockdowns and mask mandates are not being discussed and the governor has no plans to institute these measures," she said.

Still, the misleading narrative has proven a convenient scare tactic for Republicans in their efforts to woo voters who see Democrats as oppressive leaders targeting their freedoms.

The GOP presidential hopefuls hammering this message in the last week join a chorus of conservative lawmakers and far-right pundits who have spent the last month warning that tyrannical COVID-19 measures are looming.

In August, conspiracy theorist Alex Jones claimed an anonymous "highlevel manager in the TSA" and an unnamed "Border Patrol-connected" source told him that Transportation Security Administration workers would soon need to wear masks and that COVID-19 lockdowns would return in December.

The US Centers for Disease Control and Prevention said the claims were "utterly false," but they still were amplified by influential Republicans, including Rep. Lauren Boebert of Colorado, who posted on X that she wrote to the TSA demanding answers.

Later last month, when a Black liberal arts college in Atlanta announced it had reinstated a temporary mask mandate in response to student infections, Rep. Marjorie Taylor Greene, a Republican from Georgia, posted on X that "Americans have had enough COVID hysteria. We Will Not Com-

"We now have a range of tools for people to protect themselves from the impact of COVID-19, including vaccines, at-home testing and treatments. Masking is one of several steps people may choose to take to protect themselves if they wish."

Reinstated mask requirements across the country have so far been limited to a handful of local schools and businesses. One example is a Maryland elementary school that required students who were exposed in a classroom's outbreak to wear masks at school for 10 days.

But these isolated measures have sparked outrage from conservatives who have used them to energize their supporters.

Sen. J.D. Vance of Ohio last week unveiled the "Freedom to Breathe Act," a bill that would block the federal government from imposing mask mandates for domestic flights, public transit and schools.

NBA takes steps to try to ensure its star players appear in more games

NEW YORK, Sept 14, (AP): The NBA took steps Wednesday to try to ensure that its star players appear in more games, particularly nationally televised matchups and the in-season tournament that is being added this

The league's board of governors approved a new player participation policy that will take effect for this upcoming season, replacing the player

resting policy that was implemented prior to the 2017-18 season. The new rules focus primarily on star players - someone who has been an All-Star or on the All-NBA team in any of the prior seasons. three are 50 players who fit

into the star category. "It's a shared view by everyone in

the league, it's not just coming from the league office," NBA Commissioner Adam Silver said. "I think whether it's our teams, our players association, individual players, I think there's an acknowledgement across the league that we need to return to that principle that this is an 82-game league. ... I think there's a statement of principle that if you're a healthy player in this league, the expectation is that you're going to play. Increased player participation is a

top priority for Silver as the league negotiates a new media rights deal. The current deal ends in 2025.

Teams will have to manage their rosters to ensure only one star player is unavailable per game at the most.

"What we've tried to do as the league office is work through all the different issues recognizing the genuine concern from the fans and of course the media that's paying for the opportunity to broadcast those games," Silver said.

The league will have the ability to penalize teams that violate the policy by fining them \$100,000 for the first infraction and \$250,000 for the second. Each successive violation will increase by \$1 million.

The NBA also wants teams to maintain a balance between the number of

one-game absences a star player has at home and on the road, as well as refrain from any long-term shutdowns where a star player stops playing

The league will allow teams to submit written requests in advance for older players for back-to-back games. This is for a small pool of stars who are either 35 or older at the start of the season or have played in over 34,000 regular-season minutes or 1,000 games in their careers. LeBron James, Kevin Durant and Stephen Curry all fit in that category.

"The Players Association was very much a part of it," Silver said of discussions on the new policy. "We had extensive discussions with them and then with individual groups of players, particularly the veterans in the league, about how they thought we should be approaching it." Teams will be able to make other requests to have players miss games that include personal reasons, player's prior injury history and end-of-season flexibility.

A late collapse after the departure of Stokes ended with England all out for 368, with Trent Boult impressing with the figures of 5-51.

The New Zealanders were reduced to 70-5 after recalled seamer Chris Woakes (3-31) removed three of the top five in the batting order, and only Glenn Phillips (72 off 76 balls) went big before they were bowled out for

The tourists can only draw the series now, with England 2-1 up heading into the final match at Lord's on Friday. The teams shared their recent Twenty20 series 2-2.

Harry Brook, who is not in the provisional squad and is pushing to replace Roy or another batter, dropped out of the team to accommodate the return of Malan and has only made 25 and 2 in this series.

will be observed before the national anthems are played at the Stade Pierre Mauroy in the northern French city of Villeneuve-d'Ascq close to Lille. Authorities in Morocco have reported nearly 3,000 deaths and several thousand injuries after the earthquake that hit the country. In Libya, thou-

guay's first match in the tournament. New Zealand should rack up a pile of points against Namibia on Friday in the Rugby World Cup.

Poland is fourth in its five-team European Championship qualifying group - behind Albania, the Czech Republic and Moldova - after losing three of its five games so far, despite three goals from Robert Lewandowski. Poland is likely to land in the Euro 2024 qualifying playoffs in March.

MILAN, Sept 14, (AP): The Milan derby has the air of a title match even After scoring for Spain, Yamal seeks 1st goal with Barca at this early stage of the season. Both Inter Milan and city rival AC

Milan are off to perfect starts with three wins in three matches, with both playing an exciting style of soccer look set to light up the Italian league.

Both also recorded confidenceboosting victories before the international break, with Milan winning 2-1 at Jose Mourinho's Roma and Inter thumping Fiorentina 4-0.

The derby della Madonnina has always had a special atmosphere. But the intensity has ramped up even more over the past few seasons with both teams fighting for the Serie A title, which Inter won in 2021 only to be deposed by Milan the following season.

Inter has won five of the past six matches between the two, including both legs of their Champions League

semifinal last season. But after a glut of new arrivals in the offseason, who will emerge on top this campaign?

"Let's say that the derby is the perfect opportunity to find out," Christian Pulisic said in an interview with Italian newspaper Gazzetta dello Sport.

World Cup ref Yamashita among 1st women match officials at Asian Cup

KUALA LUMPUR, Malaysia, Sept 14, (AP): Referee Yoshimi Yamashita will return to Qatar to make more soccer history at the men's Asian Cup in January after she worked in the coun-

try last year at the men's World Cup. Yamashita is among five female match officials, including two referees, picked Thursday by the Asian Football Confederation to work in Qatar. The tournament runs form Jan. 12 to Feb. 10.

It is the first time the AFC has appointed female match officials for its marquee men's event.

Katherine Jacewicz of Australia was also picked among the referees. The assistants selected are Makoto Bozono and Naomi Teshirogi of Japan, and Kim Kyoung Min of South Korea.

The 24-team Asian Cup will be played in most of the same stadiums as the men's World Cup, where Yamashita served as the fourth official for six group games. Yamashita was one of three female referees picked by FIFA for the men's World Cup. Stephanie Frappert of France made history working the Germany-Costa Rica game in the group stage.

In April, Yamashita led the first allfemale team of match officials for a game in the J-League, Japan's top league.

The AFC said the video review system will be used for the entire tournament for the first time. At the 2019 tournament, video review started being used at the quarterfinal stage.

Marco Verratti left Paris Saint-Germain after 11 years at the club to join Al-Arabi in the Qatar Stars League on Wednesday. The 30-yearold Italy midfielder signed a three-year contract, Al-Arabi said. Financial terms were not released but French media estimated the transfer fee to be 45 million euros (\$48.3 million).

Pulisic, who turns 25 on Monday, came to Milan to revive his flagging club career after falling out of favor at Chelsea. He is among more than 10 new players Milan splashed cash on over the summer to try to wrestle the title back from Napoli.

"We are confident in the title race," he said. "We have strong players, really good players came in, there's a great mix of talent. We can win it, we just have to continue working hard and playing like this." Milan's powerful attack faces per-
