

Kuwait hits Iraq maritime pact ruling

Consensus seen

NEW YORK, Sept 19, (KUNA): Kuwait Minister of Foreign Affairs Sheikh Salem Abdullah Al-Jaber Al-Sabah denounced in the strongest terms the recent Iraqi Federal Court ruling over the issue of Khor Abdullah in which Kuwait and Iraq signed a 2012 agreement to regulate maritime navigation.

Speaking to KUNA late Monday on the sideline of the 78th session of the UN General Assembly, Sheikh Salem said that the Iraqi decision was based on ahistorical claims, affirming that he had reflected the State of Kuwait's stance on the issue during his meetings with GCC Foreign Ministers.

He reiterated Kuwait's stance during the GCC Foreign Ministers meeting with US Secretary of State Antony Blinken, affirming that the gathering came out with consensus of views on the issue

Sheikh Salem hoped that the Iraqi government would take necessary steps to handle the case and respect the sovereignty of the State of Kuwait and agreed upon treaties.

Sheikh Salem presented a narrative on a recent verdict by the Iraqi Federal Supreme Court, which canceled agreement on maritime navigation in Khor Abdullah, according to a press release from the Kuwaiti Foreign Ministry.

The agreement, ratified by parliaments of both Kuwait and Iraq in 2013, was lodged at the UN, the minister told the meeting, noting that Iraqi court ruling contained offending fallacies against the State of Kuwait.

On his part, Secretary Blinken said he understood Kuwait's stance on the agreement, stressing the US commitment to protection of Kuwait's security, safety, sovereignty and territorial integrity, as well as the security of the Gulf region.

The GCC-US meeting dealt also with regional topics of common interest, and strategic partnership between the GCC and the US, according to the statement.

Meanwhile, Deputy Kuwait Foreign Minister Ambassador Sheikh Jarrah Jaber Al-Ahmad Al-Sabah expressed late Monday Kuwait's firm stance on the Khor Abdullah agreement with Iraq, saying that the latter party's federal court took unnecessary decision based on ahistorical claims.

According to a Foreign Ministry statement, Sheikh Jarrah reflected Kuwait's stance on the matter during his participation in the GCC-UK meeting held on the sideline of the 78th UN General Assembly in New York.

Over 30,000 Libya flood refugees

GENEVA, Sept 19, (KUNA): United Nations High Commissioner for Refugees (UNHCR) announced on Tuesday that hurricane Daniel that ravaged Libya left out more than 30,000 refugees in the City of Derna, and 3,000 others in Ajdabiya.

This came in a virtual press conference where Assistant Chief of Mission Rana Ksaifi affirmed, "The situation on the ground is more than catastrophic with an unimaginable level of destruction, as homes, buildings, shops, hospitals and schools are almost completely submerged and thousands of people have lost everything.'

"UNHCR has records that include more than 50,000 persons in Libya who are seeking asylum, including those who were living in areas affected by the floods. In addition to 2,800 internally displaced people from eastern Libya who were settled in Derna and more than 3,000 in Ajdabiya, as the disaster elevated their suffering into a new level," she said.



make the right thing appear wrong. For this reason, the right things to do become rare in the corridors of falsehood, which has a thousand doors, to the point that if one of them comes out to be addressed, it will be like a missing child; rather, it is born with a thousand faults in it because the opportunists have exploited it to such an extent that it is almost dead.

There are many cases that have been waiting for a decision for three decades. Some of them have been consumed for a long time and drunk to the point of satiety, as if the parliamentarians and ministers were intending not to wake them from their slumber to avoid their negligence being exposed, or so that their political and financial investment in it is not exposed.

That is why there are projects that have passed more than four decades and are still subject to change orders, such as the university city. Some of them were scheduled to be completed within two years, but they are now entering their fourth year, and are still crawling on the path of implementation like a turtle, such as the new Kuwait Airport. Also, some of them have turned into shameful scandals such as roads.

Not to mention poor education, and other problems resulting from one another, as if Kuwaitis were doomed to spend their lives waiting for mirages, while many of them require the decision of a minister or the one above him to be bold, and not to a session of the National Assembly or to settlements, but rather it is at the core of the daily work of ministers.

In the majority of countries in the world that seek to rely on their own strength, arms deals are not managed by intermediaries who inflate prices artificially, as it did in some deals that were concluded in Paris hotels, the result of which was a scandal that exposed the money obtained by the middlemen when they disagreed on dividing the shares.

In reality, countries can contract directly with arms factories, and the cost ends up being much lower than what the middlemen and brokers put forward.

These are some examples that Kuwait suffers from, and is directly threatened by, either in financial or economic stability, and even social stability as well. which has become an occasion for political as well as financial investment, and is subject to deals. For example, the issue of co-education and efforts to prevent it. which indicates a struggle of wills, and the subjection of society to the vision of a group of parliamentarians who invest in it on all fronts

The talks focused on cooperation in the economic, investment and development areas, with a view to serving the interests of the peoples of both countries, UAE news agency WAM reported. (KUNA)

CAIRO: The 32nd meeting of the Arab League's customs and information committee started Tuesday at the headquarters of the General Secretariat, chaired by Saudi Arabia and the participation of representatives of the customs administrations in the Arab countries.

Chief of economic integration directorate at the League of Arab States, Bahjat Abu Al-Nasser said in his opening statement that the agenda would include a number of important topics. (KUNA)

DAMASCUS: Syria's President Bashar Assad will head to China later this week in his first visit to Beijing since the start of his country's 12-year conflict during which China has been one of his main backers, his office said Tuesday.

China has been expanding its reach in the Middle East after mediating a deal in March between Saudi Arabia and Iran, and it continues to support Assad in the Syrian conflict, which has killed half a million people and left large parts of the nation in ruins. (AP)

IDLIB, Syria: A Kurdish-led force attacked Turkish-backed opposition fighters in northern Syria on Monday, killing at least 13 of the militants, activists said.

The opposition activists blamed the Kurdish-led Syrian Democratic Forces for carrying out the assault, though the U.S.-backed group did not claim responsibility. (AP)

'Nightmare finally over'

Americans detained for years in Iran arrived home Tuesday, tearfully hugged their loved ones and declared "Freedom!" after being let go as part of a politically risky deal that saw President Joe Biden agree to the release of nearly \$6 billion in frozen Iranian assets.

The prisoners landed at Fort Belvoir, Virginia, with clap-ping and cheers heard in the predawn hours. Siamak Namazi, the first off the jet, paused for a moment, closed his eyes and took a deep breath before leaving the plane.

Loved ones, some holding small American flags, enveloped them in hugs and exchanged greetings in English and Farsi, the main language of Iran. "The nightmare is finally over," Namazi's brother, Babak,

said at the airport.

"We haven't had this moment in over eight years," he added, his arm around his brother and his formerly detained father, Baquer, who had been earlier released by Iran. "It's unbelievable." (AP)

Biden to emphasize Abraham Accords

More in US doubt Israel shares values

NEW YORK, Sept 19, (AP): As U.S. President Joe Biden prepares to meet Israeli Prime Minister Benjamin Netanyahu this week in New York, a new poll finds that while Americans generally view Israel as a partner or ally, many question whether his far-right government shares American values.

The poll results from The Associated Press-NORC Center for Public Affairs Research and the meeting come during a new period of tension between the Biden administration and Israel. Those tensions are caused by Netanyahu's proposed judicial overhaul that has sparked mass protests in major Israeli cities, ongoing disagreements over how to deal with Iran and how to approach the Palestinians, and comments from Netanyahu political allies that have irked U.S. officials.

Despite the friction, Biden, who spoke out in barely disguised opposition to the judicial plan, and Netanyahu are expected to project a solid partnership in which the U.S. continues to support Israel's security.

Biden will also emphasize that the U.S. is continuing to work on expanding the Trump-era Abraham Accords, which normalized Israeli relations with several Arab countries, to include Saudi Arabia. However, there is little sign of an imminent breakthrough on that front.

Although the poll showed that Americans overwhelmingly view Israel as more of a friend than a foe, it also found that they are divided on whether Israel is a country with which the U.S. shares common interests and values.

About 4 in 10 Americans described Israel as a partner with which the U.S. should cooperate, but they also said the country does not share U.S. interests and values, the poll found. Only about 3 in 10 said Israel is an ally that shares U.S. interests. Republicans (44%) are more likely than Democrats (25%) to call Israel an ally with shared values. About 2 in 10 Americans described Israel as either a U.S. rival or an adversary.

The U.S. provides Israel with more than \$3 billion a year in military and other assistance and the close relationship has endured over the decades despite not infrequent spats over policy, most notably over Iran and treatment of the Palestinians.

Overall, 61% of Americans disapprove of how Biden is handling the Israeli-Palestinian conflict, with only 35% approving. That number was slightly lower than Biden's overall approval rating.

PAM mulls over worker residency transfer without the sponsor approval

KUWAIT CITY, Sept 19: Dr. Fahd Murad, the Acting Deputy Director for the Protection Sector Affairs at the Public Authority for Manpower, stated that PAM is currently exploring the feasibility of enabling expatriate workers to transfer their residency directly from one employer to another without requiring the original employer's approval, reports Al-Jarida daily.

This would be permissible if it is confirmed that the sponsor has violated the terms and conditions specified in the employment contract or any provisions of Law No. (6/2010) concerning work in the private sector.

In a press statement during an introductory visual presentation organized by the Authority, Dr. Murad highlighted that the Authority is meticulously studying a set of procedures aimed at facilitating labor transfers between employers.

These procedures are designed to ensure a fair balance, respecting the rights of both employers and employees without infringing upon or overstepping legal boundaries. He emphasized that maintaining equity in the labor equation is a priority for the Authority.

Regarding potential amendments to the Private Labor Law, Dr. Murad clarified that while there haven't been any amendments thus far, the Commission is actively reviewing certain articles. They are collecting information and observations to determine the necessity of amending the law. He noted that the Commission consistently gathers feedback from diplomatic missions' representatives in Kuwait concerning their nationals' labor rights, ensuring a careful and swift response.

Addressing the recruitment of domestic workers, Dr. Murad underscored the government's policy to expand recruitment opportunities beyond a limited number of countries, aiming to accommodate workers from various markets. He revealed plans to sign new memorandums of understanding with several East Asian countries to meet the demand for domestic workers from citizens and residents

In terms of labor complaints, Dr. Murad mentioned the possibility for both workers and employers to schedule complaint submissions through the authority's electronic platform, streamlining the complaint process. Efforts are underway to enhance the complaint-handling procedures and mitigate any delays. Additionally, plans are in progress to create comprehensive individual worker files to aid in resolving labor disputes and disagreements.

Dr. Murad also discussed ongoing efforts to establish a shelter center for male expatriate workers, similar to the existing center for women in the Jleeb area. This initiative is part of a broader strategy to improve shelter services for trafficking victims, with collaboration and coordination with the International Labor Organization for studies, plans, and programs in this area.

Colonel Abdulaziz Al-Kandari, the Colonel in the Residency Affairs Investigations at the Ministry of Interior, highlighted that a recent operation resulted in the apprehension of a company engaged in human trafficking, responsible for bringing in over 2,000 expatriate workers.

The company coerced these workers into obtaining loans and extorted money from them to waive malicious absenteeism reports, ultimately leading to legal actions taken by the Public Prosecution against the perpetrators.

Details sought on 'MEW' hackers

'What are you doing to curb drugs spread?'; 3 ministers queried

KUWAIT CITY, Sept 19: MP Marzouq Al-Hebeini has forwarded queries to Minister of Electricity, Water and Renewable Energy Jassem Al-Ostad about the arrest of a gang that hacked the electronic systems in the ministry.

He asked if the gang members include current or former ministry employees or those under the sponsorship of the companies that signed contracts with the ministry, list of companies and copies of contracts if the response is in the affirmative, if the usernames of officials were used to hack the systems and if these officials processed illegal transactions.

MP Khalid Al-Tamar asked Minister of State for Municipal and Communication Affairs Fahd Al-Shulah if licenses were granted to Red Bull Mobile operator in the last three months. If yes, he demanded for copies of the licenses and value of the contract. He also inquired if Red Bull Mobile published promotion advertisements before obtaining the licenses, if complaints were filed against it, measures that the Communications and Information Technology Regulatory Authority (CITRA) took regarding the complaints, copy of the decree issued by the Council of Ministers to form the Board of Directors of CITRA including the positions occupied by the members in the last five years, if any of them are board members of other entities or if they serve as consultants in other companies. He requested for copies of the decisions of the Council of Ministers specifying the salaries and allowances of CITRA's board members.

MP Muhammad Al-Mahan asked Minister of Education, Higher Education and Scientific Research Adel Al-Mane about the plan of the ministry to curb the spread of drugs among students; if the ministry has a strategy to raise awareness among youths and warn them about the devastating effects of drugs, and copy of the strategy if the answer is 'yes'.

He also forwarded queries to Deputy Prime Minister and Minister of Interior Sheikh Talal Khalid Al-Ahmad Al-Sabah about the strategy of the ministry in fighting against drugs; number of citizens and expatriates accused of trafficking and possessing drugs since Jan 1, 2015 till date; reasons behind the spread of drugs; and measures taken to eliminate this social menace.

Kuwait was the first Gulf state to establish full-scale diplomatic relations with China (1971).

The strategic Kuwait-China relationship has been evolving, serving aspirations of the two countries namely with respect of development schemes. Moreover, Kuwait was the first Arab state to ink a memorandum of understanding with China for involvement in China's strategy, "belt and road." New Kuwait 2035 development strategy

has given further impetus for the country's drive to cement ties with China, with the prime goals of overhauling the Kuwaiti economy to render it diversified and sustainable; thus largely becoming in harmony with the Chinese economic strategy.

Development of the Kuwaiti-Chinese relations witnessed a major leap in 2018, when the late Amir Sheikh Sabah Al-Ah-

crude oil to China and there are more than 60 Chinese companies in Kuwait, contributing to 80 key projects.

The Gulf state highly values China's stand with Kuwait in the face of the 1990 Iraqi aggression and role of the Chinese firemen in putting out flames at oil wells, set ablaze by the occupiers before they withdrew from the country.

In May 2020, amid the coronavirus plight, a Chinese medical team came to Kuwait to furnish the Kuwaiti authorities with Beijing's expertise in coping with the pandemic. In March 2020, the Kuwaiti Government donated USD three million to China to assist Beijing in the efforts against the communicable virus.

At the educational level, China grants academic scholarships to Kuwaiti students and sends Chinese students to the country to study the Arabic language.

Other Voices

Judges must only be men?

One of the most beautiful manifesta-tions of democracy is the supremacy of the judiciary in the state. Without democracy, there is no constitution, and without it, there are no state institutions,

no judiciary that can be relied upon, no clear penal code, and no equality in litigation!

But the delay in issuing verdicts is equally harmful to not issuing them, and perhaps even tampering with them.



From time to time, His Highness the Prime Minister makes visits to some government agencies, and the last of these visits was to the Jahra Hospital.

What we urgently need is a visit by His Highness, with his entire Cabinet members, to the judicial facility, to make an effort and extend a hand of cooperation to the judicial authority, our last resort, to overcome all obstacles facing it, as the judicial situation has almost spiraled out of control.

I feel and know, like others interested in public affairs, the great responsibility placed on the shoulders of the President and members of the Supreme Judicial Council, and the almost mythical size of the cases heard by the courts, especially the Court of Cassation.

This is a worrying matter, as a short while ago I received notices from the Justice Department stating that some cases involving me will be heard by the court of first instance after two years! This means that I will most likely not survive to see the issuance of final rulings in these cases, especially when there are more than 70,000 appeals before the Courts of Cassation to decide on them, and no judge's conscience allows them to issue rulings in them quickly and hastily.

The suffering of citizens and residents with the issue of delayed issuance of rulings has already become a worrying concern, and requires the three state authorities to come together to develop appropriate solutions to resolve this dilemma. This often prompted MP Jenan Bushehri to submit a request for the return of the Legislative Committee in the National Assembly to discuss this issue.

It was funny, and even disgraceful, to read the proposal put forward by a number of MPs, asking that judges be men only, forgetting all the state's problems that have accumulated over the years, and all the difficulties that the judiciary complains about, from the accumulation of appeals, the loss of files, and the delay in implementing the law, rulings, the severe shortage of secretaries, the printing of rulings, the loss of files, and many others.

Strategy

He asked the health minister about the strategy to prevent the spread of drugs, number of individuals undergoing treatment for drug addiction and other related health conditions in public and private hospitals and clinics since Jan 1, 2015 till date; number of drug-related deaths; and if there is a plan to establish clinics and centers for drug addiction treatment.

MP Dawoud Ma'arafi forwarded queries to Minister of Foreign Affairs Sheikh Salem Al- Sabah about the number of employees under contracts at the ministry classifying them into citizens, children of Kuwaiti women married to foreigners, Bedouns and expatriates.

He wants to know the actual manpower needs of the ministry, number of nationals appointed since 2020 till date, number of vacant supervisory posts, if they have been advertised, number of national and expatriate consultants at the offices of the minister, undersecretary and assistant undersecretaries.

MP Mubarak Al-Tasha asked Minister of Justice and State Minister for Housing Affairs Faleh Al-Raqaba if any of the courts ruled against any of the ministers since the issuance of decree number 116/2023 on the formation of the current government on June 18, 2023. If yes, he wants to know which court issued the ruling - First Instance, Appeals or Cassation, and list of concerned ministers.

He asked Minister of Commerce and Industry and State Minister for Youth Affairs Muhammad Al-Aiban about the number of consultants in the ministry and its subsidiaries including their nationalities, qualifications, salaries, allowances, job performance assessment in the last five years, committees they joined, training courses they passed and official tasks

He inquired about the measures taken to oversee the lotteries organized by banks and malls to promote their products, list of lotteries held in the last five years including the names of winners and their nationalities, names of the members of the committee tasked to attend the lotteries, copies of the committee's report on each lottery including violations if any, number of individuals who won more than once since Jan 1, 2018 till date, legal action if any, and if the ministry or Consumer Protection Department received complaints about lotteries in the last five years.

MP Hassan Jawhar asked Deputy Prime Minister and Minister of Interior Sheikh Talal Khalid Al-Ahmad Al-Sabah about the reasons behind the delayed completion of the traffic safety project, which was included in the development plan for fiscal 2020/2021 and was supposed to be completed in fiscal 2021/2022. He wants to know if the ministry questioned those tasked to complete the project, action taken against them if the answer is 'yes', reasons for not taking action if the answer is 'no', and completion percentage of the project as at the end of the first quarter of fiscal 2023/2024.

KUWAIT CITY, Sept 19: The Minister of Finance Fahad Al-Jarallah says the state is moving to impose new fees for the use of public facilities and services within the framework of starting to implement the projects included in the government's work program, with emphasis on the relevant government agencies in the event of pricing their services on the existence of the appropriate legal tool to impose fees.

He stressed that each entity is responsible for what concerns it in accordance with the laws of its establishment, and in a manner that does not conflict with law No. 79/1995 regarding the fees for the use of public facilities and services.

În response to a parliamentary question submitted by MP Muhalhal Al-Mudhaf, Al-Jarallah explained that the government's work program for the 17th legislative term and within the first axis "Public Finance Stability" included a program to increase and develop state revenues. The program has three projects, which are launching a pricing mechanism for public services, the fees, and the violations (developed and renewed periodically), and issuing a general framework for reviewing and re-pricing the state's real estate properties on a periodic basis that takes into account the principles of justice and productivity rates.

The intention is to reconsider the current fees. The reasons go back to what was previously explained in the first paragraph above, that the government's work program includes the first axis of "stability of public finances" to increase and diversify state revenues with the aim of reforming the financial structure for the general public.

Study

The Ministry of Finance has directed all government agencies to study and reconsider the fees imposed by each agency in accordance with the laws of its establishment and in a manner that does not conflict with law No. 79/1995 regarding fees and financial costs, and in exchange for the use of public facilities and services.

Al-Jarallah said, "The Ministry of Finance is currently reconsidering ministerial resolution No. 40/2016 regarding issuing a list of fees for the use of private real estate state properties and service fees.

In response to another question by Al-Mudhaf, Al-Jarallah explained that the Public Institution for Social Security does not charge fees for the services it provides, other than what is stipulated in article 95 of the Social Security Law issued by the Amiri decree law No. 61/1976.

This includes the fees for issuing the certificate indicating the payment of the subscription to the institution amounting to KD 0.500 for each certificate or taken from it. The government agencies responsible for issuing specific licenses or certificates must condition the issuance of these licenses or certificates or their renewal on the applicant's submission of the aforementioned certificate or an extract thereof.

Imposing any increase or establishing a new fee requires a legislative amendment, and the institution has no intention of doing so.

Directives

In response to the question about the Amiri directives from the political leadership regarding granting retirees percentages of the institution's profits, and whether a portion of the institution's profits will be distributed to retirees. Al-Jarallah said, "Based on the noble desire, a grant was decided for retirees and those entitled to receive their effective shares at the rate of KD 3,000 by law No. 4/2022. The right to increase pensions on an annual basis by KD 20 was decided as of August 1, 2023, as the scheduled increase was KD 30".

He further explained that the social security laws included provisions requiring the establishment of funds, and precisely defined the sources of each fund and the methods of disbursing from it. They obligated the institution to implement the provisions of those laws, which means that the money of those funds should not be disposed of except in accordance with the provisions of the laws regulating them.

This also takes into account that investment returns are considered a resource from the funds' resources in accordance with the social security laws, and are allocated to finance funds based on the disbursement of pension rights to ensure their permanence and the continuation of performing the rights established pursuant to them, and that they may not be disposed of other than for the purposes prescribed by law.

Al-Jarallah stressed that there is no legal objection in the Social Security Law to giving grants to the beneficiaries of its provisions if it becomes clear that there is excess money in the funds after the approval of the institution's Board of Directors, but this is not achieved at the present time because there is a realistic obstacle, which is the actuarial deficit.

'Basic education teaching staff contribute great effort over new university proposal'

• A proposal for legislation was put forth by a Member of Parliament advocating the creation of an "autonomous government university", columnist Dr. Bahija Behbehani wrote for Al-Qabas daily.

"Accompanying this proposal was an explana-tory document comprising 37 articles, including Article 2, stipulating that the government should establish an independent government university within three years of the enactment of this law.

"This envisioned university was to be developed comprehensively in scientific, administrative, and financial aspects, with its headquarters situated in the residential city of Sabah Al-Ahmad.

"The executive regulations were to delineate their powers and responsibilities. Moreover, the competent minister was mandated to furnish the National Assembly with a report every three months detailing

the actions taken towards the project's implementation and the current executive status.

"Article 3 outlined the university's objective, emphasized the production of proficient and distinguished professionals in the realms of science and development, crucial for bolstering the nation's developmental and economic sectors.

"Article 4 delineated the university's structure, comprising the College of Basic Education affiliated with the Public Authority for Applied Education and Training. Additionally, faculties in Engineering, Law, and Science were to be established, along with any other colleges falling under the purview of the Public Authority for Applied Education and Training. The completion of a bachelor's degree was envisioned to occur within three years from the law's implementation.

"The representative emphasized that faculty members in applied education, particularly the teams at the College of Basic Education, were entitled to protect their rights, having made substantial contributions to the formulation of "Jaber Al-Ahmad University" in a manner akin to the proposed legislation.

"This earlier initiative, under the moniker "Jaber Al-Ahmad University," had been prepared a decade ago and was suspended due to political interference. Notably, the National Assembly had sanctioned the issuance of the "Jaber Al-Ahmad University" law, introducing fundamental modifications to the proposal.

"Initially named "Jaber University of Science" during the first discussion, it was later renamed "Jaber Al-Ahmad University" in subsequent deliberations, with its designated headquarters in the Ardhiya area.

"According to the provisions of this prospective university law at that time, the government was obligated, within a three-year period, to establish an autonomous governmental university, encompassing scientific and administrative dimensions.

"It was to comprise the College of Basic Educaon currently under the General Authority for Applied Education and Training, in addition to engineering, law, and administrative sciences colleges, and any other colleges under the Authority's jurisdiction. The completion of a bachelor's degree was to be facilitated within this new institutional framework. "Unfortunately, the members of the Educational Committee in the National Assembly and the representatives at that time did not know the type of specializations that the labor market needed, and they did not request the preparation of a feasibility study on the new university and the specializations available in it, and the extent of the labor market's need for them, knowing that the creation of any university in the world requires the submission of these documents and data with the feasibility study. Certainly, the teaching staff in basic education will support the deputy's new university pro-posal because they contributed a great effort in preparing it!

the optimism that once prevailed when a new government was formed and the National Assembly rejoiced, heralding a theoretical course correction.

"A thorough analysis of the situation reveals that the challenge to correct the course remains fraught with challenges. Modern history seems to repeat itself, drowning in the cacophony of political entanglements and narrow calculations, far removed from the nation's and citizen's priorities.

It's no secret that citizens are grappling with concerns about infrastructure, healthcare, education, and the economy. The overarching crisis looms as the spiraling budget deficit threatens the nation's financial capabilities, instilling fear of an economic downturn.

"Kuwait is no longer what it once was, and neither is the world. The disparity lies in their divergent trajectories. As the world steers towards new coordinates and future imperatives, Kuwait remains stuck in its place, entangled in political discord and a crisis that begets another.

"The gravity of the current situation is such that we cannot afford to waste any more time outside the realm of progress, compensating for missed opportunities essential for a deserved renaissance for today's Kuwaitis and future generations.

"In summary, the persistence of obstinacy and political intrigues serves as a warning to all politicians, urging them to swiftly unite in dismantling this dam and commence activating the necessary reform pathways. This action is imperative to prevent the situation from spiraling beyond control.'

"Members of the National Assembly, we want you to issue a law that cares about citizens and the State, which is suffering from many problems. We have not heard any solution from you and the latest thing you have come up with is the mixing of students," columnist Fatma Al-Khaldi wrote for Annahar daily.

"This law is absurd, yet you have put it in place. It is not worthy of being under the dome of the Parliament. Mixing exists everywhere. It exists in Holy Makkah, Medina, markets and associations. Even the streets are mixed. You make separate associations, markets and streets for women and for men. You think you have won.

"In fact, everyone is watching and laughing at you. I believe MP Muhammad Haif presents this project in every council he enters. He has nothing but this project to present. He has no laws concerning the country, the foremost of which are the Bedouns, deteriorating condition of the streets, lack of medicines in the Ministry of Health and outdated ministries' buildings like the Capital pas-

1,066 'iqama' law breakers deported; 107 illegals held


Two Asians caught selling foreign liquor

KUWAIT CITY, Sept 19: In a painful blow dealt by the Ministry of Interior to violators of residence law, the Ministry of Interior has deported 1,066 violators during the past seven days, and also arrested 107 illegals during a security campaign in the vegetables market, reports Al-Seyassah daily.

A security source explained that among the deportees were 613 males and 453 females, stressing that the ministry continues to deport people to eliminate all violators of the Residence and Labor Law, those caught violating public morals, criminals and those who violate the country's laws.

In this context, the Residency Affairs Investigation Department launched a surprise security campaign on the vegetable market in the Kabd area, which resulted in the arrest of 107 violators of the Residency and Labor Law and seized people of various nationalities.

They were referred to the competent authority to take the necessary legal measures against them.

"From Morocco to Libya, distances are no longer merely measured in kilometers, using common geographic coordinates. "All we can do now is pray to God Almighty for mercy upon the departed in Morocco and Libva, for healing and patience for the wounded, and for strength for those enduring the affliction.

"Reflecting on Kuwait, our trials seem trivial compared to the luxury of political discord and rifts that have plagued the country for years. This chronic condition has worsened, diverting attention away from urgent economic and financial risks. We are in desperate need of a unified approach for rescue and consensus.

"In recent days, political disputes have escalated to a degree that echoes Kuwait's prolonged uncertainty, reinforcing negative indicators reminiscent of the past. These developments have diminished

"We do not want a guardian to teach us what is right and what is wrong. If you have a law that interests us, present it. If there is none, then silence is better than boiling laws that waste our time.

"Please, members of the National Assembly, enough of futile laws. "Bridges are continuously built with various countries around the world through diplomatic bodies, humanitarian, economic, cultural aid and other means of cooperation.

"However, in our time, these bridges must be made of iron, cement and other sturdy construction materials in order to create real bridges connecting the East and West, bridges that connect Kuwait to the commercial world through railways, suspension bridges, highways, and other quick and easy means of transportation.

"The Belt and Road Initiative or One Belt and One Road is a Chinese initiative based on the Silk Road Initiative, which was established in 2013 - 10 years ago. The implementation of this initiative has already begun. Bridges and highways were built between China and the neighboring countries like India, Pakistan, Afghanistan and others.

"This initiative aims to connect the East with the West, meaning to connect China with Asia, Europe and Africa for commercial and economic purposes and to promote the Chinese currency (Yuan). It is known that China's annual production started to grow significantly due to what has been accomplished in the huge project, which will be completed in 2048 approximately.

"It is noted that the road map for this huge project, especially the sea route (the road), does not stop at Arab ports, except the Suez Canal. It is also believed that the land route (the belt) does not pass through Arab land, because the purpose of this initiative is to pass through densely populated areas such as India, Pakistan and other countries that are far from cities.

"Is it not time to create a similar initiative for Arab countries to communicate with each other and with the outside world from East to West and create bridges and highways between Arab countries, Europe, Africa and Asia? Do Arabs lack money, equipment, men, technology and expertise in constructing highways and bridges?"

KD 586.8m set for new recruitment

KUWAIT CITY, Sept 19: The government has approved an additional budget of 586.8 million dinars to cover the appointments plan that will be announced during the remaining months of the current fiscal year, reports Al-Anba daily

The sources explained that the Civil Service Commission will announce the opening of registration for job seekers during December and February, with 3 recruitment batches to be announced in October 2023, and January and March 2024.

The source added that the CSC, through coordination with ministries, institutions and government agencies, was able to nominate the names of 4,700 male and female citizens to work during the period from August 9 to Sept 3, with the aim of meeting the needs of these bodies and providing job opportunities.

The honoring ceremony was attended by cultural and public figures with professors from Yerevan State University



KUWAIT CITY, Sept 19: Data released by the Central Administration of Statistics indicates that as of June 2023, Kuwait had a total of 2.43 million expatriates, both male and female, from 174 countries employed in various sectors, including domestic work. This number represents an increase of approximately 82.5% compared to the end of December 2022 when the expatriate workforce stood at 2.34 million, reports Al-Anba daily.

In terms of the broader labor market, which includes citizens and domestic workers, the total employment saw an increase of about 86.8 thousand male and female workers during the first half of 2023. This raised the total number of workers to around 2.877 million by the end of June 2023, compared to 2.79 million at the end of December 2022.

India had the largest representation in the Ku-waiti workforce, constituting 30.2% of the total. The number of Indian workers increased to about 869.82 thousand by the end of June 2023, a rise of 35.14 thousand compared to December 2022.

Egypt followed as the second-largest contributor, with a workforce of 483.45 thousand at the end of June 2023, a slight decrease of 808 Egyptians compared to December 2022. Kuwait ranked third, with approximately 447.06 thousand male and female citizens in the labor market by June 2023, reflecting a rise of 4,417 citizens compared to December 2022

The Philippines and Bangladesh secured the fourth and fifth positions, with 269.48 thousand and 248.92 thousand workers, respectively, by the end of June 2023.

The data also revealed notable changes in the workforce from specific nationalities. Nepalese workers, for instance, moved up to the fifth position, surpassing Pakistanis. Meanwhile, the number of domestic workers increased by about 34.85 thousand during the first half of 2023.

Regarding salaries, the average salary for Kuwaiti citizens rose to 1,557 dinars per month during the first half of 2023. Kuwaiti citizens in the government sector had an average salary of 1,598 dinars per month, while those in the private sector earned an average of 1,342 dinars per month.

Expatriates' average salary increased to 343 dinars per month, with those in the government and private sectors earning 750 dinars and 323 dinars per month, respectively.



Lawyer Elaf Al-Saleh file lawsuits

Courts issue several rulings against those accused of assaulting doctors



KUWAIT CITY, Sept 19: The Criminal Court and the Court of Appeals issued several rulings to convict those accused of assaulting doctors while the latter are performing their duties. These lawsuits were filed by Lawyer Elaf Al-Saleh in her capacity as the legal representative of the Kuwait Medical Association.

against a woman who was accused of assaulting an expatriate doctor and detaining her in the ultrasound room after she became angry and refused to undergo tests before the ultrasound. The court fined her, and referred the case to the competent civil court.

In the second case, the Criminal Court acquitted an Egyptian doctor and imposed a fine of KD 2,000 against a citizen after the two had an altercation in which the patient assaulted the doctor.

During the court session, Lawyer Elaf Al-Saleh said her client, the doctor, was the one who was assaulted publicly, adding that the medical report and witness testimony are in favor of her client.

In the third case, the Court of Appeals ruled to issue a suspended prison sentence of two years against a citizen, releasing him on a bail of KD 500 and obliging him to vow to maintain good conduct for a period of three years. This citizen was found guilty of publicly assaulting an expatriate doctor while the latter was performing his duty.

In the fourth case, the Misdemeanor Court fined a woman a sum of KD 500 for insulting a Kuwaiti doctor at Farwaniya Hospital.

In these cases, Lawyer Elaf Al-Saleh stated that she is continuing as a legal representative for the Kuwait Medical Association in filing complaints against those who assaulted medical staff and doctors in various hospitals.

She emphasized that the deterrent penal

The ministry will receive requests to supply electricity to 168 plots in Block 1, which are plots from 191 to 201, plot No. 402 and plots from 506 to 549, and from 564 to 604. In Block 2, electricity will be supplied to plots from 494 to 510 and 512, 514, 516, 518, 531, 533, 535, from 537 to 574, 576, 578, 580, 582, 584, and from 596 to 601.

In another development, informed sources in the ministry revealed that 208 citizens were appointed to the various sectors of the ministry in August through the Civil Service Commission (CSC), which nominates for jobs in the ministry in accordance with the annual requirements determined by the ministry at the beginning of the fiscal year.

They explained that the total number of employees in the ministry is 33,559, with 32,667 Kuwaitis, representing 97.3 percent, and 892 non-Kuwaitis.

Kuwait's real estate market holds steady

Local banks have reported a significant decline in financing provided to the residential sector, with a consolidated monthly decrease of 38.6 percent or approximately 766.1 million dinars. This drop is substantial, bringing the financing from 1.85 billion dinars during the first seven months of 2022 down to 1.08 billion dinars for the same period in 2023, as per data from the Central Bank of Kuwait for July. Interestingly, these financing

figures saw a month-on-month increase of 29.4 percent, rising from 133.6 million dinars in June to 172.9 million dinars in July. However, on a year-on-year basis, there was a 17.5 percent decrease, equivalent to 36.8 million dinars, down from 209.7 million dinars in July 2022.

Housing financing encompasses long-term personal loans with a maximum duration of fifteen years, offered by banks to customers for the purpose of purchasing, constructing, or reno-vating their private residences.

Over the past five years, the housing financing balance provided by banks has surged by 30.3 percent, amounting to about 4.767 billion dinars, from 10.972 billion dinars in December 2017 to 15.74 billion dinars in December 2022.

On the other hand, financing for "private and model housing" witnessed a 1.8 percent monthly decrease, falling by 5.6 million dinars from 306.2 million dinars in June to 300.6 million dinars in July. On an annual basis, this financing decreased by 6.8 percent, down from 322.8 million dinars in June 2022.

Real estate experts have confirmed that the Kuwaiti real estate market remained stable during the first half of 2023. Despite a continuous rise in housing prices, with the average price per square meter of private residential land increasing by 16.4 percent in 2022 to 1,274 thousand dinars, liquidity in the


private housing sector decreased

by 32 percent in 2022 compared to 2021. Contracts and agency volumes amounted to approximately 2.009 billion dinars, contributing only about 53.4 percent to the market liquidity, a decrease from its 2021 contribution of 75.1 percent. Meanwhile, investment housing activity witnessed a 43.3 percent increase to about 1.116 billion dinars, contributing approximately 29.6 percent to market liquidity, compared to 19.8 percent in 2021.

This balance grew from 15.74 billion dinars in July 2022 to 15.885 billion dinars in July 2023, marking a 0.4 percent increase compared to June 2023, when the balance was 15.82 billion dinars.

The financing balance exhibited consistent growth throughout 2022, starting at 14.390 billion dinars in December 2021 and steadily climbing to 15.74 billion dinars by December 2022. The trend continued into 2023, with the balance



Easing inflation worries notwithstanding

Global growth to stay under pressure

The global economy continues to hold up better than L expected, with resilient consumer spending and stilltight labor markets helping growth in developed markets, especially the US, and severe recession fears waning. Inflation has receded from its highs, supporting consumer and business confidence, and bolstering expectations that aggressive policy tightening by major central banks is at or near its end. However, the recent climb in oil and global food prices, together with still well above-target underlying inflation rates in the US and Europe, are likely to rule out early rate cuts in 2024, which could add to growth headwinds there next year. Meanwhile, weak economic growth figures in China may have helped trigger firmer government policy support recently. If successful in boosting growth, this will have positive knock-on effects on European and Japanese exports though also risks pushing global inflation up.

US shows resilience, Fed rate hikes seen near their end The US economy has outperformed expectations, with GDP growth surprising positively and dissipating chances of recession this year. GDP growth accelerated slightly to 2.1% q/q (annualized) in Q2 2023 from 2% in Q1 on higher business investment and relatively robust household spending. (Chart 1.) The positive momentum has continued into Q3, with strong increases in industrial production and retail sales in July-August. Sales of new homes have also recovered, helped by a tight supply of existing single-family units. The ISM services activity index in August climbed to a solid 54.5, and even its manufacturing equivalent at 47.6 signaled a slower pace of contraction. The consensus is for another strong GDP print of 2.8% in Q3, though growth in Q4 could be hit by the resumption of student debt repayments in October.

The tight job market remains at the core of the US economy's resilience. Although monthly job gains have eased from their unsustainable rates of last year, the unemployment rate at 3.8% is at near historic lows and real wage growth is now in positive territory. Unless we see widespread cracks in the labor market, consumer spending and the economic outlook should continue to hold up, offsetting the impact of higher interest rates.

Consumer price inflation remains on a broadly slowing path, with core CPI inflation still above target at 4.3% y/y in August but well off its 6.5% peak last year and further softening seen ahead as the lagged impact of earlier falls in shelter costs feeds through. With the Fed funds target interest rate now at 5.25-5.50%, real policy rates are in positive territory and the Fed is seen delivering perhaps one final 25bps rate hike in November. However, with the economy growing at or above its trend rate, wage growth still high, commodity prices rising again and some narrower measures of inflation remaining sticky, the Fed will be unable to declare victory over inflation very quickly and interest rate cuts are likely to be delayed until the second half of next year. ■ The global economy has held up better than expected, especially in the US, where resilient consumer spending and a still-tight labor market continue to support at-or-above-trend economic growth.

■ Europe's economy has so far avoided a widely-anticipated recession, though remains pressured by high interest rates and the fragile Chinese recovery weighing on exports.

■ Japanese GDP grew strongly in Q2 as inbound tourism rebounded, but lingering doubts about the domestic economy are making an early reversal of ultra-loose monetary policy less likely.

Recent policy support measures should help China's economy, which grew a modest 0.8% q/q in Q2. A rebound in domestic demand, however, could pose upside risks to global inflation and commodity prices.




while, having also escaped recession so far by a narrow margin, the UK economy faces a similarly soft outlook: GDP contracted 0.5% m/m in July versus +0.5% in June and could rise just 0.1% q/q in Q3 (+0.2% in Q2).

Eurozone inflation has halved from its peak in October last year (5.1% y/y from 10.6%), though remains well above the ECB's 2% target. Given high but easing inflation and a weak economic outlook, the bank increased its policy deposit rate by 25 bps in September to 4.0%, but hinted at no change going forward. Inflation in the UK has eased at a much slower pace (currently at 6.4% y/y), but as economic growth loses steam, the Bank of England governor has hinted that the rate-hike cycle is also ending. Another 25 bps increase in the policy rate to 5.5%in September could be the final hike in the current cycle.


External sector lifts Japan's Q2 GDP growth

Japan's economy continues its struggle for a robust post-pandemic recovery amid a weaker yen and a softening global outlook. GDP growth in Q2 2023 was revised sharply lower in the final reading, albeit still high at an annualized 4.8%. This was a solid upgrade from Q1, but growth was solely driven by a strong performance in the external sector (helped by a recovery in inbound tourism) while domestic consumption and business investment were weak. Moreover, real wages continued to fall for the 16th consecutive month in July (-2.6% y/y), boding ill for underlying domestic demand. In light of the mixed data, the Bank of Japan (BOJ) has reaffirmed its stance on maintaining an ultra-loose monetary policy. However, BoJ governor Kazuo Ueda has hinted at shifting away from negative interest rates if the data by the year-end suggest that current high inflation (3.1% y/y in July) looks like being sustained. The BoJ had earlier tweaked its yield curve-control policy to allow up to 1% yields on 10-year government bonds from 0.5% earlier, but hasn't let yields to rise anywhere near this. As Japan is a net creditor to international markets, any repatriation of overseas funds due to higher rates could have a large impact on the global financial system. Ueda's signal on ending negative interest rates seems a step in preparing markets for a policy reversal sometime in 2024 rather than earlier. The signals may also have been aimed at stemming weakness in the yen, which is hovering close to 30-plus-year lows versus the US dollar.





momentum in China has slowed amid ongoing problems in the real estate sector, softer manufacturing activity, and declining exports. GDP growth slowed to just 0.8% q/q in Q2 2023 from 2.2% in Q1, though a base effect pushed growth up to 6.3% in year-on-year terms. (Chart 3.) Pressures on the real estate sector include falling home valuations that have hit homebuyer confidence, declining property investment, and rising liquidity and solvency risks for developers. Falling land prices have reduced local government revenues and raised concerns about the ability of their financing vehicles to service debt, estimated by the IMF to stand at \$9 trillion (55% of GDP). The real estate slump has also heightened risks in the country's \$2.9 trillion shadow banking sector. Nevertheless, while the prevailing sentiment on the economy remains negative, there have been a few encouraging signs of late. CPI inflation turned positive again in August at 0.1% y/y, having been negative in July. Retail sales growth accelerated to 4.6% y/y in August, while industrial production edged up 4.5%, signaling stabilizing economic activities. The pace of contraction in both exports and imports softened in August, while the official composite PMI rose for the first time since March, though at 51.3 is still signaling only modest growth. Importantly too, the government continues to roll out measures to support the economy. The central bank slashed the 1-year loan prime rate by 15bps in August, both mortgage rates and down payment requirements for homebuyers have been cut and the government is extending loan relief to troubled developers. The government is also trying to diversify household wealth away from real estate, as it passed some measures to boost stock market performance. These steps, coupled with tentative recent

improvements in some economic indicators, suggest that the government could achieve its targeted 5% GDP growth this year.

India's Q1 growth surges, but challenges ahead

India's GDP growth beat forecasts in Q1 FY23/24 (fiscal ending March) at 7.8% y/y versus 6.1% in Q4 FY22/23. A sharp recovery in private consumption growth and elevated investment spending provided impetus. The government has reiterated its forecast of around 6.5% growth for the current fiscal year and leading indicators, including recent PMI surveys, have been robust.

Europe's economy loses steam

Europe's economy is witnessing growing signs of weakness on a steep rise in policy rates and a fragile recovery in China. The Eurozone's services sector, which was outperforming manufacturing for a long period, has now also come under pressure with both sectors' PMIs coming below the 'no change' 50 mark in August. (Chart 2.) In Q2 2023, Eurozone GDP grew just 0.1% q/q, following a similar rise in Q1. Moreover, a softening global outlook amid ongoing weakness in Chinese demand are likely to weigh on the region's exports. In September, the European Commission cut its growth outlook for the Eurozone for 2023 (to 0.8% from 1.1% in the Spring) and 2024 (to 1.3% from 1.6%), as Germany slips into recession on a slump in manufacturing and exports. Mean-

Chinese government continues to ramp up support Following an initial post-Covid rebound, economic However, signs of fatigue are also emerging, with indirect tax collections exhibiting slowing growth in recent months. Moreover, monsoon rains have been erratic, impacting agricultural production and prompting authorities to control exports of main agri-commodities, including wheat, rice, and sugar. The effects have been felt both locally and overseas, with global food prices spiking. For example, following the ban, Asian white rice prices jumped by around 20% in early August. With a general election scheduled for next year, the government may announce other populist measures to support the rural sector, perhaps pushing government spending higher, despite its goal of narrowing the fiscal deficit to 5.9% of GDP this fiscal year from 6.4% last year.

Higher agri-commodity prices steeply reversed the softening trend in consumer prices, with headline inflation standing at 6.8% y/y in August versus 4.9% in June. The Reserve Bank of India left the repo rate on hold (at 6.5%) at its August meeting but tightened liquidity by increasing the banking sector's cash reserve ratio. The bank also upgraded its inflation outlook for this year to 5.4% from 5.1% earlier.

Asian shares weaker ahead of Fed interest rate decision Wall St slips as oil prices keep rising

NEW YORK, Sept 19, (AP): Stocks were slipping Tuesday, and oil prices keep rising while Wall Street waits for the Federal Reserve's latest decision on interest rates.

The S&P 500 was 0.6% lower in midday trading, a day after barely budging. The Dow Jones Industrial Average was down 232 points, or 0.7%, at 34,391, as of 11:30 a.m. Eastern time, and the Nasdaq composite was 0.8% lower.

Stocks have been see-sawing for weeks on uncertainty about whether the Fed is done with its market-shaking hikes to interest rates. By pulling its main interest rate to the highest level in more than two decades, the Fed has helped inflation to cool from its peak last year but at the cost of hurting prices for investments and damaging some corners of the economy.

The Fed is beginning its latest meeting on interest rates Tuesday, with an announcement scheduled for Wednesday. The overwhelming expectation is for the Fed to announce no change to rates. More focus will be on updated projections Fed officials give for where they see rates heading in upcoming years.

Traders are split on whether the Fed may raise rates one more time this year, but they're largely expecting the Fed to begin cutting rates next year. Such cuts can act like steroids for financial markets, giving a lift to all kinds of investments.

Optimists say inflation has come down enough for the Fed to cut rates meaningfully next year, while the economy continues to hum due to a solid job market. Pessimists say the Fed may need to keep rates higher for longer than investors expect to get inflation down to its 2% target, while the threat of a recession still looms.

A soft landing, where inflation gets back to the Fed's target without the economy having to suffer a painful recession, "is still possible, but not probable in our view," according to Joe Davis, chief global economist and head of Vanguard's investment strategy group.

A risk remains that the Fed could misread a temporary slowdown in inflation as having accomplished its mission, which could lead to a cycle reminiscent of the late 1960s where inflation reaccelerates, the Fed hikes rates further and a recession eventually hits.

High rates have already hit the manufacturing and housing industries. A report Tuesday showed that homebuilders broke ground on fewer new homes in August than economists expected. The 11.3% drop from July's level was much worse than the 0.8% forecasted. But activity for building permits, a possible indicator of future activity, rose more than expected.

On Wall Street, shares of Instacart are set to begin trading later in the day after pricing its stock at \$30 in an initial public offering. It raised \$660 million and quickly follows after another highly anticipated IPO by Arm Holdings.

The offerings could mark a warming environment for IPOs, which fell off sharply after stocks tumbled last year with worries about higher interest rates. Arm jumped in its first day of trading on Thursday but followed that up with two days of losses.

Instacart's IPO valued the company at around \$10 billion. It was thought to be worth \$39 billion in 2021.

The Walt Disney Co. fell 3.5% for one of the largest losses in the S&P 500 after it announced a big investment plan for its theme parks and cruise lines. It plans to double its investment in its parks, experiences and products business to \$60 billion over the next 10 years versus the prior decade.

Shares of AutoZone swung between losses and gains after the auto parts retailer reported stronger profit for the latest quarter than analysts expected. It fell in the morning after it said growth in its domestic commercial business was weaker than expected, but its stock later recovered to rise 0.1%.

Europe

France's CAC 40 added 0.2% to 7,292.91 in early trading. Germany's DAX fell nearly 0.1% to 15,716.61. Britain's FTSE 100 was little changed, rising less than 0.1% to 7,659.91.

Asia

Asian shares were mostly lower in cautious trading Tuesday ahead of the Federal Reserve's upcoming decision on interest rates.

Japan's benchmark Nikkei 225 dropped 1.1% to 33,160.03. Australia's S&P/ASX 200 lost 0.5% to 7,196.70. South Korea's Kospi edged down 0.7% to 2,556.42. Hong Kong's Hang Seng slipped 0.2% to 17,893.99, while the Shanghai Composite fell 0.1% to 3,122.21.

The Fed is due to wrap up a two-day meeting on Wednesday. Japan's central bank will meet Thursday-Friday as observers speculate that it might gradually begin to adjust its longstanding negative interest rate policy.

"Market sentiment remained in its usual waitand-see ahead of the Federal Open Market Committee meeting this week," said Yeap Jun Rong, market analyst at IG.

Oil

In energy trading, benchmark U.S. crude added 95 cents to \$92.43 a barrel in electronic trading on the New York Mercantile Exchange. It rose 71 cents to \$91.48 Monday. That's up from less than \$70 in July. Brent crude, the international standard, rose 55 cents to \$94.98 a barrel.

Currencies

In currency trading, the U.S. dollar rose to 147.80 Japanese yen from 147.58 yen. The euro cost \$1.0680, down from \$1.0691.

What happened to Germany? From envy of the world to the worst

ESSEN, Germany Sept 19, (AP): For most of this century, Germany racked up one economic success after another, dominating global markets for high-end products like luxury cars and industrial machinery, selling so much to the rest of the world that half the economy ran on exports.

The proposal from Vice Chancellor Robert Habeck of the Greens Party has faced resistance from Chancellor Olaf Scholz, a Social Democrat, and probusiness coalition partner the Free Democrats. Environmentalists say it would only prolong reliance on fossil

Jobs were plentiful, the government's financial coffers grew as other European countries drowned in debt. and books were written about what other countries could learn from Germany.

No longer. Now, Germany is the world's worst-performing major developed economy, with both the International Monetary Fund and European Union expecting it to shrink this year.

It follows Russia's invasion of Ukraine and the loss of Moscow's cheap natural gas - an unprecedented shock to Germany's energy-intensive industries, long the manufacturing powerhouse of Europe.

The sudden underperformance by Europe's largest economy has set off a wave of criticism, handwringing and debate about the way forward

Germany risks "deindustrialization" as high energy costs and government inaction on other chronic problems threaten to send new factories and high-paying jobs elsewhere, said Christian Kullmann, CEO of major German chemical company Evonik Industries AG.

From his 21st-floor office in the west German town of Essen, Kullmann points out the symbols of earlier success across the historic Ruhr Valley industrial region: smokestacks from metal plants, giant heaps of waste from now-shuttered coal mines, a massive BP oil refinery and Evonik's sprawling chemical production facility.

Blackened

These days, the former mining region, where coal dust once blackened hanging laundry, is a symbol of the energy transition, dotted with wind turbines and green space.

The loss of cheap Russian natural gas needed to power factories "painfully damaged the business model of the German economy," Kullmann told The Associated Press. "We're in a situation where we're being strongly affected - damaged - by external factors.

After Russia cut off most of its gas to the European Union, spurring an energy crisis in the 27-nation bloc that had sourced 40% of the fuel from Moscow, the German government asked Evonik to keep its 1960s coalfired power plant running a few months longer.

The company is shifting away from the plant - whose 40-story smokestack fuels production of plastics and other goods - to two gas-fired generators that can later run on hydrogen amid plans to become carbon neutral by 2030

One hotly debated solution: a government-funded cap on industrial electricity prices to get the economy through the renewable energy transifuels

Kullmann is for it: "It was mistaken political decisions that primarily developed and influenced these high energy costs. And it can't now be that German industry, German workers should be stuck with the bill.'

The price of gas is roughly double what it was in 2021, hurting companies that need it to keep glass or metal red-hot and molten 24 hours a day to make glass, paper and metal coatings used in buildings and cars.

Slowdown

A second blow came as key trade partner China experiences a slowdown after several decades of strong economic growth.

These outside shocks have exposed cracks in Germany's foundation that were ignored during years of success, including lagging use of digital technology in government and business and a lengthy process to get badly needed renewable energy projects approved.

Other dawning realizations: The money that the government readily had on hand came in part because of delays in investing in roads, the rail network and high-speed internet in rural areas. A 2011 decision to shut down Germany's remaining nuclear power plants has been questioned amid worries about electricity prices and shortages. Companies face a severe shortage of skilled labor, with job openings hitting a record of just under 2 million.

And relying on Russia to reliably supply gas through the Nord Stream pipelines under the Baltic Sea - built under former Chancellor Angela Merkel and since shut off and damaged amid the war - was belatedly conceded by the government to have been a mistake.

Now, clean energy projects are slowed by extensive bureaucracy and not-in-my-backyard resistance. Spacing limits from homes keep annual construction of wind turbines in single digits in the southern Bavarian region.

A 10 billion-euro (\$10.68 billion) electrical line bringing wind power from the breezier north to industry in the south has faced costly delays from political resistance to unsightly aboveground towers. Burying the line means completion in 2028 instead of 2022.

Massive clean energy subsidies that the Biden administration is offering to companies investing in the U.S. have evoked envy and alarm that Germany is being left behind.

"We're seeing a worldwide competition by national governments for the most attractive future technologies attractive meaning the most profitable, the ones that strengthen growth, Kullmann said.

GENEVA, Sept 19, (AP): Ukraine is filing a complaint at the World Organization Trade against Hungary, Poland and Slovakia after they banned grain and other food products coming from the war-torn country, Ukrainian Prime **Minister Denys Shmyhal** said Tuesday.

It lays bare a widening rift with the three members of the European Union, which has been a pivotal backer of Kyiv as it works to fight off Russia's invasion.

In a break with the wider EU, Poland, Hungary and Slovakia have announced bans on grain and other food from Ukraine, a major agricultural supplier to parts of the world where people are going hungry. The 27-nation bloc last week lifted restrictions on Ukraine's exports to five member states, also including Romania and Bulgaria.

Imports

Farmers in eastern Europe have railed against the imports from Ukraine, saying grain has gotten stuck inside their borders and driven down prices for local growers. Farmers in Bulgaria protested Monday after their government cited higher food costs in lifting the ban on Ukrainian products.

The WTO confirmed that it received a Ukrainian request for talks with Hungary, Poland and Slovakia over the dispute, a first step toward a possible showdown through the Geneva-based trade body.

Shmyhal blasted the "unfriendly" actions by the three countries and announced an investigation of possible discriminatory practices.

But the Ukrainian prime minister also floated a possible "compromise scenario" that would control four groups of exported farm products, aiming to limit

Panos Panay is stepping down after nearly two decades at Microsoft, most recently as chief product officer, according to a staff memo Monday. "Under Panos' leadership, the team created the iconic Surface brand with loved products," said the message to employees from Rajesh Jha, executive vice president of Microsoft's experiences and devices group.

Yusut Another longtime executive,

Mehdi, who is currently chief marketing officer for consumer products, will take lead on the Windows and Surface businesses and products, Jha said. The note said Panay would be helping with the transition. "After 19 incredible years at Microsoft, I've decided to turn the page and write the next chapter," said a social media post from Panay on X, formerly Twitter. He didn't say what his next undertaking would be.

The first Surface device, a tablet computer, was unveiled in 2012 in a market dominated by Apple's iPad. Google brings AI chatbot Bard to Gmail, Maps and YouTube

NEW YORK, Sept 19, (AP): Google is introducing Bard, its artificially intelligent chatbot, to other members of its digital family - including Gmail, Maps and YouTube - as it seeks ward off competitive threats posed by similar technology run by Open AI and Microsoft.

Bard's expanded capabilities announced Tuesday will be provided through an English-only extension that will enable users to allow the chatbot to mine information embedded in their Gmail accounts as well as pull directions from Google Maps and find helpful videos on YouTube. The extension will also open a door for Bard to fetch travel information from Google Flights and extract information from documents stored on Google Drive.

Privacy

Google is promising to protect users' privacy by prohibiting human reviewers from seeing the potentially sensitive information that Bard gets from Gmail or Drive, while also promising that the data won't used as part of the main way the Mountain View, California, company makes money - selling ads tailored to people's interests.

The expansion is the latest development in an escalating AI battle triggered by the popularity of OpenAI's ChatGPT chatbot and Microsoft's push to infuse similar technology in its Bing search engine and its Microsoft 365 suite that includes its Word, Excel and Outlook applications.

ChatGPT prompted Google to release Bard broadly in March and then start testing the use of more conversational AI within its own search results in May.

A railroad worker dies after being struck by remote-controlled train

NEW YORK, Sept 19, (AP): A railroad worker died over the weekend after he was struck by a remote-controlled train in a CSX railyard in Ohio, raising concerns among unions about such technology.

The death highlights the need for an in-depth review of the use of remotecontrolled locomotives. the Transportation Communications Union and Brotherhood of Railway Carmen said in a news release Sunday. Every major railroad has used such locomotives inside, and increasingly outside of, railyards across the country for years.

The National Transportation Safety Board is investigating the death, which happened shortly before 4 a.m. Sunday Walbridge, Ohio. Spokesperson Keith Holloway said the worker was struck and fatally injured when he walked into the path of a moving locomotive that was being operated by remote control.

Fred Anderson is the third carman killed in an incident involving a remote-controlled locomotive, the unions said.

"Enough is enough. A full-scale review of the use and practices around remote-control locomotives is long overdue. CSX - and every railroad - must evaluate their use of these supposed technological advancements to ensure they are actually making our members safer, and not merely replacing people to continue lining the pockets of Wall Street," Transportation Communications Union National President Artie Maratea said in the news release.

NEW YORK, Sept 19, (AP): If Jigar Shah doesn't do his job correctly, the company with the second-highest number of fast-charging electric vehicle plugs could lose money or EV owners could have to pay more to fill

As director of energy services at Electrify America, Shah is in charge of navigating a wide range of rates charged by more than 200 electric utilities in areas where the company has stations.

Electrify America, a subsidiary of Volkswagen formed as part of the settlement for its diesel emissions cheating scandal, has more than 3,600 fastcharging plugs in the US and Canada. It's second only to Tesla with more than 22,000 ports.

Shah talked about the cost of charging and regulations that vary by state and local government. His comments are edited for length and clarity.

Question: Fast-charging stations often need line extensions, transformers and other things because they use a lot of electricity. How do you work all of this out?

Answer: We have relationships with utilities to go through the lineextension process. We make capacity requests to say we're putting in four chargers with approximately a megawatt worth of demand, and how long is it going to be and how much would it cost. So there's definitely this matching game that happens between assessing how difficult from a timing and cost perspective it is to get utility infrastructure in that area versus pivoting to another location that may be more grid-friendly or already has infrastructure nearby that may be more cost-effective. I'm responsible for everything after the point that the site is live and managing all our energy costs.

Q: You have to worry about fluctuating rates, including costs that rise with higher demand?

A: Ōne of the key variables is something called a utility demand charge. This is very different from what you're used to in your home electricity bill. You typically just pay for kilowatt hours, plus a few fixed charges. In the commercial world, usually utilities have a demand charge, which is based on peak kilowatts drawn in usually a 15- or 30-minute period in a given month or sometimes a year. If I have four vehicles charging at once for 15 minutes and a station shut down for the rest of the year, my costs from that one 15-minute amount may be above a quarter-million dollars. Four vehicles, when they draw that amount of power at once, that could be approximately a megawatt of demand. So you get billed based on that spike and that's carried through the rest of

BOULDER, Colo., Sept 19: Without innovative electric vehicle (EV) charging solutions, the average utility will need to invest thousands of dollars in grid upgrades per EV. To support utilities and consumers with increased EV charging capabilities, Rhythmos has announced the commercial deployment of its mobility and utility network management platform in East Tennessee, which is sponsored by the Tennessee Valley Authority (TVA) and the Electric Power Research Institute (EPRI) Knoxville Utilities Board (KUB) will be the first utility system to implement Rhythmos' innovative predictive analytics software solution to provide vital data such as EV detection, charging characterization, day-ahead forecasting, and transformer loading. Rhvthmos' data offers unprecedented visibility into the electric grid and will allow KUB to identify, quantify, forecast, and control EV charging needs to minimize grid impact. This data also informs operational planning, procurement and rate design. This project, made possible by EPRI's Incubatenergy® Labs (IEL) program, marks a significant step towards enhancing EV infrastructure in the state.

"Today's utilities are doing everything they can to support electric mobility and to meet charging demand in

the year. We take that risk as a company to provide fast charging availability that's crucial to EV adoption, because when you're pulling up in a vehicle on a highway route, you're not thinking about all those variables. You want that fast charge as quickly as your vehicle can accept it.

Q: Do you try to negotiate better rates?

A: Many of those quarter-million dollar examples, for example, are now zero because of testifying in front of public utility commissions to have rate reform to support direct current fast charging. We also use behind-themeter energy storage to bridge that gap. We have over 160 deployed, so 35 megawatts worth. Think about a different rate for that one megawatt peak that I was describing. Instead of all that coming from the utility at once, most of that will come from the storage system next to our chargers. Once those vehicles leave, the storage system will charge back up again.

Rhythmos will also characterize EV charging behavior - such as frequency and time of day based on historical meter data, which will provide KUB with unparalleled insight into EV charging load projections for the next day.

"KUB empowers electric vehicle adoption throughout our service territory by improving infrastructure, reducing demand charges for separately metered EV stations, providing residential customers with EV charging incentives, and supporting commercial fleet electrification," said Mathew Stinnett, manager of electric engineering at KUB. "By deploying Rhythmos" software, we gain powerful insight into our customers' needs so that we are better prepared to manage EV charging loads. This deployment signifies a step towards a more intelligent and responsive energy grid."

To earn this rapid deployment demonstration with KUB, Rhythmos was one of only 16 companies to earn a place in EPRI's 2023 IEL Cohort. EPRI provides rigorous technical validation of Rhythmos' energy management analytics and algorithm performance based on EPRI's evaluation of the effectiveness of Rhythmos' EV detection and day-ahead forecasting functionalities. The assessment of this demonstration will extend to exploring the potential impact on utility rates, resulting in a comprehensive report outlining the rate implications of the solutions presented. The results of this partnership will be presented on November 1st at EPRI's Incubatenergy Demo Day.

Q: Can you say what your monthly electric bill is?

A: It's fair to say it's in the millions. Q: How does this affect what EV owners pay per charge?

A: We've recently announced that we're going to site-specific pricing. There are a lot of utility areas where some of those rates weren't designed to support this type of fast-charging. There isn't the state backing the mission to support EV adoption. Some of those rates are problematic even with the storage systems. So we are increasing pricing in certain areas to accommodate what our actual economics are, and in other cases we're reducing prices substantially to accommodate that policy movement.

Q: What's the cost per kilowatt hour now?

A: It's around 41, 42 cents per kilowatt in kilowatt hour in some states. In certain states there's a price per minute, and that's 30 cents per minute.

Q: So I don't know how much this

is going to cost me when I roll up to one of these?

A: It's on the Electrify America mobile app. That pricing will always be transparent to the customer, especially before they start charging, so that there's never a case where there's a surprise bill. We recommend that when we've made the change to site pricing, that people look at the app to see what it is in advance.

Q: Does putting lithium-ion battery storage units on your sites slow your expansion?

A: Any time we're making an investment in energy storage, that is an investment that could have gone to more fast-charging deployment. One thing to keep in mind is 70% to 80% of charging still occurs at home. And so folks are using our DC fast-charging network primarily for long distances. It's important to keep in mind in terms of the price premium compared to charging at home and the service and experience that we provide.

GE HealthCare gets \$44m to develop AI ultrasound tech

MH002 safe, effective in mild-to-moderate Ulcerative Colitis patients

GHENT, Belgium, Sept 19: MRM Health NV, a clinical-stage biopharmaceutical company focused on developing next-generation live microbiome consortia therapeutics, has reported positive topline results from its Phase 2a clinical trial with MH002 in mildto-moderate Ulcerative Colitis (UC).

MRM Health's MH002-UC-201 study was a multi-center, double-blind, randomized, placebo-controlled trial in 45 UC patients at multiple clinical sites in Belgium, Poland and Czech Republic. The study was designed to evaluate safety (primary endpoint), initial efficacy and mechanistic effects of MH002 over eight weeks, with a further eight-week extension period.

The primary endpoint was met with an excellent safety profile and tolerance at a fixed dose of 400mg per day over 16 weeks administration. Treatment-Emergent Adverse Events (TEAE) were reported in 35% of patients allocated to MH002 treatment compared to 57% when treated with placebo and there was no evidence of adverse reactions related to MH002.

Improvement

Initial efficacy on disease activ-ity was evidenced in clinically relevant parameters, including a 12% improvement in Mayo Endoscopic Severity (MES) score (p=0.05, 1-sided Wilcoxon rank sum test), while placebo worsened by 5%. Stool consistency significantly improved in the MH002 treatment group as from week 2 (p=0.006; 1-sided Student t-test). At the end of the eight-week period, 18% of subjects achieved clinical remission compared to 0% of the placebo group (Per-protocol analysis). As opposed to previous trials with other live biotherapeutics in UC, this study was performed successfully without vancomycin preconditioning.

At a mechanistic level, anti-inflammatory effect was demonstrated with 42% decrease in median fecal calprotectin (a clinically relevant bowel inflammation marker) compared to 18% in placebo at week 8.

These early results indicate that MH002 is safe and well tolerated by patients, and has potential efficacy in mild-to-moderate UC patients who have not responded sufficiently to firstline treatment," commented Séverine Vermeire, coordinating investigator of study MH002-UC-201 and Professor of Medicine at the KU Leuven, Belgium. "There is a significant absence of treatments for UC patients, particularly in this population, so I look forward to conducting the full analysis of the data and following MH002's progression through the clinic."

Bruce Sands, Professor of Medicine at the Icahn School of Medicine at Mount Sinai, New York and paid consultant to MRM Health, added: "MH002's mechanism of action and anti-inflammatory effect in UC look very promising, with the potential of a highly favorable benefit/risk balance, pending larger con-firmatory studies. These topline results also suggest that this formulation could have applications across a wider range of other inflammatory bowel disorders, including pouchitis, in which MH002 is also being tested

ADSCC successfully manufactures **UAE's first CAR-T cell to treat boy**

ABU DHABI, UAE, Sept 19: Abu Dhabi Stem Cells Center (ADSCC), a PureHealth subsidiary and the largest healthcare platform in the Middle East, has successfully manufactured the UAE's first CAR-T cells to treat an 11-year-old boy with leukemia. Engineered CAR-T cells therapies are recognized as a breakthrough in blood cancer treatment.

The child, Murad, was diagnosed with leukemia more than five years ago and went into remission, but unfortunately, the leukemia returned approximately six months ago. Murad underwent chemotherapy, as per standard protocols for his case, but did not respond to that treatment. At that point, CAR-T cell therapy was the only treatment option available for him.

The procedure involved manufacturing the cellular product (CAR-T), which relies on the use of immune cells from the patient, at ADSCC's Good Manufacturing Practices (GMP) laboratories - one of very few laboratories in the Middle East. The treatment took five weeks, during which Murad was admitted at ADSCC, the only accredited Centre of Excellence in Hematopoietic Stem Cell Transplantation in Abu Dhabi. Physicians withdrew the cells from the patient and genetically modified his immune cells in the laboratory to fight the cancer cells after intravenously injecting them into the patient.

Rapper Scott questioned over deadly crowd surge lawsuits

HOUSTON, Sept 19, (AP) - Rap superstar Travis Scott was questioned for several hours on Monday in a civil deposition he gave in connection with hundreds of lawsuits that were filed against him and others over the deaths and injuries at the 2021 Astroworld festival.

Lawyers and others connected to the civil lawsuits are under a gag order, preventing them from saying little beyond what happens during court hearings.

"Travis Scott's deposition is typical legal procedure. What is not typical is how the media continues to focus on him despite being cleared of any wrongdoing by extensive government investigations, including by the Houston Police Department," Ted Anastasiou, a spokesperson for Scott, said in a statement. "Travis is fully cooperating with the legal process while still remaining committed to his tour in support of his record-breaking album, 'Utopia,' and his charitable efforts to support at-risk communities.' Following an investigation by Houston Police, no charges were filed

against Scott after a grand jury in June declined to indict him and five other people on any criminal counts related to the deadly concert. Police Chief Troy Finner declined to say what the overall conclusion of his agency's investigation was.

In July, the police department made public its nearly 1,300-page investigative report in which festival workers highlighted problems and warned of possible deadly consequences.

According to a summary in the investigative report of a police interview conducted two days after the concert, Scott told investigators that although he did see one person near the stage getting medical at-

tention, overall the crowd seemed to be enjoying the show and he did not see any signs of serious problems. This was the first time Scott was questioned by attorneys for those who have filed lawsuits since a crowd surge at his Nov. 5, 2021, concert in Houston killed 10 festivalgoers. Those killed, who ranged in age from 9 to 27, died from compression

asphyxia, which an expert likened to being crushed by a car.

Similar crushes have happened all over the world, from a soccer stadium in England to the hajj pilgrimage in Saudi Arabia to Halloween festivities in the South Korean capital. Most people who who die in crowd surges suffocate.

Scott's deposition comes as a judge earlier this year scheduled the first trial from the lawsuits for May 6, 2024. That first trial would take place nearly 2.5 years since the deadly concert.

Distress

Documents filed in court in April listed more than 1,500 active cases, many of which were filed against Scott and Live Nation, the concert promoter.

Of these, 992 were cases with physical injuries and 313 were cases of "emotional distress, pain, suffering and mental anguish." Orthopedic surgeries have been completed in 17 of these cases, with other surgeries recommended in another 21.

Some of the lawsuits have since been settled, including those filed by the families of three of the people killed during the concert. Scott's deposition on Monday took place on the same day that hiphop artist Drake, who performed several songs with Scott during the Astroworld concert, was performing in Houston. Drake was also sued in connection with the deadly concert.

NEW YORK: Bill Maher has delayed returning to his HBO talk show during the ongoing strike by writers and actors, a decision that follows similar pauses over the weekend by "The Drew Barrymore Show," "The Talk" and "The Jennifer Hudson Show.

Maher last week said he would bring his show back into production, but on Monday said he'll wait because talks are scheduled to begin between producers and writers on Wednesday.

"My decision to return to work was made when it seemed nothing was happening and there was no end in sight to this strike," Maher said via social media. "Now that both sides have agreed to go back to the negotiating table I'm going to delay the return of 'Real Time,' for now, and hope they can finally get this done.'

Barrymore, who drew criticism for taping new episodes of her daytime talk show despite the ongoing writers and actors strikes, said Sunday she'll wait until the labor issues are resolved.

"I have listened to everyone, and I am making the decision to pause the show's premiere until the strike is over," Barrymore posted on Instagram on Sunday. "I have no words to express my deepest apologies to anyone I have hurt and, of course, to our incredible team who works on the show and has made it what it is today.

LACONIA, NH: Marilyn Manson was sentenced to 20 hours of community service and a fine on Monday after pleading no contest to blowing his nose on a videographer at a 2019 concert in New Hampshire.

The shock rocker, 54, wanted to appear via video for his hearing on the misdemeanor charge, but the judge required him to be in the courtroom in Laconia, about 30 miles north of **Concord**, the state capital.

Manson, whose legal name is Brian Warner, was charged with two misdemeanor counts of simple assault stemming from the encounter with the videographer at the Bank of New Hampshire Pavilion in **Gilford** on Aug 19, 2019.

Manson pleaded no contest to just the nose-blowing charge in a fully negotiated plea agreement with prosecutors. The prosecutors agreed to dismiss the other charge, which alleged that he spit on the videographer. A no contest plea means Manson is not contesting the charge and does not admit guilt.

Manson was fined a little more than \$1,400 as part of the deal, with \$200 suspended. He needs to remain arrest-free and notify local police of any New Hampshire performances for two years.

The judge, who called Manson's acts "egregious," agreed to allow Manson to do his community service in California. Manson mentioned to reporters that he might choose to work with people in recovery. He has to give proof of his community service by Feb. 4.

According to a police affidavit, Manson approached videographer Susan Fountain in the venue's stage pit area, put his face close to her camera and spit at her. She was struck on both hands with saliva. He approached her again later, kneeling and covering one nostril before blowing the other on her arms and hands.

Manson "blows a significant amount of mucous at Fountain, a police sergeant who reviewed concert video footage said in the affidavit. After that, the camera view changes and people can see Manson "point and laugh at Fountain as she gets down and walks away," the affidavit said.

Fountain was not in court, but submitted a statement that was read aloud. Several women have sued

'Promising' director's cinematic evolution

Fennell crafts dark drama in 'Saltburn'

NEW YORK, Sept 19, (AP): Countless English protagonists have for decades been making their way to grand country estates where their lives are irrevocably changed. "Brideshead Revisited." "The Go-Between." "Remains of the Day." "Rebecca."

These are some of the books that Emerald Fennell grew up devouring. And when the dust had settled on "Promising Young Woman," her incendiary Oscarwinning directorial debut, Fennell, too, wanted to make her way to a fictional stately manor.

"I really wanted to make a movie that was a take on the classic English gothic story," Fennell says. "It felt like an incredibly well-worn and therefore intriguing genre to start looking at and applying pressure to.

In "Saltburn," which opens in theaters Nov. 24, Fennell applies her particular and potent brand of pressure to the one of the longest standing British genres. And given the bleakly vengeful conclusion of her provocative debut, it's safe to say that things get quite a bit bumpier at Saltburn than they ever did at Downton Abbey.

Fennell has already been a memorable part of one conversation-starting film this year. That was her as Midge, the pregnant doll, in Greta Gerwig's "Barbie.

Like that film, "Saltburn," which Fennell wrote and directs, includes Margot Robbie as a producer. It stars Barry Keoghan as Oliver Quick, an Oxford University freshman on a scholarship who's drawn to a dashing, aristocratic classmate named Felix Catton (Jacob Elordi). Their relationship has strong echoes of "The Talented Mr. Ripley" to it.

In the summer of 2006, Felix invites Oliver to his family's estate where he fits in sometimes awkwardly and sometimes smoothly but increasingly eerily with the extravagant flow of life. Things get steamy, weird and dark as Fennell toys with class as she did with gender in "Promising Young Woman."

Several in the cast give standout performances - especially Rosamund Pike, who plays Felix's mother. But it's also a rare leading performance for Keoghan, himself coming off an Oscar nomination for "The Banshees of Inisherin." Already some of his scenes - one involving some leftover bathtub water, one a fresh grave - have added to the early buzz around "Saltburn."

"I saw Barry in 'Killing of a Sacred Deer' and I just couldn't believe it," Fennell said in a recent interview from London. "That performance was so amazing. It's a kind of once-in-a-lifetime arresting performance. I just thought immediately: Who is that?

The opportunities were many for Fennell after the success of "Promising Young Woman." The film, a blackly comic feminist revenge thriller starring Carey Mulligan, was one of the most talked about movies of 2020. In that first pandemic year, it went on to be nominated for five Oscars including best picture and best director. Fennell won for her script.

Surreal

"None of us had anticipated how amazing the response would be," Fennell says. "Because of COVID, I was in a bubble with my young family. So it maybe didn't feel as surreal as it might. I mean, everything was surreal, so it kind of felt like another surreal thing."

Once the pandemic subsided, Fennell's focus turned to "Saltburn," a film that seemingly could have pulled from her own experiences. Fennell, who attended the elite boarding school Marlborough College and studied at Oxford, is the daughter of jewelry designer and socialite Theo Fennell and author Louise Fennell.

Fennell, though, is reluctant to draw any connections between the high society of her youth and "Saltburn." Yes, the 37-year-old grants, she attended Oxford around the same time as the characters in the film.

"But I'm afraid the similarities end there," she says. "It definitely wasn't quite as sexy.

Did she consider herself an outsider like Oliver or more of an insider like Felix?

"I was kind of like Oliver, mostly outside of it but occasionally having seen it as well," Fennell says. "The fascinating thing about these sorts of systems in general, both in America and in England, is that nobody ever really knows whether they're in or out."

To her, "Saltburn" is more about those anxious undercurrents among family, friends and hangerson, each playing by unspoken codes of money, class and privilege.

'There was a world where 'Saltburn' might have been set in the Hamptons," Fennell says. "If you're allowed in these places, it's never a one-way ticket. Honestly, it could be set anywhere. It could be set in Los Angeles and the court, rather than being a stately home, is a compound of an incredibly famous actor and actress. It all works the same way. It's power. Who wants it and who's got it."

Fennell, who was the showrunner and an executive producer for the second season of "Killing Eve," often used the phrase "poison popcorn movie" to describe "Promising Young Woman" - an entertainment laced with more disturbing issues to contemplate.

She remains committed to eliciting that kind of dual response - something that people are eager to watch and just as eager debate after on their way home. Her current favorite film, which she says she's seen 20 times, is Ari Aster's "Beau Is Afraid." "I think it's truly the greatest film of the last 10 years and I'm obsessed with it," Fennell says.

It would be giving too much away to describe how "Saltburn" unspools. But to Fennell, it's ultimately about the deep longing and ambition of Oliver, a young man yearning to live. It's a love story, she says.

"This movie feels to me like the closest thing to wanting something," says Fennell. "There's a particular type of need and want that you feel at a certain point in your life when it's the first time you felt it, whether it's about a person or a place. The intensity of the desire to make yourself. That, to me, is what the film is about."

The Who's masterpiece Rootsy harmonies on Millers' 'Throes'

Buddy and **Julie Miller** have been wed for 40 years. Their latest album, "In the Throes," celebrates the marvelous marriage of his rustic, raspy tenor and her eternally youthful alto.

The 12-song set, which will be released Friday is filled with the Tennessee duo's rootsy harmonies that bridge genres and are a model of an equal partnership. At times, either vocal line could be the melody, as with some Everly Brothers songs.

The Millers also shine singing solo. Buddy's at his plaintive, full-throated best on the ballads "Don't Make Her Cry" and "I'll Never Live It Down," which showcase the Ohio native as a South-



ern soul man. His distinctive electric guitar work is equally

compelling. Julie takes the lead vocal on "I've Been Around," a delightful slice of bluesy bravado, dissonance and distortion punctuated by her antic shouts of "Hey! Hey!" She says the song came to her in her sleep, and she awoke to record it immediately in one take, which is just how it sounds.

Julie

By contrast, "Don't Make Her Cry" required years to complete - Julie, Bob Dylan and Regina McCrary passed it around and share composing credit.

Julie is the sole songwriter on the other cuts, and there's a recurring spiritual strain. "Niccolo" mixes sweet and savory pop and finds comfort in angels, while "The Last Bridge You Will Cross" pays rev-erent tribute to the late Rep. John Lewis for making love a weapon. The infectious country gospel singalong "We're Leavin" offers uplift, as does the simple ballad "I Love You," where the Millers harmonize about the permanent bond that is a happy marriage.

"Who's Next/Life House" - The Who's massive new box set - dives deep down the archival rabbit hole to shed light on the development of one of the band's greatest records – and one grandiose idea that (mostly) slipped away.

The 10-disc, 155-track collection shows how Pete Townshend's self-described "mad idea" for a science fiction rock opera "Life House" project, which was abandoned and eventually became 1971's "Who's Next."

But the sprawling original concept from The Who's songwriter, lead guitar player and vocalist never left his mind and got refashioned numerous times in various formats over the ensuing half century

Åt its most basic, Townshend's original "Life House" concept foresees a future where an autocratic government, in a land ravaged by pollution, enforces a national lockdown where every person is hooked up to an entertainment grid to distract them. Music becomes an inconvenient diversion to the powers that be, while inhabitants search for the

LOS ANGELES, Sept 19, (AP): Music fans, it is time to bid adieu to the sunny, slow summer months, and welcome fall - historically, one of the busiest times in the calendar year for new albums, EPs, and mixtapes.

Trends have already begun to reveal themselves: Some of the biggest names in pop (and in pop's future) are gearing up for back-to-school releases. A-listers are returning after years. Country legends are taking on new genres. And hip-hop heavyweights are back in full force.

Doja Cat's "Scarlet" arrives. Ed Sheeran has seemingly run out of mathematical symbols to name albums after and will return with an autumnal release. After HBO's "The Idol," Trove Sivan gears up to release his third fulllength album. If the rest of the tracks contain songs half as sexy as the football chant homoeroticism of the lead single "Rush," listeners are in for a treat. BTS member V will release his debut solo album; Korean American popstar Eric Nam will drop another self-released record, centered on a pandemic-induced existential crisis. The exhaustive box set allows the listener to observe the evolution of some of The Who's best and most well-known songs, including "Won't Get Fooled Again," "Baba O'Reilly" (aka "Teenage Wasteland"), "Behind Blue Eyes" and "Goin' Mobile."

While first envisioned for "Life House," the songs eventually were released on "Who's Next," a record that to the uninitiated may appear to be a greatest hits compilation, it's just that good.

There's plenty here for Who nerds to take a deep dive. One fascinating bit is hearing the difference in the demos, sung by Townshend, and the versions that were ultimately released with Roger Daltrey's signature vocals – including the epic scream that defined the official version of "Won't Get Fooled Again.

Townshend writes the liner notes for the original "Life House" demos he recorded at his home studio, working tirelessly with some of the earliest synthesizer technology. His devotion to the material is reminiscent of other artists from that time, most notably Brian Wilson and the Beach Boys "Smile" sessions, who struggle to translate the ideas and songs in their head into a finished product.

In fact, Townshend reportedly came close to having a nervous breakdown while working out the material.

"I have to say I am still so deliriously proud of the work I did on this music," Townshend writes. "When The Who perform it on stage, I sometimes give a little prayer of gratitude to that young man I once was who worked so hard on this for several weeks in that tiny studio full of dozens of excluded lengths of tape edited out to make it fly.

As an added bonus, the box set also includes other songs recorded in the era, a "Life House" graphic novel and two complete 1971 concerts that showcase The Who in their prime debuting the material with some crowd pleasers like "Pinball Wizard" and "My Generation" sprinkled in.

LOS ANGELES: Drake has finally announced a released date for his highly anticipated eighth studio album: "For All the Dogs" will drop Sept. 22. The follow-up to 2022's "Honestly, Nevermind"

- which released without warning - was announced on the Canadian rapper's Instagram on Wednesday night. Drake wrote the release date in the caption of the post, which featured video footage depicting his father. Dennis Graham.

A representative confirmed the date on Thursday.

Drake - who is currently on his "It's All a Blur" tour - had teased the project for a few months, including at a July 2023 New York City concert, where the rapper told the capacity-filled Barclays Center crowd his next album would drop in approximately "a couple of weeks."

The 36-year-old megastar, known for surprise releasing music, teased the potential project at his intimate Apollo show in January.

The new album features several collaborations Drake has mentioned live on stage in the last few months, including one with Nicki Minaj and another track with reggaetonero Bad Bunny.

"It was shocking when I found out part of the album leaked - at the time - that it wasn't ever going to come out, especially as I poured so much of myself into it. I was heartbroken but, at the same time, it was really exciting to see my fans listening to the tracks and loving them," Petras said in a statement to The Associated Press.

"Now that I'm able to put them out. it's just so freeing to have more music that I love out in the world and officially share them in a way that all my fans can hear them."

That opinion is shared by Hilton. "Recording 'All She Wants' at Kim's house was so much fun," she said in a statement. "The song is all about being unapologetically fabulous, a sentiment both Kim and I live by.

The road to "Problematique" has been a difficult one. In 2021, Petras signed with major label Republic Records and announced the album - then scheduled to be her full-length debut - but it was eventually scrapped and leaked.

It was a disappointing turn of events for Petras and her fans, who had long awaited her first album. It wasn't until June that she released what would become her actual debut, the Eurodance-pop "Feed the Beast."

Releasing "Problematique" now, in some ways, is a way to keep her fans on their toes - and a way of taking something that was stolen from her and packaging it in a way that feels true.

The album was released due to fan demand and in advance of her "Feed the Beast" world tour, which kicks off on Sept 27 in Austin, Texas, and concludes in Milan on March 5. Petras says fans can expect to hear some of their favorite tracks from across her vast discography. (AP)

Use 'science of math' in US classrooms: experts

NEW YORK, Sept 19, (AP): For much of her teaching ca-reer, Carrie Stark relied on math games to engage her students, assuming they would pick up concepts like multiplication by seeing them in action. The kids had fun, but the lessons never stuck.

A few years ago she shifted her approach, turning to more direct explanation after finding a website on a set of evidencebased practices known as the science of math.

"I could see how the game related to multiplication, but the kids weren't making those connections," said Stark, a math teacher in the suburbs of Kansas City. "You have to explicitly teach the content.'

As American schools work to turn around math scores that plunged during the pandemic, some researchers are pushing for more attention to a set of research-based practices for teaching math. The movement

has passionate backers, but is still in its infancy, especially compared with the phonics-based "science of reading" that has inspired changes in how classrooms across the country approach literacy

Math is hard — even for teachers. What if they conquered their math anxiety?

Experts say math research hasn't gotten as much funding or attention, especially beyond the elementary level. Meanwhile, the math instruction

schools are currently using doesn't work all that well. The US trails other high-income countries in math performance. and lately more students graduate high school with deficits in basic math skills.

Advocates say teaching practices supported by quantita-tive research could help, but they are still coming into focus.

"I don't think the movement has caught on yet. I think it's an idea," said Matthew Burns, a professor of special education at the University of Florida who was among researchers who helped create a Science of Math website as a resource for teachers.

There's a debate over which evidence-based practices belong under the banner of the science of math, but researchers agree on some core ideas.

Principle

The foremost principle: Math instruction must be systematic and explicit. Teachers need to give clear and precise instructions and introduce new concepts in small chunks while building on older concepts. Such approaches have been en-dorsed by dozens of studies highlighted by the Institute of Education Sciences, an arm of the US Education Department that evaluates teaching practices.

That guidance contrasts with exploratory or inquirybased models of education, where students explore and discover concepts on their own, with the teacher nudging them along. It's unclear which approaches are used most widely in schools.

In some ways, the best practices for math parallel the science of reading, which emphasizes detailed, explicit instruction in phonics, instead of letting kids guess how to read a word based on pictures or context clues. After the science of reading gained prominence, 18 states in just three years have passed legislation mandating that classroom teachers use evidence-backed methods to teach reading

Margie Howells, an elementary math teacher in Wheeling, West Virginia, first went researching best practices because there weren't as many resources for dyscalculia, a math learning disability, as there were for dyslexia. After reading about the science of math movement, she became more explicit about things that she assumed students understood, like how the horizontal line in a fraction means the same thing as a division sign.

"I'm doing a lot more instruction in vocabulary and symbol explanations so that the students have that built-in up derstanding," said Howells, who is working on developing a science-based tutoring program for students with dyscalculia and other learning differences. Some elements of math instruction emphasize big-picture concepts. Others involve learning how to do calculations. Over the decades, clashes between schools of thought favoring one or another have been labeled the "math wars." A key principle of the science of math movement is that both are important, and teachers need to foster procedural as well as conceptual understanding. "We need to be doing all those simultaneously," Stark said. When Stark demonstrates a long division problem, she writes out the steps for calculating the answer while students use a chart or blocks to understand the problem conceptually. Stark helps coach fellow teachers at her school to support struggling students - something she used to feel unequipped to do, despite 20 years of teaching experience. Most of the resources she found online just suggested different math games. So she did research online and signed up for special trainings, and started focusing more on fundamentals. For one fifth grader who was struggling with fractions, she explicitly re-taught equivalent fractions from third grade why two-fourths are the same as one-half, for instance. He had been working with her for three years, but this was the first time she heard him say, "I totally get it now!" "He was really feeling success. He was super proud of

Health experts on alert as COVID hospitalizations rise 'BA.2.86 variant can dodge immunity'

The latest variant, or sublineage, of SARS-CoV-2 to emerge on the scene, BA.2.86, has public health experts on alert as COVID-19 hospitalizations begin to rise and the new variant makes its way across the globe.

The Conversation asked Suresh V. Kuchipudi, a virologist and infectious disease expert at the University of Pittsburgh School of Public Health, to explain what researchers know about BÅ.2.86's ability to dodge immune protection and whether it causes more severe infection than its predecessors.

BA.2.86, nicknamed Pirola, is a highly mutated new omicron sublineage of SARS-CoV-2 that was first detected in Denmark in July 2023. The World Health Organization announced

BA.2.86, the newest sublineage on the scene, seems to have come from the older BA.2 omicron lineage that was dominant in early 2022 and not from the newer omicron offshoots.

A preliminary study reported that BA.2.86 features 33 distinct spike mutations when compared to its precursor, BA.2. The spike proteins, which form the knobby protrusions coming off the main body of the virus, are like a key that the virus uses to unlock our cells, which is how a new infection begins.

After an infection by one of the variants that cause COVID-19, our bodies create antibodies that target the spike protein to help neutralize the virus and prevent it from infecting cells. So, numerous changes in the spike protein of BA.2.86 could potentially affect how well it evades antibodies as well as the degree of disease severity it causes.

Among the new mutations that BA.2.86 carries, 14 reside within an area of the spike protein called the re-

However, in contrast, another new study that has not yet been published found that neutralizing antibody re-sponses against BA.2.86 were comparable to or slightly higher against the recent XBB sublineages. Hence further studies are needed to understand BA.2.86's ability to escape antibody protection.

The emergence of BA.2.86 underscores the need for flexibility in current vaccine strategies to ensure continued effectiveness against these new variants. The newly FDA-approved fall 2023 COVID-19 booster shots are formulated to target XBB.1.5, which was dominant in early 2023 when public health officials made the reformulation decisions. The 2022 booster shot was designed to target both the original strain of SARS-CoV-2 as well as the BA.4 and BA.5 omicron lineages.

We researchers have much more to learn about BA.2.86's capacity to evade antibody protection from prior

himself," Stark said.

Algorithms

Still, skeptics of the science of math question the emphasis placed on learning algorithms, the step-by-step procedures for calculation. Proponents say they are necessary along with memorization of math facts (basic operations like 3x5 or 7+9) and regular timed practice - approaches often associated with mind-numbing drills and worksheets.

Math is "a creative, artistic, playful, reasoning-rich activity. And it's very different than algorithms," said Nick Wasserman, a professor of math education at Columbia University's Teachers College.

Supporters argue mastering math facts unlocks creative problem-solving by freeing up working memory - and that inquiry, creativity and collaboration are still all crucial to student success.

"When we have this dichotomy, it creates an unnecessary divide and it creates a dangerous divide," said Elizabeth Hughes, a professor of special education at Penn State and a leader in the science of math movement. People feel the need to choose sides between "Team Algorithms" and "Team Exploratory," but "we really need both."

Best practices are one thing. But some disagree such a thing as a "science of math" exists in the way it does for reading. There just isn't the same volume of research, education researcher Tom Loveless said.

"Reading is a topic where we have a much larger amount of good, solid, causal research that can link instruction to student achievement," he said.

To some, the less advanced state of research on math reflects societal values, and how many teachers themselves feel more invested in reading. Many elementary school teachers doubt their own math ability and struggle with anxiety around teaching it.

"Many of us will readily admit that we weren't good at math," said Daniel Ansari, a professor of cognitive neuroscience at Western University in Canada. "If I was illiterate, I wouldn't tell a soul.'

Still, Ansari said, there is enough research out there to make a difference in the classroom.

"We do understand some of the things that really work," he said, "and we know some of the things that are not worth spending time on.³

William sees oyster reef project: Prince William got a first-hand look at the waters of New York City on Monday on a visit to an oyster reef restoration project, after arriving in the United States for an environmental summit connected to a global competition for solutions to climate change challenges.

William was taken to Governors Island in New York Harbor to see the efforts of the Billion Oyster Project. The organization is trying to rebuild the oyster reefs that were once abundant in New York waters, and which can help with water filtration and protect against storm damage.

William also met Monday with UN Secretary-General António Guterres, according to the UN. It said the two discussed efforts needed to step up the fight against climate change, as well as ways to finance development and improve implementation of key UN goals.

On Tuesday, William is scheduled to speak at the Earthshot Prize Innovation Summit. He founded the prize, which looks for ways to address problems created by climate change, and is announcing a second group of finalists.

The summit is taking place during New York Climate Week and the 78th convening of world leaders at the United Nations General Assembly. (AP)

Wild black bear captured: It wasn't an escapee from the Country Bear Jamboree at-traction, but a wild black bear managed to be the star of its own show Monday at Walt Disney World.

The presence of the black bear in a tree in the Magic Kingdom delayed the opening of three lands Monday morning - Frontierland, Liberty Square and Adventureland.

Staffers with the Florida Fish and Wildlife Conservation Commission were at the park, attempting to capture and relocate the bear. Disney World said in a statement. The bear was eventually captured Monday afternoon.

The bear was likely in search of food as it looks to pack on fat reserves for the winter, the wildlife commission said in a statement.

"In most cases, it is best for bears to be given space and to move along on their own, but given this situation, staff are working on capturing and relocating the bear," the wildlife commission said.

The wildlife commission estimates there are more than 4,000 black bears in Florida, with the most located in central Florida. (AP)

A variant is an alternate version of a virus - in this case, the SARS-CoV-2 virus that causes COVID-19 - that has some mutations or changes in its genetic code, compared with the original. Mutations can alter the behavior of the viruses in various ways, such as how effectively they break into cells and how rapidly they can replicate.

The WHO names these variants using Greek alphabet letters, like alpha, delta and omicron. However, another naming system called the PANGO, or pangolin - short for phylogenetic assignment of named global outbreak lineages - tracks variants and their offshoots by way of a lineage system.

Think of it as a family tree for the virus, which is grouped into different lineages, like branches on a tree. The omicron variant is like a big family, and its known family members - BA.2, BA.2.86 and XBB.1.5 - are all branches - or lineages and sublineages - on the same tree.

After the omicron variant showed up in November 2021, it didn't stay the same for long. It kept changing, and soon we got different sublineages of it, such as BA.2, BA.4 and BA.5. The one that's been dominant globally for most of 2023, called XBB.1.5, originated from the mixing, or recombination, of two separate sublineages.

But what's interesting is that

In addition, the new sublineage, BA.2.86, is even more dissimilar when compared to the most recent sublineage, XBB.1.5, with 35 new mutations in the spike protein - including some unusual mutations - than to its precursor, BA.2. These alterations intrigue infectious disease specialists like me, and we are working to understand how they might affect this new variant's behavior.

We researchers do not yet fully understand what these changes might mean and the degree to which BA.2.86 can get around our protective defenses.

Scientists and health authorities closely monitor all emerging variants and lineages for changes that can affect how easily the virus is transmitted. what it might mean for vaccine effectiveness and the severity of disease it can cause. While mutations can be cause for concern, it's important to remember that not all mutations lead to increased danger.

The earlier-mentioned preliminary study found that BA.2.86 can escape the protective defenses of antibodies against the recent XBB sublineages.

This critical information helps scientists and doctors make better decisions to protect public health

COVID-19 variants continue to stay one step ahead of our efforts at combating them, so it will become increasingly important that the US step up its genomic surveillance efforts and stay committed to working collaboratively with other countries. (AP)

Grievance filed by NFL says players' union leaders advised RBs to fake injuries

WASHINGTON, Sept 19, (AP): The NFL has filed a griev-ance against the NFL Players Association, alleging that union leaders, including President JC Tretter, have advised running backs to "consider feigning or exaggerating injuries" to help increase their leverage in contract negotiations.

The grievance was filed on Sept. 11 and will be reviewed by an arbitrator.

In a memo sent to the league's management council executive committee and obtained by The Associated Press, the NFL said the union made the suggestion to running

backs during a Zoom meeting before the season.

Any player who took the union's advice and faked an injury would be violating the collective bargaining agreement, the league argued.

'This conduct is a clear violation of the union's agreement to use 'best efforts to faithfully carry out the terms and conditions of the (CBA)' and 'to see that the terms and conditions of all NFL Player Contracts are carried out in full by players," the memo said. "The union's conduct is also reckless as any player that chooses to follow this advice and improperly withhold services under his player contract will be subject to discipline and financial liability under the CBA, club rules, and/or the player's contract."

The league's grievance seeks for the union to "cease

and desist from such improper conduct as well as other remedies that the arbitrator may deem appropriate."

Giants star running back Saquon Barkley and Raiders All-Pro Josh Jacobs refused to sign their \$10.1 million franchise tags and were unhappy about not getting longterm contracts.

Colts RB Jonathan Taylor has been involved in a contract dispute and was placed on the physically unable to perform list to start the season because he's recovering from offseason ankle surgery.

Tretter spoke openly about the contract issues running backs are facing on former NFL player Ross Tucker's podcast in July.

"You need to try to create as much leverage as you pos-

sibly can," Tretter said. Hudson-Odoi scores on Forest debut to help salvage draw vs Burnley

Torino rout Salernitana; Bologna and Hellas Verona draw



NOTTINGHAM, England, Sept 19, (AP): Callum Hudson-Odoi marked his first Premier League appearance in 18 months with a goal to help Nottingham Forest rally for a 1-1 draw at home against Burnley, which earned its first point of the campaign.

The 22-year-old former Chelsea player spent last season on loan at Bayer Leverkusen but served up a reminder of what he can do as he was Forest's biggest attacking threat on his debut for his new team following a deadline-day move from Stamford Bridge. He brought his side level with a curling effort in the second half after Zeki Amdouni had put Burnley ahead.

It was Burnley's first point after three successive losses, but the visitors were denied a late winner by VAR and finished the game with 10 men after Lyle Foster was sent off for elbowing Ryan Yates.

Having once been considered one of the brightest prospects in English soccer, with Bayern Munich among the teams reportedly interested in signing him, Hudson-Odoi is now looking to revive his career after Chelsea decided to let him go.

Forest manager Steve Cooper coached him when in charge of England's Under-17 World Cupwinning team and has been quick to get him firing at his new club. Hudson-Odoi curled a 20-yard shot in off the far post to level the score in the 61st. Burnley had taken the lead in the 41st when Amdouni fired into the bottom corner. Foster thought he had scored the winner for Burnley in the 76th, but Sander Berge was ruled to have used his hand in the buildup.

Lions & Campbell aet mixed results

ALLEN PARK, Mich., Sept 19, (AP): Detroit Lions coach Dan Campbell made some aggressive and conservative decisions in a 37-31 overtime loss to Seattle on Sunday.

"I knew I wanted to play that game a certain way early, but also knew if it doesn't quite work out that way we go the long road and win it at the end and we weren't able to do that," Campbell said on Monday.

The usually gutsy coach went for it on fourth-and-4 instead of attempting a 48-yard field goal in the second quarter and Jared Goff threw an incomplete pass; went for it on fourth-and-3 and eventually scored a touchdown on the drive in third quarter; went for it on fourth-and-2 instead of a punt, helping Seattle have better field position to set up a touchdown at the end of the third quarter. Then on fourthand-3 at the Seattle 20, he went for the game-tying field goal with 3 seconds left because he said it was too much of a risk to go for it.

Campbell liked their chances in overtime, but never got the ball after Seattle won the toss.

There was little sense of urgency when the Lions got the ball at midfield down three points with 1:44 left.

European soccer could see more disruption

GENEVA, Sept 19, (AP): International soccer games could again be affected by the territorial dispute between Azerbaijan and Armenia that reignited Tuesday.

Norwegian team Molde was traveling Tuesday to Azerbaijan two days ahead of a scheduled game in the Europa League against Qarabag. As Molde players and officials were in transit, Azerbaijan launched what it called an "anti-terrorist operation" targeting Armenian military positions in the Nagorno-Karabakh region.

"We're on our way and with a stopover in Warsaw for fuel now,

before heading for Baku, that's our plan," Molde spokesman Per Lianes wrote in an email to The Associated Press.

UEFA said it is "monitoring the situation and is in close contact with the host association" of Azerbaijan.

The latest conflict follows rising tensions this month in the region that was the scene of a separatist war that started in the 1980s and a six-week war in 2020.

Nagorno-Karabakh and sizable surrounding territories were under ethnic Armenian control since 1994. Azerbaijan regained the territories and parts of Nagorno-Karabakh itself in 2020. That war ended with an armistice that placed a Russian peacekeeper contingent there.

Three years ago, UEFA required club and national teams

Finally, the Asia qualifiers for the 2025 World Cup are scheduled to be held in Bahrain from January 14-25, 2024.



Saints improve 2-0

PITTSBURGH, Sept 19, (AP): T.J. Watt scooped up a fumble by DeShaun Watson and ran 17 yards for the go-ahead touchdown midway through the fourth quarter, and the Pittsburgh **Steelers beat the Cleveland** Browns 26-22 on Monday night in a game overshadowed by a serious knee injury to Cleveland star running back Nick Chubb.

The Steelers (1-1) beat the Browns (1-1) for the 20th straight time at home in the regular season when outside linebacker Alex Highsmith - who returned an interception for a touchdown on the game's first snap - beat Cleveland left tackle Jedrick Wills Jr. off the edge and chopped the ball out of Watson's hands.

Watt picked it up and raced home as Pittsburgh extended its home winning streak on Monday night to 21 straight dating to 1991. Cleveland allowed an opponent to score two defensive touchdowns for the first time since Pittsburgh did it on Oct. 16, 1983.

The Browns played most of the final three quarters without Chubb, who took a handoff from Watson early in the second quarter and reached the Pittsburgh 3. Steelers safety Minkah Fitzpatrick dove at Chubb's legs, and the four-time Pro Bowler's left leg bent awkwardly underneath him. He was carted off the field.

Jerome Ford, Chubb's replacement, ran for 106 yards and caught a 3-yard touchdown pass for the Browns, but Cleveland's miscues cost it a chance to win at Pittsburgh in the regular season for the first time since 2003

Watson completed 22 of 40 for 235 yards with a touchdown and an interception. He was also flagged twice for unsportsmanlike conduct for grabbing the facemask of a Steeler while running. The penalties cut a pair of promising drives short.

LONDON, Sept 19, (AP): Finland's reward for beating the United States and Croatia to reach the knockout stage of the Davis Cup is a quarterfinal match against defending champion Canada.

Finland has never reached this stage before in the top team event in men's tennis.

The draw for the Final 8 was made on Tuesday. Serbia will play Britain, the Czech Republic will meet Australia and Italy will take on the Netherlands in the other matches in the quarterfinals.

The Final 8 takes place in Malaga, Spain, from Nov. 21-26.
