
This question was raised by circles close to the decision-makers

The improper implementation of the decisions vexed the society, whether at the university or the Ministry of Education, especially the flexible working hours and the like, which is subject to major criticism from the educational body, as well as in most ministries. It is as if we are in a vicious circle from which there is no way to escape. We blame the so-called elite, as they were supposed to work on

eveloping minds, but they fell into the dilemma of submitting to some parliamentarians, leaving three or four of them to impose their orientations and visions that conflict with Kuwaiti society. This means deviating from the principle of the state of institu-

tions is considered, at the same time, as a painful blow to the development of Kuwait, which has been suffering for three decades from stagnation and backwardness.

This situation requires uprooting it from its roots and stopping the infiltration of corruption, which has been continued by the fangs of the deep state.

Another issue that cannot be tolerated is the financial demands that parliamentarians propose day and night to shackle the state with a huge budget as it tries to move towards the future.'

The circles praised the directions of the Minister of Finance Fahad Al-Jarallah, stressing that he announced a set of "very good" ideas that will bear fruit if they are implemented according to a fair principle, and revealed that the articles of the Constitution allow the government to impose taxes.

They said, "If the tax system is carefully studied and established as it is supposed to be established in various global countries where they take from the powerful, the wealthy, and companies, and work to develop the infrastructure, as well as sort those with limited and low incomes, it would benefit the state and take into account the interests of the people.

Everyone has become convinced that the welfare state ended a long time ago, and that continuing to ignore this trend is the reason for the financial confusion facing Kuwait, in addition to the corruption whose scope is expanding day after day.

MP sounds alarm as fraud crimes on rise

KUWAIT CITY, Sept 24: MP Khalid Al-Otaibi says the decision issued by Iraq's Federal Court about the constitutionality of the treaty signed between Kuwait and Iraq on the use of Abdullah Bay has false claims with no foundations, adding that it also ignored the United Nations' regulations.

He explained that the agreement between Kuwait and Iraq was signed in 2012 and approved by the legislative authorities of both countries before being referred to the United Nations. These as-

pects prevent any party from suspending the treaty.

The decision of Iraq's Federal Court was laden with hateful words that expose the Iraqi position towards Kuwait, and indicate that nothing of the Iraqi hostility towards Kuwait has changed despite the nonstop support provided by Kuwait to Iraq since the Liberation.

The decision of the Federal Court unmasked the schemes and bad intentions plotted by Iraq against Kuwait and aimed at abandoning the international commitments.

MP Al-Otaibi stressed the need to continue exerting diplomatic efforts and adopting a firm position towards the Iraqi hostilities to conclude the permanent agreements on defining the marine bor-

He called upon the United Nations' Security Council to issue a strong statement against the Iraqi court's decision.

Meanwhile, MP Abdulaziz Al Saqabi sent parliamentary questions to the Minister of Finance Fahad Al-Jarallah regarding the fraud crimes that have been on a rise lately and targeting individuals' money through suspicious sites and applications. He wanted to know the role played by the Central Bank of Ku-

wait concerning these crimes and to what extent the public institutions cooperate with the Central Bank in this regard. **Continued on Page 5**

Kuwait to build renewable energy stations: Al-Ostad

KUWAIT CITY, Sept 24, (KUNA): His Highness the Crown Prince Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah arrived in Kuwait Sunday after attending the opening ceremony of the 19th Asian Games in Hangzhou and holding official talks with Chinese President Xi Jinping.

His Highness the Crown Prince Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah sent on Sunday a cable to Chinese President Chinese President Xi Jinping, thanking him for the invitation for the opening ceremony of the 19th Asian Games in Hangzhou.

His Highness the Crown Prince expressed appreciation and gratitude for the Chinese President for the warm welcome and reception, praising the success of the opening ceremony.

His Highness the Crown Prince wished the Chinese president everlasting health and wellness, and further progress and prosperity to his country and people.

State of Kuwait is heading in the direction of constructing clean energy stations in order to honor the growing electricity demands and provide cheap power, Minister of Electricity, Water and Renewable Energy said.

"We will have power shortage in the coming years so the State's approach is to invite corporates or consortiums to establish clean energy stations in what is known as the Independent Power Provider (IPP)," Dr. Jassem Al-Ostad told KUNA.

These companies, he added, would be building solar power stations that provided clean and cheap electricity on one side, and contribute to Kuwait's honoring of its commitment towards the 2030 UN Sustainable Development Goals (SDGs) to provide renewable and clean energy thus minimize emissions.

Al-Ostad signed a memorandum of understanding with the national energy department of China regarding power systems and renewable energy. The MoU was signed during His Highness the Crown Prince Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah's visit to Hangzhou, at the invitation of Chinese President Xi Jinping.

Al-Ostad called on importance of changing to clean energy through environmentfriendly projects.

He noted that solar panels could be installed on roofs of schools and houses, and could be connected to the power grid.

Bid to repatriate migrants

EU urged to rethink Syria safe zones

NICOSIA, Sept 24, (AP): Cyprus has formally called on the European Union to re-evaluate which areas of Syria can be declared safe and free from armed conflict so that Syrian migrants can eventually be repatriated there, Cypriot authorities said Friday.

Interior Minister Constantinos Ioannou was the sole official to raise the issue during July's informal gathering of his EU counterparts in Spain. No other EU nation has taken a formal position on safe zone re-evaluation, the Interior Ministry told The Associated Press.

Cyprus is fronting the re-evaluation bid because it says its proximity to the region has now made it a prime destination for

Syrian migrants. Ethnically divided Cyprus, with a population of nearly a million in the southern, internationally recognized part where migrants seek asylum, says migrants now comprise 6% of its population - much higher than the average in other EU member countries. War-torn Syria has for the past 12 years

has been designated as an unsafe country where indiscriminate violence poses a real risk to the safety of its citizens. The threat makes them eligible for international protection status which enables them to live and work in third countries.

The government of Cyprus is proposing that the EU re-examine whether conditions on the ground in Syria - or parts of the country - have changed enough for Syrians to be safely repatriated.

The practicalities of how such repatriations would take place could be decided later. One possibility would be to start repatriations of Syrians who hail from the declared safe zones, according to the Cypriot

'No Mideast peace without ... full rights

UNITED NATIONS, Sept 24, (AP): Palestinian President Mahmoud Abbas told the U.N. General Assembly that there can be no peace in the Middle East without his people enjoying their "full and legitimate national rights.

It was the closest he came in a nearly 25-minute address to acknowledging U.S.-led negotiations aimed at getting Saudi Arabia to normalize relations with Israel. The Saudis have said such a deal must include major progress toward the creation of a Palestinian state, something Israel's far-right government has all but ruled out.

'Those who think that peace can prevail in the Middle East without the Palestinian people enjoying their full and legitimate national rights are mistaken," Abbas said at the start of his address

The 87-year-old Palestinian leader's speech largely resembled those he has delivered in past sessions. He accused Israel of a litany of violations against Palestinian rights and called for an international conference to revive the peace pro-

He said the Israeli occupation of lands the Palestinians want for a future state "challenges more than a thousand resolutions, violates the principles of international law and international legitimacy, while racing to change the historical, geographical and demographic reality on the ground.

The Israeli delegation walked out of the hall early in his address, when he spoke about Israel's

New protocol facilitates Hajj pilgrimage for illegal bedoun

KUWAIT CITY, Sept 24: A new protocol has been introduced to facilitate the registration of bedoun - people who are living illegally in Kuwait with no recognized nationality – who wish to participate in the Hajj pilgrimage during the upcoming season, reports Al-Qabas daily.

They will now be included in the Kuwaiti pilgrim lists, following specific conditions outlined by the Supreme Committee for Hajj. The primary objective is to streamline the registration process and avoid any delays. Once approvals are granted by Saudi authorities, the registration will progress.

In addition, approved Kuwaiti Hajj campaigns have commenced efforts to secure lodging for the pilgrims in the Holy Land no later than a month before the pilgrimage. During this phase, details regarding contracts, prices, and the commencement of registration in October will be disclosed.

It has been noted that a total of 62 caravans have been designated to partake in Hajj for the forthcoming season. Each caravan is mandated to have a minimum of 50 registered

pilgrims, with a maximum cap set at 250 pilgrims for individual campaigns. For combined campaigns organized by companies, the numbers will be doubled, allowing a maximum of 600 pilgrims for doubles and triples combined, and 800 pilgrims for quartets.

Officials have underscored that the Ministry of Awgaf has coordinated with all authorized entities utilizing the electronic platform, gathering their information. The grouping of registrations will be based on kinship for the upcoming Hajj season, focusing on the first and second degrees of kinship within the group.

The registration period will be sufficient once the central platform for pilgrim registration is made accessible, extended from one month to forty days. The criteria for Hajj and the selection process will prioritize individuals who have not previously undertaken Hajj. Preference will be given to groups consisting of relatives, and the sorting will be based on the eldest member. Additionally, the bedoun security card must remain valid throughout this

Bid to improve operations

'Awqaf' opts for internal transfers

KUWAIT CITY, Sept 24: In a move aimed at enhancing operations across various sectors and departments within the governorates, Dr. Badr Al-Mutairi, the Undersecretary of the Ministry of Awqaf and Islamic Affairs, has initiated a reassignment and transfer initiative involving 8 departmental heads within the ministry.

As per the directive, the following appointments were made -- Ahmad Al-Khalidi was appointed as the Director of the Information Systems Center; Hussein Bouzbar was appointed as the Head of the Cleaning Department in the Department of Mosques in Hawalli Governorate, and Abdul Rahman Al-Numis was designated as the Head of the Automated Projects Follow-up Department at the Information Systems Center. The decision stands valid for a period of one year from its issuance.

Moreover, the decision encompassed the transfer of Nasser Al-Khalidi from his role as the Head of the Rehabilitation and Training Department in the Educational Affairs Control Department in the Department of Islamic Studies and Qur'anic Sciences for the Capital and Hawalli Governorates, to the position of Head of the Curriculum Affairs Department within the same administrative

Furthermore, Muhammad Al-Mu-

tairi was transferred from the position of Head of the Curriculum Affairs Department in the Control of Educational Affairs in the Department of Islamic Studies and Our'anic Sciences for the Capital and Hawalli Governorates, to the role of Head of the Training and Qualification Department within the same administrative realm.

Saeed Al-Hajri moved from the position of Controller of Support Services in the Department of Islamic Studies for the Al-Ahmadi and Mubarak Al-Kabeer Governorates to the role of Controller, 'Al-Siraj Al-Munir,' at the Department of Islamic Studies and Qur'anic Sciences for the Farwaniya and Jahra Governorates.

Moreover, Hanan Al-Lamie transitioned from her position as the Head of the Planning and Performance Development Department at the Center for Promoting Moderation to the role of Head of the Vacations and Permanence Department within the Human Resources and Administrative Development Department. Khaled Al-Otaibi shifted from the position of Head of the Secretarial Department in the Office of the Assistant Undersecretary for the Holy Quran and Islamic Studies Affairs Sector to the position of Head of the Secretarial Department at the Mosques managed by Mubarak Al-Kabeer Governorate.

Govt intends to revise vision of Kuwait 2035

KUWAIT CITY, Sept 24: During the signing of seven Kuwaiti-Chinese agreements, Deputy Prime Minister, Minister of Oil, and Minister of State for Economic Affairs and Investment, Dr. Saad Al-Barrak, unveiled the Kuwaiti government's intention to revise the "Kuwait 2035" vision and extend it to "2024-2040." This decision prompts questions about the rationale behind this update and whether it is justified.

Kuwaiti economists unanimously support the vision update, citing low completion rates that render the original 2035 goal unattainable.

They attribute these delays to ongoing political tensions between the government and the National Assembly, which have hindered project implementation. They predict that without comprehensive reforms and the resolution of political disputes, the extension could extend even further to 2050.

Extension

Former Housing Minister Yahya Al-Sumait considers this extension a consequence of mismanagement and political appointments driven by personal interests. He emphasizes that the government's inability to swiftly execute projects, such as railways and transforming Kuwait into a financial hub, necessitates this move. Al-Sumait also points out that Kuwaiti private sector capital is frequently invested in neighboring countries due to obstacles in the domestic market.

Economic expert Muhammad Ramadan underscores that the political conflict between the government and the National Assembly has obstructed project implementation. He laments the failure to transform Kuwait into a financial center despite proposing this vision over 15 years ago. Ramadan believes that the update is necessary to address these obstacles, even though some progress has been made on various projects.

Here's an overview of the nine reform paths within the Kuwait 2035 plan:

1. Building a special international economic zone: Establishing an international economic zone with specific laws and regulations to attract high-value investments, encourage innovation, and ensure transparency. The estimated completion date is 2025.

2. Public Privatization: Modernizing legislative frameworks and introducing privatization initiatives to reform public finances, diversify income sources, enhance service quality, and create job opportunities in the private sector.

3. Promoting a dynamic private sector: Creating an attractive investment environment driven by the private sector through ease of doing business, fair competition, and innovation in various fields.

Capabilities

- 4. Strengthening the capabilities of citizens and institutions: Providing individuals with knowledge, skills, creativity, and innovation capabilities to create a productive and competitive workforce and enhance social
- 5. Restructuring the government apparatus: Creating an agile government that enhances integrity, transparency, and digital transformation while meeting citi-
- 6. Building a cohesive infrastructure: Developing an advanced infrastructure network, including projects related to transportation, energy, and urban development.
- 7. Creating environmentally harmonious living areas: Promoting sustainable resource use, reducing pollution, and improving citizens' quality of life through environmentally friendly living areas.
- 8. Promoting the health and well-being of all: Enhancing healthcare services, promoting healthy lifestyles, and developing national capabilities in the healthcare sector.
- 9. Effective participation in the global community: Strengthening Kuwait's regional and international position in diplomacy, trade, culture, and charitable work. These reforms aim to shape Kuwait's future, but their success depends on overcoming political challenges and implementing them effectively.

KUWAIT CITY, Sept 24, (KUNA): A Kuwait-based research center on Sunday said that an Iraqi court ruling that invalidated an agreement with Kuwait over regulating navigation in the Khor Abdullah waterway was riddled with flaws, citing the "historical fallacies" contained in it.

Upon closer inspection, the Iraqi Federal Supreme Court ruling, which rendered the agreement as "unconstitutional" earlier this month, comes across as highly paradoxical since it had previously ratified the deal in 2014 after Iraqi lawmakers unanimously voted in favor of the agreement a year earlier.

In its thorough analysis of the Iraqi court ruling, Kuwait Institute for Scientific Research (KISR), citing Kuwait University's Faculty of Law professor Dr. Ali Al-Rashidi, slammed the mere notion that the deal proved detrimental to Baghdad, saying the ruling does not contravene constitutional procedures in any way since it was made with legal validity.

Shining light on the paradoxical nature of the ruling, it said that Iraq's parliament, being the country's legislative power, not only supported the agreement, but an Iraqi court even rejected an appeal by a lawmaker to invalidate the agreement in a testament to how "contradictory" the latest court ruling

Citing the Vienna Convention on the Law of Treaties, an international agreement that regulates treaties among sovereign states, the KISR analysis underlined that since Iraqi lawmakers had ratified the agreement, it was a clear "gesture of consent" since the same Iraqi court had also given its approval of the "constitutionality" of the ruling.

Emphasizing the principles of the aforementioned convention, all parties involved in a treaty are obligated to "implement the agreement in earnest," while any attempt by a party involved in a treaty to question its validity after it had been ratified is inappropriate, according to the analysis.

Afterwards, the Center confirmed that the court's decision dated September 4, 2023, ruling that the agreement was unconstitutional, contradicts the idea of the final ruling issued by the Federal Supreme Court on December 18, 2014, which was confirmed by Article (94) of the Iraqi Constitution, as well as Article (5) of the Federal Supreme Court Law Number 30/2005.

The center stated that this comes in addition to the fact that the court's recent decision contradicts the previously mentioned texts regarding the Vienna Convention on the Law of Treaties. Especially since the highest Iraqi court, the Federal Supreme Court, had previously explicitly confirmed in its final ruling in 2014 the constitutionality of the law issued by the Iraqi Council of Representatives regarding ratifying the agreement regulating maritime navigation between the Iraq and Kuwait.

Indicated

The Center indicated in its reading that after both Iraq and Kuwait approved the bilateral agreement regarding the regulation of maritime navigation in Khor Abdullah, a copy of the agreement was deposited at the United Nations in December 2013 through the Permanent Representatives of Iraq and Kuwait, Muhammad Ali Al-Hakim, and Mansour Al-Otaibi.

It continued that this bilateral deposit comes in line with the first paragraph of Article 102 of the United Nations Charter, which stipulates that "every treaty and every international agreement concluded by any member of the United Nations after the implementation of this agreement must be registered in the secretariat of the UN and published as soon as possible.'

In line with what was stipulated in the second paragraph of Article 102 of the Charter of the United Nations, "No party to an international treaty or agreement that has not been registered in accordance with the first paragraph of this article may invoke that treaty or that agreement before any branch of the United Nations.

According to the Centre's reading, the Permanent Representative of the Repub-

lic of Iraq to the United Nations, Muhammad Al-Hakim, stressed on that agreement, which regulates maritime relations between the two countries on the basis of United Nations resolutions, especially Resolution 833, which says that "both parties are committed to it, and that it also means that the two countries agree to facilitate the process of the passage of ships and traffic in Khor Ab-

It pointed out that the Official Newspaper of Iraq published on 11/25/2013, Issue No. 4299, the law ratifying

an agreement between the government Iraq and the government of Kuwait regarding the regulation of maritime navigation in Khor Abdullah. The second article of the law stipulates "this law shall be implemented by date of publication in the Official newspaper."



Moreover, the Center said that, the Iraqi government accordingly deposited a copy of the agreement with the United Nations in December 2013. The first paragraph of Article 16 of the agreement stipulated that this agreement come into effect after the exchange of notices, by which the last party notifies the other party of its completion of the procedures. The internal legal requirements necessary for its implementation.

This was achieved after the Iraqi copy deposit in December 2013, in accordance with Article 15 of the agreement. The Iraqi Federal Supreme Court in 2014 also issued its ruling confirming the constitutionality of the law issued by the Iraqi Council of Representatives regarding the ratification of the agreement, which means it is effective for both parties.

Pointed

The center pointed out that the second paragraph of Article 16 of the agreement stated that the agreement remains in effect for an unlimited period, provided that the agreement may not be terminated except with the consent of both parties.

Therefore, Article 16 requires bilateral approval to terminate this agreement, meaning that it may not be terminated by one

Article 14 of the Convention stipulates that any dispute that arises between the two parties regarding the interpretation or application of the agreement shall be settled amicably between them through consultations. In the event that they are unable to reach an agreement regarding this dispute, it shall be referred to the International Tribunal for the

Regarding the objective facts and historical allegations in the ruling, the Research Center stated in its reading that "the ruling of the Iraqi Federal Supreme Court was supposed to be limited to a specific issue, which is the agreement on regulating navigation in Khor Abdullah, but it descended into a maze of allegations about the historical existence of Kuwait.'

"These allegations that had no reliable scientific response to it, no evidence, no maps, and no studies have been published regarding it, which makes it a waste of time. Kuwait, as a land, a people, and a state, is a historical fact, and there is no room or claim to deny it," the Center added.

It also pointed out that these claims of historical rights completely contradicts what the basic principles of international law have concluded. The Security Council took these principles into account when it adopted the borders agreement, which was signed by both Kuwait and Iraq in the years 1932 and 1963, which is what studies of international law call for, which it refuses to dissolve. However, the objective scientific study of the issue of Kuwait's borders with Iraq always reaches the same results, which was backed by the world.

The statement noted that He stated that the reason for this is clear, as Kuwait's borders are officially registered in international documented documents, maps and agreements. No one denies them and no one claims their falsity except those who want to contradict the people and misrepresent scientific facts. The history of these documents goes back to periods that precede the emergence of modern Iraq and its independence. They are not artificial documents to falsify evidence.

'Kuwait Belt and Road initiative versus the Economic Corridor'

"THE Belt and Road initiative, initially conceived by China around 30 years ago, evolved into a comprehensive strategy in 2013. It is a modern extension of the historical Silk Road, reaching from China to Africa and the Middle East, and passing through Central Asia," columnist **Dr Abdullah Sahr** wrote for **Al-Rai** daily.

"The project has been conceptualized to consist of two major lines. The first, known as the Maritime Silk Line, commences from Chinese and Asian ports, traversing the Arabian Sea, the Red Sea, and eventually reaching Europe via the Suez Canal; the second line, the overland Silk Line, branches into multiple routes, originating from China and extending to Asia, Africa, and Europe, connecting through an intricate network of railways and touching more than 200 cities.

"At its outset, 18 countries were part of this strategy, and over time, it has garnered the support of approximately 126 countries and over thirty interna-

approximately 126 countries and of tional organizations, representing about 60% of the global population. Kuwait was among the early adopters, signing the initiative. However, regrettably, Kuwait did not proceed to establish the necessary protocols with China for undisclosed reasons. In contrast, many nations that followed suit have engaged in these projects through the Asian Infrastructure Investment Bank. Surprisingly, there is no information available on Kuwait's membership in this

bank, despite its initial approval of its establishment when China proposed the idea in 2014.

"In exchange for this project, several Gulf countries, notably Saudi Arabia and the UAE, have entered into an agreement for a parallel initiative called the Economic Corridor with India, bypassing Kuwait. From both economic and political perspectives, Kuwait must swiftly activate these protocols to achieve several objectives, including fulfilling the objectives outlined in the development plan to transform Kuwait

into a commercial and financial hub.

"This is in addition to developing Kuwaiti islands through a partnership with China; enhancing infrastructure development in Kuwait at an accelerated pace through Chinese companies known for their efficiency and speed in project completion; leveraging

Chinese expertise in constructing housing communi-

ties, desert greening, combating desertification, and undertaking environmental projects.

"By also positioning Kuwait as a major partner in this strategy, offering protection against various international and regional political fluctuations and establishing itself as a key player for the strategic balance in the future; creating genuine employment opportunities for youth and diversifying economic income sources and by carefully reviewing official Chinese maps illustrating the Belt and Road routes, it is evident that they do not definitively confirm passage through the Gulf

sage through the Gulf.

"However, this does not rule it out entirely. Some maps exclude the Gulf region, while others suggest a line passing through the Gulf into Iraq, hinting that Kuwait is ideally situated for this strategy. A collaboration between the three major Gulf countries can establish a free trade zone and a pivotal city for trade intersection.

"What is essential in this endeavor is a commercial mindset, determination, and prompt decision-making. It is hoped that His Highness the Crown Prince, may God protect and guide him, will succeed in translating these objectives to propel Kuwait towards a brighter future."

How does a borrower, who has not even KD10 left in his salary, benefit from preventing segregation? How does a retiree, who has low pension and can barely meet his monthly obligations, benefit from preventing segregation? How does a young man, who has been living in a rented house for 20 years, benefit from your law?

"Education in general must be reconsidered, not just segregation, which is not a priority! Promote education and its outcomes, then talk about segrega-

"Despite the major change in the political scene that took place the past year, the problems and crises have not changed, and will not change as long as the radical change does not include the basic systems of government such as the Constitution and the basic laws," columinist **Dahim Al-Qahtani** wrote for **Al-Qabas** daily.

"From the parliamentary aspect, a new parliamentary majority that is loyal to the government was brought in. It is mostly made up of the previous opposition. This does not coincide with the advanced project to radically change the parliamentary scene.

"There is also hope that young people in their prime will realize the importance of joining political work early. This should be done through a state of political awareness based on understanding and not enthusiasm."

New strategies to manage traffic in peak hours eyed

Asian expat wanted in fraud arrested

KUWAIT CITY, Sept 24: In an official announcement, the Ministry of the Interior stated that Acting Prime Minister and Minister of the Interior, Sheikh Talal Al-Khaled, chaired a security meeting today, as part of the Ministry's routine engagements with security leaders, reports Al-Oabas daily.

During the meeting, Sheikh Talal Al-Khaled, accompanied by a team of assistant undersecretaries and Lieutenant General Anwar Al-Barjas, the Undersecretary of the Ministry of Interior, discussed the traffic

Sixteen criminal sentences had been handed down, and the outstanding amounts totaled approximately one million dinars, encompassing checks, bills of exchange, and debt declarations."

The sources also pointed out, "General Al-Saeedi referred this high-priority security suspect, holding a record number of criminal cases, to the appropriate authorities."

Company caught selling KD460 phone for KD900

KUWAIT CITY, Sept 24: The Commercial Control Department of the Ministry of Commerce and Industry monitored attempts by some companies to raise prices in violation of laws and decisions, reports Al-Seyassah daily.

The ministry recently discovered that a multi-branch company that sells electronic devices was selling a particular type of mobile phone device for KD 900 and taking advantage of people's desire to acquire the mobile phone.

This type of mobile phone has not been officially released in the local market, and its actual price is KD 460.

The Ministry of Commerce and Industry warned companies and stores that sell electronic and electrical devices that it will refer to justice anyone who exploits people's desire to acquire modern communications devices, and raises their prices illegally, taking advantage of the devices not being officially released in the local market, in implementation of article 2 of law No. 10/1979.

24,540 citations issued: Traffic officers, during their security tours, issued 24,540 various traffic citations in the past seven days in all governorates, based on the directives and instructions of the Director General of the General Traffic Department Major General Yousef Al-Khadda, says Al-Seyassah.

According to the decree, a copy of which has been obtained by the daily, the rental cost for spaces leased within government mall centers, where ministries, agencies, and institutions offer their services to the public, will be set at 200 dinars for the initial square meter and an additional 12 dinars for each subsequent meter for each individual space. This revised rate will come into effect starting from today.

'Divorce cases see 22% decrease in first year of marriage last year'

Spouses with university degree have highest divorce rates

KUWAIT CITY, Sept 24: In a good indication of the efforts made by the government, various state agencies, public benefit associations, and specialists to confront the phenomenon of divorce and not destroy the family entity, statistics issued by the Ministry of Justice showed a decrease in the divorce rate in the "first year of marriage" in Kuwait during the year 2022 by 21.9% compared to the year 2021.

The statistics, a copy of which has been obtained by Al-Anba, according to the statistical book prepared by the Statistics and Research Department of the Information Technology and Statistics Sector in the Ministry of Justice, indicated a decrease in the number of divorce cases in the first year of marriage during the past year from 948 cases in 2021 to 740 cases in 2022 by an amount 208 cases.

The statistics show marriages in Kuwait reached 13,656 in 2022 from 16,393 the previous year, 66.9% of which are for a Kuwaiti who married a citizen, and 17.5% of both spouses are non-Kuwaiti.

Highest

The percentage of divorces for those married from one year to less than 5 years is the highest, followed by the percentage of those married for less than a year, and it decreases as the duration of married life increases.

Spouses with a university degree have the highest divorce rates in Kuwait, at 30.4% of the total divorce cases, followed by those with intermediate qualifications, at 22.1%.

Almost 11.4% of citizens married non-Kuwaiti women and 4.2% of female citizens married non-Kuwaiti men during the past year.

The number of "divorce before consummation"

cases decreased from 738 cases in 2021 to 610 cases in 2022, by 128 cases, or a rate of 17.3%.

Divorce cases for "couples with one or more wives remaining married" decreased from 2,787 cases in 2021 to 1,365, with 1,422 cases, or a rate

According to educational status, for couples, the percentage of marriages with university qualifications reached 42.5%, then those with post-secondary diploma qualifications at 20.1%, then high school holders at 19.5, then those with intermediate qualifications at 13.1%. As for the rest of the educational cases, their percentage reached 4.8% of the total cases. marriage.

As for wives, the percentage of marriages with university degree holders reached 52.5%, then those with secondary qualifications at 23.4%, then those with post-secondary diploma qualifications at 15.1%, then those with intermediate qualifications at 60%. As for the rest of the educational cases, their percentage reached 3.0% of

One center serving 223,000 people

'MoH keen to increase health centers in the Hawally area'

KUWAIT CITY, Sept 24: According to health sources, the Ministry of Health, as part of its efforts to open many additional specialized centers and clinics in residential areas, is intensifying efforts to demolish, establish, complete, and maintain the South Hawally Medical Center, especially with the ongoing coordination with the regulatory authorities to obtain the necessary approvals, reports Al-Qabas daily.

The sources explained that Hawally area has only one health center that serves about 223,000 people, including about 2,000 Kuwaiti citizens, as per statistics issued by the Public Authority for Civil Information (PACI). Congestion has become the most prominent feature of this center, along with the suffering that the elderly and those with chronic diseases face.

Without mentioning the reasons, the supervisory authorities postponed the approval of the ministry's request to award a tender for the project to demolish, construct, complete and maintain the South Hawally Center, the cost of which amounts to KD 3.8 million, to one of the parties.

Hawally area had 3 medical centers - West Hawally, South Hawally, and one near Hawally Park, which had been used by a department affiliated with the Ministry of Health since 2014, and with the aim of staying in it for a period of only up to six months until the completion of construction. The building for that department is in Sabah Medical Center. This period has now exceeded eight years, despite the readiness of the department building in Sabah area.

The presence of only one health center in Hawally area would put additional pressure on Mubarak Al-Kabeer Hospital, specifically its emergency unit. There are repeated scenes of long queues being witnessed at West Hawally Clinic, such that patients eventually resort to specialized clinics in private medical centers and hospitals, which puts another pressure on families' budgets, as they need more than one visit during the week sometimes, in addition to dispensing medications from the pharmacies of those facilities.

It is worth mentioning that the number of primary healthcare centers in the country is 112, which are distributed across all governorates. Most of them are in Ahmadi Governorate with 31 centers, followed by the Capital Governorate with 26

WFP official hails Kuwait's long-term support

KUWAIT CITY, Sept 24, (KUNA): Representative of the World Food Programme (WFP) in the GCC, Mohammad Yahya, affirmed recently Kuwait's continuous support in emergency and humanitarian

response activities.
Yahya stated to KUNA on the program's launch, "We are working closely with the Kuwaiti government to provide long-term sustainable support to the most vulnerable

communities around the world." He added that regarding the lack of funding and the deteriorating level of food security worldwide, Kuwait contributed USD 18.8 million in 2023 to support WFP operations in various countries.

He also added that WFP is struggling to meet global needs for food aid with a decrease of 60 percent this year, noting that it is the highest rate recorded in the program's history, which forced them to only rescue people that are suffering from hunger.

He stated that, "It is no longer limited to the fact that we have received much less funding, but also to the fact that we need more this year."

Kuwait 10th biggest world oil producer in 2022

Country's average daily production reach 3.028 million barrels

KUWAIT CITY, Sept 24: A report from Visual Capitalist revealed that Kuwait secured the tenth spot on the global list of leading oil producers in 2022. The country's average daily production reached 3.028 million barrels, accounting for 3.2% of the total worldwide oil production, which amounted to 93.848 million barrels per day. This average production represents a notable 12% increase from Kuwait's production levels in 2021, reports Al-Anba daily.


The report highlighted that during 2022, oil prices surged to their highest point, exceeding \$100 per barrel and marking the highest level in eight years. This spike followed a tumultuous year in energy markets due to the Russian-Ukrainian war.

As a result of the price surge, oil companies experienced a doubling of their profits, and the economies of the largest oil-producing nations gained significant momentum.

The Energy Institute's Statistical Review of World Energy report ranks the world's oil supplier countries as follows -- 1- The United States with 17.771 million barrels; 2- The Kingdom of Saudi Arabia with 12.136 million barrels; 3- Russia with 11.202 million barrels; 4- Canada with 5.576 million barrels; 5- Iraq with 4.502 million barrels; 6- China with 4.111 million barrels; 7- United Arab Emirates with 4.02 million barrels; 8- Iran with 3.822 million barrels; 9- Brazil with 3.107 million barrels and 10-Kuwait with 3.028 million barrels.

Hence, the United States solidified its position as the world's primary oil producer since 2018 and maintained its prominence in 2022 by achieving an output of approximately 18 million barrels per day. This figure translates to roughly 5% of the global oil supply. The majority of the nation's oil production is centralized in five key states: Texas, New Mexico, North Dakota, Alaska, and Colorado.

Following closely, the Kingdom of Saudi Arabia secured the second position, boasting a production exceeding 12 million barrels per day, constituting approximately 13% of the worldwide supply. Russia secured the third spot with an oil production of 11 million barrels per day in 2022. These three major oil-producing nations, alongside Canada in fourth place and Iraq in fifth place, contribute to over half of the world's oil supplies.

Bioprinting could achieve major 'medical breakthroughs': IOMS

KUWAIT CITY, Sept 24, (KUNA): Bioprinting is a technology that could bring about major breakthroughs in the medical world, as it grants the ability to grow in labs

human cells organs with the very shape and function, stated Islamic Organization for Medical Sciences (IOMS) on Sunday. Organiza-

Dr Al-Jarallah tion Chief Dr. Mohammad Al-Jarallah spoke while inaugurating symposium, "Bioprinting.. opportunities and challenges from an Islamic perspective" held over two days with participation of more than 15 states and 400 participants.

This technology, explained Dr. Al-Jarallah, is used in the treatment of unhealthy organs, tissues or cells to improve vital functions. This, he added, could save millions of people awaiting their treatment on donor waitlists.

It is a comprehensive biological process, employing the use of modern three-dimensional printing technologies, Al-Jarallah expounded saying that thus far they have successfully printed skin grafts, outer ear tissue and liver tissue, while full organs printing remains in preliminary stages.

This congregation, he stated, aims to provide better healthcare while finding a fine-tuned balance between technological advancements, and ethical and legal prin-

Director of World Health Organization for Middle East, Dr. Ahmad Al-Manthari, spoke of recent innovations in direct cell printing mechanisms and called for collecting and analyzing more data on cell and tissues donations.

As for head of Islamic research complex at Al-Azhar, Nazir Ayad, he affirmed that bioprinting does not go against the principles of Islam, saying that it is a religion that supports the promotion of physical

He stated that while this pushes the world towards the precipice of medical revolution, it requires the implementation of tightly-woven regulations.

In this regard, former Jordanian Islamic affairs minister Abdulnasser Abu Albasal commented that this drives the Islamic nation to adapt to rapidly changing world and technologies.

Cardiologist Dr. Hanan Shamsi indicated that while it is a highly promising technology, it is faced with many technical challenges.

'Shaping a positive image'

Kuwait's humanitarian diplomacy portrays plentiful relief programs

KUWAIT CITY, Sept 24, (KUNA): Kuwait's long record of humanitarian aid for the needy has become quite rich due to unaccountable relief programs and campaigns to relieve peoples suffering from poverty or entangled in repercussions of catastrophes.

Kuwaiti organizations and associations have scrambled for many years to respond to crises and disasters, adding a new concept in diplomatic work, the humanitarian diplomacy.

Anwar Al-Hasawi, the deputy chairman of Kuwait Red Crescent Society, affirmed in an interview with KUNA, marking the World Humanitarian Action Day (August 10), that Kuwait is highly visible on the international map for relief work, given enormity of the relief campaigns it has launched over many years.

Kuwait had to deal with two major recent catastrophes that afflicted Libya, ravaged with the devastating hurricane Daniel and Morocco that suffered a a powerful quake rendering whole villages heaps of ruins.

As part of Kuwait's relief air bridge for Libya, at least five planeloads of supplies had been dispatched to the stricken country. Hamad Al-Aoun, the deputy director general of "Al-Salam" charity told KUNA that the association had dispatched detergents and chemical substances to fight viruses, amid fears that Libya might witness epidemics' outbreak due to rotting dead bodies, many still submerged in mud or drowned, particularly in Derna, the hardest hit region.

The tons of supplies included masks, beds, wheelchairs and other medical accessories, he said.

Abdullah Al-Traiji, Chairman of Kuwait Scout Association, declared that the society along with Arab counterpart associations have raised donations to relieve the victims in both Libva and Morocco.

Omar Al-Thuwaini, the general supervisor of the relief campaign, "fazaat al-maghreb," said 14 Kuwaiti spocieties joined hands to assist the quake victims in Libya. He indicated that the aid included blankets and food parcels. Meshari Al-Enezi, an official of "Al-Najat" charity, said the next phase of the humanitarian operation would be

rebuilding houses, schools and medical centers. Moreover, the Kuwaiti embassy in Morocco organized a blood donation campaign for helping the injured. Kuwait, since start of 2023, has established an air bridge sending 16

planeloads of tons of relief, medical and food supplies to the Sudanese peo-It had scrambled to relief hundreds

of thousands of Rohinya who fled persecution in their country to Bangladesh where they ended up in impoverished camps. The ICRC Regional Head of Delegation for the Gulf Cooperation Council, Mamadou Sow, lauded Kuwait for backing the IRCS efforts to relieve the Rohingya.

Aftermath

In Turkey, the Kuwaiti medical team "shifaa" was present in the south of the country in the aftermath of the devastating earthquake that jolted the nation earlier this year. They had been present there attending to the needs of hundreds of thousands of Syrians who escaped war in their home country.

Dr. Husam Bechir, the head of a Kuwaiti team of surgeons, said the group arrived in Hatay, South Turkey, to followup on previous missions that had been undertaken by other Kuwaiti doctors with backing from Kuwait Zakat (alms)

The "shifaa" team has a record of executing relief missions in Turkey, Lebanon, Jordan, Gaza and Somalia. Up to 8,500 patients have been treated or given medical aid in these countries.

Also regarding the region, the UN High Commissioner for Refugees and Sheikh Abdullah Nouri Charity signed a cooperation agreement for aiding Syrian refugees in Lebanon. The UNHCR acting representative in Kuwait, Maher Ishaqat, said in a statement the accord was the third to be inked with Abdullah Al-Nouri society, indicating that the two entities have become bonded with a strategic partnership and involved in joint fund raising for aiding the refugees in winter times.

The Kuwaiti good hands have been stretched for many miles across the region reaching Egypt, where Kuwait Office for Charitable Projects delivered 24 fishing boats and tools to limited-income Egyptian fishermen. Up to USD 30,000 had been granted by the Kuwaiti Al-Najat charity to assist fishermen who depended on ramshackle boats to earn bread.

For its part, the International Islamic Charity Organization distributed 11,000 sacrificed live stocks to 440,000 people in 25 countries. IT distributed sacrificial meat to the needy every year during Al-Adha eid. The granted meat reached people in need in Kuwait and many countries.

"Rahma around the world" launched a project in Gaza to aid cases of special needs -- with support from the Kuwaiti Al-Awqaf Secretariat General. In the aftermath of the fiery blast that

rendered Beirut port and nearby residential districts largely heaps of ruins, Kuwait Red Crescent Society renovated and reequipped the maternity ward of Al-Makassed Hospital. Kuwait had also given aid to other hospitals that were damaged in the explosion that affected wide sections of the Lebanese capital.

Khaled Al-Zaid, the KRCS director of public relations and media, said that the Kuwaiti humanitarian aid for many years helped in shaping a positive image of the State of Kuwait abroad. "Kuwait's diplomacy has constituted a soft power for the state especially that it has gained a humanitarian aspect," he said.

Al-Zaid, who was speaking during the Qatari Red Crescent celebration of International Day for Humanitarian Law in Doha, said the participants in the event discussed a task paper themed "media and the humanitarian diplomacy," shedding light on Kuwait as an oasis for good deeds. The name Kuwait has become syn-

onymous with humanitarian deeds, he said.

Heartened with Kuwait's generous assistance for peoples in need, the UN had designated it as the center for humanitarian action and the former Amir Sheikh Sabah Al-Ahmad Al-Jaber Al-Sabah as the leader for humanitarian

The mission of guidance and advice remains within its correct framework, when officials realize that continuing in efits of its wealth, which will soon be depleted if dependence on oil remains the only and main source of income, and the revenues generated from fees does not become a source of national income.

Getting out of the impasse requires the state to develop primary and heavy industries as a first step towards starting a system to protect future generations, unless the intention is for our young people to become workers in other countries such as drivers and servants.

Markets now pricing in two rate cuts next year

Central banks pause amid business conditions contraction

Federal Funds Rate

The U.S Federal Reserve left its benchmark interest rate unchanged at the target range of 5.25% to 5.50%, as widely expected by the market. The central bank signaled borrowing costs will likely stay higher for longer after one more hike this year. Twelve out of nineteen Fed officials said that they still expect to raise rates once more this year. Markets are now pricing in two rate cuts next year instead of the previously projected four rate cuts. Projections also showed that they expect inflation to fall below 3% next year and then return to their initial target of 2% by 2026. As inflation remains elevated, the overall sentiment given by the Fed was deemed hawkish as they repeated language on 'extend of additional policy firming. All in all, the so called "soft landing" was a bit far-fetched 3 months ago, but now seems within reach.

U.S PMI

There was no significant change in U.S business activity as shown in the latest data to come out on Friday. Flash Manufacturing PMI rose from 47.9 previously to 48.9, remaining in contraction territory. Meanwhile, Flash Services PMI dropped slightly to 50.2, allowing the index to remain in expansion territory.

The U.S Dollar Index closed the week at 105.58. **Inflation in Canada**

Inflation in Canada accelerated more than expected in August on the back of rising energy prices, with annual CPI coming in at 4% versus 3.3% in July. On a monthly basis, this represents a 0.4% increase versus estimates of a 0.2% rise. In their press release, governmental organization Statistics Canada stated, "In addition to facing higher energy prices, Canadians paid more for rent and mortgage interest in August." Following the release of inflation data, markets are pricing in a 56% chance of no hike for the upcoming Bank of Canada monetary policy meeting.

Europe

SNB Policy Rate

The Swiss National Bank kept its policy rate unchanged at 1.75%. The latest data in August showed that inflation had in fact declined in recent months and stood at 1.6%, thus downplaying the need for an interest rate hike by the SNB. The monetary policy tightening deployed by the SNB seems to have properly fought back against inflationary pressures so far, however, the SNB reiterated that further tightening can still come into play if deemed necessary.

The ECB seems to have taken the approach of prioritizing inflation rather than the wellbeing of the economy, and they seem that they will continue that way until they reach their desired inflation target

United Kingdom

UK Inflation

Inflation in the United Kingdom fell more than expected coming in at 6.7% annually versus 6.8% previously. This represents an increase of 0.3% on a monthly basis. Expectations were that figures would come in at 7% annually and 0.7% monthly amid a rise in energy prices globally. The Office for National Statistics stated, "The largest downward contributions to the monthly change in both CPIH and CPI annual rates came from food, where prices rose by less in August 2023 than a year ago, and accommodation services, where prices can be volatile and fell in August 2023." Core CPI which excludes food and energy also fell drastically more than anticipated coming in at 6.2% from 6.9% previously. The Office for National Statistics explained the difference between headline and core figures citing "Rising prices"

Bank Rate

The Bank of England kept its bank rate unchanged at 5.25%, after expectations had long been predicting a 25bps hike. The latest flash PMI data to come out on Friday, which the BOE had a sight of prior to its decision, showed a significant drop to 47.2 from 49.5 in August, showing clear signs of recession. The services sector dropped further into contraction and showed the lowest score since Global Financial Crisis when not taking covid times into account. As for employment, wages had been a major concern for inflation as they had been surging to high levels, however the latest data shows that employment has dropped to its lowest levels since 2009, and thus canceling out the concern of high wages. That, along with cooling inflationary pressures, must have been key behind the BOE's decision to pause rate hikes.

The GBP staggeringly dropped against the USD, with the currency pair closing the week at 1.2238.

Asia Pacific

China Loan Prime Rate

The People's Bank of China's one-year loan prime rate has been kept unchanged at 3.45%, while the five year loan prime rate was held at 4.2%, both in line with expectations. As recent economic data showed that the world's second largest economy is coming back from a sharp slowdown, policy makers believe that the need for immediate monetary easing can be neglected at this time.

Banks must verify integrity of funds, info: central bank

'Fulfill due diligence'

KUWAIT CITY, Sept 24: According to reliable sources, banks have consulted the opinion of the Central Bank of Kuwait regarding the required control mechanism for banking operations between the accounts of bank employees and customers, reports Al-Rai daily.

They revealed that the banks asked the supervisory regulator to provide them with the adequacy of the procedures followed by them to monitor the accounts of their employees, and whether the Central Bank has any directives that must be taken into account.

In this regard, the Central Bank of Kuwait stated that banks must fulfill due diligence requirements to verify the integrity of the funds and information available to them, either about the movement of customer or employee accounts, and compare it with their financial data recorded in the "Know Your Customer" form, to ensure the

extent of its consistency with the transactions executed on their accounts.

The Central Bank asked banks to rely on the instructions previously issued by it and amended in February, which specified the frameworks and concepts that banks must take into account when setting policies and work procedures that must be followed to verify compliance with fulfilling the requirements of the instructions for monitoring the accounts of their employees and customers.

The banks rely on the instructions of

the Central Bank of Kuwait and their internal control systems for implementing oversight instructions on employees' and customers' accounts, especially with regard to unusual money flows to the client's accounts, irrespective of whether he is an employee or a client outside the bank.

The banks follow a more careful

The banks follow a more careful policy on employee accounts, in accordance with the instructions of the Central Bank. As soon as suspiciously high amounts enter the employees' accounts, the bank immediately inquires about the source of these funds, and seek evidence to confirm their legality, especially if the liquidity flowing to the employee's account is high compared to the size of his salary and

traditional income rates.
The sources affirme

The sources affirmed that banks generally review customers' account opening papers and review the negative lists before opening new accounts or conducting banking transactions with customers.

They said the banks audit the payments of funds received into the accounts, during which the equivalent of the usual income is taken into account, or proof of its legality is provided in the event that its level exceeds the traditional financial rates that enter the client's accounts, especially those that enter his accounts on a regular basis.

The sources highlighted that banks, in the context of their audit of the movement of funds into accounts either for employees or customers, are committed to all procedures, and apply the requirements of the law and instructions for combating money laundering and terrorism financing, including ensuring when opening the account that the official identification documents match the customer's ID.

They affirmed the banks' commitment to the Central Bank of Kuwait's close follow-up framework of developments in internal control trends at all established levels.

Strategy also carries potentially significant risks

Auto workers still have room to expand strike

MICHIGAN, Sept 24, (AP): Even after escalating its strike against Detroit automakers on Friday, the United Auto Workers union still has plenty of leverage in its effort to force the companies to agree to significant increases in pay and benefits.

Only about 12% of the union's membership is so far taking part in the walkout. The UAW could, if it chose to, vastly expand the number of workers who could strike assembly plants and parts facilities of General Motors, Ford and Stellantis, the owner of the

Jeep and Ram brands.

Yet the UAW's emerging strategy also carries potentially significant risks for the union. By expanding its strike from three large auto assembly plants to all 38 parts distribution centers of GM and Ford, the UAW risks angering people who might be unable to have their vehicles repaired at service cen-

ters that lack parts.

The union's thinking appears to be that by striking both vehicle production and parts facilities, it will force the automakers to negotiate a relatively quick end to the strike, now in its second week. To do so, though, some analysts say the union might have to act even more aggressively.

"We believe the next step for UAW is the more nuclear option - going for

a much more widespread strike on the core plants in and around Detroit," said Daniel Ives, an analyst with Wedbush Securities. "That would be a torpedo."

Sam Abuelsamid, an analyst at the

consulting firm Guidehouse Insights, suggested that with so many workers and factories still running, the union has a number of options with which to squeeze the companies harder.

"They could add more assembly plants to the list," Abuelsamid said.

"They could target more of the plants that are building the most profitable vehicles."

As examples, he mentioned a plant in Flint, Michigan, where GM builds

heavy-duty pickups, and a Stellantis factory in Sterling Heights, Michigan, that produces Ram trucks.

All three companies said that talks

All three companies said that talks with the union continued on Saturday, though officials said they expected no major announcements.

In Canada on Saturday, Ford workers began voting on a tentative agreement that their union said would increase base pay by 15% over three years and provide cost-of-living increases and \$10,000 ratification bonuses. The tentative deal was forged earlier this week, hours before a strike deadline.

The union, Unifor, said the deal, which covers 5,600 workers, also in-

cludes better retirement benefits. If the deal is ratified in voting that will end Sunday morning, the union will use it as a pattern for new contracts at GM and Stellantis plants in Canada.

In the United States, the UAW began its walkout more than a week ago by striking three assembly plants - one each at GM, Ford and Stellantis. In expanding the strike on Friday, the UAW struck only the parts-distribution centers of GM and Stellantis. Ford was spared from the latest walkouts because of progress that company has made in negotiations with the union, said UAW President Shawn Fain.

said UAW President Snawn Fain.

Striking the parts centers is designed to turn up pressure on the companies by hurting dealers who service vehicles made by GM and Stellantis, the successor to Fiat Chrysler. Service shops are a profit center for dealers, so the strategy could prove effective. Millions of motorists depend on those shops to maintain and repair their cars and trucks

and repair their cars and trucks.

"It severely hits the dealerships, and it hurts the customers who purchased those very expensive vehicles in good faith," said Art Wheaton, a labor expert at Cornell University. "You just told all your customers, 'Hey we can't fix those \$50,000 to \$70,000 cars we just sold you because we can't get you the parts."

California bill to have human drivers ride in autonomous trucks vetoed by governor

SACRAMENTO, Calif, Sept 24, (AP): California Gov. Gavin Newsom has vetoed a bill to require human drivers on board self-driving trucks, a measure that union leaders and truck drivers said would save hundreds of thousands of jobs in the state.

The legislation vetoed Friday night would have banned self-driving trucks weighing more than 10,000 pounds (4,536 kilograms) - ranging from UPS delivery vans to massive big rigs - from operating on public roads unless a human driver is on board.

Lorena Gonzalez Fletcher, head of the California Labor Federation, said driverless trucks are dangerous and called Newsom's veto shocking. She estimates that removing drivers would cost a quarter million jobs in the state. "We will not sit by as bureaucrats side with tech companies, trading our safety and jobs for increased corporate profits. We will continue to fight to make sure that robots do not replace human drivers and that technology is not used to destroy good jobs," Fletcher said in a statement late Friday.

said in a statement late Friday.

In a statement announcing that he would not sign the bill, the Democratic governor said additional regulation of autonomous trucks was unnecessary because existing laws are sufficient.

Newsom pointed to 2012 legislation that allows the state Department of Motor Vehicles to work with the California Highway Patrol, the National Highway Traffic Safety Administration "and others with relevant expertise to determine the regulations necessary for the safe

operation of autonomous vehicles on public roads."

Opponents of the bill argued self-

Opponents of the bill argued self-driving cars that are already on the roads haven't caused many serious accidents compared to cars driven by people. Businesses say self-driving trucks would help them transport products more efficiently.

Union leaders and drivers said the

Union leaders and drivers said the bill would have helped address concerns about safety and losing truck driving jobs to automation in the future.

The bill coasted through the Legisla-

ture with few lawmakers voting against it. It's part of ongoing debates about the potential risks of self-driving vehicles and how workforces adapt to a new era as companies deploy technologies to do work traditionally done by humans.

Microsoft's revamped \$69 bln deal for Activision gets closer to UK approval

Watchdog closer to reversing earlier decision

LONDON, Sept 24, (AP): British competition regulators signaled Friday that Microsoft's restructured \$69 billion deal to buy video game maker Activision Blizzard is likely to receive antitrust approval.

The Competition and Markets Authority said the revamped proposal "substantially addresses previous concerns" about stifling competition in the fast-growing cloud gaming market, which frees players from buying expensive consoles and gaming computers by streaming games to tablets, phones and other devices.

The updated offer "opens the door to the deal being cleared," the watchdog said, though there are lingering concerns. Microsoft has offered remedies that the watchdog provisionally decided will resolve those issues, and regulators are now getting feedback on those fixes before making a final

The announcement shows the U.K. watchdog is closer to reversing its earlier decision to block Microsoft from taking over the maker of hit gaming franchises like Call of Duty and World of Warcraft, removing a final obstacle for one of the largest tech transactions in history

"The CMA's position has been consistent throughout - this merger could only go ahead if competition, innovation and choice in cloud gaming was preserved," CEO Sarah Cardell said. "In response to our original prohibition, Microsoft has now substantially restructured the deal, taking the necessary steps to address our original concerns.'

Since the deal was announced in January 2022, Microsoft has secured approvals from antitrust authorities covering more than 40 countries. Crucially, got a thumbs-up from the 27-nation European Union after agreeing to allow users and cloud gaming platforms to stream its titles without paying royalties for 10 years.

But it hit a roadblock in Britain, where regulators feared Microsoft's pur-

chase of Activision would harm competition and hurt gamers.

The companies agreed to extend the original July deadline for the deal to close to mid-October to try to overcome the British regulator's objections. The CMA then put its original decision on hold and opened a new investigation into the revamped proposal.

Microsoft President Brad Smith said the company is "encouraged by this positive development" in the U.K. watchdog's review process.

"We presented solutions that we believe fully address the CMA's remaining concerns related to cloud game streaming, and we will continue to work toward earning approval to close prior to the October 18 dead-

Under the restructured deal, Microsoft will sell off cloud streaming rights outside of the EU and three other European countries for all current and new Activision games released over the next 15 years to French game studio Ubisoft Entertainment.

What does it mean, who's hit and what's next?

US federal govt is headed into a shutdown

WASHINGTON, Sept 24, (AP): The federal government is heading toward a shutdown that will disrupt many services, squeeze workers and roil politics as Republicans in the House, fueled by hard-right demands for deep cuts, force a confrontation over federal

spending.
While some government entities will be exempt - Social Security checks, for example, will still go out - other functions will be severely curtailed. Federal agencies will stop all actions deemed non-essential, and millions of federal employees, including members of the military, won't receive paychecks.

Here's a look at what's ahead if the government shuts down on Oct. 1.

What is a government shutdown? A shutdown happens when Congress fails to pass some type of funding legislation that is signed into law by the president. Lawmakers are supposed to pass 12 different spending bills to fund agencies across the government, but the process is time-consuming. They often resort to passing a temporary extension called a continuing resolution or CR, to

allow the government to keep operating. When no funding legislation is enacted, federal agencies have to stop all non-essential work and will not send paychecks as long as the shutdown lasts.

Although employees deemed essential such as air traffic controllers and law enforcement officers still have to report to work, other federal employees are furloughed. Under a 2019 law, those same workers are slated to receive backpay once the funding impasse is resolved.

When would a shutdown begin

and how long will it last? Government funding expires Oct. 1, the start of the federal fiscal year. A shutdown will effectively begin at 12:01 a.m. if Congress is not able to pass a funding plan that the president signs into law.

It is impossible to predict how long a shutdown would last. With Congress divided between a Democraticcontrolled Senate and Republican-led House, and Speaker Kevin McCarthy's hard-right conservatives looking to use the shutdown as leverage for spending cuts, many are bracing for a stoppage that could last weeks.

Who does a shutdown affect?

Millions of federal workers face delayed paychecks when the government shuts down, including many of the roughly 2 million military personnel and more than 2 million civilian workers across the nation.

Nearly 60% of federal workers are stationed in the Defense, Veterans Affairs and Homeland Security depart-

Federal workers are stationed in all 50 states and have direct interaction with taxpayers -- from Transportation Security Administration agents who operate security at airports to Postal Service workers who deliver mail.

Some federal offices will also have to close or face shortened hours during a shutdown.

Beyond federal workers, a shutdown could have far-reaching effects on government services. People applying for government services like clinical trials, firearm permits and pass-

Businesses closely connected to the federal government, such as federal contractors or tourist services around national parks, could see disruptions and downturns. The travel sector could lose \$140 million daily in a shutdown, according to the U.S. Travel Industry

Association. Lawmakers also warn that a shutdown could rattle financial markets. Goldman Sachs has estimated that a shutdown would reduce economic growth by 0.2% every week it lasted, but growth would then bounce back after the government reopens.

Others say the disruption in government services has far-reaching impacts because it shakes confidence in the government to fulfill its basic duties. The U.S. Chamber of Commerce warned, "A well-functioning economy requires a functioning government."

What about court cases, the work of congress and presidential pay?

The president and members of Congress will continue to work and get paid. However, any members of their staff who are not deemed essential will be furloughed.

The judiciary will be able to continue to operate for a limited time using funds derived from court filings and other fees, as well as other approved

Notably, funding for the three spe-

cial counsels appointed by Attorney General Merrick Garland would not be affected by a government shutdown because they are paid for through a permanent, indefinite appropriation, an area that's been exempted from shut-

downs in the past. That means the two federal cases against Donald Trump, the former president, as well as the case against Hunter Biden, the son of President Joe Biden, would not be interrupted. Trump has demanded that Republicans defund the prosecutions against him as a condition of funding the government, declaring it their "last chance" to act.

Has this happened before? Prior to the 1980s, lapses in government funding did not result in government operations significantly shuttering. But then-U.S. Attorney General Benjamin Civiletti, in a series of legal opinions in 1980 and 1981, argued that government agencies cannot legally operate during a funding gap.

Federal officials have since operated under an understanding they can make exemptions for functions that are "essential" for public safety and constitutional duties.

Since 1976, there have been 22 funding gaps, with 10 of them leading to workers being furloughed. But most of the significant shutdowns have taken place since Bill Clinton's presidency, when then-Speaker Newt Gingrich and his conservative House majority de-

manded budget cuts. The longest government shutdown happened between 2018 and 2019 when then-President Trump and congressional Democrats entered a standoff over his demand for funding for a border wall. The disruption lasted 35 days, through the holiday season, but was also only a partial government shutdown because Congress had passed some appropriations bills to fund parts of the government.

What does it take to end a shutdown?

It's the responsibility of Congress to fund the government. The House and Senate have to agree to fund the government in some way, and the president has to sign the legislation into law.

Congress often relies on a so-called continuing resolution, or CR, to provide stopgap money to open government offices at current levels as budget talks are underway. Money for pressing national priorities, such as emergency assistance for victims of natural disasters, is often attached to a short-term bill.

But hardline Republicans say any temporary bill is a non-starter for them. They are pushing to keep the government shut down until Congress negotiates all 12 bills that fund the government, which is historically a laborious undertaking that isn't resolved until December, at the earliest.

The strategy's language is vague, obscure and almost noncommittal. But it points the industry toward a cleaner future. New European Union rules will also soon go into effect that will significantly raise costs for ships burning highly polluting sulfur fuel oil.

I spent several years working in the shipping industry and follow it as a researcher and analyst. Here's what I see changing.

The new IMO strategy does not explicitly set a new fuel standard, but it seems to indicate that less reliance on cheap, environmentally harmful, heavy-sulfur fuel oil is the best direction, and possibly less use of low-sulfur fuel oil.

What the strategy does is set goals to reduce international shippings' greenhouse gas emissions by at least 20% by 2030, compared with 2008 levels; by at least 70% by 2040; and to reach net-zero emissions around 2050. The IMO also commits to implement a greenhouse gas emissions-pricing mechanism - a carbon levy or tax - by 2027, and to develop a goal-based marine fuel standard. At this time, that's the only direction the IMO has provided regarding the emissions-pricing mechanism.

While the new strategy may not have been as clear or restrictive as many people hoped, the IMO may be providing the maritime industry an opportunity to set the direction itself.

A number of large ship owners and operators have already built and placed orders for container ships with some sort of alternative fuel use, primarily methanol or liquefied natural gas, and there is some interest in hydrogen. LNG is still a fossil fuel, though it's less polluting than traditional sulfur oil. Methanol, however, can be made from either natural gas or renewable sources.

Maersk's new dual-fuel vessel - to be powered in part by green methanol is small and plans to operate in the Baltic Sea, but Maersk may be using this vessel as a prototype for larger alternative-fuel containerships expected to be delivered next year. Evergreen, also among the world's larger shipping companies, has ordered 24 dual-fueled methanol ships.

Purchases like Maersk's and Evergreen's are an indication that the maritime industry will be moving in the direction of greener fuels. They also indicate that the industry is willing to follow the IMO's focus on well-to-wake emissions, meaning not just emissions from ship operations but also from fuel

The other significant challenge faced by the maritime industry is having a sufficient supply chain available to support dual-fueled vessels, which can operate on alternative fuels.

There are currently a limited number of ports worldwide with the necessary infrastructure to provide alternative fuels. But, here again, simple economics suggests that if there is enough demand, supply should follow.

With Maersk, Evergreen and others preparing to operate more dual-fuel containerships, the industry is demonstrating demand so the green-methanol supply chain can develop, and hopefully soon. Japan recently launched its first dual-fueled LNG bunkering ship - essentially a floating gas station - to develop the supply of LNG fuel.

The new IMO strategy has some big caveats: The goals are nonbinding, and the strategy explicitly encourages compliance when "national circumstances allow." In other words, no nation-state will be under any legal obligation to comply.

The statement seems to have been included as a means to appear focused on achieving goals while placating some countries that may not be able or willing to meet the goals by 2030 or beyond.

It's also unclear whether the "national circumstance" pertains to a physical nation-state, to flag registry meaning where the ship is registered or both. Many ships are registered in countries with weaker regulations. Adding such language appears to say that the IMO is serious about emissions and understands that some countries may have significant challenges to meet the standards. It also gets around opposition to a carbon levy, or tax on emissions, which some delegates - China for example - adamantly opposed.

Many countries, such as the U.S., United Kingdom, Australia and those in the European Union, will work to meet the strategy, I believe. The EU is already launching its own carbon levy on shipping beginning in 2024.

One factor that the IMO, most analysts and environmentalists rarely discuss is the additional cost of using an alternative fuel.

By some estimates, green methanol costs three times as much as low-sulfur fuel oil. And low-sulfur fuel oil is more expensive than high-sulfur fuel oil. The maritime research company Drewry estimated that switching to methanol on a well-to-wake basis would increase fuel costs by 350%, or equal to approximately an additional \$1,000 for each 40-foot-long shipping container aboard.

Shipping lines will soon also face higher costs from the European Union if they don't clean up their emissions. Starting in 2024, the EU Emissions Trading System will cover all cargo and passenger ship voyages in EU waters and ports involving over 5,000 gross tons, regardless of where the ship is registered. The costs to those with high emissions are expected to significantly increase the operating costs for the global shipping fleet.

Hecla Emissions Management, a consulting arm set up by Wilhelmsen Ship Management and Affinity Shipping, analyzed the three-year phase-in period for just the EU change and expects it to cost the shipping industry nearly \$19 billion.

Whether we like it or not, these additional costs will be borne by the cargo owners, who will pass the costs along to their customers - and, ultimately, the consumer, meaning you and me. (AP)

Japan's central bank keeps ultra-low rates policy it is expected to be under downward

TOKYO, Sept 24, (KUNA): Japan's central bank decided on Friday to maintain its ultra-low interest rates policy.

At a two-day policy meeting, Bank of Japan's (BOJ) Governor Kazuo Ueda and his eight board colleagues agreed to keep shortterm interest rates at minus 0.1 percent and guiding 10-year government bond yields around zero percent within the 0.5 percent cap, according to a statement released by the BOJ.

"The bank will continue to maintain the stability of financing, mainly of firms, and financial markets, and will not hesitate to take additional easing measures if necessary," it said. The central bank also said it will continue to offer to purchase 10year Japanese government bonds at an effective ceiling of 1.0 percent in fixed-rate operations every business day, the new upper limit it adopted

Meanwhile, the BOJ said the world's third-largest economy is likely to continue recovering moderately for the time being, although pressure stemming from a slowdown in the pace of recovery in overseas economies. Thereafter, as a virtuous cycle

from income to spending gradually intensifies, Japan's economy is projected to continue growing at a pace above its potential growth rate," it

Govts tap latest tech to get ahead of flames

As wildfire risks rise, Al solutions are gaining ground to fight them

LONDON, Sept 24, (AP): Wildfires fueled by climate change have ravaged communities from Maui to the Mediterranean this summer, killing many people, exhausting firefighters and fueling demand for new solutions. Enter artificial intelligence.

Firefighters and startups are using AI-enabled cameras to scan the horizon for signs of smoke. A German company is building a constellation of satellites to detect fires from space. And Microsoft is using AI models to predict where the next blaze could be sparked.

With wildfires becoming larger and more intense as the world warms, firefighters, utilities and governments are scrambling to get ahead of the flames by tapping into the latest AI technology - which has stirred both fear and excitement for its potential to transform life. While increasingly stretched first responders hope AI offers them a leg up, humans are still needed to check that the tech is accurate.

California's main firefighting agency this summer started testing an AI system that looks for smoke from more than 1,000 mountaintop camera feeds and is now expanding it statewide.

The system is designed to find "abnormalities" and alert emergency command centers, where staffers will confirm whether it's indeed smoke or something else in the air.

Interrogate

"The beauty of this is that it immediately pops up on the screen and those dispatchers or call takers are able to interrogate that screen" and determine whether to send a crew, said Phillip SeLegue, staff chief of intelligence for the California Department of Forestry and Fire Protection.

The cameras, part of a network that workers previously had to watch, provide billions of bytes of data for the AI system to digest. While humans still need to confirm any smoke sightings, the system helps reduce fatigue among staffers typically monitoring multiple screens and cameras, alerting them to look only when there's possible fire or smoke, ŠeLegue said.

It's already helped. A battalion chief got a smoke alert in the middle of the night, confirmed it on his cellphone and called a command center in San Diego to scramble first responders to the remote area.

The dispatchers said that if they hadn't been alerted, the fire would have been much larger because it likely wouldn't have been noticed until the next morning, SeLegue said.

San Francisco startup Pano AI takes a similar approach, mounting cameras on cell towers that scan for smoke and alert customers, including fire departments, utility companies and ski re-

The cameras use computer vision machine learning, a type of AI.
"They're trained very specifically to

detect smoke or not, and we train them with images of smoke and images of not smoke," CEO Sonia Kastner said. The images are combined with feeds from government weather satel-

Hawaii economists warn 'the risk is real'

Lahaina locals could be priced out of rebuilt town without zoning changes

HONOLULU, Sept 24, (AP): Residents who survived the wildfire that leveled the Hawaii town of Lahaina might not be able to afford to live there after it is rebuilt unless officials alter the zoning laws and make other changes, economists warned Friday.

"The risk is very real," Carl Bonham, executive director of the University of Hawaii Economic Research Organization, told a virtual news conference ahead of the group's release Friday of its quarterly state economic

Soaring housing prices have already forced many Native Hawaiians and other longtime Hawaii residents to leave the islands and move to the US mainland. The wildfire that claimed at least 97 lives and destroyed 2,200 buildings in the West Maui community of Lahaina - 86% of which were residential - amplifies that problem for the survivors. Nearly 8,000 of them have been placed at 40 hotels or other accommodations around the island of Maui

"Market prices for this new housing are likely to far exceed the already high prices that existed in Lahaina before the fire. For renters, the old housing stock that was destroyed provided opportunities for reasonable rents," the economic report said.

A spike in housing costs would be a further burden for people - including retirees and those who worked in restaurants, hotels and shops - who lost their homes and jobs when their places of employment burned to the ground on Aug. 8, or when West Maui temporarily closed to tourism after the

West Maui, where the verdant coastline is studded with resort hotels, will reopen on Oct. 8.

You'll see that that will speed our recovery for those who have suffered so much," Gov. Josh Green said.

At a news conference on Thursday at the state Capitol, Green stressed

that the displaced survivors won't be forced out of hotels to make room for tourists, with October typically being a slow month for tourism

But it is much less clear when people displaced by the fire will be able to move back to Lahaina and whether they'll be able to afford to do so. Bonham said he doubts that rebuilding will start before 2025.

The warning about locals being priced out of a rebuilt Lahaina, which was once the capital of the former Hawaiian kingdom in the 1800s, comes despite Green's assurances that he won't let it get too expensive for locals. Green previously indicated that he was considering having the state acquire land for workforce housing, but he later said that wouldn't happen unless the community requested it.

Utility companies sometimes play a role in sparking wildfires, when their power lines are knocked down by wind electric utility acknowledged that its power lines started a devastating blaze in Maui this summer after apparently being downed by high winds.

PGE, which provides electricity to 51 cities in Oregon, has deployed 26 Pano AI cameras, and Bekkedahl said they have helped speed up response and coordination with emergency services.

Treatment plan for depression can be challenging

Deep brain stimulation, biomakers transform depression recovery

It can be challenging to create a treatment plan for depression. This is especially true for patients who aren't responding to conventional treatments and are undergoing experimental therapies such as deep brain stimulation. For most medical conditions, doctors can directly measure the part of the body that is being treated, such as blood pressure for cardiovascular disease. These measurable changes serve as an objective biomarker of recovery that provides valuable information about how to care for these patients.

On the other hand, for depression and other psychiatric disorders, clinicians rely on subjective and nonspecific surveys that ask patients about their symptoms. When a patient tells their doctor they are experiencing negative emotions, is that because they are relapsing in their depression or because they had a bad day like everyone does sometimes? Are they anxious because their depression symptoms have lessened enough that they are experiencing new feelings, or do they have some other medical problem independent of their depression? Each reason may indicate a different course of action, such as altering a medication, addressing an issue in psychotherapy or increasing the intensity of brain stimulation treatment.

Help

We are neuroengineers. In our study, newly published in Nature, we identified potential biomarkers for deep brain stimulation that could one day help guide clinicians and patients when making treatment decisions for those using this approach to alleviate treatment-resistant depression.

Clinical depression does not respond to available therapies in a significant number of patients. Researchers have been working to find alternative options for those with treatment-resistant depression, and many decades of experiments have identified specific brain networks with abnormal electrical activity in those with depression.

This notion of depression as abnormal brain activity rather than a chemical imbalance led to the development of deep brain stimulation as a depression treatment: a surgically implanted, pacemaker-like device that delivers electrical impulses to certain areas of the brain. Studies testing this technique have found that it can decrease depression severity over time in most patients.

Our research team wanted to find specific changes in brain activity that could serve as a biomarker that objectively measures how well deep brain stimulation is helping patients with depression. So we monitored the brain activity of 10 patients receiving deep brain stimulation for severe treatment-resistant depression over six months.

At the end of six months, 90% of the patients responded to the therapy - defined by a reduction of symptoms by at least a half - and 70% were in remission, meaning they no longer met the criteria for clinical depression.

To identify a potential biomarker, we developed an algorithm that looked for patterns in brain activity changes as patients recovered. The algorithm was based on data from six out of the original 10 patients who had usable data from the experiment. We found that there are coordinated changes in different frequencies present in the electrical activity within the area of the brain being stimulated. Using these patterns, the algorithm was able to predict whether someone was in a stable recovery with 90% accuracy each week.

Interestingly, we observed some parts of this pattern moved in the opposite direction later in stimulation therapy compared with the patterns at the start of therapy. This finding provides evidence that the long-term recovery is due to the brain adapting to the stimulation in a process called plasticity rather than as a direct effect of the stimulation itself.

Investigating

We also saw other potential biomarkers worth investigating further.

For example, abnormalities in brain imaging taken before implanting the electrodes in specific parts of the brain correlated with how sick each patient was. This could provide clues about what's causing depression in some people, or help develop imaging methods to determine who might be a good candidate for deep brain stimulation.

For another example, we found that the facial expressions of patients changed as their brains changed over the course of their treatment. While physicians often report this anecdotally, quantifying these changes may provide a way to develop objective markers of recovery that incorporate a patient's behavior with their brain

Because the results of our study are based on a small sample of patients, it's important to further investigate how broadly they can be applied to other patients and newer deep brain stimulation devices.

Clinical depression is a debilitating condition that causes significant personal and societal suffering. It is one of the largest contributors to the overall disease burden of many countries. Despite the many approved treatments available, nearly 30% of the 8.9 million US adults taking medications for clinical depression continue to have symptoms.

Deep brain stimulation is one of the alternative therapies for treatment-resistant depression that researchers are investigating. Studies have shown that deep brain stimulation can offer effective and long-term relief for some patients.

Although deep brain stimulation is an approved treatment for other conditions like Parkinson's disease, it remains an experimental therapy for treatment-resistant depression. While the results from small experimental studies have been positive, they have not been successfully replicated in large-scale, randomized clinical trials necessary for approval from the US Food and Drug Administration.

Finding an objective biomarker

that measures recovery in depression has the potential to improve treatment decisions. For example, one patient in our study had a relapse after several months of remission. Were a biomarker available at the time, the clinical team would have had warning that the patient was relapsing weeks before standard symptom surveys showed that anything was wrong. Such a tool could help clinicians intervene before a relapse becomes an

US breakdancers aim to preserve Black roots at Olympics

NEW YORK, Sept 24, (AP): As ambassadors of the country where breakdancing originated 50 years ago, members of Team USA have something to prove - and potentially to lose - when the hip-hop dance form makes its official debut at the Paris Games in 2024.

That's because for US breakers like Carmarry Hall, Victor Montalvo and Jeffrey Mike Louis, it's more than just nailing the right moves; it's about preserving breaking's soul.

"When I started breaking, it wasn't about competition; it was about culture, it was about Black dance," said Hall, an African American Team USA member. "The Olympic platform is not going to appreciate the understanding. It's structured in a certain way, and in that structure, you lose a little bit of the heart."

But it is precisely that structure that international competitors to the US have zoned in on while battling for a shot at Olympic gold in headto-head contests over the past year. And at the moment, Team USA's squad of b-boys and b-girls, the term for male and female breakers, is trailing in rankings tabulated by the World DanceSport Federation, the International Olympic Committee-approved body that administers breaking battles.

As of Friday, the top three b-boys in the world are Canada's Philip Kim, known as B-Boy Phil Wizard; Japan's Shigeyuki Nakarai, known as B-Boy Shigekix; and France's Danis Civil, known as B-Boy Dany. The top three b-girls in the world are Japan's Ami Yuasa, known as B-Girl Ami; China's Qingyi Liu, known as B-Girl 671; and Lithuania's Dominika Banevi□, known as B-Girl Nicka.

"Everybody else has surpassed the United States, so we better go out and do some workout camps," said Chuck D of the iconic hip-hop group Public Enemy. "The United States probably ain't going to gold, silver or bronze. ... Other places, they've been training for years. It's like martial arts.

Dancers need to win or perform well at WDSF-sanctioned events to earn the points that will eventually qualify them for the Paris Games. The next World Breaking Championship is taking place this weekend in Leuven, Belgium, just outside of Brussels.

The top b-boy and the top b-girl from the championship will automatically gain spots in the Olympics. After the Belgium event, Olympic-qualifying competitions are scheduled in China and Chile, through mid-December. Additional Olympic trials will be held in the early part of next year and run through June 2024. At the end of the process, 16 bboys and 16 b-girls will be allowed to compete over two days at Paris' iconic Place de la Concorde.

Competitive

Montalvo, a 29-year-old from Kissimmee, Florida, who also goes by B-Boy Victor, is not discouraged.

"We have a big chance, a really big chance," he said. "We always make the podium.

Montalvo, who is ranked No. 5 in the world among competitive breakers, and nine others have already been named to Team USA, even though they haven't yet qualified for the Paris Games. Competing alongside Montalvo this weekend in Leuven will be No. 7-ranked Team USA member Sunny Choi, aka B-Girl Sunny; Team USA member and No. 40-ranked Morris Isby, aka B-Boy Morris; and Logan Edra, aka B-Girl Logistx, a native of San Diego, California, who is ranked No. 13 in the world but is not a member of Team USA.

It's widely understood in the competitive breaking community that judges favor dancers who master the foundations of breaking: "toprock" moves, footwork, "downrock" moves done closer to the floor, "power" moves showing acrobatics and strength, along with the classic 'headspins," "windmills" and "freeze" poses.

In the past, judging in hip-hop breaking competitions has always been very subjective. But that won't be the case with the Paris Olympics, where officials will use a newly developed system to decide which b-boy or b-girl has bested their opponent in one-on-

The Trivium judging system, created for the debut of breaking at the 2018 Youth Olympic Games in Buenos Aires, is a digital scoring platform that allows judges to react in real time to breakers' physical, artistic and interpretative qualities - their "body, mind and soul." A panel of five judges scores each breaker on creativity, personality, technique, variety, performativity and musicality. The scores can adjust throughout the battle, based on how breakers respond to their

Scores can be lowered if a breaker "bites," or copies, a set of moves from their opponent. Misbehavior, such as deliberate physical contact with an opponent, and other unsportsmanlike conduct can also lower a breaker's score.

The scoring system could not have been developed without the input of the breaking community, said Alexander Diaz, a Boston-based member of Team USA

"It's hard to get all the dancers, all the breakers on the same page," said Diaz, who is also known as B-Boy El Niño.

LOS ANGELES: Public support for striking Hollywood actors and writers is broad, but not necessarily deep enough for most people to change their viewing habits, a new poll finds.

A majority (55%) of **US** adults sympathize with the writers and actors in the months-long dispute than with the studios they're striking against (3%), the poll from The Associated Press-NORC Center for Public Affairs Research shows.

Half of Americans (50%) approve of writers and actors striking, while 40% are neutral on the topic, and 9% disapprove.

The more people said they had heard about the strike, the more likely they were to favor it. About six in 10 Americans have heard "a lot" or "some" about the labor strikes of writers and actors against Hollywood studios. People who have heard "a lot" or "some" about the strike are more likely than those who have heard less to approve (63% vs. 29%).

"I'm a big supporter of labor," said one respondent, James Denton of Louisville, Kentucky, who said he strongly approves of the strikes and has followed them closely. "I'm a union member myself, my father was the president of a union, I believe in unions, they're

well worth the money."

About a quarter (24%) of US adults do not sympathize with either the writers and actors or the studios,

and 18% are split between the sides. Overall sympathy toward the writers and actors runs much more strongly among Democrats (70%), than Independents (47%) and Republicans (39%). Republicans (35%) are more likely than Democrats (15%) to say they sympathize with neither side.

US backs maternal RSV vaccine to protect infants

NEW YORK, Sept 24, (AP): US health officials on Friday recommended RSV vaccinations for moms-to-be, a second new option to protect newborns from serious lung infections. The shots should be given late in pregnancy but only dur-

ing RSV season, the Centers for Disease Control and Preven-"This is another new tool we can use this fall and winter to help protect lives," said CDC Director **Dr. Mandy Cohen**

in a statement.

Cohen signed off after a CDC advisory panel backed the vaccine. The only opposition came from a panel member who found the recommendation "incredibly complicated."

A month ago, the agency recommended another option for infants to guard against severe RSV: lab-made antibodies given to babies younger than 8 months before their first RSV season. A single dose is given to babies by injection after

they are born. Most infants will likely only need protection from one - either the mom's vaccine or the antibodies but not both, Cohen said.

There is no head-to-head study that answers which is more effective, and no published research on how safe it is to give both. And they are both expensive, although the cost will be ultimately covered by insurance.

The RSV vaccine, made by Pfizer, should only be given between 32

weeks and 36 weeks of pregnancy. The shot prompts the moms-to-be to develop virus-fighting antibodies that pass through the placenta to the fetus. Protection in newborns likely drops after 6 months of age, so the shot is for use between September and January in most of the US, to coincide with the time of year when RSV infections tend to be most

A baby born in April, for example, may not have much immunity left from the mother's vaccination by the time the fall RSV season comes around.

"It really depends on when the due date is as to how impactful this vaccination will be," said Dr. Grace Lee, chair of the CDC advisory panel.

RSV, or respiratory syncytial virus, is a common cause of coldlike symptoms. A surge last year filled hospitals with wheezing children, but far more US seniors are hospitalized and die from the virus.

Two new vaccines were recently approved for Americans age 60 and older. There isn't a vaccine for children.

Some CDC panel members who ultimately supported the recommendation expressed reservations. Available data suggests the antibodies are a more cost-effective — and probably longer-lasting - way to prevent severe illness in infants. Several also balked at the \$295-a-dose price Pfizer has been charging for the same RSV vaccine for seniors, called Abrysvo.

Allergy: Federal regulators declined to approve a nasal spray to treat severe allergic reactions recently, calling for more research on what would have been the first alternative to injections using devices such as an EpiPen.

The US Food and Drug Administration told ARS Pharmaceuticals Inc., of San Diego, that the company needs to conduct another study on repeat doses of epinephrine, a drug that halts potentially life-threating reactions, called anaphylaxis, using the company's nasal spray device compared with

The move comes four months after an FDA advisory committee recommended approval of the device, dubbed neffy. The FDA is not required to follow the committee's recommendations, though it usually does.

Richard Lowenthal, president and chief executive of ARS, said in a statement that the company would appeal the FDA's decision and resubmit an application in early 2024.

The ARS product is one of several needle-free devices being developed to treat dangerous reactions to food, insect stings and medications. Such a device could alter treatment for the between 33 million and 45 million Americans with severe allergies to food and other triggers.

Advocates for people with allergies said they were "frustrated" by the FDA's request for more research.

"Our community believe this innovation would finally come to the more than 10% of Americans with life-threatening food allergies, but instead, the FDA will force us to wait even longer," Sung Poblete, chief executive of Food Allergy Research & Education, a nonprofit group, said in a statement.

COVID-19 vaccine: Some people seeking the newest COV-ID-19 vaccine are running into high demand, insurance head-

aches and supply delays coast to coast. Millions of the newly formulated vaccines have shipped out since the Centers for Disease Control and Prevention signed off on them last week for ages 6 months and up. Cases started rising again in late summer, and experts hope that the new shots will help protect people during the upcoming fall respiratory virus season.

But some people have had to cancel appointments because their insurance hasn't updated the billing codes to cover the vaccines. Others signed up for an appointment, only to have it canceled due to supply issues. And in some places, there are no available nearby vaccines: A search in Juneau, Alaska, through the federal government's website shows no available appointments within 100 miles.

Some pharmacies have a limited supply of the shots, Alaska Department of Health spokesperson Alex Huseman said, but order backlogs and slow shipments have prevented the vaccines from being widely available. Private health care providers hopefully can get them as early as next week, she said.

"This rollout has been a little bumpier than anticipated, but we do not believe there will be any significant delay in vaccine availability," Huseman said.

This is the first time that the vaccines are reaching most Americans through the commercial market, bringing public and private health insurers back in the mix. Previously, the federal government bought and distributed COVID-19 vaccines for free since they became available.

CVS Pharmacy spokesperson Matt Blanchette said some insurers are still in the process of updating their billing systems to cover the vaccines. For others, the shots were covered by insurance without issue, but appointments were canceled by their pharmacy due to supply delays.

Walgreens and CVS confirmed that delivery delays to some stores across the country had led to canceled appoint-

"We are aware of isolated incidences at a small number of locations where appointments had to be rescheduled due to delays in supply," a Walgreens spokesperson said, noting most stores "have supply to support existing patient appointments."

Moderna and Pfizer representatives told The Associated Press that they have enough supply. Pfizer spokespeople said it is not experiencing any shortages and has "shipped and delivered several million doses of its 2023-2024 COVID-19 vaccine." Moderna had six million available as of Thursday, vice president of communications Chris Ridley said.

Marwa Bakr, the owner of a small, private pharmacy on Milwaukee's southwest side, said she put in a preorder for Pfizer and Moderna's new vaccines a month ago. She got a call from Moderna this week telling her she should get the vaccines in the next two weeks, and Pfizer has said the shots could come by the end of next week.

She used to order the vaccines through the federal government, and said the return to the commercial process is "taking longer.

'Power' palazzo reopens: An ancient Roman imperial palazzo atop the city's Palatine Hill was reopened to tourists, nearly 50 years after its closure for restoration.

The nearly 2,000-year-old Domus Tiberiana was home to rulers in the ancient city's Imperial period. The sprawling palace allows for sweeping views of the Roman Forum below.

The public is now able to tour it, following decades of structural restoration work to shore the palace up for safety reasons. Excavations uncovered artifacts from centuries of Roman life following the decline of the

The director of the Colosseum Archeological Park, which includes the Palatine Hill, in a written description of the restored palazzo, dubbed it "the power palace par

On the eve of the reopening, the official, Alfonsina Russo, quoted a first-century Roman poet as saying the sprawling palace seemed "infinite" and that "its grandiosity was just like the grandiosity of the sky."

Although the domus, or residence, is named after Tiberius, who ruled the empire after the death of Augustus, archaeological studies indicated that the palace's foundations date from the era of Nero, shortly after the fire of 64 A.D that devastated much of the city.

After the demise of the Roman Empire, the residence suffered centuries of abandonment, until when, in the 1500s, the Farnese noble family developed an extensive garden around the ruins.

Thanks to the palazzo's reopening to the public, visitors today can get a better idea of the path ancient emperors and their courts enjoyed en route to the domus.

The English word "palatial" is inspired by the sumptuous imperial residence atop the Palatine, one of ancient Rome's seven

The domus, built on the northwest slope of the hill, is considered to be the first true imperial palace. Besides the emperor's residence, the complex included gardens, places of worship, quarters for the Praetorian Guard that protected the ruler and a service district for workers that overlooked the Ro-

Excavation and restoration work, carried out also during the coronavirus pandemic when for months tourism was at a minimum, helped archeologists piece together what Russo calls centuries of history in a place that "somehow went forgotten.

On display for those visiting the reopened domus is a selection of hundreds of artifacts that were found, including objects in metal and glass. Statues, other decorations and ancient coins were also dug up. (AP)

Experts anticipate at least a cup of rubble from Bennu

First asteroid samples heading for Earth

NEW YORK, Sept 24, (AP): A space capsule carrying NASA's first asteroid samples streaked toward a touchdown in the Utah desert Sunday to cap a seven-year journey.

Flying by Earth, the Osiris-Rex spacecraft released the capsule from 63,000 miles (100,000 kilometers) out. The capsule was expected to parachute down four hours later onto the military's Utah Test and Training Range.

Scientists anticipated getting at least a cup of rubble from the carbon-rich asteroid known as Bennu. About a teaspoon was returned by Japan, the only other country to bring back asteroid samples.

The pristine samples are believed to be the leftover building blocks from the dawn of our solar system and will help scientists better understand how Earth and life formed.

Osiris-Rex rocketed away on the \$1 billion mission in 2016. It reached Bennu two years later and, using a long stick vacuum, grabbed dust and pebbles from the small roundish space rock in 2020. By the time it returned Sunday, the spacecraft had traveled 4 billion miles (6.2 billion

Now free of the sample capsule, Osiris-Rex is already targeting another asteroid. That encounter won't occur until 2029.

NASA's recovery effort in Utah includes helicopters and a temporary clean room set up at the range. The samples will be flown Monday to a new lab at NASA's Johnson Space Center in Houston.

Scientists anticipate getting about a half pound (250 grams) of pebbles and dust, much more than the teaspoon or so brought back by Japan from two other asteroids. No other country has fetched pieces of asteroids, preserved time capsules from the dawn of our solar system that can help explain how Earth - and life -

came to be. Sunday's landing concludes a 4 billion-mile (6.2-billion-kilometer) journey highlighted by the rendezvous with the carbon-rich Bennu, a unique pogo stick-style touchdown and sample grab, a jammed lid that sent some of the stash spilling into space, and now the return of NA-SA's first asteroid samples.

"I ask myself how many heartpounding moments can you have in one lifetime because I feel like I might be hitting my limit," said the University of Arizona's Dante Lauretta, the mission's lead scientist. A brief look at the spacecraft and its cargo: Asteroid chaser Osiris-Rex blast-

ed off on the \$1 billion mission in 2016. It arrived at Bennu in 2018 and spent the next two years flying around the small spinning space rock and scouting out the best place to grab samples. Three years ago, the

spacecraft swooped in and reached out with its 11-foot (3-meter) stick vacuum, momentarily touching the asteroid's surface and sucking up dust and pebbles. The device pressed down with such force and grabbed so much that rocks became wedged around the rim of the lid. As samples drifted off into space, Lauretta and his team scrambled to get the remaining material into the capsule. The exact amount inside won't be

known until the container is opened. **Formation**

Discovered in 1999, Bennu is believed to be a remnant of a much larger asteroid that collided with another space rock. It's barely one-third of a mile (half a kilometer) wide, roughly the height of the Empire State Building, and its black rugged surface is packed with boulders. Roundish in shape like a spinning top, Bennu orbits the sun every 14 months, while rotating every four hours. Scientists believe Bennu holds leftovers from the solar system's formation 4.5 billion years ago. It may come dangerously close and strike Earth on Sept. 24, 2182 - exactly 159 years after the asteroid's first pieces arrive. Osiris-Rex's up-close study can help humanity figure out how to deflect Bennu if needed, Lauretta said.

Osiris-Rex will release the sample capsule from 63,000 miles (100,000 kilometers) out, four hours before it's due to touch down at the Defense Department's Utah Test and Training Range on Sunday morning. The release command will come from spacecraft builder Lockheed Martin's control center in Colorado. Soon afterward, the mothership will steer away and take off to explore another asteroid. The capsule - nearly 3 feet wide (81 centimeters) and 1.6 feet tall (50 centimeters) - will hit the atmosphere at 27,650 mph (44,500 kph) for the final 13 minutes of descent remaining. The main parachute will slow the last mile (1.6 kilometers), allowing for a mild 11 mph (18 kph) touchdown. Once everything is deemed safe, the cap-

sule will be hustled by helicopter to a makeshift clean lab at the range. The next morning, a plane will carry the sealed container full of rubble to Houston, home to NASA's Johnson Space Center. NASA is livestreaming the touchdown, set for around 10:55 a.m. EDT.

A new lab at Johnson will be limited to the Bennu rubble to avoid cross-contamination with other collections, said NASA curator Kevin Righter. Building 31 already holds the moon rocks brought back by the Apollo astronauts from 1969 through 1972, as well as comet dust and specks of solar wind collected during two previous missions and Mars meteorites found in Antarctica. The asteroid samples will be handled inside nitrogen-purging gloveboxes by staff in head-to-toe clean room suits. NASA plans a splashy public reveal of Bennu's riches on Oct. 11.

This fall is what NASA is calling Asteroid Autumn, with three asteroid missions marking major milestones. The Osiris-Rex touchdown will be followed by the launch of another asteroid hunter on Oct. 5. Both the NASA spacecraft and its target a metal asteroid - are named Psyche. Then a month later, NASA's Lucy spacecraft will encounter its first asteroid since soaring from Cape Canaveral, Florida, in 2021. Lucy will swoop past Dinkinesh in the main asteroid belt between Mars and Jupiter on Nov. 1. It's a warmup for Lucy's unprecedented tour of the socalled Trojans, swarms of asteroids that shadow Jupiter around the sun. Neither Psyche nor Lucy will collect souvenirs, nor will Osiris-Rex on its next assignment, to explore the asteroid Apophis in 2029.

This is NASA's third sample return from deep space, not counting the hundreds of pounds (kilograms) of moon rocks gathered by the Apollo astronauts. The agency's first robotic sample grab ended with a bang in 2004. The capsule bearing solar wind particles slammed into the Utah desert and shattered, compromising the samples. Two years later, a US capsule with comet dust landed intact. Japan's first asteroid sample mission returned microscopic grains from asteroid Itokawa in 2010. It's second trip yielded about 5 grams a teaspoon or so- from the asteroid Ryugu in 2020. The Soviet Union transported moon samples to Earth during the 1970s, and China returned lunar material in 2020.

Okefenokee World Heritage bid: A

US agency said Friday it will nominate the vast, federally protected wildlife refuge in the Okefenokee Swamp for listing as a UN-ESCO World Heritage site

The National Park Service filed a notice in Washington that it will seek the designation for the Okefenokee National Wildlife Refuge, which sprawls across more than 400,000 acres (161,875 hectares) in southeast Georgia near the Florida state line.

Conservation groups say the rare distinction would boost the Okefenokee's profile

"It would join a long list of iconic American landscapes - the Grand Canyon, Yellowstone, Yosemite," said Kim Bednarek, executive director of the nonprofit Okefenokee Swamp Park that's working with the U.S. government on the refuge's nomination package. "Nobody questions the value of those places.

Since the 1970s, the World Heritage list has recognized more than 1,100 natural and cultural sites worldwide for having "outstanding universal value" to all of humanity. Just 25 places in the U.S. have been listed, including national parks like the Grand Canyon in Arizona and treasured manmade landmarks such as the Statue of Liberty.

The most recent US addition, a network of ancient Native American ceremonial and burial mounds in Ohio, was announced by UNESCO's World Heritage Committee.

The Okefenokee refuge covers more than 90% of the swamp and is the largest national wildlife refuge east of the Mississippi River. Its diverse wildlife, cypress forests and flooded prairies draw roughly 600,000 visitors each year, according to the US Fish and Wildlife Service, which manages the

Designation as a World Heritage site wouldn't impose any added restrictions or regulations for the Okefenokee. But conservationists say the distinction of being listed gives governments and local communities an incentive to protect and preserve the



Lewandowski, Cancelo lead Barcelona to comeback win over Celta

BARCELONA, Spain, Sept 24, (AP): Robert Lewandowski scored two late goals before João Cancelo snatched the 89th-minute winner to lead Barcelona to a 3-2 comeback win over Celta Vigo at home in the Spanish league.

Rafa Benítez was eying his first big win since returning to coaching in Spain with his team ahead 2-0 before Lewandowski struck in the 81st minute. Cancelo then set up Lewandowski to equalize in the 85th before the Portugal right back completed the

"It was a great fightback," said Barcelona coach Xavi Hernández, who signed a contract extension through 2025 on Friday. "It is true we were disorganized at times and didn't make the ball flow like in other games, but the team won in faith and courage.'

Barcelona is tied on points with the surprising Girona at the top of the table after its fellow Catalan club routed Mallorca 5-3.

Jorgen Strand Larsen put Celta ahead in the 19th and substitute Anastasios Douvikas made it 2-0 in the 76th while its five-man defense held the defending champions in check - until the

Cancelo joined Barcelona on the final day of the transfer window on loan from Manchester City. He has made an immediate impact by giving Barcelona a versatile right back, and it was never more evident than when he joined in a last-gasp push against Celta.

After Lewandowski had given Barcelona hope by scooping a shot over goalkeeper Ivan Villar, Cancelo acted as a midfielder to provide an assist for the Poland striker to make it 2-2. His next move was to make a run through the heart of the defense where he met a lobbed pass by Gavi Páez and guided it home

Cancelo said he was relieved to have helped his new team after having had what he called a poor performance after turning the ball over several times.

"I made many mistakes, but you just have to keep focused and play until the end," Cancelo said. "We didn't play well and Celta did well defending its area. But it is always better to play poorly and win, than to play well and

João Félix set up Lewandowski's first goal, adding to his three goals al-ready since he also arrived on loan just before the market closed.

It was a bitter loss for Benítez, who took over Celta this summer for his first job in Spain since his short-lived stint with Real Madrid in 2015. Celta has only one win in six games under the coach that led Valencia to league titles back in 2002 and 2004.

"I think we played well for most of the game, but in that final stretch I have the feeling their last two goals were preventable," Benítez said. MILAN, Sept 24, (AP): Inter Milan's perfect start to the Serie A season continued with a 1-0 win at Empoli on Sunday but the Nerazzurri found it harder than they perhaps expected against a side that has yet to register a point or score a goal after five matches.

China sweep through gold medals on 'opening' day of Asian Games

HANGZHOU, China, Sept 24, (AP): China has dominated the Asian Games for the last 40 years, and the 2023 edition will be the

The host country won 20 gold medals - 30 overall - on Sunday, just hours after Saturday's opening ceremony overseen by President Xi Jinping and watched by 80,000 at Hangzhou Olympic Sports Center Stadium.

The first gold medal of the games went to the Chinese pair of Zhou Jiaqi and Qiu Xinping in women's lightweight double sculls. The Chinese rolled from there and many are already looking ahead to next year's Olympics in Paris.

"Stepping on to the podium today is a new starting point," Qiu said. "To prepare for next year's Paris Olympics with all our strength is equivalent to starting from scratch."
Added teammate Zhou: "This can help us build self-confidence and help us prepare.

Two other gold medals on the first day went to Hong Kong, in men's pairs in rowing, and in men's individual foil in fencing.

Hong Kong, a former British colony, was returned to Chinese rule in 1997 and has come under increasingly tight control from Beijing following months of pro-democracy protests in 2019.

China won gold in modern pentathlon (2), artistic gymnastics (1), rowing (6), shooting (2), wushu (2) and swimming (7).

Zhang Yufei won the women's 200 butterfly, the same event she won two months ago at the world championships in Fukuoka, Japan.

"I actually felt the pool was a little slow for me," she said. "And I told my coach that I wasn't feeling in good form or I could have gone faster.'

Wang Shun took the men's 200 IM, and Li Bingjie won the women's 1,500.

South Korea won five gold medals on the first day and 14 overall to trail China in second place. South Korea won two gold medals in modern pentathlon, two more in taekwondo, and one in fencing.

Japan had two gold and 14 overall, just behind South Korea.

The only other gold medals on the first day went to Taiwan and Uzbekistan.

China won almost 300 medals -132 gold - five years ago in the Asian Games in Indonesia with Japan and South Korea the main challengers. Host nations traditionally get a

homefield "medal bump," China's dominance this time could be more overwhelming than usual.

The Asian Games feature 12,500 participants from 45 nations and territories. Next year's Olympics will involve about 10,500 from more about 200 delegations.

Cricket is prominent in the Asian Games, and India and Sri Lanka will face off on Monday for the gold in the women's game. The earlier bronze medal game matches Bangladesh against Pakistan.

The men's final is Oct. 7, and many expect a final between old rivals Pakistan and India.

Assefa shatters women's marathon world record

BERLIN, Sept 24, (AP): Tigst Assefa broke the women's world record by more than two minutes Sunday at the Berlin Marathon, as Eliud Kipchoge won the men's race for the fifth time but couldn't break his own record.

Ethiopian runner Assefa, the winner in Berlin a year ago, ran the race in 2 hours, 11 minutes, 53 seconds to break the previous women's record of 2:14:04 set by Kenya's Brigid Kosgei at the Chicago Marathon in 2019.

Assefa sank to her knees after crossing the line and raised her arms, then celebrated with the flag of Ethiopia. She was nearly six minutes clear of any other runner in Sunday's marathon, with Sheila Chepkirui of Kenya second in 2:17:49 and Tanzania's Magdalena Shauri third in 2:18:41.

Max easily wins Japanese GP, edge closer to 2023 series title

'Unbelievable season'

SUZUKA, Japan, Sept 24, (AP): Max Verstappen survived a dramatic first lap then coasted to victory at the Japanese Grand Prix on Sunday to move a step closer to securing

his third consecutive Formula One championship.

The Red Bull driver, who missed out on the podium a week ago in Singapore, started from pole and held on for his 13th win of the season.

With Verstappen's victory, Red Bull secured the constructors' title, their sixth overall and second in a row. They did it with six races remaining.

"What an unbelievable season we are having," Verstappen said. "You can all be very proud here at the track and back at the factory. You guys built a rocket ship of a car, well done.'

second, 19.4 seconds back of Verstappen, while his teammate Australian rookie Oscar Piastri was third for his first F1 podium.

Verstappen, who also secured a point for the fastest lap, increased his lead over Red Bull teammate Sergio Perez to 177 points. He could wrap up his third consecutive title at the Oct. 6-8 Qatar Grand Prix.

The race got off to a thrilling start with Verstappen, Piastri and Norris going wheel-to-wheel but the Red Bull driver held his lead through the first two turns.

Verstappen commented on the ex-

citement at the start. "Luckily nothing happened," Verstappen said. "It all got quite close but that's racing, that's how it goes at the start. And then of course you had a good battle into Turn 1 and Turn 2, I was lucky there (was) a bit more grip in Turn 2. "

MOTOR RACING

It was a disastrous day for Perez, who was given a penalty for hitting Haas driver Kevin Magnussen and retired from the race after serving the penalty.

The Mexican driver won in Saudi Arabia in March and Azerbaijan in April but has struggled since.

Verstappen saw his record 10race winning streak come to end at Marina Bay in Singapore and came to Japan determined to get back on top of the podium. Prior to Sunday's race, he led every session at the fast Suzuka circuit, where he wrapped up last year's championship in a rainshortened race.

Conditions on Sunday were ideal and Verstappen took full advantage.

The safety car came out on the first lap when Alfa Romeo driver Valtteri Bottas made contact with another car resulting in debris on the track. Verstappen was able to quickly retake the lead after his first pit stop and was never seriously challenged.

Ferrari driver Charles Leclerc was fourth followed by Mercedes' Lewis
