SOLVING the most important dilemmas begins with a decision. In this world, there is a solution to every problem ... Even death ends the suffering of a chronic patient, which of course is the will of Allah, but that is the case when all treatments fail to succeed.

However, this does not apply to countries, which have their own laws, experiences, and minds. They also have the right to emulate others who have solved similar problems. This is not a shame.

Therefore, there is no problem without a solution, irrespective of whether it is related to the housing issue, improving the citizens'



livelihood, unnecessary support, infrastructural development, disguised unemployment, the relationship between the executive and legisla tive authorities, amending the Constitution, or raising the national product through the implementation of major projects that benefit the country and those in it.

All of the aforementioned challenges have solutions, but the problem is the decision, and the ambiguity

tiple heads, each with its own decision? If an MP objects to a project, the Council of Ministers suspends it, and if a minister does not like the implementer, he stonewalls it. A major catastrophe happens when the two authorities together take into consideration what is published on social media, after which the ministry issues an order, but at the request of an MP, the decision is suspended, as if the latter's authority

is greater than the authority of the government. Regarding the problem of infrastructure and road repair, the matter does not require much headache ... Just allocate a budget, and the Ministry of Public Works will begin work.

As for the Bedoun issue, there are many laws that have been issued in this regard, but they have been put inside the drawer. On the other hand, in other countries, especially the Gulf countries, this issue has been resolved through a government decision. It did not become a problem that international institutions talk about, as is the case with us, because some do not want to solve it due to flimsy reasons.

Amir to embark on state visit to Egypt

KUWAIT CITY, April 29, (KUNA): His Highness the Amir Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah is scheduled to depart Kuwait heading to Egypt Tuesday (April 30) on a state visit.

Meanwhile, Kuwait's Ambassador in Cairo Ghanim Al-Ghanim underscored the significance of the upcoming historic visit by His Highness the Amir Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah to Egypt Tuesday during which he would meet with President Abdel Fattah El-Sisi.

Ambassador Al-Ghanim told Kuwait News Agency (KUNA) on Monday that the upcoming visit would be the Amir's first since assuming the office last December, coinciding with president El-Sisi's third term. This visit was welcomed both officially and among people.

Al-Ghanim emphasized that the Egyptian-Kuwaiti relations were characterized by their close and enduring historical bonds, spanning decades and serving as a model for Arab-Arab relations.

He explained that the historical and special relationships between Kuwait and Egypt, dating back to before Kuwait's independence in 1961, have been strengthened over the decades by the alignment of visions between their leaderships, contributing to their consolidation in various

Kuwait's expat remittances plunge

Down 28.47%

KUWAIT CITY, April 29: The value of remittances from expatriate workers in Kuwait declined by 28.47% in 2023.

The Al-Seyassah daily said last year the remittances of expatriates from Kuwait were about 3.867 billion dinars (\$12.581 billion), compared to 5.406 billion dinars (\$17.588 billion) in 2022.

Based on statistics issued by the Central Bank of Kuwait, the secondary income account deficit in the net value of current transfers abroad decreased to 3.97 billion dinars during 2023, compared to 5.48 billion dinars in 2022.

Kuwait on alert for 'heavy rain'

KUWAIT CITY, April 29: Meteorologist Issa Ramadan has warned of an upcoming depression that will affect the country for several days, accompanied by light to moderate southeasterly winds. These winds will intermittently increase relative humidity and reduce horizontal visibility, reports Al-Qabas daily.

The forecast indicates cloudy to partly cloudy weather with expected rain, possibly accompanied by thunderstorms. The chances of rain will be particularly high on Tuesday, continuing into Wednesday and Thursday. During this period, relative humidity will increase further, reducing visibility and leading to high waves.

Ramadan emphasized the need for caution in the coming days, highlighting that the weather patterns in May are unusual this year. He advised that southeasterly winds and high humidity are expected to persist into the following week.

Additionally, Ramadan noted that some Gulf countries may experience moderate to heavy rainfall due to the convergence of warm, humid air masses from the Arabian Sea with cold air masses from the upper atmosphere.

KUWAIT CITY, April 29, (Agencies): Minister of Foreign Affairs, Abdullah Al-Yahya, on Monday chaired the State of Kuwait's delegation partaking in the joint ministerial meeting grouping the foreign ministers of the GCC states and the U.S. Secretary of State Antony Blinken,

held at the GCC Secretariat General headquarters in Riyadh, Saudi Ara-The ministers examined the deeprooted historic relations bonding the

GCC states with the United States of America and discussed issues related to the bilateral relations and coopera-The discussions dealt with means

of maintaining the security and stability of the regional states, development and conditions in Gaza Strip, the necessity of enforcing a cease-fire and backing efforts to secure delivery of aid to the Gazans. (end)

The ministerial meeting was chaired by Qatari Foreign Minister Sheikh Mohammad Al-Thani, the chair of current session of the GCC Ministerial Council, with participation of his Saudi counterpart Prince Faisal bin Farhan, GCC Secretary General Jasem Al-Budaiwi, Omani Foreign Minister Badr Al-Busaidi, the latter's Bahraini counterpart Abdullatif Al-Zayani, and Diplomatic Advisor to the United Arab Emirates' President Anwar Gargash.

The conferees discuss latest developments concerning the Gaza Strip and Rafah City, the importance of an immediate ceasefire, and the safe passage for relief and humanitarian aid to reach the Palestinians.

The meeting addresses regional and global developments, as well as ways to develop and strengthen cooperation between the GCC and the US. U.S. Secretary of State Antony

Blinken said on Monday that Washington supports enforcement of a truce in Gaza and releasing the pris-

Kuwait deploys 2nd medical relief team to Gaza hospitals

Kuwait joins US-GCC strategic talks

KUWAIT CITY, April 29, (KUNA): Kuwait Society for Relief (KSR) announced, Monday, the departure of the second medical relief team consisting of 14 physicians and consultants from different medical and surgical fields to Al-Arish Airport head-

ing towards Gaza's hospitals. In a statement to (KUNA), Head of the medical team Dr. Ibrahim Al-Saleh confirmed sending the Kuwaiti relief medical team to the Gaza Strip came within the framework of donations campaign, launched by Kuwait Relief and is still ongoing.

The team left with six tons of basic and necessary medical supplies and equipment, to help the health system in Gaza Strip and provide medical care and medications, especially for some critical cases and chronic diseases, he

The team will perform important surgical operations in various surgical specialties, in addition to implementing a number of other relief projects, most notably food and shelter projects, Dr. Al-Saleh noted.

He praised the efforts of the official and humanitarian agencies in Kuwait, Egypt and Palestine, and their Ministries of Defense and Foreign Affairs

In a similar statement, Treasurer of (KSR) Jamal Al-Nouri said in a similar statement to (KUNA) that the society decided to undertake the second relief trip due to the popular support the first flight received from Kuwaiti, Gulf and Arab people, and the calls for repeating such experiences.

Minister rejects 15 metres rumors

'Height of model houses stays same'

KUWAIT CITY, April 29: The Minister of State for Municipal Affairs Dr. Noura Al-Mashaan sent an explanatory letter yesterday to the Chairman of the Municipal Council Abdullah Al-Mahri, confirming that the current private and model housing listing will take effect without any change, and that the situation will continue as it is without prejudice to the interests of citizens or discrimination between them.

She emphasized that the height of the private and model housing buildings remains as is currently, which is 18 meters, including the height of the staircase.

The minister denied what is being circulated on social media sites about reducing the height of the building in private and model housing areas to 15 meters.

Meanwhile, six candidates submitted their nomination papers yesterday to the General Elections Administration to register their names in the Municipal Council's by-elections for the sixth (Khaitan) and ninth (Ahmadi) constituencies, which are scheduled to be held on May 18. These candidates are - Atallah Saleh Al-Sawagh, Hussein Al-Hamdan, Jawad Qambar, Fahad Nasser Al-Ajmi, Abdulaziz Hajiya and Mubarak Al-Hajri. The total number of candidates has now reached 16.

PM, UAE minister meet

UAE seeks investment. probes Kuwait market

KUWAIT CITY, April 29: His Highness Sheikh Dr. Mohammad Sabah Al Salem Al-Sabah, Prime Minister of Kuwait, has received His Excellency Dr Thani bin Ahmed Al Zeyoudi, UAE Minister of State for Foreign Trade in Kuwait City. His Excellency was leading a highlevel Emirati delegation to the "UAE Companies Investment Meet", which was designed to identify trade and investment opportunities in the Kuwaiti market.

During the meeting, which was attended by His Excellency Dr Matar Hamed Al Neyadi, UAE Ambassador to Kuwait, His Excellency Al Zeyoudi underscored the positive nature of UAE-Kuwait relations, which reflect the shared determination of both leaderships to catalyze growth and support each other's economic development.

His Excellency Dr Thani Al Zeyoudi welcomed the opportunity to restate the importance of bilateral relations: "The UAE and Kuwait enjoy a long-term economic partnership and this visit is an important opportunity to both restate its value and seek to increase private-sector collaboration in priority sectors. The UAE Companies Investment Meet provides a key platform to build the networks, and identify the opportunities, that can deliver mutually beneficial results in the months and years to

While attending the event, His Excellency Al Zeyoudi also held a meeting with His Excellency Abdullah Hamad Al Jawaan, Kuwait's Minister of Commerce and Industry in the State. They reviewed bilateral trade, which reached AED45 billion in 2023, marking a 2 percent increase compared to 2022 and 16 percent compared to 2021, and agreed to maintain the positive momentum. Kuwait is the UAE's 12th largest trading partner globally, its 10th leading export destination and 6th globally for re-exports.

Trading

The UAE, meanwhile, ranks as Kuwait's second largest trading partner globally, and first in the Arab world. The UAE is currently Kuwait's leading non-oil export destination, accounting for 22% of total global exports, and ranks 3rd in terms of Kuwait's imports.

In terms of investment, the UAE is the 3rd largest investor in Kuwait's economy accounting for 6% of total investments in 2022 at a value of more than AED3.3 billion. In turn, Kuwait is the tenth largest investor in the UAE with a total investment value of AED13.2 billion by the close of 2021

His Excellency Abdullah Al Jawaan welcomed the UAE delegation, and said in a statement that the growth of bilateral trade between the two countries reflected the strength and diversity of the economic relations between the two nations, which continues to evolve. The UAE Companies Investment meet, Al Jawaan noted, will boost bilateral trade ties, facilitate successful investment agreements, and enhance the exchange of ideas and expertise. "Events such as this one will restore the historic role of the private sector in both Kuwait and the UAE as a strong bridge that connect the two broth-

Citizens interests on top: Al-Dahoum

KUWAIT CITY, April 29: MP-elect Bader Al-Dahoum has asked HH the Prime Minister-designate Sheikh Ahmad Al-Abdullah Al-Sabah to consider the election results in forming the new government in order to choose competent ministers who can fulfill the citizens' demands.

He urged the premier-designate to learn from the experience of former prime ministers who lost their popularity upon neglecting the interests of citizens.

He went on to disclose that a colleague has been begging the MPs-elect to support him in the National Assembly speaker election, stating the latter claimed that HH the interim Prime Minister Sheikh Dr. Mohammad Sabah Al-Salim Al-Sabah promised to support him and that he obtained the support of majority of the MPs-elect. He pointed out the decision of Sheikh Dr. Mohammad Sabah Al-Salem to decline the post is clear evidence that his colleague is lying. He added his colleague even vowed that if he is elected speaker, the legislature will not be annulled and political stability will be achieved. He asserted such claims are dangerous as the said MP-elect is linking his occupation of the speaker seat with the verdicts of the Constitutional Court, stressing that stability and reform are possible only if the latter is away from the speaker's seat.

In another development, MP-elect Shuaib Al-Muwaizri warned the leaders of Islamic countries in general, and the Gulf countries in particular, against the approval of treaties presented at the economic forum. He said the treaties presented by the World Health Organization (WHO) are aimed at destroying countries, spreading viruses and diseases, causing massive chaos and undermining the sovereignty of states. He added there is conspiracy in announcing new viruses, imposing total curfew, canceling cash payment, imposing the monitoring of citizens, destroying natural food sources, and causing Moreover, MP-elect Saleh Ashour asked

address issues in his ministry, including the shortage of medicines and implementation of court decisions in favor of many pharma-He also said that the competent employees in the ministry are not given a chance to

Minister of Health Ahmad Al-Awadhi to

be promoted to leadership positions, most of which are occupied by seconded staff from other ministries. He added the Ministry of Public Works paved Road 600 in Wafra two months ago, but

many damaged spots are now seen on the road. He stressed the need for the ministry to ask the concerned contractor to immediately carry out the necessary maintenance works.

On the other hand, MP-elect Abdulhadi Al-Ajmi participated in the gathering organized by the Students Union at Kuwait University, and the academic staff at the university and the Public Authority for Applied Education and Training (PAAET), in solidarity with the teachers' encamping in American universities in protest against the genocide of Palestinians. He affirmed the Kuwaiti position on the Palestinian cause is permanent; and it reflects the vision of the people, government, Assembly and political

Former MP Hamad Al-Matar praised the ongoing protest, indicating "the Zionist lobbyists have kidnapped the American administration." He highlighted the fact that supporting the Palestinian cause is deep-rooted in Kuwait, while urging everyone all over the world support the righteous position of the Palestinians.

MP-elect Mohammad Al-Dousari expressed his pride in attending the gathering as the Palestinian cause is righteous at all levels -political, moral, humanitarian and religious. He affirmed that the people of Kuwait will never disappoint and betray the Palestinians as it happened in some sisterly countries.

Major gap between Kuwait's hospitals, qualified workers

"IT sounds like there's a significant gap between the healthcare infrastructure in Kuwait and the availability of qualified medical personnel to staff these facilities," columnist Dr Saud Mohammad Al-Asfour wrote for Al-Qabas daily.

"This shortage seems to stem from a lack of effective planning and coordination between educational institutions and the healthcare sector. Despite the

construction of hospitals new and efforts to renovate existing ones, the shortage skilled medical professionals remains a pressing





producing graduates with high academic achievements, appear to be insufficient in terms of meeting the demands of the healthcare sector. Additionally, there seems to be a need for greater investment in training programs and opportunities for medical professionals to specialize and further their education, both domestically and through international collaborations.

"Addressing these challenges will likely require a comprehensive approach that involves closer collaboration between educational institutions, healthcare authorities, and government agencies to develop and implement effective strategies for recruiting, training, and retaining qualified medical personnel.

"It seems like there's a need for the Kuwait University to reassess its scholarship programs and infrastructure to better align with the demands of the healthcare sector and the state's plans to expand and improve its healthcare system. Increasing the number of scholarship opportunities for students, both domestically and abroad, could help address the shortage of qualified medical personnel.

"Additionally, investing in the rehabilitation and modernization of existing university facilities, such as Sabah Al-Salem University in Al-Shaddadiya and the new Sheikh Abdullah Al-Salem University, will be crucial for ensuring that students have access to stateof-the-art equipment and facilities that meet international standards.

"This will enable them to receive training and education that aligns with advancements in medical science and technology, ultimately producing graduates who are better equipped to contribute to the healthcare sector in

"By enhancing scholarship programs, upgrading infrastructure, and ensuring that educational offerings are in line with the evolving needs of the healthcare industry, Kuwait University can play a pivotal role in addressing the shortage of qualified medical professionals and supporting the state's efforts to improve its healthcare system.

"It seems there's a concern about the current state of healthcare in Kuwait, particularly regarding the utilization of private hospitals and the "wellness" system. Private hospitals are experiencing similar issues as government hospitals, such as overcrowding and long waiting times, and there's a perception that they are exploiting the "wellness" system, which was originally intended

"This situation is seen as a waste of public resources, especially considering the investment in government hospitals that are now underutilized. The shortage of medical staff in government hospitals and the long wait times for appointments have led citizens to seek care in private hospitals, often at no cost to themselves if they have "well-

ness" benefits. "However, this reliance on private hospitals may exclude those who do not have access to "Afiya" benefits and contribute to commercial exploitation in the healthcare sector.

"There's a need to address the shortcomings in government hospitals to make them more appealing and accessible to the public, thereby reducing the burden on private healthcare facilities and ensuring equitable access to health-

care services for all citizens. "It seems there are concerns about the evolving landscape of private hospitals, particularly in light of the "Afiya" system. While private hospitals have improved their facilities and management, there's a perception that they may prioritize their reputation over addressing shortcomings in care. Patients may feel that certain medical conditions are better treated in government hospitals, especially for childbirth

and minor surgeries. "There's a call to reconsider the overall medical system, including scholarship plans for medical education and the rehabilitation of government hospitals.

"Moreover, there's a need to reassess the "Afiya" system, as it may represent a waste of state funds and lead to commercial manipulation in medical specialties. This includes the unnecessary prescription of medications, which can contribute to inefficiencies in the healthcare system.

Also:

"It seems that Minister of Public Works Dr. Noura Al-Mashaan felt what Kuwaitis were suffering from in their private residences, as the Minister kept the height of private housing at 20 meters," columnist Abdul Mohsen Muhammad Al-Husseini wrote for

Al-Anba daily.

"When we started living in private housing areas, there were conditions for building private houses, including the construction percentage for the plot. These conditions did not allow construction except on the condition of staying away from the neighbor by three meters, and in the facade, a distance of ten meters must be left. These conditions were in the seventies

"One of the conditions was that the building should not exceed two floors, and among the requirements was to stay away from government facilities, such as the power transformer, by fifty

"Today there are houses adjacent to the power transformer, and the house is higher than the roof of the transformer. I hope that Minister Al-Mashaan will tour the private housing areas to see the conditions and consider amending the previous laws and requirements that led to an increase in the problems of private housing due to the lack of parking.

"The amended law allows the construction of more than two floors. Without requiring the provision of parking for each apartment, as is the practice in many sisterly countries, as there are conditions for construction, which is to provide parking for residents.

"I felt very happy with the Minister's interest in what the citizens are suffering... and I hope that Minister Al-Mashaan will continue her efforts so that she can address all the problems that residents of private housing areas

"My attention was drawn to what Mr. Ahmad Al-Sarraf wrote in Al-Qabas newspaper, who in his article a few days ago praised the efforts of Minister Al-Mashaan and her ability to find solutions to the problems that citizens suffer from because of the roads that have multiple potholes in all private residential areas and highways. The state must pay attention to the efforts made by Minister Al-Mishaan to find solutions to treat roads and residential

"Let us salute Minister Al-Mashaan for her sincere efforts in taking all necessary decisions and actions that serve the interests of citizens.

"Cooperate and do not be stubborn We remind our representatives about the Divine Constitution, and that what Allah Almighty and His Noble Messenger said is better than what man wrote in the earthly Constitution by obeying and respecting the ruler. Therefore, they are requested to adhere to the speech of His Highness the Amir -- may Allah protect him -- in the last 10 days of the blessed month of Ramadan," Sheikh Ali Al-Jaber Al-Ahmad wrote for Al-Sevassah daily.

"The most important aspect of the speech is the call to adhere to the provisions and texts of the Constitution. We are fed up with hearing this, yet they do not adhere to the constitutional texts, the first of which is the violation of Article 90, which states it is unconstitutional to convene prior to the opening of the legislative term. This is in addition to calling some people rather than others, and the failure to adhere to the principle of equality and separation of powers, because they bypassed the powers of ministers. They even reached the point of exposing the powers and options of His Highness the Amir in naming the Crown Prince, the Prime Minister and the ministers.

"The most common observation is that scores are settled in most interrogations, instead of interrogation being a tool for the right to monitor the government and to work in the spirit of cooperation, not with the intention of challenging and controlling, in order to reach the desired goals for public good.

'The government works according to what it deems appropriate for a better future based on the financial, political and social information it possesses, its relationship with other countries, its knowledge of the circumstances surrounding it, and its future outlook that protects the country from any emergency, God forbid. Its policy is constant even when its ministers change.

"Meanwhile, the representatives of the National Assembly are in a state of change. Most of them work according to their own point of view. They tickle the feelings of their voters in order to return to the next Assembly at the expense of public interest. There are many examples, the most recent of which is their objection to the legal measure taken by the Ministry of Interior to protect the national identity, although His Highness the Amir, may Allah protect him, stressed the need to strictly apply the law to preserve the Kuwaiti identity and protect it from

tampering.
"Oh guide, oh guide ... Even if it is impossible due to the similarity of character, human nature pushes a person to gain the love of others to increase his knowledge and expand his circle of friends. The rational group calls for this, while the other group makes people turn away, because of their bad behavior and snarling of the tongue. One of them calls the other 'monkey', because he is the enemy of himself due to his excessive nervousness, while losing his tolerance. This type of person is not a desirable companion. We ask Allah for guidance for him and others like him.

"O Allah, protect Kuwait and its people from all forms of evil and harm.'

Outskirts targeted

Massive campaign is on to raze encroachments

KUWAIT CITY, April 29: The Kuwait Municipality launched a massive campaign on Monday to remove the illegal godowns in Salmi, as part of a comprehensive government plan to remove encroachments on state properties and serious violations observed in several locations in the

According to informed sources, the municipality has prepared a time plan to remove encroachments on state properties, which will take three months in several land

sites, including Salmi, Abdali, Al-Mutlaa, Kabad, Barr Al-Sulaibiya, and Amghara, with the cooperation of the Ministry of Interior and the Environment Public Authority.

These illegal reserves had been transformed into mini-factories, warehouses, and random workshops, with some wild sites becoming a hotbed for all kinds of violations, transgressions, and illegal practices.

The sources said, "Some have acquired state lands by surrounding them with various areas and exploiting them in an irregular manner, as if these lands were private estates without a license.'

Meanwhile, Head of the Violations Removal Department in Farwaniya Municipality Fahad Al-Muwaizri affirmed that the field tours resulted in the removal of 85 canopies for encroachments on state property used to rent parking lots, in addition to the removal of 105 iron barriers and chains, adding that necessary measures were taken against

'No living in premises'

Firms violating industrial laws closed down by PAI

KUWAIT CITY, April 29: The Public Authority for Industry has taken action on 11 establishments that were found to be in violation of industrial laws. These violations ranged from operating without proper licenses to incom-

Sources told the Al-Jarida daily that a new list has been issued, warning of closure penalties if the violations are not promptly rectified. Some of the offenses observed included engaging in blacksmithing, marble cutting, and carpentry activities without obtaining industrial licenses, contravening Law No. 56 of 1996 regarding industrial regulations.

The closures were enacted based on violation reports submitted by the Industrial Inspection Department of the Industry Authority, with recommendations from the Permanent Committee for Industrial Violations

It was determined that the violations persisted and would continue until they are remedied. If the violations persist beyond a month from the closure date, stricter penalties will be enforced.

Among the observed violations were instances of workers' housing located in mezzanines of plots up to 500 square meters and the absence of firefighting licenses.

Additionally, an industrial company was warned by the Industry Authority for storing five electricity generators within plot boundaries and housing workers in an area of 500 square meters. The company was given a maximum of one month to rectify the violation, with more severe measures threatened if non-compliance persists.

These closures are part of an ongoing effort by the Industry Authority, following a series of closures earlier in the year due to violations of industrial and regulatory laws. The actions are based on reports from the Industrial Inspection Department and recommendations from the Permanent Committee for Industrial Violations, as discussed in their meetings last March.

Store shut, 23 citations: The Emergency and Rapid Intervention Team at the Kuwait Municipality branch in Hawally Governorate closed a store and recorded 23 violations in its recent inspection campaign, reports Al-Rai daily.


In a press statement, the Public Relations Department at the Municipality disclosed that the team carried out the inspection campaign in Hawally and Salmiya to ensure the shops and markets are strictly complying with the rules and regulations of the Municipality. According to the department, the uncovered violations

include displaying advertisements without a license, opening a store before obtaining a license, utilizing a space not mentioned in the license and displaying goods outside the

Head of the team Ibrahim Al-Sabaan urged the shop owners to fully abide by the rules and regulations in order to avoid penalties such as administrative closure.

Man held for role in 'money-laundering'

Mechanic dies; drugs in accident car

KUWAIT CITY, April 29: The Public Prosecutor has ordered the detention of an expatriate amid accusations of involvement in a significant money laundering case, stemming from allegations, reports Al-Anba daily.

Despite the expatriate's denial of the charges and claims of victimization by a specialized network, his statements hold little weight as he was fully accountable for all banking operations conducted through his accounts prior to the network's involvement.

According to a security source, the Criminal Investigation Department received a notification regarding an expatriate allegedly facilitating money laundering transactions from his account to a network outside Kuwait. Subsequently, security forces apprehended the accused at his resi-

Upon interrogation, the expatriate asserted that he worked as a driver and had accepted an online job offer to promote goods on the internet in order to supplement his income. He admitted to providing all his banking details, including IBAN, account number, and card information, under the impression that his nearly empty account would not be exploited for illicit

In light of this incident, a security source cautioned both citizens and residents against the dangers of indiscriminately sharing banking information with untrustworthy individuals, as it could lead to unwitting involvement in criminal activities.

Emphasizing the principle of accountability, the source underscored that the account holder bears responsibility for all transactions carried out through their ac-

Furthermore, the source highlighted the existence of organized criminal networks that lure individuals with false job opportunities, ultimately ensnaring them in unlawful schemes.

Mechanic dies under car: An unidentified mechanic, believed to be an Asian, died

under the weight of a vehicle he was repairing on the Salmi Road, reports Al-Ânba According to the vehicle owner, the vehicle moved suddenly while the mechanic

was performing the repair work crushing the

man to death under its wheel. When a rescue patrol moved to the site of the incident, the owner of the car told police the car had a breakdown and he had summoned the mechanic to fix it.

A case of accidental death has been registered at Taima Police Station.

Drugs in accident car: A collision between three vehicles on the Sixth Ring Road opposite the Shooting Club resulted in the seizure of 60 narcotic pills, reports Al-Anba In the accident three people were injured

and their vehicles were damaged. A security source said after a report was received by the Operations Department of the Ministry of Interior security patrols were dispatched to the site of the accident and the injured were taken to the nearby hospital.

Upon inspection of the vehicles, securitymen spotted 6 medium-sized bags containing 60 'red and white' pills. The pills were found in the one of the vehicles.

Police investigations are ongoing to determine the source of the pills. The damaged vehicles have been towed to the Sulaibiya

It is worth noting that the total number of plots in the project is 1,448. Meanwhile, the Central Agency for Public Tenders (CAPT) decided to postpone the date for opening the bids submitted for the tender to supply, install and maintain smart water filling card devices as well as install surveillance cameras on the sites for the 26 water filling stations from Sunday, to June 23.

According to informed sources in the Ministry of Electricity, Water and Renewable Energy, the Customer Affairs Sector, through the aforementioned tender, aims to replace the current system in which 26 filling stations operate with another modern one that keeps pace with technological development. A digital technology system will be installed that facilitates water consumption through a specific appli-

cation that will increase safety rates and revenues and reduce water wastage during the filling operations at the same time.

They explained that the sector is currently offering the tender through CAPT. If the bids are opened on the aforementioned date, they will be referred for study and the preparation of the technical recommendation, and then returned to the agency to take the award decision and then begin implementing the agreedupon works in the contract.

Before launching the tender, coordination took place between the customer service sector and the water projects sector, which participated in preparing the aforementioned tender papers and documents. There is a mechanism that leads to compatibility and integration of the tenders presented by it with the system to be installed in order to avoid any malfunctions that may affect the smooth progress of work.

It is worth noting that water filling stations have achieved revenues estimated at KD 6 million during the year 2023. The stations' water is also a strategic alternative in the event of a disaster or a water outage from the network during maintenance operations that occur periodically in all regions, including the border and agricultural areas.

'CSC's haphazard structure hits public sector job nominations'

'Coordinated efforts of several departments vital

KUWAIT CITY, April 29: The nomination of citizens, who registered in the central employment system of the Civil Service Commission (CSC) to apply for public sector jobs, has been delayed due to the haphazard organizational structure of the CSC, reports Al-Anba daily quoting sources.

Sources explained the distribution of departments in the organizational structure of the CSC was done in a random manner; thereby, delaying the documentary cycle for completing the work, in addition to the dispersion of powers that were supposed to be given to one department, sector or official.

Sources said the process of nominating citizens registered in the central employment system requires the coordinated efforts of several departments including the Information Systems Department,

Ranking Department and Selection Department. Sources revealed each director must address the assistant undersecretary who in turn addresses the undersecretary to obtain approval. Sources added that the Budget, Job Title Modification, Manpower Needs, Job Grades and Titles departments are not under the Employment Sector as they are distributed to various other sectors.

Sources also stated that the Job Description Department is under the Administrative Development Sector and the Job Arrangement Department is under the Financial and Administrative Sector, indicating only the Registration and Nomination departments are under the Employment Sector.

They pointed out this dispersion is unhealthy and does not serve the work. For example, the Employment Sector must address four departments under other sectors to create a new job title, sources

Sources disclosed the Job Arrangement Department, which is under the Finance and Administrative Sector, is responsible for approving job titles for new employees and this is supposed to be the responsibility of the Employment Sector.

The Organizing Structures and Job Descriptions departments were merged and put under the Administrative Development Sector, although the Job Descriptions Department's task is to set the terms of reference for the employee's job title in new jobs and this is the responsibility of the Employment Sector, they added.

Sources stressed the need to solve this issue, especially since the Employment Sector is considered the most important sector in the CSC; and the departments entrusted with carrying out its tasks are distributed to other sectors.

Sources went on to say that the Termination of Expatriates' Services Department is under the Employment Sector, even though it is supposed to be under the Legal Affairs Sector, which currently has only two departments -- the Legal Advice and Legislation Department and the Grievances Department; while some sectors have five departments.

KFAS organizes seminar

Seminar showcases advanced structural health monitoring of the 'Al-Hamra Business Tower'

KUWAIT CITY, April 29: Kuwait Foundation for the Advancement of Sciences (KFAS) organized a seminar on "Structural Health Monitoring of Al-Hamra Business in cooperation with Al-Hamra Real Estate Company and the Kuwait Institute for Scientific Research.

The seminar aimed at disseminating the results of a research project funded by KFAS entitled "Ground Motion Modeling and Structural Monitoring of high-rise Buildings" which was implemented at Al Hamra Business Tower by Kuwait Institute for Scientific Research. Devices and sensors were installed in Al Hamra Tower to measure the building's response to the dynamic loads that high-rise buildings are exposed to, due to wind speed and the effects of local and regional seismic activities.

The project is an extension of another funded project, which was also implemented by KISR and Kuwait University in collaboration with Massachusetts Institute of Technology (MIT), where Kuwaiti researchers gained extensive experience and knowledge during its implementation, enabling them to implement the current phase. The project included a high-accuracy computational model for the tower, which was developed and utilized for continuous monitoring of it's structural safety to detect any damages or changes that may arise in the building's structural system.

The seminar was attended by a number of researchers, academics, engineers and architects, and representatives and officials from several relevant entities and institutions, including Kuwait University, Kuwait Institute for Scientific Research, Municipal Council, Ministry of Public Works, Kuwait Municipality, Public Authority for Housing Welfare, Environment Public Authority, in

addition to the private sector. KISR stated that the project is aligned with Kuwait's Developmental Plan aimed at developing and enhancing the resilience of infrastructure projects. The project, funded by KFAS, was carried out in the Sustainabil-

ity and Reliability of Infrastructure (SRI) Program under the Energy and Building Research Center at KISR. The research team developed innovative Structural Health Monitoring (SHM) technology, specifically for infrastructure applications in Kuwait. This technology, successfully implemented in Kuwait's tallest building, the Al-Hamra Business Tower. This is the first time such advanced monitoring technology has been applied in Kuwait, representing a significant step towards developing sustainable smart cities supported by advanced sensor technology and real data. The technology has the potential to transform how infrastructure safety is monitored during extreme events such as earthquakes and sandstorms. The technology provides accurate information about the safety of infrastructure and the areas most affected during emergencies, thereby enabling more efficient and effective responses by gov-ernmental authorities. This technology can be scaled to monitor other critical systems, such as bridges and energy infrastructure throughout Kuwait.

Al Hamra Real Estate Company indicated that Al Hamra Business Tower has become a symbol of innovation and excellence in adopting the highest international architectural standards, as it has won many international awards through its commitment to the development of its infrastructure by applying thorough creative strategies, which include integrating leading technologies such as a solar energy system and a structural health monitoring system to ensure the safety and longevity of the tower.

The facility management is constantly working to protect its facilities as part of its commitment to drive innovation and promote learning in the architectural community. This is why Kuwaitis have one constant question - When will we have a decision? Will we not remain subject to the parliamentary-ministerial wrangling that neither nourishes nor avails against hunger.

The value of Kuwait's current account surplus with respect to goods, services, and income decreased in the past year by 18.13% to 1.58 billion dinars, compared to 1.93 billion dinars in 2022.

This decline in the current account is attributed to a decrease in the merchandise balance surplus, and an increase in the net deficit in the Kuwait's current balance of payments.

In general, the overall position of the Kuwaiti balance of payments turned into a deficit during the year 2023 at a value of 150.2 million dinars, compared to a surplus of 1.13 billion dinars in the previous year.

Speaking at events in Riyadh, Blinken said the best way to ease the humanitarian catastrophe in Gaza would be to conclude an elusive cease-fire agreement that would release hostages held by Hamas. And, he said Hamas had been presented with an "extraordinarily generous" offer by Israel that he hoped the group would accept.

"Hamas has before it a proposal that is extraordinarily, extraordinarily generous on the part of Israel and in this moment the only thing standing between the people of Gaza and ceasefire is Hamas," he said at a World Economic Forum gathering in the Saudi capital.

"They have to decide, and they have to decide quickly. So, we're looking to that and I'm hopeful that they will make the right decision and we can have a fundamental change in the dynamic," Blinken said.

Although talks continue, Hamas has thus far balked at a series of offers negotiated by Egypt, Qatar and the United States and agreed to by Israel, and even without a deal, Blinken said it was critical to improve conditions in Gaza now.

"We're also not waiting on a cease-fire to take the necessary steps to meet the needs of civilians in Gaza," Blinken told Gulf Cooperation Council foreign ministers earlier Monday.

"We have seen measurable progress in the last few weeks, including the opening of new crossings and increased volume of aid delivery to Gaza and within Gaza, and the building of the U.S. maritime corridor, which will open in the coming weeks. But it is not enough. We still need to get more aid in and around Gaza," he said.

"We need to improve deconfliction with humanitarian assistance workers. And we have to find greater efficiency and greater safety and deconfliction is at the heart of that. And, finally we have to make sure that we're focusing not just on inputs, but on impact."

Scores of relief workers have been killed since the conflict began, and a deadly Israeli attack on a World Central Kitchen aid convoy in Gaza this month only highlighted the dangers and difficulties of protecting them. Israel has said the strike was a mistake and has disciplined officials involved.

He added that the conference under the slogan (management pace modern technology) tackles the potential of technologies in various fields in the sector for effective water management and to devote the uses of modern technology to achieve the desired goals, strengthen the water sector and protect its fresh source.

For his part, Chairman of the Board of Directors of the Gulf Water Science and Technology Society Engineer Abdulrahman Al-Mahmoud mentioned in his speech the importance of technology in enhancing the sustainability of the water sector, pointing to the leadership of the GCC in keeping pace with technological developments in water production, quality, transportation, distribution, or rationalization.

The President of the Arab Water Council, Dr Mahmoud Abu Zaid expressed his hope that this conference will be an opportunity to exchange opinions, ideas and experiences to reach the desired goal, especially since the conference's topics generally address the development of water conservation and improve its quality.

For his part, Dr. Hamo Al-Omrani, member of the United Nations Economic and Social Commission for Western Asia (ESCWA) said that the issue of water is one of the important topics in the region and water security has become a priority.

KU expert analyzes ministerial jurisdiction in urgent matters

KUWAIT CITY, April 29: Constitutional expert Dr. Muhammad Al-Faili from Kuwait University's Faculty of Law highlighted that ministerial jurisdiction during the handling of urgent matters typically includes the authority to initiate investigations, as prescribed by relevant laws and regulations.

Delving into a study for Al-Jarida, titled 'A commentary on the fatwa department's opinion regarding the minister of youth's authority to investigate the director of the youth authority during urgent matters', Al-Faili noted the unique nature of the issue necessitating consultation with the "Fatwa and Legislation" department.

Specifically, he addressed concerns about the minister of sports potentially facing political accountability during urgent matters, which, constitutionally, is not feasible since the ministers resign collectively.

The study scrutinizes the definition of "urgent matters" within Kuwait's context, emphasizing its criticality due to government resignations and the extended duration of forming new administrations.

During such transitional phases, the responsibility for governance falls to interim authorities handling urgent matters. Notably, the lack of established literature defining urgent matters underscores the significance of the Fatwa and Legislation Department's opinion, serving as a benchmark issued by the government's legal advisor.

The study dissects the opinion request submitted by the Deputy Prime Minister and Minister of State for Cabinet Affairs, focusing on whether the suspension and investigation of the director of the Public Authority for Sports by the minister of State

for Youth Affairs during urgent matters aligns with legal frameworks.

The Fatwa Department's response discerns between decisions made out of necessity, those pertaining to regular public service operations, and those with political implications, emphasizing that ministers handling urgent matters cannot be held politically accountable due to their resigned status.

In its analysis, the study reflects on the methodological approach adopted by the Fatwa Department, highlighting potential ramifications on political responsibility and the need for legal clarity.

It questions the jurisdictional oversight of the Deputy Prime Minister and Minister of State for Cabinet Affairs, particularly concerning coordination between ministries and the scope of urgent matters vis-à-vis ordinary governance functions.

Furthermore, it delves into the relationship between urgent matters and political accountability, stressing the need for a nuanced understanding of ministerial actions within legal frameworks

ministerial actions within legal frameworks.

The study suggests that the Fatwa Department's interpretation may have implications for government powers during transitional phases, emphasizing the importance of judicial oversight for resolving disputes definitively.

In conclusion, the study underscores the significance of the Fatwa and Legislation Department's opinion in navigating complex legal terrain during transitional governance phases. It advocates for deeper contemplation and potential judicial intervention to establish binding legal precedents for future administrations and jurisprudence.

Sánchez stays in office

Scottish 1st minister Humza Yousaf quits

LONDON, April 29, (AP): Scotland's first minister, Humza Yousaf, resigned on Monday rather than face a no-confidence vote just days after he torpedoed a coalition with the Green Party by ditching a target for fighting climate change.

Yousaf, whose Scottish National Party has been weakened by a campaign finance scandal and divisions over transgender rights, stepped down after failing to strike a deal with a breakaway nationalist party whose single seat could have given him a majority in Scotland's devolved regional parliament.

With no prospect of victory, Yousaf quit rather than face defeat later this week when Scottish lawmakers were scheduled to vote on motions of no confidence in Yousaf and his government



"After spending the week-end reflecting on what is best for my party, for the government and for the country I lead, I've concluded that repairing our relationship across the political divide can only be done with someone else at the helm," he told reporters. "I have therefore informed the SNP's national secretary of my intention to stand down as party leader.'

The debacle in Scotland adds to the fevered political climate in the broader United Kingdom, where concerns about immigration, health care and government spending have undermined support for the ruling Conservative Party.

The Conservatives and the opposition Labour Party had proposed separate no-confidence motions as they sought to weaken the SNP before a UK-wide parliamentary election expected to take place later this year. The SNP has been the dominant party in Scottish politics for almost two decades and currently holds 43 of the country's 59 seats in the UK parliament.

Spain PM to remain in office: Spanish Prime Minister Pedro Sánchez on Monday ended days of specu-

ister Pedro Sánchez on Monday ended days of speculation about his future by saying he will continue in office "with even more strength."

Sánchez shocked his country last Wednesday by taking five days off to think about his future, following the decision by a court to open preliminary proceedings against his wife on corruption allegations.

"I have decided to continue on with even more strength at the below of the government of Spain." he

strength at the helm of the government of Spain," he said in a televised speech after informing King Felipe VI of the decision earlier Monday.

His resignation would have deprived Europe of its longest-serving Socialist prime minister currently in charge of a major European Union country right before European elections in June.

'Putin likely didn't order Navalny's death': US intelligence officials have determined that Russian President Vladimir Putin likely didn't order the death of imprisoned opposition leader Alexei Navalny in February, according to an official familiar with the

While US officials believe Putin was ultimately responsible for the death of Navalny, who endured brutal conditions during his confinement, the intelligence community has found "no smoking gun" that Putin was aware of the timing of Navalny's death - which came soon before the Russian president's reelection or directly ordered it, according to the official.

The official spoke on the condition of anonymity to discuss the sensitive matter.

Soon after Navalny's death, US President Joe Biden said Putin was ultimately responsible but did not accuse the Russian president of directly ordering it.

7 dead in police checkpoint attack: A group of militants attacked a police checkpoint in Russia's North Caucasus region, killing two officers, officials said Monday.

Four other officers were wounded and all five attackers were killed in the shootout in the Karachay-Cherkessia region late Sunday, according to the regional branch of Russia's Interior Ministry.

The Investigative Committee, the country's top state criminal investigation agency, said the same gunmen had raided another police checkpoint in the region a week before, killing two police and injuring another. It didn't describe the attackers' affiliation or motive.

Two Russian journalists jailed: Two Russian journalists were arrested by their government on "extremism" charges and ordered by courts there on Saturday to remain in custody pending investigation and trial on accusations of working for a group founded by the late

Russian opposition politician Alexei Navalny. Konstantin Gabov and Sergey Karelin both denied the charges for which they will be detained for a minimum of two months before any trials begin. Each faces a minimum of two years in prison and a maximum of six years for alleged "participation in an extremist organization," according to Russian courts.

They are just the latest journalists arrested amid a Russian government crackdown on dissent and independent media that intensified after its full-scale invasion of Ukraine more than two years ago.

1 migrant dies, 25 rescued in Greece: Authorities on the Greek island of Samos said Monday that a migrant died and 25 others were rescued from a sinking dinghy that had left the nearby coast of Turkey.

A search and rescue operation was launched, assisted by the European border protection agency, Frontex, for others possibly missing, officials said.

The coast guard said it responded to a distress call on Sunday. Twenty-three people were rescued from the sinking vessel while two others were pulled from the water. A third man found unresponsive was later pronounced dead at a hospital.

Convicted ex-officials freed: A court in Athens convicted five former senior firefighting and disaster response officials on Monday, over a 2018 wildfire outside the capital that killed more than 100 people. The fire that swept through the seaside town of

Mati, east of Athens, was the deadliest in the country's history. Residents and vacationers, many trapped in their cars, were killed as they tried to escape.

The officials, including a former fire chief, received sentences of between 15 and 111 years for multiple counts of criminal negligence resulting in injury and loss of life. But the presiding judge ordered that sentences could be served concurrently, capping jail time at five years.

Oklahoma towns hard hit by tornadoes begin cleanup after 4 killed in weekend storms

Small towns in Oklahoma began a long cleanup Monday after tornadoes flattened homes and buildings and killed four people, including an infant, widening a destructive outbreak of severe weather across the middle of the US.

Punishing storms that began late Saturday in

Oklahoma injured at least 100 people, damaged a rural hospital, washed out roads and knocked out power to more than 40,000 customers at one point, state officials said. Tornadoes on Friday in Iowa and Nebraska also caused wide destruction and were blamed for one death.

The destruction was extensive in Sulphur, a town of about 5,000 people south of Oklahoma City, where a tornado crumpled many downtown buildings, tossed cars and buses and sheared the roofs off houses across a 15-block radius.

Suspect killed in standoff: Three Louisiana police officers were wounded by gunfire Sunday in a standoff with a man who was later killed by a police sharpshooter, authorities and news reports

Sheriff Joseph Lopinto said a sniper from the Jefferson Parish Sheriff's Office shot and killed the suspect at a house in Kenner where he had held off police and fired shots at law enforcement authorities after shooting three officers who tried to enter the home, WGNO-TV reported.

The injured officers were taken to a hospital after being shot Sunday morning in Kenner, about 15 miles (25 kilometers) west of New Orleans, Kenner Police Chief Keith Conley said. (AP)

Runner dies: A runner in the St. Jude Rock 'n' Roll Running Series in Nashville on Saturday has died after receiving emergency treatment at the race, organizers said Sunday.

The Rock 'n' Roll Running Series said the runner received urgent medical attention by an on-site team before being transported to a hospital, where the participant died. Organizers did not immediately release the identity of the runner.

"We appreciate the medical personnel who worked quickly to support the participant," the statement from organizers said. "We share our greatest sympathies with the family and friends of the race participant, and we will continue to offer them our support as they go through this very difficult time."

The race events that took place Saturday included marathon, half-marathon, 10K and 5K distances. More than 23,000 runners were registered for the weekend's races. (AP)

Biden tries humor on campaign trail

WASHINGTON, April 29, (AP): US President Joe Biden is out to win votes by scoring some laughs at the expense of Donald Trump, unleashing mockery with the goal of getting under the former president's thin skin and remind-

ing the country of his blunders. Like a comic honing his routine, the Democratic president has been testing and expanding his jokes over the past few weeks. It started with jabs about his Republican opponent's financial problems, and now Biden regularly pokes fun at Trump's coiffed hair, his pampered upbringing.

Modern

The jokes are the latest attempt to crack the code on how to clap back at Trump, whose own insult comedy schtick has redrawn the boundaries of what is acceptable in modern politics. Few have had much luck, whether they try to take the high road or get down and dirty with Trump, the presumptive Republican nominee for president.

"This is a constant challenge," said Eric Schultz, a senior adviser to former President Barack Obama. Trump is "not someone who plays by the rules. So it's up to Biden to figure out how to adapt and play by new rules of engage-

So far, Biden has been trying to thread a delicate needle to boost his chances of a second term. He uses humor to paint Trump as a buffoon unworthy of the Oval Office, but the president stops short of turning the election into a laughing matter.

Sometimes he finds that a few jokes can energize an audience even more than a major policy victory and draw precious attention away from an opponent who otherwise commands the spotlight even while stuck in a New York courtroom for his first criminal The latest example came at the

Republicans seeking congressional seat debate 'limits' on immigration

ATLANTA, April 29, (AP): Brian Jack sought to make a Sunday debate among Republican candidates for an open Georgia congressional seat all about his close ties to former president Donald Trump, while the other contenders ignored Trump's endorsement of

Five Republicans running for their party's nomination in Georgia's 3rd Congressional District met in an Atlanta Press Club debate. Besides Jack, who was Trump's political director during his administration and worked for then-US House Speaker Kevin McCarthy, they included former state senators Mike Crane and Mike Dugan, former state Rep. Philip Singleton and party activist Jim Bennett.

They're seeking to replace Republican US Rep Drew Ferguson, who is stepping down. The district hugs the Alabama border from Carrollton to Columbus and swings east into the Atlanta suburbs of Newnan and Peachtree City.

Jack repeatedly referenced his work in the Trump administration, promising that in Congress he would continue that work. All of the candidates, in a show

of hands, said they believed Trump was the rightful winner of Georgia's 16 electoral votes in 2020, despite no reliable evidence to contradict Democrat Joe Biden's win.

All of the candidates voiced support for more restrictions on immigration, with several including Jack saying they support mass deportations of people who have entered the country illegally. Jack said he would have voted against the recent foreign aid package to Ukraine, Israel and others until he was satisfied on border security.

Togo voters head to polls: Togolese voters headed to the polls on Monday to vote in the country's par-liamentary elections, which will test support for a proposed new constitution that would scrap future presidential elections and give lawmakers the power to choose the president instead.

The opposition and the clergy say the legislation is an effort by President Faure Gnassingbe to prolong his rule. It was passed by lawmakers in late March and is close to being enacted.

Authorities have cracked down on civic and media freedoms ahead of the vote. In early April, the government banned protests against the proposed new constitution and the arrest of opposition figures.

In mid-April, a French journalist who arrived in Togo to cover the elections was arrested, assaulted and expelled. Togo's media regulator subsequently suspended the accreditation process for foreign jour-

The electoral commission has also banned the Catholic Church from deploying election observers to monitor the process.

'88,000 displaced in Somalia': The United Nations High Commissioner for Refugees (UNHCR) said on Sunday that about 88,000 people were internally displaced in Somalia in the first three months of

The UNHCR said the displacement was mainly caused by conflict or insecurity and the long-term effects of flooding, which occurred between October and December 2023.

"Clan conflicts and political differences within the federal member states (FMS) as well as between the Somali government and the FMS further threaten the fragile security situation," the UNHCR said in its latest update released in Mogadishu, the capital of So-

The UN refugee agency noted that the security situation in the country remains tense, with ongoing military operations to reclaim territory from al-Shabab, which has been responsible for multiple indiscriminate attacks, often causing harm to ordi-

The indiscriminate reprisal attacks against the nonstate armed group have resulted in the deaths and displacement of innocent bystanders, the UNHCR said.

SAfrica puts in place measures: The South African government on Sunday assured its citizens that the upcoming national and provincial elections will be conducted in a safe and secure environment, with just one month to go before South African voters head to the polls.

'As the government, we want to issue a stern warning to anyone with the intention of disrupting the elections that law enforcement officers will deal with them decisively and put them behind bars," Minister of Defense and Military Veterans Thandi Modise said in Pretoria, South Africa's administrative capital, while briefing the media on crime prevention and security preparedness for the elections.

Modise said they will rely on coordinated and intelligence-led planning and operations before, during, and after the elections.

'We have put measures in place to protect all public facilities that will be used for voting, including national key points and other essential infrastructure that might be targeted by criminal elements.'

Even Gálvez, Sheinbaum's most serious competitor, stressed that she, too, would maintain the popular, but costly programs if elected. The former senator and tech entrepreneur reminded voters that she knew poverty growing up and was able advance in part because of a scholarship.

"I am a woman who comes from below, who knows poverty and knows how poverty hurts and the time that it steals from you," Gálvez said. (AP)

BOGOR, Indonesia, April 29, (AP): Singaporean Prime Minister Lee Hsien Loong and Indonesian President Joko Widodo on Monday celebrated the countries' continued cooperation at their seventh and final Leaders' Retreat in Jakarta, an annual meeting between the two Southeast Asian leaders that was also attended this year by their successors.

Lee's visit to Indonesia is one of his last working trips before he hands over the reins of his administration to a new leader. The eldest son of Singaporean founding father Lee Kuan Yew announced his resignation earlier this month after two decades at the helm. His deputy prime minister and finance minister, Lawrence Wong, will succeed him in May.

Widodo, Indonesia's first president from outside the traditional Jakarta elite who is widely known by the nickname Jokowi, will be succeeded by Prabowo Subianto, who takes office in October.

All four top officials met Monday at the colonial-style Presidential Palace in Bogor just outside Jakarta retreat became a passing of the guard for both countries.

"I'm glad that President Jokowi and I are handing over the bilateral relationship in good state to our successors," Lee said at a joint news conference with Widodo after the meeting. "I have every confidence that Mr. Prabowo and DPM Lawrence will continue to bring the relationship to greater heights."

Xi to visit France, Serbia & Hungary as **China appears to seek role in Ukraine**

BEIJING, China, April 29, (AP): Chinese President Xi Jinping will visit France, Serbia and Hungary next week as Beijing appears to seek a larger role in the conflict between Business and the conflict between Business and the conflict between the conflict betwee tween Russia and Ukraine that has upended global political and economic security.

The visit by Xi, China's president and head of the ruling Communist Party, is his first to Europe in five years and will "inject new momentum to the peaceful development of the world," Foreign Ministry spokesperson Lin Jian said at a daily briefing on Monday.

China claims neutrality in the Ukraine conflict, but Xi and Russian President Vladimir Putin declared their governments had a "no limits friendship" before Moscow's February 2022 attack on Ukraine. China has refused to call the Russian assault an invasion and has been accused of bolstering Russia's financial and technological ability to continue producing weapons for use against Ukraine, which

is awaiting tens of billions of dollars in military aid to counter Russia's aggression.

The Foreign Ministry said Xi's visits will begin April 5 and end April 10 but gave no further details.

Teens plotted to buy guns: Four teenagers plotted to buy guns and attack people days after a bishop was stabbed in a Sydney church, according to police documents cit-

ed in news reports on Monday. Five teens, aged 14 to 17, were charged in a Sydney court on Thursday last week with a range of offenses including conspiring to engage in or planning a terrorist act.

Police alleged they all "adhered to a religiously motivated, violent extremist ideology" and were part of a network that included a 16-year-old boy charged with stabbing Assyrian Orthodox Bishop Mar Mari Emmanuel on April 15 as a church service was being streamed online.

The meeting was their first since Yoon took office in 2022 after defeating Lee in the country's closest presidential election. During their 2022 campaigns, Yoon, Lee and their supporters demonized each other and filed dozens of lawsuits against one another.

Yoon proposed the meeting as he faces growing calls to cooperate with Lee's Democratic Party, whose victory in the April 10 parliamentary election allows it to extend its control of the single-chamber National Assembly until after Yoon's single five-year term ends in 2027.

In his lengthy opening remarks, Lee said the election results mean "the people's stern demand for correcting wrong government administrations, addressing economic troubles and restoring democratic rules.

Lee urged Yoon to accept independent probes into the 2022 Halloween crush in Seoul that killed 159 people, and the 2023 death of a marine who drowned during a search-and-rescue for flood victims.

Global 'sovereign wealth' funds reach \$12.7 trillion

Kuwait's sovereign fund vital amid economic challenges

KUWAIT CITY, April 29: According to the latest data from the Sovereign Wealth Fund Institute in April 2024, the total value of sovereign funds worldwide reached approximately \$12.7 trillion, up from about \$11.9 trillion in the same period last year, reports Al-Qabas daily.

The top 10 largest funds accounted for around \$9.2 trillion, representing approximately 72.7% of the total. Among the Gulf countries, the largest sovereign funds belong to the Abu Dhabi Investment Authority, Saudi Arabia, Kuwait, and Qatar.

These sovereign funds play a crucial role in supporting economies that have achieved sustainability in their public finances or are actively pursuing that goal.

However, Kuwait is facing economic challenges and must focus on preserving and developing its sovereign fund. Unlike other Gulf countries, Kuwait is considering distributing its fund's revenues to address public finance issues and promote economic sustainability.

Regarding the Kuwaiti economy, growth expectations for the region have decreased from 3.6% to 2.4% for the year 2024. Kuwait's economy has been particularly affected, with growth expectations shifting from positive to negative.

This decline is attributed to geopolitical tensions and internal political factors. However, there are doubts about the accuracy of these projections due to deficiencies in national statistics and public administration.

Global energy prices fell across the board during March-2024 led by a notable decrease in gas consumption in the EU. The decline reflected lower heating demand driven by unusually warmerthan-expected winter in most of the EU countries. This caused Asian and European natural gas spot prices to decline to the lowest level since the Russia-Ukraine conflict during Q1-2024.

Overall, the World Bank's Natural Gas Index recorded 35.7% y-o-y decline during Q1-2024 to close March-2024 at 68.1 points. The World Bank's monthly average European natural gas price recorded 38.1% y-o-y decline to average 8.55 USD/MMBtu during March-2024 while the World Bank's US monthly average gas price witnessed a 34.9% y-o-y drop to an average of 1.5 USD/MMBtu during the month. In terms of East Asian LNG prices, the World Bank's liquified average price for Japan recorded 24.8% y-o-y decline to reach 13.54 USD/MMBtu during March-2024.

According to the IEA, natural gas prices are expected to recover during 2024 and improve by 2.3% during the year driven by expected growth in demand primarily from the industrial power sectors of energy hungry fast-growing economies in Asia coupled with higher demand from residential and commercial sectors. Moreover, geopolitical tensions such as the Russia-Ukraine conflict, the war on Gaza and the stoppage of LNG transport across the Red Sea since the beginning of the year pose greater risk to the short-term outlook of the commodity during the year and might put an upward pressure on the current sluggish prices. It was a similar story in the Asian markets where unusually mild winter coincided with improving supply fundamentals during the winter season of 2023/24. On the other hand, the Asian markets witnessed a combination of higher LNG production in Asia as well as higher-than-expected piped natural gas deliveries to China, which brought downward pressure on Asian natural gas spot prices. Similarly in the US, the downward pressure on natural gas was brought in by a combination of ongoing increase in gas production and weak demand. Geopolitical tensions such as the Russia-Ukraine conflict have already disrupted natural gas markets and it took two years for the global gas markets to recalibrate and stabilize. However, new conflicts and current geopolitical tensions might limit growth of natural gas consumption in 2024, according to the IEA

Growth in LNG demand in key markets in Asia and Europe is expected to be restricted by limited global LNG supply. In its latest Gas Market Report Q2-2024, the IEA penciled LNG growth to average 3% in 2024. According to the IEA, natural gas demand in Asia increased 6% y-o-y or 25 bcm during the period between the October-2023 till March-2024 period. China was the main driver on the growth in natural gas consumption as the country witnessed 9% y-o-y growth in its gas consumption during the same period.


According to the latest Monthly Gas Report from GECF, natural gas demand in China improved 10% y-o-y to reach 34 bcm in Feb-2024. The growth in China's gas consump-

tion was mainly driven by the renewal of economic activities in the country. In context, electricity generation from natural gas in China increased by 14% y-o-y during Feb-2024 while total electricity production increased 10% y-o-y during the month. In terms of power mix for electricity generation in China, coal remained the largest fuel representing 65% of usage in China followed by renewables (19%), hydro (9%), nuclear (4%) and natural gas (3%). Similarly, natural gas consumption in Japan witnessed 10% y-o-y growth to reach 8.7 bcm in March-2024. The monthly growth in Japan's gas consumption was attributed to growing demand in the power generation sector due to cold weather. Japan's power sector witnessed 12% y-o-y increase in natural gas consumption which reached 4.6 bcm during March-2024.

The trend of monthly gas consumption growth was even stronger in other Asian countries such as South Korea and India. In February-2024, natural gas consumption in India jumped 25% y-o-y to 5.6 bcm registering its 14th consecutive month of y-o-y growth in natural gas consumption. India's monthly growth in gas consumption was mainly driven by energy demand growth in the power generation, petrochemical, and refinery sectors. Comparatively, natural gas consumption in South Korea, another major natural gas importer, increased 11% y-o-y in March-2024. Th growth was fueled by increased demand in the power generation sector as well as city gas sectors.

Natural gas demand in the OECD Europe region recorded a 1% y-o-y decline during the 2023/24 heating season, according to the IEA. The dip in European gas consumption was attributed to a combination of developments impacting natural gas consumption in the region including strong expansion of renewable and nuclear energy consumption. Comparatively, natural gas consumption in the Eurasia region witnessed 4% y-o-y growth during the 2023/2024 heating period. Natural gas consumption in the EU fell 9% y-o-y during March-2024 mainly due to less energy demand for heating. According to latest report by GECF, gas power generation in the EU recorded 15% y-o-y drop during March-2024 while electricity generation in the block recorded relatively modest decline of 2.7% y-o-y during the month. German natural gas consumption fell 10% y-oy to 7.4 bcm during March-2024. This significant drop in gas consumption in Europe's largest economy was mainly due to the fact that Germany witnessed the warmest March ever recorded in in the country with average temperature being 7.4 degree Celsius or 2.8 degrees above the normal temperature. Moreover, Italy's natural gas consumption declined by 6% y-o-y to 5.7 bcm while gas consumption in France fell 13% y-o-y 3.3 bcm during March-2024. Natural gas consumption in North America remained flat during the 2023/24 winter heating season, according to the IEA. Despite growth in gas-fired power generation, a steep decline in demand in the residential and commercial sectors due to mild winter weather was enough to offset that growth.

According to the GECF, total natural gas consumption in the US declined by 4.5% y-o-y to 80 bcm during March-2024. In context, natural gas consumption in US residential and commercial sectors dropped by 15% and 16 y-o-y, respectively. On the other hand, the US power gen-



eration sector maintained its natural gas consumption during March-2024 mainly due to the ongoing coal to natural gas switch in the sector.

The global LNG market trade remained strong during the 2023/24 heating period. There have been several liquefication projects that came online during the past year (2023) which have greatly supported in meeting the global growing demand for LNG. Global aggregate traded volumes for LNG increased by 3% y-o-y over the October-203 till March-2024 period. However, LNG imports in certain regions of the globe fell during 2023/24 heating period. OECD Europe's primary natural gas supply declined by an estimated 4% (or 10 bcm) y-o-y over the 2023/24 heating season, on the back of combination of lower natural gas demand and high storage levels. According to the IEA, LNG imports in Europe fell 12% y-o-y or 11.5 bcm during 2023/24.

In its latest short-term energy outlook, the EIA forecasted

that US natural gas consumption would remain stable at 104 bcf/d (2.94 bcm/d) in 2024 reflecting an overall expected consumption stabilization in the country. The EIA also estimates that US natural gas marketed production to reach 90 bcf/d (2.55 bcm/d) in 2024 witnessing an increase of 1.1% from 2023 to 2024. In terms of sectors, the EIA forecasts that the US natural gas share of electricity generation to remain at 42% in 2024 and then witness a marginal drop to 41% in 2025. In terms of natural gas prices in the US, the EIA forecasts the Henry Hub natural gas spot price to average at around USD 2.20/MMBtu during 2024 and then

increase to USD 2.90/MMBtu in 2025 due to expected rise in demand for LNG exports which is forecasted to reach an annual record in 2025. In terms of US LNG exports in 2024, the EIA expects US (LNG) exports to average 12 Bcf/d (0.34 bcm/d) in 2024, recording a 2% increase compared with 2023. Furthermore, US LNG exports are expected to increase by a further 2 Bcf/d (0.06 bcm/d) or 18% in 2025; due to the additional LNG export capacity that is expected to be afforded by three of the five LNG export projects currently under construction which are expected to start operations and increase up to full production.

In the GCC, Qatar has announced another expansion of its LNG capacity during Q1-2024. QatarEnergy has announced its third phase of LNG expansion during February-2024 which is expected to add 16 million tons of LNG per annum. The additional capacity is expected to increase Qatar's overall capacity to 142 million tons per annum by 2030. In context, Qatar has been working on to increase its LNG expansion capacity for the last six years and there have been notable projects previously unveiled by the country including the 127 million tons per annum project expected to be completed by 2027. Moreover, Qatar has been positioning itself to take advantage of Europe's growing demand for LNG to replace the continents Russian natural gas supply. According to Bloomberg, Qatari LNG will be reserved in the UK's giant new LNG tank from the middle of next year. Reserving capacity in the UK is a strategic move for Qatar as it would make it easier for the GCC country to send volumes of LNG to the UK, store them and

Saudi Arabia's non-oil growth to be broadly steady in 2024

Non-oil economic growth decelerated in 2023 though remained robust at 3.8% (private sector +4.4%) as consumption expenditure proved resilient. We project non-oil growth to be broadly steady in 2024 (+3.7%) then potentially accelerate in 2025 helped by lower interest rates. Budget deficits in 2024-2025 should be limited given higher dividends from Aramco and a modest rise in government spending. The main upside risk is higher-than-forecast oil production in 2024-2025 while the major downside risk is a weaker-than-expected non-oil expansion that may be triggered by the projected deceleration in government spending growth and/or pressure from ongoing elevated interest rates.

Non-oil private sector growth to accelerate in 2025

Despite higher interest rates, non-oil economic growth remained robust in 2023, softening to 3.8% from 5.3% in 2022. The private sector continued to be the growth driver, although its expansion moderated to 4.4% in 2023 from a strong 5.6% in 2022. Sector-wise, trade, restaurants, and hotels contributed the most to GDP growth, expanding by 7% in 2023, supported by the strong focus on boosting tourism, both inbound as well as domestic. In terms of expenditure on GDP, private-sector investment continued to be the fastest growing, although it decelerated sharply to 6.2% in 2023 from a very strong 22% average in 2021-2022.

We expect the constructive macroeconomic dynamics to be sustained in 2024 and potentially accelerate in 2025 as the impact of lower interest rates starts to kick in. Consumer spending remains resilient, with the value of POS transactions up around 10% y/y through mid-April, in line with the increase recorded in 2023. Despite ongoing tight liquidity in the banking sector, credit growth (+11% y/y through February) remains buoyant, even showing signs of strengthening in the first months of 2024, driven by corporate credit (+15%). The PMI continues to be favorable (averaging 56.5 in Q1), and while it hit a recent low in January, has improved driven by the important sub-indices of output and new orders. We forecast the nonoil sector to grow by a broadly steady 3.7% in 2024 and then by 4.2% in 2025, driven by private sector gains of 4.5% and 5%, respectively.

This positive outlook is supported by the government's effective policymaking and the upgrade to the projected spending levels for 2024-2025 in the latest budget. There are challenges along the way, however. For example, given that government spending

soared by an average of 12% in each of the past two years, the spending intensity is set to slow in 2024-2025, which could weigh on non-oil activity. In addition, given some stalling in the US disinflation progress so far this year, the cut in interest rates is being pushed out to late 2024, keeping Saudi interbank rates, and hence the cost of borrowing elevated, which is not supportive for non-oil activity this year. Consequently, the tailwind of lower interest rates (Saudi policy rates usually move together with US rates) will be mostly a story for 2025. Another key metric to monitor is foreign direct investment (given that higher investment levels are crucial to achieve Vision 2030 targets), which, after rising strongly in 2021-2022, dropped in 2023 to stand at 1.8% of GDP compared with a 5.7% target for 2030.

As for the oil sector, growth was negative in 2023 (-9%) given the production cuts, which deepened around the middle of that year. Given our house view on oil market dynamics, Saudi oil production is expected to remain at current levels throughout 2024 and increase only gradually next year, translating into oil GDP growth of -5.2% and +3.7%, respectively. However, KSA will likely continue to take a very proactive and nimble role in managing global oil supply, which could result in a steep deviation from our oil production assumptions for 2024-2025. All in all, total GDP is forecast to increase by a limited 1.2% in 2024, pressured by the oil sector, then grow by a stronger 4.2% in 2025 as oil GDP growth turns positive and non-oil growth strengthens.

Inflation to soften further; unemployment at a record low

Inflation (which remained relatively low, driven by subsidies, price caps, and strong competition) continued to soften, standing at 1.6% y/y through March, with housing rentals (+10.5% y/y) almost the sole driver of price pressures over the past year. Despite ongoing hot housing rentals, we project average inflation to continue softening, standing at 1.8% and 2% in 2024-2025, down from 2.3% in 2023. Solid non-oil growth and ongoing Saudization initiatives dropped the unemployment rate among Saudis to an all-time low of 7.7% at the end of 2023, down from 8% one year before, and a stone's throw from the 7% target set for 2030.

Manageable fiscal deficits; higher oil GDP upside risk

An 11% increase in spending in 2023, a 12% drop in oil revenues but a 11% rise in non-oil revenues resulted in a fiscal deficit of 2% of GDP. We project limited deficits of 1.7%-2% of GDP in 2024-2025, as government spending (which will likely continue to exceed budget) rises modestly, oil revenues increase on higher dividends from Aramco, and non-oil revenues continue growing, fueled by an expanding non-oil sector.

Dubai plans to move its busy int'l airport

DUBAI, April 29, (AP): Dubai International Airport, the world's busiest for international travel, will move its operations to the city-state's second, sprawling airfield in its southern desert reaches "within the next 10 years" in a project worth nearly \$35 billion, its ruler said Sunday.

Sheikh Mohammed bin Rashid Al Maktoum's announcement marks the latest chapter in the rebound of its long-haul carrier Emirates after the coronavirus pandemic grounded international travel. Plans have been on the books for years to move the operations of the airport known as DXB to Al Maktoum International Airport at Dubai World Central which had also been delayed by the repercussions of the sheikhdom's 2009 economic crisis.

"We are building a new project for future generations, ensuring continuous and stable development for our children and their children in turn," Sheikh Mohammed said in an online statement. "Dubai will be the world's airport, its port, its urban hub and its new global center."

The announcement included computer-rendered images of curving, white terminal reminiscent of the traditional Bedouin tents of the Arabian Peninsula. The airport will include five parallel runways and 400 aircraft gates, the announcement said. The airport now has just two runways, like Dubai International Airport.

The financial health of the carrier Emirates has served as a barometer for the aviation industry worldwide and the wider economic health of this city-state. Dubai and the airline rebounded quickly from the pandemic by pushing forward with tourism even as some countries more slowly came out of their pandemic crouch.

The number of passengers flying through DXB surged last year beyond its total for 2019 with 86.9 million passengers. Its 2019 annual traffic was 86.3 million passengers. The airport had 89.1 million passengers in 2018 - its busiest-ever year before the pandemic, while 66 million passengers passed through in 2022.

Earlier in February, Dubai announced its best-ever tourism numbers, saying it hosted 17.15 million international overnight visitors in 2023. Average hotel occupancy stood at around 77%. Its boom-and-bust real estate market remains on a hot streak, nearing all-time high valuations.

But as those passenger numbers skyrocketed, it again put new pressure on the capacity of DXB, which remains constrained on all sides by residential neighborhoods and two major highways.

Magamess added: "To achieve the main goal of our efforts in ensuring the reliability of banking operations, we continually work on developing banking protection systems and enhancing measures that provide our customers with a secure experience across all our banking channels, such as the KIB mobile app, KIB online service, and

more." Magamess pointed out that KIB enhanced its data protection measures by introducing confirmation steps to the process of adding a new beneficiary through its online banking services. The steps involve sending a message containing a one-time password (OTP) to the customer's mobile phone. The message includes the name of the new beneficiary and the Bank's contact information in the event of suspected fraud. The Bank also sends a notification about the success or failure of the process. More importantly, the Bank will not activate the beneficiary before the lapse of at least 12 hours, unless the customer contacts the Bank to confirm adding the beneficiary from their part. Additionally, KIB contacts the customer if any suspicious activity or transaction is detected on their bank account, and continues to enhance its security systems and fraud prevention mechanisms for electronic payment links and the financial services it provides to its customers.

It is worth mentioning that KIB recognizes the importance of its leading role in educating its customers to prevent them from falling victim to fraud. The Bank consistently publishes material related to financial awareness on all its digital and electronic channels to guide customers towards safe and appropriate responses to any fraud

In this context, the Bank reemphasizes the importance of adhering to certain recommendations should one encounter any suspicious fraud attempts. Key among these is the urgent need to report to the customer service center immediately at the number 1866866 if there is any suspicion of a data breach involving financial or personal information, or if unusual activity is observed on bank accounts, ATM cards, or credit cards. Additionally, it is vital not to respond to any calls requesting bank card details or one-time passwords (OTP), to ignore any suspicious emails or text messages, to avoid clicking on links from unknown sources, and to refrain from installing any software requested over a phone call. The Bank also assures that neither it nor any of its employees will, under any circumstances, request any private banking information, one-time passwords (OTP), or passwords in this manner or by any other means.



Docu revisits a bizarre 1990s Japanese reality show

TOKYO, April 29, (AP): Naked and frail, a shaggy-haired man films himself as he endures solitude in a tiny room for months, and months

"The Contestant," directed by Clair Titley, explores the story behind the late 1990s hit reality TV show from Japan, "A Life in Prizes," in which a comedian nicknamed Nasubi is forced to survive on whatever he can redeem from mail-in coupons, as he is denied contact with the

The film premiered at the Toronto International Film Festival in 2023 and will stream on Hulu from May 2.

Tomoaki Hamatsu - whose nickname "Nasubi," meaning eggplant

in Japanese, refers jokingly to his long chin - never manages to clothe himself and remains naked throughout the show. But he dances to celebrate the things he does obtain, especially food, even if it's just a pot

Canada's National Post, in a review of Titley's documentary, described the TV show as "'The Truman Show' meets 'OldBoy," referring to the 1998 American film starring Jim Carrey about a man who unwittingly stars in a reality TV show about his own life and the 2003 Cannes-winning Korean film about an imprisoned man.

The British director Titley said she chanced upon the reality show and reached out to Nasubi because she felt no one had ever told his side of the story.

"I felt that they were kind of dismissive and even derogatory to an extent about, you know, look at those crazy Japanese. And I really wanted to know Nasubi's story. I really wanted to know what had happened to him, why he'd stayed in there," she said in a recent Zoom interview with The Associated Press.

What makes her documentary more than a just-for-laughs, big-in-Japan satire are the interviews Titley conducts with Hamatsu's mother, sister and friend, who express outrage, sorrow, pride and a mix of other emotions as the show grew into a prime-time hit. They said they felt sorry for what he endured, including his nudity.

The film also explores Hamatsu's childhood experience of being bullied because of his long chin and how he turned to laughter to pro-

Solitude

Hamatsu says the hardest part of the show was the solitude, although being without clothing - and very little food - for a year and three months also took a toll on him. The comedian was moved to tears when he received a standing ovation at a New York screening of the

"I feel I was able to relay a positive message through the documentary," he said.
"The Contestant" raises serious questions about how far society

might go for entertainment, and the big audiences and money it rep-

The show's producer said in the documentary he just wanted to "capture the moment" and did not mention any reservations about producing the show.

"I think to an extent we are all complicit in these narratives. I think

that's something to be aware of. It's very easy to stand back and look at all of this, and sort of think, 'Oh, look at what those producers did.' But, you know, as viewers we need to take some responsibility," Titley

The film explores the various emotions of being trapped in different ways, including in relationships, hardships or just feelings of mean-

Hamatsu is from Fukushima in northeastern Japan, which was hit by the March 2011 triple disaster, when a giant tsunami followed a 9.0 magnitude quake and devastated the coastline, setting off the world's worst nuclear disaster since Chernobyl.

Hamatsu, who still works as an actor, also devotes his time to the reconstruction of Fukushima and raising awareness about the region. "I want everyone to know the people of Fukushima are working

"Life is gradually returning to what used to be in the exclusion zones. Of course, I realize the road to decommissioning the nuclear plants is still a long battle. But I would like people to know the Fukushima of today, feel hope by visiting Fukushima and watch Fukushima rebuild."

In a vindication of sorts at the end of the documentary, Hamatsu becomes a climber and conquers Mount Everest, a feat he dedicates to Fukushima.

Many people think the famous show 25 years ago was the high point of Hamatsu's life, since he is not on TV much anymore, he said.

"But it's just the opposite. That was the worst point in my life. I overcame that. And now I am free to do what I want.'

The emotional state I was in after nine years was a little ragged. Maybe we weren't thinking quite clearly. The idea of doing that on his show - the math of it is really amazing. Seinfeld: Yes, "Oppenheimer." I think it's a fun game if anyone wants to play - how many movies we stole from. Obviously, "The Godfather," obviously "The Right Stuff." At one point, I was going to say, "I'll bury you under the ground, Eli," from "There Will Be Blood." And we weren't even going to explain it. The character's name wasn't Eli.

AP: You once in an interview suggested you only

say you love Pop-Tarts to make the joke work **Seinfeld:** I probably just said that to make that point. But I do love Pop-Tarts. I had one yesterday. We were doing a social media piece with Jimmy Fallon and Meghan Trainor. I took a bite and I went, "This is fantastic." What I like about it is the man-made quality of it. I love great objects that fit in your hand in a nice way. A pack of cigarettes is one of the greatest things you can put in your hand. It just feels great. Dice feel great.

I like a nice spoon. I like things. (Laughs) AP: Were you aware of the recent trend of movies

based on products? **Seinfeld:** Yeah, but we were started long before that. I was a little disappointed that I suddenly became part

of a trend but there was nothing we could do about it. **AP:** Do you have any guesses as to why we've turned our focus to American consumerism? Your film is a big, silly satire of American consumerism.

Seinfeld: For me, I love men in suits talking about

something stupid, like cereal and puffs and sprinkles. AP: You've often spoken about your dedication to sharpening and sculpting a joke. Are you still driven

Seinfeld: I started a bit the other night about your kitchen sponge on the sink looking up at you going: "I don't know how much more you think I have. I was done two months ago." Now it's just growing and growing into a monologue of your kitchen sponge telling you, "Let me go! Let me die a rectangle, not in pieces." When I lock on to something like that, I just want to see how far I can go with it, how long will they let me talk about this.

AP: You're about to turn 70. Is that meaningful to

Seinfeld: No.

AP: Some entertainers turn inward when they reach their 70s, like Steven Spielberg did with "The Fabelmans." But maybe this is a very personal movie for you.

Seinfeld: Very much. This is my "Fabelmans." Because I'm not interested in my life. I'm interested in

So I would want to do an anti-stand-up special if I did one. I envy, sometimes, these little Italian artisans who don't really care if anybody knows who they are or what they do. And stand-up can be like that. Any writing work is very lonely work. Stand-up, in a way, is kind of a private, lonely world. I'm going to Dayton, Ohio, on Friday. No one's going to know what happened there. I'm very attracted to that. I'm more attracted to that than, "Hey everyone, I made a movie." My way, if I had my choice, is that I would like to do this work very

AP: It's interesting you'd say that as someone who had one of the biggest TV shows ever. Maybe you had

Seinfeld: That's possible. But it never felt like me. Larry and I, when we first started to do the show thought: This will be a really fun, little boutique thing that will just get our people that like this kind of quirky, off-beat thing, and that would be cool. What it became was never on our radar. Then, suddenly, you're a big wave surfer. I think it was tougher on Larry than for me. Because you feel the pressure. I never minded the pressure.

AP: Have you experienced younger generations finding "Seinfeld" on Netflix?

Seinfeld: That age around 10 to 12, they seem to find it. They have no idea what it is at first. NEW YORK: Dan Rather returned to the CBS News airwaves for the first time since his bitter exit 18 years ago, appearing in a reflective interview on "CBS Sunday Morning" days before the debut of a Netflix documentary on the 92-year-old newsman's

After 44 years at the network, 24 as anchor of the "CBS Evening News," Rather left under a cloud following a botched investigation into then-President George W. Bush's military record. Rather signed off as anchor for the last time on March 9, 2005, and exited the network when his contract ended 15 months later.

With continued enmity between him and sincedeposed CBS chief Leslie Moonves, Rather essentially became a nonperson at the news division he dominated for decades.

"Without apology or explanation, I miss CBS," Rather told correspondent Lee Cowan in the interview that aired Sunday. "I've missed it since the day I left.'

Rather escaped official blame for the report that questioned Bush's Vietnam War-era National Guard service but, as the anchor who introduced it, was identified with it. CBS could not vouch for the authenticity of some documents upon which the report was based, although many people involved in the story still believe it was true.

In the documentary "Rather," debuting Wednesday on Netflix, Rather said he thought he would survive the incident, but his wife, Jean, told him, "You got into a fight with the president of the United States during his reelection campaign. What did

you think was going to happen?" Rather did not retire after leaving CBS, doing investigative journalism and rock star interviews for HDNet, a digital cable and satellite television network. Over the past few years, he has become known to a new generation as a tart-talking pres-

ence on social media. This past week, he posted on X during former President Trump's hush money trial: "Is it just me or did today seem sleazy even for **Donald Trump**?"

LONDON: British author C.J. Sansom, best known for his historical crime novels featuring the Tudor lawyer and investigator Matthew Shardlake, has died, his publisher said Monday. He was 71.

Pan Macmillan said Christopher John Sansom was working on his latest Shardlake novel, "Ratcliff," when he died Saturday after a period of worsening health. Sansom introduced the character of Shardlake in his first novel, "Dissolution," a murder mystery set in Tudor England in the 16th century. The title referred to King Henry

VIII's dissolution of the monasteries. Published in 2003, the book's combination of intriguing detective story and convincing historical details won Sansom critical acclaim and many fans, and he went on to release six more novels featuring Shardlake.

"Dissolution" has been adapted into a Disney+ series, and the show, starring actors Sean Bean and Arthur Hughes, is set to be released on Wednesday.

Sansom also penned two standalone historical thrillers, "Winter in Madrid" and "Dominion." Over 3 million copies of his books are in print, his publisher said.

"An intensely private person, Chris wished from the very start only to be published quietly and without fanfare," his editor and publisher, Maria Reit, said, "But he always took immense pleasure in the public's enthusiastic responses to his novels and worked tirelessly on each book, never wanting to disappoint a single reader.

Sansom was born in 1952 in **Edinburgh**. He had a doctorate in history and trained as a solicitor before becoming a full-time writer. (AP)

HOUSTON: Time marches on and all good things must come to an end. But don't tell that to The Rolling Stones.

What many believe to be the greatest rock 'n' roll band in the world showed no signs of slowing down anytime soon as they kicked off their latest tour Sunday night at Houston's NRG Stadium.

'There's Still Tomorrow' director opens on success, hope

Cortellesi's film strikes a chord

LONDON, April 29, (AP): Actor Paola Cortellesi has long been a staple on the Italian pop culture scene, mostly known for her work as a comedian. Then she turned to directing and her first feature movie, "There's Still Tomorrow," took Italy

The black-and-white film about an ordinary woman trapped in a toxic marriage in post-World War II Italy opened in October. The low-key drama resonated with women from all walks of life, even overtaking the global hit "Barbie" at the Italian box

After its whirlwind success at home, the movie launched internaionally and opened in the United Kingdom on Friday. Cortellesi was in London earlier in the week to promote "C'e' Ancora Domani," as the movie is titled in Italian, in which she also stars in the lead role.

With a bright smile contrasting her elegant black suit, white shirt and hoop-like black glasses, Cortellesi, 50, stopped by The Associated Press to chat about her unexpected success.

"Thankfully, the camera is high, so you don't see my double chin," she joked as she sat down.

Her signature mix of fun and serious talk soon became apparent as Cortellesi confessed she didn't have high expectations for the film - monochrome cinematography and oldfashioned storylines are not popular at the box office these days.

But there was something especially captivating in the drama unfolding on the screen between Delia - the main character in "There's Still Tomorrow," played by Cortellesi - and that of her husband Ivano, played by Valerio Mastandrea.

"We heard of queues outside the cinema, something that never happens," Cortellesi said. "My friends started sending me pictures from all over Italy of people queuing. I heard of sold-outs.

As the revenue numbers soared, Cortellesi's interactions with the audiences at the end of the screenings brought even more satisfaction.

"They wanted to talk, to tell me a little about the story that had touched them and how this story could be about them," she said.

Relationship

The movie's Delia is physically assaulted by her husband but Cortellesi also brings other kinds of abuse to light - verbal, psychological and financial - and depicts how a victim is often isolated by an abuser as a way of denigrating them further.

Modern audiences have connected with the movie, she said, because the traits of a toxic relationship are recognizably the same nearly 80 years

"The dynamics repeat themselves. They are the constants," she said. "Often women do not report abuse because they are not economically independent, they would not know

It is the contemporary parallels of this tragedy that Cortellesi believes made the movie a success. A woman in an abusive relationship could maybe consider running away from this situation, but it's not easy, especially if she has children.

"We must also understand that it's very complicated," Cortellesi says.

She says not only women but men, too, respond to her movie. On the day of its release in Italy, Cortellesi recounts how she was greeting the audience after a later showing and met an older man in the crowd.
"He told me, 'I'm watching it for

the second time.' So I told him that's not possible ... it just opened today,' she recounted. "He said, 'I was at the show before, now I'm back. I found a seat and I'm watching it again.'

Like Delia in the movie, Cortellesi is a mother. One time, as she was reading a children's book about women's rights to her 11-year-old, Laura, she recalls her daughter's reaction.

practically no rights before and so she asked me incredulously, talking about divorce, talking about abortion, talking about the vote, talking about whatever, she said 'No, but why? Really?' and it was wonderful to see her so amazed," recalls the

"We must fight, be aware of our rights and fight to defend them," Cortellesi added.

In taking her movie around the world. Cortellesi says she is learning how the subject of women's rights affects people in different countries in different ways - in some places, women have been emancipated longer than in Italy.

Her moment of hope?

Cortellesi said she read about young girls, as they were leaving the movie theater after seeing her film, commenting that they want to "practice freedom.'

"Their own freedom and that of others others," she said, smiling.

Saudi Arabia, Bill Gates partner for new pandemic vaccines

RIYADH, April 29, (KUNA): The Co-Chair of the Bill & Melinda Gates Foundation (BMGF), Bill Gates, stated that the foundation would work with the Kingdom of Saudi Arabia to develop capacities for creating new vaccines to prevent future pandemics.

In a speech at the first-ever World Economic Forum (WEF) Special Meeting hosted in Riyadh, following the announcement of an initiative to eradicate polio between Saudi Arabia and his foundation.

Gates emphasized that eradicating polio was crucial not only to save lives and prevent them from living with disability and suffering but also to envision a world free of diseases.

"We began the polio eradication initiative in the 1980s, and the number of polio cases has declined significantly, we are close to eradicating this disease, which once threatened humanity," Gates said

He added that this success was not the anticipated success, the disease's infection rate must reach zero, as this is the desired goal.

He also thanked Saudi Arabia, where this new commitment would ensure the provision of vaccines for measles and other diseases to more than 30 million children, he described the investment as "the future of children wherever they are in the world and a strengthening of health systems at the same time."

He concluded his speech by mentioning he was proud to partner with Saudi Arabia, as this was not only collaborating to eradicate polio but also to build capabilities to develop new vaccines, prevent crises, and protect the world from future pandemics.

CDC confirms 1st HIV cases from 'cosmetic needle' use

ALBUQUERQUE, N.M., April 29, (AP): Three women who were diagnosed with HIV after getting "vampire facial" procedures at an unlicensed New Mexico medical spa are believed to be the first documented cases of people contracting the virus through a cosmetic procedure using needles, federal health officials said.

The Centers for Disease Control and Prevention said in its Morbidity and Mortality Report last week that an investigation into the clinic from 2018 through 2023 showed it apparently reused disposable equipment intended for one-time use.

Although HIV transmission from contaminated blood through unsterile injection is a well-known risk, the report said this is the first documentation of probable infections involving cosmetic services.

Many popular cosmetic treatments are delivered with needles, such as Botox to iron out wrinkles and fillers

The New Mexico Department of Health began investigating the spa in the summer of 2018 after it was notified that a woman in her 40s had tested positive for HIV even though she had no known risk factors. The woman reported exposure to needles through the procedure at the clinic that spring.

The spa closed in fall 2018 after the investigation was launched, and its owner was prosecuted for practicing medicine without a license.

The report said the investigation showed how important it is to require infection control practices at businesses that offer cosmetic procedures involving needles.

China completes ignition test for powerful liquid-propellant engine

BEIJING, April 29, (Xinhua): China has successfully completed an ignition test for its liquid-propellant engine with the highest thrust, according to the China Aerospace Science and Technology Corporation (CASC).

and Technology Corporation (CASC).

This marks a new breakthrough in the country's liquid propulsion development. It is also the first-ever parallel ignition test of four large-thrust liquid oxygen (LOX) kerosene

The 130-tonne class LOX kerosene engine, developed by the CASC, has a total thrust of over 500 tonnes. Compared to the currently operational 120-tonne class LOX kerosene engines, it not only boasts a larger thrust and better performance, but also a more compact structure, effectively enhancing the rocket's carrying capacity.

The parallel ignition test refers to the integration of four mature engine systems, working in unison rather than simply being bundled together. This approach provides a larger thrust for the rocket while also reducing the overall complexity of the system. The successful trial run validates the coordination of multiple engines and their reliability in high thermal environments, demonstrating that the engines are fully capable of flight applications.

LOS ANGELES: A study led by NASA researchers has provided new estimates of how much water courses through Earth's rivers, which is crucial information for understanding the planet's water cycle and managing its freshwater supplies

Researchers at NASA's Jet Propulsion Laboratory in **Southern California** used a novel methodology that combines stream-gauge measurements with computer models of about 3 million river segments around the world.

The study, published recently in Nature Geoscience, estimates that the total volume of water in Earth's rivers on average from 1980 to 2009 was about 2,246 cubic kilometers. The researchers estimate that the Amazon basin contains about 38 percent of the world's river water, the most of any

Estimates in the study could eventually be compared with data from the international Surface Water and Ocean Topography (SWOT) satellite to improve measurements of human

hydrological region evaluated.

Pharmaceutical innovation

Chinese experts find hidden drug resources in deep sea

FUZHOU, April 29, (Xinhua): Chinese marine scientists have identified a plethora of previously unknown microbial natural products from the deep sea floor that may have pharmaceutical applications.

In the cold seeps of the deep sea, microbial communities thrive on the geological seepage of hydrocarbons and inorganic compounds for sustenance, in stark contrast to the sunlight-dependent ecosystems that people are more familiar with on the surface.

These organisms utilize biosynthetic gene clusters (BGCs) to synthesize natural products that help them contend for resources. These unknown natural products are believed to possess potent anti-microbial properties, which could be a game-changer in the fight against drug-resistant infections.

The team of scientists, led by researchers from the Third

Institute of Oceanography under the Ministry of Natural Resources, have analyzed 22 sediment cores from nine cold seeps, and detected natural product-encoding BGCs from 63 archaeal and bacterial phyla.

A large proportion of the BGCs they discovered are likely

A large proportion of the BGCs they discovered are likely to encode antimicrobial compounds, serving as chemical weapons for host defense and competition within the microbial community, according to the study published recently in the journal Science Advances.

The findings provide a pathway to identify previously unrecognized antimicrobial compounds and other types of drugs, according to the researchers

EU's saltwater lagoon rights advocate wins 'Green Nobel'

LOS ANGELES, April 29, (AP): Growing up, Teresa Vicente spent long days in Spain's Mar Menor swimming in transparent waters, cupping seahorses in her hands and partying under the moonlit sky. Out there, she recalled, time stood still.

But over the decades, chronic contam-

ination from mining, development and agricultural runoff turned the once crystal-clear waters of Europe's largest saltwater lagoon into a graveyard. A mass fish die-off in 2019 prompted the professor of philosophy of law at the University of Murcia to take action.



Over the next several years, Vicente, now 61, led a grassroots campaign to save the region's ecological jewel from collapse. Her efforts helped lead to a new law passed in 2022, giving the lagoon the legal right to conservation, protection and damage remediation.

Vicente is one of this year's seven winners of the Goldman Environmental Prize, known as the "Green Nobel," which honors grassroots activists and leaders from across the globe for achievements in protecting the natural world. The recipients were selected from about 100 nominees.

Humanity (cross head)

"(This prize) signifies an international recognition that we are facing a new stage in humanity," said Vicente in Spanish. It's a stage where "human beings understand they are part of nature. And this recognition means that it is not a local or national conquest, but rather a European and international one."

"They call Mar Menor the lagoon of magic," she added, "and all of us on this journey have seen a lot of magic."

The other winners are:

■ Marcel Gomes, executive secretary for the media nonprofit Repórter Brasil, who organized a campaign that alleged connections between beef from the world's largest meatpacking corporation, JBS, and illegal deforestation in Brazil and helped pressure retailers around the world to stop selling the meat.

Indigenous activist Murrawah Ma-

roochy Johnson, who helped stop development of a coal mine in Australia's Queensland state that would have devasted nearly 20,000 acres (8,000 hectares) of a nature preserve, spewed nearly 1.6 billion tons of planet-warming carbon dioxide into the atmosphere over its lifetime, and endangered the rights and culture of Indigenous peoples.

Alok Shukla, who led a community

movement that saved nearly half a million acres (200,000 hectares) of forests from 21 proposed coal mines in Chhattisgarh, a state in central India.

■ Andrea Vidaurre, who helped convince the state of California's air quality agency to establish two transportation regulations that limit emissions from trains and trucks. The rules include the nation's first emissions limit for trains.

Nonhle Mbuthuma and Sinegugu Zukulu, Indigenous activists who prevented seismic testing for coal and gas in a coastal area off South Africa's Eastern Cape.

Michael Sutton, executive directions of the company of the

Michael Sutton, executive director of the Goldman Environmental Foundation, called the winners "an incredible group of individuals laboring, sometimes in obscurity, against overwhelming odds to prevail against governments, against industry."

Vicente was born and raised in Spain's southeastern city of Murcia, home to the Mar Menor. When she learned about the 2019 fish die-off, she was at the University of Reading in England studying how other countries had successfully bestowed legal rights upon natural resources to protect them.

To save the lagoon, Vicente in 2020 helped write the first draft of a bill granting legal protection to the Mar Menor and submitted it to Spain's Parliament, which allows citizens to propose laws directly. But the process required her to gather 500,000 signatures during COV-ID-19 lockdowns.

CLEVELAND, April 29: Global health system Cleveland Clinic has started using a recently FDA-approved ultrasound device to treat liver tumors. The non-invasive technology, called histotripsy, uses brief high-intensity ultrasound pulses that disrupt and kill the targeted tumor cells.

Choon Hyuck David Kwon, M.D., Ph.D., director of Minimally Invasive Liver Surgery at Cleveland Clinic's Digestive Disease Institute, led a team of surgeons and nurses during the first case in which a small tumor on the left side of the patient's liver was liquified. Following the procedure in December 2023, the patient recovered well. The patient was being treated for liver metastases from colorectal cancer.

Target

To deliver the treatment, **Dr. Kwon** used an ultrasound machine connected to a mobile robotic arm, which was positioned above the patient's abdomen to precisely target the liver tumor. The microsecond ultrasound pulses created microbubbles in the targeted tumor, which disrupted and killed the diseased cells.

"This treatment is noninvasive, which provides the patient with an easy recovery following the procedure," said Dr. Kwon. "In addition, studies have shown that, in some cases, a histotripsy treatment may stimulate the body's immune system to attack cancer cells."

Researchers are looking into a phenomenon – known as abscopal effect – that has been observed in patients with cancer following radiation therapy and ablation. Following radiation therapy treatment, researchers have noticed, in some cases, an anti-tumor response that causes untreated tumors to shrink. Histotripsy may also produce an abscopal effect in some cases.

Since the first case, Dr. Kwon and his colleagues – including **Federico Aucejo**, M.D., and **Jaekeun Kim**, M.D.– have successfully used the ultrasound technology to treat more patients with liver tumors. On average, the procedure lasts up to an hour.

"More research is needed to continue to study the benefits of histotripsy, including the occurrence and frequency of the abscopal effect," said Dr. Kwon. "I see this noninvasive treatment as a complement to our current therapies for liver tumors, including surgery and chemotherapy."

Currently, histotripsy is only FDA-approved for tumors in the liver.

NEW YORK: New York City residents may soon see warning labels next to sugary foods and drinks in chain restaurants and coffee shops, under a law set to go into effect later this year.


The rule requires food businesses with 15 storefronts or more to post a warning icon - a black and white spoon loaded with sugar - next to menu items containing at least 50 grams of added sugar.

Businesses will also have to post the

following written label to accompany the logo: "Warning: indicates that the added sugar content of this item is higher than the total daily recommended limit of added sugar for a 2,000 calorie diet (50g). Eating too many added sugars can contribute to type 2 diabetes and weight gain."

The city's health department posted its proposed rule language last week and set a public hearing for late May. City officials and Mayor **Eric Adams**, a Democrat, approved the law last year.

Victory puts happy ending on rough week for Team Penske

McLaughlin wins 2nd straight at Barber Motorsports Park

BIRMINGHAM, April 29, (AP): Scott McLaughlin won his second straight race at Barber Motorsports Park, giving Team Penske a muchneeded triumph on Sunday just days after IndyCar erased Josef Newgarden's victory and also disqualified McLaughlin from the season opener.

McLaughlin and Penske's fuel strategy worked to perfection, with teammate Will Power finishing second - the same order they started in.

CAR RACING

McLaughlin's fifth IndyCar win provided temporary solace after a troubling week for Team Penske, led by series owner Roger Penske. On Wednesday, Newgarden had his season-opening win at St. Petersburg, Florida, stripped for manipulating the push-to-pass function system on

his car. McLaughlin, likewise, was disqualified after finishing third.

Power was docked points and fined but not disqualified. They bounced back to give Team Penske its eighth win in 14 races at the permanent road

"We just had to keep rolling," McLaughlin said. "We know our job. We know what we need to do. I'm just super proud of our execution."

Reigning Indy 500 winner and two-time series champion Newgarden finished 16th at a race where he had won three times before. He had tearfully acknowledged two days earlier having used the push-to-pass when it wasn't allowed at St. Petersburg, while saying he didn't knowingly break the rules.

Most of the drama for his teammates McLaughlin and Power was left behind once hitting the track, with McLaughlin holding onto his

lead coming out of a third and final pit stop with 16 laps to go. He led 58 of the 90 laps and raced to the win coming out of a caution with two laps to go. Power held off rookie Linus Lundqvist to finish second.

"He got a run on me and you don't want two Penske cars out of the race with everything that was going on," Power said of McLaughlin. "So I was kind of easy on him going into Turn 1 there. We were certainly fast but a lot of strategy played into that."

Felix Rosenqvist was fourth and Alex Palou fifth.

Pole-sitter McLaughlin and Power, who started with him on the front row, maintained their spots after their third and final pit stop. They emerged ahead of the 2021 winner Palou, who opted for a two-stop strategy that left him without enough fuel to push the

A restart with 30 laps to go left

Palou nursing his fuel for the rest of the way, while McLaughlin worked to build enough of a cushion to stay up front with one more stop.

"We had to save so much fuel that it was impossible," Palou said.

Arrow McLaren had a rough day after Pato O'Ward was awarded the St. Petersburg victory with Newgarden's disqualification.

O'Ward received a drivethrough penalty for contact that sent Pietro Fittipaldi skidding backward through the grass and into the tire barriers. "That was a freakin' racing incident," O'Ward said when told of the penalty. He finished 22nd.


Teammate Alexander Rossi's left rear tire got loose and rolled across the grass shortly after emerging from pit road, forcing another caution at about the midway point. He completed 60 laps.

Williamson to lead NZ at the Twenty20 World Cup

WELLINGTON, New Zealand, April 29, (AP): Veteran seamer Tim Southee will play at his seventh Twenty20 World Cup after being included Monday in an experienced New Zealand squad for the tournament starting June 1 in the Caribbean and United States.

Kane Williamson will make his sixth T20 Cricket World Cup appearance and will captain the team at the tournament for the fourth time. He is warming up for the tournament in the Indian Premier League.

Southee's regular new ball partner Trent Boult has been included to play at his fifth world T20, despite no longer having a central contract with New Zealand Cricket. The 35-year-old Southee is New Zea-

land's leading wicket-taker in T20 internationals with 157 and is also the Black Cap's top wicket-taker at T20 World Cups with 29, five more than Boult.

The New Zealand selectors have sprung a minor surprise by selecting Matt Henry among four specialist

seamers and ahead of Ben Sears, who was named as a traveling reserve. Henry, 32, will be playing at a T20 World Cup for the first time and has made only 20 previous appearances for New Zealand in the short format.

"Matt has worked exceptionally hard on his skills across the phases of T20 game to come back into selection consideration," head coach Gary Stead said.

So many goals scored in stoppage time this year

Late escapes keeping Alonso's Leverkusen unbeaten this season

BERLIN, April 29, (AP): Just call him Xabi Houdini. Bayer Leverkusen coach Xabi Alonso has seen his team pull off several scarcely believable escapes from defeat this season as it remains unbeaten across all competitions

Leverkusen, which has already secured the Bundesliga title, is on a 46-game run without a loss - a record across Europe's "big five" leagues.

It has been achieved in extraordinary fashion. Robert Andrich scored with the last kick of the game for a 2-2 draw with high-flying Stuttgart on Saturday. The goal came in the sixth minute of stoppage time when there was only supposed to be five. Stuttgart had won seven of its nine games since losing to Leverkusen in the German Cup and

led 2-0 against Leverkusen, but even that wasn't enough of a cushion to prevent Alonso's team from coming back and extending its unbeaten record.

The previous weekend, Josip Stanišić scored in the sev-

enth minute of stoppage time for a 1-1 draw at Borussia Dortmund. And in Leverkusen's previous game, Amine Adli scored in the 90th minute for a 1-1 draw at West Ham in the Europa League. In all, Leverkusen has eight draws this season to go with 38 wins.

"We've scored so many goals in stoppage time this year," Adli said after the latest drama on Saturday. "But we should score earlier. It would be better for us." Andrich's equalizer against Stuttgart was the 16th goal that Leverkusen has scored in the 90th minute or later across all competitions this season, and the 21st that was scored from the 86th.

"It's not easy to explain what we did again after last week again in the last minute," Alonso said. "There's no explanation why it happens so often, but it's good for us.

Those late goals helped Leverkusen clinch the Bundesliga title ahead of 11-time defending champion Bayern Munich

"We've already reached our main target - to be champions but we want to keep going, we don't want to stop. There are still three games (in the Bundesliga). We want to stay unbeaten for the rest of the season," Alonso said.

Leverkusen's next game is against Roma in the first leg of their Europa League semifinal on Thursday. The teams met at the same stage last season, when José Mourinho's team eliminated Alonso's thanks to a 1-0 win in Rome. They drew the second leg 0-0 in Leverkusen.

'From the first Europa League game against (Swedish team) Häcken, we spoke about our experience in Rome and now we're back in the same situation, semifinal vs. Roma," Alonso said. "So yeah, hopefully we can use this experience well."

'VAR ruins the euphoria that soccer can bring'

Video reviews have changed face of soccer, one country holding out

STOCKHOLM, April 29, (AP): As the Swedish league got underway this spring, yellow-and-black-clad supporters of Stockholm club AIK held up an enormous banner containing a long, vivid story about the dark forces of modern soccer conquering the world. The intruder in this case is VAR - the

high-tech video review system formally written into the laws of soccer in 2018 to help referees make the right calls in the biggest moments.
While most leagues around the world

are now using this technology, Sweden is an outlier in holding out and, in its view, retaining the game in its purest The Swedish league is the only one

of Europe's top-30 ranked leagues yet to have rolled out the system. It won't be happening anytime soon, either. Thews is more than just a die-hard

AIK fan. He played a part in mobilizing anti-VAR sentiment among Sweden's top clubs and helped push through a motion at AIK opposing the introduction of the technology, before the Swedish soccer federation had the chance to bring it

That's possible because Swedish clubs are majority-controlled by members - essentially, supporters - under a regulation that states members should control at least 50% of their club's shares, plus one.

Although the federation initially appeared to want VAR in operation - the technology is, after all, used at European and international level - it will not go

against the wishes of its member-run clubs. As a result, the federation has held off on further discussions about adopting VAR and said last week it doesn't envisage any in the foreseeable future.

That's a big win for Swedish matchgoing fans who are proud of their rebel status in European soccer.

VAR "ruins the euphoria" that soccer can bring, Thews says. "The absolute happiness and passion, or grief and sadness, that comes from a goal being conceded or a goal being scored if you're not sure what has happened until it has been reviewed and decided in a VAR

Compared to other sports, soccer is a latecomer to video replays. In the United States, the NFL introduced instant replays in the mid-1980s but scrapped the system in 1991 after widespread discontent. They returned in 1999 and have spread to other major North American leagues and international sports, such as cricket and rugby.

In soccer, pausing for video reviews can appear more disruptive. Not least because the VAR system has its imperfections.

In the English Premier League, a communications mix-up between the official running the video review and the on-field referee cost Liverpool a valid goal in a loss at Tottenham in October. Weeks later, a Tottenham-Chelsea match had a total of 21 minutes of stoppage time added on largely because of a raft of video reviews. Earlier this month, Nottingham Forest put out an inflammatory statement, questioning the integrity of a match official, after being denied what it perceived to be three clear penalty shouts overlooked by the video referee.

In Spain, Barcelona threatened legal action to force a replay after a VAR-related controversy in the recent "clasico" against Real Madrid.

Originally from the Al-Bab neighborhood in Makkah, Ramadan's journey was marked by various professional stages. Despite specializing in political science, his passion for sports led him to pursue a career in journalism, where he excelled as a journalist, field correspondent, and commentator.

Ramadan's golden voice resonated through generations, leaving an indelible mark on the sports land-scape of Saudi Arabia. Despite facing health challenges in recent years, his dedication to his craft remained unwavering until his peaceful departure yesterday morning.



pean heavyweight in Real Madrid, the record 14-time champion and king of $the_competition.$

Dortmund faces Paris Saint-Germain, whose star striker Kylian Mbappe is looking to lead the French team to its first ever Champions League title in his last season these hefens likely. in his last season there before a likely move to Madrid.

Germany didn't have a single semi-finalist in each of the last three seasons. In the 2019-20 competition, it had two - Bayern and Leipzig - and Bayern was the eventual champion.

This season, Bayern and Dortmund have mounted impressive European campaigns while underperforming on the domestic front.

Germany's Julian Nagelsmann. As Tuchel nears the end of a troubled tenure at Bayern, he's often seemed more upbeat than ever.

"If people want me to stay, it is still an issue that has no priority," Tuchel said Friday when asked about a fan petition begging the club to keep him. "Even if in this case it is a pleasant issue for me.'

The injuries that have plagued Bayern this season are easing off, too. Tuchel predicted Friday that Serge Gnabry would recover from his latest problem in time to play - and score - against Madrid on Tuesday, while fellow forward Leroy Sané could also return. PSG won another French league ti-

tle on Sunday - after second-place Monaco lost at Lyon - but the Champions League is the trophy the Qatar-backed club is desperate to finally get its hands And there would be no better way

for Kylian Mbappe to sign off at the end of the season than by leading PSG to victory in European club soccer's elite competition.

The club is already planning for life without its superstar striker, who is set to walk away as a free agent, with players like Randal Kolo Muani, Ousmane Dembele and Goncalo Ramos expected to help fill the void in his absence. But Mbappe could still have a big say in the Champions League and he scored two goals in PSG's 4-1 comeback win against Barcelona in the quarterfinals.

PSG drew 3-3 at home to Le Havre on Saturday after coming back from 3-1 down and needing an equalizer from Ramos in the fifth minute of stop-

That would open the door for AFC president Sheikh Salman bin Ebrahim Al Khalifa of Bahrain to keep the job and the status it brings as a FIFA vice president - after his current term ends

The anticipation builds for the next installment set to unfold in Belgium come June, promising further exhilarating competition and the opportunity for the Kuwaiti team to showcase their skills on the international stage once
