'Unify school vacation'

Committee urges inquiry into excessive leave cash

KUWAIT CITY, Feb 1: The parliamentary Budgets and Final Accounts Committee has urged all government agencies – each within its jurisdiction – to conduct an internal investigation into anyone who caused imbalances identified by the State Audit Bureau (SAB) during the implementation of the provision of Article 41 of the decree issued on April 4, 1979 regarding the civil service system and its amendments to allow employees to convert their unused leave days into cash while they are still in service.

The committee asked each government agency to submit the investigation results to SAB within three months, which will be used as basis for the follow-up report that will be submitted to the National Assembly along with the final account of

the State administration for fiscal 2023/2024. Committee Chairman MP Adel Al-Damkhi stated in an incoming letter that he sent to the Assembly: "The legislative authority assigned SAB to review the encashment of unused leave days of civilian and military personnel in the public sector. The committee asked the Assembly to take this step after it became clear during its discussion of the draft law on linking the budgets of ministries and government departments for fiscal 2023/2024 that the Ministry of Finance requested the inclusion of new financial appropriations for the project mentioned in Chapter One for Expenditures (Workers' Compensation) to cover the overspending on the implementation of Article 41 of the decree issued on April 4, 1979. SAB submitted its report on Nov 29, 2023; revealing that the expenditure for leave encashment reached KD422,477,072 -- more than the KD300 million budget allocated for this purpose. This is a violation of Article 147 of the Constitution, stating 'in no case may the maximum estimate of expenditure, included in the budget law or the laws amending it, be exceeded."

Inconsistency

He went on to say that "other results became clear for SAB, the most important of which is the rise in the risk index in all government agencies in terms of inconsistency in decisions and systems for accruing, granting and settling leaves; weak oversight of leave systems and their accrual; failure to deduct them regularly, which led to the accumulation of days due to some employees and replacing them without auditing or reviewing them; weak internal control in following up the employees' commitment to work and their absence at work; lack of control over the extent of employees' commitment to the attendance system; exempting others from proving attendance in accordance with regulatory decisions; exaggeration in the value of comprehensive salaries in the statements in a way that does not reflect the actual salary as it was found that some employees whose actual salaries are less than what is listed on the statements; and temporary contract employees (non-Kuwaitis) were included in the decision to disburse cash for unused leave days.

He added the committee attached in its letter a summary of the results and recommendations of SAB, as well as the obstacles it faced during the completion of its task; so that the Assembly will take them into consideration.

Meanwhile, MP Badr Nashmi Al-Anzi has submitted a proposal to specify the same vacation period for schools, institutes, colleges and universities in the public and private sectors. He explained that his proposal is aimed at giving families a chance to spend their vacation with all members of the family.

Kuwait sets fees for part-time work permits through 'Sahel'

Bid to address demographic imbalance

KUWAIT CITY, Feb 1: The Public Authority for Manpower (PAM) has launched the service for obtaining part-time work permit through the Sahel platform, reports Al-Seyassah daily.

This is part of procedures aimed at developing the labor market in order to meet manpower demands and to ease the process for employers to benefit from workers who are already in Kuwait as one way of addressing the demographic imbalance

Following are the conditions and fees for obtaining part-time work permit:

1. Approval of the original employer,

Maximum part-time work is four hours except the contracting sector, 3. Payment of corresponding fees — KD 5 for one month, KD 10 for three months, KD 20 for six months and KD 30 for one year.

On the other hand, citizens are exempted from these conditions and fees. They can apply for part-time work with the approval of the original employer in line with the laws on protecting competitiveness.

Kuwait grapples with childhood obesity surge

Kuwait banks heighten scrutiny on source, purpose of deposits

KUWAIT CITY, Feb 1: Sources have revealed that certain banks are not only inquiring about the source of a customer's funds but are also seeking information on the purpose behind obtaining the money. This heightened scrutiny particularly applies to checks from known parties issued by other local banks, especially when the check amounts are significant compared to the client's usual income, reports Al-Rai

Banks have recently intensified their calls to customers who deposit checks into their accounts. focusing not just on the source of the check, but also questioning the reason behind receiving it. Some customers find this practice intrusive, arguing that not all financial transactions should stem from business relationships

Several individuals have informed banks that the check amounts received are gifts, emphasizing that there is no legal prohibition on the exchange of financial gifts between individuals, especially within socially acceptable limits. Banks typically refrain from escalating such matters to the Financial Investigation Unit unless the value is exceptionally substantial and unexplained.

In an effort to safeguard against money laundering and terrorist financing, local banks are now restricting the deposit of funds from exchange companies. They are only accepting deposits of specific cash levels, particularly if the amounts differ from the standard liquidity rates of these companies.

'Durra' solution through dialogue

Kuwaitis can enter Iran without visa from next week: Toutounji

KUWAIT CITY, Feb 1: The Iranian Ambassador to Kuwait Mohammad Toutounji says his country is always ready for cooperation and constructive dialogue with Kuwait, stressing that the issue of Al-Durra field is "purely technical" and will be addressed through dialogue and understanding.

In a press conference held yesterday on the occasion of Iran's National Day, Ambassador Toutounji praised the Kuwaiti-Iranian relations, declaring that Kuwaiti citizens will be able to enter Iran without a visa starting from the beginning of next

Regarding possibility of opening new discussions about the Durra field, he said, "We hope and pray for success for the new Kuwaiti government.

Iran has always expressed its readiness for any cooperation and constructive dialogue. We believe

Toutounji that the issue of Al-Durra field is a purely technical one, and can be addressed through dialogue and understanding.

The ambassador announced his government's decision to cancel entry visas for citizens of Kuwait, and a number of other countries, coinciding with the Iranian National Day, adding that the Iranian government decided to implement this decision from Sunday.

He said, "This will be available to citi-

zens of 28 countries including Kuwait. It also applies to holders of regular, diplomatic passports. Article 17 and special passports will still have their own specific

Every Kuwaiti citizen can visit Iran without a visa within six months. The time available for a visa is 15 days, which cannot be extended. If he wishes to stay for a longer period, he must obtain a visa from the embassy.

The implementation of the decision was supposed to be in March, but the date has been advanced".

Ambassador Toutounji revealed that there is an opportunity for Kuwaiti citizens to obtain an annual visa.

Regarding the cancellation of tourist visas, he explained that it will happen unilaterally every six months, with a 15-day stay for citizens of 28 countries, which are Kuwait, UAE, Bahrain, Saudi Arabia, Qatar, Uzbekistan, Kyrgyzstan, Tunisia, Mauritania, Tanzania, Zimbabwe, Mauritius, Seychelles, Indonesia, Brunei Darussalam, Japan, Singapore, Cambodia, Vietnam, Brazil, Peru, Cuba, Mexico, Bosnia & Herzegovina, Serbia, Croatia, Belarus, and India.

The implementation steps have been communicated to the relevant authorities as of February 4, taking into account that only holders of ordinary passports

of the aforementioned countries can enter without a visa every six months, and stay for a period of 15 days that cannot be extended.

Those who wish to reside or enter more than once for tourism purposes or to obtain other types of visas must apply for visas through diplomatic missions. There are provisions for canceling visas for Indian citizens through airports only.

Ambassador Toutounji stressed that the path of the Iranian-Kuwaiti bilateral relations, throughout the 62 years since the beginning of diplomatic relations between the two countries, has passed through different stations, but religious ties and historical and popular commonalities have led to relations moving for the better.

He said, "During the past two years of the government of Dr. Ibrahim Raisi, there was a special trend to strengthen relations with neighboring countries. Thanks to Almighty Allah, today we are witnessing balanced and deep-rooted relations between Iran and

Meanwhile, the ambassador affirmed that the Iranian community in Kuwait is considered one of the oldest communities that have inhabited the country for decades, and is distinguished by good behavior and proficiency in work.

He said, "This community enjoys trust, as we have doctors, university graduates, and trade and business workers. Today, there are more than 30,000 Iranians residing in Kuwait. Iranian private schools receive more than 1,600 students of the three educational levels.

The trade relations between the two countries are continuing even before the launch of diplomatic relations and have not been interrupted even in the darkest circumstances such as the days of the COVID-19 pandemic. However, the volume of trade exchange is below the level of ambition, as there are enormous possibilities to enhance trade and provide food security for Kuwait due to the short distance and competitive prices, and the quality of Iranian goods that the Kuwaiti citizen has experienced over the past years.'

Regarding the possibility of a preemptive American strike on Iran, Ambassador Muhammad Toutounji said, "We always aspire to peace, tranquility and stability in the region, as there are always pretexts they are looking for to launch attacks. There is no doubt that such actions will not help in establishing security in the region. If some Iranian sites were targeted, Iran would undoubtedly respond to that.

Regarding Iran's relationship with the attacks on American bases, he said, "This is an allegation.'

Ambassador Toutounji stressed that the resistance factions in the region work according to their program and plans without any interference from outside, and do not receive orders from Iran about their decisions, actions and positions regarding the Zionist aggression against the Palestinian people.

Winter in Kuwait mild to moderate

El Niño cause of high temp in '23


KUWAIT CITY, Feb 1: The Al-Ajairi Scientific Center, in collaboration with the Swiss organization "Metoblue," has conducted an analysis aimed at understanding the factors contributing to the elevated temperatures experienced during 2023 and the initial months of 2024, leading to a diminished perception of cold weather this season, reports Al-Rai daily.

Engineer Yousef Al-Ajiri, the Director General of the Center, explained in a press release that the current winter season has witnessed temperatures surpassing the annual average.

Al-Ajiri emphasized that, particularly in Al-Murabbaniyah, the cold percentage has been significantly lower than usual. The average temperatures for the Al-Murabbaniyah season, covering the period from December 7, 2023, to January 14, 2024, were identified as the highest compared to those recorded in the same time-frame over the past six years.

This year's recorded temperature for the Murabbaniyah season is 17.16 degrees Celsius, indicating an increase from the range of 14.81 to 15.39 degrees Celsius observed in the past six years, signifying a rise of approximately 1.77 degrees Celsius.

Al-Ajiri pointed out that weather experts involved in the analysis attribute the temperature surge this year to two primary factors. Firstly, the ongoing global climate changes, and secondly, the El Niño phenomenon, a natural occurrence associated with elevated temperatures in the Pacific Ocean, thereby influencing temperatures on a global scale.

ETA becomes effective Feb 1

UK preferred destination for Kuwaitis: Lewis

KUWAIT CITY, Feb 1: The British Ambassador to Kuwait, Belinda Lewis, expressed pride in the United Kingdom remaining the preferred travel destination for many Kuwaitis. She welcomed an increased number of Kuwaiti visitors, particularly with the recent launch of the electronic travel permit, reports Al-Qabas daily.

As of today, Kuwaiti citizens, as well as citizens from Gulf Cooperation Council countries and other residents, are eligible to apply for an Electronic Travel Authorization (ETA). This authorization enables travel to the UK on or after February 22, 2024.



Ambassador Lewis highlighted that the ETA, priced at only 10 pounds sterling (approximately 4 Kuwaiti dinars), facilitates unlimited short trips to the United Kingdom. It covers visits of up to six months for purposes such as tourism, visiting family and friends, studying, conducting business, or transiting to another destination. It remains valid for two years or until

the passport used to submit the application expires (whichever comes first). Belinda Lewis Unlike its predecessor, the Electronic Visa Waiver (EVW), an ETA can be used multiple times dur-

ing this period and has the added benefit of not being tied to a specific trip. This will make short trips to the UK more flexible and spontaneous." She added, "We welcome more Kuwaiti visitors to enjoy

the beauty, culture and job opportunities that the United Kingdom has to offer, and help strengthen the connections between people that have long strengthened the deep and special partnership between our two countries.

Meanwhile, Ambassador Lewis, announced that all preparations have been made to receive Electronic Travel Âutĥorization (ETA) applications for Kuwaitis wishing to visit the United Kingdom, starting today.

Lewis said, "I would like to point out that February 1, 2024 is the date on which Kuwaiti citizens, GCC citizens and other Jordanians become eligible to apply for an Electronic Travel Authorization (ETA), which can be used to travel to the United Kingdom on February 22, 2024, or after. She added, it remains valid for two years or until the passport

used to submit the application expires (whichever comes first). Unlike its predecessor, the Electronic Visa Waiver (EVW), an ETA can be used multiple times during this period and has the added benefit of not being tied to a specific trip, this will make short trips to the UK more flexible and spontaneous.

According to the system, the electronic multi-travel permit is for an open period of no less than two years, and is used for short tourist, therapeutic, commercial, and academic visits of less than 6 months (training courses). The traveler can also enter Britain with this electronic visa once, and if he wishes to travel again, the traveler must apply for a new visa with a

With this decision, all citizens of the Gulf states are allowed to travel to Britain for a period of no less than 180 days. The visa cannot be used for work purposes or contracting a civil marriage, and every traveler, including children, must apply

'MPW's budget spikes by KD30m new fiscal'

KUWAIT CITY, Feb 1: According to the report on the draft law regarding apportioning the budget of ministries and government departments for the 2024/2025 fiscal year, an amount of KD 952.424 million had been allocated to the total annual budget of the Ministry of Public Works, which is an increase of

for the current fiscal year, to cover all items. The report explained that the budget for the capital expenditures item witnessed an increase of KD 55 million to reach KD 566 million from KD 511 million during the current fiscal year in order to cover the projects implemented by the ministry, especially major projects such as Kuwait International Airport's T2 terminal, Mubarak Port, and road construction and maintenance projects, as well as payments to the companies that im-

plement these projects. The employee salary item witnessed an increase of only KD 2 million, reaching KD 299 million, compared to the budget for the current fiscal year of KD 297 million, to cover the item of salaries, bonuses, and allowances that employees receive in all technical and administrative sectors of the

Meanwhile, the Central Authority for Public Tenders (CAPT) has set March 3 as the closing date for bids for two projects - the construction of the Sheikh Nawaf Al-Ahmad Complex for the Printing of Qur'an, and the construction of the

new building of the State Audit Bureau. According to informed sources, these two projects are among the important construction projects currently being offered by the ministry through CAPT. On March 3, the bids of companies competing to win the project will be opened and referred to the ministry for study through specialized committees, then returned back to the agency to make the award decision, after which the implementation of these two projects

"Successive governments did not take a decision regarding stray dogs that harm people and their number has become terrifying. They pose grave danger to people, so what then?

"In the past, there were governments that took the appropriate decisions at the appropriate time. They did not back down, while there were political ministers who laid down the country's supreme policy, and left the implementation part in the hands of agents and

"Some ministers occupied positions vacated by family and friends. They do not know the meaning of ministerial solidarity. News about them spread among the people before the end of their session, until the fair Amiri decree was issued to stop this nonsense that almost reached the bone!

"The important question for all members of the current government is: Can you make a decision without fear or

Famous blogger jailed for 3 years

KUWAIT CITY, Feb 1: The Criminal Court sentenced a famous blogger to threeyear imprisonment with hard labor for publishing false news on the social networking site X, formerly known as Twitter, reports Al-Seyassah daily.

It is noteworthy that the blogger wanted to flee the country due to the issuance of judicial rulings against him in State Security cases.

The Public Prosecution charged the accused with spreading false news through posts on his private X account that bears his name, and intentionally misusing his mobile phone.

5-year jail overturned: The Court of Appeals overturned the verdict issued by a Health's employee to five-year imprisonment, and instead refrained from punishing him, reports Al-Seyassah daily.

During the court session, lawyer Zaid Al-Khabbaz representing the defendant stressed that the documents were devoid of any evidence to prove that his client had forged permits for overseas treatment and counterfeited the doctor's seal. Also, the forensic evidence report proved that his client's handwriting did not match the handwriting on the transactions. There is also no proof that his client obtained any interest or benefit from the forged documents.

He insisted that there was no interest or benefit, which indicates that his client commit the crime of forgery leveled against

Al-Khabbaz requested the court to cancel his client's imprisonment sentence.

Troops, police deployed to round up illegals, criminals in Mahboula

Massive raids launched to curb 'lawlessness' on streets

KUWAIT CITY, Feb 1: A security operation conducted by the General Administration of Rescue in the Mahboula area has resulted in the issuance of 258 traffic violations and the apprehension of several individuals involved in various offenses on Wednesday evening, reports Al-Rai daily.

This initiative, in line with the directives of Lieutenant General Sheikh Salem Al-Nawaf, the Undersecretary of the Ministry of Interior, emphasizes the imperative need for enhanced security and traffic measures to curb security threats, reckless behavior, and criminal activities. The operation specifically targeted entrances and exits of the region, as well as locations with a high concentration of offenders.

Accompanying the men of the General Department of Rescue during this security campaign, "Al-Rai" witnessed the coordinated efforts led by Brigadier General Fares Al-Qahtani, the Director of the Department. The operation involved the participation of all rescue departments across governorates, with approximately 100 troopers and 30 patrols. The area was effectively cordoned off for a duration of 4 hours, resulting in the apprehension of numerous violators.

The campaign's outcomes included the issuance of 258 traffic violations, identification of 15 residency law violators, detection of 10 individuals without proper documentation, identification of 13 individuals with arrest warrants, and the arrest of a person with criminal charges. Additionally, 5 vehicles subject to judicial custody were detained, along with the arrest of an individual found in possession of controlled substances.

Security sources emphasized that the General Department of Rescue maintains continuous activity across all governorates, deploying patrols and establishing checkpoints around the clock. Furthermore, a weekly initiative brings together the personnel and vehicles of all rescue departments, focusing on a designated area that is completely closed and monitored to identify and apprehend violators, particularly those engaged in reckless and criminal activities.

These ongoing security campaigns aim to safeguard the well-being of citizens and residents, acting as a deterrent against anyone attempting to disrupt the peace or violate the law. These efforts are part of a sustained com-

mitment to daily operations aimed at maintaining and enhancing overall security.

Meanwhile , over the past two days, the Traffic and Operations Sector in Kuwait confronted violators, monitored violations, conducted traffic campaigns, and deployed patrols across various governorates, reports Al-Rai daily.

As a result, 6,186 various traffic violations were issued, 6 individuals were referred to traffic police, and 9 people were handed over to juvenile prosecution. Additionally, two individuals wanted by security were apprehended.

Department of the Interior Ministry reported that the campaigns led to the seizure of 152 vehicles, which were subsequently impounded. Furthermore, 199 violations related to nuisance noise were issued, 12 wanted vehicles were seized, and 167 radar violations

were recorded. The department emphasized the ongoing commitment of the General Traffic Department to conduct campaigns and enforce the law without leniency for violators. Kuwait sees unusual surge in court cases

KUWAIT CITY, Feb 1: The Supreme Judicial Council, the Ministry of Justice, and the National Assembly have failed to take necessary measures to address the substantial surge in court cases which reached from 500 in 2011 to an overwhelming 1.2 million in 2019 and the trend persists, reports Al-Jarida daily.

In 2023, an astounding 1,572,341 cases were recorded by the courts, indicating an increase of 400,000 within just four years. This surge underscores a significant uptick in legal matters within Kuwait. An examination of the statistics from the past year reveals that the Court of First Instance bore the brunt of case registrations, handling 1,522,697 cases. Among them, criminal cases numbered 934,705, civil cases reached 554,240, and family cases amounted to 33,752.

Top of Form

The Court of Appeal circuits processed 53,282 ordinary and family appeal cases, while the Court of Cassation dealt with 21,771 cases. Despite the cumulative appeals reaching around 70,000 before the Court of Cassation, only 396 judges were available across its circuits.

Intriguingly, each judge in the Court of Cassation faced an annual workload of about 3,840 cases, averaging 320 per month and 80 per week. The Court of Appeals had 334 judges handling


53,282 cases annually, averaging 160 cases per judge annually.

Considering the substantial workload faced by the Court of Cassation, with 21,771 cases distributed among 87 judges, each judge dealt with an average of 250 cases annually and 11 cases per month. This raises concerns about the strain on judges, particularly considering their responsibility to monitor the integrity of rulings and apply legal provisions.

The surge in appeals, exceeding 16,500 in 2019 and rising to 21,771 in 2023, prompts a critical examination of the adequacy of the current number of judges. Despite the court deciding on a significant number of appeals, the increase in the number of judges has been minimal, posing challenges to efficiency.

The evident backlog and inefficiency in the justice system, exacerbated by outdated procedures and a lack of legislative development in the last 45 years, underscore the pressing need for a comprehensive overhaul.

With 730 judges responsible for handling over one and a half million cases, a reconsideration of the appointment and recruitment of judges is imperative to ensure a more modern and efficient judicial system that aligns with contemporary technological advancements and addresses the longstanding issues in the litigation process.



KUWAIT CITY, Feb 1: According to informed sources in the Ministry of Electricity, Water, and Renewable Energy, the ministry has again sent a

Kuwait envoy to China presents 'credentials'

KUWAIT CITY, Feb 1, (KUNA): Kuwait's Ambassador to China Jassem Al-Najem has presented his credentials to Chinese President Xi Jinping.

During the reception, Ambassador Al-Najem conveyed the greetings of His Highness the Amir Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah to the Chinese leader, the Kuwaiti Embassy in China said in a press statement to KUNA on Thursday.

The Chinese leader also asked the ambassador to convey his greetings to His Highness the Amir, and hoped for further development of Chinesenumber of letters to the various state ministries to deduct the amounts owed to the ministry for damages to its facilities by contractors implementing contracts for these government agencies, including the ministry itself.

The sources explained that the ministry seeks to collect the largest amount of this debt before the end of the current fiscal year. It received KD 413 thousand last fiscal year out of a total of KD 5.852 million, bringing the remaining amount to KD 5.439 million.

There is also a specialized technical committee formed to follow up the collection and settlement of fines and damages.

The ministry, in the event that the debts of these companies and individuals are not paid, will implement the mechanism it approved by banning most of the wanted persons and taking legal measures against them, considering that these amounts are public money that must be preserved through the mechanisms and frameworks in place. This is especially since these aforementioned damages are the result of incidents in which judicial rulings were issued against companies and individuals and must be implemented.

The amounts collected last year represent seven percent of the total debt, and the ministry will not hesitate to collect the rest of the debt amounts, despite the difficulty in collecting some of them, as

they date back to 1992 and have not been collected. On the other hand, the sources reported that the ministry has been making moves regarding renewable energy projects.

They revealed that it recently proposed two projects, first to supply the photovoltaic cell system on car awnings in the main workshops and the emergency services department in Subhan to produce 7,000 kilowatts, and another on car awnings in the power stations in the northern region to produce 6,200 kilowatt.

The sources said these projects are part of the projects included in the ministry's plan to produce renewable energy, which will achieve self-sufficiency for the ministry's sites in renewable energy instead of traditional energy generated by fossil oil, which the state seeks to reduce dependence on in order to preserve the environment and reduce expenses.

Critical roles of NATO activities

Complex dynamics of American foreign policy in the Middle East

In this special interview with the Reconnaissance Research, Peter Berkowitz, a senior fellow at the Hoover Institution at Stanford University, reveals to us the complex dynamics of American foreign policy in the Middle East, and through him we learn about the critical roles of NATO activities, and the internal debates in Washington regarding the military presence in the region and its impact on

It also highlights the strategic shifts in US military operations, especially towards Kuwait, and the repercussions of the growth of Chinese influence.

The discussion also addresses controversial issues surrounding the relationship between the United States and Israel and Palestinian human rights needs. Berkowitz offers a frank perspective on the influ-ence of Congress in shaping Middle East policy, and the position of the United States as a mediator in Israeli-Palestinian

Abdulaziz Al-Anjari, founder and CEO

of the Reconnaissance Research, said:
"At the Reconciliation Center for Research and Studies, we believe in the importance of presenting diverse and multidimensional points of view to understand the complex dynamics of the regional and international situation. This presentation is an integral part of our responsibility as an independent and specialized research center. We realize that listening to different points of view does not necessarily mean agreeing with them. In the same way our dissemination of these viewpoints does not mean we support them, and dialogue with others does not mean complete acceptance of their opinions, and listening does not mean admiration for what is heard. But by exploring different opinions, we can understand how others think, how they justify their actions, and how they explain their policies. This approach motivates us to hear from prominent figures such as Peter Berkowitz, who held important positions during the administration of former US President Donald Trump, and who is currently considered one of the influential scholars in Washington on US policy. We hope that this interview will contribute to providing a more comprehensive understanding of the current and future landscape of US foreign policy in the East. Middle East, in addition to the strategic considerations followed and their impact on international relations and security.

Question: How does Iranian-Iraqi proxy group activity influence U.S. foreign policy decisions in the Middle East, especially regarding military withdrawal from Iraq?

Answer: The presence of Iranian proxy groups in Iraq and throughout the Middle East reinforces the need for U.S. military forces throughout the region. We have long known that Iran, the world's leading state sponsor of terrorism, foments regional instability. The heightened military conflict in the region since Hamas' Oct 7 attacks on Israel have thrown into sharp relief Iran's destabilizing influence. Israel, which the United States contin-

ues to see as vital to regional stability, faces a seven-front war with Iranian-backed forces: Hamas in the Gaza Strip, Hamas in the West Bank, Hezbollah in Lebanon, other Iranian proxy forces in Syria, Iranian proxy forces in Iraq, the Houthis in Yemen, and Tehran itself.

Under these circumstances, and with regional stability a priority for U.S. for-eign policy, a withdrawal of U.S. forces would further destabilize a precarious

Q: What are the implications for NA-TO's role in the region following the U.S. military withdrawal from Iraq?

A: The US and Iraq have not yet agreed to a withdrawal of US forces. If agreement is reached and the United States does withdraw forces, NATO itself will not have a major role in the Gulf. But the United States and allies, including fellow NATO members, will continue to partner to maintain a shared national security interest in preserving stability throughout the Middle East, especially in the Gulf.

NATO was designed for a specific purpose - the defense of liberal democracies in Europe and North America against the Soviet challenge. NATO is not well suited to protect all North America's and Europe's security interests around the world.

Accordingly, the United States and fellow NATO member nations must show flexibility and creativity in forming alternative partnerships, coalitions, and alliances that are carefully designed to address the specific challenge of maintaining stability in the Middle East.

Q: Can you discuss the internal divide within Washington on the continuation of

A: Powerful forces within both the Republican Party and the Democratic Party seek to reduce America's presence in the Middle East. For those in both parties who recognize

that stability in the Middle East requires America's engagement in the region, the key divide concerns Iran.

Democrats have been inclined to be-

lieve that the United States can negotiate fruitfully with Iran; they seek to cajole Tehran to the negotiating table with sanctions relief. Republicans have been disposed to see Iran as the principal source of instability in the Middle East; they be-lieve that America must take a hard line to bring Tehran to the negotiating table by intensifying sanctions.

The Obama administration relaxed sanctions on Iran to persuade it to enter the JCPOA. The Trump administration withdrew from the Iran deal and then intensified sanctions to convince Iran to reenter negotiations on terms more favorable to the United States. To lure Iran back to the negotiating table, the Biden administration once again relaxed sanctions, causing tens of billions of dollars to flow to Iran, which enabled Tehran to increase funding of its terrorists proxies.

The intensifying military conflict in the Middle East since Oct. 7 can be traced to a single source: Iran's quest for hegemony in the region through the export of extreme ideology and terrorism, and through the pursuit of nuclear weapons. It is to be hoped that the Biden administration will adopt a tougher stance against the multidimensional threat posed by Iran, especially following the deadly drone attack

on U.S. forces in Jordan. **Q:** What strategic advantages are offered by relocating U.S. military operations to Kuwait, and how might this affect

U.S. capabilities in the region?

A: The United States, according to Axios, has more troops and military contractors in Kuwait than in any other country in the Middle East. For example, around 2500 American troops and contractors are stationed in Iraq and about 8500 in Qatar whereas 13,500 are stationed in Kuwait. The big advantage to the United States of relying more on our friends in Kuwait is that Kuwait does not harbor Muslim terrorists, does not disseminate anti-Western propaganda, and does not maintain cordial relations with Iran, the world's leading state sponsor of terrorism and the principal source of instability in the region.

Q: How does the U.S. plan to balance its strategic interests with its goal of promoting regional stability and countering extremism in the Middle East?

A: While there are important differences between the parties, the top priority for the United States is increasingly seen on both sides of the aisle as countering efforts by the Chinese Communist Party to bring more states within its authoritarian orbit.

Strategic competition between the United States and China takes place in all regions of the world, very much including

Consequently, promoting regional stability in the Middle East by countering extremism is part of America's larger efforts to maintain a free and open international order, one based on respect for national sovereignty and human rights. Regional stability in the Middle East is not a distraction from America's strategic competition with China but rather crucial to America's prevailing in that competition.

Q: Considering Kuwait's strategic importance in U.S. plans, how do you view Kuwait's autonomy against pressures from global powers like China or A: The United States has a strong in-

terest in working with Kuwait to enable it to maintain its independence and prosperity. Russia's interest and China's interest are to bring Kuwait within their orbit and subordinate Kuwait. America's interest is to keep Kuwait part of the free and open international order, which would allow Kuwait to develop in ways that Kuwait believes best. Similar efforts around the world suggest that China's efforts to build and finance infrastructure in Kuwait will cost Kuwait in the long run and decrease

its independence and prosperity.

The United States must develop private- and public-sector partnerships that offer Kuwait better deals. These publicprivate partnerships must find ways to team up with Kuwait entrepreneurs, Kuwait civil society, and the Kuwait government to expand opportunity in the Kuwait economy and cooperation between the

Q: Is the U.S. prioritizing its military capabilities in the region over the stability and security of host countries?

A: It is a mistake to see military capabilities and the promotion of stability and security as in conflict. The United States would undermine its vital national security interests if the presence of its military in the region destabilized a host country and rendered it less secure. That means that the United States must be vigilant in understand the culture, language, religion, history, and political and economic systems of nations in the region to avoid inadvertently causing problems for host

During my time in the State Department, where I served as director of the Policy Planning Staff, Secretary Pompeo issued a directive to the Department to bolster foreign language capabilities to promote greater understanding of nations around the world.

It is common to say that we must understand our enemies. In the United States we must also do a better job of understanding our friends so that we can more effectively shape our diplomacy and defense assistance to suit our friends beliefs, practices, and geopolitical challenges.

Q: Can the U.S. Congress effectively influence U.S. foreign policy in the Middle East, or is it controlled by the Zionist lobby as some believe?

A: Congress has a limited role in foreign policy under the US Constitution, but because of its power of the pursue and its lawmaking responsibilities, its limited

role is crucial. Congress is not controlled by the so-called Zionist lobby or any other single

Many groups seek to influence Congress and Congress is influence by them. Supporters of Israel represent one such roup. The Arab Gulf monarchies and their friends represent another. Congress listens to both but is controlled by neither. Both exert influence, sometimes in opposite directions, sometimes in the same direction.

involvement in the case, if the term of any of these judges was renewed or if they were terminated in case they are non-Kuwaitis, number of judges whose judiciary immunity was requested to be lifted because of their involvement in the case, if their immunity was lifted, when it was lifted if the answer is 'yes', reasons for not lifting the immunity if the answer is 'no', and if any of the senior officials tasked to conduct investigations are related to any of the judges implicated in the case.

MP Muhammad Al-Mahan asked Minister of Health Dr Ahmed Al-Awadhi if his ministry has a plan to open dialysis centers in the southern residential areas. If yes, he requested for a copy of the plan, including the current number of patients who need dialysis. He also inquired if the necessary medical teams and equipment are available to operate these dialysis centers, if it is true that the donation of Sabah Al-Ahmad Cooperative Society has been allocated for the establishment of a dialysis center in Sabah Al-Ahmad, and if there is a plan to establish specialized clinics in the South including Sabah Al-Ahmad, Wafra, Khiran and Ali Sabah Al-Salim. If yes, he requested for a copy of the plan. He wants to know the number of suspended or out-of-service clinics in these residential areas, reasons for suspending the establishment of X-Ray units in Khiran and Wafra, and if there is shortage of medical staff in the southern areas.

Al-Mahan also asked Minister of Public Works and State Minister for Municipal Affairs Noura Muhammad Al-Masha'an about the contracting company tasked to put street tiles in Wafra, copy of the contract, if there are variation orders, if the contractor is committed to the schedule for completing the project, if the teams tasked to follow up the project have recorded violations of the contracting company, and penalties imposed if the answer is 'yes'.

MP Abdulkareem Al-Kandari forwarded queries to Minister of Electricity, Water and Renewable Energy and State Minister for Housing Affairs Salem Falah Al-Hajraf about the number of housing plots qualified for housing loans in the budget for fiscal 2023/2024, budget allocated for this purpose, number of plots whose owners already obtained housing loans from Kuwait Credit Bank (KCB), total amount of granted loans so far, factors leading to the increase or decrease of the actual budget for housing loans compared to the estimated budget in fiscal 2023/2024, impact of such developments on the construction of houses, if KCB received the total capital from Kuwait Fund for Arab Economic Development (KFAED) as per law number 1/2022, and measures that KCB took if the answer is 'no'.

Moreover, the Ministry of Finance confirmed that "the presence or absence of approvals from Kuwait Municipality, the Municipal Council and the service ministries will not change the fact that the Sabah Al-Ahmad Marine City contract is not subject to prior oversight provisions as it is an implementation of the terms of the original contract, and is subject to subsequent rather than prior oversight by SAB. This is a confirmation of the contents of a letter dated Jan 9, 2023 from the Legal Advice and Legislation Department.

In response to the question of MP Mubarak Al-Hajraf, the ministry disclosed it had a correspondence with SAB regarding the Sabah Al-Ahmad Marine City, which began with the approval of SAB issued in July 2002 approving all terms and materials of the contract that regulate the implementation of the two phases of the project (phases A and B). It confirmed receiving a letter from SAB dated Oct 4, 2023 canceling letter number (1/1/22) S (23) dated Jan 9, 2023 which stated:"the implementation of the terms of the original contract is not subject to the prior oversight provisions." None of these letters mentioned the cancellation of the previous approval of SAB issued on July 27,

The ministry responded to SAB's letter saying, "what prompted SAB to send its letter dated Jan 9, 2023 is the data contained in the Ministry of Finance's letter dated Dec 25, 2022, in which it was stated that 9,197,117 square meters remaining for the company in the second phase had not been delivered to it, and there are approvals from the Municipality, Municipal Council and other service ministries. This statement contradicts the reports of the regulatory authorities regarding the result reached by SAB in its letter dated Jan 9, 2023 stating that: "The subject of the research

is the implementation of the terms of the original contract mentioned above and is not subject to the provisions of its prior supervision, and accordingly it will continue with subsequent supervision and follow-up of the audit of the

According to the ministry, the value of the plots sold was determined according to the price per square meter mentioned in the contract, and the company committed to the price specified in the sale of the plots of the first phase in five batches (A1-A2-A3-A4-A5).

The ministry stressed that the concerned authorities in the government have fulfilled all their contractual obligations in the Sabah Al-Ahmad Marine City project, and there is no difference between the first phase and the second phase, as the same uses have been approved for the two phases. It added that the implementation the project is in accordance with the conditions and obligations contained in the contract concluded with the company, including the requirements in each phase.

Furthermore, Assembly Speaker Ahmed Al-Saadoun recently met with Chairman of Kuwait Anti-Corruption Authority (Nazaha) Abdulaziz Abdullatif Al-Ibrahim who submitted the semi-annual report of the authority to

In another development, MP Jenan Bushehri attended the online regional forum organized by the International Parliaments Union (IPU) recently, in collaboration with a number of concerned global organizations that are keen on expediting the economic empowerment of women.

During the forum, Bushehri talked about the challenges in the economic empowerment of women, indicating the challenges vary from one country to another. She disclosed the major challenges include the educational and professional gap between women and men in some countries. She said the share of women in education and professional programs is lower than that of men, which negatively affects the opportunities for women in the labor market. She added that women also face difficulties like the higher rate of unemployment and differences in salaries compared to their male colleagues, as well as the difficulty of occupying leading positions and to be part of decision-making.

She revealed that women usually en-

counter problems in obtaining loans for opening or expanding their business due to bureaucracy and discriminatory legislation that make it too difficult for women to find financing entities. She stated the cultural and social customs have a negative impact on the economic role of women in society, taking into consideration the traditional view about the roles of men and women. She affirmed the laws in Kuwait have contributed to enhancing the economic role of women, but more laws are still needed to push women toward achieving economic progress.

She said the economic empowerment of women in Arab countries requires addressing the abovementioned challenges by adopting integrated strategies, effective support programs, assessment and revision of relevant legislation, exchanging experiences, benefitting from the successful models in some advanced countries, and correcting the wrong social and cultural concepts on the role of

Attack injures 3

Putin 'vows' to make military gains in Kyiv

MOSCOW, Feb 1, (AP): Russian President Vladimir Putin has vowed to push back Ukrainian forces to reduce the threat of attacks on Russian territory as he met with activists running his campaign ahead of the March presidential election that he's all but certain to

Asked about plans for the military campaign in Ukraine, Putin said the line of contact needs to be pushed back to "such a distance from our territory that will make it safe from Western-supplied long-range artillery that Ukrainian authorities use for shelling

He added the Russian military has been doing just that, "pushing the enemy back from vital populated



"This is the main motive for our guys who are fighting and risking their lives there -- to protect the Motherland, to protect our people," he added.

Ukraine has struck inside Russia recently, including a Dec 30 attack on the border city of Belgorod that killed 25 people, injured over 100.

Putin also said Russian investigators concluded that Ukraine used US-supplied Patriot air defense systems to shoot down a Russian military transport plane in the

Ukrainian POWs heading for a swap.

Ukrainian officials didn't deny the plane's downing but didn't take responsibility and called for an international investigation.

Russia, Ukraine swap scores of POWs: Russia and Ukraine have exchanged about 200 prisoners of war each, the countries said Wednesday, despite tensions stemming from last week's crash of a military transport plane that Moscow claimed was carrying Ukrainian POWs and was shot down by Kyiv's forces.

After the Jan. 24 crash of the Il-76 plane in Russia's Belgorod region near the border with Ukraine, some Russian officials had publicly questioned the possibility of future POW swaps.

Russia's Defense Ministry said the countries exchanged 195 POWs each. After the statement was released, Ukrainian President Volodymyr Zelenskyy said 207 Ukrainians were freed. There was no immediate explanation for the different figures.

"We remember each Ukrainian in captivity. Both warriors and civilians. We must bring all of them back. We are working on it," Zelenskyy said on X, formerly Twitter.

'Corrosive substance' attack injures 3: A woman and her two young daughters were in a hospital on Thursday being treated for injuries after a man threw a

corrosive substance at them in south London.

The Metropolitan Police said officers received reports that a man pushed a 3-year-old girl to the ground and threw an alkaline substance at her, her 8-year-old sister and their 31-year-old mother near Clapham Common, a residential area in south London, on Wednesday evening.

The woman and the 3-year-old girl suffered potentially life-changing injuries, police said.

Police said a manhunt was underway to find the suspect, who they believe is known to the woman.

Three members of the public who tried to help the family were also admitted to the hospital with minor burn injuries. Five police officers at the scene were also being treated in the hospital for injuries.

UK judge dismisses Trump's lawsuit: A judge in London on Thursday threw out a lawsuit by former US President Donald Trump accusing a former British spy of making "shocking and scandalous claims" that were false and harmed his reputation.

Judge Karen Steyn said the case Trump filed against Orbis Business Intelligence should be dismissed.

"There are no compelling reasons to allow the claim to proceed to trial," she said.

The ruling comes as Trump is the front-runner for the 2024 Republican presidential nomination while facing legal problems on both sides of the Atlantic.

Trump sued the company founded by Christopher Steele, who created a dossier in 2016 that contained rumors and uncorroborated allegations that caused a political storm just before Trump's inauguration.

Norway's storm leaves trail of destruction: Residents of central Norway awoke to scenes of havoc and homes without power Thursday following the coun-

try's most powerful storm in more than three decades. Hurricane-force winds hit parts of the Scandinavian country, with gusts of up 180 kilometers per hour (112 miles per hour). Near Laerdal, a small, picturesque town northeast of Bergen, Norway's second-largest city, a bus with 14 passengers was blown off a road, though no injuries were reported, police said.

Some areas were flooded, and airlines and ferry operators temporarily suspended service. There were scattered reports of closed schools, roads, tunnels and bridges both Wednesday and Thursday.

'Life sentences for 3 suspects': Prosecutors requested life sentences on Wednesday for three suspects in the killing of Dutch investigative journalist Peter R. de Vries and sentences of three to 21 years for

The life sentences were sought for the man who allegedly shot de Vries in a downtown Amsterdam street on July 6, 2021, the alleged getaway driver and a man suspected of organizing the assassination. De Vries, a popular reporter and television presenter, died nine days later of his injuries at age 64.



Hangar collapse kills 3, 9 hurt: A hangar under construction on the grounds of the airport in Boise, Idaho, collapsed Wednesday, killing three people and injuring another nine, officials said.

Five of those injured in the collapse at the Boise Airport are in critical condition, the city said in a statement released Wednesday

Authorities responded at about 5 pm to the privately owned steel-framed hangar, which suffered a "catastrophic" collapse, Boise Fire Department Operations Chief Aaron Hummel said during an earlier news briefing. Everyone who had been at the site had been accounted for as of Wednesday evening, he said.

The city statement said that the three people killed died at the scene. It said that responding fire crews worked to stabilize the scene and rescued multiple victims.

"It was a very chaotic scene," Hummel said, describing the incident as a "large-scale collapse" of the framework of the building. "I don't know what caused it, but I can tell you it was a pretty global collapse," he said. (AP)

Man accused of beheading dad: A man accused of beheading his father in suburban Philadelphia posted a gruesome video on social media that shows him holding up the severed head and railing against the government, authorities said Wednesday.

Justin Mohn, 32, who is charged with first-degree murder and abusing a corpse, was armed and had jumped a fence at a National Guard facility about 100 miles (160 kilometers) away when he was arrested late Tuesday, hours after the killing, a Guard spokeswoman said.

The father, identified as Michael F. Mohn, was found decapitated in the bathroom of the home in Levittown where his son also lived.

The YouTube video, more than 14 minutes long, showed Justin Mohn picking up the head and identifying his father by name. Police said it appeared he was reading from a script as he encouraged violence against government officials and called his father a traitor to his country. (AP)

Possible union endorsement: Trump

WASHINGTON, Feb 1, (AP): Former US president Donald Trump met with leaders of the Teamsters Union in Washington Wednesday as he tried to chip away at President Joe Biden's organized labor support heading into a likely general election rematch.

Trump participated in a roundtable with the union's executive board, its president and members as he works to win over the blue-collar workers who helped fuel his 2016 victory and who are expected to play a major role in November, particularly in critical Midwestern swing states like Wisconsin and Michigan.

Speaking to reporters after what he called "a very productive meeting," Trump acknowledged the union typically backs Democrats, but said of a possible endorsement, "Stranger things have happened."

"Usually a Republican wouldn't get that endorsement," he said. "But in my case it's different because I've employed thousands of Teamsters and I thought we should come over and pay our respects."

"As you know, a big part of the voting bloc votes for me.'

Union members tend to vote Democratic, with 56% of members and households backing Biden in 2020, according to AP VoteCast. And Biden has already received significant organized labor backing with early endorsements from the AFL-CIO and others. But Trump is hoping to cut into that support as he casts himself as pro-worker and tries to exacerbate divisions between union leaders and some rank-and-file members.

Days before the meeting, he called on members of the United Auto Workers to oust their president, Shawn Fain, after the group endorsed Biden.

"Shawn Fain doesn't understand this or have a clue," Trump wrote on his Truth Social network. "Get rid of this dope & vote for DJT. I will bring the Automobile Industry back to our Country.

Deal on wartime aid and border security 'stalls' in US Congress

WASHINGTON, Feb 1, (AP): With time slipping to bolster Ukraine's defenses, Senate negotiators struggled Wednesday to finalize a bipartisan deal that would pair policy changes at the US southern border with wartime aid for Kyiv as their carefully negotiated compromise ran into strong resistance from House Republicans and Donald Trump.

Senate negotiators have kept a ose hold on the details of a bipartisan package on border enforcement and immigration policies that was supposed to unlock Republican support in Congress for aiding Ukraine. But conservatives view the tens of billions of dollars in proposed support with growing skepticism, unmoved by arguments about the larger stakes for global security. NATO Secretary-General Jens Stoltenberg was making the case for the aid on Capitol Hill Wednesday, including at the Heritage Foundation, a power center for Trump's allies in Washington.

President Joe Biden, who is pushing for a deal alongside Republican and Democratic leaders in the Senate, faces a daunting task in convincing Republicans to defy Trump's wishes and embrace the deal - especially in the midst of an election year.

Republican leaders, including House Speaker Mike Johnson,

had looked to February as a potential deadline to approve another tranche of military aid for Ukraine. But the \$110 billion national security package that congressional leaders say is essential to buttressing American allies around the globe, including Ukraine, Israel and aiwan, has been swept up in the fight over border policies. Meanwhile. Ukrainian troops are

running short of weapons, including air defenses and artillery to defend against Russia's ongoing attack. The Pentagon reported last week it is out of money for Ukraine.

Senate Majority Leader Chuck Schumer warned in a morning floor speech that "the survival of Ukraine

'The only way we'll rise to the occasion is if both sides are serious about finding a bipartisan compromise," he said, adding, "We have not concluded negotiations so we will keep going to get this done.'

Even if the Senate is able to finish the deal and pass it, resistance is strong in the House, where Trump, the likely Republican presidential nominee, holds significant sway over lawmakers. His opposition has left Republican leaders increasingly questioning whether the border legislation should be jettisoned from the package in a last-ditch effort to get the Ukraine funding through Congress.

A lawsuit filed last week in Mississippi follows a similar one last year in North Dakota, both brought in heavily Republican states before conservative federal courts. Democratic and voting rights groups are concerned about the potential impact beyond those two states if a judge rules that deadlines for receiving mailed ballots that stretch past Election Day violate

Parents charged: The parents of a social media model charged with fatally stabbing her live-in boyfriend in South Florida have been arrested in Texas on charges related to the case, jail records show.

Deborah Lyn Clenney, 57, and Kim Dewayne Clenney, 60, were taken into custody Tuesday in Austin, Texas, on an out-ofstate warrant, according to the records. A Miami-Dade circuit judge had signed arrest warrants for the couple last week, charging them each with a felony count of unauthorized access to a computer.

Their daughter, 27-year-old Courtney Clenney, faces the same new charge. Jail records show she's been held without bond on a second-degree murder charge since August 2022.



NZ will contemplate sharing military tech: New Zealand said Thursday it will contemplate sharing advanced military technologies with the United States and Britain as it pursues closer defense ties with Australia amid worries over an increasingly assertive China.

The defense and foreign ministers of Australia and New Zealand met in Melbourne to discuss deepening security ties between the neighboring nations. It was their first joint meeting since New Zealand's right-leaning coalition government took office last year.

New Zealand prime minister is Christopher Luxon.



China, the United States and others are wrangling for influence in the strategically crucial Pacific.

The US and Britain have agreed to pro-

vide Australia with a fleet of submarines powered by US nuclear technology. New Zealand has banned nuclear-pow-

Luxon ered ships from using its ports since 1984, However, it is pondering whether to become involved in a commitment between Australia, Britain and the United States to develop and share advanced military capabilities, including artificial intelligence, electronic warfare and hypersonic technology. (AP)

China, Russia discuss military cooperation: Chinese Defense Minister Dong Jun and his Russian counterpart Sergei Shoigu discussed bilateral military cooperation on Wednesday, China's Defense Ministry said.

During their video call, Dong said that under the strategic guidance of President Xi Jinping and President Vladimir Putin, China-Russia comprehensive strategic partnership of coordination for a new era has maintained a high level of development, according to a press release by the ministry.

As 2024 marks the 75th anniversary of the establishment of diplomatic ties between China and Russia, the two militaries should implement the important consensus reached by their heads of state, firmly respond to global challenges, constantly enhance strategic mutual trust, Dong said.

He also called on the two militaries to continuously expand practical cooperation, push the mil-to-mil relationship to a higher level, and play a greater role in deepening China-Russia comprehensive strategic coordination and maintaining global security and

For his part, Shoigu said that under the guidance of the two heads of state, Russia-China relations are at the highest level in

He also said Russia is willing to work with China to take the 75th anniversary of the establishment of diplomatic ties this year as a new starting point to innovate the fields and ways of bilateral military cooperation, and to push bilateral relations between the two countries and the two militaries to a new level. (KUNA)

'Tide turning against the military': When the army overthrew Myanmar's elected government on Feb. 1, 2021, it looked

like a walkover that could entrench the military in power indefinitely. Three years later, a poorly armed grassroots resistance movement has shaken the military's grip in a modern-day David vs. Goliath conflict. Overshadowed by the wars in Ukraine and Gaza, Myanmar's

civil war is no longer on the front pages, even as violence perpetrated under the military government has risen. Air strikes on villages have increased and civilian casualties have grown, according to the Armed Conflict Location & Event Data Project, a US-based nonprofit organization, and Myanmar Witness, a project headquartered in Britain.

The war has engendered a humanitarian crisis, the UN special rapporteur on the human rights situation in Myanmar said in an interview.
"Thousands and thousands have been killed, 2.3 million people

have been displaced. 18.6 million in Myanmar are in need right now of humanitarian aid," Tom Andrews said. "Half the country has fallen into poverty. The education system doesn't exist for millions of children. The health care system is in shambles.

Inside Myanmar, opponents of military rule called for a "silent strike" on Thursday's anniversary, with people showing their solidarity by staying inside their homes or workplaces. (AP)

Member of KMT elected speaker: Han Kuo-yu of Taiwan's pro-unification Nationalists was elected speaker of the island's legislature on Thursday, a sort of consolation prize for China, which claims the self-governing democracy as its own ter-

The Nationalists, also known as the Kuomintang or KMT, won 52 of the legislature's 113 seats in a Jan. 13 election. The Democratic Progressive Party won 51, a decline from the 63 seats it held in the last legislature. The remainder went to two independents

and the recently formed Taiwan People's Party. Han secured the speaker position without an absolute majority but won the support of the two independents for a total of 54 votes. The eight Taiwan People's Party legislators, all of whom hold atlarge seats, abstained from voting in the second round.

Vice President Lai Ching-te was elected president on Jan. 13, giving the independence-leaning DPP a third consecutive fouryear term in office. The Chinese government loathes Lai and has refused most contact with Taiwan's government since his predecessor, Tsai Ing-wen, won a first term in 2016. (AP)

'Party must stop trying to change law': Thailand's Constitutional Court ruled Wednesday that the progressive Move Forward party must cease advocating amending the law on royal defamation - a decision that leaves the party vulnerable to being

dissolved. The court's nine judges deemed it unconstitutional to advocate a change in Article 112 in the country's Criminal Code - also known as lese-majeste law - which protects the royal institution from criticism by imposing severe penalties on those found to vio-

late it, including up to 15 years in jail per offense. Critics say the law is often wielded as a tool to quash political dissent. Študent-led pro-democracy protests beginning in 2020 openly criticized the monarchy, previously a taboo subject, leading to vigorous prosecutions under the law. (AP)

SKorean court convicts man of murder: A South Korean judge convicted a man of murder Thursday for an unprovoked car-and-stabbing rampage that killed two people and injured 12 others in a city near Seoul last year.

Prosecutors had sought a death penalty for 23-year-old Choi Won-jong, who was arrested in August after he rammed his car into pedestrians in a bustling leisure district in Seongnam and then stepped out of the crashed vehicle and stabbed people at random at a nearby shopping mall. Two of the five people who were hit by the car died of their injuries, while nine others were treated for stab wounds.

Judge Kang Hyun-koo of the Suwon District Court's Seongnam branch gave Choi a life prison sentence, rejecting defense lawyers' appeal for leniency based on the defendant's mental health

Choi had been diagnosed for schizoaffective disorder, which the court acknowledged fueled his delusional beliefs that he was being secretly watched by a gang of stalkers. (AP)

Hong Kong court convicts 4 for rioting: A Hong Kong court convicted four people Thursday for rioting over the storming of the city's legislative council building at the height of the anti-

government protests more than four years ago.

The break-in on July 1 in 2019 - the 22nd anniversary of the former British colony's return to China - was one of the most chaotic episodes of the massive protests sparked by a now-withdrawn extradition bill.

Hundreds of protesters swarmed into the legislature that night, defacing pictures and smashing furniture. Some spray-painted slogans in the chamber and painted over the territory's emblem on a wall before vacating the site as riot police cleared surrounding streets with tear gas and then moved inside. The legislature eventually spent about 36 million Hong Kong dollars (\$4.6 million) on

repairing the damages, the court heard earlier. Six defendants, including actor Gregory Wong and two reporters, Wong Ka-ho and Ma Kai-chung, pleaded not guilty in 2023 to rioting. (AP)

Sikhala gets suspended sentence: A Zimbabwe opposition figure who spent nearly two years in pretrial detention is set

Job Sikhala, an outspoken official with the main opposition Citizens Coalition for Change party and a former member of parliament, was given the suspended two-year sentence after a trial that supporters criticized as being politically motivated. Amnesty International has called the charges "baseless" and said his treatment was an example of the government's attempts to silence dissent.

Sikhala, seen by many as the face of resistance to Zimbabwe's ruling ZANU-PF party and President Emmerson Mnangagwa, was arrested in June 2022 following the killing and dismembering of an activist from his party. He was accused of using social media to encourage opposition supporters to violently respond to the death of Moreblessing Ali. (AP)

Man arrested in Kenya: A man wanted for allegedly killing his girlfriend and leaving her body in a parking lot at a Boston airport before flying to Kenya has been arrested. Kenyan police said Tuesday.

Kevin Kangethe, 40, was apprehended at a nightclub Monday following a tipoff, Director of Criminal Investigations Mohammed Amin told The Associated Press.

Amin said Kangethe will be extradited. The body of Margaret Mbitu, 31, was discovered in early November in a car at a parking garage at Boston Logan International Airport.

Mbitu, of Whitman, Massachusetts, had been reported missing by her family two days before her body was discovered.

Bullfights suspended in Mexico

El Salvador's Bukele seeks re-election

SAN SALVADOR, Feb 1, (AP): Love him or hate him, all eyes are on Nayib Bukele.

To many, El Salvador's president is a national hero who took on the country's violent gangs with an unrelenting hand. To others, the populist is a 21st century autocrat who has committed mass human rights abuses and has altered the rules of the game to concentrate power in his own hands.

Bukele has captured the world's attention in a way few other Latin American leaders have in recent times.

The self-described "world's coolest dictator" is likely to easily skate into a second presidential term in the election Sunday. After sidestepping El Salvador's constitution prohibiting reelection in six different places, Bukele has the support of from seven to nine of every 10 voters, according to recent

Alex Cisneros is among those who plan to vote for Bukele, many saying they have few options after years of corruption and violence under El Salvador's traditional parties.

"He's done many good things and many bad things," said Cisneros, 32. "People criticize him, but he's at least changed something.

Dangerous

Growing up in one of the most danerous areas of San Salvador, Cisneros fled to the US when he was 20 after his cousin was slain by the Mara Salvatrucha gang.

Now back home, he says he was disturbed when police jailed an elderly neighbor for protecting her son, a likely gang member, but he adds he can walk the streets freely at night for the first time in his life.

Bukele's almost certain victory will further cement his grip on power as his tough tactics ripple out from this small Central American nation to other places with their own security crises like Ecuador, Honduras and the Dominican Republic.

That worries rights advocates across the region.

Tyler Mattiace, Americas researcher at Human Rights Watch, considers Bukele "one of the biggest risks for human rights and for democracy that we see in Latin America right now.

"Bukele is incredibly popular, not only at home in El Salvador," Mattiace said. "We see a growing number of people in countries across Latin America who are supporting this kind of authoritarian populism because they believe that it could be the only way to address rising levels

But his rise to wide recognition came in 2022 with his harsh war on the gangs that had long terrorized El Salvador.

Under a state of emergency, his government has locked up 76,000 people - more than 1% of the population in prisons where rights groups have documented cases of torture and the deaths of more than 150 inmates.

MEXICO CITY: A federal court granted a temporary injunction against bullfighting in Mexico City on Wednesday, as activists and supporters of the practice once again locked horns in

Bullfighting had only just returned Sunday to the capital's Plaza Mexico, which held the city's first legal bullfight in almost two years.

The ruling will apparently force the postponement of fights scheduled for Feb. 4-6; organizers have not yet announced what they will do. In May 2022, a local court ordered

an end to bullfighting, ruling that the practice violated city resident's rights to a healthy environment free from violence. That case had been appealed to the

Supreme Court, which struck down the ban on largely technical grounds but left the underlying questions unresolved. But the joy of bullfighting enthusiasts only lasted a few days. Animal

rights supporters quickly filed another legal challenge that resulted in Wednesday's ruling, which suspends fights until Feb. 7. At that point, another hearing will be

held to consider activists' complaints that the practice subjected the animals to cruelty and violated humans' rights to be free of degrading spectacles of cruelty and environmental insensitivity. Animal rights groups have been

A former military officer and a lawyer for drug traffickers in the 1980s, Montesinos became intelligence chief after Fujimori was elected president in 1990. Fujimori, who also faces charges in the case, has not pleaded guilty and a trial is expected on his role.

The former president, now 85, was released from prison in December, after Peru's constitutional court ruled that a presidential pardon that had been awarded to Fujimori in 2017 should be upheld.

LIMA, Peru: The streets, hotels and restaurants around the ruins of Machu Picchu - Peru's most famous tourist attraction - remained almost deserted Wednesday, with train service to the area canceled amid a week-long protest over the outsourcing of entry ticket sales to a private company. Small businesses and workers in the

tourism sector fear the new ticketing system imposed by Peru's government 10 days ago will hurt them while benefiting big companies, and their protests have slowed visitor arrivals to a trickle. "This seems like the time of the

Business and household credit set to improve in Kuwait for 2024

Kuwait's credit growth at 1.7% in 2023, outlook brightens for 2024

Domestic credit growth was a relatively decent 0.9% in Q4, resulting in an 1.7% increase in 2023, down from 7.7% in 2022. The growth in Q4 was boosted by solid credit for securities purchase (+4.9% q/q) and to banks & financial institutions (+4.3%). Businss and household credit growth weakened sharply in 2023, but both should witness an improvement this year given the sharp pick up in project awards in 2023, ongoing job gains among Kuwaitis, steady-to-falling interest rates, and a very weak 2023 naturally opening-up growth opportunities this year.

Business credit inched up by 0.3% q/q, bringing 2023 growth to 0.9%, down from a multi-year high of 6.8% in 2022. Sectors showed wide differences with "construction" and "trade" up 14.5% and 6.8%, respectively, in 2023 while "oil/gas" and "industry" fell by 8.1% and 5.9%, respectively, essentially reflecting a similar sector leadership as in 2022. Real estate, the heavyweight sector with a 41% share, increased by 1.4% in 2023. Looking ahead, growth should improve with the very weak 2023 naturally opening room for a better performance this year, especially with the major rebound in project awards, which soared to KD 2.5 billion in 2023, the highest since 2017, and more than double the 2018-2022 annual average of KD 1.2 billion.

On the other hand, household credit edged up 0.6% q/q, resulting in growth of 1.5% in 2023, a sharp deceleration from 9.1% in 2022. However, trends have slightly improved given that nearly all the 2023 increase occurred in the second half of the year, and where the last six-month annualized growth rate stands at a more decent 3%. For 2024, household credit growth should improve given ongoing job gains among citizens (+1.5% YTD in 1H2023), salary increments, and as the pressure on debt burden ratios from higher rates is somehow absorbed. Finally, credit for securities purchase and to banks & financial institutions supported headline growth in 2023, as they expanded by 6.9% and 4.6%, respectively, accounting for nearly 40% of the increase in credit despite constituting only 12% of total credit.

Public-institution and government deposits rebounded in Q4 while private-sector deposits weak in 2023

Resident deposits jumped by 2.9% in Q4 driven by soaring public-institution (+18%) and government deposits (+9.4%), putting 2023 growth at 3.9%. Government deposits were the growth driver in 2023, soaring by 37% (KD 1.26 billion) and accounting for 69% of the total increase in deposits in the year. Private-sector deposits remained muted (falling in six of the last seven months) to inch up by just 1.2% in 2023, down from 7.1% in 2022. Within private-sector KD deposits, CASA fell 11% in 2023 while time deposits rose 12%. However, the peak divergence between their growth is likely behind us given a limited drop of 1.3% in CASA in Q4 while time deposits were flat, recording the weakest quarterly growth in two years.

Market-implied pricing more aggressive than the Fed's dot-plot with respect to interest rate cuts in 2024

Finally, the Central Bank of Kuwait (CBK) has hiked the discount rate by a cumulative 2.75% since March 2022, compared with a cumulative 5.25% increase by

the Fed. While the Fed's most recent dot-plot (December 2023) pointed to three 25 bps rate cuts in 2024, current futures market pricing is indicating a more aggressive five to six cuts in the year. While it is uncertain whether the CBK will follow suit, any cuts to the discount rate in Kuwait will likely be positive for credit growth.

QatarEnergy & TotalEnergies collaborate on \$6B AI-Shaheen project

DOHA, Feb 1, (KUNA): QatarEnergy has announced the award of the four main Engineering, Procurement, Construction, and Installation (EPCI) contracts, worth USD six billion, related to the development phase of the offshore Al-Shaheen field to increase production by about 100,000 barrels of oil per day (bpd).

According to a statement by the company, the deal was part of Project Ru'ya (vision in Arabic), which is the third phase of Al-Shaheen's development since North Oil Company, a joint venture between QatarEnergy, owns 70 percent of shares, and TotalEnergies, owning 30 percent, took over the field's operation in July 2017.

Project Ru'ya, which will develop more than 550 million barrels of oil, will be executed over a period of five years with first oil expected in 2027. The project includes the drilling of more than 200 wells and the installation of a new centralized process complex, nine remote wellhead platforms, and associated pipelines.

The four EPC packages, with varying scopes of work, valued in total at more than USD six billion consisting of and EPC package for nine wellhead platforms valued at about USD2.1 billion and awarded to a consortium of McDermott Middle East Inc. and Qingdao McDermott Wuchuan Offshore Engineering Co.

The second EPC package for a Central Processing Platform valued at about USD 1.9 billion and awarded to a consortium of McDermott Middle East Inc. and Hyundai Heavy Industries.

The third EPC package for a riser platform valued at about USD 1.3 billion and awarded to Larsen and Toubro Limited. The fourth EPC package for subsea pipelines and cables valued at about USD 900 million and awarded to China Offshore Oil Engineering Co (COOEC).

KUWAIT CITY, Feb 1: Chairman of Kuwait Finance House (KFH) Hamad Abdulmohsen Al-Marzouq said that, by the grace of Allah, KFH has reported record net profit of KD 584.5 million attributable to the shareholders of the bank for the year ended 2023, an increase of 63.4% compared to 2022. The historic profits are the highestever recorded in the Kuwaiti banking sector of which government and semi-government share represented KD 224 million, which is higher than the share during the pre-acquisition phase at KD 68.6 million, an increase of 50%.

Additionally, the share of the governmental entities in the Group market cap increased by KD 285 million compared to the pre-acquisition phase in 2021. This reflects a significant benefit for public funds due to the strategy set by KFH Board

Earnings per share reached 38.49 fils for the year 2023(after the distribution of the acquisition shares), an increase of 29.6%, compared to 29.7 fils in

Net Financing income for the year ended 2023 reached KD 965.9 million; an increase of 20.7% compared to last year. Net operating income for the year ended 2023 reached KD 945.4 million, an increase of 30.7% compared to 2022. Financing receivables increased to reach KD 19.4 billion, an increase of KD 624.7 million or 3.3% compared to 2022. Total assets increased to reach KD 38.01 billion, an increase of KD 1.04 billion or 2.8% compared to last year. Total shareholders equity reached KD 5.3 billion in 2023. Depositors' accounts reached KD 21.8 billion, an increase of KD 782.4 million or 3.7% compared to last year. In addition, the capital adequacy ratio reached 18.18% for the year 2023 (17.66% in 2022), which is above the minimum requirement. This percentage confirms the solid financial position of KFH.

Al-Marzouq explained that the solid financial position of KFH Group has enhanced its ability to increase cash dividends to its shareholders this year and for the coming fiscal years. The Board of Directors has proposed cash dividends to shareholders of 10 fils per sharefor the remaining profits until the end of 2023,in addition to 10 fils in H1 2023, totaling 20% for the year 2023, compared to 15% in the previous year. The Board of Directors also recommended the distribution of bonus shares of 9% of the issued paid capital.

levels, transforming KFH into the largest bank in Kuwait in terms of total consolidated assets amounting to KD 38 billion as of 31 December 2023, and the second largest Islamic bank in the world. He noted that the acquisition contributed to enhancing the profitability level, in which KFH successfully recorded the highest-ever profit rates in the local banking sector and the highest returns on the total key indicators.

"KFH successfully achieved the key goals of Group strategy, strengthened its leading position, and overcame different challenges and operating difficulties. Additionally, High liquidity ratios, solid capital base, and strong operating performance resulted in growth in operating income, profits, financings portfolio, and all key financial indicators," Al-Marzouq said.

He pointed out that the Group's market capitalization has increased and trading in KFH shares attracted record levels of high liquidity. Since last December, the Bank has offered an integrated range of products and services that are compliant with the provisions and principles of Shariah, including retail and corporate services, saving and investment products, in addition to trade finance and wealth management

"The acquisition has resulted in dividend and accretion value of 17.9% for the dividend share of each shareholder at KFH as of 31 December 2023 (before synergies)", added Al-Marzouq "It is expected to increase while achieving synergies in the coming periods, particularly after the completion of the merger with AUB-Kuwait."

Return on average tangible shareholders' equity reached 20.5% (before synergies) as of31 December 2023. It is the highest returnon shareholder's equity in the banking sector.

Foreign investment contribution increased to reach 12.92% as at the end of 2023 compared to 10.34% at the end of 2021 and 7.44% at the end of 2019. This is an increase of 73.6% compared to 2019 end, reflecting the

strength of KFH share following the acquisition and indicating the trust confided of investors.

Al-Marzouq pointed out that KFH is currently in the process of completing the merger by amalgamation with the Ahli United-Kuwait, one the final acquisition stages leading to numerous benefits for both parties and the overall banking industry in Kuwait.

This also enabled KFH to enter new markets and expand its financing contributions with high efficiency at the regional and local levels.

It is worth noting that KFH participated in financing deals for electricity, petrochemical and aviation projects, amounting to approximately USD 10.5 billion, in addition to many local and regional financing deals. These mega deals confirm the high financing capability and financial strength KFH enjoys.

MSCI GCC index drops 0.9% in January after reaching 13-month high

Kuwait leads GCC markets with 6.6% gain in January 2024

GCC index goes from a 13-month high to a 5-week low in 3 days...


GCC equity markets witnessed a positive start to the year with incremental gains across most markets during the month. However, declines during the last week of the month wiped out almost all the gains since the start of the month. The MSCI GCC index reached a 13-month high level on 28-Jan-2024 but consecutive declines during the last three trading sessions completely offset the gains since the start of the month resulting in a decline of 0.9% during January-2024. The monthly performance was affected by a steep decline in Qatar that was further supported by marginal monthly declines in Saudi Arabia and Abu Dhabi. These declines were partially offset by gains in the remaining four markets in the GCC.

Kuwait was the best performing market in the GCC during January-2024 with a gain of 6.6%, the highest monthly gain in almost five years. Gains in Kuwait were broad-based and was reflected in all market segments. Bahrain and Dubai were next with monthly gains of 4.9% and 2.7%, respectively. Gains in Dubai came despite the index seeing 21.7% gains in 2023. On the other hand, Oatar witnessed the biggest decline at 6.8% after seeing fall in almost all the sectors. Meanwhile, the contraction in Saudi Arabia and Abu Dhabi benchmarks was led by rising regional geopolitical issues as well as the oil output cap announcement from Aramco.

The monthly sector performance chart for the GCC region also showed mixed trends with an equal number of gainers and decliners during the month. F&B was the best performing sector with a gain of 7.0% followed by Pharma and Transportation sectors with gains of around 4%. Banks saw a sharp fall during the last three days and closed with a gain of 0.7%. On the other hand, the Energy sector recorded the biggest decline at 6.0% followed by other large-cap sectors like Materials and Real Estate with declines of 5.7% and 3.5%, respectively.

Boursa Kuwait

Boursa Kuwait witnessed broad-based gains during January-2024 with all market segments recording monthly gains. The Premier Market index breached the 8,000 mark after consistent gains during the second half of the month and recorded an intraday peak of 8,083.1 points. However, declines in the subsequent sessions pushed the index down to a monthly close of 7,959.5 points. Mid-

Gains in the Financial service sector was supported by the double-digit gains in 17 constituent stocks while the performance of the Telecom sector was supported by a 24.8% gain in shares of Ooredoo Kuwait followed by 4.8% and 3.7% gain in shares of STC and Zain, respectively. In the Banking sector, nine out of ten Kuwaiti banks recorded healthy gains during the month.

In terms of monthly stock performance, First Takaful Insurance topped the chart with a gain of 298.3% followed by ASC and AlDeera Holding with gains of 248.4% and 72.2%, respectively. On the decliners side, Jazeera Airways topped with a fall of 18.0% followed by PAPCO and United Projects Co for Aviation Services with the declines of 15.4% and 12.3%, respectively.

In terms of trading activity, volume traded during the month surged by 84.3% to reach 6.2 Bn shares in January-2024 as compared to 3.4 Bn shares in December-2023. TUNIS, Feb 1, (AP): Cash-strapped Tunisia wants to take the unprecedented step of borrowing billions from its central bank to address budget deficits and bandage its economic crisis, a step that experts warn could bring inflation and lessen faith in institutions.

In an emergency meeting behind closed doors, parliament's finance committee on Wednesday considered a request from President Kais Saied's government to borrow the funds after it previously overhauled laws designed to guarantee the bank's autonomy.

Those laws added the central bank to a growing list of institutions that critics say Saied has sought to undermine since taking power in the North African nation, along with briefly suspending parliament and rewriting Tunisia's constitution.

His government wants the central bank to directly buy up to 7 billion Tunisian dinars (\$2.25 billion) in interestfree bonds to help plug a 10 billion dinar (\$3.2 billion) budget deficit. But in Tunisia - where inflation and

shortages of basic goods have become routine - the request is raising concerns about maintaining the bank's independence from politics, causing inflation and further spooking foreign lenders and investors.

It comes as Tunisia finds itself unable to borrow from traditional creditors, including the International Monetary Fund, whose proposed \$1.9 billion bailout package remains in limbo.

Though the IMF has said purchasing securities like bonds may serve a monetary policy purpose at times, it has warned countries that central banks should not finance government expendi-

Earnings fall to \$28.3 billion

Shell reports 29% profit decline

LONDON, Feb 1, (AP): Oil giant Shell saw profits tumble by nearly a third in 2023 as a result of lower oil and natural gas prices, which had surged the year before in the wake of Russia's invasion of Ukraine.

In a statement Thursday, London-based Shell said its post-tax earnings fell 29%, to \$28.3 billion from the previous year's all-time high of \$40 billion.

The main reason behind the decline was the fall in energy prices, with oil trading at an average of \$82

a barrel against \$100 the year before. Shell CEO Wael Sawan said the company had "made good progress" over the year and that it would focus on "more value with less emissions."

Shell's green credentials, which have been under fire over the past year, were in focus again Thursday outside the company's London headquarters dressed as partying Shell board members. Greenpeace campaigners said

as Greenpeace activists protested

the oil group should pay some of its profits into a fund agreed at U.N. climate talks in December to help pay for loss and damage caused by climate change. Last year, Shell effectively aban-

doned one of its green pledges, which was to cut oil production by 1% to 2% each year until the end of the decade, saying it had already met the goal.

But this was largely as a result of it selling off some oil and natural gas fields, which meant the company's production was already lower than it would have been in 2030 under the old plan.

China overtakes Japan as world's top car exporter

China overtook Japan as the world's biggest car exporter in 2023 for the first time, with 4.42 million exported vehicles in 2023, data from the Japan Automobile Manufac-

turers Association showed The volume fell short of the 4.91 million cars exported by China, with a 58 percent surge, due to the growing demand for allelectric vehicles around the world, the China Association of Automobile Manufacturers announced in a statement.

Chinese exports of gasoline-powered cars to Russia also rose, after Japanese, US and

European automakers pulled out of the market due to the war in Ukraine, it said.

Data showed Japan's car exports rose for the first time in two years but fell short of the pre-pandemic level of 4.82 million vehicles in

Japanese automakers such as Toyota Motor Corp. have been reviewing their production strategies in recent years, aiming to rely less on gasoline-powered cars and ramping up sales of gasoline-electric hybrids, which in many cases have higher mileage than pure EVs. (KUNA) Deutsche Bank said Thursday that it would cut 3,500 jobs as part of efforts to slash costs by 2.5 billion euros (\$2.7 billion) through next year and boost profits even as Germany's largest lender benefits from higher global

The bank said it would seek to streamline its marketing network and computer systems and software as it seeks to cut costs. It said the reduction in the number of positions would mostly be for jobs that don't involve directly dealing with customers.

The announcement came alongside the release of annual profit fig-ures showing the bank made 4.2 bil-lion euros (\$4.5 billion) last year, a decline of 16% compared with 2022. It was, however, the fourth straight year

in which the bank made a profit. The bank has benefited along with its peers from the global rise in interest rates, which can increase the profit margin between what the bank pays out in interest and what it can earn.

CEO Christian Sewing said the results "demonstrated impressive resilience in a difficult environment, expanded our business and shown everyone our bank is sustainably profitable.

Revenue grew 6.8%, to 28.9 billion euros. The company announced it was raising its dividend to 45 euro cents per share from 30 cents per share and would put more cash in shareholders' hands by buying back 675 million euros in shares by the end

Bank of England keeps interest rates on hold

Cbank fails to signal imminent cuts

LONDON, Feb 1, (AP): The Bank of England kept its main interest rate at a near 16-year high Thursday as inflation remains too high for comfort, and like the U.S. Federal Reserve a day earlier, it gave no signal that it is close to cutting borrowing costs anytime soon.

In a statement, the central bank said it had maintained its key rate at 5.25%, where it has stood since August of last year. The nine-member Monetary Policy Committee was split, with two voting for a quarter-point increase and one voting for a quarter-point cut.

There had been "good news" on inflation in recent months, bank Gov. Andrew Bailey said, but at 4%, it's still double the bank's goal.

"We need to see more evidence that inflation is set to fall all the way to the 2% target, and stay there, before we can lower interest rates," he said.

According to economic projections published alongside the rate decision,

the Bank of England expects inflation to fall to 2% between April and June, about 18 months earlier than previous forecasts.

However, it expects inflation to carry on rising as wages remain high and oil prices recover.

Overall, it indicated that monetary policy will remain "restrictive for sufficiently long" to ensure inflation returns to its target and stays there. That's code that interest rates will stay at current levels, or higher, until the bank is convinced inflation will settle down to 2%.

Similarly on Wednesday, the Fed held rates steady but surprised financial markets with its cautious statement that it "does not expect it will be appropri-

The Bank of England, like the Fed and other central banks around the world, raised interest rates aggressively from near zero to counter price rises first stoked by supply chain issues during the coronavirus pandemic and then Russia's invasion of Ukraine, which pushed up food and energy

In December, inflation in Britain unexpectedly rose to 4%, an increase that tempered market expectations that the central bank would cut borrowing costs as soon as May.

"It's hardly surprising that inaction is the order of the day, given that inflation ticked up in December," said Susannah Streeter, head of money and markets at stockbrokers Hargreaves Lansdown. "It hardly set the stage for an interest rate cut.'

Higher interest rates - which cool the economy by making it more expensive to borrow, thereby bearing down on spending - have contributed to bringing down inflation worldwide.

Though a predicted recession has not materialized over the past year, economic growth is muted as high rates hold people back from borrowing to buy houses or invest in businesses.

The backdrop is hardly ideal for the governing Conservative Party ahead of a general election in the coming year. Opinion polls point to a big victory for the main opposition Labour Party.

2.8% fall matches with what was expected by analysts

Inflation in Europe edges down again. But will Houthi attacks on ships spoil the relief?

FRANKFURT, Germany, Feb 1. (AP): Inflation in Europe edged lower in January to 2.8%, keeping alive speculation about quick interest rate cuts that would lower borrowing costs for businesses and consumers - and help boost the stagnating economy.

The annual figure released Thursday by the European Union statistics agency Eurostat compares with 2.9% in December and matched what was expected by market analysts.

Energy prices fell 6.3%, contributing to the drop in inflation in the 20 European Union countries that use the euro currency. The overall decline brings the European Central Bank closer to its goal of 2% considered best for the economy.

The steady fall in inflation should help the stagnant European economy show stronger growth later this year as moderating prices and wage increases help consumers make up the purchasing power they lost when inflation surged to record-high double digits in late

Inflation has fallen steadily as the ECB rapidly raised interest rates, the typical antidote to out-ofcontrol price increases.

Price spikes in Germany eased despite the end of both a lower tax rate on restaurant bills and some energy subsidies that should have pushed prices up - a good sign for the rest of the year, according to Christoph Swonke, macroeconomic analyst at DZ Bank.

"Even if spring is still a ways off, it's the first rays of sunshine from the current economic sky," he wrote in an emailed analysis.

Inflation decreased to 3.1% in Germany, Europe's biggest economy, down from 3.8% in December and the lowest since June 2021. France, Europe's No. 2 economy, saw inflation dip to 3.4% from

Core inflation, which excludes volatile food and energy prices and is monitored closely by the ECB, fell to 3.3% from 3.4%.

Yet the downward inflation path faces risks from disruptions to shipping through the Red Sea, a key route for goods and fuel headed for Europe.

Attacks on ships by Iranianbacked Houthi rebels in Yemen have led to ships being routed around the southern tip of Africa rather than taking the shorter route through the Suez Canal. That has raised shipping costs and could slow the decline in in-

The trade disruption has so far not led to a spike in prices for oil and natural gas, but that remains a risk if the Israel-Hamas war escalates or spreads to other countries in the Middle East.

The decline in inflation has unleashed speculation that the European Central Bank could start cutting interest rates as early as April. ECB officials - much like policymakers at the Bank of England meeting Thursday and the U.S. Federal Reserve a day earlier - have not committed to a timetable for rate cuts, saying they will decide based on incoming economic data to ensure inflation is definitely trending toward their target.

Some analysts say a cut is more likely at the bank's June policy meeting, around the same time the

Musk cannot keep Tesla pay package worth more than \$55 bln, judge rules

Musk is not entitled to landmark compensation package awarded by Tesla's board of directors that is potentially worth more than \$55 billion, a Delaware judge ruled Tues-

day.

The ruling by Chancellor KathaCormick comes leen St. Jude McCormick comes more than five years after a shareholder lawsuit targeted Tesla CEO Musk and directors of the company. They were accused of breaching their duties to the maker of electric vehicles and solar panels, resulting in a waste of corporate assets and unjust enrichment for Musk.

The shareholder's lawyers argued that the compensation package should be voided because it was dictated by Musk and was the product of sham negotiations with directors who were not independent of him. They also said it was approved by shareholders who were given misleading and incomplete disclosures in a proxy statement.

Defense attorneys countered that the pay plan was fairly negotiated by a compensation committee whose members were independent, contained performance milestones so lofty that they were ridiculed by some Wall Street investors, and blessed by a shareholder vote that was not even required under Delaware law. They also argued that Musk was not a controlling shareholder because he owned less than one-third of the company at the time.

An attorney for Musk and other Tesla defendants did not immediately respond to an email seeking

comment. But Musk reacted to the ruling on X, the social media platform formerly known as Twitter that he owns, by offering business advice. "Never incorporate your company in the state of Delaware," he said. He later added, "I recommend incorporating in Nevada or Texas if you prefer shareholders to decide matters.

Musk, who as of Tuesday topped Forbes' list of the world's richest people, had earlier this month challenged Tesla's board to come up with a new compensation plan for him that would give him a 25% stake in the company. On an earnings call last week, Musk, who currently holds 13%, explained that with a 25% stake, he can't control the company, yet he would have strong in-

In trial testimony in November 2022, Musk denied that he dictated terms of the compensation package or attended any meetings at which the plan was discussed by the board, its compensation committee, or a working group that helped develop

McCormick determined, however, that because Musk was a controlling shareholder with a potential conflict of interest, the pay package must be subject to a more rigorous standard.

McCormick concluded the only suitable remedy was for Musk's compensation package to be rescinded. The plan called for Musk to reap billions if Tesla, which is based in Austin, Texas, hit certain market capitalization and operational milestones. For each incidence of simultaneously meeting a market cap milestone and an operational milestone, Musk, who owned about 22% of Tesla when the plan was approved, would get stock equal to 1% of outstanding shares at the time of the grant. His interest in the company would grow to about 28% if the company's market capitalization grew by \$600 billion.

Each milestone included growing Tesla's market capitalization by \$50 billion and meeting aggressive revenue and pretax profit growth targets. Musk stood to receive the full benefit of the pay plan, \$55.8 billion, only by leading Tesla to a market capitalization of \$650 billion and unprecedented revenues and earnings within a decade.

Tesla has achieved all twelve market capitalization milestones and eleven operational milestones, providing Musk nearly \$28 billion in stock option gains, according to a January post-trial brief filed by the plaintiff's attorneys. The stock option grants are subject to a five-year holding period, however.

Defense attorney Evan Chesler argued at trial that the compensation package was a "high-risk, high-reward" deal that benefitted not just Musk, but Tesla shareholders. After the plan was implemented, the value of the company climbed from \$53 billion to more than \$800 billion, having briefly hit \$1 trillion.

Chesler also said Tesla made sure that the \$55 billion compensation figure was included in the proxy statement because the company wanted shareholders to know that "this was a heart-stopping number that Mr. Musk could earn."

Uptick not boosting Biden

AP-NORC poll finds an uptick in positive ratings of US economy

WASHINGTON, Feb 1, (AP): Stocks are near record highs. Growth was surprisingly strong last year. And oncehot inflation has begun to cool. But so far, U.S. adults are feeling only slightly better about the economy.

A new poll from The Associated Press-NORC Center for Public Affairs Research finds that 35% of U.S. adults call the national economy good. That's an uptick from 30% who said so late last year and up from 24% who said so a year ago. While 65% still call the economy poor, that's also an improvement from a year ago, when 76%

Voters' confidence in the economy could be a pivotal factor in this year's presidential election as it is consistently rated as a top issue. Recent data on the economy has shown that growth accelerated last year even as inflation returned closer to the Federal Reserve's 2% target, proving wrong a multitude of Wall Street and academic economists who said a recession would be the consequence of efforts to lower inflation.

President Joe Biden and his aides have taken to highlighting the economic positives as consumer sentiment has rebounded. Biden is also drawing an open contrast with former President Donald Trump, the Republican front-runner. Trump supporters remember his tenure with pride for how the economy fared, but his term was marred by job losses tied to the coronavirus pandemic.

The evidence of a stronger economy has yet to spill over into greater support for Biden. The new poll puts his approval rating at 38%, which is roughly where that number has stood for most of the past two years. Biden's approval rating on handling the economy is similar, at 35%.

Respondents interviewed for the survey often expressed their views on the economy through a personal lens. Some judged it based on their grocery bills and prices at the gasoline pump. Others assessed the economy based on their appreciating investments. Housing prices mattered, and so did job prospects for their adult children and the upward trajectory of the federal debt.

Molly Kapsner, 58, lives on a farm in Wisconsin and thinks the economy is doing "pretty well" because she has three children finishing college this year and all of them have job options. She voted for Biden in 2020 and plans to do so again.

"He has a lot on his plate right now and he's doing quite well," she said. "He's just putting his head down and doing his job and not trying to create a circus in our country.

David Veksler, who voted for the libertarian candidate, Jo Jorgenson, in 2020, said he's worried about the rising federal debt. The 43-year-old software engineer manager from Denver said the borrowing will hurt growth in the long term, even if his investments are doing well now.

"I think he's similar to his predecessors in furthering unsustainable deficits," Veksler said of Biden. "I'm as negative on him as I was on Trump."

Harry Broadnax, a 62-year-old retiree, said he increasingly thinks about the economy in relation to the increase in migrants illegally crossing the U.S. southern border. He feels their presence is diverting financial resources from U.S. citizens.

"I would like to see them block up

the border like Trump wanted," said Broadnax, who is from North Carolina, adding for emphasis, "I'm a Demo-

Broadnax doesn't see himself voting for Biden or Trump, whose criminal indictments worry him.

The Biden administration has tried to put a greater focus on the big numbers used to assess the overall economy, making its case through hard data.

Lael Brainard, director of the White House National Economic Council, told a group of reporters last week that skeptics about the economy had overlooked how Biden's policies boosted the labor market and repaired supply chains wrecked by the pandemic.

"The big miss here was not to understand how much, by surging back into the workforce, by addressing supply chains that were completely broken, those inflationary pressures would come down," she said.

Trump has said that the economy is "fragile" and "running off the fumes of what we did." The Republican frontrunner has said on social media that stocks are rising because he is likely to return to the White House. That claim overlooks the influence of the Fed, as well as the fact that average annual growth has been higher under Biden so far than it was during Trump's term.

There continues to be a political split in how people think about the economy. As a consequence, there might be a limit on how much Biden's approval numbers can climb even if the economy keeps thriving as it did last year.

Democrats remain far more likely than Republicans to describe the economy as good, 58% to 15%. Still, views have improved at least slightly since the same time last year, when 41% of Democrats and 8% of Republicans called the economy good.

Sixty-five percent of Democrats, but just 7% of Republicans, say they approve of Biden's handling of the economy, both largely unchanged since late last year.

However, the poll did show a brighter outlook on the economy from some key voter demographics. Since a year ago, a disproportionate increase in sentiment has come from college graduates and older adults - two groups that tend to turn out to vote at higher rates. There is also the possibility that voters will care more about the personalities of the Democratic and Republican nominees than they do about the state of the economy.

Deborah Shields, 70, who works in direct sales, said she's noticed an improvement in the economy as her investments have improved. Yet she said her opposition to Trump will determine her vote in November.

Grammys preview

Music extravaganza vows exciting twists

LOS ANGELES, Feb 1, (AP): The 66th annual Grammy Awards are on Sunday, airing live from Los Angeles' Crypto.com Arena on CBS and Paramount+. So, what can viewers expect?

Some new, some old. Executive producers Raj Kapoor, Ben Winston, and Jesse Collins are returning for their fourth year - evolving the show from their first, which required completely reimagining the Grammys for COVID-19. In 2021, they had the idea to turn musicians into each other's audiences when there couldn't be one, a concept that has informed every



For example: artists sit at tables near the front of the stage to give the sense that the musicians and the audience as "just having a really lovely evening together," Winston told The Associated Press. "We've gone away from the big, grandiose, massive theaters with rows and rows and rows of people and actually try to make a really beautiful, bespoke concert every year.' He says there will continue

to be no close ups of musicians as the winners are read out - "and then people rewind to see the disappointment in people's faces," he says. "We've changed that because it becomes a bit too competitive. We've really just tried to make it a loving room for the music com-

Some elements of the stage - like the gramophone in the middle - will remain the same. "I really like the ideal of keeping elements of last year, but then changing key parts of it," he says - building off of what has succeeded in the past and making appropriate alterations for the new year.

Similarly, comedian **Trevor Noah** will host for a fourth time. "There's never a hesitation, never a hiccup. There's never a stumble," says Recording Academy CEO and President Harvey Mason jr. of their returning host. "He relates so well to the artists and to the music community in my mind, because he's a fan and he's an appreciator and a lover of music.

Performance

But what's new in 2024, and what should viewers keep an eye out for? Here are five burning questions - and answers.

Winston says "best pop solo performance" will likely be the first award of the night - remarkable because every nominee in the category is a woman.

"That's the same throughout the show, really - it's dominated by women," he says, joking that he brought up doing "ladies' night at the Grammys with only women performers," which was quickly shot down.

"I'm really excited about the mix of talent we have, and that's based on the nomination this year, which skew heavily female," says Kapoor. "That is something we're really celebrating. It's almost unprec-

Mason agrees, crediting the inclusion of so many women to the changing demographics at the Recording Academy.

"We have so many great women nominees leading some of the general feeling categories, which to is a direct result of a lot of the changes that we've been making at the academy," he says.

Last year, the organization announced over 2,400 diverse music creators joined their voting bloc - 50% are people of color, 46% are under the age of 40, and

Winston says there will be between "12 to 15 performers - it depends on if the memoriam counts as one

"He likes to put an arc through our show beyond just seeing performances on the stage," Mason says of Winston. "It feels like teamwork at all times - each artist brings their creative ideas; they have a creative director from their team collaborate with a creative director from our team - so it is this incredible mashup of ideas to produce the final results you see on TV.'

Winston says that for some artists, his team has created short films to play before their performances in order to "tell the story of the artist's year."

"We're going to put the spotlight on them and the significance of the moment that the audience are about to witness," he says, to provide helpful context for a general audience.

There are three new categories at the 2024 Grammy Awards as well, including the first-ever best African music performance award. Burna Boy, who is among the announced performers, is nominated in the cat-

Protocols

Kapoor points out, too, that this is the second year in a row that the Grammys are collaborating with a visual artist for its design: this year is Dave McLeod, a digital artist from the fine art world.

Last year, the Recording Academy announced a series of changes to the Grammy Awards to better reflect an evolving music industry. Of those newly instituted guidelines, protocols involving technological advancements in machine learning sparked headlines: "Only human creators" could win the music industry's highest honor in a decision aimed at the use of artificial intelligence in popular music.

What has been the public reaction - and how will artists respond? "I haven't heard much yet - I'm sure we'll hear more after the show," says Mason. "And I'm sure how we treat AI next year will be different than how we treat it next year. Right now, the way our awards team functions, there wouldn't be any music that was not eligible in any of the categories - so voters were able to vote with confidence that the screening has already taken place."

That's impossible to predict, but there are certainly a few contenders: if Taylor Swift takes home album of the year, she'd break the record of the artist with the most wins, ever, with four

If Victoria Monét 's "Hollywood" wins best traditional R&B performance, her daughter Hazel Monét will become the youngest Grammy winner in history at 2 years old. Karol G could become the first female artist to ever win in the best música urbana album category if she wins for "Mañana Será Bonito." Jack Antonoff could tie Babyface as the producer with the most consecutive wins in the producer of the year, non-classical category with a third win in 2024.

Kelly Clarkson could break the record for most best pop vocal album wins if she gets her third trophy for her 2023 album "Chemistry." Kendrick Lamar could extend his record in the best rap performance category if he wins for a seventh time for "The Hillbillies," his track with his cousin Baby Keem.

MOSCOW: A dissident Russian rock band angered by Moscow's war in Ukraine has arrived in Israel after being deported from **Thailand** under suspected pressure from the Kremlin, the performers said Thursday.

The seven members of the band Bi-2 were arrested last week after playing a concert on the southern resort island of Phuket, reportedly for not having proper working papers. On Facebook, they said all their concerts "are held in accordance with local laws and practices." Phuket is a popular destination for Russian expats and tourists. After paying a fine, the band members were sent to an immigration detention center in Bangkok.

Speaking in the arrival hall of Israel's Ben Gurion International Airport in Tel Aviv, guitarist and singer Aleksandr "Shura" Uman of Bi-2 said the band was doing well and very tired after their ordeal. He also called the conditions he and his band faced in a Thai iail as "horrible.

"We are free and we will keep moving forward," Uman said.

Uman thanked the Israeli, American and Australian diplomats, as well as human rights organizations, for their work to bring them to Israel. A handful of supporters met their early-morning flight with signs to welcome them to Israel.

Russia has denied it had a hand in trying to get the band deported. However, Moscow has a reputation for cracking down on artists critical of the war, even those working abroad. (AP)

LOS ANGELES: For about 15 years, Uriel Rincon told authorities he didn't recognize the gunman who killed Run-DMC's Jam Master Jay and wounded Rincon himself in the rap star's recording studio. But on Wednesday, Rincon pointed

Pearl Jam's music hits the pinnacle

WEST HOLLYWOOD, Calif., Feb 1, (AP): Pearl Jam blasted out their forthcoming album to a few hundred family, friends, industry insiders and reporters Wednesday, and the tracks showed they are doing anything but mellowing with age.
Singer Eddie Vedder, 59, lead gui-

tarist Mike McCready, 57 and bassist Jeff Ament, 60, played the record for the first time for invited guests at the Troubadour, the legendary Los Angeles-area club where Elton John and many other Rock & Roll Hall of Famers first made their names.

The Republic Records release will be the 12th studio album and first since 2020's "Gigaton" for the saints of the 1990s Seattle scene, who have been plying their trade together for more than three decades.

"You all get together as a group as we've been doing for 30-plus years and you say, 'Let's try it again," Vedder said from the stage as he introduced the album. "No hyperbole, I think this is our best work.

The title of the record and its songs, recorded by producer Andrew Watt at Rick Rubin 's Shangri-La studio in Malibu, California, are not yet being made public, nor is the date it drops. But musically, it's ready for release. 'We made this record like a year

Calls for heightened awareness and customized care

Young-onset cancer cases rise globally, vigilance urged

CLEVELAND, Feb 1: With cancer diagnoses in young people on the rise worldwide, it is important to raise awareness of symptoms, family history and differences in treatment approaches for adolescents and young adults, says an expert from global health system Cleveland Clinic, speaking ahead of World Cancer Day (February 4).

Global cancer cases in people under the age of 50 rose by 79% between 1990 and 2019, according to research recently published by the UK's University of Edinburgh. The study also shows cancer deaths among this population



grew by more than 27%, and it estimates there are now more than 1 million under-50s a year dying of cancer. Cancers of the breast, windpipe, lung, bowel and stomach are responsible for the majority of these deaths. 'Cleveland Clinic

other institutes globally are conducting research into why cancer incidence in young

people is increasing so significantly, and we believe the cause is multifactorial," says David Liska, M.D., a colorectal cancer surgeon who leads a multidisciplinary program to improve treatment approaches and outcomes for adolescent and young adult (AYA) and young-onset cancer patients at Cleveland Clinic.

"Researchers have noted a birth cohort effect." showing that people born in each decade since the 1950s have a higher incidence of youngonset colorectal cancer than those born in the preceding decades. This indicates that shared exposures to certain factors in the environment could be elevating their risk, whether this is changing eating habits, use of chemicals or any number of factors. Interestingly, we have discovered differences inthe gut microbiome, the metabolome, and the tumor immune microenvironment of younger and older people with the same cancers. Another consideration is that individual cancer risk factors such as obesity and leading a sedentary lifestyle are increasingly prevalent in this age group, and therefore likely contributing to the problem," says Dr. Liska, who is also director of Cleveland Clinic's Center for Young-Onset Colorectal Cancer.

Dr. Liska's advice to young people focuses on prevention, early diagnosis, and ensuring that treatment is managed by an experienced multidisciplinary team

Prevention

"In terms of prevention, we recommend following a healthy lifestyle, incorporating a balanced diet and regular exercise, and avoiding tobacco and excessive alcohol use," says Dr. Liska. "Early diagnosis is important, too, as the earlier a cancer is diagnosed and treated, the better the outcome will be. Individuals should never ignore persistent symptoms of any kind, but instead report them to a physician. People should also discuss any family history of cancer with their doctor, who can then advise on the optimal timing and frequency of cancer screenings, and whether they could be candidates for genetic testing."

As far as seeking treatment is concerned, Dr. Liska says acustomized approach is needed in younger patients as the biology of the cancers as well as the psychosocial and long-term treatment implications are different compared to older patient populations.

Dr. Liska explains that at Cleveland Clinic, a wide team of experts works closely with oncologists and surgeons to ensure that all of the young patients' needs are met. "There are unique factors facing younger patients at their life stage - for example, they might want to start a family, in which case consulting a fertility preservation specialist is important. Other younger people might have children and/or be looking after older parents, so the transition from becoming a primary caregiver to a person who needs care can be difficult financially and socially, which is where psychologists and social workers would be involved. Younger patients also benefit from the advice of wellness experts who can work with them to modify their diet, exercise and other lifestyle habits to support treatment, avoid complications related to the cancer or treatment, and reduce the risk of the cancer returning.

"Finding a multidisciplinary team specialized in treating young cancer patients is important as the quality of treatment received can have a significant impact on outcomes, not just in terms of a patients' survival but also their quality of life after treatment," says Dr. Liska.

Military personnel had 20% higher cancer risk

Study links Camp Lejeune water to several cancers

NEW YORK, Feb 1, (AP): Military personnel stationed at Camp Lejeune from 1975 to 1985 had at least a 20% higher risk for a number of cancers than those stationed elsewhere, federal health officials have said in a long-awaited study about the North Carolina base's contaminated drinking water.

Federal health officials called the research one the largest ever done in the United States to assess cancer risk by comparing a group who live and worked in a polluted environment to a similar group that did not.

The study found military personnel stationed at US Marine Corps Base Camp Lejeune were at higher risk for some types of leukemia and lymphoma and cancers of the lung, breast, throat, esophagus and thyroid. Civilians who worked at the base also were at a higher risk for a shorter list of cancers.

The study is "quite impressive," but cannot count as final proof that the tainted drinking water caused the cancers, said David Savitz, a Brown University disease researcher who is consulting for plaintiffs' attorneys in Camp Lejeune-related litigation.

"This is not something we're going to be able to resolve definitively," he said. "We are talking about exposures that happened (decades ago) that were not well documented.


But he said the new research will add weight to arguments made on behalf of people who got sick after living and working at the base.

Camp Lejeune was built in a sandy pine forest along the North Carolina coast in the early 1940s. Its drinking water was contaminated with industrial solvents from the early 1950s to 1985. The contamination - detected in the early 1980s - was blamed on a poorly maintained fuel depot and indiscriminate dumping on the base, as well as from an off-base dry cleaner.

Before wells were shut down, contaminated water was piped to barracks, offices, housing for enlisted families, schools and the base's hospital. Military personnel and families drank it, cooked with it and bathed in it.

The contamination has spawned a wave of litigation by law firms who have aggressively sought out clients with TV ads.

People who got sick after being at Camp Lejeune have accused the Marine Corps of failing to protect the health of its personnel and criticized the federal government for being slow to investigate. Marine Corps officials have repeatedly said that federal environmental regulations for these cancer-causing chemicals were not finalized until

1989, after the wells were shut down.

The Agency for Toxic Substances and Disease Registry, or ATSDR, an Atlanta-based sister agency to the Centers for Disease Control and Prevention, has done about a half-dozen studies focused on health problems in people at Camp Lejeune. Those studies were smaller than the new one, and had varied focuses, including ale breast cancer rates and birth defects in children born to base personnel.

Research

The earlier studies pointed out health risks, but the new work "more fully establishes the scope," said Richard Clapp, a Boston University emeritus public health professor who has been involved in past Camp Lejeune research.

Dr. Aaron Bernstein, the head of the ATSDR and CDC's environmental health programs, called the new study "remarkable" for being bigger and more rigorous than past research.

In the new paper, the ATSDR investigated cancer in about 211,000 people who were stationed at or worked at Camp Lejeune between 1975 and 1985 and compared them to about 224,000 people at California's Camp Pendleton - which was not known to have polluted groundwater - during the same time period.

Frank Bove, a senior epidemiologist, has led the agency's Camp Lejeune research for many years and was in charge of the latest study. He relied on staff at Battelle Memorial Institute and others to comb through cancer registries across the country to look for cases tied to ei-

They found a similar number of malignant cancers in each group, about 12,000. But the numbers - and the relative risks calculated from those numbers - were higher in the Camp Lejeune population for a number of specific types of cancer. That list included some that weren't clearly identified in some earlier studies, most notably thyroid cancer, Clapp said.

A federal law signed by President Joe Biden in August 2022 included language to address concerns of people who developed certain health problems they believe were linked to Camp Lejeune water contamination. It gave them a two-year window to file claims.

The new study may lead to inclusion of thyroid cancer to be added to the list of diseases for which Camp Lejeune personnel and their families might one day be compensated, Clapp said.

The paper, which underwent external peer review, is being submitted for publication, agency officials said.

PORTLAND, Ore.: Several elected leaders in Oregon declared a state of emergency on Tuesday for downtown Portland over the public health and public safety crisis fueled by fenta-

Oregon Gov. Tina Kotek, Portland Mayor Ted Wheeler and Multnomah County Chair Jessica Vega Pederson made the declaration for a 90-day period during which collaboration and response will come from a command center downtown. The three governments are directing their agencies to work with first responders in connecting people addicted to the synthetic opioid with resources including drug treatment programs and to crack down on drug sales.

Our country and our state have never seen a drug this deadly addictive, and all are grappling with how to respond," Kotek said in a statement.

The declaration is a recommendation from a governor-established task force that met for several months last year to determine ways to rejuvenate downtown Portland.

People addicted to fentanyl who interact with first responders in Portland's downtown in the next 90 days will be triaged by this new command center. Staff can connect people with various resources from a bed in a drug treatment center to meeting with a behavioral health clinician to help with registering for food stamps.

"We cannot underestimate the tremendous value of bringing leaders from different disciplines in a room on a daily basis who all account for a different part of the solution," Portland Mayor Ted Wheeler said in a statement.

Mike Myers, the director of Portland's Community Safety Division, will head the city's command team. Nathan Reynolds, deputy policy chief at the state's Office of Resilience and Emergency Management, will be the state's incident commander.

The effort also extends the Portland Police Bureau's partnership with Oregon State Police to jointly patrol downtown streets for fentanyl sales. It additionally kicks off information campaigns centered on drug use prevention and recovery programs across the region. The county will expand outreach and training on how to administer Narcan, an overdose-reversal drug.

The program doesn't establish any goals to measure success. Kotek said the next 90 days will provide a road map for the next steps.

Focus on alternative treatment

Biogen stops sale of Alzheimer's drug Aduhelm

NEW YORK, Feb 1, (AP): Biogen will stop selling its Alzheimer's treatment Aduhelm, a drug once seen as a potential blockbuster that stumbled after its launch a few years ago.

The drugmaker also said Wednesday that it will end a study of the drug needed for full approval from the Food and Drug Administration.

Patients taking doses of Aduhelm available through the commercial market can continue until November. A company representative said there are about 2,500 people worldwide taking Aduhelm. Biogen said it will turn its focus to other

treatments for the fatal, mind-robbing disease. The company also is helping Japanese drugmaker Eisai sell another Alzheimer's treatment, Leqembi, which received full FDA approval

Leqembi is the first medicine that's been convincingly shown to slow the cognitive decline caused by Alzheimer's disease, though only modestly. Regulators have approved it for patients with mild dementia and other symptoms caused by early Alzheimer's.

When Aduhelm debuted in 2021, it was the first new Alzheimer's drug in nearly two decades. The FDA had granted accelerated approval but required the additional study for full approval, which can spur broader insurance

Aduhelm promised to slow the progression of the disease instead of just managing its symptoms, like other drugs on the market.

Initially priced at \$56,000 a year, analysts predicted it would quickly become a blockbuster that would generate billions for Biogen. The federal government's Medicare program raised the premium it charges for its coverage partially because of an expected influx of Aduhelm claims.

But doctors were hesitant to prescribe the intravenous drug, given weak evidence that it meaningfully improved Alzheimer's patients lives. Insurers blocked or restricted coverage. Medicare, which eventually scaled back its premium hike, imposed strict limits on who could

That proved especially challenging for Biogen. Most U.S. Alzheimer's patients are old enough to qualify for the federal program, which covers patients age 65 and older

The drug wound up generating millions, not billions, in quarterly sales. Biogen announced in 2022 that it would largely shut down marketing of Aduhelm.

Last year, Biogen started an unsuccessful search for outside financing or partners to help with Aduhelm. That was done as part of a review the company did of its research and devel-

Biogen said it had considered during that review the time and investment that would be required for that additional study and likely advancements in the field before Aduhelm received full approval. Aside from Leqembi, patients also may soon

have another treatment option. The FDA is currently reviewing a potential drug from Eli Lilly and Co. A decision is expected early this year.

Biogen said it would book a charge of about \$60 million in its fourth quarter for shutting down the Aduhelm program

Shares of Cambridge, Massachusetts-based Biogen Inc. climbed around \$4 to \$251.11 in late-morning trading while the Standard & Poor's 500 index slipped.

JACKSON, Miss.: Mississippi could allow Medicaid coverage earlier in pregnancy in an effort to improve health outcomes for mothers and babies in a poor state with the nation's worst rate of infant mortality.

With wide bipartisan support, the state House passed a bill Wednesday to allow up to 60 days of "presumptive eligibility" for Medicaid, starting July 1. This means a pregnant woman's outpatient medical care would be paid by Medicaid

as her application for coverage by the government insurance program is being considered.

Processing Medicaid applications can take weeks, and physicians say early prenatal care is important. House Medicaid Committee Chairwoman

Missy McGee of Hattiesburg pointed out that Mississippi has high rates of fetal mortality, infant mortality and maternal mortality.

"I think this will go a long way in helping moms and babies be healthy ... and give babies the best shot for a healthy life," McGee said.

Mississippi ranks worst in the US for infant mortality, with Black infants nearly twice as likely as white ones to die over the past decade, according to a report unveiled Jan. 18 by the state Department of Health.

Presumptive Medicaid eligibility during pregnancy would be based on questions about income, asked by health care providers such as employees of county health departments. If a woman's Medicaid application is ultimately rejected because her income is too high, Medicaid would still pay health care providers for services they provided during the time of presumptive eligibility.

McGee said presumptive eligibility could cost the Medicaid program just under \$600,000

While his parents sometimes join him on the tennis tour now, they also still work - his dad helps out in the restaurant when he can and his mom runs the family guest house, Haus Sinner.



Hamilton linked with shock 'move' to Ferrari next year

SEVEN-time Formula One champion Lewis Hamilton has been linked with a shock move from Mercedes to Ferrari next year, according to reports on Thursday.

Sky Sports News said Hamilton would leave Mercedes after the 2024 season and replace Carlos Sainz Jr. at Ferrari. It didn't cite any sources. The Daily Mail also said the deal would go through while motorsport. com said it wasn't a done deal yet but negotiations were at an advanced stage and could be concluded this

When contacted by The Associated Press, Mercedes and Ferrari declined to comment on if Hamilton will join Ferrari.

The move would surprise many F1 observers because the 39-yearold British driver signed a new twoyear deal last summer until 2025, although it remains unclear whether the deal contained an escape clause.

Hamilton won six titles with Mercedes in seven years from 2014-20 and lost the 2021 championship to Red Bull's Max Verstappen on the final lap of the last race. He has not won a race since 2021 and remains stuck on a record 103 wins.

If he joins Ferrari he would likely replace Sainz, considering Sainz's teammate, Charles Leclerc, recently signed a multi-year contract exten-

Five years ago, Hamilton was asked if he could ever be tempted to

"If there is a point in my life where I decide I want a change, that potentially could be an option," he said at

the time.

In late 2019, Italian newspaper La Gazzetta dello Sport reported Hamilton met with Ferrari chairman John Elkann twice that year and they discussed Hamilton potentially replac-ing then-driver Sebastian Vettel at

Hamilton was subsequently asked at the season-ending Abu Dhabi Grand Prix that year if he met El-

"Naturally, everything that happens behind closed doors is always private with whoever it is you end up sitting with," Hamilton said. 'For many years, I've never ever sat down and considered other options, because we (Mercedes) have been driving straight ahead, on the same path. We're still on that path, and there's very little that's going to

joined Mercedes in Hamilton 2013 from McLaren in what was also a surprise move at the time.

After dominating to 2020, Hamilton and Mercedes have been frustrated in the past two seasons. Mercedes won only one race in 2022 when the car suffered from a bouncing effect, known in F1 as porpoising. The team admitted getting the design wrong.

Preseason F1 testing begins on

Feb. 21 in Bahrain. Bahrain also hosts the first of a record 24 races on March 2, when Verstappen starts his bid for a fourth straight world championship. (AP)



Injury scare for Sancho highlights role in Dortmund turnaround

DUESSELDORF, Germany, Feb 1, (AP): For a while after he returned to Borussia Dortmund, Jadon Sancho shrugged off more than four months

without playing at Manchester United. Sancho was back on the field for Dortmund two days after a move he said felt like "coming home," and he set up a goal. He started the next two games, winning a

penalty against Cologne. But that long lull finally seems to have caught up with Sancho, who has been out of training for much of this week with what coach Edin Terzic said was a problem with his adductor muscle

Sancho could miss Friday's game at Heidenheim. Terzic said it's simply a matter of being cautious, and so far Dortmund has given no indication it's expected to be a longer-term injury. Terzic linked the muscle problem to Sancho's long spell away from the first team at United, saying it "is not surprising after the long break that he had."

A return to Germany has breathed new life into Sancho's career, bringing back memories of when he was considered one of English soccer's brightest young stars and worthy of a \$100 million fee. He's also helped Dortmund revive its season.

Before Sancho arrived, the team was winless in four Bundesliga games, its domestic league form failing to match bright Champions League group-stage efforts. With Sancho, Dortmund has three wins from three.

But this injury scare shows how quickly he has become important to Dortmund again and raises questions

about how fragile his and the club's turnarounds might be.

A 3-1 win over Bochum on Sunday saw Dortmund overtake out-of-form Leipzig for fourth place and return to the Champions League qualifying spots for the first time since November. One competitor for Sancho's place in the lineup, U.S. midfielder Gio Reyna, is heading out on loan to Nottingham Forest.
