Commerce minister sets up committee

Kuwait moves to strengthen Consumer Law

(KUNA): The Commerce and Industry Minister Abdullah Al-Jouan issued a ministerial decree, Tuesday, forming a threemember committee to review the Consumer Protection Law, its associated regulations, implementation, and challenges.

The ministry announced in a press release that the committee's mission is to identify legislative and executive shortcomings, propose amendments to standard contracts to prevent unfair treatment of consumers, suggest awareness campaigns for consumer rights, ensure the consumer complaint process, and propose any necessary amendments.

The committee is responsible for studying topics referred to it by the minister concerning consumer protection, identifying legislative and executive deficiencies, and proposing amendments, the ministry stated.

LONDON, Feb 6, (AP): King Charles III's cancer was caught early and the whole country is hoping for a speedy recovery, British Prime Minister Rishi Sunak said Tuesday, as the monarch's son Prince Harry reportedly flew from the U.S. to visit his father.

Buckingham Palace announced Monday evening that the king has begun outpatient treatment for an undisclosed form of cancer. It was found during his recent hospital treatment for an enlarged prostate but is a "separate issue" and not prostate cancer, the palace said.

Australian meat will be available in Ramadan, no shortage: envoy

Visas for Kuwaitis via our mission in Dubai: Kelly

KUWAIT CITY, Feb 6: The Australian **Ambassador to Kuwait Melissa Kelly says Kuwait and Australia are celebrating this** year the 50th anniversary of the establishment of their diplomatic relationship.

She affirmed that the celebrations will be different and will focus particularly on the diplomatic activities between the two countries, indicating that the historic visit of Sheikh Jaber Al-Ahmad Al-Jaber Al-Sabah to Australia in 1992 will be a focal point for thought and contemplation.

During a press conference held the day before yesterday evening, Ambassador Kelly said, "This was the first visit of its kind by a Kuwaiti ruler to Australia. I look forward to witnessing this year visits from Kuwaiti ministers to Australia and an increase in visits by Australian ministers to Kuwait.

"Many things represent the pivotal threads in the fabric of our partnership. Behind our cooperation in the fields of food security, investment, education, and other fields, there are names and personalities that enabled that cooperation. For this reason, the Australian embassy's social media accounts will be highlighting the "50 Stories for 50 Years" campaign throughout 2024.

In response to a question regarding Australia's gradual end to the export of live sheep by sea, she explained that the Australian government had announced in 2022 its inten-

tion to gradually end the export of live sheep by sea. This will not begin in the government's current term (meaning it will not begin before mid-2025), as an independent committee will provide guidance to the government on the details of the phasing-out. No report has yet been released by the committee. There is close consultation with Kuwait regarding the details of the gradual end of the export.

The ambassador reassured that Australia is committed to remaining the ideal partner for Kuwait to ensure its

food security, adding that Australian meat will be present during Ramadan and there will be no shortage of it, through coordination with the Kuwaiti government, the livestock company, and the Embassy of Kuwait in Australia.

When asked about the situation of the Australian community in Kuwait, she said, "We have about 800 people working in various fields such as oil, education, and various other professions. Some have been in Kuwait for a long time, some are married to Kuwaitis, and some live with their families in Kuwait."

Regarding whether there were any discussions about lifting visas for Kuwaitis to enter Australia, she said, "Unfortunately, there are none at the present time. Visa applications must be submitted online because we do not issue entry visas through our embassy in Kuwait, but rather through our mission in Dubai.'

When asked about the military cooperation between the two countries, the ambassador said Australia is interested in the security of Kuwait and the Gulf region as a whole, adding that Australia had provided assistance in liberating Kuwait from the Iraqi invasion.

She affirmed that this cooperation continues, with the presence of a number of Australian soldiers in Camp Arifjan, which does not exceed ten soldiers, indicating that this number changes constantly.

Ambassador Kelly denied the existence of any discussions between the two sides to conclude deals to purchase weapons, stressing that her country is ready to support Ku-

wait if there is a Kuwaiti desire.

She said, "We have limited participation in securing the Red Sea at the present time. We are working with the government of Kuwait and the governments of the Gulf states in order to provide military security for the region.'

Regarding the volume of Kuwaiti investments in her country, the ambassador explained that, "According to official statistics, the amount of investment has reached about 30 billion Australian dollars. However, I believe that the real value is greater than that and perhaps twice this amount, given that it is difficult to monitor all Kuwaiti investments. These investments are diversified in the field of solar energy,

wind energy, and food security.

Concerning the number of Kuwaiti students studying in Australia, she indicated that there are 400 Kuwaiti students studying in Australia and they are well integrated into Australian society, affirming that, although the number is small,

they contribute to transferring Australian culture to Kuwait. Meanwhile, the Australian ambassador highlighted her country's position on what is happening in the Gaza Strip

and the funding of UNRWA.

She said, "We are closely following what is happening there. This is what was expressed by our country's Minister of Foreign Affairs, who called for the necessity of protecting civilians and delivering humanitarian aid.

Since October 7, Australia has increased aid to UNRWA to approximately 46 million Australian dollars. We work on cooperating with it, as it is the only organization in the United Nations capable of delivering aid.

However, at the present time, funding has been suspended due to what happened, as the catastrophic crisis in Gaza confirms the need for a political solution to the conflict".

dex, which includes 180. The state advanced 14 places compared

to its previous ranking. Meanwhile, the cabinet meeting, has approved the final form of the government action program.

The program will be tabled to the National Assembly soon after the government takes the oath of office before the parliament Tuesday, the government spokesman Amer Al-Ajmi said in a tweet on the X account of the Government Communication Center.

'Govt must pursue real reforms for better economic discharge'

"IN THE past decade, Kuwait has experienced an unprecedented surge in the establishment of various economic entities, both in terms of quantity and scope. The rationale behind this initiative was not officially, clearly, or comprehensively articulated by the government at the time," columnist **Dr Saud Al-Mu**tairi wrote for Al-Jarida daily.

"Some argue that it merely involved stripping government ministries of their

inherent functions to settle political detached debts, from any technical justifications. Conversely, others view it as a worthwhile policy aimed at activating sectors by freeing them from the constraints of traditional government agencies,

known for bureaucratic challenges and complex procedures.

'Setting aside the underlying intentions and objectives of creating these entities, this article focuses on examining the significance and role of these institutions since their inception in economic activities. The key question is whether they have had a positive impact on the economy and the country or the

opposite.
"While acknowledging the importance of the goals these entities aim to achieve in stimulating economic growth, it becomes evident, upon reviewing reports and statistics from specialized bodies, that most, if not all, have exhibited disappointing performances

"The Kuwait Direct Investment Promotion Authority, established in 2013, for instance, failed to attract foreign investments, ranking last among Gulf countries in 2022, significantly lagging behind the UAE, which secured the top spot.

"Similarly, the Competition Protection Authority did not enhance competitiveness, and inflation persists despite historically tight monetary policies.

'The Small and Medium Enterprises (SMEs) Fund, despite a substantial budget allocation, failed to make a tangible contribution to the local economy, lacking in job creation and neglecting important industries. The Authority for Public-Private Partnership Projects, established in 2014, has only presented one project, Shamal Al-Zour Company, which remains incomplete to date.

"The underwhelming performance of these bodies raises questions about whether the expansion of such entities is politically or technically motivated. Despite this, there are calls for establishing more bodies, like the State Property Management Authority and the Real Estate and Land Authority, rather than reevaluating the feasibility of continuing with the current entities.

"The real reform must be through the improvement and restructuring of exist ing institutions, addressing their challenges without political interference.

'The expansion of parallel bodies is deemed ineffective, and the focus should be on enhancing the performance of existing entities and reducing costs.

"Allocating entire bodies to achieve development goals is seen as insufficient evidence of the state's commitment, as it may serve narrow interests at the expense of the public. The government is urged to pursue genuine restructuring for better performance and cost-effectiveness, avoiding superficial changes with political motives.

"The State of Kuwait marked the ceremony of hoisting the Kuwaiti flag at Bayan Palace in the esteemed presence of His Highness the Amir Sheikh Mishal Al-Ahmad, may God protect and preserve him," columnist Dr. Hind Al-Shoumer wrote for Al-Anba daily.

"The hoisting of the Kuwaiti flag signals the commencement of Kuwait's festivities for its national days, the sixty-third Independence Day, and the thirty-third Liberation Day.

"The celebrations take various forms, including flag-raising ceremonies at government buildings, residences, and vehicles, national parades, the singing of patriotic songs and anthems, donning traditional attire, illuminating lights on official structures and homes, and fireworks displays.

"Kuwait's history spans over 400 years, with the establishment of Kuwait City in the seventeenth century and the

subsequent prosperity following the set-tlement of the Al-Sabah family.

"Archaeological evidence suggests that the region's history predates the

"From its inception, the majority of Kuwait's population engaged in pearl diving and maritime trade, fostering Kuwait's development into a commercial hub in the northern Arabian Gulf and a crucial port connecting the Arabian Peninsula and Mesopotamia. The pearl diving industry remained the cornerstone of Kuwait's economy until 1946, when the oil era commenced with the first oil shipment.

"Maintaining internal independence from the Ottoman Empire under the rule of the Al-Sabah family, Kuwait entered a phase of British protection during Sheikh Mubarak Al-Sabah's reign. The protection agreement with the British Empire, signed in 1899, provided Kuwait with external political stability and laid the foundation for modern governance. The treaty was terminated on June 19, 1961, and Kuwait declared its independence.

"Âs we celebrate this year, let our festivities reflect Kuwait's economic and political stature. It is imperative that all citizens ensure the dignified raising of the Kuwaiti flag and refrain from disrespecting or damaging the flags. The flag is the emblem of our nation, and those participating in the celebrations should adhere to public decorum, preserve the cleanliness of our country, and avoid causing harm to others. Celebrations should be a source of joy, not sadness

"I extend an invitation to all to partake in the celebrations of the national days, fostering love for our homeland and instilling patriotism in our children. May the bonds of belonging, loyalty, and sacrificial love for the nation be fortified.

"Congratulations to the Kuwaiti people and all the Gulf states on our national days under the guidance of our sagacious leadership. I pray to God Almighty for our perpetual safety, security, and stability. Wishing everyone good health, and well-being.

"My heart ... the homeland, then the citizen. He expresses his opinion in the morning, then he has another opinion before the day ends, according to the interest and hypocrisy that increased and spread among the people recently," Kuwaiti citizen Sheikh Ali Al-Jaber Al-Ahmad wrote for Al-Seyassah daily.

mentioned in the previous article? "Recognition is the master of evidence, as one of the nation's representatives stated with courage, that the government is responsive to the National Assembly more than necessary. Thus, there is no comparison with the representatives of the European assemblies, whose cooperation with their governments is for the benefit of their countries. Here, some representatives' cooperation with the government is for the benefit of their relatives. We do not know when they will oblige us to

change our impression of them. "This piece of news made me laugh: Representatives advised His Highness the Prime Minister not to back down in the face of pressure. The question is: Gentlemen, where does the pressure come

10 years imprisonment, KD33m fine in money laundering case

Court acquits activist in 'false' X upload

KUWAIT CITY, Feb 6: The Criminal **Court acquitted activist Talal Al-Dabbous** who was accused of publishing a medical report of Dr. Obaid Al-Wasmi on X social media platform, which would have caused damage to his reputation.

According to the case file, the Public Prosecution charged Talal Fahad Al-Dabbous and others, as stated in the indictment report, with publishing confidential medical reports of legislator Dr. Obaid Muhammad Al-Mutairi on X social networking application.

The prosecution explained that such publication was aimed at harming the reputation of the victim. The accused used words intended for harming his dignity, as stated in the investigations. They also intentionally committed the offenses using a smartphone.

During the court session, which was attended by the accused along with his defense counsel Lawyer Mohammad Al-Husseini, he denied all charges leveled against him.

Lawyer Al-Husseini stressed the complainant is a member of the Kuwaiti parliament and claims to fight corruption and recover stolen funds, and he has publications denouncing this.

He said, "We were surprised by the trending of pictures on social media sites that included his dental treatment abroad at the state's expense of \$47,000, which unjustly cost the state's public treasury. Out of concern and fear for the state's money, the actions in question were published as well as out of criticism of the complainant because he is a public figure, and in a bid to serve the public interest of the state."

Jail, heavy fine: The Criminal Court, headed by Judge Nayef Al-Dahoum, sentenced the owner and the director of a car sale office to 10 years in prison and fined them KD33 million in a money laundering case, reports Al-Rai daily.

The court also ordered freezing the company's accounts and referral of the case to the Civil Court.

Attorney Abdul Mohsen Al-Oattan, in his capacity as representative of a number of the victims, said: "The court does not take into account the defendants' denial, especially since there is no evidence to support their claim that they did not commit the crime. The Public Prosecution referred them for trial based on incriminating evidence.'

Al-Qattan added "the actions of the defendants harmed the victims and disrupted commercial transactions; hence, the need to impose the harshest penalties on them as per the law. In this manner, the victims can reclaim

He revealed the two defendants were charged with fraud and laundering large sums after more than 500 people in and outside the country accused them of swindling

He said the defendants laundered the amounts they collected from the victims, which are estimated at more than KD17 million and OAR 1.5 million, to hide their illegal source. They deceived the victims by deluding them about the possibility of purchasing luxury vehicles at a lower price, and these vehicles will be shipped and delivered to them.

Earlier, the prosecution referred two citizens and a general trading and contracting company to the court for claiming that they can import cars at prices lower than the actual value and to deliver them within a short period.

Forged permits used to enter 'no-go' area

KUWAIT CITY, Feb 6: In a recent development, Abdullah Qunais reports that port authorities have initiated investigations against three foreign nationals, all in their thirties, on charges of unlawfully entering and facilitating entry into a restricted area using a falsified permit purportedly belonging to another individual. As per a security insider, two of the apprehended individuals were caught during their attempted entry, with one found in possession of a forged permit, while the other presented a permit not registered under his name. Subsequent inquiries revealed the involvement of a third accomplice in the scheme, reports Al-Rai daily.

Upon questioning, the suspects confessed to their involvement, with the initial accused disclosing that he had obtained a permit from the third party to facilitate the entry of the second individual for work purposes. The collaboration among the trio was allegedly premeditated.

Further investigations by detectives confirmed the complicity of all three individuals, as the driver, identified as the first invitee, had procured the permit from the third individual, despite its belonging to an unrelated party. The said permit was in the possession of the third accused.

The case underscores the gravity of forgery and breaches of security protocols within Kuwait's port facilities.

Liquor, illegal entry: Al-Ahmadi law enforcement officials successfully apprehended four expatriates in the Mina Abdullah area suspected of unlawful entry. Upon thorough investigation and search, authorities discovered three bottles of locally brewed alcohol in their possession.

According to a security source, the four individuals have been referred to the Administrative Deportation Department for processing and eventual repatriation to their respective countries. Additionally, their names have been added to the list of individuals prohibited from entering the country.

Kuwaiti doing drugs in car held Drugs Control thwarts attempt

to flood market with narcotics KUWAIT CITY, Feb 6: The vigilant ef- over to the Drugs and Liquor Prosecution

forts of the General Department of Narcotics Control have thwarted an attempt to introduce approximately 11 kilograms of narcotic substances and 133 thousand narcotic pills into the local market, reports Al-Anba daily. According to a statement released by

the Ministry of Interior, police officers received information about three individuals possessing narcotic substances with the intention of trafficking. Consequently, a parliamentary permit was obtained, and the three suspects were apprehended following a strategic ambush. Six kilograms of shabu and hashish, along with five kilograms of lyrica powder and pills, were seized during the operation.

The three detainees confessed to possessing narcotic drugs for the purpose of trafficking. Subsequently, they, along with the confiscated items, were handed

for further legal proceedings, with the intention of referring them to the judiciary.

Kuwaiti arrested: The security authorities from the Jahra governorate have arrested a Kuwaiti who is in his thirties for consuming drugs inside his car in the parking lot of a commercial complex in Jahra, reports Al-Seyassah daily. During a body search police found

with the man narcotic pills and a sum of money. According to a source, he was arrested during a routine patrol in the Jahra Markets area, a car with its interior lights on raised police suspicions.

Upon closer inspection, a person inside the vehicle was found in a state of drug use. A search conducted as a precaution before yielded narcotic pills. The suspect was subsequently taken into custody and referred to the General Administration for Narcotics Control.



Major violations noticed Forex brokerage firm under focus

KUWAIT CITY, Feb 6: The Capital Markets Authority (CMA) says it has uncovered significant violations involving a foreign exchange brokerage firm operating through external brokerage companies, reports Al-Jarida daily.

The violations primarily revolve around discrepancies between customer transaction records and their corresponding accounts.

The company failed to reconcile these records and accounts, resulting in a disparity between the amounts recorded internally and those held in customers' bank accounts and third-party accounts used for executing orders.

The violations also extend to the transfer of cash amounts from clients' wallets to the company's bank account without proper documentation, as well as the failure to reconcile records with external parties, such as financial bro-

These firms hold private accounts for executing client transactions in securities, further exacerbating the inconsistencies within the company's internal records.

The company's activities encompass providing trading services and tools across various financial markets, including Forex, precious metals, stocks, indices, commodities, and energies. Additionally, it offers market information and analyses to trading clients and investors.

The Capital Markets Authority is committed to enforcing securities laws and regulations, ensuring accountability for all market participants.

Consequently, the companies involved have been referred to the Disciplinary Board for appropriate penalties, aiming to restore investor confidence and foster a transparent and trustworthy investment environment aligned with international


On the level of cooperation, Kuwait and Oman had closely coordinated efforts throughout their history, forming in 2001 a cooperation committee to hold regular meetings.



It also includes rendering it to be the key to land communication routes between Asia and Europe, starting with Mubarak Port, which must be reactivated. The planned routes must be completed, and sovereign funds must be invested at home instead of being exposed to the fluctuations of global financial

There is no doubt that the expulsion of investments from Kuwait made it seem like an island isolated from the world, while other neighboring countries opened up to the world and worked to establish private universities, as in the Emirates, which today has about 60 private universities and colleges. As for Qatar, there are 30 private universities. On the other hand, in Kuwait, the university city in Shadadiya has been suffering from obstruction since its approval in 1986. To this day, that project has not been completed.

Also, our health sector suffers from mismanagement and lack of professionalism. A total of 112 private hospitals and 53 government hospitals have been built in the Emirates alone. All of this has helped develop its local economy, because it has become a treatment and educational hub for thousands of patients and students coming from abroad.

Kuwait could have benefited from all of this if there had been an understanding behind the meaning of opening the country based on well-thought-out plans, instead of being controlled by the mentality of "the foreigner who is coming to eat our wealth", as some shortsighted people imagine to this day.

They are the ones who advocate the culture of others, to the extent of reviving tribalism and sectarianism among the members of society, while forgetting that a person's true dignity is his experience and his understanding of how to serve his

All these important issues were presented by His Highness the Prime Minister, with whom the editors-in-chief, during the meeting with him, felt he had a great deal of understanding of what the country requires. He made them feel completely comfortable with the path that the government embarked on

There is no doubt that His Highness the Prime Minister has all the tools to work towards achieving the government's program. He also has great public support, and the confidence of the political leadership.

This is proof that Kuwait is governed by one ruler, and not 51 MPs, as was the case in recent years. Therefore, after this meeting, we believe that the affairs of the country have been handed over to the expert.

- The National Assembly discussed a number of incoming letters in its ordinary session on Tuesday - the most important of which is the government's request to postpone the discussion

and voting on the reports of parliamentary committees about the bills for one month for further study, taking into consideration that the government is new.

Some MPs supported the new government's request, pointing out that the Assembly approved a similar request submitted by the previous government headed by HH the former Prime Minister Sheikh Ahmad Nawaf Al-Ahmad Al-Jaber Al-Sabah; so the new government deserves to be treated in the same manner.

However, other MPs argued that even if the Assembly approved a similar request in the past, it was in response to the cooperation of the previous government that led to the ratification of four bills. They pointed out that the new government seems to be buying time since it did not promise to approve the bills in case they are discussed after the one month grace period.

The Priorities Committee chairman disclosed that during their meeting with the government, many options were presented, such as voting on urgent bills in the first reading and the second reading should be done in the session scheduled for March 5, 2024 – when the government is ready to present its opinion. He added the government rejected all the other options, an indica-

tion that it is not keen on passing the bills.

On the other hand, Minister of State for National Assembly and Youth Affairs Dawoud Maarefi affirmed that the new government is as committed as the Assembly in improving the citizens' standard of living and ensuring financial sustainability

Deputy Prime Minister and Minister of State for Cabinet Affairs Sheriada Al-Meosherji also stressed that improving the citizens' standard of living is the main item of the government's work program. He explained that the request to postpone discussing the bills is only aimed at giving the government a chance to study them carefully, before presenting its opinion.

Nevertheless, MPs Mubarak Al-Hajraf, Abdulkareem Al-

Kandari, Bader Nashmi and others stressed that this excuse of the government is unacceptable, considering the technical teams in different ministries have already studied the bills and submitted their reports. They also pointed out that the new government consists of some ministers who were members of the previous government and they affirmed support for the bills. They said the institutions should not change whenever the ministers change.

He disclosed that the report of the parliamentary fact-finding committee highlighted violations, including the manipulative acts of the Purchase Committee at the Ministry of Defense regarding the deals to buy Caracal helicopters and Eurofighter planes. He called on the minister to read the report on the armament deal carefully in order to take the appropriate action. He went on to say that some officers were punished and humiliated, because of their role in discovering the truth and some of them were even forced to retire.

MP Abdulhadi Al-Ajmi commented on his queries to Minister of Education, Higher Education and Scientific Research Adel Al-Adwani about increasing the capacity of the College of Medicine and the health institutes. He added some students, who obtained a grade of 99 percent, could not enroll at Kuwait University due to the lack of seats.

He also inquired about the reasons for suspending the scholarships for medical sciences in Jordan and Egypt, while the country hires doctors who graduated from the universities in both

The session was adjourned until Wednesday to discuss other items in the agenda, including the government's work program and the MPs' response to the Amiri speech.

Snow hits Tokyo

SKoreans stay 'calm' despite North threats

SEOUL, South Korea, Feb 6, (Agencies): North Korea's recent escalation of threats and more tests of weapons aimed at South Korea haven't done much to upset the calm in the nation's capital.

"We learned to be numb," said Renee Na, a 33-year-old office worker in Seoul who was one of a dozen South Koreans who sounded more indifferent than scared when talking with The Associated Press.

"Our generation grew up seeing North Korea use nuclear provocations as showmanship to maintain the stability of its regime," Na said. "When they act up, it doesn't feel like a real threat, but more like an annual event they stage when the, unity or want outside help."

That's a stark contrast to results from Pyong-



recent comments from Pyongyang, where leader Kim Jong Un said in January that his nation was abandoning its fundamental objective of peaceful reconciliation with South Korea. He also repeated a threat to annihilate the South if provoked.

At the same time, North Korea has conducted a streak of weapons testing, including what it described as simulated

nuclear attacks on the South. Worries about a direct provocation were amplified after the North fired hundreds of artillery shells into waters near its disputed western sea boundary with

South Korea, prompting the South also to fire. For now, there's concern in South Korea - but not

And it's nothing like 1994, when waves of panicked crowds emptied stores of instant ramen and rice after a North Korean negotiator threatened to turn Seoul into a "sea of fire.

North Korea has mastered a cycle of raising tensions with weapons demonstrations and threats before eventually offering negotiations aimed at extracting concessions. The result is that many South Koreans believe North Korea is using its old playbook to get attention during an election year in South Korea and the United States.

'Halt airstrikes': Nine members of the United Nations Security Council (UNSC) condemned "indiscriminate" airstrikes by Myanmar's military against civilians before an envoy briefed the council Monday as part of regional efforts to implement a peace plan that has so far been largely ineffective.

The plan, adopted in April 2021 shortly after the military seized power in a takeover that sparked a civil war, calls for the immediate cessation of violence in Myanmar, a dialogue among all concerned parties, mediation by a special envoy from the Association of Southeast Asian Nations, provision of humanitarian aid through ASEAN channels, and a visit to Myanmar by the special envoy to meet all concerned parties.

Veteran diplomat Alounkeo Kittikhoun - the special envoy to Myanmar from this year's ASEAN chair, Laos, and a former U.N. ambassador - addressed a closed council meeting on behalf of the 10-member Association of Southeast Asian Nations. Kittikhoun committed to implementing ASEAN's "five-point consensus" for peace in Myanmar through continued "quiet diplomacy," according to a council diplomat familiar with the meeting who spoke on condition of anonymity because the meeting was private.

The military leadership in Myanmar has so far ignored the plan, and violence and the humanitarian crisis in the country have been growing at a rapid pace.

Cambodia ruling party files lawsuit: Lawyers for Cambodia's ruling Cambodian People's Party filed a lawsuit Monday at the order of the party's leader. former Prime Minister Hun Sen, accusing a leading rights activist of defamation and seeking damages of half a million dollars.

The complaint was filed in Phnom Penh Municipal Court against Soeng Sen Karuna, deputy chief of Cambodia's biggest rights group, ADHOC. The lawsuit asserts that remarks by Soeng Sen Karuna caused dishonor to the ruling party. The court is expected to determine which law would be applicable for the complaint.

There have been previous cases in which political opponents of the ruling party have been ordered to pay punitive damages after being found guilty of defama-

The complaint, according to a copy seen by The Associated Press, referred to comments Soeng Sen Karuna made in a recent interview in which he allegedly said that the Cambodian People's Party used the country's courts as a tool to thwart or intimidate its political opponents.

Heavy snow hits Tokyo, injures 240: Rare heavy snow hit Tokyo and surrounding areas, injuring at least 240 people, authorities said Tuesday.

Among them, 135 people in Tokyo were taken to hospital due to snow-related injuries, the Tokyo Fire Department said in a statement. 31 flights were cancelled Tuesday so far, mainly to and from Tokyo's Haneda Airport, according to the airlines.

Snowfall also caused suspensions or delay of some trains linking Tokyo with other cities, and affected Tokyo metropolitan area's transit systems, the operators said. Expressway sections in and around Tokyo were also partially closed.

Central Japanese village of Nozawa Onsen observed 82 cm of snow through Tuesday morning, while central Tokyo recorded 8 cm of snow, the Japan Meteorological Agency said, urging people to take precautions although the snowfall has passed its peak.

Thousands of vehicles stuck in China highways: Icy conditions trapped thousands of motorists on

highways in central China as snow and freezing rain snarled travel by air, train and road during the annual Lunar New Year holiday rush. A Chinese travel blogger said she and her boyfriend were waiting with others Tuesday for de-icing work to

be completed after covering only 30 to 40 kilometers (20 to 25 miles) in 13 hours the previous day. Traveling in the relative comfort of a motorhome, Chen Wei appeared unperturbed by the delay in the

trip to her hometown. She quoted an old Chinese saying, telling the AP she "accepts what comes and faces it with calmness."

The heavy snow, unusual for central China, was forecast to continue into Wednesday. Millions of people are heading home for the Lunar New Year, which falls on Saturday. Families traditionally gather for dinner the night before.

'Security still fragile at N-plant': Security at Ukraine's Zaporizhzhia Nuclear Power Plant remains fragile amid worrying recent staff cuts enacted by Russian authorities occupying the facility, which is one of the 10 biggest atomic power plants in the world, the United Nations nuclear watchdog

chief said Tuesday. International Atomic Energy Agency chief Rafael Grossi, who is in Kyiv, told The Associated Press that his upcoming visit to the plant as the war approaches its twoyear milestone will aim to assess the impact of recent personnel reductions after Russia denied access to employees of Ukraine's Energoatom.

"This huge facility used to have around 12,000 staff. Now, this has been reduced to between 2,000 and 3,000, which is quite a steep reduction in the number of people working there," Grossi said. "To man, to operate these very sophisticated big installations you need a certain number of people performing different specific functions."

Germany doubles contribution: Germany will double its contribution of about 100 troops to the NATO-led peacekeepers in Kosovo in a demonstration of its commitment to regional security, German Defense Minister Boris Pistorius said Monday.

Pistorius, who was on a regional tour to Kosovo and neighboring Serbia, said Germany will add another company of soldiers to the 99 troops it already has in the nearly 4,500-strong peacekeeping force by spring. It is also prepared to add more if necessary, he said.

"I believe the signal is strong and expresses our perspective on the stability of this region," Pistorius said at a news conference with Kosovar President Vjosa Osmani.

NATO has been ramping up the level of the Kosovo Force, or KFOR, from about 3,800, following two violent incidents last

In May, Serb demonstrators in northern Kosovo clashed with NATO peacekeeping troops. In September there occurred a deadly gunbattle when about 30 Serb gunmen clashed with Kosovo police, leaving a Kosovar officer and three Serb gunmen

Biden going small to try to win big in Nov

WASHINGTON, Feb 6, (Agencies): US President Joe Biden is going small to try to win big in November.

With 10 months to go until Election Day, the Democratic incumbent is all in on minimalist events - visits to a boba tea store, a family's kitchen and a barbershop, for example - rather than big rallies.

Never much of an orator, Biden is leaning into his strength as a retail politician honed over more than 50 years in elected office. But the strategy also reflects what his team sees as a changed media landscape, where TikTok videos and Instagram stories can reach voters more effectively than television ads and speeches.

Last month in Raleigh, North Carolina, Biden picked up burgers and fries from Cook Out and brought takeout to what his campaign described as a "kitchen table conversation" at the home of Eric Fitts, who works in the local school system and benefited from the administration's student loan forgiveness programs.

Biden's campaign taped the visit, which was closed to reporters, and later released curated snippets online. But the highlight for the president's team was unplanned. One of Fitts' sons, Christian, shared a 57-second video on TikTok, offering a behind-the-scenes look at Biden's drop-by, including the president admiring photos on the family's fridge and his limo pulling out of their driveway.

Concerns

The post quickly attracted millions of views, and Biden's campaign was happy to steer reporters to it even though the campaign itself doesn't use TikTok due to national security concerns.

"You have to go to the places where people are," said Biden deputy campaign manager Rob Flaherty. He added that in an era when people consume media on different platforms that cater to individual tastes, it's harder than ever for campaigns to reach the voters they need.

For Biden, those voters are often the least engaged with the political process - younger, more racially diverse than the country at large and unenthused about a likely rematch between Biden and former president Donald Trump.

"We have to widen the aperture of what the president's time is good for,

and who he's talking to and why," Flaherty said. Biden kicked off the presidential elec-

tion year with a pair of big speeches near Valley Forge, Pennsylvania, and in Charleston, South Carolina, meant to lay out the choice for voters in November. His campaign says he'll continue to hold set-piece events, especially closer to the summer once voters begin to tune in, but they see as much - if not more - value in smaller interactions.

Biden's less-than-electric speaking style and sometimes rambling speeches at larger events have become fodder for Trump and GOP critics to feed into the notion that the 81-yearold president is not up to another four years in the White House. Trump, by contrast, rarely holds retail events, preferring his signature rallies before large crowds of supporters - many of whom wait hours to get in - or appearances at sporting events.

The campaign hopes Biden's gosmall strategy is a way to show the American people a different side of the president that will help boost his lagging poll numbers.

WASHINGTON: Former UN Ambassador Nikki Haley has requested Secret Service protection after receiving a growing number of threats during her 2024 presidential campaign, according to a report published Monday. Haley told The Wall Street Journal

while campaigning in South Carolina that she had made the request. "We've had multiple issues," she

said. "It's not going to stop me from doing what I need to do.'

Neither Haley's campaign nor the Secret Service responded to requests for comment.

Both President Joe Biden and former President Donald Trump receive Secret Service protection. The Secret Service protects the president and vice president as well as their families along with some senior government officials. It is also authorized to provide protection to major party presidential candidates, an authority granted after the assassination of Robert F. Kennedy in 1968.

Haley is the last major challenger to Trump in the Republican primary race. She is focusing on South Carolina's Feb. 24 primary as an opportunity to demonstrate momentum against Trump, though she is also traveling the country to attend fundraisers and is scheduled to appear at a rally in California on Wednesday.

WASHINGTON: The US House is ready to impeach Homeland Security Secretary Alejandro Mayorkas over border security, a deeply partisan and highly unusual attack on a Cabinet official that has drawn concerns from constitutional scholars and rebuke from Democrats.

Republicans in the House argue that Mayorkas has "refused to comply" with immigration laws resulting in the record surge of immigrants at the US-Mexico border and "breached the public trust" by his actions and comments. The House vote on the charges, which Democrats say are untrue and hardly grounds for impeachment, is set for Tuesday.

Not since 1876 has a Cabinet secretary faced impeachment charges and it's the first time a sitting secretary is being impeached - 148 years ago, Secretary of War William Belknap resigned just before the vote.

"Very clearly Secretary Mayorkas has picked and chosen which laws he's going to enforce," said Rep. Mark Green, R-Tenn., the chairman of the Committee on Homeland Security, at a hearing ahead of the vote. The impeachment charges against

Mayorkas come as border security is fast becoming a top political issue in the 2024 election, a particularly potent line of attack being leveled at President Joe Biden by Republicans, led by the party's front-runner for the presidential nomination, Donald Trump.

Record numbers of people have been arriving at the southern border, many fleeing countries around the world, in what Mayorkas calls an era of global migration. Many migrants are claiming asylum and being conditionally released into the US, arriving in cities that are underequipped to provide housing and other aid while they await judicial proceedings which can take years to determine if they

BP exceeds expectations with \$3 billion earnings

Oil and natural gas giant BP beat expectations on Tuesday with earnings of \$3 billion in the last three months of 2023, bringing last year's total to half its record 2022 profit as energy prices have fallen since spiking after Russia's invasion of Ukraine.

London-based BP reported its underlying replacement cost profit, which excludes one-time items and fluctuations in the value of inventories, was down from \$3.3 billion in the previous quarter.

It brought in \$13.8 billion for all of last year, a huge drop from the \$27.7 billion it earned in 2022, when Russia's war in Ukraine sent oil and natural gas prices surging. Those prices drove inflation and contributed to a cost-of-living crisis, drawing outrage from consumers facing higher utility bills while energy companies saw explosive growth in their bottom lines.

Energy prices have since fallen as a weak global economy holds back demand for fossil fuels to power cars, planes, factories and more.

Despite the drop in annual earnings, BP kept its dividend steady and said it would buy back \$1.75 billion in shares as well as commit to \$3.5 billion in additional share buybacks for first half of this year. The company's stock rose 5.75% in morning

"Looking back, 2023 was a year of strong operational performance with real momentum in delivery right across the business," CEO Murray Auchincloss said in a statement. "We are confident in our strategy, on delivering as a simpler, more focused and higher-value compa-

IEA likely to upgrade oil demand projections

Oil prices rally in January on geopolitical risk and economic optimism



■ Brent futures rallied in January, posting their first monthly increase since September with a rise of 6% m/m to \$81.7/bbl. (Chart 1.) Price gains reflected a combination of heightened geopolitical risk in the Middle East, inventory drawdowns in the US and better-than-expected global economic activity. Houthi attacks on passing vessels in the Red Sea forced shipping companies to transit around the much lengthier—and costlier—Cape of Good Hope in South Africa. Meanwhile, US commercial crude oil inventories dropped to a multi-month low in December, further adding to the bullish impulse. Prices were also buoyed with the release of data showing that the US economy grew at a much faster rate than expected in Q4 23 and after Chinese authorities unveiled stimulus measures to support the economy. Local marker Kuwait Export Crude (KEC) closed the month at \$84.1/bbl, up 5.7%

■ In terms of oil demand expectations for the year ahead, the outlook looks slightly more positive following the upgrade to global GDP growth by the IMF in January: growth was revised up from October's forecast by 0.2% pts to 3.1%. The International Energy Agency (IEA), which takes its economic cues from the IMF, may follow suit with another upgrade to its oil demand projections for 2024, having just last month revised them up by 180 kb/d to 1.24 mb/d from 2.25 mb/d in 2023. (Chart 2.) The organization has raised its 2024 forecast by a cumulative 380 kb/d in total since June last year and was behind the curve in its 2023 oil demand growth estimates, underestimating the resilience of gasoline consumption especially. OPEC, meanwhile, has been consistent since the outset in its projection of oil demand growth of around 2.25 mb/d for 2024. The oil exporters' group has been firm in its view of abovetrend demand and has extended the bullish narrative into 2025 with its projection of growth of 1.85 mb/d to 106.2 mb/d. Consumption growth in non-OECD countries will account for 94% of this rise.

■ On the supply side, OPEC+ has determined that further supply restraint will be necessary in 2024. The group will roll over and deepen last year's voluntary production cuts through Q1—and potentially longer to balance the market and prevent a large buildup of oil inventories. The volume of cuts pledged at November's OPEC+ meeting was around 2.2 mb/d, though in practice only about 500 kb/d will be fresh cuts including



135 kb/d from Kuwait, 223 kb/d from Iraq and 82 kb/d from Kazakhstan. Russia signed up to an additional 200 kb/d of export reductions (refined products). Saudi's 1 mb/d voluntary production cut rollover remains the largest item in the 'cut' announcement.

■ OPEC+ output (quota-bound members only and





excluding Angola) is therefore scheduled to fall to 34.3 mb/d in Q1. (Chart 3.) Supply in December rose to 34.7 mb/d (+49 kb/d), according to combined OPEC secondary source and S&P Global data, with the largest gains coming from Nigeria (+99 kb/d) and Kazakhstan (+30 kb/d), offsetting slight declines in most members. Out-

side of quota-bound members, Iran's output declined modestly from November's post-2018 sanctions high of 3.2 mb/d to 3.1 mb/d. Iranian production soared in 2023: with gains of almost 600 kb/d, it was one of the largest contributors to global supplies. Meanwhile, Venezuela, which has benefitted from a reprieve in US sanctions, has been gradually pumping more oil. Output in December reached 786 kb/d (+7 kb/d m/m), its highest level since February 2019.

■ Non-OPEC supply, meanwhile, increased by 2.3 mb/d in 2023, the IEA estimated. This was mainly on the back of output gains in the US, Canada, Brazil and Guyana. In the US, oil production expanded at the fastest rate since 2019, by more than 1.0 mb/d to 12.9 mb/d, according to US Energy Information Administration (EIA) data. Weekly EIA data showed that output, at 13.0 mb/d, was hovering near its record high of 13.3 mb/d. (Chart 4.) Remarkably, such gains have taken place while oil drilling has been in decline (-19.5% in 2023), though by the end of January the drop in the number of active oil rigs appeared to stabilize at the 500 level, according to Baker Hughes. Looking ahead, the EIA thinks such oil production gains are unlikely to be sustained, with growth dropping to less than 300 kb/d on average over the next two years.

■ As far as the outlook for 2024 is concerned, notwithstanding the forecasting uncertainties by research houses over the pace of global economic and demand growth amid a myriad of factors including the prospects for monetary policy easing in the US and the Europe, we think that overall activity will be fairly solid. Oil demand growth will slow from last year's 2.2 mb/d but remain slightly above trend at 1.4 mb/d given ongoing consumption gains in emerging markets. Non-OPEC supply growth should also moderate, with Iran and the US not expected to bring on supply at 2023's breakneck pace.

■ OPEC+ supply management will, therefore, once again be key to the oil price outlook, geopolitical risk apart. Provided that supply cuts remain in place beyond Q1, we think OPEC could succeed in keeping market balances tight, with bias towards a stock decline. Of course, OPEC+ compliance issues and market share considerations are bound to come into play and could result in supply cuts being unwound from Q2 onwards: OPEC+ will not want to cede market share to rivals by suppressing supply indefinitely. Nevertheless, we think that Brent will find support at the \$80/bbl level for the year.

KUWAIT CITY, Feb 6: The Effect of Competitiveness of Kuwaiti Banks on Risk Profile and Profitability study by the Institute of **Banking Studies Research** covers several topics, of which the main one is investigating the impact of competition on profitability and risk profile in the Kuwaiti banking sector, in addition to other related relevant subjects.

Other topics include Covid-19 and the impact of the geo-political environment on banking competition, the talent war among banks and its implications for banks' performance from a cost to income perspective, new payment technologies and their implications for fee income for banks, the implications of digital banks and new Telco market penetration for the banking and financial services landscape. The following bullet points summarize the findings of the study:

- Competition among Kuwaiti banks is not significantly high due to the significant concentration in the Kuwait banking sector.

- Concentration has a favorable significant impact on profitability and the risk profile of banks in the Kuwaiti banking sector.
- Interest rate spread increases banks' profitability while it slightly increases credit risk, but not liquidity and capital risk.
- Income diversification slightly increases risk exposure due to monitoring difficulties across the sectors engaged with.
- Coping with the new post-pandemic trends reshaping the future of the banking industry landscape, namely new monetary and fiscal policies, digitalization, regulation,

'Three interest rate cuts in '24'

Powell acknowledges Fed's 'misjudgment' on inflation

WASHINGTON, Feb 6, (AP): Chair Jerome Powell said in an interview broadcast Sunday night that the Federal Reserve remains on track to cut interest rates three times this year, a move that's expected to begin as early as May. Powell, in an interview recorded

Thursday for the CBS news program "60 Minutes," also said the nation's job market and economy are strong, with no sign of a recession on the horizon.

"I do think the economy is in a good place," he said, "and there's every reason to think it can get bet-

Powell's comments largely echoed remarks he gave at a news conference Wednesday, after the Fed decided to keep its key interest rate steady at about 5.4%, a 22-year high. To fight inflation, the Fed raised its benchmark rate 11 times beginning in March 2022, causing loans for consumers and businesses to become much more expensive.

The Fed chair also reiterated that the central bank's next meeting in March was likely too soon for a rate cut. Most economists think the first

cut is likely to come in May or June. With inflation steadily cooling, nearly all the 19 members of the Fed's policy-setting committee have agreed that cuts in the central bank's key rate will be appropriate this year, Powell said in the "60 Minutes" interview. A reduction in that rate would help lower the cost of mortgages, auto loans, credit cards and other consumer and busi-

ness borrowing.
In December, Fed officials indicated that they envisioned three rate cuts in 2024, reducing their benchmark rate to about 4.6% by year's end. Powell told "60 Minutes" that that forecast likely still reflected policymakers' views.

As gauged by the Fed's preferred measure, inflation fell to just 2.6% in December compared with 12 months earlier. And in the second half of 2023, inflation was measured at an annual pace of just 2%, matching the Fed's target level, down drastically from a peak of 7.1% in the summer of 2022

Powell attributed the inflation surge of 2021-2022 to the disruptions of the pandemic, including a shift in spending away from services, like restaurant meals, to goods,

like home office furniture and exercise bikes. At the same time, COVID closed down or slowed factories across the globe, severely disrupting supply chains and causing widespread shortages of goods and components. Both trends, Powell said, accelerated inflation.

At the same time, Powell acknowledged in the interview, the Fed misjudged the duration of the resulting inflation, which it repeatedly suggested would prove shortlived. As he has before, Powell said the central bank moved too slowly to raise its key rate, which can help slow borrowing and spending. Inflation began spiking in mid-2021 yet the Fed didn't start raising rates until March 2022.

"So in hindsight, it would've been better to have tightened policy earlier," Powell said, referring to rate hikes. "I'm happy to say that. ... We thought that the economy was so dynamic that it would fix itself fairly quickly. And we thought that inflation would go away fairly quickly without an intervention by us."

At his news conference Wednesday, Powell signaled that the Fed was likely to cut rates this year but underscored that central bank officials wanted to see further evi-

dence that inflation is in check. "It's not that we're looking for better data - it's just that we're looking for a continuation of the good data that we've been getting," he said. "We just need to see

Also Wednesday, Powell repeatedly acknowledged the strength of the U.S. economy and noted that inflation had slowed without the sharp rise in unemployment and weak growth that many economists had said would be necessary to cool consumer demand and slow

price increases. "We've got six months of good inflation data and an expectation that there's more to come," Powell said Wednesday. "So this is a good situation. Let's be honest. This is a

good economy."
Other Fed officials have expressed caution about the prospect of rate cuts, particularly after a government report Friday showed that job growth soared unexpectedly in December, a sign that businesses remain confident enough in the economy to add many workers.

China pledges measures to boost domestic consumption

China will introduce a raft of measures to boost domestic consumption this year, state-run Xinhua News Agency reported Tuesday, such as stimulating purchases of vehicles and household appliances.
"Automobiles, household ap-

pliances and home furnishing are the focus of traditional consumption and are closely related to people's lives," Vice Minister of Commerce Sheng Qiuping said at a press conference in

Beijing.
Sheng also mentioned how China aims to work on promoting vehicle trade-ins this year due to the great demand among people and the potential for replace-

Last year, the world's second economy's new car sales exceeded 30 million units for the first time, up 12 percent year on year, while its second-hand car

trading volume reached 18.41 million units in 2023, an increase of nearly 15 percent.

Car ownership has reached 340 million in China, ranking first in the world, according to the vice minister

China will also encourage the renovation of old houses and the replacement of home appliances, as part of a package of measures to bolster domestic demand, Sheng added. (KUNA)

Swiss bank UBS reports a pretax loss in 4th quarter

UBS on Tuesday reported a fourth-quarter pretax loss of more than \$750 million as the Swiss banking giant continued to integrate its longtime rival Credit Suisse after a government-or-

chestrated merger.
The Zurich-based lender reported losses before tax of \$751 million in the quarter, which included losses of more than a half-billion dollars linked to an investment in SIX Group,

which operates Switzerland's main stock market. The net loss in the quarter came in at \$278

UBS said it expects to complete the merger of Credit Suisse by the end of the second quarter this year, and the merger of the two banks' Swiss operations by the end of the third quarter. The company plans to increase its dividend for the 2023 financial year by 27 percent, and said it would resume share buybacks in the second half of the year.

As we move to the next phase of our journey, we will focus on restructuring and optimizing the combined businesses," CEO Sergio Ermotti said in a state-

Toyota raises its profit outlook after solid earnings helped by a weak yen

TOKYO, Feb 6, (AP): Toyota raised its full fiscal year profit forecast Tuesday after reporting its profit in the October to December quarter nearly doubled from the year before.

Toyota Motor Corp.'s third quarter profit totaled 1.36 trillion yen (\$9 billion), up from 727.9 billion yen in the same period in 2022, as Japan's top automaker recovered from losses suffered when the coronavirus pandemic

slammed computer chip production. In the first nine months of the fiscal year, Toyota reported a 3.9 trillion yen (\$26 billion) profit, more than double what it racked up the previous fiscal

A favorable exchange rate also helped the maker of the Camry sedan, Prius hybrid and luxury models. A weak yen raises the value of overseas earnings when they are converted into yen. The dollar has been trading at about 148 yen lately, up from 140 yen a year ago.

Quarterly sales rose 23% to 12.04 trillion yen (\$81 billion) from 9.75 tril-

Toyota, based in central Japan's Toyota city, raised its full fiscal year profit forecast to 4.5 trillion yen (\$30 billion), from an earlier forecast of 3.95 trillion yen (\$27 billion). It earned 2.45 trillion yen in profit in the year that ended in March 2023.

Toyota also raised its full year sales projection to 43.5 trillion yen (\$294 billion), from an earlier estimate of 43 trillion yen (\$290 billion). It was 37

trillion yen in the previous fiscal year. Cost cuts, marketing efforts and the currency exchange effects are behind

its revision of its forecast, Toyota said. The company did not raise its vehicle sales forecast for the full fiscal year, instead cutting it to 9.45 million vehicles. Toyota had earlier expected to sell 9.6 million vehicles. Even the lower forecast is better than the previous fiscal year's sales of 8.8 million

The shortage of computer chips has hurt automakers, including Toyota. Production has been suspended recently at Toyota group's Daihatsu Motor Co., which makes small models, under Japanese government orders after the automaker admitted it had faked safety tests for decades.

No major accidents have been reported in connection with the cheating, but the tests will have to be carried out properly. The scandal began after a whistleblower came forward in April 2023. Daihatsu has apologized and promised sweeping reforms of its cor-

porate culture. The impact on Toyota sales and profits will be relatively limited because the subsidiary makes up a small fraction of Toyota's massive global sales

The owners of Yandex are selling at a big, Kremlin-required discount

FRANKFURT, Germany, Feb 6, (AP): The Dutch parent of pioneering Russian tech company Yandex is selling its operations in the country at a steeply discounted price of just over \$5 billion to its Russia-based managers and oil company Lukoil, one of the biggest deals for Western-held companies to exit Russia since the invasion of Ukraine.

The price reflects a 50% discount that Moscow imposes on companies from "unfriendly" countries like the Netherlands as a condition of exiting business in Russia, according to a statement Monday from Nasdaqexchange listed Yandex NV.

It follows drawn-out negotiations that show the complexities international companies must navigate if they want to unload their Russian businesses, which many have been struggling to do since President Vladimir Putin's February 2022 invasion of Ukraine and the sweeping financial and economic sanctions that followed.

Yandex, founded in 1997 as Russia's answer to Google and Yahoo, serves Russian-speaking customers through its search engine and with widely used apps for food delivery,

car-sharing and shopping.
Co-founder Arkady Volozh, who had earlier moved to Israel, resigned as CEO in 2022 after he was hit with European Union sanctions. He subsequently condemned Russia's invasion as "barbaric." The Nasdaq exchange suspended trading in Yandex shares

days after the invasion.
"We can welcome the agreement reached by the shareholders on the sale," Kremlin spokesman Dmitry Peskov said in a conference call with reporters. "The company's Russian management will remain as the main owner. Of course, it's important for us that the company continues its operations in this sphere.

"We know that the negotiations were long, and we welcome their completion," he added.

The sale in cash and shares worth 475 billion rubles would transfer Yandex's core business - representing more than 95% of its revenue, assets and employees - to the group of up to 50 managers, Lukoil and business en-

Ryazanov. The 50% discounted sale price was based on the average value of Yandex shares on the Moscow exchange for the three months ending Jan. 31 - \$10.2 billion. That's after shares had already fallen by more than half in ruble terms since their peak before the invasion.

After the sale, Yandex NV would be left with its international businesses - employing 1,300 people - including self-driving technology and generative artificial intelligence as well as a data center in Finland.

Yandex NV Chairman John Boynton said the company had faced "exceptional challenges" since the start of the war.

"We believe we have found the best possible solution for our shareholders, our teams and our users in these extraordinary circumstances," he said in a statement.

Boynton said the sale would "allow shareholders to recover some value for the businesses that we are divesting, while unlocking new growth potential for the international businesses we will

Hurdles for businesses to exit Russia include finding partners who are not under U.S. or European sanctions as well as avoiding banned financial transactions. None of the purchasers have been sanctioned, Yandex NV said, and the cash part of the transaction would be conducted in Chinese yuan outside of Russia.

Companies fleeing Russia not long after the war began ended joint ventures and wrote off stakes worth billions. For instance, McDonald's sold its 850 restaurants to a local franchisee, while France's Renault took a symbolic single ruble for its majority stake in Avtovaz, Russia's largest carmaker.

Others are still struggling to leave because of the hurdles put in place by Putin's government, and some are simply staying put.

The government also has seized as-



"All's fair in love and poetry..." her caption read. In a little over an hour, the Instagram post alone had amassed nearly 7 million likes - a figure that swelled to an apt 13 million in under a day. "And so I enter into evidence / My tarnished coat of arms / My mus-

es, acquired like bruises / My talismans and charms / The tick, tick, tick of love bombs / My veins of pitch black ink," read what appeared to be handwritten lyrics posted after the album cover.

Inside Los Angeles' Crypto.com Arena, Swift's album announcement elicited screams from the upper levels.

Swift had provoked mass speculation earlier in the night when her site seemed to go down. Some theorized she was gearing up to release "Reputation (Taylor's Version)," but cryptic clues on the "crashed" site indicated that might be a misdirect. And so it was.

The site's back up now, focused around the upcoming album, with preordering and merchandise options. The album will feature 16 tracks, with some editions offering a bonus track, "The Manuscript," according to product descriptions. On Monday night, Swift released a track listing on social media.

Collaborations include "Fortnight," featuring Post Malone, and "Florida!!!" featuring Florence + the Machine. A selection of other song titles: "Down Bad," "I Can Fix Him (No Really I Can)," "loml" and "Clara Bow."

Launched

This will be Swift's 11th studio album, not counting her re-recordings. Her last original album was "Midnights," released in October 2022. Since then, she's launched the billion-dollar Eras Tour and released 'Speak Now (Taylor's Version)" and "1989 (Taylor's Version)."

Swift was accepting the Grammy for "Midnights" when she made the surprise announcement. She later picked up album of the year, the show's final award, for the album.

"I would love to tell you this is the best moment of my life, but I feel this happy when I finish a song, or when I crack the code to a bridge that I love, or when I'm shortlisting a music video, or when I'm working with my dancers," she said after accepting her album of the year award from Celine Dion. With it, she broke the record for the most wins in that category (her other albums of the year: "Fearless," "1989"

While a nod to the album - and reminiscent of the "tick, tick, tick" in "The Tortured Poets Department" post - the watch seemed particularly apt, given the superstar's seemingly packed schedule over the next week. Swift is set to head back out on her Eras Tour this week, performing for four nights in Tokyo. She still will be able to make it back to the US later in the week to catch her boyfriend Travis Kelce playing in the Super Bowl.

A tale of serenity amidst Tokyo's hustle

Wim Wenders' 'Perfect Days' is sublime

Wim Wenders' "Perfect Days" is set among the VV crowded skyscrapers of Tokyo and the quiet urban parks that Hirayama (Kôji Yakusho) traverses daily in his job cleaning public toilets. But where the

movie resides, really, is Yakusho's face. In this gently sublime film, Hirayama steps outside his humble apartment each morning and gazes up at the sky with a smile radiating gratitude. Hirayama says little throughout the course of Wenders' quiet, quotidian film. Little happens. Yet Yakusho's warm presence speaks volumes in a film where less can mean profoundly more.

Wenders, the 78-year-old German filmmaker, has long had a preference for troubled loners. Think of Harry Dean Stanton's dusty drifter in "Paris, Texas," or Bruno Ganz's terminally ill man in "The American Friend." But the Wenders' movie that "Perfect Days' most recalls is "Wings of Desire," where melancholy angels watched over Cold War-era Berlin and spoke of testifying "day by day for eternity." "Perfect Days" has no such supernatural element, but its gaze is likewise attuned to what's beautiful and meaningful in everyday living.

Each morning, Hirayama wakes, puts on his blue sanitation jump suit and neatly drapes a white towel around his neck. He drives his van from public toilet to public toilet, where he takes remarkable care in his work. He uses a small mirror to see the underside of a

"How can you put so much into a job like this?" says Takashi (Tokio Emoto), Hirayama's younger, less scrupulous coworker.

Hîrayama's days are rigorously routine but lively with variation. While driving through the elevated highways of Tokyo, he selects a cassette tape from a rack above the sun visor. Patti Smith, Lou Reed, the Kinks, the Animals or Nina Simone play as he rides. Usually, Hirayama, analog through and through, is driving against the traffic.

He's a lover of trees, and each day on his lunch break takes a photograph of the branches above him,

with light pouring through. With the care of a surgeon, he plucks a tiny seedling, places it in a small paper sack, and adds it to his nursery at home. At night, he

reads Faulkner. Eventually, a niece (Arisa Nakano) turns up, followed by Hirayama's estranged sister (Yumi Aso). But Wenders' film, which is nominated for best international film at the Oscars and opens in theaters Wednesday, is largely uncluttered by plot or exposition. Instead, we're invited to ponder Hirayama's serene, monastic existence - to admire the joy he finds in the mundane

and the attentiveness he gives to the things he values. Is he running from the world or in its thrall? Wenders, who co-wrote the film with Takuma Takasaki, is a longtime admirer of Japan; in his 1985 documentary "Tokyo-Ga," Wenders traveled to Japan to pay homage to the great filmmaker Yasujiro Ozu. Much in 'Perfect Days," filmed in boxy academy ratio, radiates with a similar spirit of minimalistic wisdom.

That's a great credit to Yakusho, the great Japanese actor, whose soulfulness fills the empty spaces of "Perfect Days." It may sound like an art house enterprise but anyone could connect with Wenders' film. My 8-year-old daughter accompanied me on my second watch; that she hung with the movie from start to finish, I think, is because Yakusho's Hirayama is a char-

Wenders was initially drawn to the project by Tokyo's exquisite public toilets, which are light years more artfully designed than the few you can even find in most American cities. In that way, they're a symbol of civic good. And so is Hirayama, who in his life and work, in plant life and cassette tapes, fully encapsulates the definition of custodian.

"Perfect Days," a Neon release, is rated PG by the Motion Picture Association for some language, partial nudity and smoking. Running time: 123 minutes. Four stars out of four.

Women triumph

'24 Grammy Awards signal changing tide

LOS ANGELES, Feb 6, (AP): When the 2024 Grammy nominees were first announced, women dominated the major categories. And at Sunday's show, those nominations translated into awards: Every televised competitive Grammy went to at least one woman.

Several women earned their very first Grammys, including Miley Cyrus, best new artist Victoria Monét, country artist Lainey Wilson and Karol G - also the first woman to win in best música urbana, a moment that may reflect changing perceptions of reggaetón and Latin hip-hop as exclusively "men's music."

"You know, I feel a lot of responsibility about that. As a woman, I have to say, like in my experience, it was tough, like so many things, to be a girl in this industry, in the music that I



do, in urban music," the "Mañana Será Bonito" artist told The Associated Press backstage, saying she also reflected 'women in the world fighting to represent" themselves.

Paramore became the first rock band fronted by a woman to win best rock album. And Taylor Swift, of course, not only made history by becoming the first artist to win album of the year four times - but she

also is still the only woman to ever win more than twice. "First of all, I think it is just wonderful to see so many women at the top," Dua Lipa told the AP on the red carpet, moments before she opened the show with

a fiery pop medley. a hery pop mediey.

"What we want is just an equal space in the industry and to be seen equally on equal levels - not just on the creative side but on the business side - so hopefully the equality in the industry will kind of level things out a little," she added. "I think we're still kind of figuring that part out. But we're getting there, slowly."

The evidence points to what Lipa is referencing: Only 19.5% of all songwriters across the Billboard Hot 100 songs in 2023 were women, according to analysis from the USC Annenberg Inclusion Initiative. Women still make up a fraction of producers and engineers

But at the Grammys, where much of the focus is on performers, it appeared like women were ruling the

Phoebe Bridgers of boygenius won her first Grammys last night, taking home more than any other performer last night, with four.

In the week leading up to the Grammys, Bridgers told the AP there was some significance to the band's recognition because "it was only a couple of years ago now that that (expletive) who is now being accused of sexual violence said women need to step it up if they want to be nominated."

She was referring to former Recording Academy President Neil Portnow, who, in 2018, said women need "to step up" if they wanted to receive Grammys and then issued an apology. He stepped down in 2019. In November 2023, Portnow was sued by a woman who said he had drugged and raped her in 2018, an allegation his representative has called "completely

Bridgers renewed her critique backstage at the Grammys, telling the media room, as she held one of her four trophies, that she hopes he'll "rot."

The Recording Academy has made considerable changes to their programming in the post-Portnow years, attempting to better reflect the current musical climate. Recently, more than 2,400 music creators joined the voting bloc - of those new additions. 50% are people of color, 46% are under the age of 40, and 37% are women.

In January, Recording Academy CEO and President Harvey Mason jr. theorized the number of women nominated was "a direct result of a lot of the changes that we've been making at the academy," something echoed by Swift while accepting her first award of the

"I know that the way the Recording Academy voted is a direct reflection of the passion of the fans," she

said. The question then becomes: Was this year a fluke? The result of an all-star year of women who couldn't be ignored? A correction? Symbolic of some systemic

shift? Or something else entirely? The only real televised criticism came from Jay-Z, the lone man awarded solo on the telecast (Finneas also won a televised Grammy, alongside his sister, Billie Eilish). His acceptance speech for the Dr. Dre Global Impact Award began by shouting out the rap legends that came before him - the ones who worked to bring hip-hop to the preeminent music award show, only to have rap categories not make the official broadcast Sunday

"We want you all to get it right," Jay Z said in his speech. "At least get it close to right."

History

The he switched focus to Beyoncé, who last year became the most decorated artist in Grammy history, with 32 trophies.

"Most Grammys, never won album of the year. How does that work?" he said of his wife. "Even by your own metrics it doesn't work.

Emily Lordi, a Vanderbilt University professor whose focus is African American literature and Black popular music, says there is value in examining the intersections of race and feminism at the Grammys

This year, two women - SZA, for her critically acclaimed and groundbreaking "SOS," and Janelle Monae, for her innovate treatise on sensuality and freedom "The Age of Pleasure," were up for album of the year. If one of them had taken it home, the winner would have become the first Black woman to do so since Lauryn Hill with "The Miseducation of Lauryn Hill" in 1999.

Lordi says that record "suggests a residual and highly flawed view of Black women's music as 'niche, despite the fact that "Black women have foundationally influenced every genre of American music, so that Billie Eilish's vocal style is a direct descendant of Billie Holiday's aesthetic, just as Miley is made possible by Tina Turner, and Taylor by Tracy Chapman.'

Janelle Monae, who has 10 career nominations, did not win a Grammy - and never has. SZA, who led nominations with nine, took home three awards - but was completely shut out of the general field categories.

There's much to celebrate about the 2024 Grammys, including its focus on female performers - something that wouldn't have seemed possible as recently as 2011, when the Grammys still had gender-specific

The Grateful Dead pulled out ahead of Elvis Presley and Frank Sinatra with 59 total Top 40 entries on the chart Monday following the No. 25 debut of their archival release "Dave's Picks, Volume 49: Frost Amphitheatre, Stanford U., Palo Alto, CA (4/27/85 & 4/28/85)." Elvis and Sinatra are

stuck at 58 albums apiece. It's a remarkable run, made even more special since the group disbanded following the death of Jerry Garcia in 1995. Forty-one of the band's 59 entries in the Top 40 have happened since 2012, thanks to the popularity of the series of archival albums compiled by **David Lemieux**.

Lemieux in a statement credited the Dead for recording so many live shows and "the loyalty and passion of the many Dead Heads who have made this record possible." He said it "could be the most unlikely and unexpected record in music history

The record could be further solidified: Another volume in the Dave's Picks series will be released in April, capturing the band's May 1977 shows at the Palladium in New York City. (AP)

NEW YORK: Gap Inc. has tapped American fashion designer Zac Posen as the chain's creative director.

The hire announced on Monday is among the first big personnel moves under the San Francisco-based chain's new CEO Richard Dickson, who took the helm in August and is aiming to turn around years of languishing sales. Dickson had previously been president of toy giant Mattel and was responsible for re-energizing its Barbie and Hot Wheels lines.

Gap also operates stores under Athleta and Banana Republic, Old Navy and its namesake brand.

In a statement, Dickson said Posen's "technical expertise and cultural clarity have consistently evolved American fashion, making him a great fit for the company as we ignite a new culture of creativity across the portfolio and reinvigorate our storied brands

Posen, who launched his eponymous collection in 2001 and was known for his glamorous body-hugging gowns, was a red carpet favorite for such stars as Katie Holmes and Rihanna. But the business later struggled and was forced to shut down in 2019.

He'll be executive vice president at Gap Inc. and also chief creative officer for the lower-priced Old Navv chain. Posen will work closely with Haio

Barbeito, Old Navy's president and CEO, reporting directly to him, the company said. Gap's shares rose nearly 1%, or 16 cents, on Monday to close at \$19.97. They are up 31% in the last 12 months. (AP)

Legendary singer-songwriter suffered from cancer

Country icon Toby Keith dies at 62

NORMAN, Okla., Feb 6, (AP): "Beer For My Horses" singer-songwriter Toby Keith has died. He was 62.

Keith, who was battling stomach cancer, passed peacefully on Monday surrounded by his family, according to a statement posted on the country singer's website. "He fought his fight with grace and courage," the statement said. He was diagnosed in 2022.

Sometimes a polarizing figure in country music, the 6-foot-4 singer broke out in the country boom years of the 1990s, crafting an identity around his macho, pro-American swagger and writing songs that fans loved to hear. Over his career he publicly clashed with other celebrities and journalists and often pushed back against record executives who wanted to smooth his rough edges.

He was known for his overt patriotism on post 9/11 songs like "Courtesy of the Red, White and Blue," and boisterous barroom tunes like "I Love This Bar" and "Red Solo Cup." He had a powerful booming voice, a tongue-incheek sense of humor and range that carried love songs as well as drinking

Among his 20 No. 1 Billboard hits were "How Do You Like Me Now?!," "Should've Been a Cowboy," Good As I Once Was," "My List" and "Beer for My Horses," a duet with Willie Nelson

Keith worked as a roughneck in the oil fields of Oklahoma as a young man, then played semi-pro football before

launching his career as a singer. "I write about life, and I sing about life, and I don't overanalyze things,' Keith told The Associated Press in 2001, following the success of his song "I'm Just Talking About Tonight."

Lessons

Keith learned good lessons in the booming oil fields, which toughened him up, but also showed him the value of money.

"The money to be made was unbelievable," Keith told The Associated Press in 1996. "I came out of high school in 1980 and they gave me this job December of 1979, \$50,000 a year. I was 18-years-old."

But the domestic oil field industry collapsed and Keith had not saved. "It about broke us," he said. "So I just learned. I've taken care of my money

He spent a couple seasons as a defensive end for the Oklahoma City Drillers, a farm team for the now-defunct United States Football League. But he found consistent money playing music with his band throughout the red dirt roadhouse circuit in Oklahoma

"All through this whole thing the only constant thing we had was music," he said. "But it's hard to sit back and say, 'I'm going to go make my fortune singing music, or writing music. I

Eventually his path took him to Nashville, where he attracted the interest of Mercury Records head Harold Shedd, who was best known as a producer for the hit group Alabama. Shedd brought him to Mercury, where he released his platinum debut record

"Toby Keith," in 1993. "Should've Been a Cowboy," his breakout hit, was played 3 million times on radio stations, making it the most played country song of the 1990s.

But label's focus on global star Shania Twain overshadowed the rest of the roster and Keith felt that the executives were trying to push him in a pop direction. "They were trying to get me to com-

promise, and I was living a miserable existence," Keith told the AP. "Everybody was trying to mold me into something I was not.' After a series of albums that pro-

duced hits like "Who's That Man," and cover of Sting's "I'm So Happy I Can't Stop Crying," Keith moved to Dream-Works Records in 1999.

Independent

That's when his multi-week "How Do You Like Me Now?!" took off and became his first song to crossover to Top 40 charts. In 2001, he won the male vocalist of the year and album of the year at the Academy of Country Music Awards, exclaiming from the stage: "I've waited a long time for this. Nine years!'

Songs like "I Wanna Talk About Me," a spoken-word song written by Bobby Braddock about a man frustrated by a talkative partner, got him attention for its similarity to the cadence of rap, which Keith dismissed. "They're going to call it a rap song, (although) there ain't nobody doing rap who would call it rap," he told "Billboard" magazine in 2001.

Keith often wore his politics on his sleeve, especially after the terrorist attacks on US soil in 2001, and early on he said was a conservative Democrat, but later claimed he was an independent. He's played at events for Presidents George W. Bush, Barack Obama and Donald Trump, the latter giving him a National Medal of the Arts in 2021. His songs and his blunt opinions sometimes caused him controversy, which he seemed to court.

His 2002 song, "Courtesy of the Red, White and Blue (The Angry American)" included a threat-"We'll put a boot in your ass - It's the American way" - to anyone who dared to mess with America.

That song got pulled from a patriotic ABC Fourth of July special after producers deemed it too angry for the show. Singer-songwriter Steve Earle called Keith's song "pandering to people's worst instincts at a time they are hurt and scared."

Then there was the feud between

Keith and The Chicks (formerly called the Dixie Chicks), who became a target of Keith's ire when singer Natalie Maines told a crowd that they were ashamed of then President George W. Bush. Maines had also previously called Keith's song "ignorant."

Keith, who had previously claimed that he supported any artist's freedom to voice their opinion about politics, used a doctored photo of Maines with an image of Saddam Hussein at his concerts, further ramping up angry fans.

Maines responded by wearing a shirt with the letters "FUTK" onstage at the 2003 ACM Awards, which many people believed was a vulgar message to Keith.

He also publicly called out actor Ethan Hawke, who had written a story in "Rolling Stone" that described an argument between Kris Kristofferson and an unnamed country star that sounded a lot like Keith. During a backstage press conference during an awards show, Keith was furious at Hawke (and reporters for repeating the story) for what he called a "fictitious (expletive) lie."

Keith, who has acknowledged that he holds onto grudges, walked out of the ACM Awards in 2003 early because he had gotten snubbed in earlier categories, causing him to miss out when he was announced as entertainer of the year. Vince Gill accepted on his behalf. He came back the next year and won the top prize for a second year in a row, along with top male vocalist and album of the year for "Shock 'n Y'all."

Career

His pro-military stance wasn't just fodder for songs, however. He went on 11 USO tours to visit and play for troops serving overseas. He also helped to raised millions for charity over his career, including building a home in Oklahoma City for kids and their families who are battling cancer.

After Universal Music Group acquired DreamWorks, Keith started anew again, starting his own record label, Show Dog, in 2005 with record executive Scott Borchetta, who launched his own label Big Machine at the same time.

"Probably 75 percent of the people in this town think I'll fail, and the other 25 percent hope I fail," he said that year.

Later the label became Show Dog-Universal Music and had Keith, Trace Adkins, Joe Nichols, Josh Thompson, Clay Walker and Phil Vassar on its

His later hits included "Love Me If You Can," "She Never Cried In Front of Me," and "Red Solo Cup." He was inducted into the Songwriters Hall of Fame in 2015.

He was honored by the performance rights organization BMI in November 2022 with the BMI Icon award, a few months after announcing his stomach cancer diagnosis.

Researchers publish findings on artificial intelligence and immunity

New study highlights Al's role in enhancing immunotherapy

from global health system Cleveland Clinic and IBM have published a strategy for identifying new targets for immunotherapy through artificial intelligence (AI). This is the first peerreviewed publication from the two organizations' Discovery Accelerator partnership, designed to advance research in healthcare and life sciences.

The team worked together to develop supervised and unsupervised AI to reveal the molecular characteristics of peptide antigens, small pieces of protein molecules that immune cells use to recognize threats. Project members came from diverse groups led by Cleveland Clinic's Timothy Chan, M.D., Ph.D., as well as IBM's Jeff Weber, Ph.D., Senior Research Scientist, and Wendy Cornell, Ph.D., Manager and Strategy Lead for Healthcare and Life Sciences Accelerated Discovery.
"In the past, all our data on cancer

antigen targets came from trial and error," says Dr. Chan, chair of Cleveland Clinic's Center for Immunotherapy and Precision Immuno-Oncology and Sheikha Fatima Bint Mubarak Endowed Chair in Immunotherapy and Precision Immuno-Oncology. "Partnering with IBM allows us to push the boundaries of artificial intelligence and health sciences research to change the way we develop and evaluate targets for cancer therapy."

For decades, scientists have been researching how to better identify antigens and use them to attack cancer cells or cells infected with viruses. This task has proved challenging because antigen peptides interact with immune cells based on specific features on the surface of the cells, a process which is still not well understood. Research has been limited by the sheer number of variables that affect how immune systems recognize these targets. Identifying these variables is difficult and time intensive with regular computing, so current models are limited and at times inaccurate.

Published in Briefings in Bioinformatics, the study found that AI models that account for changes in molecular shape over time can accurately depict how immune systems recognize a tar-

get antigen. Through these models, researchers could home in on what processes are critical to target with immunotherapy treatments such as vaccines and engineered immune cells.

Researchers can incorporate these insights into other AI models moving forward to identify more effective immunotherapy targets.

"These discoveries are an example of what makes this partnership successful - combining IBM's cuttingedge computational resources with Cleveland Clinic's medical expertise,' Dr. Weber says. "These findings resulted from a key collaboration between everyone from a world-class expert in cancer immunotherapy to our physics-based simulation and AI experts. Collaboration when combined with innovation has terrific potential."

Cleveland Clinic and IBM launched their Discovery Accelerator partnership in 2021, which is focused on advancing the pace of biomedical research through the use of high-performance computing, artificial intelligence and quantum computing. The landmark partnership brings together Cleveland Clinic's world-renowned expertise in healthcare and life sciences, with IBM's next generation technologies to make scientific discovery faster.

Dengue fever cases surge

Rio de Janeiro 'declares' a dengue health emergency

RIO DE JANEIRO, Feb 6, (AP): Rio de Janeiro on Monday has declared a public health emergency because of an outbreak of mosquito-borne dengue fever, the city announced Monday, just days before Carnival celebrations kick off across Brazil.

The outbreak wasn't expected to derail Carnival, which officially starts Friday evening and runs until Feb. 14, but it has prompted a slew of special measures by the city in hopes of con-

Rio city hall announced the opening of 10 care centers, the creation of an emergency operations center and the allocation of hospital beds for dengue patients. Authorities also will use "smoke cars" in regions with the highest incidence of cases, diffusing an insecticide in the air.

Since the beginning of 2024, the municipality has registered more than 10,000 dengue cases. That is just under half of the total cases - 23,000 - recorded throughout all of 2023.

The announcement comes as tourists and revelers are pouring into Rio to take part in street parties and attend the samba schools' flamboyant parades.

Among Rio state's operational plans for Carnival, presented by Gov. Cláudio Castro on Monday, is the "Against Dengue Every Day" campaign. That will entail the distribution of repellents, stickers, bandanas and hats with warnings about the disease to audiences at the Sambadrome, where a 15-second notice about the fight against the infection also will be

Dengue is a viral infection transmitted to humans through the bite of infected mosquitoes and is more common in tropical climates. Frequent rains and high temperatures, mosquito eggs and the development of larvae, make the famously hot city of Rio susceptible to dengue out-

But the problem is national. The explosion of dengue cases across Brazil has caused at least four states - Acre, Minas Gerais and Goias, in addition to the Federal District - to declare public health emergencies.

On Monday, the Brazilian air force set up a 60-bed field hospital in the Federal District in Ceilandia that was due to begin treating patients.

"Our objective is to relieve emergency care units in the region, given that today the Federal District accounts for around 20% of dengue cases in the country," air force commander Lt. Brig. Marcelo Kanitz Damascene said From convenience to necessity

'Smoking leading cause of death'

Debate over vaping might derail the war on tobacco

NEW YORK, Feb 6, (AP): Cliff Douglas fought the tobacco industry for decades. As a lawyer, activist, and executive at nonprofit organizations, he sued cigarette makers, cultivated whistleblowers, and led the campaign to ban smoking on airlines.

Which is why allies in the antismoking movement were surprised when in October he became CEO of the Foundation for a Smoke-Free World, a nonprofit created and entirely funded by Philip Morris International, one of the world's largest tobacco companies.

Douglas, who previously worked for the American Cancer Society and the American Lung Association, sees his new job as the continuation of his antismoking work. He joined the foundation only after its board agreed to make a clean break from Philip Morris. He wants to bring together foundations, nonprofits, public health experts, elected officials, regulators, and academics in a renewed effort to curb death and disease caused by smoking.

It won't be easy. Because antismoking groups aren't just fighting the tobacco companies these days. They're fighting, sometimes bitterly, among

"I'm under no illusions about the challenges," Douglas says.

The stakes are high. Smoking remains the leading cause of preventable death in the United States, killing about 480,000 people a year, according to the Centers for Disease Control and Prevention. To succeed, Douglas will have to work through what he calls the "very fraught, polarized environment" that hampers the nonprofits, foundations, governments, and academics who work on tobacco control. They have fractured over tobacco harm reduction - the idea that people who cannot or will not quit smoking should be provided with alternatives, notably e-cigarettes, which deliver nicotine without burning

Cancer

Bloomberg Philanthropies and the supports - the Campaign for Tobacco-Free Kids and long-established groups like the American Cancer Society, the American Lung Association, and the American Heart Association - have campaigned relentlessly to limit access to e-cigarettes. The Campaign for Tobacco-Free Kids has focused on what it continues to describe as a "youth e-cigarette epidemic," even though vaping by teens has fallen by more than 60% since its peak in 2019. They argue that e-cigarettes will lead to a new generation addicted to nicotine,

even if they are not smoking.

Backed by \$300 million in Bloomberg philanthropic money, along with political donations from Michael Bloomberg, the anti-vaping groups have helped convince five states - California, Massachusetts, New Jersey, New York, and Rhode Island - to ban

the sale of flavored e-cigarettes. The nonprofit Truth Initiative goes further, saying it is "committed to making tobacco use and nicotine addiction a thing of the past," which would require removing all e-cigarettes from the market. Some cities, including San Francisco, have already done so.

Douglas and his allies in the harm reduction camp say that's been nothing short of disastrous. Bans on flavored ecigarettes, which now cover nearly 40% of the United States, have been associated with increased sales of conventional cigarettes, according to several academic studies and financial analysts.

'These bans disincentivize the far safer product and move people back to a product that's going to kill one in two of them," Douglas says.

The argument threatens to derail progress on one of the most successful public health campaigns in history. The percentage of Americans who smoke has dropped from 42% in 1964 when the first Surgeon General's report warned of the dangers of smoking - to less than 12%. But the arrival of e-cigarettes fractured opponents of smoking, especially after startup company JUUL marketed its vapes with high nicotine levels to young people, infuriating activists and regulators.

"I can't think of any other field of public health that has been so divided,' says Charles Gardner, a former program officer at the Foundation for a Smoke Free World and a global-health expert who previously worked at the Rockefeller and UBS Optimus foundations.

The mission of the Foundation for a Smoke Free World, which Philip Morris started in 2017, is to reduce deaths and diseases caused by smoking. It focuses largely, but not entirely, on reducedrisk nicotine products, a category that includes e-cigarettes, oral tobacco, and "heat not burn" products that warm up tobacco without burning it.

This aligns with the goals of the

company, which says that its future depends on replacing cigarettes with the smoke-free products that it sells. Philip Morris International promised that the foundation would be independent and said it would fund it with \$80 million a year for 12 years.

Disease

Anti-smoking groups called the foundation a public relations stunt, noting that the tobacco industry has a long history of creating front groups to push its agenda. Joanna Cohen, a professor of disease prevention at the Bloomberg School of Public Health at Johns Hopkins University, and Ellen MacKenzie, the school's dean, urged universities and nonprofits around the world to shun the foundation.

Douglas says the company has no influence over the foundation. All ties with Philip Morris were severed after accepting \$122.5 million, which he characterized as a severance payment.

But some anti-tobacco advocates remain skeptical. Yolonda Richardson, president of the Campaign for Tobacco Free Kids, and Deborah Arnott, chief executive of a British health charity called Action on Smoking and Health, told Reuters that the foundation was tainted by accepting tobacco money and could not be seen as independent.

Douglas would like his critics to reserve judgment. "I'm asking those who feel doubt at this early stage to not merely rely on what I say but to watch what we do," he says.

What, then, will the foundation do? Douglas intends to correct widespread and dangerous misunderstandings about the relative risks of conventional cigarettes, e-cigarettes, and nicotine. There are no safe tobacco products; all fall along what's called a continuum of risk. Nicotine pouches and gums are widely accepted because, unlike e-cigarettes, they have been approved as smokingcessation medicines by the FDA.

NEW YORK, Feb 6, (AP): Telemedicine's early days of handling mostly mild illnesses like sinus infections or pink eye are fading fast.

He's seeing this develop as co-CEO of Amwell, a Boston-based company that provides telemedicine software and technology for health systems and insurers. The company works with more than 55 health plans and health systems representing over 2,000 hospitals.

Schoenberg spoke recently with The Associated Press. The conversation has been edited for clarity and

Question: The COVID-19 pandemic pushed people into telemedicine. Did that lead to any permanent care delivery changes?

Answer: In a very profound way. We're just beginning to unravel how deep the impact is. When people started buying books on Amazon, they didn't notice that they were beginning to embrace online retail. We're going through the same thing with telehealth. People have opened the door for getting care through technology.

Q: What is some care patients seek in-person now that you expect will become largely virtual in the future?

A: Early generations of telehealth have really been about convenience ... how a patient can quickly get a simple prescription or solve a problem with a sick child. The revolution that's going on right now is where people are beginning to utilize these technologies to interact with their regular caretakers. These are regularly scheduled appointments. Patients with very difficult conditions like cancer and deep chronic conditions are becoming the frequent flyers of telehealth. That's going to continue to evolve.

Q: What's the biggest way your technology uses artificial intelli-

A: AI is not in any position to replace clinicians. However, these technologies can help check on a patient regularly. If you have a patient who was discharged from a hospital or has a chronic condition at home we can check every day to see how they're doing. If the patient is not doing well, (the technology) will

have the smarts to escalate that patient right back in front of (a nurse or doctor). You get a text message that begins the interaction. It switches over to a secure platform, essentially an application on your phone.

Q: You're co-CEO with your brother Ido. How do you handle disagreements?

A: Ido is focused on business making. My heart is about developing technologies that solve big problems in care. We respect the fact that each of us has his own special skills. When disagreements arise ... the right decision-maker is whoever really is proficient in that domain. We've been doing this for 30 years now.

Hosts make clean sweep of ODI series

Australia rout West Indies for 86

CANBERRA, Australia, Feb 6, (AP): Fast bowler Xavier Bartlett ran through the Wtest Indies lineup with another impressive total of 4-21 as Australia swept the one-day international series with another resounding eight-wicket win on Tuesday.

Australia won the first match by eight wickets in Melbourne and the second by 83 run s in Sydney.

Bartlett, who grabbed four wickets in his debut ODI at MCG in the series opener before the pace bowler was rested at Sydney, ripped through West Indies batting as the visitors were bowled out for 86 - its fifth-

Jake Fraser-McGurk made a rapid 41 off just 18 balls as Australia sped to 87-2 in just 6.5 overs with the opening batter smacking three sixes and five fours.

CRICKET

Josh Inglis was also in a hurry and made a brisk unbeaten 35 off 16 balls as fast bowler Matthew Forde gave away 40 runs off his two overs with Fraser-McGurk and Inglis both showing plenty of aggression.

"It's pretty insane. It's just great to get a taste of international cricket," Bartlett said. "To cap it off with a series win was great. There was still some pressure there (today) but I relaxed a little bit more and tried to enjoy it a little bit more and they came out alright again.'

Australia's 12th successive win came in its landmark 1,000th ODI as it became only the second country after India to play so many ODIs.

Bartlett was on target from the onset once Steven Smith won the toss and elected to bowl first. He had opener Kjorn Ottley leg before wicket in his second over but television replays suggested the batter had inside edged the ball.

Lance Morris, one of the two changes Australia made with Bartlett, had an injury scare when he walked off the ground with a side strain in his fifth over.

But Bartlett, who replaced rested Josh Hazlewood, bowled at an impeccable line and length as he conceded just 11 runs in his first fiveover spell.

Morris dented West Indies enough before walking off the field as he had Keacy Carty as his first international wicket when Marnus Labuschagne grabbed a stunning catch at backward point and then had Teddy Bishop clean bowled with a superb full delivery.

Alick Athanaze top-scored with 32 but when he fell to a rash sweep against Adam Zampa and was caught at deep backward square leg, West Indies lost the last six wickets for just 16 runs and the innings got folded in just 24.1 overs.

Smith recalled Bartlett who had the wicket of Romario Shepherd with his first ball of the second spell and then cleaned up West Indies innings by having the wicket of Alzarri

"Our batting let us down, it did for the entire series," West Indies captain Shai Hope said.

"We need to do some real soulsearching to understand what's needed in certain conditions ... The mindset has a lot to do with it, playing the situation. We just didn't bat as well as we could have. We must take the positives with us and try to negate the negatives. Hopefully we can come back stronger for the next series."

Paris Oly '24 organizers 'surprised' by reports of probe into president's pay

PARIS, Feb 6, (AP): The Paris Olympics organizing committee has expressed surprise that the salary of its president is reportedly being investigated by the French National Financial Prosecutor's Office.

According to French media, quoting the French agency AFP on Tuesday, the investigation into Tony Estanguet's pay was handed to Paris

police last week, less than six months before the Olympic Games open on July 26.

The financial prosecutor's office, contacted by The Associated Press, declined to comment. Paris organizers said they have not been contacted by investigators and could not confirm a probe is ongoing.

The Games organizing committee set Estanguet's pay in 2018 at the end of its first board meeting. It was

then agreed that the former three-time Olympic canoe champion would receive an annual pay of 270,000 euros (\$290,000) gross, with possible extra incentives based on performance criteria that would not exceed 20% of annual salary.

Organizers told reporters on Tuesday that Estanguet's pay - which has not risen since 2018 - is not capped by French law.

"We wish to remind people that the organising committee president's remuneration is subject to a strict framework," Games organizers said on Tuesday in a statement.

As president, Estanguet does not have an employee statute within the organizing committee and invoices his services on a monthly basis.

The organizers added Estanguet's income was decided independently, in line with the advice of a committee "made up of independent experts whose role is to ensure the appropriateness of our remuneration policy.


Halep's appeal begins on Wed

Foden grabs the spotlight

LONDON, Feb 6, (AP): Phil Foden grabbed the spotlight from fit-again **Manchester City superstars Erling Haaland and Kevin** De Bruyne by scoring a hat trick in a come-from-behind 3-1 win at Brentford that moved the champions two points behind Liverpool in a congested English Premier League summit.

City's opponents might be able to stop Haaland from scoring or close down the space for assist king De Bruyne, but there will always be a top-class player somewhere in the team to inflict the damage.

Foden was that player against Brentford as he led City's recovery after Neal Maupay's 21st-minute goal against the run of play for the hosts.

The England midfielder equalized in first-half stoppage time by pouncing on a poor defensive clearance, headed home the go-ahead goal in the 53rd, and completed his second career hat trick in the 70th with a piercing run and composed finish.

"It's probably the best form I've had in a City shirt for a long time, consistently. Long may that continue," Foden said. His goal tally improved to 14 in

all competitions. Foden has won it all with his boy-

Messi says he 'feels much better' and hopeful of playing

TOKYO, Feb 6, (AP): Look for Lionel Messi to play on Wednesday in Tokyo where Inter Miami meets Japanese club Vissel Kobe in a friendly.

And don't look for another public relations disaster as happened on Sunday when Argentina's World Cupwinning captain sat on the bench for an entire match against a selection of players from the Hong Kong league, angering thousands of fans who demanded refunds.

Teammate Luis Suarez - another big name at Miami - also remained on the

Messi showed up at a five-star Tokyo hotel on Tuesday for his second news conference since joining Miami last June 7, and his first since Aug. 17. He sat alone on a stool on stage, wore a pink warm-up jacket, and showed a bit of humility. He was surely under pressure from

local Japanese sponsors, including Vissel Kobe where his former Barcelona teammate Andres Iniesta became a Japanese crowd favorite before leaving last year.

'The truth is that I feel very good compared to a few days ago," Messi said in Spanish. "And depending on how that (training) goes. And if I'm honest, I still don't know if I will be able to or not. But I feel much better and I really want to be able to do it."

Messi trained later Tuesday in suburban Tokyo and looked fit, running drills and moving with ease at a practice facility run by the Japan Football Association. He did not speak afterward with reporters.

Messi tried to explain to Hong Kong fans that it was impossible for him to play with a groin injury. Some suggested he could have simply trotted around for a few minutes, which might have satisfied fans in a game that was largely meaningless except for its promotional value.

An English Premier League title race rich with narratives is shaping up to have a thrilling finish with the top three - Liverpool, Manchester City and Arsenal - separated by just two points with 15 matches remaining.

Arsenal's 3-1 win over Liverpool on Sunday, followed by City's victory at Brentford by the same score on Monday, has left what appears to be a three-way fight for English soccer's biggest prize. It has the potential to be the closest finish between three teams for a decade, when there was only four points between eventual champion City, Liverpool and Chelsea after the final round of the 2013-14 season.

Manchester City (2nd, 49 points

after 22 games) No team in the history of English soccer, dating back all the way to 1888, has won the top-flight for four straight years. That's what City is attempting to do as manager Pep Guardiola strives to break more new ground for an Abu Dhabi-owned club that won the Champions League for the first time last year and the Premier League in seven of the last 12 seasons. For some, any trophy won by City now comes with an asterisk, given the club is under heavy scrutiny while it faces about 80 alleged breaches of the league's financial rules and 30 more relating to its alleged failure to co-operate with an investigation. That case will likely be heard during next season. For the moment, City is focused on on-field matters and has won nine straight games in all competitions, five of them in the league. City has a fully fit squad now that Erling Haaland and Kevin De Bruyne are over their longterm injuries and also a game in hand, leading many to believe a successful title defense is likely, maybe even inevitable.

Arsenal's push for a first league title since 2004 is being fueled by a desire to make amends for last season, when the team imploded in the closing weeks after taking an eightpoint lead with nine games left. Arsenal manager Mikel Arteta seems to be pacing this season better, setting up his team to control games more and not go full throttle like in the first half of the last campaign. He has a deeper squad at his disposal this time round, too. His players will likely have learned lessons from last season, especially mentally in playing under pressure in every match and going toe-to-toe with an always fast-finishing City team. The dominant display against Liverpool on Sunday can only strengthen confidence, with Arsenal seemingly having gotten over a wobble either side of Christmas and winning its last three games while scoring 10 goals. Injuries to key players would likely affect Arsenal more than City or Liverpool, however, so Arteta will hope the likes of William Saliba, Declan Rice and Bukayo Saka can stay healthy for the run-in. Arsenal might have the toughest schedule, with away games at City, Tottenham and United.

CFF rejects Eto'o's resignation

ABIDJAN, Ivory Coast, Feb 6, (AP): Nigeria star Victor Osimhen did not travel with the rest of the squad on Monday for its Africa Cup of Nations semifinal with South Africa.

Osimhen missed the team's flight from Abidjan to Bouaké for Wednesday's game because of abdominal discomfort, the Super Eagles said on X,

formerly known as Twitter.

"Team medics confirmed that he has been placed under close watch with a member of the medical team staying behind in Abidjan with him. If cleared by tomorrow morning, he will join the rest of the squad before 5 p.m." the team said.

Osimhen has only scored one goal in the tournament, but the Napoli star's tireless performances have played a large role in Nigeria getting to the semifinals for a record-equaling 16th time in its 20 appearance.

committee met in Cameroon's capital, Yaoundé, on Monday to evaluate the national team's performance at the Africa Cup of Nations, and that the meeting started with Eto'o offering to step down while inviting the other members "to do likewise in good faith."

"At the end of discussions and subsequent deliberations, the members of the executive committee decided to maintain their current mandates and thus unanimously rejected the president's resignation thereby renewing their confidence in him to continue with the same spirit of reconstruction and development of Cameroon football at all levels as envisaged in his plan adopted by the elective general assembly of Dec. 11, 2021," the federation said in a statement, referring to the date Eto'o took over as president.

The federation made no mention in the statement of any other decisions taken or conclusions drawn. Cameroon coach Rigobert Song's future was uncertain after a disappointing Africa Cup campaign.

Cameroon, the five-time champion, needed a win in its final group game to be sure of progressing to the group stage, scored late to achieve it, and was then eliminated by Nigeria after a lackluster performance in the round of 16. Eto'o, who celebrated with the team

after its dramatic win over Gambia in their final group game, has been dogged by corruption allegations in the last year.

Last week, sports website The Athletic reported that it had seen WhatsApp messages, emails, letters and audio recordings that allegedly support a wide-range of accusations, including "match-fixing, abuse of power, physical threats, inciting violence and spreading false information in Cameroon." It said a file had been sent to FIFA's ethics committee and that it is also being investigated by the Confederation of African Football.

CAF was already investigating what it said were "serious" allegations from "several Cameroonian football stakeholders" against Eto'o. It noted that the former Barcelona and Inter Milan star was "presumed to be innocent until an appropriate judicial body concludes otherwise.

Questions were raised in Cameroon about Eto'o's ambassadorial role with a sports betting company. At least one club complained to the Cameroonian federation about the deal, which could violate the institution's codes.

Cameroonian soccer had plenty of problems in the past. Before Eto'o was elected president, the national league had been tainted by interference from the government, allegations of corruption and broken promises from soccer
