IS Kuwait destined to be discordant, not only in the Gulf Cooperation Council, but also in the world. Is it meant to be a repellant of joy, creativity, culture and arts?

Yesterday, the world celebrated New Year's Day. Joy spread among all people of all diversities, and the entertainment industry flourished.

Indeed, many countries, especially certain Gulf ones, have achieved greater financial success by recognizing from the start that entertainment is an industry, in stark contrast to the more restrictive approach seen in Kuwait.

Here, individuals appear confined, as if they are in a prison cell where smiling is prohibited because they violated the "negative phenomena" law, leading to a surge in drug abuse among other consequences.

People were happy to usher in the new year because it is a moment of joy in a world that is dominated by wars and crises. However, the scenario in Kuwait was gloomy because of the presence of a parliamentary force that opposes any manifestation of joy and happiness.

This force has been given full reign by weak governments to determine what is permissible and what is forbidden.

There are the many prohibitions that the Kuwaiti people have been enduring for nearly two decades to this day, to the extent that restaurants are prevented from playing music at the end of

the year to celebrate the New Year.

During the time of holidays, more than half a million people leave Kuwait, and neighboring countries benefit from them. For example, in the Emirates, hotels are crowded with Kuwaitis during the current holidays. Same is the case in Saudi Arabia, Bahrain, and the Sultanate of Oman. On the other hand, it is

forbidden for any visitor to come to us.

This is due to the fact that the deep state and the MPs have erected high walls to prevent anyone from entering, except with special

CAIRO: The Egyptian cabinet on Sunday dismissed recent reports about the alleged detection of a case of a new swine flu (H1N1) virus variant in the country.

The Ministry of Health's preventive medicine sector has not monitored any new variant of swine flu, urging mass media and social media users to obtain relevant information from official sources, the cabinet's media center said in a press release. (KUNA)

BEIRUT: The U.S. military said Sunday that its forces opened fire on Houthi rebels after they attacked a cargo ship in the Red Sea, killing several of them in an escalation of the maritime conflict linked to the war in Gaza. "We're going to act in a self-defense going forward," a White House official said

House official said.

In a series of statements, the U.S. Central Command said the crew of the USS Gravely destroyer first shot down two antiship ballistic missiles fired at the **Singapore**-flagged Maersk Hangzhou late Saturday, after the vessel reported getting hit by a missile earlier that evening as it sailed through the Southern Red

BEIRUT: U.N. Secretary-General **Antonio Guterres** has closed an international tribunal that was created to investigate the 2005 assassination of former Lebanese Prime Minister **Rafik Hariri**, the U.N. chief's spokesperson said Sunday.

Over the years, the Special Tribunal for **Lebanon** held in absentia proceedings and found three members of the militant Hezbollah group guilty in connection with Hariri's death in a massive Feb. 14, 2005 truck bombing. (AP)

BAGHDAD: Three overnight airstrikes on eastern **Syria** near a strategic border crossing with **Iraq** killed six **Iran**-backed militants Saturday, two members of Iraqi militia groups told The Associated Press.

The strikes on the border region of **Boukamal** came hours after an umbrella group of Iranbacked Iraqi militants known as the Islamic Resistance claimed an attack on a U.S. military base in northern Iraq's city of **Irbil**. (AP)

TEHRAN: In response to the joint statement of the **United States** and three European countries regarding Iran's program, Spokesman of the Iranian Ministry of Foreign Affairs **Nasser Kanani** reiterated that **Iran**'s nuclear program has always been and will be peaceful.

"It is very ridiculous that the countries that are responsible for the current situation regarding Iran's nuclear program, with the heart of reality, seek to change the culprit and the victim," he said in a press release on Friday. (KUNA)

TEHRAN: Iran executed on Friday four people and sentenced several others to prison for having alleged links with Israel's Mossad security service, local

media reported.

Mizan, the news website affiliated with the country's judiciary, said three men and one woman were executed Friday morning.

Snapshots of joy as New Year welcomed with optimism

World's ongoing conflicts cast shadow on 2024

NEW YORK, Jan 1, (AP): New Year's Day arrived to cheers from thousands in New York's Times Square where a sparkling crystal ball descended to start 2024 with hope for some, even as the world's ongoing conflicts subdued celebrations and raised security concerns across the globe.

"It's beautiful," Corin Christian of Charlotte, North Carolina, said of the scene seconds past midnight as Frank Sinatra's "New York, New York" blared from speakers in the square and many in the crowd held cell phones in the air, trying to capture the spectacle.

"It's going very well so far," said Jacob Eriksson of Salt Lake City, Utah, with the earliest assessment of the New Year.

The march of midnight from time zone to time zone brought 2024 first to places like Australia, where more than 1 million people watched a pyrotechnic display centered around Sydney's famous Opera House and harbor bridge - a number of spectators equivalent to 1 in 5 of the city's residents. It would be another 16 hours before New York finished 2023.

There were snapshots of joy from country to country as the new year was welcomed with optimism that its days will bring more joy than sorrow.

Before midnight arrived in Times Square, December Lee, 26, and Shadayah Lawrence, 25, of Columbus, Ohio, said their New York visit highlighted four years of traveling the globe.

"It is a good way to bring in the new year," Lee said.

Also in Times Square, Tyrell Jacobs, 27, and Sarah Crayton, 26, arrived from New Orleans 15 hours before midnight and got engaged in streets packed with tens of thousands of people counting first the hours and then the minutes until midnight.

Free people around the world demand stopping the Israeli aggression on the Gaza Strip, he said, affirming support to all Palestinians' actions overseas in defending their issue and ensuring their right to return.

Additionally, Al-Azmi emphasized that Kuwait has been among the first Arab and Islamic countries that hastily provided support to Palestine's issue via offering humanitarian and relief aid to the Gaza Strip.

Collision results in death

KUWAIT CITY, Jan 1: Dr. Ahmed Al Shatti, Director of the Medical Emergency Department at the Ministry of Health, reported the first fatality in 2024 as a result of a collision with an all-terrain vehicle (buggy).

He explained that the department received 159 calls within the first 12 hours of 2024. These included four instances of fighting, two suicide attempts involving jumping from high buildings, 2 cases of poisoning due to drug overdose, and two incidents of burns. The Control Room of the Medical Emergency Department referred all these cases to various hospitals, of which 11 cases were referred to Farwaniya Hospital, ten to Jahra Hospital, nine each to Adan Hospital and Mubarak Al-Kabeer Hospital, four each to Jaber Hospital and Al-Sabah Hospital, eight cases to Amiri Hospital, in addition to other hospitals and clinics.

Dr. Al-Shatti affirmed that accidents are still occurring in the desert camping areas due to lack of respect for the relevant instructions and regulations, indicating that the first few hours of the new year witnessed clear misuse of buggies, electricity generators, and other equipment.

He emphasized that the department aims to promote a safety culture by issuing warnings and emphasizing the consequences of neglecting them.

Dr. Al-Shatti reiterated the importance of avoiding high-pressure areas, refraining from driving buggies on driveways and highways, and ensuring that kitchens and electricity generators are away from the areas intended for gathering and sitting.

KNPC to sell assets

MPs propose student union, certificate bill

KUWAIT CITY, Jan 1: MPs Abdulkareem Al- Kandari, Bader Nashmi Al-Anzi, Abdulaziz Al-Saqaabi, Muhannad Al-Sayer and Mehalhal Al-Mudhaf have submitted a bill consisting of 43 Articles on organizing the election and formation of student unions in Kuwait and abroad.

The MPs pointed out that the bill is a necessary step due to the growing number of students and student unions, indicating that the number of such unions has reached seven so far. He emphasized the importance of student unions, especially during the Iraqi invasion of Kuwait.

According to the bill, the Minister of Higher Education will lay down the executive regulations for the election of student unions, and the official declaration of relevant societies and committees. The Minister of Higher Education is authorized to dissolve the students union if it commits major violations.

The first students union was that of Kuwaitis who studied in Cairo, Egypt in 1964. In 1969, the first students union in Kuwait was formed.

In addition, MPs Bader Nashmi Al-Anzi, Dawoud Maarafi, Fares Al-Otaibi, Shuaib Shaaban and Bader Sayyar submitted a bill on banning public institutions; including ministries, their subsidiaries and independent-budget institutions, from hiring individuals who hold unaccredited academic certificates.

11 new martyrs registered; total now reaches 1,329

'Kuwaiti, non-Kuwaiti martyrs' kin to get govt, private medical care'

KUWAIT CITY, Jan 1: Assistant Undersecretary at the Amiri Diwan and Director General of the Martyrs Office Salah Al-Oufan said 11 new martyrs were registered in the office as per the recommendation of the Nomination

Committee in the Board of Trustees and with the approval of the board chairman; raising the total number of registered martyrs to 1,329, reports Al-Anba daily

Al-Ofan made the statement to the daily on the sidelines of his participation in the workshop that the Office organized

Salah Al-Oufan for the widows and mothers of martyrs, which included a symposium on psychological pressures presented by Dr Ayoub Al-Ayoub.

Regarding the symposium, Al-Ofan said that its aim is to hone the talents of widows and mothers to help them deal with psychological pressures in the family and in their social lives.

As for the services, he talked about the amendments in the health, educational and housing regulations for the benefit of the families of the martyrs as the previous regulations were laid down 30 years ago; hence, the need to amend them in accordance with the developments concerning families and the ages of their

He explained that according to the amendments in terms of housing, all of a martyr's heirs shall enjoy a share in his home, even if he has a non-Kuwaiti widow and this is in coordination with the Public Authority for Housing

As for the health aspect, he pointed out that the amendment will allow Kuwaitis and non-Kuwaitis among the families of martyrs to undergo treatment in government and private hospitals; including the families of 1,329 martyrs. He said the officials of the Office will soon hold a meeting with the health minister to work on canceling fees in hospitals and dispensaries for the families of martyrs who hold non-Kuwaiti nationality — 14 nationalities.

As for the educational regulations, he point-

ed out that the amendments include raising the age allowed to complete university studies with a bachelor's degree, in order to allow the largest possible number of children of martyrs to complete their education in cooperation with the concerned authorities in the Ministry of

He announced that after the end of mourning and in celebration of the national holidays, in cooperation with the Public Authority for Applied Education, the College of Basic Education, and the Department of Art Education; the Art Education Department will establish the martyrs mural in the martyrs garden, designed by the college's female students. He added a similar mural will be established in front of the Office in memory of the martyrs.

On the other hand, Director of the Family Guidance and Care Department in the Martyrs Office, Muhammad Al-Mutairi stressed this is the first course for the martyrs' widows. "We witnessed a wonderful interaction between the participants, as they were keen on benefiting from the symposium in terms of dealing with psychological pressures," he concluded.

Muted festivities in Amir mourning

KUWAIT CITY, Jan 1: Major General Abdullah Al-Rujaib, the Assistant Undersecretary for Public Security, Operations, and Traffic Affairs at the Ministry of Interior, conducted a comprehensive tour of security checkpoints from Mubarakiya, Jaber Causeway, and Subbiya in the northern areas to the southern areas in Khairan chalets.

This visit by Major General Abdullah Al-Rujaib was in line with New Year celebrations and was carried out based on directives issued by Deputy Prime Minister and Minister of Interior Sheikh Talal Khalid Al-Ahmad Al Sabah, and Acting Undersecretary of the Ministry of Interior Sheikh

Salim Al-Nawaf. Security vehicles patrolled different parts of Kuwait where the usual celebrations witnessed in previous years were not held in compliance with individuals observing mourning due to the passing of the late Amir Sheikh Nawaf Al Ahmed Al Sabah.

Meanwhile, the Jahra Security Commander Brigadier Saleh Agla Al-Azmi explained that the extensive deployment of security campaigns, particularly in Subbiya Desert and camping sites, is aimed at bolstering security and addressing any nega-

tive phenomena or violations. Simultaneously, special security forces and women police were stationed at the security checkpoint in Jaber Causeway, under the command of Brigadier Muhammad Taher Al-Ebrahim, alongside the traffic awareness officer Major Abdullah Bu Hassan.

In another development, Foreign Affairs

Minister Sheikh Salem Al-Abdullah offered his deep condolences to the families of the deceased Kuwaiti citizen and his Saudi companion -- Faisal Al-Mutairi and Anwar Al-Dhufairi respectively -- whose bodies were transported from Iraq and buried in Kuwait last Thursday, reports Al-Qabas daily.

The minister thanked the Iraqi government for its quick response in terms of revealing the scene of the accident, finding the bodies of the two deceased, and facilitating their transfer to Kuwait.

He added: "On Tuesday, when the two bodies were found, we officially requested the Iraqi government through our embassy in Baghdad to conduct an extensive investigation into the incident. Last Wednesday, the Iraqi Prime Minister issued a directive to conduct an investigation into the incident and ordered the formation of a committee to follow up this investigation. The information we have today is that the committee visited the scene of the accident. We are waiting for the official report on this accident. Let us review the report first and then see the results.'

Asked about the presence of nine cars in the entire trip, Sheikh Salem disclosed: "We have not reached them yet. We are currently focusing on the two victims -- Faisal Al-Mutairi and Anwar Al-Dhufairi."

He asked all media outlets to be patient and refrain from publishing false news. "I hope everyone will adhere to this directive. I urge everyone not to circulate information that is not confirmed or incorrect or not issued by official sources, because this will lead to more confusion, as well as incite people's anger and sadness. We are all affected as something extremely sad hap-

Hoarding in ports, stores denied

'No onion crisis in local market'

KUWAIT CITY, Jan 1: The Ministry of Commerce and Industry has confirmed the availability of imported vegetables and onions in the local market, while vehemently denying the alleged hoarding of vegetables and other goods in Kuwaiti ports or warehouses, reports Al-Anba daily quoting

Sources quoted the ministry as saying that there are multiple sources of imported vegetables and onions.

In a related development, Chairman of Kuwait Society for Consumer Protection Khaled Al-Subaie affirmed that Turkish, Iranian and Jordanian onions are being sold at prices ranging from 240 to 250 fils per kilo in Shubrat Al-Khadar Vegetable Market.

He stressed there is no onion crisis in the local market; indicating that he contacted some onion traders or importers in Kuwait and they assured him that Yemeni, Indian and Egyptian onions will be available in the next few days.

3 shops without license: Kuwait Municipality teams have intensified their inspection efforts in compliance with the instruction of Municipality Director General Eng Saud Al-Dabbous who stressed the need to strictly enforce the Municipal Law, bylaws and regulations, reports Al-Anba daily.

In a press statement, the Public Relations Department at the Municipality confirmed that the inspection teams from the branch in Farwaniya Governorate carried out an inspection tour in Farwaniya and Khaitan to ensure that the markets and stores are following the Municipality's rules and regula-

Meanwhile, Deputy Director General of the Control and Inspection Sector and Director of the Audit and Follow-up Department at the Municipal Services Sector in the Farwaniya Governorate branch Dr Nasser Al-Rashidi disclosed that the inspection campaign resulted in the closure of three shops found to have started their operations without the approval of the Municipality.

KUWAIT CITY, Jan 1: Doctors specializing in preventive health reassured that the emergence of the new coronavirus variant - 'J \bar{N} .1' - is normal and it does not pose any danger as the symptoms are mild, the hospitalization rate is low and those infected usually recover quickly, reports Al-Qabas

These doctors told the daily that the medical teams in the country have vast experience and are efficiently dealing with any health development. They pointed out that the whole world has obtained immunity and the vaccines in Kuwait are good. They advised those with serious diseases to take precautionary health measures, such as reducing contact if symptoms similar to seasonal influenza and others appear. Preventive health physician and general practitioner at Ku-

wait Integrated Petroleum Industries Company (KIPIC) Dr Khaled Al-Hajri affirmed that "the health situation in Kuwait is under control and does not cause concern, according to the latest reports issued by the Ministry of Health. He reiterated that the virus, despite its mutations, remains

under the supervision of specialized medical teams, indicating that preliminary studies have shown the new variant is not as dangerous as some expect. He advised everyone to take the necessary precautions, especially among groups most at risk such as the elderly and

people with immune diseases, calling on them in particular to continue wearing masks in gathering places and closed areas as a preventive measure. While he underscored the importance of getting winter vaccinations, which are the primary line of defense against the virus and its variants; he confirmed the continuous monitoring of the health situation in the country. He said the Health Min-

istry is working side by side international bodies to ensure an effective response to any development. Another public health doctor — Ahmad Al-Otaibi — said the new variant is derived from Omicron that has been spreading for some time now. He added the symptoms of most cases

are mild and the rate of hospitalization is very low. He told the daily that vaccination works efficiently and the only thing required is to monitor the symptoms if they develop into difficulty breathing. He also emphasized the importance

of taking the influenza vaccine as a preventive measure. He disclosed that the United States Centers for Disease Control and Prevention issued a statement, indicating that "JN.1" is the reason behind the increasing number of infections in the United States and that the variant is either more contagious or better at evading the immune systems in our bodies than other

He then pointed out that there is no evidence JN.1 causes more serious symptoms than other variants, asserting there are no symptoms specific to JN.1. He said the initial symptoms are the same as the other newer variants, such as sore or itchy throat, fatigue, headache and cough.

Co-ops shelves empty of eggs; prices spiral

KUWAIT CITY, Jan 1: Kuwait Society for Consumer Protection Chairman Khaled Al-Subaie said the price of table eggs is rising, because some merchants sell only a small quantity of their products to cooperative societies and large quantities are sold to parallel markets, reports Al-Anba daily.

Al-Subaie informed the daily that the Ministry of Commerce and Industry set the price of a tray of eggs in cooperative societies at KD1.210, affirming the prices in cooperatives are closely monitored. He revealed that in other sales outlets like parallel markets, the price of a tray of eggs ranges from KD1.400 to KD1.5 and more.

He said the cooperatives must submit complaints to the concerned authorities against companies that reduce the quantities of eggs they supply to the cooperative societies. He added he was surprised when the concerned authori-

ties decided to prohibit the export of eggs within a certain period, except the licensed national farms and chicken and egg production companies. He asserted such decisions are contradictory, because the authorities prohibited the export of eggs while allowing certain companies to do so.

32 citations issued: The inspection team at the Hawally Governorate Inspection Department in the Public Authority for Food and Nutrition (PAFN) recently issued 32 citations against several food establishments in the governorate, reports Al-Anba daily.

Inspector Muhammad Al-Kandari told the daily that the violations included selling food unfit for human consumption as the natural properties changed like the color, shape and smell. He also confirmed the destruction of food items weighing 240 kilograms; indicating other violations were non-compliance with public sanitation rules and regulations as a large number of live insects were found in the food establishments.

KFF cautions camp-goers

'Take lit coal out of tent, turn off generators to avoid fire'

KUWAIT CITY, Jan 1, (KUNA): Kuwait Fire Force called on desert-goers to take safety measures during the camping season.

In a statement to KUNA on Friday, the force's head of public relations and media Brigadier Mohammad Al-Ghareeb said that it is neccessary to take lit coal out of the tent and turn off generators before sleeping, to avoid fire or suffocation by carbon monoxide.

He also called on people to avoid any cracks or holes in the ground, since they can be sheltering insects, rodents and poisonous reptiles. Moreover, he underlined the need to keep the camping site clean and without dry grass that could easily catch fire.

Al-Ghareeb said that desert-goers must refrain from using exposed wires to avoid electric shocks, and should also keep gas cylinders out of the kitchen tent.

Meanwhile, he called for setting tents opposite of the wind direction to avoid flying waste, choosing a higher floor for the camp site to avoid landslides during rain and leave a space of no less than six meters between each tent to prevent fire from spreading, should it break out.

The Brigadier added that in case of any emergency, people should immediately call the emergency hotline 112.

Meanwhile, the Public Relations Department at Kuwait Municipality has announced that the Camps Committee, headed by Faisal Al-Otaibi, approved a recommendation to cancel the camping site's license and impose fines once violations are uncovered, reports Al-Anba daily.

According to the department, the committee uncovered a number of violations

against the terms and conditions for establishing camping sites; such as unlicensed motorcycles and all-terrain vehicles (ATVs)

The department affirmed that the Municipality is keen on curbing the spread of negative phenomena or anything that contravenes Islamic teachings and the conservative customs and traditions of the country. It then warned that all the necessary legal measures will be taken against anyone proven to have committed violations, including the cancellation of the camp license.

'MENA suffering from water dearth'

'Hike investment in water projects'

KUWAIT CITY, Jan 1: MEED magazine reported that the increasing scarcity of water in most parts of the Middle East and North Africa region reinforces trends to increase investments in the field of water and its sources in order to enhance the capacity and efficiency of this sector, reports Al-Anba daily.

The magazine pointed out that water scarcity may constitute an obstacle to spending on major projects aimed at improving economic performance in the region instead of increasing water desalination and treatment capacity to meet the growing demand in a more sustainable manner, as well as water transportation pipeline projects to reduce water loss and improve sanitation.

Other projects, such as reservoirs and district cooling, are also emerging as national and municipal governments work to improve water security and reduce the carbon footprint of buildings.

Contracts worth about \$22 billion were awarded between January and November 2023, about double the value of the previous year's awards, according to Med Projects data that tracks regional projects. Saudi Arabia accounted for 43% of the total contracts awarded, followed by the United Arab Emirates with 23%.

In terms of non-awarded contracts in the field of water transportation projects, the UAE and the Kingdom of Saudi Arabia ranked first and second with \$10.75 billion and \$9.986 billion, respectively, and Oman and Oatar ranked third and fourth with proiects worth \$1.823 billion and \$1.35 billion respectively. Kuwait came in fifth place with \$660 million, and finally Bahrain with projects worth \$240 million.

Water transmission and pipeline projects represent about 35% of the planned and non-awarded projects, followed by water desalination and wastewater treatment plant projects, each with a share of about 25%.

575 'aliens' held

Fake cash in market

KUWAIT CITY, Jan 1: The Criminal Investigation and Licensing Department, under the General Department of Criminal Investigation, successfully apprehended two individuals of African descent on allegations of orchestrating fraudulent schemes involving the creation and distribution of counterfeit banknotes, reports Al-Rai daily.

According to the Ministry of Interior, during the arrest, law enforcement agencies discovered in the suspects' possession an electric apparatus, colored papers resembling genuine banknotes in size, forged currency, and synthetic materials used to deceive unsuspecting victims into parting with their money.

575 illegals nabbed: Inspection campaigns by the General Administration of Residency Affairs Investigations, represented by the Research and Investigation Department, the Control and Coordination Department, the Violators Follow-up Department, and the Financial and Administrative Services Department, resulted in the arrest of 575 people of various nationalities - violators of Residency and Labor Law.


Is Israel mortal or permanent entity?

have a different nature from the rest of humanity.

One uprising after another; we also put them in prisons and said, "We will raise them inside them." Years later, after we thought they had learned their lesson, they returned to us with another armed uprising that burned a lot.

So we demolished their homes and besieged them for many years, and suddenly they extracted missiles from almost nothing to attack us with, despite the siege and destruction. So we took them. We build walls and put up barbed wire.

And lo and behold, they came to us from underground and through tunnels, until they intensified the killing of our youth. We fought them with our minds, and then they took control of the Israeli satellite, and brought terror to every home in Israel, by broadcasting threats and intimidation, as happened when their youth were able to seize control of the Israeli Channel 2!

In summary, it seems that we are facing the most difficult people in history, and there is no solution for them but to recognize their rights and end the occupation.

In 1970, the Israeli writer Shlomo Sand, a professor of history at Tel Aviv University, published a book entitled "The Invention of the Jewish People." It was very popular and remained on the list of best books for weeks, and was translated into many languages.

Documents

Sand says that there are no historical documents proving the expulsion of the Jewish people by the Romans at any time, as it was impossible, at least logistically, at that time to deport hundreds of thousands from one place to another, and that modern Jews do not descend from the origins of the ancient Jews who lived in the land of ancient Israel, there is no such thing as a Jewish "race." The Jews do not belong to a single source, and they were not deported out of the country by the Romans during the 12th century.

Most of them continued to live there until the advent of Islam in the seventh and eighth centuries, when many of them converted to Islam, which means that many of the ancestors of today's Palestinians were Jews.

Sand believes that the myth of the Jewish "diaspora" began with the first eras of Christianity, to attract Jews to the new religion, and a group of Jewish intellectuals appeared in Germany who were influenced by the ardent enthusiasm for German nationalism, and they took upon themselves the task of "inventing" Jewish nationalism and the idea of promising the return of the Jewish nation to the land.

The promised one is an idea completely foreign to "Judaism," and it only appeared with the birth of "Zionism," as the Jews had previously dealt with the Holy Lands as places to be glorified, and it was not necessary to live within them -- just as Muslims deal with their holy places!

Sand, a professor of history at Tel Aviv University, reviews valuable information about the emergence of the idea of Judaism and the national homeland, reviewing the entirety of Jewish history, criticizing the traditional Jewish historical discourse in its various stages and trends.

He wonders: How and why was the Torah transformed from a book of religious laws into a history book that narrates the emergence of the "Jewish nation," knowing that no one knows with accuracy when the Torah was written?! Who wrote it?! What path did the Jews expelled from Egypt take?!

Sand concluded that the Jews had always formed important religious groups that had a foothold in various regions of the world, and were not a people of one origin.

Shabit's article and Sand's book, and dozens of other similar articles and books, which were published before Hamas's latest attack on Israel, on October 7, have become nothing compared to the flood of articles, interviews, speeches and demonstrations in free capitals, and the accompanying major change in the position on the Palestinian issue, which is a momentum that could not have been achieved without the sudden Hamas attack, which was denounced by the world, but which awakened the global conscience towards the cause of a people who had suffered for more than a century from the oppression of the English occupier and subsequently from the occupation and oppression of the Israeli occupier, such that it became criminal to think about the continuation of the situation as it was before that date.

In order to be as energetic and just as the Jews who stood with our causes, we must immediately respect their positions and appreciate them as they deserve, and reduce the trait of ingratitude in our societies, for we are not... the best of nations!

Copper cable thieves arrested

As part of an extensive security initiative involving rigorous search and investigation operations into copper cable thefts across various regions of the country, both the Criminal Security and Public Security sectors of the Ministry of Interior have taken into custody four Asians in two separate incidents, reports Al-Anba daily

The accused parties and the confiscated items have been handed over to the concerned authorities for the necessary legal actions to be taken against them.

Fluctuation seen in house rents in Q3, '23, says KFH

'Capital accommodation expensive'

KUWAIT CITY, Jan 1: The Kuwait Finance House "KFH" report said that the rental values among residential areas in Kuwait vary according to distinct factors and different areas, indicating that the third quarter of 2023 witnessed an uneven change in most areas on an annual basis, and in light of the limited decline in private housing prices, a decrease is observed. A slight increase in the rental value of some locations in this category of properties, reports Al-Anba daily.

The report indicated stability in prices elsewhere in private housing areas, and that waiting for the allocation of housing requests encouraged the tendency of a large segment of citizens to rent private housing, which led to an increase in its supply, in light of the demand for areas close to workplaces and shopping, which stimulated tenants' demand for renting private housing.

renting private housing.

The average rental value for the second floor, 3 rooms and a living room, with an area of 135 square meters, at the governorate level, in a private housing building with an area of 400 square meters, stabilized at 482 dinars at the end of the third quarter, without change from the second quarter, while it decreased by 0.4% on an annual basis.

The average in the Capital Governorate reached 570 dinars, a decrease of about 0.8% at the end of the third quarter, after recording an increase last year, reaching 11% in the third quarter of 2022, and in the Ha-

walli Governorate it reached 516 dinars. . , an annual decrease of 0.7%.

In the Farwaniya Governorate, there was no quarterly change, recording 397 dinars, while it is higher by 1.9% on an annual basis, and in Mubarak Al-Kabeer Governorate, the average rental value is 437 dinars for the same area, with an annual increase of 0.8%. The average rental value in Al Ahmadi is 375 dinars, unchanged on a quarterly or annual basis.

The rental value for the entire ground floor of a private residential property reached an area of 400 square meters. The average rental value for this category at the governorate level was 890 dinars, with a slight annual increase of 0.1% at the end of the third quarter of 2023.

In the Capital Governorate, it reached around 1,045 dinars, without change on an annual basis. While the average rental value in the governorate reaches 953 dinars, an increase of 1.4% on an annual basis, and in the Farwaniya governorate it is 736 dinars, an annual decrease of 2.3%.

The average rental value for the first full floor or the second floor in private housing properties with an area of 400 square meters at the governorate level was 790 dinars, without a quarterly change, while it is considered a slight decrease of 0.6% on an annual basis.

In the Capital Governorate, the rental value was around 945 dinars, down 1% on an annual basis.

Rents were recorded in the highest areas, as in Adailiya, at 1,100 dinars and in Al Rawdah at 1,000 dinars, while rents in the lowest areas of the governorate, as in Granada, reached 800 dinars, and in Sulaibikhat, the average rental value reached 600 dinars, with no annual change, and in Hawalli Governorate, the average rental value reached 853 dinars, an annual decrease of 0.6%.

Bootleggers nabbed in Khaitan

Drugs worth over KD 0.5m seized

KUWAIT CITY, Jan 1: "In a relentless pursuit of enforcing the law and safeguarding public safety, the Directorate-General for Drug Control has made a significant breakthrough by meticulously following the trail of drugs and the illicit substances traffickers after obtaining crucial information about a narcotics smuggling operation through one of the country's border crossings, reports Al-Anba daily.

By ramping up surveillance, gathering essential intelligence, and strategically deploying forces to the border area, the DGDC personnel have arrested two individuals for attempting smuggle into the country approximately 35 kilograms of shabu and around 300,000 Captagon pills cleverly concealed in various compartments of the vehicle.

The seized contraband -- with a street value of more than half a million Kuwaiti dinars -- and the suspects have been referred to the concerned authority. The Ministry urges the public to collaborate with security forces, encouraging them to report any suspicious activities through the emergency phone (112) and DGDC hotline 1884141."

Bootleggers nabbed: Personnel from the Directorate-General of the General Department for Drugs Control have arrested three people for manufacturing local booze, reports Al-Anba daily.

The daily added with permission from the Public Prosecutor CID men raided the apartment in Khaitan which the suspects had turned into liquor den and seized 100 barrels containing raw materials for manufacturing liquor and 24 bottles of local booze ready for sale,

The seized contraband and the bootleggers have been referred to the competent authorities.

Farmhouse robbed: A Kuwaiti on behalf of his father reported a break-in at his father's farm. The suspect committed the crime by breaking the main door of the farm, reports Al-Anba daily.

Stolen items included 2 air conditioning units, 2 power generators, and 3 air cylinders, with a total value of approximately 16,750 dinars.

'Major parties failed to stop crimes of war and genocide'

"IF we read through the pages of our long history, we find that wars have always raged between two sects, Muslims and Christians, and armies may have met and battles have taken place, and fellow Muslims and Christians traversed, visited, and engaged in trade without objection from any quarters," columnist **Dr Abdul Rahman Al-Jeeran** wrote for **Al-Rai** daily.

both the "winter and summer journey," Karak Fort lies within a day and night's travel from Jerusalem, possessing the expanse of Palestinian land with a commanding view. Saladin initiated a prolonged and challenging siege.

"However, amidst these hostilities, caravans continued their journeys from Egypt to Damascus, from Damascus to Acre, and vice versa.

"Trade routes crisscrossed from Hijaz to the Levant and Yemen, unhindered by any disruptions. Christian and Jewish merchants traversed their paths without hindrance, adhering to the agreed-upon taxes. Christians paid taxes in Muslim lands, reciprocated by Christian merchants in Muslim territories -- marked by moderation in all circumstances.

"Amidst the tumult of war, the people were resilient and sought their livelihood like a "beehive." This reflects the life of the common people in Islam, emphasizing securing a decent living over concerns about ruling dynamics among Muslim leaders. Strife between Muslim princes and kings did not affect subjects or merchants, as their paramount concern, in all circumstances, remained security.

"This peaceful coexistence and understanding of the role of the state are attributed, first and foremost, to gratitude towards God.

"Furthermore, it reflects an awareness of the state's role in fostering harmonious relations between governments, individuals, and groups. In the Arab world, unlike Crusader Europe, internal disputes over royal succession or inheritances rarely led to inter-country conflicts.

"Arab Islamic civilization, rooted in a robust understanding of the state, precedes Crusader Europe in international education. Al-Shaybani's "Al-Sir Al-Kabir," written in 189 AH, stands as a significant jurisprudential work, guiding global transactions to maintain international stability.

"This contrasts with the contempo-

"This contrasts with the contemporary failures of major countries and international institutions in preventing crimes and wars, as witnessed in Bosnia and Herzegovina, against the Hutu tribes in Africa, Myanmar, and the ongoing events in Gaza."

Also:

"When the scientists of the French campaign led by Napoleon Bonaparte against Egypt in 1798 unearthed the Rosetta Stone, containing inscriptions in hieroglyphics, Greek, and Demotic texts, it was more than just a stone with information," columnist **Dr. Abdulaziz Yousef Al-Ahmad**, wrote for **Al-Anba** daily.

"The ancients used stones to record significant events, and the Rosetta Stone is a prime example. Before this, early humans turned to animal skins and bones for recording, until the Pharaohs introduced papyrus, a plant abundant along the Nile River. Despite its continued manufacture

in Egypt with Pharaonic drawings for tourists, papyrus has a rough texture.

"Known as 'Papyrus' in Latin, derived from the Pharaonic name, it eventually evolved into the term 'Paper', maintaining its Pharaonic origin. Cai Lun, a Chinese inventor, created paper from bamboo pulp, silk tissue waste, and fishing nets, unknowingly sparking a revolution. In 751, during the siege of Samarkand, Chinese paper was discovered on captured soldiers. The Arab leader learned the craft from the prisoners, marking a pivotal moment in human history.

"Islamic scholars, aiming to spread the Holy Qur'an, adapted Chinese paper-making techniques. They substituted cotton for silk, utilizing affordable materials from their surroundings.

"The first paper factory emerged in Baghdad in 791 under Harun al-Rashid's rule. Jabir bin Hayyan, a renowned chemist, enhanced the industry, inventing fireresistant paper. Paper-making thrived, giving rise to paper-makers and ink specialists known as 'squirrels'.

"The paper industry expanded across the Islamic world. Fez, Morocco, housed around four hundred paper factories, exporting to both the Islamic world and Europe.

"Europe's first paper factory in Friano, Italy, was established in 1276, centuries after Muslim advancements. Today, we recognize that paper, preserving the world's memory, originated in China, developed by Arab and Muslim scholars. Despite technological advancements, the value of paper as a life memory persists."

"Reforms are necessary for the advancement of Kuwait! The real reform process, which follows painful stages of financial, administrative and political corruption requires the following: first a thoughtful vision, second, national competencies that are creative and capable of implementation, and third, firm decisions -- not flattering, preferential or lax," columnist Abdulrahman Al-Mesfer wrote for Al-Seyassah daily.

"It is very natural for reform and development movements to encounter obstacles of confusion, skepticism and obstinacy, because the forces of corruption that benefit from the deteriorating conditions will fight to keep the bad conditions in place, as it is their means of survival and strength.

"The real approaches to tangible reform begin with fundamental amendments to the Constitution or the introduction of another one. Constitutions are not the revealed Qur'an or sacred texts. The United States of America, France and a long list of countries throughout the world have amended their constitutions several times to keep pace with the developments of the times, and the needs of peoples and nations.

"Screening the government system administratively, technically and productively is an extremely important issue. It is realistic and practical. There is an explicit reference to what we are aiming for. It is expressed in the Kuwaiti Constitution, specifically Article 123: 'The Cabinet shall exercise control and supervision over the interests of the State. It shall lay down the public policy of the Government, shall follow its execution and shall control the operations in Government departments.'

"The organization of political action and its practices should take its share of serious studies. What makes us anxious about reconsidering the National Assembly, and thinking about creating an advanced and effective alternative that pushes towards construction, addressing thorny issues, improving political and social life, and preserving human, civil and legal gains without detracting from any of them?"

Kuwait tops MEED list of financial

GDP expected to decrease to 27.7 pc in 2024

performance of countries in MENA

KUWAIT CITY, Jan 1: Kuwait topped the MEED list of financial performance of countries in the Middle East and North Africa (MENA) with 30.3 percent gross domestic product (GDP) in 2023, while it is expected to decrease to 27.7 percent in 2024, reports Al-Anba daily.

Kuwait ranked first in the Gulf and regionally in terms of the fiscal balance as a percentage of the GDP, reaching 14 percent in 2023; while the magazine estimated that the percentage will decline to 9.5 in 2024. In terms of nominal domestic product, it reached \$159.9 billion in 2023 and it is expected to rise to \$167 billion in 2024.

Kuwait is the only one among the six Gulf Cooperation Council (GCC) countries to record negative growth in GDP for the year 2023, albeit a small percentage of 0.6 and MEED estimated that this percentage will increase to 3.6 in 2024.

MEED also reported that the economies of MENA countries are going through a dangerous stage, as geopolitical tensions and natural disasters weighed heavily on the region's economies in 2023, and that these economies are heading towards 2024 in a state of continuous change.

While most of these countries are considered in a good position to continue their growth path after the end of the Corona epidemic, but in the context of weak oil sector growth; some countries, most notably Egypt and Tunisia, are under strong pressure with the aim of carrying out painful reforms in order to obtain financing packages from the International Monetary Fund (IMF).

"In general, there are high hopes that growth in the MENA region will exceed, at least, the sluggish performance recorded last year," MEED said, and policymakers across the region will also look to double the dynamism of the private sector, which has witnessed non-oil growth outpacing the performance of the private sector in 2023. bizarre specifications, including the possibility of being miserable.

When you look at neighboring countries and their national output, and compare it with Kuwait, you find that we are more like a grocery store, and not a country seeking to diversify sources of its income.

In the Emirates, the tourism industry generated more than USD 25 billion in 2022. The share of Dubai alone was about USD 10 billion. On the other hand, Kuwait's share of tourists was less than one percent compared to the tourists in the Gulf countries, and most of them were from neighboring coun-

It is important to shed light on this resource, which constitutes a wastage of about ten billion dollars annually. as a result of Kuwaitis fleeing abroad on vacation, in addition to preventing visitors from entering the country, which adds about ten billion or more

There is no doubt that the first dilemma facing the tourism industry in facilities, but also the backward laws that contradict the nature of the social culture on which the state was founded nearly 400 years ago.

In fact, there is an effort to tighten it further, and impose other restrictions that contribute to the closure of the country.

This impacts the national income, which urgently requires diversification rather than the squandering of human resources. What might be deemed as bribing citizens through salary increments and bonuses does little to alleviate hunger amid rising inflation. Moreover, limited job opportunities persist due to the intricate and numerous considerations surrounding the establishment of new projects.

Perhaps the coming days will bring good tidings, based on what we heard from our new Amir. In his speeches, he had heralded a more prosperous era for Kuwait, especially with regard to correcting the relationship between the two authorities, and not having one

overpower the other. Nevertheless, it remains to be said that we must thank the MPs of extremism and weak governments, as they refrained from enacting a law that would prohibit citizens and residents from exchanging congratulations on holidays and special occasions, particularly at the onset of each new year. Otherwise, a circle of restriction would have been fully realized.

The bill mandates the Minister of Higher Education to form a committee chaired by the Undersecretary of the Higher Education Ministry; while the members include representatives of the academic staff at Kuwait University and the Public Authority for Applied Education and Training (PAAET), as well as the National Bureau for Academic Accreditation and the Directorate of Academic Certificates Accreditation at the Higher Education Ministry. The committee's tasks include the evaluation of academic certificates to determine if they are qualified for accreditation or not. The Minister of Higher Education shall specify the total number of committee members, the system for holding meetings and the executive regulations.

The bill also stipulates the formation of another committee to receive complaints regarding the decisions of the abovementioned committee and issue its decision within 30 days of receiving

the complaint. Meanwhile, MP Muhammad Hayef commented on the recent traffic accident along Abdally Road; urging

Minister of Electricity and Water and acting Minister of Public Works Jassem Al-Ostad to immediately instruct the concerned technical teams to repair damaged roads as the deteriorating conditions of roads expose the public to fatal dangers.

On the other hand, Chairman of the Parliamentary Coordination Committee MP Saud Al-Asfour disclosed that Minister of Social Affairs and State Minister for Family, Women and Children Affairs Sheikh Feras Al- Sabah said the government returned the Disabled Affairs Bill to the National Assembly after its ratification. He clarified that the committee has yet to receive the official reply of the government. He then affirmed that once the committee receives the government's reply, it will take the necessary measures as per the Constitution.

Furthermore, Deputy Prime Minister and Minister of Oil and Energy Saad Al-Barrak has responded to the queries of MP Mehalhal Al-Mudhaf regarding Kuwait National Petroleum Corporation (KNPC). He revealed the corporation will sell some of its assets and obtain loans as per the Islamic rules in order to cover the budget deficit. He stressed that the assets that the corporation intends to sell do not include strategic assets, adding such assets are no longer profitable.

The troop movement could signal that fighting is being scaled back in some areas of Gaza, particularly in the northern half where the military has said it is close to assuming operational control. Israel has been under pressure from its chief ally, the United States, to begin to switch to lower-intensity

Word of the drawdown came ahead of a visit by Secretary of State Antony Blinken to the region and after the Biden administration bypassed Congress for the second time this month to approve an emergency weapons sale to

But fierce fighting continued in other areas of Gaza, especially the southern city Khan Younis and central areas of the territory. Israel has pledged to charge ahead until its war aims have been achieved, including dismantling Hamas, which has ruled Gaza for 16

The military said in a statement Monday that five brigades, or several thousand troops, were being taken out of Gaza in the coming weeks for training and rest.

In a briefing Sunday that first announced the troop withdrawal without specifying how many forces were leaving, army spokesman Rear Adm. Daniel Hagari did not say whether the decision meant Israel was launching a new phase of the war.

"The objectives of the war require prolonged fighting, and we are preparing accordingly," he said.

Israel has vowed to crush Hamas' military and governing capabilities in its war, which was sparked by the militant group's Oct. 7 attack on southern Israel, which killed 1,200 people. Roughly 240 people were taken hos-

Israel responded with a blistering air, ground and sea offensive that has killed more than 21,900 people in Gaza, two-thirds of them women and children, according to the Health Ministry in Gaza, which does not differentiate between civilians and combatants in its count.

Israel says more than 8,000 militants have been killed, without providing evidence. It blames Hamas for the high civilian death toll, saying the militants embed within residential areas, including schools and hospitals.

'Majority of Kuwaitis wish to marry again'

KUWAIT CITY, Jan 1: The year 2023 ends in a bittersweet manner while the beginning of the year 2024 comes with hopes and aspirations at the public and private levels; as a wide segment of Kuwaiti citizens expressed various New Year wishes, but it is remarkable and funny that a large number of them wish to marry again, and others want to witness the repair of roads and streets or to buy a new car, reports Al-Qabas daily.

Chief Justice examines AI impact: Chief Justice John Roberts on Sunday turned his focus to the promise, and shortcomings, of artificial intelligence in the federal courts, in an annual report that made no mention of Supreme Court ethics or legal controversies involving Donald Trump.

Describing artificial intelligence as the "latest technological frontier," Roberts discussed the pros and cons of computergenerated content in the legal profession. His remarks come just a few days after the latest instance of AI-generated fake legal citations making their way into official court records, in a case involving ex-Trump lawyer Michael Cohen.

"Always a bad idea," Roberts wrote in his year-end report, noting that "any use of AI requires caution and humility.

At the same time, though, the chief justice acknowledged that AI can make it much easier for people without much money to access the courts. "These tools have the welcome potential to smooth out any mismatch between available resources and urgent needs in our court system," Roberts wrote.

The report came at the end of a year in which a series of stories questioned the ethical practices of the justices and the

DeSantis urges crowd to defy odds

Trump force frustrates some in Iowa

DES MOINES, Iowa, Jan 1, (AP): The Iowa frenzy is typically in full force by

With less than three weeks until the Iowa caucuses formally usher in the presidential nomination process, White House hopefuls are usually in a heated competition. They fan out across the state and pack as many events into a single day as is humanly possible - all in a bid to appeal to undecided voters and lock down support that could lift them to victory in Iowa and keep them

in the race for months to come. But as the campaign intensifies ahead of the Jan. 15 caucuses, the normal frenzy is subdued. While the schedule is filling up, former President Donald Trump is such a commanding force in the party that some voters worry the contest that normally transforms Iowa into the center of the political world may turn out to be something of

"It's kind of frustrating," said Jenna Maifeld, a 19-year-old student at the University of Iowa who is eager to participate in her first caucus but is disappointed with the campaign cycle's lack of competition. "I feel like a lot of people's voices aren't being heard."

There's still time for the dynamics of the race to shift. And Trump's rivals are hardly ceding the state to him, working to convince voters that his victory isn't inevitable. Florida Gov. Ron DeSantis has effectively centered his campaign on Iowa, pumping it with advertising and crafting a robust travel schedule of events and media availabilities. Former United Nations Ambassador Nikki Haley is also campaigning throughout Iowa, stepping up criticism of Trump while laying the groundwork for a potentially stronger showing in New Hampshire, where the Jan. 23 primary includes more independent voters.

The question is whether any of those efforts will notably erode Trump's standing, a prospect some voters find unlikely at this point.

"A lot of candidates are hoping that one of these spears in his back will finally take him down, but I doubt it," said Nick Peters, a 31-year-old from Prairie City who is also among the Iowa Republicans frustrated by Trump's dominance.

Trump enters the final stretch before the caucuses facing a host of challenges. He's the subject of 91 criminal charges related to everything from his handling of classified information to efforts to overturn the 2020 presidential election. The Colorado Supreme Court and Maine's top election official have recently declared Trump ineligi-ble to appear on their states' ballots, decisions the former president is likely to appeal to the U.S. Supreme Court.

And Trump is embroiled in controversy over his harsh rhetoric toward immigrants, repeatedly using language that extremism experts say echoes writings from Adolf Hitler about the "purity" of Aryan blood, which underpinned Nazi Germany's systematic murder of millions of Jews and other "undesirables" before and during World War II.

Vulnerabilities

For now, however, Trump's baggage appears to be doing little to deter a majority of Republican voters. In fact, Trump has sought to turn his vulnerabilities into something of an advantage, arguing that he's been indicted on behalf of his supporters. He's also aimed to turn around concerns that he poses a threat to democracy by accusing President Joe Biden of harnessing the power of government against a political rival. There's no evidence that Biden or the White House had any influence on the Justice Department's decision to criminally charge Trump.

It's Trump's impenetrable base of support that has left many feeling resigned to seeing his name on the ballot in November.

"If democracy is working fairly and if the country wants him, then it's going to be him," said Dylan Kooiman, a 21-year-old student at Dordt University in Sioux Center, Iowa, who said it would be hard for him to support Trump given his legal battles. "It doesn't always fall the way everyone wants it."

Iowans are historically proud of the role they play at the beginning of the presidential election calendar every four years. Voters are accustomed to intimate exchanges with candidates, who pay visits to living rooms, neighborhood centers and county fairgrounds in an effort to connect and persuade.

WEST DES MOINES: To underscore how much Iowa means to Ron DeSantis, the Florida governor was unwilling to put his campaigning there on hold even in the waning hours of 2023.

At a New Year's Eve event in a Sheraton Hotel ballroom in West Des Moines, jeans and cowboy boots outnumbered tuxedos and cocktail dresses, and Miller Lite seemed more popular than champagne.


While **Donald Trump** prepares to return this week for a series of rallies, DeSantis did not leave Iowa alone during the week between Christmas and New Year's. He campaigned in the suburbs of Des Moines, Cedar Rapids and Davenport, revisiting spots he had gone to in 2023 as part of his drive to touch all 99 of Iowa's counties as a gesture of commitment to the leadoff nominating contests. But Trump holds a large advantage

in Iowa polls as well as a sophisticated campaign organization in the state, threatening to deny DeSantis the win he needs to justify his claim to be the leading alternative to the former presi-

Appearing Sunday night with his wife, Casey, and their young children, DeSantis urged his audience to defy the odds. "I think we have an opportunity to just make a statement that in this country it's we the people that ultimately decide these things,' he said. "Because I think you have a lot of media, they don't think you even matter.'

DeSantis wasn't alone in Iowa between Christmas and New Year's, a period typically free from politics.

Japan issues tsunami warnings after strong quakes

Japan issued tsunami alerts and ordered evacuations following a series of earthquakes on Monday that started a fire and trapped people under rubble on the west coast of its main island.

The Japan Meterological Agency reported more than a dozen quakes off the coast of Ishikawa and nearby prefectures shortly after 4 p.m., one of them with a preliminary magnitude

The agency issued a major tsunami warning for Ishikawa and lowerlevel tsunami warnings or advisories for the rest of the western coast of the island of Honshu, as well as the northernmost of its main islands,

Hokkaido.

Japanese public broadcaster NHK TV warned torrents of water could reach as high as 5 meters (16.5 feet) and urged people to flee to high land or the top of a nearby building as quickly as possible.

NHK said the tsunami waves could keep returning, and warnings were continuing to be aired hours after the initial alert. Several aftershocks also rocked the region.

Government spokesman Yoshimasa Hayashi said it was critical for people in coastal areas to get away from the oncoming tsunami.

"Every minute counts. Please evacuate to a safe area immediately," he

A tsunami of about 3 meters (about 10 feet) high was expected to hit Niigata and other prefectures on the western coast of Japan, and the waves were confirmed to have reached parts of the coastline.

At least six homes were damaged by the quakes, with people trapped inside. A fire has broken out in Wajima city, Ishikawa Prefecture, and electricity is out for more than 30,000 households, Hayashi said.

He said no reports of deaths or injuries had been confirmed, saying the situation was still unclear. Japan's military was taking part in the rescue efforts, he said. (AP)

Denmark has Europe's oldest ruling monarchy, which traces its line back to the Viking king Gorm the Old, who died in 958. Although Magrethe is head of state, the Danish Constitution strictly ruled out her involvement in party poli-

Yet the queen was clearly well-versed in law and knew the contents of the legislation she was called upon to sign.

She received training in French and nglish from her earliest years as wel Swedish from her mother. In addition to archaeology, she studied philosophy, political science and economics at universities in Copenhagen, Aarhus and Cambridge along with the London School of Economics and the Sorbonne in Paris.

Ever since his birth on May 26, 1968, Frederik André Henrik Christian has been the heir to the Danish throne.

He is the oldest son of Queen Margrethe and her late French-born husband, Prince Henrik, who died February 2018. Frederik, 55, has a younger brother, Prince Joachim.

Since the age of 18, he has served as regent whenever his mother was outside the kingdom and carried out official duties, shaking hands with thousands and receiving foreign dignitaries.

The queen's announcement made up only a few sentences at the end of her wide-ranging New Year's speech which reflected on the "turbulence and upheaval in the world" amid the wars in the Middle East and Ukraine, and the climate crisis.

Putin lauds Russian unity: Russian President Vladimir Putin praised Russia's "united society" in his prerecorded New Year's address to the nation, the country's state news agencies reported Sunday. Putin addressed Russians in a video

that ran under four minutes long, sig-nificantly shorter than the New Year's speech he gave last year, according to state news agency RIA Novosti. Millions of people were expected to watch the new address when it airs on TV as each Russian time zone region counts down the final minutes of 2023 on Sunday.

The first to see it were residents of the Kamchatka Peninsula and the Chukotka region in Russia's Far East, some nine hours ahead of Moscow.

Returning to tradition after speaking flanked by soldiers last year, Putin delivered his address to the nation against the backdrop of a snowy Kremlin. In remarks carried by RIA Novosti, he described 2023 as a year marked by high levels of unity in Russian society. (AP)

The Ukrainian Air Force said Sunday that it had shot down 21 of 49 drones launched by Russian forces overnight.

The retaliatory Russian attack wounded 28 people in the eastern Ukrainian city of Kharkiv, regional Gov. Oleh Syniehubov said. A hotel, kindergarten, apartment buildings, shops and administrative buildings sustained damage, according to the regional prosecutor's office.

Russia's Defense Ministry said it had targeted "decision-making centers and military facilities" in Kharkiv. The ministry said the hit on the Kharkiv Palace Hotel had "destroyed representatives of the Main Intelligence Directorate and Ukrainian Armed Forces" involved in the "terrorist attack" in Belgorod.

Ukrainian Interior Minister Ihor Klymenko said a British journalist was among the wounded, while public German broadcaster ZDF said Sunday that one of its television crews had been in the hotel. A Ukrainian translator was hit by debris and seriously wounded, and one of the team's security guards also was injured, ZDF said in a statement.

"This is another attack by Russia on the free press," ZDF Editor-in-Chief Bettina Schausten said.

A second trial of FTX founder Sam Bankman-Fried on charges not in the cryptocurrency fraud case presented to a jury that convicted him in November is not necessary,

prosecutors told a judge Friday.
Prosecutors told U.S. District
Judge Lewis A. Kaplan in a letter that evidence at a second trial would duplicate evidence already shown to a jury. They also said it would ignore the "strong public interest in a prompt resolution" of the case, particularly

because victims would not benefit from forfeiture or restitution orders if sentencing is delayed.

They said the judge can consider the evidence that would be used at a second trial when he sentences Bankman-Fried on March 28 for defrauding customers and investors of at least \$10 billion.

Bankman-Fried, 31, who has been incarcerated since several weeks before his trial, was convicted in early November of seven counts, including wire fraud, wire fraud conspiracy and three conspiracy charges. He could face decades in prison.

Last spring, prosecutors withdrew some charges they had brought against Bankman-Fried because the charges had not been approved as part of his extradition from the Bahamas in December 2022. They said the charges could be brought at a second trial to oc-cur sometime in 2024. (AP)

Google settles \$5 billion privacy lawsuit

Google has agreed to settle a \$5 billion privacy lawsuit alleging that it spied on people who used the "incognito" mode in its Chrome browser - along with similar "private" modes in other browsers - to track their internet use.

The class-action lawsuit filed in 2020 said Google misled users into believing that it wouldn't track their internet activities while using incognito mode. It argued that Google's advertising technologies and other techniques continued to catalog details of users' site visits and activities despite their use of supposedly "pri-

vate" browsing. Plaintiffs also charged that Google's activities yielded an 'unaccountable trove of information" about users who thought they'd taken steps to protect their privacy.

The settlement, reached Thursday, must still be approved by a federal judge. Terms weren't disclosed, but the suit originally sought \$5 billion on behalf of users; lawyers for the plaintiffs said they expect to present the court with a final settlement agreement by Feb. 24.

Google did not immediately respond to a request for comment on the settlement. (AP)

Bond market rallies on aggressive rate cut expectations

Bond market rallies on aggressive rate cut expecta-

Global bonds and government securities witnessed gains recently backed by a faster-than-expected rate cut expectations, although a number of economists said that the market is being overly optimistic. Traders are now pricing in disinflationary pressure over the next few months resulting in an accelerated rate cut approach. This was reflected in yield on treasury bonds that swung from a 16-year high to multi-month lows. Yield on US 10-year treasury bonds declined from 5.02% in October-2023 to around 4.3% by the third week of December-2023. The yield on Bund and gilts also dropped to multi-month lows reflecting latest data on inflation that came in lower than market expectations. Swap traders priced in almost six 25 bps cuts next year, that many believed to be overly aggressive. Cuts from ECB were even more steeper, with traders pricing in 162 bps decline next year led by softer economic data and slowing inflation. Market is now expecting ECB to be the first to implement rate cuts next year, although the ECB vehemently denied the forecast in a recent statement. The EU is also implementing new rules on the fiscal front related to breaches to budget deficits and debt-to-GDP ratio in order to realign policies more in line with new economic realities.


The impact on GCC economies is expected to be largely positive as global economic slowdown in now expected to be softer-than-expected, with soft landing in economic growth. This coupled with lower inflation rates in the GCC should augur well for the region in terms of GDP growth backed by thriving non-oil GDP, a strong project pipeline and elevated oil price above the USD 70/b mark. In addition, the strong credit profile of most countries in the GCC with recent upgrades this year also provides stability to currency and the fixed income funding market.

In the primary market, GCC bonds and sukuk issuances exceeded our and market expectations with several big-ticket issuances during the second half of the year. Sukuk issuances in Saudi Arabia coupled with bond issuances in the UAE during 2H-2023 pushed aggregate issuances in the GCC to over USD 100 Bn at USD 107.8 Bn by mid-December-2023. This compares with USD 90.0 Bn in total bond and sukuk issuances in the GCC during full year 2022. However, despite the growth, issuances in the GCC remained well below the issuances seen during the preceding five years (2017-2022) that averaged at USD 136.2 Bn.

Inflation and interest rate hikes

The slowing inflation seen over the last few months have drastically altered investor and trader's expectation for the fixed income market. The last meeting of the year was instrumental in changing the rate cut/pause forecasts for 2024. From a scattered expectation of one or two hikes in 2024 during the later half of 2024 just a few months ago, the consensus forecast now shows at least 150 bps cuts during 2024. Some economists also see earlier rate cuts in the US as against 2H-2024 cuts as per previous expectations

In its most recent meeting, the US Fed kept the rates unchanged in the range of 5.25% - 5.5% after consistent hikes until July-2023. The rate pause was expected by the market as inflation is seen cooling in the near term and economic growth is expected to remain subdued. The most recent reading of headline inflation came in at 3.1% y-o-y growth during November-2023 after showing a gradual decline since the start of the year. Excluding volatile food and energy prices, the core CPI increased 0.3% as compared to the previous month and 4% y-o-y. Prices for a broad range of goods and services were higher in November-2023, but were in line with expectations. In terms of forecast, The US

Fed expects inflation to fall to 2.4% in 2024, lower than its previous forecast of 2.6%. The Fed forecasted core personal consumption expenditures price index to decline to 2.2% by 2025 (2.3% expected previously) and finally reach its 2.0%

Rates hikes by the ECB also took a pause after 10 consecutive rate hikes until September-2022. The bank raised its rate for refinancing operations to a record 4.5% and deposit rate also to a record 4.0% in September-2023 after the most aggressive tightening of monetary policy in the ECB's 25year existence. The uncertainty related to economic growth and inflation trend was significantly high at the time of the rate hike and as a result analysts and traders were expecting a rate cut only during the third quarter of 2024 at the earliest. However, after a steep fall in inflation that dropped to 2.4% last month from 10% a year earlier put the EU's 2% inflation target in sight and proved the group's earlier forecast which said that inflation would remain stubborn for the next two years. Even the most influential and hawkish policymakers in the EU changed their stance to an earlier and steeper rate cut next year.

Meanwhile, in the GCC, economic growth was revised lower after the decision by the OPEC+ to slash oil productions until next year and added voluntary cuts until the first quarter of 2024. Crude oil prices also provided volatility to forecasts after a wild swing in prices that reached multimonth lows during the second half of the year. Nevertheless, inflation in the region remained under control as a result of proactive policies of the regional governments and mostly trended lower over the last few month. The trend in interest rates in the GCC was almost in line with that by the US Fed. Most GCC central banks raised rates by 100 bps while some implemented lower rate hikes depending on the existing rates and the pressure on the currency pegs. The rating actions in the GCC were largely positive during this year with most upgrades to Oman after the country successfully steered the economy from deficits to a much more manageable finances, including earlier than maturity repayment of debt. The sultanate was upgraded by all the three ratings agencies and the most recent upgrade from Moody's cited improvement in debt affordability matrix as the rationale for

Bond/Sukuk Maturities

GCC governments are expected to see elevated levels of maturities over the next five years. According to data from Bloomberg, GCC sovereign maturities stands at USD 209.3 Bn over the next five years (2024-2028), whereas corporate maturities stand significantly lower at USD 177.9 Bn. Both bond and sukuk maturities are expected to remain elevated starting from 2024 until 2028 and then gradually taper for the rest of the tenor. The higher maturities during the next five years reflects a number of short-term (less than 5-year maturity) issuances in 2020 and 2021 as governments raised funds to plug-in deficits during the pandemic. A majority of these maturities are denominated in USD at 59.7% followed by local currency issuances in SAR and QAR at 16.3% and 7.6%, respectively. In addition, due to the credit rating profile of the GCC governments, a majority of these maturities are in the high investment grade or A rated instruments. In terms of type of instruments, conventional bonds dominate with USD 244.3 Bn in maturities over the next five years, whereas sukuk maturities are expected to be at USD 142.9 Bn. In terms of country split, Saudi Arabia continues to see the biggest maturities during 2024-2028. The Kingdom is expected to see maturities of USD 131.9 Bn until 2028 followed by UAE and Qatari issuers at USD 122.5 Bn and USD 71.4 Bn, respectively. Kuwait has the smallest maturities in five years at USD 14.1 Bn due to lack of government issu-

In terms of sector maturities, Banks and other Financial Services sector have USD 130.9 Bn in maturities in the next five years, accounting for around 73.6% of the total corporate maturities and 33.8% of the total maturities in the GCC until 2028, respectively. The Energy sector was next with maturities of USD 17.9 Bn or 10.0% of GCC corporate maturities until 2028 followed by Utilities and Communications at USD 11.4 Bn and USD 6.1 Bn, respectively. Banks in UAE have the biggest maturities over the next five years at USD 60.2 Bn followed by Qatari banks with maturities of USD 26.3 Bn. Banks in the two countries accounted for 22.3% of total bond/sukuk maturities over the next five years in the GCC. Real Estate maturities are concentrated mainly in the UAE and Saudi Arabia at USD 6.3 Bn and USD 2.9 Bn, respectively, until 2028. The structure of maturities saw perpetual instruments seeing consistent growth until 2022. However, 2023 witnessed a steep decline in issuances of perpetual instruments. According to data from Bloomberg, aggregate issuances declined from USD 11.5 Bn in 2023 to merely USD 2.0 Bn during 2023.

Issuances in 2023

Aggregate issuances from 1-January-2023 until the third week of December-2023 stood at USD 107.8 Bn as compared to USD 90.0 Bn during 2022, resulting in an increase of USD 17.8 Bn or 19.7%. The increase was mainly led by higher corporate issuances that went up from USD 40.5 Bn in 2022 to USD 66.2 Bn in 2023. On the other hand, government issuances dropped by 15.9% or USD 7.9 Bn in 2023 to reach USD 41.6 Bn as compared to USD 49.5 Bn in 2022. In terms of type of issuance, both bond and sukuk issuances witnessed growth during the year. A garagate GCC bond is witnessed growth during the year. Aggregate GCC bond issues went up by 43.7% or USD 17.6 Bn to reach USD 58.0 Bn as compared to USD 40.4 Bn in 2022. Sukuk issuances, on the other hand, witnessed marginal growth during the year to reach USD 49.8 Bn. At the country level, Kuwait, Qatar and Oman reported declines in issuances in 2023 vs. 2022 while the rest of the GCC countries witnessed growth. UAE issuers reported the biggest absolute growth in fixed income issuances this year with an increase of USD 18.4 Bn or 77.4% to reach USD 42.2 Bn in issuances. Saudi Arabia reported a small growth of USD 0.8 Bn or 1.5% but remained the biggest issuer this year with aggregate bonds and sukuk issuances reaching USD 52.1 Bn in 2023.

Outlook - Fed vs. GCC rate moves

The consensus estimates on policy rates by major central banks shows cuts across the globe in 2024 ranging from over 200 bps to 50 bps. According to Bloomberg consensus estimates, the US Fed is forecasted to lower rates by 156 bps in 2024 and end of year rates are forecasted to be at 3.82%. The Eurozone is forecasted to make more aggressive rate cuts next year slashing policy rates by 219 bps with ching 2 319 and New Zealand are forecasted to lower rates by around 100 bps next year. For the GCC, we have forecasted rates based on US Fed rate cuts. As a result, most central banks in the GCC would slash rates in line with the US Fed due to the pegged currencies. However, Kuwait has its currency pegged to a basket of currencies. As such, we've forecasted a 100 bps cut by the Kuwait Central Bank in its discount rate. This is lower than the cuts in the rest of the GCC countries as Kuwait has made the smallest aggregate rate hike in the GCC since 2022 (275 bps) and since the start of the year (75 bps) and we believe that the roll back of rates would also be smaller than the rest of the GCC.

KPC to borrow \$45 bn in the coming five yrs

ast month, Kuwait Petroleum Corporation (KPC) had announced its decision to borrow about KD 14 billion (\$45 billion) in the

coming five years, which is about KD 3 billion per year, in order to meet strategic long-term investment plans mainly for exploration, and for developing and enhancing old crude oil fields.

ternationally, and try to privatize some of its non-core activities that impose more burden upon it. However, it necessitates a form of consensus with the parliament, ensuring non-intrusiveness and alignment with the state's interests, in accordance with approved regulations, mirroring practices adopted in neighboring countries. A clear example is the sale of five percent of the formidable Aramco. However, it's noteworthy that KPC is neither pursuing nor considering such a daring move.

KPC has outlined its main investment strategies, allocating 60 percent toward the development and exploration of new oil discoveries, as well as enhancing and optimizing production from existing fields. This includes a focus on increasing free gas production, which is not independent and unrelated to oil production. Hence, the core of its future

investments relies on boosting crude oil production, which has experienced a decline since 2016.

International oil companies decline to engage with our friends and develop their production potential unless some form of agreement guarantees a specified volume for each barrel produced through their expertise and technology.

Working on a rental basis is a thing of the past. However, our Kuwait Oil Company (KOC) ei-ther rejects acknowledging such arrangements or struggles to address concerns raised by parliament members to avoid complications. This is despite the fact that many neighboring countries have established similar production-sharing arrangements within the agreed-upon rules and

conditions of sovereign states. Indeed, it is imperative for both KPC and KOC to play a proactive role in advocating for inviting oil companies. It is crucial to openly acknowledge our limitations in increasing crude oil production to nearly three million barrels per day or beyond. As the weakest link in oil production management and output, Kuwait must rely on the expertise and technology of international oil

Simultaneously, KPC is not obligated to borrow the entire \$45 billion in one go. It has the option to generate a portion of the required funds by selling and privatizing certain companies, initially created and developed by the private sector. This includes entities such as tanker and petrochemical companies. Notably, our refining company had a 40% ownership by the private sector when first established in 1962

China's manufacturing contraction worsens in Dec as demand weakens

BANGKOK, Jan 1, (AP): A survey of factory managers in China shows manufacturing contracted in December in the latest sign the world's second-largest economy remains sluggish.

The official purchasing managers index, or PMI, fell to 49 last month in what officials said was evidence of weak demand, the National Bureau of Statistics reported on Sunday. It was the third straight month of contraction. The PMI is on a scale up to 100 where 50 marks the cutoff between expansion and contraction.

The index has fallen in eight of the past nine months, with an increase only in September. In November, the index was at 49.4, down from 49.5 the month before.

Despite unexpectedly prolonged weakness after the pandemic, China's economy grew at a 5.2% pace in the first three quarters of the year and showed signs of improvement in November, with factory output and retail sales rising.

In recent months, the government has raised spending on construction of ports and other infrastructure, cut interest rates and eased curbs on home-buying to try to stimulate the domestic demand that economists say is needed to sustain growth.

Smooth transition

In his New Year speech, leader Xi Jinping said China had achieved a "smooth transition" from the country's response to the pandemic, which at times involved the shut downs of factories and parts of or entire cities.

China's economy has become "more resilient and dynamic than before," Xi said in remarks carried by the official Xinhua News Agency.

Global demand for manufactured goods has suffered as central banks around the world have raised interest rates to battle decades-high rates of inflation. Price pressures have eased in recent months, but demand has yet to rebound to prepandemic levels. That has ramifications across the region since supply chains linked to China are scattered across many

Reliance on exports to fuel growth in China means more competition as the government invests in still more industrial construction, Stephen Innes of SPI Asset Management said in a commentary. He noted that "the biggest constraint on the manufacturing sector hasn't been access to capital but rather weak demand, so expanding manufacturing investment mostly means expanding ex-

cess capacity.' China's non-manufacturing PMI rose in December to 50.4, the statistics bureau reported. The service sector PMI sub-index was 49.3, however, unchanged from Novem-

ber's reading.

Despite a slump in the housing market brought about by a crackdown on excess borrowing by property developers, the construction industry is thriving: the sub-index for that sector climbed to 56.9 in December, well into expansionary territory, from 55 in November, the

Milei's latest policy shift

Argentina formally announces it won't join the BRICS alliance

BUENOS AIRES, Jan 1, (AP): Argentina formally announced Friday that it won't join the BRICS bloc of developing economies, the latest in a dramatic shift in foreign and economic policy by Argentina's new far-right populist President Javier Milei.

In a letter addressed to the leaders of Brazil, Russia, India, China and South Africa - all members of the alliance - Milei said the moment was not "opportune" for Argentina to join as a full member. The letter was dated a week ago, Dec. 22, but released by the Argentine government on Friday, the last working day of 2023.

Argentina was among six countries invited in August to join the bloc made up of Brazil, Russia, India, China and South Africa to make an 11-nation bloc.

Argentina was set to join Jan. 1, 2024. The move comes as Argentina has been left reeling by deepening economic

Milei's predecessor, former centerleft president Alberto Fernandez, endorsed joining the alliance as an opportunity to reach new markets. The BRICS currently account for about 40% of the world's population and more than a quarter of the world's GDP.

But economic turmoil left many in Argentina eager for change, ushering

chainsaw-wielding political outsider Milei into the presidency.

Milei, who defines himself as an "an-archo-capitalist" - a current within liberalism that aspires to eliminate the state has implemented a series of measures to deregulate the economy, which in recent decades has been marked by strong state interventionism.

In foreign policy, he has proclaimed full alignment with the "free nations of the West," especially the United States and Israel.

Throughout the campaign for the presidency, Milei also disparaged countries ruled "by communism" and announced that he would not maintain diplomatic relations with them despite growing Chinese investment in South

However, in the letter addressed to his counterpart Luiz Inácio Lula Da Silva in neighboring Brazil and the rest of the leaders of full BRICS members Xi Jinping of China, Narenda Mondi of India, Vladimir Putin of Russia and Matamela Ramaphosa of South Africa - Milei proposed to "intensify bilateral ties" and increase "trade and investment

Milei also expressed his readiness to hold meetings with each of the five

Resilient economy energizes investors as financial markets end 2023 up 24% Prospect of lower interest rates buoyed investors

NEW YORK, Jan 1, (AP): The S&P 500 closed out 2023 with a gain of more than 24% and the Dow finished near a record high, as easing inflation, a resilient economy and the prospect of lower interest rates buoyed investors, particularly in the last two months of the year.

Stocks closed Friday with mod-

The S&P 500 slipped 13.52 points, or 0.3%, to 4,769.83. The benchmark index still posted a rare ninth consecutive week of gains and is just 0.6% shy of an all-time high set in January of 2022.

The Dow Jones Industrial Average fell 20.56 points, or 0.1%, to 37,689.54 after setting a record Thursday.

The Nasdaq slipped 83.78 points, or 0.6%, to 15,011.35, but that was barely a blemish on an annual gain of more than 43%, its best performance since 2020.

Driven

For most of the year, gains in the broader market were driven largely by seven stocks -- Apple, Microsoft, Alphabet, Amazon, Nvidia, Meta Platforms and Tesla. Dubbed the Magnificent 7, they accounted for about two-thirds of the gains in the

and finished 2023 with a 15.1% gain after falling 21.6% in 2022.

"It was broad participation in the market that reinforced and confirmed gains for smaller company stocks that were particularly important," Krosby said.

Investors in the U.S. came into this year bearing the bruises of sharp losses for both stocks and bonds in 2022. They expected inflation to ease further as the Federal Reserve pushed interest rates higher. The trade-off would be a weaker economy and possibly a recession. But while inflation has come down to around 3%, the economy has chugged along thanks to solid consumer spending and a healthy job

The stock market is now betting the Fed can achieve a "soft landing," where the economy slows just enough to snuff out high inflation, but not so much that it falls into a recession. As a result, investors now expect the Fed to begin cutting rates as early as March.

The Fed has signaled three quarterpoint cuts to its benchmark interest rate next year. That rate is currently sitting between 5.25% and 5.50%, its highest level in two decades.

Lower rates could add more fuel to the broader market's momentum in 2024. Wall Street is forecasting stronger earnings growth for companies next year after a largely lackluster 2023, when companies wrestled with higher input and labor costs and a shift in consumer spending.

Bond market investors appeared headed for a third losing year in a row until things turned around starting in late October. Excitement about potential cuts to interest rates sent bond prices soaring and yields dropping. The yield on the 10-year Treasury, which hit 5% in October, stood at 3.88% Friday, up from 3.85% on Thursday.

The yield on the two-year Treasury, which more closely tracks expectations for the Fed, fell to 4.25% from 4.28% from late Thursday. It also surpassed 5% in October.

Many global markets also saw solid gains this year. Indexes in France and Germany made double-digit advances, while Britain's has climbed just under 4%

Tokyo's Nikkei 225 gained 27% in 2023, its best year in a decade as the Japanese central bank inched toward ending its longstanding ultra-lax monetary policy after inflation finally exceeded its target of about 2%.

The Shanghai Composite index lost about 3% this year and the Hang Seng index in Hong Kong fell nearly 14%. Weakness in the property sector and in global demand for China's exports, as well as high debt levels and wavering consumer confidence have weighed on the country's economy and the stock market.

U.S. and international crude oil prices were relatively stable on Friday. The price of oil tumbled by more than 10% this year, defying predictions from some experts that it could cross \$100 per barrel.

Despite production cuts from OPEC, a war involving energy exporter Russia and another in the Middle East, U.S. benchmark crude dropped nearly 11% in 2023, and a whopping 21% in the final three months of the year.

Increased production in the U.S., now the top oil producer in the world, as well as Canada, Brazil and Guyana offset the reduced output from OPEC. Not all OPEC members participated in the cuts and some countries like Iran and Venezuela are pumping more oil, energy ana-



Minimum-wage workers now earn up to \$16

Empire State rings in the new year with a pay bump

ALBANY, N.Y., Jan 1, (AP): New York's minimum-wage workers had more than just the new year to celebrate Monday, with a pay bump kicking in as the clock ticked over to 2024.

In the first of a series of annual increases slated for the Empire State, the minimum wage increased to \$16 in New York City and some of its suburbs, up from \$15. In the rest of the state, the new minimum wage is \$15, up from \$14.20.

The state's minimum wage is expected to increase every year until it reaches \$17 in New York City and its suburbs, and \$16 in the rest of the state by 2026. Future hikes will be tied to the Consumer Price Index for Urban Wage Earners and Clerical Workers, a measurement of inflation.

New York is one of 22 states getting minimum wage rises in the new year, according to a recent report by the Economic Policy Insti-

In California, the minimum wage increased to \$16, up from \$15.50, while in Connecticut it increased to \$15.69 from the previous rate of

This most recent pay bump in New York is part of an agreement made last year between Democratic Gov. Kathy Hochul and the state Legislature. The deal came over the objections of some employers, as well as some liberal Democrats who said it didn't go high enough.

The federal minimum wage in the United States has stayed at \$7.25 per hour since 2009, but states and some localities are free to set higher amounts. Thirty states, including New Mexico and Washington, have done so.



From the first spray of fireworks to the closing chorus of "Auld Lang Syne" 366 days into the future - 2024 is a leap year - it could be the year for finally achieving long-elusive goals, fulfilling aspirations and being resolute on all those New Year resolutions.

"As humans, we are creatures that aspire," said Omid Fotuhi, a social psychologist who is a motivation and performance researcher.

"The fact that we have goals, the fact that we want to set goals is just a manifestation of that internal and almost universal desire to want to stretch, to want to reach, to want to expand and grow," said Fotuhi, the director of learning innovation at Western Governors University Labs and a research associate at the University of Pittsburgh.

"New Year's resolutions are one of those ways in which we do that," he said. "There's something very liberating about a fresh start. Imagine starting on a blank canvas. Anything is possible.

If so, could this be the year to run a marathon, vanquish (or make peace with) old foes such as the bathroom scale and a thickening waist? Maybe learn Mandarin or register to vote, and actually vote? So many questions, and so much time to delay.

Tim Williams used to issue himself a panoply of resolutions: lose weight, drink less, exercise more and yada yada.

Now, he doesn't bother.

"In the past, I would make them, and I would fail or give up on them or whatever," said Williams, a part-time resident of Fort Lauderdale, Florida

Carla Valeria Silva de Santos, a Florida transplant from Brazil, wants to learn to play the guitar. A native Portuguese speaker, she wants to learn Spanish and improve her English.

With any resolution, she said, the ultimate goal is "to improve your life and be in peace with yourself."

Josh Moore, another Fort Lauderdale resident, sees things in line with the natural philosopher Sir Isaac Newton and physics. For every action there must be an equal reaction.

"If you do something like eat a bunch of candy or a bunch of desserts at a holiday party, go run," he said while interrupting a jog with his dog. "Maybe you went out drinking too much and you might have a hangover. But then next day when you're feeling better, go to the

Too many people are too soft on themselves, he posited. "You've got to actually hold yourself accountable.

Resolutions don't have to be big, grandiose or overly ambitious, Fo-Even it they are, he said value should not exclusively be derived

from the achievement but also be measured by what you become by trying to better yourself. "Goals are only there to serve a function to get you started," Fotuhi said. "If they don't do that, then maybe that's not the appropriate goal

In other words, it is a time to recalibrate goals and expectations, he said, adding that some people hang on to outdated goals for way too long.

"If you set a goal that's overly ambitious, that doesn't have the effect of getting you excited and making you believe that it's possible, then maybe you should think about a goal that's a little bit more within your reach - starting with a 5k for instance, then moving up to 10K, Fotuhi said

Soul-stirring adaptation shines with stellar cast

'Color Purple' unleashes musical magic

Exuberant performances from a cast led by Fantasia Barrino, Taraji P. Henson and Danielle Brooks breathe life into Blitz Bazawule's stirring "The Color Purple," adapted from the Tony-winning Broadway production.

Alice Walker's Pulitzer Prize-winning 1982 novel, which Steven Spielberg turned into the 1985 film, may be an unlikely book for such bright adaptations. Walker's novel, told through Celie's letters penned to God, is harrowingly bleak in its tale of trauma, poverty, abuse and rape. Much of Walker's "The

Color Purple" doesn't scream song and dance. But the emotional triumphs of Walker's novel and its soul-stirring tribute to the power of Black women lend themselves to the kind of maximalist spectacle of Bazawule's razzle-dazzle adaptation. The tragedy found in "The Color Purple" makes its final release all the more rousing.

It can still be an awkward mix, and, like Spielberg's movie, not all of the tonal changes work in this version of "The Color Purple." But the payoff is immense, as are the thrilling performances at the movie's center.

Barrino, who in 2007 took over the role on Broadway, plays Celie with a raw soulfulness. In the film's opening scenes, she's picked by Mister (Colman Domingo) to be his wife, though her role at his messy, ramshackle home is much closer to

Life with Mister, who regularly beats her, is a nightmare. That Domingo is able play such a loathsome, cruel character and yet still find subtle notes of woundedness and ultimately redemption in Mister is a testament to his dynamism as an actor. The roots of Mister's barbarism are traced to his own brutal father (Louis Gossett Jr.), one of the numerous ways in which "The Color Purple" contemplates cycles of abuse and inherited pain.

Celie, separated from her beloved sister Nettie (Halle Bailey), has little to look forward to. But after years go by, signs of possibility begin entering the orbit of her savage rural corner of early 20th century

Georgia. First there's Sofia (Brooks), the wife of Mister's more sensitive son Harpo (Corey Hawkins), who builds a juke joint on a pier above a swamp. Brooks, reprising the role she played in the 2015 stage revival, is a revelation as the strong-willed, admirably reckless Sofia. Her forceful and funny entry (and her thundering song "Hell No!") announce a female empowerment Celie hasn't ever dared to imagine.

Bazawule's film, penned by playwright Marcus Gardley, wavers most in the balance of its first half. The musical scenes, with kinetic choreography from Fatima Robinson, perhaps come too fast and furious, distracting from our connection with the meek Celie.

Affection

The numbers are richly conceived — the juke joint (part of the excellent production design of Paul Denham Austerberry) is pierced with light shining through wooden planks. But some flights of fancy, like one number in which Celie is transported onto a giant turntable, make for a herky-jerky flow. The jumbled book-to-movie-to-musical-to-movie-musical path of "The Color Purple" sometimes shows.

But the film takes off when Shug (Henson) makes her show-stopping entrance. Shug, a glamorous singer who breezes in and out of their country lives, is whom Mister most pines for — and whom Celie has great affection for, as well.

Henson, outfitted sumptuously by costumer Francine Jamison-Tanchuck, gives "The Color Purple" a vivid, movie-star splash. Celie and Shug's romance has often been downplayed — it was almost totally absent Spielberg's film. This version, while still falling short, does a little better thanks to their tender duet "What About Love?"

In this lengthy and star-packed musical (Ciara, Jon Batiste, H.E.R. and Aunjanue Ellis-Taylor are just some of the cameos), there are more dramatic ups

and downs to go. But the movie builds irresistibly toward the hard-earned emancipation of Celie, and Barrino's climactic, impassioned performance of

"I'm Here." Bazawule, the Ghana-born filmmaker, has made one previous feature ("The Burial of Kojo"). But he also performs as the hip-hop artist Blitz the Ambassador and directed Beyoncé's "Black Is King" visual album. And his adroitness in capturing musical performance is easy to see in "The Color Purple," produced by a trio of heavyweights from the first film:

Oprah Winfrey, Spielberg and Quincy Jones. But it's the movie's own power trio of Barrino, Brooks and Henson that makes "The Color Purple" one of the most moving big-screen musicals in recent years. Each in their own way transforms suffering

into exhilarating portraits of survival and strength. "The Color Purple," a Warner Bros. release, is rated PG-13 by the Motion Picture Association for mature thematic content, sexual content, violence and language. Running time: 140 minutes. Three and a half stars out of four

Shecky Greene dead

'Full Monty' star Tom Wilkinson dies at 75

LONDON, Jan 1, (AP): Tom Wilkinson, the Oscarnominated British actor known for his roles in "The "Michael Clayton" and "The Best Exotic Marigold Hotel," has died, his family said. He was 75.

A statement shared by his agent on behalf of the family said Wilkinson died suddenly at home on Saturday. It didn't provide further details.

Wilkinson was nominated for a best actor Academy Award for his work in 2001's family drama "In The Bedroom" and in the best supporting actor category for his role in "Michael Clayton," a 2007 legal thriller that starred George Clooney.

He is remembered by many in Britain and beyond for playing former steel mill foreman Gerald Cooper in the 1997 comedy "The Full



Monty," about a group of un-employed steel workers who formed an unlikely male stripping act. Wilkinson was born in Yorkshire in northern England

in 1948 and spent part of his childhood in Canada. He attended the Royal Academy of Dramatic Art in the 1970s. He starred in dozens of other

TV dramas and movies, from "Rush Hour" and "Batman Begins" to "Shakespeare in Love," "Eternal Sunshine of the Spotless Mind" and "Valkyrie."

He most recently reunited with his "Full Monty" co-stars, Robert Carlyle and Mark Addy in a Disney+ series of the same name.

"He'll be sorely missed by everyone who had the pleasure of working with him," Carlyle said in a statement. "Such a huge performer, a real titan of an actor, one of the greats of not only his, but of any genera-

Wilkinson was recognized for his services to drama in 2005 when he was appointed a member of the Order of the British Empire. He also won a 2009 Golden Globe and 2008 Emmy

for his role as Benjamin Franklin in the HBO series "John Adams."

Wilkinson married actress Diana Hardcastle in 1988. The couple had two daughters.

Shecky Greene, the gifted comic and master improviser who became the consummate Las Vegas lounge headliner and was revered by his peers and live audiences as one of the greatest standup acts of his generation, has died. He was 97.

His widow, Marie Musso Green, told the Las Vegas Review-Journal that her husband died early Sunday at their home. She said her husband of 41 years died of natural causes. Those who saw Greene in his decades of comedy

dominance on the Vegas Strip in the 1950s, '60s and '70s said that with a mic in his hand he could roam a room and work a crowd like no other.

He couldn't wait to abandon written jokes for the shared thrill of improv.

"I've never had an act," Greene told the Las Vegas Sun in 2009. "I make it up as I go along."

Greene made huge fans of his fellow entertainers including Bob Hope, Johnny Carson, and, most famously, Frank Sinatra, who hand-picked him as his opening act for a stretch. Greene couldn't resist the gig with the biggest star in America at the time, but the two big personalities butted heads frequently, and the relationship ended with the comic taking a beating from the singer's cronies at the Fontainebleau hotel in Miami Beach.

It led to his most famous joke:

"Frank Sinatra once saved my life," Greene would say. "A bunch of guys were beating on me and Frank said, 'OK that's enough."

Sinatra wasn't actually there, Greene later said, but the beatdown was real. Also true was the oft-repeated story of Greene driving his Oldsmobile into the fountains at Caesars Palace in 1968, a consequence of what he conceded was a serious alcohol problem and a dangerous desire to go for a drive when he was a few drinks in.

He got a famous joke out of that moment too, later saying that when the cops arrived at his submerged car, whose windshield wipers running, he told them, "No spray wax please!"

With a body like a linebacker's, a wit as quick as lightning and a voice that suggested he could've been a lounge singer instead of a lounge comic, Greene in the course of a night would plow through dozens of impressions, do extended riffs at audience members' tables and turn musical standards into parody songs on the spot.

Tony Zoppi, who for decades was entertainment director of the Riviera Hotel, said Greene was the finest comic mind he ever saw.

"He'll walk out on a stage and do an hour off the top of his head," Zoppi told the Los Angeles Times. "A waitress dropped a glass - he did 15 minutes."

Appearances

He made appearances in films including 1967's "Tony Rome" with Sinatra, 1981's "History of the World Part I" with Mel Brooks, and 1984's "Splash" with **Tom Hanks**, showed-up on network sitcoms including "Laverne & Shirley" and "Mad About You," and was a constant guest on talk and variety shows.

But he never really clicked on the screen. He needed a crowd he could interact with, and a whole night to woo them. That meant never becoming as famous as comic contemporaries like Don Rickles, Buddy Hackett or Carson. But he pulled the same six-figurea-week paychecks as they did for live shows.

Born Fred Sheldon Greenfield, Greene took to singing, acting, making jokes and doing mock accents while growing up on the North Side of Chicago.

He served in the Navy in World War II in the Pacific. On returning to Chicago, he went to community college and thought he might become a gym teacher, but started doing comedy nightclub gigs for money. An offer of a two-week gig at the Prevue Lounge in

He did his first show in Las Vegas in 1953. He found he and the Strip were a perfect match, and within a few years he owned the town. In 1956, he opened for a young Elvis Presley at the New Frontier.

New Orleans turned into a six-years stint.


tGreene would remain a Vegas mainstay, his playgrounds places like the Riviera and the Tropicana, for the next 30 years.

From 1972 to 1982 Greene was married to Nalani Kele, a dancer whose show, the Nalani Kele Polynesian Revue, was a long-running nightclub hit. And in 1985, he married **Marie Musso**, daughter of jazz saxophonist Vido Musso.

Greene gained his share of national fame eventually. He could fill Carnegie Hall, and guest-hosted both Carson's "Tonight Show" and "The Merv Griffin Show."

LONDON: John Pilger, an Australia-born journalist and documentary filmmaker known for his coverage of the **Khmer** Rouge in Cambodia, has died, his family said Sunday. He was 84.

A statement from his family, posted on X, formerly Twitter, said Pilger died on Saturday in London.

"His journalism and documentaries were celebrated around the world, but to his family he was simply the most amazing and loved dad, grandad and partner," the statement said.

Pilger, who has been based in Britain since 1962, worked for Britain's left-leaning Daily Mirror newspaper, broadcaster ITV's investigative program "World In Action" and for the Reuters news agency.

He won an International Academy of Television Arts and Sciences award for his 1979 film "Year Zero: The Silent Death Of Cambodia," which revealed the extent of the Khmer Rouge's atrocities. He followed that with a 1990 documentary titled "Cambodia: The Betrayal," which examined international complicity in the Khmer Rouge remaining a threat.

He also won acclaim for a 1974 documentary looking into the campaign for compensation for children after concerns were raised about birth defects when ex-

pectant mothers took the drug Thalidomide. Pilger was known for his opposition to American and British foreign policy, and he was also highly critical of Australia's treatment of its Indigenous population. (AP)

LOS ANGELES: Paula Abdul has accused former "American Idol" producer Nigel **Lythgoe** of sexually assaulting her in the early 2000s when she was a judge on the reality competition show, according to a new lawsuit.

A surge of action, masculinity and controversy

Bollywood celebrates rocking year

NEW DELHI, Jan 1, (AP): Bollywood has made a financial comeback this year worthy of one of its traditional

singing-on-top-of-the-hills moments.

India's Hindi language movie industry made an impressive recovery after a pandemic-driven slowdown, audience fatigue with big studio productions and Bollywood megastars, and streaming platforms taking away a large chunk of viewership.

According to consultancy firm Ormax Media, the cumulative box office in 2023 pulled in \$1.3 billion, making it one of the best-grossing years of all

Indian moviegoers - both the masses and niche film lovers - are back in theaters and the massive commercial success of big-ticket Bollywood films has set at ease fears that Mumbai's glitzy dream factory was losing its shine.

As one of the largest film producers in the world. India rolls out more than 1,500 movies yearly, its diverse storytelling traditions reflected in its prolific cinematic entertainers.

The films that made the cut this year were a mixed bag of visual delights. Some portrayed the classic Bollywood larger-than-life spectacles, others were action-filled spy thrillers with topbilling movie stars. Many included stylized special effects, slickly choreographed romantic songs filmed in stunning locales, and pulsating music that had fans cheering and dancing in cinema halls.

More than anything, the year belonged to India's beloved superstar, Shah Rukh Khan, whose son was jailed amid controversy in a narcotics case in 2021 and subsequently cleared of the charges. Khan's global fandom welcomed him back like never before, with his movies pumping the box office numbers.

The year began with his movie "Pathaan," which made more than \$100 million worldwide, according to The Numbers website. Then came "Jawan," which raked in nearly \$136 million worldwide. And the year is ending with yet another, titled "Dun-

"Very grateful to all the people around the world who have given me soooo much love as an entertainer," Khan recently posted on social media platform X, formerly known as Twit-

"This year Shah Rukh Khan has almost single-handedly revived cinema, very similar to what Tom Cruise did in Hollywood with his 'Top Gun'" last year, said Nikhil Taneja, co-founder of the youth-centered media organization Yuvaa and host of the popular You-Tube show, "Be A Man, Yaar."

Other blockbusters of the year in-

clude the heavily criticized "Animal" featuring actor Ranbir Kapoor, "Gadar with actor Sunny Deol, and Salman Khan's "Tiger 3."

It was also a year when hyper-masculinity overwhelmed Bollywood, often wrapped in misogyny and aggressive nationalism.

Angry young men have always been a staple of Indian movies but the excessive, fantasized screen violence this vear took it to another level. Almost all 2023 Bollywood hits were filled with anger and violence, and led by alpha male protagonists with rippling muscles and blazing guns brandished on screen as they went on a bone-crunching rampage to vanquish their enemies.

Injustices

Even Shah Rukh Khan, known as the king of romance, embraced the gun and gore while playing a spy fighting a militant outfit in "Pathaan" and a vigilante battling institutional injustices in "Jawan.

While Khan's soft machismo remained nurturing and women-friendly even in his action flicks, many critics slammed the superhit movie "Animal" directed by Sandeep Reddy Vanga for glorifying the toxic masculinity and misogyny of its twisted leading man. The film is moving toward a \$100-million run at box offices worldwide, its production company, Bhadrakali Pictures, said.

"Violent men do exist in the real world and a violent man can certainly be the central character in a film - the issue here, as always, is the manner of the portrayal, the script's indulgence towards him, the humour and coolth written into his fictional character, and

the various means used to give him an allure despite his violent ways," film critic and author Anna MM Vetticad wrote in a blog post.
India has the world's largest young

population, who also make up the majority of movie watchers. In a country where movie stars have a cult-like following, and movies reflect as well as shape mass behavior, making dehumanizing violence and casual sexism aspirational can be damaging, observers said.

The country's National Crime Records Bureau reported more than 445,000 cases of crimes against women in 2022, an increase of 4%. "Cruelty by Husband or Relatives" accounted for more than 31% of such crimes, the report said.

"Today what we see is the detachment of violence from emotional purpose," in the movies, wrote social commentator Santosh Desai in the Times of India newspaper. "Given that politically, there is great comfort with maintaining more traditional gender roles, this emphatic assertion of masculinity might take us back in time."

Taneja, the Yuvaa organization cofounder, has been holding roadshows to reach out to young Indians about what he calls "positive masculinity." He said some films "feed into every single bias" of the viewer, whether it was misogyny or a villain of a different religion.

"When they see such films, they can relate to what they see in their homes where their fathers are misogynistic. They are patriarchal to their mothers. They see a certain kind of gender imbalance and they start believing it," he

However, other successful films this year showcased a less angry, more accommodative masculinity, said Tane-

Karan Johar's "Rocky aur Rani kii Prem Kahaani," or "Rocky and Rani's love story," won praise from most critics for its gender politics and for challenging male stereotypes and prejudices. The film went on to make nearly \$45 million at box offices worldwide, according to the Bollywood Hungama

"It was clearly a difficult decision to make, but Ms. Abdul knows that she stands both in the shoes and on the shoulders of many other similarly situated survivors, and she is determined to see that justice is done," Johnson said.

Lythgoe said in a statement that he was 'shocked and saddened" to hear of the allegations made by Abdul, who he said he considered a "dear" and "entirely platonic"

"While Paula's history of erratic behav-

ior is well known, I can't pretend to understand exactly why she would file a lawsuit that she must know is untrue," Lythgoe said in the statement. "But I can promise that I will fight this appalling smear with everything I have."

The lawsuit states Abdul remained silent for years about the alleged assaults out of fear of retaliation by "one of the most well-known producers of television competition

Before "American Idol" and "So You Think You Can Dance," on which Lythgoe served as a judge for 16 seasons, he was a producer on the British show "Pop Idol," which became a global franchise that includes the US iteration starring Abdul. (AP)

1 in 10 American teens use vaping products

US battles influx of illegal e-cigarettes as seizures escalate

WASHINGTON, Jan 1, (AP): Federal officials are seizing more shipments of unauthorized electronic cigarettes at US ports, but thousands of new flavored products continue pouring into the country from China, according to government and industry data reviewed by The Associated Press.

The figures underscore the chaotic state of the nation's \$7 billion vaping market and raise questions about how the US government can stop the flow of fruit-flavored disposable e-cigarettes used by 1 in 10 American teens and adolescents.

More than 11,500 unique vaping products are being sold in US stores, up 27% from 9,000 products in June, according to tightly held industry data from analytics firm Circana.

"FDA whacks one product and then the manufacturers get around it and the kids get around it," said Bonnie Halpern-Felsher, a Stanford University psychologist who develops anti-vaping educational materials. "It's too easy to change your product a little bit and just relaunch it."

Halpern-Felsher says she is "constantly" updating her curriculum to keep pace with new vaping brands and

Nearly all the new products are disposable e-cigarettes, according to the sales data gathered from gas stations, convenience stores and other shops. The products generated \$3.2 billion in the first 11 months of this year.

The FDA has authorized a handful of e-cigarettes for adult smokers and is still reviewing products from several major companies, including Juul. Regulators consider nearly all other e-cigarettes to be illegal.

"Those committing illegal acts don't advertise their crimes, and those trying to import illegal tobacco products into the United States are no different," said FDA's tobacco director, Brian King, in a written response to AP questions. "The FDA and our federal partners are using tools, like import alerts, to stop these illegal tobacco products at the border and to deter countless others."

Destroyed

The rise in e-cigarettes sold continues despite a record number of products detained.

An FDA database shows officials "refused" entry to 148 containers or pallets of "tobacco" goods last month, consisting almost entirely of vaping products from China. Refused imports are typically destroyed.

Through the end of November, US officials had refused 374 such shipments this year, more than double the 118 refused in 2022.

This year's items included \$400,000 worth of Esco Bars, a disposable brand placed on a list of banned imports in May. The agency's posted data is often preliminary because it takes time to finalize refusals.

But recent history shows how easily companies can maneuver around import bans.

In July 2022, the FDA barred dozens

of e-cigarettes from Chinese manufacturer Fume, including flavors Pineapple Ice and Blue Razz.

Fume sales dipped after the ban, but the company launched a slew of new products, posting \$42 million in US sales in the third quarter of 2023, the data shows. Roughly 98% of sales came from products not on the FDA's "red list" of products that can be detained.

Industry shipping tactics are also challenging the usefulness of import restrictions.

In July, FDA and customs officials intercepted \$18 million worth of illegal vapes, including leading brand Elf Bar. But the shipments were mislabeled as shoes, toys and other items - not ecigarettes - requiring officials to individually open and verify the contents of more than two dozen containers.

Circana, formerly IRI, restricts access to its data, which it sells to companies and researchers. A person not authorized to share it gave the AP access on condition of anonymity.

Health

The FDA has no schedule for updating its import lists but said it is "closely monitoring" instances where companies try to avoid detection.

"The FDA has a variety of tools at our disposal to take action against these tactics," FDA's King said.

The agency has limited powers to penalize foreign companies. Instead, regulators have sent hundreds of warning letters to US stores selling their products, but those are not legally binding.

Even as the FDA attempts to work with customs officials, it is struggling to complete a yearslong review of applications submitted by manufacturers hoping to market their products to adults.

The few tobacco-flavored products currently authorized by FDA are deeply unpopular. Their combined sales were just \$174 million, or 2.4% of the vaping marketplace this year, according to Circana.

"Nobody wants them," says Marc Silas, owner of 906 Vapor shop in Michigan. "If people wanted them, they'd be on the shelves and they're not."

Deeply frustrated with the pace of FDA's review, public health groups have successfully sued the agency to speed up the process. The agency aimed to complete all major outstanding applications this year, but it recently said the process would stretch into

The delays have raised questions about the viability of the the current regulatory framework for a cingrettes

regulatory framework for e-cigarettes. "FDA is trying to operate with an old model when the whole environment has changed," said Scott Ballin, a health policy consultant who previously worked for the American Heart Association. "They have this long line of products that have to be reviewed one by one and now they're in a giant bale."

Bid to centralize drug supply

Mexico launches super pharmacy to address medication shortages

MEXICO CITY, Jan 1, (AP): Mexico's president inaugurated a huge "super pharmacy" Friday in a bid to end the woes of patients throughout the country who are often told they need a specific medicine - but the hospital in question doesn't have it.

President Andrés Manuel López Obrador's solution was to outfit a big warehouse on the outskirts of Mexico City to centralize a supply and send it to hospitals throughout the country.

"The pharmacy is going to be big, big, big, and it is going to have all the medications that are used in the heath system," López Obrador said Friday.

The pharmacy is intended to complement local health facilities. If a patient can't get needed medications at a local hospital, the patient, the patient's doctor or the pharmacist would be able to call up the warehouse and get it delivered from the huge 40,000 square meter (430,000 square foot) Mexico City warehouse.

The armed forces, or the government-run pharmaceutical company Birmex, will ship the drugs out by land or air "within 24 to 48 hours," López Obrador pledged.

The question is whether Mexico can overcome its history of being bad at regulating the pharmaceutical industry, bad at buying medicines, bad at storing them, and bad at distributing them. Extreme centralization also hasn't helped Mexico much in the past in many areas.

The most visible face of this problem are the parents of children with cancer, who frequently stage protests because they say that in recent years chemotherapy and other drugs have been impossible to obtain.

Desperate parents blocked traffic at the Mexico City airport last year, holding up a banner reading: "There isn't any chemotherapy, treatment or medicines, have some empathy and sensitivity."

The problems have killed otherwise

healthy people. Because Mexico has had problems in obtaining enough morphine, anesthesiologists in Mexico have had to carry around their own vials of the sedative, drawing multiple doses out of a single vial for routine procedures like spinal blocks during

In the United States, where there is no shortage of morphine, doctors are advised to draw a single dose from a vial and throw the remainder out.

Contamination

But in Mexico, that has led to contamination of the vials, triggering outbreaks of injection-induced meningitis in two Mexican states that have killed dozens of people - including some Americans who sought treatment at clinics in the border city of Matam-

oros, across from Brownsville, Texas.
López Obrador mounted a major effort to obtain COVID-19 vaccines in 2021, using the armed forces to distribute them and volunteers to help apply them, and by the end of that year just about anybody in Mexico who wanted a vaccine got one, for free.

But trying to replicate that model of centralized government purchasing and army distribution on a national scale for thousands of medications is not the same, according to Mauricio Rodríguez, a professor at the School of Medicine at Mexico's National Autonomous University.

"This is crazy," said Rodríguez, noting the government is opening the centralized warehouse without answering how the system will operate, especially for urgently-needed medications. He noted that concentrating all the drugs at one site increases risks, and could sideline some already-existing distribution systems.

Many of the problems pre-date López Obrador, who took office in late 2018. For decades, there have been scandals involving of millions of dollars worth of medicines going out-

of-date at warehouses while hospitals couldn't get them.

The country's medicine regulatory

agency, known by its Spanish acronym as Cofepris, was already so riddled with corruption prior to López Obrador that regulators would hide applications for approval of new medicines for years, and demand bribes to approve them.

And with alarming frequency, regulators in Mexico send out alerts about falsified or knock-off medications being sold for treating everything from cancer to heart disease. Boxes, labels, vials and certifications are copied with amazing accuracy, but the bottles often contain little or none of the medication.

The fake medicine trade is so common, and so lucrative in Mexico because patients or their relatives are often told by doctors to buy medications at private drug stores when they are unavailable at government hospitals.

The civic group "Zero Shortages" said there was an increase of 142% in the number of alerts about falsified medicines between 2021 and 2022.

But part of the problems are of López Obrador's own making. An-

López Obrador's own making. Angry at what he claimed were inflated profits made by drug distributors and importers, the president simply cut the private companies out and decided the government should directly buy all medications.

Because the government did not

Because the government did not have much infrastructure, contacts or experience in such a massive effort, López Obrador signed an agreement with the World Health Organization to help Mexico in purchasing. But even with that help, Mexico was unable to obtain some specialized medication, something López Obrador blamed on sabotage by pharmaceutical firms.

Rafael Gual, the director of the National Pharmaceutical Industry Chamber, said the government's own actions created "bottlenecks" in distribution.

NEW DELHI, Jan 1, (KUNA): India on Saturday reported 743 new COV-ID-19 infections and seven deaths in the last 24 hours as fear of yet another massive corona virus spread loomed.

Total coronavirus cases in India since its outbreak in January 2020 now stood at 4.5 million with an increase of 743 cases in the last 24 hours. With the seven more deaths in the last 24 hours, total death toll due to COVID-19 in the country rose to, 533 358

Variant

Southern Indian states of Kerala and Karnataka reported three and two deaths respectively, while Chhattisgarh and Tamil Nadu reported one death each.

Several other states including Delhi, Gujarat, Madhya Pradesh, Odisha and West Bengal have seen spike in COVID-19 cases and deaths. The development came as India reported several cases of COVID-19 Omicron sub-variant JN.1, which the World Health Organization has labelled as a variant of interest.

Meanwhile, the Algerian Ministry of Health announced, Sunday, the registration of four new cases of the novel coronavirus (COVID-19) in the last 24 hours. The ministry added in a statement that no deaths from COVID-19 were recorded in the past 24 hours, nor were there any cases in intensive care during that period. Instead, two cases were reported to have recovered. The ministry urged the "necessity of respecting the necessary preventive measures to limit the spread of the novel coronavirus (COVID-19) and avoid its spread, which may lead to the creation of new outbreaks of the pandemic.

NEW DELHI: Air pollution in the Indian capital New Delhi rose to severe category amid strong cold wave and dense fog across north India, said Indian authorities on Sunday.

Several areas in the capital recorded Air Quality Index above 400 on a scale of 500 mark, according to the Central Pollution Control Board under the Ministry of Environment, Forest and Climate Change.

Munirka, R K Puram, Nehru Nagar, Dwaraka, Pusa and Anand Vihar were the worst affected regions in the capital as air quality index registered above 400. Any reading above 400 is considered dangerous even for the healthy people.

Delhi is considered one of the most polluted cities in the world according to several studies on global air quality. The deteriorating air quality is attributed to industrial and vehicular pollution, construction related pollution and burning of stubbles in neighboring states.

The authorities had imposed restrictions on construction and demolition, vehicle movement and running of polluting industries.

The air quality deteriorated for several weeks as the Indian capital came under dense fog that affected train and aircraft services. Several north Indian states including Delhi, Uttar Pradesh, Jammu and Kashmir, Himachal Pradesh, Haryana, Punjab and Uttarakhand also came under intense cold wave.

New Zealand was in desperate trouble at 49-5 in the ninth over, trailing under the Duckworth-Lewis system when Neesham and Santner came together. They stayed together and guided New Zealand to 95-5 in the 15th over when the forecast rain arrived torrentially and brought the match to an abrupt end. "I think we always knew there was going

to be a bit of rain around whether it came at the end of halfway through that second innings," Santner said. "The bowlers did the job up front and it was good to get across the line in a pretty hard-fought series.' In extraordinary scenes, spectators dashed for the exits of Bay Oval as the rain

pelted down, driven by strong winds. New Zealand needed 78 runs to be ahead on the Duckworth-Lewis calculation.

Sunday's win leveled the three-match series at 1-1 after Bangladesh won the first match by five wickets and after the second match at Bay Oval was washed out after 11

But New Zealand can no longer turn a blind eye to the failings of its top order in the ongoing absence of Kane Williamson and Devon Conway. Bangladesh may have lost the three-match one-day international series and shared the T20 series, but it achieved its first wins in New Zealand in both formats.

In the third ODI, New Zealand was reduced to 70-6 and in the first T20 it was 50-5 as its top batters failed to master the Bangladesh attack. The latest collapse seemed both inevitable and at times comical.

CRICKET

Santner excelled as New Zealand bowled out Bangladesh for only 110 in 19.2 overs after winning the toss. Bangladesh lost three wickets for 45 runs in the power play then was bogged down in the middle overs, scoring only 32 between the seventh and 16th

Najmul Hossain Shanto's 17 from 15 balls was the top score. Four other batsmen reached double figures, including Towhid Hridoy who made 16 from 18 balls.

Santner was particularly effective in the middle stages and there was enough grass on the pitch at Bay Oval for the ball to grip and turn a little. Santner took 4-16 from his four overs while the seamers Tim Southee, Adam Mile and Ben Sears shared six wick-

"Bowling into the wind can be challenging at times but I was thinking of changing the pace and trying to get a bit of bounce out of the wicket," Santner said. "As a whole the seamers bowled extremely well as well to keep them to 110 on a pretty good pitch."

Santner surprised a little when he chose to field on winning the toss. Bay Oval usually is a bat-first pitch with an average first innings score of 190. But with rain forecast, bowling gave New Zealand some control. In the end it was decisive and New Zealand became the first team to win a T20 at Bay Oval when batting second.

Real Madrid host

Girona start new year with another chance to show they are 'genuine' title contenders

MADRID, Jan 1, (AP): The new year brings Girona another chance to show they are a genuine title contenders in the Spanish

league. Girona's first match of 2024 is a tough challenge against third-place Atletico Madrid at home on Wednesday.

Girona have been the surprise team in Spain so far this season, with statement wins such as the one they earned at defending champions Barcelona last month.

SOCCER

Now they have a shot at taking down an Atletico team that finished the year with a win against Sevilla.

Girona, partly owned by Manchester City's Abu Dhabi ownership, are tied with Real Madrid on 45 points, but trail the Spanish powerhouse on a tiebreaker.

'We finished the first half of the season on the same level as the top clubs." Girona coach Míchel Sánchez said. "Our fans are

proud of what we have achieved so far. The game against Atletico should help give an idea about whether Girona have what it takes to keep competing at the top.

Girona lost 3-0 to Madrid at home in September in their first big challenge of the season, but it recovered and showed their strength in a convincing 4-2 win at Barcelona in December.

Girona went on a 12-match unbeaten streak in all competitions since the loss to Madrid, with draws against fifth-place Athletic Bilbao in November and at Real Betis in their last match of the year, when it was winning until conceding an 88th-minute

The team coached by Míchel has 14 wins in 18 matches, and have the league's best attack with 42 goals, three more than Madrid's high-profile offense.

Atletico Madrid forward Antoine Griezmann enters the game against Girona tied with Luis Aragonés as the club's all-time top scorer with 173 goals. The France international has his second

chance to break the record after going scoreless in the team's win against Sevilla on Dec. 23. Atletico won only two of their five league

matches in December in a run that included a loss at Barcelona and a 3-3 draw against Getafe that ended the club's record-tying 20-game home winning streak in all competitions. Diego Simeone's team trail leaders Ma-

drid and Girona by seven points. Real Madrid could enjoy the return of Vinícius Júnior when it hosts Mallorca on

Wednesday. Vinícius hasn't played since November, when he injured a leg muscle while playing a World Cup qualifier with Brazil's national team.

"I'm fine, doing very well," Vinícius said. "Now it's up to the coach to decide whether I'll play." Also possibly returning from injury for coach Carlo Ancelotti - who last week re-

Osaka makes triumphant return

Poland into the United Cup quarterfinals

SYDNEY, Jan 1, (AP): No. 1-ranked Iga Swiatek led Poland into the quarterfinals of the United Cup mixed teams tennis tournament on Monday, winning both her singles and doubles matches.

Swiatek took the court under pressure, needing to win her singles match against Spain's Sara Sorribes Tormo to keep the tie alive. Alejandro Davidovich Fokina had given Spain a 1-0 lead with a 3-6, 6-3, 6-4 comeback victory over No. 9-ranked Hubert Hurkacz.

But Swiatek beat Sorribes Tormo 6-2, 6-1 to force a deciding mixed doubles match. Swiatek, a four-time Grand Slam singles champion, and Hurkacz then needed little more than half an hour to wrap up the tie with a 6-0, 6-0 win to make Poland the first country through to the quarterfinals.

In Sydney, three-time Grand Slam singles finalist Casper Ruud kept Norway's quarterfinal chances alive with similar victories in the singles and mixed doubles against Croatia.

TENNIS

Donna Vekic gave Croatia an early 1-0 lead with a 7-5, 3-6, 6-3 win over unheralded Malene Helgo. But Ruud then beat Borna Coric 6-4, 6-1 to send the tie to a decisive mixed encounter, which Norway claimed in a match tiebreaker.

The 6-2, 3-6, 10-7 victory for Ruud and Ulrikke Eikeri over Vekic and Ivan Dodig leaves Norway (1-1) awaiting the outcome of the last remaining Group F match between Croatia (0-1) and the Netherlands (1-0) on Tuesday.

In later matches Monday, the United States played Britain in Perth and France played Germany in Sydney.

Two quarterfinals from the Perth group games will be played Wednesday. The Sydney quarterfinals will be played Thursday and Friday, with the semifinals and final set for Saturday and Sunday, also at Sydney's Ken Rosewall Arena.

Speculation set to intensify

Countdown begins on Mbappé's future; Real, Liverpool possible destinations

PARIS, Jan 1, (AP): As the New Year begins, so does the countdown on Kylian Mbappé's future.

It promises to be a nervous start to 2024 for Paris Saint-Germain and its fans with speculation set to intensify about their prolific striker, one of only two players in soccer history to score a hat trick in a World Cup final.

Mbappé began this season in a transfer standoff with his club after not taking up the option of a 12-month extension into 2025. It means that, starting Jan. 1, he can openly talk to other clubs or even sign a pre-contract agreement with long-time suitor Real Madrid or Premier League leader Liverpool.

Mbappé can do so because his contract runs out in June, when he can leave the defending French champion for free, having joined from Monaco - initially on loan in 2017 - for 180 million euros (now \$199 million).

The France star is PSG's all-time leading scorer with 233 goals despite only recently turning 25, and has al-

But it has been frustrating at times for Mbappé at PSG, which failed to reach the quarterfinals of the Champions League in the last two seasons and has scraped through to the last 16 in second place this season.

Despite having scored 21 goals in 22 games in all competitions so far this season, Mbappé failed to make his mark when PSG lost 4-1 at Newcastle and 2-1 at AC Milan.

His frustration has been seen in some of PSG's league games over the past three seasons, when bad defending and a lack of teamwork has led to soft goals being conceded.

Mbappé has said he wants to win the Ballon d'Or - soccer's most prestigious individual prize - and the Champions League. But whether he can win either with PSG remains to be seen and, at age 25, the time could be right for him to leave PSG as he enters his

Here's a look at where Mbappé

Real Madrid

Will it be third time lucky for the Spanish powerhouse with a record 14 European Cup titles?

PSG rejected an offer of 180 million euros for Mbappé in 2021 and Madrid missed out a year later when Mbappé amid frenzied speculation that Madrid would finally get him to join - signed a new deal with PSG in May 2022.

SOCCER

Mbappé held aloft the PSG jersey that day with 2025 on the back. But he was reportedly annoyed because the actual deal only took him to 2024 and, while good PR for the club, it was also seen as somewhat presumptuous to expect he would sign the extension given his world renown.

Mbappé has spoken about his affection for Madrid but, if he does not join this time, then the move may never happen. Coach Carlo Ancelotti has re-shaped the attack since Karim Benzema left and it is functioning well.

Jude Bellingham has made a stunning start to his career there since joining from Borussia Dortmund in a big-money deal, and the 20-year-old attacking midfielder has netted 17 goals in 21 games. Wearing his idol Zinedine Zidane's No. 5 jersey, Bellingham pulls the strings brilliantly behind forwards Vinícius Júnior - who has signed a new long-term deal - and Rodrygo.

Neither are as prolific as Mbappé but the Brazilians are younger - Vinícius is 23 and Rodrygo is 22 - and it raises the question whether Madrid really needs Mbappé now the void left by Benzema, and Cristiano Ronaldo before him, has clearly been filled.

Liverpool Mbappé's English is near-fluent and he's at ease conducting interviews after Champions League games with British broadcasters.

It would make his transition to the Premier League even easier, for his speed, strength on the ball, dribbling and lethal finishing are all attributes that would serve him well.

The six-time European champions are trying to hold onto prolific forward Mohamed Salah amid growing interest in the Egypt star from the even richer Saudi Arabian league.

Salah recently reached the 200-goal mark for Liverpool and enjoys hero-like status at Liverpool's famed Anfield stadium, but he is 31 and his prime years could almost be

Mbappé is entering his prime and appears the ideal replacement. Chelsea

With no transfer fee to pay, any club signing Mbappé for free would have to play massive wages.

Chelsea can do that, and the west London club is languishing in midtable, desperately in need of a goalscorer of Mbappé's caliber.

Whether Mbappé feels up to the challenge of rebuilding is doubtful, considering he could walk into any leading club.

Saudi Arabia

Al-Hilal failed with a record \$332 million bid for Mbappé last July and, given his ambitions to win the Ballon d'Or numerous times, even the lure of massive wages seems unlikely to tempt him.

Furthermore, Saudi Arabian soccer intends to be around for the long-term.

If so, it means there's no pressure for Mbappé to go there now when he could easily do so in his 30s.

Staying at PSG

Mbappe previously said he wanted to see out his last season at PSG and then leave.

Should he stay, the club would need to strengthen its midfield and defense. Should he go, there will still be a Mbappé playing at PSG - younger brother Ethan, who just turned 17.

This latest setback came despite Bukayo Saka putting Arsenal ahead after just five minutes as he turned in the rebound from a shot by Gabriel Martinelli, who had made a marauding run from inside his own area.

There was little in the way of attacking threat from the visitors after that. though, and bad defending helped Raul Jimenez equalize in the first half and Bobby De Cordova-Reid poke in the winner after a corner in the 59th.

"Not good enough from us again today," Arsenal midfielder Declan Rice said. "The game against West Ham we had 30 shots, so many touches in the box but couldn't put it away. Today when (we) go one up we have to have more control. We need to demand more from each other. We had to push on again and go for more. In this league there is no room to mess up. It is a tough one to take.'

Fulham had lost their last three league games by a combined score of 8-0 but was boosted by the return of Jimenez from a suspension. The striker has now scored four goals in his last four league games equaling his tally from his previous 50.

Don't count Tottenham out of the title race just yet. Ange Postecoglou's team is three points behind Liverpool after bouncing back from a 4-2 defeat at Brighton on Thursday with a convincing win against Bournemouth.

Tottenham were boosted by the early return of Rodrigo Bentancur from an injury at a time when Postecoglou is without a handful of starters. But the win was marred by Senegal international Pape Sarr leaving the field in tears with an injury in the first half - just two weeks before the start of the African Cup of Nations - after he had scored the opening goal in the ninth minute.

Tottenham had to wait until the 71st minute for another goal, but Son Heungmin and Richarlison scored late to make the game safe before Alex Scott pulled one back for Bournemouth.

After a great start to the season under Postecoglou, Tottenham fell out of the top four after a five-game winless run but could soon be back in the Champions League places.

"We're still in there and fighting," Postecoglou said. "We're three points off the top so if that is the difference between having a great season and where we are I'll take it.'

Meanwhile, Luton captain Tom Lockyer will meet with heart specialists before deciding his future after suffering cardiac arrest in a Premier League game at Bournemouth on Dec. 16.

The 29-year-old defender collapsed in the 59th minute at Vitality Stadium, resulting in the game being abandoned. Lockyer was discharged from the hospital five days later following a successful procedure to fit an implantable cardioverter defibrillator.

The Welshman made his first comments since the incident via his Instagram account on Sunday, thanking the doctors and paramedics who treated him and indicating that he hasn't given up on resuming his playing career.

Lockyer also collapsed during May's Championship playoff final victory over Coventry at Wembley, leading him to undergo surgery to correct an atrial fibrillation.

Manchester United midfielder Christian Eriksen successfully resumed playing after being fitted with an ICD following his collapse at the European Championship in 2021 while playing for Denmark.
