

# Kuwait gov't returns amended **Penal Trials Law to parliament**



'Income' quizzed

KUWAIT CITY, Jan 2: The government has returned the bill on amending Procedures and Penal Trials Law Number 17/1960 to the National Assembly according to Decree Number 228/2023.

The bill that was ratified on Oct 12, 2023 stipulates reducing the required period for the rehabilitation of convicts in order to restore their social, career and political rights to be the same as the prison term or 10 years maximum.

According to the bill, the convict is considered rehabilitated upon completion of the similar period that he spent in jail, if he is granted amnesty or after five years if the punishment is nullified because of seniority provided he does not commit another crime. In case the punishment is a fine, the convict is con-

In these two matters, the Prime Minister and his team must have a high level of awareness about the extent of the responsibility they assume.

They should not submit to the game of circunventing the Constitution that parliamentarians play. They should not misunderstand democracy as having the right to do what they want and say what they want.

Rather, it is an ongoing reform integration process between the two powers - the legislative and the executive.

Unfortunately, over the past three decades, Kuwait lived through a struggle over interests between members of the two authorities, while the interest of the nation was absent.

This is either as a result of the lack of success in choosing a Prime Minister, or because of the pressure exerted by parliamentarians and influential people to appoint incompetent ministers, except the "blessed" ones.

Therefore, if there is no person from the ruling family who is up to the task of assuming the position of Prime Minister, why not seek the help of a person among the people for a temporary period?

It works to dismantle the causes of the ongoing conflict between the two authorities, and to confront the political stubbornness between them that the country is experiencing. This will be a new experience that can be judged after a while.

In this regard, the late Sheikh Sabah Al-Salem said, "My people and I are a group. Our religion is one and the goal is to serve the people."

Hence, everyone is at the service of Kuwait, especially after citizens noticed the weakness of successive councils of ministers.

Appointment-related deals that put the wrong person in a position of sensitive responsibility, the National Assembly's approval of strict laws that do not suit Kuwaiti culture, and others have caused many negative impacts, both economically and socially

Almighty Allah said in the decisive revelation, "Indeed, the best among whom you hire is the strong and trustworthy one.'

This is what Kuwait needs today. These are not the feelings of one citizen, but rather a general vision that we convey in these lines.

## Economists sound alarm

## **Populist laws could push Kuwait** towards 'fiscal impasse': experts

KUWAIT CITY, Jan 2: Experts and economists are sounding the alarm about the repercussions of succumbing to economically irrational populist demands and parliamentary pressures, warning of the potential catastrophic financial consequences that could push Kuwait into a fiscal impasse, jeopardizing its economic stability and sovereign credit rating, reports Al-Qabas daily.

The ongoing chaos of parliamentary demands, characterized by a lack of economic rationale and a failure to assess their financial impact, has raised concerns. It appears as if there is a plan to deplete the "generations" reserve, exacerbated by the government's struggles to pass laws promoting financial sustainability and its inability to make tangible progress in financial and economic reforms.

Experts emphasize the state's limited capacity to meet ill-considered parliamentary demands with high costs. They stress that all financial and economic indicators point towards a looming financial crisis for Kuwait.

Without real, executable reform programs backed by a strong will to implement them, the situation is expected to worsen. Adding to the gravity of the financial predicament is the fact that approximately 80% of the country's budget is allocated to salaries and subsidies, leaving meager spending on capital projects that often face numerous obstacles.

Experts warned that the deficit for the upcoming fiscal year 2024-2025 may soar to 6.1 billion di-

## Palestinian spokesman decries genocide'; S. Africa files case

RAMALLAH, Jan 2, (Agencies): The Palestinians are the victims of a "genocide" committed against them by Israeli forces, the spokesman for the Palestinian President Nabil Abu Rudeineh said on Tuesday, citing death of some 22,000 Palestinians amid the violence.

The "barbaric" acts committed by Israeli forces aim to "forcibly displace" thousands of Palestinians in the Gaza Strip and West Bank, the spokesman said in a statement, emphasizing that the situation is at the precipice of "explosion."

He went on to underline the commitment of the Palestinians towards a "two-state solution" to the Middle East conflict, based on 1967 border lines with East Jerusalem as the capital of an independent Palestinian state.

nars, assuming optimistic oil prices around \$80 per barrel. If oil prices drop to \$70 per barrel, the deficit could reach 9 billion dinars. At this point, salaries, wages, and subsidies would constitute about 113% of general budget revenues, exceeding current expenses.

This calculation does not even account for the cost of absorbing 20,000 to 25,000 citizens entering the labor market.

Israel will defend itself before the United Nation's top court against charges that it has engaged in genocide of Palestinians in Gaza, officials said Tuesday, a rare engagement with the world body, which Israel often denounces as biased against it.

South Africa launched the case Friday at the International Court of Justice at The Hague, Netherlands, saying the magnitude of death, destruction and humanitarian crisis in Gaza from the Israeli military campaign against Hamas meets the threshold of genocide under international law. South Africa asked the court to order Israel to halt its attacks in Gaza.

Israel dismisses international cases against it as unfair and biased and rarely cooperates.

It is emphasized that any cash spending in the form of increases or allocations, though appearing as grants on the surface, will not contribute any added value to the economy.

Instead, such funds are expected to evaporate in the market, with tangible repercussions, as seen in the example of the housing loan increase reflecting in rising land prices in Kuwait.

sidered rehabilitated upon payment of the fine.

On the other hand, the government iustified its decision to reject the bill: stressing the proposed period for a convict to be rehabilitated is not in line with the relevant legislation, which stipulates the latter can go back to society if he fulfills the pledge of good conduct and proves he is rehabilitated by completing the specified period as a righteous citizen. The government highlighted the right of the society to make sure that the convict is rehabilitated before allowing him to return to society, which stressing the need to complete the rehabilitation period similar to the penalty period. It argued that the periods specified in the bill are not enough to protect the right of the society and to prove that the convict has recovered from the influence of the crime he committed. It pointed out that in some cases, the imprisonment period is too short and does not match the gravity of the crime committed due to various factors like the opinion of the judge. In such a case, the rehabilitation period is not enough to protect the society and guarantee that the social interests are secured, the government elaborated.

The government said the bill does not consider equality among the convicts as it stipulates similar period of rehabilitation for convicts who committed different crimes, some of which are more serious than others yet the perpetrators must complete the same rehabilitation period. It argued that specifying the rehabilitation period as half of the penalty term or by obtaining amnesty with a maximum rehabilitation period of five years is unjust as it does not make any difference between someone convicted of a crime and one who is convicted of misdemeanor.

## Local rise in prices linked to global trends

## 'Limited industrial base, import of gadgets gives rise to inflation'

KUWAIT CITY, Jan 2: A government report stated that the whole world is expected to continue witnessing commodity price hikes, especially the prices of food products; which will put more pressure on countries that depend on food imports, those whose climate or conflicts could disrupt local food production, and those suffering from macroeconomic fragility, reports Al-Qabas daily.

The report stressed the need to take urgent decisions to reduce the impact of glob-al food price increases on the local market, especially since the cost on the national economy will be high. It indicated that food prices will continue to rise in the next five years -- higher than the prices prior to the Corona crisis. The same applies to the prices of agricultural products and grains.

Data from the Central Statistics Bureau showed that the consumer price index (inflation) in Kuwait rose by 3.79 percent in November, explaining that the annual rise in inflation rate stems from the increase in the prices of all the main groups affecting the movement of index numbers, particularly foodstuffs, education, clothing and apparel.

#### Merchandise imports

Government data indicate that merchandise imports to Kuwait are concentrated in appliances, machinery, equipment and industrial inputs, and that the country imports approximately 80 percent of its food needs. They indicate that the steady growth in merchandise imports over the last 10 years is reflected in the nature of the Kuwaiti economy, represented by the high per capita income and the limited industrial base.

Datas show that cooperative societies are the most important outlet for selling food commodities and account for about 80 to 85 percent of the total food commodities in the local market. Therefore, any measure to neutralize price increases in the local market must be centered on cooperative societies.

In addition, the delivery by ship method is the most important channel for transporting merchandise imports to Kuwait, exceeding about 85 percent of total imports; while delivery by land does not exceed 10 percent. This reflects the extent of the exposure of Kuwaiti imports to delivery by ship method, as well as the associated disruption in the ports and shortage of containers.

### **Global inflation**

A number of financial institutions said that global inflation may return to normal for the first time next year -- after about four years. Goldman Sachs indicated that core inflation, which excludes food and energy in economies that witnessed an inflation boom in the post-Corona stage, specifically the United States, Europe and many emerg-ing markets, reached 2.2 percent during the three months ending last November. It expects that average inflation among these countries would be at or close to the inflation targets of most major central banks by the end of 2024.

Oxford Economics expects inflation to reach 1.3 percent in the last quarter of next year in the Euro zone and 2.7 percent in the United Kingdom, while it will decline to 2.2 percent in the United States

10 recommendations to curb inflation

The report indicated that to reduce the impact of global price increases on local prices, it is necessary to adopt the following recommendations:

1. Most countries in the world have witnessed record rises in commodity prices, especially food commodity prices, which threaten to spread more severely to the local economy. Therefore, this requires us to adopt a clear and strict mechanism to implement the relevant treatments.

2. The necessity of adopting the proposed treatment mechanism and linking it to a specific time period for implementation, as the concerned authorities must implement their own treatment mechanism and not fail to implement it as required.

These treatments in pricing policy must be accompanied by consensus in the direction of fiscal and monetary policies, ensuring that price inflation in the country is addressed, and in a way that does not conflict with the growth of economic activities.

4. Reconsidering the Cooperatives Law to allow more oversight of the practices of boards of directors in cooperative societies.

5. Price control to avoid large differences in commodity prices.

6. Activating the role of the competition agency in cooperative societies to ensure that their monopolistic practices are consistent when displaying goods in them, to ensure that there are sufficient substitutes for the commodity, which encourages competition and the consumer's choice of the commodity with the appropriate price for his needs.

7. Studying the increase in the spaces allowed for displaying goods in cooperative societies to facilitate the process of supplying goods.

8. Creating job opportunities for nationals and reducing current expenses (salaries) in the State budget.

9. Intensifying media and awareness campaigns to rationalize food consumption.

10. Taking the necessary measures to ensure the application of governance, digitization of services, reducing the costs of cooperative societies and the costs borne by suppliers, preventing the collection of any amounts by cooperative societies from suppliers, and ensuring that profits are directed towards providing goods in cooperative prices

KUWAIT CITY, Jan 2: With the end of the New Year holidays, employees of government agencies and state institutions resumed work as usual in their sectors. The attendance rate ranged between 80 and 90 percent, with the exception of the Ministry of Justice, which witnessed an attendance



### rate of 67 percent, followed by the Ministry of Electricity and Water with 70 percent.

While work was organized in all sectors of ministries and government institutions, it was noticeable that the number of visitors to most government agencies was lesser than usual, as most of them expected that the majority of employees would not show up.

The Ministry of Education recorded full attendance, as schools appeared fully prepared to receive students in the tenth and eleventh grades to resume their exams. The schools in the elementary and intermediate levels started distributing certificates for students.

Meanwhile, the Ministry of Health recorded an attendance rate of 95 percent. Also, the Undersecretary of the Ministry of Health Dr. Abdul

Rahman Al-Mutairi accepted the resignation of the Director of Mubarak Al-Kabeer Hospital Dr. Najah Al-Zenki.

The following are the details of the work activities in the state ministries on the first day after the New Year holidays:

### **Ministry of Education**

Employees at the Ministry of Education resumed their work yesterday morning in full swing such that the attendance rate was 90 percent, and only those with medical excuses or on vacations were absent. A large number of visitors rushed to the employees' offices to complete their transactions.

Meanwhile, elementary and intermediate schools yesterday morning started announcing the results of the first semester exams. The students in the tenth and eleventh grades will be completing their remaining exams today and tomorrow. The twelfth grade students will sit for their exams from Sunday until January 18.

#### **Ministry of Public Works**

Employees at Ministry of Public Works resumed their work at the headquarters of the ministry located in the south of Sorra with average attendance of roughly 75 percent at the different technical and administrative departments including drainage plants, emergency sections at the entire governorates as well as the construction departments, major projects and road maintenance. According to sources, the employees work according to shift systems as stated by Civil Services Commission CSC which stipulates that technicians and engineers must follow up the work during vacations in addition to the hotline of the ministry which is available 24/7.

Employees of the Ministry of Public Works flocked to their shifts yesterday morning in the ministry's offices in South Sur-ra, such that the attendance rate was about 75 percent in most administrative and technical sectors, especially in wastewater treatment and purification plants and emergency centers affiliated with the ministry in all governorates, as well as the sectors related to construction, major projects and road maintenance.

### **Ministry of Electricity, Water**

Employees of the Ministry of Electricity, Water and Energy resumed work in all sectors of the ministry such that the attendance rate was about 70 percent in most of the administrative and technical sectors and external sites affiliated with the ministry, especially electricity and water production plants, consumer affairs offices, and other departments and units affiliated with the ministry in the various governorates.

According to informed sources in the ministry, the corridors of the ministry witnessed the influx of visitors, both from outside the ministry who came to complete their transactions related to customer affairs and connecting electricity, and from within the ministry, who are employees wishing to obtain "To Whom It May Concern" certificates and other transactions.

## 'Don't exploit salary increments'

## 'Shops to be shut if prices raised'

KUWAIT CITY, Jan 2: Director of the Technical Department for Supervising Goods and Determining their Prices in the Ministry of Commerce and Industry Faisal Al-Ansari confirmed that the Price Monitoring Team monitored 160 central markets and commercial stores in Shuwaikh Industrial Area, making the owners promise not to take advantage of citizens' salary increment by increasing prices, reports Al-Anba daily.

In a statement to the daily, Al-Ansari disclosed that the team focused on stores selling food, tea, coffee, dates, cardamom and other items that are in demand during the New Year. They stressed to the store owners that if the ministry's decisions are violated and prices are raised, measures will be taken against the violators who will be referred to the Commercial Prosecution.

He added: "We informed the store owners about the need to coordinate with the

ministry in the event of any price increase by the exporting body, so that they do not commit a violation which could lead to the closure of the commercial establishments. I submitted an action plan to the ministry's officials regarding surveying the markets and monitoring prices.'

He stressed that the ministry is intensifying inspection tours and price monitoring operations; hence, it will not hesitate to impose the maximum penalty on anyone who exploits the salary increments granted to citizens by increasing the prices.

He advised the consumers that if they fall victims to commercial fraud or violations, they should visit the nearest center affiliated with the Commercial Control and Consumer Protection Sector or call Hotline No. 135 or send the complaint on through WhatsApp No.: 55135135 or the ministry's electronic platform.

### Kuwait network to get power generated

## PPPA, MEW seek local, foreign bidding in two energy projects

KUWAIT CITY, Jan 2: The Public-Private Partnership Authority (PPPA), in collaboration with the Ministry of Electricity, Water, and Renewable Energy, has extended invitations to both international and local companies and alliances to participate in a bidding process. This initiative pertains to the design, financing, construction, operation, maintenance, and transformation of the Al-Dabdaba Electrical Power Generation Project and Al-Shaqaya Renewable Energy Project - Phase Three, reports Al-Qabas daily.

The project entails the establishment of a renewable energy production station with a net capacity of 1,100 megawatts, with the intention of exporting the generated energy to Kuwait's electricity network. This will be facilitated through a power purchase agreement with the Ministry of Electricity, Water, and Renewable Energy for a duration of 30 years

The PPP revealed that a consortium of companies, spearheaded by Ernst & Young as the main financial advisor, DLA Piper as the legal advisor, and DNV Company serving as the technical and environmental advisor, has been appointed to provide support to the Public-Private Partnership Projects Authority and the Ministry of Electricity, Water, and Renewable Energy in preparing the project documents and procedures for its launch

By offering this project, the Public-Private Partnership Authority and the Ministry of Electricity, Water and Renewable Energy aim to achieve the following goals:

Attracting private sector expertise in the field of renewable energy.

Reducing the financial and operational burden on the Ministry of Electricity, Water and Renewable Energy.

Reducing local dependence on fuel. Reducing the total costs incurred by

## Mubarakiya raids

## 120 kg food destroyed

KUWAIT CITY, Jan 2: Inspection supervisor in the Capital Governorate Department at the Public Authority for Food and Nutrition (PAFN) Abdullah Al-Siddiqi said the inspection teams assigned in the governorate visited the Mubarakiya Market recently during which they uncovered several violations in the meat, fish, and vegetable sections, reports Al-Anba daily.

The tour resulted in the issuance of 14 pledge reports and a report on the destruction of 124 kilos of food items not fit for human consumption.

In a special statement to the daily Al-Siddiqi confirmed: "We conducted an inspection tour at the Mubarakiya Market, during which we uncovered a violation at the fish section and this led to the disposal of a large quantity of food products found to be unfit for human consumption."

He said the inspection teams also checked the restaurants in the market to ensure strict compliance with the food safety and storage regulations, indicating the teams recorded several comments on the food storage locations of some restaurants. He explained that the main goal of the inspection tour is to guarantee that the food products sold to consumers are safe and healthy.

He added the inspection tour covered Shuwaikh Industrial Area as well, where three commercial establishments were shut down for operating without a license.

### **Ministry of Justice**

The corridors of the Ministry of Justice and the courts witnessed an attendance rate of about 67 percent by employees. Most of the employees were keen to come to work early in the morning and register their attendance using their fingerprint, with the exception of official absences.

However, it was noticeable that there was a weak turnout of visitors.

A tour of the Justice Palace revealed regular work flow since the early morning hours.

One of the administrators in the Ministry of Justice said the rate of attendance after the New Year's holiday in the ministry's sectors, both within the ministries complex and in its affiliated departments in the courts, was normal. The attendance rate was 67 percent and the rate of absenteeism was 33 percent. The majority of absences are legal, either through periodic leaves or medical leaves

### Ministry of Interior

From the early morning hours of January 2, civilian employees of the Ministry of Interior began work at their workplaces such that the rate of attendance was normal, except for those absent on sick or regular leave in accordance with the regulations.

Despite the digital transformation in the ministry's service sectors, employees did not miss their work in the sectors of residency affairs, citizen service centers, nationality, passports, and the General Traffic Department. All departments worked at full capacity, but the low number of visitors was evident.

#### **Ministry of Social Affairs**

The employees of the Ministry of Social Affairs resumed work yesterday morning such that the attendance rate reached 88 percent. The absences among employees were due to normal leaves and sick leave. However, the less number of visitors was noticeable.

#### **Ministry of Awqaf**

The employees of the Ministry of Awqaf and Islamic Affairs resumed work as usual, such that the ministry recorded an attendance rate of about 90 percent. However, the rate of visitors to the ministry's sectors was weak to moderate.

#### **Kuwait Municipality**

The Director General of Kuwait Municipality Saud Al-Dabbous affirmed the commitment of the employees in all departments of Kuwait Municipality to the official working hours on the first working day of 2024.

He indicated that all employees began their work smoothly and received visitors. adding that the transactions and services available on the municipality's website were completed smoothly.

In a press statement, Al-Dabbous affirmed that the employees who were absent had committed to submitting their leave requests an appropriate period before the holiday and obtained approvals for their leaves in accordance with the controls and laws in force in the Department of Personnel Affairs in the municipality and approved by the Civil Service Commission.

accountable for the missteps of others after more than a century.

Since the Oslo Accords and subsequent events, it has become evident that a significant portion of the Palestinian population has grown disillusioned with the "armed struggle," often characterized by guerrilla operations. Instead, they opted for the path of peace, aspiring to secure their right to a free and independent state. However, the refusal from the Israeli side, coupled with corresponding Palestinian rejections, has fostered a conviction among Israelis over time.

This conviction holds that the recognition of a Palestinian state signals the potential demise of their own state. Consequently, some believe that the only viable solution lies in settling those seeking a homeland on the territory of another Arab state or states.

The Israeli mindset, particularly after the events of October 7, has solidified around the notion that "Palestinian peace" poses a threat to their existence, prompting a belief that the Palestinian presence must be terminated through various means.

In an interview with Natalie Bennett, a former Prime Minister of Israel and a formidable candidate to succeed Netanyahu, expressed to the BBC that the act of ceding land to the Palestinians, as Israel has done on multiple occasions for the establishment of their state, has proven perilous and should not be repeated.

Additionally, former Israeli Foreign Minister Shlomo Ben Ami emphasized in a lecture that events have demonstrated how Israel's withdrawal from any previwithin Israel to prevent any recurrence of such instances.

I never agreed with Hamas, nor was I impressed for a moment with the words of its leaders, nor with their positions and policies, and I mentioned this in more than one article and interview. I firmly believe that handing over the fate of Palestine to the movement, as an ideological organization imbued with Brotherhood thought, and with ties to radical regimes in the region, will not end the conflict, nor will it achieve the desired peace, because they lack the minimum understanding of the logic of matters, and there will only be more innocent victims.

I also believe that the Palestinian issue was and must remain a Palestinian issue, and without the precious Palestinian blood it is not possible to achieve any victory, or reach any peace, and relying, as I have written several times, on the help of Arab countries in liberating their homeland is closer to an illusion, as most of them are too incapable of that. Palestine frees herself from the restrictions that bind her. Seeking help from Arab countries automatically means transferring all their differences to the issue and its people.

I also believe that the Palestinian blood that will be spilled will not build a free, united and independent state in the presence of a Palestinian-Palestinian conflict or disagreement.

The international sympathy and support that has been poured so far, and the overwhelming support that Palestinian rights have received, have shaken even the foundations of the US Congress, and the overwhelming and unprecedented support for Palestinian rights will be lost, especially among Western educated elites, especially among the Jews of Israel and abroad, in the first clash between Hamas and the PLO.

And all the factors of this clash are present on the ground and in the hearts. Therefore, the path to the future state begins with unifying the Palestinian decision. The world is unable or unwilling to impose it on Israel, without American approval and support and a unified Palestinian will.

## 'Benefits of breastfeeding aplenty'

KUWAIT CITY, Jan 2: Dr. Marzouq Al-Azmi, Pediatrics and Pediatric Emergency Consultant at Kuwait Hospital, has recommended that mothers breastfeed their babies for a minimum of the first 6 months, emphasizing its numerous benefits, reports Al-Anba daily.

International studies have validated that breastfeeding enhances children's immunity while reducing the likelihood of allergies and eczema symptoms. In a statement to the daiily, he highlighted that if breastfeeding extends beyond 6 months, it is advisable to introduce iron-rich foods or provide iron supplements to prevent iron deficiency in the child.

Underlining the significance of adhering to the vaccination schedule, Dr. Al-Azmi emphasized that vaccinations are pivotal in preventing diseases, especially during the winter season. of Interior successfully dismantled a network comprising individuals of Asian nationalities who were actively involved in the sale of narcotics within schools, specifically targeting student groups and other young individuals.

Details provided by the sources revealed that the Ministry of Interior received confidential information indicating the involvement of individuals working as cleaners in an (Asian) school. These individuals were allegedly engaged in the sale of suspected narcotic substances, with a focus on students both within and outside the school premises.

Taking swift action upon receiving this information, the relevant authorities at the Ministry of Interior monitored the criminal network. Following careful observation and verification of the provided data, security personnel executed a controlled ambush, resulting in the initial arrest of a network member found in possession of narcotic substances prepared for distribution and sale.

Subsequently, four other individuals from three different Asian nationalities were also apprehended, and appropriate legal measures were taken against them.

In response to the incident, the Ministry of Interior notified the Ministry of Education, urging them to emphasize the importance of not employing individuals with residency violations or those wanted by security forces in educational institutions. They further urged educational facilities to conduct inspections to ensure the safety of students.

# Top officer gets 14 yrs jail for drug trafficking

KUWAIT CITY, Jan 2: The Criminal Court has issued a verdict sentencing an officer from the Ministry of Interior to 14 years in prison for "trafficking in psychotropic substances." The officer was acquitted of the charge of bringing hashish

The officer was acquitted of the charge of bringing hashish by sea. Additionally, two Kuwaitis were sentenced to 15 years and 4 years in prison respectively, while an Iranian received a life sentence, reports Al-Rai daily.

According to the daily, the lieutenant colonel was arrested in collaboration with the Coast Guard who had exploited his position and workplace to facilitate the smuggling of large quantities of narcotic substances into the country.

The arrested suspects, including the lieutenant colonel who worked at the Shuwaikh Port Office, were involved in an attempt to smuggle approximately 800 kilograms of hashish into the country.

Acting on received information about the smuggling attempt, a dedicated squad was deployed to the site, resulting in the arrest of the officer.

# **MoSA studying various options** in favor of co-ops, shareholders

Ministry eyes cutting percentage of profits to governorates

**KUWAIT CITY, Jan 2: According to informed sources** at the Ministry of Social Affairs, the ministry is studying a number of options and decisions that are aimed

at enhancing the interest of the shareholders of cooperative societies, and is examining all possible proposals for developing cooperative work.

Al-Seyassah/Arab Times Staff KUWAIT CITY, Jan 2: The Fish Market recorded remarkable price hikes at the beginning of the year; especially the local fish, reports Al-Seyassah daily.

The daily's staff, who toured the Fish Market on the first day of the year, noticed the scarcity of fish and the merchants attributed this to the lack of rain; which made the species that flood seasonally decrease in noticeable proportions, in addition to the suspension of shrimp fishing until August.

Fish trader Nasser Bawi told the daily that rainfall is beneficial for both the sea and land; hence, the lack of rain led to the scarcity of fish in general, which in turn leads to an increase in prices. He disclosed that the fish available locally include Zubaidi, which now costs KD16 per kilogram for the large size and KD12 for the small ones. He added the price of a kilogram of 'bulul' reached KD8, KD3 for 'shaman' and KD4.5 for squid.

Earlier, the Kuwaiti Fishermen Un-

National Diwan for Human Rights' complaints committee completes 146 tasks in 2023, claims Dr Assiri

KUWAIT CITY, Jan 2, (KUNA): The National Diwan for Human Rights' standing committee for complaints issued its statistical review for 2023 as stipulated in the provisions of

Law 67/2015 that established the Diwan.

Chairman of the committee Dr. Abdulredha Assiri said that the committee had completed 146 tasks in 2023, of them were 39 complaints.

Dr Assiri The committee, said added in a statement, also presented two researches about human rights issues, two seminar, and 19 field visits to correc-

tional and social care centers The committee also visited 12 police stations and released 13 reports of its work and collaborated with three organizations of the civil society, as well as participating in six events and media interviews, nine meetings and conferences abroad, and 26 meetings inside Kuwait.

Dr. Assiri added that through the committees work they were able to initiate different practical activities for prisoners in cooperation with a number of the civil society organizations and charities including the Human Construction Society for Social Development.

The committee also raised public awareness about human rights issues by collaborating with the Center for Gulf and Arabian Peninsula Studies, and handled the complaints positively, said Assiri.

The committee has different educational and discussion programs to be announced in due time, directed to social care homes' residents including the elderly, children with unknown parents, juveniles, as well as law enforcement officials through collaborating with official institutions in the country, Dr. Assiri added.

PAHW issues report regarding South Sabah Al-Ahmad infrastructure tender

KUWAIT CITY, Jan 2: The Public Authority for Housing Welfare (PAHW) has released a report regarding the infrastructure tender in the South Sabah Al-Ahmed residential area.

The project comprises seven neighborhoods with a total of 13,812 plots, scheduled to be completed within 900 days.

PAHW highlighted that the infrastructure work includes the application of three layers of asphalt on the highways and streets within the neighborhoods,

implementation of rainwater and sewage networks, irrigation networks, and drinking water networks, and the implementation of civil services related to traffic, telephone and electricity, along with the installation of light poles.

Meanwhile, housing activist Salman Al-Mutairi said the latest statistics on the South Saad Al-Abdullah residential project until January 1 reveals that the project consists of 23,551 plots, divided into 11,897 plots that have already been distributed and 11,654 plots that are yet to be distributed.

He stressed that the requests for the distributed plots date back to the year 2008.

## KOTC formally submits plans for design, construction of gas tankers

KUWAIT CITY, Jan 2: An authoritative source in the oil sector said the Kuwait Oil Tanker Company has formally presented plans for the design and construction of three gas tankers and a colossal crude oil tanker to prominent international shipyards and shipbuilding companies, reports Al-Anba daily.

The source outlined that the designs for the three gas tankers were submitted to major entities such as Korean Hyundai Heavy Industries Limited, Chinese Shanghai Wagaoqiao Ship Company, Japanese Mitsubishi Heavy Industries Company, and Japanese Kawasaki Heavy Industries Company

Regarding the massive crude oil tanker, proposals for its design, construction, and delivery were extended to Korean Hyundai Heavy Industry Co., Ltd., Chinese Shanghai Wagaoqiao Ship Company, and Bohai Heavy Industry and Shipbuilding Company.

These tanker projects mark the initiation of the fourth phase of the fleet modernization initiative, which encompasses the development of a substantial crude oil tanker and four petroleum product tankers, in addition to the construction of three liquefied gas tankers.

The source noted that the decision to embark on the fourth phase was prompted by a downturn in construction activities at international shipyards.

Despite the challenges, the Kuwait Oil Tanker Company remains committed to sustaining a marine fleet of optimal size and quality, aligning with long-term strategic coverage and marketing requirements. This commitment is further tailored to meet targeted production rates within Kuwait while strategically operating and leasing surplus tankers to address global market needs on commercial grounds.

In the event that the bid is submitted electronically, a copy of the payment receipt must be attached to the bid electronically.

Sources said KPC charges a fee of KD250 for requests to add the company's name to the lists of limited tenders, indicating the receipt for the deposit in KPC's account must be attached to the application submitted for this purpose to the Secretariat of the Supreme Purchasing Committee. The bill does not consider if the period that the convict spent in jail is enough to be rehabilitated or not, hence, it does not guarantee the consequences of restoring the convict's political rights within a short period. The government said the laws that the concerned parliamentary committee used as basis in preparing its report on the bill were not taken into consideration, pointing out that these laws stipulate the need to fulfill the rehabilitation requirements such as completing the specified period with full commitment to maintaining good behavior and not committing any crime. The focus was on specifying the rehabilitation period without paying attention to the type of crime committed. The bill does not right to assign two individuals to take care of an individual with severe and permanent disability without defining the phrase 'permanent disability

- Article 32 of the bill allows obtaining housing loan from Kuwait Credit Bank (KCB) regardless of the number of disabled family members,

- The privileges stipulated in articles 40 and 41 of the bill such as reducing the working hours for the disabled employees and those assigned to take care of them are already included in the current law,

- Reducing the required service period for a disabled employee or the caregiver to be referred for retirement,

- The option to provide the equipment to the beneficiary or grant him cash instead of the equipment.

The decision stipulates the formation of a committee of specialists, headed by the assistant undersecretary for Pharmaceutical and Food Control Affairs. The committee's functions include assessment of the current situation of private pharmacies and the observations received in line with the laws and decisions regulating the practice of the pharmacy profession and distribution of medicines, as well as the submission of a detailed report including the results and recommendations within three months from the date of the first meeting of the committee.

In the context of following up reform steps and tightening control over the provision of psychotropic medications, Al-Awadhi issued another decision on the establishment of a central electronic system under the supervision of the ministry; through which the regularity of recording prescriptions for psychotropic substances and preparations dispensed from private pharmacies is followed up and monitored.

The decision obligates all private pharmacies licensed to trade in psychotropic substance preparations and regulate their circulation to register in the electronic system in accordance with the conditions and procedures specified in the decision.

For the abovementioned reasons, the government concluded that the bill failed to serve its purpose; so it was returned to the Assembly for the necessary action.

Meanwhile, Chairman of the Disabled Affairs Committee MP Saud Al-Asfour disclosed that the committee received a copy of govern-ment decree number 229/2023 on returning the ratified bill on amending Disabled Affairs Law number 8/2010 to the Assembly.

Al-Asfour clarified that this is one of the rights granted to the head of the State and the government as per Article 65 of the Constitution. He added the Assembly has the right to take measures as per Article 66 of the Constitution.

Article 65: (1) The Amir has the right to initiate, sanction, and promulgate laws. Promulgation of laws takes place within 30 days from the date of their submission by the National Assembly to the Amir. This period is reduced to seven days in case of urgency. Such urgency is decided upon by a majority vote of the members constituting the National Assembly

(2) Official holidays are not counted in computing the promulgation.

(3) If the period of promulgation expires without the Head of State demanding reconsideration, the bill is considered as having been sanctioned and is promulgated.

Article 66: Reference of a bill for reconsideration is by a decree stating the grounds therefore. If the National Assembly confirms the bill by a twothirds majority vote of its members, the Amir sanctions and promulgates the bill within 30 days from its submission to him. If the bill does not receive the said majority, it may not be reconsidered during the same session. If the National Assembly, in another session, considers the same bill by a majority vote of its members, the Amir sanctions and promulgates the bill as law within 30 days from its submission to him.

Al-Asfour confirmed that the decree specified the reasons for rejecting the bill as follows:

- High cost,

- Failure to provide a clear definition of the person assigned to take care of the disabled,

- Article 25 of the bill regulates the right of the first degree relative assigned to take care of the disabled to pass the task to the next of kin,

KUWAIT CITY, Jan 2: On the first day after the New Year holiday, oversight teams from the Engineering Audit and Follow-up Department in Farwaniya Municipality carried out an inspection tour yesterday morning in West Abdullah Al-Mubarak to detect violations related to construction work, and ensure the extent of the commitment of business owners and contractors to implementing projects and carrying out all construction, restoration, and excavation works. It was also aimed to ensure they have the necessary licenses and implement the regulations and decisions issued by the Kuwait Municipality regarding construction work and the maintenance of public facilities related to engineering control of buildings within the scope of the governorate's work. Director of the Engineering Au-

dit and Follow-up Department in the Farwaniya Municipality Saeed Al-Azmi explained that three citations on building violations, and four warnings against the violation of the regulations and decisions issued by the municipality regarding construction work were issued. Through the department, 90 percent of the building permits were issued, and 85 percent of the electricity connections were established,

In a press statement issued on the sidelines of the tour, Al-Azmi said the department's tours will continue periodically.

He explained that the detected violations vary between violations of gardens, buildings, contractors, and rubble. Each department determines its specialized team which is based on the nature of the tour and the inspection campaign. ## Russian ballistic missiles strike Ukraine's largest cities

Ukraine's two largest cities came under attack from Russian hypersonic ballistic missiles on Tuesday morning, killing at least four people and injuring almost 100, officials said, as the war approached its two-year milestone and the Kremlin's forces stepped

up their winter bombardment of urban areas. Ukraine President Volodymyr Zelenskyy said on his Telegram channel that four civilians were killed and 92 injured in the capital, Kyiv, and in northeastern Kharkiv as hypersonic Kinzhal missiles that can fly at 10 times the speed of sound slammed into city blocks

Russia fired almost 100 missiles of various types, Zelenskyy said on X, formerly Twitter. He claimed that at least 70 missiles were shot down, almost all of them in the Kyiv area, and said Western-supplied

air defense systems such as Patriots and NASAMS had saved hundreds of lives. Russia's Defense Ministry said it had launched missile and drone strikes on military industrial facilities in and around Kyiv. Depots storing missiles and munitions supplied by Ukraine's Western allies were also targeted, it said.

"The goal of the strike has been achieved, all the

targets have been hit," it said without elaborating. It was not possible to independently verify either side's claims.

Since Sunday, Zelenskyy said, Russian forces have launched about 170 Shahed drones and "dozens of missiles of various types" in an onslaught against Ukrainian targets. Most were aimed at civilian areas, he said.

The Kh-47M2 Kinzhal is an air-launched hypersonic ballistic missile. Russian forces rarely use such expensive missiles against Ukraine due to their limited stocks. (AP)

Migrant buses ignore NYC order: A New Jersey mayor says buses of migrants bound for New York City have been stopping at the train station in his town and others in an apparent effort to evade an executive order by New York's mayor trying to regulate how and when migrants can be dropped off in the city.

Secaucus Mayor Michael Gonnelli said Sunday that Secaucus police and town officials had been told by Hudson County officials about the arrival of buses at the train station in Secaucus Junction beginning Saturday. He said four buses were believed to have arrived and dropped off migrants who then took trains into New York City.

Gonnelli said the executive order signed recently by Mayor Eric Adams of New York requires bus operators to provide at least 32 hours' advance notice of arrivals and to limit the hours of drop-off times.

"It seems quite clear the bus operators are finding a way to thwart the requirements of the executive order by dropping migrants at the train station in Secaucus and having them continue to their final destination. Gonnelli said in a statement. He suggested that the order may be "too stringent" and is resulting in "unexpected consequences."

Gonnelli called the tactic a "loophole" bus operators have found to allow migrants to reach New York City, and added that state police have reported that "this is now happening at train stations throughout the state." Gonnelli vowed to work with state and county officials and to "continue to monitor this situation closely." (AP)

eign exchange student from China who was reported missing last week in Utah has been found in what authorities said was an ap-

tility surrounding this year's presidential contest has few modern parallels, posing profound challenges to the future of American democracy.

Not since the Supreme Court effectively decided the 2000 campaign in favor of Republican George W. Bush has the judiciary been so intertwined with presidential politics.

In the coming weeks, the high court is expected to weigh whether states can ban former President Donald Trump from the ballot for his role in leading the Jan. 6, 2021, insurrection at the U.S Capitol. Meanwhile, a federal appeals court is weighing Trump's argument that he's immune from prosecution.

The maneuvers are unfolding as prosecutors from New York to Washington and Atlanta move forward with 91 indictments across four criminal cases involving everything from Trump's part in the insurrection to his efforts to overturn the 2020 election and his hush money paid to a porn actress.

Depending on how Trump's appeals play out, he could be due in court as early as March 4, the day before Super Tuesday, raising the unprecedented prospect that he could close in on the GOP nomination from a courtroom. On the Democratic side, President

Joe Biden is seeking reelection as the

And at least three serious candidates who have launched outsider presidential bids threaten to scramble the campaign and eat into the support from independent voters who were critical to Biden's success in 2020.

Facing such uncertainty, few expect the traditional rules of politics to apply in 2024. Jim Messina, who managed former President Barack Obama's reelection, said Trump could very well defeat Biden in the fall, even if the former president is in prison.

"We just don't know," Messina said. "Everyone in the world knows, especially me, that this election is going to be really, really close."

The results will have long-term implications on everything from the future of abortion rights and immigration policy to the role of the U.S. in the world. A Trump victory would raise the possibility of the U.S. largely abandoning Ukraine as it seeks to repel Russia's invasion. Domestic politics could also test Biden's commitment to Israel, a policy that threatens to erode his standing with young voters and people of color who are critical elements of his coalition.

One of the few certainties at this point is that Biden is a virtual lock

Jan. 15 when the Iowa caucuses launch the nomination process. Trump holds a commanding lead in most national polls, although former U.N. ambassador Nikki Haley and Florida Gov. Ron DeSantis are fighting to stop him.

That hasn't been easy, however, as DeSantis has struggled to connect with voters and has embraced culture war topics that often left him competing for the same base of support as Trump. And Haley's pitch as a more sensible, moderate candidate was threatened last week when she was pressed on the cause of the Civil War and didn't mention slavery.

Allies of DeSantis and Haley privately concede that their best chance to wrestle the nomination away from Trump would come in a long-shot push for a contested convention in Wisconsin in July.

Many leaders in both parties are already convinced that Trump will be the GOP nominee. More than 90 House Republicans, 18 senators and seven governors have endorsed Trump. Haley and DeSantis have secured the endorsements of just six House Republicans, no senators and two governors combined.

## Powerful earthquakes leave at least 55 dead

WAJIMA, Japan, Jan 2, (AP): A series of powerful earthquakes that hit western Japan have left at least 55 people dead and damaged thousands of buildings, vehicles and boats. Officials warned Tuesday that more quakes could lie ahead.

Aftershocks continued to shake Ishikawa prefecture and nearby areas a day after a magnitude 7.6 temblor slammed the area.

Damage was so great that it could not immediately be assessed. Japanese media reports said tens of thousands of homes were destroyed.

Government spokesperson Yoshimasa Hayashi said 17 people were seriously injured and gave a slightly lower death toll, saying he was aware of the prefecture's tally.

Water, power and cell phone service were still down in some areas. Residents expressed sorrow about their uncertain futures.

"It's not just that it's a mess. The wall has collapsed, and you can see through to the next room. I don't think we can live here anymore," Miki Kobayashi, an Ishikawa resident, said as she swept around her house.

The house was also damaged in a 2007 quake, she said.

Although casualty numbers continued to climb gradually, the prompt public warnings, relayed on broadcasts and phones, and the quick response from the general public and officials appeared to have limited some of the damage.

Toshitaka Katada, a University of Tokyo professor specializing in disasters, said people were prepared because the area had been hit by quakes in recent years. They had evacuation plans and emergency supplies in stock.

"There is probably no people on earth other than Japanese who are so disaster-ready," he told The Associated Press.

Japan is frequently hit by earthquakes because of its location along the "Ring of Fire," an arc of volcanoes and fault lines in the Pacific Basin.

Katada warned the situation remains precarious and unpredictable. The March 2011 quake and tsunami in northeastern Japan had been preceded by other quakes.

TOKYO: A passenger plane and a Japanese coast guard aircraft collided on the runway at Tokyo's Haneda Airport on Tuesday and burst into flames, with five people on the smaller plane killed, officials said.

### Egypt's oil well commences production

# **Financing of Kuwaiti imports by** local banks sees jump of 31.8%

Bulk of the financing in US dollars

**KUWAIT CITY, Jan 2:** Financing provided to support Kuwaiti imports from local banks has exhibited substantial growth over the 11 months of 2023, demonstrating a notable increase of 31.8% compared to the same period last year. The total financing rose from 7.282 billion dinars during the 11 months of 2022 to an impressive 9.6 billion dinars in the corresponding period of 2023. This robust growth is particularly noteworthy given the challenging economic circumstances experienced globally.

However, it is essential to note that despite the impressive yearon-year increase, there was a monthly decline of 12.9%, with

the financing dropping from 697.5 million dinars at the end of October to 607.4 million dinars at the end of November 2023. This monthly fluctuation underscores the dynamic nature of financial markets and economic activities.

Breakdown by Currency: 1. US Dollars Dominance: Financing provided in US dollars constituted a significant major-ity, representing 85.17% of the total import financing. This currency experienced a remarkable increase of 34.4% during the 11 months of 2023, reaching 8.178 billion dinars in compared to 6.082 billion dinars in the same period of 2022. Despite a 14.6% monthly decline in November to 486.9 million dinars, the overall annual growth is substantial.

2. Other Currencies Contribution: Financing in other currencies occupied the second position, making up 6.3% of the total. This category witnessed a 32.3% increase during the 11 months, totaling 610.7 million dinars. In November alone, there was a 1% rise to 52.3 million dinars.

3. Euros and Other Currencies: Financing provided in euros accounted for 4.3% of the total import financing, although it experienced a 22.1% monthly decline in November to 30.9 million dinars. On an annual basis, there was a decrease of 2.2%, reflecting the volatility in currency markets.

4. Diversification with Dirhams and Riyals: Financing in UAE dirhams represented 1.8% of the total, marking a 16.4% increase to 174.2 million dinars. Simultaneously, financing in Saudi riyals surged by 71.6%, amounting to 127.5 million dinars, contributing about 1.3% to

the total financing. 5. Japanese Yen and British Pound: Financing in Japanese yen and the British pound reached 46.2 million dinars and 41.6 million dinars, respectively, showcasing diversified currency support.

Consequently, the market is eagerly anticipating the monthly projections released by the OPEC Secretariat, the US Energy Information Administration, and the US Energy Agency. These forecasts play a pivotal role in shaping the trajectory of the demand and supply equilibrium in the oil markets. The market is also closely monitoring the actions of speculators, with the hope that it will maintain a sense of calm until after the OPEC Ministerial Conference, as these events can significantly influence oil prices. Kuwaiti oil prices reached their

zenith at \$53.3 per barrel on February 3, 2017, only to dip to \$45.5 per barrel in recent weekend trading. There is an optimistic outlook that Kuwaiti prices may recover towards \$53 per barrel again, contingent upon the acceleration of oil stock withdrawals, ultimately contributing to a more balanced state in the oil markets.

## Political turmoil persists despite economic success

## Brazil's economy improves during President Lula's first year back

RIO DE JANEIRO, Jan 2, (AP): Brazilian President Luiz Inácio Lula da Silva likes to boast he had a good first year after returning to the job. The economy is improving, Congress passed a long-overdue tax reform bill, rioters who wanted to oust him are now in jail, and his predecessor and foe Jair Bolsonaro is barred from running for office until 2030.

Still, the 78-year-old leader has struggled to boost his support among citizens and lawmakers. Some major setbacks, including a series of votes by Congress to override his vetoes, sig-

naled that Lula's future could be productive less in a Brazil almost evenly split between his supporters and Bolsonaro's. "Brazil's po-

polarizalitical tion is such that it crystallized the opinions of Lula and Bolsonaro

voters beyond the economy," said political consultant Thomas Traumann, the author of a recent best-selling book on Brazil's political divisions. "These groups are separated by very different world views, the values that form the identity of each group are more important than food prices or interest rates."

Lula took office on Jan. 1, 2023, after a narrow victory over Bolsonaro in October 2022. At the beginning of his four-year term, only one fourth of Brazil's Congress sided with him. Business and opposition leaders feared Lula had gone too far to the left.

A riot led by Bolsonaro supporters destroyed government buildings in the capital of Brasilia on Jan. 8 and more turmoil looked certain. Former Finance Minister Paulo Guedes, among other conservatives, forecast Lula's policies would make Brazil's economy soon turn as sour as those in crisis-ridden Argentina and Venezuela.

"Six months to become Argentina. One year and a half to become Venezuela," Guedes said in an interview. Fast forward to December.

Brazil's economy is set to grow 3% this year instead of the 0.6% expected by market economists. Inflation looks controlled at about 4.7% on a yearly basis, slightly above projections but far from the double digits of recent years. The unemployment rate fell to 7.5% in November, one percentage point below the day Bolsonaro left office.

The Sao Paulo stock exchange hit record levels in December, rising above 134,000 points for the first time in its history. Brazil's real currency is also rising against the U.S. dollar. All that brought back the optimistic, keen-totravel-abroad Lula who had been missing during almost a decade of personal gloom.

"We needed to get our house fixed (in 2023), put things into place," Lula said in a meeting at the presidential palace on Dec. 12. "And now I say get ready. Next year, the Brazilian economy will not let anyone down.'

Yet some polls have shown unchanged support for the president, at between 38% and 40% since January 2023. The numbers didn't pick up even after the announcement of a higher minimum wage in 2024, the buildup of Bolsonaro's legal woes or Brazil's return as a player in foreign affairs under Lula.

#### Powerhouse

About a third of Brazilians consider Lula's presidency about average and another third deeply dislike the way he governs Latin America's powerhouse economy, which rose once again to the top 10 biggest in the world after years of sinking. Lula's supporters are at home, but Bolsonaro's are still taking to the streets.

Though not as numerous as in the recent past, the few thousand protesters asking Congress to impeach Lula on corruption allegations have shown the resilience of the far-right leader's political base.

Bolsonaro was barred in June 2023 from running for office again until 2030 after Brazil's electoral court ruled that he abused his power and cast unfounded doubts on the country's electronic voting system. Engineer Eduardo Carlos Santos,

73, believes Brazil's economy recovered due to the work of Bolsonaro. A devout evangelical, as with many in the former president's base, he says there is a cultural war against conservatives and that leftists should have no place in government.

"Like it or not, Bolsonaro left a better economy and Lula is just reaping the fruits of that," said Santos, who blames the economic difficulties during the previous presidency on the COVID-19 pandemic and health restrictions. "Lula is a former inmate, sentenced for corruption. He had his time in office, we needed to move the country to another direction. I don't see a bright year coming ahead."

Lula was imprisoned for alleged corruption in 2018, when he led polls to return to the presidency. He was released after the country's Supreme Court ruled the following year that prison sentences could only take place after every appeal has been exhausted which was not the case with Lula.

Later, the same court ruled that the judge in Lula's case, now a pro-Bolsonaro senator, was biased against him.

# World markets are mixed on the first trading day of 2024

European benchmarks higher after Asian markets mostly fell

**BANGKOK, Jan 2, (AP):** European benchmarks were higher Tuesday after Asian markets mostly fell on the first trading day of 2024.

U.S. futures were higher and oil prices gained more than \$1.

Hong Kong's benchmark fell more than 1% and Shanghai also declined after data showed more signs of weakness in the Chinese manufacturing and property sectors.

The future contract for the S&P 500 edged 0.1% higher and that for the Dow Jones Industrial Average added 0.2%

## Sharp run-up lift borrowing costs

## Average long-term mortgage rates dip for 9th straight week

NEW YORK, Jan 2, (AP): The average long-term U.S. mortgage rate retreated for the ninth straight week to reach its lowest level since May.

The average rate on a 30-year mortgage dipped to 6.61% from 6.67% last week, mortgage buyer Freddie Mac said. In 2022, the rate averaged 6.42%. Borrowing costs on 15-year fixedrate mortgages, popular with homeowners refinancing their home loans, also inched down this week, with the average rate falling to 5.93% from 5.95% last week. In 2022, it averaged 5.68%, Freddie Mac said.

"Heading into the new year, the economy remains on firm ground with solid growth, a tight labor market, decelerating inflation, and a nascent rebound in the housing market," Sam Khater, Freddie Mac's chief economist.

Mortgage rates have been easing since late October, when the average rate on a 30-year home loan reached 7.79%, the highest level since late 2000.

The decline has tracked the trajectory of the 10-year Treasury yield, which lenders use as a guide to pricing loans. The yield, which in mid October surged to its highest level since 2007, has been falling on hopes that inflation has cooled enough for the Federal Reserve to shift to cutting interest rates after yanking them dramatically higher since March of 2022.

The Fed has opted to not move rates at its last three meetings, which has also given financial markets a boost.

Investors' expectations for future inflation, global demand for U.S. Treasurys and what the Fed does with its benchmark federal funds rate can influence rates on home loans.

The sharp run up in mortgage rates that began early last year has pushed up borrowing costs on home loans, reducing how much would-be home buyers can afford even as home prices have kept climbing due to a stubbornly low supply of properties on the market. That's weighed on sales of previously occupied U.S. homes, which are down 19.3% through the first 11 months 2023.

Despite the recent decline, the average rate on a 30-year home loan remains sharply higher than just two years ago, when it was 3.11%. The large gap between rates now and then is contributing to the low inventory of homes for sale by discouraging homeowners who locked in rockbottom rates two years ago from sell-

ing. Some housing economists are forecasting that home sales will increase in 2024, on the assumption that mortgage rates ease further.

Germany's DAX gained 1% to 16,927.63. In Paris, the CAC 40 was 0.6% higher to 7,587.62. Britain's FTSE 100 was up less than 0.1% to 7,734.75. Investors were awaiting the release of euro-zone manufacturing statistics later in the day.

The Hang Seng index in Hong Kong sank 1.6% to 16,784.00 and the Shanghai Composite index dropped 0.4% to 2,962.28.

Investors were selling property de-velopers like debt-laden China Evergrande, which fell 6%, and LongFor Group Holding, which lost 6.9%. Sino-Ocean Holding declined 4.6%.

The December survey of the official purchasing managers index, or PMI, in China fell to 49 for the third consecutive month, signaling weak demand and underscoring the challenging economic conditions in the world's second-largest economy.

That contrasted private-sector survey, by financial publication Caixin, which registered a slight improvement in the manufacturing PMI to 50.8, driven by increased output and new orders. However, it showed that business confidence for 2024 remained subdued.

The latest data also showed that the value of new home sales by China's top 100 developers fell nearly 35% from a year earlier in December despite moves by regulators to lift limits on such transactions.

South Korea's Kospi gained 0.6% to 2,669.81 and the S&P/ASX 200 in Australia rose 0.5% to 7,627.80.

Bangkok's SET added 1.2% while the Sensex in Mumbai lost 0.5%

Japan's markets were closed for a holiday.

Stocks fell Friday on Wall Street from their near all-time high amid easing inflation, a resilient economy and the prospect of lower interest rates which buoyed investors.

The S&P 500 slipped 0.3%. The benchmark index still posted a rare ninth consecutive week of gains and is just 0.6% shy of an all-time high set in January of 2022. The Dow Jones Industrial Average fell 0.1% and the Nasdaq composite slipped 0.6%.

## Deutsche Bank pledges to help combat human trafficking

SANTA FE, N.M., Jan 2, (AP): Deutsche Bank pledged nearly \$5 million in funding to help combat human trafficking in New Mexico, the bank announced in a joint statement with Attorney General Raúl Torrez.

The announcement comes seven months after Deutsche Bank settled a U.S. lawsuit for \$75 million that claimed the German lender should have seen evidence that the late Jeffrey Epstein engaged in sex trafficking when he was a client.

Torrez's office has been investigating several financial service companies and their role in what he says is a failure to identify sexual abuse and trafficking of underage girls at Epstein's ranch in Santa Fe County, according to the state-

"I am pleased that Deutsche Bank recognizes its ongoing responsibility to help us combat this problem," Torrez, a Democrat, said in the statement. "We appreciate the steps they have taken since terminating Jeffrey Epstein as a client in 2018 to strengthen their oversight capabilities and intend to use their pledge to support our ongoing efforts to apprehend traffickers and expand our victim services.'

A spokesperson for Deutsche Bank said the lender is pleased to support Torrez "in this important effort, which reflects our industry's shared responsibility to play an active role in safeguarding the financial system.'

## Inflation eases, confidence rises

## IPO market poised for 2024 recovery

NEW YORK, Jan 2, (AP): The signs of life shown by the IPO market, especially in the second half of 2023, are giving analysts hope that more companies will be enticed to go public in 2024.

Overall, 108 initial public offerings raised proceeds of about \$19.4 billion in 2023, according to Renaissance Capital. That's up from a dismal 71 IPÔs for proceeds of \$7.7 billion in 2022, when high inflation and rising interest rates discouraged companies from hitting the market.

This year's big IPOs included healthcare products company Kenvue in May, U.K. chip designer Arm Holdings in September and footwear company Birkenstock in October. They accounted for over half of the total IPO proceeds, according to Renaissance Capital. Instacart also had a splashy IPÔ in late summer.

A post-pandemic surge for IPOs was stifled by the highest inflation in four decades in 2022, raising concerns about the economy buckling under the pressure. The Federal Reserve then embarked on a historic round of rate hikes to tame inflation, which made borrowing more expensive and increased caution in the IPO market.

The Fed's preferred measure of inflation, the monthly personal consumption and expenditures report, has cooled to a pace of 2.6% from a high of 7.1% in the middle of 2022. Other measures of inflation, such as the consumer price index, reached a peak of 9.1% in 2022

The central bank fought inflation by raising its benchmark rate from near zero to a range of 5.25% to 5.50%. The Fed has held that range steady for several months and has signaled that it could start cutting rates in 2024. Wall Street is betting that could happen early in the year.

Cooling inflation and falling interest rates could push the IPO market back toward a more normal level of activity, which averaged about 170 IPOs with average proceeds of about \$43 billion from 2017 to 2019.

Advocates seek to eliminate tipped wage

## Workers in New England states looking forward to bump up in minimum wages

BOSTON, Jan 2, (AP): Workers in several New England states are looking forward to a bump up in the minimum wage in 2024 while advocates in Massachusetts are pushing a ballot question aimed at phasing out the state's subminimum wage of \$6.75 per hour for tipped workers.

In Rhode Island, the state's current \$13 minimum wage will jump by \$1 to \$14 an hour on Jan. 1. It is the next step in a phased-in increase that will reach \$15 in 2025.

In Vermont, the state's minimum wage will reach \$13.67 - climbing \$0.49 from the current \$13.18 wage. The annual adjustment also affects the minimum wage for tipped workers, which will tick up from \$6.59 to \$6.84 per hour.

Maine will see its hourly minimum wage tick up from \$13.80 to \$14.15 per hour. Maine requires annual adjustments to the minimum wage based on the cost-of-living. Portland is pushing its city minimum wage from \$14 to \$15. The state's new tipped wage in 2024 will be \$7.08 per hour.

The minimum wage in Connecticut will rise from the current rate of \$15.00 per hour to \$15.69 - the highest in New England. Beginning Jan. 1, and occurring annually each following Jan. 1, the wage will be adjusted according to the U.S. Department of Labor's calculation of the employment cost index.

Massachusetts' minimum wage will remain at \$15 per hour in 2024, although there is a campaign to hike the wage again to \$20.

New Hampshire continues to have the lowest minimum wage in New England, matching the federal wage of \$7.25. State lawmakers have defeated multiple attempts to increase it in recent years.

The New England states are among 20 raising minimum wages for workers, further widening the gap between state requirements and the federal minimum wage, which has been static at \$7.25 an hour since July 2009. In several states, the new minimum will more than double that rate.

In Massachusetts, advocates are pushing a ballot question that would phase out the state's "service rate" which lets restaurants pay workers \$6.75 an hour if tips make up the difference between that and the state's \$15 minimum wage. Under the question, the service rate would end by 2029.

Organizers for the group One Fair Wage said they have collected enough signatures to clear an initial hurdle to gaining a slot on next year's ballot.

"Massachusetts voters are ready to move away from outdated wage practices and towards a system that guarantees dignity, justice, and economic security for all workers," Saru Jayaraman, president of One Fair Wage, said in a written statement,

The Massachusetts Restaurant Association opposes the question, saying the highest-paid employees in any restaurant are tipped employees, frequently averaging \$20, \$30, and sometimes even \$50 per hour.

A restaurant owner can employ more than two full time waitstaff employees for the same hourly rate as one minimum wage employee, said Jessica Muradian of Massachusetts Restaurant Association.

## Canadian fan's ashes to join 'Star Trek' stars in orbit

VANCOUVER, British Columbia, Jan 2, (AP): The family of a mother of eight who was a huge "Star Trek" fan has ensured the final frontier will be her ultimate resting place.

Gloria Knowlan was 86 at the time of her death 12 years ago. A small quantity of ashes from her cremated body are to be in one of 250 memorial capsules set to be launched into space later this month.

Launch organizers are hoping the rocket carrying the capsules will wind up approximately 330 million kilometers (205 million miles) from Earth, roughly past the orbit of Mars.

The remains or DNA samples of "Star Trek" creator Gene Roddenberry, his wife, Majel Barrett Roddenberry, and Original Series stars Nichelle Nichols, DeForest Kelley and James Doohan also are expected to make the trip.

Their final journey will take place through American company Celestis Inc., which has offered what it calls "memorial space flights" for more than two decades.

Knowlan's son said his mother dove headlong into things she loved, including the show, after his father died in 2002. Her love of "Star Trek" prompted her to collect replica starships and deck out her Christmas tree each year with a homemade alien space-

craft known as the Borg cube, complete with working lights. Rod Knowlan said he thinks his mother would be "just tickled" by the idea that a part of her remains were going to space alongside some of the people she saw on TV.

"She was a fan of 'Star Trek,' of the concept, from the outset,□ he said in a telephone interview.

For prices ranging from a few thousand dollars to \$13,000, Celestis Inc. takes small capsules of human remains or DNA to space and either returns them, drops them in Earth's orbit or takes them to the moon as a tribute to late loved ones.

Co-founder and CEO Charles Chafer said the rocket carrying Knowlan's remains, scheduled to take off from Cape Canaveral, Fla. on Jan. 8, will mark the first time the company has offered a trip into "deep space,□ meaning the capsules won't eventually fall to Earth.

"I believe it's an awful lot like why people choose to be scattered at sea," Chafer said. "There's a calling there. There's something about the sea that either interests them or attracts them as a location for a memorial service.'

The capsules will be taken into space by the commercially owned and aptly named Vulcan rocket.

Chafer said the main purpose of the trip is for the rocket to test its capabilities to become the first commercial spacecraft to land on the moon and his company's cargo is getting taken along to serve a "secondary" purpose.

## **Allure & monstrosity in 'Poor Things'**

NEW YORK, Jan 2, (AP): "Poor Things" is a Frankenstein-esque fantasia about a young woman (Emma Stone) reanimated by a demented surgeon (Willem Dafoe), but the behind-the-scenes work that went into crafting the movie's wildly warped world may be the film's greatest act of mad science.

Though Yorgos Lanthimos' earlier films - at least leading up to "The Favourite" - were more spare productions, "Poor Things" fuses all the tools of classic Hollywood filmmaking - grand sets, miniatures, sumptuous costumes - with subtler touches of modern technology. The movie is, itself, a Frankenstein.

Only the scars (not counting the ones on Dafoe's elongated face) don't show in the magpie design of "Poor Things." The film's style is rooted in an 1890s Victorian setting, but it expands surreally from there.

"We were looking at the Victorian era as if it had been written about in a sci-fi movie," says Shona Heath, one of the two production designers on the film along with James Price. "We basically gave ourselves an open book to do what we wanted."

The result is something wholly original. "Poor Things," based on Scottish novelist Alasdair Gray's 1992 book, conjures an elaborately demented world as seen through the childlike eyes of Bella Baxter (Stone), a woman, as Dafoe's Dr. Godwin Baxter describes, whose mental age and body "are not quite synchronized."

"Poor Things" is one of the most acclaimed films of the year. (It won top prize at the Venice Film Festival and was nominated for seven Golden Globes on Monday. ) And a lot of that is owed to the richness of its craftsmanship.

To understand how they tackled it, The Associated Press spoke to Lanthimos and several key collaborators - the productions designers, costume designer Holly Waddington and cinematographer Robbie Ryan - about bringing "Poor Things" to life.

"From the moment I read the novel, I always felt that we needed to build a world that Bella would inhabit," says Lanthimos. "Like Victorian era, but tweaked."

The sets built by Heath and Price would be the foundation of "Poor Things." The movie begins in Baxter's London townhouse, which houses a laboratory inspired by "Young Frankenstein." It then travels to Lisbon, Alexandria and Paris, with a steamship voyage in between. It's a journey of self-discovery and sexual liberation for Bella, set against a delirious fairy-tale backdrop.

Lanthimos had some guiding references, including films like Francis Ford Coppola's "Bram Stoker's Dracula," Luis Buñuel's "Belle du Jour" and Fellini movies. But he gave his production teams wide latitude. "Yorgos encouraged every extremity," says Heath.

"He wanted something he hadn't seen before.

The designers gradually assembled a reference guide of 200 pages. Inside were everything from paintings by Hieronymus Bosch, Egon Schiele, Francis Bacon and John Singer Sargent; drawings of medical surgeries; and grotesque blob fish.

On soundstages in Budapest, the production designers built massive, immersive sets for the London townhouse, a Paris square in winter and the cruise ship. The Lisbon street scene set, 170 feet long and 60 feet tall, was so large it needed to be erected separately at nearby Korda Studios. LED screens were typically used for backdrops. "We did 10 years worth of work in one movie, crea-

tively," says Price.

#### Creative

Price and Heath are particularly proud of the London townhouse, which was so fully built, with something down every corridor, that to some on set it seemed like an actual house. Lanthimos didn't save anything from the production but he took pictures of the London

house's slow demolition. Price ("Paddington 2," "Judy") has grown accustomed to seeing his works built and destroyed.

"I find it quite cathartic that you can go from conception, the birth of an idea, to the death. It's kind of rare as a creative. It lives on in cinema," says Price. "I'm odd, though. Everyone else finds it tragic.

Lanthimos' guidance for Waddington was even less: a single image of some inflatable trousers. But that was enough to set her thinking about expressing Bella's nature through her clothing. In one striking example, Bella wears a wedding dress with airy, balloon-like sleeves.

"She is a reanimated person. This idea of air and breath. That manifested itself in these sleeves that were huge and lung-like and organic," says Waddington.

Waddington initially thought Bella's wardrobe would be small, since she's traveling. But as she dug more deeply into her work, Waddington began to chart Bella's growing independence through her attire.

"I realized quickly that it would not do to do that. Her evolution is rapid, and the clothes needed to grow with her," says Waddington.

Early on, Bella's clothing is more doll-like and animalistic. The bustle of one dress was made of rolls of crinoline that resemble a judge's wig or a lobster tail. To Waddington, it's a perfect combination of period and contemporary, almost like a puffer jacket.

"If you look at the late Victorian clothes, the women's wear is full of bits of animals, bits of unborn Persian lambs - quite grotesque things," she says. "I wanted to capture something of the animal in the clothes."

For the Paris brothel chapter of the film, Waddington used yellow latex to create what she terms Bella's "condom coat." Throughout the process, she leaned into bodily shapes and textures.

"It's partly the subject matter," she says. "All I could see was genitalia in everything I was doing.'

Yet by the time Bella is fully realizing herself and finding her professional future, her clothing grows closer to modernity. Once in medical school alongside rows of men, Bella, in a formal black top, initially seems to blend in.

"Then I wanted a subtle shift," Waddington says. "I still wanted to subvert it, so when she got up, you would see these legs without any skirt on.'

Ryan is best known as the cinematographer of naturalist filmmakers like Andrea Arnold, Ken Loach and Noah Baumbach. But beginning with "The Favourite," Ryan and Lanthimos have found a strong collaboration.

Ryan, who operates the camera himself, found he could bring some of the same approaches to the florid design all around him.

"Ironically, we shot in a very similar way to 'The Favourite.' We didn't use much lighting on set. Everything was lit from afar," says Ryan. "We shot it in a way that didn't feel complicated.'

Ryan and Lanthimos shot "Poor Things" on film. He was typically working with only one camera and shot as much as possible in camera, not depending on visual effects for much except things like the movie's many computer-generated hybrid creatures.

'The visual references and ideas they had were wild. I was like: 'How are we going to do that?'" Ryan says. "We used a lot of tricks and techniques and old camera styles that were very practical in a way, and lent themselves to being more visual. That was the great ambition, to try and follow it in an old-school way of '30s cinema. That made it easier to imagine.'

## Magubane, fearless photographer, dies

CAPE TOWN, South Africa, Jan 2, (AP): Peter Magubane, a fearless photographer who captured the violence and horror of South Africa's apartheid era of racial oppression, and was entrusted with documenting Nelson Mandela's first years of freedom after his

Ing Nelson Mandela's first years of freedom after his release from prison, has died. He was 91. Magubane died Monday, according to the South African National Editors' Forum, which said it had been informed of his death by his family. He was a "legendary photojournalist," the editors' forum said. The South African government said Ma-

gubane "covered the most historic moments in the liberation struggle against apartheid."

Magubane photographed 40 years of apartheid South Africa, including the



1960 Sharpeville massacre, the trial of Mandela and others in 1964, and the Soweto upris-ing of 1976, when thousands of Black students protested against the apartheid government's law making the Afrikaans language compulsory in school.

The Soweto uprising became a pivotal moment in the struggle for democracy in South Af-

the young protesters, killing at least 176 of them and drawing international outrage. Magubane's awardwinning photographs told the world about the killings.

Magubane became a target of the apartheid government after photographing a protest outside a jail where Mandela's then-wife Winnie Madikizela-Mandela was being held in 1969.

Magubane was jailed and kept in solitary confinement for more than a year-and-a-half. He was imprisoned numerous times during his career and subjected to a five-year ban that prevented him from working or even leaving his home without police permission. He said he was shot 17 times with shotgun pellets by apartheid police while on assignment and was beaten and had his nose broken by police when he refused to give up the photographs he took of the Soweto uprisings.

### Apartheid

Faced with the option of leaving South Africa to go into exile because he was a marked man by the apartheid regime, he chose to stay and continue taking photographs.

"I said, 'no I will remain here. I will fight apartheid with my camera," he said in a recent interview with national broadcaster SABC.

While Magubane photographed some of the most brutal violence, he also created searing images of everyday life under apartheid that resonated just as much.

One of his most celebrated photographs was a 1956 image of a Black maid sitting on a bench designated for whites only while seemingly caressing the neck of a white child under her care in a wealthy Johannesburg suburb. The photo spoke of the absurdity of the forced system of racial segregation given that so many white children were looked after by Black women.

Magubane began his career at the South African magazine, Drum, gained fame at the Rand Daily Mail newspaper and also worked for Time magazine and Sports Illustrated, earning international recognition.



Hit-Boy building legacy with family

LOS ANGELES, Jan 2, (AP): When Hit-Boy walks the Grammy red carpet, he expects to proudly strut into the Feb. 4 awards ceremony with his father beside him for the first time.

For three decades, Hit-Boy's dad was in-and-out of prison, with his recent stint lasting nine years until his release several months ago. With his father's newfound freedom, the super producer - who has worked with music heavyweights from Jay-Z, Nas and Kanye West - is focused on strengthening their father-son bond while navigating the music industry together.

Hit-Boy has the Grammys and a producer of the year, non-classical nomination in his sights. He's had three songs involving Brent Faiyaz, Blxst and The Alchemist. He also produced three Nas albums, including "King's Disease III," which is up for best rap album; one with Musiq Soulchild; and his two "Surf or Down" albums, which featured the producer as a rapper and his father on several tracks under the stage name Big Hit. When Hit-Boy first heard about being a nominee again, he felt an instant "wave of emotions." He was one of the most productive producers this past year compared to others in his category - which includes Jack Antonoff, Metro Boomin, Dernst "D'Mile" Emile II and Daniel Nigro. "I literally broke down in tears," said Hit-Boy, a three-time Grammy winner through Jay-Z and Kanye West's "... In Paris," Nipsey Hussle's "Racks in the Middle" and Nas' album "King Disease." He's worked with top performers including Beyoncé, Mary J. Blige, Drake, Mariah Carey, Ariana Grande and Jennifer Lopez.

Throughout the year, Hit-Boy said he worked mostly with Nas and his father, Big Hit, who recorded his lyrics for the intro on "Surf or Down Vol. 1" while incarcerated. After his father's release, Hit-Boy took him directly to the studio - where they both laid down tracks.

This month, Big Hit, 52, released his debut album "The Truth is in My Eyes," which features Snoop Dogg, Benny The Butcher, Musiq Soulchild, Dom Kennedy, The Alchemist and Mozzy. He said it was tough being away from his son and watching his success from afar.

"It was torture just knowing the kind of impact I could've had and what I missed in his life," said the rapper, who was arrested during a traffic stop

might do something to jeopardize it again. It's part of that brainwork where you just got to hold it down and financially. I wanted to build, put together pieces that would bring people completely into his world."

Hit-Boy said several labels have offered Big Hit deals, but they turned them down. The producer said they'll be better off on their own for now.

"They wanted to put some cool money in his pocket," Hit-Boy said. "But I've been in the game since I was 19. He got locked up at 19 until he was in his 30s. Now, I'm in my 30s and I'm locked up in the industry, because I'm still to this day in a bad publishing deal with Universal Music Publishing Group. I would feel so crazy to let my dad get caught up with these same systems, the same ways and ideologies that I've been fed since I was a kid. I just can't go for it." Hit-Boy, 36, and his team decided against releasing Big Hit's new album on digital stream platforms. He wants people to buy directly from them, which according to his team has so far worked out. "We got physical CDs. We're not going to do any DSPs, no streaming," the producer said. "I've been seeing a lot of people complain about that. Snoop just went on a platform and talked about how he got a billion streams, but only earned about \$40,000 or \$45,000. I feel like if we sell 10,000 CDs, we're going to blow that out the water. We're going to start small. We don't need to have a billion streams, because that might only equate to 10,000. We're going to let people buy the music directly from us.' Hit-Boy said he and his father are making music, doing business together like he always wanted. If he could win a Grammy with his dad, mother and young son in attendance, it would mean the world to him. "Every time I won a Grammy, he was locked up," he said. "That would be dope to win. I'm going to speak it into existence.'

LOS ANGELES: Les McCann, a prolific and influential musician and recording artist who helped found the soul-jazz genre and became a favorite source for sampling by Dr. Dre, A Tribe Called Quest and hundreds of other hip-hop performers, has died. He was

McCann died Friday in Los Angeles a week after being hospitalized with pneumonia, according to his longtime manager and producer, Alan Abrahams.

A Lexington, Kentucky, native, McCann was a vocalist and self-taught pianist whose career dated back to the 1950s, when he won a singing contest while serving in the U.S. Navy and appeared on "The Ed Sullivan Show," the top variety program of its time. With admirers including Quincy Jones and Miles Davis, he went on tour worldwide and released dozens of albums, starting in 1960 with "Les McCann Ltd. Plays the Truth."

He was best known for "Compared to What," a funky protest song on which he first teamed up with his future musical partner, saxophonist Eddie Harris. Written by Eugene McDaniels and recorded live at the 1968 Monteaux Jazz Festival, "Compared to What" blended jazzy riffs and McCann's gospel-style vocals. The song condemned war, greed and injustice with such couplets as "Nobody gives us rhyme or reason/Have one doubt, they call it treason.

Among those covering "Compared to What" was Roberta Flack, a McCann protégé whose career he helped launch by setting up an audition with Atlantic Records. McCann was a pioneer in merging jazz with soul and funk. He would record with Flack and tour with such popular musicians as Wilson Pickett, Santana and the Staples Singers.

His other albums included "Talk to the People" (1972), "Layers" (1973) and "Another Beginning" (1974). Last month, Resonance Records issued "Never A Dull Moment! - Live from Coast to Coast (1966-1967).

MEXICO CITY: Mexican actor Ana Ofelia Murguía, who gave voice to the character of "Mama Coco" in the popular Pixar film "Coco," has died, Mexican officials said. She was 90.

Mexico's National Fine Arts Institute announced Murguía's death Sunday without providing a cause of death.

"She leaves an enormous void on our country's sets," Culture Secretary Alejandra Frausto Guerrero said in a statement.

"Coco," which was released in 2017, brought Murguía to an international audience late in life.

But the actor had a long acting career in Mexican film and television, and on the stage. She appeared in some 70 plays and 90 movies, including 'Life Sentence' (1979) and 'The Queen of the Night' (1994).

In the animated "Coco," she voiced the soft-spoken great-grandmother of a boy discovering his family's musical history.

LOS ANGELES: Cher has filed a petition to become a temporary conservator overseeing her son's money, saying the 47-year-old's struggles with mental health issues and addiction have left him unable to manage his assets and potentially put his life in danger.

The Oscar and Grammy winning singer and actor on Wednesday filed the petition in Los Angeles Superior Court that would give her temporary control of the finances of Elijah Blue Aliman, her son with musician Gregg Allman.

Cher's petition says that Elijah Allman is entitled to regular payments from a trust fund. But "given his ongoing mental health and substance abuse issues," she is "concerned that any funds distributed to Elijah will be immediately spent on drugs, leaving Elijah with no assets to provide for himself and putting Elijah's life at risk," the petition says.

Reached through his attorney, Elijah Allman said in a phone call with The Associated Press, "I am well, and able, and of sound mind and body.

He declined to say whether he planned to oppose the petition, or give any further comment. A court-ordered conservatorship is "ur-

gently needed," Cher's filing says. A judge scheduled a January hearing on the issue.

The filing explicitly seeks to keep con-trol of Elijah Allman's finances from his wife, Marieangela King, from whom he filed for divorce in 2021.

The two remain legally married. A filing from King in October says the couple had agreed to pause the divorce proceedings and work on their marriage, but she had not seen him in person in six months.

Cher's petition says the couple's "tumultuous relationship has been marked by a cycle of drug addiction and mental health crises" and that she believes King "is not supportive of Elijah's recovery. Emails seeking comment from an attor-

ney for King and representatives for Cher were not immediately returned. (AP)



CLEVELAND, Ohio, Jan 2: New Year's resolutions are often abandoned almost as soon as they are made, but according to a psychologist from global health system Cleveland Clinic, the problem could lie in how the resolutions were formulated, rather than a perceived lack of willpower.

"To improve the chances of long-term success, individuals can carefully consider why they want to achieve a certain lifestyle goal, being as specific as possible, says David Creel PhD, who is a clinical psychologist, exercise physiologist and registered dietitian. "Regularly revisiting the 'why' behind the objective can help people keep up the momentum after the initial enthusiasm has worn off. Even if individuals have already broken their resolutions, they can reformulate these in a way that supports a successful outcome."

Once clear on their motivation, individuals can improve their chances of success by reviewing their worklife balance and committing to prioritizing self-care in the same way they would do for work success, for example.

The next step, says Dr. Creel, would be to formulate the health objective using the concept of smart goals, meaning goals that are Specific, Measurable, Action-oriented, Realistic and Time-bound. He gives the following example of goal that is smart: "I am going to get up at 7am, four days a week, to take a 30-minute walk.

Another useful approach, says Dr. Creel, could be to reframe outcome-oriented goals as behavior-oriented goals. "Sometimes people start out with an outcome goal such as wanting to lose 15kg, whereas it could be more effective to identify behaviors that need to change to achieve this goal. For example, they could aim to walk on the treadmill, rather than sitting on the couch, when watching a favorite TV show.

### Keeping up the momentum

Building in a time frame for the regular reevaluation of goals is also important, especially when overarching goals have been broken down into short-term, measurable goals, says Dr. Creel. This



individual themselves, or with support from a loved one. Other options are to join a virtual or in-person group, program or app that holds them accountable or keeps them motivated.

This has to be well thought out, so your choice of accountability partner is not counterproductive, says Dr. Creel. "For example, if you are new to exercising and de-

doesn't enjoy exercising, you could easily end up talking each other out of any activity,

Another helpful measure is the use of rewards. "In general, internal motivation is more powerful than external motivation," Dr Creel says."However, when it comes to starting something new, judicious use of rewards can be really helpful. A non-food reward, such as a massage, after a certain number of weeks can keep you motivated as you head towards achieving your overall goal.'

Setting some 'one and done' goals, such as sign-ing up to complete a 5km walkathon, could also help support the achievement of a long-term goal, says Dr. Creel. He says that by achieving several smaller, realistic goals, the person can build their confidence and motivation

#### Preparing for success

To increase their chances of success, individuals can also prepare and rehearse for temptations and challenges. "For example, if you want to commit to taking an exercise class every second day, but have previously found that some days leave you too tired to exercise you could decide beforehand that on days like these you will do at least 10 minutes of exercise, which you can easily fit in while watching a TV program," says Dr. Creel Similarly, he says, a person can identify obstacles such as moods that interfere with good intentions and then think about what has helped to overcome this obstacle in the past, for example socializing might help if someone feels down. If people normally 'stress-eat', they could anticipate this by having a prepacked calorie-controlled treat at the back of the cupboard to reach for, which helps eliminate the 'all or nothing' feeling that could lead to overeating. "If there are specific mood disorders that get in the way of success or a person is experiencing an ongoing struggle in an issue such as managing their weight, they could consider seeking support from a psychologist specialized in that area to help them to explore and manage the issue," Dr. Creel concludes.

## World population hits 8 billion on Jan 1, up by 75 million

The world population grew by 75 million people over the past year and on New Year's Day it will stand at more than 8 billion people, according to figures released by the US Census Bureau on Thursday.

The worldwide growth rate in the past year was just under 1%. At the start of 2024, 4.3 births and two deaths are expected worldwide every second, according to the Census Bureau figures.

The growth rate for the United States in the past year was 0.53%, about half the worldwide figure. The US added 1.7 million people and will have a population on

New Year's Day of 335.8 million people

If the current pace continues through the end of the decade, the 2020s could be the slowest-growing decade in US history, yielding a growth rate of less than 4% over the 10-year-period from 2020 to 2030, said William Frey, a demographer at The Brookings Institution.

The slowest-growing decade currently was in the aftermath of the Great Depression in the 1930s, when the growth rate was 7.3%

"Of course growth may tick up a bit as we leave the

pandemic years. But it would still be difficult to get to 7.3%," Frey said.

At the start of 2024, the United States is expected to experience one birth every nine seconds and one death every 9.5 seconds. However, immigration will keep the population from dropping. Net international migration is expected to add one person to the US population every 28.3 seconds. This combination of births, deaths and net international migration will increase the US population by one person every 24.2 seconds. (AP)

# New obesity drugs out of reach for millions

WASHINGTON, Jan 2, (AP): New obesity drugs are showing promising results in help-ing some people shed pounds but the injections will remain out of reach for millions of older Americans because Medicare is forbidden to cover such medications.

Drugmakers and a wide-ranging and growing bipartisan coalition of lawmakers are gearing up to push for that to change next year.

As obesity rates rise among older adults, some lawmakers say the United States cannot afford to keep a decades-old law that prohibits Medicare from paying for new weight loss drugs, including Wegovy and Zepbound. But research shows the initial price tag of covering those drugs is so steep it could drain Medicare's already shaky bank account.

Long before Oprah Winfrey and TikTok influencers alike gushed about the benefits of these weight loss drugs, Congress made a rule: Medicare Part D, the health insurance plan for older Americans to get prescriptions, could not cover medications used to help gain or lose weight. Medicare will cover obesity screening and behavioral treatment if a person has a body mass index over 30. People with BMIs over 30 are considered obese.

The rule was tacked onto legislation passed by Congress in 2003 that overhauled Medicare's prescription drug benefits.

Lawmakers balked at paying high costs for drugs to treat a condition that was historically regarded as cosmetic. Safety problems in the 1990s with the anti-obesity treatment known as withdr

ate all sorts of ailments associated with obesity that cost the system money.

The problem is so prevalent," Wenstrup said. "People are starting to realize you have to take into consideration the savings that comes with better health."

Last year, about 40% of the nearly 66 million people enrolled in Medicare had obesity. That roughly mirrors the larger U.S. population, where 42% of adults struggle with obesity, according to the Centers for Disease Control and Prevention.

### Complications

Notably, Medicare does cover certain surgical procedures to treat medical complications of obesity in people with a BMI of 35 and at least one related condition. Congress approved the exception in 2006, noted Mark

Other research, however, shows it could also save the government billions, even trillions over many years, because it would reduce some of the chronic conditions and problems that stem from obesity.

An analysis this year from the University of Southern California's Schaeffer Center estimated the government could save as much as \$245 billion in a decade, with the majority of savings coming from reducing hospitalizations and other care.

What we did is we looked at the longterm health consequences of treating obesity in the Medicare population," said the study's co-author, Darius Lakdawalla, the director of research at the center. The Schaeffer Center receives funding from pharmaceutical companies, including Eli Lilly.

The Food and Drug Administration has in recent years approved a new class of weekly injectables, Novo Nordisk's Wegovy and Eli

Lilly's Zepbound, to treat obesity. People can lose as much as 15% to 25% of their body weight on the drugs, which imitate the hormones that regulate appetites by communicating fullness between the gut and brain when people eat.

The cost of the drugs, beloved by celebrities, has largely limited them to the wealthy. A monthly supply of Wegovy rings up at \$1,300 and Zepbound will put you out \$1,000. Shortages for the drugs have also limited the supplies. Private insurers often do not cover the medications or place strict restrictions on who can access them.

Last month, a large, international study found a 20% reduced risk of serious heart problems such as heart attacks in patients market, were also fresh in their minds.

Medicaid, the state and federal partnership program for low-income people, does cover the drugs in some areas, but access is fragmented.

New studies are showing the drugs do

more than help patients slim down. Rep. Brad Wenstrup, R-Ohio, introduced legislation with Rep. Raul Ruiz, D-Calif., this year that would allow Medicare to cover the now-forbidden anti-obesity drugs, therapy, nutritionists and dietitians.

"For years there was a stigma against these people, then there was a stigma about talking about obesity," Wenstrup said in an interview with The Associated Press. "Now we're in a place where we're saying this is a health problem we need to deal with this." He believes the intervention could allevi-

McClellan, a former head of the Centers for Medicare and Medicaid Services and the FDA.

The 17-year-old law may provide a blueprint for expanding coverage of the new drugs, which mirror the results of bariatric surgery in some cases, McClellan said. Evidence showed that the surgery reduced the risks of death and serious illness from conditions related to obesity.

"And that's been the basis for coverage all this time." McClellan said.

Still, the upfront price tag for lifting the rule remains a challenge.

Some research shows offering weight loss drugs would assure Medicare's impending bankruptcy. A Vanderbilt University analysis this year put an annual price of about \$26 billion on anti-obesity drugs for Medicare if just 10% of the system's enrollees were prescribed the medication.

put a cost on covering the drugs because no one knows how many people will end up taking them or what the drugs will be priced at.

The Congressional Budget Office, which is tasked with pricing out legislative proposals, acknowledged this difficulty in an October blog post, with the director calling for more research on the topic.

Overall, the agency "expects that the drug's net cost to the Medicare program would be significant over the next 10 years."

The cost of the legislation is the biggest hang up in getting support, Ruiz said.

"When we talk about the initial cost, I often have to educate the members that the CBO does not take into account cost savings in their cost benefit analysis," Ruiz told the AP. "Taking that number in isolation, one does not get the full picture of the full economies of reducing obesity and all of its comorbidities in our patients.'

## Gauff starts 2024 with win over Liu in Auckland

### PERTH, Australia, Jan 2, (AP): Novak Djokovic endured a wrist injury to lead Serbia into a United Cup mixed teams quarterfinal showdown against host Australia.

The world No. 1 was troubled by his right wrist during practice on Tuesday morning and he received intense treatment from his physio.

Djokovic was cleared to play his singles match against Jiri Lehecka later in the day, and it was just as well given that Wimbledon champion Marketa Vondrousova defeated Olga Danilovic 6-1 3-6 6-3 to give the Czech Republic a 1-0 lead.

Djokovic looked on track for an easy victory against Lehecka while leading by a set and 3-1. But with his wrist troubles growing, Djokovic started making unforced errors. He took a medical timeout after losing the second-set tiebreak and came out

strongly with a double break in the third set to win 6-1, 6-7 (3), 6-1.

"I managed to play through," Djokovic said. "It's not the first time or the last time, these things happen. You just have to manage. You have to find a solution and thankfully I managed to finish the match."

There was confusion after the match as to whether Serbia had done enough to qualify for the quarterfinals.

Officials initially said that even if Serbia lost the mixed doubles and the tie, it would still make the quarterfinals as the best second-place team in Perth. But organizers later clarified that Serbia would be out if it lost the mixed doubles in straight sets.

Djokovic opted out of the mixed doubles, most likely thinking Serbia had already qualified. Serbia still won 4-6, 7-6 (2), 10-8.

Serbia topped Group E, and will take on Group C winner Australia on Wednesday in a quarterfinal in Perth. Poland will face China in the other Perth quarterfinal.

In Sydney on Tuesday, Chile defeated Greece 2-1.

Stefanos Tsitsipas - runner-up at last year's Australian Open - was scheduled to face Chile's Nicolas Jarry in SYDNEY, Jan 2, (AP): The leadup to the third test between Australia and Pakistan at David Warner's home Sydney Cricket Ground was always going to be about the opening batter himself playing his final test in the sport's traditional format.

Warner has helped to hype what amounts to a match with little really on the line for the home side - Australia has already clinched the three-test series with victories in Perth and Melbourne. The visitors still have something to play for - the last time Pakistan beat Australia in a test Australia was 1985 - at the SCG.

Warner announced during a New Year's Day news conference that he will also add one-day internationals to his retirement list. But in typical Warner fashion, he said he'd make a comeback at the 2025 ICC Champions Trophy if asked.

He said the time was right to conclude his ODI career following Australia's recent World Cup triumph in India, where he was the champion team's leading run-scorer.

Warner will continue to play Twenty20 cricket for Australia, at least until

T20 World Cup in the United States and Caribbean in June.

"It was a (ODI) decision that I was very, very comfortable with," the 37-year-old Warner told Australian Associated Press. "To win in India, from where we were, was absolutely amazing."

Australia lost two early games in the group stage of the World Cup, denting its title hopes, but Warner said it helped inspire the squad.

"The bond just got stronger with each other and it's not by fluke or by chance that we were able to get to where we were," he said.

In 111 test matches Warner has accumulated 8,695 runs at an average of 44.58, including 26 centuries and a career-high score of 335 not out, scored against Pakistan in 2019.

Warner retires from the 50-over format as the sixth-highest run-scorer in Australian ODI history, having scored 6,932 runs from his 161 matches, and a two-time World Cup winner. His 22 ODI centuries are the second-most by any Australian ODI player, behind only Ricky Ponting, who made 29 in

105 more innings than Warner played. The Champions Trophy, set to be played in Pakistan next year, is among the only pieces of silverware missing from Warner's resume; the last time Australia won it in 2009, he was not yet a certainty for selection in the starting side.

"If I'm playing decent cricket in two years' time and I'm around and they need someone, I'm going to be available," he said.

Warner said the decision to quit ODIs would create more opportunities to play franchise cricket overseas, including in the United Arab Emiratesbased ILT20. He is also eager to remain in Australia's Big Bash League after his contract with the Sydney Thunder

expires at the end of this season.

Warner will have a commentary role with Fox Sports television later this year but beginning Wednesday he will again open the batting for an Australian lineup aiming for a test sweep of Pakistan.

On Tuesday, Warner took to social media to plead for the return of his "baggy green" test cricket cap which was in a bag that went missing in transit between Melbourne and Sydney this week.

"It's sentimental to me. It's something I'd love to have in my hands walking out there this week," Warner said in the post on Instagram.

Australian selectors have confirmed there'll be no change from the starting XI that won by 79 runs in Melbourne.

Pakistan, meanwhile, decided to rest ace fast bowler Shaheen Shah Afridi and drop opening batter Imam-ul-Haq for the third test.


With World Test Championship points to play for, Pakistan made the call to leave out Afridi and to call in spinner Sajid Khan. First-choice spinner Abrar Ahmed remained on the sidelines because of a right leg injury.

Captain Shan Masood had earlier said Pakistan was keen to play two spinners in Sydney.

"We think that it might turn in Sydney. So we want to give ourselves the best possible opportunity," Masood said. "We've kept Abrar on the Australian tour. They have looked after him very well. His rehab process has been going very well. But we have to be absolutely sure he is close to 100% ftt"

The call to drop Imam comes after the opener made scores of 62, 10, 10 and 12 in the first two tests. In his place, 21-year-old Saim Ayub will make his test debut.

In an expecting change to the fielding positions, Pakistan warmed up with Babar Azam in the slips on Tuesday and Abdullah Shafique not featuring in the cordon. Shafique put down three chances at first slip in the opening two tests.

In Auckland, New Zealand, U.S. Open champion Coco Gauff started her 2024 season and her defense of the Auckland Tennis Classic title Tuesday with a rusty-at-times 6-4, 6-2 win over American compatriot Claire Liu.

Gauff used her powerful forehand well but took time to find her range, over-hitting at times in the first set.

She raced to an early 4-0 lead then dropped serve, served for the first set at 5-2 and lost serve again to love before composing herself to overcome a tenacious performance by Liu.

Gauff defeated Aryna Sabalenka in the U.S. Open final 2-6, 6-3, 6-2 for her first major title last year. On Tuesday, Gauff mostly stuck to the baseline while Liu came more often and effectively to the net. But as Gauff settled in and found her service rhythm, she took the second set more convincingly in 35 minutes, the match in 82 minutes.

Emma Raducanu, the 2021 U.S. Open champion, was given a thorough workout in her first match since April before beating Romanian qualifier Elena-Gabriela Ruse 6-3, 4-6, 7-5.

Raducanu had begun to feel the effects of wrist and ankle injuries when she played in Auckland last year. In April she bowed to the inevitable and broke from the tour for surgery and rehabilitation.

She couldn't have asked for a more searching test of her fitness than she received from Ruse who kept her on court for 2 hours, 25 minutes.

Raducanu took the first set comfortably with a single break of serve. But from then on Ruse made her fight for every point.

Ruse swung hard, forcing Raducanu on the defensive and had three service breaks to two in taking the second set. Raducanu served for the match at 5-2 and 5-4 in the deciding set but Ruse broke back on both occasions. The Briton served again for the match at 6-5 and, with the help of a timely ace, prevailed on her fourth match-point.

## Purdue faces big tests in Big Ten, with Maryland, Illinois coming up

WASHINGTON, Jan 2, (AP): Purdue should be accustomed to playing high-ly ranked opponents by this point of the season.

The top-ranked Boilermakers rolled through Tennessee, Gonzaga and Marquette in consecutive days to win the Maui Invitational when all three of them were among the top 11 teams in the country. A few weeks later, they took down Arizona for their first win over a team ranked No. 1 since beating the Wildcats on Nov. 25, 2000.

Now, they will face ninth-ranked Illinois on Friday night in one of the early showdowns in Big Ten play.

Purdue (12-1), which also faces Maryland on Tuesday night, has already dropped a conference game to Northwestern, and another loss this week would put coach Matt Painter's crew in catch-up mode before they even hit mid-January.

"We still haven't won a road game and we're going into a beehive where they didn't lose in the Big Ten last season," Painter said of the Terps (9-4), who have won six straight games. The second quarter ended in a 39-39, with Alexander Al-Ghais leading the scoring for Kuwait. ## Al-Kuwait look to bounce back after draw

KUWAIT CITY, Jan 2: The twelfth round of the Zain Premier League concludes today with two matches. In the first encounter, Al-Nasr will face Khaitan at Ali Sabah Al-Salem Stadium at 5:35 pm, while Al-Kuwait will take on Al-Shabab at Mohammed Al-Hamad Stadium at 8:00 pm.

Al-Kuwait (27 points) is eager to regain its winning streak after being held to a draw by Al-Salmiya in the last round (2-2), resulting in a loss of two crucial points and a drop to third place in the league standings.

The coach of the Tunisian team "Al-Abyad," Nabil Maal-

oul, recognizes the critical nature of the situation and the necessity of avoiding any further point loss to prevent the gap from widening with the top two teams. Such a scenario could jeopardize their chances of securing the title for the third consecutive season. In recent training sessions, Maaloul emphasized capitalizing on opportunities and organizing the team's defensive strategies, addressing the issues that led to the draw against Al-Salmiya.

On the other side, Al-Shabab (11 points) is determined to halt the recent point losses, having failed to secure a victory or draw in the last four rounds. The team aims to restore its reputation against Al-Kuwait, a team it defeated 4-1 in the initial stages of

the competition.

In the second clash, Al-Nasr (22 points) aims to replicate its earlier victory over Khaitan, having triumphed with two goals in the first encounter. Simultaneously, the team seeks to maintain its pursuit of the leading teams and compete for an elevated position in the league. Al-Nasr's coach, Zaher Al-Ad-

wani, hopes to build on the positive results of the season, particularly in the last three matches, where they secured 7 points by

defeating Al-Shabab and Kazma 1-0 and 2-0, respectively, and drawing 1-1 with Al-Salmiya. These results have placed Al-Annabi in the fourth position.

Conversely, Khaitan's Romanian coach, Florin Matrock, is eager to secure his first victory with the team and accumulate nine points. Since taking over from Ibrahim Obaid, Matrock has faced three defeats, losing to Al-Arabi 0-4, Al-Fahaheel by a single goal, and Al-Qadsia in a clean sweep.

## Four players omitted as Mancini unveils Saudi Arabia final 'roster' for Asian Cup


RIYADH, Jan 2: The Saudi national football team's coach, Roberto Mancini, revealed the final roster for the upcoming Asian Cup in Qatar this month. This announcement came after the exclusion of four players from the initial squad he had disclosed last Saturday.

The omitted players are goalkeeper Mohamed Al-Yami, midfielder Ali Hazazi, and strikers Khaled Al-Ghanem and Mohamed Maran. The confirmed squad consists of 26 players, with Nawaf Al-Aqidi, Raghed Najjar, and Ahmed Al-Kassar as goalkeepers. The defensive lineup includes Hassan

Kadish, Aoun Al-Saluli, Ali Al-Bulaihi, Ali Lagami, Hassan Al-Tambakti, Saud Abdul-Hamid, Fawaz Al-Saqour, and Abdullah Al-Khaybari. The midfield comprises Abdul-Ilah Al-Ma-liki, Mukhtar Ali, Faisal Al-Ghamdi, Eid Al-Mawlid, Salem Al-Dosari, Abbas Al-Hassan, Nasser Al-Dosari, Muhammad Kanno, and Sami Al-Naji. The attacking options feature Fahd Al-Mawlid, Ayman Yahya, Abdul-Rahman Gharib, Firas Al-Braikan, Abdullah Radif, and Saleh Al-Shehri.

During their current training camp in Doha, the team is scheduled to play three friendly matches, starting with Lebanon tomorrow, followed by a match against the Palestine national team five

days later, and concluding with a fixture against Hong Kong on January 10.

In the preceding three stages of preparation, Saudi Arabia engaged in six friendly matches against teams such as Venezuela, Bolivia, Costa Rica, South Korea, Nigeria, and Mali. Additionally, Al-Akhdar participated in two matches during the first round of the second phase of the Asian qualifiers for the 2026 World Cup, facing Pakistan and Jordan.

As a three-time Asian champion, Saudi Arabia is set to compete in Group 6 of the Asian Cup, alongside Oman, Kyrgyzstan, and Thailand, with the tournament kicking off on January 12.

## Jenni 'testifies' in assault case

MADRID, Jan 2, (AP): The Spanish player assaulted by the soccer president at the Women's World Cup final appeared in court on Tuesday to testify against the former official.

Jenni Hermoso was at the Madrid court to give her version of the kiss by Luis Rubiales following Spain's victory over England in the final in Sydney in August.

The incident sparked outrage across the soccer world and ignited one of the worst crises in the history of the sport in Spain. It also led to a boycott of the national team by the World Cup-winning players, and to the eventual resignation of Rubiales despite his denial of wrongdoing .

The testimony was expected behind close doors. Spanish media said Hermoso asked the judge to keep her court appearance as pri-vate as possible. She arrived wearing a grey coat and waved to journalists before entering the court through one of its main entrances along with her lawyers.

Spanish state prosecutors accused Rubiales of assault and coercion, alleging he tried to convince Hermoso and her relatives to publicly downplay his action. The judge is also hearing tes-

timony from other World Cupwinning players, coaches and federation officials, before deciding whether to start a trial.

Rubiales previously denied wrongdoing to the judge who imposed a restraining order on him not to contact Hermoso

The 33-year-old Hermoso, the record scorer for Spain's women's team, said last vear she received threats in the fallout from the incident, though she did not elaborate.

Salah scores 2 after changing boots

LIVERPOOL, England, Jan 2, (AP): Mohamed Salah headed off to the Africa Cup of Nations on the back of a starring role for Liverpool in their 4-2 win over Newcastle that opened up a three-point lead in the **English Premier League.** 

An individual performance that started with his latest failure from the penalty spot ended with Salah scoring Liverpool's first and last goals and having a hand in the other two for his team in a chaotic game in wet and wild conditions at Anfield. All of the goals came in an end-to-end second half.

The league pauses for the FA Cup and then a winter break lasting much of the rest of January with Liverpool looking the team most likely to stop Manchester City winning an unprecedented fourth straight top-flight title. City are in third place, five points behind Liverpool - and two behind Aston

Villa - with a game in hand. Salah, who could be missing until mid-February depending on how far Egypt advances in the Africa Cup, could be the player to lead Liverpool to a record-tying 20th league champi-onship. He has 14 goals for the campaign, tied for the most with City's Erling Haaland.

"I said to myself, 'Are you going to leave for the national team with that performance? Not really," Salah said, referring to his penalty failure in the 22nd minute. "I just had to step up."

Salah said he changed his boots at halftime. "When I felt like it was playing with my head, I was like, 'OK, I change.' Make my mind calm, focus on the game.'

Curtis Jones and Cody Gakpo scored the other goals for Liverpool in howling rain as Newcastle conceded 34 shots. Eighteen came in the first half, the most in the league this season. Newcastle manager Eddie Howe is

coming under pressure with his team in ninth place, out of Europe completely and also recently losing in the League Cup. The Saudi-controlled northeast club equalized through Alexander Isak and made it 3-2 through Sven Botman's header at a corner but was totally dominated by Liverpool.

"I know in time we will get the results we need," Howe said after Newcastle's seventh loss in their last eight games.

"I can always see a light at the end of the tunnel if the players continue to give everything they've got."

Salah had his first penalty saved by Martin Dubravka after Luis Diaz was tripped by Botman. That was his fourth failure from the spot in his last nine attempts

## Michigan sets up championship showdown with Washington

PASADENA, Calif., Jan 2, (AP): Blake Corum rushed for a 17-yard touchdown on the second snap of overtime, and top-seeded Michigan advanced to its first College Football Playoff championship game with a 27-20 victory over fourth-seeded Alabama in the Rose Bowl on Monday.

Michigan's defense ended only the second overtime game in the 110 editions of the Rose Bowl when Alabama quarterback Jalen Milroe was emphatically stopped as he attempted to sneak up the middle on fourth down from the Michigan 3.

Coach Jim Harbaugh's Wolverines (14-0) will play for their school's first national title since 1997 against Wash ington on Monday night in Houston, but only after a late comeback and a dramatic finish Roman Wilson made a 4-yard TD catch with 1:34 left in regulation for the Wolverines, who hadn't scored in the second half until that gritty 75-yard drive led by J.J. McCarthy. Corum needed only two snaps to score in the first overtime period. Milroe found Jermaine Burton at the Michigan 3 on third-and-goal in OT, and Alabama turned to its quarterback on the final play call. But, Milroe ran into a waiting Michigan defense and was stopped 2 yards short of the goal line.

No. 3 Texas (12-2) had four shots at the end zone after getting to the UW 12 with 15 seconds left, but Quinn Ewers missed on the last three. The final throw was a fade to a well-covered Adonai Mitchell that sailed long.

In Texas' first CFP appearance and final football game as a member of the Big 12 before it goes to the Southeastern Conference, Ewers passed for 318
