When the Council of Ministers flatters fanatic parliamentarians with a set of laws that make the country appear to be following in the footsteps of the Taleban, or when some of the retrogressive parliamentarians defend saboteurs and those who adhere to destructive ideology or work to insinuate themselves through the channel of other components, while the successive governments remain silent about them. this definitely means only one thing, which is a change in the social nature of the country. This is a historical crime against Kuwait.

The insistence on closing the country based on the need in the hearts of some short-sighted people, and the issuance of laws that led to expelling expertise abroad under the slogan of reforming the demographic composition without appropriate study, means obstructing the economic cycle and restricting its ability to move.

When the Bedoun issue becomes a dilemma because there are those who do not want to solve it for personal motives and considerations, this means seeking to plant a social, economic, and security minefield, the mines of which explode every day.

Yes, this government has many issues that cannot be postponed, as every day that passes without solutions means adding more fuel to the fire of administrative, economic, and ministerial failure.

In other countries, residents, for example, are three times more than citizens. They generate a lot of revenue from it because they add value. However, Kuwait is a closed country. When the family visa was opened, we saw the reactions of economists, traders, and other experts, as these people will spend their money here, and their overseas transfers will not increase.

Likewise, when a citizen complains about potholes on the roads and the high cost of repairing his car due to the lack of restoration of the streets and with no one taking any action, this indicates the extent of the failure of ministers and their ministry staff, because the employee sees his job as an acquired right, and no one will hold him accountable, because he is convinced his back is covered by a parliamentarian or an influential person.

This also is an indication that corruption has become a general phenomenon, and it cannot be eliminated unless there is a strict decision to hold "head of the snake" accountable in the ministry in order to make things right.

In order for this government to get rid of the corrupt legacy, it must confront without hesitation, fear, shame or complacent, and put things in their right place.

The reform workshop begins by amending or abolishing backward laws, which cost the State a lot of time and money, such as banning co-education, closing the country, and other laws that brought harm to the country.

COLUMBIA, S.C.: US President Joe Biden said Sunday that the U.S. "shall respond" after three American troops were killed and dozens more were injured in an overnight drone strike in northeast Jordan near the Syrian border. Biden blamed Iran-backed militias for the first U.S. fatalities after months of strikes by such groups against American forces across the Middle East since the start of the Israel-Hamas war.

Biden, who was traveling in South Carolina, asked for a moment of silence during an appearance at a Baptist church's banquet hall. (AP)

RIYADH: The Saudi Ministry of Foreign Affairs emphasized on Monday the critical need for enhancing review mechanisms and conducting thorough investigations into allegations leveled against personnel of the United Nations Relief and Works Agency for Palestine Refugees (UN-RWA).

The Saudi Ministry of Foreign Affairs confirmed in a statement its commitment to investigating these allegations, underscoring the humanitarian efforts of UN-RWA personnel. (KUNA)

ISTANBUL: The Islamic State group has claimed responsibility for an attack on a Roman Catholic church in Istanbul during a Sunday Mass that killed one person

The extremist group said in a statement late Sunday on Aamaq, the media arm of the militant group, that it "attacked a gathering of Christian unbelievers during their polytheistic ceremony" inside the Santa Maria Church in the Buyukdere neighborhood in Istanbul. (AP)

Domestic workers recruitment

begins under new fee structure

KUWAIT CITY, Jan 29: Acting General Manager of Al-Durra Labor Recruitment Company Muhammad Fahd Al-Zoubi said the implementation of contracts for the recruitment of domestic workers has started based on the fees set by the Ministry of Commerce and Industry, including air tickets, reports Al-Anba daily.

In a statement to the daily, Al-Zoubi confirmed this step was taken with the support and guidance of the company's Board of Directors; indicating that the decision was carefully considered. He pointed out the ministry is a governmental body that takes decisions based on technical studies and bilateral agreements, and in coordination and consultation with other government agencies concerned with labor recruitment; thereby, setting fair fees.

He stressed that the first and last goal is to reduce the burden on the citizens in recruiting a domestic worker, especially when the fees reached shocking levels as some took advantage of the citizens' domestic manpower needs, particularly before the holy month of Ramadan.

Blueprint unveiled

Kuwait's health-centric cities take shape in MoH workshop

KUWAIT CITY, Jan 29: Dr. Amal Al-Yahya, the Head of the Kuwait Healthy Cities Office at the Ministry of Health (MoH), provided insights into the continuous progress of the "Healthy Cities" initiative during a workshop on "Review for Healthy Cities" held on Monday.

Dr. Al-Yahya emphasized the commitment to the initiative through applied strategies, ensuring alignment with updated plans and the establishment of these health-centric cities

One key aspect highlighted by Dr. Al-Yahya was the signing of cooperation agreements with more companies, resource mobilization efforts, and the initiation of various health-related initiatives. She underscored the importance of staying abreast of national, regional, and global trends, with the office working diligently in recent years to formulate a national strategy for healthy cities.

The workshop served as a platform to review the features and objectives in creating a national strategy for healthy cities spanning from 2023 to 2030. Dr. Al-Yahya stressed the significance of enabling both currently registered healthy cities and those aspiring to join the initiative to implement development plans in coordination with the current applied approaches.

Furthermore, Dr. Al-Yahya delved into the methods used in preparing the strategies, including the components of the package of new initiatives. She emphasized the need to achieve health development standards for healthy cities in alignment with the national strategy.

Dr. Al-Yahya reiterated the vital importance of creating and implementing healthy cities within various areas in Kuwait. Beyond mere accessibility to medical facilities, these cities

are envisioned to enrich the environment, stimulate economic growth, and foster national values within the community, ultimately promoting the highest level of health and well-being among Kuwaiti society members.

In addition to Dr. Al-Yahya's insights, Dr. Maitham Husain, Director of the Planning and Development Department at the MoH, highlighted the significance of the four-day workshop. He emphasized the acquisition of skills and preparation for Kuwait's fourth development, aligning with the government's current legislative session action plan. Dr. Husain also mentioned the Ministry of Health's strategic vision in plan, in line with the aspirations of the Minister of Health, Dr. Ahmad Al-Awadhi.

KUWAIT CITY, Jan 29: In a special session of the National Assembly held Monday upon the request of the government, HH the Prime Minister Sheikh Dr Mohammad Sabah Al-Salem Al-Sabah took the constitutional oath as Deputy Amir, as well as the ministers who are not members of the Assembly in accordance with Article 91 of the Constitution.

Article 91: "Before taking up his functions at the Assembly or at its Committees a member of the National Assembly shall, at a public meeting of the Assembly, take the following Oath: 'I swear by God Almighty to be loyal to the Amir, to respect the Constitution and the laws of the State, to defend the people's liberties, their interests and their properties, and to perform my duties faithfully and sincerely.

National Assembly Speaker Ahmad Al-Saadoun inaugurated the special session early, which started with the reading of the Amiri Orders and Decrees on the formation of the government as per Article 68 of the Assembly's bylaw; including the Amiri order approving the resignation of HH the former Prime Minister Sheikh Ahmad Nawaf Al-Ahmad Al-Jaber Al-Sabah issued on Dec 20, 2023; Amiri order issued on Jan 4, 2024 to appoint Sheikh Dr Mohammad Sabah as Prime Minister and assign him to form the new government; Amiri Decree number 1/2024 issued on Jan 17, 2024 to approve the formation of the new government: Amiri order issued on Jan 24, 2024 to appoint Sheikh Dr Mohammad Sabah as Deputy Amir in the absence of HH the Amir Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah until the Crown Prince is named; Amiri Decree number 2/ 2024 to assign Deputy Prime Minister, Minister of Defense and acting Minister of Interior Sheikh

KUWAIT CITY, Jan 29, (KUNA): His Highness the Amir Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah is scheduled to visit the brotherly Kingdom of Saudi Arabia on a state visit Tuesday, January 30, that will be marked with a scheduled

summit meeting with the Custodian of the Two Holy Mosques King Salman Bin Abdulaziz Al-Saud.

His Highness the Amir's visit is the latest step by the top leadership for bolstering further the close relations between the two

brotherly Gulf countries, bonded with family affiliations, geographic proximity, joint history and destiny

The mission falls within the framework of regular coordination between the two neighboring countries' leaderships regarding regional and international issues

Leaders of the two Gulf States regularly reciprocate visits. His Highness the Amir Sheikh Mishal's last visit to the Kingdom was on June 1, 2021, when he was the State of Kuwait's Crown Prince. He went there again on October 25, 2021, for partaking in the first Middle East Green Initiative (MGI) Summit, followed with another one on, December 14, heading a delegation at the 42nd session of the Supreme Council of the Arab Gulf Coop-

eration Council (GCC). On July 16, 2022, His Highness Sheikh Mishal Al-Ahmad visited Saudi Arabia to address a speech at Jeddah Security and Development Summit, followed with another mission, on December 8, participating in the 43rd session of the GCC Supreme Council, the GCC-China Summit and the Arab-China Summit, hosted by Riyadh.

On May 19, 2003, His Highness Sheikh Mishal Al-Ahmad went to the Kingdom to head the State of Kuwait's delegation at the Arab Summit that convened in the Red Sea city of Jeddah. He went there again on July 19 to take part in the 18th consultative meet-ing of the top GCC leaders and the Gulf Summit with Central Asia States.

On October 20, 2023, His Highness Sheikh Mishal Al-Ahmad was in the Kingdom, leading the State of Kuwait's delegation at the Gulf-ASEAN summit in Riyadh, and he was there on November 11 chairing the Kuwaiti delegation at the Arab-Islamic Summit, organized in Riyadh.

On December 11, 2022, Kuwait and Saudi Arabia signed a memorandum of understanding (MoU) to develop the offshore Al-Durra gas field with a projected daily output of one billion cubic feet of gas and 84,000 barrels of liquid gas a day.

On September 26, 2023, the Saudi Cabinet approved the Kuwait-Saudi accord for establishing joint railways.

In aerial transports, on May 14, 2023, Kuwait Airways signed a code-sharing deal with Saudia (formally known as Saudi Arabian Airlines).

At the parliamentary level, cooperation between Kuwait's National Assembly and the Saudi Shura Council has been growing through the joint friendship committee, reciprocal visits and coordination with international and external quarters.

In May 2023, a Saudi delegation visited Kuwait for coordination against cross-border trafficking. And in tourism. A Saudi delegation came to Kuwait in September 2022 to promote tourist attractions in the Kingdom. During the 2023, hajj season, Kuwait staged 75 flights for transporting the devotees to sacred sites in the Kingdom.

Meanwhile, Kuwait's Ambassador to the Kingdom of Saudi Arabia Sheikh Sabah Nasser Sabah Al-Ahmad Al-Sabah stressed on Monday the strength of fraternal relations between Kuwait and Saudi Arabia and their leaderships.

KUWAIT CITY, Jan 29: According to informed sources, the Minister of Public Works and Minister of State for Municipal Affairs Dr. Noura Al-Mishaan recently met with the leaders of the ministry and the Public Authority for Roads and Transportation (PART), and discussed ways to develop a quick plan to correct the defects and address dangerous sites on Abdali, Salmi and Kabd roads.

They explained that Minister Al-Mishaan instructed the leaders of the Ministry of Public Works and PART to carry out urgent maintenance work on the dangerous sites on the three roads such as potholes, flying gravel, and subsidences, and send a report in that regard through the concerned ministry teams in the Road Engineer-

ing Sector and PART. Minister Al-Mishaan plans to hold subsequent meetings to follow up the plan that will be prepared by the leaders, and the actions that will be taken on the ground to overcome all obstacles that will face this plan. She said, "The three roads are con-

ous accidents due to the deterioration of their conditions, as reported on social media. These roads have areas that have not witnessed maintenance for more than 20 years, which has led to a large number of potholes, flying gravel, and subsidences that put lives and properties at risk.

Earlier, the Minister Dr. Noura Al-Mishaan, accompanied by the acting Director of the Public Authority for Roads and Transportation (PART) Khaled Al-Osaimi and a number of PART's engineers, took a tour recently to follow up the repair work being implemented by PART on King Fahad Expressway and the Sixth Ring Road.

According to informed sources in the Ministry of Public Works, the minister's tour comes within the framework of a series of tours that she is conducting to learn the latest developments in the projects being implemented by the ministry and PART, especially the contracts for road maintenance projects, as it is the most important file on the ministry's table.

The minister gave direct directives on the necessity of accelerating the pace of completion of road projects and removing all obstacles facing these projects, especially maintenance projects and the development and modernization of the country's road network

Moreover, the former prime minister, His Highness Sheikh Ahmad Nawaf Al-Ahmad Al-Sabah, visited the Kingdom in September 2022, on the first such mission abroad since taking the office, signaling

Speaking to KUNA on the occasion of the planned visit to the Kingdom by His Highness the Amir (of Kuwait) Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah, the ambassador affirmed the two countries' support for peace and stability in the region and the world, noting also their common vision for the two peoples' prosperity.

sary to stop some representatives and citizens from issuing statements in this regard.'

"It is known, and even self-evident, that whoever seeks to represent the people in any parliament should know the Constitution well. He must be familiar with the laws, or has a team of advisors or legal experts. In the end, he is a legislator. The legislator does not throw sand and does not enact a law on his own or according to his mood. He does not listen to those in his Diwaniya and then propose a law. As long as some representatives do not understand their limits when it comes to a matter that is the core of the powers of the head of State, in which no one has the right to interfere, we know why Kuwait has fallen behind over the past three decades.

"When some representatives issue statements or post on X (formerly Twitter) about who they think should be given the Crown Prince post and they do not have any authority over this matter, and in fact, no one consulted them about it, we must know that majority of the laws issued since 1992 till date are the reasons behind the frightening decline that Kuwait has been suffering from, because they drafted laws without knowledge or experience. One of them even spent 30 years in the prosecution.

"It is unfortunate that the legal cul-

constitutional rights of citizens, and the duties of representative towards the people and other authorities. "Without a doubt, there is a big

problem with regard to parliamentary work and how the Constitution is utilized to deal with the issue of His Highness the Amir's choice of the Crown Prince. For this reason, some representatives should read Article Four of the Constitution. They must understand its purpose and how the founders of the Constitution sought to explain it in great detail, because they realized from the beginning that Kuwait is a State of institutions and it has an Amir whom no one disputes with on the selection of the Crown Prince.

"Rather, the article specifies the jurisdiction of the representatives, and that the appointment of the Crown Prince must be through an Amiri order. The matter is known in the language, as well as the meaning of an order. The same article stipulates that 'his appointment shall be through an Amiri order based on the recommendation of the Amir and a pledge of allegiance from the National Assembly that takes place in a special session, with the approval of the majority of the members.

In the event that the appointment is not made in the aforementioned manner, the Amir shall recommend at least three of the descendants entitled to the succession of the Crown Prince and the Assembly shall pledge allegiance to one of them as Crown Prince.

"Did those involved in this matter realize that they are attacking the Amir's powers? Do they know that the law punishes them for that? If they know, it is a disaster. If they do not realize it, then the disaster is greater. The question remains: Why this impudence?'

KUWAIT CITY, Jan 29, (KUNA): The Ministry of Awqaf (Endowment) and Islamic Affairs announced on Monday that next Friday prayer's sermons would be devoted to talk about national unity and tolerance.

The Ministry's spokesman, Salman Al-Kandari told KUNA that the Minister of Justice and Minister of Awqaf and Islamic Affairs, Faisal Al-Gharib, directed officials to make the speech about the concept of national unity and tolerance.

Al-Kandari explained that this directive by the Ministry of Awqaf and Islamic Affairs comes in order to consolidate the concept of tolerance and acceptance of others.

He added that the tolerance that the Kuwaiti society has achieved is derived from following the teachings of the Holy Quran and the Sunnah of Prophet Muhammad (Peace Be Upon Him), which leads to supporting national unity and achieving peace and security among society.

Human rights

Core concern: Kuwait is committed to protect human rights in the most exemplary way possible, a diplomat said on Sunday, citing the matter as among the nation's core concerns.

These efforts primarily entail the works of a national committee tasked with compiling a routine report on measures Kuwait has taken to protect human rights on a local level, Kuwaiti Assistant Foreign Minister for Human Rights Affairs Sheikha Jawaher Al-Sabah told a workshop co-organized by the foreign ministry and the UN's human rights office.

On the purpose of the workshop, the Kuwaiti diplomat said it comes in line with national commitment to human rights protection, which includes pushing further a close rapport with the UN's human rights office as part of efforts to hone skill development on the matter.

Echoing the Kuwaiti diplomat's sentiments, the UN's High Commissioner for Human Rights in the Middle East and North Africa Mazen Shaqoura said such workshops revolve around national efforts to protect human rights, in addition to looking into regional experiences on dealing with such a pressing issue.

He went on to express hope that such initiatives would be instrumental in boosting awareness on the magnitude of the matter, in addition to developing the skills needed to ensure maximum human rights protection, he added.

'Kuwaiti-Saudi ties deep-rooted'

RIYADH, Jan 29, (KUNA): Kuwaiti-Saudi relations have traversed through pivotal and historical points over the course of 130 years, passing over stepping-stones that solidified and deepened relations between leadership and people alike.

The evocative words of late Saudi King Fahad bin Abdulaziz Al-Saud during Iraqi occupation of Kuwait, "Either Kuwait is restored, or Saudi is gone with it," still reverberate through the hearts and minds of Kuwaitis.

The exceptional nature of these share bonds is rooted all the way back in 1891 when Amir of Kuwait at the time Sheikh Mubarak Al-Sabah (Mubarak Al-Kabeer) hosted Imam Abdulrahman Al-Faisal Al-Saud and his son King Abdulaziz bin Abdulrahman in Kuwait, standing by their side until they regained Riyadh in 1902.

This took Kuwaiti-Saudi relations beyond the point of neighboring nations, to a relationship of kinship and joint destiny in the face of challenges and mitigating circumstances.

The relationship between Sheikh Mubarak and Imam Abdurrahman was passed down the line of successive Kuwait Amirs and Saudi Kings, and further solidified bonds.

In 2018, during the reign of late Kuwait Amir Sheikh Sabah Al-Ahmad Al-Jaber Al-Sabah, and King Salman bin Abdulaziz Al-Saud, the Saudi-Kuwaiti Coordination Council was established with joint vision of augmenting cooperation, and ensuring sustainability of ties, in line with Gulf Cooperation Council objectives.

The Council sets out to reinforce an integrated economic system, find innovative solutions for the utilization of resources, and build an efficient cohesive educational system founded on strength points of both nations.

In June 5 of 2021, the first council meeting was held as per directions of late Amir Sheikh Nawaf Al-Ahmad Al-Jaber Al-Sabah and Saudi King Salman bin Abdulaziz Al-Saud.

The two nations are aspiring towards a more expanded trade exchange with official data showing that in 2019 it reached SAR 39.8 billion (approx. USD 10.61 billion), with Saudi exports to Kuwait at SAR 83.7 billion (approx. USD 22.32 billion), and imports at SAR 56.1 billion (approx. USD 14.96 billion).

The countries' leadership have regularly reciprocated visits over the past few years for coordination on various issues of common concern, latest of which was His Highness the Amir's Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah, then Crown Prince, visit to Riyadh on 11 November 2023 heading Kuwaiti delegation at the Joint Arab-Islamic Extraordinary Summit.

"It is also possible to develop general questionnaires to explore opinions, analyze them later and extract commonalities between them. Indeed, the issue does not stop there, as it rather takes an encouraging dimension by granting a lucrative financial reward accompanied by honoring deep and distinguished contributions. In this way, we actually change the approach in dealing with the government work

'This often causes many people to be shocked by some people, whom they previously had an idea about, which may reach a stage of contradiction with the real picture, after a few minutes of sitting with them and talking to them.

"According to the noble speech, the silence of the two authorities regarding this absurdity is painful. All of this means there are deals to exchange interests and benefits between the two authorities! 'This is just a small part of the supreme speech. Did His Highness the Prime Minister meet the members, describe them as his partners in development and state that his history is not a reason for dissolving the Assembly? This entails his adherence to the current composition of the Assembly, which the Amiri speech described as harming the interests of the country and its people. "The supreme leadership is the constitutional head of the three authorities, and the government is supposed to be the first to implement the supreme directives and act upon them. Now, they are talking about the work program of the new government that will be presented to the Assembly after taking the oath. The matter is with the concerned authorities, and I do not care much about the outcome of the investigation, as the matter was not a surprise to everyone who repeated his warning to those concerned, on dozens of occasions and through articles, of the danger of the decline of society, and the state in turn, towards religious extremism and the continued move away from the civil state, which we have known for a long time. Our awareness of life! The intellectual and sectarian thought,

the Salafist and the Brotherhood, and by extension the Shiite, is taking root ev-

ery day, gaining more space in the minds of the youth, and spewing its terrorist, sectarian and racist poisons in various religious gatherings, without caring about the challenges the nation faces, internal and exter-

nal, and the problems it suffers from beyond the power of any person.

But the minister's decision to be firm relaxed after a few hours, and laxity returned to its previous state, and this is further evidence of the strength of the centers of extremism and backwardness.


We also find that all state decisions related to employment include exceptions, for the lion's share of the category of imams and muezzins, to whom memorizers of the Qur'an have recently been added!!







Demand for food commodities increases

MoCI keen to monitor commodity prices

KUWAIT CITY, Jan 28: According to informed sources, the relevant authorities in the Ministry of Commerce and Industry are working to monitor the prices of food commodities, especially the price of onions, in order to prevent the rise in prices, considering the approach of the month of Ramadan when the demand for food commodities increases.

They revealed that a team from the management of the technical staff in the control and consumer protection sector of the Ministry of Commerce and Industry made a number of visits to cooperative societies and supermarkets to follow up on the goods and food items and check the prices of vegetables and their availability to consumers. The sources indicated that the most prominent commodity that was scrutinized was onions, adding that they checked their availability in the markets and cooperative societies, and their quantities, and prices.

They said the price of a kilogram of onions at the present time ranges from 350 to 450 fils, adding that there are sufficient quantities available and there is no indication of a shortage in quantities.

The sources revealed that onions are available from a number of countries, including Iran, Yemen, Turkey and Pakistan.

They reassured consumers of stable prices in preparation for the month of Ramadan, reiterating that the department is conducting a number of tours and campaigns to ensure the availability of goods and to avoid any increase in their prices under any justification.

Professional qualifications under scrutiny

MP stresses need for regulation in Kuwait's psychological counseling

KUWAIT CITY, Jan 29: MP Dr. Jinan Boushahri says psychological counseling has become a profession for those who do not have a profession due to the absence of a law regulating the practice of this profession in Kuwait.

She highlighted the entry of non-specialists and those who do not have the necessary work experience and qualifications to be in this profession, and the increase in the number of institutions, offices and centers in this regard, causing confusion between psychological counseling and psychiatry.

In the explanatory memorandum for the proposed law that she submitted regarding regulating the practice of the psychological counseling profession, MP Boushahri explained that this profession serves the old and the young, the students, the teachers, the employees, the mothers and the fathers, and people with normal behavior and people with abnormal behavior.

This requires those who practice this profession to be armed with knowledge and practical training in the field of psychological counseling and its theories. Many countries even require those who wish to practice this

The session proceeded with the oath-taking of the ministers who are not members of the Assembly, followed by that of His Highness the Deputy Amir and Prime Minister Sheikh Dr Mohammad Sabah as per Article 63 of the Constitution.

Article 63: "At a special session of the National Assembly and before assuming his functions, the Deputy Amir shall take the oath prescribed in Article 60 to which shall be added the phrase 'and to be loyal to the Amir.' Should the Assembly not be in session, the aforementioned oath shall be taken before the Amir.'

During his oath-taking, HH the Deputy Amir and Prime Minister promised to respect the Constitution and the laws of the State; protect freedoms, interests and funds of the citizens; preserve the homeland's independence and territorial sanctity; and be faithful to His Highness the Amir Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah.

Meanwhile, Assembly Speaker Ahmed Al-Saadoun disclosed that the swearing-in of HH the Prime Minister Sheikh Dr Mohammad Sabah Al-Salem as Deputy Amir established a new precedent in the history of the country.

In his speech at the session, Al-Saadoun said he reviewed all precedents, but he did not find similar instances. He then pointed out that the Amiri Decree on the appointment of His Highness the Prime Minister as Deputy Amir outlined two key points stipulated in the following articles:

Article One: The appointment remains valid throughout the periods of His Highness the Amir Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah's absence from the country.

Article Two: This procedure shall continue until the Crown Prince is appointed.

Therefore, the Deputy Amir will be sworn in only once during His Highness the Amir's absence until a Crown Prince is appointed.

After the oath-taking of HH the Deputy Amir and Prime Minister, Al-Saadoun adjourned the session until the next regular session scheduled for Feb 6-7.

Meanwhile, Deputy Prime Minister and Defense Minister Sheikh Fahad Al-Yousef Al-Sabah expressed, Monday, gratitude towards the trust bestowed by the country's leaderships, saying it was a huge responsibility to execute all ministerial duties with utmost diligence.

Speaking to the press after taking the constitutional oath at parliament, Sheikh Fahad Al-Sabah -- who is also Acting Minister of Interior -- said the responsibilities "placed upon us" was great, and the cabinet has to work toward achieving the aspiration of the people.

He stressed on, "No one is above the law", affirming that the government would be fighting corruption through accountability.

The pivotal cooperation between legislative and executive authorities would ensure the best interest of the country and the people of Kuwait, he added.

The bill states that marketing and delivery platforms are not allowed to impose discriminating terms and extra fees or refuse to provide services.

The concerned establishments must modify their conditions within one month of enforcing the bill.

MPs Osama Al-Shaheen, Hamad Al-Matar, Hamad Al-Obaid, Abdulaziz Al-Saqaabi and Hamad Al-Elyan submitted a bill on the establishment of Kuwait Institute for Leaders. According to the bill, the institute shall organize leadership and development programs for ministries, other public institutions, public and private companies, and civil society organizations; in addition to providing consultations.

The institute's objectives include discovering talented students with leadership capabilities in schools, colleges and institutes; conducting longterm leadership programs to prepare these students to occupy leadership positions in the future; revising the relevant laws; and submitting bills on the amendment and development of these laws.

The institute will be managed by a five-member Board of Directors nominated by the concerned minister. The board members should be Kuwaitis who hold a doctorate degree in leadership and administration from an accredited university. A national who holds a Doctor of Philosophy degree in a different specialization can be appointed as board member, provided he already published three research works on leadership and administration in accredited universities. The candidates should have served at least four years in a leadership position such as minister, undersecretary, assistant undersecretary, board chairman or chief executive officer in the private sector.

The seat of a board member is considered vacant in these cases: resignation, suffering from a serious disease, death, end of term, absent in three consecutive meetings or six meetings in one year without a valid excuse, and declared bankrupt as per a final court verdict.

The Board of Directors shall lay down the general strategies to achieve the objectives of the institute, and specify the terms and conditions for the general manager who will be appointed according to the nomination of the board with a four-year term renewable only once.

In another development, 36 MPs signed a statement calling on the Ministry of Foreign Affairs to request for an extraordinary session of the Human Rights Council at the United Nations and assign an international fact-finding committee to investigate the Israeli crimes against the Palestinians in Gaza. The MPs pointed out that the request is in line with the recommendations presented by the Assembly during the special session allocated for this purpose; indicating Kuwait is a member of the Human Rights Council from Jan 1, 2024 until the end of December 2026

Moreover, Assembly Speaker Ahmed Al-Saadoun presided over the recent meeting of the Executive Committee of the Parliamentary Division. Undersecretary of the Division MP Hamad Al- Matar, Secretary MP Muhammad Al-Mahan, Treasurer MP Hamad Al-Obaid, members MP Shuaib Shaaban, Fahd bin Jame'e and Hani Shams; Assembly Secretary General Khalid Busleeb, and acting Assistant Secretary General for the Organizations and Rlations Sector Meshal Al-Anzi attended the meeting.

raise the fees for the recruitment of domestic workers.

He added that Al-Durra Company, which operates in accordance with the government's plans, has ensured that the new fees are compatible with the cost of recruitment. He affirmed coordination with the government agency; which includes more than 900 offices, companies and agencies accredited by the Government of Sri Lanka that has bilateral agreements with Kuwait in this regard.

He clarified that the entity, which issued the statement from the Republic of Sri Lanka, is a non-governmental entity and only 200 offices fall under its umbrella; reiterating the statement was not issued by the Sri Lankan Gov-ernment, Ministry of Labor or Embassy in the country

He was surprised that some people resorted to comparing the latest fees with that in other Gulf Cooperation Council (GCC) countries; as each market has its own economic nature, price balance and work environment, and each country has its own decisions regulating this matter, which means the company adheres to everything issued by the official State authorities.

He explained that the statement of a nongovernmental agency that the domestic labor recruitment cost is KD600 and that the fee announced by the ministry is KD750 is a confirmation of a profit -- KD150 for each recruitment contract, which is a logical amount and sufficient profit for the recruitment office, and does not burden the citizens. He added that demanding for other fees or leaving such an area open would lead to seeking excessive profit and exhausting the citizens by exploiting their need for domestic workers, wondering what profit some recruitment office owners are aspiring for.

He continued: "We, at Al-Durra Labor Company, believe that recruitment offices are supposed to work for the benefit of citizens and to serve our country by unifying the word against any unjustified price hike from abroad, cooperating with government agencies and not creating crises for financial purposes, especially since the holy month of Ramadan is fast approaching."

Stubb wins 1st round

Officials 'register' Putin to run in March election

MOSCOW, Jan 29, (AP): Russia's election com-mission on Monday formally registered President **Vladimir Putin** as a candidate for the March presi-dential election, a vote in which he's all but certain to win another six-year term in office.

Putin, 71, is running as an independent, but he retains tight control over Russia's political system that he has established during 24 years in power. With prominent critics who could challenge him either jailed or living abroad and most independent media



banned, his re-election in the March 15-17 presidential vote

looks all but assured. In 2018, Putin also ran as an independent, snubbing the United Russia party that nominated him to run in 2012. With hated him to full in 2012. With his approval ratings hovering around 80 percent, Putin is far more popular than United Rus-sia, which is widely seen as a part of the Kremlin-controlled state bureaucracy rather than a political force.

The Central Election Commission formally cleared Putin for the race after reviewing 315,000 signatures gathered by his campaign from all 89 regions of Russia. Russian election law requires independent candidates to present at least 300,000 signatures to get on the ballot

The commission already has approved three other candidates who were nominated by parties represented in parliament and weren't required to collect signatures: Nikolai Kharitonov of the Communist Party, Leonid Slutsky of the nationalist Liberal Democratic Party and Vladislav Davankov of the New People Party

All three parties have been largely supportive of the Kremlin's policies. Kharitonov ran against Putin in 2004, finishing a distant second.

Boris Nadezhdin, a 60-year-old liberal politician who serves as a local legislator in a town near Moscow, is also seeking to run. He has openly called for a halt to the conflict in Ukraine and starting a dialogue with the West.


Thousands of Russians have lined up across the country to leave their signatures in support of Nadezhdin's candidacy to allow him to qualify for the race, an unusual show of opposition sympathies in the rigidly controlled political landscape that raised a challenge for the Kremlin.

The Central Election Commission is expected to review Nadezhdin's papers later this week to decide whether to register him for the race.

Stubb wins first round of Finland election: Former Prime Minister Alexander Stubb won the first round of Finland's presidential election Sunday and will face runner-up ex-Foreign Minister Pekka Haavisto in a runoff next month.

The vote largely centered on the Nordic nation's new role as a NATO front-line country with Russia, and the security situation in Europe, particularly Russia's assault on Ukraine.

With all the votes counted, Stubb led the first round with 27.2% of the votes, while Haavisto, Finland's top diplomat in 2019-2023, took second place with 25.8%. Parliamentary Speaker Jussi Halla-aho came in third with 19%, followed by Bank of Finland gov-

GOP unveils Mayorkas impeachment articles

WASHINGTON, Jan 29, (AP): US House Republicans released two articles of impeachment against Homeland Security Secretary Alejandro Mayorkas as they vowed to swiftly push forward with election-year efforts to oust him over what they call his failure to manage the US-Mexico border. The rare step against a Cabinet member drew outrage from Democrats and the agency as a politically motivated stunt lacking the constitutional basis to

remove Mayorkas from office. Republicans contend Mayorkas is guilty of "high crimes and misdemeanors" that amount to a "willful and systemic refusal to comply with the law' on immigration and a "breach of the public trust." Impeachment, they say,

is "Congress's only viable option." "Alejandro N. Mayorkas willfully and systemically refused to comply operation" in U.S. history if he returns to the White House.

The Republican-controlled House Homeland Security Committee is set to vote Tuesday on the articles of impeachment, aiming to send them to the full House for consideration. Speaker Mike Johnson, R-La., has said the House will move forward as soon as possible with a vote after that.

Passage requires only a House majority. The Senate would hold a trial, and a two-thirds vote is required for conviction, an exceedingly unlikely outcome in the Democratic-run Senate.

The GOP push also comes at a curi-ous time for Mayorkas.

Even as the House is taking steps to try remove him from office, Mayorkas has been engaged in arduous negotiations with senators seeking to reach a bipartisan deal on border policy. He

Caretaker government approved: North Macedonia's parliament on Sunday approved a caretaker government with a mandate to organize a general election in May.

The government of the small Balkan country of 1.8 million people will be headed by the country's firstever ethnic Albanian prime minister, current parliament speaker Talat Xhaferi, 61.

The 120-member parliament approved the caretaker government 65-3, with the main opposition, centerright VMRO-DPMNE lawmakers abstaining.

Despite the abstention, VMRO-DPMNE will join the government with two ministers (interior and labor and social welfare) out of the 20 total ministers, plus three deputy ministers.

VMRO-DPMNE attacked Xhaferi in a statement.

"Talat Xhaferi is the man who is known for violating the Constitution, the laws, the Rules of Procedure of the Assembly. ... Talat Xhaferi is a man who comes from a party in which all the leaders' mouths are full of European values, but whose actions only show how they are violated. Hence, one can only expect and think that Talat Xhaferi can only do worse," the statement said.

Far-right party popularity produces rallies: Hundreds of thousands of people in Germany turned out for a third weekend to protest the popularity and policies of the far-right Alternative for Germany, or AfD party.

A rally in Hamburg took place Sunday with a theme of "For diversity and our democracy - Hamburg stands united against the AfD." Organizers said that up to 100,000 people marched through the northern city.

In the western city of Duesseldorf, 100,000 demonstrators rallied Saturday under the slogan "Against the AfD - We will not remain silent. We do not look away. We are taking action!"

Dozens of smaller protests took place over the weekend, including in the cities of Aachen, Osna-brueck, Kiel, Sigmaringen and Wittenberg, German news agency dpa reported.

Police detain man who had knife: Police detained an Italian man found with a knife in his bag on the boulevard leading to St. Peter's Square hours before Pope Francis made his weekly appearance at a Vatican palace window Sunday.

The Italian news agency ANSA said the knife was discovered during an inspection of the bag as part of routine security for the public approaching the square.

The man, 52, from the southern Italian region of Calabria, is believed to be mentally disturbed and authorities said there was no suspicion of terrorism, ANSA reported.

Italian media said the man scuffled with police, and one officer was slightly injured.

The pope's noon window appearance went ahead as scheduled, as he greeted some 20,000 people in the square during the customary Sunday tradition.

2 people in custody: Two people were taken into custody as part of an investigation into the abandonment of a newborn girl who was found last week behind dumpsters in Mississippi, authorities said.

The two people were arrested Friday, the Marshall County Sheriff's Office said on social media, without providing further details.

The newborn was found bundled in several blankets in a car seat Wednesday behind dumpsters at the Grove of Cayce mobile home park, near the Tennessee border, the sheriff's office said.

The baby was taken to a hospital and was in good condition, authorities said Friday. The mobile home park is about 35 miles

The officers were responding to a call about a domestic dispute at a home in a residential neighborhood when they were shot, according to the chief. He said the suspect was killed during the exchange of gunfire.

"Two of our officers were shot today as a result of doing their jobs and that's protect-ing our community," Augello said. "We will not tolerate anybody raising their guns or any type of lethal force against officers." (AP)

52 killed in clashes Mali, Niger, Burkina withdraw from bloc

ABUJA, Nigeria, Jan 29, (Agencies): West African nations Mali, Burkina Faso and Niger have withdrawn from the regional economic bloc known as ECOWAS, their respective juntas announced Sunday. They accused the bloc of "inhumane" sanctions to reverse the coups in their nations.

ÉCOWAS said in a statement that it wasn't notified of the countries' decision to withdraw.

The juntas said in a joint statement read on state television in all three countries that they have "decided in complete sovereignty on the immediate withdrawal of Burkina Faso, Mali and Niger from the Economic Community of West African Štates (ECOWAS)," alleging that the bloc has "moved away from the ide-



als of its founding fathers and pan-Africanism" after nearly

50 years in existence. "Furthermore, ECOWAS, under the influence of foreign powers, betraying its founding principles, has become a threat to its member states and its populations whose happiness it is supposed to ensure," their statements read.

Sunday's announcement is the latest twist in a series of events that have deepened political tension in West Africa since it experienced its latest of a string of coups - in Niger - last year. It also comes as the three nations have formed a security alliance after severing military ties with France and other European nations and turning to Russia for support.

The joint statement accused ECOWAS of failing to assist those three countries in fighting "existential" threats like terrorism - the common reason cited by their militaries for deposing their democratically elected governments.

"When these States decided to take their destiny into their own hands, it (ECOWAS) adopted an irrational and unacceptable posture in imposing illegal, illegitimate, inhumane and irresponsible sanctions in violation of its own texts," the statement noted.

Myanmar, Sea conflicts top agenda at ASEAN

LUANG PRABANG, Laos, Jan 29, (AP): China's increasingly assertive posture in the South China Sea and escalating violence in Myanmar topped the agenda for Southeast Asian diplomats at their meeting in Laos on Monday, with the Laotian foreign minister expressing guarded optimism that progress could be made this year on both acrimonious issues

Lao Foreign Minister Saleumxay Kommasith told reporters that Thailand was moving ahead with plans to provide more humanitarian assistance to Myanmar, where more than 2.6 million people have been displaced by civil war.

He said it was a good sign that the military leaders who seized control of Myanmar in February 2021 from the democratically elected government of Aung San Suu Kyi had for the first time sent a high-level representative to attend the meeting of ASEAN foreign nisters in the historic city of Luang Prabang in Laos. "We feel a little bit optimistic that the engagement may work, although we have to admit that the issues that are happening in Myanmar will not resolve overnight," Saleumxay said. "I think there is probably a small light at the end of the tunnel. Myanmar has been prohibited from sending its foreign minister or any political representative to highlevel ASEAN meetings since the end of 2021, when it blocked the group's envoy from meeting with Suu Kyi. Instead, it has sent non-political representatives to lower-level working meetings but has refused to send anyone to high-level meetings.

Duterte assails Marcos, accusing him of 'plotting to expand grip on power'

MANILA, Philippines, Jan 29, (AP) Former Philippine president Rodrigo Duterte is throwing allegations at his successor, Ferdinand Marcos Jr., and even raising the prospect of removing him from office, bring-ing into the open a long-rumored split between the two.

In an expletive-laden speech late Sunday, the former populist leader alleged Marcos' legislative allies are plotting to amend the constitution to lift term limits and warned that could lead to him being ousted like his father - the late dictator Ferdinand Marcos. Duterte also accused Marcos of being a drug addict. Marcos laughed off Duterte's al-

legations, speaking to reporters before he flew to Vietnam for a visit. Marcos said ne would not dignity the question with an answer, but claimed his predecessor is using fentanyl, a powerful opioid. In 2016, Duterte said that he had used fentanyl in the past to ease pain caused by spinal injuries from a motorbike accident, but has not acknowledged ongoing use of the drug.



Clashes in Abyei kill 52: Gunmen attacked villagers in the oil-rich region of Abyei claimed by both Sudan and South Sudan, leaving at least 52 people dead, including a U.N. peacekeeper, and 64 wounded, a regional official said Sunday.

The motive for the attack Saturday evening was not immediately clear but it was suspected to revolve around a land dispute, Bulis Koch, Abyei information minister, told The Associated Press in a telephone interview from Abyei.

Deadly ethnic violence has been common in the region, where Twic Dinka tribal members from neighboring Warrap State are locked in a land dispute with Ngok Dinka from Abyei over the Aneet area, located at the border.

The attackers in Saturday's violence were armed youth from the Nuer tribe who migrated to Warrap state last year because of flooding in their areas, Koch said.

Airstrikes kill number of militants: A number of "Kharijite" militants were killed on Monday - commanders included- in an airstrike in Hiran district, said Somali National Army.

In their statement broadcasted by Somali National News Agency (SONNA) said, the army targeted two vehicles that had wanted commanders and militants.

The airstrikes have been increased in the past hours, as they targeted commanders and other terrorist elements.

'Mass graves still being found': A Rwandan official said that the remains of 119 people believed to be victims of the 1994 genocide have been discovered in the country's south, as authorities continue to find mass graves nearly three decades after the killings.

The remains of more victims continue to be found because perpetrators of the genocide tried their best to hide possibly incriminating information. Naphtal Ahishakiye, executive secretary of the genocide survivors' organization Ibuka, told The Associated Press

In October, authorities first found six bodies under a house that was being built in Huye district. They have since found more bodies there after investigating further, he said.

'60 civilians killed last year': Human Rights Watch said that Burkina Faso's security forces last year killed at least 60 civilians in three different drone strikes, which the group says may have constituted war crimes.

The West African nation's government claimed the strikes targeted extremists, including jihadi fighters and rebel groups that have been operating in many remote communities.

The accusation by the New York-based watchdog were the latest in a string of similar charges raised by various rights groups.

Group criticizes Venezuela: Condemnation of the Venezuelan government for its decision to block the presidential candidacy of an opposition leader strengthened Sunday when the Organization of American States declared the move eliminates any possibility of a free election this year.

The regional body in a statement said the decision announced Friday against María Corina Machado, as well as the recent "prosecution and political imprisonment of opponents," was evidence the government of President Nicolás Maduro "had no intention of allowing" a clean election. That had been his commitment under a key agreement that earned him some relief from economic sanctions imposed by the United States.

"This dictatorial logic of political persecution and violation of the political rights of citizens - absolutely foreseeable and to be expected given the background of the regime - once again eliminates for Venezuela the possibility of free, fair and transparent elections," the organization said in a statement.

Machado, a former lawmaker, won a presidential primary held in October by the faction of the opposition backed by the US. She secured more than 90% of the vote despite the Venezuelan government announcing a 15-year ban on her running for office just days after she formally entered the race in June.

The longtime government foe was able to participate in the primary because the election was organized by a commission independent of Venezuela's electoral authorities. Machado insisted throughout the campaign that she never received official notification of the ban and said voters, not ruling-party loyalists, were the rightful decision-makers of her candidacy

In December, Machado filed a claim with Venezuela's Supreme Tribunal of Justice arguing the ban was null and void and seeking an injunction to protect her political rights. Instead, the court on Friday upheld the ban, which alleges fraud and tax violations and accuses her of seeking the economic sanctions the US imposed on Venezuela last decade.

The court and the National Electoral Council, the country's electoral body, are stacked with people affiliated with the ruling party.

Machado's administrative ban was signed in June by Elvis Amoroso, at the time the nation's comptroller and under whose tenure state coffers lost billions to corruption

"Why the bullfights were allowed to return when there is so much evidence of all the damage they do to a living being, such as the bull," questioned activist Guillermo Sánchez, who was holding up a sign that read "Sadism disguised as culture, sport and tradition." (AP)

Mitsui Chemical turns down KIPC proposal to waive loan interest

After the initial approval of Kuwait International Petroleum Company on the proposal to drop the interest on partners' loans to the lowest possible level, down to 0% if necessary in the Vietnam refinery, informed sources revealed that the Japanese partner, Mitsui Chemical Company of Japan, which owns a 4.7 percent stake in the refinery, rejected the proposal, reports Al-Qabas daily

The same sources said the reasons for the rejection was that it is not possible to obtain internal approvals in the company to waive important contractual rights such as reducing the interest rate on the secondary loan and the completion guarantee loan without there being a viable economic

justification or strong justifications for doing this postponement. The sources indicated that the interest on the partners' loans in the Viet-nam refinery amounts to approximately \$4 billion until 2029, of which "Inter-national Petroleum's" share amounts to approximately \$1.4 billion.

The refinery company had revealed in a letter sent to the partners at the end of last December that it had discussed reducing interest rates on loans, and in view of the large burden and negative impact of the financing cost (especially the cost of the partners' loan) on the expected financial performance of the refinery company in 2024 due to the very high interest rate, it proposed reducing the interest rate. Interest on loans.

It is noteworthy that the Nghi Son refinery is an oil refinery located in Vietnam. It was opened in November 2018. The capacity of the refinery is 200,000 barrels per day, and the total cost of the refinery project amounted to nine billion dollars, in which Japan's Idemitsu Kozan and Kuwait Petro-leum International Company each own a 35.1 percent stake; while Vietnam Oil and Gas Group owns 25.1 percent, and Japan's Mitsui Chemicals owns 4.7 percent

Kuwaiti consumer spending abroad surges by 12% in economic rebound

KUWAIT CITY, Jan 29: In a noteworthy indication of the swift recovery of the Kuwaiti economy, official figures reveal a 12% increase in consumer spending outside Kuwait, reaching 2.7 billion dinars in the past year. This surge reflects an accelerated pace compared to the 2.4 billion dinars spent in 2022, reports Al-Qabas daily.

Domestic consumer spending by citizens and residents totaled about 45.7 billion dinars, with 43 billion dinars spent within Kuwait and 2.7 billion abroad -- an 8.5% increase from 2022. Central Bank of Kuwait statistics highlight that the majority of overseas spending occurred through point-ofsale devices and online transactions using bank or credit cards. Foreign website transactions alone amounted to approximately 1.2 billion dinars, with the last quarter of 2023 witnessing an unprecedented quarterly spending figure of 11.5 billion dinars.

As oil prices continued to rise, government deposits saw a significant jump of 37.2% in 2023, reaching 4.63 billion dinars, compared to 3.37 bil-lion dinars in 2022. Total deposits increased by 3.8%, totaling 48.72 billion dinars by the end of December 2023.

The breakdown of total deposits reveals growth in private sector deposits by 1.1%, reaching 37.34 billion dinars, while public institutions' deposits in-creased by 2% to 6.753 billion dinars.

Local banks witnessed a 3.7% growth in total assets, reaching 87.666 billion dinars at the end of 2023. Net foreign assets surged by 17.9%, totaling 12.21 billion dinars, and share-

Contracts skyrocket to \$20 bln

Water project spending surges in MENA, hits three-year high

KUWAIT CITY, Jan 29: MEED magazine has reported a significant upswing in spending on water projects throughout the Middle East and North Africa (MENA) region in 2023, reaching its highest levels in three years, as per Al-Anba daily.

The collective value of contracts awarded in the water sector soared to \$20 billion, marking a noteworthy 74% increase compared to the \$11.5 billion awarded in 2022 and surpassing the highest annual contract values in the region recorded in 2021 at \$14.5 billion.

The magazine underscored the MENA region's recognition of the critical importance of water security due to geopolitical tensions, water scarcity, and climate change. Sustainable investments in water projects align with the region's long-term economic diversification agendas.

Presently, projects valued at approximately \$77.5 billion are in the pre-implementation stage across the five water sub-sectors in the MENA region, indicating a 29% increase compared to the previous year's projects under implementation.

This presents substantial opportunities for facility developers and engineering, procurement, and construction (EPC) project contractors seeking to secure more projects in this sector. Saudi Arabia remains a dominant force in future opportunities, with planned and non-awarded projects valued at around \$30 billion.

proximately \$4.9 billion. This growth was driven by independent water production projects and major water infrastructure initiatives.

While all other MENA countries recorded higher values of contracts awarded in 2023 compared to 2022, exceptions were noted for Qatar (decreased by 72%), Jordan (decreased by 58%), and Algeria (decreased by 57%).

Water transmission and distribution network projects retained a significant share, contributing 37% (\$7.7 billion) in 2023, a 1% increase from the previous year. Water treatment plant projects saw a substantial increase of 180%, reaching \$6.8 billion in 2023, and the value of water desalination contracts rose from \$1.8 billion to nearly \$4 billion.

Noteworthy developments include Morocco awarding its first major independent water production contract, Jordan's Ministry of Water and Irrigation receiving a bid for the Aqaba-Amman water transfer and desalination project, and the expected launch of the first batch of seawater reverse osmosis (SWRO) plants powered by renewable energy in Egypt within the next 12 to 24 months.

Dubai and Qatar present lucrative short-to-mediumterm opportunities in sewerage tunnels and infrastructure projects. Qatar's Public Works Authority is set to issue a tender for four pumping station projects, while Dubai Municipality revived the

The Central Bank of Kuwait reported a 1% annual decline in the official reserve assets, recording about 14.6 billion dinars at the end of December 2023, compared to 14.7 billion dinars in December 2022.

Q4 sees legal changes and fiscal proposals

Positive indicators accompany new leadership in Kuwait's 2023 conclusion

 \mathbf{T} he Kuwaiti economy ended 2023 on a relatively positive note, with the final quarter of the year showing tentative signs of a turnaround in bank credit growth, real estate activity and stock market performance. Inflation finally ticked lower in December after being rangebound for most of the year. Sentiment was also hopeful, with new emir Sheikh Meshal Al-Ahmad Al-Sabah taking the oath and appointing former Deputy Prime Minister and Minister of Foreign Affairs Dr Mohammad Al-Salem Al-Sabah as Prime Minister to lead a new, predominantly technocratic government.

Q4 2023 was notable for a pick-up in the pace of legislation. Several laws were passed including to annul the local agent requirement for foreign companies, allowing foreign companies to participate in the bidding process for public tenders and penalizing owners of unused, so-called 'white' lands to free up land for residential housing. Measures with potentially positive fiscal implications were also proposed, including excise taxes on tobacco and sugary drinks ('sin taxes') and a 15% tax rate for multinational corporations. The latter follows Kuwait's joining in November the OECD-BEPS inclusive framework against tax avoidance.

Non-oil activity picked up pace in Q2 2023

In terms of economic data, the Central Statistical Bureau (CSB) released national accounts figures after a three-year delay. These show that the non-oil economy was more resilient during the 2020 Covid-19 pandemic than originally thought, but that from 2021 onwards activity was less robust than inferred from the strong performance of associated, higher frequency metrics.

The data showed non-oil GDP expanding 1.5% y/y in Q2 2023 after several quarters of negative growth. Growth in Q2 was driven by strong gains in the transportation (+35%) y/y) and construction (+21%) sectors, with the latter reflecting the rebound seen in project awards in 2023.

Oil sector output, on the other hand, declined by -3.9% y/y as Kuwait lowered its crude production level as part of its voluntary participation in OPEC+ cuts. The negative performance of the weighty oil sector explains the 1.3% y/y contraction in overall GDP in Q2.

The CSB data also published revisions to the historical GDP series. These showed non-oil activity performing better than expected both in 2019 and in pandemic-affected 2020.

Looking ahead to 2024, additional oil sector cuts will likely keep headline growth flat to slightly negative, even as we ■ GDP figures published recently after a long delay show non-oil growth accelerating to 1.5% y/y in Q2 2023, after several quarters of contraction. Overall GDP growth was -1.3% on declining oil sector output.

■ Real estate activity ended a weak 2023 on a slightly better note, with sales up 13.6% q/q (-8.3% y/y) and with parliament passing new laws to stimulate supply in the medium term. Inflation finally notched a decline in Decem-

ber (3.4% y/y), after spending most of the year stuck at 3.8%

Private credit witnessed a third consecutive month of increase in November thanks to gains in both business and household lending. Annual growth slowed to 1.5% y/y, however.

The pace of policy proposals picked up in Q4 2023 with measures unveiled to improve the business environment and address the housing shortage.

on by refining gains and still growing private consumption. Oil prices decline in Q4 despite spike in geopolitical risk Oil prices fell sharply in Q4 2023, with Kuwait Export Crude (KEC) ending the year at \$79.6/bbl (-18.7% q/q; -3.3% y/y) and erasing most of Q3's OPEC supply-curtailment gains.

While Q4 saw a spike in geopolitical risk in the aftermath of hostilities in Gaza in October, including subsequent Houthi rebel attacks on Red Sea shipping, the effect on oil prices was negligible. Markets weighed that there was enough idle global spare production capacity to offset any potential supply disruptions, especially amid weakening oil demand. KEC averaged \$84.3/bbl (-16.7% y/y) in 2023, having traded at a premium to the usually more expensive physical Brent on the back of tighter medium sour crude fundamentals.

For 2024, we see KEC at \$82/bbl on softer but still solid oil demand growth and supportive OPEC+ supply management. At November's ministerial meeting, Kuwait agreed with the OPEC impulse to deepen and extend 2023's voluntary production cuts into Q1 2024 and possibly longer to balance the market and prevent further oil stock builds. Kuwait's output in Q1 2024 will therefore fall by 135 kb/d to 2.41 mb/d.

continuing to normalize post-pandemic. Total card spending grew 8.7% y/y in Q3 2023, similar to the 8.4% rise recorded in Q2 2023.

Looking to the year ahead, consumer spending faces headwinds including an uncertain global macroeconomic backdrop, lower year-on-year oil prices, heightened geopolitical risk and still-elevated global interest rates, though these are expected to begin easing in H2 2024. But the bulk of the slowdown in spending growth is likely behind us, with growth now more in line with historic trends after a post-pandemic surge. Moreover, consumer confidence could be boosted if the government tackles its economic agenda with renewed vigor

Real estate activity improved in Q4 2023

Q4 2023 saw the real estate sector post its best quarterly sales performance in more than two years, with sales rising 13.6% q/q to KD771 million. Strong investment and commercial sector activity, the latter including sizable deals in Kuwait City and Al-Ahmadi governorates, as well as a less marked decline in residential sector sales were behind the improvement. Activity benefitted from the end of the summer lull and an expansion in credit to the real estate sector in the final months of the year. Cumulative sales of KD2.8 billion in 2023 were still an acute 22% drop on 2022. Higher interest rates, pricier residential valuations and uncertain prospects were some of the factors at play.

Nevertheless, the government did provide some muchneeded legislative clarity with its 'white land law' bill in November, with which it aims to free up the supply side by penalizing the practice of keeping lands idle for a prolonged period. This comes on the heels of the residential cities law, approved in July, which hopes to stimulate large-scale residential development and other key projects through private sector participation. The authorities also hope to shift more of the financing to the private sector to help reduce the fiscal burden. These laws could support supply in the medium-tolong term while demand could be boosted by passage of the draft mortgage law through parliament.

Project activity dips in Q4 but still logs an impressive year

Project award momentum slipped slightly in Q4 2023 with KD621 million worth of projects being awarded, a drop of 9.6% q/q. This mainly reflects the high base of the previous quarter-a large one-off infrastructure award-since awarded contract values in absolute terms remain elevated by post-pandemic stand-ards. Total awards in 2023 reached KD2.47 billion, an almost three-fold increase on the previous year and by some margin the best projects market performance since 2017. Last year's strong performance was probably a reflection of the large backlog of pandemic-era projects finally coming alongside an unwinding in labor and material shortages.

most Americans feel they pay too much in taxes: Poll

Majority of taxpayers feel they pay too much in taxes, with many saying that they receive a poor value in return, according to a new poll from the University of Chicago Harris School of Public Policy and The Associated Press-NORC Center for Public Affairs Research.

Two-thirds of U.S. taxpayers say they spend "too much" on federal income taxes, as tax season begins. About 7 in 10 say the same about local property taxes, while roughly 6 in 10 feel that way about state sales tax. Generally speaking, Republicans are more likely than Democrats to view taxes as unfair, to say they are paying too much in taxes, and to see taxes as a poor value.

The poll found that few U.S. adults have a high level of confidence that the institutions that ultimately use their tax dollars - whether the federal government or local school districts - spend those taxes in the best interest of "people like them." But people tend to trust governing bodies closer to home with their tax dollars slightly more: 16% are extremely or very confident in their local school district, compared to 6% for the federal government.

Adults who are 60 and older are more likely than younger adults to perceive taxes, generally, as fair. Chris Berry, a professor at the Univer-

sity of Chicago Harris School of Public Policy who was involved in the creation of the poll, said that, overall, public opinion about taxes and trust in government has declined. He sees the poll results as partly reflecting increased political polarization but says the public has long typically trusted local government more than the federal government. "One of the things you'll hear said

"One of the things you'll hear said is, 'There's no Democratic or Republican way to collect the trash or pave the streets," he said. "We tend to think of local government as less partisan."

Among those who pay federal income taxes, half say they would prefer having fewer government services if it meant reducing their bill. One-third would keep their taxes the same in exchange for the same services, and 16% would opt to increase taxes for more services.

Danny Velasquez, 39, a business manager and Democrat in Boston who answered the poll, said he trusts local government to spend his tax dollars better than the federal government.

Asked how he would prefer his federal tax dollars be spent, Velasquez said the government "spends too much on warmaking" and that he'd prefer "national healthcare and investment in education." (AP)

European natural gas market remained constrained

Natural gas market rebalances in 2023 despite new geopolitical challenges

Natural gas market rebalances in 2023 despite new geopolitical challenges...

A fter a tumultuous 2022 in which natural gas prices reached record highs, 2023 has been somewhat of a stabilizing year for the commodity. The ensuing repercussions of the Russia- Ukraine conflict forced a global natural gas rebalancing as European countries tried to find immediate substitute for their supply of cheap Russian gas. On the other hand, Russia had also to find new buyers for the excess natural gas stock that previously used to be supplied to European countries. Natural gas prices witnessed significant decline during 2023 but also managed to stay well above historical averages in Europe and Asia.

The Éuropean natural gas market remained constrained in 2023 as Russia supplied 38 bcm less gas to European countries than it did in 2022. On the other hand, global LNG production increased by only 13 bcm in 2023 which was inadequate to fill Europe' natural gas demand gap left by the restrictions on Russian pipeline gas. However, despite the shortfall in natural gas supplies in Europe, the combination of unexpected milder winter and increase in alternative sources of energy consumption such as renewables relieved pressure on natural gas consumption in Europe. China overtook Japan as world's largest LNG importer in 2023. Comparatively, natural gas consumption in Europe declined by 7% to its lowest level in 28 years. In terms of global natural gas trade, global LNG trade increased by 12 bcm in 2023 in which the US alone accounted for over 10 bcm.

In terms of monthly price performance, according to the World Bank, US average monthly natural gas prices for December-2023 decreased by 54.0% y-o-y to reach USD 2.53/MMBtu. Similarly, European natural gas prices for December-2023 declined by 68.1% y-o-y averaging the month at USD 11.51/MMBtu, while average monthly Japanese LNG price for December-2023 witnessed 38.7% y-o-y drop at USD 12.61/MMBtu.

According to the IEA, global natural gas demand is set to increase by 2.5% in 2024, mainly due to expected strong growth in the Industrial and Power sectors mainly in fast-rising economies in Asia as well as countries in the Middle East and Africa. Moreover, the return of average winter temperatures is expected to add to natural gas consumption growth primarily as a heating fuel in the Northern Hemisphere in 2024 after an exceptionally mild winter in 2023.

Overall, according to LNGPrime.com, China's natural gas imports improved 9.9% in 2023 to reach 120 million tones. The surge in China's natural gas consumption was supported by decreasing spot prices, growth in terms of contracted volumes and extreme weather conditions in the country's southern parts during middle of the year. Natural gas consumption in China is expected to grow in the coming years as the country goes ahead with its plans to increase the share of natural gas in its power generation sector.

On the other hand, Japan's LNG imports declined by 8% y-o-y in 2023 to 66.2 million metric tons marking it's lowest level in 15 years. The fall in Japan's LNG imports was mainly driven by the increase in the re-introduction of electricity generating nuclear reactor to the country's energy mix. Furthermore, Japan increased its renewable consumption including wind and solar as well as nuclear power that allowed the country to reduce its LNG imports.

Natural gas consumption in North America increased by over 1% y-o-y mainly due to an increase in gas consumption in the region's Power Sector. Natural gas production in the US rose 4% to reach a record high of 1065 bcm in 2023. The combination of natural gas production growth and mild weather increased the downward trend and pressure of gas prices in the US which declined approximately 60% during 2023, according to the International Energy Agency. In its latest short-term energy outlook, the EIA forecasted that US natural gas consumption in 2024 would reach 1.1% higher than the consumption in 2023 at 89.89 bcf/d (2.54 bcm/d), reflecting an overall expected consumption stabilization in the country. The EIA also estimates that US natural gas marketed production to reach 105.04 bcf/d (3.0 bcm/d) in 2024, witnessing an increase of 1.4% from 2023 to 2024. Overall, OECD Europe consumed 35 bcm less natural gas in 2023 (488 bcm) than it did in 2022 (524 bcm). Most of the decline in Europe natural gas consumption was because of the gas-to-power sector which recorded 15% y-o-y drop during 2023 mainly due to stronger renewable power output and falling electricity consumption. According to the IEA, natural gas demand in OECD Europe is expected to grow 3% in 2024 due to the expected growth of gas consumption in the residential, commercial, and industrial sectors. On the other hand, Europe's gas use in the Power Sector is expected to drop by 10% mainly due to accelerated growth of renewable energy usage and increasing nuclear power availability in France. The EIA forecasts that the US natural gas share of electricity generation to remain at 42% in 2024 and then witness a marginal drop to 41% in 2025. In terms of natural gas prices in the US, the EIA forecasts the Henry Hub natural gas spot price to average at around USD 2.66/MMBtu during 2024 and then increase to USD 2.95/MMBtu in 2025 due to expected rising demand LNG exports which is expected to reach an annual record in 2025. According to the EIA, US net LNG exports would grow 17% in 2023 to reach 14.43 bcf/d (0.41 bcm/d) driven by growth in LNG exports Europe and South Asia. The US managed to export more LNG than any other country during 2023. According to the IEA, the Middle East natural gas production increased from 716 bcm in 2022 to 722 bcm in 2023. The Middle East was natural gas net producing region in 2023. In comparison, the Middle East consumed 591 bcm of natural gas in 2023 up from 580 bcm in 2022. The IEA expects the Middle East region to be one of the key drivers of natural gas production in 2024 as it penciled the regions gas production to reach 745 bcm. However, the region is facing security challenges due to the ongoing war on Gaza as well the recent attacks of the Yemeni Houthis to ships travelling their transit routes in the Bab Al-Mandab strait. In context, 4% of global LNG trade or 21 bcm passed eastward through the Suez Canal while another 4% of global LNG trade passed westward through the Suez Canal; all Qatari LNG deliveries passes through the Bal Al-Mandab straight and through the Suez Canal. Recently Qatar has announced that it is halting sending its LNG cargo through the Bal Al-Mandab straight due to Houthi attacks. This development is expected to put upward pressure on global natural gas prices.



Plans to expand the country's oil, electricity and water production capacities with Al-Zour (phases 2&3) and Al-Khairan IWPPs, in particular, are set to top the priorities list going forward. Kuwait Petroleum Corporation also plans to invest \$9-10 billion annually over the next five years to raise upstream oil and gas production capacity. For 2024, MEED projects has identified KD6.2 billion worth of projects awards that are up for sign-off.

Inflation rate moderates as food price pressures ease

Inflation softened in December, slowing to 3.4% y/y from 3.8% in November and 3.7% at end-Q3. (Chart 5.) The slowdown reflected moderating price rises in the food & beverages (4.7% y/y in December from a peak of 7.7% in April), housing (2.3% from 3.1% in November) and transport (2.4% from 3.0% in November) categories. Inflation accelerated, however, in the furnishings, education, health and recreation & culture categories, though not enough to positively influence the core rate, which fell slightly to 3.4%. Inflation averaged 3.6% in 2023 (vs. 4.0% in 2022) and is forecast to slow again in 2024 to 2.5% as food price and supply chain pressures ease further and consumer spending strength lessens.

Credit and deposits tick up as weak 2023 draws to a close

Private credit to residents showed signs of improvement in Q4, with growth edging up to 1.5% YTD (+1.5% y/y) in November. (Chart 6.) Business credit was the primary driver (+1.8% YTD; +1.3% y/y), helped by the construction (+15.6% YTD) and trade (+8.3% YTD) sectors especially, while the real estate sector, the largest component of business credit, was up 2.6% YTD after being broadly flat-tonegative for most of 2023. Household credit, after being flat in H1 2023, showed further signs of a pick-up (+1.7% YTD; +2.1% y/y). Resident deposit growth also strengthened in Q4 (+2.9% YTD; +2.5% y/y). Recent momentum has largely been driven by growth in public institution deposits (+15% in Sep-Nov), though these were still down 2.1% YTD after declines earlier in 2023.

Private-sector deposit growth remained muted (+1.3% YTD) after drops in five of the last six months. In contrast, government deposits surged 31% YTD. Within private-sector KD deposits, the outflow from current and savings accounts (CASA), -11.2% YTD, to higher-yielding time deposits continued (+12.6% YTD).

The CBK's key discount rate ended the year at 4.25%, after a cumulative 275 bps increase since March 2022-around half of the US Fed's 525 bps rise over the period. Attention now shifts to the pace of monetary loosening after the Fed signaled that its rate hiking cycle was all but complete. Fed dot-plots projections point to three, 25 bps rate cuts in 2024; futures markets see five to six cuts.

Equities rallied in December, off to strong start in 2024

Equities continued to decline in Q4, with the Boursa Kuwait All-Share Index falling 1% q/q (-6.5% y/y) and significantly underperforming the MSCI GCC Index (+6.3% q/q). (Chart 7.) Average turnover by traded value in Q4 was KD46 million, improving on Q3's 3-yr low of KD41 million (but still well below 2021-22 levels).

Towards the end of December, sentiment shifted in a more positive direction as markets looked for Fed rate cuts in 2024. The relief rally extended into the New Year, with sentiment buoyed by the formation of a new Kuwaiti cabinet. The All-Share Index was up 6.1% as of January 18, with turnover recovering to an elevated daily average of KD69 million-a strong start to the year.

'Hackney Diamonds' Rolling Stones' album to give 'party' FOMO

LOS ANGELES, Jan 29, (AP): "How ya doing?" **Mick Jagger** asks the crowd, arriving for a club gig in Manhattan

You read that right: A club gig. And how would YOU be doing if you were in a club and the house band turned out to be The Rolling Stones?

True, it wasn't a total surprise when Jagger, Keith Richards and Ronnie Wood, plus some invited musicians and one very high-profile guest, showed up to play at Racket NYC, capacity around 600, back in October. The crowd, industry folk and VIPs like Elvis Costello and Trevor Noah, had gathered to fete the release of "Hackney Diamonds," the Stones' first album of new songs in 18 years.



There were hopes, but most didn't know the band would be playing seven tunes - four from the new album and three longtime hits, including "Jumpin' Jack Flash." Few can say they were there, but now there's one way to recre-ate the experience: "Hackney Diamonds (Live Edition)," a two-disc CD out recently, includes both the studio album and the live show

Jagge

"We're gonna play old, we're gonna play new!" Jagger tells the crowd. First, the old: "Shattered," in which the band sings about New York, of course, where the crime rate's "going up, up, up." That was back in 1978, but guess what, we've still got "rats on the West Side" (arguably more) and yes, "bed bugs uptown," too.

We next get "Angry," the big (now Grammy-nominated) single from "Hackney Diamonds," in which Mick pleads, "Don't get angry with me, I never caused you no pain." By the end, though, he's off to Brazil. And then "Whole Wide World," with Richards and Wood sounding like they're having an especially good time (in videos, the band is smiling a lot - surely energized by enthusiasm over the new album).

"Everywhere I'm looking there's memories of my past," the song goes, but these lads - now 80 (Mick and Keith) and 76 (Ronnie) - also give a nod to the future: "And you think the party is over, but it's only just begun...

Another oldie, "Tumbling Dice," features terrific backup vocals from Chanel Haynes. That aggressive vibe from "Angry" returns with "Bite My Head Off" - but alas no Paul McCartney, who played bass for the studio album. Might Sir Paul join the band on a tour date? One can dream.

A rollicking "Jumpin' Jack Flash," often the band's encore song, closes out the show - well, for a second, because we know the Stones always come back.

And they do, with the gospel-infused "Sweet Sounds of Heaven." Mick starts it off and then, sure enough, Lady Gaga comes out to do her vocal dueling thing with the frontman, the two trading "Oh yeah!" howls.

At the end, Gaga salutes this up-and-coming bar band: "New York City, The Rolling Stones!" Jagger suggests: "Let's take a bow."

Iconic rocker takes center stage in Vegas

Billy Idol's music still strikes a chord

LOS ANGELES, Jan 29, (AP): Billy Idol normally takes advantage of riding his motorcycle on the open road knowing there's hardly any traffic because millions are usually glued to watching the Super Bowl.

But this year, Idol's bike won't be leaving his garage on game day. In-stead, the legendary British rocker will be strolling on stage to headline a pregame concert in Las Vegas ahead of the big game on Feb. 11 just outside Allegiant Stadium, where the NFL's two best teams face off.

Idol, 68, is expected to perform some of his biggest hits including "Dancing with Myself" "Mony Mony" and "Rebel Yell" during a 35-minute set on two different stages at On Location's Club 67 and Touchdown Club in front of nearly 9,000 anticipated guests. It's the second time the singer has taken part in a pre-Super Bowl show after he rocked out with Miley Cyrus three years ago outside Raymond James Stadium in Tampa, Florida. In a recent interview, Idol exclusively chatted with The Associated Press about his Super Bowl halftime aspirations, the inspiration behind his Hoover Dam show, if he would ever consider doing Broadway and looking to soon release his first studio album in a decade

would be amazing if it involved some other artists or a combination of people. That would be great. It would be one of the craziest things in the world to play. Everybody in the country watches it. Playing the pregame for me is good. Pumping people up before it and getting them ready is kind of a fun thought.

AP: You celebrated the 40th anniversary of your album "Rebel Yell" and had a five-night residency in Las Vegas last year. How does it feel to have your music still resonating today?

Idol: When we were starting out, I couldn't have imagined the effect of (our) music. We were living one day at a time. The songs were for that time period. They were just for that moment You weren't inking about any

your upcoming project compared to past works?

Idol: Not really. We're bouncing off our last album "Kings & Queens of the Underground." We did that in England and had strings on it. With this, we tried to make a lot more of an up-tempo album. There are nine songs and six of them are up-tempo. Three of them are kind of slower. It's more of a youthful sounding record. I think it'll allow our audience to have a lot of fun. AP: What inspired you to perform at Hoover Dam?

Idol: It was something like I would see in movies when I was a child. There was an Alfred Hitchcock movie ("Saboteur") that referenced Hoover Dam. There was another film "711

Avery Hellman possesses an affable alto that's quirky, as is the perspective from which Hellman writes.

Animals, nature and farm life are recurring sub-jects. On "The Ohio," Hellman sings of desert cracks, wild winds and the tug of a river. "Coyote in the Road" considers the encounter from both points of view, while "The Shearer & the Darby Ram" spins a tale from British lore.

Topics elsewhere include family skeletons, domestic dysfunction, empathy, decency and creativity. "My pathway to others," Hellman sings "is paved

LOS ANGELES: Bob Marley & The Wailers, The Clash, Beastie Boys - what do these legendary artists have in common? They owe much to Lee "Scratch" Perry, a pioneer of the dub music scene celebrated as one of reggae's founding fathers. Perry (real name Rainford Hugh Perry) died in 2021 but during the pandemic, he worked on new music material, which will be posthumously released in his final album, "King Perry," out Friday, Feb 2. This Peacock original documentary offers a close look at the early days of Joseph "Rev Run" Simmons, Darryl "DMC" McDaniels, and Jason "Jam Master Jay" Mizell's revolutionary group – finding inspiration in the streets, bringing hip-hop to the masses, and, in doing so, validating and legitimizing what will soon become the most popular style of music - and assisting in turning it into a billion-dollar business. Let's face it, "It's Tricky to rock a rhyme, to rock a rhyme that's right on time," is both an earworm for the ages – and some astute musical analysis.

MINNEAPOLIS: A dying thief who

confessed to stealing a pair of ruby slippers that Judy Garland wore in "The Wizard of Oz" because he wanted to pull off "one last score" is expected to stay out of prison after he's sentenced Monday.

Terry Jon Martin, 76, stole the slippers in 2005 from the Judy Garland Museum in the late actor's hometown of Grand Rapids, Minnesota. He gave into temptation after an old mob associate told him the shoes had to be adorned with real jewels to justify their \$1 million insured value, his attorney revealed in a memo to the federal court ahead of his sentencing in Duluth.

The FBI recovered the shoes in 2018 when someone else tried to claim a reward. Martin wasn't charged with stealing them until last year. He pleaded guilty in October to theft of a major artwork, admitting to using a hammer to smash the glass of the museum door and display case to take the slippers. But his motivation remained mostly a mystery until defense attorney Dane DeKrey revealed it this month.

Martin, who lives near Grand Rapids said at the October hearing that he hoped to remove what he thought were real rubies from the shoes and sell them. But a person who deals in stolen goods, known as a fence, informed him the rubies were glass, Martin said. So he got rid of the slippers.

DeKrey wrote in his memo that Martin's unidentified former mob associate persuaded him to steal the slippers as "one last score," even though Martin had seemed to have "finally put his demons to rest" after finishing his last prison term nearly 10 years ago.

"At first, Terry declined the invitation to participate in the heist. But old habits die hard, and the thought of a 'final score' kept him up at night," DeKrey wrote. "After much contemplation, Terry had a criminal relapse and decided to participate in the theft."

Both sides are recommending that Chief US District Judge Patrick Schiltz sentence Martin to time served because he is housebound in hospice care and is expected to die within six months. He requires constant oxygen therapy for chronic obstructive pulmonary disorder and was in a wheelchair when he pleaded guilty.

Federal sentencing guidelines would normally recommend a sentence of about 4 1/2 years to 6 years, though someone with Martin's criminal history could get an even longer term. But his health "is simply too fragile," prosecutors wrote in a court filing. Another prosecution filing said both sides agreed he should be ordered to pay \$23,500 in restitution to the museum, even though

he apparently does not have the money.

Scientific vigilantes uncover flaws in cancer research

Science sleuths use tech to find fakery in research papers

NEW YORK, Jan 29, (AP): Allegations of research fakery at a leading cancer center have turned a spotlight on scientific integrity and the amateur sleuths uncovering image manipulation in published research.

Dana-Farber Cancer Institute, a Harvard Medical School affiliate, announced Jan. 22 it's requesting retractions and corrections of scientific papers after a British blogger flagged problems in early January.

The blogger, 32-year-old Sholto David, of Pontypridd, Wales, is a scientist-sleuth who detects cut-and-paste image manipulation in published scientific papers.

He's not the only hobbyist poking through pixels. Other champions of scientific integrity are keeping researchers and science journals on their toes. They use special software, oversize computer monitors and their eagle eyes to find flipped, duplicated and stretched images, along with potential plagiarism.

Errors

A look at the situation at Dana-Farber and the sleuths hunting sloppy errors and outright fabrications:

In a Jan. 2 blog post, Sholto David presented suspicious images from more than 30 published papers by four Dana-Farber scientists, including CEO Laurie Glimcher and COO William Hahn.

Many images appeared to have duplicated segments that would make the scientists' results look stronger. The papers under scrutiny involve lab research on the workings of cells. One involved samples from bone marrow from human volunteers.

The blog post included problems spotted by David and others previously exposed by sleuths on PubPeer, a site that allows anonymous comments on scientific papers.

Student journalists at The Harvard Crimson covered the story on Jan. 12, followed by reports in other news media. Sharpening the attention was the recent plagiarism investigation involving former Harvard president Claudine Gay, who resigned early this year.

Dana-Farber said it already had been looking into some of the problems before the blog post. By Jan. 22, the institution said it was in the process of requesting six retractions of published research and that another 31 papers warranted corrections.

Retractions are serious. When a journal retracts an article that usually means the research is so severely flawed that the findings are no longer reliable.

Dr. Barrett Rollins, research integrity officer at Dana-Farber, said in a statement: "Following the usual practice at Dana-Farber to review any potential data error and make corrections when warranted, the institution and its scientists already have taken prompt and decisive action in 97 percent of the cases that had been flagged by blogger Sholto David." California microbiologist Elisabeth Bik, 57, has been sleuthing for a decade. Based on her work, scientific journals have retracted 1,133 articles, corrected 1,017 others and printed 153 expressions of concern, according to a spreadsheet where she tracks what happens after she reports problems.

She has found doctored images of bacteria, cell cultures and western blots, a lab technique for detecting proteins.

"Science should be about finding the truth," Bik told The Associated Press. She published an analysis in the American Society for Microbiology in 2016: Of more than 20,000 peer-reviewed papers, nearly 4% had image problems, about half where the manipulation seemed intentional.

Bik's work brings donations from Patreon subscribers of about \$2,300 per month and occasional honoraria from speaking engagements. David told AP his Patreon income recently picked up to \$216 per month.

Technology has made it easier to root out image manipulation and plagiarism, said Ivan Oransky, who teaches medical journalism at New York University and co-founded the Retraction Watch blog. The sleuths download scientific papers and use software tools to help find problems.

Publication

Others doing the investigative work remain anonymous and post their findings under pseudonyms. Together, they have "changed the equation" in scientific publication, Oransky said.

"They want science to be and do better," Oransky said. "And they are frustrated by how uninterested most people in academia - and certainly in publishing - are in correcting the record." They're also concerned about the erosion of public trust in science.

Bik said some mistakes could be sloppy errors where images were mislabeled or "somebody just grabbed the wrong photo."

But some images are obviously altered with sections duplicated or rotated or flipped. Scientists building their careers or seeking tenure face pressure to get published. Some may intentionally falsify data, knowing that the process of peer review when a journal sends a manuscript to experts for comments - is unlikely to catch fakery.

"At the end of the day, the motivation is to get published," Oransky said. "When the images don't match the story you're trying to tell, you beautify them."

Scientific journals investigate errors brought to their attention but usually keep their processes confidential until they take action with a retraction or correction.

Some journals told the AP they are aware of the concerns raised by David's blog post and were looking into the matter. Dark side of Dominican Republic's medical tourism exposed

93 Americans die after cosmetic surgery

NEW YORK, Jan 29, (AP): US health officials say 93 Americans have died after cosmetic surgery in the Dominican Republic since 2009, with many of the recent deaths involving a procedure known as a Brazilian butt lift.

The operation has grown in popularity recently and has led to deaths in other countries as well, including the US. A report issued Thursday by the US Centers for Disease Control and Prevention could not say how common these deaths are or whether they are more common in the Dominican Republic.

The report suggests steps that medical tourists should consider before traveling to get work done.

"Be informed about who is doing your surgery, the qualifications of the person doing your surgery, and whether or not the facility is capable of doing the surgery and whether it is capable of providing adequate post-operative care - which is crucial," said Dr. Matthew Hudson, the study's first author.

Complications

A Brazilian butt lift involves injecting fat. The report included details of about two dozen of the deaths, and most were the result of fat or blood clots getting into the lungs or bloodstream.

Complications from cosmetic surgery are not unique to the Dominican Republic. Reports of deaths after cosmetic surgeries have repeatedly surfaced in the United States, perhaps most often in Florida. The CDC on Thursday issued a separate report about 15 cases of bacterial infections in women who went to one Florida cosmetic surgery center in 2022.

Sporadic reports also have come out of Mexico, including last year when US patients were stricken with fungal meningitis after undergoing cosmetic procedures in the border city of Matamoros. Two clinics were closed and a dozen deaths reported.

The Dominican Republic is known as a friendly island vacation spot, and some doctors there advertise in the US, offering breast implants, liposuction and other operations at lower prices. After an increase in US deaths in 2019 and 2020, the US Embassy contacted the CDC, which investigated along with the Dominican Republic Ministry of Health.

They tallied 93 cosmetic surgery-related deaths of US citizens in the Dominican Republic from 2009 to 2022, or an average of about seven a year. All but one were women. More than half of the deaths occurred since 2019, coinciding with the increasing popularity of Brazilian butt lifts. In the US, nearly 29,000 of those procedures were done in 2022, according to the American Society of Plastic Surgeons.

The procedure commonly involves liposuction of fat from the hips, lower back, thighs or other areas. The fat is then injected in the buttocks to change the shape or size. Risks include fat being injected too deeply, making its way into the bloodstream and blocking key arteries or veins.

Autopsy records show that was the cause of death for 11 of 20 deaths, said Hudson, who is now at the State University of New York at Buffalo.

UK to ban disposable vapes and curb candy-flavored e-cigarettes

LONDON, Jan 29, (AP): The British government says it will ban the sale of disposable vapes and limit their cornucopia of flavors in an effort to prevent children becoming addicted to nicotine. It also plans to stick to a contentious proposal to ban today's young people from ever buying cigarettes. Prime Minister Rishi Sunak is due to announce

details of the plan on Monday. It is currently illegally to sell vapes or tobacco to children under 18 in the UK, but officials say that youth vaping has tripled in the past three years, and that cheap, colorful disposable vapes are a "key driver."

As well as banning disposable vapes, the government says it will "restrict flavors which are specifically marketed at children" and ensure that manufacturers put vapes in "less visually appealing packaging."

"As any parent or teacher knows, one of the most worrying trends at the moment is the rise in vaping among children, and so we must act before it becomes endemic," Sunak said.

"The long-term impacts of vaping are unknown and the nicotine within them can be highly addictive, so while vaping can be a useful tool to help smokers quit, marketing vapes to children is not acceptable."

Sunak's government also said it will push on with a plan announced last year to gradually raise the minimum age to buy cigarettes, so that no one born after Jan. 1, 2009 can ever legally buy them.

The idea has been welcomed by health experts, but outraged some members of the Conservative Party who view it as excessive state intervention. The plan was modeled on a proposal in New Zealand that was scrapped late last year after a change of government in that country.

The number of people in the UK who smoke has declined by two-thirds since the 1970s, but some 6.4 million people, or about 13% of the population, still smoke, according to official figures.

As the first and only facilitated subcutaneous immunoglobulin (fSCIG) for CIDP, HYQVIA offers the potential for patients to infuse up to once monthly (every two, three or four weeks), as the hyaluronidase component facilitates the dispersion and absorption of large immunoglobulin (IG) volumes in the subcutaneous space between the skin and the muscle. Penske wins Rolex 24 at Daytona

DAYTONA BEACH, Fla., Jan 29, (AP): Roger Penske snapped a 54-year losing streak at the Rolex 24 at Daytona on Sunday when Felipe Nasr held off two-time defending race winner Tom Blomqvist in the final 45 minutes of the most prestigious endurance race in the United States.

The win for Team Penske at Daytona International Speedway was its first since "The Captain" restarted his sports car program in 2018, first with Acura and then last season as a two-car Porsche factory team. Penske's only other overall win at the Rolex came in 1969 with a lineup of Mark Donohue and Chuck Parsons, who was flown in the day before the race because regular driver Ronnie Bucknum fractured his finger in a motorcycle accident.

Team Penske also won the GT class in 1966, but he has chased the overall Rolex victory since '69.

"To come back here and have both cars run for 24 hours, and then win the race, it's hard for me to believe," Penske said. "This goes down as one of the biggest wins we've

COLUMBIA, S.C., Jan 29, (AP): South Carolina coach Dawn Staley learned something new about her No. 1 Gamecocks - they didn't let their big win over LSU steal their focus from rising Vanderbilt.

Kamilla Cardoso scored 23 points and South Carolina won its 16th straight over Vanderbilt, 91-74, on Sunday, just a few days removed from rallying for a 76-70 win against the defending national champions.

The past few days have been a fan's delight and a coach's worst nightmare to make sure her players didn't get caught up in the achievement.

"I was a little nervous about how they'd respond," Staley said.

Not great at first, it turned out.


South Carolina looked like it still had the LSU triumph on its mind at first. The players danced and shimblack hoodie with "Boo," on it - a clapback to her joke about her treatment by LSU fans.

lied to win her hometown LPGA Drive On Championship and delay Lydia Ko's LPGA Hall of Fame entry, outlasting the New Zealander on the second hole of a playoff Sunday after overcoming a threestroke deficit with an eaglebirdie finish.

In calmer conditions after wind gusts to 30 mph at Bradenton Country Club, Korda won with a 3-foot par putt on the par-4 18th after Ko's 4-footer caught the lip and spun out. Ko won the season-open-

ing Tournament of Champions last week at home in Orlando for her 20th tour victory to move within a point of qualifying for the Hall of Fame.

Four strokes ahead of Ko beginning play Sunday, Korda shot a 2-over 73 to match Ko at 11-under 273. Ko, playing in the group ahead of Korda, also eagled the par-5 17th in a 69.

GOLF

Korda dropped four strokes in a three-hole stretch - making a bogey on the par-4 14th, a double bogey on the par-3 15th and a bogey on the par-4 16th - before rallying with the eagle putt across the green on 17 and an approach to a foot on 18.

The 25-year-old Korda led wire-to-wire for the first time in her career en route to her ninth LPGA Tour victory and first since the 2022 Pelican Women's

Championship. Thorbjorn Olesen won the Ras Al Khaimah Championship by six shots over fellow Dane Rasmus Hojgaard.

The 34-year-old Olesen shot a 5-under 67 to finish at 27 under for his eighth victory on the European Tour.

Olesen finished with a 69. Kazuma Kobori won his second straight PGA Tour of Australasia event - a feat last accopmplished by Adam Scott in 2013 - in the Webex Players Series Victoria. Kobori, the 22-year-old from New Zealand, made a 12foot birdie putt on the final hole for a one-stroke victory over Ashley Lau.

He lauded the crowd - the largest in recent history for the Rolex - and praised IMSA for staging such a competitive race. Five of the 10 cars in the top GTP class finished on the lead lap and Nasr's margin of victory was .0861 seconds.

"When we won in 1969 with a Lola, it was a lot different in those days," Penske said. "But to think about today, the biggest crowd they've had here for a sports car race, just to see the competitiveness, a win by (eight-) tenths of a second, that's unbeliev-able. That's what I'll say."

The winning lineup consisted of Nasr, Dane Cameron, Matt Campbell and Indianapolis 500 winner Josef Newgarden, who would like to believe his win at Indy last May is what earned him a seat in the No. 7 Porsche 963. Newgarden is the 16th driver in history to win both the Indy 500 and the Rolex.

"I just showed up, that's all I did. Porsche and Team Penske delivered the result," Newgarden said. "I was just happy to be here. You gotta talk to RP, though, I think he was crying up there on the pit stand."

The second Penske Porsche finished fourth.

It was a fight to the very end, especially the final 30 minutes, when Nasr found himself trading the lead with Blomqvist, who was driving for reigning IMSA champions Action Express Racing. Blomqvist was part of the last two Rolex wins with Meyer Shank Racing, but that team shuttered at the end of last season when it lost its factory support in part because of a cheating controversy in last January's win.

The No. 31 Cadillac, which had dominated much of the race with the Cadillac from Chip Ganassi Racing, needed Blomqvist to close the race because, with only a threedriver lineup, regular Pipo Derani had driven more than eight hours and was exhausted.

Blomqvist pitted three laps earlier than Nasr with about 75 minutes remaining and was able to pass Nasr for the lead after Nasr made his own pit stop. But Nasr got it back under caution on the final pit stop with 44 minutes remaining when he beat Blomqvist off pit road.

Nasr pulled away on the restart with 31 minutes to go, and even though Blomqvist turned the fastest lap of the race 10 minutes later. he couldn't catch Nasr as the 86-yearold Penske watched from the pit stand. Penske is known for staying up the entire 24

hours of the race.

The win capped a remarkable 246-day stretch for Penske, the most decorated team owner in motor sports history. In the last eight months, he won a record-extending 19th Indy 500 with Newgarden's victory, claimed back-to-back NASCAR Cup titles when Ryan Blaney won in November and celebrated the achievements at industry events in early December and this week. He and Newgarden were feted at the Henry Ford Museum in Michigan on Tuesday when they were presented with their own replica Indy 500 trophies.

Cadillac dominated most of the race, but the Ganassi car was eliminated with an engine failure during the overnight stints, and Penske took the lead with just under six hours remaining. Nasr passed Jack Aitken on track to take the lead and built a lead of more than four seconds.

Newgarden had been asking Penske for years to drive Team Penske cars in other racing series, and he wasn't certain the Indy 500 victory was enough to earn him a Rolex seat. But he was serious about not being a hinderance to a lineup that includes Nasr,

Cameron and Campbell.

"He's fit in perfectly with the team, he's easy to get along with and obviously very experienced within the Penske organization," Campbell said. "That makes it quite easy for him. It's good having a guy like him, he brings a lot of experience in different ways. I know coming from IndyCar, it is quite different. But he's brought some new ideas to the table.

"Having someone with his expertise in a different style of racing has really boosted us, and he's been able to adapt very well."

Newgarden said his only goal was to be a positive addition to the Porsche team.

"When I come to work with guys like Matt or Felipe or Dane, I'm learning something new and I'm seeing a new perspective that I've never seen before," Newgarden said. "I haven't run sports cars that often, definitely not as much as these guys. So they have a way of looking at things or approach-ing situations much differently than we do.



Malinin wins title: Ilia Malinin established such a big lead after his peerless short program at the U.S. Figure Skating Championships that the phenom's free skate Sunday was less a competition and more a coronation.

After starting his program with a textbook quad axel - a jump only Malinin has landed in competition he doubled a planned quad loop, fell on a quad lutz and doubled another planned quad. But even with those miscues, the 19-year-old "Quad God" was still nearly 30 points better than the rest of the competition, cruising to his second consecutive national championship.

"Even though it wasn't what I wished for," he said, "it was a fun experience. I enjoyed having the crowd with me every step."

Malinin finished with 294.35 points, well below the world-leading score of 314.66 points he had at the Grand Prix Final in December. But it was well ahead of Jason Brown in second with 264.50 points, while Camden Pulkinen soared from fifth after his short program into the bronze-medal position with 262.33 points.

Malinin had been bothered coming into nationals by a boot problem, and he resorted to wearing an old pair that he used at the Grand Prix Final. And with that issue still in the back of his mind, he wasn't sure whether he would try the quad axel. He did. And he landed it in spec-

tacular fashion. (AP)

Valieva disqualified: Russian figure skater Kamila Valieva was disqualified from the 2022 Olympics on Monday, almost two years after the teenager's doping case caused turmoil at the Beijing Games.

While Hussein added to that total, his red card proved pivotal to Iraq's elimination.

Jordan advanced as one of the best third-placed teams and took the lead against Iraq in the first minute of first-half stoppage time through Yazan Al Naimat

ABIDJAN, Ivory Coast, Jan 29, (AP): Congo knocked seven-time champion Egypt out of the Africa Cup of Nations with an 8-7 win on penalties after the teams finished 1-1 after extra time in the round-of-16 match.

Egypt goalkeeper Mohamed Abou Gabal struck the crossbar with his spot kick before Congo counterpart Lionel Mpasi stepped up to send the Leopards into the quarterfinals.

Also known as Gabaski, Abou Gabal - whose saves almost won the title for Egypt in the last edition was playing because regular goalkeeper Mohamed El Shenawy dislocated his shoulder in the team's final group game against Cape Verde.
