KUWAIT CITY, March 6, (KUNA): The state visits, paid by His Highness the Amir of Kuwait Sheikh Mishal Al-Ahmad Al-Jaber Al-Sabah to the member countries of the Gulf Cooperation Council following his inauguration, laid the groundwork for a new era featuring a new national list of priorities and aspirations.



Kuwait reiterates its support for Palestinians at OIC meet

JEDDAH, March 6, (KUNA): Kuwait has reaffirmed its backing to the Palestinian people, and called for taking measures to halt the Israeli occupation bombing, Kuwait's Minister of Foreign Affairs said Tuesday.

Minister Abdullah Al-Yaha delivered Kuwait's speech before the Organization of Islamic Cooperation (OIC) extraordinary meeting in the Saudi city of Jeddah.

"Kuwait calls on the international community to take all measures aiming to stop indiscriminate bombing

launched by the Israeli occupation forces against Palestinian people that claimed the lives of thousands of innocents," Al-Yaha, who is leading Kuwait's delegation to the meeting, said.

This is considered crimes of war and genocide, he stressed, demanding also the halt of displacing Palestinians that amounts to the crime of ethnic cleansing, in addition to allowing relief to the people of Gaza without restrictions or conditions

KUWAIT CITY, March 6: Khaled Ali Al-Wataid, the Hawalli Governorate Inspection Supervisor at the Ministry of Commerce and Industry, affirmed to Al-Seyassah daily the ministry's commitment to surveying central and supermarkets across all governorates to maintain price stability and ensure food availability before Ramadan.

He highlighted the intensification of inspection tours and campaigns on markets, shops, and cooperative societies during this period to meet the needs of citizens and residents during the holy month.

During an inspection tour of the Hawalli Governorate's Control Department, Al-Wataid revealed that the Ministry of Commerce inspectors had closed 25 commercial stores in the governorate in January and February of the current year, while reopening 24 stores during the same period.

Additionally, the inspection teams issued 139 reports and 11 notices of license violations since the beginning of the year.

32 parliamentary hopefuls register on Day 3

KUWAIT CITY, March 6: Thirty-two parliamentary election candidates, including one woman, registered on Wednesday. Following is a breakdown of the number of these candidates per constituency:

First Constituency: nine men (Osama Zaid Al-Zaid, Jarrah Ali Noor, Sultan Mohammad Al-Ajmi, Abdulsamad Mustafa Zahid, Abdulaziz Youssef Arhama, Ali Hussain Jafar, Ali Hussain Mohammad, Ali Abdurrahman Al-Kanderi and Fahad Abdullah Mezel)

Second Constituency: six men (Ahmad Mohammad Al-Hamad, Bader Nashmi Al-Enezi, Bashar Kathem Ali, Falah Dhahi Al-Hajri, Fahd Abdulaziz Al-Masoud and Moussa Ashour Al-Majedi

Third Constituency: three men and one woman (Jenan Mehsen Ramadan Bu Shehri, Khaled Jumaa Al-Yasin, Abdulaziz Saud Al-Furaij and Abdulaziz Tariq Al-Saqobi)

Fourth Constituency: five men (Buraikan Al-Sulaimani, Bakr Badi Al-Rashidi, Eid Al-Mutairi, Faisal Karam

and Muath Al-Duailah)

Fifth Constituency: eight men (Jaber Al-Muhaibli, Hamdan Al-Hamdan, Khaled Al-Mutairi, Saud Al-Hajri, Abdullah Al-Kanderi, Abdulhadi Al-Ajmi, Mohammad Al-Huailah and Hani Shams)

So far, the total number of candidates has reached 102 including three women, all of whom registered in the Third Constituency.

Former MP and First Constituency candidate Osama Al-Zaid intends to focus on the implementation of the legislative agenda of the dissolved Parliament. He said this agenda is not just a list of bills, as it is a model of institutional group work. He pointed out: "We have been able to unify efforts and coordinate with the government. There must be an agreement to approve priorities."

Regarding the election of the next speaker, Al-Zaid underscored the need for a neutral and experienced speaker who is capable of conveying messages from the political leadership to the Parliament and vice versa. He added former Speaker Ahmed Al- Saadoun has most of these characteristics.


First Constituency candidate Jarrah Ali

Ghuloum revealed he is keen on "achieving goals in all fields for the development of the country's infrastructure.'

Another First Constituency candidate Ali Hussein Ali stressed that the economic aspect is not clear in the country, as well as the results of improving the living conditions of citizens. He is keen on prioritizing the interests of citizens, especially in the fields of education, electricity, health and others. He added his electoral program includes solutions to many political, economic and development issues that he will present in the electoral symposium.

Dr Ali Al-Kandari, who is also standing for election in the First Constituency, stressed that reform of education, health and roads will be achieved through collective action, not slogans. He pointed out that "individual action does not create a political environment capable of providing what people are aspiring for. We must take a stand to ensure a solid start towards building Kuwait, similar to neighboring countries. We used to be a model of progress. Now, we have become a model of decline. This must change.'

'We need to restore public trust in government'

KUWAIT CITY, March 6: His Highness the Prime Minister Dr. Sheikh Mohammad Sabah Al-Salem Al-Sabah says the biggest challenge facing the government is restoring the confidence of the people in the government's ability to reform.

In a speech on the sidelines of his visit to Kuwait University in Sabah Al-Salem University City in the presence of the Minister of Education and Higher Education Dr. Adel Al-Adwani yesterday, he affirmed that the state is capable, through its children and its people, of correcting everything that has gone awry.

Sheikh Mohammad Sabah Al-Salem said, "I am happy to be with you. The College of Administrative Sciences is the place where I became involved academically after I returned from studying abroad. Therefore, I am very happy to see that my colleagues worked together and went through phases, some of which were difficult and some of which were easy, especially with the difficult phases being immediately after the liberation.

I will mention how this university, particularly this college, rose and restored life, not only in Kuwaiti institutions, but also at the Arab and Middle Eastern levels. We are proud that Kuwait University is a pioneer in the field of education in the Gulf region.

Likewise, the reason for the leadership of Kuwait University are the distinguished faculty members who make very valuable contributions not only in the field of teaching but also in the field of research and development.

I feel proud to be at Kuwait University today. When I was studying in this college, I used to talk about the experiences of countries, because theory is one thing and applying it is another.

Country

It cannot be more eloquent than for a person to come up with a real life model of a country that was very rich in a depleted resource but the misuse of this depleted resource led to the country falling after having the highest per capita income in the world in 1991-1992. Today, it is said it leases its land as prisons for refugees around the world. To this degree the economic situation has declined, as it is the island of Nauru.

This is not a comparison with the State of Kuwait, praise be to God, but one can take lessons from the tragedies that countries and societies experience.

The American President Roosevelt, after the depression in 1929, gave his famous phrase - There is nothing that fears us except fear itself.

Therefore, we are not afraid, but we must take lessons, but not from a standpoint of fear, but from a standpoint of optimism in order to avoid the situations that other countries have fallen into.

Before I was assigned to head the Council of Ministers, I

was one of you, listening, criticizing, and seeing, because I was outside the executive authority, so I had this luxury of "must, must" and other expressions that we always use.

It was perhaps the most noticeable and common thing in the previous period. Many citizens have questions about the situation in general, as they read about the level of corruption here and Kuwait's ranking rates in the global index. They viewed Kuwait as having a low position in the fight against corruption. They saw that there were a lot of forgery operations. For example, we in the university institution are talking about forged certificates, forgery of official documents, and others.

This was creating a kind of anxiety among the youth, especially about the spread of drugs, human trafficking, and many issues that our society talks about, especially the youth, and in scientific institutions and popular gatherings.

There are many theories stating that there is an inverse relationship between the degree of anxiety in a citizen and the time period in which it is achieved. If his anxiety increases greatly, the period that he plans for becomes short. If he becomes extremely anxious, he says, "Follow me today, I don't know what will happen tomorrow".

The first challenge for the government was to restore confidence in state institutions and the ability of this state to correct the deviations that occurred previously.

This country is capable, with its children and its people, of correcting everything that has gone awry.

This was the first challenge, which was to restore reas-

surance to the people of Kuwait about our ability to reform.

Therefore, it is reassuring that there is a real application of the law to everyone. The corruption file, for example, was the first action taken by the government in presenting the largest corruption case currently being discussed, which is the issue of the Army Fund.

The government submitted a new report on how military offices around the world used to attack public funds. We will not stop at this matter. The report was submitted and its procedures were taken to the Court of Ministers.

A group of young men, who are your children, were assigned to work to recover all the money that had been seized.

One of the tasks of this team that was assigned is to file cases in a group of countries to recover what was seized and the message from this is that we are serious about the issue of combating corruption. No matter his position, it is not a big deal in the face of justice and fairness, on which the values of Kuwaiti society were built over time and were framed in a constitution that we are all proud of.

Kuwait's score in the Corruption Perceptions Index rose 17 points, which was recorded by the Anti-Corruption Commission. It is a development that we are all proud of, as we were in one situation and moved to another situation such that we ended up on the ladder of the international anti-corruption index.

Regarding forgery, His Highness the Prime Minister highlighted the level of forgery in university certificates, saying the Ministry of Education has been reviewing the certificates from the year 2000 until now and working to verify the certificates that have been submitted to the official authorities and approved.

He stressed that it is a practical, effective and legal measure in combating administrative corruption.

His Highness the Prime Minister said, "The most asked question at the present time is where we are going. This is what is repeated everywhere, so I am happy to tell you, with all confidence, that we are going to a better horizon, through the vision of His Highness the Amir of moving Kuwait to a better state.

The New Kuwait 2035 vision depends on building an economy parallel to the oil economy, because of our dependence on a vibrant resource, that is through our vision of the experiences of other countries that were dependent on it, such that they obtained the highest sources of income and then fell to the lowest at the present time, and reached the stage of poverty."

Awareness

Sheikh Mohammad Sabah Al-Salem praised the Kuwaiti people's awareness about the need for building a new economy that does not depend on oil, but rather depends on human energies and the ability to innovate, adding that, "This matter is historic for the people of Kuwait and is not new".

He explained that the triangle that existed between Kuwait, India, and North Africa regarding trade routes was what protected Kuwait from famines.

There are also many immigrants who arrived in Kuwait as a result of famines in half of the Arabian Peninsula and Najd. Kuwait did not go through a famine the same as what other countries went through, because it is considered a supermarket for the Gulf countries, thanks to the trade in which the people of Kuwait were creative.

Kuwait has a distinct geographical location that is close to major human and economic centers such as Iran and Iraq. It is also considered a part of the Gulf system, and is the base that provides reassurance due to its proximity to the countries of the Cooperation Council. It is considered the link for the Gulf group and the broader expanse in the north of the Cooperation Council.

His Highness the Prime Minister revealed about the railway network between the GCC countries, explaining that the trains will start from Kuwait and head to the countries of East Asia, passing through the countries of Kazakhstan and Uzbekistan, and linking all roads to India.

This road is also called the Silk Road and it is on railways. It is also possible that it will extend north from Iraq, passing through Turkey and then to European countries.

The aim of this network is to maximize the benefit from the geographical location of Kuwait. All of this network will be in the northern and southern regions of Kuwait, resulting in a new Kuwait, with the presence of a distinguished logistical center that provides necessary logistical services to countries neighboring the geographical area.

It provides financial, banking and capital markets services as well as distinguished services in the field of education by providing opportunities for international universities to open branches in Kuwait.

Two top officers jailed in torture of juveniles

Drug smugglers file appeal

KUWAIT CITY, March 6: In a deterrent ruling against the actions of security personnel, the Criminal Court sentenced an officer of rank Brigadier General, who holds the position of acting director of the Juvenile Investigation Department, and his colleague of rank Lieutenant Colonel, to fouryear imprisonment each with hard labor on charges of torturing two juveniles and using cruelty on them.

The Public Prosecution charged the two defendants with torturing two juveniles to force them to confess and provide statements related to a crime that the two had allegedly committed.

The prosecution explained that the first defendant insulted, punched and slapped them several times. The second defendant took each of them separately to the office of the supervisor at his place of work, and insulted them, beat them on their legs with a wooden stick, and punched them several times

an officer, two citizens, and an Iranian who were accused of smuggling a quarter of a ton of drugs, reports Al-Seyassah daily

The lower court had sentenced the officer to 14-year imprisonment for using and possessing hashish and possessing psychotropic substances without the intention of trafficking, the two citizens to 15-year imprisonment each, and the Iranian to life imprisonment.

According to the case file, officers from the Drug Control General Department, with the cooperation of the officers from the General Department of Coast Guard, arrested an officer working in the Shuwaikh Port Office for attempting to smuggle about a quarter of a ton of hashish into the country. He was referred to the competent authority to take legal measures.

"Imagine with me a road project whose completion was delayed beyond the contractual duration for force majeure reasons, then an extension was requested to complete the project.

The project will stop because the body authorized to approve the extension has expired and the term for appointing its members has expired, and it does not exist today. Therefore, we see many projects stalled for several months due to the absence of the Central Agency for Public Tenders. Repairing and re-asphalting streets is perhaps one of the most famous projects, which was disrupted due to the failure of the administrative apparatus and the absence of a decision-making body.

"Today, the new Kuwait Airport is about to be completed, but the project will face a strange problem, which is that the tender for the roads leading to it has not been awarded to date, and its completion requires more than three years!

"Question: Why was a new device not set for tender when we know the expiration date of the previous one? The answer is poor planning and the instability of the administrative apparatus in the state, as changing a minister is faster than changing a member of the agency's board of directors.

"Recently, the director of a minister's office spoke to me and said, "I have been appointed to this position for three years, and seven ministers have passed me by!"

"The country is completely paralvzed, and today we hope from His

We have lived on barren land devoid of any economic resource -- no agriculture or river, but in a stable political situation that makes the individual feel dignified.

"As for these traitorous and ignorant 'Brothers', they are the fifth column, instigators of strife and a symbol of high treason. When their bellies were full, they began to reject grace. Are they not aware of the tragedies of peoples, their poverty, and the sectarian strife that has torn apart many nations and peoples?

"We repeat, the followers of the criminal religious ideology of the 'Brotherhood' and 'ISIS' claim that we are not governed by Islam, while Kuwait leads the world in the number of mosques and charitable deeds, which makes us wonder: Why was the State silent for so long. Why it did not consider extremist Islamic groups a terrorist organization, while it considered the Lebanese Hezbollah as such? Does the religious movement deserve courtesy at the expense of the nation?'

How to avoid rental problems?

Those who live outside their country prefer to buy a car instead of renting it, and they have their reasons, but with the complexity of life in many countries, leasing has become a solution to many of the problems of owning a car, as its owner is not required to perform any periodic maintenance on it, nor renew its ownership papers, nor insurance.

He/she does not have to face mountains of small problems if he/she is

involved in a traffic accident, for example, or breaks down in the middle of the road.

Leasing a car instead of buying it is the practical solution to all ownership problems, and

it is the general trend. Many individuals and

companies have achieved their "traditional" wealth by leasing to huge industrial companies, such as the Kuwait Oil Company, Aramco, and others.

In recent years, I have begun to satisfy my passion for cars by renting them, instead of buying them, as this causes less headache, and I say this from experience dating back to more than 62 years. I am fond of owning and driving cars, and the first car I owned was a 1962 Volkswagen, for which my father paid for its agent, Murad Behbehani, 540 dinars. My second car was a 1965 Mustang convertible, and the obsession continues today.

Since the solution is in leasing, it is necessary to know some car leasing secrets:

We must first make sure that the place to pick up the car is convenient and close to the airport building. When it is far away, the issue of handling luggage becomes very annoying. The reservation must be flexible, allowing cancellation at any time without any financial penalty. Therefore, experts advise booking the car early and then using the time before the trip to check prices from time to time. If prices decrease, the reservation can be canceled and reinstalled at a lower price. The same tactic can be followed with hotel reservations.

Also, when the car you reserved is not available when you arrive, most rental agencies will give you the second best available car without any additional fees, and this is the right of the renter. But some of them try to take advantage of the situation and offer a better car in exchange for paying an additional amount. Here you must insist on the original category of your car, and when it is not available, you have the right to get a car of a better category, without paying an additional fee.

What many car renters do not know is that the bank credit cards they carry often provide them with insurance coverage, especially if the car was reserved using the same card, which provides a significant saving on the rental cost.


Car renters must verify that there are no scratches or external or even internal damage upon receiving the car. If so, it is necessary to inform the company of this so that it can be officially installed.

It is necessary to return the car with a full fuel tank until the end, to avoid the company tampering with this matter. A picture of the tank's full indicator can be taken, as an argument against the company in the future, if it tries to tamper with it.

Finally, it is necessary to return the car to the company on time. Sometimes a delay not exceeding half an hour gives the company the right to charge a full additional day.

Power ministry unveils ambitious strategy regarding clean energy

Contract signed to prep studies related to general water plan

KUWAIT CITY, March 6: The Ministry of Electricity, Water, and Renewable Energy has revealed an ambitious strategy aimed at harnessing clean energy sources, including solar and wind power. With an approved plan in motion, the ministry aims to generate an impressive 4,710 megawatts from these projects, reports Al-Jarida daily.

Key projects within this plan include the Al-Shagaya complex project, spanning five phases, expected to produce 4,500 megawatts of electricity. Additionally, the Abdaliyah station project, with an estimated energy ca-pacity ranging from 180 to 230 megawatts, is currently under study.

Innovative approaches are also being explored, such as installing photovoltaic systems on the roofs of Subiya ground water tanks, targeting a capacity of 30 megawatts. This project is currently under evaluation by the Central Agency for Public Tenders.

In addition to these large-scale initiatives, the ministry is actively pursuing smaller projects to enhance renewable energy technology. Ongoing projects already boast a combined capacity of 5.045 megawatts, with future endeavors set to contribute an additional 93.46 megawatts.

Projects


Upcoming small-scale projects include plans to install photovoltaic cell systems on car awnings, buildings of power stations, and ministry facilities across various sites, with a total installed capacity of 8 megawatts and 34.6 megawatts, respectively, pending approval by relevant authorities.

Proposals for projects like the Doha Water Complex Project, the Shuwaikh Water Complex, and the Hawally Water Complex are underway, expected to yield a production capacity of 37 megawatts.

The latest addition to this ambitious portfolio is the Al-Matlaa High Reservoirs Project, projected to generate 45 megawatts of electricity. With these endeavors, the Ministry of Electricity, Water, and Renewable Energy is making significant strides towards a sustainable energy future.

Meanwhile, the ministry has signed a consultation contract with Aldar Engineering Office to prepare studies and documents related to the general water plan of the country in the presence of acting Undersecretary Eng Maha Al-Asousi and officials from the Water Projects Sector, reports Al-Anba daily.

Al-Asousi disclosed that the contract covers eight strategic

Dar Al-Athar Al-Islamiyyah hosts event

Kuwait participates in 10th int'l conference of Mamluk studies

KUWAIT CITY, March 6, (KUNA): The 10th conference of Mamluk studies kicked off on Tuesday at Dar Al-Athar Al-Islamiyyah with the participation of Kuwaiti and international archeological scholars and researchers specialized in the history of the Mamluk state.

The conference is conducted by the Middle East Documentation Center at the University of Chicago and under the patronage of the National Council for Culture, Arts and Literature (NCCAL).

In his speech in the conference, NCCAL Secretary General Dr. Mohammad Al-Jassar said that translating and interpreting archeology could reveal more facts about that historical era than any individual effort

Dr. Al-Jassar added that the importance of archeology reflects the culture and civilization of a certain society, such as the buildings that society builds, we can study

them, investigate and predict their way of living, patterns, and how they deal with their surroundings in the world.

He noted that this conference is an opportunity to exchange expertise, experience and researches, and to discuss the outcomes of those investigations of different archeological locations and shed the light on that important period of time in human history especially in the Middle East.

The conference over the course of two days will focus on the relationship between historical narratives and archaeological findings of the Mamluk period through more than 35 researches presented by scholars and academics from Kuwait, Saudi Arabia, United States and Russia. In addition to research centers and universities from France, Germany, Italy, Holland, Belgium, Poland, Turkiye, Egypt, Ghana, Nigeria and Japan.

water projects, including studies on connecting the northern and southern water networks. She said these projects include the establishment of two water distribution complexes -- one in Wafra (South) and the other in Naeem (North); as well as the development of Ahmadi and Subhan water distribution complexes to increase their storage, transportation and distribution capacities. She explained the rate of increase in storage capacity for both projects will be linked to the technical aspects of developing the tanks site.

Preparing

She stated that the basic project for preparing the general water plan, which will be carried out by the consultant, will determine the additional capacity that the ministry needs in each of the sites that will be developed. She said the ministry will first focus on developing the Subhan distribution complex, given the need to upgrade its stations. "Through the general water plan, we will be able to identify the future water needs of the country; that is, until 2040," she revealed.

She added the benefits of linking the southern and northern water networks include flexibility in supplying water to all parts of the country while ensuring ample water supply; indicating the above-mentioned contract also stipulates training of the local staff to acquire the necessary expertise in all stages.

The ministry has announced significant advancements in water projects within the residential city of Wafra, reports Al-Jarida daily. Valued at approximately 14.289 million dinars, these projects entail crucial infrastructure developments, including the installation of a main water line with an 800 mm diameter connecting the Wafra reservoirs to the residential city.

Additionally, there is a project underway to construct a 1200 mm diameter water line from the Al-Zour Water Complex to the Al-Wafra reservoirs, as reported by Al-Jarida daily, citing ministry sources. The ministry has reiterated its commitment to completing all energy and water projects, particularly those catering to new cities, within the specified timelines. This dedication is reinforced by ongoing collaboration with various government agencies to ensure the prompt and effective implementation of these vital initiatives.



First Constituency candidate Abdul Samad Mustafa asserted: "Once again, we return to participate in the National Assembly election and go to the ballot boxes after less than eight months of participating in the previous election. Al-Bahar underlined that as Kuwait's development entity, KFAED has funded projects for Arab and other developing countries for over 61 years, supporting their efforts to enhance social and economic plans.

The Director General of KFAED aims to strengthen bilateral cooperation with development funds of the Gulf Cooperation Council countries to attract and cover costs of developmental projects through an integrated financing plan.

Established in 1961, KFAED is considered the first development institution in the Middle East aimed at assisting developing countries in financing their projects by providing loans and aid.

'Resolve sea disputes' Australia and Laos elevate bilateral ties

MELBOURNE, Australia, March 6, (AP): Leaders of Australia and Laos signed an agreement that deepens bilateral ties on Wednesday on the final day of a Southeast Asian summit.

Australian Prime Minister Anthony Albanese and his Laos counterpart Sonexay Siphandone are cochairing the Association of Southeast Asian Nations' special summit being held in Melbourne to mark 50 years since Australia became the 10-nation bloc's first external partner.

The agreement elevates the relationship to a comprehensive partnership which will become the foundation for collaboration on defense, environment, climate, clean energy, agriculture and education. Laos, the bloc's poorest nation, took over ASEAN's



rotating leadership from Indonesia this year and is pursuing a theme of enhancing connectivity and resilience.

Albanese said the key themes of Wednesday's discussions would include trade, investment, climate change, clean energy and maritime cooperation.

These will be reflected in the leaders' communique to be adopted later on Wednesday. China's increasing asser-

Gusmão

tiveness in the region and the ongoing violence and humanitarian crisis in Myanmar, as ASEAN state, have also loomed over the three-day summit.

Myanmar has been denied political representation at the meeting over its failure to stem violence in that country since a military junta seized control in 2021. East Timorese Prime Minister **Xanana Gusmão**

is also attending the summit after ASEAN agreed in principle to admit Asia's newest country.

The former independence fighter has called on ASEAN do more to restore peace and democracy in Myanmar.

Recognizable

The Southeast Asian leaders attending the summit in Melbourne also had an opportunity on Wednesday to get up close with one of Australia's most recognizable native animals, the koala.

Albanese expressed concerns Wednesday over "unsafe and destabilizing behavior" in the South China Sea, citing the collision between Chinese and Philippine ships the previous day.

Albanese's remarks came as his country wrapped up a three-day summit of the Association of Southeast Asian Nations that failed to explicitly call China out over a series of incidents in the disputed waters.

Instead, ASEAN leaders urged for disputes to be resolved through dialogue rather than threats, a day after Chinese and Philippine coast guard vessels collided near a disputed shoal in the South China Sea and four Filipino crew members were injured in the confrontations.

Chinese and Philippines officials traded blame for the incident. The disputed area has been site of several tense skirmishes between Chinese and Philippine coast guard ships last year.

"It is dangerous and it creates risks of miscalculation, which can then lead to escalation," he said.

Australia had backed the Philippines' push to have the ASEAN declaration adopted at the end of summit cite a 2016 arbitration ruling in The Hague Netherlands that

Rivals move closer to November rematch

Biden, Trump dominate Super Tuesday races

WASHINGTON, March 6, (AP): US President Joe Biden and his predecessor, Donald Trump, romped through more than a dozen states on Super Tuesday, all but cementing a November rematch and pushing the former president's last major rival, Nikki Haley, out of the Republican race.

US

Their victories from coast to coast, including the delegate-rich states of California and Texas, left little doubt about the trajectory of the race. Haley won Vermont, denying Trump a full sweep, but the former president carried other states that might have been favorable to her such as Virginia, Massachusetts and Maine, which have large swaths of moderate voters like those who have backed her in previous primaries.

Hours after the last polls closed in Alaska, Haley scheduled a 10 am ET speech in her home state of South Carolina to announce she was suspending her campaign. Three people with direct knowledge who spoke on the condition of anonymity because they weren't authorized to speak publicly confirmed Haley's decision ahead of her announcement. while, was packed for a victory party. Among those attending were staff and supporters, including the rapper Forgiato Blow and former North Carolina Rep. Madison Cawthorn. The crowd erupted as Fox News, playing on screens around the ballroom, announced that the former president had won North Carolina's GOP primary.

"They call it Super Tuesday for a reason," Trump told a raucous crowd. He went on to attack Biden over the US-Mexico border and the US withdrawal from Afghanistan. After beginning the night with victories in Virginia and North Carolina, he wrapped Super Tuesday by winning contests in Alaska and Utah.

Warning

Biden didn't give a speech but instead issued a statement warning that Tuesday's results had left Americans with a clear choice and touting his own accomplishments after beating Trump. ley, 66, of Raleigh, North Carolina. The final days before Tuesday demonstrated the unique nature of this year's campaign. Rather than barnstorming the states holding primaries, Biden and Trump held rival events last week along the U.S.-Mexico border, each seeking to gain an advantage in the increasingly fraught immigration debate.

Attempts

After the Supreme Court ruled 9-0 on Monday to restore Trump to primary ballots following attempts to ban him for his role in helping spark the Capitol riot, Trump pointed to the 91 criminal counts against him to accuse Biden of weaponizing the courts.

"Fight your fight yourself," Trump said. "Don't use prosecutors and judges to go after your opponent."

The Melbourne Declaration, released late Wednesday, did not mention the 2016 ruling. The summit was held in the Australian city to mark 50 years since Australia became the first external ASEAN partner.

The declaration called for peaceful resolution of disputes through legal and diplomatic processes "without resorting to the threat or use of force" in accordance with international law, including the United Nations Convention on the Law of the Sea. "We encourage all countries to avoid any unilateral actions that endanger peace, security and stability in the region," it said.

Albanese said compromises had to made to find words that ASEAN leaders at the summit could agree on.

"There is a general recognition that we need to make sure that activity in the South China Sea alleviates any tension and doesn't add to it," Albanese said.

Deakin University Southeast Asia expert Damien Kingsbury said the declaration's failure to explicitly mention China was a nod to countries that are close to Beijing - Cambodia, Laos and Myanmar - and also to Malaysia's more conciliatory approach to the Chinese.

It's "a veiled criticism of China, which is about as strong as consensus would allow," Kingsbury said.

Leaders agreed at an ASEAN summit in Indonesia last September to accelerate a negotiation process with China with a goal of finalizing a South China Sea code of conduct within three years. Such a code would aim to prevent risky and provocative behavior.

That summit was joined by Vice President Kamala Harris, Chinese Prime Minister Li Qiang and Russian Foreign Minister Sergey Lavrov.

ABOARD BRP SINDANGAN: The **Philippines** will not allow **China** to remove a Philippine military outpost in a fiercely disputed South China Sea shoal, a navy official said Wednesday, a day after four Filipino navy personnel were injured in a confrontation between Chinese and Philippine ships.

Philippine officials summoned a Chinese Embassy diplomat in **Manila** to convey a strong protest over the confrontation Tuesday off Second Thomas Shoal. A small Filipino navy contingent has stood guard on a long-marooned warship that has served as an outpost in the shoal since the 1990s.

Washington issued a warning after Tuesday's hostilities that it is obligated to defend the Philippines, its oldest treaty ally in Asia, if Filipino forces, ships or aircraft come under an armed attack anywhere in the South China Sea.

Philippine navy Commodore **Roy Trinidad** also said Filipino forces will not allow any structure to be erected in another hotly contested South China Sea area, Scarborough Shoal. China surrounded the vast fishing atoll northwest of the Philippines with coast guard and suspected militia ships in 2012 after a tense standoff between Chinese and Philippine ships.

"These are red lines for the Philippines, to the armed forces," Trinidad said at a news conference in Manila when asked what Chinese actions would be unacceptable to the Philippines in the disputed waters.

Trinidad said the administration of former President **Rodrigo Duterte**, who preceded current President **Ferdinand Marcos Jr.**, established those "red lines," which delineate actions by China and any other rival claimant state that would spark fierce Philippine resistance in the disputed sea. lessly suppresses it. Arrests, trials and long prison terms - once rare - are commonplace. (AP)

IAEA chief arrives in Russia: The UN atomic watchdog agency's director has arrived in Russia for talks on nuclear safety in Ukraine, where Europe's largest nuclear power plant is at risk amid fighting.

The International Atomic Energy Agency has repeatedly expressed alarm about the Zaporizhzhia Nuclear Power Plant amid fears of a potential nuclear catastrophe. The plant has repeatedly been caught in the crossfire since Russia sent troops into Ukraine on Feb. 24, 2022, and seized the facility shortly after.

The plant's six reactors have been shut down for months, but it still needs power and qualified staff to operate crucial cooling systems and other safety features.

IAEA Director-General **Rafael Mariano Grossi** arrived at the Black Sea resort of Sochi on Tuesday evening, according to Russian state news agency RIA Novosti. Grossi announced the trip on Monday, the first day of a regular meeting of the agency's 35-nation board of governors in Vienna. (AP)

Leaders vow support for Ukraine: The Czech and French presidents said Tuesday their countries remain united in their support of Ukraine's fight against Russian aggression and are ready to look for new ways of helping the Ukrainians succeed. "We agree that the only option for us is to

we agree that the only option for us is to continue supporting Ukraine," Czech President Petr Pavel said. "We've agreed that Europe has to play a bigger role in helping Ukraine."

Pavel said that all options had to be considered but ruled out deploying combat troops in Ukraine, an idea French President Emmanuel Macron floated last week, prompting an outcry from other European leaders. Later, French officials sought to clarify Macron's remarks and tamp down criticism while insisting on the need to send a clear signal to Russia that it cannot win in Ukraine. (AP)



Kuwait's official reserve assets dip by 1% in 2023

Trade balance deficit narrows with Gulf countries

KUWAIT CITY, March 6: During the fiscal year 2023, the official reserve assets of the State of Kuwait experienced a decrease, declining by approximately 158 million dinars, or 1%, reaching a level of 14.620 billion dinars compared to 14.778 billion dinars in 2022. However, there was an increase in December, with reserve assets rising by about 531 million dinars, or 3.7%, reaching 14.620 billion dinars compared to 14.089 billion dinars in November.

Throughout 2023, the path of reserve assets exhibited fluctuations, with December marking the highest levels, followed by February with a value of 16 billion dinars, and April with 15.7 billion dinars; May saw a value of 15.6 billion dinars, June at 15 billion dinars, January at 14.8 billion dinars, August at 14.73 billion dinars, September at 14.6 billion dinars, November at 14 billion dinars, and October at 13.9 billion dinars.

Two main factors influenced the monthly performance of the reserves. Firstly, foreign currency and deposits abroad decreased to 12.309 billion dinars by the end of October, a drop of 5.15% compared to the previous month, despite an annual increase of 1.07%.

On the other hand, Kuwait's trade balance deficit with Gulf countries in the third quarter of 2023 decreased to about 280.3 million dinars, down 48.1 million dinars, or 14.6%, compared to the same period in 2022. Kuwait's exports in the third quarter of 2023 amounted to approximately 168.2 million dinars, while imports reached 448.5 million dinars.

Export figures to specific Gulf countries include approximately 52.9 million dinars to Saudi Arabia with imports of 139.6 million dinars, resulting in a trade deficit of 86.8 million dinars.



Boursa stays neutral, slight declines noted

KUWAIT CITY, March 6: The Boursa Kuwait remained relatively neutral for the third consecutive session, with slight declines observed, reports Al-Jarida daily

Yesterday, the general market index edged down by 0.05 percent, closing at 7428.57 points. Liquidity volume stood at 44.8 million dinars, with 167.6 million shares exchanged through 12,700 transactions. Of the 125 listed shares, 50 gained, 60 lost, and 15 remained unchanged.

Similarly, the Premier Market Index experienced a minor decrease of 0.01 percent, settling at 8,149.38 points, with liquidity totaling 32.3 million dinars. Trading activity involved 83.7 million shares across 6,801 transactions, with 33 listed shares. Among these, 17 gained, 11 lost, and 5 remained unchanged.

The Main Market index also saw a decline of 0.27 percent, closing at 6,062.89 points, with liquidity reaching 12.5 million dinars. Trading recorded 83.8 million shares through 5,899 transactions, with 92 listed shares. Of these, 33 gained, 49 lost, and 10 remained unchanged.

While the trading session began with promising liquidity, particularly in shares of Arjan, KFH, Wataniya Investments, and Nour, some stocks faced selling pressure, resulting in minimal losses.

Despite declines in heavyweight stocks such as KFH and NBK, overall losses were contained, with liquidity remaining above 40 million dinars.

Meanwhile, GCC market indices showed varied performance, with bullish trends observed in markets like Oman and Bahrain. Conversely, the Dubai index experienced increased pressure, registering a 2 percent decline. However, oil prices exhibited resilience, trading in the green and nearing \$83 per barrel.

Egypt's central bank raises interest rate to 27.75 pct

The Central Bank of Egypt (CBE) raised Wednesday the overnight deposit rate, overnight lending rates, and the main operation rate by 600 basis points to reach 27.25 percent, 28.25 percent, and 27.75 percent, respectively.

The CBE's Monetary Policy Committee (MPC) also increased the discount rate by 600 basis points to 27.75 percent, the bank said in a press statement, carried by Egypt's official news agency (MENA). The move came as the domestic economy has been recently weighed down by foreign exchange shortages resulting in the existence of a parallel exchange rate market and constraining economic growth, coupled with the impacts of

Following the agreement, QatarEnergy will hold a 24 percent interest share in Block 3B/4B, TotalEnergies will be the operator and hold 33 percent in shares, while the rest will be held by existing license holders, Africa Oil Corporation (17 percent), Ricocure (19.75 percent) and Eco Atlantic Oil & Gas (6.25 percent). The Minister of State for Energy Affairs, the President and CEO

of QatarEnergy, Saad Al-Kaabi stated that acquiring exploration Block 3B/4B enhances their presence in the prolific Orange Basin. Al-Kaabi also expressed his pleasure on partnering with Total-Energies, and looking forward to working together with them and the relevant government entities in South Africa. According to the statement, Block 3B/4B covers an area of more than 17,500 square kms within the Orange Basin offshore the western coast of South Africa in water depths ranging between 300m and 2,000m. Delta Airlines hiking checked-baggage fees by 17%

In case you needed yet another incentive to cram all your travel items into a carry-on, Delta Airlines just boosted the cost of your first checked bag by 17%. The increase adds \$5 to the previous, and not-exactly-insignificant, \$30 fee for domestic flights.

Delta is the third major U.S. carrier to hike bag fees in the past several weeks.

Its move follows similar increases that American Airlines and United Airlines announced in February, three days apart; those high fees themselves followed fee hikes by smaller carriers Alaska Airlines and JetBlue Airways. Major U.S. carriers often copy one another's pricing changes, a move that behavior analysts sometimes refer to as herd instinct.

Delta said Tuesday that the first bag checked on a domestic flight will now incur a \$35 fee. The charge for a second bag rose from \$40 to \$45.

Delta last raised bag fees for domestic flights in 2018. The airline said the increase will help it keep up with unspecified rising industry costs. Customers with status perks can still check their first bag for free; those with first class tickets can check two free bags. (AP)

Sri Lanka seeks to defer loan payments

Sri Lanka's president said Wednesday that he is seeking a loan repayment moratorium until 2028 as the debt-ridden county tries to emerge from bank-ruptcy.

Président Ranil Wickremesinghe told Parliament the government is asking lenders to accept a plan to defer payments for five years and then pay down the debts from the beginning of 2028 through 2042.

through 2042. Sri Lanka declared bankruptcy in April 2022 and suspended repayments on some \$83 billion in local and foreign loans amid a severe foreign exchange crisis that led to a severe shortage of essentials such as food, medicine, fuel and cooking gas, and hours-long power cuts. "Our goal is to obtain temporary relief from

"Our goal is to obtain temporary relief from debt defaults from 2023 to 2027. Subsequently, we plan to diligently work towards repaying the loans in the period from 2027 to 2042," Wickremesinghe said.

By 2022, Sri Lanka had to repay about \$6 billion in foreign debt every year, amounting to about 9.5% of GDP. The government aims to reduce debt payments to 4.5% of GDP through a negotiated debt restructuring, Wickremesinghe said. (AP)

Former Twitter executives sue Elon Musk over firings Bitcoin briefly hits an all-time high, Iess than two yrs after FTX scandal

NEW YORK, March 6, (AP): Former senior executives of Twitter are suing Elon Musk and X Corp., saying they are entitled to a total of more than \$128 million in unpaid severance payments.

Twitter's former CEO Parag

Agrawal, Chief Financial Officer Ned Segal, Chief Legal Counsel Vijaya Gadde and General Counsel Sean Edgett claim in the lawsuit filed Monday that they were

fired without a reason on the day in 2022 that Musk completed his acquisition of Twitter, which he later

rebranded X. Because he didn't want to pay their severance, the executives say Musk "made up fake cause and appointed employees of his various companies to uphold his decision."

The lawsuit says not paying severance and bills is part of a pattern for Musk, who's been sued by "droves" of former rankand-file Twitter employees who didn't receive severance after Musk terminated them by the thousands.

"Under Musk's control, Twitter has become a scofflaw, stiffing employees, landlords, vendors, and others," says the lawsuit, filed in federal court in the Northern District of California. "Musk doesn't pay his bills, believes the rules don't apply to him, and uses his wealth and power to run roughshod over anyone who disagrees

with him."

Representatives for Musk and San Francisco-based X did not immediately respond to messages for comment Monday.

The former executives claim their severance plans entitled them to one year's salary plus unvested stock awards valued at the acquisition price of Twitter. Musk bought the company for \$44 billion, or \$54.20 per share, taking control in October 2022.

They say they were all fired without cause. Under the severance plans, "cause" was narrowly defined, such as being convicted of a felony, "gross negligence" or "willful misconduct."

According to the lawsuit, the only cause Musk gave for the firings was "gross negligence and willful misconduct," in part because Twitter paid fees to outside attorneys for their work closing the acquisition.

The executives say they were required to pay the fees to comply with their fiduciary duties to the company.

"If Musk felt that the attorneys' fees payments, or any other payments, were improper, his remedy was to seek to terminate the deal - not to withhold executives' severance payments after the deal closed," the lawsuit

says. X faces a "staggering" number of lawsuits over unpaid bills, the lawsuit says. "Consistent with the cavalier attitude he has demonstrated towards his financial obligations, Musk's attitude in response to these mounting lawsuits has reportedly been to 'let them sue.""

NEW YORK, March 6, (AP): Bitcoin has hit an all-time high less than two years after the collapse of the crypto exchange FTX severely damaged faith in digital currencies and sent prices plunging.

The world's largest cryptocurrency jumped 4% this week and briefly surpassed \$68,800 Tuesday, according to CoinMarketCap. That's just above bitcoin's previous record set in November 2021.


The volatile asset soon fell some, standing at just under \$62,000 as of 3 p.m. ET, but the price is still up more than 175% from one year ago.

Gains in recent months have been fueled by the anticipation, and eventual U.S. approval, of bitcoin exchange traded funds earlier this year, which provided access to a much broader class of investors. The price for bitcoin has surged about 60% since the approval of bitcoin ETFs in January, an easy way to invest in assets or a group of assets - like gold, junk bonds or bitcoins - without having to directly buy the assets themselves.

Also driving prices is what is known as bitcoin "halving" which is anticipated in April. Halvings trim the rate at which new coins are mined and created, thus lowering the supply.

Here's what you need to know.

In January, the U.S. Securities and Exchange Commission approved the first spot bitcoin ETFs from asset managers including Blackrock, Invesco and Fidelity. These newly approved ETFs hold actual bitcoin - unlike previous bitcoin-related ETFs that were invested in contracts related to future price bets, but not on the cryptocurrency itself.

Institutional demand for bitcoin show "no signs of slowing down," H.C. Wainwright's Mike Colonnese and Dylan Scales wrote Tuesday - adding that bitcoin's popularity "is likely to accelerate in the coming months as more wealth management platforms make spot (bitcoin) ETFs accessible to their clients."

Using data from crypto platform BitMEX, Colonnese and Scales estimated that the 10 bitcoin ETFs averaged \$302 million in net daily inflows for the month of February. Last week alone, these spot ETFs booked record inflows of \$1.7 billion - bringing total net inflows to \$7.5 billion since their Jan. 11 launch.

Increased demand is also aligning with bitcoin's next halving event, which is expected at the end of April.

Bitcoin halving, which occurs every four years, is when the reward for bitcoin mining is cut in half. This reduces how fast new coins are created - making supply scarcer.

While analysts say that constrained supply in a time of high demand can push bitcoin's price

higher over time, others point to significant volatility that has resulted before and after halving events - and the possibility of sizable declines.

"Past history may not be a reliable guide to predict how the upcoming halving of bitcoin will influence its value," Rajeev Bamra, senior vice president of digital finance at Moody's Investors Service, noted. "Various external factors, market sentiment shifts, and regulatory developments can influence the trajectory of Bitcoin's price."

Bitcoin has a history of drastic swings in value - which can come suddenly and happen over the weekend or overnight in trading that continues at all hours, every day.

Bitcoin rocketed from just over \$5,000 at the start of the pandemic to its November 2021 peak of nearly \$69,000, in a period marked by a surge in demand for technology products. Prices crashed during an aggressive series of Federal Reserve rate hikes intended to cool inflation, slow money flows and make risky investments potentially riskier. Then came the 2022 collapse of FTX, which significantly undermined confidence in crypto.

At the start of last year, a single bitcoin could be had for less than \$17,000. Investors, however, began returning in large numbers as inflation started to cool. And 2023's collapse of prominent tech-focused banks actually led more investors to turn to crypto as they bailed out of positions in Silicon Valley start-ups and other risky bets.

Despite the recent excitement around bitcoin, experts still maintain that crypto is a risky bet with wildly unpredictable fluctuations in value. In short, investors can lose money as quickly as they make it.

"It's essential to exercise caution and acknowledge that the road ahead for the digital finance ecosystem, particularly the crypto markets, is expected to navigate through a period marked by volatility," Bamra noted - pointing the importance of "cautious optimism."

WASHINGTON, March 6, (AP): The Biden administration announced a rule Tuesday to cap all credit card late fees, the latest effort in the White House push to end what it has called junk fees and a move that regulators say will save Americans up to \$10 billion a year. The Consumer Financial Protection Bureau's new regulations will set a ceiling of \$8 for most credit card late fees or require banks to show why they should charge more than \$8 for such a fee.

The rule would bring the average credit card late fee down from \$32. The bureau estimates banks brought in roughly \$14 billion in credit card late fees a year.

"In credit cards, like so many corners of the economy today, consumers are beset by junk fees and forced to navigate a market dominated by relatively few, powerful players who control the market," said Rohit Chopra, director of the bureau, in a statement.

President Joe Biden planned to highlight the proposal along with other efforts to reduce costs to Americans at a meeting of his competition council on Tuesday. The Democratic president is forming a new strike force to crack down on illegal and unfair pricing on things like groceries, prescription drugs, health care, housing and financial services.

The strike force will be led by the Justice Department and the Federal Trade Commission, according to a White House statement.

The Biden administration has portrayed the White House Competition Council as a way to save people money and promote greater competition within the U.S. economy.

The White House Council of Economic Advisers produced an analysis indicating that the Biden administration's efforts overall will eliminate \$20 billion in annual junk fees. The analysis found that consumers pay about \$90 billion a year in junk fees, including for concerts, apartment rentals and auto dealers.

year's presidential election. Just 34% of U.S. adults approve of Biden's economic leadership, according to a new survey by The Associated Press-NORC Center for Public Affairs Research.

Sen. Tim Scott, R-South Carolina, criticized the CFPB cap on credit card late fees, saying that consumers would ultimately face greater costs through higher interest rates and less access to credit.

"It will decrease the availability of credit card products for those who need it most, raise rates for many borrowers who carry a balance but pay on time, and increase the likelihood of late payments across the board," Scott said.

Rob Nichols, the CEO of the American Bankers Association, said the CFPB "relied on flawed assumptions and a mischaracterization of the important role late fees play in promoting responsible consumer behavior."

The U.S. Chamber of Commerce said it will file a lawsuit to try to prevent the federal agency from capping late fees at \$8.

"The Consumer Financial Protection Bureau has exceeded its authority," said Neil Bradley, the chamber's executive vice president and chief policy officer. "The agency's final credit card late fee rule punishes Americans who pay their Americans held more than \$1.05 trillion on their credit cards in the third quarter of 2023, a record, and a figure certain to grow once the fourth-quarter data is released by the Federal Deposit Insurance Corp. next month. Those balances are now carrying interest on them, which is the highest it has been since the Federal Reserve started tracking the data back in the mid-1990s.

Further, more Americans are falling behind on their credit card debts as well. Delinquency rates at the major credit card issuers such as American Express, JPMorgan Chase, Citigroup, Capital One and Discover have been trending upward for several quarters. Some analysts have become concerned Americans, particularly poorer households hurt by inflation, might be taking on too much debt.

"Overall, the consumer is credit healthy. However, the reality is that there are starting to be some significant signs of stress," said Silvio Tavares, president and CEO of VantageScore, one of the country's two major credit scoring systems, in an interview last month.

The growth of the credit card industry is partly why Capital One announced it would buy Discover Financial last month for \$35 billion. The two companies, which are two of the largest credit card issuers, are also two companies whose customers regularly carry a balance on their accounts.

This is not the first time policymakers have weighed in on credit card fees. Congress in 2010 passed the CARD Act, which banned credit card companies from charging excessive penalty fees and established clearer disclosures and consumer protections.

The Federal Reserve issued a rule in 2010 that capped the first credit card late fee at \$25, and \$35 for subsequent late payments, and tied that fee to inflation. The CFPB, which took over the regulation of the credit card industry from the Fed after it was established, is proposing going further than the Fed.

Preparation is key to staying safe

Five expert 'fitness guidelines' for exercising safely during Ramadan

CLEVELAND, March 6: There are several measures fasting individuals can take to make physical activity a more comfortable experience during Ramadan, and a few warning signs to heed, says an expert from global health system Cleveland Clinic, who works with young athletes regularly.

"We don't always have control over when or how we exercise, par-

ticularly in the case of competitive athletes, full-time employees and school children, but we can focus on making the right food and drink choicesin non-fasting taking hours. breaks, staying



Dix cool and know-

ing when to stop," says Jennifer Dix, ATC LMT MSc, an athletic trainer at Cleveland Clinic Sports Medicine, who works with many young athletes as part of the health system's outreach program.

For those individuals who can choose when to exercise, Dix says there are no hard and fast rules. "It's a matter of finding out what works best for you. In general, it is a good idea to exercise before sunrise or close to sunset so that there is time to refuel and rehydrate afterwards. However, exercising late at night might impact on an individual's sleep cycle, and not everyone can wake up very early.

Here, Dix shares five guidelines that can help everyone who is keeping up their fitness routine this month.

1. Focus on quality, not quantity Dix says, "Be kind to yourself and remember that the body takes time to adjust to new eating and sleeping patterns. I always tell athletes to focus on quality rather than quantity. Take plenty of breaks when needed, and don't push yourself too hard." She adds, "Ensure that you get adequate rest at night, and if needed, take a nap after a strenuous exercise session."

2. Eat a balanced diet

"It is very important not to skip suboor, and to ensure you eat balanced meals. Both suboor and iftar should include complex carbohydrates, lean proteins, and healthy fats," says Dix. "You could also consider taking a good multivitamin to ensure you are getting all your nutrients. Potassium, calcium, sodium, and magnesium can help to prevent muscle cramps, while B vitamins are

energy boosters." Dix emphasizes that it is important consuming up to a liter of liquid in the mornings with suboor. In addition to water, drinks containing electrolytes can help to address imbalances caused by exertion, and milk and fruit juices are acceptable choices too. Caffeinated beverages, including teas, coffees and sodas, however, are diuretic and should be avoided as far as possible.

"For people who are playing sports or working out heavily, the guideline is to replace 100% of sweat lost during exercise with liquid. During warmer weather or more strenuous workouts, it's a good idea to weigh yourself daily to get an idea of how much sweat you lose during practice so as to determine how much fluid you need to replace this. The guideline is to drink around one liter of water for each kilogram lost," she says.

4. Keep cool and rest up

exercising outdoors, especially in humid conditions, include taking frequent breaks in the shade or indoors, says Dix. "During breaks, you can pour cold water over yourself, or hold ice towels or an icebag against your neck, stomach and upper legs.'

After training, take a cool shower or bath as soon as possible, says Dix. "It's also a good idea to pack extra clothes so that you can change directly after exercising, rather than staying in gym clothes that cling to you and retain the sweat.'

5. Know the warning signs

"The risks of exercising too intensely during Ramadan include heat cramps, where the muscles can feel tight and painful, as well as heat exhaustion and heat stroke," says Dix. "Ensure that people such as your coach or trainer know that you are fasting, and don't dismiss any symptoms. If at any time you are cramping up, feel overheated, lightheaded, weak or nauseous, or have hot, dry skin, you need to stop your activity immediately, and seek help if need-

Dix points out that it is particularly important to keep a close eye on young children who are exercising and might not be as self-aware as older children or adults.

Scientists use cells from fluid drawn during pregnancy to grow mini lungs, other organs

Amniotic fluid breakthrough enables targeted treatments

LONDON, March 6, (AP): Scientists have created miniorgans from cells floating in the fluid that surrounds a fetus in the womb - an advance they believe could open up new areas of prenatal medicine.

Miniorgans, or "organoids," are tiny simplified structures that can be used to test new medical treatments or study how the real organs they mimic work, whether they are healthy or diseased.

Researchers from University College London and Great Ormond Street Hospital in the United Kingdom collected cells from amniotic fluid samples taken during 12 pregnancies as part of routine prenatal testing. Then, for the first time, they grew mini-organs from cells taken during active pregnancies. They envision their approach could eventually help doctors monitor and treat congenital conditions before birth and develop personalized therapies for a baby in the womb.

"We're really excited" about that possibility, said Mattia Gerli of University College London, an author of the study published Monday in the journal Nature Medicine.

The tissue-specific stem cells Gerli and his col-leagues collected were shed by the fetus, as normally happens during pregnancy. The scientists identified which tissues the stem cells came from, and found cells from the lungs, kidneys and intestines.

Previously, mini-organs have been derived from adult stem cells, which more closely resemble adult tissue, or fetal tissue after an abortion

Collecting cells from amniotic fluid gets around regulations about taking stem cells directly from fetal tissue, allowing these scientists to get cells from fetuses into the latter part of pregnancy. In the U.K., the legal limit for terminating a pregnancy is generally 22 weeks after conception. Scientists can't get fetal samples after that, limiting their ability to study

normal human development or congenital diseases past that point.

In the U.S., abortion restrictions vary by state. It's legal in most to use fetal tissue for research, said Alta Charo, an emeritus professor of law and bioethics at the University of Wisconsin at Madison. Fetal tissue is defined by the National Institutes of Health as coming from a dead human embryo or fetus after a miscarriage, abortion or stillbirth - and the use of tissue from an abortion has long been controversial.

Charo, who wasn't involved in the study, said the new approach doesn't raise the same ethical issues. "Obtaining cells from amniotic fluid that is already being sampled for standard clinical purposes does not appear to add any physical risks to either fetus or pregnant woman," she said in an email.

Dr. Arnold Kriegstein, who directs the Developmental and Stem Cell Biology Program at the University of California, San Francisco, and also wasn't involved in the research, said getting cells this way has "the potential of giving you some information about that individual fetus as it's grow-

ing." And since growing mini-organs from cells in amniotic fluid takes about 4 to 6 weeks, Gerli said, there's enough time for prenatal therapy to fix problems doctors might find.

To examine one practical use of their approach, the U.K. team worked with colleagues in Belgium to study the development of babies with a condition called a congenital diaphragmatic hernia, in which organs such as the liver and intestines get displaced into the chest because of a hole in the diaphragm. The lungs don't develop the way they should, and about 30% of fetuses with the condition die. If doctors detect the hernia, they can operate on the fetus while it's still in the womb. Researchers grew lung organoids from the cells of fetuses with the condition before and after treatment and compared them to organoids from healthy fetuses. Dr. Paolo de Coppi, an author of the study from University College London and Great Ormond Street Hospital, said they were able to assess the affected child's condition before birth using this method. Doctors are now unable to tell families much about the outcome of a prenatal diagnosis because each case is different, he said. The ability to study functioning prenatal miniorgans, he added, is the first step toward a more detailed prognosis and more effective treatments.

to focus on rehydrating foods at meal times. "Avoid salty foods and include those with a high water content, for example fruit such as watermelons, apples, pears, and vegetables such as cucumbers," she says.

For athletes who need to consume large amounts of protein and calories, Dix suggests adding energy bars or protein supplements, but not to have these as meal replacements. She points out that it is important to read the labels carefully and avoid highly processed products that contain artificial additives, excessive sugars and refined carbohydrates.

3. Rehydrate sufficiently

Dix says individuals should drink more liquid than usual to prevent dehydration during the day, suggesting



Paris won't allow tourists free access to the Olympics opening ceremony

PARIS, March 6, (AP): Tourists won't be allowed to watch the opening ceremony of the Paris Olympics along the Seine River for free, the French government announced Tuesday, as it grapples with security concerns about the unprecedented open-air event. Free access will be invitation-only instead.

Organizers had planned a grandiose opening ceremony July 26 for as many as 600,000 people, most watching free of charge from riverbanks. But security and logistical concerns - and an outcry from booksellers along the city's picturesque quays - have led the government to progressively scale back ambitions.

Earlier this year, the overall number of spectators was reduced to around 300,000. On Tuesday, Interior Minister Gérald Darmanin said that 104,000 of them will be paying ticket holders with spots along the lower riverbanks, with another 222,000 watching for free from the upper banks.

But he said that the free tickets will not be available to the public via open registration as earlier envisaged, and will be invitation-only.

"To manage crowd movement, we can't tell everyone to come," Darmanin said. "For security reasons that everyone understands, notably the terrorist threat of recent weeks, we are obliged to make it free but contained."

This means that tourists from France or elsewhere, as well as ordinary Parisians, won't be able to sign up for free access. Instead, access to the ceremony will be allocated via quotas to select residents of towns or regions hosting Olympic events, local sports federations and others chosen by organizers

or their partners, said two Interior Ministry officials. The officials weren't authorized to be publicly named according to ministry policy.

Those invited will then need to undergo security checks and will receive QR codes to pass security barriers.

Local town councils can invite "their employees, kids from local soccer clubs and their parents," for example, Darmanin said. One of the Interior Ministry officials said that sports federations could invite foreigners as part of their quotas, and towns could offer spots to people with disabilities or in a situation of need, to "diversify" access.

The official said the change was not aimed at punishing tourists, and that the Games remain more open than any Olympics in several years. Another 200,000 people are expected to watch the opening from inside apartments or buildings overlooking the river, and about 50,000 from fan zones, Darmanin said.

Spain 'fines' soccer federation for not having harassment protocol in place at Women's WC

BARCELONA, Spain, March 6, (AP): The Spanish soccer federation and Barcelona soccer club have been fined an undisclosed sum by Spain's labor ministry for not meeting workplace regulations regarding gender equality.

The ministry said Wednesday that the federation, along with Barcelona and two second-division clubs, failed to meet regulations obliging workplaces with at least 50 employees to have "equality plans" in place.


The ministry said in an email to The Associated Press that it ordered an inspection of clubs with women's soc-

Spain's players boycotted their national team for a month after the World Cup until the federation agreed to overhaul the way it ran the women's team. The ministry did not disclose the sum of the fines. But the maximum fine for not having an equality plan or a harassment protocol is 7,500 euros (\$8,100) each.

Of the 16 clubs inspected, Barcelona and second-tier Catalan clubs Espanyol and Europa were found to not have proper equality plans. They did have harassment protocols in place.

Barcelona said that it "rejected any statement that put in doubt the historic commitment that the club has with gender equality policies." It said that it has had an equality plan in place since 2013, and that at the time of the inspection by the ministry it was working on updating its plan.

Barcelona's women's team won the Champions League last season and provided the backbone of players to Spain's World Cup-winning side, including Ballon d'Or winners Aitana Bonmatí and Alexia Putellas.

Kane 'steers' Bayern into **Champs League quarters**

Mbappé scores twice as PSG return to CL last 8

MUNICH, March 6, (AP): He's done it again.

Harry Kane scored twice to steer Bavern Munich into the quarterfinals of the Champions League with a 3-0 win over Lazio.

Kane's 32nd and 33rd goals this season for Bayern ensured the Bavarian powerhouse recovered from losing the first leg of the last 16 tie 1-0 in Rome to win 3-1 on aggregate over two legs.

The win will ease the pressure on Bayern coach Thomas Tuchel, whose premature departure at the end of the season was announced by Bayern after the team's three-game losing run - including the defeat in Rome.

Bayern's new sporting director Max Eberl said before the game that Tuchel would remain in charge afterward even if the team lost, but there had been a feeling defeat would bring forward the coach's exit.

Bayern, which is 10 points behind Bayer Leverkusen in the Bundesliga, was facing the prospect of just its second elimination in 12 appearances at this stage of the Champions League

Kane broke the deadlock in the 38th minute after Ciro Immobile had gone close for Lazio at the other end

At 25 years and 76 days, Mbappé became the second-youngest player to reach 45 Champions League goals, from group stage to final. Lionel Messi reached that mark at 24 years and 257 days. Mbappé stands at 46 goals.

Mbappé hadn't scored in his last two appearances with PSG but had eight goals in his last eight matches with the club. He had been replaced in the last two matches but played through the final whistle on Tuesday. PSG had won 10 of its last 13 matches in all competitions but was coming off consecutive draws against Rennes and Monaco in the French league. Mikel Merino scored Sociedad's lone goal in the 89th to give the home crowd some reason to celebrate. Sociedad was trying to advance past the last 16 of the Champions League for the first time. The Basque Country club hadn't played in Europe's top club tournament since 2013-14. Its best European campaign was in 1982-83, when it reached the semifinals of the European Cup. Sociedad started the season strong and won its Champions League group for the first time, but it has been going through a slump recently. It has lost six times in its last Kuwait and Al-Qadisiya Clubs to get state-of-the-art stadiums

Real coach accused of alleged tax fraud

BARCELONA, Spain, March 6, (AP): Spanish state prosecutors have accused Real Madrid coach Carlo Ancelotti of alleged tax fraud, claiming he used shell companies to hide parts of his income during his first stint at the club a decade ago.

Prosecutors in Madrid said in a statement Wednesday that they are accusing Ancelotti of two accounts of tax fraud and are requesting a prison sentence of four years and nine months. They accused the Italian coach of having defrauded



by firing in the rebound after Leroy Sané drew a save from Provedel. It was the England captain's sixth Champions League goal this season.

Kylian Mbappé led Paris Saint-Germain back to the Champions League quarterfinals, scoring both goals in a 2-1 win over Real Socie-dad that kept alive the French club's hopes of winning the European title in its last season with the France forward.

PSG advanced 4-1 on aggregate, with Mbappé also scoring one of the goals in the 2-0 win in the first leg in Paris three weeks ago. Mbappé has already told PSG he will not stay with the club after this season.

Despite huge spending to try to win the Champions League for the first time, PSG had been eliminated from the last 16 five times in the last seven seasons, including the last two. It had made it to the semifinals in 2021 and was runner-up in 2020.

Mbappé was the difference-maker again on Tuesday, opening the scoring with a beautiful goal in the 15th minute after a couple of nifty moves inside the area to cut back from near the touchline and fire a firm rightfooted shot into the far corner. The shot broke the netting by the far post, prompting a short stoppage in play so it could be fixed.

Mbappé's second goal came in the 56th with a run that started from near the midfield line. He sped to the open space to collect a long pass by

tors claimed he set up a "confusing" system of shell companies to hide his extra earnings. Ancelotti allegedly used companies "lacking any real activity" based outside Spain "so that neither he nor the mentioned companies had to pay taxes on the large sums earned in Spain or outside our country," the prosecutors said.

The 64-year-old Ancelotti coached Madrid from 2013-15 before rejoining the club in 2021.

Ancelotti is one of soccer's most successful coaches. He is the only coach to have won the Champions League four times, twice with Madrid and twice with AC Milan, and the only coach to have won domestic league titles in England, Spain, Italy, Germany and France. He is the latest in a string of

major soccer profiles to face a crackdown by Spanish authorities over unpaid taxes, although none have actually been sent to prison so far.

Former Madrid coach Jose Mourinho received a one-year suspended sentence after reaching a guilty plea for tax fraud in 2019. Star players Lionel Messi and Cristiano Ronaldo - among others - have also been found guilty of tax fraud in Spain. Similar to Ancelotti, Mourinho, Ronaldo and Messi were also accused of using shell companies outside Spain to hide revenue from image rights.

Ronaldo agreed to pay a fine of nearly 19 million euros (then \$21.6 million) in 2019, and was handed a two-year suspended sentence that he didn't have to serve.

Messi and his father were found guilty of defrauding tax authorities of 4.1 million euros (then \$4.6 million) but also avoided a jail sentence by paying hefty fines.
