CAPE TOWN: Three monks belonging to **Egypt**'s Coptic Orthodox Church were killed in an attack at a monastery in **South Africa** on Tuesday, the church said.

They were killed at the Saint Mark the Apostle and Saint Samuel the Confessor Monastery. The Coptic Orthodox Church, which is based in Egypt, named the monks as **Monk Hegumen Takla el-Samuely, Monk Yostos ava Markos** and **Monk Mina ava Markos**. All three were Egyptian nationals. (AP)

BEIRUT: Lebanon has lodged a complaint with the UN Security Council in the aftermath of Israeli occupation's attacks on civilians in the country.

The foreign ministry said in a statement on Wednesday that it filed the protest in retaliation for the Israeli attacks on March 11-12, targeting civilians in the northeastern town of **Baalbeck**. (KUNA)

WASHINGTON: A ballistic missile unleashed by the Houthi militias has targeted a US destroyer in the Red Sea.

Moroccan King orders relief aid to Palestine

Iran warns of 'unprecedented' humanitarian disaster in Gaza

TEHRAN, March 13, (KUNA): Iranian Foreign Minister Hossein Amir-Abdollahian warned of an unprecedented humanitarian disaster in Gaza, as Israeli aggression force continues its genocide and famine against Palestinians.

According to a statement by the Iranian Foreign Ministery on Wednesday, the minister's remarks came in a letter to UN Secretary General Antonio Guterres, UN Security Council president, Secretary General of the Organization of Islamic Cooperation (OIC) and foreign ministers of Muslim and other countries. The minister noted that it is obvious that Israeli occupation force's target now is to end all forms of life in Gaza and erase the Palestinian identity.

He called on the international community to take serious measures to end the Israeli crimes against Palestinians.

United Nations Special Coordinator for the Middle East Peace Process Tor Wennesland warned of increasing political and security risks, highlighting that the war in Gaza posed a significant threat to the fragile stability in the region.

"This year's Ramadan is marked by the rapidly deteriorating humanitarian crisis and a breakdown of law and order in Gaza, the increasing number of civilian casualties and mounting instability across the West Bank," said Wennesland in a press release on Tuesday.

He called Israeli occupation to allow the Muslim population of the occupied West Bank, including East Jerusalem, access to the Holy Sites.

He confirmed that extremists should not escalate the situation during this Holy month, as he affirmed that the sanctity of Ramadan cannot and should not be used for political gains and calculations.

"After over 150 days of war, the population of Gaza must see an end to the horrors they continue to endure" he added.

The UN official encourage all parties to avoid provocations and demonstrate utmost self-restraint. Egyptian Foreign Minister Samerh Shukry and his South Korean counterpart Cho Tae-yul discussed by phone on Wednesday the latest security and humanitarian developments of the Gaza Strip.

During the phone conversation, both ministers also tackled ongoing international efforts to put an end to the five-month war on the Palestinian territory, the Egyptian Ministry of Foreign Affairs said in a press statement.

Final day sees 37 candidates, including 7 women, join race

KUWAIT CITY, March 13: Thirty-seven candidates, including seven women, registered on the 10th and last day of the registration period for candidates in the upcoming parliamentary election.

The total number of candidates reached 255 - 241 men and 14 women. Three candidates have so far withdrawn from the electoral race.

Political conflicts cause of instability: poll-runners

Registration for Assembly poll 2024 ends

KUWAIT CITY, March 13: The Election Affairs Department (EAD) has wrapped up the registration process for candidates vy-

Al-Shaheen ing in the 2024 National As-

sembly elections after a 10-day period that commenced on the March 4, 2024, reports Al-Jarida daily.

With yesterday seeing the addition of 17 new candidates, the total count reached 221 applicants, including 7 women.

Following the withdrawal of two candidates, the tally stood at 219, with 47 members from the dissolved 2023 Council among

them, while Dr. Hassan Johar, Osama Al-Shaheen, and Daoud Marafi opted not to run.

The candidates highlighted political conflicts as a primary cause of instability in the country, emphasizing the urgent need for reforms across various sectors to enhance citizen services.

They urged authorities to develop programs and laws to establish a welfare state and enhance citizens' quality of life.

Reflecting on past councils, candidates expressed dissatisfaction with the invalidated 2022 council and questioned the effectiveness of the 2023 council, stressing the importance of delivering tangible benefits to citizens. Candidates from various districts articulated their commitment to addressing societal concerns and urged active participation in the upcoming elections.

Meanwhile, the presence of female candidates, including Nawal Aba Al Khail in the fourth district, underscores a growing trend towards gender diversity in electoral representation. With two candidates withdrawing their candidacy yesterday, the focus now shifts to the forthcoming electoral process as Kuwait prepares for the 2024 National Assembly elections.

Then he entered the 1985 elections and won first place, assuming the position of Vice President, then continuing his parliamentary career, and winning the election 1992 elections, after the liberation, and he chaired the fact-finding committee about the brutal and unjust Iraqi invasion.

He also won the 1999 elections and assumed the presidency of the Prisoners and Hostages Committee. Finally, he won the 2006 elections and assumed the presidency of the Human Rights Committee.

This became his last participation in his parliamentary career, and he was then chosen, well deservedly, in November 2010 to be head of the Central Agency for Redressing the Conditions of those with unspecified nationality, or what is known as the "Bedoun' apparatus, and he was a successful choice, as he was famous for his knowledge of the genealogies of the people of Kuwait and its families, and even some of its tribes, and the gates of hell would open in his face, as the more attacks on him increased, the more the patriots' confidence in him increased. Only an ignorant person would deny that there are cases among the bedoun that deserve to be granted state citizenship, and there are those who have been wronged, for one reason or another, but this is not the work of the central apparatus, and is not among the responsibilities of the head of the apparatus, whose work is limited to being an impenetrable barrier against anyone who wants to sabotage the system -- the social fabric of the state, in addition to the sabotage and corruption it has been exposed to over half a century. Uncle Saleh Al-Fadhala is not loved by a well-known group, nor is he voracious towards them, but in the eyes of the overwhelming and right majority of the Kuwaiti people, he is considered the barrier who deserves support and praise for what he does, and this is what we have done in this article, and he deserves much more than that.

'Non-smokers equally affected in closed spaces'



KUWAIT CITY, March 13: Within the framework of cooperation between health zones for the declaration of Faiha area as a healthy area in Kuwait, the Cancer Aware Nation (CAN) campaign affiliated with the Kuwait Society for Combating Smoking and Cancer launched a diwaniya competition titled "Health Without Smoking" in Faiha under the sponsorship of the mayor of the area Mohammad Al-Hawwas.

Chairman of the Board of Directors of CAN Dr. Khaled Al-Saleh revealed that eight diwaniyas agreed to participate in this competition, but ten others excused themselves.

He stressed that the competition aims to create healthy diwaniyas far from the harmful effects of the scourge of smoking on both smokers and non-smokers.

Dr. Al-Saleh warned of the dangers of smoking in its various forms, explaining that the World Health Organization stated that the smoking epidemic is one of the biggest public health threats around the world, as it kills more

Prices monitored at markets, shops

Teams check on hoarding of goods

KUWAIT CITY, March 13: A team of inspectors from Ahmadi Emergency Department in the Commercial Control and Consumer Protection Sector at the Ministry of Commerce and Industry recently inspected a number of central markets and shops in Ahmadi Governorate to monitor the prices of basic commodities, especially those that are in high demand during the holy month of Ramadan, reports Al-Anba daily.

In a statement to the daily, Ahmadi Emergency Team Leader Khaled Al-Muhailbi revealed that the inspection resulted in the discovery of 12 price control violations. He said the inspection of local markets is based on the plan of the ministry to intensify such campaigns, especially during Ramadan.

He affirmed that the team monitored the markets to control commercial fraud, check the expiration dates of food commodities and ensure that spe-

cial offers are not tampered with . He added the team also inspected a number of warehouses to ensure that goods are not being stored with the aim of increasing the prices without justification.

He added: "If there are violations during the tours that we conduct, we prepare arrest reports and refer the violations to the competent authorities in the ministry to implement the law against the violators." He then stressed the need to confront violators in order to protect the consumers.

He advised the consumers that if they are exposed to commercial fraud or violations, they should visit the nearest center affiliated with the Commercial Control and Consumer Protection Sector or by calling hotline number 135, or sending the complaint through WhatsApp 55135135 or the electronic application 'Easy'.

than eight million people annually. About seven million of these deaths are the result of direct smoking, compared to 1.3 million deaths resulting from exposure to second-hand smoke. This places everyone responsible for preventing smoking in closed gathering places, especially diwaniyas.

He stressed that such initiatives serve as a support for the implementation of the law that prohibits smoking in closed places, and are an incentive to highlight the importance of raising the culture of societal awareness regarding the impacts of smoking in all its forms and manifestations, as there are more than 30 components in tobacco that cause cancer.

Dr. Al-Saleh added that smokers are 22 times more likely than non-smokers to develop cancer, with lung cancer perhaps being the most closely related to smoking, in addition to heart disease, bronchitis, atherosclerosis, stroke, and others.

Plan to clean beaches at all areas around chalets

KUWAIT CITY, March 13: The Director General of Kuwait Municipality Saud Al-Dabbous approved the executive body's response to the proposal of the Municipal Council member Sharifa Al-Shalfan regarding maintaining the cleanliness of beaches.

In the letter sent in response to the proposal, the plan to activate Al-Shalfan's proposal and its steps was mentioned,



which began with the municipality addressing the Ministry of Finance to coordinate with it to identify areas for public beach cleaning mechanisms. The Ministry of Finance responded by submitting a letter containing plans for all chalet areas under the supervision of the ministry's State Property Department, as well as all the public paths leading to the beaches.

Accordingly, the municipality assigned the directors of the cleanliness and road works departments in the Ahmadi, Jahra and Capital municipalities

to determine the entrances for the municipality's cleaning mechanisms to clean the beaches in the areas located in those governorates, which are the chalets of Zour. Nuwaiseeb. Mina Abdullah and Bneider, and the chalets of the northern region.

The municipality explained in its letter that the process of cleaning the beaches will include removing all concrete and rock barriers separating the sea from the land. It will also place a number of containers that commensurate with the need on all public beaches, and identify sites for collecting waste after it is removed from the beach in preparation for transporting it to places for treatment or backfilling by the municipality through monitoring and following up on the work of cleaning companies contracting with the municipality.

This follow up begins from the start of the work for executing these contracts on a daily basis to ensure their commitment to performing their work in accordance with the terms and conditions of the contracts concluded with them. In the event that they violate their commitment, necessary measures are taken by applying the list of violations and penalties contained in the contracts. Also, the number of advisory signs will be increased on all public beaches to clarify the penalties resulting from throwing waste in places other than those designated for it.

Kuwait's prosperity lies in unity, transcending internal strife and external pressures, thereby reaffirming its status as a homeland for all. In this blessed month, may our collective adherence to moral virtues guide us towards a brighter future."

"It is incumbent upon Arab and Islamic countries to shoulder their historical responsibilities, confronting the legacy of tyranny and complacency that has plagued their governance. From the era of the Umayyads to the Ottomans, oppressive regimes have subjugated their subjects, betraying the principles of justice and equality enshrined in Islam. Intellectual enablers, complicit in legitimizing authoritarian rule, have distorted religious texts to justify oppression, perpetuating a cycle of tyranny and servitude.

"Furthermore, the collective failure of Arab nations to unite in defense of Palestine, as exemplified by the League of Arab States, underscores a deeper malaise within the region.

"Despite unanimous rejection of the UN's partition plan for Palestine in 1947, Arab armies failed to coordinate effectively, allowing colonial powers to dictate the course of events. The annexation of Palestinian territories by neighboring states, notably Jordan, further compounded the fragmentation of the Palestinian cause, thwarting aspirations for statehood.

"While the international community increasingly rallies behind Palestine's quest for recognition, Arab and Islamic nations must seize this moment to rectify historical injustices. The demand for Palestinian statehood within the United Nations is long overdue, necessitating a concerted effort to mobilize diplomatic support and redress past failures.

Drug addicts assault police, escape

KUWAIT CITY, March 13: The Al-Ahmadi investigation officers have been tasked with apprehending two men and referring them, along with

others already in custody, to the relevant authorities. They face charges including assaulting a security officer, damaging a police patrol, aiding an accused person in escaping, and possessing and using drugs.

According to a security source, the incident occurred during a routine patrol in the Al-Dhahr. A vehicle was observed moving erratically, prompting the security officers to signal the driver to stop.

However, the driver attempted to flee before being compelled to stop.

Upon inspection, it was discovered that the vehicle contained four individuals, two of whom were wanted for criminal offenses and had been sentenced to 12 years in prison.

During the attempt to arrest them, the suspects assaulted the security personnel, resulting in injuries to one soldier. Two of the suspects managed to escape and flee between the nearby houses, while the other two were apprehended. Subsequent search of the vehicle led to the discovery of narcotic substances and related paraphernalia.

As a result, a case has been registered against the suspects for assaulting a security officer, damaging a police patrol, aiding the escape of wanted individuals, and failing to comply with security personnel.

"The global outcry against the ongoing catastrophe in Gaza has sparked widespread demonstrations worldwide, including within the corridors of power among Israel's allies. Some governments, irrespective of their Arab or Islamic affiliations, have taken swift action, expelling Israeli ambassadors and severing diplomatic ties. "This year, as is the custom, sisterly Saudi Arabia announced immediately after the Maghrib prayer on Sunday that the sighting of the crescent moon was confirmed at the Sudair Observatory. People in Kuwait circulated the news early, while the official announcement in our country was delayed until close to the evening prayer. What is the justification for the delay?

"It is true that there is regret in haste, and one must be careful, but does the vision committee imagine that someone will come forward to it from inside Kuwait to confirm its sighting of the Ramadan crescent, while it knows with certainty that this is almost impossible in Kuwait, and that the crescent has not been sighted here for some time? This is due to the small area of Kuwait, air pollution, and the lack of observatories and experts to see the crescent with the naked eye, as the case in Saudi's observatories that compete to see and record a victory for seeing the crescent, a confirmed sighting based on which people fast.

'We say to the vision authority: There is no justification for delaying the announcement of the confirmation of the sighting after it was proven in Saudi Arabia so that people can act before the evening call to prayer. It is known that the night of the announcement is considered one of the nights of Ramadan. It is desirable to perform Tarawih prayers on this night. Preparing for Ramadan requires time that is provided by early announcement, instead of leaving people waiting for the official announcement of the State for a long time, while they are deliberating on the confirmation of the vision in Saudi Arabia. What is the opinion of the members of the esteemed committee?"

3 acquitted in funds scam

Top Mol officer, 2 staff get jail in vehicle fraud

KUWAIT CITY, March 13: The Criminal Court ordered the referral of an officer of rank Lieutenant Colonel in Hawally Traffic Department and two other employees to the Central Prison after convicting them of transferring the ownership of a vehicle without the actual owner's permission.

According to the case file, a person went to the Hawally Traffic Department based on instructions from some individuals who were trusted by the head of the department. He submitted a request to transfer a vehicle from a particular individual's name to his name under the illusion that the vehicle owner's approval was obtained to carry out the transaction without his presence.

Since this person was trusted by the Lieutenant Colonel officer, the latter signed a "no objection" transaction and referred it to the other employees, who then carried out the procedures for transferring the vehicle's ownership.

Three acquitted: The Criminal Court presided over by Judge Dr. Khaled Al-Omairi acquitted an employee, a trader, and an Egyptian expatriate of facilitating the seizure of KD 6 million from the public funds and forging approvals for some works that were not executed.

According to the case file, the three suspects had facilitated the seizure of KD 6 million from the public funds for a tender for air conditioning and heating systems at the Amiri Diwan, and forged approvals for the unimplemented works.

They were referred to the Public Prosecution in accordance with article 10 of law No. 1/1993 regarding the protection of public funds.

Gov't allocates KD186 mln to expedite Mubarak Al-Kabeer Port project

KUWAIT CITY, March 13: In a move signaling the government's commitment to completing the long-awaited Mubarak Al-Kabeer Port project, the Council of Ministers has approved an allocation of 186 million dinars to the Ministry of Public Works for fiscal 2024-2025, reports Al-Qabas daily.

This decision underscores the administration's determination to finalize this crucial development initiative, which has faced delays in its completion.

The Mubarak Al-Kabeer Port project, estimated to cost 990 million dinars, is slated to cover an expansive area of approximately 1,161 hectares. With the capacity to accommodate around 24 berths and handle 8.1 million containers, the port is envisioned as a pivotal hub for transit trade and regional transportation. The executive position of the Mubarak Al-Kabeer Port project includes: Implementing the road linking from the Subiya area to the east of Bubiyan Island.



It takes them out of the vicious circle that they were in as a result of the absurd conflict between the National Assembly and the Council of Ministers over the past years.

They lacked the simplest elements of joy and entertainment, and saw their country static and closed, floating in a space other than planet Earth.

Here it is necessary to remember, which perhaps will benefit the believers. We have suggested in previous articles about investing Kuwait's sovereign money locally, including the USD 200 billion that the government extracts from the sovereign fund, which, according to reports, is approaching one trillion dollars.

This money should be injected into local urban projects either on the deserted islands or infrastructure and roads, as well as the establishment of housing cities with integrated specifications, and entertainment cities that will be a haven for both citizens and residents instead of migrating during each vacation to neigh-

boring countries. Once upon a time those countries were just desert lands but today they are the destination for every visitor to reside and spend their income there.

Unfortunately, when extremist mentalities interfere in the decisions, the result is what we are currently seeing in Kuwait, while in other countries there is determination and resolve.

The decision maker does not listen to a parliamentarian or influential person, and does not close the country or cause the cost of projects to be artificially inflated.

There are several proposals to get rid of this corruption by seeking the help of foreign companies that have a long history in urban projects, technology, etc., without the need for a local agent.

In fact, the previous government did well by abolishing this type of fraud on public money through the local agent who doubled the cost by entrusting the project to a foreign company and obtained large profits.

What we need in Kuwait is a decisive executive decision that will bring the country into a major reconstruction revolution with all facilities, instead of just concrete slums, buildings and houses. It has been proven by experience that their owners do not live in many of them, and simply rent them out. In fact, some of them are empty.

Also, entertainment projects have been prevented, because some people affiliated with some parliamentarians hate seeing people enjoying and having fun.

Your Highness the Prime Minister, Kuwait needs a reconstruction revolution at all levels. At least one fifth of its sovereign wealth must be invested at home, because its risks are close to zero. It can be used to benefit the country. However, if we wait for the approval of any MP, it will be like we have done nothing, and the effort that we have been applying will be equal to zero.

Sources pointed out that cutting off water supply for those who defaulted on payment is part of the strategy of the ministry to collect debts from citizens, disclosing that KD435 million were collected during the current fiscal year.

Sources said the ministry asked the government agencies to quickly respond to its request to pay their electricity and water bills before the end of the fiscal year in order to avoid accumulating debt, to protect public money and to increase the collection rate. change.

CSC issues circular on requesting data from work centers

KUWAIT CITY, March 13: Director of the Civil Service Commission (CSC) Dr Issam Al-Rubaian issued a circular on requesting data or information from work centers in the CSC, reports Al-Anba daily.

The circular stated that officials, supervisors, and employees should not request for any data or information verbally; stressing this should be done through official memorandums approved by the concerned official or supervisor.

Al-Rubaian explained that the work centers in the CSC might need to exchange information among themselves to complete transactions and studies according to their jurisdiction, and this should be done through official memorandums.

He added: "The official memorandums must include the type of data or information required so these memorandums can be used as reference in the future -- when needed to determine the reasons and justifications for requesting the data, and the employees who have the data

Move to transfer employees

KUWAIT CITY, March 13: Civil Service Commission (CSC) Director Dr Issam Al-Rubaian recently met with officials at the Supreme Council for Provincial Affairs to lay down the procedures for implementing the Council of Ministers' decision to transfer the employees of the Supreme Council to various government agencies, reports Al-Anba daily quoting sources.

Sources revealed the decision covers 2,500 employees with different job grades; clarifying that the transfer process requires exception from the CSC because transfer between government agencies is still suspended; in addition to the need to provide financial grades suitable for those who will be transferred, including the first, second, third, fourth and fifth classes.

Sources said the transfer decision stipulates that the job grades, job designations, financial benefits and statuses will be retained; so the concerned employees will not be transferred according to the newly established financial grades, such as those for which the new graduates are appointed.

Sources added the issue will be presented to the CSC to take the appropriate decision; such that the transfer process does not affect the supervisory positions and promotion grades by choosing the entities to which they will be transferred.

Sources confirmed that the salaries of the 2,500 employees will be the same as they will be given the same financial and job grades in their new workplaces. and related documents."

Meanwhile, the latest statistics from the Public Authority for Housing Welfare (PAHW) revealed that the Citizens Service Department completed 49,288 transactions in February, including 246 new housing grant applications and 707 allocation transactions, reports Al-Anba daily.

The daily obtained a copy of the statistics, indicating that the abovementioned department opened 91 new files related to rented housing, while the Reception Department submitted 193 rental allowance transactions and issued 126 'To Whom It May Concern' certificates.

The Customer Service Telephone Unit at the Communications Department received 2,219 direct calls from citizens and responded to 22,244 inquiries through the chatbot service. The Statistics Unit at the Follow-up Department received 48 petitions that were forwarded to the Requests, Allocation, Distribution and Documentation sectors.

Navalny strategist attacked

'Russia ready to use N-arms if threatened'

MOSCOW, March 13, (AP): President Vladimir Putin said that Russia is ready to use nuclear weapons if there is a threat to its statehood, sovereignty or independence, voicing hope that the U.S. would refrain from actions that could trigger a nuclear conflict.

Putin's statement was another blunt warning to the West ahead of a presidential vote this week in which he's all but certain to win another six-year term.

In an interview with Russian state television released early Wednesday, Putin described U.S. President Joe Biden as a veteran politician who fully understands possible dangers of escalation, and said that he doesn't think that the world is heading to a nuclear war.

At the same time, he emphasized that Russia's nuclear forces are in full readiness and "from the military-technical viewpoint, we're

prepared." Putin said that in line with the country's security doctrine, Moscow is ready to use nuclear weapons in case of a threat to "the existence of the Russian state, our sovereignty and independence.'

The Russian leader has repeatedly talked about his readiness to use nuclear weapons since launching the invasion of Ukraine in February 2022. The

most recent such threat came in his state-of-the-nation address last month, when he warned the West that deepening its involvement in the fighting in Ukraine would risk a nuclear war.

Asked in the interview if he has ever considered using battlefield nuclear weapons in Ukraine, Putin responded that there has been no need for that.

Ĥe also voiced confidence that Moscow will achieve its goals in Ukraine and held the door open for talks, emphasizing that Russia will hold onto its gains and would seek firm guarantees from the West.


Russia kills 234 fighters: Ukrainian long-range drones smashed into two oil facilities deep inside Russia on Tuesday, officials said, while an armed incursion claimed by Ukraine-based Russian opponents of the Kremlin unnerved a border region just days before Russia's presidential election.

The attack by waves of drones across eight regions of Russia displayed Kyiv's expanding technological capacity as the war extends into its third year. The cross-border ground assault also weakened President Vladimir Putin's argument that life in Russia has been unaffected by the war, though he remains all but certain to win another sixyear term after eliminating all opposition.

The Russian Defense Ministry said that Mos-cow's military and security forces killed 234 fighters while thwarting the incursion. In a statement, the ministry blamed the attack on the "Kyiv regime" and "Ukraine's terrorist formations," insisting that the Russian military and border forces were able to stop the attackers and avert a cross-border raid.

Top strategist of Navalny attacked: Associates of late opposition leader Alexei Navalny said late Tuesday that the politician's close ally and top strategist was attacked near his home in Lithuania's capital.

Kira Yarmysh, who had been Navalny's spokesper-

In WH visit, Polish president pushes NATO to ramp up spending

Polish President Andrzej Duda used a joint White House visit with his political rival, Polish Prime Minister Donald Tusk, on Tuesday to call on NATO allies to significantly increase defense spending and press a divided Washington to break its impasse over replenishing funds for Ukraine at a critical moment in the war in Europe.

Duda wants members of the NATO alliance to raise their spending on defense to 3% of their GDP as Russia puts its own economy on a war footing and pushes forward with its plans to conquer Ukraine. Poland already spends 4% of its own economic output on defense, double the current target of 2% for NATO nations.

The Polish leader made the call as he and Tusk visited Washington to mark their country's 25th anniversary of joining the now 32-member transatlantic military alliance. It was a historic step into the West after breaking free from Moscow's sphere of influence after decades of communist rule.

The remarks by Frank Hester, chief executive of healthcare software firm The Phoenix Partnership, about Diane Abbott, the first Black woman elected to Parliament, were also blasted by opposition parties who said the Tories should return the 10 million pounds (\$12.8 million) he donated last year.

"The comments about Diane Abbott are just abhor-rent," Labour leader Keir Starmer told ITV. "This apology this morning that is pretending that what was said wasn't racist or anything to do with the fact she's a woman, I don't buy that I'm afraid, and I think that it's time the Tory Party called it out and returned the money."

Kate at the center of a media backlash: She's one of the most photographed women in the world. But attention on Kate, the Princess of Wales, hasn't reached this level since she married Prince William in a fairy-tale wedding in 2011.

An announcement from palace officials that Kate, 42, had unspecified abdominal surgery and would be out of sight for weeks triggered huge speculation and gossip about her health. But an admission from Kate that she altered an official family photo - one that's supposed to reassure the public that she is doing well - made things even worse.

Senior US official travels to Kosovo: A senior US official on Tuesday said he would be visiting Kosovo in the next days to put "back on track" talks on normalizing ties between Kosovo and Serbia, after tensions escalated over Kosovo's decision to ban the use of the Serbian dinar.

Deputy Assistant Secretary of State Gabriel Escobar said he would discuss with Kosovo authorities a possible resolution of the "uncoordinated decision" to ban Serbia's dinar and transfers from Serbia to citizens of Kosovo who depend on social services and payments.

Romania's president to enter race: Romania's president said Tuesday that he will enter the race to become the next leader of the 32-nation NATO military alliance, emphasizing his country's proximity to Ukraine and the threat from Russia.

President Klaus Iohannis wants to succeed Secretary-General Jens Stoltenberg, who has been NATO's top civilian official since 2014 and has made clear he will not be staying.

Romania, a NATO member since 2004, borders Ukraine and has played an increasingly prominent role in the alliance throughout Russia's full-scale invasion, including hosting a NATO meeting of foreign ministers in November 2022.

Uvalde police chief resigns: The Uvalde police chief who was on vacation during the Robb Elementary School shooting submitted his resignation Tuesday, less than a week after a report ordered by the city defended the department's response to the attack but outraged some family members of the 19 children and two teachers who were killed.

Uvalde Police Chief Daniel Rodriguez was in Arizona when a teen entered a fourthgrade classroom in Uvalde with an AR-style rifle on May 24, 2022. In his resignation letter, which did not mention one of the deadliest school shootings in US history, Rodriguez said it was time for a new chapter in his career.

"Together we achieved significant progress and milestones, and I take pride in the positive impact we've made during my tenure," Rodriguez wrote. He also thanked colleagues and said Uvalde will "always hold a special place in my heart."

The resignation is effective April 6. (AP)

Ex-US Rep Everett dies: Former Alabama Republican US Rep Robert Terry **Everett**, who represented the state's 2nd District from 1993 to 2009, died Tuesday, the governor's office confirmed. He was 87. Everett died peacefully in his sleep at his

home in Rehobeth, a suburb of Dothan, Gov Kay Ivey's office said.

The outcome of contests across Georgia, Mississippi and Washington state was never in doubt. Neither Biden, a Democrat, nor Trump, a Republican, faced major opposition. But the magnitude of their wins gave each man the delegate majority he needed to claim his party's nomination at the summertime national conventions.

Choices

Not even halfway through the presi-dential primary calendar, Tuesday marked a crystalizing moment for a nation uneasy with its choices in 2024.

There is no longer any doubt that the fall election will feature a rematch between two flawed and unpopular presidents. At 81, Biden is already the oldest president in US history, while the 77-year-old Trump is facing decades in prison as a defendant in four criminal cases. Their rematch - the first featuring two US presidents since 1912 - will almost certainly deepen the nation's searing political and cultural divides over the eight-month grind that lies ahead.

In a statement, Biden celebrated the nomination while casting Trump as a serious threat to democracy.

Trump, Biden said, "is running a campaign of resentment, revenge, and retribution that threatens the very idea of America.'

Honduras former first lady seeks presidency

TEGUCIGALPA, Honduras, March 13, (AP): Former Honduras first lady **Ana García de Hernández** said Tuesday, just days after her husband's U.S. drug traf-ficking conviction, that she plans to seek the country's presidency next year.

Ex-President Juan Orlando Hernández was convicted of conspiring with drug traffickers moving tons of cocaine to the United States in a federal court in



Manhattan Friday. On Tuesday, his wife said in a news conference: "I want to tell you that from this moment I will start an active and proactive fight for the world to know the injustice that was committed." She said she would do so by seeking the nomination of Hernández's National party.

Hernández, who maintained his innocence throughout his trial, could be sentenced to life in prison.

Garcia

"I know what has to be done, I know the job, I know the dedication and the fight my husband has had every day and I know Honduras' great needs, and one of the greatest is the injustice we've just seen," García de Hernández said

Marco Eliud Girón, a lawmaker from the ruling LI-BRE party, said that García de Hernández could run, but asserted that she surely knew of her husband's ties to drug traffickers. He suggested her entry into politics had more to do with reducing her own legal exposure.

After an intense session of international diplomacy in Jamaica, a group of Caribbean nations and the United States announced Tuesday that Haiti's best hope for calming violence rests with a council of influential figures who would elected an interim leader and could steer the country toward fresh presidential elections.

As they spoke to the media, a heavily armed gang leader held an impromptu news conference in Port-au-Prince and rejected any solution led and supported by the international community.


"Haitian people will choose who will govern them," Jimmy "Barbecue" Chérizier said Monday.

'4m face acute food insecurity in Haiti': Four million people face "acute food insecurity" and one million of them are one step away from famine, the U.N. food agency's director in the conflict-wracked Caribbean nation said Tuesday.

Jean-Martin Bauer told a virtual press conference that he's "ringing the alarm bell" because the recent increase in gang violence has made a very bad situation even worse and displaced an additional 15,000 people - just over the first weekend in March in the capital, Port-au-Prince.

That brings the total number of displaced people in Haiti to over 360,000, he said, and the U.N. says half of them are children. The country has more than 11 million inhabitants.

Bauer said, there were 4 million food insecure and hungry Haitians during the COVID pandemic in 2020 and that number hasn't gone down, but the number on the brink of famine has escalated to one million.

2 dead, dozens injured in suspected gas explosion outside Beijing

An explosion caused by a suspected gas leak ripped through a building in northern China on Wednesday, killing at least two people and injuring 26 others, authorities said.

The blast occurred early in the morning at a fried chicken shop in the city of Sanhe, authorities said in a short statement. The city is around 63 kilometers

(39 miles) east of Beijing. Police cordoned off streets 1 kilometer (over half a mile) around the explosion, Associated Press reporters saw, and were directing people away.

Fire engines were dispatched to the scene and a truck could be seen hauling away a burnt-out car with its windows gone. Most of the original building is gone, with only part of its frame remaining above piles of rub-ble. State broadcaster CCTV said 14 people were hospitalized, including two in serious condition.

Relatives of a person who had died told local news outlet Hongxing News that she was the owner of a guesthouse inside the building and that her husband was still missing. (AP)

'Wastewater discharge at Fukushima safe'

TOMIOKA, Japan, March 13, (AP): The head of the UN atomic agency told local Japanese representatives at a meeting in Fukushima on Wednesday that the ongoing discharge of treated radioactive wastewater at the ruined nuclear power plant has met safety standards and that any restrictions on products from the region are "not scientific."

International Atomic Energy Agency Director-General Rafael Grossi joined local officials and representatives from fishing and business groups and reassured them that the discharges are being carried out "with no impact to the environment, water, fish and sediment."

Grossi, who arrived in Japan on

Prosecutor with political ties selected as AG: Colombia's Supreme Court on Tuesday selected the nation's new attorney general following a month of deliberations that were interrupted by protests outside the court and complaints from President Gustavo Petro 's supporters, who argued the judges were stonewalling his nominees.

Ultimately the court selected Luz Adriana Camargo, a seasoned prosecutor with few political ties, as the country's lead prosecutor, with 18 of the 23 judges voting in favor. The attorney general in Colombia must be ratified by a two-thirds majority of the court, whose members are elected by the judicial branch.

Camargo will lead the Attorney General's Office, a branch of the Colombian state that has long been criticized for favoring its political allies and pursuing criminal investigations for political ends.

Though she is known to have worked closely with Colombia's defense minister, observers are hoping that Camargo can make the Attorney General's Office more independent and impartial.

2 detectives found safe in Mexico: Two federal detectives have been found unharmed after they went missing in Mexico's Pacific coast state of Guerrero while investigating the disappearances of 43 students almost 10 years ago.

Officials did not say Tuesday how the man and woman were found or whether they had been freed from captivity.

President Andrés Manuel López Obrador mentioned their disappearances over the weekend at his daily news briefing, noting, "I hope this is not related to those who do not want us to find the youths."

The disappearances were the latest sign of what appeared to be a generalized breakdown in law and order in Guerrero state, home to the resort of Acapulco. The state has been dogged for a decade by the disappearances of 43 students from a rural teachers' college in Guerrero in 2014 who are believed to have been abducted by local officials and turned over to a drug gang to be killed.

Rio police release 17 hostages: Brazilian police said Tuesday they released 17 hostages from a gunman that took over a crowded bus for three hours in Rio de Janeiro and wounded at least two people.

Rio police spokesman Col. Marcos Andrade told journalists all hostages aboard a bus parked at one of the city's main terminals had been freed after negotiations with the gunman, who allegedly wanted to leave Rio after receiving threats from a gang.

Andrade said the gunman claimed to have shot one of hostage he mistakenly believed was a policeman. Bruno Lima de Costa Soares, 34, is in serious condition, police said.

The bus was parked at the Sao Cristovao terminal in the city center and was scheduled to head to the neighboring state of Minas Gerais.

Police cars and ambulances could be seen waiting near the bus, while thousands of passengers were stranded waiting for information on scheduled travel.

People interviewed on TV said they heard several gunshots, causing panic inside the crowded terminal.

'Piracy attack off coast of Somalia':

Several people boarded and took control of a vessel in a suspected pirate attack in the Indian Ocean nearly 700 miles (1,100 kilometers) east of Somalia's coastal capital Mogadishu, the British military reported Tuesday.

The vessel was boarded by several people from two craft, "one large and one small," said a statement from the British military's United Kingdom Maritime Trade Operation. "Unauthorised persons now have control of the vessel," the statement said. It gave no other details.

British maritime security company Ambrey reported that 20 armed assailants took control of the vessel while it was going from the Mozambique capital Maputo to Hamriya in the United Arab Emirates.

Once-rampant piracy off the Somali coast diminished after a peak in 2011, but concerns about new attacks have grown in recent months. (AP)

Sudan army regains TV control: Sudan's military has said it regained control of the country's national radio and television headquarters on Tuesday from a rival paramilitary group it has been battling for

about a year. The paramilitary Rapid Support Forces seized the headquarters of Sudan's Radio and Television in the first weeks of Sudan's conflict which broke out in April last year after long-simmering tensions between its commander and the head of the military.

In a statement midday Tuesday, the military said it took over the headquarters buildings in the city of Omdurman from RSF fighters who fled the area. It also posted footage online showing its soldiers inside the headquarters. (AP)

The Dewi Jaya 2 was on its way from a port in Jakarta to Lombok Island near Bali carrying tons of fish when it was overwhelmed by high waves during stormy weather after midnight on Saturday, the National Search and Rescue Agency said in a statement.

The vessel capsized in the Gulf of Bone about 52 nautical miles from the port of Benteng in the Selayar island chain off South Sulawesi province, the statement said. After local fishers reported the accident on Sunday, rescuers found 11 survivors including the captain stranded in various places in the Selayars. They also found two bodies there.

Boursa Kuwait witnesses collective rise

KUWAIT CITY, March 13: In yesterday's trading session, the Kuwait Stock Exchange witnessed a collective rise in its indices following several sessions of varied performance, reports Al-Anba daily.

This upward trend boosted the market's capital value to 44 billion dinars, with circulating liquidity reaching approximately 40.05 million dinars.

The surge in indices was fueled by purchasing activities and the establishment of positions across a broad spectrum of selected stocks, particularly in the first market, which comprises the leading stocks on the exchange.

The Premier Market index climbed by approximately 35.33 points, marking a 0.43% increase to reach 8,195.32 points, setting a new peak for the market.

Oil prices steady above \$80 amid mixed data

Crude oil prices remained elevated and traded in a tight range over the last few weeks on mixed economic data, geopolitical concerns as well as controlled oil supply. Temporary support also came after data from China showed higher y-o-y import of crude oil in China during January-2024 and February-2024, although total imports were smaller than previous months, indicating a declining trend in purchase by China. This comes as concerns continue to remain on extended economic weakness in China despite several measures and sops offered by the government over the last few months.

A sneak into softer demand trend was also seen when Russia decided to lower production during Q2-2024 based on expectation for global oil demand growth. The country has kept its production target for the year at 9.5 mb/d and slashed production during Q2-2024 by 471 tb/d. A report from Bloomberg showed that Russia plans to cut output by 350 tb/d in April-2024 but increase exports from planned cuts of 500 tb/d to 121 tb/d. Cuts in May-2024 is planned at 400 tb/d and export curbs of 71 tb/ds while the entire 471 tb/d of cuts in June-2024 will come from output reduction.

On the other hand, prices of refined products could come under pressure in the coming weeks after several incidents of disruptions at a number of global refineries. This includes the fire at ExxonMobil's Port Jerome refinery in France, TotalEnergies halt of a refining unit section in France, hiccups at BP's refinery in Whiting, the drone attacks on Russian oil refineries over the last week and a pipeline leak and subsequent unit shutdown of TotalEnergies refinery in Texas. In addition, late last month, Russia announced a six-month ban on gasoline exports starting March-2024 aimed at keeping prices stable in the domestic market. The aforementioned was reflected in the prices of gasoline in the US that is up more than 20% this year while diesel prices in Europe are up by 10%. The shortages of refined products are somewhat offset by exports from Nigeria's Dangote refinery, although the refinery is yet to reach peak capacity. Moreover, China is also seeing an increase in exports of refined products due to weakness in the domestic market.

In terms of production, data from the US showed a small decline of 100 tb/d in crude oil output that reached 13.2 mb/d during the week ended 1-March-2024 after staying elevated at 13.3 mb/d for the previous five weeks. Oil output from the OPEC group increased slightly mainly led by resumption of production in Libya that more than offset decline in bigger producers in the group. **Oil Prices**

Crude oil futures traded in a very tight range over the last few weeks above the USD 80/b level. Prices reached around USD 83/b on 12-March-2024 mainly reflecting geopolitical issues in the Red Sea as well as disruption in Russia. The options on crude oil indicate bullish bets at prices of over USD 90/b in the months ahead, according to data from Bloomberg, betting on curtailed supplies from OPEC and increase in demand. The extension to OPEC+ cuts until the end of Q2-2024 had only a minimal impact on prices as speculations on lower-than-expected demand in China offset the impact. Expectations of weak economic growth in China capped further gains although exports during the first two months of the year showed y-o-y growth. These trends were also seen in the demand for jet fuel in China. The latest Bloomberg weekly report showed a marginal dip in global passenger jet fuel demand after growth in Eastern Europe, North America and Sub-Saharan Africa offset by decline in other regions, mainly China. Oil prices were also affected by the lack of clarity on the future course of rate cuts in the US with data largely pointing to a delay in cuts that what was expected at the start of the year as well as speculation over the number of cuts this year. Meanwhile, the latest data on US job market showed that job growth accelerated in February-2024; however, an increase in unemployment rate and moderation in wage gains indicates that a rate cut is still possible in June-2024. Prices of almost all crude grades reported gains for the second consecutive month during February-2024. Average spot brent crude oil price was up by 4.5% to reach USD 83.9/b during February-2024 as compared to USD 80.3/b during January-2024. The gain in average OPEC reference basket price was much smaller at 1.5% to reach USD 81.2/b while Kuwait export grade crude witnessed a marginal monthly gain of 0.3% to average at USD 81.1/b during February-2024. Meanwhile, the consensus estimate for Brent crude underwent minimal changes from last month's forecast with prices expected to average at USD 82.3/b in Q1-2024 and show gradual growth until Q4-2024 to reach USD 84/b. Price forecasts from the US EIA showed a steep upgrade for Brent which is forecasted to reach USD 87.0/b in 2024 vs. USD 82.42/b in the previous forecast.

upward revision to demand data for India and Other Asia regions reflecting higher demand during the quarter fully offset the downward revision. For 2025, demand growth forecast was also kept unchanged at a growth of 1.8 mb/d with demand expected to average at 106.3 mb/d during the year.

Oil demand in the US is expected to be supported mainly by transportation fuels and light distillates. According to OPEC, US oil demand is expected to increase by 168 tb/d during 1H-2024 mainly backed by demand for jet/kerosene, gasoline and LPG that would be partially offset by subdued demand for diesel as the industrial/manufacturing sector remains showed contraction. For OECD Europe, recent forecasts shows slight economic improvement towards the close of the year. Once again, demand is expected to be supported by transportation and air travel activity.

Oil demand in China showed growth with total imported crude oil increasing by 5.1% y-o-y during January-2024 and February-2024 to reach an average of 10.74 mb/d led by higher buying by refiners to meet rising demand during lunar new year holiday. Demand for aviation fuel and gasoline was high during January-2024 that flowed through February-2024 that resulted in higher refinery runs from state refiners. Private independent refiners, however, lowered run rate in February-2024 due to thinning margins. Demand in India also increased during February-2024, according to oil ministry data. Fuel consumption in the country increased by 5.7% y-o-y during February-2024 to reach 4.98 mb/d led by strong factory activity during the month. The m-o-m increase came in at 5.1% as compared to total consumption of 4.74 mb/d in January-2024. Demand for all refined products saw growth during the month including gasoline, diesel, fuel oil and LPG.

World Oil Supply

Non-OPEC oil supply (liquids production) growth forecast for 2024 was once again lowered by 120 tb/d by the OPEC in its latest report. Supply is now expected to grow by 1.1 mb/d and average at 70.5 mb/d, including 50 tb/d of processing gains. The downward revision reflected the recently announced extension of additional voluntary production cuts by OPEC+ countries until the end of Q2-2024. The revisions included downward revisions to supplies from Russia (-95 tb/d), Kazakhstan (-13 tb/d) and Oman (-10 tb/d). The latest monthly short term outlook report from the US EIA suggested even higher output from the US this year. As per the report, crude oil output is expected to increase by 13.19 mb/d in 2024 vs. previous forecast of 13.1 mb/d followed by 13.65 mb/d in 2025.

Crude oil exports from Russia witnessed a spike recently, despite the announcement of further cuts as per the OPEC+ agreement. A Bloomberg report showed that seaborne crude exports increased to the highest level this year from the Pacific port of Kozmino during the week of 10-March-2024 following disruptions in loading due to a storm during the previous week. In addition, crude oil shipments that were previous meant for Indian consumers and were shunned due to implementation of US sanctions is said to be getting buyers especially from private refiners in China.

For 2025, non-OPEC liquids supply growth forecast stood at 1.4 mb/d and total supply is expected to reach 71.9 mb/d during the year. The forecast for 2025 was largely unchanged and reflected the change in base for 2024 **OPEC Oil Production & Spare Capacity** After seeing a steep decline in output during January-2024 led by the implementation of new production cuts, OPEC oil output remained subdued at one of the lowest in the last few months but witnessed a marginal growth during February-2024. Total crude oil production averaged at 26.7 mb/d with a m-om increase of 110 tb/d during February-2024, according to data from Bloomberg. Data from OPEC secondary sources showed a much bigger production growth of 203 tb/d during the month to reach an average rate of 26.57 mb/d backed by a similar trend. The increase was mainly led by higher production in Libya further supported by growth in Venezuela and Nigeria. However, a decline in production mainly in Iran and Iraq partially offset the overall growth. Crude oil output from Saudi Arabia, UAE and Kuwait were almost flat m-o-m aimed at compliance to the OPEC+ quotas. During the month, in a move to maintain the stability in oil prices, OPEC+ producers extended the voluntary oil output cuts of 2.2 mb/d until the end of June-2024 highlighting concerns over global economic growth as well as higher output outside the OPEC+ group. As per the announcement, Saudi Arabia would extend its voluntary cut of 1.0 mb/d until June-2024 and produce at the current rate of around 9.0 mb/d. Russia said it would slash total production and export by an additional 471 tb/d during Q2-2024. The biggest monthly growth in production in February-2024 was seen in Libya with average production reacharound 1.1 mb/d after seeing a growth of more than 100 tb/d during the month. The growth came after the country restarted production from its biggest oil field after a two week shutdown. Libya's NOC also announced the resumption of exploration in the Ghadames basin next April by a

Kuwaiti depositors shift 3.34 billion dinars in Jan

Private sector sees surge in high-interest deposits

KUWAIT CITY, March 13: According to data released by the Central Bank of Kuwait, depositors shifted deposits totaling 3.34 billion dinars in January, resulting in a total deposit amount of 37.6 billion dinars for residents and non-residents in the banking system, reports Al-Jarida daily. terest rates greater than 4.5 to 5%, which increased by 23.7%, totaling 6.17 billion dinars.

In terms of private sector deposits denominated in Kuwaiti dinars, there was a notable increase in deposits with interest rates ranging from greater than 3.5% to 5%, attracting approximately 3.3 billion dinars. Conversely, deposits with interest rates up to 2% saw the largest decline, totaling 2.7 billion dinars.

Among the deposits that experienced an increase, those with interest rates greater than 4 to 4.5% showed a significant rise of 33.6%, reaching 7.25 billion dinars by the end of January; following closely were deposits with in-

than 3% to 3.5% increased by 8.6%. Deposits with interest rates greater than 2% to 2.5% also saw a rise of 5.14%.

On the other hand, deposits with interest rates up to 2% witnessed a significant decrease of 28%, totaling 6.9 billion dinars.

Similarly, deposits with interest rates greater than 5 to 5.5% decreased by 16.6%, and deposits with interest rates greater than 5.5 to 6% declined by 36.9%.

Demand deposits experienced a withdrawal of approximately 130.6 million dinars, while deposits with interest rates greater than 2.5% to 3% decreased by 50.89%. Deposits with interest rates greater than 6% also saw a decline of 16.7%.

These shifts in deposit values reflect changing trends and preferences among depositors in the Kuwaiti banking system.

Solar focus in Kuwait's renewable energy agenda

Kuwait unveils ambitious renewable energy strategy with 22.1 GW capacity by year 2030

KUWAIT CITY, March 13: During a recent event in Kuwait, Minister of Electricity, Water, and Renewable Energy Salem Al-Hajraf outlined the nation's new renewable energy strategy spanning from 2030 to 2050, reports Al-Qabas daily.

The plan aims to achieve an installed renewable energy capacity of 22.1 GW by 2030, with a focus on solar energy farms.

The strategy emphasizes citizen participation in energy production while aligning with environmental objectives to achieve carbon neutrality, in accordance with the Emir's directives.

Additionally, the Ministry of Electricity and Water, through the Public-Private Partnership Projects Authority, has initiated the procurement process for the 1,100 MW Independent Solar Power Production Program. Despite some delays, Kuwait remains committed to advancing its renewable energy agenda, with ongoing projects and future plans set to transform its energy landscape.

Kuwait aims to have an installed renewable energy capacity of 22.1 GW by 2030, as part of a new 20-year strategy ending in 2050.

Al-Hajraf said that the strategy includes installing solar energy farms, where the state purchases energy production from solar photovoltaic farms.

This step aims to allow citizens to participate in energy production while "taking into account environmental aspects in implementing the Emir's directives regarding carbon neutrality."

MEED reported in October last year that Kuwait was expected to begin issuing requests for quotations for the next 4,500 MW phases of the Shaqaya renewable energy project by the end of the year.

The second phase will include a 200 MW concentrated solar power plant with a storage capacity of about five hours. The third phase will include an independent solar energy project with a capacity of 1,500 MW, and the final phase will be an independent solar energy project with a capacity of 1,700 MW.

Meanwhile, the Kuwait Institute for Scientific Research, in partnership with the Ministry of Electricity, has developed the first phase of the renewable energy development project. This consists of a 50 MW concentrated solar power plant and a wind and solar PV plant, each with a capacity of 10 MW.

Further delays are expected in the \$16 billion project to deliver alternative feeding systems for the hydrogen production unit at the Al-Zour refinery.

MEED reported that uncertainty over details regarding the scope of the project led to a study being conducted to determine how the refinery would process heavy oil and the exact specifications of several different units.

One source told the magazine: "There have already been a lot of delays in the tender process, and it seems likely that there will be more to come. Contractors will need to see the results of the ongoing study before they can submit their bids."


The project is being proposed by the Kuwait Integrated Petroleum Industries Company (KIPIC), which recently announced that it extended the deadline for submitting bids to April 14 from the previous date of March 12.

The deadline for submitting bids have been extended several times since the project was first proposed last year, with the deadline for submitting bids set for June 20, 2023.

The scope of the contract includes engineering, procurement and construction (EPC) works, in addition to works covering pre-commissioning, commissioning and quality testing.

World Oil Demand

Global oil demand growth forecast for 2024 was kept unchanged by the OPEC in its latest monthly report at 2.2 mb/d with demand expected to average at 104.5 mb/d during the year. However, adjustments were made to demand growth data for OECD Asia for Q1-2024 with a downgrade due to expected lower performance in the manufacturing and petrochemical sectors in Japan and South Korea. However, an polish oil company. Oil production in Iraq witnessed a marginal drop during the month and averaged at 4.2 mb/d. However, the output remained above the quota by around 0.2 mb/d. A recent news also showed that the country is in talks with oil companies to resume crude oil exports via Turkey and make amendments to its budget to pay recovery and transit fees. However, oil companies in the semi autonomous region of Kurdistan have denied any such proposals for the resumption of exports.

Europe's world-first Al Germany Taunches' bidding process for carbon contracts

Germany 'launches' bidding

BERLIN, March 13 (AP): Germany's vice chancellor on because companies will be bidding Tuesday launched a program initially worth up to 4 billion euros (\$4.4 billion) to help heavy industry shift to more climate-friendly production over a 15-year period. Germany, which is home to many energy-intensive industries as Europe's biggest economy, aims to cut its greenhouse gas emissions to net zero by 2045. The government, which says industry accounts for about one-fifth of the country's emissions, says Germany is the first in the European Union to launch the so-called "carbon contracts for difference.' Companies in areas such as paper, glass, steel and chemical production have four months to bid for support under the contracts, which are supposed to compensate for the extra costs of climate-friendly production processes where they otherwise would not be competitive. Support will be capped at 1 billion euros per bidder in an effort to accommodate medium-sized companies. The government says that switching to new production methods is essential but currently comes with high costs and risks that put companies off investing in them - for example, uncertainty over future hydrogen prices. Vice Chancellor Robert Habeck, who is also Germany's economy and climate minister, said the contract system compares with a cumbersome existing application process for support that can take three years to complete.

He said it is "super cost-efficient" to make carbon-neutral production as economically as possible

Here's what happens next

LONDON, March 13, (AP): European Union lawmakers are set to give final approval to the 27-nation bloc's artificial intelligence law Wednesday, putting the world-leading rules on track to take effect later this year.

Lawmakers in the European Parliament are poised to vote in favor of the Artificial Intelligence Act five years after they were first proposed. The AI Act is expected to act as a global signpost for other governments grappling with how to regulate the fast-developing technology.

"The AI Act has nudged the future of AI in a human-centric direction, in a direction where humans are in control of the technology and where it - the technology - helps us leverage new discoveries, economic growth, societal progress and unlock human potential." said Dragos Tudorache, a Romanian lawmaker who was a co-leader of the Parliament negotiations on the draft law.

Big tech companies generally have supported the need to regulate AI while lobbying to ensure any rules work in their favor. OpenAI CEO Sam Altman caused a minor stir last year when he suggested the ChatGPT maker could pull out of Europe if it can't comply with the AI Act - before backtracking to say there were no plans to leave.

Here's a look at the world's first comprehensive set of AI rules:

Like many EU regulations, the AI Act was initially intended to act as consumer safety legislation, taking a "risk-based approach" to products or services that use artificial intelligence.

The riskier an AI application, the more scrutiny it faces. Low-risk systems, such as content recommendation systems or spam filters, will only face light rules such as revealing that they are powered by AI. The EU expects most AI systems to fall into this category

High-risk uses of AI, such as in medical devices or critical infrastructure like water or electrical networks, face tougher requirements like using high-quality data and providing clear information to users.

"For the companies, there is the advantage of being able to plan and calculate with a fixed, green energy price over 15 years," he added.

Bidding for the first round of support is limited to firms that went through a preparatory procedure last summer. Companies must state how many euros it will take them to avoid a ton of CO2 emissions with new technology. Habeck's Economy Ministry

hopes that a second round of bidding for support totaling up to 19 billion euros will take place at the end of the year.

The Federation of German Industries welcomed the launch. It said that "extensive state support is necessary if the politically desired transformation to climate neutrality is to succeed in a short time.'

The head of Greenpeace Germany, Martin Kaiser, said that the new contracts could only help modernize industry if they support companies that emit no CO2 by using modern technology and clean energy.

But if "designed wrong, carbon contracts for difference stand completely in the way of this transition" by chaining the country to old, climate-damaging technology, he argued in a statement.

The group has criticized plans Habeck, a member of the environmentalist Green party, announced last month to enable underground carbon storage at offshore sites.

AfDB chief criticizes opaque loans tied to Africa's natural 'resources'

LAGOS, Nigeria, March 13, (AP): The head of the African Development Bank is calling for an end to loans given in exchange for the continent's rich supplies of oil or critical minerals used in smartphones and electric car batteries, deals that have helped China gain control over mineral mining in places like Congo and have left some African countries in financial crisis.

"They are just bad, first and foremost, because you can't price the assets properly," Akinwumi Adesina said in an interview with The Associated Press in Lagos, Nigeria, last week. "If you have minerals or oil under the ground, how do you come up with a price for a long-term contract? It's a challenge." Linking future revenue from natural resource exports to loan paydowns is often touted as a way for recipients to get financing for infrastructure projects and for lenders

to reduce the risk of not getting their money back.

The shift to renewable energy and electric vehicles has caused a spike in the demand for critical minerals, driving these kind of loans. That includes a China-Congo deal that strengthens Beijing's position in the global supply chain for EVs and other products as it taps into the world's largest reserves of cobalt, a mineral used to make lithium-ion batteries, in the impoverished central African country.

Adesina, whose Abidjan, Ivory Coast-based institution helps finance development in African countries, said these arrangements come with a litany of problems.

He highlighted the uneven nature of the negotiations, with lenders typically holding the upper hand and dictating terms to cash-strapped African nations. This power imbalance, coupled with a lack of transparency and the potential for corruption, creates fertile ground for exploitation, Adesina said.

"These are the reasons I say Africa should put an end to natural resourcebacked loans," Adesina said. He pointed to a bank initiative that helps "countries renegotiate those loans that are asymmetric, not transparent and wrongly priced.'

Adesina said loans secured with natural resources pose a challenge for development banks like his and the International Monetary Fund, which promote sustainable debt management. Countries may struggle to get or repay loans from these institutions because they have to use the income from their natural resources - typically crucial to their economies - to pay off resource-tied debts, he said.

Argentina inflation slows

BUENOS AIRES, Argentina, March 13, (AP): Argentina's inflation slowed in February for a second consecutive month, as right-wing President Javier Milei continues to push austerity and deregulation measures in an effort to revive the country's struggling economy.

According to figures released Tuesday by the government's INDEC statistics agency, Argentina's monthly inflation slowed down to 13.2% in February, compared to 20.6% in January and 25.5% in December. On a yearly basis, however, inflation remains the highest in three decades. topping 276.2% in February.

Government officials and analysts foresee a surge in prices in March due to a combination of increases in the price of energy, fuel, private education and medical services, among others

Milei's government said in a state-

ment that February's inflation rate was the result of a "strong fiscal discipline.'

A self-described anarcho-capitalist, Milei assumed power in December and almost immediately announced a series of shock measures, including a 50% devaluation of the nation's currency in hopes of eventually bringing the country's roaring inflation under control.

As part of those measures, the government eliminated some state subsidies in energy and transport.

Milei has announced a painful adjustment plan aimed at staving off hyperinflation and warned that the measures would initially have a "negative impact on the level of activity, employment, real wages, and the number of poor and indigent people." It is estimated that around 40% of the population live in poverty.

Segment omission sparks criticism in Ukraine

Oscars international broadcast cuts '20 Days in Mariupol' win

KYIV, Ukraine, March 13, (AP): The shortened version of the international broadcast of the 96th Oscars faced harsh criticism in Ukraine for omitting the segment announcing the documentary feature award, which went to Mstyslav Chernov's "20 Days in Mariupol."

The documentary, a collaboration between The Associated Press and PBS' "Frontline," is a harrowing first-person account set in the Ukrainian port city during the early days of Russia's invasion in 2022.

Ukraine's public broadcaster Suspilne, the exclusive broadcaster of the Oscars in the country, published a statement of indignation on Monday.

"Our team was shocked and deeply disappointed when we did not see the category for Best Feature Documentary in the international version, where 20 Days in Mariupol was justly awarded," said Lukian Halkin, executive producer of the Suspilne Kultura TV channel.

According to Disney, the official international licensing agent for the Academy of Motion Picture Arts and Sciences, decisions were made weeks in advance of Sunday's telecast on which portions and categories to omit for the condensed version of the show.

Variety

International licensees receive two versions of the broadcast: the live version and a 90-minute version, produced by the film academy. The truncated version - which does include a recap of the cut winners, including "20 Days in Mariupol" - is often preferred by international broadcasters, Disney says. Suspilne said that instead of the shortened version, it is broadcasting Ukrainian viewers the unedited cut.

"Mstyslav Chernov's powerful speech emphasized the unity between Ukraine and the world, which makes it all the more disappointing to see this episode full of truth and power excluded from the version distributed to the Oscar's global licensees," Halkin said.

The film academy did not immediately respond to a request for comment on the decision to cut the documentary category.

The edited version also sparked criticism on various social media platforms in Ukraine, where the documentary's Academy Award was hailed as a bittersweet but welcome victory

"The fact that Ukraine received its first Oscar, and that the world will see again the horrors that the Russian army committed in Mariupol, is certainly a victory of truth over falsehood," Oleksii Kurka, a Kyiv office worker, told the AP.

The AP team of Chernov, photographer Evgeniy Maloletka and producer Vasilisa Stepanenko arrived an hour before Russia began bombing the port city. Two weeks later, they were the last journalists working for an international outlet still in the city, sending crucial dispatches to the outside world showing civilian casualties of all ages, the digging of mass graves, the bombing of a maternity hospital and the sheer extent of the devastation.

The Oscar - and the nomination - was a first for both Chernov, an AP video journalist, and the 178-year-old news organization. The documentary was a joint production of the AP and PBS' "Frontline." It was the first win for "Frontline" after two previous nominations.

Statuettes were awarded to Chernov, producer and editor Michelle Mizner and producer Raney Aronson-Rath. Maloletka, Stepanenko and Derl McCrudden, an AP vice president and credited producer on the film, were among those onstage to accept the award.

"We can make sure that the history record is set straight and the truth will prevail, and that the people of Mariupol, and those who have given their lives, will never be forgotten," Chernov said from the Oscar stage. "Because cinema forms memories and memories form history.

LOS ANGELES: Hollywood has been able to put on a show of happiness and something akin to normalcy as it struggles to shake off the effects of the dual strikes and one of the most tumultuous years in industry history.

Yet Sunday's Academy Awards didn't sidestep the labor strife that left its screenwriters and actors out of work for much of 2023. The acknowledgment - prominent amid muted acknowledgment of the strikes during other awards shows this season - comes as behind-thescenes crews could be next to challenge studios, and video game actors may be weeks from their own strike.

In front of an enormous global audience, Oscars host Jimmy Kimmel devoted part of his opening monologue toward vowing to union members and those working behind the scenes that Hollywood's stars would stand with them - repayment for those workers supporting actors during the strike that brought much of the entertainment industry to a standstill last year.

"We fully support them, obviously, as they did us," said Fran Drescher, the president of the actors guild, told The Associated Press on the Oscars red carpet. Kimmel took the opportunity to

shine an even bigger light on the matter. "For five months, this group of

writers, actors, directors, the people who actually make the films said 'We will not accept a deal' ... well, not the directors, you guys folded immediately," Kimmel said during the show, mixing a bit of humor in. "But the rest of us said we will not accept a deal without protections against artificial intelligence."

That's when he thanked the workers in Hollywood now embroiled in a labor fight of their own, bringing dozens of truck drivers, lighting workers, gaffers, grips and more onto the stage as a thank-you. "Thank you for standing with

us," Kimmel said. "And also, we want you to know that in your upcoming negotiations, we will stand with you too.'

There was a time when the Academy Awards would have been the last place for an expression of solidarity like Kimmel's. The guilds in the current labor struggles formed in the 1930s in large part because of fears that

NEW YORK, March 13, (AP): Just in time for election year, a new Max series called "The Girls on the Bus" follows female journalists who are part of a traveling press corps with presidential candidates on the campaign trail.

These candidates are fictional but may be a reminder to people more familiar. They include Felicity Walker - played by Hettienne Park - who came close to winning the presidency four years prior and is trying again, and Hayden Wells Garrett, an "aweshucks" widower war vet who is mayor of a Midwest town and considered a longshot. Scott Foley plays candidate Garrett. Mark Consuelos recurs as an action star seeking to add the role of president to his credits. The series premieres Thursday.

Julie Plec ("The Vampire Diaries") executive produces and co-created the show with Amy Chozick, who wrote "Chasing Hillary" in 2018, about following Clinton's presidential pursuits for the New York Times.

"You can literally equate this presidential election and the state of American politics over the last decade to the worst reality show you've ever had to sit through," said Plec in a recent interview. "To be able to embrace that idea and put it into this show does make it feel really of the moment and yet also timeless.

Melissa Benoist produces and stars as Sadie Mc-Carthy, a newspaper reporter who romanticizes old school journalists by often wearing a short-brim fedora and imagining conversations with Hunter S. Thompson. When Sadie's not taking calls from her editor, played by Griffin Dunne, who demands "get me copy," she befriends three other female journalists on the road.

Grace, played by Carla Gugino, is a respected seasoned reporter who has a knack for getting exclusives but whose relationship with her daughter has suffered because she's rarely home. There's also Kimberlyn, a Black on-air reporter at a conservative cable news outlet, played by Christina Elmore. Lola,

portrayed by Natasha Behnam, is the newbie of the group who works in new media, often going live on TikTok and writing a Substack newsletter. She scoffs at the traditional journalism practices of the other women.

Riveting blend of politics, journalism and mystery

'Girls on the Bus' takes you on soapy ride

Benoist was first approached about the series after she had wrapped a six-season stint as "Supergirl." She was enjoying the break by taking her son to the park when she got a call about "The Girls on the Bus."

"I've always considered myself a really informed citizen," said Benoist. "I still get a hard copy of the New York Times every day. But I did not know anything about the field. And I have to say, I have such a newfound respect for journalism and political journalism, especially the people that are on the campaign trail. I look at my news so differently now, and I really loved learning about it."

Documentary

To prepare, Chozick gave Benoist a list of materials to check out, including Alexandra Pelosi 's "Journeys with George," a documentary from her time as an embed covering then-Texas Gov. George W. Bush's run for president in 2000. Chozick also suggested the book "What it Takes: The Way to the White House" by Richard Ben Kramer. "I went through withdrawal when I was done with that book," said the actor.

"I see so much more than a byline now on an article, and I'm so glad to have that perspective. Now I digest news very differently.3

Aside from media and politics, Benoist and Gugino's favorite thing about the series is that it underscores the relationship of the core four women.

"You have these complicated, interesting women who all come from different backgrounds, different ideologies, different generations, and they are theoretically competitors, yet ultimately end up valuing each other over any of that," said Gugino.

"Women supporting each other goes so much further than being pitted against each other," adds

Benoist.

Throughout the episodes, the characters debate journalism ethics and ideologies and whether text, video or digital is the best medium. Behnam's character Lola declares, "Print is dead. Cable is for old people." Lola argues that the others are too rigid in beliefs that are unrealistic because a bias is only natural on some topics.

"We wanted to create journalists from all different walks of life is because we get to have those debates that are happening in every newsroom in America and every journalism school," explained Chozick. "Lola is arguing a point I've heard young journalists make or aspiring journalists make, that objectivity is sort of a myth. It's impossible not to bring your own perspectives into a story.'

Elmore says her role made her more aware of the potential hurdles a Black conservative journalist can encounter

"I can't imagine what an othering experience that must be for her to be someone who does have conservative values and conservative political point of view but also believes in the innate value of who she is and her perspective.'

"The Girls on the Bus" isn't all about scoops and deadlines, but there is a central mystery about a secret source that weaves throughout and intensifies deeper into the season. It also explores the characters' relationships and family drama and shows unvarnished moments with the candidates, which was particularly enjoyable for Foley.

"I like the duality of my character. I don't even know if they know what they're going to do next season, but I'm interested to find out where it goes,' said Foley, who noted the dual sides of his characters in "Felicity" and then "Scandal."

"Playing Noel years ago allows me to play these characters because producers and audiences of a certain age now, they think of Noel and they don't think, 'Oh, there's going to be a turn,' you know," Foley said.

the newly founded Academy of Motion Picture Arts and Sciences would become a cartel of studios used to keep pay low. In September, the game actors overwhelmingly gave their leaders the authority to call a strike against the collective of gaming companies that hire them. They last walked off the job for six months in 2016 and 2017. (AP)

Sora ... Al revolutionary text-to-video tool

Transforming text into high-quality clips at unprecedented speed

KUWAIT CITY, March 13, (KUNA): **OpenAI** has finally unveiled Sora, an artificial intelligence tool that transform text instructions into video, another step in the AI realm.

The launch of Sora, which means sky in Japanese language, created an uproar amongst media industry and social media in the US, while the Washington Post commented this move would pave way for producing high-quality video clips from scratch.

Kuwait News Agency (KUNA) analyzed videos generated by OpenAI and showed high-definition (HD) minute-long clips, only produced by inserting texts. OpenAI, backed by Microsoft, said Sora could gener-

ate videos from still photos in addition to adding visual contents.

It said Sora was in a testing phase to assess critical areas for harms or risks, but was grating access to a number of visual artists, designers and filmmakers to give feedback to help develop the model to the most helpful for creative professionals.

OpenÂI CEO Sam Altman urged users outside OpenAI to present proposals on how to produce videos and to give the public an idea on capabilities of AI.

OpenAI invented the ChatGPT, GPT-4 and Dall-E. It took a further step and offered Sora, giving the company another leap towards AI.

Although AI-generated videos were already produced by tech giants Meta and Google the past year, videos produced by Sora in terms of quality, accuracy and length were at another level and generated within a minute of the request

Sora produced a clip on the following text: a girl walking in a Tokyo street filled with colorful and warm lights, and moving signs .. the girl wears a black leather jacket, covering a long red dress and wears black shows .. the girl carries black purse, wears sunglasses, wears lipstick, and walks in a confident way on a wet street, reflecting lights from above .. many people walk in this street.

One of the complicated description that Sora produced was a scene of the gold frenzy in the State of California, US, in 1848, as well as a clip of an old lady blowing candles, and archeologists discovering a plastic chair in the desert and taking extra care in cleaning it.

Another challenging text was: Beautiful, snowy Tokyo city is bustling. The camera moves through the bustling city street, following several people enjoying the beautiful snowy weather and shopping at nearby stalls. Gorgeous sakura petals are flying through the wind along with snowflakes.

The Tokyo scene showed how Sora believed that these scenes were real and depicted accurate camera movement.

Sora is another breakthrough in AI, revolving around algorithm processing huge quantities of data through network engineering enabling machines to break AI barriers to go beyond self-learning to thinking, imagining, analyzing, visualizing and listening to voices and generate reactions.

Rehab Ismail, Multimedia professor at the American University in Cairo (AUC), predicted Sora to make quick steps to digital media and to replace existing programs used to produce videos, documentaries and videographics

"Journalists in newsrooms always look for new ways to produce videos and attract the public. And they already started producing AI photos and now we have videos ... the future is open to all possibilities," she told KUNA in an interview

"We need lots of experiments to learn how to finesse the new skill and use it in newsrooms. In a short time this technology will be the normal even for the regular user," she said.

"The world is changing remarkably fast which adds additional responsibilities on journalists to develop their skills in order to absorb this change," added Ismail.

Media organizations, she added, were worried about this expansion of technology particularly regarding "intellectual property," one of the pressing questions about the spread in using AI.

Ismail said there "are no real laws organizing intellectual property rights when we talk about content of AI products. "Training AI on using work of others withing compensating them is a big problem that needs intensive research by academic and media institutions," she added.

There are other challenges facing the public as well including misinformation and disinformation, facing a dilemma on what to believe.

Ahmad Esmat, a professor of information technology at AUC, voiced concern that Sora would contribute to spread of "deepfake," especially during elections and conflicts.

Speaking to KUNA, Esmat, a specialist in verifying digital information, warned media institutions because "flood of AI" lacked proper investments aimed at verifying the contents.

Experts said humanity has only seen a fraction of what AI could do.

"I did not expect to see this level of ongoing video production in two or three years from now," Ted Underwood, an Information Technology professor at University of Illinios, told Washington Post reacting to capabilities of Sora.

A new study, prepared by tens of researchers in work-shops hosted by Chatham House, expected AI to dominate news production and digital content by 2026.

The study did not recommend a confrontation with AI but using it to make media more efficient, amidst regional and international conflicts affecting media jobs worldwide

NBC news channel expected Sora to affect around 25 percent of video and movie industries in the US in 2026.

Observers said it was hard to predict AI influence on future of media but anticipate this year to be decisive in spread of AI applications which few years ago were only fantasies.


obesity imperative to prevent kidney failure

CLEVELAND, March 13: While anybody can develop chronic kidney disease (CKD), individuals with diabetes, high blood pressure, obesity and other chronic diseases are particularly at risk and need to ensure they are screened regularly and manage their health condition well, says an expert from global health system Cleveland Clinic, speaking ahead of World Kidney Day on March 14.

Globally, around one in 10 people have some form of CKD, according to the International Society of Nephrology and the International Federation of Kidney Foundations, which jointly organize World Kidney Day "With CKD, a person often doesn't experience symptoms until they have advanced disease, so screening tests are vital for early detection of disease or assurance that the kidneys are functioning normally," says Cleveland Clinic nephrologist Hanny Sawaf MD. "In the case of long-standing chronic kidney disease, the damage is often irreversible, but if kidney damage is caught early, we can take steps to reverse, prevent or delay any further damage. This is why simple non-invasive kidney tests are included in annual health check-ups for adults, and they are particularly

important for people with a family history of kidney disease or those with chronic health conditions."

Dr. Sawaf points out that, left unchecked, hypertension- or high blood pressure- and diabetes are the most common causes of kid-



tive effect on renal function ended prematurely as it had met its objective."

Tips for Good Kidney Health

In addition to managing chronic conditions and undergoing recommended screening tests, Dr. Sawaf says there are lifestyle changes that individuals can implement to improve their kidney health. In general, the guidelines for maintaining heart health also apply to kidney health, and these steps can also contribute to better management of diabetes, obesity and hypertension, he says.

Despite setback, Space One remains optimistic

Managing high blood pressure, diabetes and Japan's first private-sector rocket launch attempt explodes moments after takeoff

TOKYO, March 13, (AP): A commercial rocket trying to put a satellite into orbit was intentionally exploded shortly after liftoff Wednesday morning in central Japan following a problem that's still under investigation.

Space One was aiming to be Japan's first private sector success at putting a satellite into orbit.

Online video showed the Kairos rocket blasting off in a mountainous area filled with trees then exploding five seconds later. A huge plume of smoke engulfed the area, and flames shot up in some spots. Spurts of water were shown trying to put out the blaze.

Live footage on public broad caster NHK showed debris scattering from the sky and later charred pieces were shown strewn about on the ground. No injuries were reported and the fire was brought under control, according to the fire department for Kushimoto city in Wakayama prefecture



various information, including monitoring possible dangers from rocket launches from neighboring North Korea.

It occurred during step two of the launch, with the first step being liftoff, and all the pieces of the rocket landed on Space One's property, the

Napoli elimination from CL helps Turin club

Juventus advance to the 2025 Club World Cup from Italy

GENEVA, March 13, (AP): Banned by UEFA from European competitions this season for breaking financial rules, Juventus still qualified for the 2025 Club World Cup on Tuesday when Napoli went out of the Champions League.

Barcelona beat Napoli 3-1 in the second leg of the round of 16 to seal a 4-2 win on aggregate score that ensured Juventus advanced through a European ranking system to the revamped FIFA event.

Barcelona is still not sure to be among Europe's 12 entries because it trails Spanish rival Atletico Madrid in the European rankings.

Champions League winners in the four-year period -Chelsea, Real Madrid and Manchester City so far - will be joined by eight or nine teams finishing highest in a table counting all results in the competition. Countries also are limited to two entries unless they have more than two winners of the continental title.

Inter Milan, which reached the Champions League final last season, already secured its Club World Cup place by ranking and Napoli's exit Tuesday ensured Juventus cannot be overtaken as the second-best Italian team.

Juventus reached the Champions League round of 16 twice in the four-year span and also played in the group stage last season. It is currently No. 14 in the European ranking table though behind three teams from each of England, Germany and Spain which will reach their quota.

UEFA imposed a one-season ban on Juventus from its competitions in July in the fallout from a false accounting case that also saw the team deducted points in Serie A.

Juventus also was fined 10 million euros (\$11 million) by UEFA though should more than recoup that in Club World Cup prize money paid by FIFA next year. The June 15-July 13 tournament has the established World Cup format of eight four-team groups then a 16-team knockout bracket.

Bayern Munich, Paris Saint-Germain, Porto, Borussia Dortmund and Benfica also have qualified, and will be joined by either Atletico or Barcelona. Other teams still in contention include Arsenal, PSV Eindhoven and Salzburg

Three Brazilian teams - Flamengo, Palmeiras and Fluminense - have qualified, plus Seattle Sounders, and Mexican teams Leon and Monterrey. Another U.S. team will qualify as part of a Club World Cup tradition to include the host nation's champion.

In Asia, Al Hilal of Saudi Arabia and Japan's Urawa Red Diamonds of Japan are in. Al Ahly of Egypt and Wydad Casablanca of Morocco have qualified from Africa and Auckland City of New Zealand will represent Oceania.

The last of the continental finals in 2024 is South America's Copa Libertadores on Nov. 30.

Brazil's Senate opens new inquiry on fixing

BRASILIA, Brazil, March 13, (AP): Brazil's Senate on Tuesday opened another inquiry into match-fixing in the country's top soccer divisions. The move comes a year after a sprawling investigation by pros-ecutors linked 26 people, including players, businesspeople and sports executives, to criminal betting schemes.

Sen. Romario de Souza Faria, a World Cup winner in 1994, made the request for the inquiry last week. A similar investigation in the country's lower house ended in frustration six months ago.

Faria said the Senate inquiry should use as a reference a recent report published by technology company SportRadar, which put 109 matches played in Brazil in 2023 under suspicion of matchfixing.

The original investigation by prosecutors in the state of Goias is still ongoing. It showed last year that players in Brazil's first and second divisions were allegedly offered up to \$20,000 by criminal syndicates to perform specific actions during games, such as receiving yellow cards and giving away penalty kicks.

Several players who were accused of involvement in the scheme have been suspended from the sport.



SAARBRÜCKEN, Germany, March 13, (AP): Third-division Saarbrücken's German Cup fairytale continued Tuesday with a 2-1 win over Borussia Mönchengladbach in their raindelayed quarterfinal.

Kai Brünker scored on a counterattack in stoppage time for Saarbrücken to knock out yet another Bundesliga team after a sensational second-round win over Bayern Munich and thirdround victory over Eintracht Frankfurt.

Celta Vigo has fired coach Rafa Benítez after winning just five league games this season.

The Spanish club announced the decision on Tuesday, thanking the former Liverpool and Real Madrid manager for "eight months of absolute dedication and total commitment" but saying he fell short of obtaining "the results expected." His contract was to 2026.

Celta lost 4-0 to league leader Madrid on Sunday and is 17th in the Spanish league, one place above the relegation zone with 10 matches remaining.

The 63-year-old Spaniard was also fired by Premier League side Everton after 200 days in early 2022.

Benitez's best spell was when he coached Liverpool and won the Champions League in 2005 and reached the final in 2007. He also won the FA Cup in 2006.

Barcelona back in Champs League quarterfinals after win over Napoli

'Today we showed that we are prepared to compete in Europe'

BARCELONA, Spain, March 13, (AP): Four years later, Barcelona is again celebrating a triumph in the knockout stage of the **Champions League.**

The five-time European champions returned to the quarterfinals with a 3-1 win over Napoli.

Fermín López, João Cancelo and Robert Lewandowski scored for Barcelona as it advanced 4-2 on aggregate after a 1-1 draw in the first leg in Italy three weeks ago.

Amir Rrahmani scored for Napoli, which couldn't repeat its last-eight appearance from last season, when it won a knockout round for the first time.

Barcelona had been eliminated in the group stage the last two years and hadn't reached the quarterfinals since 2019-20, when it lost to Bayern Munich.

"It was an incredible night," Barcelona midfielder Sergi Roberto said. "It had been four years since this club was where it deserves to be. We have to enjoy this moment.'

In the other Champions League match on Tuesday, Arsenal eliminated Porto in a penalty shootout after a 1-1 aggregate draw.

The Champions League could be Barcelona's last realistic chance for a title this season. It was eliminated in the Copa del Rey and trails Spanish league leader Real Madrid by seven points. Coach Xavi Hernández already announced he will leave at the end of the season.

"It was a great match, very complete," Xavi said. "We have been criticized unfairly, and today we showed that this team is prepared to compete in Europe. We are among the best eight teams in Europe. We have to enjoy it."

The victory also means extra income for Barcelona, which has been struggling financially recently.

The Catalan club is unbeaten in six meetings with Napoli in all competitions

It struggled to keep the Italian side from threatening after taking the early lead at Estadi Olímpic Lluís Companys. Goalkeeper Marc-André ter Stegen, making his 100th UEFA appearance, was tested often by Napoli's attack

Barcelona had a few chances to increase its lead on counterattacks before Lewandowski sealed the win from close range in the 83rd after an assist by substitute Roberto. Lewandowski has scored 13 goals in his last 13 knockout stage games in the Champions League.

López put the hosts ahead with a shot from the middle of the area in the 15th minute after a low cross by Raphinha, who also set up Cancelo's goal two minutes later. The Brazil forward hit the post from inside the area and the ball bounced back for an easy strike by Cancelo.

Napoli got on the board in the 30th with Rrahmani finding the net with a low left-footed shot for his first European goal.

"We gave them too much space, we lost possession often, we started with the wrong attitude and didn't defend well," Napoli coach Francesco Calzona said.

Barcelona teenager Lamine Yamal had a goal disallowed for offside in the 68th.

The last time Barcelona played in the quarterfinals it had also eliminated Napoli 4-2 on aggregate in the round of 16.

Xavi still couldn't count on several players because of injuries, including Pedri, Frenkie De Jong and Ferran Torres. He played with 17-year-old Pau Cubarsí as a central defender, and the teenager was named the man of the match as he helped contain Napoli's attack in his European debut.

The other teams that have advanced to the last eight include Real Madrid, Bayern Munich, Paris Saint-Germain and Manchester City.

Raya stars in penalty shootout vs Porto

Arsenal end a 14-year wait for **Champs League quarterfinals**

LONDON, March 13, (AP): Arsenal's 14-year wait for a spot in the Champions League quarterfinals is over, thanks largely to David Raya's penalty saves

Raya tipped one spot kick by Porto's Wendell against the post and then palmed away another from Galeno to secure a 4-2 win in a penalty shootout at the Emirates Stadium.

It ended a long streak of round-of-16 losses for Arsenal, which had been eliminated at this stage in its last seven appearances in the competition but won 1-0 to level the aggregate score at 1-1.

And it was a massive moment for Raya, who was brought in last summer to replace Aaron Ramsdale as Arsenal's No. 1 - a decision that has been frequently questioned by the club's supporters this season.

"Obviously it's a great feeling for me personally, first time in the Champions League and for the club to get into the quarterfinals for the first time in so many years." Raya said. "We've worked a lot on penalties this year and all the hard work with the goalie coach and the team has paid off."

It was the first penalty shootout in the Champions League since the 2016 final won by Real Madrid against Atletico Madrid.

Barcelona also reached the quarterfinals with a 3-1 win over Napoli in Tuesday's other game to advance 4-2 on aggregate.

The shot went through the legs of veteran defender Pepe, who at 41 is the oldest outfield player to play in a Champions League match and the same age as Arteta.

Arsenal had a second goal ruled out in the second half when Odegaard put the ball into an empty net but Kai Ĥavertz was adjudged to have fouled goalkeeper Diogo Costa moments before.

Gabriel Jesus nearly scored straight after coming on in the 83rd minute with a shot that nearly snuck between Costa's legs but deflected out for a corner.

Al-Hilal win 28th straight game to set record

JEDDAH, Saudi Arabia, March 13 (AP): Saudi Arabian team Al-Hilal set a world record for a top-tier team by winning its 28th straight game with a 2-0 victory over Al-Ittihad to reach the Asian Champions League semifinals

Al-Hilal had also won the quarterfinals first leg by the same score to advance 4-0 on aggregate over its domestic rival

The 18-time Saudi champion broke the previous recognized record of 27

straight wins set by The New Saints in the 2016-17 season. The Welsh team took the mark from the great Ajax team inspired by Johan Cruyff in 1971-72.

"Everyone at Al Hilal is delighted to achieve world football history by winning 28 consecutive matches," Al-Hilal coach Jorge Jesus said. "This is truly an incredible achievement and I want to thank everyone at the club for their part in this momentous winning record.

Al Hilal's dominating season follows the club spending about 350 million euros (\$380 million) on player transfers after being effectively nationalized by the Saudi sovereign wealth operation, the Public Investment Fund. It is controlled by Saudi Crown Prince Mohammed bin Salman.

The last time the team did not win was on Sept. 21 in a 1-1 draw against league rival Damac.

Al-Hilal, already champion of Asia four times, is 12 points clear atop the Saudi Pro League.

This will join Kuwait and Manama of Bahrain, who previously secured their spots as champions of the two Gulf region groups in the preliminary rounds.

Police search AC Milan's offices as part of probe into sale of club

MILAN, March 13, (AP): AC Milan's offices were raided by police on Tuesday as part of an investigation by Italian prosecutors into the sale of the Serie A giant.

RedBird Capital Partners purchased Milan from fellow American firm Elliott Management in August 2022, but Milan prosecutors claim Elliott still owns and controls the Italian club.

Italian financial police raided Milan's offices and also reportedly searched the homes of current CEO Giorgio Furlani and former chief executive Ivan Gazidis, who held the role from 2018 to 2022.

Furlani and Gazidis are being investigated for allegedly hiding information related to the sale from the Italian soccer federation.

"In regards to the search carried out today in its headquarters, AC Milan is a third party and extraneous to the ongoing legal action concerning the purchase of the club," Milan said in a statement it sent to journalists including The Associated Press.

'The investigation, which also involves the legal representatives with authority to sign, Giorgio Furlani and Ivan Gazidis, hypothesizes incorrect communications to the competent vigilance authority. The club is giving its full cooperation to the investigating authority."

Milan could nevertheless be fined or docked points by the Italian soccer federation.

Lazio officially announced coach Maurizio Sarri's resignation on Wednesday and said his longtime assistant Giovanni Martusciello is taking over

Italian media had reported on Tuesday that the 65-year-old Sarri had decided to step down after five losses in Lazio's last six matches.

Sarri was in his third season in charge of Lazio and had a contract until the end of next season.

"Lazio announces that Maurizio Sarri has resigned as coach." the team said. "The club thanks the coach for the achievements reached and for the work done, wishing him the best luck humanely and professionally.

"At the same time, the club announces that the coaching duties have been given to Giovanni Martusciello."

Martusciello was Sarri's assistant at Empoli, Juventus and Lazio. He was Empoli's head coach in 2016-17, when the Tuscan club was relegated on the final day of the season.
